#### Sonia Gandhi referring to President as 'poor thing' demeans high office

New Delhi, Jan. 31: The BJP on Friday latched on to former Congress president Sonia Gandhi's reaction to President Droupadi Murmu's address to both Houses of Parliament, alleging the Congress leader referring to the President as a "poor thing" demeans the high office and reflects her feudal mindset. Soon after the President delivered her address to the joint sitting, Sonia Gandhi, Rahul Gandhi and Priyanka Gandhi Vadra were seen discussing the speech. "The poor lady, the President, was getting very tired by the end...She could hardly speak poor thing," Sonia Gandhi was purportedly heard saying in a video doing the rounds on social media. Latching on to the remark, BJP IT department head Amit Malviya said on X "Sonia Gandhi referring to the President as a 'poor thing' demeans the high office and reflects her feudal mindset. This is not the first time the Congress has ridiculed the first tribal woman to hold the highest constitutional office in the country." "Rahul Gandhi, the Leader of the Opposition, who frequently flaunts a copy of the Constitution, has not even considered making a courtesy visit to the President," he said.

# No attempt from abroad to stoke trouble before Parliament session: PM Modi

New Delhi, Jan. 31: It is perhaps the first time since 2014 that no attempt has been made from abroad to "stoke a fire" in India before the start of a Parliament session, Prime Minister Narendra Modi said on Friday. Ahead of Parliament's Budget session. Modi also took a swipe at opposition parties, saying that there were people abroad ready to do mischief before every session since 2014 and there was also no dearth of those here who would fuel such attempts. "Shayad 2014 se lekar ab tak, ye pehla Parliament ka satr hai, ki jiske ek-do din pehle koi videshi chingari nahi pakdi hai, videsh mein se aag lagane ki koshish nahi hui hai (Perhaps since 2014, this is the first session of Parliament in which a day or two before the session, there has been no foreign attempt to stoke a fire from abroad)," Modi told reporters before the start of the session. "This is the first session I am seeing in the last 10 years in which there has been no attempt to stoke a fire from any foreign corner," the prime minister said. With his government tabling its first full-fledged budget on Saturday in its third term, Modi said he

prayed that Goddess Lakshmi, who is associated with wealth, will bless the poor and middle class. He expressed confidence that this Budget session will infuse new confidence and energy in attaining the goal of 'Viksit Bharat' by 2047. He said his government has been working in mission mode in its third term for an all-round development and asserted that innovation, inclusion and investment have shaped its economic agenda. Modi said many historic bills will be taken up during the session and

will become laws after comprehensive debate to strengthen the country. "Particularly, important decisions will be taken during the session to empower women to ensure they get equal rights and any sectarian or faith-based discrimination is removed," he said. Modi also expressed confidence that every MP, especially the

young ones, will contribute to the agenda of 'Viksit Bharat' during the session. Stressing on the mantra of 'Reform, Perform and Transform', Modi said fast-



paced development has to be achieved and the maximum emphasis is on reform. He said the state and Central governments have to perform together and one can see transformation through public participation. "Ours is a young country... The youth of 20-25 years of age today, when they will

be 45-50 years-old, they will be the biggest beneficiaries of a developed India. At that stage of their age, they will be sitting in that place in the policy making system...

They will proudly move forward with a developed India," Modi said. Hence, this effort to fulfill the resolve of a developed India, this immense hard work, is going to be a great gift for our teenagers, our young generation, he said. "Those who had joined the freedom struggle in 1930, 1942... The entire youth generation of the country was engrossed in the freedom struggle, and the fruits of that were reaped by the generation that came after 25 years," Modi said. Similarly, these 25 years would be

marked by the intention of people to achieve a prosperous and developed India through their resolve and reach the pinnacle through their achievements, he said. Therefore, in this budget session, all MPs will contribute to strengthen the resolve of a developed India, Modi said.

According to the prosecution, a huge mob, armed with deadly weapons, resorted to largescale looting, arson and destruction of properties of Sikhs to avenge the assassination of Indira Gandhi.

#### **Greater Chennai Corporation** makes microchipping must for pet dog licence

CHENNAI. To prevent abandonment of pet dogs and the subsequent increase of strays, the Greater Chennai Corporation (GCC) has made it compulsory to implant microchips on canines to get pet licence. A resolution was passed during the corporation council meeting at Ripon Building on Thursday.Owners found abandoning their pets will face fines or legal action, the resolution said. This system will also help in tracking the lost pets.

Dr J Kamal Hussain, the GCC Veterinary officer, said, "The microchipping will be done at GCC's six pet clinics and will be further extended to the Tamil Nadu Veterinary and Animal Sciences University's veterinary hospital, and private veterinary clinics."The microchips will store details such as the pet's name, species, breed, colour, sex, age, vaccination status, and a unique identification number recognised by the Indian Council of Agricultural Research. The GCC will develop a dedicated online software and a mobile app to be integrated with the corporation's existing online pet licencing portal. In August 2023, GCC introduced an online licencing system, leading to 9,151 registrations so far. However, the current system only tracks pet numbers and vaccination status. In 2024, a survey by the Worldwide Veterinary Service found around 1.8 lakh stray dogs in Chennai. The GCC, under TNAWB's guidance, introduced the microchipping mandate to pin accountability on pet owners.While now, Rs 50 is being charged to obtain a pet licence, the corporation is yet to decide about the charges for microchipping

#### Sexual assault allegation surfaces as cops arrest two more for inmate abuse

SAMBALPUR. Shocking allegation of sexual abuse at 'Samartha' rehabilitation centre has come to the fore even as police on Wednesday arrested two more persons for their involvement in torturing the mentallychallenged inmates of the facility.

A woman inmate has accused the secretary of 'Adarsha Shishu Mandir', the NGO managing the centre, Harishchandra Das of sexually assaulting her. Police have already arrested Harishchandra and a female caretaker of the centre Swagatika Pradhan after disturbing videos of inmates being subjected to torture went viral on social media.On Wednesday, Harishchandra's son Subhrajit Das and another caretaker Subham Behera were arrested for allegedly abusing and assaulting the inmates of the facility located at Netaji Nagar here.

Dhanupali IIC Subrat Panigrahi said police arrested Subhrajit and Subham after their involvement in the crime was ascertained. "We are now investigating into the complaint of sexual assault. The medical examination of the victim has already been conducted. A scientific team was also sent to the facility to collect evidence," he said. This apart, sub-collector Pushpanjali Panda visited the centre to investigate the allegations and also interacted with some of the inmates. She has reportedly submitted her probe report to the district collector. # IIIT Bangalore, University of Toronto collaborate on Al-driven solutions to enhance infrastructure

The institutions have proposed a public-private partnership to integrate AI into governance for better management of water resources.

BENGALURU. In a significant push towards AI-driven urban governance,

researchers from the International Institute of Information Technology Bangalore (IIIT-B) and the University of Toronto are collaborating to enhance infrastructure and quality of life in Bengaluru and other urban centres in India.

The institutions have proposed a public-private partnership to integrate AI into governance for better management of water resources, urban mobility, waste disposal, and climate adaptation.

The initiative aims to develop solutions for Bengaluru first, with plans to replicate them across other metros like Chennai, Hyderabad, Mumbai, and Delhi.

The initiative was highlighted at the 'AI and the City - Understanding Applications in Urban Environments' conference, organised by IIIT-B's Centre for Information Technology and



Public Policy (CITAPP) in collaboration with the University of Toronto's School of Cities and the University of Toronto India Foundation (UTIF). The event showcased AI's role in urban planning, disaster management, cybersecurity, and environmental sustainability. The conference drew participation from ex

perts across 22 institutions spanning 11 countries, including the Geneva Graduate Institute, Georgia Institute of Technology, Royal Holloway University of London, and Singapore Management University.

Sachit Rao, a professor at IIIT-B, demonstrated how AI-based techniques can map and monitor Bengaluru's water bodies, track flooding using satellite data, and assist policymakers in planning flood mitigation strategies. Given Bengaluru's recurrent flooding issues, such AIdriven insights could significantly improve urban resilience, he said, emphasising the need to replicate this model in other major Indian cities for better infrastructure planning.

Similarly, researchers at CITAPP presented AI applications for monitoring urban heat islands, using predictive modelling and local climate zone analysis. They highlighted how AI can classify land surfaces, analyze temperature patterns, and evaluate the effectiveness of green spaces in cooling urban areas.

Roland Hass, Adjunct Professor at IIIT-B, showcased AI-driven

cybersecurity solutions to protect interconnected smart city systems. He explained how technologies like Large Language Models (LLMs) can detect vulnerabilities, automate software testing, and strengthen urban digital infrastructure against cyber threats. AI-powered threat intelligence was also highlighted as a crucial tool in countering the rising frequency of cyberattacks on city networks. With AI gaining momentum globally, researchers emphasise that while AI solutions take time to develop, crossdisciplinary knowledge exchange is essential to create effective, context-specific urban governance models.Karan Singh, Associate Director at the University of Toronto's School of Cities, emphasized the importance of interdisciplinary collaborations in tackling India's critical urban challenges.

ast April, she trekked to the base camp of Mount Everest, and ir November, she summited the 5,895-metre high Mount Kilimanjaro in Tanzania -- the highest mountain in Africa and the highest free-standing mountair above sea level in the world. And now, she is preparing to climb Mount Elbrus in Russia, the highest mountain in Europe at 5,642 metres.

In her forties, Seena braved cold and acute mountain sickness, among other hurdles associated with hilly terrain, during the 11-day travel from Kathmandu to the Everest base camp. "Acclimatisation is a challenge. However, besides following your passion, going intc nature's lap and finding solace there is also a healing," she tellsI. She undertook the climb to the base camp. at 5.364 metres, after a year of training. There, she met many people from across the globe, who inspired her to do the Sever Summits.

The Kilimanjaro trip, she says changed her perception of Africa as it was the safest journey she has ever had. "The people there were so friendly," she recalls. Ar advocate turned educator, Seena married Majnu M Rajan in 2007 and has since been associated with the management of National College, a tutorial college run by her husband in Tiruvalla.

They are mainly focused on finding buildings that can accommodate 15 High Court Judges, as well as various rooms for court operations and other essential amenities, he added. They are also tasked with identifying residential accommodation for judges.hey are mainly focused on finding buildings.

State government support to preserve their century-old craft, much like the recognition given to Etikoppaka toys as a symbol of Andhra Pradesh's rich cultural heritage. The local artisans are urging the State government to help them market their dolls nationally.

of Settigunta and Lakshmigaripalle villages in the Railway Koduru region of the erstwhile Kadapa district have been crafting Raja-Rani wooden dolls and other intricately designed wooden toys that enjoy demand not only in the Telugu States but also in Karnataka and Tamil Nadu.

The Andhra Pradesh MSME Development Corporation recently identified the region as a Raja-Rani Dolls Cluster, a decision welcomed by the artisans. Under the Government of India's Ministry of MSME, cluster development programmes require the State government proposals for approval. Therefore, the State government submitted a Detailed Project Report (DPR) prepared by ITCOT National Technical Agency proposing a `6 crore budget for land development, building construction, and machinery.



The feasibility of the project is currently under review by SIDBI (Small Industries Development Bank of India), with field inspections expected in February. The project is likely to take In 1993, artisans formed the Sri Lakshm shape by June-July, with 85% funding from the Centre and 15% from the State. Once approved, the initiative gives an impetus to the local toy-making industry through training programmes, necessary infrastructure and machinery to sustain the makers, thereby carrying on the intricate tradition.Located along the Kurnool-Chittoor National Highway, these villages have a 100year-old legacy of wooden toy-making, with nearly 100 families engaged in the craft.

Men, women, and children alike contribute to this art form, skillfully shaping wood into intricate figures. The Raja-Rani dolls have a substantial market at sacred pilgrimage sites in the tradition. The craft gaine national attention betwee 1997 and 2002 when government-backe exhibitions across th country showcased thes toys. A notable momen came when artisans from th region presented thei Shakuntala wooden dol

crafted from white pumpkin wood at a exhibition in Hyderabad, where i caught the eye of then-US President Bil Clinton, who purchased it.

Venkateswara Artistic Wooden To Makers Cooperative Society, led by I Subbarayudu Achari. While earlie generations relied solely on this crat for livelihood, many families have sinc shifted to other professions due t dwindling support.

Speaking to TNIE, K Subbarayud Achari emphasised that recognition as Raja-Rani Dolls Cluster would boos training programmes, infrastructur development, and national-leve marketing opportunities. He highlighte the unique demand for Settigunta dolls particularly in neighbouring state where similar toys are unavailable reinforcing the need for government backed promotion and expansion.

# Accessing government services with Mana Mitra will be as easy as texting a friend: Lokesh

VIJAYAWADA. In a world-first initiative, the Andhra Pradesh government has launched WhatsApp governance, offering 161 citizens' services directly to the public through the platform.At the launch of 'Mana Mitra' at his residence in Undavalli on Thursday, HRD and IT Minister Nara Lokesh stated that with WhatsApp governance, accessing public services will be as simple as texting a friend or a family member.As part of phase one, 161 citizens' services are now available under Mana Mitra, which has been launched in collaboration with Meta.

Lokesh further explained that 360 more services will be added in the second phase. The services will cover six key categories: electricity bill payments, revenue services, municipal services, grievance redressal, and booking for temple darshan/seva and bus tickets.Lokesh observed, "This first-of-its-

kind chatbot symbolises our vision for a digitally inclusive Andhra Pradesh, where citizens can book bus tickets, plan temple visits, and obtain certificates - all on WhatsApp." "This initiative, in partnership with Meta, makes accessing government services as simple as chatting with a friend or family member. People will no longer need to run from pillar to post to access certificates and other government services," he said.Explaining the scale of the project, he noted, "Connecting 36 departments to WhatsApp governance is a complex task. In phase one, we are making 161 civil services available on the platform.

In phase two, we plan to add 360 more. WhatsApp governance will serve as a bridge between the government and the people, ensuring real-time delivery of certificates and Lokesh stressed that there would be no room for fake certificates in the

system. "Every certificate provided will feature a special QR code for authenticity verification. We are also planning to integrate blockchain technology soon. In the second phase, we will incorporate AI bots and voice functionalities," he added. Acknowledging that there would be further refinements, the Minister assured that any shortcomings would be addressed.

'We are collecting real-time data from all departments and codifying it. A data lake will be created to provide seamless services. Our team has worked tirelessly over the past three months, testing for the last 15 days. While we understand improvements are needed, we are committed to making this an ideal product within six months.

"Reflecting on his Yuva Galam Padayatra, where the idea for WhatsApp governance originated, Lokesh shared,

#### Man gets life imprisonment for murder of brother-in-law

Gurgaon. A court has awarded life imprisonment to a man accused of killing his brother-in-law in 2022.

Police stated that accused Naveen Kumar visited his sister Sarita's family, in Basai Enclave on 26th June, 2022, He was on talking terms with his brother-in-law Harvinder, however, was unhappy due to a dispute between the couple, who were married for 14 years and had 2 children.A fight broke out between the couple in the middle of the night and Naveen shot Harvinder in the head. A case was registered under section 302 of IPC and sections of the Arms Act

at Sector 10A police station by Naresh Kumar, who stated that Harvinder was his uncle.Another relative Rupesh stated that they received a phone call around 1:00 AM from Sarita, who told them about Harvinder's firearm injuries. He added that upon reaching




the spot, he found Harvinder lying on the bed. A pistol was found on the floor, which was taken into possession by the police.

victim's wife, Sarita, however, changed her statement two times. Initially she said that she woke up to a gunshot noise and saw Naveen holding a pistol and fleeing from the spot. She later changed her statement in the court, saying some unknown person came and murdered her husband.Manjit Kaushik, counsel for the accused, argued there is no eyewitness of the occurrence and Naveen can't be held guilty in the absence of any reliable evidence. Additional session judge Sunil Kumar Dewan, in his order on Jan 29, observed that as per the material available on record, the convict killed Harvinder due to the family dispute going on between the deceased and his wife, who happens to be the sister of the convict.

The court refused to show any leniency in the case, however, refused to give capital punishment, stating chances of "reformation". The case does not fall in the category of 'rarest of the rare case.

### Israel says it struck 'multiple' Hezbollah targets in Lebanon's Bekaa Valley

JERUSALEM. Israel's military said Friday it struck "multiple" Hezbollah targets in Lebanon's Bekaa Valley, two months into a fragile ceasefire with the Lebanese group after major hostilities last year.

- "The targets that were struck include a Hezbollah terrorist site containing underground infrastructure, used to develop and manufacture weaponry and additional terrorist infrastructure sites on the Syrian-Lebanese border used by Hezbollah to smuggle weaponry into Lebanon," the military said in a statement. It said the overnight strikes were aimed at targets that "posed a threat" to Israel and Israeli troops.On Thursday, the military said it intercepted a Hezbollah "surveillance" drone approaching Israeli territory, which it said "represents a breach of the ceasefire understandings between Israel and Lebanon"."The (army) continues to remain committed to the ceasefire understandings between Israel and Lebanon, and will not permit any terrorist activity of this kind," it said.
- The Israeli army missed a January 26 deadline to complete its withdrawal from Lebanon. It now has until February 18.Israel had made clear it had no intention of meeting the deadline, charging that the Lebanese army had not fulfilled its side of the bargain.Under the terms of the ceasefire, the Lebanese army is to deploy in the south as Hezbollah pulls its forces back north of the Litani River, some 30 kilometres (20 miles) from the border.
- The Iran-backed militant group is also required to dismantle any remaining military infrastructure it has in the south.

#### Find another sucker: Trump warns BRICS nations, says '100 per cent tariff if they move away from US dollar'

World US President Donald Trump fired another stern warning to the BRICS bloc, which includes India, threatening to impose 100% tariffs if the group attempts to replace the US dollar with an alternative currency. In a post on his social media platform, Truth Social, Trump wrote on Friday: "The idea that the BRICS countries are trying to move away from the dollar, while we stand by and watch, is OVER."

He said, "We are going to require a commitment from these seemingly hostile countries that they will neither create a new BRICS currency nor back any other currency to replace the mighty US dollar. If they do, they will face 100% tariffs and should expect to say goodbye to selling into the wonderful US economy."Trump added,"They can go find another sucker nation. There is no chance that BRICS will



# How did so many Thai farmers end up held hostage by Hamas

#### Thais remain the laraest group of foreign agricultural laborers in Israel today, earning considerably more than they can at home.

BANGKOK. Five Thai nationals held hostage by Hamas since its Oct. 7, 2023, attack on Israel were released Thursday.

They were among 31 Thais taken by the militant group, of whom 23 have already been released. Another two have been confirmed dead, and the status of one remaining person is not clear. According to Thailand's Ministry of Foreign Affairs, 46 Thais have been killed during the conflict, including the two who died in Hamas captivity. They were among tens of thousands of Thai workers in Israel. Here's a look at what they were doing there.

Why are there so many Thais in Israel?

Israel once relied heavily on Palestinian workers, but it started bringing in large numbers of migrant workers after the 1987-93 Palestinian revolt known as the first Intifada.Most came from Thailand, and Thais remain the largest group of foreign agricultural laborers in Israel today, earning considerably more than they can at home. Thailand and Israel implemented a bilateral agreement a decade ago to ease the way for workers in the agriculture sector.Israel has come

under criticism for the conditions under which the Thai farm laborers work. In a 2015 report, Human Rights Watch said they often were housed in makeshift and inadequate accommodations and "were paid salaries significantly below the legal minimum wage, forced to work long hours in excess of the legal maximum, subjected



to unsafe working conditions and denied their right to change employers."A watchdog group found more recently that most were still paid below the legal minimum wage. How many Thais work in Israel?There were about 30,000 Thai workers, primarily working on farms, in Israel prior to the Oct. 7 attack by Hamas.In the wake of the attack, some 7,000 returned

home, primarily on government evacuation flights, but higher wages have continued to attract new arrivals. Thai ambassador to Israel Pannabha Chandraramya said Thursday that there are now more than 38,000 Thai workers in the country.

What happened after they left?

Faced with a labor shortage in the wake of the exodus after the Hamas attack, Israel's Agriculture Ministry announced incentives to try and attract foreign workers back to evacuated areas. Among other things, it offered to extend work visas and to pay bonuses of about \$500 a month. Thailand's Labor Ministry granted 3,966 Thai workers

permission to work in Israel in 2024, keeping Israel in the top four destinations for Thais working abroad last year.

Thai migrant workers generally come from poorer regions of the country, especially the northeast, and even before the bonuses the jobs in Israel paid many times what they could make at home.

# No happiness': Misery for Myanmar exiles four years on from coup

SAMUT SAKHON.Four years after Myanmar's military seized power in a coup, the country is in the grip of a bloody civil war that has driven many of the country's young across the border to Thailand. There they scrape Like thousands of others, Ma Phyu chose by doing hard jobs for little pay -- often living in fear of being arrested and sent back to Myanmar.AFP met three of

them in Mahachai, a district of Samut Sakhon in Bangkok's western suburbs known as "Little Myanmar" for its population of migrant workers. They told of their experiences and hopes and fears for the future -- speaking under pseudonyms for their own

safety and that of their families back in Myanmar. Ma Phyu: 'I lost all my dreams'

'After the coup, I lost all my dreams," Ma Phyu told AFP.Before the military seized power, the 28-year-old was teaching young children while studying at university in Yangon with the aim of qualifying as a teacher. After the February 1, 2021 coup, which

ousted the elected civilian government of Aung San Suu Kyi, the generals launched a bloody campaign of violent repression against dissent.Resistance has been fierce, led in large part by young people who grew up during Myanmar's 10-year dalliance with democracy.

I feel disgusted at work and it's the same at home. Nothing changes, I don't want to live any more,' Ma Phyu said."My previous life was full of happiness. If there had been no coup, there would have been a good life for me."Lwin Lwin: 'There is no happiness'In a shabby room in a rundown building in Mahachai, Lwin Lwin practises Japanese grammar with five other Myanmar migrants. The 21year-old, who fled Myanmar without finishing high school, hopes learning the language will give her a way out of a tough existence in Thailand."The coup turned my life upside down. I thought I would finish school, go to university and work for the government," she told AFP.

## Investigators recover plane black boxes from Washington air collision

WASHINGTON: Investigators on Thursday recovered the black boxes from a passenger plane whose mid-air collision with a military helicopter over Washington's Potomac River killed 67 people, as rescuers pulled victims' bodies from the freezing water.

US President Donald Trump launched a political attack blaming diversity and inclusion policies championed by his Democratic predecessors for causing the incident. Trump's politicization of the tragedy came as the National Transportation Safety Board (NTSB) said it had recovered the cockpit voice recorder and flight data recorder from the Bombardier jet operated by an American Airlines subsidiary that smashed into an Army Black Hawk helicopter late Wednesday.

- "The recorders are at the NTSB labs for evaluation," the agency said in a statement to AFP.According to a New York Times report, staffing was thin in the control tower at Reagan National Airport, where the airliner was about to land when the collision occurred.
- One controller, rather than the usual two, was handling both plane and helicopter traffic, the Times quoted a preliminary Federal Aviation Administration report as saying.A fireball erupted in the night sky and both aircraft tumbled into the icy Potomac, leaving rescue crews with the grim, difficult task of searching for bodies in the dark and cold.Over 40 bodies had been

#### US Senators push to reverse autorenewal of work permits back to 180 days

WASHINGTON. Two influential Republican Senators have introduced a resolution to reverse a Biden-era rule that increased the period for renewing work permits from 180 to 540 days. The automatic extension of the Employment Authorisation Document (EAD) from 180 days to 540 days was of great help to the spouses of H-1B visa holders, a significant number of whom were from India. The rule finalised by the Department of Homeland Security on January 13 applies broadly to immigrants, refugees, green card holders, spouses of H-1B visa holders and more.Introduced on Thursday jointly by Senators John Kennedy and Rick Scott, the resolution seeks disapproval under Congressional Review Act (CRA) procedures for the Biden administration's rule that automatically extended the renewal period for an immigrant EAD to almost a year-and-a-half before officials could review those permits.

- The Biden administration's dangerous rule automatically extended work permits for immigrants to 540 days.iving immigrants more time to avoid reporting to US officials hampers the Trump administration's efforts to enforce our immigration laws and keep Americans safe, said Kennedy.In a statement, Scott alleged that the Biden-Harris administration worked for four years straight to dismantle America's immigration system and open the southern border, allowing millions of illegal aliens to come across the border unvetted and unchecked.

# Five years after Britain left the EU, full impact is still emerging

LONDON. Five years ago Friday, two crowds of people gathered near Britain's Parliament - some with Union Jacks and cheers, others European Union flags and tears.On Jan. 31, 2020 at 11 p.m. London time - midnight at EU headquarters in Brussels — the U.K. officially left the bloc after almost five decades of membership that had brought free movement and free trade between Britain and 27 other European countries.For Brexit supporters, the U.K. was now a sovereign nation in charge of its own destiny. For opponents, it was an isolated and diminished country.

It was, inarguably, a divided nation that had taken a leap into the dark. Five years on, people and businesses are still wrestling with the economic, social and cultural aftershocks."The impact has been really quite profound," said political scientist Anand Menon, who heads the think-tank U.K. in a Changing Europe. "It's changed our economy."And our politics has been It wasn't so simple. changed quite fundamentally as well," he added. nation with a robust sense of its historical importance, Britain had long been an

uneasy member of the EU when it held a referendum in June 2016 on whether to remain or leave. Decades of deindustrialization, followed by years of public spending cuts and high immigration, made fertile ground for the argument that Brexit would let the U.K. "take back control" of its borders, laws and economy. Yet the result - 52% to 48% in favor of leaving — came as a shock to many. Neither the Conservative government, which campaigned to stay in the EU, nor pro-Brexit campaigners had planned for the messy details of the split.

The referendum was followed by years of wrangling over divorce terms between a wounded EU and a fractious U.K. that caused gridlock in Parliament and ultimately defeated Prime Minister Theresa May. She resigned in 2019 and was replaced by Boris Johnson, who vowed to "get Brexit done."

#### Ablow to the British economy

The U.K. left without agreement on its future economic relationship with the EU, which accounted for half the country's trade. The political departure was followed by 11



months of testy negotiations on divorce terms, culminating in agreement on Christmas Eve in 2020.The bare-bones trade deal saw the U.K. leave the bloc's single market and customs union. It meant goods could move without tariffs or quotas, but brought new red tape, costs and delays for trading businesses."It has cost us money. We are definitely slower and it's more expensive. But we've survived," said Lars Andersen, whose London-based company, My Nametags, ships brightly colored labels for kids' clothes and school supplies to more than 150 countries.To keep trading with the EU, Andersen has had to set up a base in Ireland, through which all orders destined for EU countries must pass before being sent on. He says the hassle has been worth it, but some other small businesses he knows have stopped trading with the EU or moved manufacturing out of the U.K.Julianne Ponan, founder and CEO of allergenfree food producer Creative Nature, had a growing export business to EU countries that was devastated by Brexit. Since then she has successfully turned to markets in the Middle East and

Australia, something she says has been a positive outcome of leaving the EU.Having mastered the new red tape, she is now gradually building up business with Europe again."But we've lost four years of growth there," she said. "And that's the sad part. We would be a lot further ahead in our journey if Brexit hadn't happened."The government's Office for Budget Responsibility forecasts that U.K. exports and imports will both be around 15% lower in the long run than if the U.K. had remained in the EU, and economic productivity 4% less than it otherwise would have been.Brexit supporters argue that short-term pain will be offset by Britain's new freedom to strike trade deals around the world. #### Four get 20-year jail term for 2022 gang rape

VELLORE: The Fast-Track Mahila Court in Vellore on Thursday convicted four men for gang-raping a doctor in 2022 and sentenced them to 20 years in prison.Judge S Mageswari Banu Rekha also imposed a fine of Rs 25,000 on each of them. Having already served three years in Vellore Central Prison during the trial, the court directed them to serve the remaining 17 years. Meanwhile, a juvenile in the case is facing trial at a Juvenile Justice Board and the verdict is expected next week.

According to police sources, the convicted were identified as R Parthiban (22), V Manikandan (22), R Barath (20), and E Santhosh Kumar (24) - all residents of Sathuvachari, Vellore. The incident took place on March 17, 2022, when the 28-yearold doctor and her male friend were returning after watching a movie. They had taken a shared auto-rickshaw with four other passengers and the driver. The vehicle was diverted to an isolated area and the five gang-raped the woman. They also robbed them of Rs 40,000 in cash and two sovereigns of gold jewellery. Based on an online complaint from the woman, the police registered a case. A special investigation team led by DSP R Ravichandran and ASP D V Kiran Shruthi had arrested the culprits and submitted a 496-page chargesheet. Public prosecutors K Vigneshwari and M Sandhiya examined 39 witnesses.

#### Hesaraghatta grassland reserve gets Karnataka cabinet stamp

BENGALURU. In what could be termed a victory for conservationists, the public and state forest department, the Siddaramaiah cabinet on Thursday decided to declare 5,678 acres and 32 guntas of land (2298.18 hectares) in Yelahanka taluk of Bengaluru City district as 'Greater Hesaraghatta Grassland Conservation Reserve' (GHC) under Section 36(a) of the Wildlife (Protection) Act, 1972. The government fulfilled a decade-old demand that was being stalled because of political controversy. The area was the last standing 'savannah' ecosystem of Bengaluru. In October 2024, the State Board for Wildlife headed by Chief Minister Siddaramaiah, had approved the proposal which has now got the cabinet nod.Meanwhile, the cabinet deferred the proposal to declare 5959.32 hectares, including 6km of Honnavar sea coast and forest area in Uttara Kannada district as 'Apsarakonda-Mugali Marine Wildlife Sanctuary'. Revision of annual licence renewal charges of Karnataka Water Transport Board is expected to generate an additional revenue of Rs 3.50-4 crore per annum. The state's minor ports include Karwar, Honnavar, Malpe, Belekeri, Manki, Padubidri, Keni, Bhatkal, Old Mangalore, Tadadi, Kundapur, Pavinakurve and Hangaratta.Withdrawal of Karnataka Urban and Rural Planning (Amendment) Bill, 2024, regarding Premium FAR. The Governor has returned the bill, seeking some clarifications. Since it involves legal aspects, it is appropriate to consult the relevant stakeholders. The ordinance for utilisation and regulation of Bengaluru Palace Grounds land was gazetted on January 29, 2025.

# Kadamattom St George Church: A blend of history, art, and architecture with unique murals and heritage

KOCHI. It is the smell of burning candles and incense floating with the gentle breeze that greets you as you slowly climb the stone steps of the hillock leading to the historic Kadamattom St George Orthodox Church along NH 85 near Kolenchery. At the summit, what strikes you is the nadakasala or portico reminiscent of Hindu temples and it harmoniously sits next to the Baroque facade of the church. Having a unique place in the annals of history, this church houses the mortal remains of the legendary Kadamattathu Kathanar who was believed to possess supernatural powers. Besides its association with the wizard priest, this church is known for its magnificent centuries-old murals and a Persian stone cross with Pahlavi inscriptions.Step inside the church and one's eyes immediately rest on the beautiful barrelvault above the sanctuary, which sports small panels exquisitely painted with floral designs. Hidden behind the main altar is a visual treasure

- a rare painting of St George slaying a dragon. Flanking the sanctuary are two side altars. The one on the left has a wooden reredos with a panel depicting the Virgin Mary and behind it hides a painting showing St Thomas touching the Risen Jesus. Behind the reredos on the right altar is a mural of the Resurrection. The paintings, which had faded over the centuries, were painstakingly redone by mural conservationist V M Jijulal and his six-member team as part of the renovation of the church. "We used imported Italian pigment to restore the paintings, including the one depicting the



Baptism of Christ on the right wall," says Jijulal, adding that it took five months to retouch all the frescoes. He says they also painted two new murals of the Virgin and Mar Abo, the saintly bishop who established this church in the 9th century, above the side altars. "We also recreated the painting of St George on the wall above the main entrance as the original mural is not visible to believers because it is behind the main altar," Jijulal smiles.Kadamattom Church joins the ranks of historic Christian places of worship which boast remnants of the Kerala architectural style from the pre-colonial era.

According to Kochi-based Conservation Architect Rakhi Mariam Johnson, this church blends European and traditional Kerala architecture."Like many old Kerala churches, here you can find a Vernacular Kerala church with a European facade in Renaissance,

Mannerist and Baroque styles brought by Portuguese missionaries,' she says.One can safely say that based on historical records, the original Kadamattom Church, probably built of wood in the Kerala style, was rebuilt using stone and mortar during the Portuguese colonial period.

According to Fr Sunny Varghese, the vicar, the roof, ceiling and interior of the church were restored as part of the three-year renovation project spearheaded by Swiss architect Karl Damschen. "It was done without affecting the antiquity of the structure

and almost 3,000 cubic metres of wood were needed to restore the roof and ceiling," he says.All throughout the day, one can spot a steady stream of pilgrims, many of them non-Christians, to Kadamattom Church.

They all come to the tomb of Kadamattathu Poulose Kathanar in front of the altar on the left, seeking solace from their various afflictions.

People believe that he is a powerful intercessor who can work miracles. Though there aren't any historical records about this priest who used his magical powers to fight the powers of darkness, there are legends aplenty. It is said that he was born in this village in the 9th century to a poor couple."Like many old Kerala churches, here you can find a Vernacular Kerala church with a European facade in Renaissance, Mannerist and Baroque styles brought by Portuguese missionaries," she says.

#### Idukki's Muthuvan tribe keeps wild honey collection sweet, civil

**IDUKKI.** The expertise of members of the Muthuvan tribe is second to none when it comes to collecting wild honey from dangerous, rocky slopes and wild trees. However, since the five tribal settlements in the Vattavada panchayat of Idukki have several honey collecting men who extract it from the large tree holes where the bees build hives, they strictly follow a specific system to ensure proper distribution of the produce, which is also a source of their livelihood.Each collector is allotted a specific number of tree holes from which he can collect the wild honey. In the collector's absence, only a member of his family or someone he assigned can collect the honey from the spot allotted to him. The system helps with the community existence and cooperation, and the Muthuvan tribal community in Vattavada follows it without any hesitation and complaints. Says Ramaraj, the Vattavada panchayat member and a resident of the Kudalar tribal settlement, "The Shola forests that surround the settlements have wild honey in abundance, and the tribes have been collecting the produce for generations for selfconsumption and sale."He said the bees build hives in the holes of large wild trees. "Since the bees build hives only in tree holes with narrow entrance, the large holes are purposefully made narrow by placing a stone," Ramaraj told He said each settlement in Vattavada has around 20 to 30 collectors. "Another man should not harvest honey from the tree hole where a collector has placed a stone. In his absence, anyone he has assigned or his family members can harvest the honey from the tree hole," Ramaraj

said. Though wild trees dot the expanse of the Shola forests, every honey collector knows the spots assigned to him and others. However, anyone is free to harvest from newly-formed beehives. C Rajendran, a tribal community member said, Muthuvan tribals give more importance to community values and cooperation. "Our forefathers followed the system (of allotting spots and collecting honey), and now, we also follow in their footsteps," he said.

#### Campaign has desired effect: Leprosy cases decline in state

THIRUVANANTHAPURAM. For the second time since the launch of 'Aswamedham,' a statewide initiative to identify and treat leprosy patients, the number of annual new cases has remained below 500. The state has witnessed a 38% decline in new cases in 2024-25, to date, compared with 2018-19.In 2018-19, there were 783 newcases, but this number has now dropped to 486. The prevalence rate of leprosy has also declined, down from 0.15 per 10,000 in 2022-23 and 2023-24 to 0.11 in 2024-25. This progress is particularly encouraging given improved case detection since the launch of the Aswamedham campaign in 2018. However, the initiative faced setbacks during the Covid pandemic before being revived in 2022-23, leading to the detection of 559 cases that year. While cases among children have also decreased from 33 in 2022-23 and 30 in 2023-24 to 19 in 2024-25 - health experts caution that these figures may not tell the full story. They warn that undetected and unreported cases, especially among adults, could still be prevalent.

- Dr Purushothaman Kuzhikkathukandiyil, professor of paediatrics at MES Medical College, Malappuram, emphasised that stigma remains a significant barrier to accurate reporting. "Despite awareness campaigns, the stigma associated with leprosy may lead to under-reporting.
- In contrast, diseases like tuberculosis, which are notifiable, have a more robust reporting mechanism," he said. To tackle these challenges, the health department launched the sixth edition of the Aswamedham campaign on Thursday, focusing on home visits to identify hidden cases and provide timely treatment

### Firm to pull out of housekeeping services, 4k families in a fix

Noida. Nearly 4,000 families at Jaypee Greens Kosmos are in a fix as the maintenance agency, a subsidiary of the builder Jaiprakash Associates Limited, will cease its operations from Wednesday and halt manpower and financial support for housekeeping and security services. In a letter dated Nov 22, Jaiprakash Associates Limited-Facility Management Group (JAL-FMG), which has managed the society's maintenance since 2015, and Suraksha Reality Ltd asked the society's apartment owners' association (AOA) to take over the housekeeping and other services. The AOA, however, expressed its inability to manage these services as the company did not transfer the bank accounts or the balance amount collected as charges paid so far by the residents towards such services. Residents also pointed out that several towers and electricity infrastructure in the project were still incomplete, and the developer also has an outstanding water bill towards Noida Authority. If the maintenance agency pulls out, water and electricity supply are also likely to be affected. Ten of the 46 towers at the Kosmos project, part of the Jaypee Greens Wish Town in Sector 134, are still under construction. In May 2024, Suraksha officially assumed control of Jaypee Infratech Limited (JIL) through insolvency proceedings to complete the unfinished flats. Earlier this month, TOI reported that Suraksha had failed to mobilise the promised Rs 3,000 crore required for construction, deploy workers, or even establish escrow accounts as stipulated in the resolution plan. According to the approved resolution plan, passed by NCLAT in May this year, Suraksha was supposed to resume construction of flats within 90 days."In 2015, Jaypee Infratech Ltd appointed its subsidiary, JAL-FMG, for the maintenance-related services of the society. Since then, residents have been depositing all the maintenance charges to the company's account, which is about Rs 4,000 to Rs5,000 per month. Initially, while buying the flats, all the residents deposited about 1.5 lakh to the company in the name of a maintenance deposit, which is approximately Rs 80 crore. JAL-FMG has not transferred this amount to the AOA but wants it to take over all the services," Brijesh Singh, a resident of the society, said.he society's AOA was set up in 2022, but since then has not received any maintenance charges from the residents.

#### Kumbh stampede leaves painful lessons

The unfortunate incident of stampede at Prayagraj Maha Kumbh is a cause of concern for the whole nation. As per initial reports, more than a hundred million devotees had gathered in the Sangam area to take 'amrit snan' on the occasion of 'mauni amavasya'. The thread of faith and belief of the masses is so strong that everybody wants to take a holy dip at the nose point on this historic moment which has arrived after 144 years.

It is being reported that the mishap happened around 1 o'clock in the early morning hours, when some pilgrims tried to cross the barricades demarcating the path for the akharas to go for the traditional 'shahi snan'. It is a matter of satisfaction that normalcy was restored immediately and the rituals at the Sangam are going on.

Stampede during religious congregations has become almost a matter of routine in India. People take it in their stride as an act of God and the administrators also forget it after some initial jolts.In January 2015, in a stampede at a temple in Andhra Pradesh, six devotees died in an attempt to get the free-visit passes; 121 people lost their lives at Hathras in Uttar Pradesh in their quest to get a closer glimpse of their religious guru; 115 pilgrims were killed and 100 others injured in a stampede at Ratangarh temple in Madhya Pradesh during Navaratri celebrations in November 2023.

The Kumbh Mela in Uttar Pradesh witnessed a stampede in February 2013, in which 36 devotees lost their lives; while jostling to get free food and clothing at a temple in Uttar Pradesh, 63 people died due to mismanagement; in September 2008, 250 pilgrims were trampled to death at Chamundagar temple in Rajasthan during the Navaratri festival; 145 devotees died after a rumour of a landslide triggered a stampede at the Naina Devi temple in Himachal Pradesh in August 2008; 265 people died at the Mandardevi temple in Wai town, Maharashtra, because of slippery steps in January 2005. The list of such mishaps is endless. The recurrence of such human tragedies at regular intervals indicates that the system does not learn enough lessons to prevent them from happening in future.

Though it is not advisable to do a hasty post-mortem of such a human tragedy, there are some facts in the public domain which need to be discussed for preventing similar mishaps.Such discussions become imperative in view of the fact that preparations for the Maha Kumbh started years before the event. Meticulous planning was done under the supervision of the Chief Minister of the state.Pre-event assessment of the crowd as well as daily monitoring of the arrivals of the devotees during the Maha Kumbh is of utmost importance. The entry of the pilgrims in the Sangam area should have been regulated keeping in view the actual space available to accommodate them.

There should have been a mechanism in place, in coordination with police agencies of all states, to estimate the number of devotees likely to arrive at the Maha Kumbh on a daily basis. Restrictions, which were imposed on the movement of trains and buses carrying people to Prayagraj after the tragedy, should have been clamped much before the crowd swelled to full capacity. It seems many devotees did not leave the area after taking a holy dip at the nose point and were occupying the space for days together, resulting in congestion. This would have been prevented by launching awareness campaigns and circulating advisories in advance, asking people to limit their stay at the Sangam area and vacate the space for the others.

There should have been deployment of force to ensure that the circulating and bathing areas were free from unnecessary squatting. It is advisable to plan holding areas at all entry points to contain the crowds temporarily and release them in groups as per the space available on the bathing ghats. Waterways should have been planned for a quick exit of the pilgrims from the Sangam area. The entry and exit routes should have been separate to avoid traffic jam. It would have been better if areaspecific days for bathing were fixed and notified to people for the sake of their safety and security. ss

# **Kudos to cops for cracking Saif case**

#### Politicians have struck a jarring note by making all sorts of inferences and insinuations

It was in 1975 (or perhaps the first half of 1976) that I first set eyes on Saif Ali Khan. He was fast asleep on the upper berth of a coupe on a Mumbai-Ahmedabad train. 

## The letters, loves and literature of Amrita Sher-Gil Amrita had a choice of lovers and she exercised it daringly, at times, even defiantly.



Amrita Sher-Gil (1913-1941) was very fond of literature, poetry in particular. This fondness figured midway between her passion for painting and interest in music.During her early childhood in war-torn Hungary, drawing interested her a lot. She was able to draw figures on her own. But reading needed help. With help from her parents, she took to reading short pieces, lyrical poems in particular. Hungarian was her mother tongue and appealed to her.

She read not only to pass time but also to enjoy and refine her feelings. The poems of Endre Ady charmed her a lot. He was a symbolist who sought to award new meanings to social and political concerns. They were in tune with the risks that had begun to lurk over human life with the advent of industrial changes. She might not have grasped the full import of such poems then.Her interest grew into profound concern when, as a young lass, she started to live in Paris, the centre of modernism in Europe. It was only a matter of time before French became her primary mode of communication and literary expression. Charles Baudelaire shone over the literary and artistic world at the time. He wrote poems in the modern mode, setting a trend in Europe. Under his influence, love poetry turned its back on nostalgia, swooning in union and the bliss of solitude. Their place was taken up by cynicism, loneliness, nihilism and abandon. Evidences of all these factors were to be seen and encountered in every nook and corner of Paris.

Amrita did swim with the tide, but she also set her aim high. While Picasso and Braque painted Europe, she resolved to paint India in a modern way.India was then ruled by the British. It was pertinent for her to be adept in the use of the English language and also to have sufficient knowledge of its literature. Her

letters, which escaped burning at the hands of her parents, bear witness to the fact that her writing skills in English grew very fast. Her earlier letters to her admirers and lovers show that she was labouring a lot. Words and phrases were jumbled together. Her later letters show how cogent she had become in their usage. Surely, towards the end of her short and tragic life, English blossomed as her literary language with as much felicity as French had figured earlier. Regarding Punjabi and Urdu, she could converse in these languages, probably not so fluently. What about her study of English literature? As compared to her grasp of French literature, it was less in extent and depth. She relished DH Lawrence and Virginia Woolf. Like Lawrence, she believed that sensuality was the root of the creative process in a language and more so in music and painting. In its absence, the creative urge met with a false and facile end.

Virginia Woolf gave her the insight to paint from more than one perspective. The first creative work to celebrate her art is a play in

Punjabi written by Sant Singh Sekhon. Named Kalakar (artist), its protagonist is a male artist who feels that Amrita Sher-Gil is destined to raise the art scene in Punjab to the level it is enjoyed elsewhere, particularly in Europe. Her great concerns - seeing versus looking, sex versus sexuality, nakedness versus nudity - figure a lot in it. Then, a Pakistani poet of great promise penned a poem, Jamurd, on her celebrated painting, The Three Sisters. He invokes



the memory of Amrita to take birth again and turn the enraptured silence of the three sisters into an eloquent experience.Slender and short, but charming, Amrita fascinated Salman Rushdie, who introduced the spell of magical realism in the Indo-English fiction. In The Moor's Last Sigh, he both inflates her being and deflates her becoming. Its heroine, born and brought up in Europe, turns into a painter of diverse talent. She is married and her husband is a mismatch. Though she bears several

children, her charm stays intact.Even Jawaharlal Nehru gets close to Amrita Sher-Gil. He would often voice his affection for her.

Rushdie's definition of Amrita as a "line of beauty" glows as a rainbow in the play, Tumhari Amrita, starring Shabana Azmi and Farooq Shaikh. It was the Urdu translation of an American play, Love Letters, penned by AR Gurney in 1889. It had nothing to do with Amrita's life, except that she was also very fond of writing and receiving letters. Her letters hinged on the recognition of the other along with of her own self. No wonder. she was full of remorse when her parents consigned most of her letters, including several from Nehru, to the flames.Tumhari Amrita deals with the illusion and disillusion caused by letterwriting, with the lovers getting close just for a short while. With Amrita, it was otherwise. Amrita had a choice of lovers and she exercised it daringly, at times, even defiantly. She had the creative urge to realise her potential through sexual

union. There was none who charmed her for long. Most persons with whom she cohabited failed to understand how sex, turning into a play of senses, invigorated her art of painting. Rather than getting intrigued, which regrettably enough they did, it was essential for them to grasp this factor. This was the core of her being-cum-becoming and it is yet to be grasped in full. The leitmotif, lost in the past, should be elaborated, recognised and applauded.

#### Lake District

Everyone has their favourite Lake District panorama, but from the summit of Haystacks you have god-like views over the valleys of Buttermere and Ennerdale and the glittering waters of Crummock Water. On a clear day, you can even glimpse the Irish Sea.

#### North Cornwall

The rocky coast of North Cornwall contains some of England's most magnificent, surf-washed beaches. Watergate Bay, near Newquay, has two miles of golden sand, pounded by Atlantic rollers and backed by cliffs and caves. Peregrine falcons, gulls and fulmars wheel overhead and you can spot strawberry anemones and crabs among the rock pools. Cotswolds

The High Street, with its 17th century covered market house, is particularly lovely-summed up in the words of the English historian G.M. #### Ross and Smith Island Beach

A boat ride of 25 minutes off Diglipur gets you to the serene twin islands called Ross and Smith. The beaches here promise uncluttered vistas and soft waves sweep up along the shore. The islands are actually separated by a narrow stretch of sand, technically making it a single beach.

#### Lalaji Bay Beach, Long Island

For an unhurried experience, visit Lalaji Bay beach in Long Island. If nothing else, you are bound to see dolphins leaping up out of the sea. The beach lies six km from the main jetty, and can be reached by a short

#### trip. Radhanagar Beach, Havelock Island

The Radhanagar beach has won many accolades in the travel world-an evening of sunset watching here and you will understand why. A sprawling, flat, soft bed of sand, it can accommodate hundreds of people during high season. There are a few pavilions to sit at, with the buzz of beach sellers and a small market leading up to it. But to avoid the entire bustle, walk towards the far end on the right.

#### **Elephant Beach**

One of the most coveted and isolated sandy spots, Elephant beach is a pit stop for snorkellers. You'll need to take a boat to get here, but once you arrive, expect pristine water and untouched white sand. There is a bit of infrastructure here too, so carry food and water if you are planning on spending the day. Boats are available from Havelock Island.

#### hike or small dinghies. Wandoor Beach

Wandoor is one of the closest beaches with tourist access, since it lies in Port Blair. Expect a splash of colour during high season, with tourists dotting the pale sand. Boats to Jolly Buoy Island leave from here.

#### Aamkunj Beach, Rangat

The Aamkunj beach in Rangat is known as a popular turtle nesting ground. So if you are a keen environmental enthusiast, this is the place you should be heading. A long boat ride

through the islands (or with multiple crossings if you take the ferry) is the only way to get here from Port Blair.

#### Mayabunder

Avis and Karmatung beaches in Mayabunder are situated in the north part of Middle Andaman. Relatively quiet, you will not find the buzz of Havelock here-which is a blessing if you want to avoid the tourist clutter.

#### **Casurina Beach, Diglipur**

Diglipur is the main base camp for those who want to hike up to Saddle Peak in the Andaman Islands. An added advantage of this long trip from Port Blair (300 km by road), is that you can relax by the Casurina beach here. It can be hours before you will bump into anyone.

So, who's winning? They are suddenly contrite. "Delhi will prefer commitment, not corruption!" The New Delhi constituency has over 1,00,382 voters, including 45,713 women. Former chief minister Arvind Kejriwal won thrice from here. So did one of his predecessors, the late Sheila Dixit of Congress.

The BJP made it only once when Kirti Azad returned victorious over three decades ago. Kejriwal faces a stiff challenge from Pravesh Singh Verma, son of former CM Sahib Singh Verma, and Sandeep Dikshit, son of Sheila Dikshit. It's a no-holds-barred contest. The catch is that many middle-class voters remain undecided.Raghuvar Nirala, who runs an eatery on Mandir Road, sums up the mood: "The voters of our category, who constitute nearly 10.12% of voters, are still in a dilemma. We cannot overlook Kejriwal as he has left an impression on the voters, but the BJP's Verma has made the race tough."

## PM condoles deaths in Washington plane crash: We stand in solidarity with US

New Delhi. Prime Minister Narendra Modi on Friday said he was "deeply saddened" over the loss of lives in a midair collision between an American Airlines plane and a US Army helicopter in Washington DC. He said India stood in solidarity with the people of the US.All 67 people - 64 aboard the American Airlines plane - that collided with a Black Hawk helicopter, carrying three US Army personnel, were feared dead in what could be the worst US aviation disaster in almost a quartercentury."Deeply saddened by the loss of lives in the tragic collision in Washington DC. Our heartfelt condolences to the families of the victims. We stand in solidarity with the people of the United States," PM Modi tweeted and tagged US President Donald Trump in the post.

The midair collision occurred when the American Airlines flight (Flight 5342) coming from Wichita, Kansas, was approaching the runway of Ronald Reagan Washington National Airport. The flight collided with the chopper engaged in a training exercise and both the aircraft plunged into the Potomac River bordering the airport.

Emergency personnel found the body of the plane upside down in three sections in the river and the wreckage of the helicopter. The crash occurred in some of the most tightly controlled and monitored airspace in the world, just around five kilometres south of the White House and the Capitol.Officials were yet to ascertain the reason behind the collision.Investigators from the National Transportation Safety Board (NTSB) and the Federal Aviation Administration (FAA) were investigating the circumstances that led to the tragedy.

# Delhi HC sets aside Rs 2.5 crore bail condition for Rau's CEO

NEW DELHI. The Delhi High Court on Thursday set aside the Rs 2.5 crore financial condition imposed on Abhishek Gupta, CEO of Rau's IAS Study Circle, while granting him interim bail. The case pertains to the tragic deaths of three UPSC aspirants in the basement of the coaching institute in Old Rajinder Nagar in July 2024.Justice Vikas Mahajan ruled in favour of Gupta, directing the trial court to reconsider his bail plea purely on its merits. The hearing on his interim bail is scheduled for Friday

before the Rouse Avenue court. Earlier, the trial court had granted Gupta interim bail on September 23, 2024, but imposed a condition requiring him to

On December 7, 2024, Gupta's counsel had informed the trial court that the financial condition was under challenge in the High Court.

#### India Tops Global List In **Passenger Loads On Domestic Flights: Report**

- New Delhi. India's domestic flights have recorded a passenger load factor of 86.4 per cent in 2024, to forge ahead of the US and China which figure at the second and third spot respectively, according to the latest report of the International Air Transport Association (IATA).India's fast-growing aviation sector has carried 16.3 crore passengers on domestic flights during 2024. according to figures compiled by the country's Directorate General of Civil Aviation (DGCA).
- India achieved a passenger load factor of 86.4 per cent, the highest among all domestic markets, the IATA report states. The corresponding figure for the US was 84.1 per cent and China (83.2 per cent). Brazil with a passenger load factor of 81.9 per cent was placed at the 4th rank followed closely by Australia (81.8 per cent) and Japan (78 per cent).Globally both domestic and international full-year demand reached record highs for passenger numbers and load factors.
- The international full-year traffic in 2024 increased 13.6 per cent compared to 2023, and capacity rose 12.8 per cent. The total full-year traffic in 2024 (measured in revenue passenger kilometers or RPKs) rose 10.4 per cent compared to 2023.
- This was 3.8 per cent above pre-pandemic (2019) levels.
- Total capacity, measured in available seat kilometers (ASK), was up 8.7 per cent in 2024. The overall load factor reached 83.5 per cent, a record for full-year traffic, according to the IATA report.
- It also points out that December 2024 was a strong finish to the year with overall demand rising 8.6 per cent yearon-year, and capacity grew by 5.6 per cent.International demand rose by 10.6 per cent and domestic demand by 5.5 per cent. #### Lake District

Everyone has their favourite Lake District panorama, but from the summit of Haystacks you have god-like views over the valleys of Buttermere and Ennerdale and the glittering waters of Crummock Water. On a clear day, you can even glimpse the Irish Sea.

#### North Cornwall

The rocky coast of North Cornwall contains some of England's most magnificent, surf-washed beaches. Watergate Bay, near Newquay, has two miles of golden sand, pounded by Atlantic rollers and backed by cliffs and caves. Peregrine falcons, gulls and fulmars wheel overhead and you can spot strawberry anemones and crabs among the rock pools.

The lovely market town of Chipping Campden is quintessential Cotswolds, all golden stone, mullioned windows and gracious houses. The High Street, with its 17th century covered market house, is particularly lovely—summed up in the words of the English historian G.M. Trevelyan as, "the most beautiful village street now left on the island".

#### North Norfolk

There is a haunting quality to the creeks and salt marshes of North Norfolk, set under vast dome-like skies. Explore them safely by walking from Burnham Overy Staithe along a causeway to a vast dune-backed beach, or by taking a boat trip from Morston to see the resident seal colony at

Blakeney Point.

#### Exmoor National Park Exmoor National Park, Wh

extends across north Devon and west Somerset, contains wonderfully varied landscapes of wild heather moorland, heath and deep wooded combes of ancient oaks. From windswept Dunkery Beacon, the highest point, you can see swathes of south west England laid out below you—moors, rolling fields and the glittering sea beyond. Look out for Exmoor ponies and red deer, and on a clear night, the stars shine like diamonds. London

#### Northumberland

Through summer and winter, they'd have stared out across this same landscape to the Tyne Valley and Scottish borders, perhaps longing for the olive groves and cypress trees of home.

#### Settle Carlisle railway

The Settle Carlisle railway offers some of the best countryside views of any train journey in England. Get off at Dent Station and you can see the Yorkshire Dales national park spread out below you. Wild moorland drops to a zigzag valley dotted with the occasional cottage. Cloud shadows race across the hilltops and the cry of sheep drifts on the wind.

#### New Forest

The New Forest is a mix of heath and moor, bogs and ancient pasture, but walk or cycle among the dappled glades, arching tunnels of beech trees and stands of redwoods and ancient trees to see it at its most beautiful. Especially in spring, when leaves are soft, vibrant green, ponies and foals graze in clearings and bluebells and rhododendrons bloom in Roydon Woods.

#### **Peak District**

Kinder Scout and the high moorland of the Dark Peak are the images that come to mind when you think of the Peak District. But as viewers of BBC's The Village will have seen, it's the region's green roller-coaster hills studded with sheep and the steep valleys dropping to splashing rivers and streams that are every bit as beautiful.

## India will build world-class Al model: IT minister

NEW DELHI. India will develop a world-class foundational AI model that will compete with the best global models, including ChatGPT and Deepseek R1, said Minister of electronics and information technology Ashwini Vaishnaw on Thursday.he minister while speaking to the press also highlighted that the government's AI compute facility would be "the most affordable" in the world. The minister further stated that at least six major developers and start-ups are expected to build foundational models within the next 8-10 months, with an optimistic estimate of just 4-6 months."Making modern technology accessible to everyone, that is the economic thinking of our PM... Ours is the most affordable compute facility, at this point of time," Vaishnaw said.

The minister outlined the next steps in India's AI blueprint, which includes the deployment of 18,693 Graphics Processing Units (GPUs) by empanelled bidders, including companies such as Jio Platforms, CMS Computers, Tata Communications, E2E Networks, Yotta Data Services, and others. Additionally, the government plans to establish an AI safety institution, with 8 projects already approved under this initiative.

The government is also seeking proposals to develop India's own foundational AI models tailored to the country's context, languages, and culture.

These models will use datasets that are "for our country, by our country, and for our citizens," with an emphasis on removing biases. As part of the IndiaAI Mission, the government had earlier approved an outlay of Rs 10,372 crore to strengthen India's AI ecosystem, with a key focus on enabling 10,000 GPUs for AI compute infrastructure. When asked about potential impacts of the US' GPU and AI chip export restrictions on India's AI mission, Vaishnaw reassured that India is regarded as a trusted partner globally.

'India respects intellectual property rights and technological considerations. That's why we have signed memorandums of understanding (MoUs) on several important technologies," the minister stated.

#### Survey may address tough economic questions

cThe much-awaited Budget session of the parliament kicks in with the tabling of the Economic Survey report in Parliament on Friday. The economic survey report, an annual document prepared under the guidance of the CEA, is a precursor to the Budget. It gives a glimpse of the economic health of the country in the ongoing financial year, and lays down a path for policymakers for the next year. Even though the finance ministry and its bureaucrats maintain that the preparation of the Economic Survey report is an independent process and has no bearing on the budget presented a day later, the survey does prepare for things to come in the budget. With the economy going through tough times - GDP growth slowing down, consumption and private investments failing to take off and employment generation facing unprecedented challenges amid the rise of AI and automation - the Economic Survey is expected to find answers to some of those questions."This annual publication (of Eco survey) is a definitive source for derstanding the Indian economy, its challenges and likely solutions through the lenses of actual practitioners," says Debopam Chaudhary, chief economist, Piramal Enterprises. He expects the survey to lay out a plan to create fiscal space for funding new capex; underline low or negative economic impact from freebies and make a case for one nation one election.Lekha Chakrabarti, an economist and a professor at National Institute of Public Policy and Finance (NIPFP), says the Economic Survey will focus on "economic growth with equity" towards a Viksit Bharat 2047. She says the country does not have a comprehensive document yet on the analytical framework and the road map towards Viksit Bharat 2047, and she hopes this Economic Survey will present that comprehensive framework and the significant components of our 'graduation dreams' towards a developed country by 2047.

# Apple expanding manufacturing in India to meet domestic demand, global export needs: Tim Cook

#### The company has been diversifying its manufacturing from China to India, largely due to the ongoing trade tensions between the U.S. and China.

NEW DELHI. Apple CEO Tim Cook on Friday said that the company is expanding its manufacturing in India to meet both domestic demand and global export needs.During a call with investors discussing the company's quarterly results, Cook also expressed his enthusiasm for the Indian market. In 2024, Apple surpassed the Rs 1 trillion

mark for iPhone exports from India, achieving record outbound shipments of USD 12.8 billion (Rs 1.08 trillion), reflecting a 42% year-on-year increase."Yeah, if you look at the manufacturing we do there, we do manufacturing both for the domestic market, and we export. And so, in -- our business needs a certain economies of scale for it to make sense to manufacture in-country. And so, that really means that we're going to be both a use for the domestic market and an export market," said Cook.The company has been diversifying its manufacturing from China to India, largely due to the ongoing trade tensions between the U.S. and China. Apple now aims to source around 25% of its total manufacturing from India.Cook also revealed that India set a new record for the December quarter and that the company is planning to open four more stores in the country. While Apple currently holds a

modest share in India, it aims to grow its presence in the market.



"We have great results in a number of emerging markets. And as you know, from past calls, I'm particularly keen on India. India set a December quarter record during the quarter. And we're opening more stores there," said Cook. Additionally, Cook stated that the iPhone was the top-selling model in India during the quarter. India, which is the

> second-largest smartphone market in the world and the third-largest for PCs and tablets, presents a significant opportunity for Apple, given its modest current share in these markets.

> And we have very modest share in these markets, and so I think there's lots of upside there," he added.Apple reported a remarkable USD 124.3 billion in revenue for the year-end holiday quarter, although sales growth fell short of market expectations as the iPhone

faces intense competition, particularly in China. However, the company's shares surged more than 3% in afterhours trading on Thursday after it forecast higher-than-expected sales for the upcoming quarter.

Finance under the guidance of the Chief Economic Advisor, provides a snapshot of the country's economic health for the current financial year and outlines a path for policymakers in the year ahead.With the economy facing challenges-slowing GDP growth,

#### Demand for hybrid cars will remain strong in 2025

NEW DELHI: Japanese auto major Toyota is confident that demand for hybrid vehicles will remain strong in India going forward owing to its practicality and consumer acceptance.

"Two years back we introduced the strong hybrid vehicle and the customers have accepted it. There are still convictions that in terms of practicality, hybrids are going to stay here. We believe that demand for strong hybrids will remain strong in 2025 as well," Toyota Kirloskar Motor & Lexus India, Deputy Managing Director - Sales-Service-Used Car, Tadashi Asazuma told this publication.

As per the last data available, sales of hybrid cars, including both strong and plug-in versions, increased by 27% from January to July 2024, reaching 51,897 units compared to 40,811 units during the same period last year. materialise, forcing it to buy time from creditors after paying interest. A large portion of the debt was maturing last May. As per a source in the know of the ongoing discussions, the Shapur Mistry-led group is in advanced stage of talks with four alternative asset managers -- Davidson Kempner and Cerberus Capital, along with its existing investors Farallon Capital Ares Management, who are willing to partially rollover their debt maturing later this year. Sterling Investments, the main holding company of the group, holds a little over 9% in Tata Sons. The group has been looking for fundraising since early 2024 but without much success. Most of its existing debt was maturing in May 2024. Since then it got an extension

from creditors by paying interest. Most of the group's debt is linked to the group's promoter entity, Sterling Investments, which had secured \$2.6 billion in 2021 from alternative investment manager Ares Management and the hedge fund Farallon Capital with a tenor of 3.5 years."The group is looking to refinance its debt with fresh funding from Davidson Kempner and Cerberus Capital and partial financing from existing creditors Farallon and Ares who are willing to roll over a portion of their debt maturing by May," the source explained.

He added that if they experience a rise in input cost, they will have to pass it to end consumers."While we are producing in India, there are some cars which we bring from Japan. This is where we are facing the impact," stated Asazuma as the rupee experienced a consistent depreciation in recent months. Asazuma also informed that TKM would be coming up with a new mobility service company for their used car division. Toyota, at present, has three outlets for used cars which they expect to double this year. Toyota Kirloskar Motor Executive Vice President & Country Head Vikram Gulati said that the company has a multi-pathway corridor ranging from battery electric to hydrogen, plugin hybrid and flex fuels to tackle the problem of carbon emission.

# Sebi bans finfluencers from using live stock prices, tightens crackdown on illegal advisories

MUMBAI. The markets regulator Sebi, which has been after the so-called financial influencers or finfluencers who are tricking the gullible public into investing in stocks they get paid to recommend, for long, has delivered a major blow to them by restricting their use of live-market data/prices in their what they call educational content. The key prohibitive measures include not allowing them to use real-time stock price data and using the names of the scripts they are talking up/down directly or indirectly by using code names. The regulator has warned of strict penalties including cancellation of their licence for rule violations. This move is expected to end the illegal advisory businesses that many finfluencers operate without Sebi registration.Sebi first restricted associations between registered and unregistered entities in an October 2024 circular, and the latest circular further tightens the rules.Under the new rules, which the Securities and Exchange Board announced in a circular last night, finfluencers can only use stock prices with a three-month lag, effectively preventing

them from offering real-time trading tips disguised as education. They are also banned from using the name of the stock directly or indirectly through employing a code."A person engaged solely in education shall mean that such person is not engaged in any of the two prohibited activities. Such person should not be using the market price data of the preceding three months to speak/talk/display the name of any security including using any code name of the security in his/her talk/speech, video. ticker, screen share etc indicating the future price, advice or recommendation related to security/securities," says the circular, adding these "regulations have come into force wth effect from August 29, 2024."The following are the key points in the latest circular: Finfluencers/self-styled stock market educators cannot use live stock prices they can use only data with a three-month lag; registered market entities cannot associate with finfluencers in any way that involves monetary or non-monetary compensation; investor education is allowed, but educators must not give

claims without Sebi's approval; finfluencers cannot use stock names, codes, or price data from the past three months in any form that could imply



investment advice; and any entities found violating these rules risk penalties/suspension/cancellation of their Sebi licence."It is the responsibility of the persons regulated by Sebi to ensure that any person associated with them or their agent, directly or indirectly, does not engage in any of the above-mentioned two prohibited activities, directly or indirectly," the circular warned.

The mushrooming of so-called finfluencers on a slew of social media platforms has

investment advice or make performance blurred the lines between real financial education and investment advice on the sly, leaving the gullible public at risk as it has become too complicated to distinguish credible sources from

misleading ones. However, with the latest move, which bans access to live data, many of these financial crooks are likely to find it difficult to retain subscribers and students.Sebi norms will be violated if any entity regulated by Sebi is indirectly associated with an entity engaging in the above-mentioned prohibited activities, the circular said, adding the restrictions will apply to

advertisements, branding and promotional materials sourced through third-party marketing agencies as well."Persons regulated by the Sebi and their agents have been advised through the October 22, 2024 circular to terminate their existing contracts, if any, with persons engaged in any of the abovementioned two prohibited activities, directly or indirectly, within three months from the date of issuance of that circular," Sebi said.

In the recently concluded Border-Gavaskar Trophy, the pacer picked up 18 wickets from 5 Tests, helping captain Pat Cummins bag a sensational 4-1 win over India in the series. Stare has spoken about his love for Test cricket before. Back in 2022, he had spoken about extending his red-ball career in international cricket.


