ISRO again postpones ambitious space docking experiment: 'Satellites safe'

New Delhi, Jan 08: The Indian Space Research Organisation (ISRO) on Wednesday again postponed its ambitious space docking experiment using



two satellites in orbit. The event was scheduled for the morning of January 9. Earlier, it was postponed from January 7 to January 9. "While making a maneuver to reach 225 m between satellites the drift was found to be more than expected, post non-visibility period," ISRO wrote in an update on X. "The planned docking for tomorrow is postponed. Satellites are safe." ISRO is planning to carry out its ambitious space docking experiment using two satellites in orbit If the ISRO succeeds in its mission, India will become the fourth country in the world to have space docking technology. ISRO had launched the two satellites -

SDX01 (Chaser) and SDX02 (Target) - as part of the mission on December 30 with the help of PSLV C60 rocket from Satish Dhawan Space Centre in Sriharikota. The two small spacecraft weighing about 220 kg each were injected into a 475-km circular orbit as intended. ISRO said the two spacecraft in the PSLV rocket- Spacecraft A (SDX01) and Spacecraft B (SDX02) would be placed in an orbit that would keep them 5 km apart from each

other. Later, scientists at ISRO headquarters would try to bring them closer up to 3 metres which would subsequent ly lead them to merging together at an altitude of about 470 km above Earth. The in-space docking technology would be essential for taking up India's ambitions in space including sending humans to the Moon, bringing samples from there, and also building and operating the country's own space station-Bharatiya Antariksh Station.

Local court to hear Jama Masjid-Harihar temple case on March 5

Lucknow, Jan 08: Sambhal mosque row: A local court in Sambhal has fixed March 5 as the next hearing date in a case related to the Mughal-era Shahi Jama Masjid and its survey. Shakil Ahmad Wari, the advocate representing the Muslim side, told reporters that they have filed a copy of the Supreme Court order directing all lower courts not to entertain new suits seeking surveys of any place of worship until further orders. "The Supreme Court has directed all the lower courts not to entertain new suits seeking surveys of any place of worship until further orders. We have filed a copy of the said order in the court, which fixed March 5 as the next date of hearing," Shakil Ahmad Wari quoted as saying by news agency PTI. On the Hindu side's claim that the mosque was built over an ancient Harihar temple, Wari said the court would decide. "We will prove in the court that it was not a Harihar temple but the Jama Masjid. We have all the evidence," he added. "We filed an application with the court demanding their opportunity to reply should now end. Now the matter will be heard on March 5,' he said. A survey of the Shahi Jama Masjid was conducted on November 19 following orders from a court that came on a petition filed by Supreme Court lawyer Vishnu Shankar Jain claiming that a temple existed at the site earlier. Violence broke out on November 24 when the mosque was being surveyed again. Four people were killed and others injured in a clash between protesters and police. According to police, personnel were injured in the incident.

Delhi court defers judgment on case linked to 1984 riots killings in Saraswati Vihar

New Delhi, Jan 08: A Delhi court is likely to deliver on January 21 its verdict in a 1984 anti-Sikh riots murder case against former Congress MP Sajjan Kumar. The verdict in the 1984 anti-Sikh riot murder case against former Congress MP Sajjan Kumar is anticipated to be delivered by a Delhi court on January 21. The case is linked to the alleged killings of two men in the Saraswati Vihar area during the riots. Special Judge Kaveri Baweja, who was scheduled to pass the order on Wednesday, deferred the pronouncement. Kumar, currently lodged in Tihar central jail, appeared before the court via videoconferencing. The court had reserved the judgment after hearing the final arguments in the case related to the killings of Jaswant Singh and his son Tarundeep Singh on November 1, 1984. Though the Punjabi Bagh police station initially registered the case, a special investigation team subsequently took over the investigation. According to the prosecution, a huge mob armed with deadly weapons, resorted to large-scale looting, arson and destruction of properties of Sikhs to avenge the assassination of former prime minister Indira Gandhi.

Commenting on woman's body structure amounts to sexual harassment

New Delhi, Jan. 08: The Kerala High Court has held that a comment on a woman's "body structure" is a sexually coloured remark which would constitute penal offence of sexual harassment. The ruling by Justice A Badharudeen came while dismissing a former Kerala State Electricity Board (KSEB) employee's plea to quash the sexual harassment case against him filed by a woman staffer of the same organisation. The woman had alleged that the accused used vulgar language against her from 2013 onwards and then in 2016-17 began sending objectionable messages and voice calls. Despite complaints against him to the KSEB and the police, he continued sending her objectionable messages, she had claimed. Following her complaints, the accused was booked for the offences under sections 354A (sexual harassment) and 509 (insulting modesty of a woman) of the IPC and section 120(o) (causing nuisance through any means of communication by undesirable call, letter, writing, message) of the Kerala Police Act. Seeking to quash the case, the accused claimed that mere reference that a person has a nice body structure could not be attributed to sexually coloured remarks within the ambit of section 354A and 509 of the IPC and section 120(o) of the Kerala Police Act.

Akhilesh alleges BJP role in Sambhal violence, calls it a government plot

Lucknow, Jan. 08: Samajwadi Party (SP) chief Akhilesh Yadav on Tuesday unleashed a sharp critique of the Bharatiya Janata Party (BJP), accusing the ruling party of engineering the recent violence in Sambhal as part of a "government conspiracy." The incident, which claimed five lives, was not a communal riot but a "pre-planned act" allegedly executed with the involvement of local administration, Yadav charged. Speaking at a press conference, Yadav alleged that the BJP was stoking unrest and targeting innocent citizens in Sambhal. "When an SP delegation tried to visit Sambhal, they were blocked by authorities. What is the government hiding?" he asked. According to him, the violence was deliberately orchestrated to disturb communal harmony in Uttar Pradesh. The SP leader also condemned a controversial survey conducted at the Shahi Jama Masjid, a Mughal-era mosque, calling it a ploy to implicate innocent people. "The Places of Worship Act, 1991, prohibits such surveys. What urgency drove this? It was a calculated act that led to violence," he asserted. Leader of Opposition Mata Prasad Pandey bolstered Yadav's claims while presenting a report on the incident. He alleged that the mosque survey team included BJP members and accused the police of using excessive force. "Instead of resorting to tear gas, they



fired bullets, escalating tensions and disrupting peace," Pandey said. The violence broke out on November 24 when a team from the Archaeological Survey of India (ASI) arrived

at the Shahi Jama Masjid. The SP has alleged that the survey, conducted despite legal constraints, was part of a broader scheme to ignite communal unrest. Yadav didn't mince words while criticizing the BJP's handling of the situation. "Life has no value under this government. This is a heartless regime devoid of empathy. Justice and public grievances are meaningless to them," he remarked. He also took aim at the BJP for alleged corruption and its neglect of backward classes, Dalits, and minorities (PDA). "Even BJP leaders are accusing each other of corruption. Their internal strife is visible in both Delhi and Lucknow," Yadav said. Shifting focus to the by-elections for nine Assembly seats, Yadav accused the BJP of manipulating the electoral process. "The administration actively suppressed voting. People were intimidated, and police prevented them from reaching polling booths. Let the media visit Milkipur to witness the BJP's idea of democracy," he alleged. The SP chief also targeted Chief Minister Yogi Adityanath over allegations of cow slaughter.

Regarding the dinner meeting hosted by the MLAs from SC/ST community being cancelled, he said he has no information about it. Karnataka Home Minister G Parameshwara on Tuesday said that the dinner meeting of Congress leaders, ministers and lawmakers from SC/ST communities that was called on January 8, has been postponed following an instruction from a AICC general secretary in-charge of Karnataka, Randeep Singh Surjewala.

HYDRAA gets first dedicated police station

HYDERABAD. The Hyderabad Disaster Response and Asset Protection Agency (HYDRAA) now has its own police station to address cases of land grabbing, encroachments, public property damage, defacement and other asset protection matters within its jurisdiction, which spans the ORR limits. An officer of Assistant Commissioner of Police (ACP) rank will serve as the Station House



Officer, with cases registered upon instructions from the HYDRAA Commissioner. The state government issued orders on Tuesday for the creation of the HYDRAA Police Station at B-Block, Buddha Bhavan, Secunderabad. This station, sanctioned via GOMs No108 dated September 25, 2024, will operate within the Commissionerate's territorial limits, with personnel adjusted on a deputation basis. The notification, citing provisions from the Criminal Procedure Code, 1973, and the Bharatiya Nagarik Suraksha Sanhita, 2023, officially declared the establishment of the station to streamline the filing and processing of HYDRAA-related cases. HYDRAA Commissioner AV Ranganath emphasized that this dedicated station would enhance efficiency, addressing delays caused by the burden.

VMC launches garbage loader points

VIJAYAWADA. The Vijayawada Municipal Corporation (VMC) has launched a pilot project to enhance sanitation and ensure a healthier environment by introducing garbage loader points in high-waste zones like vegetable markets and residential areas. The initiative was unveiled on Tuesday by VMC Commissioner Dhyanchandra HM during an inspection of the first loader centre on Sambamurthy Road, a busy area near Rythu Bazaar. Under the project, open loader bins have been relocated to specially constructed sheds in designated locations. This measure aims to eliminate the unsightly and unsanitary conditions caused by waste accumulation in open spaces. Dhyanchandra explained that the enclosed bins would prevent open dumping, with waste collection vehicles directly accessing them for timely removal. If the project succeeds, similar facilities will be set up across all city circles.During his visit, the VMC Commissioner also inspected the cattle shed near the Excel Plant, designed to manage stray cattle. He directed Veterinary Assistant Surgeon Dr B Somasekhar Reddy to enforce regulations by relocating stray cattle and penalising negligent owners. He reviewed the performance of hook loader vehicles to improve waste collection efficiency and emphasised daily segregation of dry waste at the Material Recovery Facility (MRF). He also visited the garbage transfer station, where he inspected toilets built for drivers and stressed their proper maintenance under the Swachh Survekshan initiative.Officials present during the inspections included Additional Commissioner (Projects) Dr D Chandrasekhar, Superintending Engineer (Projects) P Satyakumari, Medical Health Officer Dr Suresh Babu.

CHENNAI. If you grew up in Chennai, chances are the Chennai Book Fair was one of your earliest glimpses into a world brimming with stories. Maybe it was those class trips where you pooled pocket money to buy a new book or the annual family outing where someone would inevitably negotiate for an extra bag to carry the haul. For me, it was my granddad who used to take me, and I'd excitedly grab whatever caught my eye - often a book that seemed cool at the time, like a shiny new Tintin comic. Walking through

the fair now, I can't help but feel that same rush of excitement, almost as if I'm back to those simple moments of discovery.

The atmosphere in the halls may have evolved over the years, but the fair still holds onto that same delightful chaos. Stalls fill every corner, offering something for every taste — from adventurous escapes to books that ignite curiosity. In the midst of it all, a child's voice rises, filled with excitement, as he tugs at his mother, begging, "Amma, idhu mattum vaangitha ma!" pointing to the latest Geronimo Stilton book. These little moments capture the essence of the fair, which, this year, showcased three particular stalls that stand out. The first stop was Kavitha Publications, a stall that instantly felt like it belonged in the fair, bridging old traditions with fresh narratives. C Kavitha, the managing director, explains the legacy of her company, started by her father, S



Chockalingam, who transitioned from printing media to publishing. "We've been in this for over 30 years, since my father started the company. His first book was about MGR, and we've grown ever since," Kavitha shares with a smile.he company offers a mix of modern releases alongside classic titles from Tamil literature, like works by Jayakanthan and Vaasanthi, as well as unique cultural treasures like books on Ilaiyaraaja's music. She adds, "We even bring ancient works to the fair. Whatever we have, we make sure to showcase it. If there's a title that runs out of stock, we reprint specifically for fairs like these."With a stock of about 100 titles, the fair always sees a new batch of books from Kavitha Publications

— a sign of the company's commitment to nurturing Tamil literature, both ancient and contemporary. Kavitha notes that "Since the pandemic, we've only seen about 50 new titles, but this year it's picking up again."

Not too far down the aisle, People's Publishing House has its own draw. An entirely different world, yet just as captivating. Established in 1947, PPH's political and intellectual focus couldn't be more timely, and yet, it's been around long before today's discussions on democracy and leftwing politics came into vogue. Rajan PK, an editor at the stall, explains,

We've been serving left publications long before independence, providing books in major Indian languages and

now here, in Tamil. We're popular among young people - IT professionals, those studying for UPSC exams. We offer books like Outsider in the White House by Bernie Sanders and others on topics ranging from economics to philosophy.'

Despite only being in their second year at the book fair, Rajan highlights that they were already surpassing sales from last year. "We broke even in the first six days this time, which is fantastic

We cater to all kinds of readers, from casual ones interested in Indian and European philosophy to those wanting to understand political science and economics in a democratic context." The stall offers a wide spectrum of left-wing and democratic literature — essential reading not just for academics but also for anyone interested in engaging deeply with the current social and political climate.

ASHA workers start indefinite strike in Bengaluru, demand fair

wages

BENGALURU. Thousands of ASHA (Accredited Social Health Activists) workers gathered at Freedom Park here on Tuesday for the indefinite strike urging the government to fulfill their various demands. These workers who are the face of the healthcare delivery in rural and urban areas are urging the government to give a fixed monthly honorarium of Rs 15,000, along with an additional Rs 2,000 for citybased ASHA workers to meet their rising living costs.Members of Karnataka State United ASHA Workers Union (Karnataka Rajya Samyukta Asha Karyakarteyara Sangha) affiliated to All India United Trade Union Centre (AIUTUC) said that there is no question of withdrawing the protest until their demands are met by the government.Speaking to TNIE, State Secretary of AIUTUC, D Nagalakshmi said, "ASHA workers are the backbone of the healthcare delivery in Karnataka fighting against diseases, malnutrition, child mortality and taking care of maternal health. They play a crucial role in implementing various central and state government health programs. However, they do not have a fixed honorarium. Hence, our major demand is to fix a monthly honorarium of Rs 15,000."She said that they have been fighting for fair treatment for nearly a decade, and lamented that their protests and demands have not been considered yet. Recalling the protest in February 2024, Nagalakshmi said they withdrew the protest after assurance from CM Siddaramaiah. "We went back with an assurance that our demands will be met. Since then, multiple high-level meetings have been held but our demands haven't been met," she said. The State Secretary of SUCI (Communist) said that the state government, which proclaims to be pro-woman, tried to suppress the workers, and that they would be removed from their jobs if they took part in the indefinite protest.Releasing pending salaries, increasing retirement benefit to Rs 5 lakh, considering ASHA workers as government employees, providing ESI and PF, providing smartphones for mobile based works, annual comprehensive health checkups and free treatment for serious illness.

This LP school farm yields fresh food for thought

KOCHI. After class hours, Mercy N George and her students at Government LP School, Neerampuzha, head to the plot of land near the school premises. The children make their way through rows of tomatoes, spinach, pumpkins, ash gourd, cabbage, mangoes, guavas, rambutans, and more.Come harvest time, the little ones here carry baskets and handpick the best yield from the lot. This initiative isn't part of the curriculum. This small school, with just 62 students, has set a healthy example, cultivating fresh produce under the guidance of Mercy and members of the PTA. The 25-cent farm is home to a variety of fruits and vegetables, including noni plants, plantains, jackfruit, and nutmeg, achieving a level of selfsufficiency. The idea of starting a pesticide-free farm near the school wasn't just about the 'goorganic' trend — it arose from a deeper need. Woman dies as shop goes up in flames, husband escapes

Tuesday morning while her husband managed to escape unharmed.KS Cloth House and Readymade Garments went up in flames around 3.40am. Fire department officials said they received a call at 3.47am and dispatched four fire tenders to the spot. The shop owner, Rohit Sharma, and his wife Vinita were sleeping on the ground floor when they noticed sparks from a suspected short circuit on the first floor, which served as their storage area.

When they went upstairs to find out what had happened, a few bundles of cloth had already been engulfed by flames by then. The fire spread quickly through the inflammable material and trapped both of them.

While Sharma managed to rush out of the building, Vinita was unable to make it."Sharma lived about 300 metres from the shop with his family, but routinely slept inside his store to prevent theft. This was their usual practice — closing the shop at 10pm, going home for dinner, and returning around midnight to sleep there," said an officer from Sector 63 police station. The fire fighters found Vinita unconscious and rushed her to a nearby hospital, where she was declared dead on arrival. It took about an hour for the fire department team and cops to douse the flames.

All hell will break out if hostages in Gaza are not freed': Trump warns Hamas

WASHINGTON: US President-elect Donald Trump has warned that all hell will break out in the Middle East if the hostages being held by Hamas are not released by Inauguration Day, repeating the threat four times. Trump did not elaborate on what actions he might take if the captives are not released by the time he takes office.Officials say about 100 hostages, including some Americans, who were seized on October 7, 2023, remain captive in Gaza, though they believe many of them may have died in captivity.

All hell will break out.

If those hostages aren't back, I don't want to hurt your negotiation, if they're not back by the time I get into office, all hell will break out in the Middle East, Trump told reporters at a news conference in Mar-a-Lago, Florida. Trump will be sworn in on January 20 as the 47th President of the United States.

He was responding to a question on the status of negotiations with Hamas on the release of American hostages. His Special Envoy to the Middle East Steven Charles Witkoff, who has just returned from the region, told reporters that they are on the verge of it.

I believe we've been on the verge of it. I don't want to discuss sort of what's delayed it, no point in being negative in any way. But I think it's the president, his stature, what he's said he expects, the red lines he's put out there, that's driving this negotiation, Witkoff said.

Noting that they are making a lot of progress, he said: I don't want to say too much because I think they're doing a really good job back in Doha.

I'm leaving tomorrow to go back to Doha. But I think that we've had some really great progress and I'm really hopeful that by the inauguration we'll have some good things to announce on behalf of the president. I actually believe that we're working in tandem in a really good way, but it's the president, his reputation, the things that he has said that are driving this negotiation. So hopefully it'll all work out and we'll save some lives, Witkoff said. Negotiations between Hamas and Israel are ongoing in Qatar, with Hamas this week naming 34 hostages in Gaza including two dual US citizens it would be willing to release in a ceasefire deal, the National Public Radio reported.Trump, in response to a question, warned Hamas to release all the hostages by January 20.

A seaplane crashes off an Australian tourist island, killing 3 and injuring 3 others

MELBOURNE, Australia: A seaplane crashed during takeoff from an Australian tourist island, killing three people including Swiss and Danish tourists and injuring three others. Only one of the seven people aboard the Cessna 208 Caravan was rescued without injury after the crash Tuesday afternoon on Rottnest Island, police said. The plane owned by Swan River Seaplanes was returning to its base in Perth, the Western Australia state capital 30 kilometers (19 miles) east of Rottnest Island, which is also known by its Indigenous name Wadjemup.

The dead were a 65-year-old Swiss woman, a 60-yearold man from Denmark and the 34-year-old male pilot from Perth, Western Australian Premier Roger Cook said.The dead tourists' partners, a 63-year-old Swiss man and a 58-year-old Danish woman, survived. A Western Australian couple, a woman aged 65 and a 63-year-old man, also survived.

It is not clear which passenger was uninjured. Western Australian Police Commissioner Col Blanch said no survivor sustained life-threatening injuries. The three injured people were flown to a Perth hospital.

Cook said the cause of the crash was not yet known. Reports that the plane had struck a rock at the entrance of a bay on the west side of the island could not be confirmed from video viewed so far, Cook said.

Rottnest Island is renowned for its sandy beaches and cat-sized hopping marsupials called quokkas which are rare on the Australian mainland. The island's tourist accommodation is fully booked during the current Southern Hemisphere summer months."Every Western Australian knows that Rottnest is our premier tourism destination," Cook told reporters."For something so tragic to happen in front of so many people, at a place that provides so much joy, especially at this time of the year, is deeply upsetting," Cook added Blanch said police divers had recovered the bodies on Tuesday night from a depth of 8 meters (26 feet). Wreckage of the plane was still being recovered.s

Man who exploded Tesla Cybertruck outside Trump hotel in Las Vegas used generative AI, police say

World The highly decorated soldier who exploded a Tesla Cybertruck outside the Trump hotel in Las Vegas used generative AI including ChatGPT to help plan the attack, Las Vegas police said Tuesday.

Nearly a week after 37-year-old Matthew Livelsberger fatally shot himself, officials said according to writings, he didn't intend to kill anyone else.An investigation of Livelsberger's searches through ChatGPT indicate he was looking for information on explosive targets, the speed at which certain rounds of ammunition would travel and whether fireworks were legal in Arizona.

Kevin McMahill, sheriff of the Las Vegas Metropolitan Police Department, called the use of generative AI a "game-changer" and said the department was sharing information with other law enforcement agencies."This is the first incident that I'm aware of on U.S. soil where ChatGPT is utilized to help an individual build a particular device," he said. "It's a concerning moment." In an emailed statement, OpenAI said it was committed to seeing its tools used "responsibly" and that they're designed to refuse harmful instructions."In this case, ChatGPT responded with information already publicly available on the internet and provided warnings against harmful or illegal activities. We're working with law enforcement to support their investigation," the emailed statement said.

Fast-moving wildfires rage across Los Angeles, destroying homes and prompting widespread evacuations

LOS ANGELES. A fast-moving wildfire broke out Tuesday in the inland foothills northeast of Los Angeles, just hours after another blaze tore through the city's Pacific Palisades neighborhood along the coast, destroying many homes and prompting evacuation orders for tens of thousands.

The Eaton fire in Altadena started near a

nature preserve just before 6:30 p.m. The flames spread so rapidly that staff at a senior care center had to push dozens of residents in wheelchairs and hospital beds down the street to a parking lot, where they waited in their bedclothes for ambulances and other vehicles to take them to safety.

To the west, the Pacific Palisades fire that started Tuesday morning burned out of control into the night. The Los Angeles Fire Department issued a plea for off-duty firefighters to help fight the flames, which were being pushed by winds topping 60 mph (97 kph) in some places and creating chaotic scenes as residents fled. It was too windy for firefighting aircraft to fly, hampering the efforts. The Pacific Palisades fire swept through a Los Angeles hillside dotted with celebrity residences Tuesday, burning homes and prompting evacuation orders. In the frantic rush to get to safety, roadways became clogged, and many people abandoned their vehicles and fled on foot, some toting suitcases.A resident of a senior center is evacuated as the Eaton Fire approaches Tuesday, Jan. 7, 2025 in Altadena, Calif. The traffic jam on Palisades Drive prevented emergency vehicles from getting through. A bulldozer was brought in to push abandoned cars to the side and create a path, according to the LA Fire Department. California Gov. Gavin Newso, who was in Southern California to attend the naming of a national monument by President Joe Biden, made a detour to the canyon to see "firsthand the impact of these swirling winds and embers." He said he found "not a few many structures already destroyed."Officials did not give an exact number of structures damaged or destroyed in the Pacific Palisades wildfire, but they said about 30,000 residents were under evacuation orders, and more than 13,000 structures were at risk. The worst could still be ahead. The blaze began around 10:30 a.m., shortly after the start of



a Santa Ana windstorm that the National Weather Service warned could be "lifethreatening" and the strongest to hit Southern California in more than a decade. The exact cause of the fire was unknown, and no injuries had been reported, officials said. The winds were expected to increase overnight and continue for days, producing isolated gusts that could top 100 mph (160 kph) in mountains and foothills including areas that haven't seen substantial rain in months. "By no stretch of the imagination are we out of the woods," Newsom warned residents, saying the worst of the winds were expected between 10 p.m. Tuesday and 5 a.m. Wednesday. He declared a state of emergency on Tuesday.

As of Tuesday evening, 28,300 households were without power due to the strong winds, according to the mayor's office. About 15,000 utility customers in Southern California had their power shut off to reduce the risk of equipment sparking a blaze. A half a million customers were at risk of losing power preemptively.he Pacific Palisades fire quickly consumed about 4.6 square miles (11.6 square kilometers) of land in the Pacific Palisades neighborhood in western Los Angeles, sending up a dramatic plume of smoke visible across the city. Residents in Venice Beach, some 6 miles (10 kilometers) away, reported seeing the flames.

Grief and nostalgia in India's 'Jimmy Carter village'

NEW DELHI. In a quiet village tucked in the shadow of India's capital, the late US president Jimmy Carter's name is etched for posterity.

Carterpuri, or the "village of Carter" was abruptly renamed from Daulatpur Nasirabad after an hour-long visit by the Nobel laureate in 1978.

The renaming was suggested by India's then-prime minister Morarji Desai who accompanied Carter on the visit to the small hamlet, some 30 kilometres (20 miles) from New Delhi."When the proposal was mooted, all the village elders immediately said yes," recalled 71-year-old resident Attar Singh, who vividly remembers the January afternoon from nearly half a century ago. One of the last surviving members from the generation old enough to remember the occasion, Singh said he was "distressed" by Carter's death last month, and played a key role in staging a small tribute ceremony.

A picture of the former president was quickly downloaded from the internet, framed, garlanded and placed at a local war memorial where a group of village elders made offerings of salty porridge



and a newly stitched traditional turban. Singh said the porridge and the turban, along with a condolence message, were then shipped to the US Embassy.

The entire village grieved because we considered him as one of our own," said Rajiv Kumar, a younger resident who was a toddler when Carter visited.

The body of Carter, who died at the age of 100 last month, is currently lying in state in Washington and will be buried Thursday in his home state of Georgia. 'Such a big man' -

Carter's visit to the village, then home to less than 500 people, was not by chance.He was driven by a deeply personal mission: his mother Lillian had worked in the village as a Peace Corps volunteer in the late 1960s.

The dilapidated mansion where Lillian stayed during her time there no longer exists. It was torn down around 15 years ago to make way for a concrete two-storey structure with a line of tiny shops on its ground floor.Little else from that era survives in Carterpuri, which now has a population of roughly 5,000. The village council office where Carter and his wife Eleanor Rosalynn Carter were feted while bedecked in traditional headgear, is now a community health centre.

Nonetheless, Carter's visit remains firmly imprinted in the memory of Carterpuri's old-timers."I was a little boy then but I remember everything," said 62-year-old Motiram, who goes by one name. His recollections include Carter smoking tobacco from a hookah and waving at the eager children who looked from the rooftops as he took a tour of the village.But Motiram's nostalgia is tinted with disillusionment. Despite such a lofty name, our village has seen no progress in all these years,

US Congressman challenges Biden administration's decision to investigate Adani

WASHINGTON. Challenging the Biden administration's decision to investigate the activities of Indian billionaire Gautam Adani, an influential Republican lawmaker has said that such selective actions risk damaging critical alliances with key partners.In a strongly worded letter to US Attorney General Merrick B. Garland, Congressman Lance Gooden, a member of the House Judiciary Committee, also asked, "What will the US do if India refuses to comply with an extradition request?"Gooden also demanded answers regarding the Justice Department's selective prosecution of foreign entities and the potential harm such actions pose to the US's global alliances and economic growth. He further inquired if there was any connection to George Soros.

The Department of Justice's selective actions risk damaging critical alliances with key partners like India, one of America's strongest allies in the Asia-Pacific region," Gooden said in his letter dated January 7."Instead of pursuing cases with tenuous jurisdiction and limited relevance to US interests, the DOJ should focus on punishing bad actors at home, rather than chasing rumors abroad," he added.

Israeli TV reporter regains his ability to speak with the help of Al

JERUSALEM. When renowned Israeli TV journalist Moshe Nussbaum lost his ability to speak clearly due to ALS, he thought his career might be over. However, with the help of artificial-intelligence software that recreates his iconic gravelly voice, Nussbaum known to generations of viewers simply as "Nussi" is making a comeback. Nussbaum, 71, was diagnosed two years ago with amyotrophic lateral sclerosis (ALS), also known as Lou that attacks nerve cells controlling muscles throughout the body. At the time, he vowed to Channel 12 News viewers that he would continue working as long as he was physically able. But as time passed, it became increasingly difficult.

It was a devastating blow for the leading reporter, who had spent more than 40 years covering many of Israel's most important stories. Nussbaum had reported from the scenes of suicide bombings, the front lines of wars in Gaza and Lebanon, and covered high-profile scandals and court cases in Israel's parliament.After Hamas' October

7, 2023, attack, which triggered the war in Gaza, Nussbaum was unable to report from the field. It was the first war of his career that he had ever missed. Despite his difficulties with speaking and moving, he launched a segment interviewing injured soldiers in Israeli hospitals. His questions were slow and halting, but he continued for the first half of the war. However, as it became harder to be understood, his interviews became less frequent.

Nussbaum is excited by the possibilities of the technology but also concerned about its potential misuse to spread fake news. In its current form, the technology doesn't work for live broadcasts, so Nussbaum will focus on commentary and analysis on crime and national security, areas of expertise from his decades of reporting.

Ahead of the broadcasts, Channel 12 released a preview featuring snippets of Nussbaum

speaking naturally garbled and difficult to understand followed by the new "Nussi AI," which sounds strikingly like the original Nussbaum, speaking quickly and emphatically. "Honestly, this is my first time sitting here in the studio after more than a year," AI Nussbaum says in the preview. "It feels a bit strange, and mostly, it tugs my heart."AI-powered voice cloning has rapidly advanced in recent years. Experts warn that the technology could enable phone scams, disrupt elections, and violate the dignity of individuals who did not consent to having their voices recreated. However, it also holds great promise for people who have lost their ability to speak clearly. Similar AI programmes have enabled a U.S. congresswoman with Parkinson's disease to deliver a speech and helped a woman who lost her voice due to a tumour. Channel 12 declined to disclose which AI programme it is using. Nussbaum had feared that ALS would rob him of the career he loved. In an interview with Channel 12, he recalled telling his managers.

Torres investment scam: 3 held, 7.4cr in firm's bank a/cs frozen

MUMBAI. Shivaji Park police on Tuesday arrested two directors and a senior executive of Platinum Hern Pvt Ltd, the company that runs Torres jewellery chain, for cheating more than 18,000 people from Mumbai, Navi Mumbai, Thane and Mira-Bhayander of crores of rupees through its investment schemes. Meanwhile, Navghar police in Mira-Bhayander have frozen Rs 9.17 crore maintained by the company in its bank accounts. Thane police and APMC police in Navi Mumbai on Tuesday registered separate cases, even as Kandivli police recorded the statements of 10 investors and forwarded them to Shivaji Park police station, where an FIR has been registered against five accused under the Maharashtra Protection of Interest of Depositors Act, 1999. The case has been taken over by the Economic Offenc-es Wing of city police. BJP's Kirit Somaiya claimed the sc-am could cross Rs 1,000 crore. The arrested directors, Tania Casatova and Sarvesh Surve, and senior executive Valentine Kumar have been remanded in police custody till Jan 13 by the Dadar metropolitan magistrate's court. Torres has five stores at Grant Road, Dadar, Sanpada, Mira Road, and Kalyan, and had plans to open a sixth one in Kandivli. Flower power: City sets Guinness record for world's largest bouquet

Ahmedabad. The Ahmedabad Municipal Corporation (AMC) has set a Guinness World Record for the world's largest flower bouquet (in size) at this year's flower show. AMC broke the record for the largest bouquet of natural flowers held by Al Ain Municipality, United Arab Emirates.

On Jan 7, a Guinness team recognised AMC's bouquet 10.24m high and having a diameter 10.84m, as the largest in the world. The Al Ain Municipality had created a flower arrangement that stood seven metres tall. The award was accepted by deputy mayor Jatin Patel at an event attended by AMC standing committee chairman Devang Dani and municipal commissioner M Thennarasan.

Last year's Flower Show too had set a Guinness World Record, for the longest flower wall, measuring 221m. This structure surpassed the previous record of 166.15m. This year's Flower Show at the riverfront features over 1 million flowers from more than 50 species, including exotic varieties such as roses, lilies, and orchids. The show is segmented into six thematic zones: Growth and Development, Sustenance and Inclusivity, Sustainable Future, Culture and Heritage and Vision for the Future. Nine Tamil Nadu fishers rescued after five days stranded in Sri Lankan waters

NAGAPATTINAM. A group of nine Tamil Nadu fishers, stranded in Sri Lankan waters for five days after their fishing boat suffered an engine failure, was rescued in a crossborder operation involving authorities of both nations. Their boat was towed back to Nagapattinam by another fishing vessel on Tuesday. The group, led by S Selvamani from Nagore, had ventured into the sea on December 29 aboard Venkatammal, a mechanised deep-sea fishing boat. Accompanying him were two fishermen from Vanavanmahadevi and six others from Nayakkarkuppam in Mayiladuthurai district."While we were fishing around 90 nautical miles east of Nagapattinam on December 30, turbulence caused water to enter the engine's exhaust, stalling it. The waters were too deep for anchoring, so we deployed drogue parachute to slow our drift," Selvamani told .Despite contacting fisherfolk representatives and the fisheries department in Chennai through VHF, the boat drifted beyond the International Maritime Boundary Line (IMBL) into Sri Lankan waters on January 2, losing communication. Sri Lankan fishers spotted the boat and informed their authorities. Indian authorities also reached out to their Sri Lankan counterparts seeking permission for rescue mission.On January 3, a team comprising four fishers from Nagore, led by V Saminathan, set out for the search and rescue mission on a deep-sea fishing boat. Relief finally came on January 5 at 3 am when the fishing boat was located 60 nautical miles near Sri Lanka's Trincomalee. Lankan navy and fishers provided food and assistance to the stranded fishers for two days until Nagore fishers arrived, Selvamani said. Both boats reached Nagapattinam at 1 am on Tuesday." All nine fishers are safe. We are grateful to the Lankan Navy and our fishers," said T Elamvazhudi, joint director of Fisheries.

Security staff, rickshaw drivers clash over touting

Ahmedabad. A scuffle broke out late on Monday night between airport security officials and autorickshaw drivers outside the domestic arrivals terminal of the Sardar Vallabhbhai Patel International (SVPI) airport in the city. What began as an exchange of arguments around 10.30pm took an ugly turn, leading to chaotic scenes that lasted nearly an hour.

The confrontation began when the security officials attempted to stop autorickshaw drivers and cab operators from soliciting passengers and touting for business. Airport sources told TOI that some of the drivers retaliated by hurling abuses and shoving the security personnel.

"In the late hours of Jan 6, 2025, touts and transport providers created a ruckus at the arrivals area of SVPI airport, leading to physical altercations and injuries. The airport team is working with the authorities to investigate and address the incident. Airport operations remain unaffected. The safety of passengers and stakeholders continues to be our top priority," said an SVPI airport spokesperson. According to sources, touting is a persistent issue at the airport and often leads to friction between security personnel and cabbies and autorickshaw drivers. The security agencies hired by the airport operator promptly filed a formal complaint against the drivers at the SVPI airport police station.

With the situation escalating, the Central Industrial Security Force (CISF) was called in to restore order. A cab driver, Navin Harvani, also filed a counter-complaint alleging that a security guard at the airport hit him on his head with a pipe, causing him to bleed from his mouth.

The complaint further stated that at least five autorickshaw drivers were also attacked by security personnel during the altercation. The city airport operator has been struggling to handle the menace of touting and is seeking stringent regulations to prevent inconvenience to passengers..In the past, four FIRs were lodged by security agencies in addition to 50 complaints over the issue of touting," a source said. The govts in Delhi and Maharashtra introduced anti-touting laws at least 10-15 years ago in their respective states to curb the menace of touting

Karnataka High Court strikes down Centre's renewable energy promotion rules

BENGALURU. Observing that the power to enact a law to achieve net-zero emission cannot empower the central government to transgress the existing Electricity Act, 2003, the Karnataka High Court struck down the Centre's Electricity (Promoting Renewable Energy Through Green Energy Open Access) Rules, 2022, and also the Karnataka Electricity Regulatory Commission (KERC) (Terms and Conditions for Green Energy Open Access) Regulations, 2022, framed by KERC, for lack of competence to frame the same. The court directed the KERC to frame appropriate regulations if it so desires, in the matter of granting open access to green energy generators and consumers. During this exercise, the court said the KERC will only be guided by the National Electricity Policy and the Tariff Policy framed by the central government, and



should independently consider the interests of all the stakeholders before framing the regulations. Justice N S Sanjay Gowda passed the order while partly allowing a batch of petitions filed by Brindavan Hydropower Private Limited and several others questioning the validity of the rules. The court said the role essentially to frame a policy and it can only issue directions to the regulator, and the regulator can only be guided by such directions and not be bound by it. Taking cognisance of the fact that this order would leave a vacuum till the regulations are framed by the KERC independently, the court said an interim arrangement would therefore have to be made to ensure that the wheeling and banking facilities availed hitherto by the petitioners are facilitated. order recently, an oral request for a grant of stay of this order was made but the court refused it, saying that it has been held that the Centre lacked the competence to frame the rules in question and therefore the question of permitting it to continue would be illegal.

JDS MLC Suraj Revanna

Shreyas Patel clueless about Muthaliyarpatti govt school students forced to projects of JDS leaders: study under trees, left with no basic amenities

TENKASI. Owing to inadequate infrastructure at Muthaliyarpatti Government Higher Secondary School near Kadayam, many students have to brave the elements daily. They are forced to attend classes under trees or inside a makeshift shed located on a nearby parcel of government land. As a result, several children have developed health issues like allergies and nasty itches. When visited the school, students highlighted the lack of basic facilities such as toilets, a playground, proper laboratories, and drinking water filters. "Due to the insufficient number of classrooms, teachers take classes under trees, inside the shed, or even on a pathway in front of the headmistress's room. Many of the classrooms that do exist have no fans. The children are also forced to play on a narrow pathway next to the school due to the dearth of a playground," a student said.

A few other children said that the school has only one water purifier to cater to as many as 626 students. They form long queues in front of the purifier, and often, the water runs out before everyone is served. "During power cuts, everyone goes thirsty. Sometimes, we even drink water from a leaking pipeline laid as part of the Combined Water Supply Scheme



near a railway track," another student said. The kids also complained about insufficient toilets, forcing many to urinate in the open. "The school has a small toilet, which is poorly maintained. Those using it often suffer from urinary tract infections," they added. Speaking to, M Faridha Banu, chairperson of the School Management Committee, said the shortage of classrooms has also restrained the school from introducing new groups in Classes 11 and 12."Since the school has no kitchen, food for the students is cooked at a nearby primary school. The children have to walk all the way there to have food. The only sweeper in the school is paid just around

Rs 3,000 per month. Even that payment is made once in six months. How can we expect a clean toilet and premises in this situation?" she asked.Social activist Mohammed Abdul Khader said he repeatedly petitioned officials about the issue. Following his efforts, the Tenkasi Revenue Divisional Officer and Tahsildar visited the school in November 2024 and promised to arrange land for additional classrooms. "However, no action ensued. The state government must expedite the process to prevent students from transferring to private schools," he said. Khader also submitted a petition to District Collector

AK Kamal Kishore on Monday.


No HMPV cases, Andhra ready to fight virus

VIJAYAWADA. In response to rising concerns about the spread of Human Metapneumovirus (HMPV) after the detection of a few cases in Karnataka, Tamil Nadu and Gujarat, the State government has geared up to fight the virus. Though no HMPV cases have been reported in the State, Chief Minister N Chandrababu Naidu convened a review meeting with officials of the Health, Medical and Family Welfare Department on Monday. He directed them to raise public awareness, and ensure preparedness for any eventuality.

Following the Chief Minister's directive, Health Minister Y Satya Kumar Yadav and Special Chief Secretary MT Krishna Babu have stepped efforts to combat HMPV. Health authorities have been instructed to procure symptomatic drugs, oxygen

concentrators and oxygen cylinders as part of readiness measures.Director of Public Health K Padmavathi held a virtual meeting on Tuesday with PHC officials, DM&HOs, and programme officers to educate the public on precautionary steps need to be taken to protect themselves from HMPV. Krishna Babu directed the Director of Medical Education to set up 20-bed special wards in government hospitals to treat potential cases, and the hospital authorities have also started arranging special wards.

A five-member specialist committee has been formed to prepare Standard Operating Procedures (SOPs) and oversee virus management. Ten Viral Research and Diagnostic Laboratories (VRDLs) across the State have been placed on high alert. However, shortage of uniplex, duplex and



multiplex testing kits is said to be a concern. Dr Padmavathi confirmed to TNIE that no HMPV cases have been detected in Andhra Pradesh so far, and people need not to worry. Testing kits need to be imported from Germany, and the DME has filed an indent to expedite their arrival, which are expected within a week. Each kit can conduct 96 tests and 10 kits will be distributed to each lab and two kept as a buffer stock. The DME and Andhra Pradesh Vaidya Vidhana Parishad (APVVP) have been directed to review the

condition of oxygen plants and conduct mock drills.HMPV symptoms resemble the flu, including fever, cough, cold, stuffy or runny nose, sore throat, and shortness of breath. In severe cases, the virus can lead to respiratory complications such as pneumonia and bronchitis, posing risks to young children, the elderly, and individuals with chronic illnesses or weakened immune systems.Dr Padmavathi advised that symptomatic relief can often be achieved by taking prescribed drugs for two to three days. However, respiratory problems warrant immediate medical attentionShe explained the importance of preventive measures, including frequent handwashing with soap and water for at least 20 seconds, and covering the mouth and nose with a tissue when coughing or sneezing.

Reforms must give us a cutting edge

INDIA's composite defence and military ecosystem is critical for ensuring that national security and sovereignty are not endangered. This domain has been accorded priority by Prime Minister Narendra Modi since he assumed office in 2014.

The need for a holistic review and necessary reforms was long acknowledged — an issue that the late Dr Manmohan Singh often flagged in his interaction with the military top brass — but the institution remained reluctant to go down this path.

During his second term, PM Modi announced the creation of the post of Chief of Defence Staff. However, the task of initiating defence reforms is mammoth, and it remains a work in progress. The entire organisation that is the responsibility of the Defence Minister is like an octopus, whose many some going back to the colonial period (ordnance factories, for example) — are insular, prickly and tenaciously resistant to change. This, incidentally, is not an Indian trait. Most militaries the world over are steeped in tradition and slow to adapt to change — this is part of the institutional DNA.

Thus, it is encouraging to note that in PM Modi's third term, 2025 has been designated as the 'Year of Reforms'. Defence Minister Rajnath Singh highlighted this move at the 67th Foundation Day of the Defence Research and Development Organisation (DRDO) last week. He dwelt on the crucial role the organisation could play in realising the objectives of these much-needed reforms.

In a nutshell, the core objectives of India's defence reforms are: One, to move the needle of national combat readiness, as warranted by national security and shaped by contemporary technostrategic and geopolitical compulsions; and two, to reduce dependency on external sources that provide critical platforms/inventory items/technology. The DRDO and the larger national scientific and manufacturing ecosystem have a major role in this endeavour. Rajnath Singh exhorted scientists to improve their core competencies and set an ambitious benchmark. He added, "The DRDO should aim to become one of the strongest research and development organisations in the world." He also commended the design team that enabled the success of the Long-Range Hypersonic Anti-Ship Missile, which is the most recent feather in the sparsely burnished DRDO cap.However, the structural constraints and legacy issues related to India's defence R&D and manufacturing need to be addressed if the stated objective is to be realised. India does not figure among the top R&D nations of the world, and the defence sub-sector has a relatively modest record in terms of investments and scientific output over the decades, barring a few islands of innovation. In September last year, DRDO Chairman Samir V Kamat pointed out that India spent only 0.65 per cent of the national GDP on R&D. The contrast with other nations is striking. Their respective R&D spending as a percentage of the GDP is: the US, 2.83; China, 2.14; France, 2.19; and South Korea, 4.8. Kamat added that the government was aware of this insufficiency and that over the next few years, during Modi 3.0, this modest figure will hopefully rise to 1 per cent of the GDP and be doubled to 2 per cent by 2035. But on current evidence, this is a low-probability exigency and may need a major political intervention, especially since the whole defence budget just touches 2 per cent of the GDP.

The legacy challenge for the DRDO and the extended defence-military ecosystem is that India continues to have high dependency on foreign imports to maintain its minimum combat readiness. In the decade from FY 2012-13 to 2021-22, as per a report of the Parliamentary Standing Committee on Defence, India's capital expenditure for military inventory acquisitions and modernisation in foreign exchange was above 35 per cent; it hit 49 per cent in one year.

This proportion blunts India's claim to credible strategic autonomy. PM Modi's prioritisation of 'atmanirbharta' (self-reliance) over the past decade is laudable, but the gestation periods are very long and a broad-brush review of the DRDO and defence public sector undertakings (DPSU) indicates a pattern that needs a review.

Balancing privacy rights and investigative powers

Denying ED access to computers and mobile phones of offenders needs to be examined as electronic and digital devices have almost become an extension of human memory.

THE Supreme Court recently upheld a high court order quashing the arrest of former Haryana MLA Surender Panwar in a money-laundering case, while terming his 15-hour-long interrogation by the Enforcement Directorate (ED) as 'high-handedness' and 'inhuman conduct'. In another case, on December 13, 2024, an interim order of the SC drew the red line for the ED over access to and copying the content stored in computers and mobile phones seized from Santiago Martin, the 'lottery king', and his associates. The court did not prescribe any date Accordingly, the Bharatiya Sakshya Adhiniyam, 2023 for lifting the ban in the Santiago case. It ordered that the matter be heard along with other connected cases in which the ED's demand to the applicants to produce electronic devices had been challenged and guidelines were sought for such seizures.

If the interim order in the case becomes a precedent, it would have serious consequences on the powers of the law enforcement agencies (LEAs). However, at the same time, it would be a welcome reminder to the citizens that their fundamental right to life, including right to privacy, and the constitutional guarantee against self- incrimination are sacrosanct and that 'fishing expeditions' by the LEAs under the cover of investigations are not to be allowed. Justice Felix Frankfurter, in Nardone vs United States (1939), gave the "exclusionary rule of evidence" and stamped the "doctrine of fruits of the poisonous tree". It postulates that illegally procured evidence becomes inadmissible in court proceedings;

if the source of evidence or the evidence itself is tainted, anything gained from it is also tainted and cannot be used against the accused.

Evidence collected by questionable means, like by using unauthorised phone-tapping or recording without the knowledge of the subject, accessing private information and personal secrets contained in electronic gadgets, conducting illegal and unwarranted searches and recording events using secret cameras, etc, certainly fall in the category of tainted evidence. Indiscriminate confiscation of personal laptops and mobile phones by the LEAs and accessing the contents stored therein also run the risk of intruding into privacy, compromising business secrets and fishing into private affairs of individuals; at times, even bringing their personal

and business activities to a halt. On the other hand, tracing the digital footprint and filtering the electronic record of suspects have become a necessity in almost all heinous crimes, including crimes against women, financial scams, moneylaundering, drug trafficking and offences against the state and national security, etc. Perhaps, this is the reason the legislature, hitherto, has refrained from subscribing to the doctrine of "fruits of the poisonous tree" in Indian laws.

(BSA), which prescribes rules of evidence, is silent on the admissibility of illegally procured evidence, although it declares confession caused by inducement, coercion, threat or promise irrelevant in



criminal proceedings. Even the SC, in RM Malkani vs State of Maharashtra (1972), has validated the admissibility of illegally tape-recorded evidence. In the case of Umesh Kumar vs State of AP (2013), the court has observed: "Even if a document is procured through unlawful means, its admissibility would not be barred if it is relevant and genuine."


In fact, Indian laws put the relevancy of evidence on a higher pedestal than the source of its procurement. Illegally collected evidence is admissible even after the right to privacy has been recognised as a Fundamental Right by the Supreme Court in Justice KS Puttaswamy (retd) vs Union of India and Others (2017). In fact, in our constitutional scheme, no right, including the right to life, is absolute and may be curtailed in accordance with the procedure established by law. Under Section 349 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS), the court can force a suspect to give his handwriting and voice sample; Section 53 of the BNSS allows even the extraction of body fluids from an accused person by force to meet the demand of investigations. Electronic and digital devices have almost become an extension of human memory for a majority of the people nowadays. In Selvi and Others vs State of Karnataka (2010), the Constitutional Bench of the SC allowed the recovery of information from the mind of an accused after obtaining his informed consent before the court by resorting to 'narco-analysis', 'brain-mapping' and 'lie detection test', as an aid to investigation.

> Denying ED access to the computers and mobile phones of offenders needs to be examined in this backdrop, too. The interim order in the case should also be viewed in light of the fact that electronic and digital records are included in the definition of 'document', as contained in the BSA, and Sections 94 to 97 of the BNSS empowers the LEAs to summon, undertake searches and seize documents during investigations. The order has the implication of taking away this power from the LEAs and may halt investigations in those cases where digital and electronic evidence are crucial.

The investigation needs of the LEAs and yardsticks to judge the admissibility of evidence in courts are two separate domains. Whereas a strict law of evidence needs to be applied during the trial, the LEAs deserve freedom, under strict vigilance of the court, to find out and present the truth before the courts. The protection of citizenry from overzealous law enforcers, though, is equally important. Unarguably, the issues at hand in the case are contentious. Finding a balance between the contrary demands of the LEAs for just investigations and safeguarding the constitutional rights of the people, both at the same time, is a tightrope walk. It is, however, a given that any blanket prohibition on the powers of the LEAs would not augur well for public safety and national security. Every case needs to be decided on its own merit.

Pakistan punishes Taliban for TTP attacks

Pakistan will continue to face the brunt of TTP attacks, as the latter's crusade is religious and such militant groups seldom abandon their ideological beliefs.

ON December 24 last year, Pakistan launched targeted attacks against Tehrik-e-Taliban Pakistan (TTP) hideouts in the Paktia province of Afghanistan. killing dozens of people, mostly women and children. This was in response to the TTP's raids against Pakistani security forces on December 21 in south Waziristan, which resulted in the killing of 16 Pakistan soldiers. As US-made weapons seized during the Taliban takeover of Afghanistan in August 2021 became available to the TTP, it increased its attacks inside Pakistan in 2024, killing 1,612 security personnel and others in 444 terrorist attacks. Last year was the deadliest in terms of terror attacks, as per Pakistani sources. Pakistan's reading of the Taliban — whom it reared and supported for more than two decades against the US-led international security forces in the expectations of having a friendly regime in Kabul, which would provide it with "strategic depth" — has turned out to be completely wrong. The Taliban has accused Islamabad of pocketing much of the international aid it got from the US and other countries in the name of Afghanistan. The two countries have also differed on The TTP attacks have increased the installation of a fence by Pakistan in the bordering areas as Afghanistan does not accept the Durand Line marking the border, claiming that it was an artificial line dividing the Pashtuns unfairly on both sides. In 2021, the then Imran Khan government of Pakistan engaged in peace talks with the TTP, which were facilitated by the Taliban. The year-long negotiations, which included a brief ceasefire, failed without the ceasing of attacks by the TTP. According to some Pakistanis, these talks provided useful time to the TTP to regroup and boost its strength. Pakistan has given several warnings to the Taliban at the

highest levels, but the latter has shown no serious intent to control the TTP. The Taliban and TTP share ethnic ties and have fought together against the West for years. The Taliban has ideological sympathy with

the TTP's objective of establishing a Sharia state in the tribal areas of Pakistan and uses TTP's militant activities to pressure Pakistan whenever it wants. Also, if the Taliban were to take harsh action against the TTP, the latter's fighters could defect to the Islamic State of Khorasan (ISK), an offshoot of ISIS, with whom they share jihadist beliefs and deep-rooted bonds and which is active in several parts of eastern and north-western Afghanistan. It would, thus, weaken the Taliban and strengthen its enemy. At present, the Taliban has given a decisive blow to the ISK, killing several of its senior commanders and keeping the group's terror activities under check.

groups, such as the Balochs and Pashtuns, to fight against the Pakistani state. Pakistan's hopes of attracting foreign investment from Saudi Arabia and the UAE have not borne fruit. Even Pakistan's allies like China and the US would not favour that option for their own reasons. The US would not like the Taliban to be distracted from its fight against the ISK. China

nurtures the ambition to extend its Belt and Road Initiative to Afghanistan and carry out projects in mining, oil exploration and infrastructure sectors. Also, then the Taliban will not be able to control the

> China-centric terror group, the East Turkestan Islamic Movement, in Afghanistan.

The deterioration in Pakistan's relations with the Taliban has allowed India to reassess its policy towards the Taliban, reopen its embassy and provide emergency assistance to the Afghan people and consider resuming work on its economic projects in Afghanistan. The Afghan Embassy in New Delhi is now being run by the representatives of the Taliban government.Pakistan has taken a few steps to increase the cost for the Taliban in allowing the TTP. These include the repatriation of about 8,00,000 Afghan refugees and disruption of Afghanistan's land trade via Pakistan. These measures were not liked by the US and others as they felt that the Taliban was already facing a grim humanitarian

situation, with a shortage of food, energy and other essential items, and was hardly in a position to look after so many more people. The Taliban has also not relented in any of its policies about broad-basing its government, allowing education to women beyond the middle school or other human rights despite facing severe sanctions and near-total isolation on the world stage. It has enforced its religious codes of conduct in an authoritarian manner, oblivious of the global public opinion.

The iconic structure of the Howrah Bridge completes 75 years of its existence this month. The historical landmark that has been synonymous with the City of Joy has been a witness to history, both in pre-Independence India and thereafter. The bridge has been not only been a part of history, literature and art, but also a significant part of popular culture — be it in commercial cinema or magazine art and caricature. From Satyajit Ray to Richard Attenborough and Mani Ratnam to Anurag Basu, the popular iconography of Kolkata has been celebrated by film-makers and photographers alike.

Connecting the twin city of Kolkata (earlier known as Calcutta) and Howrah, on either sides of River Hooghly in Bengal, the archetypal structure is one of the busiest bridges on the country. Renamed Rabindra Setu in 1965 after Nobel Laureate Rabindranath Tagore, the suspension-type balanced cantilever bridge has a central span of 1500 ft. between centres of main towers. As the bridge completes being functional for over seven decades, here are some interesting facts about the unique structure that you might be interested

A bridge without nuts and bolts

Hard to believe? Yes, the gigantic bridge spread across the width of River Hooghly does not have a single nut and screw joining the array of metallic structures. Instead, the unique bridge was built by riveting the whole structure, which means a metal piece (rivet) is used to connect two or more plates inserted through the hole in plates and pressed on the other side.


A suspended bridge If you didn't notice in all the photos of Howrah Bridge, then take a look now and observe how the metal structure hangs above the river with no pillars in between supporting it. It's a suspended-type balanced cantilever bridge, the third longest when it was constructed and now, it's the sixth longest bridge of its type in the world.

It's the 'new' Howrah Bridge

Even though the vintage structure has been around for more than seven decades and even stood witness to the Second World War, it is ironically called the 'New' Howrah Bridge. The reason behind it is that it replaced an old pontoon bridge, which was set up in 1874. As in the 17th century, Calcutta was emerging as a bustling city by the merger of the three villages - Kolkata,

As Rabindra Setu - popularly known as Howrah Bridge - celebrates its 75th anniversary, here are some interesting and lesser-known facts about the iconic structure. Opened to the public in 1943, in a pre-Independence era historic bridge is a engineering marvel and one of the busiest bridges in the world.



Sutanati and Gobindapur, there was an urgent demand to link the city with the commercial hub Howrah. And after the Howrah station was built in 1906, the to-fro movement on the bridge began to escalate and engineers at Calcutta Port Trust started brainstorming ideas to build a better and stronger bridge.

Stalled by First World War

The bridge has a sad association with World War I (1914-1919). Even though the proposal to replace the old pontoon bridge had begun in the early 1900s, it was delayed owing to the catastrophic war. The bridge was partially renewed in the years 1917 and 1927. However, it was completed until the Second World War.

Even as a marvel for architects, engineers and the Colonials who built the emblematic landmark, it did not even have a formal opening, forget a grand inauguration. It was completed in 1942 and opened to the public in February 1943 but was not highlighted due to a fear of attacks by Japanese planes fighting the Allied Powers. Japan had already attacked Pearl Harbour in 1941 and that instilled fear among the Britishers that this could prove to be a target as well.

A made-in-India bridge

Unlike now, during the British Era, not only the raw materials but even the finished product were made in England and assembled here. Even the former Sir Bradford Leslie's pontoon bridge — different parts were constructed in England and shipped to Calcutta. However, it incurred a huge cost. Owing to the ongoing WWII (1939-1945) all the steel (26,000 tonnes) that was to come from the UK were diverted for the war effort in Europe. Out of total steel required for the bridge, only 3,000 tonnes were supplied from England. The remaining 23,000 tonnes were supplied by India's Tata Steel and even the erection work was reassigned to a local engineering firm of Howrah — the Braithwaite, Burn and Jessop Construction Co.

Trams used the bridge As lakhs of commuters daily cross the bridge now either by foot on on cars and buses, but during its initial days of existence, trams used to ply on the bridge transporting people to and fro from the twin cities. In fact, the first vehicle to use the bridge was a solitary tram. The tram services on the bridge were discontinued in 1993 owing to rise in vehicular traffic.

Yet to get 40 Tejas ordered in 2010: IAF chief as China tests sixth-gen jets

Indian Air Force (IAF) chief AP Singh has raised concerns over China's astonishing pace of air force modernisation while expressing frustration over the sluggish pace of the delivery of Tejas jets.

NEW DELHI.Expressing concern over the snail-paced delivery of Tejas fighter jets, Indian Air Force (IAF) chief AP Singh lamented that it was yet to receive the first batch of 40 aircraft ordered in 2009-2010. Speaking at the 21st Subroto Mukerjee Seminar, the IAF chief asserted that the scale of production had to increase at a time when India's adversaries like China were "investing heavily in its air force". The Air Chief Marshal's scathing remarks come days after China tested its mysterious sixthgeneration stealth combat aircraft- a feat not achieved by any other nation. Singh said that the first Tejas jet flew in 2001, while induction started 15 years later in 2016.

RAISES CONCERN OVER DELAYS IN TEJAS DELIVERIES

"We should go back to 1984, when we conceived that aircraft. The first aircraft flew in 2001, 17 years later. The induction started another 15 years later, in 2016. Today, we are in 2024. I do not have the first 40 aircraft also, so this is the production capability," the IAF chief said, underlining that "technology delayed is



technology denied".

The Tejas is a multirole light fighter aircraft being developed by Hindustan Aeronautics Limited (HAL). It is being inducted into the IAF to replace the ageing Mig 21 fighter jet, dubbed the "flying coffin" because of its high crash rate. Underscoring the need for production agencies to invest in advanced manufacturing processes, AP Singh called for the need to rope in private players."I am very convinced that we need to get some private players in. We need to have competition. We need to have multiple sources available so that

Otherwise, things will not change," the Air Chief Marshal emphasised.

CHINA TESTS 6TH GEN FIGHTER AIRCRAFT

His comments come at a time when the Air Force is facing a severe crunch in its fighter strength. It currently has 30 fighter squadrons against a sanctioned strength of 42. A fighter squadron consists of 18 aircraft. China's recent display of two sixth-generation combat aircraft, which took the world and defence experts by surprise, also found a mention in Singh's address.

In contrast, India's fifth-generation fighter jet is still at the design and development stage. A proposal to develop the jet was cleared by the Cabinet only last year, in March.Raising concerns over India's neighbour's astonishing pace of military modernisation, the IAF chief said, "As far as China is concerned, it is not just the numbers, even the technology is growing at a very rapid pace. We just saw the recent flight of the new generation fighter that they have pulled out."

Tibet rocked by 20 earthquakes in 24 hours: What happened in the Himalayan region

The Xizang region of Tibet, which experienced a deadly 7.1-magnitude earthquake on Tuesday morning, recorded at least 20 significant aftershocks within 24 hours.

NEW DELHI. A series of powerful earthquakes rocked Tibet on Tuesday, leaving over 120 dead and more than 400 people trapped under debris as rescue operations continued for the second day on Wednesday. The seismic activity began with a 7.1-magnitude earthquake in the Xizang region, near the Nepal-Tibet border, followed by over 20 tremors within 24 hours. The most recent quake, recorded at 6.58 am on Wednesday, registered a magnitude of 4.0 on the Richter scale. Among the series of earthquakes, 10 exceeded a magnitude of 6, highlighting the region's seismic vulnerability. Tibet, a known earthquake-prone zone, experienced over 100 earthquakes with magnitudes of at least 3.0 last year. However, quakes measuring 7.0 and above are rare, with only nine recorded since the early 20th century.

The epicentre of the disaster was located in Tingri County, near the collision point of the Indian and Eurasian tectonic plates. This tectonic activity



Delhi lawyer allegedly under stress from divorce dies by suicide

NEW DELHI. A 45-year-old Delhi-based lawyer, who was allegedly under stress due to an ongoing divorce case with his wife, shot himself dead with a licenced pistol, police said. The victim has been identified as Sameer Mehendiratta, a resident of Mukherjee Nagar.

According to the police, Mehendiratta, who died in a hospital on Tuesday evening, had been living separately from his wife amid the ongoing case. His family has alleged that Mehendiratta had been suffering from

depression as a result of the divorce



Authorities have initiated an investigation into the incident. This latest case comes days after Puneet Khurana, a bakery

owner also based in Delhi, died by suicide amid divorce proceedings with his wife. The couple were also engaged in a dispute over the bakery, called For God's Cakes, which they co-owned. According to Khurana's family, he "upset" with his wife.Last month, Bengaluru-based techie Atul Subhash died by suicide. The software engineer left behind a 24-page suicide note in which he accused his wife and her relatives of harassment and also detailed his years-long emotional distress from marital

Thick fog engulfs Delhi, over 200 flights delayed, temperature to dip further

New Delhi. A thick layer of fog blanketed Delhi and neighbouring areas as North India continued to reel under a cold wave. Visibility was significantly reduced at airports across the region, disrupting flight services. At New Delhi's Indira Gandhi International Airport (IGI), 200 flights were delayed, and four services were cancelled. In the latest advisory, the airport authorities stated that while landings and takeoffs continue, flights that are not equipped for low-visibility landings (CAT III A compliant) may be affected due to the prevailing weather conditions. Along with IGI Airport, the airports in Amritsar, Jammu, and Agra also recorded zero visibility, affecting services.

Meanwhile, the weather department's 7-day forecast



indicates that from Wednesday, the minimum temperature will start dipping, and by Friday, it is expected to drop to 5 degrees Celsius.

Anticipating dense to very dense fog conditions, the India Meteorological Department (IMD) has issued an orange warning for Delhi on Wednesday and a yellow alert for Thursday and Friday. In the past 24 hours, the maximum temperature in Delhi was recorded at 16.2 degrees Celsius, which is 2.8 degrees below normal, and the minimum temperature was 7.4 degrees, which was 5 degrees above normal. It marked a 3.1-notch fall from Tuesday's temperature.

On Tuesday, over 300 flights were delayed, and around 25 train services were disrupted due to blinding fog. States including Punjab, Haryana, Uttar Pradesh, Bihar, and Rajasthan, among others in the North Indian region, continued to be gripped by an extreme cold wave. In Rajasthan's Nagaur, the minimum temperature was recorded at 2.5 degrees Celsius.

Domestic Airlines May Soon Have To Share Weather Data With Weather Office

The earth sciences ministry secretary said weather forecasts depended largely on the number of observations collected.

New Delhi. The government is planning to make it mandatory for domestic airlines to share weather data captured by aircraft during takeoff and landing with the IMD, which senior officials say will significantly enhance forecasting capabilities.M Ravichandran, secretary in the Union Ministry of Earth Sciences, told PTI that his ministry had been in discussions with the civil aviation ministry on the matter, and providing weather data would be "made mandatory for domestic airlines within a year"."It has to be mandatory... It will not only be

very useful for airline operations but also for weather forecasts everywhere," he said.

The earth sciences ministry secretary said weather forecasts depended largely on the number of observations collected.

The more observations we have, the better our predictions can be. It is similar to an exit poll -- if you gather data from more places, you will get a clearer picture. In the same way, we aim to collect information on temperature, humidity, and wind wherever possible," he said.

Vertical weather observations (obtained from aircraft and weather balloons) are more important than ground observations because they provide a complete picture of the atmosphere, not just what is happening at the surface, Ravichandran said. Weather systems such as storms form and evolve in the atmosphere, where temperature, humidity and wind conditions at different



altitudes play a key role, he said. The India Meteorological Department (IMD) launches weather balloons from 50-60 stations to collect critical data on temperature, humidity and wind at

various altitudes. Aircraft also record weather data during takeoff and landing. This data is transmitted to the ground in real-time and integrated into forecasting models. Unlike the limited number of weather balloons, thousands of aircraft can relay data. Ravichandran said all aircraft operating on international routes provided weather data because it was required by law. However, not all domestic airlines do so

as it is not mandatory for them.

He said many countries had made it mandatory for their airlines to provide this data and India needed to have a similar mechanism."The aircraft are already gathering the data. It would be a different issue if they were not doing so," he said.

'Air connectivity is increasing tremendously in India, with each state having 10 to 15 airports. Our prediction capability will improve significantly if all domestic airlines start providing this crucial data," he added.

How drug-smuggling detection soared in run-up to Christmas, New Year

NEW DELHI. The detection and seizure of weed and cocaine by customs officials across Delhi, Mumbai, Chennai, and other zones surged in the run up to the Christmas and New Year celebrations, with cases even involving foreign nationals concealing narcotics worth crores in their bodies.

Delhi customs reported registered nearly half a dozen cases in December alone involving foreign nationals arriving at Indira Gandhi International Airport (IGI) from Kenya, Brazil, the Philippines, and other countries hiding over Rs 50 crore worth of cocaine capsules inside their bodies.Just a week before Christmas, Mumbai customs reported multiple large seizures of hydroponic weed (marijuana) worth crores at Mumbai International Airport. The contraband was hidden in breakfast cereal boxes, passenger baggage, food packets, undergarments, and toys. Earlier last month, Mumbai customs destroyed narcotic drugs and psychotropic substances (NDPS), such as heroin, cocaine, marijuana, and charas worth Rs 410 crore, weighing nearly 55

kg, at the Common Hazardous Waste Treatment, Storage & Disposal Facility in Navi Mumbai. Meanwhile in Chennai, customs reported that the Air Intelligence Ûnit seized cocaine worth Rs 14.2 crore, weighing 1,424 grams, from a Kenyan woman traveling from Addis Ababa on December 7. Modus Operandi

In what could suggest the involvement of organised crime networks, traffickers could be using identical methods to smuggle cocaine into the country since a number

of cases emerged where capsules were hid inside human bodies and required medical extraction at Delhi's Safdarjung Hospital.In one such case, Delhi customs intercepted two passengers, a man and a woman, traveling from Sao Paulo, Brazil, via Paris on December 24. Both passengers exhibited "unusual behaviour" after crossing the green channel and "voluntarily" admitted to



carrying illicit goods.Under medical supervision at Safdarjung Hospital, a total of 105 capsules containing 937 grams of cocaine were recovered from the male passenger, while 58 capsules containing 462 grams of cocaine were recovered from the female passenger. The estimated value of the seizure was Rs 20.98 crore, officials said in a statement. Another case involved a

Filipino national traveling from Bangkok via Addis Ababa on December 13. The individual had ingested 90 cocaine capsules, weighing 676 grams and valued at Rs 10.14 crore, which were extracted through medical procedures.

Intelligence Input

While vigilance and "cutting-edge profiling techniques" are being used to prevent the entry of illicit products into the country, customs officials

are also relying on intelligence inputs to identify perpetrators.

For instance, on December 19, Mumbai customs intercepted a passenger arriving from Bangkok and seized hydroponic marijuana worth Rs 11.32 crore. The contraband, weighing 11.322 kilograms, was hidden in vacuum-sealed plastic pouches inside the passenger's trolley

Budget 2025: Salaried earners up to Rs 15 lakh may get tax relief. Details here

NEW DELHI. The upcoming Budget 2025-26 is likely to introduce significant tax benefits aimed at individuals earning up to Rs 15 lakh annually. These measures are expected to increase disposable incomes, spurring consumption in urban areas where most taxpayers reside. Sources indicate that the government is eyeing tweaks to the new income tax regime, introduced in FY 2020-21, which has attracted over 70% of taxpayers due to its simplified structure and regular enhancements.

PROPOSED CHANGES IN TAX STRUCTURE

Currently, under the new regime, income up to Rs 3 lakh is tax-free, while earnings between Rs 3 lakh and Rs 6 lakh are taxed at 5%, Rs 6-9 lakh at 10%, Rs 9-12 lakh at 15%, Rs 12-15 lakh at 20%, and above Rs 15 lakh at 30%. A standard deduction of Rs 75,000 ensures that incomes up to Rs 7.75 lakh are tax-free.

PROPOSED CHANGES IN TAX Sudhir Kapadia, EY India Tax &

Currently, under the new regime,

Smuggling of misbranded Indian cigarettes causing Rs 20k crore tax revenue loss, funding terrorism: ITC to Union MoF

from south-east Asian countries into India causes an annual tax revenue loss of Rs 21,000 crore, apart from helping finance terrorism, India's biggest cigarette manufacturer has cautioned in a letter to the Union finance ministry, sources said. The letter written by ITC Ltd, forwarded to all Customs and Directorate of Revenue Intelligence (DRI) formations last month, flags widespread smuggling of counterfeit cigarettes via air, sea and land routes, as well as speed post from foreign countries, mainly south-east Asia and Middle East, to India. Apart from tax losses and funding organised crime rackets, this affects tobacco farmers as cigarettes are manufactured abroad, the letter stated.

DRI data shows seized 9.1 crore cigarette sticks worth Rs 179 crore were seized in antismuggling operations in 2023-24, over 50% of which was via sea route. This is a 33% rise from last year and nearly double of what was seized in 2019-20. DRI and Customs together seized 17.85 crore sticks in FY24 worth Rs 308 crore.

One of the biggest seizures in FY24 of 63.7 lakh cigarette sticks was in Chennai port. Customs officials, both at seaports and airports in Chennai and Trichy, routinely foil cigarette smuggling bids. About 20 lakh cigarettes worth Rs 3.5 crore concealed in bitumen drums were seized at Chennai Port last month.

uch counterfeit cigarettes are available across India, officials said. DRI identifies India as a key destination and transit hub for illicit tobacco products, which poses challenges to public health, economy and law enforcement. This is a profitable venture for criminal networks, DRI said. There are two main reasons for this illegal trade. Indian probe agencies say cigarettes are subject to high taxes and import duties intended to curb consumption. The cost difference in legal cigarettes and smuggled ones is what drives this trade. Officials estimate the margin on sale of each smuggled stick at Rs 10 and that shopkeepers can sell it at cheaper than Rs 18-20 that Indian made cigarettes cost.

Profits are huge even after adding shipping costs as labour costs in south-east Asian countries like Cambodia and Vietnam is lower, officials say.

Secondly, though branding on smuggled cigarettes is similar to originals, they don't comply with packaging and labelling regulations, officials say. Postulating that the seizures made by agencies might only be the tip

Neymar says 2026 World Cup will be his last; hints at reunion with Messi, Suarez

Brazilian football star Neymar has announced that the FIFA 2026 World Cup will be his last opportunity to compete on football's biggest stage. While injuries have limited his impact at Al-Hilal in Saudi Arabia, Neymar remains determined to represent Brazil and is optimistic about earning a spot in the squad for the tournament, which will be jointly hosted by Canada, the United States, and Mexico.Brazil currently sit fifth in the South American World Cup qualifiers, with six matches left to secure a top-six spot for automatic qualification. Neymar, sidelined since October 2023 due to a ruptured ACL and meniscus, remains hopeful about contributing to his national team's campaign. The 32-year-old forward, who recently became Brazil's all-time top scorer with 79 goals, described the upcoming World Cup as his "last shot" at glory. Speaking to CNN, Neymar said, "I will try, I want to be there. I will do everything I can to be part of the national team. This will be my last World Cup, my last shot, my last chance, and I will do everything I can to play in it."



Neymar's time at Al-Hilal has been marred by injuries, limiting him to just seven appearances since his move from Paris Saint-Germain (PSG) for a reported fee of €90 million in 2023. His contract with the Saudi Pro League club runs until June 2024, but Neymar hinted at future possibilities, including a move to Major League Soccer (MLS) and a reunion with former Barcelona teammates Lionel Messi and Luis Suarez at Inter Miami.Neymar, Messi, and Suarez famously formed one of football's most celebrated attacking trios, leading Barcelona to a historic treble in 2015 before Neymar's record-breaking transfer to Paris Saint-Germain for €222 million (\$230.39 million)

Reflecting on the prospect of reuniting with his friends, Neymar said, "Obviously, playing again with Messi and Suarez would be incredible. They are my friends, we still speak to each other. It would be interesting to revive this trio. I'm happy at Al-Hilal, I'm happy in Saudi Arabia, but who knows. Football is full of surprises."

Sam Konstas admits provoking Jasprit **Bumrah in Sydney Test:** It was my fault

New Delhi. Australia's Sam Konstas admitted to provoking Jasprit Bumrah on Day 1 of the fifth Test in Sydney, a move that ultimately backfired when the Indian pacer dismissed Usman Khawaja on the last delivery of the day. With 15 minutes left in the day's play, Australian openers Usman Khawaja and Konstas faced the daunting task of surviving against Bumrah and Mohammed Siraj on a lively SCG track. A minor interruption from Khawaja, who stepped away to slow things down, seemingly irked Bumrah. However, it was Konstas at the non-striker's end who escalated the tension by engaging in a verbal exchange with the Indian stand-in captain. The heated moment ended with the umpire's intervention. On the very next delivery,



Bumrah dismissed Khawaja with a sharp delivery that caught the edge, sending the Indian team into wild celebrations. Bumrah then stepped toward Konstas in celebration but refrained from further escalation.

Reflecting on the incident, Konstas admitted his role in the sequence of events. Speaking to Triple M, he said, "I didn't get too fazed. Unfortunately, Uzi got out. He was trying to buy some time. It was probably my fault, but it happens. It's cricket. Credit to Bumrah for the wicket, but overall, it was a great team performance."

Konstas was a polarising figure in his debut series. From riling up Bumrah to theatrically egging on a crowd of 90,000 after a maiden half-century, the teenager has left his mark. His audacity was further highlighted in Melbourne, where he reverse-ramped Bumrah for four, setting the tone for a memorable debut series. However, his antics haven't always been welcomed. Virat Kohli's shoulder charge in the previous Test-aimed at Konstas-sparked widespread criticism and earned Kohli a fine.

"No, I was very calm. I was talking to my parents and teammates. Uzi (Khawaja) mentioned my adrenaline was pumped when batting, but I didn't feel it. Still, it was a great debut, and I'm happy with two wins."
