Mumbai, Feb. 02: Shiv Sena (UBT) leader Aaditya Thackeray there was no mention of Maharashtra which contributes the highest tax revenue in the budget speech, which was an insult to the state. In a post on X, Thackeray also expressed disappointment about the budget being silent on the demand of a new airport for Pune, and claimed that the BJP government has always neglected Maharashtra since 2014. While the Bharatiya Janata Party speaks of infrastructure growth, it is actually creating a contractor-based economy where favourite contractors get contracts and construct "horrible" roads like Mumbai-Goa, Mumbai-Nashik and Mumbai-Ahmedabad highways, Thackeray said. The BJP spoke of abolition of income tax between 2012 to 2014, and now its government is becoming more liberal and "negotiating" with tax payers on slabs and rebates but with a lot of conditions and hidden clauses, he said. This was due to the power of citizens that brought the saffron party's Lok Sabha tally down to 240 after it had taken the country for granted,

Thackeray said, referring to the income tax cuts in the budget presented by Finance Minister Nirmala Sitharaman. But it did not deal with the issue of unemployment which is at its peak, the Sena (UBT) leader said. "Not a single mention of Maharashtra is an outright insult to the state of Maharashtra, the state that contributes the highest taxes, including one of the highest GST consistently," Thackeray said in his reac-

"The body of the girl was found in a field this morning. Senior officials and the Forensics team reached the spot and collected scientific evidence. Prima facie, it seems that the murder did not happen on the spot, the girl was murdered somewhere else and her body was disposed of there," he added.

Meanwhile, Ayodhya SSP Rajkaran Nayyar further informed that police have detained a suspect for questioning and formed special teams to probe the case. "Three teams have been formed as of now, one suspect has been taken into custody and is being questioned.

Vengaivaval water contamination case: Special court adjourns plea against CB-CID chargesheet to February 3

PUDUKKOTTAI. The special court for trial of cases under the SC/ST (PoA) Act on Saturday adjourned the hearing on a petition challenging the CB-CID's chargesheet in the Vengaivayal water contamination case until February 3.

The chargesheet submitted last month by the CB-CID to the special court in the December 2022 case held three residents responsible for mixing faecal matter in the village overhead tank supplying potable water to the locality. Kanagaraj, based on whose complaint the case was registered, recently filed a petition seeking the court not to accept the chargesheet as he argued that the CB-CID had submitted it without informing him and without recording his statement. He also said that he was not informed of the removal of charges under the SC/ST (PoA) Act against the accused in the case.During the hearing on Saturday afternoon, senior advocate PP Mohan, representing Kanagaraj, argued before court that the CB-CID was obligated to provide a free copy of the chargesheet to the complainant. To this, public prosecutor KN Kumar appearing for the CB-CID replied that the complainant failed to appear before the investigating agency for questioning despite multiple summons having been issued to him. Meanwhile, the protest by a section of residents of Vengaivayal against the CB-CID charge sheet, which was suspended for two days over the death of an elderly woman villager, resumed on Saturday.

Sugarcane farmers urge TN government for subsidy scheme amid rising labour costs

DHARMAPURI. Sugarcane farmers in the district are distressed by increasing labour costs and have urged the state government to implement a special subsidy scheme that would provide them assistance during harvest season.Dharmapuri was once a major producer of sugarcane, but over the years, erratic climatic patterns, water shortage and rising labour costs have resulted in a decline of cultivation area. In 2024, sugarcane was planned to be cultivated in 2,800 hectares, but only 878 hectares saw actual produce. Farmers attribute this decline to a lack of profits which arises out of limited labour and increasing costs. The Tamilaga Vivasayigal Sangam state president told, "Nearly two decades ago, the state government set up two mills here, owing to the high production. But now, the produce is barely enough to run one mill. A tonne of sugarcane gives us about Rs 3,750, but we lose over Rs 2,000 to labour charges. Therefore, farmers are choosing alternative crops," he said. Another farmer, R Tamilselvan from Palacode said, "It is difficult to find labourers. As the harvesting period is seasonal, labourers seek other employment in off seasons. Labourers who are willing to work will require high wages. We cannot afford this without losing out on profits. Either the prices of sugarcane must be increased to at least Rs 5,000 per tonne or the mills must pay some assistance for tackling labour charges." When TNIE spoke to the agriculture department, they said, "The farmer's demand has been forwarded to the state government, Now it is up to them."

Fishlings released in Gundlakamma Reservoir to mark Meenotsavam

GUNTUR. Meenotsavam (fishermen festival) was held at Gundlakamma Reservoir in Bapatla district on Saturday.

Energy Minister Gottipati Ravi Kumar and Social welfare Minister Dola Bala Veeranjaneya Swamy participated in the event and released 20 lakh fishlings into the reservoir, marking the occasion. The local fishing community also attended, emphasising the project's significance to their livelihoods.

Madras HC dismisses

CHENNAI. The Madras High Court has dismissed the petitions filed by the owners of the ecommerce platform Flipkart challenging the complaint and the notices issued by the Enforcement Directorate over violations of the Foreign Exchange Management Act (FEMA) and the Transfer or Issue of Security by a Person Resident Outside India Regulations (TISPRO) over receiving foreign direct investments (FDI) and issuing of equity shares.

The court stated that the petitioners -Sachin Bansal and Binny Bansal had not availed the alternative remedy available before the adjudicating authority of ED as the ground for dismissing the petitions. Under FEMA, the court said that remedy is not available just before the civil court but also before the constitutional court, namely the high court, under section 35 of the Act.

Observing that any order passed by the adjudicating authority in a proceeding initiated under section 16 is liable to be scrutinised by the high court in a second appeal filed by the aggrieved party, Justice S Sounthar, however, reasoned that the remedy before the high court by way of appeal on question of law cannot be treated as "ineffective" remedy by no stretch of imagination.

"Hence I am not inclined to exercise my discretionary jurisdiction under Article 226 of the Constitution, especially when the petitioners failed to make out a case that they come under one of the exceptions to the general rule regarding availability of alternative remedy," the judge said issuing notice (in 2021) even granted liberty to the petitioners to file their explanations/objections before the adjudicating authority within 30 days. The ED had registered the complaint against Flipkart owners under sections 6 (3) (b) r/w section.

Three killed, one critical after ambulance carrying dead body hits tipper

BHADRAK/BALASORE. In a tragic incident, three persons including two members of a family were killed and another sustained critical injuries after the ambulance in which they were taking the body of a deceased kin home from Cuttack, hit a dumper near Maitapur Chowk on NH-16 in Bhadrak, on Saturday. The victims have been identified as 33-year-old Himansu Jena and his brother-in-law Sudhanshu Dhal of Palasia village in Bhograi, and the ambulance driver Dilip Singh. Jena's

mother Sabitri, who sustained critical injuries in the mishap, was initially taken to Bhadrak district headquarters hospital and later shifted to SCB MCH after her condition deteriorated. As per sources, Jena's father Dibakar, a TB patient,



was undergoing treatment at SCB medical college and hospital in Cuttack. He reportedly lost his life while undergoing treatment on Friday night. The family was taking his body home when the incident took place during the early morning hours of the day. Owing to dense

fog, the ambulance driver was reportedly unable to see clearly and as a result, hit the dumper in front of him. Jena, Dhal and the driver were killed on the spot. GUNTUR. In a move to enhance safety and accountability for auto rickshaws, Guntur Superintendent of Police (SP) Sathish Kumar launched a traffic police number system on Saturday. This initiative aims to maintain a database of auto rickshaws, ensuring safer travel for commuters.

Under the system, auto drivers and owners must submit vehicle details, Aadhaar cards, driving licenses, and passport-sized photographs to obtain a unique traffic police number. Each auto will display a sticker with the number and a unique QR code, allowing authorities to track vehicles efficiently. Superintendent Kumar also announced that displaying these numbers will be mandatory from February 28. The system will assist in resolving issues like lost items, auto theft, or criminal activities, as well as identifying traffic violations through CCTV monitoring.



Sathish Kumar highlighted that the unique number, similar to an Aadhaar ID, ensures traceability and accountability.

Auto drivers were urged to cooperate with the police to prevent crime and improve traffic management. The SP also inspected the upgraded East Traffic Police Station, reviewed staff working conditions, and discussed the need for traffic equipment and measures to address city traffic issues.Traffic DSP Ramesh, East Traffic CI (Circle Inspector) Ashok Kumar, SIs Ravindra Babu, Srihari, Sambasivarao Naik, and other officials were present.

HYDERABAD. The new tax regime introduced in the Union Budget on Saturday has received positive reactions from professionals, experts alike.

In effect, a taxpayer in the new regime with an income of Rs 12 lakh will save Rs 80,000 in taxes. Those earning Rs 16 lakh will save Rs 50,000, while individuals making over Rs 24 lakh annually will save Rs 1.1 lakh." Dr Dinesh Chandrasekar, chief strategy

News box With 50% UP's investments, Noida is top pick of realtors

Ghaziabad. State's real estate sector saw significant growth last year with 259 projects registered with UP-Rera promising a total investment of Rs 45,000 crore. While NCR cities accounted for 34% of the total projects registered, Noida emerged as the primary investment destination—cornering 46% of the total investment.

The Noida International Airport, set to see flight operations from April, is seen as a major real estate driver in the region. An extensive network of roads, railways, and new metro and rapid rail corridors planned around the airport are likely to improve connectivity and stimulate economic growth. This has propelled property demand in the area. Rera data shows the 51 projects registered in the city last year have brought in an investment of Rs 20,929 crore. In 2023, nearly 100 projects were registered in the city.At 61, the highest number of properties were registered in Lucknow last year. Together, the projects offer 53,655 units and an investment of Rs 6,150 crore. "Previously, we have seen that almost 50% of the real estate projects were being launched in Noida. The data for 2024 seems to change that. Lucknow now leads in the state in terms of the number of new launches. But Noida continues to lead in terms of the number of units, project area, and overall investment," an official from UP Rera said."The higher number of units (1.1 lakh units) with larger project area (1,35,500 sqm) and investment in Noida is attributable to the explosion of high-rise buildings in the city, driven by demand from the higher middle class," he said. Ghaziabad occupies the third position after Lucknow and GB Nagar in terms of area and units.UP Rera chairman Sanjay Bhoosreddy told TOI this was the highest number of projects to be registered in one year since the Authority's inception. A total of 197 projects were registered in 2023 and 215 in 2022."Real estate is gaining pace because of the forwardlooking policies of the govt. We are now witnessing the preference of the people for apartments in small and medium cities also, with the development of educational, health, employment and infrastructure facilities outside the metropolitan cities," Bhoosreddy said.

Truck with LPG cylinders on fire, houses & cars damaged



Ghaziabad: A massive fire broke out in a truck loaded with around 100 gas cylinders in the Bhopura area on Delhi-Wazirabad Road early Saturday morning, leading to a series of powerful explosions that damaged at least two houses and three cars in the vicinity.

Firemen and eight engines took nearly 1.5 hours to control the blaze. One personnel was injured during the firefighting operations. Chief fire officer (CFO) Rahul Pal stated that the Sahibabad fire station was alerted about the incident around 4.30 am, prompting the deployment of eight fire tenders."We had to evacuate the area and cordon it off as cylinder splinters were flying everywhere. Despite the risk, our personnel doused the fire in 1.5 hours," he said. The fire spread to two houses, three cars, and a motorcycle. While no casualties were reported, Pal confirmed that one firefighter was injured. Officials are yet to determine the exact cause of the fire.A senior official said that the truck was heading to Rampur and had over 100 cooking gas cylinders on board. The driver had refilled them before stopping in Bhopura to visit his family.

Many residents said that the explosions were so powerful they could be heard several kilometres away, causing panic in the area. As a precaution, police evacuated nearby homes while fire crews battled the blaze.

A resident described the chaos, stating that the blasts shattered car windows, terrace grills, and shop shutters. "We woke up to the deafening noise and rushed out of our house," he said.

3 lure man via dating app, hold him hostage and extort 1.4 lakh



Ghaziabad. Three men were arrested today for allegedly extorting Rs 1.4 lakh from a man they lured through a dating app Grindr. The suspects reportedly invited the man for a meetup, then held him hostage and forced him to undress while they recorded him. When the victim protested, he was physically assaulted. They also threatened to kill him. The perpetrators coerced him into making six online transactions amounting to Rs 1.4 lakh and threatened to release the video. Later, the victim was able to reverse two transactions totalling Rs 80,000. A case was reported at Madhuban Bapudham police station. Rinkû (37), Ajay (21) and Shubham (25) were arrested near Bunkar Mart. Their mobile phones were seized and Rs 9,042 was recovered from them, said Swatantra Kumar, Kavinagar ACP. During investigation, the suspects said they would lure people on Grindr and called them to meet in person. They would then attack the targets, take obscene videos of them, and threaten to kill them. They would then extorted money from them. Based on a complaint, police took action and used local intelligence to trace the suspects. "On investigation, it was found that Rinku, the gang's leader, was previously implicated in a similar case in Nandgram," Kumar said.

Trade wars have no winners: China as Trump imposes 10% tariffs

World. Hours after Donald Trump initiated a trade war with China, Beijing condemned the move and vowed to take "countermeasures to defend its legitimate rights and interests." The Chinese foreign ministry, in an official statement, said that the US tariff violates global trade rules and could disrupt cooperation on drug control efforts between the two countries."Trade and tariff wars have no winners," China's foreign ministry said. "The US's unilateral tariff hikes severely violate World Trade Organisation (WTO) rules," it added.

This comes as Trump imposed a 10 per cent tariff on Chinese goods. Beijing warned that such measures would not resolve economic issues in the US and would harm both countries.

China also addressed concerns over fentanyl, a synthetic opioid linked to overdose deaths in the US. It said Beijing has taken strong steps to control the drug and has cooperated with Washington."In the spirit of humanity and goodwill, China has given support to the US's response to this issue," the foreign ministry said. It noted that China classified all fentanyl-related substances as a controlled category in 2019, a step it said was taken at the request of Washington. China said it has engaged in broad cooperation with the US on drug control and called for a "rational" approach to the issue. "The US needs to view and solve its own fentanyl issue in an objective and rational way instead of threatening other countries with arbitrary tariff hikes," the

Zelenskyy Accuses Russia Of Bombing Its Own Civilians In Kursk Region

Kyiv. Ukraine President Volodymyr Zelenskyy has accused Russia of bombing its "own civilians" who were sheltering in a school in the Kursk region.Zelenskyy claimed that Russia dropped an aerial bomb on a boarding school while the civilians were still preparing to evacuate.

This is how Russia wages war--Sudzha, Kursk region, Russian territory, a boarding school with civilians preparing to evacuate. A Russian aerial bomb. They destroyed the building even though dozens of civilians were there." Zelenskyy wrote in a post on X on Saturday (local time). This is how Russia waged war against Chechnya decades ago. They killed Syrians the same way. Russian bombs destroy Ukrainian homes the same way. And even against their own civilians, the Russian army uses similar tactics," he added.

According to CNN, Ukraine has made advancements in Kursk, as stated by the Institute for the Study of War (ISW), a DC-based think tank, on January 26. On the other hand, the Russian Military said that it had recaptured the region.

On Saturday, Russia launched a barrage of drones and missiles on Ukraine killing at least 12 people, Al Jazeera reported.

Ukraine's air force claimed that it shot down 56 drones and redirected 61.

Ukraine's Emergency Services said a missile struck a residential building in the central city of Poltava killed eight people, including a child, and injured 17.

On Friday, A Ukrainian Military official informed that North Korean forces have "probably" withdrawn from the frontlines in Russia's Kursk region after suffering heavy losses, CNN reported.

Budget 2025: India Hikes Foreign Aid To Maldives, This Country Tops List; Where's Bangladesh?

world. The Ministry of External Affairs has allocated Rs 5,483 crore for foreign aid in the Union Budget 2025-26, up from Rs 4,883 crore last year. This financial year, 'Neighbourhood First' and 'Look East' policies seem to drive India's aid priorities. A whooping 64% of the total scheme portfolio (Rs 4,320 crore) has been allocated to its immediate neighbors for various initiatives, including major infrastructure projects like hydroelectric plants, power transmission lines, housing, roads, bridges, and integrated check-posts. Bhutan remains India's top recipient of foreign aid, with an allocation of ?2,150 crore for 2025-26, up from ?2,068 crore last year. India continues to be Bhutan's key development partner, providing financial support for infrastructure, hydropower projects, and economic collaboration.

Maldives Aid Surge Amid Diplomatic Thaw

New Delhi has increased its financial assistance to the Maldives by Rs 130 crore, raising the total aid to Rs 600 crore from Rs 470 crore in the 2024-25 budget. This makes the Maldives one of the largest beneficiaries of India's foreign aid, second only to Bhutan in priority among neighboring countries.

This increase comes at a time when Malé is actively working to rebuild its relationship with New Delhi, following a period of diplomatic tensions that arose after the election of President Mohamed Muizzu, who dominantly puts forward a pro-China stance.

Aid To Bangladesh Unchanged

India has retained its financial aid to Bangladesh at Rs 120 crore for 2025-26, with no increase from the previous year. The decision comes amid diplomatic tensions following the exit of former Prime Minister Sheikh Hasina, who has been granted asylum in India.

The new government, led by Muhammad Yunus, has formally requested her return, adding to the ongoing political strain between the two nations.

India's Cautious Approach With Afghanistan

India has significantly reduced its financial aid to Afghanistan, cutting the allocation from Rs 200 crore last year to Rs 100 crore in the 2025-26 budget—a steep drop from Rs 207 crore granted two years ago. The move reflects Prime Minister Narendra Modi's cautious approach toward the Taliban regime, with its engagement largely restricted to humanitarian aid and economic cooperation.

For mining sector expert Javed Noorani, authorities are tendering "maybe 10 times more than its own capacity to do things".

Madras HC directs Pudukkottai administration to consider PIL on illegal quarrying

MADURAI. The Madurai Bench of the Madras High Court directed the Pudukkottai district administration to consider a Public Interest Litigation (PIL) petition filed by a man seeking action against illegal quarrying in a village in the district.A division bench of Justices MS Ramesh and AD Maria Clete was hearing a petition filed by one C Ezhilarasu seeking direction to take action against the illegal quarrying operations carried out by one Subbu in Kunnathupatty village of Thirumayam taluk in Pudukkottai district, based on his representation in June 2023.

Observing that there has been a considerable lapse of time since the filing of the earlier representation, the court granted the petitioner the liberty to file a fresh representation to the concerned respondent, ventilating his grievances, as expeditiously as possible.On receipt of such a representation, the concerned respondent is directed to consider the same, on its own merits and pass appropriate orders in accordance with law, after giving due opportunity to the petitioner and the private respondents, as well as to any other person, who may be interested in the subject matter, within a period of three months, the court added.

TN to face power crunch amid summer as North Chennai plant works vet to be completed

CHENNAI. With Tamil Nadu's peak power demand projected to cross 22,000 MW, about 10% increase from last year, the state will require all of its thermal power plants to operate close to full capacity to bridge the demand without power cuts. However, the state's first 800MW North Chennai Super Critical Thermal Power Station (NCTPS-Stage III), which was inaugurated last March, is unlikely to be of any use since many infrastructure related works are yet to be completed. According to top official sources in the Tamil Nadu Power Generation Corporation Limited (TNPGCL), the power plant will not be ready to supply power during the upcoming

The Southern Regional Power Committee has predicted the state's peak power demand to be 22,150 MW this year."Despite the plant being inaugurated, few technical works remain unfinished. Hence, we are unable to run the plant commercially. We have generated less than 1,000 million units using imported coal or oil as fuel since the plant was inaugurated," a senior TNPGCL official told

Another official added that wagon-loading facilities and fly ash ponds at the new power plant are essential for it to run at full capacity. "For these, the utility had submitted a detailed project report seeking Rs 50 crore. But, the funds are yet to be allotted. In addition, BHEL is yet to hand over the power plant to the power utility as it has not reached its full generation capacity. Sources said technical issues have resulted in failed attempts by BHEL to run the plant at full capacity (800 MW).

Fishing for benefits: Kerala can enhance catch from high seas

KOCHI. The Union budget gives stress to the fishing sector to tap the potential of the marine sector by enabling a framework for harnessing fisheries from India's Exclusive Economic Zone and the high seas which can be beneficial for Kerala's fisheries sector. Aiming to enhance India's competitiveness in the global seafood market, the budget proposes to reduce the basic customs duty on frozen fish paste from 30% to 5% for the manufacture and export of its analogue products.

The basic customs duty on fish hydrolysate for manufacture of fish and shrimp feed has been reduced from 15% to 5%. Besides, the government will provide financial support for setting up a network of Nucleus breeding centres for shrimp broodstocks.

Financing for shrimp farming, processing and export will be facilitated through NABARD."The budget proposal will help end the stagnation in marine fisheries sector and increase production. Facilitating deepsea and high-sea fishing will help tap highvalue tuna species like yellowfin tuna,



skipjack tuna and other 10 speciest. The lack of infrastructure facilities in Lakshadweep and Andaman and Nicobar seas has led to under-exploitation of the resources in these

Expanding fishing activities to the high seas can lead to a steep increase in production," said KUFOS founder vice- chancellor B Madhusoodana Kurup. However, mechanised fishing operators are apprehensive of the initiative to promote high-seas fishing.

Kerala government indecision delays process to finalise metro rail alignment

THIRUVANANTHAPURAM. The process to finalise the alignment for the long-pending metro rail project in the state capital drags on owing to indecision of the state government. It's been several months since the Kochi Metro Rail Ltd (KMRL) - the Special Purpose Vehicle (SPV) roped in by the government to implement metro projects in the state submitted the proposal with six different alignments for the upcoming conventional metro rail project in Thiruvananthapuram. However, the state government is yet to take a decision and choose an alignment that will cater to the maximum number of riders.

According to official sources, the proposal is pending with the Finance Department for getting clearance. "If the alignment is passing via Secretariat the main arterial road will be blocked and we need to take a decision on constructing the metro underground. If the plan is for an overhead metro then the Bakery Junction - Thampanoor alignment would be ideal. These are policy matters and a decision on whether to take the metro underground or overhead needs to be taken. Only after making these decisions will we be able to finalise the alignment," said an official source.

Widespread demand to reroute the metro via Kazhakootam has turned into a headache for the authorities. With the NH66 work ongoing near Pallipuram, it's becoming impossible to plan a metro in the route. "Even the service road is feasible and we need to look for another alignment. These are policy decisions and once the finance department approves the project,



the chief minister level meeting will be held to finalise the alignment," said the official.KMRL MD Loknath Behera told TNIE that a decision on the alignment will be taken soon by the state government. "We have submitted the proposal and are waiting for the decision on the final alignment so that we can kickstart the process," said Behera.

The metro project for the state capital was conceptualised over a decade ago. However, the changing governments have failed to make the project into a reality. Initially, the Delhi Metro Rail Corporation Ltd (DMRC) proposed a monorail for the capital city. Later, it was decided to implement a light metro project for the capital. During the previous term, the LDF government sanctioned administrative sanction for the proposed metro projects in Thiruvananthapuram and Kozhikode.In February 2021, the Kerala Rapid Transit Corporation Ltd (KRTL) submitted a revised DPR for the light metro.

Later, the state government roped in KMRL as the SPV for the project which came up with the proposal of a conventional metro for the state capital. The Trivandrum Chamber of Commerce and Industries (TCCI) has come out with stiff criticism against the government and the KMRL for keeping the proposed

Elderly couple charred to death as son sets house on fire near Chennithala in Kerala

ALAPPUZHA. The charred bodies of an elderly couple were found in the remains of a house in Kottamuri, near Chennithala, which was allegedly set ablaze by their son in the early hours of Saturday. The deceased were identified as Raghavan, 96, and his wife Bharathi, 86. Mannar police arrested their son Vijayan. According to officers, an autorickshaw driver first noticed the fire around 3.30 am. Locals immediately alerted authorities.Fire and rescue service personnel extinguished the blaze and recovered the bodies. The house, with walls made of tin sheet walls and its roof interspersed with tarpaulin and asbestos sheets, was gutted in the blaze. According to reports, the couple and their third son, Vijayan, had differences over property. Vijayan, who used to live with his wife and



children, moved out of their house six months ago following an altercation. He then moved in with his parents again. He turned into a drunkard and quarrelled regularly with his parents over property. This may have been the motive for killing them, said officers."We suspect that he killed his parents before setting the house on fire," officers said. The bodies were shifted to Alappuzha Medical College

Hospital for postmortem."The autopsy report will help us ascertain the exact cause of death," they added. Vijayan will be produced before a magistrate on Sunday.Police registered a case under various sections including murder and arson. As per the police statement, Vijayan was planning to kill himself along with his parents, but he panicked as the fire engulfed the house. He then ran away from the

scene. The parents denied his demand for property and had rejected his reasoning for the same. This enraged Vijayan. This led him to the decision to kill parents and end his own life, it

Officers collected CCTV visuals from a fuel station where Vijayan had reportedly purchased the petrol used to set off the fire.

SCTIMST unveils two innovative drug-eluting bone graft products

THIRUVANANTHAPURAM, Sree Chitra Tirunal Institute for Medical Sciences and Technology (SCTIMST) has launched two innovative drug-eluting bone graft products. The products were unveiled by President of SCTIMST, S Kris Gopalakrishnan under the brand names CASPRO and BONYX. They were developed by the research team at the Biomedical Technology Wing of SCTIMST and commercialised by M/s Onyx Medicals Pvt Ltd, Meerut, UP. BONYX' contains bioceramic beads for local drug delivery in bone, mainly to handle bone infections.

In this product, the bone mineral composition is designed as ceramic beads with multi-modal porosity, through a patented process.The beads allow the vacuum loading of antibiotics or drugs in liquid form, and then release the same in the implanted region in a controlled manner, sustainable for more than 30 days.Being composed of osteoconductive minerals, they integrate with native bone issues ensuring the dead-space management and local bone regeneration. 'CASPRO' is a bioactive, mouldable and selfsetting bone cement designed for drug delivery in bone. The product is composed of synthetic medical grade basanite (or calcium sulfate hemihydrate mineral), fortified with phosphate ions, prepared through a proprietary 'drowning out' precipitation process.

On wetting with aqueous solution, the powder forms a putty or paste, which could be used for the repair of bone defects. In addition, the cement gives provision to add antibiotics or drugs to it, in either powder or liquid form, and facilitate the controlled release for a period of over 21 days.Both products are the results of years of scientific research and development and validation for regulatory approval as per International Standards. The making of the products CASPRO and BONYX, which spanned over a decade, demonstrates a viable model in the country to develop biomedical products.

KLEF top brass arrested in NAAC bribery case

VIJAYAWADA. Central Bureau of Investigation (CBI) officials on Saturday arrested the top brass of Koneru Lakshmaiah Education Foundation (KLEF) and members of the National Assessment and Accreditation Council (NAAC) inspection team in connection with a bribery case. In an official statement, the CBI confirmed that a case had been registered against the office bearers of the educational institution as well as the NAAC inspection team members.

The allegations involve offering undue advantages to public servants in exchange for favourable NAAC ratings, specifically for A++ accreditation. The investigation agency also conducted searches at 20 locations across various cities, including Vijayawada, Chennai, Bengaluru, Palamu, Sambalpur, Bhopal, Bilaspur, Gautam Buddh Nagar, and New Delhi.

During these searches, the CBI sleuths seized Rs 37 lakh cash, six laptops, one mobile phone, and other incriminating documents.KLEF Vice-Chancellor GP Saradhi Varma, Vice-President Koneru Raja Hareen, Director of KL University (Hyderabad Campus) A Ramakrishna, NAAC Inspection Committee Chairman and Vice-Chancellor of Ramchandra Chandravansi University Samarendra Nath Saha, Member Coordinator and Professor at Jawaharlal Nehru University Rajeev Sijariya, NAAC Inspection Committee Member and Dean at Bharath Institute of Law Dr D Gopal were arrested the by CBI on Saturday.

Other NAAC inspection members including Rajesh Singh Pawar, Manas Kumar Mishra, Gayathri Devaraj, and Dr Bulu Maharana were also arrested. The agency stated that a total of 14 individuals are involved in the case, and confirmed that a investigation is underway to uncover the full extent of the crime and identify others involved.

Scope for Andhra Pradesh, Telangana to spur rural growth

Andhra Pradesh. Andhra Pradesh seeks to become a \$2.5 trillion (Rs 216.48 lakh crore) economy by 2047, meaning that it would have to grow over the next 22 years at a CAGR of 13.53% from its current (2024-25) GSDP of \$190 billion (Rs 16.41 lakh crore). That is, the economy has to expand by 13 times in 22 years.

Theoretically, it may be possible, but practically, an unnerving target. Post bifurcation, Ap's growth rate has been flat, relative to Telangana. Further, fiscal prudence, (or the lack of it) is also a matter of concern for both Telugu States. While revenue from own tax sources and Central transfers amount to Rs 1.77 lakh crore, AP's debt is Rs 4.91 lakh crore (2023-24). In other words, AP has a current debt liability thrice that of its annual income. Some of this accumulated debt is certainly attributable to profligacy, or mismanagement.

So, achieving such an ambitious growth target while balancing its liabilities will definitely be a tough call. Assuming that governance improves, own revenue sources diversify and expand, identification and prioritisation of growth sectors is properly done, strong Central budgetary support is likely, and



favourable global investment climate prevails over the next two decades, near 13% growth is feasible. But then, these are too many ifs. Good to have an ambition, but it is better to be realistic. Now that the context has been set, let us examine the Finance Minister's Budget speech. To my mind, the FM perfectly identified the key growth engines for the country - (1) Agriculture (2) MSME (3) Investment and (4) Exports. Funds should flow within the above framework over the next few years.

I steer clear of the persistent demands like Polavaram, Railway Zones, new capital, etc. because they are somewhat politico-economic in nature. Special dispensations can always be found for them if political cards are played well. So, let us limit the discussion to what the

current budget can give to the Telugu States. Within the domain of agriculture, the one that catches my attention is the PM-Dhan Dhanya Krishi Yojana. Andhra and Telangana already have six notified aspirational districts.

The new scheme envisages that 100 districts with low productivity, moderate crop intensity and below-average

credit parameters are picked for this scheme. If both the Telugu States can get at least 10 additional districts under the new scheme, primary economy will expand and the slogan - 'produce only if you can process' acquires meaning.

Focussing on pulses, using India Post as an institutional mechanism for providing multiple services to the farmers is a meaningful initiative. While pointing out that 45% of our exports are done by MSMEs, in one fellswoop, she widened the ambit to cover a much larger number of enterprises under the definition, as the turnover limit goes up to Rs 500 crore which is very significant. If we can leverage these growth engines, both the Telugu States will develop rapidly. But as always, it is a big 'if'

TN exporters hail budget for boosting cotton output, knitwear exports

TIRUPPUR. The Export Promotion Mission and a five-year plan to boost cotton production, announced in the union budget, would together drive up exports of knitwear firms and cut down manufacturing costs, said Tiruppur Exporters' Association president K M Subramanian on Saturday.

Subramanian said the budget included positive announcements, for instance, the announcement of Export Promotion Mission, with sectoral and ministerial targets, driven jointly by the Ministries of Commerce, MSME, and Finance. He said, "The government said it will streamline credit access for exporters, support for crossborder factoring and assistance for MSMEs to tackle non-tariff measures in overseas markets."On the mission for cotton productivity, Subramanian said the initiative would ensure a reduction in cotton prices and the availability of quality cotton, "Nearly 80% of the total production of the Tiruppur knitwear sector is cotton garments," he said. The turnover limits of MSMEs have been raised, which is one of their long-pending demands, he said.

"MSMEs with investments up to Rs 125 crore will be recognised as medium enterprises, an increase from the previous limit of Rs 50 crore," he said. Responding to TNIE on whether the announcements were adequate to address the challenges faced by the ready-



made garment export sector, he said, "We will seek other requirements from the centre.'

Similarly, Tiruppur Exporters and Manufacturers Association (TEAMA) president M P Muthurathnam said the budget is "very favourable" for

MSMEs.Apparel Made-ups and Home Textiles Sector Skill Council chairman A Sakthivel said the raising of investment and turnover limits of MSMEs will help enterprises achieve higher efficiencies of scale, technological upgradation and better access to capital. The revision in classification criteria will bring in more firms under the MSMEs coverage. The provision to voluntarily

declare material facts and pay duty with interest but without penalty will incentivise voluntary compliance. But, it will not apply in cases where the department has already initiated audit or investigation proceedings, he said.

What Ambedkar's vandalised statues imply

During a recent seminar to mark 75 years of the Constitution, my colleague in the Joint Action Committee on Telangana, Prof M Kodandaram, summed up the state of affairs in two lines. He said there were two groups of people in this country those who wanted to throw the Constitution into the Bay of Bengal and those who wanted to protect it with their lives. We have been witnessing the vandalisation of statues of the 'Father of the Constitution', BR Ambedkar, all over the country. One such incident took place on Heritage Street in Amritsar —and, that too, on Republic Day.

The culprit climbed atop the statue using a steel ladder and hit it with a hammer before he was nabbed. In his statement to the police, he said that he did not believe in the Constitution. The fact that he belongs to a reserved category makes it all the more deplorable. The development prompted a visit to the holy city by Union Minister of State for Social Justice and Empowerment Ramdas Athawale, who issued directions for strict action to ensure that such incidents were not repeated.

Ambedkar's statues are found in virtually every city and town, besides many villages. They mostly stand unprotected. Last year, the Andhra Pradesh Government unveiled the world's tallest statue of Ambedkar in Vijayawada. Standing 206 feet from the ground, the 'Statue of Social Justice' figures among the 50 tallest statues worldwide (Sardar Vallabhbhai Patel's 'Statue of Unity' tops the list). The second-tallest Ambedkar statue (175 feet) is situated in the neighbouring Telangana.

The trend of idolising national icons started with the installation of Mahatma Gandhi's statutes in various towns and cities. Some roads were also named after him. As the Dalit movement in India grew stronger, the community went all out to make its presence felt across the country. In several states, Dalit leaders and activists raised the demand for the installation of a bust or a statue of Ambedkar at a central location in cities as well as towns. In some cases, they collected money and put up the statue at a place provided by the municipality concerned. Those who benefited from reservation displayed a photograph or portrait of Ambedkar in their offices. The ruling Aam Aadmi Party (AAP) has done it in Punjab offices, where portraits of Ambedkar are showcased beside those of Shaheed Bhagat Singh, particularly in the Chief Minister's Office.

As a result of these endeavours, the movement spread to villages. In parts of coastal Andhra Pradesh, you can even find two Ambedkar statues within a distance of one kilometre. The political statement made by the Dalits was that no other leader (except Gandhi) could be seen as a pan-India phenomenon. One of the best features of the Ambedkar statues for Dalits is that the location gives them a great opportunity to use it as a protest site in cases of atrocity against members of the community. They invariably protest by holding candles in front of the statue. This gesture is also common among Dalits who are part of the diaspora. Ambedkar statues adorn places like Columbia University, the London School of Economics and Brandeis University in Massachusetts, US. An Ambedkar statue was unveiled in October 2023 in Maryland, US, reinforcing the commitment of the Dalits to their icon. A possible trigger for the vandalisation of the Ambedkar statue in Punjab, which has a significant Dalit population, could be antipathy towards the community, whose members have been seeking constitutional rights over the years and demanding punishment for the culprits who commit atrocities against them.

Or, it could be due to disillusionment and discontent within the community. The Amritsar incident might also have a political angle, considering that the AAP is not only in power in Punjab but also in Delhi, where the Assembly elections are scheduled for February 5. The iconography of the Ambedkar statue is clearly recognisable: he is shown holding the Constitution in one hand, while the other hand is raised, indicating that he is showing the right path and direction to his followers and admirers. As the Constitution is an inseparable part of his iconography, the recent incident could be a symbolic assault on constitutional values and mandate.

Kotkhai and the unchecked horror of custodial torture

The culture of impunity created as a result of not fixing accountability in custodial torture cases must be pierced.

On July 4, 2017, a 16-year-old girl went missing in Himachal Pradesh's Kotkhai. Two days later, her body was recovered from a forest near the town. The sensational rape and murder of Gudiya (the name given to the minor victim by locals) made newspaper headlines across the country and triggered political mudslinging and massive public protests.

In order to assuage public sentiments, the government swiftly formed a special investigation team under the then IG, Zahoor Haider Zaidi. In such highprofile cases, a combination of mounting political pressure, an aggressive media and rising public outrage often forces the police to resort to an old script — of quickly picking up scapegoats and inflicting torture on them to extort confessions and douse the anger.Unfortunately, this case was no

different. Twelve days later, Suraj Singh, one of the suspects in the case, was brutally tortured and killed by the police. An investigation by the Central Bureau of Investigation later revealed that a nexus of eight officials - Zaidi, DSP Manoj Joshi, Sub-Inspector Rajinder Singh, ASI Deep Chand Sharma, head constables Mohan Lal, Surat Singh and Rafee Mohammad and constable Ranjeet Steta - was involved in the conspiracy and cover-

The brazen conspiracy was only the latest example that spotlighted the grim reality of custodial torture and deaths. The malaise has not been eradicated despite the Supreme Court, the National Human Rights Commission and civil society groups repeatedly lamenting that allowing this criminality

to continue by not fixing accountability on perpetrators had created a culture of impunity.

The conviction pronounced by a CBI court last week for illegal detention, torture to extort confessions, murder, fabricating and destroying evidence, and other crimes in the case, is an important blow to this culture of impunity.

It offers a glimmer of hope for holding the police accountable for their actions, especially in a milieu where convictions in custodial death cases are rare. Three takeaways from the case are crucial.

First, the focus on the role of the whistleblower, Dinesh Kumar, who was the sentry on duty outside the lockup of the Kotkhai police station at the time of

His testimony provided a crucial account of the night when police officers brutally beat Suraj Singh and others on the first floor of the station, with their screams echoing down to the ground floor. The extraordinary nature of this testimony is evident when one turns to the 1995 State of MP vs Shyamsunder Trivedi case, where the Supreme Court noted that police officers, bound by "ties of brotherhood", often choose to stay silent rather than assist the court. Initially, this case was no different. All personnel involved --- except Dinesh Kumar and Mukesh Sharma (the night munshi on duty) — worked together to fabricate and destroy conspiracy to falsify the death. Despite frequent threats from Rajinder Singh, the then SHO of



Kotkhai Police Station, Kumar stood firm. Not only that, he recorded these threat calls, which became a key piece of evidence in holding the perpetrators accountable. His bravery in speaking the truth and exposing the crimes committed by his superiors was the single biggest contributor to the landmark conviction. Second, the critical role of the CBI cannot be overstated. Its investigation to unearth the fabrication of the general diary and other documents at the police station and interference with the CCTNS (Crime and Criminal Tracking Networks and Systems) as well as ensuring that the autopsy report was not manipulated and safeguarding the family from the fear of reprisal so that they could testify in court, all collectively ensured that Suraj

Singh's killers were brought to justice. Third, the brazenness displayed by the police even in a highprofile case with nationwide scrutiny is instructive. The IG confidently proclaimed in a press conference that the police had 'cracked' the Gudiya case and arrested the culprits based on scientific evidence, whereas the arrests were made six hours after this press conference. Further, the IG tried to intimidate and force the then SP, Shimla, to hand over Suraj Singh's body to the family for cremation even as the re-examination of the body was yet to be conducted - all this, at a time when the police had not even informed the family of Suraj's death.

evidence.Kumar, however, resisted joining the Clearly, even intense media scrutiny and political pressure were not deterrents enough for the officials to stick to the law. The conviction is heartening,

> especially in a system where guilty officers often escape any accountability. But it is far from a watershed moment. The 400-oddpage judgment makes for sombre reading and is a ringing indictment of the criminal justice system.

It showed that despite a flurry of apex court orders, torture of suspects is rampant and easily excused. Medical reports and testimonies of the co-accused revealed that they were stripped naked, hung upside down, beaten with lathis and given electric shocks. Suraj Singh's autopsy report showed that he was beaten with a blunt hard cylindrical object/weapon, such as lathi, rod or baton, from about two days to two hours prior to death.

It showed that the fabrication of evidence can be done with little fear of consequences. And, it showed that whistleblowers continue to battle mounting challenges if they choose

to expose the rot in the system. The Kotkhai verdict was achieved against odds because of the grit of investigating officials to uncover and deal with procedural violations, the courage of the eyewitnesses to stand up and testify against their superiors, even threats hanging over their heads, and the availability of the recordings to corroborate these testimonies. Now, the hard work must begin to pierce the culture of impunity. While a complete overhaul of police selection, training and orientation is essential, some immediate steps need to be taken. Certain legislative changes will significantly help in preventing law enforcers from becoming lawbreakers.

While this find holds the potential to transform India's battery industry, concerns persist over deforestation, groundwater depletion and displacement of local communities. Notably, insufficient exploration data has deterred industry players from bidding for the Reasi reserves. The more modest lithium block in Chhattisgarh is the only one to have been successfully auctioned.

Additionally, strengthening local manufacturing of batteries, electric vehicles and renewable energy infrastructure will be critical to reducing reliance on global supply chains. India must also expand its strategic partnerships with mineral-rich nations to ensure supply stability. It has partnered with Argentina for lithium exploration. Discussions with Australia, Chile and Bolivia are also on. Expanding such collaborations and securing long-term agreements will be crucial for building a resilient and self-sufficient critical minerals ecosystem.

THE GREAT GAME: The life-and-death battle in Prayagraj holds a lesson for the Opposition

ASHES to ashes, dust to dust. Equal parts devotion, despair, desperation, anger and even, fulfilment. Above all, the ability to swallow insults over millennia. And so the Ganga gobbled up another 31 bodies on the night of the sacred Mauni Amavasya earlier this week at the Maha Kumbh in Prayagraj and seven more in the neighbouring village of Jhusi - a much smaller stampede, the day after. What's 38 lives when several crore people took a sacred dip in the Sangam at exactly the same time, cleansing both body and soul. Yogi Adityanath has still not confirmed the numbers his police have put out. PM Modi has reassured the families. VHP global chief Alok Kumar has said that this is the "will of god."

The problem is that the VHP leader is right. There is probably deep sorrow in the ashrams and akharas on the banks of the Ganga these last few days at the deaths of the pilgrims, but the overwhelming sentiment remains, "Chalo, ho gaya. It was terrible, but this is the Kumbh. Not just an ordinary Kumbh, a Maha Kumbh. How can any government be blamed when millions of devotees want to pray together at the same time in such a small space?"People like me will point to the unshakeable fatalism of the Hindu devotee and say, perhaps this is part of the problem. Some of you upstanding folk may metaphorically stomp your feet and add, Sack this CM, transfer that DGP. Instead, I would entreat all of you to get out of your heated homes and go to the nearest railway station from where the Kumbh Specials for Prayagraj are leaving. People carrying bundles of provisions on their heads, the poorest of the poor, with nothing to hold on to except their faith in the Almighty perhaps, someday, she May improve their lot. The coaches of the trains are packed to the gills with human beings, dark, expectant eyes set in bronzed faces, men with gamchas tied over their heads, women wearing brightly coloured saris - red, orange, pink, the colours of fertility, of celebration. Of course this is also a pilgrimage of joy.

Jai Ma Gange!" echoes as you walk and walk and walk over the pontoon bridges on the Ganga and then to and from the Sangam, over the sand in which bodies were buried during those awful Covid years barely five years ago. You remember the pictures of dogs poking their noses in those sands. Families have spread themselves on it now, on plastic sheets made from used KitKat wrappers. Home Minister Amit Shah and his wife, accompanied by Yogi, also came for a dip in the Sangam on Monday, so the police shut 17 bridges back into the city, in the name of security. Scenes of mothers with babies as well as older people exhausted beyond belief plead with UP policemen to let them pass, but they remain unmoved. You must trudge to the 18th and the 19th bridge to return, another 4 km upstream, they say. Upar se aadesh aaya hai.A minor political row has broken out since the Mauni Amavasya stampede, with Akhilesh Yadav crying foul, saying he doesn't believe the low numbers of deaths being cited, while Rahul Gandhi has complained about the "VIP culture" that discriminates against ordinary folk. Certainly there are still many missing people.

A judicial enquiry will attempt to figure out the truth, but the fact remains that nothing these Opposition leaders say is likely to amount to even a drop in the churning ocean of UP politics, because they are not seen as serious alternatives to the political regime at hand. Any anger against Yogi, it is now clear, will only come from the faceless devotees themselves, who feel that the chief minister, elected on a majority Against the light, Rahul looked so good in that photo-Hindu mandate, hasn't done enough to take care of them. Moreover, the cynic will point out, anger cannot be transformed into a political challenge unless it is channelised by someone. How to reuse Cooking oil?

Are you wary of using your cooking oil after frying a batch of nachos, because of the health implications? Here are some tips to reuse them.

Choose the oil

If your frying technique is off, your oil won't be reusable. Every oil has a specific smoking point, - the temperature where the oil starts breaking down. Use oils like canola, peanut or vegetable oils with a high smoking point that won't break down easily. Avoid reusing olive oil as it has a low smoking point and a dominant flavour, which makes it a bad choice for deep-frying in the

first place. Filter the oil

After the first (and each subsequent) fry, drain the oil and filter it. Any impurities and unwanted extras like loose crumbs or bits of batter are going to spoil the oil's integrity, making it burn the next time



you heat it. Put a few layers of cheesecloth in a metal strainer to filter out the crumbs.

Refrigerate it

Let the oil cool down till it's at room temperature, and then refrigerate it in an air-tight container.

Use separate oils according to flavour

The oil is going to take on the flavour of the food you cooked in it, which makes fried fish oil ideal for shrimp, but not good for onion rings. Separate the oils to prevent bad flavour overlaps.

Defence Ministry to return Rs 12,500 crore unused funds amid procurement delays

New Delhi. The Defence Ministry is expected to return Rs 12,500 crore from its 2024-25 budget due to not fully using the funds allocated for capital acquisition. This comes as the ministry's budget for 2025-26 rises to Rs 6.81 lakh crore, marking a 9.53 per cent increase from the previous year. The main reason for the underutilisation of funds is the slow and complex defence procurement process, which causes delays. Out of the Rs 6.81 lakh crore allocated for 2025-26, Rs 1.8 lakh crore is set aside for capital expenditure, including Rs 1.48 lakh crore for modernising and acquiring essential defence equipment. However, the modest 4.65 per cent increase in capital allocation has raised concerns due to inflation and currency fluctuations.

The remaining Rs 31,277 crore is allocated for Research & Development and infrastructure development, with Rs 1.12 lakh crore earmarked for procurement from domestic industries under the Atmanirbhar Bharat initiative. Two major deals worth over \$10 billion are likely to be concluded by the end of the fiscal year, which includes the procurement of 26 Rafale-M fighter jets and three additional Scorpene-class submarines from France. These deals are expected to coincide with Prime Minister Narendra Modi's upcoming visit to Paris in February 2025.

The Rafale-M jets are critical for bolstering India's naval capabilities. Additionally, the Army is set to finalise the procurement of 307 Advanced Towed Artillery Gun Systems (ATAGS) valued at Rs 8,000 crore. While the armed forces grapple with procurement delays, the Indian Coast Guard (ICG) has received a significant boost in its allocation. The ICG's budget has increased by 26.5 per cent, with a sharp 43 per cent rise in its capital outlay, which now stands at Rs 5,000 crore.

The additional funds will be used to acquire Advanced Light Helicopters, Dornier aircraft, fast patrol vessels, training ships, and interceptor boats, enabling the ICG to enhance coastal security and respond more effectively to emergencies, according to officials.

To streamline procurement, the government has started consolidating capital expenditures for the three armed services under a single framework. This unified approach aims to cut down on redundancies and boost efficiency in acquiring critical assets like land, aircraft, aero-engines, and heavy vehicles.

Dense fog envelops Delhi, as cold conditions prevail

NEW DELH. Dense fog covered the national capital on Sunday morning affecting visibility.

The fog was accompanied by cold winds. According to India Meteorological Department (IMD), the lowest temperature in Delhi today is 10 degree Celsius. The weather department has forecast dense fog in isolated places over Punjab, Haryana, Delhi and Uttar Pradesh. The Met Department has predicted rain for Delhi on February 3.

Meanwhile, Dehi's air quality was recorded in the "very poor" category. According the Central Pollution Control Board, Air Quality Index was



logged at 340 at 8 am this morning.

An AQI rating is categorized as follows: 0-50 (good), 51-100 (satisfactory), 101-200 (moderate), 201-300 (poor), 301-400 (very poor), and 401-500 (severe). Cold weather conditions continue to grip the national capital, with residents seeking refuge in night shelters to escape the biting cold.On Saturday night, many were seen huddled in shelters across areas like Nizamuddin and Lodhi Road, looking for warmth amid the harsh conditions. The dip in morning and night temperatures is attributed to northwesterly winds coming from the Himalayas.



No tax for up to Rs 12.75 lakh, major overhaul in slabs

NEW DELHI. Finance Minister Nirmala Sitharaman on Saturday gave the middle class and the common man enough reasons to smile when she announced her personal income tax proposals.

Not only did she increase the income threshold up to which no taxes would be levied from Rs 7 lakh to Rs 12 lakh, she also changed the income tax slabs that will lead to a substantial reduction in tax burden for all taxpayers under the new tax regime. With these changes, and the standard deduction of Rs 75,000, an individual earning Rs 12.75 lakh a year will have to pay no taxes under the new tax regime. However, if one's taxable income crosses that threshold, all the income would be taxed as per the new slabs, which are both magnanimous and generous.

The new tax slab increases the basic exemption limit from Rs 3 lakh to Rs 4 lakh, which means the first Rs 4 lakh would attract no taxes. Income from Rs 4-8 lakh would attract a rate of 5%, Rs 8-12 lakh would attract 10%.

From Rs 12,00,001 to Rs 16 lakh, there will be 15% tax and from Rs 16,00,001 to Rs 20 lakh, the tax rate would be 20%. The government has introduced a new tax slab of 25%, which would be applicable on income from Rs 20,00,001 to Rs 24 lakh. The highest tax slab of 30% kicks in only if the income crosses Rs 24 lakh per annum.A taxpayer in the new regime with Rs 12 lakh income will save Rs 80,000 in tax (which is 100% of tax payable as per existing rates). A person earning Rs 18 lakh will get a tax benefit of Rs 70,000 (30% of tax payable as per existing rates), while a person with an income of Rs 25 lakh gets a benefit of Rs 1,10,000 (25% tax payable as per existing rates).

Meanwhile, the FM also announced that the new direct tax bill will be introduced in the Budget session of Parliament. "The new income-tax bill will carry forward the same spirit of 'Nyaya'," said the FM, adding that the new bill will be clear and direct in text with close to half of the present law, in terms of both chapters and words.

From letters to logistics: With 1.5 Lakhs rural post offices, FM announces in Budget

New Delhi. Finance minister Nirmala Sitharaman Saturday announced the govt's plan to transform India Post into a large logistics organisation with 1.5 lakh rural post offices.

needs of Viswakarmas, new entrepreneurs, women, SHGs, MSMEs, and large business organizations."India Post's range of services will now include rural community hub colocation; institutional account services; DBT, cash out and EMI pick-up; credit services to micro enterprises; insurance; and assisted digital services. The FM added services of India Post Payment Bank will be deepened and expanded in rural areas.

NEW DELHI. Despite terming Agriculture as the first engine of growth, the Union Finance Minister Nirmala Sitharaman has allocated a lesser amount than previous year. The allocation of 2025-26 is around 3% less than previous year revised estimates. This year, total budgetary allocation for the department of agriculture is Rs 1,27,290 crore whereas it was Rs 1,31,195 crore (revised estimate)

However, a major emphasis is given on natural farming and flagship scheme Rashtriya Krishi Vikas Yojana (RKVY). The funds for National Mission on Natural Farming has increased by over 500% and RKVY funds

increased by 41% compared to previous year. Even Krishonnnati scheme has witnessed an increase of 12 % over previous year.

The government gave a major relief to 7.7 crore farmers who hold Kisan Credit Cards (KCC). The loan limit under the Modified Interest Subvention Scheme will be enhanced from Rs 3 lakh to Rs 5 lakh for loans taken through the

However, there is no chance for that drama anymore as the England batting lineup imploded in the final 5 overs of the 4th T20I în Pune, handing India an unassailable lead of 3-1 in the series. Now that both teams are playing a dead rubber before the ODIs, a lot of changes can be expected, at least for the hosts on Sunday.

But, is all lost? Is there no drama, something to look forward to in the final T20I?

Of course, there is.

Bangladesh Cricket appoint independent committee to probe BPL corruption allegations

New Delhi The Bangladesh Cricket Board appointed an independent inquiry panel to help its Anti-Corruption Unit in investigating a series of corruption claims made in recent weeks in the Bangladesh Premier League. This is the first formal corruption inquiry in the BPL since 2013, as the league deals with delayed player payments and ticketing issues.

"As part of its ongoing efforts, the BCB is in the process of establishing an Independent Inquiry Body to further support the ACU in its investigations," a BCB press release said. "The BCB remains dedicated to ensuring a fair and transparent cricketing environment, and will continue to take all necessary actions to safeguard the integrity of the sport in Bangladesh."The ongoing BPL season is under scrutiny over corruption allegations, with reports claiming that the BCB's Anti-



Corruption Unit (ACU) has identified eight matches suspected of spot-fixing and match-fixing based on anonymous tips and media reports. Ten players are also under investigation, while four franchises are being closely monitored. Among the players, six have played for the Bangladesh national team, two are uncapped Bangladeshi cricketers, and two are foreign players.

Among the franchises, Durbar Rajshahi and Dhaka Capitals have the most integrity concerns, with 12 flagged instances each, while Sylhet Strikers and Chittagong Kings have six and two, respectively."The BCB has also come across media coverage regarding potential anti-corruption concerns about the BPL. The Board reiterates its firm commitment to upholding the integrity and spirit of the game," added the release. A day after the announcement, the BCB reaffirmed its commitment to preserving the league's integrity and revealed plans to set up an independent inquiry committee to support the ACU's investigations."The BCB strictly adheres to the ICC Anti-Corruption Code for Participants and maintains a zero-tolerance policy towards corruption in any form. The BCB anti-corruption unit is continuously monitoring all matters relating to integrity




