#### Airstrikes after Pulwama terror attack befitting reply to terrorists: Amit Shah

New Delhi, Feb.15: Union Home Minister Amit Shah Friday paid homage to the martyrs of the Pulwama terror attack and praised Prime Minister



Narendra Modi for giving a befitting reply through airstrikes in Pakistan. Forty jawans were killed when a Jaishe-Mohammad suicide bomber rammed an explosive-laden car into a CRPF convoy at Lethpora-Pulwama on the Jammu-Srinagar National Highway

Indian Air Force fighter jets bombed terror training camps in Balakot, deep inside Pakistan. On the anniversary of the terror attack, Shah said the martyrdom of the jawans made the country's borders safe. Addressing an event at the conclusion of the 38th National Games here, the Union home minister said, "On this day in 2019, our 40 jawans were martyred in Pulwama. But their martyrdom made the country's borders safe. "I pay tribute to them with all my heart. But through the airstrikes that followed Prime Minister Narendra Modi gave a fitting reply to terrorists," he said. The Pulwama attack and the airstrikes that followed have changed the way the world looked at India, he said. "It sent out a message to terrorists all over the world not to play with our troops or our borders.

# Rahul Gandhi calls for stronger industrial, manufacturing base in India

New Delhi, Feb 15: Congress leader Rahul Gandhi on Saturday accused Prime Minister Narendra Modi of "failing to grasp" innovations like drones, which require a "strong industrial system." He called for a "strong production base" to build "real industrial prowess" and generate employment for the youth. "Drones have revolutionised warfare, combining batteries, motors and optics to manoeuvrer and communicate on the battlefield in unprecedented ways. But drones are not just one technology - they are bottom-up innovations produced by a strong industrial system. Unfortunately, PM Modi has failed to grasp this. While he delivers 'teleprompter' speeches on AI, our competitors are mastering new technologies," Gandhi posted on X, accompanying a nine-minute video. The Bharatiya Janata Party (BJP) is yet to

#### Cops find Ranveer Allahbadia's Mumbai flat locked, summon him again

Mumbai, Feb. 15: Mumbai Police have asked podcaster Ranveer Allahbadia to appear before them on Saturday as part of a probe into his controversial remarks on a YouTube show, as he did not turn up during the day. Teams of Mumbai and Assam police on Friday visited his residence here but found the flat locked, an official said. Crass remarks by Allahbadia, popular on YouTube for his 'BeerBiceps' channel, about parents and sex on comedian Samay Raina's now-deleted YouTube show 'India's Got Latent' have sparked massive outrage, leading to complaints from several persons. "The Mumbai police, who have initiated an inquiry in connection with Ranveer Allahbadia's controversial remarks, on Friday



locked," an official said. Allahbadia had been asked to remain present at the Khar police station here on Thursday in connection with the probe into his controversial comments. But after he failed to appear, the police issued a second summons, asking him to appear on Friday, he said. The podcaster had requested the Khar police that his statement be recorded at his residence, but his request was turned down, he added. Meanwhile, an Assam police team also wants to question Allahbadia in a case registered in Guwahati on a complaint by a resident there for alleged promotion of obscenity in a publicly accessible online show, he said. "Accordingly, teams of the Mumbai and Assam police went to Allahbadia's flat in Versova but found it locked. Both the police teams then returned to Khar police station," the police official said. The case in Guwahati was registered on Monday. Besides Allahbadia and Raina, others named in the case in Assam are Ashish Chanchlani, Jaspreet Singh and Apoorva Makhija. The Assam police team on Thursday met the Maharashtra Cyber Department officials. The Mumbai police and the cyber department, who are conducting separate probes into the remarks, have also asked Raina to appear before them in the next five days. The Mumbai police (Khar police station) have recorded the statements of eight persons, including Makhija, Chanchalani and Allahbadia's manager, on a complaint filed by a BJP functionary. However, the city police have not registered any FIR in this connection so far. On Friday, police recorded the statement of Pratham Sagar, video editor of 'India's Got Latent' show.

#### Congress alleges 'systemic failure' in education sector

Patna, Feb 15: Congress leader Kanhaiya Kumar said just as the system is responsible for farmer suicides, it is also responsible for student suicides The Congress on Saturday questioned the government over students' suicide cases and closure of coaching institutes, and alleged a "systemic failure" in the education sector in the country. #### Woman raped, murdered near Hassan Railway junction

HASSAN. The body of an unidentified 40year-old woman was found at an underconstruction tower wagon shed building, attached to Hassan Railway Junction on Thursday evening.

The railway police said the miscreant had smashed her head with bricks, after allegedly raping her in one of the rooms. The police have not yet identified the victim. The police have shifted the body to the mortuary at Hassan Institute of Medical Sciences (HIMS), and are making efforts to identify her. A source said the victim might have migrated from a neighbouring state and was working as a construction worker in the same building site. Fingerprint experts and the sniffer dog squad have arrived on the scene to gather clues.

Site engineer of the yard re-modelling railway stations Pavan CM, in his complaint, said he came to know of the incident through Kumar, a labourer. The railway police registered a murder case and are investigating.

HEADLESS BODY OF SENIOR CITIZEN FOUND IN CHINTAMANI

CHINTAMANI. The headless body of a senior citizen was found near Yagnyavalka temple in Chintamani, Chikballapur district on Thursday. The deceased is Muniyappa (65), a resident of Gowdanathatha Gadda village in Srinivasapura taluk. He worked as a mason in Chintamani. The incident came to light when a pack of stray dogs were found near the body, and were dragging the head.

The villagers noticed it and immediately alerted the police. SP Kushal Chowksey said the police are probing the case in all angles. Preliminary investigation revealed that Muniyappa was facing health issues. However, a technical team has been assigned in the case. A source said the deceased had two wives.

#### **Power cut: Doctors suture wound** using phone torch in Karnataka's Ballari

BALLARI. Close on the heels of five maternal deaths at BIMS, which sent shockwaves across the state, the government's Super Speciality Trauma Centre in Ballari is in the news for the wrong reasons. The emergency ward witnessed a sudden power cut for about 15 minutes and the doctors attending on a patient who had met with an accident had to use mobile phone torchlight to stich up a wound which the patient had suffered, on Thursday evening, creating a panic situation at the hospital. Lack of maintenance and shortage of staff is being blamed by the public, who are demanding strict action against the authorities. The hospital was jointly started by the Union and state governments two years ago and from day one, there are many complaints against it. A relative of the patient whose wound was stitched up said the former was rushed to the hospital after ne met with an accident.

'Around 7 pm, there was a sudden power cut in the emergency ward. No one seemed to be bothered about the power interruption. When the doctors were approached, they came and stitched up the wound with the help of a smartphone torchlight," he said.

'The power supply was interrupted for about 15-20 minutes, and we could see some patients on ventilators struggling to breathe. This shows how staff of government hospitals work everyday. We urge the state and Central governments to take necessary action against such negligence by the staff," he demaded, adding, "The government spends lakhs of rupees on the doctors' salaries, but some of them fail to provide

#### Seven-year-old schoolgirl dies as iron gate collapses on her at Nanganallur



CHENNAI. In a tragic accident, a seven-yearold girl died after the iron gate of her apartment complex broke from its fixtures and fell on her at Nanganallur on Thursday afternoon.

The Palavanthangal police said S Aishwarya of MMTC Colony in Nanganallur was a Class 2 student at a private school in Nanganallur. Her father owns a supermarket in the locality. On Thursday evening, Aishwarya returned home from school on her father's bike. She opened the gate and her father first went inside. Before Aishwarya could close the gate, it collapsed on her injuring her grievously. Passers-by rushed to her help and lifted the gate.

Aishwarya was rushed to a hospital where doctors declared her brought dead. Police sent the body for postmortem. Sources said police have not registered a case of death due to negligence as Aishwarya's parents did not lodge a complaint against anybody.

# How Chennai's IT corridor becoming an urban development disaster

**Chennai.** Chennai's IT corridor, located along the Old Mahabalipuram Road (OMR), is facing a severe infrastructure crisis due to rapid urbanisation outpacing the development of basic amenities. Despite substantial investments in infrastructure and taxes, a joint inspection of 2,513 buildings by the Greater Chennai Corporation (GCC),

Metro Water, and Chennai Metropolitan Development Authority (CMDA) has exposed serious shortcomings that could lead the area toward an urban disaster. Adding to the problem are buildings flouting government

According to a report in Times Of India on Friday, key issues include inadequate water and sewage connections, poor road infrastructure, ineffective storm water drainage, and mismanagement of solid waste. "Beyond SRP Tools, there is no water or sewage connection. With more than 90 new residential and commercial projects in the

pipeline, we're heading toward a perfect storm of infrastructure deficiencies," said a developer. In 2024, Chief Secretary N. Murugananadam ordered an inspection after OMR experienced severe flooding even during minimal rainfall. The inspection, conducted in December across zones 13, 14, and 15, identified a major issue:

the absence of rainwater harvesting (RWH)

systems. Only 35% of buildings had proper RWH systems in place, while 56% were poorly maintained. "Many high-rises follow the Urban planning experts warn that this lack of norms; the defaulters are mid-rise buildings," said a CMDA official. Although CMDA guidelines mandate RWH systems and tie them to completion certificates, lax enforcement has



resulted in water stagnation and flooding during heavy rains, reported.

The sewage system is also underdeveloped. "Many high-rises follow the norms; the defaulters are mid-rise buildings," the CMDA official reiterated. Poor enforcement and a disconnect between development approvals situation, contributing to waterlogging and drainage issues during the monsoon.

coordination is creating an environmental disaster. "The absence of a cohesive plan to address these issues is undermining efforts to resolve OMR's infrastructure challenges," said

an urban planner. The lack of enforcement and poor coordination between authorities remains a significant concern. "Though joint inspections are conducted, there seems to be no unified approach to solve the problems," the planner added.

Ram Shankar, coordinator of the Save Water and Recharge Aquifers Network (SWARAN), emphasised that builders need to implement RWH systems independently, and residents must demand these structures be put in place to ensure easier enforcement.

Meanwhile, a senior official stated that show-cause notices would be issued to buildings flouting norms, and a Metro Water official

confirmed that an underground sewage system would be implemented across OMR by the end of 2026. "Projects in areas like Okkiyam Thoraipakkam, Kottivakkam, Palavakkam, Neelangarai, Uthandi, and Semmenchery will be completed by 2026, while services are being provided for the rest of the area," the official

## Secunderabad railway station redevelopment underway, 40% work complete

HYDERABAD. Railway authorities have commenced the demolition work on the Secunderabad railway station's main building, with the terminal's right end, including the RPF office, largely reduced to rubble by Friday.

An SCR official told TNIE: "The work is being done in phases to avoid passenger inconvenience. The existing structure had several structural issues, making redevelopment necessary." The project, costing around `720 crore, aims to modernise the station with a ground-plus-threefloor building.

Built in 1874 during the Nizam era, the 151-year-



old building once served as the principal terminal of Nizam's Guaranteed State Railway (NGSR). Following the Nizam Railways'

merger with Indian Railways in 1951, a major renovation was completed in 1952. While platform one remains operational, some trains will shift to the Cherlapalli terminal next month.

Earlier, a 100-metre section near the Ganesh Temple was demolished for a multi-level parking complex, now under construction. A temporary booking office has been set up, and a new RPF building is complete.

On the south side, 90% of basement construction is done. The ground floor will serve as a drop-off zone, while basement levels will provide parking for 200 vehicles. "Nearly 40% of the total redevelopment work is complete,

with the project slated for completion by November this year," said the official.

#### ED attaches assets worth rs 6.47 crore in Go Rural India money laundering case

HYDERABAD. The Hyderabad Zonal Office of the Directorate of Enforcement has provisionally attached immovable properties worth '6.47 crore under the Prevention of Money Laundering Act (PMLA), 2002. This action is part of an investigation into the alleged misappropriation of funds by a company named Go Rural India. The probe was initiated based on two FIRs filed under the IPC, 1860, against Go Rural India Pvt Ltd (GRIPL) and its promoters. The complaints were lodged by the Secunderabad and Hyderabad divisions of the TSRTC (now TGSRTC) for non-payment of dues amounting to Rs 21.72 crore. These dues were accrued from the display of advertisements on the buses.

Go Rural India had entered into a contract with TSRTC to display advertisements on its buses. As per the agreement, the company was required to pay the contractual amount specified in the agreement. However, after securing the contract, Go Rural India conducted its advertising business not only through the designated entity but also through other companies, including GRIPL, Poster Town India Pvt. Ltd., Go Transit Media Pvt. Ltd., and Lime Lite Advertising Pvt. Ltd. These companies, managed and controlled by the accused, were not authorised to carry out the advertisement display business. The ED investigation further uncovered that the accused collected significant sums from clients into their bank accounts, violating the terms of the contract. Instead of remitting the dues to TSRTC, they diverted the advertisement revenue for personal gains. The funds were allegedly used for purposes such as repaying loans, purchasing jewellery, vehicles, immovable properties, and covering other personal expenses. This diversion of funds resulted in a default of `21.72 crore to TSRTC.

Now the lake has shrunk to almost nothing and this order could be crucial for the protection of what is left of the lake," Gopan said.

Vellayani lake has a wetland spanning over 268.68 hectares. It is learnt that the lake is included in a list of 40 wetlands in the state that are in the

process of being notified under the Wetlands (Conservation and Management) Rules, 2017. The area of the lake has shrunk dramatically with widespread encroachment affecting the ecosystem adversely.

The first phase of the Vellayani lake conservation project, granted administrative sanction back in 2021, had taken off recently. "The protection

and conservation of the lake is crucial. Because of silt accumulation, we are unable to ensure a continuous supply of water to the panchayat areas. Water is supplied only twice a week.

Once we remove the silt and clean up the reservoir, the storage capacity will go up and we will be able to supply water every day," Kalliyoor panchayat president M Somasekharan Nair said.

### KCBT metro link with elevated road to cost Rs 5,000 crore more

CHENNAI. In a significant move to enhance connectivity, Chennai Metro Rail Limited (CMRL) has submitted a revised Detailed Project Report (DPR) to the state government for extending the metro rail from Chennai airport to Kilambakkam bus terminus. The updated proposal, integrating the metro line with an elevated road, comes at an estimated cost of Rs 9,335 crore — Rs 5,000 crore higher than the initial projection.

CMRL managing director MA Siddique presented the DPR for the 15.46 km stretch, which will feature 13 stations, to K Gopal, additional chief secretary to the government, Special Initiatives Department.

The original DPR, submitted earlier, was revised following instructions to incorporate an elevated road along with the metro corridor. As per the new plan, the metro line will be constructed at Level-2 while the elevated road will be at Level-1, ensuring



seamless connectivity to the Kilambakkam bus terminus. Additionally, intermediate ramps near Tambaram will facilitate access to the Outer Ring Road. The elevated road will extend directly to the Kilambakkam bus stand, with provisions for a future extension to Chengalpattu. The proposed metro

extension will traverse major suburban areas, including Pallavaram, Chrompet, Tambaram, Perungalathur and Vandalur.

This alignment will significantly enhance connectivity between key transport hubs such as Kilambakkam bus terminus, Chennai International Airport and Tambaram railway station, offering commuters a more efficient transit option.

The feasibility study for the airport-Kilambakkam metro line was conducted in 2019 by Larsen & Toubro Infrastructure Engineering. However, the preparation of the DPR faced delays, with CMRL submitting the initial report in early 2022.

A major hurdle was the state highways department's plan to construct an elevated corridor up to Tambaram, which conflicted with the proposed metro route.

After extensive discussions, both agencies reached an agreement regarding the metro viaduct's level and the height of the elevated corridor. During the feasibility study, CMRL

evaluated three possible alignments.

#### 8 Independents file nomination for MCM polls

Gurgaon. With just two days remaining before the nomination process for MCG and MCM elections ends, no candidate has filed papers for the city civic body while only eight independent candidates have submitted their nominations for Manesar polls.

Till the fourth day (Friday), these nominations cover just four out of the total 20 wards in MCM, while there is no nomination for the mayoral post in MCM. Meanwhile, Bharatiya Janata Party (BJP) revised its mayoral candidates list and fielded Rajrani Malhotra, BJP Mahila Morcha state executive member, as the mayoral candidate from Gurgaon. The Congress has not yet announced its candidates. The last date for filing nominations is Feb 17 and scrutiny of nomination papers will take place on Feb 18. District election officer and deputy commissioner Ajay Kumar said that the nomination process will continue on Saturday, while Sunday will be a non-working day. According to election officials, three nominations were received for Ward 1 (Garhi Harsaru and adjoining areas), two each for Ward 11 (Manesar) and Ward 20 (Nawada Fatehpur, Badha), and one for Ward 5 (Kankrola). No nominations were filed for the remaining 16 wards. Among the independent candidates, Mohit Yadav, a 28-year-old resident of Garhi Hasaru, is contesting from Ward 1. A social worker, Yadav said, "There were many aspirants for party tickets, but I wanted to work for my people as I was doing. Some development took place after our areas came under the MCM, but much more needs to be done, especially in improving roads and sanitation." Umed Singh Yadav, 38, who filed his nomination as an independent candidate from Ward 11 (Manesar),

#### Teenager sexually harassed by uncle dies by suicide

talked about the lack of development.

Noida. A 16-year-old girl died by suicide in Sector 63 after she was allegedly sexually harassed by her uncle on Wednesday evening. Both the teen's and his families are living as neighbours, a senior police officer said, adding that the man sent his daughter to call her cousin home around 4.30pm. The teenager, after she was molested, ran to a friend's house where she revealed her ordeal to the latter and even requested poison, fearing parents wouldn't believe her if she accused her uncle of sexual harassment. Police said the girl's father works as a food delivery agent, and mother is an employee of a private company. They were away at work when the incident happened. The girl, the officer added, even told her friend that she can get money spent for poison from her mother later. Though her friend tried to calm her down, the traumatised girl returned home and hanged herself from a fan. Her mother, upon returning from work around 6.45pm, found the girl's body hanging, with the door left open. Neighbours gathered at the spot after hearing the woman screaming.

A police investigation revealed that the accused — a daily wage worker and habitual drinker — committed the crime while his wife and two other children were away. He fled home soon after the incident. Both families have been living just 20m apart for around 10 years, and often visited each other quite often. The girl's family is from Farrukhabad. The autopsy of the minor was carried out on Thursday evening, and the report confirmed that the girl ended her life by hanging.

DCP (Central Noida) Shakti Mohan Avasthy said, "The accused was arrested after a gunfight. While our team was carrying out checking near Bahlolpur underpass on Thursday night, we received a tip-off that he was standing near the green belt on FNG Expressway's service road waiting for someone. A police team rushed to the spot and cordoned off the area. Upon spotting cops, he tried to run towards the green belt. On seeing himself surrounded by the team, he fired upon them. In retaliation, the man suffered injuries in his leg. A country-made pistol along with a live cartridge was seized from him," Avasthy said.

#### Acquisition cost too steep, GDA won't acquire land from 3 villages for Harnandipuram now

Ghaziabad: GDA has decided to chip the proposed Harnandipuram township by nearly 150 hectares.

The township was proposed to come up on 521 hectares - almost the same size as Indirapuram — which would require the Authority to acquire land from 8 villages at an estimated Rs 5,000 crore. The costs were to be shared equally by GDA and UP govt under the CM Urban Expansion New City Promotion Scheme.

GDA secretary Rajesh Kumar Singh informed a sixmember panel, set up for supervising the land acquisition process under UP govt's direction, that for now, it has decided not to acquire land from three villages from it was to acquire over 150 hectares—Shahpur Morta (77.4 hectares), Bhowapur (68.9 hectares) and Morta (5.4 hectares).

financial status of the GDA is not sufficient to acquire land from all eight villages in one go," Singh said.

The official added about 127 hectares are to be acquired from farmers of Nagla Ferozepur, Mohanpur, Âtour, Champat Nagar, Shamsher, Bhenda Khurd, Mathurapur and Shapur Morta. The rest—about 242 hectares— is either with the GDA already or is gram sabha land.DM Deepak Meena told TOI that at the meeting on Thursday, they also discussed the rates at which land will be acquired for the township.

'The panel has decided that land acquisition rate will be determined on mutual consent between GDA and landowners as the process was less time consuming. In case there is no consensus, plots will be acquired under the Land Acquisition Act," he said.GDA has now been directed to start a land survey. "The development authority has some land parcels in its bank. With three villages out of the purview now, only 127 hectares need to be acquired," Meena added. The map of the new township, vetted at the GDA Board's meeting in Aug last year, showed that the township will span from Pipeline Road in the north of the city to Northern Peripheral Road in the east and Morti in the south. As per one estimate, Rs 10,000 crore will be needed to develop Harnandipuram, and nearly 50% will go into acquiring land.

# City sees warm days and chilly nights; minimum temperature increases to 13°C

#### Medical board to probe death of woman admitted to hospital with typhoid in Gurgaon

Gurgaon: A govt medical board will probe if there was negligence in treating a 22-year-old engineer who died at a private hospital in the city after being admitted there with typhoid.Deepika Singh, a BTech graduate who recently joined Tata Consultancy Services (TCS) in the city, was admitted to the emergency ward of the hospital around noon on Jan 25 with fever and low platelet count. She died early in themorning on Jan 26.Her brother Aditya Singh made three specific allegations - that Deepika was taken into the ICU and put on ventilator "unnecessarily", she was not examined by senior doctors, and the first batch of platelets she got was only at 3am on Jan 26. "Despite her platelet count being 22,000, she wasn't administered platelets till 3am wasn't administered platelets till 3am on Jan 26, which worsened her condition. She purportedly experienced internal bleeding, though no explanation was provided. When I questioned the delay in platelet administration, the hospital staff dismissed my concerns, advising me not to rely on 'Google knowledge'," Aditya said in his complaint to the

district health department. A member of the board on Friday confirmed that the complaint had been forwarded to it and it will look into allegations of medical negligence. Only if the board concludes that there are indications of negligence can complaints against doctors or hospitals be investigated by police. The board includes the district's chief medical officer, among other

Aditya told TOI that his sister was down with high-fever on Jan 22, and the family took her to a local clinic in Sector 15 for consultation. "Her CBC (complete blood count) indicated typhoid, but she was ambulatory (able to walk).

Her condition worsened on Jan 25 and on the local doctor's advice, the family took her to the hospital. The treatment (at the hospital) was inadequate. Instead, they demanded Rs 2 lakh," Aditya said. "She was ambulatory till hospitalisation.

The culpable parties should face consequences to prevent similar incidents," he said. Aditya said that after her death, viscera samples were also sent to a govt laboratory for an autopsy. The initial post-mortem report, he said, could not conclude a cause of death and a detailed report is pending. Asked about the case, the hospital said in a statement that it "deeply regrets the passing of Ms. Deepika Singh", who was admitted to the facility in a "very critical condition"."The patint was shifted to ICU and was treated under monitoring by specialist doctors. Despite the best efforts of our experienced doctors and intensive care specialists, her condition continued to deteriorate, and she sadly passed away on Jan 26, 2025. at 7.34am," the hospital said. The statement extended condolences to Deepika's family and added: "While we recognise the family's concerns, we assure that all due procedures were followed in her treatment. We remain fully cooperative with relevant authorities and have also reached out to the family to provide the necessary

information and support.

#### Hrs after withdrawing list, BJP declares 9 mayoral candidates

Gurgaon. Hours after withdrawing its list of nine mayoral candidates for civic elections in Haryana, BJP on Friday night released a final one, with just one change: the party's nominee from the city. Instead of BJP Haryana women's wing president Usha Priyadarshini, who was named in the initial list, the party announced the name of Rajrani Malhotra, state executive member of BJP's Mahila Morcha, as the MCG mayoral candidate. The remaining eight names on the list were the same. BJP is yet to announce a mayoral candidate for Municipal Corporation of Manesar (MCM), which is going to polls for the first time since the body was created in 2020.

After consulting with the national president of the Bharatiya Janata Party, Mr Jagat Prakash Nadda, the state election committee has approved the following names for the mayoral positions in the Haryana Municipal Corporation Elections-2025," the party said on the revised list. Around 2.30pm on Friday, a post by the party's official Facebook account listed mayoral candidates for Gurgaon, Faridabad, Hisar, Karnal, Sonipat, Panipat, Rohtak, Yamunanagar and Ambala corporations. The post was deleted within the next half an hour. Sources told TOI that the Gurgaon candidate was changed because the party could not reach consensus on Priyadarshini's nomination. This election, the mayor's post in the city has been reserved for a woman from backward class (A) category. TOI had earlier reported that the party leadership was not sure if Priyadarshini could contest from the reserved seat. Asked why the change was made within hours, district BJP president Kamal Yadav said: "The senior leadership of the party reached a collective agreement regarding their choice for the mayoral position in Gurgaon.

Priyadarshini aside, Sheetal Swami, daughter-ir law of senior BJP functionary Praveen Chandra, was also in the fray for a nomination from Gurgaon. Rajrani Malhotra, the party's final pick, is the wife of former district BJP chief Tilak Raj Malhotra.In 2000 — when then-Gujarat CM Narendra Modi was in charge of Haryana — BJP had fielded Tilak Raj from the Gurgaon assembly constituency. Tilak Raj lost that poll to rebel INLD candidate Gopi Chand Gehlot. Party functionaries said that Rajrani's candidature will help BJP reach out to Punjabi voters in the city.

A party's choice of mayoral candidate is of particular importance in the coming civic polls because it is the first time that voters in Gurgaon will directly elect a mayor.

The Haryana cabinet, in 2018, approved the new norm for residents to elect a mayor instead of ward councillors. The last time that MCG went to the polls was in 2017.

# Tabletop crossing demolished after Golf Course Road safety row in Gurgaon

near La Lagune on Golf Course Road has been dismantled by DLF, months after the project was approved by the district administration and partially constructed by the GMDA. #### OpenAI board unanimously rejects Elon Musk's \$97.4 billion takeover proposal

SAN FRANCISCO. OpenAI says its board of directors has unanimously rejected a \$97.4 billion takeover bid by Elon Musk

OpenAI is not for sale, and the board has unanimously rejected Mr Musk's latest attempt to disrupt his competition," said a statement Friday from Bret Taylor, chair of OpenAI's board.OpenAI attorney William Savitt, in a letter to Musk's attorney Friday, said the proposal "is not in the best interests of OAI's mission and is rejected."Musk, an early OpenAI investor, began a legal offensive against the ChatGPT maker nearly a year ago, suing for breach of contract over what he said was the betrayal of its founding aims as a nonprofit. OpenAI has increasingly sought to capitalise on the commercial success of generative AI. But the for-profit company is a subsidiary of a nonprofit entity that's bound to a mission-which Musk helped set-to safely build better-than-human AI for humanity's benefit.

OpenAI is now seeking to more fully convert itself to a for-profit company but would first have to buy out the nonprofit's assets. Throwing a wrench in those plans, Musk and his own AI startup, xAI, and a group of investment firms announced a bid Monday to buy the nonprofit that controls OpenAI. Musk, in a court filing Wednesday, further detailed the proposal to acquire the nonprofit's controlling stake.

Savitt's letter Friday said that the court filing added "new material conditions to the proposal. As a result of that filing, it is now apparent that your clients' much-publicised 'bid' is in fact not a bid at all."

In any event, "even as first presented," the board has unanimously rejected it, Savitt said.

Musk has alleged in the lawsuit that OpenAI is violating the terms of his foundational contributions to the charity. Musk had invested about \$45 million in the startup from its founding until 2018, his lawyer

He escalated the legal dispute late last year, adding new claims and defendants, including OpenAI's business partner Microsoft, and asking for a court order that would halt OpenAI's for-profit conversion.

Musk also added xAI as a plaintiff, claiming that OpenAI was also unfairly stifling business competition. A judge is still considering Musk's request but expressed scepticism about some of his claims in a court hearing last week.

Jaishankar also participated in Ananta Aspen Centre's 'Coming of Age: Evaluating Rising India's Security Challenges' session at the conference and "shared India's thinking on global engagement, regional strategy and key bilateral partnerships".

The minister also met Bavarian Prime Minister Markus Soder here and discussed cooperation in economy and technology between the two countries.

'Exchanged views about the international situation. Look forward to welcoming him to India," Jaishankar said in another post on X. Jaishankar also met Germany's Defence Minister Boris Pistorius on Friday and discussed bilateral cooperation and the Ukraine development during the meeting.

#### **Abortions To Resume In** Missouri After A Judge **Blocks Restrictions**

Kansas City. Abortions are set to resume in Missouri after a judge blocked regulations that had restricted providers even after voters approved enshrining abortion rights into the state's constitution. Friday's ruling came after a Kansas City judge ruled last year that abortions were now legal in the state but kept certain regulations on the books while a lawsuit by abortion-rights advocates played out. One regulation required abortion facilities to be licensed by the Missouri Department of Health and Senior Services. Planned Parenthood said most of its facilities could not comply with some of the licensing rules, including "medically irrelevant" size requirements for hallways, rooms and doors. Planned Parenthood argued that the licensing law required providers to give "medically unnecessary and invasive" pelvic exams to anyone receiving an abortion, including medication abortions, according to court documents. The plaintiffs also said some of the regulations on Planned Parenthood centre were so strict, "most health centre or doctors' office simply do not meet"

Jackson County Circuit Judge Jerri Zhang said in her ruling that the licensing requirement is "facially discriminatory because it does not treat services provided in abortion facilities the same as other types of similarly situated health care, including miscarriage care." Voters approved the measure adding abortion rights to the constitution in November. That amendment did not legalise abortion in the state outright but instead required judges to reconsider laws that had almost completely banned the procedure.

# Trump's reciprocal tariffs will overturn decades of trade policy

WASHINGTON. President Donald Trump is taking a blowtorch to the rules that have governed world trade for decades. The 'reciprocal" tariffs that he announced Thursday are likely to create chaos for global businesses and conflict with America's allies and adversaries alike.

Since the 1960s, tariffs — or import taxes have emerged from negotiations between dozens of countries. Trump wants to seize the process."Obviously, it disrupts the way that things have been done for a very long time," said Richard Mojica, a trade attorney at Miller & Chevalier. "Trump is throwing that out the window ... Clearly this is ripping up trade. There are going to have to be adjustments all over the place."Pointing to America's massive and persistent trade deficits – not since 1975 has the U.S. sold the rest of the world more than it's bought --Trump charges that the playing field is tilted against U.S. companies. A big reason for that, he and his advisers say, is because other countries usually tax American

exports at a higher rate than America taxes theirs. Trump has a fix: He's raising U.S. tariffs to match what other countries charge.

The president is an unabashed tariff

supporter. He used them in his first

term, and three weeks into his second he has already slapped 10% tariffs on China; effectively raised U.S. taxes on foreign steel and aluminum; and threatened, then delayed for 30 days, 25% taxes on goods from Canada and Mexico. Economists don't share Trump's enthusiasm for tariffs. They're a tax on importers that usually get passed on to consumers. But it's possible that Trump's reciprocal tariff threat could bring other countries to the table and get them to lower their own import taxes."It could be win-win," said Christine McDaniel, a former U.S. trade official now at George Mason University's Mercatus Center. "It's in other countries'

interests to reduce those tariffs."She noted

that India has already cut tariffs on items from motorcycles to luxury cars and agreed to ramp up purchases of U.S. energy. What are reciprocal tariffs and how do they work?They sound simple: The United States would raise its tariff on foreign

goods to match what other countries

impose on U.S. products." If they charge us,

we charge them," the president told reporters on Sunday. "If they're at 25, we're

Ukrainian President Volodymyr Zelensky said he sought "security guarantees" as he met with the US vice president on Friday to discuss the Trump administration's efforts to broker a truce deal with Moscow.Zelensky's sitdown with JD Vance at the Munich Security Conference comes as Kyiv scrambles to ensure it is not sidelined in Washington's push to wrap up the three-year war.President Donald Trump stunned allies and upended the status quo of US support for Ukraine this week when he announced he would likely soon meet Russian leader Vladimir Putin to start truce talks.

Speaking with reporters in Munich, Zelensky stressed the need to "speak any endgame to the war is formulated. "We want peace very much but we need real security guarantees," he said after

his first meeting with Vance. Zelensky's anxiety was also on display in peace, not the kind of peace that's

#### Global democracy in trouble: EAM Jaishankar refutes claim, says India's 'has delivered'

MUNICH. External Affairs Minister (EAM) S Jaishankar has expressed optimism over the direction of India's democracy and stressed that India's democracy has delivered. He spoke about how the elections are conducted in India and mentioned the recent elections in Delhi and parliamentary elections held in 2024. While participating in a panel discussion on the topic 'Live to Vote Another Day: Fortifying Democratic Resilience' at the Munich Security Conference alongside Norway's Prime Minister Jonas Gahr Store, US Senator Elissa Slotkin and Warsaw Mayor Rafal Trzaskowski on Friday, Jaishankar said that he differs in the view that democracy is in trouble globally and highlighted India's democracy.

When asked about his views regarding Western democracy, the EAM said, "Well, before I do that, I appeared to be an optimist in what is relatively a pessimistic panel, if not room. I will begin by sticking up my finger, and don't take it badly; it is the index finger. This, the mark you see on my nail, is a mark of a person who has just voted. We just had an election in my state. Last year, we had a national election. In Indian elections, roughly two-thirds of the eligible voters vote. At the national elections, the electorate of about 900 million, about 700 million voted. We count the votes in a single day.'

"Nobody disputes the result after it's announced, and by the way, from the time we started voting in the modern era, 20 percent more people vote today than they did decades ago," Jaishankar said."So, the first message is that somehow democracy is in trouble globally, worldwide. I am sorry; I have to differ with it. I mean, right now, we are living well. We are voting well. We are optimistic about the direction of our democracy, and for us, democracy is actually delivered," he added

Jaishankar said that India is a democratic society and

gives nutrition support to 800 million people. He noted that there are parts where democracy is working well and there could be parts where it is not. However, he underscored that it should not be considered a universal phenomenon. The external affairs minister said, "Senator, you said that democracy doesn't put food on your table. Actually, in my part of the world, it does because it actually, today, because we are a democratic society, we give nutritional support and food to 800 million people, and for whom that is a matter of how healthy they are and how full their stomachs are.""So, the point I want to make is look different parts of the world are going through different conversations. Please do not assume that this is a kind of universal phenomenon; it is not," he added.

There are parts where it is working well; maybe there are parts where it's not, and the parts which are not, I think people need to have honest conversations about why it is not, but I would argue that, to an extent, as someone dispassionately viewing it, which was your question, there are some problems; a lot of it is an accumulated problem of the model of globalisation that we have followed for the last 25-30 years.

# Anger, chaos and confusion take hold as US government workers face mass layoffs

NEW YORK. Workers across the country responded with anger and confusion Friday as they grappled with effort to shrink the size of the federal workforce by ordering agencies to lay off probationary employees who have yet to qualify for civil service protections. While much of the administration's attention was focused on disrupting bureaucracy in Washington, the broad-based effort to slash the government workforce was impacting a far wider swath of workers. As layoff notices were sent out agency by agency, federal employees from Michigan to Florida were left reeling from being told that their services were no longer needed.In a sign of how chaotic the firings have been, some who received layoff notices had already accepted the administration's deferred resignation offer, under which they were supposed to be paid until Sept. 30 if they agreed to quit, raising questions about whether others who signed the deal would nonetheless be fired.On Friday evening, the Office of Personnel

Management, which serves as a human resources department for the federal government, acknowledged that some the Trump administration's aggressive employees may have received efforts to reduce the size of the federal termination notices in error and said the workforce, which are being led by buyouts agreements would be honored."This has been slash and burn," said Nicholas Detter, who had been working in Kansas as a natural resource specialist, helping farmers reduce soil and water erosion, until he was fired by email late Thursday night. #### GHMC to launch rs 5,942 crore H-CITI project to ease Hyderabad traffic



HYDERABAD. The Greater Hyderabad Municipal Corporation (GHMC) is gearing up to launch the Hyderabad City Innovative and Transformative Infrastructure (H-CITI) programme, a major initiative aimed at reshaping the city's urban landscape.

The project will implement multiple infrastructure developments, including flyovers, underpasses, and road widening projects, to ease traffic congestion and enhance urban connectivity.

According to officials, H-CITI includes 38 projects across seven packages totalling Rs 5,942 crore. The initiative is based on a Comprehensive Traffic Study by the Hyderabad Metropolitan Development Authority (HMDA), which identified critical congestion points and traffic bottlenecks across the city.

As part of Phase-I, GHMC will invite bids in February for the construction of 10 flyovers and underpasses spanning 13.56 km and six major road-widening projects covering 6.585 km, totalling 16 works across 20.145 km at an estimated cost of Rs 2,400 crore.

#### Brain-dead teacher's organ donation gives new life to four patients in Thiruvananthapuram

THIRUVANANTHAPURAM. In a remarkable act of generosity, the family of 52-year-old R Rajesh, a teacher at Amrita HSS Paripally, donated his organs after he passed away due to a brain haemorrhage.

The selfless act gave a new lease of life to four individuals. His family made the decision to donate his organs to critically ill patients undergoing treatment in various hospitals.

Two kidneys and two corneas were donated. One kidney was allocated to the Thiruvananthapuram Government Medical College hospital, while the other was sent to KIMSHEALTH. The corneas were donated to the Regional Institute of Ophthalmology in the city.

A native of Varkala, Rajesh was admitted to a private hospital on February 8. He was declared brain dead on February 13. His wife Sangeetha and sons, Harishanth and Sivashanth, consented to the organ donation, enabling the life-saving procedure.

The donation process and the allocation of recipients were coordinated by Kerala State Organ and Tissue Transplant Organization (K-SOTTO), part of the government's organ-donation initiative. Rajesh's funeral is scheduled to take place on February 15 at his residence in Varkala.

#### Plus-I student found dead in school in Thiruvananthapuram; family alleges harassment by

THIRUVANANTHAPURAM. A Plus-I student of Government Vocational Higher Secondary School, Paruthippally was found dead in his school on Friday morning in what is being suspected as a case of suicide.

Benson Abraham, a resident of Erumakuzhy, was found dead when the school was opened on Friday morning. Benson's father Benny alleged that he was verbally abused by the office clerk of the school when he went to get his record book signed and that prompted his son to take the drastic step.

The last date for submitting the record book was Friday. After getting the signature of the teacher concerned, the boy went to the office to get the office seal. According to a friend of Benson, the clerk abused the boy when he went to the office. "Benson told us that the clerk asked him whether the seal belonged to his father," said a student, who sought anonymity. Principal Geetha Babu confirmed that Benson had told her about the incident and it was she who had asked him to bring parents to the school the next

"Whenever such incidents happen, we summon the parents," she said. The principal said she asked the clerk about the incident, but he did not reply. "He is like that. Later, by night the clerk sent me a message on WhatsApp saying he has gone on a leave," she said. The incident has snowballed and the family members of Benson and youth outfits, including DYFI, protested against the school authorities and sought action against the clerk. General Education Minister V Sivankutty has also intervened in the matter and ordered a department-level probe. The probe will be conducted by VHSE deputy director (Curriculum). The Kattakada police, meanwhile, said they will conduct an inquiry on the incident and will examine the veracity of the oral statements, which were reportedly given by the deceased to the principal and his parents. #### BBMP should frame rules on mosquito control, impose fines on violators: Karnataka HC

BENGALURU. The Bruhat Bengaluru Mahanagara Palike (BBMP) should evolve a continuous mechanism to check and control the breeding of mosquitoes which is the primary cause of dengue, the Karnataka High Court said. Any individual, residential society or hub, if found to be negligent in clearing water stored in containers, stagnant water or solid waste, which may result in the breeding of mosquitoes, should be subjected to heavy fines by framing proper rules, the court said.

A division bench of Chief Justice NV Anjaria and Justice KV Aravind made these observations in the order pronounced on a suo motu public interest



litigation taken up after publication of a letter on the rampant spread of dengue, in the 'Letters to the Editor' column in a newspaper in July

The court said the state and civic authorities should not remain complacent in discharging their duties to deliver medicare for citizens, and control the spread of the disease. Whenever any disease or pandemic

poses a threat to public health, the measures directed by court could be applied to control the disease, and ensure citizens their right to health and a clean and disease-free environment, the court said.

It also said the purpose of this suo motu PIL was to activate the authorities in the wake of the spread of dengue, minimize fatalities due to the disease and keep the disease away from the common citizen. The court also took note of measures taken by the State government and BBMP, and figures which revealed that dengue was on the decline both in its intensity and spread. The number of patients, admissions and deaths had dropped, the court said, disposing of the petition.

# Wedding crasher thief nabbed again in Bhubaneswar, Rs 10 lakh stolen ornaments recovered

Posing as guests, they went in and stole a bag consisting of ornaments and Rs 1.20 lakh cash from the venue.

BHUBANESWAR. Quietly trailing a 20-year-old youth who crashed weddings to steal valuables, Bhubaneswar police nabbed him from his hometown in Madhya Pradesh with burgled gold and diamond

ornaments worth about Rs 10 lakh.

Two days after the accused Rajesh Sisodia walked out of iail on bail, police followed him to Rajgarh district in MP and recovered all the stolen ornaments from his possession. He was brought to Bhubaneswar and remanded in judicial custody on the day.

Investigation revealed Sisodia and his two

associates had arrived here earlier in February. They visited a hotel located within Maitri Vihar police limits on February 2 when a wedding was underway. Posing as guests, they went in and stole a bag consisting of ornaments and On receiving information about Rs 1.20 lakh cash from the venue. A complaint in this regard was

lodged by the bride's father Saroj Mishra and police registered a case. However, not satisfied with the spoils, the wedding crashers went to another wedding venue at a hotel in Puri the same evening.

However, their luck ran out as locals caught hold of Sisodia though his associates managed to escape. Baliapanda police arrested the accused and he was sent to jail.

Sisodia's possible involvement in theft in Bhubaneswar, the city

police questioned him when he was lodged in Puri jail. However, the thief managed to secure bail after two days and left for his hometown in Madhya Pradesh. The city police wasted no time

and followed him to Rajgarh district where they carried out raids at his house.

'All the stolen ornaments were seized from Sisodia's house and he was arrested. Efforts are on to nab the other culprits involved in the thefts," said a police officer.

Police said the gang members used to travel to different parts of the country during wedding seasons. The

accused collected information about prominent hotels from the internet and trespassed if they noticed any wedding was underway. They would dress elegantly and target mostly the bride's family before escaping in their car after committing the theft, said the police.

## Local self-government department tops vigilance corruption cases in Ernakulam

**KOCHI.** The highest number of government officials facing probe in corruption cases belongs to the local self-government department in the district, according to the data available with the Vigilance and Anti-Corruption Bureau (VACB) since 2021.In the last four months alone, as many as four officials of Kochi corporation were arrested by the VACB for accepting bribes.

As per VACB data, as many as 44 vigilance cases have been registered against government servants in Ernakulam district since 2021. Similarly, in eight cases officials were caught red-handed while accepting bribes. As many as 11 corruption cases were registered against officials of LSG institutions. This is followed by the cooperative department with five cases, and forest and police departments with four cases each. VACB registered three cases each against officials of Kerala State

Pollution Control Board (KSPCB) and revenue department. Two cases each were registered against officials of the civil supplies, excise, PWD, and mining and geology department.

Four cases were registered against officials of LSG bodies after they were caught redhanded. One trap case each was registered against officers of PWD, KWA, revenue and central labour department.

"In the last two months alone, we arrested four officials of Kochi corporation for taking bribes. All the officers were from the health wing. There are several business firms functioning in Kochi. As part of renewing licence, these firms have to obtain clearance from health inspectors. In one case, three health officials of Kochi corporation were arrested in a trap case after they demanded Rs 50,000 as bribe from a businessman who is running an accessory shop in West Kochi," a VACB officer said. Since November 2024, VACB registered six trap cases in Ernakulam and arrested nine officers. The arrested officers belong to Kochi corporation, the central labour department, the agriculture department, KWA and the police. "A positive change is that more people are approaching us with complaints when government servants demand bribes from them. However, there is still a long way to go. We can nail officials who demand and accept bribes if people give us proper information. Even now, several people without hesitation give bribes to get various services from government offices,' he said. Across Kerala, 393 cases were registered by VACB against government officials since 2021. Similarly, 146 trap cases were registered during the same time period. The highest number of vigilance cases was registered in Thiruvananthapuram

district (72) followed by Kozhikode (56), Ernakulam (44) and Thrissur (36).

However, VACB does not encourage anonymous complaints as a majority of them turn out to be bogus during further inquiry. As per recent data, 81% of anonymous complaints received by VACB officers turned out to be bogus in Ernakulam district since 2016. As many as 673 anonymous complaints were received by VACB units in Ernakulam via mail and online since 2016. However, only 132 anonymous complaints were found worth proceeding with the investigation and the rest were found to be fake. "Most of the anonymous complaints are filed out of personal grudge against government officials. In some cases, complaints are filed against honest officials who take action against illegal activities. Some file anonymous complaints due to family feuds," an officer said.

#### SAD's control over SGPC and fate of jathedars

THE Shiromani Akali Dal established itself in the political dynamics of Punjab after spearheading the Gurdwara Reform Movement in the early 20th century. With this powerful movement, the SAD built a strong cadre base, one that could be mobilised for Sikhs' religious issues. During the period of Constituent Assembly debates from 1946 to 1949, issues concerning the Sikh community were raised by some leaders, particularly Hukam Singh, and fiercely debated. The SAD never abandoned the movement mode since it was playing pressure politics as also keeping the support base intact.In electoral politics, the SAD gained significance only in 1962, when it became the official opposition party. After the formation of the Punjabi Suba in 1966, the SAD headed the coalition government and Gurnam Singh became the Chief Minister in 1967. The intra-party dynamics of the SAD can be traced to this year. Understanding the internal politics of the SAD at present requires two sets of forces which work in two distinct situations -- when SAD is in power and when it is out of power. In both situations, there is a struggle for power among top leaders. The 1967-72 period was the beginning of what became the signature image of the SAD. During this time, there were three chief ministers. First, Lachhman Singh Gill toppled Gurnam Singh and then, Parkash Singh Badal replaced Gurnam Singh. A similar process was seen in 1986 when Surjit Singh Barnala was reduced to minority as some MLAs rebelled, led by Parkash Singh Badal. It was in 1997 that Parkash Singh emerged as the undisputed leader of the SAD and remained so till his death in 2023.

The SAD has had such strong leaders as Master Tara Singh, Sant Fateh Singh and Harchand Singh Longowal, who influenced and shaped the Akali politics. Except for Master Tara Singh, who was discredited for ending his fast unto death without getting the Sikhs' demands accepted by the Government of India, the others remained at the citadel for long periods of time.Parkash Singh Badal faced challenges from strong leaders like Gurcharan Singh Tohra and Jagdev Singh Talwandi. The SAD had realised quite early that to remain in power, resources were needed and for this, the SGPC was the most important source. Over time, the SGPC came under the control of the SAD. Thus, with Tohra, who remained the SGPC president for a record 27 years, there emerged two centres of power, both competing and cooperating with each other. Since 1997, Parkash Singh began to control the entire machine. With politics dominating the SGPC, the position of takht jathedars also came under the influence of the SAD. The recent removal of the Jathedar of Takht Damdama Sahib, Giani Harpreet Singh, is not unprecedented. The major reason for such ousters is SAD's domination. The appointments of takht jathedar are done keeping political pragmatism and interests in mind. The control over religious institutions through the SGPC is the major source of political power to the SAD and is done in such a way that both reinforce each other.

Giani Harpreet Singh's removal is crucial in light of the crisis faced by the SAD, which has politically shrunk. To rejuvenate itself, the SAD recently approached the SGPC and conceded that its party leaders had committed mistakes in the past. The Five Singh Sahiban pronounced punishment to the Akali leaders for their mistakes and they accepted it. The title of Panth Rattan Fakhr-e-Qaum that was awarded to Parkash Singh Badal in 2011 was taken back as punishment. It was a danger signal for the Akalis.By getting Giani Harpreet Singh removed through the SGPC, the Sukhbir Badal-led SAD has tried to manage the crisis created by the Five Singh Sahiban's verdict.It is believed that the current crisis that the SAD is facing is mainly due to certain incidents of sacrilege that occurred in Punjab. They include the Bargari incident and the Behbal Kalan police firing which led to the death of two Sikh protesters in 2015. When it became clear that the sacrileges were committed by some Dera Sacha Sauda followers, its head Gurmeet Ram Rahim Singh came under fire.

### Post-Pulwama lessons for India, Pak

India's demographic dividend is a fleeting opportunity that must be used in time. A few states have attempted a skill census, but the scale and complexity of a national one demand a concerted effort

SIX years ago, on February 14, 2019, a CRPF convoy was attacked by a vehicle-borne suicide bomber in Pulwama, Jammu and Kashmir, resulting in the tragic loss of 40 personnel. Pakistan-based terrorist organisation Jaish-e-Mohammed (JeM) claimed responsibility for the attack. It released a video of the assailant, Adil Ahmad Dar, who had joined the outfit one year earlier.Indian strategic planners viewed the suicide bombing as an unacceptable provocation that demanded a strong response. In the early hours of February 26, 2019, a formation of Indian Air Force (IAF) Mirage 2000 aircraft crossed into Pakistani airspace and struck a JeM camp at Balakot, located in Khyber Pakhtunkhwa province. This was a striking departure from previous engagement patterns, where operations remained confined mainly to areas along the Line of Control (LoC). The next day, Pakistani fighter jets launched a retaliatory strike in the Jammu sector. In the ensuing aerial engagements, India claimed to have downed an F-16 fighter, while an Indian MiG-21 was shot down, and its pilot, Wg Cdr Abhinandan Varthaman, was captured by Pakistani forces.

The capture of a serving IAF officer raised the stakes, and there was a brief period of heightened tensions, with reports that India was readying for a missile launch into Pakistan. The situation eased when Pakistan announced that it was releasing Abhinandan as a 'peace gesture'. Ajay Bisaria, who served as Indian High Commissioner to Islamabad during that time, writes in his book that the release of the pilot was due to India's "coercive diplomacy, backed by a credible resolve to escalate the

Both India and Pakistan claimed victory in the Balakot affair. India had shown that it would not demonstrate passiveness in response to major terror strikes on Indian Pakistan, on the other hand, states that it has a 'Quid Pro soil by Pakistan-sponsored terrorists. Pakistan's nuclear blackmail had run its course, and India would use the military instrument to impose costs on Rawalpindi.Pakistan's retaliatory strike, named Operation Swift Retort, was also celebrated as a victory. On the first anniversary of the operation, the Director General of Pakistan's Inter-Services Public Relations tweeted: "February 27 commemorates the resolve of Pakistan Armed Forces against any aggression. The way we responded on this day is a proof that any misadventure by enemies of Pakistan will always be defeated."

As both sides made victorious declarations, there was no incentive to escalate, and the crisis rapidly subsided. However, even in this brief episode of hostilities, there are some important lessons for future crises. How adversaries view the results of their actions will determine how they behave in the future. The Indian political leadership is determined that it must use its conventional military superiority to deter Pakistan from using terrorism as an instrument of state policy. This now



includes the use of airpower, which was considered highly escalatory earlier.

In 2020, then IAF Chief, Air Chief Marshal RKS Bhaduria, declared, "Balakot was a clear demonstration that there exists a space within the sub-conventional conflict boundary wherein the Air Force can be used for targeting and yet have escalation control." Using precision, standoff weapons, the employment of airpower carries lesser risks than physically sending soldiers across the strongly held LoC, as was done in 2016.

Quo Plus' strategy, implying that it would retaliate against India's limited military action with a response that is slightly more potent or escalatory while remaining below the threshold that could spark an all-out conflict. If this strategy is to be credible, Pakistan must be prepared to employ its military forces to mount quick, targeted operations. While India discounts Pakistan's nuclear bluff, the latter puts it on a higher pedestal. Speaking at an IISS-CISS Workshop in London on February 6, 2020, Lt Gen Khalid Kidwai (retd) stated that the Balakot crisis "amply demonstrated" that "Pakistan's nuclear weapons continue to serve the purpose for which they were developed... It is precisely the presence of these nuclear weapons that deters, and in this specific case, deterred India from expanding operations beyond a single unsuccessful airstrike.'

These perceptions on both sides of how Balakot played out mean that there is likely to be lesser restraint on using military force in the event of a crisis between the two countries. With diplomatic channels being almost absent,

there is a risk of misunderstandings or misinterpretations that can lead to unintended escalation. International mediation can help in a crisis, but India rejects any thirdparty role in responding to national security threats.

The problem is also exacerbated due to the public rhetoric surrounding events like the Balakot strikes. With a strongman image at stake, social media-driven mass sentiment could put pressure on political leaders to take swift, decisive military action. As Henry Kissinger points out in his book, World Order, "The temptation to cater to the demands of the digitally reflected multitude may override the judgment required to chart a complex course in harmony with long-term purpose. The distinction between information, knowledge and wisdom is weakened."Does this throw up scenarios of an India-Pakistan crisis quickly ascending the escalation ladder, bringing nuclear weapons into play? While some Western observers feel that this is a possibility, the reality is different. The scope for the use of military force by India in response to terrorist attacks has indeed widened, but there is also a very deliberate effort by both sides to control the escalation through public messaging.

ollowing the Balakot airstrikes, the Indian Foreign Secretary issued a statement calling it a "non-military pre-emptive action" with the target selection being "conditioned by our desire to avoid civilian casualties." The Pakistan Foreign Office statement after their retaliation said the strikes were on "non-military targets, avoiding human loss and collateral damage... We have no intention of escalation but are fully prepared to do so if forced into that paradigm."

#### Justice delayed

#### SC calls out lax prosecution in 1984 riot cases

OVER four decades have passed, but for the victims of the 1984 anti-Sikh riots, time has not dulled the wounds of injustice. The Supreme Court's remarks on Monday questioning the Delhi police's laxity in prosecuting cases — especially their failure to challenge acquittals — highlight a troubling reality: justice for the victims remains elusive. Out of the 650 registered cases, charge-sheets were filed in only 362 cases, and convictions secured in a mere 39. The rest - more than 300 - resulted in acquittals, many unchallenged by the prosecution. The apex court's observation that "prosecution must be carried out seriously, not just for the sake of it" underscores a decades-long pattern of neglect. When the Justice Dhingra Committee – which was set up following a PIL filed by former Shiromani Gurdwara Parbandhak Committee member Gurlad Singh Kahlon - found in 2020 that several investigations had been derailed, there was a flicker of hope for accountability. Yet, even now, the appeals against acquittals seem more perfunctory than purposeful.



For survivors, the trauma is not just about the horror they

witnessed but also the systemic betrayal that followed. Statements given in court paint a grim picture - families torn apart, homes burned and a justice system that remains indifferent. The Supreme Court's intervention offers a chance to correct past wrongs, but will it amount to real action? The Delhi police's excuse of "lack of evidence" after nearly four decades is an indictment of their own inefficiency, if not

Justice cannot be an afterthought or a delayed formality. The court's scrutiny must translate into concrete steps proper legal representation, fresh investigations where needed, and, above all, an unwavering commitment to ensuring that the guilty do not walk free. Until then, the victims of 1984 will continue to wait for a closure that seems forever out of reach.

### Trump-Modi bond faces trade test in second term

Trump's 'America First' trade agenda — which clashes with Modi's 'Make in India' initiative — threatens to undermine India's status as the world's 'back office'.

The last time Donald Trump was president, ties between the United States and India flourished. But the bilateral relationship began to fray during Joe Biden's presidency, owing not least to divisions over the Ukraine war. Will Indian Prime Minister Narendra Modi's latest meeting with Trump at the White House mark the first step toward restoring this critical relationship?Trump has made no secret of his conviction that personal bonds between leaders can underpin stronger bilateral relationships. And he and Modi certainly share an affinity: both are nationalist politicians who love little more than to please a roaring crowd with elaborate theatrics. In September 2019, the two came together for a public rally in Houston, attended by 50,000 Indian-Americans and several US legislators. The following February, Trump addressed more than 1,00,000 people in Ahmedabad. "America loves India," he declared. "America respects India, and America will always be faithful and loyal friends [sic] to the Indian people."

The US-India relations took a turn for the worse after Russia's full-scale invasion of Ukraine in 2022. The Biden administration mobilised America's allies and partners to join its campaign to punish Russia - and. ideally, compel it to change its behaviour. But far from joining this effort, India stayed neutral and seized the opportunity to secure cheap Russian oil. There were other points of contention, as well. The Biden administration sought to weaken Myanmar's military junta by imposing stringent sanctions on the country and sending "non-lethal aid" to rebel groups - a policy that has contributed to instability in India's border state of Manipur. Biden also coddled Pakistan's military-backed regime, including by approving a \$450-million deal in 2022 to upgrade the country's fleet of F-16 fighter jets.

Similarly, Biden welcomed the interim government that Bangladesh's military installed following the overthrow

of the country's India-friendly government last August. Bangladesh's rapid descent into lawlessness and Islamist violence since then has raised serious security risks for India, which is already home to millions of illegally settled Bangladeshis. America's approach to Sikh separatist leaders on its soil has also raised India's hackles. Under the Biden administration, the US carried out a criminal investigation into India's alleged involvement in supposed assassination plots against Sikh militants in the US and Canada.

Last September, just days before Biden met with Modi in Delaware, senior White House and US intelligence officials met with Sikh separatists to assure them that they would be protected from "transnational repression". The following month, the US charged a former Indian intelligence officer in an alleged failed plot to kill a New York-based Sikh militant, who is on India's most-wanted list.

Against this backdrop, it is easy to see why Trump's victory in last November's presidential election raised hopes in India for a reset in bilateral relations. It helps that Trump has repeatedly pledged to negotiate a quick conclusion to the Ukraine war, meaning that India's choice not to pick a side in that conflict would no longer matter.A few weeks into Trump's second presidency, however, there are reasons to doubt this rosy scenario. So far, Trump has done nothing to spare India from his frenetic push to implement his campaign promises, from raising tariffs to deporting undocumented immigrants. When the Trump administration sent more than 100 Indian nationals back to India on a military aircraft - a 40-hour

nothing. In fact, far from standing up to Trump, Modi has preemptively slashed tariffs on US imports, hoping that this

would keep India out of the "Tariff Man's" sights. But a dissatisfied Trump, who has called India a "very big abuser" of tariffs, has not spared India from his steel and aluminium levies. He wants India to wipe out its \$35billion bilateral trade surplus by buying more oil and petroleum products, and more weapons, from the US. India is the world's third-largest primary energy

consumer, after China and the US, and the largest source of oil demand growth. That makes the country a highly



attractive market for a US administration that is committed to increasing domestic oil and gas production. It also means that Trump's commitment to pushing down oil prices, including by applying pressure on OPEC leader Saudi Arabia, would benefit India's economy.But Trump has never been particularly concerned about ensuring that his trade agreements are mutually beneficial. Regarding India, his plan may well be to use the threat of tariffs to compel Modi's government to accept the trade deal of his choosing. That is what he did to Japan during his first presidency. He also tried to do it to India, but failed, so he stripped India of its special trade status instead, prompting India to impose retaliatory tariffs on some US products. If Trump ends up slapping more tariffs, the Indian economy could slow down, at least marginally. More broadly, Trump's

> "America First" trade agenda clashes with Modi's "Make in India" initiative - threatens to undermine India's status as the world's "back office", providing extensive IT and business services to US companies. Where trade is concerned, Trump treats friends and foes alike. But it matters that India is a friend and Trump should want to keep it that way. The US-India strategic partnership helps advance the two countries' shared interests in the Indo-Pacific region, the world's emerging economic and geopolitical hub, including strengthening maritime security and supporting a stable balance of power. Already, the two countries are working to deepen military interoperability, and the US has overtaken Russia as India's leading weapons supplier, new contracts show.

As Trump and Modi build on their rapport, both should recognise that India is America's most important partner in countering China's hegemonic ambitions. It is thus in shared interest to restore and deepen bilateral ties, including by strengthening collaboration on critical and emerging technologies, from AI to biotechnology. Warm personal relations are an added bonus.



# 48 hours in Varanasi

One of the oldest living cities in the world, Varanasi is situated on the western banks of the Ganga and extends beyond the riverbank into a labyrinth of alleys. Filled to the brim with temples and teeming with pilgrims, the city is a magnet for travel enthusiasts. From witnessing vibrant evening prayers at Varanasi's oldest ghat to touring one of the most significant Hindu temples in India—here is a guide to making the most of your two-day trip



#### Breakfast at Kachauri Gali

Dotted with weathered, blackened cauldrons bubbling with hot oil, Varanasi's Kachauri Gali is one of the city's main landmarks near the ghats. The Vishwanath Gali transforms into the Kachauri Gali as soon as you pass the famous Vishwanath temple. This is where the famous kachauris are fried and served fresh with chana and imli chutney. Arrive as early as 7 AM to beat the rush and dig into the hot fried kachauris. Make sure you are not too late, as the street falls into a lull soon after breakfast.

#### Visit Prayag Ghat

Overflowing with devotees that come to offer their prayers day and night, the Prayag Ghat is another significant ghat in Varanasi. Located on the immediate left of the Dashashwamedh Ghat, it was built by Balaji Bajirao in 1778 and is a replica of the Prayag holy city in Allahabad. Fortune tellers, seated under rattan umbrellas, read fortunes for the visiting pilgrims.

One of the most unique aspects of the city of

Varanasi is that the cremation grounds at Manikarnika Ghat are located in the city itself and in the vicinity of some of Varanasi's most sacred temples. Piles of firewood line the shore and the fires continually burn as a stream of dead bodies, each wrapped in cloth, is carried through the lanes on makeshift stretchers. It was said that Lord Shiva gave Lord Vishnu a boon, that whoever dies in Kashi would be liberated from the endless cycle of birth and death and his soul would be set free.

#### Head to Assi Ghat

Situated at the confluence of Ganga and Asi rivers, Assi Ghat is the southernmost Ghat in Varanasi, where pilgrims bathe before paying

their homage to Lord Shiva in the form of a huge lingam situated under a peepal tree. To most visitors to Varanasi, it's known for being a place where long-term foreign students, researchers and tourists live. It was at Assi Ghat where the famous Indian poet, Tulsi Das had written the much-celebrated Ramcharitmanas and the ghat can accommodate about 22,000 people at once during festivals like Shivratri. In the evenings, around 7 pm, a full-fledged aarti takes place here and many visitors prefer watching it from the



boats that can be hailed from the ghat.

flowers and calligraphy using precious gems like agate and jasper, and the main archways are carved with passages from the Holy Qur'an.

### Take a guided tour of Agra

Aside from the Taj Mahal, Agra has one of the finest Mughal forts in India, the Agra Fort. A massive red sandstone structure located on the banks of the Yamuna River, construction on the fort was started in 1565 by the Mughal Emperor Akbar, and further additions in white marble were subsequently made up till the reign of his grandson Shah Jahan. Originally built for military purposes, it was later used as a palace, and eventually even served as a prison where Shah Jahan was confined for 8 years by his son Aurangzeb, who seized power in 1658. The fort runs along a length of 2.5 kilometres within enclosed walls, it encompasses several exquisite

palaces such as the Shah Jahani Mahal, Jahangiri Mahal, Khas Mahal, audience halls named Diwan-i-Am and the Diwan-i-Khas, a Fish Pavilion, the Nagina Masjid, Garden of Grapes and the Pearl Mosque. A world heritage site, it is a testament to architecture which deserves a visit.

#### Drive out to Fatehpur Sikri

Fatchpur Sikri is a town located about 40 kilometres from Agra, and has been given the status of a World Heritage site by UNESCO. Founded in 1569 by the Mughal emperor Akbar, this was the Mughal capital from 1571 to 1585, during which the empire reached its pinnacle of success. The site was chosen to honour the Sufi saint Salim Chishti and the city within was built to honour the birth of his child, Salim.

The construction of this walled city took almost 15 years to complete, and the complex included several royal palaces, a harem, courts and a mosque. The buildings have been made from red sandstone and have been designed in


Mughal style of architecture and the most important construction inside the fort is the famous 'Durbar hall' which is a hall dedicated to the public audience.

#### Lunch at Shree Café





New Delhi. Maharashtra Chief Minister Devendra Fadnavis on Friday said the state government is prepared to lodge the 26/11 Mumbai terror attacks accused Tahawwur Hussain Rana in jail once he is extradited from the United States.

The chief minister's comments came after

US President Donald Trump announced that his administration has approved the extradition of "very evil" Rana, wanted by Indian probe agencies for his role in the 26/11 Mumbai terror attacks, "to face He was lodged in jails in Maharashtra justice in India"."We kept Kasab, what is the big deal here? We will keep him for sure," Fadnavis said here when asked about Maharashtra's preparedness once Rana is extradited. The CM, who also handles the home portfolio, emphasised Mumbai's security infrastructure was capable of handling high-profile criminals."The case is in Mumbai so he (Rana) will be brought to Mumbai. We handled Ajmal Kasab. We had got Rana's

online statement due to which Pakistan's involvement was proved (in 26/11). He was in American protection at that time. Rana was India's criminal and should face the law here. We will get final justice in the 26/11 case," the CM asserted.Ajmal Kasab, one of the 10 terrorists involved in the November 26, 2008, Mumbai terror attacks, was arrested from one of the carnage sites in Mumbai.

during his trial for four years and hanged in Pune's Yerwada central jail in 2012. Fadnavis said during the investigation, Pakistan's role in the terror attack was exposed and established.

He thanked Prime Minister Narendra Modi for his efforts to bring Rana to India for trial."I want to profusely thank Prime Minister Narendra Modi for his (Rana) extradition. We all wanted that the person who conspired against us, the mastermind



of the Mumbai terror attack, to be handed over to India," he said.

The chief minister said initially America was reluctant to hand over Rana to India and wanted to protect him but due to the initiative of the Prime Minister, extradition of the key 26/11 accused has been in a way cleared by America and its President Trump."I believe this is very significant for India. Because it is very important that the criminals should get

punishment through our judicial and legal

process," he said.Fadnavis noted the Trump administration's approval to extradite Rana was an "important development" to ensure "final justice" in the case. Those who conspired against India must face the country's legal system, he maintained.Rana, a Canadian national of Pakistani origin, is currently lodged at a metropolitan detention centre in Los Angeles. He is known to be associated with Pakistani-American terrorist David Coleman Headley, one of the key conspirators of the 26/11 attacks. Speaking at a joint press meet along with Prime Minister Modi in Washington on Thursday, President Trump said, "Today I am pleased to announce that my administration has approved the extradition of one of the plotters and very evil people of the world, and having to do with the horrific Mumbai terrorist attacks, to face justice in India. # **Ambedkar University Campus**

This is not your usual university campus

with a main building surrounded by graffiti-ridden walls and some academic blocks. The single-storeyed sprawling building that serves the Ambedkar University today is steeped in history and has been witness to all its turmoil. It's ageold trees have an impressive canopy of their own and can boast of many a historical figures taking sanctuary under their branches. Built in the 1900s, the building was initially the IG Block in British rules India. As the British were looking to develop more structures of governance, before the Parliament was built, Civil Lines, beginning from Kashmere Gate right up till Majnu Ka Tila, was going to be the scene of action.

As a result, since the time of the British and after that, this campus has housed many educational institutions including the Kashmere Gate Polytechnic, the Woodcraft Institute and the Delhi College of Engineering, the latter has now moved to Bawana.

#### William Fraser's Bungalow Referred to as a 'white mughal' by noted

author William Dalrymple, William Fraser

was a civil servant in the times of British

ruled India and the reign of the last

Mughal ruler, Bahadur Shah Zafar. His bungalow, today the site of the Railway office, was built next to the Yamuna in 1803 when he was the deputy resident of Delhi. Fraser was murdered outside this bungalow and has been buried in the grounds of the neighbouring St. James' Church. The rather wellmaintained structure of William Fraser's bungalow is also the recipient of DDA's Adaptive Urban Heritage award in 1998. The building comprises of two separate structures that have been joined together. Architecture is in the Indo-Saracenic style, also known as Indo-Gothic or Hindu-Gothic. The building was greatly damaged during the revolt of 1857 and has since then been restored hence the alteration in architectural styles. What is most interesting is that the building stands on a tykhana, or a dungeon, that has three tunnels, one leading up to Red Fort, the other to the Yamuna river and the third to a corner of the bungalow's huge campus. This network of tunnels was meant to facilitate clandestine passage of sepoys as

The Yamuna river's waters came right up to the dungeons at the time that the waters had not receded. This is probably why these dungeons reek of a dank odour even today. A part of the tunnel accessible from behind

On the outskirts of the erstwhile walled city of Delhi was an area frequented by invaders, scheming wazirs and power hungry emperors. What is left today are structural landmarks, memories and many

#### How to reach

If you are planning to take the metro, take the Kashmere Gate exit and ask a three wheeler or a cycle rickshaw (plenty available) to the St. James' Church. The building is right behind the church.

#### Dara Shikoh's Library

The more well known and revered son of emperor Shahjahan, Dara Shikoh was known to have keen intellectual pursuits. The library established by him in the year 1637, stands in the grounds of the Ambedkar University to this day, a testimony ancient scriptures within the reach of Persian scholars. A lot of his own texts reflect a confluence of both Sufi and Vedantic schools of thought.

The library building is a short drive into the Ambedkar University campus, accessible on weekends as well. In the British period, the building served as the residence of the Mughal Viceroy of Punjab, Ali Mardan Singh. Thereafter, the Government College, the District School and the Municipal Board School operated from these premises.

The building has a huge lawn on the back side of the premises that probably served as a play area for the children at that time.

Today, the Department of Archaeology of Ambedkar University operates from here.

#### Old Post Office

The oldest post office of Delhi dating back to 1885; this is where the story of India Post began. Despite the age, the building is in good shape due to adequate maintenance and the fact that this is still an operational post office.

Its double-storeyed structure is located a quick walk down from the Ambedkar University entrance, on the way from Kashmere Gate to Red Fort. The Old Delhi Railway Station is a stone throw's away, a convenient location for all the post coming in at the time when snail mail was the only way of communication. The building has five bays with semi-circular arched doorways, typical of architecture of this time. There are semi-circular tapering pilasters between each bay.

Once you are in the area, you can also check out some other British era buildings in the vicinity; the St. James' Church, Ambedkar University building that was earlier used as the IG Block during the British governance and houses Dara Shikhoh's library and

North Delhi Ridge, with the Ashokan Pillar on one side and the Delhi University North Campus to the other, stands the Hindu Rao Hospital. The sprawling campus of the biggest hospital of the North Delhi Municipal Corporation has quite a few

As per the official version of the Hindu Rao Hospital, the main building of the hospital goes back to 1911. It was built by Sir Edward Cole Brook as a 16 bedded nursing home. However, other accounts of this structure, particularly those of noted author William Dalrymple have referred to the Hindu Rao House as a structure built by William Fraser in the early 19th century who also resided here. After his death in 1835, the house was acquired by Hindu Rao, a Maratha nobleman and brother in law of Maharaja Daulat Rao Scindia of Gwalior and the name has since stuck.

The house premises was turned into the British head quarters during the time of the 1957 Revolt, probably because of the vantage point that it offers, thanks to its elevation and thick green cover. Incidentally, this was also the spot where Timur the Lame camped and looted Delhi in

#### Qudsia Bagh and Masonic Lodge

The Qudsia Bagh complex that separates ISBT from Civil Lines has been in and out of news for various reasons. The story goes back to the 18th century when the palace of Qudsia Begum-mother of mughal emperor Ahmad Shah Bahadur and wife of Mughal king Mohammed Shah Rangila, stood at this very point. After the revolt of 1857, much of the palace was destroyed and what remains today is a mosque, an archway and a hunting lodge and some remains of the corner facade of the erstwhile palace.

The mosque is an ASI protected monument. Built with lakhori bricks, the ASI is still working to restore this to its days of glory. Some of the initial work has been patchy and looks as if sepia paint has been slapped on the structure in a hurry. The mosque is already giving in to encroachment despite notices prohibiting the same.

In the same complex is the Masonic Club and the mason's lodge. While the club is now closed since it would attract mostly those who would come across to enjoy highly subsidised liquor, the mason's lodge has recently been painted and restored, freed of all the broken furniture that had been piled up here for decades.

The historical structures notwithstanding, the real story lies in the resurrection of the park complex itself. Built in the char-bagh style, the Oudsia lawns sprawling over 50 acres were dishevelled and gradually deteriorating into a den for miscreants. Ever since the upkeep of these lawns was taken over by the Qudsia Bagh Welfare society, a body comprising mainly of local residents, the area has been converted into a walker's and horticulturist's paradise. A neat 1-km walk-way has been carved out of the lawns' periphery so that even the remote corners are now accessible to all. Almost 550 trees, 42,500 shrubs and 450 bamboo plants were planted recently.

This has only added to the already existing green treasures of this area; a few 200 year old Pipal trees that were probably planted in the Mughal era, two of the largest specimens of Cycus Palms in the city going back almost 80 years and many other old trees that are now neatly labeled for those who care to observe as they go about their morning walk. The complex is flanked by the ring road on one side and Palna-an orphanage-on the other side.

Way back in the 18th century, when the palace of Qudsia Begum stood on this grounds, the river Yamuna was flowing right next to the mosque. The river has now receded many metres and is barely visible from here today. However, you must pay a visit to the area and witness the wonders that can materialize when ownership comes from the ground up, from residents and not just an alienated municipal body.



#### **Gold Delivered Higher** Returns Than American And Indian Stock Markets In Last 25 Years: Report

NEW DELHI. Gold Returns In India: Gold has emerged as a strong performer in terms of returns since 2000, surpassing major stock market indices such as the S&P 500 and Nifty 50 over the last 25

years, according to a report by Aequitas.

The report highlighted that gold has consistently delivered higher returns than both the American stock market index S&P 500 and India's benchmark Nifty50.It said, "Gold has outperformed both S&P 500 and Nifty 50 in the last 25 years since 2000".In USD terms, gold has grown 9.99 times since 2000, significantly outperforming the S&P 500, which has grown 4.34 times during the same period. This indicates that gold has more than doubled the returns of the S&P 500 over 25 years. The S&P 500 is a stock market index in the United States that tracks the stock performance of 500 of the largest companies listed on stock exchanges in the United States. Similarly, in Indian rupee terms, gold has also outperformed India's Nifty 50 index. Over the last 25 years, gold's value has increased 19.32 times, while Nifty 50 has grown 15.67 times. The findings highlight the long-term strength of gold as an investment option, particularly during uncertain economic conditions.

Gold has often been viewed as a safe-haven asset, and its consistent growth over the years highlights its reliability for investors looking for stable returns."Gold prices continued their upward momentum, driven by a weaker dollar index and sustained support from US tariff policies. In MCX, (On Friday) gold rose by Rs 475 to Rs 86,280, while Comex gold gained USD 18 to trade at USD 2,935. The focus now shifts to upcoming US Retail Sales and Core Retail Sales data, which could influence the next move in gold.

The trend remains positive, with Rs 85,750 acting as a support zone and Rs 87,000 emerging as the next resistance level" said Jateen Trivedi, VP Research Analyst - Commodity and Currency, LKP Securities. With gold surpassing both major stock indices in performance, it continues to remain a preferred asset for investors globally.

#### US visa interview waiver rules: Wait could get longer for tourists, H1B seekers

Kolkata. The United States seems to have changed eligibility rules for Visa Interview Waiver, which could pave the way for a longer wait for those seeking visa to visit the US as tourists and for work on HIB. This facility of interview waiver is popularly often referred to as dropbox facility. The new rules are believed to have already come into effect and according to the new rule, visa applicants can use the facility if they are applying for renewing a visa in the same nonimmigrant category which expired in past 12 months in place of the 48 months that was being followed in the past few years. Simply put, the new rules are drastically reducing the time window by one-fourth and would adversely impact nonimmigrant visa holders including H-1B and applicants for B1/B2 category. However, according to reports, no formal announcement has been made so far. The National law Review has said that Visa Application Centers are already declining applicants who fail to meet the

The shrinking of the dropbox window has come at a time when the appointment period in different visa centres of the US are unusually lengthy. The wait is more than 400 days everywhere — more than 440 days in New Delhi and Mumbai, 436 days in Chennai, 429 days in Hyderabad and 415 days in Kolkata which is the shortest. Incidentally, the US government stretched the dropbox facility to 48 months in 2022, when the waiting period for B1/B2 visa interview rose to more 1,000 days.

#### What changed and what applicants can do

According to the post 2022 practice, if any applicant had a visa that expired in the past 48 months could try to renew visa through dropbox facility without personal interview. But now only those who visa has expired in the past 12 months can do so. This would mean longer personal interview queues. Experts are saying that one should plan for delays and longer time for visa processing. H-1B visa holders could perhaps attempt premium processing for

#### Bitter chocolate: High prices pinch pockets on Valentine's Day

MUMBAI. For consumers, love may have come at a cost this Valentine's Day. Chocolates, the go-to gifting choice for the season have become more expensive on the back of soaring global cocoa prices, nudging several companies to take price hikes. This essentially means that the price increases which have been taken over the past few months have now hit the markets and consumers are paying more to buy the same pack of their favourite chocolate. Amul, for instance, took a price hike of about 20%-30% for its chocolates around August 2024. "Global cocoa prices are trending at \$10,000 per metric ton. We haven't seen such price rise in the last 50 years. The situation doesn't look good but we have to live with it," Jayen Mehta, MD at Gujarat Cooperative Milk Marketing Federation, which owns the brand Amul, told TOI. The company remains watchful of the situation, Mehta said, not ruling out further price hikes if the situation warrants. Global cocoa prices which have been on the boil for quite some time due to scarce supply reached nearly \$13,000 per metric ton in December last year, hitting a record high.

Chocolate prices have surged by nearly 50% compared to Valentine's Day last year, said Ashwin Rathi, chief financial officer at Smoor Chocolates.

# BSNL reports profit of Rs 262 crore in third quarter, first in 17 years

**BSNL** expects revenue growth to improve further, exceeding 20% by the end of the financial year.

NEW DELHI. State-owned Bharat Sanchar Nigam Limited (BSNL) on Friday reported a net profit of Rs 262 crore in the third quarter ending December 2024. This marks the first time the telecom service provider has turned profitable since 2007.

For nearly two decades, BSNL struggled

with declining subscriber numbers and operational losses, largely due to intense competition from private telecom service providers in the country. However, the government intervened with a nearly Rs 3,22,047 lakh crore relief package over the past three years, providing a much-needed lifeline to the ailing telco. Communication minister Jyotiraditya Scindia said this is an important day in the journey of India's telecom sector.

"BSNL, a government-owned telecom service provider, has posted a quarterly profit of close to Rs 262 crore for the first time in 17 years," said Scindia.Robert J Ravi, Chairman and MD of BSNL, attributed this growth to the company's focus on innovation, customer satisfaction, and aggressive network expansion.

BSNL expects revenue growth to improve further, exceeding 20% by the end of the financial year. Revenue from Mobility, FTTH, and leased lines has increased by 15%, 18%, and 14%, respectively, over Q3 of the previous year. Additionally,



BSNL has successfully reduced its finance cost and overall expenditure, leading to a decline in losses by over Rs 1,800 crore compared to last year. Despite this positive development, the government has infused significant capital to support the ailing telco. BSNL

and Mahanagar Telephone Nigam Ltd (MTNL) have received another relief package worth Rs 6,000 crore for the

expansion of their 4G rollout plans. This is the fourth revival package from the government, totaling Rs 3,22,047 crore so far. The first revival package for BSNL/MTNL, approved in 2019, totalled Rs 69,000 crore. In 2022, the government approved an additional Rs 1.64 lakh crore to provide financial support for capital expenditure, viability gap funding, and debt restructuring. In June 2023, Rs 89,047.82 crore was infused for the allocation of 4G/5G

spectrum through equity infusion. However, despite these relief packages, BSNL has seen a major drop in its customer base. In December 2024, nearly 8 lakh subscribers ported out to other networks, while only 3 lakh new subscribers joined the network.

## India slashes import duty on bourbon whisky to 100% after Trump's criticism

NEW DELHI. India has slashed tariffs on bourbon whisky to 100% from 150%, a move that will benefit imports of brands like Suntory's Jim Beam, after US President Donald Trump's criticised "unfair" levies in the South Asian market. Trump, who met Indian Prime Minister Narendra Modi at the White House this week, has railed against the climate for American businesses in India and unveiled a roadmap for reciprocal tariffs on countries that put duties on US imports. The tariff notification by the Indian government was dated Feb. 13 but gathered media attention only on Friday. It said the basic customs duty on bourbon will be 50%, with an additional levy of 50%, bringing the total to 100%. Previously, such imports were



taxed at 150%. There will be no change on imports of other liquor products, which are also taxed at 150%. The move would primarily benefit imports from the United States, said Pratik Jain, a partner at PwC India. "It signals that the Indian government is willing to explore changes in tariff items for strategic partner countries," he added. Many foreign liquor companies such as Diageo, opens new tab and Pernod Ricard, opens new tab operate in India's \$35 billion spirits market, and industry executives have often criticized India's high tariff regime for such imports. Vinod Giri, director general at Brewers Association of India, said tariffs on bourbons, like motorbikes, had

# A lowdown on simpler, shorter, crisper Income Tax Bill, 2025

**MUMBAI.** The New Income Tax Bill 2025, which will replace the 1961 Act, is an attempt at simplifying the tax rules. While the Bill is shorter and Some allowances like HRA are listed in crispier, the language has been simplified. The Bill has nearly halved the sections (819 to 536), and the number of chapters to 23 from

47. In terms of word count, the reduction is nearly 50% to 2.6 lakh words from 5.12 lakh running into 622 pages, down from 1,647 pages. Another key change is doing away with the 1,200 provisos and the 900 explanations - each change in taxation laws have been passed by Parliament and become part of existing Act - in the new Bill presented in the Lower House on Thursday. Here are some of the important changes/mentions that may affect the common taxpayers: Salaried class

The new Bill consolidates all salaryrelated provisions into one place for easier understanding, so taxpayers no longer have to refer to separate chapters while filing. Deductions earlier allowed under Section 10, which deals with gratuity, leave encashment, commutation of pension, compensation for VRS and retrenchment compensation, are included in the salary chapter.

Schedule II of the Bill, referenced in



salary provisions. The goal is to improve readability by including tables and formulas. While taxability of perks remains in the Bill, valuation, conditions and exceptions are moved to Rules section as they don't apply to every taxpayer.

The Bill simplifies the definition of incomes to be taxed as salary. Any income earned by a taxpayer is taxed under different heads now but in new Bill, there are five heads of income, including salary. Other heads are income from house property, profits and gains of business or profession,

capital gains and income from other sources. The list of income to be considered as salary in the Bill are wages, annuity or pension, gratuity, fees or commission, perquisites, profit in lieu of, or in addition to, any salary or wages, advance salary, leave encashment, contribution to provident fund beyond tax-free limit, contribution by central government or other employer to employee's pension scheme accounts. Salary, bonus, commission

or remuneration due to, or received by, a partner of a firm from the firm will not be considered for tax calculation under head "salary".

# US to deport 119 more Indians as Trump's immigration crackdown continues

**NEW DELHI.** The US is set to deport 119 Indian nationals as part of President Donald Trump's immigration crackdown. A US military C-17 aircraft will land at Amritsar International Airport on Saturday around 10 pm, carrying the deportees, according to

This is the second round of deportations, following last week's repatriation of 104 illegal Indian migrants who were also flown back in a US military transport aircraft. The latest deportation includes 67 individuals from Punjab, 33 from Haryana, eight from Gujarat, three from Uttar Pradesh, two each from Rajasthan

and Maharashtra, and one each from Goa, Jammu and Kashmir, and Himachal Pradesh.

According to news agency PTI, the deportation flights will continue every two weeks until all illegal Indian immigrants in the US are sent back. PM Modi and Trump's talks on

immigration and human trafficking The deportations come shortly after PM Narendra Modi's visit to the US, where he met President Trump to discuss key bilateral issues, including immigration. During a joint press conference, PM Modi reaffirmed India's commitment to accepting its citizens living illegally in the US, but also emphasised the need to combat human trafficking, which he said is a

major factor driving illegal migration. 'They are shown big dreams and most of them are misled and brought here. We must attack this system of human trafficking. The US and India should work together to dismantle such an ecosystem so that human trafficking ends... Our bigger fight is against that

entire network, and we are confident that President Trump will fully cooperate with India in finishing this ecosystem," PM Modi said.


