#### Yogi Adityanath attacks Akhilesh Yadav over Maha Kumbh

Lucknow, Feb 24: Uttar Pradesh chief minister Yogi Adityanath on Monday slammed the Samajwadi Party in the UP assembly over



Maha Kumbh, saying the Akhilesh Yadav government had made a 'non-Sanatani' in-charge of the 2013 mela. The BJP leader was referring to former UP minister Azam Khan. "What you (the opposition) said regarding Maha Kumbh, a person from a particular caste was stopped from entering Maha Kumbh. We had told those who go with goodwill, they can go but if somebody goes with malicious intent, they would be in trouble... We did not play with the religious sentiments of people, unlike the Samajwadi party. Their CM did not have the time to monitor Kumbh and see its arrangements

and therefore, he (Akhilesh Yadav) made a non-Sanatani, in-charge of Kumbh," he was quoted as saying by ANI. Yogi Adityanath, reacting to the opposition's claim of mismanagement in the ongoing Hindu festival, said 63 crore people would not have attended Maha Kumbh had there not been world-class facilities. He also claimed that the figure would cross the 65 crore mark on February 26, the last day of

the Kumbh Mela. "Had there been no world-class facilities in Maha Kumbh, 63 crore devotees would not have attended it till now...by 26th February, I guess that the way the country and world are attracted towards Maha Kumbh, we will cross 65 crores," he said. 

Patna, Feb 24: Prime Minister Narendra Modi on Monday launched a scathing attack at the opposition in Bihar and said that those who believe in "jungle raj hate our heritage and faith", adding that the people of

the state will never forgive those abuse Maha Kumbh. The prime minister's remark gains significance in the backdrop of heavy criticism from the opposition over the alleged mismanagement, accidents, lack of 'clean water' at the world's largest spiritual gathering. While addressing a massive gathering in the Bhagalpur district, PM Modi expressed gratitude over his visit to the land of Mandarachal during the time of Maha Kumbh. "This land has faith, heritage and the potential of a developed India. This is the land of Shaheed Tilka Majhi. This is also the Silk City. Preparations are going on for Maha Shivratri here. In such a holy time, I have got the privilege of sending one more instalment of PM Kisan Samman Nidhi Yojana to many people in the country," he said. He mentioned that the NDA government in the state and the Centre is work

together to preserve the nation's glorious heritage and build a great future. However, "these people who believe in jungle raj (RJD) hate our heritage and our faith". The prime minister said that the opposition is "abusing" the ongoing Maha Kumbh of Unity, the

biggest festival of the nation's faith, unity and harmony. He noted how more than the entire population of Europe has taken a holy dip in the great Kumbh of unity. "People who are annoyed with the Ram temple are not leaving any opportunity to curse the Maha Kumbh. I know that Bihar will never forgive those



who abuse the Maha Kumbh," PM Modi added. Last week, Rashtriya Janata Dal (RJD) chief Lalu Prasad Yadav had sparked controversy by terming Maha Kumbh Mela "meaningless", blaming the Railways for the stampede at the New Delhi station that killed 18 people. Lalu lambasted the BJP-led central government over the incident and demanded that the railway minister resign. Responding to a question about the large crowds heading to Prayagraj for the Mela, he said, "The Kumbh has no meaning...It is just meaningless." Several other opposition leaders have also hit out at the BJP-led government in Uttar Pradesh as well

as the Centre, with Samajwadi Party chief Akhilesh Yadav offering to send CM Yogi Adityanath a book on managing the Kumbh Mela. Yadav had said that he would present a book on the Kumbh Mela study by Harvard University during his party's tenure in the state. The stampede at the Maha Kumbh during the January 29 shahi snan, the recent deadly stampede at the New Delhi railway station and the massive influx of devotees moving towards the Mela have all been some of the major talking points. The issue over lack of 'pure water' has also been raised, with the opposition saying that the Triveni Sangam's water, where devotees are taking a holy dip during the Kumbh Mela, was not fit for bathing. UP CM Yogi Adityanath had clapped back at the 'baseless allegations', saying that circulating "fake videos" against Sanatan

Dharma, "Maa Ganga, India or the Maha Kumbh" is like playing with the faith of the crores of people who have taken a holy dip at the ongoing Mela. He said that the Sangam water is not only fit for dip but also for drinking, alleging a propaganda to malign Maha Kumbh after faecal bacteria report by the CPCB.

## Cong slams BJP after FinMin report says USAID projects not related to 'voter turnout'

New Delhi, Feb.24: Amid the ongoing row over USAID funding, the Congress on Monday claimed that the Union finance ministry has "thoroughly exposed" the BJP's

"lies" with its annual report for 2023-24 stating that the US agency is currently implementing seven projects in collaboration with the Government of India and none of them has anything to do with voter turnout. The BJP has also rejected allegations of the Congress and accused Rahul Gandhi as well as the party of colluding with foreign forces in a bid to weaken India. The latest annual report of the finance ministry has disclosed that the agency funded seven projects worth USD 750 million in 2023-24. "Currently, seven projects worth a total budget of USD 750 million (approx) are being implemented by USAID in partnership with the Government of India," as per the

finance ministry's annual report for 2023-24 Congress general secretary in-charge communications Jairam Ramesh said, "None other than the Union Finance Ministry has thor-

oughly exposed the lies of the PM and his jhoot are with and through the Union Government," brigade, including his dapper External Affairs Minister." As stated in the finance ministry's annual report for 2023-24, USAID is currently



implementing seven projects in collaboration with the Government of India, with a combined budget of approximately USD 750 million, he said in a post on X. "Not a single of these projects has to do with voter turnout. All of them Ramesh said. For the financial year 2023-24, an obligation of a total of USD 97 million (about Rs 825 crore) has been made by the US Agency

for International Development (USAID) under the seven projects, the ministry report said. New Delhi, Feb 24: Ahead of Prime Minister Narendra Modi's visit to Bihar today, Rashtriya Janta Dal Leader Tejashwi Yadav Tejashwi Yadav raised a voice of dissent, calling out the Central and state government for its failure to deliver on promises made to the state. Tejashwi Yadav, the leader of the Rashtriya Janta Dal, arrives in Bihar today ahead of Prime Minister Narendra Modi's visit. Tejashwi Yadav voiced his disapproval, criticising the federal and state governments for not fulfilling their commitments to the state. (HT photo/Santosh Kumar) "There is an election in Bihar, and this is the only election that will be held in Bihar this year. The elections in Delhi have already con-



cluded. We had said earlier that everyone will go to Bihar, and people will flock to Bihar," he said. Yadav emphasized that despite Bihar having provided a "dou ble-engine government" for two decades, the state remains at the bottom of several key development indices. "But Bihar gave these people a chance to run the double-engine government for 20 years. Narendra Modi has been the Prime Minister for 11 years at the center, and Nitish Kumar has been the Chief Minister of Bihar for 20 years," he remarked, pointing out that Bihar ranks poorly in terms of per capita income, investment, and farmer income. "Bihar is at the bottom. Bihar ranks lowest in per capita income and investment. Bihar ranks lowest in farmer income, and Bihar is number one in unemployment, migration, and poverty," Yadav added. While acknowledging that the Prime Minister's visits to Bihar were frequent during election times, Yadav accused Modi of using empty slogans and failing to address the state's real concerns. "It's good when the Prime Minister comes, but when he comes, he only speaks in slogans and tricks the people of Bihar," he said. He recalled Modi's promises to revive sugar mills in Champaran and other districts, a commitment that was never fulfilled. "What happened? Do you understand the issues faced by Bihar's farmers?" he asked, highlighting the severity of problems like share cropping exacerbating farmer struggles.

#### **Kedarnath temple's** earnings more than double since 2020-21

Dehradun, Feb.24: The Kedarnath temple's earnings from offerings, donations and different services offered to devotees have more than doubled since March 2021, an RTI query has revealed. From Rs 22.04 crore in 2020-21, it rose to Rs 52.9 crore in 2023-24, the Sri Badrinath-Kedarnath Mandir Samiti said in response to the query filed under the Right to Information Act by Noida-based RTI activist Amit Gupta. Giving a yearly break-up, the committee said the income of the famous Himalayan temple in Uttarakhand was 22.04 crore in 2020-21, it dropped to Rs 16.52 crore in 2021-22 in the wake of the COVID-19 pandemic but rose again to Rs 29.67 crore in 2022-23 and to Rs 52.9 crore in 2023-24. The rise in the temple's income during the period was 2.3 times. A delayed opening of the temple for devotees in 2021, coupled with restrictions such as mandatory negative RT-PCR test reports, a daily cap on the number of devotees visiting the shrine, besides compliance with mask-wearing and social-distancing norms had severely affected the inflow of pilgrims during the pandemic. However, as the number of Covid cases declined and the yatra norms were relaxed, the number of pilgrims surged the following year, increasing the temple's earnings once again. The trend continued in 2023-24, the temple committee said.

#### acquits man of minor's rape 'Adolescent love': Delhi HC

New Delhi, Feb.24: The Delhi High Court has acquitted a man of a minor girl's rape saying it was a case of adolescent love and physical relations between them were consensual. Justice Jasmeet Singh therefore set aside the conviction of the man, who was 19 at the time of the incident in 2014, and was accused of raping a 17-yearold girl. The high court said punishing him was "perversity of justice". "... what cannot be lost sight of is that, at the time of the incident, the appellant (man) was 19 years of age and the prosecutrix (girl) was about 17 years of age. Thus, it was a case of adolescent love and the physical relations were established consensually. Therefore, to convict the appellant under the POCSO Act would be a perversity of justice," the court held on February 20. The age of majority as prescribed, said the court, must be construed and interpreted in the context of the law for which it was being considered. It found it improper to brush aside the girl's

view on the only ground that she was below 18 when her opinion and desire remained "certain and unshaken". Directing his

release from jail, the high court said the prosecution was unable to prove the girl's age beyond reasonable doubt and the benefit of doubt accrued to the appellant. The girl's father lodged a missing complaint in 2014 and she was later found with the man from Ghaziabad. She disclosed of having married in a temple and living at a rented accommodation in Ghaziabad. She claimed of having consensual physical relations with the man. A trial court sentenced him to seven years' rigorous imprisonment under the Protection of Children from Sexual Offences Act. The man challenged his conviction saying the trial court erred in appreciating that the girl was a consenting party to every act and nothing suggested it was a case of sexual assault. The high court advocated for a compassionate approach

prioritising "understanding" over "punish-

ment" in criminal cases involving adolescent love, saying the law should evolve to acknowledge such relationships that were



Affirming that consensual and respectful adolescent love was a natural part of human development, the court said adolescents should be allowed to express their feelings and engage in relationships without fear of criminalisation. "I believe that societal and legal views on adolescent love should

emphasise the rights of young individuals to engage in romantic relationships that are free from exploitation and abuse," the court said. The judge went on, "Love is a funda-

mental human experience and adolescents have the right to form emotional connections. The law should evolve to acknowledge and respect these relationships, as long as they are consensual and free from coercion." The focus of the law, the court said, should be on preventing exploitation and abuse rather than punishing love. While the legal age of consent is important for protecting minors, I feel that adolescents should be allowed to express their feelings and engage in relationships without fear of criminali-

sation," the judge said. The verdict added, "I affirm that consensual and respectful adolescent love is a natural part of human development." Dealing with a similar case on January 30, the judge upheld a trial court judgement acquitting a man booked under the POCSO Act.

#### Drinking water wastage, 112 cases booked in Bengaluru

BENGALURU. With summer approaching and many parts of the city staring at possible water crises, the Bangalore Water Supply and Sewerage Board (BWSSB) has cracked down against unnecessary wastage of drinking water, registering 112 cases in the past week and collecting fines amounting to

The water board had issued a circular on February 17, to curb the misuse of drinking water and ensure an adequate supply for all residents. Accordingly, it has intensified its campaign against the unnecessary wastage of drinking water. BWSSB officials have identified and penalised 112 violations.

The South Zone recorded the highest number of cases at 33, followed by the West Zone and East Zone with 28 cases each, and the North Zone with 23 cases. Fines have been imposed, and steps are being taken to recover the penalties from offenders, an official release stated.

Under Sections 33 and 34 of the Bangalore Water Supply and Sewerage Act, 1964, the use of drinking water for activities such as vehicle cleaning, gardening, construction, entertainment, decorative fountains, and other non-drinking purposes in cinema halls and malls is prohibited. Despite these regulations, many individuals and entities have continued to misuse clean water, ignoring the looming water crisis, the release added. BWSSB Chairman Dr Ram Prasath Manohar emphasised that drinking water is transported to Bengaluru from nearly 100 kilometers away, making it a precious resource. He urged the public to avoid wastage and collaborate with the Board to ensure equitable water distribution to all areas and residents in need.

#### As police watch, mentally ill man dies in Tambaram attack

CHENNAI. A lawyer and law graduate were arrested late Saturday night for allegedly attacking a man with mental illness near the Tambaram bus stand and causing his death, even as police were attempting to defuse the situation. Police said the duo attacked the man after he banged on their "new car".

The attack ended in them allegedly pushing Ranganathan (59) to the ground, leading to his death. Police said Ranganathan of Ayanavaram, was being treated for mental illness for three years. On Saturday night, passersby alerted police that he was obstructing traffic.

Two patrol officers reached the spot, took him aside, and contacted his family. They found he had left home a few days ago and his family was looking for him. As the cops were waiting with Ranganathan for his family, a car occupied by lawyer Manikandan (33), and law graduate Vinoth (28), parked nearby. Pushed to ground, victim hit head against cement slab

The duo was heading to a family function and had stopped to buy bottles of water. Police said Ranganathan ran toward the car and banged on the door. Manikandan and Vinoth got down and allegedly began attacking him, claiming that their car was new.

Despite police intervention, Vinoth allegedly pushed Ranganathan to the ground, causing his head to hit a cement slab. He was severely injured and rushed to Chromepet Govt Hospital where he was declared dead. The police then arrested Manikandan &

#### 24-year-old woman ends life over dowry harassment in Hyderabad

HYDERABAD. Sick of frequent harassment and abuse from her husband over dowry, a 24-year-old woman in Ramanthapur allegedly decided to end her life on Saturday. The woman, Akulua Manisha, is a resident of Suryapet district. She married her husband, Puligujju Sampath, a year ago, police said.

Manisha's relatives told TNIE that she and Sampath eloped on February 14, 2024. "After getting married, the couple relocated to Ramanthapur. However, after a few months, he started harassing and assaulting



"his cousin B Muneetha also demanded dowry rom her' Sampath, who works as a Lab Technician at Niloufer Hospital,

allegedly had an affair with another woman. A relative informed that Manisha attempted to stop her husband from seeing other girls but she failed, and owing to her dysfunctional relationship with her husband, she finally took the extreme step. "We knew that Sampath was not a good person. Despite asking Manisha to return to her family, she never listened and did not come back," the relatives wept. ## Woman dies after being run over by van driven by minor in Kancheepuram

CHENNAI. A 53-year-old woman died after a van allegedly driven by a 17-year-old boy hit her while she was drawing a kolam outside her house in Kancheepuram on Sunday morning. A case of death by negligence has been registered, and an inquiry is underway.

According to the Sivakanchi police, the boy is a Class XII student at a school in the locality. His father, Swaraj (name changed), runs a wholesale snacks business and delivers supplies to shops in and around Kancheepuram using the van. Since Swaraj does not drive, he

## CRUT launches trial run of ADAS in Mo Buses to curb road accidents



BHUBANESWAR. In a bid to curb frequent road mishaps involving Mo Buses in the capital region, CRUT has started trial run of advance driver assistance system (ADAS)-fitted vehicles as part of its integration in the entire fleet. CRUT officials said ADAS sensors will alert drivers when they get close to any other vehicle. Besides, the system will also help

drivers identify the traffic signals and lanes on which they are supposed to ply. It will also monitor the maximum speed limit that has been set at 40 kmph for city areas.

Around eight to 10 vendors have evinced interest to provide the system to CRUT. Accordingly, a trial run of the advanced technology on proof-of-concept (POC) basis was launched earlier this week, they said.

The trial is being carried out in four different buses including e-buses. It will continue for 10 days after which tender will be floated to finalise the vendor. "As the system will be linked to CRUT's command control centre, we will also be able to monitor drivers in realtime," an official said. Once finalised, ADAS will be installed in all 520 Mo Buses including 150 e-buses in Bhubaneswar, Cuttack, Sambalpur and Rourkela.

The system will initially be installed in the capital region which may take three months time, they added. Keeping in view the increasing cases of Mo Bus accidents, which have even resulted in a couple of

#### 13 arrested in Kochi joint raid for possession of drugs including MDMA

During the raid in a hotel located on SRM Road,

KOCHI. A total of 13 people were arrested with psychotropic substances like MDMA during a joint raid by police, the excise department, narcotics control bureau (NCB), customs, railway police, and the dog squad in Kochi on Sunday.

The raid against drug use and trafficking focused primarily on previous drug offenders, individuals currently out on bail, their suppliers, and locations such as railway stations and lodges where drug transactions are suspected to occur. During the raid in a hotel located on SRM Road, two persons

were nabbed with 31.46g of MDMA. The arrested are Subin, 26, a native of Idukki, and Bijin Abraham, 21, a native of Pathanamthitta. ## 'System has failed us': Kerala's Eloor residents left gasping for solution to pollution

s such as Pathalam, Eloor East, Mepirikunnu, and Ilanjikkal-the four wards of Eloor municipality-have been the worst hit by air and water pollution.

KOCHI. As soon as we crossed the regulator-cum-bridge on the Eloor-Edayar stretch of the Periyar on a humid evening, a pungent odour that hung thick in the air hit us hard. The result of emissions from almost every factory in the area, it left us disgusted; and, we hoped to leave as soon as possible.

However, this sorry state is nothing new for residents of Eloor industrial area, who, for several days now, have been protesting against local authorities and the state Pollution Control Board (PCB). Those especially in areas such as Pathalam, Eloor East, Mepirikunnu, and Ilanjikkal-the four wards of Eloor municipality-have been the worst hit by air and water pollution. All they seek is a permanent solution to their concerns.

We have been raising complaints with the PCB for several years, demanding action to help the residents. We are worried about pollution-related health have decided to raise our voices," says a visibly exhausted Shabeer O V, a Pathalam native and representative of Jana Jagratha Samithi in Eloor.

There are around 350 industrial units in the area. Most of these produce chemicals, rubber products, and fertilisers. "We are not against The concerns are not new. ## Odisha govt to expand AI camera surveillance to Satkosia, Debrigarh sanctuaries

BHUBANESWAR. With the Similipal experiment proving a big success, the state government has decided to expand the artificial intelligence (AI) surveillance system to Satkosia and Debrigarh wildlife sanctuaries this year at an investment of around Rs 150 crore.

Forest officials said the AI camera-based surveillance in Similipal Tiger Reserve has added teeth to the forest monitoring and wildlife protection measures while a similar exercise in Rourkela has proved effective in mitigating human-elephant conflict in the region. This has prompted the government to expand the system to other sanctuaries and forest reserves. The Al-based fire monitoring and protection surveillance towers will be installed in Debrigarh



Wildlife Sanctuary as well as the Satkosia landscape covering Dhenkanal, Angul, Satkosia and Mahanadi wildlife divisions this year. "A provision of Rs 150 crore has been made by the government and the project will most likely be taken up from the start of the 2025-26 financial year,"said an official.

He said the department is planning to deploy five AI-enabled camera towers in both Satkosia and Debrigarh as these protected areas with rich biodiversity continue to face constant threats from wildfire and other environmental challenges.

Introduction of advanced camera towers may prove to be a significant step toward preserving the vital ecosystems of the two sanctuaries, where the government is planning to take up tiger supplementation programme in the near future," the officer said.

# Roads and sidewalks shrink as encroachments choke Gurgaon

**Gurgaon.** Street vendors hastily set up their carts, shops extend their displays onto the sidewalks and cars park haphazardly along the narrowing streets. As the morning sun rises over the city, Gurudawara Road — which has several showrooms, wholesalers and shops of all kinds — already bears witness to a familiar chaos. This scene, replicated across numerous sectors, represents a growing crisis that's literally shrinking the city's road space."It takes around 15-30 minutes to cover the 200-metre stretch of the road, a distance that should be a fiveminute drive," Amit Kumar, a software  $professional\,who\,commutes\,daily\,through$ the road, says. "The roads have become obstacle courses with vendors, illegal structures and random parking eating up driving space."The problem is particularly acute in older parts of the city, where urban planning struggles to keep pace with rapid population growth. Areas like Khandsa Mandi, once a manageable marketplace, have transformed into

congestion hotspots. Here, the original road width has been reduced to nearly half by permanent and temporary encroachments. Local shop owner Ramesh Gupta explains, "Everyone wants a piece of the road. Shopkeepers extend their displays, vendors set up stalls and customers park wherever they find space. It's a vicious cycle."Architect and city planner Ahimanyu Mehta said Gurgaon once known for its sleek malls, corporate towers and modern infrastructure — is facing a persistent challenge that is gradually choking its roads. Widespread encroachments by street vendors, illegal shops and haphazard parking have turned many roads into narrow, cluttered lanes, causing severe traffic congestion, particularly in older, densely populated areas. Mehta said, "The problem is not restricted to Old Gurgaon. The situation is the same in all parts of the city. The issue continues to disrupt the daily commute for thousands of residents, hampering not just vehicle

movement, but also the quality of life in these communities."As the city's population grows, so does the number of vehicles on the roads, further exacerbating the issue of encroachment. On roads like those in Sector 12, Sector 14 and areas surrounding Galleria Market, metro station, Sector 48, bus stand, Udyog Vihar, HUDA sector markets, narrow lanes are increasingly blocked by street vendors setting up their makeshift stalls. Shabby shops extending onto the pavement, parked cars blocking entire lanes and temporary structures built on public land for commercial use have made these roads unrecognisable. Once wide thoroughfares are now bottlenecks, often leaving drivers stuck in long queues during peak hours.

For those who need to travel in emergency vehicles, the situation becomes even more perilous. Ambulances and fire trucks find it nearly impossible to navigate these clogged roads in a timely manner, creating a grave risk to public safety. Despite

Tracks to green cover: Gurgaon breathes fresh life into 75 ponds

News box

**Gurgaon.** Work to revive 75 ponds and water bodies across the city is in full swing, with officials saying that around 65% of the project has been completed since it began in 2022. These water bodies, officials said on Sunday, were once neglected and decaying, but they are starting to come to life with thriving plants and animal species. Their restoration will help the city replenish groundwater levels and reduce the risk of flooding every monsoon.Other than cleaning up the waterbodies, the project involves carrying out plantation drives nearby and laying down walking tracks along with other facilities to transform them into community areas.

The initiative is part of state govt's Amrit Sarovar Mission, under which 8,000 water bodies across Haryana are to be revived for a budget of Rs 1,000 crore. The Haryana Pond and Waste Water Management Authority oversees this initiative and research firm The Celestial Earth is documenting all the work to feature the progress in a coffee table book."Gurgaon's waterbodies are silent witnesses to the city's evolution — reviving them is not just an act of conservation, but a step toward a resilient and sustainable future," said Dr Tania Bhattacharya, founder and CEO of The Celestial Earth.Among the ponds to be revived are those in Sector 12 and Bhondsiboth important areas where waterlogging is common. Others being restored are ponds in Dhankot, Daultabad, Bajghera, and Kadarpur, along with Ghata jheel. According to officials, the city has been divided into four zones for the initiative.

In zone 1, 64% of 17 ponds over 33.6 acres of area have been restored. The figure is 44% for 18 ponds in zone 2 (51.6 acres), 88% for 12 ponds in zone 3 (28 acres) and 70% for 28 ponds in zone 4 (43.4 acres)."Restoring waterbodies in Gurgaon is a commendable step towards water security, ecological revival. But true sustainability requires more than just restoration — it demands scientific rigour, long-term planning and strong community stewardship. A pressing concern is unchecked disposal of solid waste and cow dung in village drains. Despite significant investment, poor maintenance and lack of local cooperation are clogging wastewater treatment systems," said Dr Fawzia Tarannum, strategic adviser, GuruJal.

#### Minimum temp drops by 2.6°C, air stays 'moderate' in Gurgaon

Gurgaon: The city on Sunday recorded a minimum temperature of 9.8 degrees Celsius. This marked a decline from the previous day's minimum temperature of 12.4 degrees Celsius by 2.6 notches and surpassed the season's normal by 0.4 degrees. The maximum temperature stabilised at 24.8 degrees Celsius, 1.9 degrees above the previous day's 22.9 degrees and 0.4 notches below the seasonal average. According to IMD, some parts of Haryana may experience lightning and thunderstorms on Feb 26 and 27 owing to a fresh western disturbance. Meanwhile, the city's air quality index (AQI) decreased to 116 - in the 'moderate' category - from 129.According to System of Air Quality and Weather Forecasting and Research (Safar), AQI is anticipated to ameliorate over the next three days due to advantageous conditions for pollutants' dispersal. "The predominant surface winds, likely from the north, will prevail at speeds below 15kmph during morning hours for the next three days. Northwest wind speed may intensify to 20-30kmph during the afternoon," Safar predicted. An AQI reading between 0 and 50 is considered 'good', 51 and 100 'satisfactory', 101 and 200 'moderate', 201 and 300 'poor', 301 and 400 'very poor', and 401 and 500 'severe'. Meanwhile, Delhi recorded a minimum temperature of 10.3 degrees Celsius on Sundays, below the normal by two degrees, compared to 12.5 degrees the previous day. The IMD attributed the below-normal temperature to cooler northwesterly winds. An IMD official stated that the western disturbance will affect northwest India from Feb 24 and Delhi-NCR by Feb 27, bringing reduced wind speeds and increased cloudiness, affecting temperatures. The maximum temperature was 26.7 degrees Celsius, slightly above normal, compared to 24.7 degrees Celsius the previous day, and could approach 30 by Wednesday due to slower winds.

#### Bus terminal, taxi stand: GMDA plans transit hub in Guragon

Gurgaon: GMDA will construct a bus terminal and a dedicated taxi stand in Sector 53, aiming to enhance the public transportation facility in the city. The metropolitan authority has identified 1.9-acre land for the bus terminal and 0.78 acres for the taxi stand, which will serve as an integrated public transport facility. However, before moving forward with the project, GMDA has sought the transfer of land from the Haryana Shahari Vikas Pradhikaran (HSVP).

A senior official of GMDA said, "The land has already been earmarked for building the bus terminal and taxi stand. Now we have sought possession of land from HSVP before we can move forward with the plan, including feasibility studies and project execution. The site is ideal considering the high demand for public transport in the area and it will help in streamlining traffic movement and provide better connectivity to residents."While the city has two bus depots — Sector 10 and Sector 52-53 — it lacks dedicated terminal facilities, resulting in buses often being parked on roadsides, exacerbating congestion. A bus terminal is a point where a bus route starts or ends and where buses wait before departure. Officials said the planned bus terminal will facilitate smooth intracity bus operations and the taxi stand will provide a dedicated space for taxis, autos and other last-mile connectivity options, addressing the prevalent issue of haphazard parking along roadsides, which often leads to traffic bottlenecks. The city has long struggled with inadequate public transport facilities, leading to an overreliance on private vehicles, cabs and shared autorickshaws. Sector 53, located along the Golf Course Road, has several major residential and commercial

#### Surprise rebel alliance could boost Sudan's beleaguered RSF

PORT SUDAN. Sudan's paramilitary Rapid Support Forces have signed a charter paving the way for a parallel government with its allies, including a former foe who analysts say could offer crucial territory, fighters and border access.

Since April 2023, a brutal war between the RSF and the regular army -- represented by the internationally recognised government currently based in Port Sudan -- has killed tens of thousands, uprooted 12 million and visited mass human rights violations upon civilians.Last month, the former US administration declared that the RSF had committed genocide in the western region of Darfur. Until last week, the lesserknown third party to the war was Abdelaziz al-Hilu, whose faction of the Sudan People's Liberation Movement-North had previously fought both the army and the RSF in the country's south.

In an unexpected turn of events, Hilu appeared in Nairobi last week, and his group was one of the key signatories to an RSF charter for a "government of peace and unity". If his battle-hardened fighters join forces with the RSF, analysts say it could significantly bolster the weakened paramilitaries, led by Mohamed Hamdan Daglo (widely known as Hemeti).

After weeks of losses as the army charges through the country, the new rebel alliance could also grant key border access to RSF-friendly east African states. On the back foot

The RSF has conquered nearly all of Darfur, but is unable to cement its hold on the region and appears on the verge of losing all of the capital Khartoum to the army."Hemeti is on his back foot," Marc Lavergne, a professor at France's University of Tours, told AFP.

#### Who is Friedrich Merz, Conservative leader set to become new German Chancellor

World Germany's conservative leader, Friedrich Merz, is poised to lead the nation after his party, the Christian Democratic Union (CDU), won the largest vote share in the country's general elections, overtaking Olaf Scholz's center-left Social Democratic Party (SPD).

t 69 years old, Merz, a long-time rival of ex-chancellor Angela Merkel within the CDU, has led the centerright Union bloc through the election campaign, which consistently outpaced polling.

Known for his strong business background, including roles at investment fund BlackRock and various corporate boards that made him a millionaire, Merz has never held a government leadership position.

Despite this, he seeks to project a statesman-like persona, confident in his ability to deal with unpredictable global leaders, such as US President Donald Trump, whom he has described as "predictably unpredictable."

erz, a trained lawyer, has been a vocal critic of Merkel's open-door migrant policy, which led to tensions within the CDU, especially regarding support from the far-right Alternative for Germany (AfD) on controversial issues in parliament. His fiery rhetoric was directed at Scholz and his government throughout the campaign, particularly as he railed **Rerlin**. For the first time since the against the perceived failures of the "green-left" coalition.Merz, although lacking strong personal approval ratings, was seen as the favored challenger to Scholz, positioning himself as the remedy to what he has labeled "three lost years" for Germany.

#### Trump fires 1,600 USAID employees, others sent on indefinite paid leave

WASHINGTON. Most employees at USAID will be placed on leave or fired by midnight on Sunday, the aid agency said, as President Donald Trump's administration plows ahead in slashing government spending.

Around 1,600 workers based in the United States will be laid off in a "reduction-in-force" effort. according to a notice on the US Agency for International Development's website.All other staff directly hired by USAID will be placed on administrative leave globally, except those responsible for "mission-critical functions, core leadership and/or specially designated programs."

The move is a step forward in Trump's effort to dismantle USAID, which has more than 10,000 employees and operates an array of humanitarian

and development programs around the world. The agency announced earlier this month that all staff would be placed on administrative leave -- a directive that faced legal challenges. But on Friday, a federal judge lifted an order pausing the Trump administration's implementation of plans to gut USAID. In its statement on Sunday, the agency said that remaining staff expected to continue working would be informed by management by 5:00 pm (2200 GMT) that day.USAID added that it will fund return travel expenses for staff based overseas."In the coming week, we will provide details on how to retrieve personal items from the former USAID workspaces and return government issued devices," it said. Trump and his allies -including billionaire donor Elon Musk -- allege USAID is rife with "fraud," but have provided little proof of the accusations. Its budget of more than \$40 billion is mandated by Congress, with its programs ranging from governance to life-saving food assistance. The decades-old agency has, over the years, faced criticism in the aid sector for its overhead costs and questions on whether some of its programs achieve their objectives. USAID has, however, also been a key US tool of global "soft power" -- the ability of a country to persuade others through its attractiveness.

Rome. Pope Francis remained in critical condition on Sunday and blood tests showed early kidney failure, but he remained alert, responsive and attended Mass, the Vatican said, as the 88-year-old pontiff battles pneumonia and a complex lung infection.

In a late update, the Vatican said Francis hadn't had any more respiratory crises since Saturday night but was still receiving high flows of supplemental oxygen. Some blood tests showed "initial, mild,

kidney failure", but doctors said it was under control."The complexity of the clinical picture, and the necessary wait for drug therapies to provide some feedback, dictate that the prognosis remains guarded," Francis' doctors concluded. Prayers for Francis, meanwhile, poured in from around the world, from his native Argentina to the seat of Sunni Islam in Cairo to schoolchildren in Rome.

In New York, Cardinal Timothy Dolan admitted what church leaders in Rome weren't saying publicly: that the Catholic faithful were united "at the bedside of a dving father.""As our Holy Father, Pope Francis is in very, very fragile health, and probably close to death," Dolan said in his homily from the pulpit of St. Patrick's Cathedral, though he later told reporters he hoped and prayed that Francis would "bounce back." Doctors have said Francis' condition is touch-and-go, given his age,

fragility and pre-existing lung disease. His condition has revived speculation about what might happen if he becomes unconscious or otherwise incapacitated, and whether he might resign.

Francis was supposed to celebrate Mass on Sunday morning in St. Peter's Basilica and ordain deacons as part of the Vatican's yearlong Holy Year commemoration.

The organiser of the Holy Year, Archbishop Rino Fisichella, celebrated the Mass in his place and offered a special prayer for Francis from the altar before delivering the homily the pope had prepared.

Even though he is in a hospital bed, we feel Pope Francis close to us. We feel him present among us," Fisichella told the hundreds of white-robed deacons.

A pre-written message that had been prepared for Francis to read Sunday, but he did not deliver, said he was "confidently continuing my hospitalisation at the Gemelli Hospital, carrying on with the

necessary treatment; and the rest is also part of the therapy!"The message asked for prayers for him — as he always asks - and noted the upcoming anniversary of Russia's invasion of Ukraine, "a painful and shameful occasion for the whole of humanity". Meanwhile, in Francis' native Argentina, Catholics prayed for the pope at the Buenos Aires cathedral and the city's iconic obelisk was lit up: "Francis, the city prays for you."In Cairo, the grand imam of Al-Azhar, the seat of Sunni learning who forged a close bond with Francis, wished him well."I pray to Allah to grant my dear brother, Pope Francis, a swift recovery and to bless him with good health and wellbeing so that he may continue his journey in serving humanity," Sheikh Ahmed al-Tayeb wrote in a Facebook post. The American Jewish Committee also offered prayers. "We stand together with our Catholic brothers and sisters during this challenging time," the group wrote on X.

And school children from around Rome deluged the Gemelli hospital with get-well cards, while Italian bishops led rosary prayers and celebrated special Masses across Italy.

The Triplicane police said that one of the victim, Farman, was a textile businessman in Rajasthan. He had befriended M Muhamed Khalid (26) of Chennai through social media. Furman's sister died recently and to console him Khalid invited him to Chennai.

On Tuesday, Farman came to Triplicane and was staying at a lodge there. Furman's friend Muhammad Munajur from Rajasthan also had come to Chennai and visited him on Thursday.

The same day, Khalid and three of his friends came to the room. They forcibly detained Farman and Munajur, and demanded Rs 5 lakh from them. The duo were beaten with an iron rod. Munajur managed to pay Rs 6,000 using a mobile application and was then let go. Munajur immediately lodged a police complaint based on which the police went to the lodge and rescued Farman.

Apart from Khalid, the police arrested S Syed Fazal Ahmed (38), N Irfan Basha (24), and M Yuvraj (24). After an inquiry, all four were sent to judicial custody on Saturday. A search is on to nab one more person.

# Special court questions 10 for giving a go-by to accused in Karnataka

BENGALURU. The special court for Lokavukta cases pointed out that investigation officers, giving a go-by to accused top officials while filing chargesheets in most cases, depend on the status, position, power and influence of the culprits without assigning any

This despite incriminating materials against them, said the court and directed the Lokayukta DGP to take up further investigation into the multi-crore Transferable Development Rights (TDR) scam in Bruhat Bengaluru Mahanagara Palike (BBMP) and submit the report within two months.

Judge KM Radhakrishna passed the order, while rejecting the application filed by four accused to discharge them from the case taken up suo motu in 2019 with respect to TDR in Kowdenahalli village in Bengaluru East taluk. The chargesheet was filed by then SP Uma Prashanth of the Anti-Corruption Bureau. The court, however, discharged Geetha HR, Assistant Engineer, BBMP, from the case.

'The note sheet found on pages 1277 to 1307 of Book-C in the chargesheet, prima facie unfurls the involvement of not only accused No 1 to 8, 10 but also officials of the TDR section of Mahadevapura. Particularly, the



Superintending Engineer (Road Infrastructure), Deputy Commissioner, Joint Commissioner, Additional Commissioner including Special Commissioner (Planning) and Commissioner of BBMP by involving the village accountant, surveyor, assistant revenue officer of Horamavu and others, in committing the alleged offences.

The most unfortunate action on the part of the investigation officer is giving go-by to all these officials and laying the chargesheet with incomplete investigation against accused No 1 to 8, 10 and 11. No reasons are assigned by her to ignore those against whom incriminating materials are forthcoming," the court said.

The investigation in this case is obviously incomplete and warrants further investigation to ensure effective justice in the true sense, it added.

They projected the excess land and fixed inflated rates for 2012-13 rather than the applicable rates of 2013-14 to the extent of crores of rupees. ## Ambulance driver refuses to ply on damaged road in Coimbatore, tribals carry body in doli for 3 km

**COIMBATORE.** Sending a strong message to authorities to lay road, a group of tribal men took the body of man in a doli (makeshift cradle) and walked for over three km from Neeradi to Kadambankombai near Karamadai on Saturday. According to sources, Mani (48) of Kadambankombai died due to heart attack in the Mettupalayam government Forestdepartment officials confirmed that hospital, and the body taken in an ambulance. ### The transformation more women teachers could bring

The participation of women in India's teaching workforce has seen a significant transformation over the years. According to the latest data from the Unified District Information System for Education, the number of women school teachers increased from 47.1 lakh (49.98 percent) in 2018-19 to 52.3 lakh (53.34 percent) in 2023-24. Women first surpassed the halfway mark in 2019-20, and their representation has steadily grown.

However, disparities persist between private and government schools, with private institutions showing a higher rate of women teacher participation—a 20 percent rise in recent years. Important reasons for this could be their urbancentric locations, which reduce commuting challenges and perhaps better facilities. However, these positions often come with lower salaries, reflecting societal perceptions of women as secondary income earners. Among government schools, states like Kerala, Tamil Nadu, and Punjab lead in female teacher representation—at 78, 67 and 64 percent of the respective totals.

Higher education remains a male-dominated domain. Data from the 2021-22 All India Survey on Higher Education shows that women constitute only 43 percent of faculty members. Globally, women dominate teaching roles in primary and secondary education but face a significant drop in tertiary education. According to Unesco, 68 percent of primary and 54 percent of secondary teachers are women, but only 41 percent of tertiary educators are female. In countries like Latvia and Russia, women represent over 80 percent of primary teachers, while in Sub-Saharan Africa, the figure drops to 41 percent due to systemic and cultural barriers. In India, women's underrepresentation in higher education reflects deeper societal biases, such as gender discrimination, lack of mentorship, and the disproportionate burden of household responsibilities.

Many scholarly studies have demonstrated the positive impact of female teachers on students' academic and emotional development. Women bring unique strengths such as empathy, communication skills and nurturing abilities that foster supportive learning environments. Moreover, gender balance among teachers reflects an equitable and inclusive society, and research shows that students, particularly girls, perform better when taught by female educators. Female teachers also play a critical role in addressing sensitive issues like menstruation taboos and child marriage, which often impede girls' education in developing countries. However, systemic challenges such as inadequate salaries, unsafe transportation, workplace harassment, and expensive certification processes deter women from entering or advancing in the teaching profession. The dual burden of professional and household responsibilities further limits their capacity for career growth. To address these challenges, institutions must implement familyfriendly policies, such as flexible work hours and childcare support.Governments must adopt targeted measures to address these barriers and promote gender equity in education. Providing housing allowances, transport facilities, and enhanced safety measures for women in remote schools can significantly improve their participation. Expanding financial aid for women pursuing education degrees and offering leadership training can empower women to take on administrative roles.

Bangladesh's initiative to provide stipends for female teachers in rural areas is a successful model worthy of emulation. Addressing regional disparities and incentivising women's participation in underrepresented areas would not only improve gender parity but also enhance the overall quality of education. In early childhood and primary education, female teachers are particularly effective. Studies in educational psychology highlight that classrooms led by female teachers show a 20 percent higher rate of inclusive participation. Women often integrate social-emotional learning and employ cooperative teaching methods that cater to the diverse needs of

The assignments CECs undertook post retirement have also created retrospective doubt on their non-partisan attitude. After all the talk of uprightness, T N Seshan in 1999 contested the Lok

## Don't choke education budget to enforce NEP

There is near-unanimous consensus in Tamil Nadu against the three-language formula the Centre is trying to enforce through the National Education Policy. Holding back funds allocated for education in the state amounts to coercion

School education has been the subject of many disputes in India, particularly regarding what and how to teach. One recent dispute involves Chief Minister M K Stalin's strong condemnation of the Union government for reallocating funds intended for Tamil Nadu under the Samagra Shiksha Abhiyan (SSA) scheme to other, BJPruled states. This is not an isolated incident. More and more states ruled by opposition parties have accused the Centre of discrimination in distributing discretionary transfers. The funds due for Tamil Nadu under the SSA were not released on the pretext that the state government had not signed a memorandum for implementing the PM-Shri schools, which requires implementation of the National Education Policy (NEP) in Tamil Nadu—which this state and many others have vehemently opposed. Freezing funds that constitute 7-8 percent of the state school education budget to impose a centralising agenda of the Union Government, which directly impacts lakhs of students, isn't just a blot on federalistic ethos, but is also a travesty of Indian democracy. Denying a state funds recommended by the constitutionally mandated 15th Finance Commission—unless it complies with the Centre's arbitrary and legally non-binding policies—is nothing short of authoritarian coercion. The Tamil Nadu government has been implementing a number of commendable aspects of the NEP through schemes such as Ennum Ezhuthum (for foundational literacy and numeracy), Pudhumai Penn (guidance for girl students to get into higher education), and the CM Breakfast scheme, many of wich pre-date the NEP's rollout.On a number of fronts the state has surpassed NEP targets. For instance, the NEP aims to achieve a 50 percent gross enrolment ratio by 2030. But Tamil Nadu's GER in 2022 was already 51 percent, making it almost a decade ahead

in implementation. The Tamil Nadu government has primarily objected to the NEP on two grounds: the threelanguage policy with significant curriculum changes, and implementing the 5+3+4 system. Imposition of the three-language formula is being viewed as a measure to pave the way for Hindi to enter through the backdoor. A 2022 information request revealed that the Kendriya

Vidyalayas in Tamil Nadu did not have a single Tamil Teacher.Paragraph 4.5 of the NEP initially states, "The three languages learned by children will be the choice of states and of course the students themselves." But a later part of the clause adds, "so long as at least two of the three languages are native to India". One can only assume that the other language would mostly be Hindi, and not Odia or Bengali. This is why many states such as Tamil Nadu, Kerala and Karnataka fear imposition of Hindi through manipulative mechanisms.

But this should not be viewed as a measure to deprive individuals of the opportunity to learn Hindi or any other language. The Dravidian parties in Tamil Nadu have never opposed the voluntary learning of Hindi or any other

language-they only oppose their direct or indirect imposition. On the contrary, with 5,80,000 students appearing for the Prathmik exams in 2024, Tamil Nadu has a legacy of large cohorts voluntarily choosing to learn Hindi. Another poignant question is why an In Tamil Nadu, opposition to the three-language formula is education policy should deprive individuals of the freedom to learn international languages such as German, Japanese or Mandarin, given their strong economies face significant labour shortages and are seeking both skilled and unskilled workers from India.

The Centre's approach of directly imposing its ideological agenda on elected state governments through schools reinforces a centralisation fetish that we have seen increase over the last 10 years. The states that were denied funds—Kerala, Punjab, Tamil Nadu, Delhi and West Bengal—are among the top performing states on NEP objectives that include bridging gender and social gaps as well as promoting equal opportunities. Instead of incentivising states that have performed well, the Centre is penalising them. Tamil Nadu is already squeezed for funds, receiving back only 29 paise for every '1 it contributes to the central kitty. Denial of apportioned funds to such a top-performing state will only hinder India's growth. Countries can

prosper only when individual states thrive. What they require is more autonomy and solutions tailor-made for their socio-economic growth.

According to interesting research, people at the workplace may adjust their behaviour to break stereotypes about themselves or match the stereotypes of others - even if it means playing dumb or giving the

The team from Princeton University showed four experiments with approximately 150 to 200 participants

They found that both supervisors and subordinates chose to present themselves in diverging ways either by trying to break down these stereotypes or by mirroring or "matching" the expected behaviour of the other

Past studies have shown that managers are typically seen as competent and cold while lower status employees may be seen as warm but not entirely

"In doing this, people might actually talk past each competence to appear warmer to you while you other, making people have more of an awkward



misunderstanding," said Jillian Swencionis, lead author from Princeton's Woodrow Wilson School of Public and International Affairs.

"Our findings illustrate just how invasive perceived inequality and social hierarchies really are, impacting both interpersonal relationships and workplace encounters," the author added.

The stereotypes people hold about others may not necessarily be true so when they're trying to "match" the other person, they're matching what they think the other

"These kinds of diverging impression management strategies may be one reason for misunderstandings or otherwise awkward situations people have in these interactions," Swencionis noted in a paper published in the Journal of Experimental Social Psychology.

To reach this conclusion, researchers used Amazon's Mechanical Turk (artificial intelligence project), recruiting 202 participants. The studies show this clear pattern in which people are uncomfortable with status divides because of how they are stereotyped or perceived. As a result, they present themselves in diverging ways.

"The bigger picture is that supervisors trade off warmth and competence and subordinates know this. Someone seen as highly competent will seem colder, and someone seen as really warm will seem dumber. regardless of the fact that these dimensions don't really operate in opposition," explained Susan Fiske, study co-author from Princeton University.

Human resource managers, job applicants, reference-letter writers, organisational managers and candidate image handlers all need to know this, the authors noted.

His lack of trust is a major factor for the number of people quitting the team."

#### MICROMANAGER

The trait of a typical micromanager is someone who wants to be a part of each task that his her team undertakes. Right from why a team mate is late to work, to wanting to know the details of even the smallest work undertaken. Working with a micromanager, though daunting at most times, can sometimes be positive. Rahil Shah, who works with a telecommunication company, says, "My boss insists on knowing the details of the work we put in every hour. New Delhi. Congress workers on Monday staged a massive protest outside the Rajasthan Assembly in Jaipur amid an ongoing uproar over a Rajasthan minister's controversial remarks against former Prime Minister Indira Gandhi. The protest, however, turned violent as the demonstrators clashed with police as they were stopped from marching towards the Assembly where the Budget Session is currently underway. Videos of the protest showed participants trying to climb police barricades, with some resorting to physical altercation.ute between the two states.

According to news agency PTI, MPs Harish Meena and Murari Meena, former minister BD Kalla and several other senior Congress leaders participated in the protest.

During a discussion in the Rajasthan Assembly on the Centre's 'Lakhpati Didi' scheme on February 21, the state's Social Welfare Minister, Avinash Gehlot critiqued

the Congress and said, "In the 2023-24 budget also, like always, you named the scheme after your 'dadi' (grandmother) Indira Gandhi."The remark triggered an immediate uproar in the House, which led to three adjournments and the suspension of six Congress MLAs, including state party chief Govind Singh Dotasara, for the rest of the Budget session.

Since then, Congress legislators have staged a sit-in at the premises demanding an apology from Avinash Gehlot. Assembly proceedings witnessed three adjournments on Mondayas Congress MLAs continued sloganeering against the controversial remarks and the suspension of legislators.

While the Congress has continued lashing out at Avinash Gehlot, the minister, however, claimed that the remark was not made out of disrespect."Elderly in the family are addressed as Dadi. It was not done out of disrespect," he said in defence.



#### Bomb threat forces NY-Delhi flight to divert, land in Rome

NEW DELHI. An American Airlines flight from New York's John F Kennedy International Airport to Delhi was forced to make an emergency landing in Rome on Sunday night following a mid-air bomb threat. The Boeing 787-9 Dreamliner, with over 280 passengers aboard, diverted its course over the Caspian Sea before heading westward toward Italy. According to flight tracking data, Flight AA292 took off from New York at approximately 8:30 pm on Saturday for its scheduled 14-hour journey to the Indian capital. However, around



10 hours into the flight, the aircraft executed an abrupt turn near the Black Sea, reversing its path before heading toward Rome's Fiumicino Airport.

Upon nearing Italian airspace, the plane was reportedly escorted by Italian fighter jets as a precautionary measure. It landed safely in Rome at around 5:30 p.m.

While authorities have not disclosed the precise nature of the security alert, sources suggest that a bomb threat was received mid-flight, necessitating an immediate assessment by airline and security officials.

The decision to divert to Rome instead of a closer landing site was attributed to American Airlines' established operational base in the Italian capital.

#### MK Stalin demands complete withdrawal of Advocates Amendment Bill 2025

NEW DELHI. Tamil Nadu Chief Minister MK Stalin demanded the complete withdrawal of the Advocates Amendment Bill 2025, calling it a direct assault on the autonomy of the legal profession. In a post on X, he accused the BJP government of systematically undermining the independence of the judiciary since 2014.He alleged that the central government first attempted to hijack judicial appointments through the National Judicial Appointments Commission (NJAC), then ignored the collegium's recommendations for judicial appointments and



transfers, and is now trying to weaken judicial independence by seeking control over Bar Councils. "By eroding the autonomy of the legal profession, the BJP government aims to curb judicial independence," Stalin stated. Criticising what he termed the BJP's aversion to the Tamil language, the Chief Minister pointed out that the Bill seeks to rename the Bar Council of Tamil Nadu & Puducherry as the Bar Council of Madras. "Tamil Nadu is not just a name, it is our identity," he asserted.

Stalin also noted that while strong opposition forced the Union government to withdraw the draft Bill, the indication that it would be reconsidered and processed afresh was unacceptable. He reiterated his party Dravida Munnetra Kazhagam's (DMK) demand for a complete withdrawal of the Bill and urged the Union government to respect the autonomy of the legal profession.

## Panel on cost soon to firm up sub project

NEW DELHI. Formation of a cost negotiation committee is under way to speed up the Indian Navy's Project 75 (India) project under which submarines will be built in alignment with the Atmanirbhar Bharat Abhiyan.

The CNC to be firmed up soon will include officials from the Ministry of Defence (MoD), Navy and Defence Finance in addition to representatives of Mazagon Dockyard Limited (MDL) that will lead the project under strategic partnership (SP) with Germany's TKMS (ThyssenKrupp Marine Systems), said sources."Once the project is firmed up, MDL and Germany must adhere to the objectives of the Atmanirbhar Bharat Abhiyan. TKMS will need to meet 100% of the commercial and technical requirements, including transfer of



MoD source said.

"This area will be closely scrutinised to ensure that actual design knowledge is transferred to India after the delivery of the first submarine, allowing India to freely use this technology as needed," the source added.

"A contract will be signed between the MoD and MDL. Further, there will be a contract between MDL and TKMS. Work share and responsibilities will be finalised under the contracts," another

source said."Firstly the design will be confirmed and then it will be work converted into a functional system. The transfer of technology from the original equipment manufacturer (OEM) should be such that the next class of submarines should be totally Indian, from scratch to operational system," the source said.

"Historically Germans are not known for sharing such extensive knowledge in defence programmes, so the successful implementation of the SP model is will be seen as significant," the source added.

Defending his remarks, he said on the podcast that the people have supported his right to express himself over the state's development.

"If the party wants me then I will be there for the party. If not, I have my own things to do. You should not think that I don't have any option to spend time. I have options. I have my books, speeches, invitations from across the world for talks," he said.

The 2024 national elections saw a Congress resurgence, but the same did not reflect in the state elections that followed. Mr Tharoor said the Congress needed to expand their appeal in Kerala, or else they would sit in the opposition for the third straight time.

The Congress cannot win elections with the support of only its committed support base, he asserted. "At the national level, the Congress vote was around 19%. Would we be fine with our own vote base? Only if we get 26-27% additional, we can come to power. We need those who have not backed us in the last two elections," he added.

He said he even got the votes of those opposing the Congress due to the way he expressed himself. "I came back to this country to serve it. I was doing well in the US and earning a lot of money," he said.

#### The Tharoor Row

Mr Tharoor, a prominent Congress face in Kerala, sparked a buzz of rift after he praised the LDF government's handling of the Kerala economy in a newspaper article. The Left welcomed his remarks, but it drew fire from his own camp.



#### Meta rewards executives with 200% bonuses despite ongoing job cuts

New Delhi. Just a week after laying off 3,600 employees, Meta has decided to give its top executives a big pay boost. According to a corporate filing, the company has increased executive bonuses to 200% of their base salary, more than double the previous 75%.

The decision was approved on February 13, 2025 by Meta's Compensation, Nominating, and Governance Committee (CNGC). However, the new bonus structure does not include CEO Mark Zuckerberg. The company justified the hike by saying that its executive pay was falling behind industry standards, reported Moneycontrol.Meta's board argued that, before the increase, the "target total cash compensation" for its executives was "at or below the 15th percentile of the target total cash compensation of executives holding similar positions" at other major tech firms. Following the increase, Meta said, "the target total cash compensation for the named executive officers (other than the CEO) falls at approximately the 50th percentile of the Peer Group Target Cash Compensation."The company defended the move, saying it was necessary to retain top talent and keep compensation competitive. However, the timing of the announcement has led to criticism.

The announcement comes soon after Meta laid off around 5% of its global workforce. The company said the job cuts were due to "low performance," but many employees and industry watchers have criticised the decision, especially given the large executive payouts. Despite the layoffs, Meta is increasing its presence in India, particularly in Bengaluru. The company is actively hiring for 41 engineering positions in the city, focusing on software development, machine learning, and chip design for

Meta has posted several job openings on LinkedIn in the past month, showing its push to build an engineering hub in India. The company is also looking for an "experienced Engineering Director" to lead its India-based team, a role that Meta describes as important for shaping its technical vision in the country.Unlike its offices in Hyderabad, Gurgaon, New Delhi, and Mumbai, which mainly handle nonengineering roles, the Bengaluru office will be a key technology centre. It will support Meta's Enterprise Engineering team, which focuses on internal tools rather than public-facing products like Facebook and

# Indian ITeS Industry and GenAl Conundrum as adoption remains under 40%

New Delhi. India's IT enabled services industry is at a defining crossroads. While it is a fact that generative artificial intelligence (GenAI) could be India's next trillion dollar opportunity, for this to happen Indian developers have to adopt it. According to a study, despite over 80 per cent of developers recognizing GenAI's benefits, adoption lingers below 40 per cent. According to the latest Boston Consulting Group (BCG) report 'The GenAI Adoption Conundrum', over 80 per cent of developers acknowledge its advantages, citing increased productivity and efficiency. But even with allpervasive benefits, proficient adoption of these tools is still at paltry figures.

"This is the GenAI adoption conundrumwhere the benefits are visible, but proficient adoption still remains stuck below 40 per cent" said Sambhav Jain, MDP at BCG. "It's like being handed a Formula 1 race car—but choosing to walk instead. Contrary to further belief that GenZ is the GenAI generation, we observed that proficient adoption among GenZ dipped even further to 31 per cent", Jain added. What ails this adoption is integration issues and inadequate enablement. Jain says that while every company says they are training their employees, this training is not focused on GenAI. "Training today is broad but lacks depth—Almost half developers reported being unaware of how to fully utilize the tool's capabilities in their workflow. Clients are skeptical too, and require clear value proposition & security measures," said Rajiv Gupta, Managing Director & Senior Partner, BCG in a conversation withAt a time when AI and GenAI has been the focus area for clients, the Indian developers inability to be prepared can cost the industry a big opportunity.

"This conundrum represents a missed opportunity for Indian IT services. It's not just about access - Scaling is about behavior change, process transformation, and leadership. Many companies have begun their AI journey—running POCs,



experimenting, and seeing early success. Organizations that are getting this right are leveraging a structured adoption playbook," he added.

To break free from this conundrum, India's IT firms must move beyond experimentation and into full-scale adoption. BCG's report outlines a fivepart playbook for success; it asks organisations to train for Impact, not Just Awareness – GenAI adoption jumps from 16 per cent to 48 per cent when developers receive five or more targeted training sessions. Two, 92 per cent of enterprise clients are willing to pay a premium for AI-driven services, but they need proof of tangible ROI. Three, firms must track productivity gains scientifically—measuring AI's impact across efficiency, quality, and output.

Change management is a huge part of this adoption. Addressing psychological resistance among developers is also important. Finally, setting up Centers of Excellence (CoEs) is impactful. Almost 80 per cent of firms with GenAI Centers of Excellence have seen marked improvement in trainings, better resource access & regular scientific tracking.

"GenAI's momentum is at the bottom of the hockey stick effect-what we do next will define our trajectory. We are at a critical inflection point where Indian ITeS must lead with conviction, scale GenAI with urgency, and earn the right to shape the future of AI-powered services. The choice is clear: we either embrace this transformation and cement our global leadership, or hesitate, lose ground, and fade into irrelevance," said Gupta.

## Earning up to Rs 12.75 lakh Why you should opt for new income tax regime

NEW DELHI. Perhaps, the biggest Budget 2025 announcement by the Finance Minister Nirmala Sitharaman was that individuals with salaries up to Rs 12 lakh will pay zero taxes under the new tax regime. This regime, though it has few exemptions and deductions, offers reduced tax rates. However, with Rs 75,000 as the standard deduction under the new regime, individuals earning up Rs 12.75 lakh annually need not pay any taxes.Earlier, taxpayers earning up

to Rs 7 lakh paid nil taxes under the new regime. Now that limit has been raised to Rs 12 lakh. This means anyone with an income of up to Rs 12.75 lakh (taking standard deduction into consideration) will now pay zero taxes.The Finance Minister in her Budget 2025 speech said, "I am now happy to announce that there will be no income tax payable upto income of 12



lakh (i.e. average income of 1 lakh per month other than special rate income such as capital gains) under the new regime. This limit will be 12.75 lakh for salaried taxpayers, due to standard deduction of 75,000."

Vaibhav Jajoo, Advocate (CA), Dhruva Advisors LLP said, "From a direct tax perspective, the relief and changes in tax slab rates are welcome measures. Notably, income up to Rs. 12.75 lakhs (including a standard deduction of Rs. 75,000) has been made tax-exempt under the new tax regime. This is a significant and welcome move to provide relief to the middle class and stimulate spending in the economy.

In other words, those taxpayers with the

above-mentioned income threshold of Rs 12.75 lakh annually, and who do not have significant savings or investments, such as those eligible for deductions under Section 80C (HRA, PPF, LIC, ELSS, etc.), should opt for the new tax regime owing to zero tax liability. This, in turn, would raise their consumption levels and give a boost to

#### They told her women shouldn't box, Now she's Ghana's first female world champion

ACCRA. When Abigail Kwartekaa Quartey decided as a teenager to become a professional boxer - an unusual choice for a young woman in a working-class neighbourhood of Ghana's capital of Accra her family begged her to stop training.

Boxing is the pride of Jamestown, which is based around the fishing industry and also known for being home to many boxing stars. But like most sports in Ghana, boxing has often been seen as for men only, and women are discouraged from taking part.

And last year, at age 27, she became Ghana's first female world boxing champion and the first woman to travel the world as a member of the West African nation's national team.

"My aunts and siblings didn't like it when I started boxing. They would come here to beg my coach not to let me become a boxer," she said at the Jamestown neighborhood's Black Panthers Gym where Quartey has been training since her teenage years.

But when last November Quartey defeated British boxer Sangeeta Birdi in Jamestown's

Apart from that, Kohli also worked on his backfoot game by going deep inside his crease to play cut shots and push the ball into gaps for singles. Former India cricketer turned commentator Aakash Chopra shared the details of Kohli's practice session a day ahead of the game and threw light on the thought process of the batting star. "It was interesting actually a couple of shots, wrist spin has been a problem, let's be honest. Whether it's Rashid or Rishad, he knows that. There is a problem that's just there and it's ailing him. There's an Abrar, whom he will have to handle against Exorcising the spin demons Pakistan. So playing the slog sweep and the Kohli's trial by spin finally began as Abrar sweep shot and going deep inside the crease and then playing the cut shot. And I think,



what also plays a role here is that now he knows how this surface is going to react. So you know, these are the areas, I need to target. This is the bowler, I need to play. And these are my strengths as well that if I were to score runs, I will go sweep and slog sweep and also deep inside the crease and cut shot," said Chopra on Star Sports. Having refined his skills, the King was all ready to pounce on his favourite opponent as he walked to the crease amid loud cheers from fans demanding some sumptuous shots from his blade. Kohli got off to a good start in his innings as, after scoring a few singles, his trademark cover drive came to the fore, and he moved to 22 (20).

Ahmed came on to bowl in the 14th over and he comfortably started the battle with a single. The contest between the two was expected to be a match-defining moment as Kohli had been dismissed by wrist spinners five out of his last six innings. He played three dot balls in the over but never for a second looked perturbed, showing good judgement at the crease, playing both off the front foot and back foot. As his innings went on, Kohli kept on nudging the ball around for singles and doubles and gradually built on his innings. In

between, he collected a couple of boundaries against Haris Rauf and Naseem Shah and completed his half-century off 62 balls. The Kohli of the old had returned, as he whittled away the deficit run by run and brought the game into India's grasp in no time. His method was simple, 'go after the seam bowlers and not take too many risks against the spinners but keep rotating the strike'. Kohli stood true to his mantra as he took no risks whatsoever against the spinners and collected occasional boundaries against the fast bowler to keep the required run rate under control.
