Kolkata, Feb 27: Abhishek Banerjee of the Trinamool Congress on Tuesday rejected reports that he has differences with party supremo and West Bengal chief minister Mamata Banerjee. The TMC general secretary reaffirmed his loyalty to her. "I am a loyal soldier of the TMC, and my leader is Mamata Banerjee," Abhishek Banerjee said at a party conference in Kolkata. Dismissing speculation that he might cross over to the Bharatiya Janata Party, Abhishek Banerjee said, "Those who are saying that I am joining the BJP are spreading canards." "I know those people who are spreading such fake news. They have vested interests ahead of the next year's assembly polls," he said. The Diamond Harbour MP also asserted that he would "continue to expose traitors within the party, just as he did during the last assembly elections". "Till the time all of you are with us, we will continue to demolish BJP's 'chakravyuh'... Those who spoke ill about the party have been identified. I was the one to identify people like Mukul Roy and Suvendu Adhikari who went against the party," the Mamata Banerjee's nephew said.

loans in the post-Covid years were about 18 per cent of the Private Final Consumption Expenditure, he said. Much of this indebtedness was due to the rise in small ticket personal loans from non-banking finan-

cial companies - they comprise 82 per cent of the new personal loans originated in 2024," he said citing the report. Credit growth has now created a household indebtedness crisis instead of continuing to fuel consumption, Ramesh said. Household debt to GDP has hit an all-time high of nearly 43 per cent, he claimed. "As a flipside to the household indebtedness, households are saving less especially financially.\

Maha Kumbh was like a nation breathing with a new consciousness: PM Modi



Highway to connect Arunachal border districts: Rijiju Tejinder Kaur Babbar

ITANAGAR, Feb 27: The Union government has approved the construction of the Arunachal Frontier Highway, a massive infrastructure project aimed at enhancing connectivity in border areas, Union Minister Kiren Rijiju announced on Wednesday. Speaking at the first-ever Joint Mega Nyokum Yullo Celebration in Boasimla, Kamle district, Rijiju said the highway, which will pass through 12 districts along the India-China border, is a dream come true and set to be a game changer for the northeastern state. With an estimated cost of ?42,000 crore, this is the highest-ever allocation for a single infrastructure project by the Centre, Rijiju added. The highway, according to Border Roads Organisation, is around 1637-km-long and in some places, it will run as close as 20km to the Line of Actual Control. Its development is in line with the Narendra Modi government's emphasis on developing border villages, building infrastructure in the North-East, and strengthening infrastructure in border areas so as to facilitate rapid movement of troops. Article 370 abrogation proved to be good for JK's development: Athawale

Mumbai, Feb.27: The Centre's decision to revoke Article 370 of the Constitution proved to be "good" as it strengthened development and "ended" terrorism in Jammu and Kashmir, Union Minister Ramdas Athawale said on Thursday. There was a time when tourists were afraid of visiting Jammu and Kashmir but that has changed after the revocation of Article 370, the minister of state for social justice and empowerment said at a press conference here. On August 5, 2019, the Centre abrogated Article 370, which accorded a special status to the erstwhile state of Jammu and Kashmir. The government also divided Jammu and Kashmir into two union territories - Jammu and Kashmir, and Ladakh. "The (PM) Narendra Modi-led government has taken a lot of important decisions and the abrogation of Article 370 was a very big step which strengthened development in J&K, ended terrorism and generated employment opportunities besides establishing peace and paving the way for unfurling the tricolour," Athawale said. Earlier, people were afraid

of visiting J&K but the situation changed after

Article 370 was revoked and more than 2.5 million

tourists visited the union territory last year, he said. "The increase in tourism means more development for the region. It was a very good decision to



revoke Article 370. Now the people want us to give the status of a state to J&K. When (Home Minister) Amit Shah announced the removal of Article 370, he also announced that J&K's statehood would be restored at an appropriate time. Jammu and Kashmir will get the status of a state soon and all of people's problems will be resolved," he added. The minister lauded the highest voter turnout in Jammu and Kashmir in the assembly elections held last year. "Though the alliance of the National

Conference and the Congress came to power. t hardly matters to us as we are with the people and want the region's development," he said. Asked about the rape of a 26-year-old woman in a bus at the busy Swargate depot in Pune, Athawale said such incidents are condemnable and heart-wrenching. "We demand that the culprits behind such incidents be hanged," he said. Maharashtra Chief Minister Devendra Fadnavis has already directed police to speed up the investigation and bring the culprit to book, he said. "Society needs to come forward to counter such incidents which are increasing. The people behind such incidents should be boycotted as we are seeing atrocities being committed on even three to four-year-old

children. It is the responsibility of parents and families to ensure that their children get a good education," he said. On the opposition to the "imposition" of Hindi in Tamil Nadu, Athawale said the introduction of Hindi in the southern state should not be opposed as it will harm the country's unity and integrity.

'Nirbhaya case led to changes, but': Former CJI Chandrachud

New Delhi, Feb 27: As the investigation over the alleged rape of a woman inside a bus at Swargate depot of Maharashtra's Pune, calls for strictest punishment for the absconding accused are



growing, with former Chief Justice of India DY Chandrachud also raising a similar demand. Amid mounting pressure from the opposition, which has likened the incident with the 2012 Delhi Nirbhaya gang rape, a frantic effort to crack the case is underway. Police have formed multiple teams to nab the history-sheeter accused, Dattatray Ramdas Gade (37), who has

been on the run since the incident which took place on a Maharashtra State Road Transport Corporation (MSRTC) bus early Tuesday morning. Pune rape case updates A reward of ?1 lakh will be given

to the person providing information about his whereabouts, news agency PTI quoted Pune police commissioner Amitesh Kumar. Former CJI DY Chandrachud on Thursday said a lot of changes were made in the laws following the 'Nirbhaya' incident, however, we can not prevent such incident by only having laws. Chandrachud said there is a great responsibility on the society and apart from this the implementation of laws should be there. "Laws made for women should be implemented properly. Women should feel safe wherever they

Kidney patients suffer as SCB's transplantation unit is in limbo

BHUBANESWAR. Once a pioneer in renal transplantation, SCB medical college and hospital (MCH) in Cuttack is now grappling with a severe crisis, thanks to the apathetic attitude of the Odisha government towards the premier healthcare institution.

SCB MCH was one of the few state-run hospitals to start renal transplantation in the country way back in 2012. A decade later, the transplantation unit is in limbo due to prolonged vacancies in the department of nephrology, which is crucial for both pre and post-operative care of kidney patients.

While the hospital had recorded 194 renal transplantations till 2022, only 14 were conducted in 2023 and nine in 2024. The hospital that was conducting at least two transplants a month until a few years back, has managed to perform only one transplant in last three months.

According to hospital records, of the nine transplants performed in 2024, three patients succumbed in the ICU itself and two are now undergoing dialysis. The hospital was also under scanner for poor transplantation in 2023 as the team had to remove a cadaver kidney transplanted in a patient after the 'diseased' organ stopped functioning and led to further complications.

The fall in transplant numbers is attributed to severe staff shortage, with key posts including that of a professor and one assistant professor, lying vacant for a long time. "If the shortage of doctors delayed evaluation of patients, post surgery care is

Traffic plan at Tidel Park Junction delayed due to congestion from CMRL work

CHENNAI. Even as two "U"-shaped flyovers at Indira Nagar and Thiruvanmiyur on Rajiv Gandhi Salai have been thrown open for vehicular movement, state highways and traffic police have postponed the plan to convert the Tidel Park Junction into a bidirectional signal.

This decision is primarily due to the narrowing of Rajiv Gandhi Salai from a four-lane road (including service lane) to a double lane (six metres) because of CMRL construction work in Thiruvanmiyur-Indira Nagar section. As a result, vehicles coming from Thuraipakkam and Thiruvanmiyur (on the "U"-shaped flyover) converge at the narrow section in Thiruvanmiyur-Indira Nagar section, leading to a huge vehicular congestion.

'At present, motorists from Thuraipakkam and SRP Tools are permitted to turn right to access Thiruvanmiyur, ECR, and Adyar," said officials from Traffic Police and Tamil Nadu Road Development Company

The proposal to change the Tidel Park Junction signal from four-way to bi-directional configuration was part of the "Development of Comprehensive Integrated Traffic Infrastructure at Tidel Park Junction" scheme initiated in 2019 to ease congestion on OMR and its connecting roads. The proposal includes construction of two "U"-shaped flyovers, foot over bridge at Tidel Park and widening of carriageway in Rajiv Gandhi Salai at a cost of Rs 108.13 crore.

According to the proposed plans, vehicles travelling from Thuraipakkam/SRP Tools should take a detour of an additional 1 km and use the flyover at Indira Nagar to make a Uturn. From there, motorists will find Indira Nagar 2nd Avenue Road on their left, providing access to Adyar/R.A. Puram. Those heading towards ECR (Thiruvanmiyur/Kottivakkam) can continue driving and take a left turn. However, this plan could not be implemented due to severe congestion caused by the narrow road.

Monitor e-filing of cases; upgrade to CCTNS 2.0 in three months: Madras HC

MADURAI. Observing that the e-filing system in the police department and criminal courts are not functioning optimally and that both parties are playing the blame game, leading to a huge pendency of charge sheets before courts, the Madurai Bench of the Madras High Court recently directed all principal district judges to constitute taluklevel and district level-committees to ensure proper functioning of the e-filing system.

The court further ordered the state police to complete the implementation of the Crime and Criminal Tracking Network and Systems (CCTNS) 2.0 within three months.

Justice K Murali Shankar gave the directions while disposing of a petition filed by one S Janardhanan, seeking to quash an FIR against him by the Dindigul police in a cheating case in March 2024. Though the police claimed that they already filed the final report in his case through e-filing, the petitioner was informed by the lower court staff that they did not receive any final report. Noting that such occurrences have become common and there is widespread delay in taking final reports on file by the subordinate courts, the judge suggested the implementation of the Inter-Operable Criminal Justice System (ICJS) platform, introduced by the e-committee of the Supreme Court, in TN. However, it was informed that the ICJS system, which interconnects the CCTNS (Police), CIS (ecourts), e-prison (jail), e-forensic (Forensic Department) and e-prosecution (Prosecution), could not be implemented in the state as the current CCTNS platform used by TN police is not compatible.

Future is clean! DTPC to turn Ernakulam district's four beaches into green destinations

Tourism dept plans various initiatives at Fort Kochi, Munambam, Cherai and Kuzhuppilly beaches

KOCHI. The sorry sight of plastic waste littering the beaches in the district could become a thing of the past after March 31. As part of turning Fort Kochi, Munambam, Cherai and Kuzhuppilly beaches into green destinations following a state government directive, the District Tourism Promotion Council (DTPC) will be implementing various initiatives.

"The Suchitwa Mission carried out a gap assessment study and has submitted a report to the DTPC, in which various issues were pointed out," DTPC secretary Lijo Joseph told. The main gap pointed out was a lack of adequate number of waste bins in and around the beaches, he said.

"Not that there are no waste bins at all. However, they are scattered and few. It has also been decided to set up boards that direct tourists to the location of the waste bins. Another initiative is to educate the vendors and the shopkeepers near the beaches on the need to avoid single-use plastics," Lijo said.

The plan is to phase out plastic water bottles from these beaches. When asked about the timely collection and disposal of plastic waste from the waste bins, the official said, "We have a team in place at all the destinations that see to



timely collection and disposal of the waste from the bins.

There are 22 people at Fort Kochi and a team of around four to five at other beaches. We have arrived at a plan, discussed at a meeting with the district collector recently, on how to go about the collection and

In the long run, the department aims to turn these destinations into plastic-free zones. "We are thinking of setting up water kiosks at beaches so tourists can refill the water bottles they bring with them or even the pet bottles they buy. Refilling pet bottles will dissuade them from throwing them once the bottle runs out of water," the DTPC secretary

Another idea, which is yet to be finalised, is to introduce steel water bottles at a nominal fee, he pointed out. "The aim is to make the beaches plastic-free. As for toilet facilities, DTPC will be holding talks with the Kochi corporation to get the toilets at the parks under the civic bodies opened for tourists' use.

Also, under the green practices, steps will be taken to develop a digital platform or a mobile app that will help tourists get all details on destinations, including facilities available. The aim is to make the destinations flyer-free," Lijo said.

Orissa HC directs government to amend VRS rules to prevent 'exit without restraint'

CUTTACK. The Orissa High Court has directed the state government to amend within three months the provisions on voluntary retirement in the Odisha Civil Services (Pension) Rules, 1992, while endorsing rejection of application of Dr Snigdha Prava Mishra, a professor in Physiology, for voluntary retirement from service (VRS).

While dismissing Dr Mishra's petition recently, Justice SK Panigrahi noted that across states like Uttar Pradesh, West Bengal, Tamil Nadu, governments have codified the power to reject voluntary retirement when the withdrawal of service threatens the well-being of the public.

Yet in Odisha, the OCS (Pension) Rules, 1992 remain silent where they ought to speak. They lack the safeguard that other states have rightly recognised, that a profession whose absence imperils life itself cannot be surrendered at will. The law, in its present form, leaves an opening, a path unguarded, through which a public servant, however essential his role, may exit without restraint," Justice Panigrahi

BHUBANESWAR. The department of Social Security and Empowerment of Persons with Disabilities on Tuesday asked Khurda collector Chanchal Rana to allocate a 40 acre land in Bhubaneswar for establishment of the Santa Kabi Bhima Bhoi State University for Visually

It would be the first university for the visually-challenged in the state and a oneof-its-kind in the country. Director of the department Niyati Pattnaik said the single patch of land will be used for construction of the university building and other related infrastructure. The university will have residential facilities for the students and an advanced digital lab on the campus.

Sources said the decision on setting up the university for visually impaired students was taken by the



department in August last year and it had sent the proposal to Chief Minister Mohan Charan Majhi

Vigilance registers case into alleged backdoor recruitment at coop bank

In its preliminary investigation, VACB uncovered malpractices in preparing the question paper.

KOCHI. The Vigilance and Anti-Corruption Bureau (VACB) has launched an investigation into alleged exam manipulation and backdoor recruitment at Marampally Service Cooperative Bank, in Ernakulam district.

VACB central range, Ernakulam VACB uncovered malpractices in registered a case against Fathima T K, secretary of the bank, Geetha C, of Aluva, who was tasked with preparing the question papers for the recruitment exam, and

Saneesh, of Parakkadavu,

who assisted Geetha. According to VACB officers, a written examination was conducted for the posts of three peons, one salesman and a night watchman at the bank in February 2024. Around 50 persons took the exam. "Following the examination, six candidates, who officials claimed had scored the highest marks, were recruited to the permanent posts. However, other people alleged severe malpractices in

the evaluation process. They approached the Kerala High Court seeking a probe. A petition was filed with VACB to investigate the appointments," an officer said.

In its preliminary investigation,

converted land. The problem arises when someone buys that particular land. It is alleged that revenue officials refuse to complete the mutation process unless the word 'converted' is inserted in all places in the deed where the phrase 'dry land' is written.

With the revenue department having made all services digital, only one option is available for the applicant while applying for mutation online - whether the land is

When a person wants to change the pattern of their land, they should submit an application to the revenue divisional officer (RDO) for land pattern conversion in each district. It is then handed over to the village offices concerned. The village officer would then inspect the land

sketch of the land to the RDO. The RDO would take a final decision on the basis of this report.

To prevent land conversion, the Left government had introduced the Kerala Conservation of Paddy-Land and Wetland Act, 2008. However, to help the homeless poor, the government has allowed conversion of land up to five cents in urban areas and up to 10 cents in panchayats. To

KOCHI. A migrant woman from Bihar, visibly distressed, rushed into the Aluva East police station about 8pm on February 15. Instead of approaching the help desk, she went straight into the cabin of Station House Officer M M Manjudas.

Struggling to introduce herself, she managed to convey that her one-month-old baby had been abducted by two fellow migrant workers while she was preparing to return to her hometown. She had little information about the kidnappers beyond a few identification marks. They had demanded Rs 70,000 over a phone call for the child's release.

Noting the urgency, the officers on duty, led by Manjudas, sprang into action. "We bypassed the usual formalities," says an officer. After reassuring the woman, the officers showed her the images from the crime gallery at the police station. Meanwhile, the police cyber cell started tracking the phone number used for the ransom demand.

The woman recognised one of the suspects Rinki, 20, a transgender person from Assam residing in a rented house in Aluva. Manjudas alerted Aluva DySP T R Rajesh and Ernakulam district police chief Vaibhav Saxena about initiating a rescue operation.

Acting on the gathered details, a police squad reached Rinki's residence. It was vacant. Suspecting that Rinki and her accomplice, Rashidul Haq, 29, from Nagaon, Assam, had already fled with the infant, the district



police chief ordered an extensive search operation, involving the review of multiple CCTV footages and checks at railway stations, bus stands, airports, and road

How kumbh came to NCR with 'pool dubki'

Noida. Crores of people went to Mahakumbh, crores more missed out or stayed away. Many felt the yearning, but the prospect of crowded journeys and a packed Sangam was too daunting. But what if Sangam came to them? At several housing societies in NCR, it did in a symbolic way, showing how faith bridges gaps that reality can't.By Wednesday, when Mahakumbh ended with the final 'Shahi Snan' at the Sangam, many who could not make it were thankful for the 'holy dips' they could take in swimming pools of their housing societies. These were no regular dives. The 'dubkis' were organised after a symbolic purification and consecration of the pools by sprinkling Sangam water, which was brought back in jars and cans by those who did make it to Prayagraj. And thus were the pools transformed, bringing Kumbh to societies and solace to many who could not make the journey."At this age, what more could I ask for than to take this dip just below our flats?" said JC Sharma (79), a resident of Mahagun Moderne in Noida who has been to five Kumbhs but could not make a sixth. The 'holy dip' was organised at the society on Feb 2 and 3,



said AOA member YP Gupta. He said more than 500 residents participated in it. One of them was Rahul Goel, a chartered accountant who could not go to Prayagraj because he did not get leave. "So when the holy dip was organised in our society's swimming pool, we participated. My children were also there. Since the pool was not functional because of winter, we filled it and then poured in 10 litres of Triveni Sangam water," he explained. A similar dip was organised last Monday at Shipra Suncity in Ghaziabad, complete with rituals. Pooja Kapoor (49) said Sangam water was brought by fellow society residents who had been to the Kumbh.

"It turned out to be such a wonderful experience," said Pooja, who has a physical disability due to which she thought she would never have been able to take a Kumbh dip and was full of gratitude for those who made it possible. Sanjay Kumar, the councillor for Ward 100 (Shipra Suncity) told TOI the "holy water was specially arranged for approximately 50 handicapped residents of Shipra Suncity as well as senior citizens, and for children who couldn't travel to Prayagraj due to their ongoing exams"."By Tuesday afternoon, 622 residents participated in the holy dip. More than 2,000 residents travelled to Prayagraj in three buses arranged by us. We had 415 litres of Triveni Sangam water that they brought back with them," he said.

At Sector 122 in Noida, a group of 11 senior citizens from an RWA arranged for Sangam water to be brought to a pond that was dug for Chhath Puja. The dip was organised from Feb 12 to 14 after a tanker brought 1,000 litres of water from Sangam. "We were discussing how many of us are unable to travel to Prayagraj when this idea came to us. It was not just senior citizens, but for everyone who could not go because of work or other reasons," said Umesh Sharma (80), who heads the RWA.Dips were also organised in societies such as ATS Pristine in Sector 150, Cherry County in Greater Noida and several others across Noida and **Ghaziabad**

In the suspected case of a suicide pact, police have received counter complaints – one each by the families of the two youngsters whose bodies were found with bullet wounds in a hotel room on Monday.Nikhil (23), an ITI diploma holder from Pataudi, and Komal (20), an undergraduate student from Kherki Daula, had checked into room 303 at Haveli Hotel along NH-8 in Manesar on Monday morning.By night, Komal's family had reached the hotel while searching for her and called in cops to open the room's door. Police broke open the door and found the bodies, lying side by side and covered with a blanket up to their chest. According to initial investigation, police had said it appeared that the youngsters were in a relationship and made a suicide pact after Komal's marriage was fixed with another man by her family. Komal's cousin Sunil on Tuesday night filed a complaint, alleging that Nikhil killed her. By Wednesday, Nikhil's brother Chanchal filed a counter complaint and accused Komal's family of killing both the youngsters."My brother Nikhil left home on Feb 24 morning to work at a private company in Manesar. As he did not return home till late, we thought he stayed back at the company for a night shift. Around 4am on Feb 25, we were informed by police that he and a woman, Komal, were found shot dead in a Manesar hotel," Chanchal said.

He said in his complaint to police, "After visiting the hotel, we think that my brother and Komal were shot by her family members. Please verify CCTV footage from the hotel and initiate appropriate legal action against the accused."So far, there are no indications of murder in the probe. Police said Komal's postmortem examination was carried out on Wednesday, and no injuries other than the bullet wound were found. Nikhil's autopsy will be conducted on Thursday."The bullet hit Komal's chest on the left and was lodged on the right side. It was retrieved. There were no other injuries on her body. Supreme Court, for now, blocks order for Trump administration to release billions in US foreign aid

WASHINGTON. The Supreme Court on Wednesday temporarily blocked a judge's order giving the Trump administration a midnight deadline to release billions of dollars in U.S. foreign aid.

Chief Justice John Roberts said the order issued by U.S.District Judge Amir H.Ali will remain on hold until the high court has a chance to weigh in more fully. Ali had ordered the federal government to comply with his decision temporarily blocking a freeze on foreign aid, ruling in a lawsuit filed by nonprofit groups and businesses.

An appellate panel refused the administration's request to intervene. The federal government froze foreign assistance after an executive order from President Donald Trump targeting what he called wasteful programs that do not correspond to his foreign policy

The district bills itself as a site for immersive art installations, including Meow Wolf. Organizers say the jet, which was gutted after its Burning Man days in the Black Rock Desert of northwestern Nevada, will be transformed into an event and nightlife venue at AREA15. We just really want to celebrate the arts community and find immersive and experiential ways (to enjoy art)," said Pearl Verzosa, the district's marketing director. "We are open for everybody. We want families, friends, partners just to have a really good time here. And I think that the airplane will be one of those really special places."

Mysterious 'crying disease' kills over 50 in Congo: What we know so far

world. Unidentified illnesses have killed more than 50 people in north-western Congo's Equateur province over the past five weeks, with nearly half of the victims dying within hours of falling ill. Notably, 'crying' is also one of the symptoms reported by

Health officials report 419 cases and 53 deaths since the outbreaks began on January 21 in two remote villages separated by over 120 miles.

Authorities are still investigating the cause of the diseases and whether the cases in the two villages—Boloko and Bomate—are linked. It is still unclear how the diseases are spreading, including whether human transmission is involved.

Outbreak details

The first outbreak was recorded in Boloko, where three children died within 48 hours after eating a bat. In Bomate, more than 400 people have fallen ill, with malaria identified in some patients.

However, no connection has been established between the outbreaks in the two villages, according to the World Health Organization (WHO).

Dr Serge Ngalebato, medical director of Bikoro Hospital and a member of the government response team, noted differences between the two outbreaks. "The first one with a lot of deaths is an unusual situation that we continue to investigate. In the second episode, we see many cases of malaria," he

Symptoms and investigation

Congo's ministry of Health reported that about 80% of patients exhibit symptoms such as fever, chills, body aches, and diarrhoea. Patients experienced symptoms including neck and joint pain, sweating, and shortness of breath. Those under 59 years old reported intense thirst, while children exhibited persistent crying. Initially, concerns were raised about the possibility of a hemorrhagic fever like Ebola, due to the rapid progression from sickness to death. However, Ebola and similar diseases like Marburg have been ruled out after testing more than a dozen samples. The WHO is now investigating other potential causes, including malaria, viral hemorrhagic fever, food or water poisoning, typhoid fever, and meningitis.

Trump administration says it's cutting 90 per cent of USAID foreign aid contracts

President Donald Trump and ally Elon Musk have hit foreign aid harder and faster than almost any other target in their push to cut the size of the federal government.

WASHINGTON: The Trump administration said Wednesday it is eliminating more than 90% of the U.S. Agency for International Development's foreign aid contracts and \$60 billion in overall U.S. assistance around the world, putting numbers on its plans to eliminate the majority of U.S. development and humanitarian help abroad. The cuts detailed by the administration would leave few surviving USAID projects for advocates to try to save in what are ongoing court battles with the administration.The Trump administration outlined its plans in both an internal memo obtained by The Associated Press and filings in one of those federal lawsuits Wednesday. The Supreme Court intervened in that case late Wednesday and temporarily blocked a court order requiring the administration to release billions of dollars in foreign aid by midnight. Wednesday's disclosures also give an idea of the scale of the administration's retreat from U.S. aid and development assistance overseas, and from decades of U.S. policy that foreign aid helps U.S. interests by stabilizing other countries and economies and building alliances. The memo said officials were "clearing significant waste stemming from decades of institutional drift." More changes are planned in how USAID and the State Department deliver foreign assistance, it said. President Donald Trump and ally Elon Musk have hit foreign aid harder and faster than almost any other target in their push to cut the size of the federal government. Both men say USAID projects advance a liberal agenda and are a waste of money. Trump on January 20 ordered what he said would be a 90-day program-by-program review of which foreign assistance programs deserved to

continue, and cut off all foreign assistance funds almost overnight. The funding freeze has stopped thousands of U.S.-funded programs abroad, and the administration and Musk's Department of Government Efficiency teams have pulled the majority of USAID staff off the job through forced leave and firings. In the federal court filings Wednesday, nonprofits owed money on contracts with USAID describe both Trump political appointees and members of Musk's teams terminating USAID's contracts around the world at breakneck speed, without time for any meaningful review, they say."'There are MANY more terminations coming, so please gear up!" a USAID official wrote staff Monday, in an email quoted by lawyers for the nonprofits in the filigs. The nonprofits, among thousands of contractors, owed billions of dollars in payment since the freeze began, called the en masse contract terminations a maneuver to get around complying with the order to lift the funding freeze temporarily. So did a Democratic lawmaker."The administration is brazenly

attempting to blow through Congress and the courts by announcing the completion of their sham 'review' of foreign aid and the immediate termination of thousands of aid programs all over the world," said Connecticut Sen. Chris Murphy, a member of the Senate Foreign Relations Committee.The State Department said Secretary of State Marco Rubio had reviewed the terminations. In all, the Trump administration said it will eliminate 5,800 of 6,200 multiyear USAID contract awards, for a cut of \$54 billion. Another 4,100 of 9,100 State Department grants were being eliminated, for a cut of \$4.4 billion. The State Department memo, which was first reported by the Washington Free Beacon, described the administration as spurred by a federal court order that gave officials until the end of the day Wednesday to lift the Trump administration's monthlong block on foreign aid funding."In response, State and USAID moved rapidly," targeting USAID and State Department foreign aid programs in vast numbers for contract terminations.

What's next for Trump's agenda after House GOP approves tax breaks and slashed spending in US budget

WASHINGTON. Now that House Republicans have passed an ambitious budget blueprint for US President Donald Trump's agenda, it's time for the hard work of turning ideas for \$4.5 trillion in tax cuts and \$2 trillion of slashed spending into a bill that lawmakers warn could bring intense changes to Americans back home.

Republicans are insisting the costs of the tax breaks be partly paid for by the steep reductions in federal government spending as a way to ensure the nation's \$36 trillion debt load doesn't balloon to dangerous levels.But deciding what to cut-health care, food stamps, green energy, government regulations or student aid—is a politically agonizing choice. And it's not just the House that has to agree. GOP senators have their own plans. Their priority is to make the tax cuts permanent, rather than have them expire in a decade, as the House proposed. GOP senators see that as non-negotiable, but it would skyrocket the costs. Eventually, the House and Senate must vote on a final package.

We have a lot of hard work ahead of us," House Speaker Mike Johnson said after

Clip of Gaza as seaside resort posted on Trump's social media

WASHINGTON. US President Donald Trump's official social media accounts posted an apparently AIgenerated video depicting war-ravaged Gaza rebuilt into a seaside resort, replete with a towering golden statue of himself. The video, which racked up more than 15 million views on Instagram and was shared thousands of times on Trump's Truth Social network by Wednesday morning, prompted some commenters to question whether the president's accounts had been hacked. The 33-second clip remained on Trump's accounts without denial or retraction hours after the initial posting on Tuesday night.

The video "Gaza 2025 What's Next?" opens with people on a rubble-strewn street emerging from a tunnel onto a beach with palm trees and yachts. Trump has floated the idea of a US takeover of Gaza under which its Palestinian population would be relocated - a proposal met with global condemnation. He later appeared to soften his plan, saying he was only recommending the idea, and conceding that the leaders of Jordan and Egypt - the proposed destinations for relocated Gazans - had rejected any effort to move Palestinians against

Nigerian drug supplier arrested in Mumbai in Chennai cocaine peddling case



CHENNAI. The Greater Chennai Police on Tuesday arrested a Nigerian man from Mumbai, who was identified as a drug supplier, as part of its ongoing investigation into a cocaine peddling gang.

The anti narcotics intelligence unit (ANIU) arrested Eko Nathaniel Chibuzor from Mumbai and seized 5g of cocaine from him. He was brought to Chennai on a transit remand and sent to a prison here. Two others, V Purushottaman (32) of Urapakkam and A Ramkumar Raju (37) of Greams road were also arrested in the case registered on January 25.

ANIU and the Choolaimedu police, which were involved in the operation, had then arrested 14 people and seized around 60g of cocaine, 1.15 kg of ganja and their mobile phones. Some of them included people who worked in a private restobar and supplied to customers.

Based on interrogation of the accused, other members of the network were tracked which led to the arrest of Mayur Purot, S Waran Grake Kani (28) of Chengalpattu and S Surendran (35) of Thiruvanmiyur four days ago. Information given by them led to the latest arrests, police said.

GHMC Annapurna canteens cry for repairs

HYDERABAD. Most of the Annapurna centres, which serve affordable and hygienic food at Rs 5 to thousands of poor and needy people have become unfit, rusted, and are on the verge of collapse. More than 50% of the centres, built with tin sheds over a decade ago, have corroded and become unfit, requiring immediate repairs or replacement.

GHMC officials told that out of GHMC-run 150 Annapurna centres, eight have been removed due to road widening, and another nine have been relocated due to low turnout. Around 60-65 centres are said to be in good condition, while nearly 65-70 canteens have become rusted and corroded.

The Annapurna Meals Scheme is implemented in about 150 centres, with one centre in each GHMC division, providing around 30,000 meals per day at a cost of Rs 27.63 per meal. On an average, 250 meals per centre are served daily to needy people, with an annual GHMC budget of Rs 25

Officials told TNIE that many Annapurna canteens have rusted and decayed, requiring revival, while those severely damaged will be replaced with new structures. To improve their functioning, GHMC commissioner K Ilambarithi has constituted a committee to inspect the condition and facilities at the existing canteens. GHMC chief engineer Bhaskar Reddy has been appointed as the head of the committee, with additional commissioners Pankaja (Health) and Venugopal Reddy (Advertisement) as members. As per the commissioner's instructions, the committee visited the Annapurna centre at Mint Compound, Lakdikapul, recently.

Telangana police uncover child trafficking racket, arrest couples buying infants illegally

HYDERABAD. A joint investigation by the police and Child Welfare Committee members into a child trafficking case has revealed that childless couples were purchasing infants outright, though they were aware that what they were doing was illegal. The Special Operations Team (SOT) of Malkajgiri, in collaboration with Chaitanyapuri police and Child Welfare Committee members, on Tuesday uncovered a child trafficking case in which prospective parents sought to purchase the infants. The police had arrested the suspects involved in the transportation of the infants illegally from Gujarat to Hyderabad, as well as the couples who tried to purchase

The investigation revealed that some of the accused obtained infants from private individuals rather than through authorised government channels for supplying them to childless couples.

A similar case had been reported in May 2024 at the Medipally police station, where individuals approached the CWC for adoption but turned to illegal means due to delays in the official process. "However, in the case busted on Tuesday by the Chaitanyapuri police, the adopting parents were fully aware that they were taking the

babies illegally," the official disclosed. Police arrested two couples and one individual for purchasing infants illegally at rates of Rs. 1.5 lakh for a baby girl and Rs 2.5 lakh for a baby boy. The investigation identified Vandana as the key suspect. She is alleged to have sent infants from Gujarat to Hyderabad along with Sunitha Suman and Savitri Devi. The babies were then handed over to Kola Krishnaveni, Deepthi, and Sampath Kumar by intermediaries including Sharada, Umarani, Jayasree, Sravan, and Soni

Activists, residents criticise BBMP Chief Commissioner for inaction on illegal construction

Residents have alleged that the BBMP Chief Commissioner Tushar Girinath delayed hearings of an illegally constructed building for 106 days.

BENGALURU. Civic activists and residents have criticised Bruhat Bengaluru Mahanagara Palike (BBMP) Chief Commissioner Tushar Girinath for his alleged inaction against developers constructing illegal buildings across Bengaluru. They accuse him of allowing violators to complete their projects unchecked, despite clear violations of building norms.

One such case has surfaced in Seegehalli, where a building owned by Jayaram Naidu was allegedly constructed without any sanctioned plan or approvals. Activists claim that instead of taking action, BBMP authorities gave Naidu ample time to finish the illegal construction. This is not Naidu's first instance of flouting regulations. According to residents, he has previously built two other unauthorised structures that have received notices from BBMP.

Residents of SS Layout in Seegehalli of Basavanapura Ward in KR Puram, allege that the Chief Commissioner delayed hearings for 106 days, postponing them at least four times, which ultimately enabled Naidu to complete



the construction of his illegal building on Sai Mandir Road.

Violators are required to maintain the status quo and halt construction once a notice is issued. However, in the Mahadevapura BBMP zone, developers seem to operate without any fear of the Commissioner or his orders," said Sandeep Anirudhan, a civic activist, who is also a resident of Mahadevapura zone. "The top official does not seem to be taking any action against negligent officials," he added.

Residents highlight the case of Appeal Number 285/2024, involving the controversial Seegehalli building, where BBMP repeatedly postponed hearingfrom November 30, 2024 to December 7, then from December 21 to February 1, and again from February 15 to March 15. senior official from BBMP's legal department noted that, previously,

citizens had to represent BBMP in court on such matters. However, following a High Court directive, the Chief Commissioner is now responsible for hearing cases and passing final orders.

"One of the main reasons illegal buildings are not razed is the lack of cooperation and support from ward engineers. If the Chief Commissioner suspends five to six ward engineers across different zones, we might finally see some change," the official stated. BBMP has also issued notices to Naidu's other projects in the same locality- Building No 17 and 18, which reportedly has 46 flats, including a penthouse, across six floors, allegedly violating multiple building bylaws.

Water tanker demand in Hyderabad rises 60 per cent as summer begins early

HYDERABAD. With temperatures soaring earlier than expected this year (February, 2025), the demand for water tankers in Hyderabad has already increased by 60% compared to February 2024. As groundwater is depleting, officials anticipate a further surge in demand during the peak summer season from March to

From February 1 to 24, over 1.44 lakh water tankers were booked through Metro Customer Care (MCC), HMWSSB mobile app, IVRS (customer care) and other platforms, compared to 87,700 during the same period last year. The highest number of tanker bookings comes from areas under HMWSSB divisions like Manikonda, Durgam Cheruvu, Kukatpally, S R Nagar, Nizampet, Hafeezpet, Saheb Nagar and others. According to official sources, the Water Board supplies around 545 million gallons of water (MGD) per day with additional water sourced from groundwater reserves. Water consumption usually rises by about 15% during summer. However,

authorities assure that there is no water shortage in Hyderabad as major reservoirs -Osmansagar, Himayatsagar, Manjira, Singur,



Krishna and Godavari — have adequate water storage. Further, the Water Board has taken necessary steps to ensure uninterrupted supply of water.

For this summer, HMWSSB will continue to provide 545 MGD upto ORR. However, certain areas experiencing significant groundwater depletion - Asifnagar, Shaikpet (Division-3), Banjara Hills, Jubilee Hills, SR

Nagar, Fateh Nagar, Erragadda (Division-6), Moosapet, Bhagyanagar, Kukatpally, Hasmathpet (Division-9), Madhapur,

Kondapur, Gachibowli, Ayyappa Society (Division-15), Hydernagar, Budwel, Attapur (Division-16), Miyapur, Chandanagar (Division-17), and Manikonda, Kismathpur, Jalpally (Division-18) - are being closely

To prevent any disruptions in supply, HMWSSB has ramped up its tanker services by deploying additional staff at filling stations, ensuring uninterrupted pumping operations, reducing turnaround time and increasing the

number of tanker trips as needed. There are more than 966 registered tankers under HMWSSB, with the majority having a 5,000 litres capacity followed by 10,000 litres and above. The board has more tankers at its disposal this year compared to last summer, ensuring that most requests are fulfilled within the Service Level Agreement (SLA)

No sanction in law to withhold entire pension: Karnataka High Court

BENGALURU. Ruling that imposing a penalty of withholding 100 per cent pension and gratuity on a permanent basis, based on the advice of the disciplinary authority, has no sanction in law, the Karnataka High Court directed the central government's Ministry of Finance to pay the entire pension that was withheld and full gratuity to a septuagenarian.

Justice M Nagaprasanna passed the order while allowing the petition filed by Hanumanth N Karkun (73) from Dharwad, a cancer patient, against the arbitrary action of the finance ministry. The petitioner was working as superintendent in the officer of the Commissioner of Central Excise, Customs and Service Tax, in Hubballi. He was caught with a certain amount of money which he found on his table in 2011, and faced criminal charges. Later, the case was transferred to CBI which filed a chargesheet in 2013, while the petitioner had retired on January 31, 2012. The inquiry officer exonerated him,

but based on the advice of the Union Public Service Commission, the impugned order of withholding pension and gratuity was passed on February 6, 2023. Against this, Karkun filed an appeal before the Appellate Authority. Meanwhile, he was acquitted of offences charged by the CBI. He moved the high court, owing to his advancing age and the fact that he had been acquitted in the criminal case. Karkun's counsel contended that the penalty is impermissible under Central Civil Services (Pension) Rules, 1972, or even under Central Civil Services (Conduct) Rules, 1964, and the petitioner has no money for his cancer treatment.

Counsel for the ministry submitted that the appeal filed by the petitioner is pending and he should await the outcome of the decision of the Appellate Authority. Rejecting it, the high court said the petitioner is now 73 years old. He has not seen his terminal benefits, despite his retirement 13 years ago, and was left bleeding by the impugned penalty, which is worse than dismissal. There is no question of sending the petitioner back to the doors of the Appellate Authority, the court said.

KSRTC staff dig up dumpyard, revive forgotten pond at Vizhinjam depot

THIRUVANANTHAPURAM. A heap of waste lay near the Vizhinjam KSRTC depot. And the stench was unbearable. It was a place no one paid much attention to, except to park three buses on its hardened surface. Little did the KSRTC employees know that a pond buried for over 35 years under the waste would be a solution to their long-standing water shortage. "It was just a dumping ground for years. Old employees told us there was once a pond here, a place where people used to bathe and where fish thrived. Honestly, we didn't believe it at first," said Satheesh Kumar VO, inspector at the depot.

For over three decades, the pond had been buried beneath layers of mud, waste and discarded scraps. Meanwhile, the depot had been battling a severe water crisis. Drinking water was delivered twice a week, barely enough to quench thirst, let alone clean the fleet of buses or maintain toilets. Attempts to dig a borewell were futile. Situated on a coastal belt and with the Vizhinjam port project nearby, the depot couldn't secure permissions. Ministers were approached, requests were filed, but every route seemed blocked until an offhand comment from a senior employee gave hope.

"They mentioned the pond like it was some myth. But desperation makes you try everything," said K Shibu, Transport Democratic Federation (TDF) representative. With approval from KSRTC and an initial fund of Rs 78,000, excavation began. An excavator rumbled onto the site, clawing at the dirt. Soon, they realised that the heap of waste was just the tip of the iceberg. "We thought we'd clear it in a week. But one load after another, the muck just wouldn't end," said Shajikumar V S, vehicle supervisor.

By the time they reached halfway, the funds had dried up. Work halted. The half-excavated pit stood still and so did their hopes, briefly. The corporation would sanction the fund if water is seen and a report of completion given. Neither of that happened. That's when over 30 depot employees decided to pool in money from their pockets. Another Rs 80,000 was collected and the job was done.

Gas leak sparks scare at city plant; TNPCB says it's only steam, emission within limits

A TNPCB official stated that at 8.45 am, a steam leak was detected in the first economiser of sulphuric acid plant 2 at CIL. The economiser removes excess during the sulphur melting process, by

Main Guard Cross Road, a crucial link between Bowring Hospital Road and Infantry Road in Shivajinagar, has become a major headache for traders and motorists due to the slow progress of whitetopping work by the Bruhat Bengaluru Mahanagara Palike's (BBMP's). The public has complained that work is dragging on at snail's pace, inconveniencing

Traders along the stretch, which also connects Commercial Street and other busy roads, say the dust and rising temperature have further

deterred customers from visiting the area. "Parking is not allowed due to the ongoing white topping work, and increased traffic congestion is making matters worse. Vehicles that were supposed to be diverted to Cubbon Road are also entering Main Guard Cross Road to reach Wheeler Road, Banaswadi and other areas. This has led to a dip in customer footfall," said a shopkeeper at Safina Plaza.

Echoing this, Mayank Rohatgi from Commercial Street Association stated that there is a 20 per cent dip in business, compared to the normal season. "Customers are worried about

getting stuck in traffic, and many decide at the last minute to shop elsewhere instead of coming to Commercial Street," said Rohatgi.

To ensure regular customers and staff are not inconvenienced, a popular jewellery store on the stretch has made alternative arrangements.

For the benefit of customers, alternative route maps have been shared via WhatsApp. We pick up customers and bring them to the shop and offer refreshments. This is done to ensure they are not inconvenienced," said a staffer at the jewellery store.



Europe unsure if US is still an ally

SINCE the end of World War II, America's grand strategy was to ensure that no hostile power arose on either flank of Eurasia. To this end, the US initiated the Marshall Plan and helped rebuild ruined Europe. This, in turn, became an important factor in raising US prosperity in the 1950s and 1960s. It also shaped the North Atlantic Treaty Organisation (NATO) alliance and provided men and material to ensure the security of Europe.

In the east, the US went further in the pursuit of its goal. It fought a war in Korea that cost it over 35,000 lives and another in Vietnam, where it lost over 58,000 soldiers. The US occupied Japan till 1952 and completely remade its society and government in its own image, and it still retains substantial forces in the country at over a dozen bases.American President Donald Trump seems to be wanting to turn this policy inside out. He seems to want to make deals with the Eurasian powers the US targeted — Russia and China — and write off America's erstwhile friends. His pursuit of territorial expansion with regard to Canada, Panama and Denmark looks like a "sphere of influence" policy where the US will be the dominant Western Hemisphere power, while Eurasia will be left to the tender mercies of Vladimir Putin and Xi Jinping. His new posture is manifesting itself in his approach to the war in Ukraine, where he has adopted what can, at best, be termed as a "Russia-leaning neutrality". This is apparent in the stark difference visible in a US draft resolution circulated at the United Nations to mark the third anniversary of the Russian invasion. The draft has mourned the loss of life in the "Russia-Ukraine conflict" and sought "a swift end to the conflict, including by addressing its root causes", while calling for a lasting peace between Ukraine and Russia. This is a rival resolution to the one that Ukraine and Europe have backed, which speaks of Russian aggression and the implementation of past resolutions demanding that the Russians end the war and withdraw from Ukraine's internationally recognised territory.

Trump has adopted a hard approach towards Kyiv. After freezing out Volodymyr Zelenskyy from the first US talks with Russia, Trump falsely accused Ukraine of starting the war that has ravaged that nation and killed thousands of people. When Zelenskyy criticised him for living in a "disinformation bubble", Trump lashed out, calling the Ukrainian President a "dictator". He attacked Ukraine for tricking the US into spending \$350 billion "to fight a war that couldn't be won" And he has demanded a deal through which the US would control half the mineral rights of Ukraine to repay the money that Washington has spent in supporting Kyiv. According to US News & World Report, the US has actually spent around \$100 billion, while the Europeans have put in nearly \$400 billion till now. The Trump plan is based on delivering a systemic shock to Europe and Ukraine to destabilise, if not destroy, the older system where the US was a firm NATO ally and a key backer of Ukraine in its war with Russia. The second objective has been to freeze out Europe and embrace Russia as a partner in making peace in Ukraine, even while blaming it for causing the war. Earlier this month, Trump called Putin and talked to him about ending the war without consulting either Ukraine or its European allies.

As for China, things seem to be moving towards a major trade deal which would take up from where the Phase I trade deal between the US and China in the last year of his previous administration left off. His advisers such as Treasury Secretary Scott Bessent have been pushing a new deal, while his new alter ego, Elon Musk, has extensive business interests in China. Just how deep the shift against Europe is was manifested by the speech of US Vice-President JD Vance at the Munich Security Conference last week. He said free speech and democracy were under attack in Europe, but not from Russia or China, but mainstream political parties that were attacking European right-wing parties like the Alternative for Germany (AfD). It is no coincidence that the Far Right in Europe is soft towards Putin.

How a legal loophole shields marital rape in India

Marriage has evolved from a contractual bond to a partnership of equals, built on mutual respect and consent. Yet, the marital rape exception contradicts this shift, perpetuating abuse and denying women legal recourse.

The Chhattisgarh High Court acquitted a man convicted under Sections 304 (culpable homicide), 375 (rape) and 377 (unnatural sexual offence) of the IPC of the death of his wife. The court ruled that non-consensual sex and unnatural acts within marriage do not constitute offences due to the marital rape exception under Section 375. The court extended this exception to Section 377, relying on the SC's decriminalisation of homosexuality

While the judgment is legally sound, it is disheartening that a woman lost her life after enduring extremely gruesome violations — details of which cannot be reproduced. This resulted in the loss of her honour, dignity and self-esteem, an outcome that sends chills down the spine, leaving a sense that something deeply wrong remains unaddressed.

Marriage has evolved from a contractual bond to a partnership of equals, built on mutual respect and consent. Yet, the marital rape exception contradicts this shift, perpetuating abuse and denying women legal recourse. By presuming perpetual consent, the law disregards modern understandings of dignity, autonomy and human rights. Legalising non-consensual sex within marriage undermines individual freedom and the principle that a wife's bodily autonomy is as vital as that of a husband. Globally, about one in three women have experienced sexual intimate partner violence or nonpartner sexual violence in their lifetime (WHO, 2021). A study has found that sexual violence from intimate partners in women aged 15-49 ranged 6-59 per cent across 10 countries (WHO, 2005).

The National Family Health Surveys (NFHS) and National Crime Records Bureau (NCRB) are primary sources of national-level data on violence against women in India. However, the data includes only reported cases and marital rape is not legally recognised, leading to less than 1 per cent of such cases being reported. Resolving marital rape in India is complex due to cultural norms surrounding marriage and sexuality. Unlike western societies that emphasise individual autonomy, the Indian society tends to be more conservative, with limited open discussion on sexual matters. Women face societal pressure to conform to traditional roles and any deviation is often seen as a threat to the institution of marriage. The concept of consent within marriage is complicated by cultural and moral implications, where, in more conservative areas, men may feel a strong expectation to fulfill their sexual needs within marriage as sex outside of it is either unavailable or morally rejected. This can blur the line between entitlement and mutual consent.According to a study by Deosthali et al, which analyses data, a 2010 survey found that one in five men reported forcing their wives into sex. In rural Karnataka, 36 per cent women agreed that husbands might force sex even if their wives refused. A Chennai study found 31 per cent women reported sexual violence by husbands while a survey in UP found 32 per cent husbands admitted to

The NFHS (2019-2020) shows that 29 per cent married women have experienced physical or sexual violence from their husbands. Studies also highlight high rates of sexual violence during pregnancy, with 40 per cent



women reporting violence during experiencing sexual violence. These figures likely underreport the prevalence of marital rape due to stigma. Marital rape leads to severe physical, sexual, reproductive and psychological health issues for women. Research shows that abusive husbands are more likely to engage in extramarital sex, have sexually transmitted infections and expose their spouses to increased health risks. Sexual violence is linked to stillbirths, pelvic inflammatory diseases, limited access to prenatal care and even suicide attempts by women. These findings raise serious questions about the cost women have to pay to 'save" the institution of marriage, often cited as a reason to exempt marital rape. Sweden criminalised marital rape in 1965, leading to a rise in reported cases and public awareness.

A 2013 study by the Swedish National Council for Crime Prevention showed that this legal change, coupled with public education on consent, helped women identify nonconsensual sex as rape. It also empowered women to seek help from authorities and support organisations, redefining marriage as a partnership based on equality and mutual respect, which fostered broader social changes. The criminalisation of marital rape has brought about significant shifts in societal attitudes and increased reporting. In the UK (1991), it empowered women to recognise marital rape as an abuse of power, leading to higher reporting rates (Kelly & Gavey, 2001). In the US (1993), legal reforms raised awareness, reduced tolerance and underscored a woman's right to refuse sex in marriage (Journal of Interpersonal Violence, 2005). In Australia (1981), it resulted in higher reporting and

prosecution, with a shift in societal views from seeing forced sex as a private matter to acknowledging it as a violation of personal rights (Australian Institute of Criminology, 2008).

Though initially met with opposition, these legal changes gradually fostered greater recognition of women's rights and helped instill more progressive values in society.


The Justice Verma Committee (2013), the 2014 Special Rapporteur on Violence Against Women, and the Pam Rajput Committee (2015) recommended criminalising marital rape, saying that marriage does not imply consent. While international law recognises marital rape, 36 countries, including India, do not. Its criminalisation would ensure proper law enforcement response, survivor support and alignment with global human rights norms.

Recognising and criminalising marital rape in India faces challenges like cultural resistance, potential misuse, inadequate support systems, judicial burden and marital tensions. While legal recognition is vital, a holistic approach is equally crucial — encompassing comprehensive sex education, stronger marriage counselling, legal literacy, victim support, gender sensitisation, open discussions on consent, community interventions and reinforced legal protections. A multifaceted strategy combining education, legal reform and societal support is essential for lasting change.

Even the Mahabharata, despite its narratives of wronged women, upholds an undeniable truth in the Anushasana Parva (The Book of Precepts): "The righteousness of men depends upon women." A society that denies women dignity and autonomy imperils its own moral foundation.

When citizens are fighting to save trees and restore degraded landscapes, the government's financial recklessness is nothing short of betrayal. Uttarakhand must act decisively -

before its rivers dry up, its forests vanish and its green cover becomes just another forgotten policy promise.

ISN'T it absurd that we can't think of anything beyond a set of technical solutions - say, the installation of Instead of arousing the learner's curiosity or activating 'suicide proofing' fans in hostel rooms, or nets in balconies and lobbies - to the recurring problem of suicides or the abrupt end of the life-journey of broken/shattered/ disillusioned young students in Kota, which is a site of the demonic coaching industry?

Well, in recent times, the business of the Kota coaching industry has somewhat declined because of the 'bad' name it got as newspapers began to report regularly about the pathetic mental health of young aspirants. In fact, the number of students in Kota is falling and, as a report reveals, the annual revenue of this business enterprise has been reduced to Rs 3,500 crore from

Rs 7,000 crore. However, nothing seems to have changed as far as the agony of young minds is concerned. In this year only, seven students have ended their lives by suicide and sought to convey the message that they could not bear the pressure and fulfil the parental aspirations for 'good' careers/lucrative salary packages.

It is sad that we are not yet ready to think of a meaningful solution to this sort of suicide beyond the parameters of the typical 'law and order' discourse or even a set of routine 'counselling sessions'. In fact, it is high time some of us began to raise certain critical issues we seldom talk about. In this context, as a teacher and concerned citizen, let me make four observations. First, what has severely damaged the intellectual/ psychic growth of our children is the faulty pattern of education that has attached almost one-sided importance to one's performance in standardised tests, like the JEE, NEET and CUET. It has systematically devalued what really matters for the intellectual, aesthetic and moral development of the child.

And, I have no hesitation in saying that these standardised tests destroy the joy of learning and kill the ecstasy of a creatively nuanced critical pedagogy.

his/her ability to think, interpret, contemplate and go deeper into the exciting domain of sciences and humanities, these problematic MCO-centric tests transform him/her into a 'war strategist', continually And, it is not a mistake on the part of your child if she/he mastering the 'technique' of identifying the 'one and only one correct answer' - instantly and mechanically.

Second, in addition to the obsession with standardised tests, we are witnessing another disturbing phenomenon - the growth of 'dummy schools'. As these schools have a setting with coaching centres, young students need not attend regular classes and take part in the dynamics of school culture. Instead, they do what coaching centres dictate - say, the act of mastering the 'success manuals' or all sorts of strategies for cracking such tests as the JEE and NEET.Be it physics or mathematics, biology or chemistry, everything is reduced to an MCQ question. No wonder, the formative years of these youngsters are spent in an environment that promotes endless drilling, mental fatigue and hyper-competitiveness and the chronic fear of failure.It destroys the joy of learning, or the art exploring the domains of science, culture and aesthetics holistically, creatively and mindfully.

No wonder, they miss what a comprehensive school culture provides - say, a life-long relationship with good teachers, a spirit of fellow feeling and the joy of music, theatre, sports and other 'non-utilitarian' creative pursuits.

Third, it is equally important on the part of the parents to accept a set of fundamental facts about their children's unique aptitudes, inclinations, capabilities and mental

orientations. For instance, there is no harm if your child is not particularly inclined to science and mathematics. Likewise, it is possible for a child to have deep interests in the so-called 'soft' domains - say, music, literature, aesthetics, theatre or social work.

needs some breathing space for exploring and



understanding what she/he really wishes to do in life. However, as the anxiety-ridden middle class parents abhor any 'risk', they want their kids to follow what is seen as the standardised path towards a 'secure' career.

So, these youngsters, irrespective of their inclinations and capabilities, are compelled to nurture the same ambition that is seen as 'acceptable': the desire to become a software engineer or a doctor. Quite often, it becomes exceedingly difficult for them to bear the resultant

psychic pressure and fulfil the unnatural parental ambitions. No wonder, it is now common to find a suicide note like this: "I am the worst daughter. Sorry mummy, papa. Yahi lasts option hai."

And finally, let us accept that the routinised acts like pariksha pe charcha or a set of counselling sessions fail to address the real issueThe fact is that these youngsters

are suffering because we live in an overpopulated society of perpetual scarcity.Moreover, because ofthe neoliberal/market-driven doctrine of hyper-competitiveness and the resultant logic of the 'survival of the fittest', the commodification of almost every aspect of life seems to have become normal. As education is increasingly commodified and marketed, it loses its libertarian potential. Nobody joins the coaching industry to think critically or activate the faculties that make us truly humane, compassionate and sensitive.

ikewise, these days, the worth of being educated is measured primarily in terms of "placement and salary package." And this reckless pressure to emerge as a saleable commodity or a "resource" that the market needs to use tends to cripple

one from deep inside. Alienation or chronic nervousness is the price of 'success'. Indeed, as the latest National Crime Records Bureau data suggests, with 13,044 student suicides in a year, an "epidemic is sweeping

When will we wake up, initiate a movement for structural and cultural transformation and give a life-affirming vision of education and vocation to our children?







New Delhi. Maharashtra Deputy Chief Minister Ajit Pawar on Wednesday said the Pune rape case accused deserves nothing but the death

penalty. He said he has directed the Pune police commissioner to investigate the alleged rape of a woman inside a stationary state transport bus at the Swargate depot and swiftly arrest the The accused, who is on the run, used a mask to hide his identity after the crime. The Pune Crime

Branch has deployed 13 teams along with a dog squad to arrest the accused. Additionally, a bounty of Rs 1 lakh has been announced by the police for anyone providing information about the accused.

A 26-year-old woman was allegedly raped inside a stationary state transport bus at the Swargate depot in Pune on Tuesday morning. The accused, identified as 36-year-old Dattatraya Ramdas Gade, was out on bail for a previous criminal case. Gade is a history-sheeter with several criminal cases registered against him at Shirur, Shikrapur, and Swargate police stations. The accused is currently on the run.

Ajit Pawar instructed the Pune Police Commissioner to investigate the incident thoroughly and arrest the accused at the earliest.

'The incident of rape at the Swargate bus station is extremely unfortunate, painful, infuriating, and shameful to all in civilised society. The crime committed by the accused is unforgivable, and there can be no other punishment for him than death. I have directed the Pune police commissioner to personally look into this matter and arrest the accused immediately," Pawar said.

Pawar said that the Maharashtra Chief Minister has also taken note of the incident and given necessary instructions to the police.

'Instructions have been given to the Minister of Women and Child Development and the Chairperson of the State Women's Commission to provide justice, psychological support, and all possible assistance to the victim," he added. PUNE RAPE CASE

The incident happened when the woman was waiting for a bus for Phaltan in adjoining Satara district at one of the platforms at around 5.45 am. According to the woman, as she was waiting for the bus, a man approached and engaged her in conversation, calling her 'didi' (sister), and said

Army cracks down on exsoldiers tarnishing its image on social media

New Delhi. The Army has initiated strict action against former soldiers who are allegedly spreading misinformation and damaging the army's reputation on social media. According to sources, Army headquarters has instructed all commands to actively monitor social media platforms and file FIRs against any ex-serviceman found engaging in such activities.

FIR REGISTERED IN JAIPUR, MORE UNDER RADAR

In a recent development, an FIR has been registered in Jaipur against a former soldier accused of repeatedly making allegations against the army and its functioning through a YouTube channel.

Sources suggest that several other ex-servicemen across different cities are also under the army's radar for similar activities. Some of these individuals reportedly include those who were dismissed from service due to indiscipline.

ARMY'S STRATEGY, IDENTIFYING AND PROSECUTING OFFENDERS

To counter this issue, the Army headquarters has ordered all its commands to continuously monitor social media, track individuals involved in spreading false narratives, and take legal action against them.

Commands have been directed to gather detailed information on such ex-servicemen, establish their identities, and file FIRs under relevant sections. Army Headquarters will actively follow up on these

As AAP firefights BJP in Delhi, where is Arvind Kejriwal?

Since the AAP's debacle in the Delhi Assembly polls, party chief Arvind Kejriwal has been conspicuous by his absence and has not been seen at any public events. Kejriwal, who was defeated by the BJP's Parvesh Verma in New Delhi, was last seen publicly on February 23 at the AAP legislative party meeting where Atishi was announced as the leader of the opposition.

Kejriwal's sudden disappearance has generated curiosity about his next move, with speculation gaining ground that he might enter the Rajva Sabha from Punjab. The buzz started after the AAP announced that its Rajya Sabha MP Sanjeev Arora would contest the Ludhiana West bypoll. The Congress and the BJP were quick to point out that the move was to pave the way for Kejriwal's Rajya Sabha seat. The AAP immediately denied the speculation with a one-line statement. The party also scotched rumours about him becoming the Punjab Chief

Interestingly, Kejriwal has remained silent even after the suspension of 21 AAP MLAs from the Assembly amid an uproar over the tabling of the CAG report on Delhi's controversial liquor policy. WHERE IS ARVIND KEJRIWAL?

Top sources said Kejriwal was preparing for the upcoming Assembly elections where the party has strong roots, particularly Punjab, which is the only state under the AAP. The idea of contesting polls in other states with INDIA bloc partners is now in cold storage as the AAP is not eyeing entering the fray in

Bihar. Elections are due in Bihar in November. For now, the focus of Kejriwal is to win the Ludhiana West bypoll and subsequently prepare for the 2027 Punjab Assembly election. Sources said Kejriwal's daily routine involves regular meetings with party leaders with key roles in Punjab. The AAP chief is also taking feedback from ground-level workers in the state. A number of meetings were held recently at Kejriwal's residence with Punjab leaders and the incharge of the state. Taking a cue from the Delhi debacle, where AAP lost power to the BJP after a decade, the party's core focus is now on organisational strength and governance model. Former Delhi deputy chief minister and senior leader Manish Sisodia has been frequently visiting schools in Punjab. The Punjab government has decided to expedite the reform of government schools and the entire education sector on the basis of AAP's 'Delhi model'.

After Anindita's story was highlighted by the media, her doctor Biju Singh started receiving cases every month. This growingdemand for IVF was corroborated by gynaecologist Dr Gautam Khastgir, "People from all strata of society are coming in for IVF, especially after knowing that it is an easy procedure. Society, too, has accepted it whole-heartedly. I get approximately two patients every month," he said. Dr Khastgir said most of his patients were women who hadn't found the right man yet or wanted a child after divorce or lesbian couples desiring babies.

Government employee Kalidasi Halder, 55, who had a daughter through IVF last December, said, "I am unmarried, but wanted to become a mother. Though I dilly-dallied for two-three years fearing societal reactions, after giving birth, I realized that there were two types of people - those who looked away, and those who welcomed us with open arms. My colleagues not only took me to the hospital, but also got me discharged and looked after us. Yes, support was less, but it wasn't non-existent."

"I think it's very important for girls to be financially independent to take such a step," Kalidasi added. City schools, too, are equally open to accepting children of single mothers. Ranu Biswas, headmistress of the primary section of Bharatiya Vidya Bhavan, said, "We still haven't received any application for admission of a child of a single mother.

But if I do, such children would be treated on a par with other students."Sunita Sen, principal of The BSS School, added, "We welcome children of single parents. A child is a child, whether he has one parent or both. Our only concern is quality parenthood - whether the mother can give the child proper attention."

22,548 in the previous session, with the overall trend remaining bearish. The key support and resistance levels for the index stand at 22,400 and 22,720, respectively. BankNifty is also moving within a defined range of 48,450-48,840.

Gaggar pointed out that FMCG stocks are approaching a crucial support zone, which could provide a buying opportunity if the support holds. However, the IT and Metal sectors are expected to remain under selling pressure.

'On the stock front, certain NBFC stocks, particularly Bajaj Finance, Bajaj Finsery, and Cholamandalam Holdings, are showing strong technical strength and could see further upside in the near term," he added. Vishnu Kant Upadhyay, AVP –

Research & Advisory at Master Capital Services, said the stock has broken out of a downward-sloping consolidation pattern, signalling renewed bullish momentum. He explained that the stock is



trading above both the 21-day and 200day exponential moving averages (EMA), which reinforces a positive trend. The Relative Strength Index (RSI) at 58.61 is moving higher, indicating increasing

strength in the uptrend. Additionally, the Moving Average Convergence Divergence (MACD) has given a bullish crossover, further confirming the upward

movement. Upadhyay said that Cholamandalam Finance Holdings has the potential to reach Rs 1,698 and then Rs 1,720 in the near term, while Rs 1,476 remains a key support level. He recommended buying at the current levels, with dips providing opportunities for additional accumulation.

5 PSU banks may see government stake sale of up to 20%: Report

New Delhi. The government is planning to sell up to 20% of its stake in five public sector banks (PSBs) over the next four years, according to a report by Business Standard. The stake sale in public banks is aimed at meeting the Securities and Exchange Board of India's (Sebi) minimum public shareholding norms, which require listed companies to have at least 25% of their shares held by the public.

A senior government official quoted in the report said that the government is working on a plan in consultation with the Department of Investment and Public Asset Management (DIPAM), the Department of Financial Services (DFS), and state-run banks."This will be done to comply with the Securities and Exchange Board of India's (Sebi's) minimum public-shareholding norms. While market conditions will be considered, the government plans to use both the offer for sale (OFS) and qualified



institutional placement (QIP) routes," said a senior govt official as quoted by Business Standard. The five banks where the government is looking to reduce its shareholding are Bank of Maharashtra, Indian Overseas Bank, UCO Bank, Central Bank of India, and Punjab and Sind Bank. In each of these banks, the government's stake will be

brought down to below 75% in a phased manner.On February 25, it was also reported that DIPAM had invited bids from merchant bankers to assist with the stake sale in public sector banks and other listed public financial institutions. The Request for Proposal (RFP) issued by DIPAM states that the selected merchant bankers will be empanelled for three years, with the option of extending their term for an additional year. These bankers will

provide guidance on the timing and structure of the government's equity dilution in these banks and financial

Best place to invest: Why is World Bank bullish on India despite FII sell-off

New Delhi. Dalal Street has been jittery and has seen a nearly 12% correction since it peaked at an all-time high in September last year. The major reason has been the FIIs selling stocks, leading to dampening market investment, but the World Bank thinks the move might not be the right one.

The World Bank has said that India remains the best place to invest, even as foreign institutional investors (FIIs) continue to pull money out of the stock market. World Bank Country Director Auguste Tano Kouame, while speaking at the Advantage Assam 2.0 Business Summit, dismissed concerns over the recent market downturn and reaffirmed confidence in India's growth."We are not worried about India's growth at the moment. We are very bullish about India and will remain bullish," Kouame said. He urged investors to focus on the bigger picture, adding that India is "the shining light in the world" and a prime destination for investment. The statement comes at a time when the Indian stock market has been under pressure due to heavy selling by FIIs. Since October 2024, FIIs have withdrawn nearly Rs 2 lakh crore from the Indian stock market, leading to a decline of over 10% in the Sensex.

Midcap and smallcap stocks have been hit even harder, with the BSE Midcap index falling 19% and the BSE Smallcap index dropping 21% during the same period. The trend has continued into 2025, with FIIs offloading almost Rs 1 lakh crore worth of shares in just 33 trading sessions until February 14. India is not alone in witnessing these outflows, as several other emerging markets, including Brazil, Indonesia, Malaysia, the Philippines, South Korea, Taiwan, and Vietnam, have also faced similar trends. The only exception has been Thailand, which has attracted \$17 million in FII inflows. Experts believe that the FII sell-off is largely driven by rising bond yields in the US. Higher yields have made American assets more attractive, prompting global investors to shift money away from emerging markets like India. Vipul Bhowar, Senior Director of Listed Investments at Waterfield Advisors, explained that FIIs are choosing the stability of US equities over Indian stocks. Another factor impacting investor sentiment is the slowdown in corporate sales growth. In the December 2024 quarter, the combined gross sales of Nifty50 companies grew by 6.6% year-on-year, down from 9.2% in the same quarter the previous year. This slowdown has made investors more cautious about Indian stocks.Despite these challenges, India's broader economic fundamentals remain strong. However, analysts warn that external risks could continue to affect market sentiment. Shrikant Chouhan, Head of Equity Research at Kotak Securities, pointed out that concerns such as US tariffs on Indian exports, domestic economic uncertainty, and weak corporate earnings in the third quarter of FY25 have contributed to market volatility.

Dope suspended wrestlers at IIS camp, Dangal raise eyebrows

The camp was organised in Vijayanagar, Karnataka close on the heels of an MoU signed between the United World Wrestling and Inspire Institute of Sport during the 2024 Paris Olympics

CHENNAI. An international camp held for women wrestlers at the Inspire Institute of Sport (IIS) last month and Ĥaryana Dangal organised by the charitable trust on February 19 and 20 have come under the scanner due to participation of athletes serving provisional suspensions for dope violations.

The camp was organised at the IIS, Vijayanagar, Karnataka close on the heels of a Memorandum of Understanding (MoU) signed between the United World Wrestling (UWW) and IIS during the 2024 Paris Olympics last year. "This strategic partnership is designed to foster collaboration and enhance the development of wrestling in India by establishing a

framework for mutually beneficial programs, projects, and activities," said an UWW statement soon after the signing of the MoU.Incidentally, an exposure trip to Italy was also planned for a few men and women wrestlers by the IIS after the completion of the camp. One of the selected wrestlers for the trip too was provisionally suspended by the World Anti Doping Agency (for SARMS) after prohibited substances were found in his sample taken during an international tournament in July 2023.

The trip, however, is unlikely to go ahead with chances of selection trials for the Asian Championships next month. Besides, the Italy Federation has enquired its Indian counterpart (Wrestling Federation of India) about the trip and the latter has clarified that it is not part of the plan and the list contains a provisionally suspended wrestler."I cannot comment on the issue," was the response from an IIS official when queried about the participation of a provisionally suspended wrestler in the camp. He, however, said the tour may not go ahead due to the proposed selection trials. Meanwhile, Siyanand, head of IIS, Hisar, who was also the tournament director at the Haryana Dangal, accepted the woman wrestler had participated in the camp. "She has been provisionally suspended, that's why she was allowed in the camp. Again that's what my opinion is as only higher officials at the IIS can talk about this elaborately," Siyanand told this daily. Speaking on suspended wrestlers



competing in the Dangal including the above-mentioned woman wrestler, he said, "The said woman wrestler was disqualified ahead of her bouts. We spoke to the National Anti Doping Agency and once we got confirmation from it then we didn't allow her to participate." Interestingly, quite a few suspended wrestlers competed at the tournament with a few of them winning a bout or two. "We prevented a few from competing but as we didn't have any comprehensive list of suspended wrestlers, there is a possibility that a few might have director. The competition was held at the Haryana Agriculture University, Giri Centre, Shahid Madan Lal Dhingra Multipurpose Hall in Hisar. Each participant was charged Rs 1000 as entry fee for the tournament, which was held in four weight categories in each style (men's freestyle and Greco-Roman and women's wrestling). Interestingly, a couple of coaches from the Sports Authority of India (SAI) also assisted the tournament director for the competition. The winners (gold, silver and bronze medallists) were also given cash prizes apart from the medals.

WFI source said the Italy federation mailed it seeking information on the proposed tour. "The WFI was not kept in the loop before organising the camp and holding the tournament. The federation told its Italian counterpart the same and also informed it about the presence of a suspended wrestler in the list. As far as the tournament is concerned, the guidelines clearly say the competition will be held according to the WFI and UWW Rules and Regulations but the same were not followed. How wrestlers serving suspension or provisional suspension can be allowed to compete," said
