Pushback from South on Hindi, delimitation grows

New Delhi, Feb 28: Karnataka chief minister Siddaramaiah on Thursday added to the growing clamour around the impending delimitation of Lok Sabha seats while his Tamil Nadu counterpart MK Stalin upped the ante over the emotive issue of Hindi language, fuelling the controversy on two contentious issues that have the potential to widen the chasm between India's northern and southern regions. In a series of posts in Kannada, Siddaramaiah hit back at Union home minister Amit Shah, who had dismissed the row a day ago and said no southern province will suffer a reduction in their parliamentary representation. "The Union home minister Amit Shah's statement that he will not allow injustice to be done to the southern states during the delimitation of constituencies is not credible. It is tainted with malicious intent to create confusion in the southern states," he said on X. His strong comments came just hours after Tamil Nadu chief minister Stalin fired a salvo at the Centre, saying the southern state will not allow the "imposition" of the Hindi language and vowed to protect Tamil and its culture. "We will oppose Hindi imposition. Hindi is the mask, Sanskrit is the hidden face," he said in a series of posts that appeared to refer to a 2017 article on the connection between Hindi and many northern Indian dialects published in Mint

Modi, Von der Leyen set target for concluding India-EU FTA within 2025

New Delhi, Feb 28: Prime Minister Narendra Modi and European Commission President Ursula von der Leyen on Friday threw their weight behind the ambitious goal of finalising an India-EU free trade agreement (FTA) within the year, against the backdrop of geoeconomic churn due to the trade policies of the Donald Trump administration. The two leaders unveiled other measures to intensify cooperation between India and the European Union (EU), ranging from a proposed security and defence partnership and a new space dialogue to closer collaboration on artificial intelligence (AI) and the interoperability of digital public infrastructure. Von der Leyen is in India with 22 members of the 27-strong EU College of Commissioners for the first such visit to a non-European nation since she got a fresh mandate last year, reflecting the desire in Brussels to substantially upgrade ties with

New Delhi. She arrived in India hours after US President Donald Trump said he would hit goods made in the EU with 25% tariffs, exacerbating European concerns about Washington's unpredictable trade policies. "We have directed our teams

to conclude a mutually beneficial bilateral free trade on the momentum in economic ties – two-way trade agreement by the end of this year," Modi told a joint



Hindi. Von der Leyen acknowledged the difficulties associated with finalising the trade deal, negotiations for which began in 2007, were suspended in 2013, and then revived in 2022. The two sides will hold the tenth round of talks in Brussels during March 10-14. She said the two leaders tasked their teams to build in goods was worth 120 billion in 2024 – and "finalise our free trade agreement before the end of this year".

She added: "We are expecting a lot of our trade negotiators, we told them they should surprise us. Now more than ever, the geopolitical context asks for decisive action." Modi said a bilateral blueprint had been prepared for collaborating in trade, investment, technology, green growth, security and mobility of professionals, and the two sides are moving forward on investment protection and geographical indication (GI) agreements. "We have agreed on increasing cooperation in semiconductors, AI, high performance computing and 6G. We have also decided to initiate a space dialogue," he said. The two sides will conduct joint research on EV batteries and green hydrogen, and take concrete steps to drive the India-Middle East-Europe Economic Corridor (IMEC) so that it serves as an "engine of global commerce, sustainable growth and prosperity", he said. While deliv-

ering a speech before her talks with Modi, Von der Leyen said the two sides are exploring a security and defence partnership to jointly counter common threats such as cross-border terrorism, cyber-attacks and attacks on critical infrastructure.

Prashant Kishor's swipe at Nitish Kumar ahead of Bihar elections

New Delhi, Feb 28: Kishor, counting on his party, Jan Suraaj, to leave a mark in the elections, also revealed plans for a rally in April ahead of upcoming polls later this year. Political strategist-turned-activist Prashant Kishor on Thursday predicted that Bihar chief minister Nitish Kumar's Janata Dal (United) would fail to secure even a single seat in the upcoming elections, saying that veteran leader is "physically tired and mentally retired." Prashant Kishor criticised Nitish Kumar's ability to retain power despite shifting political alliances Prashant Kishor criticised Nitish Kumar's ability to retain power despite shifting political alliances The remark comes in the lead-up to the highly anticipated Bihar assembly elections set for later



this year. Prashant Kishor's Jan Suraaj Party is also likely to contest for the first time in these polls. Kishor, banking on Jan Suraaj Party to make a significant impact in the polls, also announced plans for a rally in April, claiming it would "break all records in terms of turnout," news agency PTI reported. Speaking to reporters in Patna, he criticised Nitish Kumar's ability to retain power despite shifting political alliances, saying, "Nitish Kumar has managed to hold on to the seat of power while switching alliances. This enables him to be the CM even if the JD(U) has a small number of seats." Nitish Kumar parted ways with the BJP in 2013, only to return four years later after briefly aligning with the RJD from 2015 to 2017. In 2022, he once again switched sides to join the RJD-led Mahagathbandhan but returned to the NDA last year. Kishor, criticising Nitish's frequent political shifts, urged voters to put an end to the cycle. "To break this cycle, and to ensure that the arrow (JD(U)'s poll symbol) does not float with the lotus (BJP) nor burn bright with the lantern (RJD), I appeal to the people that they vote in a manner that the JD(U) does not win even one seat. Only then would we get rid of the chief minister who is physically tired and mentally retired," he said. The former JD(U) national vice president also accused the BJP of "enjoying power while using Nitish Kumar as a mask" and alleged that Wednesday's cabinet expansion, just six months before the elections, was driven by the intention of "loot of public money and assuaging some estranged castes.

Seven held in Bengaluru for murder of rowdy-sheeter

BENGALURU. Seven people, including two rowdy-sheeters, were arrested for the brutal murder of 38-year-old rowdysheeter Hyder Ali early on Sunday near Garuda Mall, in the Ashoknagar police station limits. An old rivalry is being cited as the reason for the murder.

The arrested have been identified as Nayyaz Pasha alias Naju, who has eight cases against him in Ashoknagar police station; Darshan, Raheed, and Waseem, all residents of Bengaluru; Rizwan, a rowdysheeter from Shivamogga; and Mateen and Saddam, also from Shivamogga.

According to the preliminary investigation, Pasha, the prime accused in the case, hatched a plot with his gang to kill Ali. There had been a long-standing enmity between Pasha and Ali, with both making multiple attempts to kill each other over the years. The investigation also revealed that both had been attacked twice by rival gangs in the past.

Around 1.30 am on February 24, Pasha, along with his gang, executed their plan. They divided themselves into two groups, one which tracked Ali's movements and the other which waited near the football stadium. As Ali was heading home with a friend after a party at a pub on Church Street, a few bikers followed him.

As he neared Garuda Mall, a car intercepted his bike, and the gang pounced on him. They first stabbed him and then brutally assaulted him with lethal weapons, the police said, adding that a special team was formed under the Cubbon Park Sub-Division Assistant Commissioner of Police to investigate the case. The police further said that four accused were detained on Tuesday and questioned, leading to the arrest of three more suspects.

Make family courts childfriendly, says child rights panel

THIRUVANANTHAPURAM. Family courts should be made 'child-friendly' taking into account the huge physical, mental and emotional stress that children accompanying their parents undergo during the hearing of divorce petitions, the state child rights commission has recommended.

The recommendation forms part of a study undertaken by the commission on the problems faced by children of couples undergoing divorce proceedings and the condition of family courts in the state. The study analysed in detail the condition of 120 children between the age of six and 18 whose parents are involved in divorce proceedings in the 35 family courts across the state.

The study report was submitted to Chief Minister Pinarayi Vijayan by commission chairperson K V Manojkumar on Thursday. "While deciding on the custody and protection of children, arguments between parents in front of them put the children under a lot of mental stress. The setting up of child-friendly family courts can address this problem to a large extent," the report

The report has also proposed collection of a specific amount from both parents (petitioners and respondents) for creation of a welfare fund to be utilised for the health. education and other needs of children during the course of hearing of the divorce petition. The District Legal Services Authority (DLSA) should be empowered to utilise the funds for the children's welfare. Such an arrangement assumes special significance in the case of children who face physical or mental challenges.

Lingaraj mishap: Questions raised on use of excess ghee

BHUBANESWAR. Even as the Lingaraj temple administration has decided to examine the circumstances that led to the accidental fall of a servitor while carrying the Mahadeepa atop the shrine during Maha Shivaratri, the Samartha Nijog on Thursday alleged that excess ghee in the ceremonial lamp was the reason behind it.

The seriously injured servitor Yogendra Samarth, in his mid-50s, is under treatment. Yogendra, who has been changing flags and lifting Mahadeepa atop the Lingaraj temple since the last three decades, fell down while climbing the shrine with the holy lamp on Wednesday.

Before carrying the Mahadeepa, he had climbed atop the temple twice to fix the flag during Sahana Mela darshan. This is for the first time such an accident took place during Maha Shivaratri celebration at the 11th century temple.

As per the temple rules, it is the temple administration that provides 200 to 250 ml ghee for the Mahadeepa which is prepared by a Mekap sevayat. Instead of using the amount provided by the temple administration, the sevayat concerned added more ghee donated by servitors as an offering for wish fulfilment.

In the past, Yogendra had sustained severe burn injuries from the hot ghee flowing down the Mahadeepa. We have been requesting the servitors concerned to use only the amount of ghee given by the temple administration but in vain. Yesterday too, Yogendra said that his hand slipped because of ghee," said secretary of Samartha Nijog Prashant Samartha.

He added that the government should think of providing health insurance to servitors who take up sevas of Lord Lingaraj that are risky in nature. The Mekap servitors, however, refuted the allegation.

Builders use 'black magic' to stall BBMP action

Residents claim that builders who constructed illegal sixstorey structures with over 40 tenements without approvals, are responsible for the act.

BENGALURU. In a shocking incident, three bamboo trees were cut in Basavanapura, KR Puram, allegedly as part of a tantrik ritual aimed at obstructing BBMP action against unauthorised constructions.

According to residents, builders who received notices from the (BBMP resorted to occult practices in an attempt to counter complaints against them. Silver and copper foil sheets with engraved notes were wrapped around the base of a tree, before they were chopped from the

Residents claim that builders who constructed illegal six-storey structures with over 40 tenements without approvals, are responsible for the act. "In August 2024, 19 buildings in KR Puram sub-division received demolition notices under Section 356 of BBMPAct.

However, some engineers helped owners secure court stays, which were misused to complete and sell these under-construction flats. With mounting pressure from BBMP officials to take action, builders have resorted to superstitious methods like black magic, including chopping bamboo trees," alleged a Basavanapura resident. The matter was escalated to Mahadevapura BBMP Range Forest Officer Chidanand LB, who confirmed that officials had inspected the site.

The thin silver and copper foil sheets contained inscriptions in Telugu stating, "The bamboo tree on the opposite side has to be cut." Additionally, the sheets bore names such as Reddamma, Jyothsna, Naidu and Devaprasad, along with some text in Urdu and Telugu.

The work appears to have been done in Kalakada Mandala Pileru Assembly, Andhra Pradesh. Some names listed on the sheets belong to people residing in this area. It is now up to the BBMP to investigate and take action against those responsible," said a resident.

Despite residents' opposition, Chennai corporation to go ahead with Kodungaiyur incinerator plant

Around 6,150 tonnes of solid waste is being collected by the Greater Chennai Corporation from Zone 1 to 15.

CHENNAI. Despite opposition from Kodungaiyur residents, the corporation on Thursday adopted a resolution at the council meeting to implement the waste-to-energy incinerator plant in the area.

The project will cover an integrated waste processing facility at Kodungaiyur including the waste to energy incinerator, material recovery facility, Bio-CNG plant, and composting centre and carried out in a DBFOT model.

Around 6,150 tonnes of solid waste is being collected by the Greater Chennai Corporation from Zone 1 to 15. When 90% waste is segregated

and sent for recycling at various solid waste processing facilities in Chennai, the other non-segregated waste is being transported to



the landfill. The GCC plans to use these nonrecyclable and burnable waste for processing of waste to energy plants that turns waste into usable energy, such as heat or electricity. G

Sundarrajan from Poovulagin Nanbargal said, "The GCC's move to install an incinerator despite the opposition is unfair and undemocratic. North Chennai is already polluted and this move will cause significant health issues to the public."During the council meeting, A Theerthy, Ward 22 councillor, also raised safety concerns for the employees at the GCC's Bio-CNG plant at Manali where an employee died in a fire. In response, GCC Commissioner J Kumaragurubaran said the corporation has set up a consultant to inspect and submit a report in a week.

The GCC also adopted a resolution to shut down around 168 micro composting centres and 137 material recovery facilities.

HYDERABAD. With temperatures soaring earlier than expected this year (February, 2025), the demand for water tankers in Hyderabad has already increased by 60% compared to February 2024. As groundwater is depleting, officials anticipate a further

surge in demand during the peak summer season from March to

From February 1 to 24, over 1.44 lakh water tankers were booked through Metro Customer Care (MCC), HMWSSB mobile app, IVRS (customer care) and other platforms, compared to 87,700 during the same period last year. The highest number of tanker bookings comes from areas under HMWSSB divisions like

Manikonda, Durgam Cheruvu, Kukatpally, S R Nagar, Nizampet, Hafeezpet, Saheb Nagar and others.

According to official sources, the Water Board supplies around 545 million gallons of water (MGD) per day with additional water sourced from groundwater reserves. Water consumption usually rises by about 15%

during summer. However, authorities assure that there is no water shortage in Hyderabad as major reservoirs -Osmansagar, Himayatsagar, Manjira, Singur, Krishna and Godavari - have adequate water storage. Further, the



Water Board has taken necessary steps to ensure uninterrupted supply of water. For this summer, HMWSSB will continue to provide 545 MGD upto ORR. However, certain areas experiencing significant groundwater depletion -Asifnagar, Shaikpet (Division-3), Banjara Hills, Jubilee Hills, SR Nagar, Fateh Nagar, Erragadda (Division-6),

Moosapet, Bhagyanagar, Kukatpally, Hasmathpet (Division-9), Madhapur, Kondapur, Gachibowli, Ayyappa Society (Division-15), Hydernagar, Budwel, Attapur (Division-16). Miyapur, Chandanagar (Division-17),

and Manikonda, Kismathpur, Jalpally (Division-18) - are being closely monitored. To prevent any disruptions in

supply, HMWSSB has ramped up its tanker services by deploying additional staff at filling stations, ensuring uninterrupted pumping operations, reducing turnaround time and increasing the number of tanker trips as needed.

There are more than 966 registered tankers under HMWSSB, with the majority having a 5,000 litres capacity followed by 10,000 litres and above. The board has more tankers at its disposal this year compared to last summer, ensuring that most requests are fulfilled within the Service Level Agreement (SLA) timeframe.

Paradiso RWA writes to DTCP, wants company to pay rent for families that vacated flats in Gurgaon

Gurgaon. Homeowners of Chintels Paradiso in Sector 109 have sought urgent intervention of the district town planner (enforcement) to ensure execution of rent payment orders issued by the district administration.In a letter to town planner (enforcement) Amit Madholia, RWA members said the developer has failed to comply with official directives mandating rent payments to displaced residents. President of the association Rakesh Hooda said, "The residents, who vacated their unsafe flats following govt orders, are struggling to manage temporary accommodations without the promised financial support from the builder."Meanwhile, a spokesperson for the developer said, "The welfare of our residents remains our top priority, as they are part of our extended family. In line with the Hon'ble Supreme Court's order, Chintels was directed to pay rent from the start of reconstruction. While construction will take a few more months to begin due to procedural requirements, we have already started rent payments on humanitarian grounds. We are fulfilling our rental commitments to over 140 eligible residents and have settled buyback agreements with around 160 homeowners. Claims from individuals not receiving rent are from those without formal agreements or those with ongoing court cases."arlier, the district administration had issued directions to compensate homeowners of six towers (D, E, F, G, H and J) of the first phase and three towers (A, B, and C) of the second phase.

A total of 41 homeowners — 25 from first phase towers and 16 from second phase towers — have formally chosen Option II (reconstruction) of the compensation plan and submitted requests for rent payments. These appeals were emailed to the builder, with copies marked to the district town planner, deputy commissioner and additional deputy commissioner. However, residents claim the builder has not responded or initiated the payments, pushing them into financial distress. In the letter, RWA urged the district town planner to intervene and ensure compliance. Their demands include authorities to engage with the builder to enforce the directive, all pending payments, including arrears, to be cleared by March 7, 2025 and action if rent payments are not made by the deadline. In Sept 2024, the district administration committee had decided that 130 homeowners of five unsafe towers — D, E, F, G, H will get rent compensation at Rs 15/sqft per month

Earthquake of magnitude 6.1 strikes Nepal, tremors felt in Bihar

world. An earthquake with a magnitude of 6.1 struck Nepal early on Friday, causing tremors felt across the Himalayan region. Tremors were also felt in Patna, Muzaffarpur and nearby areas of Bihar.

The earthquake struck around Bhairab Kunda of the Sindhupalchok district in Nepal at around 2.35 am, according to news agency Reuters. The German Research Centre for Geosciences measured the earthquake at a magnitude of 5.6, while India's National Centre for Seismology estimated it at 5.5. However, it was not immediately clear whether multiple quakes had occurred.A 6.1 magnitude earthquake is considered strong and can cause significant damage, especially near the epicentre, including the shaking of buildings and the formation of cracks. The extent of Friday's seismic activity is yet to be ascertained, and no reports of damage or casualties have been reported so far.

"It shook us from our sleep strongly. We rushed out of home. People have now returned back to homes. We have not received any report of damage or injuries so far," Ganesh Nepali, a senior Nepali official told Reuters.People shared videos online showing buildings and ceiling fans shaking due to the earthquake in Patna. An X user mentioned that the tremors lasted for a "good 35 seconds". "Felt a strong earthquake in Patna, Bihar. Everything was shaking but no visible damage so far," another user, Nikhil Singh, wrote.In January this year, a series of six earthquakes struck Tibet's Himalayan region, with the strongest measuring 7.1 magnitude, claiming

'We don't need to talk': Heated confrontation between Jordan Schultz & Ian Rapoport at NFL combine

UPDATED Jordan Schultz of FOX Sports and Ian Rapoport of NFL Media engaged in a verbal confrontation on Wednesday afternoon at a Starbucks inside the JW Marriott in Indianapolis. Multiple witnesses confirmed the incident that took place during the NFL Scouting Combine.

What Led to the Confrontation?

According to NBCSports, Rapoport was speaking with an agent when Schultz approached him and said, "We need to talk." Rapoport dismissed the request, responding, "We don't need to talk." That response sparked a heated exchange. Witnesses say Schultz accused Rapoport of something unknown, which Rapoport viewed as unfounded. The two then stood face to face as Schultz allegedly said, "If you have anything to say to me, say it to my face," followed by, "If this continues, we're going to have a problem.'

Rapoport asked Schultz to step back, but Schultz reportedly repeated the warning before eventually stepping away.

NFL Security gets involved

The situation was reported to NFL Security, which gathered statements from multiple witnesses. Rapoport declined to comment, but Schultz later acknowledged the confrontation via text to ProFootballTalk (PFT), saying:

'It really isn't anything too much. Ian Rapoport and I had a verbal confrontation. It lasted a little over a minute. Multiple agents and reporters were nearby. Rapoport was the one who called security shortly after, but it never escalated further."Schultz also disputed the number of expletives in the account, later claiming he did not use profanity. The altercation stems from Schultz's report earlier this week that Rams quarterback Matthew Stafford met with Raiders minority owner Tom Brady in Montana. Rapoport later downplayed the report, describing the meeting as a coincidence rather than an intentional recruiting effort. Schultz, however, stood by his reporting.

Tensions between the two reporters are clearly high, so it remains to be seen whether this confrontation is a one-time incident or the beginning of a larger feud. Either way, the exchange added unexpected drama to a business-focused week at the NFL Scouting Combine.

Zelensky, Trump to meet at White House for deal on US access to Ukraine's rare minerals

The extraordinary turnaround caps a week of frantic international

WASHINGTON. A week ago Donald Trump branded Volodymyr Zelensky a dictator. On Friday he will host the Ukrainian president at the White House and sign a deal granting Washington access to Ukraine's rare minerals. The extraordinary turnaround caps a week of frantic international diplomacy centered on Washington, as Kyiv seeks to shore up support despite Trump's recent pivot towards Russia. Trump upended years of US policy on Ukraine two weeks ago when he spoke to Russian President Vladimir Putin and started talks on ending the threeyear-old war-without Kyiv.He also alarmed allies as he appeared to turn on

without elections" and blaming Ukraine for Trump, a billionaire real estate tycoon, Russia's February 2022 invasion.

But Trump's tone has softened in recent days after visits by French President Emmanuel Macron and British Prime Minister Keir Starmer. "I have a lot of respect for him," Trump said of Zelensky on Thursday. 'We're going to get along really well."

Trump also backtracked on the "dictator" broadside he launched on social media at Zelensky last week—a jibe he had previously refused to retract even as he declined to call Putin a dictator too.

'Did I say that? I can't believe I said that," Trump responded when asked about the Zelensky comment by journalists during a meeting with Starmer.

The dictator outburst was sparked in particular by Zelensky's initial rejection of the deal to give Washington preferential access to Ukrainian natural resources, including oil, gas and rare earth metals. Zelensky demanded US security guarantees

as part of any deal but Trump has refused to give any commitments.'Dig, dig, digging'

insisted the deal was necessary for Washington to recoup the billions of



dollars it has given Ukraine in military and other aid. Finally, Zelensky relented and agreed to come to the White House to sign it. The deal would give the United States a share in much of Ukraine's mineral wealth. "We'll be dig, dig, digging" for Ukraine's resources, Trump told reporters Thursday. Few details of the minerals deal have emerged. Zelensky told reporters this week

that it would act as framework for broader deals.Further discussions between US and Ukrainian officials would determine the

nature of security guarantees for Ukraine and the exact sums of money at stake in the accord, he said.But Trump has repeatedly refused to commit to any guarantees. Britain and France have both offered peacekeepers in the event of a deal to end the Ukraine war but say there must be a US "backstop" -- including American intelligence and possibly air power.The US president told Starmer Thursday he was "open to many things" in terms of security guarantees but that he wanted to get a Russia-Ukraine deal

in place first. Trump added that there had been a "lot of progress" towards a deal but then added: "It'll either be fairly soon or it won't be at all."US and Russian fficials met on Thursday in Istanbul in a new round of talks. Putin and Trump said after their February 12 phone call that they had agreed to meet personally -- but they have not finalized any meeting yet

Russian tourist dies after being attacked by sharks in Philippine diving spot, another drowns

MANILA. Two Russian tourists died when they were swept away by strong undercurrents while scuba diving in waters south of Manila, with one believed to have drowned and the other attacked by sharks, a Philippine coast guard official said Friday. Two other Russian tourists

managed to swim back safely to their dive boat Thursday off Verde Island, a popular diving destination in the province of Batangas, Philippine coast guard provincial commander Capt. Airland Lapitan said. The four Russian tourists traveled by boat to the waters off Verde Island from the nearby town of Puerto Galera in Oriental Mindoro province

with a Filipino dive instructor. While



diving, the five were swept away by strong undercurrents, Lapitan said. Two of the Russians managed to surface with the dive instructor but the two other Russians, who were identified as Ilia Peregudin, 29, and Maksim Melekhov, 39, went missing. The dive

along with Philippine coast guard personnel, immediately launched a search, according to Lapitan.Melekhov was found unconscious at sea an hour later and was declared dead by doctors in a Batangas hospital, he said."The other Russian diver was found while being attacked by sharks. His right arm, unfortunately, had been severed and the sharks were moving around him," Lapitan told The Associated Press. "They

somehow managed to pull him away.' An investigation is underway and the coast guard will meet provincial officials to discuss ways to prevent such deadly incidents at Verde Island and other dive spots, Lapitan said.

Is New Orleans on the brink of a Fiscal crisis City officials disagree UPDATED. Earlier this month, when New Orleans

Mayor LaToya Cantrell announced that she intended to renege on a \$20 million settlement with the Orleans Parish School Board, she said the city couldn't afford

The settlement with the school board was brokered last fall by the New Orleans City Council and Cantrell's own top deputy, Chief Administrative Officer Gilbert Montaño. It would have ended yearslong litigation over the fees the city collected on property taxes intended for schools and provided an infusion of money for the cash-strapped district. But City Attorney Donesia Turner said that the settlement wasn't a done deal because the mayor hadn't been actively involved and, further, that it would be too costly for the city. This was later echoed by Chief Financial Officer Romy Samuel."The city's financial positioning has taken a major shift," Samuel said at a special meeting to discuss the school board settlement on Feb. 11. "Budgetary obligations, the continued rise in inflation accompanied by unexpected expenditures beginning in 2025 and various other factors have weighed heavily on the city's operating costs."The about-face from the city's executive leadership caught both the school board and the council by surprise. The council had approved the deal with Montaño's apparent approval and without any objection from Cantrell's office. And Cantrell had just signed a 2025 city operating budget that was more than \$200 million higher than the one she approved for 2024. Now, councilmembers — and even a top official within Cantrell's administration are pushing back on the mayor's claims, saying that the city is not only able to afford the school board settlement but also is prepared to handle the budgetary challenges heading its way. This is something that's been manufactured, and is now trying to be reverseengineered to explain where we are," said Councilmember Joe Giarrusso, who chairs the budget committee. "And I am extraordinarily troubled that we're going to hold the city captive for the next month or two because we're saying we don't have any money and we can't move forward." Cantrell's office, which has been criticized for a lack of transparency around budgeting and other matters, did not respond to requests for comment on this story.

It's no secret that the city of New Orleans has faced a slate of potential challenges since the year began. Israel and Hamas have begun negotiating next phase of Gaza ceasefire: Egypt

KHAN YOUNIS. Negotiations between Israel and Hamas on the next phase of the Gaza ceasefire began Thursday, Egypt said, averting a collapse ahead of Saturday's expiration of the agreement's first phase.

Officials from Israel, Qatar and the United States started "intensive discussions" on the ceasefire's second phase in Cairo, Egypt's state information service said.

"The mediators are also discussing ways to enhance the delivery of humanitarian aid to the Gaza Strip, as part of efforts to alleviate the suffering of the population and support stability in the region," its statement said.

Phase 2 talks are meant to negotiate an end to the war, including the return of all remaining hostages in Gaza who are alive, and the withdrawal of all Israeli troops U.S. President Donald Trump's Mideast from the territory.Return of remaining deceased hostages would happen in Phase 3. According to Israel, there are 59 remaining hostages — 24 of whom are still believed to be alive.It will be difficult to reconcile a deal with the war objectives of Israeli Prime Minister Benjamin

Netanyahu, who has called for dismantling Hamas' governing and military capabilities. After suffering heavy losses in the war, Hamas has nonetheless emerged intact during the ceasefire, and the group says it will not give up its weapons. Hours before talks began, an Israeli official said the country would not withdraw from a strategic corridor in the Gaza Strip as called for under the ceasefire, a refusal that could severely complicate negotiations with Hamas and key mediator Egypt at a sensitive moment for the fragile truce. Overnight, Hamas released the remains of four hostages in exchange for over 600 Palestinian prisoners, the last planned swap of the ceasefire's first phase.

Many fell into the arms of relatives, who spent days waiting for them after Israel held up their release last weekend to protest what it called cruel treatment of hostages by Hamas during their releases. Former Gannavaram MLA Vallabhaneni Vamsi sent to judicial remand after threeday custody

VIJAYAWADA. Former Gannavaram MLA and YSRCP leader Vallabhaneni Vamsi Mohan was sent to judicial remand at Vijayawada district jail on Thursday after completing three days in police custody.

Patamata police had arrested Vamsi Mohan from his residence in Gachibowli, Hyderabad, and presented him before a Vijayawada court last week. The court granted three days of custody, rejecting a ten-day request. On Thursday, police sought ten-day custody for two more accused.

Following a special SC and ST court's order, Central Assistant Commissioner of Police (ACP) K Damodhar interrogated Vamsi and two others-Lakshmipati and Sivaramakrishna Prasad—over allegations of abducting and threatening complainant Mudunuri Satyavardhan in the Gannavaram TDP office attack case. Police presented CCTV footage and call records as evidence.

Investigators provided separate questionnaires to the accused, but police sources said Vamsi did not cooperate, prompting plans for another custody request. He allegedly admitted to meeting former CM YS Jagan Mohan Reddy in Tadepalli on February 12. Meanwhile, a fresh case was registered on a complaint by Jasthi Murali Krishna, who alleged land grabbing. The CID filed a PT warrant petition for Vamsi's custody, with arguments set for Monday. The court denied Vamsi's request for preferred cellmates and ordered periodic health checks.

Private firms to handle upkeep of Marina, four other beaches



CHENNAL. The Greater Chennai Corporation (GCC) is all set to privatise the cleaning and maintenance of five beaches, including the Marina and the Elliot's, at a cost of Rs 11.64 crore for a contract period of one year. Maintenance of Srinivasapuram, Thiruvanmiyur and New beaches are also to be privatised. The Marina, which spans 250 acres, is one of the most visited beaches in Chennai, collecting an average waste of around 5.5 tonne to 7 tonne every day.

Speaking to TNIE, a senior GCC official said while the zones in which these five beaches are located are covered by Urbaser Sumeet, its scope of work extends only up to the service road and does not include the beach.

As a result, the beaches have been left uncleaned except during special occasions when cleaning is carried out with the assistance of Urbaser or Chennai Enviro Solutions Private Limited along with a few of GCC's own staff.

With the privatisation, workers will be equipped with vehicles for beach combing. The GCC is also taking measures to regulate unauthorised shops. Beach captains and marshals will be given point of sale machines to levy spot fine for littering. They will also be equipped with walkie-talkies.

"We believe this privatisation will help clean the beach completely by June or July. The beaches will be maintained regularly from then on," the official said.

Tamil Nadu releases new policy for care of homeless people with mental illness

CHENNAI. Chief Minister MK Stalin on Thursday released the state policy for Care of Homeless Persons with Mental Illness and Implementation Framework - 2024, brought out by the Health and Family Welfare Department, as part of the government's commitment to delivering quality services to this vulnerable segment of society. The proposed policy framework delineates the service provided to Homeless Persons with Mental Illness (HPWMI) into four stages -rescue and acute care, intermediary care, long term care, and social integration.

The policy proposes a standard operating procedure (SOP) to be followed in rescue operations. When a rescuer finds any person to be homeless and suspects mental illness, he shall inform the nearest police station and assist the cops in rescue operation. The police with or without the assistance of NGOs should take the person concerned to a government medical college hospital or headquarters hospital for admission. Medical assessment should be done. The medical officer in-charge shall arrange for assessment of mental health. The policy states that if the person doesn't have mental illness, then the psychiatrist should inform the police for reunion with the family, or if the person has mental illness and is severely ill, he/she should be treated at the medical college hospital itself. The policy also details what should be done if the person is below 18 years, woman or pregnant and a victim of crime. The HPWMI after discharge from acute psychiatric care shall be transferred to Emergency Care and Response Centre (ECRC) for intermediary care. The duration of the stay should be 12 months or until union with the family, whichever is earlier.

Odisha CM asks depts to spend 85 per cent of budget funds by March-end

Telangana scraps 15 per cent non-local quota in Higher education

HYDERABAD. The Telangana Higher Education department has issued orders reserving 85% of the seats in all higher education institutions - government or private higher education and technical institutions — for locals.

Government Order 15 (GO 15). issued by Education Department Secretary Yogita Rana on Thursday, says that 85% of the seats in all higher education institutions will be reserved for local candidates in the Osmania University (OU) area, while the remaining 15% will be unreserved. The GO makes it difficult for non-local students to get admission in the 15% unreserved seats as they will also have to compete with the local candidates. The GO revises the 'region-wise reservation of seats" to "admission to 85% of seats for local candidates of the OU area". This implies that candidates from Andhra Pradesh will no longer be eligible for local reservations in colleges in Telangana. The GO says that candidates who can claim seats in the 15% unreserved category should have resided in the state for a total period of 10 years (excluding periods of study outside the state), or either of their parents should have resided in the state for a total period of 10 years (excluding periods of employment outside the

The US was never Europe's safe harbour

The Europeans were left dumbfounded, if not shellshocked, by the verbal whiplashing administered to them by US Vice-President James David Vance at the sixty-first iteration of the Munich Security Conference earlier this month. Vance questioned the fundamental commitment of Europeans to democratic values, that, he argued, underpinned the US-European construct. By the end of the speech, there was a lot of European strategic blood spilled on the conference floor of Hotel Bayerischer Hof.The diatribe led to extended recriminations, with many European leaders pushing back strongly against Vance's caricatured characterisation of the current state of play in Europe. However, this begs the question as to why Europeans are surprised. For, they have to only look back to the past hundred years or so of US ties with Europe to see that America has always only acted in its own interest — what it has conveniently characterised as American exceptionalism. The First World War began on July 28, 1914. It was triggered by the assassination of Archduke Franz Ferdinand, heir to the Austro-Hungarian empire, and his wife Sophie, by a Bosnian Serb a month earlier. Though it was a European war, the Triple Entente — Britain, France and Russia — which was fighting the Triple Alliance of Austria-Hungary, Germany and Italy, pleaded with America to weigh in on its side.

The US, led by President Woodrow Wilson, stymied by Senators with Jacksonian impulses, refused to enter what it deemed, and perhaps correctly so, a European imperial joust. It was only two and a half years later, on April 7, 1917, that the US declared war on Germany. And that was only because the Germans had unleashed extensive submarine warfare in the North Atlantic Ocean, causing a huge loss of American men and material.

An added trigger was a communication by the then German Foreign Minister, Arthur Zimmermann, which later came to be known as the notorious "Zimmermann Telegram". It promised the Mexican government that Germany would help Mexico retrieve the territory it had lost to the US in the wake of the Mexican-American war of 1846-1848. In return for this assistance, Germany asked for Mexico's support in the war. This was a direct affront to the Monroe doctrine conceptualised by President James Monroe and his Secretary of State John Quincy Adams. Articulated during Monroe's address to the US Congress on December 2, 1823, the Doctrine held that the Western Hemisphere, especially the Americas, was the US' exclusive sphere of influence and the Europeans had no business to interfere in this eminent domain. Thus, only when its own interests were threatened did the US enter the European war.

After the spectacular collapse of the League of Nations — midwifed by President Wilson, vide the Treaty of Versailles on June 28, 1919, with the Japanese walkout in February 1933 and the German withdrawal eight months later — the US once again retreated into splendid isolation even as Adolf Hitler and his Nazis gobbled up territories and countries in Europe, beginning with the Austrian Anschluss in March 1938. Even when the Great Britain stood alone in its darkest hour from May to November 1940 - President Roosevelt expressed his inability to help it because of the Neutrality Act of 1939 and the Johnson Act of 1934. Though certain innovative means were found later, the US only formally entered World War II after the devastating Japanese attack on Pearl Harbor on December 7, 1941.

Then also, to begin with, on December 8, 1941, it only declared war on Japan. It was only when Germany and Italy declared war on the US on December 11, 1941, did it reciprocate that announcement. The bottom line is that even as Europe was being subjugated by the hoodlums of the Gestapo and Shcutzstaffel, the US may have continued to remain neutral had it not been for the Japanese attack.

Qatar counts in West Asia and beyond

The Gulf nation is important to India primarily for bolstering energy security

EVEN as analysts were preoccupied with the implications of US President Donald Trump's policies for India, an important visit passed under the radar. The Amir of Qatar, Tamim bin Hamad Al Thani, visited India last week and was given the signal honour of being received at the airport itself by Prime Minister Narendra Modi

The courtesy has been reserved for the leaders of only a few countries, including leading economies like Japan and France. Qatar, in contrast, is a tiny West Asian kingdom. But it wields far more heft than is evident by its mere size. It is the fifth richest country in terms of per capita GDP and is home to the world's largest natural gas field. It also plays a disproportionately large role in the geopolitical events of the region, including recent negotiations to reach a peace deal in the Israel-Hamas war.

Qatar is critically important to India for many reasons, but primarily as a major supplier of liquid natural gas (LNG). As much as 45 per cent of the country's requirements are met by imports from this Gulf country. LNG is natural gas cooled to a liquid state. In this chilled form, it can be transported by special tankers to terminals around the world. It is then warmed again and moved through pipelines to distribution points. The advantage is that it can be transported to places beyond the reach of pipelines. There have been many proposals for subsea pipelines to bring natural gas from Gulf countries like Oman to the subcontinent, but these have failed to take off due to technical reasons. LNG imports are, therefore,

Natural gas is also a cleaner alternative to other fossil fuels. It currently comprises only 6 per cent of the country's energy mix, but the target is to raise this to 15 per cent by 2030. The International Energy Agency has forecast that India's natural gas consumption will rise by nearly 60 per cent over this period from 2023 levels. This, in turn, will lead to a doubling of LNG imports owing to sustained demand growth and a slowing domestic production. Currently, imported natural gas accounts for roughly half of the country's consumption needs.

Qatar and the US look set to be major suppliers of natural gas in the form of LNG in the long run. An existing India-Qatar contract for the supply of 7.5 million tonnes per annum of LNG has recently been extended for another 20 years with effect from 2028. The value of the contract is a mind-boggling \$78 billion. For the long-term commitment provides a tremendous comfort level in the energy sector at a time when the US is doubling down on sanctions against Russia. Right now, India needs to ensure that oil and gas supplies are not disrupted for any reason. Diversification of sources of supply has already been carried out in the case of oil, with imports contracted from multiple sources. As far as natural gas is concerned, the recent agreements with Qatar give similar confidence that much of the demand will be met without any hiccups.

PM Modi's warmth towards the Qatari leader also stems from an expectation of substantial investments to be made in the coming years.

A \$10-billion investment plan was announced during the visit, but this could expand significantly, especially in the energy sector. Foreign direct investments of \$1.5 billion



have already been made by the Qatar Investment Authority in a wide range of areas, including retail, power and information technology. As for bilateral trade, it is expected to rise from \$14 billion currently to \$28 billion over the next five years. Yet, investments from Qatar are lagging behind those from other Gulf countries like Saudi Arabia and the United Arab Emirates (UAE). These countries have announced investment plans of \$100 billion and \$75 billion, respectively, largely in the hydrocarbons sector. Clearly, more efforts are needed to enhance ties with the equally cash-rich yet smaller

Apart from economic cooperation, the Qatar leader's visit has led to bilateral relations being upgraded to a strategic partnership. It becomes the fifth Gulf country with which India has developed this relationship. The upgradation of ties is significant, especially in the context of the key role that this small nation plays in West Asia. It has become a broker for peace talks in most conflicts in the region, the most recent being the Gaza truce that was negotiated in Qatar.For India, it has also emerged as a channel of communication with the Taliban in Afghanistan. The relationship had floundered in 2022 when eight former Indian Navy personnel were sentenced to death by a


Qatari court. PM Modi's intervention led to the sentence being commuted, but one former naval officer still remains in custody. It is also interesting that the ambitious India-Middle East-Europe Corridor (IMEC) project has bypassed Qatar, though both the UAE and Saudi Arabia are on board. Hopefully, these lingering irritants in bilateral ties will be ironed out soon. At a time when media scrutiny of the India-US relationship is overwhelming due to a raft of announcements by Trump on various issues, the growing importance of India-Qatar

ties has been given only muted recognition.

But there is no doubt that this relationship, built on the foundational element of energy security, is set to become deeper. One aspect that will play a significant role in determining the course of these ties is the eight lakhstrong Indian diaspora that makes a major contribution to the economy of the Gulf country. It is incumbent on the government to ensure adequate working conditions for its citizens there, even as domestic foreign exchange reserves benefit from the bonanza of remittances that prop up foreign exchange reserves. A multiplicity of factors, therefore, are underpinning this much-needed initiative to expand relations with a country that has rapidly assumed a key role in West Asia.

Asphalt over art

Why India must think twice about Trump's F-35 offer

The F-35 is already a highly questionable and controversial commodity in the USA itself. There have been too many glitches.

AFORMER foreign secretary has advised "India to adjust to a whole new world" with "only transactions and deals" and believes that there are "no friends and enemies in this scenario." Obviously, the diplomat's assessment originates from the 'real-time' unpredictability of the sole 'super power', President Donald Trump, who appears difficult to be dealt with by today's "whole new world." Simply put, the 'scenario' today has dramatically turned to 'T' for 'transactional Trump', and 'D' for 'dollar deals Donald', with the USA launching its global blitzkrieg for 'deal' and 'transaction'. The US unilateralism is compelling friends and foes alike to either scurry for cover or make a personal appearance before Trump to keep him in good humour, notwithstanding the bleak prospect of any meaningful result. Trump loves the driver seat for deals, dictating all in his durbar to put their signatures in the DC-prepared draft of transaction documents.

Trump now wants India to buy the Lockheed F-35 fighter to reduce America's \$35 billion bilateral trade deficit

However, India knows well (as does the USA, presumably) that any international deal, transaction, contract, or even the hatching of criminal conspiracy, is a bilateral process and essentially a matter of 'offer plus acceptance' for the sealing of the deal. From India's perspective, too, shouldn't then the F-35 be looked into?

Barring the US Douglas DC-3 Dakota and Fairchild Packet C119G transport and air-dropping, the Indian Air Force has never had a US fighter in its combat squadron inventory since 1947. Hence, the sudden transformative, unilateral and command-like-offer to India to buy the Lockheed F-35 multirole fighter by the transactional President of the US (POTUS) deserves a scrutiny, especially in light of the contemporary geopolitical weather and history of erratic, overbearing US policy

towards Delhi-DC bilateral contours over the decades. First, let us be clear that no air force of a country of India's shape and size is made in a day and an air force building

is no garden party or a matter of joke. It is a serious business of high-tech, high-risk, high-investment and exceptionally high-quality trained personnel or men behind the machines. Jane's All the World's

Aircraft shows that the period from the "request for proposal" to the "first delivery' of the F-35 fifth generation multirole stealth fighter Lockheed, spanned over 15 years (December 1995-May 2011). Also, India was never under the US radar either as an industrial partner or a potential buyer or readymade user of the high-tech Lockheed fighter. The F-35 essentially was for the advanced west and its defence and security partners from the non-west. Thus, in late 1996, "Australia, Canada, France, Germany, Greece, Israel, Singapore, Spain and Sweden were briefed on the programme." It was clear from the beginning that it would be an enormously expensive flying machine.

First-level collaboration with 10 per cent costsharing was sought from the UK; Italy and the Netherlands were level-two partners, with 5

per cent cost sharing; level three involved the payment of 1-2 per cent with Denmark and Norway and, finally, came Australia, Canada and Turkey, who were to bear the cost on their own. Consequently, the cost of each fighter was exorbitant. As seen from the annual publication of Jane's All the World's Aircraft, from 2012-2013, each unit cost of the US Air Force F-35A was quoted as \$37.3 million. It escalated to \$94.3 million in 2017 and is now well over \$100 million per fighter. On top of this, if one takes into account the depreciation of the Indian rupee vis-a-vis the US dollar, the expenditure by the Indian exchequer can be truly mindboggling. It can make any F-35 "deal" or "transaction" highly explosive and an impossible hot political potato, with the questionable possibility of the US fighter role, responsibility and utility in the Indian defence



system. There are also multiple technical factors which surely would be beyond the comprehension of the millions of uninitiated, who get impressed by the air display and further charged by the emotional public debate of/for optics. The F-35 is already a highly questionable and controversial commodity in the USA itself. There have been too many glitches and cost and time overruns that have made both the POTUS and his principal Man Friday, Elon Musk, making comments on the US aviation industrial capacity and capability. The POTUS is after Boeing for its inability to deliver two 'Air Force One' transport craft for the White House. Musk is all over F-35, making comments like: "F-35 fighter jets are obsolete" and "meanwhile, some idiots are still building manned fighter jets like F-35."

Expectedly, the outgoing US air chief has given Musk a

mouthful of expletives. Tech and economics aside, India is expected to follow zero-tolerance to flight safety failure if it afflicts an extraordinarily "sophisticated stealth" like F-35. Regrettably, things went wrong early in October 2010 itself, with a brief grounding of the fleet at the Edwards Air Force Base (AFB), owing to a "software problem affecting the pump that could have caused un-commanded inflight shutdown of engine."

Almost 15 years have gone by, but unexplained and unexpected inflight glitches continue to plague the F-35s. A few citations would suffice. In two successive accidents in June and July of 2014, a mixed group of F-35s "suffered catastrophic engine failure at Eglin AFB which was followed by a fleet-wide grounding order." This is similar to what the Indian Air Force faces today — a whole fleet of the indigenous Advanced Light Helicopter Dhruv being grounded after the January 5, 2025

crash. For the F-35, however, the most serious finding of the accident inquiry report was "rubbing between thirdstage fan blades in low-pressure section of the P&W F-135 engine and the inner wall of compressor casing."Unfortunately, the F-35 offered by the POTUS still suffers from nagging niggles which do not inspire confidence of any potential user. That's the irony, but also the reality. One, therefore, would hate to see a possible increase in the number of widows and orphans in our Air Force stations during peace time.

New Delhi. India will need to grow at an average 7.8 per cent to become a high-income country by 2047, a World Bank report said on Friday. To achieve this goal India would require reforms in financial sector as well as in land and labour market, the World Bank said in its India Country Memorandum titled 'Becoming a High-Income Economy in a generation'.

Recognizing India's fast pace of growth averaging 6.3 per cent between 2000 and 2024, the report notes that India's past achievements provide the foundation for its future ambitions.

However, reaching the ambitious target of becoming a high-income economy by 2047 will not be possible in a business-as-usual scenario... for India to become a high-income economy by 2047, its GNI (gross national income) per capita would have to increase by nearly 8 times over the current levels; growth would have to accelerate further and to remain high over the next two decades, a feat that few countries have achieved.

"To meet this target, given the less conducive external environment, India would need to not only maintain ongoing initiatives but in fact expand and intensify reforms," the World Bank

In recent years, India has introduced a host of structural reforms to transform the country into a global manufacturing hub, to boost infrastructure, improve human capital, and leverage digitization, while at the same time bolstering macroeconomic stability.

To reach high income by 2047, India's growth rate needs to average 7.8 per cent, in real terms, over the coming decades... Only an 'accelerated reforms' package would put India on track to become high-income by 2047," the report said. World Bank India country director Auguste Tano Kouame said lessons from countries like Chile, Korea and Poland show how they have successfully made the transition from middle to high-income countries by deepening their integration into the global economy. The report said that over the past decades. India has developed at a scale and pace that few would have thought possible. From 2000 to today, in real terms, the economy has grown nearly four-fold, and GDP per capita has almost tripled. Because India grew faster than the rest of the world, its share in the global economy has doubled from 1.6 per cent in 2000 to 3.4 per cent in 2023. India has become the world's fifth largest economy.

"Arbitrary, Illegal": Top Court **Sets Aside Dismissal Of Two**

The case pertained to the dismissal of Judges Aditi Kumar Sharma and Sarita Chaudhary, who had joined the Madhya Pradesh judicial service in 2018 and 2017 respectively. A bench of Justices BV Nagarathna and N Kotiswar Singh noted that one of judges, during probation period, had got married, contracted Covid-19, had a miscarriage, and her brother was diagnosed with cancer."When there is birth there is sense of fulfillment whereas miscarriage has serious effect on mental health of women which has psychological impact which even leads to suicide and recurring miscarriages even has severe effects on health. Miscarriage affects a person's identity, stigma, isolation in other factors. It is not enough to find comfort in growing number of women judicial officers unless we secure a comfortable atmosphere for them to work in," Justice Nagarathana

While adding that women judges often take pain-killer medicines to sit through the entire day in court on certain days, the Bench added that freedom from discrimination for women during pregnancy is precious right. The top court direct the reinstatement of both women judges within 15 days. Justice Nagarathna said a report given by the Madhya Pradesh High Court in a sealed cover was also not satisfactory in persuading the Bench to take a different view. "We hold that the termination was in the form of punishment. The termination was stigmatic in nature," she said.On November 11, 2023, the top court had taken a suo motu cognisance of the termination of six women civil judges by the state government over their alleged unsatisfactory performance. However, a full court of the Madhya Pradesh High Court reconsidered its earlier resolutions on August 1, 2024 and decided to reinstate four officers-- Jyoti Varkade, Sushri Sonakshi Joshi, Sushri Priva Sharma and Rachna Atulkar Joshi -- on certain terms and conditions, leaving out the other two, Aditi Kumar Sharma and Sarita Chaudhary from the

Teacher writes answers on board during exam, suspended after video goes viral

New Delhi.In a shocking incident, a teacher in a Madhya Pradesh school was caught helping students cheat by solving the question paper on a blackboard. The incident, which was captured on camera, took place on February 25 in Betul district. The school has suspended the teacher and has launched an enquiry into the matter. During the exam, primary school teacher Sangeeta Vishwakarma was seen writing answers for the Mathematics question paper on the blackboard, enabling students to cheat.

As the teacher was helping students cheat, someone recorded the entire incident and shared the video on social media, where it quickly gained traction.

As soon as the video went viral, the district administration took immediate notice. Betul Collector Narendra Kumar Suryavanshi ordered an urgent investigation considering the seriousness of the matter. During the enquiry, the allegations of facilitating cheating against the teacher were found to be true, leading to her suspension.

Assistant Commissioner of the Tribal Affairs Department, Shilpa Jain, said that Sangeeta Vishwakarma was assigned as an invigilator in the examination hall. However, Jain pointed out that Vishwakarma misused her position by solving the question paper on the blackboard and facilitating cheating among students."Following her suspension, a disciplinary enquiry has been initiated against the teacher. If further serious charges are proven, strict action may be taken against her," said Jain.Additionally, action is being considered against the examination centre head and assistant centre head. If required, an FIR may also be registered folzowing the investigation," Jain added.

After this incident, the education department issued strict warnings to all teachers, stating that using unfair means or promoting cheating in any way during exams will result in severe consequences. The administration has also instructed authorities to enforce strict monitoring at examination centres to prevent such incidents in the

USAID accused of supporting Hamas, Lashkar-linked group at Congress hearing

New Delhi. Over USD 2 billion has been sent by the US Agency for International Both the LeT and its front JuD, Development (USAID) to support the Hamas terrorist organisation since the October 7 attacks on Israel in 2023, under the Biden Administration,

according to testimony presented during a House Committee hearing on USAID and federal workers.

Reports further indicate that USAID also provided assistance to an anti-Indian outfit designated as a terrorist organisation by the US government.It funded the Falah-e-Insaniat Foundation (FIF), a front for Lashkar-e-Taiba

(LeT) based in Pakistan. LeT was responsible for the 26/11 Mumbai attacks, which left 166 people dead and over 300 injured.

Previously, USAID had been accused of continuing to support the foundation despite being under investigation for proscribed as terror organisations by both India and the US, have carried out multiple terror attacks across India,



including Jammu and Kashmir. Despite the US ban on FIF, shocking accusations have, now, emerged indicating that USAID actively funded the proscribed organisation. The aid from USAID was sent to FIF through a Michigan-based charity called Helping

Hand for Relief and Development (HHRD). HHRD has alleged ties with jihadist organisations in South Asia."USAID funded HHRD, a Michigan-based Islamist charity with ties to jihadist groups, including

Pakistan's Falah-e-Insaniat Foundation, a USdesignated terrorist organisation involved in the 2008 Mumbai attacks," said Middle East expert Amjad Taha said on X, further claiming that USD 110,000 was sent to jihadist groups operating out of South Asia, including FIF, which was behind the 26/11 Mumbai attacks.

The Trump administration has decided to cut 90% of USAID's foreign contracts and over USD 60 billion in funding for the US's assistance programs worldwide, signalling a decades-long shift in the US shaping up its policies and interests abroad with the help of the aid agency's initiatives.

'Duplicate registrations': CAG exposes Rs 220 crore irregularities in Ladli scheme

The report found that the Women and Child Development department overseeing the scheme failed to verify beneficiary details, leading to widespread duplication.

NEW DELHI. A Comptroller and Auditor General (CAG) audit has uncovered massive discrepancies amounting to over Rs 220 crore in the Ladli Scheme, launched to provide financial assistance for girls' education. The audit documents, exclusively accessed by this newspaper, revealed thousands of duplicate and fraudulent registrations, an excess payment of over Rs 41 crore, and a staggering Rs 618.38 crore lying unclaimed. The report found that the Women and Child Development department overseeing the scheme failed to

verify beneficiary details, leading to widespread duplication. It identified over 36,000 cases where beneficiaries' names, birth dates, and parental information were identical, raising concerns about fraudulent

According to the findings, 16,546 duplicate and 131 triplicate registrations were detected among 8.84 lakh active beneficiaries as of December 2022. This resulted in an excess payment of Rs 11.49 crore. In another 20,127 cases, where either the names or dates of birth matched, Rs 29.23 crore was disbursed. The



audit also highlighted that the department did not integrate Aadhaar verification until May 2023, allowing multiple enrollments of the same beneficiary. The department only initiated steps to incorporate the Ladli Scheme into the Direct Benefit Transfer system that May. This failure to ensure a foolproof registration process led to significant financial irregularities.

The CAG flagged another primary concern: nearly 9 percent of beneficiaries were enrolled after turning 18, the scheme's maturity age, causing a financial loss of Rs 180.92 crore. The audit found that 78,065 beneficiaries who had already crossed the eligible age at

enrollment had accounts accumulating funds. "In many cases, the column 'Date of Birth' was blank," it stated.Meanwhile, a staggering '618.38 crore for beneficiaries remained unspent since the scheme's inception, even as lakhs of eligible girls have crossed the maturity age, the audit report has revealed. The initiative was launched in 2008 during the tenure of late former Chief Minister Sheila Dikshit to provide financial assistance to girls at different stages of their education and a lump sum amount of up to Rs 1 lakh upon turning

18.As of December 31, 2022, around 4.9 lakh girls, out of 8.84 lakh active beneficiaries, which amounts to 55% of the scheme's total active enrollees, had not received their due benefits despite meeting the eligibility criteria, the audit said. The report states that Rs 236.03 crore remained unclaimed by 1.26 lakh beneficiaries aged 18 to 20 years. Another Rs 224.56 crore was not disbursed to 1.18 lakh beneficiaries between the ages of 20 and 26, while Rs 157.78 crore never went to 77,000 girls now over 26 years old. Additionally, 1,74,960 cases where beneficiaries met the maturity criteria were left unsettled.



ere's the buzz for people in Tamil Nadu, a state in which mosquitoes infect an average of 5,000 people with dengue each year and 100 deaths have been recorded in the past six years.

Scientists at Vector Control Research Centre (VCRC), Puducherry, will soon induce Wolbachia bacteria from fruit flies in the primary transmitter of the dengue virus, the female Aedes aegypti mosquito, to slow or prevent the spread of the life-threatening

Once we introduce it in mosquitoes, the Wolbachia bacteria will hopefully block the dengue virus (flavivirus) from infecting new

The research institute will test the bacteria in its laboratory from March, with eggs of mosquitoes infected with Wolbachia from Monash University in Australia.

In 2016, more than 11akh people across the country tested positive for dengue and more than 200 died of the disease, data from the National Vector Control Programme shows. In the past six years, more than 30,000 people in Tamil Nadu tested positive and nearly 100 people died due to dengue. If the research is successful, the Union health ministry believes it could eliminate dengue from the country or at least out the brakes on the disease.

Research by the Australian scientists showed Wolbachia from fruit flies can block the dengue virus in mosquitoes. The Indian Council of Medical Research has signed a memorandum with Monash University to study the impact of the bacteria countering dengue.

"We have tried traditional vector control measures such as fogging, mosquito nets,

insects will be infected," Jambulingam said. "Then we'll check if the virus is retained in the insects' abdomen. If it is, we will launch these insects in the field."

At least five countries including Vietnam, Indonesia and Brazil are testing Wolbachiainfected mosquitoes to check the spread of

Dr Soumya said ICMR is keeping tabs on research by private company Oxitec, which uses advanced genetics to insert a self limiting gene into mosquitoes.

The gene is passed on to the insect's offspring, so genetically engineered male mosquitoes released in the wild mate with wild females and their offspring inherit the self-limiting trait. The resulting offspring die before reaching adulthood and local mosquito populations decline.



For the study, published in the journal Circulation, the team enrolled more than 9,350 adults aged 50 and older who had high blood pressure and were at high risk for cardiovascular disease.

High blood pressure, or hypertension, is a leading risk factor for heart disease, stroke, kidney failure and other health problems. While saving lives, an intensive blood pressure

regimen also would cause serious side effects, the researchers said. The study estimated that approximately 56,100 more episodes of low blood pressure, 34,400 more episodes of fainting and 43,400

While the 2006 smoking ban prohibited smoking in enclosed public places and workplaces (except in hospitality venues), in 2011, it was extended to all hospitality venues and selected outdoor areas (hospital campuses, educational centres, and playgrounds). The survey results, published in the journal Nicotine & Tobacco Research, showed significantly lower exposure following the second legislation, with participants reporting their overall exposure falling from 72 per cent in 2006 to 45 per cent in 2011.Exposure decreased across all locations surveyed, beyond the workplaces and hospitality settings covered by the 2011 legislation.

For example, exposure also decreased in residences from 29 per cent to 13 per cent and in transportation spaces from 41 per cent to 13 per cent.

"Exposure to second-hand smoke in selected outdoor settings may be further reduced by extending smoke-free legislation," said senior author Maria J. Lopez of the Public Health Agency of Barcelona,

Meta fires 20 employees for leaking internal information to media

New Delhi. Meta on Thursday said it had laid off 20 workers for leaking information to the media, as the social media giant faces pressure over the recent political shift of its boss Mark Zuckerberg towards US President Donald Trump.

"We tell employees when they join the company, and we offer periodic reminders, that it is against our policies to leak internal information, no matter the intent," a Meta spokesperson said, confirming a story first reported in The Verge.

We recently conducted an investigation that resulted in roughly 20 employees being terminated for sharing confidential information outside the company, and we expect there will be more," the company added. We take this seriously, and will continue to take action when we identify leaks."The round of firings came following a recent series of reports based on Zuckerberg's meetings with employees. In one meeting, first reported by The Verge, Zuckerberg told employees he would no longer be forthcoming with information because "we try to be really open and then everything I say leaks. It sucks."

He also warned them to "buckle up" for the coming year and said that Meta would be a productive



Ediz and Wei Yi share the last spot on a half point apiece from their two games.n a day when world champion Boris Spassky breathed his last, Chithambaram's




