

The legislation, enacted 46 years ago during the tenure of former chief minister P K Thungon, seeks to prohibit forced conversions through inducement or fraudulent means. New Delhi, Feb. 05: A voter turnout of 57.70 per cent was recorded till 5 pm in the Delhi assembly polls, according to officials figures. The polling in all the 70 constituencies began at 7 am and will continue till 6 pm. According to Election Commission (EC) data, 57.70 per cent of the electorate exercised their franchise till 5 pm. There are around 1.56 crore eligible voters in Delhi. The highest turnout was recorded in the Northeast district at 63.83 per cent, while the New Delhi district recorded the lowest at 54.37 per cent. Among other constituencies, Mustafabad had the highest turnout at 66.68 per cent while Karol Bagh recorded the lowest at 47.40 per cent. Shahdara recorded a turnout of 61.35 per cent, Southwest Delhi 58.86 per cent, Northwest Delhi 58.05 per cent, North Delhi 57.24 per cent, Central Delhi district 55.24 per cent, Southeast Delhi 53.77 per cent, according to the EC data. Polling is underway at 13,766 stations across Delhi's 70 constituencies to decide the electoral fate of 699 candidates. In the 2020 polls, Delhi had recorded a turnout of 62.59 per cent while only 56 per cent participated in the 2024 Lok Sabha elections. is an exception for the elderly and those who cannot walk. For them, bringing their car inside is allowed," Ankit Chauhan, DCP, South Delhi told ANI. "This rule is being implemented everywhere. We will investigate the places where he (Saurabh Bharadwaj) is raising concerns about..." Voting is underway in all 70 of Delhi's assembly constituencies. The votes will be counted on February 8. President Droupadi Murmu, Union ministers S Jaishankar and Hardeep Singh Puri, and Congress leader Rahul Gandhi were among those who cast their votes for the Delhi Assembly polls early in the morning on Wednesday. New Delhi, Feb. 05: The Congress on Wednesday expressed sadness over "pictures of Indians getting handcuffed and humiliated" while being deported from the US and recalled that America had to express regret over the treatment meted out to India diplomat Devyani Khobragade in 2013 after the then UPA government retaliated sharply. A military transport aircraft of the US is bringing a group of Indian migrants, in the first such deportation to India as part of the big crackdown on illegal immigrants by President Donald Trump in his second term at the White House. ### Boat services to Mattancherry resume after six-year break

KOCHI. Boat services to Mattancherry resumed on Tuesday after a gap of six years, enabling residents and tourists to reach the popular tourist destination quickly instead of over-an-hour long travel by road from the Kochi city. Transport Minister K B Ganesh Kumar unveiled a slew of projects, including resumption of boat service to Mattancherry, launch of night tourist services of Indra, dedication of renovated Fort Kochi terminal, launch of five dinghies, two new ferry boats and a silt pusher machine. The State Water Transport Department (SWTD) was forced to stop the operations in the Ernakulam-Mattancherry route, post formation of large silt deposits in the backwater channel post the 2018 floods.

The services remained disrupted all these years after the irrigation department failed to carry out dredging works on a timely basis. It finally deployed the newly-acquired silt pusher machine to clear the navigation channel."Initially we could operate only a few services daily, that during the high tide. It will take some more time to operate regular services as the dredging activities need to be completed," an SWTD official said. The minister travelled in 'Indra', the country's largest solar-electric vessel, to Fort Kochi and also launched the renovated Fort Kochi Customs boat jetty. Meanwhile, the minister also launched two new catamaran ferry boats, one 75-passenger capacity vessel and the other 100."Another 50-passenger capacity.

## Corporation to set up advanced composting plant to process food waste in Thiruvananthapuram

THIRUVANANTHAPURAM. With food waste management becoming a mounting issue in the capital owing to restriction on inter-state transportation of food waste to pig farms in Tamil Nadu, the city corporation has given nod to a proposal to set up an advanced composting plant having the capacity to treat 10 tonnes of food waste daily.According to sources, the civic body has given approval to begin the trial run of the new composting technology by mid-February, in the wake of the ongoing crisis. The composting plant is part of the decentralised waste management plan of the civic body and uses advanced technology to expedite the composting process. The state capital generates around 423 tonnes of solid waste daily, of which around 127 tonnes is nonbiodegradable. Ever since the launch of household waste collection by Haritha Karma Sena members, the civic body has been able to implement source-level segregation of waste. The civic body's move to implement source-level waste management facilities in households is vet to gain acceptance among citizens owing to bad experiences in the past. The Haritha Karma Sena members are collecting approximately around 35 tonnes of food waste from households daily, but with the Tamil Nadu government imposing strict restrictions to ban the entry of waste from Kerala, the flow of food waste to pig farms in Tamil Nadu has halted.

## TNSTC workers' federation urges CM Stalin to stop privatisation, implement wage revision

TIRUNELVELI. Tamil Nadu State Transport Corporation (TNSTC) Workers' Federation urged Chief Minister M K Stalin to immediately halt the privatisation of transport corporations, expedite implementation of the 15th wage revision, and resume the dearness allowance hike for retired workers as per the Madras High Court order. Addressing the media here on Tuesday, federation's general secretary R Radhakrishnan, accompanied by other office bearers, said the government was taking steps that could lead to the gradual dismantling of state-run transport corporations."

Tamil Nadu government is engaging in privatisation by hiring contract workers, allowing private buses to operate on state routes during festival seasons with fare adjustments, permitting private minibuses in Chennai, and leasing bus depots to private players. These actions will weaken the public transport system and reduce employment opportunities, particularly for people from marginalised communities," he said.Radhakrishnan added that transport corporations, which were restructured under the Companies Act, currently operate 20,260 buses across 26 divisions, covering 18,723 routes and transporting 1.76 crore passengers daily. He stressed that the sector provides direct and indirect employment to lakhs of people. ## Student's death: GPS letter putting victim in bad light draws criticism

**KOCHI.** Even as questions about what and who is responsible for the extreme step taken by 15-year-old Mihir Ahammed of Global Public School International are still being asked, the latest communique by the school authorities to the parents of the students of the school has raised protests from various quarters. The letter has allegedly tried to paint the victim in a bad light. The letter is said to have highlighted how Mihir was given TC from Gems Modern Academy after an incident with a girl student and then at GPS International wherein he and a few of his friends got into a fight with another student.

According to the letter, Mihir joined the school after being forced to take a transfer certificate from Gems Modern Academy. "We hear he was issued TC after an incident related to physical assault on a girl student. He sought admission to GPS International.

Being a school which believes in giving a second chance to a student, we decided to give admission to the child, even though it was the middle of the academic year. We took an undertaking from his parents that he would abide by the school rules," says the letter.

The letter highlights how Mihir was included in every activity in the school. "He was selected to the school basketball team. He was part of the Model United Nations team at school and even presented the school in the event held at Choice School. We did everything to get him



integrated into all the activities at the school," says the letter. As per the letter, the school conducted enquiries with the students and parents who were alleged to be involved in the bullying incident. The teachers and classmates were also questioned to find out the veracity of the incident. There was no evidence or eye witness and all of them denied any such incident.

The complaint from Mihir's mother was immediately communicated to the SHO of the Hill Palace Police Station. Thereafter the police investigating teams including SHO and Intelligence units and Child Welfare Committee visited the school and hard copies of the mail from the parent along with attachments were also handed over to the Hill Palace station as per the request of the parents," says the letter.

"We were advised by the authorities not to take any hasty decisions or actions without reports and findings from them considering the age of the children involved. As a school, we have zero tolerance to bullying and ragging. If any wrongdoing is found and informed to us, we will take strict action to ensure that the wellbeing of all our students is protected. Enquiries by the intelligence, education department authorities and the Thrikkakara ACP are on and we are awaiting the findings.

"In the wake of the school's letter to parents, the 15-year-old's mother has issued a rebuttal. In her letter,

Rajna P M, Mihir's mother, took the school to task for sending across a misleading message that he was expelled from Gems Modern Academy. "The fact is that the school wanted Mihir to continue his education there.

We were the ones who made the difficult decision to apply for a TC. GPS International is trying to shirk its responsibility," Rajna wrote. She dismissed the school's claim that the parents had signed an undertaking regarding Mihir's claim of an exclusive undertaking further adds to the misleading narrative, suggesting that Mihir was a problematic student who required special monitoring—this is simply not true. As for the point that we hadn't raised any prior concerns regarding Mihir getting bullied, the school's narrative is false," she said in the letter.

#### Monkeys getting increasingly brazen, wreaking havoc: Khammam farmers

KHAMMAM. Farmers across Enkoor, Tallada, Bonkal and Raghunadhapalem mandals are battling a crisis as troops of monkeys ravage maize crops, threatening livelihoods and food security. With over 1 lakh acres of corn being cultivated during the current Rabi season, the fourmonth-old crops are now under relentless attack, forcing farmers to adopt desperate measures to protect their fields. Sources said thousands of monkeys swarm the fields daily, decimating crops and leaving farmers in distress. Many report spending sleepless nights guarding their land, while others lament the futility of their efforts. "We hoped to earn some income from this crop, but the survival of the harvest is now our only focus," said K Raghava Rao, a farmer. "We never anticipated such devastation from monkeys."

Earlier interventions under the previous BRS government, which involved trapping and relocating monkeys to forests, provided temporary relief. However, the problem has resurged inexplicably. "Monkeys vanished for a while, but now they're back in hordes—we don't even know where they're coming from," added Raghava. Farmers are experimenting with creative—and often unconventional—methods to deter the primates.

N Koteswara Rao of Tallada mandal installed Kondamucchulu (traditional scare devices), but monkeys simply attack from the other sides. Others have placed photos of tigers and predators, deployed sound systems or even worn animal masks to intimidate the invaders. M Sivaram from Raghunadhapalem shared, "I wear a mask to scare them, but they have grown fearless.

Another farmer, G Nageswara Rao, hired a guard for `10,000 per month, but monkeys now attack the guard also. "No one wants this job anymore," he admitted.District Panchayat Officer R Ashalatha said financial constraints have prevented them from implementing solutions. "Professional monkey catchers demand at least `500 per animal, but funds are scarce," she added.

## Appointment of information commissioners subject to outcome of plea, says Karnataka HC

BENGALURU. The Karnataka High Court on Tuesday said the appointment of state chief information commissioner and information commissioners by the state government will be subject to the final outcome of the petition challenging their appointments. Referring to the oath taken by these officers on Tuesday evening, the court said the state and all the appointees are put on notice that merely because they were sworn in today, it should not preclude the court from considering the interim prayer made by the petitioner and the court may issue appropriate orders

Justice R Devdas passed the order after hearing the petition filed by K Mallikarjuna Raju from Bengaluru, questioning the notification dated January 30, 2025 by the state government appointing former IPS officer Ashit Mohan



Prasad as the state chief information commissioner and Raman K, Dr Harish Kumar, Rudranna Harthikote, Narayan G Channal, Rajashekara S, Badruddin K and former IAS officer Dr Mamatha BR as state information commissioners.

The court issued notice to all the appointees while adjourning further hearing to February 10. The petitioner contended that as per Section 15(3) of

the Right to Information Act, 2005, a committee comprising the chief minister, the leader of the opposition in the Assembly and a cabinet minister nominated by the chief minister may recommend to the governor the appointment of the state chief information commissioner and information commissioners. As per the Supreme Court judgment in the case of Anjali Bhardwaj, every state needs to have a search committee, which should scrutinise the applications.

Their recommendation has to be placed before the selection committee for recommendation. However, the state government has not complied with the directions of the Supreme Court, the petitioner claimed while also pointing out that Ashit Mohan Prasad did not apply for the post.

## Major fire in Odisha's Pujariguda CHC, no injuries reported

UMERKOTE. A major fire broke out in the godown of a community health centre (CHC) in Nabarangpur district reportedly due to an electrical short circuit, causing two oxygen cylinders to explode on Tuesday. The mishap took place in Pujariguda CHC under the Umerkote block. Under the impact of the explosion, the roof of the godown was blown away. Though many patients and their attendants were present in the CHC during the incident, no



one reportedly suffered any injury. Sources said at around 11:30 am, a hospital employee noticed smoke coming out from the godown and informed medical superintendent Dr Patita Paban Dwivedi. Immediately, five patients admitted to the indoor ward, located adjacent to the godown, and their attendants were shifted to safety. The CHC authorities then asked around 40 to 50 patients present in the outdoor ward to leave the hospital. As the blaze started to spread gradually, the security personnel deployed at the CHC tried to control it using fire extinguishers. However, their efforts went in vain. On being informed, fire service personnel from Umerkote reached the spot and managed to douse the fire.

Guided by French photographer Yannick Comier, he learned to channel personal expression into his work, piecing together the surreal chaos of Hieronymus Bosch's paintings, philosophical musings of Wal

Hieronymus Bosch's paintings, the philosophical musings of Walter Benjamin, and the critical lens of Susan Sontag.

The result? A body of work that feels both meticulously crafted and intuitively raw. His series 'Stopping by the Woods', an exhibition at Forum Art Gallery, Adyar, invites viewers into his journey through Tamil Nadu's mountains, blending artistic expression with documentary style to create surreal, dreamlike images that speaks to the soul. Arun's journey into photography is as layered and thoughtful as his work itself. "Early in my career, I approached photography as a way to earn a living, excelling in the



commercial world," he says. "However, after feeling like a 'production machine', I took a step back to reflect." This pause became pivotal, sparking his exploration of analogue techniques and photography's deeper history. An apprenticeship with large-format photographer Varun Gupta reintroduced Arun to the craft, encouraging experimentation and a slower, more meditative process.

'Stopping by the Woods' is an ongoing project which has been selected for a 45-day darkroom residency programme hosted by Chennai Photo Biennale. "The residency offers a unique opportunity to explore and experiment

with analogue photographic processes in a collaborative environment," he shares. The experience has allowed him to deepen his practice and develop fresh perspectives within his project. Today, Arun's practice delves into themes of identity, memory, and the passage of time, concepts he translates into deeply evocative imagery.

## Foot bridge at Greater Noida West's busiest intersection to open this month

Noida. The Greater Noida Industrial Development Authority (GNIDA) has completed the main structure of the foot overbridge near Gaur Chowk. Final touches, including the installation of lifts, are underway and the facility will likely be open to the public by the end of this month.Officials inspected the overbridge site, which is located near the Gaur City Mall, and directed workers to complete the remaining work by the end of month.

For years, pedestrians have risked their safety by crossing the high-speed traffic zone on foot in the absence of a designated crossing. Residents said that the new foot overbridge will not only enhance pedestrian safety but also reduce congestion and prevent jaywalking.

'This is one of the busiest intersections in Greater Noida West. In the absence of a foot overbridge, crossing the road was a daily struggle. With this overbridge, commuting will be much safer and more convenient," said Amarjeet Rathore, a



resident of Gaur City. Punit Kohli, a resident of Saya Zion in Gaur City, said that this overbridge was much needed. "A number of people cross Greater Noida West Link Road to come to

Gaur City Mall. However, a foot

overbridge is also needed on the Taj Highway, which connects to different residential towers in Gaur City. The population of the area has immensely increased but not the infrastructure in that ratio," he added.GNIDA additional CEO

Traffic snarls at Gaur Chowk are a daily occurrence, especially in the evenings, when vehicles from the six-lane Parthala flyover slow to a crawl, leading to massive congestion. While the Parthala flyover was initially expected to decongest traffic at Parthala Chowk, it has

instead shifted the bottleneck further ahead toward Gaur Chowk.

#### 30 illegal colonies razed, 172 FIRs lodged in Ghaziabad in 1 year

Ghaziabad. The Ghaziabad Development Authority has reclaimed more than 60,000 sqm of land through its anti-encroachment drives over the last year. More than 30 illegal colonies have been razed so far as part of the drive."Between Jan 1, 2024, and Jan 17, 2025. GDA carried out anti-encroachment demolition drives across all its eight zones. A total of 87 illegal structures and hutments were razed and over 60,000 sqm of land was reclaimed from land grabbers and secured," a GDA official said. In addition to demolition drives, officials have also carried out sealing of illegal structures, registered FIRs against individuals found encroaching spaces and handed



out fines."FIRs were filed in 172 cases in different police stations. We also managed to seal 280 structures and issued challans in 785 cases. An amount of Rs 29.36 crore was collected as a compounding charge," the official added.

Anti-encroachment drives were also necessitated to increase the land bank, which the development authority may require for its Harnandipuram township project. GDA will need 501 hectares of land for its township, out of which 11 hectares are already under the purview of the development authority."While the demolition drive has been carried out across the district, it was mostly in areas like RNE, Duhai, Basantpur Seinthli, Muradnagar, Modinagar, and Navipur areas. These areas are in proximity to the proposed township and also fall under the TOD zone," the official further explained.

This has been GDA's most sustained drive to reclaim its land in the last few years. In 2021, GDA had identified 321 illegal colonies across the city, which included Brij Nagri, Nandini Enclave, Durga Enclave, and Pandav Nagar.In previous years, cracking the whip on illegal structures, the GDA had unilaterally banned the registration of land or properties that came up in designated illegal colonies. GDA had contended that the stamp and registry department should verify the land records and documents before executing land registries on lands and colonies that were encroached upon.

#### Sectors & villages: Adjacent, but worlds apart the sectors have been built by Noida

**Noida.** Along many of the city's wide streets that draw neat grids around its sectors lie the parallel world of its villages. Village can be a misnomer here — these are as integral to the city as the highrise hubs that have become Noida's identity and as urban as it gets, be it broadband speed or access to metro.But it's the state of amenities that put them a world apart from their adjacent sectors. Villages such as Chhalera in Sector 44, Salarpur in Sector 101, Mamura in Sector 66, Atta in Sector 27 and Behlolpur in Sector 63 have endured poor civic conditions for decades even as they have prospered through real estate and commerce. Take, for instance, Atta village in Sector 27 illustrates a stark contrast between urban areas, situated right across upmarket showrooms and shopping centres. Recently, villagers near these upscale areas protested against what they term "focus on urban sectors". However, Noida Authority officials assert that they routinely

carry out several drives in residential

sectors and villages under 'Noida Apke Dwar' initiatives to tackle civic problems. Although exponential growth in population partly explains deteriorating infrastructure in numerous villages, the overall situation remains inadequate.In certain villages, like Salarpur Khadar, authorities acquired villagers' land for development, yet failed to deliver on promises. Residents also highlight the absence of a village head, who earlier served as an intermediary between officials and locals, following the notified status given to numerous villages. Despite the initial master plan ensuring equal treatment for urban and village areas, substantial work remains pending for residents. The disparity between these neighbouring areas persists, although the Noida authority might not acknowledge these differences. Speaking about Bahlolpur, situated near industrial sectors 63 and 65, president of Noida Village Residents Association (NOVRA) Ranjan Tomar said, "While

Authority on the plots adjacent to the villages, locals have been treated unfairly. This is not just now but ever since Noida was established."Chhalera village, with a population of 80,000 to 90,000, is located near the premium Sector 44, with its post office in Sector 37. Around 20 to 30 years ago, a large number of those who moved here included civil labourers and contractors, as the village witnessed major developments near Sector 18. Despite the presence of Amity University, Asian Business School, and techies living in nearby areas, the village lacks reinforced cement concrete roads, Ganga water, a primary school, a community centre, and functional sewers and drains. "Sewage lines were installed about 30 years ago when the population of the village was almost one-fifth of the current count," said Puneet Rana, a resident of Chhalera.Rana said areas remain infested

#### Builders can't deduct over 10% of base price in case of cancellation by homebuyers, says Supreme Court

New Delhi. Holding that one-sided agreement between homebuyers and real estate companies which is totally tilted in favour of the developer cannot be enforced, Supreme Court on Monday said that developers cannot deduct unreasonable amounts if the buyer seeks cancellation and it should not be more than 10% of basic sale price (BSP). A bench of Justices B R Gavai and S V N Bhatt said the contractual terms which are ex facie one-sided, unfair and unreasonable would constitute unfair trade practice as per the aforesaid definition of unfair trade practice and turned down the plea of real estate company Godrej Projects Development Ltd which said it should be allowed to forfeit 20% of the amount which was part of the agreement with a buyer.Referring to

various verdicts of the apex court, the bench said, "It can be seen that this Court has held that if the forfeiture of earnest money under a contract is reasonable, then it does not fall within Section 74 of the Indian Contract Act, 1872, inasmuch as, such a forfeiture But the bench said that the apex court does not amount to imposing a penalty. It has further been held that, however, if the forfeiture is of the nature of penalty, then Section 74 would be

applicable. This Court has further held that under the terms of the contract, if the party in breach undertook to pay a sum of money or to forfeit a sum of money which he had already paid to the party complaining of a breach of contract, the undertaking is of the nature of a penalty". The court was hearing an appeal filed by the company challenging an order passed by NCDRC which had ordered that it cannot forfeit more than 10% of the amount. It contended that forfeiture of 20% was part of the agreement and there was nothing wrong to enforce it.

and NCDRC in many cases held that forfeiture of 10% is reasonable and above that amount should not be allowed. "Relying on the aforesaid observations of this Court, the NCDRC, in a series of cases right from the year 2015, has held that 10% of the BSP is a reasonable amount which is liable to be forfeited as earnest money. The NCDRC has initially taken this view in the case of DLF Ltd. v. Bhagwanti Narula. The said view has been followed subsequently in various

## How 16-year-old murder case took cops to Bihar, made them pose as labourers

Noida. From camping at a remote village in Bihar's East Champaran to dressing up as workers at a construction site, it took cops 23 days to reach a man accused of killing a toddler 16 years ago in Noida.

Additional DCP (Noida) Sumit Shukla said the multiple police teams have worked on the case over the years, many came very close to cracking it too, but each time the accused managed to give them a slip.

In 2009, Sanjay electrocuted a 2-year-old boy, the son of a woman he was seeing at the time, and flung him onto the floor, killing him on the spot, apparently after the child spotted them together. Since then, Sanjay has been on the run — never staying in one city for long, assuming a new name and identity, and refraining from using mobile phones to stay off the police radar. The breakthrough finally came after a four-member team was set up under sub-inspector Jaydeep Malik in Jan by Sector 58 SHO Amit Kumar, where the FIR was registered in July 2009 by the child's father.

The team camped in Bihar for days, narrowly missed the suspect twice as he fled to Nepal, set up a string of informers among local residents and even dressed as construction workers to track, follow and nab Sanjay, who now called himself Nitesh Kushwaha and worked as an electricity supervisor at a highway being constructed between Pakhri Dayal and



Dhaka Vihar in Champaran."It is an old case. Most of the officers investigating the case then have retired or transferred. After being assigned the case, I spoke to some of the previous investigating officers to get some leads on Sanjay, his appearance who was just 27 in 2009," Malik said. Around 23 days ago, Malik and his team —head constable Parwinder Kumar and constables Sachin Rathi and Anuj Sehrawat — visited Bihar's Bokane Kala village in East Champaran district, nearly 1,100 km from Noida."We hit the first hurdle almost instantly. The locals were unwelcoming and treated us as outsiders. As repeated attempts to build rapport with the locals failed, we dressed

as workers to blend among the people working at the highway construction site to find out more about Sanjay's daily movements. We would sit among the workers for hours and follow him for days to ensure he did not go out of the radar," Malik said.Cops said Sanjay would start from his house around 9 am on a bike each day to reach the work site around 15-17 km away. He would leave for home at 7 pm. At times, he would often stay back at campsite, about 2km from the construction spot."We decided to nab him at the campsite to keep the operation lowkey. But on D-day, we hit the second hurdle: Sanjay had disappeared right in front of our noses. We later learnt that he

got information about our movement from a relative and fled to Nepal, barely 20 km away. Subsequently, the team was asked to return to Noida. But before returning, we were able to set up informers in the village," another member of the probe team said. Around 15 days ago, Malik got a tip-off on Sanjay again and the team was back in Bihar. "But the accused didn't show up as the construction site was closed for two days. Then we got to know that Sanjay had fled to Nepal again. We changed our set of informers and put a watch on his house. We found that Sanjay was married and had five children. He earned Rs 12,000 monthly for the highway project," the SI said. On

Feb 2, informers told the team that Sanjay was likely to travel to Noida to check why cops had become so active over the past few weeks. "Our teams started tracking him and on Monday, Sanjay was nabbed from Sector 62," the additional DCP said.Sanjay told interrogators after the murder he took a train from Noida. "He claimed to have lived in many places before returning to Bihar, where he initially worked as a TV mechanic. When cops visited his village, Sanjay's friends and family would alert him and help him flee to Nepal," Shukla said. On Monday, he was produced before a local court and sent to judicial custody.

#### 24 Ghaziabad police stns get top rankings for tackling online complaints in January

Ghaziabad: A total of 24 of 25 police stations in Ghaziabad have achieved top state rankings in the Integrated Grievance Redressal System (IGRS) in Jan. These stations scored 100% of the 90 marks awarded for efficiently and swiftly resolving residents' complaints on the portal. Vijay Nagar, which was a table-topper in Dec, scored lower than 80% and ranked 1,590th in the state. The 24x7 IGRS portal, which makes filing complaints flexible, facilitates quicker responses to grievances and allows real-time tracking of complaints, was launched in 2016. It typically redresses complaints on land-related disputes, corruption, cyber fraud and cheating. The rankings, released by Lucknow headquarters on Tuesday for districts and police commissionerates, show Ghaziabad commissionerate resolved the highest number of complaints logged on the IGRS portal in Jan and scored 100% marks out of 125.In Dec too, the commissionerate was ranked number 1 in the state, with 21 of the 25 police stations scoring 100%. The four police stations that ranked below 1,300 were Sahibabad (1,482), Ankur Vihar (1,448), Indirapuram (1,394) and Tronica City (1,307). This month the four police stations are among the 24 that

achieved 100% score out of 90 points in the district. The other top scorers include Kavi Nagar, Madhuban Bapudham, Nandgram, Modinagar, Nagar Kotwali, Loni, Sihani Gate, Loni Border, Masuri, Wave City, Crossings Republik, Bhojpur, Tila Mod, Niwari, Shalimar Garden, Link Road, Kaushambi, Women's Police Station and Muradnagar. Vijay Nagar police station, which secured 100% marks and ranked number 1 in Dec last year, scored 71 out of 90, which is only 78.9%, in Jan. Police commissioner Ajay Kumar Mishra told TOI that the commissionerate secured the first position in the state five times in resolving public complaints and was also consistently at the top for being the quickest to respond to Dial 112 complaints for the past 21 months. "We will review why Vijay Nagar police station is lagging and improve its performance," Mishra said. In Dec, the average response time for police to respond to emergencies flagged on Dial 112 number across the state was 6.4 minutes. In Ghaziabad, the average response time was 3.3 minutes.

#### FIR against mills if flour causes illness

Noida. The food safety department has issued a strict warning to eight buckwheat flour manufacturers, prohibiting the sale of products older than 15 days. Preventive measure comes ahead of Mahashivratri on Feb 26, when devotees traditionally consume breads made from buckwheat (kuttu) flour to break their fasts.

Sarvesh Kumar, assistant commissioner of the food department, asserted that manufacturers found selling substandard buckwheat flour would face legal consequences. "We will get FIRs registered against manufacturers if people fall ill from consuming stale or adulterated flour. Our inspection teams are vigilant," he said. Food safety officials said they would conduct random sampling of buckwheat flour from markets across the city in the days leading up to Mahashivratri to ensure compliance with safety standards. The heightened vigilance follows a series of food poisoning incidents in recent years. In March last year, over 200 people — including hostel students in Greater Noida — fell ill after consuming contaminated buckwheat flour during Mahashivratri. In similar incidents through 2023, 150 people across NCR suffered food poisoning from adulterated buckwheat flour during the festive season. According to sources, cases of food poisoning from stale buckwheat flour have increased 40% during the festive season in the past five years."On March 9, 2024, around 250 students from Aryan Residency and APJ College hostels became ill after consuming puris made from stale buckwheat flour," Kumar said.Food safety department also issued guidelines for consumers, emphasising the importance of purchasing fresh, properly packaged buckwheat flour from reputable

#### Gurgaon leads in TB detection in Haryana, cases up by 23%

Gurgaon. The city leads in detecting tuberculosis (TB) cases in Haryana from 2023 to 2024 even as the aggregate TB cases in the state escalated from 79,160 in 2023 to 86,171 in 2024, indicating an 8.86% increase.

In fact, Gurgaon, Kurukshetra and Faridabad have exhibited substantial increases in TB case detection, with gains of 22.93%, 18.50% and 17.33% respectively, according to the health department data. Besides other factors — such as surveillance and better testing methods — urban districts like Gurgaon and Faridabad benefit from "superior healthcare infrastructure, including well-equipped hospitals and clinics for TB management", officials said.

District-wise, Gurgaon TB cases increased from 7,605 in 2023 to 9,349 in 2024. Kurukshetra TB cases were up from 2,092 in 2023 to 2,479 in 2024. Faridabad TB cases were 8,031 in 2023 that went up to 9,423 in 2024.

The considerable surge in TB cases across these districts isn't solely attributed to increased infections but reflects enhanced surveillance and reporting mechanisms.Officials indicate multiple contributing factors, encompassing amplified testing, screening protocols, healthcare infrastructure and public awareness. Speaking to TOI, officials elaborated that these districts have intensified their TB testing and screening endeavours, facilitating improved case identification. Mobile testing units and community health workers have been instrumental in reaching marginalised populations. Public health initiatives have heightened awareness regarding TB symptoms and early detection significance, prompting increased voluntary testing. Chief medical officer (Gurgaon) Virender Yadav said, "We have been conducting Interferon-Gamma Release Assay (IGRA) tests for TB screening for the last two years. Earlier, we utilised lesssensitive TB screening tests that took more time to return results."The IGRA tests are whole-blood tests that diagnose the infection in 24 hours."IGRA tests, unlike others, do not cause a false positive because of BCG (Bacille Calmette-Guérin) vaccination.

#### CIA offers buyouts to its entire workforce: Report

WASHINGTON. The US Central Intelligence Agency offered buyouts to its entire workforce on Tuesday, the Wall Street Journal reported. The move would make it the first intelligence agency to join a voluntary redundancy program initiated by President Donald Trump for federal employees.

The agency is also freezing the hiring of job seekers already given a conditional offer, the paper reported, citing an aide to CIA Director John Ratcliffe.

The anonymous aide said some of those frozen offers are likely to be rescinded if the applicants do not have the right background for the agency's new goals, which include targeting drug cartels, Trump's trade war and undermining China, according to the Journal.he move is part of a massive overhaul of the US government by Trump, who has vowed to radically downsize the federal workforce in the name of efficiency and frugality that has sent shock waves through Washington.

The report on the buyout offers at the CIA -- whose work gathering foreign intelligence is vital to US national security -- came just hours after Trump announced an extraordinary scheme for the United States to "take over the Gaza Strip."

#### India Featured In UN's **Honour Roll For Timely** Payment Of Regular Budget



New York. The Permanent Mission of India in New York announced on Tuesday that India has once again been included in the 'Honour Roll' of the United Nations (UN) for paying its regular budget assessments in full within the 30-day period specified in the Financial Regulations of the UN.

In a statement, the Mission said, "India yet again featured in the 'Honor Roll' of UN as one of the countries that have paid their regular budget assessments in full within the 30 day period specified in Financial Regulation 3.5 of the UN. The Honour Roll includes select Member States that have successfully fulfilled their financial commitment to the UN within 30 days of receiving a payment note."

The UN General Assembly approves UN's Regular Budget in December each year. Each Member State is then assessed based on the Scale of Assessment approved by the General Assembly, and corresponding payment notes are issued by the UN in early January. The statement emphasized that India has consistently figured on the UN's Honour Roll."India's promptness in making contributions to the UN demonstrates its unwavering support to the principles and purposes enshrined in the UN Charter and commitment to upholding the financial stability and operational effectiveness of the UN", the statement highlighted adding, this further reaffirms India's role as a responsible member of the UN.

#### Iran Is Secretly Developing **Nuclear Missiles Capable Of** Hitting Europe, Claims Report



with the ability to reach Europe based on designs handed to the Islamic regime by North Korea, a new report released by the National Council of Resistance of Iran (NCRI) claimed. According to the report, the weapons are being produced at two sites disguised as satellite launch facilities. The NCRI, an exiled opposition group, said that Tehran is expediting its alleged nuclear weapons program at these facilities. It also stated that the missiles are capable of travelling more than 3,000 km (1,800) miles, potentially targeting Europe. Citing the report, the New York Post reported that one of the facilities the NCRI flagged as a nuclear weapons site was the Shahrud missiles facility, which is being run by Iran's Organization for Advanced Defense Research and Islamic Revolutionary Guard Corps (IRGC). The group believes that the nuclear warhead being developed at the site would be fitted on a Ghaem-100 missile and would be capable of reaching as far as Greece. It also estimates that Iran has already tested the rocket launchers at the Shahrud facility at least three times. Those rocket launches were allegedly concealed as part of satellite launches, the NCRI claims. It believes that IRGC is planning to test launch more advanced Ghaem rockets in the coming months. The second testing facility is believed to be located more than 43 miles southeast of Semnan, where Tehran is developing Simorgh missiles based on North Korean designs. In its report, the NCRI said that portions of this site are hidden underground. It also accused Tehran of expanding this site since 2005.

Tens of thousands of Palestinians flocked to the strip.Under Egyptian military control, Palestinian refugees in Gaza were stuck, homeless and stateless. Egypt didn't consider them to be citizens and Israel wouldn't let them return to their homes. Many were supported by UNWRA, the United Nations agency for Palestinian refugees, which has a heavy presence

in Gaza to this day. Meanwhile, some young Palestinians became "fedayeen"—insurgency fighters who conducted raids into Israel

during the 1967 Mideast war, when it also captured the West Bank and east Jerusalem—areas that remain under Israeli control. The internationally recognized Palestinian Authority, which administers semi-autonomous areas of the occupied West Bank, seeks all three areas for a

### Trump to sign executive order barring transgender female athletes in US from competing

WASHINGTON. US President Donald Trump will sign an executive order on Wednesday designed to prevent people who were biologically assigned male at birth from participating in women's or girls' sporting events. The order, which Trump is expected to sign at an afternoon ceremony, marks another aggressive shift by the president's second administration in the way the federal government deals with transgender people and their rights.

The president put out a sweeping order on his first day in office last month that called for the federal government to define sex as only male or female and for that to be reflected on official documents such as passports and in policies such as federal prison assignments.rump found during the campaign that his pledge to "keep men out of women's sports" resonated beyond the usual party lines. More than half the voters surveyed by AP VoteCast said support for transgender rights in government and society has gone too far. He leaned into the rhetoric before the election, pledging to get rid of the "transgender insanity," though his campaign offered little in the way of details. Wednesday's order-which coincides with National Girls and



Women in Sports Day-will involve how his administration will interpret Title IX, the law best known for its role in pursuing gender equity in athletics and preventing sexual harassment on campuses."This executive order restores fairness, upholds Title IX's original intent, and defends the rights of female athletes who have worked their whole lives to compete at the highest levels," said US Rep. Nancy Mace, a Republican from South Carolina. Every administration has the authority to issue its own

interpretations of the landmark legislation. The last two presidential administrations-including Trump's first—offer a glimpse at the push-pull involved.Betsy DeVos, the education secretary during Trump's first term, issued a Title IX policy in 2020 that narrowed the definition of sexual harassment and required colleges to investigate claims only if they're reported to certain officials. The Biden administration rolled back that policy last April with one of its own that stipulated the rights of LGBTQ+ students would be protected by federal law and provided new safeguards for victims of campus sexual assault. The policy stopped short of explicitly addressing transgender athletes. Still, more than a half-dozen Republican-led states immediately challenged the new rule in court." All Trump has to say is, 'We are going to read the regulation traditionally," said Doriane Lambelet Coleman, a professor at Duke Law School. How this order could affect the transgender athlete population—a number that is incredibly difficult to pin down-is uncertain.

#### US plane carrying 205 deported Indians to land in Amritsar in afternoona

AMRITSAR. A US military aircraft carrying around 200 illegal Indian immigrants is likely to land at the Shri Guru Ramdas Ji International Airport here on Wednesday afternoon.

Earlier, the aircraft was expected to land in the morning. So far, details of those on the plane are not available. According to reports, the US military plane C-17 is

carrying 205 illegal immigrants hailing from Punjab and neighbouring states.

Punjab Director General of Police (DGP) Gaurav Yadav said on Tuesday that the state government would receive the immigrants and set up counters at the airport.Punjab NRI Affairs Minister Kuldeep Singh Dhaliwal on Tuesday expressed disappointment over the US government's decision and said these individuals, who contributed to that country's economy, should have been granted permanent residency instead of being deported. He said many Indians entered the US on work permits which later expired, making them illegal immigrants. The minister said he plans to meet External Affairs Minister S Jaishankar next week to discuss the concerns and interests of Punjabis living in the US.

Dhaliwal had also appealed to Punjabis not to travel abroad through illegal means, emphasising the

### About 10 killed at adult education centre in what officials say is Sweden's worst mass shooting

World Swedish police said that about 10 people, including the gunman, were killed during a shooting Tuesday at an adult education center. But a final death toll and a conclusive number of wounded hadn't yet been determined. The damage at the crime scene was so extensive that investigators were unable to be more definitive, said Roberto Eid Forest, head of the local police. The shooting happened on the outskirts of the city of Orebro, which is located about 200 kilometers (125 miles) west of Stockholm.Police said that the death toll could rise. Eid Forest told reporters that the suspected gunman was among those killed. Police believe the perpetrator acted alone, and he wasn't previously known to police, officials said. Authorities said that there were no suspected connections to terrorism at this point, but police didn't provide a motive. The school, called Camus

exchange of WhatsApp messages between himself and Chauke that backed up his account. Chauke did not respond to questions by Reuters about his role in contacting Musk's father. Ramaphosa's office confirmed the phone conversation with Elon Musk, who was born in South Africa, in a post on the tycoon's X social media platform.Contacted by Reuters, Ramaphosa's spokesperson declined to comment on how the conversation with Elon Musk came about or on its content, only saying: "Errol Musk is a private citizen, his views are his personal views."Elon Musk did not reply to multiple requests for comment from Reuters. The trigger for the sudden flurry of backdoor diplomacy was a post on Sunday by Trump who said - without citing evidence - that "South Africa is confiscating land" and "certain classes of people" were being

#### Power distribution network to be revamped in Kovai

COIMBATORE. The Tamil Nadu Power Distribution Corporation Ltd (TNPDCL) formerly known as Tangedco will soon revamp 305 distribution lines under the Revamped Distribution Sector Scheme (RDSS) of the union government in the Coimbatore region which comprises Coimbatore, Tiruppur and Nilgiris districts. The field survey for the project, which is aimed at ensuring quality power supply and avoiding transmission loss, is at the final stages."The scheme suggests construction of new substations, augmentation of existing substations, provision of aerial bunched cables or high voltage distribution system in high loss areas, segregation and bifurcation of feeders, replacement of conductors, additional HT lines and under-ground cabling works and other related works for system strengthening and loss reduction. We are collecting data for reforming the distribution line," said a senior official.In Coimbatore Metro Circle, 28 feeders will be revamped under the project. "Out of 164 feeders, 28 feeders need to be revamped in the Coimbatore metro circle and the work would be carried out at a cost of Rs 4.3 crore. As per the plan, the corporation would install 193 new 11kv transformers and 14 22-kv transformers after bifurcating the existing pattern which reduces the electricity loss and pressure. Further, the corporation is going to install 350 new 9meter poles across the Coimbatore metro circle," said C Sathishkumar, superintendent engineer of Coimbatore

#### **Low-consumption consumers in** Kerala getting power at cheap rates': Study

THIRUVANANTHAPURAM. With the exception of domestic consumers with monthly consumption of over 400 units of electricity per month and above, household consumers in other categories pay comparatively cheaper power bills in Kerala, a study of the electricity tariff of various states conducted by Kerala State Electricity Regulatory Commission has shown.According to government sources, the lower power tariff for industries has also contributed to its transformation into an industry-friendly state.

In the agriculture sector, Kerala offered the fourth best tariff in the country at Rs 2.79 per unit, also the best among all south Indian states. For electricity provided to Railways, the state was placed in the ninth position at Rs 7.16 per unit. However, the state's tariff for medium commercial establishments stood at Rs 10.68 per unit, which was quite higher in comparison to other states. For domestic consumers with a monthly consumption of 40 units, Kerala had the lowest energy charge in the country at Rs 1.50 per unit.

The corresponding tariff for other south Indian states were: Telangana (Rs 2.50), Tamil Nadu (Rs 4.80), Andhra Pradesh (Rs 6.95) and Karnataka (Rs 9.70).For domestic consumers with monthly consumption of 100 units, Kerala was ranked eighth with a tariff of Rs 4.67 per unit. Only Telangana topped Kerala among southern states in this category with a tariff of Rs 3.13 per unit. In the 250 units per month consumption category, Kerala was placed in the 12th position with a rate of Rs 6.40 per unit, with Tamil Nadu and Telangana offering lower tariffs among southern states.

#### **IIT-BBS, ECRICC to find ways for** seagrass restoration

BHUBANESWAR. IIT-Bhubaneswar in collaboration with the Enhancing Climate Resilience of India's Coastal Communities (ECRICC) on Tuesday organised a workshop to work out a plan for protection, restoration and management of seagrass and salt marshes that are vital to the state's ecosystem for carbon sequestration and coastal protection.UNDP India head for Energy, Environment and Resilience Ashish Chaturvedi provided an overview of UNDP Green Climate Fund (GCF) initiatives and the progress of the GCFsupported ECRICC project, while associate professor and head of School of Earth, Ocean and Climate Sciences at IIT-BBS SH Farooq outlined the scope of seagrass and salt marsh interventions, expected outcomes and deliverables.

Senior scientist at James Cook University, Australia Amrit Mishra spoke on stakeholder roles, timelines and capacitybuilding requirements for protection and restoration of seagrass and salt marshes in the state. ## Anna University sexual assault case: Madras HC pulls up Tamil Nadu police's SIT for harassing journalists

CHENNAI. The Madras High Court on Tuesday restrained the Tamil Nadu police's Special Investigation Team (SIT) from harassing journalists by issuing repeated summons, grilling them with unnecessary questions about their families and seizing their electronic devices — including mobile phones — in connection with the case over the leaking of the FIR in the sexual assault of a student inside the Anna University campus.

The HC ordered the SIT to return the seized electronic devices while directing the journalists to cooperate with the investigations. The court also questioned why the SIT has not examined the police officers responsible for registering the FIR and uploading it to the official website.Justice G K Ilanthiraiyan passed the orders while hearing a batch of petitions filed by the affected journalists, belonging to mainstream television channels and a newspaper.

The judge posed a series of questions to the government advocate K M D Muhilan who represented the SIT. "How many people have you examined other than the journalists? Have you examined the officer who authored the FIR and uploaded it to the website," he asked, stating that the first person to be examined must be the Station House Officer who registered the FIR."Before examining others, why are you harassing the journalists," the judge questioned.Pointing out that only police personnel can upload the FIR to the website, Justice Ilanthiraiyan said there is no question of



forwarding the document when it was available in the public domain.

He asked whether the media published news revealing the identity of the victim, and flayed dvocates M R Jothimanian, K Balu, the SIT for asking details of the journalists' families, including those of their "forefathers". Government advocate Muhilan denied the

journalists' complaints being harassed, stating the SIT had just inquired with them about downloading the FIR and sharing it with others. "We are not trying to curtail the freedom of

We don't intend to harass and go after them," he told the court. He promised the court of sorting out irrelevant questions posed to the journalists

 via a questionnaire — and addressing their concerns. The SIT is simply tracking how the FIR went out, Muhilan added

#### Tamil Nadu: Misguided by officers, PwD travels 200 akm in two days for certificate that was not necessary

COIMBATORE. Misguided by officers at the Anaimalai taluk office, a tribal man living in Pollachi travelled for nearly 200 km in two days carrying his 40year-old sister, who cannot walk due to locomotor disability, to several government hospitals to obtain a disability certificate and get her government aid reinstated. After checking their records, the CMCH dean said the issue should have been solved in Anaimalai itself. The aid was reinstated on Tuesday. Seven months ago, the differently abled welfare department suspended assistance of Rs 1,500 to K Kittathal, a Malasar tribe who lives in Divansapudur village with her brother K Mani (44), because the officers who conducted a door-todoor verification had recorded that she did not live in the address.

After pursuing the case with local body representatives, Mani approached officers at the Anaimalai taluk office recently . Without checking the facts, the officials told him to get a fresh disability certificate for Kittathal from a government hospital. On Monday, the family went to the Pollachi GH but found out that the post of the doctor who would approve the certificates was vacant. They were directed to go to Coimbatore Medical College Hospital. "On Monday afternoon, we reached CMCH after changing three buses, but the staff told us to come on Tuesday because the board that issues certificates meets only in the morning. We came back on Tuesday," Mani said.After learning about their hardship, this reporter took up the issue with CMCH dean Dr A Nirmala. After reviewing their records, she said Kittathal's existing disability certificate was valid till her life time and she need not get a new certificate.

To confirm this, the family was directed to the differently abled welfare department located in the collectorate. There staff reiterated that a new certificate was not required and told them to resolve the matter at the Anaimalai Taluk Office. When questioned, the special tahsildar (social security scheme) S Alamelumangai said she was unaware who misled them

### Speeding goods train halts inches from slum, averts major tragedy in Rourkela

ROURKELA. A major tragedy was narrowly avoided in Rourkela when a speeding goods train broke through barriers and came to a halt just inches away from a slum household in the Malgodown area early on Wednesday morning.

Slum dwellers were left panicked and shocked as they spotted the train hurtling toward them. Had it not stopped on its own, with its wheels stuck in soil and debris, a disaster in the densely populated settlement seemed inevitable.

According to reports, the incident occurred between 6:00 and 6:15 am when the goods train was being placed at the warehouse in Malgodown. Eyewitnesses said the train broke through the track buffer, destroyed the protective boundary wall, and ploughed through the paved road on its western side



before stopping dangerously close to a slum dwelling." As the goods train forced its way towards the slum, panicked residents ran for their lives, but nothing could stop the locomotive. Everything happened in a fraction of a second, and the train stopped on its own," an eyewitness recounted.

The warehouse is several metres away from the Howrah-Mumbai main line and is connected to loop lines. Local railway authorities from

Rourkela and Bondamunda, including the Area Manager, rushed to the spot to assess the situation.Senior Divisional Commercial Manager and spokesperson for the Chakradharpur division of South Eastern Railway (SER), Aditya Chaudhury, said the mishap occurred during rake placement in the warehouse for loading and unloading goods.He

confirmed, "The goods train broke through the buffer and the boundary wall and went about 50 metres beyond."

When asked how the train could have reached such high speed during rake placement, Chaudhury admitted human error, adding that an inquiry has been launched to determine the reasons and circumstances behind the incident for appropriate action.

## Railway Board seeks location survey for all seven corridors of Circular Rail

BENGALURU. The Railway Board recently responded to the Detailed Project Report submitted by Bengaluru Division for one corridor of the Rs 23,000-crore Circular Railway network, by asking it to first complete the Final Location Survey (FLS) for all seven corridors. The 287-km network is aimed at increasing Bengaluru's rail capacity and decongesting train traffic. The FLS is the final stage of any survey, and outlines detailed plans accurately, marking the alignment, precise locations and grades of the project. This is followed by the Detailed Project Report (DPR) and then construction commences.

The proposed project is one of the biggest circular networks in the country and will cover the outskirts of Bengaluru by connecting Heelalige, Solur, Malur, Devanahalli, Doddaballapur and Nidavanda.Divisional Railway Manager Amitesh Kumar Sinha told TNIE that the division had submitted the FLS followed by the DPR for one corridor to the Board, by the end of last year. "The DPR had exhaustive information on the corridor from Devanahalli to Oddarahalli, running 28.5km. We were awaiting the nod



from the Railway Board in this connection," he said. The Board has now asked the division to complete the FLS for the remaining six corridors of the project before proceeding with the single corridor. "It is a circular rail and unless all the corridors are completed, the project would anyway be incomplete," the DRM explained.

## 180 nursing students crammed in building meant for 30 in NLG

NALGONDA. Students living in the hostel of the nursing college for girls in Nalgonda face a host of issues, which range from inadequate infrastructure to a lack of basic facilities and neglect in upkeep.Sources said that the hostel, spanning approximately 12,000 square feet and being rented at Rs 84,000 per month, was originally designed to accommodate only 30 women in various trades. However, it now houses all 180 students, leading to severe overcrowding.

Students have raised concerns about poor maintenance, lack of cleanliness and inadequate facilities. Many are forced to sleep on the floor due to space constraints, while some first-year students share single beds, a student said, adding that the hostel also lacks a water purification system, forcing students to buy drinking water on their own.Despite being sanctioned by the previous BRS government, the nursing college has been operating without a dedicated building for the past three years. Established in 2022 in the heart of Nalgonda, the college lacks essential infrastructure, such as adequate academic and hostel facilities.

Currently, 180 students across three batches are enrolled. First- and secondyear classes are being conducted in vacant classrooms of the medical



college, while the hostel is situated in a women's campus building about four kilometres from the college.

ATo add to their struggles, third-year students have to attend classes in the hostel's dining hall due to a shortage of classrooms and labs. First- and secondyear students rely on vacant classrooms at the medical college, but these are only available when not occupied by medical students. Some first-year students have even reported waiting in corridors or under parking sheds for classrooms to become available.

A college official stated, "Due to the lack of proper accommodation, 60 thirdyear students are staying in private rooms and hostels. Although the Congress government has allotted five acres near the medical college for the nursing college, construction is yet to begin. We urge the government to speed up the construction of the college and hostel."Apart from infrastructure issues, students also struggle with transportation. With no dedicated bus service, they must walk nearly half a kilometre to reach the main road and rely on auto-rickshaws to commute to college. Many students report missing classes due to a lack of auto-rickshaws, especially in the evenings when transport options are limited. The students submitted a representation to the district collector, who assured them that a bus would be arranged.

## Rising Vannamei shrimp seed prices threaten Nellore farmers' livelihoods

**NELLORE.** The steady rise in Vannamei shrimp seed prices has become a major concern for aqua farmers in the region. Until recently, shrimp seed was available at affordable rates, but increasing demand for high-quality seed and broodstock has driven up prices, making shrimp farming less viable for many farmers.

Previously, Vannamei shrimp seed was priced at 30 paise per seed in hatcheries across the erstwhile Nellore district. However, citing quality concerns, hatcheries have now increased the price to over 41 paise per seed. With prices rising almost daily, farmers are left uncertain about whether shrimp farming

will remain profitable. As per the prices 20 days ago, it costs around Rs 48,000 for 1,60,000 Vannamei shrimp seeds in an acre on average. With the surge in prices, it costs Rs 65,600 to cultivate the said variety. With indications of future price hikes, the regional aquaculturists are urging the State government to intervene and regulate the prices."The cost of seed is rising too fast. If this trend continues, small-scale farmers like us may struggle to continue shrimp farming," said Ramesh Babu, an aqua farmer from Vakadu. Last year, aqua farmers in coastal regions such as Kota, Vakadu, Chittamuru, and Chillakur declared a "crop

holiday" for shrimp farming due to unfavourable weather conditions. Now, with temperatures improving and conditions becoming favourable for shrimp cultivation, farmers have started preparing their ponds again. However, hatchery owners have seized this opportunity to increase seed prices. The increasing shrimp seed prices and crop holiday last year have compounded their financial woes.

Broodstock (parent shrimp) for Vannamei shrimp is imported from the USA, Taiwan, Indonesia, and Japan to hatcheries in Puducherry and Tamil Nadu, where shrimp seed is produced. Hatchery owners claim that the increasing cost of importing highquality, disease-free broodstock has contributed to the price hike. Nellore district plays a crucial role in Andhra Pradesh's shrimp exports. The State produces around 6.34 lakh metric tonnes of shrimp annually, with Litopenaeus Vannamei being the dominant variety. Earlier, Tiger shrimp farming was highly profitable in the region, but the industry suffered major setbacks in 2000-2001 due to diseases like White Spot Syndrome. As a result, farmers switched to Vannamei shrimp from 2003 to 2016, which yielded high profits without major disease

#### Trump's migrant crackdown sparks trade wars

Four days after his second inauguration, US President Donald Trump signed the Laken Riley Act. It provides for the arrest, detention and deposits the second inauguration of illustrations of the second inauguration. deportation of illegal immigrants charged with minor crimes, such as minor theft, shoplifting, assault or bodily injuries to another person, without waiting for a conviction by a legal court. The signing of this Bill reflects the hardening of sentiments among certain sections of the American people whose votes had steered Trump to victory in the recent presidential elections.

Among the measures that Trump has taken to crack down on the undocumented migrants in the US is the provision of military aircraft to deport thousands of arrested migrants. Additionally, 1,500 troops have been deployed on the US-Mexico border to monitor the incoming illegal migrants and install barriers to stop them.

Also, the entry of undocumented migrants to the US has been suspended, their right to seek asylum tightened and the powers of the Immigration and Customs Enforcement personnel to arrest and detain the illegal migrants on the US soil expanded. On February 1, Trump imposed 25 per cent tariffs on imports from Canada (10 per cent tariffs on import of Canadian Energy) and Mexico, citing national security concerns due to illegal immigration and drug trafficking, particularly of fentanyl. The accusations against Mexico are that its government provides safe havens to powerful drug cartels involved in the manufacture and transportation of dangerous narcotics. The Chinese goods will face 10 per cent tariffs as "China allows the transnational criminal organisations to engage in money-laundering activities which finance the drug trafficking networks."The Trump administration has said that unrestricted access to the US market is a privilege and leveraging tariffs is a powerful tool it would use to compel foreign governments to take stronger actions against illegal immigration and drug trafficking. Canada, Mexico and China have stated that their governments have taken meaningful actions to stop illegal migration and drug trafficking and they are willing to discuss further coordinated actions with the US government.Canadian PM Justin Trudeau has announced retaliatory tariffs of 25 per cent tariffs on US imports worth \$30 billion immediately and \$130 billion in 21 days.Mexican President Claudia Sheinbaum has ordered her Economy Minister to implement tariff and non-tariff measures against the US to defend her country's interests. She has denied the slander made by Washington that her government was working in an alliance with the drug trafficker cartels. She clarified that they had seized 20 million doses of fentanyl and detained one lakh persons tied to drug trafficking.

China has deplored the US tariffs and said that it would take necessary countermeasures, including complaining to the WTO against the wrong US practices. While Trump's policies primarily target illegal immigrants from Canada, Mexico and Central American countries, there are reportedly about 7,25,000 undocumented Indians in the USA, mainly from Punjab and Gujarat, and the Indians comprised about 3 per cent of all illegal border crossings in the US in 2024. The Indian government has clarified that it does not support illegal immigration anywhere and it would accept any illegal immigrants proven to be Indians. After a phone call with PM Modi on January 27, 2025, Trump said India would do "what is right on the deportation of the illegal immigrants."On the issue of H1B visas, there are differing views among Trump's core supporters. While the big business represented by Tesla owner and important Trump supporter Elon Musk favours the continuation of the H1B programme as it fosters innovation and excellence, others like Steve Bannon oppose it as it takes away jobs from the Americans. As the highly qualified foreign immigrants bring rich skills which are different from those of the natives and help create new businesses, jobs and increased consumption, the Trump administration is yet to order any major change in this programme.

#### Defence budget grows, but combat deficiencies persist

The defence allocation for FY (financial year) 2025-26 has been pegged at Rs 6,81,210 crore, which is about \$78.7 billion. This not-so-insignificant amount is 13.45 per cent of the total Central government expenditure (CGE) and has been estimated to be 1.91 per cent of the national GDP. However, there was no mention of the defence allocation in the Budget speech and this opacity is intriguing. Notwithstanding the 'invisibility', this amount needs to be contextualised against various other parameters and the net distillate is that this allocation falls below the optimum fiscal allocation needed to ensure that the combat capability of the Indian armed forces is at an appropriate level. At the global level, in 2024, the military spending of the USA was \$916 billion and China ranked second at \$296 billion. merits recall that in 2018, the Standing Committee on Defence (SCOD) had recommended 3 per cent of the GDP as the benchmark for the Ministry of Defence to enable the steady irrigation and nurturing of the national ecosystem required to ensure the desired level of preparedness of the armed forces.owever, this remains an elusive figure and over the last four years — from 2020-21 to the current FY — the trend has been a declining curve. The defence allocation to GDP percentage has dropped from 2.4 in 2020-21 to 1.91 in 2025-26. This gap has been highlighted over the years, but it is evident that a political decision has been taken by Team Modi that defence allocation will remain depressed even though the regional geopolitical environment and the internal security challenges remain complex and demanding.

The SCOD, in 2018, had also recommended that in the case of the Army — the lead service, which is manpowerintensive — the equipment/inventory mix should ideally be 30 per cent new equipment, 40 per cent current equipment and 30 per cent older-generation equipment.

But the reality is grim. In March 2023, the Army, in a candid disclosure, apprised the standing committee "that only 15 per cent of the Army's equipment can be categorised as new equipment, while nearly 45 per cent continued to be older equipment." The Army representative also informed the parliamentary committee that "there is some time to go before we reach the ideal state of 30:40:30."

The composite combat capability of the Indian military has been denuded over the last decade due to inadequate fiscal allocation and indifferent strategic planning. This has been further compounded by the unrelenting, highdecibel focus on 'atmanirbharta' (self-reliance). While the latter objective is indeed desirable when India is seeking a place at the global high table, the reality is not encouraging in terms of combat capability versus indigenisation and self-reliance.M Modi assumed office in 2014 with a commendable resolve to reform India's defence and military sector and identified 'atmanirbharta' as a core mission. A decade later, the overall picture is mixed and opaque.



broad review reveals that while the objective has had a few success stories and some major projects are in the pipeline, the Indian military is dotted with significant inventory deficiencies. These include an army that is short of artillery guns, tanks and personal weapons; a navy waiting for carrier-compatible fighter aircraft and modern underwater platforms; an air force that is woefully short of combat aircraft and a DRDO (Defence Research and Development Organisation) that is unable to deliver as promised.r realising the twin objectives of combat capability and indigenisation, the capital outlay of the defence budget is a critical indicator. An optimum figure is upwards of 35 per cent and here, the picture is bleak. In the current allocation of Rs 6,81,210 crore, the capital outlay is Rs 1,80,000 crore, which is under 27 per cent. An excellent PRS (Parliamentary Research Service) report of July 2024 has highlighted the fact that this capital outlay share "has declined between 2014-15 and 2023-24 to less than 30 per cent of the defence budget." The allocation for this FY is in keeping with this trend line and is unlikely to change in the near future.



planning for a military that is plagued by obsolescence and inventory shortage and must be redressed.

R&D is at the heart of acquiring the much-desired level of technological competence in strategic sectors of national endeavour and here, the Indian space and nuclear domain are islands of proven success. However, the DRDO trajectory in relation to enabling the military to move up the 'atmanirbharta' ladder has been poor. The PRS 2024 report notes that several projects undertaken by the DRDO have been marred by delays and adds: "In an analysis of 178 DRDO projects, CAG observed that 119 projects did not adhere to the original timeline. In 49 projects, the additional time taken was more than the original schedule which was envisaged. Projects have been declared as successful despite them not meeting one or more key objectives and parameters."Year after year, the defence budget goes through this phase of transient scrutiny in the public domain and even while deficiencies are highlighted, the standard refrain is that if there is a need, the purse strings will be opened. This is reactive posturing and when the chips were down, as in Kargil 1999, national sovereignty was retrieved by the loss of life and limb.redible military preparedness to deter the adversary from adventurism of any kind cannot be realised by prioritising visibility, spectacle and opacity.

### **Battleground Delhi**

BJP looks to turn the tables on AAP



The wily Kejriwal has managed to deflect attention from the 'Sheesh Mahal' row and the corruption charges against him by accusing the BJP government in Haryana of 'poisoning' Yamuna water supplied to Delhi. A notice, promptly issued by the Election Commission on the BJP's complaint, has



forced him to clarify that he was referring to "unprecedented high levels of ammonia in raw water". Nevertheless, BJP leaders have expended a lot of time and energy on refuting one conspiracy theory after another. This has helped AAP regroup and refocus ahead of voting day.

In this high-stakes battle, the BJP has not shied away from taking the revdi route to woo the electorate. Curiously, voters of the national capital have been resisting the temptation of electing a double-engine government; the Modi magic has been confined to the Lok Sabha elections. In the last roll of the dice, the BJP-led Centre has provided huge relief to the muchtaxed middle class, an important vote bank in Delhi. Another factor that gives the BJP hope is the conflict between AAP and the Congress, which are part of the Opposition's INDIA bloc. Both have learnt no lesson from the 2024 fiasco in Haryana, where they played into the BJP's

hands by going solo. Their avoidable one-upmanship will have a bearing on the Delhi verdict.

### Middle-class voter takes pride of place

Tax relief announced in the Budget goes beyond the need to spur consumption demand

There is a reason why the annual Union Budget grabs attention, even if disproportionate. Embedded in the Finance Minister's speech and the numbers -- the sanctity of which has been questioned in recent years are signals on how the government proposes to stabilise the economy and make it grow, and how income and wealth will be redistributed. There are multiple signals sent out through the 2025-26 Budget that reflect the intent of the BJP-led NDA government at the Centre. The strongest signal was reserved for the last paragraph of the FM's speech, when she doled out unexpectedly large sops for the middle-class, salaried taxpayers. The ceiling on tax-free annual income has been raised from Rs 7 lakh to Rs 12.75 lakh (with standard deduction of Rs 75,000). The revised rates in various tax slabs give substantial benefits to those who pay income tax. According to the minister, potential direct tax revenue to the tune of around Rs 1 lakh crore has been foregone to deliver this benefit. These sops have been justified on the ground of spurring consumption demand that has been slack in recent times, contributing to a deceleration in the GDP growth that has troubled the government.

The second signal is a desire to declare that the government is intent on sticking to its efforts at fiscal consolidation by keeping the deficit on a downward "glide path", so as to limit and stabilise the public debtto-GDP ratio. This is clearly meant to appease foreign investors, who have in recent years rushed into India, and hugely increase the presence of foreign financial investments in the country. Being footloose, this capital can exit at a short notice. Financial investors loathe government deficits, not least because of the fear that they would stoke inflation and erode the real value of financial assets. Fiscal conservatism must be the price to pay to retain the confidence of these investors.

If taxes on the rich as well as corporates recording high profits are not being raised and direct tax sops are being provided to the middle class, fiscal consolidation can be ensured only by reducing expenditure. This seems to be corroborated by the fact that total expenditure is slated to fall from 14.6 per cent of the GDP in 2024-25 to 14.2 per cent during 2025-26. But a third signal that the Budget sends out is in conflict with the fiscal contraction narrative. That's the government's ostensible intent of raising capital expenditure to support private investment. A lot of that investment is expected to be realised with marginal outlays aimed at incentivising private investments through public private partnerships, but the expenditure figures do point to a 17 per cent hike in capital spending relative to the revised estimates for 2024-25. Optimistic expectations of tax buoyancy and inflated numbers on receipts from nontax revenue and privatisation partly explain this capacity to raise capital expenditure. But, an important part of the explanation is a willingness to rein in welfare expenditure,

including on erstwhile flagship programmes that the NDA government inherited and then claimed credit for. The outlay for the National Rural Employment Guarantee Scheme, having fallen from Rs 90,800 crore in 2022-23 to Rs 86,000 crore in 2024-25, is expected to stay at the same level, even though wage payments are in arrears and demand for jobs is high. Similarly, the food subsidy bill for an enhanced safety net under the National Food Security Act, having fallen from Rs 27.3 lakh crore in 2022-23 to Rs 19.7 lakh crore in 2024-25, is projected at just Rs 20.3 lakh crore in 2025-26. Measures announced in the Budget are sometimes a response to




economic situation. But more often and increasingly so in the 'new India', budgets are instruments in the hands of the ruling party to build vote banks and sway voters. Central budgets are crucial here because of accelerated centralisation of resources in the hands of the Union Government, often at the expense of states (through, for example, the reliance on cesses and surcharges not included in the divisible pool of taxes to be shared with the states as per the constitutional mandate). As a result, the ruling party at the Centre has greater leeway in deploying resources through its own tax and subsidy schemes, and through its choice of Centrally sponsored and Central sector schemes to emphasise upon.

outside have attributed the FM's direct tax largesse to the need to consolidate a middle-class vote bank, especially with an eye on upcoming state elections, including the one in middle classdominated Delhi. Special allocation for projects like the Western Kosi Canal extension and renovation, the creation of a Makhana Board to support production of the crop and other forms of assistance for Bihar are clearly driven by the need to appease a key ally, the JD(U), and woo voters in the state that will go to the polls later this year. Meanwhile, governments in Opposition-ruled states — Karnataka, Kerala, Tamil Nadu and West Bengal have complained that their legitimate demand for funds has been ignored.Riding on the analysis in the Economic Survey, which flags the fact that depressed consumption demand and inadequate government capital spending underlie the deceleration in economic growth, the FM claims that tax cuts to

boost middle-class demand and increased capital expenditure would help reverse the slowdown. This argument makes the hold on welfare spending a sacrifice needed to revive growth. But an alternative explanation could be that the government expects greater immediate political mileage from consolidating its middle-class vote bank than from providing more support for the weakest sections. The latter, the ruling party possibly believes, have already been won over with the limited support on offer, and by the concerted efforts to attribute to the Centre and the PM the benefits provided under Centrally sponsored schemes that are partly financed by

They must have been built by the Katoch Dynasty; the information available is very less though. The temples are magnificent structures, carved into the rock and rising towards the heavens. These are covered with amazingly detailed carvings depicting Shiva, Kartikeya, Indra, Surya, as well as many forms of the goddesses. The main shrine today has idols of Rama, Sita and Lakshmana found here during the excavation though it is believed to have been a Shiva Temple. Steps cut into a mountain nearby and lead to a sort of store house, where some broken idols were found. This hillock also provides a superb view of the temples against the Dhauladhar Ranges in the background.





## As Delhi Votes, AAP vs BJP Over Seized Vote With Family, Parents 'Promotional Materials', Cops Respond

New Delhi. On Wednesday morning, as voting for the Delhi Assembly election took place, a furious Aam Aadmi Party claimed that promotional material for the opposition Bharatiya Janata Party had been found at some polling booths in the national capital, in violation of the Model Code of Conduct that is in force. The AAP which has had several tiffs with the Election Commission in this election, including party boss Arvind Kejriwal and Chief Minister Atishi accusing it of bias, a charge firmly refuted last evening - also claimed

Delhi Police, which reports to the Union Home Ministry, were "mute spectators".

In a post on X the AAP said, "What is going on? There is election material openly displayed at the BJP booth... and the police are doing nothing. His elderly parents Gobind Ram Kejriwal and Gita Devi were on wheelchairs. While Mr Kejriwal pushed his mother's wheelchair, his son Pulkit pushed his



father's. His wife Sunita walked alongside them. Earlier today, Mr Kejriwal urged voters of the national capital to vote for development and honesty. He also hoped that "hooliganism" would lose and Delhi would win.

Dear Delhi residents, today is election day. Your vote is not just a button but a foundation for your children's bright future. Good schools, good hospitals and an opportunity to give every family a dignified life. Today, we have to defeat the politics of lies, hate and fear and make development and honesty win. Vote and inspire your family, friends and neighbours. Hooliganism will lose, Delhi will win," he said.

The New Delhi constituency, which has elected Mr Kejriwal in the 2013, 2015 and 2020 polls, is witnessing a three-cornered contest this time. Mr Kejriwal is up against the BJP's Parvesh Verma and the Congress's Sandeep Dikshit. Both are sons of former Chief Ministers.

A total of 699 candidates are in the contest for 70 Assembly seats in the national capital. Delhi has 1.5 crore registered voters, including 83.76 lakh men, 72.36 lakh women and 1,267 from the third gender. In the 2020 polls, AAP won 62 seats and the BJP eight.

NEW DELHI. The Delhi High Court has approached the Supreme Court seeking clarification regarding the appropriate trial court to hear the bail plea of Baramulla MP Engineer Rashid, currently imprisoned in a terror funding case under the Unlawful Activities (Prevention) Act. The issue arose after the special NIA court, which had reserved its order on Rashid's bail plea, later transferred the matter, stating that only a designated MP/MLA court has jurisdiction to hear cases involving elected lawmakers.

Justice Vikas Mahajan, while hearing Rashid's petition for an expedited bail decision, directed the Delhi High Court's Registrar General to obtain clarification from the Supreme Court on

The case is now listed for further hearing on February 6. Rashid has also sought interim bail to attend the ongoing Budget session of Parliament.Senior Advocate N Hariharan, representing Rashid, argued that his client had been granted interim bail in the past, including instances when he was campaigning during the Jammu and Kashmir elections."I am ready to address all objections, but for now, I am only requesting interim bail. The merits of the case can be discussed later," Hariharan submitted.

Opposing the request, Senior Advocate Sidharth Luthra, appearing for the National Investigation Agency (NIA), contended that Rashid's bail plea must be heard by a division bench as per the NIA Act. However, the high court noted that Rashid had been granted interim bail multiple times in the past without any allegations of misuse.

#### Pictures of Indians getting handcuffed, humiliated while being deported from **US saddening: Congress**

NEW DELHI. The Congress on Wednesday expressed sadness over "pictures of Indians getting handcuffed and humiliated" while being deported from the US and recalled that America had to express regret over the treatment meted out to India diplomat Devyani Khobragade in 2013 after the then UPA government retaliated sharply.

A military transport aircraft of the US is bringing a group of Indian migrants, in the first such deportation to India as part of the big crackdown on illegal immigrants by President Donald Trump in his second term at the White House. Without directly commenting on the deportation flight carrying the Indians, a spokesperson at the US embassy in New Delhi said on Tuesday that Washington is tightening immigration laws and removing illegal

Congress' media and publicity department head Pawan Khera said, "Looking at the pictures of Indians getting handcuffed and humiliated while being deported from the US saddens me as an Indian.""I remember in December of 2013, an Indian diplomat Devyani Khobragade was handcuffed and strip searched in America. Foreign Secretary Sujatha Singh registered a strong protest with US Ambassador Nancy Powell," Khera said in a post on X.

The UPA government retaliated sharply. NEW DELHI. The Centre is ready to allocate land and funds to the trust to be set up to construct the memorial for former Prime Minister Manmohan Singh. Sources said the government would give Rs 25 lakh to the trust to be formed by Singh's family. Sources said the government has thrice reminded the family, but the Ministry of Housing and Urban Affairs (MoHUA), the nodal agency for land allotment, is still awaiting a response from them. Singh passed away last December. Following the demand by Congress president Mallikarjun Kharge, the government offered two adjoining plots at the Rashtriya Smriti complex for his memorial. The ministry also carried out groundwork to facilitate its construction. This newspaper also reported that the architect of the Central Public Work Department (CWPD) inspected the two pieces of land — measuring about 10,000 square feet — and later discussed the memorial's design and other modalities.

The selected sites are close to the memorials of former presidents and prime ministers such as Giani Zail Singh, Shankar Dayal Sharma, Chandra Shekhar, IK Gujaral, and PV Narasimha Rao.

According to government officials, the CPWD will carry out the construction, and the trust will bear the expenses. The proposed memorial's cenotaph would be identical to those already existing on the campus.

Each memorial is a square piece of land surrounded by about two-feet-high sandstone-latticed screens with a 5X5 black granite platform in the centre. This is the standard design for memorials at the Rashtriya Smriti

The only exception is Atal Bihari Vajpayee's Samadhi. It comprises nine square black polished granite solid stone blocks, capped with a 'diya' in the Centre. The blocks are placed in a circular lotus-shaped pattern and enclosed by nine bas-relief walls, which have inscriptions of the prose or poetry of Vajpayee.

#### Saluja's plea against her removal as director rejected

NEW DELHI. In a setback for Rashmi Saluja, executive chairperson of Religare Enterprises (REL), the Delhi High Court (HC) has denied relief to her in a plea against a resolution seeking to replace her with a new director at the upcoming annual general meeting (AGM) on February 7.

Salula had moved the Delhi High Court against her removal as a director of REL, as she had argued that her appointment was for a fixed term of five years till 2028. The decision clears the way for the AGM and the voting on the appointment of a new director to replace Saluja, an important update in the ongoing dispute between the Burman family of Dabur and Saluja. The Burmans open offer to acquire a majority stake in REL is already underway and will close on Friday.

Saluja's plea has been opposed by four independent directors of REL. Additionally, the proxy firms — Stakeholders Empowerment Services, Institutional Investor Advisory Services, and InGovern Research — have recommended an 'against' vote on the resolution pertaining to Saluja's reappointment, citing concerns over corporate governance, employee stock ownership plans (ESOPs), and higher remuneration. REL described the proxy firm's reports as 'orchestrated and motivated'. In addition to Saluja's plea, minority shareholder Sapna Rao filed a separate case with the Delhi HC to consider the counteropen offer made by Danny Gaekwad. The court on Tuesday stated that SEBI will consider Gaekwad's offer in accordance with law and that the open offer by Burmans can continue.

#### Welspun Energy to invest Rs 13,500 crore in Odisha

MUMBAI. Welspun New Energy, green energy arm of Welspun World, has signed a Rs 13,500 crore pact with Odisha to build pumped storage and floating solar projects, which will generate 2,200 mw of green electricity. mw of green electricity.

#### Growth in services sector slows to more than 2-year low: PMI survey

New Delhi. Growth in India's dominant services sector in January slumped to the slowest in more than two years as demand softened but remained strong and led to a substantial rate of hiring, said a private survey on Wednesday. The HSBC final India Services Purchasing Managers' (PMI) Index, compiled by S&P Global, fell to 56.5 in January from 59.3 in December, lower than a preliminary estimate of 56.8 but ahead of the 50-mark separating contraction from growth. The index has been above the neutral 50-mark that separates contraction from expansion for 42 months straight. "Overall new business continued to increase strongly but the rate of expansion softened to the weakest in 14 months. The rise was attributed to strong demand and decisions to offer better prices than rivals. Growth was reportedly curbed by intense competition," said the survey.

"The business activity and new business PMI indices eased to their lowest levels since November 2022 and November 2023 respectively," said Pranjul Bhandari, chief India economist at HSBC. "That said, new export business partly countered the downtrend and continued to rebound from a dip in late-2024, in line with official data which showed India's services exports shining in December and capturing a larger share of global trade," she said. The survey reported a quicker increase in international sales as respondents noted gains from clients in Asia, Europe, West Asia and the

International demand in January hit a five-month high. The survey said that new business intakes and capacity pressure prompted service providers to recruit additional staff in the early third quarter of the financial year. "According to them, full- and part-time positions had been filled. The rate of job creation accelerated from December and was among the fastest seen since data collection started in December 2005." Services firms noted another uptick in expenses, driven by staff costs and food prices. The rate of inflation was little-changed from that seen around the turn of the year, therefore remaining above its long-run average.

## **Explained: Is China playing it** safe in latest trade war with US

NEW DELHI. China has hit back after US President Donald Trump announced new 10% tariffs on Chinese goods. Beijing's response included duties on about 80 American products, an investigation into Google, tighter controls on critical minerals, and the blacklisting of two US companies. However, this time, China's countermeasures appear more restrained compared to its approach during the previous trade war. This has raised a key question: Is China treading cautiously in

the latest trade standoff with the US?The answer lies in Beijing's current economic challenges and the large trade gap it has with America. Rather than matching Trump's move entirely, China imposed tariffs on a smaller set of US goods worth around \$14 billion, according to Bloomberg News.The careful response marks a shift from its earlier strategy, when it would retaliate with equal measures against US tariffs.Instead of matching Trump's move completely, China only put tariffs on a small portion of US goods worth \$14 billion, reported Bloomberg News. This careful approach is in stark contrast to how China acted during Trump's first term, when they would match US tariffs dollar for dollar. WHY CHINA HAS MORE TO LOSE

The change in China's strategy seems to be due to ongoing economic challenges. The country is dealing with falling prices and trying to fix problems in its property market. Right now, China heavily depends



China's position even more difficult. China sells more than three times as much stuff to the US as it buys from them. This means China has fewer American products it can put tariffs on if it wants to fight back. As Larry Hu from Macquarie Group told Bloomberg, China is being restrained because it "has more to lose" due to this huge trade imbalance with the US. Therefore, instead of getting into a full-blow tariff war, China might focus

more on supporting its own economy through internal measures.Experts suggest China might try to make peace by promising to buy more American oil and gas, keeping its currency stable, or fulfilling previous trade promises. Both sides seem interested in making a deal. Trump has said he wants to talk with Chinese leader Xi Jinping, though he's in no rush. There are other issues on the table too, like Trump wanting China's help to stop the

war in Ukraine and demanding changes to TikTok's ownership.For now, China is trying to look strong without making things worse.Josef Gregory Mahoney from Shanghai's East China Normal University told Bloomberg that it's like "two giants sizing each up and testing each other's resolve while also playing to their domestic audiences before shaking hands."But if things escalate, China's heavy reliance on exports to the US means it might have the most to lose in a full-blown trade war.

New Delhi. The Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) meeting begins on Wedneday under the leadership of newly appointed Governor Sanjay Malhotra. This will be the first policy meeting of Sanjay Malhotra as RBI Governor.

Analysts are divided on whether the RBI will cut the repo rate for the first time in nearly two years or maintain the current rate to manage inflation and currency stability. The sixmember committee will announce its decision on February 7, 2025.

WILL RBI CUT KEY LENDING

Experts believe the RBI may reduce the repo rate by 25 basis points (bps) to support economic growth, especially after the Union Budget 2025 focused on boosting demand.he repo rate has been unchanged at 6.5% since February 2023, and the last rate cut was announced during the Covid-19 pandemic in May 2020

Madan Sabnavis, Chief Economist at Bank of Baroda, believes economic conditions are suitable for a rate cut. The budget has provided a growth stimulus, and inflation is expected to



ease. However, the rupee remains under pressure due to global trade uncertainties," he said. While some believe a rate cut is likely, others feel the RBI may wait for global economic conditions to stabilise before making any changes.

Edelweiss Mutual Fund predicts a 50 bps rate cut in the first half of 2025, saying that monetary policy will have to play a key role in supporting economic growth.Rumki Majumdar, Economist at Deloitte, believes the RBI will take a cautious approach. "Balancing inflation and credit growth is tricky. While there is pressure to cut rates, the RBI may choose to keep rates unchanged but maintain an easy policy stance," she said.Umeshkumar Mehta, CIO at SAMCO Mutual Fund, feels that

global factors will influence the RBI's decision. "Bond yields in the US are rising due to inflation concerns, putting pressure on the Indian rupee. To avoid further depreciation, the RBI may choose to keep rates unchanged," he explained.

FACTORS THAT COULD IMPACTRATECUTS

The RBI's decision will depend on several factors:Inflation trends: Inflation has remained above 5%, but a downward trend could encourage a rate cut. Currency stability: The rupee has been under pressure due to rising US bond yields and global trade tensions. Economic growth: With the government focusing on economic expansion, a rate cut could help boost demand. Global uncertainties: Trade wars and fluctuating commodity prices could impact the RBI's approach. The stock market and bond markets will react based on the RBI's decision. If the central bank cuts rates, banking stocks may see gains, and borrowing costs for businesses and individuals could come down. However, if rates remain unchanged, markets may turn volatile as investors adjust their expectations.

#### **Bull run on Dalal Street: Will the stock** market rally last

New Delhi. Dalal Street saw a strong rally on Tuesday as stock markets surged in the afternoon session, recovering from losses in the previous session.

The benchmark indices, Sensex and Nifty, both closed over 1.5% higher, driven by gains in banking and financial stocks. The S&P BSE Sensex jumped 1,397.07 points to settle at 78,583.81, while the NSE Nifty50 climbed 378.20 points to close at 23,739.25.

According to market experts, the next target range for Nifty stands at 23,900–24,200. The banking sector played a major role in Tuesday's recovery, and analysts believe that the market's momentum will depend on how the banking index moves beyond the 50,200 level. Ajit Mishra, SVP-Research at Religare Broking Limited, said, "Given the current market conditions, we continue to focus on selective stock picking, with a preference for large-cap



and large mid-cap stocks."

Rajesh Bhosale, Technical Analyst at Angel One Ltd., suggested that a buy-on-dips strategy remains ideal, as it has been successful in recent sessions.He added, "The Budget Day high of 23,630 now acts as immediate support, while the bullish gap near 23,400 is a key demand zone."However, he warned that geopolitical tensions and ongoing trade wars could lead to volatility in the markets. Domestic factors such as the RBI's Monetary Policy Committee (MPC) meeting and the Delhi state elections will also influence investor sentiment.

### Gold consumption in India to cool in 2025 as prices soar, says WGC

**New Delhi.** India's gold consumption in 2025 is set to moderate from last year's nine-year peak, as a rally in prices to a record high is seen dampening jewellery demand, even as investment demand rises, the World Gold Council (WGC) said on Wednesday. Demand for gold could stand between 700 metric tonnes and 800 metric tonnes, compared to last year's 802.8 tonnes, which was the highest since 2015, Sachin Jain, CEO of WGC's Indian operations, told Reuters. Historically, rising gold prices first affect jewellery customers, and if prices keep rising and remain volatile this year, jewellery demand will be impacted, Jain said. Domestic gold prices hit a record high of Rs 84,399 (\$968.62) per 10 grams on Wednesday. They have risen 10 per



cent so far in 2025 after rising more than 21 per cent in 2024."Households that buy jewellery have a set budget, and when they purchase jewellery, their budget does not increase at the same rate as the rise in gold prices," Jain said. However, the soaring gold prices,

leading to effectively higher returns, are boosting investment demand, which will rise further in 2025 after surging 29 per cent in 2024 to an 11year high of 239.4 tonnes, he said. Jewellery accounts for nearly 70 per

cent of India's total gold demand, while investment demand makes up the rest. "It is anticipated that the trend of robust gold investment demand will continue, with retail investors showing growing interest in gold ETFs, digital gold, and coins and bars," Jain said. Shantanu Naidu, known for his special bond with late industrialist Ratan Tata, was promoted to General Manager, Head of Strategic Initiatives, at Tata Motors after spending more than six years at Tata Sons. Naidu, 32, shared the big career update on LinkedIn. "I'm happy to share that I'm starting a new position as General Manager, Head -Strategic Initiatives at Tata Motors!" he wrote.Turning nostalgic, he added, "I remember when my father used to walk home from the Tata Motors plant in his



white shirt and navy pants, and I would wait for him in the window. It comes full circle now."A mechanical engineering graduate, Shantanu Naidu began his professional journey as an intern at Tata Technologies before joining Tata Elxsi. It was in 2014 that he first caught Ratan Tata's eye.Naidu, an automobile design engineer, developed a dog collar design with a safety innovation to protect homeless dogs from speeding vehicles.

Tata, a known animal lover, not only decided to invest in the project but also became his mentor.

The industrialist's backing of the initiative marked the beginning of a long-standing professional and personal bond between the two.In 2018, Naidu assumed the role of Tata's assistant, a position that brought him into the public spotlight. His close relationship with the business tycoon

won hearts, especially after a video of him singing a birthday song for the billionaire philanthropist went viral.

Naidu chronicled their unique friendship in his book, I Came Upon a Lighthouse, which offered a rare glimpse into the personality of Ratan Tata beyond his business empire.

Beyond his corporate endeavours, Naidu is also an entrepreneur. In 2021, he founded Goodfellows, a startup dedicated to providing companionship for senior citizens living alone. The venture, valued at Rs 5 crore, received backing from Ratan Tata, who later relinquished ownership of the company.

Following Ratan Tata's death on October 9, 2024, at the age of 86, Naidu shared an emotional tribute on LinkedIn. "The hole that this friendship has now left with me, I will spend the rest of my life trying to fill. Grief is the price to pay for love. Goodbye, my dear lighthouse," he wrote. According to reports, Naidu's MBA expenses at Cornell University were covered under Tata's will.

coincides with the deadline for submitting finalised Champions Trophy squads to the International Cricket Council (ICC). Smith's injury setback means he will miss the initial two ODIs against India, with England hoping he can return in time for their last 50-over fixture before the Champions Trophy opener against Australia on February 22. The three-match ODI series



begins in Nagpur on Thursday, with the second match scheduled for Sunday. Joe Root has rejoined the squad for the ODI leg, providing some much-needed experience to a batting line-up that struggled during the T20 series. Smith's absence further limits England's options at the top of the order.

Phil Salt and Ben Duckett are expected to open, with Root slotting in at number three for his first 50-over international appearance since the 2023 World Cup. Captain Jos Buttler, Harry Brook, Liam Livingstone, and Jacob Bethell make up England's middle-order options.Rehan Ahmed, who was initially only selected for the T20 series, has been retained for the ODIs. Although he did not feature in the T20s, England now have the option of pairing him with fellow leg-spinner Adil Rashid in the 50over format.

India have made a notable addition to their squad, bringing in spinner
Varun Chakravarthy after his
standout performance in the T20 series,

where he finished as the leading wickettaker with 14 scalps at an average of 9.85. The 33-year-old is uncapped in ODIs and has only played 23 List A games in his career. India also welcome back key senior players, including captain Rohit Sharma, Virat Kohli, and wicketkeeper Rishabh Pant. However, there is no place for Abhishek Sharma, who hit a century in the fifth T20 in Mumbai.
