#### SC allows Yasin Malik to cross-examine witnesses through video conferencing from Tihar Jail

New Delhi, Apr. 04: The Supreme Court on Friday allowed jailed JKLF chief Yasin Malik to cross-examine witnesses in two cases through video conferencing from Tihar Jail. The order came on a plea filed by the Central Bureau of Investigation (CBI) seeking transfer of the trials in the 1989 case of the kidnapping of Rubaiya Sayeed, daughter of former union minister Mufti Mohammed Sayeed, and the 1990 Srinagar shootout case, from Jammu to New Delhi. The plea is over the two cases in which four Indian Air Force (IAF) personnel were killed on January 25, 1990 in Srinagar and the abduction which took place on December 8, 1989. A bench of Justices Abhay S Oka and Ujjal Bhuyan perused the report submitted by the registrar IT of Delhi High Court and registrar general of the Jammu and Kashmir High Court regarding facilities of video conferencing available in Tihar jail and Jammu respectively. The top court noted the Jammu sessions court was "well-equipped" with the video-conferencing system enabling the virtual examination. It also recorded the submission of Malik that he does not wan to engage a lawyer for cross-examination of witnesses.

## Modi meets Bangladesh's Yunus, conveys deep concerns about safety of Hindus

New Delhi, Apr 04: Prime Minister Narendra Modi on Friday directly conveyed India's deep concerns about the safety of Bangladesh's Hindus and other minorities to interim government chief Muhammad Yunus and said he expects Dhaka to ensure their security and thoroughly investigate instances of atrocities against them. The two leaders met for the first time since the ouster of the Sheikh Hasina government in student-led protests last August on the margins of the Bimstec Summit in Bangkok. The security of Bangladesh's minorities has emerged as the most contentious issue between the two sides since then, with New

Delhi repeatedly urging Dhaka to ensure their

security. Several other contentious issues,

including the caretaker administration's

request for extraditing Hasina, the manage-

ment of the border and transnational crimes,

and the holding of elections in Bangladesh, figured in the 40-minute meeting. An Indian statement offered no characterisation of the talks, while a Bangladeshi readout described the meeting as "candid, productive and constructive". Modi underlined India's "deep concerns" about the safety of Bangladesh's minorities, including Hindus, and in the interest of mutually beneficial ties. Yunus



thoroughly investigating all cases of atrocities committed against them", foreign secretary Vikram Misri told a media briefing. Modi also said the two sides should avoid rhetoric that vitiates the environment and hoped all issues of mutual interest will be addressed and resolved "bilaterally through constructive discussions"

"expressed his expectation that the government of responded to Modi's concerns by saying that reports of attacks on the minorities "were hugely inflated" and

"the bulk of them were fake news", the Bangladeshi readout said. Besides asking Modi to send journalists to Bangladesh to investigate the attacks, Yunus said he had created a system for monitoring religious violence and his government is taking "serious actions" to stop such incidents. Yunus enquired about the status of Dhaka's request for extraditing Hasina, currently in self-exile in India, and pointed out she has made "false and inflammatory remarks" and is trying to destabilise Bangladesh. "We request that the government of India take appropriate measures to restrain her from continuing to make such incendiary statements while she remains in your country," he said, adding that the UN human rights agency has confirmed human rights abuses by Awami League activists. Misri acknowledged the extradition request fig-

ured in the meeting but declined to go into specifics. "At this time, it will not be appropriate for me to say anything more on this issue," he said. People familiar with the matter said on condition of anonymity that the Bangladesh side is yet to complete certain legal formalities in connection with the extradition request.



#### CM Omar Abdullah-led legislative party meeting of NC

Jammu, Apr. 04: Two days ahead of Union Home Minister Amit Shah's three-day tour of Jammu and Kashmir, a meeting of the legislators of the ruling National Conference (NC) and its alliance partners began here on Friday amid growing disquiet between the Raj Bhavan and the six-month-old government in the Union Territory. The meeting, chaired by Chief Minister Omar Abdullah and also attended by National Conference president Farooq Abdullah, began at Deputy Chief Minister Surinder Choudhary's residence at the Gupkar here. The Cabinet ministers, all MLAs of the NC, and three Congress legislators led by chief whip Nizamuddin Bhat are attending the meeting. The unscheduled meeting of



the alliance partners comes in the backdrop of Lieutenant Governor Manoi Sinha ordering transfer and posting of 48 officers of the Jammu and Kashmir Administrative Service (JKAS). The controversial transfer of 48 bureaucrats three days ago led to the latest flashpoint between the Raj Bhavan and the Abdullah government which regards the LG's move as violation of the legal and administrative framework under the Jammu and Kashmir Reorganisation Act. The meeting of the ruling alliance comes two days ahead of the home minister's visit to the Union Territory following the recent spate of terror activities in the Kathua district of Jammu region. Shah is arriving on April 6 and is scheduled to chair security review meetings in both Jammu and Srinagar during his threeday visit. Before entering the meeting, NC MLA from Sonawari Hilal Akbar Lone said the Raj Bhavan is "undermining" the elected government. He said the meeting would discuss the steps required to be taken so that such things do not recur. Abdullah has written to Sinha asking him to review the unilateral decision, saying that the transfers and postings of officers outside the All India Services cadre was the exclusive prerogative of the elected government. Such orders undermine the functioning and authority of the elected government, Abdullah asserted in the letter. Abdullah is said to have taken up the matter with Home Minister Shah, complaining that a series of actions by the LG, including the transfers, "eroded" the authority of his government.

New Delhi, Apr. 04: Union Minister Suresh Gopi on Friday stated that the recently passed Waqf Amendment Bill in Parliament would benefit the residents of Munambam, who have been protesting for revenue rights over their properties against Waqf Board's claims. Speaking to reporters, the Union Minister of State for Petroleum and Natural Gas and Tourism reiterated that the bill would be advantageous to Munambam residents. "Waqf is an institution meant for the greater good. However, certain barbaric practices within it needed to be eliminated," he said without elaborating and added that "The Bill is a legal step towards ending such practices." He further claimed that the new amendment would also benefit the Muslim community. When asked whether the amendment would have a retrospective effect, Gopi responded, "Wait, sir. Wasn't it you who said this bill would never come at all?" Dismissing

# DU to enforce Lyngdoh panel guidelines in next DUSU polls: VC

New Delhi, Apr. 04: Delhi University Vice-Chancellor Yogesh Singh has said that the varsity will implement Lyngdoh panel guidelines and the next Delhi University Students' Union (DUSU) elections will have more "limitations and restrictions" to ensure smoother conduct. "Nobody should deface walls. What happened during elections in the past, huge amounts of money and muscle power, is not expected. We don't want to repeat these things, and next time, we will see a change. We will implement Lyngdoh Committee recommendations," Singh said in an interview with. He further added that "now there will be limitations and restrictions," in an apparent reference to new measures to curb malpractices in student politics. Singh also acknowledged concerns raised by students who feel that elections disrupt academic activities. "Many students just want to study, and they should have that right without disturbances," he said. Last year, the Delhi High Court said officials of Delhi University and its colleges had failed to appreciate the true import of the Lyngdoh

Committee guidelines, which prohibit the defacement of public property and the use of printed posters during the students union elections. According to the Lyngdoh Committee guidelines, a candidate cannot spend more than Rs 5,000. They also state that the candidates can only use voluntary contributions from the student body for their campaign. The guidelines also do not allow candidates to use any printed material, including posters, for canvassing. There are other limitations as well regarding funding and campaigning. Any contravention of these recommendations may make the candidate liable to be stripped of his candidature or his elected post, and the authorities may also take appropriate disciplinary action against such a violator, as stated in the guidelines. During the interview, the VC also responded to allegations that DU is being saffronised. Dismissing such claims, he asserted that education should instil a sense of national pride. "This is our country. We all are children of this country. The education system should prepare that kind of mindset.

#### Whistleblower prof at GU transferred

Ahmedabad. A case of significant financial irregularity at Gujarat University's animation department has resulted in the dismissal and arrest of Dr Kawaljeet Lakhtariya, an assistant professor, from the computer department.

Additional disclosures are anticipated following the chargesheet. GU's decision to abruptly transfer Prof Ajay Das, who reported the misconduct and filed a police complaint that resulted in Lakhtariya's arrest, from the animation department to geography department has raised questions about the probe's thoroughness.

According to sources, certain individuals continue to exercise control over the animation department. Reports indicate that Prof Das experienced intimidation from interested parties. He acknowledged receiving a transfer notice. This unexpected move has raised doubts about the validity of the police complaint and the potential disclosure of additional individuals involved in the irregularities.

#### 16-yr-old from Bihar flees child marriage, finds help in city

Ahmedabad. She was just 16, but her future had already been decided -marry a man nearly twice her age or be disowned by her family. Faced with no other choice, she did the unthinkable; she ran. Alone, scared and with hardly any luggage on her, the girl got down at the Sabarmati Railway Station. That's when an NGO worker noticed her hesitation and sensed something was wrong.

The worker alerted the Abhayam 181 women's helpline. "With police assistance, we questioned the girl, who revealed she had fled from a town in Bihar," said a counsellor. A little encouragement uncovered a heartbreaking truth: she had escaped to avoid her imminent marriage to a 30-year-old man. Her protests and pleas to complete her studies had been ignored, leaving her with no choice but to run, said the counsellor.

When the rescue team contacted her father, his response was cold and final: he refused to take her back, stating they wanted nothing to do with her. Clinging to hope, the girl sought support from her maternal uncle, who was shocked to learn of her plight. He assured counsellors he would try to convince her family to call off the marriage and support her education. "When that failed, he stepped forward to take custody, vowing to ensure her safety, allow her to study and not marry her off till she was of legal age," said the

The girl spent two days in a govt-run observation home before her uncle arrived to take her in. The rescue team has pledged to check on her periodically. The counsellor added the girl's determination struck a chord with many because it was a story shared by many girls. "However, she decided to flee the house and go to a completely unknown region, braving difficulties."

#### Mumbai traffic police toughens stance: Drunk drivers to face FIR under BNS, 3-month jail

MUMBAI. Motorists caught for drunk driving will now face FIRs under the Bhartiya Nyaya Sanhita (BNS), the traffic police chief warned on Thursday. Last year, the traffic police had issued challans to 9,462 motorists for drunk driving while in the first three months of this year, 2,264 had received challans.

Until now, a motorist who was found to have consumed alcohol beyond permissible limits, following a breathanalysis, was asked to pay a monetary deposit An LAC (Local Act Case) was recorded at the nearest police station and the offender was asked to remain present in court. The court would then decide on the punishment.

Now on, an FIR will be registered under section 125 of Bhartiya Nyaya Sanhita



(BNS) which deals with acts that endanger

the life or personal safety of others. The law says if the reckless act has caused minor harm, the punishment can be imprisonment for up to three months, a fine up to Rs 2,500, or both. But if the act has caused serious harm, the punishment can be more severe.

In addition to BNS, Section 185 of the Motor Vehicles Act will be slapped on the offender, his driving licence will be seized, and his vehicle will be confiscated. Police sources said stringent action is necessary to deter drunk driving, which is among key causes for fatal crashes.

Sources added that on facing an offence under the BNS, motorists may encounter difficulties in applying for passport and visas and for getting police clearance certificates for jobs.

## Revoke suspension or face stir, workers' union tells Samsung

SIWU plans to go on strike in two weeks if suspension of 23 workers is not withdrawn.



CHENNAI. CITU-backed Samsung India Workers' Union (SIWU) has issued a strike notice, dated April 2, stating that its members will stop work and launch a protest after 14 days if its demands, including recognition of the union by the company, revoking the suspension of 23 employees, and fair treatment of its members, are not met. The notice also The union accused the company of bypassing details several alleged unfair labour practices and retaliatory actions taken by the company

against union members.

The major demands of SIWU include withdrawal of charge memos issued to 23 employees and the cancellation of their suspension. It urged the company to engage with SIWU in negotiations to finalise agreements on salary increments and other general demands.

SIWU and instead holding talks with the Samsung India Welfare Federation, which SIWU alleges was formed at the company's behest to determine increments for 2025-28. The company subsequently signed an agreement with this federation and allegedly pressured SIWU members to accept it. SIWU has demanded the cancellation of this agreement and called for a secret ballot, supervised by labour department officials, to establish the true majority representation

Additionally, SIWU has demanded that the company grant ex-gratia payments to all 1,455 union members without any conditions. It claimed that while workers in the federation had already received the benefit, SIWU members were being pressured to leave the union to receive it.

The union also alleged that employees at the Visual Display Plant were transferred, with the management stating they would only be reinstated in their original sections if they quit

SIWU has demanded an immediate reversal of these transfers. It also alleged various retaliatory actions taken against employees belonging to SIWU. It stated that such actions of the company are violations under the Industrial Disputes Act, 1947.

#### Man released after 'murdered' wife found alive in Karnataka; son quit education for baby sister

MADIKERI/MYSURU. A man, who spent two years in jail for "murdering" his wife, was released two days ago after she was found moving around with another man.

The woman has been arrested. She has confessed that she had eloped with her paramour and that they have been living in a village 20 km from Madikeri, according to

Suresh, a resident of Basavanahalli Tribal Settlement Camp in Kushalnagar taluk of Kodagu, married Mallige a few years ago and they have two children.

In 2020, Suresh filed a complaint with Kushalnagar rural police after Mallige went missing. Meanwhile, the skeletal remains of a woman were found on the banks of Cauvery in Bettadapura police limits in Mysuru district. The police, who had registered the missing complaint, took Suresh to the spot for a mahazar (panchnama). Later, they forced him to give a statement that the skeletal remains were of Mallige. Subsequently, a chargesheet was filed against Suresh accusing him of murdering Mallige. However, the case took a new turn after Suresh's friends spotted Mallige moving around with another man near B Shettigeri in South Kodagu

## Power utility directed to install prepaid meters in government buildings in Tamil Nadu

CHENNAI. The Tamil Nadu Electricity Regulatory Commission (TNERC) has directed the state's power distribution utility Tamil Nadu Power Distribution Corporation Limited (TNPDCL) to install prepaid meters at all existing government institutions, including local bodies, state undertakings, Tamil Nadu Water Supply and Drainage Board (TWAD), and Tamil Nadu Urban Habitat Development Board (TNUHDB).

TNERC also said prepaid meters, where the consumer makes the payment in advance, should be mandatory for all new connections in government institutions. The directions come amidst rising

concerns over payments pending to the financially struggling TNPDCL. TNERC issued these directions in its order dismissing the petition filed by TNPDCL, which sought the waiver of the belated payment surcharge (BPSC) of Rs 137.13 crore owed by local bodies as of The outstanding CC charges of all local bodies alone



March 31, 2023, so as to push them to pay the pending current consumption (CC) charges. The commission criticised TNPDCL's proposal to

waive BPSC as "irrational and wholly unjustifiable."

stand at Rs 1,618.54 crore. TNERC directed TNPDCL to ensure the recovery of CC charges and BPSC from the defaulting local bodies by initiating swift and appropriate action.

n its order, TNERC said the local bodies had already been given sufficient time to pay BPSC and requests for further concessions are neither fair nor justified. NERC pointed out that for low-tension

(LT) service connections to local bodies, the BPSC rate is only 0.5% compared to 1.5% for other LT consumers, and local bodies have a longer payment period than other consumers.

TNPDCL, in its petition, cited a decision from the chief secretary's review meeting on March 8, 2023, which

proposed waiving belated payment surcharge if local bodies paid 50% of their dues. Officials had agreed to clear pending CC charges in 24 installments, aiming to settle all dues by June 2025. Local bodies account for 8.69 lakh electricity connections.

## Gurgaon: Doorstep waste pickup may take hit as MCG yet to send contract plan to Haryana govt

**Gurgaon.** The city risks facing disruption in doorstep waste collection services if the proposal for engaging a new agency is not prepared and submitted to the urban local bodies (ULB) department for approval in a timely manner. Despite the current private agency's contract ending in June this year, MCG has not yet submitted its proposal for engaging the new agency for door-to-door waste collection. According to the revised ULB department guidelines, the new contract will span seven years and requires approval from the Haryana govt. High-value projects typically require considerable time to secure state govt approvals. However, a senior MCG official said, "The final proposal is now ready for submission to the ULB department on Friday. The delay occurred as specific modifications were necessary following consultations with ULB department officials. These required changes have now been incorporated into the completed proposal."Sources said that

### April 10 deadline set for all corporations to get House nod for budget in Haryana

Gurgaon. The Haryana govt has asked all municipal corporations to obtain approval for the 2025-26 fiscal year budget estimates rom their newly elected Houses by April 10.As an interim measure to ensure uninterrupted operations, the corporations have been allowed to use 10% of the previous fiscal year's (2024-25) approved budget from respective allocations until April 30. Haryana municipal corporation elections were held on March 2, and the results were declared on March 12. However, in the absence of functioning Houses, the corporations forwarded their budget estimates to the urban local bodies (ULB) department for approval. The Houses will now convene to approve the budget.

"The govt has decided that all municipal corporations, including those that have forwarded their estimates to the department before, shall forward their budget estimates for fiscal year (FY) 2025-26 to the ULB department, Haryana, Panchkula, after getting the same passed through their elected House by April 10," read the communication sent by the ULB department to the municipal corporations on Tuesday."The govt also permitted all the municipal corporations to incur an amount equivalent to 10% of the sanctioned budget for the FY 2024-25 under the same head by April 30, as a stopgap arrangement for the smooth functioning of the municipal corporations," it added. Moreover, the ULB department directed the corporations to provide explanations for low revenue collection and variations in expenditure, whether excess or deficit.

## GMDA prepares for trials of Chandu Budhera, water



Gurgaon. GMDA is gearing up to conduct trials of newly constructed 100 MLD unit at the water treatment plant (WTP) in Chandu Budhera within the next 15 days. To facilitate this, the authority has announced a shutdown of 30 hours at the plant. The new unit will be connected to the existing 1,600mm pipeline during the shutdown, which will be initiated from 11am on April 7 to 5pm on April 8. The areas affected by this shutdown will include sectors 4, 5, 7, 9, 11, and 12; sectors 81 to 115; Dayanand Colony, Old Gurugram, Laxman Vihar, and Choti Mata boosting station. Meanwhile, Chandu village, Dhankot, sectors 10, 33, 37D, and 38, along with the Sector 51 boosting station serving sectors 42-74 and Badshapur village will experience a partial 12-hour water supply disruption from 11am to 11pm on April 7."We have requested the residents in the affected areas to be prepared to face the shutdown. While we have announced a 30-hour shutdown, we will try to complete the work early to minimise inconvenience to the public. The water supply to Sector 51 boosting station will be partially affected and will be restoed within 12 hours," the official added. After 2016, when the third unit was constructed at the plant, this will be the first major boost to the city's water supply system. According to GMDA, finishing work is currently underway, including installation of electrical connections, with Daultabad feeder supplying power until the 66 kV substation becomes operational.

A 24-year-old man accused in an attempt to murder case almost managed to hoodwink the legal system by presenting himself as a minor to escape strict punishment, weaving a web of forged documents that included an Aadhaar card and a family ID issued by Haryana govt.Harsh Moriya's carefully scripted story began to unravel when he presented a birth certificate issued by the District Hospital in Hapur, claiming he was born on Sept 29, 2007. With this, Moriya claimed he was 17 when he was picked up for a murder bid on Dec 24 last year. While the maximum prison term under the BNS section for attempt to murder is 10 years, it's three years under the juvenile justice system. Along with the birth certificate, Moriya submitted doctored school admission forms, marksheets, and even an Aadhaar card, which initially earned

300 crore, necessitating state govt clearance, which requires a lengthy approval process. ## SC to hear 14 petitions against drive to raze illegal construction in DLF phases in Gurgaon on Friday

Gurgaon. The Supreme Court will hear special leave petitions filed by 14 different groups on Friday seeking relief from the drive to demolish unauthorised construction in housing units and seal commercial activities in DLF phases 1 to 5. The hearing comes on a day when the department of town and country planning (DTCP) is set to launch its crackdown on illegal structures in compliance with the Punjab and Haryana high court directive. A DTCP official said over 2,200 properties have been marked for action, with recommendations already made to revoke occupancy certificates and cut off essential services such as water supply.

Petitioners who approached the SC include DLF Qutub Enclave RWA, residents of areas off Golf Course Road, DLF phases 5 and 3 as well as Guesthouse Association and several independent property owners. They argue that the demolition and sealing drive is unfair and that they should

be given more time to address regulatory concerns. Residents and businesses in DLF await a crucial decision that could impact the future of the enforcement drive. The crackdown follows a Feb 13 order from the HC, directing the govt to take strict

action against unauthorised constructions and illegal commercial activities in DLF residential areas. The case originated from a 2020 petition filed by the DLF City RWA, seeking action against unregulated modifications in residential buildings.HC has instructed the DTCP to submit an action taken report (ATR) by April 19, detailing the measures implemented."Affected residents must restore their properties to comply with regulations. If they fail to do so, the department will proceed with necessary action. Any obstruction to the drive will lead to legal action," town planner (enforcement) Amit Madholia said.To

already issued public warnings in the affected areas on Thursday, urging residents to remove unauthorised modifications voluntarily. Officials have warned that failure to comply will result in strict action, including demolition and disconnection of essential utilities such as water, electricity and sewer connections. However, the administration remains firm, saying that illegal constructions have

been identified and the govt is committed to enforcing the law. Anticipating resistance from affected residents and businesses, authorities have deployed 200 police personnel to maintain law and order. Additionally, four duty magistrates have been appointed to oversee the operation. Police teams have been patrolling the area since Thursday to prevent any untoward incidents. Officials have also warned that any attempt to obstruct the demolition drive will result in FIRs being registered.

The central empowerment committee (ČEC), a body appointed by the SC to handle forestrelated issues, advised that the company should have sought forest clearance before starting operation but it acknowledged that this was a "fait accompli" situation, which left little room but to give a green

### South Korea court upholds President Yoon's impeachment, ousts him over martial law

Seoul South Korea's Constitutional Court on Friday decided to oust President Yoon Suk Yeol, upholding parliament's impeachment motion over his shortlived imposition of martial law last year that sparked the country's worst political crisis in decades.

With Yoon's ouster, a presidential election is required to take place within 60 days, according to the country's constitution. Yoon's lawyer said that he feels miserable after the court upholds his impeachment.Prime Minister Han Duck-soo will continue to serve as acting president until the new president is inaugurated. The ruling caps months of political turmoil that has overshadowed efforts to deal with the new administration of US President Donald Trump at a time of slowing growth.

Separately, 64-year-old Yoon faces a criminal trial on insurrection charges. The embattled leader became the first sitting South Korean president to be arrested on January 15 but was released in March after a court cancelled his arrest warrant. The crisis was triggered by Yoon's December 3 declaration of martial law, which he has said was needed to root out "anti-state" elements, and the opposition Democratic Party's alleged abuse of its parliamentary majority that he said was destroying the country. Yoon lifted the decree six hours later after lawmakers defied efforts by the security forces to seal off parliament and voted to reject it. Yoon has said he never intended to fully impose emergency military rule and tried to downplay the fallout, saying nobody was hurt.

Months of protests have followed, and it remains unclear if the political chaos sparked by Yoon's martial law declaration will now be eased by the

### Trump confident in TikTok sale as US ban deadline approaches

world. President Donald Trump again downplayed risks that TikTok is in danger of being banned in the United States, saying he remains confident of finding a buyer for the app's US business by a Friday deadline. The hugely popular video-sharing app, which has over

170 million American users, is under threat from a law that passed overwhelmingly last year and orders TikTok to split from its Chinese owner ByteDance or face a ban in the United States. Motivated by widespread belief in Washington that TikTok is ultimately controlled by the Chinese government, the law took effect on January 19, one day before Trump's inauguration.But the Republican president quickly announced a delay that has allowed it to continue to operate; that delay is set to expire on April 5. We have a lot of potential buyers. There's tremendous interest in TikTok," Trump told reporters onboard Air Force One late Sunday."We have a lot of people that want to buy TikTok. We're dealing with China also on it, because they may have something to do with it," he said, adding "I'd like to see TikTok remain alive."

Any deal to divest TikTok from ByteDance will require the approval of Beijing, and Trump has said he may offer to reduce tariffs on China as a way to get Beijing's approval for the sale. Trump, though he supported a ban in his first term, has lately become the app's greatest defender, seeing it as a reason more young voters supported him in November's election.

One of his major political donors, billionaire Jeff Yass, is also a major stakeholder in parent company ByteDance.

ByteDance on board? -

Several proposals for TikTok's US business have emerged since the law began to make its way through Congress last year. But according to The New York Times, citing people involved in coming up with a solution, the most likely fix would see existing US investors in ByteDance roll over their stakes into a new independent global TikTok company. Additional US investors would be brought on to reduce the proportion of Chinese investors. Trump at one point said the US government could also take a stake through a newly announced national sovereign fund.

#### You Cannot Annex Another Country": Denmark PM To **US Over Greenland**

Oslo. Accusing the US of subjecting Denmark and Greenland to "pressure and threats," Danish Prime Minister Mette Frederiksen firmly rejected US attempt to annex the Greenland, citing international law."You cannot annex other countries -- not even under the pretext of international security," Frederiksen said at a press conference with Greenlandic officials in Nuuk, the capital of Greenland. "National borders, sovereignty, territorial integrity - these are rooted in international law. These principles were established after World War II so that small countries would not have to fear large ones."Meanwhile, she expressed deep concern over what she described as pressure and threats from the United States. "When you seek to take over part of the Kingdom (of Denmark)'s territory, when we are subjected to pressure and threats by our closest ally, what are we to think about the country we have admired for so many years?" Frederiksen said.

The press conference, which was broadcast live by Danish broadcaster DR, was held amid US President Donald Trump's continuous expression of interest in acquiring Greenland, an autonomous territory of Denmark, Xinhua news agency reported.

Mute Egede, the outgoing Greenlandic prime minister, who spoke alongside Frederiksen and the incoming leader Jens-Frederik Nielsen, praised the Danish prime minister's stance and emphasised the progress made in Denmark-Greenland relations in recent years. He said that while challenges remain, the two sides are cooperating more closely. "Today's global situation obliges us to work together. Good friends and allies must stand together to defend the values we have long shared in the Western world," he said.

## Al-Generated Research Paper Is Latest Spin On Climate Change Denial

Washington.Climate change deniers are pushing an AI-generated paper questioning human-induced warming, leading experts to warn against the rise of research that is inherently flawed but marketed as neutral and scrupulously logical.

The paper rejects climate models on humaninduced global warming and has been widely cited on social media as being the first "peer-reviewed" research led by artificial intelligence (AI) on the topic.

Titled "A Critical Reassessment of the Illusion of objectivity Anthropogenic CO2-Global Warming Academics have warned that the surge of Hypothesis," it contains references contested by the scientific community, according to experts interviewed by AFP.

Computational and ethics researchers also cautioned against claims of neutrality in papers that use AI as an author. The new study -- which claims to be entirely written by Elon Musk's Grok 3 AI -- has gained traction online, with a blog post by Covid-19 contrarian Robert Malone promoting it gathering more than a million views. After the debacle of man-made climate change and the corruption of evidence-based medicine by big pharma, the use of AI for government-funded research will become normalized, and standards will be developed for its use in peer-reviewed journals," Malone wrote. There is overwhelming scientific consensus linking fossil fuel combustion to rising global temperatures and increasingly severe weather disasters.

AI in research, despite potential benefits, risks triggering an illusion of objectivity and insight in scientific research."Large language models do not have the capacity to reason. They are statistical models predicting future words or phrases based on what they have been trained on. This is not research," argued Mark Neff, an environmental sciences professor.

The paper says Grok 3 "wrote the entire Microbiologist Elisabeth Bik, who tracks scientific malpractice, remarked the paper did not describe how it was written: "It includes datasets that formed the basis of the paper, but no prompts," she noted. "We know nothing about how the authors asked the AI to analyze the data." Ashwinee Panda,

a postdoctoral fellow on AI safety at the University of Maryland, said the claim that Grok 3 wrote the paper created a veneer of objectivity that was unverifiable."Anyone could just claim 'I didn't write this, the AI did, so this is unbiased' without evidence," he said.

Opaque review process

Neither the journal nor its publisher -which seems to publish only one journal -- appear to be members of the Committee of Publication Ethics.The paper acknowledges "the careful edits provided by a reviewer and the editor-

in-chief," identified on its website as Harde.It does not specify whether it underwent open, single-, or double-blind review and was submitted and published within just 12 days.

## No food, one toilet: Passengers fume as 30hour Turkey airport ordeal drags on

Virgin Atlantic flight made emergency landing in Turkey on April 2

Over 250 passengers, many of them Indians, stranded at Diyarbakir Airport Passengers facing lack of food, toilets, and charging points

More than 250 passengers, including several Indians, have been stranded for over 30 hours at Turkey's Diyarbakir Airport after a Virgin Atlantic flight from London to Mumbai was forced to make an emergency landing.Flight VS358 departed London's Heathrow airport at 11:40 a.m. local time on April 2 and was scheduled to land in Mumbai at 1:40 a.m. on April 3. However, the plane made an unscheduled landing at

Diyarbakir airport around 7 p.m. local time after a passenger required urgent medical attention. Following what



Virgin Atlantic described as a "hard landing", the aircraft was deemed unfit to fly due to a technical issue. Passengers were disembarked, but while the crew was transported to a hotel, passengers remained confined to a restricted area within the small regional airport, which lacks adequate facilities."We are actively exploring all options, including the operation of an alternative aircraft, to ensure customers can reach Mumbai as soon as possible," the UK-based airline said in a statement on Thursday. Passengers, however, painted a grim picture of

their ordeal. X users detailed a lack of basic amenities, including insufficient food, limited toilet facilities, and a lack of charging points for electronic devices."It's been 24 hours and not a single airline representative has met the passengers. They have barely any food, one toilet amongst 275 pax, phones running out of batteries as they don't have Turkish adapters. There are babies, pregnant women,

diabetics and old people in this ordeal," wrote AAP leader Preeti Sharma-Menon on X, requesting government intervention. 

Father Arul Carasala was born and raised in South India. He was ordained as a priest in 1994 in Diocese of Cuddapah, Telangana. He moved to Kansas in 2004 at the invitation of Archbishop James P. Keleher.

Father Carasala has been working in Kansas ever since and became a US citizen on May 20, 2011 in Kansas.

Earlier than serving at Saints Peter and Paul Catholic Church in Seneca, Father Carasala served at a number of other parishes in KansasHe became the pastor at various parishes, including St. Vincent de Paul in Onaga and St. Patrick in Corning.Kansas City Archbishop Joseph Fred Naumann announced his death.

Arul Carasala, who was fatally shot earlier today, Naumann wrote."This senseless act of violence has left us grieving the loss of a beloved priest, leader, and friend."The Knights of Columbus organised a Rosary ceremony at Sts. Peter and Paul Parish in Seneca, followed by a Mass presided over by Archbishop Naumann in memory of Father Carasala.

## Trump's approval rating hits new low amid tariff announcement

world. President Donald Trump's approval rating has dropped to 43%, the lowest since he took office. According to a Reuters/Ipsos poll, most Americans are not happy with his tariff strategy and his administration's management. The survey, which lasted three days and closed on Wednesday, indicated a 2-point drop from a survey taken in late March. It is also 4 points below the 47% approval rating which he received shortly after his inauguration in January.Trump's approval had been highest in early 2017 at 49%. His lowest in

his first term was 33% in December 2017.Despite his current approval being lower than it was earlier this year, it's higher than it was for most of his first term. While Joe Biden had a lower 35% just before the November election. Are Americans satisfied with aggressive Trump policies?

One of the main areas where Trump's popularity declined is in how he



manages the economy. Only 37% of people sanctioned his performance on economic matters, and only 30% sanctioned his response to the high cost of living, an issue President Biden is also grappling with.Most Americans are particularly concerned about Trump's tariffs on items such as automobiles and automotive parts. Almost half of respondents indicated have created uncertainty in the stock market. His aggressive policies have also resulted in a shift in the way the US engages with the world by disrupting long-standing diplomatic norms. Another problem that has been of concern is how the Trump administration manages a military situation. The survey found that 74% of individuals felt that it was irresponsible for Trump's staff to talk about a military strike on militants in Yemen on a popular messaging

app, Signal.Only 22% of respondents felt that it was merely an error. 70% of people said Trump should be held accountable for the gaffe. Trump's foreign policy approval rating also fell to 34%, from 37% in January. But he still got a higher approval rating for his immigration handling, with 48% of

# India Deploys Relief Teams, Aid To Myanmar After Deadly Earthquake

Mandalay.India's National Disaster Response Force (NDRF) is actively leading the efforts as part of Operation Bharma, with rescue and relief operations underway in Myanmar. The country is currently recovering from the devastating 7.7 magnitude earthquake that hit on March 28, following which India, being the first responder in times of crisis in the neighbourhood, had been providing vital assistance to the country.NDRF Deputy Commander Kunal Tiwari, who is overseeing the search and rescue operations, shared insights into the ongoing efforts on Wednesday.Mr Tiwari mentioned that the NDRF team consists of 80 personnel, supported by four specially trained canines and advanced equipment for rigging, lifting, cutting, and bridging.

Despite the challenges, Mr Tiwari expressed confidence in their readiness to overcome them. He also highlighted the team's expertise in managing recovery operations, including handling the recovery of mortal

remains with dignity and respect.

"Our team has a total of 80 members. We have four canines and heavy team equipment like rigging, lifting, cutting, and bridging. Our team is fully equipped," he said. The NDRF Deputy Commander also spoke about the significant support received from Myanmar's local population and emphasised the strong bond between India and Myanmar, noting that while India has extended a helping hand, the people of Myanmar have shown immense warmth and respect in return." As India has taken one step forward to help Myanmar, so have the people of Myanmar taken two steps forward with us. Wherever we are going, we get their full support. So it is because of this bonding between Myanmar and India that we are able to carry forward with our work," Mr Tiwari added.Regarding aftershocks, Mr Tiwari assured that safety is a top priority for the team. All personnel are equipped with personal protective equipment (PPE), and thorough safety

protocols, including marking escape routes and safe zones, are strictly followed before commencing any work."Safety first is our principle. All of us trained for it. We all have good PPE, which gives us local protection. Before starting any work, we mark the escape route properly and the safe zone; the safety officer is informed," he said.Mandalay, the city hardest hit by the earthquake, has been divided into four sectors: Alpha, Bravo, Charlie, and Delta. The Delta sector, which is the most affected area, is under India's responsibility and has seen significant intervention, with India covering 11 of the 15 designated work sites.

A local Myanmar monk expressed deep appreciation for India's efforts, stating that he was satisfied and grateful for the assistance provided. Another local, Hussain, also expressed his thanks, describing the arrival of the Indian team as a source of great relief."We got a great sense of relief when you came. You (Indians) are very hard-working people.

We are very happy and at peace. We have benefitted a lot from the arrival of NDRF. May god shower blessings upon India and its leadership," he said. As part of Operation Brahma, India has already delivered 625 metric tonnes of humanitarian aid and disaster relief materials to Myanmar as of Tuesday. The operation reflects India's commitment to being a first responder in the region, providing essential search and rescue, medical aid, and disaster relief in the wake of the March 28 earthquake.Operation Brahma is a comprehensive effort involving multiple branches of the Indian government to address the widespread devastation caused by the earthquake and support Myanmar's recovery. The Indian Army has also set up a Field Hospital, providing medical support to the people.According to the Indian Army's release, the medical team successfully conducted 23 surgeries, over 1,300 laboratory investigations, and 103 Xray procedures as of Thursday evening.

#### Two auto drivers held for raping Bihar woman in Bengaluru

BENGALURU. A 19-year-old migrant labourer from Bihar was kidnapped and raped near KR Puram Metro station in the wee hours of Wednesday. The two alleged assailants Asif and Syed Moosa were arrested by the Mahadevapura police. The two are autorickshaw drivers.

The victim along with her cousin were looking for a hotel to have food around 1.20 am. The victim who is from Banka district in Bihar had gone to her sister's house in Idukki district in Kerala a month ago. The victim along with her sister and brother-in-law were working in a cardamom plantation.

She boarded the train from Ernakulam to Bihar on Tuesday. Her cousin joined her from KR Puram railway station around 1.15 am. According to police, Asif raped the victim while Moosa subdued her

On hearing the screams of the victim, locals rushed to the spot. The crowd managed to nab Asif and handed him over to the police.

Based on his information, the police arrested his associate, Moosa. "Both the accused who are from Mulbagal taluk in Kolar district were sleeping in their autorickshaws during night by parking near the KR Puram railway station," said an officer. The victim who has been hospitalised has been subjected to mandatory medical tests.

A case of rape (BNS 64), causing hurt (BNS 115(2)), wrongful restraint (BNS 126(2)), criminal intimidation (BNS 351(2)), intentional insult with intent to provoke breach of the peace (BNS 352), along with other sections of BNS have been registered against both the accused.

#### Training programme on women's safety in film industry launched

THIRUVANANTHAPURAM. The Women and Child Development Department has rolled out a specialised training programme to enforce the provisions of the POSH Act in the film industry. The training programme was organised in the light of the POSH Act 2013 and the Justice Hema Committee Report, said Health and Women and Child Development Minister Veena George inaugurating the training programme.

The programme was organised by the Women and Child Development Department with the help of Gender Park to create awareness about the POSH Act among those working in the film sector.

When a film is made through the collective work of about thirty sections, it is necessary to ensure a safe working environment for all those working in this sector, she said. The module training has been organised to implement the existing provisions under the POSH Act. "The producer is the employer.

Then it is the responsibility of the producer to form internal committees and ensure women's safety," said the minister. The minister also clarified that this will be the most effective training programme to make the Malayalam film industry womenfriendly. Chief Secretary Sarada Muraleedharan presided over the function. Around 60 people from the film industry participated. Under the POSH Act, internal committees have been formed in all institutions with more than ten employees in 95 government departments in the state.

More than 25,000 institutions have been registered. In January 2023, a POSH portal was launched to coordinate and monitor activities under the POSH Act to prevent sexual harassment against women in the workplace.

#### Agvin is the cheapest cooperative milk brand in country, says minister Raja Kannappan

CHENNAI. Milk and Dairy Development Minister R S Raja Kannappan on Wednesday informed the Assembly that Aavin milk is the most affordable among all state-owned cooperative brands, including Amul, Nandini and Milma, as well as private brands, with the price difference ranging from Rs 6 to Rs 16 per litre. He added that Aavin can ensure an adequate milk supply for all only if daily procurement increases from the current 36 lakh litres to 56 lakh litres. During discussions on the demands of grants for his department, Kannappan highlighted Aavin's competitive pricing. He said Aavin sells toned milk at Rs 40 a litre, compared to Rs 48 by Nandini, Rs 46 by Milma and Rs 54 by Amul. Similarly, Aavin's standardised milk variant is priced at Rs 44 per litre, whereas Nandini charges Rs 56, Milma Rs 54 and Amul Rs 60. For full cream milk, Aavin sells it at Rs 60 per litre and Rs 48 per litre for cardholders, while Nandini, Milma and Amul price their full cream milk at Rs 62, Rs 68 and Rs 66 per litre respectively.

Efforts are under way to increase milk procurement to 56 lakh litres per day to revive 300 dormant primary milk producers' cooperative societies, Kannappan said. He also mentioned that 18 dairy projects, with a total investment of Rs 1,800 crore, are currently at various stages of implementation across the state. "Upgradation of dairy plants is in progress at Salem, Namakkal, Thanjavur, Thoothukudi and other locations.

## BBMP chief Girinath revs up Palike machinery for rain work, keeps officials on their toes

Steps have already been taken in 166 places to ensure that there are no problems.

BENGALURU. BBMP Chief Commissioner Tushar Girinath has instructed civic officials to take precautionary measures to avoid any rain-related problems during the monsoon.

At a meeting on Thursday to deliberate on preventive measures to be taken due to the rain, he told officials to take necessary action under the Disaster Management Act. Officials should complete the works in Sai Layout, Pai Layout, Kendriya Vihar Apartment, Kogilu Cross, Sarjapur Road (Iblur Junction), Abbigere Kere Kodi, Mysore Road, Gali Anjaneya Swamy Temple and other places before the onset of the monsoon season.

"There are 209 flood-prone areas in the city, including 11 new areas. Steps have

already been taken in 166 places to ensure that there are no problems. Appropriate measures should be taken in the remaining 43 floodprone areas to ensure that there are no problems. Officials should personally visit



flood-prone areas and resolve the problems,' said Girinath.

The BBMP chief directed the Palike staff to coordinate with Bengaluru Traffic Police and take up works to prevent waterlogging at 180 spots on major roads. He also instructed officials to clean the gratings on the roadside rainwater into the side drains.

Girinath also stated that the Bangalore Electricity Supply Company (BESCOM) and Bangalore Water Supply and Sewerage Board (BWSSB) officials should be deployed to the BBMP control rooms before the onset of the rainy season. "A department-wise list of officers should be prepared in this regard immediately. In addition, a list of SDRF/NDRF officers should be prepared. For customers who have added their flight to the "My Trips" section of the app, baggage information becomes automatically available soon after the bags are checked-in, as well as on the "Track my Bags" tab of the website.

Customers may also scan the barcode on their baggage receipts to initiate tracking.

### Air India integrates Apple Air Tag Impounded vehicles turning police stations in Kerala's Ernakulam into junkyards

For years, the police department has been advocating for a dedicated yard to keep impounded vehicles, as many police stations are struggling with a lack of parking space.

KOCHI. Police stations across the district are turning into junkyards due to the accumulation of impounded vehicles, leading to severe space constraints. According to data with the home department, a total of 2,258 vehicles impounded in various cases

are currently parked at different police stations in the district.

Within Kochi city police limits alone, 813 vehicles remain unclaimed, while 1,445 vehicles are parked at stations under the Ernakulam Rural district. As of March this year, 26,195 impounded vehicles are lying at police stations across the state. Palakkad has the highest number (3,189). followed by Thrissur Rural (2,728), Thrissur City (2,223), and Malappuram (2,131).

"Although there are directives to release vehicles to their owners once legal procedures are completed, very few owners come forward to reclaim them. Additionally, since legal proceedings often take years, the condition of these vehicles deteriorates over time. Last year, we auctioned off several unclaimed vehicles, but bidders usually look for well-maintained ones, leaving many unsold," an officer with Ernakulam Rural police said.

For years, the police department has been



advocating for a dedicated yard to keep impounded vehicles, as many police stations are struggling with a lack of parking space. "In city areas, most impounded vehicles are two-wheelers, while in rural areas, we seize larger vehicles like trucks and lorries, which

occupy significant space. Additionally, cars and buses involved in accidents often remain at police stations for months after the incidents," the officer In 2018, the home department issued a

directive instructing all police districts

to clear impounded vehicles from station premises as soon as possible. To streamline the process, officers were advised to seize only the vehicle's registration certificate in cases of traffic violations, instead of taking physical custody of the vehicle. There was also a proposal to incorporate some of these impounded vehicles into the police motor fleet.

Despite these measures, the number of vehicles left at police stations remains alarmingly high. This is

problematic for stations like Palarivattom and Ernakulam Central, which have limited compound space. A dedicated storage yard for impounded vehicles would be a far better solution," another Kochi City police

### Al tools are fuelling a free-for-all

Anew phenomenon is catching on in the digital sphere. Users are flooding social media platforms like X, Instagram and Facebook with their portraits, family pictures and other images drawn in the style of legendary Japanese animator Hayao Miyazaki. He is the founder of the famed Ghibli Studio, which in the past four decades has created iconic animation characters. The typical style of drawing characters in light, pastel shades has come to be known as the Ghibli art. However, the art being posted online by users is not original but generated by artificial intelligence (AI) tools available for free on a trial basis. With just a few clicks, one can transform a picture into the trademark Ghibli art. Millions of users, including politicians, fashion and sports influencers, and celebrities, are using AI tools to create images in this style. Though generative AI tools — which are used for content creation — have been around for some time, the current trend has been triggered by a new tool developed by OpenAI. Text-based or large language models (LLMs) models like ChatGPT take textual inputs and generate desired material like articles, book chapters, social media posts, etc. The latest multimodal generative AI tools can take text, images, videos, voice and music as inputs and generate desired output images and videos. Tools like Midjourney, Stable Diffusion and DALL-E can take in text as input and give output as images. For instance, one can ask DALL-É to generate a painting of a Delhi street in the style of MF Husain or Jamini Roy and it would do so within a few seconds. Then there are image-to-image tools like Lensa that can provide altered versions of the input images. The images generated in the Ghibli style have caught the public imagination because they look cute and funny. The fun part, however, masks serious issues concerning text and image-generative AI systems. Any AI system is based on real data collected from various sources. AI tools should be 'trained' using massive amounts of data (text, images, music, etc.). If an LLM is asked to generate a small story in the style of Amitav Ghosh or Ruskin Bond, it would do so by digging into massive amounts of data that would have been based on the works of these authors. Much of this material is copyrighted, and AI companies have not bought the rights from authors to 'train' their systems. The same is happening with the works of Ghibli Studio or the paintings of masters like Husain.

AI companies say they are only using data available in the public domain, but the creative world is not buying this claim. The 'fair use' doctrine in copyright laws is being misused by technology companies. The existing copyright frameworks are inadequate to deal with this kind of infringement. Cases against technology companies are already in courts in North America and Europe. The larger question that generative AI raises is about the assault on the very idea of creativity. A painting, book, cartoon character or a piece of music are all forms of creative expression by individuals. They are all cultural products, born out of individual experience and context. For example, the work of the Ghibli Studio is a window to Japanese society and culture, just as the productions of Walt Disney Studio reflect American culture. Assigning such creative works as products of a machine or an AI system goes against the very idea of human creativity and passion. An artist may take months to finish a painting or a writer may take years to write a novel or a non-fiction book. Hundreds of hours of hard work go into the making of a cartoon or animation strip. Therefore, creators must get credit and money. AI companies are indulging in what critics say is data laundering and robbing creators of both credit and money. With every new generative AI - built on the work of millions of creators

 the valuation of AI firms rises by billions of dollars. They sell these models for thousands of dollars to users across the world, while creators get nothing. Image generators are not artists, but they are a challenge to artists. Generative AI has already started disrupting the creative industry globally. The most obvious impact of these products is job loss for artists, illustrators and designers in the animation industry. While AI-generated images lack the depth and expression of human-created images, they are of generally acceptable quality.

### Shielding the guilty officials and betraying the public

The attitude of senior officers to shield the misconduct and wrongdoings of juniors eventually leads to indiscipline, bad behaviour and corruption.

There is this unfortunate tendency of some senior police officers and some in other government departments to shield, cover up or overlook the misconduct and wrongdoings of junior officers and subordinate staff. Such misplaced sense of loyalty and support eventually leads to a breakdown of discipline and results in subsequent gross misconduct on the part of such subordinate staff. This happened in Punjab during the late eighties and early nineties when fake encounters had become the norm for the state police. During the mideighties, an air service was started between Kota and Delhi. A small shelter at the airport served as its office. General Officer Commanding (GoC) of the division in Kota, who was the seniormost army officer in Rajasthan, was stopped by a deputy superintendent of police (DSP) who wanted to carry out his body search before he was to board the aircraft. The GoC was in uniform and from where the DSP was standing, one could see the pilot jeep along with a number of military police personnel as the GoC arrived. The GoC did not allow the DSP to carry out his body search. The DSP was rude and had misbehaved. On return from Delhi, the GoC wrote to the DG Police in

Jaipur about the conduct of this DSP. The DGP did not respond, but his staff officer wrote back, justifying the DSP's conduct. The GoC pursued the case through staff channels. Finally, the Prime Minister's Office (PMO) issued instructions to the police to suspend the DSP and initiate disciplinary action against him. The attitude of senior officers to shield the misconduct and wrongdoings of juniors eventually leads to indiscipline, bad behaviour and corruption. There is this incident which took place in Patiala on the intervening night of March 13-14, wherein four police inspectors and eight policemen in civil dress beat up a serving colonel of the Army (Col Pushpinder Singh Bath) and his son while they were having food at a

The police personnel were apparently drunk, both with the false sense of authority and, perhaps, liquor as well. Otherwise, at least one the four inspectors would have tried to restrain the others from assaulting the colonel and his son. Even when the colonel told them that he was an army officer and showed his identity card, they did not stop beating him, but instead snatched his card and phone. They continued to hit him with sticks as he lay unconscious on the ground and kept beating his son as he tried to shield his father. These policemen told the son to collect the identity card the next morning only if they survived this encounter.A day before, these police personnel had staged an encounter and, for them, this was yet another encounter. The way the policemen continued to beat the colonel was nothing short of an attempt to murder. The colonel's arm and his son's nose were

fractured. The colonel's wife raised the alarm. She was driven from pillar to post as she tried to bring the case to the notice of the authorities. The policemen apologised and sought forgiveness from the colonel's family for their conduct and, at the same time, gave a veiled threat to the family as it had to live in Patiala and so also these police personnel. If one were to delve into the past record of these police inspectors, it is possible that it would be found that their previous wrongdoings had been covered up or, perhaps, even rewarded. Two, the names and other details of these police personnel were known to the police and the medical examination of the colonel and his son, carried out in the civil hospital, showed that they had not taken liquor. Subsequently, attempts were made by senior police officers to strike a compromise between the colonel's family and the police personnel.A second FIR by Col Pushpinder Singh was recorded after eight days, only when the incident had come into the public gaze and ex-servicemen had staged a 'dharna' in front of the deputy commissioner's office. Attempts seem to have been made to exclude the name of

one of the four inspectors involved in this crime. These policemen were merely suspended and not arrested and, that too, when pressure was built on the SSP, Patiala. The police constituted a team of senior police officers to look into the case. However, this incident of criminal assault, where an attempt seems to have been made to kill the colonel, is too serious a case to be dealt by a departmental inquiry. The colonel's wife made desperate attempts to meet senior police officers, but they could not see her as they were rather busy. The Chief Minister finally agreed to meet her on March 31. The response to her pleas from senior police officers made her realise that fair play may not come about. So, she demanded that the case be handed over to the CBI for an unbiased investigation.

## The dangers of excavating the past

The 'thousand years of slavery' makes emotions raw and leads to excavations that cannot be the priority of the Republic.

HISTORY is a minefield which can lead to great, unwelcome and unnecessary problems when India's overwhelming priority should be national consolidation, development and promotion of its strategic interests. The difficulties created by a deliberate focus on history, as is taking place now, become greater when persons, groups and parties view it through ideologically driven current political and electoral considerations. This inevitably leads to some historical figures and their clans being either stigmatised or applauded by different persons or groups. The question is whether the ruling dispensation's by now clear emphasis of India having undergone 'a thousand years of slavery' has let loose a genie. And, if so, what would be its consequences? Indeed, would it, as the ruling dispensation desires, lead to the coming together of the Hindus? Or, are there dangers that it will have the opposite impact — not only make old historical scars itch but also open social fissures among the Hindus who have remained closed over the centuries? One recent painful example of the social and political consequences of 'a thousand years of slavery' projection was witnessed in Parliament in the exchange over Rana Sanga. Ramji Lal Suman, Samajwadi Party Rajya Sabha member from UP, made unpalatable comments on Rana Sanga, who is venerated by the Rajput community as a hero. He is considered a hero by others too. Not only was there a furore in Parliament on the issue but Suman's comments also led to his house in Agra being attacked allegedly by a Rajput community group. Suman's own party has been drawn into the controversy, but it is treading a fine line. It does not wish to annoy either Suman's base or the Samajwadi Party's Rajput followers. As for Suman, media reports indicate that he has not withdrawn his comments. This controversy has not consolidated the Hindus but has had, in a small way, the opposite impact. Recently, in his podcast talk with Lex Fridman, Modi, recalling the contribution of Mahatma Gandhi to India, observed: "Another key factor to consider is India's fight for independence. India was ruled by the



Mughals, the British and several other foreign powers. Despite being bound by the shackles of colonial rule for centuries, the flame of independence burned brightly in every corner and nook of India, never fading, always fuelling the desire for freedom."Significantly, but not surprisingly, Modi has included the Mughals as a foreign colonial power in his formulation. This is obviously in line with the idea of 'a thousand years of slavery'. This idea is leading to demands — and these demands may only grow in time — by some sections that symbols of Mughal rule should not be allowed to stand.

Positive remarks on some controversial historical figures such as Aurangzeb also inflame passions in these hypersensitive times. The controversy surrounding Mughal Emperor Aurangzeb's grave which erupted last month led to demands by sections of the VHP and Bajrang Dal that the grave be removed from its location in Khuldabad, Chhatrapati Sambhajinagar district. The media quoted a memorandum given by the VHP to Maharashtra CM Devendra Fadnavis, stating inter alia:

"Having his memorial in India is an endorsement of his injustices; the grave should be properly removed....

A little over two weeks after the VHP's views, RSS' former sarkaryavah (general secretary) Suresh Bhaiyyaji Joshi said that the controversy over Aurangzeb's grave was 'unnecessary." He clarified that as Auranzeb had died in Khuldabad, he was buried there and anyone can visit his grave. It is interesting that the RSS toned down the VHP's demand; thus, indicating that the manner in which actions will unfold on handling the 'thousand years of slavery' period's remnants is not clear within the ruling dispensation. As during the period of British colonialism, during Mughal times or those of the Sultanate, too, there were some Indians who opposed the rule through different means and others who collaborated with it. During the Muslim period, a number of Indians got converted to Islam, while during the British rule, some became Christians. After Independence, the Congress party and others that emerged from the National Movement did not stigmatise those who had

collaborated with the British rulers. Indeed, Sardar Patel ensured that the Indian Civil Service and other elements of the bureaucracy continued to serve independent India, as did the British Indian army, which became the army of the Republic. The judiciary, too, continued and, finally, India adopted the British political system, too. Naturally, the heroes of the Republic were not those who aided the British or kept themselves completely aloof from the National Movement but those who led the fight for freedom. Also, these institutions imbibed the spirit of the Republic. Now, the impulses which wisely guided the Republic in its early years have given way to the stigmatisation of those who were impacted by western modes of thought which emerged from the European Enlightenment as 'Macaulay's children'. It is overlooked that 'Macaulay's children' never turned their back on India's ancient traditions but wanted a hierarchical society to become egalitarian and follow the path shown by the Republic's Constitution. The term 'Macaulay's children' is used by those who also have stressed the notion of a thousand years of slavery. So, now will those who were influenced by the Indo-Persianate culture (which has disappeared from India) be stigmatised? And what of those Hindu clans that had collaborated with the Mughals? Will a distinction be drawn between those who entered into 'matrimonial alliances' with the Mughals and those who refused to do so as they considered them humiliating? Certainly, such alliances were not on an equal basis during the Mughal period. Many clans that entered into matrimonial alliances with the Mughals held senior positions in the Mughal forces and administration. How should these Hindu grandees be looked upon? Naturally, Maharana Pratap and later Shivaji refused to submit to Mughal writ and they are rightly looked upon as heroes today. The 'thousand years of slavery' makes emotions raw and leads to excavations that cannot be the priority of the Republic as it confronts the challenges of these dramatically changing technological and global





### Over 50,000 power cuts lasting over five hours in last 10 years in Delhi: Minister Sood

NEW DELHI. Power Minister Ashish Sood on Thursday accused the Aam Aadmi Party (AAP) of misleading the public on power outages in the capital. Speaking at a press conference at the Delhi secretariat, Sood dismissed opposition claims, stating that the AAP government presided over 51,958 power cuts lasting over five hours in the last 10 years, averaging 14 long outages per day. Soood said the government is considering legal action against those spreading falsehoods and disturbing peace.

He asserted that no power grid in the world can function without scheduled shutdowns and questioned why prolonged power cuts occurred under Atishi's tenure despite AAP's claims of transforming the sector. Citing data from BSES and Tata Power, Sood detailed power cut incidents from 2015 to 2024, with peak outages in 2016 (8,659 instances) and the lowest in 2022 (2,692 instances).

He also dismissed Atishi's claim that data on power cuts was available on the state load dispatch centre (SLDC) website, stating that no such figures exist in official records.

Looking ahead, Sood said the government is working on transformer upgrades, removing overhead cables, and collaborating with the Public Works Department (PED) and the Delhi Jal Board to prevent waterlogging-related outages. With summer demand expected to rise to 9,200 MW, he assured that the government is implementing load balancing, setting up a 24hour control center, and reviewing power purchase agreements. The AAP has repeatedly accused the BJP-led Delhi government of mismanaging the city's power supply, citing frequent outages since it took office.

### Master plan to ensure clean water in Delhi Verma says initiative aims to tackle long-term water shortages and improve infrastructure

NEW DELHI. The Delhi High Court has ruled that driving at a high speed cannot automatically be deemed as rash and negligent behavior and stressed that speed alone is insufficient to establish culpability unless supported by concrete evidence of reckless conduct. Justice Saurabh Banerjee made the observation while discharging a man accused of driving at high speed and fatally hitting two pedestrians.

The accused had been convicted by a trial court under Sections 279 (rash driving) and 304A (causing death by negligence) of the IPC, 1860, and sentenced to two years of rigorous imprisonment. Reversing the conviction, the court noted a significant lack of evidence to demonstrate that the accused was driving in a reckless or negligent manner.

'Even assuming that the petitioner was driving at a 'high



speed', the same is not sufficient to conclude that he was, in fact, driving the car in a 'rash and negligent' manner," Justice Banerjee said.

The court pointed out that neither the witnesses nor

the prosecution had defined what constituted "high speed" in the case or provided any specific details about the speed at which the vehicle was being driven.

The HC observed that merely because the car, allegedly being driven at a 'high speed', hit two pedestrians, leading to their death, it is not adequate for a court of law to hold that the petitioner was being 'rash and negligent'. It further criticised the prosecution's case for its overall inconsistencies and lack of conclusive proof. "Succinctly put, there being an overall infirmity and unfilled lacunae in the case set up by the prosecution, it was not able to prove beyond reasonable doubt that the petitioner was indeed driving the car in a 'rash and negligent' manner, which resulted in the demise of the two pedestrians," the court

### Heritage tag for Delhi Old Secretariat likely soon

After Independence, the building saw a lull in activity until Delhi was granted an Assembly in 1952.



NEW DELHI. The iconic Old Secretariat building which houses the Delhi Legislative Assembly - may soon become a heritage site. Unveiling a plan to convert the 115-year-old structure into a heritage site, Assembly Speaker Vijender Gupta on Thursday said that he would take it up with Union Minister of Culture Gajendra Singh Shekhawat.

Once a symbol of imperialism, the Vidhan Sabha building housed both the Central Legislative Council (Parliament) and a temporary Central Secretariat when the capital of British India was shifted from Kolkata (then Calcutta) to Delhi in December 1911. After Independence, the building saw a lull in activity until Delhi was granted an Assembly in 1952.

However, the Assembly was disbanded in 1956. The building assumed fresh significance in 1966 as a Metropolitan Council was established in Delhi. The building has been the seat of the Delhi legislature since 1993. The Old Secretariat was designed by E Montague Thomas in 1912 and was completed in eight months. The Assembly had plans in 2022 to renovate the execution house - a two-room suite outside the Assembly chamber that can be accessed via a staircase and throw it open to the public.

NEW DELHI. Water Minister Parvesh Verma on Thursday inspected the Wazirabad Water Treatment Plant (WTP) and Sewage Treatment Plant (STP), announcing a 50-year master plan to ensure a sustainable and clean water supply for the city. The initiative aims to tackle long-term water shortages and improve infrastructure, he said.

A major component of the plan involves desilting the Wazirabad Barrage to double its storage capacity within the next one to one-and-a-half months. Verma stated that this measure will help prevent shortages, particularly during the summer months. He also criticized past administrations for neglecting Delhi's water infrastructure, emphasizing that his government is committed to transparency and effective governance. The minister also highlighted efforts to curb Yamuna pollution and illegal encroachments. "The Delhi Jal Board (DJB) has enlisted the help of the Indian Army's Territorial Army to prevent encroachments and waste dumping into the river," he said. He assured stricter surveillance and tougher enforcement against violators to restore the Yamuna's health.



Verma also announced the implementation of a comprehensive water management strategy to replace crisis-driven solutions with long-term reforms. The plan includes upgrading pipelines, preventing water leakage, and enhancing the distribution network to reduce wastage. He noted that

outdated pipelines and illegal water extraction have contributed significantly to Delhi's water issues, but the new approach will address these problems systematically.

To maintain transparency, Verma disclosed that the Total Dissolved Solids (TDS) level in Wazirabad's water stands at 170, which meets safety standards set by the World Health Organization (WHO) and Indian regulations. "I drank the treated water myself and verified its safety. Instead of fear-driven politics, we are taking concrete steps to guarantee clean water for every citizen," he said.

He also revealed plans for an IT-based dashboard to enable real-time tracking of water intake and output at WTPs and STPs. Reaffirming the government's commitment to ensuring uninterrupted clean water access for all Delhi residents, he stated, "Those using the water crisis for political gain will have

The vehicles, which were parked in the malkhana, had been seized under the 207 Motor Vehicle Act and 66 Delhi Police Act. Initial investigations indicate that approximately 300 to 400 vehicles were destroyed in the fire, the officials said, adding that the exact cause of the blaze remains under investigation. In a separate incident, a car caught fire on Wednesday night in the Ambedkar Nagar area of South Delhi. No injuries were reported in the incident.

Police said they received a PCR call around 9 pm regarding the fire. Upon arrival at the Khanpur to Chirag Delhi road, officers found a car engulfed in flames. The driver, Shakeel Ahmad, a resident of Jamia Nagar, stated that the fire started suddenly while he was driving.

Stressing the importance of an active lifestyle, Ibrahim Khan, master trainer at Talwalkars gym, said: "A sitting job would lead to lower back pain and spondylosis. A side effect of not working out would be slowing down of Basal Metabolic Rate (the rate at which we burn our calories), and weight gain."Leading holistic health guru Mickey Mehta has some easy-to-follow solutions."Use the staircase at least three times a day. Walk from your house or office to the bus stand. After every two hours, get

#### US trade policy offers both challenges and opportunities

New Delhi. The US government's decision on tariff on Indian imports is expected to have a major impact across multiple sectors. The new levies are likely to hit India's \$32 billion gems & jewellery exports hard, hit India's \$32 billion gems & jewellery exports hard, given the US accounts for \$11.58 billion, or 34%, of these exports. "While the tariff's application to competing nations presents both challenges and opportunities, it is expected to significantly impact India's diamond and jewellery sector, a cornerstone of its exports to the US," the Gem & Jewellery Export Promotion Council said in a statement. "In the short run, we see challenges in sustaining India's the short run, we see challenges in sustaining India's export volume of \$10 billion to the US market." The US is India's largest goods export destination, about \$78 billion in annual exports, or 18% of India's total

India has an annual goods trade surplus of about \$35 billion with the US. Auto parts and aluminium exports remain outside the scope of the latest 27% levy, though they will still be subject to the previously announced 25% tariff. This is expected to affect Tata Motors' JLR (exported from the UK), which derives 33% of its sales from North America.

"The tariff could force price hikes or cost-cutting measures to maintain margins. Given its premium positioning, JLR may have some resilience, but nearterm volume pressure is expected," said Sanket Kelaskar, analyst - institutional equity at Ashika Group. Since passenger vehicle exports from India to the US constitute less than 1% of total PV exports, tariff will not impact domestic automotive OEMs.The auto component industry will face challenges. India's auto components exports is 29% of industry revenues in FY24, with 27% of these exports going to the US.

#### Smartphone exports unlikely to be derailed by tariff move

NEW DELHI. India is in a better position compared to its key competitors in the electronics export sector, particularly China, Vietnam, Thailand, and Indonesia, following the Trump administration's tariff announcement, according to experts.

However, they advise the Indian government to continue negotiating with the US to lower tariffs and pursue a bilateral trade agreement. As per Donald Trump's announcement on April 2, 2025, Vietnam, Thailand, Indonesia, and Malaysia face tariff rates of 46%, 36%, 32%, and 24%, respectively. In contrast, Idia's reciprocal tariff rate stands at 27%. In 2023-24, India exported \$10 billion worth of electronics to the US. However, countries such as Saudi Arabia, the UAE, Brazil, and the Philippines have secured lower tariff rates, posing a threat to India's electronics exports.

"Several developing countries have secured notably lower tariff rates compared to India, including Brazil, Turkey, Saudi Arabia, the UAE (each at 10%), and the Philippines (17%). Saudi Arabia and the UAE represent near-term threats to India's electronics exports due to their SEZs, competitive manufacturing environments, and potential laborcost advantages. ### Biggest plunge for the dollar in a decade as Trump's tariffs send shockwaves through the global economy

NEW DELHI. Financial markets around the world are reeling following President Donald Trump's latest and most severe volley of tariffs, and the dollar slumped by as much as 2.6 percent versus the euro, its biggest intraday plunge in a decade, and suffered sharp losses also against the yen and British pound.

The U.S. stock market may be taking the worst of the tariff shock. Little was spared as fear flared globally about the potentially higher inflation and weakening economic growth that tariffs can create. Prices fell for everything from crude oil to Big Tech stocks to small companies that invest only in U.S. real estate.

The simultaneous decline in both stocks and the US dollar speaks volumes about investor confidence in Trump's trade policy," said City Index and FOREX.com analyst Fawad Razaqzada.

The U.S. Senate voted 51-48 to counter Trump's tariffs on Canada by ending the presidential emergency declaration on fentanyl Trump used to justify them. The S&P 500 sank 4.8%, more

than in major markets across Asia and Europe, for its worst day since the pandemic crashed the economy in 2020. The Dow Jones Industrial Average dropped 1,679 points, or 4%, and the Nasdaq composite tumbled 6%.Little was spared in financial markets as fear flared about the potentially toxic mix of weakening economic growth and higher inflation that tariffs can create. More than \$2 trillion in value vanished, according to Howard Silverblatt, a senior index analyst at S&P Dow Jones Indices.Everything from crude oil to Big Tech stocks to the value of the US dollar against other currencies of the Russell 2000 index of smaller



All the other broader market indices declined sharply as volatility rose due to chaos triggered by US President Donald Trump's reciprocal tariffs announcement, which led to heightened fears of a global recession. Vaibhay Porwal. Co-



Founder of capital market company Dezerv, said tariffs will create nearterm market volatility. "In this market environment, gains will likely be concentrated in select stocks rather than broadly distributed, making careful stock selection and active management strategies more effective than passive approaches," Porwal said.

It may be noted that auto, metal and IT stocks have been hit hard as Donald Trump's reciprocal tariffs have threatened to significantly hit the revenues of these export-heavy sectors. Tata Motors' shares were down nearly 5% amid concerns about exports of Jaguar Land Rover (JLR) vehicles to the US. Companies like Hindalco, Tata Steel, L&T and JSW

Steel also witnessed a steep

### **US** tech, retail stocks lead rout after Trump's tariff blow

NEW DELHI. Megacap US tech companies including Apple and retail giants Walmart and Nike led a global market meltdown as President Donald Trump's sweeping new tariffs heightened fears of a spike in costs across a wide range of industries. The tariffs, which threaten to destabilize the world trade order and unsettle businesses, mark a sharp reversal from just a few months ago when hopes of business-friendly policies under the Trump administration pushed US stocks to record highs. Trump said he would impose a 10% baseline tariff on all US imports along with higher duties on dozens of other countries, pushing U.S. tariffs to the highest in more than a century according to Fitch Ratings. Analysts and economists warned that hefty tariffs on imports from Asian manufacturing hubs and potential retaliatory measures could rattle global supply chains, dent corporate profit margins and significantly raise recession risks.Ken Mahoney, CEO of Mahoney Asset Management in Montvale, New Jersey, said some pre-announcements can be expected this earnings season. "What guidance can a company really give in this scenario when things are looking so dire?""Even before tariffs were actually set in stone, we heard from companies like Walmart and

Speaking at the Startup Maha Kumbh on Thursday, Goyal criticised the current direction of Indian startups. He pointed out that while many Indian startups are focusing on food delivery, betting, and fantasy sports, Chinese startups are working on electric vehicles, battery technology, semiconductors, and artificial intelligence.

"Do we have to make ice cream or chips? Dukaandari hi karna hai (Do we just want to do shopkeeping)?," Goyal asked during his speech. He questioned whether the country was content with creating gig jobs instead of aiming for deeper innovation and long-term progress in key technologies. These comments have led to strong responses from well-known names in the startup and tech world. Mohandas Pai, former CFO of Infosys and

a prominent investor, said the comparison with China was unfair and unhelpful. He raised concerns about the role of government policies in slowing down the growth of deep tech in India.

Minister @PiyushGoyal should not belittle our startups but ask himself what has he done as our Minister to help deep tech start ups grow in India?" ## From Olympic heartbreak to winning bagful of medals: Rower Tyagi's story

CHENNAI: As New Year 2024 dawned, rower Ajay Tyagi was in a happy space and dreaming of qualification for the Paris Olympics. And why not? He was already in the national camp and the next few months were going to present him ample opportunities to make it to his maiden Games. Things, however, went downhill from there as he was excluded from the camp and went out of contention to qualify for the marquee event. It was a difficult period for Tyagi, a Havildar in the Indian Army, who even thought of quitting the sport and communicated the same to his coaches. "Had they not convinced me, I would have left the sport last year," 25year-old Tyagi told this daily following his return from Tasmania, Australia where he won two gold and a silver at the 2025 Australian Rowing Championships. He then made a return to the sport during the Indoor Nationals in Moga, Punjab in July 2024 and won gold in the lightweight pair event.

"Representing the country in the Olympics is every athlete's dream and I was no different. I don't know why I was excluded from the camp ahead of the 2024 Games. I didn't compete at the 2024 National



Championships as I was told to focus on my preparations. Later, they picked only gold medallists from the nationals for the camp."Tyagi's return coincided with the Indian Army hiring services of Australian

coach Antony Patterson and it changed his outlook towards the sport completely. "He brought his training methods. We were made to take tests every month and our progress was gauged from our performances there. I saw huge improvements in my timings both in water and on ergometer. My timings have improved by 6-7 seconds outdoors while the timings on ergometer saw an improvement by four seconds. Earlier, we used to work on ergometer for 30 minutes but the foreign coach made us work there for an hour. It improved our stamina," noted the rower, who hails from Ghaziabad, Uttar Pradesh.An improved Tyagi was ready for his second stint and the hard miles he had done started to bear fruit as he went on a medal-winning streak. ## Sumeeth eager to share hard-earned wisdom to youngsters

Having recently called time on his playing career, former badminton doubles ace from Telangana determined to lift current crop of players

CHENNAL B Sumeeth Reddy recently made one of the biggest decisions of his life. Having dedicated his life to badminton for over two decades, he called time on his professional career. His playing days might have ended but it's also the beginning of a new chapter, a chapter he hopes will bring wealth of success. Brimming with hardearned wisdom, Sumeeth, having donned the hat of a coach, is now eager to pass on the knowledge to youngsters in the days to come. "I only wanted to do it (retire) when I felt like I couldn't improve any further than whatever I was during my peak. Lately, I could feel that my body wasn't able to keep up. I had lost a

lot of power due to a back issue. Despite that,

I used to manage because of my experience. Even last week, I was World No 25. However, I couldn't get myself into the top-10, something that was always in my mind. Maybe, I could have pushed a little more but that would not fulfill my goal," he said.

Once recommended by the doctors to quit playing the sport (due to a back injury), the man from Telangana had overlooked their suggestion to soldier on and carve out a respectable career for himself. Against all odds, Sumeeth, alongside partner Manu Attri, had made history in 2016 by becoming the first men's pair from the country to qualify for the Olympics. Manu and Sumeeth climbed as high as World No 17 at their peak. That might pale in comparison to what Satwiksairaj Rankireddy and Chirag Shetty has produced, but it was a significant push for Indian badminton then. It was not just his personal injury that Sumeeth was battling, the Indian doubles department, for various reasons including the results, did not use to get the attention required to thrive at the elite level. He has played alongside other notable players like Ashwini Ponnappa and N Sikki Reddy, with whom he tied the knot in 2019, in the mixed doubles category as well. Being part of the Olympics is something that

will remain in his heart forever. "Getting selected for the Olympics was special. Only 13 spots (three others would be part of continental quota) were there and to be part of that number was always special. I had to wait 12 or 16 years to get the Commonwealth



medal. I had always missed it by a whisker. That was special. We also had some big scalps against top-ranked players. That was special too. All those Grand Prix wins were also quite special," he recalled.Despite the injury that ended his aspirations to become a singles star (he was former India junior No 1 in singles) and despite the challenges that tested players from doubles category then,

Sumeeth is filled with gratitude. "We were lucky that we were at one of the top centres in the country, the Gopichand Academy. The atmosphere was always positive, looking to win big titles. Apart from that, my dad has

always been a source of strength and motivation. He was also a national athlete. Obviously, he couldn't get any support from my grandparents and he wanted me and my brother to pursue sports. He always supported me. I could see him day in and day out and that pushed me to achieve bigger things in life."The 33-year-old is encouraged by the talent in store, especially Treesa Jolly and Gayatri Gopichand apart from Satwik and Chirag. But he also felt that doubles players, especially the youngsters, still have a lot of learning to do."When I started, I had helped them (Treesa and Gayatri) for a month before



ive years after Sushant Singh Rajput's death sent shockwaves through India, the Central Bureau of Investigation (CBI) officially closed the case, citing no foul play and confirming it was a suicide. While the final report may bring legal closure, the emotional scars left on those caught in the storm-particularly actress Rhea Chakraborty and her family-remain deep and unhealed.Now, Rhea's close friend Nidhi Hiranandani has come forward in a powerful interview with Indian Express to speak about the chaos, trauma, and isolation the Chakrabortys endured during the relentless media and legal trial that followed Sushant's death. Her account paints a picture of a family ripped apart not just by accusations, but by a public narrative that left no room for empathy or nuance.

Vidhi remembers the exact moment the nightmare began. "Rhea's parents treated Sushant like family," she said. "They were shattered when he passed. I saw how they broke down, how their mental health was already suffering. What Rhea went through was unprecedented. I felt helpless watching their life being ripped apart."

n the months following Sushant's death in June 2020, Rhea became the face of the scandal. She was accused by the late actor's family of financial misconduct, abetment to suicide, and controlling his life. The Narcotics Control Bureau later arrested her for allegedly procuring drugs for Sushant—a charge that would later be weakened by lack of substantial evidence. She spent nearly a month in jail before being granted bail. But the damage, Nidhi says, had already been done.

There was a wave of hatred, and everybody was riding it," Nidhi recalled. "We were begging and pleading with people to talk for us, to speak out. But nobody wanted to. No one wanted to focus on the truth-they just wanted someone to hate. Rhea became that person. She became the scapegoat."
