Jawed, a Lok Sabha MP from Kishanganj in Bihar, was a member of the Joint Parliamentary Committee (JPC) on the Bill and has alleged in his plea that the Bill "introduces restrictions on the creation of Waqfs based on the duration of one's religious practice".

PM Narendra Modi conferred Sri Lanka's highest civilian honour 'Mitra Vibhushana'

New Delhi, Apr 05: Sri Lanka on Saturday conferred its highest civilian honour, the Mithra Vibhushana, on Prime Minister Narendra Modi, who said the award reflects the historic ties and deep friendship between the two countries. The honour was introduced in 2008 and has been bestowed on former Maldivian president Maumoon Abdul Gayoom and late Palestinian leader Yasser Arafat in the past. The award was presented to Modi by President Anura Kumara Dissanayake during a ceremony at the presidential secretariat in Colombo. "It is an honour for me to be awarded the Sri Lanka Mithra Vibhushana by President Dissanayake," Modi said, adding that this was also an honour for 1.4 billion Indians. The recipient is awarded a citation and a silver medal to be worn around the neck, studded and adorned with nine types of Sri Lankan gems and the symbols of a lotus, globe, sun, moon and sheaves of rice. The Dharma Chakra on the medal reflects the shared Buddhist heritage that has shaped the cultural traditions of both nations. The Pun Kalasa or ceremonial pot adorned with sheaves of rice symbolises prosperity and renewal. Stock market slide: Akhilesh Yadav says common people losing money

Lucknow, Apr. 05: Samajwadi Party chief Akhilesh Yadav on Saturday said it is very important to pay attention to the slump of India's markets as common people are losing their money and this could cause the economy to sink. In a post on X in Hindi, the former Uttar Pradesh chief minister held the central government responsible for this "double vicious circle" of the economy. Indian markets plunged on Friday after US President Donald Trump announced sweeping reciprocal tariffs, including 27 per cent on India, to reduce the trade deficit and boost domestic manufacturing. "It is very important to pay attention to the loss of millions of crores in the country's stock market because the

UK PM Keir Starmer in talks with world leaders as stocks fall after Trump's tariffs

Washington, Apr 05: The UK's FTSE 100 suffered its worst day since the start of the pandemic as Keir Starmer agreed that "like-minded countries must maintain strong relationships" in the wake of Donald Trump's tariffs. Trading across the world has been hammered in the aftermath of the US president unveiling his full range of import taxes on countries around the world. The Prime Minister spoke to the leaders of Australia and Italy on Friday - the first in a series of calls expected with world leaders over the weekend – as nations reel from the economic hit. London's top stock market index shed 419.75 points, or 4.95%, to close at 8,054.98 on Friday, the biggest single-day decline since March 2020 when the index lost more than 600 points in one day. From Saturday, UK goods imported into the US will be subject to a 10% import tax, and the car industry has already been hit with a 25% levy which came into effect in the early hours of Thursday morning. Downing Street has said that Sir Keir, Anthony Albanese and Giorgia Meloni "all agreed that an all-out trade war would be extremely damaging". Issuing a readout of the sepa-

rate discussions on Friday, a Downing Street spokesperson said the PM "has been clear the UK's response will be guided by the national interest" and officials will "calmly continue with our preparatory work, rather than rush to retaliate". "He discussed this approach with both leaders, acknowledging that while the global economic landscape has shifted this week, it has been clear for a long time that like-minded countries must maintain strong relationships and dialogue to ensure our mutual security and main-

tain economic stability," the spokesperson added. "They all agreed that an all-out trade war would be extremely damaging and is in nobody's interests, while agreeing to keep in close contact in the coming days." Pharmacy student dies, Deputy CM Pawan Kalyan promises justice to bereaved family



RAJAMAHENDRAVARAM. Naga Anjali, a 23-year-old pharmacy student who attempted suicide by administering a poisonous injection on March 24, died on Friday while undergoing treatment at a private hospital in Rajamahendravaram. Prakashnagar Circle Inspector SK Bajilal confirmed her death and stated that the body was handed over to her parents following a postmortem. The family has taken her remains to their native village in Jeelugumilli mandal of Eluru district. Police have arrested the accused, Deepak, manager of the private hospital.

Deputy CM and JSP chief Pawan Kalyan expressed his condolences to the bereaved family and condemned the incident. He assured the student community that the government would take strict action against those involved in harassing female students. He added that he would discuss the matter with the Home Minister and CM, highlighting the seriousness of the case and the need for justice. Former MP Margani Bharath also demanded that the State government provide compensation to Anjali's family.

Sircilla weaver crafts gold saree for Ram Navami

RAJANNA-SIRCILLA. Veldi Hariprasad, a weaver from Sircilla, has created gold and silk clothes (a saree and shawl) for the celestial wedding at Bhadradri temple during Sri Ram Navami.

Hariprasad spent 10 days weaving the saree, which features images of the Bhadradri temple idols, a conch, and a lotus motif. The names of Hanuman and Garutmanta appear along the border. The entire saree is woven to repeatedly display the verse "Sri Rama Rama Rameti Rame Rame Manorame Sahasranama Tulyam Ramanama Varana'

Hariprasad used one gram of gold and silk thread, resulting in a seven-yard saree weighing 800 grams. He has received appreciation for creating rare sarees for deities and has been offering such sarees during Sri Ram Navami for the past three years. He requested Chief Minister A Revanth Reddy to place orders through the Endowments department to support handloom weavers and provide more opportunities. Hariprasad is known for weaving the 'Rajanna Siripattu' saree, which was launched in New Zealand.

Another weaver, Nalla Vijay, produced a saree containing 20 grams of gold, valued at Rs 2.80 lakh. The five-and-a-half-metre saree has been ordered by a businessman from Bellary in Karnataka.

Seven held in crackdown on cricket betting rackets in Telangana

NIZAMABAD. Nizamabad police have cracked down on illegal cricket betting, arresting seven persons from two gangs operating in Nizamabad and Armoor. Several mobile phones and motorbikes were seized from them. The police stated that the accused, who established an illegal betting business, is estimated to be worth over Rs 88

Commissioner of Police P Sai Chaitanya presented the accused and case details to the media on Friday. Based on a tip-off, the police arrested four people — Sheikh Mujeeb Ahmed, Sheikh Nadeem, Sheikh Junid and Sheikh Rehan - from Autonagar, Bharathi Rani Colony under Fifth Town Police limits.

Mujeeb admitted that they contacted a man named Sachin from Nanded, Maharashtra, through Shakeel of Salura village. Sachin provided access to online betting apps. Referred to as a "Master", he appointed agents (Bookies), who created user accounts and handled deposits and withdrawals. The agents earned 7% commission by recruiting users. Over 200 youth joined the apps this IPL season, with nearly 5,000 transactions recorded.

The police recovered Rs 50,000 cash, five mobile phones, bank passbooks, one credit card and one debit card. Four more suspects are absconding.

In a separate case in Armoor, the police arrested Gattadi Vadda Gouth, Dayal Sunil and Jaju Ranjith. Five others are absconding. The trio received betting app links from contacts in Haryana and Maharashtra and invested earnings in money-lending, using bikes as collateral. The police seized 34 bikes, mobile phones and Rs 6,000 cash from their possession.

Commissioner Sai Chaitanya stated that betting has been banned by the state government and is being treated as cyberterrorism. He linked betting to several suicides in the district and appealed to youth to avoid the lure of easy money.

Indian seafood sector left in rough waters as Trump's tariffs kick in

India exports vanamai shrimp, black tiger shrimp, squid and cuttle fish to the US market and the country's seafood export stood at Rs 60,524 crore in 2023-24.

KOCHI. The decision of the US administration to impose a 34.26% tariff on Indian marine food products has left the seafood exporters and shrimp farmers in the country in deep distress. Though there is no indication of tariff negotiations, the seafood exporters are hopeful that the US may reduce the tariffs. If the US administration refuses to reduce the reciprocal tax, small producers like Ecuador may take over the US market riding on the tax advantage and India will be the loser as we have a 40% share in the US seafood market.

As per information, the US has decided to impose an anti-dumping duty of 2.49%, countervailing duty of 5.77% and reciprocal tariff of 26% which will raise the tariff to a total of 34.26%. The situation will be advantageous to Ecuador as its tariff is only 13.78%.

"Despite the ban on Indian wild-caught shrimp, the US continues to be the biggest market for Indian seafood products. We have around 35 to 40% share in the US market. The reciprocal tariff of 26% will make our products expensive and there are chances of Ecuador taking over the market. The buyers have already asked us to stop shipping new consignments. Many



consignments are already on the way and we fear the buyers may demand a discount or reject them. There is uncertainty over shipping the inventory in the cold storage. The exporters are forced to stop procurement as we will be forced to reduce the rates," said Seafood Exporters Association of India vice-president, Alex

India exports vanamai shrimp, black tiger shrimp, squid and cuttle fish to the US market and the country's seafood export stood at Rs 60,524 crore in 2023-24. The earnings from frozen shrimp export alone stood at Rs 40,013 crore during the period. The export firms in Kerala ship around Rs 8,000 crore worth

seafood products per year and a major share of the products go to the US market.

We will have to concentrate more on the European and China market as the high reciprocal tax will make our products expensive in the US market. But we cannot afford to lose a market like the US as there is no other country that consumes so much of shrimp. We are hopeful that the US may reduce the reciprocal tariff after talks. Besides, the reduction of duty on feed by the India government will reduce the farmers' production cost by around Rs 30. The buyers, exporters and farmers will have to share the burden," said Seafood Exporters Association Kerala Chapter president M R Premachandra

"The reciprocal tariff and anti-dumping duty will affect around 130 export-oriented seafood processing units in Kerala and the thousands of workers in the sector. The Kerala government should send a delegation to Centre to raise Kerala's concern before the Union government," said Kerala Fishermen Coordination Committee president Charles

Air conditioners to push peak power demand beyond 7,000 MW by 2026-27

On the other hand, battery systems that allows bulk electricity storage for later use, offer quicker deployment, and greater location flexibility.

THIRUVANANTHAPURAM. Use of air conditioners, induction cookers, and charging of electric vehicles will mainly contribute towards the state's peak electricity demand crossing 7,000 MW by 2026-27, according to a report by the Energy Management Centre (EMC)-Kerala, an agency under the state power department.

the peak demand was approximately 5,300 MW. In the report titled 'Analysing Viability of Energy Storage Systems at the Sub-national Level', EMC has recommended that large-scale battery energy storage systems and pumped storage projects be deployed to handle the rising demand.

ACs will be the prime energy increase of 15% in consumption over the next three years, the report said. This at a time when the state's overall energy consumption is growing at a pace of just 5.1%. From 348 million units (MU) in 2024-25, ACs are projected to consume 400 MU in 2025-26 and 460 MU in 2026-27, registering a cumulative Possible solutions consumption of 1,208 MU over While recommending pumped three years.

In the just concluded fiscal year, Notably, induction cooktops are set to edge past EVs by a slight margin to claim the spot for the second major power demand driver by 2026-27. The report noted that the power consumption of induction cooktops is expected to rise by a whopping 80% over the next three years. A cumulative consumption of 340 MU is expected till 2026-27, the report

Jarkiholi claimed that the BJP itself had previously raised prices of petrol, diesel, and essentials. "How many times have fuel prices been hiked over the past decade? The increase in prices at that time triggered the current situation. Why didn't the BJP protest back then?" he questioned.

He explained that the rising population and the need to fund development works have made price hikes inevitable. When asked about protests by the Opposition,

Jarkiholi said they should be "scientific" and constructive. He also noted that the newly built Karnataka Bhavan in New Delhi now has 70 additional rooms, which will help



ease accommodation issues for visitors. Jarkiholi mentioned that Karnataka does not receive any revenue from highway toll hikes. During a recent visit to New Delhi, he said he could not meet leaders of the Congress high command due to the rush of people seeking Legislative Council nominations and other appointments. For 2,800 prisoners, Bhondsi jail has 1 doctor, NHRC finds; Sactioned posts of medical officers 3, gaps in security facilities too

Gurgaon. No woman doctor, insufficient medical staff, severe lack of facilities and gangsters using mobile phones — Bhondsi Jail is reeling under several problems. While the jail lacks adequate healthcare services for its inmates, there is only one medical officer appointed for the health services of over 2,800 prisoners, even though there are three sanctioned positions for medical officers. The lack of primary medical check-up facilities is causing difficulties for the inmates.

Sick prisoners are sent to Civil Hospital in Sector 10 for routine tests, whereas such facilities should be available within the jail as per regulations. There is no woman doctor for female inmates, raising concerns about how sick women can discuss their health issues with a doctor. The use of mobile phones by gangsters has also not stopped, a National Human Rights Commission (NHRC) official said after inspection of the jail that has been included in Haryana's list of high-security prisons. These shortcomings — among a

plethora of issues plaguing the jail were revealed during an inspection by NHRC's special monitor Balkrishna Bhondsi Jail and an old age home were conducted on Tuesday, uncovering several deficiencies that need to be rectified promptly. "The inspection report will be submitted to the chairman of NHRC and subsequently sent to the chief secretary of Haryana to address the issues," he said, adding, no human rights violations will be

Goyal told TOI that although the wages for working inmates are transferred to their accounts on time, "they lack information on how to use the money and thus are unable to utilise it." "Additionally, there are no jammers to prevent inmates from using phones. The jail has 2G jammers, while 5G networks are operational on mobile phones, allowing inmates to potentially use them. ACB probe unveils major flaws

in key Ardee City road

The thickness of the road failed to meet standards, and the surface was damaged with numerous potholes, a bureau team found in the April 1 inspection following a complaint about the use of poor construction material.

Preliminary findings indicated the contractor failed to adhere to standard road construction guidelines, holding MCG officials and contractors accountable for the substandard construction work. MCG constructed the road during the lockdown in 2020 when Ardee City was not under its jurisdiction back then.

An ACB official said the bureau will take necessary action to tackle the matter."We will also get the road quality checked. If the ACB team has taken samples for the assessment, we can take action based on the results; otherwise, we will also get it checked. Moreover, punitive action will be taken against those responsible," said MCG chief engineer Vijay Dhaka."The road, constructed in 2020, was initially built nine inches above other roads in Ardee. After we raised concerns, it was reconstructed to prevent flooding issues. Despite construction and reconstruction within six to seven months, the road was dilapidated in less than a year. Currently, vehicular movement on this stretch proves challenging," said Ardee City resident Chaitali Mandhotra. Ardee City residents said they repeatedly requested municipal officials to inspect the quality of Ardee City roads for several months and raised the issue through TOI on March 16. 
mortality rates in the country despite an year-on-year improvement, annual health report for 2024-25 released by Union ministry of health and family welfare has revealed. Forty-three out of 1,000 children born in UP die before their fifth birthday, the report said, adding the current infant mortality rate (IMR) stood at 38 per 1,000 live births, while the neonatal mortality rate (NMR) was 28. The state stands after Madhya Pradesh, where infant mortality rate is 43 out of 1,000 live births and NMR is 31. This is much higher than the country's average IMR of 28 and MNR of 20.Doctors attributed a significant share of infant deaths to infections during childbirth or septicaemia caused by poor hygiene, especially due to a lack of institutional deliveries. The report also flagged that UP was among the few low-performing state (LPS) when it came to institutional childbirth. "Home births are still prevalent in UP, especially in rural areas. This is mostly due to the unavailability of institutional facilities," a senior doctor at Child PGI, Noida, said.

Unicef India report, published in 2020, suggests that nearly 46% of all maternal deaths and 40% of neonatal deaths happen during labour or in the first 24 hours after birth."Pre-maturity (35%), neonatal infections (33%), birth asphyxia (20%) and congenital malformations (9%) are among the major causes of newborn deaths," the report stated. The annual report, however, states UP and Karnataka saw the highest drop in under-five mortality rate, each by five points from 2019 when it was recorded at 48 out of 1,000 live births. In comparison, India's average decline was three points from 35 per 1,000 live births in 2019 to 32 per 1,000 live births in 2020. However, UP continues to remain "behind the all-India average of these indicators", states a CAG report, released in Dec 2024.

Noida woman kills kids, dies by suicide after quarrel with husband over breakfast

Noida. A 35-year-old woman and her two minor children, aged 6 and 5, were found dead on the roof of their house in Bisrakh on Thursday morning. Police suspect the woman died by suicide by hanging herself with a scarf after killing her children following a quarrel with her husband. Police were alerted on the emergency helpline, Dial 112, by neighbours after they spotted the bodies around 10.45 am. The woman, Aarti, and her children were taken to a nearby hospital by her family members but were declared brought dead."Initial investigation shows Aarti and her

husband, Rajkumar, were having domestic trouble and would fight frequently. The couple, married around 12 years ago, have three children. On Thursday, Aarti took the two younger children to the roof and hung them with a scarf before dying by suicide herself. The couple's eldest daughter was also in the house, on one of the lower floors, during the incident," DCP (Central Noida) Shakti

Year-long study done, report to reveal local polluters & impacts in Gurgaon

Gurgaon: Every winter, the air quality in Delhi-NCR plummets to dangerous levels. The wait to identify the primary contributors to the city's air pollution levels will be over next month. A source appropriation study focusing on identifying local polluters, which started on Feb 1 last year, is now complete.

The final report will be submitted to Haryana State Pollution Control Board (HSPCB) in May. "The study conducted by Automotive Research Association of India — is finalised and we will get a final report by next month," HSPCB regional officer Nirmal Kashyap said.The source appropriation study's findings will be crucial in assisting authorities to implement effective measures to combat air pollution, as the lack of uniformity in efforts to improve air quality has been a major challenge.

An HSPCB official said, "The study will help us understand which industries to close down, when and for how long. After data collection, validation and interpretation, researchers will create a detailed roadmap for air quality improvement using all possible measures." The official, however, declined to comment on why the study was initiated only last year instead of earlier. Every winter, the region is enveloped by a blanket of toxic haze due to a combination of cold weather and local emissions like garbage burning. Additionally, farm fires, commonly seen in north India's agricultural belt to clear tracts of land for another round of sowing after the paddy harvest, contribute significantly to the pollution during this period.

"Now that the data collection is complete, we will carry out validation and interpretation of the assimilated information. A detailed road map will be drawn considering all possible measures for air quality improvement,' Kashyap said.HSPCB officials say these measures will be classified into short and long term, with due priority to low-cost measures that give maximum benefits. Two similar studies were already conducted in Delhi, by IIT Kanpur in 2010 and National Environmental Engineering Research Institute (NEERI) in 2019.

2 slabs fall from 23rd floor of highrise, miss woman by a whisker in Gurgaon

Gurgaon. A woman had a narrow escape when two concrete slabs fell from the 23rd floor of tower 5 in ATS Kocoon in Sector 109 on Thursday evening. The woman was gardening at her ground-floor lawn.

Two slabs, weighing 45kg and 35kg each, lodged six to nine inches into the ground. The falling of the slab highlights serious structural safety concerns in the highrise complex. Meanwhile, the residents of ATS Kocoon have demanded a safety audit. A formal complaint has been sent to the district administration and the department of town and country planning (DTCP).ATS group spokesperson said, "The alleged incident has been brought to our notice. Without prejudice to anyone, at the outset, it appears that a plaster moulding has fallen into the private lawn of a resident in the complex. It is certainly not a concrete block, as alleged in your queries. We have initiated an investigation into the alleged incident and the reasons thereof. The company will take every necessary measure to safeguard the

interests of every complex resident."Apra Agarwal, the resident, recounted the terrifying moment. "I had just finished watering the plants and turned around to



step inside when there was a deafening crash behind me. If I had been there even a second longer, I wouldn't be alive today," she said. The slabs landed exactly where she had been standing moments earlier.Residents of the society say this is not an isolated incident. Apra recalled a similar scare when a slab from the 9th floor had fallen into the front lawn earlier.

SC halts demolition of illegal construction in DLF phases in Gurgaon, town planner & cops return

Gurgaon. The Supreme Court on Friday stayed a demolition drive in DLF phases 1 to 5 by the town and country planning department, halting a team that had arrived at the site to bring down illegal constructions and residential properties turned into commercial complexes like gyms and guesthouses. The division bench of justices JK Maheshwari and Aravind Kumar ordered a status quo, slamming the brakes on all current and planned hearing, slated four weeks from now. The SC was hearing a petition by DLF Qutub Enclave RWA, challenging the country planning department's authority to act on these properties. Lawyers Indira Jaising and Anuj Saxena — who represented the RWA — argued that the five DLF phases had been under the jurisdiction of Municipal Corporation of Gurgaon (MCG) since 2008, which meant that only the civic body had the power to initiate

actions such as demolitions."There are two conflicting orders from different division benches of the Punjab and Haryana high court regarding constructions in DLF phases. So, it is legally questionable how action could be taken based on only one of the orders. The Supreme Court has rightly asked all parties to maintain status quo and issued notices seeking responses from all

enforcement measures until the next The next hearing is scheduled after four weeks," Saxena said on Friday. On Feb 13, the HC asked authorities to pursue action against unauthorised constructions, alterations and commercialisation in residential zones of DLF areas. The court also sought an action-taken report by April 19. Subsequently, the department issued over 4,500 show-cause notices and restoration orders to more than 2,200 houseowners in the five DLF phases.

A third of Gurgaon's Aravali land under threat: Notification barring nonforest activities in Manesar, Farrukhnagar expired a decade ago

Manesar and Farrukhnagar tehsils, which constitute over one-third of Gurgaon's total area, are currently vulnerable to treefelling and destruction. This vulnerability stems from the expiration of a notification that barred non-forest activities in this region a decade ago, Haryana forest department told a bench of National Green Tribunal (NGT) at a hearing while submitting a report to the green tribunal on Thursday.

The forest department said it has taken significant steps to protect these areas. It has sent a proposal to the state govt to include Manesar and Farrukhnagar tehsils under the tree felling regulations. According to the forest department, the proposal was sent to Haryana govt in Feb this year. The state govt has been urged to set up a panel, the NGT was informed.

City-based activist Vaishali Rana said on Friday, "The forest department's initiative to include the Manesar and Farrukhnagar areas under tree regulation and their proposal to establish a committee for creating a policy on tree felling regulation in non-forest areas is a positive step. It is crucial for the govt to act swiftly to ensure the protection of trees in these non-forest regions."These proposals aim to address several key concerns raised by the applicants in the ongoing case of Vaishali Rana & Ors. vs. Union of India & Others (O.A. No. 680/2024), currently under review by National Green Tribunal (NGT) principal bench. The plea filed by



Vaishali Rana contends numerous trees were cut down in the city (Gurgaon) without authorisation and for these "egregious violations", the divisional forest officer imposed paltry fines of Rs

Rana's plea also questioned the process of granting permission for felling trees, terming it arbitrary. She argued that while the tehsils of Gurgaon, Sohna and Pataudi are covered under the Punjab Land Preservation Act (PLPA), 1900, Manesar and Farrukhnagar tehsils, though in the same district, are not covered by the law, exposing those areas to incidents of treefelling. Shame on you all," she added.Suleyman responded calmly, saying, "Thank you for you want total bearage." you for your protest, Î hear you."

However, the protester continued, accusing him and Microsoft of having "blood on their hands."

AI in military operations

The protest comes as there has been increasing scrutiny of how tech firms, including Microsoft and OpenAI, sell AI tools to the military. An earlier report by The Associated Press this year claimed that the AI models produced by the companies were being used by the Israeli military to select bombing targets. The report further cited a disastrous incident in 2023 when an Israeli airstrike accidentally destroyed a car in Lebanon, killing three young girls and their grandmother. Earlier in February, five workers were banned from an in-house meeting with CEO Satya Nadella when they protested over the company's contracts with the military. Meanwhile, Friday's demonstration was more high-profile because it occurred during a livestreamed celebration.

Magnitude 6.9 earthquake strikes Papua New Guinea, tsunami warning cancelled

world. WELLINGTON: A tsunami warning was cancelled for Papua New Guinea after a strong magnitude 6.9 earthquake, according to the US Geological Survey.

The quake was shallow, striking the Pacific island nation at a depth of 10 kilometers (6 miles) on Saturday morning local time. It was centered offshore, 194 km (120 miles) east of the town of Kimbe, on the island of New Britain.

The Pacific Tsunami Warning Center later called off an alert issued immediately after the jolt that warned of waves of 1 to 3 meters along some parts of the Papua New Guinea coastline. A caution about smaller waves of 0.3 m issued for nearby Solomon Islands was also called off. There were no immediate reports of damage. Just over 500,000 people live on the island of New Britain. Australia's Bureau of Meteorology said there was no tsunami threat to the country, which is Papua New Guinea's closest neighbour. No warning was isued for New Zealand.

"Oops": Trump Shares Video Showing Deadly Strike On **Houthis In Yemen**

Washington, United States.US President Donald Trump on Friday posted a video purportedly showing dozens of Huthi fighters being killed in an American strike on Yemen, adding the comment "oops."Resembling images shot from military drones or other loitering aircraft, the black-and-white footage Trump posted to his Truth Social network shows several dozen human figures from an almost vertical angle."These Houthis gathered for instructions on an attack," Trump wrote in an accompanying text, using an alternate spelling for the Yemeni rebel group. American forces have carried out major raids on Yemen in recent weeks in response to the group's attacks on Red Sea shipping. Gathered in a loose oval along a road, the people in the video are superimposed with a gun camera-style crosshair.

A few seconds in, a bright flash appears in the middle of the scene, followed by billowing smoke. From IRS to EPA: Full breakdown of historic US government layoffs

UPDATED President Donald Trump and billionaire Elon Musk are undertaking a sweeping campaign to cut the size of the 2.3 million-strong civilian US government workforce. Nearly 200,000 employees have been fired or earmarked for termination or have accepted buyouts.

The layoffs have primarily been aimed at probationary workers, many in jobs for less than a year with fewer job protections than longer-tenured staffers.A judge ruled in March that the terminations of some 25,000 probationary employees were likely illegal, forcing federal agencies to begin reinstating themMeanwhile, a new wave of cuts targeting career government workers has begun and is intensifying after Trump ordered federal agencies to submit plans for large-scale layoffs by March 13.

Here are details of some of the layoffs at federal departments and agencies gleaned by Reuters reporters.

UNITED STATES INSTITUTE OF PEACE Employees at the United States Institute of Peace received termination letters Friday

evening, according to people familiar with the matter. The organization, an independent, nonprofit organization funded by Congress, employs about 300 people at its Washington headquarters.

The mass firing came less than two weeks after DOGE staffers gained access to USIP's headquarters in Washington with the help of police officers, prompting the institute to accuse Musk's team of occupying its building by force.INSTITUTE OF MUSEUM AND LIBRARY **SERVICES**

All employees of the Institute of Museum and Library Services, a federal agency with about 75 workers which provides funding for America's libraries and museums, were placed on administrative leave on Monday, according to a union statement.

The American Federation of Government Employees Local 3403 said in a statement that all employees were put on leave following "a brief meeting between DOGE

staff and IMLS leadership" and told to turn in all their government equipment.

The US Department of Health and Human VETERANSAFFAIRS jobs and close half of its regional offices, it said on March 27, a major overhaul of the department under Secretary Robert F. Kennedy Jr. Employees of various departmental agencies began receiving their termination notices on April 1.

Supreme Court backs Trump move to cut \$600 million in teacher training funds

WASHINGTON. The Supreme Court on Friday granted the Trump administration's plea to cut hundreds of millions of dollars in teacher-training money as part of its anti-DEI efforts, while a lawsuit continues.

The justices split 5-4, with Chief Justice John Roberts joining the three liberal justices in dissent. The emergency appeal is among several the high court is considering in which the Justice Department argues that lower-court judges have improperly obstructed President Donald Trump's agenda. Friday's order was the first time, in three attempts, that the nation's highest court gave the administration what it wanted on an emergency basis.

The Supreme Court previously sided against the administration in another lawsuit over nearly \$2 billion in foreign aid cuts in another divided 5-4 ruling, with Justice Amy Coney Barrett in the majority in both cases.It remains to be seen whether Friday's decision marks a narrow win or a broader shift in Trump's favor. The Trump administration is facing some 150 lawsuits

in lower courts challenging his flurry of executive orders. That includes about two dozen over federal funding cuts, some totalling billions of dollars. The teaching training case deals with cuts to more than 100 programs. They had been temporarily blocked by a federal judge in Boston, who found that they were already affecting training programs aimed at addressing a nationwide teacher shortage.U.S. District Judge Myong Joun issued a temporary restraining order sought by eight Democratic-led states that argued the cuts were likely driven by efforts from Trump's administration to eliminate diversity, equity and inclusion programs. The federal appeals court in Boston turned away an appeal from the administration to allow them to resume. The Republican president has also signed an executive order calling for the dismantling of the Education Department, and his administration has already started overhauling much of its work, including cutting dozens of contracts it dismissed as "woke" and wasteful. The

two programs at issue — the Teacher conservative majority wrote that the states Quality Partnership and Supporting Effective Educator Development provide more than \$600 million in grants



for teacher preparation programs, often in subject areas such as math, science and special education, the states have argued. They said data has shown the programs had led to increased teacher retention rates and ensured that educators remain in the profession beyond five years.Despite Joun's finding that the programs were already being affected, the high court's can keep the programs running with their own money for now. By contrast, the majority said in an unsigned opinion, the federal government probably wouldn't

be able to recover the cash if it ultimately wins the lawsuit.Justice Elena Kagan wrote in dissent that there was no reason for the court's emergency intervention. Nowhere in its papers does the Government defend the legality of canceling the education grants at issue here," Kagan wrote.In a separate opinion, Justice Ketanji Brown Jackson wrote, "It is beyond puzzling that a majority of Justices conceive of the

government's application as an emergency."Roberts joined neither dissent, noting only that he would have denied the appeal. The administration halted the programs without notice in February. Joun, an appointee of Democratic President Joe Biden, found that the cancellations probably violated a federal law that requires a clear explanation.

Vijayawada Municipal Corporation takes up special drive to curb vectorborne diseases

VIJAYAWADA. The Vijayawada Municipal Corporation (VMC) has intensified its efforts to control the spread of vector-borne diseases, including dengue and malaria, across the city.

VMC officials have launched special drives involving canal cleaning, drainage desilting, fogging, and spraying ML oil using drones and Taiwan sprayers. As part of preventive measures, the health department also released one lakh Gambusia fish into stagnant water bodies to control mosquito larvae and prevent further breeding.

Biologist Dr R Ch Surya Kumar said they were working under the instructions of VMC Commissioner Dhyana Chandra H M to curb the mosquito menace. He said the civic body had collected 98,534 blood smears for malaria testing and 7,543 samples from Jakkampudi alone from January to December 2024. Across NTR district, 3,17,250 samples were collected during the same period.

Despite it being summer, residents are facing an unusual surge in mosquito population, leading to sleepless nights and rising health concerns. Many people are using coils, lotions, and vapourisers to protect themselves, but their efforts remain largely ineffective.

Last year, the district reported 61 malaria cases-29 in Jakkampudi, 36 in rural areas, and the remaining within Vijayawada city limits. 50 dengue cases were confirmed across the district, including in the city. The VMC has urged residents to cooperate by removing stagnant water and keeping their surroundings clean to prevent mosquito

Vulture count in Nilgiris Reserve up by 70 in a year

CHENNAI. Vulture population in Tamil Nadu and the Nilgiri Biosphere Reserve (NBR) continues to rise and it is an incredible comeback from the verge of extinction. On Friday, the state forest department released the results of the synchronised vulture survey, and the data show the population grew from 320 to 390.

Conducted on February 27-28 this year across 106 vantage points in Tamil Nadu, Kerala and Karnataka spanning 4,670 sq km in the NBR, the survey reveals Tamil Nadu retains its leadership position when it comes to vulture conservation in the region. Tamil Nadu recorded 157 vultures, up from 100 in 2022-23 and 152 in 2023-24. Kerala recorded 125 vultures and Karnataka 106.

The White-rumped Vulture (Gyps bengalensis) dominates the recovery, with 110 counted in Tamil Nadu and 288 sightings in the NBR. Long-billed Vultures (Gyps indicus) followed with 31 in Tamil Nadu and 50 in the NBR, while Redheaded Vultures (Sarcogyps calvus) hit 11 and 47, respectively. Five juvenile Egyptian Vultures (Neophron percnopterus), listed as endangered, were recorded in Nellai wildlife sanctuary in Tamil Nadu.

The most heartening news for the conservationists is the first-ever Redheaded Vulture nest documented in south India in Masinagudi range of Mudumalai Tiger Reserve (MTR), a rare win for the species. Overall, 75 active nests were recorded in NBR, of which MTR in Tamil Nadu reported 54 active White-rumped nests, supporting 108 adults and 30 chicks.

CEIR helps recover over 6,000 stolen phones, preventing data theft, financial loss

THIRUVANANTHAPURAM. Losing personal electronic devices, especially mobile phones, is something people dread. Apart from the financial setback, there is the fear of confidential data being compromised. But, not many are aware that the Central Equipment Identity Register (CEIR), a portal created by the department of telecommunication, is their best ally in tracking down and retrieving lost or stolen

Between September 2019 and March 2025, the portal received 45,647 requests from the state for blocking mobile phones. Of these, nearly 39,500 phones were successfully blocked. Traceability reports were generated in around 35,000 instances, which culminated in the tracking of 29,000 phones. And, as many as 6,222 phones were successfully retrieved.

Many of the devices were recovered from local second-hand mobile shops, while some were repossessed from counterfeit markets in West Bengal, Delhi, Mumbai, and Chennai, police sources said.

A senior police officer said the phones are blocked using their IMEI number. Using state-of-the-art digital tools, the devices are tracked, and once the geographical location is identified, they are physically retrieved. The collective worth of the recovered phones could be more than '6 crore, the official told.

However, it's not always monetary loss that prompts users to register police complaints and report on the CEIR platform. Most fear the prospect of data stored in their phones being accessed by others, which could in turn ruin their personal and professional

Refrain from hate speech against CM Stalin: Madras HC to CVe Shanmugam

CHENNAI. The Madras High Court has asked senior AIADMK leader and Rajya Sabha Member CVe Shanmugam to refrain from making 'hate speech' against Chief Minister MK Stalin while addressing public forum even though he is entitled to level criticism on public issues owing to freedom of speech and expression as enshrined in the Constitution.

Noting that he had held posts of an MLA and a minister for 10 years and is currently an MP, Justice GK Ilanthiraiyan, in a recent order, said Shanmugam should show responsibility while criticising the chief minister.

He explained, "The petitioner (Shanmugam) has the right of freedom of speech and expression and hold public meetings under Article 19 (1) (a) of the Constitution with some restrictions. He should not have delivered hate speech against the CM and the state government."

The petitioner shall have to avoid hate speech while addressing public meetings," the judge said. However, Justice Ilanthiraiyan held that free speech of the citizens of the country cannot be stifled by implicating them in criminal cases unless such speech has the tendency to affect the public order.

Chennai: The Madras HC has refused to quash an FIR registered against the Periyar University vice chancellor R Jaganathan on the alleged misappropriation of funds and caste abuse against a leader of the university employees union.

The petition filed by Jagannathan praying for quashing the FIR, registered by the Karuppur police in Salem district on December 26, 2023 for the offences that included criminal conspiracy, cheating and caste abuse under various sections of IPC was dismissed by Justice GK Ilanthiraiyan

A similar petition filed by the registrar (incharge) K Thangavel was also dismissed by the court. The main charge was that the V-C had floated a private entity-Periyar University Technology Entrepreneurship Research (PUTER) Foundation, without obtaining appropriate permission from the government, with an intention to misappropriate the university funds.

Thiruvananthapuram 's Vellanad KSRTC depot officials file complaint over stray dog menace

THIRUVANANTHAPURAM. In light of the increasing stray dog menace, officials at the Vellanad KSRTC depot have filed a complaint with the Vellanad panchayat seeking urgent intervention. The complaint was lodged on Friday after a 16-year-old girl was bitten by a stray dog near the depot.

According to depot staff, the girl had just gotten off a bus on Thursday morning when she was bitten by the dog on her leg. Later, another girl who had arrived with her family was also attacked by the dog, but she escaped without any injuries.

"This is not the first time such an incident has happened. Our staff and passengers are at risk daily. We have informed the panchayat multiple times, but no concrete action has been taken yet," said a depot official.

The concern has been mounting for months, with several attacks reported in and around the depot. Two weeks ago, a KSRTC driver Baiju was bitten by a stray dog while on duty. A month ago, a homemaker from Companymukku was attacked in front of the depot. Stray dog attacks have also been reported from Vellanad Junction and nearby areas.

Responding to the complaints, Vellanad panchayat vicepresident Vellanad Sreekandan admitted that the situation has become alarming.

"Human lives are more important. We have vaccinated the dogs and marked them with numbers before releasing them. However, to completely eliminate the threat, culling the dogs is the only solution, but there is no law for that. We are helpless," said Sreekandan.

The vice-president also pointed out that the government had suggested setting up shelters for stray dogs, but the initiative failed due to high maintenance costs. Meanwhile, the panchayat has issued strict instructions to travellers and employees to stop feeding stray dogs to curb their presence near public spaces.

Kerala police investigate trafficking of job seekers to Thailand

Police officials revealed that Euro Sky World began recruiting overseas in Edappally in 2023-24, advertising on social media with claims of providing visas for New Zealand, Australia, and Southeast Asia.

KOCHI. The police have launched an investigation into a suspected human trafficking incident in which several individuals were deceived with promises of high-paying jobs and taken to Bangkok. Following a magistrate court's directive, the Elamakkara police have registered three cases against a recruitment agency that operated in Edappally. According to police officials, the agency, Euro Sky World, began its overseas recruitment activities in Edappally during 2023-24. The firm advertised on social media, claiming to provide visas for New Zealand, Australia, and various South-east Asian countries. Several job seekers approached the agency for overseas employment. "Although the applicants initially sought jobs in Europe, Australia, and New Zealand, the agency lured them into applying for warehouse jobs in

Hong Kong, promising salaries of over Rs 2 lakh per month. The victims collectively paid around Rs 7.75 lakh for these job placements," a police officer said. In May 2024, the victims were taken to Bangkok under the pretence that their travel to Hong Kong would be finalised upon arrival. However, after reaching Bangkok, they were informed that their Hong Kong visas had not been approved and were advised to seek employment in Bangkok instead. "The victims alleged that in Bangkok, they were coerced into working for an online sex racket.

When they refused, they were threatened, tortured and detained. They were released only after paying a ransom of \$1,500," the officer added.Following complaints filed by three victims in the magistrate court, the police have registered cases against six individuals,

including the managing director and employees of Euro Sky World. Two more victims, who were similarly deceived and taken to Bangkok, have also approached the court. The recruitment agency is not operational now.

We questioned the managing director of the recruitment firm. He claimed that his company was associated with an agent in Tamil Nadu and that the Tamil Nadu native was responsible for cheating the victims. Our initial probe indicates that this agent has been involved in multiple fraud cases," an official said.

The Tamil Nadu-based agent was previously arrested in another overseas job fraud case in Kochi but is currently out on bail. "We are tracking his movements and working to help the victims reclaim their lost money," the officer

Munambam residents

KOCHI. A day after the passage of the Waqf (Amendment) Bill in Parliament, the BJP on Friday said it would stand with the people of Munambam until their revenue rights are re-established. BJP leaders led by state president Rajeev Chandrasekhar visited Munambam and joined residents in their celebrations over the passing of the bill by the Lok Sabha and Rajya Sabha.

Chandrasekhar said Prime Minister Narendra Modi has been following a policy of 'Sabka Saath Sabka Vikas' since 2014 and the Union government has not shown any discrimination towards any community on the basis of caste or religion.

The Waqf (Amendment) Bill passed by Parliament is a milestone in Indian history. The non-violent protest of the residents of Munambam village reached New Delhi and facilitated the passage of a historic bill. I am sure the bill will help restore the land rights of the residents of Munambam," he said. Interacting with media after visiting the protesting residents, Chandrasekhar said the passage of the bill marks a decisive moment in Kerala politics.

Waqf bill not against any religion: BJP state chief

"The fight against Waqf claim over Munambam land has brought the village in national focus," Chandrasekhar said. Alleging that the MPs who opposed the bill had supported appeasement politics, Chandrasekhar said the bill was not against any religion. KOCHI. The Railways has expedited track-doubling work on the key Ernakulam-Thuravoor section of the coastal line and revised the deadline for completion of work to February 2027. Work on the over 23-km stretch is being

executed in two sections -- the 7.71-km Ernakulam-Kumbalam section and

the 15.59-km Thuravoor-Kumbalam section. "Eighty per cent of the land acquisition process along both stretches has been completed. We've awarded all the major contracts, except for the laying of tracks. While it will take another two years to complete the works, we've speeded up activities," said a senior official with the railway construction wing in Ernakulam.

While doubling work has been completed in the main Ernakulam-Kottayam-Kayamkulam section, work on the Kayamkulam-Alappuzha-Ernakulam segment has encountered major delays due to non-availability of funds. Of the total 102-km section, track doubling has been completed only in the 33-km Kayamkulam-Ambalapuzha stretch. Administrative sanction is yet to be received with respect to the 46-km-long Ambalapuzha-Thuravoor section.

Ambalapuzha section was initially set for December 2026. "Now we're focusing on the Ernakulam-Thuravoor

section. Work on the section, including that of three bridges, has been hastened," the official said

Construction of the 854.5-m-long Aroor-Kumbalam railway bridge, the second longest in the state, is now being carried out from both the Alappuzha and Ernakulam sides. "Kolkata-based Royal Infra is executing work of Aroor-Kumbalam bridge (EAK 31). We've also started work on the Konthuruthy-Nettoor (EAK10; 152.5

m) and Nettoor-Kumbalam (EAK 17; 158.6 m) bridges," the official said. Delay affecting ops

The deadline for the 69-km Ernakulam- Meanwhile, daily commuters complain that delay in works and sanctioning the doubling of the Thuravoor-Ambalapuzha line have resulted in travel woes.

> 'We've submitted multiple memorandums seeking completion of doubling work along the entire section. Currently, there are inadequate services along the coastal route. Many trains are halted multiple times to facilitate crossings. This delays services," said Paul K J Manvettom, president of the All Kerala Railway Users'

Association. A social-impact study carried out as part of the track-doubling project noted that the number of railway passengers travelling from neighbouring districts to Kochi and back is on the rise.

The proposed unified platform aims to simplify the tax payment process and thereby improve efficiency in tax collection as well.

CHENNAL City residents may soon be able to pay their property and water taxes through a single platform as the state is conducting a feasibility study for their integration.

Currently, taxpayers have to navigate separate portals for property tax under the GCC and water tax through the Chennai Metropolitan Water Supply and Sewerage Board (CMWSSB). The proposed unified platform aims to simplify the tax payment process and thereby improve efficiency in tax collection as well.

GCC deputy mayor M Magesh Kumaar said, "If implemented, the new single-window system will direct taxpayers' payments into an escrow account under the GCC after which the funds will get distributed to the respective departments, ensuring seamless revenue management." According to sources, both departments are conducting test calculations by determining the number of taxpayers in both departments and identifying mismatches. For instance, the GCC does not collect property taxes for houses on poramboke land without patta. However, these households may still receive basic amenities, including water connections and therefore pay taxes to CMWSSB.

Similarly, as per Section 87 of the Tamil Nadu Urban Local Bodies Act, 1998, GCC has exempted property taxes for places of public worship and educational institutions. Yet, these places still pay water taxes. A CMWSSB official said



discrepancies also arise as some domestic water connections are used for commercial purposes illegally. To overcome such challenges during integration, the GCC and CMWSSB are relying on TNEB data,

which is more accurate. However, as the process is complex and time-consuming due to technical challenges, the integration is likely to take time. GCC officials added since both the civic body and CMWSSB has limited human resources for tax collection, an integrated platform will be helpful for both.

The CMWSSB calculates water and sewerage tax as 7% of the annual rental value fixed by the GCC for property tax, with the amount collected in two batches per year. CMWSSB has at least 14 lakh consumers, receiving Rs 1,050 crore taxes in 2024-25, following the recent tax revision. In previous years, the sewerage board collected around Rs 800 crore per

Till 2023 and the start of violence in Manipur, peace had prevailed in the Northeast after decades of unrest and violence. There was a ceasefire in Nagaland and elected governments were in place in Assam, Arunachal Pradesh, Mizoram, Meghalaya, Tripura and Manipur.

The Government of India has done an admirable job with the help of the army, security forces and police in bringing peace to the area and the restoration of the democratic process. The interaction and integration between the Northeast and the rest of India has improved and people of the area are going to other parts for studies and employment. Tourism has also begun to grow green shoots. However, an unfortunate Manipur High Court ruling recommended that the state government should move the GoI to include the dominant Meiteis as a Scheduled Tribe and, thereby, allowed for affirmative action (also implying the opening of purchase of land in the hills by outsiders). Knowing the potential of harm likely to be caused by the ruling, the state government should have taken immediate steps to challenge the ruling through judicial means (it could have easily done so).

The hill tribes, fearing loss of land and identity due to the anticipated influx of outsiders, reacted on a massive and sometimes violent scale. Unfortunately, the matter was not handled properly at the state level and the situation was allowed to descend into unrest and violence. The people of the valley and the hills clashed in large numbers and police armouries were looted and many arms were taken away (most of which have not been recovered). The army and the paramilitary forces were not used aptly and the police were not up to it. Now, some kind of peace has been restored, but the social fabric has been torn asunder and silence is the only dialogue. The hill people have not been able to go back to their old way of life. We are sitting on a powder keg, which one volatile statement can set off. The process of dialogue between the communities and the government was not initiated in the early stages and the state government opted to use strong-arm methods, which failed.

The situation in the Northeast requires political acumen and statesmanship of the highest order. We should not wait for the situation to escalate and then try to douse the fires. I would like totake just a passing glance at the other states.

Mizoram has been quiet for long, but now some ominous signs are visible. As reported in the press, the Government of India had asked Mizoram to not take in Rohingya refugees from Myanmar and set up camps for them.

Trump's trade war may sound death knell for WTO

India must start preparing for seizing the opportunity arising out of the higher tariffs being imposed on our competitors.

So the world is not flat any longer! (with homage to Thomas Friedman). In fact, POTUS' 'Liberation Day' announcements have created a large number of valleys and crevices across the global economy. Donald Trump's announcements may also sound the death knell for the World Trade Organisation (WTO) because one of its cardinal principles, the MFN (most favoured nation), has been unceremoniously chucked out of the window of the Oval Office. The MFN, from its inception, has unambiguously mandated that the tariff rate applied by a country on its imports from another country will be applicable to all other exporting countries. With a dazzling bouquet of tariff rates applicable specifically to a particular trade partner of the US, the MFN principle is truly dead and buried. Will this imply the culmination of the long-drawn demise of the WTO, from which the US effectively withdrew in Trump 1.0? I think it will. Centre William Rappard, which houses the headquarters of the WTO in Geneva, should be soon available for new tenants!I am also fairly curious on the reaction to these global economy-shattering announcements from the Bretton Woods Twins, the IMF and the World Bank, as also from the die-hard advocates of a tariff-free world which Prof Jagdish Bhagwati has spawned over his lifetime. What happens to the remnants of the Washington Consensus and its proponents? The entire macroeconomic copybook has been turned on its head with the country that accounts for more than one quarter (26.3 per cent) of the global economy now proceeding to virtually close its domestic market to imports. Poor Mexico, which sent 80 per cent of its exports northwards, and Canada, whose Ontario border bristles with cross-border trade of autos, auto components and consumer products, will now be looking at alternatives that can absorb this large volume of exports. Will they find these when all other countries may be tempted safeguard their own markets! The EU, with a 20 per cent tariff imposed on their exports, may retaliate with a tit-for tat announcement, but will that not sound the end of the north Atlantic alliance that we had taken for granted as the guarantor of the rules-based, multi-lateral global trading order? Sorry, Fukuyama san, history is yet being made. No respite for the succeeding generations.

am at my wits' end to understand as to how an economy with a per capita income of \$87,000 in 2024, having achieved a significant increase of more than \$5,000 over the level in 2023, can hope to raise these incomes further by shutting itself out of the global trade flows which has benefitted it so enormously. Is it real for POTUS to expect a grand revival of the manufacturing sector and the reshining of the rust best across the mid-west, given the extraordinarily high real wages in relative terms with other trading partners? These are only likely to rise as




result of the large-scale forced emigration of working age population. Perhaps the calculus is based on a large-scale adoption of robotisation in the US manufacturing sector and a massive increase in private sector capex to undertake this AI-driven robotisation. More likely, the expectation is that border-hopping foreign direct investment, as announced by TSMC (Taiwan Semiconductor Manufacturing Company), will get the rust best up and running in no time. One is reminded of the saying that if wishes were horses...What of the impact on India? The 26 per cent tariff announced is argued to be half of the 52 per cent effective protection applied by India on US exports to India, I am not sure at all on how this figure of effective protection has been arrived at. But be that is it may, it is clear that India's exports to the US will attract substantially lower tariffs as compared to China (34 per cent) Taiwan (36 per cent), Vietnam 46 per cent, and I am sure none of us would have guessed that Cambodia (49 per cent) will face the worst wrath meted out on Liberation Day.So, does this new fragmented world trading arrangement present an opportunity for India? I think so specially if we consider that the much higher cost exports from the EU and Canada will also now attract similar level of tariffs. So rather than go on about the negative impact on our exports to the US, we start preparing for seizing the opportunity presented to us by higher tariffs being imposed on our competitors. In any case how much could the negative impact be if our total exports to the US are a

paltry \$77.5 billion in 2023 - compared to China's \$526 billion and Vietnam's at \$120 billion? One straightforward opportunity that is plainly visible comes from the hugely concessional 10 per cent tariff on Brazilian export. Our firms should be encouraged and indeed helped in setting up joint ventures in Brazil and shift our high-end garment export units to that country. The diamond business with relatively low capital costs could also be so re-routed. And with Bangladesh losing out on its import duty free status, we should be preparing to welcome our garment exporters back to India and assure them that they will surely not face the business conditions that drove them away from India to Bangladesh in the past two decades. Finally, a suggestion that, going by past rhetoric, is likely to evoke the fury of Trump 2.0. Members of BRICS, now expanded to BRICSUSAI, should use its next summit to try and agree to a common low-tariff regime among themselves. Yes, there exists the danger of Chinese flooding of all these markets, but it will also open up the growing Chinese market to exports from its BRICSUSAI trading partners. And China could be persuaded to maintain a trade balance with its trading partners with some limits on trade surplus as was originally suggested by Keynes and which was cornerstone of IMF's exchange rate determination stance. With nearly 40 per cent of world trade among themselves, including everything from energy to gold and gems and jewellery, this could pose a very healthy flat world challenge to the global trade.

Without a multipronged strategy that includes medical intervention, community support and economic opportunities for those at risk, the state will struggle to turn the tide. The Mann government's youth engagement and the Governor's padyatra aim to mobilise public participation, but deeper interventions are needed. Schools and colleges must play a proactive role and, as the Chief Minister has suggested, teachers should be trained to identify early signs of addiction. For Punjab

to truly rid itself of this scourge, political leaders must prioritise long-term structural reforms over momentary

Nation's moral fabric is in peril

Citizens are the sufferers as public life is witnessing a steady decline in values

Justice Yashwant Varma, who was recently transferred to the Allahabad High Court amid a cash stash row, has claimed that someone placed the money in the outhouse of his official residence in Delhi in order to frame him. It must have been a very rich person who had planned to frame the judge. Only Justice Varma would be in a position to name him! A fire was reported at the judge's residence during his absence last month. The police and, of course, the fire brigade were at the scene promptly. Wads of notes were recovered from the outhouse. Some of them were charred, making it difficult for the first responders to count the money - Rs 15 crore is what the public has learnt. It is the figure bandied around on the grapevine, but there is no official take on the amount nor how the money got into the outhouse. The Chief Justice of the Delhi High Court was informed before others. He informed the Chief Justice of India (CJI), who, in turn, ordered an in-house inquiry by a committee of three judges of different high courts. The CJI has decided to be open about the facts as and when they are reported to him. It is obvious that the CJI wants to hide nothing since he knows that if rumours based on conjectures are allowed to proliferate, the damage being done to the integrity and good name of the institution would harm the very essence of the judicial process system in the country. In fact, much harm has already been done.

The armed forces and the judiciary are the two institutions that the people still respect. The other two pillars of any democratic polity, the legislature and the executive, have gone for a toss. The media, too, has largely capitulated. It no longer performs the task of acting as the eyes and ears of the people which it was wont to do earlier. The judiciary is our sole protector at present. If the judiciary,

too, goes the way of all flesh, we as a nation are doomed. There is an advocate in Mumbai named Raju Z Moray. He writes books on his experiences in courts of the city, including the high court. In his latest book, Tales of Law and Laughter, he makes the reader laugh at the foibles of the stakeholders he meets in the HC corridors. But he



also subtly hints at the decline in the quality of judges and, worse, the standards of integrity that they were known for earlier. It is very, very sad that the very concept of honesty is under assault in all departments of the government and public life. When our Prime Minister proclaimed that he would not touch tainted money and would not permit others from doing so, many took him at his word. I do not doubt that he has kept to the first part of his promise. The second part should never have been included in the first place. Corruption at the ground level has bested all records. The PM is helpless to combat the menace. He knows it and so do the people. Entrants to the IAS, the IPS and the judiciary, the three Services which matter the most to the people, primarily used to be men and women of merit and integrity. The subordinate ranks

respected them and followed their example to a major degree. Three decades later, electoral battles have become so intense that demands to expand the scope of reservation and relax the age of the candidates for the All-India Services and the Central Class I have led to a situation where someone like Puja Khedkar could walk into the premier Service and that, too, in her home state, even though she was ranked 800-plus in the order of merit! In 1952, when I competed, only 41 were taken into the IAS/IFS and 37 in the IPS. If the need to win elections eclipses the need to ensure justice and good governance, there will never be any light at the end of the tunnel. People will have to be content with mediocrity and the insidious corruption that they experience in daily life. It becomes even murkier if justice is dispensed on payment

in courts of law. One of my first postings as an assistant superintendent of police was in Nasik. The district judge, for some reason, took a liking to me. When my superior was on leave and I was temporarily in charge of the district police, a policeman on duty in the tribal area of Surgana raped a woman at a fair. The commotion that followed required the presence of a senior officer to calm tempers. The sessions judge and I were in the Officers' Club when the news reached us. He advised me to leave every other matter on hand and proceed immediately to the scene of the disturbance, which I did.All sessions judges in the districts where I served were men of great integrity. Our social interaction rested on shared values and a firm belief in justice and the rule of law.

Things have changed drastically in recent decades. All Services that cater to the public have experienced a steady deterioration in standards. The real sufferers are the citizens of our great nation. The irony is that they do not know what has hit them and how the tsunami originated.We do not know as yet if Justice Varma accepted money. A fair inquiry should reveal the truth. What is certain, however, is that there has been a steady decline in morals and values in public life. India may rise to the rank of the third-largest economy in the world, but if that is achieved under the shadow of corruption, the self-esteem of our citizens will remain low. The writ of the Supreme Court on bulldozer justice, for instance, is being openly flouted by the executive in BJP-ruled states. A form of terrorism has taken shape. The State has become a terrorist. In classical terrorism, citizens do not know who is going to be the next victim. The uncertainty

keeps him or her on edge constantly. On the outskirts of Mumbai, a 'patriot' passing by a Muslim house when an India-Pakistan cricket match was being played in Dubai thought he heard a boy raise anti-India slogans. That was enough for the bulldozers to perform their task of destruction as punishment for a crime the boy may or may not have been guilty of. The Supreme Court's diktat was peremptorily ignored!

'Shistachar' squads conduct women's safety drive at school, public places

NEW DELHI. The Delhi Police's anti-eve-teasing team, coined as the 'Shistachar Squad', conducted awareness campaigns at a school in Rani Bagh and in public places around outer Delhi's Paschim Vihar area in a bid to spread awareness over issues like eveteasing, molestation, and harassment, officials said on Friday. The initiative focused on educating the public about the perpetuating forms of harassment that women face in public spaces. In an effort to empower women

and make them aware of their rights, the campaign also emphasised on the legal provisions, helpline numbers, and support mechanisms available for those facing such harassment, they said.

With an aim to foster a safer public environment for women, the police teams distributed pamphlets and held interactive Earlier this month, Delhi Police Commissioner



sessions with commuters, stressing the importance of respecting women's safety, dignity, and boundaries.

Members of the Shistachar Squad also engaged with local authorities to discuss preventive measures and encourage victims to report such criminal tendencies without fear or stigma, the police said.

Sanjay Arora had issued a circular comstituting dedicated district-wise anti-eve-teasing teams (Shistachar Squads) across the national capital to check incidents of harassment and ensure the women's safety in public spaces. Each squad comprises an inspector, a sub-inspector, four female and five male personnel, and one technician from special staff from the anti-auto theft squad for technical aid. They will be provided with one fourwheeler and adequate two-wheelers to ensure effective patrolling and quick response.

"DCPs in each district shall identify and compile a list of hotspots and vulnerable areas, posing risks to women's safety, which will be the primary focus of these squads. A list of such hotspots identified by the district DCPs will be shared with DCP of the Special Police Unit for Women and Children (SPUWAC)," the circular had read

BookMyShow removes all content of comic Kunal Kamra amid joke row, delists him



NEW DELHI. In a huge blow to Kunal Kamra, online ticketing platform BookMyShow on Saturday removed all content related to the stand-up comedian and removed him from the list of artists listed on its website. This comes a day after Shiv Sena (Shinde faction) youth leader Rahool N Kanal wrote to BookMyShow, requesting the company not to provide a platform for Kamra, following his controversial remarks on Maharashtra Deputy Chief Minister Eknath Shindra.

Requesting the website not to facilitate the sales of tickets for Kamra's upcoming show, Kanal stressed that "continuing to facilitate ticket sales for his events could be perceived as an endorsement to his divisive rhetoric which may have serious repercussions for public sentiment and order in the city."Soon after the ticketing website's decision to delete Kamra from the history list of artists, Kanal welcomed the move, thanking BookMyShow for removing any content linked to the artist.

Fight against the Waqf bill goes to Supreme Court

NEW DELHI. Hours after the Waqf (Amendment) Bill 2025 received Parliament's approval, the Congress and the All India Majlise-Ittehadul Muslimeen (AIMIM) moved the Supreme Court on Friday, challenging its validity, arguing that it violates constitutional provisions. The development came a day after Tamil Nadu Chief Minister M K Stalin announced in the state assembly that the Dravida Munnetra Kazhagam (DMK) will move the SC to challenge the bill.

In his plea, Congress MP Mohammad Jawed held that the bill imposes arbitrary restrictions on waqf properties and their management, undermining the religious autonomy of the Muslim community. The petition claimed that the proposed law discriminates against Muslims by imposing restrictions that are not present in the governance of other religious endowments.

Jawed, a Lok Sabha MP from Bihar's Kishanganj, was also a member of the Joint Parliamentary Committee (JPC) that scrutinised the bill.

While the Lok Sabha cleared the bill 288:232; in the Rajya Sabha it sailed through with a 128:95 vote. Both Houses witnessed 12-hour marathon debates. The bill will now go to the President for assent before becoming law. Earlier in the day, AICC general secretary Jairam Ramesh said his party will soon challenge the constitutionality of the Waqf (Amendment) Bill, 2024, in the Supreme Court.

Challenging the bill in the top court, AIMIM president Asaduddin Owaisi in his plea argued that it removes various protections that were previously accorded to wagfs as well as to Hindu, Jain, and Sikh religious and charitable endowments."This diminishing of the protection given to Waqfs while retaining them for religious and charitable endowments of other religions constitutes hostile discrimination against Muslims and is violative of Articles 14 and 15 of the Constitution, which prohibit discrimination on the grounds of religion.'

IGIA to begin trials for fullbody scanners from May

NEW DELHI. The Indira Gandhi International Airport (IGIA) will soon have advanced full-body scanners to enhance security while maintaining accuracy. Delhi International Airport Limited (DIAL), operator of the IGIA announced on Friday that the trials for the scanners will begin from next month following the latest guidelines from the Bureau of Civil Aviation Security (BCAS). The airport operator said that four state-of-the-art scanners have been procured for the trials. Two of them will be installed at Terminal 1 (T1), while the other two will be placed at Terminal 3 (T3).

It further said that the IT interface of these machines is currently being finalised. After the completion of the three- to four-month long trial, a BCAS-led committee will go through the findings and establish a Standard Operating Procedure (SoP) for full-scale implementation. The scanners will be using millimeter-wave technology operating between 70 to 80 GHz. DIAL said that unlike conventional X-ray scanners, they do not emit radiation, making them safe for all travellers, including pregnant women and individuals with medical implants."These advanced scanners detect both metallic and non-metallic threats, including explosives, significantly improving upon traditional metal detectors. The technology, already in use at major international airports in the US, Canada, and Australia, enables rapid screening, with each scan taking just three seconds and a maximum throughput of 1,200 scans per hour," the DIAL said. The airport operator further said that the scanners ensure no personal images are stored, while generating a standardized 2D image on a preset human avatar. These can scan in individuals between 3.3 feet to 6.7

DIAL CEO Videh Kumar Jaipuriar said, "Delhi Airport remains committed to deploying the latest technology to enhance security while ensuring a seamless passenger experience. The introduction of these body scanners is a game-changer in security screening, allowing for faster checks."

Delhi hospitals to get 20 per cent hike in compensation and incentives

NEW DELHI. A special tariff is planned for Delhi hospitals under the Ayushman Bharat Yojna, which will begin in the national capital on Saturday. The tariff includes a 20% hike in compensation of treatment rates for hospitals enrolled in the scheme. Also, hospitals with the best performance will receive an incentive of up to 30%. A senior official says, "The treatment tariffs in Delhi are higher compared to other cities. The



stakeholders have communicated that enforcing the standard tariff will not be sustainable for hospitals here."The official says the incentive for top-performing hospitals will be based on multiple parameters, including the turnaround time for surgeries and medical interventions, clearance of bills, and patient feedback.

On Saturday, Delhi will become the 35th state to implement the Centre's flagship Ayushman Bharat scheme and an MoU will be signed between the National Health Authority and the Delhi government.

Ration card holders under the Antyodaya Anna Yojana and citizens above 70 years old will be among the first beneficiaries of the scheme. Verification of senior citizens' details will be done through the voter list, while ration card holders' info will be cross-checked via National Food Security Act portal.



India's IT Services **Companies To Report** Subdued Growth During 4QFY25: Report

New Delhi. India's information technology sector is expected to report subdued growth for the fourth quarter of FY25 (January-March period), according to a report by Systematix Institutional Research. The report attributed this slowdown to seasonal weakness and reduced discretionary spending on digital transformation projects by global clients.

It said, "We expect IT services companies within our coverage to report subdued growth during 4QFY25 on seasonal weakness and lower discretionary digital transformation spends." It also mentioned that Indian IT companies, which earn a major share of their revenues from the US market, continue to face a revenues from the US market, continue to face a challenging business environment as the US deals with macroeconomic uncertainties. Just as the sector was hoping for a recovery in discretionary tech spending, the report stated that the situation has become more complex due to fresh tariff announcements by the Trump-led administration, recessionary concerns, and a cut in IT budgets by recessionary concerns, and a cut in IT budgets by Elon Musk-led DOGE.These developments are causing delays in large-scale tech transformation projects. Instead, clients are now focusing on costsaving measures, including vendor consolidation and budget reallocation, which is affecting new

project flows and revenue visibility for IT firms.

The report expects large-cap Indian IT companies to post a quarter-on-quarter revenue decline of 0 to 2 per cent in dollar terms. Among the major players, Tata Consultancy Services (TCS) is likely to see revenue pressure due to a ramp-down in its deal with Bharat Sanchar Nigam Ltd (BSNL).

Infosys and HCL Technologies may experience a dip in revenues due to seasonal factors, while Wipro, Tech Mahindra, and Sonata Software are expected to report weaker results due to company-specific challenges. Despite the pressure on revenue, EBIT (earnings before interest and tax) margins are expected to remain largely stable across companies.

However, margins for Infosys and HCL Technologies could be slightly affected due to seasonality and wage increases. Overall, the outlook for the IT sector remains cautious, as companies brace for a quarter marked by soft demand, client budget tightening, and global economic uncertainties.

Income Tax Return 2025: What's New In ITR-2 Filing **Process Find Out Here**

New Delhi. The new financial year has started and so has the tax filing season. Taxpayers can now file their Income Tax Return (ITR) for the Assessment Year 2025-26 (Financial Year 2024-25). Just like every year, the ITR filing process is available in both online and offline modes, making it convenient for everyone to get started. The Income Tax Department has introduced a new Excel-based utility for ITR-2 which was launched on March 25, 2025. This form is meant for individuals and Hindu Undivided Families (HUFs) who don't have income from business or profession. A key update is the addition of the option to file a revised return under Section 139 (8A).

So, if you spot an error or need to update any details in your return, you can now do it without hassle. This new feature is especially helpful for salaried individuals, pensioners, and other non-business

Who Should File ITR-2?

ITR-2 is for individuals whose annual income exceeds Rs 50 lakh or those who earn from sources like rent, capital gains, or other income. You'll also need to file ITR-2 if you're a director in a company or hold shares in an unlisted company. Plus, if you own any foreign assets, this is the form you need to use. Choosing the right ITR form depends on where your income comes from. If your total annual income is below Rs 50 lakh and you earn only from salary, pension, interest, dividends, or rent from just one property, then you should file ITR-1. So, whether you earn from salary, rent, capital gains, or other sources, picking the right ITR form is key to hassle-free filing and staying compliant with tax

Forex kitty continues to gain for 4th week, RBI adds \$6.6 bn

NEW DELHI. The reserves rose \$6.56 billion to \$665.4 billion as of March 28, the Reserve Bank said on Friday. This marks the highest level in nearly five months.

During the reporting weekend, the rupee appreciated by 0.6% against the dollar, supported by the renewed foreign investment in the Indian equities. This means the central bank did not sell much dollars to defend the currency. March also saw the rupee making its best monthly gain in nearly seven months, since November 2018, gaining close to 2.3%. However, the currency closed the last fiscal with a loss of 2.46%. The foreign exchange reserves continue to gain, adding \$6.596 billion to a five-month high of \$665.4 billion in the week to March 28, according to the latest data from the central bank. In the previous three weeks, the RBI cumulatively added \$20.1 billion. According to the government, this can cover 11 months of imports and makes the country's reserves the fourth largest in the world after China, which has over \$3.3 trillion in its reserves, followed by Japan with \$1.23 trillion, and the tiny Switzerland at the third place with \$927 billion, which is 1.5 times of our forex reserve.

The rupee opened strong at 84.95 on Friday as the dollar index fell massively after the bloodbath on the Wall Street following the tariff war unleashed on Thursday. The rupee edged up in volatile trades, holding near three month high against the dollar and closed at 85.22, up 33 paise from the previous close. The dollar index currently quotes at 101.76, nearly at five month low. The RBI said the reserves by \$6.6 billion in the latest reporting week, following a cumulative increase of \$20.1 billion over the previous three weeks. Movements in foreign currency assets within the reserves are influenced by the central bank's market interventions and fluctuations in the value of foreign assets.

JP Morgan warns of 60% chance of global recession after Trump's tariffs

JP Morgan ratcheted up its odds for a US and global recession to 60%, as brokerages scrambled to revise their forecast models with tariff distress threatening to sap business confidence and slow down global growth. The Trump administration imposed tariffs on dozens of countries earlier this week. China

retaliated on Friday with its own levies on US goods, adding to worries about an escalating trade war and wreaking havoc on global financial markets.JP Morgan said it now sees a 60% chance of the global economy entering recession by year end, up from 40% previously."Disruptive US policies have been recognised as the biggest risk to the global outlook all year," the brokerage said in a note on Thursday, adding that the country's trade policy has turned less business friendly than anticipated."The effect ... is likely to be magnified through (tariff) retailation, a clide in LIS business continent and slide in US business sentiment and supply-chain disruptions."S&P Global also raised its "subjective" probability of a US recession to between 30% and 35%, from 25% in March.Last week, before the April 2 tariff announcement, Goldman Sachs also raised the probability of a US recession to 35% from 20%, noting economic fundamentals were not as strong as in the previous years.HSBC said on Thursday that the recession narrative will gain traction, but added some of this is already "priced in"."Our equity market implied recession

probability indicator suggests equities are already pricing in (about) 40% chance of a recession by the end of the year," HSBC analysts added. Other research firms including Barclays, BofA Global Research, Deutsche Bank, RBC Capital



Markets and UBS Global Wealth Management also warned the US economy faces a higher risk of slipping into a recession this year if Trump's new levies remain in place.Barclays and UBS warned the US economy could enter into contraction territory, while other analysts forecast economic growth broadly between 0.1% and 1%.US equity markets

rallied in November after Trump won a second term in the White House on expectations of business-friendly policies.Following Trump's tariffs announcement in January, it has been a forgettable three months for Wall Street's

main indexes, with the benchmark S&P 500 down over 8% so far this year.Brokerages including Barclays, Goldman, RBC and Capital Economics slashed their year-end targets on US stocks, with UBS downgrading its recommendation to "neutral" from "attractive". This would help boost investments in domestic industries and make Indian products more competitive in the global market.It stated, "The Indian government should



Incentive (PLI) schemes in these sectors to cover a wider range of products and extend their duration by three years, thereby bolstering domestic industries' investment and global competitiveness."One of the key areas where India stands to gain is

in exports to the U.S. With tariffs on Chinese goods increasing, India can capture a larger market share in sectors such as textiles, apparel, and footwear. Additionally, India has manufacturing strength in iron and steel products, which can also benefit from these trade changes. Sectors like IT and metals have underperformed relative to the broader market, reflecting growing concerns over the outlook for the US economy and potential retaliatory trade actions by other countries. According to Vinod Nair, Head of Research, Geojit Investments Limited, investors are expected to closely monitor any countermeasures implemented by global trade partners, which could further exacerbate geopolitical and economic uncertainty. This cautious sentiment is reflected in the sustained rally in gold and bond prices, underscoring a pronounced shift toward safe-haven assets.Meanwhile, benchmark indices extended their losing streak to a second session on Friday, falling over a per cent each, as a risk-off sentiment took over global markets amid fears of a trade war on the back of US President Donald Trump's reciprocal tariffs, according to a Bajaj Broking Research note. Nifty was down 345.65 points or 1.49 per cent at 22,904.45. Investors fear that aggressive trade policies by US would lead to retaliatory measures from other countries, escalating into a full-scale trade war. Such an outcome could disrupt global supply chains and slow economic growth. The broader markets witnessed sharp decline, with the Nifty Midcap 100 and Nifty Small cap 100 declining by 2.91 per cent and 3.56 per cent, respectively. All the sectoral indices traded with sharp cuts, with the IT, Auto, Pharma, PSU Bank, Realty, Oil and Gas and metals gauges losing 6 per cent to 3 per cent. NEW DELHI. Wall Street faced its sharpest downturn since the height of the Covid-19 crisis on Friday. The S&P 500 plunged 6% after China retaliated against President Donald Trump's tariff hike, stoking fears of a trade war spiralling into a global recession. It was the S&P 500's worst week since March 2020, when the pandemic severely impacted the economy. The Dow Jones dropped 2,231 points (5.5%), while the Nasdaq tumbled 5.8%, falling over 20% from its December high.On Friday, US stock exchanges saw a record-breaking 26.79 billion shares traded, surpassing the previous high of 24.48 billion on January 27, 2021. The Nasdaq dropped 962.82 points to 15,587.79, confirming the techheavy index was in a bear market after falling more than 20% from its December NO WINNERS AS STOCK PLUNGE

16 record closing high of 20,173.89.

The Dow Jones Industrial Average declined 2,231.07 points to 38,314.86, marking a correction from its December 4 record closing high of 45,014.04. Meanwhile, the S&P 500 slid 322.44 points to 5,074.08, its lowest close in 11 months, according to Reuters.

GLOBAL MARKETS SLIDE AMID TRADE WAR FEARS

Global stock markets also continued their downward spiral, driven by growing investor fears that Trump's reciprocal tariff strategy could fuel inflation and potentially tip the global economy into a recession. The uncertainty has amplified concerns across financial markets worldwide. However, the US government urged investors to stick behind Trump's policies. "To anyone on Wall Street this morning, I would say trust in President Trump," press secretary Karoline Leavitt said in an interview on CNN. "This is a president who is doubling down on his proven economic formula from his first term this is indeed a national emergency, and it's about time we have a president who actually does something

about it."

ACROSS THE BOARD

Stocks for all but 12 of the 500 companies that make up the S&P 500 index fell on Friday. The price of crude oil tumbled to its lowest level since 2021. Other basic building blocks for economic growth,



such as copper, also saw prices slide on worries the trade war will weaken the global economy.

CHINA HITS BACK WITH MATCHINGTARIFFS

China's response to US tariffs caused an immediate acceleration of losses in markets worldwide. The Commerce Ministry in Beijing said it would respond to the 34% tariffs imposed by the US on

imports from China with its own 34% tariff on imports of all US products beginning April 10. The United States and China are the world's two largest economies.US-listed shares of Chinese

companies dived, with JD.com and Alibaba and Baidu all down more than 7.7%. Companies with exposure to China also fell across the board, with mega-caps such as Apple

dropping 7.3%. TRUMP REMAINS DEFIANT

Trump seemed unfazed. From Mar-a-Lago, his private club in Florida, Trump headed to his golf course a few miles away after writing on social media that "THIS IS A GREAT TIME TO GET RICH."

However, Trump gave mixed signals on Friday. Trump said Vietnam "wants to cut their tariffs down to

ZERO if they are able to make an agreement with the US." Trump also criticised China's retaliation, saying on his Truth Social platform that "CHINA PLAYED IT WRONG, THEY PANICKED - THE ONE THING THEY CANNOT AFFORD TO DO!"

Trump has said Americans may feel "some pain" because of tariffs, but he has also said the long-term goals.

ctress Jividha Sharma, who shared screen space with Aishwarya Rai Bachchan in Subhash Ghai's 1999 hit Taal, has revisited her experience working with the former Miss World during the early years of their respective careers. In a recent interview with Lallantop, Jividha candidly spoke about the assumptions she had before meeting Aishwarya, and how the actress completely shattered those preconceived notions through her humility, discipline, and work ethic.In 1999, Taal wasn't just a milestone in Aishwarya Rai's career-it was also the first major project for Jividha Sharma, who was making her Bollywood debut. At the time, Aishwarya was just beginning to build her career in films, following her Miss World win in 1994 and her debut roles in Iruvar and Aur Pyaar Hogaya in 1997 By the time she stepped into Taal, she had already begun to attract widespread attention, with expectations running high. People had said she has an attitude because of the Miss World title and all that," Jividha recalled. "So even I went in with that impression. But when I actually met her and spent time with her on set, I realized she was nothing like that. She's very simple, very grounded-a genuinely good person.'

The actress was quick to highlight Aishwarya's professionalism on set. "She was extremely hardworking. We had several scenes together, and I observed that she was totally focused. She didn't take her role lightly, even though she already had that big title attached to her name. She would keep rehearsing her scenes, especially dance steps, until she got them perfect."A trained classical dancer, Aishwarya's commitment to nailing her performances wasn't lost on her co-star. "Despite being trained in Kathak and having all those credentials, she didn't take anything for granted. She never acted like she knew it all. If a step didn't look right, she would do it again and again. She wouldn't give up until it was flawless. That really inspired me. I genuinely liked her and even wanted to be like her

at that point. Jividha also offered a glimpse into their dynamic offcamera, revealing that both actresses would often be accompanied by their mothers during shoots. "We mostly talked about our scenes, but sometimes she would ask about my mom. She used to bring her mother along as well. There was a comfort in that, like we were both protected and supported."Though much of their joint screen time was later edited out from the final cut of Taal due to the film's runtime, the time spent together made a lasting impression on Jividha. "We had a lot of scenes together, but many of them were chopped. Still, the experience of working with her was memorable for me," she said.
