Guwahati, May 18: Assam Chief Minister Himanta Biswa Sarma on Saturday urged Congress leader Rahul Gandhi to drop the state's MP from the list of four parliamentarians nominated by the grand old party for the delegations to be sent abroad to explain India's stance on terrorism from Pakistan. Without naming Gaurav Gogoi, the Congress deputy leader in the Lok Sabha who is among the four MPs nominated by the party, the CM maintained that he should not be included in the all-party delegations "in the interest of national security". Sarma has been making allegations against Gogoi over his alleged Pakistan links through his British wife Elizabeth Colburn, and has claimed that the Jorhat MP had stayed for 15 days in the neighbouring country without informing authorities. The Congress leader had dismissed the allegations. "One of the MPs named in the list (from Assam) has not denied his prolonged stay in Pakistanreportedly for two weeks-and credible documents show that his wife was drawing salary from a Pakistan-based NGO while working in India," Sarma alleged on X. # Owaisi terms new Waqf law unconstitutional, seeks SC intervention

Navdeep Singh Sahni New Delhi, May 18: Describing the

new Waqf law as "unconstitutional", AIMIM president Asaduddin Owaisi has alleged that it is aimed at "destroying" Waqf properties and expressed hope of getting justice from the Supreme Court in the matter. In an interview with PTI Videos on Saturday, he also wondered how a uniform civil code (UCC) can be 'uniform' when there are several separate laws for different issues. The Hyderabad MP challenged the BJP and those hailing the Waqf (Amendment) Act to point out which sections are good in the new law. "Tell me in what way is it a progressive law? Tell me

one provision by which Waqf property is saved. Tell me one provision by which there is an increase in Waqf's income and one provision by which encroachers are removed," Owaisi asked. Owaisi,

who was a member of Parliament's Joint Committee on the Waqf (Amendment) Bill, alleged that the new law was made



Tell me which sections (are good in the new law)... neither the government nor those sitting in their support would be able to say," the All India Majlis-esaid. He further said the Dawoodi Bohras had wanted to be kept out of the purview of the Waqf law. Owaisi, who has challenged the Waqf (Amendment)

Act in the Supreme Court claiming that it violates the constitutional provisions, said, "We hope to get justice from the Supreme Court because this is an unconstitutional law." His remarks come after the Supreme Court said last week that it would hear on May 20 the point of interim relief in the challenge to the (Amendment) Act, 2025. A bench comprising Chief Justice of India B R Gavai and Justice Augustine George Masih would hear arguments for passing interim directions on three issues, including

In Mahendragarh town, LT cables will replace existing LT lines, and the nonfunctional 33 KV line between Mahendragarh and Narnaul will be removed. In terms of healthcare infrastructure, the Chief Minister announced the construction of a Primary Health Centre in the Khatod village panchayat area, subject to land availability. For irrigation, he announced Rs 6.60 crore for the reconstruction of four minors



# Earth observation mission could not be accomplished due to 3rd stage pressure issue: ISRO chief

New Delhi, May 18: ISRO's 101st mission from here, an earth observation satellite onboard the agency's trusted PSLV rocket, could not be accomplished on Sunday following a pressure issue in the third stage of the launch vehicle, the space agency said. Although the Polar Satellite Launch Vehicle (PSLV) made a textbook lift-off at the prefixed time of 5.59 am, the mission objectives, however, could not be achieved. "Today we targeted the 101st launch from Sriharikota, the PSLV-C61 EOS-09 mission. The PSLV is a four-stage vehicle and up to the second stage, the performance was normal. The third stage motor started perfectly but dur-

ful launch. The outcome of Sunday's launch to the data shared by the Indian Space Research would have come as a surprise to many, since PSLV has emerged to be the most reliable launch vehicle of ISRO. Post lift-off, even till the second

stage separation from the four-stage rocket, it was announced at the Mission Control Centre that they were being tracked by other centres of ISRO located in various parts of the country. According Organisation (ISRO), the PS1 (first stage) separation was scheduled for 111.64 seconds after lift-off, but it was achieved at 110 seconds. Further, the

second stage ignition of the rocket was targeted to be achieved at 111.84 seconds, but the process occurred at 110.2 seconds leaving a marginal difference. Similarly, the PS2 (second stage) separation was targeted at 264.34 seconds but it took place at 261.8 seconds. Although things were proceeding on expected lines, as understood by the regular announcements by the scientists over the progress of the mission, it was after reaching the third stage that a glitch surfaced. Meanwhile, a retired ISRO official, when asked about about the fate of the rocket after facing such an issue, said that it would have fallen into the sea as the issue cropped up at an altitude of about 450 km. EOS-09 is a repeat satellite similar to EOS-

04 launched in 2022 that has been designed with the mission objective to ensure remote sensing data for the user community engaged in operational applications and to improve the frequency of observation.

# Cong leader over govt rejecting party names for Op Sindoor delegations

The government has also assigned extra responsibilities. S Sreejith will oversee Cyber Operations, H Venkatesh will handle the Crime Branch, and G Sparjan Kumar will supervise all three regional crime divisions in Thiruvananthapuram, Ernakulam and Kozhikode.

# Fun learning: Over 11 lakh students join Odisha government's summer program on WhatsApp

BHUBANESWAR. The state government has started an 'Odisha Summer Learning Programme' this year to ensure students are connected to studies during the ongoing summer vacation, but in a fun and engaging way. At present, over 11 lakh students are actively taking part in the programme.Launched by the School and Mass Education department, the initiative aims to keep students from Classes I to VIII in government schools connected to learning through digital platforms during the summer break. From learning alphabet and solving mathematical problems to exploring subjects through creative activities, the programme covers it all but with a creative touch.

As part of the programme, SME officials said around 1,70,932 WhatsApp groups have been created under the guidance of teachers, enrolling more than 11.08 lakh parents whose children are studying in the primary and upper-primary level. The initiative ensures that students stay connected to their studies even during the vacation and enjoy learning in creative ways, the department officials said.

They are also enjoying songs, stories, and drawing activities and are eagerly writing answers to the questions," said Rashmita Patra, parent of a student from Tulasi Chaurasahi Government Primary School in Balipada.

# Denial of power subsidy to registered farmer societies unlawful, says Karnataka HC

The HC also directed the HESCOM to review, reconsider, and amend the existing policy governing agricultural power subsidies.

BENGALURU. The Karnataka High Court has directed the State Government and power distribution companies to treat farmer societies at par with individual farmers and not deny them tariff subsidies. The HC declared the September 4, 2008 government order unconstitutional for denying power tariff subsidies to farmers based on collective consumption exceeding the horsepower limit. The HC also directed the HESCOM to review, reconsider, and amend the existing policy governing agricultural power subsidies. The HC directed that the authorities must frame and notify appropriate guidelines within a reasonable period (preferably within six months) to extend power tariff subsidies to registered farmers, which aligns with the principles of equality, promotes cooperative farming, and advances the broader goals of sustainable agricultural development.Justice Sachin Shankar Magadum passed the order while partly allowing the petition filed by Neeru Balakedaarara Sanghas' from Parthanahalli and



Madabhavi in Athani of Belagavi, who have constructed a lift irrigation project on the Krishna river for the benefit of 200 acres of land and 103 acres of land in both the villages of the taluk."The denial of power subsidy to registered farmers, solely on the ground that their collective consumption exceeds a prescribed limit, is hereby declared unconstitutional and arbitrary. This practice is discriminatory and fails to align with the core objectives of agricultural subsidies, which are intended to support small and marginal farmers, promote equitable access to resources, and encourage sustainable farming practices.

The practice of differentiating between individual farmers and societies, based purely on collective consumption, is found to be inconsistent with the constitutional mandate of equality before the law under Article 14 of the Constitution of India. It is based on an irrational classification that arbitrarily penalises farmers for forming societies aimed at improving efficiency," the court said. The court further said that the authorities concerned should review and amend the current policy to extend power subsidies to registered farmer societies, with criteria based on per capita consumption, landholding, or aggregate power consumption per member, rather than penalising the society as a whole for exceeding a prescribed power consumption limit. The authorities should also ensure that the objectives of agricultural subsidies, including supporting marginal farmers, promoting cooperative farming, and ensuring equitable access to resources, are upheld.

# ED raid continues, Tasmac MD questioned for 10 hours

CHENNAI. The Enforcement Directorate's search operation at 10 locations in Chennai in the alleged Rs 1,000 crore Tasmac bribery scam that began on Friday morning continued for the second day on Saturday.Tasmac Managing Director S Visakan was once again taken to the Enforcement Directorate's office in Nungambakkam for questioning, where he was interrogated for at least 10 hours. Sources said that Deva, a prominent hotel owner, was also summoned to the agency's office for questioning.ED is conducting the searches to collect evidence on alleged money laundering in the Prevention of Money Laundering Act (PMLA) case registered by it.

The agency has booked the case based on 41 FIRs registered by the Directorate of Vigilance and Anti-Corruption (DVAC) regarding corruption in the state-owned liquor marketing company.

## ED yet to issue official note on ongoing raids

The first set of searches was conducted in the first week of March at Tasmac's office in Egmore and at the offices of various distilleries and bottling units that supply liquor to the government firm.

Apart from Visakan's home in Manapakkam, the central agency searched the properties linked to film producer Akash Bhaskaran of Dawn Pictures; AP Keshav Selvi of KS Smart Solutions, a tech firm which had won contracts of various state government departments; Ratheesh Velu, a Chennai resident close to top government officials; an executive of a bottling firm linked to Tasmac, and a few contractors. The searches are being carried out against entities alleged to be 'conduits' for laundering the bribe money, sources said.

The ED had alleged that illegally generated excess cash of Rs 1,000 crore was used for paying kickbacks in Tasame. No official statement has been issued by the agency regarding the searches yet. DVAC raids houses of former

# 12 years on university's roll, faculty suspended for 'lack of experience' in Salem's Periyar University

SALEM. Nearly 12 years after her appointment, Periyar University has suspended a female associate professor in the Department of Education on Friday, citing a 'lack of experience'. The suspended employee, K Dhanalakshmi, alleged casteist motives for the action. She was appointed as Associate Professor and had joined duty on August 5, 2013.In the suspension order, VC R Jagannathan stated, "The preliminary inquiry made to ascertain the genuineness of the experience certificate for the job of Associate Professor in the service of the Periyar University, revealed that you (K Dhanalakshmi) employed as Associate Professor has submitted

the experience certificate which is not adequate for the post applied," he said in the order.

'The lack of experience is also evident from the self-declaration submitted by you (K Dhanalakshmi) at the time of interview on August 1, 2013. It is felt necessary in the larger



public interest and it the interest of the university to place you (K Dhanalakshmi) Professor denies charges under suspension from service," the order Alleging casteist motives behind her suspension, reads.Dhanalakshmi, who denied the VC's charges, told TNIE that she has all the proper experience certificates for the job of Associate Professor and they were approved by the

former registrar and dean of the university during appointment. She suspects a move to prevent her from

becoming the Head of the Department and attributed a casteist angle as she belongs to a Scheduled Caste."Even now, the university administration is trying to appoint a junior in my department as the head of the department due to casteist intentions. Even though I have the qualifications, the opportunity to become the HoD has been denied to me. Regarding this, I had appealed to the VC last week. After listening to a few casteist teaching staff, the VC suspended me," she alleged and said that she would face the issue legally. V-C was not available for comment.

Dr Satyavani, along with her elder sister Dr Saraswati, has extensively toured India over 20 years and documented their memories in lucid Telugu.

Born in a traditional family in 1942 in the erstwhile Godavari district, Dr Satyavani did her Masin Hindi and political science, and M.Phil and doctorate from Andhra University. She worked as a political science lecturer in Kandukuri Rajyalakshmi Women's College for over 30 years.

Dr Satyavani has penned 40 spiritual books, including "Dwadasa Jyotirlinga Kshetra Darsini," "Godavari Pushkaralu," and "Varanasi." She shared her experiences with TNIE, saying, "I, along with my sister, took a holy dip in all Pushkara rivers in the country. I took a holy dip in the Sindhu river to Brahmaputra with a little pride. I get emotional whenever I see the river." She credited her father, Challa Veeravadhanulu, for her adventurous spirit. "My father's impact is enormous on my life. My father was a friend of Mutnuri Krishnarao and great freedom fighter Bhogaraju Pattabhi Sitaramaiah," she said

# Youth collective hosts biryani challenge to fund road project in Malappuram

MALAPPURAM. A youth collective in the tiny hamlet of Orulummada, near Kalikavu, Malappuram, has come up with a "flavourful" proposal -- a biryani challenge, on May 20 -- to fund the construction of boundary walls for homes along a key artery. Part of Chokkadi panchayat, Orulummada suffers from poor road connectivity. During the 2018 floods, residents lost the lone three-foot-wide bridge which connected them to Kalikavu town.

Though the Army went on to construct a temporary bridge, that was also washed away in the heavy rain. The residents' long wait for a bridge became a reality when the Malappuram district panchayat constructed a six-foot-wide bridge. But with no public stretch available to build the approach road on the Orulummada side, local residents were asked to

arrange the land. Travelling to Kalikavu town was proving very difficult. We were helpless even when having to deal with emergencies. This formed the basis of our demand for a wider bridge and



approach road. That's why the club decided to take up the matter," Basheer, president of the Kairali Arts and Sports Club, said.A local resident named Kalarikkal Kunhappu donated 32 cents of land. But the approach through the plot would have created another bottleneck, and more land was sought for widening the road. However, most of the families with adjacent plots are small landholders. And they were

initially reluctant to give up their plots. The club took it upon itself to resolve the issue. We assured families of building boundary walls to protect their homes, and finally, they agreed. Despite the best efforts the road will be limited to a width of five feet for a 1km stretch. We are conducting the biryani challenge to raise money for the boundary walls," Basheer added.Construction work is expected to cost nearly Rs 2 lakh.

# 50kg single-use plastic seized from Noida market

Noida. Noida Authority conducted a drive in D-Block market in Sector 56 and seized around 50 kg of singleuse plastic. Officials said shopkeepers who are found using single-use plastic again will face penalties.

SP Singh, general manager (public health), Noida Authority, said, "We have been taking all possible steps to enforce the ban on single-use plastic and to regulate the use of plastic. We are conducting campaigns in Noida to control single-use plastic," he said. He urged residents to carry cloth bags to the markets.



Over the years, Noida climbed steadily in the Swachh Survekshan rankings - moving from 324th position in 2018 to 150th in 2019 and 25th in 2020 among cities or urban local bodies (ULBs) with a population of 3 lakh to 10 lakh. In 2021, it was ranked fourth; in 2022, it bagged the fifth spot. In 2022, Noida was also adjudged the best self-sustainable medium city (3 lakh to 10 lakh category). In the 2023 survey, Noida was declared the cleanest city in Uttar Pradesh. At the national level, it obtained the 14th rank out of 446 cities or ULBs in the 1-10 lakh population category.

# Gurgaon's pass rate falls, Rewari is best performer among districts

Gurgaon. With a pass percentage of 96.9, Rewari emerged as the top performer in the Haryana Board Class X examinations, the results of which were announced on Saturday afternoon. Girls outperformed boys once again. The pass percentage for girls was 94, around 3% higher than that of boys.

At 92.5%, the state's overall performance saw a drop of 2.7% from last year's 95.2%. The city recorded a pass rate of 92.9%, reflecting a drop of 3% from last year's 95.9%. No student from Gurgaon featured on the list of the top 20 released by the board. Nuh, consistent with last year, had the lowest score at 73.9%, a drop from last

Rohit from Oxford Public Senior Secondary School in Hisar district topped the examination by scoring 497 marks out of 500, followed by Mahi from New Saraswati Senior Secondary School in Ambala, who also scored 497. Akshit Sehrawat from Ashadeep Adarsh High School in Panipat scored 496.

While Gurgaon's overall pass percentage dipped by 3% there has been a notable improvement in its state-level ranking. Gurgaon climbed two places to secure the 14th position in the state this year, up from 16th last year. Despite the drop, education officials have considered the results satisfactory, especially highlighting the strong performance of government schools.

According to board data, 14,625 students from government schools in the city registered for the exam, out of which 13,585 passed. Additionally, 854 students are eligible for reappear exams, and 186 failed. In contrast, private schools performed significantly lower, with only 29 of the 84 registered students passing, resulting in a pass percentage of just 34.52%.

The performance of government schools in Gurgaon has been commendable. The consistent efforts by teachers and district-level educational initiatives are showing positive results. We are optimistic about even better outcomes in the future," Captain Indu Boken, education officer of the district said.

# Estonian businessmen among 5 dead as two helicopters collide midair in Finland

world. Two helicopters collided in mid-air over the western Eura province of Finland on Saturday, killing all five on board, Finnish news outlet Helsinki Times reported. The helicopters crashed to the ground after the collision. Finnish police said that five people were on board the two helicopters, and there were "several fatalities." The authorities are yet to determine the victims and the complete details of the event.

Estonian tycoons Oleg Snajalg, a wind energy pioneer, and Priit Jaagant, construction firm chairman, died in the accident. The accident occurred close to Eura airport, within the area that British helicopter squadrons had been deployed recently for military manoeuvres in late April. Finnish General Staff verified that no Finnish Air Force or foreign military aircraft were involved. The helicopters were civilian and were said to be carrying businessmen who flew from Estonia.

### HELICOPTERS' FLIGHT PATH AND WITNESS ACCOUNTS

Local media reported that one helicopter had three passengers, and the other had two. Both the helicopters departed from Tallinn, the capital of Estonia, and were on their way to Piikajarvi Airport in Kokemaki, some 15 kilometers from Eura airport.

# As India expels illegal Bangladeshi immigrants, Dhaka claims 'push-ins' at border

Dhaka. Bangladesh Home Affairs Adviser Lieutenant General (Retd) Md Jahangir Alam Chowdhury on Saturday said that Indian nationals found staying illegally in the country will be repatriated through proper diplomatic channels. The adviser made these remarks after inaugurating the third floating Border Outpost in Satkhira, news agency Bangladesh Sangbad Sangstha (BSS) reported.Bangladesh does not engage in "push-ins like India but believes in resolving issues through diplomacy", Chowdhury said, according to The Dhaka Tribune newspaper.

Bangladesh has always abided by international laws and protocols," he said. "The Ministry of Foreign Affairs has already written to India regarding the matter. Foreign Affairs Adviser Touhid Hossain and National Security Adviser and Chief Adviser's High Representative on Rohingya Affairs Khalilur Rahman are maintaining diplomatic communication on the issue," he added.

He said that India has been informed that if any Bangladeshi citizen is residing in India illegally, they should be returned through proper channels.

Similarly, if any Indian nationals are found to be staying in Bangladesh without authorisation, they will be repatriated following legal procedures, he said.He added: "We have requested the Indian side not to conduct push-ins but to follow formal repatriation procedures."The adviser claimed that on Friday, an attempt was made by India "to push in individuals along the Brahmanbaria border, which was foiled with the help of the Border Guard Bangladesh (BGB), Ansar members, and local residents". "If the local community remains united and vigilant, such push-ins can be resisted," the

Since the video has gone viral, many have started speculating about Erdogan's body language during the brief interaction captured in the footage.

According to a Turkish media outlet, Erdogan reacted in that manner as "Macron tried to establish psychological superiority by putting his hand" on the Turkish President's shoulder."But Erdogan did not allow it, he held his finger tightly and did not let go," the Turkish media outlet added. I'll be watching, and so will your customers!!!"Trump spoke after Walmart announced on Thursday that prices on many items like groceries and children's car seats might increase soon. Walmart's warning came in defiance of the government's move to lower tariffs temporarily for Chinese imports. Walmart CEO Doug McMillon said during the company's earnings call, "We can control what we can control. Even at the reduced



levels, the higher tariffs will result in higher prices.

The company expects these price increases to take effect later this month.

He also noted that Musk's love for events like Burning Man, adult entertainment, and gambling made him even more vulnerable to such spy

Buma spent 16 years in the FBI before he was arrested in March for leaking confidential information to a publishing house. He was indicted on one count of "Disclosure of Confidential Information" and freed on \$100,000 bail.



# Odisha urges Centre to expedite rice evacuation amid record paddy stockpile

BHUBANESWAR. The record procurement of 73.5 lakh tonne paddy during the kharif season has posed a problem of plenty for the state forcing the government to send an SOS to the Centre to evacuate more custommilled rice from Odisha to the central pool.

While the storage capacity of rice millers, registered with the Odisha State Civil Supplies Corporation (OSCSC) for milling and delivery of custom-milled rice (CMR) to the state government and Food Corporation of India (FCI), is full to the brim, procurement of rabi paddy from May 15 has added to the woes.

Sitting over a stockpile of over 48.5 lakh tonne of paddy (equivalent of 33 lakh tonne rice) after delivery of 16.25 lakh tonne of CMR rice to the state and FCI, the All Odisha Rice Millers Association (AORMA) has taken up the matter with the Food Supplies and Consumer Welfare (FS&CW) department to put pressure on FCI to speed up evacuation of rice. Even as FCI has fixed a target to lift 1.7 lakh tonne of CMR rice from the state every month, the central public sector undertaking is evacuating far less due to shortage of storage space in its godowns. The central agency has received 7.76 lakh tonne of CMR rice for kharif 2024-25 season from the state as on May 7, 2025, against the target of 10.20 lakh tonne, sources said.

# From failure to flourishing: NTR district woman farmer finds success through natural farming

VIJAYAWADA. Amidst the harsh realities of erratic vagaries of nature, soil degradation, and dwindling farm incomes, a woman farmer from Chevuturu village in G Konduru mandal of NTR district has emerged as a symbol of resilience and achieved success through Natural Farming. K Ramadevi, once disillusioned by repeated crop failures, has built a sustainable livelihood using methods that require minimal water and chemical inputs.

For years, Ramadevi and her husband Srinivas Rao struggled with mono-cropping cotton on their 2.30-acre land. "The soil had turned hard as stone due to excessive use of fertilizers. We had no borewell and depended on neighbours for irrigation water just to keep our 42 mango trees alive," she recalled. After facing repeated crop failures, the family abandoned farming for nearly five years. A turning point came in 2018 when Ramadevi attended a natural farming awareness session by the Andhra Pradesh Community Managed Natural Farming (APCNF), implemented by Rythu Sadhikara Samstha (RySS).

# CM Chandrababu Naidu sets deadline for infrastructure projects in Andhra's Kurnool

KURNOOL. Chief Minister Nara Chandrababu Naidu conducted a whirlwind tour of Kurnool district on Saturday, announcing several developmental projects and interacting with the public.

Arriving at Orvakal Airport, he proceeded by road to C Camp Rythu Bazaar, where he engaged with farmers and reviewed local infrastructure. During the visit, he sanctioned Rs 6 crore for the expansion of the Rythu Bazaar and directed officials to complete the project within a year, ensuring the addition of parking facilities and an Anna Canteen.Industries Minister TG Bharath, who accompanied the CM, expressed gratitude for the timely fund allocation.

The Chief Minister then visited Dhanalakshmi Nagar near Kendriya Vidyalaya to lay the foundation stone for the 'Swarna Andhra - Swachha Andhra' park, to be developed over 67 cents of land with Rs 50 lakh Corporate Social Responsibility (CSR) funds from Jai Raj Ispat Limited.

He directed officials to complete the project in two months, integrating solar lighting, fitness zones, multipurpose lawns, senior citizen areas, children's play areas, walking tracks, and stone gravel beds. Addressing the gathering, Naidu emphasised creating a model recreational spot and instructed the installation of gates to prevent nighttime misuse.

As part of the agricultural mechanisation initiative, the CM distributed Kisan Drones to two farmers. KANNIYAKUMARI. Swoosh...stirred by the passing breeze, long palm fronds gently grazed the rooftops of E L Prathee Jeen's childhood home in the Ethavilai village of Kanniyakumari. The village sat nestled among these panai marams, woven into the fabric of their daily life. Jeen recollects playing with nungu vandi, sipping nungu sarbath, and sleeping on palm-fibre mats. In her early 40s, she quit her teaching profession and took up a new life mission - to revive the lost glory

of the palm tree, a symbol which, she says, is deeply rooted in Tamil community and landscape. The 43-year-old now travels across Tamil Nadu to plant palm saplings, conduct awareness campaigns, and train communities to craft value-added palm products, through her organisation the TAN Palm Foundation.

Fondly called "Panai Mara Tharahai" (Palm Star), Jeen is a familiar face at social gatherings, weddings, and political events - often gifting palm-leaf hats she personally makes. These handmade gifts, which she distributes even to policymakers, serve as reminders of the importance of palm conservation. "Palm trees are not just symbols of tropical beauty," she says, "They are lifelines - offering food, shelter, and income to generations of people.



Preserving them is preserving our heritage." Jeen trains others, especially women, in making palm-based products - baskets, hats, fans, and decorative items - helping them build livelihoods while promoting eco-conscious She says the mission is not just about trees, but practices. Though she doesn't come from a family of traditional palm climbers, Jeen was

raised with a deep appreciation for the tree's value. Her father, P Eliyas, a businessman, and her mother, K Leela Bai, a homeopathy practitioner, instilled in her a respect for sustainable living. Palm wasn't just a tree in our village - it was part

of our daily life," Jeen recalls. "From what we drank to what we slept on, palm was everywhere." A postgraduate in History with a BLit in Tamil and Montessori training, Jeen taught at several schools across Tamil Nadu,

and eventually worked for over a decade at Fathima Public School in Kottamam, Thiruvananthapuram, Kerala. Her handson, activity-based teaching style allowed her to weave environmental education into her lessons, including the significance of palm trees. But the pull of the panai maram was too strong.

# Karnataka to take lead in elephant census among southern states

BENGALURU. For the second consecutive year, Karnataka State Forest Department will continue to take the lead in coordinating and conducting the synchronised annual elephant census exercise for the three southern elephant states, from May 23- 25.Like the previous year, while the 10 bordering forest divisions will be assessed, this year, along with the Mysore Elephant Reserve, the elephants residing in the coffee estates of Karnataka -- in Hassan and Chikkamagaluru -- will also be accounted in the census exercise.

The census will also be done in Kerala and Tamil Nadu. "While all-India elephant census is done once in five years, in Karnataka, just like the tiger census, the elephant census is also being done annually to mitigate conflict.

The decision to involve the southern elephant states in the exercise was taken at the meeting which was held in Bandipur Tiger Reserve in 2024. Following which, the first coordinated estimation exercise was done in 2024 and Karnataka took the lead. On May 20, a training will be imparted to the foresters on the methodology," said Additional Principal Chief Conservator of Forests, wildlife,

The prescribed format set by the Wildlife Institute of India and the Ministry of Environment, Forest and Climate Change will be used for assessment- direct count, indirect method including dung analysis and elephant profiling. Elephant experts along with those from IISc will also be a part of the exercise.

In 2024, Karnataka recorded 4,126 elephants in the 10 divisions bordering the neighbouring states. Reports showed Bandipur Tiger Reserve housed the highest elephants- 1,042 and Virajpet the lowest-23. In 2023, foresters counted 6,395 elephants across Karnataka. This is 25% of India's elephant population.

# Kerala beer sales losing fizz, decline 8.6 per cent in two years

KOCHI. Kerala, it seems, is no longer looking to beat the heat with a chilled bottle of beer! Over the 2023-25 period, consumption of the beverage in the state declined by a sharp 8.6%, or nearly 10 lakh cases. This downturn underscores Kerala's enduring preference for hard liquor, a characteristic of its traditionally brown spirits market that holds firm even during record-breaking heat, as data from the Kerala State Beverages Corporation (Bevco) confirms.Bevco managing director Harshita Attaluri told TNIE that beer consumption has been on the decline over the past two years, and she attributed the slump to public preference.

As per the Beverages corporation's data, beer sales slumped from 112 lakh cases -- both wholesale (to bars) and retail (Bevco outlets) - in 2022-23 fiscal to 102.39 lakh cases in 2024-25.Meanwhile, consumption of Indian Made Foreign Liquor (IMFL) through the



wholesale and retail routes surged by 9.74 lakh cases in the two-year period to 229.12 lakh cases.In contrast, beer sales increased year-onyear by 9% nationally during 2024-25, according to Brewers Association of India (BAI), the apex body of the Indian beer industry, representing India's leading beer

Beer sales in Kerala has been affected primarily due to low number of retail shops and acute shortage of chilling equipment in those all government owned shops. Further, absence of permitting even basic innovations such as draught beer has limited on-trade demand and a beer culture as seen in other parts of country," Vinod Giri, director-general of Brewers Association of India told

According to Giri, Bevco acknowledges the need for change and is implementing measures to revitalise the beer sector. These initiatives include opening model shops, allowing companies to install chillers in shops, and permitting draught beer sales. "We are optimistic that once these reforms are effectively executed, the beer industry in the state will undergo a significant


# Let there be water: Restoration of Koliyanur lake in Tamil Nadu

# A crucial lifeline decades ago, the 100-acre Koliyanur lake had shrunk by half. Through the efforts of the Kalaam group, 37 acres of land were restored in 2025

VILLUPURAM. The dust of decades had settled thick upon the promise of Koliyanur Recognising the ecological and lake, a vital artery choked by neglect and the relentless creep of encroachment. For a generation, its lifeblood had dwindled, a silent tragedy unfolding in the Villupuram district. But from the parched earth, a spark ignited - the Kalaam Volunteer Group.

This unassuming collective of residents dared to dream of reviving it, a vision that would not only reshape their environment but also bind their community in the face of nature's fury. Their story, unfolding over the past year, is a testament to the extraordinary power of ordinary people, a beacon of hope Cyclone Fengal and resurrected a lost lifeline.Koliyanur lake, stretching across hundreds of acres, had been encroached upon by 57 farming families in the Koliyanur village area for more than three decades. Once a crucial source of irrigation and drinking water, the lake had slowly shrunk by half due to unregulated occupation and sediment build-up. communal importance of the loch, the Kalaam Volunteer Group, in collaboration with Exnora International Foundation, NDSO, and M N Gayathri Charities, initiated a restoration project in 2024. "As a resident of Koliyanur, I've never seen the river with water since I was a child, and it has been a dream to see it flow with water in its natural allure. And that is why I chose to revive it," said N Manikandan (32), the group's full-time organiser.

that pierced through the devastation of Through persistent dialogue and peaceful engagement, the volunteers worked closely with local authorities and the encroaching farmers to find a resolution. Many of these farmers, though initially resistant, were later persuaded to vacate the land, understanding the long-term benefits of a restored waterbody for the wider



"The restoration involved clearing vegetation, removing debris, and extensive desilting operations. Volunteers toiled for months under the sun, raising funds locally and receiving support in the form of machinery and manpower from wellwishers. By early 2025, the loch had been rejuvenated across 37 acres — its basin deepened, banks fortified, and native flora

reintroduced around its perimeter. The revived loch has now begun recharging groundwater, benefiting nearby villages, and is expected to support agriculture in the region for decades to come," said Manikandan.

The organisation further extended its service to address the devastating effects of Cyclone Fengal in November 2024. Amidst the chaos, the Kalaam Volunteer Group emerged as one of the first responders. Within hours, volunteers spread out across the district, setting up makeshift relief camps, organising

food drives, and distributing essentials. Several lakhs of people were aided, thanks to the group's network and local knowledge. The group's approach ensured that relief reached not just urban neighbourhoods but also isolated villages and marginalised communities, including tribal, disabled, and transgender

# Kashmir's normalcy, Pakistan's turmoil

Everyone must watch the talk delivered by Pakistan's army chief, Gen Asim Munir on April 14-16 at the Annual Convention of Overseas Pakistanis. It was certainly the most extreme speech I have seen by any leader, anywhere. Many have linked, or believe, that this "hate" speech was the green signal the Pahalgam terrorists were waiting for before they carried out their massacre.

The speech certainly outlined the battle between secular India and theocratic Pakistan. In Munir's narrow world-view, there is a lack of connection, or commonality, between the citizens of India and Pakistan. In fact the reality is quite the opposite, especially in Punjab.Gen Munir's first gross miscalculation is that he addressed his remarks to overseas Pakistani residents. But in the audience pictures, you will be hard-pressed to find a smile of approval to what Munir was saying, let alone cheer. Many of these overseas Pakistanis have worked, lived and roomed with the very same people that Munir was saying were Pakistan's born enemy, i.e. Indians - some even have intermarried. Hence, the lack of applause, if not downright embarrassment, perhaps even contempt.Gen Munir's second miscalculation was the expectation of support his Muslim terrorists would get from India's Muslims. Instead, there was overwhelming condemnation of their unsparing brutality as well as of Pakistan, the country they came from. The response by Indian Muslims, both leaders and ordinary people, across the country as well as in Kashmir, has been most pronounced in the outright condemnation of Munir's hate speech. It is likely that this response was not anticipated by the terrorists and their political handlers. Perhaps their warped worldview also does not allow them to comprehend fundamental and structural divergences between the economies of India and Pakistan. This process of change has been long in the making. In 1985, Pakistan's per capita income (Penn World Tables, 2017 PPP), relative to India reached a peak of 2.2, i.e. Pakistan's per capita (pc) income was more than twice that of India. In 2024, at the time of its 13th IMF loan since 1991 (the last time India got an economic loan from the IMF), Pakistan's pc income was reduced to 60 per cent of India's level. This continuous fall in Pakistan's living standards, especially relative to India, partially explains Munir's desperation in appealing to the only factor he thinks reflects the welfare of both domestic and foreign Pakistanis - religious fanaticism and Kashmir. Along with these Grand Canyon gaps in performance, it is the fullest integration of Kashmir with the rest of India that seems to have affected Munir the most. Today India is in the midst of major trade deals with the US, UK and the EU, while Pakistan begs for Chinese financial help, debt and armaments alongside the 25th loan from the IMF — the highest for any country ever. Meanwhile, PM Narendra Modi, with his visit to

Saudi Arabia, is demonstrating India's closest linkages with the Arab world than at any time before - traditionally Pakistan's friends and allies. The tragically explicit copycat behaviour of the Pahalgam terrorists with Hamas terrorists attack in Israel on October 7, 2023 was not missed -- the same terrorist playbook. At the time of the Hamas terrorist attack, Israel was in the final stages of negotiating with Saudi Arabia, a complete normalisation of relations. However, the real Munir-Pakistan misjudgment was not about bilateral country aggregates, but what is happening in Kashmir itself. It is not just India that has economically leapt way past Pakistan. Government initiatives, particularly after the abrogation of Article 370 in 2019, have substantially improved the normalisation of Kashmir. It is this integration and development that Munir and his army have completely missed.

Why did Pakistan stir up the terrorist pot again? That's a question every Indian — Hindu, Muslim, Sikh, Isaai — is asking. Was it to provide an alternative to the distress caused by the relative decline of Pakistan? Note, that the standing of the Indian economy and polity was at its peak and that of Pakistan at its trough, when Munir made his speech. One week later, on April 22, the terrorists struck.

# Beyond Indo-Pak truce: Reimagining peace in a region on the edge

The historical trajectory of South Asia, marked by seminal events as Partition, the Kargil conflict and the Indo-Pak wars of 1965 and 1971, has bequeathed a complex legacy of societal fragmentation

WAR means an ugly mob madness, crucifying the truth tellers, choking the artists, sidetracking reforms, revolutions and the working of social forces — these words by John Reed, American socialist activist, written in 1917 amidst the carnage of World War I, ring disturbingly true in our time. The recent escalation between India and Pakistan, marked by military exchanges and public panic, brought the subcontinent close to the same disaster. But in a remarkable turn of events, a ceasefire was abruptly announced facilitated by an unexpected diplomatic intervention. While it brought welcome relief, its sustainability remains uncertain. The fragile nature of the agreement was evident in the renewed military hostilities that followed shortly after, highlighting the deep-seated trust deficit and questionable intentions between the two nations. The terrorist attack in Pahalgam, which left 26 innocent people dead, rightly drew widespread condemnation. India's military response — described as calibrated and proportional — unleashed a chain of retaliatory moves that risked spiraling out of control. Even measured actions, in a region so steeped in historical grievance and mistrust, can set off devastating consequences. In border regions like Punjab and Kashmir, the suffering was acute, with families displaced, agricultural livelihoods disrupted, and civilian lives lost. The cost of conflict is incalculable. The ceasefire has potentially averted a catastrophic conflict between two nuclear-capable nations. However, true peace demands more than a halt to hostilities. It requires reflection, moral clarity and a commitment to sustained diplomacy. The conflation of patriotism with militarism warrants critical reevaluation, as the pursuit of justice necessitates a more nuanced approach. Consequently, effective accountability for acts of terror requires a multilateral, rules-based framework that prioritises evidentiary rigour and international cooperation rather than unilateral actions that may compromise truth and exacerbate conflict.As Ernest Hemingway astutely reminded us, "Never think that war, no matter how necessary, nor how justified, is not a crime." Regardless of its perceived necessity or justification, war constitutes a profound failure of political and diplomatic endeavours. These historical antecedents cannot be perpetuated indefinitely and the subcontinent's future stability cannot be predicated on chance, rather they necessitate a concerted effort to transcend the pathologies of past conflicts. Pakistan, under General Asim Munir, remains a troubled state. Its economy is on the verge of collapse, its foreign reserves are dangerously low and its democratic institutions under siege. Its military continues to dominate its political discourse. For Pakistan's establishment, escalating tensions with India offered a convenient distraction from domestic chaos and economic mismanagement. India, however, resisted falling into this trap and showed strategic restraint and



visionary leadership, displayed in its laudably measured and calibrated approach, that has not escaped global attention. A more enduring solution lies in investing in democratic values, regional cooperation and economic justice. As it is, militarisation of the Kashmir dispute has led only to entrenched hostility and alienation. A focus on democratic inclusion, dignity, and development can build trust where fear now festers. The wounds will heal through through education, dialogue and a reaffirmation of our shared humanity. The people of Kashmir, who have long been caught in the crossfire of competing nationalisms, must remain central to any solution that aspires toward justice and peace.

Furthermore, the prospect of nuclear escalation warrants utmost gravity, particularly given the unstable leadership dynamics in Pakistan, characterised by questionable decision-making capacity and a propensity for disinformation, thereby heightening the imperative for cautious diplomacy. Any miscalculation can lead to consequences far beyond our imagination. The ceasefire is slippery and must be seen as the beginning of a broader peace process. Nations like Sweden and New Zealand have shown that true security stems not from arms, but from equity and cooperation. India and Pakistan must move in that direction. The subcontinent cannot overlook that the trauma induced by past wars continues to cast its shadow over generations. The psychological effects of conflict - seen in veterans, widows, orphans and refugees — remind us of the heavy price we pay for political failures. Such trauma is not just personal; it seeps into the collective consciousness, shaping identities, reinforcing fear, and stifling possibilities of reconciliation. The silence of those who lost

everything in war should echo in our decisions. On international relations, a shift is necessary, wherein strategic alliances are reoriented towards fostering peace and cooperation rather than perpetuating conflict. Partnerships with nations like the US or within frameworks like the Quad should prioritise collaborative initiatives in trade, innovation, climate resilience and regional stability, rather than serving as conduits for confrontation with countries like China or Pakistan. It is essential to distinguish between patriotic sentiment and national arrogance.

There must also be a reckoning with the militarised mindset that dominates much of our political discourse. We must understand peace as not the absence of war but as a proactive state — built through institutions, education, empathy and exchange. Civil society, artists, writers, teachers and journalists have a key role to play in imagining a new regional future. The stories we tell, textbooks we write, films we produce, all must move us towards common ground. The moment demands critical introspection, not triumphalism, as we consider the potential consequences of military action and the human and moral costs associated with it. Effective leadership necessitates questioning prevailing narratives, embracing hope, and refusing to succumb to the logic of violence.Let us seize this pause in violence to initiate conversations long overdue, not only between governments, but also among peoples. Religious leaders, scholars, entrepreneurs, students — all must collectively contribute to building bridges of trust.

# Talking to Taliban

# It should not be seen as an endorsement of the regime, but a calibrated engagement focused on regional security

When the Taliban took over Afghanistan in August 2021, India responded with caution. A few days into the takeover, New Delhi withdrew its ambassador and diplomatic staff from Kabul and suspended direct engagement. Realising that a stringent no-talk policy was impractical, India started to gradually open channels of communication. The reopening of the Indian embassy in June 2024 was followed by a public meeting in January this year between Foreign Secretary Vikram Misri and Afghanistan's acting Foreign Minister, Amir Khan Muttaqi, in Dubai. Amidst these developments, since August 2021, India has been regularly delivering wheat, pesticides, medical supplies and other forms of aid. Even in the Union Budget for 2024-25, there was an allocation of Rs 100 crore for assistance to Afghanistan. The first-ever ministerial-level conversation between External Affairs Minister S Jaishankar and Muttaqi on Thursday should be seen as the next logical step in the

incremental outreach by both countries. The phone call took place days after the India-Pakistan ceasefire following the Pahalgam terror attack, which was unequivocally condemned by the Taliban regime.

Traditionally, Delhi and Kabul have had warm ties, barring the years of Taliban 1.0 (1996-2001), when India saw it as a proxy for Pakistan's strategic interests. But relations between the Taliban and Pakistan have been deteriorating rapidly, primarily driven by issues over the Tehrik-i-Taliban Pakistan, operating along the Afghan-Pakistan border. Realising that it does not have a hold on the Taliban any more, Rawalpindi has been trying to drive a wedge between India and Afghanistan. In a post on X, Jaishankar welcomed Muttaqi's "firm rejection" of Pakistan's "recent attempts to create distrust between India and Afghanistan through false and baseless reports" — a reference to reports in Pakistan that Indian missiles had hit Afghanistan during Operation Sindoor. Amid a widening rift

between Taliban 2.0 and Pakistan, India needs to keep communication lines open and prevent Afghanistan from becoming a sanctuary for anti-India terror groups. There is no denying that the Taliban continues to be an autocratic regime with little regard for human rights, especially the rights of women. That is why India is yet to recognise the Islamic Emirate of Afghanistan. Indeed, increased engagement risks undermining India's moral stand. But to not engage at all carries risks, too. China has signed significant investment and security agreements with the Taliban, including a \$540million oil extraction deal. Within the power politics of South Asia, given the China-Pakistan-Bangladesh axis, a Kabul-Beijing entente would be a matter of concern. India does not have the power to alter Afghan politics and society, but it has to deal with whoever sits in Kabul. There is no denying that the Taliban continues to be an autocratic regime with little regard for human rights, especially the rights of women.

# Three morals and a Trump story

THE GREAT GAME: The story of how India won over the Taliban is perhaps the most fascinating of all

HOURS after India's Ministry of External Affairs issued a six point-by-point rebuttal on how the US never mediated last week's India-Pakistan conflict, Donald Trump has insisted, for the sixth time since the conflict began, that he did."...And by the way, I don't want to say I did, but I sure as hell helped settle the problem between Pakistan and India last week, which was getting more and more hostile," Trump told troops at the US al-Udeid airbase in Qatar on Thursday, the last stop of his Gulf tour. It sounded like a parting shot. I'm telling you guys, he was saying, I am the one who averted a nuclear war.

Now you could roll your eyes or you could believe what the US President says, which is that it needed a powerful third party — him — with influence in both New Delhi and Islamabad to stop the natives from going at each other again and continuing their "1,000-year war."

But there are three more morals to the story. The first penny dropped when External Affairs Minister S Jaishankar got on the phone with his counterpart in Afghanistan, Taliban Foreign Minister Amir Khan Muttaqi, on Thursday evening. Nobody knows who called whom, but the MEA did put out that Jaishankar expressed his appreciation of Muttaqi's earlier condemnation of the Pahalgam massacre. The first (of the last three) morals is not that Jaishankar and Muttaqi actually spoke to each other — a leader of the world's largest democracy speaking to a man who doesn't even represent a country, merely a regime — or that he did so openly. The lesson here is that New Delhi didn't seem unduly bothered whether it would be criticised or not for speaking to the Taliban, which has violated every rule in every book before and since it came to power for the second time on August 15, 2021. Fact is, Jaishankar was only taking a leaf out of Trump's book. Which is that if you have the ability to exercise power, you will be forgiven the vanity of changing your mind as well as the direction of your country's policy. Just check out Trump. He is making nice with Vladimir Putin, his country's arch-enemy; in Riyadh earlier this week, he shook hands with the Al-Qaeda's newest ally which now rules Syria; and in Qatar,



the home of the radical Islamist Muslim Brotherhood group, he ignored all the signs because the Al-Thani sheikhs flattered him with a welcome that included the gift of a \$400-million plane for the US President's use. Even when Trump brought up his grouse about Apple CEO Tim Cook making iPhones in India with Qatari businessmen ("I said to him, 'my friend, I am treating you very good... but now I hear you are building in India. I don't want you building in India..."), New Delhi simply refused to react. They turned to the Apple folks, instead, who assured them that Cook would, indeed, continue with his plans to set up factories in

India.In the bad, old days, New Delhi would have been shaken if someone as powerful as the US President said the things he did. But India is learning to hold her own, in the face of far more powerful economies like China and the US cutting a deal that brings down their own tariffs a decision that is bound to affect India's own exports.Fact is, this week, India relearnt the oldest maxim in the book of politics — there are no permanent friends or enemies, only permanent interests. Like yesterday's newspaper which is today's raddi, last week's fast friends could be distant cousins today. That's why 'Ab ki baar Trump sarkar' is a slogan from another

century. Today's protection will come from having Apple on your side, because that company is so powerful that Trump has no option but to have Tim Cook on his side. As for Trump taking credit for "mediating" between India and Pakistan, in any case, even the New York Times now admits that India inflicted the most damage on Pakistani facilities. As for Pakistan celebrating its "victory" in this conflict, perhaps neither Trump nor the Pakistanis have noticed that 11 Pakistani bases were spiked by Indian missiles. Which is when the Pakistanis sought the attention of the US President and requested him to shut it down.Or, maybe, Trump has noticed—just that he's moved on to something else, this time to celebrating a newly arrived grandchild. The third moral is that in his three months in power, Trump has successfully antagonised half the world. The fact that he went back on his own promises to burn China to the ground — because his own enormous US conglomerates who make in China and large profits at that, must have told him that high tariffs would only hurt American customers — only indicates that when you're this powerful, talk is cheap. As for the Jaishankar-Muttaqi conversation, the fact that it took place so close to the end of Operation Sindoor or that Pakistan and Afghanistan have been at daggers drawn for some time has escaped no one. Fact is, India has been wooing the Taliban for some time now, almost as soon as it took Kabul in 2021 on the anniversary of India's independence. On a visit to Kabul a year later, it was plain to see that the Taliban were already losing patience with their one-time mentors and guardians, the Pakistani military establishment. The story of how the ISI won over the Taliban and nurtured it, until the West took back Afghanistan in the wake of 9/11; how the ISI bided its time for 20 years and then helped the Taliban wrest the country back from the Americans and its NATO allies — that's a story for another time.In this great game this week, as Trump changes course as quickly as the Sutlej and the rest of the world rearranges itself — the story of how India won over the Taliban is perhaps the most fascinating of all.





The multitude and variety of tasks can become overwhelming; many employees are unable to handle the stress and face a dip in their productivity . When the fire drills of the day begin to sap your time and something in the schedule has to slip, make sure it's not part of that 20 per cent."

Prioritization also enables employees to maintain clarity on the ultimate goals of the organization. Sailesh Shetty, VP human resources & services, Toyota Kirloskar Motor, explains, "Organisations should make every employee understand the role he or she is playing in solving the issues important for the organisation. Employees should have clarity on what is expected from them; this enables them to prioritise better. When the employer engages employees every day in analysing and solving problems, they feel highly motivated."

On May 13, the victim received a courier at his home containing two photographs of his wife and son, along with two empty cartridges and a letter demanding a large sum of money in US dollars.



# Delhi University to implement uniform seniority policy for teachers

NEW DELHI. Delhi University (DU) is set to introduce a uniform policy to determine the seniority of college teachers, aiming to promote transparency and eliminate confusion in faculty appointments and promotions. The proposal is slated for final approval at the Executive Council (EC) meeting on May 23, chaired by Vice-Chancellor Yogesh Singh. The lack of a clear framework, particularly for Assistant Professors (Level 10), has led to ambiguity in promotions and nominations for academic and statutory committees across DU colleges.

To address this issue, a high-level committee was formed in July 2024. Led by the Dean of Colleges, the committee included college principals, Executive and Academic Council members, as well as representatives from SC, ST, and OBC communities. After five meetings and a comprehensive review of Ordinance XI, the committee presented its recommendations.

The proposed policy stipulates that departments with earlier appointments will be deemed senior. In departments without a unified seniority list, age will be used to determine seniority, ensuring equal treatment of first-ranked candidates from different categories. This approach will be applied until all ranks are covered. Additionally, the policy introduces parallel seniority lists within categories, ensuring clarity without altering overall rankings. This system is designed to uphold constitutional reservation provisions and guarantee fair representation in university governance.

# India blocks land route for several Bangladeshi goods, hits textile trade

NEW DELHI. In a tit-for-tat move, India has banned imports of several items from Bangladesh via land routes, dealing a severe blow to Dhaka, which already has a massive trade deficit with Delhi amounting to USD 9.2 billion for the fiscal year ending March 2024.

As per a notification sent by the Commerce Ministry, dated May 17, imports from Bangladesh will only be allowed through Mumbai's Nhava Sheva and Kolkata's seaports. Several items like fruits, fruitflavoured and carbonated drinks, processed food items, wooden furniture, plastic, dyes, cotton and cotton yarn waste, among others, have been included in the list.

Imports of these products through the land customs check posts in Assam, Meghalaya, Tripura, Mizoram and Changrabandha and Fulbari in West Bengal have now been barred.

However, fish, edible oil, LPG and crushed stones have been exempted from the list. This latest move will make Bangladeshi goods even more expensive, acting as a disincentive for Indian importers. Bangladesh -- a major exporter of textiles and readymade garments will now be unable to send these goods via land routes, severely impairing Dhaka's export

Last month, the Narendra Modi government pulled the plug on the transshipment facility that had allowed Bangladesh's export cargo to flow smoothly to other countries like Bhutan, Nepal and Myanmar. Days later, Bangladesh stopped its import of yarn -- which forms 30 per cent of Delhi's textile exports to Dhaka -through Benapole, Bhomra, Sonamasjid, Banglabandha and Burimari land ports.

Meanwhile, Bangladesh's Chief Adviser Muhammad Yunus called for "an integrated economic plan for Bangladesh, Nepal, Bhutan, and the Seven Sisters" last week. This proposal came two months after Yunus urged China to extend its economic footprint not only to Bangladesh but also to India's seven northeastern states.

# EPF: Don't underestimate a low salary; trust it to build a nice corpus; check how

Kolkata. Legislated in 1952 a few years after Independence, the Employees Provident Fund (EPF) is not only the earliest social security scheme for employees in the country but also one of the most impactful. It provides assured and tax-free returns for all employees working in any organisation that employ 20 or more persons. The most important feature of the EPF is that it uses the force of compounding and regular contribution to build a

The EPF scheme draws on a 12% contribution from the basic + DA of the employee's salary. It is taken from the employee. A contribution is also taken from the employer. The entire amount taken from the employee's salary is deposited in the EPF account. But only 3.67% of the portion deducted from employer is put in the EPF account. The rest (12-3.67 = 8.33%) is put into a pension account.

Since EPF contributions are a percentage of the basic salary (and DA) of an employee, the amount of contribution is directly dependent on the quantum of salary of the employee. Significantly, while this statement is most definitely true, the reverse is not true. Which means if one has a small salary, the EPF kitty can turn out a significant corpus, thanks to the immense force of compounding. Let's check the

# EPF calculator: Basic salary less than Rs 5,000

Let's assume a person starts earning at the age of 23 and retires at the age of 58. Let's assume that he/she gets a basic salary of Rs 4,500. Let's also assume that this individual gets an average salary increment of 5% — a rate that can barely keep pace with retail inflation. The EPF calculator will tell you that the EPF kitty will stand at Rs 28,95,567 (Rs 28.95 lakh) when this person retires. By the way, this calculation assumes that the rate of interest paid by EPFO stands at 8.25% as paid in Fy24.

Now if we assume that this person is able to earn a salary increment of 7.5%, the kitty will swell to Rs 45,00,093 (Rs 45 lakh) in the same period of time. If the rate of increment jumps to 10%, the money in EPF will rise to Rs 73,95,334, or Rs 73.95 lakh.

With the help of this SFT the Income Tax Department can track an individual's financial activities. SFT full form is a Statement of Financial Transactions.

The new notes will retain the existing design and features of the current 20 notes in circulation, except for the updated governor's signature. The RBI also clarified that all previously issued 20 banknotes will continue to be legal tender. Sanjay Malhotra was appointed as the RBI Governor effective December 11, 2024, for a tenure of three years.Legal tender refers to coins or banknotes that are legally accepted for the discharge of debts or obligations. According to the Banknotes are printed at four currency

# I am surprised: Sourav Ganguly shocked after Virat Kohli's Test retirement

Ganguly acknowledged the challenge, saying that it's a tough decision and believed the selectors will choose the next skipper based on their deep understanding of the team's needs and the demands of the longest format."The selectors will take decisions as per their understanding. A lot must be thought about in terms of captaincy. Longterm thinking. Many are talking about Jasprit Bumrah. There are concerns about his injury. We will have to think about everything together," he said.

Meanwhile, the Indian Premier League is back in full swing. The match between Royal Challengers Bangalore and Kolkata Knight Riders in Bengaluru was abandoned due to rain, but the spotlight is already shifting to the IPL final, scheduled for June 3. Although Eden Gardens in Kolkata was initially set to host the final, rumours are swirling that the venue may be shifted to Ahmedabad.Ganguly, however, remains optimistic about Kolkata hosting the final. "The final cannot be removed so easily! Efforts are underway to conduct the finals here by CAB. Nothing will be achieved by protesting and marching. Talks are ongoing with the board. CAB is having a great relationship with BCCI. Everything will be fine. I am optimistic, the final will be here,"

# IPL 2025: How KKR collapsed right after their title-winning season

Kolkata Knight Riders were eliminated from IPL 2025 after a rainout capped off a disappointing season marked by poor team decisions and underperformance. The franchise now faces pressure to overhaul its squad and leadership.

New Delhi. Defending champions Kolkata Knight Riders' Indian Premier League campaign was ended by rain on Saturday, May 17, at the M. Chinnaswamy Stadium. KKR, playing their 13th league stage match of the tournament, needed a win to stay alive in the competition, but it was not to be, as the rain refused to stop in Bengaluru.It felt fitting that even the gods didn't wish to see this KKR team in action-a side that made some odd decisions throughout the season. The Ajinkya Rahane-led team looked like a competition in 2024.

KKR's record of 5 wins, 6 losses, and 1 no result from 13 matches stands in stark contrast to their fortunes last season, when they won 9 and lost only 3 games. And that hasn't come as a major surprise, given how the team was set up this year.

The franchise broke up their successful opening combination of Phil Salt and Sunil Narine, who were prolific in 2024. That opening pair consistently set the pace in games, giving the lower order the cushion to occasionally fail without hurting the team.

However, with Salt gone, KKR needed their other top-order batters to step up-something that unfortunately didn't happen. The team stayed rigid with its batting order, delaying the entry of hitters like Andre Russell, Rinku Singh, and Ramandeep Singh. That lack of flexibility showed in their middling scores this season.

What didn't help was the prolonged poor form of Venkatesh Iyer, who has scored just 142 runs in 11 matches so far. Iyer, the most expensive player (?23.75 crore) in KKR's history, insisted that he didn't feel any

pressure from the price tag, but that seemed increasingly unlikely as his performances dwindled.

## The exit of Shreyas Iyer

'Shreyas Iyer was not given the credit he deserved after KKR won the IPL 2024," Time for a rejig fumed Sunil Gavaskar after the team's exit After their brilliant run in IPL 2024, KKR were from the Indian Premier League.Gavaskar criticised the narrative built around KKR's 2024 success, where most of the praise went to Gautam Gambhir. Since leaving the franchise, Iyer has led Punjab Kings to a sensational season in IPL 2025, thriving in an environment of trust and belief under Ricky Ponting. On the other hand, both

Gambhir and KKR have struggled in their respective roles."He didn't get the credit for the IPL victory last season. All the plaudits were given to someone else. It's the captain who plays a major role in what's happening in the middle, not someone sitting in the dugout. See, this year he's getting fair credit. No one is giving all the credit to Ricky Ponting," Gavaskar said on Star Sports after KKR's exit.

The reality is that before winning the Champions Trophy 2025, Gambhir's position as India coach was under threat. While that pressure has eased

for now, the same can't be said for KKR, whose decision to change leadership and appoint Ajinkya Rahane has completely backfired.

"Don't ask me, ask the VAR and the referee" Guardiola said post-match.Guardiola also shared his take on Dean Henerson wasting time whenever he recieved the ball, which

left a lot of City fans and players irritated, specificlly after conceeding the goal in the 16th minute."Listen, he defended his position, we defended our position. I understand in the last minutes, but since the first or second minutes? He's British, you know, in the English football, you have to play," Guardiola said.

# Neeraj Chopra hits 90.23: 2016 Olympic champion welcomes India athlete to 90m club



New Delhi. Former Olympic champion Thomas Rohler welcomed Neeraj Chopra to the 90m club after the Indian athlete delivered a stellar performance at the Doha Diamond League.On Friday, Neeraj crossed the 90m mark for the first time in his career, surpassing his previous best of 89.94m set at the 2022 Stockholm Diamond League.

In Doha, the 27-year-old recorded a throw of 90.23 metres, although it wasn't enough to secure the top spot. Germany's Julian Weber clinched first place with a throw of 91.06 metres.Rohler, the gold medallist at the 2016 Rio Olympics, praised Neeraj for his outstanding achievement.Rohler wrote, "Welcome to the 90m+ club."

Rohler, who won the gold medal in Rio with a throw of 90.30 metres, had previously bested Kenya's Julius Yego (88.24m) and Trinidad and Tobago's Keshorn Walcott (85.38m) at the 2016 Olympics.

Notably, Rohler's personal best came at the 2017 Doha Diamond League, where he registered an impressive 93.90 metres. He currently ranks third on the all-time list of javelin throws, behind Jan Zelezny's world record of 98.48 metres and Johannes Vetter's 97.76 metres.After Neeraj crossed the 90metre mark, Weber followed suit by breaching the milestone for the first time in his career as well, becoming the 26th athlete to do so.Reflecting on his performance in Doha, Neeraj said he will continue to push himself and aims to perform even better in upcoming events."A lot of people had this question - whether I'd be able to throw 90m or not - since I hadn't done it despite competing since 2018. I had broken 88-89m before but not 90m. But finally, not just for me, but at least for Indians, the burden has reduced. I feel I can do even better," Neeraj told Revsportz in an interview.


