Haryana court extends YouTuber Jyoti Malhotra's police remand by four days in espionage case

Hisar, May 22: A court here on Thursday extended the police remand of content creator and social media influencer Jyoti Malhotra by four days, a police spokesperson said. The 33-year-old YouTuber – arrested on suspicion of espionage - was produced before the court at the end of her five-day police remand. Malhotra was among the 12 people arrested from Punjab, Haryana and Uttar Pradesh over the past two weeks on suspicion of espionage, with investigators suspecting the presence of a Pakistan-linked spy network operating in north India. The Hisar native ran a YouTube channel "Travel with JO". She was arrested at the New Aggarsain Extension last week and booked under provisions of the Official Secrets Act and the Bharatiya Nyaya Sanhita. Hisar police said on Wednesday that no evidence had emerged to indicate Malhotra had access to any military- or defence-related information. But she was definitely in contact with some people, knowing that they were Pakistani intelligence operatives, they had said. Police sources had said she was in touch with Ehsan-ur-Rahim alias Danish, a staffer at the Pakistani High Commission, since November 2023.

and a university, including Siddhartha Institute of Technology and Siddhartha Medical College, seeking financial records from the past five years. He said he has instructed his staff to cooperate and provide all necessary information to the ED. "As a person who believes in the law of the land, I am prepared to cooperate with whatever comes out of their verifica-

tions or searches," he said. To a query on allegations that Rs 40 lakh from his institution's account was used to pay Ranya Rao's credit card bill, Parameshwara declined to comment, saying he would respond after the investigation is complete. He also refrained from commenting on speculation that he was targeted due to his Dalit background, and said he would address it if necessary in the future.


Huge effort is underway to build modern infrastructure for developed India: PM Modi

Punjab CM Mann opposes Centre's move to deploy CISF personnel at Nangal dam

Chandigarh, May 22: Punjab Chief Minister Bhagwant Mann on Thursday condemned the Centre's move to deploy a contingent of 296 CISF personnel to secure the Nangal dam. Questioning the Union government's move, Mann asked what was the need to deploy CISF personnel when Punjab Police was already providing security to the dam. The chief minister also said that he will raise the issue with Prime Minister Narendra Modi at the Niti Aayog meeting scheduled for Saturday. The Centre has sanctioned a contingent of 296 CISF personnel to provide a counter-terrorist security cover to the Nangal dam amid



the standoff between Punjab and Haryana over sharing of water from the dam. The Bhakra Beas Management Board (BBMB) has been asked to make a security deposit of Rs 8,58,69,600 in favour of the CISF for the 296 personnel. Addressing the media in Sangrur on Thursday, Mann said the deployment of CISF personnel will cost Rs 8.58 crore per annum, showing a copy of the Centre's letter in this regard. "They say either the BBMB or Punjab will pay this money. What was the need for this when Punjab Police was already providing security to the dam for free? Why should we give money," Mann asked. "I will strongly oppose this move. We will neither allow money to be given through the BBMB nor from the state exchequer of the Punjab government," he added. Questioning the intention of the Centre for deploying security cover, Mann asked whether it wanted to "steal" Punjab's share of water. "We will not allow this," he asserted. Mann also asked BJP leaders, including Punjab BJP chief Sunil Jakhar, if the Centre's latest move came with their approval. "The Centre must withdraw this decision. The dam falls in Punjab's jurisdiction. If Punjab can protect the international border, why can't it protect the dam," the chief minister asked. Replying to a question, Mann said he will raise the issue with the prime minister at the Niti Aayog meeting on Saturday, and ask Modi if he thought Punjab Police was incapable (of providing security to the dam).

The other persons named in the chargesheet included the then Chenab Valley Power Projects Pvt Ltd (CVPPPL) managing director M S Babu, its directors Arun Kumar Mishra and M K Mittal, managing director of construction firm Patel Engineering Ltd Rupen Patel and private person Kanwaljeet Singh Duggal, the officials said. Existing cowsheds to be expanded: Delhi CM

New Delhi, May 22: Delhi Chief Minister Rekha Gupta met dairy owners on Wednesday and assured them that the existing cowsheds ('gaushalas') will be expanded and new ones will be established. She held a high-level meeting at the Delhi Secretariat with representatives of all authorised dairies, gaushala representatives and senior officials of the Municipal Corporation of Delhi (MCD) and the Animal Husbandry Department, an official statement said. The meeting focused on reviewing the current state of gaushalas operating in the capital, the growing issue of stray cattle, and the dire condition of authorised dairy colonies, with an aim to ensure quick and effective solutions, it added. Expressing concern over the rising presence of stray cows on

Delhi's roads, she alleged that this is the result of years of negligence and false promises by the previous government. "We are focusing on both citizen safety and animal welfare by ensuring proper management, shelter, and care. It is

also our moral responsibility to ensure that animals shifted from the streets to gaushalas receive the care they deserve," she added. The statement said comprehensive steps are being

taken to ensure proper sanitation, fodder, medical care and shelter for animals. She said a budget of Rs 40 crore has been allocated for the establishment of a state-of-the-art 'Model Gaushala' in Delhi. This gaushala will be equipped with modern facilities for cow protection, dairy production and veterinary care. Gupta announced that considering the current situation, the government will now work on a

concrete action plan to find a permanent solution. She stated that Wednesday's meeting concluded with the decision to equip all authorised dairies with basic infrastructure such as drinking water, drainage, sanitation and sewage systems. It will also be ensured that no cow or animal roams the streets and that all animals are kept in a safe, clean and conducive environment, the statement said. In addition, the existing gaushalas will be expanded and new ones will be established, the statement added. She explained that these dairies do not even have access to drinking water or any other water source. There are no 'gobar' (cowdung) gas plants, drains, sewage systems or sanitation facilities, she

claimed. After the meeting, minister Kapil Mishra said now dairies will receive basic amenities, gaushalas will be expanded and the government will ensure that not a single cow is seen abandoned on the streets.

Prime Minister Narendra Modi has sent a message, not only to our difficult neighbours but to the entire global community, that terrorism will not just not be tolerated but going beyond it terrorists will be punished," the Vice President said. "Wherever they (terrorists) are located, they will be hunted down. Operation Sindoor was needed and it continues. We must salute the vision of our Prime Minister for having accomplished it," he said. The world has acknowledged the might of the Indian armed forces because dur-

ing Operation Sindoor as the targeting was precise, calculated and calibrated. There was no dissent on the impact of the operation, he asserted. "No one asked for proof because when coffins were taken, the (Pakistani) Army was present, terrorists were present, (Pak) government was present.

Don't hold local body polls without delimitation: Madras

MADURAI. The vacation bench of the Madurai Bench on Wednesday directed the government and state election commission not to conduct local body elections in nine districts without completing delimitation and the process required for announcing reservation. A bench of justices S Srimathy and R Vijayakumar gave the interim direction on a PIL petition filed by K Shunmuganathan of Tirunelveli.

The petitioner said that on May 5, the state election commission had published electoral rolls for nine districts where elections would be held. The previous local body elections in TN was conducted based on the 2011 census.

When it was pointed out by the Madras High Court in a similar case last year that the state had undergone drastic changes in population and other factors, the government had given an undertaking that it would not conduct elections without completing the delimitation and the process required for finalising ward reservations.

However, authorities have now initiated the election process without fulfilling the undertaking, the petitioner said adding, the poll rolls for several wards did not even have photographs of voters, which could pave way for impersonation. Also, some of the vacancies have not been included for the election, he added, suspecting ulterior motive behind it. Considering the submissions, the judges gave the interim direction, issued notice to authorities concerned and adjourned the case for a

A wild elephant attack in Malakkapara, in the Athirapilly panchayat of Thrissur, claimed another life on Thursday, as an elderly woman became the latest victim of the ongoing wild animal attacks in Kerala. With this, the total number of deaths in wild animal attack in Kerala this year has risen to 27 in the state.Mary, 67, was found dead near her house. As per the local sources, Mary and her daughter were living in a house near the left canal of Sholayar dam in Malakkapara, Valparai region. At around 1 am on Thursday, Mary came out of her house hearing noises. The wild jumbo was moving so close to her house that she was attacked when ventured out of the house.

The region has been reporting the presence of wild elephants frequently with some even attacking at forest vehicles as well.

Two IITH professors elected as Fellows of Royal Society



HYDERABAD. Two professors from the Indian Institute of Technology, Hyderabad (IITH) - Chennupati Jagadish and Dr Mallikarjun Tatipamula — have been elected as Fellows of the Royal Society (FRS), one of the most prestigious scientific honours globally. The FRS is a prestigious title awarded to individuals who have made a substantial contribution to the improvement of natural knowledge, including mathematics, engineering science and medical science.

Both the honorees trace their roots to India and maintain close academic ties with IITH. A Distinguished Professor Emeritus at the Australian National University, Prof Jagadish is renowned for his pioneering work in semiconductor nanotechnology, photonics, and optoelectronics.

He was born in a small village, Vallurupalem, in AP and grew up in a smaller village, Arekayalapadu, Telangana and obtained his BSc Physics from ANU-Guntur, MSc (Tech) Appl Physics from AU and MPhil and PhD in Physics from Delhi University. He is currently serving as Distinguished Professor Emeritus of Physics and Electronic Materials Engineering at the Australian National University.

A global technology leader and CTO at Ericsson, Dr Mallikarjun Tatipamula has played a transformative role in the development of 5G and next-generation networks. Born in Warangal, Telangana, Dr Mallik is a globally respected leader in telecommunications. He holds a BTech from NIT Warangal, an MTech from IIT Madras,

and a PhD from the University of Tokyo. Prof Jagadish said: "First and foremost, it is a real pleasure for me to be associated with IIT Hyderabad. I am humbled to be elected a Fellow of the Royal Society, among giants

like Newton, Einstein, and Sir CV Raman". Dr Mallikarjun Tatipamula said: "It is a great honour. But for me, this moment is not just about recognition - it is a reminder of what is possible when passion meets purpose.'

Siruvani Dam leakage yet to be plugged even as monsoon nears

just days away, concerns are mounting over the delay in initiating critical repair works at the Siruvani Dam - one of the primary sources of drinking water for Coimbatore city.


The Coimbatore City Municipal Corporation (CCMC) has been waiting for the Kerala Water

Resources and Irrigation Department to finalise cost estimates for essential repairs, based on a recent report by dam safety experts. To address increasing seepage from the dam, a joint inspection was conducted on January 8 by five teams comprising officials from the Pune-based Central Water and Power Research Station (CWPRS), Tamil Nadu Water Supply and Drainage (TWAD) Board, Indian Institute of Technology, Madras (IIT-M), CCMC, and the Kerala State Government's Water Resources Department. The teams carried

out a detailed assessment of the dam's condition and highlighted urgent structural interventions.

The CWPRS team has since submitted a comprehensive report to CCMC Commissioner M Sivaguru Prabakaran, outlining the extent of the damage and suggesting remedial measures to arrest the leakage and improve overall dam safety.

The Pune team has suggested two methods grouting and geo membrane for fixing the issues in the dam. Due to water seepage, around 10 MLD of water is being wasted every single



day. This quantity can be used to supply water for three days to residential areas in the city. And once the issues are addressed, around 50 to 55 MLD of water can be saved during the peak summer season which would be of great use for the people. Speaking to , CCMC Commissioner M Sivaguru Prabakaran stated that the Kerala Water Resources and Irrigation Department is in the process of preparing a detailed estimate for the repair works. "Once the estimation is submitted, the Tamil Nadu government will allocate the necessary funds, and the work will be executed by the Kerala government," he

Visakhapatnam Central Jail faces severe overcrowding amid surge in ganja smuggling cases

VISAKHAPATNAM. Visakhapatnam Central Jail has the largest number of overcrowded prisoners in Andhra Pradesh and is facing overcrowding challenges. A large number of blocks in the prison have been occupied by smugglers who were caught while trying to transport ganja from various parts of North AP. Speaking to TNIE, Superintendent of Visakhapatnam Central Prison (SCP) M Mahesh Babu emphasised that the Visakhapatnam Central Jail facility was designed to accommodate 900 inmates, including 80 female prisoners. The jail has around 1,830 prisoners, far exceeding its capacity. Among the inmates, 1,548 are on remand, and the number of female prisoners has slightly increased to 82.

At present, there are 185 male lifers and no female lifers in the jail. Around 1,000 prisoners have been booked under the NDPS Act, specifically for ganja-related cases, Mahesh Babu added. He stated that over the past few months, as many as 200 first-time offenders have been in the jail, highlighting an increase in crime reporting and legal actions.

As a temporary relief measure, 175 prisoners have been transferred to Rajahmundry Central Prison, he added. He said, "Around 60% of prisoners are below the age of 32, raising concerns about the growing involvement of young individuals in criminal activities.'

He mentioned that around 300 prisoners from other states were also present, in the past few years, bail for ganja-related cases was typically granted after one month, but currently, with the full implementation of the relevant Acts, the process now takes between one to six months, depending on the severity of the crime.Strict measures have been enforced to minimize the illegal transportation of ganja. Mahesh emphasised that strict security measures and thorough checks have been implemented within the jail premises, with regular inspections being conducted to

KPSC graft: Karnataka government could proceed to seek sanction to prosecute officials

BENGALURU. The cabinet is expected to discuss the long-pending issue of irregularities in the KPSC at its meeting on Thursday. Charges relate to allegations of large-scale malpractice in recruitments in 2011, which triggered widespread protests at that time. Sources said the cabinet will review the findings of a CID probe that established the involvement of then KPSC

chairman and members in the alleged irregularities. The CID named former KPSC chairman Gonal Bheemappa and member Mangala Sreedhar, along with others who were part of the commission during the controversial recruitments.

The CID's report is said to have provided evidence of procedural violations and possible manipulation in the selection process. But as KPSC functionaries hold constitutional positions, any legal proceedings against them will require prior sanction from constitutional authorities -- the governor and, in some cases, the President of India. Sources said

the cabinet will on Thursday look at CID's recommendations and observations. If the cabinet approves further action in the case, the state government could formally seek permission from constitutional authorities to proceed with the prosecution of officials. Officials familiar with the case said irregularities in 2011 recruitments came to light in 2013 and over 382

> appointments were under a cloud. The revelations put a halt to recruitments and the unofficial freeze continued till 2019, when the BJP government cleared the appointments in 2022.

Many selected candidates have since started working in various departments. If the cabinet decides to reopen the case that has remained dormant for over a decade, it would have significant legal and political implications. While the government is expected to proceed cautiously, because of the sensitivity of the issue, Thursday's cabinet meeting is likely to set the course for further action in the long-running controversy.

The exclusion of the faculty-student ratio and intern stipend as criteria for ranking medical colleges has triggered criticism, with many alleging that the new framework compromises both educational standards and student welfare.

Students' Unions and faculty associations are now calling for the rollback of the new draft and demanding wider consultations across the country.

Doctors and faculty members argue that an adequate faculty ratio is fundamental to maintaining quality in medical education. Without a sufficient number of trained teachers, medical students are likely to receive subpar clinical training, which can ultimately impact patient care.

'Faculty-student ratio is not just a metric, it's the backbone of medical education. Ignoring it in assessment is a disservice to the future of from Nellore, told.

Defunct for year, motors fixed 2 hours before minister's visit in Gurgaon

Gurgaon. MCG officials turned an adage — where there's a will, there's a way — on its head. Since a Haryana minister was on the way, they developed the will to fix things delayed for a year. In a telling example of administrative apathy and sudden efficiency, a year-long delay in providing electricity to rainwater-lifting motors at Gulmohar Park in Sector 15 was mysteriously resolved just two hours before Union minister Rao Inderjit Singh's scheduled visit on Wednesday.

Speaking to the media during the visit, locals sarcastically remarked the minister should consider visiting the area more often. "Only when senior officials and ministers come do things actually move. The park is cleaned, water problems are addressed and the system seems to function," a Sector 15 resident said. Interestingly, besides the power connection, residents noted the park was "freshly cleaned and the surrounding area beautified" just before the minister's visit, suggesting the transformation was more for "optics" than sustainable urban management. The motors were part of a rainwater management system implemented by MCG to tackle waterlogging in the area during the monsoon. While the underground tank and pipelines to lift rainwater into the master drainage line were installed seven months ago, the motors remained non-functional due to the absence of an electricity connection — a detail conveniently overlooked by the authorities. Residents revealed the project to resolve waterlogging began three years ago after a direct appeal to the minister. Despite the infrastructure being laid down, the essential electricity connection remained pending for over a year. It wasn't until news of the minister's inspection visit that MCG officials hurriedly connected the power supply — just two hours before his arrival.

Fraudster impersonates Army officer & cheats over 100 people, held in Gurgaon

Gurgaon. A cyber con was arrested for posing as an Army officer on social media platforms and luring people on the pretense of selling old motorcycles and vehicles. The accused has reportedly conned over 100 people using, police said. Mubahid alias Wahid, a native of Lakhnaka village of Palwal district, lives in Rajeev Nagar in the city.He had created multiple user IDs using fake names and posted sale advertisements of old motorcycles. He also kept track of other users posting advertisements to sell their motorcycles. Once he identified a victim, he would comment on their post or obtain their phone number. He would then contact them and claim to be the owner of the vehicle. Posing as an Army officer, he would claim that he was being transferred to another location and needed to sell his bike. He lured buyers with attractive offers and convinced them to transfer money for bike delivery. After receiving the payment, he would cut off all contact."The accused confessed to committing over 100 such frauds across different regions, including three cases specifically in Gurgaon. A case has been registered under relevant sections at the cyber crime police station (East), Gurgaon, and the accused was arrested on Wednesday," a senior police official said.

The police recovered two mobile phones used in the crime. He will be presented before a local court and taken into police custody for further interrogation. The police will continue their investigation based on the information extracted during remand. Further legal proceedings are

Noida reclaims Rs 45cr govt land from squatters

Noida. During an anti-encroachment drive on Wednesday, officials cleared five hectares of land worth around Rs 45 crore in Kasna. A day prior, a fiveacre plot of land was freed from encroachment in Dadri's Dhoom Manikpur area. The encroached land in Kasna belonged to the irrigation department, and had been under illegal occupation for over two decades.



An unauthorised colony had come up on the plot, with several houses constructed, officials said.

'Over the last 10 years, the irrigation department sent several notices to the residents of the colony to vacate the area as it belonged to govt. When the residents did not budge, the district administration started a survey of the area two years back, and on Wednesday, the demolition action was done," SDM Sadar Charul Yadav, who led the operation, told TOI.

No FIR has been registered in the case so far, she added. Officials said that previous attempts to clear the land were stalled due to local resistance. This time, however, the administration deployed heavy police force to ensure the operation went ahead without disruption. Four excavators were used to raze illegal constructions on the land, and around 120 personnel from Kasna police station and nearby areas, along with a company of the Provincial Armed Constabulary

(PAC), were deployed to maintain law and order. A day prior, officials freed five acres of notified land in Dhoom Manikpur village in Dadri. A team of revenue officials demolished boundary walls of over 30 plots using bulldozers. An FIR will be filed soon, officials

Israel says missile fired by Yemen's Houthis downed after sirens spark panic

Tel Aviv.The Israeli military said it intercepted a missile launched from Yemen targeting Israel early on Thursday, in the latest attack bearing the hallmarks of Yemen's Houthi militants. The missile triggered sirens in several areas of central Israel, the military said in a statement. Undeterred by Israeli strikes on Yemen, the Houthis have continued to fire missiles at Israel in what they describe as an act of solidarity with Palestinians in Gaza, although they have agreed to halt attacks on US ships. The group has not claimed responsibility for Thursday's launch.Israel has carried out retaliatory strikes, including one on May 6 that damaged Yemen's main airport in Sanaa, and another last week targeting the Red Sea ports of Hodeidah and Salif. Since the start of the Israel-Hamas war in October 2023, the Houthis have launched dozens of missile and drone attacks targeting Israel, most of which have been intercepted or have fallen short.

China's 650-Year-Old Fengyang Drum Tower Collapses

world. A centuries-old Fengyang Drum Tower in China collapsed partially on Monday, forcing tourists to scramble for safety. Hundreds of roof tiles fell from the 650-year-old drum tower in Anhui. A video of the moment portions of the tower came crashing down has gone viral on social media. It shows a cloud of brown dust enveloping the area near the tourist site.Debris rained down near visitors exploring the area, creating chaos and compelling people to run for cover.One of the eyewitnesses told Yangcheng Evening News, "The tile falling lasted for a minute or two." Another witness told the Beijing News, "There was no one in the square and no one was injured; if it happened a little later, there would be many children playing (near the tower) after dinner."

The structure was first built in 1375 during the Ming Dynasty. A part of the building was ruined in 1853 during the Qing Dynasty and was rebuilt 150 years later in 1995. In 2023, a restoration project was launched. It was wrapped up in March 2024.

The roof, which suffered a partial collapse, was built a year ago. Social media users expressed shock and concern over the poor construction quality. One person commented, "Modern restoration construction compared to something built 650 years ago."

Under questioning by his lawyer, Albor insisted that his top priority was protecting about 300 dolphins and other animals that are the main attractions at the parks and also serve as collateral for the lenders.

Washington."Turn the lights down," President Donald Trump said. It was showtime in the Oval Office.

Sitting next to him was South African President Cyril Ramaphosa, who was visiting in hopes of reaching new agreements on trade. But Trump wanted to talk about baseless allegations that white farmers in his country were being systematically singled out for persecution and murder.He directed everyone's attention to a television that had been wheeled into the room, and a video began to play.

Even for a president who has transformed the Oval Office from a diplomatic venue into a gladiatorial arena, it was an extraordinary scene. Trump stared at the screen while Ramaphosa looked away. For roughly four minutes, the video showed Black politicians - none part of Ramaphosa's government or political party - using anti-apartheid chants about attacking white South Africans.

The politicians have said their comments aren't meant to be taken literally; conservative media use them to advance widely rejected claims that there's a genocide underway in South Africa. The video ended with footage of rows of white crosses, which Trump said represented white farmers."It's a terrible sight. I've never seen anything like it," he said.

Ramaphosa sounded skeptical."I'd like to know where that is," he said. "Because this I've never seen."

The confrontation echoed Trump's explosive meeting in the Oval Office with Ukrainian President Volodymyr Zelenskyy almost three months ago, but this one did not devolve into acrimony. While Zelenskyy and Trump ended up arguing in full view of the news media, what unfolded on Wednesday was a delicate dance between two leaders who had clearly prepared for the encounter. Trump had more than just the video. He also shuffled through a stack of papers that he said were printouts of reports about attacks on white farmers.

Mahmoud Khalil denied chance to hold his newborn baby, family says


world. Mahmoud Khalil, a Columbia University graduate and Palestinian activist, was not allowed to hold his newborn son during a recent visit, according to his legal team. Khalil, who was detained by Immigration and Customs Enforcement (ICE) since March, met his baby for the first time behind a glass partition.

His wife, Noor Abdalla, flew from New York to the Louisiana detention centre with their one-month-old infant, hoping for a contact visit. ICE and the private company operating the facility denied the request. Officials claimed a no-contact visit policy and imprecise "security concerns" for the denial, his lawyers say. Noor, who is a US citizen, said "After flying over a thousand miles to Louisiana with our newborn son, his very first flight, all so his father could finally hold him in his arms, ICE has denied us even this most basic human right." "This is not just heartless. It is deliberate violence, the calculated cruelty of a government that tears families apart without remorse," she added.

India To Host Event At UN To Mark International Tea Day

United Nations. The aromas and flavors of popular Indian teas permeated the halls of the United Nations headquarters as India hosted a special event to commemorate International Tea Day to highlight the beverage's contribution in empowering communities and fostering inclusive economic growth.The Permanent Mission of India to the UN hosted the high-level event Wednesday on the theme 'Tea for Livelihoods, Tea for SDGs' to mark the International Tea Day, a celebration of the world's most consumed drink, after water.

The event concluded with a special curated tea tasting experience where guests enjoyed a variety of Indian teas, including the famous Darjeeling tea, Masala chai, Assam and Nilgiri teas.

India's Permanent Representative to the UN Ambassador Parvathaneni Harish, Director of the FAO UN Liaison Office in New York Angelica Jacome, and representatives of Kenya, Sri Lanka,

and China, the other major teaproducing countries, spoke on the occasion and highlighted the challenges faced by the tea growers, especially the small tea farmers.

The story of tea in India is not merely one of trade and taste but also one of transformation. What began in the early 19th century from the misty hills of Assam to the slopes of Darjeeling and Nilgiris, India's tea industry has grown to become a cornerstone of rural employment, women's empowerment and export-led development," Harish said at the houseful event attended by UN envoys, senior UN personnel and community members.

The UN General Assembly had in 2019 proclaimed May 21 as International Tea Day following a proposal moved by India at the Food and Agriculture Organisation's (FAO) Intergovernmental Group (IGG) on Tea in October 2015. The UNGA resolution recognised the long history and the

cultural and economic significance of tea around the world, as well as the significant role it plays in rural development, poverty reduction and food security in developing countries.India is one of the largest producers and consumers of tea globally and the sector directly employs over 1.5 million workers, the majority of whom are women. It supports over 10 million livelihoods, including small landholder farmers and those engaged in allied industries.

"For many of these communities, tea is not merely a crop. It's a way of life, a source of dignity, opportunity and hope," Harish said.He also pointed out the complex challenges faced by the tea industry. "Climate change is disrupting growing conditions and then, there are rising input costs," Harish said, adding that market volatility and structural inequities threaten the economic viability of small producers who are responsible for over 60 per cent of global tea production.

Seoul. A serious accident occurred on Wednesday during the launch of a new North Korean warship while Kim Jong Un was attending the event, with the isolated state's leader calling it a "criminal act" that could not be tolerated, state media KCNA reported.

Mr Kim, who witnessed the failed launch of the 5,000-ton destroyer, excoriated the accident as caused by "carelessness" that tarnished the country's dignity, and ordered the ship to be restored before a key ruling party meeting in June, KCNA said on Thursday. The report did not mention whether there were any casualties.

KCNA said the incident at the northeastern

Enjoy mangoes with a pinch of caution: Doctors

GUNTUR. As the mango season reaches its peak, markets across the district are filled with bright, yellow mangoes, attracting eager buyers. However, health experts are urging caution, highlighting concerns that some of these fruits may have been ripened through artificial means, compromising both quality and safety.Popular mango varieties such as Rasalu and Banganapalli are often harvested before reaching full maturity and subjected to ripening techniques that may not meet food safety standards. Though natural ripening remains the preferred method, some traders resort to chemical alternatives to meet market demand quickly. Calcium carbide, a substance known to release acetylene gas when exposed to moisture, is used in some instances for accelerating the ripening process. While the use of this chemical is restricted under food safety laws, officials acknowledge that improper ripening practices still occur in certain pockets. A renowned physician in Guntur, Dr Kavitha, explained the effects of this chemical to, saying, "Fruits treated with calcium carbide can ripen externally within a day or two, but often remain underdeveloped

Bharathiar University has directed all its affiliated colleges to hold Tamil classes six hours weekly for secondyear undergraduate students in the upcoming academic year.University Registrar Rupa Gunaseelan sent a letter regarding this to all affiliated arts and science colleges located in Coimbatore, Tiruppur, Erode, and Nilgiris districts. Professors from the Tamil Department welcomed this move.

Earlier, teaching staff from the Tamil departments of private colleges had submitted a petition requesting that six hours weekly be ensured for Tamil classes.

An assistant professor of the Tamil department in a private college in Coimbatore city told TNIE that state-run universities introduced Tamil classes for second-year students in the 2023-24 academic year."Bharathiar University introduced Tamil in undergraduate courses of B.Com and B.Sc Computer Science in the second year in its affiliated colleges. As per the higher education department's direction, six hours should be allocated for Tamil for second-year students. But the university allocated only four hours with the approval of the Board of Studies, and the remaining two hours were used for Naan Mudhalvan skill courses. Due to this, the teaching faculty were unable to complete the portions for second-year students," he recalled.

"The university has now allocated six hours for second-year Tamil classes by giving necessary instructions to the colleges," he said, citing the request of teachers. Sources say colleges have been asked to conduct skill courses during evening hours as per each college's schedule.

Blow to Tamil Nadu government as Madras HC orders interim stay on 10 Acts

Ten amendment Acts came into force on April 11 after the Supreme Court, in its April 8 verdict, granted deemed assent to bills delayed by Tamil Nadu Governor R N Ravi.

CHENNALThe Madras High Court on Wednesday temporarily stayed the operation of the 10 amendment Acts covering various state-run universities, which transferred the powers to appoint vice-chancellors from the governorchancellor to the Tamil Nadu government.A vacation bench of justices G R Swaminathan and V Lakshminarayanan granted the interim stay despite strong objections raised by the state government and the higher education department against passing any interim orders without hearing them in

detail as the issue is related to the constitutionality of the legislations. These 10 amendment Acts were notified and came into force on April 11, after the Supreme Court granted deemed assent to the bills in its landmark verdict on April 8 in the case filed by Tamil Nadu government against Governor R N Ravi for delaying assent to the bills.A BJP-affiliated advocate K Venkatachalapathy alias



Kutty of Tirunelveli district moved the HC praying for staying the operation of the Acts. Senior counsel Dama Seshadri Naidu, assisted by V R Shanmuganathan, represented the petitioner and argued that the Acts are repugnant to Regulation 7.3 of the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges, 2018, regarding appointment of vice-chancellors.

'TN will move SC against interim stay'

The counsel further stated that education should not fall in the hands of people with political interest, instead, it should be in the hands of apolitical persons. Advocate General P S Raman, representing the state government, and senior counsel P Wilson, appearing for the higher education department, questioned the urgency to take up such matters, which involve constitutionality of the amendment acts that are plenary legislations adopted by the state legislature. They noted that the

amendments acts have come into effect through the judicial order of the SC where the same grounds of repugnancy were raised but were brushed aside by the court. They submitted that the amended acts provide for taking the powers to appoint V-Cs away from the governorchancellor and not removing the post of chancellor. Further, they noted the petitions have not challenged the constitution.

Karnataka hands over four kumki elephants to Andhra Pradesh

BENGALURU. Karnataka handed over four partially trained (kumki) elephants to Andhra Pradesh at a grand ceremony at the Vidhana Soudha on Wednesday. Two more elephants will be given to AP in the coming days. The elephants were handpicked, based on their behaviour and skills, by a team of officials from Karnataka and AP. The bulls, their mahouts and kawadis were sent to a special camp in Chittoor in Andhra Pradesh for

The mahouts and kawadis will train their counterparts in AP.Forest, Environment and Ecology Minister Eshwar B Khandre said the elephants were sent to AP to support that state's efforts to conserve and mitigate manelephant conflict. "I had meetings with AP Deputy Chief Minister and Forest Minister Pawan Kalyan in August and September last. As per an MoU, we decided to hand over the elephants as gifts to AP," Khandre said.

As per the MoU, AP has to give Karnataka regular reports on the elephants' health and their upkeep. A senior forest official said,



"Karnataka is sending elephants to another state after a gap of two years." From 2016, Karnataka sent over 65 elephants to Uttarakhand, Jharkhand, Uttar Pradesh, the last state to receive three elephants.

'We have over 100 elephants in our camps. The six elephants given to AP are from Kodagu's Dubare elephant camp, which houses 35. We capture the elephants in conflict and train them. The space to house such elephants is getting reduced. We are ready to send trained elephants to other states if they are keen on taking care of them," the official said. Kalyan said, "We did not expect Karnataka to give us

They will be used to capture the elephants in conflict in Kupam and Palakundalam regions. I promise Karnataka that we will take good care of the elephants, and if anything goes wrong, you can take action against us."Two months ago, Karnataka organised a training camp in which around 25 mahouts from AP participated. Deputy Chief Minister DK Shivakumar said, 'Karnataka has many trained elephants which can be given to other states to help mitigate

man-elephant conflict." Madhya Pradesh and Bihar. Maharashtra was Chief Minister Siddaramaiah said conflict mitigation is not just the task of the forest department. People of Karnataka and its neighbouring states, which share reserve forests, should support it.

Monsoon onset expected in three to four days in Kerala, says IMD

THIRUVANANTHAPURAM.

The India Meteorological Department (IMD) has announced that the Southwest Monsoon has progressed further, with its onset expected in the next 3-4 days. If the monsoon sets in between May 23 and 27, it will be the earliest onset in the past 15 years. The last time it arrived this early was in 2009, when the onset was recorded on May 23.

The monsoon winds, which usually reach Sri Lanka by May 26, have already entered the Comorin region, suggesting an early arrival in Kerala. The IMD had declared the monsoon's onset over the Andaman and Nicobar Islands on May 13 - 10 days ahead of schedule. "The westerly wind pattern has set in along the Kerala coast in the Arabian Sea. The state is likely to receive monsoon rain by May 23 or 24," said Rajeevan Erikkulam, a meteorologist with the Kerala State Disaster Management Authority.

Even when monsoon rain starts, IMD follows a set of criteria before declaring the onset. It includes rainfall over 60% of 14 designated stations, the presence of westerly winds up to 600 hPa depth, and satellite data showing strong atmospheric convection via Outgoing Longwave Radiation.

Strong westerly and northwesterly winds are expected to persist over Kerala for the next seven days. The Met department has forecast heavy to very heavy rainfall across the state between May 23 and 27.

IMD issues orange alert in four dists

Northern districts continue to experience heavy rain due to the influence of an upper air cyclonic circulation off the North Karnataka-Goa coasts. The IMD has also predicted the formation of a low-pressure area by Thursday, which is expected to move northward and intensify into a depression within the next 36 hours.

It stated that the rain will be more evenly distributed across the state

Andhra's Jiyyannapeta mourns death of techie-turned-Maoist leader Kesava Rao

SRIKAKULAM. A pall of gloom descended over the hometown of Maoist leader Namballa Kesava Rao, alias Basava Raju, after he died in a firefight with security forces BENGALURU. Farmers of in an encounter in the dense forests of Abhujmad on the trijunction of Narayanpur-Bijapur-Dantewada districts, Chhattisgarh.Srikakulam SP K V Maheswara Reddy confirmed the Maoist party general secretary's demise to TNIE, citing official reports from security forces on Wednesday.Born in 1955 in Jiyyannapeta near NH-16, Kesava Rao was the second son of Vasudeva Rao, a late government teacher, and Lakshmi Narayanamma. He is survived by his elder brother, Dhilleswara Rao, a former kabaddi player and retired Port Blair sea port chairman, and younger brother, Ram Prasad, a Visakhapatnam-based real estate businessman, and one of his two sisters.

Kesava Rao, a skilled kabaddi and volleyball player, completed his B Tech at the Regional Engineering College, Warangal. While pursuing his M Tech, he joined the People's War Group (PWG) in 1976 at the age of 21, drawn to the ideologies of leaders like Kondapalli Seetharamayya and K G Satyamurthy, and influenced by Srikakulam's antilandlord movement.

After joining the PWG, which later became the Maoist party, Kesava Rao cut ties with his village and family, and remained unmarried.

He carried Rs 1.5 cr bounty on his head

Known for expertise in IED explosions, Kesava Rao, who carried a bounty of Rs 1.5 crore, was implicated in the 2003 attack on CM N Chandrababu Naidu at Alipiri in Tirupati, as well as the 2010 Dantewada attack, which killed 76 CRPF



Kerala CM's backing for control of wildlife numbers stirs row

.Church, farmers welcome suggestion; activists call for scientific justification and legal scrutiny

KOCHI. At a time when the state is witnessing a spike in wild animal attacks, which have claimed 26 lives this year, Chief Minister Pinarayi Vijayan's statement advocating controlled culling of wild pigs has ignited a debate on balancing human development with wildlife conservation. While the Church and farmers have welcomed the CM's suggestion on controlled culling, conservation activists are demanding a moratorium on any policy proposal involving wildlife hunting or population control unless preceded by rigorous scientific justification and full legal scrutiny. Animal rights activists are demanding steps to restore wildlife habitats by converting forest plantations into natural forest and raising barriers to stop wild animals from entering human habitations. Welcoming the CM's statement, Thalassery archbishop Joseph Pamplany said it vindicates the Church stand."Wild pigs, peacock and monkeys are proliferating at an alarming rate, and they have



spread from forest fringes to the midlands. These animals are destroying crops and denying farmers' livelihood. So we have demanded that the government order controlled culling to limit their population. The population of elephants and tigers has increased threefold. We don't demand indiscriminate killing. But the government should control the population based on the carrying capacity of forests. Tigers and elephants should be tranquilised and shifted to other reserve forests. Elephant walls and trenches should be made to stop wild animals from entering human habitations," he said.

'The forest department has been focusing on protection of wild animals, which has led to their proliferation.

But the rise in the wild animal population has affected the lives and livelihoods of farmers. There should be a balance and we favour culling to control the wildlife population," said Kerala Catholic Bishops' Council (KCBC) deputy secretary general Fr Thomas

We have been demanding allowing hunting to control the population of wild animals. Without putting the blame on the Union government, the state government should take the initiative to protect farmers. Section 11 (2) of the Wildlife Protection Act says killing wild animals in selfdefence is not a crime.

The inside story of merger of Sikkim with India

Within a few years of its creation in 1968, India's external intelligence agency - the Research and Analysis Wing (R&AW) - played a decisive role in two major operations that reshaped the region's map. The first was its covert support during the liberation of Bangladesh in 1971. The second, less discussed but no less consequential, was the

merger of Sikkim with India in May 1975. At the time of India's independence, 565 of the 600 princely states joined the Indian Union through bilateral Instruments of Accession. Sikkim, also a member of the Chamber of Princes and the Constituent Assembly, remained outside this process. Sardar Patel wanted Sikkim to accede, but Nehru disagreed. Ultimately, the December 1950 treaty gave Sikkim protectorate status - India would handle its external affairs, defence, communications, currency and posts.In 1947, smaller Sikkimese parties that supported merger, joined the Sikkim State Congress (SSC), led by Tashi Tshering. They wanted an end to absentee landlordism, a representative government and eventual accession to India. Tshering met Nehru twice, in 1948 and 1949. While Nehru was sympathetic to the first two demands, he rejected outright the merger, saying that Sikkim should evolve "according to its own genius." On May 1, 1949, Tshering led 5,000 people to the palace gates, demanding reform. The Maharaja fled to the Political Office. But with Indian support, the monarchy regained control, and the prodemocracy movement was sidelined. India's policy was what I called "an apparent appeasement towards the Maharaja and cautious containment of pro-accession forces."Electoral reforms introduced by the Maharaja in 1953 failed to satisfy public demands. A "parity system" was introduced to balance representation between the majority Nepalese (75 per cent) and the minority Bhutia-Lepcha (25 per cent) populations, but combined with nomination quotas, it ensured promonarchy outcomes. By the 1960s, new personalities were reshaping Sikkim's politics. In 1958, LD Kazi married Eliza Maria Lanford Rai, a charismatic figure who played an influential role in his party. In 1963, Rajkumar Palden Thondup Namgyal married Hope Cooke, a young American who dreamed of being queen of a Himalayan kingdom. Thondup used the marriage to draw international attention to Sikkim's cause

Following his father's death in 1963, Thondup became the 12th Chogyal - 'Dharam Raja' - a title officially recognised by India at his coronation in 1965. He was dissatisfied with the 1950 treaty and began openly pleading for greater autonomy. In 1967, he told reporters that he wanted more political freedom. A year later, on India's Independence Day, Sikkimese students in Gangtok chanted slogans like "We are buffers, not duffers" and "Indians leave Sikkim.

In 1972, India offered Sikkim permanent association status with associate membership of UN-affiliated bodies like the WHO. The Chogyal rejected it, as his lawyers advised him that it would leave Sikkim worse off than under the 1950 treaty. At this point, diplomacy had run its course. A covert operation was the only solution. Towards the end of 1972, Prime Minister Indira Gandhi summoned R&AW chief RN Kao and her principal secretary PN Haksar. She showed them a letter from the Chogyal in which he had used the title 'His - suggesting sovereign status. She turned to Kao and asked, "Can you do something about this?"Kao asked for two weeks. He returned in 10 days and said, "Yes." Gandhi agreed, but made one thing clear: the operation could go all the way to merger, provided it had public support.


Around June 1973, I was called by Kao. He assigned me this operation and I was told to meet my regional chief PN Banerjee in Calcutta. There, in July 1973, the mission was laid out: unite prodemocracy groups, assure them that India would no longer shield the Chogyal, support Kazi Lhendup Dorji's Sikkim National Congress (SNC) and prepare for a possible merger, while keeping the Chogyal under the illusion that negotiations were still possible, so he wouldn't actively oppose the process or mobilise against the upcoming

Narlikar and Srinivasan leave behind a shining legacy in the world of science

Dr Jayant Vishnu Narlikar was director of the globally acclaimed Inter-University Centre for Astronomy and Astrophysics (IUCAA), Dr MR Srinivasan was one of the towering personalities who ably guided India's nuclear programme

It is with profound grief that I share the news of the passing away on May 20 of two prominent Indian scientists - Dr Jayant Narlikar and Dr MR Srinivasan. Dr Narlikar was 86 and Dr Srinivasan 95. Nehru Science Centre, of which I was the Director, had the honour of hosting lectures of both these scientists.Dr Jayant Vishnu Narlikar was an eminent scientist in astrophysics and cosmology. He was also a great science communicator, including in Marathi.Dr MR Srinivasan was one of the founding members of the Atomic Energy Commission. He worked with Dr Homi Bhabha and also served as Chairman of the Atomic Energy Commission and Secretary, Department of Atomic Energy (DAE). As we mourn their loss, it is also a time to reflect on and celebrate their life of extraordinary intellect and their contributions to our nation.Dr Narlikar's contributions to theoretical astrophysics, his role in nurturing scientific talent in India and in the establishment of the Inter-University Centre for Astronomy and Astrophysics (IUCAA), a globally acclaimed institution, and his efforts to make science accessible to all will continue to inspire generations. Narlikar was born in Kolhapur, Maharashtra, on July 19, 1938. He received his early education at Banaras Hindu University (BHU), where his father was Professor and Head of the Department of Mathematics. Young Jayant Narlikar had a brilliant career in school and the intermediate. He obtained his BSc degree from BHU in 1957. Narlikar opted to pursue his higher studies at the Cambridge, UK. He was a Wrangler and Tyson Medallist in the Mathematical Tripos at Cambridge, from where he obtained his degrees in mathematics: BA (1960), PhD (1963), MA (1964), and ScD (1976). He also distinguished himself at Cambridge with the Smith's Prize in 1962 and the Adams Prize in 1967. He stayed back there till 1972 as a Fellow of King's College (1963-72) and Founder Staff Member of the Institute of Theoretical Astronomy (1966-72).It was during this period that Dr Narlikar laid the foundations of his research work in cosmology and astrophysics in collaboration with his internationally acclaimed For his stellar contributions to science communication mentor, guide and collaborator, Fred Hoyle. One of Dr Narlikar's most significant contributions is his development of the "Hoyle-Narlikar Theory", also known as the "Quasi-Steady State Cosmology (QSSC)". This cosmological theory proposes an alternative explanation for the origin and evolution of

the universe, challenging the widely accepted Big Bang theory of that time.Dr Narlikar returned to India in 1972 to join the Theoretical Astrophysics Group at the Tata Institute of Fundamental Research (TIFR), where he served for 17 long years. This group, under the leadership of Dr Narlikar, expanded and acquired international standing for TIFR in the field of theoretical astrophysics, which TIFR continues to enjoy even today.In 1988, Dr Narlikar was invited by the University Grants Commission (UGC) to set up the IUCAA as its Founder-Director. He was a recipient of the Bhatnagar award as well as of the MP Birla award, the Prix Janssen of the French Astronomical Society



and the prestigious Associate of the Royal Astronomical Society of London. He was a Fellow of the three national science academies as well as of the Third World Academy of Sciences.

and popularising science, Dr Narlikar was honoured by the UNESCO in 1996 with the prestigious Kalinga Award. Dr Narlikar was conferred the Padma Bhushan award by the Government of India in 1965 and the Padma Vibhushan in 2004. In 2011, the Maharashtra Government awarded him the state's highest civilian award, the Maharashtra Bhushan.Dr Narlikar served as the Chairman of the Executive Committee of the Nehru Science Centre, Mumbai. I have had the honour of heading the Centre for two terms.

MR Srinivasan was born on January 5, 1930 in Bangalore. He was one of the towering personalities who ably guided the Indian nuclear programme. He completed his mechanical engineering from the UVCE, Bangalore, in 1950. He did his masters in fluid mechanics, heat transfer and applied mathematics and his post-graduation in gas turbines and acquired a doctorate from McGill University, Canada.Dr Srinivasan was hand-picked by Dr Homi J Bhabha to

work for the DAE. He joined the DAE as senior research officer in September 1955. He was deputed to the UK Atomic Energy Authority for an international course in reactor technology at Harwell. His first assignment with the DAE was to work with the group responsible for the construction of the first research reactor of Swimming Pool Type, later

In 1959, a project group was constituted for setting up the first nuclear power plant. Dr MR Srinivasan was the principal project engineer of a boiling water reactor of US design at Tarapore. In early 1967, he was appointed as the chief construction engineer of the Madras Atomic Power Project. It was the first indigenously designed pressurised heavy water reactor based on CANDU technology. The construction work at the power station involved many new and callenging techniques in civil engineering.He was made the Chairman of the Nuclear Power Board, DAE, in 1984. Dr MR Srinivasan served as Chairman of the Atomic Energy Commission from 1987 until his retirement in February, 1990. He hastened the process of setting up the Nuclear Power Corporation of India, which was created in September 1987, with Dr Srinivasan as Founder-Chairman.In 1984, he was awarded the Padma Shri, the Padma Bhushan in 1990, and the Padma Vibhushan in 2015. He is the author of the book, 'From Fission to Fusion: The Story of India's Atomic Energy Programme' (Viking Penguin, 2003).Dr MR Srinivasan has also written extensively in the print media on the significance of the development of nuclear energy for India's energy mix and has appeared regularly on TV programmes to engage on nuclear issues and nuclear safety.

Stitch in time: on judiciary and Environment Ministry notifications

Making illegal units pay heavy fines might have limited deterrent effect

Last week, the Supreme Court of India finally struck down as "illegal" two notifications by the Union Environment Ministry that allowed industrial units to set up, expand operations or change their manufacturing practices without following the due process of taking government permission beforehand. Taking 'prior' approval is a sacrosanct principle at the heart of the Environment Impact Assessment (Notification) of 2006. On the surface it appeared that the Centre, or the Union Environment Ministry, had instituted a system that made a mockery of this principle, but there was a rationale, even if it was flawed to some extent. In March 2017, the body issued a notification providing a "one-time" six-month window for industries that did not have the right instituted a 'standard operating procedure' that in effect allowed projects in violation of the laws, but which could not avail of the six-month window, to

apply - albeit at the cost of heavy fines - for regularisation. Moreover, all these significant changes were being issued through executive orders, rather than any attempt at amending the underlying Environment Protection Act (EIA), 2006, through Parliament.The Centre's reasoning was three-fold. First, the process for regularising projects had already been initiated by the United Progressive Alliance government in 2012 and 2013. These were, however, struck down by the Jharkhand High Court and the National Green Tribunal on procedural grounds, and not that these projects were irredeemably violative. Second, demolishing functioning plants that were contributing to the economy and employment could exacerbate pollution and be disruptive.

environmental clearances, to apply for one. In 2021, it The Centre cited examples of various disputes involving copper mines to pharmaceutical companies where the courts had agreed that a "balanced" approach was necessary in cases involving violations. Finally, it argued that it had put in place a system whereby the industrial units seeking to be regularised would have to pay fines for the period that they had functioned in violation.

The Court in its final verdict has rightly, as previous courts have, emphasised the principle of "prior" clearance, though its action may be a little late as it has clarified that companies that had regularised themselves under the 2017 and 2021 orders would be "unaffected" by the judgment. That thriving industrial units in violation of the laws mushroomed is a testament to the collective failure of regional environmental boards to enforce laws. So it stands to reason that making these illegal units pay, under the purported new procedure, would have been a fruitless exercise. The judgment should ideally nip any "crafty" attempts by future governments to condone violations in the name of the economy though it must also trigger on-ground enforcement.

Indo-Pak conflict: The nuclear bogey is here to stay



LIKE Banquo's ghost in Macbeth, the spectre of nuclear weapons has hovered over India-Pakistan conflicts in recent decades. Notwithstanding disclaimers, it does so over the Operation Sindoor strikes as well. Looking back, the risk of an actual nuclear outbreak seems to be low, almost negligible. But as the events unfolded, several pathways that could have led to that dreaded event became visible. The urgency of addressing these pathways seems to have prompted the US to shift from its arms-length posture to active diplomacy and help broker a ceasefire. The Indian proposition is that the ceasefire was reached bilaterally, but it's apparent that it was brokered by Uncle Sam, who does not tire of reminding us about it.On May 12, speaking at the White House on the eve of his visit to Qatar, US President Trump declared, "My administration helped broker a full and immediate ceasefire, I think a permanent one, between India and Pakistan, ending a dangerous conflict of two nations with lots of nuclear weapons." The previous day, he praised the Indian and Pakistani leadership for ending the "current aggression" and said "millions of good and innocent people could have died."

Even before the crisis escalated, Pakistan had hinted at a nuclear response. Following the suspension of the Indus Waters Treaty (IWT) by India, a statement from the Pakistan Prime Minister's office said any attempt to stop or divert the waters would be considered as an act of war "and responded to with full force across the complete spectrum of national power." This reference to "complete spectrum" clearly related to nuclear weapons. Then, as the crisis escalated, Pakistan sent more nuclear signals. On May 10, Prime Minister Shehbaz Sharif called a meeting of the National Command Authority, the top body that takes decisions on the country's security as well as those related to nuclear weapons. This was later conveniently denied by Pakistan. There was a lot of misinformation swirling around developments relating to nuclear weapons. One came from the landing of a Beechcraft Super King Air



350 aircraft - purportedly of the US Department of Energy — in Sargodha shortly after an Indian strike on Kirana Hills, where some Pakistani nuclear weapons are reportedly stored. It transpired later that this aircraft, which did belong to the US agency, had been bought by Pakistan in 2010 and its presence had nothing to do with anything nuclear. India denied that it conducted a strike on Kirana Hills, a mountain range located about 15 km from the Mushaf airbase near Sargodha, which it did strike. But there is evidence of two hits near the entrance of the facilities at Kirana Hills. Let's be clear their strikes

on Nur Khan base near Rawalpindi, Malir near Karachi and on Kirana Hills was clear messaging since these facilities are host or adjacent to facilities relating to nuclear weapons.

This became explicit on May 12 when Prime Minister Narendra Modi, in his address to the nation, declared that "India will not tolerate nuclear blackmail. India will strike precisely and decisively at the terrorist hideouts developing under the cover of nuclear blackmail."

This is a new doctrinal assertion, since in the past 40 years in which India has suffered from cross-border terrorism,

it was the nuclear factor that had stayed the Indian hand. On May 13, in his official briefing, Ministry of External Affairs spokesperson Randhir Jaiswal rejected Trump's account of the ceasefire and also insisted that "the military action was entirely in the conventional domain." India has a nuclear doctrine, which says that its nuclear

weapons are only for retaliation against a nuclear, chemical or biological weapon attack on India or Indian forces anywhere. Pakistan does not have an enunciated doctrine, but it has asserted at various times that India is the target of its weapons, which will be used if it suffered major territorial loss, destruction of key military assets or economic strangulation. It would be foolhardy to ignore the prospect of a nuclear war even if there is a selfconscious effort to keep it in the conventional domain. These dangers have been evident in the recent Indian strikes on Pakistani Air Force (PAF) facilities. The Op Sindoor strikes were limited - they initially struck at terrorist facilities, and hit Pakistani military facilities only after the PAF launched attacks on Indian aircraft over Indian territory. All this was limited to the 48 or so hours of the main conflict. In an actual war, even one that lasts two or three weeks, the bombing would be much more intense. This is where problems can occur. As of now, India keeps its nuclear weapons de-mated — the weapon and the fissile core separate - so as to promote nuclear safety and political oversight. But in the case of Pakistan, where the military runs the show, both the weapons and cores are mated and held by the Army.

The big danger in an all-out war, even if India intends to keep it entirely conventional, is that it may inadvertently end up hitting a large number of nuclear weapons storage sites using weapons like the SCALP (Storm Shadow), Crystal Maze and Paveway-type bombs that can penetrate fortified bunkers. Without intending to do so, it may degrade the Pakistani nuclear arsenal to the point where the country is confronted with a "use it or lose it" dilemma. In this event, it may find itself being compelled to escalate things to the use of nuclear weapons.

The enormous temple of Surang Tila was unearthed in 2005-06. The temple premises covers a vast area and the main temple stands tall, elevated by a flight of 37 steep limestone steps. The temple was built by Mahasivagupta Balarjun in seventh century AD and has been constructed in the panchayatan style of temple architecture, with the main temple in the centre and four temples in the corner. The main temple has five sanctums, four of which had four different types of Shiva lingas for worship, respectively coloured white, red, yellow and black. The remaining sanctum contains a Ganesh idol. The 32-pillared mandapa holds these five sanctums. The complex area has three tantric temples in a platform, dedicated to Brahma, Vishnu and Shiva. 

Laxman Temple

Dating back to 625-650 AD, the Laxman Temple in Sirpur is one of the most famous structures in the city. It is believed to be one of the best examples of brick temples in India and is dedicated to Lord Vishnu. The intricate carvings on the exterior of the temple make it special. These designs include Lord Vishnu, Krishna Leela symbols, Vaishnava Dwarpal, and pictures bearing resemblance to the famous erotic work as in the Khajuraho Temple. The mandapa which originally bore stone pillars is now in ruins.

Budh Vihar

The Budh Vihar was unearthed in 2003 and houses a statue of Buddha, with Padmapani on either side. It is believed to have been constructed during the time of

Somanvansi king, Teevardeo and continued to stay in use until the rule of his grandson Mahashivgupta Balarjun in 7th to 8th century AD. Perhaps the most interesting aspect of this ruin is the entry gate to the temple. The beautiful carvings here depict plenty of scenes from Buddha's life, including love, matrimony, friendship and other ties. This emphasis confirms the influence of Buddhism in Sirpur. The northern and southern arms of this space were used as dwelling

Ancient marketplace

The ancient marketplace is an impressive set of ruins that are spread over an area of 250 sq m along the river Mahanadi. This place was believed to be the centre of all commercial and trading life of the era. The excavations have revealed that some shops have connecting underground channels, which may imply that the shop owners had more than one shop. There

are places which suggest that goods were kept covered in these depressions to guard against natural weathering. The main artefacts unearthed from here indicate that this market was used mainly by coppersmiths, goldsmiths, ironsmiths and potters.

Street food

Street food is busy but organised in Chhattisgarh. Even though the samosas are believed to be mouth-wateringly delicious here, the bhajiyas or the pakoras definitely deserve more of the attention. With the traditional cup of chai, the breakfast here usually comprises kachoris, mirchi bhajis, dal ka wada and onion bhajiyas. To satisfy your sweet tooth, pick a warm jalebi and you will not regret it. Sirpur is essentially dominated by a straight road with major sights located on either side. The city's main street food hub is on the junction of the road that turns towards Budh Vihar and Laxman Temple.

High Commission official who trapped YouTuber a Pakistani spy: Sources

Danish, alias Ehsan-ur-Rehman, who was posted to the Pakistan **High Commission** in Delhi, was expelled by India earlier this month amid tensions with Pakistan.

New Delhi. The Pakistan High Commission official who trapped Haryana-based YouTuber Jyoti Malhotra was an agent of Islamabad's notorious Inter-Services Intelligence (ISI), sources said.Danish, alias Ehsan-ur-Rehman, was expelled by India earlier this month amid tensions with Pakistan following the Pahalgam attack, which left 26 people dead.

Sources said Danish's passport was issued from Islamabad, and he was granted a visa for India on January 21, 2022. According to documents, exclusively accessed by India Today, Danish was born in Narowal in Pakistan's Punjab province. Security agencies are now probing whether Ehsan alias Danish was his real name or a code name given by the ISI.Sources said Danish was posted at the visa desk at the Pakistan High Commission in Delhi, ISI AGENTS POSTED AT PAK HIGH but his real job was espionage and trapping people to spy for Pakistan.Danish was actively working to develop Malhotra, who was arrested last week for allegedly spying for Pakistan, as an intelligence asset.

Malhotra, a Haryana-based travel vlogger,



confessed to security agencies that she first came in contact with Danish in 2023 when she visited the High Commission in Delhi for a visa to travel to Pakistan. Since then, she was in regular contact with him. She is presently under Haryana Police custody, which was extended on Thursday by four more days.

However, this is not the first time that officials posted at the Pakistan High Commission in Delhi have been accused of spying. Sources said Pakistan's ISI deploys its agents in the High Commission in India, and their postings are

On May 31, 2020, the Special Cell of Delhi Police and Military Intelligence (MI) exposed two such Pakistan High Commission officials who were posing as visa officers in India but were found to be ISI agents. They were identified as Abid Hussain and Tahir Khan.The officials were declared persona non grata and sent back to Pakistan. Immediately after this incident, the strength of the Pakistan High Commission was cut from 180 to 90. Over the years, security agencies have received regular input of staff posted at the Pakistan High Commission being ISI agents who prepare their passports under fake names and come to India for espionage activities.In 2021 too, the Delhi Police, along with MI, carried out a sting operation in which a Pakistani-origin visa officer, identified as Rana Mohammad Zia, was exposed. He was found to be an ISI agent working as a visa officer at the Pakistan High Commission.In this case, a military contractor named Habib, who was linked to Rana Mohammad, was arrested in

3,000 Agniveers braved Pak assault in Operation Sindoor, guarded key installations

New Delhi. Around 3,000 Agniveers -- most barely 20 years old and recruited under the Agnipath scheme in the past two years -- were at the forefront of Operation Sindoor, defending Indian military installations from Pakistani missile and drone attacks, sources told .From manning critical air defence systems to holding their ground across multiple installations, cities, and airbases despite repeated enemy assaults, the Agniveers' performance matched that of regular soldiers. Frontline feedback described their contribution as both decisive and commendable, sources in the defence establishment added. Sources revealed that each air defence unit had 150-200 Agniveers in its ranks, deployed primarily along the western

The Agniveers served across four specialised trades -- gunners, fire control operators, radio operators, and drivers of heavy-duty vehicles mounted with guns and missiles. Additionally, they helped activate and operate Akashteer -the locally developed air defence control and reporting system -- that became the nerve centre of India's air defence response

Agniveers were actively involved in firing shoulder-launched missiles, operating upgraded anti-aircraft guns such as the L-70 and Zu-23-2B, manning systems like Pechora, Schilka, OSA-AK, Strela, and Tunguska, and deploying and launching Akash and other surface-to-air missiles. This real combat experience is seen as a turning point for the Agnipath model, with officials stating it should "settle the debate" over the short-term recruitment policy's effectiveness.Running radars, communication networks, and Akashteer nodes, some also acted as sentries in forward zones after deploying weapon systems. Additionally, they are covered by an insurance policy worth Rs 48 lakh. The ex-gratia benefit for an Agniveer killed in the line of duty is Rs 44 lakh. Upon completing four years of service, Agniveers are entitled to a Seva Nidhi package of Rs 11.71 lakh, of which Rs 5.02 lakh is self-contributed.

Punjab and Haryana High Court receives bomb threat, probe launched



New Delhi. The Punjab and Haryana High Court on Thursday afternoon received a bomb threat prompting immediate security measures and the evacuation of courtrooms as a precautionary step. According to police sources, after the High Court received a bomb threat via email, Chandigarh Police's Operation Cell, rescue team, fire department and all concerned officials have reached the spot. In view of the situation, the Bar Association asked all the advocates to vacate court premises for safety.

Earlier, on Wednesday, Gurugram Mini Secretariat had received a hoax bomb threat in the afternoon which also prompted authorities to carry out temporary evacuations. Similar to today's incident, yesterday's bomb threat was also sent via mail. The mail was marked to the Deputy Commissioner.

The bomb scare expressed in the received email has been proven to be false and baseless. It was a rumour, but we do not take any situation lightly," DC Ajay

32 Real-Time Water Monitoring Stations To Be Set-Up For Yamuna Clean-Up

New Delhi. In line with its commitment to clean the Yamuna river, the BJP-led Delhi government will install 32 real-time water quality monitoring stations to monitor the river water and the drains flowing into

A senior official said ten stations will be set up on the Yamuna River and 22 on major drains. Some of the Yamuna river sites where Monitoring Stations will be set up include Palla, ISBT Bridge, ITO Bridge, Nizamuddin Bridge, Okhla Barrage, etc. The major drains that will be included are Najafgarh, Metcalfe House, Khyber Pass, Sweeper Colony, along with some border drains that include Singhu Border (DD6, Sonepat), Bahadurgarh, Shahdara, Sahibabad

These Monitoring Stations will monitor the river along with drains flowing into it and record the date of the cleaning procedure.

All the monitoring stations are expected to be operational by the end of this year. The tender process has already been initiated. These stations will monitor water quality in real time and transmit the data directly to the Delhi Pollution Control Committee (DPCC) server. These stations will monitor key pollutants, for instance, BOD (Biological Oxygen Demand), COD (Chemical Oxygen Demand), TSS (Total Suspended Solids), along with Levels of Nitrogen, Phosphorus, and Ammonia. The Yamuna cleaning project is already underway, where the treatment of sewage has begun. Delhi LG VK Saxena, Chief Minister Rekha Gupta, and Minister Parvesh Verma are monitoring the procedure.

The trio has regularly inspected major drains that also

fall into the river. Yamuna cleaning has been a significant issue in the state, where the previous government promised to clean it but failed to do so. The BJP government, led by Chief Minister Rekha Gupta, has also promised and plans to clean it within its first tenure. In the Delhi budget 2025- 26, Delhi CM Gupta allocated 500 crore specifically for Yamuna cleaning, where funding will be designated for the construction of 40 decentralised sewage treatment plants (STPs). The aim is to treat the water before it enters the river, thereby addressing pollution at its source.

The "Auld Grey Toon" is one of cloister garths, courtyards, "yetts" (gates of latticed wrought iron bars), "wynds (narrow lanes), "pends" (streets leading to courtyards), Renaissance arcades, masonic porches, villas, staired turrets, balustrade parapets, slate or clay pantile, Flemish crow-stepped or corbie roofs, moulded windows, porticos, old archdeacon's mansions and walled gardens.

St Salvator's Chapel

Locals and students are all familiar with Agnes, Annie, Elizabeth, Margaret, Katherine and George. These are the church bells of the university chapel on North Street. The six bells are contained in the tower and are hung for full circle ringing. The oldest is Elizabeth, recast in 1940. Agnes is named after the sister of one of the university's chairs of Greek, George after a student, Margaret after a Scottish medieval queen and Annie after the university's first female student, Agnes Forbes Blackadder (MA, 1895).

A rare example of Late Gothic architecture, the chapel was founded in 1450. The adjacent 1933 halls of residence were once described as "a rambling Gothic dormitory". The oldest hall is St Regulus (1868). The modern halls are in the "brutalist" style of architecture.

St Salvator's College

Established in 1450 by Bishop Kennedy, this is now a university residential hall. The tower, to which the present spire was added in 1550, contains the original bells—Katharine and Kate Kennedy. The butts date from the 1860s. The entrance archway originally formed part of the old cloister court. In the vestry is a 1461 college mace. In 1747, St Salvator's College became the seat of the United College.

St Salvator's Quad contains lecture and exam halls, and was for many years the scene of the annual Raisin Weekend mass shaving foam fight every October. This

commemorates the tradition of giving raisins to academic parents or mentors who look after freshers, first year students or "beasants" (fledglings). Now, their services are rewarded usually by alcohol! Outside the Quad are the letters PH in the cobble marking the site where the Protestant martyr Patrick Hamilton was burned at the stake in 1528, and it is considered bad luck to walk on the letters. Students who walk across these letters will fail their degree but can remove the 'curse' by bathing in the sea at dawn on 1st May

St Andrews Castle

Once one of the most important strongholds of the kingdom, the castle was founded around 1200, reconstructed in the 14th century and repaired in the 16th century. The structure forms an irregular pentagon enclosing a courtyard with towers or blockhouses which are now long gone, along with the original square Fore Tower. What remains is the work of Archbishop Hamilton, following the siege of 1546-7. Still standing is the Kitchen tower and Sea Tower with its bottle dungeon.

St Rules Tower

The place to sightsee, St Rules Tower in St Andrews Cathedral has the best view in town. Its name derives from the town's claim to be the final resting place of the apostle Andrew and the patron saint of Scotland, whose bones were brought under divine guidance from Patras, Greece by St Regulus (St Rule) to Kilrymont. St Andrews was also called Kilrule.

The Priory of Canons Regular of the Order of St Augustine was founded in 1127. The community were for a while associated with the Church of St Regulus or St Rule, of which the 33 m Romanesque tower and choir (1080) still stands to the east of the later Cathedral. It is the oldest surviving building in St Andrews. It was the first place of worship for arriving St Augustine canons. The establishment of the present town began around 1140 by Bishop Robert. The burgh of St Andrews was first represented at the great council at Scone Palace in 1357 and granted a royal charter by King James VI, who used the area around the nearby Falkland Palace for

St Andrews Cathedral

This Cathedral was founded in 1160 by Bishop Arnold and consecrated in the presence of King Bruce in 1318. Construction started at the east end, where the detail is Romanesque but later work is Gothic. The nave consisted of 12 bays, a crossing with a central tower, north and south transepts, a choir and shrine. At 109 m (357') it was by far the longest and largest cathedral in Scotland.

The vaulted calefactory and refectory undercroft were restored at the end of the 19th century. Parts of the Great Hall remain, as well as the re-built gateway of the New Inns or royal guest house on Pends Road. The whole area is a half-a-mile in length with 13 towers and three gateways. The Cathedral was abandoned during the Reformation (1559). The lead on the roofs was used for ammunition in the Wars of Religion. The central tower collapsed and the ruins were used as a quarry. Many buildings around town are made from the Cathedral stone.

Used as a place of worship since the 8th century, the cathedral became the headquarters of the medieval Scottish church and dominated religion until the Protestant Reformation in 1560. It was the seat of Scotland's leading bishops, and from 1472 of the archbishops. In 1559, John Knox preached a passionate sermon in the parish church and, as a result, the church was cleansed. In 1561, it was abandoned and left to fall into ruin.

The Cathedral graveyard contains the

graves of Scottish diplomat and prelate Andrew Forman, Scottish Presbyterian and museum curator James Bell Pettigrew and famous golfing pioneers, Old Tom Morris and his son, Young Tom who won the British Open Championship four times and died at the age of 24.

There is also the grave of golfer Allan Robertson to whom Old Tom was an apprentice. He is considered to be the first professional golfer club and ball maker. Robertson was never beaten and was first to break 80 over the Old Course, the year before he died in 1859. He exported his clubs and balls worldwide. An authentic Robertson "feathery" ball is a collector's item today. Along with Morris, he also designed Carnoustie in 1842. His epitaph reads: "Allan Robertson-who died 1st Sept. 1859 aged 44 years old. He was greatly esteemed for his personal worth and for many years was esteemed as the champion golfer of Scotland."

The British Open is due to his death. The members of Prestwick Golf Club on the west coast of Scotland held the competition in 1860, to decide who would succeed him as the "Champion Golfer". The Open, continuing annually ever since except for the war years, is the longest-running golf championship, and the oldest of the four "Majors"—the US Open, US Masters and US PGA Championship.

Queen Mary's House

On South Street, which is like all the streets a processional avenue to the St Andrews Cathedral, there is the three-storey frontage of the house and its later extension, "Priorsgate". The most striking design element is the western wing's stair tower and corner oriel of brownstone. The house was begun in 1523 by merchant Hew Scrymgeour and became known as Queen Mary's House when she stayed there in 1564 on one of her many visits. The building was renovated in 1927 for use as a library by St Leonards School.



Walmart to cut 1,500 jobs in restructuring move: Report

New Delhi. Retail giant Walmart is planning to cut around 1,500 jobs as part of a major reshuffle to make its operations more efficient. This move is part of the company's larger plan to focus on long-term goals, as per an internal memo shared by Reuters.

The job cuts will affect several areas, including Walmart's global tech team, the e-commerce section in US stores, and its advertising arm, Walmart Connect. While some roles will be removed, new ones will also be added to better match the company's future plans."To accelerate our progress delivering the experiences that will define the future of retail, we must sharpen our focus," mentioned the memo, quoted Reuters. Walmart is the largest private employer in the United States, with around 1.6 million workers. Globally, it employs about 2.1 million people. It's also the biggest US importer, bringing in nearly 60% of its goods, like clothes, electronics and toys, from China.

This round of job cuts follows several other changes in recent months. In February, Walmart closed its office in North Carolina and shifted employees to other main offices in California and Arkansas. Just last week, it said prices on some products would go up by the end of May, partly due to economic pressure from trade policies under former US President Donald

All ITR forms are out, but you still can't file. What's causing the delay

New Delhi. The Income Tax Department may have rolled out all ITR forms for the Assessment Year 2025-26. But before you rush to file your income tax return, here's something important to know - the actual e-filing process isn't open yet. It's because the e-filing utilities are not live on the portal.

WHAT'S THE DELAY ABOUT?

While all seven ITR forms (ITR-1 to ITR-7) and even the updated ITR-U form are ready, the filing process can't begin until the government activates the utility software. These utilities are essential tools that help taxpayers fill in, check, and submit their returns online or offline. Without these tools, the system won't accept your return, no matter how ready you are, say experts.

WHAT ARE THESE UTILITIES AND WHY DO THEY MATTER?

Each year, the department provides the filing utility in different formats, online, offline (Java or JSON), and Excel. These formats are designed to suit different users. Many individual taxpayers prefer the online mode for its simplicity and ease, while professionals often use the JSON or Excel versions.

But whether online or offline, these utilities are a must. They allow you to fill in the form correctly, validate the data, and upload it securely.

Without these, the system won't accept your return no matter how ready you are.



On the other hand, people working in sales, as waiters, security guards, or in jobs with strict routines like factory work or driving, reported low job satisfaction. Even corporate managers, despite their high status, felt unhappy because of stress and lack of control over their work.

PRESSURE DRAINS JOB SATISFACTION

Too much pressure and little freedom can make even the most respected jobs feel empty, explained the researcher. The study also found that self-employed individuals reported greater satisfaction, largely due to the freedom and flexibility their work offers.



ABFRL demerger: Brokerages assign fair value to new fashion twins. Details here

Brokerages have begun breaking down the newly split entities, laying out distinct growth paths and fair value estimates for both ABFRL and ABLBL.

New Delhi.Shares of Aditya Birla Fashion and Retail Ltd (ABFRL) fell nearly 66% on Thursday, trading at Rs 91 on the BSE, as the market recalibrated its valuation following the demerger of Aditya Birla Lifestyle Brands Ltd (ABLBL). It may be noted that the sharp correction reflects the subtraction of the demerged entity's value and not a deterioration in ABFRL's business outlook.Brokerages have begun breaking down the newly split entities, laying out distinct growth paths and fair value estimates for both ABFRL and ABLBL. Bernstein, which has closely tracked ABFRL's transformation, values the demerged ABFRL at Rs 80-105 per share, while assigning ABLBL a fair value range of Rs 185-215. The brokerage firm believes the separation will allow both companies to sharpen

their brand focus and unlock value for shareholders.Jefferies echoes this view, pegging ABFRL's standalone fair value at Rs 100. The brokerage believes the rerating is a technical adjustment and anticipates more investor clarity once ABLBL lists next month.Domestic brokerage JM Financial is even more granular in its assessment. It assigns a Rs 103 valuation to ABFRL, applying 18 times EV/EBITDA to its flagship Pantaloons brand, 3 times EV/Sales to ethnic wear, and 1 time EV/Sales to the digital-first TMRW portfolio. Meanwhile, ABLBL is projected at Rs 186 per share, based on 23 times EV/EBITDA for core lifestyle brands and 10 times for growth businesses such as Reebok and Van Heusen Innerwear. Under the demerger scheme, shareholders will receive one share of ABLBL for every ABFRL share held as of the May 22 record date. The new entity is expected to list on both the NSE and BSE by mid-June, pending regulatory clearances.

TWO NEW FASHION POWERHOUSES ABFRL will now retain businesses with a focus on ethnic wear, value fashion, and premium retail. This includes Pantaloons,

the ethnic portfolio under TCNS, designer brands like Sabyasachi, Tarun Tahiliani, Masaba, and the upcoming luxury play with Galeries Lafayette. JM Financial noted that ABFRL starts with a net cash balance of Rs 140-150 crore, enough to



support near-term growth plans. Its digital venture TMRW may raise funds independently to fuel M&A-led expansion.On the other hand, ABLBL has become home to India's dominant western wear and innerwear portfolio, including Madura Fashion & Lifestyle (Louis Philippe, Van Heusen, Allen Solly, Peter England), alongside newer growth drivers like Reebok, American Eagle, and Van Heusen Innerwear.According to JM, ABLBL will launch with a manageable debt of Rs 700-800 crore, which it expects to retire over the next 2-3 years. The brokerage is optimistic about the

business scaling quickly, with targets to double revenue and triple cash profits between FY24 and FY30. A 300-basis point margin expansion could lift EBITDA margins above 11 per cent, taking return on capital employed (ROCE) to as high as 70 per cent by FY30 (excluding intangibles).

In such cases, the match referee's decision is considered to be final and binding.

"Mukesh Kumar admitted to the Level 1 offence under Article 2.2 and accepted the Match Referee's sanction," an IPL release stated."For Level 1 breaches of the Code of Conduct, the Match Referee's decision is final and binding." Mukesh Kumar has a night to forget at the Wankhede stadiumIt was a night to forget for Mukesh against MI as his final over proved to be the turning point in the game. The pacer had come into the side to replace T. Natarajan in the must-win game for the Capitals as play-off qualification was on



the line. Mukesh started off brilliantly at the Wankhede as he was impressive with the new ball and got the wicket of Will Jacks. Before the start of the death overs, the Bengal pacer also dismissed Tilak Verma as it seemed like DC would restrict MI to a below-par total.

However, all this changed in Mukesh's final over as Suryakumar Yadav and Naman Dhir took him apart. Ruben Amorim to quit United without payoff if board loses trust after Europa loss

New Delhi. Manchester United head coach Ruben Amorim has revealed he is willing to leave the club without taking a single penny in compensation if the board loses faith in him following their failure to win the Europa League final. Amorim's side failed to turn around a disastrous season after losing 1-0 to Tottenham Hotspur in the final on May 22, which has increased the pressure on the Portuguese manager. Spurs secured victory thanks to a 42nd-minute strike from Brennan Johnson, which deflected off United fullback Luke Shaw and wrong-footed goalkeeper Andr Onana. This result ended United's hopes of qualifying for next season's UEFA Champions League, compounded by their 16th-place finish in the Premier League. Despite enduring one of the club's worst seasons in recent history, Amorim insisted he wants to continue as



manager and will only step down without a payoff if the board clearly withdraws their trust."I have nothing to show to the fans, so in this moment it is a little bit of faith...Let's see. I am always open. If the board and fans feel I am not the right guy, I will go in the next day without any conversation about compensation, but I will not quit," Amorim told reporters."I am really confident on my job. And as you see I will not change nothing in the way I do things. I am not going to talk about the future, tonight we need to deal with the pain of losing this match...It was clear we were the better team, then we manage not to score again. The guys try everything to win the game. In the future we can assess," he added.Although United entered the Europa League final in Bilbao unbeaten, a costly defensive lapse and a lack of clinical finishing up front prevented them from making a comeback after Spurs took the lead.

With hopes of a top-five Premier League finish off the table, Amorim admitted his focus shifted entirely to winning the Europa League and giving youngsters opportunities in the league.

Manchester United collapse: A nightmare season ends without glory or europe

™ Manchester United's Europa League final loss captured the very essence of their horror 2024-25 season. A campaign filled with missteps, a misfiring forward line and a lack of mentality has seen the Red Devils set for their worst finish in the Premier League and miss out on making it to Europe for the next season.

New Delhi. May 21 holds a significant place in the history of Manchester United. In 2008, they defeated Chelsea on penalties in Moscow to win their third UEFA Champions League title under the stewardship of one of the greatest managers of all time, Sir Alex Ferguson. That same season, they also won the Premier League, underlining their dominance as one of English football's true

giants. Fast forward to 2025, and May 21 is now a date United fans would rather forget. In a match that exposed the glaring lack of quality in the current squad, they lost the Europa League final to Tottenham Hotspur. The Red Devils registered 16 shots—six on target—while Spurs had just one, which proved decisive.

But that's been the story of United's 2024–25 campaign: a nightmare from start to finish. Set to end the season in either 16th or 17th place, and saved from relegation only because Southampton, Leicester, and Ipswich were worse, United look a shadow of their former selves—trapped in the echoes of past glory. To put things in perspective, the Europa League final loss was Manchester United's 20th defeat of the season—their most in a single campaign since 1973–74, when they were relegated. So, where did it all go wrong for the Red Devils?

Was it just a lack of quality on the field? Or were poor decisions from ownership a deeper part of the problem?Let's take a look at the key reasons behind United's worstever Premier League campaign and their European heartbreak—a season that ended with no silverware and only bitter disappointment.Sticking with Ten Hag after a poor 2023–24 seasonThe first major

misstep, in hindsight, was retaining Erik ten Hag after an underwhelming 2023–24 campaign. United had finished eighth, with the Dutchman's system and tactical shortcomings being repeatedly exposed. The



very public fallout with Jadon Sancho didn't help, and while there were fleeting high points—like the dramatic extra-time FA Cup win over Liverpool and the final triumph over Manchester City—Ten Hag always seemed to be living on borrowed time.

By then, INEOS had taken over club operations, and their first big decision was Ten Hag's future. Despite testing the waters with other options, including Thomas Tuchel, they chose to back the Dutchman. That decision proved costly. United's Premier League form continued to slide, and after a loss to West Ham in October, Ten Hag was finally shown the door.But the issue wasn't just about sacking

Ten Hag—it was about who they brought in.
Ruben Amorim, known for his rigid tactical methods and structured system, had worked wonders at Sporting, turning them into one of Europe's most exciting sides. However, his system didn't align well ith the players at United. The result? A disjointed squad and continued defeats. Old Trafford, once a fortress, became anything but. With just one game remaining on May 25, the only thing left to play for is whether they finish 16th or 17th—with no European nights to look forward to

A misfiring forward line that never clicked

United's financial constraints are no secret, and their failure to sign a proven striker has haunted them for two seasons now. The Harry Kane deal was deemed too costly, so they instead spent around 64 million on Rasmus Hjlund. While the Dane showed promise last season, the 2024-25 campaign saw him become a figure of frustration. He scored just 10 goals in 51 appearances—six in the Europa League—and endured long droughts in the Premier League.

"And the beauty of Santner is that, on a surface like that, it's not so much the turn is the threat, it's the pitch being slow and his ability to change the arrival of the ball at different paces without the knowledge of the batsman. That's what makes him lethal, his subtle change of pace without any real sign or cue for the batter is his key," Moody said. "It's not like he's spun the odd one, but let's face it, Mitchell is not a big turner of the ball, he's never been a big turner of the ball, that's why he's never really grabbed hold of a Test cricket and run with it.

Both sides came into the final under intense pressure following disastrous domestic seasons. While Manchester United had remained unbeaten in Europe leading up to the final, Spurs saved their best for last. The win not only delivered silverware but also booked their place in next season's UEFA Champions League. The victory marked a fairytale moment for Son, who has spent a decade at the

North London club. For United, however, the night added further misery — with no trophy and a 16th-place finish in the Premier League leaving them without European

With the four IPL 2025 playoff spots already sealed, Gujarat Titans - in blazing form and still gunning for a top-two finish — will test their momentum against a struggling Lucknow Super Giants side, who have little more than pride left to play for on May 22. The Narendra Modi Stadium will play host as GT eye a crucial cushion by locking in a Qualifier 1 spot, while LSG hope for a consolatory win to round off an otherwise underwhelming season. The secret to Gujarat's successful campaign this year

has been consistent performances across all departments. From captain Shubman Gill, a rock-solid Sai Sudharsan, and the experience of Jos Buttler in the top order, to their reliable pace duo in Mohammed Siraj and Prasidh Krishna, and the guile of spin twins Rashid Khan and Sai Kishore— GT have clicked as a unit. Their dominant 10-wicket win over Delhi Capitals was a perfect example, as Gill and Sudharsan made light work of a 174-run chase, leaving Delhi Capitals stunned.Gill's composed leadership, backed by the ever-animated Ashish Nehra, has been a defining trait of GT's 2025 run — strengthening the chorus for his elevation to India's red-ball captaincy. The clash against LSG could be another litmus test reinforcing that narrative.Lucknow, on the other hand, have endured a season of misfires, with their campaign falling apart



after a defeat to Sunrisers Hyderabad, sealing their exit from the playoff race. Rishabh Pant's debut season as captain — after replacing KL Rahul — has been forgettable, with the keeper-batter failing to justify his hefty price tag. Despite the promise shown by openers Aiden Markram and Mitchell Marsh, and a resurgent Nicholas Pooran in the middle order, LSG's injury-hit and imbalanced bowling attack has undone any gains. Facing an in-form GT top-order will be a major concern for LSG, given their bowling frailties.

Interestingly, LSG lead the head-to-head tally in IPL history, having won four of their six meetings against Gujarat. Their last win came in IPL 2024 — a

six-wicket victory over GT. GT vs LSG: Team News

Gujarat are expected to be near fullstrength for the LSG match, at least until the playoffs begin. Their final league games — against LSG and then Chennai Super Kings — will be vital to cementing their Qualifier 1 berth.
