31, West Bengal chief minister Mamata Banerjee said on Tuesday, assuring that those who lost jobs over the West Bengal School Service Commission (WBSSC) will get age relaxation. The Supreme Court in April ordered invalidating the appointments of 25,753 teaching and non-teaching staff of stateaided schools, deeming the recruitment process "vitiated and tainted." The development comes amidst ongoing agitations by jobless teachers, many of whom are demanding permanent reinstatement and expressing

their unwillingness to appear for a fresh round of recruitment. West Bengal education minister Bratya Basu on Sunday urged the agitating teachers to have faith in the state government "which is taking every step to end the impasse" following the invalidation of their jobs by the Supreme Court. He also urged the agitating teachers not to be used by the opposition political parties. Basu, who was talking to reporters on the sidelines of a programme, said a senior official will meet the teachers - who have been agitating before the Education department headquarters Bikash Bhavan for the past several days -

to ascertain their demands as the government is exploring all possible legal steps to solve the issue, according to PTI news agency. Bratya Basu said the state government ensured the "untainted teachers", rendered jobless by SC order, can continue to attend their workplace and get salary till the process of fresh recruitment is completed by December 31.



Crowd at unfinished floating jetty sparks safety fears in Tamil Nadu

MADURAI. A floating jetty, under construction at the Vandiyur kanmoi (tank), has lately been attracting a huge crowd with several people using the unfinished platform, which has been raising safety concerns among several residents. The trend has caught on after videos of a few vloggers, who had mentioned the jetty as a walkway, recently went viral. The floating jetty is being built as part of the city corporation's Rs 50crore developmental works to transform the 550-acre Vandiyur kanmoi -- a major waterbody under the city limits -- into a tourist attraction. The works, to be completed in three months, include the construction of a bicycle track, a library, and a meditation centre.

Besides, the civic body also has plans to operate boating services in the tank, for which the floating jetty, made of a fibrereinforced platform filled with air, is being constructed.

Meanwhile, as a result of the viral videos, the number of people visiting the spot has gone up, with residents raising red flags over the issue.K Pandivarajan, a city-based enthusiast, said, "Many people, sometimes with their children, are seen walking over and sitting near the edge of the unfinished platform, which has no safety guardrail. Also, no lifeguard was present at the venue."

Acknowledging the development works, he urged the corporation to keep proper safety measures in place. When contacted, corporation commissioner Chitra Vijayan told, "The development works being carried out at the Vandiyur tank are in their final stages. By three months, the works will be completed and the facilities will be opened for public use. Though we have cordoned off the entry to the floating jetty, some people have violated the restrictions before the works are completed."

Four Bengaluru birders spot rare red phalarope in Dharwad

DHARWAD. In a remarkable discovery, four birders from Bengaluru have sighted and photographed the extremely rare red phalarope near Dharwad-likely marking the first recorded sighting of this vagrant species in Karnataka. The birders-Manjunath P, Chidananda Urs, Nitin Srinivasa Murthy, and Nisarg Bharadwaj—identified the Red Phalarope, during their birdwatching expedition. The bird has been sighted at Mavinkoppa Lake near Dharwad. While their breeding grounds are in the High Arctic regions of Alaska and Canada, these birds undertake long-distance migrations. In India, they were earlier sighted along the coastal areas.

There have been very few records of sightings of red phalaropes in Kerala, Maharashtra, Gujarat and in some time it recorded in the Andaman and Nicobar. "This bird is not a migrant. It's a vagrant, which means it has appeared outside its normal range. Normally migratory birds find themselves

This bird does not have one," Murthy told . India is not part of their regular migratory route or wintering grounds, there have been several documented sightings of the red phalarope in various parts of the country over the years. These sightings typically involve individual birds.

This bird should not be mistaken with rednecked phalarope," Murthy added.

Age-old wooden boat craft faces death as trade drops by 70 per cent in Kendrapara

VIJAYAWADA. Senior municipal teachers across the State have raised strong objections to the School Education Department's transfer guidelines, calling the system discriminatory for failing to reward long years of service. At the heart of the issue is the station point system, which currently caps points at 8 for teachers with eight or more ed to receive 2 points and corporation teachers 1 point. However, recent classifications grant 1 to 3 points inconsistently, depending on the municipality type.

This is a blatant violation," he said, calling for a uniform 2-point allocation for all municipal teachers regardless of municipality category.

The MTF also appealed for a 25% quota for municipal teachers in promotions to Primary School Headmaster (PSHM) posts. Ramakrishna alleged that some lessperforming teachers had been promoted, while deserving ones had been overlooked. He thanked HRD Minister Nara Lokesh for recently sanctioning 1,800 municipal teacher posts but urged swift resolution of roster anomalies and protection of senior.

Coast Guard confirms oil spill after container vessel sinks off Kerala coast, swings into action

KOCHI. The Indian Coast Guard (ICG) on Monday confirmed oil spill in the Arabian sea, around the area off Kerala's coast where MSC Elsa 3, a Liberia-flagged container vessel carrying hazardous cargo and calcium carbide, sunk the day before. It has deployed three vessels and an aircraft for counterpollution operations. The Coast Guard's Offshore Patrol Vessels ICGS Saksham, ICGS Vikram and ICGS Samarth utilised infrared cameras to detect the oil spill area and sprayed OSD (Oil Spill Dispersant) to contain the spread. A Dornier aircraft is conducting aerial assessment and OSD dispersal in the 2x1 nautical miles area where the spill has been detected. The vessels are churning the waters using hoses and propeller to mix the dispersant.

Meanwhile, ICG Ship Samudra Prahari, a specialised pollution response vessel carrying significant quantities of OSD, has set sail from Mumbai and is expected to reach Kochi on

The Coast Guard said in a release: "At approximately 0750 hrs on May 25, MSC Elsa 3 sank around 15 nautical miles off the coast of Kerala, southwest of Alappuzha. The maritime incident has raised environmental concerns, including the potential for oil spill impact and drifting of debris and cargo ashore along



Kerala's coastline.

Within 2-3 hours of the vessel's submergence, the ICG surveillance aircraft detected the presence of an oil slick at the site at 11 am, the oil slick was observed drifting in east-southeast direction at an estimated speed of 1.5-2 knots (around 3.7 kmph). By 2pm, the spill was assessed to have spread over an area of approximately 2x1 nautical miles"The ship had 84.44 tonnes of diesel and 367.1 tonnes of furnace oil when it sank, and this caused the oil

operations. The Mercantile Marine Department

(MMD), Kochi, has issued a warning to the vessel's owners regarding pollution liability and launched an investigation into the

MMD principal officer and Joint Director J Senthil Kumar met the 24 crew members of the sunken vessel on Monday. As the crew were yet to recover from the trauma, the MMD decided to record their statements on Tuesday.

It has directed the shipping agency to present the cargo manifest, a document that lists the contents and details of the shipment. As per information provided by the agency, there were 643 containers in the vessel of which 13 contained hazardous cargo and 12 had calcium carbide in it.

"Oil is normally shipped in tankers and the diesel and furnace oil in the vessel was not part of the cargo. It was the fuel stored to power the engine and for internal power generation," said an MMD official.The MMD will investigate whether it were flaws in loading the containers or bad weather that caused listing of the vessel. It has directed the shipping agency to deploy technical staff to salvage the floating containers and to explore the possibility of retrieving the oil from the ship's tank. However, the presence of large quantity of calcium carbide and hazardous cargo is posing

Government doctors must now prescribe medicines available in hospital pharmas

KALABURAGI. Medical Education Department will issue orders restricting the doctors serving in the hospitals attached to the medical colleges in the state from giving prescriptions to the patients to purchase medicines from outside.

Speaking to the media here, the Medical Education Minister Dr Sharan Prakash Patil said that usually the common people, especially the poor would visit the government hospital and they could not pay the doctors fees in the private hospitals and could not purchase the medicines. The government has decided not to give permission to open medical shops or Jaanoushadhi Kendras in the hospitals, to prevent the patients from paying an amount for the medicines as the doctors would give prescriptions and ask patients to purchase medicines from the medical shops or Janaushadhi Kendras.Dr Sharanaprakash said that the medical education department would restrict the doctors serving in the hospitals attached to medical colleges in the state from giving prescriptions to the patients for purchasing medicine from outside and an order would be issued in this regard in a

Taps run dry, tankers take over tempers rise in Gurgaon's BPTP Astaire Gardens

Gurgaon: Hundreds of families living in BPTP Astaire Gardens have been reeling under an acute water crisis for weeks, with no let-up in sight yet. The supply from GMDA has been erratic and inadequate, forcing 700 families of the residential society in Sector 70A to depend heavily on private tankers. Residents estimate they have spent nearly Rs 3 lakh on private water tankers this month alone. Despite multiple complaints to GMDA on May 3, 10 and 22, no tangible action has followed. Earlier, GMDA cited "pipeline damage", but residents say there has been no clear explanation or accountability since."We're spending from our own pockets for a basic necessity that the govt is supposed to provide us," Astaire Gardens RWA president Jaswant Rao said. On Monday, a delegation met deputy commissioner Ajay Kumar and submitted a formal complaint, demanding immediate restoration of supply and a long-term plan to prevent recurrence."This is mentally and financially exhausting," RWA general secretary Aruni Shukla said. "We pay taxes and water charges, yet we're left scrambling for tankers every day just to maintain basic hygiene."With summer pushing daily demand to nearly 8 lakh litres, the shortfall has been severe. Residents say GMDA's supply has declined steadily since mid-Mayhitting zero on May 22. "Not a single drop came that day. We had to survived on stored water and extreme rationing," said Rao.GMDA officials admitted a shortfall. A senior GMDA official said Sector 70A currently receives water via the Sector 51 boosting station. A new boosting station in Sector 72 is under construction and is expected to be operational by yearend.Officials also said water output at the Chandu Budhera plant has been augmented by 50 MLD to ease the pressure, but residents argue these long-term measures offer only little relief for their ongoing distress.

Of this, Rs 132 crore was recovered as EC, but the remaining – Rs 367 crore – was pending. HSPCB said that it runs into several obstructions in recovering EC.A key problem is that small-scale industrial units evade paying compensation by abandoning rented or illegally occupied premises after they are issued closure orders. These units operate in compact or open spaces, making enforcement and tracking difficult. Once vacated, the EC notices remain undelivered, it said. HSPCB also pointed out that the lack of any statutory mechanism or policy to write off EC

dues means that they keep mounting. There is no policy/scheme to settle or write off the environmental compensation of such units, and thus the amount remains outstanding," the May 20-submission by Krishna Kumar, regional officer, HSPCB (Gurgaonsouth), read."It is also necessary to bring into kind notice of this honourable tribunal that due to the absence of any statutory backup for imposition and recovery of environmental compensation, it is humbly prayed to this tribunal to implead the defaulter units and to initiate the action against them for recovery of the environmental

Kathmandu.Famed Nepalese Sherpa guide Kami Rita has scaled Mount Everest for the 31st time, breaking his own record for the most successful ascents of the world's highest peak. The 55-year-old climber leading stood atop the 8,849-meter summit at around 4 am on Tuesday under stable weather conditions, according to Mingma Sherpa, chairman of Seven Summit Treks, the expedition organiser.

He was guiding a team of the Indian Army Adventure Wing Everest Expedition, led by Lieutenant Colonel Manoj Joshi."This new feat cements his status as the record holder for the highest number of ascents to the top of the world - a record that no one else has come close to," the Kathmandu Post newspaper quoted Mingma as saying. "Kami Rita is safe and stable after his summit. He has started his descent and is on his way back to base camp," he added. "As always, Kami has demonstrated his unmatched skills and professionalism on the mountain. We are immensely proud of his achievement and the legacy he continues to build." In the last two years, Kami Rita scaled Mt Everest twice each season taking his successful summits count to 30.Kami Rita developed a deep passion for climbing from a young age and has been scaling mountains for over two decades, Chhang Dawa Sherpa, Expedition Director at Seven Summit Treks, said. His mountaineering journey began in 1992 when he joined an expedition to Everest as a support staff member. According to Dawa, between 1994 to 2025 Kami Rita also scaled K2 and Mt Lhotse one time, Manaslu thrice, and Cho Oyu eight times. Hundreds of climbers attempt to climb Mount Everest from the Nepali side each year.

Everest was first climbed in 1953 by New Zealander Edmund Hillary and Nepali Sherpa Tenzing Norgay.

Salman Rushdie Says He's "Pleased" Attacker Got Maximum 25-Year Sentence

world. Booker Prize-winning author Sir Salman Rushdie has said he is "pleased" that the man who brutally attacked him on stage in 2022 has been handed the maximum sentence of 25 years in prison.

The 77-year-old Indian-born British author was stabbed multiple times during an event at the Chautauqua Institution in New York, leaving him blind in one eye. Rushdie testified at the 2025 trial of Hadi Matar, a US citizen who was convicted of attempted murder and assault earlier this year.

Matar was sentenced to 25 years for the attack on Rushdie and an additional seven years for injuring another man who was on stage at the time.

Speaking to BBC Radio 4 on Monday, Rushdie said, "I was pleased that he got the maximum available, and I hope he uses it to reflect upon his deeds."

'AI Could Imagine a Conversation Better Than Reality"Rushdie also spoke about working with the late BBC producer Alan Yentob on a unique 2024 documentary, which used artificial intelligence to simulate a fictional conversation between the author and his attacker - a concept inspired by Rushdie's memoir Knife: Meditations After An Attempted Murder."I thought if I was to really meet him and ask questions, I wouldn't get very much out of him... So I thought, I could open that conversation myself probably better than a real one would go," Rushdie said, referring to the AI-generated dialogue.He added that the animation was "very startling" and "certainly made a point".

Remembering Alan Yentob

Rushdie paid tribute to Alan Yentob, who passed away on Saturday, calling him an "unbelievable champion of the arts" and "a giant of British media".

What Saudi Arabia Official Said On Reports Of Kingdom Lifting Alcohol Ban

Dubai. A Saudi official denied on Monday media reports saying the kingdom, the birthplace of Islam. would lift its 73-year-old ban on alcohol, which is prohibited for observant Muslims.

The report, which was picked up by some international media after it appeared on a wine blog last week, said Saudi authorities planned to allow the controlled sale of alcohol as the country prepares to host the 2034 soccer World Cup. It did not give a source for the information. The report sparked a vigorous online debate in the conservative kingdom, whose king also holds the title of Custodian of the Two Holy Mosques



 Islam's most revered places in Mecca and Medina. Saudi Arabia's de facto leader, Crown Prince Mohammed bin Salman, known as MBS, is pushing a series of reforms to open up the country for tourism and business, as part of an effort to strengthen non-oil sectors of the economy. The government ended its prohibition on allowing women to drive in 2017, and has eased some rules on sex segregation in public spaces and reduced the power of the religious police. A minor step towards allowing alcoholic drinks to be consumed in the kingdom was the opening of the first alcohol store in the capital, Riyadh, last year serving exclusively non-Muslim diplomats. Prior to that, alcohol was available only through diplomatic mail or on the black market. 27 In Hospital As Car Hits Liverpool Fans, Cops Rule Out Terrorism

Liverpool.A car ploughed into a crowd of Liverpool fans during a parade celebrating their side's Premier League soccer title on Monday, hospitalising 27 people, with two seriously injured, but police said they did not believe the incident was terrorismrelated. Police said they had arrested a "53year-old white British man from the Liverpool area," whom they believed to be the driver of the vehicle which struck a large group of supporters who were celebrating in the city in northwest England. Twenty people were treated at the scene. Ambulance officials said of the 27 taken to hospital, four were children. One child and one adult were in a serious condition. Four people trapped under the vehicle had to be released by firefighters.

Videos on social media showed people thrown into the air as the car rammed into spectators. When the car stopped, angry fans converged on it and began smashing the windows as police officers intervened to prevent them from reaching the

incident, and we are not currently looking for anyone else in relation to it. The incident is not being treated as terrorism," temporary Deputy Chief Constable Jenny Sims told reporters.

With most people off work for the Spring Bank Holiday, hundreds of thousands of fans gathered to watch the Liverpool team and its staff travel through the city centre on an open-top bus with the Premier League trophy.An eyewitness said the collsion happened about 10 minutes after the bus carrying the Liverpool team had passed by, the British Broadcasting Corporation reported. The same police force oversaw the response to the murder of three young girls in the nearby town of Southport last year, an incident which sparked days of rioting, fuelled by speculation online over the identity of the attacker.An eyewitness to Monday's incident who gave her name as Chelsea told BBC Radio that people packed onto

the street were only alerted to the danger by screams from the crowd. That enabled some to jump out of the way as the driver showed no sign of slowing."With the commotion, that was the only reason we looked up, and thankfully, looked up and managed to jump out (of) the way in time," the woman said.Liverpool last won the trophy during the COVID pandemic when celebrations were not

world. New Zealand Immigration Minister Erica Stanford is under fire for saying she "never responds" to emails from Indians, because she considers them "akin to spam." During a parliamentary session on May 6, defending her use of a personal Gmail account for official correspondence, Ms Stanford said, "I receive a lot of unsolicited emails like, for example, things from people in India asking for immigration advice, which I never respond to. I almost regard those as being akin to spam."

Indian-origin Labour MP Priyanca Radhakrishnan condemned the remarks as insensitive and discriminatory. Speaking to The Indian Weekender, Ms Radhakrishnan said, "Such comments reinforce negative stereotypes about an entire community," and called it unacceptable for a minister to single out a specific ethnic group.Ms Radhakrishnan described the comments as "careless at best and prejudiced at worst." She pointed out that ministers receive unsolicited emails regularly, so there was no reason to single out emails from Indians. "Particularly given New Zealand's important relationship with India," she said, "comments like these serve to reinforce negative stereotypes against an entire community of people."Erica Stanford later clarified, saying she had been misinterpreted. "I did not say that I consider them as spam," she explained. "I only said that I consider them almost akin to spam."

She defended her statement, saying it referred to the volume and nature of unsolicited emails she receives on her personal email, not Indians specifically. "In

this instance, I recalled a recent email I'd received of this nature when answering," she said.

Erica Stanford has been serving as New Zealand's Minister of Immigration since November 27, 2023. She assumed the role following the formation of the National-led

Netanyahu's remarks came after a Palestinian official on Monday said that Hamas has agreed to a 70-day ceasefire proposal by America, only for US envoy Steve Witkoff to later reject the notion that Hamas had accepted his offer.An Israeli

official also dismissed the proposal, saying no responsible government could accept such an agreement, as they rejected the assertion that the deal matched one proposed by Witkoff.Later, in a recorded message on social media, Netanyahu said he "hoped very much" he would be able to deliver developments on the subject of Israel's fight against Hamas and releasing the hostages, "today and if not today then we will tomorrow"."We intend to bring them all back, the living and the dead," he added, but made no mention of a proposed deal. The Palestinian official, who is close to Hamas, had told news agency Reuters that the so-called Witkoff proposal, which the group reportedly agreed to, would see the release of 10 hostages and a 70-day ceasefire and was received by Hamas through mediators."The proposal includes the release of 10 living Israeli hostages held by Hamas in two groups in return for a 70-day ceasefire and a partial withdrawal from the Gaza Strip," the source said.

It also included the release of a number of

Palestinian prisoners by Israel, including hundreds serving lengthy prison terms. Witkoff nonetheless disputed Hamas's claim that the group had agreed to his proposed deal, telling Reuters that what he had seen



was "completely unacceptable" and the proposal being discussed was not the same as his.Israel-Hamas WarFighting meanwhile raged in Gaza, where civil defence agency spokesman Mahmud Bassal said that an early-morning Israeli strike on the Fahmi Al-Jarjawi school, where displaced people were sheltering,

killed "at least 33, with dozens injured, mostly children". The Israeli military said it had "struck key terrorists who were operating within a Hamas and Islamic Jihad command and control centre embedded" in the area, adding that

"numerous steps were taken to mitigate the risk of harming civilians". Bhovi Corporation scam case: ED attaches assets of former top officials



BENGALURU. The Directorate of Enforcement (ED) has provisionally attached immovable properties worth Rs 26.27 crore (current market value of Rs 40 crore) of BK Nagarajappa, R Leelavathy and other accused under the Prevention of Money Laundering Act (PMLA), 2002, in a case related to misappropriation of funds at the Karnataka Bhovi Development Corporation (KBDC).

In an official release on Monday, the ED said the investigation revealed that Nagarajappa, who was then general manager, and Leelavathy, then managing director, of KBDC, in connivance with middlemen and their associates, misappropriated funds by sanctioning loans/subsidies/financial assistance to the bank accounts of more than 750 fake beneficiaries, which were fraudulently

"Later, the amounts so sanctioned from KBDC were diverted to the bank accounts of various entities controlled by Nagarajappa and others, which was used in purchase of properties, making payments to middlemen and diverted to bank accounts of individuals and various other entities," it added.

Andhra Pradesh's Kuppam to get Shreeja, Mother Dairy units

VIJAYAWADA. Chief Minister N Chandrababu Naidu announced a significant step towards economic development of Kuppam, revealing investment plans of Shreeja Milk Producer Organisation, and Mother Dairy during a meeting with their representatives on Monday. The initiatives, which are in tune with the State government's Swarna Andhra Vision, aim to eradicate poverty, and bolster the rural economy.

As part of the agreement, both the companies have been allotted land to establish industrial units in Kuppam under the Kuppam Area Development Authority

Shreeja will set up a dairy and animal feed processing unit, while Mother Dairy will establish a fruit pulp processing unit. These projects are expected to create 8,000 jobs, providing a major boost to local employment. The new units will focus on directly procuring milk and horticultural produce from local farmers, a move aimed at enhancing ryot income, and strengthening the rural economy.

The Chief Minister emphasised importance of inclusive development in the region, and directed both the companies to complete their projects within 15 to 18 months.

CHENNAL Three students of the Rajiv Gandhi National Institute of Youth Development (RGNIYD) functioning under the Union Ministry of Youth Affairs and Sports in Sriperumbudur have alleged that the institution has arbitrarily rusticated them on the charge of defacing hostel property with "content of an anti-national" nature. Aslam S, Sayeedh M A, and Nahal Ibnu Abullaise were pursuing second and final year of Master of Social Work (MSW) at the institute and were supposed to write their final exam on Monday. However, they were served rustication letters on Sunday,

suspending them from the institute and expelling them from hostel. Institute authorities could not be reached for a comment until Monday night. Messages and calls to institute Director Subrata Hazra and Disciplinary Committee Chairperson S Suresh were not answered.Students claimed the institute had "planned" the episode.

Targeted for stir against staff: Rusticated



The students added that this was done to disallow them from writing the exam. "We have been targeted by the administration for taking lead in a recent protest demanding the resignation of a senior administrative staff against whom sexual harassment charges have been leveled," Nahal told .According to Nahal, on May 22, a few hostel officials noticed slogans such as "Free Palestine" and "Jai Bhim" written on the hostel wall, following which they inspected the hostel.

However, Nahal contended that the inspection was limited to only a few rooms on a single floor. Acknowledging that they found some empty beer bottles and fabric colors in their room, Nahal alleged the authorities immediately jumped to conclusion and took action against the three and four more students in the room. While the three were rusticated forthwith, the other four were expelled from hostel but allowed to sit for the exam. Food, relief materials arrive for Chinnarpathi tribals in Coimbatore

They encouraged the people to move to the relief camp for their safety. However, the people declined, stating they would consider moving only if the situation

the current situation. Living under makeshift roofs is routine for them. They assured us that they would use the relief camps if conditions become more difficult. Therefore, we have decided to let them stay in their village while keeping the camp in a ready status," said Pollachi Sub-Collector (In Charge) Viswanathan. According to revenue officials, food and rations have been arranged for the people at Chinnarpathi. Additionally, repair work is underway on their makeshift shelters to help manage the rainfall.Meanwhile two houses collapsed

due to heavy rain - one at Anna Nagar in the Vettaikkaranpudur town panchayat on Sunday, and another near the Solayar dam area on Monday. The families affected are currently staying with neighbours and have also declined to use the relief camps. Officials have provided them with rations and food as well, the Sub-Collector said.

At a high-level meeting of the temple administration, presided by Puri king Gajapati Dibyasingha Deb on Monday, it was decided to seek legal and intellectual protection of words like Shree Jagannath Dham, Srimandir, Purushottam Kshetra, Purushottam Dham, Mahaprasad, Srikshetra, Neelachakra and the logo of the

The decision of Shree Jagannath Temple Administration (SJTA) to seek legal protection comes in wake of the controversy surrounding the naming of Jagannath temple at West Bengal's Digha as Jagannath Dham. Chief administrator of the shrine Arabinda Padhee said certain words which are linked to the Srimandir and its various rituals should not be used by any other temple for any purpose.

'Hence, we have decided to legally protect these words. Trademarking or copywriting them will be an important move in this direction," said Padhee. The meeting also took a decision to regulate the height of new buildings coming up around the Srimandir and Gundicha temple to maintain the visual prominence of the two ancient shrines.

The victim Hrithiksha was the only daughter of Vanishree and Ashok and hailed from Goravanahalli village in Maddur taluk. Earlier in the day, the girl was bitten by a stray dog while playing near her home. Vanishree and her brother-in-law Baskar Gowda took the girl to the Maddur government hospital. The doctors there gave her first aid and then referred her to MIMS Hospital in Mandya owing to the unavailability of the required anti-rabies vaccine at



At around 10:30 am, the bike carrying Hrithiksha, her mother, and uncle was stopped by traffic police near Swarnasandra for riding without helmets. After Vanishree explained the medical urgency, the police allowed them to proceed. But just a few metres away, another traffic policeman attempted to stop them again. In the confusion, Gowda lost control of the bike. While he fell to the left, Vanishree and Hrithiksha fell to the right, directly in the path of an oncoming truck. The truck ran over the child, resulting in fatal head injuries. The incident sparked public outrage.Grieving family members, relatives, and members of the public gathered outside MIMS Hospital and staged a protest on the highway by placing the child's body on the road. They demanded immediate action against the police personnel involved, accusing them of negligence.

Mandya Superintendent of Police Mallikarjun Baladandi rushed to the scene and attempted to pacify the protesters. Following mounting pressure, he announced the suspension of three traffic ASIs - Jayaram, Nagaraju, and Gurudev - attached to the Mandya traffic police station.SP Baladandi said, "Preliminary investigation has revealed that the officers failed to follow proper procedure during the inspection. A departmental inquiry has been ordered. Meanwhile, I have instructed all police personnel to avoid vehicle inspections that could endanger public safety.

Centre-state synergy should boost startup ecosystem

THIRUVANANTHAPURAM. It was quite an exciting and eye-opening experience to Experts point out that proficiency in space be part of a group of defence vloggers who were discussing a remotely piloted aerial vehicle (RPAV) developed recently by a fledgling startup that won the Centre's iDEX (Innovations for Defence Excellence) challenge.

As operational pictures emerged, a Malayali vlogger remarked, "Imagine this launcher on a small patrol boat. With proper training and situational awareness, the Navy can wreak havoc with this. Good stuff from the startup - hope they succeed."Such innovation reflects the growing momentum among young minds aiming to break into defence technology, particularly following Operation Sindoor, Here, Kerala's strategic relevance is underscored by its status as home to the national space agency and as a rising hub for startups."Most startups are now in the space sector, although defence has been getting attention in the last few years. The products are finishing only now after incubation," said Varun G, technical officer at Kerala Startup Mission (KSUM), which reportedly has tie-ups with about 60

defence-based startups

technology translates effectively into defence capabilities. Prateesh V Nair, CEO of space startup Tachlog, explains: "Whatever you do in space, the same can be done in defence with not as much complexity. We are a space startup but are now aggressively pushing into defence as well."Prateesh sees this sector only growing. The key word is indigenisation. What we witnessed recently was a direct result of the Atmanirbhar Bharat initiative," he said."For example, we used our own NavIC (Navigation with Indian Constellation) system instead of relying on the US-based GPS for surveillance. Kerala has potential - but it must be requirementdriven. Defence prefers end-to-end products, not just specific parts or projects, which makes funding more challenging. Now, with IDEX stepping in, opportunities will only grow."

Prateesh also highlights the risks of collaborative efforts like the Indo-Russian BrahMos missile. Such partnerships involve tech transfers, but with deterrents in place to



prevent use against the partner nation in future conflicts."Every country does this. If we devise systems ourselves, we are in full control," he said.

Lok raj without lok laj is a hollow democracy

THE popular but much-mocked Devi Lal, former Deputy Prime Minister of India, once said, "Lok raj lok laj se chalta hai." He was one of the tallest farmer leaders of the country, with an incomparable connect with the people, especially in rural areas. He both regaled and riled people with his rusticity. But this article is not about him; it is about what he famously said. For those in power in a democracy, it is an axiom summed up in the word 'laj', for which there is no exact equivalent in the English language.

Lok raj is simple to understand, for it is the power that the people exercise in an elected democracy. It is the power, the right to elect people, that the Constitution provides and protects. Lok laj, on the other hand, doesn't emanate from the Constitution; it emanates from the character of a society that is reflected in individual behaviour and its normative response to individual conduct.

I recently wrote about the growing incidence of crime and no punishment (The Tribune, March 12), a disturbing trend witnessed in our system, which doesn't bode well for an orderly society. A crime is established on the basis of evidence; the ingenuity of legal arguments help courts determine an illegality or dismiss it. Societies, however, have long existed before the legal system came into being, or was codified. Laws change faster than social mores. Order in a society has been the outcome of compliance with the law as well as the observance of common ethics.

Take, for instance, the dictum Satyamev Jayate (truth always triumphs), an exhortation to speak the truth. Whether it triumphs or not in these days and times is a different matter. It is a human value propagated in every society and in most families. However, except for perjury, not speaking the truth is not illegal. While perjury could be punished by law, how do we deal with falsehood? How do we deal with those who publicly speak untruth? We have seen many recent examples where the utterances of the BJP's elected representatives have offended common sensibility. A minister in Madhya Pradesh referred to a lady army officer briefing the media during Op Sindoor as a "sister" of those who killed innocent tourists. The government chose her as part of an impactful communication strategy, a woman army officer belonging to a minority community, the face of a system delivering justice to the victims of an inconceivably ghastly act. By inventing a fraternal bond between her and the terrorists based on a common religion, the minister displayed a perverse mind, the kind you need to carry forward a nefarious communal agenda. The Supreme Court has set up an SIT to probe his conduct, but that was necessitated because he wasn't chastised by his own organisation. Nor was he genuinely chastened by his own conscience, his clever expression of regret notwithstanding. No leader of his political party reprimanded him publicly; nor did his organisation take him to task for the reprehensible comment.Moreover, what can be a more heartbreaking and pathetic example of this crass insensitivity than the utterances of the Haryana BJP MP who accused the unfortunate women who suffered the loss of their husbands during the Pahalgam massacre, of lack of "courage" and "training" to fight the terrorists? Is he suggesting that the state is vanishing and law enforcement should be an individual responsibility? The law cannot punish him for what he said because there has been no violation of the law; also, his party leadership might exhibit "broad shoulders" and "tolerance". But should he not be publicly castigated and made to pay by his party?

In both cases, a brazen abandoning of Lok Laj is clear, by both politicians and their party leadership. That amounts to a social approval of their conduct, allowing them to live without guilt even if the law were to punish them.

To render Pakistan irrelevant, analyse it meaningfully

In stark contrast, the China Study Group and multiple think tanks focus on the study of China. The MEA runs the Centre for Contemporary China Studies.

I met the first Pakistani in the UN Mission in Angola in 1992, when I was a Major with 15 years of service. I was a staff college graduate and had battled militancy in Punjab. The proxy war in the Kashmir valley was then in its nascent stage. In keeping with the requirements of military diplomacy, I drew on my reserve of Urdu, picked up from movies like Waqt, Taj Mahal and Kanoon, to strike a conversation with the Pakistani. He enquired whether I knew Punjabi and, if so, why I was being a mohajir. That broke in my mind the stereotype of an Urdu-spewing Pakistani. It was a rude reality check. Every time he visited my HQ, I accommodated him in my container, to understand his psyche. The March 11 hijacking of the Jaffer Express in Pakistan, allegedly by the Balochistan Liberation Army, evoked much interest and even

celebrations on social media. But it didn't wake up our intelligence experts, who should have anticipated an immediate, violent reaction. After all, 380 passengers had been taken hostage and 18 soldiers and 13 civilians killed. It didn't take long. Within six weeks, the dastardly Pahalgam attack had taken place.

The obvious question is — do we suffer from some sort of complacency in our analysis of the intentions and capabilities of our western neighbour? We have been following the policy of no dialogue and minimum contact with Pakistan for about a decade. It has been recently reiterated that terror and talks/trade will not be permitted; and blood and water cannot be allowed to flow together. These are indeed

complex and difficult goals to achieve. One such goal was the restoration of the 2003 ceasefire on the Line of Control in February 2021, aided by backroom parleys, possibly facilitated by the UAE.After Pahalgam, suddenly our experts decided that Pakistan's Army chief (now Field Marshal) Syed Asim Munir, was the main culprit. But the first shot had been fired by Lt Gen Ahmed Sharif Choudhary, DG-ISPR, immediately after the Jaffer Express fiasco. He vowed 'badla' (revenge) and blamed R&AW for the train hijack. Certainly, this was accentuated by the highly provocative statement on the 'two-nation' theory by Munir.It may be appropriate to recount that the diabolic drift in the Pakistan army was initiated by Gen Zia-ul-Haq, who was IMA-trained, St Stephen's college-educated and hailed from Jalandhar. Zia gave the Pakistan army a theological twist, with the new motto — 'Iman, Taqwa, Jihad-fi-Sablillah' — and, most surprisingly, added the defence of ideological frontiers in its role.

Gen Aslam Beg, another mohajir from Azamgarh, triggered the proxy war in Kashmir. It was sustained by others like Gen Pervez Musharraf, a mohajir with roots in Neharwali Haveli in Delhi.

Now Gen Munir is a sort of outlier and 'dark horse', a rare OTS achiever, with an intelligence (DGMI and DGISI) background. His posting profile is peppered with India-focussed appointments. After nearly two and a half years at the helm, there is no point in being surprised at his 'mullah' orientation. Born to an 'imam'



father, hailing from Jalandhar, he had a madrasa education. Like Zia, his parents are both Punjabi and mohajir. Surprisingly, he earned the title of Hafiz by attending the Koran recitation course in Saudi Arabia, while on diplomatic assignment. His description of Kashmir as the "jugular vein" is not new; it has been a constant theme with Pakistani generals. Only a few years back, Gen Kayani described the same phrase in Urdu as India's 'shah rug' — Munir, in fact, has inappropriately termed it as Pakistan's "jugular vein." The timing of Munir's uncalled-for diatribe was probably triggered by his yearning to recover his plummeting popularity. He was also unsettled by the chief, Gen Jehangir Karamat and other senior veterans. calling for a review of the ongoing mismanaged operations in Khyber Pakhtunkhwa and Baluchistan.

To quote Sun Tzu on the enemy, "Know thy enemy and know yourself, and in a hundred battles, you will never be in peril." I would be audacious to add a few supplementaries to this seminal wisdom, reflecting on our approach to Pakistan. First, we know our enemy; unlike the Chinese, they are not complicated. Second, they are irrelevant; so you may well ask, where is the need to formally study them? In stark contrast, the China Study Group and multiple think tanks focus on the study of China. The MEA runs the Centre for Contemporary China Studies. While China is the primary and complicated adversary, Pakistan remains

the persistent and prickly one. Pakistan considers India the raison-d'etre for its existence, and seeks parity and attention. It certainly has the propensity to continue to surprise us — unveiling the 6th Armoured Division in 1965, invading India at Kargil in 1999 and more recently, using sophisticated Chinese missiles and weaponry in the recent conflict with India.

Fragically, we have no study groups and think-tanks to analyse our western adversary. We must make do with Twitter/TV channel warriors, who capture Karachi, Lahore and PoK periodically.

It is time to make amends so that we begin to acquire a meaningful understanding of Pakistan. Critical to our study will be the ability to differentiate between three segments of the population — the

military establishment, mullahs (clergy) and the awaam (public). Significantly, despite limited or no government contact in the last decade or so, the Internet remains porous. People on both sides of the Radcliffe Line in Punjabcommunicate in Shahmukhi (Punjabi written in the Persian-derived script). But for some mystical reason, the decision to set up the Shahmukhi Linguistic Centre at Panjab University was dropped after the VC changed in 2018; although Panjab University in Lahore did set up its Gurmukhi Department and Chair later. Gaza war is a case of free speech versus loyalty test for Trump

President Donald Trump has conflated criticism of Israel with anti-Semitism, stifling free speech instead of addressing the root causes of protests on university campuses

At a time when the Trump administration is fixed on purging academic campuses of pro-Palestinian activists, two staffers of an Israeli embassy were shot dead by a lone assailant in Washington. They were exiting a Jewish museum, barely two kilometres from the White House, when the gunman pulled the trigger. The killer later entered the museum and raised 'Free Palestine' slogans as security forces took him into custody. The Washington shooting is an awful instance of how geopolitical strife can ignite lone-wolf violence, putting diplomatic personnel and civilians at risk worldwide.

There can be no justification for taking any human life under whatever pretext. However, anti-semitic toxicity is at its highest across the world, most of which is self-inflicted. Whatever sympathy Israel had in the wake of the brutal Hamas incursion of 2023 that killed 1,700 people in Israel has evaporated after its blistering counterattack that has left at least 52,000 people in Gaza dead. Particularly heart-wrenching was the

bodies of nine of a doctor's 10 children, killed in a recent



Israeli airstrike, arriving at a Gaza hospital where she was attending to patients. Despite Israel's scorched earth policy that has nearly razed Gaza, the Hamas militia continues to survive in its tunnels and hold hostages, though their support systems from Iran and Hezbollah have largely weakened. Instead of actively pursuing a negotiated settlement for the release of hostages, Prime Minister Benjamin Netanyahu has expanded the war and choked humanitarian aid, leading to global outrage. Israel's closest allies are also no longer on the same page—the UK has paused trade talks, France and Canada have threatened sanctions, and the EU has begun reviewing a bilateral pact. The US, however, remains an outlier. President Donald Trump has conflated criticism of Israel with anti-Semitism, stifling free speech instead of addressing the root causes of protests on university campuses. He appeared implacable as he announced a crippling fund squeeze on Ivy League universities and barred Harvard from foreign student intake unless it shared information on participants of the

anti-Zionism protests on its campus. That hung out to dry around 7,000 international students, about 800 of whom are Indians, before a court stayed the unsound Trumpian order. The clash of civilisations appears to be at its peak and needs no further escalation.

Operation Sindoor has ticked the right boxes

India has stuck to its guns despite international pressure, unlike Op Parakram of 2001-02

A defining feature of Operation Sindoor, which has been paused for the time being, is that India launched it without being perturbed by international opinion. This approach is a far cry from how things panned out during Operation Parakram, which began shortly

after terrorists attacked Parliament on December 13, 2001.At that time, several Cabinet meetings were held to monitor the situation and work out an action plan. The military mobilisation underlined India's resolve to punish Pakistan. A strike by the Indian Air Force (IAF) on a terror camp was proposed with the aim of deterring Pakistan from sponsoring terror attacks. However, some Cabinet members were apprehensive that an airstrike could make the situation spin out of control. For that reason, proposals to strike the terrorists' headquarters in Bahawalpur and deploy the Navy in the Arabian Sea to carry out a blockade of Karachi, as and when required, were declined.International pressure started mounting on India to call off the offensive because some countries feared that Pakistan

may use nuclear weapons. Presidents of the US and Russia voiced their concerns. The India-Pak skirmish upset the Americans, who were deeply involved in Afghanistan following the 9/11 attacks. They did not want any distraction caused by a war in Afghanistan's neighbourhood. Besides, the US needed Pakistan's support for their Afghan engagement. A series of events happened in the first two weeks of January 2002. LK Advani, then Home Minister, travelled to the US. The Americans told him that they would persuade Pakistan President Gen Pervez Musharraf to avoid going to war. Prodded by the US, then UK PM Tony Blair visited India to dissuade the Vajpayee government from taking military action. In a public speech on January 12, Gen Musharraf promised to



reduce tensions; he condemned the Parliament attack but emphasised his stand to use nuclear weapons in accordance with Pakistan's right of 'first use'. His speech was reason enough for the Indian government to call off the planned airstrike. By then, around 500,000 Indian and 300,000 Pakistani troops had been deployed at the border. On May 14, 2002, Pakistani terrorists attacked an Indian Army camp at Kaluchak (J&K), killing 30 people, mostly wives and children of defence personnel. However, Pakistan

refused to extradite the terrorists' handlers, even as Lashkar-e-Taiba continued to operate under a new name. The Indian Cabinet felt that a limited airstrike India's response this time has been kinetic as well as would serve no purpose under these circumstances.

By May-end, both India and Pakistan were fully mobilised. Pakistan's terror network was extremely well organised. It was practically used as an extension of the Pakistan army and was given huge technical and financial support.On June 5, 2002, then US Deputy Secretary of State Richard Armitage extracted a commitment from Gen Musharraf that he would stop cross-border terrorism and dismantle infrastructure supporting terrorism. On June 10, India called off Op Parakram and the entire strike plan against Pakistan with the hope that the promise secured by the Americans would be

However, the 'love story' between the Pakistan army and terror outfits continued unabated. India witnessed one major terror attack after another — Mumbai (2008), Pathankot and Uri (2016) and Pulwama (2019). The April 22 massacre in Pahalgam was promptly followed

the deployment of the Navy's Carrier Battle Group in the Arabian Sea and the suspension of the Indus Waters Treaty. On the intervening night of

May 6-7, Operation Sindoor was launched. The IAF struck nine terror sites inside Pakistan and PoK. In retaliation, Pakistan sent some 300 drones across the border, the majority of which were lightweight quadcopters; in between them were embedded unmanned combat aerial vehicles (UCAVs) that carried munitions. These UCAVs were identified and

shot down by the Indian air defence system; they caused practically no damage to Indian assets.

This resolve was reflected in the directions to the armed forces. Decisions were taken spontaneously and fearlessly.



NEW DELHI. The Delhi High Court on Monday issued summons to political commentator Abhijit Iyer-Mitra in connection with a Rs 2 crore defamation suit filed by Newslaundry Executive Editor Manisha Pande and eight other women journalists. Mitra's Advocate Percival Billimoria told that all the contentious tweets had been removed. But counsel for the journalists, Bani Dikshit, countered that deleting the posts did not reflect genuine regret. "There's no sign of remorse. In fact, he continues to post poetic remarks on the issue," she said. Despite these, Billimoria sought dismissal of the case.

However, the bench declined to be drawn into unrelated allegations. "This case is strictly about the posts. If there are other concerns, they must be pursued separately," the judge said.Dikshit informed that her clients intended to pursue damages, along with an injunction to prevent any future defamatory content. Justice ordered issuance of summons and maintained the interim relief in favour of the journalists.

2020 Delhi riots case: Court orders chargesheet copy to respondents on pen drive

NEW DELHI. A Delhi court has directed the police to supply a digital copy of the chargesheet in the 2020 riots conspiracy case to all respondents within three working days. The order came during hearings on revision petitions challenging a magistrate's directive for further investigation into the role of Delhi's Law Minister Kapil Mishra and others. Special Judge Dig Vinay Singh of the Rouse Avenue Courts on Monday asked Special Public Prosecutor (SPP) Amit Prasad to furnish the chargesheet on a pen drive to all respondents.

The court also instructed complainant Mohd



for compliance on May 31. Till then, the interim stay on the trial court's order will remain in effect.

The directions were issued while the court was hearing two revision petitions, one filed by the Delhi Police and the other by Kapil Mishra, both contesting the Additional Chief Judicial Magistrate's order for further investigation. The original order stemmed from a complaint filed by Illiyas in the MP-MLA court seeking action against Mishra and others for allegedly inciting violence during the 2020 Delhi riots. Appearing for the police, SPP Amit Prasad raised questions about the magistrate's jurisdiction. He argued that the case FIR was already being dealt with by a designated special court. Prasad also noted that the complaint had not been filed with the Station House Officer (SHO) as required for FIR registration, but instead had been emailed to several public officials, including the Prime Minister and the Delhi Police Commissioner.

She said that the 100 days have established a new work culture, commitment to public service, and a model of transparent governance. The government's decisions to bring about real change in people's lives are backed by a Rs 1 lakh crore budget focused on infrastructure development.

Sources said that the government implemented the Ayushman Bharat Yojana in the healthcare sector. The Vay Vandana Yojana' was launched for senior citizens aged 70 and above, offering cashless treatment up to Rs 10 lakh. The establishment of 1,139 Ayushman Arogya Mandirs, 11 Integrated Public Health Labs, and nine Critical Care Hospital Blocks is underway.

Covid-19 situation fully under control, says government

NEW DELHI. The national capital has reported 99 new Covid-19 cases over the past week, bringing the total number of active cases to 104, according to data from the Ministry of Health and Family Welfare. As Delhi crossed the 100-mark in active infections, CM Rekha Gupta on Monday assured the public that the government is closely monitoring the situation and has issued necessary guidelines to all hospitals.

'There is no need to panic. We are keeping a close watch, and clear instructions have been issued to hospitals to stay prepared," said CM Gupta. She emphasised that all state-run hospitals are fully equipped to handle the situation and manage any rise in cases.Last week, the Delhi government issued a Covid-19 advisory directing hospitals to ensure the availability of beds, oxygen supplies, essential medicines, and vaccines.

"Hospitals must ensure complete preparedness, including availability of beds, oxygen, antibiotics, essential drugs, and vaccines. All equipment-such as ventilators, BiPAP machines, oxygen concentrators, and PSA plants-must be in working condition," the advisory stated.

It also instructed all healthcare institutions to send positive Covid-19 samples for genome sequencing to Lok Nayak Hospital. Health Minister Pankaj Singh stated that authorities are also verifying whether the reported patients are residents of Delhi or have a recent travel history.

According to an official, the operation was launched based on intelligence inputs about the presence of Maoist commander Nitesh -- who carries a reward of Rs 15 lakh -- and his squad in Sitachuan, a forested area on the border

of Mohammadganj and Haidernagar police station

Sanjay Godram, another Maoist with a bounty of Rs 10 lakh, is also believed to be part of this group.As police and security forces closed in on the location, Maoists opened fire, prompting the forces to retaliate. This encounter comes a day after a similar operation in Netarhat police station area of neighbouring Latehar district,

where Maoist commander Manish Yadav, who carried a Rs 5 lakh reward, was killed. Another Maoist, Kundan Kharwar, with a bounty of Rs 10 lakh, was arrested during the same operation. On May 24, in an encounter in Ichwar forest of Latehar, Maoists Pappu Lohara (Rs 10 lakh reward) and Prabhat Lohara (Rs 5 lakh reward) were killed, and another injured Maoist was arrested.

Why Indian cities get submerged overnight. No, it's not just rain

New Delhi. In the early hours of Sunday, May 25, Delhi recorded 81.4 millimetres of rainfall in just a few hours. The rain marked the capital's wettest May since 1901. Similarly, Mumbai on Monday broke its 107-year record for the highest May rainfall. The result: Delhi's Minto Road underpass, a recurring emblem of its urban flood woes, went underwater yet again. In Mumbai, the flooding was so severe that not just roads and streets, but even a newly inaugurated underground metro station on the Aqua Line was inundated with rainwater. The main and immediate culprit is, of course, the relentless rainfall, the one natural factor. But what truly turns heavy rain into urban chaos and hazard in Indian cities, as seen in Delhi and Mumbai this weekend, is a mix of human-induced factors that compound the impact of multifold. And even the natural factor, rain, has become more erratic due to climate change, which is largely anthropogenic, driven by

unchecked emissions, poor urban planning, among other factors.

While multiple factors contribute to urban flooding, such as a city's topography, poor drainage, urbanisation, impermeable surfaces, and inadequate stormwater management, the way these factors play out varies significantly from one city to another. These cityspecific factors explain why a city like Delhi, where the Aravalli hills create a natural slope draining west to east toward the Yamuna River, experiences floods, and Mumbai, despite being surrounded by the vast

Arabian Sea, four rivers, and numerous creeks, faces similar urban flooding challenges. Why does Bengaluru, sitting atop a ridge, see urban floods?A closer look at four Indian metros, Delhi, Mumbai, Bengaluru, and Chennai, reveals how different factors play out to create these unique vulnerabilities, contributing



to urban flooding in each of these cities. WHAT ARE URBAN FLOODS? YES, IT'S DIFFERENT FROM REGULAR FLOODING

Urban flooding occurs when heavy rainfall overwhelms the drainage capacity of cities and towns, often due to constraints put up by flawed urbanisation, concretisation of surfaces, and poor

planning defying the topography. Unlike rural floods, which typically result from river overflow or monsoon-swollen basins over a larger timeframe, urban floods are sudden and localised. These flood peaks can rise 1.8 to eight times faster than normal, and the amount of water can be up to 6 times more, says the website of the National Disaster Management Authority (NDMA).In contrast, rural floods, like the annual ones in northern Bihar, are caused by Himalayan rivers bringing in large amounts of water during the rainy season, which

play out over days or weeks. Though massive in scale, they follow predictable patterns. Urban floods, however, strike unpredictably, often paralysing cities within hours. This distinctness also reveals a different and more infrastructure-centric vulnerability in our urban spaces.





Look Beautifu By the time you've reached your late 20s,

Collagen and elastin fibres are present beneath the skin's surface around your mouth and eyes. They begin to gradually break down as you age — this leads to fine lines and wrinkles. Use a cream with vitamin A or retinol, which helps in their reduction.

Saggingskin

As you get older, the skin starts to lose its elasticity which in turn leads to sagging. To treat sagging skin, use an agediffusing serum for firmness.

Visible pores

Those with oily or combination skin suffer from visible pores. Use a good anti-ageing foaming cleanser and a toner daily to reduce the enlarged pores.

Uneven skin tone

Age spots or uneven skin tone can happen due to

hormonal disorder, exposure sunlight etc. Use an anti-ageing cream that corrects the skin tone and a firming serum to treat uneven skin.

Causes of skin-ageing

Says dermatologist Dr Jamuna Pai, "The skin ages due to external and internal factors. Among internal factors, decrease in elastin production, less turnover of new skin cells and the inability of the skin to retain moisture are the main reasons. The external factors include lifestyle change and environmental



damage like constant exposure to sunlight, poor diet, t o o much stress and lack of exercise."

In your mid 20s, your skin is in its prime. Ageing does not happen overnight, it happens over a period of time. Though you can't evade it, you can delay it if you take good care of your skin well in

<u>How to care for mature skin</u>

Says beauty expert, Aakriti Kochar, "Trying to hide mature skin with make-up is not the solution. The make-up will stay for only two hours or so and then your skin will come back to its normal state. To treat mature skin, you need to regularly cleanse, tone and moisturise your skin."

Opt for creams rich in vitamins C and E,

which help counter the effect of sun exposure and reduce wrinkles.

Rakesh Gangwal to sell 3.4 per cent stake in IndiGo for Rs 6,800 crore

New Delhi. InterGlobe Aviation promoter Rakesh Gangwal and his family trust will offload another 3.4% stake worth at least Rs 6,831 crore in the airline on Tuesday, according to sources. Currently, Gangwal and the family trust together hold about 13.5% in IndiGo.Under the proposed transaction, up to 1.32 crore equity shares will be sold at a floor price of Rs 5,175 per share. The floor price is at a 4.5% discount compared to the closing price of Rs 5,420 per share on Monday. Investment banking firms Goldman Sachs (India) Securities Pvt Ltd, Morgan Stanley India Company and J P Morgan India are the placement agents for the fresh stake sale. Gangwal, who co-founded India's largest airline IndiGo, has been offloading his stake in a phased manner following a bitter fallout with co-founder Rahul Bhatia over alleged corporate governance issues. The share sale is part of Gangwal's decision in February 2022 to trim his shareholding in the airline. He sold a 5.24% stake in InterGlobe Aviation in August last year for Rs 9,549 crore. The fresh offloading will be the sixth time in less than 3 years when Gangwal would be reducing his holding in the airline. The stake sale again comes when IndiGo shares continue to hit new highs. So far in 2025, IndiGo shares have risen by 18%.Last week, IndiGo reported a profit of Rs 3,067.5 crore for the quarter ended March on the back of strong domestic travel demand. The company had posted a net profit of Rs 1894.8 crore in the year-ago period.

Volvo to slash 3,000 whitecollar jobs in restructuring move: Report

NEW DELHI. Volvo Cars has decided to cut around 3,000 office jobs as part of a major cost-saving plan. The Swedish carmaker is facing rising costs, weaker demand for electric vehicles (EVs), and trade uncertainties, reported Reuters. This decision comes just weeks after the company's former CEO, Hakan Samuelsson, returned to lead Volvo again. In April, he shared a plan to reduce expenses by 18 billion Swedish crowns (about \$1.9 billion).

A major portion of the cost-cutting will come from trimming white-collar roles, which account for around 40% of the company's total staff. Globally, the company has about 29,000 employees in Europe, 10,000 in Asia, and 3,000 in the Americas. Samuelsson said the job cuts will happen across different departments, like research, human resources, and communication. Volvo Car's new finance chief, Fredrik Hansson, added that while all parts of the business will be affected, most of the job losses will be in Gothenburg, Sweden. According to Volvo Cars, nearly 15% of its office employees will be laid off, with the move expected to cost 1.5 billion crowns in restructuring charges. However, the move will help make its structure more efficient, said the company. One of the key concerns for Volvo right now is trade tensions, especially with the US. Since most of its cars are made in Europe and China, new US tariffs could hit Volvo harder than other European brands. The company even warned it might not be able to sell some of its more affordable cars in the US if duties go up. Volvo plans to complete its new business structure by autumn this year. According to analyst Hampus Engellau from Handelsbanken, the job cuts were expected, and the move could help the company become leaner and more focused in the long

Meet Vacharaesorn Vivacharawongse, Thailand King Rama X's disowned son, Who Became A Buddhist Monk -- And Then...

New Delhi. Vacharaesorn Vivacharawongse, Thailand's King Rama X's disowned son, has become a Buddhist monk. The ordination ceremony of Vacharaesorn was posted on his official Instagram account which fuelled speculation over whether he could re-enter the



royal fold. The ceremony was conducted on Vesak Day which is a prominent Buddhist holiday. Some observers have raised the question whether these spiritual endeavours could signal a return to royal goodwill. Vacharaesorn, called Than Oun, is the second son of King Maha Vajiralongkorn and his former wife Sujarinee Vivacharawongse. Born in 1981, Vacharaesorn was raised in the United States. He was exiled from the Thai royal family in 1996 along with his mother and three brothers.

Vacharaesorn stayed abroad for a long time, yet kept in touch with the Thai community. He returned to Thailand in 2023 and was spotted at several public events. Many people believe that Vacharaesorn's return to Bangkok could be a sign that he is trying to rekindle his father's favour.

Who is King Rama X? King Maha Vajiralongkorn, 72, took over the Thai throne in 2016 after the death of his father. Known formally as Rama X, he has been married four times and has a queen and a royal consort.

Medium enterprises face severe credit scarcity: NITI Aayog

NEW DELHI. Medium enterprises face severe challenges in accessing credit as the credit demand gap for the segment has reached \$10 billion in 2024, showed a Niti Aayog report on Monday. The report says there are no government schemes that address the working capital needs of Medium enterprises, which account for only 0.3% of all registered MSMEs, but contribute nearly 40% of MSME exports. The report further says that MEs receive less priority sector loans, compared to micro enterprises, and the rate of loan is 4% higher for medium enterprises than for large corporations. To address the funding issue, Niti Aayog suggests the introduction of a working capital financing scheme linked to enterprise turnover; a Rs 5-crore credit card facility at market rates, and expedited fund disbursal mechanisms through retail banks, overseen by the Ministry of MSME.

The report underscores other challenges faced by medium enterprises, including limited adoption of advanced technologies, inadequate R&D support, lack of sectoral testing infrastructure, and a mismatch between training programmes and enterprise needs. The report says there are 18 schemes for MSMEs, out of which only 8 are for medium enterprises, which are those units that have invested between Rs 25-125 crore in plant and machinery, and have a turnover of Rs 100-500 crore. Total fund allocated to these 18 schemes is Rs. 5,442 crores, out of which funds for Schemes available to MEs are 17.81%. This segment of the MSME also severely lacks innovation and access to skilled labour, according to the report.

The report suggests the creation of a dedicated sub-portal within the Udvam platform featuring scheme discovery tools, compliance support, and AI-based assistance to help enterprises navigate resources effectively. The report emphasises that unlocking the potential of medium enterprises requires a shift toward inclusive policy design and collaborative governance. With strategic support in finance, technology, infrastructure, skilling, and information access, medium enterprises can emerge as the drivers of innovation, employment, and export growth.

behind in STEM education, which limits our ability to compete in a modern, tech-driven world. On top of that, India is lagging behind in STEM education - science, technology, engineering, and maths — which are critical for building a skilled workforce.

Rishabh Pant is victim of bad timing in IPL 2025: Akash Deep defends LSG captain

NEW DELHI. Lucknow Super Giants pacer Akash Deep has backed his captain, Rishabh Pant, amid widespread criticism of his form in the ongoing IPL 2025 season, saying the wicketkeeper-batter is a victim of "bad timing" rather than pressure.Pant, the most expensive player in IPL history at Rs 27 crore, has endured a disappointing campaign. In 13 matches, the left-hander has managed just 151 runs at an average of 13.73 and a strike rate of under 100. His highest score—63 off 49 balls—came against Chennai Super Kings in a match that had little impact on LSG's playoff chances.

"Look, I feel that in cricket, timing is also something very important," Akash Deep said ahead of Lucknow's final league fixture. "I don't think it's about pressure because Rishabh has played a lot of cricket, and at a very high level too, and he has performed as well. An athlete who has achieved so much in
