Subject: Humble Appeal to Clarify Government's Stand on Operation Blue Star and Address Long-standing Concerns of the Sikh Community

Respected Prime Minister Shri Narendra Modi Ji,

With due respect and utmost regard, I write to you on behalf of the All India Sikh Conference (Babbar) and the wider Sikh community, which continues to be deeply pained and disturbed by the tragic events of Operation Blue Star, executed in the first week of June 1984 under the leadership of then Prime Minister Smt. Indira Gandhi.

Even after four decades, the wounds of that military operation, which targeted the most sacred Sikh religious shrines—Shri Darbar Sahib (Golden Temple) and Shri Akal Takhat Sahib, remain unhealed. The emotional, spiritual, and cultural trauma endured by the Sikh community during and after the operation continues to cast a long shadow.

It is widely perceived that the decision to deploy the Indian Army inside the holy precincts was not only avoidable but politically motivated. Many believe that Smt. Indira Gandhi's primary objective was to consolidate political power and secure her position rather than pursue genuine peace. We respectfully ask:

Why was military force chosen over dialogue, especially when multiple alternative solutions were available?

Why were other senior Congress leaders not able to prevent or advise against such an extreme step?

Why were the sentiments of crores of Sikhs across the globe ignored?

In light of the above, we humbly request your esteemed office to take a bold and dynamic step by initiating an open dialogue with prominent Sikh leaders and organizations to:

1. Clarify the present Government of India's stand on the events of June 1984.
2. Provide an official explanation to the Sikh community and the nation on the circumstances, motives, and alternatives considered during that time.
3. Acknowledge the pain and injustice that the Sikh community continues to feel and extend a healing hand through words and action.

Sir, the time has come for reconciliation, truth, and justice. We believe that your leadership has the vision and moral courage to bring closure to this long-standing issue, in the spirit of national unity, harmony, and respect for all religious sentiments.

Thanking you in anticipation of your kind consideration.

India poised to remain fastest growing major economy in FY26: RBI

Mumbai, May 29: The country is poised to remain the fastest growing major economy in the world even in FY26, the Reserve Bank said on Thursday. The benign inflation outlook and a "moderation" in GDP expansion warrant the monetary policy to be supportive of growth going forward, the RBI said in its annual report. "...The Indian economy is poised to remain the fastest-growing major economy in 2025-26 by leveraging its sound macroeconomic fundamentals, robust financial sector and commitment towards sustainable growth," the RBI said in the latest report. It flagged global financial market volatility, geopolitical tensions, trade fragmentation, supply-chain disruptions and climate-induced uncertainties as factors posing downside risks



to the growth outlook and also upside risks to the inflation outlook. However, factors like easing of supply-chain pressures, softening global commodity prices and higher agricultural production on above-normal south west monsoon augur well for inflation outlook, the central bank said. Shifts in tariff policies may result in sporadic episodes of volatility in financial markets, it said, adding that exports may encounter headwinds on "inward-looking policies and tariff-wars". The trade pacts being signed and negotiated by India will help ensure that the impact is limited, the RBI said, adding that services exports and inward remittances will help ensure that the current account deficit is "eminently manageable" in the new fiscal.

PM Modi slams TMC over Murshidabad violence, teacher scam

Alipurduar (WB), May 29: Launching a blistering attack on the TMC government in West Bengal, Prime Minister Narendra Modi on Thursday accused it of fostering violence, corruption and lawlessness, and asserted that the people in the state are yearning for change to get rid of the 'nirmam sarkar' (cruel government). Addressing a public rally in north Bengal's Alipurduar, Modi cited the recent incidents of communal violence in Murshidabad and Malda as grim reminders of the TMC regime's "cruelty and indifference" towards the ordinary citizens. "Today, West Bengal is grappling with a series of crises. People don't want 'Nirmam Sarkar'. They want change and good governance. That is why the whole of Bengal is saying that they don't want cruelty and corruption anymore," the prime minister said, exactly

a year ahead of the assembly elections in the state. Criticising the Mamata Banerjee-led



TMC government for the recent communal violence in Murshidabad and Malda, Modi said the allegation was that lawbreakers were allowed to operate unchecked under the guise of "appeasement", while the police stood by

helplessly, failing to act. "Look at what happened in Murshidabad and Malda — clear examples of the government's cruelty. In the name of appeasement, lawlessness was allowed to flourish. Just imagine the horror: members of the ruling party mark out homes and set them on fire, while the police stand by and do nothing," he said. "I want to ask the poor people of Bengal — is this how a government is supposed to function? Here, the courts, in almost every matter, have to step in because nothing gets resolved otherwise. The people have lost faith in the TMC government. There's an outcry across Bengal — 'Bengal mein machi cheekh pukaar, nahi chahiye nirmam sarkar' (Outcry in Bengal is to oust cruel government)," the PM claimed. This is Modi's first visit to the state

since violent clashes broke out in parts of Murshidabad—including Samserganj, Suti, and Dhulian—in April following protests over the contentious Waqf Amendment Act. At least three people were killed and several others injured in the communal riots. Modi listed five major crises that are allegedly "plaguing" Bengal under the TMC rule. "First is the widespread violence and lawlessness that are tearing apart the fabric of society. Second is the growing sense of insecurity among mothers and sisters, compounded by horrific crimes committed against them," the PM alleged. He also claimed that the third crisis is the despair among youth due to unemployment and lack of opportunities, while the fourth is the "corruption that destroyed the system and eroded pub-

44 MLAs seek to form new Government in Manipur

Imphal, May 29: Forty-four MLAs are ready to form a new Government in Manipur, BJP legislator Thokchom Radheshyam Singh claimed on Wednesday after meeting Governor Ajay Kumar Bhalla. Singh, along with nine other MLAs, met the Governor at the Raj Bhavan. "Forty-four MLAs are ready to form a Government as per the wishes of the people. We have conveyed this to the Governor. We also discussed what solutions can be there for the issue," he said. "The Governor noted what we had to say and will initiate actions in the best interests of the people," he added. Asked if they would stake a claim to form the Government, he

said the central leadership of the BJP will take the decision. "However, to inform that we are ready is similar to staking a claim to form a Government. Speaker Thokchom Satyabrata Singh has individually and jointly met the 44 MLAs. There is no one who opposes the formation of a new Government," Singh said. "People are facing too much hardship. In the previous term, two years were lost due to COVID-19 and in this term, another two years have been lost due to the conflict," he said. Manipur has been under President's Rule since February after BJP leader N Biren Singh resigned as the Chief Minister, amid criticisms about his Government's handling of the ethnic clashes between Meiteis and Kuki-Zos, which broke out in May 2023. The 60-member Assembly at pres-

ent has 59 MLAs, with one seat vacant due to the death of a legislator. In the BJP-led coalition, there are 32 Meitei MLAs, three Manipuri Muslim MLAs and nine Naga legislators, totalling 44. The Congress has five MLAs—all Meiteis. The remaining 10 MLAs are Kukis—seven of them won the last election on a BJP ticket, two belong to the Kuki Peoples' Alliance and one is an Independent. The development comes amid massive protests in the Meitei-inhabited Imphal Valley over the hiding of the State's name written on the windshield of a Government bus by security forces. Meitei groups have been demanding an apology from the Governor over the incident that happened in Gwalabi on May 20 and the resignation of the chief secretary, DGP and security advisor.

CM Stalin inaugurates India's first exclusive Tuna fishing harbour in Chennai

CHENNAI. Chief Minister M K Stalin on Wednesday reiterated his party's demand on retrieving Katchatheevu from Sri Lanka to put an end to the ordeals faced by Tamil Nadu fishermen. He said this after inaugurating an exclusive fishing harbour for Tuna fishing constructed at a cost of Rs 272.70 crore at Tiruvottiyur here.

A release said this is the first such exclusive harbour for Tuna fishing in the country. The facilities available will help fishermen returning with tuna from deep sea to swiftly sell the catch to exporters without impacting the quality. It said around 6,250 people involved in fishing and related jobs in 12 fishing villages will benefit from the fishing harbour, which has the capacity to handle 70,000 tonnes of fish every year.

He also laid the foundation stone for new fish landing centres at Thangachimadam and Rosma Nagar in Ramanathapuram district, worth Rs 170 crore.

Additionally, he launched the 'Alaigal' (waves) microcredit scheme for women's self-help groups through the Tamil Nadu State Apex Fisheries Co-operative Federation Limited and commenced the distribution of welfare assistance worth Rs 10.67 crore to 2,290 beneficiaries.

Stalin underscored the role of fishing hamlets stretching from Palaverkadu to Kovalam in Chennai's development.

Protecting the welfare and livelihood of fisherfolk is akin to preserving Tamil cultural identity. Our Dravidian model government has been fulfilling this duty," he said.

Miss World contestants share stories, smiles with Hyderabad schoolchildren in heartfelt outreach event

HYDERABAD. In a departure from the usual glamour and spotlight, Wednesday afternoon brought a heartwarming scene to the Trident Hotel in Hyderabad, where over 200 students from Victoria Memorial School mingled freely with Miss World contestants from around the globe.

The event, held in the hotel's grand ballroom, was part of a social initiative hosted by Fortune Hospitality and Sudeeksha Estates.

There was no stage, no pageantry. Instead, small circles of children and contestants sat together on the ballroom floor, exchanging stories, laughter and curiosity. Some shared their dreams, others simply enjoyed the rare experience of speaking with visitors from distant countries. The reigning Miss World, Krystyna Pyszkova, and Miss World CEO, Julia Morley, found themselves fielding an array of thoughtful questions from the young audience.

"How did you decide to enter the Miss World pageant?" one child asked. Another wanted to know what challenges came with organising such a global competition. Morley and Pyszkova responded candidly, offering reflections on perseverance and the importance of believing in one's own voice. At the children's request, both shared messages of encouragement, tailored not for a press release, but for a school assembly.

Heavy rains cause severe waterlogging in Odisha's Kendrapara due to poor drainage, illegal construction

KENDRAPARA. Incessant rains for the last three days have led to severe waterlogging in several parts of the coastal district, causing major inconvenience to residents.

Waterlogging has been reported from Pattamundai town, Aul, Rajnagar, Rajkanika and Mahakalapada with both vehicles and pedestrians struggling to navigate the submerged roads. Sources said several low-lying villages continue to remain submerged due to the heavy downpour.

The worst-hit are residents of Pattamundai town. Local resident Satyapriya Samal said poorly maintained roads and a dysfunctional drainage system have worsened the crisis. "The roads are in shambles. Small potholes have turned into large craters, leading to traffic jams," he said.

Adding to the woes, illegal construction on wetlands and canal-side lands has aggravated the problem. "Land sharks are converting water bodies into homestead lands, leading to poor water drainage. Revenue officials are also involved in illegally converting wetlands and water bodies for residential use," alleged Prafulla Das, another resident of Pattamundai.

Many roads which were recently repaired have been damaged again due to the continuous rain. Accumulation of rainwater is a major convenience, claimed Das. Executive officer of Pattamundai municipality Prafulla Biswal said, "We are already clearing drains to prevent waterlogging. Some potholes have formed on roads due to the rains but the number is relatively less. Pumping of rainwater from residential areas is currently underway."

Kendrapara ADM Nilu Mohapatra said a few months back, drains were cleaned in many areas to prevent the waterlogging problem. But he admitted that some low-lying villages and urban areas have been waterlogged due to the recent rains. "We are using pumps to drain out the rainwater," he added.

Tamil Nadu universities to send question papers through email to avoid leaks

CHENNAI. To avoid any incident of question paper leak, the higher education department has instructed the registrars of state universities to computerise the process of distributing the question papers to examination centres through email just before the start of the exam. The initiative has been successfully pilot-tested by the Tamil Nadu Teachers Education University (TNTEU), which was marred by a question paper leak incident last year. After its successful implementation in TNTEU, secretary of higher education department C Samayamoorthy, in a recent meeting with the registrars, directed them to pilot the process in one subject first before implementing it completely for the entire exam. In another move to streamline education, especially in PhD, the secretary recommended the universities to start a common online portal for PhD, where all registrations and updates related to research work can be done. He also asked registrars to conduct a centralised entrance exam for PhD courses. After implementation of the process, the students will not have to write exam separately for various state universities' PhD course, said



higher education department officials.

To enhance the quality of PhD and ensure its timely completion, registrars have been directed to acquire the software being used by Anna University for providing affiliation to colleges and PhD registration and to implement the same in their universities. The secretary highlighted that the department has received many complaints from students that their PhD guides are delaying the submission of their project/thesis. So, he instructed registrars that the list of external examiners/foreign faculties for evaluation of PhD thesis should not be obtained from the guides of the projects; instead it has been

suggested to obtain it from the registrar, University of Madras, currently. He also instructed to take steps to improve the standard of internal exams and to provide internal marks to students based on their participation in seminars, viva voce, group projects and building interpersonal relationships with staff and students, instead of giving marks based on just theory and attendance. "Students take the internal exams very lightly. We need to make this exam relevant," said an official of the department.

The secretary also directed registrars to focus on revenue generation by insisting the faculty and students to file patent on suitable projects, so that those patents can turn into products and university can take steps to obtain regular royalty from those products. He asked registrars to fix the target for revenue generation to each department. The registrars were directed to identify heads of departments (HoDs) in universities who have been HoDs in the same department for more than three years and to furnish the list to the government. They were also instructed to appoint faculty to the post of HoD on a rotation basis for every three years.

Sand mining to resume in Kerala rivers after long gap of nine years

State prepared survey reports for 11 dists with CSIR-NIIST support, of which four approved.

THIRUVANANTHAPURAM. River sand mining is set to resume in Kerala after a gap of nine years. The revenue department recently issued an order on the standard operating procedure (SOP) for mining activities. The SOP is the first step in a series of procedures involving different government departments. The SOP is based on the directives issued by the Union Ministry of Environment and Forests (MoEF), Supreme Court and the National Green Tribunal. Under this, District Survey Reports are to be prepared for districts where mining is planned. It should be prepared by an agency approved by the National Accreditation Board for Education and Training.

The state has so far prepared DSRs for 11 districts with the support of NABET-approved CSIR-NIIST. Of them, four were approved by the State Environment Impact Assessment Authority (SEIAA) and the remaining are under different stages of review.

The report has information on the mining potential



of rivers in the districts and their environmental impact. The primary data would be the sand auditing report for each district prepared earlier under government supervision. So far, audits have been conducted for 32 of the 44 rivers. Of them, 17

rivers in 10 districts were recommended for restricted mining activities. They are Mogral, Uppala, Shiriya, Chandragiri, Valapattanam, Perumba, Sreekandapuram, Mahe, Kadalundi, Chaliyar, Bharathappuzha, Muvattupuzha, Periyar, Manimala, Pampa, Achankovil and Kulathupuzha.

After the SOP, the state mining and geology department should give a letter of intent. Since existing mines and mineral rules do not provide for an LoI, an amendment should be brought to it. Following this, the RDO of a district can apply for environmental clearance.

Based on the clearance, the mining and geology department will issue permits for mining from each river. As per the present plan, mining activities would be under the supervision of the Kadavu committee formed for specific banks of a river. The committee to be constituted by the district collector will have the grama panchayat president or the municipal chairperson as its ex-officio president and LSGI secretary as ex-officio secretary.

'Failed' SSC student scores 96 marks in re-evaluation in Andhra

However, having scored over 90 marks in five other subjects, her family suspected an error and applied for re-evaluation.

GUNTUR. A Class 10 student from Bapatla district saw a dramatic turnaround in her SSC results after re-evaluation, prompting appeals for a special admission opportunity and raising concerns at the highest levels about lapses in paper correction.

Tejaswini, a student at Zilla Parishad High School in Kolluru, was initially declared failed in the recently released SSC results, with just 23 marks in Social Studies. However, having scored over 90 marks in five other subjects, her family suspected an error and applied for re-evaluation.

Following review, her Social Studies marks were revised to 96, bringing her total marks to 575, well within the eligibility range for admission to IIT institutions. Unfortunately, the application deadline had already passed on May 20, even before the updated marks were issued. Her teachers and family appealed to authorities



to ensure she is not denied an opportunity due to the delay.

Speaking to , Bapatla district education officer (DEO) Purushottam Sriram said the matter was brought to their attention on Wednesday.

Ensure no lapses occur in future: CM

"Though the re-verification results

were out on May 23, we came to know about this on May 28. I personally spoke with the IIT admission convenor, who assured us that if the student qualifies under the norms, she will be considered for admission despite the missed deadline," he said.

Chief Minister N Chandrababu Naidu also took serious note of discrepancies in evaluation. Naidu expressed severe dissatisfaction, and directed officials to ensure that affected students are not denied further opportunities.

Tejaswini's father, a daily-wage labourer, has supported her education against all odds. The family remains hopeful that she will now be able to continue her studies without interruption.

Education Director KV Srinivasulu Reddy said 64,251 applications for re-verification and 2,112 for recounting have been received so far, and the process will be completed by June 1.

New scheme to curb anaemia in adolescent girls

HYDERABAD. With an objective to prevent anaemia among adolescent girls, the state government has decided to launch a new scheme, Indiramma Amrutam, under which millet and peanut chikkis (energy bars made with nuts and jaggery) will be distributed among girls aged between 14 to 18. Women & Child Welfare Minister Danasari Anasuya alias Seethakka will be launching this scheme in Bhadradi Kothagudem district on Thursday.

Initially, the government will implement this scheme in Bhadradi-Kothagudem, Kumurambheem-Asifabad and Jayashankar-Bhupalpally districts on a pilot basis through Anganwadi centres.

Under this scheme, the government will distribute 30 chikkis, in two instalments, per girl per month. Each chikki will contain 600 calories, 18 to 20 grams of protein and micronutrients.

According to officials, the government decided to launch this scheme as 64.7 per cent of adolescent girls in Telangana are

suffering from anaemia as per the National Family Health Survey-5.

"The government is already providing iron and folic acid tablets for girls after conducting Hb tests. Now, it has come out with a new scheme that will help in curbing



anaemia among adolescent girls," the officials added. Seethakka, meanwhile, asserted that Indiramma Amrutam scheme will become a game-changer for girls' health.

"Initially, this scheme will be implemented in three districts where the prevalence of anaemia is relatively high. It will be extended to other districts in the future," she added.

Technical failure in ballast management system led to failure of sunk ship: Shipping regulator

KOCHI. Dismissing the sabotage theory behind the capsizing of container vessel MSC Elsa 3, the Director General (DG) of Shipping Shyam Jagannathan on Wednesday said the ship sank due to the failure of its ballast management system, which ensures the vessel's stability. The containers that fell off the ship when it sank off Kochi coast on Sunday and were floating in the Arabian Sea would be retrieved in 48 hours, Jagannathan said, adding that environmental damage was minimal.

"The oil spill is limited and the Coast Guard is cleaning it. The oil in the ship bunker will be removed by July 3," he said. "Our primary inference is that the vessel sank due to mechanical failure of the ballast management system. Safety and environmental requirements of the ships are governed by norms set by International

Maritime Organisation (IMO) and this vessel complied with international norms.

We have no evidence of other reasons. Failure of the ballast system may be due to lack of operational understanding. When the vessel listed to 26 degrees, there was a complete blackout due to failure of internal power generation. This virtually incapacitated all operations of the ship," said chief surveyor of Union government Ajith Sukumaran. About the cargo, Jagannathan said there were 13 containers carrying hazardous cargo of which 12 had calcium carbide, while one had rubber chemical antioxidants.

Vessel will be recovered: DG Shipping

"Five containers carrying calcium carbide were on the deck and might have landed on the sea floor. The other seven containers are in the cargo hold and are safe. The calcium carbide is stored in 200-litre drums inside



the containers and chances of it mixing with sea water are sparse. There are some containers having iron and ethylene polymers which are plastic nodules," he said, adding that all sunken containers as well as the ship will be recovered. Jagannathan said around 100 containers floated in the sea of which 50 beached in coastal areas of three southern districts.

US Woman Arrested For Allegedly Hitting Boy Who Called Her "Fat" On Flight From Disney World

world. A woman from Maryland, United States, has been arrested for allegedly assaulting a boy on a flight from Florida after he reportedly insulted her appearance, according to police officials.

The incident took place aboard a flight at Orlando Sanford International Airport on Memorial Day. The accused, 46-year-old Kristy Crampton from Hagerstown, allegedly hit the boy after he called her "fat" and "Miss Piggy", the police report said.

Witnesses on the flight told Sanford Airport Police that Crampton struck the child and slammed his head against the plane window following a heated verbal exchange. One passenger described the incident as "abuse", claiming the woman "was not correcting the child, she was abusing him". Crampton, however, told authorities that the child had been disrespectful throughout their trip. When she took away his phone as a disciplinary measure, the boy allegedly pushed her arm off the armrest, prompting her to strike him, the report added. Police have not clarified the nature of the relationship between the two, according to Fox News. Crampton was arrested and booked into Seminole County Jail on child abuse charges. She was later released on a \$10,000 bond.

Won't Differentiate Between State, Non-State Terrorism: DMK's Kanimozhi In Greece

Athens. DMK MP Kanimozhi Karunanidhi, leading an all-party delegation to Greece, said India has made it clear that it will no longer distinguish between individual acts of terror and state-sponsored terrorism. While interacting with the Indian diaspora on Wednesday (local time), she added that the government's outreach, which includes opposition MPs, reflects a united stance against cross-border terrorism and a firm resolve to say "no more" after years of suffering.

"Our Prime Minister and the Government of India have made a decision to reach out to countries. In our delegation, except Capt Brijesh Chowta, all of us are from the opposition parties. Our Prime Minister and the country have clearly stated that we will no longer differentiate between state-sponsored terrorism and terrorist activities of individuals and groups. India has suffered enough, and the time has come to say no more," Mr Kanimozhi said. Earlier, an all-party delegation led by Ms Kanimozhi interacted with the Athens-based newspaper Kathimerini in Athens on Wednesday (local time) as part of the government's diplomatic outreach to highlight India's stance on terrorism. "The members of the delegation led by Ms Kanimozhi held a constructive interaction with the editorial board of Kathimerini during which they conveyed India's 'new normal' policy on terrorism. They emphasised India's firm stance against terrorism in all its forms," posted India in Greece on X.

The delegation, led by DMK MP Kanimozhi Karunanidhi, also includes Rajeev Rai (Samajwadi Party), Mian Altaf Ahmad (Jammu and Kashmir National Conference), Brijesh Chowta (BJP), Prem Chand Gupta (Rashtriya Janata Dal), Ashok Kumar Mittal (Aam Aadmi Party), and Former envoys Manjeev S Puri and Jawed Ashraf.

How Indians Stand As Donald Trump's Team Orders Pause On US Student Visas US Student Visa Pause: This means that the US's decision to pause student visa

Washington DC. India has for years been among the top two countries from where students go to the United States of America to pursue their higher education. In the last few years, Indians have outranked China to emerge as the largest contingent of international students in the US. This means that the US's decision to pause student visa interviews globally will impact aspiring Indian students the most. The Donald Trump administration, had on Tuesday, ordered its embassies and consulates worldwide to not schedule any new interviews for student-visa applicants. The reason behind the move is that the Trump administration is in the process of ramping up vetting of social media profiles of all applicants.

WHY THE PAUSE IN US STUDENT VISAS?

This new move is likely to result in significantly longer wait times for applications to be scrutinized, thereby delaying the interview schedules and making the visa approval process much lengthier. To tackle the existing backlog of applications, the US government has decided to defer the interview process till existing forms aren't perused and the applicant's background checks, including online activity, is not complete.

There is no deadline set for this, so it is uncertain as to how long the "pause" is likely to remain in effect. This latest development comes amid President Trump's ongoing battle with US universities and colleges, including those which are part of the Ivy league.

Donald Trump also wants to reform the higher education system in the US, while simultaneously initiating a crackdown on student activism and "Left liberal" legislation that promote diversity policies, which the Trump Administration has labeled as "divisive". Students visas are also being revoked and students deported if they are found to indulge in on-campus protests, especially on political issues, such as the war in Gaza. The US government has called such protests "anti-Semitic" and students who participate in it, "terror sympathisers". This is what has led to the enhanced scrutiny and background checks of applicants and their social media activity.

Israel And UN Clash Over Aid To Gaza

United Nations. Israel accused the United Nations Wednesday of seeking to "block" Gaza aid distribution, as the global body said it was doing its utmost to gather the limited assistance greenlighted by Israel's authorities. The humanitarian situation in Gaza, where Israel has imposed a two-month aid blockade, is dire, with food security experts saying starvation is looming for one in five people.

"While the UN spreads panic and makes declarations detached from reality, the state of Israel is steadily facilitating the entry of aid into Gaza," Israel's United Nations Ambassador Danny Danon told the Security Council. He said the assistance was entering by trucks -- under limited authorization by Israel at the Kerem Shalom crossing since last week following the blockade -- and via a "new distribution mechanism developed in coordination with the US and key international partners."

Danon was referring to the Gaza Humanitarian Foundation (GHF), a private, US-backed aid group that has established its own distribution system, one the United Nations considers contrary to its

humanitarian principles. A chaotic distribution of aid at a GHF center Tuesday left 47 people wounded. Israel's ambassador blamed Hamas for the tumult, saying the Palestinian group set up roadblocks and checkpoints to block access to the distribution center. He accused the UN of "trying to block" the aid. The United Nations "is using threats, intimidation and retaliation against NGOs that choose to participate in the new humanitarian mechanism," Danon added.

- "Will not participate" -

Danon specifically accused the United Nations of having removed these nongovernmental organizations from a database listing groups working in Gaza, an accusation rejected by the UN. "There are no differences between the current list and the one from before the launch of the GHF," Stephane Dujarric, spokesman for UN Secretary-General Antonio Guterres, told AFP. But the UN reiterated its opposition to coordinating with GHF. We will not



participate in operations that do not meet our humanitarian principles," insisted Dujarric. He also said the UN was doing all it could to gather the aid arriving through Kerem Shalom.

Since last week 800 truckloads were approved by Israel but fewer than 500 made it into Gaza, according to Dujarric. We and our partners could collect just over 200 of them, limited by insecurity and restricted access," he said. "If we're not able to pick up

those goods, I can tell you one thing, it is not for lack of trying." Danon had said "more than 400 trucks" full of aid were already on the Gaza side of the crossing and that Israel had provided "safe routes" for the distribution.

"But the UN did not show up," the Israeli envoy said. "Put your ego aside, pick up the aid and do your job." Israeli military operations in Gaza have killed at least 54,804 people, mostly civilians, according to the health ministry there. The UN considers the figures reliable. The punishing offensive has reduced much of the Palestinian territory to rubble -- including hospitals, schools and other basic infrastructure -- and resulted in the displacement of almost all of its roughly two million people. Israel launched its operations in response to the October 7, 2023, attack by Hamas, which killed 1,218 people, according to an AFP tally based on official figures.

China Urges US To Protect "Academic Exchanges" Amid Trump's Visa Freeze

world. China has called on the United States to avoid "disrupting" education and academic exchanges after the Trump administration froze all student visa interviews and appointments at US embassies and consulates worldwide. "We urge the US to effectively safeguard the legitimate rights and interests of all international students, including Chinese students overseas," Chinese Foreign Ministry spokesperson Mao Ning said on Wednesday, as per Newsweek. She added that China "upholds that normal education cooperation and academic exchanges should not be disrupted."

The appeal comes as US Secretary of State Marco Rubio announced plans to "aggressively" revoke visas for Chinese students with alleged links to the Chinese Communist Party or those studying in sensitive fields.

The US will also increase scrutiny of all future visa applications from China and Hong Kong, Rubio said. By



halting the student visa category, which issued over 4 lakh visas in fiscal year 2024, the administration aims to slow international student admissions and reduce immigration. This pause could also slash a key revenue stream for many US universities that rely on foreign students' tuition.

Donald Trump has ramped up efforts to restrict foreign student admissions, citing national security concerns. On Wednesday, he proposed a cap on international enrollment at Harvard University, limiting it to 15 per cent of the student body. Tensions between Washington and Beijing have already led to a 4 per cent decline in Chinese

student enrollment in 2024. The FBI has repeatedly warned that Chinese actors may exploit "America's deeply held and vital culture of collaboration and openness on university campuses." According to US State Department data, 277,398 Chinese students enrolled in American institutions in 2024, making China the second-largest source of foreign students after India. In the 2023-24 academic year, over 1.1 million international students studied in the US, accounting for nearly 6 per cent of total higher education enrollment. Almost half came from India and China, according to the Institute of International Education. Separately, Rubio also announced new visa restrictions on foreign officials and individuals who "censor Americans," particularly those targeting US tech companies. Rubio told lawmakers last week that the government had already revoked thousands of visas. "A visa is not a right."

NASA's Starliner Crew Sunita Williams, Butch Wilmore Finish Recovery On Earth

Washington. Butch Wilmore and Sunita Williams, the U.S. astronauts left on the International Space Station last year by Boeing's troubled Starliner capsule, are on the up after returning to Earth in March, emerging from weeks of physical therapy to ramp up work with Boeing and various NASA programs. "Right now, we're just coming off of the rehab portion of our return," Wilmore, 62, told Reuters in an interview on Wednesday. "Gravity stinks for a period, and that period varies for different people, but eventually you get over those neurovestibular balance type of issues." Wilmore and Williams, who last year set off for an eight-day Starliner test flight that swelled into a nine-month stay in space, have had to readapt their muscles, sense of balance and other basics of Earth living in a 45-day period standard for astronauts returning from long-term space missions. The astronaut have spent at least two hours a day with astronaut

strength and reconditioning officials within NASA's medical unit while juggling an increasing workload with Boeing's Starliner program, NASA's space station unit in Houston and agency researchers. "It's been a little bit of a whirlwind," Williams, 59, said in the interview. "Because we also have obligations to all of the folks that we worked with." Williams said some of her post-spaceflight side effects were slower to clear up and she felt tired in late stages of recovery, as dozens of various muscles re-engaged. That made it hard for her to wake up as early in the mornings as she likes, until a little more than a week ago. "Then I'm up at four in the morning, and I'm like, Aha! I'm back," she said. Wilmore had some issues with his back and neck before heading to space, being unable to turn his head all the way to the side, he said. That all went away in space where "you don't have any stress on your body."

When he returned in March, gravity greeted him with the neck pain he left

on Earth. "We're still floating in the capsule in the ocean, and my neck starts hurting, while we still hadn't even been extracted yet," he said, laughing. The human body, evolved over millions of years in the gravity of Earth's surface, was not meant for spaceflight. The absence of gravity triggers an array of physical effects over time, such as muscle atrophy or cardiovascular shifts that can cause a chain reaction of other health changes. Confinement in a small space and higher solar radiation in space, without the protection of Earth's atmosphere, have other effects. Starliner problems: Propulsion system issues on Boeing's Starliner forced NASA to bring the capsule back without its crew last year and to fold the two astronauts into its normal, long-duration rotation schedule on the ISS. Boeing, which has taken \$2 billion in charges on its Starliner development, faces a looming decision by NASA to refly the spacecraft uncrewed before it carries humans again.

"Our focus for this year is deepening the experience and making Meta AI the leading personal AI," Zuckerberg said when Meta announced quarterly earnings at the end of April.

Ngugi wa Thiong'o, Kenyan author and dissident who became a giant of modern literature, dies at 87

NEW YORK. Ngugi wa Thiong'o, the revered Kenyan man of letters and voice of dissent who in dozens of fiction and nonfiction books traced his country's history from British imperialism to home-ruled tyranny and challenged not only the stories told but the language used to tell them, died Wednesday at 87. Derek Warker, publicist for Ngugi's US publisher The New Press, confirmed the death to The Associated Press. Ngugi's son Nducu wa Ngugi said he died in Bedford, Georgia. Further details were not immediately available, though Ngugi was receiving kidney dialysis treatments. Whether through novels such as "The Wizard of the Crow" and "Petals of Blood," memoirs such as "Birth of a Dream Weaver" or the landmark critique "Decolonizing the Mind," Ngugi embodied the very heights of the artist's calling -- as a truth teller and explorer of myth, as a breaker of rules and steward of culture. He was a perennial candidate for the Nobel literature prize and

a long-term artist in exile, imprisoned for a year in the 1970s and harassed for decades after. "Resistance is the best way of keeping alive," he told the Guardian in 2018. "It can take even the smallest form of saying no to injustice. If you really think you're right, you stick to your beliefs, and they help you to survive." He was admired worldwide, by authors ranging from John Updike to Chimamanda Ngozi Adichie, and by former President Barack Obama, who once praised Ngugi's ability to tell "a compelling story of how the transformative events of history weigh on individual lives and relationships." Ngugi was shortlisted for the Man Booker Prize in 2009, was a finalist for a National Book Critics Circle prize in 2012 and, four years later, was the winner of the Pak Kyong-ni Literature Award. Through Ngugi's life, you could dramatize the history of modern Kenya. He grew up on land stolen from his family by British colonists. He was a teenager when the Mau Mau uprising for independence

began, in his mid-20s when Britain ceded control in 1963 and in his late 30s when his disillusion with Kenyan authorities led to his arrest and eventual departure. Beyond his own troubles, his mother was held in solitary confinement by the British, one brother was killed and another brother, deaf and mute, was shot dead when he didn't respond to British soldiers' demands that he stop moving. In a given book, Ngugi might summon anything from ancient fables to contemporary popular culture. His widely translated picture story, "The Upright Revolution," updates Kenyan folklore in explaining why humans walk on two legs. The short story "The Ghost of Michael Jackson" features a priest possessed by the spirit of the late entertainer. Ngugi's tone was often satirical, and he mocked the buffoonery and corruption of government leaders in "The Wizard of the Crow," in which aides to the tyrant of fictional Aburiria indulge his most tedious fantasies.

"Rumor has it that the Ruler talked nonstop for seven nights and days, seven hours, seven minutes, and seven seconds. By then the ministers had clapped so hard, they felt numb and drowsy," he wrote. "When they became too tired to stand, they started kneeling down before the ruler, until the whole scene looked like an assembly in prayer before the eyes of the Lord. But soon they found that even holding their bodies erect while on their knees was equally tiring, and some assumed the cross-legged posture of the Buddhist."

Ngugi sided with the oppressed, but his imagination extended to all sides of his country's divides -- a British officer who justifies the suffering he inflicts on local activists, or a young Kenyan idealist willing to lose all for his country's liberation. He parsed the conflicts between oral and written culture, between the city and the village, the educated and the illiterate, the foreigner and the native.

Anna University sexual assault case: It took court just 31 hearings, two months to reach the verdict

CHENNAI. The criminal justice system lived up to the trust placed in it by the brave Anna University student who displayed admirable courage to file an official complaint against her rapist, A Gnanasekaran, within 24 hours of the incident. The survivor, who was assaulted on her college premises, which thousands of students consider a safe space, was delivered justice in a span of five months. She remained fearless in the face of a vile threat by Gnanasekaran, who threatened to 'leak' the video of the rape, and proceeded to inform the authorities. While the Special Investigation Team (SIT) formed by the Madras High Court completed the probe and filed a charge sheet within three months, the Mahila court judge, S Rajalakshmi, held 31 hearings from March 7 to May 22 and delivered the verdict. The state was represented by advocate MP Mary Jayanthi and they were able to prove the 11 charges against the accused using forensic and other evidence. Advocate Sudha Ramalingam told TNIE that this is a perfect example of justice being delivered quickly and would inspire rape victims to come out and file complaints against the perpetrators; at the same time, it will also instil fear among the perpetrators against committing such crimes, as justice will be given speedily. "This is what we have been talking about for ages. Justice delayed is justice denied. This shows that justice can be fast-tracked if the system wants," she said. However, sounding a word of caution, she said such quick investigation and trials are done only in high-profile cases where the victim is from a well-placed socio-economic background, crime occurs in an urban scenario and where there is a lot of pressure. "Such quick justice should be ensured in all cases, even in rural areas," she added.

Annual fish prasadam at Nampally on June 8 and 9 in Telangana

HYDERABAD. The annual 'fish prasadam' will be administered to people suffering from asthma and other respiratory ailments at the Exhibition Grounds, Nampally from 10 am on June 8 to 10 am on June 9. A large number of patients from across the country come to Hyderabad to receive the prasadam. The Bathini family, known for their long-standing tradition of administering fish prasadam, said that this year too, the prasadam will be administered on Mrigasira Karti day. They, along with volunteers, will insert herbal paste into the mouth of a live fingerling, which is then slipped into the throat of patients. For vegetarian patients, a separate medicine with jaggery is administered. However, vegetarians need to take the medicine for a longer period, the family stated. Patients are advised to take the medicine over four consecutive days and follow a strict diet prescribed by the Bathini family. Meanwhile, authorities are supervising the arrangements. Various departments, including HMWSSB, TGRTC and the Electricity departments are working in tandem for the successful conduct of the event. The Fisheries department will provide the fingerlings. The Bathini family informed that the prasadam has been administered free of cost for the last 179 years.

Maoists suspected in explosives loot near Saranda; Odisha, Jharkhand police launch joint anti-maoist operations

ROURKELA. A day after suspected Maoists hijacked and looted a truck laden with huge cache of blasting explosives, Rourkela police intensified combing operation along the Odisha-Jharkhand border with DGP YB Khurania visiting the steel city to take stock of the situation on Wednesday. Reliable sources said the DGP held a closed-door meeting with IG (Operation) Deepak Kumar, DIG (Western Range) Brijesh Kumar Rai and Sundargarh SP Pratyush Diwakar, also in charge of Rourkela. Khurania also reportedly visited K Balang police station amid tight security and reviewed the ongoing investigation. At around 9.30 am on Tuesday, eight armed persons hijacked the explosives-laden truck from near a forested stone quarry at Banko within K Balang police limits, more than 90 km from Rourkela and drove the vehicle to a nearby forest. Another 10-15 persons waiting inside the forest looted at least 150 packets of explosives each weighing 15 to 25 kg. The loot site is barely two km from the Maoist hotbed of Saranda forest in West Singhbhum district of Jharkhand. The empty vehicle was later found abandoned inside the forest and its driver was unhurt. Requesting anonymity, a police officer associated with the investigation said driver of the explosives-laden vehicle Debnath Toppo and owner of the stone quarry Niraj Pandey were interrogated.

Diamond fever grips Andhra's Kurnool as monsoon rains revive treasure hunt

Currently, only local villagers are involved, but hundreds more from Kurnool, Anantapur, Kadapa, Prakasam, and Karnataka's Bellary district are expected to arrive in the coming weeks.

KURNOOL. With the season's first rainfall in Kurnool district, diamond seekers from Andhra Pradesh and Karnataka have started arriving in Maddikera and Tuggali mandals in search of precious stones. Villagers and fortune-seekers have flocked to areas such as Jonnagiri, Peravali, Pagidirayi, and Madanantapuram, driven by age-old legends linking the region to the buried treasures of Vijayanagara emperor Sri Krishnadevaraya and his minister Timmarasu.

Local sources reported a few recent discoveries of valuable stones, further fuelling the rush. "A rumour is spreading that a man from Tuggali found stones worth Rs 10 lakh," said Jonnagiri resident G Rama Krishna. "We haven't seen proof, but it's enough to get people moving," he added.

Currently, only local villagers are involved, but hundreds more from

Kurnool, Anantapur, Kadapa, Prakasam, and Karnataka's Bellary district are expected to arrive in the coming weeks. Many will set up makeshift tents and camp in nearby areas. Experts say the rainfall helps expose stones by washing away the topsoil. Locals estimate that diamonds worth Rs 4 to Rs 5 crore are found annually in these mandals.

The impact on the local economy varies. While some villagers earn large sums overnight, others end up selling stones to middlemen, who resell them in trading hubs like Gooty in Anantapur district. A police official from Pathikonda police sub-division confirmed that the seasonal search has begun, although no official reports of significant finds have been received. He also noted that Goa Mysore Services Pvt. Ltd. is currently conducting authorised drilling operations in Pagidirayi to explore gold and other minerals.



Visually-impaired woman appointed as Oodhuvar of Tamil Nadu's Thiruvannmiyur temple

SS Priyavathana (24) from Chennai received her appointment order from Chief Minister MK Stalin on Tuesday and was posted at the Pamban Swamigal temple in Thiruvannmiyur.

CHENNAI. In a first for the state, a visually impaired woman has been appointed as an Oodhuvar in a temple under the Hindu Religious and Charitable Endowments (HR&CE) department. SS Priyavathana (24) from Chennai received her appointment order from Chief Minister MK Stalin on Tuesday and was posted at the Pamban Swamigal temple in Thiruvannmiyur.

With this, she becomes the 12th woman and the first visually impaired person to be appointed as Oodhuvar — devotional singers who recite Tamil hymns in temples. Since the DMK government assumed office, 35 Oodhuvars have been appointed, including 11 women. Born preterm, Priyavathana was diagnosed with visual impairment five months after birth. With her parents' support, she



pursued a BA in Vocal Music from the Tamil Nadu Government Music College, completed diplomas in music teaching and in Isai Kalaimani, and later trained at the Archaka Training Institute. She now performs daily

temple duties accompanied by one of her parents. Speaking to her mother Subashini Sureshkumar, who has been her constant companion and first teacher, said, "She would sit close to the TV speaker and hum along. We noticed her interest early and enrolled her in music classes." Since Priyavathana does not read Braille, Subashini first memorised the songs and then taught them to her daughter. Over time, Priyavathana mastered various Tamil devotional hymns and has performed in temples and venues such as Bharatiya Vidya Bhavan. "She also sings bhajans in Telugu, Hindi, and Marathi, and plays the violin. Her day is filled with music practice for three to four hours," said Subashini, adding that she continues to support her daughter.

Six cases reported in Guntur region as Covid spikes in Andhra

GUNTUR. Amid a nationwide rise in Covid-19 cases, six cases were reported in the erstwhile Guntur district on Wednesday. Among them, three fresh cases were recorded in Bapatla and Palnadu districts on Wednesday, while the other three were registered in Guntur over the last couple of days. District Medical and Health Officer (DM&HO) Dr Vijaya Lakshmi confirmed. A married couple from Eluru tested positive at Manipal Hospital in Tadepalli. An 83-year-old man from Tenali, reportedly in serious condition, is being treated at the same hospital.



In response to the surge in cases and an increase in respiratory illnesses, the Government General Hospital (GGH) in Guntur has launched a dedicated COVID-19 outpatient service near the Emergency Department. The facility utilises the newly established intensive care unit to treat patients showing the Covid-like symptoms.

GGH currently has 300 oxygen cylinders in reserve and an operational oxygen plant capable of producing 30,000 litres. The infrastructure supports oxygen supply to 1,500 beds, including those in emergency wards. Technical teams are on standby for maintenance. The hospital also operates four in-house oxygen generation units that extract oxygen directly from the air. While one unit is under repair, each of the other three produces 40 litres per minute, enough to collectively support about 1,000 patients in case of a spike in demand.

Telangana farmers protest, say fine rice not being procured

RAJANNA-SIRCILLA. Farmers in Rajanna-Sircilla district staged protests on Wednesday, alleging delays in paddy procurement and neglect of fine variety paddy. Unseasonal rains have worsened conditions with several farmers reporting germination of stored grain. In Venkataroep of Konaraoepet mandal, a group of farmers protested with pesticide bottles at the local procurement centre, threatening suicide if their fine variety paddy was not purchased. They accused officials of procuring only coarse paddy while leaving fine grain heaps to spoil. "The delay is causing our paddy to germinate. Authorities must act immediately," a farmer said. Procurement centre staff said millers were refusing to accept fine varieties, which they claimed was causing the backlog. In Anathapally of Boipally mandal, a woman farmer showed paddy that had germinated after being brought to the procurement centre nearly two weeks ago. "We have spent several sleepless nights here waiting. The government must take responsibility for the damage," she said.

Farmers protest over 'sluggishness' of officials

Farmers in Kummurikunta village of Dhanthalapalle mandal staged a protest on the Dhanthalapally-Suryapet main road, blocking traffic and accusing officials of inaction. They demanded immediate intervention from the state government to ensure that the soaked paddy is procured without further delay.

Mahabubabad Collector Adwait Kumar Singh was unavailable for comment. According to the district's civil supplies department, 1.65 lakh metric tonnes of paddy have been procured so far, with another 15,000 metric tonnes yet to be purchased. "We have already increased the pace of procurement," said District Civil Supplies Officer A Prem Kumar.

Paddy at 34 procurement centers in N'bad soaked
Nizamabad: In Nizamabad district, paddy stored at 34 procurement centres across



Balkonda, Armoor and Nizamabad Rural constituencies was soaked in heavy rain on Tuesday night. Srikanth Reddy, district manager of the Civil Supplies Corporation, said around 800 metric tonnes had been affected, but preliminary assessments suggested the grain was not fully damaged. Official teams are touring affected villages to assess the situation and send stock to mills. Discussions with rice millers are ongoing.

Kerala farmers keep wild boars at bay with leadwort

KOTTAYAM. As wild boar attacks continue to escalate across the state's forest fringes, an organic solution for mitigating crop destruction is gaining traction among farmers. The Indian leadwort, scientifically known as Plumbago Indica and locally referred to as 'Chethikoduveli,' has emerged as an effective deterrent, said farmers.

First introduced by settler farmers in Kannur, the plant has now expanded its reach to the high ranges of Central Travancore with local bodies and the Agriculture Department taking initiatives to promote the planting of chethikoduveli at various locations. Local bodies in Idukki such as Vazhathope and Arakkulam as well as Kootickal in Kottayam have rallied to support the farmers to use this plant as a natural barrier against wild boars. "We have decided to use this plant in our panchayat as a pilot project. We will provide plants to farmers at 75 per cent subsidy rate. In the initial phase, plants will be given to 18 farmers in the panchayat," said Bijoy Jose, president of Kootickal panchayat.

According to experts, the plant's roots produce a pungent sap that repels wild boars, making it a natural alternative to traditional methods to prevent the vermin. Farmers residing in the forest fringes have increasingly adopted this plant, especially after previous attempts to fend off these animals proved unsuccessful.

After four years of experimentation, Maju, a native of Mayyil in Kannur, introduced the Indian leadwort as an effective solution to wild boar invasions. Subsequently, the Agriculture Department validated its efficacy in preventing wild boars and have begun developing plants in their Karimbam and Aralam farms. The plants are also available at the Kerala Agricultural University's Aromatic and Medicinal Plants Research Station at Odakkali in Ernakulam. Meanwhile, chethikoduveli's success has spurred farmer interest and demand. However, despite the Agriculture Department's endorsement, its efficacy is yet to be scientifically substantiated by the experts. "While many local initiatives have been undertaken, the precise effectiveness of this method requires scientific validation," said Dr. P Balakrishnan, scientist at Kerala Forest Research Institute, Peechi.

THIRUVANANTHAPURAM.

When the National Highways Authority of India envisioned an ambitious plan to reduce the travel time between Kasaragod and Thiruvananthapuram from 15 hours to just seven, the cost paid was green, quite literally. As many as 74,921 trees were felled for highway development across the state. Although replantation has been promised, progress has been snail-paced. The plan was to plant ten times the number of trees that were cut. However, the actual replantation so far stands at just 55,540. Therefore, a total of 6,93,670 saplings are yet to be planted. Currently, replantation efforts are only taking place in two areas: Kadampattukonam-Kazhakkootam in Thiruvananthapuram and Thalappady - Kalikkadavu in Kasaragod. The goal is to complete the replantation in tandem with the highway project, but according to officials from the Social Forestry Department, the delay is largely due to



the difficulty in identifying suitable land. "As there are challenges in identifying land for the project, we are considering alternatives such as block planting, 'Nagaravanam' (urban forests), and 'Vidyavanam' (school forests). For the 23 stretches across nine districts, proposals for compensatory afforestation are being prepared. These will be submitted to the NHAI for fund release," said Ajay Ghosh, an official with the state social forestry department.

Of the 55,540 plants currently on the ground, 23,540 are in Kozhikode, 24,000 have been planted at Sainik School, Thiruvananthapuram, and 8,000 at the Greenfield Stadium in the same district. NHAI, which is constrained by land availability, has signed an MoU with the social forestry department to identify planting locations and submit cost estimates.

"There is no delay from our side in fund disbursement. We have already allocated funds for stretches in Kasaragod, Kozhikode and Thiruvananthapuram. For the remaining areas, we are awaiting estimates from the social forestry department," said an NHAI official who wished to remain anonymous. As the social forestry department has proposed a shift from the original 1:10 planting scheme to the Nagaravanam and Vidyavanam models, NHAI has stated that they have got the revised plan approved.

Nageswara Rao has urged farmers to begin paddy transplantation early this monsoon, as rains arrived 15 days ahead of schedule. He advised farmers to grow crops that can withstand unseasonal rains and suggested oil palm and traditional varieties as better options.

On Wednesday, the minister inaugurated a shopping complex built at the Chitaly mandal Agricultural Market Yard at a cost of '1.5 crore. He spoke after the swearing-in of the new market committee. The minister said Rythu Bharosa funds would be deposited into farmers' accounts before transplantation begins.

He encouraged the cultivation of high-return, low-water crops like jaji and oil palm, and urged farmers to experiment with new varieties. Stressing the need to grow essential crops alongside paddy and cotton, he advised reducing the use of pesticides and urea and shifting to traditional practices.

CoBRA sting in Operation Black Forest

In a pre-mission briefing of his men from the special CoBRA force, Manoranjan, a newly-inducted young officer, had declared, “It’s a do or die mission, and mine will be the first CoBRA blood to be shed if it came to that.” During his pre-induction interview, I had observed his readiness to give his best for an operation. He and the brave men of CoBRA knew the challenge of fighting a well-armed, motivated and organised adversary—one who can’t be identified easily even if seen gossiping with local villagers. So, imagine taking him on in his own adda. You cannot disrupt village life, though you are sure an extremist is hiding there. You don’t have Armed Forces (Special Powers) Act in force and your adversary enjoys the rights of a vibrant democracy. Maoists demonstrate their position by sporadic violence, so that the local population toes their line and joins their militia in large numbers out of fear, most often not knowing the movement’s ideology. Mobile warfare is a decisive stage in guerrilla warfare to liberate pockets of influence. They set up alternative administrative structures where the presence of government agencies is not seen or felt—like in Abujhmad, which literally translates as ‘unknown area’. Detection and disposal of explosives, especially the improvised explosive devices, are a real challenge. In September 2009, in one of the CoBRA unit’s early major operations, Manoranjan and his men succeeded in outmanoeuvring the IEDs. But he did not survive the ensuing close encounter to tell the tale. For the newly operationalised CoBRA, it was a shock and a warning. But they just could not fail.

The central government had recognised left-wing extremism as the worst internal security threat and had mandated CRPF to raise 10 units (about 10,000 personnel) of Commando Battalions for Resolute Action or CoBRA. The CRPF, seasoned with decades of experience in dealing with insurgency and terrorism, had to identify and develop 10 centres in affected states; and induct, train and equip the personnel recruited with stringent limits on age and physical efficiency.

But formulating a standard operating procedure comprising new operational doctrines and tactical strategies was a daunting task. Without going into the details, I would sum up that the most outstanding features of this new doctrine were massive operational mobilisation and officer-led area domination extending to weeks. That’s the early background that eventually led to the recently-concluded Operation Black Forest—which lasted 21 days and was carried out in the inhospitable and treacherous terrains of Abujhmad. It can be hailed as heralding the countdown of the Maoist menace. Their supreme leader, himself an explosives expert, and 26 others were killed in fierce encounters. Weapon modifying and manufacturing units were dismantled along with nearly 250 cave formations, besides recovering two tonnes of explosives and several IEDs. The operations, led by senior commanders including the CRPF Director General G P Singh, have yielded unparalleled results. The loss inflicted is so terrible that regrouping and reviving the movement is almost impossible. The Maoist menace is both grievance- and ideology-driven. In a country like ours, the scope for spreading such violent ideology cannot be confined to a state or region, unlike terrorism and insurgency. What began as ‘Spring Thunder’ (as described by Radio Peking) in the 1960s in Naxalbari, nurtured by Charu Majumdar and Kanu Sanyal, was almost written off by the time of the Emergency. But by 2004, resurgence and regrouping had taken place. Splinters of the movement, like CPI(ML) and People’s War Group, had merged and were spreading terror through the ‘Red Corridor’ that stretched from parts of Karnataka to the Nepal border. The leaders, mainly from Andhra Pradesh, Telangana and the area ‘sanitised’ by Operation Black Forest, stand neutralised. Projects—especially for infrastructure development, which was opposed and disrupted by extremists—should be resumed forthwith, so that the mainstreaming of the afflicted area is fast-tracked.

The population problem in India & why it is time to act now

The year 1921, known as the “Year of Great Divide”, is regarded as the most important in the demographic history of India.

The demographic dividend might just end up as a demographic nightmare. I have long been speaking and writing about the demographic dividend. Politicians and their hucksters have latched on to this term without quite understanding what it implies. The challenges are on hand. India, with a population of 1.34 billion, is now the most populous country in the world. But India was not always as large as it is now, both in terms of population or economy. The year 1921, known as the “Year of Great Divide”, is regarded as the most important in the demographic history of India. It marked a drastic fall in mortality and the swing from a pattern of a relatively stable population to one that was rapidly increasing. The population grew very slowly from 1801-1921, from about 200 million to 220 million. It is then that our population really took off to reach the stratospheric levels of today.

The population growth rate reached a high in 1981, touching 2.22 percent, a trend that has since been on a decline. Over the span of a century, India’s population increased by six times. Estimates suggest that India has added approximately 200 million people in the last hundred years. We can look forward to another 200 million by the middle of this one. Medium variant projections propose that during 2005-50, India’s population will increase by approximately 45 percent. The proportion of aged persons (over 65 years old) will increase from the 5 percent to 14.5 percent in 2050, which in absolute numbers would imply a growth from 57 million to 240 million. From the experiences of advanced ageing nations we can infer that a growing old age population will require us to properly plan our policies on taxation, social security and healthcare. Old people cost more. Another major area of concern is the fast increasing population density. This is estimated to go up from 345 per sq. km in 2005 to 504 per sq km in 2050. Juxtaposing this with the increasing urbanisation trend indicates a plethora of problems in the years to come. In 2000, only 28.7 percent or approximately 300 million people lived in urban areas; this is projected to go up to 40.7 percent of the population, or approximately 600 million persons by 2030. This huge increase, particularly given the rising economic power of the middle and working classes, will require provisioning for substantially

enhanced housing and urban infrastructure such as water, sewage, mass and rapid transit, traffic management and parking, energy and a much increased consumption of food items such as milk, milk products, processed food and horticultural produce and their efficient distribution. The 15-64 years age group is projected to increase from 62 percent in 2005 to about 67.3 percent in 2050, which in numbers means 700 million to 1120 million. India is at present adding 12 million people to the work force every year. This accretion to this age group will be



rapid till 2030, after which it begins to decline so much so that during 2045-50 there is hardly any increase, signalling a stabilisation of the 15-64-population cohort and subsequent aging. This is the natural cycle as the population stabilises. The immediate challenge of the next three decades is to create tens of millions of jobs and then to cope with a sharp decline in workers. As China is experiencing now. The demographic definition of population stabilisation means constant birth and death rates over a period of time.

More specifically, a population will be termed to attain stability if it achieves replacement level of fertility of 2.1. The NPP 2000 envisages that India should achieve a stable population by the year 2045; a goal based on the assumption that the country would have reached

the population replacement level TFR 2.1 by the year 2010. We missed that. Recent data on TFR however indicates a postponement of this target and the health ministry is now looking at 2060 as a plausible target for population stabilisation. It would be pertinent to mention here that demographic stabilisation comes much after reaching the replacement level fertility.

An exercise carried out by the Technical Committee on Population constituted by the Planning Commission in 1996 reveals that India will reach replacement level fertility only by 2026. Amongst the Hindi-speaking states Bihar will reach replacement levels only by 2039, Rajasthan by 2048, Madhya Pradesh beyond 2060 and Uttar Pradesh beyond 2100. We should not expect national population stabilisation before 2060 or 2070. These regional disparities manifest themselves in the alarming growth of projected populations in these states. Out of the addition of 773 million to India’s population during 1991-2050, Uttar Pradesh alone would account for a huge 198 million, which is about a fourth of the entire national population increase. Let us take a peek into how the per capita GDP will look in the years to come. In a 2005 paper “Will India Become An Economic Superpower, Does It Matter & What Might Prevent It?” Stephen Howes, Lead Economist (India) at the World Bank, makes per capita income projections to 2050 on the basis of historic growth rates. This

indicates that Bihar, Orissa, UP, MP and West Bengal will have incomes of less than US\$1000 in 2050, which is less than the current per capita GDP and definitely lower than what will be in 2050. Not surprisingly these are the states that will see surging populations. In 2020, India had more than 245 million people in the 15-24 age segments. If savings rates hold and with productive potential at its peak in 2020, we will have a great window of opportunity to make it as a developed and prosperous economy by 2050. That will be possible if we are able to educate and empower the masses. Such a demographic constellation will never appear again. If we have to break out of the poverty trap in the next half a century, the time to make major investments in human and economic development is now.

Owaisi tells Pak its Muslim card won’t work in India

The Tribune Editorial: Asaduddin Owaisi, who heads a political outfit AIMIM, has hit Pakistan where it hurts.

It’s no secret that there are more Muslims in India than in Pakistan. But this fact assumes greater significance when it is emphasised by one of India’s leading Muslim politicians. Asaduddin Owaisi, who heads the All India Majlis-e-Ittehadul Muslimeen — a political outfit that considers itself a custodian of Muslim rights in the country — has hit Pakistan where it hurts. Addressing the Indian diaspora in Kuwait as a member of a multi-party delegation, Owaisi said the neighbouring country could not bank on religion to win over Indian Muslims. “We are more sincere (to our country) than them,” he added, delivering a strong message about his community’s unswerving loyalty to India. Owaisi, a fierce critic of the BJP-led NDA government over Muslim issues, deserves praise for rising above political and communal lines in national interest. Launching a blistering attack on Pakistan, he ridiculed the army chief, Field Marshal Asim Munir, for



presenting a fake photo of a military operation to Prime Minister Shehbaz Sharif. “They want to rival India, but

the image was from a 2019 Chinese military drill,” he said, before coming up with the punchline — ‘Nakal karne ke liye bhi akal chahiye’. His words, all the more painful because an Indian Muslim leader uttered them, added insult to Islamabad’s injury.

However, it’s not only Pakistan that should think long and hard about Owaisi’s remarks. He has effectively hammered home the point that the patriotism of the Muslim community in India should not be doubted. Hopefully, this voice of sanity will deter leaders and supporters of the ruling party from demonising Muslims or treating them with suspicion. The Pahalgam terror attack was an attempt to aggravate communal tensions in the country, but people belonging to various communities have stood together resolutely. This spirit of unity should be sustained against all odds.

Japanese economy | How not to get lost in translation

It’s not overtaking Japan’s GDP that’s instructive for India. We should learn from the Asian powerhouse’s bitter and long experience of trying to cover up underlying economic weaknesses

Global policymakers looking to resuscitate economic activity and combat falling asset prices would do well to critically examine Japan’s trajectory, which illustrates the problems of traditional approaches—especially their risks.

Japanese post-war success was based on low costs, manufacturing competence and an undervalued currency. When the 1985 Plaza Accord forced a revaluation of the yen and adversely affected exports and growth, the authorities cut interest rates, fuelling a debt-funded real estate and stock price boom. The bubble economy collapsed in 1990 and triggered a balance-sheet recession, as heavily indebted households and businesses cut back on consumption and investment to reduce debt. Over two decades, Japanese policymakers repeatedly lowered interest rates, injected liquidity and unleashed waves of government spending to resuscitate the economy. The policies alleviated the slowdown, but did not restore the growth levels or create the inflation needed to boost nominal asset prices and reduce real debt levels. Japan’s potential growth rates fell, reflecting misallocation of capital that reduced returns on investment. Excessive manufacturing capacity and low domestic demand increased reliance on exports and balance of payments surpluses to align production and demand. Government-financed infrastructure investment only provided a short-term boost in economic activity.

Low interest rates and abundant liquidity allowed excessively high debt levels. Weak businesses

survived in a zombie-like state, operating only to pay loan interest. Banks avoided writing off loan assets, tying up capital and reducing credit availability for productive enterprises, especially small and medium




enterprises. Low returns reduced income for savers, decreasing consumption and encouraging additional savings for retirement. The increasing reliance on government spending led to a steady deterioration in public finances as the government ran large deficits. Government debt increased to 220 percent of GDP. The policies acted as a palliative, allowing essential reforms to be deferred. Policymakers borrowing from Japan’s playbook misunderstand the country’s circumstances. When its bubble economy collapsed, Japan was relatively rich and technologically

advanced. The country entered the crisis with modest government debt. It had high domestic savings and a high home investment bias, which allowed the government to finance its spending domestically, assisted by the central bank’s quantitative easing programmes. In the 1990s, Japan benefitted from favourable external conditions. Strong global growth allowed exports to partially offset the lack of domestic demand. A weaker yen was helpful in creating economic activity. Contrary to commonly-held views, Japan’s demographics were helpful. Its aging population was an advantage, because it meant fewer new entrants into the workforce, keeping unemployment low. A falling population supported per capita income, and disinflation or deflation ameliorated the erosion of living standards. There were problems of a shrinking workforce and lower tax base, but Japan’s welfare system is less generous than those in many countries. The social and political background were favourable. Shaped by the hardships of the Second World War and the immediate post-war period, Japanese culture is characterised by strong national consciousness, stoicism and selflessness, particularly among older citizens. There was acceptance of the need for economic sacrifices. Japan is also, de facto, a one-party state, where the ruling LDP is able to pursue its policies with little political opposition. This allowed the country to pursue consistent policies to manage its problems with limited opposition. Most of these conditions do not exist in other countries, should they seek to copy Japan’s approach. The problems are now

global in scope. The world now faces unsustainable debt levels. There are trade and currency wars that are likely to escalate. There is a deteriorating geopolitical security environment, an expensive and slow energy transition, and a resource scarcity. In essence, one lesson from Japan’s experience is that it is better to enter a crisis first as there are greater options. Despite its advantages, Japan has never fully recovered its economic and financial standing. The period since the collapse is known as the ‘lost decades’. There are social costs—elderly poverty encouraging some to commit crimes for the security of jails and a cohort of dispirited young who have opted out of society.

Now, Japan may be illustrating the terminal phase of this process where the side effects of the initially effective policies become toxic. The endgame begins with inflation. Beginning in 2020, the supply shocks from the pandemic and geopolitical events combined with the longstanding loose monetary policies has created price pressures. Japan’s inflation rate, while comparatively lower, rose to around 3 percent. Despite tentative steps, Japanese authorities are reluctant to normalise policy settings. They fear the impact of higher interest costs especially for the government and highly indebted businesses. There is the risk of falls in asset values which support high debt levels. This creates currency weakness. The differential between Japan’s low rates and those in most advanced economies caused the yen to fall from around 100 to the dollar to over 160 (with a modest recent recovery). The devaluation feeds inflationary pressures through higher import prices, especially for raw materials, food and energy. It feeds capital flight, limits policy options and flexibility to respond to new crises.

Manipur MLAs urge Governor to restore elected government, end President's rule

The meeting signals growing momentum within the political class for an end to the President's Rule and the restoration of democratic governance in the conflict-hit state.

New Delhi. Ten MLAs from Manipur met Governor Ajay Kumar Bhalla on Tuesday morning, urging him to initiate the process of installing a popular government in the state, which has been under President's Rule since February 13, 2025.

Following the meeting, MLA Nishikant Sapam addressed the media, stating that the primary objective of their visit was to reflect the will of the people, who, he said, overwhelmingly want a democratically elected government to return.

"It has been over three and a half months since President's Rule was imposed. From every section of society, there is a strong desire to restore a popular government. That was the main purpose of our meeting with the Governor," Sapam said.

He added that the delegation had submitted a signed letter formally requesting the reinstatement of an elected government.

According to him, the Governor responded positively and assured them that the matter would be considered seriously.

"We discussed how the administration under President's Rule is different and cannot effectively replace a popular government. All MLAs aligned with the NDA in Manipur are united in this effort and are very keen to see governance return to the people," Sapam noted.

He also stressed the importance of public support in the process, saying, "Without the people, nothing can move forward. Their backing is essential for stability and development."

Some MLAs who were not physically present had endorsed the same appeal, which has also been forwarded to the Prime Minister and central leadership. Sapam concluded, "Everyone wants the same thing — a popular government that works for the welfare of Manipur and its people." Ex-aide of Congress leader held in Rajasthan for 'spying', visited Pak 6-7 times

New Delhi. A government employee and former personal assistant to a senior Congress leader was detained on Wednesday for allegedly spying for Pakistan's Inter-Services Intelligence (ISI).

The Rajasthan CID and other intelligence special teams from Jaipur detained the individual, Sakur Khan Mangaliya, from a government department office in Jaisalmer. Khan is a resident of Jaisalmer district, and is currently employed in the state's employment office. Shakoor Khan was on duty in the district administration control room of the during Operation Sindoor.

Officials suspect Khan of being involved in suspicious activities. Intelligence agencies had been monitoring him for some time after receiving input about his alleged connections with a Pakistani Embassy official and possible links with the ISI. "Based on inputs from higher headquarters about his involvement in suspicious activities, we have detained him for verification and questioning," said Sudhir Chaudhary, Superintendent of Police, confirming the detention.

Sakur Khan earlier worked as a personal assistant to Shale Mohammad, a former minister in the Congress government. Mohammad and Khan belong to the same village. Sources said the intelligence team has found multiple unknown Pakistani numbers on Khan's mobile phone. He has reportedly failed to explain the presence of these numbers. During questioning, Khan also admitted to visiting Pakistan 6-7 times in the past. According to officials, no military-related videos or sensitive content have been found on his mobile phone so far. However, many posts on the device were found deleted. His financial records, including two bank accounts, are also being examined by intelligence agencies.

"There was surveillance on his movements for some time. His links with an officer in the Pakistan Embassy and the possibility of connections with a Pakistani intelligence agency prompted the intelligence team from Jaipur to take action," sources added. Khan is expected to be taken to the Central Investigation Centre in Jaipur for further interrogation.

Crashes, Cattle & Chaos: recipe for disaster

NEW DELHI. The roads of Delhi—some newly paved, others worn by decades of overuse—tell a story of chaos, carelessness and chronic neglect. Behind the rising toll of road accidents in the national capital lies a mix of poor infrastructure, risky driving behaviours, enforcement gaps and civic apathy. From overspeeding on major arterial roads to stray cattle appearing out of nowhere, residents, traffic officials and experts point to multiple overlapping factors that make Delhi's streets a dangerous place for both drivers and pedestrians.

Crashes Rooted in Behaviour

A senior Delhi Police official said that one of the most pressing concerns is non-compliance with basic traffic rules. "Many people do not wear helmets, drive under the influence of alcohol and over-speed in areas where traffic is light. There are even bikers who ride on footpaths, creating safety hazards for pedestrians," the official said. These violations often go unchecked in many parts of the city, with commuters offering excuses rather than accepting accountability when confronted by traffic personnel. Data from Delhi Police reflects a sobering picture: in 2023, there were 5,834 reported road crashes, up from 5,652 in 2022. While the number of fatalities remained relatively consistent—1,457 deaths in 2023 compared to 1,461 the previous year—the figures underscore a persistent crisis. Injuries rose to 5,470 in 2023, from 5,201 in 2022.

Key Problem Areas

Several key roads in the city have been identified as high-risk zones including Ring Road, Outer Ring Road, GTK Road, Rohtak Road, NH-8, Bawana Road, and Mathura Road among them. One particularly dangerous stretch is the Ring Road near Lajpat Nagar, a busy segment flanked by residential areas and markets.

BJP Minority Morcha chief claims Muslims are descendants of Lord Ram

New Delhi. Jamal Siddiqui, National President of the BJP's Minority Morcha, drew strong theological and cultural parallels between Sanatan Dharma and Islam. In an interview with India Today, Siddiqui made striking claims about the origins of the religion, the status of Hindu deities within Islamic tradition, and the intertwined heritage of India's diverse communities.

Siddiqui said Santan Dharma came much before Islam, adding that it is the foundation of the civilisation. He further said that all Muslims are descendants of Lord Ram.

"Sanatan Dharma came much before Islam. It is the foundation of our civilisation," Siddiqui stated, emphasising the deep historical roots of Indian culture. Taking his viewpoint further, he said,

"Muslims who do not believe in Ram and Krishna cannot be called Muslims," asserting that these revered figures may have a place within

Islamic spiritual lineage. Siddiqui

grounded his remarks in Islamic theology, explaining that Islam acknowledges not just one prophet but many.

"The Quran mentions 25 prophets, but according to Hadith and tradition, there were 1,24,000 prophets sent across the world. How can we say Lord Ram and Lord Krishna were not among them?" he asked. "They may well have been messengers of God."

He also claimed a common ancestry, saying, "All Muslims are descendants of Lord Ram," suggesting that the roots of the Muslim community in India are intertwined with ancient Hindu tradition.

He clarified that while methods of worship may have changed, the underlying culture has remained constant. "Our identity is still Sanatani," Siddiqui said.

Shashi Tharoor slams 'zealots' after Congress flak over surgical strike remark

Shashi Tharoor came under severe criticism from Congress over his remark that India crossed the LoC to carry out surgical strikes 'for the first time' under the Modi government.

New Delhi. In a sharp clapback to jabs from his own party for supporting the Centre over cross-border strikes, Congress MP Shashi Tharoor accused "critics and trolls" of distorting his views and words and said that he had "better things to do".

Tharoor, who is leading a multi-party delegation as part of the Centre's global outreach on terrorism, came under severe criticism from Congress over his remark that India crossed the LoC to carry out surgical strikes "for the first time" under the Narendra Modi government in 2016.

Clarifying his remark, Tharoor said he was referring to reprisals for terrorist attacks and not about previous wars.

"For those zealots fulminating about my supposed ignorance of Indian valour across the LoC in the past," Tharoor posted on X. "I was clearly and



explicitly speaking only about reprisals for terrorist attacks and not about previous wars. My remarks were preceded by a reference to the several attacks that have taken place in recent

years alone, during which previous Indian responses were both restrained and constrained by our responsible respect for the LoC and the IB," he further said.

Monuments of corruption: Projects worth Rs 900 crore lie abandoned in Chhattisgarh

New Delhi. In the heart of Naya Raipur, a gleaming skywalk built at a staggering cost of crores stands deserted. Below it, there are no commuters, no busy footfalls, only the echo of mismanagement and waste. This isn't an isolated story, but a recurring theme across Chhattisgarh.

Over the past decade, the Chhattisgarh government has spent more than Rs 1,000 crore on skywalks, luxury malls, bus stands, auditoriums and ministerial bungalows. Yet, most of these grand projects have become empty monuments to poor planning and alleged corruption.

The Rs 100 crore CBD Mall, locked since 2019, is a glaring example. A Rs 10 crore bus stand has been gathering dust for eight years. A Rs 8 crore hospital, meant to serve the poor, is still not operational.

Across the state, numerous such structures, intended to benefit the public, now lie abandoned, caught in a web of inefficiency and graft, reportedly enriching contractors and politicians, with



total estimated losses nearing Rs 900 crore. Locals are frustrated. "This skywalk is a waste. It's not useful at all," said one resident. "In fact, it's unsafe for women. It's become an adda for goons." Another echoed similar sentiments, stressing that the projects have failed to serve any real purpose. Urban planners argue that these projects were never meant to meet real needs.

"A simple foot over bridge would have solved the traffic congestion issues," says RTI activist Rakesh Chaubey. "There was no need for a skywalk worth crores. It's clear corruption funds meant for real development were siphoned off into vanity projects."

The contrast is jarring. While hollow urban structures stand unused, footage from remote villages shows people walking

miles for water, children studying in dilapidated schools, and patients waiting outside crumbling health centres.

As these monuments of neglect stand in silent testimony, political blame games have begun. Congress spokesperson Amit Srivastava blamed the previous BJP government, stating, "These projects were started under BJP rule, which focused more on glitzy structures than real development."

Countering this, PWD Minister and Deputy CM Arun Sao said, "The Congress has been in power for years now. Why haven't they put these buildings to use? Instead of fixing issues, they keep blaming others."

Today, these deserted structures are not just reminders of wasted public money but also symbols of flawed governance. As Chhattisgarh's citizens continue to struggle for basic needs, these vacant buildings stand as stark indictments of misplaced priorities and systemic corruption.

Delhi teen kills two after hitting bicycle with car, then crashing into slum

Delhi. At least two people were killed and three injured after a Swift car, driven by a 19-year-old boy, first hit a cyclist and then crashed into a roadside slum after losing control. The incident was reported at 3:30 am from west



Delhi's Pankha Road. Upon receiving the PCR call, police rushed to the spot and took the injured to the hospital. The boy behind the wheel has been taken into police custody. In

March, another crash was reported in West Delhi's Naraina area, where a Maruti Ciaz collided with a tree around midnight. Of the four occupants in the car, two were pronounced dead.

Encroachers awaiting rehabilitation cannot stay on public land, says Delhi HC

NEW DELHI. The Delhi High Court has ruled that people living on public land without permission cannot continue staying there just because they are awaiting the resolution of their rehabilitation claims under the relevant government policies. Justice Dharmesh Sharma made the observation while dismissing a set of petitions by residents of jhuggi jhopri (JJ) clusters in Bhoomiheen Camp, in the city's Govind Puri area.

These residents had asked the court to stop the Delhi Development Authority (DDA) from continuing demolition work and evicting them. They also wanted the Delhi Urban Shelter Improvement Board to carry out a fresh and detailed survey and provide rehabilitation as per the 2015 policy on slum and JJ relocation. The court refused the request and stated that eviction and eligibility for rehabilitation are two separate processes.

"There is no gainsaying that the petitioners have no vested right to seek rehabilitation, as it is not an absolute constitutional entitlement available to encroachers such as themselves. The right to rehabilitation arises solely from the prevailing policy, which binds the petitioners. The determination of eligibility for rehabilitation is a separate process from the removal of encroachers from public land," the court noted. The judge emphasised that allowing people to stay on government land while their rehabilitation status is decided could delay important public projects.

Fear in Okhla over demolition notice

NEW DELHI. In the tightly packed lanes of Taimoor Nagar, Batla House, and Muradi Road, anxiety hangs thick in the air, with just days left for demolition—scheduled a day before Eid (June 7).

On the night of May 22, without warning or explanation, eviction notices were slapped on the residents' doors. No police presence nor prior communication. Just red crosses painted on walls that have seen generations come and go. Families who have called the streets home for over 40 years now count down the final days before they are displaced.

The notice warns in Hindi: "This is to inform the general public that in Village Okhla, at Khasra Number 277 (Khizar Baba Colony, Muradi Road), Delhi, land belonging to the Irrigation Department of the Government of Uttar Pradesh has been illegally encroached upon, and permanent houses and shops, have been constructed. Remove these illegally constructed houses and shops within 15 days. Else, in the event of any damage/harm, you'll be solely responsible."

This comes weeks after the Supreme Court issued a directive to the Delhi Development Authority (DDA) on May 8 to carry out a demolition drive to raze unauthorised structures spread over more than 4 vighas of public land in Okhla villages as per the due process of law within three months. Accordingly, a 15-day notice was to be served before demolition. The Supreme Court's order emanated from a contempt plea related to non-compliance with a 2018 directive, in which an order was passed against illegal construction and encroachment on public land.

Which tax form should salaried individuals choose: ITR-1 or ITR-2

New Delhi. As the income-tax filing season for 2025-26 commences, salaried individuals face the decision of choosing the appropriate tax form between ITR-1 and ITR-2. Understanding the eligibility criteria and recent updates is crucial for ensuring accurate tax filing.

The Income Tax Department has notified all ITR forms earlier this month, prompting individuals to start preparing their documents, although Form 16s are typically released in the month of June. Notably, the changes introduced in the recent Budget have introduced modifications in tax slabs and capital gains tax regulations, affecting the selection of tax forms this year.

WHAT IS ITR-1 (SAHAJ)?

ITR-1, also known as Sahaj, is designed for resident individuals whose income does not exceed Rs 50 lakh. This simple form is appropriate for those whose income sources are limited to salary, pension, one house property, and income from savings or fixed deposits, dividends, and family pension. Additionally, taxpayers with long-term capital gains (LTCG) up to Rs 1.25 lakh from listed equity shares or equity mutual funds under Section 112A can utilise this form for the current financial year. The ease of use is further enhanced by pre-filled personal information and income details, allowing for online verification against documents like Form-16 and bank account statements.

New pension rules for PSU employees: Key things to know

New Delhi. The central government has amended pension regulations that could have major implications for employees who move from government departments to public sector undertakings (PSUs).

Under the newly notified Central Civil Services (Pension) Amendment Rules, 2025, any PSU employee dismissed or removed after absorption due to misconduct could forfeit their PSU-related benefits and pension entitlements earned during their earlier government service. The change, incorporated under Rule 37(29C) of the CCS (Pension) Rules, 2021, marks a toughening of the disciplinary framework. Previously, employees absorbed into PSUs retained pension benefits from their time in government service, even if they were later dismissed from the PSU. That protection is now gone.

The revised rule states that if an absorbed PSU employee is terminated for misconduct, their entire pension, both from PSU service and previous government service, can be forfeited.

However, such decisions will not be absolute. They must undergo review by the administrative ministry responsible for the concerned PSU, adding a layer of checks and balances to the process. The rules also align PSU dismissals with the standards applied to government employees under Rules 7, 8, 41, and 44 of the CCS Pension Rules, ensuring consistency in how disciplinary actions impact retirement benefits. This amendment applies to employees who were initially appointed to government service on or before December 31, 2003. It is being seen as an attempt to reinforce accountability among PSU staff, signalling that misconduct at any point in an employee's career can have long-lasting financial consequences.

Radico Khaitan withdraws brand name of new single-malt whisky after objections

New Delhi. Radico Khaitan, one of India's leading liquor manufacturers, has decided to withdraw the 'Trikal' brand name from its new range of single-malt whisky following concerns over religious sentiments. The company announced the move in a stock exchange filing on Wednesday, 28 May 2025.

"We understand that concerns have been raised regarding the brand name. As a responsible and sensitive organisation, post internal review we have decided to withdraw the brand," the company said in its filing. Radico Khaitan emphasised that the decision was not merely commercial but a mark of respect for public sentiment. "This is not just a business decision, it is a gesture of respect,



reflection, and our unwavering commitment to honour the sentiments of our people and our country." The matter escalated after the excise department in Uttarakhand stated that the company had not received any approval to manufacture, register, or sell the whisky in the state. "The whisky has neither been allowed to be manufactured in the state, nor has any approval been granted for registration or sale," Excise Commissioner Harichandra Semwal told newsagency ANI.

According to the company, the name 'Trikal' was inspired by a Sanskrit term meaning "three times" — the past, present, and future. Crisil Pegs India's GDP Growth At 6.5% In Fiscal 2026

New Delhi. Crisil on Thursday forecast India's gross domestic product (GDP) growth at 6.5 per cent in fiscal 2026, adding that improving domestic consumption is likely to support industrial activity. "We expect domestic consumption demand to improve driven by healthy agricultural growth, easing inflation supporting discretionary spend,



rate cuts by the Reserve Bank of India (RBI)'s Monetary Policy Committee (MPC) and income tax relief this fiscal," the global ratings agency said in a note. The India Meteorological Department expects an above-normal monsoon this fiscal (106 per cent of long-period average), which bodes well for agricultural production and inflation. Furthermore, according to Crisil Intelligence, crude oil prices are expected to remain subdued this fiscal, averaging \$65-\$70 per barrel compared

with an average of \$78.8 per barrel in the previous fiscal. "We expect the MPC to cut the repo rate by another 50 basis points (bps) this fiscal, after 50 bps cuts until April. Bank lending rates have begun easing, which should support domestic demand," according to the note. Overall, Crisil forecasts gross domestic product (GDP) growth at 6.5 per cent in fiscal 2026, with external headwinds posing downside risks. In the month of significant tariff announcements by the United States (US), IIP growth slowed in

April. Production slowed in certain export-oriented sectors (including pharmaceuticals and chemicals), while front-loading exports benefitted others (machinery and readymade garments). Among consumer goods, durables performed better than non-durables. Industrial goods recorded a mixed performance, with output growth in capital goods picked up sharply along with a mild acceleration in intermediate goods. Performance of export-oriented sectors was mixed in April, despite the sharp improvement in merchandise exports (9.0 per cent in April in nominal terms vs 0.7 per cent in the previous month). There was also a 6.4 per cent increase in the production of consumer durables such as electronic goods, refrigerators, and TVs during November, reflecting the higher consumer demand for these items amid rising incomes, according to data released by the Ministry of Statistics. The infrastructure sector clocked a growth of 4 per cent on the back of big-ticket government projects being implemented in the highways, railways and ports sectors.

Asian shares and US futures jump after court rules against Trump's sweeping tariffs

New Delhi. Asian shares have advanced and US futures jumped after a federal court blocked President Donald Trump from imposing sweeping tariffs on imports under an emergency-powers law.

The court found the 1977 International Emergency Economic Powers Act, which Trump has cited as his basis for ordering massive increases in import duties, does not authorise the use of tariffs. A three-judge panel ruled on several lawsuits arguing Trump exceeded his authority, casting doubt on trade policies that have jolted global financial markets, frustrated trade partners and raised uncertainty over the outlook for inflation and the global economy. The Trump administration filed an appeal, and it was unclear if the White House will respond to the ruling by pausing all of its emergency power

tariffs in the interim.

Many of Trump's double-digit tariff hikes are paused for up to 90 days to allow time for trade negotiations, but the uncertainty over their eventual outcome has stymied businesses and left consumers wary about what lies ahead. "Just when traders thought they'd seen every twist in the tariff saga, the gavel dropped like a lightning bolt over the Pacific," Stephen Innes of SPI Asset Management said in a commentary. The ruling was, at the least, "a brief respite before the next thunderclap." The future for the S&P 500 was up 1.6% while that for the Dow Jones Industrial Average gained 1.2%. Japan's Nikkei 225 index jumped 1.5% to 38,263.36. American's largest ally in Asia has been appealing to Trump to cancel the tariffs he has ordered on imports from Japan and to

also stop 25% tariffs on steel, aluminum and autos. The ruling also pushed the dollar sharply higher against the Japanese yen. It was trading at 146.06 yen early Thursday, up from 144.87 yen late Wednesday. Australia's S&P/ASX 200 gained 0.3% to 8,418.90. In South Korea, which like Japan relies heavily on exports to the U.S., the Kospi surged 1.4% to 2,707.77. Shares also were helped by the Bank of Korea's decision to cut its key interest rate to 2.5% from 2.75%, to ease pressure on the economy.

On Wednesday, U.S. stocks cooled, with the S&P 500 down 0.6% to 5,888.55. It's still within 4.2% of its record after charging higher amid hopes that the worst of the turmoil caused by Trump's trade war may have passed. It had been roughly 20% below the mark last month.

IndusInd Bank's Stock In Turmoil As SEBI Bans CEO From Securities Market

Mumbai. The stock of IndusInd Bank has declined 11 per cent since March 10 following the bank's disclosure of suspected fraud and concerns over insider trading. On March 10, the bank's then Chief Executive Officer Sumant Kathpalia said during an analyst call that these derivative trades took place over five to seven years ago and came to light when the bank took the review of the portfolio after the RBI's accounting framework, which was identified by September and October 2024. Soon after, the bank started an internal review in the matter and informed the regulator about it. The bank had also appointed an external agency to validate its internal findings. On Thursday, the bank's shares were trading at Rs 813.95 apiece, up Rs 8.80 or 1.09 per cent. In the latest development, the Securities and Exchange Board of India (SEBI) has barred former Kathpalia and four others from dealing in the share market. SEBI said they were aware of unpublished price sensitive information about the lender's derivative trades. IndusInd



Bank's former executive director and deputy CEO, Arun Khurana, along with head of treasury operations Sushant Sourav, head of GMG operations Rohan Jathanna, and chief administrative officer of consumer banking operations Anil Marco Rao are the other officials named in the order. The individuals have been restrained from buying, selling or dealing in securities, either directly or indirectly, in any manner until further

orders, the SEBI said in an interim order. Last week, Ashok P. Hinduja, Chairman, IndusInd International Holdings Limited (IIHL) which is the promoter of IndusInd Bank, went into damage-control mode following the announcement of the fraud in the bank that has plunged the lender into a Rs 2,236 crore loss for the January-March quarter. "Though the capital adequacy of the Bank is quite healthy, for business growth, should any further

equity be required, IIHL, as the promoter of IBL, remains committed to supporting the Bank, as it has done over the past 30 years," Hinduja said in a statement.

The RBI has launched investigations into the accounting discrepancies at IndusInd Bank. IndusInd Bank said that its Board suspects a fraud involving certain employees, who played a significant role in the lender's accounting and financial reporting, and has directed all necessary actions to be taken under applicable laws, including reporting the matter to regulatory authorities and investigative agencies. IndusInd Bank's internal audit department found on May 20 that Rs 172.58 crore had been incorrectly recorded as fee income in the Microfinance (MFI) business over three quarters ending the December quarter, which has since been reversed in the fourth quarter of FY25.

The disclosure follows the abrupt sacking of the IndusInd Bank CEO last month after widespread irregularities were discovered in its foreign exchange derivatives and microfinance portfolio.

Jansen bowled the crucial overs both in the powerplay and death and the team will certainly miss him on Thursday night. Kyle Jamieson showed promise in his debut for the franchise but will need to bowl better upfront to make an impact.

Despite losing their first three home games, RCB bounced back by excelling on the road, giving themselves crucial breathing space. Their dramatic chase of 228 against the Lucknow Super Giants - now the third-highest successful run chase in IPL history -
