

According to the data available on the official website of the Ministry of Health



and Family Welfare, 306 new cases were added to the active case count since Friday. Kerala has recorded 2,223 cases, Gujarat 1,223, Delhi 757, and West Bengal 747. Maharashtra has recorded a total of 615 cases so far, while Karnataka and Uttar Pradesh have reported 459 and 229 cases, respectively. Tamil Nadu has reported 204 cases, Puducherry 10, Haryana 125, Andhra Pradesh 72, Madhya Pradesh 65, and Goa six. Official data shows a total of 74 deaths since January due to the deadly virus so far, which began in 2020.



Auto ride in Bengaluru to get costlier; base fare at Rs 36

BENGALURU. The base autorickshaw fare is expected to increase from the existing Rs 30 to Rs 36, and the subsequent perkilometre charges from Rs 15 to Rs 18, according to highly placed sources.

Autorickshaw drivers and unions have been repeatedly urging the government to increase the fares for a long time. They have been demanding that the base fare be revised to Rs 40 and the per-kilometre charge to Rs 20.

Officials from the 10 Regional Transport Offices (RTOs) falling within the city limits, Deputy Commissioners of Police (Traffic) and representatives from the auto drivers' unions will be part of the District Transport Authority (DTA), which will decide the fare revisions after considering factors like existing fuel prices, traffic condition in the city and passenger demand. Based on the recommendation, the Bengaluru Urban deputy commissioner, who chairs DTA, will take the final decision on fare revision.

'Auto fares not revised since 2021'

According to sources from the Bengaluru Urban DC office, the revised fares are Rs 36 and Rs 18 and is awaiting the nod of Bengaluru Urban DC Jagadeesha G. The source said the DC is heading the magisterial probe into the stampede near Chinnaswamy Stadium and is completely occupied with that work and once he gets free, the fares will be announced officially.

Auto unions like the Autorickshaw Drivers' Union, Adarsh Auto and Taxi Drivers Union said that they will get into the streets if the revised fares are not Rs 40 and Rs 20.

"Fares have not been revised since 2021. In all these years, prices of many things have increased. We urge the auto fare revision to be linked to the Wholesale Price Index," said General Secretary of ARDU Rudra

IT belt citizens launch 'Project Abhimanyu', to send junk art to BBMP chief over bad roads

BENGALURU. Frustared over bad roads. residents in the IT belt in Gunjur and surrounding areas are set to launch 'Project Abhimanyu', which involves gifting junk art using spare parts of scooters and cars to Bruhat Bengaluru Mahanagara Palike (BBMP) Chief Commissioner. Speaking about the symbolic protest over good roads that has remained elusive for the last several years in Varthur, Gunjur, Panathur, Thubarahalli, Balagere, S Cross Road, and other areas, Gobind Srivatsa from Prestige Lakeside Habitat Apartments said: "The IT belt residents pay the highest tax but in return, the civic body has deprived us of basic infrastructure. Many office goers complain about their vehicles being damaged due to bad roads. This apart, travelling on bad roads is like risking lives."

The BBMP has violated my constitutional right to livelihood hence, the next step is to approach the high court against the BBMP," said Srivatsa who is spearheading the project. He said the residents have to break the 'Chakrayuha' of bad roads, broken footpaths, clogged drains and others. "The residents will only highlight failed infrastructure over the years and there is nothing political about it."

Expressing frustration on the bad civic infrastructure in Mahadevapura Zone, Anitha Janardhanan, another resident of Prestige Apartment in Varthur, said that due to potholes, her drive from home to the office on Brookefield has become a daily ordeal. "My car windshield and suspension were damaged as I was unable to see the huge pothole during rains. As the front wheel landed in the crater, the windshield broke into pieces. My car suspension was also damaged in the process," said Janardhanan.

Meanwhile, the BBMP Chief Commissioner Maheshwar Rao as well as the Additional Chief Secretary and BBMP Administrator Tushar Giri Nath have directed the zonal officials to give attention to potholes and fix footpaths.

Another laser beam hits flight near Chennai airport, third in a monthAnother laser beam hits flight near Chennai airport, third in a month

Last week, an Emirates flight from Dubai with over 300 passengers was targeted by a green laser beam while descending into Chennai.

CHENNAI. An Air India Express flight carrying more than 170 passengers was hit by a laser beam during its final approach to Chennai airport early on Tuesday, the third such incident reported in the city's airspace in

less than a month. The latest incident adds to growing concern among aviation regulators and pilots over a recent uptick in laser-related incidents in Chennai's airspace, despite warnings from the Greater Chennai Police against the use of laser beam lights that can pose a

threat to passenger safety. On Tuesday, Flight IX2660 from Pune was around three nautical miles from touchdown on runway 25 when the crew reported a flashing white laser aimed at

the aircraft's right side, according to Chennai airport sources. The incident occurred at 1.03am during the aircraft's descent, a phase considered among the most critical for pilots. Authorities at Chennai International Airport notified the Directorate General of Civil Aviation (DGCA), airport police station and Air India Express station manager for necessary

action. Succeeding arrivals did not report any such activity, airport sources stated. Officials confirmed an investigation is under way.

"Contrary to alarmist portrayals, pilots handled the situations calmly and professionally, and no emergency occurred," AAI said on social media platform 'X'.

AIADMK man among three held under Goondas in Chennai after pub brawl

CHENNAI. Two AIADMK members, initially apprehended for a pub altercation in Nungambakkam, have been detained under the Goondas Act. This follows a surge in the number of fraud allegations against them after their initial arrest, the police said.

Sources said D Ajayrogan (36) alias Ajay Vandayar, a businessman and T Prasad (33), an IT wing functionary of the AIADMK, were among the five people taken into



custody after a brawl at a pub in Nungampakkam weeks ago. The other arrested are R Ganesh Kumar (42), G Dhanasekar (29), and Nagendra Sethupathi (33), a history-sheeter.

Further investigations into Prasad's activities led to the

arrest of a police sub-inspector, Manikumar, and head constable, Senthil Kumar (44), who served as a personal security officer for an incumbent member of Parliament. They are allegedly accused of assisting Prasad in a job scam, the police said. In a separate case, Daniel, a man facing numerous charges, including the abduction of a film assistant director and a sexual assault case, has also been detained under the Goondas Act, the police said.

Daniel was among seven people arrested on May 29 for the alleged kidnapping and intimidation of Rajakumaran, an assistant director working with filmmaker Suseenthiran.

World's most popular TikTok star Khaby Lame leaves the US after being detained by

LAS VEGAS. Khaby Lame, the world's most popular TikTok personality with millions of followers, has left the US after being detained by immigration agents in Las Vegas for allegedly overstaying his visa. The Senegalese-Italian influencer, whose legal name is Seringe Khabane Lame, was detained Friday at Harry Reid International Airport but was allowed to leave the country without a deportation order, a spokesperson for US Immigration and Customs Enforcement confirmed in a statement.Lame arrived in the US on April 30 and "overstayed the terms of his visa," the ICE spokesperson said. The Associated Press sent a message seeking comment Tuesday to the email address listed on Lame's Instagram account. He has not publicly commented on his detainment. His detainment and voluntary departure from the US comes amid President Donald Trump's escalating crackdown on immigration, including raids in Los Angeles that sparked days of protests against ICE, as the president tests the bounds of his executive authority. A voluntary departure — which was granted to Lame — allows those facing removal from the US to avoid a deportation order on their immigration record, which could prevent them from being allowed back into the US for up to a decade.

The 25-year-old rose to international fame during the pandemic without ever saying a word in his videos, which would show him reacting to absurdly complicated "life hacks." He has over 162 million followers on TikTok alone.The Senegal-born influencer movd to Italy when he was an infant with his working class parents and has Italian citizenship. His internet fame quickly evolved. He signed a multi-year partnership with designer brand Hugo Boss in 2022. In January, he was appointed as a UNICEF goodwill ambassador.

US appeals court lets Trump administration keep collecting tariffs while challenges continue

WASHINGTON. A federal appeals court agreed Tuesday to let the government keep collecting US President Donald Trump's sweeping import taxes while challenges to his signature trade policy continue on appeal. The decision by the US Court of Appeals for the Federal Circuit extends a similar ruling it made after another federal court struck down the tariffs May 28, saying Trump had overstepped his authority. Noting that the challenges to Trump's tariffs raise "issues of exceptional importance," the appeals court said it would expedite the case and hear arguments July 31. The case involves 10% tariffs the president imposed on almost every country in April and bigger ones he imposed and then suspended on countries with which the United States runs trade deficits.It also involves tariffs Trump plastered on imports from China, Canada and Mexico to pressure them to do more to stop the illegal flow of immigrants and synthetic opioids across the US border.

In declaring the tariffs, Trump had invoked emergency powers under a 1977 law. But a three-judge panel of the US Court of International Trade ruled he had exceeded his power. The tariffs upended global trade, paralyzed businesses and spooked financial markets.

Hamas kills at least 50 Palestinian fighters armed by Israel in Gaza



world. At least 50 fighters of a Palestinian gang armed by Israel in Gaza have been killed by Hamas in the recent months. Clashes between Hamas fighters and members of the militia led by Yasser abu Shabab, erupted early on Tuesday in Rafah.

The Guardian citing an Israeli news channel, i24 reported that Israeli soldiers had clashed with Hamas members in order to protect Abu Shabab from being killed, which resulted in deaths on both sides.

Last week Israeli defence officials had acknowledged arming the militia withthe aim of undermining Hamas. The Guardian quoting aid workers said that the group had a long history of looting from UN trucks.On Tuesday, in a og statement released to the press, Abu Shabab's militia, named the Anti-Terror Service or Popular Forces, said: "Hamas has killed over 50 of our volunteers, including relatives of our leader, Yasser, as we guarded aid convoys and redistributed supplies that were otherwise destined for corrupt entities linked to Hamas."We've also cleared explosive remnants from the area - losing members in the process."On 7 October 2023, during Hamas's attack in Israel that ignited the war, Abu Shabab was languishing in a Hamas-run jail in Gaza on charges of drug trafficking. With the outbreak of the conflict, the Palestinian from Rafah managed to leave prison, though the circumstances of his release remain unclear, The Guardian report said. His Israeliarmed gang now consists of more than 100 men who operate in eastern Rafah. Abu Shabab has been nicknamed "the Israeli agent" and described as a traitor on social media in Gaza. Hamas has publicly declared its intent to kill him.Israeli analysts have warned that the move by Israel to arm Abu Shabab could push Gaza to the brink of a civil war.

Russian strike on Ukraine's Kharkiv kills 3, injures 60 amid stalled peace talks

Russia has fired record numbers of drones and missiles at Ukraine over recent weeks, escalating daily bombardments as it outlines hardline demands to halt its invasion.

KHARKIV. Fresh Russian strikes on Ukraine's northeastern city of Kharkiv killed three people and wounded 60 including children early on Wednesday, authorities said, as Moscow pushed ahead with its relentless attacks after rejecting an unconditional ceasefire.Russia has fired record numbers of drones and missiles at Ukraine over recent weeks, escalating three years of daily bombardments as it outlines hardline demands -- rejected by Kyiv as

"Seventeen strikes by enemy UAVs (drones) were carried out in two districts of the city tonight," Kharkiv Mayor Igor Terekhov said on Telegram.Kharkiv Governor Oleg Synegubov said three people had been killed.AFP journalists in the city saw damaged apartment blocks, burnt out cars and streets strewn with debris after the attacks. Olena Khoruzheva had run into the hallway -- away from the windows -- with her two children when she heard the incoming drones. "The younger one lay on the floor, hands on his head. I was on top of him," the 41-year-old pharmacist told AFP. We heard it approaching. Silence, and then we were thrown against the wall ... there were more explosions, then we heard people shouting 'Help! Help!" Her 65-yearold neighbour was one of those killed in the

attack.Early on Wednesday morning, an

removing the body of one killed resident from a block of apartments in a black body bag.Ukraine's air force said Russia had fired 85 drones overnight -- fewer than in recent days.US President Donald Trump has been urging the two sides to strike a peace deal Ukrainian President Volodymyr Zelensky has in turn called on the West to up the pressure on Russia with hard-hitting economic sanctions that he says would limit its capacity to wage war.He is expected to press that message with Trump and European leaders at a G7 summit in Canada, which kicks off on Sunday. Two

rounds of peace talks between Russia and Ukraine have failed to yield a breakthrough in ending the war.Russia has rejected calls for an unconditional ceasefire and demanded that Ukraine give up its territory and bid to join NATO.But the two sides agreed to swap more than 1,000 prisoners of war and hand over the bodies of dead soldiers, swapping groups of captured soldiers on Monday and Tuesday.The attacks came after Russia pummelled Kharkiv on Saturday in what Terekhov had called "the most powerful attack" on the city since the start of the war.Kyiv has hit back with retaliatory drone strikes on Russia, with Moscow's defence ministry saying 32 Ukrainian drones were intercepted overnight.Both sides have downplayed any chance of progress at talks in Istanbul. While not rejecting diplomacy, Zelensky called it "pointless" to hold further talks with the current Russian delegation -- whom he previously dismissed as "empty heads" -- since they could not agree to a ceasefire.

Raids in Southern California rattle immigrant communities, including those in US legally

LOS ANGELES. Jacob Vasquez began working at a clothing warehouse in Los Angeles soon after arriving from Mexico less than three years ago. He is among dozens of workers detained by federal immigration authorities in a series of raids in LA's fashion district and at Home Depot parking lots in Southern California.More than 100 people ave been detained. The raids have triggered days of turbulent protests across the city and beyond and led US President Donald Trump to deploy National Guard troops and Marines to the LA area, the latest development in the administration's immigration crackdown.Meanwhile, protests in the city's downtown have ranged from peaceful to raucous, with demonstrators blocking a major



freeway and setting cars on fire over the weekend.Immigrant advocates say the workers who were detained do not have criminal histories and are being denied their due process rights.

Vasquez has a three-month-old baby, according to his family who spoke to reporters outside the Ambiance Apparel warehouse, a clothing company founded in 1999, and where

Trump says he will 'liberate' Los Angeles in speech to mark US Army's 250th anniversary

FORT BRAGG US President Donald Trump called protesters in Los Angeles "animals" and "a foreign enemy" in a speech at Fort Bragg on Tuesday as he defended deploying the military on demonstrators opposed to his immigration enforcement raids and as he vowed to "liberate" the West Coast city.

Trump, in his most aggressive language yet regarding the protests, used a speech ostensibly supposed to be used to recognize the 250th anniversary of the US Army to denounce the protesters while repeating his false statements about the 2020 election being rigged and attacking the previous commander in chief, former President Joe Biden. The Republican president, who sees the military as a critical tool for domestic goals, has used the recent protests in Los Angeles as an opportunity to deploy the National Guard and US Marines over the objections of California's Democratic governor. Protesters blocked a major freeway and set cars on fire over the weekend in Los Angeles, but the demonstrations in the city of 4 million people have largely been centered in several blocks of downtown.

We will not allow an American city to be invaded and conquered by a foreign enemy. That's what they are," Trump said Tuesday. Trump's heated rhetoric came as he has left open the possibility of invoking the Insurrection Act, one of the most extreme emergency powers available to the president. It authorizes him to deploy military forces inside the US to suppress rebellion or domestic violence or to enforce the law in certain situations. Trump received plenty of cheers from the crowd, which laughed at the president's jokes and delighted in his dancing to his campaign anthem of "YMCA." However, some members of the audience were uneasy with certain aspects of his remarks.

Robin Boothe, who voted for Trump and works on the base as an audiology assistant, said the speech was "classic Trump." However, she also found it to be too partisan, especially his comments on Los Angeles.

'I thought that was better left for a news conference than what we were celebrating today," the 50-year-old said.

The president called Los Angeles "a trash heap" with "entire neighborhoods under control" of criminals and said the federal government would "use every asset at our disposal to quell the violence and restore law and order.""We will liberate Los Angeles and make it free, clean and safe again," Trump said.

Frump authorized the deployment of 4,000 National Guard soldiers to the city against the wishes of California Gov. Gavin Newsom. About 700 Marines were deployed to the Los Angeles area but had not yet been sent to respond to the protests. Newsom asked a federal court Tuesday to block Trump from using the military in his city. California leaders accused Trump of fanning protesters' anger and stoking the unrest.

In an address Tuesday evening, Newsom warned: "California may be first, but it clearly will not end here. Other states are next. Democracy is next. Democracy is under assault before our eves."

UK government expected to boost defence, NHS in major spending review

LONDON. Britain's Labour government will unveil its day-to-day spending and investment plans for the coming years on Wednesday, with big funding increases to defence and healthcare expected, along with cuts elsewhere. Finance minister Rachel Reeves is set to address parliament country's sluggish growth, which risks added pressure from US President Donald Trump's tariffs onslaught. Ahead of her speech, Reeves said the government would invest in security, health and the economy "so working people all over our country are better off." She also promised to "invest in Britain's renewal."Defence and the struggling National Health Service (NHS) are set for a funding boost, which leaves other ministries facing cuts.Reeves, the chancellor of the exchequer, has amended her fiscal rules to allow the government more headroom for investment in the runup to the spending review. At the same time, she is looking to balance the books so

that tax revenues match day-to-day spending, meaning the government borrows only to invest. The minister has allowed the Treasury to borrow more, particularly for infrastructure projects across the vital housing and energy sectors. 
Northeast Nss Festival 2025 **Kicks Off In Nagaland**

Haryana's accelerates Floor Preparedness ahead of Monsoon

Chandigarh, June 11 – In a high-level meeting held today, Haryana's Financial Commissioner for Revenue and Disaster Management, Dr. Sumita Misra, reviewed the state's preparedness ahead of the upcoming monsoon. Chairing the meeting with all Deputy Commissioners, Dr. Misra emphasized a proactive and strategic approach to flood mitigation, calling for quality site inspections, real-time monitoring, and swift execution of all preparedness measures. Dr. Misra directed Deputy Commissioners to ensure comprehensive contingency planning, including ground-level mock drills. She instructed officers to map all pumping infrastructure and manpower, identify flood-prone hotspots, and designate responsible officers for each critical area. Attendance and deployment of pump operators and support staff are to be closely monitored, with special focus on preventing urban waterlogging. Dr. Misra further directed the Deputy Commissioners to oversee the Public Health Engineering Department (PHED) and Urban Local Bodies (ULB) to ensure the impeccable cleanliness of stormwater drainage systems in both urban and rural areas under their purview. Dr. Misra underscored Chief Minister, Sh. Nayab Singh Saini's clear directive: there will be absolute zero tolerance for any complacency or neglect of duty concerning this vital responsibility. It was informed during the meeting that Haryana has significantly ramped up drain desilting activities achieving around 78% clearance of the targeted 4,097.41 km drain network as of June 10, a notable rise from 19.20% recorded on May 27. Dr. Misra set a firm deadline of June 20, 2025, to achieve 100% drain clearance. The review noted that 672 out of 868 drains have been desilted for FY 2025, through a coordinated effort involving departmental machinery, MGNREGA workers, and e-tendering processes. The Land Reclamation and Development Corporation (LRDC) reported 82.51% completion, while Bhakra Water Services (BWS) has achieved 76.62%. The Irrigation & Water Resources Department showcased its preparedness, with a robust inventory of 553.22 km of HDPE pipelines and 2,401 pumps including diesel, electric, and VT mobile units ready for rapid deployment. Dr. Misra stressed the importance of addressing districtspecific bottlenecks promptly to ensure smooth execution. "Our foremost priority is the protection of communities and agricultural land from monsoon-related risks," she said, urging optimal resource utilization and timely project completion.

New frontlines of terrorism and the Pakistan equation

For decades, the Line of Control (LoC) in Jammu and Kashmir has served as the visible boundary between war and peace, infiltration and prevention, terror and counter-terror. It has also been the default focal point of Indian military strategy and Pakistan's proxy hybrid war, primarily kinetic. However, in 2025, the paradigm is shifting quite drastically. The LoC, while still active, and the kinetic domain in general, may no longer be the main front in the battle for Kashmir's stability. Instead, the new war fronts are dispersed, amorphous, and dangerously embedded within the digital, psychological, and ideological landscape. This is the classic grey zone strategy that has been long expected to manifest.

At the heart of this shift lies a question with major implications for India's internal security calculus: Does Pakistan still hold remote control over Kashmir's terrorism?Recent indicators suggest that Pakistan's ability to infiltrate terrorists across the LoC physically has been severely degraded. Better fencing, aggressive patrolling, a robust counterinfiltration posture, and enhanced surveillance capabilities—both aerial and electronic—have reduced large-scale infiltration to a trickle. The classical model of launching fidayeen squads, guiding them across the Pir Panjal, and sustaining them with local overground workers is not easily feasible in most sectors. Yet, this does not mean that the threat has receded. Instead, the theatre has simply moved.

The Pakistani deep state, ever adaptive, has invested in non-kinetic warfare to offset its reduced kinetic options, fully aware that shifting to a counter-no-kinetic mode is never easy for India. Drone drops of weapons and narcotics in Punjab and Jammu have now become regular events. Encrypted digital communication for recruiting and guiding local youth without the need for physical handlers is on the rise; intercepting this is proving a major challenge in the current cycle of technology infusion. Deepfake videos and AI-generated propaganda blend radical religious messaging with disinformation about the Indian state and its security forces through social media. This shift signifies a new logic: if territory is difficult to breach, minds become the next terrain of war.

One of the most notable post-2019 developments was the emergence of hybrid terrorists—local youth with no prior record, recruited via encrypted apps and trained online to act as lonewolf attackers. They don't cross the LoC. They don't train in Pakistani camps. They rarely operate in groups. Yet their actions serve the same end as those of their predecessors: psychological destabilisation and turbulence.

In many cases, the "handler" is virtual, sitting in a safe house in Pakistan-occupied Kashmir (PoK), Rawalpindi, or sometimes even third countries like the UAE or the UK. Intelligence intercepts suggest that while physical guidance has reduced, ideological remote control remains very much in Pakistan's hands. However, that control is not absolute. Several factors have diluted Islamabad's influence.

First, Pakistan's economic crisis and internal fragmentation have weakened the focus and capacity of its security establishment. The Tehrik-i-Taliban Pakistan (TTP) threat, rising sectarian violence, and civil military friction have forced the Pakistan Army to look inward. The events following Operation Sindoor-India's massive retaliation after the Pahalgam attack—acted as a sobering moment, exposing the limits of Pakistan's escalation.

Punjab must up the ante against drugs

The state should delve into socio-economic & health factors as it's not just a law-and-order problem

THE Punjab Government appears to be in battle mode against drugs and illicitly distilled alcohol. Illicit distillation's history is perhaps as old as the evolution of mankind. My first posting in the field was as the SP of Kapurthala, which at the time was a small district having just six police stations. One of the law-and-order problems of that time was illicit distillation along the riverine area. Working stills operated in the thick undergrowth with impunity. On the basis of intelligence inputs, we conducted extensive joint raids across the area, arrested a large number of distillers and impounded vats

with large amounts of lahan and liquor. A functional small group or groups can be set up to study the drug problem and offer solutions. Fifty years later, I still read about the Yudh going on, although more manpower and technology are available. The same operations were carried out against opium and poppy husk, gambling, prostitution, etcetera. The scale of the problem, however, was minuscule at the time compared to today.Drugs, especially of the chemical kind, have entered the fray and big cartels are operating in the state as well as in border areas across the country (especially along the western coast where humongous seizures have been made), but no details are available regarding the origin and destination of these drugs.I am confounded by the attitude of successive governments in dealing with social vices. No country has been able to eradicate human vices, for they are as old as civilisation; however, they have

strived for a better balance. America experimented with prohibition a century ago, only to land itself with crime bosses and a rampant mafia. Eventually, most countries have tried to reduce the criminalisation of society and the presence of rampant addiction through custom-made solutions for their societies. Some have pushed lowalcohol beverages, some have legalised marijuana and similar mild recreational intoxicants. They have been tough on hard drugs and supply to children. Continuous awareness campaigns are conducted to drive home the impact of alcohol and drugs on the body and mind.Coming back to my home state of Punjab, the troubles in the lost decades of the 1980s and 1990s took a massive toll on the socio-economic fabric. Terrorism and the proxy war unleashed by Pakistan wreaked havoc on the state. The ISI provided an unending stream of arms, ammunition and training. Tactics perfected in Afghanistan with the Mujahideen against the Soviet Union were used, as were the munitions. The AK-47 became a dreaded weapon (most had Afghan-origin markings) and a force multiplier for the terrorists. Industries shut down or migrated; families were broken by killings; extortion became an ever-present dread. Thousands were killed — civilians as well as police and paramilitary personnel. No major effort was made to address these large-scale physical, psychological and economic traumas. A whole state was virtually destroyed



on all parameters of life and not a single commission was ordered to enquire into the causes and effects of this upheaval and to suggest remedies. The people were left to deal with it on their own — quite a few migrated, some took to crime and formed gangs, others took to smuggling and distribution of drugs. The politicians came back to power after a hiatus, and this led only to further criminalisation of society...why? An enquiry panel headed by eminent jurists, sociologists and administrators could have been set up for this purpose. A separate commission should have been formed to look into the losses incurred by the state, its institutions, its people and a proper rehabilitation plan mapped out, as also a financial and employment package.

What happened in Punjab for two decades was an undeclared war supported by Pakistan. Was it treated as such? Only for the first part of crushing terrorism was full support provided. For the second part of dealing with the aftermath, Punjab was left to the mercy of the forces of nature. I would like to mention that it was the Punjab Police, along with the Punjabi civil society, that was at the vanguard of this battle, and which bore the brunt of it.

For a region to be economically prosperous, one of the essentials is the ability to trade. Punjab is landlocked. Historically, the region did trade with Central Asia, Afghanistan and beyond through the Silk Road, with the Khyber Pass being a major route. The coming of the

British and the subsequent Partition put paid to this route. Today also, that option is no longer available. In fact, it has been closed for quite a few decades after a few feeble attempts to open it. With the withdrawal of the freight equalisation scheme, the ports of southern and western India are no longer viable for most products. As a result, the factories of Mandi Gobindgarh, Khanna, Ludhiana, etc. are a pale reflection of their former glory. We do not have air connectivity worth mentioning, even though this state accounts for one of the biggest diasporas. So, where and how do we trade... where is the government in the state and at the Centre involved in facilitating

Coming back to the Yudh on moonshine and drugs, the problem here has been tackled mainly as a law-and-order problem and the

appointed agency to tackle it is the police. As far as I know, no listed study has been carried out at the state level to go into the roots of the problem — factors involving social and economic forces and mental health issues. The role of national and international cartels, the role of various state agencies and the compromised nature of our criminal justice system. We should have involved top-level sociologists, psychiatrists, social workers and agencies dealing with narcotics. We should also involve specific units of our intelligence agencies, both internal and external, to find out the origins of this trade, its tentacles across the country and the nexus between politicians, police and drug cartels. This is a wide-ranging suggestion, but if the government should so desire, a functional small group or groups could be set up to study the problem and

Rights of all consenting adults are not up for debate: Madras HC

When does an adult become an adult, free to make their own decisions and choose their own love, life, and future? India allows its youth to decide its political future from the age of 18, and yet family, society and the state too often infantilise and deny the same adults their rights and their agency.A recent case in point is a Madras High Court ruling on a habeas corpus petition. The female petitioner was the partner of a young woman in her 20s who was allegedly illegally confined by her parents. Complaints to the police about her fate had gone in vain. Finally, at court, the woman's mother told the judges that the petitioner had led her daughter astray. The court, noting that every parent cannot be like the late Justice Leila Seth, who openly accepted and advocated for her gay son (celebrated writer Vikram Seth), allowed the woman to go with the petitioner just as she had preferred. In handling the case, the court relied on

Supreme Court guidelines from only last year in dealing with habeas petitions and pleas for police protection.



Those guidelines also came from a similar case; only there, the Kerala High Court, instead of going by the preference of the woman detained by her parents, sent her for counselling.It is not only in cases of LGBTQIA+

couples that matters have devolved into parental confinement and adults have had to turn to the courts for respite. The famous Hadiya case is one example of how the agency and rights of young people, especially women, are denied at the altar of parental preferences and societal compulsions. The Madras High Court rightly pointed out that couples, cisgender heterosexual or otherwise, have the right to form their own families even outside the scope of traditional marriages. Yet, in India, gender, sexuality, caste and religion are grounds on which families and societies keep consenting adults apart, often violently and fatally. Worse, however, is the willingness of police and even the judiciary to back these antiquated notions and support errant parents rather than upholding the rights of consenting

adults as guaranteed by the Constitution. Until that changes, judgments can set free individuals to live and love fully, only one at a time.

Business can bring India and China closer

India and China have had close people-to-people relations for centuries. Chanakya and Sun Tzu were approximate contemporaries, a hundred years apart. India has historically excelled in relationship-building with other nations through travel, trade, and thought. The three Ts were strong glues. The Tea Horse Road carried a flourishing trade. The spread of Buddhism had a mercantile streak, as highlighted by Devdutt Pattanaik in his recent column for The New Indian Express. Another relevant article on a syncretic vision to heal our divided world was published by this newspaper earlier this month. When a truncated India encountered a unified China in the 1950s, the frontier politics of British India opened differences. Differences have been around for eight decades, even as soft power has influenced both sides for centuries. In future, there is potential for benefit if Chanakya and Sun Tzu can collaborate through business. For two large China is only through business. Trade, travel, and

thoughts bring people together. A young Jamsetji Tata, the founder of Tata, went for training in Shanghai around 1860. neighbours, that is worthwhile.My experience of China claims that Tibet has been part of it since the fall of the Qing dynasty around 1911. Therefore, in 1950, China took over Tibet. The role of India in extricating the Dalai Lama from Tibet caused tension with China. In 1962, China and India fought a Himalayan war. Since then, there have been skirmishes and periodic tensions leading up to the clashes in 2021 in the Galwan Valley. For six decades now, India and China have viewed each other with suspicion. In 2007, Professor Tarun Khanna of Harvard Business School felt that the opening of the Nathu La pass in Tibet reactivated the world's highest customs point for trade between India and China. Both nations now appear to desire

longer-term ties, although the terms have yet to be developed. Their foreign ministers met in Kazan, Russia, in 2024. The meeting was reported as "a tactical thaw rather than a strategic shift away from Sino-Indian rivalry" by Tanvi Madan of the **Brookings Institution**

Over the past thirty years, despite border tensions, trade between India and China has grown from \$0.25 billion in the 1990s to over \$120 billion in 2024, albeit in an unbalanced manner. Between 1920 and 1940, China published twenty-seven books based on Gandhi and Gandhism. When the Government of Zanzibar and East Africa enacted the Asian Ordinance in 1906, 1,100 Chinese stood beside 8,000 Indians to protest it. At the centenary celebrations at Visva Bharati University, Tagore's 1924 statement from his China visit was recalled by Ma Jia, chargé d'affaires of the Chinese embassy. "India has been one of China's closest relatives, and China and India have enjoyed a time-honoured and affectionate brotherhood," Tagore had said.

Apart from people-to-people contact, there are geographical and geopolitical factors. It is a circle around the South China Sea, encompassing China, India and some Southeast Asian nations. Ken Myers of Texas first drew this circle two decades ago, and his nom de plume, Valeriepieris, became associated with the idea. Professor Danny Quah, Dean of the Lee Kuan Yew School of Public Policy and Professor Riaz Shah of Hult International Business School refined it.As per the UN World Population Prospects, an estimated 4.2 billion people live within the circle, compared to 3.8

billion outside. However, the land area accounts for only 15 percent of the planet's total area. Imagine the density. Tightly packed people of China and India must either adjust to live peacefully or fight to extinction. The choice is obvious. Both nations are culturally strong and are aware of their cultural heritage. Both are economically marching towards regaining their past strength, albeit at different stages and with varying outcomes. China has been quiet but strong in discipline and pragmatism. India has been both noisy and strong in creativity and ideas.Like China, India must also invest heavily in R&D to bring this opportunity to life. Consider that since 2000, China's investment in research has increased by 18 times, reaching over \$750 billion. No wonder China has become highly competent in new technologies and research. Chinese technology joint ventures in India, spanning electronics, automobiles, pharmaceuticals, financial services, and artificial intelligence, are promising. This can work only if China too wants it, and policies must change in this regard. China developed rapidly by combining Western technology with Chinese manufacturing. India could combine Chinese technology with Indian manufacturing, initially producing for India but later for export. There is a role for business leaders and government through promoting travel, thoughts, and trade. Studies by university students, tourism initiatives, joint ventures, and other endeavours, rather than just short term trades, all contribute to this effort. They are proven instruments in geopolitics. Circumstances make allies of nations.

It's not just swimming pools or beaches where you must be cautious. Even bathtubs at home, ditches and drum filled with water can

be hazardous. Keep the cans covered and empty water if you are not using them. They are a breeding ground for mosquitoes and flies.

Ensure an adult is always around

Children shouldn't be allowed near water bodies without supervision. "There's a reason why

beaches and swimming pools where adults practise are equipped with lifeguards — to help in case of emergency. So, make sure that either you or an adult — your spouse, family members or your kid's friends' parents — is always present at an arm's length away from the child," says physical education trainer Mathew Moses. He adds, "In swimming jargon, this is called touch supervision." Have family and friends on standby, and tell them how to react in case of an emergency. Write out all the important phone numbers as well. And when you are watching the kids, do only that. Don't get distracted by the smartphone

Learn first aid

Knowing life-saving techniques like CPR is always important. Life coach Shekhar Kekan says, "When you see someone is drowning or choking in the water, follow the four-step rule - reach to them using towel, rod or by lying down flat near the water body, throw a safety

ring around them, swim to reach them or get a rescue boat if need be. Once you get them out of danger, pump their stomach to get the excess water out of their body. Knowing how to react in case someone has a heart attack or is choking is also important. However, remember that the first instinct of anyone who is drowning is to catch hold of whatever or whoever is near them."

Radhika Kanwalkar, a housewife and mother of a two-year-old son, says, "Before we took him to the beach, we had ingrained in his mind the following rules — don't run near water, don't push others into the water, and never go out of our sight. When you are strict with rules, there is little chance of accidents."

Use life jackets

Life-saving jackets are not replaceable with inflatable toys. Yes, they provide support for your child to stay afloat, but they stand the risk of getting deflated. Moses says, "If you are going to the pool, ask the authorities for life jackets. I would suggest, invest in one, because most beaches in our country don't

have such facilities. If your little one is using floaties or inflatable toys, he/she can easily slip off them. Life jackets in the right size will not come off once they wear it. Also, remove all the toys from the pool when not needed, because they can tempt kids to jump into the pool."

Familiarise kids with the surroundings

When you take children to the beach, for a boat ride or to the pool, show them around first and make them familiar with the new surroundings. 

New Delhi. The Maharashtra government on Tuesday issued orders to begin the long-pending election process for 29 municipal corporations, including the Brihanmumbai Municipal Corporation (BMC), by initiating the drafting of

corporations included in this process are Pune, Nagpur, Thane, Nashik, Pimpri-Chinchwad, Navi Mumbai, Vasai-Virar, Chhatrapati Sambhajinagar, and Kalyan-Dombivli. The Urban Development (UD) department directed Municipal Commissioners to start preparing ward boundary drafts, which will be sent to the State Election Commission (SEC) for approval. The municipal bodies will also need to invite suggestions and objections from citizens and provide hearings before finalising the boundaries.

The order emphasised that ward boundaries must be drawn strictly as per the latest census data. "The number of voters or the current number of residents in that area cannot be taken boundaries," the order clarified.

The move comes after a Supreme Court directive last month, where a bench of Justices Surya Kant and NK Singh instructed the Maharashtra state election body to notify elections to all pending

On Tuesday, the national capital recorded its hottest day of the year so far, with the maximum temperature at Safdarjung touching 43.8°C — four degrees above the seasonal average.

The "heat index" — or the temperature felt by the human body — reached a searing 47.7°C in the city due to low humidity levels, intensified by hot, dry westerly winds. The IMD has warned that similar conditions are expected to persist on Wednesday, with maximum temperatures hovering between 44°C and 46°C. Gusty winds, potentially reaching speeds of 40 km/h, may further increase discomfort levels.

Relief likely on Friday

According to IMD data, this is the fifth heatwave day for the capital this season. Tuesday's temperature surpassed Monday's 43.4°C, making it the hottest day of the year so far.

The weather department has forecast relief from the intense heat starting June 13, when moistureladen winds from the Arabian Sea and Bay of Bengal are expected to converge over northwestern plains, potentially triggering thunderstorms and rainfall. Some regions in eastern Uttar Pradesh and Uttarakhand may see marginal relief a day earlier, beginning June

New Delhi.Chief Justice of India (CJI) BR Gavai has cautioned against excessive judicial overreach, saying that "judicial activism must not become judicial terrorism". He was speaking at the Oxford Union during an address titled "From Representation to Realisation: Embodying the Constitution's Promise".

CJI Gavai described the Indian Constitution as a "quiet revolution etched in ink" and a transformative tool aimed at ensuring justice, equality, and upliftment of the historically marginalised. While acknowledging the judiciary's role in protecting constitutional values, he emphasised the need for restraint.

'Courts must not become unelected policy-makers' "Judicial activism has played a key role in expanding rights and ensuring accountability. But courts must not cross the line into becoming unelected policymakers," he said. "Judicial terrorism occurs when activism turns into overreach, undermining the balance of power."The comments come amid ongoing debates over judicial interventions in matters typically handled by the legislature or executive. In recent years, courts have been both praised and criticised for ruling on issues ranging from

electoral reforms. 'Judiciary's constitutional mandate is to interpret

environmental regulations to religious practices and

Responding to a question from legal news portal Bar and Bench, CJI Gavai reiterated that the judiciary's constitutional mandate is to interpret the law, not to assume legislative or executive functions. "Our democracy depends on institutional boundaries. Overstepping them weakens the very structure we aim to protect," he said.



A baby who bangs his head against the cradle or the wall is naturally a cause of concern. However, a lot of toddlers do this seemingly without harming themselves or feeling pain, because they like the rhythm of going back and forth.

WHAT TO DO: If the head banging continues far too long, check with the doctor.

ARCHINGHER BACK

Newborns arch their back in reaction to pain or heart burn. It could be a direct sign of an acid reflux -a condition in which the backward flow of acid from the stomach irritates the foodpipe. Your baby will arch her back to try to relieve the discomfort.

WHAT TO DO: If your baby is sleeping well, there is no need to panic. However, if the case is severe and both of you are spending sleepless nights, then take her to a paediatrician who may be able to provide medication to reduce the acids caused in her stomach.

HANDS ON EYES

If your baby places his hands on the eyes, it could mean that he wants to play a game of peek-aboo. Their worlds revolve around t their line of vision right now.Babies love to obstruct their vision and then see if the person in front of them is still around.

WHAT TO DO: Join your baby in the game. Take a thin blanket and start the game of peek-a-boo. Hide in the blanket and surprise your baby with the trick.

RUBBING EYES OR EARS

Toddlers rub their eyes and ears with their hands when they tire. Before they turn six months old, they rub their faces against something if they are tired. After that, they could discover the ear by accident and take comfort in rubbing it since ears are sensitive.

WHAT TO DO: Start your bedtime routine as soon as your baby begins rubbing his ears and eyes. If your baby is rubbing his ears and is also running a temperature of over 101 degrees, he may have an ear infection. Consult your paediatrician in such cases.

ROOTING

Does your baby automatically turn the face toward your finger and make sucking motions with the mouth when you touch his cheek or lip? This is called the rooting reflex and is a survival tactic to help the baby find food. The reflex disappears after the first few weeks.

India now home to over 85,000 millionaires, ranks 4th globally: Report

New Delhi. India has emerged as the fourth-largest hub of high-net-worth individuals (HNWIs) globally, with 85,698 people now having a net worth of over US\$10 million, according to the Knight Frank Global Wealth Report 2025. India now trails only the United States, China, and Japan in terms of the number of wealthy individuals, accounting for 3.7% of the global HNWI population. The report highlights India's strong economic growth, rise in entrepreneurial activity, and increasing access to capital as the key reasons behind the growing concentration of personal wealth. Knight Frank report highlights that India's digital infrastructure, especially the spread of smartphones and digital banking, has made wealth creation more accessible than in earlier decades. The report also points to a sharp increase in India's billionaire population, which rose by 12% over the past year. India now has 191 billionaires, up from 165 in 2023. That includes 26 new billionaires added in a single year, a pace far quicker than the seven added in 2019. Indian billionaires now collectively hold around US\$0.95 trillion, ahead of France, Germany, and the UK, though still behind the United States and China. Wealthy individuals in India, like their global counterparts, continue to place a high value on real estate. Nearly 30% of billionaire wealth globally is held in real estate, and this trend is particularly strong in India, where property is seen as a symbol of status and stability. Indian HNWIs are also increasingly looking to invest in overseas markets such as Dubai, London, and Singapore. According to the report, India's population of high-net-worth individuals is projected to grow by 43% by 2028, reaching an estimated 122,119 individuals. This projected growth is one of the fastest among all major economies.

The report also notes a rising appetite among Indian investors for equities and risk-based assets, setting

Tariff cuts, easing digital barriers: India, US make headway in trade talks

New Delhi. India and the US made progress this week in their latest round of closed-door negotiations in New Delhi on a long-anticipated bilateral trade agreement, officials said. The talks, held from June 4–10, focused on increasing market access for industrial and select agricultural goods, reducing tariffs, and easing non-tariff barriers. Both sides are aiming to finalise the first tranche of a comprehensive Bilateral Trade Agreement (BTA) by September-October this year.

The US delegation, led by the Additional US Trade Representative, held in-depth meetings with Indian trade officials led by chief negotiator Rajesh Agrawal."The negotiations held with the US side were productive and helped in making progress towards crafting a mutually beneficial and balanced agreement, including through achievement of early wins," a government official told news agency PTI.

The talks also explored issues such as sanitary and phytosanitary measures (SPS), technical barriers to trade (TBT), digital trade, customs facilitation, and legal frameworks. Digital trade was a point of particular interest for the US, whose service providers flagged concerns about restrictions on cross-border data flows and competition regulations in India. Officials indicated an interim pact is on the horizon. India is pressing for complete exemption from a punishing 26% reciprocal tariff on domestic goods. After the US suspended the proposed levies until July 9, the Indian side is racing to achieve a limited deal before that deadline.US President Donald Trump and Prime Minister Narendra Modi had previously committed to concluding the BTA by fall 2025 and doubling bilateral trade to \$500 billion

Reliance Industries Target Price hiked: Key brokerages predict 13-14% upside

New Delhi. The stock of Reliance Industries is in the news as three major brokerage firms are being bullish on its stock. Paramount to cut 3.5% of US jobs as cable TV declines: Report

New Delhi. I Paramount Global has announced that it will lay off 3.5% of its staff in the United States. The news was shared with employees through an internal memo on Tuesday, reported Reuters. The job cuts are part of the company's efforts to deal with falling cable TV viewership, as more people switch to streaming services like Netflix.

This is not the first round of job losses at Paramount. Back in August last year, the company had already cut 15% of its workforce, indicating ongoing adjustments in response to market changes. Paramount's Co-CEOs, George Cheeks, Chris McCarthy, and Brian Robbins noted in the memo that the company is beginning the process of further simplifying its structure this week, calling it a tough but essential decision. The latest layoffs are part of a broader trend as cable TV faces a "generational disruption." As the company seeks to navigate these challenges, the memo suggested



potential future impacts on international staff. Paramount's workforce counted 18,600 employees at the end of 2024. The latest move comes while the company is also trying to go ahead with a major \$8.4 billion merger with Skydance Media, led by billionaire David Ellison. Make in India' gave us breakthrough in defence, says Bharat Forge's Baba Kalyani

"A lot of army guys walked by, some laughed at it," Chairman Baba Kalyani said during an episode of the New India Junction podcast "Not a single guy stopped to even see what the hell it was."

New Delhi. After years of indifference from policymakers and the military establishment, Bharat Forge is now among the companies that are at the forefront of India's defence manufacturing push, thanks to a crisisdriven pivot and a policy overhaul led by the Narendra Modi-led government. In 2012, at a defence exhibition in Delhi, a few paused to look at the artillery gun on display by Bharat Forge."A lot of army guys walked by, some laughed at it,' Chairman Baba Kalyani said during an episode of the New India Junction podcast "Not a single guy stopped to even see what the hell it was."The lack of interest

wasn't about the product. It was about disbelief, according to Kalyani, but that an Indian private company, not a foreign giant or public sector unit, could build something as complex as an artillery gun. The military brass was still sold on imports. "Everybody believed in global suppliers," said Joint MD Amit Kalyani. Today, over a decade later, the same homegrown gun is a symbol of India's Make in India ambitions. But Bharat Forge's entry into defence manufacturing wasn't born out of strategy alone, it was shaped by frustration, missed opportunities, and a global financial crisis that forced a rethink. The seeds were sown in the aftermath of the 2008 financial crash. "This idea of defence came into my mind somewhere around 2011," said Kalyani.Drawing on his military school background and deep friendships within the armed forces, he realised that artillery guns were essentially complex forging systems, something Bharat Forge already excelled at."Look at artillery, it's full of forging. It's metallurgy. So I thought, why don't we use our metallurgical and forging knowledge to make guns?"But back then, defence production was a state monopoly.



Kalyani recalled how in the 1980s, India imported 400 artillery guns from Swedish firm Bofors, along with a full technology transfer package. "Sweden literally gave the total artillery technology package on a platter," he said. "But the private sector was locked out."In 2011, Kalyani took his pitch to then Prime Minister Manmohan Singh. He was directed to Defence Minister AK Antony. "He listened to me for 15-20 minutes and said thank you very much. I walked out. I got no response," Kalyani recalled.Amit Kalyani shared how his father had carried a file dating back to 1976—documenting Bharat Forge's early efforts to enter the sector. Four decades later, the same equipment was still being imported. The 2012 gun

display only reinforced how deep the skepticism ran. "We showcased this gun in 2012, and I can tell you, the kind of skepticism that came out, it was as if we didn't exist," said Kalyani. "We were offering guns at half the price of imports. Price was not the problem."It wasn't until the Modi government's Make in India campaign began in December 2014 that the tide turned. Kalyani participated in a defence conclave at Vigyan Bhavan that year, helping draft policy inputs alongside senior officials. That's where the real revolution started,' he said. The beakthrough came under Manohar Parrikar, who as Defence Minister rewrote the Defence Procurement Procedure (DPP 2016). "He understood both the policy and implementation challenges. He formed committees to fix the entire system," Kalyani said. "If Parrikar were alive today, he would have taken India's defence industry even further."Kalyani believes India's reluctance to involve private players is the key reason countries like China and South Korea pulled ahead in the 1990s. "We focused everything in the public sector.


