Aviation department initiated probe, official death toll only after DNA test: Amit Shah on Air India plane crash

The Ahmedabad-London Air India flight with 242 people onboard, crashed within seconds of taking off from Ahmedabad's Sardar Vallabhbhai Patel Airport.

New Delhi. Union Home Minister Amit Shah has said that the temperature in the ill-fated Air India plane that crashed in Ahmedabad on Thursday was so high due to burning fuel that there was no chance to rescue people. Shah also said the the Ministry of Civil Aviation has initiated a probe into the tragic incident that claimed 241 lives. The Ahmedabad-London Air India flight with 242 people onboard, crashed within seconds of taking off from Ahmedabad's Sardar Vallabhbhai Patel Airport on Thursday

The plane brushed past one of the buildings in Byramjee Jeejeebhoy Medical College(BJMC)compound before crashing and bursting into flames. Of the 242 people onboard, only one survived, Air India said in a statement. While Air India has confirmed that 241 people were killed in the deadly crash, Shah said that. The plane crash occurred on Thursday afternoon, just minutes after it took off from Sardar Vallabhbhai Patel International Airport. 169 Indian nationals, 53 British nationals, 1 Canadian national and 7 Portuguese nationals were killed in the crash.

Air India Crash: For Vijay Rupani, 1206 Was A Lucky Number — Until His Final Flight

New Delhi. For years, 1206 was more than just a number to Vijay Rupani. It was the former Gujarat chief minister's talisman, a symbol of fortune that had guided him through the pivotal moments of his life-from his rise in Gujarat politics to personal milestones. However, on June 12, that very number-which had once brought him success and fortune-would come to mark his untimely end.

On Thursday, when Rupani boarded Air India AI171, bound for London, a routine flight that would take him to his family quickly turned into a nightmare. The plane crashed shortly after takeoff from Ahmedabad, taking the lives of 241 people on board and leaving just one miracle survivor. Among them was the former chief minister, whose relationship with 1206 seemed almost prophetic in its tragic irony.

For decades, 1206 had appeared in some of the most significant moments of Rupani's career, from his entry into politics to his tenure as chief minister. It



had been the number on his election forms, the number of his personal cars, and even the one he used to sign personal documents. Rupani had often spoken of it with reverence, describing it as his "lucky charm," the key to his success. His supporters, too, came to see it as a good omen-something that would continue to steer him toward a bright future. However, now, the number that once signified prosperity will forever symbolise an unfathomable loss.

Confirming Rupani's death, Gujarat BJP state president CR Patil called it a "great loss" for the party. "Our leader, former Chief Minister Vijay Rupani, was also on that flight. Vijay Rupani died in this tragedy. May God grant peace to his soul. This is a great loss for the BJP family as well,"

The ill-fated Air India flight struggled to gain altitude and slammed into a hostel for doctors of a medical college, immediately killing five students. What seems to have compounded the impact was the fact that the airliner was loaded with aviation fuel since it was set to fly all the way

to London. It was also revealed that shortly after takeoff, the pilot sent out a "Mayday" call, but when Air Traffic Control tried to make repeated attempts to get in touch with the flight, there was no response.

In Jharkhand, trouble mounts for Sita Soren as ex-PA files abduction case

Patna. A Dhanbad court has admitted a criminal complaint filed by Jharkhand BJP leader Sita Soren's ex-aide Devashish Manoranjan Ghosh, who has accused her of abducting, assaulting, looting, and framing him in an Arms Act case earlier this year. Ghosh, who was a former PA to Soren, alleged that on March 6 he was taken to Dhanbad at Sita's behest under the pretext of attending a wedding. He alleged he was "diverted from Wedlock Hotel to Sonotel Hotel in Dhanbad, where the conspiracy unfolded".

On the evening of March 6 while I was taking rest in the hotel (Sonotel Hotel), I was asked to come out of the hotel, where nearly 15 people assaulted me, looted money from my ATM and UPI apps, and planted weapons including a pistol (desi katta) near me," Ghosh alleged. "They filed an FIR against me the same night at Saraidhela police station under the Arms Act and I was arrested soon afterwards. I spent 31 days in jail," he said.

Ghosh claimed that "the real reason behind Sita Soren's fallout with me was political". He said Sita had accused him of "aligning" with Congress leader Irfan Ansari in the Jamtara seat during the November 2024 Jharkhand polls in an alleged attempt to "sabotage" her campaign. After his release on bail, Ghosh said he refrained from approaching the police and has now chosen to directly move a Dhanbad court with his complaint against Sita.

Tragedy Above Ahmedabad: Air India Flight A1171 Crash Claims Hundreds

On 12 June 2025, Air India Flight AI171, a Boeing 787-8 Dreamliner (VT-ANB), bound for London Gatwick, crashed mere seconds after takeoff from Ahmedabad's Sardar Vallabhbhai Patel International Airport

Initial investigations suggest technical failure, eyewitnesses reported the landing gear was irregular for climb-out-combined with engine "thrust loss"

Kerala nurse's dream to settle at home meets tragic end in Ahmedabad crash

PATHANAMTHITTA. A pall of grief descended on Pullad in Pathanamtitta on Thursday as news broke that Ranjitha Gopakumaran Nair was among the victims of the Air India flight crash in Ahmedabad on Thursday.Ranjitha,39, a nurse, was returning to the UK, where she worked, after a brief visit to her home.

The tragedy has left her two children -Induchoodan, and Idhika - and elderly mother, Thulasi, devastated. As news about her death was confirmed by the district administration around 4.30pm, a large number of people gathered at her ancestral home in Vadakkekavala.

Ranjitha, who had worked as a nurse in Salalah, Oman, and later in the UK, was on the cusp of fulfilling her life's aspirations. She had been working in the UK for the past eight months and returned to India recently to complete the formalities for renewing the government job she had in Kerala.

She had secured a job at the Pathanamthitta General Hospital five years ago and was on long leave during which she worked abroad. She had been constructing a new house at Pullad and was planning to move into it along with her children soon. "Ranjitha's visit home was brief. After completing the paperwork for her government job, she was returning to the UK when the tragedy struck," said Aneesh Varikkannamala, KPCC secretary and close associate of the family.Ranjitha left home on Wednesday afternoon. She travelled to Ernakulam from Tiruvalla on a train and flew from Nedumbassery to Chennai and then to Ahmedabad, from where she boarded the illfated flight to London.

Telangana HC bars demolition of heritage structures for Metro works in Old City

HYDERABAD. The Telangana High Court on Thursday barred the state government and Hyderabad Airport Metro Ltd from demolishing or altering any archaeological or heritage structures along the proposed Metro Rail Corridor-6 from MGBS to Chandrayangutta, until a comprehensive report is filed. The directive came from a division bench, comprising Acting Chief Justice Sujoy Paul and Justice Renuka Yara, while hearing a petition filed by the Act Public Welfare Foundation, represented by Rahim Khan. The petitioner alleged that several heritage sites in the Old City were being targeted for demolition as part of the Metro project.

In April, the Additional Advocate General (AAG), Imran Khan, had assured the court that no declared heritage structures would be touched, and sought time to submit a report based on heritage conservation committee notifications.On Thursday, the AAG sought more time again. Opposing the plea, petitioner's counsel, MA Basith, accused authorities of deliberately stalling and misleading the court. He also submitted K11 replies questioning whether statutory clearances were obtained for the project. Taking serious note of the delay, the court gave the government three weeks to file the report and barred any demolition or alteration of heritage structures in the

VIMSAR, OUHS warned by UGC for flouting anti-ragging norms

BHUBANESWAR. The University Grants Commission (UGC) has warned two state government-run institutions of regulatory action for failing to submit the mandatory anti-ragging compliance reports and undertakings from students not to indulge in ragging, for the year 2024. The two institutions are Veer Surendra Sai Institute of Medical Sciences and Research (VIMSAR) at Burla and Odisha University of Health Sciences (OUHS) in Bhubaneswar. The UGC on Thursday asked 89 universities and institutions across the country including the two in Odisha to submit the anti-ragging compliance and get online undertakings from all students directly under them or in their affiliated institutions, within 30 days.

Under the National Ragging Prevention Programme of the Ministry of Education, it is mandatory for all colleges, standalone higher education institutions and universities - both public and private - to submit anti-ragging undertaking by students through UGC's anti-ragging website and file undertakings of compliance with UGC's anti-ragging regulations, 2009.

In a letter to the institutions, UGC secretary Manish R Joshi pointed out that despite multiple advisories, follow-up calls from the anti-ragging helpline and direct interventions by its anti-ragging monitoring agency, the institutions have failed to submit the documents which is a violation of the

He directed the defaulters to ensure that all enrolled students complete their online antiragging affidavits and submit their compliance reports within 30 days, along with a comprehensive account of the preventive measures taken to stop ragging on campuses. Failure to comply would lead to listing of the institutions as noncompliant on the UGC website and consideration for de-recognition or withdrawal of affiliation, Joshi warned.

An episode of trust and betrayal: Father — daughter duo Krishnakumar-Diya exposes the 'QR-code' mafia

Thiruvananthapuram. In a case that has stirred public emotion and political discourse alike, the Kerala police is under fire for allegedly filing a false and politically motivated FIR against actor-politician and BJP leader Krishnakumar, his pregnant daughter Diya Krishna, and four others. Krishnakumar alleged that the FIR containing non-bailable sections, was filed without proper inquiry, following a counter-petition by three employees accused of massive financial fraud.Krishnakumar, a public figure, an actor, politician has alleged that the entire FIR was a deliberate move to intimidate and silence him due to his political leanings. What is the case all about?

In the first week of June, there was two cases that was filed in the Museum police station - one by Krishna Kumar and her daughter Diya Krishnan for defrauding Rs 69 lakhs and the other by three employees of their firm for allegedly abduction, extortion and later insulting them



using caste slurs. What Diya said:

Diya and her father claimed the scam was uncovered when a friend tried to pay at the store and the money failed to reach the business account. According to Diya, the employees convinced customers that the shop's QR code was "corrupted" and directed payments to their personal accounts.

Diya says she has submitted CCTV footage and a video where one of the employees confesses to splitting the money. The family also claimed the employees returned around Rs9 lakh, with over Rs60 lakh still unaccounted for. Diva out-rightly denies the abduction charge, saying the employees voluntarily travelled with her and

her family from her flat to her father's office. What the employees say:

The accused employees told the media they had worked at the boutique for a year and regularly handed over money received from customers to Diya in cash. Since these were off-the-record transactions, they claim to have no proof. They allege that on May 29, they were forcibly taken to Krishnakumar's office and insulted based on their caste. The next day, they resigned.

The couple had earlier chosen not to pursue police action when Diva discovered that three employees - Radhakumari, Divya R., and Vineetha Julius - had siphoned off money from the firm using unauthorized QR codes. However, when they were threatened late at night by the accused individual's husbands, Diya and Krishnakumar brought the matter before the police. However the father-daughter duo alleged that they faced intimidation from various quarters instead of support.As per Krishna Kumar what followed was shocking: Museum Circle Inspector Mr. Vimal registered a non-bailable FIR against the victims themselves, ignoring clear evidence of the crime. How I survived: Vishwas Kumar, on seat 11A, recounts miracle escape from crash

Vishwash Kumar Ramesh was in seat 11A of the doomed Air India flight. After the plane crashed and exploded, he was the only person pulled out alive from the wreckage.

Mumbai. The sole survivor of the Air India Flight AI171 crash in Ahmedabad, which left 265 people dead, has revealed how he miraculously escaped the inferno that followed the disaster. Vishwash Kumar Ramesh, a British national, was seated in 11A, next to the emergency door on the left side of the aircraft. He said the plane broke apart shortly after take-off, and his seat was flung clear of the wreckage. As a result, he was shielded from the flames that engulfed the rest of the aircraft."The plane broke, and

my seat came off," he told doctors treating him at Ahmedabad Civil Hospital. "That is how I was saved."Ramesh told doctors that he did not jump from the plane but was thrown out while still strapped to his seat when the aircraft disintegrated."The place where I landed was low ... I took off the seat belt and for a moment, I was scared for my life. But I was near ground level, so I tried to get out," he told DD



News.Seeing the doors of the aircraft were broken, Ramesh said he was able to walk out on foot, even as he saw passengers and crew dying around him."I can't believe how I survived,' Ramesh said. "I thought I would die. People died in front of my eyes."A now viral video shows a bruised and bloodied Ramesh limping towards an ambulance as bystanders assail him with questions about the fate of the rest of the people on the flight. At present, he is under

The Boeing 787-8 Dreamliner, bound for London's Gatwick airport, crashed into a medical college hostel shortly after take-off from Ahmedabad's Sardar Vallabhbhai Patel International Airport on Thursday. The aircraft was carrying 230 passengers and 12 crew members. The 11-year-old aircraft could be seen from miles away, losing altitude rapidly and combusting in a fiery blaze that sent plumes of thick black smoke spiralling up in the air. The aircraft climbed just about 600-800 feet before plummeting to the ground almost immediately.Images of the aftermath showed parts of the plane embedded into BJ Medical College, with pieces of its landing gear, fuselage and tail protruding from the building. The pilot of the twin-engine widebodied aircraft issued a 'Mayday' distress call, denoting a full emergency, soon after takeoff at 1.39 pm, the Air Traffic Control.

Kerala nurse's dream of new home, life back in India ends with Gujarat air crash

Kerala. A 39-year-old nurse, Ranjitha Gopakumar, from Thiruvalla in Kerala's Pathanamthitta district, was among Dehradun. As monsoon sets to the 241 passengers and crew killed in a catastrophic plane crash in Ahmedabad on Thursday.Ranjitha, a mother of two, was working as a nurse in the United Kingdom and had returned to India just four days earlier. According to sources close to her, she had hoped to complete formalities related

'Land grab' by shrimp farms threatens Pulicat sanctuary

The study area, Thangalperumbulam in Ponneri Taluk of Tiruvallur, is inhabited largely by Scheduled Caste communities.

CHENNAI. A grassroots movement committed to protecting wetlands in Chennai has flagged large-scale violations and alleged land grab by aquaculture farms in the eco-sensitive zone (ESZ) of the Pulicat bird sanctuary in Tiruvallur district.

A report titled "Aquaculture Land Grab" released by the 'Save Ennore Creek Campaign' on Thursday claimed 309 acres, equivalent to 34 cricket stadiums, have been occupied by aquaculture farms, of which 62 acres are poramboke common lands classified as grazing grounds (Meikal poramboke) and floodplains (Kazhuveli poramboke). The study area, Thangalperumbulam in Ponneri Taluk of Tiruvallur, is inhabited largely by Scheduled Caste communities. The residents largely rely on cattle rearing, agriculture, and fishing, all of which depend on access to common lands and the Kosasthalaiyar-Pulicat wetland system.

According to the Coastal Aquaculture Authority (CAA) Act, 2005 (as amended in 2023), aquaculture farms must not be established within 100m of rivers, creeks, backwaters, or agricultural lands. Section 13(8)(b) prohibits farm siting in buffer zones of waterbodies.Guidelines under Section 3 require that common property resources such as canals, creeks, and sea must not be used in ways that interfere with traditional activities like fishing. Despite these rules, the report found that 173 acres of shrimp farms are located within prohibited buffer zones - 50 acres near agricultural land, 110 acres near the Kosasthalaiyar River, and 13 acres in both zones.

When contacted, a senior bureaucrat from the Department of Environment, Forest and Climate Change said the government will look into the allegations. "A thorough check should be done on the veracity of the claims since many of these shrimp farms would be old and existing before the CAA Act came into force, and the land grab issues are dealt by revenue department," the official said. Tiruvallur collector M Prathap was not



available for comments. The report contended that of the nine operators registered by CAA, eight were registered despite the farms located within the prohibited buffer zones. According to the CAA website, 178 acres were registered with renewed certification. Local residents say farms have affected their access to grazing The report documented lands. "By taking over poramboke lands, these farms are taking away our livelihood. The government should remove these," said Mary, a cattle-rearer of

Thangalperumbulam.

Around 700 cattle are reared by women in the village, and they rely on the Meikkal poromboke. Cattle rearers from nearby villages like Kadapakkam, Sirupazhaverkadu, and Edayankulam also use these common resources.

Manusmriti will not be taught in any course: DU VC New Delhi, 13 June: Delhi University Vice-

Chancellor Yogesh Singh has reiterated that Manusmriti will not be taught in any course at the university, following criticism over its mention in a Sanskrit department paper. "Earlier also, the administration has said that Manusmriti will not be taught in any course. Last year too the administration made it clear that it will not be taught in any form. However, the Sanskrit department suggested a reading containing Manusmriti under 'Dharamshastra Studies'. The reading stands deleted. If the department wants to teach Manusmriti, then they have to make it differently and they will do it accordingly," Singh said. The university also issued a statement on X saying, "University of Delhi will not teach Manusmriti text in any course of the University. 'Dharamshastra Studies', the DSC of the Sanskrit Department, where Manusmriti is mentioned as a 'recommended reading' stands deleted." The move comes after Manusmriti was listed in a four-credit Sanskrit course titled Dharmashastra Studies, introduced under the Undergraduate Curriculum Framework in line with the National Education Policy (NEP) 2020. The course also included texts like the Ramayana, Mahabharata, Puranas and Arthashastra. However, the inclusion of Manusmriti, a text long debated for its views on caste and gender, sparked protests from students and teachers alike. This is not the first time Delhi University has distanced itself from the controversial scripture. In July last year, the university had rejected a proposal to include Manusmriti and Baburnama in the history syllabus, stating that such additions would not be entertained in the future either.

DU orders structural, safety inspection in all its colleges

New Delhi, 13 June: The Delhi University administration has ordered a comprehensive structural and safety inspection in all its colleges, hostels and departments during the summer vacation, after multiple infrastructure-related accidents across campuses were reported. In an official circular issued by the Office of the Proctor, the university directed authorities to begin inspections of "all the rooms and toilets in your institution" after examinations end, as part of a survey under the Board of Residence, Health and Discipline, Ordinance XV (Chapter VI). This move comes after several accidents, including a fire at Sri Guru Gobind Singh College, another at the University Science Instrumentation Centre and an incident where a fan fell on a teacher at Kalindi College, were reported. There have also been repeated complaints about falling ceilings and deteriorating infrastructure in various colleges. "Please see that all the roofs and walls are in proper and safe condition, all the electrical fittings, like fans, lights are in working condition and there is ample supply of drinking water and water in the toilet," the letter states.

In another clip shared to social media, they described their trip as a "magical experience" and promised to share a vlog with their followers of their "mind blowing things"."We really have been on quite a journey and then just spending the last night here in this most amazing hotel, we've just had the most delicious Thali food. It was the perfect way to round up the trip," Jamie said. The Wellness Foundry, which is located in Vauxhall, offers psychic readings, tarot cards and aura readings, and has partnered with major brands such as Netflix, Google and Dior. On its webpage, it details that Fiongal founded the company in 2018 after experiencing a spiritual awakening following a mysterious illness.

His husband joined the team in 2023 as co-director and head of events, and he also offered psychic readings and life coaching.

follow the facts and put safety first." National Transportation Safety Board (NTSB), an independent US government agency tasked with investigating transportation accidents and incidents, said that they will lead a team of US investigators to probe the Air India crash in Gujarat.

The NTSB stated that as per protocols, all information on the investigation will be provided by India.

In a post on X, it said, "The NTSB will be leading a team of US investigators travelling to India to assist the Aircraft Accident Investigation Bureau with its investigation into the crash of an Air India Boeing 787 in Ahmedabad, India, Thursday. Per international protocols under the International Civil Aviation Organization's Annex 13, all information on the investigation will be provided by the Government of India."US President Donald Trump, while talking about the Air India plane crash, said that it was a "horrific" crash.Trump added that India is "a big country, a strong country, and they'll handle it, I'm sure, but I let them know that anything we can do will be over there immediately."

Israel attacks Iran's nuclear and missile sites, kills top military officials

IRGC chief Gen. Hossein Salami and CoS of Iran's armed forces Gen. Mohammad Bagheri were confirmed dead by state television, along with other top military officials and scientists.

DUBAI. Israel attacked Iran's capital early on Friday in strikes it claims targeted the country's nuclear program and killed at least two top military officers, raising the potential for an all-out war between the two bitter Middle East adversaries. It appeared to be the most significant attack Iran has faced since its 1980s war with Iraq.The strikes came amid simmering tensions over Iran's rapidly advancing nuclear program and appeared certain to trigger a reprisal, with Supreme Leader Ayatollah Ali Khamenei warning that "severe punishment" would be directed at Israel. Israel said Iran had launched drones in an

initial response. Multiple sites around the country were hit, including Iran's main nuclear enrichment facility, where black smoke could be seen rising into the air. The leader of Iran's paramilitary Revolutionary Guard, Gen. Hossein Salami, was confirmed dead, Iranian state television reported, a development that is a significant blow to Tehran's governing theocracy and an immediate escalation of its longsimmering conflict with Israel.

The chief of staff of Iranian armed forces, Gen. Mohammad Bagheri, was also confirmed dead by Iranian state television. Other top military officials and scientists were believed to have been killed.

In Washington, the Trump administration, which had cautioned Israel against an attack during continued negotiations over Iran's nuclear enrichment program, said that it had not been involved and warned against any retaliation targeting US interests or personnel. Still, it seemed likely the US suspected an attack could be in the offing, with Washington on Wednesday



pulling some American diplomats from Iraq's capital and offering voluntary evacuations for the families of US troops in the wider Middle East.

Israel calls attacks preemptive strikes

Israeli leaders cast the preemptive assault as a fight for the nation's survival that was necessary to head off an imminent threat that Iran would build nuclear bombs, though it remains unclear how close the country is to achieving that or whether Iran had actually been planning a strike soon.

'It could be a year. It could be within a few months," Israeli Prime Minister Benjamin

Netanyahu said as he vowed to pursue the attack for as long as necessary to "remove this threat." This is a clear and present danger to Israel's very survival," he said.

Israel is believed to have carried out numerous highly secretive attacks on Iranian soil over the years, though it has rarely acknowledged them. Most have been aimed at Iran's nuclear program, though Iran has also

accused Israel of targeting its natural gas pipelines and of assassinating Hamas political leader Ismail Haniyeh in Tehran.Over the past year, Israel has also been targeting Iran's air defenses, hitting a radar system for a Russian-made air defense battery in April 2024 and surfaceto-air missile sites and missile manufacturing facilities in October.Some 200 Israeli aircraft took part in Friday's operation, hitting about 100 targets, Israeli army chief spokesman Brig. Gen. Effie Defrin said, adding that the attacks were

Video shows a Secret Service agent on Noem's security detail grabbing the California senator by his jacket and shoving him from the room as he tried to speak up during the DHS secretary's event. Padilla interrupted the news conference after Noem delivered a particularly pointed line, saying

Images and video of the scuffle ricocheted through the halls of Congress, where stunned Democrats demanded an immediate investigation and characterized the episode as another in a line of mounting threats to democracy by President Donald Trump's administration.Senate Democratic leader Chuck Schumer said what he saw "sickened my stomach."

We need immediate answers to what the hell went on," the New York senator said from the Senate floor. "It's despicable, it's disgusting, it's so un-American."In a statement, DHS said that Padilla "chose disrespectful political theater" and that Secret Service "thought he was an attacker." The statement claimed

erroneously that Padilla did not identify himself — he did, as he was being pushed from the room. Trump illegally deployed National Guard to help with LA protests, must return control: Federal Judge

SAN FRANCISCO. President Donald Trump must return to California's governor control over National Guard troops his administration deployed to Los Angeles to assist in immigration enforcement and controlling unrest, a federal judge said in a temporary restraining order Thursday.U.S. District Judge Charles Breyer said Trump overstepped his bounds in ordering the deployment of roughly 4,000 National Guard members to LA after protests erupted over the immigration crackdown. The order, which takes effect at noon Friday, applies only to the National Guard troops and not Marines who were also deployed to the city."Today was really about a test of democracy, and today we passed the test," Gov. Gavin Newsom, who had asked the judge for an emergency stop to troops helping carry out immigration raids, said in a news conference after the decision. The deployment of the Guard was illegal and both violated the Tenth Amendment and exceeded Trump's statutory authority,



Breyer said. The White House called the order "unprecedented" and said it "puts our brave federal officials in danger."The district court has no authority to usurp the President's authority as Commander in Chief," White House spokesperson Anna Kelly said in a statement. "The President exercised his lawful authority to mobilize the National Guard to protect federal buildings and personnel in Gavin Newsom's lawless Los Angeles. The law will come into effect on October 1, while the festival will be celebrated in the same month.The governor on Thursday signed Senate Bill 201, protecting the right to religious door displays, such as the Hindu toran and Jewish mezuzah, according to an advocacy group, Hindu American Foundation (HAF). The bill was a joint initiative between HAF and the Anti-Defamation League (ADL), two of US's largest Hindu American and Jewish American advocacy organisations, HAF said in a statement.It was introduced by Senators Pazina, Neal, Flores, Scheible, and Krasner, and Assemblymembers Roth and Nguyen. Per the bill, religious displays in

dwellings that are no larger than 12" x 36" are permitted.

Want to clear waste from streets? WhatsApp the pic to BSWML

BENGALURU. The Bengaluru Solid Waste Management Limited (BSWML), a BBMP offshoot, has come up with a dedicated WhatsApp helpline (9448197197) to report and address issues related to waste. As per the officials, the residents may send a message with photographs to this number. Upon receipt, the officials concerned will take necessary action within a stipulated time and update the complainant on the resolution.

Within the BBMP limits, door-to-door waste collection is carried out daily through autotippers. However, many residents fail to hand over waste to these vehicles and instead resort to dumping garbage at night or during early hours on roadsides, footpaths, empty spaces, stormwater drains, and other public areas adversely impacting the city's aesthetics. This apart, construction debris is also being dumped by the roadside or in vacant plots, along with other unwanted items discarded indiscriminately across the city. To address this issue, permanent measures are being implemented across all wards in the eight zones of the BBMP," said an official.

Eliminating black spots is the key objective. To support this mission, a dedicated complaint centre has been established, and a WhatsApp helpline has been introduced.

Cuttack residents beware! CMC to impose penalty for littering roads

CUTTACK. To address the growing garbage menace in the city, the Cuttack Municipal Corporation (CMC) has planned to impose fine on the residents who litter the roads.

As per the decision taken by the civic body, individuals throwing garbage on roads will have to pay fine of '100 each while traders/shopkeepers will have to shell out '200 for the same.Mayor Subhas Singh said the move has been planned in view of the deteriorating sanitary condition of the city. "The proposal submitted by the CMC's health standing committee has been approved in the council and the civic body will soon implement the fine to streamline the waste management system in the city,"

While the minimum fine will be levied on the first-time violators, the penalty would be doubled for repeated violators. A team of 15 members headed by the sanitary inspector will be formed to collect the fine from the violators, Singh said.

Even though the roads and streets are being swept twice a day, and garbage collection vehicles mobilised to collect waste directly from the households, people continue to mindlessly litter them. Even roadside vendors and eateries throw waste directly into drains which lead to choking, as a result of which the issue of waterlogging worsens during heavy rains," the mayor said.

He further informed that the CMC would first hold awareness camps for the same in all 59 wards following which fine collection would be taken up.

Purchases for schools: Vigilance raid at Thiruvananthapuram corporation office uncovers irregularities

THIRUVANANTHAPURAM. The Vigilance and Anti-Corruption Bureau sleuths on Thursday conducted a raid at the Thiruvananthapuram corporation in connection with an investigation into alleged irregularities in the purchase of computers and allied equipment for schools between 2022-24. The raid,

conducted at the people's plan wing, began at 11am and lasted till 5.30pm. The scheme for supplying computers to schools within city limits was implemented with Rs 1.35 crore from the

development fund of the corporation. Vigilance had received information about massive irregularities in the execution of the project. Sleuths were tipped off about anomalies in preparing specifications for the purchase materials and in the tendering process. Contrary to the government directive, desktop computers were believed to have been purchased, instead of laptops. As many as 244 desktop computers and 193 UPS devices were purchased from private firms, allegedly resulting in a loss of Rs 20 lakh to the corporation. During the raid, it was found that the tendering process did not fully conform with norms. Gadget specification, warranty and quality check papers, besides the delivery challan and GST documents of firms that were part of the project were found to be missing from the files.

It also emerged that the purchase of computers contravened existing government rules that mandated purchase of laptops, instead of desktops, for students. The vigilance department had earlier received complaints that technical and purchase committees were not formed to implement the project.

Also, the project was reportedly implemented without the ratification of the technical committee, which is responsible for ascertaining the quality of materials. Another grave allegation was that the firms that supplied the UPS devices did not have GST registration at the time the project was implemented. However, despite this they were paid '92,973 as GST, which translated to a loss of that amount for the corporation.

Stir as Avadi garment unit plans Tambaram shift

CHENNAL Over 500 women, working in a garment manufacturing unit for the past three years in Avadi, have been on a protest since Monday as the company informed them all of a sudden that the operations will be shifted to its unit in Madras Export Processing Zone

(MEPZ) in Tambaram, located around 35 kilometres away, from July. The workers, who are in their thirties and forties and largely come from areas in and around Red Hills and Minjur, said the shift would result in them spending ! around 15-16 hours away from their homes, which is unsustainable, considering their family responsibilities.

We are not just 500 workers, we are 500 families, and many of us are single parents. If we are to spend our whole day working and travelling, who will take care of our families? We have to manage our homes

too," said 41-year-old R Jansi from Minjur. The workers are now demanding that the company should either drop its decision to shift or pay a fair final settlement of at least three months of their salaries, for the workers will have no option but to collectively resign. At present, the

company arranges vans to pick up the women from 32 points. Although the company has said it will continue to provide this facility, the workers said they would end up spending around five hours in travel, as the travelling distance will increase from roughly 13 to 25



kms (one way) at present to 40 to 60 kms (one way), once shifted.

The workers said they clock around nine hours a day at present at the unit, besides on occasions when they have to do overtime, and earn somewhere between Rs 12,000 to Rs 15,000 garment production after their mid-thirties," said Dharani V (33) from Red Hills, adding the workers are concerned whether they would get another job soon to sustain their families. According to the workers, the company has agreed only to encash their earned leave

balance, if any, if they were to resign by this month.

Sujata Mody, president of Garment and Fashion Workers Union (GAFWU), who has taken up the issue with the labour department along with the workers, contended that the company, Celebrity Fashions Limited, has violated provisions of the Industries Dispute Act with its sudden retrenchment announcement."The GAFWU contends that the company is in the process of closing, and it is a closure case. Neither the government nor the employer (Celebrity Fashion) is taking any steps to redress the grievances of the workers within a

fixed period, and neither of them has agreed on any solutions to the workers' problem," Mody said, adding another round of discussion is expected on Friday. The company could not be reached for a comment despite multiple

Mandaveli bus depot set to get Rs 151 crore makeover with Metro rail connectivity

CHENNAI. The Mandaveli Bus Depot and Terminal is slated for a face-lift for Rs 151 crore with modern, multimodal transit hub that integrates metro connectivity, bus services, retail, and office spaces within a single complex.

Envisioned as part of Corridor 3 of Chennai Metro's Phase II expansion, the project will embed the entry and exit structures of the upcoming Mandaveli underground metro station directly into the footprint of the existing bus depot. The objective is to maximise land use efficiency by combining metro access with designated pick up and drop off bays for buses.Chennai Metro Asset Management Limited (CMAML), a joint venture between Chennai Metro Rail Limited (CMRL) and the Tamil Nadu Industrial Development Corporation (TIDCO), has invited bids for the construction of the integrated development project at the Mandaveli site. The proposed project spans two adjacent land parcels. The first, covering 0.745 acres, will support a built-up area of 13,419 square metres, while the second, on 0.88 acres, will accommodate 15,966 square metres. Both plots will feature dual access points from RK Mutt Road and connecting side streets, aimed at improving connectivity and pedestrian flow.

Edakochi terminal to become key hub for Water Metro's suburban expansion

KOCHI. In a significant step toward expanding Kochi Water Metro services to the city's outskirts, construction of the Edakochi terminal-envisioned as the main Land parcels on either side of the Edakochi operational hub for the region-is set to begin soon. Though the Water Metro terminals at suburban locations such as Kumbalam and Nettoor have long been completed, pending power connections and final touches have delayed the launch of boat operations. Crucially, services in these areas can commence only after the Edakochi terminal becomes functional."The Edakochi terminal will serve as the hub for boat operations in the city's suburban belt. It will be equipped with electric charging facilities and other infrastructure, similar to the High Court terminal. The required land has

already been handed over to us," Sajan P John, chief operating officer of Kochi Water Metro Ltd (KWML), told.

Investors accuse Bengaluru builder firm of cheating in Kakkanad project

KOCHI. Around 50 people have approached the Kochi city police accusing Bengalurubased real estate developer Hoysala Projects Ltd of defrauding them of over Rs 30 crore that they collectively invested in new apartment projects at Kusumagiri along Infopark Road in Kakkanad.

Based on the complaint of Sathyanarayanan Gopinathan Nair from Aluva, one of the investors, the Infopark police have registered a case of cheating and criminal breach of trust under the IPC.As per the complaint, Hoysala Projects allegedly deceived investors, causing them financial distress, and without timely intervention, their lives would be ruined. Sathyanarayanan alleged the issue dates back to 2013-2014, when Hoysala Projects launched a development project featuring two 13-storey towers comprising a total of 128 flats. He said the builder promised modern amenities, including a shopping

At the time, construction of around 11 floors had been completed, attracting numerous investors, who paid 25% of the flat's cost as

part of the initial payment schedule, but the builder failed to complete the project even after collecting the money, he alleged.

"After getting no response from the developer for nearly five years, we approached the Kerala Real Estate Regulatory Authority (K-RERA) in 2021. The authority directed the developer to complete the project and later appointed a commission to investigate the delay. However, upon learning about the investigation, the developer unilaterally cancelled the agreements and allotments, and issued cancellation notices to 50 investors," Sathyanarayanan alleged.

"Many of us invested our retirement savings, personal funds and bank loans, with the assurance the apartments would be handed over by 2016. I paid '58.32 lakh for a 2BHK apartment of 1,512 sq ft, with only around '2.5 lakh remaining at the time of handover. This was my entire life's savings, supplemented by loans from multiple



banks," said Sathyanarayanan, a retired chief engineer from the shipping sector. An officer with the Infopark police station said they initially received a mass petition from the Flat Allottees Association, followed by an individual complaint.

Based on this, we registered a case naming the builder firm as the primary accused, and its MD T S Satheesh and CEO Vinod Kumar as the second and third accused," the officer said, adding, "The investigation is in its preliminary stage and further details cannot be disclosed at this point."

Developer denies allegations

Denying the allegations, Hoysala Projects Ltd said the complainants did not pay the remaining amount and the case is now before K-RERA.

We informed the customers on more than two occasions in 2023 that the Occupancy Certificate (OC) was ready and they needed to pay the balance amount to receive the keys. Instead, they approached K-RERA after one-and-a-half years claiming they were cheated.

Even after completing most of the payments, they are now seeking relaxation to adjust the remaining amount as delay compensation," said Satheesh T S, MD, Hoysala Projects Ltd.

As per the RERAAct, customers must pay the remaining amount within two months of receiving the OC or the agreement will be cancelled. Since they failed to do so, we terminated the agreements, Satheesh said.

Calling a rapist 'family' is not just

The Supreme Court recently used its special powers under Article 142 of the Constitution to uphold the conviction of a 25-year-old man for raping a 14-year-old girl without imposing a sentence. Some hailed the decision as a 'landmark', but it has raised serious concerns about the message it sends on child protection and justice. In 2018, a child was kidnapped in West Bengal. Later, she was found married to the man who had raped her and gave birth to his child. The court acknowledged that a crime had taken place and upheld his conviction under the Protection of Children from Sexual Offences Act, but reasoned that sending him to jail would make the victim the "worst sufferer" because she had now built a life with the accused.

The bench of Justices A S Oka and Ujjal Bhuyan made the decision based on the report of a committee consisting of a clinical psychologist, a social scientist and a child welfare officer, which found that the woman, now 21, is emotionally attached to the accused and protective of her "small family". Has the court interpreted her trauma-based dependence as 'consent' and survival as 'choice'?

In another recent case, the Orissa High Court adopted a similar approach. Justice S K Panigrahi granted bail to a 26-year-old man accused of raping a girl he had allegedly been in a relationship with since 2019, when she was 16. The complainant said the accused had physical relations with her on the false promise of marriage and that she became pregnant twice, in 2020 and 2022, but was forced to terminate both pregnancies. A case under the POCSO Act was filed i 2023. In 2024, the accused sought bail, claiming both families had agreed he should marry the complainant. The judge, while granting bail, remarked that the allegations, though serious in statutory terms, arose out of a "consensual relationship" between two individuals who were close in age and shared a personal bond before the case was filed and did not prima facie exhibit characteristics of force, coercion or exploitation. While the Supreme Court's judgement attempts to insulate itself by stating it is not to be treated as a precedent, exceptions like these rarely stay as such. Such orders seep into trial court reasoning, police investigations, and cultural discourse that already leans towards victim-blaming. It only takes one such judgement to fuel hundreds of similar pleas by offenders claiming to be part of a "small family" with their victim. The POCSO Act leaves no room for interpretation: a child under 18 cannot consent to sex. Section 2(d) defines a child as any person below 18. Section 3 defines penetrative sexual assault. Section 29 creates a presumption of guilt. And Section 42A overrides all other laws. Similar judgements by several Indian courts over the years have legitimised unequal relationships. These are not adolescent romances. These are situations of unequal power, age, access and agency. The law exists precisely to address that imbalance.

situation is the result of abandonment at every

level: first by her family, then by the state, and

finally by the court. She was failed at every

Overdependence of NASA on private entities like SpaceX and Axiom has global implications

Private agencies in space race has its perils

THE public spat between US President Donald Trump and his former advisor Elon Musk, triggered by the latter's criticism of the Congressional tax bill, has captured global attention. After Trump threatened to terminate government contracts and subsidies to Musk-owned SpaceX, the maverick billionaire issued a counter-threat to 'decommission' the Dragon spacecraft used by NASA. Musk made a U-turn and withdrew his threat a few hours later. Trump's warning to cancel government contracts to SpaceX and Musk's threat to withdraw Dragon from service — both have serious implications for the space sector in America and globally. An immediate point of concern was the flight of the Falcon rocket and crew spacecraft Dragon to fly the four-member crew, including Group Captain Shubhanshu Shukla of India, to the

International Space Station (ISS). Though Musk could

not have possibly carried out his threat to decommission Dragon at such short notice, given the complex web of contracts involving multiple players, the threat did create temporary uncertainty and anxiety. In a related development, Trump has withdrawn the nomination of Jared Isaacman to lead NASA. Isaacman, a billionaire aerospace entrepreneur, was widely known to be Musk's pick for the top job.

Unlike the 1984 space flight of the first Indian astronaut, Rakesh Sharma conducted free of cost as per a bilateral deal between India and the Soviet Union — Shukla is going to the ISS in a private mission costing each passenger \$55-60 million (about Rs 550 crore). The flight results from a set of agreements involving the Indian Space Research Organisation (ISRO), NASA, SpaceX and Axiom Space. NASA operates the ISS, while it has hired the services of SpaceX for transporting astronauts to the space station, and Axiom Space provides

Shukla's co-passengers on this trip are two astronauts from Poland and Hungary, and the flight is commanded by former NASA astronaut and Axiom official Peggy Whitson. Astronauts from Canada, Israel, Spain, Italy, Saudi Arabia, Turkiye and Sweden have flown to the ISS during previous missions of Axiom Space. Since the decommissioning of the Space Shuttle programme of NASA over two decades ago, SpaceX has become a centrepiece in America's space infrastructure. The company is responsible for satellite launches, crewed missions to the ISS as well as the launch of national

astronaut training and other facilitating infrastructure.

security payloads for the Pentagon and intelligence agencies. The total value of contracts awarded to SpaceX, Several important missions of NASA, like the launch of the Nancy Grace Roman Telescope in May 2027 and future lunar missions, depend on the launch services of SpaceX. NASA's next-generation Space Launch System is running behind schedule and faces budgetary cuts.

The Accords are a set of non-binding multilateral agreements launched in 2020, aimed at establishing principles for cooperative space exploration, especially concerning the Moon and Mars. While SpaceX is not a signatory to the Accords (only national space agencies or countries can sign it), it is vital for turning the Accords' vision into reality. SpaceX will build space vehicles and systems needed to make cooperative lunar missions possible. India and other

signatories to the Accords should consider this critical role of private entities in its execution.

Musk's threat to decommission Dragon and his conflict with Trump over space contracts should be a cause of concern globally on another count - satellite Internet services provided by Musk's Starlink. The company has been marketing its services to security agencies and armed forces globally. In America, several military commands are said to be using Starlink services, and it has been deployed in Ukraine too. Should Starlink customers trust someone like Musk who can threaten his own President and national space agency to decommission a vital space asset?It is known that Starlink's global satellite-based Internet service can be turned off or on in specific regions at will. Ironically, amid the Trump-Musk spat, the Central Government cleared Starlink to provide its services in

> The conflict between Trump and Musk, while rooted primarily in politics and ego clashes, raises larger strategic questions for national space agencies. It underscores the risks and implications of relying heavily on billionaire space entrepreneurs like Musk or Jeff Bezos (Blue Origin) for critical national and international space objectives. National and space agencies like ISRO, European Space Agency (ESA) and Japanese Aerospace Exploration Agency should watch out and chalk their future collaborations with America accordingly. The European Commission is already emphasising 'strategic autonomy' in its space plans. The dependence of European countries on Falcon 9 of SpaceX has led to calls for reducing reliance on US launchers. France and Germany are pushing for a Europe-led megaconstellation to compete with Starlink.

It is being realised that sovereign control is a must since Starlink controls vast real-time data networks. Musk's influence over NASA's capabilities is a reminder that space access sovereignty is essential for every spacefaring nation. It is a wake-up call that space is not insulated from political power games. ISRO must diversify partnerships, strengthen its own launch ecosystem and advocate a global space governance framework to ensure that the future of space does not rest in the hands of a few powerful individuals. Technological sovereignty should be kept in mind as India also plans to open its space sector to private

Manipur needs lasting political solution, not a patchwork

The conflict has torn apart its rich mosaic of diversity, with ethnic communities asserting their space and identity over the resource-rich landscape.

A fresh wave of violence tore the fragile calm in Manipur after protestors demanded the unconditional release of Ashem Kanan Singh, leader of the armed Meitei outfit Arambai Tenggol. Singh, a former head constable whose service was terminated this March, was arrested by the Central Bureau of Investigation at Imphal airport on June 8 for his involvement in various criminal activities linked to the 2023 Manipur violence. Clashes with the security forces across several districts of the Imphal valley and roadblocks that followed his arrest come on the heels of severe liash floods that have affected over about 56,000 people. The unrest has led to the imposition of curfew across five valley districts of Manipur along with the suspension of mobile internet services for five days.

The state has been grappling with deadly violence since May 2023, when clashes broke out between the Meitei the areas bordering Bishnupur and Churachandpur districts to protest the Meiteis' demand for scheduled tribe status. Manipur has been on the boil since then, with very



brief periods of peace marred by sanguinary violence. and Kuki communities during a tribal solidarity march in Former Union Home Secretary, Ajay Bhalla, a retired IAS officer of the Assam-Meghalaya cadre, was appointed Governor of Manipur this January to help assuage a society deeply divided on the issue of ethnic identity and

dominance. Former Chief Minister Biren Singh resigned in February after his tenure became untenable and Manipur was placed under the President's rule on February 13.Despite the political rearrangements, the state continues to bleed on a razor's edge of distrust. The conflict has torn apart its rich mosaic of diversity, with ethnic communities asserting their space and identity over the resourcerich landscape. The demands for ST status by the Meiteis, and for an even distribution of resources, equal representation and separate administration or state for their tribal areas by the Kukis have deepened the ethnic faultline. The conflict has claimed hundreds of lives, displaced around 60,000 people, bled the economy and led to a mass exodus. Manipur needs a healing hand, with a trustworthy and strong-

willed political solution that opens communication lines between the warring ethnic factions. Peace will return with a cohesive law and order situation and economic development. Any short-sighted patchwork can be even more damaging.

How India is countering Pakistan's false propaganda

SAARC may be fading, but India must have robust and dynamic alternatives like BIMSTEC.

IN recent weeks, the irony of Pakistan chairing key UN counter-terrorism committees has not been lost on the Indian public or its leadership. But lamenting irony is not enough. India must rise not just in protest but also in purpose. As terrorism continues to cast a long shadow over South Asia, our response must be anchored in clarity, vision and constructive engagement. The task ahead lies not only in exposing duplicity but also in shaping solutions that uphold truth, strengthen diplomacy and ensure regional stability. As part of the Global Outreach Programme, seven delegations were dispatched to engage with nations across the globe. I had the privilege of being in the delegation that visited Qatar, South Africa, Ethiopia and Egypt.

Our mission was clear: present India's perspective with conviction and counter misinformation. We highlighted the threat of cross-border terrorism and India's measured response to the Pahalgam attack - targeted action to dismantle terrorist infrastructure, not escalate conflict.

India counters global misinformation with action, not words. Post 1971, we returned 13,000 sq km and released 93,000 POWs — strength through statesmanship. I was part of Prime Minister Vajpayee's 1999 bus diplomacy to Lahore. This act of peace met with betrayal in Kargil and the 26/11 attack on Mumbai. Yet, India never closed the door on dialogue. Our stand: respond to falsehood with facts, betrayal with resolve and always pursue peace from strength. The problem, as we established, is not episodic. It is structural. Pakistan functions as a dual state: a shaky civilian government overshadowed by a deep state-military intelligence nexus that operates as a rogue force.

Since 1947, no civilian government in Pakistan has completed a full term. Democratic institutions remain hollowed out, manipulated by Generals and agencies. And then came the moment of truth. Pakistan's own former Foreign Minister admitted on BBC: "Yes, we have been doing this dirty job for 40 years, at the behest of the West—namely the US and UK." The admission should have jolted global conscience. Instead, it was met with silence, with realpolitik burying accountability yet again.

The results are clear. Today, 52 Pakistani individuals and entities are listed on the UN Security Council's Sanctions List for terrorism. These are not claims; they are official international designations.

Diplomacy, too, must adapt. In today's world, social media is a battlefield. False narratives about Kashmir, India's democracy and its minorities are amplified by networks seeking to destabilise us. We need a proactive, multilingual and digitally agile strategy. The government must work with civil society, tech firms and influencers to debunk propaganda in real time. A single timely fact can silence a thousand lies. Equally vital is the role of think tanks and public intellectuals. India must invest in narrative power — supporting those who can engage with global media, academia and multilateral forums and a well-informed diaspora empowered with verified data and regular briefings. We must not let the conversation on South Asia be hijacked by agenda-driven voices. We must shape the global discourse with facts, transparency and moral clarity. India, by contrast, showed immense patience. It granted Most Favoured Nation (MFN) status to Pakistan in trade. It opened the Integrated Check Post at Wagah to


promote people-to-people contact. But goodwill was weaponised against us. After the 2019 Pulwama attack, in which 40 Indian paramilitary personnel were martyred, India revoked Pakistan's



MFN status. Trust had bled dry.If international media truly wishes to understand Kashmir, they must see the smiling faces of children in Baramulla, the bustling hotels of Gulmarg, and the girls studying freely in Kupwara. The change is visible—but only if you dare to look beyond the narrative spun in Rawalpindi. Since the abrogation of Article 370, over \$5 billion was pumped into infrastructure, tourism has been at an all-time high, and thousands of young people in Kashmir are now employed in startups, tourism, and traditional crafts. Amid all this, India has stayed committed to No First Use (NFU) in nuclear doctrine. It is not a doctrine of timidity but of strength. In the face of persistent provocation—from Kargil to Pulwama to Pahalgam—India has chosen restraint, an act of leadership.India must also lead in building multilateral platforms for truth and engagement. India should propose a South Asia Peace and Development Forum — bringing together political

leaders, diplomats, scholars, bureaucrats and business voices. This forum could serve as a counterweight to misinformation while advancing dialogue on counter-terrorism. SAARC may be fading, but India must have robust and dynamic alternatives like BIMSTEC.At the global executive level, India must institutionalise joint task forces with democracies such as the EU, the US, South Africa, Egypt and others. These coalitions should prioritise critical issues like counterradicalisation, cybersecurity and intelligencesharing, with Pakistan's duplicity. The world must be made aware of the facts India possesses through incontrovertible evidence. Simultaneously, addressing the false narrative that India is overly aligned with Israel at

the exense of Palestine, India reaffirmed its principled stance. India's support for the Oslo Accords, its \$40 million humanitarian aid contribution, and its vote in favour of 10 out of 13 UN resolutions—including abstaining on resolutions related to the ICJ and trade—clearly underscores its commitment to a balanced approach. India does not seek domination; it seeks responsible leadership. Our vision is one of roads, railways and opportunities, not rockets and radicals. The African Union has robust measures against terrorism, addressing the growing nexus between terrorism, transnational organised crime, illicit financial flows and the use of advanced technologies like satellites and drones.

Teeth Naturally

- Banana peel

Claim: High levels of potassium, magnesium and manganese in bananas can help remove stains

Simply peel a ripe banana, and rub your teeth with the insides of the peel for about two minutes. After three weeks, your teeth will have whitened.

Verdict: True. If you rub the skin it can act as a

gentle exfoliator and will remove some surface stains, but the banana will not reach inside the pores on the surface of your enamel - so no true 'deep' clean will take place.

- Cider Vinegar

Claim: Rinsing with apple cider vinegar (mixed two parts of water) will make teeth whiter and protect teeth and gums from bacteria. Verdict: False. Cider vinegar is a favourite of

> 'detox' devotees. Once swallowed, it mixes vith pancreatic secretions in the intestines nd turns alkaline, but when it hits your teeth, is an acid, albeit a weak one. This makes he enamel on your teeth less resistant to damage - like wetting a chalk and then scraping off the surface.

- Coconut oil

Claim: A 3,000-year-old Ayurvedic way to clean teeth is to swish a tablespoon of oil (usually coconut, sesame or olive oil) around your mouth for 20 minutes every morning. The coconut oil sticks to the oil in the cell membranes of any bacteria in your mouth, so when you spit it out, you are ridding your mouth of unwanted microorganisms. Used by stars including Gwyneth Paltrow, who claim it whitens teeth and improves complexion.

Verdict: False. There is no scientific evidence at all that 'oil pulling', as it's called, will whiten teeth, or even remove bacteria. It's possible that the act of swishing the oil around your mouth will dislodge some bacteria or debris, so followed by a careful brushing session, your teeth may look cleaner. But no science shows that oil pulling will make your teeth any whiter.

- Strawberries

Claim: Mash up a ripe strawberry, dip your toothbrush in it and brush carefully over teeth. Within two weeks, your teeth will be whiter.

Dentist's Verdict: True. Strawberries contain citric acid, which can weaken the surface hardness of your teeth. But it also contains the more gentle malic acid, and the riper the strawberry becomes, the higher the concentration of malic acid compared to the more harmful citric acid.

So choose a really ripe strawberry, rub it on your teeth and just like exfoliating the skin, it does remove superficial debris. The malic acid won't actually break down the stain molecules, but the surface clean gives your teeth a whiter appearance. A gentle and effective natural whitener.

- Turmeric powder

Claim: Mix half a teaspoon of dried turmeric yellow spices are the worst. Far from whitening



Air India crash blaze reached 1,000°C, even dogs, birds couldn't escape

New Delhi. The temperature in and around the crashed Air India plane rose to around 1,000 degrees Celsius, which made the rescue operation extremely difficult, officials said on Thursday night. Even dogs and birds at the site could not escape, they said. A London-bound Air India plane carrying 242 passengers and crew crashed in a residential area in Ahmedabad minutes after taking off from the city airport on Thursday afternoon.

There was 1.25 lakh litres of fuel inside the plane, and it caught fire so it was impossible to save anyone," Union minister Amit Shah told reporters.A State Disaster Response Force (SDRF) official said their personnel reached the hostel and residential quarters of doctors and staff members of the BJ Medical College, where the aircraft crashed, between 2 to 2.30 pm. Before that, locals had pulled out some people alive but their teams did not get anybody alive. A senior fire official said, "As the (aircraft's fuel) tank exploded it created an inferno where the temperature rose to 1,000 degrees Celsius in no time. This left little chance for anyone to escape." An SDRF personnel, who joined the force in 2017, said he has handled crisis situations before but has never seen such a disaster.

"We came here with PPE kits. But the temperature was so high that it made operations difficult. There were debris everywhere. So we had to clear the debris that were already simmering," he said. The official, who said he was not allowed to speak to the media, claimed his team removed 25-30 bodies including those of children."DNA tests will have to be done for recognition of

Another SDRF official claimed he lost the count of bodies he removed. "It was so quick that even animals and birds got little time to escape," he said, pointing to the carcasses of dogs and birds in the residential complex.

Bulging eyes Could be: Thyroid problems

Prominent-looking eyes can run in families, but eyes that appear to bulge may be evidence of an overactive thyroid. Abnormal levels of thyroid hormone cause the tissues around the eye to swell, making it appear the eye is popping outwards.

Droopy eyelid

Could be: Bell's Palsy or Stroke

Crude oil prices surge amid tension between Israel and Iran

NEW DELHI. Crude oil prices soared by more than 12% on Friday following an escalation in tensions between Israel and Iran. Israel launched a series of coordinated airstrikes on Iranian nuclear facilities, triggering fears of broader disruptions to global oil supplies. As a result, Brent Crude prices surged nearly 13%, reaching \$77.77 per barrel, while West Texas Intermediate (WTI), the benchmark US oil contract, climbed 12.6% to \$76.61 per barrel.

However, by 11:10 AM IST, the rally had cooled somewhat, with Brent Crude trading at \$74.86 per barrel and WTI at \$73.73. The spike in crude prices was driven by concerns that the ongoing conflict between Israel and Iran could disrupt oil supplies from the energy-rich region, which accounts for roughly one-third of the world's oil production. Oil prices are now on track for their largest weekly gain since 2022.A report from JPMorgan warned that an escalation in the conflict could push oil prices to as high as \$120 per barrel, potentially driving the US Consumer Price Index (CPI) to 5%. However, the report also noted that the closure of the Strait of Hormuz, a key global oil shipping route, is considered a low-risk event, as Iran would damage its own economic and political position by antagonizing its main oil customer. According to brokerage firm ICICI Securities, crude oil prices have risen amid growing geopolitical tensions in the Middle East. The escalating situation between Israel and Iran could affect oil supplies, further adding to the uncertainty in global energy markets. In addition, the US is preparing a partial evacuation of personnel from the region after Iran threatened to target US military bases if nuclear talks fail.

Gold sees sharp rise in price as investors turn to safehaven assets

CHENNAI. Gold prices in India witnessed a sharp rise on Friday, reflecting global market trends as investors turned to safe-haven assets amid escalating geopolitical tensions and macroeconomic uncertainty. The price of 24-carat gold jumped by ?840 per 10 grams, while 22-carat gold rose by ?770 per 10 grams compared to the previous day. This sharp uptick pushed domestic gold prices to record levels, mirroring gains in international markets where spot gold has been buoyed by rising safehaven demand. The surge comes on the back of renewed tensions between Israel and Iran, along with lingering concerns over inflation and potential shifts in interest rate policies by major central banks. The US dollar and bond yields remained volatile, further supporting gold prices. Analysts note that the current geopolitical environment and financial market volatility are likely to keep gold demand strong in the near term, especially among cautious investors and



central banks increasing their reserves. With gold hitting fresh highs, both retail buyers and investors are advised to stay informed and monitor market cues closely. While gold continues to be a favored hedge in times of crisis, price volatility remains a key risk factor in the short term.



Iran has promised to respond, adding to concerns that oil prices could rise even more if tensions continue to grow.

OIL MARKETING COMPANIES DROP

Shares of India's major oil marketing companies fell sharply in early trade. Bharat Petroleum Corporation (BPCL) lost more than 4%, Hindustan Petroleum Corporation (HPCL) declined around 4.5%, and Indian Oil Corporation (IOC)

The Indian rupee dropped to 86.20 against the US dollar in early trade but later recovered to 86.04, helped by the central bank's likely intervention. Currency dealers at two state-run banks told the news agency that RBI sold dollars around the 86.05 mark to stabilise the market. The pressure on the rupee came as oil prices surged nearly 12% to \$78 a barrel after Israel targeted Iranian nuclear facilities in what it described as a preemptive strike to prevent Tehran from developing

atomic weapons. Iran has vowed to respond, raising fears of prolonged conflict in the Middle East and potential disruption to global oil supply routes, including the critical Strait of Hormuz.Any escalation in the region could lead to higher crude prices, a key risk for oil-importing countries like India, which relies on imports for over 85% of its energy needs. A sustained rise in oil prices not only widens India's trade deficit but also adds pressure on the rupee and complicates the inflation outlook.While the RBI does not officially comment on currency market operations, it has consistently intervened in the past to curb excessive volatility, especially when global events disrupt capital flows or commodity prices. Friday's intervention underscores the central bank's focus on containing imported inflation risks and ensuring currency stability amid fresh geopolitical

Aviation stocks tumble after Air India plane crash in Ahmedabad

New Delhi. Aviation stocks saw a sharp fall on Friday, June 13, after the tragic Air India plane crash in Ahmedabad. The crash has shaken investor confidence and led to selling pressure in related shares during early trade.

This was one of the world's deadliest aviation disasters in a decade and the first fatal crash involving a Boeing 787 aircraft. Following the news, Boeing shares in the United States dropped around 5% on Thursday.



Consistency will be crucial in England: Morne Morkel

BECKENHAM (Kent): Consistency will be key in English conditions, according to India bowling coach Morne Morkel, who admitted to being "a little bit nervous" about the squad's lack of red-ball time ahead of the Test series against England, starting June 20. India kickoff their new World Test Championship cycle with the five-match away series, under the leadership of newlyappointed captain Shubman Gill.

"I think consistency is crucial in England and there is consistency when we practice, there's consistency off the field, finding your process, what's going to work for you as an individual," Morkel said on the sidelines of India's training session here."We've got a great variation, variety in our attack, guys with different skill sets so they can do that and still execute the basics well," he added.

India last played red-ball cricket in early January, during the Sydney Test against Australia. Additionally, several players in the current squad, including Yashasvi Jaiswal and Sai Sudharsan, will be featuring in their maiden Test series on English soil.

"All in all, happy with the start so far. I was a little bit nervous in terms of the lack of red

The South African doesn't think that the Test pitches are going to be as spicy as the once they have experienced so far.

I'm going to tell them not to only talk when the wickets are nipping around but when its flat, that's where we're going to need the character at all times."

Matthew Hayden has claimed that the bowling trio of Pat Cummins, Josh Hazlewood and Mitchell Starc is better than the iconic Australian pace attack of Glenn McGrath, Brett Lee and Jason Gillespie after their performance on Day 2 of the World Test Championship final on Thursday, June 12. Cummins broke all sorts of records as he picked up figures of 6 for 28, while Starc took 2 and Hazlewood 1 as Australia bundled out South Africa for 138 runs.

Speaking after the end of Day 2, Hayden said that Cummins does everything right and the trio have bowled together more and in different combinations as compared to the legendary trio. The former Aussie opener



felt that Australia did well to pull ahead despite pressure, with the game being evenly poised heading into Day 3."Cummins does everything right—he challenges the off stump, uses the slope, and targets the top of the stumps, making batters play constantly. He now has over 300 Test wickets despite not bowling for five and a half years due to

injury. That's extraordinary.""The trio of Hazlewood, Cummins, and Starc might just be Australia's best-ever pace attack—even better than McGrath, Gillespie, and Lee—because they've bowled more together, in more combinations. Add Nathan Lyon to the mix, and it's an 'awesome foursome.' Australia did well to pull ahead

despite pressure. South Africa fought back hard, making this a seesaw contest. It's been a fantastic Test match so far, and Day 3 promises more drama," said Hayden. 'Bowlers have dominated WTC Final so far'

A total of 14 wickets have each fallen on first two days and Hayden feels that the batters have been a bit rusty. The former Aussie opener feels that South Africa will need to get a hundred-run stand and a fifty partnership in the second innings to help them stay in the game."Looking at Day 2 performance, an equal number of wickets have fallen over the two days. Batters seem a bit rusty in terms of Test match batting. The lateral movement has made footwork difficult—they're getting hit on the pads, edging deliveries. Bowlers have dominated this match. There hasn't been a single century partnership yet, and that could make a huge difference in the fourth innings. Even if Australia gets a lead of 250, South Africa will need a 100-run stand and another 50-run partnership to stay in the game. Ironically, more wickets have fallen when the sun's been out, not under overhead conditions. It speaks more about batting rust than exceptional bowling."

New Zealand batter Finn Allen rewrote the record books with his breathtaking innings of 151 (51) during the opening game of Major League Cricket 2025 (MLC 2025) for San Francisco Unicorns.

New Delhi. New Zealand batter Finn Allen shattered the record books with his breathtaking innings for San Francisco Unicorns against Washington Freedom in the opening match of Major League Cricket 2025 (MLC 2025) on Friday, June 13 at Oakland Coliseum, California. Allen played a blistering innings of 151 (51), smashing five fours and 19 sixes as he helped his team



post a massive score of 269/5 in their allotted 20 overs.

Allen brought up his half-century in just 20 balls and later registered the fastest hundred just 34 balls. His six-hitting exhibition helped him etch his name in the record books for the fastest 150 recorded in T20 cricket in just 49 balls.

The Kiwi batter treated the bowlers with utter disdain, whacking them all round the park as he also broke the record for most sixes in T20 cricket (19 sixes). He stitched a quick-fire 88-run stand for the third wicket off 37 balls with Sanjay Krishnamurthi, taking San Francisco past the 150-run mark in the 12th over.Later in the second innings, Washington also got off to a blistering start

as openers Rachin Ravindra (42 off 17) and Mitchell Owen (39 off 20) added 80 runs for the first wicket off just 32 balls.
