Chandigarh: Man accused of abetment to suicide in Manimajra, case registered



**Chandigarh.** In a case of alleged abetment to suicide reported in Manimajra, a 34-year-old man has accused another person of mentally harassing his father over a financial dispute, leading to his father’s death.

According to the police, an FIR under Section 108 of the Bharatiya Nyaya Sanhita (BNS) has been registered at Manimajra police station on the complaint of Rahul, a resident of Manimajra. Rahul alleged that Idam Khan Gill, also a resident of the area, had been repeatedly pressuring his father, Satish Kumar, regarding a loan amounting to Rs 12 lakh.

Due to alleged constant mental harassment, Satish Kumar reportedly died by suicide at his residence on the evening of June 25 around 6.54 pm. He was immediately rushed to PGIMER, Chandigarh, where doctors declared him brought dead. Police have initiated a thorough investigation into the matter to ascertain the circumstances surrounding the death. Further action will be taken based on the findings, said the police.

Surat witnesses creek floods, roads inundated; Limbayat most affected



**Surat.** Owing to the incessant rainfall over the last three days, low-lying areas in Surat were on Friday inundated. Surat also witnessed creek floods. Limbayat, which houses the migrant population working in textile and other industries, was the most affected. Relief camps have been set up in several municipal corporation schools for around 227 people who were affected by creek floods, while water was being cleared in some areas.

Sources in the Surat Municipal Corporation (SMC) stated that from June 23 to 26, a total of 459 mm of rainfall was recorded in Limbayat, accounting for 30 per cent of rainfall received by the area in the entire monsoon season. Apart from this, due to the heavy rain in the upper catchment areas, the water levels of Mithi Creek and Koili Creek, which pass through Limbayat, had risen to 8.85 meters and 7.50 meters, respectively. However, on Friday, the water levels in these creeks dropped to 7.35 meters (Mithi) and 6.75 meters (Koili), respectively. The dip in the water level was led by a sea tide.

During June 23-26, a total of 36 complaints of waterlogging were received at Limbayat’s zone-level control room, out of which 15 complaints were disposed of, and work on the remaining was in progress.

Security guard of Kolkata law college where student was raped held, fourth arrest in case



**Kolkata.** The Kolkata police Saturday arrested the security guard of a law college in the city in connection with the alleged rape of a 24-year-old student inside its campus on Wednesday. This is the fourth arrest in the case.

“We have arrested a security guard of the college,” said Rupesh Kumar, Joint Commissioner of Police, Crime. He has been identified as Pinaki Banerjee, a resident of Khardaha who was on duty when the crime took place inside the college. In her complaint, a copy of which is with The Indian Express, the survivor had alleged that she was raped inside the guard room after the security guard was told to leave.

“We found discrepancies in the guard’s statement and the survivor has made a direct complaint against him. His role when the crime was being committed is being investigated. He will be produced in court today,” said a senior Kolkata police officer.

Earlier, the police had arrested three people over the matter, including Monojit Mishra, the prime accused who is a former leader of the Trinamool Congress’s (TMC) student wing and an ex-student of the college. The TMC has claimed that Mishra is no longer associated with the party. The other accused have been identified as Zaib Ahmed and Pramit Mukherjee.

Ahead of 50th anniversary, Sion’s iconic Guru Kripa, whose samosas were loved by Raj Kapoor and Dilip Kumar, debuts in South Mumbai

**Mumbai.** In the late 1960s, Vishindas Wadhwa — whose family came to India during Partition and settled in Mumbai — found success selling samosas from a thela (hand cart). In 1975, he went on to establish what would become Sion’s beloved Guru Kripa. Over the next five decades, it earned a loyal following for its samosas, tikki chole, and a range of savouries, as well as mithais like the Sindhi specialty Sev Barfi, made with khoya and sev. Its reputation spread far beyond the neighbourhood. But for South Mumbai residents, there was always one complaint: “It’s too far!”

Ahead of its 50th anniversary this August, third-generation custodians Bharat and Sunaina have addressed this long-standing gripe by opening Guru Kripa’s first branch — just a stone’s throw from the Royal Opera House on Charni Road. “What better gift to my grandfather than taking his culinary repository to a bigger audience,” said Bharat on a weekday afternoon, just two days after the shutters were lifted.

Spread across 800 sq ft, the Charni Road outpost functions as a mithai retail outlet and delivery kitchen and offers an elevated experience. While the original 1,500 sqft store evokes nostalgia with its classic mithai-and-snack shop vibe, the new branch is more contemporary in

design. There’s a truck-style mithai station, a hamper counter, and a “wall of fame” showcasing celebrity visitors and key milestones in the brand’s journey. “We wanted it to be an experience centre where every corner tells a story,” Bharat shared. “So



we gave it a retro South Bombay touch.” Pointing to a wall behind the savoury counter, he drew our attention to a series of black-and-white photos featuring the Asiatic Library, Chhatrapati Shivaji Maharaj Terminus, and the BMC building. “This is our ode to South Bombay.”

Unlike the original outlet, where customers can grab a quick samosa while standing outside or enjoy a full meal in the air-conditioned seating

area, this new branch is strictly takeaway and delivery. “We did want a small dine-in section,” Bharat admitted. “But it didn’t fit the space and what we set out to do with this experiment.” In the hour we spent at the shop, the counter stayed busy with walk-ins sampling mithai or picking up snacks for home. “The response has been great, people are happy that it’s now accessible,” he said, adding that early favourites include samosas, gulab jamun, sugar-free dates mithai and their recently launched Biscoff barfi, and Jain-friendly snacks like chole tikki, sandwiches, and Sindhi-specialty dal pakwan.

Guru Kripa’s samosas, of course, have a cult following of their own. Legend has it that Raj Kapoor and Dilip Kumar were regulars, and that when Amitabh Bachchan suffered a near-fatal injury on the sets of Coolie, Vishindas Wadhwa distributed samosas while praying for his recovery. “When Mr Bachchan learned of this, he visited us, enjoyed the samosas, and declared them his favourite,” Bharat recounted proudly.

We asked him for the real marker of success: the number of samosas sold. He smiled shyly before revealing, “We sold 1,000 samosas each on day 1 and day 2.” Fifty years on, it seems life has come full circle for Vishindas Wadhwa’s Guru Kripa.

Stark difference in labour costs pushes Maharashtra farmers to grow illegal HTBt cotton variety



**Pune.** Over the last few years, Laximant Kauthankar has refrained from using genetically modified cotton variety, commonly known as Bt cotton, and has completely switched to using the unauthorised Herbicide Tolerant Bt (HTBt) cotton. This farmer from Adgaon Budruk village in Akot taluka of Akola knows such cultivation is illegal but claims that simple economics pushes him towards it. “Weed control alone in Bt cotton would cost me over Rs 20,000 per acre. In the case of HTBt, the same would cost Rs 2,000. So why should I not go for it?” he asks. Kauthankar says the input shop in his village hardly sees any sale of Bt cotton — most farmers have crossed over to HTBt for the same reason as him. Like him, other cotton growers in Maharashtra have lapped up the unauthorised transgenic cotton, fully knowing the illegality of

their act. Central government regulations stipulate fines as well as jail term for the cultivation of non-authorised GM crops. India has so far allowed the commercial release of Bt cotton. Bt stands for Bacillus thuringiensis — the name of the bacteria whose gene has been inserted into the cotton seed. HTBt is the next generation of GM cotton and allows the plants

to resist the spray of the commonly applied herbicide glyphosate for weed control. But the sale, production as well as storage of this variant is illegal in the country. But for farmers like Kauthankar, the ground situation matters. “Consider this: for an acre of land, I would require around four cycles of weeding during the entire 6-7 month cycle of the cotton crop. For a single weeding, I would require around 15 labourers and thus the total requirement for labourers would be around 60. At a daily wage of Rs 300 per day, the total labour expenditure for weeding turns out to be Rs 18,000. Even if I arrange the money, where are the labourers?,” said the farmer who cultivates cotton and soyabean over 40 acres of his holding. On the other hand, HTBt cotton requires spraying of the herbicide, and the total cost of this operation across the entire cotton crop cycle comes to Rs 2,000 per acre.

Air India 171 crash: Last DNA match day after family holds symbolic funeral

**Vadodara .** Friday marked Ashadhi Beej, when Kutchhis celebrate their new year. But the Khimani family was grieving. They were grieving the loss of their loved one, Anil Khimani (32), who was on the London-bound AI 171 that crashed in Ahmedabad on June 12. They were also grieving because his was the only body among the 241 dead that had not yet been identified through a DNA match. Searching for “closure” and to “overcome the guilt” of not being able to bid a respectful farewell, the Khimanis held a “symbolic” funeral at Dahinsara, their village in Bhuj, on Thursday followed by a prayer meeting on Friday.



Hours after the prayer was held, however, a senior government official told The Indian Express that they were finally able to find a DNA match and identify Anil’s body.

“Multiple rounds of processing for DNA extraction were undertaken, considering that the sample was too degraded with charring... But eventually, it was matched. The family will be informed, the DNA match will give them final closure,” the official said. Speaking to The Indian Express earlier Friday, Anil’s older brother Rakesh said “the reason for organising the symbolic funeral was that two weeks had passed since the crash”.

Haryana agri university agitation: Female students allege food denial, threaten shutdown on July 2

Students are demanding action against those responsible for the June 10 assault and the resignation of Vice-Chancellor Dr B R Kamboj.

**Chandigarh.** The agitation at Chaudhary Charan Singh Haryana Agricultural University (CCSHAU) has intensified, with female students alleging that food services in university hostels were abruptly discontinued. Protesters continued raising slogans late into Thursday night, accusing the university authorities of harassing them. While the university administration claimed the hostels were vacated as a routine measure following the completion of exams, students asserted they were left without basic necessities.

On Friday, a group of aggrieved female students met senior university officials, alleging that no dinner was provided the previous evening.

PhD student Nikita voiced her resentment to the authorities: “We are standing hungry in front of you. Why has our food been stopped? What is our crime? On Thursday night, we kept requesting

our hostel warden with folded hands that we are hungry and want food. The hostel warden replied that no one would come to talk to you.” She added, “We got food at 11 pm after the intervention of policemen. On Friday morning



again, our hostel warden announced that she would not allow us food at the hostel.” The Director of Students’ Welfare, Dr S K Pahuja, responded by saying that hostel evacuation was part of a scheduled plan to conduct repairs and renovations.

As KSHCE flags ‘violations’, St Joseph’s University defends programme expansion, calls govt report a ‘misreading of norms’

**Bengaluru.** St Joseph’s University has refuted allegations made by the Karnataka State Higher Education Council (KSHCE) that it violated state norms by launching new academic programmes and admitting excess students without government approval. The university, in its official response, termed the objections “a misreading of UGC norms and state-issued guidelines” and said that it would consider raising the matter with the state government.

On June 24, the Karnataka Higher Education Department announced a penalty of Rs 4 lakh on the university based on KSHCE’s inspection report which found that St Joseph’s had introduced over 20 new undergraduate programmes and admitted more than 500 additional students during the 2023–24 and 2024–25 academic years.

The report also said that the institution failed to share 60 per cent of its seats with the state, as mandated for private universities.

In a detailed response, Prof Dr Melwin Colaco, Registrar of St Joseph’s University, said the changes were made in good faith, based on the National Education Policy (NEP) guidelines issued by the state. “It is our understanding that the council’s objections are based on a wrongful reading of UGC norms and the specific directions issued from time to time,” he said.

Tracing the developments back to 2021, Prof Colaco explained that when the institution was still St Joseph’s College (Autonomous), affiliated to Bangalore City University, it had restructured academic offerings in response to the NEP.

Three major programmes were reconfigured into two major combinations, thereby increasing the number of programmes offered, though the overall student intake remained the same,” he clarified.

pending for over a month, implying students could return home.

However, Nikita contended: “We have stayed here earlier too during summer vacations with special permissions and were provided food. What has changed this time? Why has our food been stopped? We have faced a lot of mental harassment. My thesis is due in 10 days. We have already paid a late fee for an extension. How can I go home? Please understand us — we are like your daughters.” Another student questioned the officials directly: “Had your daughter been a student here, would she have faced the same treatment?”

Director (Research), Dr Rajbir Garg maintained that the students’ claims regarding closure of hostels were false, stating that “the vacation of hostels for repair work during summer is a standard procedure”. As tensions continue to rise, students have declared that they will observe a complete shutdown of the university on July 2 if their demands are not met by then.

ED launches probe into ‘Rs 800 crore graft’ case linked to Navi Mumbai dredging project

Earlier, the CBI booked the former chief manager of the Jawaharlal Nehru Port Authority and Tata Consulting Engineers, Mumbai, in connection with the case.

**Mumbai.** The Enforcement Directorate (ED) has launched a money laundering investigation into the Rs 800 crore graft case linked to the Capital Dredging Project at Nhava Sheva port in Navi Mumbai. The central agency registered an Enforcement Case Information Report (ECIR) on Friday and initiated a probe to examine the money laundering aspect of the entire graft case, sources said.

The ED’s case is based on the predicate offence registered by the Central Bureau of Investigation (CBI) around 10 days ago. The CBI lodged a case against former chief manager of the Jawaharlal Nehru Port Authority (JNPA) Sunil Kumar Madabhavi, Tata Consulting Engineers (TCE), Mumbai, as well as several private individuals and entities. The other accused named in the First Information Report (FIR) include TCE

director Devdutt Bose; M/s Boskalis Smit India LLP, Mumbai; and M/s Jan De Nul Dredging India Pvt Ltd, based in Chennai. The case, registered on June 18, 2025, stems from allegations that a criminal conspiracy was orchestrated between JNPA officials and a consortium of private firms, one based in Mumbai and the other in Chennai, to siphon off public funds under the guise of project payments, the CBI said.

Irregularities in Capital Dredging Project

According to the CBI, the alleged irregularities occurred during the execution of a Capital Dredging Project aimed at deepening the port’s navigational channel to accommodate larger vessels. During Phase-I of the project, JNPA reportedly made excessive payments totalling Rs 365.90 crore to contractors for supposed over-dredging work. However, the



payments came under scrutiny after it was revealed that during Phase-II, which coincided with the maintenance period of Phase-I, an additional Rs 438 crore was disbursed under the claim that no over-dredging had taken place in the previous phase, thereby contradicting earlier assertions.

CBI raids in Mumbai, Chennai

After lodging the FIR, the CBI teams raided the

residences of former JNPA officials, offices of the private companies involved, and the premises of the consulting firm at five locations in Mumbai and Chennai. A large cache of project-related documents, digital devices, and evidence, allegedly indicating illicit investments made by public servants linked to the scam, has been seized during the exercise.

### Canal bath turns tragic in Jhajjar, bodies of two cousins found after search

Jhajjar: A weekend meant to offer respite from the searing heat ended in tragedy for two cousins in Jhajjar district, as the bodies of Amit (32) and Vikas (28) — both residents of Azad Nagar — were recovered from the Akehri Madanpur pump house on Sunday morning, two days after they went missing while bathing in the Jawaharlal Nehru Canal near Matanhail village. According to police, the two had entered the canal on Friday evening, hoping to cool off from the oppressive temperatures. When their motorbike, slippers and wallets were later found abandoned near the canal bank, alarm bells

rang. Suspecting drowning, authorities launched a search and rescue operation with divers and boats, but efforts proved fruitless until Sunday. It was only when staff at the Akehri Madanpur pump house noticed something lodged in the filter system that the grim discovery was made. They immediately informed the police, who arrived at the spot along with a team from the Forensic Science Laboratory (FSL) to examine the scene and collect evidence. Both Amit and Vikas were working as apprentice carpenters at a workshop in Khaparwas village. Their employer confirmed that the two had left work early on Friday, saying they were heading

for a bath in the canal. When they failed to return home, their worried families filed a missing report, triggering the search operation. Police officials stated that both victims were believed to be competent swimmers, but the strong current and high water levels in the canal likely overwhelmed them, leading to the tragic drowning. After a preliminary forensic examination, the bodies were taken to the Jhajjar Civil Hospital for post-mortem. They were later handed over to the bereaved families for final rites. The victims, both married and fathers to young children, leave behind grieving households and a community in mourning.

## Health Minister Arti Singh Rao Reviews Hospital Development Works in Rewari & Narnaul

Chandigarh, June 27: Haryana Health and Family Welfare Minister Arti Singh Rao chaired a high-level meeting with senior officials in Chandigarh to review the status of ongoing infrastructure and service enhancement projects in government health institutions, particularly in Rewari and Narnaul districts. The meeting focused on expediting key initiatives related to hospital safety, construction progress, utility infrastructure, and essential facilities aimed at improving healthcare delivery and patient experience. During the review of District Hospital, Rewari, the Minister took up the issue of the Fire NOC, directing officials to work closely with the Fire Department to ensure that all compliance requirements are fulfilled and approvals are obtained at the earliest. She also emphasized the urgency of completing the land demarcation process and directed the Deputy Commissioner, Rewari to expedite the matter. The

Minister directed the Public Works Department (PWD) to complete all ongoing repair works at the hospital by the end of July. She also reviewed the construction of the foot overbridge connecting the hospital to the trauma centre and instructed the PWD to

ensure that all four lifts are fully installed and operational by July 15. On the proposed upgrade of the mortuary, it was informed that the plan is expected to be approved by the Chief Architect by Monday, after which the PWD will prepare a detailed estimate. The

Minister also issued directions to resolve the issue of waterlogging at the Rewari Civil Hospital to prevent service disruptions during monsoons. While reviewing the functioning of District Hospital, Narnaul, the Health Minister directed the PWD to initiate re-ten-

dering for the construction of the 200-bed hospital and begin work without further delay. She also ordered the removal of waterlogging in the basement of the hospital building and instructed that proper drainage lines be laid to prevent future issues. Further, the 4

## Chemical spray used to force family out of car

New Delhi: In a shocking case that has exposed a new method of robbery on Delhi roads, a family traveling from the Capital to Karnal on Friday became victims of a well-planned heist near Adarsh Nagar flyover. The robbers allegedly used a chemical spray on the car's windscreen which further spread in the car, causing severe irritation and itching to the passengers and forcing them out, before snatching a handbag containing cash, a mobile phone, and diamond jewelry. Despite having tracked the location of the stolen phone through a mobile app and informing the police, the family claims no concrete action has been taken yet. According to the FIR registered at Adarsh Nagar Police Station, the incident occurred around 8:10 pm on MG Road. The complainant, Dyanchand Singh, 70, a resident of Karnal, stated that two young men on a motorcycle came close to their white Toyota Crysta car

and sprayed an unknown chemical on the vehicle's windscreen while the car was moving along the heavily trafficked stretch. The chemical, once circulated through the air conditioning vents, caused severe irritation, suffocation, and itching, forcing the passengers to halt the vehicle and exit in panic. As the family members stood by the roadside trying to understand what had happened, the same two bike-borne individuals returned at high speed and snatched the handbag from one of the women before fleeing in the opposite direction. The bag reportedly contained an iPhone, cash, important documents including Aadhaar, PAN and ATM cards, and diamond rings. As per the complainant, his son, using a family tracking app installed on the stolen phone, was able to trace its last known location to an area in East Delhi. The family immediately reported this information to the police, hoping for swift action.

However, they allege that even after sharing the specific location of the suspects, no visible effort has been made by Delhi Police to either recover the stolen items or apprehend the culprits. A case under Sections 304(2) and 35 of the Bharatiya Nyaya Sanhita has been registered. According to the

duty officer and officials from PS Adarsh Nagar, a team has been formed, and efforts are ongoing to trace the accused. "We are investigating all aspects of the case and following all leads, including the location shared by the victim's family," said a police official.

## Accused 'sold' login credentials for altering 300 IDs on Parivar Pehchan Patra portal

Rohtak: Preliminary investigation into the alleged tampering of the Parivar Pehchan Patra (PPP) portal case, which came to light in Karnal on Friday, has pointed to a nexus between a local Citizen Resource Information Department (CRID) official and Common Service Centre (CSC) operators. Sources said an accused official revealed during the interrogation that he had "sold" his login credentials, which were then used to illegally alter the details of around 300 family IDs, enabling beneficiaries to fraudulently qualify for var-

ious welfare schemes. "The accused further disclosed that fake documents were prepared to support these illegal changes in professional details. The racketeers would share the bribes based on the financial aid received under the welfare schemes. Besides altering occupations, they changed the name of the district, split family IDs, and even deleted names of family members from the PPP records," claimed the sources. The FIR registered in the case also states that the CRID official's social media accounts on WhatsApp, Instagram, Facebook, and Telegram should be exam-

ined technically to detect possible collusion with other individuals involved. Two persons, including Ankit Kumar, a CRID official deputed at Municipal Council office in Nissing (Karnal), and Sunny, a CSC operator, were booked by the Karnal Police two days ago on charges of cheating, criminal breach of trust, criminal conspiracy, and under relevant provisions of the Information Technology (Amendment) Act, 2008. The complaint was filed by the District Citizen Resources Information Manager. The CRID official is accused of sharing his login credentials, including ID, password,

and one-time passwords (OTPs), with CSC operators and others, to alter details of family IDs allegedly in exchange for bribes. Meanwhile, Ram Lal, Station House Officer (SHO) of Nissing Police Station, Karnal, told "The Tribune" that preliminary investigations point to the involvement of multiple individuals. "Ankit appears to be part of an organised network, possibly operating across Haryana. We are investigating the case from multiple angles and have launched raids to locate another accused believed to be in hiding," said the SHO, adding that the official is, currently, in police remand.

### 8,000 flat registries in 9 Gr Noida projects stuck over Rs 400cr dues, seesaw over FAR

Noida: Over 8,000 buyers who invested in nine group housing projects under Uttar Pradesh State Industrial Development Authority (UPSIDA) in Greater Noida continue to wait for the registration of their properties over dues exceeding Rs 400 crore, incomplete towers, legal hurdles and an impasse over Floor Area Ratio (FAR). While land parcels for the projects were allotted between 2007 and 2011 when Greater Noida offered a 2.75 FAR, developers redrew maps and got them vetted by UPSIDA again after FAR was increased to 3.5 in 2013. FAR is a ratio of the area on which a building can be constructed in relation to the size of a land parcel.

## CISF National Fire training initiative : 380 Fire fighters trained in 150 cities, across 22 States/UTS

Netanyahu denounces report that Israeli soldiers have orders to shoot at Palestinians seeking aid

**JERUSALEM.** Israeli Prime Minister Benjamin Netanyahu and Defense Minister Israel Katz emphatically rejected a report in the left-leaning Israeli daily Haaretz on Friday, which claimed Israeli soldiers were ordered to shoot at Palestinians approaching aid sites inside Gaza. They called the report's findings "malicious falsehoods designed to defame" the military.

More than 500 Palestinians have been killed and hundreds more wounded while seeking food since the newly formed Gaza Humanitarian Foundation began distributing aid in the territory about a month ago, according to Gaza's Health Ministry.

Palestinian witnesses say Israeli troops have opened fire at crowds on the roads heading toward the sites. Reacting to the Haaretz piece, Israel's military confirmed that it was investigating incidents in which civilians had been harmed while approaching the sites. It rejected the article's allegations "of deliberate fire toward civilians."The foundation, which is backed by an American private contractor, has been distributing food boxes at four locations, mainly in the far south of Gaza, for the past month.

"GHF is not aware of any of these incidents but these allegations are too grave to ignore and we therefore call on Israel to investigate them and transparently publish the results in a timely manner," the group said in a social media post.Palestinians trying to find food have frequently encountered chaos and violence on their way to and on arrival at the aid sites. Tens of thousands are desperate for food after Israel imposed a 2 1/2 month siege on Gaza, blocking all food, water and medicine from entering the territory pending the setup of the GHF sites.

The bodies of eight people who died Friday had come to Shifa Hospital from a GHF site in Netzarim, although it was not immediately clear how they died, Dr. Mohamed Abu Selmyiha, the hospital's director, told The Associated Press. A GHF spokesperson challenged the report, saying they did not know of any incidents at or near their sites Friday.Twenty other bodies his hospital received Friday came from airstrikes across north Gaza, he said.

Protesters gather in Bangkok to demand PM Shinawatra's resignation over leaked phone call with Hun Sen

**BANGKOK.** Hundreds of protesters gathered in Thailand's capital on Saturday to demand the resignation of Prime Minister Paetongtarn Shinawatra, part of the brewing political turmoil set off by a leaked phone call with former Cambodian Prime Minister Hun Sen.Paetongtarn faces growing dissatisfaction over her handling of a recent border dispute with Cambodia involving an armed confrontation May 28. One Cambodian soldier was killed in a relatively small, contested area.The recorded phone call with Hun Sen was at the heart of the demonstration Saturday and has set off a string of investigations in Thailand that could lead to Paetongtarn's removal.Outrage over the call mostly revolved around Paetongtarn telling Hun Sen, the current Cambodian Senate president, not to listen to "an opponent" in Thailand. It's believed to be a reference to the regional Thai army commander in charge of the area where the clash happened, who publicly criticized Cambodia over the border dispute.

Protesters held national flags and signs as they occupied parts of the streets around the Victory Monument in central Bangkok. At a huge stage set up at the monument, speakers expressed their love for Thailand following the intensified border dispute.Many of the leading figures in the protest were familiar faces from a group popularly known as Yellow Shirts, whose clothing color indicates loyalty to the Thai monarchy. They are longtime foes of Paetongtarn's father, former Prime Minister Thaksin Shinawatra, who reportedly has a close relationship with Hun Sen.

Driven to starvation, Sudanese people eat weeds and plants to survive as war rages

**CAIRO.** With Sudan in the grips of war and millions struggling to find enough to eat, many are turning to weeds and wild plants to quiet their pangs of hunger. They boil the plants in water with salt because, simply, there is nothing else. Grateful for the lifeline it offered, a 60-year-old retired school teacher penned a love poem about a plant called Khadija Koro. It was "a balm for us that spread through the spaces of fear," he wrote, and kept him and many others from starving.

A.H, who spoke on the condition his full name not be used, because he feared retribution from the warring parties for speaking to the press, is one of 24.6 million people in Sudan facing acute food insecurity —nearly half the population, according to the Integrated Food Security Phase Classification. Aid workers say the war spiked market prices, limited aid delivery, and shrunk agricultural lands in a country that was once a breadbasket of the world.Sudan plunged into war in April 2023 when simmering tensions between the Sudanese army and its rival paramilitary the Rapid Support Forces escalated to fighting in the capital Khartoum and spread across the country, killing over 20,000 people, displacing nearly 13 million people, and pushing many to the brink of famine in what aid workers deemed the world's largest hunger crisis.Food insecurity is especially bad in areas in the Kordofan region, the Nuba Mountains, and Darfur, where El Fasher and Zamzam camp are inaccessible to the Norwegian Refugee Council, said Mathilde Vu, an aid worker with the group based in Port Sudan

'This is not an ordinary fraud case': Funeral home owner who stashed nearly 190 decaying bodies sentenced to 20 years in prison

Federal prosecutors accused both Hallfords of pandemic aid fraud, siphoning the money and spending it and customer's payments on a GMC Yukon and Infiniti worth over \$120,000 combined, along with \$31,000 in cryptocurrency...

**DENVER.** A Colorado funeral home owner who stashed nearly 190 dead bodies in a decrepit building and sent grieving families fake ashes received the maximum possible sentence of 20 years in prison on Friday, for cheating customers and defrauding the federal government out of nearly \$900,000 in COVID-19 aid.Jon Hallford, owner of Return to Nature Funeral Home, pleaded guilty to conspiracy to commit wire fraud in federal court last year. Separately, Hallford pleaded guilty to 191 counts of corpse abuse in state court and will be sentenced in August.At Friday's hearing,

federal prosecutors sought a 15-year sentence and Hallford's attorney asked for 10 years. Judge Nina Wang said that although the case focused on a single fraud charge, the circumstances and scale of Hallford's crime and the emotional damage to families warranted the longer sentence.

"This is not an ordinary fraud case," she said. In court before the sentencing, Hallford told the judge that he opened Return to Nature to make a positive impact in people's lives, "then everything got completely out of control, especially me.""I am so deeply sorry for my actions," he said. "I still hate myself for what I've done."Hallford and his wife, Carie Hallford, were accused of storing the bodies between 2019 and 2023 and sending families fake ashes. Investigators described finding the bodies in 2023 stacked atop each other throughout a squat, bug-infested building in Penrose, a small town about a two-hour drive south of Denver.The morbid discovery revealed to many families that their loved ones weren't cremated and that the ashes they had spread or cherished were fake. In two cases, the wrong body was buried, according to court documents.Many families said it undid

their grieving processes. Some relatives had nightmares, others have struggled with guilt, and at least one wondered about their loved one's soul.Among the victims who spoke during Friday's sentencing was a boy named Colton Sperry. With his head poking



just above the lectern, he told the judge about his grandmother, who Sperry said was a second mother to him and died in 2019.Her body languished inside the Return to Nature building for four years until the discovery, which plunged Sperry into depression. He said he told his parents at the time, "If I die too, I could meet my grandma in heaven and talk to her again." His parents brought him to the hospital for a

Bangladesh government reaffirms commitment to safeguard minority rights

**DHAKA.** Bangladesh government has said that it remains firmly committed to safeguarding the rights of all communities and protecting places of worship but building religious structures on public land is not permissible "under any circumstance".

The Foreign Ministry's statement on Friday came a day after India denounced the reported destruction of a Durga temple in Dhaka and stressed the responsibility of Bangladesh's interim government to protect Hindus as well as religious institutions.The ministry claimed that the temple in Dhaka's Khilkhet area was built on land owned by Bangladesh Railways, and its removal was carried out following due process to recover public land, the state-run BSS news agency reported.It alleged that the temple started as a makeshift pavilion, with organisers attempting to make the temporary structure permanent despite repeated

reminders.On June 26, Bangladesh Railways proceeded with the "peaceful eviction of all unauthorised structures along the rail track in Khilkhet area," it said.

"While the laws of the land ensure full



protection to all places of worship without discriminating against any built-in conformity with law, it is not permissible for any to build any religious structure encroaching public land under any circumstances," the ministry said."Bangladesh remains firmly committed to safeguarding the

rights of all communities, including protection of the places of worship," it added.During a briefing on Thursday, External Affairs Ministry spokesperson Randhir Jaiswal said, "We understand that extremists were clamouring for demolishing the Durga temple in Khilkhet, Dhaka.""The interim government, instead of providing security to the temple, projected the episode as illegal land use and they allowed the destruction of the temple today," he said.

"This has resulted in damage to the deity before it was shifted. We are dismayed that such incidents continue to recur in Bangladesh," he added.Jaiswal underlined that it is the responsibility of the interim government of Bangladesh "to protect Hindus, their properties, and religious institutions."The Hindu population in Bangladesh has been affected by a series of incidents against minority communities in the country.

Thousands mourn top Iranian military commanders, scientists killed in Israeli strikes

**DUBAI.** Thousands of mourners lined the streets of downtown Tehran on Saturday for the funeral of the head of the Revolutionary Guard and other top commanders and nuclear scientists killed during a 12-day war with Israel.

The caskets of Guard's chief Gen. Hossein Salami, the head of the Guard's ballistic missile program, Gen. Amir Ali Hajizadeh and others were driven on trucks along the capital's Azadi Street as people in the crowds chanted: "Death to Aericia" and "Death to Israel."Salami and Hajizadeh were both killed on the first day of the war, June 13, as Israel launched a war it said meant to destroy Iran's nuclear program, specifically targeting military commanders, scientists and nuclear facilities.There was no immediate sign of Iran's Supreme Leader, Ayatollah Ali Khamenei, in the state broadcast of the funeral. Khamenei, who has not made a public appearance since before the outbreak of the war, has in past funerals held prayers for fallen commanders over

their caskets before the open ceremonies, later aired on state television.Iranian Foreign Minister Abbas Araghchi was on hand, and state television reported that Gen. Esmail Qaani, who heads the foreign wing of the Revolutionary Guard, the Quds Force, and Gen. Ali Shamkhani were also among the mourners.Shamkhani, an adviser to Khamenei who was wounded in the first round of Israel's attack and hospitalized, was shown in a civilian suit leaning on a cane in an image distributed on state television's Telegram channel.Iran's Revolutionary Guard was created after its 1979 Islamic Revolution. Since it was established, it has evolved from a paramilitary, domestic security force to a transnational force that has come to the aid of Tehran's allies in the Middle East, from Syria and Lebanon to Iraq. It operates in parallel to the country's existing armed forces and controls Iran's arsenal of ballistic missiles, which it has used to attack Israel twice during the Israel-Hamas war in the Gaza Strip.Over 12 days before a

ceasefire was declared on Tuesday, Israel claimed it killed around 30 Iranian commanders and 11 nuclear scientists, while hitting eight nuclear-related facilities and more than 720 military infrastructure sites. More than 1,000 people were killed, including at least 417 civilians, according to the Washington-based Human Rights Activists group.Iran fired more than 550 ballistic missiles at Israel, most of which were intercepted, but those that got through caused damage in many areas and killed 28 people.Saturday's ceremonies were the first public funerals for top commanders since the ceasefire, and Iranian state television reported that they were for 60 people in total, including four women and four children.Authorities closed government offices to allow public servants to attend the ceremonies.Iran has always insisted its nuclear program is only for peaceful purposes. But Israel views it as an existential threat and said its military campaign was necessary to prevent Iran from building an atomic weapon.

Many South Asians, Muslims in NYC and beyond electrified by Mamdani's mayoral primary triumph

**World** The success of Zohran Mamdani in New York City's Democratic primary for mayor is euphoric for Hari Kondabolu, a stand-up comedian who's been friends with the candidate for 15 years.

Mamdani stunned the political establishment when he declared victory in the primary on Tuesday, a ranked choice election in which his strongest competition, former New York Gov. Andrew Cuomo, conceded defeat.When he launched his campaign, the unabashed democratic socialist ranked near the bottom of the pack. Now, the 33-year-old state assemblyman has a chance to be New York City's first Asian American and Muslim mayor. Mamdani's family came to the United States when he was 7, and he became a citizen in 2018. He was born to Indian parents in Kampala, Uganda.

For Kondabolu, this moment is not just exciting, but emotional.

"I think so many of us have had those experiences in New York of being brown and in a city that has always been really diverse and feels like ours. But after 9/11, like you start to question it like, is this our city too," Kondabolu said. "And 25 years later ... it's surreal, like this is the same city but it's not because we've elected this person."Mamdani's campaign has piqued the interest of many Indian, Pakistani and other South Asian Americans, as well as Muslims — even those who may not agree with Mamdani on every issue. Despite that opposition, some still see his rise as a sign of hope in a city where racism and xenophobia erupted following the Sept. 11, 2001, terrorist attacks.

South Asians and Muslims riveted by primary in New York, and beyondMany of New York City's over 300,000 South Asian residents have been inspired by Mamdani's extraordinary trajectory."My mom was texting her friends to vote for him. I've never seen my mother do that before," Kondabolu said. "So the idea that it's gotten our whole family activated in this way — this is, like, personal."Snigdha Sur, founder and CEO of The Juggernaut, an online publication reporting on South Asians, has been fascinated by the response from some people in India and the diaspora.

"So many global South Asians ... they're like, 'Oh, this guy is my mayor and I don't live in New York City,'" Sur said.At the same time, some are also concerned or angered by Mamdani's past remarks about Indian Prime Minister Narendra Modi, who he publicly called a "war criminal."In Michigan, Thasin Sardar has been following Mamdani's ascent online. When he first heard him, he struck him as "genuine" and he felt "an instant connection," he said."As a Muslim American, this victory puts my trust back in the people," said Sardar, who was born and raised in India. "I am happy that there are people who value the candidate and his policies more than his personal religious beliefs and didn't vote him down because of the color of his skin, or the fact that he was an immigrant with an uncommon name."

New York voter Zainab Shabbir said family members in California, and beyond, have also excitedly taken note.

Pakistan welcomes Court of Arbitration's ruling on J&K hydroelectric projects

**ISLAMABAD.** Pakistan on Saturday welcomed the ruling by the Permanent Court of Arbitration in The Hague over two hydroelectric projects in Jammu and Kashmir and indicated its readiness for talks with India on issues relating to Indus Waters Treaty.The "high priority", at this point, is that "India and Pakistan find a way back to a meaningful dialogue, including on the application of the Indus Waters Treaty (IWT)," Pakistan said in a statement released early on Saturday.India on Friday strongly rejected the ruling saying it has never recognised the so-called framework for dispute resolution with Pakistan.

India rejects this so-called "supplemental award", the Ministry of External Affairs (MEA) said, referring to the ruling in the case related to Pakistan's objections to Kishenganga and Ratle hydropower projects.In its ruling, the Court of Arbitration said India's decision in April to keep the Indus Waters Treaty in abeyance "does not limit" its competence over the

dispute and that its ruling is binding on the parties.However, India has never recognised the proceedings at the Permanent Court of Arbitration after Pakistan raised objections to certain design



elements of the two projects under the provisions of the Indus Waters Treaty.On the other hand, Pakistan called the ruling a "major legal win" emphasising that it is a "clear message that India cannot unilaterally suspend or sideline the

treaty."The MEA called out Pakistan by saying that "this latest charade at Pakistan's behest is yet another desperate attempt by it to escape accountability for its role as the global epicentre of terrorism.""Pakistan's resort to this fabricated arbitration mechanism is consistent with its decades-long pattern of deception and manipulation of international forums," it said in a statement.The illegal Court of Arbitration, purportedly constituted under the Indus Waters Treaty 1960, albeit in brazen violation of it, has issued what it characterizes as a 'supplemental award' on its competence concerning the Kishenganga and Ratle hydroelectric projects in the Indian Union Territory of Jammu and Kashmir," the MEA said.

"India has never recognised the existence in law of this so-called Court of Arbitration," it said.The MEA said India's position has all along been that the constitution of this so-called arbitral body is in itself a serious

breach of the Indus Waters Treaty and consequently any proceedings before this forum and any award or decision taken by it are also illegal for that reason.A day after the April 22 Pahalgam terror attack, India took a series of punitive measures against Pakistan that included putting the Indus Waters Treaty of 1960 in "abeyance".

"Following the Pahalgam terrorist attack, India has in exercise of its rights as a sovereign nation under international law, placed the Indus Waters Treaty in abeyance, until Pakistan credibly and irrevocably abjures its support for cross-border terrorism," the MEA said.

"Until such time that the treaty is in abeyance, India is no longer bound to perform any of its obligations under the treaty," it said.

"No court of arbitration, much less this illegally constituted arbitral body which has no existence in the eye of law, has the jurisdiction to examine the legality of India's actions in exercise of its rights as a sovereign," it added.

Allotment of 3.7 acres of prime land to IAMC illegal, rules Telangana HC

**HYDERABAD.** The Telangana High Court on Friday set aside a Government Order (GO) dated December 26, 2021, issued by the previous BRS administration allotting 3.7 acres of prime land in Raidurg to the International Arbitration and Mediation Centre (IAMC). The court, however, upheld related GOs providing financial support to the IAMC and requiring referral of certain disputes to the centre.The market value of the land is around Rs 350 crore, according to sources. The then government also sanctioned a grant of Rs 50 crore for the construction of the IAMC. The foundation stone for a permanent building was laid on March 11, 2022, by the then-Chief Justice of India Justice NV Ramana in the presence of the then chief minister K Chandrasekhar Rao.

A bench of Justice K Lakshman and Justice K Sujana was hearing PILs filed by advocates Koti Raghunatha Rao and A Venkatrami Reddy questioning the legality of the GOs granting land, funding and arbitration referrals to the IAMC. The PILs said that the IAMC was a private entity receiving state support without a legal basis.

The bench held that the allotment was in breach of the 1975 Rules on alienation of state land. It ruled that land cannot be allotted free of cost to a private body unless it is for a public purpose and with the collection of market value.

The bench also noted that the IAMC was not registered under the Companies Act at the time of allotment, making the process invalid.

Hyderabad to get sculpture park around KBR walkway



**HYDERABAD.** The GHMC, in collaboration with the Krishnakriti Foundation, will develop the Hyderabad Sculpture Park around the Kasu Brahmananda Reddy (KBR) Walkway in Jubilee Hills under the Corporate Social Responsibility programme. The primary objective is to enhance the area with public art installations and improve the overall aesthetic appeal of the walkway.

Popular for walking, jogging and enjoying nature, KBR Park is a well-known green space in Hyderabad. The sculpture park is intended to beautify the urban landscape and provide a more appealing experience for visitors and walkers at KBR National Park. The project is being undertaken as part of the GHMC’s CSR initiatives, demonstrating a commitment to social and environmental responsibility.Officials said the collaboration with the foundation focuses on integrating art and culture into the urban environment, creating a unique space at the popular KBR Park. On Thursday, the GHMC Standing Committee approved the proposal and recommended it to the GHMC Council for awarding the work.Recently, the foundation submitted proposals to the zonal commissioner of Khairatabad to take up the project. The initiative includes enhancing the city’s visual landscape, creating a cultural landmark, promoting public engagement, encouraging CSR partnerships.

Pilgrims troubled as Bhadrachalam chokes on garbage amid sanitation staff protest over reduced salary

**KHAMMAM.** Due to poor sanitation, the temple town of Bhadrachalam has been in a state of disarray for the past two months. Sources said the outsourcing staff have not been discharging their duties because of reduced salaries.

The unhygienic conditions are troubling pilgrims visiting from across the country. Locals have also criticised the government’s inaction. Garbage has piled up across the town, including near the temple.

Of the 285 sanitation and drainage workers, nearly 140 have stopped reporting to duty. Most of the absentees are from the drainage and road-cleaning sections. Officials said only seven out of 90 drainage workers are currently on duty.Earlier, the gram panchayat paid each worker Rs 12,000 per month. This was reduced to Rs 9,500 recently. “We can’t run our families on such low pay,” said worker K Ramana, adding that daily-wage labourers earn up to Rs 15,000 a month. “Despite working 8 to 12 hours a day, we are paid just Rs 9,500,” he lamented.

Local resident B Shanker Reddy said the mosquito menace has worsened, causing illness, especially among children and the elderly. Another resident, B Ramana Reddy, said the issue must be resolved urgently as Bhadrachalam is a temple town.Devotees have also raised complaints about the foul smell and garbage heaps. Gram Panchayat executive officer Ch Srinivas said the issue has been taken up with the government and that they are managing sanitation with the available staff.

1.2 lakh orphans across Maharashtra fail to get monthly assistance of Rs 2,250 from state govt

**Nashik.** More than 1.2 lakh orphaned children across Maharashtra have not received the monthly monetary assistance from state govt since Sept 2024. The guardians of these children have alleged that the assistance was stopped after state govt began providing aid to women through the Mukhyamantri Majhi Ladki Bahin Yojana.The children are given assistance under the Krantijyoti Savitribai Phule Child Care Scheme. The list includes children who lost either one or both their parents due to Covid-19.

A senior officer from the Women and Child Development Commissionerate, Pune, admitted that there were more than 1.2 lakh such orphans across the state who received the assistance and have not received any money for 10 months now.

"There has been some technical issue regarding funds, and as soon as it is resolved, the funds will be cleared," he said on the condition of anonymity. When asked if the reason for the non-disbursal of funds to these orphans was connected to the Ladki Bahin scheme, the officer refused to comment.Despite several attempts, state minister for women and child development Aditi Tatkare was not available for comment till the time of going to press.

According to the Economic Survey of Maharashtra 2024-25, the scheme had 80,224 beneficiaries in 2023-24 and 1,05,595



beneficiaries till Dec 2024. Maharashtra govt incurred an expenditure of Rs 190.97 crore in the 2023-24 financial year. However, till Dec 2024, govt had only spent Rs 40.5 crore on the scheme.

There are as many as 7,300 such orphans receiving aid in Nashik district. They last got the money in their accounts in Aug 2024.

Panchavati resident Sanket\*, one of the beneficiaries of the scheme, said, he received Rs 2,250 every month in his bank account directly from state govt. "I lost both my parents to Covid. I stay with my maternal uncle, who is a labourer. My sister and I are not receiving the

Fragments of grief: Al 171 families cling to mementos from ashes — scorched gold jewellery and torn clothes, which tell stories of loss, are all that remain

**AHMEDABAD/VADODARA.** The debris of the ill-fated flight AI 171 may have been cleared from Meghaninagar, but for the families of the 241 lives lost in the June 12 crash, the emotional wreckage remains. For many, closure comes in fragments: a child's lone shoe, scorched jewellery, torn clothes. These fragile items, returned by authorities, now carry unbearable meaning. They are fragments of love, loss, and all that never got to be said.

For Yasin Vora of Ahmedabad, a bar of gold serves as the last tangible link to his wife Yasmin Bano, 51. "Yasmin had got a bracelet so our daughter-in-law could wear it for a baby shower, as it is customary to wear gold on that day. She was wearing it on the flight," says Yasin. A local goldsmith, moved by the tragedy, cleaned the jewellery without charge. "The ornaments were damaged, so we had it refined into a gold bar. I will keep it forever."

Yasmin had planned to fly on June 9 but



delayed her journey to travel with his nephew Parvez, 31, and Parvez's four-year-old daughter Zuveriya who also died in the crash. His nephew Ejaz Vora says fragments of Parvez's and Zuveriya's clothing were buried with them. Yasmin was headed to London to visit her sons, both expecting children. What should have been a joyous six-month visit turned into a farewell none could imagine. Another grieving relative from Ahmedabad,

aid now. We don't know when we will get this assistance regularly," he said.

Std VIII student Aziz\*, who lives in the Old City area, faced a similar plight. "I lost my father due to Covid-19. I have a younger brother, and my mother works in a private hospital. The assistance helped us get admission in a good private school," he said.

Aziz added: "The non-receipt of assistance is taking a toll on me and my school, which is putting pressure on my family for the fees."

Many guardians said the children were not a burden on them but sought govt assistance due to the situation they were forced into since Covid."My wife succumbed to Covid, and it happened despite spending a huge amount on medicines. I had to sell my two-wheeler and other valuables to arrange for funds of about Rs 1.5 lakh. I also lost my job. This is the reason that I am seeking govt assistance for the future of my two children," said Ramesh Patil, a worried parent.

The beneficiaries include orphans under the age of 18, children whose parents cannot be traced, kids who have not been adopted, those who have lost one parent or are impacted due to family disputes and under govt child care. Children of people with leprosy, HIV or other serious life-threatening ailments, or kids of convicts serving life sentence and those whose both parents have a handicap are also eligible for the financial assistance.

Hi-res Skymet forecasts topower BMC's rain response



**Mumbai.** In a first-of-its-kind move, BMC is set to collaborate with private weather agency Skymet to receive hyperlocal rainfall forecasts for each of the city's 24 municipal wards. The forecasts will not only offer 24-hour advance alerts but also "nowcasts" within three hours of an expected extreme weather event.While India Meteorological Department (IMD) will remain the official authority for weather alerts, BMC plans to use Skymet's ward-level forecasts as a "parallel lens" to enhance its preparedness. An MoU is being drafted, and Skymet is expected to begin issuing alerts starting July 1.

The move follows widespread flooding on May 26, when IMD's red alert was issued after severe waterlogging had already disrupted the city. Although civic officials have refrained from publicly criticizing IMD, sources say the delay prompted BMC to seek a second opinion system to better anticipate such events and position resources.

As part of the pro bono agreement, Skymet will gain access to live data from Mumbai's 120 automatic weather stations. In return, it will provide real-time, ward-specific forecasts. "If there's a mismatch between the two forecasts, both IMD and Skymet will be asked to re-evaluate their models," said a senior civic official.

Additional municipal commissioner Ashwini Joshi, who also chairs the city's district disaster management authority and heads the environment department, said, "The govt already uses Skymet's services, particularly in agricultural forecasting."

Skymet CEO Yogesh Patil said, "Our system will leverage five years of historical data from BMC's weather stations and deliver two types of forecasts: a 24-hour advance alert and a nowcast 3 to 6 hours before an event, both at the ward level," he said.

Guj sees fastest 30% monsoon rain in 10 yrs

**Ahmedabad.** On Friday, Gujarat crossed 30% of the seasonal rainfall with an average cumulative 257 mm of rainfall. According to State Emergency Operations Centre (SEOC) data, the average cumulative rainfall on June 7 was 7 mm, indicating that in a matter of 20 days, the state received 250 mm of rain, which is 28% of the season's total rainfall. The SEOC data indicate that it was the most vigorous monsoon in June the state has seen in at least the past 10 years.

To put the figure in perspective, the average rainfall till June 27 for the past five years was 10.6% - the highest, 14%, was recorded in 2020 at 118 mm of rain.

According to India Meteorological Department (IMD) data, the state's departure from normal this year till June 27 was 135% or more than double. Across the state, several districts such as Surat, Jamnagar, and Bhavnagar recorded major rainfall in the past 10 days. While all the regions of the state recorded significant rainfall, the SEOC data indicate that 22 out of 34 districts received over 25% of seasonal rainfall so far.Ashok Kumar Das, director of IMD Gujarat, said that



the long-range forecast (LRF) of IMD for India indicated normal to above-normal rains for India at large, which was also true for Gujarat. "This year, we have seen a good monsoon trough extending from the Arabian Sea to the Bay of Bengal. The state also benefited from cyclonic circulations over Rajasthan and Gujarat. Thus, this year's rains are relatively higher compared to normal," he said, adding that traditionally July and August are the months with high rainfall and monsoon activities for Gujarat. "For the next few days, almost all regions of the state are expected to receive good rainfall." Gujarat has suffered a loss of life due to heavy rains, with nearly 30 people reported dead due to rain-

related emergencies this season. Parts of north Gujarat and Surat city recorded major rains this year that resulted in damage to property. Experts said that for the past two decades, the state is experiencing a change in weather patterns where the hitherto semi-arid regions of Saurashtra and Kutch are recording excessive rains.

This year, the arrival of the monsoon took place simultaneously in south Gujarat and coastal Saurashtra. Asked to ‘trim’ his beard, Kashmiri doctor loses seat at Coimbatore hospital

**Hyderabad.** A Kashmiri doctor – Zubair Ahmed – has accused Kovai Medical Centre and Hospital located in Coimbatore of forcing him to “quit his super speciality seat”. The doctor, who was allotted a seat at the nephrology department of the hospital after he cleared the NEET-SS was allegedly told by the hospital administration that he will have to either shave or trim his beard if he were to take admission.

The doctor who had grown his beard for religious reasons refused the same, even as he agreed to abide by the hygiene requirements of the hospital including wearing a mask to “hide his beard”.

He decided to forgo the seat at the hospital, because the administration was refusing to budge. “They clearly told him to shave or trim his beard or not take admission at all,” a source at the hospital told the Indian Express.

When contacted the hospital administration clarified, “We have not denied admission to anyone. We were allotted the candidate and

we have to take admissions based on their rank given by the National Board of Examinations in Medical Sciences”. The hospital administration asked Dr Ahmed to “merely trim his beard”, the hospital clarified. “He was wearing a beard which reached his chest and



we wanted him to trim it because in the nephrology department which he was planning to join he will be dealing with several patients whose immunity is low. Personal hygiene in such cases is absolutely important,” a spokesperson of the hospital told the Indian Express.According to sources at the hospital, Dr Ahmed had written to NBEMS “accusing the hospital of discrimination”.

Karnataka tiger deaths: Forest Minister Eshwar Khandre warns of strict action against officials if negligence is proven

**Bengaluru.** Karnataka Forest Minister Eshwar Khandre Friday said that strict action would be taken against suspects responsible for the deaths of five tigers at Male Mahadeshwara Hills in Chamarajanagar district.Speaking to reporters after visiting the forest where a tigress and her four cubs were found dead in a case of suspected poisoning, Khandre said that the suspects had even attempted to burn the carcasses.“Officials and experts who have arrived for the investigation have expressed suspicion that the tigers died due to poisoning. This is a crime, and strict action will be taken against those responsible for this heinous act,” the forest minister said.“The state is ranked second in the number of tigers because the state government has taken all necessary steps for wildlife conservation. But the death of five tigers in a single day is a very painful and

heartbreaking incident. This incident has caused great pain,” he added.

Referring to the high-level investigation ordered by him into the tiger deaths on Thursday, the minister said. “The order has been given. Representatives of the National Tiger Conservation Authority (NTCA) have also arrived here. Wildlife experts and witnesses have also arrived. The post-mortem examination has been conducted as per the rules and the bodies have been cremated.”

Khandre further said that “there are reports that the outsourced frontline forest staff were not being paid on time. This will also be investigated and action will be taken to pay the frontline staff on time.”The minister warned that action will be taken against forest department officials if the investigation were to reveal negligence on their part.

The tiger deaths were discovered by forest patrol staff during routine monitoring of the reserve forest area. Initial investigations suggested that the big cats died from consuming meat laced with toxic

substances.The forest minister has directed the principal chief conservator of forests to conduct a thorough inquiry soon after the tigers were found dead and asked him to submit the report within three days.





J P Nadda: BJP president with nine lives

As the world’s largest political party contesting serial elections, notching more hits than misses and running governments at the Centre and 14 states, the BJP is known to be a stickler for organisational propriety and discipline. It’s no mean achievement considering that the exercise of executive and legislative power alters the dynamics within a party for the worse.

In the long years when the BJP was in the opposition, it scrupulously adhered to its own Constitution—as distinct from the Indian Constitution—particularly when confronted with imbroglios involving the leadership. The veto power lay with the extended family’s head, the Rashtriya Swayamsevak Sangh, that had the last word and sometimes shot down the BJP’s proposals and decisions to party leaders’ discomfiture. The RSS’s assertions were manifest after the BJP was seated at the Centre and some states. Competing pulls and pressures became inevitable as the playing field grew larger and the stakes for BJP leaders bidding for absolute power became apparent.In 1991, when L K Advani became the opposition leader in the Lok Sabha, without a fuss he relinquished the BJP presidency for Murli Manohar Joshi. The import of this act gets amplified when in 2005, he scripted encomiums for Muhammad Ali Jinnah during a visit to Jinnah’s mausoleum in Karachi.

Following the first outcry of protest from Gujarat, where Prime Minister Narendra Modi was the chief minister and in the thick of fighting local body polls, Advani was pressured by the BJP and RSS’s sarsanghchalak K S Sudarshan to quit office as the BJP chief. But ringed by a cabal of new friends and advisers who advocated the merits of converting to secularism, Advani fought back for a while and eventually gave up office. If the BJP and Advani had still not become the forces they were by then despite the BJP losing the 2004 election, the view was he would have acquiesced.

Notwithstanding the skirmishes in BJP-ruled states—most notably between two factions in Gujarat, of which one was aided by Modi, then a state general secretary—the party made it a point to hold organisational polls from the lowest tier every three years. Rivalries often surfaced at the mandal and district tiers, but these were quelled to allow the process of appointing a new president to go on. So far in its history, the top post was never contested in the BJP, unlike the Congress which held polls twice to elect its president. It was either the RSS’s writ that prevailed, pre-empting the inevitability of a contest that would have undermined the Sangh’s own authority or the parivar’s unified purpose to reach the commanding heights which disallowed disruptions in an all-important quest for absolute power.The current incumbent, J P Nadda, leads a charmed life. The soft-spoken and amenable party president—who has no choice but to lie low in the highly centralised power structure run by the Modi-Shah duopoly—is nearly at the end of a five-year term. It’s a record in a party whose Constitution stipulates two terms of three years each to a president. He stepped into the post once Amit Shah demitted office in 2019 on becoming a central minister.Nadda hangs on to the post even after his induction in the Union cabinet, which was believed to be the first sign that a successor was being readied. His continuance has virtually put to rest the ‘one person, one post’ principle. But who cares for the party’s Constitution any longer? When an old-timer timorously brought up the subject of not adhering to the book at an internal meet, he was told that the Constitution existed because of the party and not the other way—so there was no need to obsess over its importance.

Where is the much-awaited successor? A plethora of names are bandied about periodically. But like the cat with nine lives, each time the succession chatter gains momentum, Nadda manages to survive. He was seldom embroiled in a controversy like his role model, former party president Kushabhau Thakre, who served during Atal Bihari Vajpayee’s prime ministerial tenure.

Public faith in judiciary at stake

The higher judiciary serves as a bulwark against injustice. If the judiciary hesitates to step in to restore people’s faith in a just order, we as a nation stand doomed.

A three-member committee comprising two Chief Justices of high courts and a judge of a third high court, selected by then Chief Justice of India (CJI) Justice Sanjiv Khanna, examined more than 60 witnesses and inspected the residential premises. The panel concluded that Justice Varma could not explain satisfactorily the presence of sacks ofRs 500 notes, some of them damaged by the fire. The committee recommended impeachment proceedings against the judge as this was the course prescribed in the Constitution for the dismissal of a Supreme Court (SC) or high court judge.The CJI and the SC’s Collegium of senior judges recommended Justice Varma’s transfer back to the Allahabad High Court, his parent HC, in March itself. The CJI had instructed the Chief Justice of the Delhi High Court not to allot judicial work to Justice Varma while he was in the Capital.The CJI at that time had an onerous duty to perform. He was well aware that public trust in the integrity of the higher judiciary had to be salvaged. At the same time, no scope should be left for people to think that the judiciary at the highest level was involved in any form of cover-up of a recalcitrant brother judge. In my opinion, the CJI passed the test with distinction. He opted for transparency, a route rarely favoured by government agencies under attack.

The judiciary and the armed forces of the country are the only two institutions left which people still respect. All others, including the media to a great extent, have fallen by the wayside. If these holdouts are politicised or weakened by corruption, the present system of governance would slip into full-fledged dictatorship.

The higher judiciary serves as a bulwark against injustice. When winning elections at any cost becomes more important than ensuring good governance by upholding the rule of law, instances of injustice are bound to increase. If the judiciary hesitates to step in to restore people’s faith in a just order, we as a nation stand doomed!Corruption in the judiciary is becoming a problem. The CJI and other senior judges should sit up and take notice. As corruption in society increases, as it is happening today, leaders from all walks of life should ponder over measures to combat the disease. Prime Minister Narendra Modi used to say that he would not touch tainted money and also not allow those under his watch to do so.It is to be noted that he has not been repeating this boast nowadays. Corruption in public life goes on as merrily as before. Even his party, which was voted to power in 2014 as it swore to end corruption, has not bucked the trend. Having completed 11 years in power, Modi’s party is absorbing in its ranks assorted Congressmen, Shiv Sainiks and others who had been named and even prosecuted by his government for big-time corruption. An English term, “washing machine”,



has entered common parlance in Mumbai. Former Cabinet Secretary BG Deshmukh was a good friend of mine. He and I, along with Dr Raj Kumar Anand, a leading paediatrician of Mumbai, formed the Public Concern for Governance Trust (PCGT). The Trust concentrates on college and school students, trying to make them good citizens by imbibing good values. We felt that this was the only way concerned citizens like us could contribute to fight corruption.A girl who served on the staff of our NGO competed for a First-Class Judicial Magistrate’s appointment in Maharashtra. She was selected. Having worked with our NGO, where she herself was involved in spreading noble values among the youth, we are confident that there will be at least this one dispenser of justice to perform her dharma, as the Gita expects every good human to do without any expectation of a reward. The PCGT’s trustees will follow her career with much interest.Reverting to Justice Varma’s case, some previous impeachment proceedings went in vain. This may not happen this time round as the BJP has taken the correct stand, supporting the findings of the three-member committee which passed muster with the

collegium of five senior judges of the Supreme Court. Opposition parties cannot afford to vote against this motion.

In a court of law, it might have been more difficult, though not impossible, to sustain the charges. The main omission of counting the burnt and unburnt notes could come to the rescue of the accused. The leading legal luminary who has taken the judge’s brief will certainly play up this defect in the prosecution case.The firemen and the security detail who were the first responders talked of sacks of currency notes and burnt notes scattered on the ground. If a HC judge was not involved, the panchnama would have been drawn up. It would have sealed the culprit’s fate. But the imperative of informing the CJI and getting his consent at each stage threw up impediments to the normal procedure. Three judges of repute have concluded that sacks of money were seen by the first responders but were removed by Justice Varma’s personal staff before the Delhi High Court officials could arrive at the scene. The then CJI’s decision to hide nothing from the public and keep it informed at all stages has helped to build public trust in the higher judiciary, but there is a long road ahead.

Develop a robust aviation maintenance ecosystem in India

The recent Air India crash, whose causes are still being investigated, casts a harsh light on an issue critical for aviation safety—the country’s maintenance, repair and overhaul (MRO) ecosystem. It’s not merely about fixing aircraft, but having a well-regulated backbone to ensure that every plane taking off is fit to do so. MRO is not an option; it’s a critical pillar of aviation safety. However, the sector is in a nascent stage in India even after years of regulatory efforts to establish an ecosystem. The crash and the frequent flight cancellations due to technical glitches should be seen as a warning for the government to address the challenges the sector faces and clear the hurdles to its development.The Directorate General of Civil Aviation (DGCA)—the body that oversees aviation safety and enforces MRO standards in the country—faces its own share of challenges. A Parliamentary Standing Committee report tabled just days before the Air India incident highlighted that the DGCA is facing a staggering 53 percent vacancy. How can the country’s primary safety regulator effectively



audit MRO providers, ensure compliance with complex civil aviation requirements and oversee a rapidly expanding sector—reflected in the number of airports growing from 74 to 220—with over half its sanctioned posts vacant? Similarly high levels of vacancy plague the Bureau of Civil Aviation Security, which is responsible

for security, and the Aircraft Accident Investigation Bureau. All this adds up to a systemic oversight deficit in the country.The domestic MRO sector is hobbled by some inherent deficiencies. A Niti Aayog report has highlighted manufacturing monopolies that restrict access to vital data and manuals, inadequate infrastructure such as modern hangars and specialised training facilities, and a lack of universal recognition for DGCA’s certifications, which severely hinders India’s ability to undertake high-value MRO work. While policy adjustments like GST reduction are welcome steps, they alone cannot address the foundational issues hampering the sector’s growth and efficacy. The safety of the millions flying every day rests squarely on ensuring the regulator tasked with overseeing it has the resources to perform its job. The recent crash unequivocally underscores this. Building a robust MRO infrastructure and filling critical regulatory vacancies are not avoidable expenses—they are essential investments needed to save lives.

Family values: Court affirms Tamil Nadu’s inclusive gender traditions

Madras High Court’s ruling that same-sex couples can form a family is a testament to Tamil Nadu’s progressive legacy rooted in Indic traditions, activism and legal reforms. The state has led in establishing significant milestones for LGBTQIA+ rights in the country

In a landmark ruling delivered earlier this month, the Madras High Court affirmed that same-sex couples can form families without legal marriage. It marked a major milestone for LGBTQIA+ rights in India, particularly in Tamil Nadu. Emerging from a habeas corpus petition, the ruling addressed the case of a 25-year-old lesbian woman detained by her natal family. Her partner sought her release so that they could live together. While securing her freedom, Justices G R Swaminathan and V Lakshminarayanan expanded the definition of family under Indian law, emphasising personal autonomy and right to self-determination.

It comes decades after the 2002 suicide of two lesbian women in Erode’s Satyamangalam forest after facing societal rejection of their relationship. Despite this, the 2025 verdict builds on Tamil Nadu’s progressive legacy rooted in both legal reforms and Indic traditions fostering wider acceptance of diverse identities. The verdict signals progress while recognising the concept of a “chosen family” under Article 21 of the Constitution, which guarantees life and personal liberty. The court’s assertion that “marriage is not the sole mode to found a family” validates non-traditional relationships and offers hope where despair once prevailed.Despite a section of society refusing to accept gender-diverse communities, every May to July, vast numbers of indigenous gender-variant and diverse SOGIESC (sexual orientation, gender identity, expression, and sex characteristics) communities in south India honour their patron deities at temples such as those for Koothandavar Aravan in Tamil Nadu, and for Ellamma, Bhagavati and Mariamman across the

region. These communities enact gender-specific Hindu rituals, which have historically provided sacred spaces for early LGBTQIA+ activism. This cultural acceptance, though not universal, has helped shape a more inclusive societal framework and complemented the legal efforts.

The court’s legal reasoning in the latest case was meticulous. The detainee confirmed her lesbian identity and desire to live with her partner, exposing familial coercion. The judges, referencing the Supreme Court’s 2023 ruling in the Supriyo @ Supriya Chakraborty case, noted while same-sex marriage remains unrecognised, same-sex couples can still form families. The court criticised police inaction and directed law enforcement to protect the couple, reinforcing the judiciary’s role in safeguarding individual rights against societal and familial pressures

Tamil Nadu’s history of activism and legal milestones has been crucial in reaching this point. In 1994, former Chief Election Commissioner T N Seshan granted voting rights to transgender individuals, setting a precedent for inclusion. In 2004, advocate G R Swaminathan, now a judge, secured voter identity cards for transgender people, prompting the state to publicise their voting rights. By 2006, a government order aimed to improve transgender living conditions, promoting counseling to prevent disownment and ensure educational access.

In 2008, Tamil Nadu established a transgender welfare board, and in the early 2000s, it introduced one of India’s first transgender welfare policies, offering free gender-affirming surgeries and socio-economic benefits. Asia’s first Genderqueer Pride

Parade and Education Fest for school children and college students were organised in 2012. Anjali Gopalan of Naz Foundation flagged off the event in Madurai. In 2019, the Madurai bench of the Madras High Court led by Justice Swaminathan banned forced sex-selective surgeries on intersex infants, making Tamil Nadu the first state to do so. It also



became the first to recognise and register marriages of transgender and intersex persons under the Hindu Marriage Law, amend police guidelines to prevent harassment of the LGBTQIA+ community, ban conversion therapy, and include LGBTQIA+ issues in curriculums in 2017.

Organisations like Srishthi Madurai and Orinam Collective have supported these efforts through legal petitions, providing shelters, funds and organising workshops, pride parades, embedding queer rights within Tamil Nadu’s cultural and legal fabric. Today, the Tamil has native terminologies for diverse SOGIESC identities, which is missing in many Indian languages.

Festivals and rituals at temples like Koothandavar

Aravan, where gender-diverse individuals are celebrated, has provided a foundation for LGBTQIA activism. These sacred spaces, where GIESC communities perform rituals honoring deities associated with fluid gender identities, have historically challenged societal norms, fostering a sense of belonging and resistance against discrimination. This cultural acceptance, though not without resistance, has been a catalyst for legal victories, like the latest ruling, which resonates with the communal spirit of these traditions.

Despite these advancements, challenges persist. The 2002 suicide underscores the personal struggles behind legal battles. Activists say societal acceptance often lags behind legal progress, with financial hardships and exclusion remaining prevalent.The latest verdict complements rulings by former Chief Justice D Y Chandrachud and Justice Venkatesh of Madras High Court, creating an ecosystem where personal identity and relational freedom are upheld as matters of dignity and public interest, the ruling has sparked broader discourse on queer rights, inviting debate on legal recognition of diverse family structures. It signals a future where all, regardless of sexual orientation, can live with integrity and autonomy.

The ruling is a testament to the enduring power of activism Activists are continuing to push for comprehensive legal recognition, including same-sex marriage, and cultural acceptance to address ongoing discrimination. Building on decades of progress, the latest judgement ensures that love in all its forms is protected, offering a path towards an inclusive future where past tragedies are not repeated.



# Ammonium sulfate contributes to one-third of Faridabad's PM2.5 pollution

**Gurgaon.** Ammonium sulfate is responsible for a staggering one-third of Faridabad's PM2.5 concentration, according to a study by the Centre for Research on Energy and Clean Air (CREA), which underlined the need for National Clean Air Programme (NCAP) to take a closer look at the secondary pollutant. Ammonium sulfate forms insidiously in the atmosphere through chemical reactions between sulfur dioxide (SO2) and ammonia (NH3). CREA's analysis reveals that this pollutant, averaging 19.76 µg/m³ out of a total PM2.5 level of 58.28 µg/m³ of Faridabad mean data, is prevalent across nearly all NCAP cities, irrespective of their proximity to major emission sources, therefore showing the need for a unified national strategy. NCAP primarily targets PM10. However, PM2.5 poses great danger to human health, its smaller size allowing it to penetrate deep into the lungs and enter the bloodstream. The health impacts are severe, ranging from increased risk of premature death,

nonfatal heart attacks, irregular heartbeat, aggravated asthma, decreased lung function, and even lung cancer. Faridabad's designation as the sole 'non-attainment' city in Haryana under the NCAP highlights its consistent failure to meet National Ambient Air Quality Standards (NAAQS). These precursor gases are commonly spewed from coal-fired thermal power plants, agricultural fertiliser use and livestock waste — sources that often extend far beyond city limits. The new study further highlights the complex challenges cities are facing. The transboundary nature of ammonium sulfate pollution means that local emission controls, while necessary, are insufficient on their own. A comprehensive, national approach is imperative to tackle this pervasive and deadly component of India's air pollution crisis, ensuring cleaner air for all its citizens. "To make real progress, NCAP must evolve to include targeted measures for reducing secondary pollutants," said Manoj Kumar, an analyst at CREA,

adding that city and state-level clean air action plans must explicitly tackle major sources of precursor gases. Kumar also emphasised the importance of source-specific strategies, such as installing flue-gas desulfurisation units in coal-fired power plants to reduce sulfur dioxide (SO2) emissions, promoting efficient fertiliser management to curb ammonia release and ensuring strict compliance with existing emission norms across all polluting sectors. The study serves as a wake-up call for policymakers to recalibrate India's clean air strategy, shifting focus from just visible dust to invisible but deadly chemical reactions that are silently poisoning the air. "In addition to ammonium sulfate, other secondary pollutants like ammonium nitrate also contribute significantly to PM2.5 mass. In fact, secondary particles can account for up to 50% of total PM2.5 mass, according to an IIT study which triggered our analysis. The IIT study found that even beyond 200km of a thermal plant, sulfate concentrations were

found," he added. Experts also pointed out that the air pollution crisis in cities like Faridabad might not improve until the govt takes all parameters into account. "The dominance of ammonium sulfate in Faridabad's PM2.5 profile is a stark reminder that India's air pollution crisis is no longer just about visible smoke or dust. It's about invisible chemical transformations driven by coal and fertiliser emissions. Without a strategic shift to tackle secondary pollutants and precursor gases, cities like Faridabad will continue to choke under a haze that knows no boundaries," said Shubhanshi Tiwari, a research associate at Centre for Science and Environment (CSE). "We recognise the growing complexity of air pollution in Faridabad, especially the role of secondary pollutants like ammonium sulfate. We are factoring in results of the recent source apportionment study to expand our monitoring network to better understand and tackle these emerging challenges," said an HSPCB official.

## Insurance scam busted, 7 held in Ghaziabad

Ghaziabad: Seven persons were arrested on Friday for operating a fake insurance policy racket that targeted over 1,500 people nationwide. Two suspects, former employees of a Noida call centre, allegedly stole customer data and contacted victims with fake promotional offers. The group created counterfeit receipts using specialised software after receiving payments from victims. They opened their office in a car and earned approximately Rs 4.5 crores through the fraud. Police identified the prime suspects as Aman Aggarwal (29) and Rahul Sharma (23). The five other accused were identified as Aftab Alam (25), Rahul Yadav (30), Deepak Singh (25), Garvit Tyagi (24) and Jagjit Singh (26). Alok Priyadarshi, additional CP of Ghaziabad, told TOI that Aman and Rahul worked at HAXR Company in Noida in 2021. This company was an authorised centre for various insurance policies from companies like Reliance, Bharti Hexa, Cigna TTK, HDFC, and Bajaj. "They provided the mule bank account details to victims and provided fake insurance documents to them. For contacting policyholders, they used pre-activated SIM cards with fake IDs provided by a person named Mukesh (absconding)," Alok said. The accused were booked by Cyber police station under the sections 3(5) (acts done by several people in furtherance of common intention), 318 (4) (cheating), 336 (3) and 338 (forgery), 340 (using forged documents) of BNS and Section 66 of the IT Act.

## A decade gone, GDA frees Rs 800cr land for Indirapuram Extension project

**Ghaziabad.** Ghaziabad Development Authority (GDA) recently freed 10 hectares of its land worth Rs 800 crore in Kanawani in Indirapuram. The land parcel was encroached upon for more than 10 years, where illegal shanties and hutments came up. A GDA official said the land parcel will be clubbed with the Indirapuram Extension scheme — covering an area of 34 hectares — where the development authority is planning a new township. "Last week, GDA carried out a major anti-encroachment drive in Kanawani in Indirapuram, in which the land was reclaimed. Now the development authority has started erecting pillars and the area has been fenced to secure it," the official said. The official said GDA now plans a request for proposal for the said land parcel and a detailed project report will be made. The Indirapuram Extension scheme was launched in 2004, involving about 92 hectares of land in Mahiuddinpur Kanawani village, for which compensation to farmers was given at the rate of Rs 1100/sqm. In 2005, about 225 farmers who owned 35 hectares of land got a stay from Allahabad high court over enhanced compensation, as a result of which GDA was not able to take the parcel of land into its possession, and since then, the project has remained in a state of limbo. The matter got further compounded in 2014 when the Land Acquisition Act 2014 came into force, which decreed that landowners be given compensation four times the market value. The project became financially untenable for GDA due to the new land acquisition law, so in 2019, GDA wrote to the state govt seeking to de-notify the remaining 35 hectares of land. But GDA, on 20 May 2022, received a shot in its arm in the form of a Supreme Court order involving the Ayodhya Development Authority. The case was similar with respect to GDA's Indirapuram Extension housing scheme. The court, in its May 2022 order, said that any issue pertaining to land compensation that was initiated before the Land Acquisition Act 2014 came into existence should be dealt with the land rates prevailing prior to 2014, irrespective of the fact whether the land could be acquired or not.

## Soiled clothes, tied hands, inmates locked in rooms: Shocker at Noida old-age home

**Noida.** Clothes stained with excreta, soiled bedspreads, several inmates with hands or feet tied, and some without clothes. At least 40 men and women — most in their 70s and 80s, left there by their families — have been living in inhuman conditions in the squalid interiors of a privately run old-age home, a surprise inspection on Thursday night by the UP women's commission found. Running out of Sector 55 since 1989, Anand Niketan Vridh Sewa Ashram is among the city's oldest facilities for the elderly and is operated by a trust. Officials said the home did not have qualified care staff, nor any facilities for timely medical aid, and was run by a handful of caretakers. Women's commission member Meenakshi Bharala told TOI on Friday she decided to visit the old age home after a video of a woman sitting on the floor of the old age home with her hands tied was brought to her notice. "The video was also sent to mahila ayog in Lucknow," said Bharala, who was accompanied by ADCP Manisha and officers from the social welfare and probation departments during the inspection. "When we reached, we asked about the woman in the video and were directed to her room. She was lying on a bed that had just a bare mattress. She was clad in dirty clothes and was reeking. She could not even speak to us. The people there told us they had done so because the woman misbehaved," Bharala said. Other inmates also said they were tied up and kept confined to rooms, she added. A man found sitting in just his shorts was asked where his clothes were. He told the inspection team that he was never given any. The woman in the video is a 69-year-old originally from Kerala. She apparently used to be a Reiki healer. TOI is withholding her name to protect her privacy. A prescription with her suggested dated June 4, 2025 showed she was consulting a doctor at a private hospital in Noida. No one from her family had turned up at the centre on Friday. She was among three inmates at Anand Niketan who were shifted to a govt shelter in Dankaur. "We checked the premises and found how they were mistreated, mostly kept in dirty rooms and unsanitary conditions with just a mattress. The staff there told us the inmates would hit them and throw soiled clothes at them."

## RRTS deadlock holds up new metro line's Cyber City station in Gurgaon

**Gurgaon.** Uncertainty over the exact location of the proposed rapid rail (RRTS) station at Cyber City has derailed integrated planning for the Gurgaon Metro project. The Gurgaon Metro station at Cyber City is to be integrated with RRTS and the existing Rapid Metro network. NCR Transport Corporation, which is building rapid rail, initially planned to construct the RRTS station on the green belt along the expressway near Shankar Chowk. But the industrial authority has shown reluctance in handing over the land, citing concerns over congestion, sources said. The Gurgaon Metro station at Cyber City will be constructed under Phase 2 of the project. GMRL invited bids for geotechnical investigation on the 16km section of Phase 2 between Sector 9 and Cyber City last month. But with the RRTS stations caught in a bind, the location of Gurgaon Metro's station at Cyber City has not been decided. A senior GMRL official told TOI, "Since NCRTC has not frozen its station location, we are unable to finalise ours for Cyber City either. This is a key interchange. Planning for integration between the three systems — RRTS, Gurgaon Metro and Rapid Metro — is affected." NCRTC told TOI on Friday the location of the station at Shankar Chowk is "currently being discussed" in consultation with all key stakeholders. "We are confident that a common ground will be reached soon through mutual understanding," the NCRTC CPRO said. In Feb, senior officials from NCRTC, GMRL and HSIIDC visited Shankar Chowk to explore options for creating an integrated transport hub. The idea was to allow seamless passenger transfers between RRTS, the new metro corridor from Millennium City Centre to Cyber City and the existing Rapid Metro. Originally approved by Haryana govt in 2019, the alignment of the RRTS corridor, which followed the Old Delhi-Gurgaon Road, was revised in Aug 2023 to run along NH8. This realignment prompted GMRL to shift its metro route from the initial Rao Gajraj Singh Marg to an alternate alignment via Old Delhi-Gurgaon Road and Shankar Chowk Road.

## Cop's daughter dies by suicide, family alleges pressure from school principal in Gurgaon



**Gurgaon.** A Class IX student allegedly died by suicide at her residence in Police Lines in Faridabad on Thursday morning. The family of the girl — whose mother is a police officer — has alleged she was under pressure from the school principal over "non-performance" in classes. The girl studied at a public school located in the same area in Sector 30. The family has alleged that the girl, who was under "immense mental stress" took the extreme step by hanging herself. According to her parents, the girl was being "mentally harassed" by the school principal, particularly after she failed in three subjects in Class 9. The principal reportedly told her she would have to repeat Class 9. Police spokesperson Yashpal said, "We have received a formal complaint from the family, naming the school principal and a math teacher." A

case has been registered under Section 194 of BNSS. Attempts to contact the school principal for comments were unsuccessful, as she did not respond to phone calls. The mother of the deceased is an assistant sub-inspector in Faridabad Police and is posted at Palla police station. Police said the parents approached the principal to discuss the issue. "The principal refused to listen. The girl pleaded she would work harder and clear her exams this year, but

her appeals were ignored," the complaint said. Police said the incident took place after the 14-year-old girl returned home from school after performing a unit test when parents were at work. Her father Naresh went home to have lunch and asked one of his daughters about her sister. She told him she was in her room studying. When the father tried to enter the room, he found it locked. He broke the door and found the girl hanging from the ceiling fan. The family, originally from Khanpur village in Hisar, has been living in Faridabad for several years. The girl's father works in a private company in Faridabad and her two younger sisters also study in the same school. The police spokesperson said the body was handed over to the family after a post-mortem. She was an accomplished kho-kho player.

## Man cured of rare facial pain with advanced radiosurgery in Gurgaon



**Gurgaon.** For this 41-year-old native of Ashgabat, Turkmenistan, life became a daily battle against invisible torment. For over a year, he endured sudden, electric shock-like pain on the right side of his face — pain so intense and unpredictable that even brushing his teeth or speaking could trigger a storm of agony. He was suffering from Trigeminal Neuralgia (TN) — a condition so cruel, it is often called the "suicide disease." Trigeminal Neuralgia affects only about 4 to 13 people per 100,000 annually, making it an uncommon neurological disorder. It strikes without warning, causing recurrent facial pain that can last for seconds or minutes, and repeat dozens of times a day. In most cases, the right side of the face is affected. The condition is more prevalent in women and people over 50, though it can occur at any age, even in children, though extremely rarely. To treat the patient, the medical team at Medanta

chose CyberKnife radiosurgery — a non-invasive, high-precision treatment — that uses focused radiation to target the affected nerve without harming surrounding brain tissue. Within 48 hours of the surgery, the patient reported a reduction in pain. A month has passed since, and he lives on with minimal medication. "It is a rare disease and patients suffering from it face severe headaches, inability to swallow even

water, and spasms. The pain is intermittent. It can happen to anyone. After CyberKnife radiosurgery, which helps 60-90% patients, they may not feel any pain for 5 to 8 years. Earlier, just 50% of the patients used to get temporary relief after surgery," said Dr Tejinder Kataria, chairperson, radiation oncology, cancer care, Medanta. Explaining the disease, she said, "The trigeminal nerve, also known as the fifth cranial nerve, is one of the 12 pairs of cranial nerves and plays a vital role in facial sensation and motor functions like chewing. In cases of trigeminal neuralgia, a blood vessel — often an artery — compresses the nerve root near the brainstem, leading to localized, electric shock-like pain. This neurovascular conflict disrupts normal nerve signalling," she said. "Trigeminal neuralgia is primarily diagnosed through a patient's description of pain and its triggers."

## Sudden scanner on old age home in Noida reveals harsh realities of twilight years

**Noida.** His voice is feeble, his gait unsteady. But instead of love, care and support from family, what 80-year-old MG Singh (name changed) has found himself in is an alien, inhospitable environment, a locked room, and biting loneliness. Singh feels like he is a prisoner. But without a house where he is welcome to live, he has lived within the confines of this 'prison' for years. "I often feel dizzy. They give me biscuits and glucose and keep me locked in a room," Singh told TOI on Friday morning as govt officers scanned the premises after an inspection by the UP women's commission revealed a sordid state of affairs at the privately run home.

"When I first came here, they used to give eggs and butter. Now they don't give such things. That has caused my dizziness and made me weak," he added.

Singh, who prefixed a 'Dr' to his name and identified himself as a former general practitioner at a medical college in Gujarat, was taken away by his niece, who is based in Gurgaon. "They cannot uproot somebody from their home where they're staying without letting



their local guardian know," the niece told TOI. "He was throwing water on electric equipment. He once set this old-age home on fire. I thank the home for keeping him here," she said.

Staff at the centre didn't deny using restraints, saying he sometimes tried to set things on fire. A caretaker of the home said inmates were tied "on instructions from their family

members". Several of the inmates have mental health conditions that require regular medical supervision and support. But at Anand Niketan, there's none. The centre is run by 10 severely underpaid caretakers, five each in the morning and evening shifts. They have no medical training. Some of them have only completed school. But not every inmate was complaining, perhaps

because the reality beyond the perimeters of Anand Niketan was more daunting. "We are fine here. We get food on time. In fact, I haven't been able to sleep because of all this chaos since Thursday night," an elderly woman told this correspondent, clearly cross with questions about her wellbeing.

A woman from Kerala was among the three inmates who were moved out of Anand Niketan to a govt shelter in Dankaur because of failing health. She could give no information about herself other than her name. Her prescriptions from a private hospital in Noida revealed her full name and age (69). The prescription mentioned hyperthyroidism and said she is prone to delusions. An octogenarian inmate who was shifted out could not communicate with anyone because he cannot hear.

A caretaker told TOI they were instructed to restrain the inmates as it was "the only option to keep them sane" because of the mental health problems they have. "If we didn't do this, things would get out of hand," the caretakers said, admitting the old age home is crippled by severe understaffing. "We work 12-hour shifts, seven days a week, earning just Rs 6,000 monthly," said the caretaker.



# In first meeting of MCD’s Standing Committee, 25 proposals get nod

**The delay caused due to a tussle between AAP and BJP had ended with the appointment of BJP councillor Satya Sharma as chairperson on June 12**

Poor sanitation, dog menace, monsoon preparedness, and status of desilting were among the few issues discussed on Friday at the first meeting of the Municipal Corporation of Delhi’s (MCD) Standing Committee, a body set up after a delay of two-and-a-half years. The delay caused due to a tussle between AAP and BJP had ended with the appointment of BJP councillor Satya Sharma as chairperson on June 12. Every project worth over Rs 5 crore needs to be passed by this committee. At the meeting on Friday, Sharma announced that the deadline for availing a 10% rebate on property tax has been extended till July 31. Over 25 items on the agenda were passed at the meeting, including the purchase of Diflubenzuron

25% WP, used to kill mosquito larvae in its initial stage. This is in line with the initiative taken up by MCD’s Public Health department to prevent and control of vector-borne diseases ahead of the monsoon. Also passed were items related to the revision of the layout plan of DDU Marg, as well as Delhi University colleges, including Shri Ram College of Commerce (SRCC) and St Stephen’s College. The proposal for SRCC included the construction of a new academic block and the addition of two floors for a girls’ hostel. The approval for this proposal had been pending since 2012. For St Stephen’s College, the approved proposal included the addition of a new academic block, a hostel



block, staff quarters, and an auditorium block. A proposal in this regard had been pending for the last 10 years. The meeting also approved the extension of contract for private security services, sanitation workers, and housekeeping staff at MCD-run hospitals such as Kasturba Hospital, Rajan Babu Institute of Pulmonary Medicine and Tuberculosis and Maharishi Valmiki Infectious Diseases

Hospital. Leader of Opposition, AAP councillor Ankush Narang, meanwhile, raised the issue of poor sanitation in Central, West, and South zones, questioning the budget sanctioned to each councillor. At the meeting, councillors sought status and data on drains desilts ahead of monsoon, open drains, JJ Colony clusters, encroachments, illegal parking, and vacant posts of sanitation workers, among others. A civic body official said, “Authorities have hastened the process of desilting. Till now, 1.56 lakh metric tonne of silt has been removed, while 37,000 small drains have been desilted against the 40,000 target.”

## Delhi BJP chief accuses ILBS of labour & PF law violations

Delhi BJP president Virendra Sachdeva has written to Central Provident Fund Commissioner Ramesh Krishnamurti alleging serious violations of labour laws and provident fund regulations at the Institute of Liver and Biliary Sciences (ILBS), an autonomous institution under the Delhi government. In a letter dated May 15, Sachdeva alleged that the employer’s contribution towards provident fund (PF) at the super-speciality hospital for liver and biliary diseases is reportedly limited to only 8% of the employees’ salaries, in contravention of the statutory requirement of 12%. He alleged that an equivalent amount is deducted from employees’ salaries. When asked, ILBS Director Dr S K Sarin said, “So far, I have not received any complaint from anyone.” Sarin further

said that he will look into the details as soon as he receives any official intimation. In his letter, Sachdeva wrote, “The specific issue relates to PF

Organisation (EPFO) are shown to be lower than the actual amounts, thereby misrepresenting the contribution as compliant,” he added. This manipulation not only violates the Employees’ Provident Fund and Miscellaneous Provisions Act, 1952, but also undermines the financial security of the employees, he further said. “Moreover, it is alleged that these actions are taking place with the full knowledge and complicity of senior officials at the institute. Employees, most of whom are on contractual appointments, reportedly refrain from raising these issues formally due to fear of termination and other reprisals. I am also informed that these irregularities have been going on for a few years now and largely unchecked,” he said in his complaint. Despite attempts, Sachdeva could not be contacted for a response.



## Faridabad murder: Police await post-mortem report to confirm rape by victim’s father-in-law

**Agency Faridabad.**

The Faridabad police, probing the murder of a 25-year-old woman, whose decomposed body was found buried in a pit, is awaiting the post-mortem report to confirm the rape confession of the victim’s father-in-law, who allegedly strangled her in April. The Crime Branch-DLF, Haryana Police, have added rape charges against the father-in-law, who was arrested on June 20, the same day the woman’s body was recovered outside his house in Faridabad. A police officer told while the accused had stated during interrogation that he had allegedly raped the deceased, before the murder, they are awaiting the medical and post-mortem reports of the deceased are still awaited. “He did not tell the family about the (alleged) rape,” the officer said. Five days after the decomposed body was found beneath a concrete slab, the Crime Branch on June 25 arrested her mother-in-law in the case. The case was initially being probed as a dowry dispute. The father-in-law had allegedly confessed that the family had conspired to murder the daughter-in-law due to ongoing domestic disputes, including talks of divorce. According to the police, the father-in-law had allegedly revealed that he and his family had plotted the murder a week before the incident. On April 21, he allegedly sent his wife to her relatives in Uttar Pradesh. The same day, a pit was dug outside their house, the police had said. The victim was allegedly given sugarcane juice laced with sleeping pills by the father-in-law, and later that night, while she was unconscious, he strangled her with a dupatta. Her body was then buried in the pit with her husband’s assistance, the police said, adding that the family subsequently reported that she had gone missing to mislead people. The police had initially registered a missing case based on a complaint by the husband on April 25. While the husband is absconding, the role of the husband’s sister is under investigation. However, the police intensified the investigation following suspicions and complaints from the deceased’s father that her in-laws were involved in her disappearance.

## Minor boy, tailor stabbed to death in separate incidents in Delhi’s Rohini

**Agency New Delhi.**

Two people, including a 15-year-old boy, were stabbed to death in separate incidents which took place within a span of two hours in Rohini’s Aman Vihar area on Thursday evening, the Delhi Police said. According to the police, at 8.30 pm on Thursday, they received a call about two siblings being stabbed by a group of people in the Aman Vihar area, with one of them succumbing to the injuries. The deceased was identified as Praveen, 25, a tailor who had been living in Aman Vihar’s Balveer Nagar for the past two months. A police team rushed his brother Deepak to Sanjay Gandhi Hospital where he was reportedly in a critical condition. A police officer said Praveen and Deepak were on their way to buy vegetables on Thursday night when some assailants attacked Praveen with knives. Deepak intervened to save his brother, but was also stabbed by the attackers, who then fled. “Praveen had an altercation with some local residents earlier this month, and they were allegedly looking for revenge. The assailants have been identified and attempts are being made to nab them,” an officer said. Just two hours before the incident, at 6.30 pm, Aman Vihar police received another call about a 15-year-old boy being stabbed to death by boys in his neighbourhood. According to a senior police officer, the boys who attacked the Class 10 student had an argument with him and his friends at a park in Rohini’s Sector 20. “Three to four boys came to the park where the deceased was with his friends. The deceased got into an argument with the visiting boys, who then started beating him,” a police officer said. Four friends of the deceased then stepped in to help him, upon which the attackers took out knives and stabbed all five. The police rushed all five injured to Sanjay Gandhi Hospital, where the 15-year-old boy was declared dead. His friends are currently under treatment, the police added. No arrest was reported in connection with the stabbings till Friday night.

## This park in Delhi could soon be ‘pollution-free’. Here are the details

**The previous AAP Delhi government had explored various measures to control air pollution, including the installation of two smog towers at Connaught Place and Anand Vihar**

**Agency New Delhi.**

The Delhi government has an ambitious plan up its sleeve to turn the famed Nehru Park in the diplomatic enclave of Lutyens’ Delhi into a ‘pollution-free zone’ — by installing ‘modern air purifiers’ equipped with a unique system to capture and store polluting particles, said officials. According to Environment Minister Manjinder Singh Sirsa, the New Delhi Municipal Council (NDMC) first installed the air purifiers on a trial basis at four locations — Anand Vihar ISBT in 2023, Ambassador hotel in Khan Market, and New Moti Bagh in 2024, and Jangpura in January 2025 — which were successful. “The government is planning to extend this

initiative on a large-scale basis, starting with Nehru Park... The premises has a good green cover. But



when the air-quality level deteriorates overall, it also affects this space — even if the AQI is better than other locations. So, with these machines, we want to make this park pollution-free,” he said. Officials said the locations for

the trial run were selected based on whether they saw a large influx of vehicles or where pedestrian footfall was high. “For instance, Anand Vihar-ISBT sees buses passing through, it has a high footfall, and there is construction work going on. So, this spot was suggested by the Commission for Air Quality Management. In Jangpura, the machines were installed at a petrol pump, which also sees vehicles passing through. As for the two other locations, one is a residential area and the other a hotel. Thus, the key aim is to reduce harmful exposure to people in outdoor spaces that see a high footfall,” said an official.

## Delhi govt schools directed to set up Special Admission Cells for children out of school

**The cells have been tasked with ensuring smooth and time-bound admission of identified out-of-school children, including those with special needs, in Delhi.**

**Agency New Delhi.**

Delhi’s Samagra Shiksha Department has directed the heads of all government schools, including that of the Directorate of Education (DoE), Municipal Corporation of Delhi (MCD), New Delhi Municipal Council (NDMC) and the Delhi Cantonment Board (DCB), to set up Special Admission Cells (SAC) for children who were never enrolled. According to a circular issued on Thursday, the department aims to “strengthen and streamline the admission process of never-enrolled Out-of-School children (OOSC), including Children with Special Needs (CWSN)” as well as students who dropped out of the school system due to any reason. These cells need to comprise the school head, admission in-charge and an educational and vocational guidance counsellor (EVGC) or a representative of similar expertise from the management belonging to MCD, DCB or NDMC authorities. There also has to be a Cluster

Resource Centre Coordinator (CRCC) to give data to the cell. The SAC has been tasked with ensuring smooth and time-bound admission of identified out-of-school children, including Children with Special Needs. It is also expected to guide and counsel parents and children during the admission process. According to the circular, the SAC should ensure minimal documentation and coordinate with the school head and Special Training Centre (STC) teachers for enrolment support. Other responsibilities listed include: To monitor retention, attendance Follow up on absenteeism and academic progress of the admitted out-of-school children. These need to be done by maintaining their records. Review the progress of out-of-school children by holding periodic meetings



Coordinate with the Cluster Resource Centre Coordinator to update the Unified District Information System for Education (UDISE+) data from time to time Identify and address dropout cases Identify issues and counsel parents, resolve difficulties Ensure timely re-enrolment of affected children Prepare fortnightly reports on identified out-of-school children

The reports should include the admission status of the children, their attendance in schools and Special Training Centres, status of textbook supply, uniform, writing material, assessment status and mainstreaming plan, among others which should be provided to the Samagra Shiksha headquarters through district project offices. According to the department’s standard operating procedure for out-of-school children, their identification is done “to admit them in regular class/STC at the earliest.” They should be given admission in a regular government school immediately in the age-appropriate class where learning assessment of the child is done. This is to mainstream the child as after the assessment, the child may be recommended schooling in regular class or STC for a bridge course, as per the stage of learning.

## Delhi bans fuel for old vehicles from July 1: How will defaulters be tracked?



**Agency New Delhi.**

Starting July 1, Delhi will stop supplying fuel to all overage vehicles. As part of this effort, the Transport Department, the Traffic Police, and the Municipal Corporation of Delhi (MCD) will work together to identify hotspots that see a high number of such vehicles attempting to pass through the city. These vehicles will be identified by ANPR (Automatic Number Plate Recognition) cameras that have been installed at 498 fuel stations, officials said Friday. According to directions issued earlier this year by the Commission for Air Quality Management in NCR and Adjoining Areas (CAQM), all end-of-life vehicles (ELVs) — 10 years for diesel vehicles and 15 years for petrol ones — will be denied fuel starting Tuesday. From October 31, the plan comes into effect in five high-vehicle-density districts of Gurgaon, Faridabad, Ghaziabad, Gautam Buddha Nagar, and Sonipat. Niharika Rai, Secretary-Cum-Commissioner, Transport Department, said the number of ELVs arriving at a fuel station will be noted, as it could be a proxy for vehicle owners residing in nearby areas. Targeted action will be taken at such fuel stations, Rai said. “Joint teams of the transport department, traffic police and MCD will be deployed at all identified fuel stations reporting a high number of such vehicles.” Ajay Chaudhary, Special Commissioner (Traffic), Delhi Police, said, “The departments are still assessing how the teams should be deployed as a few fuel stations work around the clock, but others work for a few hours.” He emphasised that there will be no loopholes and the plan will be implemented stringently, as all staff at fuel stations have also been trained.

## Delhi: Man on scooter dies after throat slit by Chinese manjha

**Agency New Delhi.**

A 22-year-old man died after his throat was slit by a banned Chinese manjha — a sharp string used for flying kites — while he was riding his scooter near Bara Hindu Rao Hospital in North Delhi on Friday evening. Chinese manjha, which is coated with glass, metal, or other sharp materials, has been banned in the Capital since 2017. Police said the victim, Yash Goswami, a resident of Karawal Nagar, was on his way home when he came in contact with the sharp thread near the Rani Jhansi flyover. “Goswami suffered a deep cut on his neck, causing him to collapse on the spot. He was rushed to the hospital by passersby, where he was declared dead on arrival,” a police officer said. Goswami used to run an auto parts shop in Karol Bagh. He was alone at the time of the incident but was wearing a helmet, the officer added. Police said a case under Section 106(1) (causing death by negligence) of the BNS has been registered against unknown persons at Bara Hindu Rao police station. “The crime scene was inspected by the forensics team, and strands of Chinese manjha were recovered from the body as well as from the scooter,” another officer said. This is not the first incident of Chinese manja claiming lives in the Capital. In July 2023, in West Delhi’s Paschim Vihar, a seven-year-old girl lost her life after the thread slit her neck while she travelling with her parents on a scooter. Last year, in August, a 47-year-old Assistant Sub-Inspector (ASI) of the Delhi Traffic Police and a 34-year-old businessman were injured by the abrasive string in two separate but similar incidents in Northeast Delhi. Cracking down on the illegal stocking of Chinese manja, the Delhi Police Crime Branch had conducted a raid in Rohini in August 2024. During the raid, they recovered around 12,000 reels of illegal Chinese manja and arrested three people for stocking it.

Sensex ends 300 points higher, Nifty above 25,600; Jio Financial shares jump 4%

**New Delhi.** Benchmark indices closed higher for the fourth straight session on Thursday, buoyed by easing global concerns and renewed foreign inflows. The S&P BSE Sensex rose 303.03 points to end at 84,058.90, while the NSE Nifty50 gained 88.80 points, settling at 25,637.80. All broader market indices also finished in positive territory as volatility eased, bringing both key benchmarks within striking distance of new record highs.Vinod Nair, Head of Research at Geojit Financial Services, said recent global developments have lifted market sentiment.“Key catalysts like the ceasefire in the Middle East and optimism around easing trade tensions have cleared investor concerns. After several sessions of selling, FIIs have turned net buyers, which is helping stabilise the market,” he said. “Benign oil prices, a stronger rupee, and steady macroeconomic indicators are driving interest in domestic growth themes. Expectations of stronger earnings, supported by resilient consumption, are further boosting optimism.”

Pump and dump scam: Sebi says has raided many shell companies

**MUMBAI.** Markets watchdog Sebi has confirmed reports in a section of the media that it had carried out raids in multiple locations and on multiple shell companies for what it considers to be cases of pump and dump scams.“Sebi has conducted search and seizure operations at multiple locations in June in connection with pump and dump in certain scrips and has seized incriminating evidence,” Sebi said in a statement Friday, confirming various news reports regarding its raids in the pump and dump scam.“Further investigatio in the matter is under progress,” the regulator added in the statement without offering any more details such as the number of companies raised or the value of the alleged scam etc.Some section of the media has been reporting since last week that Sebi raided around two dozen shell companies involved in the Rs 300-crore pump and dump scheme across Ahmedabad, Mumbai and Gurugram. These raids are one of the biggest in Sebi’s history in terms of monetary value. The raids primarily involved 15-20 shell companies which were allegedly created by promoters of some listed companies to pump and dump their own shares. At least two listed agro-tech companies along with their promoters are said to be at the helm of the alleged network, sources had said.“Sebi has seized several documents including company documents, rubber stamps. Preliminary assessment suggests the scam was at least Rs 300 crore, however more details would emerge once the seized documents are analysed,” a source was quoted by one such report. Generally, in cases of pump and dump schemes, Sebi issues an order against the entities. In in very few cases, Sebi also uses its search and seizure powers against the entities like in the current case.The pump and dump scam works in the following manner: promoters create shell companies and register them as proprietary traders which will buy and sell the company stocks later. In the past, there have many instances where Sebi has gone after promoters of small and mid-cap companies for manipulating their stocks.In a pump and dump scheme, entities related to the scamsters first start buying shares of own companies in large numbers to drive up the stock price and once the price has gone up significantly, it catches the attention of retail investors and the manipulators then exit the stock at a profit by selling the shares to gullible retail investors.

Output of farm sector rises to Rs 29.49 lakh crore in FY24: Govt data

**New Delhi.** The Gross Value of Output (GVO) from the agriculture and allied sector increased 54.6 percent from FY 12 to FY 24 to Rs 29.49 lakh crore at constant prices, the National Statistics Office (NSO) said on Friday.The NSO, part of the Ministry of Statistics and Programme Implementation (MoSPI), has released the annual publication of ‘Statistical Report on Value of Output from Agriculture and Allied Sectors (2011-12 to 2023-24)’.“Gross Value of Output (GVO) from the agriculture and allied sector at constant prices has shown steady growth from Rs 1,908 thousand crore in 2011-12 to Rs 2,949 thousand crore in 2023-24, marking an overall increase of approximately 54.6 percent,” NSO said.It further said the Gross Value Added (GVA) of agriculture and allied sectors at current prices registered a growth of about 225 percent, increasing from Rs 1,502 thousand crore in 2011-12 to Rs 4,878 thousand crore in 2023-24. The publication is a comprehensive document that provides detailed tables on values of output of crop, livestock, forestry and logging, and fishing and aquaculture sectors of agriculture and allied activities from 2011-12 to 2023-24 at both current and constant (2011-12) prices.The detailed publication comes after the major aggregates at the all-India level have been released in the form of National Accounts Statistics on 28th February 2025, NSO said.According to the data, the crop sector with GVO at Rs 15.95 lakh crore remains the largest contributor to total GVO (at constant prices) of agriculture and allied sectors with a share of 54.1 percent in 2023-24. Cereals and fruits and vegetables together accounted for 52.5 percent of total crop GVO in 2023-24.Among the cereals, only paddy and wheat constituted approximately 85 percent of GVO (at constant prices) of all cereals in 2023-24.Five states—Uttar Pradesh, Madhya Pradesh, Punjab, Telangana, and Haryana—contributed nearly 53 percent of GVO (at constant prices) of cereals in 2023-24.With a reduced share (18.6 percent in 2011-12 to 17.2 percent in 2023-24), Uttar Pradesh maintained the top position, according to the NSO data.In the fruit group in 2023-24, the constant price GVO of bananas (Rs 47,000 crore) has surpassed that of mangoes (Rs 46,100 crore). Mango was the top-most contributor in GVO (at constant prices) in the fruit group consistently from 2011-12 to 2021-22.

IndusInd Bank shortlists 3 names for top job ahead of RBI deadline

**The bank is run by an RBI-approved executive committee comprising its consumer banking head Soumitra Sen and the chief administrative officer Anil Rao.**

**MUMBAI.** The troubled IndusInd Bank, which has been headless since late April when the scam-tainted chief executive Sumant Kathpalia and his deputy Arun Khurana resigned owning moral responsibility for the massive losses in its forex derivatives trading book, has reportedly shortlisted three names--Rajiv Anand of Axis Bank, Anup Saha of Bajaj Finance, and Rahul Shukla of HDFC

Bank--to man the top deck.While Rajiv Anand is currently the deputy managing director of Axis Bank, Anup Saha is the managing director of Bajaj Finance, and Rahul Shukla is the group head of commercial and rural banking at HDFC Bank and is on a sabbatical from the largest private sector bank. While Sumant Kathpalia resigned on April 29, his deputy Arun Khurana did so a day before. Both had cited moral responsibility for the scam for the decisions to leave, which came in well after seven weeks since the crisis came out. Both have also been banned by the market regulator from the market for insider trading—they had pocketed over Rs 157 crore from selling bank’s shares in 2023-24.Since their resignations, the bank is run by an RBI-approved executive committee comprising its consumer banking head Soumitra Sen and the chief administrative officer Anil Rao. According to a source in the know of the development, the board of the Hinduja group-promoted bank is expected to clear

these names and submit the list to the Reserve Bank for approval any day now before the regulatory deadline of June 30. The regulator has also asked the board to suggest probable names only from



outside IndusInd Bank. During a recent analyst call, IndusInd chairman Sunil Mehta had assured stakeholders that the names would be submitted well before the deadline.The upcoming leadership change is seen as a crucial development for the bank, which has been in focus since early March when it was forced by the RBI to inform all stakeholders that it

HDFC Bank slashes FD and savings rates again in June. Details here

**HDFC Bank's latest changes signal that deposit rates could remain soft if the RBI continues its rate-cutting cycle. Depositors should review their plans, stay updated with rate changes, and make informed decisions before booking new FDs or Rds.**

**New Delhi** HDFC Bank has again cut its fixed deposit (FD) interest rates this month. This is the second rate cut in June 2025 for India’s largest private bank. From June 25, 2025, the bank has lowered the interest rate on single FD tenures by 25 basis points (bps) for deposits below Rs 3 crore. This follows a similar cut made earlier on June 10, 2025, after the Reserve Bank of India (RBI) reduced the repo rate by 50 bps, from 6% to 5.5%. WHICH FD TENURE IS AFFECTED? HDFC Bank has reduced the interest rate on FDs with a tenure of 15 months to less than 18 months. Earlier, this rate was 6.60% for general customers and 7.10% for senior citizens. Now, it is 6.35% for general customers and 6.85% for seniors.The bank offers FD rates from 2.75% to 6.60% for the general public (for 18 months to less than 21 months) and 3.25% to 7.10%



for senior citizens for amounts under Rs 3 crore.PENALTY FOR PREMATURE WITHDRAWAL If you need to break your FD early, remember that the bank charges a penalty. According to HDFC Bank’s rules, if you withdraw your FD before maturity, you will get 1% less than the rate applicable for the period your money stayed with the bank, and not the original contracted rate. SAVINGS ACCOUNT RATES ALSO REDUCED

Along with the FD rate cut, HDFC Bank has also lowered the interest rate on all savings accounts. From June 24, 2025, the savings rate is down by 25 bps, i.e., from 2.75% to 2.50% per annum for all balances.The savings account interest is calculated daily and paid every three months. Weekly Review: Gold prices fall as investors turn away from safe-haven assets

**CHENNAI.** Gold prices have recently declined, marking their second consecutive weekly loss, as global investors increasingly shift focus away from traditional safe-haven assets. The weakening demand for gold comes amid a broader surge in risk appetite, buoyed by rising equity markets, easing geopolitical tensions, and firming expectations of a stable macroeconomic environment. In India, the precious metal prices have eased this week, offering a potential buying opportunity. On June 28, the price for 22-carat gold fell by about Rs55 per gram from the previous day—now around Rs. 8,930 per gram—while 24-carat gold was Rs. 9,742 per gram. Over the last ten days, 22-carat prices have dropped from Rs. 9,265 on June 19 to Rs. 8,930 on June

28—a fall of roughly Rs. 335. Similarly, 24-carat gold fell from Rs. 10,108 to Rs. 9,742—a Rs. 366 decline.



This downward trend reflects a broader global correction, driven by easing geopolitical tensions (such as the Israel-Iran ceasefire), a stronger dollar, and rising U.S. Treasury yields reducing the appeal of non-yielding

assets like gold . In MCX futures, domestic prices dropped about Rs. 1,630 per 10?g this week amid reduced safe-haven demand. For buyers, this dip may be a good chance to purchase jewelry or invest—but it's wise to monitor global trends, interest rates, and inflation data for future movements. Spot gold dropped by approximately 1.2% to around \$3,288 per ounce, while US August futures fell by 1.7%, closing the week with a nearly 3% decline. This drop reflects investor preference for higher-yielding or growth-oriented assets, with the Nasdaq hitting fresh record highs—signaling a strong risk-on sentiment in the market. Gold’s earlier rally, which saw prices touching historic highs earlier this year, has also prompted technical profit-taking, accelerating the recent sell-off.

Wall Street rallies to record highs as AI stocks soar, recession fears ease

**US stock markets hit all-time highs on Friday thanks to an AI boom and Fed hints at looser policy ahead. Trade deals with the UK and China have also fuelled market hopes that a global recession could be avoided.**

**New Delhi.** The S&P 500 and Nasdaq Composite hit all-time highs on Friday as megacap stocks surged on renewed AI enthusiasm and the prospect of a looser monetary policy, powering a recovery in US stocks from months-long rout.The benchmark index rose 0.2% to 6,154.81 points, surpassing the previous peak of 6,147.43 on February 19, while the tech-heavy Nasdaq gained 0.3% to 20,229.31 points, exceeding its record high of 20,204.58 on December 16.Markets



rallied this week as an upbeat forecast from chipmaker Micron brought back investor confidence around artificial intelligence, while AI bellwether Nvidia hit a record high to reclaim its position as the world's most valuable company.Risk appetite also benefited from a US-brokered ceasefire to a 12-day air battle between Israel and Iran that sparked a

jump in crude prices and raised worries of higher inflation.Dovish remarks from Federal Reserve policymakers have also aided sentiment.Trump's April 2 "reciprocal tariffs" on major trading partners and their chaotic rollout had put the S&P 500 within a striking distance of confirming a bear market when it ended down 19% from its February 19 record

closing high.The Nasdaq had tumbled 26.7% from its previous peak, marking a bear market days after Trump's "Liberation Day" on April 2.Since then, US trade deals with the UK and China have firmed up market expectations for more such agreements on the hopes that a global recession could be avoided.The S&P 500 has surged more than 23.5% and the Nasdaq added 32% since their recent lowest close on April 8, largely powered by a handful of megacap stocks such as Microsoft, Nvidia, Meta Platforms and Amazon.If the Nasdaq closes above the December 16 record close at 20,173.89, it would be the end of the bear market and start of a new bull market, according to common definitions.A bear market is defined as a 20% decline from a record high close, on a closing basis.Both the Nasdaq and S&P 500 have gained 4.4% this year as of Thursday's close. The blue-chip Dow has risen about 2% this year and remains about 3.7% below its all-time peak.

## Roston Chase demands penalty for umpires after contentious calls in 1st Test

**NEW DELHI.** West Indies captain Roston Chase demanded a penalty for the umpires after several controversial decisions went against them during the first Test against Australia in Kensington Oval, Bridgetown, Barbados. Australia beat West Indies by 159 runs as Josh Hazlewood ran through the hosts on Day 3 with his five-wicket haul.Following their loss, Chase called out the contentious decisions during the match and said that the umpires should face penalties for their wrong calls as one bad



decision can make or break a player's career. He mentioned how players face harsh penalties when they're found breaching the code of conduct and asked for similar treatment of umpires."But the officials, nothing ever happens to them. They just have a wrong decision or questionable decision, and life just goes on. You're talking about guys' careers. One bad decision could make or break a guy's career. I just think that it should be an even playground in terms of when players step out of line, they're penalised. I think that there should be some penalty put in place when you have blatant

decisions going against you," said Chase in the post-match press conference.Three decisions became the talking point of the Test match as on Day 1, Australia batter Travis Head was given a reprieve by TV umpire Adrian Holdstock after he ruled him not out on 53, citing lack of evidence on a clear catch by Shai Hope behind the stumps. Later on Day 2, Roston Chase was given out lbw against Pat Cummins, despite the cameras showing an inside edge onto the pads on replays.

To add to West Indies' woes, Shai Hope was given out against Beau Webster as a low take from wicketkeeper Alex Carey was ruled in Australia's favour. West Indies head coach Darren Sammy even met with match referee Javagal Srinath after Day 2 to express his concerns over the controversial decisions. Meanwhile, after losing the first Test, West Indies will be eager to make a comeback in the second Test of the series, beginning from July 3 in Grenada.

The West Indies collapsed to 86-8 inside 27 overs but the Australians didn't mop up the last resistance until the day's last over in an extra 75 minutes.Despite the inevitable, allrounder Justin Greaves, 38 not out, and No. 10 batter Shamar Joseph, a career-best 44 with four sixes, went for broke in a team-best ninth-wicket stand of 55 runs.Australia started the day in some bother at 92-4 in its second innings, but half-centuries from Travis Head, Beau Webster and Alex Carey hoisted them to an impressive 310 all out and a 300-run lead."We wanted to get 200 but felt lot more comfortable (with 300)," captain Pat Cummins said. "We're lucky to have

He bowled beautifully."West Indies start chase badlyWest Indies' attempt at its eighth highest successful run chase and highest in eight years was in trouble from the outset.Mitchell Starc claimed opening batter Kraigg Brathwaite in the first over, caught at backward square by a diving Sam Konstas.

"We lost our most experienced batsman in the first over and never got a foot back in the game," West Indies captain Roston Chase said. "The result was heartbreaking. We did well to get a (10-run first-innings) lead but couldn't put a batting innings together."Starc also should have bagged Keacy Carty on 1 but Cameron Green spilled the catch at gully. That was the 10th dropped catch in the match and Australia's third.Hazlewood changed ends and suddenly had success by dismissing John Campbell, scooping badly and gloving to wicketkeeper Carey, and Brandon King, caught above the 1.98-meter Green's head, in



successful balls.When Chase gave Konstas another catch at short leg, West Indies was 49-4 in 13 overs.Carty used his one life to reach 20 when he tried defending Hazlewood and lost his off stump.Shai Hope, the leading West Indies run-scorer in the first innings, faced 21 balls for 2 until his off stump was hit by a low shooter from Cummins.Alzarri Joseph was then slow coming from the non-

striker's end and run out by a throw from substitute fielder Marnus Labuschagne.Jomel Warrican's edge behind gave Hazlewood his 13th test five-for and second in the Caribbean, 10 years after the first.Greaves and Shamar Joseph frustrated Australia with lusty strokes but Nathan Lyon ended the joyride in his second over of the innings. On day one, 14 wickets fell, and on day two 10 wickets. Before Friday's play, Lyon said, "Every run is gold." But Australia enjoyed a gold rush from Head, who made 61, Webster 63, and Carey 65.Australia, starting on 92-4 and a lead of 82, amassed a bonus 310 total.After taking cover late Thursday, Head came out firing in the morning but should have gone on 21 and it be 107-5. Greaves spilled the catch at second slip off the bowling of Alzarri Joseph. It was West Indies' seventh dropped catch in the match.
