At the same time, we wish to caution the government: Do not deploy military forces, CRPF, BSF, or any paramilitary units inside or around the Golden Temple. The Sikh community and the SGPC will not tolerate such interference. Sikhs around the world will strongly oppose any attempt by the government to militarize the Darbar Sahib precincts. The SGPC and the Sikh community are fully capable of protecting their Gurdwaras. No power in this world can intimidate or terrorize Sikhs. No one can dare touch or damage the Darbar Sahib. The SGPC is actively working to uncover the forces behind these threats. We strongly appeal to the central government and concerned

agencies to: 1. Immediately investigate the source of these threatening emails. 2. Let the cybercrime department trace the IP addresses and identify the individuals or organizations involved. 3. Expose and punish those trying to create panic, spread fear, and destabilize the atmosphere. At this critical moment, the SGPC has urged Sikhs and all peace-loving people around the globe to continue visiting Darbar Sahib without fear. The management has assured that complete arrangements for the safety and security of all devotees have been made. This issue has sparked concern in every Sikh household worldwide. People are wondering who is behind this deeply dangerous conspiracy. The Sikh community is treating the matter with utmost seriousness. Any attempt—direct or indirect—to harm the sanctity of the Golden Temple will be crushed by the willpower of the Sikh people.

New Delhi, 18 July 2025: Social Welfare Minister Ravinder Indraj Singh held a key review meeting on Friday in North Delhi to assess the progress and strategy of the anti-drug campaign. The Cabinet Minister emphasized that prevention is the most effective way to control drug abuse. Women can bring a new direction to awareness at the family and community level by being actively involved in the de-addiction campaign. Awareness must be created among women in JJ colonies, slums, and clusters. By becoming volunteers, women can significantly contribute to making their families and society drug-free.

Ravinder Indraj stated that in addition to strict legal action, societal support is equally essential to curb drug abuse—particularly the active participation of women. Women should be made aware of symptoms of addiction, help line numbers, and available de-addiction centers so that they can help their families and neighborhoods.

The Minister informed that he has written to the Commissioner of Police to assign responsibility to beat officers in drug hotspot areas. He also instructed the police to identify and share a list of dark spots and ensure close surveillance to facilitate effective awareness campaigns in those locations.

He stressed the need for strict monitoring of the sale of intoxicating products at medical stores and other outlets and asked for concrete action to prevent drug abuse at public spaces like parks and toilets.

Justice Yashwant Varma approaches Supreme Court over impeachment in cash haul case

Allahabad High Court judge Justice Yashwant Varma, from whose residence a large sum of cash was recovered, has approached the Supreme Court challenging the findings of an enquiry committee that cited "strong inferential evidence" against him and recommended impeachment proceedings.

In his petition, Justice Varma has sought to cancel the three-judge enquiry committee's report, contending that the proceedings violated his rights both as an

individual and as a constitutional functionary.

He has also urged the Supreme Court to set aside the impeachment recommendation made by former Chief Justice of India Sanjiv Khanna, which was based on the committee's findings.

Justice Varma argued that the enquiry committee concluded its proceedings without investigating key facts and had erroneously shifted the burden of proof onto him, requiring him to disprove facts that the committee had merely presumed to be true

Hounded for 10 years: Rahul Gandhi backs Robert Vadra amid ED crackdown

The Enforcement Directorate has filed its first chargesheet naming Robert Vadra in a money laundering case linked to a Gurugram land deal, drawing sharp accusations of a "witch hunt" from Congress.

Congress leader Rahul Gandhi on Friday launched a scathing attack on the Centre, accusing it of carrying out a decade-long "witch hunt" against his brother-in-law Robert Vadra, after the Enforcement Directorate filed its latest chargesheet against him.

"My brother-in-law has been hounded by this government for the last ten years. This latest chargesheet is a continuation of that witch hunt. I stand with Robert, Priyanka and their children as they face yet another onslaught of malicious, politically motivated slander and harassment," Rahul Gandhi said in a post on X. "I know that they are all brave enough to withstand any kind of persecution and they will continue to do so with dignity. The truth will eventually prevail," he added. The Leader of Opposition's remarks came a day after the

breathed unity. Any effort to inject fear and hatred into this spiritual landscape must be confronted with resolve and clarity."

Bajwa, however, expressed disappointment over the "inaction" by the Punjab government. "Despite the seriousness of the threats, neither Chief Minister Bhagwant Mann nor the Director General of Police (DGP) have visited Amritsar to assess the situation and reassure the public. Even four days after the initial threats, the absence of top officials on the ground is alarming," Bajwa said.

He said, "In today's age of instant communication and rapid response, such silence and absence of leadership raise serious concerns. The chief minister, the chief secretary and the DGP should have personally visited Amritsar, demonstrated sensitivity and stood by the people during this critical time. This was a moment to show leadership. Unfortunately, the government appears disengaged and indifferent."

Taking strong exception to the "double standards" of the AAP, Bajwa noted, "On the one hand, Arvind Kejriwal and Bhagwant Mann are pushing a sacilege prevention Bill in the Assembly to claim religious sensitivity, while on the other, they are completely absent during a moment of actual crisis."

Surat robbery-cum-murder: 2 more accused held in Bihar, hunt on for fourth

Two gang members of Bihar's Paswan gang, involved in a recent robbery-cum-murder of a jeweller from Surat, were arrested in Bihar by the Surat Crime Branch. One of the gang members, who was caught and thrashed by the public on the day of the incident, is currently in remand of the Surat police.

The arrested individuals have been identified as Sanjay Chandradev Paswan (45) and Avinash alias Rakesh Paswan (21), both residents of Bihar's Vaishali.

As per the Surat police, a gang of four entered Shrinathji Jewellers at C V market in Sachin on July 7 and held its owner Vishal Rajpara, his friend Rajesh Soni, and two saleswomen at gunpoint. The accused carried looted gold



jewellery worth around Rs 10 lakh. Vishal's brother Ashish rushed to his help and tried to stop the robbers from fleeing. One of the robbers shot three rounds from his pistol and Ashish sustained injuries. The robbers also shot at Rajesh and vegetable vendor Azim Shaikh. However, people caught hold of one of the robbers, later identified as Dipak Paswan, and thrashed him before handing him over to the police.

Ashish was rushed to a hospital where he was declared dead, while Rajesh and Azim survived. A complaint of robbery and murder was lodged against the gang at Sachin police

station. Dipak was admitted to a hospital and was discharged after recovery.

The police, who were looking for the absconding accused, sent three teams to Bihar after receiving information about them. The teams, led by Surat Crime Branch officer J N Gosami and V A Jograna, caught two robbers from different villages in Vaishali district. They were produced in a district in Vaishali court, which granted the Surat police a four-day transit remand of the accused. On Thursday,

Surat Crime Branch teams

returned to Surat.

Talking to the Indian Express, Police Inspector Goswami said, "Three accused have been arrested so far. The fourth accused, identified as Pinto alias Ravindra Paswan, is still at large. All of them have criminal

history. All had been lodged in jails in Bihar. While three of them were released on bail in 2024, Pinto was released this year." "The gang was operated by Dipak and Sanjay. It was Dipak who came down to Surat and started working first at a factory in Kadodara, and later in Sachin. Dipak had his eyes on Shrinathji Jewellers. He talked to his friends in Bihar and asked them to come to Surat. They conducted a reeve for three days before committing the crime. Dipak made arrangements for their (other accused's) stay at a rented house in Sachin. We are trying to dig out more information from these accused."

Will go on indefinite strike if our demands are not met soon, says sanitation workers in Mumbai

Essential activities in Mumbai like picking up solid waste from households and commercial establishments and keeping the city clean may suffer a major setback as nearly 31,000 municipal workers have announced to go on an indefinite strike starting July 23. The workers have called for the strike in order to oppose the civic body's Rs 4,000-crore project under which it aims to rope in private contractors to carry out cleaning and collection of waste through a fleet of new waste collection trucks across all the wards in Mumbai.

On Thursday, hundreds of sanitation workers gathered at Azad Maidan to protest the civic body's new waste collection policy, voicing concerns over job security and living conditions. The protest, organised by the Municipal Workers Action Committee, also saw BJP leader and cabinet minister Girish

Mahajan extending support to the agitating workers. Following the gathering, a delegation of municipal workers along with Mahajan also met Chief Minister Devendra Fadnavis.

"We have held a discussion with the CM who assured us that all our demands will be met and we will have an agreement with municipal commissioner by July 23. If this doesn't happen, then we will go on an indefinite strike," Ramakant Bane, general secretary of municipal union said. Bane said their demands included that no existing employee of the solid waste department should lose their job, there shall be no change in the service condition and no scheduled post should be dissolved or nullified in the wake of this tender. Meanwhile, civic officials maintained that the tender of the Rs 4,000 crore project is



still live and there has been no instruction from the administration to revoke it.

Thursday's protest also comes amid growing anger among workers against the civic body's plan to bring in private agencies for garbage

collection. Workers fear the move will render thousands jobless, disrupting livelihoods of families that have served the city for generations.

"I have been working for over 20 years with the BMC. This job has been our family's sole source of income for generations," said Prafulla Kamble, a sanitation worker. Kamble also highlighted another longstanding demand of the community—ownership rights to the municipal

quarters they have lived in for over three generations. "Our demand for ownership is repeatedly denied, and now we face the risk of losing our jobs too," he said.

Super swachh league shines spotlight on City of Diamonds – Surat

As the Swachh Survekshan 2024-25 awards were announced on Thursday, they brought special laurels to Surat, known to be a hub of diamonds and textiles, as it was moved to a new "super swachh league".

At an event held in New Delhi, President Droupadi Murmu conferred the award to Surat Municipal Corporation (SMC) for its outstanding work in sanitation. The President felicitated Gujarat Health Minister Rushikesh Patel, SMC Mayor Dakshesh Marani, and Municipal Commissioner Shalini Agarwal by presenting them with a certificate and a shield.

Sources in SMC said that as "the cleanest city in India", Surat has delivered an excellent performance in the league.

Under the guidelines of Swachh Survekshan 2024, this new category was introduced to inspire other cities and holds a greater significance than the traditional ranking system.

In Swachh Survekshan 2023, Surat



had jointly secured the first position along with Indore. In the 2021 and 2022 editions, Surat had achieved second place.

The Super Swachh League includes cities that have been ranked in the top three slots at least twice in the last three surveys. In this

category, 12 cities across the country were selected and divided into five categories based on population.

In the category of towns with a population of over 10 lakh, Surat has secured the highest position in the Super Swachh League, said SMC sources.

With a significant presence of migrants, Surat has an estimated population of over 82.32 lakh. The work of SMC was assessed by the team of Swachh Survekshan over the job done in different segments such as Source Segregation, door-to-door waste collection, waste-to-compost plant, RDF plant, plastic-waste processing unit, biomedical waste processing units, sanitary landfill, tertiary treatment plant etc.

45 birds, including herons, killed during tree pruning at Thane housing society, forest dept launches probe

Corporation has issued a notice to the housing society management seeking an explanation. It has also lodged a police complaint against the society's management.

As many as 45 birds died, and many unhatched eggs were destroyed during a tree trimming exercise that was carried out in a housing society in Thane on Thursday. However, 27 were rescued by the Maharashtra forest department from the housing society's compound on Ghodbunder Road. Most of the birds that died were egrets belonging to the heron family, apart from sparrows and mynas, forest officers said, adding that their nests were also destroyed in the incident reported at 2 pm.

The forest department has launched an investigation into the incident, and action will be taken based on the report, said an officer.

"The trees were being trimmed after securing permission from the Thane Municipal Corporation (TMC). According to norms, a maximum of 20 per cent of the branches could be trimmed during a pruning operation, and we found out that more than 50 per cent of the



branches got affected," said a forest officer.

The forest department said that when their team arrived at the spot, they found the dead birds lying in the drains of the society, while the contractors immediately fled the spot on seeing them. The officer said that birds, mostly fledglings, died by getting crushed underneath the branches. The rescued birds have sustained injuries and have been transferred for treatment. Some eggs are also rescued, and we

are examining the possibility of whether it could be artificially hatched," the officer added. Meanwhile, the TMC administration has issued a notice to the society management seeking an explanation of the incident. The civic administration has also lodged a police complaint against the society's management and the contractors. "The tree was being pruned by a third-party contractor appointed by the society. The rules clearly state that one should be

careful about bird nests and hatchlings while carrying out a tree trimming operation.

We have issued a notice to them and given them time to respond to us, and a complaint has been filed with the police,"

a TMC officer said. According to the forest officers, herons are seasonal birds that migrate between May and June, which is their

Varanasi, July 18: During his two-day visit to Varanasi, Chief Minister Yogi Adityanath inaugurated the National Seminar on Tribal Pride Birsa Munda at Vasant Mahila Mahavidyalaya on Friday. He hailed tribal communities as the foundation of Indian civilization and warned against rising attempts to incite caste conflict through fake social media accounts, calling for immediate action to stop such divisive agendas. In his address, the Chief Minister referring to the Ramayana, he said, "When Lord Rama was in exile and Mother Sita was abducted, it was the tribal community that stood by him, despite the absence of Ayodhya's army. Similarly, Maharana Pratap reorganized his army in the forests of the Aravalli Range with the support of tribal groups and resisted Akbar. Chhatrapati Shivaji, too, relied on the Vanavasi (forest dwellers) society to lay the foundation of the Hindavi Swarajya." The Chief Minister hailed Birsa Munda as a key figure of India's national awakening, asserting that tribal communities have consistently played a vital role in protecting India's spiritual and cultural legacy. "While we often associate the struggle for independence with recent history, the tribal society has been fighting for Sanatan Dharma through

spread caste-based hatred online had also tried to provoke tribal communities against the nation. "Such elements must face strict action," he asserted. Acknowledging past shortcomings, the Chief Minister said previous governments failed to extend governance and essential services to tribal communities. "Where communication breaks down, conflict begins," he noted. "After 2017, our government granted revenue village status to tribal villages, places that hadn't had voting rights since 1947. We ensured delivery of ration cards, land leases, pensions, and development schemes to tribal regions in Sonbhadra, Chandauli, Mirzapur, and the Terai areas bordering Nepal." Describing tribal society as the true embodiment of India's Sanatan tradition, Chief Minister Yogi Adityanath said, "Tribal communities live in complete harmony with nature, reflecting the essence of Vedic teachings in their everyday lives." "We often worship trees and rivers, but do not hesitate to exploit or encroach upon them. In contrast, tribal society has lived the message of the Vedas, coexisting with nature rather than exploiting it," he remarked. The Chief Minister emphasized that Indian tradition has never confined Hindu identity to temple visits or scriptural belief. "Both the believer and the non-believer are Hindus. Charvak

and Lord Buddha did not accept the Vedas, yet they are deeply respected in our tradition. Then why question the identity of tribal communities in the context of Hinduism?" he asked. Underscoring the importance of social harmony, the Chief Minister emphasized that the Kanwar Yatra embodies unity transcending caste, creed, and sect. "Today, the Yatra is progressing peacefully and with devotion, yet some label it as unruly. These are the same forces that try to mislead and provoke tribal communities. We must remain alert to such divisive elements," he warned. He cited another incident from Jaunpur, where a towering Tazia was constructed in violation of safety norms and came into contact with a high-tension wire, tragically claiming three lives. "Following this, an attempt was made to block roads and create unrest. I instructed the police to take strict action. Those disrupting social harmony must understand that peace and order are paramount," he asserted. Praising Prime Minister Narendra Modi for declaring November 15 as Janjatiya Gaurav Diwas (Tribal Pride Day), the Chief Minister said the move has instilled a sense of respect and recognition in tribal communities. "They are our original society. Tribal Pride Day is a gesture of gratitude and a bridge of communication with them," he noted.

Strict Instructions by Commissioner: Ensure No Waterlogging on City Roads After Rainfall

Amritsar: Commissioner Gulpreet Singh Aulakh held an emergency meeting with officials from the O&M Cell and Sanitation Department regarding water accumulation on city roads during the monsoon season. He instructed that duties be assigned to subordinate staff to inspect roads immediately after rainfall and to ensure that any water accumulation is promptly cleared without delay. Present in the meeting were Additional Commissioner Surinder Singh, Joint Commissioner Jai Inder Singh, Health Officers Dr. Kiran and Dr. Yogesh Arora, Executive Engineer Swarajinder Pal Singh, along with several other officials. Commissioner Gulpreet Singh Aulakh stated that the Municipal Corporation, Amritsar is making every possible effort for the convenience of the city residents. He emphasized that, considering the rainy season, officials of the O&M Cell and Sanitation Department have been directed to ensure that field staff inspects roads within 15-20 minutes after rainfall and removes any stagnant rainwater without delay. He further added that if manual drainage is not possible in any area, roadside chambers should be checked, as sometimes plastic bags or garbage block the outlets. Immediate cleaning of these chambers must be ensured to allow proper drainage of rainwater. The Commissioner also mentioned that in case of emergencies, a special O&M Emergency Group has been formed to operate the available machinery such as Super Sucker, Jet Pump, and Suction Machines. These machines will remain on standby at all times and will be dispatched promptly to affected areas upon receiving WhatsApp messages, ensuring quick drainage of rainwater. He assured city residents that the Municipal Corporation Amritsar will not let there be any shortage in manpower or machinery for rainwater drainage.

Five US immigrants deported to Eswatini in Africa are being held in solitary confinement

BAGHDAD. (Agency)

CAPE TOWN, South Africa: Five immigrants deported by the United States to the small southern African nation of Eswatini under the Trump administration's third-country program are in prison, where they will be held in solitary confinement for an undetermined time, a government spokesperson said. Thabile Mduli, the spokesperson, declined to identify the correctional facility or facilities where the five men are, citing security concerns. She said Eswatini planned to ultimately repatriate the five to their home countries with the help of a United Nations agency.

In cell phone messages to The Associated Press on Thursday, Mduli said it wasn't clear how long that would take. The men, who the US says were convicted of serious crimes and were in the US illegally, are citizens of Vietnam, Jamaica, Cuba, Yemen and Laos. Their convictions included murder and child rape, the US Department of Homeland Security said, describing them as "uniquely barbaric." Their deportations were announced by Homeland Security on Tuesday and mark the continuation of President Donald Trump's plan to send deportees to third countries they have no ties with after it was stalled by a legal challenge in the United States. A new country for deportees

Eswatini, a country of 1.2 million people bordering South Africa, is the latest nation to accept third-country deportees from the US. The Trump administration has sent hundreds of Venezuelans and others to Costa Rica, El Salvador and Panama, and deported eight men earlier this month to South Sudan, also an African country.

US House Republicans grasp for response to demands for transparency in Epstein case

WASHINGTON. (Agency)

US House Republicans were grasping late Thursday to formulate a response to the Trump administration's handling of records in the Jeffrey Epstein sex trafficking case, ultimately putting forward a resolution that carries no legal weight but nodded to the growing demand for greater transparency.

The House resolution, which could potentially be voted on next week, will do practically nothing to force the Justice Department to release more records in the case. Still, it showed how backlash from the Republican base is putting pressure on the Trump administration and roiling GOP lawmakers. The House was held up for hours Thursday from final consideration of President Donald Trump's request for about \$9 billion in government funding cuts because GOP leaders were trying to respond to demands from their own ranks that they weigh in on the Epstein files.

In the late evening they settled on the resolution as an attempt to simultaneously placate calls from the far-right for greater transparency and satisfy Trump, who has called the issue a "hoax" that his supporters should forget about. Yet the House resolution was the latest demonstration of how practically no one is moving on from Attorney General Pam Bondi's promises to publicly release documents related to Epstein. Since he was found dead in his New York jail cell in August 2019 following his arrest on sex trafficking charges, the well-connected financier has loomed large among conservatives and conspiracy theorists who have now lashed out at Trump and Bondi for declining to release more files in the case.

"The House Republicans are for transparency, and they're looking for a way to say that they agree with the White House. We agree with the president. Everything he said about that, all the credible evidence should come out," House Speaker Mike Johnson said Thursday afternoon.

Misbehaving monks: Sex scandal shakes Thailand's Buddhist faithful

BANGKOK. (Agency)

Reverence for the saffron-robed Buddhist monkhood is deeply woven into Thai society, but a sex extortion scandal has besmirched the clergy and left the devout questioning their faith.

Thai police this week arrested a woman accused of bedding at least 11 monks in violation of their vows of celibacy, before blackmailing them with thousands of secretly taken photos of their trysts. The monks are said to have paid nearly \$12 million, funnelled out of their monasteries funded by donations from laypeople hoping to increase their merit and prospects for reincarnation. The scandal provoked outrage over hypocrisy in the monkhood, concern their status shields them from scrutiny, and soul-searching across society about the role of religion. "I'm not involved in the religion like I used to be," 33-year-old motorbike taxi driver Mongkol Sudathip told AFP. "I don't have full respect for it anymore." King Maha Vajiralongkorn has cancelled invitations to more than 80 monks who had been due to attend his upcoming 73rd birthday celebrations, citing "inappropriate behaviour that caused mental distress among the Thai people". While the 11 monks have been stripped of their robes, the kingdom's National Office of Buddhism has vowed to "restore public trust" with a sweeping police probe into the grubby affair. Splurging attitude!

Theravada Buddhism has been the spiritual backbone of Thai identity for more than two millennia, and still shapes national laws banning alcohol on religious holidays and protecting sacred objects. Thai men are traditionally expected to ordain as monks at least once in their lives for a period lasting as short as a few weeks or as long as decades. The clergy are bound by 227 strict rules, including a ban on masturbation, touching women and even handling objects directly from them. Monks traditionally survive on alms, food offerings and a modest \$170 monthly stipend, but some pocket fees for lectures, blessings and ceremonies -- blurring the line between faith and fortune.

Chinese university expels female student over relationship with foreigner

Expulsion sparked debate on Chinese social media about privacy and nationalism

Student accused of improper interactions with foreign gamer, videos circulated

State media question legality of publishing student's name

A Chinese university announced the expulsion of a female student for "damaging national dignity" after she was accused of "improper interactions" with a foreign man, generating heated discussions across Chinese social media about whether the university had gone too far. Over the last several days, the expulsion has drawn thousands of comments on platforms such as Xiaohongshu and Douyin, the Chinese version of TikTok, many of which question whether the school has the right to judge her personal life and elevate it to a matter of

national import. In an announcement posted last week, Dalian Polytechnic University in the country's northeast declared that the student would be "expelled" in 60 days, saying she violated the university rule against "having improper interactions with foreigners that damage national dignity." "Your misbehaviours on December 16, 2024, caused a terrible negative impact," the announcement said, without giving details on what constituted the "misbehaviours."

The university released her name, but AP is not publishing it out of privacy concerns. The incident taps into multiple issues in China. The university's actions illustrate a number of issues percolating into modern Chinese society, including discussions about gender bias and a full-on push toward nationalism. Chinese internet users have connected the accused university student to videos posted by Danylo Teslenko, also known as Zeus, a professional Ukrainian gamer, showing



him being intimate with an Asian-looking young woman in a hotel room. AP cannot independently verify if the woman in the video is a student.

Some on social media called the school's decision to expel the student a sign of the "Taliban style," by which a particular nation or group claims ownership over a woman's body. Others call it misogyny, asking if a Chinese man would be considered a "national pride" if he had sex

with a foreign woman. The Paper, a state-run newspaper in Shanghai, said it was not just "inappropriate" to publish the student's full name but also "may even violate the Personal Information Protection Law."

"It is improper to graft private affairs onto the public domain for public disposal," said The Paper. Teslenko, the gamer, confirmed on Sunday that he posted "a few videos on Telegram with a girl I met in Shanghai" but later deleted

them "as soon as I understood the seriousness of the situation," according to his post on X, formerly known as Twitter.

"Our faces were visible, but there was no explicit content or anything disrespectful in those videos," the post said. "I have never said that Chinese girls are easy."

Media reports said Teslenko and the student met at the final of the Perfect World Shanghai Major, a gaming competition held in December 2024.

Newsom vows legal fight as Trump admin pulls \$4 billion from high-speed rail project

California Governor Gavin Newsom on Thursday vowed to fight an "illegal" move by President Donald Trump's administration to cancel USD 4 billion in federal grants for the state's ambitious but much-delayed high-speed rail project. Trump's announcement on Wednesday added yet another hurdle to the 16-year effort to link Los Angeles and San Francisco by a three-hour train ride, a project that would deliver the fastest passenger rail service in the United States. Newsom said the move by Trump's Transportation Department came as the high-speed rail project was on the verge of laying track, with "active construction" under way on the initial 171-mile segment between Bakersfield and Merced in California's politically conservative Central Valley. The rail system, whose first USD 10 billion bond issue was approved by California voters in 2008, has built more than 50 major railway structures, including bridges,

overpasses and viaducts, and completed more than 60 miles (97 km) of guideway. State Attorney General Rob Bonta told reporters on Thursday he was "poised to take imminent action" on the issue, indicating the dispute would end up in



court. "California is putting all options on the table to fight this illegal action," Newsom said in a statement.

The funding cancellation marked the latest confrontation between the Republican president and a

Democratic governor widely viewed as a leading contender for his party's 2028 White House nomination. The two men have clashed over issues from transgender athletes and electric car rules to the use of National Guard troops during Los Angeles protests and even egg prices.

'LEGAL BINDING AGREEMENTS'

Ian Choudri, chief executive officer of the California High Speed Rail Authority, said that canceling the federal rail grants "without cause isn't just wrong, it's illegal." "These are legally binding agreements, and the authority has met every obligation, as confirmed by repeated federal reviews, as recently as February 2025," Choudri said, adding that the program has created some 15,500 jobs. The Federal Railroad Administration issued a 315-page report last month finding the project was plagued by missed deadlines, budget shortfalls and questionable ridership projections.

Greatest injustices of our time: One billion Africans being harmed by cooking pollution

IEA estimates 815,000

premature deaths occur each year in Africa alone due to poor indoor air quality, largely resulting from a lack of access to clean cooking methods.

One billion Africans have to cook on open fires or with fuel that is hazardous to their health and the environment, the International Energy Agency said Friday. The problem, which its report says can be easily solved, causes as much greenhouse gas emissions every year as the aviation industry. Two billion people across the world still cook on open fires or with rudimentary stoves fed by wood, charcoal, agricultural waste or manure, the IEA report found. "It is one of the greatest

injustices of our time, especially in Africa," IEA head Fatih Birol told AFP, where four out of five households rely on open fires and burning wood. These fuels pollute the air both indoors and outdoors with fine particles that

penetrate the lungs and cause multiple respiratory and cardiovascular problems, the report said. It also adds to the destruction of forests, natural sinks that trap carbon and help fight global warming. The IEA estimates that 815,000 premature deaths occur each year in Africa alone due to poor indoor air quality, largely resulting from a lack of access to clean cooking methods.

Women and children suffer the most, spending hours each day searching for fuel and keeping the fire going. This takes time away from paid employment or education, the report said. 'Can be easily solved' A landmark IEA summit on the issue, held in Paris in May last year raised \$2.2 billion in public and private sector commitments, as well as political pledges from 12 African governments. Since then \$470 million has been distributed, with concrete results already being seen, Birol insisted, citing a stove factory under construction in Malawi and an affordable stove programme developed in Uganda and Ivory Coast.

The IEA report assesses the progress made a year after the summit and sets out a roadmap for African countries to be able to use clean cooking methods at low cost before 2040. Since 2010, nearly 1.5 billion people in Asia and Latin America, particularly in Brazil, India, and Indonesia, have got access to modern cooking stoves and fuels.

They urge Iran to return for a verifiable and lasting nuclear deal.

UN sanctions may snap back if no deal by October 18

DHAKA. (Agency)

France, Britain, and Germany have warned Iran that they expect concrete progress on nuclear talks soon. If Iran does not take clear steps by the end of summer, these European countries said they will push to bring back United Nations sanctions against Tehran.

The foreign ministers of these three nations, known as the E3, spoke on Thursday with Iran's Foreign Minister Abbas Araghchi. This was their first conversation since recent air strikes by Israel and the US targeted Iran's nuclear program in June. A French diplomatic source said the ministers urged Iran to immediately return to the negotiating table to reach a "verifiable and

supporting the nuclear deal will expire on October 18. After that, the UN can reinstate sanctions if Iran is found to have broken the terms of the agreement. The process to restore sanctions would take about 30 days.

Europe has made it clear that without a new nuclear deal, it will trigger the so-called "snapback" mechanism. This would bring back all previous UN sanctions on Iran. "The ministers also reiterated their determination to use the so-called 'snapback' mechanism in the absence of concrete progress toward such an agreement by the end of the summer," the French source said. However, the officials did not specify what kind of progress Iran must show.

Since the recent air strikes, UN inspectors have pulled out of Iran, complicating efforts to oversee the country's nuclear activities. Although Iran claims it is willing to engage in diplomacy, there are currently no signs that talks between Washington and Tehran will restart in the near future.

'Fear is the tool of a tyrant': Fired US federal prosecutor Maurene Comey tells colleagues

WASHINGTON. (Agency)

Maurene Comey, the daughter of former FBI director James Comey who as a federal prosecutor in Manhattan worked on cases against Sean "Diddy" Combs and Jeffrey Epstein, said in a note to colleagues that "fear is the tool of a tyrant" and that her firing without reason should fuel "a fire of righteous indignation at abuses of power."

"If a career prosecutor can be fired without reason, fear may seep into the decisions of those who remain," Comey said in the note, which was obtained by The Associated Press on Thursday. "Do not let that happen. Fear is the tool of a tyrant, wielded to suppress independent thought." "Instead of fear," she added, "let this moment fuel the fire that already burns at the heart of this place. A fire of righteous indignation at abuses of power. Of commitment to seek justice for victims. Of dedication to truth above all else." Until her firing Wednesday, Comey had been a veteran lawyer in the Southern District of New York, long considered the most elite of the Justice Department's prosecution offices. Her cases included the sex trafficking prosecution of Epstein, who killed himself behind bars in 2019 as he was awaiting trial, and the recent case against Combs, which ended earlier this month with a mixed verdict. Her termination represented the latest Justice Department effort to fire lawyers without explanation, a trend that has raised alarm over a disregard for civil service protections designed to remove attorneys for political reasons. The department has also fired a number of prosecutors who worked on cases that have provoked Donald Trump's ire, including some who handled US Capitol riot cases and lawyers and support staff who worked on special counsel Jack Smith's prosecutions of the Republican president. She was long seen as a potential target given her father's fraught relationship over the last decade with Trump. The Justice Department recently appeared to acknowledge the existence of an investigation into James Comey, though the basis for that inquiry is unclear. Asked about the firing Thursday, White House press secretary Karoline Leavitt said, "This was a decision made by the Department of Justice."

Maurene Comey had most recently been among the prosecutors in the sex trafficking and racketeering case against Combs. The hip-hop mogul was acquitted of the main charges but convicted of lesser prostitution-related offenses that may result in a prison sentence of just a few years, an outcome seen by some as a rare defeat for prosecutions.

Kanakakunnu Palace unfit for protected monument status'

In a significant development in the ongoing legal battle over the conservation of the historic Kanakakunnu Palace and its heritage grounds, the archaeology department has reported that extensive unscientific renovation using modern materials has eroded the palace's historical and archaeological authenticity. A detailed inspection report by the department painted a grim picture of the palace's current condition. Once a stately residence built during the reign of Sree Moolam Thirunal, and later modified by Sree Chithira Thirunal, the palace has undergone multiple structural alterations that have significantly changed its interior architecture. Vitrified tiles have replaced the original Italian flooring, traditional wall paintings have been repainted with acrylics, and partition walls and false ceilings have been installed using gypsum boards to accommodate a proposed Digital Museum.

The affidavit filed by Additional Chief Secretary Rajan Khobragade before the High Court made it clear that the archaeology department has ruled out the possibility of declaring Kanakakunnu Palace an ancient monument. However, recognising its cultural significance and historical value to the city of Thiruvananthapuram, the government has decided to preserve the structure as a heritage building rather than as an archaeological monument.

The tourism department had launched extensive development activities at the Kanakakunnu Palace and the attached grounds, triggering widespread protest among green activists. Subsequently, green activists approached the High Court, stalling the construction activities. The High Court recently disposed of the case, giving liberty to challenge the state government decision.

Eugene Pandala, member of the Art and Heritage Commission, said that tourism in Kerala is turning into an enemy of tourism itself. "Both tangible and intangible heritage needs to be protected and such destruction of heritage is happening because of a lack of awareness. Tourists come here to enjoy our cities' cultural heritage and the government should be more careful while taking up renovation of heritage structures that need to be protected for posterity," Eugene said.

Green activists are gearing up to challenge the decision of the government not to protect Kanakakunnu Palace as an ancient monument.

12 injured as 3-storey chawl in Mumbai collapses, many feared trapped under debris

Ahmedabad. (Agency)

At least 12 people, including an eight-year-old boy and two senior citizens, were injured, and several others are feared trapped under the debris after a portion of a ground-plus-three-storey structure in Mumbai's Bandra (East) collapsed early on Friday. No casualties have been reported so far, the police said, adding that the senior citizens have sustained serious burn injuries.



According to the police, the chawl in the Bharat Nagar area collapsed around 6 am and rescue operations are currently underway.

"Based on eyewitness accounts, we suspect a cylinder blast could have triggered the overall collapse incident," Ravindra Ambulgekar, chief fire officer of the Mumbai Fire Brigade (MFB) told. He said around 15 people were suspected to be trapped underneath the debris of the residential structure, and some of the victims have sustained burn injuries. "We have rescued 12 of them till now, and the work of rescuing two more people is underway," he added.

Punjab govt setting up 22 committees to advise it on new industrial policy: Minister Sanjeev Arora


Punjab Industries Minister Sanjeev Arora Thursday said the state government was in the process of setting up industry-specific committees to advise it on shaping up a new industrial policy.

A total of 22 committees comprising industrialists will be formed, he said, adding each committee will comprise 8 to 10 members with its chairman. The tenure of these committees will be for two years.

"These committees will advise the government for any requirement they need in their respective sectors. They will advise the government about what changes they require in the policy," said Arora.

Arora said the committees will be asked to give their first report within 45 days. "We will seek their comments to make new industrial policy a reality. We want to come out with the new policy as soon as possible," said Arora.

These committees will be constituted for the textile sector, IT, sports goods, , bicycle industry, auto and auto components, heavy machinery, electric vehicles, renewable



energy, food processing, steel, chemical industry, tourism and hospitality, film and media, pharmaceuticals, retail and manufacturing among others, he said.

Replying to a question on some textile industrialists from Punjab investing in Madhya Pradesh, Arora said no industry is

moving out of the state. "They have future expansion plans. If any industry has future expansion plans, these can be for going there where raw material is available, and a port is near for import and exports." "Nobody is shutting here. They are expanding here as well," he said.

On July 7, MP Chief Minister Mohan Yadav had met local industrialists in Ludhiana and had them said that his state received investment proposals worth Rs 15,606 crore from Punjab industrialists.

To a question on industry complaining about unscheduled power cuts, Arora said they regularly take up this issue with the state-owned power utility — Punjab State Power Corporation Ltd. "We do not have a shortage of power. Rather the PSPCL is looking for customers for sale of electricity. But somewhere there are transmission problems. Sometimes grids get overloaded. All these are issues being taken care of. In the last 6-8 months, new grids have been set up and upgraded. "We assure that this problem will be solved," he said.

Cabinet takes decisions on waiving interest, penalties on KSRTC's loans

In a significant move, the cabinet on Thursday approved the complete waiver of interest and penalties amounting to Rs436.49 crore on KSRTC's outstanding short-term and long-term loans from the Kerala Transport Development Finance Corporation (KTDFC). This comes as a major relief to the cash-strapped state-run transport corporation.

Taking into account the ongoing monsoon and related challenges, the cabinet also sanctioned Rs 43.65 crore for coastal erosion prevention works in Pozhiyur (Thiruvananthapuram) and Kollamkode. The project will cover around 1.2 km of vulnerable shoreline, with technical assistance from the National Centre for Coastal Research (NCCR). A dedicated Project Management Unit will be formed to monitor the initiative, and the Kerala Infrastructure Investment Fund Board (KIIFB) has been designated as the special purpose vehicle (SPV) to execute the work.

Another major decision was the lease extension of 2.09 hectares of land in Cheruthuruthy village, in Thrissur, to the National Research Institute. The lease will now be valid for 25 years from May 25, 2021. The extension is aimed at supporting the institute's continued role in providing affordable healthcare services.

The cabinet also approved the electrification of 1,137 Scheduled Caste houses across Kerala. Of these, 1,097 houses will be electrified under the Central government's Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DA-JGUA) and the remaining 40 under the Revamped Distribution Sector Scheme (RDSS). Further, the government has decided to establish a new model residential school for Scheduled Caste students at Thonakkal in Thiruvananthapuram.

Haryana clerk issues birth certificate for dead person, faces Rs 6,000 fine

The Right to Service Commission has imposed a Rs 6,000 penalty each on two Haryana government officials for issuing a birth certificate to a man whose father died and delaying over four months in issuing a marriage certificate to a couple. The penalties will be deducted from the officials' salaries, of which a certain amount will be paid to the complainants as compensation. Rs 6,000 to be deducted from tehsildar's salary

Taking serious note of a four-month delay in issuing the marriage certificate, the Commission, invoking Section 17(1)(h) of the Right to Service Act, imposed a symbolic penalty of Rs 1,000 on the tehsildar-cum-marriage registrar of Hansi. The Commission further directed that a compensation of Rs 5,000 would be paid by the tehsildar from his pocket to the complainant.

On March 10, a Hisar resident applied for the registration of his wedding that took place on November 28, 2023, with the consent of his and his wife's parents in the delayed marriage registration category. The couple is domiciled in Haryana and has valid Family IDs, confirming their age and addresses. The

marriage registrar, however, raised an objection, citing the absence of birth certificates, and allegedly refused to issue the marriage registration certificate.

According to the complainant, "The tehsil office demanded hard copies of birth certificates and additional documents. Despite, as per the Haryana government guidelines, dated July 19, 2024, age and address can also be verified by Family ID. Therefore, no separate documents were required for verification."

"During the hearing before the Right to Service commission on July 15, the marriage registrar admitted that he relied on the statements of the marriage clerk and did not review the instructions. He acknowledged his mistake, expressed regret and assured the Commission that the certificate would be issued as early as possible. The Commission, however, viewed this as a case of serious negligence. Marriage registration is a service that the government offers with a set timeline of 5 to 7 days, and it should not have been delayed for four months. Had the officer followed the instructions on time, the certificate could have been issued much earlier," a Commission spokesperson said.

Haryana gets govt staff to vacate 34 houses, 24 others in Panchkula served notice

The Haryana government has intensified efforts to get houses allotted to its officials in Panchkula vacate in order to re-allocate them to judicial officers and employees, as per a recent direction of the high court.

A senior government officer told The Indian Express on Thursday that "34 out of the 58 identified houses have already been vacated by government staffers," and "notices have been issued to the occupants of the remaining 24 houses." The officer added, "They have been asked to vacate the houses by July 22 to ensure compliance with the high court's orders." On Tuesday, the Punjab and Haryana High Court directed the state government to reallocate 58 government quarters — currently occupied by employees from other departments — to judicial officers and staff within a week. "To the extent of the Chief Secretary admitting that 58 houses are

deficient in the 15 per cent pool reserved for judiciary, contempt appears to be, prima facie, made out," the Bench had observed. The court warned that failure to comply would result in the dismissal of the Haryana Chief Secretary Anurag Rastogi's appeal against contempt proceedings.

The court's direction came alongside an order for charges to be framed against Chief Secretary for non-compliance with a 2011 court ruling that mandated the reservation of 15% of general pool government quarters for judicial officers and court staff, in line with recommendations of the Shetty Commission and the Supreme Court. Following these directions, the Haryana Public Works Department (PWD) got 30 houses vacated in a jiffy. Sources said the department has reported the vacancy of 27 houses to the District and Sessions Judge of Panchkula.

A senior officer stated, "We have issued



vacation notices to current occupants based on the 'last come, first go' principle. The notice period is about to end. These employees live with their families and

naturally, need time to find alternative accommodation, which may be the reason for the delay in vacating the houses."

The contempt petition was filed by Rajesh Chawla, an employee of Panchkula District court, in October 2016, alleging wilful defiance of the high court's September 7, 2011, order directing the Haryana government to implement the Shetty Commission's recommendations and earmark 15 per cent of general pool government housing for judicial employees. Chawla had alleged that the government misrepresented facts by claiming to have allotted 38 houses from the district pool in Panchkula, whereas the directive pertained to the general pool comprising quarters in both Panchkula and Chandigarh. Arshdeep Bhullar, counsel for Chawla in the High Court, reiterated that "as per the order, the 58 houses must be vacated within one week."

New foreign policy for a news world

Sooner than later, India will have to make a choice where it stands. Perhaps more important, what India stands for. The Narendra Modi government's policy of multi-alignment brought good results for the country's foreign policy for most of Modi's time as prime minister. But with Donald Trump acting like a bull in the china shop of world order, multi-alignment, at its best, has exhausted all possibilities. It was inventive while it lasted.

India needs a new foreign policy. Exposed to the scorching heat of Trump's assaults on the existing order, the old policy is now like wine that tastes of wet cardboard. It emits an aroma similar to spoilt vinegar. The existing policy is no longer sustainable. Repackaging it in shimmering new Bohemian crystal will not make the old wine any better. It will not be potable, although the new bottle may draw praise. The old policy must be discarded. Or else, South Block will be stranded by the receding tide of history. In six months, Trump has decisively pulled the world away from multilateralism or even from plurilateral ways of advancing foreign policy. This may change if Trump does not complete his term for any reason, or if the next US president is either a Republican in the conventional mould or a Democrat. But India cannot wait for that. The challenge of adapting the country's foreign policy to the new global realities is urgent. Every single day's delay entails opportunity costs for 1.4 billion Indians whose aspirations, no longer circumscribed by the nation's borders, are at stake. India's biggest contribution at the recent BRICS summit in the enchanting city of Rio de Janeiro was to propose a new expansion of that acronym. As India prepares to succeed Brazil as BRICS chair, Modi told his co-leaders at the summit: "Our goal will be to redefine BRICS as Building Resilience and Innovation for Cooperation and Sustainability." That means BRICS will no longer be Brazil-Russia-India-China-South Africa. But in the Trump era, it falls short of hard bargains and transactional foreign policy. Modi is obsessed with catchy acronyms—his administration is peppered with them. If India does not innovate and reconfigure its foreign policy, it will soon dawn on those in the vanguard of the country's diplomacy that its ways are not working. Modi confidently said at Rio that "under India's BRICS chairmanship next year... just as we brought inclusivity to our G20 presidency and placed the concerns of the Global South at the forefront of the agenda, similarly, during our presidency of BRICS, we will advance this forum with a people-centric approach". The world has changed dramatically since India's G20 presidency and will have changed even more before BRICS leaders meet in India in 2026. Much thought and preparation ought to go into how the next BRICS chair is going to adapt to those changes. There is not a moment to waste. A bigger challenge for Indian diplomacy before its BRICS presidency will be the Quadrilateral summit of Australia, India, Japan and the US to be hosted by Modi later this year. Trump will not be travelling all the way to India to listen to niceties, which India is famous for in dealing with the mercurial US president. Trump will try within Quad to wreck the existing rules-based international order and impose his brand of unilateralism. External Affairs Minister S Jaishankar will be at his persuasive best through his long-time friend and US counterpart Marco Rubio to influence Trump into not wrecking this summit. If Jaishankar succeeds, India can proclaim victory like in Delhi G20, which was credible. But with Quad, any similar victory will be illusory. It will only signal that Washington doesn't care enough about the Quad and is letting its next summit be anodyne in outcomes.

RARE earths are in the spotlight as China's export curbs on these elements have disrupted output in a wide range of global industries. Automotive, electronics, defence, aerospace and renewable energy sectors have been hit as these minerals are essential for manufacturing critical components. India is facing this situation along with other countries, with the prospect of a slowdown looming large in the electric vehicle (EV) and automobile industries. The problem began in April when China's export restrictions came into force in response to the Donald Trump administration's threat of imposing high import tariffs. While the main target may have been the US, countries like India had to face red tape in sourcing these minerals, especially rare earth magnets needed for the EV industry. This prompted the belated recognition that such heavy reliance on China for minerals can have a crippling impact on industries in case supplies are cut off. It was the growing concern over this issue that evidently led to Prime Minister Narendra Modi's warning at the BRICS summit in Rio that critical minerals must not be 'weaponised'. It is not just rare earths, however, but several other minerals which are essential for sunrise industries like semiconductors. These include lithium, copper, zinc and uranium. Fast-growing economies like India need them to produce equipment of all kinds. The realisation that sources for long-term supplies need to be tied up, like in the case of fossil fuels, has prompted the latest round of resource-oriented diplomacy. The PM's recent overseas tour took him to mineral-rich countries where investments could yield dividends.

It is no coincidence that the countries he toured earlier this month are rich in resources. The African leg covered Ghana and Namibia, which are well known for mineral deposits of all kinds. Despite China having made inroads in terms of influence and investments in Africa, these two nations have longstanding ties with India.

In the case of Ghana, the relationship goes back to the Non-Aligned Movement and the friendship between Jawaharlal Nehru and Kwame Nkrumah. Proposals for investments to develop mineral resources in collaboration with Indian companies are thus being viewed favourably. Among the West African country's key mineral resources are gold, which is already a big import item, along with diamonds, bauxite and manganese. Even lithium reserves have been discovered there recently. As for Namibia, the warm relationship goes back to the days of India's support for its independence movement. The highlight of the visit, the third by an Indian PM, was collaboration in mineral exploration as well as digital financial infrastructure. Namibia can be a valuable ally in providing resources like uranium for India's nuclear energy programme. It is also a major diamond producer, but the gems normally reach here through intermediaries. Direct trade, which

will be mutually beneficial, is now being talked about. The focus was on resources during the Latin American leg of the trip as well. The bonhomie witnessed in Argentina was based on an expanding economic relationship involving the development of mineral resources. Indian state-owned companies have already begun collaborating in exploration and mining of that country's huge lithium reserves. Argentina forms part of what is

locate. They are considered rare owing to their dispersed nature, which makes mining difficult and not economically viable at times. China has not imposed an explicit ban on exports to India, but some restrictions have been introduced for seven rare earth elements. Persistent delays in availability could have a serious impact in the coming days, especially as these minerals are used in a wide range of hi-tech industries.



known as the Lithium Triangle. Other members of this triad are Bolivia and Chile; the latter has the largest lithium reserves in the world.

India's scramble to ensure that it has access to lithium in countries like Argentina is because of the pivotal role of this mineral in lithium-ion rechargeable batteries. These are an integral element of a wide array of consumer electronics, such as mobile phones, laptops and tablets. They are indispensable for the manufacture of EVs and medical devices as well as in renewable energy storage systems. Lithium is also needed in the aerospace and automotive industries. Minerals were high on the agenda of the India-Brazil meetings in Rio following the BRICS summit. Plans were discussed for joint exploration, mining, processing, recycling and refining of minerals. Brazil has the world's third largest reserves of rare earths. However, it has only recently begun mining, with commercial production having started from its first mine last year. Rare earth elements, incidentally, are not termed such because reserves of these 17 minerals are difficult to

The resource-linked diplomacy is thus a pragmatic attempt to ensure that the country's development is not hampered at any stage by a shortage of these critical minerals. At the same time, it is high time India stepped up exploration and processing of minerals within its own borders. It has one of the largest reserves of rare earths—the fifth in the world at 6.9 million tonnes—but has done little in the way of exploitation of these resources. One reason has been difficulty in extraction as they are tied to radioactive minerals like thorium. It is not too late to start the process. The National Critical Minerals Mission was launched this year with an outlay of Rs 36,000 crore over a seven-year period. It is aimed at ensuring self-reliance in critical minerals by raising investments in exploration, expanding domestic output and acquiring assets abroad. In the meantime, imports must be sourced from multiple suppliers to prevent disruption to industrial production. It is here that PM Modi's Global South tour should help in making assured sources of supply available for immediate needs and in the long run.

Being 'saare jahaan se achchha' in space too

Group Captain Shubhanshu Shukla became the second Indian in space after Squadron Leader Rakesh Sharma's April 1984 sortie to the Soviet Salyut 7 space station. The 41 years between the two have witnessed significant progress in space technology

At 3.02 pm on Tuesday, Group Captain Shubhanshu Shukla (call name Shux) and his three crewmates' space mission ended with the textbook splashdown of their return capsule in the Pacific Ocean off California. The Axiom 4 mission, which entailed 18 days of experiments and observations aboard the International Space Station (ISS), created history for the Indian space programme. Shux became the second Indian in space after Squadron Leader Rakesh Sharma's April 1984 sortie to the Soviet Salyut 7 space station. The 41 years between the two have witnessed significant progress in space technology. Therefore, a comparison between Sharma's eight-day venture then and Shux's 18-day mission now would be unfair. Besides, while the former mission was more of a diplomatic endeavour between India and the then USSR as a result of Cold War coddling; the Ax 4 mission was a commercial, public-private venture involving collaboration between Nasa, Indian Space Research Organisation and European Space Agency on one side, and Axiom Space and SpaceX on the other. Arifical



Intelligence uses Arifical Intelligence uses The experiments conducted four decades apart by both Sharma and Shux will be immensely relevant for India's own maiden manned space mission, Gaganyaan, in 2027. Sharma was part of a crew that conducted 43 experiments including a pioneering study of the impact of yoga on the human body in microgravity; other biomedical studies assessing the effect of weightlessness on the body; remote


sensing studies that later helped Indian satellites map natural resources; and material science studies. Communication with Earth—as crucial then as it's now—saw Prime Minister Indira Gandhi asking Sharma how India looked from space, to which the air force officer famously replied, "Saare jahaan se achchha."

Shux conducted seven experiments as part of the Ax-4 crew, which included growth and radiation response of edible algae; muscle regeneration with supplement treatment in zero-gravity; microgravity growth of methi and moong seeds; resilience and ageing patterns of tardigrades (microscopic creatures called 'water bears'); cognitive testing with in-flight displays; comparative growth of proteins in cyanobacteria in microgravity; and the impact of microgravity on crop seed physiology. In his last words to the nation before leaving the ISS, Shux echoed Sharma with confidence and pride that India looks better than all other lands even today. The ambitious missions ahead will provide India ample opportunities to prove it in space as well.

In digital arrest cases, golden hour crucial for cops to act

Banks must evolve from transaction facilitators to proactive cybersecurity partners

DIGITAL arrest is not a legal term but a cyber extortion scam where victims are coerced by impersonated officials into paying money or sharing data. Digital arrest scams operate like global corporations. At the base are mule accounts—bank accounts run by coerced or unaware individuals to move stolen funds. The middle tier includes scam centres with trained staff impersonating officials through fake calls and documents. At the top, masterminds control strategy and finances from abroad. Funds are routed through layers of mule accounts, shell firms, forged cards and cryptocurrency to evade detection. In digital arrest scams, the "golden hour"—the first four hours after a fraud—can determine whether funds are recovered or lost. During this window, banks flag suspicious activity while police act with intelligence and investigation. Swift coordination is key to disrupting the scam in real time. Banks must evolve from transaction facilitators to proactive cybersecurity partners. With scammers using spoofed identities, leaked data and fake authority setups to instil fear even in educated victims, banks are well-positioned to detect and block fraud in motion. AI- and ML-driven systems should flag anomalies like large or rapid transfers, new payees or sudden liquidations. Integration with the DoT's Financial Fraud Risk Indicator (FFRI) allows real-time risk profiling of mobile numbers and automatic blocking or delay of high-risk transactions. Verification must be strengthened with behavioural biometrics (unique



user habits) and device fingerprinting (device traits), to prevent unauthorised access. Tackling mule or temporary accounts used to move stolen funds and shield culprits is critical. A 2024 BioCatch report found each mule-linked device in India accessed 35 accounts on average, with

hotspots in Bhubaneswar, Navi Mumbai and Lucknow. Fraudsters lure individuals via fake job offers or agents, sometimes aided by bank insiders. Banks must use advanced analytics to spot suspicious patterns like frequent small deposits followed by large withdrawals and enforce strict

KYC during account opening. Customer education is equally vital. Banks should run continuous awareness campaigns via SMS, email and social media to alert users about red flags like isolation tactics, fake legal notices or coercive video calls. Equally important is real-time coordination with Indian Cyber Crime Coordination Centre (I4Cs) 1930 helpline and NCIP portal. Acting within the golden hour greatly improves chances of fund recovery through swift freezing and tracing of money trails.

The police should increasingly adopt pre-emptive cyber intelligence operations to intercept scams in real time. Recently, the Tamil Nadu Cyber Intelligence Wing detected two digital arrest scams in Coimbatore. Officers reached a doctor's home just in time; he had already lost Rs 2.9 crore and initially refused to open the door, believing the arrest was real. The case highlights both the seriousness of such scams and the value of timely intervention. While the police don't monitor bank activity directly, they can act swiftly through closer collaboration with financial institutions via the Citizen Financial Cyber Fraud Reporting and Management System (CFCFRMS) platform.

The police should combat digital arrest globally via Interpol operations like First Light and HAECHI V to dismantle cross-border syndicates. Ultimately, banks detect, the police intervene, forming a hyperlocal cyber shield. Swift action, strong coordination and public vigilance are key to stopping these scams.

Eyes in sky: Real-time monitoring to curb land use changes in Nuh Aravalis

Satellite image-based monthly reports to identify non-forest activities and usage of drones for real-time monitoring — these are among a slew of measures to secure Nuh Aravalis and stop land use changes. Investigations have revealed how forest and revenue land in the Aravalis is being systematically exploited through coordinated illegal mining.

To stop the plunder, two drones will be deployed to monitor and track illegal activities in the hills of Nuh. Forest officials said the drones will provide real-time imagery and help detect violations such as illegal constructions, land-use change, mining, deforestation and encroachments. This move follows a major illegal mining case registered in Basai Meo, in which several people — including the sarpanch, officials from mining, revenue and forest departments along with private contractors — were booked by the state vigilance and anti-corruption bureau (SVACB). Land row stalls metro project, panel to break deadlock over Gurgaon Cyber City station

The Haryana govt set up a high-level committee to resolve the impasse over finalisation of the proposed Gurgaon metro station at Cyber City. According to a GMRL official, the revised route of the new metro corridor cannot be finalised until the issue over the planned NCRTC's station, proposed on HSIIDC land near Shankar Chowk, is settled.

To address this issue, the state has now constituted a six-member committee, which is to submit its report in a month, and is chaired by ACS (town & country planning) AK Singh. Its members include GMDA CEO Shyamal Misra, GMRL MD Chander Shekhar Khare, HSIIDC MD Yash Garg, chief project manager, NCRTC, and deputy commissioner Ajay Kumar. The move comes after a meeting of high-powered committee (HPC) held last month under the chairpersonship of chief secretary Anurag Rastogi, where the finalisation of alignment was flagged by GMRL as a major hurdle to the project.

During the meeting, the HPC held discussions on finalising the location of the NCRTC station at Cyber City, and HSIIDC raised objections to it due to potential disruptions to road traffic. Meanwhile, NCRTC expressed its inability to shift the station to another location owing to a sharp curve in the alignment. It was decided that a detailed traffic impact study should be undertaken to evaluate the concerns.

According to sources in GMRL, HSIIDC was "not keen" on giving land for the proposed NCRTC station at Shankar Chowk. "The metro station is planned in the same vicinity. But until the NCRTC station's location is finalised, we cannot lock the alignment. The integration point at Cyber City needs to be planned carefully to ensure seamless commuter transfer between systems," the senior GMRL official said.

Moreover, an alternative site for the station — near Institute of Pesticide Formulation Technology — is under consideration, but this land belongs to

drone surveillance, the forest department is also planning to analyse satellite image-based monthly reports to identify non-forestry activities within notified Aravali areas. If any such changes are observed, strict action will be taken as per law. The aerial surveillance will be conducted with the support of the Drone Imaging and Information Service of Haryana Limited (DRIISHYA). South Haryana conservator of forest Subhash Yadav said, "The idea is to ensure early detection of changes in land use and initiate timely action." To build awareness among stakeholders, a workshop is scheduled by the end of this month. It will focus on educating local authorities, village representatives and residents about Aravali forest laws, various notifications and types of violations, Yadav said. Earlier this month, the forest department blocked two illegal roads in Nuh's Basai Meo village by planting around 7,500 saplings. The two roads were carved out by the mining mafia to gain access to the ecologically



sensitive Aravalis to carry out quarrying. To permanently obstruct these entry points and restore the damaged area, the forest department converted them into green zones through rapid afforestation. Basai Meo has been under scrutiny after revelations of illegal road construction and mining on forest and agricultural land, directly contravening the Supreme Court directives and environmental norms. SC has prohibited mining in the protected Aravali region,

which includes parts of Nuh, to conserve the fragile ecosystem and prevent further environmental degradation. The apex court banned mining within 5km of Delhi in 2002 and imposed a blanket ban on mining in south Haryana in 2009 after observing significant damage to the Aravalis. A 2018 report by the SC-appointed CEC noted that approximately 25% of the Aravali range was lost due to illegal mining in Rajasthan between 1967 and 1968. The Aravalis in Nuh face constant pressure from illegal mining, land clearing and construction. Continuous monitoring and stakeholder participation are crucial for their protection. This move comes amid growing concerns over the degradation of Haryana's Aravali landscape, especially in districts like Nuh, where forest protection laws such as the Punjab Land Preservation Act (PLPA), 1900, and central forest notifications are often violated.

Infrastructure lapses exposed: Drowning in drain sparks demand for safety steps

Gurgaon: The worst fears of residents came true when body of a 22-year-old man, who had been missing for three days, was found in an under-construction drain along Hamilton Court Road. The incident sparked outrage among locals and highlighted the safety gaps on sites of ongoing civic projects in the city. GMDA is carrying out a project to renovate the stretch at a cost of Rs 21 crore. It was undertaken by the authority in Feb 2024 and was to be completed within 12 months, but only 50% of the work has been completed. Meanwhile, residents have been complaining for months about the poor condition of the stretch, pointing to uncovered drains, lack of proper barricading, and inadequate lighting.

Despite several reminders to GMDA, no corrective measures were taken, they said. "It is a dangerous stretch — cars get stuck here often. A few weeks ago, a cow was found trapped in a drain pit here. There is no space left for pedestrians. The work is being executed in a shoddy manner, with

no proper planning. The road was revamped with a footpath ahead of the G20 summit in 2023, and then they started tearing it up again in 2024," said Col Pravin Uberoi (retd), a resident of Sushant Lok-1. "There is no barricading or

signages on the stretch and streetlights malfunction frequently. We have been facing these issues for the last one-and-a-half years," Uberoi added.

The recent incident of drowning at the site has intensified demands for a safety audit and strict accountability from the authorities, with many residents saying

the tragedy could have been averted.

"There is absolutely no monitoring of the stretch. They dug up everything and left it unattended. The contractor has also damaged sewer and electricity lines during digging. If someone is killed due to negligence, those responsible should be held accountable. Until accountability is fixed, such tragedies will keep happening," Anil Kapoor, another resident, said. Meanwhile, a GMDA official said safety protocols were part of every contract they signed. "They are mentioned in the agreement we sign with the agency. All terms and conditions regarding pollution mitigation and safety measures are clearly stated in the contract. While some safety measures were taken, they were not fully implemented," he said. The official added that instructions had been issued to all field officers to ensure that contractors strictly followed safety protocols. Reacting to the police notice served to GMDA in the case, the official said, "It's an ongoing investigation. We have responded to the notice."

Elusive warbler spotted in Ladakh, its first official sighting in 46 years

At an elevation of 3,200 metres, Ladakh's rugged mountain sweep in the backdrop, a group of five sat huddled and listened intently to the 'click-click-click' captured in a recording. The insect-like call was proof that one of the most elusive bird species they had come looking for was there. Visual proof came soon enough, making July 15 the day when a confirmed sighting of the long-billed bush warbler would be recorded after 46 years. The tiny brown bird was trilling from a thicket in Kargil's Suru Valley. The last time the bird (Locustella Major) was seen was also in Ladakh in 1979, when a group of birders from Southampton University were on a tour (1977-80) to chronicle the region's avian fauna. Between 1979 and now, only one more sighting of the long-billed bush warbler was documented when ornithologist James Eaton spotted it in Naltar Valley of Gilgit-Baltistan in 2023. The current expedition to Ladakh by five

birders — Harish Thangaraj, Lt Gen Bhupesh Goyal, Manjula Desai, Rigzin Nubu and Irfan Jeelani — was planned specifically to spot this rare warbler.

Team leader Thangaraj told TOI the group

"has years and years of experience sighting birds" and "what we are now looking for are 'lost birds' — that were spotted decades ago but were never seen since". "There are more such birds on our

lister," he added. Earlier this year, in Feb, the group had made another expedition in search of the bird but failed to spot it. "We searched in Gurez and Tulail valleys at altitudes between 2,400m and 2,800m.

But it yielded no results, possibly because of altitude mismatch," Thangaraj said, referring to the Gilgit-Baltistan sighting, which was at a higher reach.

After the first unsuccessful attempt, the group stepped up research and got in touch with Eaton for an insight into the warbler's habitat.

It was the Malaysia-based ornithologist's knowledge that steered them on the right path — in this case, near terraced fields surrounded by rumex and gooseberry shrubs at Sankoo in Suru Valley. Eventually, the bird was found in a willow amidst terraced fields. It's the first time the warbler has been seen on a willow, which will now be added to its known habitats," Thangaraj told TOI.



From 140 to 41: Far from clean but Gurgaon jumps up 99 spots in Swachh rankings

Amid construction debris that blight the scenic Aravalis on Gurgaon-Faridabad road and garbage dumps strewn on streets that paint a grim picture of sanitation struggles, the city has made a leap in its Swachh Survekshan ranking, moving from 140 to 41. The rankings, announced on Thursday, place Gurgaon in the category of cities with populations between 3 lakh and 10 lakh, a change from last year's category of over 1 lakh. However, this shift in categorisation does little to conceal the city's struggles with effective garbage management. The city's report card reveals a decline in several key areas. Door-to-door waste collection has dropped from 85% last year to just 59% this year. The decline is attributed to the civic body's decision to terminate its contract with the previous solid waste management concessionaire and hire a private firm for doorstep waste collection for one year. Residents have consistently complained about irregular services, noting that instead of deploying a new team, the contractor outsourced the work to vendors already operating in different parts of the city. Also, source segregation — essential for effective waste management — has worsened from an already low 15% to a mere 10%. Residents express a willingness to

engage in source segregation, but the lack of infrastructure such as vehicles with compartments for transporting segregated waste, facilities for dry waste, e-waste, composting pits for wet waste processing and material recovery facilities, are hindrances in their efforts. In cities like Indore, which consistently ranks first in the Swachh rankings, residents segregate waste into six streams — dry, wet, domestic hazardous, plastic, sanitary, and e-waste — and collection vehicles are equipped with six compartments to transport these streams, ensuring complete segregation. Indore achieves 100% waste segregation, according to the survey. Gurgaon's improved ranking is attributed to progress in several areas, according to the Swachh survey.

Dumpsite remediation has increased from 22% to 50%, residential area cleanliness has risen slightly from 86% to 90%, waterbody cleanliness has improved from 80% to 100%, and waste processing versus generation has advanced from 93% to 98%. In contrast, Manesar received a lower ranking of 574 in the category of cities with population between 50,000 and 3 lakh. In its affidavit to National Green Tribunal (NGT) in April, MCG reported progress in remediation at dumpsites, whereas courts, NGT have been snubbing MCG for its waste processing at Bandhwari. I've visited several cities but have not

seen a city as dirty as Gurgaon," said Chaitali Mandotra, a resident of Ardee City and co-convenor of United Gurugram RWA. Former joint secretary at Cabinet Secretariat Kundan Lal Sharma, who lives in the city said, the city's leap from 140th to 41st place in national sanitation rankings is a clear signal. "Waste management in the city is not an insurmountable problem. It is, in fact, highly manageable — provided the right decisions are taken and the right people are empowered. The city doesn't need more cosmetic clean-ups or celebratory hashtags. It needs ground-up redesign of its governance model, rooted in capacity-building, decentralisation, and co-governance with its residents," he added. MCG commissioner Pradeep Dahiya attributed the city's 41st position to teamwork. "Our representatives, sanitation workers, officials and citizens have collectively achieved this, but there is a lot of scope for improvement. We are continuously striving to ensure that in the next cleanliness survey, the city is ranked among the cleanest cities in the country.

The corporation will prioritise speeding up waste disposal, increasing doorstep waste collection, waste segregation green zone development and cleanliness awareness campaigns," he said.

Bandhwari landfill. From Jan to Dec 2023, approximately 16.5 lakh metric tonnes (MT) of waste were processed. The following year, from Jan to Dec 2024, this figure increased to 17.5 lakh MT. Despite these efforts, over 12 lakh MT of waste remains unprocessed at the landfill. Recent MCG data suggests that in the last six months, only 2 lakh MT waste has been processed. The city's improved ranking comes despite being under Solid Waste Environment Exigency Programme (SWEEP) for over a year. The state govt declared a solid waste exigency in the city on June 12, 2024. Garbage management, which the corporation failed to handle effectively, was transferred to a committee tasked with implementing the exigency programme. From April 1, 2024 to June 30, 2025, MCG spent Rs 348 crore on sanitation. Residents are sceptical of the rankings. "Garbage scattered across the city is not a surprise. Instead, a leap of 100 points in Swachh rankings is a surprise for us. It's either that the other cities are worsening their performance or there is manipulation of data. Construction work leaves uneven patches on Dwarka Expressway tunnel on Gurgaon side

Gurgaon. (Agency)

Barely months after it opened to the public, the ride into the newly constructed tunnel on Dwarka Expressway towards the city is far from smooth. A portion at the tunnel's entrance on the Gurgaon side was dug up last week for cable-laying work, leaving commuters to navigate an uneven patch. At times, barriers are placed along the side, further restricting movement.

The 1.5km tunnel is part of the Dwarka Expressway that connects the expressway to NH8 towards Gurgaon. It was opened on trial in May this year. It was aimed at improving connectivity from Delhi's Dwarka and IGI airport to Gurgaon. While National Highways Authority of India (NHAI) claimed the dug-up portion was temporarily restored with concrete, the final bituminous layer is still pending. A senior NHAI official said, "There was subsidence due to some cable works. The trench was refilled with concrete. The final blacktopping will be done once the weather is dry." Commuters say the current surface makes for a jerky and uncomfortable drive. "The tunnel was supposed to be a smooth, signal-free experience, but the ride right at the entrance is uneven and poorly patched. The concrete patch and the abrupt gradient change give you a jolt while entering. For the last week, it has been a bumpy ride. It doesn't feel like a newly opened road," Umesh Rawat, a resident of Sector 109, said. Shashank Mittal, a resident of Dwarka Sector 22 who commutes daily to Gurgaon through the tunnel, echoed similar concerns. "There is a noticeable depression right at the tunnel's entrance. Sometimes they place barricades, allowing only one vehicle to pass at a time, which causes bottlenecks — especially during peak hours," he said. At another stretch on the Dwarka Expressway near the Bijwasan railway underbridge (RUB), opposite BPCL depot, a section of the road surface has settled, posing difficulties for commuters coming from Mohammadpur Shahbad, Sector 8, and Sector 21.

How much fat in a samosa? Noida schools to put up oil boards

After 'sugar boards', oil boards will be the next caution that schools affiliated with CBSE will advertise on campuses to discourage students from having processed and fried foods and promote healthy eating habits. The Central Board of Secondary Education (CBSE) on July 15 issued a circular, asking all schools to display 'oil boards' in common areas such as cafeterias and lobbies. On these digital or physical posters, the circular said, schools must list out fat or oil content in different food items, such as 28g fat in one piece of samosa, 10g fat in a kachori, and 17g fat in a handful of fries.

The move, the board said, was announced keeping in view the trend of rising obesity levels among youngsters across India. Data points out that there is a sharp rise in obesity among both adults and children. As per NFHS-5 (2019-21), over one in five adults in urban areas are overweight or obese. According to The Lancet GBD 2021 obesity forecasting study, published in 2025, the number of overweight and obese adults in India is projected to rise from 18 crore in 2021 to 44.9 crore by 2050, making it the country with the second-highest global burden. The prevalence of childhood obesity is impacted mostly by poor dietary habits and reduced CBSE's directive is similar to the notice issued on May 14, which asked all schools to display 'sugar boards'.

Parents and school managements in Noida and Ghaziabad said on Thursday that it was an important initiative. "We wholeheartedly welcome CBSE's directive to display 'oil boards'. This is a vital extension of the earlier 'sugar board' initiative, and it reflects a strong, unified approach to tackle childhood obesity and unhealthy dietary habits. ed physical activity," the circular read.

Over 80 Delhi, Bengaluru schools get bomb threats: What's the law to deal with it

Multiple schools in Delhi have been targeted with bomb threats, prompting immediate police action. The incidents highlight the legal framework and response measures in place to address such threats, impacting school operations.

Agency New Delhi.

A wave of unsettling bomb threats gripped several schools in Delhi and Bengaluru on Friday, prompting immediate and rigorous responses from law enforcement and school authorities. While 40 private schools in Bengaluru received threats, which mentioned, "you all deserve to suffer", 45 schools in Delhi received similar threats. Many of these emails have turned out to be hoaxes, but the incidents have caused widespread panic and disruption, putting a spotlight on the legal repercussions for those responsible.

Upon receiving the alerts, teams from the police, fire service, bomb disposal squad, and dog squad rushed to the affected schools. This is standard procedure for any bomb threat, whether it targets a market, hospital, school, or aircraft, and agencies treat such calls with the utmost seriousness, even if they are likely hoaxes.

Court backs divorce after wife fails to respond to husband's reconciliation efforts

The Bombay High Court has upheld a divorce decree granted by the Pune Family Court, observing that the wife made no sincere effort to resume cohabitation despite the husband's attempts to reconcile, including moving out of his family home and renting a separate apartment for them.

The couple, who married on December 12, 2013, separated just a year later in December 2014. Matrimonial proceedings began in 2015.

The wife had approached the High Court, challenging the Family Court's 2019 judgment which dismissed her petition for restitution of conjugal rights and allowed the husband's counterclaim for divorce.

The bench of Justices Revati Mohite Dere and Dr. Neela Gokhale noted that repeated mediation attempts had failed. The court also took note of the husband's unchallenged testimony that he had rented a flat and invited his wife to live there, but she never showed up.

The wife's allegations included harassment by in-laws, being forced to do housework and pressure to agree to mutual divorce. She also claimed her jewellery was taken and that her consent to the divorce was obtained by force. However, the court found contradictions in her statements, including her own admission that the household had multiple servants.

The husband, on the other hand, sought divorce on grounds of cruelty and desertion. He alleged that the wife left without notice, mistreated his specially-abled sister, refused physical intimacy and made false accusations of extra-marital affairs.

The High Court held that the wife's conduct amounted to cruelty, noting her humiliating behavior in front of others and indifference towards the husband's family. The court said, "The husband's unrefuted evidence clearly shows he suffered mental cruelty."

The bench concluded that the marriage had irretrievably broken down. It also rejected the wife's claim that she was deserted, noting that the husband had taken steps to live separately from his family and offered her a chance to rebuild the relationship.

Why can't same-sex partner be medical proxy: Court asks government, medical body

The Delhi High Court on Thursday asked the Central Government and the National Medical Commission (NMC) to explain why same-sex couples are not allowed to make medical decisions for each other as "medical proxies." Justice Sachin Datta issued a notice to the Centre and NMC and sought their response by October. "Why can this benefit not be extended to non-heterosexual couples? What is the procedure for people who live alone and only have friends nearby?" the judge asked. The court was hearing a plea filed by Arshiya, a Delhi-based businesswoman. She married her partner, also a woman, in New Zealand in 2023. Both are Indian citizens living in Delhi. Her partner works as a lawyer.

The petition challenges the National Medical Commission Registered Medical Practitioner (Professional Conduct) Regulations, 2023, which allow only family members such as a spouse or parent to make medical decisions if a person is hospitalised and unable to decide for themselves.

The petition highlights that while the Supreme Court's 2023 *Supriyo* judgment called for policy changes to recognise queer couples, the government has failed to act, especially in allowing same-sex partners to act as medical proxies during emergencies. Senior advocate Saurav Kirpal, appearing for the petitioner, said many LGBTQ+ persons are estranged from their families and may not have relatives nearby to make such decisions.

The petition, filed by advocates Manjira Dasgupta and Bhargav Ravindran, seeks court directions to allow hospitals and doctors to recognise non-heterosexual partners as medical representatives. Alternatively, it asks for a declaration that a medical power of attorney given in advance to a non-heterosexual partner should be valid. Currently, Clause 7.16 of the Indian Medical Council Regulations, 2002 allows consent only from a "husband or wife, parent or guardian in the case of a minor, or the patient himself." In this case, Arshiya's partner's family does not live in Delhi. The couple argues that, under the existing rules, they would be unable to make critical decisions for each other in a medical emergency.

Many schools declared an early dismissal as a precautionary measure. Given the high-profile nature of the targeted schools, the Delhi Police immediately launched an investigation, involving both local police and cyber units. Investigations revealed that the email sent to the Dwarka school on July 15 was from a 12-year-old student. After tracking down the child, police focused on counselling him to understand the motive behind his actions. His parents were also advised to monitor their child more closely.

However, the individuals behind the emails sent to other Delhi schools on July 16 and July 18 are still under investigation. Previous incidents show a pattern, with a 12th-grade student being identified as the sender of multiple hoax emails between

February 2024 and January 2025. Police sources indicated that this student claimed to have sent the emails as a "joke". In some

Under the BNS, individuals making false bomb threats can face charges under several sections, including:

Section 176 - Giving false information with intent to breach public peace: This section applies if a person knowingly gives false information that causes fear, panic, or disorder, such as a bomb threat. It carries a punishment of up to five years imprisonment, a fine, or both.

Section 353 - Obstructing public services: False bomb threats disrupt essential services like police, fire, and administration. Violators can face up to five years imprisonment, a fine, or both.



45 Delhi schools get bomb threats. Over 50 such incidents this week

More than 45 schools in Delhi received bomb threats on Friday, triggering panic and prompting the evacuation of students. This was the fourth day of bomb threats targeting over 50 schools in the national capital.

Simultaneously, 40 private schools across Bengaluru also received bomb threats. "I will erase every last one of you from this world. Not a single soul will survive... You all deserve to suffer," the threat email read.

Among the schools that received threatening emails were Richmond Global School, Delhi International Public School, Maxfort Junior School and Guru Nanak School in Pitampura, six schools each in Dwarka and Rohini. Teams from the Delhi Police and fire department were rushed to the

schools and thorough search operations were launched. However, the threats were found to be hoaxes in most schools. In the first three days of this week, 11 schools and one college



in Delhi received similar threat emails.

ATISHI ATTACKS BJP
Former Chief Minister and AAP leader Atishi, who previously headed the Education department, accused the BJP government of failing to provide

"safety or security to our children". "More than 20 schools have received bomb threats today! Think of the trauma that children, parents and teachers would be going through. The BJP controls all 4 engines of governance in Delhi, and is not yet able to provide any safety or security to our children! Shocking!" Atishi tweeted. On Wednesday, Delhi witnessed a similar wave of bomb threats to schools across the national capital. However, nothing suspicious was found after the schools were thoroughly checked.

A 12-year-old student was detained for sending a bomb threat to St Thomas School in Dwarka, PTI reported. "He was counselled and handed over to his family members," Deputy Commissioner of Police (Dwarka) Ankit Singh said.

"Chief Minister Siddaramaiah passed away yesterday multilingual star, senior actress B. Took darshan of Saroja Devi's earthly body and paid his last respects," the post's faulty translation read.

'PAUSE KANNADA AUTO-TRANSLATION'

Reacting strongly to the faux pas, the Chief Minister asked social media platforms to

act responsibly and urged Meta to suspend its Kannada auto-translation feature until it is accurate.

"Faulty auto-translation of Kannada content on Meta platforms is distorting facts and misleading users. This is especially dangerous when it comes to official communications. My media adviser, KV Prabhakar, has formally written to Meta urging immediate correction," Siddaramaiah tweeted.

"Social media platforms must act responsibly. I caution citizens to be aware that translations shown are often inaccurate. Such negligence by tech giants can harm public understanding and trust," he further said.

Meta seemed to have corrected the

translation later.

"I don't want to commit that I want to get into coaching. But yes, I would definitely like to help out," the former India women's number one custodian said.

As a result, he etched his name in the record books, registering the second highest match aggregate in a Test of 430 runs and was also adjudged Player of the Match in India's 336-run victory.

England reach Euro 2025 semis after shootout win over Sweden

England will face Italy, who are in the last four for the first time since 1997, in Geneva on Tuesday after a rollercoaster comeback.

England roared into the semi-finals of Women's Euro 2025 on Thursday after coming back from two goals down and then beating Sweden 3-2 in a chaotic penalty shoot-out to continue their title defence. Smilla Holmberg blasted over from the spot to settle the shootout drama in Zurich after the match finished 2-2 thanks to Lucy Bronze and Michelle Agyemang's quick-fire strikes just as England looked to be limping out of the tournament. The reigning European champions were staring at elimination with 11 minutes remaining in normal time after Kosovare Asllani, who opened the scoring with her 50th international goal in the second minute, and Stina Blackstenius shot Sweden into a two-goal lead at half-time. "That was



one of the hardest games I have ever watched. We could have been out four or five times," England boss Sarina Wiegman told the BBC. "We started badly. We didn't create anything so we changed shape and we scored two goals which was crazy. The shootout, we missed a lot but they missed more and we're through." England will face Italy, who are in the last four for the first time since 1997, in Geneva on Tuesday after a rollercoaster comeback. "Not how we planned it to be, of course, but it's a learning experience that we

put in our back pocket and learn from going forward," Chloe Kelly, who was key to both England goals and took one of the few good penalties of the shootout, told reporters.

Gill, 25, who had scored three centuries - including a career-best 269 - in the first two matches, was dismissed for just 6 in the second innings after the verbal altercation, which occurred moments before stumps on Day Three. India went on to lose the Test and now trail 1-2 in the five-match series. "The thing with Virat Kohli was that he would get even more fired up and become a better batter [if things got nasty].



What disappointed me with Shubman Gill - and that's why I was wondering, where is Shubman Gill heading? - because that seemed like it didn't have the right effect on Shubman Gill the batter," Manjrekar said on ESPNcricinfo's Match Day.

Gill arrived at the Home of Cricket in scintillating form, having already amassed 485 runs in the series. But unlike his previous innings - where he often faced an older, softer ball - the fourth innings presented a sterner challenge: a fresh new ball on a tricky surface. According to Manjrekar, the extra spotlight Gill drew upon himself with his actions may have only

made his job harder. "If Shubman Gill had that kind of a fiery side to him, we would have seen it a little earlier. You don't have to show it when you're captain. Or did he show it because he's got this confidence now that he's won a Test match and scored so many runs?" Manjrekar questioned. "Because with Virat Kohli, you could see he was ready for a scrap. He was always looking to get into the thick of things - even before he was captain. That was a trait we saw early on. With Shubman Gill, I've never seen it before." With an eight-day break before the fourth Test, Manjrekar feels the timing is ideal for Gill to regroup and reassess his mindset - both as a leader and as a batter.

"I think this break of eight days is perfect for him. There are a lot of good people around him. His father - who played a big part in his cricketing journey - would know his son better than anyone. Whether he's a Virat Kohli, a potential Kohli, or an [MS] Dhoni - or somewhere in between. I'm guessing somewhere in between. So he's got to find his own way. But whatever that way is, it has to enhance his leadership qualities and make him a better batter," he added.

With the Anderson-Tendulkar Trophy still on the line, all eyes will be on how Gill responds - not just with the bat, but in how he embraces pressure and leads from the front in what has become a riveting series.

Arsenal pays world record women's soccer transfer fee to sign Olivia Smith from Liverpool

→ Arsenal is a 15-time English champion and won the Champions League for the second time in its history last season.

Olivia Smith became the most expensive player in women's soccer history Thursday when she joined Arsenal from Liverpool for a world record transfer fee of 1 million pounds (\$1.34 million). The new benchmark in women's soccer surpasses the 900,000 pounds (\$1.1 million) Chelsea paid for Naomi Girma from San Diego Wave in January. "She's one of the most talented young players in the game and has huge

potential for further development here at the club," Arsenal director of women's football Clare Wheatley said. The 20-year-old Canada forward signed a four-year deal, a person with knowledge of the contract told The Associated Press. The person, who also confirmed the record fee, spoke on the condition of anonymity because the full details of the transfer have not been made public. Smith's deal highlights the rapid increase in spending in women's soccer with transfer records regularly broken in recent years. Zambia striker Racheal Kundananji set a new record when joining Bay FC from Madrid CFF for \$788,000 last year, and that figure was quickly exceeded by Girma's move to Chelsea, becoming the first \$1 million women's soccer player. As recently as 2020, the most expensive women's player was Denmark's Pernille Harder, who joined Chelsea from Wolfsburg for \$355,000. England's Keira Walsh left



Manchester City for Barcelona in 2022 for a deal worth \$513,000, and Chelsea broke the record again in 2024 when signing Mayra Ramirez from Levante for \$542,000. But those figures are still a long way behind the men's game where Neymar remains the record signing following his 2017 move from Barcelona to Paris Saint-Germain for \$262 million. Kylian Mbappe joined PSG for \$216 million and is the second most expensive player of all time. After one season

at Penn State, Smith joined Sporting Lisbon in 2023 and scored 16 goals in 28 appearances. She moved to Liverpool last year and scored nine times in 25 games.

Smith is also Canada's youngest international after making her debut at 15 in 2019.

"Olivia is an exciting young player and we believe she can make a big contribution here at Arsenal," head coach Renee Slegers said. "We've been impressed by her mentality and character, excelling in two European leagues at such a young age." Arsenal is a 15-time English champion and won the Champions League for the second time in its history last season. Despite Chelsea being the dominant force in women's soccer in England, Arsenal is the only English team to win the Champions League. "It's my dream to compete for the biggest titles here in England and in Europe and I'm excited to get started and contribute to doing that here with Arsenal," Smith said.

ITR-2 online filing live: Know who can file, new changes and other details

New Delhi. (Agency)

The Income Tax Department has now made it possible to file ITR-2 online for the financial year 2024-25. This means taxpayers can easily submit their returns through the e-filing portal without using the offline Excel version if they wish. Many people find the online option faster and less confusing because it fills in some details automatically. The IT Department in a post on X wrote, "Income Tax Return Form of ITR-2 is now enabled for filing through online mode with pre-filled data at the e-filing portal. It must be noted that earlier, on July 11, the Excel utilities for ITR-2 and ITR-3 were released, allowing people to download the forms, fill them offline, and then upload them on the portal."

WHO SHOULD USE ITR-2? ITR-2 is mainly for people who earn from salary or pension, own more than one house, have capital gains, or get income from other sources.

But it is not for those who have business or professional income. Hindu Undivided Families (HUFs) can also use this form if they fit these rules.

IMPORTANT CHANGES THIS YEAR

This year, the ITR-2 form has a few important changes that every taxpayer should know. You now have to report your long-term capital gains separately for periods before and after July 23, 2024, as new indexation and tax rules apply. If you hold unlisted bonds or debentures, you must clearly mention them depending on how long you have kept them. Any money you receive from share buybacks on or after October 1, 2024 should be shown under "Income from Other Sources" and also marked as "Nil" under capital gains. Plus, if you earn more than Rs 1 crore in a year, you must disclose your assets and liabilities. This limit was earlier set at Rs 50 lakh.

Domestic market sentiment on Friday, despite a supportive global backdrop, remained cautious, led by sharp declines in key private banks and telecom. Investors are closely watching corporate earnings and institutional flows to gauge short-term trends.

As of 11:41 AM, the equity benchmark indices were trading lower, with the Sensex down by around 500 to 600 points, slipping below the 82,000 mark, and hovering near 81,600-81,750. The Nifty50 also dropped below the 25,000 level and was seen trading around 24,930-24,960, down by approximately 150 to 180 points. This subdued performance in domestic equities came despite positive global cues following strong US labour and retail data, which had helped ease concerns about a global economic slowdown.

The downturn in Indian markets was largely driven by selling pressure in banking and telecom stocks. Axis Bank was the top loser on the Nifty, falling by nearly 4 to 6 percent after reporting a weaker-than-expected Q1 result. The bank's net profit dropped by 4 percent year-on-year to ₹5,806 crore, while its net interest margin narrowed to 3.80 percent. A rise in gross non-performing assets, which increased from 1.28 percent to 1.57 percent on a quarterly basis, added to investor concerns. Kotak Mahindra Bank and Bharti Airtel also contributed to the drag on indices, with notable declines. Meanwhile, select IT stocks provided some relief. Wipro gained around 3 to 4 percent after posting better-than-expected Q1 earnings, aided by continued resilience in client spending in the US. Broader markets showed mixed action—while midcaps were down mildly, small-caps saw limited declines of around 0.7 percent. Some stocks on the BSE defied the trend and posted gains of over 15 percent. Globally, the mood remained optimistic. Asian markets traded higher following a record close on Wall Street, supported by upbeat US economic data. The MSCI Asia ex-Japan index was up around 0.7 percent.

Tesla Model Y in India may get cheaper, but it's not because of the Trump trade deal

Tesla's Model Y has finally landed in India with a price tag of ₹61 lakh (ex-showroom). That's nearly double what it costs in the US, where it starts at \$37,490 (about ₹32 lakh). For Indian buyers, it's an eye-watering premium. Many expected the India-US trade corridor to play a role in softening prices. But it turns out that's not the route this price cut might take. The real twist? Any potential drop in pricing could be linked to Europe, not America. That's right. India's ongoing Free Trade Agreement (FTA) talks with the European Union might play a bigger role than any Trump-era tariff negotiations with the US. Model Y in India isn't from the US, it's from Germany.

The Model Y units displayed at Tesla's new Mumbai showroom are not manufactured in the US. And that's important. Tesla's US factories don't currently produce right-hand-drive (RHD) cars, which are necessary for Indian roads. Tesla's China factory in Shanghai does export RHD units, but for the RHD markets like Australia and Japan.

Tesla began RHD production at Giga Berlin around April 2024, as per a Reuters report this was likely in preparation for export to India.

India-EU FTA talks could lead to lower tariffs

India currently charges over 100 percent import duty on fully built cars, which doubles the price of vehicles like the Model Y. But that could soon change. India is considering bringing down tariffs on EV imports from the EU to as low as 10 percent in a phased manner, according to a Reuters report citing officials and industry sources. This comes as part of India's ongoing FTA negotiations with the European Union. If the agreement is finalised, German-made cars like the Model Y and the VAG cars, Mercedes and more might see a steep price correction. Indian carmakers, however, are pushing back, asking the government to maintain at least 30 percent duties for the next four years to protect their turf.

2025 tech layoffs: Amazon, Microsoft, Google fuel job fears amid AI push

Amazon lays off hundreds from AWS despite 17% revenue rise
Microsoft cuts 9,000 jobs amid rising AI infrastructure costs
Google offers voluntary exit programme, avoids forced layoffs

Amazon has laid off a huge chunk of its employees from its AWS cloud division. The exact number remains uncertain, reported Reuters. Other tech giants like Microsoft, Google, Intel and Meta also join the trail. The year 2025 was supposed to be a new chapter. A time when artificial intelligence promised smarter work, faster growth, and a better future. But for tens of thousands of workers across the world, it has meant sleepless nights, and uncertain futures.

From the glass towers of Microsoft in Redmond to Intel's chip plants in Oregon, from Amazon's cloud hubs in Hyderabad to Disney offices in Mumbai - job loss has turned into a global layoff wave. According to Reuters, Amazon has laid off hundreds of employees from its AWS cloud computing division, with affected departments including support, training, and cloud specialist units. Despite strong revenue from AWS (a 17% increase in Q1), Amazon continues to trim costs across its business verticals. The report highlights that laid-off employees will receive 60 days' pay, extended health benefits, and severance. MICROSOFT LAYS OFF 9,000 EMPLOYEES AS AI TAKES OVER

In early July, Microsoft also confirmed another round of layoffs. Around 9,000 people, nearly 4% of its workforce to be cut. Seattle Times reported Microsoft had pledged \$80 billion in capital spending for its fiscal year 2025. However, the soaring cost of scaling its AI infrastructure has



weighed on its margins, with its June quarter cloud margin expected to shrink from last year. Microsoft plans to reduce organisational layers with fewer managers and streamline its products, procedures and roles. "The company's shift from human-led sales to AI-powered solution engineering marks a changing tide," reports Windows Central.

GOOGLE INTRODUCES VOLUNTARY EXIT PROGRAM

On the other hand, Google has introduced "Voluntary Exit Program" amid restructuring rather than immediate job

terminations. This was introduced for U.S.-based employees, particularly in the Search, Ads, and Engineering teams. According to The Economic Times, the move comes alongside office return mandates and aims to reduce headcount without forced terminations. All of these layoffs have one thing in common - the revolution of AI. Instead of using human-intensive procedures and traditional hierarchies, businesses are opting for automation, machine learning, and leaner digital-first approaches. Separately, Bloomberg News revealed that Microsoft's King subsidiary, based in Barcelona and home to the Candy Crush video game, is laying off roughly 200 employees, or 10% of its workforce.

Job layoffs have also been reported by Big Tech peers that are making significant investments in artificial intelligence. Leaving people in a dilemma of what their future beholds after being cut from one of the world's largest MNCs.

Startup founder calls flight travel insurance a scam, shares experience

Founder criticises travel insurance as a 'borderline scam'
Claiming Rs 3,000 for flight delay turned into weeks-long struggle
Founder doubts value of insurance after frustrating experience

A business founder has shared his frustrating experience with travel insurance, calling the industry's practices a "borderline scam" after struggling for weeks to claim compensation for a delayed flight. Ayushman Pandita, founder of Growth Rocket, detailed his ordeal on LinkedIn after attempting to claim Rs 3,000 for a three-hour flight delay between Bangalore and Delhi. What

should have been a straightforward process turned into a weeks-long battle across multiple platforms and customer service calls.

THE CLAIM JOURNEY

Pandita purchased travel insurance for Rs 249 whilst booking his flight, describing it as an afterthought. "I didn't think much of it while booking. Just clicked 'Add' and moved on," he wrote. When his flight was delayed by three hours, he attempted to use the app to make a claim but found no option available. A 20-minute call to customer care revealed the policy was handled by a third-party insurer, directing him to check his email for further instructions. The email mentioned he could claim but provided no clear process, simply stating: "Contact support if you face issues."

MULTIPLE PLATFORMS, NO RESOLUTION

What followed was a maze of different platforms and requirements. Pandita described being directed from email to

a web portal, then to download yet another app, before finally being asked to provide documents via WhatsApp. "I went to the portal and surprise, no claim option. Only a link asking me to download their app," he explained. After downloading the app and creating an account, he still found no clear way to make his claim. A second customer service call lasted 30 minutes, during which he was asked for "all details, policy number, certificate number, random codes from my inbox."

WEEKS OF FRUSTRATION

Three weeks after the initial delay, Pandita says he has spoken to six different people and visited more than five portals, yet the claim process remains incomplete. "They make the claim process so long and painful that I'm somehow convinced this isn't a flaw, it's by design," he claimed in his post. Pandita suggested that insurance companies profit from customers who give up on small claims due to the complex process.

emergencies or short-term needs, while investing helps it grow for bigger goals. 
US-India trade talks: Tariff on Indian goods could end up around 10-15%

The US President Donald Trump has signaled optimism about a deal, stating that a "very close" agreement is in progress. He hinted that the tariff on Indian goods could end up being around 10-15%, in line with other "smaller countries."

As the July 31 deadline for the ongoing trade negotiations between the US and India approaches, both sides are reportedly converging on a modest 10-15 percent US tariff on Indian imports—avoiding the steep 27 percent reciprocal tariff previously announced by US President Donald Trump, which is set to take effect on August 1, 2025.

India is actively working to reduce or avert the proposed tariff hike. According to reports, Indian officials are seeking terms



at least on par with or better than those secured by countries like Indonesia and Vietnam, which negotiated final rates closer to 19-20 percent. In exchange for the US lowering or dropping its planned duties, India is offering tariff cuts on US industrial goods and even proposing a zero-for-zero agreement on auto parts.

The US was initially considering imposing

a 27 percent import tariff on Indian goods as part of its broader trade strategy under the Trump administration's "Liberation Day" policy. While a base 10% universal tariff has already been introduced across most US imports, India has been listed for a higher "reciprocal" tariff rate of 27%. This follows the earlier suspension of the tariff, which was supposed to take effect

on July 9, to allow time for negotiations between the two countries. However, the US President Donald Trump has signaled optimism about a deal, stating that a "very close" agreement is in progress. He hinted that the tariff on Indian goods could end up being around 10-15%, in line with other "smaller countries," rather than the initially proposed 27%. However, this depends on the outcome of the negotiations, which are expected to conclude before the August 1 deadline. Until a final decision is reached, Indian exporters in sectors like electronics, auto components, and agriculture are facing uncertainty. Many businesses have delayed shipments and new orders, awaiting clarity on the final tariff structure. A scaled-down trade pact focused on key sectors may be signed in the final days of July, which could prevent the full tariff from being implemented. For now, the situation remains fluid. If no agreement is reached by August 1, Indian goods could be subject to the full 27% tariff, which may significantly impact trade flows and pricing across several industries.


He added that just because he wasn't visible in pictures doesn't mean he wasn't present. "If you

The National Crime Records Bureau (NCRB) statistics reveal that a total of 1,35,445 people committed suicide in 2012 which amounts to an average of 15 suicides an hour or 371 suicides daily. Maharashtra ranked second on the suicide index with Tamil Nadu topping it.

Asraa, a 24x7 suicide helpline based out of Mumbai receives about 50 calls daily from people who, almost at the verge of suicide and are seeking out help. Jhonson Thomas, the director of this crisis intervention centre said, "The callers are usually really desperate and right at the edge as seeking help is not ingrained in our culture and people prefer to sort out an issue on their own." The counsellors remain with them on the call for durations ranging from 20 minutes to 2-3 hours, depending on the situation, and discourage them from taking



any drastic step. "We cajole the caller to share his/her problem in detail and vent out their bottled emotions. Once that is done it's easier to address the issue and offer solutions," he added.

Many psychologists and doctors believe that suicide is a mere trigger reaction to unaddressed issues that have been piling on. City-based psychologist, Dr Himani Chaphekar, who treats 8-10 depression patients every month, said, "Stress levels have gone up right from school level which continues well into the old age. Excessive expectations to excel, societal pressures and being unsatisfied with what you have are the factors

that contribute largely to depression." Commenting on the fact that Indians do not take their mental health very seriously and are sceptical of addressing it she added, "There are many stigmas and misconceptions associated with mental health and well-being."

While people rush to a doctor for a normal cold and flu they avoid seeing a psychologist as they feel that a psychological disorder is their own doing that they need to be ashamed of." Emphasising on the need for quick identification and diagnosis of such disorders, she added, "Very few people know that mental health is directly co-related to hormonal imbalance or chemical changes/imbalances and is hence also physiological. All this misconception ensures that people are not able to distinguish between sadness, normal anxiety and clinical depression that requires treatment."

Adding to it another circuit



y-based psychiatrist, Neville Misquita said, "The stigma for mental health patients arises from the behaviours and emotions that sets them apart from others. Once these are controlled, there is no stigma. And modern medication can do this. If diagnosed with depression the person needs to follow the prescribed medical advice. The road to recovery is normally smooth but one needs to be patient."

Speaking about the average age group of the callers on the suicide helpline Thomas added, "15-45 is the most prominent age group that is prone to suicidal tendencies globally. The second most vulnerable age group comprises 60 plus people. While for the first age group it's usually a break-up, loss of a loved one or a general loss that's the biggest trigger, among the second age group the reasons range from loneliness, chronic illnesses, coping with the lack of loved ones to coming to

terms with retirement and making a transition to a sedentary lifestyle."

Examinations, especially the waiting period between exams to the results being declared is when students are most vulnerable. In recent times, unemployment, an unsatisfactory financial position and marital discord have also been seen as the major reasons of depression. Blaming the changing social scenario for the rise in depression rates and subsequent suicides, Thomas said, "India has been in a transition phase, since the last 15-20 years, with a changing value and support system. The MNC culture has brought about long working hours, lesser time spent with family, more distractions and more reliance on technology etc." Pointing out the flaws in a nuclear family structure he added, "Joint families earlier used to be a huge protective set-up as there were so many people to talk to. Man is social animal and needs to constantly talk things out."

Corporations and educational institutions all have a provision for in-house counsellors who can be approached. "While companies do have a counselling cell, employees refrain from using it openly or otherwise as firstly you cannot discuss work related problems there and secondly no one wants to be seen as a whiney, problematic employee," said Neelam Puri, an IT professional. "The constant competition these days is really nerve wrecking. From climbing the corporate ladder, to looking good, to managing all the stress factors related to city life and then the financial and emotional upheavals really takes a toll and all of us do feel depressed every now and then," confessed Nafisa Begum, an advertising professional
