# Purnima University Sikh Girl Episode: Silence Raises More Questions

**Jaipur.** July 30: Yesterday morning, around 6:00 AM, I, Gurcharan Singh Babbar, Editor-in-Chief of The Sikh Times, along with my associates Sardar Avtar Singh (Punjabi Bagh) and senior journalist Mr.Sourabh Sharma, travelled from Delhi to Purnima University, Jaipur, to investigate the shocking incident where a Sikh girl was allegedly forced to remove her Kirpan and Kada, sacred symbols of the Sikh faith.Our purpose was clear to meet the Vice-Chancellor, Chairman, and Principal of the university.

To ask why the religious kakars of a Sikh student were forcibly removed, and under whose orders?

To find out who is behind this deliberate attack on the religious freedom of Sikhs?

Before our visit, we formally informed Prime Minister Shri Narendra Modi, Chief Minister of Rajasthan, and Director General of Police Rajasthan through official emails about our



scheduled visit to the university.

### Shocking Reception at Purnima University

However, upon reaching Purnima University, Jaipur, we were stunned. The gates of the university were locked, and not a single official—no Vice-Chancellor, no Chairman, no Principal, no administrative authority—was present. The campus appeared deserted. Only a few security guards were seen on duty, who categorically refused to provide any information.

### This raises serious questions

1. Why did the university shut its doors on journalists seeking the truth?
2. Why is the administration refusing to clarify?
3. Under whose direction a Sikh girl was humiliated?
4. What action has been taken against those who forced the student to remove her religious kakars?The university's silence only deepens the suspicion that this is not an isolated incident but part of a larger, orchestrated anti-Sikh conspiracy.Previous Story Context: Earlier, The Sikh Times reported the courage of the brave Sikh girl who refused to

surrender her Kirpan and Kada despite immense pressure. We compared this to the Mughal era of Aurangzeb, where Hindus were forced to remove their sacred Janu threads.

"Back then, Aurangzeb attacked Hindu faith by forcefully removing Janu. Today, in a so-called 'Hindu Raj', Sikh students are being compelled to remove their Kirpan and Kada. This is not just an insult to Sikh faith but a direct attack on India's constitutional right to freedom of religion."

This incident has become a hot topic of debate across Punjab, India, and the global Sikh diaspora. The Sikh community is outraged, viewing this as a blatant religious assault.

We demand that: 1. Prime Minister Modi intervene directly and ensure strict action against those responsible.

2. The Rajasthan government conduct a high-level inquiry and publicly disclose the findings.

## Revival of the lake to give Delhi tourism a new identity: Kapil Mishra

**New Delhi.** 30 July 2025: Delhi's Minister for Development and Tourism, Kapil Mishra, yesterday held an important review meeting on the Model Town Naini Lake Project with senior officials of the Delhi Tourism Department and the Delhi Tourism and Transportation Development Corporation (DTTDC). The meeting focused on a detailed review of the progress of previously announced proposals for the lake's revival and beautification.

It was informed during the meeting that work is underway to install a state-of-the-art laser show on the island located in the middle of the lake. Renovation of the musical dancing fountain and preparations for installing two new LED fountains are also in the final stages. Discussions were also held regarding the construction of footpaths around the lake and establishing a cafeteria. He emphasized that all attractions should reflect Delhi's rich cultural and historical heritage to provide a unique experience to visitors. Several proposals were seriously considered to develop the lake as a family-friendly and cultural tourism destination. These include the introduction of Shikara and Gondola boat rides, racing boats, and water scooters. Kapil Mishra instructed that complete safety arrangements must be ensured before initiating any of these activities — including CCTV surveillance, deployment of lifeguards, and a robust emergency rescue system within the lake premises.

## PM corrected Nehru's mistakes by suspending Indus treaty with Pak: Jaishankar

### Participating in the debate on Operation Sindoor, S Jaishankar said that the Indus Waters Treaty, signed in 1960, was not an act of peace but one of appeasement.

External Affairs Minister S Jaishankar on Wednesday told the Rajya Sabha that the PM Narendra Modi-led government had "corrected the wrongs" of former Prime Minister Jawaharlal Nehru by suspending the Indus Waters Treaty with Pakistan, saying that "blood and water cannot flow together".

Participating in the debate on Operation Sindoor, Jaishankar said that the Indus Waters Treaty, signed in 1960, was not an act of peace but one of appeasement.

"We were told for 60 years that nothing can be done. Pandit Nehru's mistakes can't be corrected.

The Narendra Modi government showed it can be corrected. Article 370 was corrected. The Indus Water Treaty is being corrected," he said, reiterating that the treaty is being held in abeyance until Pakistan irrevocably gives up its support

of terrorism.

Criticising Nehru's decision, Jaishankar said, "The then PM is saying that let us do this treaty because the Indian government should put the interest of the Pakistani Punjab. Not a word about the interest of the farmers of Kashmir, Punjab, Rajasthan, and Himachal."

Referring to Nehru's 1960 statement, Jaishankar said, "He now says that because people are saying, we felt that in the circumstances, this is the right settlement. We purchased peace and it is good for both countries... We didn't purchase peace, we purchased appeasement because within one year, the same PM accepted

that with Pakistan, there is no peace."

The minister also underlined the "uniqueness" of the agreement. "Indus

has allowed its major rivers to flow to the next country without having rights on that," he said.



Waters Treaty in many ways is a very unique agreement. I cannot think of any agreement in the world where a country

One of the steps taken by India in response to the April 22 Pahalgam attack, which left 26 people dead, was to place the Indus Waters Treaty in abeyance, citing cross-border terrorism.

## Centre approves Rs 821.26 crore to accelerate Delhi's Development: CM Rekha Gupta

**New Delhi.** 30 July 2025: Chief Minister Mrs Rekha Gupta announced that the Central Government has sanctioned Rs 821.26 crore as special assistance to accelerate the transformation of the National Capital into a 'Developed Delhi'. She stated that 66 percent of the sanctioned amount has been released as the first instalment, enabling the immediate commencement of key projects. The funds will be utilised for critical public service sectors including health, education, housing, drinking water, electricity and transport.

The Chief Minister informed that the Union Ministry of Finance has approved the allocation under the Scheme for Special Assistance to States for Capital Investment (SASCI) 2025-26. Of the total amount, Rs 716.00 crore under Part-I has been earmarked for 33 major infrastructure projects, while an additional Rs 105.26 crore under Part-III has been sanctioned for the Priority Corridor of MRTS Phase-IV.

Expressing her gratitude to Prime Minister Narendra Modi, Home Minister Amit Shah and Finance Minister Nirmala Sitharaman, the Chief Minister said that this approval lays a strong foundation for realising the vision of a 'Developed Delhi' in alignment with the Honourable Prime Minister's goal of a 'Developed India'. She affirmed that the Delhi Government will continue to seek additional allocations to ensure comprehensive development of the capital. Mrs Rekha Gupta highlighted that the proposals were submitted promptly and in compliance with all procedures through the Public Financial Management System (PFMS) portal. The seamless coordination with the Ministry of Finance ensured expeditious approval. The Chief Minister stated that these projects will strengthen essential public services, urban mobility and civic amenities, while also generating employment and boosting economic activity in the capital. She assured that the Delhi Government will implement all projects in a time-bound, transparent and quality-driven manner to deliver direct benefits to the citizens of Delhi.



## Pinarayi Vijayan says nuns arrested in Chattisgarh on Bajrang Dal's false complaint

**Kerala Chief Minister Pinarayi Vijayan criticised the arrest of Malayali nuns in Chhattisgarh, alleging they were targeted based on a false complaint by Bajrang Dal. He urged Prime Minister Narendra Modi to intervene.**

#### New Delhi. (Agency)

Kerala Chief Minister Pinarayi Vijayan came down heavily on the BJP over the recent arrest of Malayali nuns in Chhattisgarh. Calling it an act of targeted harassment, the Chief Minister said the nuns were arrested and jailed on the basis of a false complaint filed by Bajrang Dal activists.

Vijayan alleged that the incident exposed the "true nature of the Sangh Parivar" and accused them of consistently attacking the Christian community under the guise of curbing religious

conversions and trafficking. "The same people who walk into Christian homes with cakes and smiles are now hunting down nuns," he said.

The Chief Minister added that the Sangh Parivar fears the pluralism and coexistence that defines India, and that attacks on minorities are part of a larger agenda to undermine secularism and promote divisive politics.

Stating that he had written to the Prime Minister as soon as the news broke,



Vijayan said there had been no effort from the Centre to correct the injustice. "Shockingly, the arrests were even justified by the Chhattisgarh Chief

Minister," he said.

The Kerala Chief Minister warned that minority rights and the fundamental rights enshrined in the Constitution were under threat and urged citizens to resist any such encroachments.

Kerala BJP Chief Rajeev Chandrasekhar said the Kerala BJP has taken proactive steps, with State General Secretary

Anoop Antony already in Chhattisgarh to offer legal and logistical support to the arrested nuns.

## Why idea of free-fair polls in Bengal is ghorar dim

**►At a recent meeting, West Bengal CM Mamata Banerjee reminded block-level officers (BLOs) that they were state government employees. Bengal is the only state to have a Chief Electoral Officer's office under the Home and Hill Affairs Department. These and large-scale illegal immigration make the dream of free-fair polls in Mamata's Bengal nothing but bunkum.**

"Ghorar dim", as the Bangla phrase, which means "a horse's egg" goes, captures the absurdity of the idea of free and fair elections in West Bengal. Not just reported large-scale immigration and the shadow of political violence, an election machinery, which is allegedly far from independent, makes the idea of a fair franchise a pipe dream. As ghorar dim, the idea of fair elections here remains a fantasy.

In an administrative meeting last week, West Bengal CM Mamata Banerjee reminded block-level officers (BLOs) that they were state government employees. This is important because the BLOs are key to the special intensive revision (SIR) of electoral rolls that is expected to begin in Bengal soon.

Also, West Bengal is the only state where the Chief Electoral Officer (CEO) office

operates under the state's Home and Hill Affairs Department, without functional freedom. The state has seen an influx of illegal immigration from Bangladesh, leading to demographic changes in several



districts. Retributive political violence, as seen after the last Assembly elections, also cast a cloud over the idea of participatory democracy.

**ILLEGAL IMMIGRATION AND SIR IN WEST BENGAL**

Even as the Special Intensive Revision (SIR) exercise is underway in Bihar and speculated to begin in poll-bound Bengal next, Mamata Banerjee has openly opposed it, calling it a targeted move against Bengali voters. The Trinamool Congress leader, who has launched a Bhasha Aandolon from Rabindranath Tagore's Sanctuary Bolpur, has asserted that "people from Gujarat were preparing Bengal's [voters'] list".

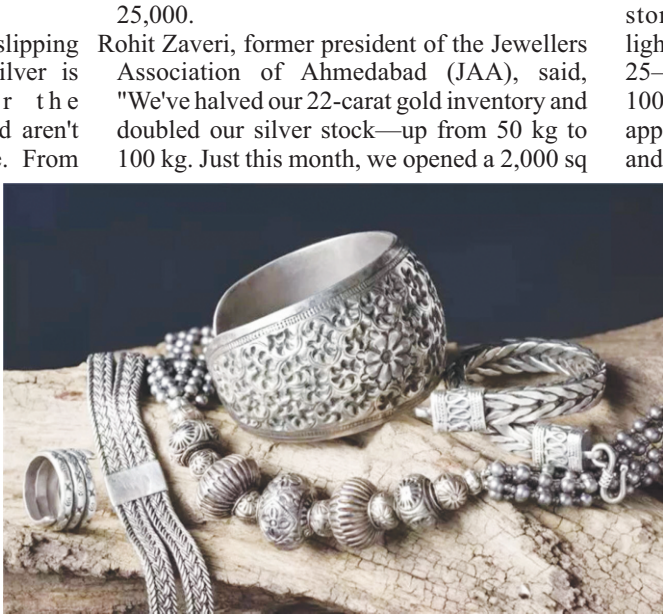
This even as the West Bengal CEO flagged major irregularities during sample checking of voter lists in South and North 24 Parganas, where 127 fictitious voters were allegedly entered by two Electoral Registration Officers (ERO) without BLO verification, reported The Economic Times newspaper on Wednesday. The SIR is a legal and essential exercise mandated under the Representation of the People Act, 1950, to ensure the accuracy and integrity of electoral rolls ahead of major elections.



# Silver is the new gold: Showrooms in A'bad scale up to meet rising demand

With gold prices hitting new highs and slipping out of everyday gifting budgets, silver is getting its moment under the spotlight.Jewellers across Ahmedabad aren't letting the opportunity go to waste. From expanding display counters to launching entire showrooms dedicated to silver jewellery, the city's jewellers are betting big on the white metal.“We've gone from one silver counter to dedicating 3x the space for it," said Manoj Soni, a jeweller based in Ahmedabad. "There's huge interest across the board — from Navratri-themed traditional sets to sleek, Italian machine-made pieces for daily wear. Customers want something stylish yet accessible, and silver fits the bill perfectly and makes a style statement too."

Gold prices stood at Rs 1.01 lakh per 10 gram on Tuesday in the Ahmedabad market whereas silver is priced at Rs 1.14 lakh per kilogram here. Shoppers are turning to silver jewellery and artefacts as elegant, value-for-money alternatives. This is especially true for the gifting ticket size of Rs 20,000 and Rs



25,000. Rohit Zaveri, former president of the Jewellers Association of Ahmedabad (JAA), said, "We've halved our 22-carat gold inventory and doubled our silver stock—up from 50 kg to 100 kg. Just this month, we opened a 2,000 sq ft silver-only studio-style showroom near Science City Road."

The shift is not just in volume, but also in variety. According to jewellers, there's a visible uptick in demand for 925-grade silver crafted into everything from oxidised Jaipuri jewellery and antique Jadtar-inspired designs to sleek,

stone-studded Italian imports. Silver's lightweight nature, lower making charges (Rs 25–30 per gram for oxidised styles and Rs 100–200 for premium finishes), and stylish appeal have made it a hit among millennials and traditional buyers alike.

Even jewellers who never stocked silver before are now diversifying. "Earlier, we didn't even keep silver rings or bracelets," said Jigar Patel, JAA treasurer. "Since January, we've introduced items in the Rs 2,000 to Rs 10,000 range. And with Rakshabandhan coming up, we're expecting a spike in demand for such pieces."

Gold is no longer the go-to for gifting, so people are turning to silver—be it jewellery or artefacts," said Kailash Kabra, founder of a jewellery store in Ahmedabad. "Silver has emerged as both an investment and everyday wear option. We've launched a dedicated silver showroom with increased stock and variety, and are also planning to roll out an e-commerce portal soon to offer customers even more convenience. Whether it's for Navratri or routine wear, stylish silver pieces are clearly in demand."

## MMRDA deposits Rs 560 crore with Bombay high court registry in arbitration dispute with Mumbai Metro One Pvt Ltd

The Mumbai Metropolitan Region Development Authority (MMRDA) deposited Rs 560.2 crore with the registry of Bombay high court in an arbitration matter involving Mumbai Metro One Pvt Ltd, in accordance with a directive recently issued by Supreme Court.MMOPL, a joint venture between Reliance Infrastructure and MMRDA, is a special purpose vehicle set up to run the Versova-Andheri-Ghatkopar Metro 1 corridor.

In Aug 2023, a three-member arbitral tribunal awarded Rs 992 crore to MMOPL as compensation for cost escalations and contractual disagreements. With interest accrued till May 2025, the total award rose to Rs 1,169 crore.

On July 10, 2025, HC directed MMRDA to deposit the entire amount, rejecting its plea for an unconditional stay. The court observed that MMOPL's arbitration win could not be rendered meaningless during the pendency of MMRDA's challenge to the award. It noted that MMRDA failed to make a prima facie case to justify a stay without deposit.HC also pointed out that MMRDA, as a 26% equity holder in MMOPL, was involved in key financial decisions and project execution. The audit committee of MMOPL, chaired by an MMRDA nominee, endorsed the financial statements on which the tribunal partly relied. It concluded that the award —

passed by a 2:1 majority — could not be dismissed as perverse or arbitrary. MMRDA filed a challenge under Section 34 of the Arbitration and Conciliation Act, calling the award illegal and based on flawed assumptions regarding project delays, rent recovery, and cost escalations. MMOPL, in turn, accused the authority of attempting to backtrack from previously



approved decisions.After the HC ruling, MMRDA approached Supreme Court, which granted partial relief by allowing it to deposit only 50% of the award amount pending final adjudication. In a stock exchange filing, Reliance Infrastructure confirmed that MMRDA complied with the SC order and deposited Rs 560.2 crore with the HC registry.The final outcome of this arbitration matter is likely to set a precedent for public-private partnership infrastructure disputes in India.

## Judge resigns after senior, whom she accused of harassment, elevated to High Court

**Bhopal.** A woman civil judge in Madhya Pradesh has resigned in protest, expressing anguish over the appointment of a district judge accused of harassing her to the Madhya Pradesh High Court. In a strongly worded resignation letter addressed to the Chief Justice of the Madhya Pradesh High Court, Junior Division Civil Judge Aditi Kumar Sharma said the very judiciary that preaches justice and equality had failed her by promoting the man she accused of serious misconduct.

Judge Sharma's resignation follows the elevation of Shahdol District Judge Rajesh Kumar Gupta, whom she had accused of harassment, to the post of a High Court judge. Describing the appointment as a “reward” for her alleged tormentor, she questioned the silence and inaction of the judicial system in the face of documented complaints.

# Row erupts over paid 'Vallasadya' at Aranmula temple; PSS accuses TDB of breaching ritual norms

Amid the controversy at Aranmula Sree Parthasarathy Temple over the Travancore Devaswom Board's (TDB) launch of a paid version of the traditional Vallasadya-a ceremonial temple feast -the Palliyoda Seva Sangham (PSS), which denounced the move as a breach of long-standing temple customs, remains steadfast in its opposition.The TDB's Vallasadya, priced at Rs 250 per head, is being offered to devotees who book in advance. Coupons for the feast can also be availed online. As of now, the feast is scheduled exclusively on Sundays.However, the PSS, which traditionally oversees the conduct of the Vallasadya, has strongly objected to the Board's move. "Palliyoda Seva Sangham has no involvement whatsoever in the Vallasadyas proposed by the Devaswom Board. This is a serious

breach of ritualistic norms," K V Sambadevan, president of the PSS, told. He cited a Kerala High Court order which mandates that any decision related to the Vallasadya must be taken jointly by a committee comprising representatives of both the PSS and the TDB. "Selling food coupons in the name of Vallasadya without the participation of Palliyodams is tantamount to commercialising the ritual," he added.In protest, PSS activists had recently marched to the office of the Devaswom Assistant Commissioner singing Vanchippattu, the traditional boat song, demanding that the ritual be conducted only in the presence of snake boats."If the Board is determined to override ritual norms and hold Vallasadya for money, the Sangham will intensify its agitation," Sambadevan warned.



Considering the devotees reaching from faraway places, he also said the normal feast can be booked through the PSS website, clarifying that they are 'paid feasts' and not Vallasadhya.Vallasadhya has various rituals

connected to faith, he said, adding that it cannot be compared with other feasts.

Other PSS leaders, including secretary Prasad Anandabhavan, joint secretary Ajay Gopinath, vice-president K S Suresh, treasurer Ramesh Malimel, and executive members B Krishnakumar, Sashikumar Kurup, and Dr Suresh Babu also addressed the gathering, echoing their concern over what they termed the Devaswom Board's unilateral and commercial approach.The Sangham reiterated that the Vallasadya, a traditional feast offered to the oarsmen of the Palliyodams, must not be conducted in their absence. They demanded that the Devaswom Board respect established rituals and practices tied to the Aranmula Parthasarathy Temple's centuries-old heritage.

## Ambaji set to become model temple town

**Ahmedabad. (Agency)**  
The Gujarat govt has prepared a Rs 1,632 crore master plan for developing the famous Ambaji temple in north Gujarat as a model temple town.The govt said on Tuesday that new facilities will be added, keeping in mind the requirements of the next 50 years.

To be implemented in two phases, with work on the first phase to begin shortly, the master plan addresses various needs of the entire Ambaji pilgrimage site. "The aim is to establish a new benchmark for pilgrimage sites by integrating sacred places and improving facilities for pilgrims," an official statement said. The site attracts lakhs of devotees during the Bhadarvi Poonam fair and throughout the year.

The Gujarat Pavitra Yatradham Vikas Board (GPYVB), working under the state's tourism department, will execute the master plan. At the centre of the master plan is Gabbar Hill, believed to be where Goddess Sati's heart fell, and the Ambaji Mata Temple.

"The plan envisions the integration of

these two sacred sites and constructing an interactive corridor – Shakti Corridor – to enhance the spiritual journey between Ambaji Temple and the flame on Gabbar," the statement added.The govt said various development works costing Rs 950 crore will be undertaken in the first phase. The main attraction in this phase is the construction of the Shakti Corridor connecting Ambaji Temple and Gabbar. This Shakti Corridor is a major attraction, forming a comprehensive network connecting Gabbar Hill, the temple, and Mansarovar. A vast Shakti Chowk will connect with Gabbar Darshan Chowk through the Shaktipath.

In the second phase, development works costing Rs 682 crore will be carried out for the Gabbar Temple and its surroundings, the expansion of Ambaji Temple and Mansarovar, and the development of Sati Sarovar. Event plazas and garba grounds will be developed in the Sati Sarovar and Sati Ghat areas.

## Senior govindas hand over baton of dahi handi to next generation

The festival of dahi handi coming up Aug 16 is a household affair in certain families. A number of father-son and mother-daughter pairs are part of govinda teams. Even the third generation of little boys and girls joins their grandparents in this adventure sport.profiles a few families where the baton of dahi handi is being handed down, with school and college students, IT engineers and rickshaw drivers all making this sport a level playing field.

The founder of Mumbai's most prominent women govindas' team, Geeta Zagde of Parle Sports Club, said, "My daughter Ashtami, who was born on Janmashtami, plays dahi handi as do my sister and my niece. Each girl born into our family comes to watch practice from childhood



and becomes a govinda. I have never allowed our girls to fear injury or worry about their prospect of marriage should they fall."Sanket Salvi, 33, an IT engineer based in Bhandup, works as a software developer. Work life balance for him involves climbing the human pyramid for the local Shivneri Govinda Pathak after he is done with his day job. As a teen he

would accompany his father, Arvind Salvi, now 68, who is a mentor to a professional govinda championship. Sanket's six-year-old daughter Tvisha is also developing interest. She joins her father and climbs the pyramid under his watchful eye. This Bhandup pathak has a separate handi for women.

In Malad, autorickshaw driver Sachin Sharad Mhashelkar, 41, playing since 2007, trains his son Vedant who is studying in 12th grade. The father-son duo is attached to Om Brahmand Sai Govinda Mandal. 8.8 magnitude earthquake near Russia's Kamchatka Peninsula triggers tsunami warning for Japan's Pacific coast

**TOKYO . (Agency)**  
Japan's meteorological agency issued a tsunami alert for Japan's Pacific coast, upgrading an earlier advisory stemming from the powerful, magnitude 8.8 quake that hit on Wednesday morning near Russia's Kamchatka Peninsula. The agency issued an advisory for a tsunami of up to 3 meter (yards) across the Pacific coast of Japan, possibly starting to arrive along the northern Japanese coasts in less than half an hour after the alert. A tsunami warning also was extended to the U.S. state of Hawaii, with the National Weather Service's Pacific Tsunami Warning Center saying a tsunami from the quake had been generated that could cause damage along the coastlines of all the Hawaiian islands.

"Urgent action should be taken to protect lives and property," the warning stated. The first waves were expected around 7 p.m. local time. Japan's meteorological agency said the quake occurred at 8:25 a.m. (2325 GMT Tuesday) and registered a preliminary magnitude of 8.0. The quake was about 250 kilometers (160 miles) away from Hokkaido, Japan's northernmost of the country's four big islands, and was felt only slightly, according to Japan's NHK television. The U.S. Geological Survey said it hit at a depth of 19.3 kilometers (12 miles). The USGC said shortly after initial reports that the quake's strength was 8.7 magnitude. Russia's Tass news agency reported from the biggest city nearby, Petropavlovsk-Kamchatsky, that many people ran out into the street without shoes or outerwear. Cabinets toppled inside homes, mirrors were broken, cars swayed in the street and balconies on buildings shook noticeably. Tass also reported power outages and mobile phone service failures in the capital of the Kamchatka region. The National Tsunami Warning Center, based in Alaska, issued a tsunami warning for parts of the Alaska Aleutian Islands, and a watch for portions of the West Coast, including California, Oregon, and Washington, and Hawaii. The advisory also includes a vast swath of Alaska's coast line, including parts of the panhandle. The Japanese government said it set up a taskforce for information gathering and response in case of any emergency. A University of Tokyo seismologist Shinichi Sakai told NHK that a distant earthquake could cause a tsunami that affects Japan if its epicenter is shallow.

US says Trump has 'final call' on China trade truce

**STOCKHOLM. (Agency)**  
China and the United States agreed Tuesday to hold further talks on extending their tariff truce, but a top US trade official stressed that President Donald Trump would make any "final call."  
The world's top two economies met for a second day of negotiations in Stockholm, with both sides seeking to avert tariffs from returning to sky-high levels that had ground trade between the rivals to an effective standstill. The meeting in a Swedish government building, led on the Chinese side by Vice Premier He Lifeng and Treasury Secretary Scott Bessent for the Americans, ended without a resolution but with the US side voicing optimism. Neither government has made public any details from the talks, which started on Monday, although US Trade Representative Jamieson Greer said Trump would have the "final call" on any extension in the truce. "Nothing has been agreed until we speak with President Trump," added Bessent, calling the tone of the talks "very constructive". The negotiations are taking place in the wake of a trade deal struck over the weekend that set US tariffs on most European Union imports at 15 percent, but none on American goods going to the EU. The truce between China and the United States has temporarily set fresh US duties on Chinese goods at 30 percent, while Chinese levies on trade in the other direction stand at 10 percent. That accord, reached in Geneva in May, brought down triple-digit tariffs each side had levelled at the other after a trade war sparked by Trump spiralled into a tit-for-tat bilateral escalation.

Elon Musk Confirms \$16.5 Billion AI Chip Deal With Samsung Electronics

**Seoul. (Agency)**  
Tesla Chief Executive Officer (CEO) Elon Musk said he discussed the details of a recent semiconductor supply deal with Samsung Electronics Chairman, Lee Jae-yong. In a response to a user's comment on his X account on Tuesday (U.S. time) that Samsung Electronics "has no idea what they signed up for," Musk replied, "They do." "I had a video call with the chairman and senior leadership of Samsung to go over what a real partnership would be like," he continued, adding they will "use the strengths of both companies to achieve a great outcome." Later, when another user commented that "Samsung is definitely the underdog when it comes to chipmaking," Musk defended the South Korean tech giant, saying: "Both TSMC and Samsung are great companies. It is an honor to work with them." Shortly after Samsung Electronics announced a 22.8 trillion-won (US\$16.5 billion) deal to supply artificial intelligence (AI) chips to an undisclosed customer, Musk revealed that Tesla was the partner behind the contract, reports Yonhap news agency. He said Samsung Electronics will manufacture Tesla's next-generation A16 chip at its new semiconductor plant in Texas, stressing, "The strategic importance of this is hard to overstate." Meanwhile, Samsung Chairman Lee departed for Washington, D.C., on Tuesday amid ongoing South Korea-US tariff discussions ahead of Friday's trade deadline.

'Taken out of the spa': Trump says Epstein 'stole' young women from his Florida club

**Trump expanded on remarks he had made a day earlier, when he said he had banned Epstein from his Mar-a-Lago club two decades ago because his one-time friend "stole people that worked for me."**

**WASHINGTON. (Agency)**  
US President Donald Trump said Tuesday that Jeffrey Epstein "stole" young women who worked for the spa at Mar-a-Lago, the latest evolution in his description of how their highly scrutinized relationship ended years ago. One of the women, he acknowledged, was Virginia Giuffre, who was among Epstein's most well-known sex trafficking accusers. Trump's comments expanded on remarks he had made a day earlier, when he said he had banned Epstein from his private club in Florida two decades ago because his one-time friend

"stole people that worked for me." At the time, he did not make clear who those workers were. Trump has faced an outcry over his administration's refusal to release more records about Epstein after promises of transparency, a rare example of strain within Trump's tightly controlled political coalition. The Republican president has attempted to tamp down questions about the case, expressing annoyance that people are still talking about it six years after Epstein died by suicide while awaiting trial, even though some of his own allies have promoted conspiracy theories about it.

Ghislaine Maxwell, Epstein's imprisoned former girlfriend, was recently interviewed inside a Florida courthouse by the Justice Department's No. 2 official, Deputy Attorney General Todd Blanche, though officials have not publicly disclosed what she said. Her lawyers said Tuesday that she's willing to answer more questions from Congress if she is granted immunity from future prosecution for her testimony and if lawmakers agree to satisfy other conditions. Aboard Air Force One while returning from Scotland, Trump said he was upset that Epstein was "taking people

who worked for me." The women, he said, were "taken out of the spa, hired by him — in other words, gone." "I said, listen, we don't want you taking our people," Trump



said. When it happened again, Trump said he banned Epstein from Mar-a-Lago. Asked if Giuffre was one of the employees poached by Epstein, he demurred but then said "he stole her." The White House originally said Trump banned Epstein from Mar-a-Lago because he was acting like a "creep." Giuffre died by suicide earlier this year. She claimed that Maxwell spotted her working as a spa attendant at Mar-a-Lago in 2000, when she was a teenager, and hired her as Epstein's masseuse, which led to sexual abuse. Although Giuffre's

allegations did not become part of criminal prosecutions against Epstein, she is central to conspiracy theories about the case. She accused Epstein of pressuring her into having sex with powerful men. Maxwell, who has denied Giuffre's allegations, is serving a 20-year-prison sentence in a Florida federal prison for conspiring with Epstein to sexually abuse underage girls.

A spokeswoman for the House Oversight Committee, which requested the interview with Maxwell, said the panel would not consider granting the immunity she requested. The potential interview is part of a frenzied, renewed interest in the Epstein saga following the Justice Department's statement earlier this month that it would not be releasing any additional records from the investigation, an abrupt announcement that stunned online sleuths, conspiracy theorists and elements of Trump's political base who had been hoping to find proof of a government coverup. Since then, the Trump administration has sought to present itself as promoting transparency, with the department urging courts to unseal grand jury transcripts from the sex-trafficking investigations.

The Japan Meteorological Agency (JMA) kept its tsunami alerts that waves of up to three metres (9.8 feet) were expected along Japan's Pacific coast, after a magnitude-8.8 earthquake off Russia's Kamchatka Peninsula. But higher waves were still arriving, said Shiji Kiyomoto, an earthquake and tsunami response official at JMA. A tsunami of 50 centimeters (1.6 feet) was detected at the Ishinomaki port in northern Japan, according to JMA. White waves washed up to the shoreline on Japan's Hokkaido in the north and Ibaraki and Chiba, just northeast of Tokyo, in footage aired on Japan's NHK public television. Russian regions report quake damage

The quake at 8:25 a.m. Japan time had a preliminary magnitude of 8.0, Japan and US seismologists said. The US Geological Survey later updated its measurement to 8.8 magnitude and the USGS said the quake occurred at a depth of 20.7 kilometers (13 miles). The quake was centered about 119 kilometers (74 miles) east-southeast from the Russian city of Petropavlovsk-Kamchatsky, which has a population of 180,000, on the Kamchatka Peninsula. Multiple aftershocks as strong as 6.9 magnitude followed. The first tsunami wave hit the coastal area of Severo-Kurilsk, the main settlement on Russia's Kuril Islands in the Pacific, according to the local governor Valery Limarenko. He said residents were safe and staying on high ground until the threat of a repeat wave was gone. The quake caused damage to buildings and cars swayed in the streets in Petropavlovsk-Kamchatsky, which also had power outages and mobile phone service failures. Russian news agencies quoting the regional Health Ministry saying several people sought medical help in Kamchatka after the earthquake, but no serious injuries were reported.

A video posted on Russian social media showed buildings in the town submerged in seawater. Authorities said the population of around 2,000 people was evacuated. Several people were injured in Russia by the quake, state media reported, but none seriously.

Gunman who killed 4 in NYC building blamed NFL for mental health issues and was targeting its office

**NEW YORK: . (Agency)**  
A gunman who killed four people inside a Manhattan office tower blamed his mental health problems on the National Football League and intended to target its headquarters but took the wrong elevator, officials said Tuesday. Shane Tamura, a Las Vegas casino security worker, was carrying a handwritten note in his wallet that claimed he had chronic traumatic encephalopathy, known as CTE, investigators said. He accused the league of hiding the dangers of brain injuries linked to contact sports. Tamura, 27, sprayed the skyscraper's lobby with bullets then shot another person in a 33rd-floor office on Monday before he killed himself, authorities said. Among the dead were a police officer, a security guard and two people who worked at companies in the building. An NFL employee was badly wounded but survived. The attacker's grievances with the NFL emerged as police worked to piece together his background and motivations, and as loved ones began to mourn the dead. It's unclear whether Tamura showed symptoms of CTE, which can be diagnosed only by

examining a brain after death. Tamura, who played high school football in California a decade ago but never played in the NFL, had a history of mental illness, police said without giving details. In the three-page note found on his body, he accused the NFL of concealing the dangers to players'



brains for profit. The degenerative brain disease has been linked to concussions and other repeated head trauma common in contact sports such as football. Artificial Intelligence uses Artificial Intelligence uses Detectives planned to question a man who supplied gun parts for the AR-15-style rifle used in the attack, including

the weapon's lower receiver, Police Commissioner Jessica Tisch said in a video statement. She and members of the force also paid tribute to Officer Didarul Islam, who was guarding the building on a paid security job when he was killed. His flag-draped remains arrived late Tuesday afternoon at the Bronx mosque preparing for his funeral.

A multifaith vigil Mayor Eric Adams visited the scene and recalled working in the mailroom of the building as a young man.

"To have to walk through and see the remnants of violence at that level, tore at me," he told mourners at an evening multifaith vigil for those killed.

Muslim, Sikh, Buddhist, Hindu, Christian and other faith leaders delivered prayers at the gathering held at a park about a dozen blocks from where the shooting took place. Both Adams and Gov. Kathy Hochul spoke of the need for stronger gun laws. Hochul said guns designed to kill people on battlefields shouldn't be in New York buildings.

Flagrant violation': Thailand accuses Cambodia of breaking ceasefire

**BANGKOK. (Agency)**  
Thailand accused Cambodia on Wednesday of a "flagrant violation" of a truce deal to end cross-border fighting, saying Cambodian troops launched an overnight attack on the frontier. The nations agreed to a ceasefire starting Tuesday after five days of clashes killed at least 43 on both sides, as a long-standing dispute over contested border temples

boiled over into open combat on their 800-kilometre (500-mile) frontier. But Thailand's foreign ministry said its troops in Sisaket province "came under attack by small arms fire and grenade assaults launched by Cambodian forces" in an offensive which continued until Wednesday morning. "This represents a flagrant violation of the ceasefire agreement," said a foreign ministry statement. Thai government spokesman Jirayu Huangsab also reported overnight clashes but said in a statement "the Thai side maintained control of the situation" and "general conditions along the border are reported to be normal" from 8:00 am (0100 GMT). Cambodia has previously denied breaking the truce, designed to end fighting which has seen the two countries evacuate a total of more than 300,000 people from the border region.

An AFP journalist on the Cambodian side who heard a steady drumbeat of artillery fire since fighting began last Thursday

reported hearing no blasts between the start of the truce and Wednesday morning. Still fragile The armistice got off to a shaky start in the early hours of Tuesday, with Thailand accusing Cambodia of



continuing attacks in "a clear attempt to undermine mutual trust" -- before peace generally prevailed. Meetings between rival commanders along the border -- scheduled as part of the pact -- went ahead, with Thailand's army saying de-escalation

steps were agreed including "a halt on troop reinforcements or movements that could lead to misunderstandings". But later in the day a foreign affairs spokeswoman for Bangkok's border crisis centre, Maratee Nalita Andamo, warned: "In this moment, in the early days of the ceasefire, the situation is still fragile." Jets, rockets and artillery have killed at least 15 Thai troops and 15 Thai civilians, while Cambodia has confirmed only eight civilian and five military deaths. The flare-up has surpassed the death toll of 28 in violence that raged sporadically from 2008 to 2011 over the territory, claimed by both nations because of a vague demarcation made by Cambodia's French colonial administrators in 1907. The peace pact was sealed in Malaysia after intervention from US President Donald Trump -- who both Thailand and Cambodia are courting for a trade deal to avert his threat of eye-watering tariffs.



## Pothole-ridden road outside Ulhasnagar hospital puts patients, commuters at risk



**ULHASNAGAR. (Agency)**

The deteriorating condition of roads in Ulhasnagar city, particularly in front of the Central Hospital in Ulhasnagar-3, has become a daily source of inconvenience and danger for residents, commuters, and even patients visiting the city's main govt hospital. The main road connecting various parts of the city developed large potholes, creating massive traffic snarls, especially during peak hours. Motorcyclists are particularly at risk, with multiple incidents reported of riders losing balance and falling due to uneven surfaces.

Adding to the gravity of the situation, this critical stretch leads directly to Central Hospital, where hundreds of patients and their relatives visit every day. Many of them, already dealing with health concerns, now face the added burden of navigating treacherous road conditions to access medical care.

The same road also houses several key govt institutions, including the Public Works Department (PWD), Excise Department, Ulhasnagar Police Station, and even the Deputy Commissioner of Police (DCP) Office. Despite the importance of this stretch, no significant repair work was initiated, raising serious questions about Ulhasnagar Municipal Corporation administrative apathy. Local citizens and shopkeepers have expressed growing frustration with the lack of response from municipal authorities. "It's shocking that a road leading to the main hospital and police station is in such poor condition. Authorities are well aware, but no action is being taken," said Ashok Bajaj, a local resident.

**Chairman among two held in Rs 140 cr Mudra co-operative scam**

**HYDERABAD. (Agency)**

The CID has arrested two key accused in a Rs 140 crore scam involving the Mudra Agriculture Skill Development Multi-State Co-operative Society, which allegedly defrauded farmers, daily wagers and shopkeepers with promises of high-interest returns. Chairman Thippneni Ramadasappa Naidu (61) was held in Amaravati, while member Thippneni Sai Kiran (43) was arrested in Hyderabad. The duo mimicked the Pradhan Mantri Mudra Yojana, falsely claiming government backing and luring people with promises of jobs and returns.

Telangana CID chief Charu Sinha said the society grew to 330 branches with 1,600 employees and over 2,000 victims. Jobseekers were asked to deposit money as share capital, submit original certificates and were assigned collection targets. Many were penalised, denied salaries and certificates or threatened with defamation.

Funds were diverted for personal gain, including investments in APIIC Ltd for industrial plots in Andhra Pradesh. Further probe is on to trace the money trail and identify more accused.

# Wayanad disaster a year on: Time stands still in valley of despair

**CHOOALMALA.** "I lost 11 members of my family. Body of only one was found. The earth swallowed the rest," said 68-year-old Asiya, her eyes fixed on the rain-soaked graves at Puthumala. A year has passed since the landslide that tore through the hills of Chooralmala and Mundakkai, but for people like her, time has not moved on. On Tuesday morning, as clouds hung low over the hills, Asiya returned to Puthumala — the mass burial site of the victims. The IUML had organised an all-religion prayer meet to mark the first anniversary of the tragedy. "Sometimes I wake up hearing their voices," she whispered. "I don't know if it's a dream or a memory. I lost everybody," said Asiya.

She was not alone in her grief. Survivors and former residents arrived from across Wayanad, most now living in rented homes in Meppadi and Kalpetta, with flowers and heavy hearts.

"We have nothing left in Chooralmala. We buried our dreams and happiness along with our loved ones here," said Sainaba, standing

by the edge of the graveyard. Many wandered through what remained of their old homes. Overgrown paths now lead to collapsed roofs and moss-covered walls. A few residents had returned after months, just to see what the place that raised them had become.

On the intervening night of July 29 and 30, 2024, a massive landslide struck Chooralmala and Mundakkai in Wayanad, triggered by heavy monsoon rain. It claimed nearly 300 lives, injured hundreds, and displaced over 10,000 people. Entire settlements were wiped out, with many people buried under debris as they slept.

Rescue teams, including the Army and NDRF, worked round the clock to save survivors, and a Bailey bridge was built in 31 hours to restore access. One year later, many still struggle with trauma, loss, and slow-paced rehabilitation. For Shyja Baby,

the visit brought back unbearable memories. As the former ward member of Mundakkai, she had lived among the victims. On the morning of the landslide, she found herself helping



The Bailey bridge still stretches across the Punnappuzha river. Faded, it says nothing, but holds the weight of everything that happened. On Tuesday, officials from ULCCS visited the site to take measurements for a new bridge, which the PWD hopes to begin building by August.

Outside the no-go zone, a few shops remain open. One of them belongs to Rekha, a Chooralmala native who refused to leave. "Only plantation workers and a few policemen stop by," she said. "But we have nowhere else to go. Even if it hurts, this is home." As usual a special KSRTC bus rolled through the Chooralmala road, picking up children. They used to study at Mundakkai LP School and Vellarmala GVHSS—schools that were swallowed by the landslide. Now, the children sit in borrowed classrooms—Mundakkai LP students inside the Meppadi Panchayat Hall, and Vellarmala students at the Meppadi HSS.

## Mumbaikars lose Rs 1,127 crore to cybercrime in 15 months

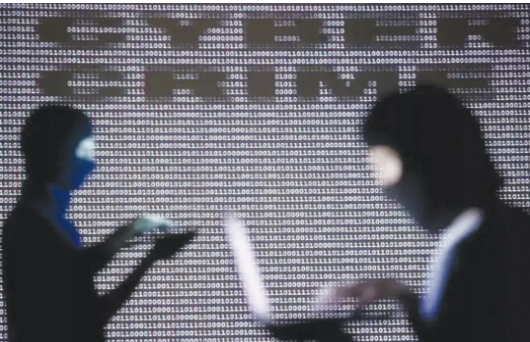
**MUMBAI.(Agency)**

Mumbaikars lost Rs 1,127 crore to various cybercrimes in the 15 months from Jan 2024 to March 2025, data with the city police shows. Around 85% of the total financial losses — nearly Rs 964 crore — were a result of cyber-cheating, which includes share trading frauds, digital arrests, cryptocurrency scams, provident fund scams and such.

Incidents of sextortion resulted in losses up to Rs 47 crore while credit card fraud resulted in losses of Rs 34 crore in the same period.

Experts demanded more accountability from banks and penalties for non-compliance of guidelines. They demanded govt-run insurance schemes for cybercrime related financial losses and mental health interventions for victims.

Cybercrime lawyer Prashant Mali said actual losses could be higher than what the police data reflects. "Fearing social ostracisation, not every victim would approach the police to report a cybercrime. Even in instances where



victims come forward, the complaint may not be converted into an FIR," Mali said.

In March, an elderly woman from south Mumbai lost Rs 20 crore in a digital arrest scam where she was accused of money laundering and kept hostage at home for two months. Earlier this month, a pilot working with a leading airline was duped of Rs 3 crore in a meticulously planned investment scam which involved a malicious trading app.

## HC lifts stay on civil prison order against builder, initiates contempt proceedings

**Ahmedabad.(Agency)**

The Gujarat high court has lifted the stay on an order by the Gujarat Real Estate Regulatory Authority (GujRERA) to detain office bearers of Pacifica Developers Pvt Ltd, including its managing director Rakesh Israni, in a 60-day civil prison. The developers were penalised for failing to hand over possession of a house to a customer and allegedly selling the same property to a third party.

In addition to clearing the way for execution of the civil prison order, Justice Vaibhavi Nanavati last week referred the case to a division bench for the initiation of contempt of court proceedings against Israni, the company, and other office bearers—Darpan Tarwani, Kaushik Patel, and Jay Chandani—for making false statements before the court. "The conduct of the original petitioners in SCA No. 20527 of 2022 is contemptuous and requires action. This court deems it fit to refer the original petitioners to the bench handling contempt matters," the order reads.

In 2019, GujRERA had ordered Pacifica



Developers to hand over possession of a flat to the complainant, Rachna Sharma. When they failed to comply, GujRERA, in October 2022, directed that Israni and others be sent to civil prison for 60 days.

The developers approached the high court after couple days, offering a settlement and depositing Rs 24 lakh, as ordered by the court, to

be paid to Sharma. The court accepted the proposal and stayed the GujRERA order of civil detention.

Later, Sharma's advocate, Vishal Dave, informed the court that the developers had approached the high court again and sought to withdraw their petition, stating they would instead file an appeal before the RERA appellate tribunal. The court allowed this and continued the stay on the civil detention order.

However, in 2024, Sharma approached the court again, stating that the developers had never filed an appeal before the appellate tribunal and had continued to enjoy the stay order wrongfully.

Justice Nanavati observed, "The aforesaid in the opinion of this court, is nothing but abuse of process of law and the said act is contemptuous in nature and in the opinion of this court, the original petitioners (builders) are jointly and severally liable for the same." While referring the matter to a division bench for contempt proceedings, the high court also ordered the release of the Rs 24 lakh deposit to Sharma.

A dominant presence will no longer be felt in Gir. Jay and Veeru, the iconic pair of lions who hunted and ruled together have reunited — in death. Over a month after Veeru's death from fatal fight injuries, his partner, Jay joined him, losing his battle with serious injuries suffered during an episode of in-fighting on June 7 that had also left buddy in death's arms. Forest officials announced Jay breathed his last on Tuesday afternoon. Veeru had died during treatment on June 11.

"Jay too suffered serious injuries to his rear and was under treatment. We tried our best to save him. When modern medicine could not heal him, we even tried ayurveda, but in vain," said Mohan Ram, deputy conservator of forest headquarters, Sasan. The pair, always together for close to five years, were given the names for their bond which was as fierce as their dominance, just like the heroic pair of the film, 'Sholay'. "They were inseparable when alive, and could not be separated by death either, till they died," said a senior officer who has tracked the duo in the past.

Department officials said the two lions were attacked separately by two different groups of males. Jay, attacked first by a group from the Kasia area, was brought in for treatment with serious injuries to his rear. "Left alone, Veeru was attacked by another group from the Khokar side, all in the protected Gir Sanctuary. The injuries were grave — Veeru had three to four deep bite marks in the rear — which proved fatal for him. He stopped eating and died on June 11," an official said.

"Jay and Veeru dominated nearly half of the tourism zone and were never spotted alone. It was destiny that Jay ventured out alone while Veeru went in the other direction. The two had control from Malanka to Kasia Ness and Gadharia. The two males had about 15 females in their group, eight to nine sub-adults and about 14 cubs who were below one year," said a senior officer.

# LDF, UDF delegations in Chhattisgarh protest over arrest of Malayali nuns

**KOCHI.** Amid rising political tension over the arrest of two Catholic nuns hailing from Kerala, delegations of LDF and UDF arrived at Durg in Chhattisgarh on Tuesday. While the UDF delegation could meet Sr Vandana and Sr Peethy Mary, the LDF team was asked to return on Wednesday. Angamaly MLA Roji M John, Kollam MP N K Premachandran, Chalakudy MP Benny Behanan, Kottayam MP Francis George and Saji Joseph comprised the UDF delegation. The LDF delegation, led by Brinda Karat and including Rajya Sabha MPs Jose K Mani, A A Rahim, P P Suneer and John Brittas and Alathur MP K Radhakrishnan, is scheduled to meet the nuns between 9am and 10am.

Francis told TNIE that they were not

allowed to meet the nuns initially. This led the UDF delegation to stage an impromptu dharna in front of the police station. "The police prevented us from entering the station and told us to come the next day. However, we came to know BJP leaders Anoop Antony and Shone George had been allowed to meet the nuns earlier. They are the reason why we were turned away," alleged Francis.

Following this, the UDF leaders contacted former Chhattisgarh chief minister Bhupesh Baghel. "He ensured that we meet the nuns. The nuns are doing okay under the current circumstances. We talked to them. Though emotionally traumatised, they have not been harmed physically. But that can't be said about the man who had accompanied the three girls. He

suffered physical harm," said the UDF MP.

Meanwhile, the LDF delegation arrived at Durg only in the evening. "We arrived late and were told that the visiting time was over. We have been asked to come between 9am and 10am on Wednesday. We will be talking to the nuns and also their family members, who have arrived here, to coordinate the next legal steps that need to be taken. A bail application will be moved on Wednesday," Jose K Mani told.

**Church outfits protest against arrest of nuns**

Various Church organisations staged protests in Ernakulam and Thrissur on Tuesday against the arrest of two nuns in Chhattisgarh. In Kochi, the Kerala Latin Catholic Association (KLCA) took out a protest march,

condemning the arrests as being based on false charges. The protestors termed the incident an encroachment on the Constitution and accused the Chhattisgarh government of enabling communal forces. The KLCA also called for strong intervention from the Central government in the matter. In Thrissur, a protest march was held under the aegis of the Syro-Malabar Church's Thrissur archdiocese.

**Muraleedharan alleges attempts to target BJP**

Senior BJP leader V Muraleedharan has come out against attempts to target the BJP in the arrest of nuns in Chhattisgarh. At a political explanation meeting at Pallithura here, Muraleedharan alleged a conspiracy behind the allegations targeting the BJP.





## Big platforms take over, small businesses flutter

Small is beautiful. Well, it was. Once upon a time. Today, life in the fast-track world of business and commerce is about scale. Big is beautiful, the model embraced by all. I talk of India today in particular. If you peek into the realm of commerce, it is e-commerce and D2C. If you peek into the food ordering and restaurant business, it is the big that dominates. Food-delivery apps are the norm, and no small restaurant can afford to be outside of it. If you look into the realm of public commute, cab-aggregator apps are the norm. The standalone autorickshaw or cab driver outside of this ecosystem is struggling to survive. I base this entire column on my recent research exercise, where I took random sample sizes from three distinct realms: The grocery business, fresh food outlets (restaurants) and the cab commute business (autorickshaws and taxi cabs included). The data summation is of India’s top eight cities. The breaking news is the sad fact that every small business across these three verticals is battling to survive. Being a standalone player in these three spaces is no longer a viable business proposition. This is particularly so when it comes to traditional nondifferentiated businesses in each realm. Take autorickshaw drivers in Bengaluru. The city currently has 3,55,000 autos.Competition is intense, and the ratio of autorickshaws to humans is rather dense. The small, standalone autorickshaw driver, who is not on a cab aggregator app, is fighting to survive. Therefore, every auto driver wants to be on an app because finding customers is suddenly that much easier. The app appropriates that task. Business happens. And for this business to happen, you need to belong to an app.The restaurant business in the past was about establishing a set of in-restaurant diners who would come in seeking a great taste. Every restaurant had a set of items which no one else had. A Peter Cat in Kolkata had to be visited for something specific, just as an Arsalan was a mandatory visit for the best biryanis to try. Things have changed, however, today. The food-delivery apps are in with vigour. If you observe the traffic flow in Mumbai, Delhi, Bengaluru, Kolkata, or any of the eight cities we have studied, at lunchtime, 13 percent of it comprises food delivery aggregators.Artrifical Inteligence usesArtificial Intelligence uses

The same is the case with your corner ‘kirana’ grocery outlet. You need to belong to an app that takes online orders and distributes them. Out here, however, life is more complex. The aggregator has decided not to distribute orders around to the kirana stores. Instead, the aggregator has invested in their own dark store. He procures stocks directly from the manufacturer, eliminating the shopkeeper as a middleman. The app is the middleman. In the bargain, kirana outlets in Indore have lost as much as 31 percent of their top-line business volume. In Chennai, the hit rate is a deeper 37 percent. Every city has its unique story about top-line volume loss.On top of it, the top-line volume loss has put pressure on the small store and its margin. The small store owner has now reduced his prices to sell to those who still come to him as part of a desperate customer retention policy. In the bargain, his margin is down as well. A typical 12 percent margin on most fast-moving products has now decreased to 8.5 percent in Indore and 8 percent in Chennai. This loss of topline volume and bottom-line margin has impacted those employed in these stores. Job losses are the norm. Livelihoods are, therefore, under stress.

We then checked 107 traffic signals in the big cities. At lunchtime (between 12:30 and 2:30 pm), a whopping 13 percent of vehicles belong to food aggregator apps, and 14 percent to grocery delivery apps. The rest of the traffic belongs to you and me; nearly six percent represents the cab aggregator apps. That’s a lot of vehicles on the road that have replaced the small ones. Big is the norm.

## The charge of the lumpen brigade

### Libertarian education can enable us to overcome the prevalent cultural neurosis

IT seems that we are living in a wounded society characterised by some sort of cultural neurosis, widespread violence, hatred and anger. Where are the ideals of India as a civilisation — the ideals we learned from great sages, mystics, poets, philosophers and freedom fighters? Why is it that all noble visions — say, the ethos of cultural/religious/linguistic pluralism; the quest for a fine thread of harmony and connectedness amid splendid diversities; and the longing for the union of the material and the spiritual — are disappearing fast?Of course, it is possible to say that these ideals are just empty words, and India was never free from institutionalised hierarchy, social and economic inequality, cultural conflict and associated violence. Yet, in the process of our journey towards modernity and decolonisation, as a careful look at the works of Gandhi, Tagore, Nehru, Ambedkar, Maulana Azad and above all, the vision implicit in our Constitution would indicate, we sought to strive for these principles. India was economically poor, but our civilisational ideal was pretty high.The irony is that at this moment, when the nation loves to flaunt the tag of the ‘fourth largest economy’ in the world, there is no end to our moral and cultural fall. Take, for instance, what we witnessed recently in the streets of Uttarakhand and Uttar Pradesh: the degradation of Kanwar Yatra — an annual pilgrimage of the devotees of Shiva to sacred sites like Hardwar, Gaumukh and Gangotri in order to fetch holy water of the Ganga, and carry it on their shoulders for hundreds of miles to offer it in their local Shiva shrines — into sheer hooliganism and vandalism. Yes, some of these ‘pilgrims’, it seems, were on a mission to demonstrate their anger and brute masculinity. We saw how they targeted roadside dhabas and stalls over disputes on nameplates; we saw them vandalising a school bus in Meerut; and they even punched a CRPF jawan at Mirzapur railway station during an argument over train tickets. Their noisy journey generated fear and anxiety, not the rhythmic music of spiritual harmony. Even though Uttar Pradesh Chief Minister Yogi Adityanath warned us against ‘defaming’ Kanwariyas,



the reflection of India’s diversities. Yet, when we see angry members of the Maharashtra Navnirman Sena attacking a food stall owner in Thane for his inability to speak in Marathi, we realise how this sort of linguistic chauvinism negates the very spirit of India.Or, imagine a young software engineer from West Bengal or Assam who has just arrived in Bengaluru in search of a better fortune. You cannot expect her/him to speak Kannada fluently; possibly, she/he will try to communicate with a cab driver or a delivery boy in

broken Hindi or English. This is understandable. However, because of the absence of even this minimal empathy, we are seeing overenthusiastic ‘pro-Kannada’ groups asking these ‘outsiders’ to speak Kannada or leave Karnataka immediately. Of course, it is desirable to see beyond our mother tongues, expand our mental horizons and become sensitive to the rich traditions of many other languages. In fact, it is the art of good translation that helps us internalise the spirit of cross-cultural conversations. I do not know Kannada. However, it is the power of good translation as a bridge between cultures that has enabled me to read the works of a great Kannada literary figure like the late UR Ananthamurthy, and enrich my vision of the world. Likewise, I assume that there are many Tamil-speaking people who too, because of translation, have read the works of Munshi Premchand and got a glimpse of the rich Hindi literary sphere. We need this willingness to overcome the otherness of the ‘other’. However, the closure of the mind we see in the recent language politics negates this very spirit of India as a civilisation. Possibly, it is the fear of the ‘other’, and the resultant paranoid and psychic insecurity that leads to this sort of cultural neurosis. Is there any way we can heal ourselves, and move towards collective sanity? Even though the master narrative of Hindutva speaks of unity, it is essentially divisive as it is based on a conflicting binary: Hindus vs Muslims. The violence implicit in such a homogenised doctrine is infectious.No wonder it even simplifies Hinduism and misses the heterodoxy within it. Not every Hindu, for instance, worships Rama. Or, for that matter, not every Hindu is a vegetarian. If you visit Kolkata during the Durga Puja festival, you are bound to see Bengali Hindus enjoying chicken biryani and fish cutlet outside pandals. Even if a vegetarian Gujarati Hindu feels uneasy with this indulgence with non-vegetarian food, the fact is that it can’t be wished away.We need to accept this wonder called India, and cherish these diversities. It is this libertarian education that alone can enable us to overcome the prevalent cultural neurosis.

## TCS layoffs flag AI-induced pain, need for safety net

**The TCS disclosure reminds us of the consequences of AI—the programming of machines to simulate human intelligence**

Everyone knew that artificial intelligence (AI) had arrived, and it would cost jobs. When it has hit home, it hurts. India’s largest IT services provider, Tata Consultancy Services (TCS), has announced it will lay off 12,260 employees, around 2 percent of its global workforce, this financial year. The company deemed it necessary to become ‘future-ready’ in an era of AI-led business transformation. It is a euphemism for describing the challenging times TCS and other IT companies face in a slowing global economy, increased competition and turbulent tariff and other geopolitical challenges. TCS’s plans come soon after its poorest first-quarter financial performance since 2020. The results showed that overall revenue fell by 3.1 percent, while dollar revenues slipped 1.1 percent. Artificial Intelligence usesArtificial Intelligence uses

TCS isn’t the only one letting go of its employees. Start-ups have retrenched 3,600 personnel early this year. Other tech companies, including Infosys, Wipro, and HCL Tech have slowed fresher recruitment and let go of small batches of older staff. At the international level, it’s a stampede. Tech



giant Microsoft terminated over 6,000 employees this May. The announcement followed the confirmation by CEO Satya Nadella that AI currently writes 30 percent of the company’s code. One employment tracker has claimed that over 80,000 employees across 169 tech companies

have been laid off in 2025.The TCS disclosure reminds us of the consequences of AI—the programming of machines to simulate human intelligence, enabling them to ‘think’ and ‘learn’ to solve problems, make predictions and take decisions. Management consultancy Goldman Sachs reminds us we could lose as many as 300 million full-time jobs worldwide. McKinsey projects that by 2030, nearly 30 percent of working hours in the US could be automated. However, all technological change—AI is a significant one—creates turbulence in the present, but yields rewards in the future. Many have forgotten that computerisation arrived decades ago, accompanied by some job losses, but it ultimately expanded the employment base manifold in the long run. The World Economic Forum’s recent “Future of Jobs” report, for instance, forecasts that 83 million jobs globally will be eliminated by 2027, but 69 million new roles will emerge. What is necessary, though, is an immediate safety net that will retrain and redeploy those who have been rendered redundant.

## 17th BRICS Summit: Bold words, blunt impact

**While this Declaration is timely and music to many, and at first glance looks impressive and ambitious, a closer reading reveals its limited substance. Instead of providing new solutions, many of the clauses reiterate past positions and lack substantive commitment**

If one were to go solely by the Declaration of the 17th BRICS Summit held in Rio de Janeiro without context, the Summit appears to be a roaring success. It hit the right notes on cooperation, projecting a cohesive voice for the Global South, and standing up to the Global North with calls for radical economic and governance reform. With the Declaration spanning over 100 clauses that cover the BRICS pillars of political and security, economic and financial, cultural and people-to-people cooperation, the Declaration at first glance appears both extensive and impressive. However, beneath the rhetoric, the document essentially reiterates past positions, which lack substance and fail to provide a clear roadmap for implementation.The core of the BRICS agenda has been to position and present itself as an alliance to counter Western dominance and advance Global South cooperation. The Declaration recognises the need for progressive tax reform to help reduce inequality. However, it limits itself to the UN Framework Convention on International Tax Cooperation, while missing the opportunity to discuss and develop other mechanisms for just taxation, such as global corporate tax or programmes for regional tax cooperation among BRICS+ countries. The Declaration raises alarm about an increase in global military spending. It also reiterated BRICS’ commitment to the peaceful resolution of international disputes through dialogue, consultation and diplomacy. It condemned the military strikes against Iran, a member of BRICS, in particular on ‘peaceful nuclear facilities’. It called it a violation of international law and the Charter of the United Nations, as well as relevant resolutions of the IAEA.

It raised grave concern about the continuous Israeli attacks against Gaza, obstruction of the entry of humanitarian aid into the territory and use of starvation as a method of warfare, and called for adherence to international law.It called for negotiations to achieve an “immediate, permanent and unconditional ceasefire, the full withdrawal of Israeli forces from the Gaza Strip and all other parts of the Occupied Palestinian Territory”. Taking the US tariff regime by its horns, it raised serious concerns about the rise of unilateral tariff and non-tariff measures. That, and several trade cooperations on agriculture, fisheries and aquaculture and digital infrastructure, among others, have invited an immediate and (now) predictable response from President Trump, threatening to impose a 10 percent additional tariff on nations backing ‘anti-American’ BRICS.The Declaration also acknowledges the high debt levels in some countries, which reduce the fiscal space needed to address ongoing development challenges as well as resolving to remain united in the pursuit of the purpose and goals of the Paris Agreement, at a time when the Trump Administration withdrew from the Paris Climate Accord, reversing prior US commitments to global climate action. While this Declaration is timely and music to many, and at first glance looks impressive and ambitious, a closer reading reveals its limited substance. For example, from 2012 to 2023, six BRICS summit declarations—hosted in New Delhi (2012, 2021), Ufa (2015), Moscow (2020), Beijing (2022), and Kazan (2023)—have explicitly demanded reforms in multilateral institutions, including the UN Security Council, IMF, WTO, and related bodies. The demand did not go any further. With 45 percent of the global population and over 35 percent of the world’s GDP, this

Declaration does not outline how they intend to leverage the power of this alliance to achieve something differently this time.Across this and previous Declarations, importance and centrality are placed on Western-led institutions, rather than creating mechanisms for autonomy and leverage or developing alternative frameworks.Countries like India, which try to tread two paths simultaneously—being the ‘Voice of

Global South’ and maintaining good relations with the United States regime—weaken the ability of BRICS to stand upright. India seemed to have sleepwalked into the Declaration. After abstaining from a UNGA resolution calling for “immediate, unconditional, lasting ceasefire in Gaza” and refusing to sign the SCO statement condemning Israel’s military strikes on Iran, both in June 2025, India’s signing the BRICS statement, which is unequivocal on both issues, is either because its sleepwalking into it or for the FOMO effect. Persisting with this trend of contradiction, India continues to strengthen economic and security ties with Western allies. Despite the emphasis of the Declaration on multipolarity and SouthSouth solidarity, India’s growing relations with powers such as the US, the UK, Israel, and other countries in the EU suggest otherwise, with India even hosting the QUAD dialogue in 2025. Many of India’s actions contravene the commitments in the Declaration. For example, the current talks between India and the US, which could potentially open up India’s agricultural sector, oppose the commitment to protecting farmers and food systems. These contradictions in India and other countries also contribute to the alliance’s inability to function as a powerful bloc.Seventeen years into its formation, it is clear that BRICS+ must evolve beyond mere words and commitments to consider meaningful reform. Within the current geopolitical context, this need becomes more urgent than ever. With India set to assume the BRICS+ presidency in 2026, it has an opportunity to implement the 17th BRICS Declaration into practice.



# Crèche & girls' hostel at housing units: Buildings sealed in Gurgaon's Sushant Lok-1

**Gurgaon.(Agency)**

Upscale Sushant Lok 1 township saw a major enforcement drive on Sunday and Monday after "glaring violations of residential zoning regulations".

Crèche plots used for schools and dance training facility and a girls' hostel in a residential area — these were among the violations that led to the action by the department of town and country planning (DTCP), which has sealed three key locations. The drive was launched in coordination with local authorities and personnel from Sector 29 police and Sushant Lok police post. In the first case, authorities sealed six rooms at a plot designated for crèche use in C-2 Block.

The premises were being used for unauthorised activities such as primary and secondary school classes, as well as dance training — none of which are permitted in residential crèche plots. This misuse raised serious concerns

regarding child safety, traffic congestion and violation of approved land use.

In the second case, an entire building in B-Block was sealed after it was found to be operating as a girls' hostel and for other commercial purposes, despite being situated in a residential zone.

According to officials, the conversion of residential premises into high-density commercial accommodations like hostels not only violates zoning laws but also disturbs the peaceful character of the neighbourhood and puts pressure on civic infrastructure. The third and perhaps most concerning violation involved unauthorised construction in the stilt (parking) area of a residential building, despite the property having already been granted an occupation certificate. Authorities found fresh brickwork and partitioning activity underway, indicating an attempt to convert the stilt space into habitable or



commercial units. The space was promptly sealed to prevent further misuse. A senior DTCP official

said, "Such enforcement drives are necessary to maintain the planned character of Gurgaon's residential areas. Illegal conversions not only breach development norms but also compromise structural safety and public convenience."

Reactions from residents were mixed. Kavita Sharma, a long-time resident of Sushant Lok 1, welcomed the crackdown. "I'm glad the authorities are finally taking action. These illegal setups were turning our quiet lane into a noisy, congested commercial street," she said.

However, not everyone was in agreement. Ramesh Arora, a property owner in the area, expressed disappointment, saying, "There's no clear communication or warnings. People invest their savings into these properties. A little flexibility or at least prior notice would help."

## 6 lanes, footpaths: Revamp for key e-way link by early next year in Gurgaon

**Gurgaon.(Agency)**

The long-pending revamp of the stretch connecting Naurangpur Road and Rampura Chowk on NH8 may kick off early next year, with GMDA having received the administrative approval for the project in April. According to the GMDA's plan, the upgraded stretch will have an 84m wide road, featuring a six-lane main carriageway, surface drains, footpaths and a central verge. The corridor will also improve connectivity with Tauru, Nuh and parts of Rajasthan. The key arterial road — connecting Naurangpur to Rampura Chowk on NH8 — serves as a lifeline for residents of sectors 78, 79 and 80.

It has long suffered from poor road conditions and increasing traffic volumes due to rapid urbanisation in the surrounding areas. This expansion is expected to ease mounting traffic pressure in the newly developed sectors along the highway. The existing 5.5-metre-wide stretch has become "increasingly unsafe" and inconvenient for daily commuters.

GMDA is now in the process of appointing a consultant to prepare a detailed project report (DPR), which is crucial, officials said, since multiple utilities — such as water pipelines, sewerage lines, electricity cables and telecom infrastructure — are laid along the 2km-long corridor. A proper assessment is needed to plan their relocation and estimate the overall project cost. GMDA earlier estimated the cost of redevelopment at Rs 41.8 crore. A GMDA official said, "The report will help assess the cost of relocating these utilities and help in executing the work in a planned manner to minimise disruption."

While the alignment of this master road was finalised years ago and land compensation awarded in 2016, the project faced multiple setbacks due to encroachments and administrative delays. A breakthrough came in March this year when Haryana Shehri Vikas Pradhikaran carried out a demolition drive to remove illegal structures blocking the proposed alignment.

## Flaws in infra, sewage spills into parks & open plots, raises a stink in Gurgaon's Sector 9A

**Gurgaon. (Agency)**

Residents of Sector 9A have been facing persistent sewage overflows due to a malfunctioning main pumping station (MPS) in the area. They pointed out repeated failure of the pumping station to channel sewage to the treatment plant (STP), resulting in raw sewage continuing to stagnate near residential areas and creating an unbearable stench, further posing severe hygiene and environmental risks. Residents have written to GMDA CEO Shyamal Misra, seeking his intervention on the matter. The MPS was built to channel sewage across the railway line to a treatment plant at Dhanwapur.

Residents say that raw sewage flows along the railway track and spills into nearby green belts, parks, and open plots. "This is not a one-off issue after rains; we have been living with this for years. Our parks have turned into dumping grounds for sewage. The trees we planted five to six years ago started dying, and the park is no longer safe for any kind of use," said Lalit Bhola, general secretary of the RWA.

According to residents, they have made repeated complaints to GMDA officials, but no lasting measures have been taken to resolve the issue. "Every time we raise the matter, we are told the motors are under capacity or the system is overloaded — but nothing is done to prevent the sewage



from spilling out," Bhola added.

In response, a GMDA official maintained that the system is working as intended. "The main pumping station is functioning at full capacity, and the discharge is occurring through freefall, ensuring smooth outflow. During the monsoon season, the MPS can pump up to 230

MLD against its 168 MLD usual capacity," the official said. Residents, however, questioned these claims. "If everything is running smoothly, then why is sewage still flowing through our sector?" asked RS Balwada, a resident.

With the ongoing monsoon intensifying the overflow, residents say the situation is worsening, with no interim arrangements such as containment or redirection in place. "Besides creating unlivable conditions in our sector, it is causing environmental degradation. There should be some temporary arrangement as they cannot remain in denial while residents keep suffering," Balwada added. In July last year, the govt had approved the augmentation of the existing main pumping station up to 665.5 MLD capacity. Subsequently, the GMDA started the tendering process in May this year, but extended the timeline for submitting the bid to August. Once construction begins, the project, estimated at Rs 97.6 crore, will take two years to complete.

## Torn between grief & bills, says mother of 5-yr-old killed in BMW hit-&-run

**Noida. (Agency)**

Tanzeela Khatoun's life has been upended by grief as she tends to her critically injured husband while mourning the loss of her five-year-old daughter and 20-year-old brother in a hit-and-run crash involving a BMW on Sunday. "I am praying for my husband's recovery," she said. "But one sad news after another has shaken my faith. I haven't even had the time to grieve properly for my daughter, and now my brother is gone too." With her husband, Gul Mohammad, admitted at Delhi's Safdarjung hospital, Tanzeela says she has just been running between the hospital and home. On Saturday evening, Tanzeela had sat holding Ayaat in her arms as the child writhed in pain—a throbbing earache had left her nauseous. "Ayaat kept crying the whole evening. So, when my husband

came home around 9pm, he decided to take her to the hospital. Who knew she'd never return? Her siblings keep asking about her, and I don't know what to say," Tanzeela added. Ayaat, who had started attending a local Anganwadi school a few months ago, died on the spot after the BMW, allegedly driven by a 20-year-old man under the influence of alcohol, crashed into Gul's scooter near Child PGI in Sector 30 around 12.20am on Sunday as they were returning home from the hospital. Gul and Raza, who had also accompanied them to the hospital, were critically injured as the scooter was dragged for nearly 100 metres due to the impact of the collision.

In the FIR, police said Gul had approached a U-turn near the hospital from the wrong side on his scooter when the BMW rammed it. Yash Sharma (20) of Sector 37, who was

behind the wheel, and Abhishek Rawat (22) of Sector 70, who was accompanying him in the car, were arrested on Sunday within hours of the crash. On Monday, the two men got out on bail. "They killed two people and walked free in 24 hours. How is that justice?" Tanzeela's younger brother, Masoom, asked. "If this is the value of a poor person's life, what are we supposed to believe? These rich people can buy their way out while we lose everything."

Masoom also flagged delays in Raza's treatment at the hospital. "When Raza and my brother-in-law were taken to the hospital, they didn't get immediate medical help. We were told to first deposit money. How could we arrange Rs 1-2 lakh in the middle of the night? Every moment mattered.

## 'System has collapsed': 650 private hospitals in Haryana to exit Ayushman Scheme; reimbursements stuck, facilities strained

Indian Medical Association's Haryana unit on Tuesday issued a notice announcing that 650 private hospitals across the state will stop treating patients under the Centre's Ayushman Bharat scheme from Aug 7 if reimbursements amounting to Rs 500 crore aren't cleared by then. Officials of IMA (Haryana), which had issued a similar warning in Jan earlier this year, said the state's administration of the scheme was in a state of "chronic breakdown". Most private hospitals have only gotten 10-15% of their billed amounts in reimbursements since March, forcing them to dip into their own reserves or turn patients away, they said.

"The situation is worse than before. Hospitals cannot continue offering free treatment under the scheme without timely reimbursements. We're now at a point where running the system is financially impossible," said Dr Mahavir Jain, president of IMA (Haryana).

According to Haryana govt data, there are 1,300 hospitals, including 650 private ones and 60 in Gurgaon, empanelled under the Ayushman Bharat scheme. Around 1.8 crore people in the state are registered under the health insurance scheme, which was launched by the central govt in 2018 to provide free medical facilities and treatments up to Rs 5 lakh a year. Ayushman Bharat, which covers anything between routine tests to surgeries, can be availed by families with annual income of less than Rs 2.5 lakh, the elderly, and others. Hospitals empanelled under the scheme provide free-of-charge treatment to registered patients and later raise reimbursement requests from the govt on an online portal. These reimbursements are reviewed and cleared by a state agency, after which payments are disbursed.

"Govt promised us that dues would be cleared soon after our meeting with the chief minister earlier this year. But the delays have continued, and many hospitals are now getting reimbursement amounts with arbitrary deductions and without any explanations," said Dr Dhirendar K Soni, secretary of IMA-Haryana.

## 33-year-old man found dead, father alleges murder by two friends

**Faridabad. (Agency)**

A 33-year-old property dealer allegedly took his life by hanging himself in his home in Sector 8, Faridabad. His father, however, alleged his two friends, who were also his business partners, had murdered him.

A case has been registered under BNS sections 103 (murder) and 3(5) (common intention).

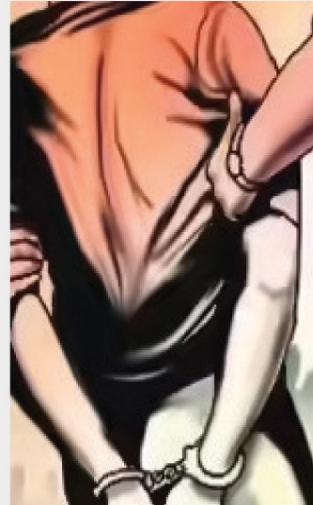
Avedit had been living in Faridabad for the last three years and had a property business with his friends, Yatin and Amit. "My son told me several times that his business partners were threatening and intimidating him over business transactions," Avedit's father said in his complaint. He was informed on Monday afternoon that his son was admitted to Sarvodaya Hospital and found out he had passed away once he reached the hospital. According to the police, his body was found hanging from his house's ceiling fan using a bedsheet. "Yatin, came to his house around 9.30am. When Avedit did not answer the door, Yatin knocked the door down and found him there," police officials said. The officer said the family could not reach the hospital by the evening, so the postmortem was delayed. "We have now conducted the postmortem and have handed over the body to the family," police said. According to police, the exact cause of Avedit's death will be known after the forensic report is published, after which further investigation will begin. As of now, none of the alleged accused have not been questioned in the matter.

## Man accused of theft hung upside down and thrashed in Gurgaon condo, 4 arrested

**NOIDA. (Agency)**

A man was hung upside down and thrashed with sticks as people watched from a distance at an under-construction building at ILG Greens society.

The victim, a resident of Rajasthan who worked as an earthmover operator, was allegedly caught stealing power cables from the society campus in June. A video of the assault recently uploaded on social media showed him crying and pleading for mercy while being thrashed by his assailants. A security guard's attempt to intervene proved futile. Although no formal complaint was filed, cops in the city took suo motu cognisance of the video and arrested four security guards employed at the society in Sector 37C. The arrested accused are Pushpendra (39) from Madhya Pradesh, Kirshan Kumar (19) and Ajit Singh (38) from Haryana, and Amit Kumar (39) from Punjab. "We initiated legal action despite the victim not approaching us. The incident appears to be from June 10 or 11," said assistant sub-inspector Sandeep Kumar. A case was registered against the guards under sections 115 (voluntarily causing hurt), 127(2) (wrongful confinement), 3(5) (act done by several persons), and 351(2) (criminal intimidation) of the BNS at Sector 10 police station.



## 'People who came here with dreams disgraced', say TMC MPs in Gurgaon

**Gurgaon. (Agency)**

Five Trinamool Congress MPs on Tuesday visited the city to interact with migrant workers, several of whom were rounded up and detained last week as Gurgaon police launched a drive to identify Bangladeshis and Rohingya living illegally in the city. Rajya Sabha MPs Mamata Thakur and Prakash Baraik, and Lok Sabha MPs Sharmila Sarkar, Pratima Mondal and Bapi Haldar went to Maidawas village in Sector 64, where they listened to accounts of the detention and fears of a recurrence from the settlement's largely Bengali-speaking migrant population. The MPs assured them of help by the Mamata Banerjee-led West Bengal govt. "West Bengal is a part of India. Our people are not Bangladeshis. Police here should behave and treat them respectfully. Many people complained of being tortured and humiliated by cops even though they had all the documents... they were detained because they spoke in Bangla. Our govt is there for our people, and we will take every step to ensure their safety," Haldar, the parliamentarian from Mathurapur Lok Sabha constituency, said. Sarkar, who represents Bardhaman East in Lok Sabha, told TOI that the party delegation



was sent to Gurgaon by chief minister Mamata Banerjee to address panic among people from the state after the verification drive led to many of them packing up and leaving. "The drive could have been handled better. These people came with dreams, but they have been disgraced in Gurgaon," Sarkar said.

Starting July 18, Gurgaon police started detaining workers to follow up on the Union home ministry's May 2 directive to

identify and deport illegal immigrants from the country.

Around 250 people, most living in slum settlements, were detained in four 'holding centres' till police 'verified' their identity documents. Of these, 10 were eventually found to be undocumented immigrants from Bangladesh. The drive sparked a political row as TMC accused BJP of targeting Bangla-speaking workers

indiscriminately. "These illegal detentions are an insult to our mother tongue and ashmita (identity)... Speaking Bangla is being treated as a crime..." Mamata Banerjee had said.

A senior police officer told TOI the drive was simply to identify and deport undocumented migrants. He added that many workers were seen leaving the city to go back to their hometowns in buses with West Bengal registration plates.

"We had asked West Bengal authorities to verify documents within 48 hours, but they took long, and that's why people had to stay at holding centres for four days. They were given good food, bedding and filtered water. Some people are doing politics and causing unnecessary panic, forcing people to leave," the officer said.

Lok Sabha MP Mondal refuted Gurgaon police's claims that the workers were detained for days because the West Bengal govt delayed the verification process. Mondal, who represents Jaynagar constituency, said police had seized workers' mobile phones. "So, they couldn't reach out to us. Still, we responded speedily to verification queries," she said.



# Delhi Residents Can Now Resolve Gas, Loan, Banking Disputes Without Court

Delhi residents facing issues loan defaults, gas supply disruptions or service lapses by banks and NBFCs may no longer need to take the long road to court. Delhi Lieutenant Governor V.K. Saxena has approved a proposal designating banking, non-banking financial companies (NBFCs), and gas supply as Public Utility Services, enabling their disputes to be resolved through Permanent Lok Adalats (PLAs).

This decision allows complaints about banking, NBFCs, or gas services—such as billing errors or service delays—to be settled out of court via Lok Adalats.

The Law Department of the Delhi government had sent the proposal, flagging a rising number of consumer

disputes tied to banks, NBFCs and gas providers. "Most of these cases involve everyday issues like EMI defaults, faulty billing, or service delays," a senior official from the department said, adding that "a lot of complainants don't have the time or means to fight prolonged legal battles."

Permanent Lok Adalats are quasi-judicial forums that offer a quicker and low-cost alternative to courts for resolving service-related disputes. Unlike regular courts, they can settle cases even if one party doesn't agree to a compromise, provided the matter falls under public utility services and doesn't involve criminal allegations.

This inclusion is expected to ease the load on civil courts while offering consumers a

more accessible legal remedy. "People shouldn't have to wait years to resolve simple issues like incorrect bank

private discoms. A fourth Lok Adalat is being planned to deal with other notified services like transport, telecom, water, health, sanitation and insurance.

The move is seen as particularly helpful for consumers who are typically at a disadvantage when facing off against large financial or utility companies. "This could be a game-changer, especially for senior citizens, daily wage workers, or those with limited legal access," a legal aid volunteer told.

For now, the DSLSA will be responsible for implementing the change and facilitating the hearing of cases under the newly included services. Residents can approach the nearest Permanent Lok Adalat for any non-criminal disputes involving these three sectors.

## Mother And Teen Son Killed In Wall Collapse, 4 Days After Arriving In Delhi

**Locals claimed that the boundary wall, built in the 1960s and stretching over 250 metres, collapsed following continuous rainfall.**

Just four days after arriving in Delhi in search of employment, a woman and her teenage son died when a decades-old boundary wall collapsed on their makeshift tent in north Delhi's Sehgal Colony on Tuesday morning. Two other family members were injured in the incident. Meera (40) and her son Ganpath (17) died, while her elder son, Dashrath (19) and brother-in-law Nanhe (35), sustained injuries and are undergoing treatment.

According to police and fire officials, the family had set up a tin shelter on the premises of a residential construction site near Raj Nivas, where they had started working as daily wage labourers for Rs 500 a day. "We came just four days ago to earn a better livelihood. Now we are returning with two bodies," Nanhe

said, speaking from his hospital bed. He said that his brother is still in the village and is unaware of the incident. Nanhe said that they had pitched the tent a couple of feet away from the



boundary wall. "It suddenly collapsed. I was outside with Dashrath but Meera and Ganpath were inside and couldn't escape. I was in shock... I remember people pulling us out and shouting," he recalled. The incident occurred around 9.40 am. Officials received a call regarding the

wall collapse at 9.53 am. A Delhi Fire Services official confirmed the identities of the woman and her son and said that both were declared dead at Aruna Asaf Ali Hospital. Locals claimed that the boundary wall, built in the 1960s and stretching over 250 metres, collapsed following continuous rainfall. They alleged that trees on the elevated land behind the wall had recently been cut down to make way for ongoing construction, which destabilised the soil. "With the downpour, the loose earth slid and pushed against the wall, causing it to collapse," a resident said. The resident, who lives right across the site, said he rushed upon hearing a loud crash. "My 78-year-old sister-in-law was doing her morning prayers when the debris crashed into our compound.

## In Big Relief For Factory Owners, Delhi Civic Body Simplifies Licensing Rules

## Agency New Delhi.

New Delhi, Jul 10 Factory owners in Delhi's notified industrial areas will no longer need separate license from the MCD, as a new rule will treat their property tax receipt as a valid factory licences.

The Municipal Corporation of Delhi (MCD) on Thursday passed a proposal to treat allotment or lease deeds issued by the Delhi government and Ministry of Micro, Small & Medium Enterprises' Udyam Registration Certificates as "deemed factory licences" under Sections 416 and 417 of the Delhi Municipal Corporation Act, 1957.

In a move aimed at promoting ease of doing business, the proposal passed

during the Corporation's ordinary meeting eliminates the need for MCD-issued factory licences in industrial



areas notified by the Delhi government or DSIIDC. Factory owners in these areas will now pay 5 per cent of their annual property tax as the license fee. A single receipt will serve as proof of

both property tax payment and factory license, thus ending the era of frequent inspections and reducing the scope for rent-seeking by officials.

Delhi Mayor Raja Iqbal Singh said that the new system will reduce unnecessary inspections by MCD officials. The responsibility for ensuring compliance with fire safety, environmental clearances and structural norms will rest solely with the factory owner or occupier, who must obtain all necessary approvals from the competent authorities.

Necessary changes will be made to the MCD Property Tax portal to integrate factory license issuance and automate the payment and compliance workflow.

## Delhi MLAs Can Now Raise Issues Digitally As Assembly Goes Paperless



## Agency New Delhi.

MLAs wishing to raise issues under Special Mention in the Delhi Assembly will now have to submit their notices through the National e-Vidhan portal as the House goes paperless from the Monsoon session commencing on August 4, officials said on Tuesday. This will be the third session of the Eighth Legislative Assembly of Delhi. According to the schedule announced by Speaker Vijender Gupta, the sittings of the House are tentatively fixed from August 4 to 8. However, depending on the exigencies, the session may be extended beyond these dates, the statement said.

Each sitting of the House will begin at 2 pm and continue until the scheduled business is concluded for the day.

The speaker has directed that the members intending to raise matters under Rule 280 (Special Mention) must submit their notices exclusively through the NeVA Portal (<https://cms.neva.gov.in/>) by 5 pm on the working day before the intended date, it said.

## Delhi rains: Downpour cripples capital once again

Delhi and its adjoining areas woke up to waterlogged streets and bumper-to-bumper traffic on Tuesday morning, as an intense spell of rain once again crippled city's movement. The IMD issued an orange alert following the continuous rain in the first half of the day. The AAP and Congress came forward to slam the BJP government in Delhi over waterlogging in the city on Tuesday, sarcastically calling it a "marvel" of the four-engine model.

From the Zakhira underpass to Connaught Place, from Safdarjung Hospital to LNJ Hospital, Aam Aadmi Party (AAP) leaders shared videos of waterlogged locations. Sharing a clip of severely waterlogged roads of Connaught Place, AAP National Convener Arvind Kejriwal took to 'X' and wrote, "When this is the condition of Connaught Place, the heart of Delhi, it's not hard to imagine the state of the rest of Delhi. Just 10



minutes of rain and the roads have turned into ponds. In 5 months, where has the BJP brought Delhi to? Is this the speed of the 'four-engine' government?"

Delhi State President Saurabh Bharadwaj and Leader of Opposition (LoP) Atishi, tore down BJP for turning waterlogging into a daily affair under its misgovernance. Bharadwaj posted videos from across Delhi—Connaught Place, the Tibetan Market on Janpath Road just 200m from BJP minister Parvesh Verma's residence, and even RML Hospital. Sharing visuals of stagnant water in RML's gallery, he wrote, "The Centre has ruled it (RML) for 11 years What excuse will they give now?"

Meanwhile, Delhi Congress president, Devender Yadav, alleged that the BJP government's lack of preparations to tackle the monsoon chaos was once again exposed when showers on Tuesday created heavy traffic snarls and waterlogging everywhere. Yadav also claimed that Delhi Congress has been warning the Rekha Gupta government even before the onset of monsoon that the desilting of stormwater drains and sewers should be completed quickly. Delhi went under water in key areas like ITO, Dhaula Kuan, Naryana, Patel Nagar, Kamla Nagar Market, Ambedkar Stadium, Pragati Maidan, GTK Depot, Model Town, Kingsway Camp, among many other areas, he added.

## Four more foreign universities set for India launch

The fifth anniversary of the National Education Policy (NEP) 2020 was marked by the handover of Letters of Intent (LoIs) to the University Grants Commission (UGC) to four universities to open their campuses in India - three from Australia and one from UK.

They were handed over by the Education Minister Dharmendra Pradhan on Tuesday during the launch of an education summit, Akhil Bhartiya Shiksha Samagam (ABSS) 2025.

Projects for more than Rs 4,000 crore across the country including the campus inaugurations were launched by Pradhan. The Western Sydney University will open its campus in Greater Noida, La Trobe University in Bengaluru, and Victoria University in Noida while the University of Bristol will open in Mumbai. With these four, the number of universities handed over the LoI to open their campuses stands at six with one campus already opened.

The University of Liverpool was handed over the LoI for a campus in Bengaluru in May 2025 and the University of Southampton in August 2024. The latter became the first to open its campus in Gurugram in Haryana on June 16 this year under the new NEP policy. "Many more such campuses are in the offing," a senior education official said.

Dr Nicolene Murdoch, Pro Vice-Chancellor, Western Sydney University, said its campus was on course to commence classes by August or September 2026. "We will be offering Bachelors in Business Administration and in IT to start with. We are expecting atleast 100 students to join us in the inaugural year in these graduate streams."

Infrastructure work has already commenced and the first phase will be ready next year, she said. "In the future, we are looking at inviting both Indian companies and Australian ones to offer placements for our students," Murdoch added.

Pradhan said, "Indian ethos lies at the core of NEP. Over the past five years, the government has succeeded in taking NEP 2020 from policy to practice - bringing about a paradigm shift in the education system and reaching classrooms, campuses and communities."

## Delhi HC upholds conviction of Patkar in two-decade-old defamation case

The Delhi High Court on Tuesday upheld the conviction of social activist Medha Patkar in a defamation case filed by Delhi Lieutenant Governor Vinai Kumar Saxena over two decades ago. Justice Shalinder Kaur ruled that there was no error in the trial court and appellate court decisions that found Patkar guilty. The court also agreed with the earlier decision to release Patkar on probation rather than jail her.

However, the High Court gave her some relief by modifying the probation condition that required her to appear before the trial court every three months. Now, she can either appear virtually or be represented by a lawyer.

The case dates back to the year 2000, when Saxena, then President of an organisation called National Council of Civil Liberties, had published an advertisement criticising Patkar's Narmada Bachao Andolan (NBA), a movement against dam construction on river Narmada.

In response, Patkar issued a press note alleging that Saxena had earlier supported the NBA and had even donated Rs 40,000 through a cheque from the Lalbhai Group, which later bounced. The press note also questioned Saxena's patriotism and claimed he was acting as an agent for the Gujarat government.

Saxena filed a defamation case against Patkar in Ahmedabad in 2001. The Supreme Court later transferred the case to Delhi in 2003. In 2024, Patkar was found guilty by a magistrate court, sentenced to five months in jail, and asked to pay Rs 10 lakh in compensation. The court said her statements were made with clear intention to harm Saxena's reputation. On April 2, 2024, a Sessions Court upheld her conviction but reduced the punishment. Patkar was released on probation for one year and asked to pay Rs 1 lakh in compensation instead of Rs 10 lakh.

## 100 lapses, including 7 critical, found at Air India base during audit: Report

India's aviation regulator, the Directorate General of Civil Aviation (DGCA), has flagged nearly 100 safety violations and observations at Air India - including seven critical lapses - following a detailed audit of the airline's Gurugram base earlier this month, reports said Tuesday.

The audit, conducted between July 1 and July 4, examined operations, flight scheduling, rostering, and other key functions. According to the DGCA's findings, the airline was found to be non-compliant in areas such as crew training, duty and rest period regulations, inadequate crew strength, and airfield qualification. Seven of the violations were classified as Level-1, which the DGCA defines as serious safety risks requiring immediate corrective action.

Air India confirmed it had received the audit report and said it would respond within the stipulated timeframe. "All airlines undergo regular audits to test and continuously strengthen processes. Air India's annual DGCA audit took place in July, during which it was fully transparent



with auditors in the spirit of such continuous improvement," the airline said in a statement.

"We acknowledge receipt of the findings and will submit our response to the regulator within the stipulated time frame, along with the details of the

corrective actions taken. Air India remains fully committed to ensuring the safety of its passengers and staff," it added.

The audit findings come amid heightened scrutiny of the airline following the June 12 crash of its London-bound Boeing 787

Dreamliner. The aircraft lost thrust seconds after takeoff from Ahmedabad and crashed into a medical college hostel, killing 241 of the 242 people onboard and 19 on the ground. It was the deadliest aviation disaster in India in over a decade. On June 21, the DGCA directed Air India to remove three officials from all crew scheduling and rostering duties due to serious violations. On July 23, it issued four show-cause notices over breaches related to cabin crew rest norms, training regulations, and operational protocols-following certain voluntary disclosures made earlier by the airline, reports added.

A 15-page preliminary report released this month by the Aircraft Accident Investigation Bureau (AAIB) on the AI171 crash found that fuel supply to both engines was cut off within seconds of each other shortly after takeoff.

The cockpit voice recorder captured one pilot asking, "Why did you cut off?" to which the other responded that he had not done so. Both fuel switches had shifted from 'RUN' to 'CUTOFF' just seconds apart, the report noted.

India unlikely to risk Jasprit Bumrah at Oval as medical staff advises rest: Report

India are unlikely to risk fast bowler Jasprit Bumrah in the 5th Test match of the England series. The pace spearhead, who has already bowled 120 overs in 3 Test matches, has been advised rest, ESPNcricinfo reported on Wednesday, July 29.This is Bumrah's first Test series since his back injury in the Border-Gavaskar Trophy 2024–25, and the Indian Cricket Board medical staff remains conservative over his workload, keeping future tournaments in mind.

The 31-year-old pacer appeared off-colour during the drawn fourth Test at Old Trafford, where he struggled with his pace and failed to make breakthroughs. The report added that Akash Deep, who missed the fourth Test due to a groin niggle, is likely to replace Bumrah in the XI.Earlier, head coach Gautam Gambhir had stated that no decision had been taken regarding team composition and that



all bowlers, including Bumrah, were fit. "We haven't had any conversation around the combination for the last Test," Gambhir had said after the fourth Test in Manchester. "No decision has been made on whether Jasprit Bumrah will play or not. Ultimately, whoever plays, they will try and do the job for the country."

India Bowlers Toil in 4th Test

England piled up a massive 669 in response to India's 358, taking a 311-run first-innings lead at the fourth Test.However, India mounted a remarkable fightback from 0 for 2, batting 143 overs in the second innings with centuries from captain Shubman Gill, Washington Sundar, and Ravindra Jadeja to earn a dramatic draw and stay alive in the five-match series, trailing 1–2.Bumrah bowled 33 overs in the first innings of the fourth Test, the most he has bowled in a single innings, but returned figures of 2 for 103, the first time he conceded over 100 runs in a Test innings.The number of deliveries he bowled over 140kph dropped significantly over the series, from 42.7 percent at Headingley, to 22.3 percent at Lord's, and just 0.5 percent at Old Trafford. Despite his dip in effectiveness, Bumrah remains the joint-highest wicket-taker for India in the series alongside Mohammed Siraj, with 14 wickets to his name.

Jake-Fraser McGurk snubbed from T20I squad as Australia announce squad vs South Africa

Swashbuckling opener Jake Fraser-McGurk was dropped from Australia's white-ball squads against South Africa for the upcoming 6-match white-ball series. Fraser-McGurk, popularly known as JFM, was dropped from the side amidst prolonged poor outings in the T20I format.

JFM has played 8 T20Is so far after his sensational outing in the 2024 season of the Indian Premier League. The opener has played 8 matches, where he has scored just 115 runs at an average of 14.37. His outings in the ODI format have not been up to the mark either. In 7 matches, he has scored just 98 runs at an average of 14.

As Australia build up for the T20 World Cup 2026, they have extended Mitch Owen's stay with the side. The 23-year-old has been rewarded for his fine form in his first 5 T20Is against West Indies by being named in both



of Australia's squads for short-format series against South Africa in the far north of the country next month.The 23-year-old all-rounder, who has yet to play a one-day international, scored 125 runs and took two wickets as Australia swept West Indies in all five T20s in the Caribbean this month.

Mitch Marsh captains both T20 and ODI squads in the absence of regular 50-overs skipper Pat Cummins, who will sit out the series with fellow quick Mitch Starc. Paceman Josh Hazlewood and batter Travis Head return to both squads as Australia continue their preparations for the T20 World Cup in India and Sri Lanka early next year.Steve Smith and Glenn Maxwell have both retired from ODIs but the latter was named in the T20 squad, which will face South Africa in two matches in Darwin and another in Cairns."As we build towards the T20 World Cup the flexibility and depth shown in the West Indies, outside of the obvious results, has been a huge positive," said chief selector George Bailey.

The match will be played at Estadio Rodrigo Paz Delgado, in the capital Quito.It will be a rematch of the final of the 2022 Copa America Femenina that was played in Colombia and that Brazil won 1-0.

This is not how you want to play against this Indian

team. I have always seen that when adversity strikes the Indian team, however it may be, someone will rise up. When things are not going right, or when we are pushed against the wall, the Indian team is a different kettle of fish; it becomes a different beast.""I think that particular thing, going into this Test match, is a serious advantage for India. Maybe this will mean nothing if England play good cricket and India don't end up on the right side, but somehow I have a feeling that this is not the way it has to be triggered," said Ashwin.

'These incidents galvanize the team'

Ashwin pointed out several incidents in India's cricket history, like the monkeygate incident, where the team bounced back brilliantly and secured big wins. The former spinner feels that such an incident will galvanise the team ahead of the crucial match.

He also said that the pitch curator also shouted at the support staff, which made Gambhir snap at him.Later on, a picture of Fortis and England coach Brendon McCullum from the 2023 Ashes emerged online, where it was seen that the curator had no issues standing on the pitch just two days before a match. Chopra talked about this on his YouTube channel and said he found Fortis'

behaviour bizarre and humiliating."It was the same curator in 2023, it was an Ashes match, and two days before that, he was standing on the pitch along with Brendon McCullum, the home team's coach. If he can stand on the pitch 48 hours before the game, can the Indian players not go even close to the pitch? Can the Indian coach not go and see how the pitch is? I find this absolutely bizarre. I find this actually humiliating," said Chopra.Chopra also said that while the words used by Gambhir to Fortis should have been better, he said that he understands where the Indian coach was coming from."There might be a question whether the choice of words was alright. This is about Gautam. Maybe that's not right because you need to be politically correct, as your designation is like that. However, I can totally understand what goes through a person's mind," Chopra observed.Fortis played down the entire spat with Gambhir on Tuesday and declined to discuss the incident further.

She struggled with it during the match, hitting some serves that were well long and others that were soft and easily pounced on by the powerful Collins."It was a frustrating match for me," Gauff said. "I felt like I was practicing well and then I don't think I transferred it today, but hopefully I got my bad match of the tournament out of the way and I could come back stronger the next round."

A balky serve ended her U.S. Open title defense last year, when she committed 19 double-faults in a fourth-round loss to Emma Navarro. The serve was even more erratic Tuesday, though Gauff did hit a good one to end the match with an ace.

She is the top seed in Montreal due to the withdrawal of top-ranked Aryna Sabalenka, the player Gauff beat to win the French Open in June.

## Australia pacer bowls 18 balls in single over, including 12 wides

## India top smartphone supplier to the US in April-June 2025, pips China: Canalys report

**New Delhi.(Agency)**

India has emerged as the largest manufacturing hub for smartphones shipped into the US for the first time in Q2, 2025, as China's share shrunk amid tariff negotiations, according to Canalys. The research from Canalys (now part of Omdia) revealed that United States smartphone shipments grew 1 per cent in the second quarter of the current calendar year as vendors continued to frontload device inventories amid tariff concerns. The uncertain outcome of negotiations with China has accelerated supply chain reorientation, it said.

The share of US smartphone shipments assembled in China fell to 25 per cent in the April-June period, from 61 per cent a year earlier. "Most of this decline has been picked up by India; the total volume of 'Made-in-India' smartphones grew 240 per cent year-on-year and now accounts for 44 per cent of smartphones imported into the US, up from only 13 per cent of smartphone shipments in Q2 2024," it said. In Q2, iPhone shipments declined 11 per cent year-on-year to 13.3 million units, a correction from the 25 per cent growth in Q1, 2025, as per Canalys. Samsung's shipments grew 38 per cent year-on-year to 8.3 million units.

Motorola continued its expansion in the US, growing two per cent to 3.2 million units. Google and TCL rounded off the top five, with Google growing 13 per cent to 0.8 million while TCL declined 23 per cent, shipping 0.7 million units. "India became the leading manufacturing hub for smartphones sold in the US for the very first time in Q2 2025, largely driven by Apple's accelerated supply chain shift to India amid an uncertain trade landscape between the US and China," said Sanyam Chaurasia, Principal Analyst at Canalys.

## Sensex, Nifty open in the green; check prominent gainers and laggards

The Indian benchmark indices of the equity market Sensex 30 and Nifty 50 opened in the green on Wednesday, July 30, in a market enlivened by the robuts quarterly results of infrastructure major L&T. At 9:15 am today, Sensex stood at 81,354.32, up 16.37 points or 0.020%, while Nifty was trading at 24,829.65, up 8.55 points or 0.034%. However, within a few minutes BSE Sensex raced up 256.57 points to reach 81,594.52 while NSE Nifty rose 69.3 points to reach 24,890.40. The global cues were mixed on July 30 morning. Among the major US indices only Dow Jones ended in the green (0.13%) on July 29, while S&P500 and Nasdaq ended in the red by 0.30% and 0.38% respectively. However, all the major European indices FTSE (0.60%), CAC (0.72%) and DAX (1.02%) ended the day in the green. However, the crucial GIFT Nifty was trading in the red on July 30 morning. Nikkei 225, Straits Times and Hang Seng were also in the red But Taiwan Weighted, KOSPI, Jakarta Composite and Shanghai Composite were in the green. Prominent gainers and laggards

In the Sensex laggard, Larsen & Toubro surged by more than 4% per cent following the 29.8% jump in consolidated net profit at Rs 3,617.19 crore in Q1 of FY26. ## Trump's tariffs could squeeze US factories and boost costs by up to 4.5%, a new analysis finds

**WASHINGTON.(Agency)**

As US President Donald Trump prepares to announce new tariff increases, the costs of his policies are starting to come into focus for a domestic manufacturing sector that depends on global supply chains, with a new analysis suggesting factory costs could increase by roughly 2% to 4.5%. "There's going to be a cash squeeze for a lot of these firms," said Chris Bangert-Drowns, the researcher at the Washington Center for Equitable Growth who conducted the analysis. Those seemingly small changes at factories with slim profit margins, Bangert-Drowns said, "could lead to stagnation of wages, if not layoffs and closures of plants" if the costs are untenable. The analysis, released Tuesday, points to the challenges Trump might face in trying to sell his tariffs to the public as a broader political and economic win and not just as evidence his negotiating style gets other nations to back down. The success of Trump's policies ultimately depends on whether everyday Americans become wealthier and factory towns experience revivals, a goal outside economists say his Republican administration is unlikely to meet with tariffs.

Trump has announced new frameworks

with the European Union, Japan, the Philippines, Indonesia and Britain that would each raise the import taxes charged by the United States. He's prepared to levy tariffs against goods from dozens of other countries starting on Friday in the stated range of 15% to



50%. The US stock market has shown relief the tariff rates aren't as high as Trump initially threatened in April and hope for a sense of stability going forward. Trump maintains the tariff revenues will whittle down the budget deficit and help whip up domestic factory jobs, all while playing down the risks of higher prices. "We've wiped out inflation," Trump said last Friday before boarding Marine One while on his way to Scotland. But there's the possibility of backlash in the form of higher prices and slower growth once tariffs flow more fully through the

world economy.

A June survey by the Atlanta Federal Reserve suggested companies would on average pass half of their tariff costs onto US consumers through higher prices. Labor Department data shows America lost 14,000 manufacturing jobs after Trump rolled out his April tariffs, putting a lot of pressure as to whether a rebound starts in the June employment report coming out Friday. With new tariffs in place, there are new costs for factories. The Washington Center for Equitable Growth analysis shows how Trump's devotion to tariffs carries potential economic and political costs for his agenda. In the swing states of Michigan and Wisconsin, more than 1 in 5 jobs are in the critical sectors of manufacturing, construction, mining and oil drilling and maintenance that have high exposures to his import taxes. The artificial intelligence sector Trump last week touted as the future of the economy is dependent on imports. More than 20% of the inputs for computer and electronics manufacturing are imported, so the tariffs could ultimately magnify a hefty multitrillion-dollar price tag for building out the technology in the US.

## Over 1.06 Lakh Claims Settled Under Ayushman Vay Vandana scheme: Health Ministry

MotoCorp, Hindustan Unilever (HUL), IndusInd Bank, and Mahindra & Mahindra (M&M), each shedding between 1% and 2%.

**Sectoral performance**

Sector-wise, weakness was seen in auto, media, and realty indices, each declining about 0.5%. Meanwhile,

buying interest remained intact in capital goods, pharma, and power stocks, which helped cushion the broader market.

**Broader market and global cues**

The overall sentiment remained mixed as investors awaited cues from the US Federal Reserve's interest rate policy

and commentary on inflation. Additionally, concerns over a potential US-India trade standoff continued to linger, with reports suggesting that export tariffs of up to 25% could be imposed on Indian goods if no agreement is reached by August 1.

Foreign institutional investors continued to be net sellers, pulling out Rs 4,640 crore on Tuesday. July's cumulative FII outflows have now crossed \$1.6 billion.

Despite global uncertainty, Indian markets recovered from a three-day losing streak on Monday, with value buying in heavyweights like Reliance Industries and HDFC Bank supporting the rebound.

**Outlook**

According to market analysts, the near-term direction of the market will likely hinge on global macroeconomic developments, foreign fund flows, and domestic earnings announcements. While gains in infrastructure and pharma sectors signal investor preference for fundamentally strong counters, they believe.

Similarly, my wife and I vowed that we would potty train our twins by the time they are two. But we kept racing between our bedroom and the restroom till they turned four. Letting things take its own course is one of the parenting mantras we follow now."

## BONUS, INCREMENT, BRIBES ARE GOOD MOTIVATORS

'Carrot and stick approach' works brilliantly well both with kids and at office. Rehana K, an HR professional, says, "Just like how bonus and increment push staff to perform better, promise of extended playtime and a picnic over the weekend motivates my daughter to study and behave well. Bribery is a punishable offence, but all is fair in love, war and parenting."

## Kids cause greater strain in relationships than illness



Having kids, the main purpose of matrimonial relationships, can bring in greater strains in romantic relationships than illness of partners, a new study suggests.

The study looked at the relationship quality of 721 couples in Switzerland over a period of thirteen years.

"Transition to parenthood is associated with a higher degree of closure of the couple, as well as greater differentiation of functional roles," said researcher Manuela Schicka from the University of Geneva in Switzerland in an official statement.

Schicka, who conducted the research as part of her PhD thesis, explained that women often abandon or substantially reduce their participation in the labour market once they become a mother, because of lack of institutionalised child care facilities. This also generates a great deal of frustration.

On the other hand, illness and accidents are seen as linked to bad luck and not personal responsibility.

There is therefore less grief and bitter thoughts between partners when the latter occur, Schicka stated.

The study also found that transition to retirement succeeds in reuniting couples at an age that is generally not perceived as the most romantic one.

The research demonstrated that while the various styles of conjugal interactions generally remain stable along the life course, some critical life events and transitions weigh much more on relationship quality than others, sometimes in unexpected ways.

## 5 ways to keep your kids safe online

With the proliferation of new technologies and social media apps, it seems these days as if our children are almost constantly online, and as parents/guardians, we sometimes have a tough time keeping pace.

How can we ensure that we are as good parenting online, as we are offline? Use these five tips to educate, empower and protect yourself, as well as your children, to have safer and more meaningful online experiences.

**Use technology together** This is a good way to teach online safety, and it creates the opportunity for you to address safety issues as they arise. Be involved in your child's online life. Discuss also the importance of unplugging from their mobile device, and establish phone-free times such as during class, at family dinners or after a certain time on school nights.

**Use privacy settings/ parental control on devices** There are many sites for sharing ideas, photos, videos and more. Many of these service providers offer privacy settings and controls that will determine who can see your content before you post it. Talk with your family about what they



should and should not share publicly. Teach your family to communicate responsibly: one good thumb rule is, if you would not say it in person, then do not text it, email it, instant message it, or post it as a comment on someone's page. Discuss how what you say online might make other people feel, and come up with guidelines about what is appropriate communication. Help them respect the privacy of others by keeping the personal details about family or friends private, and by not identifying people by name in publicly shared social media. This

should include personal information such as phone numbers or home addresses. Teach your family not to accept files or to open email attachments from strangers. Write down the rules and keep them near the computer. **Check age restrictions** Many online services have age limits restricting who can use their services. For example, for an email account, you would have to meet age requirements; some email products are restricted to users who are 18 years and older. Always check a **website's terms of usage** before allowing your child/ward to sign up for an account, and be clear with them if you have rules on which websites and services they can use. Supervise computer use If possible, the family computer should be kept in a common area of the house. You should also set reasonable limits on computer

usage. Show your children the value of privacy: encourage them to protect their passwords and personal information, as they would with something like a diary. Children under eight should have direct supervision while online. Tweens, those from eight to 12, should have more freedom, but a parent/guardian should still be close by, with privacy settings at their highest level. Teens, due to smart phones, laptops and school computers will have more Internet access, which is why it is important to set the rules early and encourage ongoing conversations.

**Keep the conversation going** Staying safe is not a one-off event; technology evolves, and so will the needs of your family. Make sure you keep up an ongoing dialogue. Check in on everyone's progress, change the rules if necessary, and set aside time to chat at regular intervals, for example, at family dinners. Encourage their questions. Invite conversation.
