## Patna has become crime capital, says Rahul after tycoon killing

**The incident, which was caught on CCTV, has stirred a political row just months ahead of the state assembly elections, with Rahul Gandhi claiming that Bihar needs to be saved from the NDA government.**

Leader of the Opposition in Lok Sabha, Rahul Gandhi, on Sunday tore into the Nitish Kumar government over the murder of Patna businessman Gopal Khemka, claiming that the ruling NDA coalition has "turned Bihar into the crime capital of India." "Today, Bihar lives under the shadow of loot, gunfire, and murder. Crime has become the new normal, and the government has completely failed," he tweeted. The Congress MP further appealed to the people of Bihar, urging them not to vote for a government "that cannot protect your children" in the upcoming Assembly elections.  
"Every murder, every robbery, every bullet is a cry for change. The time has come for a new Bihar — one of progress, not fear. This time, your vote isn't just to change the government — it's to save Bihar," he further wrote on his

chief Tejashwi Yadav claimed that the police took two hours to reach the crime scene. "It's a horrible incident. The businessmen want to leave Bihar. The incident occurred in the heart of Patna... Still, it takes the police two hours to arrive here," he told news agency ANI. "Six years ago, his (Gopal Khemka's) son was murdered, and none of the murderers were caught... By the time transfers and postings are done through bribery and performers are not posted, things will not improve. No one is safe in Bihar... The CM is unconscious and he is tired, officers are running the government," he added.  
Soon after the incident came to light, Bihar Independent MP Pappu Yadav reached the location and questioned how such an incident could occur in an area where all key officials, including the District Magistrate, reside. He further asked whether the Bihar government wanted to see all members of the Khemka family dead.

## Temporary truce or end of internal bickering in Congress?

**As things appear now, it is not an easy task for the high command to decide on the leadership issue in Karnataka, due to several factors.**

After high-decibel internal bickering caused embarrassment to the party and threatened to undo the gains made by the Siddaramaiah government, an uneasy silence prevails in the ruling Congress camp. Many wonder if the party's top brass has managed to broker peace, or whether it is a lull before the storm, and the tussle for power will continue as the government approaches its mid-way mark in November this year.  
No one — except the party high command, Chief Minister Siddaramaiah, and Deputy Chief Minister DK Shivakumar — knows about a power-sharing agreement, if any, reached before the formation of the government in 2023. A lack of clarity on the much-talked-about agreement, discontent among a section of legislators over funds for development works, and the aspirations of many senior legislators to become ministers seem to be among the major reasons for the crisis that manifests episodically, pushing the top leadership into a firefighting mode. While the exercise to gauge the mood among the party legislators, assess their contribution to implementing the government's flagship guarantee schemes, and provide a platform to express their aspirations is underway, Shivakumar took the initiative to cool down the political temperatures. His remark — "What option do I have? I have to stand by him (Siddaramaiah) and support him. I do not have any objection to it" — yet again made it clear that he is not someone who will rock the boat for selfish political gains, but rather wait for his turn. Having weathered the storm at the worst of the crisis when he was arrested by the Enforcement Directorate (ED), he perhaps thinks that the worst is behind him.

## Congress invokes Manmohan Singh's legacy as PM Modi set to join Brics summit

With Prime Minister Narendra Modi in Brazil to attend the BRICS Summit, the Congress on Sunday recalled the events leading up to the formation of the grouping as also the Summit hosted by India in 2012 during which then PM Manmohan Singh had proposed the establishment of a BRICS Development Bank.  
Congress general secretary in-charge communications Jairam Ramesh said, "After dropping by in Ghana, Trinidad & Tobago, and Argentina, the Super Premium Frequent Flier Prime Minister has reached Brazil. The Seventeenth BRICS Summit begins today in Rio de Janeiro." It was in 1998 that the Arabic-speaking, Asia-leaning, Russian Prime Minister Yevgeny Primakov floated the idea of a trilateral forum called RIC -- Russia, India and China, he



recalled.  
This was done to promote multipolarity in global affairs when the US was triumphant, Ramesh said in his post

on X. "Then in November 2001, Jim O'Neill and his research team at Goldman Sachs in New York came out with a report titled Building Better Global Economic BRICs—Brazil, Russia, India and China that were identified as the four powerhouse economies for the future," he said. The report still makes for very interesting reading, Ramesh added. Thereafter at the G8 Summit (Russia was then a member of G7 and was to be excluded post-2014) outreach in St. Petersburg in July 2006, the Presidents of Russia, China, and Brazil, and the Prime Minister of India met and gave their nod to the formation of BRIC, he said.

"The very first summit of the BRIC countries - Brazil, Russia, India and China - was held in June 2009 in Russia.

## Sandeshkhali violence: CBI takes over probe, FIR filed against Ex-TMC leader Shahjahan Sheikh

The Central Bureau of Investigation (CBI) has officially taken over the probe into the 2019 killings of three BJP workers, Pradeep Mondal, Devdas Mondal, and Sukanta Mondal during post-poll violence in Sandeshkhali, West Bengal. The agency has filed a First Information Report (FIR) naming former Trinamool Congress (TMC) leader Shahjahan Sheikh as the prime accused. The move follows a directive issued by the Calcutta High Court on June 30. Justice Joy Sengupta ordered the formation of a Special Investigation Team (SIT) within the CBI to handle the case with the "utmost seriousness." The court also instructed that the investigation be supervised by a CBI joint director. The three BJP workers were found dead after an alleged mob attack on their village in Sandeshkhali, reportedly led by Sheikh. The case was initially investigated by the West Bengal Police's Criminal Investigation Department (CID), but the families of the victims later moved the Calcutta High Court, expressing dissatisfaction with the state probe and requesting a CBI investigation. In his ruling, Justice Sengupta slammed the state police, saying they had repeatedly failed to act against



Sheikh, both in this case and in previous incidents.  
"The police failed to take action against the prime accused at different stages, leading to gross miscarriage of justice," the court noted. The judge further stated that the issue extended beyond local police to the CID, observing a pattern of inaction whenever allegations were made against Sheikh. Shahjahan Sheikh, a controversial

One dead, five injured after wedding DJ touches high-voltage wire in Odisha

One person was killed and five others injured when a DJ sound system accompanying a wedding procession came into contact with a high-voltage overhead wire in Denkanal district of Odisha. The incident occurred on Wednesday, when the wedding procession was moving along the village road and the sound system suddenly came into contact with the overhead wire.  
Within a few seconds, all the six people were seen falling on the ground after being electrocuted. According to eyewitnesses, the sudden electric discharge triggered panic and chaos in the crowd.  
All of them were rushed to a local community health centre from where they were transferred to Dhenkanal District Hospital for advanced medical care.  
One of the victims, identified as Mantu Palai, was declared dead on arrival by doctors at the district hospital. A post-mortem examination of the body was conducted and police have initiated an investigation into the incident.

## Delhi Plans Solar Panel Cover Over Munak Canal to Curb Water Loss

In a bold and forward-looking step towards sustainable water management and renewable energy generation, the Delhi government is exploring a plan to cover the Munak Canal with solar panels. This ambitious initiative—currently under planning and feasibility assessment—aims to curb massive water losses, generate clean electricity, and enhance safety and cleanliness along the canal.  
Parvesh Sahib Singh inspected the Munak Canal last week and reviewed conditions on-site along with senior officials. Based on the findings, a comprehensive plan is being developed to install solar panels across the Delhi stretch of the Munak Canal by constructing four-foot-high walls on both sides, over which the panels will be mounted.  
"The Munak Canal is a lifeline for Delhi's water supply. But in its current form, it is also a major source of loss, pollution, and risk. Our plan to cover it with solar panels will help us save water, produce clean power, and make the

canal safer and more secure for the people of Delhi," said Parvesh.

The inspection revealed alarming levels of water loss in the canal. Two of its main sections—the Delhi Sub-Branch (DSB) and the Carrier Lined Channel (CLC)—are suffering from significant leakage and inefficiency. Beyond water loss, the



Munak Canal also faces persistent issues of garbage dumping and accidental drownings. Open and unguarded stretches of the canal pose a danger to both residents and passersby.

## Maharashtra: Incomplete bridge on Gundenur river in Gadchiroli poses risk to tribals every monsoon

AMID HEAVY rains in the remote Bhamragad area of Maharashtra's Gadchiroli district, an incomplete bridge on Gundenur river on National Highway 352 has emerged as a major cause of concern for tribals in the area.

Datta Shirke, president of Jana Sangharsha Samiti said that incomplete bridge on NH-352 (Laheri to Narayanpur) is proving to be a "death trap for tribals." According to Shirke, the unfinished bridge poses significant challenges for residents, especially pregnant women and sick individuals in accessing healthcare, especially during monsoon. Gundenur river flows near Laheri village in Bhamragad taluk on the highway connecting Maharashtra to Chhattisgarh. The construction of this bridge began a few years ago. In 2018, an 84km patch of road was mentioned in a report titled, 'State-wise length of National Highways (NH) in India.'

The administration is aware of the issue. When contacted Gadchiroli collector Avishyanta

Panda, he said, "After the situation came to light, a boat was arranged for the citizens to cross the river. The situation is serious at one specific period of the day when the water level is very high."

activities in the area. Police presence was required to construct the bridge," said the district collector.

Highlighting the other issues which caused delay in the work, Panda said, "Due to remote

location, supply of labour, materials and machine was difficult and disrupted, which also led to slight delay in construction of the bridge. All the measures for mitigation and help are in place. Boats have been supplied and nobody is allowed to cross the river without supervision. The district administration is continuously monitoring the situation and has visited the place multiple times."

Panda said that the list of all pregnant women is there with health staff so that they can be placed in 'Maher Ghar' attached to PHCs prior to delivery. Also, medicines and ration for three months have

been provided beforehand to all these villages.

Bhamragad tehsildar Kishore Bagde also appealed to residents to avoid crossing the flooded river and use the government-provided boat for their safety.



"The work on the National Highway bridge was scheduled to be completed by March next year. Works are on track and will be completed within the stipulated timeline. The delays were owing to security issues because of the Naxal

## AAP MLA Vasava arrested after "scuffle" with BJP leader during meeting at taluka panchayat office

An alleged scuffle between BJP leader Sanjay Vasava and Aam Aadmi Party (AAP) MLA Chaitar Vasava during a meeting at the taluka panchayat office ended up in the arrest of the legislator, in Gujarat's Narmada district, on Saturday.

Talking to The Indian Express, Narmada district Superintendent of police Prashant Sumbe said, "There was a clash between Chaitar Vasava and BJP leader and Dediapada taluka panchayat president Sanjay Vasava. Dediapada SDM (sub-divisional magistrate) S D Sangada has submitted his report to us. Sanjay Vasava has lodged a complaint against Chaitar Vasava. We arrested him on Saturday evening, after he was detained from Dediapada taluka."

Sanjay Vasava claimed that Chaitar Vasava used "inappropriate" language against a woman panchayat president.

The row began when Chaitar Vasava, the AAP MLA from Dediapada seat, reached the taluka panchayat office to attend a coordination committee meeting. The meeting was being attended by taluka development officers from Dediapada and Sagbara talukas, mamlatdars, and deputy executive engineers from both talukas. Besides, six other people, three each from the two talukas, were present at the meeting. Chaitar Vasava's supporters said he inquired about the six people and discovered that they had been newly inducted in a committee for ATVT (Apno Taluko Vibrant Taluko), concerning development works in talukas and villages.

Vasava objected to this, stating that his consent had not been sought as the elected MLA from Dediapada, the supporters said. Chaitar Vasava reportedly demanded that the committee be dissolved and a new one formed, sources said. He also objected to a businessman being included in the committee, citing that he is not an elected member of the taluka panchayat, according to sources present at the meeting. Sources said that the committee was formed under the direction of Sanjay Vasava. Following Chaitar Vasava's objections, a heated exchange allegedly took place between him and Sanjay Vasava during which both leaders pushed each other, said sources. During the scuffle, Chaitar Vasava's clothes also got torn, the MLA's supporters claimed.

## Ludhiana Passport Seva Kendra to relocate to bigger facility after long-standing public demand

A long-pending demand of residents in Ludhiana is set to be fulfilled with the relocation of the city's Passport Seva Kendra (PSK) to a new site, Punjab Cabinet Minister Sanjeev Arora announced.

The PSK, which currently operates from Akashdeep Complex in Gyan Singh Rarewala Market, will begin operations at its new location at Global Business Park on GT Road near the Jalandhar Bypass in Village Bhora starting July 7.

Arora, who serves as Punjab's Minister for Industry & Commerce, Investment Promotion, and NRI Affairs and previously held a Rajya Sabha seat, had written several letters to

the Ministry of External Affairs, beginning February 3, 2023, urging the relocation of the PSK due to inadequate infrastructure at the current premises.

In a response dated February 28, 2023, the External Affairs Ministry confirmed that the process of shifting the PSK was underway. Arora followed up with additional letters on March 17, October 29, and December 20 of the same year, as well as a final reminder on February 5, 2025.

In his letters, Arora cited a range of issues at the existing site, including the deteriorating condition of the building, a lack of parking, and insufficient waiting areas for citizens. These shortcomings, he argued, were hampering the delivery of public

services and causing avoidable inconvenience.

"I am deeply satisfied that my consistent efforts over the past two years have finally yielded results," Arora said. "The earlier location was completely inadequate — it lacked basic infrastructure, parking space, and even a dignified waiting area for citizens."

He said head repeatedly appealed to the Ministry of External Affairs because "the people of Ludhiana deserve better." He added that the new facility is expected to be "far more accessible and citizen-friendly" and will "significantly improve the overall passport service experience."

## Shimla landslide: Yet another complaint against NHAI, this time by Himachal forest dept

The Himachal Pradesh forest department Saturday filed a police complaint against the National Highway Authority of India (NHAI), accusing it of negligence leading to a massive landslide on the Kaithlighat-Dhalli road stretch in the suburbs of Shimla city on June 30.

This is the fourth complaint filed against the road authority in Shimla in the last one week.

A five-storey building collapsed in the landslide on Monday. Nearly 8,550 square metres of protected land was damaged and trees were uprooted, causing an estimated Rs 2.14 crore loss along the under-construction four-lane Dhalli road.

The complaint, filed by forest officer Ajeet Kumar, followed an inquiry conducted by the forest department, which pinned the negligent and faulty execution of road-cutting work by the NHAI as the main cause of the landslide. The complaint said the calamity could have been avoided if the four-lane road construction was executed after



taking due precautions and safety measures.

A case has been registered under Sections 32 and 33 of the Indian Forest Act for offences related

to protected areas and Section 324 (5) of Bharatiya Nyaya Sanhita for mischief causing damage to property, police said.

Earlier, owner of the collapsed building, Ranjana Verma, had registered a case against the NHAI and the company involved in the four-lane road project for endangering life and causing damage to property.

Two more cases were filed by local residents against NHAI officials for wrongful restraint, endangering life or personal safety of others, intentional hurt and criminal liability — one each by a group of locals and a gram panchayat member. Notably, all four cases have been registered after Panchayati Raj Minister Anirudh Singh, who is also the local MLA from Kasumpti where the collapse took place, was booked based on a complaint from NHAI employees. In the complaint, NHAI employee Achal Jindal had alleged that Singh, who had been on a visit to inspect the building collapse site, summoned him and his site engineer Yogesh Verma and assaulted them.

Singh had denied the allegations, saying that "the FIR does not mean that I am guilty."

## Government sets up grain market in Gurugram to purchase crops grown through natural farming

Chandigarh: Haryana Agriculture and Farmers' Welfare Minister, Sh. Shyam Singh Rana, said that to facilitate the purchase of crops grown using natural farming methods, the state government has established a grain market in Gurugram. A laboratory has also been set up in the market to test the quality of the produce. Once the quality is assessed, a committee will determine the price and purchase the crop accordingly. The Agriculture Minister was addressing the gathering as the chief guest at the 7th Fruit Festival Mela organized at the Subtropical Fruit Centre in Ladwa on Sunday. He formally inaugurated the event by lighting the ceremonial lamp and planted a mango sapling in the centre's premises. He also felicitated 10 progressive farmers from the horticulture sector with Rs. 5100 each, a trophy, and a certificate of appreciation. The Minister also inspected various stalls at the Mela and gathered information from experts on different mango varieties. Sh. Shyam Singh Rana said that the state government's goal is to cultivate crops through natural farming on one lakh acres of land in Haryana. Currently, natural farming is being practiced on 10,000 acres, and this number is steadily increasing. He informed that the Subtropical Fruit Centre in Ladwa was established in

2016 under Indo-Israeli technology. Starting with 10,000 saplings, the centre now prepares one lakh saplings annually for distribution to farmers. Research is being carried out on six crops including mango, litchi, pear, peach, and Chikoo. Scientists at the centre are also developing a mango tree whose fruit could fetch around Rs. 1 lakh per kilogram in the market. The Minister further said that to increase farmers' income and encourage a shift from traditional farming, 17 such centres will be established in the state, 11 of which have already been completed. Sub-centres for litchi in Ambala and for strawberries in Yamunanagar will be set up soon. He emphasised the need for farmers to diversify beyond wheat and paddy cultivation into horticulture, fisheries, beekeeping, dairy farming, and other sectors. He said that the state government continuously formulates new schemes for the benefit of farmers. If any issues arise during implementation, the schemes are revised accordingly to ensure farmers benefit. He called farmers a crucial pillar of the nation and encouraged them to adopt modern and diversified farming practices. Under the Bhavantar Bharpai Yojana, if farmers get a price below the MSP in the market, the government compensates the difference to protect them from losses.

## PWD to repair three major flyovers in South Delhi

New Delhi: The Public Works Department (PWD) plans to carry out structural repairs on three major flyovers and a culvert in South Delhi and initiate the construction of three new bridges near New Ashok Nagar in the eastern fringes of the city. According to PWD officials, the IIT flyover, built in 1994, the Old Rao Tula Ram flyover and the Modi Mill flyover have been selected for comprehensive repair work. A structural audit of these flyovers, along with a culvert near Lala Lajpat Rai Marg, will be conducted in the coming days. In East Delhi, the PWD is set to construct three small bridges near the recently inaugurated RRTS metro station in New Ashok Nagar. Located near the Delhi-Uttar Pradesh border and adjacent to the Shahdara drain, the area has seen increasing traffic congestion, officials said. For the construction of three small bridges near the New Ashok Nagar metro station, the PWD will hire an agency to carry out a feasibility study and a ground survey of the location. The total cost of the consultancy projects is around '72 lakh. "The consultancy service includes carrying out a tree count survey on the central verge, roadshows and complete right-of-way of the whole stretch for the road widening work of East End apartment road," an official said. The Outer Ring Road stretch starting from the Modi Mill flyover to the IIT flyover is linked to several South Delhi areas like Greater Kailash 1 and 2, Chitranjan Park, Chirag Dilli, Pamposh Enclave and other areas. The flyover repair work would include recarpeting, patchwork, pothole repairs and restoration of roads cut by other agencies. The road repair work is carried out by the PWD from mid-March to mid-June and then it stops because of the monsoon season. In Delhi, PWD maintains 1,400 kilometres of road length, which are 60 feet wide. In April this year, PWD Minister Parvesh Verma announced that the Delhi Government plans to repair 600 kilometres of road in this financial year.

## Police arrest fake doctor wanted for 10 years in two cheating cases

New Delhi: Delhi Police have arrested a man who had been living as a fake doctor in Haridwar for more than 10 years while being wanted in two cases of cheating and forgery in Delhi. The accused, Raj Kumar Sharma, 52, was caught by the Anti Robbery and Snatching Cell (ARSC) of the Crime Branch in a late-night operation Friday. Sharma had been absconding since 2007 and was declared a proclaimed offender by the courts in both cases. In Haridwar, he had changed his identity and was living as a doctor, claiming to be associated with AIIMS Rishikesh. Locals knew him and had no idea about his criminal background. The police team that arrested him was led by Inspectors Mangesh Tyagi and Robin Tyagi and supervised by ACP Arvind Kumar. The team tracked him using technical surveillance and human intelligence. After confirming his location, they arrested him from his house in Haridwar and brought him to Delhi. According to police, Sharma was first booked in 2007 in a case registered at PS Roop Nagar (now under NR-1, Crime Branch) for cheating government banks. He and five others took vehicle loans using fake documents. A car was also recovered from him, which he had fraudulently financed. During the trial, he stopped appearing in court and was declared a proclaimed offender in 2016.

To give you back your freedom': Elon Musk officially launches America Party

**WASHINGTON. (Agency)**  
Elon Musk, an ex-ally of US President Donald Trump, said Saturday he had launched a new political party in the United States to challenge what the tech billionaire described as the country's "one-party system."The world's richest person, and Trump's biggest political donor in the 2024 election had a bitter falling out with the president after leading the Republican's effort to slash spending and cut federal jobs as head of the so-called Department of Government Efficiency (DOGE).  
Musk has clashed with Trump over the president's massive domestic spending plan, saying it would explode the US debt, and vowed to do everything in his power to defeat lawmakers who voted for it.  
Now he has created the so-called America Party, his own political framework, through which to try and achieve that."When it comes to bankrupting our country with waste & graft, we live in a one-party system, not a democracy," the Space X and Tesla boss posted on X, the social media platform that he owns."Today, the America Party is formed to give you back your freedom."Musk cited a poll -- uploaded on Friday, US Independence Day -- in which he asked whether respondents "want independence from the two-party (some would say uniparty) system" that has dominated US politics for some two centuries.The yes-or-no survey earned more than 1.2 million responses.  
"By a factor of 2 to 1, you want a new political party and you shall have it!" he posted on Saturday.  
Musk also shared a meme depicting a two-headed snake and the caption "End the Uniparty."

F-16 Intercepts Plane Over Trump’s Bedminster Golf Club For Airspace Violation

**World. (Agency)**  
In a fresh airspace breach, a U.S. Air Force F-16 fighter jet on Saturday intercepted a civilian aircraft that entered temporarily restricted airspace over former President Donald Trump’s golf club in Bedminster, New Jersey, according to a statement by the North American Aerospace Defense Command (NORAD).  
According to a Hindustan Times report, the incident occurred while Trump was spending the holiday weekend at his Bedminster property. The fighter jet, scrambled under NORAD’s directives, carried out an intercept after the civilian plane violated the Temporary Flight Restriction (TFR) zone in place around the former president’s location.According to NORAD officials, the F-16 executed a ‘headbutt’ maneuver, a standard military tactic where a jet flies in front of an unresponsive aircraft to gain the pilot's attention. The civilian aircraft was then safely escorted out of the restricted area.This marks the fifth such violation of the TFR zone reported on Saturday alone, highlighting ongoing concerns over civilian awareness of temporary flight restrictions in high-security areas.“This is part of a concerning pattern,” NORAD said, urging all civilian pilots to thoroughly check NOTAMs (Notices to Airmen) before departure. The command emphasized the importance of TFR compliance for national security and the safety of flight operations.Previous Incidents at Trump Residences  
Saturday’s incursion echoes a similar episode earlier this year in March, when a civilian aircraft strayed into restricted airspace over Trump’s Florida residence near Mar-a-Lago shortly after he completed a round of golf in West Palm Beach. In that incident, F-16s deployed flares to alert the pilot and redirect the aircraft.

US officials accuse Hamas of attacking two aid workers in Gaza

**World. (Agency)**  
The United States on Saturday blamed Hamas for an attack that injured two American aid workers from the Gaza Humanitarian Foundation at a food distribution site in Gaza.The US and Israeli-backed GHF said in a statement that the injured Americans were receiving medical treatment and were in a stable condition with non-life-threatening injuries.  
"The attack which preliminary information indicates was carried out by two assailants who threw two grenades at the Americans occurred at the conclusion of an otherwise successful distribution in which thousands of Gazans safely received food," the GHF said.US State Department spokesperson Tammy Bruce blamed "Hamas terrorists" for the attack.  
"This act of violence against the people actually bringing relief to Gazans lays bare the depravity of Hamas," she said in a post on X.  
"GHF has contributed over 62 MILLION MEALS - nothing will stop these courageous aid workers. We are praying for the rapid recovery of the injured Americans."The Israeli military earlier accused what it called "terrorist organisations" of sabotaging the distribution of aid in Gaza.GHF, which began distributingaid in Gaza in May, employs private US military contractors to provide security at their sites.Gaza has seen an escalation in violence as efforts continue to reach a ceasefire agreement. Hamas on Friday said it had responded positively to a US-brokered deal and was prepared to enter talks. US President Donald Trump is scheduled to meet Israeli Prime Minister Benjamin Netanyahu on Monday.

**KILLINGS NEAR AID DISTRIBUTION SITES**  
Gazan authorities reported at least 70 people have been killed in the territory by the Israeli military in the last 24 hours, including 23 near aid distribution sites. The ministry did not specify where or how exactly they had been killed. The Israeli military had no immediate comment on the reports.  
In a statement on Friday, the military said troops had killed 100 militants in Gaza in the past week, and that it had "operational control" over 65% of Gaza after an offensive against Hamas fighters in the north.

'I'm a Simple Buddhist monk': Dalai Lama marks landmark 90th birthday

**The US president said he and Putin talked about sanctions "a lot," adding, "He understands that it may be coming."**

**TIBET. (Agency)**  
Calling himself a "simple Buddhist monk" who usually didn't celebrate birthdays, the Dalai Lama marked his 90th on Sunday by praying for peace after China insisted it would have final say on who succeeded the Tibetan spiritual leader.Chanting of red-robed monks and nuns rang out from Himalayan hilltop forested temples in India, home to the Dalai Lama since he and thousands of other Tibetans fled Chinese troops who crushed an uprising in their capital Lhasa in 1959."I am just a simple Buddhist monk; I don't normally engage in birthday celebrations," the Dalai Lama said in a message, thanking those marking it with him for using the opportunity "to

cultivate peace of mind and compassion".Dressed in traditional robes and a flowing yellow wrap, walking with the aid of two monks while flashing his trademark beaming smile to thousands of followers, he watched dramatic dance troupes with clanging cymbals and bagpipes before the start of prayers.Beijing condemns the Nobel Peace Prize winner -- who has led a lifelong campaign for greater autonomy for Tibet, a vast high-altitude plateau -- as a rebel and separatist.Alongside the celebrations, however, is the worry for Tibetans in exile that China will name its successor to bolster control over the territory it poured troops into in 1950 and has ruled ever since.That raises the likelihood of rival challengers to the post; one by self-declared atheist Beijing, the other by the Dalai Lama's office based in neighbouring India, a regional rival of China.Good heartThe celebrations on Sunday are the culmination of days of long-life prayers for Tenzin Gyatso, who followers believe is the 14th reincarnation



of the Dalai Lama, a man whose moral teachings and idiosyncratic humour have made him one of the world's most popular religious leaders."While it is important to work for material development, it is vital to focus on achieving peace of mind through cultivating a good heart and by being compassionate, not just toward near and dear ones, but toward everyone," he said in his birthday message."Through this, you will contribute to making the world a better place."The celebrations also included his key announcement that, after being inundated with messages of support from fellow Tibetans both inside and in exile, the spiritual institution will continue after his

death.He said he had received appeals from followers from across the Himalayan region, Mongolia and parts of Russia and China.The seemingly esoteric matters of reincarnation have real-world political consequences, with Tibetans fearing his death will mark a major setback in his push for more autonomy for the Himalayan region.The Dalai Lama said his India-based office alone would "exclusively" identify that successor -- prompting a swift and sharp reply from China that the reincarnation "must be approved by the central government" in Beijing.China said the succession would be carried out "by drawing lots from a golden urn", foreign ministry spokeswoman Mao Ning told reporters on Wednesday.That urn is held by Beijing, and the Dalai Lama has warned that, when used dishonestly, it lacks "any spiritual quality".Indian Prime Minister Narendra Modi offered effusive birthday greetings on Sunday, calling the Dalai Lama an "enduring symbol of love, compassion, patience and moral discipline."

Japan PM says won't 'easily compromise' to Trump on tariffs

**TOKYO. (Agency)**  
Japan's Prime Minister Shigeru Ishiba said Sunday he won't "easily compromise" in talks with Washington as Tokyo seeks to avert President Donald Trump's threat to impose tariffs of up to 35 percent on Japanese goods."We will not easily compromise. That's why it is taking time and why it is tough," Ishiba told a television talk show.His comments came as Japan rushes to negotiate with the Trump administration before the Wednesday deadline for trade deals.While Trump imposed a sweeping 10 percent tariff on imports from most trading partners in April, he unveiled -- then paused -- higher rates on dozens of economies including Japan to allow room for negotiations.This pause will expire July 9, meaning the elevated rates are

due to kick in if countries fail to reach agreements with Washington to avert them.Trump has said he was going to write a letter to Japan, asking it to "pay



a 30 percent, 35 percent or whatever the number is that we determine," and called the bilateral trade relation "unfair".He has particularly pressed Japan to accept more US automobiles

and rice.Ryosei Akazawa, Tokyo's trade envoy, held telephone calls with US Commerce Secretary Howard Lutnick on Thursday and Saturday.  
In the Sunday television show, Ishiba reiterated that Japan, as the biggest investor nation in the US economy, should be treated differently from other countries."What is unfair? How is it unfair? We need to examine each one" of the US claims, he said."We are allies, but we have to say what we have to say. We are the world's largest investor nation and the largest job creator (in the US). We are different," he said.On another Sunday television show, Ishiba said Japan was "preparing to deal with all kinds of situations", when asked about how he plans to deal with Trump's letter.

Thousands show support for trans people at Pride in LondonLondon

**LONDON. (Agency)**  
Amid a sea of rainbow flags and sequined costumes, hundreds of thousands joined Pride in London on Saturday, showing their support for transgender people in the wake of a recent UK court ruling.They included Chase, 23, who cheered as dancers on floats paraded through Piccadilly Circus.As a transgender man, Chase came to let the government know that the community was "still here", even if it is "at the bottom of the barrel" at the moment.Like thousands of others in the United Kingdom, Chase will no longer be allowed to use certain single-sex spaces -- men's toilets and changing rooms in this case -- following the publication of new guidelines by the UK's equality regulator (EHRC) at the end of April.  
The guidelines were issued days after the Supreme Court ruled that the legal definition of a woman is based on biological sex, impacting transgender people's access to hospitals and sports clubs.The new rules "invalidate us completely", said Chase, face covered in glitter and bedecked in a transgender flag, adding that the guidelines were

"just the beginning" of a tougher approach against their community.This edition of Pride in London should therefore serve to "show solidarity with



the trans community", said Jake Hills, the event's communications head.  
The transgender community has been "scapegoated for so many problems in this country", lamented Dominic, a 26-year-old linguist who came from Reading, west London to attend the gathering."A lot of people are going out their way to show support for the trans community. And I think we should," he added.Like last year, organisers expected nearly 1.5 million people to attend the event.  
**Rising intolerance**

Political parties of all stripes have been banned from this year's Pride parades in London, Birmingham, Brighton and Manchester, due to their "refusal to platform those who have not protected our rights".Shortly after the Supreme Court's ruling, Labour Prime Minister Keir Starmer refused to repeat statements made in 2022, when he said that "transgender women are women"."We are very disappointed with the backsliding on LGBTQ+ rights that's currently taking place in the UK. We think there is a rising tide of intolerance, diminishing government support in the UK for our trans siblings," said Hills.Many in the parade were draped in the white, blue, and pastel pink transgender flag, chanting: "What do we want? Trans rights! When do we want it? Now!"They hope that the EHRC will amend its guidelines before passing them on to the government.Concerns about the rights of LGBT+ people have grown in several countries in recent months, notably in the United States and Hungary, where 200,000 people marched last weekend despite a ban by Prime Minister Viktor Orban.

Texas floods leave at least 51 dead, 27 girls missing as rescuers search devastated landscape

**KERR COUNTY. (Agency)**  
:Rescuers scoured a devastated central Texas landscape of mangled trees, overturned cars and muck-filled debris Saturday in an increasingly bleak mission to locate survivors, including 27 girls who have not been seen since their camp was slammed with a wall of water in a historic flash flood.  
The flooding in Kerr County killed at least 43 people, including 15 children, and at least eight people died in nearby counties.  
Authorities still have not said how many people were missing beyond the children from Camp Mystic, a Christian summer camp along a river in Kerr County where most of the dead were recovered.The destructive, fast-moving waters rose 26 feet (8 meters) on the Guadalupe River in just 45 minutes before daybreak Friday, washing away homes and vehicles. The danger was not over as rains continued pounding communities outside San Antonio on Saturday and flash flood warnings and watches remained in effect.

Searchers used helicopters, boats and drones to look for victims and to rescue people stranded in trees and from camps isolated by washed-out roads.Gov. Greg Abbott vowed that authorities will work around the clock and said new areas were being searched as the water receded. He declared Sunday a day of prayer for the state.  
"I urge every Texan to join me in prayer this Sunday — for the lives lost, for those still missing, for the recovery of our communities, and for the safety of those on the front lines," he said in a statement.  
Authorities were coming under scrutiny over whether the camps and residents in places long vulnerable to flooding received proper warning and whether enough preparations were made.The hills along the Guadalupe River in central Texas are dotted with century-old youth camps and campgrounds where generations of families have come to swim and enjoy the outdoors. The area is especially popular around the July Fourth holiday, making it

more difficult to know how many are missing.“We don’t even want to begin to estimate at this time,” Kerrville City Manager Dalton Rice said earlier.Raging

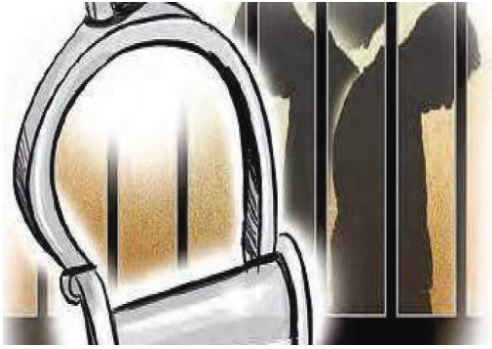


storm hit camp in middle of the night“The camp was completely destroyed,” said Elinor Lester, 13, one of hundreds of campers. “A helicopter landed and started taking people away. It was really scary.”The raging storm, fueled by incredible amounts of moisture, woke up her cabin just after midnight Friday. When

rescuers arrived, they tied a rope for the girls to hold as they walked across a bridge with water whipping around their legs, she said.Frantic parents and families posted photos of missing loved ones and pleas for information.Among those confirmed dead were an 8-year-old girl from Mountain Brook, Alabama, who was at Camp Mystic, and the director of another camp just up the road.The flooding in the middle of the night caught many residents, campers and officials by surprise.AccuWeather said the private forecasting company and the National Weather Service sent warnings about potential flash flooding hours beforehand.  
“These warnings should have provided officials with ample time to evacuate camps such as Camp Mystic and get people to safety,”AccuWeather said in a statement. It called the Hill Country one of the most flash-flood-prone areas of the U.S. because of its terrain and many water crossings.



## Bowring Hospital senior surgeon's son kidnapped, attacked

In another instance of senseless road rage in the city, a 19-year-old engineering student, the son of a senior surgeon at the Bowring and Lady Curzon Hospital, was kidnapped and assaulted by a group of men on Wednesday night.

The victim had to undergo a surgery to his head after he was tortured for more than one-and-a-half hour. Shockingly, one of the key accused is a 16-year-old. His father and another person involved in the assault were arrested and a notice has been served on the juvenile.

The incident happened near the Florence School Ground in Basaveshwaranagar police station limits between 8.30 pm and 10 pm. When the victim was riding his electric scooter near the school grounds, the juvenile, suddenly came in front. This led to a verbal altercation between them.

The victim identified as Akhilesh (name changed) is a resident of Basaveshwaranagar 3rd stage. After he was attacked and thrown out of the auto, the victim called his friends seeking help. He was rushed to Shanbhag Hospital in Basaveshwaranagar 3rd stage. The police who visited the hospital recorded the victim's statements and registered an FIR on Thursday.

The victim in his complaint has stated that the accused attacked him with a steel bangle and other weapons. The assailants who threw punches on his face also kicked him repeatedly. ## Folk singer Swarna revives ancient martial arts in Hyderabad

**HYDERABAD. (Agency)**

In a quiet morning in Hyderabad, the rhythmic clack of bamboo sticks echoes across a training ground. Under the open sky, children, some barely in their teens, practise Karam Sammu and Kathi Sammu, ancient rural martial arts from Andhra Pradesh, once on the verge of extinction. Leading this quiet revival is Swarna, a folk singer-turned-martial artist whose journey from melody to martial mastery is both unlikely and transformative.

Swarna doesn't fit the typical image of a martial arts instructor. Dressed in a simple kurta, staff in hand, she commands respect not through force, but presence. Her poise reflects years of discipline and quiet dedication to an art form few in Telangana had even heard of.

The spark was lit while she was pursuing a Master's in Performing Arts at Suravaram Pratap Reddy Telugu University. "Martial arts were part of our curriculum," she tells TNIE. "I didn't expect to connect with them so deeply." But learning traditional rural forms was not easy. With few trainers in Telangana, Swarna travelled across Tamil Nadu, where martial arts like Silambam receive active government support.



"There were hardly any instructors teaching all levels in one place," she says. "I went from Anna Nagar in Chennai to the interior parts of Salem to find the right teachers." The journey was arduous, but it shaped her mission. In 2022, she founded Swarna Arts Academy, a registered institution dedicated to reviving and teaching rural martial arts. Since then, thousands of children have joined, learning not only the techniques but also the values of courage, confidence and discipline.

"We're preserving a forgotten art," Swarna says. "But we're also giving children, especially girls, a tool for self-defence. This is about strength, of body and spirit."

**Not your regular influencer**  
Long before she picked up a staff, Swarna had found her voice through folk music. Born into an agricultural family in Nagarkurnool, she began singing at a young age. Her YouTube channel, Swarna Swaras, brought folk songs to a wider audience. One of her renditions, Diva Diva, went viral with 4.8 crore views. She reportedly became the first woman pursuing Telugu folk music to receive a CCRT fellowship from the Union government.

# State a leader in cow protection, livestock development: UP govt

**On January 2, 2019, UP became the first state in the country to launch a policy for the protection of stray cattle, as per the state government**

The Uttar Pradesh government on Saturday said the state was the nation's frontrunner in cow protection and livestock development, accounting for 16 percent of India's cattle population. It said that cows are not only revered in UP, but are also powering the rural economy, creating jobs and strengthening livelihoods. The government claimed, citing the 20th Livestock Census (2019), the state is home to 1.90 crore cattle, including 11.84 lakh stray cattle, a figure that has grown from over 12 lakh in 2017, before formal policies were in place.

The government further claims, after Yogi Adityanath became Chief Minister in 2017, cow protection became a top priority in the state. On January 2, 2019, UP became the first state in the country to launch a policy for the protection of stray cattle. According to the government data there are 7717 cow shelters in the state, housing 12.52 lakh (1.25 million) cattle. The government spends Rs 50 per animal per day, around Rs 7.5 crore daily, for their care. For every large cow protection center, Rs 1.60 crore is being invested in construction. According to the official data the state produces 5,500 tonnes of cow dung daily, which is being used to make



various products like vermicompost, flower pots, cow-based lamps, cow-dung wood, incense sticks, Panchgavya, Jeevamrit, and Ghanamrit.

According to the government, the state has a Gross State Domestic Product (GSDP) of rupees 25.63 lakh crore of which the livestock sector contributes rupees 1.67 lakh crore. While livestock contributes to 4.11 percent to India's overall GDP, While livestock contributes 4.11% to India's GDP overall, UP contributes a much higher, 7.1 percent according

The facility has been constructed at a cost of Rs 6.75 crore.

Skin Banks are facilities which collect skin through donors for replacing the burnt skin of victims. In cases where a burn victim could not use his or her skin, the skins stored in the Skin Banks can be used. This helps reduce the pain and chances of infection. The skins are

kept at a specific temperature. "Works are in progress to start another Skin Bank in Kottayam Government Medical College," Health Minister Veena George said in a statement. She also said that to ensure



efficient treatment to burn victims, burn centres were set up in Alappuzha, Kollam, Kannur Medical Colleges. Plastic surgery units were also started in these medical colleges. Burns ICU were also set up in medical colleges.

## HR&CE permits SC couple to conduct their wedding in Palayamkottai temple

The Hindu Religious and Charitable Endowments (HR & CE) Department on Saturday granted permission for a couple belonging to the SC community (Hindu Puthiraivannar) to conduct their wedding at Melavasal Balasubramanya Swami Temple in Palayamkottai, a day after TNIE published a report on their plight on Friday (July 4).

On June 24, the couple — J Gopal Sami and G Manju — submitted their application seeking permission to hold the wedding on the temple premises. However, the HR&CE staff at the temple rejected it, citing that their parents have Christian names. Their request was turned down despite the couple and their family possessing Scheduled Caste (SC) Hindu Puthiraivannar community certificates issued by tahsildars. Gopal said, "It should be noted that if members of the SC community practise Christianity, they can only obtain Backward Class (BC) certificates."

Moreover, he said, "My late father, Joseph Sami, had been visiting Sabarimala Ayyappan Temple for over 15 years. The wedding engagement followed Hindu customs. Manju's brother, G Manoj, recently got married at the Ilanji Kumarar Temple, managed by the HR&CE. Despite submitting these proofs, the temple staff rejected our application."

# Kerala health minister visits hospital collapse victim's family amidst protests

**Bindhu, who was accompanying her inpatient daughter, got trapped in the debris after part of a building in the hospital collapsed.**



George said Chief Minister Pinarayi Vijayan already talked about this and the relief

measures for the family would be announced by him based on the decisions of the state cabinet. Appropriate decisions for the family would be taken soon, the minister added. Bindhu's husband, Vishruthan said the minister assured the family that their son would be given a permanent job in the government sector.

The family has hope in the government and they are satisfied with the interventions made by the authorities so far, he said.

The toilet complex adjacent to wards 10, 11, and 14 at Kottayam Government Medical College collapsed on Thursday while the hospital was in the process of fully shifting operations to the newly constructed surgical block.

Bindu (52) had died, and three others were injured in the incident.

While the Congress and BJP termed the death as "tantamount to murder" and staged widespread protests seeking the resignation of Veena George, state ministers, including VN Vasavan, Saji Cheriyan, P A Mohammed Riyas and V Sivankutty, strongly supported her and said such allegations were "politically motivated".



## The mirror of revisited classics

It's been a summer of classics for me. A series of events made me peer beyond the here-and-now into the phenomenon of enduring works of art.

In May, Satyajit Ray's 1970 classic, Aranyer Din Ratri (Days and Nights in the Forest), was screened at the Cannes Film Festival in the presence of actors Sharmila Tagore and Simi Garewal after the film had gone through a six-year-long restoration process.A month later, an uncut, restored version of Sholay was unveiled at the Rediscovered Cinema festival in Bologna at a memorable setting—an al-fresco screening at dusk on the city's central piazza, with a full crowd watching the classic on the 50th annisary of its release.A few days earlier, on the 50th anniversary of Indira Gandhi's Emergency rule, Hazaron Khwaishein Aisi (A Thousand Wishes Like This) became the buzz. Interestingly, Sudhir Mishra's 2003 film, like Ramesh Sippy's 1975 film and Guru Dutt's Pyaasa (1957)—whose restored version was commercially re-released this April and showcased at Cannes later—had initially opened to tepid audiences, but became all-time classics with word-of-mouth promotion. But then, this is not just about movies. Be it movies, music or books, the phenomenon of classics begs questions on their enduring mystique, without any answer that involves mathematical certainty. However, with the wisdom of hindsight, I dare say there are several explanations that are equally fascinating.The most obvious one is that some creative works have a timeless appeal based on human emotions that cut across generations. The cry for justice, the longing for love, childhood innocence, character flaws, and awesome heroism are identifiable across cultures. Ernest Hemingway's The Old Man and the Sea is not about fishing, as a casual reading might show, but about endurance and the human spirit.

A favourite anecdote is about screenwriter Jean-Claude Carrière, who is said to have remarked that he wrote the script for a stage adaptation of the Mahabharata by Peter Brook in Paris because "when you see a character, you can say, There goes Shakuni".There are also storytelling styles that appeal with their innovation, timing or context. Think of the Salvador Dali or Vincent van Gogh paintings that come with stories about their creators, which built an aura with the contexts.

The cliché of struggling artists can bring attention back on their works. Teesri Kasam, the Basu Bhattacharya movie released in 1966, was a box office failure, but its songs live on along with the story about how its producer and renowned lyricist Shailendra died a broken man.I also believe classics help new generations understand their parents, ancestors or nations in a way that earns them the timeless tag. You can travel in time with classics, especially ones that are written or scripted as tales of the times. Cross-genre versions, send-ups or parodies can also be a path back to an old work. My own interest in Beethoven was kindled by a disco version of his 'Fifth Symphony' in the 1977 hit Saturday Night Fever, and I went on to listen to the sublime original and other works by the composer. One learnt later that the raucous opening guitar riff of rock group Deep Purple's 1972 classic 'Smoke on the water' was little more than a slightly modified reverse of Beethoven's Fifth.Classics also serve conduits between literature and history. This March, I listened to a captivating lecture on E M Forster's A Passage to India on the 100th anniversary of the publication of the novel set in the waning days of the British raj. For one, the book set in the 1920s reveals much about the subsoil that Hindutva grew on. The characters reflect the social realities of those times that shaped both the Gandhian approach to independence and Veer Savarkar's cultural orientations. Novels, after all, can capture the zeitgeist in a manner a droll history textbook cannot.

## Test for India in a quid pro quo world

THE GREAT GAME: To take control of the narrative, the Modi government is allowing the Pakistan hockey team to play two tournaments in India

MAY we live in interesting times, goes the Chinese proverb. In a fast-moving world, the week gone by threw up some interesting facets in the world around us. In any case, the end of the week is always a good time to take stock of things.The China-Pakistan bond — “higher than the mountains, deeper than the seas and sweeter than honey,” a phrase that is invoked like a mantra between leaders of both countries when they meet — is fast becoming a reality that is staring India in the face, wherever it turns to look.Deputy army chief Lt Gen Rahul R Singh's eloquent remarks about China using the “borrowed knife” approach — meaning that, during Op Sindoor, it aided Pakistan every step of the way to hurt India — is confirmation, if confirmation was needed, that China is India's foremost adversary.Two other factors are equally significant. The first, that China's key adversary, the US, is also warming towards the Pakistanis. The second, that as the Dalai Lama turns 90 this weekend and has, himself, put to rest speculation about his reincarnation — by saying that he will be born outside China, in a free and democratic country, for example like India — it is not clear how the Modi government is viewing this transition-in-the-making.

Let's take the first, first. It now seems that just before the Quad foreign ministers met in Washington DC earlier this week — and issued a statement that refused to name Pakistan as the sponsor of the Pahalgam attack, although it condemned “cross-border terrorism”, a compromise phrase that indicated it was the farthest it would go — the Pakistan air force chief, Zaheer Ahmed Baber Sidhu, was also warming his heels in the US capital.Sidhu's visit comes in the wake of the Pakistan army chief, Field Marshal Asim Munir's trip to the US, where he was feted to an extraordinary meeting with US President Donald Trump. Meanwhile, trade negotiations between India and the US are concluding — the Indian team is back home. If New Delhi gets away without opening up its agricultural basket, it would be a big triumph. It might also be seen by the US as a quid pro quo on expanding ties with Pakistan.

And this is exactly where the cookie is beginning to crumble these days. The US knows that the word “Pakistan” is anathema to the Modi government, but it continues to meet its senior military leadership. Parts of

the US are upset that India continues to buy oil from Russia. Meanwhile, Russia has just become the first country in the world to recognise the Taliban, Pakistan's neighbour and now friend-turned-antagonist, in an effort to gain influence in this part of inner Asia.

At least the Quad statement named “Pahalgam,” even if it didn't name “Pakistan.” Last week, Defence Minister Rajnath Singh refused to sign the joint statement of the China-led Shanghai Cooperation Organisation (SCO) because it named neither the country behind the Pahalgam attack nor the venue of the attack.

The bigger question, or questions, are why the Quad, a powerful grouping in the Indo-Pacific of which India is a key partner, is refusing to fully buy what India is saying.



Why are these nations, all of whom recognise that their fellow Quad nation is being hurt by Pakistan-sponsored terror attacks, reluctant to call out Pakistan? Moreover, what can India do to counter this view?It is clear the Modi government intends to take control of the narrative — which is why it is allowing the Pakistan hockey team to play two tournaments in India over the next few months, the Asia Cup and the Men's Junior World Cup, even if these are being framed as international and not bilateral tournaments.Even more interesting is the defence the Punjab BJP has mounted in favour of Diljit Dosanjh and why the honourable and patriotic sardar should not be trolled — and his movie unbanned — because a Pakistani

actress has acted in it.Some days ago, the government tested a balloon by unblocking some social media accounts of key Pakistani influencers like Shoaib Malik, Shahid Afridi and Mawra Hocane — but the social media backlash was so huge that it was forced to block them again.The interesting thing is that some of the information that underlines India's success during Op Sindoor is coming from these blocked social media accounts — like Pakistan Prime Minister Shehbaz Sharif's key aide Rana Sanaullah telling well-known Pakistani journalist Hamid Mir (whose account is blocked) that Pakistan was under a lot of pressure when India's BrahMos missiles were honing in towards Nur Khan airbase.According to Sanaullah, the Pakistani defence forces only had “34 seconds” to decide how to act. If they had responded by firing their own missiles, he said, the tit-for-tat reaction may have led towards an escalatory situation. Clearly, Sanaullah was admitting the nervousness in the Pakistani camp that early morning of May 10 when the IAF basically settled the matter.

Now snatches of this interview are being played out on social media today — but imagine the effect if the full interview was available to all Indians, not just a truncated version of it.And then there is the Dalai Lama question. Parliamentary Affairs Minister Kiren Rijiju, who hails from Arunachal Pradesh, which is where the sixth Dalai Lama was born, in Tawang, as well as where the current, the Fourteenth, set foot when he fled Tibet for India in 1959 — has been fielded these last few days to insist that the Dalai Lama, and no one else, (meaning, China) will decide what happens to the holy institution of Tibetan Buddhism.The Modi government will more or less go along with what the Tibetans-in-exile want, but all sides know that in the knuckle-hard world of today, where each country will protect its own interest, it is unlikely that New Delhi will go out on a limb to unduly irritate the Chinese. The Chinese, on their part, have warned India to “exercise caution” on this matter before it affects bilateral relations — there's the not-so-coded threat.

Old-timers remember the one meeting between PM Modi and the Dalai Lama about 10 years ago — a secret meeting to which the Tibetan leader was taken to meet the PM in an unmarked car and darkened windows. Today, New Delhi has put out that it doesn't take positions on matters of faith, although it upholds freedom of religion. Question is, what does this coded message mean?

## No ifs and buts about Constitution's amended preamble

When the government says on record that it holds the Constitution as the 'holiest of holy books', there can be no ifs and buts about the amended Preamble

An Emergency-era constitutional amendment inserting a couple of words to the Preamble—socialist and secular—is back in public gaze. That it was flagged by RSS General Secretary Dattatraya Hosabale, a politically savvy leader, made its latest iteration consequential. Emphasising that they were added at a time when the fundamental rights were suspended, parliament was dysfunctional, and the judiciary had become pliant, Hosabale suggested a debate on the Preamble's reset. But that came in the teeth of Prime Minister Narendra Modi's assertion in 2023 that any talk of amending the Constitution was “meaningless”. Rumours about tinkering with the Constitution through the parliamentary supermajority the BJP sought played its part in opposition consolidation in the run-up to the 2024 Lok Sabha elections. It contributed to the BJP's slide, as the party fell short of majority in the Lower House. Yet, when the second-most senior leader in the RSS makes a point, the BJP listens. Soon enough, people holding high



offices—Vice President Jagdeep Dhankhar, Assam Chief Minister Himanta Biswa Sarma and Union ministers Shivraj Singh Chouhan and Jitendra Singh—concurred with Hosabale.

However, last November, the Supreme Court had thrown out petitions seeking the purge. A bench led by the then

Chief Justice, Sanjiv Khanna, ruled that the concept of secularism represents one of the facets of the right to equality. Several landmark Supreme Court verdicts have also upheld secularism as part of the Preamble and the Constitution's basic structure. On socialism, the court said, “The way we understand socialism in India is very different from other countries. In our context, socialism primarily means a welfare state. That is all.”

With the judiciary drawing the red line and closing the door, the issue can only be dealt with by parliament. The opposition is already sharpening its knives, warning it will not allow any such change to the Constitution. When the government says on record that it holds the Constitution as the ‘holiest of holy books’, there can be no ifs and buts about the amended Preamble. Despite multiple debates in the past on the insertion of the two words and scoring polemical points, there was no parliamentary consensus on removing them. India's social fabric of a multi-ethnic, multi-religious welfare state must be kept out of harm's way.

## Heartburn over rebels with a cause

Shashi Tharoor, like V P Singh & Somnath Chatterjee before him, has put his party in a quandary by not toeing the line. Principled defiance is not easy to brush off

Political parties in India ostensibly have two kinds of rebels or dissenters. The first kind of rebels are the common, pedestrian variety. They crudely bargain for power. They could be seeking an election ticket, a higher position, a hefty ministerial berth or greater funds. They threaten to disrupt if their expectations are not met. The second type is rare to come by. They are the ones who put their parties in a piquant moral situation. They prick the conscience of their parties. They do so by either arguing from a higher ideological plane; by prescribing higher values to their colleagues, or via aligning themselves, parallelly, with a purpose far greater than that being advocated by their parties at a given time.These high-minded grumblers, if we may call them so, may be difficult to handle, but parties cannot easily dismiss them. That is because they form a virtuous smokescreen before the voting masses, and sometimes become fossilized symbols of the foundational principles of their parties.

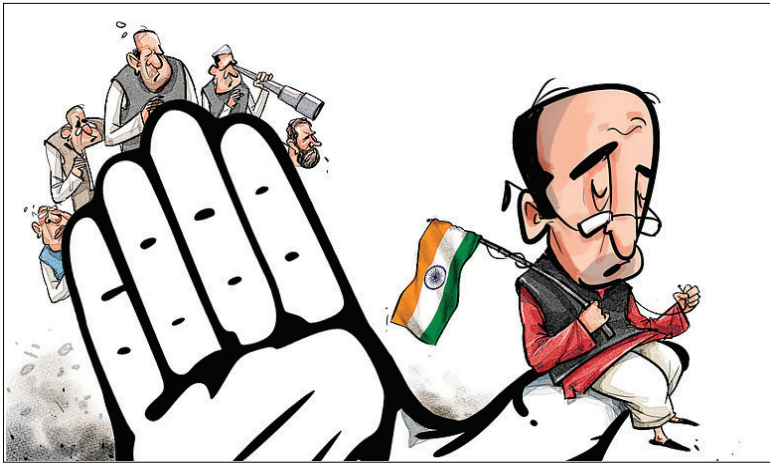
In recent days, Shashi Tharoor, a member of parliament from Thiruvananthapuram, has come across as the second type of rebel within the Congress. Ever since he became the most eloquent, nonpartisan voice by leading an official delegation to foreign nations to explain India's war against terrorism, his party has suspected his loyalty. They have coldshouldered him, attempted to play down his importance and even underplayed his certain mastery over English.But more the effort the Congress has put in, Tharoor has sparked more in the eyes of a larger audience. The headlines have

not stopped chasing him. To the extent that many think he is independent of the Congress; that he may get a newly-crafted diplomatic assignment under the Modi dispensation to regularize his patriotic services; that he may even cross over to the BJP and become a minister in the cabinet, or ultimately head to Kerala to head the state.

All these are far-fetched. Tharoor is not politically naïve to start believing the publicity that surrounds him. However, he is smart enough to leverage the fair winds among the masses in his favour, to position himself as a singularly independent politician in India in times of polarised affinities. It is this well-crafted independence that gives him the power over two large warring ideological constituencies.Arificial Intelligence usesArificial Intelligence uses

Tharoor's recent statement on the RSS was proof of his political deftness. It directly challenged the Congress position on the issue, and more so that of Rahul Gandhi. Tharoor said: “At the time of the adoption of the Constitution [75 years ago], Mr Golwalkar, among others, said that one of the great flaws of the Constitution is that there is nothing of the Manusmriti in it. But I think the RSS itself has moved on from those days. So, as a historical statement, it's accurate. Whether it's a reflection of how they feel today, the RSS should be in the best position to answer that.”The RSS and the BJP were somewhat let off the Congress hook after this statement. They had been segued out of embarrassment, courtesy Tharoor. Since the debate

was happening in the context of 50 years of the Emergency, when the Constitution was dismantled by Indira Gandhi, it was as if a mirror of duplicity had been held before the Congress. The party's self-righteous propaganda on the Constitution had



been happening without it actually apologising for the horrors it had perpetrated during the Emergency and the anti-democratic institutions, including the idea of political dynasties, that it had established.

The ruling Modi dispensation seems to have happily adopted Tharoor because it saw the need for a reasoned patriotic voice on the international stage after Operation Sindoor. Perhaps they realised that their own jingoistic tone wouldn't work. And Tharoor needed an open arena to escape the stifling atmosphere inside his party. The regime's need and

the politics of Tharoor appears to have aligned at the same time to cause a massive heartburn within the Congress. Yet, they cannot be seen acting against him, at least not immediately.It is apparent that the Congress is not enjoying this checkmate.

The dynasty may eventually act and its courtiers may add to the glossary of trolls, yet it won't be as easy as seeing off others who had crossed over for power. Over the years, Tharoor has become an aspirational symbol of new India where everybody seems to want his charm, his coiffure and his English accent.In contemporary history, there are two outstanding examples that reconstruct a similar moral quandary that Tharoor has put his party in. V P Singh, in the mid-1980s, had similarly thrown a moral challenge at Rajiv Gandhi and the Congress. Even while inside the party and the cabinet, he had accused the

regime of corruption and grabbed the mantle of ‘Mr Clean’.Singh's biographer Debashis Mukerji writes that on May 16, 1987, at a Congress rally in Delhi's Boat Club grounds, Rajiv Gandhi could not contain his growing unease against Singh. Without naming him, Rajiv said: “Today we should remember how a Mir Jafar rose in our midst, a Jaichand rose in our midst, to weaken the country... we'll give them a fitting reply.” Jaichand was purportedly Singh's ancestor and the implication was clear. Singh left the rally midway and the rest was history.



# Move over drizzle, brace for heavy showers in Gurgaon this week

## Gurgaon. (Agency)

The city is likely to experience heavy rain in the coming days, with India Meteorological Department (IMD) issuing a yellow alert till June 9. Monsoon activity over Haryana is set to intensify, bringing widespread rainfall and thunderstorms, particularly on Sunday and Monday, the IMD forecast read.

Meanwhile, on Saturday, the minimum temperature was recorded at 27.4 degrees Celsius, down from Friday's 28.4 degrees Celsius. While the lower nighttime temperature provided some relief, residents continue to experience humid conditions during daytime. The maximum temperature settled at 35.1 degrees Celsius—almost unchanged from the previous day's 35.2 degrees. Moreover, a brief spell of scattered showers took place around 5pm, which brought 3mm of rainfall to the city. "Monsoon activities are

likely to strengthen across Haryana with the peak intensity of the spell expected between Sunday and Monday, covering most parts of the state," an IMD official said, adding that multiple weather systems will bring rainfall in the region. A cyclonic circulation over northeast Madhya Pradesh in the lower tropospheric levels, combined with an upper air cyclonic circulation over Gangetic West Bengal and neighbouring regions, are influencing weather conditions. Under its influence, a low-pressure area is likely to form in the next 24 hours, further fuelling monsoon activity in the region, the weather department said. So far this monsoon, the state recorded 90mm of rainfall, with an excess of 25% against the normal of 72.1mm. While Yamunanagar received



326.5mm of rainfall (a surplus of 94%)—the highest in the state, neighbouring Faridabad logged the lowest rainfall with 30.3mm (a deficit of 52%). Between June 1 and July 5, Gurgaon recorded 71.5mm of rainfall with a surplus of 4% against the normal of 68.5mm. Meanwhile, some parts of Delhi

saw very light rain on Saturday, but hot and humid conditions made the outdoors uncomfortable. However, relief is expected on Sunday as the India Meteorological Department has issued a 'yellow' alert for light to moderate rain along with thunderstorms and lightning.

The maximum temperature on Saturday was recorded at 37.1 degrees Celsius, one degree above normal. It was 36.2 degrees Celsius a day earlier. However, due to high humidity, the heat index or 'feels like' temperature was higher. The heat index settled at 54 degrees Celsius at 5.30 pm. The relative humidity oscillated between 57% and 89%. The minimum temperature was reported at 27.9 degrees Celsius, which is near normal for this time of the year.

## Gurgaon man gets bail in cheque bounce case, but doesn't make it to home

### Gurgaon. (Agency)

A 47-year-old physically challenged man — granted bail in connection with a cheque bounce case — died in police custody as his family waited outside the gates of the Civil Hospital to take him home. An insurance agent with 80% disability, Lokesh Kumar was arrested on June 24 despite objections from his family that he was too ill to be taken out of home and had been confined to the bed for 10 days before that. He was lodged in Bhondsi jail until a local court granted him bail this Friday. Anticipating his release, Kumar's family stood outside the jail when they saw an ambulance wheeling him out unconscious. Despite their attempts to check on him, the family claimed they received no response from the jail authorities and could only follow the ambulance to the hospital, where doctors declared him dead around 2.30pm. The arrest itself was contentious, Kumar's relatives alleged, saying they had repeatedly pleaded with the proclaimed offender staff not to take him into custody because of his poor health. "He had 80% disability and was not keeping well for some time. When we requested the cops that he be allowed to stay home, they informed us that he was declared a proclaimed offender as he did not appear before the court in his cheque bounce case. They said they were bound to take him into custody. They arrested him on June 24 from his house, and he remained in jail until he was granted bail on Friday. After the release order was sent to the jail authorities, the family waited outside the gates to take him home. But he couldn't make it," said Anuj Ravhavi, a lawyer and Kumar's relative. The family accused the jail authorities of negligence, claiming they weren't informed about Kumar's deteriorating health before he was rushed to hospital. Kumar's paternal cousin has demanded a thorough investigation, asserting that the death occurred in police custody. Jail superintendent Naresh Goyal, however, denied any negligence on the part of the cops, pointing to Kumar's existing health conditions.

## 50k trees to make up for green cover loss along metro route in Gurgaon

### Gurgaon. (Agency)

A land parcel spanning 18 hectares in Kadarpur village has been earmarked for compensatory afforestation to offset the environmental impact of the Millennium City-Cyber City metro corridor project. The identified non-arable hilly terrain is part of a 190-hectare land parcel currently under MCG's possession. The compensatory afforestation is a statutory requirement under forest conservation norms, mandating authorities to plant 10 times the number of trees cut for infrastructure projects. According to officials from GMRL, the agency executing the metro project, the identified land has been earmarked by the MCG for afforestation, and the formal demarcation process has begun. The proposed metro corridor is planned to be executed in two phases. In Phase 1, which is already in the tendering process, around 1,800 trees are

set to be felled to make way for the construction of pillars, stations, and depots. For Phase 2, officials said the exact number of trees to be removed is yet to be finalised, but initial estimates suggest the number is around 3,000. Going by the estimates, GMRL is required to plant 48,000 trees to offset the loss of green cover. GMRL officials said that since the metro project is essential for urban mobility, ensuring environmental mitigation alongside construction is a key priority. "MCG has approximately 190 hectares of land in Kadarpur. Of this, the municipal corporation has earmarked 18 hectares for compensatory afforestation linked to the metro project. This area will be developed as a green zone with species that have a better survival rate. The forest department has already given permission for 1,300 trees to GMDA, as master roads are under their jurisdiction, for removal of

trees," a senior official of GMRL said. The 30.5 km metro project between Millennium City Centre and Cyber City was approved by the Union Cabinet in 2023 and is expected to decongest roads and reduce vehicular emissions by offering a mass rapid transit alternative. Meanwhile, the technical committee of GMRL has found six agencies eligible for the construction of the Phase 1 corridor between Millennium City Centre and Sector 9 with a spur to Dwarka Expressway. The tender for the civil work for Phase 1 was floated in March this year, in which eight agencies participated. Under this, 15.2 km will be constructed with 14 stations. Last month, GMRL shortlisted a joint venture of Deutsche Bahn Engineering & Consulting (DBEC) and Hill International for the role of general consultant (GC) for the Gurgaon Metro.

## Old doesn't mean unfit: Judge car not by age, but condition, say end-of-life vehicle owners in NCR

### Gurgaon/Noida. (Agency)

"In the pink of health," Pradeep Pachauri insists of his Nissan Sunny, which he has kept parked in the garage of his Gurgaon house in Sector 37D, of late, fearing the car will be seized if he takes it to Delhi. "My car is parked in the garage, and I have been taking cabs to go to Delhi. Imagine," says Pachauri, whose diesel-powered sedan has run less than 1 lakh km in 10 years. "The car is in good running condition. I have an up-to-date Pollution Under Control (PUC) certificate for it. When I bought the car in 2015, I also paid a one-time road tax for 15 years. Despite adhering to all norms, I can't run my car in NCR. The system is forcing me to purchase a new car without getting any meaningful price for my old vehicle," adds Pachauri, saying cars should be judged by emissions and running condition rather than the sole criteria of age. Based on a 2015 NGT order and subsequent rulings by the Supreme Court

that diesel vehicles over 10 years old and petrol vehicles more than 15 should be deemed "high-polluting" and EOL (end-of-life) vehicles and taken off roads, Delhi govt had announced they would not be given fuel from July 1, and the vehicles would be seized if seen on roads. But implementation proved thorny. A mix of logistical issues, such as inconsistent rollout timelines across states, and emotional ones—like the distress of parting with a still-functioning car—have made enforcement unpopular. On Thursday, the govt backtracked from it, citing public sentiment. Noida police, however, forged ahead and impounded 76 EOLVs between July 1 and 4 alone. In Delhi, around 90 were seized till July 3.

While a policy decision is yet to be taken, the deadline to scrap or shift EOL vehicles from the five high-density NCR districts of Gautam Budh Nagar, Ghaziabad, Gurgaon, Faridabad and Sonapat remains Nov 1 as of now, with plans to cover the

rest of the districts in the region by April 2026. The order, meanwhile, has left many vehicle owners, like Pachauri, anguished about making a fresh investment in a new car—a new car like Nissan Sunny would cost over Rs 20 lakh—when there is nothing wrong with their old vehicle.

"The rule seems to be blind to individual realities, especially for vehicles that saw minimal use during the pandemic and are still roadworthy," says IT professional Sapan Rastogi, a resident of Greater Noida's Gaur City, whose diesel Renault Duster has run just 52,000 km in nearly nine years. "We hardly used it for two Covid years. But we made so many memories—from office runs to trips across Rajasthan and Himachal. It's not just a car—it's part of our family history," he says. In Noida's Sector 51, Sanjeev Kumar's white Volkswagen Vento, a 14-year-old petrol car, has clocked just 58,000 km. "It's well maintained. I've replaced parts, serviced it regularly.

## Unauthorised religious structures on govt property get MCG notices

### Gurgaon. (Agency)

MCG is preparing to act against unauthorised religious structures constructed on govt property, public parks, and green belts. According to MCG records, around 90 such religious structures, including temples, mosques, churches, and gurdwaras, exist in the city.

The municipal corporation has issued a public notice, citing a Supreme Court directive prohibiting such construction in public spaces, particularly after Sept 29, 2009. The officials said that failure to comply will result in the competent authority undertaking demolition, with all associated costs to be borne by the responsible parties. Also, the authorities have warned that any violations of this directive will face legal consequences.

"We will proceed with measures against unauthorised constructions situated on govt-owned land and green zones, following the Supreme Court's directives and state govt's instructions, as the state maintains oversight of this issue. Given the religious significance and public sentiments involved, the situation will be handled with appropriate care and consideration. We will ensure proper maintenance of law and order throughout the process," the MCG commissioner Pradeep Dahiya told TOI. Meanwhile, Faridabad DC Vikram Singh also said that, in accordance with the clear directives of the Supreme Court, any construction of religious structures on public land, especially in parks and green belts, will no longer be tolerated in the Faridabad district.

Officials said that their goal is not to disrespect any religious sentiments but to ensure the proper use of public land according to regulations. They have appealed to all citizens to cooperate and report such

## Man held for pushing roommate to death from 5th floor over missing mobile phone

### Gurgaon. (Agency)

A 20-year-old man was arrested for allegedly pushing his roommate from a five-storey building following a dispute over a missing mobile phone.

Aakash, 22, who arrived from Aligarh seeking employment just 15 days before his death, was living in Manesar with his friend Prashant alias Kanhaiya, who hails from Palokhara village in Agra. Aakash had secured a job with a local private company on July 1.

The incident took place around 11.30pm on Thursday, when an intoxicated Kanhaiya confronted Aakash on the rooftop about his missing phone, leading to an altercation that resulted in the fatal push.

Aakash fell onto the rooftop of another house and sustained severe head injuries. He died on the spot and Kanhaiya fled the scene. "The cops reached the spot and found the victim's body. A forensic team along with senior police officers started investigation into the case, and IMT Manesar police nabbed the accused from Agra," ASI Sandeep, police spokesperson, said.

## After spat with wife, Noida man kills lover to end 8-year-old affair

### Noida. (Agency)

A 38-year-old man was arrested after a gunfight for allegedly murdering his partner by slitting her throat in Nirman Vihar. The accused, Mukeem, allegedly killed the woman after deciding to end their eight-year-long relationship. Police said they received information around 6pm on Friday about a woman found dead inside a rented accommodation in the colony.

"Following the information, a team from Ecotech 3 police station, along with senior officials, rushed to the spot. The woman was found with her throat slit. She was taken to a hospital where doctors declared her brought dead," said DCP (central Noida) Shakti Mohan Avasthy. The deceased, Shabnam, is from Luharli village and stayed in Haibatpur before being killed. The house where her body was found had been rented by Mukeem around 15 days ago, police said.

Based on a complaint by Shabnam's son, an FIR was registered under Section 103(1) (murder) of BNS at Ecotech 3 police station. Avasthy said two police teams were deployed to trace the accused. He was arrested after a brief encounter on Saturday morning near Changanpur roundabout. "The team signalled a suspicious man on a motorcycle to stop. Instead, he turned and tried to flee.

During the chase, he abandoned his motorcycle and attempted to escape through an empty courtyard. When surrounded, he opened fire at the police team. In retaliatory firing, he sustained a bullet injury and was subsequently arrested," Avasthy said. Police recovered a knife, a pistol, and the motorcycle from his possession. During interrogation, Mukeem, a resident of Dadri and a carpenter by profession, confessed to killing Shabnam. "He told us they had been in a relationship for over eight years. His family, particularly his wife and children, disapproved of the affair and pressured him to end it," the DCP said.

On Friday, Mukeem called Shabnam to the rented room around 3 pm and killed her with a knife, police said.

Another senior officer said Shabnam had been living separately from her husband, Shabuddin, for the past eight years. "Both Shabuddin and Mukeem are relatives. After separating from her husband, Shabnam began a romantic relationship with Mukeem. As his children grew older, they objected to the relationship, leading to tensions. Mukeem recently took a carpentry contract in Nirman Vihar and rented a room nearby, where he planned and executed the murder," officer said.



# They built NCR's cities, but never got a home of their own

### Ghaziabad. (Agency)

"Life is tough," Mangi Ram said, standing outside a four by three-metre room fashioned out of loose brick walls with tin sheets and polythene for a roof that is his home. For the time being.

The 34-year-old construction worker lives in a makeshift settlement along with hundreds of others, who—like him—have been employed to build a multi-storey building in Siddharth Vihar. "Even if we have a job, living conditions are not good. We don't have access to clean water and other necessities. At night, we live in huts. That is, till we need to move for work elsewhere," Ram said.

Some six kilometres away, Ram Narayan (35) of Mathura stays in a similar settlement in Indirapuram. Ram and Narayan are not among the 3.27 lakh workers registered with the labour department in Ghaziabad. Because of this, they remain outside the bracket of any welfare schemes introduced by the govt to make life easier. Though NCR's construction boom has been on the back of workers like Ram and Narayan, most of them live in poverty, on the sidelines of rapidly growing cities. Workers and their families leave their villages behind in search for better lives. But once here,

they neither find stable jobs nor a place to call home. Employed by contractors, workers and their families must stay on the move, living in temporary settlements near construction sites. Work is scattered over months and salaries aren't fixed. At the end of a work day, they get Rs 500, and there are no paid leaves for the days they fall sick. "We have our people in far-flung areas of the country like Bihar, UP, Odisha and Jharkhand. As per labour demand, we facilitate their movement. In NCR, however, there is no dearth of labour demand," said Ratnesh Sahu, a contractor. Sahu said contractors have the first line of contact with developers. "Developers tell us how many workers they need at a construction site. We provide them (workers) with accommodation and other basic amenities, and when the work at a construction site is over, we move them to another part of the region," he said.

Asked if contractors helped workers get registered with the labour department, Sahu scoffed and said, "There are many schemes, but most of them are on paper. Here, labourers are content that, at the end of the day, they get their daily wage

and a shelter to lie down and sleep."

Several workers said they weren't aware of any schemes. No one had ever told them or approached them about any benefits. But a registered worker is eligible to avail these govt schemes. The Uttar Pradesh Gambhir Bimari Sahayata Yojana, for



instance, provides financial assistance to construction workers in case of illness or treatment at public hospitals. Under UP's Nirman Kamgar Mrtyu Va Divyangta Sahayata Yojana, financial aid up to Rs 5.25 lakh is given to the families of registered workers in case of death or disability due to accident or illness. In FY2024-25, the families of 17 workers

got compensation under this scheme. But accidents aren't uncommon in this unorganised sector. Just this Feb, two labourers died after falling from the 10th and 11th floors of separate under-construction buildings in Raj Nagar Extension. The same month, eight workers were injured while attending to an under-construction overhead tank in Muradnagar. Anurag Mishra, deputy labour commissioner of Ghaziabad, told TOI that the district administration provided compensation to the families of any construction workers involved in accidents while at work. Still, he admitted that more needs to be done. "It is important to admit that govt schemes vis-a-vis construction workers need to be publicised, and workers should be made aware of them. Our department, from time to time, holds camps at construction sites. But the nomadic nature of their jobs adds to the problem," Mishra said.

Another official of the labour department said the district disbursed Rs 37.9 lakh under various schemes meant for construction workers in FY2024-25.

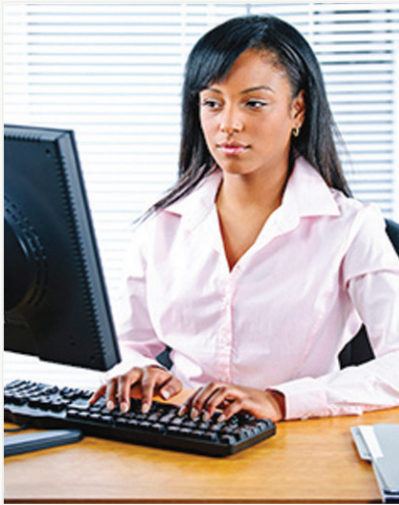

India’s Forex Reserve Is Now Almost Twice The Pakistan's GDP

**New Delhi. (Agency)**  
India’s foreign exchange reserves rose by USD 4.84 billion to USD 702.78 billion for the week ending June 27, close to the record high of USD 704.89 billion in September 2024, according to RBI data.This is a strong recovery from January when reserves had dropped to around USD 624 billion. The increase came mainly from foreign currency assets, which jumped by USD 5.75 billion to USD 594.82 billion, while gold reserves fell by USD 1.23 billion to USD 84.5 billion.Special Drawing Rights (SDRs) rose by USD 158 million to USD 18.83 billion during the week, while India’s reserve position with the IMF also increased by USD 176 million to USD 4.62 billion, as per RBI data released on July 4.Although reserves have grown, RBI’s forward dollar book — which shows future dollar obligations — fell by USD 19 billion in April and May, reducing it to USD 65.2 billion in May from USD 88.7 billion in February. RBI’s net dollar sales in this period were modest at USD 3.2 billion.he rupee has faced volatility since April due to global trade tensions, but RBI interventions have helped stabilize it. RBI buys dollars when the rupee is strong and sells when it weakens to control sharp fluctuations.  
RBI Governor Sanjay Malhotra stated that India’s forex reserves can cover 11 months of imports and 96 percentage of external debt, reflecting India’s strong external position. A healthy forex buffer not only supports the rupee but also boosts investor confidence during global challenges.

Mcap of 6 of top 10 firms declines by Rs 70,325.5 cr; HDFC Bank, ICICI Bank big laggards

**New Delhi. (Agency)**  
The combined market valuation of six of the top-10 valued firms eroded by Rs 70,325.5 crore last week, with HDFC Bank and ICICI Bank emerging as the worst-hit in line with a bearish trend in equities. Last week, the BSE benchmark Sensex dropped 626.01 points or 0.74 per cent.In the top-10 pack, Reliance Industries, State Bank of India, Infosys and Hindustan Unilever Ltd were the gainers, while HDFC Bank, Tata Consultancy Services (TCS), Bharti Airtel, ICICI Bank, Life Insurance Corporation of India (LIC) and Bajaj Finance faced erosion from their market valuation. HDFC Bank’s valuation declined by Rs 19,284.8 crore to Rs 15,25,339.72 crore. ICICI Bank lost Rs 13,566.92 crore in its market valuation which stood at Rs 10,29,470.57 croreThe valuation of Bajaj Finance dropped by Rs 13,236.44 crore to Rs 5,74,977.11 crore and that of LIC diminished by Rs 10,246.49 crore to Rs 5,95,277.16 crore. TCS faced an erosion of Rs 8,032.15 crore from its market capitalisation (mcap) which stood at Rs 12,37,729.65 crore. The mcap of Bharti Airtel fell by Rs 5,958.7 crore to Rs 11,50,371.24 crore.However, the market valuation of Reliance Industries jumped Rs 15,359.36 crore to Rs 20,66,949.87 crore. Infosys added Rs 13,127.51 crore in its valuation to Rs 6,81,383.80 crore. The mcap of Hindustan Unilever climbed Rs 7,906.37 crore to Rs 5,49,757.36 crore and that of State Bank of India went up by Rs 5,756.38 crore to Rs 7,24,545.28 crore.In the ranking of top-10 firms, Reliance Industries retained the title of the most valued firm, followed by HDFC Bank, TCS, Bharti Airtel, ICICI Bank, State Bank of India, Infosys, LIC, Bajaj Finance and Hindustan Unilever Ltd.

Mobility revolution: Union minister Nitin Gadkari unveils futuristic roadmap; pitches electric buses, ropeways and hyperloops

**New Delhi. (Agency)**  
Union minister Nitin Gadkari has outlined a bold vision to transform India’s transport landscape, with a focus on electric rapid mass transport, hyperloop corridors in urban centres, and ropeway and cable-car connectivity in remote regions.  
In an interview with news agency PTI, Gadkari said the government is working on multiple futuristic mobility solutions that aim to cut pollution, improve connectivity, and reduce logistics costs.  
“We are driving innovation. A revolution in mass mobility is underway,” he said, underlining how technology, sustainability, and accessibility will shape the next phase of India’s infrastructure growth.According to the minister, work is underway on 360 ropeway and funicular railway projects in hilly terrains, including Kedarnath, with 60 already in progress. These systems, designed for steep inclines, are seen as essential for providing safe and efficient transportation in remote areas.At the urban level, Gadkari revealed that pilot projects like Metrinio pod taxis, hyperloop systems, and pillar-based transport networks are planned for Delhi and Bengaluru. “Days are not far off when cities will have cable-run buses and electric rapid mass transport with aeroplane-like facilities,” he said.  
He also confirmed that tenders have been floated for 135-seater electric buses in Nagpur, equipped with premium seating, AC, and the ability to travel at 120–125 km/hr. These buses, capable of recharging in 30–40 minutes, will initially operate on trial and then be introduced on intercity routes like Delhi-Jaipur and Mumbai-Pune.  
On the road infrastructure front, Gadkari reiterated the ministry’s goal of building 100 km of highways per day and upgrading 25,000 km of two-lane roads to four lanes.National highways have expanded from 91,287 km in 2013-14 to 1,46,204 km today, he claimed.  
High-speed corridors have also grown substantially, from 93 km in 2014 to 2,474 km now.

Market Outlook: India-US Trade Deal, Q1 FY26 Earnings Key Drivers This Week

After witnessing a phase of profit booking last week, considering the broader indices currently trading at elevated levels, the market participants will closely watch for signs of earnings catch-up from upcoming Q1 — starting next week -- along with the outcome of the interim Indian-US trade deal before the July 9 deadline, analysts said on Sunday. Additionally, the OPEC+ meeting

scheduled for this weekend could influence global oil prices.“On the macroeconomic front, the broader economy stands to benefit from favourable conditions such as easing inflation and declining interest rates. A positive outcome from the US-India trade negotiations could further lift market sentiment, particularly benefiting trade-sensitive sectors like IT, pharma, and auto,” said Vinod Nair, Head of Research, Geojit Investments Limited.Markets ended last week on a positive note despite a largely rangebound trading environment. The Nifty closed at 25,461, up 55.7 points, while the Sensex added 193 points to end at 83,432. The broader market saw support from key sectors like banking, pharma, IT, realty, oil and gas, and media, which posted gains between 0.4 per cent and 1 per cent. However, metals, telecom, and auto stocks underperformed, limiting the overall upside.Investor sentiment remains cautiously optimistic ahead of the anticipated US-India trade agreement,

with the tariff deadline drawing closer. A favourable outcome from the talks could act as a major trigger for the next phase of the rally, especially given the recent lack of directional momentum. This event is being closely tracked by institutional



participants and could determine the near-term trend,” according to a note by Choice Broking.As per Fibonacci extension, the next major upside targets are seen at 27,300 and 28,600. On the downside, key supports are placed at 25,000 and 24,500,

where buying interest is likely to emerge, it added.Meanwhile, the Bank Nifty index closed at 57,031.90 last week, registering a 0.72 per cent decline from the previous week's close. The weekly chart indicates rejection at higher levels; however, the index has managed to hold above the crucial 57,000 mark. The selling pressure at higher levels suggests a potential pause in the ongoing uptrend, indicating a likely sideways phase in the near term, said the Choice Broking note.  
For the ongoing expiry, put options show the highest concentration near the 57,000 and 56,500 strikes, marking these as key support levels. Conversely, significant open interest in call options at 57,000 and 57,500 indicates potential resistance, suggesting a likely trading range of 56,500–57,500 in the upcoming sessions, said analysts.FIIs have turned cautious amid elevated market valuations and mixed global cues, while DIIs continue to provide support, helping stabilise sentiment.

more than what my policy offered. It was a rude shock,” he admits.Stories like Suresh’s are becoming more common as medical costs in India rise every year. A few days in a private



hospital, a surgery, or a critical illness can quickly wipe out years of savings. Many people only realize their insurance is too little when a crisis hits—and by then, it’s too

late.Financial experts say this is a classic case of being “underinsured.” It’s not that you don’t have insurance, but that your cover is too small for today’s realities. Many people stick with the minimum sum insured just to save on premiums, or rely only on the group policy provided by their employer. But with healthcare inflation running high, what seemed like enough cover a few years ago may now fall short.  
Review your health insurance regularly. Don’t wait for a medical emergency to find out your policy isn’t enough. Consider increasing your sum insured, or adding a top-up plan. **India's growing wealth gap often sparks despair, but the author, a retired ESIC Regional Director, argues the real solution lies in enforcing India's long-ignored labour laws.**

**New Delhi. (Agency)**  
It is rightly said that India still has a long way to go before poverty can be totally eradicated. But for this to happen, merely accelerating our annual GDP growth rate to 10% or more will not be enough.  
An increase in GDP, though vital, will not automatically eliminate poverty, let alone reduce income inequality. For that to happen, a range of measures is required, starting with the strict enforcement of labour laws, many of which were enacted as early as 1948, soon after Independence. These laws were intended not just to

protect workers, but to ensure a fairer distribution of economic gains. I will now go into some detail.  
**LIMIT WORKING HOURS TO CREATE MORE JOBS**  
It is common knowledge that workers in the unorganised and informal sectors often work 10 to 12 hours a day, without any overtime compensation. Despite a growing GDP, youth unemployment remains worryingly high. According to the Ministry of Statistics, the unemployment rate among those aged 15 to 29 in May this year was 17.9% in urban areas and 13.7% in rural areas.If the working hours for both regular and contract or outsourced workers are restricted to 8 hours a day and 48 hours a week—as mandated by the Factories Act, 1948 - significant employment opportunities can be created. The same applies to the Shops and Establishments Acts across states. If strictly enforced, these provisions would drastically reduce unemployment.  
**MINIMUM WAGES STILL DENIED TO MILLIONS**  
Without first ensuring fair wages, we cannot even begin to talk about living wages for India’s working class in accordance with

Article 43 of the Constitution. What is disheartening is that workers, not only in the unorganised and informal sectors but even outsourced workers in the organised sector, are frequently denied the minimum



wages mandated by law, despite long working hours.  
This is no secret. The returns submitted by employers under the Employees' Provident Fund (EPF) and Employees' State Insurance (ESI) Acts reflect the actual situation. They expose widespread violations, as these returns include wage details and the number of days worked against each employee. The evidence is there in plain sight, but we do not want to see. I raised this issue during my deposition before the Second National

Labour Commission while serving as Director, Odisha region, ESI, but to no avail.  
**ESI COVERAGE REMAINS WEAK AND SELECTIVE**  
The compliance levels under the ESI Act, 1948, are similarly troubling. Many small- and medium-scale factories either fail to register their units or exclude large segments of their workforce - particularly contract workers - from ESI coverage.  
Yet the Act is a vital social protection tool. It covers medical expenses, provides cash compensation for sickness and disability, and offers monthly pensions in the form of dependents' benefits in case of workplace fatalities. Proper enforcement could greatly improve workers' quality of life.  
**CONTRACT LABOUR LAW DILUTED BY STATES**  
The Contract Labour (Regulation and Abolition) Act, 1970, was designed to regulate and, where appropriate, abolish contract labour. But the Act’s provisions are undermined by loopholes. For instance, it does not apply to establishments engaged in intermittent or casual work.

WI vs AUS, 2nd Test: Steve Smith braves West Indies pace battery to put Australia in driver's seat

A gritty half-century from Steve Smith and a composed knock by Cameron Green helped Australia wrest back control on a rain-hit third day of the second Test against West Indies, putting the visitors firmly in the driver's seat. Australia recovered from the top order collapse, which they faced late on Day 2.Resuming at a precarious 12 for 2 in their second innings, Australia clawed their way to 221 for 7 at stumps on Saturday, stretching their lead to a commanding 254 runs on a tricky surface that continued to play unpredictable tricks, keeping low and offering variable bounce throughout the day.Smith, returning to the playing XI after missing the first Test due to a finger injury, weathered both the West Indian pace attack and a blow to his recently dislocated pinkie to compile a patient 71 off 119 balls. His knock, which included seven boundaries and a six, formed the backbone of Australia's resistance and revival.

Green, who resumed the day on 6, looked increasingly assured at No. 3 and brought up his half-century with his fifth boundary, a milestone he reached in 122 balls. But he perished the very next delivery, chopping on against Shamar Joseph for a well-made 52, ending a crucial 93-run stand with Smith that



pulled Australia out of early trouble.

"It was not ideal getting hit on the finger, but it feels all right," Smith said after play. "It's that kind of surface. Some balls can shoot up, and sometimes you just have to take a few on the hands."Rain interruptions dominated the morning and afternoon sessions, with nearly two hours of play lost to passing showers. When play resumed, scoring remained a grind as the West Indies seamers, particularly Shamar Joseph and Justin Greaves, extracted life from the deteriorating surface.Greaves, in a sharp post-tea spell, removed both Smith and Beau Webster in quick succession to briefly revive West Indies' hopes. Smith's decision to review his LBW dismissal proved futile, with replays confirming the ball was crashing into the off stump. Greaves ended with two wickets for the day, while Shamar Joseph added to his tally with the important scalp of Travis Head, who had threatened to accelerate with a brisk 39.

ENG vs IND: Will rain spoil India's chances of maiden Test win at Edgbaston

India, led by Shubman Gill, stand just seven wickets away from making a bold statement — their first-ever Test win at Edgbaston, and a dominant one at that. As the second Test heads into its final day, England find themselves deep in trouble, needing 536 more runs with only seven wickets in hand.

India, on the other hand, have done almost everything right so far. They piled on the runs with authority, declared at 427 in their second innings to set a daunting target of 608, and then ripped through England's top order before stumps on Day 4. Zak Crawley was dismissed for a duck, Ben Duckett couldn't survive either, and the biggest blow came when Joe Root was removed — all thanks to a disciplined bowling display from Mohammed Siraj and Akash Deep.Gill has led by example with the bat, scoring a stunning 269 in the first innings and



following it up with a fluent 161 in the second. Siraj, with six wickets across the game, has spearheaded the bowling attack, while Akash Deep — standing in for Jasprit Bumrah — has delivered crucial breakthroughs when it mattered.

India are in the driver's seat, and the series, currently 1-0 in England's favour, could be levelled. But there's one big variable that could throw a spanner in the works — the Birmingham weather.

register a sub-10.20 second timing in 100m, bettering Gurindervir Singh's earlier 100m national record of 10.20 seconds in the meet at Vari, a suburb of the Greek capital Athens.Sotirios Garagannis of Greece (10.23s) and Samuli Samuelsson (10.28s) were second and third respectively in the World Athletics Continental Tour silver label meet.Kujur now holds both the 100m and 200m national records. He had clocked 20.32 seconds in the men's 200m final of the Asian Athletics Championships in South Korea in May to break his own previous national mark of 20.40 seconds created at the Federation Cup earlier in the year.

Inspired by Shubman Gill, Vaibhav Suryavanshi aims 200 after record-shattering century in Youth ODIs

Young Vaibhav Suryavanshi is already targeting his next milestone just moments after rewriting the record books in the Youth ODI format on July 5. Vaibhav, while playing the fourth U19 ODI against England in Worcester, smashed a stunning 52-ball century, the fastest ever in Youth ODIs, breaking the previous record of 53 balls set by Pakistan's Kamran Ghulam.Speaking right after the game, the 14-year-old Vaibhav revealed that he wanted to score a double hundred in the youth format. Vaibhav revealed that he was inspired by Shubman Gill after seeing the India captain bat at Edgbaston. Shubman scored 269 and 161 runs in the two innings in the 2nd Test match between India and England, putting the visitors in pole position to win the Test match.I did not know that I had broken the record. I got a lot of inspiration from Shubman Gill when he scored his 100 and 200. He kept at it and took it forward," Vaibhav Suryavanshi said after his century."I could have batted for longer. There were still 20 overs left in the



match. I could have played a longer innings. I got out to a shot that I was not able to execute 100 per cent, but I wanted to bat long like him," he added.There is no celebration. I will just be happy that I was able to do well for the team. My next goal will be to hit 200 and play a full 50 overs," Vaibhav concluded.

Notably, no one in the recorded history of Youth ODIs has ever scored a double hundred. The record for the highest individual score in a Youth ODI stands at 191, by Sri Lanka's Hasitha Boyagoda. Generational Vaibhav Continues Rise Already regarded as a generational talent,

Suryavanshi's latest feat only adds to the growing list of records he's been collecting. Earlier this year, the teenager had burst onto the national spotlight when he became the youngest player to score a T20 century and the fastest Indian to reach a hundred in the IPL.Representing Rajasthan Royals, he lit up the stage with a jaw-dropping 35-ball century against Gujarat Titans, immediately making headlines and catching the eye of fans and legends alike.On Friday, Suryavanshi opened the innings alongside skipper Ayush Mhatre after England opted to bowl first. Things looked bleak for India early on when Mhatre was dismissed for just 5 by James Minto in the fourth over, with the scoreboard reading 14/1. But Suryavanshi held firm, calm, composed, and already brimming with confidence after scoring 86 in the previous match.What followed was a breathtaking display of fearless batting. The young opener reached his hundred in just 52 balls, going on to score a remarkable 143 off 78 deliveries. His innings featured 13 boundaries and 10 sixes.

England becomes first reigning champion to lose a Women's Euro opener

Collecting the ball near the right flank, he ghosted past five Montreal defenders in trademark fashion, weaving into the box with a combination of balance, control, and agility that left the home side frozen. Despite briefly losing control, Messi recovered quickly to smash a rising shot into the top right corner - a finish reminiscent of his prime years.Segovia added to Montreal's misery in the 60th minute with a piledriver from outside the box that kissed the underside of the crossbar before bouncing in, extending Miami's lead to 3-1.Then came Messi's second. Picking the ball up near midfield, he again slalomed forward, shrugging off pressure before slipping into the box. A moment of chaos saw him lose the ball temporarily, but he was quickest to react, smashing the loose ball high into the net for his brace and sealing a dominant 4-1 win for Miami.With this performance, Messi not only led his side to a third straight league victory but also delivered a highlight-reel moment that reignited comparisons to his younger self. At 38, Ankara Messi lives on - not in Barcelona blue, but in Miami pink.

Djokovic's daughter wins hearts after imitating father's special celebration

Novak Djokovic introduced a special celebration after winning his third-round match at Wimbledon 2025 - a moment that was sweetly echoed by his daughter Tara, who imitated the move from the stands.

On Saturday, July 5, Djokovic defeated his Serbian compatriot Miomir Kecmanovic 6-3, 6-0, 6-4 in just an hour and 47 minutes and advanced to the fourth round of the championships.With the win, Djokovic became only the third player in history - after Roger Federer and Martina Navratilova - to reach 100 match victories at the prestigious grass-court major.Following the win, Djokovic celebrated by pumping his fists downward, a gesture that caught the crowd's attention. During his on-court interview, he was asked about the meaning behind this new celebration."It's called 'pumpa' in our language (Serbian) and 'pump it up' in English," Djokovic said about the



celebration.The cameras then panned to Tara in the stands, where she mimicked her father's celebration, drawing loud cheers from the crowd at the All England Club.Djokovic dominates Kecmanovic

After an evenly contested start, with the score level at 3-3 in the opening set, Djokovic quickly shifted into another gear. From that point on, he dominated proceedings, reeling off nine straight games in a commanding stretch.The gap in experience and execution was evident, as Djokovic fired 60 winners - a staggering 42 more than Kecmanovic - making the difference clear and sealing a comfortable victory."I am very grateful, privileged to be in the position that I am. I have said it many times. Tennis made me who I am. It has given me things in life that I can experience. I try not to take anything for granted, particularly at this age. I'm still going strong, trying to compete with the young players and do some slides and some splits on the court," Djokovic said in the on-court interview.Up next, Djokovic will face Australia's Alex de Minaur in the fourth round. De Minaur booked his spot by defeating Denmark's August Holmgren 6-4, 7-6 (5), 6-3 on Court 2.Djokovic is chasing history on multiple fronts at Wimbledon 2025.
