# Public Stands Firm with PM Modi & HM Amit Shah Amid Online Attacks

In recent days, a series of provocative and highly controversial videos featuring former Rajya Sabha MP Dr. Subramanian Swamy have surfaced across social media platforms, attempting to malign the Prime Minister Narendra Modi and Union Home Minister Shri Amit Shah. These videos, widely circulated online, make sensational claims that border on defamation, dragging India's top leadership into baseless allegations involving foreign policy, judiciary, and personal character.

While freedom of speech is an essential pillar of democracy, what is currently unfolding appears to be a deliberate, orchestrated campaign aimed at character assassination, cleverly framed under the guise of "political analysis." In several clips, Dr. Swamy uses innuendo and insinuation to link the Prime Minister and the Home Minister with serious matters including the Justice Loya case and

India's diplomatic dealings with the USA and China—without offering any credible evidence.

Such statements, coming from a veteran political figure, have caused immense damage in the public domain. Social media algorithms have amplified these videos, fueling misinformation, confusion, and unrest, especially among the youth and the international diaspora who rely heavily on digital platforms for news consumption.

Despite these developments, no official response has yet come from the Government, and central investigative agencies have not summoned Dr. Swamy for questioning. This silence is being misused by mischief-makers to present the allegations as factual, potentially eroding public trust in democratic institutions and the leadership that commands overwhelming national and international respect. It must be noted that Prime Minister Narendra Modi and Home Minister Amit Shah have led India through some of its most

challenging times with unmatched vision, courage, and nationalistic conviction. From abrogating Article 370 to managing national security, from strengthening India's global standing to decisive internal policy reforms, their leadership has been both transformative and historic.

Modi, in particular, has become a symbol of clean governance and personal integrity. His mantra of "Na khaunga, na khane dunga" has resonated widely with the masses. Similarly, Amit Shah's unflinching stand against terrorism, organized crime, and separatist elements has reinforced public confidence in India's internal security.

In light of this escalating online defamation, it is imperative that the Government of India issues a clear official statement addressing these allegations. **8 dead, 20 injured as bus overturns in Punjab's Hoshiarpur**

Eight people were killed and nearly 20 others injured in a tragic bus accident near Sagra Adda on the Dasuya-Hajipur Road in Hoshiarpur district on Sunday.

According to initial reports, the bus was travelling through the Dasuya subdivision when it overturned in the middle of the road after the driver allegedly lost control. Local authorities and rescue teams rushed to the scene and began immediate relief operations.

**Suspicious boat, likely from Pak, spotted off Maharashtra coast; state on alert**

Security along the coastline in Maharashtra's Raigad district was stepped up after a suspicious boat was spotted near the Revdanda coast, police said on Sunday.

The boat was seen by security personnel around two nautical miles off the Korlai coast in Revdanda, an official was quoted by news agency as saying. It is suspected that the boat had Pakistani markings and some people had disembarked from the vessel, which may have drifted to the coast. Following the alert, teams from Raigad Police, Bomb Detection and Disposal Squad (BDDS), Quick Response Team (QRT), the Navy and the Coast Guard rushed to the spot.

A search operation began at night and authorities were able to notice a red light coming from the boat. A blockade was done in various places at night.

## Race for Power Begins: Hustle at Delhi Gurudwara Election Office as Polls Near

A sudden surge of activity has gripped the Delhi Gurudwara Election Office at ITO, indicating that the much-anticipated Delhi Sikh Gurudwara Management Committee (DSGMC) elections may be on the horizon. In recent days, a growing number of Sikh voters and political representatives have been seen gathering at the election office to verify names on the voter list, update records, and monitor preparations.

Sources within the office have confirmed that various Akali factions and politically backed Sikh groups are regularly visiting the office, holding discussions with election officials, and scrutinizing electoral rolls. The

momentum points clearly toward the beginning of election groundwork, which is traditionally followed by months of intense campaigning across Delhi's Sikh community.

Notably, the staff at the Gurudwara Election Office has become increasingly vigilant and active, reportedly working extended hours to ensure the completion of the voter list. The Delhi Government, under whose jurisdiction the election office operates, is also closely supervising the process, signaling the seriousness and administrative readiness for the upcoming polls.

The Delhi Gurudwara Election Office, located at ITO, New Delhi, is the nerve center of electoral activities for the DSGMC—a

statutory body responsible for managing Sikh Gurudwaras in Delhi under the Delhi Sikh Gurdwaras Act, 1971. This office is tasked with maintaining voter rolls, coordinating election logistics, and ensuring free and fair conduct of elections for 46 constituencies across Delhi.

Historically, the DSGMC elections have seen intense political rivalry, primarily between factions of the Shiromani Akali Dal (SAD Badal), Shiromani Akali Dal Delhi (SAD Delhi), and newly emerging Sikh political fronts. These elections are not just about Gurudwara management, but are often seen as a reflection of the broader socio-political currents within the Sikh community of Delhi. — **News continue page 02**

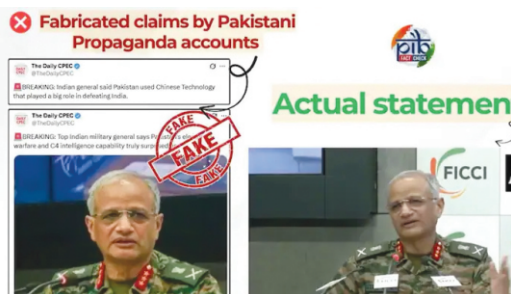

## Did Army general admit India's defeat to Pakistan? Centre's one-word clarification

The Press Information Bureau (PIB) has dismissed as fake a claim being pushed by several Pakistani propaganda accounts, which alleged that India's Deputy Chief of Army Staff, Lt Gen Rahul R Singh,



confessed to a 'defeat' at the hands of Pakistan's electronic warfare and Chinese C4 intelligence systems in the recent conflict between New Delhi and Islamabad.

The false claim was circulated with a photograph of Lt Gen Singh, alongside quotes attributed to him such as: "Pakistan's electronic warfare and C4 intelligence capability truly surprised us, and Chinese

technology played a big role in defeating India".

Other posts labelled 'breaking' repeated similar lines, claiming an Indian general had admitted that Chinese technology was instrumental in Pakistan's so-called victory.

One account even declared: "Top Indian military general says Pakistan's electronic warfare and C4 intelligence capability truly surprised us". Many of these posts linked the alleged remarks to Operation Sindoor, amplifying the narrative across multiple social media platforms.

Countering these viral posts, PIB issued a fact-check clarifying that Lt Gen Singh never made any such statement and termed the quotes "completely baseless". The bureau stated: "Pakistani propaganda accounts are claiming that Deputy Chief of Army Staff, Lt Gen Rahul R Singh has said 'Pakistan's electronic warfare and C4 intelligence capability truly surprised us, and Chinese technology played a big role in defeating India'. These claims are Fake! No such statement has been made by the Deputy Chief of Army Staff".

## 78 dead in Himachal, landslide alert in Uttarakhand as heavy rain continues

- **Torrential rains cause damage in Himachal Pradesh and Uttarakhand**
- **Himachal has reported 78 deaths since the start of the season**
- **In Uttarakhand, 21 lives were lost in rain-related incidents**

Torrential rain has battered the hill states of Himachal Pradesh and Uttarakhand over the past two days, leading to widespread damage, disruption and loss of life. The India Meteorological Department (IMD) has issued orange and yellow alerts for several districts in both states, warning of continued heavy rainfall and the risk of landslides and flash floods.

Overflowing rivers, broken roads and collapsed bridges have left hundreds of locals and tourists stranded, as the monsoon intensifies across the Himalayan region. Both states have activated emergency response teams and rescue operations are ongoing. Authorities have urged residents

and visitors to stay away from landslide-prone zones.

In Himachal Pradesh, at least 14 cloudburst incidents and 3 flash floods have been reported in recent days. Mandi district remains the worst affected, where 14 people have died, 5 have been injured and 30 others are still missing. With these latest fatalities, the state's monsoon death toll has risen to 78 since the start of the season.

Meanwhile, in Uttarakhand, natural disasters since June 1, 2025, have claimed 21 lives, left 11 injured and 9 people (from Uttarkashi) are still missing. The most severely affected districts are Uttarkashi (8 deaths), Chamoli (4), Rudrapur (3) and Dehradun (3).

# Nitin Gadkari Flags 'World War' Threat Citing Israel-Iran, Russia-Ukraine

Coordination, harmony and love are vanishing due to the authoritarianism and dictatorship of superpowers and there is an atmosphere of conflict across the world, Union minister Nitin Gadkari said on Sunday while citing the Russia-Ukraine and Israel-Iran wars.

Hailing India as the land of the Buddha giving the message of truth, non-violence and peace to the world, Mr Gadkari emphasised the need to ascertain future policy after reviewing and deliberating on international happenings underway.

Speaking at the launch of the book 'Beyond



Borders' here, the Union Minister of Road Transport and Highways said these conflicts are

creating a situation where World War could break out "anytime".

The technological advancements pertaining to war were also making it tougher to protect humanity, he asserted. "There is an atmosphere of conflict going on across the world amid the war between Israel and Iran as well as Russia and Ukraine. The situation is such that there is possibility of a World War taking place anytime in the backdrop of these two ongoing wars," Mr

Gadkari said.

Mr Gadkari said warfare dimensions have changed due to advanced technology, with increasing use of missiles and drones, which was reducing the relevance of tanks and other kind of aircraft.

"Amid all this, it has become difficult to protect humanity. Often, missiles are fired on civilian settlements. This has created a serious problem and there is need to discuss all these issues at a global level," the senior BJP leader said.

"It won't be right to say so but (fact is) all this is slowly leading to destruction. Authoritarianism and dictatorship (adhiakarwadi-hukumshahi) of the superpowers is making coordination, harmony and love vanish," he opined.



# Scenic charm of Kerala's Kuttanad 'captures' new horizons

The serene backwaters of Alappuzha and Kuttanad, once known only to local fishermen and farmers, are today a global tourist attraction. With its coconut groves, glittering lakes and lagoons, and waterlogged paddy fields, Kuttanad has long been a treasure trove of scenic wonders. Its pristine charm had attracted filmmakers since the 1990s, and over 200 movies in various languages have employed its captivating backdrops. But, the visual charm of Kuttanad has not been limited to the silver screen. The rise of drone technology and social media platforms offered new ways to capture and share the region's breathtaking landscapes. The entry of Charly K C, an event photographer-turned-visual storyteller of the state's backwaters, has further enhanced the scene.



The 40-year-old Muhamma resident's efforts have played a role in providing a new perspective to Kerala's natural beauty. Charly's journey began with a passion for photography. "I started out capturing weddings and other

events," he recalls. "In 2014, I began sharing my work on social media. Later, I bought a drone camera and focused on capturing the natural beauty of Alappuzha, especially the backwaters and beaches." Since then, Charly has shot more than 500 photographs, many of which have gone viral online. From aerial views of Pathiramanal Island to the quaint village roads of Kainakari and the mesmerising sights of 'islands' created by flooded paddy fields, his lens capture the poetic beauty of Kuttanad in stunning detail. "Every village, every flooded paddy field has a story," says Charly. "I try to show how nature and life coexist in this unique landscape."

But Charly's work isn't just artistic, it's entrepreneurial. "Social media platforms like Facebook and Instagram offer revenue for popular posts," he says. "That has allowed me to invest more, expand my horizons, and even travel to other states. I've now started posting 360-degree photographs as well, and every image gets over 50,000 views on average."

Charly's success reflects a broader trend where passion, technology and social media converge to empower individual creators and promote regional tourism.

## US records 85 unaccompanied Indian minors since Oct last year

The dangerous trend of illegal movement into the US border involving children continues. As many as 85 Indian minors aged between 12 and 17 years, including from Gujarat, were found without accompanying adults at the border during the current US financial year (Oct 1, 2024 to Sept 30, 2025), according to data from the US Customs and Border Protection (CBP). Although this number shows a marked 65% drop from the 240 in the 2024 financial year, it highlights that families from India, including from the state, continue to take risks to get into the US, often using children first as a "strategy" to get a foothold in the country. Overall, in US FY 2025, 26,744 children from various countries were found unaccompanied at the US border against 83,020 in FY2024, a marked 68% decrease. The trend corresponds with a fall in overall illegal immigration numbers after the change in federal policy following Donald Trump's return to office. The monthly data for FY2025 shows fluctuations: 24 children were found in Oct 2024, 18 in Nov, 13 in Dec, 17 in Jan 2025, four in Feb, two in March, one in April, and six in May. Sources in Indian central agencies and individuals with knowledge of human smuggling operations stated that these patterns indicate a deliberate strategy. "Families are sending children first to get a foothold in the US," said one source. "Once the children are taken into custody and placed in shelters, the parents later attempt to enter the US under family or humanitarian grounds." Another source added, "In many cases, adults pretend to be guardians of the children. This method is being used to gain entry while bypassing legal scrutiny." In a case reported in May, two Gujarati children aged 14 and 10 died while attempting to cross the US border in a boat. Their parents, who were injured in the incident, were trying to enter the country along with about a dozen others. "They were with their parents and still died — imagine the situation of children who are entering alone," said a person connected to smuggling network.

# 91 per cent of TN cops think ‘custodial torture’ sometimes necessary: Report

**Status of Policing in India Report 2025 shows that state police have higher propensity to resort to extra-judicial methods than most surveyed states**

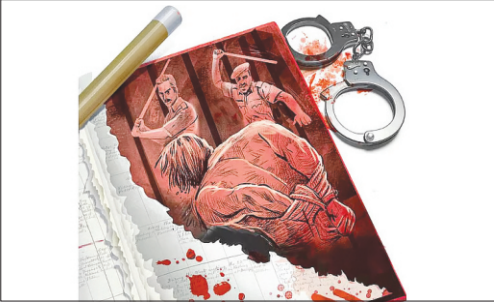
Ninety-one per cent of the police personnel in Tamil Nadu are likely to "highly or moderately" support the view that "custodial torture is sometimes necessary and acceptable to gain information" during investigation, as per the Status of Policing in India Report (SPIR) 2025 compiled based on detailed interviews with 8,276 cops of different ranks from 16 states and Delhi. In the wake of the recent alleged custodial killing of B Ajithkumar (27) in Sivaganga district, the report, brought out by Lokniti - Centre for the Study of Developing Societies in collaboration with Common Cause on March 31, showed that TN police

have higher propensity to resort to extra-judicial methods than most other states.

91% of cops in TN who "highly (56%) or moderately (35%)" support custodial torture sometimes were the highest, followed by Rajasthan (90%). The remaining nine per cent in TN expressed "low or very low" support. However, in terms of those who "highly" supported this view, TN ranked second (56%) after Gujarat (63%).

**Kerala supports lawful policing**

As per the report, Gujarat performed poorly on most parameters, while Kerala was at the other end of the



spectrum, with interviewees there more inclined to follow legal procedures.

For instance, only 11% of cops in Kerala expressed "high or moderate" support to torture. TN cops (87%) found "special squads that can detain people indefinitely"

to be "very" or "somewhat" useful as a measure to reduce crime. It was one such "special team" that allegedly tortured Ajithkumar, leading to his death.

After the incident, Director General of Police/Head of Police Force Shankar Jiwal ordered for disbanding any such special teams, unless approved by the zonal IGs or the Commissioners of Police (for cities).

In TN, 45% of police felt it was more important to solve a case "by any means rather than strictly following legal procedures", while 53% felt it was always important to follow the legal procedures. (The rest two per cent did not respond to this question).

## New Erode-Bihar express to give guest workers respite from overcrowded trains

In the wake of increasing complaints about guest workers occupying reserved coaches in northbound express trains, the Railway Board has approved a new daily train service from Jogbani, a border town in Bihar's Araria district on the India-Nepal border, to Erode. Jogbani is located approximately 380 km from Kathmandu. Prime Minister Narendra Modi will flag off the new train service soon from Bihar, where the assembly elections are scheduled to take place in October or November this year.

The railways decision comes following criticism over the reallocation of an Amrit Bharat rake, originally intended for Southern Railway, to another zone. That rake was initially proposed for a long-distance train connecting Tamil Nadu with West Bengal or Bihar.

Bihar BJP Lok Sabha member Pradeep

Kumar Singh and former deputy chief minister and MLA Tarkishore Prasad shared the train's approval on their 'X' (formerly Twitter) accounts. Tarkishore Prasad said Railway Minister Ashwini Vaishnaw conveyed the information over a phone call.

According to sources, the new train is aimed at providing daily travel options for a large number of guest workers from Bihar, Jharkhand and other states, employed in textile hubs like Tiruppur and surrounding areas. Due to inadequate train facilities, these workers often occupy reserved coaches of express trains heading to northern parts of the country.

The train is expected to pass through Bihar, UP, Madhya Pradesh, Maharashtra, Karnataka, Kerala, and TN. Southern Railway officials said they are yet to receive official communication regarding the train.



## Orange alert issued for Navsari and Valsad; 40 people relocated to safer areas in Surat

**Dolvan in Tapi received the highest amount of rain at 155 mm (6.1 inch) and Bardoli in Surat at 125 mm up to 6 pm on Sunday**

Ahmedabad . (Agency)

At least 40 people were relocated to safer areas in Surat district's Bardoli taluka, bringing the total relocations in the state to 3,703 since June 1 till Sunday even as heavy rain continues to lash Gujarat. The India Meteorological Department (IMD) has issued a forecast of very heavy rainfall warning for Navsari and Valsad, for Monday, putting these two districts under an orange alert. The state is expected to receive heavy rainfall till July 11, according to IMD. Dolvan in Tapi received the highest amount of rain at 155 mm (6.1 inch) and Bardoli in Surat at 125 mm up to 6 pm on Sunday. Surat, Tapi, Dang, Navsari ,



Bhavnagar, Amreli and Botad districts continued to receive heavy rain on Sunday.

"The entire Surat district has been on alert for a day. Nearly 40 people were relocated on Sunday," Surat Collector Dr Sourabh Pardhi told The Indian Express.

As per the State Emergency Operations Centre (SEOC), Vyara and Dolvan in Tapi

recorded 141 mm and 135 mm, respectively while Palsana in Surat recorded 125 mm and Kaprada in Valsad recorded 123 mm within the last 24 hours ending Sunday evening. In the last 24 hours till Sunday evening, Bhiloda in Aravalli received 167 mmm (6.6 inch) rain even as 204 talukas of 33 districts received an average of 26.65 mm rain.

Ahmedabad city also received continuous rainfall, recording an average of 26 mm, starting Sunday afternoon till late evening. Till July 10, the IMD has also issued a warning against light thunderstorms accompanied by lightning and surface wind 30-40 kmph and, with light to moderate rain across the state.

# Rooted in tradition & collective well-being, Abraham's 'Oor' promotes 'healthy ageing'

**As a concept founded eight years ago, 'Oor' focuses on the collective well-being of the elderly.**

In the heart of Central Travancore, where the challenges posed to senior citizens by the younger generation's migration boom are becoming more evident, a middle-aged man has returned to his hometown and crafted a compassionate response to the growing concern of elderly care.

Junking the idea of old-age homes, Abraham P Kurien aka Biju, a resident of Mallappally, in Pathanamthitta, has created a lifeline for the elderly by establishing a unique support network based on his social entrepreneurship venture 'Oor'.

"Oor is not an old-age home. It's a temporary retreat that promotes healthy ageing while allowing seniors to stay in their own homes with dignity," says Abraham. "Older people don't like to leave their homes. That's why we've built a support network around them," he adds.

As a concept founded eight years ago, 'Oor' focuses on the collective well-being of the elderly. It functions out of a building in Mallappally that is truly exceptional, in that it

was accomplished without altering the lay of the land. Moreover, the entire construction employed only reused materials.

According to Abraham, who worked for an NGO in Delhi for three decades, the construction used repurposed materials from 24 old buildings, including houses, schools, hospitals, and churches. He acquired and dismantled 16 of the structures, while sourcing materials from the rest. The wood for the three-storey building, spanning an area of 12,000 sqft, was sourced from several tharavadu (heritage mansions), some dating back 900 years. The entire structure blends traditional elegance with modern functionality.

The building was designed by architect R D Padma Kumar, a close associate of the late Laurie Baker, and executed by the Kottayam unit of the Centre of Science and Technology for Rural Development (Costford). Notably, it also features remnants from the first goods shed at Kottayam railway station and Kottayam KSRTC's first building. The project also serves as a venue for community

gatherings, residential programmes, and cultural events.

Abraham and his team of 12 provide a range of



services tailored to meet the needs of senior citizens. Their offerings include food delivery from their kitchen and an ayurveda health facility. It also provides temporary accommodation for elderly parents whose families may be away for work or other commitments.

Hundreds of homes within an 8km radius receive their service. Abraham's team assists seniors in availing laboratory facilities, arranging medical services and even coordinating transportation for medical appointments. Oor also offers accommodation for NRIs and foreigners, with daily stay packages for two people ranging from ₹2,750-3,750. Meals can also be pre-ordered and delivered to homes for special events and functions. Through Oor, Abraham has created a sustainable living space and a vibrant community hub deeply rooted in tradition, care, and collective well-being.

# CM expresses concern over annual fatalities due to lightning strikes in the state

Lucknow: Indian Space Research Organisation (ISRO) Chairman and Secretary, Department of Space, Government of India, Dr V. Narayanan, met Chief Minister Yogi Adityanath at latter's official residence on Monday and discussed a range of strategic issues, including the potential use of remote sensing technologies in Uttar Pradesh's development. During the interaction, the ISRO chairman briefed the Chief Minister on the progress and achievements made in the field of remote sensing. He shared that significant advancements have been made in areas such as weather forecasting, forest and green cover monitoring, ground-water profiling, mapping, and climate change analyses. Expressing serious concern over the recurring loss of lives due to lightning strikes in Uttar Pradesh, Chief Minister Yogi Adityanath proposed the develop-

ment of a dedicated satellite for the state. He suggested that such a satellite could be equipped to

provide timely alerts specifically related to lightning activity. The Chief Minister noted that, on average, around 300 people lose their lives each year in the state due to lightning strikes. In this context, cutting-edge satellite

Responding to the proposal, ISRO Chairman Dr Narayanan assured the Chief Minister that the matter would be taken up with due seriousness and that steps would be initiated to find a viable and timely solution.

## CEO issues show cause notice to inactive parties

New Delhi: Delhi's Chief Electoral Officer (CEO) has issued show cause notice to 27 inactive political parties following the Election Commission's directions, seeking an explanation for their continued registration. These notices have been issued to the political parties that have not fielded any candidates in Lok Sabha, State Assembly or by-elections during the last six years (since 2019), according to a statement by CEO. According to the CEO, although these parties are registered under Section 29A of the Representation of the People Act, 1951, they have not participated in any electoral activities in recent years, suggesting that they are no longer functioning as per the provisions of the Act. Hence, under Article 324 of the Constitution of India and Section 29A of the RP Act, 1951, the EC has initiated the process to delist such parties from the list of registered political parties. Akhil Bhartiya Samajwadi Party, Akhil Bharatiya Aalki Apni Party, All India Jan Congress Party, All India Women United Party, Azad Bharat Congress, Bhartiya Rozgar Party, Bhartiya Vikas Party, Bhartiya Janata Vikas Party, Bundelkhand Congress, Delhi Mazdoor Kushan Party, Jan Andolan Morcha are among the 27 political parties that have been issued notices by the CEO's office. The CEO has urged all concerned parties to submit their response within the stipulated time, clarifying why their names should not be removed from the list.

## Health Minister Arti Singh Rao hears public grievances, directs swift action on complaints

Chandigarh: Haryana's Health and Family Welfare Minister Arti Singh Rao organized a public hearing at her official residence in Chandigarh on Monday. During this, hundreds of people from various districts of the state put forth their problems and demands before the minister. Arti Singh Rao listened to each complainant seriously and directed the concerned departments to take immediate action. Most of the complaints in the public hearing were related to health services, absence of doctors, supply of medicines, and personal medical assistance. The minister redressed many complaints on the spot and gave clear instructions to the officials that no officer or employee should be negligent in public interest works. # NFR Strengthens Safety Measures for Monsoon Operations

Maligaon, 7th July: The Northeast Frontier Railway (NFR) has implemented a series of strategic preparedness measures to ensure safe and uninterrupted train operations during the monsoon season. Given the region's susceptibility to heavy rainfall, landslides and flooding, stationary watchmen have been strategically deployed at vulnerable locations to continuously monitor track conditions and raise immediate alerts if any danger is detected. Washout-prone and flood-sensitive areas have been reinforced through embankment strengthening, improved drainage systems and clearing of natural water flow channels. In addition, water level measuring gauges have been installed at critical points, particularly in hill sections, to monitor rising water levels in real time. To enable swift response during emergencies, NFR has stationed relief materials such as boulders, sandbags and wire mesh at key locations. 'Emergency on Wheels' trains are fully equipped and kept ready with technical staff and essential tools to respond promptly to any situation. Rapid Response Teams have also been constituted across all divisions to address incidents such as landslides, track washouts

and waterlogging with minimal delay. These teams are trained to restore nor-

strategic locations such as Jagiroad, Khatkhathi, Shokhuvi, Maibong, and



mal operations quickly, minimizing disruption to passenger and freight services. A total of 197 wagons loaded with boulders and quarry/dust/shingle have been positioned in Lumding Division alone, with 144 wagons of boulders and 53 wagons of quarry/dust/shingle at

Badarpur. Other divisions like Tinsukia (52 wagons), Rangiya (36 wagons), Alipurduar (20 wagons) and Katihar (40 wagons) have also been supplied as per monsoon preparedness scale. In addition, various capacities of Winch Crabs, Jacks, Tifors and Tripods are available across all divisions ensuring readiness for rescue or recovery operations. Furthermore, NFR is working closely with the India Meteorological Department (IMD) to receive real-time weather alerts and forecasts. This coordination helps railway control rooms, which are operational 24x7, to make proactive decisions regarding train movements and field deployment. Passengers are advised to stay updated through official communication channels and cooperate with railway authorities. With these comprehensive measures in place, NFR remains fully committed to ensuring safety, operational efficiency and passenger convenience throughout the monsoon season.

# Five arrested for cheating man of Rs 57 lakh in Cryptocurrency scam

New Delhi: The Delhi Police have arrested five people for allegedly cheating a man of Rs. 57 lakh in the name of a cryptocurrency deal which promised a transaction involving a popular digital currency, but the accused vanished with his money without completing the transfer, police said on Thursday. As per police, with the arrest of the accused, police successfully recovered the entire Rs. 57 lakh in cash. The arrested individuals have been identified as Praveen Kumar (40), Nitin Sharma (33), and Rakesh Kumar Dutta (46), all from Punjab; Ajay

Chaudhary (32) from Noida; and Anmol (23) from Panipat in Haryana. Police also seized an SUV and two scooters used by the gang during the commission of the crime. The case came to light when the complainant approached Karol Bagh Police Station on June 30, reporting that he had been cheated of Rs. 57 lakh by a group of men who had promised to deliver him cryptocurrency, specifically a stablecoin known as Tether (USDT). According to police, the victim had met two of the accused — Ajay and Anmol — and was taken to a rented

office for the transaction. Believing everything to be genuine, the complainant handed over ₹57 lakh in cash to them at the venue. Once the money was handed over, another accused named Shivam, along with his associates, made excuses and quietly left the place without transferring the cryptocurrency as promised. Soon after, the entire group became unreachable. Realising he had been duped, the complainant immediately informed the police, following which a case was registered under appropriate sections of cheating and criminal conspiracy. A special investigation team was quickly formed to track down the accused.

"Investigators examined multiple CCTV footage from around the office where the deal took place. The movements of the suspects were closely tracked, and based on several leads, a rented accommodation in Karol Bagh was raided," a senior police officer said. From this hideout, all five accused were apprehended. During interrogation, they confessed to having played different roles in the conspiracy. The entire Rs. 57 lakh in cash was recovered from their possession.

They lured unsuspecting victims by promising to sell them digital currency at discounted or attractive rates. In order to gain their target's trust, the gang would often meet in rented offices, present them-

selves as professional brokers, and make it look like a legitimate business transaction. In this case, too, the complainant was convinced of the authenticity of the deal after meeting the men in what looked like a professional setup. He had no idea that he was walking into a trap.

Ukraine says four killed, more than 30 wounded in Russian strikes

**KYIV. (Agency)**  
Russian strikes killed at least four people and wounded more than 30 others across Ukraine overnight, regional officials said on Monday. Two people died in the Sumy region in the east and one in the Odesa region in the south, Ukraine's state emergency services said in a post on Telegram. One man was killed in the southern Kherson region, according to the regional governor. More than 30 people have also been wounded, most of them in the eastern regions of Kharkiv and Dnipropetrovsk, officials said.  
Russian drones also hit the capital Kyiv in strikes that damaged buildings but did not result in any fatalities, the city's mayor wrote on Telegram. In Russia, the defence ministry said that it had shot down 91 Ukrainian drones overnight, including eight in the Moscow region, with the majority of the rest in regions bordering Ukraine. On Friday Russia carried out its largest drone and missile barrage on Ukraine since it launched its invasion in February 2022, sending 530 drones and around a dozen missiles on Kyiv in an attack that killed at least two people.

Indonesia's Mount Lewotobi Laki Laki volcano erupts, spews 18-kilometre ash tower

**JAKARTA. (Agency)**  
Indonesia's rumbling Mount Lewotobi Laki Laki erupted Monday, sending a column of volcanic materials as high as 18 kilometers (11 miles) into the sky and depositing ash on villages, authorities said.  
This comes just weeks after it caused dozens of flight cancellations to and from the popular resort island of Bali. Mount Lewotobi Laki-Laki, a 1,584-metre-high twin-peaked volcano on the tourist island of Flores, erupted at 11:05 am local time (0305 GMT), the volcanology agency said in a statement.  
"An eruption of Lewotobi Laki-Laki Volcano occurred... with the observed ash column height reaching approximately 18,000 m above the summit," the agency said. It warned of the possibility of hazardous lahar floods, a type of mud or debris flow of volcanic materials, if heavy rain occurs, particularly for communities near rivers. There were no immediate reports of damages or casualties. Geology agency head Muhammad Wafid said in a statement the activity level at the volcano was "very high, marked by explosive eruptions and continuous tremors".  
He also urged residents to stay at least six kilometres (3.7 miles) away from the volcano and to wear face masks to protect themselves from volcanic ash.  
Last month dozens of flights to and from Bali were cancelled after the volcano erupted. Volcanic ash rained down on several communities around the volcano and forced the evacuation of at least one village. Mount Lewotobi Laki-Laki erupted multiple times in November, killing nine people and forcing thousands to evacuate, as well as the cancellation of scores of international flights to Bali.  
There were no immediate reports of cancelled flights after Monday's eruption. Laki-Laki, which means man in Indonesian, is twinned with the calmer but taller 1,703-metre (5,587-foot) volcano named Perempuan, after the Indonesian word for woman. Indonesia, a vast archipelago nation, experiences frequent seismic and volcanic activity due to its position on the Pacific "Ring of Fire".

South Korea's Balloon Crackdown Hits Anti-North Korea Activists

The equipment activist Lee Min-bok uses to send balloons laden with anti-Kim Jong Un leaflets across the border from South Korea unto the North has been gathering dust and cobwebs for months.  
When it became clear that centre-left politician Lee Jae Myung was on track to win the June presidential election, Lee Min-bok was among several South Korea-based activists who stopped their missions, anticipating a crackdown by the new, pro-engagement administration. Lee Jae Myung, a former human rights lawyer, is pushing to ease tensions with Pyongyang and last month said activists should be "severely punished" if they continue the balloon operations that anger North Korea. I've been doing it quietly and what's wrong with that? Provoking North Korea? No way," 67-year-old Lee Min-bok told Reuters as he stood next to a rusting truck equipped with a hydrogen tank for filling balloons.  
"But realistically, look how serious it is right now. Police are out there and if I move, everything will be reported." For years, police have monitored Lee from the home next door - one plainclothes officer told Reuters they are there to protect him from potential North Korean threats - but instead of checking weather reports for ideal balloon launching conditions, Lee now spends his days writing online posts criticising the South Korean government.  
The activists, many of whom are North Korean defectors like Lee, are used to being at the centre of geopolitical tensions. An attempt by a previous liberal president to ban the balloon launches was struck down as unconstitutional. And last year, North Korea began launching waves of its own balloons into the South, some carrying garbage and excrement. Lee, who took office on June 4, has promised to improve relations with the nuclear-armed North, saying tensions with Pyongyang have had a real negative economic impact. He has urged diplomacy and dialogue and his administration has also suspended anti-North Korea loudspeaker broadcasts along the border. North Korean leader Kim Jong Un, however, last year abandoned a goal of unification with the South and has shown little openness to diplomacy. After Lee ordered measures to stop leaflet launches, officials and police discussed plans including deploying police to border regions to preempt launches, and punishing the activists by using regulations such as aviation safety laws, according to the Unification Ministry that handles inter-Korea affairs.

Pakistan building collapse site cleared with 27 dead

**Residents reported hearing cracking sounds shortly before the apartment block crumbled around 10:00 am on Friday in Karachi's impoverished Lyari neighbourhood.**

**KARACHI. (Agency)**  
Pakistan rescuers have concluded a three day-long rescue operation, recovering 27 bodies from a building that collapsed in the mega port city of Karachi, officials said on Monday. Residents reported hearing cracking sounds shortly before the apartment block crumbled around 10:00 am on Friday in Karachi's impoverished Lyari neighbourhood, which was once



plagued by gang violence and considered one of the most dangerous areas in Pakistan. "All the bodies trapped under the debris have been recovered, so the search operation has been called off," the top government

official in the district, Javed Nabi Khoso, told AFP. "The total death toll stands at 27 people." Authorities said the building had been declared unsafe and eviction notices were sent to occupants between 2022 and

2024, but landlords and some residents told AFP they had not received them. Twenty of the victims were Hindus, according to Sundeep Maheshwari, an activist in the minority community. "Most of the families are very poor," he told AFP.  
Government official Khoso said that five out of more than 50 more dangerous buildings in his district have been evacuated since Saturday. "The operation has been initiated and will continue until all such buildings are evacuated," he said. Roof and building collapses are common across Pakistan, mainly because of poor safety standards and shoddy construction materials in the South Asian country of more than 240 million people. But Karachi, home to more than 20 million, is especially notorious for poor construction, illegal extensions, ageing infrastructure, overcrowding, and lax enforcement of building regulations.

Australian woman found guilty of triple murder with toxic mushrooms

**MORWELL. (Agency)**  
An Australian woman murdered her husband's parents and aunt by lacing their beef Wellington lunch with toxic mushrooms, a jury found Monday at the climax of a trial watched around the world. Keen home cook Erin Patterson hosted an intimate meal in July 2023 that started with good-natured banter and earnest prayer -- but ended with three guests dead. Throughout a trial lasting more than two months, Patterson maintained the beef-and-pastry dish was accidentally poisoned with death cap mushrooms, the world's most-lethal fungus. But a 12-person jury on Monday found the 50-year-old guilty of triple murder. She was also found guilty of attempting to murder a fourth guest who survived.  
Family members of the victims declined to speak after the verdict, asking for privacy in a statement issued through police. "We will continue to support them in every way possible following



this decision," police said.  
A lone friend of Patterson appeared overcome with emotion as she left the courthouse through a jostling media pack. "I'm saddened. But it is what it is," she told reporters. The trial has drawn podcasters, film crews and true crime fans to the rural town of Morwell, a sedate hamlet in the state of Victoria better known for prize-winning roses. Newspapers from New York to New Delhi have followed every twist of what many now simply call the "mushroom murders". On July 29, 2023, Patterson set the table for an

intimate family meal at her tree-shaded country property. Her lunch guests that afternoon were Don and Gail Patterson, the elderly parents of her long-estranged husband Simon. Places were also set for Simon's maternal aunt Heather Wilkinson and her husband Ian, a well-known pastor at the local Baptist church. Husband Simon was urged to come but he declined because he felt "uncomfortable". In the background, Patterson's relationship with Simon was starting to turn sour. The pair, still legally married had been fighting over Simon's child support contributions. Patterson forked out for expensive cuts of beef, which she slathered in a duxelles of minced mushrooms and wrapped in pastry to make individual parcels of beef Wellington. Guests said grace before tucking in -- and prayed once more after eating -- with Heather later gushing about the "delicious and beautiful" meal.

New details emerge on Gaza ceasefire proposal as Netanyahu heads to the White House

**DEIR AL-BALAH. (Agency)**  
New details of the Gaza ceasefire proposal emerged on Sunday as Israel sent a negotiating team to Qatar ahead of Prime Minister Benjamin Netanyahu's White House visit for talks toward an agreement. Inside the territory, hospital officials said Israeli airstrikes killed at least 38 Palestinians.  
"There are 20 hostages that are alive, 30 dead. I am determined, we are determined, to bring them all back. And we will also be determined to ensure that Gaza will no longer pose a threat to Israel," Netanyahu said before departing, emphasizing the goal of eliminating Hamas' military and governing power. A person familiar with the negotiations shared with The Associated Press a copy of the latest ceasefire proposal submitted by mediators to Hamas, and its veracity was confirmed by two other people familiar with the document. All three spoke on condition of anonymity



18 dead hostages, Israeli forces would withdraw to a buffer zone along Gaza's borders with Israel and Egypt, and significant amounts of aid would be brought in. The document says the aid would be distributed by United Nations agencies and the Palestinian Red

Crescent. It does not specify what would happen to the Gaza Humanitarian Foundation, the American organization that has distributed food aid since May. Israel wants it to replace the U.N.-coordinated system. A Trump guarantee As in previous ceasefire agreements, Palestinian prisoners held in Israeli facilities would be released in exchange for the hostages, but the number is not yet agreed upon.  
The proposal stops short of guaranteeing a permanent end to the war -- a condition demanded by Hamas -- but says negotiations for a permanent ceasefire would take place during the 60 days. During that time, "President (Donald) Trump guarantees Israel's adherence" to halting military operations, the document says, adding that Trump "will personally announce the ceasefire agreement."

Israel launches airstrikes targeting Yemen's Houthi rebels, and Houthis launch missile at Israel

**DUBAI. (Agency)**  
Israel's military launched airstrikes early Monday targeting ports and facilities held by Yemen's Houthi rebels, with the rebels responding with missile fire targeting Israel. The attacks came after an attack Sunday targeting a Liberian-flagged ship in the Red Sea that caught fire and took on water, later forcing its crew to abandon the vessel. Suspicion for the attack on the Greek-owned bulk carrier Magic Seas immediately fell on the Houthis, particularly as a security firm said bomb-carrying drone boats appeared to hit the ship after it was targeted by small arms and rocket-propelled grenades. The rebels' media reported on the attack but did not claim it. It can take them hours or even days before they acknowledge an assault. A renewed Houthi campaign against shipping could again draw in U.S. and Western forces to the area, particularly after President Donald Trump targeted the rebels in a major airstrike campaign. The ship attack comes at a sensitive moment in the

Middle East, as a possible ceasefire in the Israel-Hamas war hangs in the balance and as Iran weighs whether to restart negotiations over its nuclear program following American airstrikes targeting its most-sensitive atomic sites during an Israeli war against the Islamic Republic. Israeli Prime Minister Benjamin Netanyahu also was traveling to Washington to meet with Trump. Israeli strikes target Houthi-held ports  
The Israeli military said it struck Houthi-held ports at Hodeida, Ras Isa and Salif, as well as the Ras Kanatib power plant.  
"These ports are used by the Houthi terrorist regime to transfer weapons from the Iranian regime, which are employed to carry out terrorist operations against the state of Israel and its allies," the Israeli military said. The Israeli military also said it struck the Galaxy Leader, a vehicle-carrying vessel that the Houthis seized back in November 2023 when they began their attacks in the Red Sea corridor over the Israel-Hamas war. "Houthi forces installed

a radar system on the ship and have been using it to track vessels in the international maritime arena to facilitate further terrorist activities," the Israeli military said. The Bahamas-flagged Galaxy Leader was



affiliated with an Israeli billionaire. It said no Israelis were on board. The ship had been operated by a Japanese firm NYK Line. The Houthis acknowledged the strikes, but offered no damage assessment from the attack. Their military spokesman, Brig. Gen. Yahya Saree, claimed its air defense forces "effectively confronted" the Israelis without offering evidence. Israel has repeatedly attacked Houthi areas in

Yemen, including a naval strike in June. Both Israel and the United States have struck ports in the area in the past -- including an American attack that killed 74 people in April -- but Israel is now acting alone in attacking the rebels as they continue to fire missiles at Israel. Israel's Defense Minister Israel Katz threatened further strikes. "What's true for Iran is true for Yemen," Katz said in a statement. "Anyone who raises a hand against Israel will have it cut off. The Houthis will continue to pay a heavy price for their actions." The Houthis then responded with an apparent missile attack on Israel. The Israeli military said it attempted to intercept the missile, but it appeared to make impact, though there were no immediate reports of injuries. Sirens sounded in the West Bank and along the Dead Sea.  
**Ship attack forces crew to abandon vessel**  
The attack on the Magic Seas, a bulk carrier heading north to Egypt's Suez Canal, happened some 100 kilometers (62 miles).

Death toll in central Texas flash floods rises to 82 as sheriff says 10 campers remain missing

**KERRVILLE. (Agency)**  
Families sifted through waterlogged debris Sunday and stepped inside empty cabins at Camp Mystic, an all-girls summer camp ripped apart by flash floods that washed homes off their foundations and killed at least 82 people in central Texas. Rescuers maneuvering through challenging terrain, high waters and snakes including water moccasins continued their desperate search for the missing, including 10 girls and a counselor from the camp. For the first time since the storms began pounding Texas, Gov. Greg Abbott said there were 41 people confirmed to be unaccounted for across the state and more could be missing. In Kerr County, home to Camp Mystic and other youth camps in the Texas Hill Country, searchers have found the bodies of 68 people, including 28 children, Sheriff Larry Leitha said in the afternoon. He pledged to keep searching in that Hill Country region until "everybody is found" from Friday's flash floods. Four deaths also were reported in Travis County, three in Burnet and 1 in Kendall. Rescuers dealt with broken trees, overturned



cars and muck-filled debris in the difficult task to find survivors. Authorities still have not said how many people were missing beyond the 11 children and a camp counselor from Camp Mystic, a Christian summer camp. Families were allowed to look around the camp Sunday morning while nearby crews operating heavy equipment pulled tree trunks and tangled branches out of the water as they searched along a riverbank. Thunder rumbled from a new storm.  
A woman and a teenage girl, both wearing rubber waders, briefly went inside one of the cabins, which stood next to a pile of soaked mattresses, a storage trunk and clothes. At one point, the pair doubled over, sobbing before they embraced. With each passing hour, the outlook of finding more survivors became even more bleak. Volunteers and some families of the missing who drove to the disaster zone searched the riverbanks despite being asked not to do so. Authorities faced growing questions about whether enough warnings were issued in area long vulnerable to flooding and whether enough preparations were made. The destructive, fast-moving waters rose 26 feet (8 meters) on the river in only 45 minutes before daybreak Friday, washing away homes and vehicles.



## SVPI airport gets bomb threat, turns out to be a hoax

**Ahmedabad. (Agency)**  
The Sardar Vallabhbhai Patel International (SVPI) Airport in the city received a fresh bomb threat email on June 29, prompting immediate activation of security protocols, according to a complaint filed with airport police on Saturday evening. Neelmani Sharma, landside security manager with the Adani group at the airport, is the complainant in the case. According to the FIR, Sharma received the threatening email on the company's official IDs at around 10.23am. The message, sent from the ID roadkillandkyokill@atomicmail.io, stated "powerful explosive devices are hidden inside backpacks placed around the airport", and warned of potential fatalities. The senders signed off as "Roadkill" and "Kyo," claiming responsibility and instructing that the message be circulated to news outlets.

The Airport Bomb Threat Committee convened at 10.45am. By 11.15am, the committee officially declared the email as a non-specific threat after evaluation. Representatives from the Adani group, local police, CISF, IB and airport security participated in the assessment. Bomb Detection and Disposal Squad (BDDS) teams conducted thorough searches across the airport premises, but no suspicious items or explosive materials were found. The sender of the email remains unidentified.

This incident adds to a growing list of such threats targeting the airport. In the past two years, the facility received over 40 bomb threat complaints, including 31 in the current financial year. Most threats came via emails, calls or notes, often causing temporary shutdowns and intense security activity. On Feb 10, 2025, a note reading, "Bomb is here", was found on an Indigo flight from Jeddah. In 2024, a series of email threats were recorded in May and June, one of which claimed bombs were placed near airport washrooms.

The fresh case has surfaced just days after the arrest of Birju Salla, who gained notoreity in 2017 after planting a hijack threat note on a flight. He was the first person to be booked under the stringent Anti-Hijacking Act, 2018. While Salla was acquitted by the high court in 2023 due to lack of evidence, he is presently under scrutiny in two separate threat note cases — one involving a bomb threat on an IndiGo flight from Ahmedabad to Jeddah in Nov 2024 and another targeting the Ahmedabad airport in Jan this year.

## 300-cr bridge to link Coastal Rd at Haji Ali with arterial Parel path

**Mumbai. (Agency)**  
A new elevated road is being proposed to connect Senapati Bapat Marg -- leading towards Phoenix Mills and Kamla Mills -- with the Haji Ali end of Lala Lajpatrai Road, where the coastal road has designated entry and exit points. If it goes as planned, people travelling from the crowded areas of Parel, Dadar, Matunga, and Mahim could



soon reach the coastal road near Haji Ali junction within minutes. The proposed six-lane elevated corridor, currently a missing link in the city's east-west connectivity, will skirt along the edge of Mahalaxmi Racecourse and pass near the NSCI Dome. Officials from the urban development department said the project will not require any land acquisition, nor will it disrupt the existing flow of traffic during construction.

The viaduct will begin near the coastal road's entry/exit on Lala Lajpatrai Road, pass through open areas alongside the race track and stadia, and land near the E Moses Road end of Senapati Bapat Marg. From there, motorists will have seamless access to Gokhale Road, Lady Jamshed Road, Bhavani Shankar Road, NM Joshi Marg, and onward to key locations like Siddhivinayak

# Nipah patient remains in critical care; daughter tests negative

**The state's health department has strengthened its surveillance efforts across three key districts: Malappuram, Palakkad, and Kozhikode.**

**KOZHIKODE. (Agency)**  
A woman from Palakkad who recently tested positive for Nipah virus, remains in critical condition at the Kozhikode Government Medical College Hospital. She is currently receiving critical care in the hospital's specialised Nipah isolation unit. The patient was initially admitted to a private medical facility in Perinthalmanna. However, late on Saturday night, due to a significant deterioration in her health, she was transferred to the Kozhikode Medical College. Her symptoms, consistent with a severe viral infection, first appeared on July 1, prompting her to seek medical attention. Meanwhile, the test results of the woman's 10-year-old daughter has come back negative. The Palakkad district authorities said on Sunday that three people from the patient's primary contact list are under isolation at various hospitals as a precaution. So far, 173 people have been included in the official

contact list. The state's health department has strengthened its surveillance efforts across three key districts: Malappuram, Palakkad, and Kozhikode. These areas are under heightened scrutiny due to the recent travel and contact histories of the infected individuals. An official from the health department informed that at first glance, these two cases appear epidemiologically distinct. The timelines of symptom onset and the potential for a shared social gathering linking them are currently under rigorous investigation.

In response to the evolving situation, the health department has declared an intensified fever surveillance programme across all regions where Nipah cases have been identified. Specialised medical teams and rapid response units have been strategically deployed to actively monitor



individuals on contact lists for any emerging symptoms. Authorities are appealing to the public to maintain composure while remaining highly vigilant. Citizens are urged to promptly report any flu-like symptoms, particularly if they reside in or have visited the monitored zones. The Union health ministry is reportedly considering dispatching the National Joint Outbreak Response Team to Kerala. This team would

provide crucial support to the state government in implementing robust public health interventions.

The Central Surveillance Unit of the Integrated Disease Surveillance Programme, operating under the National Centre for Disease Control, is maintaining close coordination with its state counterpart, actively monitoring the unfolding scenario. Furthermore, the State Control Room has been fully activated to orchestrate and manage a wide range of containment activities.

### Fever surveillance programme

In response to the evolving situation, the health department has declared an intensified fever surveillance programme across all regions where Nipah cases have been identified. Specialised medical teams and rapid response units have been strategically deployed to actively monitor individuals on contact lists.

## Bare truth: 63% of city's roads lack green cover, satellite study reveals

**Ahmedabad. (Agency)**  
Nearly two-thirds (63.4%) of Ahmedabad's 2,670km road network shows very sparse green cover, while nearly a third (28.6%) registers as nearly barren — a reality revealed by a new satellite-based study. This falls well below healthy thresholds for urban areas that desperately need trees along road networks as their first defence against particulate pollution like PM2.5 and PM10.

The study comes just as the Ahmedabad Municipal Corporation (AMC) races to plant saplings under its ambitious Mission Four Million Trees this year. The study not only highlights the urgency for this campaign but also provides a scientific basis to guide it. "But here in this shortfall lies an actionable opportunity," believes Anurag Kandya, associate professor at PDEU's Civil engineering department. At the heart of the research is the Normalized Difference Vegetation Index (NDVI) — a globally recognized metric that quantifies vegetation density on a scale from 0 to 1, with 1 indicating the greenest. The results are eye opening —



Ahmedabad's average NDVI across its road networks stands at just 0.189, far below the healthy threshold for urban greenery.

Nearly two-thirds (63.4%) of the network showed very sparse green cover (NDVI below 0.2), and nearly a third (28.6%) registered as nearly barren (NDVI under 0.1).

The BRTS corridors, which is Ahmedabad's backbone of sustainable transport, are paradoxically among its least green, with 72%

of their length falling under the 0.2 NDVI mark. For Sardar Patel Ring Road, which has the same NDVI, this percentage is 57.6%. However, some roads stand out for their relatively higher green cover. The Godrej Garden City Road leads with a notable NDVI of 0.6, indicating dense vegetation. The 132 Feet Ring Road near the University area follows with an NDVI of 0.4, while the 120 Feet Road in Vasna shows moderate greenery with an NDVI of 0.3. Analyzing over 4.74 lakh data points, each representing a 10x10m pixel from satellite imagery, researchers associate professor Anurag Kandya, Shubham Kela, Viral Patel of PDEU, Gandhinagar, and Ashish Sharma of Discovery Partners Institute, Chicago mapped the city's roads against NDVI scores. "Instead of haphazard planting, our data allows for precise identification of areas most in need of vegetation. Planners can prioritize these 3.05 lakh low-greenness locations for immediate intervention," Kandya said, speaking to from Chicago, where he is presenting the study.

Mango farmers in the district are pleased as prices are starting to rise even as the season is drawing to a close. According to sources, mango trees are grown in 1158.064 hectares in Kanniyakumari district. The district deputy director of horticulture, Y Sheela John told TNIE that at the horticulture farm in Palathottam, 4480 kg of mangoes were harvested generating Rs 2.2L. Last year, only 900 kg were harvested last year season and 4200 kg in the previous year. Popular varieties such as Neelam, Bengalura, Banganapalli, Alphonse, Himahudeen, Jahangeera, Kalapad, Panchavarnam, Rumani, and local varieties such as Panikanadan, Surankudi, Vettaiyan Surankudi were grown in the farm.

T Murugan (62), a mango farmer in Thittuvilai said in the yield has been high this compared to the last 6 to 7 years, which has brought down the prices. Murugan, who has taken the Neelam variety trees on lease, said he did not harvest mangoes due to poor price. "As the mango season is drawing to close, the price is

increasing. Now I am getting Rs 10 per kg whereas earlier it was much less," he said. A mango trader E Ahilan said farmers sold Neelam variety for Rs 10 -Rs 8 per kg before, but the price has increased to Rs 10 -Rs 12 since Friday. Similarly, Banganapalle variety was sold for Rs 20 per kg earlier, but now the



price has increased to around Rs 80. This is because the arrivals is going down, he explained.

# UK team arrives in Kerala to assess F-35 jet after emergency landing; aircraft moved to hangar

**Stealth jet grounded at Thiruvananthapuram since June 14; UK experts to assess recovery or possible dismantling for transport**

**THIRUVANANTHAPURAM. (Agency)**  
A team of British aviation engineers landed in Thiruvananthapuram on Sunday to repair the F-35B stealth fighter jet that has been grounded at the international airport for the past 23 days. The 14-member team arrived aboard a Royal Air Force Airbus A400M Atlas military transport aircraft, carrying specialist equipment. The jet, stranded since June 14 due to a hydraulic system failure, was moved to a designated hangar space provided by Air India. "A UK engineering team has deployed to Thiruvananthapuram International Airport to assess and repair the UK F-35B aircraft, which landed following an emergency diversion," a British High Commission spokesperson said in a statement. The UK has accepted India's offer to use the

Maintenance, Repair and Overhaul (MRO) facility at the airport and is working with relevant authorities to finalise arrangements.

"In line with standard procedure, the aircraft will be moved following the arrival of UK engineers, who are carrying specialist equipment necessary for the movement and repair process," the statement added. The jet had diverted to Thiruvananthapuram due to adverse weather and low fuel, and was cleared to land by the Indian Air Force.

A Royal Navy helicopter had flown in an additional pilot and engineer the next day, but early repair efforts were unsuccessful. Towing the aircraft was deemed too risky, prompting the UK to send a full engineering crew.

Aviation experts say the team faces a major challenge in making the aircraft flight-ready.

"It appears the UK is hoping to carry out essential repairs and attempt a carrier landing with support from their expert maintenance team and specially assigned test pilots," said Wing Commander A Mahesh (Retd.), an aviation analyst. "For the F-35B to return to the carrier, its thrust vectoring system is crucial. And that depends entirely on the hydraulic system, which, by current indications, remains unserviceable. If the jet can't be flown out, Thiruvananthapuram may see another large RAF transport aircraft arriving to lift the F-35B out," he added.

The grounding of a fifth-generation fighter



in a non-NATO country like India has sparked questions in the British parliament. The incident has also drawn wide attention online, with even the Kerala tourism department posting light-hearted content showcasing the state's hospitality.

Since the beginning, India's ministry of defence has played a key role in facilitating the UK crew and aircraft, offering swift clearances and logistical support -- an example of India-UK defence cooperation.

"The UK remains very grateful for the continued support and collaboration of the Indian authorities and airport teams," the High Commission said. The F-35B is part of the UK's Carrier Strike Group aboard HMS Prince of Wales, currently stationed around 100 nautical miles off the Indian coast. The group, which includes HMS Richmond, recently completed a joint PASSEX maritime drill with the Indian Navy, featuring INS Tabar, a submarine, and a P-8I surveillance aircraft.



1965 war, friendships, resolve, and romance

It was the time of war, as it is today, but exactly 60 years back. It was the 1965 India-Pakistan War. The common notion is that it was fought for 22 days in September, but in actuality, the war, initiated by Pakistan, was fought in three parts, all interlinked. There was no casus belli for that war, as it was contrived by Zulfikar Ali Bhutto, then the Foreign Minister of Pakistan, and a few Generals of the Pakistan army, who persuaded a reluctant President Ayub Khan to approve their plans. The Pakistani plan was to commence operations in a less important area like Kutch, with a view to gauge whether India was capable of a fight, as the war with China in 1962 had badly affected the Indian Army. There was also famine in many parts of the country. The then Prime Minister Lal Bahadur Shastri had taken over recently after the death of the colossus Pandit Nehru and in the eyes of the Pakistanis, his diminutive figure did not reflect the boldness of a fighting leader. How utterly wrong they were!

Depending on the outcome of the Kutch operation, Part II consisted of sending infiltrators inside J&K from several directions, as it was assessed that the locals will rise against India. This was to be carried out in August. Finally, an all-out offensive, code-named Operation Gibraltar, would be launched within J&K, to cut off Rajouri-Poonch. It is this part which is known as the 1965 War by the public. As far as the armed forces and the Government of India are concerned, all three parts constituted the 1965 War, the diamond jubilee of which is this year. Let me now switch to my special friend DN. We both had left behind a leg each on the battlefield, before we met at the Command Hospital, Pune. I had reached there first. I belonged to the First Battalion of the Maratha Light Infantry, while DN was a company commander in the equally famous 3 Kumaon (Rifles). We were in Pune as all limb cases were sent there; the Artificial Limb Centre was adjoining the Command Hospital.

DN, or Dharendra Nath Singh, was a very brave officer who had been awarded the coveted Vir Chakra for leading the assault on the important feature Keri in J&K, where he had lost his left leg. He was a Kaushik Rajput but now his battle was in fighting a disability, as it was for us all.

At Pune, we were confined to our beds, but soon the time came, as our wounds healed, that we had to walk with the help of crutches, but first we had to buy slippers. That simple errand sealed our friendship, as in the Bata shop, we realised that we needed not a pair of slippers each, but only one for the time being. Glances exchanged confirmed that our foot sizes were same and since our amputated legs were different, DN's being left and mine being right, our need was for only one pair! In a soldier's career, the watershed events are when one gets shot in battle, fighting for the country. We came to the conclusion that getting the disability was that event for us. DN agreed with me. Later developments confirmed it, but surprisingly not in a negative way.

Those were the days of introspection, interspersed with exchanging notes with our comrades, and surreptitiously slipping out for a couple of drinks at the military club. We were undoubtedly quite a sight, locomoting and balancing ourselves on light-weight elbow crutches, but we learnt to juggle with a drink, a cigarette, crutches and of course the good or undamaged leg! DN was very much a part of these evenings, although he neither smoked nor drank. These were also the days of a happy-go-lucky exterior, cracking jokes about the one-legged Taimur Lang, but with an interior that was all knotted up, constantly weighing various permutations for our future.

In my case, these were also the days of the first slow moves towards a blossoming love, which added some genuineness to the happy exterior and slowly diminished the personal battles being fought internally, mostly in our minds but also slipping down to the guts at times.

I asked myself why I was so moved by the phenomenon of the rise of Zohran Mamdani, despite many reservations about the reckless promises and over-confidence so typical of a young radical. I think it is about how our generation went through all the subsequent phases and came out more and more disillusioned and cynical after the first few decades of Independence. "Bliss was it then to be alive but to be young was very heaven," as Wordsworth said post the French Revolution. A few centuries later, the view he immortalised in 'From Westminster Bridge' that opens with "Earth has nothing more fair to show" is a vista that is poisoned by decline and fear. The church, the family, its splendid welfare state and its outstanding educational institutions have all but vanished, leaving in their wake a society sans ethics and morality, broken homes, deviant youth and a frustrated countryside. I sincerely hope that young Mamdani has it in him to write a new script that is not just the old Anglo-Saxon one, but one that binds the world with threads of humanity and brotherhood.

Policy thrust to grow manufacturing futile sans enhanced skills

There is an urgent need for India to train workforces and develop the skill sets needed for high-end manufacturing. Besides, it is important to build supply chains and encourage domestic component makers for manufacturing to flourish

India's manufacturing sector received a blow with Taiwan-based Foxconn Technology Group asking hundreds of its Chinese technicians working at iPhone production units in India to return home. There is no official word from Foxconn or Apple yet; but if the development is true, it could derail India's ambitions of emerging as a global manufacturing hub. The move comes at the crucial juncture when Apple was planning to ramp up production of its flagship product here, eventually to manufacture all iPhones for the US market in India by 2026. Importantly, the move casts a shadow on the China+1 strategy, under which countries like India and Vietnam are aggressively going after global technology companies to shift production lines and reduce over-reliance on China. As Apple Chief Tim Cook noted earlier, more than the cost advantage, the skill and expertise of Chinese assembly workers is something that cannot be found elsewhere. It means, in the absence of skilled talent that is found in abundance in the services sector, India woefully falls short in manufacturing. So it can only offer a cost



advantage, which can also be found in, say, Vietnam or Indonesia. If China clamps down on the outflow of talent, technology and materials, India's manufacturing growth story will slow down. While building production lines is one aspect, the availability of talent is equally crucial.

There is an urgent need for India to train workforces and develop the skill sets needed for high-end manufacturing. Besides, it is important to build supply chains and encourage domestic component makers for manufacturing to flourish. Though the government made some humble attempts through the Make in India initiative and Production-Linked Incentive scheme, they are evidently not enough to catch up with China. Manufacturing is integral to growth and has the potential to not only create jobs, but also boost exports beyond \$1 trillion by 2030, according to some estimates. But despite efforts such as Make in India and PLI, the manufacturing sector's share of the GDP has been stagnant at about 14-17 percent for a decade now. We need coordinated efforts by both the government and industry to raise the share closer to the government's stated target of 25 percent. That's when India can truly shift away from being an import-dependent economy to a global production hub.

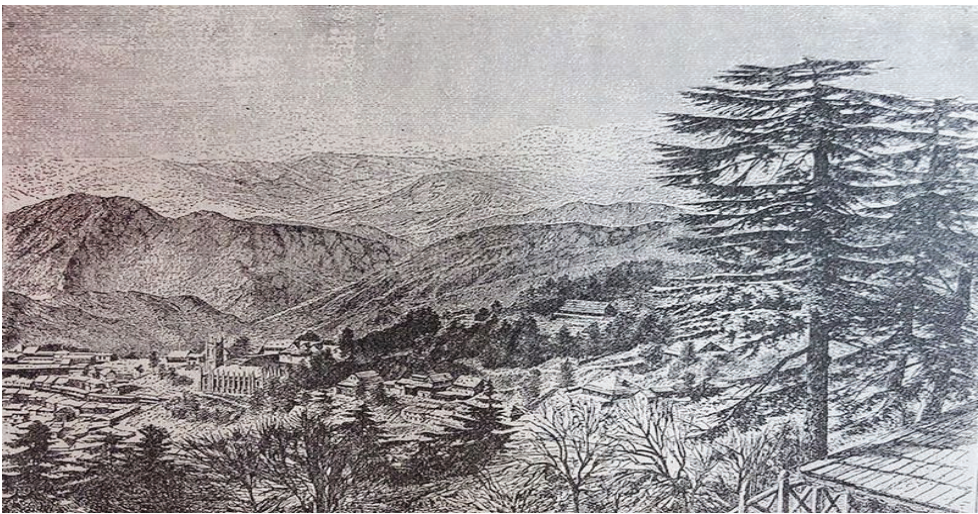
July 1939, and Dhami firing incident that shook the hills

Bad working conditions', exploitation led to revolt

Famine, or even bad food, has led to mutinies and revolts. Marie Antoinette's supposed utterance just before the French Revolution, "Let them eat cake", is historically incorrect. There is no evidence that she said something of the sort to the starving people of Paris. But we still treat this as a piece of history. The statement, howsoever false, makes the inescapable connection between hunger and the desire to remove what seems to be in the way of getting food — and a fair wage. The Naval Mutiny of 1946, which substantially hastened the process of giving India her freedom, stemmed from racial discrimination and bad food. Among other issues, the naval ratings aboard the HMIS Talwar, where the strike began, protested against the rations they were being given with the slogan: "No Food, No Work". Rice, supposedly, came mixed with mud and stones. This strike soon swept across other ships and shore establishments, with approximately 20,000 men involved. In a manner of speaking, this event and numerous others give us evidence that we fought for independence against the "bad working conditions" that existed under colonial rule. Far away from the sea, in the hills of today's Himachal, the freedom movement merged almost imperceptibly with local issues like land revenue and feudal cesses. One of these was the prevalence of 'begaar', which, at its simplest, was unpaid labour. The prevalence of this oppressive institution was substantially responsible for unrest in the hills. 'Begaar' was responsible for numerous revolts about which very little is known.

In the second half of the 19th century and in the first quarter of the 20th, some sort of disturbances occurred in almost all the hill states. These were suppressed with troops from British India and with the help of the Punjab Reserve Police. In the princely state of Dhami, which bordered Shimla, many matters of discontent were similar to other hill states. These, apart from 'begaar', were restrictions on forest rights, on civil liberties and agrarian revenue issues. The matter was precipitated after a road had been built in 1938 between Shimla and Dhami; almost all the labour was of 'begaaris'. Repeated crop failures and the subsequent absence of food security had compelled the common farmers of Dhami to ask for a remission in revenue. Eighty-six years ago, the month of July would have been quite as wet as this one. Four days after the event, The Tribune, then published from Lahore, reported that on July 13, 1939, despite bad weather, around 600 persons from Dhami and other hill states had gathered for a meeting in Shimla. They raised these and other issues. The man who came to head the campaign to redress these matters was Bhag Mal Sautha. Trained as an engineer, Sautha made his living by running the Imperial Hotel in Shimla's Lower Bazaar. He was

the secretary of the Himalaya Riasti Praja Mandal, which was spearheading the freedom struggle and anti-feudal order in the hill states. As part of a wider nationalist strategy, on July 15, 1939, with a large band of people, Sautha moved towards Dhami from Shimla.



Just short of the border, the state police showed Sautha an order that prohibited his entry. He refused to comply and was arrested. The crowd was estimated by the Dhami Durbar to have numbered between 2,000 and 3,000. As they began to move towards the thana, someone in the crowd began to shout that their leader was being taken away to jail and that this should be prevented. Subsequently, a melee ensued and two persons were

killed and 40 injured. Those killed were a man named Durga, who was a resident of Dhami, and Rup Ram, who had been shot in the legs and abandoned once the crowd dispersed; he succumbed to his injuries at the hospital in Sunni (in the state of Bhajji), where he had been taken. An upshot of the Dhami incident was that Sautha was evicted from the Imperial Hotel and all his belongings were thrown out. He was sentenced to three months of rigorous imprisonment and a fine. The event came to be known as the 'Dhami Firing Incident' or 'Dhami Goli Kaand' and its reverberations were felt not only in the hills, but throughout the country. Some went to the extent of drawing parallels with the Jallianwala Bagh massacre. For all its seriousness, and the fact that this incident would accelerate and enlarge the freedom movement in the hills, the moment also had a touch of ironical humour. Among the wounded was a man named Tulsi Ram, who claimed to have been shot by the Rana of Dhami. He refused to be treated by anyone except Pandit Jawaharlal Nehru. It took considerable persuasion to allow the wound to be bandaged; he was then placed in a palanquin and taken to a hospital in Shimla.



# Industrial units with no permits operate in Gurgaon, flouting green norms

Gurgaon: Scores of industrial units are operating in the city without environmental permits as authorities struggle to control unchecked pollution in areas already burdened by sewage overflows and encroachment.

The Haryana State Pollution Control Board (HSPCB) said in a July 2 right to information (RTI) reply that 281 industrial units in Gurgaon have been granted mandatory environmental consent to operate. Activists allege there are hundreds more industrial units that have been functioning without any approvals. These illegal factories are clustered in and around Basai, Kankrola, Badshapur and Dhanwapur. They operate without basic pollution controls such as effluent treatment systems. "Though the official number is 281, ground reality is far more alarming. In areas like Basai and



Kankrola, there are several unauthorised industrial units. These are hotspots of unregulated pollution," said Delhi-based activist Varun Gulati. Most of these units are involved in manufacturing garment and textile, milk packaging, snacks, rubber parts, sealants and synthetic glues. Some of them handle metal scrap, or

dismantle electronic waste too. "Many of these industries are ghost operators that don't follow basic rules like effluent treatment. When complaints are filed, they can't be traced," Gulati, who tracks violations in the district, said.

The unauthorised units often operate in zones not designated for industry or on the

fringes of residential areas, worsening health risks for those living nearby. "Pollution stress in these areas is no longer a hidden issue. It's visible in the water, in the air, and in the rising health risks to nearby communities," said Vivek Kamboj, an environmentalist. Despite multiple complaints, action by pollution control authorities has remained limited to show-cause notices or temporary shutdowns. There is no database to track illegal or unregistered units across the district. "The biggest failure is in enforcement. Pollution control isn't just about paperwork, it's about actually going into these industrial pockets and shutting down operations that poison the environment," said Shubhansh Tiwari, a research associate at the Centre for Science and Environment. Activists demand that district authorities need to carry out ground-level surveys.

## Security heightened as farmers protest land acquisition in Nuh

Security measures were tightened in IMT Rozka Meo area and a riot control drill was conducted at Nuh Police Lines on Sunday amid ongoing farmers' protests over land acquisition and compensation. Prohibitory orders have been clamped in anticipation of the upcoming Jalabhishek Yatra and to prevent any law-and-order disturbances. Farmers from nine villages in Rozka Meo area have been protesting since Feb 2024 over a long-pending land compensation for land acquired for industrial model township. Nuh SP Rajesh Kumar said Section 163 of BNSS (BNSS), 2023 was enforced in the region, prohibiting the assembly of five or more individuals and the carrying of deadly weapons. "This order will remain in force until Aug 4," the SP said.

The restrictions apply to the area acquired by Haryana State Industrial and Infrastructure Development Corporation (HSIIDC) and surrounding zones, including Dhir Dhaunka village and the Rozka Meo police station area. Carrying weapons such as firearms, swords, sticks, spears, axes, knives, chains and other potentially harmful objects is banned — except for the kirpan worn as a religious symbol by Sikhs.

Meanwhile, the SP said on Sunday, "The restrictions are aimed at preventing disruptions to govt development projects and deterring antisocial activities. Govt officials, police personnel and HSIIDC officers are exempted from this order." Duty magistrates have been assigned monitoring responsibilities while the SP warned against any violations or attempts to incite unrest.

In 2010, around 1,600 acres of land were acquired for the IMT Rozka Meo project and the govt paid them Rs 25 lakh per acre. The govt also acquired land from the villages of Chandawali and Machhgar in Faridabad. However, the farmers from these areas filed a petition in court, alleging the govt was buying their land at unfairly low rates. They appealed to the court to direct the govt to increase the compensation amount. In response, the court ordered the govt to pay Rs 2 crore per acre to those farmers. When the farmers from the other nine villages heard about this decision, they too began staging protests, demanding an increase in compensation for their acquired land. After a long struggle, the govt agreed to pay them Rs 46 lakh per acre and got them to sign affidavits to prevent further legal action. Farmers were initially paid Rs 21 lakh each, with a promise of receiving the remaining Rs 25 lakh later. However, that additional compensation has still not been paid. As a result, the farmers of nine village have been staging an indefinite sit-in protest since Feb 2024.

## 'Road dug up, infra deficient': Condo developer faces fire in Gurgaon Sec 44

Tension prevailed in Sector 44 area as several residents of ROF Alante Society in Sector 108 staged a protest outside the builder's office — amid a police presence — demanding basic infrastructure and a vigilance inquiry into the approvals granted to the project on Saturday afternoon. The protesters questioned how the builder was granted a licence and occupancy certificate (OC) despite not having a proper revenue road connection to the site.

"The project was developed under the Haryana govt's affordable housing scheme but the builder has failed to provide the required infrastructure, including a permanent 24-metre access road," Shivani Thusoo, a resident, said. Bouncers at the builder's office allegedly stopped the protesters at the main gate. Soon after, police arrived on the spot and spoke to the residents to understand their concerns. "The current entry road is often dug up or blocked by nearby villagers. We later found that this stretch of land was never owned by the builder and was only taken on rent," Shivani said. "Now, due to the ongoing dispute between the villagers and the builder, the residents are forced to suffer."

A spokesperson for the developer said "miscreants — local landowners — have illegally dug up the govt revenue road" to block society's access, aiming to pressure the company with unlawful demands. "Staffers were even threatened with violence when they tried to intervene. This is causing serious inconvenience and poses a law-and-order issue. Complaints have been filed and the company is working with police and civic authorities to restore access," he said. The spokesperson clarified that internal infrastructure is complete and OC was issued accordingly. "Most residents understand the situation and are not involved in the protest. Legal action is underway against offenders," he added.

## 6 applicants per seat: Surge in UG admissions at Gurugram University this year

**Gurgaon. (Agency)**

Gurugram University (GU) is witnessing a surge in undergraduate (UG) admissions for 2024-25 session, with six students vying for each UG seat. That is double the competition compared to last year when only three applicants competed per seat. GU VC Sanjay Kaushik said the first merit list will be released on July 8. Document verification for selected students will take place on July 9 and fee submission must be completed by July 10. According to university data, the online application window closed on Saturday at midnight, with 2,996 applications received for 450 seats across 10 undergraduate courses. Last year, the university had received 1,350 applications for 410 seats.

Students have shown a marked preference for professional and integrated programmes. The most sought-after courses include Bachelor of Physiotherapy (BPT): 600 applications for 60 seats; MBA (Integrated): 365 applications for 60 seats; LLB: 492 applications for 60 seats; BA (Yoga): 165 applications for 30 seats; BCA (Computer Applications): 178 applications for 60 seats; MCom (Integrated): 295 applications for 60 seats; courses like MSc (Physics) Integrated, BSc and MA (Journalism & Mass Communication) have also seen growing interest.

## Cleaning lags, choked drains cause flooding on roads in Sector 5 after showers

Gurgaon: Monsoon showers have begun lashing the city, but work on cleaning the drains in Sector 5 is still not complete. The slow progress has led to residents raising concerns of waterlogging and road damage. According to residents, work to clean a 7.5km drain network was previously awarded through a Rs 16 lakh tender, but the cleaning only began in late June and is being poorly executed.

Dinesh Vashisth, former RWA president of the sector, noted that the situation is especially bad near the Sector 5 police station. "There are stormwater drains on both sides of the road. Only surface-level cleaning was done—soil was removed from pipe inlets and barely a foot of silt was cleared from inside, while the rest of the drain remains clogged," he said. Vashisth added, "Rainwater now accumulates on the roads, creating serious



trouble for residents. Vehicles struggle to pass, and roads are deteriorating due to stagnant water. The monsoon has already started, and there is no sign that the drains will be cleaned in time. The govt is wasting public money and ignoring public concerns. What's the point of development work if they aren't completed on time or don't serve their purpose?" Residents claim that the civic body failed to act before the monsoon

arrived, and the work currently underway appears rushed and superficial. MG Yadav, another resident, echoed this sentiment, saying, "The drain cleaning work did start, but it wasn't done properly. The silt inside the drains hasn't been removed. Worse, the muck that was taken out was left on the roadside and footpaths, and has now washed back into the drains. Water has no place to go and ends up flooding the streets. We've raised complaints before but there's been no proper response." When contacted, an MCG official said, "The work started on June 22. We are prioritising the cleaning of drain openings and pits considering the ongoing rains. The agency has deployed tractors and is dumping the collected silt. A jetting machine will be used to clear the pipelines. While the timeline is Sept, we are aiming to finish by July-end."

## Water infra crumbles, taps sputter as supply-demand gap widens in Gurgaon Sector 23A

**Gurgaon. (Agency)**

Gurgaon: The water boosting station in Sector 23A, built nearly three decades ago, is struggling to keep up with the area's growing demand, with residents complaining of frequent breakdowns, poor maintenance, and unreliable supply. Despite repeated assurances and multiple estimates prepared for its overhaul by the authorities, no revamp has been undertaken, residents said, adding that critical components of the facility, including electrical panel, cables, valves, and pipeline joints, are in poor condition.

In addition to this, the civic body has not installed standby motors, which means even a minor fault brings the entire system to a halt. Every time a breakdown occurs, it takes 1-2 days to fix the issue, impacting water availability in the area, residents said. Bhawani Shankar Tripathy, vice president of Sector 23A RDWA, said, "A

complete revamp of the station is required. Whenever there is a fault, it affects at least three cycles of water supply in the area. The system is outdated and fails



repeatedly. We have raised complaints but to no avail." Moreover, residents said that water supply to the area is erratic. On some days there is no supply and on others, the water pressure is too low. In many

cases, households are forced to rely on private tankers, adding to their monthly expenses. Now, residents demand that an urgent intervention be made by the civic authorities to upgrade the station and ensure uninterrupted, high-pressure water supply. Neeru Yadav, RWA president of Sector 23A (east zone), said, "The water pressure is extremely low. Water does not reach even in single-storey houses. The station also has also frequent technical issues like motor failures and valve failures, due to which residents are forced to manage using private water tankers."

Meanwhile, Praveen Kumar, executive engineer of MCG, said, "There have been machinery-related faults at the station, but we are attending to them regularly. Additionally, we are making provision for standby motors across all MCG areas. The work has already started, and the standby motor will be deployed here soon."

## Wrong-side driving fuels rise in fatalities in Ghaziabad's Mohan Nagar

Ghaziabad: Declared "one of the black spots" for accidents, Mohan Nagar witnessed the highest accident count last year, resulting in casualties. The area saw 53 accidents, which claimed the lives of 25 people and left 28 others injured, according to a traffic police survey conducted in July 2024. However, the numbers hardly matter to those accustomed to wrong-side driving,

which is rampant on NH9 and nearby roads in Mohan Nagar, particularly during peak morning and evening periods. Auto-rickshaw and two-wheeler drivers — and occasionally truck drivers — seem to take delight in the risk associated with "avoiding" longer routes. During the morning and evening hours, motorists coming from GT Road Mohan Nagar travel towards Arthala, Anand Industrial Area and the Vashundhara

railway underpass because they have to take a U-turn, which is almost 600 metres away. As per traffic police data, from Jan to May, more than 1.1 lakh challans were issued for wrong-side driving. A total of 402,061 challans were issued to two-wheelers, 99,464 challans to four-wheelers and 57,166 challans to three-wheelers for various offences.

A man, who was driving on the wrong side, said that he worked in Sahibabad in a

private company and his house was located in Arthala. "The actual route is located almost 600 metres away near the Hindon area and it takes more than 20 minutes and traffic makes the route worse," he said. A senior police officer said that driving opposite to the traffic direction is among the key reasons for road accidents and fatalities. Police estimate that around 15% of the fatal crashes are because of wrong-side driving. "We are trying to educate people and students so that residents of the city follow the traffic rules for the safety of themselves and others," he said. Meanwhile, the traffic police has started a campaign against wrong-side driving across the district. From June 16, a dedicated drive against wrong-way driving in 80 places across Ghaziabad was launched, and till June 30, a total of 2,578 challans were issued and more than 35 vehicles were seized. Due to the lack of traffic police personnel, people are taking advantage of this and driving the wrong way to their destination for an easy route, to save fuel, energy and money. In 2024, a 35-year-old motor mechanic died while his wife and two children were injured after a car rammed into their scooter in the Indirapuram area.



# ‘Couldn’t stand in front of a pyre for 5 mins, can’t imagine my brother’s plight’: Kin of UPSC aspirant killed in Karol Bagh fire

**Agency New Delhi.** “He came to Delhi just two days before he died. He was holidaying with our parents in Coimbatore after the prelims for civil service exams,” recalled Virendra Pratap Singh, whose younger brother, Kumar Dhirendera Pratap Singh (25), was one of the two victims of the huge fire that engulfed a Vishal Mega Mart outlet in Karol Bagh on Friday.Dhirendra’s body was found in a lift. Shortly before he died, he had sent a WhatsApp message to his brother, pleading for help: “Bhaiya, hum lift mein fass gaye hai... aur bhaiya, saans phool raha hai, kuch karo (Bhaiya, I’m stuck in the lift... and I’m not able to breathe, please help).”Since Friday, Virendra claimed, none of the executives at Vishal Mega Mart have attempted to contact him. “I just want to know who will be held responsible for this,” he said. The family hails from Uttar Pradesh’s Sonbhadra district. Dhirendra’s father runs an advertising business, while his mother is a government school teacher.

Intending to crack the UPSC exam, he came to Delhi in 2019. He had enrolled at Delhi University for a Bachelor’s degree in Political Science. He eventually left DU with a Master’s degree in 2024 and then started his UPSC journey. “Dhirendra enrolled in Vajiram and Ravi coaching centre and was living in a paying guest accommodation in Karol Bagh. He gave his first UPSC attempt this year and cleared the prelims. It was unbelievable. Coming from our village, he was the ‘chirag’ (light),” shared Virendra, who works for the family business in their village, and lives there with his wife and parents. He said that he couldn’t stand in front of the burning pyre for more than five minutes. “I don’t know how my brother was feeling with all that smoke inside a lift if I couldn’t bear it for five minutes... can’t imagine his

plight,” the 29-year-old shared. Officials suspect the fire broke out after a short circuit occurred on the second floor. they received a call regarding the fire at 6.45 pm. As many as 13 fire tenders and around 90 firefighters were pressed into service to bring the blaze under control. Dhirendra’s body was found inside the lift of the building. “His body was recovered around 3 am. It is suspected that he died due to suffocation,” a police officer had said. Pawan Gautam (30), who worked at Lab Testing MTS and was living in Rajendra Nagar on rent, was the other victim. In the aftermath of the huge fire, it has become challenging for the forensic team to conduct the investigation, said officials. “One more day would be needed for forensic teams to complete their procedure. As of now, we are awaiting the post-mortem results to take the investigation further,” a senior police officer said.



## Noida International Airport will now be opened for operations in November

**Agency New Delhi.** The work at the Noida International Airport in Uttar Pradesh’s Jewar — which has missed several deadlines since its foundation stone was laid in November 2021 — will be completed by November this year, Uttar Pradesh’s Industrial Development Minister Nand Gopal Gupta ‘Nandi’ said over the weekend.Addressing reporters after a review meeting with the officials of Yamuna Industrial Expressway Development Authority (YIEDA), Nandi said, “Jewar Airport, which was like a genie in the bottle, used to come out and later get inside the bottle during the SP and BSP government. The file was gathering dust. We have worked on it for eight years, and it will now be completely ready by November.” Nandi also said it will be recognised as the fourth-largest airport in the world and the largest airport in Asia. The airport missed its first opening deadline on September 29, 2024, which was later pushed to April of this year. Following this, June 30 was announced as the new date for operations“We have reviewed the progress of the airport and directed officials to fast-track all work,” said ‘Nandi’, who was on a two-day visit to Noida, Greater Noida and YEIDA to review infrastructure projects. The minister also said that under Chief Minister Yogi Adityanath, law and order in Uttar Pradesh is in place, which has led to a surge in MNC investment on a large scale in the state.

“This meeting was to review what facilities we can provide for their work and ensure there are no obstacles for them. Uttar Pradesh has emerged as the best destination for industrialisation. If Kashmir is the crown of India, then I can say that Noida is like the crown of Uttar Pradesh,” said Gupta.The Noida International Airport in Jewar is being built in four phases with an investment of Rs. 29,650 crore. The first phase, costing Rs. 10,056 crore, is designed to cater to 12 million passengers annually, and will have one runway and one terminal building. The fourth phase, which is expected to become operational in 2040, will have the capacity to handle 70 million passengers annually making it the largest in Asia.

## Teenager stabs 15-year-old kin to death after quarrel



**Agency New Delhi.** A teenager has been apprehended for allegedly stabbing his 15-year-old relative to death with a piece of glass following a quarrel in east Delhi’s Mandawali area, police said on Sunday. The accused, aged between 16 and 17 years, works as a rag picker. Sharing the details, police said information regarding the medico-legal case (MLC) of a “brought dead” minor boy was received at Mandawali police station around 12.06 am on Sunday from LBS Hospital. The body was preserved in the mortuary for post-mortem. Police said the alleged attacker had fled the scene after the incident. Initial investigation revealed that the deceased and the accused are related and belong to the same community. A dispute had broken out between them, during which the accused used a piece of broken glass to stab the victim. “Later in the night, during routine patrolling, police detained a suspicious boy in Preet Vihar. During questioning, he confessed to having stabbed the victim during a quarrel. He was immediately taken into custody and handed over to Mandawali police station for further action,” said a senior police officer.In the hospital’s emergency ward, the deceased’s elder sister, Shabana, told police that her brother was attacked with a sharp glass piece.

## Wanted in 2015 robbery-murder case, man arrested from Greater Noida



**Agency New Delhi.** A man accused in a 2015 robbery-murder case and on the run for several years was arrested from Greater Noida on Sunday, said police. Identified as Ashish Kumar (35), the accused allegedly killed a businessman and looted Rs 7 lakh from him at Maurya Enclave in 2015, said officers. He was declared a proclaimed offender after he failed to surrender in 2022 after getting an interim bail in 2020, which was extended due to the pandemic. The case was lodged at the Maurya Enclave police station under multiple Indian Penal Code (IPC) sections, including those for murder, robbery, and criminal conspiracy, as well as under provisions of the Arms Act, said police. According to the police, inputs were received in the early hours of Sunday about the accused working at a mobile plant in Greater Noida. The police set a trap and arrested him. “He was still pursuing his undergraduate studies when his friend Amit, already involved in criminal activity, persuaded him to join a plan to rob a businessman in Maurya Enclave, Delhi. Shahbad, another associate of Amit, and Ashish robbed Rs 7 Lakh from the victim. When the victim resisted, they murdered him,” DCP Sanjeev Kumar Yadav said.

## Inside Delhi Food Walks’ new Kasol-Manali series with Anubhav Sapra—from hemp cafés to siddu spots

**Agency New Delhi.** From Rishikesh and Lansdowne to Mussoorie and Shimla, the hills are well-loved for treks, rafting, and bungee jumps. But there’s another adventure waiting in the mountains that often goes overlooked: the food. This monsoon, Delhiite Anubhav Sapra—best known for pioneering the food walk culture in the capital through his company, Delhi Food Walks—is hiking through the hilly terrains of Kasol and Manali for his ongoing YouTube series, following unusual and iconic flavours and stories nestled in the hills of Himachal. Mountain food is far more diverse than the usual momo, thukpa, or Maggi. Over the years, dining spots in Kasol and Manali have introduced Israeli and Mediterranean flavours like shakshuka, falafel, and schnitzel into the mix. Alongside these global influences, traditional Himachali staples still hold their ground—like siddu, a steamed bread stuffed with sweet or savoury fillings such as lentils, walnuts, or poppy seeds, and Himachali dham, a rare-to-find all-vegetarian feast typically reserved for special occasions. Joined by local entrepreneur Khushboo Barry, Sapra hops across iconic and lesser-known spots in the mountains. “It’s always good to go with someone who knows the place—someone who can take you around, tell you where to eat, what to avoid, and give you a deeper understanding of the place,” says Sapra—a principle reflected in much of his work outside Delhi, where he often collaborates with locals. In the recently released first episode, the duo engages in long conversations with café owners, uncovering the stories behind their journeys. They dig into kosher-style chicken shipudim and German schnitzel at the 25-year-old Evergreen Café, sip hemp cappuccino at India’s first hemp café, Offlimits, and wrap up with a flaky “prashant” (croissant) at one of Kasol’s oldest German bakery.Over six days, Sapra and his team explored Kasol and nearby spots—including Manikaran Sahib, a gurdwara in Kullu known for its natural hot springs and a langar that runs 24 hours. In search of an authentic Himachali dham, they travelled to Kailasha - The Himalayan Village, a resort in Kasol.

## Delhi: Over 1,200 rolls of Chinese manjha seized, 3 arrested

**Agency New Delhi.** Ahead of Independence Day and Raksha Bandhan, the Delhi Police has seized over 1,200 rolls of banned Chinese manjha in the past week and has arrested three men from different places in Delhi.The raids were part of an operation to curb the sale of the illegal thread, police said on Sunday. Chinese manjha uses nylon threads which are sometimes coated with powdered glass. DCP (Crime) Sanjeev Kumar Yadav, said that this is a part of a preventive drive before Independence Day. He said Chinese manjha is dangerous to people, birds, and animals. In the past month, two people have died in three separate incidents related to injuries caused by manjha have been reported.The first seizure was



conducted at Kamla Market on June 26; the second operation happened in Uttam Nagar on June 27. The third operation took place in Wazirabad on July 5. In total, 1,226 rolls of Chinese manjha were seized. “He previously operated a shop from the ground floor of his residence. He started selling banned Chinese manjha both offline and online due to high profit margins,” DCP Yadav said. In the second case, police arrested Areeb Khan, 22, from Daryaganj. He had 248 rolls of banned string and was caught near Kamla Market. Earlier, Areeb worked at a clothing store but moved to kite-string selling for more profit, the police said. In the third case, Danish Khan, 28, from Babanpuri, Uttar Pradesh, was arrested. Police caught him in Sangam Vihar, Wazirabad, with 56 rolls of manjha. He used to make kites but started selling manjha to earn more money. All three men were booked under the Environment Protection Act and sections of the BNS. Police said that they are trying to find out the larger supply network behind this illegal trade.

## Delhi belongs to all, not just one community or caste

**Agency New Delhi.** Whom does Delhi belong to? It’s a very difficult question to answer given the cultural, caste and community mosaic of the city ever since it was founded by the Tomar King Anang Pal almost 1500 years ago. He built the first city of Lal Kot, which was captured by the Chauhans in the mid-12th century and renamed it Qila Rai Pithora. However the oldest archaeological relic found in the national Capital is of Mauryan period that is 1200 years further back in history. After the defeat of Prithviraj Chauhan at Battle of Tarain in 1192, came the Sultanate, then the Mughals, the British and finally independence. All through this period, irrespective of which community did the ruler belong to, Delhi’s cultural life continued to be a mosaic described earlier. Thus it is very surprising that Delhi Chief Minister Rekha Gupta could



recommend renaming of Delhi Junction, popularly known as Old Delhi Railway station, after a Vaishya caste icon Maharaja Agrasen. According to newspaper reports she has written to Railway Minister Ashwini Vaishnaw saying, “I am writing to respectfully request your kind consideration for renaming the Old Delhi Railway Station in honour of Maharaja Agrasen, a revered historical figure whose legacy has had a profound impact on the socio-economic development of India, particularly in Delhi.”In the

chronology of kings and dynasties which ruled Delhi, Maharaja Agrasen doesn’t figure. He is part of the legend and believed to belong to the lineage of Lord Ram of Ayodhya, his 34th generation descendant. He is said to have adopted the Vanika dharma (trading duties) and the Vaishya community draws its lineage from him.His descendants came with the name of the Agarwals divided into 18 gotras. Being the ‘identity deity’ of a prosperous and a powerful community, institutions in his name have come across the country and overseas too specially in the 20th and the 21st centuries. The only historical site of any consequence in his name is ‘Agrasen Ki Baoli’ on Hailey Road in Lutyens’ Delhi.According to archaeological research and records, this step well was built in medieval times during either the Tughlaq or the Lodi period by a community of traders to commemorate the memory.

## 9-year-old Delhi boy is the talk of the chess world — after he nearly beat Magnus Carlsen

**It was four years ago that Aarit Kapil’s parents noticed his prodigious talent for the game. And there was no looking back. In December last year, he defeated Grandmaster Raset Ziatdinov. In February this year, he had gathered enough points to become a Candidate Master.**

**Agency New Delhi.** On the morning of June 24, sitting in a hotel room in Batumi, Georgia, Aarit Kapil made a decision that would have people talking for weeks to come. The nine-year-old was in the country to compete in the prestigious FIDE World Cadets Cup, battling it out in the under-10 category. At 8 am that day, on a whim, he decided to log into chess.com and play their well-known Titled Tuesday online blitz event.Organised twice every Tuesday, this tournament is only open to players with FIDE titles (like Grandmaster (GM), International Master, Candidate Master, etc.). This particular Early Titled Tuesday had elite GMs like Hikaru Nakamura, Fabiano Caruana, former world champion Vladimir Kramnik — and Magnus Carlsen — competing in it. Aarit’s parents were on a phone call when he rushed out shouting, “Draw kar diya, Magnus ko draw kar diya! (I got Magnus

to draw)”. It took his parents a few seconds to process his words before they erupted in celebration.For them, Aarit’s near success against the formidable chess grandmaster was almost natural. In December last year, Aarit defeated Grandmaster Raset Ziatdinov. In February this year, he had gathered enough points to become a Candidate Master.“He doesn’t get nervous when facing big players. He gets really excited,” said Nisha Kapil, his mother, who often accompanies him to his tournaments. Aarit, with his round Harry Potter-like glasses, smiled shyly beside her. “All I think about is that I need to beat them... I always keep looking out for mistakes they can make,” he said softly, almost under his

breath.It was four years ago that Aarit’s parents noticed his prodigious talent for the game.“I’m a casual player and used to often play online,” said Vijay Kapil, the boy’s father. “He had come to me and asked what I was doing, and I taught him. Within a week, he

was beating me at the game,” he said. At first, his parents believed it to be a fluke and tried testing his abilities. “We would feel bad that he’s beaten us,” laughed Nisha, adding, “So we’d make the game tougher for him. We’d take away a few pieces, randomly reduce his points... and he still kept beating us at it. I think that’s when we realised that he has a true talent for the game.” Aarit was put into coaching with International Master (IM) Vishal Sareen. Within a week, his father said, Aarit had won an international tournament with a Rs 15,000 cash prize. “I was shocked. I mean, he was only five years old,” Vijay said, laughing as if he still couldn’t believe it.Over the years, Aarit’s rise has been meteoric. His coaches, too, believe that the young boy prodigy has the makings of a future Grandmaster.

my Kapurthala Punjabi Chicken tikka and they went well with sarson da saag and makki ki roti. Somehow, the roti did not have the graininess I've grown to expect, but its smooth moist texture was good too. Pindi chana, another must have at any Punjabi restaurant, disappointed me as it was a little bland. Dessert, though, was a hit. I loved the creamy kulfi. It was not overly sweet and allowed the milky malai and nuts work on my taste buds. I left The Crown with a pleasant taste in my mouth.

-Heat 1 tsp oil and add Bhut Jolokia to it. When chilli splutters, remove from flame and keep aside.

-Mix corn kernels, green tomatoes, ginger,

turmeric powder, black pepper, salt, lemon juice and prepared chilli oil. Mix in 1 tsp of rice flour to help bind the mixture.  
-Divide prepared dough into half. Flatten out one half into a rectangular shape, spread over with half the prepared stuffing and roll into a cylinder. Repeat procedure with remaining dough and stuffing.  
-Boil water in a soup pot and add the cylinders. When cylinders start floating, remove, drain, pat dry and cut into slices.  
-For the chutney, combine raw papaya with salt, 2 tsp water and sugar and cook till done. Heat oil and add in the cumin seeds and coriander seeds. When spices crackle, mix in coconut and cook till golden.  
-For the smoothie, cut a peach into half and deseed carefully. Scoop out some flesh to form cups. Whip the scooped out peach with curd and sugar in a blender till smooth. Fill into prepared cups and garnish with melon seeds.  
-To serve, spread chutney on a plate and arrange rice rolls on it. Serve alongside peach cups.



Lost Rs 18 lakh in 6 months:  
Financial advisor's warning  
on online betting

**New Delhi. (Agency)**  
A financial advisor recently watched one of his clients lose Rs 18 lakh in just six months. Not to stocks, not to crypto, but to online betting. Abhishek Kumar, a Sebi-registered analyst and founder of SahajMoney, shared the story in a LinkedIn post. “One of my clients lost Rs 18 lakhs in 6 months,” he wrote. “Not to stocks. Not to cryptos. To online betting.”The client kept the losses hidden from his wife until the situation had already spiralled. “He had taken a personal loan, and was borrowing from friends,” Kumar added. The rise of online betting apps, often disguised as harmless fantasy sports or casino-style games, has created a fast-growing but poorly understood problem in India's digital economy. Flashy interfaces, instant rewards, and near-constant notifications are all part of a design meant to keep users hooked. “Betting apps are designed like slot machines,” Kumar noted. “Flashy. Addictive. Instant dopamine hits. And they’re just one swipe away.”According to him, the pattern is alarmingly familiar. It begins with a small, harmless-sounding amount—“Just Rs 500 for fun. You win once. You feel lucky. You chase the high.” But soon, the behaviour escalates. “These apps use casino psychology. Near wins. Fake bonuses. Constant notifications,” he wrote, warning that even young professionals with comfortable salaries are getting drawn in. “I’ve seen it happen to young IT professionals making Rs 15 lakh a year.”The financial consequences are often severe. “Loan apps, credit cards, even PF withdrawals,” Kumar said. “People borrow to keep playing.” Beyond the money, the social and emotional toll is also significant. “It destroys families,” he wrote. “One guy told me he started lying to his wife, skipping EMIs, and hiding transactions. The stress? Unbearable.” While some Indian states have attempted to regulate online betting, national legislation is still missing. “The Supreme Court just asked the govt if it’s time for a national law. I say: long overdue.”

The Jane Street Saga: What it  
means to you

**New Delhi. (Agency)**  
The 105-page interim order in the matter of index manipulation of Jane Street Group, a global proprietary trading firm, rocked the stock market last week. The Securities and Exchange Board of India, the stock market regulator, barred a group of four entities from trading in Indian markets and ordered the impounding of their profits. Sebi has accused the group of manipulating the prices of securities for profit. Derivatives, such as futures and options, derive their value from underlying securities, like stock indices or individual shares. Traders around the world buy in markets where prices are low and sell when prices are high. They do that within the cash or derivative market or across markets. The purpose of trading in derivatives is to make short-term profits. With the help of technology, high-frequency traders can buy in one market and sell in another in microseconds. Now, you can do that between two different counter parties. The accusation in the case of Jane’s Group concerns the use of the same entities belonging to the group, but registered in different geographic locations, for carrying out high-frequency trades. At the same time, shares in the cash market, such as those held by large banks with a high weight in the Bank Nifty, were bought and sold closer to the market close on multiple days. The allegation is that it was done to move the final settlement price in favour of Jane Group companies. While the reaction in the cash market was subdued, it was evident in a sharp decline in trading volume in the index and stock options segments on the National Stock Exchange last Friday. Those who are into day trading are likely to exercise caution. There are multiple opinions already on the issue. Some reports suggest that the Jane Group is not the only foreign trading firm in the Indian equity options market that comprises index-based options (such as Nifty and Bank Nifty) or stock options. There are other firms as well, and they may be hesitant to enter the Indian market. Brokers offering their opinions are cautious in their response to the Sebi order. Brokers generate a significant remuneration out of the day trading activity through brokerages and fees from you. They are unlikely to be happy about any decline in the trading volume in the Indian stock market.

India aims to double maize  
output by 2047; West  
Bengal, Bihar ahead in  
production: Minister

**New Delhi. (Agency)**  
India can more than double its maize production to 86 million tonne by 2047 from the current 42.3 million tonne, Agriculture Minister Shivraj Singh Chouhan said on Monday, calling for development of high-yielding seed varieties with higher starch content. Speaking at the 11th maize summit organised by industry body FICCI, Chouhan said the world’s fifth-largest maize producer needs to boost productivity without using genetically modified seeds. “We don’t use genetically modified seeds, but we can still raise the productivity levels,” Chouhan said. India’s average maize productivity stands at 3.7 tonne per hectare, with some states like West Bengal and Bihar performing above the national average, but overall yields need to increase, he said. The Indian Council of Agricultural Research (ICAR) has developed 265 maize varieties, including 77 hybrids and 35 bio-fortified varieties, but more work is needed, according to the minister. “There is a need to increase starch level in maize. We need to increase it to 72 per cent from the current 65-70 per cent level so that maize can be used in better way,” Chouhan said. India’s maize production has grown from 10 million tonne in the 1900s to the current 42.3 million tonne. To boost production, states like Punjab and Haryana, which focus on paddy cultivation, should diversify to maize, the minister said.

BRICS Summit: Key takeaways for Indian business

India’s leadership on reform,

CHENNAI: India emerged as a key architect of the BRICS agenda—driving local-currency trade, global governance reform, green investments, and digital regulation. These developments offer strong tailwinds for sectors spanning finance, infrastructure, technology, agriculture, and clean energy. With India set to assume BRICS Chairmanship in 2026, its businesses are well-positioned to capitalise on newfound opportunities. Following are some of the highlights from the Summit as far as such opportunities are concerned:  
**National Currencies**  
BRICS leaders, including India, endorsed increasing trade settlements in national

currencies, aiming to reduce reliance on the US dollar. While the idea of a common BRICS currency remains off the table, discussions around payment systems such as BRICS Pay and national-currency settlement frameworks are gaining momentum. A new BRICS Multilateral Guarantee (BMG) mechanism, backed by the New Development Bank (NDB), was unveiled to help mobilise private investment, particularly in infrastructure, climate-related, and sustainable projects. This is expected to lower financing costs and stimulate capital inflows into India. The NDB also reaffirmed its commitment to strengthening its regional presence, with existing projects in India and plans to expand its office in Gujarat. Indian infrastructure, climate, and manufacturing sectors are likely beneficiaries. India joined other BRICS members in renewing calls for reforming global institutions such as the IMF, World Bank, and UN Security Council to provide greater representation for emerging economies. This agenda closely aligns with India’s longstanding diplomatic goals.

**Climate and technology**  
India’s green energy and agri-tech sectors

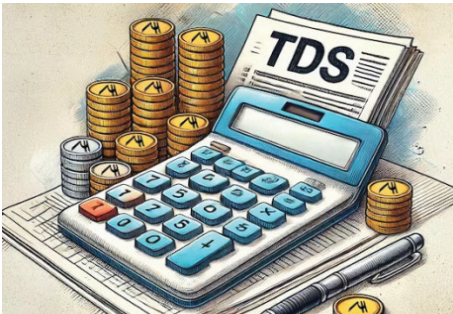
are expected to benefit from a collective push toward climate action and sustainable development. Member nations called on developed countries to finance the Global South’s climate transition and expressed support for initiatives such as the Tropical Forests Forever Facility and the BRICS Grain Exchange. The summit also focused on digital regulation, including the need to address the unauthorized use of artificial intelligence and to strengthen data protection rights. These discussions are particularly relevant for India’s fast-growing digital and AI industries. Enhanced frameworks for e-commerce and data privacy are likely to support continued growth in the domestic tech sector. India also advocated dismantling export restrictions among BRICS countries to promote more seamless trade and supply chains. This complements India’s broader push for deeper South–South economic collaboration. A bilateral meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping led to agreements on de-escalation along the Line of Actual Control and the resumption of border patrols. This

development may help restore investor confidence, particularly in India’s electronics and manufacturing sectors, which have been affected by geopolitical tensions. The BRICS joint statement also included a firm condemnation of terrorism and a call for enhanced intelligence-sharing. India, facing persistent cross-border threats, stands to benefit from stronger security cooperation within the bloc.

**Impacts**  
The new guarantee fund and the shift toward local-currency trade could reduce borrowing costs and mitigate currency risks for Indian exporters and infrastructure developers. Initiatives like the grain exchange, forest protection funding, and clean economy programs will likely boost India’s agri-tech and clean-tech industries. With AI governance and data protection now part of the BRICS agenda, Indian tech firms gain greater clarity on regulatory direction, which should support their expansion across software, AI, and e-commerce markets. Improved India–China ties may ease supply-chain constraints and open the door to more stable cross-border collaboration.

House rent above Rs 50,000 Here's  
the TDS rule you need to know

**New Delhi. (Agency)**  
If you’re paying more than Rs 50,000 a month in rent, there’s a tax compliance rule that’s easy to miss, but costly to ignore. Under Section 194-IB of the Income Tax Act, even salaried individuals are required to deduct tax at source (TDS) before paying rent and deposit it with the government. This rule is often misunderstood as applicable only to businesses or those under tax audit. But it also covers individuals, including salaried tenants. Anyone paying rent above the Rs 50,000 threshold in a financial year must deduct 2% TDS and file the necessary forms. The deduction must be made once during the year—either in March or the final month of the tenancy, whichever comes earlier. The tenant is then required to file Form 26QC and provide Form 16C to the landlord. Non-compliance can trigger serious consequences. According to TaxBuddy.com, a tax compliance



platform, one salaried individual named Abhishek paid Rs 55,000 per month in rent but failed to deduct TDS. As a result, he was issued a penalty of Rs 1,00,000 by the income tax department. “Abhishek, a salaried person, was asked to pay a penalty of Rs 1,00,000 by income tax. His mistake? He paid Rs 55,000/month in rent but didn’t deduct TDS. Even salaried people need to deduct TDS at times,” TaxBuddy.com stated in a

LinkedIn post. Another case, also highlighted by the platform, involved Rohan, a salaried employee who had been paying Rs 60,000 in rent since April 2022. He failed to deduct and deposit TDS for two consecutive financial years. When he finally complied in April 2025, he ended up paying Rs 37,000 in late fees and interest—more than the TDS amount itself. TDS obligations are often overlooked in personal financial planning. Yet failure to comply can lead to a late fee of Rs 200 per day under Section 234E, capped at the amount of TDS due. Interest accrues at 1% per month for failure to deduct and 1.5% for failure to deposit, under Section 201(1A). Penalties between Rs 10,000 and Rs 1,00,000 can be levied under Section 271H, and prosecution is also possible under Section 276B, carrying a jail term of three months to seven years.

Borosil Renewables gains 4.3% after  
German subsidiary files for insolvency

**CHENNAI. (Agency)**  
Shares of Borosil Renewables Ltd., jumped 4.30% to Rs 518.50 a unit on Monday (July 7) at 10.56 AM, following the announcement that its German subsidiary, GMB Glasmanufaktur Brandenburg GmbH, has filed for insolvency in a German court. The move follows months of operational challenges. GMB had cooled down its furnaces in January 2025 due to poor demand and deteriorating market conditions across the European Union. A key reason cited for the slump was Chinese manufacturers dumping solar panels and solar glass at cheaper prices, significantly impacting demand for German-made products. Despite efforts to seek assistance from authorities, no measures were introduced, forcing GMB to seek legal insolvency protection.

**Impact on Borosil Renewables**

Borosil Renewables’ total exposure to its German unit and step-down subsidiaries stands at approximately ₹340–350 crore. The company had been incurring a monthly cash loss of around ₹9 crore due to the underperforming German operations. With the insolvency proceedings now initiated, these monthly losses will cease, which is expected to offer immediate financial relief to the parent company.

**Strategic refocus on Indian operations**  
The company is now shifting its strategic focus to its Indian operations, where demand for solar glass remains robust. Borosil Renewables is investing heavily in its domestic manufacturing capacities, including a proposed ₹675–700 crore expansion project in Bharuch, Gujarat. The company plans to scale up capacity to meet the anticipated surge in domestic solar module production, which is projected

to grow significantly in the next two years. Favorable policy measures, such as import duties on Chinese solar glass and government support for local solar manufacturing, are expected to benefit Borosil’s India-centric strategy.

**Stock and investor outlook**

While the market may initially react cautiously to the news of insolvency, analysts view this move as a positive development in the long term. By cutting losses and reallocating resources to growth-ready segments in India, Borosil Renewables is expected to emerge financially stronger and more competitive. The company’s decision to exit its struggling German unit marks a strategic pivot toward India’s fast-growing solar market. This development, while operationally significant, may prove financially beneficial in the long run, as the company doubles down on markets with stronger demand.



Maruti Suzuki declined 0.90%, and HCL Technologies slipped 0.87%. Nifty Midcap100 fell 0.26%, Nifty Smallcap dropped 0.28%, while India VIX surged 2.03%, showing increased market volatility. Only a few sectors posted gains at the opening. Nifty FMCG led with a 0.90% rise, followed by Nifty Oil & Gas up 0.23%, Nifty Consumer Durables gaining 0.17%, and Nifty PSU Bank climbing 0.05%. Most sectors opened in the red. Nifty Media dropped the most at 1.23%, followed by Nifty Pharma down 0.48%, Nifty Metal falling 0.47%, Nifty Healthcare declining 0.47%, Nifty IT slipping 0.38%, Nifty Private Bank down 0.25%, Nifty Auto falling 0.23%, Nifty Financial Services declining 0.11%, and Nifty Realty dropping 0.05%.

"The regulatory action on Jane Street and its implications will be closely watched by the market. The volume of derivative trading is likely to take a hit impacting stock exchanges and some brokerages. This has implications for their stock prices, too," said Vijayakumar.

**New Delhi. (Agency)**  
The Securities and Exchange Board of India (Sebi) has decided to step up its monitoring of derivatives trading after its recent action against global trading firm Jane Street, reported news agency Reuters. The move comes as part of efforts to tighten oversight and prevent manipulation in one of the fastest-growing areas of India's financial markets. Speaking on Monday, Sebi Chairman Tuhin Kanta Pandey said the

regulator is increasing its surveillance in the derivatives space. While he did not go into specific details, he hinted that cases like the one involving Jane Street may not be widespread. “There may not be many more such cases,” he said as quoted by Reuters.

**INDIA’S DERIVATIVES MARKET UNDER THE LENS**

India is currently the world’s largest equity derivatives market. According to the Futures Industry Association, it accounted for nearly 60% of the 7.3 billion equity derivatives contracts traded globally in April. This explosive growth has been fuelled not only by institutional activity but also a sharp rise in participation from retail investors. The rising interest in derivatives trading has already prompted Sebi to introduce a series of checks. The regulator has reduced the number of expiry dates available for certain contracts and increased lot sizes. These measures are aimed at making derivatives trading more expensive and reducing speculative activity. However, the recent incident involving Jane Street has raised concerns that even with these

curbs, there may still be gaps in the system that allow large players to influence market prices unfairly.

**THE JANE STREET CASE**

On Friday, Sebi barred Jane Street from buying or selling securities in Indian



markets. The action followed a detailed investigation into alleged manipulation of stock indexes. Sebi also ordered the seizure of Rs 4,840 crore (approximately \$567 million), which it said represented illegal gains from these activities.

In its 105-page order, Sebi accused Jane Street of manipulating the Bank Nifty

index. According to the regulator, the firm bought large quantities of Bank Nifty stocks in both the cash and futures markets in the morning, pushing the index higher artificially. At the same time, it had built significant short positions in index options. Later in the day, the firm reversed its trades in the cash market, leading to a drop in the index and profits from the earlier short positions. This strategy, according to Sebi, was a clear example of index manipulation aimed at benefiting from planned price movements in options trading.

**BROADER INVESTIGATION PLANNED**

A person familiar with the matter told Reuters that Sebi plans to widen its probe into Jane Street’s trading activity. The investigation will now look at trades across different exchanges and possibly other indices beyond the Bank Nifty.

The regulator’s decision to expand its inquiry signals that Sebi is taking the issue seriously and may not stop at Jane Street.

I keep coming back to it- that filmmaking is a business. Aap wahi banaoge jo aapko lagta hai bikega. (You will make only what you think will sell).”

ICC appoints Sanjog Gupta as Chief Executive Officer

The International Cricket Council (ICC) on Monday announced the appointment of Sanjog Gupta as its new Chief Executive Officer (CEO). Gupta will officially assume charge on July 7, 2025, becoming the seventh person to hold the post.

A veteran of India's sports and media ecosystem, Gupta currently serves as CEO of Sports & Live Experiences at JioStar. With over two decades of experience across content, strategy, and operations, he has been widely credited with shaping the modern sports broadcast landscape in India.ICC Chairman Jay Shah welcomed Gupta's appointment, calling him a visionary leader whose expertise would prove vital in the organisation's next phase of growth."Sanjog brings extensive experience in sports strategy and commercialisation, which will be invaluable for the ICC," Shah said. "His deep understanding of global sports, media and entertainment, along with his passion for technology and the cricket fan's perspective,



will be essential as we seek to expand cricket's reach-especially with Olympic inclusion on the horizon."

Gupta was appointed following a rigorous global recruitment process that attracted more than 2,500 applicants from 25 countries. After multiple rounds of shortlisting, the ICC's Nominations Committee, comprising Imran Khwaja, Richard Thompson, Shammi Silva, and Devajit Saikia, unanimously recommended Gupta. The decision was later ratified by the full ICC Board.In his first remarks after being named CEO-designate, Gupta described his new role as a "privilege" and emphasised his commitment to taking cricket to new frontiers."These are exciting times for the sport as marquee events grow in stature, commercial avenues widen, and opportunities such as the women's game scale in popularity," Gupta said. "Cricket's inclusion in the LA28 Olympics and rapid technological advances present game-changing possibilities. I look forward to working closely with ICC Member Boards to expand cricket's global footprint and enhance fan experience."

Akash Deep flattens England to break 'Edgbaston jinx' as India level Test series 1-1

Indian pacer Akash Deep claimed his maiden five-wicket haul and first ten-wicket match as India thrashed England by 336 runs to level the series in the second Test at Edgbaston on Sunday.Set a daunting target of 608, England were bowled out for 271, with 28-year-old Akash taking 6 for 99 in the second innings to hand Shubman Gill his maiden win as Indian captain.If Gill, with his magnificent batting (269 and 161) set it up, Akash deserves equal credit for his lion-hearted effort on a track which was primarily a bowler's graveyard.The rain delayed the start of the day by an hour and 40 minutes, reducing the day's quota of overs to 80 with England resuming their second innings at 72 for three chasing a near impossible 608.

If Mohammed Siraj (7 wickets and catches)



bowled like the leader of the attack in the first innings, Akash Deep built on his first innings gains to strike twice with new ball early on day five.Once not having enough opportunities in a non-descript town in Bihar, the journey hasn't been a bed of roses for the son of a government school teacher, who would survive on pocket money earned by playing tennis ball cricket before scouts in Bengal saw his potential and fast tracked him into the age-group system seven years back. He played his debut first-class game for Bengal during Christmas in 2019.

In less than six years, his sharp incutters from length that fooled Joe Root, Ben Duckett, Ollie Pope and Harry Brook didn't let his skipper miss the peerless Bumrah. Akash came into the tour knowing that his sister is suffering from cancer and he felt that everytime, he sprinted towards the pitch, the visions of his ailing sister crossed his mind.For England, Jamie Smith (88) fought a lonely battle before being dismissed by a slow bouncer from Akash, giving the medium pacer his first five-wicket haul in Test cricket. Fittingly, Akash got the final wicket of the game to complete a match haul of 10/187.

The 2025 British Grand Prix turned out to be one of the most unpredictable races of the season, with five retirements, changing weather, and a flurry of safety cars. It also marked the first time in 11 years that Lewis Hamilton missed the podium at Silverstone.

Oscar Piastri, who looked like the top contender to win the British GP, brake-checked himself out of the top spot after receiving a 10-second penalty for trying to be too cheeky behind the safety car. Piastri was penalised on lap 21 of the race for 'erratic braking' after he nearly caused a collision with Max Verstappen, who was trailing him behind the safety car.The brake-check completely ruined Verstappen's race. He was

unable to manage his Red Bull on a simple turn and ended up spinning on the track after losing grip on his rear tyres. Verstappen dropped to 14th place but fought back to finish in 5th.The race began with stiff competition between Oscar Piastri and Max Verstappen. Piastri, who had the better car among the two, tried to overtake Verstappen in the very first lap but to no avail.

There was drama at the back as Liam Lawson collided with Esteban Ocon, resulting in the first DNF of the race and an early yellow flag.

The subsequent laps saw multiple safety cars, both on-ground and virtual, after several cars slipped off the track due to the wet conditions.Racing resumed briefly between laps 4–8, when Piastri managed to pass Verstappen for the lead. A heated on-track battle also unfolded between Kimi Antonelli and other midfield runners, with Antonelli left unscathed for the time being.

Rain took over the scene from lap 11, which meant that the McLarens turned out to be the superior cars of the lot, gaining a massive

time advantage over the rest of the field. The conditions became trickier as on-and-off rain made it difficult for race engineers to decide whether to run the cars on intermediates or slicks.

On lap 14, Ferrari’s Charles Leclerc ran off the



track completely and slid across the grass. He was able to save the car from hitting the wall, only because there was ample runoff area on the track. Another safety car during this time allowed Oscar Piastri to dive into the pits and serve his 10-second penalty.During the

caution period, Russell called for the race to be red-flagged, but the FIA chose not to halt proceedings. The safety car ended on lap 17, with Piastri still in the lead.Lap 18 saw chaos at the restart, with Russell overtaking Hamilton, only to lose the spot moments later. Racing Bulls driver Isack Hadjar collided with Antonelli due to low visibility, forcing Hadjar to retire. Antonelli lost his rear diffuser in the collision, which eventually forced him to retire from the race.In the final stages, Russell, Hamilton, and Verstappen climbed back into the top 10. Hamilton eventually finished 4th, Verstappen settled for 5th, and Russell dropped to 9th after a late spin.

Norris moved into the lead after Piastri served his penalty. Hulkenberg overtook Stroll to claim his first-ever podium in F1, and

Aston Martin finally had both their drivers score points.The race ended with McLaren celebrating another strong weekend, while Ferrari and Mercedes struggled with tyre strategy, leaving at least one driver from each team out of the points.

Magnus Carlsen wins Grand Chess Tour Zagreb: My B-game is enough

World No. 1 Magnus Carlsen reacted to his SuperUnited Rapid and Blitz win in Croatia on Sunday, July 6. After the final standings of the tournament were made official, Carlsen said on social media that his “B-game was enough” on days when others did not do something exceptional.Magnus, who lost the Rapid title in the competition to India's D. Gukesh, came back strongly in the Blitz section of the tournament, helping him win the combined title. He took a dig at his critics with a meme before deleting the post.“When nobody else has a great performance, my B-game is usually enough. Always striving for more though!” Magnus tweeted out for the second time after his win.Carlsen had earlier complained about not enjoying his chess during the Rapid round. Even after his win in Zagreb, Magnus sounded unconvinced, stating that it did not feel like he had won.“It doesn’t feel like I’ve won, really. It feels like I just came here, played alright, and nobody really did anything special in the end, and then I usually end up winning!” Magnus told Take Take Take app in an interview.After his poor outing in Rapid, the Blitz portion brought a complete reversal of fortunes.



Gukesh lost five of his first six Blitz games on Day 1, drawing one and winning just one. His rhythm was off, nerves visible, and the crisp precision of his Rapid games was nowhere to be found. A final-round loss to compatriot R. Praggnanandhaa capped a disappointing Blitz performance that saw him lose six games on the first day alone.

In stark contrast, Carlsen unleashed what he later called a “decisive” run, scoring 7.5/9 on the opening Blitz day to erase Gukesh’s lead and seize control of the leaderboard.“I felt that I struggled most of the event. Partly because it was a very strong field this year. There weren’t a lot of weaker players at all. It wasn’t obvious who was going to score poorly and who was going to score well against the others. It felt like, especially in Rapid, chances were kind of hard to come by. I had one good day yesterday (the first day of the Blitz section on Saturday).

After Rohit Sharma retired from Test cricket, Indian cricket faced the colossal task of selecting a new captain. Jasprit Bumrah opted out of the captaincy race, prompting India to make a bold decision by naming Shubman Gill as the new skipper. The move raised eyebrows, especially with a challenging tour of England on the horizon. Test captaincy brings a unique kind of pressure, and poor results often invite intense scrutiny. Gill was under pressure to



prove himself—particularly because his record in SENA countries (South Africa, England, New Zealand, and Australia) had been underwhelming.In 11 Tests, Gill averaged just 25.70, scoring only 514 runs with a lone half-century. Neither experience nor past performance seemed to support his case. But after the first two Tests, Gill has silenced many of his critics-at least for now. The tentative version of Gill appears to be gone, replaced by a confident and composed leader.

Selfish Norris, Piastri slammed for ignoring Nico Hulkenberg on British GP podium

37-year-old Nico Hulkenberg secured his first ever podium in Formula 1 on Sunday, July 6 at the British Grand Prix. However, this feel-good story ended up having a controversial finish after the Sauber driver was ignored by McLaren duo Lando Norris and Oscar Piastri during the celebrations.

Hulkenberg finished the race in third position, beating stalwarts like Lewis Hamilton and Max Verstappen to clinch his first ever podium in 239 races. Hulkenberg has been driving at the top level for 15 years, and finally managed to shrug off the unwanted record of the most race starts without ever standing on the podium.While the entire F1 world celebrated Hulkenberg's achievement, McLaren drivers decided to celebrate their 1-2 finish at the British Grand Prix with their race engineers, failing to



acknowledge Hulkenberg, who was also on the podium. The duo got slammed on social media for their selfish behaviour, with fans stating that the vibe of the celebration was off.An ecstatic Hulkenberg, however, did not care as he was showered with love by the likes of Mercedes and Aston Martin, who hand-delivered special bottles of champagne to the racer.

"I don't think I can comprehend what we've just done," he said over the team radio after taking third place.Hulkenberg did it in fairytale fashion. He started last on the grid, in 19th place, with Alpine's Franco Colapinto lining up in the pitlane, for Swiss-based Sauber.Thanks to clever strategy and pitting at absolutely the right time, Hulkenberg took Sauber to their first podium in 13 years and also became the team's all-time lowest-starting top-three finisher."It feels good. It's been a long time coming, hasn't it?" said Hulkenberg, rather stating the obvious, after tumultuous pitlane celebrations."I always knew we have it in us, I had it in me somewhere... it's pretty surreal, to be honest. Not sure how it all happened, but obviously crazy conditions, mixed conditions. It was a survival fight for a lot of the race.

Sam Konstas is good enough: Pat Cummins backs Australia opener to bounce back

Australian captain Pat Cummins took time out to publicly back young opener Sam Konstas, reinforcing the leadership group's faith in the rising talent despite a modest start to his Test career.Sam Konstas made an impressive Test debut against India, scoring 60 off 65 balls in his first innings. Since then, the 19-year-old has struggled for consistency, with scores of 8, 23, 22, 3, 5, 25, and 0 in his next seven innings. In the ongoing three-match Test series in the West Indies, Konstas has scored just 33 runs in four innings, averaging 8.25.Konstas has yet to cross the 50-run mark in his first two Tests, even as Australia surged to a commanding 133-run victory in the second match to seal a 2-0 lead in the three-match series against the West Indies. The 20-year-old showed glimpses of promise during his early outings in the Border-Gavaskar Trophy but hasn't quite lit up the scoreboard in this series.However, Cummins' post-match remarks made one thing clear: the



dressng room is standing firmly behind the young batter."Look, he's been good," Cummins said when asked about Konstas' performances. "I think for anyone who's starting out their Test career, you are kind of picked for a reason we know he's good enough." It was a clear message from the skipper - selection for the Baggy Green is no fluke, and

success in international cricket requires patience, both from the player and those around him.Cummins, who endured a rocky start to his own Test journey due to injuries, empathised with the mental challenges of trying to prove yourself at the highest level.

"For someone like a batter, it might be, where are your scoring areas, what tempo do you normally operate at your best - and don't get too caught up in every innings feeling like the biggest thing in the world," he said.

In the high-pressure environment of Test cricket - especially in the social media age - Cummins' grounded perspective serves as timely reassurance for Konstas and other newcomers still finding their feet.The Australian captain also reminded everyone that even the greats go through lean patches: "Even the best batters in the world don't hit their average three out of four times."
