# Rahul Gandhi must apologise: Amit Shah on abuse to PM, his mother at Bihar Rally

Amit Shah condemned Congress leaders for allegedly using derogatory words against PM Modi and his late mother during a Bihar rally, calling it the "greatest fall in politics."

Union Home Minister Amit Shah on Friday condemned the alleged use of derogatory words against Prime Minister Narendra Modi and his mother during an INDIA bloc event in

Referring to the incident, Shah said, "I want to urge Rahul Gandhi that if he has even a little bit of shame left, he must apologise to Modi ji, to his late mother, and to the people of this country. May God give wisdom to everyone."

He further said, "What happened two days ago has pained everyone. Modi ji's mother lived a life in a poor household, raised her children with values, and

enabled her son to become a leader of trust. To use abusive words for such a life is something the people of India can never tolerate. There can be no greater fall in political life than this, and I strongly condemn it."

"Congress leaders have committed the most condemnable act by using derogatory words against PM Modi's mother during their Ghuspaithiya Bachao Yatra. I condemn it. Every Congress leader has spoken derogatory words against PM Modi," Shah said.

# **Widowers' army: Congress leader slams RSS over Mohan Bhagwat's 3-child push**

Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat's call for Indians to have three children, Uttar Pradesh Congress chief Ajay Rai raked up controversy by calling the organisation a "widowers'

Rai questioned how the RSS could advise on family matters when many of its members are unmarried.

The RSS chief on Thursday said he was in favour of Indian parents having three children, asserting that it was necessary to stabilise the population and prevent a decline.

Addressing a press conference to mark 100 years of Rashtriya Swayamsevak Sangh (RSS), Bhagwat said that the country's population has a fertility rate of 2.1 and it was important to ensure the population was under control.

"India's policy on population suggests 2.1 children, which is fine as an



average. But you can never have 0.1 of a child. In maths, 2.1 becomes 2, but when it comes to births, after two, it has to be three. This is what doctors have told me," he said.

He stressed that communities with a fertility rate of 2.1 will slowly go extinct and that a birth rate of over 3 should be maintained. Marrying at the right age and having three children ensures that both the parents and children are healthy," he said.

He underlined that a population boom can be a boon, but at the same time, it can be a burden as well.

Referring to India's population policy, the RSS chief had added, "Our country's population policy was framed in 1998 or 2002, and it clearly mentioned that no community's population should drop below 2.1. Since one cannot have fractional children, we need at least three children per family, as per population science.'

# No objection: JDS differs from ally BJP on Banu Mushtaq's Mysuru Dasara invite

The Janata Dal (Secular) has taken a different stance from its NDA ally BJP over the Karnataka government's decision to invite Booker Prize-winning author Banu Mushtaq to inaugurate the Mysuru Dasara festival. Union Minister and JD(S) leader HD Kumaraswamy said he had no objection to the invitation. He noted that the state government had planned to give Mushtaq "a big message and responsibility" in leading the goddess Chamundeshwari procession and made clear that he supported the move.

His comments mark a contrast with the BJP, which has already voiced objections to the invitation. Mysuru BJP MP Yaduveer Wadiyar questioned Mushtaq's past remarks about the Kannada language, the state flag, and her views on the goddess Chamundeshwari. Union Minister Shobha Karandlaje also hit out at the Congress, calling the decision an "insult to Hindu sentiments." In a post on X, Karandlaje wrote that Mysuru Dasara is a sacred festival of Goddess Chamundeshwari, rooted in faith and tradition, and not a "cultural show." She accused the Congress of turning it into appeasement politics, saying: "Asking someone with no faith in our Devi to offer the first prayers is a direct insult to the Goddess and to every devotee.

Former Mysuru MP and BJP leader Prathap Simha also raised objections. He clarified that his opposition was not because Mushtaq is a Muslim, acknowledging her contributions to literature. But he questioned her connection to the rituals: "Does Banu Mushtaq believe in Goddess Chamundi? Has she ever followed our customs? This is not a government programme, it is a ritual expressing unwavering faith in the Goddess. Is she the right person for this?" The Congress government, for its part, stood firm, saying the Dasara festival was cultural and not to be viewed through the lens of caste or religion.

# Faridabad RWA asks resident to pay 'Rs 1.3 lakh fine' for feeding strays

**Gurgaon. (Agency)**Gurgaon: The RWA of a housing society in Greater Faridabad has fined a dog lover Rs 1.3 lakh over the past three years for feeding strays in unauthorised areas.Divya Nair, a private firm employee known among residents of Princess Park in Sector 86 for her compassion towards stray animals, has been feeding dogs within the society since 2022.

According to RWA officials, the fine was levied after Nair repeatedly fed dogs in parks, the basketball court, parking lots, and other public spaces despite the society designating a specific feeding zone in the market area. The RWA alleged her actions had created a mess on the campus and raised safety concerns for other residents.

A senior police official clarified that RWAs do not have the authority to levy fines on residents. "No, they can't. We can initiate action against them only if the woman lodges a complaint," the official added.

The Princess Park dispute unfolded against the backdrop of recent Supreme Court rulings on the issue of stray dogs. Responding to concerns over rising dog bite incidents and rabies cases in Delhi-NCR, the apex court modified earlier orders that called for strays to be moved to shelter homes. The latest ruling allowed authorities to release strays after sterilisation, but clarified that aggressive or rabid dogs must be kept in shelters. Most importantly, the court banned



authorities to set up dedicated feeding areas. The tussle between the RWA and Nair escalated when she took to social media platform X, alleging that she was assaulted for feeding dogs and her family faced threats from local police. She also claimed that all dog feeding had been banned in the society's premises since the revised Supreme Court order last week, and lady bouncers had been deployed by the RWA to enforce the rule.Nair expressed concern that nearly

The RWA has now decided to pursue legal action outstanding fine."If the penalty is not paid, we will pursue action against her under the Society Act through the registrar and courts. she may not be able to sell her flat," Chahal said.He also recalled a previous incident in which Nair allegedly bit a security guard and a resident during a similar dispute over feeding strays two years ago, further fuelling tension within the community.

According to Chahal, municipal authorities had already approved plans to establish designated feeding points within the society, aligning with broader legal guidelines. But Nair, the RWA claimed, has refused to comply, continuing to feed dogs at her discretion.

Efforts by RWA officials to reach out to Nair for talks have allegedly been unsuccessful. Officials said she initially cited unavailability, and later stopped responding to calls and messages altogether.

# Leachate spills into Aravalis from landfill, pollutes aquifers: Plea

Gurgaon. (Agency) Environmentalists wrote to

Rights Haryana Human Commission (HHRC) on Thursday, alleging that MCG is discharging lakhs of litres of toxic leachate from the Bandhwari landfill into the surrounding Aravali forests, waterholes, and villages, in "contempt" of National Green Tribunal (NGT) orders.According to the complaint, incessant rains created multiple pools of leachate around the landfill site and a massive "leachate lake" spanning 2.5-3 acres in an abandoned mining pit behind the landfill. The pit, the letter states, is dangerously close to underground aquifers, raising risk of large-scale



groundwater contamination in the area.In the letter, which is addressed to the HHRC chairman, the chief secretary of Haryana, deputy commissioner, and Haryana State Pollution Control Board (HSPCB), the activists described the crisis as an ongoing "ecocide/genocide" that has continued for nearly eight years, contaminating

groundwater and soil across the fragile ecosystem. They further alleged that the landfill had expanded over the years, with leachate streams now reaching homes on the outskirts of Bandhwari village. Around 50,000 residents of at least five nearby villages are believed to be exposed to contaminated drinking water as a result, they said. The letter also criticised HSPCB for being a "mute spectator" and relying on monetary challans against MCG, which, it argued, neither deterred repeated violations nor compensated affected communities.The activists pointed out that even after the HHRC chairman's visit to the site in May 2023, "no results"

# 6 lanes, footpaths: Makeover for Dwarka e-way link to NH8 soon

Gurgaon. (Agency)

GMDA is set to move forward with its plan to upgrade the key master road connecting Dwarka Expressway and Kherki Daula on NH8. The revamp of the 2.8km stretch covering sectors 83, 84, and 36A is estimated to cost Rs 24.5 crore. According to GMDA, the project has administrative approval, with the detailed project report (DPR) in place and tendering documents under preparation. The stretch will be developed into a six-lane carriageway with a 14m wide main road, a 10m central verge, and a 40m wide greenbelt along with a footpath, officials said. Streetlights will be installed, a rotary at the junction of sectors 83 and 84 will be constructed, and road safety infrastructure including solar studs, cat eyes, and markings will be put up, officials said."The commute of residents of sectors 81 to 86 and adjoining areas will become smoother after the revamp. Once the work is completed, the road will be safer for both pedestrians and commuters," a senior GMDA official said. Originally built by HSVP in 2010-11, the stretch was part of the Dwarka Expressway project. However, after the alignment of the expressway was altered in 2017, it was excluded from the network. The left-out portion of the road deteriorated soon after and it was only in March last year, ahead of the inauguration of the Gurgaon portion of the

Dwarka Expressway, tha GMDA carried out patchworl repairs to make it motorable However, potholes resurface on the stretch months.According commuters, revamp i necessary to equip the road to handle growing traffic load condominiums and from commercial projects in the area Puran Singh, former RW/president of Coralwood, said The road is in a pathetic state We have sought its revamp fo years, but authorities have carried out only patch repairs We see frequent road accident on this stretch."Rohit Malik, resident of Sector 84, said, "Th road revamp is much needed. # Argument over dog attack spirals out of control, residents come to blows in Gurgaon condo

As the Supreme Court's recent ruling on stray dogs aims to balance public safety with animal welfare — banning feeding in unauthorised places and mandating that only aggressive or rabid dogs be sheltered — tension in urban neighbourhoods is growing with multiple incidents of runins among residents.

This was evident at Climate Tower society in Sector 56 on Tuesday night, when a dispute over a stray dog's behaviour escalated into violence, leaving one resident injured and a divided.The community incident occurred around 9pm, when Anil Sharma — an interior designer — was returning home after a long day at work. According to residents, Sharma was chased and nearly bitten by a stray dog that has been living within the society premises for over a year.In an tension.The cops recorded the Just weeks earlier, a Siberian

attempt to defend himself, Sharma first tried to shoo the dog away with his lunch box. When this failed, he picked up a stick and began striking the animal.At this point, Atul Agarwal — an MNC staffer known in the community for feeding strays — intervened to stop Sharma from injuring the dog. What began as a verbal confrontation quickly spiralled out of control.Residents said Sharma, angered by the intervention, thrashed Agarwal, resulting in injuries to his hand and head. The altercation intensified when members of Sharma's family joined in, escalating the situation as onlookers gathered.Despite the escalating commotion, the society's guards allegedly did not intervene, leaving the residents to manage the chaos themselves.Police were called to the society to quell the

statements of both parties and arranged for Agarwal to be taken to a nearby hospital for the treatment of his injuries.

Till late on Thursday evening, an FIR was yet to be registered, but police confirmed that an investigation had been initiated. The incident has reignited a longstanding tension within the society over the presence of stray dogs. Many residents frustrated by what they perceived as inadequate action from the management voiced concerns about safety.

"Despite paying maintenance fees, we still have at least six stray dogs inside the premises. Whenever we try to have them removed, dog lovers start arguing and create a scene," said one resident, reflecting the deep divide within the community.

The clash is not an isolated event in the city in recent times. Husky attacked a woman during her morning walk on Golf Course Road despite being on a leash, sparking outrage over pet ownership. In another incident in May, a cab driver in Sector 29 suffered grievous injuries after being bitten by a Pitbull, resulting in an FIR against th dog's owner.

Underlying these incidents is a worrying trend. The city recorded 10,067 dog bite cases in 2024 alone, nearly doubling the 5,200 incidents registered the previous year.

This translates to almost 27 reported bites a day, a surge experts attribute to insufficient sterilisation and management of stray dog population. Amid the growing anxiety, the Climate Tower RWA maintained it was acting within the law. "We are proceeding strictly in keeping with the Supreme Court's order. We have nothing further to add at this stage," said .

# 'Mishap was waiting to happen': Scooterist falls into Ghaziabad drain; rescued

Noida. (Agency) GHAZIABAD: A scooterist

had a narrow escape after he fell through a gaping culvert hole into a drain outside Gaur Gravity Mall in Indirapuram and was pulled out by guards before the muck sucked him in. The accident, which happened Sunday morning and became known on Thursday after CCTV footage of the fall emerged, was one waiting to happen, locals said.Drain covers on both sides of Kala Patthar Road, where the mall is located, were removed or broken to clean up drains before monsoon but not put back in place all these months, leaving the busy area prone to such mishaps. The mall management accused the corporation of negligence for not getting the ĞMC, drains covered. meanwhile, accused mall staffers of removing a barricade put around the culvert hole.A 52-second clip, circulating on social media, shows the scooter sinking into the gaping 5-footwide hole as the rider tumbles into the chest-deep wastewater. Moments later, he emerges, visibly shaking, waving for help. Two children, who witnesses the fall, rushes to the mall to raise an alarm. Security guards arrive with a bamboo ladder borrowed from a nearby

construction site and pulls the

man out to safety. His scooter residents' was retrieved later with the help

Rajendra, a guard at the mall, said the incident took place around 8.30 am on Aug 25. "The children came running, shouting that a man had fallen into the drain. We found him struggling in the water. When he finally climbed out, he was



covered in filth, reeking, and had injuries on his neck and back. I remember his first words: 'I am coming straight from hell' (Narq se nikal kar aa raha hoon)," he said. While the identity of the victim

remains unclear, Puneet Kumar, who oversees maintenance, said the injured man managed to call a crane driver to retrieve his vehicle. "The entire incident was recorded on CCTV. We helped him as much as possible. Fortunately, his injuries were not life-threatening," Kumar said. The accident has renewed

concerns uncovered drains along the Kala Patthar stretch. In July, TOI had highlighted that the stretch, from NH-9 to Aditya Mall, has at least 22 open drains, some nearly six feet wide. "Such an incident was bound to

happen," VK Bhatnagar, a resident of Gaur Green City, located 1km from the spot, said. "This is not mere apathy but criminal negligence by GMC. The man was lucky he didn't drown."Another resident, Nirmalendu Mishra, said the video has left residents horrified. "Our children take this road daily to go to school. The drain is at least 12 feet deep. Imagine if it had been a child instead of an adult," he said.Local councillor Preeti Jain echoed residents' anger. "I have repeatedly written to GMC since the start of the monsoon to cover these drains, but nothing has been done. Their excuses about roadside vendors are unacceptable," she said.

Caught in the middle of the storm, GMC shifted blame to the mall management. A corporation official claimed the drain cover had been removed in late July to allow cleaning with an earthmover. "We barricaded the pit after the work, but the mall removed it. We have now put up barricades around the pit again.

# This 'puzzle' in Noida Sector 63 could solve office hub's parking woes

Noida. (Agency)

Noida Authority is planning to build its first automated puzzle parking in Sector 63, which could help solve the puzzles of the city's parking issues. The four-level facility, with a capacity of 100 vehicles (25 per floor), will cost around Rs 16.5 crore. Unlike hydraulic systems, puzzle parking uses a sensor-based mechanism to automatically shift vehicles between floors in 3-6 minutes, offering faster, safer, and more space-efficient parking. The Authority will construct the project, while a private firm will manage operations through RFP.The space is being designed by Orionn Architects. As the name suggests, the facility will work like a moving puzzle. When a car arrives, it will be parked on a movable stand at the ground level. Sensors will then guide the stand up to the desired floor, automatically shifting other stands to optimise space. Each can be retrieved independently, unlike traditional stack parking, with the entire process taking just a few minutes.General manager SP Singh said the facility is designed to ease parking woes in places where space is limited with poor parking conditions. "The detailed project report



(DPR) has been sent to IIT for expert vetting. Once approved, a tender will be floated for construction," he added.

Officials said this system significantly increases the parking capacity, fitting two to five times more cars into a limited space by stacking them vertically and moving them horizontally. This efficient design can be installed in locations various basements, empty plots, or next to buildings, and can be scaled for both small (10-20 cars) and large (100+ cars) projects.

The system is also costeffective as construction is cheaper and faster because it requires less excavation and uses pre-built steel structures. considered

#### Only 1 of 6 cubs born to tigress Aditi survives

New Delhi: The last of three tiger cubs undergoing treatment at the Delhi Zoo has died, leaving only one survivor from a rare litter of six, an official told The Tribune. The cub passed away around 11 pm on Saturday, following the death of two others last week. Tigress Aditi gave birth to six cubs on August 4. Two of the cubs died within the first week — on August 8 and 10 — after struggling to feed and being admitted for hand-rearing. Three more cubs fell ill around August 20-21 and were hospitalised with high fever and infection. Two of them died on August 22, while the third one succumbed on Saturday. The surviving cub has been undergoing treatment at the zoo hospital since August 15. Samples from all affected cubs have been sent to the Indian Veterinary Research Institute (VRI) to determine the cause of the infection, which remains unknown. Zoo Chief Veterinary Officer Abhijeet Bhaval said three cubs were admitted with infection and high fever on Thursday morning. Two of them died the same night. #### Robbers loot Rs 9.5L at gunpoint from gold loan office in Gurugram

Gurugram: Five armed miscreants, posing as auditors, fled after looting cash worth Rs 9.5 lakh at gunpoint from a branch of Manappuram Gold Loan here on Saturday evening. 

Chinese victims of online sexual abuse face uphill battle in finding justice latest demands.A challenging

Telegram channel with hundreds of thousands of subscribers that offered revenge porn, hidden-camera videos and other non-consensual content of Chinese women has highlighted gaps in laws protecting victims of sexual abuse in China.The uproar over the online group comes after Chinese authorities have silenced public activism over women's rights in recent years, even sentencing some activists to prison for promoting

The Telegram channel called MaskPark, which offered pornographic content in Chinese, came to national attention in recent weeks and was quickly shut down by Telegram. But activists say alternate channels have already emerged, with only some being shut down. Now activists are calling for ways to help women whose images have been posted. They want police to go after the posters or channel administrators, or even Telegram. They also seek a targeted law to address nonconsensual sexual online content, which they see as a form of sexual abuse. China's Ministry of Public Security and the State Council Information Office did not respond to a request for comment, and have not commented publicly on the path to courtWomen in China whose images have been shared online without their consent face an uphill battle in pursuing justice. The only woman who has come forward about MaskPark is known as Ms. D, according to a report from Southern Metropolis Daily, a



state-backed news outlet in Guangdong province. She says she received a private message in May claiming photos and videos of her were on the channel.There, she found images of her being intimate with a Canadian citizen who was her boyfriend at the time, said Li Ling, an activist and researcher on gender-based violence who works with a team to assist women exposed on MaskPark. The AP could not reach Ms. D or other women independently.

When Ms. D reported the case to police, she found the images had been deleted. She consulted with lawyers but

found there is no law in China specifically addressing what had occurred, Li said. This means a lot of police officers do not know how to lodge a case," Li said.But there are other challenges. To file a lawsuit, even a civil one claiming damages, the perpetrator's identifying information is needed, Li said.

It is impossible to tell who posted the images. Telegram is blocked in China, which allows only apps that cooperate with the government's censorship apparatus. Users can access Telegram via a virtual private network, which provides an encrypted connection. And Telegram doesn't verify the identity of users. It is unclear who ran MaskPark, and the AP could not contact them.

Telegram said in a statement to the AP it "completely removed the MaskPark channels" and that moderators continue to monitor the platform "and accept user reports — so that if such groups ever resurface, they are immediately removed once more."Telegram was founded by Pavel Durov. Last year, French authorities arrested Durov over charges that the platform was being used for criminal activity that included drug trafficking and child sex

abuse material.

# Parents of students killed in Minneapolis church shooting share emotional pleas

The parents of the two schoolchildren fatally shot in a Minneapolis church spoke out for the first time on Thursday afternoon, with some imploring the shaken community to address the root causes of shootings that target schools.Fletcher Merkel, 8, and Harper Moyski, 10, were killed on Wednesday morning when a shooter opened fire at a Mass that hundreds of students at Annunciation Catholic School attended.

The 10-year-old's parents said that they were focused on healing in the wake of the shooting, but added that they hoped Harper's memory would fuel action that might prevent shootings going forward.No family should ever have to endure this kind of pain," Harper's parents wrote. "We urge our leaders and communities to take meaningful steps to address gun violence and the mental health crisis in this country."Remembered by his life, not death

Fletcher Merkel's father, Jesse Merkel, tearfully read a statement on Thursday outside of the church where



his son was killed, saying the eight-year-old loved his family and friends and enjoyed fishing, cooking and playing any sport.

Because of the shooter's actions, Merkel said, "we will never be allowed to hold him, talk to him, play with him and watch him grow into the wonderful young man he was on the path to becoming."

"Please remember Fletcher for the person he was and not the act that ended his life," Merkel said.

# IITGN develops 'maida-free' millet-based premixes for brownies, muffins and dhokla

Indian Institute Gandhinagar (IITGN) has developed milletbased premixes without any form of wheat for making baked food items such as muffins and brownies and steamed items like dhokla.

It has also applied for FSSAI licence before its launch in the market through food start-up Plantro Private Limited at the Research Park of the

Two patent applications for ragi brownie and jowar muffin under "Millet-based premix formulation for baked desserts a process for its

preparation" and sorghum dhokla under "Millet-based premix for steamed-fermented products and a process for its preparation" are filed earlier this year by the Department of (Jointly Chemistry Sciences Biological Engineering department) at the

"Applications for the two patents have been filed in May this year. Usually, the first round of decision takes around 6-8 months, so we are expecting a decision on the application by the end of the year. Our premixes do not incorporate wheat or any other flour. The premix formulations have been



analysed for their biochemical performance via standard digestibility assays that test the release of sugars upon breakdown of the products in presence of digestive enzymes. Also, in vitro protein digestibility of the premix

antioxidant performance of the native millet flour used in each case," Prof Bhaskar Datta from the Department of Chemistry, IITGN, told The Indian Express. Recalling the interest the

institute developed in the area which, he said, is something unusual for the IITs, Prof Datta explained, "Barely 2-3 IITs have food processing or food science departments. Our research group at IIT Gandhinagar has been dabbling in various aspects of food biochemistry over the past

several years. The team while working on the artificial meat or plant-based meat got drawn towards millet-based products that further led to developing milled-based premixes." "Much of this work has an

analytical focus and we have been interested in identifying and mitigating food hazards such as acrylamide in fried foods, and novel detection methods for herbicides and pesticides in raw fruits and vegetables. Our immersion in this line of work and engagement with the broader community of food scientists spurred an interest in processed foods," he added.

# Floods inundate paddy on 2.90 lakh acres; over 400 villages marooned in Punjab

Chandigarh . (Agency) Floodwaters

devastated large swathes of Punjab, submerging around 2.9 lakh acres of farmland across more than 400 villages in over half a dozen districts.

Officials said that most of the inundated land was under paddy cultivation, raising fears of massive crop losses at a time when harvesting is just weeks

According to official figures, over 400 villages are under floodwater, including nearly 46 in Sultanpur Lodhi subdivision of Kapurthala district. While 6,000 people still live in about 16 of these villages, 30 villages, though uninhabited, are intensively farmed and now lie under water.

Apart from Kapurthala, the flood has affected 23, 150, 100, 50 ,65 and 15 villages in Gurdaspur,

# Pune Metro ridership surge continues, 2.13 lakh passengers per day in August

According to Maha Metro, one of the reasons for the surge in ridership in Pune Metro is the increase in peak-hour frequency to 6 minutes from 7 minutes.

Continuing the trend recorded over the past two months, the Pune Metro also recorded a significant boost in ridership in August. An average of 2,13,390 rides per day were recorded in the month on both the Purple and Aqua lines combined, according to the Pune Metro website as of Wednesday. This is a notable increase from the numbers recorded in July (1,92,204) and

June (1,74,702). As reported by The Indian Express, the Pune Metro had already seen a significant increase in average daily rides in July, as compared to the average daily rides of the previous 10 months. # Govt approves Rs 20,787 crore for land acquisition for 802 km Nagpur-Goa Shakti Peeth Expressway

Mumbai. (Agency)

Maharashtra on Thursday approved the land acquisition and alignment for the Nagpur-Goa Shakti Peeth Expressway, a high-speed corridor stretching 802.59 km across 12 districts, 39 talukas and 370 villages, linking Pawnar in Wardha district to Patra Devi in Sindhudurg district. The government granted an approval of Rs ₹20,787 crore for land acquisition.

The expressway will connect major Shakti Peethsincluding Tuljapur, Kolhapur, Mahur, and 18 other religious sites—while reducing travel time between Nagpur and Goa from 18-21 hours to around 8


In a Government Resolution (GR) issued on Thursday by the **PWD** department, administrative approval was granted for ₹20,787 crore— ₹12,000 crore principal and ₹8,787 crore interest—for land acquisition. The Maharashtra State Road Development Corporation (MSRDC) will implement the project, with the state covering any revenue shortfall to ensure timely repayment of the HUDCO loan.

# hunger strike at Azad Maidan, thousands reach Mumbai

Mumbai . (Agency) Maratha reservation activist Manoj Jarange Patil began an indefinite hunger strike at Azad Maidan in Mumbai Friday morning, reiterating his demand for quota benefits for the Maratha community and vowing not to withdraw the agitation until their demands are Even as Jarange Patil

launched his latest protest, groups of Maratha activists blocked the road opposite Chhatrapati Shivaji Maharaj Terminus (CSMT) and the Brihanmumbai Municipal Corporation (BMC) headquarters, disrupting traffic in the busy area. The road blockade added to the city's traffic woes during peak hours, despite the activist's repeated appeals to supporters to maintain peace and not inconvenience Mumbaikars.

The protest comes amid fresh rules notified by the police on August 26 under the Public Meetings, Agitations and Processions Rules, 2025, which prohibit protests after 6 pm and cap participation at 5,000 people. However, according to the Social Service unit of the Mumbai police, nearly 40,000 people are expected to take part in the rally, far exceeding the permitted limit and in violation of the notification. Patil, however, insisted that the grant authorities should permission for the agitation to continue until the demands are fulfilled. "We have come to because Mumbai government did not cooperate with us. The authority to grant permission lies with the government, and we have requested them to allow us. If not the government, then the courts will give us permission,' he said on reaching the protest venue. The activist declared that he was prepared to make the ultimate sacrifice for the Maratha cause. "I will die, but won't back down this time. We will not leave Mumbai until our demands are met," he asserted.

Addressing thousands of supporters, Jarange Patil repeatedly appealed for restraint and discipline during the protest. "Cooperate with the

police. Do not Mumbaikars. Don't do anything that would bring disrepute to the community. Do not pelt stones or set anything on fire. Remain peaceful," he urged.

"I should not be hearing any news of misbehaviour from you. I don't want to hear that Mumbaikars have been troubled or are unhappy with us," he added.

He further instructed community members to stay in Vashi at night and gather at Azad Maidan only in the morning, while encouraging those who had travelled from distant villages to return after the day's protest. "Now that I have begun my fast, you do not need to worry. Those who wish to return to their villages may do so in the evening — you don't have to remain here. I am here now, and

According to the Mumbai police, nearly 40,000 people are expected to take part in the protest rally seeking Maratha quota reservation, far exceeding the permitted limit.

I will not back out until the Marathas get reservations," he said. "Even if the government shoots me down or puts me in jail, I will not withdraw until our demands are met," Jarange Patil said, adding, "I won't get 'managed' till the last breath of my life." He also made a direct

appeal to Maharashtra Chief Minister Devendra Fadnavis. "Fadnavis saheb, this is your opportunity to win the hearts of the Marathas... We have only one demand and that is reservation," Pail said.

The Maratha community, which comprises over 30 per of Maharashtra's cent population, has demanding reservation in education and government jobs for several years.

## Shifting geopolitical imperatives between necessity and trust

US President Donald Trump issued a blunt warning on Tuesday: "It will not be a world war, but it will be an economic war." Though directed at Russia, the message reverberated around the world. The era of economic neutrality is ending. Nations caught between competing powers face growing pressure to pick a side. India, delicately balancing ties with Washington, Moscow and Beijing, stands at a crucial strategic crossroads.

As US economic and geopolitical demands intensify, a critical question arises: if relations with Washington deteriorate, can China replace the US as India's primary strategic business partner? The answer is not straightforward. While trust between India and China remains limited, necessity often overrides hesitation in international relations. India's trade with China is vastcovering electronics, chemicals, machinery, and more. This relationship is pragmatic, not based on shared values or strategic alignment. Despite the ongoing border disputes, China's roles as the world's manufacturing hub and India's immediate neighbour make it an indispensable economic partner India cannot easily ignore.

Meanwhile, the India-US partnership—grounded in defence ties, technology cooperation, and shared democratic values—is showing signs of immense strain. Built over 25 years as a counterweight to China's rise, this relationship



now risks unravelling. Ironically, as Washington demands greater alignment from New Delhi, particularly on issues like Russia and global security, it increasingly risks pushing India away. Rather than solidifying India's position within a US-led coalition, Washington's shifting priorities risk nudging New Delhi closer to Beijing's orbit. The subtle retreat from actively supporting India as a strategic counterweight creates a vacuum Beijing is ready to fill.

China cannot fully replace the US in innovation, strategic trust, or access to advanced markets. However, Chinese capital, which is often politically conditioned, and its vast manufacturing ecosystem remain hard to ignore. India's biggest hurdle is urgent domestic reform, modernising infrastructure, cutting through winding bureaucratic processes, and building a competitive manufacturing sector. Without strategic leverage in globally critical sectors, India risks losing ground in any trade war. Meanwhile, Trump's economic war doctrine should end all ambiguity—India must act decisively, balancing pragmatism with principle. China may be far from an ideal partner, but necessity can outweigh trust. Meanwhile, the US, by not fully backing India as a counterweight, risks quietly ceding regional influence.

# Time to revisit Special Intensive Revision

Both parties seem to be panting as they attempt to prove their point.The ECI has already announced that all states must go through the rigorous SIR exercise next year. In some states, the preliminary work might have begun. Can some lessons be learnt from the

The ECI has a reputation of being sound on protocols, managing the most arduous exercise through elaborate and meticulous standard operating procedures, which it drills down to its machinery through repeated training. That its instructions lacked clarity in the Bihar SIR is surprising.

For example, it should spell out in detail the basis on which booth-level officers (BLOs) are expected to make their recommendations on the enumeration forms submitted by the electors, which was not clearly specified in Bihar. Similarly, the criterion for scrutiny by the supervisory

officers of cases not recommended by BLOs and officers the stage of the scrutiny should be clearly stated. This, too, was unclear in Bihar. It is puzzling why the ECI didn't disclose the number of enumeration forms out of the 7.24 crore received till July 25 without the prescribed documents. Why is it that thereafter the ECI stopped disclosing the number of electors submitting documents daily?While adhering to the letter and spirit of Article 326 of the Constitution regarding eligibility, the ECI needn't dabble explicitly determining citizenship, something that it has avoided in the past but which it unnecessarily emphasised in its June 24 order.

The SIR has so far not removed any significant number on account of noncitizenship, a valid ground for ineligibility.

Those not included in the draft electoral for having "permanently shifted" cannot be termed "ineligible" as per Article 326. They are 'ineligible' to be included in the rolls of the polling station that they were earlier in without their 'citizenship' being questioned. Therefore, separating the pre-2003 and post-2003 electors on the basis of "presumed citizenship" was fallacious and created an avoidable storm over the ECI's motives, exposing it to the accusation of overreach.A comprehensive exercise of this nature cannot be abrupt in its timing, aggressive in its procedure and ambitious in its

# A tweak to make finance commission recommendation fairer



Finance commission recommendations are, technically, a zero-sum game, where a tweak in the criteria cannot be carried out to benefit all the states—a gain for some states is a loss for others. So, finance commissions always have a very tight rope to walk. Until the 7th Finance Commission (FC), only two criteria for devolution were used—population and state contribution towards income tax collection, with 80-90 percent, and 10-20 percent weights, respectively. The 8th FC breaks this tradition and introduces multiple equity criteria, with per capita income distance getting more weight, and remaining a dominant criterion for the past eight commissions. Population and income distance constitute nearly 70 percent of the weights, and most of the remaining 30 percent is distributed across fixed geographic criteria like area and forest cover, with little weight assigned to efficiency. We must wait to see whether the 16th FC paves a new direction by

drastically changing the criteria by

giving more weight to efficiency parameters, or follows the same path as their predecessors by slightly modifying the weightage, or reintroduces some of the past criteria so that there is no drastic change in inter se shares. With a maximum weight, the income distance criterion becomes the most contentious one for the progressive states with higher percapita incomes, as they get a lesser share in the devolution. With no incentive for performance, the states with low per-capita income lack the

urge to move up the ladder. The basic idea was to make the playing field more level by compensating poorer states to move up in ranks; but the data suggests otherwise. Over the past four decades, there has been no change in the ranks of the states.uccessive FCs calculated the income distance by considering the latest available three-year data on each state's per capita gross state domestic

product (GSDP), and an average is

calculated to smoothen the variation.

The income distance for a particular state is the difference between its percapita GSDP from the highest percapita GSDP state. If the state with the highest average is a small one, the next comparable state's average is considered. This distance, multiplied by the state's population, was used to calculate the share. Since the states' ranks on this average remains the same, this method is skewed towards favouring those at the bottom with a higher share and limiting the share for those at the top. A simple readjustment to this criterion can benefit states fairly and push them to improve their percapita GSDPs. Consider the per-capita GSDP for all states reported by the last FC, and similarly, calculate the average per-capita GSDP for all states for the latest three-year period. The growth rate between these two averages is the minimum expected growth of the average per-capita GSDP.

We can derive the expected per capita GSDP for each state from this growth rate, and the income distance for each state is calculated as the difference between this expected per capita GSDP, and the highest expected per capita GSDP of a comparable state. This distance multiplied by the state's population can be used to derive the share for each state.

The computed expected level for each state should be kept as the base for calculating the income distance by the successive FCs.

To explain this, let's take the average per-capita GSDP of the states considered by the 14th and 15th FCs. The average has grown by 94.8 percent, from `64,290 to `1,25,246, between the two commissions. So, by benchmarking the minimum expected growth at this level for all states, the expected average percapita GSDP level can be derived. Since the compensation to bridge this income distance has been given by the 14FC, it is anticipated that the states will grow at the expected level for the 15FC period. So, calculating income distance with actual data will always favour the states that are not coping well with growth.

Deriving income distance based on this expected level solves two problems. First, it does not punish the states that grow above the expected level; instead, it pushes the states growing below the expected level to pay the price for the gap they miss.

Second, since this expected level would be set as a base to calculate the expected level of average per-capita GSDP of each state in the next commission's period,

it pushes the states that are above the level to maintain the same speed; but pushes those below the level to grow faster than what is needed to maintain the expected level. With this readjustment, the share of the income distance criterion across states may not change drastically. The difference between the actual and readjusted shares stands at around 5.6 percent for the 15FC period, indicating that only 5.6 percent of the share has been redistributed between the performing and emerging states. But it provides a stable criterion with a predictable target for the states to turn their wheel of performance towards the future.

# The two Indias facing America for decades

We live in two Indias. They are starkly juxtaposed against each other in situations such as the ongoing tariffs challenge from the US. Of the two, one India is adept at making a case that this country will fall behind unless it recognises that Donald Trump is not unreasonable in his demand for balanced trade. This India argues that the Narendra Modi government ought to use Trump's threat of higher tariffs—at least his initial demands—as an opportunity to usher in the next wave of economic reforms. This India also views Trump's tariff imposition as a chance to raise this country's competitiveness in industrial production and other business activities. The other India is more rooted in the realities of this country, sensitive to the conditions of ordinary Indians. It does not have the tools at its command to make a case that Trump's actions and behaviour are symptoms of a deep-rooted malaise. So far at least, Prime Minister Modi has not called the spade in Washington a spade. Lula da Silva, President of Brazil, also facing high tariffs, has said Trump was elected "not to be the emperor of the world". Modi is still hoping for a trade deal and has been advised by his trusted aides not to escalate matters with the volatile and unpredictable White House. Hidden behind these symptoms is Trump's chronic disease, which India must not overlook. At the root of what Trump is seeking is a haughty and imperial imposition on sovereign

This disease is not limited to tariffs. He wants to make Canada the 51st US state, take over the Panama Canal and get Denmark to surrender its autonomous island of Greenland to the US. What if Trump demands one day that in the interest of permanent peace in South Asia, Jammu and Kashmir should be placed under Washington's trusteeship? Until 1994, when the United Nations Trusteeship Council was wound up, many territories from Tanganyika in Africa to Nauru in Oceania were administered by major powers as they moved step-by-step towards self-government or independence. It is not inconceivable that in Trump's view, Jammu and Kashmir fits this bill. After all, he wants to ethnically cleanse Gaza Strip and develop it into a riviera of the Arab world. As India begins its life under the highest tariffs imposed by the Trump administration, those who are in favour of surrendering to Washington are painting a dismal picture ahead. This India foresees sectors of industry primarily sustained by the American market collapsing, high unemployment in information technology business and a slowdown—if not an end—to business process outsourcing to Bengaluru or Hyderabad. They insist that the loss of the US market for Indian goods and services cannot be compensated for in the foreseeable future. There is a sense of déjà vu in this. When India tested nuclear weapons in 1998, triggering automatic sanctions under America's penal 'Glenn Amendment' non-proliferation legislation, one India similarly predicted unimaginable disaster for this country.

#### **Telangana High Court questions** nod to blasting in Jubilee Hills

HYDERABAD. The Telangana High Court on Thursday took suo motu cognizance of reports on continuous blasting for rock removal in Jubilee Hills, which residents said was causing severe inconvenience.

The case came up before a bench of Chief Justice Aparesh Kumar Singh and Justice GM Mohiuddin after Justice Nagesh Bheemapaka drew attention to complaints from Nyaya Vihar, Bharani Layout and around Ramanaidu Studios, where over 10 blasts were reportedly taking place daily.

During the hearing, Additional Advocate General (AAG) Md Imran Khan sought two weeks to file a counter on behalf of the State. He said blasting permissions were limited to 10 am-4 pm and promised a detailed affidavit on whether nighttime activity had occurred after March 31, 2025.

Senior advocate P Sriraghuram, for DSR Prime Spaces, said blasting was already completed with required approvals, backed by a PCB affidavit. The bench questioned the authority of the police commissioner to issue permissions.

# **Yellow Line crawling': Delhi Metro riders fume** as morning commute turns chaotic

Officials said services were being gradually normalised and efforts were underway to restore smooth operations on the affected section.

The Delhi Metro's Yellow Line was hit by major delays on Friday morning after a sudden snag disrupted peak-hour services, leaving hundreds of commuters stranded and

The Line, which runs from Samayapur Badli Millennium City Centre Gurugram stations, connects major areas such as key South Delhi locations of Hauz Khas, AIIMS, Central Secretariat, and University, among others.

"Service Update: Delay in services between Vishwavidyalaya and Central Secretariat stations. Normal service on all other lines," the Delhi Metro Rail Corporation (DMRC) said in a social media post early Friday morning. The slowdown and delay in services



are due to a signalling issue, according to DMRC officials. They said services were being gradually normalised and efforts were underway to restore smooth operations on the affected section.

Delhi Metro commuters, meanwhile, took to social media to complain about crowding on Metro stations and train delays. They also complained that services on other lines, as well as other sections of the Yellow Line, were disrupted.

"Yellow Line metro is crawling from Badli to Vishwavidyalaya as well. We are getting late...," a passenger posted on X.

Another said: "What's wrong with Yellow Line Metro Gurgaon like this."

Some commuters were also dismayed at the service disruptions, considering the metro fare hike that took place

"Metro delay was on the red line, also train arrived after 15 minutes and on yellow line train is running at a speed of 5 kmph. It took 30 minutes to reach Rajeev chowk from Kashmere gate. METRO have increased the fare but services are not upgraded (sic)," said a commuter,

After a gap of eight years, the DMRC on Monday had revised fares. The hike ranges between Re 1 and Rs 5 per passenger, depending on the Metro line and distance.

Labelled 'minimal', the revision has been made because the "financial condition of the corporation was in considerable strain," officials had said.

Before Monday, the fare ranged between Rs 10 and Rs 60. After the increase, the Metro fare ranges from Rs 11 to Rs 64. Fares on the Airport Express Line have gone up by up to Rs

The revision also applies to Sundays and national holidays.

An eight-year-old girl was crushed to death in Northeast Delhi's Maujpur after the erickshaw she was travelling in overturned on Wednesday morning. Police were informed about the incident from Guru Tegh Bahadur Hospital, where the girl was declared brought dead by doctors. In his statement to the police, the girl's father has alleged that the incident took

place when his wife was dropping their daughter off to school in Shahdara.

The driver was allegedly driving rashly and took a sharp turn near Maujpur Chowk when the vehicle overturned, crushing the girl underneath it, said police. "She was immediately taken to GTB Hospital by her mother, where the doctors declared her as brought dead," said a senior officer. The e-rickshaw driver is

# Delhi loses a food entrepreneur, culinary artist



New Delhi. (Agency) Her pioneering role in Delhi's culinary landscape, her quiet contributions to cinema and memories of her warmth, resilience, and generosity were recollected as friends, family, and admirers gathered to celebrate the life of Utpala Mukherjee (née Hazarika) at the India Habitat Centre (IHC) on Thursday.

Mukherjee passed away on August 19 during a visit to Assam. She was 70.

A prayer service was held at Sai Baba Mandir in Mayur Vihar on Thursday morning, which was followed by a memorial gathering and dinner at the IHC.

Born on June 17 1955, Mukherjee studied history at North Eastern Hill University (NEHU) and Jawaharlal Nehru University (JNU). After a stint in sales and later in government service during the 1980s, she turned to food entrepreneurship. In the mid-1990s, she launched Haowin, a Chinese eatery in Mayur Vihar that quickly became popular. She went on to

manage Haveli, a North Indian restaurant; Howrah Junction, a Bengali restaurant; Mosaic, a pan-Indian restaurant and Baankaahi at Assam Bhawan. She also co-established Spice Route in Windsor, UK.

Mukherjee ran a thriving catering business from her home, preparing meals for gatherings, clients, and cultural events across the Capital. "She was one of the pioneers in bringing Assamese food to a wider audience in the city,' recalled filmmaker Utpal Borpujari.

"Long before food pop-ups and Humayunpur's restaurants, her menus gave many Delhiites their first taste of Assam," he remembered.

Her seniors and friends at JN U remembered her as "spirited" and "graceful". Abhilasha Kumari, one of her friends from her JNU days, recalled, "She was a lovely, beautiful girl — almost angelic. Later, she became a culinary artist, bringing together dishes from across Assam and presenting them with pride.

# Delhi zoo shut after bird flu outbreak, safety measures stepped up

The outbreak was confirmed following the deaths of painted storks and black-necked ibises, said officials

New Delhi. (Agency)

An avian influenza outbreak has been confirmed at the Delhi painted storks and black-necked ibises, said senior officials. The zoo has been shut to visitors, and heightened biosecurity measures are in place, officials said. Zoo director Dr Sanjeet



Kumar confirmed the closure. Further details are awaited. Routine samples from the

dead birds were sent to the ICAR-National Institute of High Security Animal Diseases in Bhopal. "The report, received on Thursday night, confirmed the presence of avian influenza," a source in the zoo said. Officials added that the next 21 days will be critical in containing the spread of the virus. This marks the third recorded avian influenza outbreak at the Delhi Zoo, with previous incidents reported in 2016 and 2021. Sources said that all captive and migratory

being closely birds are monitored, and segregation protocol is in place to prevent further deaths. Tiger and lion cubs will also

be under special observation, as previous reports indicate that tiger deaths have occurred in large zoos due to avian flu, a senior official noted. Recently, the zoo had

witnessed five Royal Bengal tiger cub deaths out of a litter of six due to infection and weakness. The Central Zoo Authority has laid out general precautions for visitors as well as zookeeping staff in such situations. Among the specific

biosecurity measures that need to be taken include testing of captive birds, segregation of birds, and disinfection of premises. "As soon as the disease is confirmed as H5 or H7 Avian Influenza, the control actions to be initiated are the same as for domestic poultry," the CZA has said. It added, "However, wild/endangered/ precious captive birds confirmed as non-infected may be exempted from culling. Visitor entry needs to be stopped forthwith."

In addition to sampling of birds, environmental samples like water, soil, etc, are to be collected and sent for testing, as per the guidelines. According to CZA, "Sampling has to be repeated every 15 days for at least 4 times; if consecutive two samplings from the last positive result are found negative, then the opening of the zoo for the public may be considered by the competent authority."

# Delhi Police bust sex racket, rescue 4 women, 1 minor girl from 'brothel'

The Delhi Police on Thursday night busted a sex racket and rescued four women and a minor girl during a raid inside a house in the outer North Delhi's Swaroop Nagar.

The raid was conducted based on a tip-off from an NGO that women and girls are being forced into sex work at the alleged brothel run by individuals identified as Devesh Yadav, Arjun Kumar, and Bharti, the police said.

A police team, accompanied by women officers and the NGO staffers Shivam and Jyoti, set up a decoy operation. "An advance payment of Rs 1,000 was made on the QR Code of the broker through Shivam. As a decoy customer, Shivam was sent to the address, and on his gesture, the raiding team raided the premises. We found five women along with five men present at the spot," said Hareshwar Swami, Deputy Commissioner of Police, Outer



The police said that they are interrogating five men — Yadav, Arjun Kumar, Sajid, Akhilesh, and Rajnish — who were present at the house. Sajid, Akhilesh, and Rajnish were identified as 'customers', according to an officer.

During questioning, three women allegedly said that they had been hired by the accused to provide sexual services.

The five rescued victims include a 35-year-old woman from Samaypur Badli, a 50year-old from Swaroop Nagar, a 25-year-old from Shahbad Dairy, a 52-year-old woman,

and a 15-year-old girl.

The police said the minor has been sent to a shelter home in Bakhtawarpur, where her statement is being recorded with the help of counsellors.

Investigators recovered 35 packets of condoms and a diary containing the QR code used for the payment.

A medical examination revealed that one of the rescued women tested positive for

pregnancy. The police have registered a case under sections 3, 4, and 5 of the Immoral Traffic

(Prevention) Act at the Swaroop Nagar police station.

# In Delhi, Cabinet likely to hear draft note seeking PWD's engineering cadre next week

New Delhi. (Agency)

Eyeing its own engineering cadre, the Delhi Public Works (PWD) has Department submitted a draft note before the Cabinet seeking its approval, officials said on Thursday. The note is likely to be put up before the Cabinet in its Tuesday

The Indian Express had reported in July that in a major administrative reform, the Delhi government is planning to create its engineering cadre under the PWD. At present, the Public Works Department (CPWD) deputes engineers to the PWD to carry out works and can also decide on the postings and transfers of the engineers.

Officials said that at present, barring PWD, other civic agencies that manage roads like DDA, NDMC and MCD – have their own dedicated

engineering wings. A senior PWD official said that before the draft note was sent to the Cabinet, it was shared with Finance, Planning and Law departments for comments.

According to an internal document, the draft note seeks to "create a new cadre in the PWD engineering wing and to initiate the process of forming the new cadre...'

"A committee of experts and retired senior officials would also be constituted to study and recommend a roadmap for operationalising the wing," said a senior PWD

Officials said the draft note also seeks to "authorise PWD to take any consequential and necessary steps to achieve the objective of creating of the new cadre in a phase wise manner with the approval of the competent authority".

Officials said that once the Cabinet approves the draft note, the PWD will initiate the recruitment process, ensuring that each level – from junior to chief engineer – is staffed by officers exclusively under Delhi PWD's control.

"This is a turning point not just for Delhi PWD, but for the entire city. When engineers are accountable only to the people of Delhi, their performance and commitment automatically rise. We are building a stronger, cleaner, and faster Delhi, and we need our own team to do it," PWD Minister Parvesh Sahib Singh had said in July.

According to officials, till now, PWD has relied upon engineers, executive engineers, superintending engineers, and junior engineers deputed from

# Delhi residents could live 8.2 years longer if air pollution curbed: **Chicago University Report**

Residents of Delhi could live 8.2 years longer on average if particulate concentrations were reduced to meet the World Health Organization's (WHO) guideline, according to a report.

The Air Quality Life Index, developed by the University of Chicago, states that the AQLI is a pollution index that converts particulate matter levels into perhaps the most important metric that exists, namely, their impact on life expectancy.'


According to the report, India is among the most polluted countries in the world, and ranks second out of 252 countries, "potentially losing a total of 4.9B years".

It stated that air pollution is the number one cause of death in the country. "Particulate air pollution (PM2.5) shortens the average life expectancy by 3.5 years in India, relative to what it would be if the World Health Organisation (WHO) guideline of 5μg/m³ were met".

"In India's capital, the National Capital Territory (NCT) of Delhi, an average resident could live 8.2 years if particulate longer concentrations were brought down to meet the WHO guideline. This is the highest potential gain in life expectancy across all regions globally," the report said.

"The biggest increase in particulate pollution occurred in NCT of Delhi, with pollution concentrations increasing by

# 'Unauthorised absence' during probation: Services of JNU faculty member terminated

New Delhi. (Agency)

A faculty member at Jawaharlal Nehru University (JNU) has been terminated for university administration described as "unauthorised absence" during his probation period. The taken decision university's Executive Council on August 26 has drawn sharp criticism from the JNU Association Teachers' (JNUTA), which called the "illegal termination barbaric".

Rohan Vekatesh Halapeti Choudhari, an assistant professor on probation at the Centre for Political Studies, had joined JNU last April. He allegedly officially availed two days of personal leave on May 16 and 17, last year.

However, he only returned to work on July 8, after 51 days, which also included vacations that could be availed by JNU faculty members. During this period, he had only informed the JNU chairperson over the phone about extending his

In an email written on July 5, 2024, Choudhari allegedly admitted to misreading the academic calendar and cited a family emergency for his prolonged absence. "It was a serious oversight compounded by my limited familiarity with the university's procedures," he wrote, adding that he was taking steps to prevent such errors. He also submitted medical documents relating to the illnesses of his son and fatherin-law, but the same were not accepted by JNU authorities.

On January 17, this year, Choudhari sought to adjust a part of his 51-day leave as Earned Leave. The JNU administration, however, directed that a showcause notice be issued to him. The notice was formally sent on August 1, and Choudhari's reply was deemed unsatisfactory.

After granting Choudhari a personal hearing on August 20, the committee concluded that he had violated leave and the Civil Services Central (Conduct) Rules, recommended disciplinary action against him.

JNUTA, meanwhile, has strongly opposed the decision, arguing that "no case ever existed for any kind of disciplinary action... let alone such a severe one as termination".

It alleged the move was driven by "the settling of a personal score" and described the process as "pockmarked with illegality after illegality, and outright falsities".

Earlier, BCCI secretary Devajit Saikia confirmed that the deal with Dream11 has ended and the board is putting the process in motion to get new title sponsor for various national teams.Our stand is very clear. With government regulations in place, the BCCI cannot continue its sponsorship relationship with Dream11 or

any such other gaming company. Under the new restrictions, there is no scope and we are facing a roadblock



# Rupee under pressure amid tariff jitters; markets show tentative recovery

CHENNAI: The Indian rupee remains under pressure against the US dollar, slipping again on the second day. The currency was trading around 87.76–87.80 per dollar in early deals on Friday. On Thursday, the rupee briefly snapped its five-day losing streak, closing at 87.62 per dollar, helped by a greenback speculation of Reserve Bank of intervention.Persistent foreign

outflows and importer demand weighed on the currency, mirroring broader weakness in Asian peers. In the past two trading sessions alone, FIIs have sold more than \$1 billion worth of equities. Traders expect the RBI to act as a stabilizing force and prevent sharp depreciation beyond the 88 mark. Technical indicators suggest near-term support for the rupee at 87.40–87.50, with Thursday's sell-off when

While the equity markets staged a mild recovery on Friday after sharp losses earlier in the week triggered by the US decision to impose steep new tariffs on Indian exports. The Indian rupee hit a record low against the US dollar on Friday, dropping to 87.9650, weighed down by investor jitters over steep US tariffs on Indian goods. Washington recently imposed an additional 25% tariff, doubling India's total duties to 50%, triggering a sharp market reaction.

But the currency story doesn't end there. Against the offshore Chinese yuan, the rupee fell even further, touching 12.3307, marking a 1.2% decline for the week and 1.6% for the month. Over the past four months, the rupee has slumped nearly 6% versus the vuan. Economists say the contrasting US tariff treatment for India and China is behind the move. While Indian exports face a punishing 50% duty, Chinese goods are subject to a lower 30% tariff, with higher

He wrote on LinkedIn, "We celebrate people who are cashrich. Big salaries. Bigger titles. Fancy lifestyles. But here's the truth: a person earning Rs 2 lakh a month but working 16hour days isn't wealthier than someone earning Rs 1 lakh a month with evenings free to spend with family.

"He explains that while money can buy material



time brings something far more important, i.e., life itself. "Money buys

Time buys life," he noted, highlighting how many people end up trading away precious hours in pursuit of higher incomes. Walia also pointed out



the hidden cost of being what he calls "cash-rich but time-poor." He said, "When you're cashrich but time-poor, every purchase is just compensation. New phones to escape, vacations to recover, gadgets to distract." In contrast, when people have time on their side,

even smaller earnings feel abundant, as they are spent on meaningful experiences.For him, true wealth is measured not by a salary slip but by how present one is in life. "True wealth isn't about how much money you make. It's about how much time you control. Because at the end, nobody remembers your salary slip. They remember whether you showed up," Walia said.His words strike a chord in today's fast-paced world, where long working hours and constant stress often leave little room for family, hobbies, or rest. Walia's message is a reminder that while money is important, time is priceless, and finding the right balance is the real success.

# Sensex, Nifty open higher after two-day sell-off amid US tariff jitters

Benchmark indices opened on a positive note on Friday, offering some relief to Dalal Street after two straight sessions of heavy losses triggered by U.S. tariffsAt 9:22 am, the S&P BSE Sensex rose 112 points to 80,193.25, while the NSE Nifty50 gained 45 points to 24,545.90. Broader markets also edged higher as volatility eased slightly. The uptick comes after a sharp 1,500-point Sensex

plunge over the last two sessions. The pressure was largely driven by concerns over U.S. President Donald Trump's decision to impose an additional 25% tariff on Indian goods over Russian oil purchases—on top of an earlier 25% duty. Despite the punitive measures, Indian refiners are expected to increase Russian oil imports in September, dealers said.For August, foreign investors offloaded \$3.3 billion worth of

Indian shares, the biggest monthly outflow February, dragging the Sensex down 1.4% and the Nifty 1.1% so far this month.Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, noted that the recent selling came despite strong DII buying of 6,920 crore on Thursday, which outweighed FII selling of Rs 3,856 crore."The negative sentiment triggered by the 50% Trump



Sakshi said, hinting at Anusha, "Women who were 10-15 years older than me coming and saying these things, I thought it was just bully behaviour... A certain host would come up to me off camera and make snide comments about my life..."

She noted how there was no regard for the contestants' safety on set and said, "There was this task where we had to jump from one container to another. Again, you're harnessed, but some guy is manually controlling it. I don't trust people with my life like that. Anusha, without getting a go-ahead, was like, 'Jump off.' No one was holding it... she never coordinated with anyone."
