#### 'Planned' disruptions cost Lok Sabha 83 hours of work: Speaker Om Birla

New Delhi, Aug 21: Lok Sabha Speaker Om Birla on Thursday expressed deep concern over the repeated disruptions witnessed during the Monsoon session, saying the House could function for only 37 hours against the 120 hours scheduled. Before adjourning the House for an indefinite period (sine die), Birla in his valedictory remarks said the country expected meaningful debates from its representatives, but "planned disruptions" and "sloganeering" had prevented the House from functioning smoothly. "Honourable Members, as public representatives, the



entire country watches our conduct and functioning. The public has great expectations from us that we have serious and meaningful discussions... in accordance with the decorum of Parliament," Birla said, urging members to maintain restraint in language and behaviour. Notably, throughout the Monsoon session, the Opposition vociferously protested against the government over two key issues - initial days were marred with the demand for a discussion on Operation Sindoor and later over the Election Commission's Special Intensive Revision (SIR) voter exercise in Bihar. Birla reminded MPs that while differences of opinion were natural in democracy, the collective responsibility should be to ensure the House runs with "dignity, decorum and decency". "We have to think about what message we are sending to the citizens through the country's highest democratic institution," he said. The Monsoon session, which began on July 21, saw the introduction of 14 Bills and passage of 12, including key legislations. Two special discussions were also held — on Operation Sindoor (July 28-29) and on the achievements of India's space programme (August 18).

# **Army chief General Upendra** Dwivedi pledges organ donation, urges troops to follow



Under the leadership of Director General Armed Forces Medical Services, Surgeon Vice Admiral Arti Sarin, AORTA has established itself as a national leader in organ retrieval and transplant initiatives.

The Indian Army has already set a benchmark with over 26,000 personnel pledging their organs in a single campaign, making it the largest such drive in the country.

Speaking at the event, General Dwivedi described organ donation as a noble service to humanity and an extension of the Armed Forces' ethos of sacrifice and courage.

He urged service personnel and their families to lead by example and inspire society at large to embrace organ donation. The Army Chief also praised AORTA for its sustained efforts in spreading awareness and motivating personnel across the Armed Forces.In a gesture highlighting the role of healthcare workers, General Dwivedi presented on-the-spot Chief's Recommendation Cards to three frontline staff involved in organ transplant care, including a housekeeper who ensured sanitation and hygiene for patients.



# Unpaid for two years: Gurgaon civic body urges Faridabad corporation to settle Rs 75cr waste disposal bill

NOIDA. (Agency)

The Faridabad municipal corporation owes Rs 75 crore to MCG for expenses incurred on transporting waste to the Bandhwari landfill site. According to MCG officials, the dues have been pending for over two years, during which no further payments were made on MCF's behalf for waste transportation. The issue was discussed during a recent meeting of Gurgaon's city councillors, who pressed for immediate recovery of outstanding funds from MCF. Officials confirmed that since the non-payment, MCG has not borne any additional costs related to Faridabad's waste disposal."We have not been paying the transportation cost of waste that Faridabad dumps at the Bandhwari landfill site for the last two years. They have not yet paid back Rs 75 crore to us," said an MCG official.

Kuldeep Yadav, Councillor of Ward Number 11, said, "Why should we bear the cost of Faridabad's waste management? In the previous house, like in the newly-elected one, all councillors were unanimous in the decision to stop paying for their waste management."MCF commissioner Dhirendra Khadgata could not be reached for a comment on the matter.Moreover, on July 27, during a meeting chaired by ULB secretary and commissioner Vikas Gupta, a decision was made to ask the Faridabad civic body to stop sending their fresh waste to Bandhwari and make their own arrangements for its disposal.

According to MCG records, MCF currently transports between 400 and 1,000 metric tonnes (MT) of fresh waste to the landfill each day. The waste processing at Bandhwari, meanwhile, has stopped since the two agencies working at the site were barred from working by MCG due to their sluggish pace of work.

# Discretion & not rules guided **Greater Noida plot allotments:** CAG audit

NOIDA. (Agency)

Between 2006 and 2018, Greater Noida Industrial Development Authority (GNIDA) allotted plots for industrial, institutional, IT and housing projects through interviews and presentations without clear criteria like net worth, turnover or liquidity, giving committees unchecked powers to select applicants, a CAG audit for the period has found. In a test check of 170 allotments, the audit found 51 plots—nearly 30%—were given to applicants who failed to submit essential documents, including registration certificates, financial statements, liquidity certificates, and records of past projects. Many of these allottees were not serious entrepreneurs and later profited by transferring land.

The audit also found that conditions laid down in scheme brochures to assess applicants' eligibility were often overlooked. In one case, three industrial plots were allotted between June 2015 and Dec 2016 despite applicants failing to submit mandatory liquidity certificates. The screening committee still declared the incomplete documents "satisfactory", and the CEO approved the allotments. By April 2021, none of the units had become operational.

In its response, the Authority argued that the committee had evaluated applications in line with brochure conditions and relied on other financial documents provided by the applicants.

# NGT orders checks at Bandhwari landfill in a week after leachate spills into Aravalis in Haryana

Gurgaon.(Agency)

Angered over the unchecked flow of toxic leachate from Bandhwari landfill, National Green Tribunal (NGT) has directed Central Pollution Control Board (CPCB) and the environment ministry's regional office in Chandigarh to conduct a joint inspection within a week. Taking note of the "serious risk" and lack of effective checks, the bench - headed by Justice Prakash Shrivastava and expert member Dr A Senthil Vel — asked CPCB and MoEF&CC to assess the current leachate flow and the landfill's management practices. Their findings are to be submitted within three weeks.

The matter will be taken up again on Sept 18. The order came on Aug 14 while NGT heard two connected cases on the landfill's mismanagement. Applicants told the tribunal that leachate, a highly contaminated liquid from rotting waste, was spilling from the dump onto village roads and even forest patches for over a year. They alleged the landfill operator



failed to install a garland drain system to contain the toxic discharge, posing health risks to residents and damaging the ecologically fragile Aravalis. Vaishali Rana, an environmentalist and one of the applicants in this case, said, "Leachate is being discharged in ponds surrounding the dump site. It's a clear case of forest land being gradually eaten up by a govt

agency itself. They are damaging the ecosystem of the area.

NGT was hearing two cases — Poonam Yadav v. Ecogreen Energy Pvt Ltd and Ors and Vivek Kamboj v. Union of India & Ors.A CPCB inspection report dated April 11 confirmed that leachate was directly entering ponds around the landfill. However, affidavits filed by

MCG claimed the site produces only about 200 kilolitres of leachate per day. Activists argued the figure is far lower than the actual volumes, which rise sharply during the monsoon.

The order said, "Having regard to such a stand of the applicant, we direct the member secretary, CPCB, and RO, MoEF&CC, Chandigarh to get the joint inspection of the landfill site Bandhwari done within a week and find out the status of the overflowing of leachate and the arrangements which have been made at the landfill site for the management of the leachate. The joint report will be submitted within three weeks. It has also been pointed out that Haryana State Pollution Control Board (HSPCB) has filed the report yesterday after 3.00pm. Since the report has been filed late, it has not come on record. The registry is

# For way out of garbage mess, MCG taps into community knowledge in Gurgaon

Gurgaon. (Agency)

MCG on Tuesday held marathon meetings with RWAs and citizen groups, seeking solutions for the city's waste management problem — an initiative backed by chief principal secretary to the CM, Rajesh Khullar, who has been camping in Gurgaon for the past week to address some of its most pressing civic issues. Residents suggested all sorts of solutions.

On waste management, representatives of citizens' group Making Model Gurugram (MMG) proposed sustainable, decentralised solutions, such as setting up compressed bio-gas (CBG) plants and material recovery facilities at zonal levels.

United Gurugram RWA (UGR) highlighted the need for better upkeep of city parks. UGR suggested revising the park maintenance rates from the current Rs 4.5 per sq metre to Rs 12 per sq metre, which would also cover in-situ composting of horticulture waste.Founder of Making Model Gurugram Gauri Sarin said its detailed presentation was "meticulously developed" from feedback collected from over 175 resident welfare associations

(RWAs)."The presentation and ensuing dialogue underscored the urgent need for a transparent, phased approach that involves civil society, RWAs and resident groups meaningfully in decision-making. This thoughtful AEAE model awareness, education, action, enforcement — process is expected to unfold over the next two years to make Gurgaon garbage-free, achieve almost 100% segregation, reduce the fresh waste to landfill by 85% and create CBG plants and recycling capability," Sarin said.

Co-convener of UGR Chaitali Mandhotra said, "For the doorstep waste collection, we have suggested wet waste collection daily and dry waste collection twice a week with two separate contractors to ensure that waste is not mixed. For doorstep waste collection in villages, the existing model of daily waste collection can be done and waste collected should be further segregated at the MRF centres, for which we have suggested 10 such zones."

On the UGR's suggestion to enhance the park maintenance fee, MCG commissioner Pradeep Dahiya responded that a written proposal should be

submitted for consideration. The commissioner said the civic body is working towards setting up a plant for better management of horticultural waste. RWA and society representatives will transport the horticultural waste from their areas to this plant for its processing.

Dahiya shared information about the corporation's upcoming plans. He said the tender process for door-to-door waste collection is underway and will be implemented soon, enhancing the cleanliness system in the city. Similarly, the tender for cleanin roads and streets is also in process. He said the corporation has started working in "mission-mode" to improve the street lighting system, aiming to illuminate the entire city before Diwali.He emphasised the corporation's goal is to create a clean, beautiful, green and well-lit Gurgaon.During the discussion on solid waste management with the UGR team, the commissioner said RWAs or societies wishing to manage waste at their level should declare themselves as bulk waste generators (BWGs). The municipal corporation will not charge any waste fees from such

For environmental impact, Parsvnath Exotica, Paras Quartier and Park View Spa demonstrate how household-level segregation combined with community composting systems could drastically reduce landfill dependency. Their focus is on building habits that last, rather than quick fixes.

and Suncity Township excel in composting initiatives, building inhouse facilities that converted wet waste into nutrient-rich compost for landscaping and gardening within these societies."At Suncity, we have taken complete ownership of waste with a vision to become a model township for Gurgaon and inspire other RWAs to follow. # Charges against RWA in Gurgaon trigger probe into illegal deals and financial irregularities

NOIDA. (Agency)

The district registrar has appointed an inquiry officer to investigate allegations of governance failures, unauthorised dealings and financial improprieties against the governing body of Esencia RWA in Sector 67.

The move comes following complaints filed by residents accusing the RWA of entering into an "illegal and malafide agreement" with an adjacent housing society, allegedly allowing access through Esencia for laying water pipelines and electricity cables without approvals from govt authorities.

Complainants also alleged financial mismanagement, citing multiple undisclosed bank accounts, lack of audits and money collections from vendors without ratification by the general body. In an order issued on Tuesday, the district registrar appointed Col Vipin Chopra (Retd) as the inquiry officer and directed him to verify the facts and submit a report within 45 days."The inquiry officer will ascertain the facts claimed in the complaint and conduct a detailed inquiry into the

RWA's functioning as per HRRS Act," the order stated. The Esencia RWA has been directed to cooperate with the inquiry. Residents earlier wrote to the deputy commissioner and the registrar demanding suspension of the governing body, holding of fresh elections, and a criminal probe into alleged financial fraud. They pointed out that the township is still under the builder Ansal API, which has become insolvent, and that the RWA has no legal authority to sign agreements impacting the estate's infrastructure. Moreover, on June 22, a general body meeting attended by the residents passed unanimous resolutions denouncing the RWA's agreement with the neighbouring group housing project and adopting a no-confidence motion against the governing body."Our township is still under the ownership of the developer, which is now in insolvency. The RWA's role is limited to overseeing housekeeping, security, horticulture, and other essential services. It has no legal



right to enter into agreements with another group housing project," said Devender Singh Nehra, one of the complainants."Some members of the governing body have been acting in an autocratic manner, signing unauthorised agreements and mishandling residents' money. We have demanded suspension of the current body and also for a criminal probe into financial irregularities," said Jayant Dhanda, another complainant. The RWA, however, has strongly refuted the allegations, terming them

"politically motivated.""We already cancelled the agreement after the general body meeting on July 29. The complainants, who are trying to malign the RWA, themselves are land grabbers. We have done nothing wrong. I am happy that an inquiry is being conducted and we will cooperate fully. Our roads are in poor condition and it is not possible to rebuild them with residents' contribu

# Gurukul warden detained for branding 2 children with hot iron rod in Rajasthan's Barmer

New Delhi: A teacher-cum-warden of a gurukul in Rajasthan's Barmer district allegedly branded two children, aged around 10 and 11, with a hot iron rod to "discipline" them for bed-wetting, officials said on Thursday. The alleged incident took place on August 17 at a gurukul in the Harpaliya village of Sedwa area, run by Harpaleshwar Mahadev Vikas Seva Samiti. According to officials, the gurukul, operational since 2022, houses children from poor and nomadic families, some of whom were orphans. Police said the matter sur-NAME CHANGE faced after one of the children fled the gurukul at night and informed his family about the alleged torture. "The children have also alleged physical assault and threats to silence them," an official familiar with the inquiry said. # Russian attacks on west Ukraine kill one, wound multiple

KYIV. (Agency)

Russian attacks on western Ukraine killed one person and wounded multiple others, officials in the country said Thursday as diplomatic efforts to end the threeyear war grind on. Moscow and Kyiv have kept up their aerial attacks on each other as world leaders including US President Donald Trump push for a ceasefire."One person was killed and two were wounded as a result of the combined UAV and cruise missile strike in Lviv," said Maksym Kozytskyi, head of the regional military administration."Dozens of residential buildings were damaged," he added in a Telegram post.Russian fire also wounded 12 people in the city of Mukachevo, near the border with Hungary and Slovakia, the city council said."Five patients are being treated in the hospital, and one more was transferred to the regional hospital," the council wrote on Facebook.In Lutsk, Mayor Igor Polishchuk reported "an enemy attack that was conducted by UAVs and missiles". As of this moment there are no injuries or fatalities," he said.

Meanwhile, Russia's defence ministry said it destroyed "49 Ukrainian aircraft-type unmanned aerial vehicles" across multiple regions. The ministry did not detail any casualties or damage. The latest crossborder fire follows Trump's flurry of diplomacy this month aimed at ending the war. The US president met his Russian counterpart Vladimir Putin in Alaska, before bringing Ukrainian President Volodymyr Zelensky and European leaders to Washington for

# Israel to mobilize 60,000 reservists ahead of an expanded Gaza City operation

JERUSALEM.(Agency)

Israel's military said Wednesday it will call up 60,000 reservists ahead of an expanded military operation in Gaza City. Many residents have chosen to stay despite the danger, fearing nowhere is safe in a territory facing shortages of food, water and other necessities.

Calling up extra military reservists is part a plan Defense Minister Israel Katz approved to begin a new phase of operations in some of Gaza's most densely populated areas, the military said. The plan, which is expected to receive the chief of staff's final approval in the coming days, also includes extending the service of 20,000 additional reservists who are already on active duty. In a country of fewer than 10 million people, the call-up of reservists is the largest in months and carries economic and political weight. It comes days after hundreds of thousands of Israelis rallied for a ceasefire, as negotiators scramble to get Israel and Hamas to agree to end their 22 months of fighting, and as rights groups warn that an expanded assault could deepen the crisis in the Gaza Strip, where most of the roughly 2 million inhabitants have been displaced, many areas have been reduced to rubble, and the population faces the threat of famine. Gaza City operation could begin within days

An Israeli military official, speaking on the condition of anonymity in line with military regulations, said troops will operate in parts of Gaza City where they haven't been deployed yet and where Israel believes Hamas is still active. Israeli troops in the the city's Zeitoun neighborhood and in Jabaliya, a refugee camp in the northern Gaza Strip, are already preparing could begin within days.

# Judge denies US Justice Department request to unseal Epstein grand jury transcripts

**NEW YORK** . (Agency)

A US federal judge who presided over the sex trafficking case against financier Jeffrey Epstein has joined two other judges in rejecting the government's request to unseal grand jury transcripts related to the decades-long sexual abuse suffered by girls and young women who fell into his orbit.

The ruling on Wednesday by Judge Richard Berman in Manhattan came after the judge presiding over the case against British socialite Ghislaine Maxwell, Epstein's former girlfriend, also turned down the government's request.Barring reversal on appeal, Berman's decision forecloses the possibility of grand jury testimony being released now that three judges have reached the same conclusion. A federal judge in Florida declined to release grand jury documents from an investigation there in 2005 and 2007.

The rulings are a collective repudiation of the Justice Department's effort to divert attention away from its stated refusal to release a massive trove of records in its possession and make clear that the still-sealed court documents contain none of the answers likely to satisfy the immense public interest in the case.

President Donald Trump had called for the release of transcripts amid rumors and criticism about his longago involvement with Epstein. During last year's presidential campaign, Trump promised to release files related to Epstein, but he was met with criticism — including from many of his own supporters when the small number of records released by his Justice Department lacked new revelations. A Justice Department spokesperson declined to comment on Wednesday.Berman said a "significant and compelling reason" to reject the government's request was that the information contained in the Epstein grand jury transcripts "pales in comparison to the Epstein investigative information and materials in the hands of the Department of Justice."He wrote that the government's 100,000 pages of Epstein files and materials "dwarf the 70 odd pages of Epstein grand jury materials."

# US State Department employee fired after questioning talking points on Israel and Gaza

The State Department recently paused all visitor visas for people from Gaza, pending a review. This decision came shortly after Laura Loomer posted videos on social media showing Gazan children arriving in the U.S. for medical treatment and questioned how they obtained visas.

**DHAKA.(Agency)** 

WASHINGTON: The State Department has fired a press officer who was responsible for drafting Trump administration talking points about policy toward Israel and Gaza after complaints from the U.S. Embassy in Jerusalem. Officials said Shahed Ghoreishi, a contractor working for the Bureau of Near East Affairs, was terminated over the weekend following two incidents last week in which his loyalty to Trump administration policies was called into question. Ghoreishi, who is Iranian American, also was targeted Wednesday

following his dismissal by right-wing personality Laura Loomer, who accused him of not being fully supportive of the administration's policies in the Middle East.According to Ghoreishi and two current U.S. officials, Ghoreishi drew the ire of a senior official at the U.S. Embassy in Jerusalem and then top aides to Secretary of State Marco Rubio for drafting a response to a query from The Associated Press last week.

The question related to discussions between Israel and South Sudan about the possible relocation of Palestinians from Gaza to South Sudan. The draft response included a line that said the U.S. does not support the forced relocation of Gazans, something that President Donald Trump and his special envoy Steve Witkoff have said repeatedly. However, according to Ghoreishi and the officials, that line was rejected by the U.S. Embassy in Jerusalem, leading to questions about policy back in Washington. The officials spoke on condition of anonymity to discuss internal personnel changes. Ghoreishi also said he questioned a statement from the embassy

that referred to the West Bank as "Judea and Samaria," the Biblical name for the Palestinian territory that some right-wing Israeli officials prefer. Mike Huckabee, U.S. ambassador to Israel, also has



repeatedly backed referring to the West Bank by Judea and Samaria. The ouste shows the lengths that the Trump administration has gone to ensure what it sees as loyalty to the president and his goals, including a foreign policy approach that has offered overwhelming support for Israel in the war against Hamas. The administration this week also revoked

# Brazilian police say ex-President Bolsonaro had planned to flee to Argentina seeking asylum

BRAZILIA . (Agency)

Brazil's federal police said that messages found on the telephone of embattled former president Jair Bolsonaro showed that at one point he wanted to flee to Argentina and request political asylum, according to documents seen Wednesday by the Associated Press.Bolsonaro is currently awaiting a Supreme Court ruling about an alleged coup attempt and on Wednesday found out he might face another case as police formally accused him and one of his sons, Eduardo Bolsonaro, of obstruction of justice in connection with his pending trial. The AP had access to the police investigation, messaging app exchanges, voice messages and reviewed the documents, which were sent to Brazil's Supreme Court.The 170-page police report said that Bolsonaro had drafted a request for political asylum from Argentine President Javier Milei's government dated Feb. 10, 2024. Bolsonaro saved the document two days after

authorities searched his home and office as part of an investigation into an alleged coup plot.In a 33-page letter addressed to Milei, Bolsonaro claimed



he was being politically persecuted in Brazil."I, Jair Messias Bolsonaro, request political asylum from Your Excellency in the Republic of Argentina, under an urgent regime, as I find myself in a situation of political persecution in Brazil and fear for my life," the former Brazilian leader wrote. Argentina's presidential spokesperson did not immediately respond to a

request for comment. Bolsonaro did not make comments about the investigation either. On February 12, Bolsonaro reportedly spent two nights at the Hungarian Embassy in

Brasília, fueling speculation among critics that he may have been attempting to avoid arrest.Brazilian federal police investigators also said in their report that Bolsonaro's decision to ignore precautionary measures established for his house arrest and spread content to his allies "sought to directly hit Brazilian democratic institutions, notably the Supreme Court and even Brazil's Congress."With

regards to Wednesday's obstruction of justice accusations, Eduardo Bolsonaro, a lawmaker who has lived in the United States, said in a statement that he "never aimed at interfering in any ongoing proceedings in Brazil." He added the conversations with his father that are part of the investigation are "absolutely normal" and its publication has a political bias.

# A wartime mass grave in Sri Lanka yields a baby bottle, children's clothes and 141 skeletons

**CHEMMANI.(Agency)** 

A baby bottle, a squeaky toy and a schoolbag are among items that have surfaced from a mass grave site in Sri Lanka's formerly war-torn northern region, along with 141 human skeletons including some that appear to be of children of different ages. The findings were made at a cremation ground in the Chemmani area near Jaffna town, the cultural heartland of the country's ethnic Tamil minority. But hardly any burials take place here, as Hindus mostly cremate their dead according to religious customs. Excavations have been underway since June, after workers found human remains while digging to build an electric crematorium.

A pit test over nine days discovered 19 sets of human remains. Shallow burials of about 1.5 meters (4.9 feet) in a scattered and disorganized manner, and the absence of clothing, indicated the site was a mass grave, according to a report provided to a court in June. Since the area was secured and declared a crime scene that month, a total of 141 skeletons have been discovered within a 165-square-meter (1,776-square-



foot) area. About 135 of the bodies had no clothing, and only one set of adult clothing was identified. Tests confirmed that a skeleton found with a schoolbag was that of a girl between 4 and 6 years old. Toddlers' dresses, socks and footwear, tiny bead bangles and a baby powder tray were also recovered. The identities of the dead and the cause and timing of their deaths are all unclear. But many think the victims could be civilians who disappeared during Sri Lanka's civil war, which broke out in 1983 between government forces and ethnic Tamil rebels, who fought to create an independent homeland for the minority group. The war ended in 2009. Several Tamil armed groups and an Indian peacekeeping mission were active in the region over the decades. But attention has focused on the Sri Lankan military, which had a heavy presence for over a decade in Chemmani, as the gateway to Jaffna town.

# Texas House approves redrawn maps sought by Trump ahead of 2026 elections

The Republican move has sparked a national tit-for-tat as Democrats in California prepared to redraw the state's map to create five new seats.

The Texas House on Wednesday approved redrawn congressional maps that would give Republicans a bigger edge in 2026, muscling through a partisan gerrymander that launched weeks of protests by Democrats and a widening national battle over redistricting. The approval came at the urging of President Donald Trump, who pushed for the extraordinary middecade revision of congressional maps to give his party a better chance at holding onto the U.S. House of Representatives in the 2026 midterm they attended Wednesday's session. elections. The maps, which would give The approval of the Texas maps on an Republicans five more winnable seats, 88-52 party-line vote is likely to need to be approved by the GOP- prompt California's Democratic-



Republican Gov. Greg Abbott before they become official.But the Texas House vote had presented the best chance for Democrats to derail the redraw.Democratic legislators delayed the vote by two weeks by fleeing Texas earlier this month in protest, and they were assigned round-the-clock police monitoring upon their return to ensure

But the California map would require voter approval in November.Democrats have also vowed to challenge the new Texas map in court and complained that Republicans made the political power move before passing legislation responding to deadly floods that swept the state last month. # Israel approves major settlement project that could divide the West Bank

**JERUSALEM** . (Agency)

Israel approved a major settlement project on Wednesday in an area of the occupied West Bank that the international community has warned threatens the viability of a future Palestinian state.

Israel has long had ambitions to build on the roughly 12-square-kilometre (five-squaremile) parcel known as E1 just east of Jerusalem, but the plan had been stalled for years amid international opposition. The latest announcement also drew condemnation, with UN chief Antonio Guterres saying the settlement would effectively cleave the West Bank in two and pose an "existential threat" to a contiguous Palestinian state.

Last week, Israel's far-right Finance Minister Bezalel Smotrich backed plans to build around 3,400 homes on the ultra-sensitive tract of land, which lies between Jerusalem and the Israeli settlement of Maale Adumim."I am pleased to announce that just a short while ago, the civil administration approved the planning for the construction of the E1 neighbourhood," the mayor of Maale Adumim, Guy Yifrach, said in a statement on Wednesday.All of Israel's settlements in the West Bank, occupied since 1967, are considered illegal under international law, regardless of whether they have Israeli planning permission. The Ramallah-based Palestinian Authority (PA) slammed the latest move."This undermines the chances of implementing the two-state solution, establishing a Palestinian state on the ground, and fragments its geographic and demographic unity," the PA's foreign ministry said in a statement.It added the move would entrench "division of the occupied West Bank into isolated areas and cantons that are disconnected from one another, turning them into something akin to real prisons, where movement is only possible through Israeli checkpoints and under the terror of armed settler militias".Israel heavily restrict the movement of West Bank Palestinians, who

must obtain permits from authorities to travel through checkpoints to cross into east Jerusalem or Israel.Guterres repeated a call for Israel to "immediately halt all



settlement activity", warning that the E1 project would be "an existential threat to the two-State solution", his spokesperson said.British Foreign Secretary David Lammy also rejected the plans, saying it would "divide a Palestinian state in two (and) mark a flagrant breach of international law".Jordan's King Abdullah II denounced the project as well, adding that "the two-state solution is the only way to achieve a just and comprehensive peace"Bury' Palestinian statehoodViolence

Israeli troops and settlers have killed at least 971 Palestinians in the West Bank, including many militants, according to health ministry figures. Over the same period, at least 36 Israelis, including security forces, have been killed in Palestinian attacks or during Israeli military operations, according to official figures. Aviv Tatarsky, a researcher at Ir Amim, an Israeli NGO focusing on Jerusalem within the context of the Israeli-Palestinian conflict, condemned the greenlighting of the E1 project."Today's approval demonstrates how determined Israel is in pursuing what Minister Smotrich has described as a strategic programme to bury the possibility of a Palestinian state and to effectively annex the West Bank," he

# Wimco Nagar to be developed as rail-metro-bus hub in Chennai

CHENNAI. (Agency)

Wimco Nagar in North Chennai is being recast as a transport hub, with Indian Railways, Chennai Metro Rail Ltd (CMRL) and the Chennai Unified Metropolitan Transport Authority (CUMTA) working on plans to integrate suburban, regional and urban mobility at a single

At Wimco Nagar, Indian Railways has proposed to extend suburban platforms to 550 metres, enabling express and mail trains - including services bound for Kolkata and other eastern destinations - to halt there. The plan is expected to transform the station from a local halt into a regional gateway, easing the passenger load on Chennai Central.

"We have suggested that Indian Railways develop a full-fledged station at Wimco Nagar, complete with waiting halls and passenger facilities. Metro land has been identified for these amenities," a senior CUMTA official said. A multimodal integration plan has been submitted to the Railways, the official added. The master plan also includes a five-acre bus terminus on ITC land near the station, a railway ticket counter on metro-owned property, and a six-metre foot overbridge linking the metro concourse directly with railway platforms. Escalators, lifts, dedicated parking for two- and four-wheelers, share-auto bays and wider pedestrian pathways are also proposed.

Besides, the state highways department and Southern Railway are constructing a limited-use subway between Tiruvottiyur and Wimco Nagar stations, scheduled for completion by September 2025. With land requirements overlapping, CUMTA and CMRL have urged the Railways to consider land swaps to create drop-off points for cars and autos.

The Wimco Nagar scheme is backed by Indian Railways' decision in 2023-24 to sanction '50 crore for integrating suburban stations with metro corridors across Chennai. A similar model is being explored at Chromepet, where a vehicular underpass is being redesigned to align with new station access points. CUMTA has prepared a conceptual plan, where a sixmetre-wide foot overbridge is proposed to link GST Road bus stops, Chromepet railway station, the upcoming metro station and the Madras Institute of Technology

# 30 per cent of Hyderabad plunged into digital darkness

**HYDERABAD.** (Agency)

Lakhs of consumers continued to remain without internet and cable TV services across the city on Wednesday following the large-scale cable-cutting drive by the TGSPDCL.

According to the Telangana Cable, TV, Internet and Telecom Service Providers Welfare Association, the city has about 2.8 million linear and non-linear optic cables, of which over 1 million were cut during the operation, leaving nearly 30% of consumers without

The blackout of digital services disrupted daily life for thousands of households and businesses. Vinay, an IT employee, said: "We have three days of work from home. If things like this happen, it becomes very difficult to meet targets. It's been two days, and the internet is still not fully restored. If the government wants to take up such drives, users should at least be informed in

Dinesh, a parent of two children studying remotely, said: "My son had an exam today. With no internet, it was hard for him to appear. Mobile data can only help to an extent, and in the end, we are answerable to the college as children miss exams.'

Prakash, a dry fruit seller, said his billing system collapsed: "Our entire system is online. With no internet, we couldn't process payments or orders. It's like shutting shop for a day." Mayank, a Kukatpally resident, said: "Our home security cameras stopped working as they run on broadband. With frequent power cuts already, this makes us feel even more unsafe.'

'Will take 2-3 days for connections to be restored' Amid widespread disruptions, representatives of the Cellular Operators Association of India (COAI), cable operators and service providers met TGSPDCL CMD Musharraf Faruqui on Wednesday. The meeting was described as positive, with operators asked to maintain safety standards, clear clutter and ensure cables are properly laid, especially in the wake of a recent electrocution in Ramanthapur. The association said it would take 2-3 days to restore connections.

Four months after a woman's alleged murder in Mumbai's Mazgaon, the Agripada police arrested an accused in the case from the India-Nepal border on Tuesday evening.

The arrested man was identified as Mohammed Subham Shah, 24. Officers said he will be produced in court on Wednesday. According to the police, at least four people are believed to be involved in the murder of Gulshan Hashmat Khan, 53. She was found dead after allegedly falling from the 13th floor of her apartment on April 6.

Earlier, investigators had arrested her husband Shoheb Imtiyaz Khan, 27, his brother Zaid Khan, and one of his two drivers in connection with the case.

Shah, who was arrested on Tuesday, was also working as Shoheb's driver. Officers said he was allegedly involved in the destruction of evidence after the murder and was hiding at his native place in Bihar's Darbhanga. He had planned to head to



nabbed Shah and brought him to Mumbai.

Sanjay Nale, Senior Inspector, Agripada police station, said, "Shoheb's younger brother was also involved in the murder. A search is on to locate him."

The police said that Gulshan was still married to her first husband, Hashmat Khan, 63, when she decided to wed her nephew Shoheb. She then started living with him at his flat in Mazgaon from 2022.

Amid heavy rain and severe waterlogging across the city, a teenager died Tuesday morning after coming in contact with a high-tension electric wire in Bhandup, civic officials said Wednesday. At least 139 incidents of tree collapse, partial wall crash and short circuit incidents were reported between Tuesday and Wednesday morning, officials said.
According to officials, Deepak Ajay

Ramlingam Pillai (17) was walking along a waterlogged street on LBS Marg in Bhandup around 11.35 am Tuesday when he came in contact with the high-tension wire and got shock. Passersby took him to the nearby Ayushman hospital, where he was declared dead. Data from the BMC showed that between Tuesday and Wednesday morning, over 209 mm lashed the suburban area, with over 107 cases of tree collapse and partial wall collapse being reported. At least 32 incidents of short circuits were also reported. "Further, non-sus-

pending the conviction... indicates farreaching consequences... He not only remained disqualified, but also remained disqualified to contest the future election, the court said. Of the total cases, 93 were of tree collapse within 24 hours ending 8.30 am on Wednesday. Officers said that when Gulshan came to stay with Shoheb, she brought 650 grams of gold from her first husband Hashmat's house. "Later, she told her neighbours and Hashmat that Shoheb was harassing her for money," said Nale. On the day she died, Gulshan allegedly

fell from the 13th floor of their building around 5 am and was found in the duct area on the 9th floor, officers said.

Shoheb, however, claimed to the police

that she had either jumped or fallen from the bathroom. Based on a statement from Gulshan's first husband, Shoheb and the others were booked for abetment to suicide.

During the investigation, the police found blood stains on the door of a bathroom in the apartment as well as on the victim's slippers, which were sent for forensic

"There was also an injury on the back of her head. It appeared like she had been hit with a heavy object and was then pushed off," a police officer said.

As part of the probe, doctors and other experts were taken to the crime scene and further examination pointed to circumstantial evidence which indicated Shoheb's role in the murder. Based on the developments, the police added murder charges to the case

"Shoheb was already under arrest for abetment of suicide and was in jail. So the police took him into custody in the second week of June. During further probe, his brother and one of the drivers were arrested for destroying evidence," Nale said.

# Balganga dam project: In a setback to Maharashtra govt, HC upholds Tribunal order to pay Rs 303 cr to firm

In a setback to Maharashtra government and its authorities, the Bombay High Court earlier this month upheld the majority award passed by the arbitral tribunal in April 2019 that directed the authorities to pay Rs 303 crore to FA Enterprises, a private firm, towards unpaid bills for construction of Balganga dam. The HC through August 12 verdict restored the arbitral tribunal award related to the project of water supply to expanding areas of Navi Mumbai and for drinking and Industrial purposes. The copy of the order was made available on Wednesday. A division (two-judge) bench of Chief Justice Alok Aradhe and Justice Makarand S Karnik on August 12 quashed and set aside May 19, 2020 order of the single-judge bench of Justice (now retired) R D Dhanuka that had set aside the arbitral tribunal award and had granted relief to the state government, City and

Industrial Development Corporation and Konkan Development Corporation (KIDC).

The HC observed "findings of the

Arbitral Tribunal are based on the materials on record and on a proper appreciation of evidence."The two-judge bench noted that the majority award had held termination invalid as the firm had taken substantial steps to get forest land clearance. Therefore, there was "no legal basis for the single-judge bench to have upset this finding."Justice Karnik for the division bench recorded, "We are satisfied that the view taken by the Arbitral Tribunal on the basis of the evidence on record is a plausible view. In such circumstances there was no scope for the Single Judge to have inter-fered with the award of the Arbitral Tribunal in the exercise of its jurisdiction under Section 34 of the of the Arbitration and Conciliation Act, 1996."

# After 2 monorails got stuck, MMRDA to deploy staff to check overcrowding

Mumbai .(Agency)

A day after two monorails got stuck due to overcrowding and left over 700 passtranded, the Mumbai Metropolitan Region Development Authority (MMRDA) said that it will enhance efforts to avoid overcrowding.

The authority also announced that it has procured ten monorail rakes to address the peak hour demand and passenger load.

MMRDA also rolled out a set of shortterm and long-term measures after the two incidents on the Monorail route between Bhakti Park and Chembur; and Wadala and Acharya Atre station Tuesday, amid heavy downpour in the city.

According to MMRDA, station staff ordered to strictly n boarding in order to avoid overcrowding of trains. "Every Monorail coach can carry a maximum of 104 tonnes of load. In case it crosses the limit, the train won't budge until passengers are evacuated safely," a senior MMRDA official explained. Together with this, extra staff will now accompany every train. Why did the

Monorail get stuck?

Initial checks following the first incident on Tuesday indicated that the train had close to 109 tonnes, higher than the designed capacity of 104 tonnes. caused the mechanical contact

between the power rail and the current collector to break, disconnecting the supply of electricity required to operate the rake. A senior security personnel will

now always keep an eye on the movement of passengers within the coaches and a technician will be with the Monorail pilot to take care of any technical glitches during running. Emergency preparedness

MMRDA said. Each one of the eight ventilation windows in the four coaches of all four rakes is being checked and marked for easy identification. "This will assist in leading passengers during emergencies and avoid panic," said the official. Improved signage with directions for emergency procedures and exits is being fitted within trains to render safety information more

For the longer term, MMRDA is planning to induct new rolling stock. Ten new rakes were procurred, of which seven have

arrived at the depot and are being tried and certified. Upon clearance to operate, these rakes will be put on the line to enhance car-

rying capacity and decrease the burden on the existing fleet. "The induction of new trains will ensure greater reliability and balance peak hour demand," the official further said. MMRDA stated that after the

# Ganeshotsav special: Is 'shaadu maati' ideal for making Ganesh idols and a better environmental option?

In June, the Bombay High Court allowed the manufacture and sale of Ganesh idols made of Plaster of Paris (PoP) while, at the same time, restricting their immersion in natural water bodies after Ganeshotsav due to their environmental risk. Over the last two decades, shaadu maati an ecofriendly clay — has emerged as a conscious person's alternative to PoP.

For devotees concerned about the environment, the Bombay High Court ruling provides yet another reason to search for shaadu maati idols.

"The nature of Ganeshotsav idols is that they will be immersed at the end of the festival. These are not expected to be permanent idols. One must choose a material that will be aligned with the temporary nature of the idols. PoP, which is not naturally occurring, is used in the construction industry as it can last for years and decades. It is a material that has a long lifespan. But we are using it for a much smaller time frame. Shaadu maati, on the other hand, is moistureabsorbent and disintegrates immediately when immersed," says Manisha Sheth, director of Punaravartan and the founder of eCoexist Foundation, which works to raise environmental consciousness

Orchardist Naresh Kashyap says small apple growers usually transport their crop to the nearby collection cenbut big and established orchardists go to Pinjore Apple Market in Haryana, Chandigarh Grain Market, Sector 26, and other local

markets in Himachal Pradesh.

She highlighted that shaadu maati is a better option for Ganesh idols than PoP idols.

What is shaadu maati?

Shaadu maati is a natural clayey soil mined in Gujarat. It is 95 per cent clay and silt and five per cent sand. Shaadu maati is transported to places such as Pune, where it is in demand among artisans during Ganeshotsav.



Though much is not known about the quantity of shaadu maati mined in Gujarat for idol making, the following figures give an idea.

In 2024, the Brihanmumbai Municipal Corporation (BMC) of Mumbai decided to distribute 1,658 tonnes of shaadu maati for free to artisans. The Punaravartan campaign, endorsed by the Maharashtra Pollution Control Board, has been collecting maati sludge Ganeshotsav and providing it to the

artisans to create new idols. Last year, they collected 57,000 kg of clay from the three cities of Pune, Pimpri Chinchwad, and Thane. This year, Pune city is targeting 100 tonnes of clay collection, and Pimpri Chinchwad at least 50 tonnes.

Unlike PoP, shaadu maati dissolves in water during immersion. The clay also allows artisans to create detailed work on the idols. Importantly, PoP idols carry chem-

ical paint, which consists of toxic heavy metals, such as lead, mercury, and cadmium, which are released into the water during immersion. Shaadu maati idols are receptive to mineral or vegetable pigment. "Clay and natural pigments are a better option than PoP and toxic paint. Clay is a non-renewable resource. So, it has to be used cautiously. The bottom line is that neither POP nor clay should be immersed in natural water," says Sheth. Not always a sustainable option,

say experts

Experts have also highlighted the ecological issue in shifting shaadu maati from Guiarat to Maharashtra. "There is a carbon cost involved in transporting all this. There is an environmental cost as well, as removing soil from one landscape and putting it into the river in a different region is not a great ecological idea. Shaadu maati belongs to the terrestrial ecosystem, from where it is taken out and immersed into an aquatic ecosystem, which is the rivers," says Dr Gurudas Nulkar, Director of Centre for Sustainable Development, Gokhale Institute of Politics and Economics,

# **Pune team documents Kashmir's** endangered craft of building houseboats

From a ban on the construction of new houseboats since 1988 and a dip in the number of craftspersons to increasing difficulty in sourcing deodhar, which is required to make these vessels — this quintessential symbol of a tranquil Kashmir Valley is drifting into history as a lost item of Indian heritage.


Before the ageing craftspersons and their indigenous knowledge disappear, a team of researchers from Pune carried out a year-long documentation project that treats the Valley's boatbuilding traditions as a heritage craft

Nearly a year after the team startdocumenting this craft, master craftspersons and their teams were recently felicitated at the School of Designs in Srinagar in the presence of the director of Jammu & Kashmir's Department of Handicrafts.

Funded by the British Museum's Endangered Material Knowledge Programme, this documentation project sheds light on how the network of lakes and rivers that make up the Valley gave rise to the construction of floating dwellings.

The study is led by Sayali Athale and Anto Gloren. The other members of the team are Reyan U Rafiq, an interpreter from Srinagar, and researchers Ashutosh Chowhan and Anubhav Sutar from Pune. Gloren and Athale, both architects and woodworkers, have been focusing on timber in building for a while and visited the Valley a few times. "Kashmir has an amazing range of craftsmanship,

including boat building. The shikara even has a GI tag (a Geographical Indication tag, which is a form of intellectual property protection), but the craft of constructing houseboats has never been documented. Since this



necessary to help document it," says Gloren. For centuries, the tradition of making boats shaped the region's culture and character. In the 19th century, these floating houses, called doongas, started being used for tourism resulting in the well-oiled myth that the British invented houseboats.

"The houseboat has evolved from several variants, and the doonga was the last of its indigenous lineage. The existence of doongas has been recorded since the early 18th century. Yet, in popular narrative, the credit for the invention of the houseboat is given to its late 19th century British patrons. This misrepresentation of the houseboat as being an English invention and not an evolution of the local doonga has meant that it is seen as colonial heritage rather than a local tradition," says Athale.

'The houseboat is perceived as an import serving tourists, and the history of the communities of local people dwelling in boats before the arrival of the British is often forgotten. Through our research, in tracing its predecessors, we hope to also influence this narrative and help redirect it for the future generations," she adds. Due to increasing pollution of

lakes, the construction of new houseboats was prohibited in 1988. Before its ban, there were thousands of houseboats on Dal and Nigeen lakes, and the Jhelum. Fewer than 750 houseboats remain today. While Srinagar's lakes are increasingly threatened by climate change and siltation, the future of houseboats is closely tied to the life of the lake itself.

"Due to the limitations, the number of craftsmen with the specific skill of houseboat hull construction has reduced over the last 35 years. With the loss of another craftsman in January this year, only four senior craftsmen remain on record who possess this knowledge. While their sons have assisted them in constructing houseboats, their primary professions are not houseboat building. With the passage of these senior craftsmen then, it remains to be seen if the knowledge tradition will be continued," says Gloren.

# Beyond Tigerism in Sri Lanka

The Sri Lankan state must have had a laugh when a section of pro-LTTE (Liberation Tigers of Tamil Eelam) Tamils finally accepted that their leader, Velupillai Prabhakaran, indeed perished in 2009. To Colombo, it would have been amusing that a section wedded to the Tigers' ideology was still refusing to accept the bitter truth: that the LTTE founder-leader was killed 15 years ago by the Sri Lankan military, debilitating the once feared outfit and ending a long war that almost broke the island nation. The choreographed event on August 2 at Basel in Switzerland, where hundreds gathered to commemorate Prabhakaran's death, was itself a reflection of the self-defeating politics LTTE pursued. Prabhakaran was an insurgent leader who was kept fictionally alive by followers for reasons that are often obfuscated. So, why did Prabhakaran's fans behave thus? The main reason was perhaps a loss of face. The LTTE had portrayed Prabhakaran as a 'sun god' who would deliver a free Tamil Eelam and could not be vanquished. Thus, even when blames were being apportioned for the LTTE's rout, it was conjured up that he had escaped from Sri Lanka and would return to fight another day. A few politicians in Sri Lanka and India contributed to keep the fantasy alive.Meanwhile, unscrupulous former LTTE elements living in the West enriched themselves by duping gullible Tamils that money was needed for the upkeep of Prabhakaran, his wife and their only daughter living incognito. If this was not enough, a young lady surfaced on social media claiming to be Prabhakaran's daughter.

This was the last straw. It created widespread revulsion in the Tamil diaspora, where support for the Tigers had been easing since 2009. Many considered it an insult to Prabhakaran that his dead daughter's memory was being exploited to make money. Prabhakaran's only brother publicly claimed in Europe that the rebel leader had died long ago and that he had been observing annual rituals for his departed brother. Many Tamils agreed enough was enough. This led to the event in Switzerland despite critics who argued that accepting Prabhakaran's death would fuel the narrative that the Eelam campaign was buried for good.It's a moment for Sri Lankan Tamils, particularly those allied to the LTTE, to go beyond conceding Prabhakaran's death—if they need to do a genuine post-mortem on why a militant movement that at one time held a moral high ground and appeared invincible ended with a bloody whimper, leaving over 1,00,000 Sri Lankans, mainly Tamils, dead and causing unimaginable destruction. As a former LTTE guerrilla told me, Tamils in Sri Lanka stood on their own feet in 1983 when the Eelam struggle started; a quarter century later, they were on bended knees. It is easy to blame others for what happened to the LTTE, but a dispassionate analysis would show that the Tamil Tigers brought the mess upon themselves. An increasing number of former fighters are now speaking up. Some of them were close to both Prabhakaran and his intelligence chief, Pottu Amman.

The LTTE chieftain had more than one opportunity when he could have, having displayed military might, shaken hands with Colombo, with or without outside mediation, and obtained a political resolution. The first chance was when India and Sri Lanka signed a peace accord in 1987. The bigger opening came in 2002, when a Norwaysponsored ceasefire agreement came in. This was perhaps the best moment the LTTE, backed by much of the West, could have come to an honourable settlement with Sri Lanka and then built on the gains. In neither case, an independent Tamil Eelam would have been achieved. But as a senior former LTTE functionary in Batticaloa asked, did the LTTE deliver an Eelam finally? . sympathiser nation into a foe.

# Back from the USSR: When Putin met Trump in Alaska

Trump's invitation to Putin, to meet on US soil, shaking hands on the red-carpeted tarmac and sharing a limousine, announced to the world that Russia — without having backed down one iota from its maximum demands about Ukraine's future — was recognized once more as an equal partner. And with that, Putin broke more than three years of diplomatic isolation

So now Donald Trump and Vladimir Putin have met again, this time in the former Russian territory of Alaska. As an outside observer, one could almost get the impression that time had turned back to the world before the end of the Cold War, when the two superpowers, the United States and the Soviet Union, still determined the fate of the world in haughty unity. But the meeting was much more than a historical reminiscence. Russian Foreign Minister Sergey Lavrov wore a startling garment that he thought appropriate to the occasion, and to Putin's purposes: a sweatshirt with "CCCP" (the Soviet Union's Cyrillic acronym) emblazoned across the chest. If it was a joke, there was menace behind it.

Anyone who knows the longtime Russian foreign minister knows that he is not exactly known for his sense of humor or for overlooking details in the serious business of summit diplomacy. Lavrov's sartorial choice was intentional; he intended to signal that Great Russia has returned to the top table of world affairs. The collapse of the USSR and its East European empire between 1989 and 1991 has been overcome. The empire is back, and it is reclaiming its lost territories. The most important of these territories is of course Ukraine. As former US National Security Adviser Zbigniew Brzezinski famously pointed out in 1994, "without Ukraine, Russia ceases to be an empire." Lavrov's sweatshirt was not about the Cold War, but about the world as Russia intends it to be.

Trump's invitation to Putin, an indicted war criminal, to meet on US soil endorsed that vision. Putin's joint appearance with the US president, shaking hands on the red-carpeted tarmac and sharing a limousine, announced to the world that Russia — without having backed down one iota from its maximum demands about Ukraine's future — was recognized once more as an equal partner. And with that, Putin broke more than three years of diplomatic isolation. The message sent to Ukraine by the summit was also clear: even the US president accepts that the Russian empire is back. Don't think you can escape it by heading West. You belong where you belong: only when you understand this brute fact can peace return. You are on your own; the US will not help you, and Europe alone cannot.

But Europeans should also study the subtext of the Alaska summit very carefully, because for them, too, this manifestation of a world order determined solely by the interests of great powers contains many sobering messages. If the meeting was attended by a whiff of the 1945 Yalta Conference, where World War II's victors



divided the geopolitical spoils, that is because it was another milestone marking the decline of multilateralism and supranationalism.

The idea of "the West" no longer means much, if anything, to America under Trump. All that counts is Trump's worldview and his interpretation of American interests, as muddled as his interpretations are.

Europeans must decide for themselves where they stand. Although the US will not change its formal relations with Europe for the time being, Trump will continue to listen to Europeans and smirk approvingly at their flattery, then ignore them, as he did with the Alaska meeting. Europeans must therefore understand that they are alone in this new world order. The US will no longer take their interests into account, whether in matters of security or trade. Europe must become a global power in

its own right, quickly and energetically confronting the entire spectrum of challenges that this entails, including space, intelligence services, and the entire digital sector. This "turning point" in Europe's long history requires much greater and more far-reaching efforts than just European rearmament with conventional hardware and personnel, as important as that may be. That is the message from Alaska for Europeans.

Why is Trump's America so obviously acting against its own interests? Except for the lifting of economic sanctions, Putin obviously got everything he wanted from the summit, above all escape from diplomatic isolation, US recognition of Russia as an equal world power, and acceptance of Ukraine's fate as an integral part of Russkiy Mir (the "Russian world"). Why is Trump strengthening Russia without any quid pro quo?

# Set politics aside in mass burial probe

## With investigations at Dharmasthala on hold until the SIT gives its report, which could take months, the police could begin a parallel probe into the latest complaints

Under pressure from the opposition and religious bodies, the Karnataka government has made a subtle change in its approach to the Dharmasthala mass burials case, and to the witnesscomplainant who claims to have buried over a hundred bodies around the temple town from 1995 to 2014. With no skeletons coming out of 17 exhumation sites-barring one skeleton and skeletal remains at an unmarked spot—the case has taken a sharp political twist. Deputy Chief Minister D K Shivakumar voiced the first doubts about the masked complainant and Home Minister G Parameshwara said the excavation has stopped. Investigations will continue only after forensic examination of the skeletons and chemical analysis of the soil. The complainant, a

former sanitation worker, is likely to come under investigation. The alleged conspiracy angle will also be probed and, if his claims are false, the state will act against him. The BJP, already septical of the excavation, launched a fusillade against the government for its "anti-Hindu" mindset, and demanded that the CM apologise to the



people. The opposition is claiming the issue has tarnished the image of the Dharmasthala Manjunatha temple and the powerful Heggade family, and are demanding a background check on the complainant and his 'handlers'. BJP leaders reached the town over the weekend to show support to Rajya Sabha MP and dharmadhikari Veerendra

Heggade; the Bhattaraka Jain Mutt seers are planning to gather at the temple on August 29. The Congress cannot afford to upset the majority community and will perforce have to align with the conspiracy theorists to prove its credentials. Yet, the mystery endures. Families are coming forward with complaints of missing girls and suspicious deaths, and activists are seeking a probe into the unidentified bodies buried without due procedure. Forensic experts advise a thorough soil check for human traces. Soil scientists say skeletons disintegrate faster in coastal regions and those buried near rivers could be washed away. The region's acidic laterite soil corrodes bones, so material evidence may not be easily found if exhumed after decades. With

investigations on hold until the SIT gives its report, which could take months, the police could begin a parallel probe into the latest complaints. If indeed the hilly town holds some dark secrets, political and religious affiliations should be set aside in the quest for justice. The truth can never be buried for long.

# Let evidence offer ways to handle stray animals

# Free-roaming animals pose a multi-faceted public health and safety challenge

THE Supreme Court's order on removing all stray dogs from the streets of Delhi-NCR and transferring them to shelters has sparked an animated debate across the country. This debate has become polarised, with animal lovers opposing the order and dubbing those welcoming it as anti-animal and cruel. They are also raising moral, ethical, religious and mythological arguments and invoking grounds of empathy and compassion. In recent years, we have had long legal battles over stray dogs in public places, with courts issuing orders to restrict feeding and then amending them subsequently. One should recognise that stray animals, in fact, all free-roaming animals in human habitats, pose a threat to human health, and we need a public health approach to address this problem. Freeroaming animals in cities and villages include dogs, cats, monkeys and cattle.

The World Health Organisation (WHO) has recognised dog-mediated rabies as a public health problem and launched a global initiative for the elimination of rabies by 2030. India is a signatory to this global call and has committed itself to reaching the goal of ending rabies in the country. Rabies is among the slew of Neglected Tropical Diseases for which special efforts have been mounted by the world health agency, and member countries like India have endorsed them. To fulfil its commitment, India launched the National Action Plan for the Elimination of Dog-mediated Rabies (NAPRE) in 2021. The health ministry has told states to make

rabies a notifiable disease and step up reporting and surveillance systems, as well as access to diagnostic services and vaccines.

Dogs are the main carriers of the rabies virus, though it can also spread from cats and monkeys. Rabies spreads through the saliva of infected animals, which gets transferred to humans through a bite. After a dog bite, if treatment is not given in time, the infected person can die. The treatment for dog-mediated rabies consists of post-exposure prophylactic immunisation administered intramuscularly or intradermally. This

of post-exposure prophylactic immunisation administered intramuscularly or intradermally. This helps to eliminate or neutralise the rabies virus at the bite site and prevent its entry into the nervous system.

Vaccination needs to be accompanied by wound care and administration of rabies immunoglobulins in many cases. The administration of vaccination and immunoglobulins is a complicated procedure, requiring trained medical manpower. In addition, access and availability of vaccines are a major issue, given the fact that most victims of rabies exposure are from vulnerable and marginalised communities. Animal lovers often try to undermine the scale and problem of rabies by hiding behind inadequate reporting and data-gathering by government

agencies. Despite the inadequacies, the rabies burden in India is massive and among the highest in the world. Globally, as per the WHO, one person dies from rabies every nine minutes — mostly after being bitten by a rabid dog. The agency estimates that rabies causes 18,000 to 20,000 deaths every year in India. About 30 to 60 per cent of the reported rabies cases and deaths in India occur in children under 15 years, as bites that occur in kids often go unrecognised or unreported. India accounts for 36 per cent of the global burden of

The rabies burden is directly linked to the rising trend of dog bites in India. Based on data provided by national

agencies, the WHO reported recently that India had 1.22 crore cases of animal bites in 2023 — up from 72 lakh in 2019. However, the Integrated Disease Surveillance Programme data, released by the Central Government in April this year, put the total number of dog bites at 37 lakh in 2024 and the number of rabies deaths at 54.The only scientific and evidence-based solution to the rabies challenge is mass vaccination of



dogs. Since dogs are the primary reservoir of the rabies virus, inoculating them against it would prevent the transmission of rabies from dogs to humans. We need to vaccinate at least 70 per cent of the dog population to make inoculation effective in preventing rabies transmission to humans. In India, this is problematic because the population of stray dogs runs into millions, and our veterinary infrastructure is inadequate to handle the task. Also, the free-roaming dog population may be inaccessible in many areas. If the vaccination coverage is poor, it won't work. Moreover, available dog vaccines don't prevent wildlife-derived rabies.

Vaccination benefits are lost if unvaccinated dogs enter areas or territories where high vaccination rate has been achieved. Dog vaccination also does not solve the problem of dog bites, which is a traumatic experience, especially for children. The solution being advocated in India is animal birth control — taking dogs away from streets, neutering them and releasing them back on the streets. Given the large population of stray dogs and

poor veterinary infrastructure, this strategy could take decades to stabilise the population of street dogs. Meanwhile, the threat of rabies and the additional burden of treatment of dog bites will still loom large. Besides, the fear of dog bites and animal attacks keeps people, particularly children, the elderly and morning walkers, away from public places like parks, recreational facilities, pavements and neighbourhood markets. The same holds true for public premises like schools, colleges, hospitals, government offices, railway stations, bus stands and courts. We need to make all our public spaces safe for citizens. Feeding of free-roaming animals/birds — dogs, cattle, monkeys, pigeons — in public places adds to the problem.

Free-roaming creatures pose a multi-faceted public health and safety challenge, which needs a multi-pronged strategy — vaccination, birth control, relocation, restrictions on feeding, public awareness and strengthening of anti-rabies clinics. The health ministry and state health agencies should seize the opportunity provided by the Supreme Court order to initiate a public dialogue to find durable solutions based on evidence and research. The debate should not be restricted to dogs but include monkeys and stray cattle, which are causing huge economic losses to farmers in some states.

# Mann government misuses police to stop BJP's 'Sewadar Aa Gye Ne Tuhade Dwaar' campaign at 39 **locations: Sarin**

Punjab BJP general secretary Anil Sarin on Wednesday condemned the Bhagwant Mann-led AAP government for allegedly misusing police forces to forcibly halt the "BJP de Sewadar aa Gye ne Tuhade Dwaar" campaign at 39 locations. He labelled it an "antipeople" and "dictatorial" action.

"The Punjab government forcibly stopped this campaign wherein poor and needy people were getting information about the central government's welfare schemes,' alleged Sarin in Chandigarh.

Sarin claimed the initiative—which aimed to spread information and enable enrollment in various central welfare schemes—was completely blocked when the Mann government deliberately intervened.

"Instead of supporting initiatives that empower the poor, farmers, women, and youth, the state government chose to misuse police force and obstruct these programmes. This act not only denied the people of Punjab access to valuable information and guidance, but also exposed the anti-development mindset of the Mann government," Sarin stated.

He further accused the AAP government of creating deliberate obstacles to the implementation of key central schemes—such as free ration distribution, health benefits under Ayushman Bharat, PM Kisan Samman Nidhi, and numerous welfare initiatives for youth and women.

# RV Road interchange in Bengaluru gets steel barricades

The Bengaluru Metro Rail Corporation Limited (BMRCL) has begun installing steel barricades on platforms at the RV Road Interchange Metro Station to improve passenger safety.

The station connects the Green Line with the recently inaugurated Yellow Line.

"The installation of barricades at the RV Road Interchange Station is underway, and so far, on one side, the barricades have been almost completely installed.



installation for the station will be completed in the next two to three days,' a senior BMRCL official said.

The barricades are being set up to ensure safe and effipassenger movement, particularly at the inter-

change where heavy footfall is expected. Officials noted that the 25-minute wait time for Yellow Line trains often leads to passenger accumulation, increasing the risk of overcrowding. By regulating entry and exit points, the barricades are aimed at preventing congestion near train doors and providing commuters with a safer boarding experience. Passengers have welcomed the initiative, saying it will bring more order to crowd management at the interchange.

RV Road is the second station in the Namma Metro network to have steel barricades after Nadaprabhu Kempegowda Interchange. The 19.5-km Yellow Line, connecting RV Road to Bommasandra, was opened earlier this month after multiple delays.

# Standoff over Haryana teacher's death ends, cremation held after CBI probe announcement, AIIMS autopsy

The unusual circumstances surrounding the play school teacher's death, and the alleged mishandling of the case, sparked widespread protests across Haryana.

Eight days after the body of a missing 19-year-old play school teacher was found in a village in Haryana's Bhiwani district, her cremation was held Thursday morning after authorities met the demands made by her family and villagers.

Her family and the villagers refused to allow the last rites, demanding a Central Bureau of Investigation (CBI) probe and a third autopsy at the All India Institute of Medical Sciences (AIIMS) in New Delhi.

The Haryana Government decided to hand over the probe into the death of the teacher to CBI, and the third autopsy was also conducted at AIIMS, Delhi, Wednesday. Meanwhile, the Haryana Government extended the suspension of mobile internet services, bulk SMS (excluding banking and mobile recharge), and all dongle services in the Bhiwani district for 24 hours from 11 am Thursday, citing law and order concerns. It expressed apprehensions that inflammatory content, rumours and misinformation on social media platforms could incite agitation, vio-



lence, arson and vandalism, Sumita Misra Additional Chief Secretary (Home), said the order was being extended following reports from the additional director general of police (CID), and the deputy commissioner of the district.

"This order is being extended to prevent any disturbance of peace and public order only in the jurisdiction of district Bhiwani for next 24 hours i.e. 21.08.2025 11:00 hrs

to 22.08.2025 11:00 hrs. This order is being passed ex-parte in view of the emergent situation as explained in earlier paragraphs. Any person found guilty of violation of aforesaid order will be liable for legal action under relevant provisions of law," Misra said in the order. The play school teacher had gone missing on August 11 after visiting a nursing college to inquire about admission. When she failed to return home by evening, her father contacted the police through Dial-112, Haryana's emergency response system. The family alleged that although the police accompanied them to the college, they only questioned three intoxicated men who claimed not to have seen her and stated that the college had closed at 1 PM.

Her body was discovered on August 13 in a field near a canal. The initial postmortem was conducted at Bhiwani Civil Hospital, followed by a second examination at the Post Graduate Institute of Medical Sciences (PGIMS, Rohtak). However, the family raised serious concerns about the condition of the body, which was reportedly missing vital organs, including the neck, and demanded a third autopsy at AIIMS.

The unusual circumstances surrounding her death, and the alleged mishandling of the case, sparked widespread protests across the state, with students and residents joining in. The Opposition also criticised the BJP-led Haryana government, accusing it of a collapse in law and order, even as Chief Minister Nayab Singh Saini insisted he had been receiving minute-by-minute updates from the police, and that several people were interrogated in connection with the case.

In response to the growing unrest, the Haryana Government transferred the Bhiwani superintendent of police, and suspended some other officers.

Meanwhile, the Haryana Police, citing the viscera report and other evidence, suggested the possibility of suicide. This theory was firmly rejected by her family and the villagers, who refused to allow the cremation until their demands for a CBI investigation and an AIIMS autopsy were ful-

# **HC** suspends conviction of Abbas Ansari in hate speech case: 'refusal to do so also amounts to injustice to his electorate'

The Allahabad High Court on Wednesday suspended the conviction of Abbas Ansari, the son of gangster-politician Mukhtar Abbas Ansari, in a three-year-old hate speech case, saying "refusal to stay his conviction amounts to injustice not only to him but also to the electorate which elected him". Abbas Ansari, who was elected from the Mau Assembly seat in 2022 Uttar Pradesh elections, was sentenced to two years of rigorous imprisonment in May this year, leading to his disqualification from the membership of the House.

The 33-year-old was booked on March 3, 2022, for his campaign speech in which he had allegedly threatened to "teach a lesson" to the administrative officials of Mau after the elections. On May 31 this year, a court in Mau convicted him and sentenced him to two years of imprisonment, leading to his disqualification from the UP Assembly. He then challenged the order in the sessions court, which on July 5 stayed aspect," the order stated.

# **Ganesha festival: 75 single-window** centres to be set up in Bengaluru

Ahead of the Gauri-Ganesha festival, Bruhat Bengaluru Mahanagara Palike (BBMP) has issued a set of guidelines on Wednesday, which includes a complete ban

on the use of chemical paints, thermocol, and plaster of Paris (PoP) idols. Idols found to be made with any of the aforementioned items will be seized and disposed of, and criminal cases will be filed against individuals found responsible, BBMP Commissioner Chief

Maheshwar Rao M said. The order follows discus-

sions held on August 5.

To erect Ganesha idols in public places, organisations or individuals must apply at the offices of the assistant executive engineers designated as nodal officers at the sub-divisional level.

The nodal officers will coordinate with the police, BESCOM, fire department, and other relevant departments to obtain and issue approvals. To streamline the process of granting permissions for the installation

of Ganesha idols, 75 single-window centres will be set up at subdivisional offices within BBMP limits, and relevant officers will be present at these centres to provide approval.

As far as immersion is concerned, designated immersion locations in each ward will be identified by BBMP. To handle the wet waste generated during the festival celebrations, arrange-

ments will be made to send the waste to the BBMP's processing units. Apart from public displays, individuals celebrating at home are urged to immerse the idols at home in buckets, and repurpose the clay remnants into manure.

# 'Misuse of muafi land': ED searches Wahid Sandhar Sugar Mill, Gold Gym, linked premises in Phagwara

Jalandhar.

The Enforcement Directorate (ED) on Wednesday carried out search operations at eight locations across Punjab and Chandigarh in connection with their investigation into money laundering involving Phagwara-based Wahid Sandhar Sugars Limited and related entities and persons,

Sources said raids were conducted at Wahid Sandhar Sugar Mill, Gold Gym and several other premises in Phagwara linked to their owner Jarnail Singh Wahid.

Sources said it was found during the probe that Wahid Sandhar Sugars Ltd had "misused the muafi land initially allotted by Maharaja Jagatjit Singh of Kapurthala State in 1933. The said muafi land was intended for running a sugar mill as per the conditions of allotment, and its mortgage or sale was strictly prohibited."

Wahid Sandhar Sugars Ltd had acquired the rights to operate the sugar mill on the muafi land in 2000. However, the



company allegedly breached the conditions by mortgaging and selling the land, said ED sources. "By engaging in such activities, the firm caused losses to the state government while wrongfully gaining benefits

for themselves," ED officials said, adding that "the proceeds of crime generated out of these alleged activities are under investigation, with the estimated amount pegged at approximately Rs 95 crore.'

For years, Wahid and his sugar mill have faced allegations of failing to pay farmers' dues amounting to over Rs 40 crore, along with charges of misusing government land.

Several ED teams, comprising around four dozen officials, launched simultaneous searches at different locations, including residential and commercial properties associated with Wahid, they said.

According to ED sources, based on an FIR lodged by the Punjab Vigilance Bureau, the investigation into the money laundering charge was initiated against the firm.On Wednesday, officials examined documents, electronic devices and records related to financial transactions, sources said The action is also linked to complaints by farmers, who have long protested against the non-payment of their dues, they said, adding that investigators are now probing whether the withheld funds were diverted for illegal transactions or money laundering.

# Himachal apple growers struggle amid washed-out roads; transportation costs skyrocket

Incessant rain also made apple growers in Himachal Pradesh pluck the fruit much earlier than the desired time. The matter was raised during the ongoing Monsoon Session of the Assembly.

Naresh Sharma, a small-time apple grower in the Shimla district of Himachal Pradesh, usually takes his crop to the Parala mandi, located 7-8 kilometres from his village. Usually, transporting a single carton of apples from Kiar under the Theog subdivision costs him around Rs 50.

This year, however, the cost has skyrocketed to Rs 200 per carton.

Reason: An over-flooded Gai Khad (nallah), which has no bridge, and has become extremely risky to cross due to the incessant rain lashing the region. Crossing Gai Khad is essential to reach the Bhanu Raina link road that connects to the Parala apple market. "Despite the lack of a bridge, it was earlier manageable to cross the khad. But now, due to the strong water current and continuous rain, it's too dangerous for a loaded four-wheeler," says Naresh, who is also up-pradhan of Kiar Gram Panchayat. "I've had to employ Gorkha workers to carry each carton across the khad on their shoulders. transport the apples to the mandi. All this has pushed my transport cost to Rs 250 per carton," says the 31-year-

"A fortnight ago, we met the Deputy Commissioner of Shimla, Anupam Kashyap, about Gai Khad. Although work to lay the culverts in the khad started, two of the culverts C grade category," says Jagdish

"The incessant rain and bad weather made many apple growers pluck their fruit much earlier than the desired time. This kind of fruit falls under the C category, which couldn't be sold in the markets, and the Himachal Horticulture Produce Marketing and Processing Corporation Ltd (HPMC) is bound to procure such apples at the rate of Rs 12 per kg. However, the apple should not be in a bad condition. We have to see the quality of the apple before procuring it."

Meanwhile, the Horticulture Department has projected an estimated production and procurement of 6 lakh metric tonnes (MT) of apples this season. # **Construction of Ram Temple, built with stones and** no iron, likely to enter IIT-Roorkee, CBRI syllabus

THE CONSTRUCTION process of the Ram Temple in Ayodhya using stones and no iron — is likely to be included in the syllabus at two institutes in Uttarakhand's Roorkee: The IIT and the Central Building Research Institute (CBRI).

The Shri Ram Janmabhoomi Teerth Kshetra, in a meeting convened in Ayodhya over the past three days, has decided to hand over five years' of time-lapse video footage to the two institutes to turn into study material and also be featured in a documentary.

Chairman of the construction committee of the temple, Nripendra Mishra, told The Indian Express on Wednesday that as soon as he is back in Delhi, he would invite the heads of both the institutes and would discuss the signing of a "detailed agreement" with them in this regard.

He informed that five cameras were installed on the Temple premises to capture the time-lapse video footage of each day of the temple construction – right from the day of laying of foundation stone in August 2020, soil testing, different phases of construction to its completion, likely in December this year.

"The idea was to take all the possible and relevant photographs to show how the temple construction is going on," Mishra told The Indian Express, adding, "We have decided to initiate talks with IIT Roorkee and CBRI so that they may, perhaps, make a syllabus on the technology of the temple construction, particularly of stone with no iron. It would become part of their syllabus and course for students to study.'

Asked about how the footage would be handed over, Mishra told The Indian Express, "A detailed agreement would be signed with the institutes as the footage is the intellectual

# Court questions Haryana on migrant policy after Indians wrongly held in Gurugram

The Punjab and Haryana High Court on Wednesday questioned the Haryana government on whether it has a standard operating procedure (SOP) to verify the identity of migrant workers being detained in the state. The query followed a recent crackdown by Haryana Police on alleged illegal

The issue surfaced after several Bengali-speaking persons picked up in Gurugram in July, on suspicion of being undocumented Bangladeshi nationals, were later found to be Indian citizens from West Bengal and Assam. They were released after their documents were verified.

The petition, filed by Delhi resident Nirmal Gorana, argued that neither Haryana nor Punjab has a proper verification process in place, or that existing rules are being "flagrantly violated". The state of Haryana, Gurugram's Commissioner of Police, and the district magistrate have been named as respondents.

Defending the police action, Haryana's counsel told the court that officers were acting under Union government directions. In May 2025, the Ministry of Home Affairs (MHA) had asked all states and union territories to form Special Task Forces in each district to identify and deport illegal Bangladeshi migrants within 30 days.

The Haryana government submitted that an SOP exists, created by the MHA's Foreigners Branch, but noted that the petitioner had not shown whether it was publicly available on the government's website.

The petitioner's lawyer, Bhavpreet Singh Dhatt, told India Today TV that "over a thousand workers detained in Gurugram were alleged to be Bangladeshi, but many had valid documentation or were from West Bengal and Assam. While some were eventually released, there was no SOP guiding these detentions.

# Delhi High Court upholds MCD move to develop land for kids' playground

Agency New Delhi.

The Delhi High Court has dismissed a petition by residents of Model Town-II seeking to convert a parcel of land, adjacent to an MCD school, into an ornamental park, ruling that its use as a playground for schoolchildren is vital for their physical and overall development.In a judgment delivered on August 19, Justice Mini Pushkarna upheld the Municipal Corporation of Delhi's (MCD) decision, stressing that the "requirement of the said parcel of land for the school students as a playground is indispensable for their physical development and growth."

The court noted that several parks already exist in the area, including a 100-acre facility, available for public use.

The case arose from a long-standing dispute dating back to 1987-88 when residents of F Block, Model Town-II, opposed the conversion of the plot into a multi-storied school building. At the time, MCD had assured them that only a temporary shed would be built and the permanent structure would be shifted elsewhere.

However, the school building was later constructed on the site, prompting litigation. A compromise led to the withdrawal of the earlier suit, but residents continued to press for the development of the remaining land into a park, citing an undertaking given in 2011.

When MCD began constructing a boundary wall and staircases around the land, the petitioners moved the high court again, arguing that the civic body had failed to honour its commitment to develop the area as an ornamental park.

MCD countered that the petitioners lacked locus standi and had not demonstrated any harm caused by the land's use as a playground.

# Bills to oust PM, ministers referred to parliamentary panel. What happens

Union Home Minister Amit Shah has introduced three bills to remove jailed Prime Minister and ministers. The legislation faces severe opposition claims of unconstitutionality and possible misuse.

Union Home Minister Amit Shah on Wednesday introduced three On Thursday, Shah moved a similar contentious bills that would allow the removal of the Prime Minister, chief ministers, and ministers if they are jailed for more than 30 days for offences carrying a minimum sentence of five years.Describing the bills as a major anti-corruption measure, Shah moved a motion in the Lok Sabha to refer them to a Joint Parliamentary Committee (JPC) for detailed scrutiny. The JPC will include members from both the Lok Sabha and Rajya Sabha.

The Opposition denounced the legislation as "draconian" and "unconstitutional." They accused the ruling BJP of planning to misuse central agencies to frame non-BJP chief ministers, imprison them, and destabilise state governments. Despite

the outcry, Shah's motion was passed by a voice vote in the Lok Sabha.

submitted before the next parliamentary session, which would delay the matter by at least three months. Moreover, as the bills involve constitutional amendments, they will require a two-thirds majority in Parliament — an uphill task for the government.

# "To Blackmail, Torture Nitish Kumar": Tejashwi Yadav On Bill To Sack Ministers

RJD leader Tejashwi Yadav has

criticised a set of bills to sack ministers in the federal or any state or union territory government including the Prime Minister and Chief Minister - if they have been jailed (not necessarily convicted) of 'serious criminal charges' for 30 consecutive days.Mr Yadav accused the ruling BJP of trying to 'blackmail' and 'torture' the chief ministers of Bihar and Andhra Pradesh, i.e., Nitish Kumar and Chandrababu Naidu, without whose combined support Prime Minister Narendra Modi's government cannot prove a Lok Sabha majority.

He claimed the motive was to keep allies, including Mr Kumar and Mr Naidu, on a tight leash. The bill, he



said, was a message, particularly before the Bihar election this year - toe the line or be arrested in money laundering cases registered by the Enforcement Directorate and be stripped of power.

"They are bringing this for Nitish Kumar and Chandrababu Naidu. It (the bill) has only job... to blackmail. If PMLA

Act) cases are slapped by Enforcement Directorate... there can be no quick bail. These are torture tactics," he told reporters."Instead of building the country, they are distorting it," Mr Yadav raged, echoing remarks by other senior opposition leaders, including the Congress' Rahul Gandhi and Priyanka Gandhi Vadra.

The Trinamool's Abhishek Banerjee pointed out the ED's poor conviction rate in cases involving allegations against opposition political leaders, a topic red-flagged by the Supreme Court.In March the government admitted - as the ED was grilling RJD patriarch Lalu Prasad Yadav - that decadal conviction rate for cases against politicians is 1 per cent.

The Constitution's makers never imagined that leaders would run governments from prison," sources told.

The tipping point came last year. On August 7, 2024, days before Independence Day, Delhi found itself without a leader to hoist the national flag. Then Chief Minister Arvind Kejriwal was in jail but had not resigned, instead As the opposition began raising slogans writing to the Lieutenant Governor to nominate Minister Atishi to perform the duty on his behalf. None of the jailed AAP leaders had stepped down. In effect, the government was being run from behind bars. It wasn't just Kejriwal. Satyendar Jain,

# CA explains why 80% of emergency funds don't work when needed

New Delhi.(Agency)

An emergency fund is meant to be your safety net when life takes an unexpected turn – a sudden job loss, medical bills, or urgent home repairs. But, as CA Abhishek Walia points out, most people discover too late that their so-called "emergency fund" doesn't really work. He wrote on LinkedIn, "Here's why 80% of 'emergency funds' fail when you actually need them. An emergency fund is supposed to save you in crises: job loss, medical emergency, sudden repairs."Walia further added that one common mistake is keeping this money in the same bank account as everyday expenses. It slowly gets used up on non-essential spends. Another issue is the amount people save. Many feel that setting aside Rs 20,000 is enough, but when a real crisis strikes, that sum hardly covers the costs. There's also the temptation factor. During salary hikes or bonuses, people often dip into their emergency savings to buy gadgets, plan holidays, or fulfil other wants. Over time, what was meant to be a lifeline turns into just another pool of spending money. According to Walia, the solution is simple but requires discipline. "A true emergency fund should be separate, sufficient, and sacred," he explains. Separate, by keeping it in another bank account or a liquid mutual fund; sufficient, by ensuring it covers at least six months of your household expenses; and sacred, by never touching it unless a genuine emergency arises. He adds, "If you don't wall it off, it's not an emergency fund, it's just extra money lying around.'

The idea is not to deny yourself small pleasures, but to protect your future self from sleepless nights and financial stress. As Walia puts it, "Your future self doesn't need another gadget. It eeds a lifeline when life punches hard."

Building a solid emergency fund might not feel exciting today, but when the unexpected happens, it could be the most important financial decision you ever made.

# **Education loan provider** Avanse secures \$200 million ECB; to expand lending support for poor students

Leading education loan provider Avanse Financial Services Limited has raised a multi-currency syndicated External Commercial Borrowing (ECB) facility equivalent to \$200 million. Classified as a social loan, this ECB facility will be used to support students from economically weaker sections in pursuing their academic aspirations, the company said in a Thursday statement.

ECB refers to commercial loans availed by eligible resident entities in India from recognised nonresident entities abroad.

The education-focused NBFC (non-banking financial institution) said the transaction was jointly led by DBS Bank Limited, through its IFSC unit at GIFT City, and HSBC India as mandated lead arrangers and bookrunners for the commercial loan, which drew participation from leading banks across Taiwan, Japan, Singapore, Sri Lanka, the UAE, and India. The deal included commitments of \$141.3 million and a Japanese Yen tranche equivalent to \$58.7 million, aggregating to \$200 million.

Avanse said the ECB route enables access to diversified pools of global capital while strengthening long-term partnerships with domestic and international institutions, enhancing oth funding resilience and market positioning.

"This syndicated social-linked loan marks another important milestone in our mission to make education financing seamless and affordable for every deserving Indian student," said Amit Gainda, Managing Director & CEO of Avanse Financial Services, in the statement.

# CCPA fines Rapido Rs10 lakh for misleading advertisements

**CHENNAI.(Agency)** 

The Central Consumer Protection Authority (CCPA) has imposed a fine of Rs10 lakh on bike-taxi platform Rapido for running misleading advertisements and engaging in unfair trade practices. The penalty relates to Rapido's promotional campaigns "Guaranteed Auto" and "AUTO IN 5 MIN OR GET Rs 50." The regulator found that these advertisements made promises that were not delivered as advertised.

According to the CCPA order, as quoted in reports, Rapido's claim of compensating customers with Rs 50 if an auto was not available within five minutes was deceptive. The benefit was not provided in cash but as "Rapido coins," usable only for bike rides and expiring within seven days. This made the actual value significantly lower than the advertised Rs 50.

The authority also noted that important disclaimers, such as "up to Rs 50" and conditions of use, were hidden in small print or brief "T&C apply" notes, making them less prominent than the main claim. Furthermore, the so-called guarantee was offered by individual drivers and not by Rapido itself, a detail that was not communicated clearly to consumers.

The misleading advertisements ran for about 548 days across more than 120 cities in multiple regional languages. During this period, consumer complaints surged. Data from the National Consumer Helpline (NCH) showed that grievances against Rapido rose from 575 cases between April 2023 and May 2024 to 1,224 cases between June 2024 and July 2025. Many complaints related to failed services, overcharging,

non-refunds, and driver misconduct. In its order, the CCPA directed Rapido to:

report within 15 days.

Immediately stop the misleading campaigns. Refund the ?50 compensation in full to affected consumers, without conditions. Submit a compliance

# Online Gaming Bill 2025: What are the different penalties in it

The Bill, which was passed in the Lok Sabha soon after it was introduced, focusses on reducing risks linked to addiction, money laundering, and misleading advertising.

New Delhi.(Agency)

Parliament on August 20 passed the Promotion and Regulation of Online Gaming Bill, 2025, which introduces strict rules and penalties for online money gaming companies, their promoters, and even individuals involved in violations.

The Bill seeks to regulate the fast-growing but controversial online gaming sector by banning money-based online games and setting harsh punishments for offenders.

The Bill, which was passed in the Lok Sabha soon after it was introduced, focusses on reducing risks linked to addiction, money laundering, and misleading advertising.

Kunal Gala, Partner, Deal Value Creation, BDO India, said that the bill focusses on player-centric protection and responsible gaming, the very factors that build the ecosystem with a trust basis.

It provides clear deails of fines, imprisonment, and penalties for repeat offenders, while also holding companies and their top executives accountable.

PENALTY FOR OFFERING ONLINE **MONEY GAMING** 

Any person who offers online money gaming services against the provisions of Section 5 will face imprisonment of up to three years, or a fine of up to Rs 1 crore, or both.

PENALTY FOR MISLEADING **ADVERTISEMENTS** 

Those found guilty of making or promoting advertisements of such banned games in any media will face imprisonment of up to

two years, or a fine of up to Rs 50 lakh, or

PENALTY FOR UNAUTHORISED TRANSACTIONS

Any person engaged in transactions or authorisation of funds linked to banned games, in violation of Section 7, will face imprisonment of up to three years, or a fine of up to Rs 1 crore, or both.

HIGHER PUNISHMENT FOR REPEAT OFFENDERS

The Bill makes punishments stricter for repeat violations. If a person convicted under Section 5 or Section 7 commits the offence again, the minimum punishment

will be three years of imprisonment, which can extend up to five years. The fine will not be less than Rs 1 crore and can go up to Rs 2 crore.

Similarly, repeat offences under Section 6, which deals with advertisements, will attract imprisonment of at least two years, extendable up to three years, along with fines ranging between Rs 50 lakh and Rs 1

COGNISABLE AND NON-BAILABLE **OFFENCES** 

Offences under Section 5 and Section 7 will be treated as cognisable and non-bailable under the Bharatiya Nagarik Suraksha Sanhita, 2023. This means the police can register a case and arrest without prior approval, and bail will not be easily

LIABILITY OF COMPANIES AND DIRECTORS

If a company is found guilty of an offence under this Bill, not only the company but also the persons in charge of its operations at the time of the violation will be held

# Why zero GST on insurance premiums doesn't mean cheaper policies for you

New Delhi.(Agency)

The Goods and Services Tax (GST) is expected to undergo major changes, as hinted by Prime Minister Narendra Modi in his Independence Day speech. One of the proposed changes is zero GST on insurance premiums. If approved by the GST Council, customers would pay only the base premium quoted by insurers, with no additional tax. At present, every new or renewed life or health insurance policy attracts 18% GST on the premium. For instance, if the annual premium is Rs 20,000, the tax alone adds Rs 3,600, raising the total payment to Rs 23,600.On the surface, removing GST seems like a big relief, but experts caution that the outcome may not be what many are expecting.

WHY ZERO GST MAY NOT REDUCE **PREMIUMS** 

Abhishek Kumar, Sebi RIA and founder Sahaj Money, said that a GST rate cut from existing 18% to lower rate would directly lower insurance policy costs for customers by reducing the GST liability on their premiums.

"However, if the GST rate is made zero then the savings would be much less because insurance companies would lose their Input Tax Credit (ITC) benefits and would pass on their higher cost to customers through higher base premiums," he added.

HOW INPUT TAX CREDIT WORKS IN **INSURANCE** 

Kumar explained that under the current system, insurers can claim ITC against GST already paid on their operational costs. He mentioned that this helps reduce the net tax they owe and keeps overall policy pricing more stable. Removing GST entirely would take away this mechanism.

"ITC allows insurers to lower their tax burden by offsetting GST paid on expenses with what they collect from policyholders," Kumar explained. Without ITC, the cost pressure shifts back to the customer.If GST is cut to 5% with ITC intact, policyholders could save a sizeable amount. For example, on an annual premium of Rs 25,000, the tax would drop from Rs 4,500 to just Rs 1,250, a saving of Rs 3,250. But in the case of zero GST, insurers might increase the base premium, meaning the actual savings would be far smaller.Kumar summed it up by saying that while a headline of "zero GST" sounds like a big win for customers, in reality, the benefit may not reach them in full. The Aadhaar version is valid if your Aadhaar, bank details, and Form 11 information are already updated on the UAN portal. In this case, you can directly submit it to the EPFO office without your employer's signature.To use your PF balance for financing an

These derivatives allow investors to participate in the price movements of

A surge in derivatives trading, which has also been driven by retail investors, has prompted the regulator to limit the number of contract expiries and increase lot sizes to make such trades more expensive. The curbs came in after Sebi has found that retail investors were heavily losing from the derivatives to the tune of Rs 1.25 lakh per investor. Addressing the annual capital markets summit organised by the industry lobby Ficci here Thursday, he

also called for further deepening the cash segment in the market so that the quality of the market is maintained. He further said the cash segment has more than doubled in the past three years. Later talking it reporters on the sidelines, Pandey the details on increasing the tenure and maturity of derivatives will be finalised after talking with the industry. Whether Sebi prefers a longer term, he said "Yes, I mean, that is qualitatively we have to see, but we have to calibrate it. So if you really look at my



Al Pather Lake's environs are freezing, even in the summer, and susceptible to sudden showers. It's essential to carry woolens and adequate protection against the elements.

#### Khilanmarg

You can trek up from the Gulmarg bus stand if you like but a more prudent way up involves perching yourself on the back of a pony. After a bone-crunching hour long ride, Khilanmarg emerges in view as a carpeted meadow of flowers in the summer, and a frozen expanse of snow in the winter. There's some ice in the upper reaches even in the summer months and there are sled-operators who'll take visitors on hair-raising ride from one end to the other. Scenic views abound from almost any corner—the southeast edge affords magnificent vistas of the twin peaks of Nun and Kun.

#### **Gulmarg Gondola**

A huge attraction: lines start forming at the gondola ticket office almost two hours before it opens in the morning. The cable car takes visitors all the way up to Mt. Apharwat Mountain (3747 metres) from where you can get panoramic Himalayan views including major peaks like the Nanga Parbat. The ride has two phases: those who're not comfortable with heights can opt to come back from the Kondoori valley a mere 400 metres up the mountain. Tickets can also be booked at the tourist office in Srinagar or online.

The clear azure sky suddenly changes colours and a darker shade of grey begins to envelop the atmosphere. It looks as if the sky was perennially missing the floating grey clouds in its vicinity. The rainiest place on planet earth for a substantial period in the past, Sohra in local parlance or Cherrapunjee as the world knows, creates a heavy concoction of flowing rivers, cool breeze, swaying trees and hot noodle soups. There is a thick cover of mist that greets anyone whose footsteps cross these undulating green valleys. Cherrapunjee still retains the charm a British summer retreat with solitary dilapidated bungalows and remnants of colonial churches dotting the verdant valleys in between the prolific number of hotels that have conjured up recently in these parts. Cherrapunjee is the second largest town after the capital city of Shillong in Meghalaya and lies at a distance of close to 56 km from Shillong. There are regular cabs available from Shillong for a 2 hour drive to Cherrapunjee. The sight of the waterfalls in the monsoon season from July-September is the prettiest but this place also offers cosy retreats and nature walks during the winter months from October to February.

## **Dainthlen Falls**



About 2 km away from Cherrapunjee, one comes across this fall which is just 5 km away from the road. The splendour of this falls is enhanced by the presence of large number of natural potholes, much bigger in size and dimension than the regular ones on the metallic roads. The view of this waterfall tumbling down from a height of close to 80-90 m is from its source and provides a good opportunity to follow the path all the way to the bottom. There is a small legend associated with the name of this fall. According to locals, there was a huge demon python by the name of Thlen who was drenched in greed and power. Some brave men caught the animal and destroyed its hood with a huge stone near this fall. Some of the marks present on the stones are still reminiscent of the violent struggle of that snake, say the naysayers. As a result, this fall got this name. The turbulence of this fall gathers a lot of steam during the monsoons compared to the rest of the year.

## Mawsmai Cave

To the south of Cherrapunjee Market, about 6

village, a small clearing in the grasslands amidst the forests surrounding it leads to the entrance of this cave. This is a popular cave among the tourists and beginners alike. This cave is not very long and provides ample opportunity to see the stalactite and stalagmite formations of water dripping along the limestone walls. This is fully lighted and divided into old and new sections. A small entrance fee is charged from the tourists for entering this cave. A torch would be extremely handy in regions of narrow openings where the main source of light gets obstructed by the close proximity of the people in the queue. For the caving enthusiasts, there are some technical and challenging caves in Jaintia Hills where proper caving gears are required to do explorations. The population of bats inside the cave is almost negligible here due to excessive lighting and heavy visits of the regular tourists here. **Kynrem Falls** 

Kynrem Falls, located at a distance of 12 km from Cherrapunjee in the East Khasi Hills district is a three-tiered waterfall covering a distance of 305 m vertically. The base of the falls passes through the motorable road that goes all the way to Bangladesh and a small bridge provides movement for vehicles and

people across this waterfall. The fall spreads out in two different streams or rivulets with each of them gaining momentum by getting merged while flowing down the last leg of the third tier. The source of this fall originates from Thangkharang Park. It's the 7th highest waterfall in India and due to its seasonal nature: this waterfall is best enjoyed during the monsoons. The roaring din of the cascading fall poses a healthy competition to the noisy cicadas all around the neighbourhood of this fall.

## Living Root Bridge

Living Root Bridges are century-old natural shoots of the banyan fig trees grown around the vicinity of large and small rivers which in turn aid in

providing a means to cross the bridges by entangling those shoots from opposite banks. As the shoots gain strength with time, the bridges become more and more robust. The phenomenon is unique and endemic to this part and travellers from around the world come to see the miracle of these living root bridges. There is a small village known as Tyrna, about 2 km from away from Cherrapunjee where the journey to these living root bridges begins. Across 25000 steps covering a distance of close to 3.5 km, the village of Nongriat is the focal point of the famous Double Decker Living Root

There are two layers of bridges on the river here as according to local tales, the lower living Root Bridge got submerged in a heavy deluge around 40 years back. As a result, a higher elevated living root bridge above this one was conceived to tide over this problem. Contrary to the popular belief, the living Root bridges are more sturdy compared to the steel wire ones and provide a firm footing on the base for easy movement all along. The small natural swimming pools around this bridge provide

good source of relaxation after a hard day's hike. Close on the heels of 340 m drop, the tallest all tumultuous means creates a wonderful There is also a small guest house on the other side of the bridge run by Meghalaya Tourism that caters to tourists here.

# Wakaba Falls

It's a tiered waterfall close to 170-190 m in height and provides a stupendous beauty of surrounding canyon all around its vista. The fall lies at a distance of 15 km from Cherrapunjee towards Shillong. The fall becomes completely invisible during the winter months with thin streams of water creating a pattern reminiscent of the crisscross pattern of the hair strands at the back of a woman's head. The beauty of this fall comes alive during the monsoon months as the garrulous water makes its way through huge boulders and vegetation in and around the canyon. Sometimes heavy mist envelops the entire canyon and sighting the waterfall turns into a peek-a- boo through the dense layer. One needs to have a bit of luck and patience to witness its full glory. There are some good viewpoints all around the canyon to witness the magnificence of this waterfall.

Nohkalikai Falls

plunge waterfall in India is a vista to behold. The mist around the valley of this fall along with the sad legend associated with the name of this fall creates a mystic aura that engulfs the canyon all around. The name 'Nohkalikai' in Khasi language refers to 'Jump of Likai'. According to the folklore of this region, Likai was a married woman living along with her daughter and husband. Her husband died and she had to remarry but due to little means of income she had to become a porter and remain away from her home and child for long hours during the day.

Whenever she was at home, she would give full attention to her child. As a result, her iealous husband killed the infant and cooked her after throwing away her head and bones. Likai returned home and ate the meat but soon realized her folly and went mad with rage. With remorse and guilt, she jumped off the cliff close to the waterfall and hence the waterfall got the name 'Nohkalikai'. A calm and serene turquoise pool of water at the base of this waterfall illuminating death as a placid end to

contrast to the gushing volume of this fall from the cliff. There is a flight of stairs that lead close to the base of this fall and also provide terrific vantage points to enjoy this waterfall.

## Thangkharang Park

This park is situated at a distance of 12 km from Cherrapunjee and the source of Kynrem Falls lies in this park. This park provides ample prospects for travellers to revel in the panoramic view of the moorish plains of Bangladesh far ahead. The sight of serpentine roads along the valleys from this park is a joy to watch. There are two foot bridges within the park which provide wonderful view points to vast rolling green valleys and the water logged plains behind them. This park also hosts the famous Khoh Ramrah rock popularly known as the Shiva Rock.

This rock is a huge piece of stone in the shape of a lingam that stands precariously on the other side of the park opposite to the entrance. This park is also a fantastic place to enjoy the usual 4 o'clock rains that grace this part of the region every day in the evening during the monsoon season.
