Assam Government Approves SOP For Inter Religious Land Transfer

Agency Dispur.

The Assam government on Wednesday approved a Standard Operating Procedure (SOP) for inter-religious land transfer in the state. Briefing over the decision Assam Chief Minister Himanta Biswa Sarma said that "all such transfers will come to the government".

'In a sensitive state like Assam, land transfer needs to be carefully handed over. All such transfers will come to the government and we will scrutinise all the transfers. We will look at the source of funds of the person who is buying, whether that land sale will affect the social fabrics of that locality, whether any national security threat is involved in certain cases, accordingly the District Commissioner will take the final decision" Mr

The designated Nodal Officer within that Department would then transmit it to the Special Branch of the Assam Police. The Special Branch of the Assam Police will examine the proposal to identify any elements of fraud, coercion, or illegality, verify the source of funds used for the purchase, assess potential implications for social cohesion, and safeguard national security. Thereafter, the proposal would be returned to the government, with the District Commissioner taking the final decision," he added. West Bengal Chief Minister Mamata Banerjee on Thursday said she would not let anyone take away people's voting rights, alleging that the BJP was unleashing "linguistic terror" on Bengalis.Addressing a rally of the TMC's students' wing in Kolkata, Ms Banerjee claimed that the BJP has deployed over 500 teams from across the country in West Bengal to conduct surveys aimed at deleting names of voters from the electoral rolls.

You must yourself check whether your names are still there or have been struck off from the voters' list... You must ensure you have Aadhar cards," she told the rally."I will not let anyone take away people's voting rights till I am alive," she added.Ms Banerjee alleged that the Election Commission was intimidating state government officers.

The EC is threatening our officers. Gurgaon records 2nd 'good' air day in a row; AQI at 35

Gurgaon. (Agency)

For the second straight day on Wednesday, the city breathed 'good' air, with the air quality index (AQI) staying low at 35. It was recorded at a rare 30, the first 'good' air quality day in nearly a year, on Tuesday. The low readings this week, however, come with a caveat they are based on data from Gwalpahari only, one of the city's four continuous ambient monitoring quality stations. The other three located in Sector 51, Vikas Sadan, and Teri Gram — have been non-operational for months because the state pollution board is yet to appoint an agency to manage them.

Experts say these brief spells of clean air highlight the need for consistent, year-round pollution mitigation efforts.



"The recent good air quality days in Gurgaon need to be seen with some caution, as only one of the city's four monitoring stations is currently operational. With limited data, AQI may not fully capture conditions across the city and could reflect cleaner pockets rather than overall air quality. However, the improvement can, to some extent, also be attributed to the recent rainfall," said Manoj Kumar, an analyst at Centre for Research on Energy and Clean Air (CREA).On Wednesday, 33mm of rainfall and winds up to 10kmph were responsible for dispersing some pollutants, India Meteorological Department

."Think of the recent rains

as a temporary curtain drawn over a stage where the set is still broken. The fundamental systems of transport, waste, and industry continue to produce high levels of pollution. Once the winter stillness sets in and the curtain of rainfall lifts, we will be left staring at the same dangerous reality."We must use intermission fundamentally change the production-not just the presentation—of our air quality through decisive, coordinated action," said Sunil Dahiya, founder and lead analyst at Envirocatalysts.

In Gurgaon, where AQI typically stays in the 'moderate' to 'poor' range and spikes to 'severe' levels during winter, data shows that in 2023, the city did not record a single 'good' air day. The last time that the city's AQI was 'good' was on Aug 27 in 2024, when it was clocked at 35. Moreover, the last time AQI was below 30 in the city was nearly three years ago - on Oct 10, 2022, when it was 29.

Meanwhile, a 2021 study by Energy Policy Institute of the of University that estimated Gurgaon residents lose 9.9 years of life expectancy due to prolonged exposure to toxic air, with Haryana ranking fourth nationally in pollution-related life expectancy loss at 8.4 years.

Uneven showers Gurgaon records 33mm rain, Farrukhnagar leads with **59mm**

Gurgaon. (Agency)

The city received an average of 33mm of rainfall in 24 hours until 5pm on Wednesday, with sharp variations across different tehsils. According to the district administration's rainfall report, Farrukhnagar recorded the highest rainfall at 59mm, followed by Manesar with 55mm. Wazirabad received 34mm, while Kadipur and Harsaru logged 3mm each. The main city area recorded 27mm. Sohna saw lighter showers at 17mm, and Badshapur reported the lowest in the district with just 10mm. No major waterlogging and traffic congestion were witnessed in the city as the rain stopped was continuous but not heavy. It stopped completely around

Gurgaon's minimum temperature on Wednesday was 25.6 degrees Celsius, which was 0.8 degrees lower than the previous day. The maximum temperature was 28.8 degrees Celsius, which was 0.4 degrees lower than Tuesday's.Officials said such uneven distribution of rain is typical during this phase of the monsoon. "The showers have brought some relief from the heat, and more light to moderate rainfall is likely over the next two days," said an official from the India Meteorological Department (IMD).

Light to moderate rain is likely at a few places in Haryana on Aug 28, while heavy rain is likely at isolated places on Aug 29 to Sept 2. A yellow alert for heavy rain is in effect until Sept 2. The spell is also expected to help improve air quality and ease dust levels across the city.Dr Vishwas Chitale, CEEW, said, "In recent years, Delhi has been experiencing highly erratic rainfall patterns, as we are witnessing once again this season. Last year, after enduring months of severe heat waves, the city received more than half of its June rainfall on the very first day of the monsoon onset. Furthermore, from June to now, the city has already experienced 38% excess rainfall compared to the normal as

Gurgaon. (Agency) An ASI lost Rs 1.4 lakh to cyber fraudsters after his account was hacked.

ASI Shakti Singh, who lives in police lines, said in his complaint that he was on duty on Aug 19 when he received multiple deduction messages from the bank."I was at my workplace when I started receiving the messages on my mobile phone withdrawals from my HDFC bank account. Before I could understand the situation, a total of Rs 1,43,433 was withdrawn from my account by an unknown person," ASI said in his complaint.He immediately notified the cyber police helpline, and a cheating case was registered at the Cyber West Police Station. Police have yet to trace the accused.In another case, cyber fraudsters cheated the daughter of a cop residing in the Bhondsi police lines of Rs 2.2 lakh.

Nuh cops step up heat on cyber cons: 147 FIRs, 204 arrests in 4 months

Gurgaon. (Agency)

In a crackdown against online fraudsters, the Nuh cybercrime unit has intensified its operations, registering 147 FIRs and arresting 204 cyber fraudsters over the last four months.Acting under the directives of SP Rajesh Kumar, the team nabbed 10 more accused on Tuesday, in connection with eight separate cases, recovering crucial evidence related to online fraud.

A police spokesperson stated that between May and August 24, the unit not only made arrests but also refunded nearly Rs 11 lakh to victims of digital fraud. Those arrested on include Ansar, Tuesday Jamshed (alias Jamma), Rashid, Javed, Abid, Mohammad Nasir, Sahil, Arman, Mohammad Shakir and Mausim.During the raids, cops seized mobile phones, fake SIM cards, debit cards, and vehicles used in fraudulent operations. Following their arrest, the accused were produced in court and were sent to 14-day judicial custody. Cops are currently analysing technical evidence, such as CDRs, IPDRs, and banks.In recent years, Nuh has reported several cases of cyber fraud with gangs operating sophisticated scams ranging from KYC scams, phishing calls, and fake job or investment

offers to lottery.

Greater Noida Industrial Development Authority (GNIDA) has granted inprinciple approval to a proposal from Gaursons Group to mortgage a portion of its Gaur City Mall in Greater Noida West as security against additional farmer compensation dues. This move will allow for the execution of nearly 2,100 long-pending sub-lease deeds in three of the developer's housing projects, bringing relief for residents who have possession of their flats but have been unable to secure legal ownership. Without sub-lease deeds, residents remain in legal limbo despite having paid for and taken possession of their

flats in these three projects. In the case of Gaursons Promoters' plot in Sector 16C, in Gaur City 2, out of 11,354 sanctioned units whose completion was obtained, subleases were executed for only 9,655 units, leaving 1,699 pending. In the Gaursons Realty project in Tech Zone-IV, Gaur Saundaryam, 2,068 units were sanctioned and completed, with 1,881 sub-leases executed and 187 still pending. For Gaursons Hi-Tech Infrastructure's project in Sector 4, Gaur City 1, 11,742 units were sanctioned, of which 7,412 are complete and 7,209 have been registered, while 203

sub-leases remain pending.

In July this year, the GNIDA board gave its in-principle nod to the proposal after reviewing the affidavit and supporting documents. However, additional CEO Saumya Srivastava further clarified that before any subleases are executed, an independent valuation of the mall property will be carried out to confirm that its security value is adequate to cover the disputed dues. Once the mortgage is formally created, the registries will be allowed to proceed.Independent valuation exercise will be conducted in the coming weeks, after which GNIDA is expected to clear the way for registration of around 2,100 flats across the three projects.

For many homebuyers who have waited years, this could finally deliver the ownership documents that have remained out of reach. The approval follows Allahabad High Court directions and an application by Gaursons

Hi-Tech Infrastructure, which built the mall, in July, through which the company sought GNIDA's permission to mortgage up to the fifth floor of Gaur City Mall to cover outstanding liabilities arising from additional farmer compensation. This issue has been the subject of litigation between GNIDA and several Gaursons entities before the Allahabad High Court.

compensations date as far back as 2018. GNIDA raised farmers' compensation demands totalling Rs 315 crore against three Gaursons companies: Hi-Tech Gaursons Infrastructure (Rs 186 crore), Gaursons Promoters (Rs 110 crore), and Gaursons Realty (Rs 19 crore). These demands were challenged through separate writ petitions filed in the High Court.In Sept 2024, the court passed interim orders in two of the petitions filed that year, pertaining to Gaursons Hi-Tech Infrastructure and Gaursons Promoters, directing companies to deposit the amount proposed by the developer towards the farmers' compensation and secure the remaining 25% of the total

The cases pertaining to farmer

compensation amount through a charge on immvable assets. The High Court stated that in compliance with the govt's order for the rehabilitation of stalled projects, the developer would be able to avail the benefits of the policy and obtain completion certificates for the two projects. GNIDA was directed to issue the completion certificates and allow the execution of tripartite sub-lease deeds in favour of the allottees once the developer deposited required amount.In

Commuters feel pinch as Metro travel gets costlier after eight yrs

New Delhi: It is 9 am at the Rajiv Chowk Metro station and the rush is no different from any other weekday. Trains pull in every two minutes, spilling out a stream of hurried commuters while an equally restless crowd of passengers pushes its way inside. For lakhs of Delhiites, the Metro remains the lifeline that connects distant corners of the NCR, from Dwarka to Noida and Saket to Gurugram. But Monday morning carried a different mood — the Delhi Metro Rail Corporation's (DMRC) first fare hike in eight years came into effect, and while the increase is marginal, ranging from Re 1 to Rs 4, many passengers say it matters. "I already live so far from my college, making Metro my only mode of commute. With limited budget to go about my day,

Gang posing as CBI officials robs businessman of Rs 2.5 cr

New Delhi: In a case straight out of the Bollywood thriller "Special 26", the Delhi's Vivek Vihar police cracked a high-profile robbery involving a fake Central Bureau of Investigation (CBI) gang that looted nearly Rs 2.5 crore from a businessman under the guise of a raid. The police have arrested three key members of the gang and recovered Rs 1.25 crore in cash, said Deputy Commissioner of Police (Shahdara) Prashant Gautam. The incident took place on August 19 when four persons posing as CBI officers targeted Manpreet Singh, a Ghaziabad-based businessman engaged

in finance, property dealing and construction. According to the complaint, Manpreet asked his friend Ravi Shankar to collect Rs 1.10 crore from the house where they keep the money. As Shankar stepped out with the cash, he was confronted by four individu-

Pope Leo XIV demanded Wednesday that Israel stop the "collective punishment" and forced displacement of Palestinians in Gaza as he pleaded for an immediate and permanent ceasefire in the besieged territory preparations by Israel for a new military offensive.Leo was interrupted twice by applause as he read aloud his latest appeal for an end to the 22-month war during his weekly general audience attended by thousands of people in the Vatican's auditorium.History's American pope also called for the release of hostages taken by Hamas in southern Israel, 50 of them remain in Gaza and for both sides and international powers to end the war "which has caused so much terror, destruction and death." I beg for a permanent ceasefire to be reached, the safe entry of humanitarian aid to be facilitated and humanitarian law to be fully respected," Leo said. He cited international law requiring the obligation to protect civilians and "the prohibition of collective punishment, indiscriminate use of force and the forced displacement of population."Palestinians Gaza are bracing for an expanded offensive promised by Israel in some of the territory's most populated areas



including Gaza City, where famine has been documented and declared.Israeli Prime Minister Benjamin Netanyahu has said Israel will launch its Gaza City offensive while simultaneously pursuing a ceasefire, though Israel has yet to send a negotiating team to

discuss a proposal on the table. He has said the offensive is the best way to weaken Hamas and return hostages, but hostages' families and their supporters have pushed back, saying it will further endanger them.Hamas took 251 hostages on Oct. 7, 2023, in the attack that also killed about 1,200 people. Most hostages have been released during previous ceasefires or other deals. Israel has rescued eight hostages alive. Of the 50 still in Gaza, Israeli officials believe around 20 are still alive.

The shooter, identified as

Robin Westman, 23, of Minnesota, opened fire at the Annunciation Catholic School on Wednesday, killing two children aged 8 and 10, and injuring 17 others. Westman reportedly died by suicide shortly after the attack. Footage shared on social media appears to show Westman displaying a cache of weapons, including rifles, handguns, and loaded magazines.The phrase "Nuke India" was clearly visible in white lettering on one of the firearms. The magazines were inflammatory messages such as



Trump Now', 'Israel Must Fall' and 'Burn Israel'.At least two videos were uploaded to a confirmed the shooter's identity YouTube channel titled "Robin as Robin Westman, who was W" prior to the attack. Trump administration to change H1B programme, Green Card process

WASHINGTON.

(Agency) The Trump administration is planning to change the H1B programme, the most sought after non-immigrant visa among Indian IT professionals, and also bring changes to the Green Card process, US Secretary of Commerce Howard Lutnick has said."I'm involved in changing the H1B programme. We're going to change that programme, because that's terrible," Lutnick said in an interview to Fox News on Tuesday. He added that the Trump administration is also going to change the Green Card process that provides permanent residency in the US.

"You know, we give green cards. The average American makes USD 75,000 a year, and the average green card recipient USD 66,000, so we're taking the bottom quartile, like, why are we doing that? That's why Donald Trump is going to change it. That's the Gold Card that's coming. And we're going

to start picking the best people to come into this country. It's time for that to change," he said.

Highly skilled professionals from India walk away with the overwhelming number of H-1B visas, which is Congressionalmandated 65,0000 every year and another 20,000 for those who received higher education from the US.

France Beheaded An African King 100 Years Ago. His Skull Is On Its Way Home

Antananarivo. (Agency) France has returned three human skulls, including one believed to be that of a 19thcentury Malagasy King Toera of the Sakalava people, to Madagascar. This comes 128 years after

they were carried to France. The restitution was carried out in a ceremony held at the French Ministry of Culture on August 26. It marks the first use of the 2023 French law that enables the return of human remains to a country for funeral purposes.

The other two skulls belonged to Sakalava warriors who fought with King Toera and were also put to death during the bloody uprising against the Menabe kingdom in western Madagascar, CNN reported.

French troops defeated the Sakalava kingdoms in the late 19th century and colonised Madagascar. King Toera was killed and beheaded by French forces during the August 1897 massacre. His skull was then taken as a trophy to Paris and placed in the National Museum of Natural History, along with numerous other remains from Madagascar.

"These skulls entered the national collections in circumstances that clearly violated human dignity and in context of colonial violence," said French Culture Minister Rachida Madagascar Dati.Her counterpart, Volamiranty Donna Mara, hailed the handover as a groundbreaking gesture that ushers in a new era of cooperation between the two nations, Al Jazeera

reported. "Their absence has been, for more than a century, 128 years, an open wound in the heart of our island," she said.Since taking office in 2017, French President Emmanuel Macron has admitted to certain previous wrongdo

ings by France in Africa. While visiting the capital Antananarivo in April, Macron mentioned that he was seeking "forgiveness" for France's "bloody and tragic" colonisation Madagascar.The

gained independence in 1960 after more than 60 years of colonial control. The skulls are scheduled to return to the Indian Ocean island on Sunday for their burial.

JICA aid for flood mitigation, water storage revival in Chennai

The Water Resources Department (WRD) has drawn up a flood mitigation and water storage improvement plan with financial assistance from the Japan International Cooperation

WRD Superintending Engineer M Mahesh Nagarajan told TNIE that JICA's support would be crucial to strengthening Chennai's water infrastructure. "With JICA's help, WRD will deepen 28 major tanks within city limits, including Porur, Ambattur, Kolathur and Korattur.

Though these tanks store water, their capacity has drastically reduced due to silt deposits. Preventing sewage



from entering them is equally important. For this, we are planning inter-departmental Corporation and Metro Water."

future drinking water needs. 'At present, Chennai requires about 1 tmcft of drinking water. could double due to population growth and urbanisation.

Unless we enhance storage facilities now, the city will face severe shortages. Once the tanks are restored, they will serve as natural reservoirs, playing a vital role in flood management and water supply,' he added. As part of the project, WRD has also proposed four straight-cut channels to improve water flow and reduce stagnation in the Buckingham Canal. JICA is expected to submit the detailed project report shortly. Meanwhile, under state funding, desilting work worth Rs 31 crore is underway in the central canal, aimed at easing waterlogging in low-lying areas.

Thiruvananthapuram's first cycle track turns into disappointment

(Agency) The first-ever cycle track, hailed as a landmark step towards green mobility has quickly turned into a disappointing affair for cyclists and citizens in the city. Opened recently with much fanfare, the track along the Vellayambalam-Thycaud stretch lies in shambles – blocked by parked vehicles, encroachments and crippled by unscientific design. said that the cycle track is of no use to the public. "The Smart City Thiruvananthapuram Ltd (SCTL) is blaming the Uralungal Labour Contract Cooperative Society (ULCCS) for the unscientific cycle track, as it is too narrow for cycling.

Initially we were very excited as this was going to be the first ever dedicated track for cycling. However, we couldn't use it even for a day because of unauthorised parking and other encroachments. We want the authorities to make the track available from at least 5.30 am to 7.30 am," he said.

Cycle enthusiasts in the city Thiruvananthapuram P Prakash are also heavily disappointed



with the track. "The track is inadequate for cycling. The authorities should take steps to improve the safety of the track first. Parking on the track is also a major issue and the police have put up 'no parking' boards blocking the way," said Dr Shankar Ram, a native of Althara.

New cycle track coming up from Kowdiar to Peroorkada

Meanwhile, an interlocked road with a dedicated cycle track is coming up at the Pipeline Road running parallel from Kowdiar-Peroorkada. It has started attracting cyclists even before its formal inauguration. The first phase of the project from Kowdiar to Ambalamukku has been completed and the second phase Ambalamukku from Peroorkada is under way. The Rs 4-crore project is being implemented using funds sanctioned by MLA V K Prasanth.

An official associated with the project said that it had been pending for a while due to

objections from the Kerala Water Authority (KWA). "The pipeline road is owned by KWA they had granted permission for the project under multiple requirements. They had maintained the condition that heavy vehicles will not be allowed in the stretch as pipelines pass underneath," said the official.

Produce medical records of RG Kar victim's mother injured in rally: HC tells pvt hospital

The Calcutta High Court on Wednesday ordered a private hospital in Kolkata to submit medical records of the deceased trainee doctor's mother, who sustained injuries during the Nabanna Abhijan rally earlier this month, which was taken out to protest the rape and murder of the trainee doctor at RG Kar Hospital last year.

The order came after the court considered police reports from two police stations and the hospital's medico-legal form.

The case dates to August 9, the first death anniversary of the RG Kar doctor, when the victim's parents held the Nabanna Abhijan rally.

The father had filed online complaints at two police stations in Kolkata seeking them to be treated as FIRs. He alleged that his wife had been attacked by police during a lathi charge. The doctor's mother was taken to a private hospital

and later discharged.

A single-judge bench of Justice Tirthankar Ghosh heard the matter after the state placed on record the two reports of the police stations.

As per the first report, an inquiry found that "there was no ground to proceed any further with the case as there was no substance."

The second police station report stated "outcome of preliminary enquiry is completed and no evidence or materials substantiating the allegation, thus no case was made out to lodge an FIR and the information was given to the Petitioner."

The private hospital produced a medico-legal report and after examining it the court directed the hospital be made a party to the case. The court ordered the hospital to be represented and to make available all

Mumbai rain: IMD forecasts moderate showers from today

Mumbai. (Agency)
Rain activity is slated to recede in Mumbai over the weekend with the India Meteorological Department (IMD) forecasting only moderate rain activity in the city, starting Friday. At present, amid a yellow alert sounded in the district, the city and its neighbouring pockets are experiencing intermittent spells of moderate rainfall.

Data furnished by the IMD showed that the Santacruz observatory recorded 1 mm of rainfall between Wednesday and Thursday morning, while the Colaba coastal observatory received 5 mm of rainfall during the period.

According Brihanmumbai Municipal Corporation (BMC), the wettest spells were recorded in the eastern suburbs, which received an average of 5.68 mm of rainfall, followed by 3.30 mm of rain in the western suburbs and 2.56 mm of rainfall in the island city division.

Amid Ganesh Chaturthi festivities unfolding in the city, the weather bureau had sounded a yellow alert in Mumbai and its neighbouring districts since Monday, owing to the likelihood of heavy rainfall in isolated pockets. While heavy showers have eluded the region, the city is experiencing overcast skies and brief spells of light to moderate rainfall. This comes a week after extremely heavy rainfall battered the district between August 16 and August 19, when nearly 900 mm of rain

So far, Mumbai's Santacruz station has received 2,384 mm of rainfall between June and Thursday (August 28), while



IMD's Santacruz observatory recorded 1 mm of rainfall between Wednesday and Thursday morning, while the Colaba coastal observatory received 5 mm of rainfall during the period.

However, indicating a break from monsoon activity, IMD has issued no warnings for Mumbai from Friday in its forecast bulletin. Meanwhile, the neighbouring districts of Thane and Palghar have been placed under a yellow alert until Saturday morning, following which rain activity is expected to subside.

Parents allege students humiliated, photo shared on WhatsApp group: Hindustan Antibiotics School faces probe Pune. (Agency) Pimpri-Chinchwad

Municipal Corporation (PCMC)'s education department has set up an inquiry against Hindustan Antibiotics School following allegations of humiliation of students over non-payment of fees. Parents of Class 7 students have alleged children who have not paid their fees were singled out in class, made to stand together and photographed, which was then shared on the parents' WhatsApp group. The school is a government-

aided school run by the Deccan Education Society. It was established in 1958 mainly for the wards of Hindustan Antibiotics Ltd employees and children from low-income families in the neighbourhood.

Democracy on trial: From the rule of law to rule by law

The surest way to throttle democracy is to weaponise laws and target those opposing the government. This government seems to have converted this into an art.I recall the day the amendment to the Unlawful Activities (Prevention) Act, 1967 (UAPA), was taken up for discussion in Parliament. The Home Minister openly stated that this was necessary, for none could oppose the inclusion of terrorists and terrorist organisations in the First Schedule of the UAPA, seeking to destabilise our Republic. I intervened and expressed my fears that these laws are likely to be used against our citizens; it has turned out to be a reality. The prosecution of young students, like Umar Khalid and Sharjeel Imam, under those laws has resulted in them languishing in jail for years without a trial. Such laws have been used against journalists, academics, and members of religious communities in this country. The obvious intent was to silence them. The weaponisation of the Prevention of Money Laundering Act, 2002 (PMLA) is evident in its widespread use against political opponents, including chief ministers and ministers from opposition-ruled states, such as Arvind Kejriwal, Manish Sisodia, Satyendra Jain, Hemant Soren, and Farooq Abdullah, among others. Valiant attempts were made to move against Siddaramaiah, but they came to nought. These laws have also been used to instil fear in several leaders who were once part of the opposition but have been persuaded to join the BJP to save themselves from prosecution and imprisonment. The BJP has, particularly in Maharashtra, rewarded opposition leaders against whom serious allegations of corruption were publicly made for causing a split in their erstwhile parties. They are now part of the coalition ruling Maharashtra. The latest example of weaponisation of laws is the introduction of two Constitution (Amendment) Bills in Parliament on August 20, 2025. It is claimed that this is being done in public interest, for the welfare of the people and to uphold the principles of constitutional morality, and good governance—concepts that are alien to the functioning of this government. What is likely to serve is not public interest, but the political interest of the ruling dispensation. This is clear from the fact that the proposed law provides that the chief ministers and ministers being investigated for offences punishable for more than five years and being in custody for more than 30 days will, on the 31st day, if they have not resigned, be dismissed by the governor of the state. The principle of law that our Republic has embraced is that a person is innocent till proven guilty. In this case, a minister or a chief minister can be removed on a mere allegation without any proof. We are all aware that many such cases have been pending trial for over a decade and that the conviction rate in several of these prosecutions is abysmally low.

If the proposed constitutional amendments become law, it is most likely that trumped-up allegations will be made to target sitting chief ministers and ministers, and after 30 days in custody, they will be dismissed from those positions. Such allegations in the past have served the political interests of the BJP. The present establishment seeks to utilise these laws for its own political purposes. This weaponisation is also evident from how laws such as PMLA or UAPA have been used against influential ministers seeking to coerce them to join the BJP, or even public servants not belonging to any political party, in opposition-ruled states. Ironically, since 2014, these laws have never been invoked against any minister in any of the BJP-ruled states, or, for that matter, against any minister within the ruling establishment at the Centre. Obviously, the selective use of such laws serves the political interest of the party in power.

The silent scourge of hysterectomy

From Dima Hasao to Jaintia Hills, who owns the region's wealth?

There is a quiet but serious epidemic in the country-hysterectomy. It is a surgical procedure involving the removal of a woman's uterus, sometimes accompanied by the removal of the ovaries, fallopian tubes and cervix. According to the National Family Health Survey 2019-21 (NFHS 5), the prevalence of hysterectomy among women aged 40-49 years was as high as nearly 10 percent. The numbers are far higher in states such as Andhra Pradesh (22.5 percent), Telangana (21.2 percent), Bihar (17.2 percent) and Gujarat (11.7 percent). More worryingly, the median age of women who had undergone hysterectomy is 34 years for rural and 36 years for urban areas, more than 10 years before natural menopause. The common reasons for getting a hysterectomy include excessive menstrual bleeding/ pain, fibroids/ cysts, and uterine disorders. While it may be sometimes unavoidable, the surgery poses serious risk

to women's health by inducing early menopause. Research has established its links with increased risk of illnesses like cardiovascular disease, metabolic disorders, ovarian failure, vasomotor symptoms, thyroid cancer, urinary tract cancer, pelvic prolapse, bone density loss, and mental health issues. Therefore, it is not a procedure that should be taken lightly.

Despite such obvious health consequences, why is hysterectomy among young women in India on the rise? Data consistently indicates a higher prevalence among less educated rural women, despite the limited access to surgical procedures in rural areas. Moreover, women agricultural workers have been hit hard by this trend as they are led to believe that it avoids loss of wages and improves endurance for demanding work hours without menstrual discomfort. This is widely documented among sugarcane workers in Maharashtra's Beed

district, where the prevalence was at a staggering 56 percent in 2024, with an average age of 35 years among women who migrated for work. Similar trends were observed among women agricultural workers in Telangana and Bihar, where the prevalence was 18 percent and 10 percent, respectively, according to NFHS 4. This grim choice, thought to be a short-term solution to avoid financial penalties, ironically reduces the woman's active working lifespan and quality of life because of its impact on bone mineral density and cardiovascular health, among other ailments. From global experience, we know that the structure of the medical system, the

quality of medical advice and the extent of insurance coverage influence unnecessary surgeries. For instance, the prevalence of hysterectomy has always been much higher in the US (325 per 100,000 females in 2008) compared to average European OECD nations (212 in 2010), despite similar socioeconomic and health indicators. Europe's largely public healthcare system leaves less incentive for private medical practitioners for invasive procedures. In contrast, the dominant private healthcare in the US, covered by insurance, exhibits the issue of moral hazard where health insurance coverage drives overprescription of surgeries or diagnostics.

Note that as per NFHS 5, 70 percent of the hysterectomies in India were done at private clinics. Bharath Bhushan Mamidi and Venkat Rao Pulla's research, published in 2013, found in Andhra Pradesh that healthcare providers



advised poor rural women as young as 20 years to have a hysterectomy even for routine gynaecological issues, such as abdominal pain and white discharge, without offering any alternatives due to the profit motive. Such nudges are common due to the lack of awareness about the importance of the womb for their overall health and longevity. In addition, insurance coverage clearly plays a role. Gaurav Gunnal and Sudeshna Roy (2024), and Angad Singh and Dipti Govil (2021) used data from NFHS 4 to show that women covered under insurance were more likely to undergo a hysterectomy. There are widespread media reports of unnecessary surgeries being

done, particularly covered under Centre and state-funded insurance schemes. Taking cognisance, the National Health Authority, that administers the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana, brought out a working paper in 2019 highlighting that hysterectomy claims under the scheme comprised almost 2 percent of claims for all female packages in 24 states in the first nine months (September 2018 to May 2019). The paper stressed the need for monitoring claims over time. Following this, the NHA in 2019 introduced preauthorisation requirements for claims. For instance, a mandatory second gynaecological opinion and uploading of clinical or USG findings on the portal is required for women under 40 years.

The Union health ministry is clearly aware of this issue and noted in an advisory that "private empanelled healthcare

providers are proceeding with the surgery (hysterectomy) without waiting for pre-auth approval, even after preauth processing doctor has asked a query/ clarification". In 2022, it issued guidelines on unnecessary hysterectomies, including the creation of monitoring committees at district, state and national levels to gather data on surgeries across public and private facilities.

This issue requires a multi-pronged approach. Firstly, more recent and detailed data are needed on the prevalence of hysterectomy. NFHS should include questions on how women paid for the surgery to ascertain the role of public health insurance in rising cases. Secondly, greater awareness needs to be spread among women about the harmful effects of early hysterectomy. For heavy menstrual bleeding, which is the most cited reason, conservative treatment options like hormonal contraceptive pills and hormonal IUDs need to be promoted. Lastly, there should be stricter surveillance and medical audits.It is also worth examining whether such practices are guided by the misplaced perpetuation of population control policies/ mindset, as it has implications not just for women's health but also for our demography

at a time when India's fertility rate is already below replacement level. The trend of unnecessary hysterectomies highlights a deeper challenge in healthcare delivery. When private providers operate within insurance-funded systems, without transparency and accountability, there is hardly any pushback from patients as they are insured. This presents a classic case of market failure due to asymmetric information, which heavily burdens the medical system with overprescription, drives up health costs, and strains public finances.

India in right stance to face extra tariff

The urea stock with the Centre at the beginning of this month was about half of what it was last August

Those who had hoped for a last-minute pause of the additional 25 percent tariffs on Indian exports to the US would be disappointed. With no settlement signed or even negotiated, the US department of homeland security on Tuesday notified "the punitive tariffs on Indian goods entered for consumption, or withdrawn from warehouse for consumption" from 9.31 am IST on Wednesday would attract the heightened levies. The signals have been pointing in this direction. First, the US trade team, expected in India on August 25, deferred its visit. American rhetoric has been aggressive too; Vice President J D Vance on Sunday stated "aggressive economic leverage" including "secondary tariffs on India" had been applied to force Russia to stop bombing Ukraine.

It is to the credit of India that it has stood up to the armtwisting. Speaking in Ahmedabad on Sunday, Prime Minister Narendra Modi stated, "No matter how much pressure comes, we will keep increasing our strength to withstand it... The government will never let harm come the way of small entrepreneurs, farmers, livestock rearers."The government has also rightly decided to diversify its trading options. Russian crude purchases,



which were suspended in July, have been resumed, with several Indian refiners placing orders for loading in September and October. While the PM called for 'self-reliance', RBI Governor Sanjay Malhotra pledged the central bank "would not be found wanting" in providing additional liquidity to guard against the tariff impact.

ndia, which has been reaching out to Russia and China,

has made it clear it intends to more than double its trade with Russia, targeting \$100 billion by 2030. Meanwhile, it must keep its US options open too, as the latter needs India as a counterweight to China. India has surpassed China as the top smartphone exporter with a 44 percent share of the US market, largely driven by Apple's strategy to diversify production. Indian exports to the US are at about \$85 billion and cannot be replaced overnight without hurting American consumers. Peace or a pause in Ukraine could soon end the rationale behind the punitive tariffs. Thus, the expectation among some pundits that the trade talks could resume after a short hiatus is not misplaced. The government should use this period, meanwhile, to develop domestic demand and stronger, alternative regional trade routes.

Money gaming ban set to play spoilsport

The creation of a strong regulatory system could have been the first step before imposing a ban

DREAM11, RummyCircle, Pokerbaazi — these are just some of the familiar names associated with the online gaming industry. The first is well known due to its connections with cricket and football as fantasy sports games have become hugely popular. The others are linked to popular games of skill played all over the world at social and professional levels. The online versions of these and innumerable other games are played largely with real money, and this practice has now come under scrutiny. The outcome is the Promotion and Regulation of Online Gaming Act that bans all real money games (RMG) but seeks to support social and educational online games as well as electronic sports. At the outset, one must explain what defines a real money game. The new law says an RMG is any online game, which could be based on skill or chance, where a user deposits money or places a stake with the hope of winning something valuable, usually money. This is completely different from simply purchasing a game online. The passage of the law has created an uproar in the country's burgeoning real money gaming sector. Industry associations estimate that about two lakh people are directly employed by such platforms, with another one lakh in related jobs. They argue that the ban on RMG could lead to most losing their livelihoods at a time when the IT industry in general is going through a shakeout, with jobs being

lost due to the advent of artificial intelligence.

The ban will undoubtedly have a devastating effect on those employed in the sector and will equally impact the government's tax revenue of Rs 20,000 crore. Venture capitalists are also worried about the \$2 billion raised for investments made in this sector. Most online RMG platforms now have few options — either to shut down or pivot to the much-less-lucrative advertisement-based model. The beleaguered

advertisement-based model. The beleaguered gaming industry may even be gearing up to make a legal challenge to the new Act.In its defence, the government claims that these gaming platforms have caused addiction and financial ruin to millions of families. It says that as many as 45 crore people have been negatively affected and faced losses of over Rs 20,000 crore because of these platforms.

The question is: what prompted the government to take such a hard line on real money gaming, after allowing the industry to carry on operations in an unchecked manner for so long? One reason given is the failure of the industry to do self-regulation. It has not been able to implement measures to safeguard players from the danger of addiction, which often leads to financial distress. In addition, there are now concerns over terror financing and money laundering being linked to RMG entities. What is unique about this legislation is the

bipartisan support to it. Apparently, online gambling addiction has become such an endemic problem that politicians of all hues feel the need to protect their constituents from its disastrous impact.

Besides, it may appear as if the law has been imposed suddenly, but there were clear indications over the past two years that the industry was treading on thin ice. The Information Technology Ministry laid down rules in 2023 to allow the creation of self-regulatory bodies for online gaming. These were aimed at certifying games

and blocking illegal offshore betting platforms. Such self-regulation efforts did not meet with much success. Subsequently, Goods and Services Tax (GST) levies on the full face value of deposits in RMG were hiked to 28 per cent. Thus, the gaming industry should have been cautious, given the nudges being given to regulate RMG with more care. As for the need to protect users of these online games, even young gamers recognise the



pitfalls. It starts out as a catchy game and the user is then lured into pumping more and more money into it. The suggestion of gamers, as well as of industry associations, is that the ban on RMG should be replaced by a strict regulatory framework. This is based on the premise that bans rarely work effectively. Those who are desperate to gamble are bound to move to unregulated offshore platforms to satisfy their urge to play these games.

The decision to impose an outright ban may have been

influenced by revelations in the

Rs 6,000-crore Mahadev online betting scam. It involved a betting platform that enabled illegal gambling on card games and sports. It engaged in match-fixing, money laundering via crypto currency and manipulating games to ensure huge profits for its UAE-based promoters. The creation of a strong regulatory system, however, could have been the first step before

imposing a ban on RMG. It could have given gaming platforms some time to pivot to non-money games as well as to adopt an advertising-based model. The sheer size of the industry and the potential for India to grow into a global hub for gaming also need to be taken into account while formulating such policies.

A report by RMG platform Winzo and the Interactive Entertainment and Innovation Council gives an indication of the size of a sector considered a sunrise industry till now. It says revenues of the online gaming industry were \$3.7 billion in 2024 and are expected to reach \$9.1 billion by 2029. The report says India has 591 million gamers, comprising 20 per cent of the total global gaming community along with 1,900 gaming companies employing 1.3 lakh skilled professionals. What is significant in the context of the latest ban is the estimate that RMG contributed 85.7 per cent of the sector's revenue at \$3.2 billion.

The new gaming law is thus a harsh step that could affect the growth of a sunrise sector. A rigorous regulatory system could have been adopted initially before deciding to go for a complete RMG ban. At the same time, the widening arc of gambling addiction and financial distress must not be allowed to expand further. For the time being, the industry must evolve to utilise the space available for promotion of social, educational and e-sports that have a huge following in India and abroad.

"For doing any financial activities online, one has to think before making any decision. As a first step, he or she should talk to other people before making a decision," Daniels said. Gamit said,

"Three cybercrime incidents take place per second in the world. In India, a cybercrime takes place every 7 minutes. Russia is the hotbed of cybercrime incidents as it tops the world, while India falls in the 10th position." In his presentation, he explained about 20 different types of cyber frauds and shared tips to avoid falling prey to online frauds.

Talking to The Indian Express, Gamit said, "There are mainly three types of cybercrime cases - social media-related fraud, financial fraud and cyber terrorism. Swept away, 'Sher-e-Punjab' was once residential premises that took a beating in 1995 flash floods

A strong water current from the swollen Beas river swept away the iconic 'Sher-e-Punjab', a two-storey restaurant on Rohtang Road near Manali, leaving only the front wall bearing its name as a testament to its presence. The washedaway restaurant was an extension of the renowned 'Sher-e-Punjab' on the Mall Road in Manali, which had been in operation for over three decades.

The two-storey building, where the restaurant opened in 2021, was a residential structure and had faced calamities earlier, too. In 1995, when floods hit the Manali valley, the building took a beating from the raging Beas. Then, during the flashfloods of 2023, too, the overflowing Beas had hit the rear boundary wall of the structure, but didn't cause any

Sher-e-Punjab's building had a basement, a ground floor, and an upper floor with six rooms, and had the capacity to serve food to as many as 125 people at a time.

Videos and photos of the standing lone restaurant wall went viral on social media.

Saravjeet Singh Gulati, 58, who runs Sher-e-Punjab in Manali, had hired the two-

storey building on Rohtang road for the restaurant. Gulati, the third generation



of a family which migrated from Peshawar in Pakistan to Mandi, then undivided Punjab, in 1947, said, "I opened a branch on Rohtang road in 2021 after hiring the property from Sukhbir Mehta in 2020. My daughter Sehaj was managing the branch.

"Usually, staff close the restaurant by 10 pm, but on Monday, they shut it around 8.30 pm. The last customers were a senior administrative officer and his driver, who were on a routine patrol. Luckily, no one was inside when the

building collapsed in the early hours of Tuesday.

Gulati said in 2023, the Beas had hit the rear boundary wall of the building, but no damage was done. "The landowner informed us that the property was severely damaged by the flash floods in 1995."

Gulati, who used to pay an annual rent of Rs 3.5 lakh, claimed that he suffered a loss of around Rs 1 crore in the tragedy. Along with SherePunjab, two more shops — a snow-dress rental outlet and a daily-needs store -were also swept away by the river. The two adjoining stores were makeshift structures, but 'Shere-Punjab' was a concrete building.Gulati said, "My grandfather migrated from Peshawar (Pakistan) to Mandi (undivided Punjab) in 1947. My father Amar Singh Gulati started selling various things, including shoes, umbrellas, slipper, etc. Later, we also moved to Manali, and I

Murder of 2 over chicken prices and a revenge killing in Ajmer: How 3 brothers' luck runs out in Ahmedabad

The murder of a meat shop owner in Ajmer over selling chicken at "low prices" and an alleged revenge killing on July 15 after a duel between two groups of the Qureshi community have kept Rajasthan police on their toes after three of the 14 accused in the double murder, three brothers, went

into hiding. three The brothers, identified as Salman s/o Abdulali Qureshi (29) and his brothers Allarakha, 25, and Oves, 20, have been arrested in Ahmedabad a month after the alleged crime, Gujarat police said Wednesday. The trio is accused of fatally stabbing meat shop owner Imran and his associate Shahnawaz in Ajmer city for selling chicken at lower prices, said a release by the Ahmedabad Crime Branch.

The accused had been booked under BNS Section 103(2) which concerns a murder committed by a group of five or more people acting in concert. The three were handed over to the Rajasthan Police, said DCP Ajit Rajian of the Ahmedabad Crime Branch. The brothers also own a meat shop in the same area. A conflict arose after Imran posted low prices of chicken in a common WhatsApp group, the release said. This led to a fight between two groups. The accused were

allegedly trying to force Imran

to increase meat prices. On July 15, a group of 14 men allegedly stormed Pakiza Meat Shop in the Ramgani area of Ajmer city and killed Imran and his nephew Shahnawaz. While several of those allegedly involved in the double murder were apprehended by the Rajasthan police, the three brothers remained on the run. Confirming the arrest of the

the naked body of an unknown man was found on Ramganj road. His body had been kept in the local mortuary. It was only two days later that the body was identified by a family member as being that of Gulaam alias Nakku, one of the accused in the double murder case. Scholarships, work prospects — and Chinese dramas: Mandarin finds new takers in Delhi

New Delhi. (Agency) On a humid August day at MeiYu Chinese Centre in Delhi's Karol Bagh, a native Mandarin teacher, Claire Laoshi, guides a group of beginner-level students through simple sentences. "Wo he kafei," she says. "It means I drink coffee."

The students repeat it as she explains how he means drink and that adding le turns the action into the past tense.

She then introduces a practical scenario. "If your colleague asks you in the morning, 'Did you drink coffee?' you can answer, 'Wo he le (I drank)'...," she says. "In Chinese, the adverbs always go with adjectives."

The students nod, as they jot down the grammar lesson some writing down the structure: Subject + Verb + Object. "Next Saturday, when I ask you if you did the homework, you will say, 'Wo xie le (I wrote it)," says Laoshi. The next sentence is tougher. "Ta men ti zuqiu (they play football)." Some stumble at first, until the teacher pronounces zuqui as dzoo

By the end of the lesson, the students are familiar with simple Mandarin greetings.

"A says 'Ni hao', B replies 'Ni hao ma?'..." Laoshi

One by one, the students respond: "Wo hen hao. Ni ne? (I'm fine. How are you)?" marking their first attempt at a university students or young professionals aiming to study or work abroad.

A digital marketing professional, the 21-year-old says she started learning Mandarin in May 2023. She initially travelled from her hometown in Muzaffarnagar to Delhi for classes, later shifting to Noida for convenience.

"I became interested in the language because of short reels on Instagram and bingewatching Chinese dramas. The characters and phrases fascinated me, and I thought why not learn the language?" she says. Narang has since progressed to the HSK 4 level.

your all. My sister's friends told me that Mandarin has great career opportunities, so it kept me motivated."Learning the language has helped her secure the Huayu Enrichment Scholarship to study at Ming Chuan University, which she will join later this year.

At Han You Chinese Language Institute in South Delhi's Hauz Khas, batches are limited to 15-20 students. The co-founder, Arun Jaiswal, says that it is a deliberate choice as language learning requires individual attention and a focused approach. Noting that Mandarin has been gaining popularity, he adds that

awareness is still limited.

"People are fascinated, but ultimately, they approach it from a career perspective," says Jaiswal. "Chinese is a highly practical language and can be very rewarding, offering excellent salary packages."

Earlier, job opportunities for those proficient in Mandarin were largely thought to be limited to tour guides or the tourism industry. But now, Jaiswal notes, the scope has significantly expanded to include roles such as interpreters, translators, positions in multinational companies, the travel industry, embassies and diplomatic missions, as well government-linked posts.

The institute itself has come a long way from when it started with six students in 2018. "Initially, foreign languages were a niche... We wanted to focus on one language properly. Over the years, we evolved, added courses, and adjusted to student needs." he adds.

A day after Enforcement Directorate (ED) carried out searches at his residence, Aam Aadmi Party's (AAP) Delhi unit chief Saurabh Bharadwaj on Wednesday accused the central probe agency of coercion, tampering with his statement, and seizing public documents as "incriminating evidence". Delhi BJP president Virendra Sachdeva later Bharadwaj's countered allegations, claiming that he was trying to deflect the

attention. The ED action against Bharadwaj has stemmed from an FIR registered by Delhi's Anti-Corruption Branch (ACB) on June 26, which had alleged cost escalations and corruption in the construction of hospitals across the Capital.

Addressing conference at the party office, Bharadwaj on Wednesday carried a printer of his home as "evidence," claiming that it contained logs of the original statement he gave to ED

"Today I will expose an agency — the Enforcement Directorate — that has been spreading terror in India for several years," he said.

The ED officials, he said, questioned him for nearly 14

hours on Tuesday and pressured him to sign a "doctored statement". "I answered 43 questions calmly, but when I accused L-G VK Saxena of hatching a conspiracy against me, the officers refused to record my words. They cut out entire portions and returned with a 'pre-written script' asking me to sign," the AAP leader alleged. He further claimed that ED

seized only two documents from his residence — his election affidavit and an affidavit filed by the Delhi Health Department in the High "Both are public documents. Yet, in the seizure memo, my election affidavit available to the whole world – been 'incriminating'," he said.

The AAP leader also alleged that witnesses produced during the searches were "ED's own people". He said officers intimidated him and his family, warning he could be arrested that night.

The Delhi Police recently busted a network of agents allegedly targeting minors and labourers at railway stations and transporting them to Jammu and Kashmir for exploitation as domestic workers and bonded labourers. They rescued three minors, arrested four men and are looking for more members of the network.

The police probe began in December 2024, when a woman complained at the Bhalswa Dairy police station that two children were missing: her 15-year-old daughter and her 13-year-old friend, who lived in the neighbourhood.


"The 15-year-old left her house in anger after he parents scolded her. She asked her friend to accompany her," a police officer said.

The probe made no progress for the next seven months. Then in June, a man from Jammu contacted the local police, saying that a girl had contacted him on Instagram.

'The man claimed that he had been talking with a girl from Delhi for months on Instagram. He said she had then suddenly contacted him using another number registered in Jammu," a police officer said. The police found out that it was the 15-year-old girl who had left her Bhalswa Dairy home in

Jaykab, after taking the 19

men into confidence, took their Nepali passports for visa processing last April, the police said. Over a month later, Jaykab allegedly demanded that the 19 Nepali nationals pay €3,500 each for the processing of the documents. "Acting on the instructions of the accused, all 19 victims travelled from Nepal to Delhi in July, hoping they could collect their passports, Serbian visas and board their onward flights," DCP Singh said. However, once they reached India, Jaykab started avoiding them, the police said. After staying in lodges in India for over a month, the Nepali citizens finally tracked Jaykab to his Seelampur residence, where he threatened them and flatly refused to return their money, the police said.

"Acting on inputs, the Crime Branch team arrested Jayakab (41) from Noida and found Serbian visas shown by the accused were forged and fabricated," DCP Singh said.

During questioning, Jayakab revealed involvement of his associates Sachin, George aka Bijoj and Rupesh. Rupesh was then arrested from Trishul Colony in Chhawla, the police said. Further investigation to arrest the other accused is ongoing, officers added.



AIF commitments surge past Rs 14.2 tln; funds deployments nears Rs 6 tln

MUMBAI . (Agency)

Despite the Reserve Bank capping investments by banks and other financial institutions in alternate investment fund (AIF) schemes at 10%, overall investor commitments to AIFs rose 20% on-year to a record \ensuremath{Rs} 14.2 trillion as of June 2025, with funds raised touching Rs 6 trillion and deployments from such funds crossing Rs 5.72 trillion, according to Sebi data.

The AIF industry has been rocking with the rising inclination of ultra highnetworth individuals and family offices to deploy their monies in high yielding investment options like AIFs. These schemes have gained traction also because of their ability to diversify investments in early stage startups, unlisted assets, and complex trading strategies. As a result the total commitments for AIFs surged to Rs 14.2 trillion as of June 2025, which is a 20% jump on-year and 5% growth sequentially.

Also, total funds raised inched closer to Rs 6 trillion mark while total investments made through such funds rose to Rs 5.72 trillion, according to the latest data from the Securities and Exchange Board (Sebi).AIFs are investment vehicles catering to the niche segment with high entry investments. Recently, the market regulator has pushed for accreditation among investors

for certain schemes.Category II AIFs focus on private equity, debt, and other unlisted assets, continue to dominate the commitments at Rs 10.78 trillion. But of late there is also a rising inclination towards category III AIFs which include hedge funds. According to the report by the industry



association IVCA, category III AIFs accounted for 47% of the total launches this financial year so far.In terms of investments, real estate is the largest accounting for nearly 12.5%, followed by financial services, IT, NBFCs, and banks. It can be noted that in early June, the Reserve Bank, which has been frowning upon the mushrooming of AIFs for quite sometimes, has capped the cumulative investments by banks, non-banks and all-India financial institutions at 10% of their corpus of any single entity exposure 20%. Former Reserve Bank of India Governor Raghuram Rajan has said that US President Donald Trump's decision to impose steep tariffs, including a 50% duty on Indian goods, is part of a wider strategy that goes beyond trade economics. Speaking to Rajdeep Sardesai, Consulting Editor, India Today TV, Rajan explained that tariffs are being used not only as a trade tool but also as a means of exerting political and economic power.

He added that tariffs were also increasingly being seen as a tool of force.

"It can be a way for the US to essentially use force when it doesn't want to use its military," Rajan said. He cautioned that the outcome is often that "other countries suffer."IS INDIA BEING SINGLED OUT?Rajan said there were several reasons behind Trump's tariff push. "I think certainly he believes that a current account deficit, trade



United States, which the US consumer benefits from," he said. According to him, Trump has held this view since the 1980s, when he was critical of Japan. Rajan pointed out that the former US President sees tariffs as a way to "level the playing field."Another reason, Rajan noted, is Trump's belief that tariffs act as a tax on outsiders rather than on US

The textile and fertiliser industries are expected to be among the biggest beneficiaries of the upcoming GST 2.0 rationalisation, as the Council looks to ease costs, improve competitiveness, and resolve long-standing issues of inverted duty structures.

TEXTILES TO MAJOR RELIEF

In the textile sector, the fitment committee recommended a steep cut in GST rates across several categories. Woven fabrics of cotton, man-made fibres, wool, apparel, hosiery, and some blended textiles are being considered for a reduced 5%

rate, down from the current slabs.Industry higher associations have long argued that higher tax on inputs compared to finished garments creates a blockage of working capital, making it harder for small weavers, powerloom operators, and garment makers to stay competitive.




Kozhikode

Chapramari was declared a national reserve forest in 1895 and later, renamed as a wildlife reserve in 1939. After a few decades, in 1998, it was designated a wildlife sanctuary. The region is famous for its elephants that can be spotted easily. In addition, gaur is commonly found here. The sanctuary is also inhabited by Royal Bengal tiger, boars, deer, leopard, reptiles and various other animals. If you love birdwatching, do remember to carry a pair of binoculars to catch a glimpse of colourful birds like parrot, kingfisher and green pigeon, among many others. For accommodation, there are just a few options available in the area. Hence, whenever you visit Dooars, spend some time in this peaceful retreat in the foothills of the mighty Himalayas.

Buxa Tiger Reserve

A beautiful location in the lap of nature interspersed with the River Jayanti, mountains and dense forests—that's Buxa for you. The area is however more popular for Buxa Tiger Reserve, which is one of its kind in eastern Himalayas. Situated in Alipurduar, the reserve actually consists of the former Buxa Forest Division and a part of the Cooch

Behar Forest Division. It was set up in the year 1983 and was given the status of a national park in 1992.

The reserve's rich biodiversity has been attracting tourists for years now and has become a popular escape for tired souls who love to relax in the lap of nature. The area, approximately 760 sq km, encompasses a mix of different types of forests-riverine, savannah, evergreen, sal and others. The topography and climate not only supports a rich variety of plant species but also animals. Visitors can spot mammals, reptiles, amphibians and fishes, such as tigers, civets, red jungle fowls, leopards, elephants, gaurs, porcupines, rhesus macaque, mahseer, tortoise and butterflies.

Buxa is also an absolute delight for birdwatchers. Birds like red stars, wagtails, fork-tails, ibisbill, great pied hornbills, and the trans-Himalayan migratory goosander can be spotted here. A number of migratory birds too make Buxa their temporary home, such as gargani teal, common teal, white-eyed pochard and the large whistling teal at the Narathali Lake. The black-necked crane, which is a rarity in India, can be spotted in Buxa during winters. Besides, visitors can also explore other attractions of the region, such as

Buxa Fort, Jayanti and Rajabhatkhawa. For accommodation, homestays and resorts are available in the region. Buxa Tiger Reserve, a peaceful retreat, is definitely a not-to-miss attraction during a visit to Dooars.

Rasikbil Bird Sanctuary

The area derives its name from a lake named Rasikbil in Cooch Behar district of West Bengal. The lake is surrounded by low water land or marshland, which provides appropriate dwelling atmosphere for birds. Rasikbil is one of the five such low water lands in the area, others being Neeldaba, Bochamari. Shankhadanga and Raichangmari. No wonder, the area attracts a lot of migratory birds yearround, besides being home to several other resident birds. So, if birdwatching is one of your favourite hobbies, then you would love your visit to the magnificent Rasikbil Bird Sanctuary. Do remember to carry a pair of binoculars so that you can easily spot some exquisite species of birds such as cormorants, ibis, parrots, owls and storks. You can also catch glimpses of water birds like lesser whistling teal, shoveler, wigeon duck, small blue kingfisher and gadwall. Apart from birdwatching, you can choose to indulge in other activities as well. Travellers often opt for minivet, and pheasants. The ruddy shelduck, boating in the lake and nature walk in the forests. They also visit the aviary and tortoise rescue the park during winters. Beautiful butterflies

centre, deer park, python house, crocodile rehabilitation centre and leopard house in the vicinity. A day spent at such places provides an insight into the ways of animal rescue and rehabilitation. Rasikbil, a paradise of winged beauties, can be reached by road from Cooch Behar and Alipurduar.

Gorumara National Park

Situated along the banks of the River Murti and Raidak, Gorumara National Park is one of the most popular attractions in Dooars. The area of the park, which is around 80 sq km, encompasses grasslands and forests. Since 1895 it was a reserve forest but years later, it was given the status of a wildlife sanctuary in 1949. Furthermore, in 1994, the park was declared a national park which is home to a diverse range of flora and fauna. It is specially known for being home to the great Indian rhinoceros. Other prominent animals that can be spotted here are elephant, leopard, hornbill, king cobra, Indian python and gaur, to name a few. Travellers can choose between elephant safari and jeep safari to explore the park. They can even climb atop the watchtowers (Methla, Chukchuki, Chandrachur and Jatraprasad) to spot the inhabitants of the park with the help of binoculars.

One of the most popular tourist destinations in Dooars, Gorumara National Park attracts a lot of tourists round the year. The park's green forests, tall elephant grasses, streams and beautiful landscape provide shelter to several mammals, reptiles, birds and amphibians. Gorumara National Park is also a birders' paradise. If you are a birder, you will have a great time spotting and photographing birds like hornbill, woodpecker, ibis, drongo, also known as the Brahminy duck, migrates to

can also be spotted in the jungle, along with night hunters like owls and nightjars.

Preferably visit the park during winters as it is considered the best time for coming here. While you can choose from a number of forest rest houses at Gorumara for accommodation, Lataguri, the nearest town offers several accommodation facilities. The nearest railhead is New Jalpaiguri and the nearest airport is Bagdogra. Gorumara National Park can also be reached by road from Siliguri, which is around 72 km away.

Jaldapara National Park

Situated on the banks of the River Torsa, Jaldapara National Park is one of the popular places to visit in Dooars. Before 1800, when the place was inhabited by Toto and Mech tribes, it was known as Totopara. The sanctuary was established in 1941 with an aim to protect Asiatic one-horned rhinoceros, and was eventually declared a national park in the year

Spanning over an area of 216.5 sq km, the park boasts of verdant grassland with patches of riverine forest and belts of tall grass. At an altitude of 61 m in the foothills of Eastern Himalayas, this park is mainly savannah forest and is home to a rich variety of flora and fauna. Along with one-horned rhinoceros, various mammals, amphibians, reptiles and birds dwell here, such as elephant, leopard, Bengal florican, peacock, python, cobra and around eight species of fresh water turtles.

A fun way to witness the wilderness of Jaldapara National Park is by elephant safari. Another way to explore the flora and fauna of the region is to opt for jeep safari. For a close encounter, you can climb any of the many watchtowers in the park. There are various tourist lodges and guests houses available in the region for accommodation of tourists coming to visit Jaldapara National Park.
