PM Modi to visit flood-hit Punjab's Gurdaspur on September 9, to meet families

Sources said the Prime Minister is likely to stress the urgent need to strengthen embankments along the Sutlej, Beas, Ravi, and Ghaggar rivers, which have weakened over the years due to illegal mining and lack of maintenance, during his visit.

Prime Minister Narendra Modi will visit Punjab on September 9 to meet people and farmers affected by one of the worst floods the state has faced in recent years Relief and rehabilitation will be carried and to oversee relief operations and rehabilitation efforts. During the visit, he is expected to review the damage

caused by rising waters that submerged villages and destroyed crops across multiple districts.

The BJP's Punjab handle announced the visit on X, stating, "Prime Minister Narendra Modi is coming to Gurdaspur, Punjab on 9th September. He will meet

directly with the floodaffected brothers-sisters and farmers to share their sorrow and take every possible step to help the victims." Government sources said that

the Centre is committed to ensuring that Punjab will not be left alone in this crisis. The Prime Minister's visit will focus on both immediate and long-term recovery measures, including silt removal from fields,

disease prevention, and the safe disposal of dead animals once floodwaters recede.

a broader flood-control plan, building on measures implemented during the Vajpayee-Badal era, while incorporating PM Modi's new action initiatives for disaster preparedness and mitigation.Government plans for Punjab include short-term, mediumterm, and long-term measures aimed at helping farmers bounce back from the devastation, restoring livelihoods and ensuring the state's resilience against future floods, sources said.

Punjab has been ravaged by relentless monsoon rains, with over 1,900 villages across 23 districts submerged. At least 43 people have died, while crops on nearly 1.71 lakh hectares have been damaged, according to the state government.

Large areas of farmland remain underwater, rivers continue to flow above danger levels, and several highways are blocked due to landslides and flooding.

The visit comes amid calls from state governments for central assistance to tackle the worsening flood crisis. Earlier, government sources said the PM will also visit several other floodravaged states in northern India to assess the ground situation and review ongoing relief measures.

Congress questions GST reforms. asks if anti-profiteering authority will be revived

Amid claims from the BJP-led NDA government that it has rationalised the GST slabs for the greater economic welfare of ordinary people, the Congress on Saturday questioned whether the National Anti-profiteering Authority (NAA), established to monitor GST rate cuts passed on to consumers, would be given a fresh lease of life.

In a post on X, Congress general secretary for communications, Jairam Ramesh said that the NAA was created under Section 171 of the Central Goods and Services Tax Act, 2017, to monitor whether GST rate reductions lead to a decrease in consumer prices. "On September 30th, 2024, the Modi Government issued a notification virtually abolishing the NAA with effect from April 1, 2025," he said, adding that the Modi government had issued a notification on 30 September 2024, which effectively abolished the NAA from April 2025. "Will the NAA now have a fresh lease of life? How will it be ensured that the rate cuts do not benefit only a favoured few?' Ramesh asked in his post. His query follows the GST Council's recent rationalisation of GST rates removing the 12% and 28% tax slabs, effective from September 22 this year. A few days ago, Ramesh had also posted that the INC has long been advocating for GST 2.0, which would reduce the number of rates and cut taxes on many massconsumption items.

He said that the Union Finance Minister made the announcement after the GST Council meeting. "However, even before the GST Council meeting, the Prime Minister had already proclaimed the substance of its decision in his Independence Day speech of 15 August. Is the GST Council to be reduced to a formality?"He also added that the very design of GST 1.0 was flawed, a point the INC had raised back in July 2017 when the PM had made one of his typical U-turns by introducing GST.

ED summons BJP worker who accused Rahul Gandhi of holding UK citizenship

The Enforcement Directorate (ED) has summoned Karnataka BJP worker S Vignesh Shishir, who recently filed a petition in the Allahabad High Court alleging that Congress leader Rahul Gandhi is a British citizen, official sources said on Saturday. Shishir has been asked to appear before the ED on September 9 with all relevant documents and evidence, under provisions of the Foreign Exchange Management Act (FEMA). The agency is currently conducting a probe into the allegations, sources added.FEMA allows the ED to investigate suspected violations of foreign exchange laws by individuals or entities. When asked for

political figure and had reported receiving threats. The court also observed that he had been summoned by police in Raebareli district as part of an ongoing investigation.Shishir informed the court that the Central Bureau of Investigation (CBI) has been looking into his complaint since June 2024.

He claimed to have appeared before the agency multiple times in Delhi, submitting evidence related to his allegations. During an earlier hearing, the central government told the court it had officially contacted the UK government for clarification regarding Gandhi's citizenship status.

Books gone, lessons continue: When relief camp turns classroom for kids

Noida.(Agency)

Under the shade of trees beside a relief camp at Nagli Wajidpur in Sector 135, children sat on the ground, eyes fixed on blackboards. Their schoolbags and textbooks had been swept away by the Yamuna, which engulfed their homes and fields earlier this week.

'But lessons must carry on," Payal, a Class 9 student at the camp, said as she scribbled some notes on a borrowed paper. Nearly 3,700 villagers from 18 flood-hit villages of Gautam Budh Nagar remain displaced as the river, though receding, continues to submerge vast stretches of farmland. At the Okhla barrage, the water level dipped to 200 metres on Saturday, with discharge dropping to 1.92 lakh cusecs. But in low-lying areas, relief camps are still home to thousands who wait for the floodwaters to withdraw completely. To keep children engaged, social organisations and administration have begun running makeshift schools in and around the camps.

At Sector 135's relief centre set up by the district administration, around 60 children were taught the basics of counting and colours by the naib tehsildar and lekhpals on Friday. "The idea is to give them a routine and a sense that life is still moving forward," Ashutosh Gupta, SDM Sadar, where 12 villages are affected, said. For the children, the loss is tangible.

The children are still shaken by the flooding and displacement. The younger ones get restless because they're away from their comfort zones, so we try to keep the atmosphere light and playful to lift their spirits," Shristi from Chetna NGO, which is teaching children at a camp in Sector 130's Asgarpur, told.

At the camps, families receive meals, water, and bedding. The administration has stationed six medical teams with supplies, including anti-snake venom, and launched fogging drives to control mosquito breeding. Animal relief is also underway, with more than 1,400 cattle sheltered on Pushta Road in Sector 135. For displaced families, though, uncertainty lingers. Santram, a gardener who worked at a nursery on the floodplains, said his family suffered losses of nearly Rs 2 lakh, but he is determined that his children's education does not

Why busy parents are going to sleep coaches for their infants

Whoever coined the term - 'sleep like a baby' - must not have had one. Ask any new parent. Babies don't sleep soundly for long.

An average adult's sleep cycle is 90-120 minutes. For babies, this is around 40 minutes. Infants also don't have the ability to connect cycles as adults do – so a night's sleep for an adult is 4-6 cycles – and stay asleep for a longer duration. It's why they wake up frequently, leaving parents exhausted.

But new-age parents, especially in cities where both are working, have had enough of sleepless nights. They are constantly looking for solutions, turning to books, podcasts, videos, and more recently, paediatric 'sleep consultants'. It's a thriving market in Delhi-NCR – which is an aggregate of five cities and supports a huge middleclass working population - driven both by young parents' need to rest and greater awareness about the connection between quality of sleep and a child's growth

'Just like nutrition exploded a few years ago and everyone was talking about 'what to eat', the focus is now on sleep," said Himani Dalmia. A paediatric sleep consultant is essentially a certified sleep coach who may or may not be a doctor. Dalmia, who studied humanities in the UK, is one such. Heena Rastogi, a researcher, said she hasn't slept properly for a year. She also lost weight and developed hormonal imbalances, all because her one-year-old daughter is a "light sleeper".

Astrologer held from Noida condo apartment for Mumbai terror hoax

Ashwini Kumar, a Noida resident who was arrested by Mumbai Police for making a phone call threatening serial explosions in the Maharashtra capital, wanted to take revenge on a former friend in Bihar and came up with this devious plan.

Kumar, originally from Patna, moved to the city five years ago and set up an astrology business. In 2023, his friend Firoz Ahmed filed a cheating case against Kumar in Bihar's Phulwari Sharif police station, following which he spent four months behind bars there.

Nursing a deep grudge and looking for an opportunity to hit back, Kumar sent a threat message on Thursday to Mumbai's traffic control room with Firoz's name on it, warning that 34 live bombs were planted across the city and 14 terrorists from Pakistan had infiltrated. Kumar appended a fictitious name, 'Lashkar-e-Jihadi', to convey the sense of a terrorist organisation being involved. The message, sent through WhatsApp from a number that Kumar had recently purchased and put Firoz's display picture on, claimed the attacks could impact one crore residents.

Amid Ganesh Chaturthi festivities, Mumbai Police had declared high alert, deploying the crime branch, antiterrorism squad and local teams in sensitive areas. After investigators traced the origin of the message to Noida, Mumbai police coordinated with Noida police commissioner Laxmi Singh.

On Friday night, a special team from Mumbai comprising SWAT units accompanied by Noida police raided Kumar's residence at Civitech Stadia in Sector 79. Police recovered seven mobile phones, three SIM cards, an external SIM slot device, six memory cards, and four SIM holders, which Kumar had used to mask his identity. Preliminary interrogation revealed that Kumar had no links to any terrorist group. "He wanted his friend to be jailed," said a senior officer, adding the details of the fraud case would be sought from Bihar Police.

Bulk waste generators in Gurgaon face penalty deadline

Gurgaon.(Agency)

Gurgaon: MCG on Friday directed all bulk waste generators (BWGs) to immediately clear their pending dues and submit the payment receipts to its office by Sept 8.

MCG has warned that failure to pay within the stipulated deadline will invite strict legal action. This will include the imposition of additional penalties, punitive measures and the registration of FIRs against the BWGs.

Chief officer of MCG's BWG cell Colonel Sanjay Pandey said, "The challan On Thursday, in an official payments can be made at MCG's citizen notice issued by the facilitation centres located in Sector 34, Sector 42 and the old office near Civil Hospital. To facilitate compliance, these centres will also remain open on Saturdays for challan payments.

The civic body has also sent emails to all BWGs, directing them to acknowledge receipt of this notice and ensure payment within the prescribed time.

This comes a day after MCG withheld the salaries of four clerk-cum-bulk waste generator (BWG) inspectors and their teams for failing to recover penalties from violators of the Solid Waste Management Rules, 2016.

notice issued by the additional commissioner Ravinder Yadav, MCG observed that despite repeated directions and meetings, the recovery of penalties from offenders continues to remain pending.

The notice stressed that the release of salaries will now be conditional upon satisfactory recovery of penalties. MCG formed the BWG monitoring cell to

inspect bulk waste generators and ensure compliance with SWM Rules in Oct last year. The cell is headed by a chief officer. One inspector is appointed for each of the four zones in the BWG cell.

In July last year, MCG revised the criteria for identifying BWGs per the Union ministry of housing and urban affairs guidelines. According to the revised guidelines, waste generators that produce 100kg or more waste daily are classified as BWGs against the previous limits of 50kg or more. MCG also recently announced stringent measures against illegal dumping of waste.

t has invoked Section 15 of the Environment (Protection) Act, 1986 to warn violators that they could be fined up to Rs 1

lakh and may land in jail for up to five years. The crackdown, officials said, is to tackle violations mostly by BWGs, contractors and vehicle operators who dispose of waste at non-designated sites.

Radhika charge sheet: 'Shot dead by father over taunts'

Gurgaon. (Agency)

Gurgaon: Two months after 25-year-old junior international tennis player Radhika Yadav was murdered by her father Deepak on July 10, Sector 56 police filed the chargesheet in a local court on Thursday.

According to sources, police claimed that Deepak, despite investing heavily in grooming his daughter as a tennis player, killed her after an argument when he asked her to quit coaching. They added that he was deeply affected and poisoned by "taunts" from his relatives and native villagers about being financially dependent on his daughter.

The incident occurred at the family's Sector 57 home around 10.30 am. Radhika was in the kitchen when Deepak suddenly took out his gun, approached her, and shot her from behind four

times.Initially, other family members living in the three-storey house thought a cooker had exploded. Radhika's mother



gunshots alerted Radhika's younger brother Kuldeep, who lives on the ground floor, prompting him to rush upstairs. Kuldeep found a bleeding Radhika

slumped on the ground. Neighbours rushed to help transport her to a private hospital, where she was declared dead. was downstairs at the time. The sound of Deepak, 49, was arrested and charged with

murder after Kuldeep filed a police complaint. Police also recovered the murder weapon, a licensed revolver belonging to Deepak. Sources said Deepak had worked diligently to build Radhika's career, accompanying her to practice sessions and tournaments.

However, Radhika suffered an injury that prevented her from continuing to play competitive tennis. "Following the injury, she began coaching both male and female players," an investigator said. Investigators said the accused was

unhappy with Radhika giving tennis coaching. He repeatedly asked her to give it up, which led to frequent arguments

Amid rain and flooding, Noida records 100 more cases of dengue in a wk

Noida . (Agency)

The city recorded over 100 new dengue cases in the past week, taking this season's total to 176, while malaria cases touched 85. Health officials say the surge is because of heavy rainfall and waterlogging, warning that the numbers could rise further.

Earlier, reported that dengue cases in the district nearly doubled in the second week of Aug, prompting the health department to issue 48 notices, including ones to 13 housing societies for allowing stagnant water to turn into mosquito-breeding grounds.

Several hotspots have been identified and inspections are underway to prevent mosquito breeding there," said Dr Stuti Kirti Verma, district malaria officer. She said survey teams visited Sector 9 slums and houses, where larvae were found, while Barola, Harola, Amrapali Dreams, Galaxy Vega, and Royal Nest remain among the most affected localities in Noida. Officials said 265 rapid response teams have been deployed under the Dastak campaign for surveillance, treatment, and awareness drives.

Meanwhile, 59 dengue and 56 malaria cases have surfaced in Ghaziabad so far, with seven patients currently hospitalised. "All district hospitals have been instructed to reserve 10 isolation beds with mosquito nets for dengue patients. Primary health centres will have at least five such beds," said Dr R. K. Gupta, ACMO, Ghaziabad.

Private hospitals in Noida have witnessed a spike too. "We are seeing 20–25 dengue cases daily in the OPD. Many patients are being admitted with platelet counts below 15,000," said Dr Shovana Veshnavi, principal consultant (internal medicine) at Max hospital.

Court junks petition against Gurgaon mayor's caste certificate

Gurgaon: A district court has dismissed a mayor Raj Rani Malhotra's caste certificate.

The legal tussle began in April this year when Yashpal Prajapati, representing the Maharaja Daksh Prajapati Society, filed a petition alleging that Malhotra had fraudulently obtained a Backward y certificate by falsely claiming to belong to the 'sunar' caste.

The petitioner argued that Malhotra, who runs a jewellery business, had secured the certificate on Feb 16 through the additional deputy commissioner, and used it to contest and win the mayoral election. Prajapati demanded the immediate nullification of the mayoral election and sought an order barring Malhotra from exercising her official powers.

Prajapati contended that caste was determined by birth — not by profession — and alleged that Malhotra, as the daughter of Vishan Dass Butta of the Buta

Punjabi Jat community, did not qualify for the 'sunar' caste status.

Born on August 15, she couldn't be nursed by her mother. Manisha (32) was in intensive care, battling critical injuries sustained in a road accident that day on Rohtak-Jhajjar road. She was 32 full term. Doctors succeeded in saving the baby. Manisha succumbed five days later.

For an entire fortnight, the baby girl - fragile with a birth weight of 1.7kg – was sustained by other lactating mothers till she was discharged from the neonatal ward of PGIMS Rohtak on September 1. These women weren't directly nursing her. Mother's milk for the baby was sourced from the milk bank set up at the hospital last month.

Set up with Rs 40 lakh funds from National Health Mission, Haryana's first human milk bank has already helped stabilise nearly 200 babies who did not have access to mother's milk for different reasons. Cops add criminal conspiracy charges

New Delhi: The Delhi Police added charges of criminal conspiracy following revelation by the two arrested accused in connection with the alleged assault on Chief Minister Rekha Gupta at her camp office in Civil Lines. A senior police officer said the fresh charge was added after investigators found evidence suggesting the assault was not an isolated act but part of a planned conspiracy. Both accused - Rajeshbhai Khimji and Tahseen Syed - who are already in custody, were earlier booked under assault and related sections. Criminal conspiracy charges under Section 61 of the BNS have now been added to the case. According to Section 61 of the BNS, when two or more persons agree to commit an illegal act, or an otherwise legal act through illegal means, such an agreement amounts to a criminal conspiracy. It further states that conspirators to offences, punishable with life imprisonment or rigorous imprisonment of two years or more, face the same punishment as if they had abetted the offence. Following the incident, the Delhi Police have significantly intensified security arrangements for Chief Minister Rekha Gupta, permanently deploying 40 personnel and ordering multiple frisking of visitors before their entry to any of her events. Initially, the Union Home Ministry had directed the CRPF to extend Z-category cover to the Chief Minister, but that arrangement has now been withdrawn. Instead, the Delhi Police have taken over her protection with additional deployment.

New Delhi: A government wine shop salesman in Bharat Nagar, Northwest Delhi, was attacked by unidentified assailants with hockey sticks and knives, the police said on Sunday. US Man Charged After Bullet Meant For Bird Kills Daughter Days Before Her Birthday

In a tragic incident, a US father has been charged by the authorities after he fired a bullet to shoot a bird, but ended up killing his daughter. The man, identified as David Schultheis of Prairie Du Rocher in Illinois, was attempting to gun down a buzzard that had flown into a brick building on July 21 when the bullet passed through the bird, pierced a window and struck his daughter, Emma Schultheis. Emergency responders were called to the scene and immediately started administering CPR and other life-saving treatments. Ms Schultheis was rushed to a St Louis-area hospital but was later pronounced dead, according to a report in the New York Post. She was due to turn 15 in six days. The sheriff's department handed the case to Monroe County State's Attorney's Office last month and filed formal charges.

"There are no words that can adequately express the heartbreak and gravity of this tragic event," the sheriff's department said. "The death of a child under any circumstances is profoundly devastating."

While this incident may have been preventable, our obligation is not to dwell in speculation but to uncover and present the facts with integrity," they added. On September 2, Monroe County State's Attorney Ryan Webb charged Schultheis with reckless discharge of a firearm, while a woman named Karen Schwarze was charged with concealment of a homicidal death and obstruction of justice. Authorities did not specify Schwarze's connection to the victim. Notably, Schwarze hid the .40-calibre pistol used in the shooting and pressured others not to speak about the incident to the law enforcement agencies.

US Commandos Killed North Korean Civilians In Botched 2019 Mission: Report

Elite US Navy SEALs launched an audacious operation in 2019 to plant a listening device in North Korea to spy on the country's reclusive leader Kim Jong Un, the New York Times reported Friday, but the mission quickly unraveled and culminated in the deaths of multiple civilians. The operation came in the first administration of President Donald Trump during sensitive nuclear talks with Kim, whom the US leader met three times. The mission was considered so risky that it required direct presidential approval, the Times said, but Trump insisted Friday he had no knowledge of the operation. "I don't know anything about it. I'm hearing it now for the first time," the president told journalists. Despite months of practice, the mission still went horribly wrong, the Times reported.

The SEALs -- from the same unit that killed Osama bin Laden in 2011 -- approached North Korea in minisubmarines that exposed them to frigid water for hours, then swam ashore, according to the newspaper, which interviewed two dozen people to piece together the account. The special forces personnel thought they were alone, but ddn't see a small boat in the area.

The boat later approached the mini-subs, with the crew carrying flshlights. One person jumped into the water. Thinking the mission was compromised, the senior enlisted SEAL ashore opened fire on the boat, as did the others with him. When they reached the boat, they found two or three bodies, but no guns or uniforms: the dead were apparently civilians who were diving for shellfish. The SEALs used knives to puncture the lungs of the boat's crew so the bodies would sink, and were able to escape unharmed. The Times said the operation prompted a series of military reviews that found the killings were justified.

The results of the reviews were classified, and key congressional leaders were kept in the dark.

'Lot 41': Iran turning Islamic Revolution burial site into parking area; satellite images show paving

A section of Tehran's largest cemetery, where thousands of people executed after Iran's 1979 Islamic Revolution were buried, is being paved over to make a parking lot.Lot 41 of Behesht-e Zahra cemetery has long been known as the burial place of dissidents, monarchists, communists and others killed by firing squad or hanging in the early years of the Islamic Republic. The area has been under tight surveillance for years, with grave markers vandalised and trees deliberately dried out. United Nations special rapporteur in 2024 says the demolition is part of Iran's effort to erase evidence of mass killings and prevent families from mourning.Satellite images from Planet Labs show the land being freshly paved in August, with trucks and asphalt piled on site. Cemetery officials say the parking will serve visitors to a nearby section where authorities plan to bury victims of the recent Iran-Israel conflict, reported reformist newspaper Shargh. Tehran's deputy mayor, Davood Goudarzi, confirmed last week that the lot is being turned into parking space. He described those buried there as "hypocrites of the early revolution" and said the project was "ongoing in a precise and smart way," as qouted by Associated Press.

The move has sparked criticism from rights activists and lawyers, who argue that families were never consulted, as required by Iran's own cemetery laws. Research suggests between 5,000 and 7,000 people may be buried in Lot 41."It represents the final phase of destruction," said Shahin Nasiri, a University of Amsterdam lecturer who studied the site. "Families are still searching for the graves of loved ones. The destruction adds another barrier to truth and justice."

The move follows a pattern of Iranian authorities targeting graves of political prisoners, Baha'i minorities and protesters from the 2009 Green Movement to the 2022 Mahsa Amini demonstrations.

Israel strikes high-rise building as it sets sights on taking over Gaza City

Israel has begun mobilizing tens of thousands of reservists and repeating evacuation warnings as part of its plan to widen its offensive, which has sparked opposition domestically and condemnation abroad.

Israel struck a high-rise building in Gaza City on Friday after an evacuation warning, as the military stepped up operations aimed at seizing control of the famine-stricken city of some 1 million Palestinians. Strikes elsewhere in Gaza City killed at least 27 people, health officials said. The military accused Hamas militants of using highrises in the city for surveillance and planned ambushes, and said it would carry out "precise, targeted strikes" on militant infrastructure in the coming days. Israel has begun mobilizing tens of thousands of reservists and is repeating evacuation warnings as part of its plan to widen its offensive, which has sparked opposition domestically and condemnation abroad. Palestinians said Friday's strike targeted the Mushtaha tower in Rimal, an upscale neighborhood before the war. Gaza City resident Ahmed al-Boari said people fleeing Israeli operations elsewhere in the city had sought shelter in and around the building. Satellite imagery showed a large number of tents nearby. It was not immediately clear if anyone was wounded or killed in the strike. Israel said it struck the building because it was used by Hamas for surveillance. Photos of the building taken before Friday's strike showed that its roof was already heavily damaged from earlier raids.

Fears grow as Israeli forces advance

Israel has declared Gaza City, in the north of the territory, to be a combat zone. Parts of the city are already considered "red zones" where Palestinians have been ordered to evacuate ahead of expected heavy fighting. That has left residents on edge, including many who returned after fleeing the city in the initial stages of the war, which has

already displaced around 90% of the territory's population. The offensive has also sparked widespread protests among



Israelis who fear it will endanger hostages still held in Gaza, some of whom are believed to be in Gaza City. There are 48 hostages still held in Gaza, 20 of them believed by Israel to be alive.

Hamas video shows hostages

Hamas released a propaganda video Friday of two hostages in Gaza City. The video shows Guy Gilboa-Dalal in a car, at one point joined by another hostage, Alon Ohel. Gilboa-Dalal speaks, likely under duress,

pleading for an end to the war and the return of hostages. He was last seen in a video more than six months ago with another

hostage, Evyatar David, as they watched other hostages being released during a ceasefire. Israel's has killed more than 64,000 Palestinians, according to Gaza's Health Ministry, which does not say how many were civilians or combatants but says women and children make up around half the dead. Settlers attack Palestinians in the West BankIsraeli settlers descended on the Palestinian

village of Khallet A-Daba in the occupied West Bank overnight, attacking residents with clubs and pepper spray, said Palestinians who arrived at the village in the attack's aftermath. Video obtained from Palestinian activist Adeeb Huraini, 26, showed an older man with cuts on his head and leg, and a woman whose headscarf was soaked in blood. Another video shows Basel Adra, a local activist, holding a baby with blood on its head, calling for help and saying there is "a lot of blood.

US-Funded Research At Colleges Aided Chinese Military: Report

Over a recent two-year period, the Pentagon funded hundreds of projects done in collaboration with universities in China and institutes linked to that nation's defense industry, including many blacklisted by the US government for working with the Chinese military, a congressional investigation has found.

The report, released Friday by House Republicans on the Select Committee on the Chinese Communist Party, argues the projects have allowed China to exploit U.S. research partnerships for military gains while the two countries are locked in a tech and arms rivalry."American taxpayer dollars should be used to defend the nation - not strengthen its foremost strategic competitor," Republicans wrote in the report. "Failing to safeguard American research from hostile foreign exploitation will continue to erode U.S. technological dominance and place our national defense capabilities at risk," it said.

The Pentagon and didn't immediately respond to an Associated Press request for comment. The congressional report said some officials at the Defense

Department argued research should remain open as long as it is "neither controlled nor classified."The report makes several recommendations to scale back U.S. research collaboration with China. It also backs new legislation proposed by the



committee's chairman, Rep. John Moolenaar, R-Michigan. The bill would prohibit any Defense Department funding from going to projects done in collaboration with researchers affiliated with Chinese entities that the U.S. government identifies as safety risks. The Chinese Embassy on Friday called the report "groundless." "We oppose it," the embassy said. Beijing has in the past said science and technological

cooperation between the two countries is mutually beneficial and helps them cope with global challenges. The 80-page report builds on the committee's findings last year that partnerships between U.S. and Chinese universities over the past decade allowed hundreds

of millions of dollars in federal funding to help Beijing develop critical technology. Amid pressure from Republicans, several U.S. universities have ended their joint programs with Chinese schools in recent years. The new report focuses more narrowly on the Defense Department and its billions of dollars in annual research funding. The committee's investigation identified 1,400

research papers published between June 2023 and June 2025 that acknowledged support from the Pentagon and were done in collaboration with Chinese partners. The publications were funded by some 700 defense grants worth more than \$2.5 billion. Of the 1,400 publications, more than half involved organizations affiliated with China's defense research and industrial base.

Canada's Big Admission Over Khalistani Terror Groups Funding

WASHINGTON .(Agency)

A Canadian report has raised red flags over terror financing linked to Khalistani terrorists in the country. While it has been an open secret that Canada provides a safe haven to Khalistani terror groups like the Babbar Khalsa, International Sikh Youth Federation, and Sikhs for Justice, Ottawa has, for the first time, admitted that these groups have been operating from Canadian soil and receiving financial support.

The admission is part of an assessment on money laundering and terrorist financing risks in Canada by its Finance department. The Khalistani groups "are suspected of raising funds in a number of countries, including Canada", it said. The report also pointed to financial links between Canada and other listed terror groups like Hamas and Hezbollah under the Politically Motivated Violent Extremism (PMVE) category. Several terrorist entities listed under the Criminal Code in Canada that fall under the PMVE category, such as Hamas, Hezbollah, and the Khalistani violent extremist groups Babbar Khalsa



International and the International Sikh Youth Federation, have been observed by law enforcement and intelligence agencies to receive financial support originating from Canada," the report said.

Extremist groups are capitalising on charitable funds to drug trafficking and auto thefts, the report said, noting that Canada remains a terror financing hub. It also pointed to the misuse of the non-profit sector by Khalistani terrorists and donations from expatriates."

These groups previously had an extensive fundraising network in Canada but now appear to consist of smaller pockets of individuals with allegiance to the cause but seemingly no particular affiliation to a specific group," the report noted. It also flagged diverse funding methods for these groups, from crowdfunding and cryptocurrency. These terror groups use "diverse funding methods to sustain their operations, including the abuse of the MSB and banking sectors.

New York Mayor Eric Adams Says Won't Quit Race, Can Beat Zohran Mamdani

insisted again Friday that he won't end his reelection campaign, stressing that he'll remain in the race as reports swirl that he's been approached about possibly taking a job in the Trump administration. At a hastily called news conference, Adams declared, "I am in this race. And I am the only one who can beat Mamdani," referring to the Democratic nominee, Zohran Mamdani."How many times have I been told throughout this journey to step aside, to surrender, to give up, to give in," he said. "That's the same thing we tell everyday New Yorkers. Everyday New Yorkers are not giving up, are not giving in, are not surrendering, so their mayor is not going to do that." Adams has spent the week fending off news reports that



intermediaries for President Donald Trump had contacted people in the mayor's orbit to talk about whether he would consider abandoning his campaign to take a federal job. He had released a statement earlier Friday that said said he "will always listen if called to serve our country" but that he had not yet received any "formal offers."Hours later, he summoned news reporters to the mayor's official residence in Manhattan, Gracie

Mansion, fueling speculation that he would bow out of the contest.

But instead, he doubled down on his intentions to press on, launching broadsides at Mamdani and former Gov. Andrew Cuomo, calling them "two spoiled brats" who are "not like us," while playing up his own working-class origins. Trump has told reporters he would prefer not to have Mamdani, 33, as the next mayor of the largest U.S. city. He said he'd like to see two of the three other major candidates taking on Mamdani — Cuomo, who like Adams is running as an independent, and Republican Curtis Sliwa — leave the race to create a oneon-one contest. Moments after Adams' announcement, Trump was asked about it by reporters at the White House. "He's free to do what he wants," Trump said of Adams.

Trump's job market promises fall flat as hiring collapses and inflation ticks up

The U.S. job market has gone from healthy to lethargic during President Donald Trump's first seven months back in the White House, as hiring has collapsed and inflation has started to climb once again as his tariffs take hold.Friday's jobs report showed employers added a mere 22,000 jobs in August, as the unemployment rate ticked up to 4.3%. Factories and construction firms shed workers. Revisions showed the economy lost 13,000 jobs in June, the first monthly losses since December 2020, during the COVID-19 pandemic. The new data exposed the widening gap between the booming economy Trump promised and the more anemic reality of what he's managed to deliver so far. The White House prides itself on operating at a breakneck speed, but it's now asking the American people for patience, with Trump saying better job numbers might be a year away."We're going to win like you've never seen," Trump said Friday. "Wait until these

factories start to open up that are being built all over the country, you're going to see things happen in this country that nobody expects."The plea for patience has done little to comfort Americans, as economic issues that had been a strength for Trump for a decade have evolved into a persistent weakness. Approval of Trump's economic leadership hit 56% in early 2020 during his first term, but that figure was 38% in July of this year, according to polling by The Associated Press-NORC Center for Public Affairs Research. The situation has left Trump searching for others to blame, while Democrats say the problem begins and ends with him. Trump maintained Friday that the economy would be adding jobs if Federal Reserve Chair Jerome Powell had slashed benchmark interest rates, even though doing so to the degree that Trump wants could ignite higher inflation. Investors expect a rate cut by the Fed at its next meeting in September, although that's partially because of weakening job numbers.Senate Minority Leader Chuck

Schumer D-N Y said Trump's tariffs and

Schumer, D-N.Y., said Trump's tariffs and freewheeling policies were breaking the economy and the jobs report proved it."This is a blaring red light warning to the entire country that Donald Trump is squeezing the life out of our economy," Schumer said.By many measures, Trump has dug himself into a hole on the economy as its performance has yet to come anywhere close to his hype.

 Trump in 2024 suggested that deporting immigrants in the country illegally would protect "Black jobs." But the Black unemployment rate has climbed to 7.5%, the highest since October 2021, as the Trump administration has engaged in aggressive crackdowns on immigration.

At his April tariffs announcement, Trump said, "Jobs and factories will come roaring back into our country and you see it happening already." Since April, manufacturers have cut 42,000 jobs and builders have downsized by 8,000.

— Trump said in his inaugural address that the "liquid gold" of oil would make the nation wealthy as he pivoted the economy to fossil fuels. But the logging and mining sectors — which includes oil and natural gas — have shed 12,000 jobs since January. While gasoline prices are lower, the Energy Information Administration in August estimated that crude oil production, the source of the wealth promised by Trump, would fall next year by an average of 100,000 barrels a day.

Over 30 children fall ill in Kochi, cause yet to be traced

Around 35 to 40 children in Keerampara panchayat, near Kothamangalam, fell ill and sought treatment at various hospitals in the past week. The children, under the age of 10, were hospitalised with symptoms like vomiting and diarrhoea.

"As many cases were reported and children sought treatment at the Primary Health Centre, the medical officer informed us about the spread. We suspect contaminated water to be the reason behind the disease spread. Most families are dependent on Kerala Water Authority's (KWA) connections. However, people who use well water have also been affected with symptoms," said Beena Rijo, the vice-president of the panchayat. "The condition is not diagnosed yet. We checked The Aroor-Thuravoor stretch of NH 66, where an with the school. But children who don't go to school, including anganwadi kids, have also been affected. Also, these children recover in two or three days. The panchayat and health officials are investigating the spread," said Basil Baby, ward member of Chenkara, one of the affected areas.

The first case was reported on September 1. Basil Baby said that the local body has been ensuring chlorination of drinking water sources, and prevention activities. Most cases are reported in Chenkara, Punnekkad North, Palamattam, and Punnekkad South wards of the local body.

"The people here usually don't go out to have food. However, while enquiring, we came to know that some children have consumed food from outside – hotels and restaurants. We are still investigating to find the cause of the spread and prevent further spread," she added.

Where the forgotten heal: inside Pune's unique hospital where stray dogs get a second chance at life

When Bella, a street dog, was carried into Karma Foundation, she had already endured unimaginable cruelty: both eyes burned with battery acid. Few believed she could survive. Yet, in the stillness of midnight, surgeons worked against the odds to save her.

Today, Bella is blind, but she is happy. She runs, her tail wagging, following people by scent and sound. Her life is no longer defined by pain, but by resilience, resilience that only unconditional love can nurture. "The greatness of a nation and its moral progress can be judged by the way its animals are treated," Mahatma Gandhi once said. In Pune, this philosophy is embodied in the Karma Foundation, an animal hospital where every scar, every wound, and every abandoned life on the streets is given dignity, compassion, and a second chance.

Bella is one of hundreds of animals who find a lifeline at Karma Foundation every year. Founded in 2018 by Priya Kailad, the hospital began as a modest 200 sq ft area. Before founding the organisation, Kailad worked as a child psychologist with a school for children with special needs, where her compassion for the vulnerable took root. Carrying that same empathy forward, she began rescuing distressed animals-dogs, cats, even goats. "Every day I saw dogs hit by cars, animals



bleeding on the streets, and no one stepping forward to help," Kailad recalls. "The indifference was as painful as the cruelty." That heartbreak became her determination to build a space where the forgotten could heal.

From that small area, Karma Foundation in Aundh, Pune, has grown into an ably equipped hospital with an operation theatre, ventilator, pathology lab, X-ray unit, and a dedicated team


of doctors, surgeons, and animal handlers. But what truly sets it apart is its philosophy- it is not a shelter, but a hospital. "We are not a shelter, we are a hospital. That's a big difference," says Kailad. "Our job is to heal and return animals to their homes on the streets, unless they truly cannot survive there."

The work is relentless, and the struggles are many. Funding is a constant worry, with medical bills mounting for surgeries, treatments, and round-the-clock care. "People expect animal welfare to be free," Kailad says, "but quality care requires resources, from sterile operating theatres to life-saving equipment." The hospital model also allows them to prioritise treatment over long-term housing, ensuring resources are used where they are most needed.

Often, Karma Foundation is unable to admit animals suffering from highly infectious diseases because the hospital lacks specialised isolation wards required for such cases.

"Just like every hospital didn't have a Covid ward, we too cannot risk other animals' lives by admitting contagious cases," Kailad explains.

Kerala's child mortality rate lower than that of US, says health minister Veena George

Kerala's child mortality rate is now less than that of the US. "Kerala's child mortality rate is 5 per 1,000 births, lowest in the country as per the latest Sample Registration System report. Infant mortality rate for the United States is 5.6. Kerala's mortality is lower than that of developed countries," Health Minister Veena George said in a statement on Saturday. The minister congratulated health workers and other stakeholders who worked for this.

Kerala's infant mortality rate is below 4 pc as against the national figure of 18. This too is on a par with developed countries. Kerala could bring down the child mortality rate from 6 in 2021

The minister said the government was giving much importance to infant, child and maternal care. Steps were taken to raise the standards of all hospitals with delivery care. Sixteen hospitals in the state won national LaQshya certification and six hospitals won national MusQan certification. Kerala is the first state to implement a mother and child friendly hospital initiative. Comprehensive newborn screening facility is available at all hospitals offering delivery care.

The government also runs the Hridyam scheme to identify and treat children with congenital heart diseases. So far 8,450 children were given free heart surgeries. "Kerala has the same child mortality rate for urban and rural areas. Intensive care units for infants have been established in hospitals including those in tribal and coastal areas. Healthcare facilities are available to urban and rural

Insufficient drains: Waterlogging threat looms over **Aroor-Thuravoor elevated highway section**

acute traffic congestion is being witnessed due to ongoing elevated highway construction work, faces a permanent waterlogging threat as the National Highways Authority of India (NHAI) is reportedly proceeding with the drainage construction without sufficient drain outlets.

Officials of various panchayats, through which the stretch passes, and the Janakeeya Jagrata Samiti accuse the NHAI of providing storm water outlets to small canals en route, instead of draining it out to big water bodies, which they claim will only result in flooding of low-lying areas.

In fact, Kodamthuruth panchayat is yet to give permission to the NHAI to provide drain outlets, despite the central agency seeking the same nearly a year ago.

"The NHAI is seeking to drain the water into small canals (edathodu), instead of the Kuthiathode lake. But the same will only result in waterlogging of the entire low-lying region. Only 1.5 km of the NH frontage passes through our region, from Kuthiathode to Chammanad

the storm water into small canals," said "The NHAI is constructing a big drainage, Kodamthuruth panchayat president Jayakumar V G. "What should have been ideally done is to drain the storm water into major water bodies like Aroor Lake, Chandiroor canal and



Kuthiathode lake, instead of small water bodies. which will get easily filled up. The panchayat is yet to give the nod, but the NHAI is going ahead with the drainage construction without sufficient outlets," said Sanoob Aziz, a member of the Samiti, formed to protest the lack of throughout the stretch realising this. But the lack of sufficient drain outlets will lead to permanent waterlogging during heavy rains. Various spots like Kodumthuruth, and the

northern side of Chandiroor bridge are already getting waterlogged at the slightest of rains," he added. NHAI officials, though, turned down the charges, while admitting that they are yet to get the permission of the Kodamthuruth panchayat to set up drain outlets.

Elevated highway: 70 per cent work completed

Meanwhile, the construction of the country's longest six-lane elevated highway on the 12.75-km Aroor-Thuravoor stretch has entered the final phase.

"We have achieved 70 per cent progress. We have completed erecting all piles on the entire stretch. Also, the construction of all the piers (total 400) is over. Similarly, 230 deck slabs out of the total 353 have been completed, while 2,500 girders out of the total 2,560 have been erected," the

Even as the city corporation has inaugurated the state's first fully modernised abattoir, its operations are yet to gather full steam amid concerns raised by butchers and meat traders. After remaining shut for over a decade, the city corporation inaugurated the slaughterhouse, modernised at a cost of Rs 10 crore, very recently.

The civic body's decision to levy a slaughtering fee of Rs 1,500 for large animals has come as a heavy blow to the butchers and meat vendors. Meat traders warn that the steep charges, coupled with transportation costs, could push meat prices, which currently hover around Rs 280 to Rs 300 per kg. With the opening of the slaughterhouse, the civic body is planning to put an end to illegal slaughtering and meat vending. Shafeeq Abdul Rahman, a representative of butchers and meat traders,

said that the slaughtering fee is not affordable for them. "As many as 100 traditional workers involved in slaughtering will lose their jobs after the transition. We want the government to give them some relief as they are losing their jobs permanently. The high slaughtering fee, along with the transportation cost, will eventually reflect in the meat prices," said

The agreement with the agency stipulates an annual rent arrangement, under which the contractor will pay Rs 75 per large animal and Rs 15 per small animal to the corporation, with a 10% annual hike.

Butchers have also voiced concerns over the transition to a largely mechanised slaughtering process, arguing that it does not take into account halal practices, which are essential to a significant section of consumers. "Eighty percent of people



involved in this business are from the

Muslim community and they will not agree

to a fully mechanised system without following halal practices. We will be raising all these issue with the authorities," said Shafeeq. The new slaughterhouse, which has a handling capacity of 50 to 75 animals, is equipped with an effluent treatment plant (ETP), biogas units, chilling rooms, odour control systems, and a rendering plant for waste management. More than 70% of operations are mechanised, designed to ensure hygienic, safe, and environmentally sustainable meat production.

According to civic authorities, minor works are still remaining at the abattoir. "The work of the biofilter will be completed within two weeks. Once the work is completed, we will officially announce a deadline to make the transition. Prior to that, we will be meeting the stakeholders. We will sensitise the butchers and meat vendors on the new

RSS @ 100 | Reimagining India's script over a century

The spotlight is on the RSS because it has completed a century of existence. Also because many believe that it is controlling the BJP and micro-managing its affairs. The recent interactive session RSS sarsanghchalak Mohan Bhagwat held in the national capital cleared many doubts; but it disappointed those who were expecting the RSS to explode a bombshell. The RSS is not used to rattling the applecart. It works quietly, patiently and persistently committed to its ideology and style of work. It is this perseverance and relentless resilience that has made the RSS the unique organisation it is. The Sangh parivar's detractors have been impatiently waiting for any opportunity to unsettle Prime Minister Narendra Modi's continuance in office. As he could not be democratically defeated, his opponents expected that the so-called imaginary age bar the Sangh was supposed to impose on its pracharaks would open a Pandora's box. The Sangh's role has been transformative and decisive, but it doesn't interfere in the day-to-day affairs of its affiliates. It plays a guiding motherly role. That is why at this stage Bhagwat spoke more about social harmony and unity than about a Hindu rashtra. The organisation has expanded phenomenally and come to occupy the centre-stage of Indian political debate. Its influence has increased and it has come to influence the course of history in the 21st century. Thanks to the nation-building activities the Sangh has been involved in in the last 10 decades, its approach is being keenly watched by the world community. After Bhagwat's three-day session last week, the speculation on Modi's continuance as prime minister is over and, understandably, the opposition is upset. He explained that at no point was there a decision to retire at the age of 75.He further buttressed the point by affirming that he himself is not planning to step down in September, when he completes 75. He also made it clear that the Sangh would strive for national integration, uphold the values of the Constitution, and that the vision of a united, developed India was primarily the core idea of the Sangh family.On many occasions, Sang leaders have proved prophetic. Many years ago, the Bharatiya Mazdoor Sangh founder and RSS ideologue Dattopant Thengadi had told this writer that the Sangh would attain its pinnacle of glory when Bhagwat becomes the sarsanghchalak. At that time, Bhagwat was nowhere in the national Sangh hierarchy. Similarly, Thengadi had foreseen the collapse of the Soviet Union and the fall of Communism many years before it actually happened. The fifth sarsanghchalk, KS Sudarshan, had on many occasions predicted the rise of India after 2012. At that point, the UPA was in power at the Centre and there was no sign of Modi emerging as a saviour on the national stage.

The RSS's declared goal is 'param vaibhav' (ultimate glory of India). Critics asked why Bhagwat did not speak about Hindu rashtra during his stay in Delhi. Has the RSS moved away from its basic goal? Or why did the sarsanghchalak not take a hard position on the liberation of Hindu temples across the country, limiting himself to Kashi and Mathura? What these critics have not realised is that the Sangh does not act on the script dictated by its adversaries. The Sangh has been a reformative and innovative power in Indian society. Unlike its ideological opposition in the Left, the Sangh has been progressive in its approach to reforms, new technology and modern gadgets. The Left has fallen by the wayside of history, opposing India's one culture, the Quit India movement, the Constitution, even computerisation, the space mission, private capital, and the opening up of the economy. Its thinkers and historians carried colonial baggage and tried to undermine the civilisational strength of India. The RSS, on the other hand, took every challenge and opportunity to reach out to new areas and adopt a new workstyle. Water will find a way, in India & Pakistan

THE GREAT GAME: The Indus treaty held because it had rules about treating the waters of Punjab's rivers

WATER, water everywhere, said the poet, a line that is really a drumbeat in your brain as you look around the Mand area in Sultanpur Lodhi, where the Beas has burst its banks and flooded the paddy crop — a story The Tribune is also following, on the loss and devastation of one half of its two-crop agricultural cycle. Watching Punjab's rivers rise these past few weeks has been a lesson in both History and Geography. We know that the confluence of two Persian words, Panj and Aab, gave rise to the portmanteau word 'Panjab', meaning "the land of the five waters"; it is attributed to Ibn Battuta, the traveller from Tangiers who is believed to have roamed this region in the 14th century. But here's the irony: Prior to Battuta, Punjab was known as Panchnad, a Sanskrit word that means the "land of the five rivers" — a word that dates from the time of the Mahabharata, and which, even today, is the name of the river in Pakistan into which all five rivers of undivided Punjab — the Jhelum, Chenab, Sutlej, Beas and Ravi — fall, before the one mighty portmanteau river pours itself into the Arabian Sea. Note, then, how Nature (with a capital N) abhors small men-made divisions and partitions, either during 1947 — when blood ran like water — or after, as recently as April 2025, when in the wake of the horror of the Pahalgam massacre, a furious India put the circa 1960 Indus Waters Treaty (IWT) in abeyance. The IWT had held, despite two wars and one limited conflict, because it had rules about treating the waters of Punjab's rivers.

On the eve of Operation Sindoor, India shut down the sluice gates of the Baglihar dam on the Chenab in Jammu and announced that not a "single drop of water" would be allowed to flow into Pakistan in retaliation for Pahalgam. For the first time in decades, Jammu folks flocked to walk the dry Chenab bed and post Instagram pictures. Pakistani authorities reacted nervously, fearing the worst for their crops and human habitat.

Three months later, it is Geography's turn to turn the tide on geopolitics. As Himachal Pradesh and Punjab experience their strongest monsoon in decades, the reservoirs in the Bhakra, Ranjit Sagar and Pong dams — that give lifesustaining water to all of north India all year round — have filled to capacity, forcing officials to release water into Punjab's three eastern rivers in order to keep the structure of the dam safe. But that's not all. Questions on both sides of the border are now being raised — for example, should officials have not released water from these North Indian dams, which has contributed to flooding on both sides of the border?

Ajnala. Kapurthala. Sultanpur Lodhi. Ferozepur. Kartarpur Sahib. The rollcall of Punjab's towns that seem to be floating these days is giving rise to several memes — among them, "bheegta Punjab," a take-off on "udta Punjab." Flooding is so widespread in the Ferozepur region that it has obliterated familiar markers on the



Radcliffe Line. Parts of the border fencing that divides India from Pakistan has been submerged. As far as the eye can see, water and land have merged with the horizon. It's as if Geography is taking its revenge on History.

Meanwhile, common sense is replacing fury. India may have suspended the IWT, but it has been sending water data to Pakistan via its high commission in Islamabad. That's because India understands its responsibility as an upper riparian state — imagine what would happen if China, the upper riparian in the case of the Brahmaputra, which begins as the Yarlung Tsangpo in Tibet, refused to send water data to lower riparian India? Shudder at the thought.In any case, so much water flows down the Chenab and the Jhelum in Jammu & Kashmir, especially during the monsoon, as much as 136.2 million acre feet (MAF) annually, that the run-of-the-river Baglihar and Kishanganga dams have no option but to allow the water to flow into Pakistan. That is why suspending or holding the IWT in abeyance doesn't mean much on the ground - the water, as is its wont, will flow from the hills to the sea. The hills, in this case, happen to be the Himalayas and the sea, the Arabian Sea. Water disdains maps and treaties and pacts. It will find a way.

A larger question, however, has insinuated itself into the big picture, that of dam storage, rights and responsibilities. Udhampur MP and the influential junior central minister Jitendra Singh has blamed the IWT for denying India permission to desilt its dams on the western

rivers (Chenab, Jhelum). But read the IWT carefully—Singh's contention is only partially correct, as the IWT only prohibits desilting during the monsoons; India is free to desilt at any other time. Moreover, the IWT is silent on desilting dams on the eastern rivers (Sutlej, Ravi and Beas), and as my colleague Lalit Mohan reports from Ropar on the news pages of The Tribune, the Bhakra Nangal dam's carrying capacity has been reduced by 19 per cent because of the accumulation of silt over the decades. In fact, the big story is that the Bhakra dam has never been desilted since it was built in 1963.

f this is true about the Bhakra Nangal on the Sutlej, could it also be true about the Pong and the Ranjit Sagar dams, on the Beas and Ravi rivers, respectively? And if this is true for all three, does it follow that dam officials had to release water from these dams this monsoon — which caused the flooding in Punjab — because they were concerned about protecting the integrity of the dam structure?Let's ask the forbidden question: If these dams had been desilted over the years, would they have been capable of carrying much more water, especially at a time of extraordinary rain as has occurred this monsoon? Meaning, would Punjab's extraordinarily resilient villagers have remained home and dry?Perhaps it's time to pt people front and centre, to treat Nature tenderly, with kid gloves, to separate her from Politics. The rise and fall of dynasties and empires, shapeshifting maps — Nature follows her own rules. Let us respect them.

Climate resilient plan must for Bhubaneshwar

If inclusivity is a serious goal, ease of rectification of the condition and the degree to which normal functions are compromised need to be considered, instead of criteria-based eligibility

A new study has rather alarming projections for Bhubaneswar. An integrated heat and cooling action plan developed for the Odisha capital estimates that, by 2050, 'normal' hot days might turn out to be as bad as heatwave events. While rising heat projections are a global phenomenon, Bhubaneswar is likely to witness the summer maximum temperature soar by 1.5 °C, with heat stress extending to 7-9 hours daily, posing significant health risks and productivity loss. The report also found a peculiar trend of low mortalities during summer (March-July), but higher numbers during August-October when humidity levels jump. While the report by think tank iForest suggests an integrated action plan, what Bhubaneswar actually needs is an urban development ethink. What must agitate the state government is the facthat the capital—now with a population of about 1 million—witnessed unbridled construction activity in the last two decades. In the six years between 2018 and 2024, the city's built-up area grew by almost a quarter and, at the same time, the vegetation cover plunged by a tenth. More importantly, a whopping three-fourths of water bodies



vanished. These factors have contributed to the 'heat island' effect, turning the capital into a boiling cauldron.

Bhubaneswar is among the most liveable cities in the country, but the tag may not remain for long unless urban planning factors in decisive climate action.

Located not far from the coast, Bhubaneswar has borne the brunt of natural calamities. Some of the worst cyclones to hit the state have not only dealt severe blows to the city's infrastructure, but these hazards have also caused significant loss of green cover.

At the core of Bhubaneswar's problems is the regional disparity the state has witnessed in the last several decades. As the biggest urban centre, spread now over 180 sq km, it has seen continuous migration, heaping pressure on housing resources, which in turn attracted huge real estate investmens and consequent unplanned, skewed growth. Much of the damage can be contained if the government revisits the city's comprehensive development plan. The change in land use patterns must be carefully monitored, and no-go areas identified

and strictly adhered to. The capital of a coastal state requires climate-resilient infrastructure, not just housing projects dotting the cityscape. The focus should be on sustainable growth.

These reforms are more like GST 1.2 than 2.0

On September 3, the 56th GST Council meeting, chaired by Union Finance Minister Nirmala Sitharaman, unveiled goods and services tax reforms labelled GST 2.0, which would be effective from September 22.

Listening to the longstanding demand of consumers, the changes collapse the multi-tier tax structure—with rates of 0, 5, 12, 18 and 28—into a dual-slab model of 5 percent for essentials like unpacked foodgrains, fresh vegetables and select medicines, and 18 percent for most other goods and services, including electronics, cement, small cars and electric vehicles. A 40 percent rate targets 'sin goods' like tobacco and pan masala.

As the GST system was flawed to begin with, any change to simplify and rationalise it is a welcome step. But the question one has to ask here is, is it sufficient?India expects a 7.8 percent real GDP growth in the first quarter of 2025-26, painting an optimistic picture. But it masks deep economic challenges as GDP as a metric fails to capture rising inequality, weak consumer demand and high unemployment. For nearly a decade, sluggish consumer demand has plagued India. This is evident in the latest numbers available for some bellwether industries—urban consumer goods growth slowed to 2.6 percent during January-March 2025, passenger car sales dropped 1.4 the next quarter, and two-wheeler sales shrank 6.48 percent in July over comparable periods in 2024.

The International Labour Organisation's 2024 report revealed 83 percent of India's unemployed are young (aged 15-29), underscoring the crisis. One of the major reasons for low consumption is increased inequality, as it reduces money in the common man's hand and transfers it to the super rich. As per

an Oxfam report from the same year, the richest 21 people in India hold as much wealth as the bottom 70 crore people put together.

As Adam Smith identified many centuries earlier, one of the major reasons for high inequality is taxation policy. Indirect taxes—which are levied on the rich and poor alike—such as GST and excise comprise about half of revenues. In contrast, it's a third for the Organisation of Economic Cooperation and Development countries. The Indian incidence disproportionately burdens the poor, who spend 22 percent of their income on fuel—the highest share globally—due to 300 percent excise duty hikes since 2014.

The 2025 GST reforms, with a dual-slab model (5 percent for essentials, 18 percent for most goods), offer limited relief but fail to address fuel duties. This regressive taxation stems from offsetting corporate tax cuts (35 percent to 22 percent), costing ?2 lakh crore, which failed to boost investment, with private gross fixed capital formation at an 11-year low of 32.4 percent in 2023-24, down from 40 percent in 2015.

The Oxfam report shows the top 1 percent hold 40.1 percent of wealth, draining resources from 70 crore poorer citizens. To revive demand, the government must reduce fuel excise duties and reconsider corporate tax cuts, as lower oil prices would ease costs across goods, spurring consumption and economic recovery. Though the latest changes are hailed as a revolutionary reform, more anomalies remain in the GST rates for items, revealing inequities and irrationality. Ultra-luxury items like polished diamonds enjoy nil tax under specific schemes, boosting a ?1.2-lakh-crore sector, while processed agricultural

products—crucial for reducing 30 percent produce waste worth ?92,651 crore a year—face 18 percent GST, stifling Tamil Nadu's 70 lakh farmers. Zerorating these could boost farmer incomes by 20-25 percent, per the Indian Council of Agricultural Research

The textile sector, employing 4.5 crore nationally and 1 crore in Tamil Nadu, faces 18 percent on garments above ?2,500, undermining



competitiveness amid 50 percent US tariffs and a 10 percent export decline in 2023.

While 33 lifesaving drugs are now exempt, diagnostic kits and medical devices, at 5-18 percent, burden Tamil Nadu's healthcare system that serves 7.8 crore people, hampering affordability and access. These disparities highlight the reforms' failure to support critical sectors and state economies.

The latest reforms failed to democratise the GST Council, where the Centre holds 33 percent of the

total votes and each state, irrespective of their size or economic output, have 2 percent. With each resolution requiring 75 percent votes to pass, passing any resolution without the consensus of the Union government has become impossible.

Only four states—Tamil Nadu, Karnataka, Telangana and Maharashtra—contribute about 50 percent of total GST collection, but have only 8 percent of the GST Council votes; they cannot,

therefore, pass any resolution on their own.

A lack of consultation can also be evinced from the half-backed rollout of GST 2.0. The states were not fully consulted about the resulting loss of revenue and how it would be offset. The ideal step would have been for the Union government to work on a financial model to see the range of revenue losses for each state, and discuss with them on offsetting their losses. This affects industrialised states like Tamil Nadu, which could lose potentially ?6,000-15,000 crore revenue for the next fiscal year. So high net GST-contributing states would now face lower

GST revenue.

In order to compensate for the sudden revenue loss for states, the Union government should consider extending the compensatory cess that can undo the partial loss of revenue. Though the Finance Commission has recommended 42 percent of the revenue from divisible pool to be divided among states, only 31 percent is devolved with the states, simply because of very high cess and surcharge (which constitute the non-divisible pool) of 23 percent.

UP syncs rules for stray dogs with Supreme Court's order

In the wake of the Supreme Court judgment revising its earlier order on stray-dog management, the Uttar Pradesh government has issued fresh guidelines for the management of stray dogs following an increase in incidents of dog bites and human-animal conflicts.

The state's Urban Development Department released an updated circular with stringent measures that formalise designated feeding zones, strengthen Animal Birth Control (ABC) programmes and set up local conflictresolution mechanisms.

According to the government, the circular, informed by directives from Chief Minister Yogi Adityanath and aligned with Supreme Court mandates and the Prevention of Cruelty to Animals Act, 1960, outlines a multi-faceted

The Supreme Court had drawn nationwide attention after a two-judge bench on August 11 ordered the removal of street dogs from the Delhi-National Capital Region within six to eight weeks and placed them in shelters permanently.

That order provoked a backlash from animalwelfare groups and prompted a three-judge bench on August 22 to modify the stance.

The revised ruling allows non-rabid, nonaggressive sterilised and vaccinated dogs to be returned to their original localities, while prohibiting unregulated public feeding, requiring designated feeding zones, and urging the formulation of a uniform national policy. It also warned that obstruction of municipal dogcatching operations could attract contempt proceedings.

ABVP deadline nears, bulldozers at SRMU

Lucknow .(Agency)

Hours before the ABVP's 48-hour deadline to the Uttar Pradesh government came to an end on Saturday, the Barabanki district administration demolished a building on the campus of Shri Ramswaroop Memorial University (SMRU), saying it was illegally constructed on a government land.

The demolition of the 'illegal structure' on the campus was among the four demands of the ABVP, which has been protesting since last Monday's police lathicharge on students protesting over the invalidity of the law degree of the SRMU that left several of its members injured

Late Saturday afternoon, a joint team from the district administration and police reached the SRMU campus with bulldozers and removed the portion identified as an encroachment. A heavy police force was deployed both inside and outside the campus.

"A demolition drive was carried out, and the portion found built on government land was removed," said Barabanki Additional

Superintende Tripathi added that in connection with the September 1 violence on the campus, police have arrested two more persons, taking the total number of arrests to four. All four are outsiders, said police. The ABVP had earlier alleged that outsiders were involved in the violence on SRMU campus that led to brutal police lathicharge on student during demonstrations over the "validity" of certain law degrees issued by the university. The ABVP later released a list of students it claimed were hurt, along with video clips purportedly showing police chasing students and beating them with canes.nt of Police Vikas Chandra Tripathi.

Schools across Punjab have been closed since August 27 due to heavy rains and floods. Punjab is facing the worst floods in the past three decades, with at least 43 deaths until now.

Announcing the decision to reopen schools, colleges and universities, Bains wrote on X: "All government, private, and aided schools, colleges, and universities in the state will reopen as usual from tomorrow (Monday). If any school or college is affected by floods, the decision to close it will be made by the respective district's Deputy Commissioner."

"It will be mandatory for the management of private schools to ensure that the school building and classrooms are completely safe to guarantee

PM Modi To Visit Flood-Hit Punjab On Tuesday To Review **Relief Measures**

Agency New Delhi.

Prime Minister Narendra Modi will visit Punjab on September 9 to take stock of the flood devastation that has hit several parts of the state. Punjab is facing one of its worst floods in decades, with the Sutlej, Beas, and Ravi and several seasonal rivulets in spate due to heavy rain across north India. The Centre has assured that Punjab "will not be left alone in this crisis" and is working on shortterm, medium-term and long-term plans to help farmers recover.

During his visit, the Prime Minister is expected to focus on urgent issues like silt removal from fields, preventing the outbreak of diseases and ensuring the safe disposal of dead animals once floodwaters recede.

Officials said the Centre and the state government will work together on ground-level relief and rehabilitation.Strengthening of embankments along the Sutlej, Beas, Ravi and Ghaggar rivers many of which have weakened over the years due to illegal mining - is also likely to be on the Prime Minister's agenda.

Officials on Saturday said that 46 people have died due to the devastating floods in Punjab.

The highest number of deaths has been reported from Hoshiarpur and Amritsar (seven each), followed by Pathankot (six), Barnala (five), Ludhiana and Bathinda (four each), Mansa (three), Gurdaspur, Rupnagar and SAS Nagar (two each), while one death each has been reported from Patiala, Sangrur, Fazilka and Ferozepur. The floods have also damaged crops on 1.75 lakh hectares of land and impacted about four lakh people in 1,996 villages across 23

Delhi: Boy reaches police station with knife lodged in chest, 3 juveniles held

On Thursday afternoon, a 15-year-old boy arrived at the Paharganj police station with a knife lodged in his chest. A student of a school in Central Delhi, the boy said he was stabbed by three of his schoolmates near the school gate. He was soon rushed to Kalawati Saran Hospital and later referred to Ram Manohar Lohia Hospital, where he was operated upon and the knife was removed. The next evening, three of the boy's schoolmates were apprehended in a case of revenge attack,

police said. According to the boy, the three accused had confronted him at the school gate. "They argued and one of the accused threatened to kill the boy with a broken beer bottle... Then while another accused stabbed him, the others

restrained him," an officer said. Police said an inquiry revealed that about 10-15 days ago, one of the accused had been beaten up by some boys. "He suspected that the victim had instigated and sent those boys to assault him. To take revenge, the three juveniles confronted him at the school gate," DCP (Central) Nidhin Valsan said.

A case of attempt to murder was lodged under Bharatiya Nyaya Sanhita. The three — aged 15 and 16 — were also booked under Arms Act. Following this, they were apprehended and the knife used in the stabbing and the broken beer bottle were recovered, police

Displaced by Yamuna floods, families struggle in makeshift camps along Delhi-Meerut Expressway

More than 70 families displaced by the Yamuna floods are living in makeshift tents along the Delhi-Meerut Expressway near Akshardham, struggling to survive amid harsh conditions. Forced to abandon their jhuggis and kuccha homes, they now face daily challenges in tarpaulin shelters. Sitting outside her tent, Ganga Devi said, "It is either demolition, or rain and now the flood. We hardly earn Rs 300-400 a day cleaning Delhi's garbage. Where will we go now?"

Inside 6x8 tents, clothes hang damp, refusing to dry in the rain. Kamlesh Kumar comforted his son, saying, "Only a couple of clothes are left and that's what we wear." Meena Kumari, a mother of three, added, "At night, when one child moves, the others wake up. We cook outside, but everything gets soaked."

The camp runs parallel to the



expressway, raising safety concerns. "We fear our children may run towards the highway. Who will stop a speeding truck?" said elderly Kapu Mukhiya.

Education has collapsed, with most children wandering or helping parents. Women cook lentils and rice

on open stoves with limited relief rations. Ram Kumar, once a flower seller, said, "Mosquitoes bite, rain leaks in and we cannot lock our tents." Officials said the Yamuna level stood at 206.47m, above the evacuation threshold of 206m, with agencies on

'Lawyers have no right to strike as per SC': Bar Council of India urges Delhi lawyers to recall strike call

The strike had been called off after the Delhi Police Commissioner's office had issued a statement saying that "the Union Home Minister would meet the representatives of the Bar to discuss the issue with an open mind"

The Bar Council of India (BCI) on Saturday urged the coordination committee of all district court bar associations of Delhi to defer or recall its indefinite strike call from September 8 in protest against L-G V K Saxena's August 13 notification allowing police personnel to give evidence to courts from police stations via video conferencing.

The Hon'ble Supreme Court, as we all know, has held that lawyers have no right to strike or call for a boycott of courts. Only the Bar Councils, as the statutory bodies under the Advocates Act, are entrusted with the authority to regulate the conduct of advocates, and therefore any collective abstention undertaken without their sanction from State Bar Councils may lack legitimacy and risk weakening the credibility of the

profession itself," a circular issued by the BCI read.

"...repeated abstentions from work are causing grave hardship to litigants, including undertrial prisoners and victims of crime, and also to those advocates who are eager to discharge their professional duties in Delhi Courts," it added while urging the members of the Coordination Committee to hold a joint meeting with the BCI and the State Bar Council of Delhi on Monday.

Last month, the Coordination Committee - representative of Delhi's lawyers – had gone on strike for six days against the August 13 notification. The strike had been called off after the Delhi Police Commissioner's office had issued a statement saying that "the Union Home Minister would meet the representatives of the Bar to discuss the issue with an



open mind".

However, in a circular dated September 4, the office of Police Commissioner Satish Golcha said that as per a Delhi High Court notification on August 4, designated places for recording evidence include prisons, forensic departments, prosecution offices, and police stations.

Opposing this, the Coordination Committee issued a circular stating that there will be a "complete indefinite abstention from work in all district courts of Delhi from Monday... and there shall also be agitation in a more intensified manner against the arbitrary and illegal notification".

dvocate Tarun Rana, secretary of the New Delhi Bar Association, said, "After this (new circular), I am more firm - either the genuine demand of lawyers in the interest of the public is fulfilled or we will continue our agitation in a more intensified manner.""If the BCI wanted to have a meeting, it could have done it before Monday. I urge all lawyers to stay strong. In my 33 years of experience, no justice can be done on video conferencing when it comes to presenting evidence," advocate Dhir Singh Kasana added.

Six rescued from blaze at shopping complex in central Delhi's Pahargani

Six people were rescued from a midnight fire that broke out inside a wholesale shopping complex in Central Delhi's Pahargani on Friday, police said. All the rescued individuals were taken to a nearby hospital for medical examination, and no major injuries were reported, officers added.

Police said a PCR call regarding the fire was received at the Pahargani police station around 2.06 am. Officers rushed to the scene at E Block of the flatted factory complex in Jhandewalan. Seven fire tenders were deployed to contain the blaze.

'The building is a wholesale shopping complex, which usually closes around 10.30 pm. However, on the intervening night of Friday and Saturday, due to urgent parcel work, five employees were working late. The workers were trapped on the upper floors, along with the night guard, when the fire broke out.

According to the night guard's statement, the fire originated near the exit gate of the building, which blocked the passage and left the six of them trapped inside. The blaze started on the ground floor, and dense smoke soon engulfed the premises," said DCP Central, Nidhin Valsan.

A preliminary inquiry suggests the fire was triggered by an electrical short circuit, officers said. Those rescued were identified as Sagar (40), Santosh (45), Aniruddh (51), Chhotu (18), Dev (22), and Sunny. Police said two officers lifted a heavy stone and smashed through an iron grill at the rear of the building, creating an opening through which the night guard was pulled to safety. The remaining five workers were brought down with the help of fire services and evacuated from the complex, officers added.

BCCI doubles revenue, adds Rs 14,627 crore in 5 years: Report

The Indian Cricket Board (BCCI) might be going through some temporary sponsorship trouble, but it has steadily strengthened its coffers by Rs 14,627 crore over the past five vears, reported Cricbuzz on Saturday. The report states that in 2023–24 alone, the board made Rs 4,193 crore, taking its cash and bank balance to Rs 20,686 crore. The rise, recorded after disbursing all dues to state units, has seen the general fund almost double from Rs 3,906 crore in 2019 to Rs 7,988 crore in 2024, as per the figures shared with state associations. The Indian Cricket Board is one of the most powerful sporting organisations in the world and takes on the massive task of sustaining the cricketing ecosystem in the country. The BCCI in recent years has started focusing on a lot of youth tournaments to provide overseas exposure for youngsters. According to the



report, the statement of accounts submitted at the 2024 AGM reads: "Honorary Secretary apprised the members that since 2019, the cash and bank balance of BCCI has increased from Rs 6,059 crore, which was before disbursing any amount to the state cricket associations, to Rs 20,686 crore, which is after disbursing all amounts owed to the state cricket associations.

Therefore, since 2019, BCCI has added Rs 14,627 crore in the last five years. This is an increase of Rs 4,193 crore since the last financial year. Further, since 2019, the general fund too has increased from Rs 3,906 crore to Rs 7,988 crore, which is an increase of Rs 4,082 crore."It further stated that the BCCI continues to set aside huge sums for tax liabilities, provisioning Rs 3,150 crore for FY 2023–24 while contesting the matter in courts and tribunals."The BCCI has provisioned Rs 3,150 crore towards income tax obligations for FY 2023-24. While BCCI is on the right track before the courts and tribunals, it has still made provisions towards paying any obligations that may arise towards tax," said the report.

Pakistan to start WTC 2025-27 cycle with two-match series against South

Pakistan will host South Africa in their opening series of the World Test Championship (WTC)2025-27. Faisalabad is set to host its first ODI in 17 years, marking a significant return of international cricket to the city.

Pakistan cricket team will begin their campaign in the World Test Championship (WTC) cycle 2025-27 against the defending champions South Africa. It will mark the first series for the Proteas in Pakistan since 2021, where they were whitewashed 2-0 under the leadership of Quinton de Kock.

After the two Tests, the two teams will also lock horns in a three-match T20I series and an ODI series of as many matches. The Test series will begin on October 12 with the two matches being hosted in Lahore and



Rawalpindi, respectively. The three T20Is will be played from October 28 in Rawapindi, with the remaining two matches

to be played in Lahore. On the other hand, all three ODIs will be played from November 4 at Iqbal Stadium in Faisalabad, which is set to

host its first 50-over international in 17 years, with the last one being against Bangladesh in April 2008. We are looking forward to welcome South Africa for the opening series of our ICC World Test Championship 2025-27 campaign. The return of ODI cricket to Faisalabad after 17 years is a special moment. Iqbal Stadium holds a proud place in our cricketing history and we are excited to bring international cricket back to this part of the country," said PCB Chief Operating Officer Sumair Ahmed Syed while announcing the series schedule.Apart from South Africa, Pakistan will also host West Indies and Australia at home in the WTC Cycle 2025-27. They will also travel overseas to play against Bangladesh, West Indies and England. Pakistan will aim to start their campaign on a winning note, having finally ended their 11-match winless streak at home by beating England 2-1 in October

2024. They further drew level 1-1 against the West Indies in January, earlier this year.

Jitesh's best innings came against Lucknow Super Giants (LSG), as his breathtaking 85* (33) helped RCB chase down 228 in just 18.4 overs and finish in the top two of the points table.

He last played for India in January 2024 against Afghanistan and has scored 100 runs from seven T20Is so far. On the other hand, Samson was seen in sensational form in the recent Kerala Cricket League, scoring 368 runs from five innings at an average of 73.60 and a breathtaking strike rate of 186.80. The 30-year-old has had a prolific run in T20Is after being promoted to open the innings by captain Suryakumar Yadav in the series against Bangladesh in October 2024. Samson has slammed three centuries from 12 innings since then, scoring 417 runs at an average of 37.90 with

three centuries to his name. However, with Gill coming back into the fray, he will have to wait for his opportunity.

It was a win where the team shed its doubts and a good amount of rustiness, playing with a panache not seen in recent months.China was surprised-not just by the ferocity of the attacks, but by India's control. India had China in a stranglehold. Gone was the one-dimensional play that India usually got stuck in. With fans cheering their every move, India



played with velvet feet; the ball fizzing around, enjoying itself, as Indian sticks turned and swirled, the touches giving the game a surreal feeling. If China believed India would turn up and play the usual game—struggling at the back, misfiring in the middle, and missing chances upfront—their coaches need to take the blame for that. Craig Fulton, on the other hand, reshuffled the deck and came out with a whole new deal. Unlike the game against Malaysia, Abhishek was allowed to move into the striking circle, and Shilanand Lakra played a supporting role from the middle and top of the circle. The midfield opened outwards and not so much through the middle. The back line moved up from the flanks,

held, and rotated, avoiding mis-passes that could have turned into counterattacks. What China prepared for didn't happen. Neither did their bench have any ideas that could have stopped the free-fall, cutting off the lines that fed the Indian forwards constantly. Modern hockey may be about player intelligence and on-field flexibility, but it is also heavily dependent on what the bench dictates. A new China-led Axis thanks to Donald Trump

What we have witnessed in recent days in Tianjin and then China's 'Victory Parade' in Beijing this week is nothing short of momentous. As nations struggle and pivot around to realign to a new axis, these are watershed moments perhaps not seen since the dramatic Bandung Declaration of 1955. It was in Bandung, Indonesia 70 years ago, when 29 Asian and African developing countries laid the foundation of the Non-Aligned Movement (NAM) advocating political and economic independence of nations from the Cold War power blocs. For this dramatic shift in geopolitics, we have to thank none other than Donald Trump. Unleashing a tariff assault across the globe, and threatening foes and friends alike, he has rejuggled the dominoes and opened a large window of opportunity for China to lead a new anti-US axis.

Attempting to force India and others to queue up behind his 'America-first' doctrine, it is Trump who has triggered a new movement of self respect among nations. Admitting to shooting himself in the foot, Trump said on Truth Social on Friday: "Looks like we've lost India and Russia to deepest, darkest, China. May they have a long and prosperous future together." Tianjin and Beijing

The Shanghai Cooperation Organization (SCO) floated by China in 1996 as a security bloc dubbed the 'Shanghai Five' has always been a nondescript set-up. It was initially formed in 1996 to settle post-colonial border disputes between Russia, China, Kazakhstan, Kyrgyzstan and Tajikistan. Trump has just breathed life into this regional bloc as nervous nations look for alternative markets after the hammer blows of the US new tariff regime kicked in. When the last session of the SCO was held in July 2024, Prime Minister Modi opted out on the pretext of a Parliament session at home. It was a snub to the Chinese at a time when India had declared itself to be the US' card against Chinese domination. With the additional 'Russian oil' tariff of 50% kicking in from 27 August, India is now looking to mend fences with China as its opts for a more multi-polar foreign policy. No wonder Narendra Modi went scurrying to Tianjin.

The SCO platform has thus served as an important platform for the new found allies to send out their varying signals. For India, the hand-holding bonhomie displayed by India's PM towards Vladimir Putin was a clear signal India will assert its right to buy Russian oil and arms if it comes cheaper than

GST reforms: Two-wheeler sales may grow 5-6%; PVs likely to see modest 2-3%

Two-wheeler sales are expected to grow by 5-6 per cent this fiscal, aided by the GST Council's recent tax rationalisation, according to a report by Crisil Ratings.Passenger vehicles (PVs) are forecast to see a modest 2-3 per cent rise. As per news agency ANI, Crisil said the rate reduction would lift demand in the auto sector, which has been under pressure in recent months. Two-wheelers and PVs, together accounting for nearly 90 per cent of industry volumes,

are expected to see demand increase by 200 basis points and 100 basis points, respectively. Sales in the two-wheeler segment had slowed in the first quarter due to the impact of new On-Board Diagnostics II norms and weak rural demand following the early and intense monsoon. For PVs, affordability issues and purchase delays had weighed on sales."With the GST cut fully passed on, vehicle prices are expected to drop 5-10 per cent (Rs 30,000-60,000 on small PVs; Rs 3,000-7,000 on two-wheelers). GST Reforms To Boost Global Capability Centers' Growth In India: Report

The GST reforms will directly bolster global capability centres' (GCCs) operations in India -- not just with tax adjustments but also helping them with enhanced global competitiveness, cost structures and cash flows, a report said on Sunday. The 56th GST Council meeting has delivered one of the most sweeping tax overhauls since 2017. Earlier, services by GCCs to overseas affiliates often faced the risk of "intermediary" classification, leading to disputes, GST taxability on services and denial of export benefits,

according to the report by Grant Thornton Bharat. With the omission of Section 13(8)(b) of the IGST Act, place of supply for such services will now be determined by location of the recipient. This ensures that the services delivered abroad are treated as exports, eligible



report informed. The amendment will lead to greater certainty, competitiveness and may grant relief from prolonged litigation. Further, it will also provide new avenues for growth by transitioning intermediary functions to the Indian GCCs, The Council has revised GST rates on several goods and services. Reduction in rates on air conditioners, monitors

and increase in rates on passenger transport /renting of motor vehicles and air transport services (except for economy class).

"For GCCs, this translates ito both a positive as well as negative impact depending on the nature of goods/

services procured along with the eligibility of ITC," the report mentioned. Provisions related to sanctioning of 90 per cent refund on provisional basis were already present; however, due to manual interventions, the implementation was not effective. "With the proposed risk-based identification and evaluation of refund claims through system, it may enable effective implementation of the above provisions. This provision and

process will be operationalised from November 1, 2025. Faster, risk-based refunds will ease working capital pressure and improve cash flow predictability," the report noted.

The rise of Global Capability Centers (GCCs) and IT parks in Tier 2 and 3 cities is emerging as a major growth driver for the real estate sector, with developers and consultancy firms anticipating a sharp surge in both residential and commercial demand. In South India alone, developers expect a 15-20% annual growth in residential real estate over the next few years.Junaith Babu, COO of Chennai-based developer G Square, said: "We expect 15-20% annual growth in residential real estate demand across leading Tier 2 and 3 hubs in South India. The emergence of IT parks and GCCs has created a ripple effect, generating jobs that drive both residential and commercial real estate demand. Demand for plotted developments is particularly strong, often delivering 20-25% annual price appreciation in high-demand corridors like Coimbatore's Saravanampatti and Trichy's Panjapur."



According to Peush Jain, MD, Commercial Leasing & Advisory, Anarock Group, over 200 GCCs have already created demand for more than ?30,000 crore worth of commercial real estate. "Cities like Jaipur, Indore, and Coimbatore are emerging as attractive destinations since prices are 20-40% lower, while offering better chances of retaining talent," he said.Urvisha Jagasheth, assistant vicepresident, research, Knight Frank India, added: "The entry of IT parks and GCCs has positioned Tier 2 and 3 cities as new growth engines for real estate. These locations are benefiting from improved connectivity, cost arbitrage, and a large skilled talent pool. Developers are actively acquiring land and launching projects to capture this wave of corporate migration."In South India, GCCs are heavily concentrated in Coimbatore, Kochi, Thiruvananthapuram, Mysuru, and Visakhapatnam, each hosting more than 20

Desperate to raise consumption in the economy, Union finance minister Nirmala Sitharaman said that while the relief in income tax this year left more money in the hands of common people, the GST rejig will allow for greater spending, making things more affordable.

Calling the landmark GST overhaul a 'people's reform', Finance Minister Nirmala Sitharaman on Saturday said that rationalisation of rates for a wide swath of products will benefit every family, boost consumption, and bolster the economy. In an interview to PTI, the Finance Minister said she will personally monitor passing on of goods and services tax (GST) rate cuts in the form of price reduction but hastened to add that industry has shown

positivity towards such cuts.

Within days of the decision, from car makers to public sector insurance companies and shoe and apparel brands have already announced significant price cuts and the rest are likely to follow suit by the time new GST rates are implemented, she said. Nearly 400 products - from soaps to cars, shampoos to tractors and air conditioners - will cost less when the rejig of the GST is effective from the first day of Navaratri on September 22. Premium paid on individual health and life insurance will be taxfree. A third rate of 40 per cent has been earmarked for a small list of sin goods and ultra-luxury items.

This is a reform which touches the lives of all 140 crore people. There is no individual in this country who is untouched by GST. The poorest of the poor also have something small that they buy, touched by GST," she said. Starting September 22, the GST slab structure will change – 5 per cent for common use goods and 18 per cent for everything else. The

existing slab of 12 and 28 per cent rates have been done away with. In the revamped GST structure, most daily food and grocery items will fall under the 5 per cent GST slab with bread, milk and paneer



attracting no tax at all. Sitharaman said the reform – the single biggest since the 2017 rollout of the one-nation, one tax regime – has been carried out with a focus on the common man. Every tax on daily use items has gone through a rigorous review and in most cases the rates have come down drastically. While the significant relief in income tax that she gave in her Budget in February this year left more money in the hands of common people,

"People do understand for example, Rs 100 with which they go to the shop to buy a thing. Today, the same Rs 100 they can buy one and a half of the commodity. Earlier, they bought one," she said. So this rate reduction is going to bring down monthly household ration and medical bills, as well as help aspirational buying like upgrading from car, replacing white goods like refrigerator or washing machine."There is not going to be one family which is going to be without this positive impact of the GST touching them... 140 crore people are going to benefit from this in one way or the other. So this will boost consumption, and as a result, I think the virtuous cycle will start," she said. Asked about monitoring mechanism for ensuring passing on of GST rate cut benefit, Sitharaman said the ministry has been talking with industry and trade. "They've all come out openly to


