Odisha Police seek financial Rahul Gandhi

The Jharsuguda Police has issued a notice to the Rajiv Gandhi Foundation (RGF) seeking detailed records of foreign contributions and financial transactions, in connection with a case filed earlier this year against Congress leader Rahul Gandhi over his alleged "antinational remarks." According to officials, the notice was issued under Section 94 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, directing RGF Finance Director Sandeep Anand to appear before the investigating officer on November 4.In a letter to the RGF's director, Sandeep Anand, on September 3, Jharsuguda Sub-Divisional Police Officer (SDPO) and Investigation Officer in the case, Umashankar Singh, has sought a year-wise break-up of the foreign contribution received by the foundation since June

The notice said, "How much foreign contribution Rajiv Gandhi Foundation has received since its inception i.e. June 21, 1991. Provide the details in year wise till date. Provide the details of the bank accounts in which the foreign contributions are deposited."The foundation has been asked to provide year-wise foreign contribution details since 1991, bank account information, auditor names, its FCRA licence, and clarifications on alleged donations from Zakir Naik in 2011 and the Chinese government in 2005-06. The notice reads, "Provide the detailed name with alias and addresses (both Temp. and Permanent) with parentage, age, mobile number of the Authorized Signatory of those bank accounts. Provide the name/address/mobile number of Auditor of Rajiv Gandhi Foundation. Provide the true copy of license under Foreign Contribution Regulation Act (FCRA) of Rajiv Gandhi

Government Keeping "Good Watch" On **Exchange Rates: Nirmala Sitharaman**

Finance Minister Nirmala Sitharaman has said that the government is keeping a 'good watch' on exchange rates, stressing that besides rupee several other currencies have depreciated against the US dollar.

'The rupee slide is largely against the dollar, not against any other currencies. That's also because of the way globally, the dollar has strengthened," she said when asked if the slide of rupee against greenback is a concern."This is not the case only with rupee versus dollar, it's the case with many other currencies versus the dollar. So we are keeping a good watch on this," she told PTI in an interview. The rupee plummeted to a record low and closed at 88.27 against dollar after touching an intra-day low of 88.38 on Friday. The fall came amid concerns over US tariffs, while intervention by the Reserve Bank of India through state-run banks helped limit further losses. The steep tariff of 50 per cent imposed by the US on Indian goods took effect on August 27. The tariffs - among the highest in the world - include a 25 per cent penalty for buying crude oil from Russia.

On August 7, President Donald Trump

administration enforced a 25 per cent tariff on Indian goods, citing India's persistent oil imports from Russia and long-standing trade barriers.

The sectors which are impacted due to high import duties include textiles/ clothing, gems and jewellery, shrimp, leather and footwear, animal products, chemicals, and electrical and



mechanical machinery. Sectors such as pharma, energy products and electronic goods are out of the ambit of these sweeping duties. The US accounted for about 20 per cent of India's USD 437.42 billion worth of goods exports in 2024-25. The US has been the largest trading partner of India since 2021-22.

Congress Parliamentary Party Chairperson Sonia Gandhi has strongly criticised the Modi government over the Rs 72,000-crore 'Holistic Development of Great Nicobar' project, calling it a "planned misadventure" that threatens both the island's fragile ecosystem and the survival of its indigenous tribes. In an article published in The Hindu titled "The making of an ecological disaster in the Nicobar", Gandhi accused the government of insensitively pushing the project through while bypassing constitutional, legal, and environmental safeguards.

"The collective conscience cannot, and must not, stay silent when the very survival of the Shompen and Nicobarese tribes is at stake," she

wrote, urging citizens to oppose what she described as a "travesty of justice" and a "betrayal of national values."Gandhi highlighted that the project would permanently displace the Nicobarese, whose ancestral villages fall within the proposed



development zone. These communities were earlier forced to relocate after the 2004 tsunami and had hoped to return.

The Shompen, a particularly vulnerable tribal group, face an even

greater existential threat, she said.

"The project denotifies a significant part of the Shompen tribal reserve, destroys forest ecosystems where they live, and invites a massive influx of outsiders, isolating the tribe from its ancestral land."Despite policies that require prioritising tribal welfare in such cases, the government has proceeded without consulting the Shompen or the local Tribal Council, she alleged. Ecologically, Gandhi warned that the project would lead to large-scale deforestation, estimating the loss of between 8.5 lakh to as many as 58 lakh trees.



IMT Manesar murder: Ugandan woman's body found on Delhi-Jaipur highway; sexual assault suspected

Two suspects were detained hours after the body of a Ugandan woman was found near IMT Manesar Chowk on Sunday. Police said the body of the woman, believed to be in her 30s, was found in a pool of blood near a slip road on the Delhi-Jaipur highway around 5:30am. Investigators suspect sexual assault preceded the

A forensics team examined the crime scene before the body was sent for postmortem to determine the exact cause of death. Police are examining whether the woman was pushed from a moving vehicle or thrown from the flyover."Further details will be ascertained after the postmortem examination regarding the nature of injuries and the sequence of events," a senior police officer said on Sunday.CCTV footage from the highway and



adjoining areas near IMT Chowk is being analysed to reconstruct the woman's final movements."The suspects are being questioned in detail. At this point, we are not ruling out any angle, including sexual assault, robbery, or a dispute with acquaintances. The exact motive will be established once the investigation progresses," the officer added. Investigators are also working to trace the woman's associates in nearby areas to understand her activities in the days leading to her death.

Pataudi Road riddled with deep craters, commute a nightmare

Noida. (Agency)

Daily commuters are facing severe inconvenience due to deep potholes and craters along Pataudi Road, especially near Sector 89, which has become increasingly difficult to navigate. Although the stretch was resurfaced just last year, heavy truck movement combined with recent rains has left it battered, causing traffic snarls during peak hours. Residents said that despite the road deteriorating further after the monsoon, no repairs have been undertaken. Vehicles are forced to crawl and jostle for space, with damage even seen along the central verge in certain areas. The manhole near Shiv Temple in Harsaru village poses a serious safety hazard as it frequently caves in, increasing the risk of accidents.

Highlighting the poor road quality and lack of drainage planning, residents said the issues were recurring across the city. "The condition is terrible and driving is difficult. The rains only made it worse, and there is no sign of timely repairs. If a road built just last year can deteriorate this badly, it shows how poorly it was executed in the first place," said Rohit Malik, a commuter from Sector 88A.Ratan Lal, a shopkeeper on Pataudi Road, said, "The bottlenecks created by potholes slow down traffic to a crawl. Trucks and trolleys take up most of the road, and smaller vehicles often get stuck in craters. We have seen two-wheelers losing balance while dodging craters." Meanwhile, officials have promised swift action. Nijesh Kumar, executive engineer of MCM, acknowledged the damage

Laid just a year ago, internal roads crumble in Gurgaon's Sector 45, no repairs yet

Hardly one year after internal roads were laid in Sector 45, they have started falling apart. With asphalt peeling off, potholes and craters have appeared on the lanes of 18m roads, and no repairs have been carried out. Residents say poor quality of construction material and a complete lack of accountability have left the stretches in shambles. "Re-surfacing was done in Oct last year, and within months, the asphalt started to come off. Motorists struggle to commute every day, and even pedestrians struggle to walk on the roads safely. Moreover, there is no thermoplastic paint or any kind of marking on speed breakers, making it even more dangerous," said OP Yadav, RWA president of the sector.



Even eight years after the 10m and 12mwide stretches were laid, their recarpeting is still due. Residents pointed out that while the municipal corporation has

prepared an estimate for the recarpeting, it is still stuck in paperwork. "If the work is not taken up heavy monsoon rain this season on priority, it will be pushed further once GRAP restrictions kick in, followed by winter. That means another year of living with broken roads," said Puneet Pahwa, general secretary of the RWA.Residents said that they are resorting to stopgap arrangements by filling potholes with debris. "This is not a permanent solution. Every morning, it takes us twice the usual time to get out of the sector because of the potholes. We

have been flagging the issue, but there is no accountability. This is nothing but a waste of public money," Pahwa added.

Rain washes away pollutants, 1st week of Sept cleanest in Gurgaon in 6 years

heavy monsoon rain this season flooded streets and brought the city to a standstill but also washed away pollutants from the air.Data from Gurgaon's only functioning air quality station - Gwalpahari - recorded the cleanest air quality for the first week of Sept in six years. Average AQI dropped to 47.8 – firmly in the 'good' category.

AQI on Sept 1 was the best, at 39. The week's 'worst' reading was on Sept 6, when 24-hour air quality index touched a high of 59.In 2024, average AQI for the city in the first week of Sept calculated from data from four monitoring stations — was 76 ('satisfactory'). In 2023, it was 167.7,

2018's average AQI was relatively better, at 44, but data was only recorded for three days over the week. Recordkeeping in Gurgaon began only in

Experts said the reason for cleaner air so far this month was simple - 100mm of rainfall on Sept 1, followed by on and off showers in the days after."Rain essentially pressure-washed the city's air. They scrubbed out PM2.5 and PM10 particles, improved visibility and reduced ozone formation by lowering surface temperatures," Shubhansh Tiwari, research associate with the Centre for Science and Environment, said on Sunday.

The week's downpour also reduced

Gurgaon govt schools set to transform education with Al curriculum rollout

Govt schools in Haryana are set to introduce Artificial Intelligence (AI) as part of the regular curriculum from the upcoming academic session. The initiative, led by Haryana education department, will be implemented in phases, starting

with Class 9 students and gradually extending to Classes 10, 11, and 12.According to officials, the AI syllabus will consist of 40 to 45-minute sessions integrated across five subjects. The curriculum is designed to enhance students' creativity, problem-solving abilities, and proficiency with digital tools, preparing them for higher education and future employment in a technologydriven world. Until now, digital education in state-run schools

has largely been limited to basic computer skills such as writing emails, sending messages, and downloading files. With the introduction of AI modules, students will be exposed to more advanced topics,

Ganga silt or broken pumps Water trickles from taps in many Noida sectors

Noida. (Agency)

Despite Noida Authority's announcement of Ganga water supply to sectors 119 and 120 from Sunday and to 7x sectors from Dec, many residents in sectors 71, 52, 119, and 120 faced water shortages. While water tankers were deployed in some areas, the stored water depleted over time.

Officials from the water department said the supply of Ganga water from Haridwar had been inconsistent due to heavy silt, but residents claimed the issue was due to broken water pumps."There was nowater supply in our sector today. People are yearning for every drop of water; this is the condition of Noida currently. About 10,000 people are troubled by water in the area, as 80% of the pumps installed around us

do not have anyone to maintain or take care of them. If they were regularly maintained, the water problem would be solved. We had to call tankers for our daily chores, as Sunday, being a holiday, had a majority of people at home," said Sanjay Shukla, RWA general secretary of Shiv Shakti Apts Sector 71. Misha Singh, RWA general secretary of Shatabdi Vihar, Sector 52, also complained of similar problems in the sector. "We too faced a major water issue in E-3 Shatabdi Vihar, Sector 52. There was merely 15-20 minutes of water supply on Sunday, which was grossly insufficient. The water department itself is unaware of when the supply will be normal. On requesting them to send a tanker, the water department official says, 'We

don't have the facility; you can get a private tanker.' Nor are they giving any time limit for the supply to resume smoothly. How can we be left like this with no accountability from the water department? Where will RWAs have to look.

Ramlila, Durga Puja committees to get 1,200 units of free electricity

New Delhi: As the festival season nears, Chief Minister Rekha Gupta on Saturday announced that the government will provide free 1,200 units of electricity to every Ramlila and Durga Puja committee. The committees will only have to pay 25 per cent of the earlier security deposit for power connections. The CM further announced that during the festivities, a day will be dedicated to honour Prime Minister Narendra Modi, as part of the Seva Pakhwada beginning on September 17 (PM Modi's 75th birthday) and continuing till October 2 (Gandhi Jayanti). Moreover, no objection certificates (NOCs) required from departments such as the DDA, MCD, Delhi Jal Board, Fire Services and others will now be given through a single-window system. "With the Navratri beginning on September 22, large-scale Ramlila performances will be held across Delhi. This reform ensures that all formalities will now be resolved at the district level through the District Magistrate's

office," she said. She also directed officials that during Navratri, as part of the Seva Pakhwada being run by the Delhi Government, activities such as medical camps, cleanliness drives and awareness programmes should be organised at Ramlila venues. Notably, preparations for both Durga Puja and Ramlila have already begun in the city. "Messages on environmental issues and appeals in the interest of the nation should be conveyed before or after performances so that people take home a positive message," she said.

Trump signals tougher stance on Moscow, says ready to launch 'second

NEW YORK/WASHINGTON . (Agency)

US President Donald Trump on Sunday said he is ready to impose the "second phase" of sanctions against Russia. "Yeah, I am," Trump said outside the White House in response to a question if he was prepared to impose additional sanctions on Russia.

Trump's comment came shortly after US Treasury Secretary Scott Bessent said that the Russian economy will "collapse" if Washington and the European Union impose more secondary sanctions on countries that buy crude oil from Moscow. Bessent, in an interview to NBC News, said that President Trump and Vice President J D Vance had a very productive call with President of the European Commission Ursula von der Leyen, who followed up with a call with him on Friday and they discussed what the US and European Union (EU) could do to put more pressure on Russia. The Trump administration has imposed an additional 25 per cent tariff on India for its purchases of Russian oil on top of the 25 per cent reciprocal tariffs announced earlier, bringing the total duties imposed on New Delhi to 50 per cent, with effect from August 27.

Last week, Trump said he put secondary sanctions on India for its purchases of Russian oil, "the largest purchaser outside of China", and indicated that he hasn't done "phase two or phase three yet".

Several of the Trump administration's officials, including Bessent and trade advisor Peter Navarro, have said that India's purchases of Russian oil are financing the Russian war effort in Ukraine.

India has called the tariffs imposed by the US "unjustified and unreasonable". Defending its purchase of Russian crude oil, India has been maintaining that its energy procurement is driven by national interest and market dynamics.

No Bar Can Hold Russia: Defying US Sanctions, Moscow Now Extracts LNG From Arctic And Ships To China

Moscow.(Agency)

Russian President Vladimir Putin's meeting with Chinese leader Xi Jinping has begun to show results. Moscow has pushed ahead with gas supplies from its heavily sanctioned Arctic LNG 2 project, and the second shipment of liquefied natural gas has now reached Beijing. The delivery came just days after both leaders met recently during the Shanghai Cooperation Organisation (SCO) summit.

The latest shipment was confirmed through data seen on Sunday. According to the London Stock Exchange Group (LSEG), which provides detailed shipping, trade and energy flow data through its subsidiary Refinitiv, the Russian vessel Voskhod LNG dropped anchor at the LNG terminal in Tieshan Port in Guangxi, southwest China, before heading south. The tanker was loaded with nearly 150,000 cubic metres of LNG, lifted in July from the Arctic LNG 2 facility located in Gyda, northern Siberia. This delivery marks the second consignment of sanctioned LNG from the project to reach Chinese ports. At the end of August, the tanker Arctic Mulan docked at Beihai LNG terminal, making it the first restricted cargo from Arctic LNG 2 to arrive for end users in China.

The project only began production in December 2023, but supplies have struggled to keep pace due to shortages of ice-class carriers and heavy Western sanctions linked to the war in Ukraine.

Putin's Visit Sets The Stage

The timing of the shipment has drawn attention. Putin's visit to China included SCO engagements and celebrations of wartime victory, highlighting the political weight of the energy partnership.

Arctic LNG 2 is majority-owned by Russia's Novatek, holding 60 percent. It was designed to be one of Russia's largest LNG ventures, with a planned output of 19.8 million metric tonnes per year. Sanctions, however, have cast uncertainty over those ambitions.

Australia's Mushroom Killer Jailed For Life. Can Get Parole After 33 Years

Australia. (Agency)

An Australian judge sentenced convicted killer Erin Patterson on Monday to life in prison with parole after 33 years for killing three people with toxic mushrooms, capping a trial that sparked a global media frenzy.Patterson, 50, was convicted in July of triple murder for serving a poisonous meal to her estranged husband's parents, aunt and uncle during a sumptuous beef Wellington lunch at her home in 2023. Her trial drew podcasters, film crews and true crime fans to a courthouse in the rural town of Morwell, a sedate hamlet in Victoria better known for its prize-winning roses. Audiences from New York to New Delhi followed every twist of what many now simply call the "mushroom murders". The motive of the murders remains a mystery.Patterson was sentenced on Monday morning in Melbourne where Supreme Court Justice Christopher Beale said she had inflicted "trauma" on her victims and their families."Your failure to exhibit any remorse pours salt into all the victims' wounds," he said."The gravity of your offending warrants the imposition of the maximum penalties for your crimes," he said.He sentenced her to life in prison but said she would be eligible for parole after 33 years, when she will be 83 years old. Her legal team had argued she should be given the chance of release after 30 years because the notoriety of her case would mean she will spend most of her prison sentence in isolation. She now has 28 days to appeal both her convictions and her sentence. The Sydney Morning Herald reported that Patterson wore a paisley shirt as the sentence was read out, with her hair tied back. Speaking after the sentence was handed down, Pastor Ian Wilkinson -the only guest to survive the toxic mushroom lunch -thanked those who had supported the family in the aftermath of the murders.

In rare ruling, Israeli Supreme Court says Israel deprives Palestinian prisoners of food

Though the Supreme Court advises on policy legality, Israel's judiciary has rarely challenged government actions during the 23-month Israel-Hamas war.

In a highly rare exercise of wartime legal restraint, Israel's Supreme Court ruled Sunday that the Israeli government has deprived Palestinian detainees of even a minimum subsistence diet and ordered authorities to increase the amount and improve the quality of food served to deprived Palestinian inmates.

Although it's the job of the Supreme Court to advise the government of the legality of its policies, the Israeli judiciary has seldom taken issue with its actions in the 23-month Israel-Hamas war.Since Hamas' Oct. 7,

2023, attack on southern Israel that killed 1,200 people, mostly civilians, Israel has largely rejected growing international criticism of its conduct by arguing that it was doing what was necessary to defeat Hamas.The Israeli army has detained large numbers of Palestinians in Gaza and the occupied West Bank on suspicion of militant ties. Thousands have been released from months of detention in camps and jails without charge to tell of brutal conditions, including overcrowding, scant food supplies, inadequate medical attention and scabies outbreaks. As Israel's highest tier of accountability, the Supreme Court hears complaints from individuals and organizations against Israeli government actions, such as its practice of restricting food and medical supplies to Gaza or, in this case, what two Israeli human rights groups described in their complaint as the security establishment's "systemic policy"

of depriving Palestinian prisoners of food.

The three-judge panel ruled unanimously that
the Israeli government had a legal duty to
provide Palestinian prisoners with three

meals a day to ensure "a basic level of existence" and ordered authorities to fulfill that obligation. In an unexpected 2-1 decision, the court furthermore accepted



the petition filed last year by the Association for Civil Rights in Israel, or ACRI, and the Israeli rights group Gisha, siding with their allegations that the government's deliberate restriction of prisoners' food in Israeli detention facilities has caused Palestinians to suffer malnutrition and starvation during the Israel-Hamas war."We are not speaking

here of comfortable living or luxury, but of the basic conditions of survival as required by law," the ruling said. "Let us not share in the ways of our worst enemies." Palestinian

authorities have recorded the deaths at least 61 Palestinians in Israeli custody since the war started. In March, a 17-year-old Palestinian in Israel prison died of what doctors said was likely starvation. Israeli National Security Minister Itamar Ben-Gvir, who oversees the prison system, boasted last year that he degraded the conditions of security prisoners to the bare minimum required by Israeli law. Ben-Gvir, who leads a small farright ultranationalist party, lashed out at the court ruling Sunday. "Are you

from Israel?" he asked the judges, arguing that while Israeli hostages in Gaza have no one to help them, Israel's Supreme Court defends Hamas "to our disgrace." He vowed the policy of providing prisoners with "the most minimal conditions stipulated by law" would continue unchanged. ACRI called on authorities to implement the verdict immediately.

Australian judge sentences Erin Patterson to life in prison for poisoning relatives with mushrooms

WIELBOURNE. (Agency)

An Australian judge on Monday sentenced triple-murderer Erin Patterson to life in prison with a non-parole period of 33 years for poisoning four of her estranged husband's relatives with death cap mushrooms.

Justice Christopher Beale told the Victoria state Supreme Court that Patterson's crimes involved an enormous betrayal of trust.Patterson was convicted in July of murdering Don and Gail Patterson and Gail's sister, Heather Wilkinson, with a lunch of beef Wellington pastries laced with foraged death cap mushrooms.

Patterson was also convicted of attempting to murder Heather's husband Ian Wilkinson, who spent weeks in a hospital.Patterson's estranged husband, Simon Patterson, was invited but did not attend the July 2023 lunch served to her parents-in-law and her estranged husband's aunt and uncle at her home.

Murderer robbed her children of their grandparents "Your victims were all your relatives by marriage. More than that, they had all been good to you and your children over many years, as you acknowledged in your testimony," Beale said. "Not only did you cut short three lives and cause lasting damage to

Ian Wilkinson's health, thereby devastating extended Patterson and Wilkinson families, you inflicted untold suffering on your own children, whom you robbed of their beloved grandparents," he added.



Both prosecution and defense lawyers had agreed that a life sentence was an appropriate punishment for the 50-year-old on three counts of murder and one of attempted murder. But defense lawyers had asked for Patterson to become eligible for parole after serving 30 years. Prosecutors had argued she should never be considered for parole because she did not deserve the court's mercy.

Survivor calls for kindness

Ian Wilkinson did not comment on the sentence but thanked police, prosecutors and health services he'd encountered since the poisonings.

wrong, there are good people and services and systems available to help us recover," he told reporters outside court. "Our lives and the life of our community depends on the kindness of

others. I'd like to encourage everybody to be kind to each other. Finally, I want to say thank you to the many people from across Australia and around the world who through their prayers and messages of support have encouraged us," he added. Beale said Patterson had also intended to kill her husband if he had accepted his invitation to lunch.

She had pretended to have been diagnosed with cancer as a reason to bring them together. She claimed to have wanted advice on how to break the news to her two children, who were not present at the lunch. Beale accepted Ian Wilkinson's account that the guests were served grey plates while Patterson ate from an orange-tan plate. This was to ensure she didn't accidentally eat a poisoned meal, Beale said.

Only triple-killer knows her motivation "Only you know why you committed them (the crimes). I will not be speculating about that matter," the judge told Patterson.

How Donald Trump is weaponizing the government to settle personal scores and pursue his agenda

President Donald Trump, once a casino owner and always a man in search of his next deal, is fond of a poker analogy when sizing up partners and adversaries.

We have much bigger and better cards than they do," he said of China last month. Compared with Canada, he said in June, "we have all the cards. We have every single one." And most famously, he told Ukrainian President Volodymyr Zelenskyy in their Oval Office confrontation earlier this year: "You don't have the cards."The phrase offers a window into the worldview of Trump, who has spent his second stint in the White House amassing cards to deploy in pursuit of his interests. Seven months into his second term, he has accumulated presidential power that he has used against universities, media companies, law firms, and individuals he dislikes. A man who ran for president as an angry victim of a weaponized "deep state" is, in some ways, supercharging government power and training it on his opponents. And the supporters who responded to his complaints about overzealous Democrats aren't recoiling. They're egging him on.

"Weaponizing the state to win the culture war has been essential to their agenda," said David N. Smith, a University of Kansas sociologist who has extensively researched the motivations of Trump voters. "They didn't like it when the state was mobilized to restrain Trump, but they're happy to see the state acting to fight the culture war on their behalf." How Trump has

weaponized the government
Trump began putting the federal government to work for him within hours of taking office in January, and he's been collecting and using power in novel ways ever since. It's a high-velocity push to carry out his political agendas and grudges. This past month, hundreds of federal agents and National Guard troops fanned out across Washington after Trump drew on a never-used law that allows him to take control of law enforcement in the nation's capital. He's threatened similar deployments in other cities run by Democrats, including Baltimore, Chicago, New York and New

He also fired a Federal Reserve governor, pointing to unproven claims of mortgage fraud. Trump, his aides and allies throughout the executive branch have trained the government, or threatened to, on a dizzying array of targets: He threatened to block a stadium plan for the Washington Commanders football team unless it readopted the racial slur it used as a moniker until 2020. He revoked security clearances and tried to block access to government facilities for attorneys at law firms he disfavors.



A decades-long peace vigil outside the White House is dismantled after Trump's order

Law enforcement officials on Sunday removed a peace vigil that had stood outside the White House for more than four decades after President Donald Trump ordered it to be taken down as part of the clearing of homeless encampments in the nation's capital. Philipos Melaku-Bello, a volunteer who has manned the vigil for years, told The Associated Press that the Park Police removed it early Sunday morning. He said officials justified the removal by mislabeling the memorial as a shelter."The difference between an encampment and a vigil is that an encampment is where homeless people live," Melaku-Bello said. "As you can see, I don't have a bed. I have signs and it is covered by the First Amendment right to freedom of speech and freedom of expression."The White House confirmed the removal, telling AP in a statement that the vigil was a "hazard to those visiting the White House and the surrounding areas." Taking down the vigil is the latest in a series



of actions the Trump administration has ordered as part of its federal takeover of policing in the city, which began last month. The White House has defended the intervention as needed to fulfill Trump's executive order on the "beautification" of D.C.Melaku-Bello said he's in touch with attorneys about what he sees as a civil

rights violation. "They're choosing to call a place that is not an encampment an encampment just to fit what is in Trump's agenda of removing the encampments," he said. The vigil was started in 1981 by activist William Thomas to promote nuclear disarmament and an end to global conflicts. It is believed to be the longest

continuous anti-war protest in U.S. history. When Thomas died in 2009, other protesters like Melaku-Bello manned the tiny tent and the banner, which read "Live by the bomb, die by the bomb," around the clock to avoid it being dismantled by authorities. The small but persistent act of protest was brought to Trump's attention during an event a the White House on Friday.Brian Glenn, a correspondent for the conservative network Real America's Voice, told Trump the blue tent was an "eyesore" for those who come to the White House."Just out front of the White House is a blue tent that originally was put there to be an anti-nuclear tent for nuclear arms,' Glenn said. "It's kind of morphed into more of an anti-American, sometimes anti-Trump at many times."Trump, who said he was not aware of it, told his staff: "Take it down. Take it down today, right now."Melaku-Bello said that Glenn spread misinformation when he told the president that the tent had rats and "could be a national security risk.

Railway cops extorting passengers in Mumbai, 13 suspended in 5 months

Over the past five months, 13 Government Railway Police (GRP) personnel, including a Senior Inspector, have been suspended on charges of extorting money from passengers at railway stations across Mumbai in what officers say is an "unprecedented" crackdown against an "organised racket".

Sources told that the racket was found to be operating at railway stations in and around Mumbai, especially those that cater to longdistance trains, such as Mumbai Central, Dadar, Kurla, Bandra Terminus, Borivali, Thane, Kalyan and Panvel. "The targets are mostly long-distance passengers carrying valuables who prefer to avoid registering a complaint," an officer said.

Detailing the modus operandi, sources said the victims are usually passengers found carrying cash or valuables at luggage checking points. "They are told to meet a

senior officer and taken to GRP rooms on platforms that don't have CCTV cameras. There, the passengers are told to prove that the cash or jewellery actually belongs to them," the officer

Then, these passengers are threatened that their valuables would be seized and they would be thrown behind bars. In some cases, they are assaulted, too. The only way out for them is to pay money to these personnel," the officer said.

Of the 13 personnel suspended, action against seven, including the Senior Inspector, was taken after GRP Commissioner Rakesh Kalasagar took charge in May. When contacted by The Indian Express, Kalasagar said, "Strict action will be taken against those indulging in such activities and this menace will not be tolerated. We appeal to citizens to only allow



checking of bags by senior officers in uniform and under CCTV camera surveillance.'

In one such case last month, a Rajasthan-based complainant, travelling with his daughter, was allegedly forced to pay Rs 30,000 from the Rs 31,000 inside his bag at Mumbai Central Railway Station. After reaching Rajasthan, the victim filed a complaint following which an FIR was registered and transferred to Mumbai, leading to the suspension of three constables who are now on the

Railway activists like Sameer Zaveri have also provided details of vulnerable spots without CCTV coverage, including at the Mumbai Central station and others at Dadar and Borivali.

"If passengers are found carrying cash, jewellery, gutkha, lighters or wine bottles (from Goa where prices are cheaper), they are escorted into rooms without CCTV where the extortion is carried out," Zaveri

Highest rainfall was recorded in Suigam, Vav, Bhabhar and Tharad talukas of Banaskantha

district with 303 mm, 127 mm, 117 mm and 100mm rainfall, respectively.

including Banaskantha, Patan, Sabarkantha, Tapi and Vyara in Valsad received 112 mm and 100 mm rainfall, respectively.

Out of the 206 reservoirs of the state, 123 dams are on high alert, while 20 are on alert and 14 are on warning. Currently, 46,7920 MCFT of water is stored in the 203 reservoirs of the state. This is 83.87% of the total storage capacity.

Since June 1, as many as 7,177 people have been shifted to safe places in the state while 1,054 people have been rescued and saved. Currently, 12 National Disaster Response Force (NDRF) and 22 State Disaster Response Force (SDRF) teams have been deployed in various districts in the state.

The 18.4 km elevated stretch, extending from the Kilambakkam bus terminus (KCBT) to Chettipunniyam near the Mahindra City junction, will be built erecting pillars in the central median of GST road. The stretch will include entry and exit ramps at three locations. The project cost is

estimated to cost Rs 3,200 crore.

The Tambaram-Chengalpattu section of GST remains one of the busiest highways in the country throughout the year. During festival days and extended holidays, the section witnesses huge pile-ups stretching up to 3-4 km in both directions. In 2018, the Union Road Transport and Highways Ministry proposed a 30km elevated road from Tambaram to Chengalpattu. However, due to feasibility, traffic, and alignment issues, the project was scaled down to

18.4 km. Official sources said NHAI finalised the detailed project report (DPR) a few months back, but has not yet called for tenders, as the proposed metro line between the airport and Kilambakkam has to be integrated with the entry and exit ramps of the

Last week, the state government gave its final nod for extending the metro line from Chennai Airport to KCBT. To facilitate construction on the busy stretch, NHAI widened an 18.5 km stretch of the four-lane GST road into an eight-lane highway from Vandalur to Chettipunniyam in 2024. The width of the GST road ranges from 35-45m. As per the official documents, the section carries over

75,000 passenger cars per day. For construction purposes, one lane on either side will be utilised, but commuters will still have a six-lane carriageway for smooth traffic flow,"

Despite early start, Ganesh Visarjan in Pune ends after 34 hours

LIKE every year, the Ganesh immersion procession in Pune city dragged on for hours, this time creating a new record of 34 hours after it took off around 9.30am on Saturday on Anant Chaturdashi— the final day of the 10-day Ganeshotsav. The grand colourful procession came to end

with the immersion of Amarjyot Mitra Mandal's idol around 8.15pm on Sunday, said Pune Fire Brigade officials. However, the Pune police said the immersion

procession went on for 32 hours and 26 minutes and concluded around 6pm on Sunday. The procession was held peacefully barring a few exceptions, said the city police.

The time taken by the procession was more than last year's when the immersion procession lasted 28 hours and 45 minutes. In 2023, the Ganesh immersion procession went on for 30 hours and 25 minutes while it concluded after 31 hours in 2022.

As per tradition, the immersion procession started with the rituals of the first manache (prominent) Ganpati—the Kasba Ganpati Ganesh Mandal— around 9.30am on

Saturday, about 45 minutes earlier than last year. A dispute erupted this year after some Ganesh mandals in the city insisted that they would start the immersion procession at 7am, before the five 'Manache Ganpati' (the five prominent ones). These mandals had claimed that major delays are caused by the immersion procession of the five prominent mandals, forcing them to wait on the procession routes till late night.

But with the intervention of Pune MP and Minister of State for Civil Aviation Murlidhar Mohol, BJP MLA Hemant Rasane and police authorities, the dispute was resolved and it was decided that Kasba Ganpati Mandal would start the Ganesh immersion procession.

According to police, the Kasba Ganpati's procession started at 9.34am on Laxmi Road—the main route for immersion procession in the city. Subsequently, the other four Manache Ganpati also joined the procession on Laxmi Road.

Police said the idol of Kasba Ganpati mandal was immersed at Nateshwar ghat at 3.47pm, the Tambdi Jogeshwari mandal (second prominent one) at 4.10pm, Guruji Talim Mandal at 4.34pm, Tulshibaug Ganpati Mandal at 4.58pm and Kesari Wada Ganpati at 5.38pm at Panchaleshwar Ghat. Last year, the "Manache Ganpati" immersion procession lasted till 7.38 pm.

A live performance of Varaha Avatar (third incarnation of the Hindu deity Lord Vishnu) killing the demon Hiranyaksha by Taal Vadya Pathak at Tambdi Jogeshwari mandal was a major attraction of the procession this year. Besides, the thrilling 'Mallakhamb' performance by 'Swa' roopwardhinee at Tulsibaug Ganpati Mandal drew big applause from the crowd.

Like every year, activists of Guruji Talim Mandal spilled huge amounts of Gulal (pink coloured powder) during the

immersion procession. Several dhol tasha pathaks dished out energetic beats on different immersion routes in the city. While the five "Manache Ganpati" have both

ceremonial and historic importance, they

also are also thronged by a huge crowds of devotees. The procession of the famous Shrimant Dagdusheth Halwai Ganesh Mandal began at 3.45pm on Saturday and concluded at 9.23 pm at Panchaleshwar



Ghat the same day.

The immersion procession of Hutatma Babu Genu Mandal concluded at Nateshwar Ghat at 2.25am, Shrimant Bhausaheb Rangari Ganpati Mandal at 2.40am, Akhil Mandai Mandal at 3.28am, and Shri Jilbya

Maruti Mandal Trust at 3.47am at the Panchaleshwar ghat on Sunday.

About the delay in completing the Ganesh immersion procession, Commissioner of Pune Police Amitesh Kumar said, "It was never our priority to finish the immersion procession earlier than last year. Our basic objective was maintaining law and order and ensuring that the procession ends peacefully."

Why Gopichand stands out

In a world of ambiguous scruples and blurring lines between what is wrong and right, talking about ethics and its moral compass may seem like lighting a candle in front of the sun or playing a trumpet to the deaf. Yet, talk we must, especially in the framework of sports and the belief that fair play is its essence and winning or losing are two sides of the same coin. Even if it may be a selfdefeating illusion to divest sports from the larger reality of this world, there is no harm in reminding the vast mass of sports followers in India that we should admire, love and appreciate a role model who follows the principle that the "means used to achieve an end are more important than the end itself''.Remember Pullela Gopichand? The former All-England badminton champion, only the second Indian to achieve this feat after Prakash Padukone, has been the torchbearer of the badminton revolution in India, whose coaching academy in Bengaluru has changed the face of the sport and made India its thriving hub. I remember him for something else, an act that in today's world seems impossible. It is a world where sportspersons (read cricketers) endorse any brand good, bad, ugly — as long as the money earned from advertising it is substantial. At his peak, when he was dominating the international circuit before an injury affected his summit march, he had declined to promote a cola product. We don't know its financial implications but suffice it to say that the money offered must have been tempting, as badminton is no cricket and even its champion players are not pampered with money like cricketers are. Gopi, as he is fondly called, had created a fund of goodwill in the sporting world by an act which in today's ecosystem would be considered vacuous, if not downright stupid. Lost to the world would have been Gopi's strong, sincere intentions of not wanting to wrongly promote a sugar-sweetened drink as bringing health benefits to budding sportspersons. What does Gopi think today of what he did more than two decades ago? He sent this recorded message when I reached out to him: "For me, I just took a stand because it was very personal. I did not drink cola for a very long time. And for me to endorse something which I don't do myself, I felt was not right. It is a very personal decision and it is a very subjective decision... and each one has their own reasons for doing things or not doing something, I don't want to get into that. As far as I am concerned, it is something I just didn't do. I didn't endorse it."Gopi, it should be obvious, felt strongly not to promote something which he believed didn't serve the larger cause of promoting the sport he played, unlike a vast majority of topnotch cricket stars who probably did not even bat an eyelid before endorsing Fantasy leagues and online apps like Dream XI and MyCircle XI.A few years before these "dreams" were to be sold in India, a game called 6UP was launched. All you had to do was predict the score off each ball of an over and if done correctly, you could win double or even triple the amount of money you had bet on it. It caused a debate in the media and in a very critical piece, I highlighted the gambling nature of the socalled "skill" game. This 6UP was being promoted by former Australian captain Steve Waugh, who invited me for lunch at one of Delhi's expensive hotels, The Imperial. For about an hour, Waugh tried to persuade me to change my mind and convince me that predicting the result of a six-ball over is a skill, and not gambling. Waugh was to fund his charity which he launched in Kolkata from the profits to be made from this game, but due to the strong legal challenge and the sports ministry's opposition, 6UP never took off. While 6UP failed, a decade later, the fantasy leagues succeeded in establishing themselves. To circumvent the ban on betting in India, they masqueraded their products as a game of skills. The courts accepted their arguments. A vast army of young and old across India, rural or urban, were now hooked to their mobiles, making their own teams, betting on them, especially during the Indian Premier League, and suffering financial

Floods in Punjab wreak havoc, Modi-XI meet in Tianjin ushers hope

While achievements like India being ready with its indigenously developed Vikram 3201 microchip brought in positivity, denial of bail to Umar Khalid and Sharjeel Imam in the Delhi 2020 riots after spending 5 years in jail raised viable questions about UAPA

After Himachal and Jammu and Kashmir, the rain gods continued to wreak havoc in the villages and towns of Punjab. The incessant flooding obliterated familiar markers on the Radcliffe Line in Ferozepur where parts of the border fencing that divides India from Pakistan have been submerged. It's as if geography is taking its revenge on history, writes Agency in her edit Water will find a way, in India & Pak. The Bhakra dam has never been desilted since it was built in 1963. She has many formidable questions for which people need answers – If this is true about the Bhakra Nangal on the Sutlej, could it also be true about the Pong dam and the Ranjit Sagar dam? Does it follow that the dam officials had to release water from these dams this monsoon — which caused the flooding in Punjab — because they were concerned about protecting the integrity of the dam structure? If these dams had been desilted over the years, would they have been capable of carrying much more water? In their Oped piece Floodwaters expose cracks in Punjab's governance, JNU professor Seema Bathla and Ravi Kiran, Assistant Professor, Government College, Sri Muktsar Sahib, underline the need for a proactive, longterm strategy that addresses the fundamental causes of floods and the need for coordinated efforts between neighbouring states. A review of dam management protocols, a state-wide project for desiltation and a robust farmer-centric crop insurance policy is what they recommend.

In yet another informative article, science commentator Dinesh C Sharma explains in his edit piece Wake-up call on the climate front that the changing monsoon patterns are linked to larger patterns of climate change. Enumerating the solutions, he writes we need to make all our public policies compliant with climate change, review the Environmental Impact Assessment regime and conduct a 'climate audit' of all existing infrastructure - hydel projects, national highways, road and railway bridges, airports — not from a financial perspective but to check if it is climate-resilient. essentially a family feud. It is a truism that all family-run parties face internal power struggles at some point. Kavitha's ambitions were thwarted, in contrast to her brother's fortunes. While KTR was made the party's

working president, she remained a member of the council with no position in the party. The Delhi liquor scam, in which she was jailed, did not help her cause. Following her release, she was not, in her words, allowed to take an active role. The stifling atmosphere and dwindling political capital perhaps turned her into a rebel. In reality, her words and actions are aimed as much against her father, for it is he who is the deciding authority. What could be the political fallout of Kavitha's exit? She is no mass leader to split the party. Floating a new outfit is easier said than done, which leaves her with the option of joining the Congress or the BJP. The danger for BRS is that she could dent its prospects. The more the BRS is weakened, the stronger will be the other opposition

The UGC and a uniform curriculum

Oxford University, Cambridge University and the Imperial College of Science, Technology and Medicine, London, are in close geographical proximity to each other. Yet, each one of them teaches different things in mathematics at the undergraduate level. Also, the emphasis on topics and themes varies from year to year. This allows a great flowering of ideas and activities. Similarly, the Massachusetts Institute of Technology and Harvard University are in close proximity to each other and yet again the emphasis on what they teach and how they teach undergraduate mathematics differs in content, emphasis and flavour. This makes one wonder why the UGC has chosen to micromanage the design of

the mathematics undergraduate curriculum? The UGC would perhaps be better served if it stepped back a little instead of its often well-intentioned but ill-conceived attempts to help bolster academic standards through a sort of prescriptive micromanagement.

It seems that the UGC is prescribing a common syllabus for the study of undergraduate level mathematics for the entire nation. This has been necessitated by the fact that so many of our universities have abysmally low standards. However, this way of tackling the problem has the grave danger of proving to be counterproductive. All undergraduate institutions would end up teaching the same things in the same manner.

The Vizhinjam International Seaport has set a new operational benchmark by handling MSC Virginia, a container vessel with a draft of 16.95 metres - the second-highest draft ever handled in India.

The ship departed for Spain on Sunday morning after completing cargo operations at the port. MSC Virginia had arrived at Vizhinjam from Adani

Prior to this, the highest recorded draft at Vizhinjam was 16.8 metres. So far, 17 vessels with drafts exceeding 16.5 metres have been received at the port.

Vizhinjam's natural depth of 18 to 20 metres is considered a major advantage, and this development further underscores its capability to handle some of the largest container vessels in global maritime trade.

While the Sutlej and Beas systems managed heavy inflows, the Ravi river in particular ran beyond its safe limits-triggering widespread flooding in Gurdaspur, Pathankot, Amritsar and adjoining low-lying

The designed capacity vs the reality

According to a Punjab government report on river de-silting prepared after the 2019 floods, the Sutlej river, which flows for 416 km across the state with an average width of around 1,500 metres, has a designed carrying capacity of two to three lakh cusecs. The Beas, running 136 km with a width of 1,000 metres, also has a capacity in the same range of two to three lakh cusecs. The Ravi, however, is much more modest in scale—222

km long and about 500 metres wide, it can safely handle only 60,000 to one lakh cusecs. Among the smaller systems, the Ghaggar

stretches for 165 km with an average width of 150 metres and capacity of just 31,500 to 42,000 cusecs, while the Chakki rivulet, though only 35 km long and 125 metres wide, is volatile and can take up to 50,000 cusecs. What happened this season

Data from August-end to September 2025, shows that at Hussainiwala headworks, the Sutlej was carrying around 2.8 to upto 3- lakh cusecs at its peak while before Harike, which is the

confluence point of Sutlej and

Beas rivers, its maximum flow was 1.64 lakh cusecs in Yusufpur (Gidderpindi) in Jalandhar. Though this was technically within its upper limit, it exerted tremendous pressure on embankments

Tender process for AIIMS' radiotherapy machine cancelled for 4th time in a row

Agency New Delhi.

For the fourth consecutive time, the tendering process for procuring a linear accelerator machine for radiotherapy at AIIMS' cancer institute has been cancelled, leaving cancer patients who depend on advanced treatment to confront yet another setback.

The procurement process was called off due to technical reasons, officials said. The AIIMS administration has now restarted the tender process. However, it may take several months before the machines are installed and



The latest tender, floated on September 1 this year, aims to procure two linear accelerator machines at an estimated cost of Rs 70 crore. If the process is completed in the coming months, patients would still face a prolonged wait before they benefit from the new equipment, owing to the extensive safety checks and radiation shielding required before the machines can be made functional.

"Setting up and commissioning such equipment takes time because of strict safety protocols. Even after the process is completed, there will be additional delays before patients can access treatment," a senior doctor at the institute said.

The procurement effort is not new. AIIMS first initiated the purchase of such a machine in March 2022, but acquisition could not be completed. Subsequent tenders were issued in January 2024, July 2024 and May 2025, all for the procurement of two machines each.

The accused have been identified as Kuldeep Bidhuri (20), Sandeep Bidhuri (33), Monu Kangar (31), Rohit Bidhuri (24), and Mohan Bidhuri alias Bhura (19), all residents of Tughlakabad; Atul Pandey (30) of Dakshinpuri; and Nitin Pandey (27) of Govindpuri. Anil Kumar

(55), father of accused Nitin Pandey, and Babu (40) of Tughlakabad have also been arrested for harbouring the criminals and criminal conspiracy. This is not an isolated incident but a fallout

Study links capital's rising heat stress to thousands of unrecognised deaths



A new study by Greenpeace India has revealed a troubling link between Delhi's intensifying heat stress and thousands of unrecognised deaths, particularly among the homeless and outdoor workers. The report, "Death and Degree: Establishing a Relationship of Death and Heat in Scorched Delhi," uses the Universal Thermal Climate Index (UTCI) to show how extreme heat has become a silent public health crisis. According to the findings, monsoon months that once

brought relief now register dangerously high humidity and temperature levels. Between 2015 and 2024, June, July, and August consistently recorded UTCI values above 31.5 degrees Celsius, with July 2019 peaking at 34.4 degrees—conditions previously linked only to peak summer. The report highlights a sharp seasonal rise in stress, with March-to-April UTCI levels spiking by over 30 per cent, marking the onset of extreme summer danger. This rise has coincided with a surge in deaths. In 2019 alone, 5,341 unidentified deaths were recorded during months of record heat. From 2022 to 2024, Delhi reported 11,819 such deaths, the highest three-year toll on record. June has emerged as the deadliest month, with 657 deaths in June 2019 at a UTCI of 34.2 degrees. The homeless have been worst hit: in June 2024, 192 homeless people died within just nine days, while July 2024 recorded 401 deaths—the highest monthly toll in two decades."Our analysis shows Delhi's heat crisis is extending well beyond summer into the monsoon, creating a prolonged season of danger. Unless urgent measures are taken to recognise heat as a disaster and safeguard at-risk communities, Delhi will continue to lose lives in silence," said Selomi Garnaik of Greenpeace India.

The Asia Cup 2025 is just two days away as Afghanistan and Hong Kong will get the tournament underway in the curtain raiser fixture on Tuesday, September 9 in Abu Dhabi. The eight-team event will feature the usual big sides from Asia, namely India, Pakistan, Sri Lanka, Afghanistan and Bangladesh. However, apart from them, three more teams will also set out to make a mark against the big five. Oman will make their debut at the mega event in the main stages while Hong Kong and UAE are set for their fifth and fourth appearance respectively.

UAE earned their spot in the continental tournament after emerging victorious in the ACC Men's Premier Cup 2024 by beating Oman by 55 runs in the final. They're coming into the event from tri series against Pakistan and Afghanistan, losing all four of their matches. Captain Muhammad Waseem will have the burden of leading his team against the likes of India and Pakistan in Group A.

On the other hand, Hong Kong sealed their spot in the Asia Cup after winning the third-place playoff against Nepal in the ACC Men's Premier Cup 2024. They're coming into the



tournament after losing against Malaysia in the Asia Pacific Cricket Champions Trophy 2025. They've been placed in Group B alongside Bangladesh, Sri Lanka and

Meanwhile, Oman are coming into the tournament having last played in the ICC Men's Cricket World Cup League 2 2023/24-2027. A runner-up finish at the ACC Men's Premier Cup 2024 sealed their spot in the Asia Cup. They're placed in Group A alongside India, Pakistan and the UAE.

Speaking to the press after the game, Alcaraz revealed that the Wimbledon final is where he decided he



needed to better his game if he is to beat Sinner. Alcaraz said that he took a week off after the Wimbledon final loss and then dedicated two weeks specifically to work on things that would make him better than Sinner."Right after. Right after the match (Wimbledon Final). I thought that I need to prove some things if I want to beat him after the Wimbledon final. I took a week for myself after that. But after that I practised on the specific things that I need to improve to beat Jannik. So two weeks before Cincinnati, I only worked on things that I needed to beat Jannik," Alcaraz said in the post-match press conference.Sinner rued after the match that his game became too predictable against Alcaraz in the US Open final. However, the Spaniard countered that opinion and said that he simply loves watching Sinner play, and came into the

game after watching a lot of his matches. "I wouldn't say I read his game, that he was predictable... I watch a lot of his matches. First of all, because I love watching him play. I think it is unbelievable what he's doing..." Alcaraz said.

Home-Cooked Thalis Get 7-8% Cheaper In August Over **Benign Commodity Prices**

New Delhi.(Agency)

The price of home-cooked vegetarian and nonvegetarian thalis declined 7 per cent and 8 per cent in August (year-on-year), respectively, amid benign commodity prices in India, a report showed on Monday. The decline in the cost of vegetarian thali was led by a sharp drop in prices of onion, potato and pulses, according to Crisil Intelligence. Prices of potato and onion declined 31 per cent and 37 per cent on-year, respectively, on a high base. In the year-ago period, potato production had shrunk 5-7 per cent due to blight infestation and weather changes, pushing up the prices. This year, the production is estimated to be 3-5 per cent higher. For onion, an 18-20 per cent rise in annual production has led to a fall in prices this year. Prices of pulses decline 14 per cent on-year



driven by higher production and stock levels compared with the year-ago period, the report

For potato and onion, the fall in prices was on a high base, while prices of pulses moderated amid higher production. However, an increase in tomato and vegetable oil prices limited the extent of the overall decline in thali costs," said Pushan Sharma, Director, Crisil Intelligence.In the near term, thali prices are likely to remain lower on-year, aided by the high base of vegetables and pulses. The government's decision to allow free imports of yellow pea and black gram is expected to exert downward pressure on pulse prices, Sharma added. The decline in the cost of nonvegetarian thali was driven by 10 per cent on-year drop in broiler prices, which make up about 50 per cent of the cost. Lower vegetable and pulses prices also supported.

ITR Filing 2025: Taxpayers Urged To File ITRs As September 15 Deadline Nears

With the Sept 15 deadline for filing Income Tax Returns for individuals approaching, over 4.56 crore people have filed their ITRs, while the submission of returns is accelerating as the last date nears.

Senior Income Tax Dept. officials are of the view that taxpayers "should not wait till the last-minute" to file their returns, as it leads to inconvenience. The filing of tax returns has been made easy, and the simple process for individuals to file their own returns is as follows: The Income Tax Department notifies different ITR forms each year to suit various categories of taxpayers. Selecting the correct form is essential, as filing in an incorrect form may render the return defective. For FY 2024-25 (AY 2025-26), the following forms are applicable to non-audit taxpayers, including individuals and small entities:ITR-1 (Sahaj) – For Salaried Individuals

A salaried individual, as per the Income Tax Department, is a taxpayer whose income is earned from an employer in the form of salary, wages, allowances, perquisites, or pension and is chargeable under the head "Income from Salary".

ITR-2 - For Individuals/HUFs (No Business/Profession Income)Individuals are natural persons who earn income from salary, pension, house property, capital gains.

Audi India cuts prices by up to Rs 7.8 lakh following GST reforms

CHENNAI.(Agency)

Audi India has announced significant price reductions across its model range, effective from September 22, 2025. These cuts, ranging from Rs 2.6 lakh to over Rs 7.8 lakh, are aimed at passing on the benefits of the recently implemented Goods and Services Tax (GST) 2.0 reforms directly to customers. The move is seen as an effort to make luxury vehicles more accessible to a wider group of Indian consumers. Under the new pricing structure, the entry-level Audi Q3 will now start at Rs 43.07 lakh, reduced from Rs 46.14 lakh, reflecting a price cut of Rs 3.07 lakh. The mid-range Q5 sees a reduction of Rs 4.55 lakh, now priced at Rs 63.75 lakh compared to Rs 68.30 lakh earlier. The larger Q7 SUV has its price cut by Rs 6.15 lakh, bringing the new price to Rs 86.14 lakh from Rs 92.29 lakh. The flagship Q8 SUV has seen the most significant reduction of Rs 7.8 lakh, now available at Rs 1.09 crore instead of the earlier Rs 1.17 crore. Sedan models have also benefited, with the A4 now priced at Rs 46.25 lakh, down from Rs 48.89 lakh, and the A6 available at Rs 63.74 lakh.

down from Rs 67.38 lakh. These price revisions follow the recent GST reform, which introduced a more streamlined tax structure for automobiles. Previously, luxury and larger cars were subject to a combination of 28% GST plus an



additional cess. The new regulation applies a uniform 40% GST slab, effectively lowering the tax burden for high-end vehicles and aligning them more closely with mid-sized massmarket cars. The decision by Audi India comes at a strategic time ahead of the festive season, a traditionally strong sales period for the automobile industry in India. By lowering prices,

Audi aims to attract more customers and boost sales during this highdemand phase. The company believes that the revised pricing will make its luxury offerings more competitive and accessible in an increasingly pricesensitive market. Audi is not alone in

this move; other luxury car manufacturers such as Mercedes-Benz and BMW have also announced similar price cuts in response to the GST overhaul. These industry-wide reductions are expected to intensify competition in the luxury segment and provide customers with a broader range of affordable options. Customers interested in the updated pricing can visit Audi India's official website or authorized dealerships.

The new prices will be applicable for purchases and deliveries from September 22 onwards. This pricing adjustment reinforces Audi India's strategy of offering premium vehicles while responding to regulatory changes and market dynamics, positioning itself strongly in the growing Indian luxury automobile

GST cuts elude detergents, cosmetics; could be inadvertent say analysts, FMCG cos

Keeping detergents and cosmetics under 18 per cent tax rate with zero savings on these daily-use items for households under the government's sweeping GST restructuring move is surprising, say industry players and analysts. The allpowerful GST Council last week decided to reduce taxes on most of the common-use goods as part of the government's measure to boost consumer spending. The new structure of goods and services tax (GST), which comes into effect on September 22, will have two slabs of 5 per cent and 18 per cent instead of the current four slabs of 5, 12, 18 and 28 per cent. Fast-moving consumer goods (FMCG) products such as hair oil, soap, face powders,

shampoos, toothbrushes, and an equally essential item in every toothpaste have come under the lower household, appears to have been slab of 5 per cent from 18 per inadvertently left out."As a basic cent. However along with detergents and cosmetics, duty on several items such as hair dye and household insecticides has not been reduced. FMCG companies say they are ready to pass on the benefits of the duty cuts to consumers, even though they will have to face challenges on the existing stock at retail stores. Industry players as well as experts have also expressed concern over the GST Council's decision not to reduce the duty on essential items such as detergents,

which are available in bar, powder and liquid format. Harpreet Singh, Partner, Deloitte India, told PTI that detergents,

If your strategy is to let both your bosses remain in blissful ignorance about the other, you may be charting dangerous territory. It may not be pleasant to turn down a plum opportunity, but if it clashes with a commitment you've already made to your other boss, honesty really would be the best policy.

Being extremely organised is your bet as a

shared resource. "It is the toughest position to be in since every manager wants full attention and contribution from the individual. The best thing for the individual to do is to set the objectives and role expectations with every manager

they report to. Maintain a list of things to do h and follow up whenever required. Let the otheres managers know if there are any priorities that you are working on, which could potentially delay theirs. It is key that a constant review and discussion is done with all managers to course correct if there are any gaps in their expectations," advises Mukund Menon, director HR and communications, HR and communications, International Paper India.

Salvi warns against showing one boss in bad light to the other in order to gain sympathy, "Being very honest is the most critical part as that would give you credibility. Being solution-oriented would be the next thing as at the end of the day, you are responsible for yourself, so you would need to take that initiative. Third, never ever play one boss against another as remember that they are

your bosses and you never know when they would share notes and also simply, it is not a right thing to do. Fourth, when you can't find a solution pertaining to the bosses, don't be ashamed to approach them and seek their help in finding one.'

Of course, the above tips assume that all managers concerned are willing to make allowances for the employee. In some cases, bosses behave as though the other boss doesn't exist at all and all 8.5 hours of the employee are theirs to command. Menon agrees, "Most of

the bosses are not empathetic. Everyone has their own priorities and there is competition for attention as people suffer from the 'first service syndrome'. The best thing is to let the other bosses know on a constant basis how you are managing the issues and

deliverables and build rapport and trust. It is mutual respect and honesty that brings it together. The key is to manage each person's ego. Additionally, having an informal chat will also help." A Thiru, president corporate HR, JK Organisation lays the onus of empathy at the bosses' doors, "Bosses are expected to be empathetic in such a situation. If they are not, it is their problem and not that of the shared resource as long as the shared resource does hisher best under the prevailing situation and stays tuned to the purpose (serving the external customer betterfaster) than responding (wasting time) based on organisational hierarchy."

As Salvi says, continue to work hard and smart for the bosses as you are learning twice as much, compared to others who have a single
