Speaking at the launch through video conferencing, Shah said the programme will not only enhance the convenience of travellers but also give them a glimpse of the changes taking place in the country. "The next stage of enhancing travellers' convenience, aligning with PM Narendra Modi's vision of speed, scale and scope, starts today with this programme," he

# Ally's 'Little Liquor' Advice To Nitish Kumar On **Prohibition Ahead Of Polls**

Jitan Ram Manihi's public remarks against prohibition would put Nitish Kumar in a tricky spot before the Bihar election

Bihar Chief Minister Nitish Kumar's prohibition policy, which has reaped political dividends for him over the years, is under attack, not just from the Opposition but from his allies in the NDA. Jitam Ram Manjhi, once Nitish Kumar's lieutenant whom he trusted with the Chief Minister post, has said the sale of liquor in moderate amounts must be allowed and cases registered against such people must be removed before the polls. Mr Manjhi has said the prohibition enforcement officials are ignoring the liquor mafia and targeting poor people who consume limited quantities."Police nabs people who are drinking in small quantities. There should be a campaign against those making thousands of litres of liquor and smuggling

them. During a review of the policy, Nitish Kumar had said those carrying liquor in small amounts should not be arrested," he told the media.

Mr Kumar and Mr Manjhi have an interesting history. Following JDU's drubbing in the 2014

Lok Sabha election, Mr Kumar resigned as Chief Minister and put Mr Manjhi, then in JDU, in the top post. Less than a year later, Mr Kumar wanted to return as Chief Minister, but Mr Manjhi refused to step down. He was expelled from the party, after which he formed the Hindustan Awam Morcha (Secular). Later, he and Mr Kumar became allies in the NDA.

## 3 waste-to-energy plants to come up in Gurgaon, Faridabad in 2 years, says CM Saini

#### Gurgaon.(Agency)

Haryana CM Nayab Singh Saini on Thursday announced that the city and Faridabad will get three new waste-toenergy (WTE) plants within the next two years. The decision was taken during a high-level review meeting held under the state's cleanliness campaign programme in Chandigarh. The meeting, chaired by the CM, focused on strengthening the waste management system in urban areas, with particular attention to Gurgaon and Faridabad, two of the state's largest and fastest-growing cities that have been struggling with mounting solid waste. Stressing that modern technology and scientific methods should be used to improve sanitation and waste disposal, the CM directed the administration to prepare a comprehensive action plan for both the cities, ensuring effective execution of the WTE projects.

These energy projects will not only provide relief to both districts in terms of cleanliness but also give new momentum and strength to the Haryana Shehar Swachhata Abhiyan-2025. I have directed officials to ensure transparency and timeliness in the implementation of the projects and that local bodies should play an active role in this direction," he said.

Electricity will be produced directly from waste through these plants, which will reduce dependence on traditional energy sources such as coal and petroleum. The electricity generated here, officials said, will be added to the grid to meet the energy needs of both cities. This will increase Haryana's clean energy production capacity. However, environmentalists have opposed the setting up of the plants. "We have seen what a failure the Okhla WTE plant has been. The implications of the toxic emissions are known. I fail to understand why nobody is talking about the basics of waste management, which is segregation, door-to-door waste collection, and implementing decentralised waste collection. It was in 2015 that we filed the case in NGT for Bandhwari. Why cannot the bureaucracy focus on decentralised waste processing?" said Vaishali Rana, a Gurgaon-based environmental activist.

## Court rejects bail pleas of Nikki's husband & in-laws

#### Noida. (Agency)

A chief judicial magistrate's court on Thursday rejected bail pleas filed by the husband and in-laws of Nikki Bhati, who died of severe burns last month after an alleged attack over dowry harassment. Nikki's husband Vipin Bhati, his brother Rohit and parents - Daya and Satveer – were arrested after being accused by Nikki's sister Kanchan of setting the 28-year-old on fire at the family's Kasna home on Aug 21. Nikki succumbed to injuries while she was being shifted to Delhi's Safdarjung Hospital later in the day.

Advocate Amit Bhati Bodaki, who filed the bail pleas on behalf of the four accused, submitted CCTV footage, purportedly showing Vipin outside the family's house at the time of the incident. He argued that Nikki died after catching fire from a cylinder blast.

Udham Singh, the counsel for Kanchan, countered this argument, saying that police had not found any evidence of a cylinder blast. Singh said the defence was trying to mislead the court. "The court agreed there was no ground for bail and rejected their application," Singh said on Thursday. Chief judicial magistrate RK Sagar noted the gravity of the allegations and said there were no grounds for relief for the accused at this stage. "The allegation against the accused is of murdering the sister of the plaintiff by pouring inflammable substance on her along with the co-accused. The case is session triable, nonbailable and of serious nature. There are no sufficient grounds for bail in the facts and circumstances of the case. Therefore, the bail application is rejected," the

## Flu infections more severe, lasting longer says doctors; Noida shopitals face shortage of beds

#### Noida. (Agency)

Noida: Hospitals are witnessing a sharp rise in fever and flu cases, with doctors noting longer durations and increased severity compared to previous years

Several facilities reported a higher number of patients than last year, leading to long waits in emergency wards and even a shortage of beds. Physicians flagged rising cases of dengue, typhoid, hepatitis A, and influenza-like illnesses, warning of co-infections and prolonged symptoms. According to doctors, the trend shows fevers are lasting up to a week or more, often accompanied by severe complications. A senior doctor at Noida District Hospital said, "On average, 400-500 patients are coming with flu-like symptoms, compared to 300-350 patients last year, every day over the past week. However, most patients are given medicines and not admitted. A few patients are showing severe conditions,

who are given saline and medicines and are admitted." Dr Ajay Agarwal, senior director & HOD (internal medicine) at Fortis, said that they have been observing a shift in fever patterns over the past year. "We're witnessing a marked increase in patients with acute febrile illness, particularly during the extended monsoon season of 2024-2025

Unlike previous years, where cases were sporadic, we're seeing family-based transmission linked to contaminated water sources during the pre-monsoon period. What concerns us most is the changing symptomatology and severity patterns. Patients are presenting with prolonged fever duration—often 7-10 days before seeking care—and more severe complications. The co-infection rates have also increased, with patients harbouring dengue and bacterial infections. The doctor further added that typhoid fever remains a persistent challenge. "Urban areas are particularly affected, reflecting ongoing sanitation challenges and with the emergence of antimicrobial-resistant strains, it has become a matter of concern," he said.

# New service lane, carriageway widening to help clear gridlock at Bilaspur Chowk on Delhi-Jaipur highway

#### Gurgaon.(Agency)

Bringing relief to thousands of commuters who face persistent congestion at Bilaspur Chowk on Delhi-Jaipur highway, NHAI has stepped up efforts to end the gridlock. In coordination with the district administration, it has removed existing structures and streamlined traffic at the busy junction — more carriageway space, a new service lane and new signboards to name a few.In a statement on X on Thursday, NHAI said a police check post at the chowk was dismantled to create more carriageway space for vehicles. The move aimed to further widen the bottleneck that often traps traffic in long queues. A separate service lane was also created on the Jaipur-Delhi side to allow buses to halt for passengers travelling towards and from Pataudi, without adding to the traffic snarl.

To reduce conflict points, NHAI has put up new signboards to guide motorists and ensure that traffic on the service road and

the main carriageway does not merge directly at the diversion, which earlier added to the gridlock. Traffic police, meanwhile, stepped up enforcement against wrong-side driving and illegal parking by trucks and buses. Both are identified as major contributors to the traffic chaos. Road repairs are also being expedited. According to NHAI, bituminous works at the diversion are scheduled for completion by Sept 14. Once done, the highways authority said, traffic flow is expected to improve considerably.An NHAI official said, "We are taking measures to improve the situation and make the stretch motorable for highway users. Repair work on the diversion is underway. Once the flyover construction is complete, it will improve the commuting between Manesar and Bilaspur."Last Thursday, NHAI sought the district administration's intervention at Bilaspur Chowk, asking it to crack down on wrong-side driving and illegal

parking by trucks and cars. The request came a day after Gurgaon traffic police flagged concerns over worsening snarls at the junction on NH8, linking them to



the extremely poor condition of the carriageway. Earlier, NHAI said that the long-delayed Bilaspur flyover would be The traffic woes at Bilaspur Chowk have been aggravated by NHAI's ongoing flyover construction. The project was

announced in 2015 to decongest traffic along the Delhi-Jaipur highway. The work instead created more chaos, with poor management of diversions, said the

cops. The foundation stone for the work was laid in March 2022 and completion was expected in Oct last year.Initially overseen by NHAI's project implementing unit (PIU) Jaipur as part of a wider highway upgrade, the project was later handed over to PIU Rewari.Construction at Bilaspur Chowk started in May 2023. However, it stalled when underground utility lines were found in the alignment. A revision in estimates and financial constraints of the contracted

firm brought the project to a standstill.In Oct 2024, NHAI descoped the stalled work and floated a fresh tender in Dec.

# 2.8k tonnes of garbage cleared from roads in 1-day mega sweeping drive in Gurgaon

Gurgaon. (Agency)

Around 2,800 tonnes of waste was swept up and collected as a lakh-plus volunteers and sanitation staff got together on Thursday to participate in a citywide cleanliness drive organised by MCG and the district administration. Chief minister Nayab Singh Saini was among the volunteers to participate in the drive at Sohna Chowk and in Sector 52. Addressing a gathering in Sohna, Saini said Gurgaon must secure the top position in Swachh Sarvekshan rankings through effective administration and active citizen participation."Every city will be ranked on cleanliness and Gurgaon will certainly secure a prominent position," he said, assuring full govt support for realising a clean and green city. The chief minister spoke of his govt's 11-week Haryana City Swachhata campaign and said the focus was on beautification, urban area

improvements. He also announced that pending development projects would be expedited in the city after monsoon retreats.On Thursday, the campaign was organised at 46 spots across the city, among them IFFCO Chowk, Rajiv Chowk, Rezang La Chowk, Hero Honda Chowk, Ardee City, Vatika Chowk, Umang Bhardwaj Chowk, and Millennium City Centre metro station. Volunteers from Dera Sacha Sauda, Sant Nirankari Mission, Radha Soami Satsang Beas, councillors and residents also participated.MCG officials said 2,800 tonnes of waste was picked up and transported through 160 tractor-trolleys. "We have a target of clearing the secondary waste collection points where this waste was transported to within 24 hours," MCG commissioner Pradeep Dahiya told TOI. The initiative comes at a time when residents and opposition parties have increasingly criticised the

govt over uncollected garbage, poor waste segregation and overflowing drains in Gurgaon. Every year, monsoon rain lays bare the city's infrastructure, which fails to cope with bouts of showers, resulting in flooded roads and chaos in residential areas. Thursday's campaign was seen by many as an attempt by the govt to address these concerns and rebuild public confidence. "This indiscriminate dumping on roads and public places is the direct result of the city's broken waste collection and disposal system," said Gauri Sarin, founder of citizens' group Making Model Gurugram."Instead of staging cleanliness drives, MCG should focus on creating awareness about waste segregation, in-situ composting and reducing single-use plastic use. It is not the responsibility of residents to clean the streets. What the city needs is sustained efforts to educate people on segregation at source and promote composting within

## December deadline set for four-lane Gurgaon-Pataudi-Rewari highway

Gurgaon. (Agency)

National Highways Authority of India (NHAI) has set a new target to complete Gurgaon-Pataudi-Rewari highway, which has been delayed by two years. With NHAI officials claiming 70% of the work is already finished, the highway will be ready by the end of this year. The project was first conceived in 2018, when the govt decided to upgrade the two-lane state highway into a four-lane national highway. The project — estimated to cost Rs 900 crore — was originally scheduled for completion in Dec 2022. However, the work began in 2021, with a revised timeline of two years - slated for Nov 2023. According to NHAI, two main structures remain pending, including a railway overbridge (RoB) at Pahari village and a flyover on Dwarka Expressway. Once complete, the highway is expected to reduce the vehicular load on the heavily congested Delhi-Jaipur Expressway.İt will also provide an alternative route to industrial areas in Manesar, Bilaspur and Dharuhera, thereby facilitating smoother traffic flow for both commuters and transporters. An NHAI official said, "Around 70% of the work is over while other major structures such as RoB at Pahari and flyover at Dwarka Expressway — are in an advanced stage of construction. We are making every effort to complete the remaining works, including the approaches, by Dec this year."

At Pahari, the girders are already cast and the deck-slab installation, along with approach construction, is underway. On Dwarka Expressway, a two-lane unidirectional flyover is being built where the girders are ready, but the deck slab and approach works are still pending. However, a few hindrances continue to slow down progress. Strengthening of a 1.1km sewer line on the left carriageway is yet to begin, as NHAI awaits an estimate from GMDA.

# Fast-track grievance disposal, tighten monitoring of developers, Haryana tells Rera

Haryana govt has directed Rera authorities in Gurgaon and Panchkula to fast-track grievance disposal and tighten monitoring The issue of corruption in Rera was also of developers, following a review chaired by chief secretary Anurag Rastogi.

Officials said Haryana accounts for nearly 10% of pending Rera complaints nationwide, despite lower project registrations than other states. Officials attributed this to the larger size of projects in Gurgaon — spanning 5 to 100 acres in comparison to smaller, often one-acre projects registered in other states. To address the pending complaints, Rera Gurgaon has set up a help desk.

Moreover, Rera authorities were told to publish tutorials online to guide homebuyers and form mediation cells to settle disputes faster and the state govt has asked deputy commissioners to assist in executing recovery certificates. To ensure compliance to the rules, the town and

country planning (DTCP) department will now have to share copies of all licences of all projects with Rera.

# 20 STPs built, but sewer links missing: What chokes Hindon River

#### Ghaziabad . (Agency)

Noida: UP has 20 sewage treatment plants (STPs) with a total installed capacity almost equal to the sewage pumped into the Hindon basin, but still large volumes continue to remain untreated because much of this capacity goes unutilised. In a 200-page affidavit, UP chief secretary

in-charge Deepak Kumar informed the National Green Tribunal (NGT) that 943.63 million litres per day (MLD) of sewage enters the Hindon basin against an installed treatment capacity of 953.5 MLD through 20 STPs. While on paper, this suggests a surplus, however, due to missing sewer networks, only 658.2 MLD is actually treated, leaving a gap of 285.43 MLD that continues to flow untreated into the Hindon.One of the main reasons for the underutilisation of the installed capacity of STPs is the lack of sewer lines and connections at the domestic level, the affidavit states. To address this, the state has proposed seven new STPs with a combined capacity of 283 MLD in areas where sewer connectivity is being laid — two in Saharanpur, four in Shamli, and one in Ghaziabad. Districts like Meerut and Baghpat remain excluded despite having no treatment facilities. The affidavit further shows disparity across districts:



Ghaziabad has 10 STPs, GB Nagar five, Muzaffarnagar four and Saharanpur one. But Baghpat, Shamli, and Meerut have none, meaning all sewage here drains directly into the river. Even in GB Nagar, where capacity (287 MLD) far exceeds generation (171 MLD), only 149 MLD is treated because sewer lines are incomplete. The chief secretary had attached communication with the district

magistrates of the seven districts through which the river flows, with the affidavit. When the case was heard on Jan 24, the tribunal had noted that the state government's earlier affidavit was inadequate as it failed to clarify whether the STPs were meeting prescribed norms. In response, the latest affidavit stated that all but one plant were compliant — the exception being a 56 MLD facility in

Ghaziabad, maintained by the Ghaziabad Development Authority, which is not meeting standards.Petitioner Abhisht Kusum Gupta told the tribunal that industrial effluents continue to mix with treated water and flow into the Hindon.

# Post-floods, Yamuna Bazaar residents left to fend for themselves

#### The Sikh Times

New Delhi: For residents of Yamuna Bazaar, survival has meant moving from one crisis to another. Just weeks ago, they were navigating floodwaters; and today, they remain knee-deep in thick, unrelenting silt. With no electricity and no official cleanup drive, people living in this riverside locality are left grappling with the aftermath on their own. When The Tribune visited the area, the lanes leading to Yamuna Bazaar resembled stretches of dried riverbed - caked with mud that had seeped into homes and temples. In several places, residents had placed wooden planks and takhats (wooden beds) across the sludge to reach their doors. The task of recovery has been left to residents themselves. "We have been working for three days just to make our homes accessible again. There was knee-high mud after the water receded. We've cleared it ourselves. The government hasn't stepped in to help," said Sanjay Kumar, who has lived in the area for 35 years. Even the cleanup efforts are uneven. "Our lane has cleared most of the silt, but those living in the next lane haven't touched it. If they start cleaning, the muck will flow into our homes because we are at a lower level. That's why we've avoided the entrance and instead put planks across it," explained Rajkumar Mishra, pointing to the fragile wooden walkway outside his house. The bigger crisis, however, is the absence of electricity. Power has not been restored since the Yamuna's

#### **Proclaimed offender** involved in drug trafficking cases arrested


New Delhi: Delhi Police's Crime Branch has arrested Amit Kumar Jha, also known as Hari Kant Jha, a proclaimed offender wanted in two drugrelated cases, while he was attempting to flee the city near Khajuri Chowk. The accused, allegedly involved in narcotics trafficking, had been evading arrest for several years, the police said on Sunday. The court had declared him a proclaimed offender in a case registered by the Crime Branch in 2018 under the Narcotic Drugs and Psychotropic Substances Act (NDPS). In a separate case at Kashmere Gate police station, a non-bailable warrant was issued against him earlier this year under the same Act. The arrest followed a tip-off received by a head constable of the Crime Branch, who informed officers that the accused would be near Khajuri Chowk at around 4 pm. Acting on this information, the police laid a trap near parked vehicles. The accused was intercepted while heading towards Shastri Park Road. On questioning, he confirmed his identity as Amit Kumar Jha of Riwaspur, Faridabad, Haryana. The police verified that he had been declared a proclaimed offender by the court in August 2024 and that a non-bailable warrant had been issued earlier this year. The police described him as a habitual offender engaged in drug trafficking. He was arrested in accordance with due legal process and is being held for further investigation. The Crime Branch is continuing inquiries to uncover more details of his activities.

#### Villagers call mahapanchayat on Sept 13 against UER-2 toll

New Delhi: Anger over the Urban Extension Road (UER-2) toll tax is mounting in Delhi's rural areas, with villagers vowing to step up their protest. 

## Indian-origin motel manager beheaded in Dallas after argument over washng machine; co-worker arrested

A 50-year-old Indian-origin motel manager was brutally beheaded in front of his wife and son in a attack at a Dallas motel on Wednesday morning.

Chandramouli Nagamallaiah, originally from Karnataka, was killed following an argument over a broken washing machine with co-worker Yordanis Cobos-Martinez, 37, who has since been arrested and charged with capital murder. According to Dallas Police, the confrontation escalated when Nagamallaiah asked a third party to translate instructions to Cobos-Martinez, reportedly angering the suspect.Surveillance footage shows Cobos-Martinez retrieving a machete and attacking Nagamallaiah, who fled toward the motel office where his wife and 18-year-old son witnessed the fatal assault and tried to intervene. Cobos-Martinez, who has a prior criminal history including arrests for auto theft and assault in Houston, is being held without bond. If convicted, he could face life in prison without parole or the death penalty.

## Israel PM vows 'there will be no Palestinian state, this place belongs to us

Israeli Prime Minister Benjamin Netanyahu vowed on Thursday that there would be no Palestinian state, speaking at a signing ceremony for a major settlement project in the occupied West Bank.

We are going to fulfil our promise that there will be no Palestinian state, this place belongs to us," Netanyahu said at the event in Maale Adumim, an Israeli settlement just east of Jerusalem."We will safeguard our heritage, our land and our security... We are going to double the city's population." The event was streamed live by his office.

Israel has long had ambitions to build on the roughly 12 square kilometre (five square mile) tract of land known as E1, but the plan had been stalled for years in the face of international opposition. The site sits between Jerusalem and the İsraeli settlement of Maale Adumim, near routes connecting the north and south of the Palestinian territory. Last month, Israel's far-right Finance Minister Bezalel Smotrich backed plans to build around 3,400 homes on the ultrasensitive parcel of land. His announcement drew condemnation, with UN chief Antonio Guterres saying the settlement would effectively cleave the West Bank in two and pose an "existential threat" to a contiguous Palestinian state.

All of Israel's settlements in the West Bank, occupied since 1967, are considered illegal under international law, regardless of whether they have Israeli planning permission. Several Western governments, including Britain and France, have announced they intend to recognise the State of Palestine at the United Nations later this month. Britain has said it will take the step if Israel fails to agree to a ceasefire in the devastating Gaza war, triggered by Palestinian militant group Hamas's October 2023 attack.Far-right Israeli ministers have in recent months openly called for Israel's annexation of the territory. Israeli NGO Peace Now, which monitors settlement activity in the West Bank, said last week that infrastructure work in E1 could begin within a few months, and housing construction within about a year.It said the E1 plan was "deadly for the future of Israel and for any chance of achieving a peaceful two-state solution.

## **US Threatens Visa Revocations Over Online** Posts Of Charlie Kirk Killing

The US State Department on Thursday threatened to strip visas over online support for the killing of rightwing influencer Charlie Kirk, encouraging internet users to flag foreigners' posts.

"In light of yesterday's horrific assassination of a leading political figure, I want to underscore that foreigners who glorify violence and hatred are not welcome visitors to our country," Deputy Secretary of State Christopher Landau wrote on X.

'I have been disgusted to see some on social media praising, rationalizing, or making light of the event, and have directed our consular officials to undertake appropriate action," he wrote, without naming specific posts.

Landau quickly received replies that pointed to specific online comments and which encouraged him to revoke visas purported to belong to foreign residents in the United States. Landau responded in turn, asking X users to keep sharing by replying to him online. He promised to ask the State Department to look into the posts.irk, a 31-year-old ally of President Donald Trump who has helped galvanize conservative support among young people, was shot dead during a speaking engagement Wednesday at a university in Utah. The Trump administration has moved aggressively to revoke or deny visas as part of a broader crackdown on immigration.

As of mid-August, the State Department said it has rescinded 6,000 student visas, mostly over legal violations including overstays or police encounters including drunk driving. Secretary of State Marco Rubio has also said he is prioritizing the revocation of visas of "lunatics" who led campus protests against Israel's offensive in Gaza, using a law that allows him to remove people for going against US foreign policy interests. Under Rubio's orders, the State Department now asks all visa applicants to keep their social media profiles open for vetting. The approach comes despite outspoken criticism by the Trump administration over restrictions on online speech in European allies, including over alleged incitement by far-right groups.

# Nepal talks stuck on new government head

The determination of Gen Z to establish the Interim **Government with Sushila Karki** as PM is growing stronger by the day. However, army reportedly favours Durga Prasai, a promonarchy figure.

Mcurfew remains in effect across much of Nepal, particularly in the Kathmandu Valley, as the Gen Z protests enters the fourth day. Life is becoming increasingly difficult for ordinary citizens, especially those who depend on daily wages to sustain themselves. "We are leaderless at the moment, but we are not without a country.

As long as we have our Constitution, we are secure," Tanuja Pandey, a Gen Z protester, told this reporter. She explained that multiple reasons had been presented against their choice of Sushila Karki as prime minister of the Interim Government.

However, Gen Z had united in support of Karki because of her corruption-free reputation.Pandey added that Gen Z had repeatedly requested the Army to facilitate a meeting with President Ram Chandra Poudyal, though so far, all meetings have been conducted only with the Chief of Army Ashok Raj Sigdel.The determination of Gen Z to establish the Interim Government with Sushila Karki as PM is growing stronger by the day. Karki agreed and received widespread support from the public. However, some backlash has emerged. Opposition seems

to be coming primarily from the Army, which reportedly favours Durga Prasai, a pro-monarchy figure. The President also appears to prefer another candidate from among the current parliamentarians rather than Sushila Karki. This push to nominate someone from the existing parliament, rather than Karki, is causing friction with Gen Z.A press release signed by the President stated that he is seeking a solution based on constitutional provisions and urged citizens to remain calm and patient, emphasising respect for the current Constitution. Meanwhile, under repeated pressure from Army Chief to propose a new



candidate, Gen Z may now hold another virtual discussion. One potential alternative being considered is Santosh Pariyar, Chief Whip of the Rastriya Swatantra Party (RSP) and a proportional representative from the Dalit category elected in 2022.

An excellent choice, nonetheless, the majority of Gen Z remains united in supporting Sushila Karki, preferring a leader outside of existing political parties to guide the Interim Government and oversee elections under the current constitution.

Constitution of Nepal must remain intact' Regarding the legality of appointing Karki as prime minister, senior Supreme Court

lawyer Dinesh Tripathi noted: "More than legality, it is legitimacy that needs to be considered at this unprecedented time." Tripathi emphasised that Gen Z has chosen a senior, responsible leader with an unblemished record, and if the President agrees, she can be appointed to lead the Interim Government."Nepal is undergoing extraordinary times. With no caretaker government in place, it is

imperative to form an Interim Government as soon as possible. # Former Chief Justice Karki likely to become Nepal's caretaker Prime Minister

Former Chief Justice Sushila Karki is likely to be appointed as the head of a caretaker government in Nepal, according to sources. The proposal comes amid intensified negotiations between President Ramchandra Paudel, senior political leaders, the Army chief, and representatives of the youth-led Gen Z movement, which has been at the forefront of recent mass protests. The group has strongly recommended Karki, a respected figure in Nepal's judiciary and a known anti-corruption crusader, to head the interim administration. If appointed, Karki would become Nepal's first female prime minister.

The caretaker government is expected to steer the country toward fresh elections.Prime Minister K P Sharma Oli stepped down after protesters stormed his office, demanding



accountability for the deaths of demonstrators during violent clashes with police.

The Ministry of Health has confirmed the death toll from Monday and Tuesday's protests has climbed to 34, up from an earlier figure of 19. The demonstrations erupted over corruption allegations and a controversial social media ban, which was rescinded late Monday.President

Paudel, who accepted Oli's resignation, has kept his cabinet in place on a temporary basis until a new Council of Ministers is formed. Two constitutional pathways were under consideration: dissolving Parliament or retaining it under a caretaker setup. Stakeholders, including the Gen Z group, have agreed to pursue a solution within the current constitutional framework. To ease tensions,

authorities relaxed the nationwide curfew from 7 am to 11 am Friday. However, restrictive orders remain in effect from 11 am to 5 pm, followed by a short window before the curfew resumes from 7 pm to 6 am.

# Israeli soldiers, their mothers, increasingly reject calls to return to Gaza

As Israel calls up tens of thousands of reservists for its invasion of Gaza City, a growing number of soldiers — and their mothers — are saying no. There are no official figures, but newly formed groups are broadcasting their refusal to serve despite the risk of imprisonment. It's a new phenomenon in the nearly two-year war sparked by Hamas' Oct. 7, 2023, attack, though so far it has had no apparent effect on military operations. The defiance is emerging as Israelis have joined mass protests accusing Prime Minister Benjamin Netanyahu of prolonging the war for political purposes instead of reaching a deal with Hamas to bring back the remaining 48 hostages, 20 of whom are believed to be alive. # India's IT Sector Nervous As US Proposes 25% Outsourcing Tax

Former Vice President Kamala Harris says it was 'recklessness" for Democrats to leave it to President Joe Biden to decide whether to continue seeking another term last year, but she defends his ability to do the job, according to an excerpt of her new book.

Harris, in an excerpt of "107 Days" published Wednesday in The Atlantic, writes that as questions swirled about whether the then-81-year-old Biden should seek reelection, she and others left the decision to him and first lady Jill Biden. "Was it grace, or was it recklessness? In retrospect, I and a flight to the West Coast for a Hollywood fundraiser. The bill could not have come at a worse time for India's IT sector, which is struggling with weak revenue growth in its mainstay US market as clients defer nonessential tech spending amid inflationary pressure and tariff uncertainty."The HIRE Act proposes sweeping changes that could alter the economics of outsourcing and significantly increase the tax liability associated with international service contracts," EY India's compliance head Jignesh Thakkar said.

In some cases, combined federal, state and local taxes could push the levy on outsourced payments as high as 60%, Thakkar said."While its partisan proposal may seem initially attractive, it's ultimately an artificial cost which makes organisations less competitive and profitable globally," said Arun Prabhu, partner at Cyril Amarchand Mangaldas. Even so, the idea is gaining traction. This month, White House trade adviser Peter Navarro reposted a call from far-right activist Jack Posobiec for tariffs on srvies, not just goods.

When political noise turns into regulatory risk, clients quickly insert contingencies, reopen pricing and demand delivery flexibility," said HFS Research President Saurabh Gupta."Clients will simply take longer to sign, longer to renew, and longer to commit transformation dollars," Gupta said.Last week, US Republican Senator Bernie Moreno introduced the HIRE Act, which proposes taxing companies that hire foreign workers over Americans, with the tax revenue used for U.S. workforce development. The bill also seeks to bar firms from claiming outsourcing payments as tax-deductible expenses.

The bill could not have come at a worse time for India's IT sector, which is struggling with weak revenue growth in its mainstay US market as clients defer nonessential tech spending amid inflationary pressure and tariff uncertainty.

# Australia approves world-first vaccine to save koalas from chlamydia

**MELBOURNE.** (Agency)

A regulator has approved a world-first vaccine to protect koalas from chlamydia infections, which are causing infertility and death in the iconic native species that is listed as endangered in parts of Australia. The single-dose vaccine was developed by the University of the Sunshine Coast in Queensland state after more than a decade of research led by professor of microbiology Peter Timms.

The research showed the vaccine reduced the likelihood of koalas developing symptoms of chlamydia during breeding age and decreased mortality from the disease in wild populations by at least 65%. The recent approval by Australia's veterinary medicine regulator means the vaccine can now be used in wildlife hospitals, veterinary clinics and in the field to protect the nation's most at-risk koalas, Timms said on Wednesday."We knew a singledose vaccine, with no need for a booster was the answer to reducing the rapid, devastating spread of this disease, which accounts for as much as half of koala deaths

across all wild populations in Australia," Timms said in a statement. "Some individual colonies are edging closer to local extinction every day, particularly in southeast Queensland and New South Wales, where infection rates within populations are often around 50% and in some cases can reach as high as 70%," Timms added. Deborah Tabart, chair of the conservation charity Australian Koala Foundation, said resources being spent on vaccinating koalas should be redirected at saving koala habitat.

'At the risk of sounding flippant, how can The Queensland Conservation Council, an anyone be so delusional as to think that you can vaccinate 100,000 animals? It's just ridiculous," Tabart said on Friday.

Tabart's foundation estimates there are fewer than 100,000 koalas in the wild. The government-backed National Koala Monitoring Program estimated last year there were between 224,000 and 524,000 koalas."I accept that chlamydia is an issue for koalas, but I also want people to understand that they're sick because they haven't got any habitat," Tabart said.

'It's really good news. Chlamydia is one of the key stresses that has been putting pressure on koala populations," Copeman said."Koalas were at risk before chlamydia outbreaks, and they will remain at risk even if we manage chlamydia perfectly, because we keep on destroying their habitat," he added.Koalas are listed as endangered species in the states of Queensland and New South Wales and in the Australian Capital Territory, with habitat loss due to wildfires and urban expansion as the major threats. Chlamydia can cause urinary tract infections, infertility, blindness and death.

Treatment with antibiotics can disrupt an infected koala's ability to digest eucalyptus leaves — its sole food source — leading to starvation, the university said in a

statement. The research has been supported by the federal, New South Wales and Queensland governments. Federal Environment Minister Murray Watt said his government had contributed to the vaccine's development through a 76 million Australian dollar (\$50 million) Saving Koalas Fund."We know that koalas need help to fight diseases like chlamydia. It's a widespread threat impacting their reproductive health and causing infertility," Watt said in a statement.

# Rail traffic noise in slums far over WHO norms, reveals study

New Delhi: Residents of slum clusters along Delhi's railway tracks are living amid dangerously high noise levels that surpass global safety limits, a new scientific study has revealed. The research, jointly conducted by the Delhi Technological University (DTU) and the CSIR-Central Road Research Institute (CRRI), monitored more than 1,000 train pass bys across 14 locations in the National Capital Territory. The findings, published in the journal Environmental Monitoring and Assessment, point to a public health emergency unfolding in some of the city's most vulnerable communities. According to the study, average sound levels in these settlements routinely exceeded the Central Pollution Control Board (CPCB)'s permissible limit of 55 decibels for residential areas. At Patel Nagar, one of the noisiest locations surveyed, levels touched 120 decibels - equivalent to standing next to a chainsaw. Even the "quietest" site, Shahdara, recorded 69 decibels, still 26 per cent above the safety threshold. The World Health Organisation (WHO) recommends community noise levels remain below 55 decibels during the day and 40 decibels at night to prevent health risks such as sleep disruption, anxiety, cardiovascular disease and impaired cognitive functioning. In Delhi's rail-side slums, however, noise was consistently two to three times higher than

those standards. The study highlights that Scientist at CRRI, emphasised that absence Delhi has 775 slum clusters, of which nearly of sound barriers made these communities vulnerable. The study strongly recommends

Besides, regular noise audits and targeted monitoring of identified hotspots are advised to ensure accountability and long-term reduction of noise pollution. If

## Dismissal from service, imprisonment too harsh a punishment for overstaying leave, rules AFT

New Delhi: The Armed Forces Tribunal (AFT) has ruled that dismissal from service and imprisonment is too harsh and excessive a punishment for overstaying leave, even though the soldier had reported for duty after almost three years. Setting aside the sentence of dismissal awarded by a court martial, the Tribunal has held that the punishment imposed upon the soldier was not commensurate with the gravity of the charges levelled against him and the same deserves to be reviewed. While confirming the one-month imprisonment that the soldier had to undergo, the Tribunal's Bench comprising Justice Suresh Kumar Gupta and Maj Gen Sanjay Singh set aside the dismissal does not mean that the soldier will, as a logical consequence, be entitled to reinstatement in service. Observing that reinstatement is a matter of discretion, the Bench, in their order of September 3, said that if the dismissal is being set aside without reinstatement, the soldier would be treated as discharged from service and entitled to certain benefits as admissible in accordance with the length of his service. The soldier had proceeded on 10 days' casual leave in September 2017 but did not join duty after expiry of the leave period. He reported for duty in June 2020 and requested for continuation of his service. He had averred that due to a paralysis attack suffered by his father and his mother suffering from various diseases, he could not join duty. He was tried by District Court Martial, which convicted him in May 2021. While holding that the soldier was guilty of having committed the offence of overstaying leave by 1,031 days, the Bench also ruled that he would not be entitled to any back wages for the period he was absent.

### Ministers assure flood-hit farmers of compensation

New Delhi: The Delhi Government on Wednesday said it was committed to standing with farmers and residents impacted by floods in the Yamuna belt. Acting on the instructions of Chief Minister Rekha Gupta, Development Minister Kapil Mishra and Social Welfare Minister Ravindra Indraj Singh carried out a joint inspection of the flood-affected areas, marking the first time two Cabinet Ministers visiting such locations together. The inspection, conducted from Palla Chowk to Hiranki, aimed to assess the losses suffered by farmers and ensure timely compensation. The ministers, accompanied by senior officials from the Agriculture and Flood Control Departments as well as the local district administration, met farmers directly, listened to their grievances and reviewed the administrative response on the ground.

#### 19-yr-old arrested for co-worker's murder

Gurugram: The Gurugram police, on Thursday, arrested a 19-year-old man for the murder of his co-worker. The accused had pushed him from the third floor following a brawl over spilled food. According to the police, the incident took place on the night of August 14 at an under-construction building in Gandhi Nagar Colony where the deceased, Pappu Kumar (35), a native of district Ambedkar Nagar in Uttar Pradesh, along with Umesh and Rajesh used to work and live. According to the complaint filed by the deceased's younger brother, the accused, Umesh Kumar (19), a native of Ambedkar Nagar in UP, had a fight with his brother Pappu over spilled food. His friend Rajesh intervened and separated them but after some time, when Pappu went to the third floor, Umesh followed and pushed him to death. "During interrogation, the accused revealed that after committing the crime, he fled and would hide at various places in Uttar Pradesh and Bihar," a police spokesperson said.

# India-US ties | A gulf that was bridged on a

Behind a seeming thaw in the atmospherics between India and the US from last week is Washington's biggest secret of the moment—a meeting between President Donald Trump and a private Indian citizen. The venue of the meeting? Where else, but a golf course! How long did the meeting last? Just over 10 minutes, which is about the duration of the septuagenarian president's normal attention span. The two men did not discuss trade tariffs. It was not a diplomacy pow-wow. They talked about Trump's daughter Ivanka's 2017 visit to Hyderabad. The Indian citizen was very much there. They recalled Trump's visit to Ahmedabad 27 months later. The Indian was present there too, and told Trump that seeing him in person was the greatest moment in the lives of a quarter million people in Gujarat. "A quarter million Indians!" Trump exclaimed. "Explain that to me." There were 1,32,000 people inside the Narendra Modi Stadium, which was filled to capacity, was the explanation. There were an equal number of people who lined up on the route of Trump's cavalcade wherever he went in Ahmedabad. Trump knows that he cannot get that kind of a crowd in his own country. Or for that matter, anywhere else in the world. Exaggerating the importance of the 'Namaste Trump' events five years ago, the Indian said it was one of the high points in his life as well. The hype was meant solely to hit its target—Trump's huge ego. The two men briefly talked about real estate projects promoted by the Trump Organization, which entered commercial property development in Pune five months ago for the first time in India. Praise was showered on the vision of Trump's son Eric, who is in charge of the India projects, and whom the Indian has met many times in connection with this real estate business. India is set to have the most number of Trump Towers anywhere in the world outside the US. As someone who followed Trump extensively during his successful 2016 presidential election and reported on his first term in the White House, this author has little doubt that this golf course conversation with the Indian prompted the president's recollection last week of his "special relationship" with Prime Minister Narendra Modi. "I'll always be friends with Modi, he is a great prime minister," Trump said. The prime minister promptly and "deeply" appreciated Trump's remarks and "fully reciprocated those sentiments. It was only the first time that Modi has mentioned Trump's name since the tariff crisis engulfed the Indian public domain. On Tuesday, Trump remained positive, describing India and the US as "great countries". Modi again responded, saying he looked forward to speaking with the president. I am not naming the private Indian citizen because he has not reported his meeting with the president to the Indian government. "Why should I tell the Indian government?" he asked me. His was an act of goodwill in statecraft. I am not calling him an interlocutor because he was not one. He was not even a back channel. He was merely leveraging his many years of engaging with the president and members of his family. His aim was to contribute whatever he could to repair India-US relations, in which he has invested more than three decades and continues to do so.Probing this meeting in Washington, I discovered that no one in the official structure of the Trump administration knows about it either. Except one person whom the president trusts the most in Washington: his sole gatekeeper in the White House. In his second administration, Trump has filled this gatekeeper's post with extreme care, avoiding the pitfalls in his first term when aides played musical chairs. When


Today is the birthday of a personality who, inspired by the principle of Vasudhaiva Kutumbakam, has dedicated his entire life to societal transformation and strengthening the spirit of harmony and fraternity.

Today is September 11th. This day evokes two contrasting remembrances. The first dates back to 1893, when Swami Vivekananda delivered his iconic Chicago address. With the few words, "Sisters and Brothers of America," he won the hearts of thousands present in the hall. He introduced the timeless spiritual heritage of India and the emphasis on universal brotherhood to the world stage. The second is the gruesome 9/11 attacks, when this very principle came under attack thanks to the menace of terrorism and radicalism. There is something else about this day which is noteworthy. Today is the birthday of a personality who, inspired by the principle of Vasudhaiva Kutumbakam, has dedicated his entire life to societal transformation and

strengthening the spirit of harmony and fraternity. For lakhs of people associated with the Rashtriya Swayamsevak Sangh, he is respectfully referred to as Param Pujya Sarsanghchalak. Yes, I am referring to Shri Mohan Bhagwat Ji, whose 75th birthday is, incidentally, falling in the same year when the RSS marks its centenary. I would like to convey my best wishes to him and pray for his long and healthy life.My association with Mohan Ji's family has been very deep. I have had the good fortune of working closely with Mohan Ji's father, the late Madhukarrao Bhagwat Ji. I have written extensively about him in my book, Jyotipunj. Along with his association with the legal world, he devoted himself to nation-building. He played a pivotal role in strengthening the RSS across Gujarat. Such was Madhukarrao Ji's passion towards nation-building that it groomed his son, Mohanrao, to work towards India's regeneration. It is as if Parasmani Madhukarrao prepared another Parasmani in Mohanrao.

Mohan Ji became a Pracharak in the mid-1970s. Upon hearing the word 'Pracharak', one may mistakenly think it refers to someone who is simply doing Prachar or campaigning, propagating ideas. But, those familiar with the working of the RSS understand that the Pracharak tradition is at the core of the organisation's work. Over the last hundred years, thousands of young people, inspired by a patriotic zeal, have left their homes and families to dedicate their lives to realising the mission of India First. His early years in the RSS coincided with a very dark period of Indian history. This was the time the draconian Emergency was imposed by the then Congress government. For every person who cherished democratic principles and wanted India to prosper, it was natural to strengthen the anti-Emergency movement. This is exactly what Mohan Ji and countless RSS Swayamsevaks did. He worked extensively in rural and

backward areas of Maharashtra, especially Vidarbha. This shaped his understanding of the challenges faced by the poor and downtrodden. Over the years, Bhagwat Ji held various positions in the RSS. ## Task cut out for new V-P to protect democratic space

As contests go, the vice presidential poll was decided the day it began. NDA's candidate C P Radhakrishnan had over 100 votes more than the united opposition's pick, Justice B Sudershan Reddy, a former Supreme Court judge. The only point of interest was the margin of victory. The NDA expected 439 votes, which included commitments of support from other smaller entities. But it got 13 more, giving a jolt to the opposition INDIA bloc. All 315 opposition MPs had turned up to vote, with senior Congress leader Jairam Ramesh calling it an "unprecedented 100 percent turnout". Yet, Justice Reddy got just 300 votes, implying cross-voting. The finger of suspicion on the betrayal was levelled at the Aam Aadmi Party, which is out of the INDIA bloc but promised its votes. On the plus side, the opposition polled 40 percent of the votes this time around, as

against 26 percent in the vice-presidential election in 2022 that had elected Jagdeep Dhankhar, whose resignation necessitated the fresh poll. Justice Reddy was dignified in defeat, saying democracy is strengthened not just by



victory, but by the spirit of dialogue, dissent and participation.

If the opposition made it an all-South linguistic contest by pitting a Telugu speaker against a Tamilian, it did not fetch electoral rewards. The entire Andhra Pradesh went for CPR, while the BRS in Telangana abstained. As for CPR, what value his elevation would bring to the BJP and NDA in Tamil Nadu-except for some bragging rights—is uncertain. He hails from the agrarian Gounder community in west Tamil Nadu, which is the pocket borough of the AIADMK. CPR is affable, has RSS roots and the right OBC credentials. He gained legislative knowledge on the go with two stints as a Lok Sabha member, and had administrative exposure as governor in multiple states including Maharashtra.

But managing a polarised Rajya Sabha as its chairman dispassionately, while giving equal space and dignity to the opposition and the treasury, is a big challenge. His predecessor Dhankhar was often seen as preachy and partisan. The office of the Vice-President is the second

# Putting states at the centre of reforms

States hold several keys to business growth. Comprehensive reforms in states' land, labour and energy sectors can yield significant benefits in the form of national growth. The GST model for Centre-state coordination could be effective for this purpose

India's journey towards becoming a globally competitive, inclusive, and sustainable economy will be shaped by the strength and dynamism of its states. By embracing coordinated, data-driven, and outcome-focused reforms, states can unlock unprecedented growth opportunities.

States hold unique influence over business regulation, land management, labour markets, energy, education, healthcare, agriculture, and sustainability. These are vital for industrial expansion, job creation, productivity enhancement, and inclusive development. Aligning national strategies with robust state-led initiatives is, therefore, essential.A template already exists. The successful rollout and recent reforms of GST demonstrated how Centre-state coordination through the Empowered Committee of State Finance Ministers and the GST Council can create effective, carefully-crafted, consensusbased reforms that benefit the entire nation. The model should be extended to build consensus on land, labour, power, agriculture, education, and fiscal sustainability. Creating an enabling business environment is a fundamental step for encouraging private investment. States should streamline all approvals through the national single-window system, with time-bound clearances and legally recognised digital certificates to reduce delays. Fast-tracking dispute resolution through dedicated courts and alternative mechanisms will further ease business. Decriminalising business-facing state laws would strengthen trust between government

and industry. Addressing land issues remains a priority. States could establish online, integrated land authorities to digitise and integrate land data across departments. These could serve as single points for allotment, provide clarity on disputed parcels, and help transition to governmentguaranteed land titles. Simplifying forest land diversion for projects under 50 hectares, especially in mining, by delegating authority to states, can also accelerate development without compromising safeguards.

Labour reforms are another area for swift action. Prompt implementation of the four Labour Codes, with clear transition plans and advisory support from the Centre, will encourage industry and employment generation, especially in labourintensive sectors. Compliance should be centralised via an enhanced Shram Suvidha portal offering single-window filings, annual returns, and time-bound approvals. Energy is an important factor input, and its costs and availability are key determinants of competitiveness. Fostering private sector participation in distribution and transmission can dramatically improve efficiency. States adopting reforms such as tariff-based competitive bidding and discom privatisation should be rewarded with incentives like enhanced borrowing limits or long-term, interest-free capital loans. Rationalising and eventually phasing out open access charges will also be critical in making the electricity sector more competitive and affordable. Another area that the states need to address is instituting more sustainable mechanisms for providing free or cheaper power to certain user segments. This should be done through direct benefit transfers by the states to targeted end users, helping improve discoms' financial health immensely. Fiscal stability remains a cornerstone for sustainable growth. States can enhance their financial resilience by adopting long-term fiscal risk reporting, drawing inspiration from



international best practices such as Brazil's decadelong forecasts and the UK's 50-year projections. They should also work towards prioritising expenditure to bring down overall fiscal deficits and debt levels. Unlocking the value of state assets presents another opportunity. On the lines of the National Monetisation Plan, states could draw up their own plans. The central government could support the intervention through a dedicated asset monetisation cell within the finance ministry or Niti Aayog to provide technical support. This will open a new resource stream for states to undertake infrastructure and developmental projects. Agriculture, the backbone of rural livelihoods, must also be revitalised. States with lower irrigation levels can replicate successful models from Telangana and Madhya Pradesh. Extending concessional loans for climate-resilient irrigation systems will bolster productivity and

counter erratic monsoons.

To reap the demographic dividend, the Centre and states must work together to provide quality education, healthcare, and jobs for the youth. For job creation, integrating state and national employment databases under a National Career Service platform, enhanced with AI-driven matching, can bridge the skills-opportunity

Healthcare access can be significantly improved by adopting hub-and-spoke models for service delivery in small towns, complemented by digital command hubs and e-ICUs to ensure quality care in remote areas. States also have a

## Just a month old, but condition of Tambaram's new hospital critical

Chennai .(Agency)

Only a month has passed since its inauguration, but the new Government District Headquarters Hospital in Tambaram has started showing symptoms of neglect, with lack of essential amenities and staff shortage putting strain on most services. When the officials say the hospital, built at a cost of '110 crore and inaugurated by Chief Minister MK Stalin on August 9, now records a daily footfall of over 2,500 outpatients and inpatients, including more than 100 pregnant women, the patients rue that they are struggling with inadequate and unhygienic toilet facilities on almost all six

On the ground floor, which houses the Outpatient Department and the pharmacy, toilets for both men and women remain in poor condition. "I have admitted my son here. Of the three bathrooms on the ground floor, only one is usable. Most of the time, there is no water.

There is no mug either," said Rajeshwari, an attender, to . Long queues were found outside the pharmacy with only two staff tasked with issuing medicines. A 59-year-old Muniyammal from Mudichur said that the average wait time outside the pharmacy was half an hour when the consultation itself lasted only ten minutes.

With a few functional women's toilets and long queues, some women said they are often left with no option but to use the men's toilets, "which at least have water and mugs". also witnessed the struggle of a patient, who vomited in the basin, with no means to clean up.

On the second floor, which houses the operation theatre, labour ward and antenatal ward, patients said there is no drinking water facility. This forces many daily-wage workers to buy water from outside.

"I work as a construction labourer and earn '800 a day. I came here for my wife's delivery, but there is no drinking water on the floor. I spend over `180 a day for buying water from outside,' said Ponnaiyan, an attendant. Food served in the labour ward is also reportedly delayed -breakfast came only by 11 am and lunch by 2 pm, the patients said.

The threat, sent by an email under the name 'Kanimozhi Thevidiya', mentioned that the Delhi High Court's judge chamber would be "detonated shortly". It also claimed to "recreate" the 1998 Coimbatore blasts in Patna later today and threatened an acid attack on Udhayanidhi Stalin's son, Inbanithi.

## Haryana help sought to pump out floodwater from southwest villages

The Delhi government has sought help from Haryana to drain out the floodwater from Jharoda Kalan and some areas of Najafgarh that were inundated after a 50-foot embankment of Mungeshpur drain was

The breach occurred on Tuesday evening, leading to nearly five feet of water entering Geetanjali Enclave and adjoining pockets of Jharoda Kalan village near Baba Haridas Nagar in Dwarka. We are pumping out the water using submersible pumps but it is taking time," an official said. He added that they have sought help from the Haryana government to deploy manpower and pumps to aid the operation. "Waiting for the sun to dry the water will take a considerable amount of time. We have asked them to help us in the operation," the official said. The evacuated people have been housed in temporary shelters at Baba Haridas Temple and an MCD school in Jharoda.

Officials said the Chief Minister's Office (CMO) has set in motion the process for providing compensation to affected people. The CMO has sought a report from the district magistrates of the 11 revenue districts on the losses incurred by farmers due to flooding.

"The CMO has sought a report from the district magistrates of the 11 revenue districts on the losses incurred by farmers. While six districts -- North, Central, East, Northeast, Southeast and Shahdara -- have been majorly hit, there is a possibility that crops may have been affected in other districts too," a senior official said.

The official said all the district magistrates have been asked to compile a report and submit it to the divisional commissioner's office. The report will then be forwarded to the CMO.

# Pak-linked arms smuggling bid foiled in Punjab, 2 arrested with pistols and ammo

The Border Security Force (BSF) and the Crime Investigation Agency (CIA) seized a large cache of weapons and ammunition in a late-night operation in Punjab Fazilka district, foiling what officials described as a Pakistan-backed terror smuggling attempt. Two suspected smugglers were arrested during the raid.

According to officials, the joint operation was carried out in Theh Kalandar village following specific intelligence developed by the BSF in coordination with CIA Fazilka.

The teams recovered 16 pistols, 38 magazines, 1,847 live rounds and a motorcycle. The arrested men have been identified as residents of Jhok Dipulana and Mahatam Nagar villages in Fazilka.ce India's Asia Cup win in 2023.

The BSF said the intelligence input had pointed to a smuggling attempt across the border, prompting the



meticulously planned raid. Officials called the seizure a major success, saying it dealt a blow to a larger narcoterror plot linked to Pakistan and averted a potential threat to national

The Bronco Test is a high-intensity aerobic drill used to assess a player's endurance, speed, and overall cardiovascular fitness. It consists of shuttle runs over 20, 40, and 60 meters. One complete set includes all three distances, and players must complete five sets in succession — covering a total of 1,200 meters — without any rest. The benchmark time to complete the test is under six



minutes. Several Indian players recently took the test at the BCCI's Centre of Excellence in Bengaluru, and again after arriving in Dubai for the Asia Cup 2025. The fitness drill was introduced to the Indian setup on the recommendation of Adrian Le Roux, who returned as the team's strength and conditioning coach in June 2025. "I think being honest in your assessment of players is very important. Coming from a place with no agenda is also crucial. If you can approach things objectively, that's invaluable. I haven't spoken about anyone's frailties; what I've highlighted is how the modern game is played and how the strike rate required in the powerplay is very different from the past, especially in good conditions," Hesson told the reporters on Thursday.As coaches or selectors, all players ask for honesty-clear feedback on what they need to work on. If they address those areas, there's always a way back into any team. You can't let personal relationships with players prevent you from being honest."Players who want to improve and contribute need clear role definitions, and it's their responsibility to work on them. point margin after the first deuce. Satwik and Chirag's road to the semi-final has not been easy. On September 11, the duo battled back from a game down to defeat Thailand's Peeratchai Sukphun and Pakkapon Teeraratsakul 18-21, 21-15, 21-11 in an hour and three minutes.

The Thai pair, ranked world No. 42, had shocked the Indians by snatching the opening game 21-18 with sharp net play and stubborn defence. However, the World Championships bronze medallists regrouped quickly, tightening their attack and dictating the pace in the second game.In the decider, Satwik's thunderous smashes and Chirag's lightning reflexes at the net left the Thais with no answers as the Indians stormed to a dominant finish.
