"Can't Blackmail Government": DK Shivakumar On CEO's Bengaluru Roads Post

Bengaluru. (Agency)

Bengaluru is growing rapidly, and the Karnataka government will ensure that no company leaves the IT capital over infrastructure-related issues, Deputy Chief Minister DK Shivakumar assured today.

Mr Shivakumar, minister for Bengaluru Development and Town Planning, spoke exclusively to NDTV at a time when the Congress government is facing criticism for the poor condition of roads. The latest flashpoint, which has given ammunition to the opposition, BJP, is a logistics firm CEO's announcement that it had decided to shift its office out of the city's Outer Ring Road due to traffic snarls.

Asked about the state government's roadmap for India's Silicon Valley, he said, "Bengaluru became too big, so more needed to be done. To meet these demands, we formed five corporations. And for bigger projects, we decided to bring in the Greater Bengaluru Authority."

Mr Shivakumar said many areas in the city that house the "IT crowd" -- meaning techies -- are still under panchayats and not the Greater Bengaluru Authority yet, complicating civic response. "We are trying to bring them under GBA. There are big challenges, and we have formed a separate corporation for this area to fix the problems."

The unrest was triggered by a government ban on social media and quickly evolved into a larger campaign against corruption and perceived political apathy. At least 74 people have died in the unrest.

Karki's appointment to lead the Himalayan nation ended days of political uncertainty after Oli stepped down on September 9 shortly after hundreds of protesters entered his office demanding his resignation. She has declared all those killed in the protests as "martyrs".

On Wednesday, Nepal observed a national day of mourning to honour the protest victims. While all government offices and educational institutions remained closed, candlelight vigils were held in several parts of Nepal, including Maitighar Mandala in Kathmandu, where protests took place on September 8.

All government offices and Nepali missions abroad flew the national flag at half-mast.

Rahul Gandhi wants to create Nepal-like unrest in India: BJP on vote chori charge

Rahul Gandhi wants to create Bangladesh and Nepal-like situation in India, BJP's Anurag Thakur said while slamming his 'vote chori' charge against the Centre and Election Commission.

"Rahul Gandhi wants to create Bangladesh and Nepal-like situation in India," BJP's Anurag Thakur clapped back at the Congress leader after his explosive press conference on 'vote chori'. Gandhi, who had warned of dropping a 'vote chori hydrogen bomb', today came all guns blazing with "undeniable proof" of systemic voter fraud by the BJP and the Election Commission.

"While the Election Commission of India is functioning without bias, Rahul Gandhi is busy weakening democracy, misleading citizens, and trying to create a situation like Bangladesh and Nepal," Thakur said. He further slammed Gandhi and said that he was frustrated as Congress lost 90 elections under him and is now resorting to "baseless and incorrect allegations". Further, he said that while Gandhi was supposed to drop a

'hydrogen bomb' in today's press conference, he came only with firecrackers.

"The Congress has lost approximately 90 elections under the leadership of Rahul Gandhi. His frustration is increasing day-by-day... It has become a habit of Rahul Gandhi to make incorrect and baseless allegations.

Seeking apology and being reprimanded by the courts have become a routine of Rahul Gandhi," Thakur said.

Gandhi, who came prepared with a PowerPoint presentation and names were being struck off electoral rolls through software manipulation and fake applications. Minorities were being specifically targeted, he said, before presenting case studies from Karnataka's Aaland.

Ahead Of Bihar Polls, Nitish Kumar Announces Rs 1,000 Monthly Allowance For Unemployed Graduates

New Delhi. (Agency)

Bihar Chief Minister Nitish Kumar on Thursday announced a Rs 1,000 monthly allowance for each unemployed youth, in a move seen as a major outreach to young and first-time voters ahead of the Assembly elections.

In a post on X, CM Kumar reiterated his government's commitment to youth empowerment, noting that since 2005, job creation and employment have been a top priority.

He stated that the state has set a target of providing government jobs and employment to one crore youth in the next five years, with large-scale opportunities to be created in both

government and private sectors.

The Chief Minister said that under the Chief Minister's Self-Help Allowance Scheme, part of the state's flagship 7 Nischay programme, benefits will now be extended to unemployed graduates. Previously, the scheme was available only to intermediate pass candidates.

Now, graduates aged 20-25 years, who are neither studying, employed, nor self-employed, will receive an allowance of Rs 1,000 per month for up to two years.

Kumar expressed hope that the assistance would help young people pursue skill training and prepare for

competitive examinations.

"This visionary initiative of the state



government aims to provide maximum employment opportunities to the state's youth. Educated youth here will become self-reliant, skilled, and

employable, enabling them to contribute significantly to the development of the state and the nation," the Chief Minister said.

Earlier on Wednesday, Nitish Kumar transferred Rs 5,000 each to 16.04 lakh construction workers as a direct financial assistance to construction workers across the state, a move being described in political circles as a major step ahead of the upcoming elections. The financial assistance was given on the occasion of Vishwakarma Puja and Prime Minister Narendra Modi's birthday.

Delhi Chief Minister Mrs Rekha Gupta yesterday formally launched three new academic curricula NEEEV (New Enterprise and Entrepreneurship Development Scheme), Science of Living, and Rashtraneeti (National Policy). The Chief Minister stated that this initiative marks a revolutionary step in the field of education, designed not only to impart academic knowledge but also to empower students with life skills, entrepreneurship, emotional intelligence, and a sense of responsible citizenship. The programme held at Bharat Mandapam was attended by

Delhi's Education Minister Mr Ashish Sood, senior officials of the concerned department, and other distinguished guests. The Directorate of Education, Delhi has developed these curricula. On the occasion, Chief Minister Mrs Rekha Gupta remarked that the purpose of this initiative is to prepare students for the future by combining academic learning with essential life skills and civic responsibility. She explained that these three curricula have been introduced across all government schools in Delhi for millions of students, with the broader aim of nation-building. The Chief Minister highlighted that the new courses are intended to instil a business mindset in children from an early age,



introduce them to artificial intelligence (AI), and enable them to become competent and self-reliant. The goal, she emphasised, is to shape students not merely as job-seekers but as future job-creators. She further noted that

through the Science of Living curriculum, children's personalities would be refined in all aspects, while nurturing sensitivity and compassion towards society. The Chief Minister added that these curricula have already been shared with the teaching community and form a key component of the Seva Pakhwada (Fortnight of Service), aligning with the vision of Hon'ble Prime Minister Shri Narendra Modi. Mrs Rekha Gupta made it clear that the government would ensure no shortage of resources for schools, whether in terms of toilets, laboratories, playgrounds, or other facilities.

She reiterated that her priority is not the construction of large buildings or flyovers, but the creation of better schools and the guarantee of quality education. She urged teachers to carry forward this educational mission so that Delhi's government schools set new benchmarks, produce capable citizens, and play their rightful role in nation-building. The Chief Minister further assured that government schools would in no way lag behind private institutions; rather, they would excel, nurture talented students, and build a stronger future. She announced that this initiative will remain ongoing, with more new programmes to be introduced in the coming months.

Delhi Education Minister Mr Ashish Sood shared that a 15-day Seva Pakhwada is being organised to mark the birthday of Hon'ble Prime Minister Shri Narendra Modi. He called upon teachers to actively support the effective implementation of these initiatives and to disseminate the message across the teaching community. He emphasised that every student is not merely a learner, but also a potential future Prime Minister, scientist, entrepreneur, judge, soldier, artist, teacher, or leader. The strength of a nation, he stressed, does not lie in its buildings or military power, but in the character, values, and sense of responsibility of its citizens.

Mr Sood further stated that education must not be confined to academics alone. New Metro's Cyber City terminal plan hits roadblock over RRTS alignment in Gurgaon

Gurgaon. (Agency)

The plan to finalise the terminal station of Gurgaon Metro at Cyber City remains stuck in a limbo, with state agencies still unable to resolve differences over the proposed location of RRTS station. So, the uncertainty over the proposed RRTS station location — critical to finalising the alignment — is hindering the metro project. A high-powered committee (HPC) meeting, chaired by chief secretary Anurag Rastogi, was held on Wednesday, but no breakthrough was achieved. National Capital Region Transport Corporation (NCRTC) has maintained that the station can be built at Shankar Chowk, though it is willing to shift the entry and exit points slightly. However, Haryana State Industrial and Infrastructure Development Corporation (HSIIDC) is not convinced. NCRTC has earlier said that a sharp curve in the RRTS corridor's alignment has left little flexibility to plan the station elsewhere, but HSIIDC has raised objections, citing the possibility of severe traffic disruptions in the area. A senior official of GMRL said, "Until the location of the RRTS station is finalised, we cannot freeze our terminal station. There is continuous deliberation on the matter and we are hoping some consensus will be achieved soon." In July, the state govt set up a six-member committee chaired by additional chief secretary (town & country planning) AK Singh to resolve the issue. HSIIDC has pointed out that the proposed NCRTC station in Sector 18 will stand opposite the planned GMRL Cyber City station and next to the existing Rapid Metro facility. According to the agency, this clustering of stations could lead to congestion and excessive crowding on adjoining roads.

NCRTC, however, has argued that keeping stations in close vicinity is beneficial, as it improves commuter convenience, enables seamless interchanges and enhances financial viability. A detailed traffic study to assess the impact of the proposed station and its integration with other networks is being undertaken by the NCRTC. GMRL, meanwhile, has maintained that integrated planning is essential so that the Namu Bharat station and the metro are connected at Cyber City.

3 teams set up for probe, raids in MobiKwik fraud case

Three teams have been formed to investigate and conduct raids in Faridabad, Palwal and Nuh to arrest suspects who allegedly swindled Rs 40 crore from the account of digital payments firm MobiKwik earlier this month. A senior police officer said on Wednesday that cops are working closely with representatives of MobiKwik Systems to obtain technical details and transaction data. "We are also investigating whether any company employees were complicit in the fraud. If found guilty, they will face strict legal action," the officer said. The fraud was reported on Sept 13 after a company employee flagged an internal audit that detected suspicious transactions. Preliminary investigations suggest that fraudsters exploited a technical vulnerability that occurred after MobiKwik updated its software earlier this month. The glitch apparently allowed users to send amounts higher than their wallet balances and enabled transactions even with incorrect PINs. TOI reported on Wednesday that the company lost Rs 40 crore in thousands of transactions carried out on Sept 11 and 12. At least 2,500 beneficiary bank accounts were involved. On Tuesday, police arrested six suspects - Rehan, Waqar Yunus, Wasim Akram, Mohd Amir, Mohd Ansar and Mohd Sakil — five of them from Nuh and one from Palwal. Cops said the suspects were held as their accounts were found containing Rs 9 lakh of the stolen money. All six were charged under sections 318(4) (cheating) and 314 (dishonest misappropriation of property) of BNS. The company had said it has recovered around Rs 14 crore through its own efforts, bringing the estimated net impact down to Rs 26 crore.

Haryana govt tightens food safety inspections before festive rush

An IAS officer was on his regular coffee run when he noticed the milk in his drink smelled off. He raised the issue with the nodal officer of the food safety department. It led to a crackdown on the Barista Coffee outlet at MGF Metro Mall on MG Road. Despite repeated attempts, the coffee chain officials refused to comment. Acting on the complaint, the department conducted surprise checks on Wednesday and seized a milk sample for lab testing to test for possible adulteration or contamination. The action comes at a time when the Food Safety Department, as part of its larger pre-Diwali drive, is aimed at ensuring public health and hygiene during the festive season, when food consumption is at its peak. However, it isn't clear if such an incident would bring cafes under the ambit of surprise inspection of the department.

In a related inspection, the department also raided a namkeen manufacturing unit located in the Basai industrial area. During the raid, samples of besan and refined oil were collected for lab analysis. This inspection was prompted by a



separate complaint from an official within the Government of Haryana, who alleged the unit was producing substandard or adulterated food items.

Ramesh Chauhan, district food department nodal officer, confirmed that all samples have been sent for rigorous laboratory testing, and strict action will be taken

based on the results. "These inspections are not random. They are driven by credible complaints, some of which come from senior government officials. Our goal is to ensure that no compromise is made on food safety during Diwali," Chauhan told TOI. The Haryana govt has also intensified its fight against food

adulteration with major raids on paneer manufacturing units in Nuh, where officials seized large quantities of fake paneer made using soybean, palm oil, and even chuna (calcium hydroxide) instead of milk. The operation, led by Chauhan along with the state's flying squad and CID, uncovered shocking practices at five dairies in Block Punhana — Haryana Dairy Godhala Punhana, M R Paneer Dairy Godhala, Ishrayal Paneer Dairy, Pandit Ji Dairy, and Wahid Dairy.

Officials said samples were taken from each unit and sent for laboratory testing to confirm the level of adulteration. "The Food Safety Department has also issued notices to the owners of these units, asking them to present valid FSSAI licences. Units failing to do so will face closure and strict legal action," an official added. During the raids, officials seized 300 kg of fake paneer on three consecutive days, followed by 700 kg in one raid and 1,200 kg in another. Experts warn that the chemicals used in the making of such paneer can cause severe health problems ranging from stomach disorders to long-term organ damage.

Cleanup efforts falling short Demolition waste mounts on Gurgaon-Faridabad road

Days after MCG cleared construction and demolition (C&D) waste from the Gurgaon-Faridabad road, the stretch has once again turned into a dumping ground. Despite a special drive and a visit by the MCG commissioner, Pradeep Dahiya, during the cleanup, construction debris reappeared on the road. The recurrence makes it clear that the corporation failed to implement deterrent measures against repeat offenders. Residents and commuters question why the civic body limits its role to periodic clean-ups instead of finding a long-term solution.

The MCG had set a Sept-end deadline to clear C&D waste from the Gurgaon-Faridabad road and Sector 29. A week ago, the commissioner and additional commissioner Ravinder Yadav visited both locations to inspect the debris removal process. "We will increase enforcement and register FIRs against those found dumping construction waste on the roads and public places," the commissioner said. Ankit Tripathi, a commuter, said, "Barely days after the construction waste was cleared from the

road, debris resurfaced, raising serious questions over why such a basic issue of unauthorised dumping remains unchecked. The fresh dumping has undone the civic body's earlier efforts, rendering the clean-up meaningless."



"In the absence of an efficient C&D waste management system, expecting no fresh construction waste to be dumped on the roads is asking too much," said Gauri Sarin, founder of the citizens' group Making Model Gurugram, adding, "There are no designated points for C&D waste dumping, there is no helpline, and no patrolling. There should be a completely seamless system. The civic body should first identify the sources."

Environmentalist Vaishali Rana said, "At these sensitive points, such as the Gurgaon-Faridabad road, there should be strict surveillance, and patrolling teams should check the site at least three times a day. We also need to understand that people don't have an alternative, where would they dump?" Earlier, CM's chief principal secretary Rajesh Khullar held a series of meetings with MCG and GMDA officials between Aug 13 and 18. He instructed that no construction debris or garbage should remain on the roads and asked for a strict action plan. Subsequently, MCG began clearing waste from dumping hotspots. In a single-day clean-up drive held recently, over 2,800 tonnes of waste were removed as a lakh-plus volunteers and sanitation staff joined a citywide cleanliness drive organised by MCG and the district administration. The state govt in Aug had approved the long-pending proposal to enhance the capacity of the Basai C&D waste plant from 300 metric tonnes per day (TPD) to 1,200 TPD. According to MCG estimates, the city generates nearly 1,500–2,000 tonnes of C&D waste daily.

PM10 Haryana's major pollutant: Report

PM10 accounted for the largest chunk of emissions in Haryana in 2019, followed by methane and nitrogen oxides, according to the state's first inventory of non-CO2 (carbon dioxide) pollutants. Coal-burning industries, brick kilns and thermal power plants are the main contributors to PM10 emissions, which were calculated at 411.5 kilotonnes, or 26% of non-CO2 emissions, in 2019, the study by the Institute for Governance & Sustainable Development (IGSD) and The Energy and Resources Institute (TERI) found. Of the total, almost two-thirds (261kt) of PM10 was released from industries across the state. Agriculture came in second, at 88.9kt, and transport third, at 21.2kt.

The study, carried out with the help of Haryana State Pollution Control Board (HSPCB), also warned that without

interventions, the state could see pollution levels spike by 2047. PM2.5 levels could go up 37%, nitrogen oxides 47%, and black carbon 43%, compared to 2019, it said. A majority of other key pollutants, the research found, stems from the transport sector. Vehicles account for 75% of Haryana's NOx emissions and 63% of volatile organic compounds (VOCs), besides contributing significantly to black carbon and PM2.5.

Waste management presents another challenge, with methane emissions from landfills alone totalling 38.6 kilotonnes in 2019. In all, methane made up for 20% of the share of non-CO2 pollutants in Haryana that year. Experts said policy interventions were necessary to reduce emissions. "Short-lived climate pollutants are a major hurdle in the state's journey towards a cleaner future. This report can

help eliminate such hurdles and ensure a better future for Haryana," said Zerin Osho, IGSD director. Sudhir Rajpal, additional chief secretary for environment, emphasised the need to balance development with environmental sustainability. "Our future prosperity depends on prioritising the mitigation of short-lived climate pollutants, which have an immediate and powerful impact on our climate," he said. The report, published on Tuesday, said household LPG penetration, crop residue management, cleaner cookstoves and industrial controls would help Haryana cut down its pollution burden. Other measures — including solar cooking adoption beyond 2040, community boiler systems in industries, and crop diversification — can steer sharper reduction in pollution levels, it said.

Monitor infrastructure projects to ensure quality, Union minister Rao Narbir Singh tells Gurgaon residents

Union minister Rao Narbir Singh has urged people to monitor the ongoing development projects in their areas to ensure quality of work. He said by the end of Oct, drainage cleaning work will be undertaken, all roads will be strengthened and sidewalks repaired.

The authorities have been facing criticism for the poor quality of work. The roads constructed a few months back are filled with potholes after the rain, leading to congestion and breakdown of vehicles. Speaking at the cleanliness festival launched by MCG on Wednesday, the minister also called on the public to stop using polythene, start using bags of cloth and keep their areas clean for environmental protection. Moreover, the minister, along with officials, municipal councillors, and citizens, participated in a cleanliness drive in ward 18 of Badshapur in an attempt to spread awareness on the importance of maintaining cleanliness.

Multiple agencies have prepared a plan to repair roads falling under their jurisdiction and damaged during monsoon. MCG identified 110km of roads for restoration, which will cost around Rs 60 crore. An estimate of Rs 17 crore was prepared for the repair of 29 roads spanning 23km under the PWD department. Similarly, an estimate of Rs 9 crore was prepared for the repair of 72 roads, over 13km, in the Pataudi area. Out of the 110 roads under the Haryana State Agricultural Marketing Board, 2 roads in Budhera were damaged during the monsoon, and repair work on these will start soon. Stating that since the country aimed to become a developed nation by 2047, the minister said every citizen should work towards a clean environment, clean air, and pure water. "Cleanliness should not just be symbolic. It should become a part of daily life. The use of plastic and polythene causes severe environmental harm.

391 cos on Hindon basin, just 13 pumping effluents into river: UP

Ghaziabad. (Agency)

Out of 391 industries, identified in the Hindon basin, only 13 units were found non-compliant in terms of causing pollution and show-cause notices were issued to them. UP acting chief secretary Deepak Kumar has informed National Green Tribunal (NGT) through an affidavit. Filing the state's reply in a case (Abhisht Kusum Gupta vs State of UP and others), being heard by the tribunal since 2022, Kumar also said an environmental compensation of Rs 166 lakh was imposed on 53 defaulters, of which Rs 97 lakh was recovered.

However, a report prepared by the district magistrates of the districts — through which the Hindon flows — reveals that one of the major contributors to pollution in the river continues to be industrial waste discharged through various drains. There are as many as 72 grossly polluting industries (GPI) in Ghaziabad and 18 in GB Nagar flushing their wastewater into the Hindon. Of the 72 GPIs pumping industrial waste into the Hindon in Ghaziabad, 43 industries — comprising seven dyeing units and 36 yarn/textile processing units — push effluents through the Jawli drain (300km mark of the river). Another nine GPIs — comprising seven



textile processing units and one each of paper and metal surface treatment units — discharge their wastewater into the Hindon at 309.44km through the untapped Karedha drain. Twelve more GPIs — comprising metal surface treatment units, pharmaceutical industry and tannery — release wastewater into the Hindon at 313.07km through the Kaila Bhatta drain. One industry (distillery) through the Arthala drain at the 313.63km mark of the Hindon and seven more industries — comprising metal surface treatment, pulp and paper industries, besides a slaughterhouse — were found releasing water into Bhoorgarhi and Kalugarhi drains that join

the Dasna drain to finally pour into the Hindon. Removal of solid waste, action on the polluting industries, creation of wetlands and installation of decentralised water treatment facilities are some of the suggestions included in the report prepared by the DM office. Various authorities, including the forest department, UPSIDA, State Pollution Control Board, UP Jal Nigam and the urban local bodies, have been identified as enforcement agencies accountable for taking action. In GB Nagar, around 18 GPIs were found causing pollution to the river. Two industries — one each of pulp-paper and textile — empty into the Dasna drain near Yusufpur village, which joins

the Hindon at 323.01km. Effluents from 15 polluting industries, comprising hologram stickers, paint and varnish, textile processing, moulded plastic, beverage plant, rice mill and slaughterhouses, empty into the Hindon at 355.68km through the Hawaliya.

DDA identifies 1,769 hectares in Dwarka sector 19 for development

The Sikh Times

New Delhi: The Delhi Development Authority (DDA) has identified 1,769 hectares of land in Dwarka Sector 19 and its adjoining villages for infrastructure development. In the first phase of the project, a firm will be hired to survey the area and assess the current state of infrastructure. Based on the findings, a comprehensive road and drainage network will be developed, a senior DDA official said. "Some work is already going on in the area. We plan to construct a road and drainage network in the land pockets identified first, later on, future development work might be taken up and a tender has been issued in the regard," official said. In the past few months the land-owning agency has been pushing for development of areas in outer Delhi, including Dwarka and Narela. The DDA, in its budget announced in April for sports activities, has allocated '250 crore for the construction of new sports complexes — one in Dwarka, while the Dwarka Sector-8 centre of excellence has already been inaugurated by LG VK Saxena, and another facility is coming up in Sector-19. The agency has directed the contractor to take strict measures for dust control management works during construction. Proper drainage along the road also has to be maintained with proper bell mouths, keeping in mind the frequent urban flooding events, officials added. The plan which includes the construction of roads, drains and guest houses, will be carried out at a cost of '3.2 crore, within six months. The completion report of the plan also needs to be prepared within the six months deadline. The DDA has also taken into account three nearby villages — Amberhai, Bagdola, and Manglapuri — where the development work will begin.

Donald Trump says designating Antifa 'a major terrorist organization'

WASHINGTON. (Agency)
US President Donald Trump on Wednesday said he would designate "Antifa" -- a shorthand term for "anti-fascist" used to describe diffuse far-left groups - - as "a major terrorist organization," a move he has threatened since his first term.
"I will also be strongly recommending that those funding ANTIFA be thoroughly investigated in accordance with the highest legal standards and practices," Trump wrote on Truth Social, calling Antifa "A SICK, DANGEROUS, RADICAL LEFT DISASTER."Trump on Monday threatened to go through with such a designation after senior White House official Stephen Miller vowed the administration would dismantle an alleged "vast domestic terror movement" that he linked to the killing of right-wing activist Charlie Kirk.
Trump since his first term has ascribed blame to Antifa for various actions he dislikes, from violence against police to conducting the US Capitol riot on January 6, 2021.While federal law enforcement includes combating domestic terrorism under its purview, the United States does not have a list of designated "domestic terrorist organizations."

3 Police Officers Killed, 2 Injured In US' Pennsylvania Shooting, Suspect Dead

Three police officers were fatally shot and two wounded Wednesday in southern Pennsylvania, and the shooter was killed by police, authorities said.
The group of officers were at the scene to follow up on a domestic-related investigation that began the prior day."We grieve for the loss of life of three precious souls who served this county, served this commonwealth, served this country," Gov. Josh Shapiro said."This kind of violence is not OK, we need to do better as a society," he continued.
The shooting erupted in the area of North Codorus Township, about 115 miles (185 km) west of Philadelphia, not far from the Maryland line, authorities said."The grief will be unbearable but we will bear it," Pennsylvania State Police Commissioner Christopher Paris at a news conference. "We will not rest until we conduct a full, fair and competent investigation into this matter."
York Hospital said it was treating two people in serious condition and had enhanced security protocols are in place.Authorities did not identify the shooter, the officers or which police department they belonged to, or describe the circumstances of how they were shot. Police could not share many of the details because the investigation is ongoing, Paris said.
Attorney General Pamela Bondi called the violence against police "a scourge on our society." She said federal agents were on the scene to support local officers."Please send prayers to the officers and those involved in the shooting in York County," Pennsylvania Lt. Gov. Austin Davis said in a social media post.A local school district issued a shelter-in-place order, though it said schools and students were not involved in the shooting. The order was lifted later in the afternoon. The district said in a statement that authorities "advised us to hold students and staff in our buildings as a precaution while several area roads are closed."The medical response unfolded on a rural road in south-central Pennsylvania that winds through an agricultural area with a barn and farm fields.Officers were keeping people well back from the scene in the area's rolling farmland, with some 30 police vehicles blocking off roads bordered by a barn, a goat farm and soybean and corn fields.
"Pennsylvania State Police, Northern Regional Police and numerous emergency responders are at the scene. The York County Commissioners are monitoring the situation closely and praying for all those involved," the county said in a statement.An officer in the area was killed in February, when a man armed with a pistol and zip ties entered a hospital's intensive care unit and took staff members hostage before a shootout that left both the suspect and an officer dead.

The company sent out an email to its staff informing them of its

What Is Antifa Group Tagged "Terror Organisation" After Charlie Kirk Murder

US President Donald Trump on Thursday announced that he is designating the left-wing group 'Antifa' as "a major terrorist organisation" and also warned that those funding it will be investigated "with the highest legal standards and practices".This has happened days after Trump's close aide and right-wing political activist Charlie Kirk was assassinated.
It is a secretive grouping of radical activists that has emerged in recent years. It is not known to have official leaders. Its members, often dressed entirely in black, protest against racism, far-right values and what they consider fascism, and say violent tactics are sometimes justified as self-defense.
Antifa members view themselves as part of a protest tradition that arcs back to opposition groups in Nazi Germany and fascist Italy prior to World War II. US antifa activism traces its roots back to antiracists who mobilized in the 1980s while opposing the activities of racist skinheads, members of the Ku Klux Klan (KKK), and neo-Nazis.
Antifa groups in US
Antifa groups in the United States gained prominence



following violent clashes between white supremacists and their opponents, including antifa supporters, in Charlottesville, VA, on August 12, 2017.The groups have been increasingly active in protests and rallies over the past few years, especially ones that include far-right participants.In June 2016, for example, Antifa and other protestors confronted a neo-Nazi rally in Sacramento, California, with at least five people stabbed.In February, March, and April 2017, Antifa members attacked alt-right demonstrators at the University of California, Berkeley using bricks, pipes, hammers, and homemade incendiary devices.
In July 2019, William Van Spronsen, a self-proclaimed Antifa, attempted to bomb the US Immigration and Customs Enforcement detention facility in Tacoma, Washington, using a propane tank but was killed by police. Trump since his first term has ascribed blame to Antifa for various actions he dislikes, from violence against police to conducting the US Capitol riot on January 6, 2021.Trump's previous FBI director, Christopher Wray, said in testimony in 2020 that antifa is an ideology, not an organisation, lacking the hierarchical structure that would usually allow it to be designated as a terror group by the federal government.

Russia Says It Advances On All Ukrainian Fronts

A senior Russian officer toured positions held by his troops in Ukraine on Wednesday and said Moscow's forces were advancing on all fronts, the Russian Defence Ministry said, with the heaviest fighting taking place around the logistics centre of Pokrovsk.General Valery Gerasimov, Russia's chief of staff of the armed forces in what Moscow calls its "special military operation", said Moscow's troops were making progress in the eastern Donetsk region, the conflict's focal point, and further west in the Zaporizhzhia and Dnipropetrovsk regions.
"Our troops in the zone of the special military operation are advancing in practically all directions," the Defence Ministry quoted Gerasimov as saying."And the heaviest fighting is occurring in the Krasnnoarmeisk direction," he added, using the Soviet-era name for the city of Pokrovsk, "where the enemy, by any means and taking no

account of losses, is trying unsuccessfully to stop our advances and seize back the initiative."The Ukrainian military, he was quoted as saying, "has deployed the best-trained and most capable fighting units, taking them from other areas. And that facilitates the advance of our troops in other sectors."
In their slow advance through eastern Ukraine, Russian forces have maintained heavy attacks on the area around Pokrovsk in the Donetsk region for months.
Gerasimov said Russian forces were also making progress in taking Kupiansk, a largely destroyed city in Ukraine's northeastern Kharkiv region, and Yampil, further east.Gerasimov's statements appeared to be at odds with accounts by Ukrainian President Volodymyr Zelenskiy and



Ukrainian military officials, however. Zelenskiy, interviewed by Sky News this week, said he expected new Russian offensives but added that Moscow's forces had enjoyed little frontline success in their

recent activity."On the whole, I am truly pleased that the last three Russian offensive drives have failed, though they are planning two more serious offensives," he said. "In my view, this is an important signal."A Ukrainian commander this week said his forces had fended off a Russian advance near Pokrovsk, while the popular Ukrainian military blog DeepState, which uses open-source maps to track troop movements, reported Ukrainian successes in a nearby town.A spokesperson for a Ukrainian unit near Kupiansk said on Wednesday that an attempted Russian advance on the town had resulted in many of its men being taken prisoner.

ACB seizes Rs 17 lakh from residence of Telangana power official

A day after the Anti-Corruption Bureau (ACB) arrested Telangana Southern Power Distribution Company (TGSPDCL) Assistant Divisional Engineer (Operations) Ambedkar Erugu in Ibrahimbagh, officials seized Rs 17 lakh from the Chevella residence of another ADE, Rajesh, late on Tuesday. He is suspected to be one of Ambedkar’s benamis. According to officials, both Ambedkar and Rajesh had earlier worked in the same office. Raids were carried out at the houses of Ambedkar and his suspected benamis till late on Tuesday. An ACB official told TNIE that investigators are verifying whether the money recovered from Rajesh’s house belonged to Ambedkar or was his own. Ambedkar was arrested in a disproportionate assets case and remanded to judicial custody till September 29. The probe has also opened the possibility of a separate disproportionate assets case against Rajesh, suspected to be a benami of Ambedkar. It may be recalled that the ACB had earlier seized Rs 2.18 crore in cash from the residence of another suspected benami of the arrested official. The investigation is ongoing.

Roads submerged as Hyderabad reels under heavy downpour

Heavy rains lashed Hyderabad on Wednesday evening, leaving traffic in chaos and citizens wading through knee-deep water. Several areas recorded more than 10 cm of rainfall within two to three hours. Talla Basthi in Musheerabad circle reported the highest rainfall at 184.3 mm till 1 am on Thursday, followed by MCH Colony (156.8 mm) and Bholakpur (155.5 mm). Chilkalguda (147.5 mm), Monda Market (146.5 mm) and Mettuguda (140.3 mm) also witnessed intense showers. Commuters faced severe hardship as major roads were inundated. Visuals of bystanders helping the elderly cross flooded roads and vehicles stranded in gushing waters circulated widely on social media. Other localities hit hard included Miyapur, Hafeezpet, Madhapur, Jubilee Hills, Filmnagar, Yousufguda, Ameerpet, Panjagutta, Somajiguda, Khairatabad, Mehdiapatnam, Tolichowki, Kukatapally, Serilingampally, Gachibowli, Shaikpet, Raidurg, Patancheru, Kondapur, Quthbullapur, Suchitra, Kompally, Gajularamaram, Balanagar, Banjara Hills, Basheerbagh and several parts of the Old City. The India Meteorological Department (IMD) warned that medium to heavy rains are likely to continue across many districts, including Hyderabad, for the next three to four days due to a depression in the Bay of Bengal. Heavy rainfall is expected in Adilabad, Nirmal, Nizamabad, Jagtial, Sangareddy, Medak and Kamareddy, while light to moderate rains are forecast in Hyderabad, Medchal-Malkajgiri, Rangareddy and other districts. Meanwhile, Hyderabad Mayor Gadwal Vijayalaxmi visited Masab Tank during the downpour, reviewed waterlogging and traffic issues, and directed officials to take immediate measures. HYDRAA, GHMC and HMWSSB officials were put on high alert. The mayor said continuous field monitoring was underway and inter-departmental coordination being ensured, urging citizens to stay cautious during the spell of heavy rains.

Within the ambit of its Mithi River widening project, the BMC has taken up the cudgels to reconstruct the bridge between Bandra to Dharavi. The project is being undertaken in two phases in a bid to minimize the flow of river water. On Wednesday, Additional

Municipal Commissioner (Projects) Abhijit Bangar along with senior BMC officials conducted a site inspection of the ongoing bridge works at Bandra. According to officials, nearly 90 per cent of the first phase works have been executed so far with the entire bridge slated to be completed by November 30. In what will provide direct access to the flyover leading up to the Mahim Causeway, two lanes of the southern arm on the existing bridge will be opened to traffic after completion of the first phase. With the first phase nearing completion, the BMC said that the work order on the second phase will



be issued in the coming days with the entire bridge projected to be constructed in a period of 18 months. While reviewing works on Wednesday, Bangar directed officials to ensure that a strict

timeline should be derived before the launch of ground works and NOCs from the traffic department must be procured in advance. “Special care must be taken to ensure that the time period does not increase after the start of work and no inconvenience is caused to citizens,” Bangar told officials. Meanwhile, officials also reviewed ongoing works of the bridge over the nullah near Annie Besant Marg which is aimed at reducing congestion in Worli, Mahalaxmi and Lower Parel by creating a new link. While 30 percent of the project has been executed so far, Bangar said that the project is expected to be completed by December 2026.

Poor road conditions: Two youths killed in accidents in Palghar, Nagpur

In Palghar district, a 19-year-old youth, Smit Hemant Patil of Pikh village in Wada taluka, died on Tuesday morning when his scooter allegedly skidded on the pothole-ridden Wada–Bhiwandi highway and he came under a trailer moving behind him. He was employed with a private company in Vasuri and was the only earning member in his family. Police have registered an Accidental Death Report (ADR) at Wada police station. In another incident in Nagpur, 25-year-old Mahendra Fating died late Tuesday night after



his two-wheeler fell into a long-unfinished pit near the Deputy Signal underpass in Lakadganj police limits. According to police, an iron rod protruding from the half-constructed cement

road pierced his abdomen, leading to fatal internal bleeding. Fating, who worked as a supervisor in a construction material shop, was supporting the education of his younger brothers. Lakadganj police have booked a civic contractor for negligence in connection with the incident. Residents in both regions have alleged that civic apathy and unending repair work have turned major roads into accident-prone zones. While the Wada–Bhiwandi highway has been under reconstruction by Eagle Infrastructure, causing severe traffic disruptions, the Deputy Signal underpass in Nagpur has remained incomplete for nearly five years. Local residents in Nagpur staged protests at the police station demanding the arrest of the contractor and compensation for the bereaved family.

Woman caretaker at school held over sexual assault of 4-yr-old girl

According to police, the child then told her parents that the caretaker had allegedly touched her inappropriately while accompanying her to the bathroom, during which she sustained the injury.

A woman caretaker at a prominent private school in Mumbai was arrested Wednesday for allegedly sexually assaulting a four -year-old girl. Police said the matter came to light after the child complained of pain in her private parts while changing clothes. Her mother, sensing something was amiss, took her to a doctor, where an injury was discovered. According to police, the child then told her parents that the caretaker had allegedly touched her inappropriately while accompanying her to the bathroom, during which she sustained the injury. The parents approached the school administration and narrated the incident, following which the police were informed. The case was registered based on the medical report and the mother’s statement. “The woman was working in the school for more than two years and she was taken into custody on Wednesday morning and produced in the court,” said a police officer. An FIR registered under the Protection of



Children from Sexual Offences (POCSO) Act, was registered based on a complaint filed by the victim’s parents on Tuesday. The accused was produced before the court and has been remanded in police custody till September 19.

Another officer added, “It is a sensitive matter. After the initial verification, it appears that the woman committed the offence. But we have been checking the CCTV footage and will try to verify the incident.”

Bid for Palayam Connemara Market redevelopment to open by month-end

The much-delayed redevelopment of the century-old Palayam Connemara Market is set to see progress as Smart City Thiruvananthapuram Ltd (SCTL) has scheduled the opening of bids for the project by the end of this month. The project has been stuck for years due to disputes over trader relocation, legal hurdles, and disagreements with the original contractor, RDS Projects Ltd. The firm had demanded a 10% mobilisation advance, revised schedule of rates, and cost escalation, citing rising construction material prices and prolonged delays. Authorities, however, refused to agree to these terms, fearing further delays and financial risks. “Providing mobilisation advance and revising rates would only create temptations for further work delays. We are going ahead with the project at existing scheduled rates. The new contractor will be able to complete the structure within 10 months,” said a senior official. The demolition of the old market has already been completed.

“Demolition work is almost done and the new contractor will take off immediately once the tender is finalised. Around 70-80% of traders have already moved to the temporary rehabilitation block built on Trivandrum Development Authority (Trida) land, while the remaining shops are lying unmanned. The redevelopment of the historic market, pegged at Rs 88 crore, has faced stiff resistance from traders and trade unions in the past. While around 400 traders were relocated, Kerala Vyapari Vyavasayi Ekopana Samiti (KVVES) and other groups had challenged the temporary block in court, citing poor construction and pollution issues due to its proximity to a legacy dumpsite. Despite these hurdles, civic officials maintain that preparatory works are now complete, and the fresh tendering process will ensure the project moves forward without further financial disputes. “Once bids are opened and a contractor is finalised, the work can begin without delay,” the official added.

Safai Mazdoor Sangh’s Amod unit said that the sanitation worker who has been caught in the video littering the pathway was “only following instructions”. Solanki said, “In order to celebrate the birthday of PM Modi on Tuesday, a cleanliness drive was organised around 10.30-11am at the Amod Municipality. Our sanitation worker had been called by the official as well as the office bearer (of the BJP) and instructed to bring a bucket full of trash to litter on the ground where the usual sweeping had already been done early morning and there was no garbage to clean as part of the drive...” He said, “We are Class IV workers and we have to follow the orders of the officers; therefore, there was no question that the poor sanitation worker would have defied the orders. He would have been asked to leave (quit his job) immediately... What else could he have done than to follow the



President Prakash Modi told The Indian Express that the party had been made aware about the video involving Patel, and a direction was awaited. The leader said, “The video has come to the notice of the party... I,

too, received it personally from many people and I have, as my duty, informed the party’s state executive leaders. Nepal's lesson: Use youth fury for renewal

The recent convulsion in Nepal began as a backlash against a social media ban and rapidly became something far larger—a Gen Z eruption that struck at the symbols of state and elite power, left scores dead, and ended with the prime minister's resignation and the army moving into the capital to restore order. Reports showed protesters breaching and setting fire to government installations and homes of senior leaders—an intensity and a degree of targeted action that reads less like improvisation and more like careful preparation, while the intelligence community's inability to foresee the build-up remains puzzling.

In Kathmandu's compact political geography, the police's apparent retreat from key posts and the delayed arrival of specialised units created a vacuum the uprising filled; by then, the spectacle of elite residences and state buildings under attack had already rewritten the political map. A resigned police and army attitude is a blessing at times, as it was here because it helped dilute the anger.

What we are watching is not simply the recycling of old grievances, but the emergence of a new template of dissent. Gen Z operates differently—decentralised digital natives organised through viral content, encrypted chats, and ad hoc collectives rather than through political parties or charismatic hierarchies. The movement's leaderless mechanics—nobody to arrest to decapitate the revolt, no single body to negotiate with—recall political scientist Gene Sharp's ideas on decentralised resistance, now updated with social media as the organising architecture. That very structure is liberating for protesters and destabilising for states, because it makes pre-emptive intelligence harder and reactive governance clumsier. Alongside domestic dynamics, the suspicion of an 'external hand' inevitably surfaces; earlier South Asian episodes also prompted similar accusations without conclusive proof. The more productive question is which external powers materially benefit from an unstable Kathmandu—gaining diplomatic leverage, economic foothold, or a security advantage. For now, the winners are domestic: the youth succeeded in toppling a premier, forced policy reversals, and demonstrated quasi-political capability. Allegations at this stage would be conjecture. Turning to Pakistan, a likely candidate for such an upheaval, the parallels are sobering and instructive. Pakistani media is increasingly haunted by the prospect of political failure compounded by economic collapse and social erosion. Repetitive natural disasters are adding to the misery. The macroeconomic stress is well documented. The social picture accelerates the anxiety. Pakistan's precipitous ranking at the bottom of the World Economic Forum's Global Gender Gap report has provoked widespread commentary about the debilitating costs of gender inequality on development, social justice, and human security. Pakistani op-eds often frame the country's dilemma as a triple bind. First, economic stress that deepens grievance. Second, a public sphere awash in identity politics and ideological religiosity. And third, the lack of pragmatic problem-solving and institutions that fail to deliver basic services or protect minorities and women. The result is a rising social frustration that bears an uncomfortable similarity to the grievances that fuelled Nepal's uprising. Add to that a media environment where certain channels and commentators amplify sectarian or ideologically rigid frames that increase the lethality. The comparison with post-Arab Spring cycle of events is an uncomfortable, but useful, mirror. In Egypt, the popular upheaval led to the election of an Islamist government, which itself collapsed a year later under mass protest and military intervention—a process that devolved into a harsh, polarised settlement.

Plug the leaks to reduce flood risk

Punjab should take a cue from Odisha's model, which lays stress on empowering local bodies

FLOODWATER has started receding in Punjab, but the calamity is not yet over. It was one of the worst flood disasters in recent decades, affecting all 23 districts and impacting nearly two million people in over 2,000 villages. Lakhs of people have been displaced, and more than 50 have died in flood-related incidents. Clearly, the agricultural sector has suffered the most, with over 1.7 lakh hectares of farmland submerged. Crops have been damaged, and lakhs of livestock and poultry birds have been left without fodder and shelter. The damage to houses and other infrastructure in villages is massive.

The post-flood situation is more challenging. Health and agricultural rehabilitation are the most immediate tasks. The stagnant water increases mosquito-breeding, leading to malaria, dengue and chikungunya. Water-borne diseases like typhoid, diarrhoea and hepatitis can spike if drinking water remains contaminated. The risk of snakebites has also increased. Since large tracts of farmland are under silt and sand, land would need proper reclamation measures before the next sowing season. The crop cycle, too, has been disrupted due to the loss of standing paddy and delayed sowing of wheat.

While crop damage is visible and immediate steps are needed to help farmers, the authorities should not neglect long-term damage caused to the health and education infrastructure in the state. Floodwater has left 1,280 dispensaries and health and wellness centres, over 100 community health centres and 31 sub-divisional hospitals under water, disrupting essential services and damaging equipment worth several hundred crores of rupees. This is a double whammy. The healthcare delivery has been hampered when it is needed the most to prevent the outbreak of diseases. The damage to the education sector is widespread. About 3,300 government and private schools have either been impacted in various districts. Floods forced their closure, and some of them are so damaged that they will not be able to function for some more time, particularly in the worst-affected areas in Gurdaspur, Ferozepur and Fazilka. School buildings have suffered structural damage in many cases. All this is bound to disrupt the studies of thousands of children. The State Disaster Management Plan (SDMP) of Punjab recognises flood as a major hazard due to the state's high vulnerability. The causative factors are also well recognised. Almost 80 per cent of the rainfall in the state

occurs within three months that coincide with the main cropping season. There is increased encroachment in the floodplains, but the socio-economic conditions of people living there are poor, as the local economy is primarily dependent on the monsoon paddy. There is very little or no forest cover in the flood-prone areas. Beas, Sutlej, Ravi and to some extent Ghaggar have been identified in the state's flood hazard map. Over the years, the flood problem in the Beas, Sutlej and Ravi has been mitigated through the construction of reservoirs and embankments, but flood risk due to high releases from reservoirs and

operational during a disaster.

Kerala, which faces a flood-like situation every year, has taken steps to make its rural health infrastructure disaster-ready. In the 2018 floods, over 330 health facilities were fully or partially damaged in the southern state. While rebuilding health facilities that were completely damaged, the state authorities conducted a detailed vulnerability assessment of each location, incorporated critical design changes and used resilient building technologies and materials. Those partially damaged were retrofitted on similar lines.

All that is needed are small tweaks in design.

For example, all primary health centres in Kerala were earlier single-storeyed, which made them prone to flooding. New ones being developed are multi-storeyed, with upper floors for housing diagnostic equipment, pharmacy, medical records and power supply backup. Thus, even if floodwater enters the facility, vital equipment and records would be safe on the first floor. The hospital safety guidelines of the National Disaster Management Authority stipulate that every hospital in the country spell out the minimum required standards for healthcare facilities. In addition, we need to take several non-structural steps for mitigation of flood impacts, such as building the capacity of local bodies and communities through awareness, sensitisation and training. In this context, the disaster risk reduction initiative of cyclone-prone Odisha is worth studying and emulating.

The Odisha model, praised globally, includes establishing early warning systems, constructing multipurpose cyclone shelters, training community volunteers, creating rapid action forces, empowering local governance bodies and integrating disaster management into development planning at the local level to enable rapid response to disasters like cyclones and floods. A cadre of over one lakh volunteers drawn from gram panchayats, women's self-help groups, etc, have been trained to reduce disaster risk and manage rescue and relief operations. The involvement of the community and civil society holds the key. The flood problem needs a holistic approach both for prevention and risk reduction. Disaster management plans exist, best practices and guidelines have been developed, and successful models like those of Kerala and Odisha are available to study and emulate. All Punjab needs is to implement them and not wait for the next disaster.



breaches in embankments persists. There is a severe problem of soil erosion by water in normal times. About 60 per cent of the soil which is washed away ends up in rivers, streams and lakes, making waterways more prone to flooding as well as contaminating water bodies with fertiliser and pesticide residues. Besides suggesting a range of flood protection measures such as strengthening embankments, improving drainage efficiency, desilting of stream beds, curbing encroachments, revival of village ponds, construction of water harvesting structures and preventing waste disposal in canals and rivers, the SDMP suggested district-specific measures for most flood-prone areas. Given the damage caused to vital infrastructure like health centres and schools during floods, it is imperative to make them safe by adopting new techniques in construction and siting. This way, damage can be minimised and these facilities can be kept

Political parties can't wash their hands of POSH

If the penalty system is designed to act as a deterrent against traffic offences that lead to the loss of numerous lives and property, it is not clearly working. Most owners know challans just pile up

The Supreme Court on Monday dismissed a plea challenging the Kerala High Court's ruling that political parties are not bound to set up internal complaint committees (ICC) under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. The court reasoned that parties are not "workplaces" since their members are not employees. This interpretation may not fully appreciate the broader purpose of the law. The law is rooted in the Vishaka (1997) judgement, in which the top court held that Article 21 obliges institutions to protect women from harassment, regardless of their formal employment status. The Act itself reflects this, broadly defining an aggrieved woman "in relation to a workplace, a woman of any age, whether employed or not, who alleges to have been subjected to any act of sexual harassment by the respondent".

Political parties are hardly voluntary bodies of sympathisers. They issue membership cards, enforce discipline, collect funds, maintain offices, and operate with strict hierarchies. Women workers share the same work burden as men everywhere. They are also vulnerable

to exploitation. A UN Women study noted the prevalence of sexual favours demanded within political parties a decade ago. An Inter-Parliamentary Union survey found



that 82 percent of women parliamentarians had faced psychological violence, including sexual threats and remarks. If political workers exclusively work for a party,

the least they expect is minimum protection from that party. To deny them the benefit of ICCs because they are not employees is as good as dismissing their labour as inconsequential and exposing them to sexual discrimination. Where should an internally harassed party worker turn for help? Criminal law addresses assault. Yet, it cannot replace an internal legal mechanism offering safety, confidentiality, and redress. Without it, women are left vulnerable in political spaces that men mostly dominate. Parties also cannot hide behind the "voluntary association" defence. When NGOs, hospitals, and small workplaces with only 10 employees fall under POSH, political organisations, which wield enormous power, cannot be exempt. If the current law does not bind political parties, parliament must amend it. Till then, explicit guidelines from the Election Commission or the Supreme Court could mandate independent grievance redress mechanisms within parties. Anything less sends the message that women in politics are dispensable—an affront to the spirit of POSH.

‘And time passed by...’: 3 decades after UP youth went missing, police book 7 persons for murder

Three decades ago, on October 5, 1995, a 22-year-old Pradeep Kumar Bajpai, who had gone to the Betwa river for idol immersion, did not return home in Jalaun district of Uttar Pradesh. His worried family began searching for him. They were told by locals that he was “assaulted and drowned” in the river, allegedly by his rivals — all distant relatives and neighbours — with whom the family had a long-standing land dispute.

Pradeep’s family approached the district administration and police to trace and get a complaint registered against those whom they suspected were responsible for his death. However, all efforts to trace Pradeep’s body remained unsuccessful.

His body was never found.

After failing to get assistance from the authorities in getting a case registered, Pradeep’s father, Uma Shankar Bajpai, a retired government employee, approached a local court.

Three years later, in October 1998, the court directed the local police station to register a case. However, no FIR was registered at the time. According to the Bajpai family, the police claimed that a copy of the court did not

reach them. “For months, my father shuttled between the court and the police station to find out why the order had not been delivered. Since he was a government clerk, he could not spare time every day to pursue the matter... And time passed by,” said Devendra Kumar, the elder brother of Pradeep.



“In 1998, I got a job in the Education Department and was posted in Banda district. The accused persons began harassing and putting pressure on my father not to pursue the matter. Fearing for his safety, he could not take the case forward. Since the accused were our neighbours, the threat was much greater. The matter remained stalled for years, and my

father’s health also kept deteriorating,” said Devendra Kumar, who retired as principal of a government primary school in 2019.

According to Pradeep’s family, a property dispute with the accused has been going on since 1989, and the matter is still pending in the court.

In 2021, Uma Shankar died without seeing any headway in the matter. In March this year, Devendra approached the Allahabad High Court. Submitting a copy of the 1998 lower court’s order, he urged the High Court that a case be registered in compliance with the earlier directive. Now, after three decades, an FIR was finally registered on Wednesday at the Kotra police station against seven persons — all distant relatives and neighbours of Pradeep — on charges of murder and destruction of evidence.

“Our faith in the system has been restored. There were nine people involved in the case... While we were struggling to get the case registered, two of the accused died. We now hope that the remaining accused will finally be brought to justice,” Devendra Kumar Bajpai, 68, told The Indian Express over the phone.

A serious wake-up call, Bengaluru infra needs to be fixed, say industry bodies

Industry bodies have termed the BlackBuck CEO’s decision to move out of Outer Ring Road (ORR) citing pathetic road infrastructure and traffic problems, as a serious wake-up call for the government. “The decision of BlackBuck to move out of the ORR must serve as a serious wake-up call. Bengaluru’s reputation as India’s tech capital rests on infrastructure and ease of doing business,” said Krishna Kumar Gowda, General Secretary of Greater Bengaluru IT Companies & Industries Association (GBITCIA), while urging the government to improve infrastructure and Metro connectivity among others.

While appreciating the interest shown by Andhra Pradesh minister Nara Lokesh in inviting BlackBuck to Visakhapatnam, GBITCIA emphasised that Bengaluru remains the leading tech hub in India and highlighted the urgent need for infrastructural reforms within the city. “Bengaluru has an unparalleled, unique ecosystem of talent, innovation and business networks,” Kumar noted.

He called upon the government to urgently address the infrastructure challenges outlined by firms like BlackBuck, including road safety and traffic congestion. He said a multi-pronged approach, including both short-term and long-term measures, should be taken to reduce traffic congestion on the ORR, targeting both immediate pain points and promoting long-term infrastructure

upgrades. Federation of Karnataka Chamber of Commerce and Industry (FKCCI) President Balakrishna M G termed the matter as a wake-up and a serious warning. “The government must act fast — fill potholes, build infrastructure and redeem Bengaluru’s sagging global image. Let’s not lose our pride as India’s tech and start-up capital,” he said.

Some of the industry bodies TNIE reached out to declined to comment. However, they said infrastructure plays a crucial role in holding companies and bringing in new investments and a city like Bengaluru needs world-class infra.

Brand guru Harish Bijoor said, “BlackBuck is moving out of Bellandur, but not out of Bengaluru. It’s not an easy thing for any startup or business to get out of Bengaluru. Once you are in Bengaluru, you continue to be in Bengaluru. Potholes, bad infrastructure, come what may, Bengaluru is an ecosystem on its own.”

He, however, said Bengaluru seriously has to buck up on its infrastructure. “Our deputy chief minister is in action and has put out a format of splitting the city into five corporations under the Greater Bengaluru Authority. The planning is done, the institutional corrections are done and it is time to act.

We need to see how the five city corporation commissioners are going to tackle the multiple issues troubling Bengaluru,” Bijoor said.

16-year legal battle ends in acquittal for state employees in DVAC case

Two state government employees, one of whom died seven months ago, were acquitted of corruption charges by a special court for Prevention of Corruption Act cases in Chennai on Tuesday, 16 years after the DVAC registered the case.

The accused were V Lakshmanan, co-operative sub-registrar in the office of the deputy registrar of co-operative credit societies between 2005 and 2007, and R Padmanaban, then section officer in the tourism department, who died on February 11 this year. Both also served as office-bearers of a housing society in Thoraipakkam, where the alleged irregularities took place.

DVAC had charged the two with corruption, criminal conspiracy, forgery and criminal misconduct, accusing them of foul play in the allotment of two convenience stores and a shop site on a government-allotted land in the housing society. The case was registered in 2009 and a chargesheet was filed in 2013.

The court ruled that the DVAC failed to establish that the accused had received even `1 as bribe or that the alleged fake allotment orders for the shops were written by Lakshmanan or signed by Padmanaban.

Though beneficiaries of the shop sites testified they had paid money to Lakshmanan, the court said this did not prove that the allotment letters were prepared by him. The court also pointed out procedural lapses by the prosecution in presenting evidence.

DRF staff stir over pay cut, resume duties after meeting HYDRAA chief

Expressing anger over a sudden deduction of Rs 5,000 from their salaries, several outsourced Disaster Response Force (DRF) staffers working under the Hyderabad Disaster Response and Asset Protection Agency (HYDRAA) staged a protest in front of the agency’s office on Wednesday.

They alleged that despite working round the clock in emergencies, their pay had been slashed in September. Earlier deployed by the GHMC’s Enforcement, Vigilance and Disaster Management (EVDMA) wing, they are now serving under HYDRAA. The state government recently issued an order to bring parity in salaries of all outsourced employees. However, DRF personnel said the implementation of this order resulted in a deduction of around `5,000 from most of them. They pointed out that HYDRAA marshals had previously boycotted duties over similar issues, after which the Commissioner had assured there would be no salary cuts.

Not permanent: Ranganath

HYDRAA, however, denied any reduction in pay. In a statement issued on Wednesday, the agency explained that as per GO No. 1272, salaries of employees transferred from GHMC’s EVDMA to HYDRAA were revised to match wages of outsourced staff in other departments.

HYDRAA said it had immediately informed the government, which directed GHMC to release a matching grant to cover the difference. As the grant’s release requires Standing Committee approval, there was a delay. To avoid hardship, HYDRAA paid salaries strictly as per the GO, while the difference will be adjusted and cleared once GHMC releases the funds. HYDRAA Commissioner AV Ranganath met the protesting staff and assured them that there was no permanent pay cut and that they would continue to receive the same salaries as under GHMC’s EVDMA. Following this assurance, employees resumed duties.

Officials reclaim land worth Rs 16 crore

The HYDRAA on Wednesday reclaimed nearly 1,600 sq yards of land earmarked for parks and public amenities, valued at over Rs 16 crore, from land grabbers.

FIR lodged against woman advocate after high drama in HC complex

An FIR has been registered at Sector 3 police station against advocate Ravneet Kaur and her associate Simran Singh Blassi under Sections 109 (attempt to murder), 115(2) (voluntarily causing hurt) and 126 (wrongful restraint) of the Bharatiya Nyaya Sanhita (BNS), following a day of chaos inside the Punjab and Haryana High Court complex. The Punjab and Haryana High Court Bar Association has demanded their immediate arrest, alleging that the two created panic, assaulted members of the Bar, and disrupted proceedings. In an urgent notice, the association warned of an indefinite strike if prompt police action was not taken. According to the notice, the trouble began when Ravneet accused the Bar Association Secretary Gagandeep Jammu of confiscating her bag and laptop in Court Room-1. She later entered the executive office with Blassi and allegedly misbehaved with

the Secretary and others. In court, she pressed for her matter to be urgently fixed for hearing in Court Room-1, a request allowed despite opposition from nearly 100 members present.

As the two exited the courtroom, the situation spiralled. Blassi was allegedly seen roaming inside the premises with a sword and, along with Ravneet, is accused of assaulting members of the Bar. One member was reportedly injured before police intervened and took the duo away.

Despite this, the Bar Association alleged, the police were initially reluctant to lodge an FIR. As the police dragged their feet, the association then threatened to go on an indefinite strike if no action was taken. Ravneet has been a frequent litigant in recent months, filing petitions ranging from financial aid from the Bar Council, which was dismissed earlier this year, to challenges over the allocation of her cases to a particular bench.

Rs 21 crore robbed from SBI branch in Vijayapura

In a high-profile robbery, criminals stole cash and gold worth Rs 21.04 crore from the SBI branch at Chadchan town in Vijayapura district on Tuesday evening.

As per preliminary assessment by bank officials, robbers have taken away Rs 1.04 crore in cash and around 20 kg of gold ornaments, worth around Rs 20 crore, SP Laxman Nimbargi said on Wednesday. The jewellery was pledged by customers for taking loans, the police said.

The SP said that one of the accused arrived at the bank around 4.30 pm under the pretext of opening a bank account. “He sat in the bank till 6.30 pm. When the bank staff was about to close the branch for the day, he called two of his accomplices. After they arrived, all the three held some

ten people at the bank — six staffers and four customers — hostage at gunpoint and lethal weapons. They tied all the hostages and locked them in a room at the bank. They then



forced the bank staff to open the lockers and took away cash and jewellery,” Nimbargi said.

The police later recovered a motorcycle used in the crime at Huljanti village of Pandharpur in Maharashtra. Some of the stolen gold and cash kept in the bike was recovered. The bike had a fake number plate,

the SP said.

While fleeing on the bike after the crime, the accused crashed into another motorist. When local residents gathered and started arguing with the criminals, they abandoned the two-wheeler and fled from the spot with the stolen property, the police said. Meanwhile, the police have formed eight teams to crack the case. Forensic experts visited the bank and collected evidence.

This is the second major bank heist in Vijayapura district in recent months.

In the previous robbery, nearly 50 kg of gold was looted from the Canara Bank branch in Managuli. The branch manager himself was involved and was arrested later. The police successfully cracked that case and recovered the entire loot of stolen gold and arrested all the accused.

Punjab facing floods every 2 years: Are silt-choked riverbeds, dams to blame?

For the third time in six years, Punjab is reeling under devastating floods. After the 2019 disaster and the 2023 deluge, the 2025 floods have once again turned vast swathes of farmland into lakes and left rural infrastructure battered. Farmers and officials alike are now asking the same question: are Punjab’s rivers and dams too silted?

Experts from the Drainage Wing of the Water Resources Department said the answer is clear. “There are several factors involved for Punjab’s floods, including unprecedented rains, but our rivers are also choking at certain places. The beds of the Sutlej, Beas, Ravi and seasonal rivulets like Ghaggar and Chakki are raised by 5 to 12 feet at several places because of siltation and nature’s fury is adding to injury,” experts said.

After the 2019 floods, a 2020 government report had warned that Punjab’s rivers contained over 7,000 lakh MT of sand and

gravel, enough to increase water-carrying capacity by 15,000–50,000 cusecs if removed. That figure then was already 15 times more than Punjab’s annual sand and gravel requirement. But since then, at least two more floods — in 2023 and now in 2025 — have piled on additional silt. “Since 2019, the volume of trapped sand and gravel has only gone up with each flood,” said a senior officer of the Punjab Canal Wing under the Punjab Water Resources Department.

“The numbers we quoted then are outdated now. The situation is much more serious. The rivers have lost so much depth at certain points that even moderate rain or controlled water releases are causing breaches,” admitted another senior irrigation official.

The data illustrates the crisis starkly. The Sutlej, originally carrying 2–3 lakh cusecs, can barely manage 80,000–90,000 cusecs on

most stretches, while at some places it is still carrying up to 2 lakh cusecs. “At some places



even 50,000–60,000 cusecs water in the river is breaching the bandhs and at some places even water up to 2 lakh is crossing comfortably. But even a single breach on the river is causing floods in several villages,” said another officer, adding that the Beas and

Ravi too have lost large chunks of capacity at several places because silt/ sand gets accumulated and sometimes the water either damages the bandhs on the riverbanks or pushes water back into the low-lying areas. Experts said that seasonal rivulets such as Ghaggar and Chakki now overflow with far smaller flows than before.

Despite repeated floods, Punjab has made little headway in desilting, and the reason is the involvement of the environmental issues, huge finances to remove the silt and the lack of proper scientific study about the desilting of rivers, said officials, adding that it is a technical task and requires accuracy. Though successive governments had approved dozens of mining sites across seven blocks of Punjab for contractors to excavate river material under supervision, insiders say the scheme was half-hearted and patchy.

EVM ink row sparks clash between ABVP, NSUI during Delhi University student polls

elections on Thursday morning after an electronic voting machine (EVM) with an ink mark was reportedly found at Hansraj College and Kirori Mal College on polling day. The ink appeared on the button against the ABVP’s presidential candidate, Aryan Mann triggering sharp exchanges between rival student groups. The incident prompted the immediate intervention of the election committee, election observers, and even the Chief Election Officer Professor Raj Kishore Sharma who visited the sites to assess the situation. The election officer took feedback from as many as 100 students in the college.

NSUI senior leaders, including Varun Choudhary quickly released a video of its presidential candidate, Joslyn, in tears, alleging “vote chori” and accusing rivals of attempting to manipulate the poll process.

"RSS-BJP has brought its undemocratic and fraudulent tactics into Delhi University. Just as they manipulate elections outside,



they are now trying the same inside DU. But the students of Delhi University will not tolerate this. They will answer ABVP’s dishonesty with their votes,” said Varun Choudhary.

ABVP, on the other hand, dismissed the allegations, claiming NSUI was resorting to theatrics as “ABVP is winning on all four seats.”

The chief election officer termed the incident “mischievous,” noting that it was unusual for the same issue to surface at two separate colleges. Meanwhile, Hansraj College issued an official statement calling the allegations “baseless” and insisted that the college denies all false allegations and also said that voting was being conducted under strict scrutiny, with CCTV cameras ensuring transparency. With both student groups trading charges, the EVM ink row added a new flashpoint to an already high-stakes election. Professor Raj Kishore said that half of the voting in the day colleges was almost over by 12:30. The voting turn out will be released by 5 pm.

‘Andhera tha... Bus itna yaad hai ki main andar gaya’: Man recalls harrowing death of colleague

Inside the mortuary of Babu Jagjivan Ram Memorial Hospital on Wednesday, a group of men stood silently. Relatives and neighbours had gathered, trying to console the brother of Arvind who had died a day earlier while cleaning a sewer in Northwest Delhi’s Ashok Vihar.

“Bus 40 ki umar thi batao. Do bacche hai. Kaun dekhega? (Arvind was just 40. He left behind two children... Who will take care of them?)” asked his brother, 50-year-old Satyendra Yadav. Satyendra watched as Ashok’s body was hurriedly loaded into a hospital van as the mortuary hours drew to a close. The van took the body to their home in UP’s Kasganj home. On Tuesday night, Arvind suffocated to death while cleaning a sewer pipe near a society in Delhi’s Ashok Vihar.

The incident also left three other men — Sonu, Narayan and Naresh — injured, police said. All four were working for Brijgopal Construction Company on a contractual basis, police said. They were rushed to Deen Dayal Upadhyay Hospital, where Arvind was declared dead. “He had a contractor, who would usually get him work. He lived in Kasganj... The contractor would call him if there was work,” said Satyendra. “This time it was different,” he said.

Before he left home, Ashok had said it was not the contractor who had called. “He got the call directly from the company. It happens sometimes... to save expenses, companies often get in touch with workers directly. I think it was paying him more this time,” Satyendra added.

Three men held for stabbing youth inside government school in East Delhi’s Trilokpuri; one at large

Three men have been arrested for scaling the boundary wall of a government school and stabbing a 23-year-old youth over personal enmity, police said. The accused, identified as Rajeev (19), Vijay (27), and Akash, were apprehended within hours of the incident, which occurred on September 13 at the 22 Block Government School in Trilokpuri, police said. The fourth accused remains at large, officers said.

The case came to light when police received information from LBS Hospital regarding the admission of Rohit (23), a resident of Trilokpuri, with multiple stab wounds. He was later referred to AIIMS Trauma Centre for advanced treatment. The weapon used in the attack has been recovered, and the victim remains hospitalized, officers said.

According to police, four men entered the school premises around 7:30 pm and attempted to attack Rohit (23), along with his friends Shivam and a 16-year-old boy, who were sitting inside the school. Abhishek Dhania, DCP (East), stated, “Four unidentified assailants scaled the boundary wall, abused the group, and suddenly attacked them. While Shivam and the juvenile managed to escape, the assailants surrounded Rohit and inflicted multiple stab injuries with a knife. Blood stains were found at the spot, and exhibits were lifted by the Crime Team for forensic examination. A case was registered for attempted murder.” During the investigation, eyewitnesses Shivam and the 16-year-old boy identified the attackers as the three accused, police said. On the motive behind the attack, DCP Dhania said, “The motive was traced to a quarrel between the victim and accused Rajeev’s brother Nihal a day earlier, which led the four accused to conspire and carry out the attack. The fourth accused, Aniket, has been identified and efforts are underway to apprehend him. Further investigation is underway”.

Sidhu Moosewala killing to firing at Disha Patani’s home: Why Turkish Zigana pistols are go-to weapon for gangsters

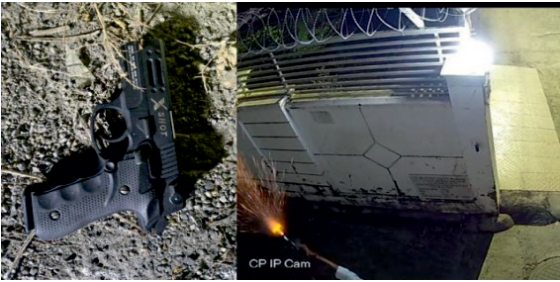

What’s common between the killings of Punjabi singer Sidhu Moosewala, UP gangster-turned-politician Atiq Ahmed, and Maharashtra NCP leader Baba Siddique? In all three cases, the murder weapon was similar — a Zigana pistol made in Turkey.

This was the pistol that was also used by the two shooters who opened fire outside Bollywood actress Disha Patani’s residence in Bareilly, which police later recovered.

According to a senior police officer, the Zigana pistol is highly popular among gangsters in Delhi, Haryana, Punjab, and Rajasthan for its ability to fire over 15 rounds in one go, its low chance of jamming, and high accuracy. Police said CCTV footage of the firing at Patani’s residence attests to this, showing that a single pull of the trigger released multiple rounds. The shooting was carried out by Ravindra (24) and Arun (27), belonging to the

Rohit Godara-Goldy Brar gang. Around 3.30 am on September 12, the duo, who were on an Apache motorcycle, fired around 8-10 rounds at Patani’s residence and fled. On Wednesday evening, the men were



shot dead in a joint encounter by the Uttar Pradesh, Haryana, and Delhi Police in Ghaziabad.

Police recovered a Zigana pistol from the encounter site. They also recovered an Austrian Glock pistol, widely used by the Indian police forces, from the shooters. While Zigana pistols are manufactured in Turkey, the police officer said

counterfeit versions are easily available in Pakistan. Its price goes up to Rs 2-4 lakh by the time it reaches the end user in India, the officer added.

Police discovered that in 2022, a significant number of such pistols were allegedly smuggled into India from Pakistan via drones and supplied to shooters associated with jailed gangster Lawrence Bishnoi for the assassination of Sidhu Moosewala.

Later, similar firearms were found to have been used in the killings of Atiq Ahmed and his brother Ashraf in Prayagraj in 2023, as well as in the murder of NCP leader Baba Siddique in Mumbai in 2024.

Sources claimed that a Zigana pistol was even gifted to the Jitender Maan alias Gogi gang by the Lawrence Bishnoi gang, when the two collaborated to operate in Delhi-NCR in early 2021.

Hit by Delhi HC verdict, airport service aggregator Dreamfolks exits domestic lounge business

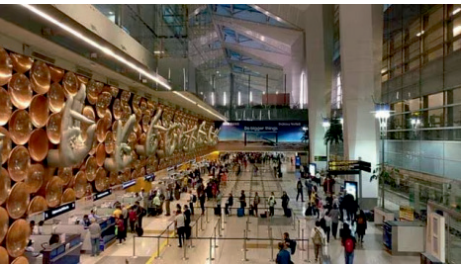

The Delhi High Court Tuesday refused to restrain lounge operator Encalm Hospitality Private Limited from dealing with banks directly, instead of solely through Dreamfolks Services Limited, an airport service aggregator, to provide airport lounge access.

After the court ruling, Dreamfolks Services, which also provides airport lounge services, said Tuesday it is discontinuing its service at domestic airport lounges, although its other domestic services and global lounge business will continue.

While refusing to restrain Encalm Hospitality from dealing with banks, Justice Amit Bansal noted that Dreamfolks Services failed to

establish that there is an “exclusivity” between Dreamfolks Services and its clients, the banks. “It appears that the



petitioner’s clients (banks) are free to have similar agreements with other third-party service providers... On a prima facie view, there is no bar upon the respondent (Encalm Hospitality) to provide services” to the banks through third-party service

providers,” Justice Bansal ruled. Dreamfolks Services was embroiled in a legal dispute under the Arbitration and Reconciliation Act against Encalm Hospitality, with which it had entered into an agreement in 2022, valid for five years. Encalm Hospitality had agreed to provide services to Dreamfolks Services, and its customers by granting them access to the services at the lounges it operated. Through the agreement, Dreamfolks Services, which has agreements with various banks that issued credit cards and other cards to their customers, essentially provided access to such cardholders to the airport lounges, allowing Dreamfolks to earn from the margin it pays Encalm Hospitality and recovers from the banks.

‘No victory procession in Capital’:Delhi HC directs candidates ahead of DUSU polls

A division bench comprising Chief Justice DK Upadhyaya and Justice Tushar Rao Gedela was hearing a petition concerning large-scale violations of the poll code.

The Delhi High Court on Wednesday barred victory processions by winning candidates of the Delhi University Students’ Union (DUSU) election, while orally warning that if the election is not conducted in a “peaceful and orderly manner,” it may stop the functioning of the elected office bearers. The elections are scheduled for September 18, with counting set to take place the following day. A division bench comprising Chief Justice DK Upadhyaya and Justice Tushar Rao Gedela was hearing a petition concerning large-scale violations of the poll code.

In its order, the court stated, “A common concern has been expressed that after counting is over winning candidate take out victory procession, which as per past experience, becomes very difficult to

handle by police and university authorities...We thus direct no victory processions in campus, hostels or in any other area of Delhi shall be taken out.” Taking note of the “large-scale violations,” evidenced by the huge number of challans issued by the police for traffic breaches, damage to public property, and defacement—along with “scores of notices and warnings” issued to erring students and candidates by DU—the bench remarked that the violations “still haven’t abated.”

The court went on to orally ask DU’s counsel, “Should we stay the elections?

...We have no problem or hesitation in doing it.” The bench further remarked,



“Counting may take place, but we will stop the functioning of the office bearers if the election is not held in a peaceful

and orderly manner.” DU’s counsel, while requesting that the elections not be stayed, urged the court to direct that no victory processions be allowed. Last year, during the DUSU polls, the Delhi HC had stayed the counting of votes for over a month due to widespread defacement and poll code violations. The stay was lifted only after the court was satisfied that the defacement had been remedied by the erring students and candidates. The court has scheduled the matter for further hearing on September 19.

Delhi Police PCR van crushes tea seller on pavement

A 55-year-old tea vendor was killed after a Delhi Police patrolling van rammed into his stall while he was sleeping in Central Delhi’s Mandir Marg area early Thursday.

The man killed in the accident has been identified as Gangaram Tiwari, who used to run the tea stall on the pavement near the RK Ashram Metro Station, and sleep inside it.

According to the police, the accident happened at 5 am when the New Delhi District PCR van — a white Ertiga — was patrolling the area. Prima facie, the police suspect the driver of the patrolling vehicle, a constable, dozed off while driving the vehicle when the accident took place. An assistant sub-inspector (ASI) was also present in the vehicle when the accident took place.

The constable and the assistant sub-inspector have been suspended after the accident, and the vehicle has been seized, a senior police officer said. Tiwari’s 24-year-old son, who lives with him, said he was out when the accident happened.

“Main walk karne gaya tha subah (I went for a morning walk). When I came back, I saw the vehicle had rammed into our shop. Hum dus saal se yahan dukaan laga rahein hai (We have been setting our shop here for the past 10 years). They (accused) come here to patrol daily,” told reporters. Gangaram’s wife lives in a village in Gonda, Uttar Pradesh. A senior police officer said the constable driving the vehicle was deployed in the PCR New Delhi Circle. “The cause of the incident is yet to be ascertained. But prima facie it appears that the constable lost control of the vehicle while taking a turn, and it climbed onto the pavement, crashing into the tea stall,” the officer said.

67-year-old US woman travelled to Punjab to marry UK-based NRI, 75; found dead

A 71-year-old Indian woman, who travelled to Punjab from the US to marry a UK-based NRI man, was found dead. The case came to light recently after Ludhiana Police registered an FIR over Rupinder Kaur Pandher's disappearance and named suspects, including her would-be husband, Charanjit Singh Grewal.

Pandher's remains were recovered from a drain in Ghungrana village near Ludhiana, as well as her badly-damaged iPhone.

The incident dates back to July when Pandher, an



American citizen based in Seattle, arrived in the state at the invitation of Grewal, the 75-year-old would-be groom originally from Ludhiana, the news agency quoted police as saying.

According to the police, the victim's sister, Kamal Kaur Khairah, grew suspicious when she found Pandher's phone switched off on July 24.

Four days later, she informed the US Embassy in Delhi, following which the local police in Ludhiana began its probe. Ludhiana resident, Sukhjeet Singh Sonu, has been arrested after he allegedly confessed to killing Pandher on Grewal's instructions for Rs 50 lakh.

Sonu said he killed her in his house and later burnt the body in a storeroom. The police said the motive was financial.

Lionel Messi and Inter Miami enter discussions for contract extension: Reports

Lionel Messi looks set to extend his stay in Major League Soccer, with reports in the United States suggesting that Inter Miami and the Argentine icon are in the final stages of negotiating a new contract. ESPN reported on Wednesday that only minor details remain to be ironed out before the deal is confirmed, raising hopes amongst Miami supporters that their star man will continue to light up MLS for years to comeThe 38-year-old’s current contract is due to expire at the end of the 2025 season, but the extension is expected to run at least two more years, potentially keeping Messi in Florida until 2027. USA Today noted that talks are about 85 percent complete, with sources indicating that the agreement would ensure Messi remains with Inter Miami well into the twilight of his playing career.Messi’s impact since arriving in 2023 has been nothing short of transformative. In 46 MLS appearances, he has already scored 41 goals and provided 27 assists. Across all competitions, those



numbers rise to 54 goals in 62 games, a return that has elevated Inter Miami from mid-table anonymity to genuine contenders. He helped the Herons lift the 2023 Leagues Cup, their first major trophy, before guiding them to the 2024 Supporters’ Shield as the league’s best regular-season side.This season, the Argentine continues to set the pace with 20 goals in 21 league games, sitting second in the MLS scoring charts, alongside 11 assists. His consistency and flair have turned Inter Miami into one of the league’s biggest attractions, drawing global attention to American soccer much in the way David Beckham once did. Beckham is now part of the club’s ownership group.

Messi’s new deal is also expected to carry long-term implications beyond his playing days. His initial contract reportedly included a clause to join Inter Miami’s ownership structure upon retirement, a move that would anchor his presence in the United States even after he hangs up his boots.

Won Myong-gyong hugs referee in joy after World Wrestling Championships gold

NWon Myong-gyong became emotional after winning the women’s freestyle 50 kg gold medal at the 2025 World Wrestling Championships in Zagreb, Croatia. The North Korean wrestler, competing in her first senior world championship, ended a perfect campaign with a strong 8-2 victory over China’s Yu Zhang in the final.The win carried historic value for her country. It was only the third women’s world title ever for North Korea, making Won’s triumph a landmark for the nation. According to her UWW athlete profile, she had three wins and one loss in 2025 before the tournament, but in Zagreb she stayed unbeaten through every round.Her celebrations reached a heartwarming moment when she gave the referee a long hug, overwhelmed with joy and relief, before turning to thank the side judges as well.Won recorded victories in different ways, including VPO1 (winning by points despite her opponent scoring) and VSU (winning by superiority), underlining both her range and technical command.

After her win, Won told United World



Wrestling (UWW): “This medal and the championship belt I’ve won are just the first step in repaying my parents for all their sacrifices. From now on, I’ll work even harder to become an Olympic champion.” More than the numbers, it was her hug with the referee that stood out most. Such a gesture is rare in wrestling, but it reflected her deep gratitude to those who maintain fairness and discipline in the sport, turning her gold medal moment into something even more memorable.

World Championships: Why India vs Pakistan in the javelin final is only a subplot

World Athletics Championships 2025: Neeraj Chopra and Arshad Nadeem's rivalry will grab subcontinental headlines, but the men's javelin final in Tokyo is stacked with world-class talent. From Germany's Julian Weber to former champions Anderson Peters and Julius Yego, the contest promises far more than just an India-Pakistan subplot.

"Ever since the Paris Olympics, when Pakistan's Arshad Nadeem stunned India's Neeraj Chopra to take gold and their run-ins blossomed into a rivalry, their next clash has been one of the most anticipated events in javelin. It was meant to happen at the Neeraj Chopra Classic - a monumental international event hosted earlier this year by the two-time Olympic medallist from India - but it didn't. Then they were expected to meet in a Diamond League, but that too failed to

materialise. So the face-off at the Tokyo World Athletics Championships was set to ignite fireworks.Neeraj single-handedly put India on the javelin map, and when Arshad joined the party, South Asia suddenly found itself challenging the European and American dominance in the sport. The two Olympic medallists finished one-two at the World Championships in Budapest in 2023, and swapped those positions at the Paris Olympics.In no time, the India-Pakistan rivalry in javelin became evenly matched – fuelled further by the passion of success-starved fans in both nations. As the cricket rivalry drifted into one-sidedness, Neeraj vs Arshad became the contest everyone in the subcontinent looked forward to.The Paris Olympic final was a watershed. Few expected Arshad to strike gold, but he did – with a monstrous Olympic record of 92.97m, while Neeraj was still chasing the elusive 90m mark. Once Arshad landed that throw, pressure gripped Neeraj, who managed only one legal throw out of six – 89.45m, enough for silver but short of his golden target.Neeraj, though, has been the very model of consistency – the benchmark for

young throwers worldwide. Since his senior debut, he has launched 40 throws beyond 85m and has finished in the top two at nearly every competition for four years. Yet even he



admitted that Arshad's effort meant the push for 90m had to gather pace.Determined to evolve, Neeraj joined forces with Jan Zelezny, the world record holder and arguably the greatest javelin thrower of all time, reworking his playbook to iron out technical flaws. The results were swift: earlier this year, at the Doha Diamond League, Neeraj finally breached the 90m barrier.Neeraj was preparing not just to be the best, but to beat the best.Which is why

Thursday's showdown carries so much weight. For Neeraj, it is about payback, redemption for Paris, and the defence of his world title. He knows Arshad is capable of summoning another mammoth throw. Can he match him this time?

CONTRASTING ROUTES TO FINAL

The qualifiers on Wednesday hinted at the storylines. Neeraj, calm and composed in the hot, humid Tokyo conditions, sealed his spot with one and done – 84.50m, the automatic qualifying mark. He packed his bags immediately, even asking an official how to slip out without disturbing other events, and headed for recovery. He was one of only two among the 37 competitors to qualify on his first attempt.Distance-wise it is not that good, but distance does not matter here. The best thing is that we crossed the automatic qualifying mark in the first throw. And this is also the first time that the final is the next day. I wanted to do my best in the first throw itself, reach the room early, recover, and give my best in the final," Neeraj said with the calmness of a man seasoned by big stages.By contrast, Arshad flirted with disaster.

Gore has already represented the USA in eight T20Is so far and this is his first call-up to play for the West Indies.Gore has been in top form during the CPL for his franchise, Antigua and Barbuda Falcons, as he scored 219 runs in 11 matches. Apart from Hosein, the other senior members in the squad includes Fabian Allen, Jason Holder, Kyle

Iga Swiatek to become No.1 Aryna Sabalenka's China Open pullout spices up race

Aryna Sabalenka's withdrawal from the China Open opens the door for Iga Swiatek to close the gap in the race for the WTA No.1 ranking. A strong run in Seoul and Beijing could bring Swiatek within striking distance of the top spot.

The battle for the women’s World No.1 ranking has taken a sudden twist after Aryna Sabalenka announced she would skip the 2025 China Open in Beijing. The Belarusian, currently holding the top spot with 11,225 points, said she is dealing with a minor injury she picked up at the US



Open.Missing this WTA 1000 event not only keeps her out of competition but also costs her 215 points, since she had reached the quarterfinals in Beijing last year.

"I am sad to announce my withdrawal from the China Open this year after sustaining a small injury after the US Open. I am going to focus on being 100 per cent healthy for the rest of the year," Sabalenka said in a statement provided by organisers.This opens the door for Iga Swiatek, the current No.2 with 7,933 points, roughly 3,300 points behind in the official rankings. Diego Simeone opens up on altercation with Liverpool fan: Insulted for 90 minutes

Atletico Madrid manager Diego Simeone opened up on the heated incident following his side’s 3-2 defeat to Liverpool in their Champions League opener at Anfield. The Argentinian coach was sent off after confronting a fan behind his dugout in the aftermath of Virgil van Dijk’s 92nd-minute winner, an altercation that overshadowed an otherwise thrilling European clash.The incident has reignited discussions around manager protection and fan conduct in football, with Simeone highlighting the emotional toll of constant abuse from the stands. Simeone, speaking after the match, stressed that while his reaction was human, managers should not have to endure repeated insults during games.“My reaction isn’t justifiable, but do you know what it is like to be insulted for 90 minutes?” Simeone said. “In the same way we fight against racism, we should look at this too because we don't have a right to respond and it is not easy to be insulted during the entire match.”“When they scored the third goal, he [the fan] turned



around and insulted me. I am a person, I am human. Obviously, my reaction was not ideal, but it was 90 minutes of being insulted.

The referee understood the situation, and I hope that when the person is identified, there will be consequences. Managers should be

able to focus on the game without having to face constant abuse," he added.

On the pitch, Liverpool raced to a 2-0 lead inside six minutes, with Andy Robertson opening the scoring from a ricocheted Mohamed Salah free-kick, followed by a clinical solo strike from Salah himself. Atletico responded before halftime, with Marcos Llorente scoring to keep his team in contention and then equalising in the 81st minute with a stunning volley reminiscent of his 2020 heroics at Anfield.Despite Atletico’s resurgence, Van Dijk’s late header secured the victory for Liverpool, leaving Simeone frustrated and visibly agitated. Stewards intervened to hold him back, and the red card was issued following the confrontation. The manager briefly gestured to the fourth official, clarifying it was a reaction to the fan abuse rather than an offensive action of his own.

Liverpool manager Arne Slot, meanwhile, praised his side’s fitness, mentality, and perseverance and strayed away from putting any focus on the altercation.

Shares of several leading Indian companies in information technology, banking, auto and pharma sectors traded higher on Thursday after the US Federal Reserve cut interest rates by 25 basis points and signaled the possibility of more easing later this year. The move boosted investor sentiment across global markets and supported sectoral gains in India, with IT stocks leading the rally. Information technology majors including Infosys, HCL Technologies, and Tech Mahindra saw gains of around 1 to 1.3 percent. A softer dollar and expectations of increased US spending following the Fed's policy shift improved sentiment for export-driven IT companies that earn a large share of revenues in the American market. HDFC Bank, Sun Pharma, and Tata Motors were also among the notable gainers today. HDFC Bank benefited from improved foreign inflows as global liquidity conditions turned more favorable. Sun Pharma advanced on steady buying in defensives, while Tata Motors extended gains on optimism around domestic demand and its global business outlook.

The other stocks made significant gain in the Indian markets on the day include MOIL, Cochin Shipyard, Avenue Supermarts.

Shares of MOIL climbed over 2 percent after the state-owned miner announced exports of manganese ore to Indonesia, a step that underscores its efforts to diversify markets and strengthen international presence. Cochin Shipyard advanced nearly 2 percent on the back of a ₹2,000 crore contract from ONGC. The order win reinforced confidence in the shipbuilder's strong order book and earnings outlook. Avenue Supermarts, parent of the D-Mart retail chain, gained around 2 percent after brokerage firm UBS upgraded its price target. Analysts highlighted the company's continued focus on value retailing and network expansion, which is expected to drive long-term growth.

GST rate cut triggers early sale season for apparel retailers

The festive season sale for premium garment retailers and e-commerce platforms has started early this year, spurred by the recent GST rate cuts announced by the government. Several retailers have rolled out discounts of up to 50% online—two weeks ahead of Navratri, traditionally seen as the start of the festive shopping season. The tax rationalisation has prompted textile and apparel retailers to recalibrate their pricing strategies.

Neeraj Nagpal, chief business officer—apparel & retail, Raymond Lifestyle Ltd, said: “The GST rate cut will boost consumption in the apparel and textile sector. It is a positive flip for value and mid-retailers from an amplification of consumption perspective.” According to him, Raymond Apparel Brands has recorded double-digit growth in combined retail and online sales compared to last year's festive season. E-commerce giant Amazon is also capitalising on the momentum. The company is offering discounts of up to 80% on leading brands such as Libas, BIBA, Levi's, US Polo Assn, GAP, Lavie, Adidas, Titan, Mokobara, GIVA, Safari, Lakme, Michael Kors, and Swarovski. Siddharth Bhagat, director, Amazon Fashion & Beauty, said: “During the last Amazon Great Indian Festival, we saw a record 140 crore customer visits, with over 85% coming from non-metro cities. Prime Day 2025 reinforced this trend, with 70% of new Prime sign-ups from Tier 2 and Tier 3 cities, and orders peaking at more than 18,000 per minute.” Under the revised GST slabs, apparel priced up to ₹2,500 will now attract 5% GST, while items above that threshold will be taxed at 18%, up from the earlier 12%.

Infrastructure alone not enough, quality and skill development keys to global competitiveness: FM

infrastructure but on a "seasoned understanding of quality management."

Government Initiatives and the AI Push Sitharaman detailed several government initiatives aimed at fostering a culture of quality and innovation. She noted that in recent years, every government project has included provisions for skilling and upskilling the workforce. Training programs, designed around local industry needs, have already been launched in approximately 150 clusters. This unique model not only trains workers for internal needs but also creates a surplus of skilled labor for the broader market, addressing a key challenge faced by industry leaders. Sitharaman also pointed to strong international collaboration, particularly with Singapore, on certified vocational training.

ITR refund 2025: How long will it take to reach you

Millions of taxpayers who filed their returns by the September 16 deadline are now waiting for the next big step, i.e., getting their refunds. But how long does it actually take for the money to land in your bank account?

New Delhi (Agency)

After filing their income tax returns (ITR) by the extended deadline of 16 September 2025, many taxpayers are now eagerly waiting for their refunds. For most people, this is the most anticipated part of the entire process. But the question is: when can you actually expect the money to arrive in your bank account?

TIMELINE FOR RECEIVING INCOME TAX REFUND

The refund process begins once your ITR

is successfully e-verified. In many straightforward cases, taxpayers receive the amount in just a few days. Some have even reported refunds being credited on the same day, especially when the refund is a small sum. On average, though, the refund is usually credited within four to five



weeks of filing. Tax experts point out that the time taken depends on the internal checks carried out by the Income Tax Department under Section 143(1). Smaller refunds are often

processed faster, while larger or more complex cases can take longer. This year, new checks on deductions and exemptions may also cause slight delays for those who have claimed them.

WHY DELAYS MAY HAPPEN

Refunds can get delayed when there are complications in the return, such as capital gains or business income. In such cases, the department may cross-check information before issuing the refund. If discrepancies are found, taxpayers might receive a communication from the department and need to respond promptly. Experts say that while some refunds are credited in under a week, others can take close to a month, especially when a large number of returns are pending. The good news is that if your refund is delayed, the Income Tax Department pays you interest at 6% per year, starting from 1 April of the assessment year.

Indian exporters brace for US tariff hike, government seeks swift resolution

TIRUPPUR (Agency)

The central government is working to address issues posed by the 'unsustainable' US tariff hike on Indian exports as soon as possible, said Sudhir Sekhri, Chairman of the Apparel Export Promotion Council, in Tiruppur on Wednesday.

Speaking to reporters, Sekhri said, "We have had some small hiccups due to the US tariff hike. It is not sustainable because American consumers will also be affected by this. The central government is working round the clock and discussing with the US to ensure that this issue gets resolved as soon as possible. I hope that it happens in the next two to four weeks."

Meantime, the government will come up with some new policies and some assistance to the US exporters and hopefully it should be announced in the next week or so, Sekhri added.

Apparel exports worth about \$2 or \$ 2.5

billion will be hit if there is no quick resolution. "In FY 2024-25, we were doing \$16 billion worth of apparel exports and of this \$5.2 billion went to



the US. By the time the tariff was imposed we had already shifted about goods valued at \$2.2 billion and about \$1.2 billion was in the pipeline. This means, if this situation continues, exports worth more than \$2 or \$ 2.5 billion will be really affected." Sekhri, however, sounded optimistic about

India retaining its market share despite the odds. "Those who have been buying for a long time are not going to abandon India. Because they also know that these (high tariffs) are not sustainable. We are not saying there is no impact, but I think all are resilient enough to absorb this impact, but it will persist for the next two months or three months," he surmised. Sekhri expects Indian garment exports to non-US markets to pick up. "The FTA with the UK is likely to be operationalised by the end of March. After three years, we expect garment exports to (the UK to) grow from \$1.2 billion to reach about \$2.5 billion. We already have an FTA with Australia. The AEPC is also looking for new markets. We conduct many fairs for this purpose. We are looking at non-refusal markets." The 52nd India International Knit Fair began in Tiruppur on Wednesday and will end on Friday.

Why gold loans are no longer just a last resort for borrowers

Gold loans are shedding their emergency-only image, becoming a mainstream credit choice for urban, semi-urban, and rural India, driven by gold prices, regulation, digital access, and flexible borrowing solutions.

New Delhi (Agency)

Gold loans are no longer just a fallback for emergencies, they have emerged as a mainstream credit option for millions of Indians. The total outstanding gold-backed loans in India have skyrocketed to Rs 2.94 lakh crore by August 2025, a 122% year-on-year jump from Rs 1.32 lakh crore in July 2024. In FY25 alone, gold loans surged over 103%, from just over Rs 1 lakh crore the previous year to nearly Rs 2.1 lakh crore, dwarfing growth in personal loans (8% YoY) and credit card loans (6% YoY).

WHY ARE GOLD LOANS IN DEMAND? One of the primary drivers behind this boom

is rising gold prices. Gold has climbed 44.1% in 2025, crossing Rs 1,13,800 per 10 grams in September from Rs 78,950 at the end of 2024. Higher valuations mean borrowers can pledge less gold for higher loan amounts, making gold loans increasingly attractive amid economic uncertainty.

Regulatory changes have also played a key role. RBI's reclassification of agricultural loans as gold loans, tighter NBFC lending norms, and new tiered loan-to-value (LTV) guidelines in 2025 have formalised access and expanded protections for borrowers. These measures have encouraged banks and fintech firms to expand gold loan offerings, using digital platforms and AI-powered valuations to streamline lending. Borrowers value gold loans for speed and flexibility. Approvals are often instant, documentation minimal, and even those with weak credit histories or limited banking experience can access funds quickly. This ease of access has led many to choose gold loans over unsecured options, which have become

costlier and harder to obtain due to rising interest rates and stricter risk-weighting. The profile of gold loan borrowers has diversified. Demand spans



urban, semi-urban, and rural regions, with strong uptake in Gujarat, Maharashtra, and Odisha. Traditionally associated with urgent cash needs, gold loans are now used for weddings, education, health emergencies, small businesses, and working capital for micro-enterprises. Interest rates, ranging from 8–12% per annum, remain lower than most unsecured credit, further boosting their appeal.

The shift is also behavioural. Gold loans are shedding their "last resort" stigma and are increasingly seen as practical, mainstream credit products. Digital adoption is a key enabler, with mobile apps allowing contactless application and approval, meeting the needs of tech-savvy urban borrowers as well as rural customers who may lack conventional banking access. Policy trends continue to favour secured credit over unsecured lending. Stricter risk-weighting for personal loans and credit cards has pushed borrowers toward collateralised options like gold loans. Public sector banks, NBFCs, and fintech platforms are aggressively innovating to capture this growing demand, offering transparent, regulated, and technology-driven services. Analysts say the growth in gold loans reflects broader economic dynamics: households and small businesses are seeking secure, fast, and flexible credit amid rising costs and uneven income growth. The combination of high gold prices.



management, and AI. Athens

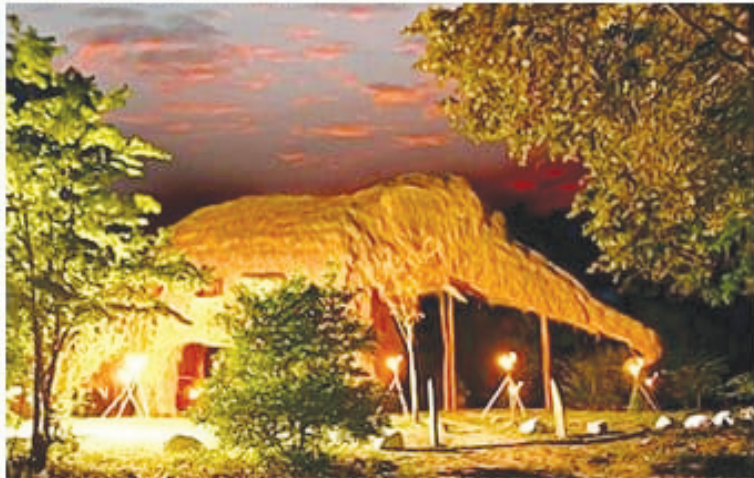
Mount Olympus

Unusual hotels around the world



V8 Hotel, Germany
The V8 Hotel in Stuttgart is a car lover’s haven. Part of an auto museum called Boblingen’s Meilenwerk, the rooms in this hotel are guaranteed to rev the engine of any car enthusiast. The four-star hotel has 34 rooms, of which 10 have undergone extreme makeovers that allow you to sleep in a Mercedes, Morris Minor, Cadillac or Volkswagen. Collectors of classic cars may even park their car in glass viewing boxes, so that others can see the repair and service taking place.

Palacio de Sal, Bolivia
Located on the edge of the world’s largest salt flat—the Salar de Uyuni—Palacio de Sal is a hotel built entirely out of blocks of salt. Everything from walls to furniture is constructed using pure salt and the only rule that guests are required to follow is ‘Don’t lick the walls!’ This luxury hotel also features a golf course, a dry sauna, a steam room, a whirlpool and its own saltwater baths. Featuring chalk-white huts that blend beautifully with the salty landscape, the hotel provides excellent grounds for star-gazing.

Trehotel, Sweden
Having to haul your luggage up a treetop is worth it, when the dwelling is as undeniably cool as Sweden’s Trehotel. Floating ethereally in the evergreen forests, this hotel is composed of five

individually designed ‘treerooms,’ each of which is created in collaboration with leading Scandinavian architects. The most distinctive room is a particularly futuristic suite that reflects the forest surroundings from its mirrored cubical walls. Other accommodation options include a bird nest look-alike, an alien UFO suite and a spacious cabin wedged between the trees.

Propeller Island City Lodge, Berlin
If the eccentric, avant-garde ethos of Berlin could be captured in one hotel, it would be the Propeller Island City Lodge—where a stay is akin to spending the night living in a work of art. Every room has a radically unique ambience constructed entirely by German artist Lars Strohschen. A preppy prison cell with coffin beds; a room covered with mirrors and a suite where upside-down furniture dangles from the ceiling and your beds are hidden beneath the floor—the rooms at this hotel range the gamut from kinky to creepy.

Jukkasjärvi Ice hotel, Sweden
For a few months each year you can experience a sensationalised Eskimo lifestyle in Jukkasjärvi, the world’s first and largest hotel that’s built entirely out of ice and snow. Every year, around 50 artists head to Sweden to help rebuild the structure, thus resulting in a hotel that looks a little bit different each time. The hotel also features a bar, with glasses made of ice, and an ice chapel that’s popular amongst marrying couples. Each year the hotel receives applications from artists all around the world to

design imaginative suites and the actual construction of the structure starts in November, finally opening up for the guests in January.

Kakslauttanen, Finland
A crystal clear view of the Northern Lights from your own private igloo is exactly what Hotel Kakslauttanen in Finland offers. Nestled amidst the wilderness, the hotel promises the best views of the Aurora Borealis and you can choose to stay either in a glass igloo, a log cabin or a snow igloo. Each igloo is fitted with thermal glass walls and ceilings that insulate the interior to keep it warm at night.

Jumbo Stay, Sweden

For the adventurous and quirky globetrotter, conventional hotels are a thing of the past. Whether you still harbour a childhood dream of living in a treehouse, or you love cars so much that you’d give anything to sleep inside one, there’s a crazy hotel somewhere to fit your vacation needs. Here are a few of the world’s most eye-popping and intriguing hotels

Stay hostel in Stockholm. Housed in the Arlanda Airport, the hostel is actually a decommissioned 747-200 jetliner that offers visitors the pleasures of first-class air travel, while staying firmly on the ground. Accessed via a 15-minute walk from the main terminal or via a five-minute shuttle bus, the hostel holds 79 beds and has a luxury suite, offering panoramic views of the airport, built inside the cockpit of the jet.

Dog Bark Park Inn, Idaho
For dog lovers looking to take a trip to Idaho, this is the perfect place to stay overnight. Dog Bark Park Inn is a whimsical two bedroom bed and breakfast that is shaped like a beagle and boasts of a number of dog-themed design choices. To add a dash of quirk to the hotel, the toilet is disguised as a fire hydrant! Lovingly known as ‘Sweet Willy’ by local residents, this unique building was created by wood-carving enthusiasts Dennis and Frances, who spent eighteen months building the structure. The guesthouse can be reserved from April through October for up to four people at a time.

The Hobbit Motel, New Zealand
From outside, these two self-contained underground dwellings look like they have come straight from Tolkien’s Middle-earth. Don’t worry if you’re not three foot tall with hairy feet, everyone is welcome at the Hobbit Motel. This unusual motel was built using polystyrene blocks, keeping it cool in the summer and warm in the winter. Each Hobbit unit is built into the hillside, much like the hobbit holes from ‘The Lord of the Rings’, and can accommodate up to six people.

Giraffe Manor, Kenya
It’s not everyday that you can enjoy a gourmet meal in a quaint historic mansion as giraffes lean in through the window over your shoulder. Giraffe Manor is located on a 140-acre sanctuary for one of the most endangered subspecies of giraffes in the world. The manor, which has ten guests rooms, offers up plates of giraffe food that you can feed to these hungry guests so they don’t go after your breakfast.
