Meghalaya Chief Minister Meets Amit Shah, Presses For Inner Line Permit

"No Need To Panic, Negotiations Underway": Piyush Goyal On Trump Tariffs

Agency New Delhi.

Stressing that negotiations are underway with the United States over 50 per cent tariff on Indian goods, Union Minister of Commerce and Industry Piyush Goyal said that there is no need to "panic" as India and US will come to an equitable, balanced and fair agreement.

In an interview with ANI on Thursday, Piyush Goyal assured that India and the US continue to have good relations.

He said, "I do not think there is any need to panic. We should allow the negotiations to happen. We continue to have good relations with the United States, and I am sure we will be able to resolve some of these issues and come to an equitable, balanced and fair agreement."

When asked about the timeline of the negotiations, he said, "There is never a timeline in negotiations. You should do it patiently, as you are doing it for the long term."

US President Donald Trump has imposed a 50 per cent tariff on Indian goods exported to the US. Initially, Trump announced 25 per cent tariffs on Indian goods, while later, he imposed another 25 per cent tariff, taking the total to 50 per cent, citing India's continued imports of Russian oil.

The secondary tariff came into force on August 27. The higher duties are applicable to all Indian products that are either entered for consumption in the US or withdrawn from warehouses for consumption.

While the Goods and Services Tax (GST) reforms were announced amid the implementation of the US tariffs, Piyush Goyal said that the work on the tax reforms was being carried out for months, and the two have coincided by "chance".

In a significant development, Meghalaya Chief Minister Conrad Sangma on Thursday met Union Home Minister Amit Shah in New Delhi to discuss several key issues concerning the state's governance, identity and aspirations. In the meeting, Mr Sangma discussed

four critical issues concerning the state, ranging from administrative reforms to cultural recognition. He also demanded a separate cadre for Meghalaya, which is currently under a joint cadre with Assam.

Mr Sangma pressed for inclusion of Khasi and Garo languages in the 8th schedule to the Constitution. He has also demanded for the implementation of Inner Line Permit in Meghalaya, a long standing demand of the civil society groups of the state. Inner line permit is a special document that non-domicile of few northeastern states needs before entering the states of Nagaland, Mizoram, Arunachal Pradesh and Manipur.

Separate Cadre for Meghalaya

Mr Sangma reiterated his long-standing demand for the creation of a separate All India Services cadre for Meghalaya. Currently, the state shares a joint Assam-Meghalaya cadre, a situation unique in the country. He argued that segregating the cadre would allow

Meghalaya to have dedicated officials, improving governance and administration.

Inclusion of Khasi and Garo Languages

The Chief Minister also pressed for the

these languages, he said, would be a major boost to cultural identity and preservation.

Implementation of Inner Line Permit

On the issue of the Inner Line Permit (ILP), Mr Sangma once again urged the Union Government to implement the system in Meghalaya. He highlighted the Assembly resolution already passed in its favor and pointed to growing concerns about illegal immigration and infiltration, particularly given the state's proximity to international borders. He stressed that ILP was the most viable mechanism to safeguard the state's interests under current laws.

Tribute to PA Sangma

Finally, the Chief Minister proposed naming a road in New Delhi after late Purno Agitok Sangma, former Lok Sabha Speaker and one of the tallest leaders from the Northeast. Describing PA Sangma as a national figure who consistently raised the voice of tribals, minorities, and the people of the Northeast, he said the gesture would be a fitting tribute.



24x7 assistance and monitoring for flood-affected people: CM Rekha Gupta

Chief Minister Mrs Rekha Gupta has said that her government is closely monitoring the flood situation. Government teams are providing 24x7 assistance to affected people. They are being continuously supplied with food, water, medical aid, toilet facilities, and other essential help.

Fodder is also being provided for cattle belonging to farmers in the affected areas, and residents are being shifted to relief camps wherever necessary.

Regarding the flood situation in the capital, the conditions in impacted areas, and the essential assistance being provided, Chief Minister Mrs Rekha Gupta yesterday held an online review meeting from her camp office. Chief Minister Jan

Seva Sadan with the Divisional Commissioner and all District Magistrates, issuing clear and necessary directions. Giving details of the meeting, the Chief Minister informed that the water in the Yamuna is continuously receding and it is likely that the situation will soon return to normal. Nevertheless, her government remains fully engaged in supporting those impacted.

She emphasised that all senior officers have been instructed to maintain round-the-clock vigil in affected areas and ensure proper arrangements for food, water, medical care, sanitation, and other essential services in relief camps. The Chief Minister underlined that safeguarding the lives and

property of those impacted by this natural calamity is the foremost responsibility of her government, and no negligence will be tolerated. The Chief Minister added that due



to continuous rainfall and flooding of the Yamuna, people residing in the river's low-lying areas had to be evacuated. Her government has set up relief camps for these residents, where proper care is being

ensured.

Mrs Rekha Gupta further said that all District Magistrates have been given specific instructions to pay special attention to the elderly, women, and children in the affected areas.

According to her, the District Disaster Management Authority (DDMA) is also keeping constant watch. Officials have also been instructed to coordinate with local social organisations wherever required, so that timely and effective help reaches the people.

District Magistrates have also been asked to ensure the protection of cattle and other animals belonging to farmers, with arrangements for fodder and related needs.

Women's groups write to Sonia Gandhi, seek intervention in Dharmasthala deaths

Women's organisations have written to Congress leader Sonia Gandhi over unnatural deaths in Karnataka's Dharmasthala, urging justice and accountability. They cited historic cases, RTI data, and political silence. Groups demanded the SIT consider the 2018 Ugrappa Report.

Amid the ongoing Special Investigation Team (SIT) probe into unnatural deaths at Dharmasthala, several women's organisations have written to Congress leader Sonia Gandhi under the banner "Who killed women in Dharmasthala?" The groups reminded that in July 2025, the Karnataka State Women's Commission had already urged the Chief Minister to form a SIT following reports of unnatural deaths and sexual assaults in Dharmasthala.

Activists and local media have also highlighted historic cases, including the 2012 Sowjanya case, the 1986 Padmalatha case and the 1979 Vedavalli case. Citing RTI data, the letter noted that 424 deaths were recorded in the Ujire-Dharmasthala belt between 2001 and 2012. While the Central Bureau of Investigation (CBI) had taken up the Sowjanya case, the groups pointed out that the culprits remain untraced.

The letter flagged several concerns: a worker recently claimed possession of documents linked to multiple deaths, complainants have

faced arrests even as the probe meanders, and political parties have taken divergent stands.

The BJP, it said, is portraying the matter as a "religious war," while some Congress leaders, including Deputy Chief Minister DK



Shivakumar, Home Minister G Parameshwara and MLA Lakshmi Hebbalkar, have reportedly warned cadres against commenting on Dharmasthala on social media.

The organisations have urged the SIT to consider the 2018 Ugrappa Report, pressed for justice for victims, and called upon Congress leaders not to undermine the investigation or shield errant officers.

Karnataka Cabinet withdraws 60 criminal cases, 11 tied to DK Shivakumar supporters

The Karnataka cabinet approved the withdrawal of 60 criminal cases involving activists and political supporters. Prominent cases include those linked to Deputy Chief Minister DK Shivakumar. BJP's Ashwath Narayan slammed the move, calling it abuse of power.

The Karnataka cabinet has approved the withdrawal of 60 criminal cases registered against various groups, including farmers, Dalit activists, pro-Kannada organisations, pro-Hindu activists, and others. The cases had been filed in different police stations across the state. One of the most prominent withdrawals involves a 2019 case against supporters of Deputy Chief Minister D K Shivakumar. His followers had been booked for stone-pelting on buses and government offices in Kanakapura after his arrest by the Enforcement Directorate.

Also included is a case against supporters of Shivakumar's brother and former Bangalore Rural MP D K Suresh, who in 2012 had gheraoed the then chief minister after being excluded from a ceremony to garland BR Ambedkar's statue.

Cases related to the 2019 Chittapur stone-pelting incident, which followed a police seizure of cattle being transported based on a tip-off from Hindu activists, are also among those being dropped. Additionally, skirmishes during Ganesha processions in Ramanagar, Koppal, and other areas, taken up on the recommendation of a former BJP minister, are part of the list. The cabinet's decision also covers several cases filed against farmer and Dalit activists during state-wide agitations.

Reacting to the decision, BJP leader CN Ashwath Narayan criticised the government, saying the move amounted to an abuse of power. "The High Court has made it clear that you cannot misuse or abuse your power to withdraw cases. The government should understand that High Court judgments prevent them from doing this. They are going against the law of the land," he said. He added that instead of withdrawing,



How dare you? Video of Ajit Pawar rebuking woman IPS officer goes viral

Maharashtra Deputy Chief Minister and Nationalist Congress Party (NCP) leader Ajit Pawar has landed in a controversy after a video of him purportedly pressuring a woman IPS officer to halt action against illegal soil excavation in a village in Solapur went viral on social media. The incident reportedly occurred two days ago in Karmala taluka's Kurdu village, where sub-divisional police officer Anjana Krishna had gone to act on complaints of illegal 'murrum' excavation — a material widely used in road construction. Villagers clashed with officials on the spot, prompting local NCP workers to intervene. Party

worker Baba Jagtap is seen in the clip handing his phone to Krishna after dialling Ajit Pawar directly.

In the video, shared by many on social media, Pawar is heard speaking to Krishna from Jagtap's phone. "I can understand what you are saying, but I am unable to figure out if I am talking to the deputy Chief Minister. Can you please call me on my number directly?" the IPS officer asked. Her reply apparently made Pawar furious. He shot back, threatening action against the IPS officer. "Ek min, main tere upar action lunga (I will take action against you. I am myself talking to you and you are asking me to call you directly. You want to see me. Take



my number and make a WhatsApp call. Ina aapko daring hua hai kya (How dare you?)" the Maharashtra Minister said.

Since the officer does not recognise his voice, the Deputy Chief Minister later makes a video call, sternly telling her to stop the action. Krishna, in response,

said she had not realised she was speaking to Pawar. The NCP leader then asks her if she recognises him by face.

The Nationalist Congress Party has defended Ajit Pawar, claiming his remarks were misinterpreted. "Ajit Dada may have choked the IPS officer to pacify party workers. He didn't mean to halt the action completely," said state party chief Sunil Tatkar, stressing that Pawar never supports illegal activities. Party spokesperson Anand Pananje added that the video was being given the wrong colour. "In a democracy, even workers' grievances must be heard. Pawar only tried to manage the situation."

Siddaramaiah, his family given clean chit in Muda 'scam', panel blames officials

The commission headed by retired judge PN Desai has given a clean chit to Chief Minister Siddaramaiah and his family in the Mysuru Urban Development Authority (MUDA) site allotment case. The Karnataka cabinet on Thursday accepted the report, which also recommended legal action against officials responsible for irregularities. The Desai Commission examined allegations that Siddaramaiah's family was involved in an "illegal alternative site allotment scam" in Mysuru between 2020 and 2024. It concluded that the allotment of sites as compensation could not be termed illegal. "In respect of utilisation of de-notified land in survey number 464 of Kesare village, though the land owner insisted on



alternative un-developed land as compensation and although the resolution was also passed in 2017, the same has not been implemented. Subsequently, in 2022, sites were allotted in the ratio of 50:50 as per one of the modes of payment adopted in the same manner as allotted to others," the commission said in its findings.

Law and Parliamentary Affairs Minister HK Patil confirmed the cabinet's decision. "We (the government) had constituted Justice PN Desai's one-man Commission, which has submitted its report in two volumes. The report makes it clear that there is no truth in allegations made against the chief minister and his family. It has also asked for action against certain officials on various accounts. We (the cabinet) have accepted the report and its recommendations," he said.

According to officials, the commission exonerated Siddaramaiah and his wife Parvathi BM, citing no illegality in the allotment of 14 plots to Parvathi in lieu of 3.16 acres of her land at Kesare village. The Muda had allegedly used the land to form a layout.

According to the Chief Minister, government teams are continuously monitoring the regions to ensure that any major damage is averted. She stated that this is both a moral and administrative duty of her government. District Magistrates have also been instructed to carry out assessments of flood-damaged crops so that appropriate compensation can be considered.

She also informed that water from a few drains in neighbouring Haryana is entering the fields and low-lying areas of Delhi's border regions. She directed the concerned District Magistrates to resolve this issue promptly and coordinate with Haryana's departmental officers to ensure that the drainage system there is fixed. District Magistrates have informed that work is in progress. The Chief Minister made it clear that the lives and safety of those impacted are her government's top priority. The entire administrative machinery is active in response to the continuous rainfall and flooding. Senior officials, disaster management teams, and health services are on full readiness. The government is fully prepared to deal with any emergency that may arise.

6-hr outage in Noida's 100x sectors, water supply hit too

Residents in several highrise societies in the 100x sectors experienced a six-hour power outage on Thursday morning due to a failure in the 11kV feeder from the 33/11 kV substation in Sector 122. The outage also impacted water supply in the area.

The outage began around 7am and lasted till after 1pm on Thursday. While some of the affected societies relied on power backup, residents in others used inverters to maintain supply during the power cut. Societies impacted included RG Residency, Amrapali Zodiac in Sector 120, Gaur Grandeur, Eldeco, and Aranya in Sector 119, among others. "Power supply in the 100x Sectors failed this morning, preventing the area pumphouse from supplying water to approximately 5-6 societies, including Gaur Grandeur, RG Residency, Amrapali Platinum, Aranya, and Eldeco. Water supply has been an issue throughout the summer, with the Noida Authority's deliveries proving inadequate. The power failure on Thursday morning created yet another problem regarding water shortages," said Nikhil Singhal, president of the Noida Highrise Federation (NHRF) for the 100x Sectors. According to NHRF secretary Kapil Mehra, power outages are a major issue in the area, particularly during morning and evening water supply hours.

DTCP demolishes illegal gates, guard room in Gurgaon

The enforcement team of the department of town and country planning (DTCP) on Thursday carried out a demolition drive in new Gurgaon, removing illegal gates installed by a developer. DTCP officials said Orris Infrastructure had erected gates and deployed guards on 24-metre-wide sector roads in Sector 85 "to restrict public entry and exit", prompting complaints from residents. Acting on the complaints, the DTCP team, led by town planner Amit Madholia, reached the site and dismantled two gates blocking the sector roads.

A guard room built in the middle of the road was also demolished. Officials said Orris not only closed the sector roads but also stationed marshals to regulate vehicle movement, in violation of planning norms.

Madholia told TOI, "No one is allowed to block a 24-metre-wide road under govt policy. These are public roads meant for free movement of residents, visitors and emergency vehicles. Deploying guards to monitor entry is unlawful. We have directed the concerned SHO to take strict action if guards are reinstated in future." The demolition is part of DTCP's ongoing enforcement drive to ensure that licensed colonies and developers hand over sector roads and open spaces to the govt without any encumbrances. Officials said such blockages often lead to traffic bottlenecks and safety concerns for residents.

In a separate action, the DTCP team also razed an encroached green park in Uppal Southend, a licensed colony in Sector 49. Officials said the residents' welfare association (RWA) fenced off part of a 24-metre-wide internal road and converted it into a park, despite the road already being handed over to the govt.

Noida: Delivery boy turns predator; forces woman to strip at knifepoint

A 23-year-old hairdresser who also delivers groceries was arrested Thursday for allegedly forcing a customer to strip by pointing a knife at her son, recording her explicit pictures and videos, and later blackmailing her.

Police said the incident happened in July at the woman's Greater Noida apartment, where the accused, Gaurav, delivered milk and other household goods. The woman claimed Gaurav harassed her for over two months with the photos before she called the emergency police helpline on Sept 2, allegedly after he uploaded some of her photos online and shared them with her husband, who works in Ahmedabad. According to the cops, Gaurav visited the woman's flat, apparently saying he wanted to talk to her, on July 10. The FIR states that once he was in the house, he pulled out a knife and held it to the neck of her son, who was sleeping. The woman claimed that Gaurav threatened to kill the boy if she resisted and forced her to undress while he recorded videos and took photos. The woman, in her statement, said, "When I refused, he threatened to kill my children. He said he would throw my daughter into a drain. Fearing for their lives, I complied." Gaurav then allegedly began blackmailing her, repeatedly visiting her flat and warning her not to go to the police. On one occasion, he allegedly scaled her fourth-floor flat's balcony at night.

Flooding to snarls: Plea in court over crumbling infrastructure in Gurgaon

For many in the city, the monsoon's arrival is less a season and more a test of endurance — submerged roads, stalled traffic, and frayed tempers. For Mahender Vazirani, a resident of Sushant Lok-3, the latest deluge was the last straw. Tired of dodging potholes, wading through waterlogged streets, and watching neighbours suffer property loss and even tragedy, Vazirani filed a petition in the district court, urging judicial intervention against what he described as chronic civic neglect. The petition named MCG, deputy commissioner, and DCP (traffic), accusing them of failing their statutory duties and allowing the city's infrastructure to fall into disrepair.

The court, acknowledging the gravity of the complaint, issued notices to the city's senior officials, demanding detailed responses within two weeks. Vazirani's petition called for transparency and accountability. He urged the court to order a thorough audit of funds spent on roads,

sewerage, and drainage over the past five years, and to ensure the city's maintenance and development records are made public. The petition, argued by counsel Manish Shandilya, painted a grim picture of the crumbling infrastructure. "The roads, sewer network, and drains inside the city have turned pathetic. In this rainy season, it has turned from bad to worse," Shandilya said. He pointed to a string of recent tragedies — eight rain-related deaths in July alone, including four persons electrocuted on a waterlogged street, and several others drowned after being swept away by the city's swollen drains. "Due to the pathetic condition of roads, several accidents have occurred in the city. Multiple people have suffered injuries and there have been casualties as well," he added. Vazirani's petition argued that this state of affairs was not just inconvenient but unacceptable, especially in a city



where residents pay hefty taxes for basic amenities. "The general public and taxpayers deserve nuisance-free lives while living in the city. They must feel safe, secure, and should be able to travel throughout the city without any inconvenience. But this is not the case," the petition stated. It accused MCG of collecting house tax, drainage, and sewer maintenance charges without delivering on its promises, and alleged corruption and collusion between officials and

contractors. Not just a cry of frustration, the petition demanded systemic change. It called for a detailed audit of all funds and projects related to roads, sewerage and drainage, and insisted that the authorities be held accountable for years of neglect.

"The acts and conduct of the authorities are gross violations of the law, unwarranted, and gross negligence of the duty and responsibility assigned to them," said Shandilya. Like Vazirani, the city's failing infrastructure is a daily ordeal for many. Shivam, a corporate executive, found himself stranded after the rains on Monday evening, forced to pay Rs 600 for a 6km e-rickshaw ride — what he wryly called a "premium charge for a boat ride".

Elsewhere, officegoers were seen wading through waist-deep water near Cyber City and Golf Course Road, laptop bags held aloft as they navigated the flooded streets.

Gone with the rain: Gurgaon roads repaired before monsoon are already in ruins

The city's main arteries, from Rao Gajraj Singh Marg and Sushil Aima Marg to the stretch between Rezang La Chowk and Krishna Chowk, are now lying battered after heavy rain. In Sector 9 and 9A, cratered roads filled with water force vehicles to slow to a crawl and attempt risky manoeuvres. Rain has also eroded the surface of the Sector 17-18 road, leaving behind an uneven stretch that jolts commuters and worsens congestion. Interestingly, most of these roads were repaired right before the monsoon, but failed to withstand even one rainy season. Residents and RWAs say shoddy repair work and lack of accountability are to blame.

"It's so unimpressive that even GPS can't decide the best crater to fall into. Driving on this stretch feels like a punishment. The city planners at GMDA do not even bother to level it," said Lalit Suraj Bhola, general secretary of RWA 9A.

Rao Gajraj Singh Marg, one of the key

access routes to Udyog Vihar, has also been reduced to a battered stretch. "This road is the main lifeline for thousands, but every day we are forced to crawl through potholes and waterlogged patches. Crossing this stretch takes 20-25 minutes and damages vehicles. Authorities are simply looking the other way," said Neeraj Verma, who works in Udyog Vihar Phase-IV. Residents say repeated patchwork repairs have only worsened the problem. "Taxpayers' money is being drained. The road work on Sushil Aima Marg was carried out just two months ago. The roads don't last even one season, yet no accountability is fixed," said Rajan Sagar, RWA president of Palam Vihar.

Beyond these sectors, the situation on Southern Peripheral Road is equally frustrating. Commuters face long snarls daily due to bottlenecks near DLF Alameda. "Reaching NH-8 or Vatika Chowk has become a struggle. The waterlogged stretch forces vehicles to crawl on one lane, and potholes have developed again," said Prasenjit Bose, a

resident of Paras Irene. Residents said inadequate drainage and poor slope design were compounding the problem. Rainwater stagnates on these stretches, weakening the surface layer and leading to rapid wear. Without comprehensive recarpeting and proper quality checks, they warn, the cycle of quick fixes and collapse will continue year after year. "The real problem is poor drainage. Water just sits on the road for hours after every spell of rain. Until GMDA fixes the drainage, no amount of carpeting will survive a single monsoon," said Harpal Arora, a resident of Sector 68.

A GMDA official said roadwork was being monitored closely. "Road repairs and pothole-filling have been extensively taken up to improve conditions.

Black top work can be carried out once the weather improves. No payment has been made yet to the agency that fixed the roads. A penalty has been imposed, and directions have been given in writing to rectify the work after monsoon," the official said.

MCG to hire 4 companies to sterilise 36k strays a year, set up ABC centres

MCG has started the process of hiring agencies to sterilise and vaccinate 36,000 stray dogs annually. Four agencies will be appointed, one for each zone, with the project cost estimated at Rs 2 crore per zone, officials said. According to MCG records, 24,985 stray dogs were sterilised and vaccinated in 2024, while 16,386 such procedures were carried out between Jan and June this year. "We have initiated the process to hire four agencies for the sterilisation and vaccination of stray dogs across the city. Each agency will be assigned a target of 9,000 dogs per year, and the contract will last for one year," said MCG executive engineer Sunder Sheoran.

As per the request for proposal, the selected agencies will be responsible for setting up animal birth control (ABC) centres, arranging vehicles, and deploying trained staff to carry out sterilisation,

immunisation, and mass vaccination of stray dogs at their own expense. Each agency must provide at least one vehicle, ensure that all vehicles are equipped with GPS tracking, and install CCTV cameras at



the rear of each vehicle to record the dog-catching process. They are also required to submit daily, monthly, and annual progress reports to MCG. These reports should detail the number of dogs caught, sterilised, vaccinated, or kept under

observation, as well as any deaths before, during, or after surgery. The reports must also include the names and qualifications of veterinarians involved, the number of sterilisation surgeries each performed monthly, their registration details, and records of any post-operative complications or mortality linked to their surgeries. Officials added that agencies must strictly follow the ABC Rules, 2023, and related guidelines.

Recently, the civic body issued fresh directives to RWAs, reminding pet owners that registering all pet dogs is mandatory under the Haryana Municipal Corporation Act, 1994, and the Registration and Proper Control of Dogs Bye-Laws, 2008. In a circular issued last Saturday, MCG noted that many residents have been keeping dogs without registering them or obtaining the required licence.

Lessons in lockup: When prisoners turn teachers for fellow inmates

Behind the high walls and heavy iron gates of the district jail on the outskirts of Greater Noida, a quiet transformation is unfolding. The inmates here are not just serving sentences, they're attempting to reclaim their lives, one lesson at a time. Every morning, at the break of dawn, the sound of "pachasa"—50 rings of the jail bell—echoes through the prison in Luksar village. While some inmates head to kitchen or vegetable garden, others head to learning spaces. Jail authorities call it reform, for the prisoners, it is a way to hold on to hope. Prashant Tyagi, a BA in Hindi serving a life sentence for murder, never imagined that his education would mean anything in the barracks. But when an elderly inmate asked him how to read and write, something changed. "When I started teaching him, others came forward too. Now, it's a routine. We gather, we learn, we grow," he said. This organic effort caught the attention of jail authorities, who structured it into a proper

initiative. Jail superintendent Brijesh Kumar said, "We realised many inmates were illiterate, and learning could be their first step towards rehabilitation. We identified about 500 prisoners who needed basic education. The goal is simple. When they step out, they should be able to sign their name." For 65-year-old Rampal Singh, the first few days in jail were suffocating. Convicted under charges he claims are false, the weight of his sentence crushed him. But within the bleakness of his new reality, he found a reason to keep going. "Other inmates introduced me to the adult literacy programme, and I started teaching. It became my escape. If I can help even one person learn to read and write, I will have done something good with my life," he said. Each of the 68 barracks now conducts a one-hour daily adult literacy class for 30-40 inmates. "They have been provided study material, stationery and blackboards by NGOs. Some inmates learn basic reading and writing skills, while others, under

the guidance of peer educators, explore maths," said Mithun Singh from India Vision Foundation. Before Naresh Choudhry (56) was sentenced under IPC Section 302 (murder) in 2009, he had been a teacher for 15 years. "When I first arrived, I felt lost," he said. "But then I saw so many who could not write. I picked up my pen again, not for myself, but for them."

"Naresh is now a key figure in the literacy programme. He believes that writing can change lives. 'If you can teach a man to write a poem, perhaps you can teach him to write a new future for himself,'" he said. Akidatta Raja, who is serving a life term, said his journey began when he saw a fellow inmate struggling to read a letter from his family.

"He was staring at the paper for hours, unable to understand what his own child had written. That moment stayed with me," he said. "I offered to help him read, and before I knew it, others started coming to me too." For Anil Tiwari (48), who was a tutor, the prison's literacy

programme is a continuation of the life he left behind. "Maybe they made mistakes, maybe they were caught in circumstances beyond their control.

But everyone deserves a second chance, even if that second chance comes in a place like this," said Tiwari, who was imprisoned for the murder of his wife over dowry.

Mukesh Sharma, who is serving a life sentence for a kidnapping and murder, believes that education inside jail is more than just learning.

New Delhi: Lawns outside Delhi University's Arts Faculty are buzzing on a humid September afternoon. Groups of students sit under trees, sipping tea and exchanging notes. But the chatter isn't about fests or classes — it's about survival in Delhi. Expensive paying guest (PG) accommodations, soaring college fee, long commutes, unsafe streets and a range of other overwhelming daily struggles of students are dominating the conversations around the Delhi University Students' Union (DUSU) elections. For many day boarders, reaching daily classes comes at a cost and exercises a financial strain. Calculating her monthly commute, Priya Sharma, a third-year student from North Campus, said: "I spend more than Rs 3,000 a month just on Metro and bus passes. This is not fair. A 50 per cent concession is not a luxury — it's a necessity." Her friend Anjali Verma from Hindu College adds, "For students like us who travel every day from far-off places, this demand is about access to education, not just comfort." Those who make it to campus are hit by another worry — fee. Rahul Yadav of Ramjas College said: "Every year, fee is raised without consider-

ing students' financial conditions. If two students are studying the same course, why should one pay double just because of the

thousands. Accommodation is no less of a headache. With limited hostel seats, most outstation students are pushed into private

provide proper housing," Archit said. As the sun sets, safety becomes the biggest concern, especially for women. Simran Kaur of Daulat Ram College says she avoids walking on certain routes after dark. "Many streets are poorly lit and CCTV cameras don't work. After 7 pm, North Campus doesn't feel safe for us." Students say situation isn't much better inside classrooms and libraries. Wi-Fi signals keep dropping, canteen food gets complaints and libraries are so overcrowded that students often wait for hours for a seat. "Reading halls are always packed, and Wi-Fi barely works. DU should invest in improving academic infrastructure, not just election posters," says Rohit Singh of Ramjas College, pointing at the campaign hoardings plastered across walls. Amid all posters and sloganeering, many students say they are tired of the political drama. Kartik Meena from Kirori Mal College puts it simply: "Elections should be about student issues, not party politics. Fee hike, transport, hostels — these affect us daily." The frustration is shared by many across the campus. Sitting outside Sri Ram College of Commerce (SRCC) canteen, Nisha Rawat says, "We are told DU is a top-ranked public university. But basic things like affordable food, hostels and women's security are still missing. Our vote will go to those who listen to us, not those who just shout slogans." As campaigning heats up, one thing is clear, stu-

dents this year want solutions, not promises. Affordable education, safe and reasonable housing, reliable transport and better facilities are the real issues at stake in what remains the country's most closely watched student election.

Prisoner creates ruckus at jail, threatens to kill officials

Gurugram: A prisoner of Faridabad's Neemka jail threatened to shoot the Assistant Superintendent and the head warder. He made a noise while talking on the phone, and when interrupted, he not only misbehaved with the head warder but also tore off his uniform. According to the complaint filed by head warder Devi Singh, a staff member told him that the prisoner, Lalit, was creating a ruckus to make a call. "On the complaint of the telephone booth in-charge, I called the prisoner. When I confronted him, he not only tore off my uniform but also pushed me back. Assistant Superintendent Umesh Kumar then reached the spot. Lalit threatened to shoot me and Kumar in front of the guards," the head warder said. The FIR was registered against the prisoner for obstructing government duty, tearing uniform during government duty and threatening to kill at the Sadar, Ballabhgarh police station. "Action will be taken according to whatever facts emerge," Inspector Umesh Kumar, SHO of the Sadar, Ballabhgarh police station, said.

Authorities intensify bio-security measures, surveillance at city zoo

New Delhi: Following the outbreak of H5N1 avian influenza at the National Zoological Park here, the authorities on Sunday intensified surveillance and bio-security measures at the facility. According to zoo officials, surveillance teams are conducting inspections of the entire premises twice in a day. Enclosures, water ponds and foraging grounds frequented by migratory birds are being thoroughly cleaned and disinfected. Health and behaviour of animals are being closely tracked by keepers as well as through CCTV monitoring. "All zoo staff members have been equipped with protective gear, including gloves, masks, protective suits and shoe covers, to ensure safety and minimise the risk of transmission," an official statement from the zoo read. As of Sunday, no new casualties have been reported among water birds or migratory species. However, three painted storks and one black-necked ibis have been separated from the aviary and are under treatment and observation. So far, six painted storks and two black-necked ibises have died inside the water bird aviary, while four migratory painted storks died in the ponds. Two samples each of painted storks and black-necked ibises were sent to lab. The results confirmed the presence of H5N1 avian influenza. H5N1 is a highly pathogenic strain of avian influenza virus, which is listed by the World Health Organisation (WHO) as a significant zoonotic disease with pandemic potential.

Posing as telecom officer, Ludhiana man held for fraud

Gurugram: The accused, Shiva, who went to Laos in March, would dupe Indians by posing as a fake officer of the Telecom Regulatory Authority of India (TRAI), CBI and the police. The police have seized a passport and a mobile phone from his possession and are investigating the fraud network. A local had filed a complaint on May 15, stating that he had received a call, wherein the caller introduced himself as an employee of the TRAI and said that his number was being used for illegal activities. He claimed that a case had been registered against him at the Colaba Police Station in Mumbai. Later, he made him talk to a fake police official. "The fake police official mentioned my name in a money laundering case and said that a warrant had been issued. Then, he digitally arrested me. I transferred money as per the direction of the fake police official," the complainant told the police. An FIR was registered and a cybercrime team of the West police station arrested the accused in Ludhiana on August 27. He was taken on an eight-day police remand after being produced in a city court. The accused was identified as Shiva, alias Harsh, a native of new Vijay Nagar.

Trump says will speak with Putin soon

Washington . (Agency)

US President Donald Trump said Thursday he would speak soon with Russia's Vladimir Putin, after his call earlier in the day with Ukrainian counterpart Volodymyr Zelensky and European leaders. "I will be, yeah," Trump told a reporter asking if he would speak with the Russian leader in the near future, on the sidelines of a dinner with prominent US tech executives at the White House. Trump's call with European leaders came after a summit in Paris aimed at firming up plans for security guarantees for Ukraine if or when there is a ceasefire.

Kremlin spokesman Dmitry Peskov said Friday that talks with Trump "can be organized very quickly if necessary" but rejected out of hand the idea of Western security guarantees for Kyiv.

"Can foreign, especially European and American military contingents, provide and guarantee security for Ukraine? Definitely not, they cannot," Peskov told state news agency RIA Novosti. "This cannot be a guarantee of security for Ukraine that would suit our country. "More than two dozen countries have pledged to join a "reassurance" force to deploy in Ukraine after any eventual peace deal, aiming to deter Moscow from again attacking its neighbour, leaders announced Thursday after the Paris summit.

However, there is growing concern that Putin has no interest in ending the conflict, with alarm intensifying after a visit to Beijing this week during which he vowed Russia would fight on in Ukraine if a peace deal cannot be reached.

UK Doctor, Who Chopped Off His Legs, Jailed For Fraud, Saving Amputation Porn

A UK judge jailed a vascular surgeon Thursday after he admitted making fraudulent insurance claims that involved having his legs amputated following self-inflicted injuries made "in part for sexual gratification". The case saw surgeon Neil Hopper also plead guilty to possessing extreme pornographic images, relating to videos by an extreme body modifications website called the EunuchMaker, which depicted genital mutilation. Judge James Adkin handed Hopper, 49, of Cornwall in southwest England, a 32-month sentence, telling the surgeon he must serve 40 percent of it behind bars before being considered for parole. The judge also made the surgeon in England's state-run National Health Service (NHS) the subject of a 10-year Sexual Harm Prevention Order, which restricts offenders' behaviour to protect the public. Hopper, a married father who had carried out hundreds of NHS amputation operations, pleaded guilty to fraud by false representation after making insurance claims for nearly £163;500,000 (\$671,000) following his own amputations. In 2019 he used dry ice to freeze his legs but on admission to hospital said he had been unwell with diarrhoea and vomiting and he was treated for suspected sepsis. He eventually underwent a double foot amputation later followed by a further operation to remove his legs below the knees.

Becoming an amputee had long been an ambition of his and he had a sexual interest in it, the court heard.

"You subsequently made fraudulent insurance claims ... by representing that the injuries were organic, caused by sepsis, when you caused the injury seemingly at least in part for sexual gratification," Adkin said as he sentenced him. Hopper was identified following investigations into Marius Gustavson, who ran the EunuchMaker site. The ringleader of the site had his penis and leg removed and assisted others in cutting off body parts, before being jailed for life by a London judge last year.

China's Victory Parade Stuns The World: Five Bold Messages The Dragon Sent To Friends And Foes

China unleashed one of its most massive military spectacles in decades, displaying everything from nuclear warheads to cutting-edge fighter jets and missiles, in its Victory Day parade on September 3. The show of strength sent ripples across the globe. Leaders from 20 countries, including Russian President Vladimir Putin and North Korean leader Kim Jong-un, witnessed Beijing's showcase, which projected not only its military might but a meticulously crafted message to allies, rivals and the global order. Every maneuver and display highlighted that China's rise is relentless and its strategic influence is steadily expanding. The parade marked the 80th anniversary of China's victory over Japan in World War II, carrying a pronounced anti-Japanese undertone. Chinese analysts state that the event sent a subtle but unmistakable warning to Tokyo, particularly on the sensitive Taiwan issue. Beijing aims to encourage restraint and dissuade Japan from adopting a "Taiwan is Japan's concern" approach. Gao Zhikai, professor at Soochow University and deputy director at the China Globalisation Centre, observed that Beijing could have leveraged the occasion to seek a joint statement from attending nations to prevent Tokyo from amending its pacifist constitution and to curb any assertive stance on Taiwan. The parade also delivered a pointed message to Taiwan. Analysts likened Taiwan's resistance to "an insect attempting to halt a moving chariot", highlighting the military disparity across the Taiwan Strait.

Beijing framed the Victory Day as a shared historical moment with Taiwan, highlighting Japan's colonial atrocities, including the killing of 400,000 people in Taiwan, and portraying Taiwan's current leadership as weak for aligning with Tokyo instead of China. Professor Shen Yi of Fudan University described the parade as a defining moment in the shifting global power balance.

Collateral consequences of Ukraine conflict, including fuel price, affecting Global South: India tells UNGA

India has consistently advocated that the path of dialogue and diplomacy is the only way forward to end the ongoing conflict in Ukraine, no matter how insurmountable such a course may appear.

India has voiced regret over the Ukraine conflict's collateral consequences, including prices of fuel, saying countries of the Global South have been left to fend for themselves, as Delhi underscored that diplomatic efforts hold the promise to end the war and bring lasting peace. India continues to remain concerned over the situation in Ukraine. We maintain that the loss of innocent lives is unacceptable, and

no solution can be found on the battlefield, India's Permanent Representative to the UN, Ambassador Parvathaneni Harish, said Thursday. Addressing the UN General Assembly debate on The situation in the temporarily occupied territories of Ukraine', Harish said India continues to "note with regret that the collateral consequences of the conflict, including prices of fuel, is affecting the world at large and particularly the countries of the Global South, which have been left to fend for themselves. From our perspective, it is critical that their voices are heard, and their legitimate concerns duly addressed".

Underscoring that the wholehearted participation and commitment of all stakeholders are critical for lasting peace, India told the UN General Assembly that it welcomes the "recent positive developments" in this direction. Harish said Delhi endorsed last month's summit meeting in Alaska between US President Donald Trump and Russian President Vladimir Putin, and voiced appreciation

for the progress made at the summit.

We also note the subsequent diplomatic efforts by the US president in engaging with Ukrainian president and European



leaders in Washington Harish said. We believe all these diplomatic efforts hold the promise of bringing to an end the ongoing conflict in Ukraine and opening up prospects for a lasting peace.

Three days after rolling out the red carpet for Putin for the summit meeting in Alaska, Trump hosted Ukrainian President Volodymyr Zelensky and seven other

European leaders - German Chancellor Friedrich Merz, French President Emmanuel Macron, United Kingdom Prime Minister Keir Starmer, Italian Prime Minister Giorgia Meloni, Finnish President Alexander Stubb, President of the European Commission Ursula von der Leyen and NATO Secretary-General Mark Rutte - in the White House. Harish said Prime Minister Narendra Modi remains in touch with Putin, Zelensky and the European leadership on the evolving situation. Underlining that an early end to the Ukraine conflict is in everyone's interest, Harish referred to Modi's message that this is not an era of war and emphasised that Delhi stands ready to support diplomatic efforts for an early end to the conflict. Hours before India's statement at the UNGA, Modi spoke with European Council President António Costa and von der Leyen. Exchanged views on issues of mutual interest and efforts for bringing an early end to the conflict in Ukraine, Modi said in a post on X.

"Cannot Provide Assurances": Russia Rejects Western Security Guarantees For Ukraine

Russia rejected the notion of Western security guarantees for Ukraine on Friday, after more than two dozen countries pledged to join a "reassurance" force to deploy in the war-torn country after any eventual peace deal with Moscow. A force to deter Russia from again attacking its neighbour is a key pillar of the security backstop a coalition of mainly European countries want to offer to Ukraine if the war ends via a peace deal or a ceasefire. The extent of any US involvement remains uncertain, even after European leaders spoke to President Donald Trump via video conference following the Paris summit at which the "coalition of the willing" pledged its force. But on Friday, Kremlin spokesman Dmitry Peskov rejected the idea of Western security guarantees for Ukraine, saying that "foreign, especially European and American" troops "definitely cannot" provide such assurances to Kyiv. The Paris summit was hosted by French

President Emmanuel Macron and attended by Ukraine's President Volodymyr Zelensky, while others, like British premier Keir Starmer,



participated remotely. The meeting represented a new push led by Macron to show that Europe can act independently of the United States after Trump launched direct talks with Russian President Vladimir Putin.

The United States was represented by Trump's special envoy Steve Witkoff, who also met with Zelensky separately. Trump said after his call with European leaders that he would speak to Putin soon, with Peskov confirming Friday

that such a call could be organised swiftly.

'First concrete step'

Europe has been under pressure to step up its response over three and a half years after Russia launched its full-scale invasion in February 2022.

"We have today 26 countries who have formally committed -- some others have not yet taken a position -- to deploy as a 'reassurance force' troops in Ukraine, or be present on the ground, in the sea, or in the air," Macron told reporters, standing alongside Zelensky. Zelensky hailed the move: "I think that today, for the first time in a long time, this is the first such serious concrete step." The troops would not be deployed "on the front line" but aim to "prevent any new major aggression", the French president said.

Macron added that another major pillar was a "regeneration" of the Ukrainian army so that it can "not just resist a new attack but dissuade Russia from a new aggression".

Facebook Brings Back "Poke" Feature After Nearly A Decade

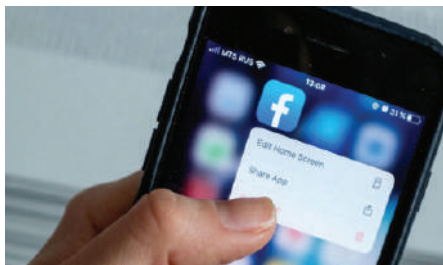

Meta is bringing back one of its classic and most nostalgic features, the Poke, on Facebook. Originally launched in 2004, the Poke allowed users to send a simple nudge to friends to say hello, get their attention, or just have fun with them without sending a message.

"Sending pokes just got easier," Facebook wrote in a carousel post, with the caption, "It's time to start poking again." In an Instagram post, Meta stated that the company was restoring pokes to user profiles in the Facebook app. "Pokes never really left, but they're making a comeback in a major way!"

Facebook users will now have a special page in the app that shows everyone who has poked them, Meta said. Earlier, Pokes were easy to miss. On facebook.com/pokes, users can see all their pokes and track interactions with friends. This time, Meta is also adding a



twist to the feature. Different emojis now appear depending on how many pokes have been exchanged between friends to give a Snapchat-like feel.

What is the Poke feature? Facebook first launched the Poke feature in 2004. It was a simple way to get

someone's attention. It became one of Facebook's signature features in the early years. People used it to flirt or show interest, play around with friends, and break the ice without sending a message.

It was particularly popular among teenagers and college students. As Facebook grew, new features like Messenger, likes, and reactions became more popular. However, the Poke feature lost its relevance and was removed from the main app by 2014.

How to use Poke feature on Facebook? Users can now poke friends directly from their Facebook profile, instead of searching or using a separate page. When someone pokes you, you'll receive a notification, so you always know when a friend is interacting with you. "Now you can poke your friends directly from their profiles and learn about new activities through notifications," Meta said.

Trump says Zohran Mamdani likely to be New York's next mayor unless 2 of his opponents quit the race

President Donald Trump said Thursday that he thinks Democrat Zohran Mamdani is likely to become New York City's next mayor unless two of the three major candidates running against him drop out of the race. But the Republican didn't say which two candidates he'd like to see quit. Trump said "No" when he was asked by a reporter Thursday night if he'd urged or encouraged any of the candidates in the race to drop out, but went on to say he would like to see that happen.

"I don't think you can win unless you have one-on-one, and somehow he's gotten a little bit of a lead," Trump said of Mamdani. "I have no idea how that happened."

The president, who spoke as he hosted a dinner at the White House with tech executives, went on and said, "I would like to see two people drop out and have it be one-on-one, and I think that's a race that could be won." Mamdani, a 33-year-old democratic socialist, has been the presumptive favorite in the election since soundly beating former Gov. Andrew Cuomo in the Democratic primary in June. But Cuomo is still on the ballot as an independent, as is incumbent Mayor Eric Adams. Joining those three Democrats in the field is Republican Curtis Sliwa, the founder of the Guardian Angels crime patrol group. Recently, intermediaries for Trump reached out to people close to Adams to talk about whether he would consider abandoning his reelection campaign to take a federal job, according to people familiar with those conversations who spoke to The Associated Press on condition of anonymity because of the private nature of the talks.

On a recent trip to Miami, Adams met with Steve Witkoff, a former real estate developer in New York who is now one of Trump's main diplomatic envoys in Washington, according to one of the people briefed on the discussions. Adams acknowledged meeting with "several political figures" on his Florida trip, which he said was to "deal with some personal issues." But he has repeatedly insisted he won't quit.

Adams reiterated his intention of staying in the race Thursday, adding that he wasn't bothered by growing calls for him to end his campaign. "No pressure, no diamonds," Adams told reporters at an event touting an endorsement from some Muslim leaders. "Just because people yell at you and call your names, and just because a number of people ask you to step down or don't do what you believe, you're supposed to succumb to that? That's not what I do."

AdvAdams' campaign was deeply wounded when he was indicted on corruption charges last year, then developed a warm relationship with Trump that bothered many Democrats in one of the country's most liberal cities. There was further backlash from Democrats after the Justice Department said.

Aftershocks rattle Afghanistan after quake kills 2,200; aid groups plead for funds

Two powerful aftershocks shook eastern Afghanistan in a span of 12 hours, the German Research Center for Geosciences (GFZ) said, triggering fears of more deaths and destruction on Friday in a region where about 2,200 people died in quakes in four days. Survivors in the earthquake-prone region are scrambling for basic amenities as the United Nations and other agencies warn of a critical need for funds, food, medical supplies and shelter, with the World Health Organization seeking funds of \$4 million. The latest aftershocks follow two earthquakes that ravaged the South Asian nation, crushed by war, poverty and shrinking aid. The Taliban administration estimated 2,205 deaths and 3,640 injuries by Thursday. A Reuters witness said continuous aftershocks hit the province of Nangarhar and details of the damage were still being collected.

Friday's earthquake of magnitude 5.4 struck

the southeast at a depth of 10 km (6.2 miles), GFZ said, hours after one late on Thursday night. The week's first earthquake of magnitude 6, just minutes before midnight on Sunday, was one of Afghanistan's deadliest, unleashing damage and destruction in the provinces of Nangarhar and Kunar when it struck at a shallow depth of 10 km.

A second quake of magnitude 5.5 on Tuesday caused panic and interrupted rescue efforts as it sent rocks sliding down mountains and cut off roads to villages in remote areas.

With houses built mostly of dry masonry, stone, and timber, some families preferred to stay in the open rather than return home, as a precaution against aftershocks.

Naqibullah Rahimi, a spokesperson for the health department in Nangarhar province, said the epicentre of Thursday's earthquake

was in the district of Shiwa near the border with Pakistan, and there were some initial



reports of damage. The earlier quakes flattened villages in both provinces, destroying more than 6,700 homes, and rescue workers pulled bodies from the rubble on Thursday.

The earthquakes mainly happen in the Hindu

Kush mountain range, where the Indian and Eurasian tectonic plates meet.

FUNDING CRISIS

Landslides and debris on key roads hampered relief work, the WHO said, while calling for more funds to provide healthcare and disease surveillance.

"A funding gap of at least \$4 million threatens to delay critical activities, underscoring the urgent need for international support," it added in a statement. It warned against the risk of disease, stemming from overcrowded shelters, unsafe water and inappropriate waste management, while an influx of Afghans recently deported from Pakistan strains the fragile healthcare system.

Afghanistan's Taliban government appealed for urgent aid from the world soon after Sunday's disaster. But relief has been scant in a country largely ignored by the world since the Taliban takeover in 2021.

34 ‘human bombs’ carrying ‘400 kg of RDX’: Mumbai police on alert after threat message

The WhatsApp message, which claims to be from the ‘Lashkar-e-Jihadi’ organisation, also said that 14 Pakistani terrorists have entered India.

The Mumbai traffic police received a threat message on its WhatsApp number Friday in which the sender claimed that 34 “human bombs” carrying “400 kg of RDX” have been planted in 34 vehicles for a blast that will “shake the entire city”, officers said. The message, which claims to be from the ‘Lashkar-e-Jihadi’ organisation, also said that 14 Pakistani terrorists have entered India. “Mumbai Police is alert, and security across the state has been enhanced. All angles of the threat are being investigated,”



an officer said. This comes even as the Mumbai police are preparing for Anant Chaturdashi and Eid-e-Milad festivals in the city. “We keep receiving such threatening messages from unknown numbers on our helpline. Most of the time, they either are from someone facing mental health issues or those under the influence of alcohol,” the officer added. “However, every time we receive such a message, we have to take it seriously and follow the protocol set up for such cases. If a specific location is mentioned, we have to evacuate the premises and carry out a check with the help of the bomb disposal squad,” the officer said. In this case, the message does not mention a specific location, the officer said, adding that they are tracking the number and should be able to identify the sender soon. “Further legal processes, like registration of an offence in the matter, will take place soon at the local police station.”

Onam eve rush grips Thiruvananthapuram as shoppers crowd markets

The state capital on the eve of ‘Thiruvonam’ witnessed ‘Uthradapachil’ — an unprecedented rush with people thronging the streets for last minute purchases. Traffic at Overbridge, East Fort, Chalai, Pazhavangadi and MG Road intermittently halted with shoppers dominating the streets for buying vegetables to textiles to celebrate Onam. Almost every street leading to Chalai, Palayam and MG Road — three popular shopping areas — were taken over by shoppers and pedestrians. Many feel that Onam festivities are almost back to normal compared to the previous years which were marred by the Wayanad landslide, pandemic and flood. On Thursday, the Chalai market was seen buzzing with activities from morning itself. Jayakumar P, a vegetable vendor at Chalai Market, said that the business is good. “There was no price surge on perishables like last year. We are also getting good sales and the market has been buzzing with customers all day. We are



content that people are able to make purchases for Onam without burning a hole in their pockets,” said Jayakumar. Sakeer, a wholesale vegetable vendor said the availability of vegetables has helped keep the prices on check this year. “The prices of vegetables surge depending on its availability and fortunately, there was no shortage this year,” he said. The market intervention by the state government to rein in coconut oil prices has come as a huge relief for families. Vijayamma Y, who came from Sreevaraham to make last minute purchases at Chalai Market, appreciated the effort of the government to slash the coconut oil prices. “Normally, the price of vegetables surge during Onam but this year things are different and except for some items we don’t feel any additional price rise on perishables this Onam. SupplyCo is selling coconut oil at subsidised rates and that helped a lot to bring down the coconut oil prices. The price before was Rs 550 for 1kg,” said Vijayamma.

Mumbai wakes up to light rain amid a yellow alert; showers to let up from Sunday

The rain led to traffic snarls in multiple locations in Mumbai, including the Western Express Highway and the Eastern Express Highway.

As Mumbai continues to be under a yellow alert until Saturday, the Maximum City woke up to a light and moderate spell of rain Friday morning, and the India Meteorological Department (IMD)’s forecast showed that light showers will continue for the next 48 hours. According to the weather bureau, Mumbai is expected to remain overcast throughout the day, with cloud cover persisting. The Brihanmumbai Municipal Corporation (BMC)’s automatic weather stations (AWS) show that Mumbai’s eastern suburbs recorded 24.86 mm of rainfall till Friday morning, followed by 9 mm in the island city, and 7.15 mm in its western suburbs. IMD’s record shows that the Santacruz observatory has recorded 11 mm of rainfall until Friday morning, followed by 9 mm at the coastal observatory at Colaba.

“The ongoing rain activity is ongoing due to low pressure that has developed in the Bay of Bengal. This low pressure is leading to an interaction between dry and moist winds, which is creating heavy rainfall over Mumbai and adjoining districts in the Konkan region of Maharashtra,” a senior official told. In its last five-day forecast that was issued Thursday, September 4, IMD sounded an orange alert for the Palghar, Thane, and Raigad districts till Sunday, September 6. The IMD forecast also stated that rain activity will gradually subside from September 7 onwards.



Meanwhile, the rain led to traffic snarls in multiple locations in Mumbai, including the Western Express Highway (WEH) and the Eastern Express Highway (EEH).

So far, IMD’s Santacruz observatory has received 2,530 mm of rainfall since June, and the Colaba observatory has received 1677.4 mm of rainfall until now. Overall, the city records an average of 2,319 mm of rainfall between June and September, which are labelled as monsoon months for the year. This year, Mumbai saw an early monsoon onset on May 26 — the earliest in 75 years. Typically, the arrival of the Southwest Monsoon occurs between June 8 and 15 each year, and the average rainfall recorded in June is 537 mm.

Changing City: Versova-Bandra Sea Link, a new artery for Mumbai’s western suburbs

The Versova-Bandra Sea Link (VBSL), officially known as the Swatantrya Veer Savarkar Sea Link, is nearing completion and is set to become among the most important transport corridors in Mumbai’s suburbs. The project, which is currently under construction, aims to offer a high-speed road link between Versova and Bandra, reducing travel time and alleviating congestion on current suburban roads. The state government has entrusted the Maharashtra State Road Development Corporation (MSRDC) with the project. **What is the plan?** The VBSL is a 9.8 km, 4+4 lane motorway running parallel to the western coastline of Mumbai. It will connect Bandra, Otters Club, Juhu and Versova, with dispersal points at Carter Road and Juhu Koliwada. It is situated about 900 to 1,800 metres from the coast and will feature multiple



navigational spans, cable-stayed bridges and intermediate connectors, allowing for efficient dispersal of traffic into adjoining neighbourhoods.

the Versova side. For commuters, the sea link will cut down travel time from Versova to Bandra to approximately 10-15 minutes, down from 45-60 minutes. By providing a coastal link, it will reduce pressure on local arterial roads like the Western Express Highway and SV Road, both of which see heavy suburban traffic. The project is also included in the larger Mumbai Coastal Road Project to provide continuity of movement along the western side of the city. Besides, the enhanced road capacity will provide smoother traffic flows in the suburbs, enhancing connectivity for commuters and residents in general. **Features** The central span of the project is a 300-metre cable-stayed bridge supplemented by three other navigation spans of 100-120 metres. Multi-lane toll plazas are to be located at varied dispersal points to manage vehicle traffic.

Woman prisoner under treatment ‘dies by suicide’ at Yerawada Regional Mental Hospital

Accordingly, the woman was admitted to the establishment on July 31, officers said, adding that she was found unresponsive in her ward on Wednesday morning, following which doctors at the hospital examined her and confirmed the death. After receiving information about the incident, a team from the Yerawada police station reached the spot for investigation. Prima facie, the incident appeared to be a case of suicide, said Ravindra Shelke, Senior Police Inspector. As per legal procedure, an accidental death report was filed at the station,

and an inquiry was initiated to determine the exact cause behind the death, Shelke said. In recent years, at least three cases of death by suicide have been reported at the Regional Mental Hospital in Yerwada. In September



2023, a 25-year-old man allegedly killed himself on the premises. In January 2020, another 25-year-old man, who was on trial in a murder case, allegedly took his life at the hospital. A 55-year-old patient also reportedly died by suicide at the hospital in January 2018.

Gujarat: Ajwa, Kadana, Narmada dams release water; over 160 villages on alert

Following heavy overnight rainfall in Halol and other parts of Panchmahal district — the catchment area of the Vishwamitri River — the Vadodara Municipal Corporation (VMC) on Friday opened all 62 gates of Ajwa Reservoir to release 6,600 cusecs of water downstream to create a cushion in the reservoir. The release will continue for four hours until 1 pm, after which the civic body will review the situation. Ajwa stood at 213.50 feet on Friday morning, against its rule level of 212.50 feet. Officials said the release will allow the Vishwamitri to rise up to 18 feet if required. The river overflows low-lying areas at 22 feet and the city faces major flooding once it crosses 28 feet. On Friday morning, the river stood at 11 feet at Kala Ghoda bridge, its measurement point.

Even as the city saw a pause in rainfall by mid-morning, Municipal Commissioner Arun Mahesh Babu said Vadodara remains in a “comfortable situation.” He told The Indian Express, “There is no reason for any anxiety as we are releasing water as part of the flood risk management plan. We are expected to maintain a rule level of 212.5 feet at Ajwa until the end of September. The Vishwamitri has an increased carrying capacity and it will help us maintain the level.” He added that Pratappura Dam, at around 224 feet, will be used to divert water flowing into Ajwa if required. “Pratappura has a cushion space available as we had already drained it earlier... So, Vadodara city is in a comfortable position. The catchment area has also seen rain subside today,” he said. Vadodara city has received 762.6 mm of rainfall so far this season.

Narmada Dam
The Sardar Sarovar Narmada Nigam Limited (SSNNL) opened 23 radial gates of the Narmada Dam for the first time this season, releasing 4.45 lakh cusecs of water overnight, including from the Riverbed Powerhouse. With an inflow of 4.9 lakh cusecs from upstream, the dam level has risen to nearly 136 metres, just over two feet short of its full reservoir level of 138.68 metres. The Narmada River is now raging through Narmada, Vadodara and Bharuch districts, with about 30 villages along the banks placed on alert. At Chandod, the Malhar Ghat saw 95 footsteps inundated, with only

13 visible on Friday. In Bharuch, the river touched 25 feet at Golden Bridge. Collector Gaurang Makwana said, “We are in a



comfortable situation until 27 feet but as part of preventive action, the low-lying areas have been alerted. If such a situation

arises that water is entering the low-lying areas, we will begin evacuations.” **Kadana Dam**

The Kadana Dam on Mahisagar river is discharging 2.29 lakh cusecs with 13 gates opened up to 10 feet, following heavy inflow from Bajaj Sagar dam in Rajasthan’s Banswada, Anas river in Madhya Pradesh, and rainfall in the catchment. A total of 124 villages are on high alert in Lunawada, Khanpur and Kadana talukas of Mahisagar district as well as Godhra and Sehra talukas of Panchmahal district. Another 39 villages along the Mahisagar in Vadodara district have also been alerted.

India-China | Why the glass brought back from Tianjin is half-full

Surveying Prime Minister Narendra Modi’s two-day visit to Tianjin, most China experts and ex-bureaucrats are sceptical whether an India-China rapprochement is possible. India’s ‘permanent establishment’, with its tunnel vision, is wary of China’s intentions. Like in Bertolt Brecht’s existential play Waiting for Godot, they would rather await Donald Trump’s arrival. Thus, it is largely left to the global audience to take note of the geopolitics of Modi’s visit.

If Modi travelled to China with hopes of rebuilding the India-China relations from ground zero, he returned home with a glass half-full. That is not because the visit and the meeting with Chinese President Xi Jinping weren’t meticulously planned. On the contrary, highlevel discussions in New Delhi between top officials of the two countries had preceded the visit up to the eleventh hour. First, the impact of the visit on bilateral cooperation. Xi told Modi that achieving a ‘dragon-elephant dance’ is the right choice for the two neighbouring countries. Modi argued that peace and tranquillity at the border are prerequisites for bilateral ties. While Xi flagged that the bilateral ties cannot be defined merely by the boundary issue, Modi added, and Xi agreed, that India and China are partners, not adversaries, and would have far more consensus than differences. Both agreed that differences should not turn into disputes.

Both India and China see the potential to leverage the external environment of tariff walls to build greater mutual understanding to advance commercial ties. Foreign Secretary Vikram Misri stated at a media briefing that this is a discussion going on at many levels between the two governments, and businesses and entities that are involved in trade in the two countries, “and we will have to see how it evolves”.

China is very much interested in the expansion and deepening of business ties, and more importantly, is conscious of the role that the Indian and Chinese economies can play in stabilising world trade. Thus, Modi and Xi agreed, once again, that there is need to proceed from a political and strategic direction to reduce India’s trade deficit, facilitate bilateral trade and investment ties and inject transparency and predictability into business conditions. Another significant outcome is to accelerate implementation of the understandings reached between the two countries’ special representatives at their 24th round of talks on the boundary held in New Delhi just a fortnight ago. There was understanding on the need to maintain peace on the border using the existing and new mechanisms, and to avoid disturbing the overall relationship. Misri disclosed that an immediate follow-up can be expected in the coming days and weeks to flesh out the recent decisions of the special representatives with regard to setting up an expert group to “explore early harvest in boundary delimitation” in the border areas; setting up a working group “to advance effective border management”; creating general level mechanisms in the eastern and middle sectors; and discuss de-escalation. Overall, there is no question that the meeting at Tianjin injected new momentum into the bilateral relations. Both leaders actively signalled cooperation. The involvement of Cai Qi, a senior politician in Xi’s inner circle for many years, is noteworthy. The importance of being Cai Qi should be understood. He is the first-ranked member of the Secretariat of the Chinese Communist Party (CCP), fifth-ranking member of the CCP Politburo Standing Committee and director of the CCP General Office—making him the de facto chief of staff to CCP General Secretary Xi. In his capacity as director of CCP’s General Office, Cai supervises the implementation of top-level decisions, internal and external alike.

Wake-up call on the climate front

There is a need to thoroughly review the Environmental Impact Assessment regime

THE southwest monsoon has wrought havoc in many parts of the country. The monsoon rainfall so far has been above normal, and several extreme weather events have been reported. The hill states/UT — Uttarakhand, Himachal Pradesh, Jammu and Kashmir — are the worst hit, along with Punjab, Rajasthan and parts of Uttar Pradesh and Bihar. Many cities and rural areas in southern states, too, have recorded heavy rainfall. It is scientifically established that the Indian monsoon has been affected by climate change. Several studies have pointed out that the frequency and intensity of heavy rainfall events have increased since the 1950s over most land areas, and that human-induced climate change is likely the main driver of this increase. A synthesis of these findings has been reported in the periodic assessments issued by the International Panel for Climate Change (IPCC).

Experts attribute the increased intensity of the monsoon to stronger atmospheric moisture build-up over the Indian Ocean, which, in turn, is triggered by higher evaporation due to higher sea surface temperatures, as well as an increased land-sea thermal contrast. The increased level of atmospheric moisture causes a larger moisture flux and higher precipitation as the summer monsoon moves from the southwest to the east, carrying moisture from the ocean in large rain clouds. It means that the changing monsoon patterns being witnessed are linked to larger climate change. So, should we simply blame climate change for whatever is happening and continue with ‘business as usual’ with our public policies relating to environment, urban planning, development, water resources, agriculture and so on? Not at all. First, climate change itself — as defined by the IPCC — is an anthropogenic or man-made phenomenon. For instance, if one of the key drivers of the monsoon — land-sea temperature difference during summers — is changing, it is due to excessive greenhouse gas emissions resulting from human activity. Second, while extreme weather events (incessant rainfall in monsoon and extreme heat in summer) are going up due to climate change, their impacts (flooding, loss of human life, damage to infrastructure, etc.) are getting aggravated due to wrong public policies (concretisation, encroachment of riverbeds, destruction of hills, deforestation, etc.).

The solution lies in addressing climate change and faulty developmental policies simultaneously. First, we need to make all our public policies compliant with climate change. For decades, we have been saying this, but we see little action on the ground. The progress made under the national and state climate change action plans is limited to the promotion of renewable sources of energy. Instead of focusing on a few sectors like energy or transport, the need is to mainstream climate change concerns in all public policies. For instance, while



proposing or constructing a hydropower plant or a new highway or a tunnelling project in the hills, we should take into account not just immediate environmental concerns but also present and future risks arising due to climate change. The same applies to developmental projects in the plains where urban flooding has become a regular occurrence due to mindless concretisation, destruction of lakes and water bodies.

Second, we should thoroughly review the Environmental Impact Assessment (EIA) regime. Over the years, it has been diluted, and clever ways have been devised to either circumvent its mandatory provisions or do away with it altogether. The most glaring example is the Char Dham highway project. The government agencies concerned avoided a comprehensive EIA by dividing the 825-km project into 53 smaller parts, each less than 100 km long. This way, they could avoid environmental scrutiny since the EIA is mandatory only for road projects exceeding 100 km.

Such segmentation of a large project to bypass environmental regulations was highlighted by environmentalists and raised in the Supreme Court-appointed committee. In some cases, environmental clearance was granted ex post facto to regularise projects initiated without EIA clearance. The apex court struck down the practice as illegal in May.

The disastrous results of wilfully ignoring ecological risks

involved in large developmental projects and violation of EIA terms, particularly in the Himalayas, are visible now. Therefore, we not only need to revisit the EIA regime to make it more stringent but also incorporate climate change risks that may arise during the lifecycle of a project and ways to mitigate them. Projects can be designed to better withstand future climate conditions, reducing potential damage and disruption. For monitoring compliance, an independent mechanism should be developed.

Third, we need to conduct a ‘climate audit’ of all existing infrastructure — hydel projects, national highways, road and railway bridges, airports — not from a financial perspective but to check if it is climate-resilient. This is more urgently required for the infrastructure built before the EIA system kicked in. For projects which have received the green nod, the check should be about compliance with the conditions mandated at the time of their clearance. Following the audit, necessary retrofitting measures should be initiated to make vital infrastructure climate-proof. As a first step, the environment ministry must develop a robust climate audit framework and requisite standards, protocols and tools for assessing whether existing infrastructure can withstand a changing climate. Then, a concerted, multi-sectoral national effort should be launched. The 2025 monsoon is yet another wake-up call.

Public broke Modi govt's pride; 2024 polls marked end of communal politics: Akhilesh in Lok Sabha

Referring to BJP's defeat in Faizabad, which includes Ayodhya, Akhilesh said it was perhaps the wish of Lord Ram.

Samajwadi Party (SP) leader Akhilesh Yadav on Tuesday hit out at the Modi government asserting the public had broken their pride and adding that the 2024 Lok Sabha polls marked the end of communal politics in India

Participating in the debate on the Motion of Thanks to the president's address in Lok Sabha, Akhilesh said that the election results were a moral victory and a message of responsibility for the INDIA bloc. "The public has broken the pride of the government. The court is in session, but it is very sad and without light. Why is there no connection from the top? There is no base from the bottom. What is stuck at the top? This is not a government... It feels like, for the first time, there is a defeated government. The people are saying that this government won't run. It was a moral victory for the INDIA alliance in the elections. It was a victory of positive politics," said the MP from Kannauj.

"The whole of India has understood that INDIA is pro-India. This election is the moral victory of INDIA. It is a victory



for positive politics. It is the victory of the PDA, social justice movement. 2024's message is also full of responsibility for the INDIA bloc," the Kannauj MP said, adding that "June 4, 2024, was the day of independence

from communal politics for India. In this election, communal politics has lost forever." "This election is a new era of positive politics, pro-Constitution people have won, the Constitution has won... It is the end of top-down politics," the former Uttar Pradesh chief minister added. Referring to the election result in Ayodhya (Faizabad LS constituency), where the SP defeated the BJP, Akhilesh said, "The victory of Ayodhya is the democratic victory of the mature voter of India... Hoi wahi jo Ram rachi rakha (Whatever Ram has planned will happen)." Faizabad MP and SP leader Awadhesh Kumar Prasad was seated next to Yadav during the debate.

Meanwhile, speaking on the paper leaks issue, Akhilesh claimed that the leaks were being deliberately done to avoid providing jobs for the

youth. "Why are paper leaks happening? The truth is that this is being done by the government so that it doesn't have to give jobs to youth," he said.

How to judge judgements

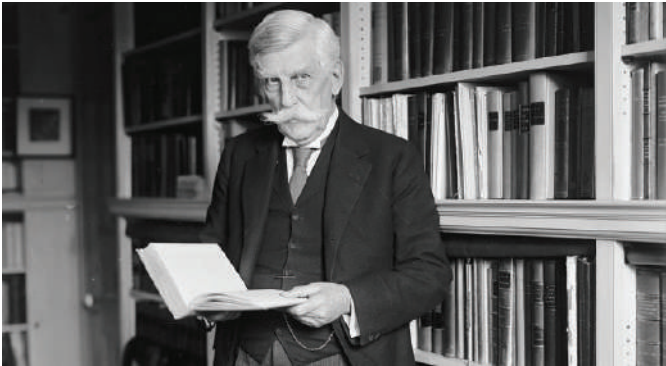
Inadequacies in criticising legal judgements have led people to dismiss practical interpretations of the law. Justice Oliver Wendell Holmes Jr said that the actual life of a law is not of logic—it’s the experience that judges’ rulings bring to it

The natural use the word ‘judgement’ is to denote a mental act of attributing a predicate to a subject. In that sense, the act of judging primarily involves inference, that is, determination of the connotation of the subject, or attribution of certain property to the object even if the inference arrived at, or the attribution cast upon, are not justified or derived through argumentation. This conception, rooted in the classical tradition extending from Aristotelian logic through contemporary analytic philosophy, generally understands judgement as the attribution of properties to particular objects or subjects.

In the legal context, where a judge is required to deliver a judgement based on facts and to justify the inference or attribution, this conception reflects as the determination that particular factual or normative claims are true or false. This determination carries significant practical consequences. When a court determines that a person is guilty of negligence, it is making a substantive assessment about the relationship between ‘individual agency’ and the legal consequence of the use of the agency. The underlying conclusion is the result of determinations about personal identity over time, the nature of causal responsibility, and the ontological status of legal properties. In this case, the court has passed a judgement that a person is guilty of a particular offense, and it differs from a more generalised judgement that “negligence must be punished with liability”. However, some

judgements do not involve such attributions or objects. This dimension concerns their relationship with truth—as a determination, recognition or attribution of truth values to factual or normative claims. Take the Kesavananda Bharati (1973) judgement, which arguably represents the most important example of such truth value attribution in Indian constitutional law. The Supreme Court held that parliament’s power to amend the Constitution was subject to implicit limitations that preserve the Constitution’s basic structure. Here, the alethic dimension manifested through the court recognising the truth of a constitutional interpretation that curbed parliament’s powers. The language of judicial judgements is the language of logic. These conceptions reveal that judicial judgements, much like other judgements, emerge not just as a derivative phenomenon but as the fundamental structure within which cognitive activity occurs. Institutions ensure that questions about the characterisation of persons and events are addressed through processes that take seriously both epistemic concerns about truth and concerns about fair procedure. However, as Justice Oliver Wendell Holmes Jr of the US Supreme Court once noted, “The whole outline of the law is the resultant of a conflict at every point between logic and good sense.” In Common Law (1881), Justice Holmes elaborated: “The actual life of the law has not been logic: it has been experience. The

felt necessities of the times, the prevalent moral and political theories, intuitions of public policy, avowed or unconscious, even the prejudices which judges share with their fellow-men, have had a good deal more to do than syllogism.” As legal realists would attest, judges’ background, beliefs, temperament and even the demeanor of the arguing



counsels affect the manner in which issues are framed and weighed. This, however, is not because the judges are acting in bad faith or pursuing an agenda. Rather, their lived experiences, which is what Justice Holmes refers to as “good sense”, lead them to see the same legal issues differently, even if the language of their judgements follow the same logic. For example, one cannot deny that Kesavananda Bharati was a product of its time. How does one then criticise judgements, especially ones that deal with constitutional issues?

One way would be evaluating the judgements based on their fidelity to formal logic and its methods. Yet, this may not always capture the undercurrents driving legal developments.

Another way would be adopting pragmatism, to judge judgements on the basis of their practical outcomes. There always being a competing “good sense”, as long as the outcomes are not anathematic, the judgement must stand. Finally, we may judge also on the basis of whether the judge has adequately acknowledged and tested their pre-suppositions in the form of adherence to procedure.

Take the recent interim order of the Madras High Court staying an amendment taking away the governor’s power to appoint vice chancellors. The criticism of the order primarily focused on what some labelled as ‘misplaced urgency’, pendency of a transfer petition before the Supreme Court, and an alleged lack of opportunity to file a counter.

However, the criticism ignores the fact that Tamil Nadu had already constituted search committees, issued government orders, published advertisements, and commenced the selection process for vice-chancellor appointments. The criticism fundamentally misunderstands judicial duty. The SC had given no stay order or oral injunction, preventing the high court from proceeding. All of these, including the issue of opportunity to file counters, are dealt with in the order.

Take measures to prevent accidents on rain-affected roads: Gangwa to officials

In response to the widespread damage caused by the recent rains in Haryana, Public Works Minister Ranbir Gangwa held an emergency meeting Thursday and directed officials to urgently repair rain-affected roads, fill potholes, and ensure the safety of bridges. He instructed officials that damaged roads be marked with warning signs if immediate repair is not possible. Haryana has already cancelled leaves of field staff till further orders, directing all engineers and workers to stay on-site for continuous monitoring of the ongoing flood-situation.

In the meeting, Gangwa added that “traffic must not be disrupted, quality of repair work must not be compromised, and public complaints, especially via the Harpath app, should be addressed promptly”.

Sumita Misra, Additional Chief Secretary (Home), announced a state-wide Civil Defence mobilisation plan to boost emergency preparedness. “The strategy includes awareness campaigns, voluntary enrollment of state employees, and special leave for those participating in training. The aim is to harness

the expertise of government personnel to improve disaster response capacity,” she said. Health minister Arti Singh Rao expressed gratitude to Chief Minister Nayab Singh Saini for promptly opening the e-Kshatipurti portal for reporting crop losses and disbursing



compensation due to extensive damage to cotton and millet crops caused by heavy rains.” Haryana is bracing for severe flood-like conditions due to relentless monsoon rains. Dozens of villages across 12 districts — spanning Ambala, Kaithal, Yamunanagar, Rohtak, Bhiwani, and others — continue to

remain inundated as rivers including the Yamuna, Ghaggar, Tangri, and Markanda have surged near or beyond danger levels.

The floodgates of the Hathnikund Barrage remained open for the fourth consecutive day (since 4 am on September 1), with water flow exceeding the danger level of 1 lakh cusecs. As of 3 pm Thursday, 1,32,295 cusecs of water were recorded.

The release of water from Hathnikund Barrage has raised the water level of the Yamuna River heading toward Delhi, putting flood-prone areas in Yamunanagar, Karnal, Panipat, and Sonapat at risk. In Faridabad, after water was released from the Okhla Barrage in Delhi, the Yamuna has reached danger level.

In Jalbehra, Kurukshetra, the Markanda River has crossed its danger level. The danger mark is 5 feet, but due to the flow of 14,000 cusecs, the water level has risen to 6.7 feet. Previously, a breach had formed near Nancy village along the Markanda, flooding nearby fields. The water has now crossed Thaska Miranji village and reached the Hisar-Chandigarh National Highway 152.

New Bengaluru civic chief directs swift action on roads, garbage black spots and encroachments

A day after taking charge as commissioner of the Bengaluru Central City Corporation, Rajendra Cholan P stressed on enhancing public transportation, safety and basic infrastructure and directed officials to initiate swift action on creating pothole-free roads, eliminating garbage

black spots, and ensuring footpaths are free from encroachments.

After his first official meeting with engineers and staff in the municipality, he instructed them to take precautionary measures in light of the ongoing rain in the city to prevent any untoward incidents.

The commissioner directed that separate contractors be appointed for each division under the corporation and instructed that potholes on major roads be filled on a priority basis. He instructed officials concerned to ensure that no complaints related to potholes remain unresolved on any web or mobile applications used by the public for reporting.

“Identify roads within the Central Business District (CBD), TenderSure roads, white-topped roads, and high-density corridors for development as model roads. For each of these roads, dedicated nodal officers will be appointed and held accountable for their maintenance,” he told the executive engineers.



Cholan also asked to prioritise beautification of Metro pillars, roadside landscaping, installation of streetlights, and ensuring their proper maintenance. Notice must be issued a day in advance to footpath encroachers, followed by clearance drives and intensive cleaning operations, he added.

India's absence from China's Victory Day parade another major setback on foreign policy front, says Congress's Vyas

Referring to China's grand Victory Day parade in Beijing, senior Congress leader Jai Narayan Vyas on Thursday raised questions on the Central government's foreign policy.

“Invitations were sent to 26 countries. The Indian government has not made any clarification on whether India was invited or not. If the Indian Prime Minister was rushing to attend the Shanghai Cooperation Organisation (SCO) summit, then this event (Victory Day parade) was an occasion for China to demonstrate its military power to the world, and especially to the US. While China's close allies like Russia, North Korea, Iran, Zimbabwe and Pakistan were present, the Indian Prime Minister was conspicuous by his absence,” former Cabinet Minister Jai Narayan Vyas stated during a press conference held at Rajiv Gandhi Bhavan.

On Wednesday, the Victory Day parade of more than 12,000 soldiers, 100 military aircraft, hundreds of other vehicles, and China's advanced military power were a special attraction at Tiananmen Square. As many as 26 countries were invited to participate in the parade, including India's neighbours Nepal, Myanmar, Maldives, and Pakistan, the Congress pointed out.

Vyas said, “In the recent meeting with Xi Jinping on the sidelines of the SCO summit, important issues like the border dispute were also kept out of the discussion. India rushed to get closer to China and Russia due to deteriorating relations with America, but this did not achieve much success, an example of which is the absence of the PM from the Victory Day Parade.

NIRF 2025: Gujarat institutes making in top 100 overall category reduces to one, ranking slips too from previous year positions

Timber logs in floodwaters: Green activists welcome SC intervention

With the Supreme Court Thursday taking serious note of videos showing a huge number of timber logs washed down by floodwaters in Himachal Pradesh, environmentalists and activists expressed hope that the state government will now be asked to bring a sustainable development policy suited to the topography of the hill state.

Noting “that in the flood, huge numbers of wooden logs were flowing around... Prima facie, it appears that there has been illegal felling of the trees, which has been going on uphill,” a bench comprising Chief Justice B R Gavai and Justice Vinod Chandran issued notices to the Centre, National Disaster Management Authority (NDMA), Ministry of Environment, Forest and Climate Change

(MOEF&CC), Ministry of Jal Shakti, National Highways Authority of India (NHAI) and states of Himachal Pradesh, Uttarakhand and Punjab, besides the Union Territory of Jammu and Kashmir.

One of the videos, widely circulated on social media, showed large number of logs floating in the Pong Dam in Mandi. A second clip surfaced later from the Ravi River, near the Old Sheetla Suspension Bridge in Chamba, showing a similar accumulation of wooden debris. The visuals raised concerns of illegal timber felling in ecologically fragile regions.

Kullu-based activist Sandeep Minhas said the apex court's intervention was timely but

stressed that the issue should not be closed merely after the state's response. “We expect



version. The court should direct the state to bring a sustainable development policy suited to the topography and ecological needs of mountain states, instead of allowing haphazard projects in fragile zones,” Minhas said.

Earlier, Chief Minister Sukhvinder Singh Sukhu had ordered a CID probe into the accumulation of logs in Pong Dam after a preliminary inquiry by the state forest department on July 8 ruled out illegal felling in the Beas catchment area. The CID inquiry, however, is still pending. Similarly, after reports of logs floating in the Ravi River, the forest department again denied illegal felling.

Gujarat: Police seize 7,800 fake notes after house raid in Banaskantha village; two held

Ahmedabad. (Agency)

The Banaskantha Police, on the intervening night of Wednesday and Thursday, raided a house in Mahadeviya village of Deesa taluka and seized 7,800 fake Indian currency notes (FICN) of Rs 500 denomination, totalling to a market value of Rs 39



lakh. The personnel of the Local Crime Branch (LCB) also seized five printers and stationery from a “special room” in the house that was set up for the operation, said Banaskantha Superintendent of Police (SP) Prashant Sumbe. The house belongs to

main accused Raimal Singh who is currently absconding, while two other accused, including Sanjay Soni and Shrimali, were caught-red handed printing the fake notes, said police.

Police said that the accused had initially told them that they had begun printing the fake notes just three-four days back and were in the process of “perfecting them” so that they could pass off as facsimiles of the real bank notes.

The police are investigating whether any of these notes have been released into the market.

An FIR was filed against the three accused at Deesa Rural Police station, booking them under Bharatiya Nyaya Sanhita

(BNS) sections 179 (using forged notes as genuine), 180 (possession of counterfeit notes), 181 (possession of instruments used in forgery), and 61 (criminal conspiracy). Further, the police added BNS sections 111(3) and 111(4) related to organised crime.

Good footpaths in Bengaluru may remain a dream

Bengaluru . (Agency)

Bengalureans' dream of having a safe, unhindered walk on the city's footpaths is likely to remain

just that for a long time, irrespective of whether the corporation is called ‘Bruhat Bengaluru Mahanagara Palike’ (BBMP) or ‘Greater Bengaluru Authority’ (GBA). Lack of funds, their improper utilisation for maintenance, and lack of interest in inter-agency coordination are being blamed for Bengalureans being deprived of the basic need for safe pedestrian mobility.

According to the data with the authority's engineering section, only 8% of the total 3,500-km footpath network in the city, or

about 280 km, is in good condition. And there is no guarantee that the number will not reduce further. Worse, even



on the 8% of “good” footpaths that exist in the city, the apathy of the civic agencies, lack of enforcement, and the absence of civic discipline among citizens ensures that the walkways are plagued with encroachments,

dangling electric wires, piles of garbage, silt cleared from drains, and public urination spots.

According to GBA engineers, there are three types of roads: arterial, sub-arterial and collector. Footpaths are mandatory for arterial and sub-arterial roads. They measure 1,682 kms in length and 90% of them have footpaths of which only 150 km are in good condition. The remaining 100 km that are part of

TenderSure and white topped roads have good paths. Also, 25% of collector roads have footpaths, but they are not in good condition. Thus, totally, 3,500 km of footpaths exist in Bengaluru, but only 8-10% is in good condition.

From Gippy Grewal to R Nait: as Punjab sees the worst floods in decades, songs are healing hearts

With fields and towns inundated, singers in Punjab have released songs of sorrow and the indomitable spirit of the state's people.

As Punjab battles devastating floods, its cultural heartbeat — its music — has stirred deep empathy and unity. From new flood-themed singles to viral social media anthems, Punjabi singers are once again proving that resilience and awareness march to the beat of their songs.

The Punjab Government has declared 23 of the state's districts flood-hit, after rivers and dams swelled to near-critical levels. More than 30 people have died and lakhs have been affected by the heavy rain and floods in Punjab.

The government has evacuated people from low-lying and flood-affected areas, and set up hundreds of relief camps to provide shelter and essential facilities to those affected.

On September 3, popular actor-singer-producer-director Gippy Grewal released Aaladna, a poignant single track that captures the emotional toll of the flood. “Lakhan supne

soorjan jidde paani vich beh gaye (Countless dreams as bright as the sun have drowned in water),” he sings, reminding listeners that it isn't just fields but futures that are lost.

The song also highlights the resilience of Punjabis to fight back.

A day before, R Nait dropped He are not Fukrey, spotlighting how Punjab's rugged tractors are wading through chest-high waters to deliver aid. With lines like “tambu taan laye bann to hun assi ghar nahi jaana... saade tractor tankan varge kyun tuhade toh zara nahi jande... (We put up tents but we won't go home... why don't our tractors spill a drop for you),” the song celebrates community resolve and selfless service.

Meanwhile, Sanam Bajaj's Fariyad Punjab Di



is streaming on YouTube, giving voice to sorrow and yearning across flooded towns. Another resonant track by Ritaz, Rabba baddal morh lai apne, nahi taan sab kuch veh jana hai (Oh God, turn back the clouds, otherwise everything will be washed away)

has been going viral on social platforms.

The song released this month features a haunting line, “paani ne hai agg lagai (the water has ignited a fire),” which connects flood fury with environmental strife, pointing to unchecked sand mining and rampant urban sprawl.

500 flights disrupted at IGLA and Hindon, airlines issue travel advisory

As the city continued to brace for torrential rain on Thursday, Delhi airports and airlines issued travel advisories for the flyers, cautioning disruptions in flight operations. In the last three days, nearly 500 flights from Delhi and Hindon airports have either been delayed, cancelled or diverted to other cities due to poor visibility and

inclement weather conditions, airport officials said.
“As per the India Meteorological Department (IMD) forecast, Delhi is experiencing inclement weather conditions. There might be an impact on flight operations. Our on-ground teams are working diligently with all stakeholders to ensure your journey remains hassle-free. For the latest flight information, passengers are advised to contact their respective airlines,” the Delhi airport said in an advisory.
The IMD on Thursday issued a heavy rain alert over Delhi-NCR for a few hours, raising concerns about further disruption to air traffic. Airlines including IndiGo, SpiceJet and Air India among others urged passengers to check their flight status before leaving for the airport.
SpiceJet, in an advisory on X, said, “Due to bad weather in Delhi, all departures/arrivals and their consequential flights may be affected. Passengers are requested to keep a check on their flight



status.” The airline also advised travellers to factor in extra time to reach the airport in view of waterlogging and traffic snarls across the city.
IndiGo, the country’s largest carrier, also cautioned of possible delays. “With heavy rainfall and thunderstorms in Delhi, we’re seeing a chance of delays and slower traffic to and from the airport. While we can’t control the skies, we’re doing everything possible to keep your journey steady on the ground,” the airline said in a statement“Please check your flight status and consider giving yourself a little cushion

of time to reach the airport,” the statement added. Despite the bad weather, airport officials maintained that ground staff were coordinating closely with airlines to minimise inconvenience to passengers, though they admitted that operations were likely to remain affected as long as the heavy downpour persisted.
Heavy downpour continues to batter city
The capital recorded widespread showers for the third consecutive day on Wednesday, triggering widespread waterlogging and traffic snarls. The IMD said that these conditions are likely to remain as the city is set to experience an active monsoon phase over the next four days.
‘Goods worth lakh damaged’
The flood has also hit the local economy. Dozens of basement shops in the area were submerged, forcing the shopkeepers to watch helplessly as their goods worth lakh were damaged in the water. The entire stock is gone, locals said.

Rajasthan man kills cousin over 'affair with wife', buries body with own excavator

A man in Rajasthan killed his cousin after suspecting him of having an affair with his wife and buried the body in a mine using his own excavator, police said.
Police in Nagaur district’s Bhawanda said the accused, identified as Sohanram (29), confessed to killing his cousin Mukesh Galwa on August 27. He allegedly tricked Mukesh into accompanying him by inviting him to a Ganesh festival programme in nearby Bhatnokha village.
After the event ended late at night, police said, Sohanram led Mukesh away from the crowd to a deserted stretch near the village road and attacked him repeatedly on the head with an iron rod until he collapsed.
Sohanram then drove the body to his own mining site, about 600 to 700 metres from a local temple, where he had access to heavy machinery. Using his excavator, he dug a 10-foot-deep pit in the middle of the night and lowered the body inside. He then covered the grave with sand and small stones to conceal the site.Mukesh’s family reported him missing on August 29 after he failed to return home. During questioning, relatives told police they suspected foul play and pointed to Sohanram. He was detained and, under interrogation, admitted to the killing, saying he was "hurt" by Mukesh’s alleged affair with his wife.
On Wednesday, police took Sohanram to the crime scene, where his directions led officers to the buried body. The body was exhumed, sent for post-mortem examination at a government hospital in Mundwa, and later handed over to Mukesh’s family.

38 relief sites with 522 tents from metro to Nigambodh ghat

As the Yamuna swelled above danger levels this week, floodwaters pushed deeper into Delhi, swamping government offices, markets, metro access points and even the city’s busiest cremation ground, forcing mass evacuations and paralysing daily life across several districts. By Thursday, water had reached near the Delhi Secretariat, which houses the offices of the chief minister, cabinet ministers and top bureaucrats.Nearby areas such as Vasudev Ghat and the Shri Marghat Wale Hanuman Baba Mandir near Kashmere Gate were also submerged. According to the revenue department, 8,018 people have been moved to tents, and another 2,030 have been shifted to 13 permanent shelters. In Majnu ka Tila, floodwater gushed into narrow lanes, leaving homes and businesses in



ruins.
The Tibetan colony, usually alive with cafés, tattoo parlours, home spas and garment shops, is now reeling. Machines have been damaged, salons lie without equipment, restaurants remain shuttered, and many owners have been forced to sleep inside their waterlogged shops.Relief camps set up in low-lying zones, including near Mayur Vihar Phase-I, were inundated after the Yamuna breached embankments. At Loha Pul (Old Iron Bridge) and Yamuna Bazar, National Disaster Response Force (NDRF) teams assisted in relocating residents.

The agency said it rescued 25 people and evacuated 1,171 individuals along with 29 livestock.
In the northeast, the DDMA reported an 11-hour search-and-rescue at Usmanpur’s 3rd Pusta, where three people, six dogs and a calf were saved with help from the Boat Club team.Transport links have also been hit. At Yamuna Bank, the approach road to the metro station was submerged, prompting the closure of station gates. Boats were used to reach stranded commuters before NDRF intervened. The Delhi Metro Rail Corporation assured that while the road was cut off, the interchange facility at the station remained functional.According to officials, six districts, North, North East, Shahdara, East, Central and South East, are now on flood watch. Majnu ka Tila and Jharoda Khan reported waist-deep water.

Yamuna swells past 207 metres, third-highest level in six decades

The Yamuna in Delhi touched 207.48 metres at the Old Railway Bridge on Thursday morning, marking its third-highest water level since 1963, according to the Irrigation and Flood Control Department.
The level, which remained static through the early hours, rose marginally from 207.47 metres recorded between 2 am and 5 am to 207.48 metres at 6 am, where it held steady until 7 am before gradually falling to 207.42 metres by 7 pm. Officials said the water level is expected to stabilise and show a gradual decline, with the Central Water Commission (CWC) forecasting a dip to around 207.30 metres by 8 am on Friday. Despite the predicted fall, the level remains well above the danger threshold of 205.33 metres and the evacuation mark of 206 metres, posing persistent flood threats for low-lying areas.
The Old Railway Bridge continues to serve as the main observation point for

monitoring the river’s flow and flood risks. “The level is above the danger mark but below the highest flood level. There is a possibility of flooding in the next few hours. People are advised not to go near the river,” the CWC warned in its bulletin.
The Yamuna had last crossed such levels in July 2023, when it swelled to 208.66 metres—the highest on record—displacing over 25,000 residents. The second-highest level of 207.49 metres was recorded in 1978.
This week’s surge has already forced nearly 10,000 people to move out of floodplains across Delhi. At 5 am Thursday, water discharge from the Hathanikund barrage was 1.53 lakh cusecs before reducing to 1.34 lakh by 4 pm. The maximum discharge reached 1.78 lakh cusecs.
Officials said coordination with the Uttar Pradesh Irrigation Department remains



crucial to regulate outflow. “Higher discharge from the Okhla barrage ensures smooth exit of water from Delhi,” an official explained.

GST Relief Done, Centre Working On Relief Package For Exporters Hit By US Tariffs: Sources

With the completion of the rationalisation of Goods and Services Tax (GST), the Centre is now gearing up for support measures for exporters hit by US tariffs, official sources told on Friday.A set of targeted schemes may soon be announced to support sectors adversely affected by the 50 per cent tariff imposed by President Donald Trump, sources said.
Key industries facing headwinds include textiles and apparel, as well as gems and jewellery, where exporters are struggling to stay competitive.Beyond these, exporters in leather and footwear, chemicals, engineering goods, agriculture, and marine products are also encountering fresh challenges in global markets.
The proposed relief package is expected to focus on the following points:
●Addressing liquidity constraints faced by small exporters
●Easing pressure on working capital
●Ensuring job security across vulnerable export-linked sectors
●Facilitating uninterrupted production while new markets are explored
Sources indicate that the Prime Minister Narendra Modi-led government is working on a stimulus model akin to the one extended to MSMEs during the COVID-19 pandemic.In parallel, efforts are underway to operationalise the Export Promotion Mission announced in the Union Budget, aimed at boosting India’s global trade footprint.India’s exports to the US during the first four months of this fiscal year have reportedly risen 21.64 per cent to USD 33.53 billion. It was USD 86.5 billion in 2024-25. About half of this is out of the ambit of 50 per cent tariffs.

Lionel Messi remains coy on Argentina future: I haven't decided about World Cup

Lionel Messi has once again cast doubt on whether he will play at the 2026 World Cup, admitting he has not yet made up his mind about extending his international career to another tournament. The 38-year-old scored twice in Argentina's 3-0 win over Venezuela in Buenos Aires on Thursday, in what he confirmed was his final World Cup qualifier on home soil. The reigning world champions, already qualified for the expanded tournament in the United States, Mexico, and Canada, were dominant from start to finish. Nicolas Tagliafico and Franco Mastantuono both went close in the opening stages, only to be denied by Venezuela goalkeeper Rafael Romo, before Messi broke the deadlock in



the 39th minute. The Albiceleste captain latched onto a pass from Julian Alvarez during a swift counterattack and fired his shot into the top-right corner. After the break, Argentina's relentless pressure was rewarded with a second goal in the 76th minute as Nico Gonzalez crossed from the left for Lautaro Martinez to score with a diving header. Four minutes later, Messi struck again, this time finishing from Thiago Almada's assist, to complete a memorable night. "It's not something I like, want or expect. But time is passing, and it's been many years," Messi said when asked about retirement. "As I've said before, I don't think I'll play another World Cup. At my age, it's only logical to think I might not." The eight-time Ballon d'Or winner acknowledged that his decision will ultimately depend on how he feels physically over the next year. "Day by day, I try to feel good and, above all, be honest with myself. When I feel good, I enjoy it. But when I don't, honestly, I don't enjoy it - and if that's the case, I'd rather not be there. So we'll see. I haven't made a decision yet about the World Cup. Match by match, I'll finish the season, then have pre-season, and in six months, I'll see how I feel. Hopefully I can finish this MLS season strong, have a good pre-season in 2026, and then make a decision."

Punjab's son, Oman's leader: Jatinder Singh eyes Asia Cup glory in the UAE

Under the bright UAE lights, Jatinder Singh will walk out carrying a burden he has never shouldered before: the hopes of an Oman side stepping into uncharted territory. For the Ludhiana-born cricketer who moved to Oman as a teenager, this Asia Cup is more than just another tournament—it is both a personal milestone and a historic leap for Omani cricket. Once a boy who dreamt of facing India and Pakistan from afar, Jatinder now stands as captain, entrusted with leading a new-look squad against two of the biggest forces in world cricket. The road to



this moment has been anything but smooth. A year ago, a bitter fallout between the Oman Cricket Board and its players tore through the camp, with 11 members of the T20 World Cup squad suspended following central contract disputes. From that turbulence emerged Jatinder, the team's most prolific run-scorer, chosen to chart a revival. He succeeds Zeeshan Maqsood, the stalwart who spent more than a decade shaping Oman's rise from obscurity. But unlike in 2016, when Oman bowed out in the qualifiers, the team this time will walk into the Asia Cup main round as debutants—drawn alongside India, Pakistan, and the UAE in Group A. Their campaign begins on 12 September in Dubai, with Pakistan as their opening test. For Jatinder, this is not just another series—it marks the beginning of a new era and a chance to prove that Oman belongs on cricket's biggest stage. Having already featured in two T20 World Cups and with more than 1,300 international runs to his name, he understands the weight of responsibility on his shoulders.

From despair to dominance: India's Asia Cup redemption against Malaysia

India overcame an early setback to beat Malaysia 4-1 in a crucial Asia Cup clash. After the disappointment of a draw against Korea, Harmanpreet Singh's men showed resilience and character to secure an important win and move a step closer to the final.

Subjecting yourself to the torture of public scrutiny is what players and teams constantly do. Some crumble and fall apart. Others climb out, one hold at a time, from the pit of despair. Against Malaysia, with their backs to the wall after a 2-2 draw against South Korea and desperately needing a commanding win, India delivered what could only be called a masterclass. Commanded by the midfield, they not only secured a 4-1 victory but set themselves up brilliantly for a spot in the Asia Cup final. It's

always a question that begs for an answer—why reach a stage where you have to dig deep, find answers, and smoothen out a machine that, over the last six months, has been misfiring? Players who are supposed to amble in, get the angles, twist, turn, send in the aerials, and figure out space where none exists have largely played like amateurs; like a college guy on a nervy first date, fumbling, spilling the drink. Malaysia, who have played some scintillating hockey against India over the years, most of it at their home base in Ipoh, would have thought they had the answers at Rajgir too. In the second minute, they silenced the Indian fans with a move from the left flank that was not only quick but electrifying. India had barely settled down when they lost the ball. Najib pushed it to Shafiq Hassan, who made a lovely run, cutting into the circle, pushing past Sanjay, and bending slightly to powerfully send a reverse shot fizzing past Krishan Bahadur Pathak. At 1-0, India not only had to rebuild but needed to calm their nerves, which were surely strumming like guitars. Against a back wall of Amit Rohidas,

Jugraj Singh, and Sanjay, Harmanpreet came up, positioning himself between the half and back line. Malaysia's middle-of-the-pitch movements were immediately cut off. At the same time, the Indian captain could initiate moves, pushing players up front. It took



some time, but India settled. In the last six minutes of the first quarter, a crucial passage of play looking at the three quarters ahead, India's pressure had Malaysia playing with eight in their own striking circle. Manpreet's hard shot, though saved, rattled Malaysian

goalkeeper Hafizuddin. Sukhjeet in a one-on-one situation swiped at air instead of the ball. Even though Malaysia led 1-0 in the first quarter, India came off controlling the game in earlier games, one could feel a sense of rigidity in India's play. Today, there was adaptability. The dynamic in the team was more collaborative. Five penalty corners came in a rush for India in the second quarter, born out of an urgent need to press the button and get results. Off the fifth, Harman's flick rebounded off the Malaysian goalkeeper's pads. Manpreet, aggressive in the circle, moved forward and swatted it into goal. At 1-1, there was a relaxed air around the team. Build-ups that were difficult in the earlier games were now coming off. A harried Malaysia was constantly scrambling back. Could this young star be Argentina's next Messi Former boss weighs in

Former Argentina team manager Jos Pkerman believes the national team may already have a successor to Lionel Messi. While he insists no one can truly match Messi's brilliance, he feels Franco Mastantuono is the closest Argentina will ever come. With Messi having announced that his time with the national team is nearing its end, Argentina will inevitably look for a new talisman—someone capable of delivering victories as consistently as the Barcelona legend once did. Speaking to DSPorts Radio, Pkerman highlighted Mastantuono's potential to be counted among the world's football greats. The teenager, often dubbed a "wonder kid," is admired for his creativity, dribbling flair, and close control. "I don't know if someone will come who can replace Messi or who is at a level close to his. There are players that you realise are different, and I think Mastantuono is on his way to being a great footballer and to make history. The team has to be organised, it has to play, but the

Explained: Watching IPL live just got costlier thanks to new GST rules

New Delhi. (Agency)

Cricket fans in India will now have to dig deeper into their pockets to watch IPL matches live, as the government has raised the GST on premium sporting events from 28% to 40%. The sharp increase places IPL tickets in the highest tax bracket, alongside casinos, race clubs, and luxury goods. According to official guidelines, the GST hike applies to "admission to casinos, race clubs, any place having casinos or race clubs, or sporting events like the IPL." The new rates are part of a broader GST reform targeting high-value discretionary spending and are set to take effect from 22 September 2025. Under the previous structure, a ticket priced at Rs 1,000 attracted 28% GST, taking the total cost to Rs 1,280. With the revised 40% rate, the same ticket will now cost Rs 1,400—a Rs 120 jump for every Rs 1,000 spent, representing a 12% increase in effective cost. Here is a breakdown of how the GST hike impacts different ticket prices: Rs 500 ticket: Rs 700 (up from Rs 640) Rs 1,000 ticket: Rs 1,400 (up from Rs 1,280)



Rs 2,000 ticket: Rs 2,800 (up from Rs 2,560) The uniform 40% tax applies to all IPL tickets and other high-value sporting events, treating them as non-essential or luxury entertainment. While the GST Council framed the hike as part of revenue alignment, it effectively distinguishes grassroots-level sporting events from high-profile commercial tournaments. SBI Research sees limited revenue loss from GST reforms, banking sector to gain

State Bank of India's research wing has estimated that the recent GST reforms, including rate reductions, will lead to a revenue loss of only about Rs 3,700 crore — far lower than the government's projected loss of Rs 48,000 crore.

The reforms, approved by the GST Council on Wednesday, introduce a two-tier tax structure aimed at simplifying compliance and reducing the burden on consumers and businesses. According to SBI Research, the move is likely to be growth-accretive, boosting consumption while keeping fiscal risks in check. The study also notes that the new structure will benefit the banking and financial sector by improving cost efficiencies. Lower indirect tax costs on inputs and services are expected to translate into operational savings for lenders, strengthening margins and competitiveness. Analysts believe the sharply lower revenue loss projection suggests that the government will have more fiscal space than initially anticipated, while the broader economy could see gains from higher demand and improved credit flow.

SoftBank pares stake in Ola Electric to 15.68%

New Delhi.(Agency)

Japanese investment major SoftBank on Thursday sold 2.15% of its stake in Ola Electric Mobility through open market transactions, reducing its holding to 15.68%. According to BSE filings, SoftBank Investment Advisers' entity, SVF II Ostrich (DE) LLC, disposed of 94.94 million shares between July 15 and September 2. It now holds 691.2 million equity shares, representing a 15.68% stake in the company. The sale crossed the 2% threshold specified under SEBI's Takeover Regulations.

Before the transaction, SoftBank held 786.5 million shares, or 17.83%, making it the second-largest investor after Ola founder Bhavish Aggarwal. Ola Electric went public in December 2024.

Following the sale, Ola's shares fell 7.63% to an intraday low of ₹63.70 on Thursday before recovering to close at ₹64.49. Despite the decline, the stock has gained 57.87% over the past month.

Founded in 2017, Ola Electric recently secured certification for compliance with eligibility assessment requirements under the Production Linked Incentive (PLI) scheme for its Gen 3 scooter



portfolio. The company also unveiled its first locally made 4680 Bharat cell and a rare earth metal-free motor at an event in Tamil Nadu. Ola was embroiled in controversy in October 2024 after users posted images on social media highlighting defects in its two-wheelers and alleging unattended complaints for several months.olved a financial dispute with Rosmerta Group, leading to the withdrawal of insolvency proceedings against Ola Electric Technologies Pvt Ltd. Rosmerta confirmed receiving ₹26.75 crore under the settlement.

Exports to Europe: In August India shipped 137% more diesel than it did last year

Kolkata.(Agency)

August was a bumper month for India's diesel exports to Europe. Reports stated that diesel exports to Europe from India jumped 137% (y-o-y) to touch 242,000 barrels per day (bpd) in August. The performance in August also marked a surge of 73% compared to July and a leap of 124% compared to the average shipments of the preceding 12 months, according to reports which quoted data by Kpler, a global real-time data and analytics provider.

According to another energy cargo tracker Vortexa, India's diesel exports to Europe in August stood at 228,316 bpd, which is 36% higher than that achieved a month ago (in July) and 166% higher (y-o-y) ie, when compared to August last year. High demand, advanced maintenance operations What led to the big rise in diesel exports? Analysts indicated that the jump was due to a combination of different factors — high demand and apprehensions of sanctions by EU that can close the doors on shipments from India, an expected winter demand and an European refinery's sudden decision to advance maintenance. In fact, the demand for Indian diesel from Europe is expected to remain robust in the remaining months of 2025. A lot of shipments landed in Rotterdam since one of Shell's refinery there brought forward its planned turnaround from 2026 this year. An analyst also told the media that the maintenance was advanced from 2026 since sanctions on imports from India could raise demands of local oil in 2026 and the refineries were preparing for that eventuality. "European buyers may accelerate liftings from India given that Middle Eastern refineries will be having a high maintenance in October-November, echoing the stockpiling seen ahead of the February 2023 EU ban on Russian products," Sumit Ritolia, lead research analyst, refining and modelling at Kpler, was quoted in the media as saying.

Life and health insurance premiums exempt from GST: How much will you save

With full GST exemption, life and health insurance premiums could become lower, potentially saving policyholders several thousand rupees. The change is expected to cover all individual policies, including term plans, ULIPs, endowments, and senior citizen health plans.

New Delhi.(Agency)

The Goods and Services Tax (GST) is getting its biggest update since 2017, and one of the most notable changes affects individual life and health insurance. From September 22, 2025, premiums for these policies are expected to be fully exempt from GST. This could make insurance more affordable for millions of households and encourage wider adoption of financial protection.

WHAT THIS MEANS FOR POLICYHOLDERS

Until now, individual health and life insurance premiums were taxed at 18%. With the GST exemption, premiums are expected to drop. For instance, a health insurance policy with a Rs 15,000 annual premium, previously costing about Rs 17,700 including GST, could now cost closer to Rs 15,000. Similarly, a Rs 25,000 term life policy might come down to around Rs 25,000, instead of Rs 29,500. Therefore, with GST exemption, premiums could become lower, potentially saving policyholders several thousand rupees. The change is expected to cover all individual policies, including term plans, ULIPs, endowments, and senior citizen health plans.

While the savings are likely to be immediate for premiums paid after September 22, 2025, actual benefits may vary depending on insurers' pricing and policy terms. Families may find it easier to buy new coverage or renew existing policies, but the exact impact will become clearer once the new rules take effect.

Rakesh Goyal, Director at Probus, says the move is more than just a numbers game.

"The GST relief on individual health and life insurance premiums is a decisive step toward making insurance more



accessible. Affordability has long been a barrier to insurance penetration. Lower premiums will encourage more households to buy coverage and improve renewal rates." Amit Ganorkar, MD & CEO of TATA AIG General Insurance, adds, "This relief will make protection more affordable for millions. Wider adoption of health insurance is critical in India, where out-of-pocket healthcare costs are high." Dr. Sabine Kapasi, CEO at Enira Consulting and UN advisor, notes that while government schemes like

Ayushman Bharat have helped financially disadvantaged groups, the "missing middle" often cannot afford private insurance. Removing GST from premiums directly benefits this segment, encouraging timely treatment and easing pressure on hospitals.

WHAT ABOUT INSURERS?

Insurers will no longer be able to claim Input Tax Credit on their business expenses, which may increase operational costs slightly, by 2.5% to 7%. Regulators, however, have mandated that insurers pass the GST savings fully to policyholders for at least a year, ensuring that families see immediate relief.

Even if small premium adjustments happen later, they are expected to remain significantly lower than the previous 18% tax burden. Simply put, policyholders are likely to benefit most if they renew or buy insurance after September 22. While the exact savings may vary by policy and insurer, this reform is designed to make life and health insurance more accessible, helping millions of households plan for protection and financial security.

BoB classifies Anil Ambani, Rcom as fraud

The classification follows a Show Cause Notice (SCN) issued by Bank of Baroda, citing findings from a forensic audit report prepared by BDO India

Public sector lender Bank of Baroda has classified the loan accounts of Reliance Communications Limited (RCOM) and its erstwhile promoter and director Anil Ambani, as 'Fraud'. The company, which is currently undergoing a Corporate Insolvency Resolution Process (CIRP), made the disclosure in a letter to the BSE and National Stock Exchange on Friday.

The classification follows a Show Cause Notice (SCN) issued by Bank of Baroda, citing findings from a forensic audit report prepared by BDO India LLP. According to the report, the audit identified a "diversion and misappropriation of funds, along with



manipulation of the books of account".

The documents show a protracted timeline of communication between the bank and RCOM's representatives. Ambani's representatives had requested a copy of the Forensic Audit Report (FAR) and later sought several extensions to respond to the SCN. On January 14, 2025, Ambani submitted a detailed reply that included an independent expert opinion and requested a personal hearing. While the bank provided a personal hearing, it found the arguments in the reply to be "not sustainable" against specific allegations such as "mis-utilization of funds, improper loan utilization, unauthorized transfers," and "fund recycling". RCOM's disclosure notes that the company is protected from legal proceedings under the Insolvency and Bankruptcy Code, 2016, during its CIRP. It also states that if the resolution

plan is approved by the National Company Law Tribunal (NCLT), the company will have immunity against any liability for offenses committed prior to the CIRP commencement. The company's affairs, business, and assets are currently managed by a Resolution Professional named Anish Niranjana Nanavaty. The total outstanding credit facilities for RCOM from Bank of Baroda amounted to Rs 1,656.07 crore as of August 28, 2025. Reacting to the development, a spokesperson on behalf of Anil Ambani said that Ambani served only as a Non-Executive Director on the Board of RCOM from inception in 2006 until his resignation from the Board in 2019, over six years ago (for almost 14 years). "He was never an Executive Director or a KMP of the company, and had no role whatsoever in the day-to-day operations or decision-making of the company," said that spokesperson, adding that after an inordinate lapse of more than 10 years, select lenders have now chosen to initiate proceedings in a staggered and selective manner targeting Ambani. Anil Ambani has categorically denied all allegations and charges and shall pursue remedies available to him in accordance with legal advice.

Probe widens as ED raids Arvind Remedies in ₹637 crore loan fraud case

The investigation in the Rs 637 crore loan fraud case involving Chennai-based Arvind Remedies is expected to continue as authorities analyse the seized documents and digital evidence. The Enforcement Directorate (ED) has in the last two days carried out searches in Tamil Nadu, West Bengal, and Goa as part of its probe into a bank fraud linked to the company and its promoter Arvind B. Shah. The case dates back to 2016, when the CBI registered an FIR following a complaint from Punjab National Bank. The company is accused of defrauding a consortium of lenders by diverting loan funds and falsifying accounts.

The ED raids are aimed at unravelling the underlying financial trail and identifying those responsible for manipulating company accounts, misappropriating funds, and laundering money through a complex web of interconnected entities.

According to investigators, quoted in reports, the promoters routed money through shell companies and multiple bank accounts. The ED examined financial statements between 2009 and 2015 and transaction details from nearly 300 accounts. The raids are aimed at tracing the flow of funds and collecting evidence of money laundering. Officials said further action will follow once documents and digital

records seized during the searches are analyzed. The ED's current probe has involved a deep dive into the company's annual reports from fiscal years 2009-10 through 2014-15, audited financial statements obtained from the Ministry of Corporate Affairs, and extensive transaction data spanning 294 bank accounts. Analysis suggests that funds were siphoned off through shell or dummy entities controlled by the promoters—raising serious concerns of financial misconduct and money laundering. The Chennai-based Arvind Remedies Ltd, was engaged in the manufacture of generic medicines and ayurvedic products.

GST 2.0: Essentials cheaper, but these items will now cost more

Following the latest GST announcement, farmers are expected to get relief as their cultivation costs will reduce. Farmers have long demanded lower taxes for the agriculture sector.

New Delhi.(Agency)

The Goods and Services Tax (GST) is set to undergo its biggest overhaul since 2017. From September 22, 2025, the system will shift to a simpler "2+1" structure: 5% for essentials, 18% for most goods and services, and a steep 40% for sin and luxury items. While most everyday items are set to become cheaper, a handful of products that people indulge in regularly will see their prices jump. Commercial cargo vehicles such as trucks and delivery vans have moved from 28% to 18% GST,



while their insurance rates have been reduced from 12% to 5%. This is expected to improve the transportation of agricultural products, making it faster and more cost-effective.

WHAT GET'S MORE EXPENSIVE?

The 40% top rate hits products the government wants to discourage or that are considered luxuries. Colas and other

fizzy drinks will rise from 28% to 40%, making movie-night sodas and family treats costlier. Sugary juices and energy drinks will also carry the higher rate, affecting lunchboxes and urban fitness routines. Pan masala and chewing tobacco move to the same slab, a clear nudge toward healthier habits. Luxury motorcycles and high-end cars now face

the 40% rate too, adding a sharp bite for aspirational buyers. However, the good news is essentials are becoming cheaper. Soaps, hair oil, packaged snacks, small cars, and even some household appliances now fall into lower slabs, sometimes by more than half. The government aims to make daily life easier, trim inflation, and revive consumption. Economists estimate that the reform could shave around 1.1 percentage points off inflation. The Centre expects a short-term revenue loss of roughly Rs 48,000 crore but hopes that lower rates on essentials and simpler compliance will encourage spending and offset the gap over time. For families, the impact is easy to see at the counter. Grocery baskets, personal care products, and household items may cost less, but colas, energy drinks, pan masala, and cigarettes will definitely be pricier.

Luxury motorcycles and cars will hit the pocket harder too. For families, the equation is simple. Essentials will cost less, while indulgences like colas, energy drinks, pan masala, cigarettes, and luxury vehicles will become more expensive.

Although it is true that there are no such things as "bad" exercises, certain faulty techniques can make an exercise useless and compromising.

While some of these exercises aren't optimal for fitness, some others should be avoided as they can easily lead to injury. However, it is important to understand that they are not always unsafe or unproductive. Adopting or avoiding any exercise technique depends on an individual's personal fitness goals and objectives. Read on to know more about these common red flags...

Spot reduction exercises: An ineffective method of 'burning fat' followed by many people is spot reduction. The popularity of this belief can be largely attributed to the many exercise gimmicks that we often see in infomercials regarding localized weight reduction. But always keep in mind that weight loss can never be isolated to a particular area. Localized strengthening and toning exercises will only help to firm muscles but will have no effect on the fat content of the target area. A better alternative is to adopt a well-rounded full-body weight reduction program.

Leg extensions (Seated): A very popular exercise for working the anterior thigh muscles, seated leg extensions are actually one of the most dangerous exercises in the gym. This is because the exercise places an unhealthy amount of stress on the knee joint. According to a research published in the Journal of Orthopaedic and Sports Physical Therapy", individuals who worked on the leg extension machines found no benefit during functional tests. This can be particularly dangerous for those who have any kind of knee problems. Safer alternatives are simple lunges and squats without any added weights.

Leg press: Another form of exercise that should be avoided is the leg press as this can place undue amount

apply more than 3400 newtons of force on his back at a time. Crossing this limit would place unnecessary stress on the back muscles leading to stress or injury. On an average, a regular sit-up program contributes around 3413 newtons of force on the back muscles. To avoid this, opt for short range crunch movements or tabletops.

of stress on the lower back. This can thus predispose a person to low back injuries. Although, many claim that seated leg press exercises can train your hams, quadriceps and gluts, in reality, it does not engage these muscles at all. All it does is force the spine into a flexed position. Hence, instead of this, try working on body weight squats.

Seated abduction or adduction: Just like leg press, seated abduction/adduction movements can place great amounts of stress on your spine. Also, such movements only train these muscles as prime movers. But, in reality, during actual physical activity, they are used only as stabilizers and not as prime movers. An easy and effective alternative is lunges which can be used to train these muscles for their actual purpose of stabilizing.

Leg curls: According to strength and conditioning coach, Charlie Weingroff, exercises like deadlifts are more effective than leg curls. This is because the latter trains the hams only as knee flexors while, during activity, they are used mainly as hip extensors.

Sit ups: As per the recommendations by the National Institute for Occupational Safety and Health (NIOSH), a person should never

(behind the head): This is a big "no-no" without proper form, as this may affect your shoulder joint functioning. Only those with extreme shoulder joint flexibility can opt for this exercise and that too, with extreme care for correct form. A better alternative for working your lats is by pulling the bar towards your chest and not behind the head. But, remember to keep your spine straight and abs pulled in while performing this.



How papaya, fenugreek leaves can control Dengue

Giloy is helpful in building the immune system and papaya leaves cure dengue fever, an expert says.



Pankaj Aggarwal, from the capital-based Agrawal Homoeo Clinic, has suggested some easy home remedies to control platelet loss and recovery from dengue fever

Giloy (herb): This is helpful in building the immune system, giloy stem marks immediate recovery when consumed in frequently during the fever. Boil two or three giloy stems for ten minutes and serve the patient for better immunity.

Papaya leaves: The budding leaves of papaya tree cure dengue fever and helps in removing excess toxins from the body. The intake of its juice from crushed leaves can help in rising the platelet count.



Fenugreek leaves:

Fenugreek leaves help in reducing the pain of the patient and help in restful sleep. It reduces the level of fever stabilizing the blood pressure and heartbeat of the patient.

Goldenseal: The herb proves to be an excellent remedy for its ability to clear up the symptoms of the dengue fever. The leaf when consumed in form of juice helps in eliminating the dengue virus from the body strengthening the immunity of the body against its signs.

Feeling blue? You have impaired your ability to identify colours

Taking the association between our mood and colours beyond a mere metaphor, new research has found that feeling sad can impair our ability to accurately identify colours on the blue-yellow axis.



"Our results show that mood and emotion can affect how we see the world around us," said study first author Christopher Thorstenson from University of Rochester in New York, US.

"Our work advances the study of perception by showing that sadness specifically impairs basic visual processes that are involved in perceiving colour," Thorstenson noted.

In the study, the researchers had 127 undergraduate participants watch an emotional film clip intended to induce sadness or a standup comedy clip intended to induce amusement.

The participants were randomly assigned to watch an animated film clip intended to induce sadness or a standup comedy clip intended to induce amusement.

After watching the video clip, the participants were then shown 48 consecutive, desaturated colour patches and were asked to indicate whether each patch was red, yellow,

green, or blue. The results showed that participants who watched the sadness video clip were less accurate in identifying colours than participants who watched the amusing clip, but only

for colour patches that were on the blue-yellow axis. They showed no difference in accuracy for colours on the red-green axis. The results cannot be explained by differences in participants' level of effort, attention, or engagement with the task, as colour perception was only impaired on the blue-yellow axis. "We did not predict this specific finding, although it might give us a clue to the reason for the effect in neurotransmitter functioning," Thorstenson said. The researchers noted that previous work has specifically linked colour perception on the blue-yellow axis with the neurotransmitter dopamine. The new research was published in the journal Psychological Science.



Here's how you should make turmeric

Milk

Much has been said about the benefits of drinking turmeric milk - or 'Golden Milk' as it is fondly called by the Orientals.

It has been advocated by several schools of native medicine, including Ayurveda. A simple Web search on 'turmeric milk' will tell you about benefits ranging from decongestion to weight loss, so I am not going to delve into that much in this post.

Instead, I want to share with you an authentic method of preparing it, which I zeroed in on after trying several recipes advised by Ayurvedic doctors, and found in many books.

1. Take an inch-long stick of turmeric. Remember that turmeric powder is never as effective as crushed turmeric sticks, because the chances of contamination in the powder are high, plus its efficacy is also bound to reduce during the heat-generating grinding process. So, take a stick of turmeric (the variety used in cooking; varali manjal in Tamil) and crush it coarsely using a mortar and pestle.

2. Crush a few peppercorns too. The white variety is better.

3. Mix a cup of water with a cup of milk, add the crushed turmeric and pepper and bring to a boil.

4. Simmer for 20 minutes. By this time, the milk will reduce to a cup. This is the reason why I suggest you begin with a mixture of milk and water; else you will end up with a very thick, kheer-like drink that won't be as soothing.

5. Remove from the stove, filter, add a spoonful of honey or palm sugar, and enjoy the drink warm.

6. If you are taking this to relieve a sore throat, add 1/2 teaspoon of ghee to the hot turmeric milk before drinking it. The ghee will melt and coat your throat, relieving you of cough as well.

Note: The most important part is to sit and relax with this cuppa for a few minutes, relishing its soothing flavour and rustic aroma! This will enhance the feel-good factor.
