Uttarakhand University Giving Extra Marks For Attending PM Modi's Event? A Fact-Check

➤ **The viral notice, which appears to be issued by the Dev Bhoomi Uttarakhand University, asks all B.Tech CSE and specialisation (2nd year) and BCA (2nd year) students to attend the event.**

New Delhi .(Agency)

A notice allegedly issued by a university in Uttarakhand asking students to mandatorily attend Prime Minister Narendra Modi's Sunday event marking the silver jubilee celebrations of the formation of the state for "50 internal marks" has gone viral, with the Centre and the university fact-checking it. The viral notice, which appears to be issued by the Dev

Bhoomi Uttarakhand University, asks all B.Tech CSE and specialisation (2nd year) and BCA (2nd year) students to attend the event. "Students are hereby informed that they must attend the upcoming event at FRI on Sunday, 9th November 2025, where an interaction with the Prime Minister of India will take place. Attendance in this event will be considered under the Bharatiya Gyan Parampara (Indian Knowledge System) course, and 50 internal marks will be awarded to each participant. Hence, participation in this event is mandatory for all programs having the Indian Knowledge System course," the notice read.

While it mentions that the order was issued by the BCA Head of Department and the B.Tech CSE 2nd Year program coordinator, it does not have any signatures on it.

The notice quickly went viral, with the Opposition leaders hitting out at the BJP. Uttarakhand Congress spokesperson Garima Mehra Dasauni alleged that the BJP has "run out of workers and leaders".



Lawyer-activist Prashant Bhushan said, "Dev Bhumi Uttarakhand University to award 50 marks for attending Modi's rally! And how many for shouting Modi Modi?" The Press Information Bureau (PIB) Fact Check division - the Indian government's

official fact-checking agency fact-checked the viral notice, calling it "fake". "A letter allegedly issued by Devbhoomi Uttarakhand University is being circulated on social media, claiming that students' attendance at Prime Minister @narendramodi's programme has been made mandatory and that internal examination marks will be given for it. This letter is #Fake. No such order has been issued by the university," it said. The university, too, issued a clarification, saying the notice is "false" and "not issued or approved by them". "It has come to our attention that a fake notice has been circulated in the name of DBUU regarding marks for the upcoming visit to FRI on 09 November 2025. We would like to clarify that the notice is completely false and not issued or approved by the University. It does not bear any official signature, reference number."

Voter List Revision A Bid To Institutionalise 'Vote Theft': Rahul Gandhi

Leader of Opposition in the Lok Sabha Rahul Gandhi on Sunday alleged that the Special Intensive Revision (SIR) of electoral rolls is an attempt to cover up "vote theft" and institutionalise it. Speaking to reporters, Gandhi also said he believes that, like Haryana, "vote theft" took place in Madhya Pradesh, Maharashtra, and Chhattisgarh, too.

"Vote theft is an issue and SIR now, it is about covering it up and institutionalising the system," the Congress MP claimed. Gandhi arrived in Pachmarhi hill town in Narmadapuram on Saturday to take part in the Madhya Pradesh district Congress presidents' training camp.

The Election Commission's Special Intensive Revision (SIR) of the voters' list commenced in nine states and three Union Territories on November 4. The massive exercise will cover nearly 51 crore electors across 321 districts and 1,843 assembly constituencies of these nine states and three Uts.

"A few days ago, I gave a presentation on Haryana, and I clearly saw that vote theft was taking place... 25 lakh votes were stolen, 1 in 8 votes were stolen," Gandhi alleged. "After looking at that, after looking at the data, I believe that the same thing happened in MP, Maharashtra, and Chhattisgarh. And this is the system of the BJP and EC (Election Commission)," he charged. "We have more evidence, which we will provide gradually. But my issue is vote theft. The SIR now, it is about covering it up and institutionalising the system," he claimed.

Unfair to judge by one episode: Shashi Tharoor defends Advani with Nehru parallel

Congress MP Shashi Tharoor is once again drawing attention for his remarks on a BJP leader. This time for defending former Deputy Prime Minister Lal Krishna Advani's political legacy, asserting that just like Jawaharlal Nehru and Indira Gandhi, the BJP veteran's decades of public service should not be assessed based on a single incident. "Reducing his long years of service to one episode, however significant, is unfair. Just as Nehruji's career cannot be defined solely by the China setback, nor Indira Gandhi's only by the Emergency, the same fairness should be shown to Advaniji," Tharoor wrote on X. The Congress MP's remarks came soon after he wished Advani, one of the BJP's founding members, on his 98th birthday, where Tharoor praised Advani's "unwavering commitment to public service". "Wishing the venerable Shri L.K. Advani a very happy 98th birthday! His

unwavering commitment to public service, his modesty & decency, and his role in shaping the trajectory of modern India are indelible. A true statesman whose life of service has been exemplary," Tharoor wrote.

Tharoor's praise for LK Advani's long public



career drew sharp pushback online, with critics accusing the Congress MP of "whitewashing the BJP veteran's role in divisive politics". Supreme Court advocate Sanjay Hegde hit back, writing,

"Unleashing the 'dragon seeds of hatred' in this country is NOT public service".

A brief exchange followed between Tharoor and the senior advocate, with the Congress leader defending the legacy of Advani by comparing it with that of former PMs Jawaharlal Nehru and Indira Gandhi. "The Rath Yatra was not an episode. It was a long march to reverse the foundational principles of the Indian Republic.

It set the stage for 2002 and 2014 and thereafter. Like Draupadi's dishonour set the stage for the Mahabharata that followed, the Rathayatra and its legacy of violence continue to haunt the destiny of this country. From his current bed of arrows, he has not preached any Rajdharma either," Hedge replied. Advani's Rath Yatra, which began in Somnath and was stopped in Bihar by then Chief Minister Lalu Prasad Yadav, is widely seen as a prelude to the Babri Masjid demolition in December 1992.

Drone Near Uddhav Thackeray's Home Sparks Row, Cops Say 'Infra Body Survey'

Uddhav Thackeray was not in the house when the incident took place. He was touring Marathwada.

A drone was spotted hovering near 'Matoshree', the residence of Shiv Sena (UBT) chief Uddhav Thackeray in Mumbai, with the Thackeray faction alleging possible surveillance in a high-security, no-drone zone. Uddhav Thackeray was not in the house when the incident took place. He was touring Marathwada. According to Aaditya Thackeray, Sena (UBT) leader and Uddhav Thackeray's son, the drone appeared to be "peeping into the residence" and flew away quickly when noticed.

Shiv Sena (UBT) leaders Ambadas Danve and Anil Parab raised concerns over the drone's presence, demanding a probe into what they called a "serious security breach". Parab also suggested the need to rule out any extremist angle, calling the incident "highly sensitive" given Matoshree's Z+ security.

Mumbai Police issued a clarification soon after, stating that the drone was part of an authorised Mumbai Metropolitan Region Development Authority (MMRDA) survey in the BKC-Kherwadi belt for the ongoing pod-

taxi project. Permission had been granted between November 8 and 16, police said, urging the public to avoid misinformation. Aaditya Thackeray, however, questioned why the residents were



not informed if it was an authorised survey and questioned whether an MMRDA survey would single out 'Matoshree'. He further criticised the Mumbai infra body for "focusing on surveillance instead of improving ground-level work", citing the Mumbai Trans Harbour Link as an example of "corruption and poorly executed projects".

Tejashwi Yadav Celebrates 36th Birthday During Rally In Bihar's Karakat

Tejashwi addressed a public meeting at the Inter College ground in Sanjhauli and cut a cake on the stage as supporters held placards wishing him 'Happy Birthday'

Grand Alliance chief ministerial candidate and Leader of Opposition in the Bihar Assembly, Tejashwi Yadav, celebrated his 36th birthday on stage during an election rally in Karakat on Sunday. Tejashwi, who addressed a public meeting at the Inter College ground in Sanjhauli, cut a cake on the stage as supporters held placards wishing him 'Happy Birthday'.

He appealed to the electorate to vote for the CPI(ML) candidate from Karakat, Arun Kumar. Addressing the gathering, Tejashwi targeted the NDA and called the present government "dishonest". The RJD leader reiterated that if the Mahagathbandhan forms the government, schemes including the 'Mai Behan Maan Yojana' would be implemented, under which Rs 30,000 would be deposited into the accounts of all women in Bihar on January 14.

He also promised LPG cylinders at Rs 500 and enhancement of the old age and widow pension to Rs 1,500 per month. The RJD leader reiterated key promises: A government job in every household if the alliance forms the government, free electricity for irrigation, and exemption for the Pasi community from the prohibition law. Tejashwi also said his aim was to transform Bihar so that people would not have to migrate for employment. Sunday is the last day of campaigning for the second phase of the Bihar Assembly elections.

Polling will be held on November 11 for 122 seats. Political parties are holding back-to-back public meetings to make a final pitch to voters. Tejashwi is scheduled to hold around a dozen rallies on the last day of the campaign, including five in different Assembly segments of Rohtas district. RJD is contesting on 143 seats in the Bihar Assembly election 2025. Among them, 70 candidates are in the fray in the second phase. The voting will be held in Champaran, Kosi, Seemanchal, Bhagalpur, Magadh and Shahabad divisions.



Mohan Bhagwat Was Asked If Muslims Are Allowed In RSS. His Response

New Delhi .(Agency)

The Rashtriya Swayamsevak Sangh (RSS) supports policies, not an individual or a political party, its chief Mohan Bhagwat has said, adding that RSS workers would have even backed the Congress if it supported the demand for a Ram Temple in Ayodhya. "We do not support any political party. We do not participate in election politics. Sangh works to unite society, and politics is divisive. We support policies. For example, we wanted Ram Mandir in Ayodhya, so our swayamsevaks who stood by its construction," he said, adding that the BJP ticked the box. "If Congress had

supported it, our swayamsevaks would have voted for that party," Bhagwat said.

"We don't have a special affinity for one party. There is no Sangh party; no party is ours. And all parties are ours because they are Bharatiya parties. We support rashtraneeti (policies), not rajniti (politics). We have our views, and we want this country to go in a particular direction. Those who drive the country in that direction, we will support them," he said at an event in Bengaluru to mark the centenary of RSS.

Asked if Muslims are allowed to become part of RSS, Bhagwat replied,



"No Brahmin is allowed in Sangh, no one from any caste is allowed, no Muslim is allowed, no Christian is allowed... People from different denominations, Muslims or Christians, can come to Sangh,

keeping their separateness out. When you come to Shakha, you come as a son of Bharat Mata. Muslims and Christians come to shakha, but we don't take their count, we don't ask who they are."

Bhagwat also responded to a question raised by several Congress leaders: why is the RSS not a registered organisation? "This answer has been given umpteen times, but those who want to raise questions go on repeating them. Sangh started in 1925. Do you expect us to register with the British government? After Independence, the laws do not make registration compulsory.

Even Hindu dharma isn't registered: RSS chief responds to Priyank Kharge's jibe

Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat on Saturday hit back at Karnataka minister and Congress leader Priyank Kharge, who had recently questioned why the Sangh remains an "unregistered organisation" despite claiming to serve the nation. Responding to Kharge's remarks, Bhagwat said the Sangh had started in 1925, long before India gained Independence, and questioned whether critics expected it to register with the British government.

"The Sangh started in 1925. Do you want us to register with the British government? After Independence, registration is not compulsory. The law recognises even unregistered bodies of individuals. We pay



income tax.

We were banned thrice, and every time courts lifted the ban. Governments and courts have recognised us as a legal organisation. Therefore, we need not be registered. Many things are not registered -- even Hindu dharma is not registered," Bhagwat said.

Earlier this month, Congress leader Priyank Kharge had accused the RSS of operating "without transparency" and avoiding legal scrutiny. In a post on X, he said, "If RSS truly serves the nation selflessly, why not register like lakhs of NGOs that work transparently and lawfully?" The Congress leader also questioned the RSS's sources of funding and the security accorded to Mohan Bhagwat by the central government. "Why does the head of an unregistered organisation receive Advanced Security Liaison protocol, putting him on par with the Prime Minister and Home Minister? Who pays the full-time pracharaks and funds the organisation's campaigns?" he asked.

Gang offers to convert scrapped notes for fees, 8 arrested in Ghaziabad

Ghaziabad.(Agency)

Nine years after demonetisation, crores of invalidated Rs 500 and Rs 1,000 notes remain stashed with people, sustaining a grey market large enough for organised fraud. This was evident from the arrest of eight members of a gang over the last two weeks. The men were allegedly behind a multi-level racket that trapped clients, mainly traders and middlemen still hoarding invalid notes, via social media sites by promising discreet conversion of demonetised currency in exchange for hefty commissions. Investigation revealed that no currency was ever exchanged, and the gang simply collected bundles of demonetised currency and their advance fees before vanishing. Police have so far recovered demonetised notes worth Rs 3.9 crore from their stash."Most victims never approached police because their own transaction was illegal," Trans-Hindon DCP Nimish Patil said. "The fraud operated through a structured, three-tier chain. The first tier, which included the recently arrested SK alias Sharik and Abhinav alias Rahul Buddhi Raja, handled negotiations with victims and offered assurances of converting the notes at 25% of face value. The second comprised collectors who sourced demonetised currency directly from clients, and the third consisted of couriers who transported the notes to designated handover points."

Itchy eyes, sore throat, choked lungs: ‘Very poor’ air takes a toll on residents in Noida

Smog continued to choke Noida on Saturday, with several neighbourhoods waking up to a burning sensation in the eyes, sore throats, and increasing breathing discomfort. As the Air Quality Index (AQI) remained in ‘very poor’ category, residents said they have stopped early-morning walks, jogging, cycling, and other outdoor activities because of the thick layer of haze that blankets the skyline.CPCB data showed Noida’s overall AQI rose to 354, up from 306 a day earlier. “It’s impossible to step out for walks anymore. Even five minutes outdoors leaves the eyes and throat burning,” said Pramila Dhar of Sector 78. "Parks across high-rise clusters that are usually crowded on weekend mornings remained near-empty today." Ghaziabad fared no better, with air quality sliding further to 339 from Friday’s 314, while Greater Noida slipped from ‘poor’ to ‘very poor’, reaching 336 compared to 284. Station-level readings presented a grim picture for Noida. Sector 116 - which covers the 7x sectors - recorded the highest AQI at 357, followed by Sector 125 at 347, Sector 62 at 345, and Sector 1 at 341, all in the very poor range.Nisha Rai, a resident of Prateek Wisteria in Noida’s Sector 77, said people in the area have been facing respiratory problems. "People in the area are suffering from sore throats and breathing difficulties. We don’t see water sprinkling being done, and the sky remains grey. We have also stopped outdoor activities," she said.Shreya Sharma, a resident of Panchsheel Pratishtha in Sector 75, said the AOA has started sprinkling water on its own. "There is rampant construction in the neighbourhood, and trucks and dumpers carrying materials create dust. However, there is no official check on such activities. We have advised children to stay indoors during morning and evening hours when pollution levels are high," she said.

GDA razes illegal walls, houses, GMC reclaims Rs 30 crore Vasundhara land

GDA has demolished an illegal township spread over 23 hectares in Bhikhanpur and Morta, where land developers had built roads and boundary walls.A recent GDA survey shows illegal colonies have risen to 351, up from 321 in 2021. These colonies have occupied 2,944 acres of land, and this is growing, said an official. In a separate drive, GMC reclaimed 1,600 sqm of land in Vasundhara worth Rs 30 crore. "In both areas, the encroachers, in connivance with land sharks, earmarked land for residential use without any map sanctions. They came up with an office, constructed a boundary wall, and were even in the process of constructing roads," said a GDA official. "Our team flagged the illegal construction, and an anti-encroachment unit with the presence of a police force demolished the structure and barricaded the area. A case was also filed against the landowners," added the official."While we carry out such drives at regular intervals, it is just a temporary solution. GDA, as a long-term solution, proposed that registries in these colonies be banned. In Sept, we also wrote to the stamp and registry department on the issue but so far have not received any response from the department," said the official. Meanwhile, an official from the stamp and registration department said, "Clause 241 of the registration manual is very clear, which says that the stamp and registry department cannot deny the registry of properties, and the department is in no way responsible for verifying documents submitted at the time of registration. This is about rules." Meanwhile, GMC led a separate anti-encroachment drive in Vasundhara. "In Vasundhara, 1,600 square metres of land was fully encroached for many years, which belonged to GMC.



A good mobility plan is central to development & ease of living: Haryana CM

Haryana chief minister Nayab Singh Saini on Saturday said the state is prioritising mobility-led urban development, integrating transport systems to improve ease of living and support India’s vision 2047 goal of becoming a developed nation.Speaking at the 18th Urban Mobility India Conference in the city, Saini said it was a matter of pride for Haryana to host the national event for the first time.He said the Prime Minister believes India’s future does not lie solely in large metropolitan centres. Instead, tier-2 and tier-3 cities are emerging as key growth hubs, with mobility systems being shaped to support inclusive development.The state government, he noted, is prioritising sustainable mobility and transit-oriented development in urban planning. Emphasis is being laid on integrating transport networks to check unplanned urban expansion and ensure efficient use of resources.



"Our cities are engines of growth, but ensuring ease of living requires mobility to be central to development," the chief minister said, adding that mobility influences economic resilience, civic empowerment, and environmental balance. He said plans are underway to introduce

smart bus services aimed at making urban transport more efficient, reliable and transparent. Improved bus connectivity, he said, boosts business activity and employment while enhancing access to services. He further highlighted the state’s mobility roadmap that includes expanding the

GMDA plans underpass to ease snarls near Millennium City Centre metro station

GMDA is planning to construct an underpass at Millennium City Centre metro junction to alleviate congestion and improve traffic flow. The proposal, estimated at Rs 80 crore, will be presented for approval at the GMDA board meeting on Nov 10. The junction, located at the intersection of sectors 27, 29, 43, and 44, connecting major roads and sectors, is a known traffic choke point, witnessing nearly 9,200 passenger car units during rush hours. Its proximity to the Millennium City Centre metro and Rapid Metro stations, Galleria Market, and Sector 29’s restaurant hub contributes to frequent jams and delays, especially during rush hours.With a new metro station also

coming at the junction, traffic load, both vehicular and pedestrian, is bound to increase, which could add further chaos.



"The proposal has been prepared and will be placed before the Authority meeting for administrative approval. Once the authority gives its nod, we will begin preparing the detailed project report,"

said a GMDA official.

According to the GMDA’s Comprehensive Mobility Management Plan (CMMP), nearly half of the city’s road network operates below 30 kmph due to congestion. The Millennium City Centre Metro junction was identified as one of the priority locations for grade separation to ensure smoother traffic flow and reduce delays caused by signalised intersections. The proposed underpass will improve traffic flow for commuters between Iffco Chowk, Golf Course Road Extension, Faridabad, NH-8, and the Delhi–Mumbai Expressway. It will also provide better local access to surrounding sectors and connectivity to the metro and Rapid Metro networks. The project is expected to be completed within 24 months from the commencement of work.

Large construction sites in Gurgaon must register on dust portal: DC

Gurgaon.(Agency)

Gurgaon administration has mandated the registration of all construction works exceeding 500 sqm on the online dust portal of the Haryana State Pollution Control Board (HSPCB) for effective monitoring during GRAP restrictions. A complete ban on burning any type of garbage or waste materials has been imposed, with immediate action required from departments.Deputy commissioner Ajay Kumar emphasised that air pollution control was a collective effort for public health and environmental protection. "Air pollution control is not just a govt formality, but a collective effort for public health and environmental protection," he said. In the video conference meeting, detailed discussions were held regarding GRAP restrictions and their effective compliance. Following this, the DC issued

strict guidelines while reviewing the pollution situation in the district. Kumar said that 100 percent compliance with all GRAP-2 rules should be ensured.



Arrangements for green nets, dust control equipment, and water sprinkling should be made regularly for dust control at construction sites. The DC directed the transport department to intensively check diesel buses and heavy vehicles coming from outside states and

issue challans to violators. Municipal Corporation Gurgaon and Manesar have been directed to regularly carry out water sprinkling on main roads and green belt areas.Emphasis was also laid on increasing the use of anti-smog guns and water sprinklers. He said that the pollution control board should continuously monitor industrial units and strict action should be taken against units not complying with emission standards. The DC said that air pollution control is a continuous process, which requires discipline and responsibility at every level.He also said that administrative efforts will be successful only when citizens also become part of this campaign. He requested citizens to follow the guidelines issued by the administration so that the quality of the environment can be improved through the collective efforts of all.

Gurgaon’s air quality remains in ‘poor’ category for sixth day

The city’s air quality remained in the ‘poor’ category for the sixth consecutive day on Saturday, recording an overall Air Quality Index (AQI) of 236, a slight improvement from Friday’s 253. Despite the marginal decline, pollution levels continue to remain above the safe limit, raising health concerns as winter sets in.Among the four air quality monitoring stations, Sector 51 and Gwal Pahari recorded the highest pollution levels with AQI readings of 276 and 274, respectively, both in the ‘poor’ category. Vikas Sadan (195) and Teri Gram (155) reported comparatively better readings but remained in the ‘moderate’ range. According to System of Air Quality and Weather Forecasting and Research (Safar), the city’s air quality is expected to deteriorate further

into the ‘very poor’ category over the next few days, as weather conditions are not favourable for the dispersion of pollutants. Safar’s forecast indicates mainly clear skies with smog and shallow fog during morning hours. Northwesterly surface winds of up to 10kmph are expected in the morning, increasing to 20 kmph in the afternoon before slowing again in the evening. The maximum mixing depth is likely to be around 1,500 metres, and the ventilation index is projected to be about 9,000 m²/s on Sunday. Safar stated that a ventilation index below 6,000 m²/s, combined with wind speeds under 10kmph, is considered unfavourable for dispersing

pollutants. Independent air quality expert Sachin Panwar said northwesterly winds are carrying pollutants from areas



where stubble burning is taking place, contributing to the city’s poor air quality. "Thermal inversion is also restricting vertical air movement, causing pollutants to remain near the surface. Conditions may worsen over the next few days before improving slightly once westerly winds set in. For now, air quality is expected

to fluctuate between the ‘poor’ and ‘very poor’ categories," he said.Levels of fine particulate matter remained high across all monitoring stations. PM2.5 concentration at Gwal Pahari was 500 µg/m³, about 33 times higher than the World Health Organization’s (WHO) safe limit of 15 µg/m³. It was followed by Sector 51 (354 µg/m³), Vikas Sadan (313 µg/m³), and Teri Gram (304 µg/m³).Pm10 levels were also elevated, with Gwal Pahari recording 467 µg/m³, nearly 10 times the WHO limit of 45 µg/m³, followed by Sector 51 (400 µg/m³), Teri Gram (178 µg/m³), and Vikas Sadan (172 µg/m³). As per Central Pollution Control Board (CPCB) standards, the annual safe limits are 60 µg/m³

for PM2.5 and 100 µg/m³ for PM10 — well below current readings across all locations. Experts have stressed.

metro network to Gurgaon, Faridabad, Bahadurgarh and Sonipat, alongside giving priority to the Regional Rapid Transit System (RRTS) and Namo Bharat Rail System. The high-speed rail links will connect Delhi, Gurgaon, Karnal and the Jewar International Airport, forming an economic corridor within the NCR and offering a faster, energy-efficient travel option. Lastly, he said that alongside major infrastructure expansion, a push is also being made for last-mile connectivity using electric and CNG buses, e-rickshaws and cycle tracks across urban areas. Modern city bus services are currently in operation in 12 cities, including Faridabad, Panchkula, Rohtak, Karnal, Hisar, Panipat, Yamunanagar, Sonipat, Bhiwani, Rewari, Kurukshetra and Ambala. Charging stations are also being expanded under the state’s electric vehicle policy.

Woman held for colluding with lawyer couple to frame her husband in a fake Pocco case

Gurgaon.(Agency)

Following the arrest of a city-based lawyer, her husband, and a balloon seller for running an extortion racket that framed men in fake Pocco cases, police have now arrested a woman who allegedly conspired with them to implicate her husband. Geetika Chawla, the lawyer believed to be kingpin of the gang that targeted families facing marital discord, her husband Harsh Kumar, and their associate Hanuman were arrested on Friday.The accused, identified as Shivani Aggarwal (42), a resident of Etawah in Uttar Pradesh, was married to Vishal Aggarwal, owner of an IT company, in 2008. The couple has two daughters. After issues arose in his marriage, Vishal had approached Geetika for legal assistance in his divorce case. However, Geetika joined hands with Shivani, who, according to sources, paid around Rs 10 lakh to Geetika to extort money from her husband. When Vishal refused to pay, he began receiving threatening calls from unknown numbers, demanding money on behalf of his estranged wife.On Oct 29, Hanuman, posing as Rohit from Farrukhabad, filed a complaint at Sector 65 police station, accusing Vishal of sodomising his eight-year-old son. "Shivani comes from a middle-class family and is a single child. She lost her father when she was young. Vishal, also from a humble background, worked hard to build his IT company after completing his engineering. He now runs a multi-crore business and leads a lavish lifestyle. After repeated quarrels, the couple decided to get a divorce, but Shivani sought a large alimony. When Vishal refused, she conspired with Geetika, who was his lawyer, to blackmail him," said an investigating officer.Police said Geetika urged Shivani to file a rape case against her husband, accusing him of abusing their daughter.

Coaching centre deaths: 2 fire officers to face the heat

New Delhi: Delhi Lieutenant Governor VK Saxena has approved disciplinary proceedings against two senior fire officers for alleged negligence and concealment of facts in connection with the July 2024 tragedy at Rau's Coaching Centre in Old Rajender Nagar where three civil services aspirants died after being trapped in a flooded basement library. The L-G has sanctioned disciplinary proceedings under Rule 18 read with Rule 14 of the CCS (CCA) Rules, 1965, against Vedpal, Divisional Officer, and Udai Vir Singh, Assistant Divisional Officer — both Group-A officers of the Fire Department, Government of National Capital Territory of Delhi (GNCTD). The two had inspected the premises on July 1, 2024, just weeks before the tragedy, and cleared it for fire safety certification, allegedly

ignoring that the basement was being misused as a seating room and library. Based on their report,



the fire safety certificate was issued on July 9, 2024. A subsequent district magistrate inquiry found the officers guilty of concealing the misuse of the premises, leading to their suspension

last year. The L-G has now directed the Directorate of Vigilance to ensure timely completion of the

disciplinary proceedings. The incident on July 27, 2024, claimed the lives of three young aspirants — Tania Soni (25), Shreya Yadav (25), and Navin Delvin (28) — after heavy rainfall caused flood-

ing in the basement. The single biometric entry system reportedly failed during the deluge, trapping them inside. The incident had triggered widespread outrage among UPSC aspirants and local residents. Students staged protests for nearly a week demanding justice for the deceased and stricter enforcement of safety norms at coaching centres. Locals had told The Tribune then that the tragedy was "a disaster waiting to happen," citing decades of waterlogging issues in the Old Rajender Nagar area. Earlier this year, on the first anniversary of the tragedy, The Tribune revisited the site and found that while civic infrastructure in the area had improved, the once-bustling hub of coaching centres had lost its old vibrancy. Locals pointed out that new drainage systems and wider gutters had reduced flooding, but footfall had declined drastically.

22-week-old premature baby survives miraculously, discharged home safely

New Delhi: A baby girl weighing 525 gm at birth at a private hospital in the national capital has now been discharged in good health with a weight of 2,010 kg — said to be a rare survival feat, not just for the Delhi NCR region but for the entire country. Dr Jay Kishore, Senior Neonatologist at Cloudnine Hospital, Patparganj, led his team to script medical history — successfully discharged the baby born at a gestational age of just 22 weeks and 5 days, after a remarkable 105-day NICU journey. Dr Kishore said, "This survival is a testament to medical precision, team dedication, and the parents' unshakeable faith. Extreme prematurity is a major challenge, but when science and compassion work together, miracles happen." The parents, who had long battled infertility and suffered a miscarriage after their first IVF attempt, conceived again through IVF. However, their joy turned into anxiety when premature labour began at just 22 weeks and 5 days — a pervivable stage where survival rates are exceedingly low. Against all odds, the baby was delivered,



intubated immediately, and resuscitated in the delivery room. Despite being counselled about the poor prognosis, the shifted to room air. Amazingly, during the entire NICU stay, not a single drop of formula milk was used. The care

approach included developmentally supportive care, kangaroo mother care, and exclusive use of mother's milk, which played a critical role in the baby's growth and neurological development.

Kishore said, "A perfect trisid of medical excellence, nursing dedication, and parental trust. At 22 weeks, survival is not just about machines or medi-

Students protest over iron gates near V-C office at Ambedkar varsity

New Delhi: Ambedkar University turned into a site of spirited protest on Tuesday, as students rallied against the administration's move to install permanent iron gates around key campus areas, including the Vice-Chancellor's office, the museum, the IT lab and the canteen. The demonstration, organised by the All India Students' Association (AISA), began near the university library, where students gathered under the "protest tree", raising slogans and singing protest songs. Marching towards the main gate, they called for an immediate halt to the construction and demanded the reopening of spaces they claim are being unfairly restricted. "Today a protest is being organised in Ambedkar University, Delhi, opposing the installation of iron gates that is being done to syphon off the administration area and the VC Office at the Kashmere Gate campus," students said. The dispute dates back to April, when temporary barricades were erected following the suspension of a student who had criticised the Vice-Chancellor's Republic Day speech. Since then, the university's main gate has remained closed, forcing students to use a back route that they describe as unsafe due to poor lighting and reported incidents of harassment. "A large part of an already small campus has remained inaccessible to the students, wherein the student-facing offices have been shifted so that the rest of the administration can be distanced from the students. This barricading has also led to a longer route to the canteen, meaning students have no access to the VC Office and administration area," said Prerna, AISA president at Ambedkar University. Students say they noticed construction work beginning on Monday and allege that the university is now installing iron gates to permanently block access to these areas, with the work expected to be completed within days. Prerna (PhD, women's and gender studies) and Aameen (PhD, urban studies) met with the university Proctor to press their demands. However, the Proctor reportedly told them the installation of the gates was "non-negotiable." Students say they remain determined to continue their protests until the campus is "open and accessible once again."

3 militants arrested in Manipur's Imphal; firearm, cash recovered

Imphal: Two active members of the banned People's Liberation Army were arrested from Khurai Lamlong and Porompat areas on Thursday, he said. A firearm, ammunition and unaccounted cash of Rs 60,300 were recovered from their possession. They were accused of being involved in extortion from schools, brick-making units, hospitals and pharmacies in Imphal East, police said. 15 years on, man held from Gujarat for murdering wife

New Delhi: The Delhi Police claimed to have solved a 15-year-old murder case with the arrest of a man, who killed his wife in a fit of rage over domestic fights in Northwest Delhi's Jahangirpuri, they said on Friday. The accused, Narottam Prasad, was arrested from Chhoti Udaipur area in Vadodra, Gujarat, where he was working as a manager at a cotton factory by hiding his identity. He killed his wife and wrote a fake suicide note to make it appear as a suicide. The case dates back to May 31, 2010, when the police received information about a foul smell from a house in Delhi's Jahangirpuri. When the police broke open the door, they found the decomposed body of a 25-year-old woman lying on the floor. They also recovered a suicide note from the crime scene. As the investigation began, the police laid their suspicion on Prasad (victim's husband), who was on the run. The police later declared him a proclaimed offender and announced a reward of Rs 10,000 for his arrest. Following a tip-off regarding his whereabouts and using technical surveillance, the police arrest him. Prasad is a resident of Sikar in Rajasthan. During interrogation, he revealed that quarrels between him and his wife escalated shortly after their marriage.

Afghan-Pak peace talks collapse after Islamabad's 'beyond capacity' demand

Peace talks between Afghanistan and Pakistan have collapsed, though a ceasefire between the two neighbours remains in place, the Taliban confirmed on Saturday. Taliban spokesperson Zabihullah Mujahid said negotiations broke down because Islamabad demanded that Kabul take responsibility for Pakistan's internal security, a condition he described as beyond Afghanistan's "capacity." "The ceasefire that has been established has not been violated by us so far, and it will continue to be observed," Mujahid added.

Pakistani Defence Minister Khawaja Muhammad Asif on Friday said that the peace talks, held in Istanbul to prevent renewed border clashes, had failed. He noted that the ceasefire would continue as long as no attacks originated from Afghan territory. The collapse of talks came a day after Afghan and Pakistani troops exchanged fire along their shared border, coinciding with the resumption of negotiations in Istanbul.

Turkish President Tayyip Erdogan met Pakistan's Prime Minister Shehbaz Sharif in Baku on Saturday and expressed hope that the discussions would "yield results toward lasting stability." He reiterated Turkey's commitment to facilitating dialogue between the two sides, according to a statement from his office. Tensions between Afghanistan and Pakistan have escalated in recent months. Their militaries clashed last month, resulting in dozens of deaths, the worst violence since the Taliban took power in 2021.

Over 1,300 US flights cancelled as government-mandated flight cuts enter second day

Air travel chaos deepened across the United States on Saturday as airlines cancelled 1,330 flights on the second day of government-mandated flight cuts, while thousands more faced severe delays amid the ongoing federal shutdown. The Federal Aviation Administration (FAA) has ordered airlines to reduce daily flights by 4 per cent at 40 major airports, citing safety concerns due to air traffic controller shortages. Staffing issues have worsened as controllers, unpaid for weeks, increasingly fail to report for duty.

Earlier on Friday, more than 1,200 flights were cancelled nationwide as part of efforts to ease pressure on the system. Major hubs including Atlanta, Denver, Newark, Chicago, Houston, and Los Angeles were among the worst affected.

By Saturday, delays were reported in at least 12 major US cities, with some passengers waiting for over five hours. The FAA warned that flight cuts could rise to 6 per cent on Tuesday and 10 per cent by November 14 if the shutdown continues.

Transportation Secretary Sean Duffy cautioned that reductions could climb even higher if absenteeism grows, saying the agency would "make decisions based on what we see in the airspace."

The disruption comes as the shutdown stretches into its 39th day, with about 13,000 air traffic controllers and 50,000 security screeners working without pay. Lawmakers remain locked in partisan gridlock, with Republicans and Democrats blaming each other for the funding impasse that has now grounded a key part of the nation's aviation system.

Canada deports 3 in gang extortion probe after attacks on Indian businesses, homes

The Canadian government has taken major action against gangs involved in extortion-related shootings. The Canada Border Services Agency (CBSA) has deported three foreign nationals accused of operating an extortion racket in the country. According to officials, the CBSA has also identified 78 other individuals suspected of involvement in similar criminal networks. Over the past few months, incidents of shootings outside the homes and businesses of businessmen have increased across Canada. Among the targets was popular comedian Kapil Sharma's Caf 2727 restaurant.

In response to the surge in such incidents, the British Columbia Extortion Task Force was formed. The recent deportations were carried out under this task force, which aims to curb the growing trend of extortion threats and violence against businesses, particularly within the South Asian community in the Lower Mainland.

In a statement, the Canada Border Services Agency said that the agency has initiated immigration investigations into 78 foreign nationals who may be inadmissible and has deported three individuals related to these investigations. The extortion task force consists of 40 members drawn from various policing agencies.

Meanwhile, sources have indicated that despite Canada designating the Lawrence Bishnoi gang as a "foreign terrorist organisation," its criminal activities have continued to rise. In areas such as Brampton in Ontario, home to a large Indian diaspora, the gangs led by Lawrence Bishnoi, Goldy Brar, and Rohit Godara have seen a spike in violent crimes and extortion attempts. Recently, Indian-origin businessman Darshan Singh Sasi was shot dead in Abbotsford, British Columbia. The Lawrence Bishnoi gang later claimed responsibility for the killing.

Hafiz Saeed opens new front against India, sends close aide to Bangladesh

Lashkar chief Hafiz Saeed is reportedly expanding the group's terror network through Bangladesh by sending his associates to train and radicalise local youth, a senior terror commander claimed during a public speech.

Lashkar-e-Taiba (LeT) chief Hafiz Saeed is planning to open a new front of terror against India through Bangladesh and has sent one of his close associates to the country, according to a top Lashkar commander who disclosed the development during a recent public rally.

According to sources, Hafiz Saeed has dispatched one of his associates to Bangladesh, where he is reportedly inciting local youth in the name of jihad and providing them with terror training.

Addressing a rally in Pakistan's Khairpur Tamewali on October 30, Lashkar commander Saifullah Saif openly called for jihad against India, declaring, "Our people are active in East Pakistan (Bangladesh) and are ready to respond to India".

"Allama Ibtisam Elahi Zaheer went to Bangladesh. He spoke of Kashmir, that Bengal (Bangladesh), which was snatched from us, which Indira Gandhi had said that 'we have drowned the two-nation theory in the Bay of Bengal'. Today, by the grace of Allah, that son of a lion, that orator, Allama Ibtisam Elahi Zaheer, is roaring like his father, like a lion, inside Bangladesh," he said.

The Lashkar commander added, "He is talking about Kashmir and Palestine. India is worried and distressed by this. They say, 'Hafiz Saeed's right-hand man has gone to Bangladesh. Now, from Bangladesh, they will come into India.'"

In a video of the speech obtained by India



action following the Pahalgam terror attack -- claiming it as a victory for the Pakistan Army.

"If you have learnt the lesson of jihad, when you entered the field on the night of May 10, Allah made you a superpower in the world. India was attacking you, America was with them, all this was happening. Today, they have all sat down. Allah has established you in the world," he said.

Hafiz Saeed and his Lashkar-e-Taiba are considered the masterminds of several major terror attacks in India, including the 2008 Mumbai terror attacks and the 2001 Parliament attack. Saeed, who is currently serving a 78-year prison term in Pakistan, allegedly continues to operate from behind bars and enjoys the patronage of Pakistan's political and military establishment, despite being an internationally designated terrorist.

Today, the terror leader is seen urging people to wage war against India, with visuals showing even children among the audience.

Saif also made an apparent reference to Operation Sindoor -- India's counter-terror

After Kalmaegi, Philippines braces for super typhoon Fung-wong, evacuates people

The Philippines evacuated over 100,000 residents across its eastern and northern regions as Fung-wong intensified on Sunday into a super typhoon ahead of its expected arrival later in the day, threatening to unleash torrential rains, destructive winds, and storm surges. Storm alert signals have been hoisted across large parts of the Philippines, with Signal No. 5, the highest warning, raised over southeastern Luzon, including Catanduanes and coastal areas of Camarines Norte and Camarines Sur, while Metro Manila and surrounding areas are under Signal No. 3.

Packing sustained winds of 185 kph (115 mph) and gusts of up to 230 kph, Super Typhoon Fung-wong, locally known as Uwan, is forecast to make landfall in Aurora province in central Luzon Sunday night at the earliest. Parts of Eastern Visayas were already experiencing power outages.

Some images shared by the Philippine Coast Guard in Camarines Sur showed evacuees carrying bags and personal belongings as they



cancelled, according to the civil aviation regulator.

A video shared by ABS-CBN News on X showed stormy conditions in Catanduanes province, with an overcast sky, tree branches swaying violently in the wind, and strong rain visibly falling and pounding the area, its intensity audible.

Fung-wong approached the Philippines just days after the country was battered by Typhoon Kalmaegi, which killed 204 people and left a trail of destruction before slamming into Vietnam, where it claimed five more lives and devastated coastal communities. In the fishing village of Vung Cheo in central Vietnam, fishing vessels were seen piled up in wrecks along the main road on Saturday, where hundreds of lobster farms had been washed away or damaged.

Man opens fire at immigration officers in Chicago amid raid, says US government

A man in Chicago opened fire on US Border Patrol agents during an immigration enforcement operation on Saturday, the Department of Homeland Security (DHS) said. However, the Chicago Police Department denied that anyone was injured in the incident. According to DHS, the suspect, who was driving a black Jeep, managed to flee the scene and remains at large. Chicago police said officers responded to reports of shots being fired and secured the area. "There are no reports of anyone struck by gunfire," the department said in a statement.

The shooting reportedly occurred in the Little Village neighbourhood during protests against ongoing immigration raids by federal agents. A Reuters witness saw police detaining a man after an argument with residents following one such raid.

DHS said "agitators" threw a paint can



and bricks at Border Patrol vehicles during Saturday's operations. "Over the past two months, we've seen an increase in assaults and obstruction targeting federal law enforcement,"

the agency said in a statement posted on X. Raids have taken place across Chicago and nearby suburbs, including one at a daycare centre earlier this week. The operations have sparked protests and, in some cases, violent confrontations.

On Friday, more than a dozen suburban Chicago mothers were arrested outside an immigration detention facility in Broadview, a suburb west of Chicago that has become a flashpoint for anger over Trump's "Operation Midway Blitz." The immigration crackdown in Chicago began in September with the stated goal of targeting dangerous criminals living in the US illegally. DHS said the operation has led to more than 3,000 arrests, including US citizens and people with no criminal history.

'Do you know about Mamdani?' Masked US immigration agents grill Indian-origin man

An Indian-origin Illinois Department of Transportation (IDOT) employee was questioned by three masked agents about his immigration status while working on a construction project in the US state and also asked whether he was aware of the new mayor of New York, Zohran Mamdani. The incident has drawn criticism from state officials and has raised concerns about the targeting of US citizens based on race or ethnicity.

The individual questioned is an Indian-American and a US citizen, and was performing his duties on the Busse Highway resurfacing project when agents approached and questioned him about his background and connections to New York, The Chicago Sun Times reported. This encounter occurred amid heightened scrutiny of immigration enforcement activities in the Chicago area.

Illinois Governor JB Pritzker addressed the incident publicly, calling it part of a broader pattern of what he described as racial profiling by federal officials. He said that President Trump and Homeland Security Secretary Kristi Noem were "continuing to question US citizens apparently based on the colour of their skin." "I am appalled they would stop and question a state employee working hard on the job to help improve our state's roads and infrastructure," Pritzker further expressed his outrage in a statement, emphasising the rights of state employees to perform their work free from harassment.

He added, "Our state employees should be able to go to work and do their jobs without masked agents targeting them for no legitimate reason".

The Department of Homeland Security (DHS) responded on Saturday, denying that the agents involved were from US

Immigration and Customs Enforcement (ICE) or US Customs and Border Protection (CBP). The governor's office did not provide additional details



regarding the agents' identities or authority.

Reports of the incident caused concern in the local community, with students and teachers in Park Ridge-Niles School

District 64 instructed to remain inside their buildings on Friday. The district superintendent, Ben Collins, said that "he was aware of reports regarding ICE agents in Park Ridge neighbourhoods near some of the district's schools."

These events unfolded during a week of increased federal immigration activity in the Chicago metropolitan area. Federal judges in Chicago recently set new restrictions on conditions at the Broadview immigration facility and on DHS use-of-force policies.

On Thursday, federal immigration agents reportedly led a caravan through Chicago's Southwest Side, making multiple stops to question residents about their immigration status. The operation was headed by US Border Patrol Commander-at-Large Gregory Bovino.

Counter sought on plea to regulate darshan in Tiruchendur Murugan temple

MADURAL (Agency)
The Madurai Bench of Madras High Court on Friday directed the Hindu Religious and Charitable Endowments (HR&CE) department to file counter counter-affidavit on a PIL seeking direction to streamline darshan and other facilities in Tiruchendur Subramaniya Swamy temple.

The litigant, B Rajesh, an advocate from Chennai, stated in the petition that, due to improper crowd management, devotees visiting the above temple are forced to wait 5 to 7 hours in a queue for darshan. The arrangements made for the smooth darshan of senior citizens and persons with disabilities (PwD) are also inadequate. Parents who come with infants are also put to untold hardships due to poor services, he alleged, and basic facilities like drinking water, toilets, and resting areas are also insufficient.To alleviate these problems, devotees submitted a representation to the temple authorities on August 7, suggesting several measures, such as an online darshan booking system, exclusive access for senior citizens and PwD, and a colour-coded darshan token system for different types of darshan, among others. However, there has been no proper action on the same, he claimed, and sought the court's intervention.

Hearing the case on Friday, the counsel representing the HR&CE department stated that several measures have been undertaken to regulate darshan and other services. Hearing this, a bench of justices, Anita Sumanth and C Kumarappan, directed the department to file a counter affidavit and adjourned the case to December 9.

Door-to-door pre-census drill in Karnataka

Ahead of the much-awaited national census 2027, the Directorate of Census Operations, Karnataka region, will conduct a door-to-door pre-census trial drill on November 10.

It will be conducted in three select locations to ascertain what needs to be improvised for Census 2027. The three locations include 46 villages of Supa, Joida taluk in Uttara Kananda district, 27 villages of Gundlupet taluk in Chamarajanagar district, and JP ward in Bengaluru North City Corporation.

Census 2027 will be held in two stages. The first will be from April to September 2026, with a 30-day window in which each state government has been given the option to choose their dates.The second stage will be from February to March 2027. The census exercise is being organised by the Directorate of Census Operations/Citizen Registration, under the Ministry of Home Affairs. A trial is being conducted as it is for the first time the census is being done with a combination of physical and digital assessment. It is also the first time a self-enumeration method has been introduced.

A trial was done from November 1-7, 2025, where around 1,100 households from select locations participated in the exercise.

Explaining the exercise, Aswini Kumar, Deputy Director, Directorate of Census Operations, Karnataka region, told The New Sunday Express that in 2010, the census was done physically.

Nuapada in spotlight: A forgotten district basks in by-election glow

NUAPADA. (Agency)
For a district that often makes headlines for migration and neglect, Nuapada is suddenly at the centre of Odisha's throbbing political map. After more than two decades, a by-election has turned this quiet border district into a buzzing hotspot of politicians.Over the past week, locals have watched the chief minister's convoy twice, the former chief minister's as many times and a steady stream of white SUVs crisscrossing the roads amid campaign music blaring through loudspeakers. For the people here, this is more than just a bypoll. It is their rare moment of fame.

Nuapada finds itself at the peak of this political excitement due the death of sitting MLA Rajendra Dholakia on September 8. A four-time legislator and former minister, Rajendra's death left a void in the BJD, triggering a political contest that soon grew larger than the seat itself.

For the ruling BJP, it became an opportunity to add another constituency to its tally and prove its 16-month governance record; for BJD, it was a mission to retain its bastion and for Congress, a test of relevance in a district where it once had deep roots.

Even before candidates began filing nominations, the ripple effects were felt in the local economy. All four hotels in Nuapada and Khariar Road were booked within hours by BJD and BJP. At the only Khariar Road hotel, rooms were first split between the two political parties. But when Rajendra's son Jay Dholakia switched camps, the entire hotel turned saffron overnight.

Houses that struggled to find tenants are now packed with party leaders and campaign workers. The boom has spread across a 60-70 km radius, even into nearby districts besides towns in Chhattisgarh.Prices of groceries and vegetables have soared, and local shops are doing brisk business, thanks to the influx of politicians.For residents, the by-election has brought back a kind of energy they last saw in 1997. In a town that usually shuts down by 9 pm, hotels now buzz past midnight. These hotels have become the only places where party workers of all affiliations, journalists, and locals sit together to eat and talk.

Kerala’s first Catholic nun Mother Eliswa beatified

In a realisation of the prayers of the sisters of the Congregation of the Teresian Carmelites and the hopes of the residents of Ochanthuruth, thousands of faithful gathered on Saturday at the Vallarpadam Basilica to witness the beatification of Mother Eliswa, the first nun of the Catholic Church in Kerala.

Cardinal Sebastian Francis, special representative of Pope Leo XIV and bishop of Penang, Malaysia, officially proclaimed Mother Eliswa as blessed. The cardinal read out the declaration issued by the pontiff in Latin. In his entreaty, the metropolitan of Verapoly archdiocese, Joseph Kalathiparambil, said, “Mother Eliswa’s holy, courageous, and unwavering life of faith and love will be an inspiration to many.”

Speaking after the proclamation, Cardinal Sebastian said, “So today, with immense joy and gratitude, we rejoice to witness this historic moment for the global Carmelite family, for the archdiocese of Verapoly, for the church of Kerala, for India, for Asia, and for the universal church. We rejoice with all the consecrated women, all mothers, and all those who suffer in silence and still choose to love. Her tomb at Varapuzha, which I too had the privilege to visit two days ago, has become a place of pilgrimage, where people of all backgrounds come to seek her intercession. And now, she intercedes for us

from heaven as Blessed Eliswa, a beacon of hope, a spiritual mother, and a saint for our times.”Earlier, processions carrying the portrait, logo, and deepashika (torch) arrived at the National Shrine Basilica of Our Lady of Ransom from Koonammavu, Varapuzha, and Ochanthuruth. Priests accompanied bishops



to the altar as songs in praise of Mother Eliswa were sung. The bells of the church were rung as the cardinal announced the beatification. Cardinal Dr Oswald Gracias unveiled the image of Blessed Mother Eliswa. And, her relics were placed on the altar.Archbishop Leopoldo Girelli, Apostolic Nuncio to India, spoke at the ceremony. Catholic Bishops’ Conference of India (CBCI) president Archbishop Andrews Thazhath released the novena. Union minister George Kurian, state’s special officer in Delhi K V Thomas,

Kochi mayor M Anilkumar and MLAs T J Vinod, K J Maxy, and Anwar Sadath attended the ceremony.

Eliswa was declared a servant of God in March 2008 and was proclaimed venerable in November 2023. On April 14, 2025, Pope Francis approved a miracle attributed to the intercession of Mother Eliswa.

Born on October 15, 1831, Eliswa was the first of eight children of Thomman and Thanda, of the Vyppissery Capithan family of Ochanthuruth. She was the founder of the Third Order of the Discalced Carmelites, which later divided into the Congregation of Teresian Carmelites and the Congregation of the Mother of Carmel. Mother Eliswa established the first special school for women in Kerala.

TN omni bus services to Kerala suspended

CHENNAI/COIMBATORE. (Agency)
The All Omni Bus Owners Association announced that they will not be operating any services to Kerala from Saturday 8 pm. The move followed the detention of around 30 buses by the Kerala Transport Department and imposition of hefty fines for alleged permit violations.The association, in a release said, the services will not be resumed until the issue is resolved. It urged the Tamil Nadu government to immediately intervene and resolve the issue amicably.According to the statement, the Kerala Transport Department imposed fines ranging from Rs 2 lakh to Rs 2.5 lakh per bus on Friday, resulting in hardship to the passengers and operators.

The association said the suspension of services is likely to affect large number of people, particularly the devotees of Lord Ayyappa travelling to Sabarimala in the coming weeks.



In this regard, around 15 TN omni buses en route to Kerala (that departed on Friday night) were stopped before Walayar on the Salem-Kochi highway in Coimatore on Saturday morning.The passengers, opposing the drivers’ sudden decision to suspend services, demanded that they either refund the ticket fare or drop them at their destinations. Following an hour of heated arguments with

the passengers, the drivers resumed operating the buses towards Kerala from Walayar around 7.30 am.Walayar is located on the TN-Kerala border.

Before that, the passengers told reporters that when they boarded the buses, the drivers had not informed them that they would not enter Kerala. They pointed out that except for a few buses registered in Nagaland, all other buses proceeded to Kerala along this route.All Omni Bus Owners and Operators Association founder A Pandiyan told that buses with an all-India permit pay a road tax of Rs 90,000 to the central government every three months and the centre gives this amount to the respective states.“Besides, we pay road tax to the TN government based on the number of seats, and no other tax is required,” he said.As Kerala imposed taxes on TN buses citing lack of permits, they have stopped operating services to Kerala, he added.

Three youths killed, three injured as car overturns in Kerala's Palakkad

PALAKKAD. (Agency)
Three young men were killed and three others were seriously injured after their car lost control and overturned near Kallingal junction on Chittur Road late Saturday night.The accident occurred around 11 pm when a wild boar suddenly darted onto the road.The victims have been identified as Rohan (24), son of Ranjith from Nooradi Road, Rohan Santhosh (22), son of Santhosh from Noorani, and Sanoosh (19), son of Santhakumar from Yakkara.

All three died on the spot. The injured — Adithyan (23) of Chandranagar, Rishi (24) of Yakkara, and Jithin (21) of Nemmara — have been admitted to the district hospital.

According to police, the group of six friends was returning to Palakkad from Chittur when the wild boar ran across the road. In an attempt to avoid hitting the animal, the driver swerved sharply, causing the car to

lose control. The vehicle first crashed into a roadside milestone and a tree before plunging into a paddy field below. The impact was so severe that the car was completely destroyed, and a large section of the tree was sheared off.

Four of the passengers were seated at the back and two in the front. Rescue teams reported that one of the rear-seat passengers was thrown out of the vehicle. Fire and Rescue personnel, along with police and local residents, used cutting equipment to break open the mangled car and pull out the trapped victims.The two passengers in the front seat and one in the rear survived the crash.

All six were close friends who regularly met in Palakkad on weekends for outings. Sanoosh was a student, while the others were either studying or employed outside the district.

NFSF oppose Blue Economy model of development, say it will threaten livelihoods of fishers

VISAKHAPATNAM . (Agency)
The National Federation of Small-Scale Fishworkers (NFSF) has opposed the government's Blue Economy model, saying it threatens the livelihoods and traditional rights of small-scale fishing communities across India.

In a statement, NFSF President Pradip Chatterjee, General Secretary Sebastiao Rodrigues, and Joint Secretary D Pal said the Blue Economy framework effectively transfers ecological resources to corporate entities under the guise of development. They alleged that projects such as new ports, logistics corridors, real estate ventures, tourism zones, and industrial infrastructure are severely impacting coastal ecosystems and displacing traditional fishing communities.

The federation criticised the India Maritime Week 2025 conclave, describing it as a declaration of the invasion and occupation of India’s coastline.

It said that behind the narrative of national development and global ambitions lies the exclusion of fishing communities from decision-making processes and the gradual erosion of their livelihoods.

According to NFSF, even after 78 years of independence, small-scale fishing communities have not been granted legal rights over the resources that sustain them, such as coastal lands, water bodies, rivers, wetlands, and fish stocks. This lack of recognition, the federation noted, has enabled the large-scale transfer of these resources to private corporations with state backing.

The organisation also raised concerns about the promotion of mechanised and capital-intensive fishing, which it said is depleting marine resources.

Pollution, encroachment, and diversion of water for industrial use have further degraded inland and marine ecosystems. Industrial aquaculture, particularly intensive shrimp farming, was identified as a major threat to coastal ecology, groundwater, and public health.

NFSF said climate change is devastating small-scale fishers, causing loss of livelihoods, equipment, and habitat. It noted women suffer from the collapse of fish-drying activities. The federation urged protection of water bodies, recognition of fishers’ rights, a ban .

Nagulapalli village in Andhra nurtures teaching legacy

In the heart of U Kothapalli mandal, nestled within Kakinada district, lies Nagulapalli—a village quietly shaping the future of education in Andhra Pradesh. With a population of around 12,000, this Panchayat has earned a reputation for producing teachers who serve across government and private institutions, inspiring young generations with their lifelong commitment to learning.

Over 133 government teachers trace their roots to the village’s Zilla Parishad High School and MPP schools, where they once sat as students and now stand as mentors. Many alumni have gone on to teach in private colleges and schools, while several have returned to serve in their alma mater, nurturing next wave of educators.

Among them are Abbireddy Apparao Reddy, Satish Reddy, Manepalli Kondababu, Thadala Nanibabu, Chintapalli Durga Reddy, Ramavenkata Sankara Reddy, K Chiranjeevi Reddy, and Yarakam Rama Reddy—now headmasters and teachers in Nagulapalli’s schools.Nagulapalli’s



emphasis on education is evident in its infrastructure, which includes two high schools and four primary schools serving over 380 students from Nagulapalli, Isukapalli, and Thoturu villages. The schools boast of spacious playgrounds and a welcoming atmosphere, where students greet visitors.

Since 1983, the village has embraced education as a pathway to public service. Long before government mandates, elders introduced school uniform and distributed textbooks, laying the foundation for a culture of academic discipline. This vision culminated in the formation of the Nagulapalli Employees Welfare Society

(NEWS) in 2002, starting with 30 members and now boasting of 176 government employees—150 of them teachers.

Under the leadership of President P Satya Mohan Reddy and Secretary B Ramakrishna, NEWS has encouraged women to pursue employment since 2003. In the recent DSC-2025 recruitment, the village celebrated the selection of four Secondary Grade Teachers and four School Assistants.

Between 2008 and 2012, NEWS organised free DSC coaching for candidates, with 15–20 educators volunteering their time. Though the initiative paused due to logistics challenges, local leaders are now reviving it, with enthusiastic support from the teaching community.Penumalla Apparao, headmaster at Gollaprolu School and a native of Nagulapalli, recalls the early efforts of NEWS. “The society helps the new generation get teacher posts and government employment. Since our childhood, the village has encouraged children to work hard and settle in life successfully,” he told.

The WTO is dead, long live the WTO

It was a clear and balmy morning when I arrived in Geneva as ambassador to the World Trade Organization. I was ushered into the VIP lounge. Ambassadors visiting Geneva as representatives of their countries at any of the missions there have the privilege of using this lounge twice: once upon arrival and once before departure. I had been working in Brussels for the previous three years as deputy chief of the Indian embassy. The gloom and incessant rain of Brussels had worn us out considerably, and it was great to see clear blue skies, the magnificent Lake Geneva, and the snow-clad Alpine mountains in the distance. My work was not easy. The counsellor in my mission, Mohan Kumar, who distinguished himself later in many key assignments in the foreign service, came to me and said that our reputation was at its nadir. This followed the single-handed crusade by former minister Murasoli Maran at the previous ministerial conference in Doha in 2001 against the introduction of new issues such as investment and competition policy into the WTO's work programme, making them subject to its powerful and rigid dispute settlement mechanism. My first task was, therefore, to re-establish friendly links with other ambassadors, which I achieved by visiting more than 40 of them and getting on first-name terms with all. While this is not the place to describe all that transpired over the next three years, I thoroughly enjoyed my stay, loved being part of the core negotiations, and attended meetings where I pitted myself against some of the finest diplomats worldwide. I am, therefore, sad to see the current status of the WTO, where it barely survives, with all its carefully crafted and negotiated trade rules in tatters, leaving global trade itself in a disarray. Trade is an essential component of global growth. As William J Bernstein puts it in his bestselling book, *A Splendid Exchange: How Trade Shaped The World*, "World Trade has yielded not only a bounty of material goods, but also of intellectual and cultural capital, an understanding of our neighbours, and a desire to sell things to others rather than annihilate them." Trump would probably disagree with Bernstein. He cast the first stone to break away from a well-established multilateral system of trade rules by arbitrarily raising tariffs on steel and aluminium in his first term. He struck an even more brutal blow later by rendering the WTO dispute settlement mechanism dysfunctional by disagreeing on the appointment of members to the appellate body. Any ruling from the dispute settlement panel cannot therefore be taken up on appeal, breaking the legal chain. This meant that even if a member country broke multilaterally-agreed trade rules, the affected country could not impose retaliatory tariffs. Back in 2018, Trump expressed his resentment towards the WTO, claiming that the WTO was set up "to benefit everybody but us", adding: "We lose the lawsuits, almost all of the lawsuits in the WTO." In his second term, he has virtually dismantled the WTO, although he recently paid a part of the amounts due to the organisation. He imposed a set of tariffs based on his perception of unfair treatment of the US. Not only did he impose high tariffs on many countries, but he also exercised his right to change them whimsically, at times based on extraneous factors such as his belief that an ally in Brazil, former President Jair Bolsonaro, was not being treated fairly by the judiciary, or that Indian companies were buying oil from Russia. He decided to flex his muscles against China and imposed a succession of increasing tariffs. He denied that the tariffs signalled a trade war, stating that the "trade war was lost many years ago by the foolish or incompetent people who represented the US".

Sadda beta' Zohran has pushed the envelope

THE GREAT GAME: For a few tremulous hours, one half of India recognised itself in his victory

INDIA has taken to Zohran Mamdani's victory in New York in a "sadda beta" kind of way, giving him the kind of media love reserved for biggies like Shah Rukh Khan. It's not just his unabashed grin or the viral video which shows him eating biryani (with his fingers) or the fact that he wears his left-wing politics on his sleeve (read, Palestine). In the last 72 hours, reports of people googling "democratic socialism" has increased by leaps and bounds. It helps, of course, that Zohran's parents are of Indian origin — Mira Nair, the girl from Amritsar, also studied at Tara Hall in Shimla; his father, Mahmood Mamdani, a Gujarati Khoja (Shia) Muslim — whose own diasporic parents were born and raised in Tanganyika in east Africa — grew up in Kampala, Uganda. The languages spoken in the Nair-Mamdani household, besides English, are Punjabi, Hindi/Urdu, Gujarati and Swahili. On stage in New York, as he celebrated his victory earlier this week, you could be forgiven for thinking that the Mamdani household was the newest advertisement for the United Colours of Benetton — besides his parents, Zohran was flanked by his wife, Rama Duwaji, a girl of Syrian descent, whom he met on the dating app Hinge — they celebrated their nikaah a year ago in Dubai. For one moment, amidst the madness of Trump, America had redeemed itself. "Give me your tired, your poor/ Your huddled masses yearning to breathe free," say the first lines from the 1883 Emma Lazarus poem inscribed on the base of the Statue of Liberty. A multi-coloured family had broken through the bipolar White-Black politics of America and made it their own. (It helped that 40 per cent of New York's population is immigrant.) That's why it's interesting that the Indian media, divided down the middle just like the rest of the country, made Zohran Mamdani's victory its own this week. It wasn't just about the Dhoom Machale song, although that helped. It was about the fact that for a few tremulous hours one half of India recognised itself in that victory. This is the half that has grown up on Jawaharlal Nehru's "tryst with destiny" speech, which Zohran quoted at the beginning of his own. It continues to believe that the idea of New York — energetic and vibrant and messy and authentic — could still be the idea of India, a little bit of this and that, welcoming immigrants, even as it accommodates people of all faiths and castes and creeds at home. The other half is viscerally critical of Zohran because he is critical of PM Modi's politics, in Gujarat and afterwards, believes that he promotes "bigotry and bias" against Hindus and vehemently disagrees with his views on Israel and Gaza — Mamdani believes Israel has committed genocide in Gaza, while India has hugely promoted the Israel relationship in the Modi years. (Ironically, and perhaps that is the role of irony, Israeli Foreign Minister Gideon Sa'ar was in India on the day



New York voted in Mamdani.) Naturally, not one member of Modi's government has welcomed or congratulated Mamdani on his victory. On the day New York went to vote, BJP Rajya Sabha MP Rekha Sharma, former chairperson of the National Commission for Women, articulated the right-wing sentiment on X. "For this one I am with Mr Trump. People of Indian origin when you vote think twice. An Indian mother doesn't make Mr Mamdani a well-wisher of India." It would be interesting to know how the pro-Modi Indian diaspora in New York voted — all those who gatecrash the PM's public appearances, were they for or against Mamdani? If they voted in favour, what does this do to the Modi government's diaspora policy with which it has been so intimately connected for decades? For the first time in a long time, a powerful American of Indian origin so clearly represents the social-political cleavage back home. From domestic politics to foreign policy, Zohran's victory is also emblematic of the disappearing idea of compromise that defined India's decades in the aftermath of Partition — when you kept your own beliefs but also participated in someone else's

joy, even if you didn't much care for that someone. That's why the Indian media's momentary celebration of Mamdani is significant. For a few hours, the back-to-back coverage of the Bihar elections and the debate over Panjab University's overhaul gave way to Dhoom Machale, the Bollywood song, some say, that is inspired by an Indonesian pop number — the perfect example of a khichri in filmi music, a little bit of this and a little bit of that. It is this idea of a khichri, when you throw everything into a melting pot and something that is more than dal and more than rice emerges to tickle your taste buds that joins New York with India — both spaces are defined by the art of ferment. Sadda beta" Zohran has pushed the envelope back home in New York — at 34, he doesn't understand the meaning of fear. Here in Chandigarh, as this newspaper goes to bed, the news that Panjab University students have forced the Centre to withdraw its move to change the functioning of their University, echoes that absence of fear. Move over, the young are saying. We are changing the old order, making it give way to the new. Democratic Socialist or simply democratic, our time has come.

Build Indian apps to reduce reliance on foreign tech

Evidence suggests that a significant share of these crimes is orchestrated from across the border and the money laundered through organised financial networks

India's digital ecosystem thrives on American technology. From search engines and social media platforms to business applications and cloud infrastructure, our reliance on US technology runs deep, which is why the very thought of a potential US tech blackout has sparked a flurry of reactions this week. Industrialist Harsh Goenka's observations about the impact of a political crisis between India and the US might have on the tech industry if Donald Trump decides to ban US apps in India incited an opinion mob that insisted a blackout was unimaginable, though not entirely impossible. Homegrown tech firm Zoho and its founder Sridhar Vembu weighed in, too, suggesting a 10-year National Mission for Tech Resilience for self-reliance. India is the largest consumer market for US tech firms outside of China, and a potential ban would be as good as shooting themselves in the foot. That said, geopolitics can trump economics with Trump unabashedly using trade as leverage. If technology also becomes a weapon, India cannot escape without serious damage.



have put in safeguards long before the global tensions escalated. In China, domestic platforms like WeChat,

Baidu, and Alibaba dominate the tech scene. Likewise, Japan, South Korea, and Taiwan have homegrown super apps like Line and KakaoTalk, overriding Facebook, X, and Whatsapp in adoption. Line is used by more than 70 percent of Japanese mobile users, with a higher share in Taiwan, which also has a domestic champion, Dcard. India took baby steps with Koo, an alternative for X, but could not match it in performance. Zoho is leading the product innovation curve with various messaging and workspace applications like Mail, Sheet, Arattai and Vani; even though some ministers have endorsed them, they are yet to see mass adoption. There are no immediate threats, and chances are that American tech may never be weaponised. However, the fact remains that our lack of digital sovereignty remains a structural vulnerability. As can be seen from the ongoing global trade war, countries with excessive external dependence risk losing out when elements of trade are weaponised to assert world dominance. India needs to build its own digital ecosystem to shield itself from geopolitical fallout.

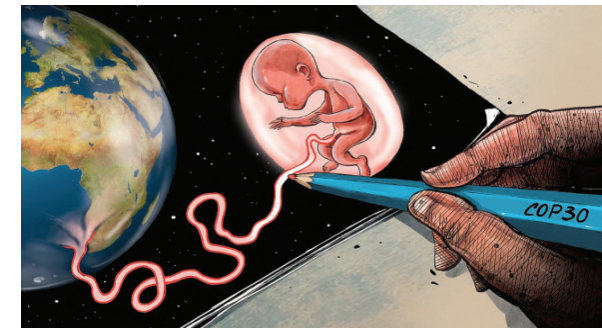
Pave road beyond COP30 with dollars, data and devotion

After starts & stops at previous COPs, the Brazil summit needs to agree on mobilising adequate funds. It must also place communities at the heart of adaptation and reward regeneration of ecosystems

As the world turns its eyes to Brazil for the 30th United Nations Climate Change Conference (COP30) next week, negotiators are preparing to track progress on the global goal on adaptation under the Paris Agreement. At its core, adaptation is about helping societies and ecosystems cope with—and ultimately thrive amid—the climate impacts that are already here, strengthening defences against floods, droughts, and heat, securing water and food, and protecting lives and livelihoods. But adaptation is more than infrastructure or indicators. It is about restoring the human relationship with nature that makes us care in the first place. After all, we care for what we love, and we love what we feel connected to. In his 1997 book, *Survival Strategies: Cooperation and Conflict in Animal Societies*, Raghavendra Gadagkar asks whether collective good can ever triumph over self-interest. Evolution rewards both cooperation and competition, but only when the balance is right. In the animal world, if individuals act solely for themselves, the group weakens; if the group thrives, individuals prosper too. That is precisely where humanity stands today on climate change. Every country and every person is trying to protect their own short-term interest to grow faster, consume more, and live comfortably while the planet's balance frays. When Earth suffers, every country eventually loses. Adaptation, then, is not charity for the vulnerable; it is survival for all. Ecological balance is restored only when people truly recognise their dependence on nature. Forests, rivers and land are not just resources but partners in survival. This understanding once

guided the rhythms of everyday life. Food and festivals followed the seasons: mangoes in summer, sarso ka saag in winter, turmeric and palash marking harvests; Pongal, Onam and Bihu celebrating nature and renewal. These quiet acts of reverence built an ethic of respect and restraint that no regulation can enforce. Today, that bond, surrounded by concrete and screens, is eroding. We speak of forests as 'carbon sinks' and wetlands as 'ecosystem services', forgetting that they are living and breathing homes. Children, especially in cities, can explain global warming but not name the trees on their street. Nature has become a subject to study, not a space to belong to, making it hard to care for something that we have never truly experienced. Why COP30 matters It is now clear that the world is heading towards exceeding the goal of limiting the global temperature rise to 1.5°C by the end of this century. The poorest and most vulnerable communities, who contribute the least to the crisis, would be the hardest hit. This makes adaptation not just a local necessity, but a test of global responsibility and solidarity. A strong collective response to their needs is a matter of climate justice and a legitimate expectation from COP30. Research by the Council on Energy, Environment and Water shows that over 80 percent of India's population lives in districts highly vulnerable to extreme climate events such as floods, droughts, and cyclones—underscoring why adaptation must be viewed as development itself. Past conferences have offered the world hope. COP26 in Glasgow urged for doubling the finance for adaptation and resilience. COP27 in

Sharm el-Sheikh created the Fund for Loss and Damage, a long-standing demand of the developing countries. However, despite these noble intentions, concrete finance commitments



remain meagre and elusive. Less than a third of climate finance currently reaches adaptation. The rest remains mired in bureaucracy and unfulfilled pledges. COP30, hosted near the world's largest rainforest, must correct the course. It should not just agree on frameworks or metrics for the global goal on adaptation. It must deliver tangible progress on adaptation finance, particularly to communities restoring ecosystems, and livelihoods on the frontlines of climate risk. Adaptation finance should be reframed as investment in resilience supporting those who protect and conserve our natural resources and keep our traditional knowledge alive. The much anticipated 'Baku to Belém Roadmap' for mobilising \$1.3 trillion a year by 2035 must not unveil mere possibilities. It should build pathways

that place communities at the heart of adaptation and reward actions that regenerate ecosystems. When trees are cut in the Amazon it weakens the monsoons in Asia. When adaptation becomes participatory and local knowledge meets modern science, it multiplies impact. For instance, India's climate missions and state action plans increasingly combine traditional wisdom with new technologies, from rainwater harvesting and mangrove restoration to resilient housing and micro-insurance. COP30 can learn from such models that value both data and devotion. This philosophy resonates deeply with Mission LIFE (Lifestyle for Environment), India's call for climate action rooted in mindful consumption and coexistence. It reminds us that individual choices, multiplied across billions, can reshape collective outcomes. Mission LiFE is a modern expression of India's ancient ethos: that progress and balance with nature are not contradictions, but complements. Equally vital is the role of the youth. YOUNGO, the official youth constituency at the climate conference, is infusing urgency and sensitivity into negotiations. Across countries, young people are demanding that adaptation be more than infrastructure: it must be imagination: of greener cities, restored rivers, and shared futures. They understand instinctively that resilience is as much about relationships as resources. The lesson is clear. The good of the individual and the good of the collective are not in conflict; they depend on each other. Caring for the planet is not an act of altruism.

Viral video by Gopalpattinam schoolgirls over leaking classrooms prompts official action

PUDUKKOTTAL. (Agency)

Taking their miseries from slushy pathways and leaking classrooms during rainy days to the attention of the public, a group of girl students of the government higher secondary school at Gopalpattinam in the district on Friday shared a video online, which has since been shared widely and has prompted official action. In their video highlighting the plight at their 13-year-old school, where more than 300 students are pursuing Classes 6 to 12 in around 10 classrooms, one of the girls said, "We struggle to even reach school when it rains. The classrooms leak and we don't even have proper toilets. We just want basic facilities."

We would be forced to stage a protest were the premises not cleaned and restored by Monday, the group said. Following the video, district education officials said they have sought a detailed report from local authorities and would mobilise funds from donors to build a proper pathway to the school.

A Rs 50-lakh proposal for constructing new buildings will also be sent to the district administration and the school education department. In the meantime, the students would be shifted to safer classrooms and similar temporary measures would be taken until permanent repairs are made, they added.

Salem double murder: Ayyanar's aide arrested

SALEM. (Agency)

One more person has been arrested over links to the brutal murder of two elderly women of Edaganasalai in Sangagiri taluk early this month.

K. Boopathy (52) was taken into custody on Saturday for allegedly assisting in the murders of Paavayi (70) and Periyammal (75) and helping the main accused, C Ayyanar, to dispose of their bodies. Ayyanar was caught by police near Orukkamalai in Sangagiri taluk during the early hours of Friday. He was shot in the leg during his capture.

Ayyanar, a 55-year-old man from Kamalapuram in Omalur, was arrested by a special police team from Magudanchavadi following a tip-off. When confronted, he allegedly attacked a sub-inspector with a knife, prompting the police to shoot him in the leg before taking him into custody. Ayyanar confessed to murdering both the women during interrogation. Their bodies were found floating in an abandoned stone quarry on November 4.

Police said the crime stemmed from a quarrel after Paavayi demanded repayment of money she had lent Ayyanar. Under the influence of alcohol, he attacked and killed her. When Periyammal questioned him about the murder, Ayyanar killed her too to conceal his crime. According to police, Boopathy had reached the spot while Ayyanar committed the second murder and later helped.

Virtual queue booking mandatory for Sabarimala darshan: Police



THIRUVANANTHAPURAM. (Agency)

Pilgrims coming to Sabarimala for darshan without virtual queue booking may face inconvenience and long waiting times, the state police have informed.

In a detailed press release on Saturday, the police informed that virtual queue booking is essential for darshan. "Devotees should strictly adhere to the time slot allotted in the booking. Spot bookings are very limited. Therefore it is not possible to accommodate all devotees arriving without virtual queue booking. Also, pilgrims from other states should plan their journey in such a way that they reach only within the allotted time," said the statement.

The state police also issued a slew of instructions to the pilgrims. According to which, pilgrims should use the traditional path - Marakootam, Saramkuthy, Nadapanthal to reach Sannidhanam. They should follow the queue system to reach Pathinettampadi, and use Nadapanthal fly-over for return journey.

Identification cards with address and contact numbers should be hung on the neck of children, aged, and malikapurams, said the release. Pilgrims can contact helpline number 14432 to approach police for emergency response in crisis situations.

Union Steel Ministry approves iron ore pipeline from Chhattisgarh to AP via Odisha

The Ministry of Steel, Government of India, has approved ArcelorMittal Nippon Steel India (AMNS India) for the establishment of an iron ore slurry pipeline connecting Chhattisgarh to Andhra Pradesh via Odisha.

The pipeline will transport iron ore from mines to AMNS India's upcoming integrated steel plant at Anakapalle in Visakhapatnam district. The approval has been accorded under the Petroleum and Minerals Pipelines (Acquisition of Right of User in Land) Act, 1962, which authorises a nominated authority to sanction the right of way across the states the pipeline will traverse.

The proposed pipeline will carry iron ore in slurry form, creating a sustainable and cost efficient logistics corridor that reduces reliance on conventional road and rail transport. The project is expected to significantly lower the



carbon footprint of industrial logistics and aligns with India's broader push for green infrastructure. The Centre's timely clearance reflects its commitment to fast tracking industrial development in Andhra Pradesh and highlights the growing synergy between the

state and Union governments in advancing India's manufacturing capabilities.

This pipeline approval marks a critical milestone in the rollout of AMNS India's 17 million tonnes per annum (MTPA) integrated steel plant, with 8.2 MTPA capacity planned for the

first phase. The Anakapalle facility is poised to become one of India's largest greenfield steel plants, featuring advanced technologies for energy efficiency, water recycling and emissions reduction. Just last week, the Ministry of Environment, Forest and Climate Change's Expert Appraisal Committee (EAC) recommended environmental clearance for the first phase.

With both environmental and pipeline approvals, the Anakapalle project is now set to enter its implementation stage, reinforcing Andhra Pradesh's emergence as a preferred destination for global industrial investment. Andhra Pradesh Minister for HRD, IT, Electronics and RTGS, Nara Lokesh said, "This milestone is a testament to Andhra Pradesh's leadership in providing world class infrastructure, speedy clearances, and proactive governance. The AMNS project will generate thousands of direct and indirect jobs, boost local industry, and strengthen India's position in the global steel supply chain."

Double-engine govt in Bihar should continue, says Minister Nara Lokesh

Andhra Pradesh HRD and IT Minister Nara Lokesh underscored the critical role of strong State governments in driving national development. As part of his election outreach, Lokesh met with representatives of the Bihar Industries Association, and prominent business leaders, including Ramji, Goenka, and former MP GVL Narasimha Rao, to share Andhra Pradesh's investment success story, and advocate for continued NDA governance.

Lokesh emphasised that Andhra Pradesh's transformation into a top investment destination was made possible by the "double-engine bullet government" led by Prime Minister Narendra Modi and Chief Minister Chandrababu Naidu.

He cited landmark projects such as Google's entry into AP within 12 months, and



ArcelorMittal's upcoming steel plant, facilitated by the swift resolution of investor concerns through direct coordination between the CM and the PM.

"States must be strong for India to grow. AP's policy clarity, leadership commitment, and speed of execution have attracted record-breaking investments," Lokesh said.

He credited the Centre's support — particularly

from Finance Minister Nirmala Sitharaman and IT Minister Ashwini Vaishnaw — for enabling India's largest FDI to land in Andhra Pradesh.

Drawing parallels with Bihar, Lokesh praised Chief Minister Nitish Kumar's leadership for fostering law and order, women's safety, and corruption-free governance. "Bihar's development before and after Nitish Kumar shows what strong leadership can achieve," he said, adding that both AP and Bihar benefit from constructive Centre-State relations.

Lokesh also highlighted AP's Vision 2047 document, which outlines the roadmap to becoming a trillion dollar economy. He acknowledged the challenges posed by the previous government's cancellation of PPAs, which forced the current administration to work 10 times harder to regain investor confidence.

Controversy erupts over preferential treatment of inmates in Bengaluru Central Prison

Bengaluru Central Prison authorities are again in the dock after photographs and videos of inmates using mobile phones and receiving preferential treatment went viral. This time, the photos and videos allegedly show suspected terror operative Zuhab Hameed Shakeel Manna and convicted serial rapist and killer Umesh Reddy using mobile phones and watching TV inside the prison.

In the video, Umesh Reddy is seen wearing coloured clothes and using a mobile phone inside his cell, while he is expected to wear prison-issued clothes as he is a convict. There is definitely no provision for him to use the mobile phone. He was also allegedly allowed to cook for himself.

Shakeel Manna, who was arrested by the National Investigation Agency for allegedly helping raise funds and radicalise Muslim youth, is also seen using a mobile phone in the viral clips. It is alleged that actor Tarun Kondaraja, an undertrial arrested in a gold smuggling case, too received special treatment when he was in the prison. Tarun was in the prison for nearly a year, and his use of mobile phones during custody is now under scrutiny. Among the 12 videos

circulating on social media, four were reportedly shot in 2022.

This newspaper tried to contact Additional Director General of Police (Prisons) B Dayananda, but he was not available for comment. Other senior prison officials, however, said he has ordered a probe into the viral photos and videos. Recently, a



video of rowdy-sheeter Srinivasa alias Gubbachchi Seena, lodged in the prison in connection with a murder, celebrating his birthday inside the jail had also gone viral. Disciplinary action had been initiated against six prison staff initiated after that incident. In the last two months, two jail wardens have been arrested for allegedly supplying drugs and mobile phones to inmates. The Supreme Court, too, had slammed the Bengaluru Central Prison authorities for allegedly giving preferential treatment.

Fix city infrastructure or quit: Karnataka LoP Ashoka to Deputy CM Shivakumar

Leader of Opposition in the Assembly R Ashoka, Bengaluru Central MP PC Mohan, MLAs S Suresh Kumar, CN Ashwathnarayana and Munirathna Naidu, and local BJP leaders launched a campaign in Vijayanagar and Govindraj Nagar Assembly constituencies on Saturday against the Congress government for ignoring the city's "crumbling" infrastructure.

Ashoka lashed out at Deputy Chief Minister DK Shivakumar, who is also Bengaluru Development Minister, for not taking any steps to fix problems such as potholes and waste disposal. He urged Shivakumar to resign as Bengaluru Development Minister if he can't set right problems related to the city's infrastructure. The campaign will be extended to other Assembly constituencies in the city, he said. Criticising Chief Minister Siddaramaiah and Shivakumar, Ashoka said they set a deadline for officials to make Bengaluru pothole-free by October 31. But that did not happen and motorists in the city have been left to fend for themselves.



The BJP leaders marked the potholes in parts of the two constituencies to alert motorists to avoid them.

Referring to Siddaramaiah asking reporters to question Shivakumar over potholes and garbage menace at a press conference recently,

Ashoka said it indicates that there is a rift between them. "The DCM claims that he is a trouble-shooter, but he is unable to take on the garbage mafia. If he can question Kiran Mazumdar Shaw, Mohandas Pai, and BJP MLAs and MPs from the city, why can't he act against the mafias in the city? The garbage mafia is from Telangana. I urge the DCM to persuade Telangana Congress

leader and CM Revanth Reddy to control the mafia," Ashoka said.

Due to the rift between Shivakumar and Siddaramaiah, the capital city is suffering, he alleged. Referring to sugarcane growers' agitation, Ashoka said the government has agreed to procure cane for Rs 3,300 per tonne only from Belagavi farmers. It can't ignore cane growers from other districts of the state.

UDF cosies up to Jamaat-e-Islami for local body election; Muslim groups raise concern

KOZHIKODE/MALAPPURAM. (Agency)

The UDF is going ahead with its seat-sharing deal with the Welfare Party of India (WPI) in Malappuram for the local body election even as some Muslim organisations are trying to convince the front's leadership about the "danger of joining hands with the political wing of the Jama'at-e-Islami".

Under the arrangement, the UDF will allocate seats to the WPI in all local bodies where the latter already has a foothold. In return, the WPI will extend its full backing to the Indian Union Muslim League (IUML) and other UDF candidates across Malappuram. Seat division has already been finalised in several key panchayats, including Angadippuram, Koottilangadi, Mampad, Tirurangadi, Tirur, and Kondotty. In

Angadippuram and Mampad, the WPI has already announced its candidates. "In Malappuram, the UDF — particularly the Muslim League — remains the most powerful force. To strengthen our political presence, we have chosen to cooperate with the League and the UDF locally. This, however, does not imply a state-level alliance," said a senior WPI leader.

IUML general secretary P M A Salam confirmed the development to, stating that the understanding with WPI was part of the League's broader electoral strategy.

'Jama'at ties will cost UDF dear in assembly polls'

"The UDF has no official alliance with the Welfare Party at the state level. But local



body elections are different — we must join hands with smaller parties to ensure the front's victory. The IUML and UDF leadership has instructed local units to cooperate with the WPI wherever

necessary. What is happening in Malappuram reflects that ground reality," Salam said. Meanwhile, some Muslim organisations have expressed deep concern over the UDF move to have an electoral understanding with WPI, which they believe would have disastrous consequences for the front and society at large.

One Mujahid group met Leader of Opposition V D Satheesan in person in Malappuram two days ago to convey the organisation's view on the matter. "We told Satheesan that it was unfortunate that he had given a clean chit to the Jama'at saying the organisation had changed its ideology. The assessment stems from a total ignorance of its working," a Mujahid leader told.

Rath Yatra stampede: Probe panel recommends action against seven cops

BHUBANESWAR. (Agency)

The probe panel to investigate the stampede during the Rath Yatra at Puri has held seven senior police officers responsible for lapses in crowd management and recommended disciplinary action against them, besides blacklisting the firm that supplied AI-powered surveillance cameras for the festival. Development commissioner Anu Garg was asked to probe the incident hours after three pilgrims were killed in the stampede near Gundicha temple on June 29. The panel observed that the then Puri SP had the overall responsibility for deployment of police force at different important locations of Puri town including at Srimandir, Gundicha temple, chariot site and Badadanda in consultation with senior police officers.

"Senior officials - commandant of OSAP 3rd Battalion, Koraput Ajay Kumar Padhi and DCP (HQ) of Commissionerate Police Vishnu Prasad Pati deployed for crowd management in front of the chariots that day were physically absent," the report stated. The panel recommended disciplinary proceedings against the two who are already under suspension.

The panel found that officers responsible for coordinating with the Shree Jagannath Temple Administration and sevayats did not maintain proper communication nor alerted the control room about ritual timings, crowd build-up and delays. Commandant of Swatantra Shree Mandir Surakshya Vahini (SSMSV), Puri Tapas Ranjan Das, deputy commandant KK Nayak and city DSP Prasanta Kumar Sahoo failed to ensure timely liaison during 'Dwaraphita' in the morning, leading to severe congestion ahead of rituals, the report said. Moreover, city DSP Sahoo and Kumbharpada IIC Susanta Kumar Sahoo were found to have failed in crowd control duties near the chariots and allowed a charamala-loaded truck to move through a densely packed crowd, which ultimately triggered the stampede, said the report.

No Chair November: BJP's AI video pokes fun at Karnataka Congress power struggle

►The sarcastic video shows that both Rahul Gandhi and Siddaramaiah sent a WhatsApp text to DK Shivakumar with a scratch card. Upon scratching the card, he finds that it was written, 'No Chair November', which means no power to him.

Agency New Delhi. The state BJP unit of Karnataka took a satirical jibe at the ruling Congress party over the growing speculation of a power struggle, dubbed as the ‘November Revolution’, between Chief Minister Siddaramaiah and DK Shivakumar. Through an Artificial Intelligence (AI) powered video, posted on the X account, it mocked both the CM and the Deputy CM and Congress leader Rahul Gandhi. Featuring the caricatures of all three, the video starts by showing that both Gandhi and Siddaramaiah share a WhatsApp text to Shivakumar. As soon as the latter opens the chat, he finds a scratch card. As he scratches, he finds that he has received a ‘No Chair November’ reward, which means that he will not become the Chief Minister as part of the power-sharing process. While Shivakumar gets surprised, the video shows that both Gandhi and Siddaramaiah are laughing after playing the prank on him. It

further continues with a husky dancing on the screen. Sharing the video, the Karnataka BJP wrote on X, “It is 'No Chair November' for @DKShivakumar.” The jibe referred to the growing speculation over a change in power dynamics in the party. When the party came to power in the 2023 assembly polls, it was thought that both Siddaramaiah and DK Shivakumar would share the Chief Minister’s seat for two-and-a-half years. However, with



time, Siddaramaiah started asserting himself as the full-time (five-year) Chief Minister. Following his claims, many key leaders in Congress found themselves in a confusing situation regarding the potential change in the chief minister’s role. Senior minister Dinesh Gundu Rao and Krishna Byre Gowda met the party high command in Delhi on November 7 and asked for clarity on the developments. They were reportedly told to remain calm over the possible developments by the high command. The speculations are, however, intensifying with time, as many think that a change in the Chief Ministerial position, along with a reshuffle in the cabinet, will occur in the state. The term ‘November Revolution’ has also been coined, highlighting these possibilities. However, Shivakumar has played down all these speculations over the power-sharing tussle. On multiple occasions, he said that the Congress Party is united in the state and there is no need for people.

Car swerves to avoid hitting pig, crashes into tree; three killed in Kerala

Agency New Delhi. Three people died and three were severely injured in a car accident in Kerala. According to sources, six friends were returning to Palakkad from Chittoor when their car lost control, hit a tree on the roadside, and overturned into a nearby field, which led to the loss of lives and injuries. The incident took place at 11 pm last night, when a pig suddenly came in front of the car. To avoid hitting the pig, the car swerved, lost control, immediately hit a roadside tree, and fell onto the ground below. It was severely damaged. Following the incident, the locals rushed to the spot and saw that all six of them were trapped inside the car. The police and the fire brigade came soon, and the rescue operations began quickly. All six of them were taken out of the car and were immediately sent to the nearby hospital. Upon reaching the hospital, the doctors declared three dead. The deceased are identified as Rohan (24), Rohan Santosh (22), and Sanush (19). The injured three, Adithyan (23), Rishi (24), and Jithin (21), are going through further treatment.

National Zoological Park reopens for visitors after two-month closure

The National Zoological Park (NZP) on Saturday welcomed over 8,000 visitors on its first day of reopening after being closed for more than two months following an outbreak of avian influenza. The zoo also introduced an all-new “Insta Ticket Booking Service” for the convenience of visitors, an official statement said. According to zoo officials, a total of 8,065 people, including 954 schoolchildren from 12 schools, visited the zoo — marking a lively restart for one of capital’s most popular weekend destinations. “Marking this special day, the NZP introduced an all-new ‘Insta Ticket Booking Service’ for visitors. This



service is an additional facility alongside the regular online booking option available through the zoo’s website,” the Director of the National Zoological Park said in the statement. With the new system, visitors can simply scan a QR code displayed at the entry gate and book tickets instantly. The payment process is quick and userfriendly — visitors can pay using any UPI app or through debit cards, credit cards, or net banking. The system has been developed to ensure a timesaving, seamless, and hassle-free entry experience. Many guests availed of this facility on the first day and expressed satisfaction with new service, the Director added. The reopening followed health clearance from authorities and confirmation that all recent bird flu tests had returned negative. The zoo had been shut since August 30 as a precautionary measure after several waterbirds, including painted storks and black-headed ibis, were found dead in the aviary.

Tamil Nadu doctor detained in Russia, wife alleges torture, seeks Centre's help

Agency New Delhi. What was supposed to be an interesting trip to Russia turned out to be an ordeal for a doctor hailing from Tamil Nadu’s Tiruvallur district after he was allegedly detained by Russian authorities in Sochi in September this year. Dr K Jagadeeswaran's wife appealed to Central and state governments to intervene and help her in getting her husband extradited back to India safely. Detailing the ordeal Jagadeeswaran went through in Russia, his wife Yamini told PTI, that he was tortured and humiliated in the custody for the reason unknown to them, and his health condition has deteriorated. Though he has been released now from custody he lacked documents required to travel to Moscow so that he can return to India. She said that Jagadeeswaran got a degree



in medicine from an Armenian University in 2022 and they have been living in Armenia since then. The couple has a baby girl and wanted to visit their families in Tamil Nadu in August this year, she said. “Since my husband is employed by a hospital in Armenia we were living there from 2022. It has been three years after our marriage. We just wanted to visit our families in Tamil Nadu and arrived here in August. I am from Chennai while Jagadeeswaran hails

from Tiruvallur. During our visit, my husband's friend Shekhar Manikandan requested Jagadeeswaran to accompany him for Russia as he is able to converse well in Russian language.” she told PTI in a brief interaction on Sunday. His friend is running an educational consultancy in Russia and wanted Jagadeeswaran to accompany him under the tourist visa, she said. “They left on September 15 (from Chennai) and the ordeal started after they reached the Sochi airport,” she said. They were taken for interrogation by the immigration authorities from the airport, she said. Seeing my husband's passport and other documents and after coming to know that Jagadeeswaran can converse well in Russian, the immigration authorities detained him along with his friend at the Sochi airport on September 16, she said.

VP C P Radhakrishnan lauds Jainism for ahimsa, promoting vegetarianism

Vice President C P Radhakrishnan attended the ceremonial conclusion of 180-day fast of Jain monk Acharya Hansratna Surishwarji Maharaj at Vigyan Bhavan on Saturday and spoke about the contribution made by Jainism to the philosophy of non-violence and the Tamil culture. Acharya Hansratna Surishwarji Maharaj is a revered Jain monk, who is known for observing strict spiritual discipline and long-term ascetic practices. The ceremony, known as the Mahaparna, marked the end of the fast— called Upvas Parna in the Jain tradition. The monk had undertaken the fast for the eighth time, reflecting his devotion, discipline, and commitment to spreading the principles of Jainism and moral values.



said that its teachings rest on four pillars of ahimsa (non-violence), satya (truth), aparigraha (non-possessiveness), and anekantavada (the multiple approaches to truth), which have left a lasting impact on the world. He noted that Mahatma Gandhi

was driven by the idea of ahimsa during India’s freedom struggle and it continues to inspire global peace movements. The Vice President extolled Jainism for its stress on vegetarianism, compassion toward animals, and sustainable living, which, he said, have become the cornerstone of environmental responsibility globally. Recalling his personal journey, Radhakrishnan said that he adopted vegetarianism 25 years ago after visiting Kashi, observing that it cultivates humility, maturity, and love for all beings. He lauded the government’s efforts, under Prime Minister Narendra Modi, to confer classical language’ status to Prakrit and preserve Jain manuscripts through initiatives such as the Gyan Bharatham Mission.

Would be disastrous: Karnataka's Sharavathy project paused after Centre objects

The Environment Ministry's Forest Advisory Committee said the project involves the felling of more than 15,000 trees, many of which are endemic to the Western Ghats, one of the 34 global biodiversity hotspots.

Agency New Delhi. The Centre has deferred a proposal to divert around 54 hectares of forest land in the ecologically sensitive Western Ghats for the 2,000-megawatt Sharavathy Pumped Storage Hydroelectric Project in Karnataka after members flagged serious ecological concerns and violations of forest laws. According to the minutes of the 11th meeting of the Environment Ministry's Forest Advisory Committee held on October 27, the proposed project area lies within the Sharavathy Valley Lion-Tailed Macaque Sanctuary, which is located in the central regions of the Western Ghats. The committee said the project involves the felling of more

than 15,000 trees, many of which are endemic to the Western Ghats, one of the 34 global biodiversity hotspots. It said the forest tracts fall under "eco-class 1 and eco-class 3" with canopy densities of 0.5 and 0.2. The area has "climax forests of tropical wet evergreen, semi-evergreen and shola grasslands", which are "highly vulnerable and complex ecosystems", which, "if destroyed, cannot be restored to their original state". The minutes said the project site supports Lion-Tailed Macaque, Tiger, Leopard, Sloth Bear, Wild Dogs, King Cobra, Malabar Giant Squirrel and other rare and endemic species.



It referred to a wildlife census that recorded 730 Lion-Tailed Macaques in the Sharavathy Valley Sanctuary and warned that "loss of canopy and habitat would intensify this fragmentation, posing a serious risk to the survival of LTMs". The panel recorded that the

compensatory afforestation site offered by the project proponent will not be able to compensate for the loss of habitat of the Lion-Tailed Macaque and that "wet evergreen forests are complex ecosystems and are quite difficult to replicate". The committee examined the engineering design and said the project involves two reservoirs, tunnels up to 3.2 km long, excavation to depths of up to 500 metres, and drilling and blasting for underground works. It said the area falls in Seismic Zone 3 and that the combination of slope cutting, blasting and heavy monsoon rainfall could aggravate landslide and erosion risks.

AAP slams BJP over delay in opening 1,470-bed Shalimar Bagh hospital

New Delhi. (Agency) The Aam Aadmi Party (AAP) on Saturday accused the Bharatiya Janata Party (BJP) government of neglecting public healthcare by keeping the newly built 1,470-bed government hospital in Shalimar Bagh non-operational. AAP leaders alleged that the facility, constructed during the Arvind Kejriwal government’s tenure, remains unused despite being fully equipped, claiming the decision benefits private hospitals in the area. AAP Delhi State President and former Health Minister Saurabh Bharadwaj said the hospital was meant to provide free and quality treatment to lakhs of residents in North Delhi but has been left idle. Sharing a video of the closed facility on social media, Bharadwaj questioned whether Chief Minister Rekha Gupta’s administration intended to privatise government hospitals. He alleged that shutting down such institutions and reducing free medical services were steps toward promoting private healthcare interests. AAP’s Municipal Councillor from Shalimar Bagh, Jalaj Chaudhary, who visited the hospital site, described it as a “world-class” facility featuring ventilators, ICU beds, and centralised air-conditioning. He claimed that the hospital, located adjacent to Max Hospital, was nearly ready for inauguration under Kejriwal’s government. According to him, the hospital’s non-operational status since the BJP came to power has deprived local residents of essential medical services. Chaudhary further alleged that discussions were underway to hand the hospital over to private operators, comparing the situation to earlier attempts to transfer public healthcare facilities to corporate entities. He also expressed concern that other newly constructed hospitals in Haiderpur and Badli remain closed and that over 100 mohalla clinics have been shut. AAP has demanded that Chief Minister Rekha Gupta visit the hospital and clarify the government’s position on its operational status.

Two men arrested in Odisha for duping Delhi rice trader of Rs 20 Lakh

Agency New Delhi. Two men were arrested from Odisha for allegedly duping a rice trader of Rs 20 lakh in northwest Delhi by posing as representatives of a company using forged documents, police said on Saturday. The accused have been identified as Basudev Swain (35), a resident of Lucknow, and Deepak Kumar (40), a resident of Varanasi, both from Uttar Pradesh, police said. “The complainant, engaged in the rice and food supply business for the past 15 years, alleged that three persons — Deepak Kumar Singh, Basudev Swain, and Amit Kumar Singh — deceitfully posed as officials of a firm and claimed that their company intended to purchase rice for testing purposes and future large-scale procurement,” a police officer said. Based on this assurance, the complainant supplied rice worth around 20 lakh against proper bills. Subsequently, the accused stopped responding and avoided making the payment. Upon verification, it was revealed that none of the accused was associated with the firm and that the documents and seals used were forged, the officer said. During the probe, police traced the accused to Bhubaneswar, Odisha, and arrested them through secret information and technical surveillance. “After extensive technical surveillance and local intelligence inputs, the team conducted raids in Bhubaneswar and arrested both accused,” a police official said. “They confessed to their involvement in the offence and disclosed that they had indulged in such criminal activities to earn easy money,” said Deputy Commissioner of Police (Northwest) Bhisham Singh.

Lionel Messi masterclass powers Inter Miami past Nashville in MLS Cup Playoffs

Inter Miami progressed to the Eastern Conference semifinals of the MLS Cup Playoffs for the first time, defeating Nashville SC 4-0 in Game 3 at Fort Lauderdale on Saturday night. The win marked a milestone for Miami, who had never previously advanced in the MLS Cup Playoffs. Miami's success ensured Nashville SC's elimination in the first round for a third consecutive year, while the Florida club now prepares to face FC Cincinnati in a single-leg semifinal in two weeks.Lionel Messi played a central role in Miami's victory, being directly involved in all four goals. Messi scored twice and registered two assists, continuing a dominant run across the three-match series, where he contributed to all eight of Miami's goals (five goals, three assists). His performance brought his career tally against Nashville to 15 goals, the most he has scored against any MLS opponent. Besides Messi, Tadeo Allende delivered a significant impact in the second half. Allende scored two quick goals in the 73rd and 76th minutes, both assisted by Messi, and also contributed an assist. His goals were the result of coordinated plays, involving a link-up with Jordi Alba for the first and a precise through ball from Messi for the second.The match's momentum was established early. In the 10th minute, Messi capitalised on a misplaced pass from Nashville's Corcoran to score the opener with a low finish. Miami's lead doubled in the 39th minute when Messi added a second following a defensive error by Walker Zimmerman, with Mateo Silvetti providing the assist. Nashville's attempts to recover after halftime were unsuccessful. Their striker, Sam Surridge, had a goal disallowed for a foul on Miami's Maxi Falcon in the second half. Miami maintained control, with Allende's brace effectively sealing the result and ending any hope of a Nashville comeback. Despite the absence of Luis Suarez, who was suspended for this match due to a red card in Game 2, Miami's attack remained potent. Jordi Alba was notably influential .

Richa Ghosh, want to see you captain India one day: Sourav Ganguly

World Cup champion Richa Ghosh was felicitated by the Cricket Association of Bengal (CAB) and the West Bengal government on Saturday, November 8. CAB president Sourav Ganguly lauded the young wicketkeeper-batter, who played a crucial role in India's maiden women's World Cup victory. At the ceremony, where Richa was conferred the Banga Bhushan award, Ganguly expressed his wish to one day address her as the captain of India. The 22-year-old wicketkeeper, who captured attention during the World Cup for her explosive power-hitting, was also appointed Deputy Superintendent of Police (DSP) and presented with a gold chain by the state government. The CAB further rewarded Richa with Rs 34 lakh — Rs 1 lakh for every run she scored in the final. Former BCCI president and CAB chief Sourav Ganguly, who had himself

come heartbreakingly close to a World Cup title in 2003, summed up the emotion of the moment with words that reflected both pride and hope. "Your career has just begun. Women's cricket will grow massively in the next four to six years, and there will be more opportunities. I hope you make the most of them and one day, like Jhulan, we'll stand here and say, 'Richa — India captain.'"You're just 22. You have time on your side. All blessings and heartiest congratulations," Ganguly said.

He praised Richa's ability to perform a demanding role in the batting order during the World Cup. Tasked with accelerating India's scoring rate in the final overs, Richa displayed remarkable composure and execution, particularly in the knockouts and in key group-stage encounters against Pakistan, South Africa, and Australia."The role she plays batting lower down the order is very difficult. You get fewer balls but have to score the most runs," Ganguly said. "People may remember Jemimah's 127 not out or Harmanpreet's 89 in the semifinals, but Richa's strike rate of 130-plus made the difference. What she has done so simply is equal in value to Smriti or Harman."

India defeated South Africa in a tense final on November 2. Richa's crucial 34 helped India post a formidable 298 at the DY Patil Stadium. In the chase, India withstood a spirited innings from Laura Wolvaardt to clinch victory by 52 runs.Shafali Verma was named Player of the Match for her all-round display in the final, while Deepti Sharma earned the Player of the Series award.

Hong Kong Sixes: Another defeat, India finish campaign with 4 losses in a row

India finished their Hong Kong sixes campaign with yet another defeat. The Dinesh Karthik side lost to Sri Lanka in their final match of the invitational tournament. After starting with a win against Pakistan, India lost matches to Kuwait, UAE, Nepal and Sri Lanka.

Captain Stuart Binny, who took over the leadership duties from Dinesh Karthik for the final game, contributed a valiant 25 not out off 9 balls. Ultimately, India fell short by 48 runs, closing out a campaign that never quite took flight.Earlier in the innings, Sri Lanka's openers Samarakoon and Madushanka dominated from the outset, both retiring hurt after identical scores of 52. Cristiano Ronaldo was caught on camera making a sarcastic comment to the referee during Al-Nassr's 3-1 win over Neom in the Saudi Pro League on Saturday. Even in victory, the Portuguese star showed his fierce competitive spirit as his frustration with the officiating briefly took the spotlight.The incident occurred just before the interval, with the score still goalless. Al-Nassr were building a promising counterattack when the referee's whistle abruptly halted play, much to Ronaldo's disbelief. As the players walked towards the tunnel, the 40-year-old confronted the official and delivered an ironic comment that left little doubt about his feelings. The Portugal captain, visibly irritated, gestured in frustration as his teammates guided him towards the dressing room. It was another reminder of Ronaldo's



relentless pursuit of perfection and his unwillingness to accept what he perceives as unfair decisions. If the first half ended in irritation, the second began with intent. Al-Nassr returned sharper and more purposeful. Just three minutes after the restart, former Chelsea midfielder Angelo Gabriel broke the deadlock, slotting home a rebound after Ronaldo's free-kick had been blocked by

the Neom defence. Neom's evening worsened moments later when striker Luciano Rodrguez was sent off following a VAR review for elbowing an opponent, leaving the hosts with ten men. The red card compounded their troubles, particularly after they had already lost former Arsenal striker Alexandre Lacazette to injury in the first half. Ronaldo, who had missed a header earlier in the match, made amends from the penalty spot midway through the second half. His compatriot Luis Maximiano had initially denied him from close range, but Joao Felix chased the rebound and was shoved in the back, earning a spot-kick.The Al-Nassr captain stepped up and converted with typical precision, firing low into the corner to register his 953rd career goal and 83rd in the Saudi Pro League since joining the club in early 2023.

This may restrain sustained FII selling in India. If, along with this realisation, India’s earnings growth continues to improve, FIIs are likely to turn buyers. But this may take time, they noted. “It is important to understand a significant feature of the FII activity this year. FIIs, particularly the hedge funds, are selling in India and buying in other markets which are driven by AI trade,” said Dr. VK Vijayakumar, Chief Investment Strategist, Geojit Investments Ltd. The US, China, South Korea and Taiwan are regarded as AI winners. This perception is hugely influencing the FPI action in the ongoing global rally driven by AI trade, he noted. While October witnessed net FII buying of Rs 3,902 crore, November has started with FIIs turning sellers on every trading day, so far. The net FII sell figure through exchanges in November up to 8th, stood at Rs 13,367 crore. This takes the total FII sell figure for 2025, so far, to a massive Rs 207,568 crore. This largely explains the underperformance of India, relative to other major markets this year, said analysts. Last week, markets ended lower, weighed down by persistent foreign fund outflows, mixed corporate earnings, and cautious global cues. Renewed concerns over the valuation of AI-related stocks triggered profit-taking across major markets, further weighing on risk appetite. “Globally, traders will monitor the performance of AI-related stocks and developments around global trade deals, both of which are expected to influence market sentiment,” said Ajit Mishra–SVP, Research, Religare Broking Ltd.

COP30: Brazil climate conclave shows waning concern

There’s a message in holding the November 6–11 international summit on climate change at Belém, Brazil. The conflagration among nations on the state of the environment, or Conference of Parties (COP30), has been convened at the gateway of the endangered Amazon rainforests, the world’s largest, 5.5 million square kilometres of tropical forests threatened by logging and mining. Unfortunately, Belém is not as exciting as Paris or Egypt’s seaside resort of Sharm El-Sheikh. The conference is seeing a tepid response, with only a few dozen world leaders making the trek to this Latin American outpost. Leading lights from some of the most important and populous nations are absent — India, the US, China and Russia. The Donald Trump-led United States and China are sceptics on climate change goals, while Russia is in the midst of a terrible shooting war. But it is indeed surprising that India, a usually sane voice on environmental issues, has given COP30 low priority this round. There is no denying climate change as a global

cause is losing steam. **Long Shadow on COP30** The environment movement is also facing the long shadow of Trump’s pushback. Though he is not coming to Belém, speaking at the United Nations in September Trump dismissed climate change as “the greatest con job ever perpetrated on the world.” “The entire globalist concept, asking successful industrialised nations to inflict pain on themselves and radically disrupt their entire societies, must be rejected completely and totally,” he added. Growing war clouds in a divisive world have also sidelined environmental goals which require a wide consensus. Currently, Venezuela and Colombia, in South America, are the latest to be caught in the US’ firing line. As Trump ratchets up his demand for regime change with left-wing governments, and bombs ‘narco’ shipping in the Caribbean Sea, the smaller regimes are struggling to survive. Saving the environment is a low

priority. The host nation, Brazil’s President Luiz Inácio Lula da Silva, made no bones about Trump’s ostrich-like stance. Without naming him, he opened the conference on Thursday warning of “extremist forces that fabricate fake news



and are condemning future generations to life on a planet altered forever by global warming.” Colombian President Gustavo Petro went further, denouncing Trump as “100% wrong” for his denial of science that threatens the future of the planet and could lead to a “real apocalypse.” **Funds Drying Up** It is exactly a decade since the nations met at

the Paris Summit, when concerns erupted about global warming and environmental degradation. For the first time, in 2015, a globally binding agreement to fight climate change was signed, requiring nations to set the long-term goal of limiting global warming to 1.5°C compared to pre-industrial levels. It established a system where each country sets its own nationally determined contributions (NDCs) to reduce emissions, to be updated every five years. It also provided a roadmap to achieve net-zero emissions by the second half of the century. Lofty goals indeed! But the have met their Waterloo in the face of stiff resistance by the rich nations. The poor nations have rightly agitated that global warming is a spin-off from the Industrial Revolution, and it is the rich nations who have been the primary polluters. It is the developed world, therefore, that must pay for the clean-up. After much back-and-forth, a deal was reached in 2009 in Copenhagen, where the rich nations agreed to raise \$100 billion by 2020.

India's foreign exchange reserves declined by USD 5.623 billion in the week that ended October 31 to USD 689.733 billion, driven by a slump in both foreign currency assets and gold reserves, the Reserve Bank of India's latest 'Weekly Statistical Supplement' data showed. Over the past month, the forex kitty has been in a downtrend, except for one week. Still, the country's foreign exchange (forex) kitty is hovering close to its all-time high of USD 704.89 billion, reached in September 2024. For the reported week (that ended October 31), India's foreign currency assets (FCA), the largest component of foreign exchange reserves, stood at USD 564.591 billion, down USD 1.957 billion. The RBI data showed that gold reserves currently stand at USD 101.726 billion, down USD 3.810 billion from the previous week. The price of the safe-haven asset gold has been on a sharp uptrend over recent months, perhaps amid heightened global uncertainties and robust investment demand.

After the latest monetary policy review meeting, RBI Governor Sanjay Malhotra had said the foreign exchange reserves were sufficient to cover more than 11 months of merchandise imports. Overall, India's external sector continues to be resilient, and the RBI remains confident of meeting its external obligations comfortably. In 2023, India added around USD 58 billion to its foreign exchange reserves, contrasting with a cumulative decline of USD 71 billion in 2022. In 2024, the reserves rose by a little over USD 20 billion. So far in 2025, the forex kitty has cumulatively increased by about USD 40 billion, data showed. Foreign exchange reserves, or FX reserves, are assets held by a nation's central bank or monetary authority, primarily in reserve currencies such as the US dollar, with smaller portions in the Euro, Japanese Yen, and Pound Sterling. The RBI often intervenes by managing liquidity, including selling dollars, to prevent steep depreciation of the rupee. The RBI strategically buys dollars when the Rupee is strong and sells when it weakens.

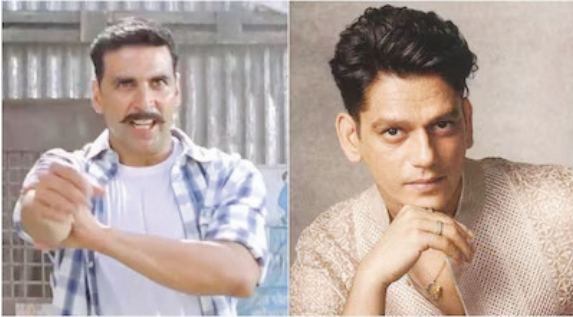

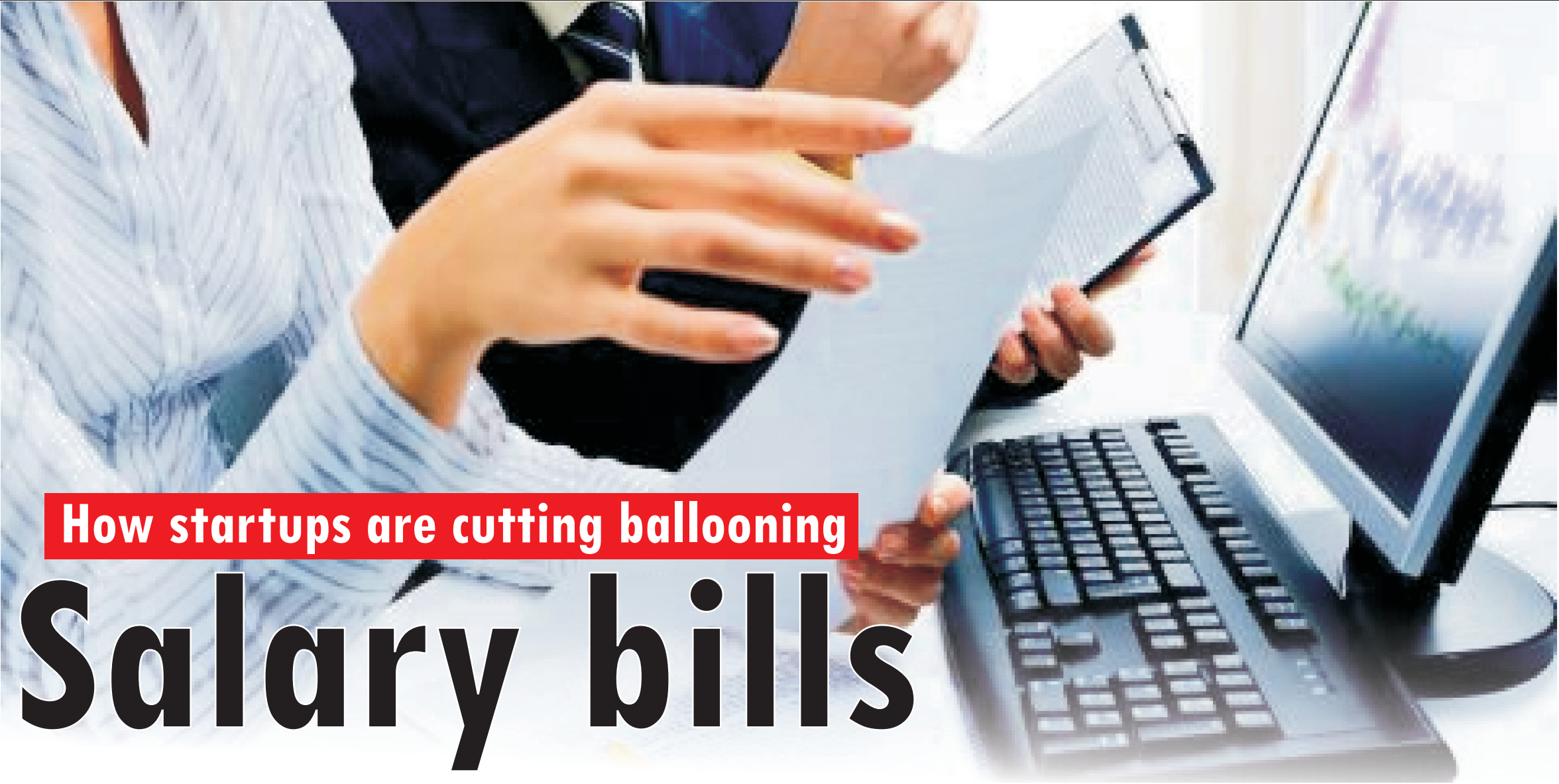

How startups are cutting ballooning

Salary bills

Combination of factors is driving more startups to scout for talent from tier-II B schools and engineering colleges at lower salaries. HiveMinds, a startup in social media, has chosen to approach tier-II B schools as it finds itself low on the priority list of the top-notch ones. "The top B-schools fix slots for bluechip companies in the first few days and they get the cream of students. Startups like ours, which cannot offer a hefty remuneration, get slotted on the last day and get the remaining ones," said CEO of HiveMinds MS Shan.

The limited fund flow into startups is one of the reasons for the hunt shifting to the non-IIM category of B-Schools. Vinod M, CEO, Cloudcherry said due to healthy funding or the promise of it last year, companies were more enthusiastic about recruiting from top B-schools at higher pay. "The funding sentiment has cooled down now and only heavily-funded startups would go on to recruit in top B-Schools," he said. Vinod said divergence, a skill required in startups, may not necessarily be available in Tier-1 schools. Going to the Tier-II B-Schools has clearly

given him a wider choice of options. They offer more scope for interaction at a pace that helps recruiters analyse and take a more measured decision. "Such options are not available with Tier-1 schools where we are pressured to make a decision fast," said Shan. PSG College of Management, Coimbatore had four new startups hiring students this time around. "Technology startups such as Zoho and Kaar Technologies looking for managerial positions have turned to us," said the institute's placement director Umesh C. Startups find graduates from engineering

colleges like VIT and SRM take risks and work for lower salaries than graduates from top B-schools demand. "We prefer to hire from B-Schools such as NMIMS or engineering colleges," education startup ChalkStreet CEO Venkat V said. B-Schools have reported a surge in recruitment from startups. Management Development Institute from Gurgaon has had 57% more startups visiting them compared to last year. Students too were keen in getting placed in them with 15 of the 17 offers getting accepted. "The

'Startup India Stand Up India' campaign will act as a catalyst in the ecosystem providing huge growth opportunity for students," said Kanwal Kapil, chairperson, placements from MDI. For internships too, startups are gaining more currency, said students of Mumbai-based B-School KJ Somaiya Institute of Management Studies and Research. "We are more open to taking risk which is reflected in the drive to take up a job in a startup than in a secure environment of a MNC or an Indian corporate," second-year student anil kumar said.

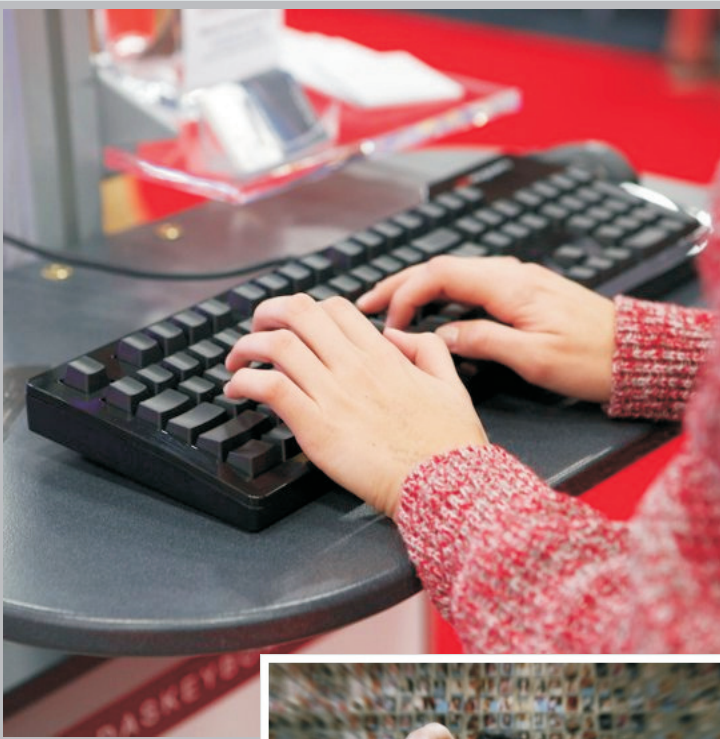
Wait for approval

The home row keys are as follows: • Left index finger on the letter F. • Left middle finger on the letter D. • Left ring finger on the letter S. • Left pinkie on the letter A. • Right index finger on the letter J. • Right middle finger on the letter K. • Right ring finger on the letter L.

• Right pinkie finger on the colon/semicolon (; and :) key. • Left and right thumbs should rest on the space bar. 4. Try and practice some simple typing exercises like: • Start with the home keys: asdf <space> jkl; • Then, type the home keys in capital letters, using the shift key: ASDF <space> JKL; • Now come to the bottom letters and type the bottom row: zxcvbnm,. • Next, skip over to the top row: qwertyuiop • Without looking at the keyboard try writing the complete alphabet. 5. Learn touch typing (typing without looking at the keyboard)

It's a difficult skill to execute at first but touch typing is generally the fastest way to type once you've mastered it. So start slowly and try to type without looking at the keyboard. Build up your speed gradually and try to stick with it even if you find it difficult initially. 6. Practice, practice and practice Well, there are no shortcuts to practice and the more you perform the better and faster you'll get.
