Delhi on high alert after explosion in car near Red Fort kills 8: What we know so far

According to sources, a high alert has been sounded across the national capital. This development comes a day after a massive terror module with nearly 2,900 kg of bomb-making material was busted.

Eight people died, and 24 others were injured after explosion in car near Gate No. 1 of Delhi's Red Fort (Lal Qila) Metro Station on Monday evening. The car went up on flames and several other nearby cars were



also gutted. After the blast, the national capital has been put on high alert. According to eyewitnesses, the intensity

of the blast was so powerful that the street lights in the vicinity went off. According to the Delhi Fire Department, a call about the explosion

was received around 6:55 pm, after which seven fire tenders and 15 CAT ambulances were rushed to the spot. The fire spread to other nearby vehicles, five to six of which were gutted before firefighters managed to bring the blaze under control.

According to sources, a high alert has been sounded across the national capital. This development comes a day after a massive terror module with nearly 2,900 kg of bomb-making material was busted.

Mumbai Police are taking precautionary measures, like increased patrolling and checks at vital locations after blast reported in Delhi. Multiple casualties have been brought to the LNJ hospital due to the blast near Gate No 1 of Red Fort Metro Station, sources tell ANI.

Senior officers, including the DCP of the Special Cell, have reached the site to supervise the investigation.

Delhi court postpones framing of charges against Lalu Yadav in land-for-job scam

A Delhi court on Monday deferred pronouncement of its order to December 4 on framing of charges in the alleged land-for-job case involving RJD chief and former Railway Minister Lalu Prasad Yadav, his family members, and several others. Special CBI Judge Vishal Gagne was hearing the case filed by the agency against Lalu Yadav and others over their alleged involvement in the case. The matter will now be taken up on December 4, when the court is expected to pronounce its decision on whether there is sufficient evidence to frame charges.

The Central Bureau of Investigation (CBI) has filed chargesheets against Lalu Yadav, his wife and former Bihar chief minister Rabri Devi, their son Tejashwi Yadav and others in connection with the alleged scam. The prosecution has alleged appointments in Group-D category of West Central Zone of the Railways based in Jabalpur, Madhya Pradesh, made during Lalu Yadav's tenure as railway minister from 2004 to 2009, in return for land parcels gifted or transferred by the recruits in the name of the RJD supremo's family or associates. The court had earlier reserved its order on whether to frame charges against the accused after hearing extensive arguments from the prosecution, represented by Special Public Prosecutor DP Singh, and the defence counsel.

The CBI has alleged that the appointments were made in violation of norms and that the transactions involved benami properties, amounting to criminal misconduct and conspiracy.

Delhi CM Slams Opposition for False Promises and Misleading Propaganda

For the upcoming by-elections to the Delhi Municipal Corporation, Bharatiya Janata Party (BJP) candidates filed their nomination papers today in the presence of Delhi Chief Minister Rekha Gupta. Tamil Nadu Deputy Chief Minister Udhayanidhi Stalin has made a veiled attack on actor-politician Vijay, saying that some people have entered politics without ideology or a strong foundation.

Speaking at the Platinum Jubilee celebration of DMK, Stalin said, "Ideology is the foundation of DMK. If the foundation is strong, then the fort built on it will also remain strong. Today, some are trying to enter politics without any foundation," he said in an apparent dig at Vijay, who heads the Tamilaga Vettri Kazhagam (TVK). In a sarcastic tone, he compared Vijay and TVK to exhibition replicas of the Taj Mahal and the Eiffel Tower.

"When we go to exhibitions, we see replica models of the Taj Mahal and Eiffel Tower. People get excited, take selfies, and feel thrilled. But those are just made of cardboard without any foundation or ideology. A slight touch or wind is enough," he said. He further emphasised that the DMK was

built through sacrifice and struggle, recalling that the party and its leaders had even faced the Emergency.

TVK hit back, questioning Stalin's political journey. "Udhayanidhi Stalin says DMK was built through sacrifice and struggle. But what is his role in that movement?"



What protests has he faced? What sacrifices has he made? On what basis was he given the youth wing post and ticket to contest elections?" TVK's Loyola Mani wrote on X. "Tell us what qualifications you have beyond being the grandson of former Chief Minister."

How Ajit Pawar's son's firm bought Rs 1,800-crore land without paying stamp duty

A controversial land deal in Pune's Mundhwa involving Maharashtra Deputy CM Ajit Pawar's son, Parth Pawar, has sparked a political storm.

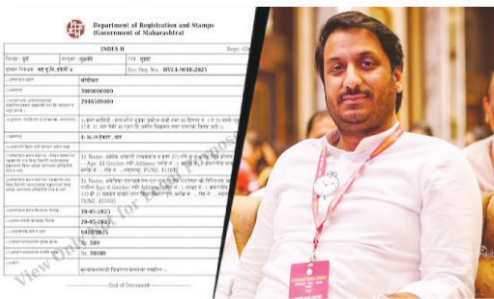

A land deal controversy involving the son of Maharashtra Deputy Chief Minister Ajit Pawar has triggered a political storm in the state amid allegations of fraudulent acquisition, undervaluation, and misuse of political influence. The Opposition has alleged that government-owned land was sold to a company linked to the NCP leader's son Parth Pawar at a heavily undervalued rate, with irregularities in stamp duty payment and exemption. The controversy centres on a 40-acre plot in Pune's Mundhwa area, which the Opposition claims has a market value of around Rs 1,800 crore. However, the sale deed was allegedly executed for just Rs 300 crore.

A m a d e a Enterprises LLP, the firm linked to Parth Pawar, is also accused of seeking and obtaining a stamp duty waiver of Rs 21 crore citing plans to establish a data centre on the land, which never happened.

HOW THE DEAL UNFOLDED

According to documents accessed by India Today, Amadea Enterprises LLP, a company with a declared capital of just 1 lakh, allegedly acquired the land worth Rs 1,800 crore for Rs 300 crore without making any upfront payment. The sale deed, executed between Amadea Enterprises and Parth's associate and power of attorney holder, Sheetal Tejwani, was registered in what sources describe as a "rare instance of absolute trust". It reportedly contained no details of payment terms, proof of receipt, or schedule of instalments, all of which are mandatory in property transactions under Maharashtra law.



UP CM Adityanath slams SP MP for opposing 'Vande Mataram'; says such 'divisive voices create new Jinnahs'

Invoking All-India Muslim League leaders Mohammad Ali Jinnah and Mohammad Ali Jauhar, Uttar Pradesh Chief Minister Yogi Adityanath on Monday said that those who oppose the national song "Vande Mataram" are insulting India's unity and integrity. "Even today, we expect everyone living in India to be loyal to the nation and work for its unity," he said while participating in 'Ekta Yatra' (Unity March) and collective singing of "Vande Mataram" in Gorakhpur. He said when events were organised to mark the 150th anniversary of "Vande Mataram", the same voices of opposition resurfaced.

"A Samajwadi Party MP again protested against the national song. These are the same people who skip the birth anniversary of Sardar Vallabhbhai Patel, the architect of India's integrity, but shamelessly attend events honouring Jinnah," Adityanath said.

He asked if the country fails to honour its national heroes, where will it go? The extremism, Naxalism, and terrorism that constantly challenge India's unity and integrity are fuelled by those who insult national icons and revolutionaries, the chief minister said. Such actions embolden separatist forces that threaten the country's



national identity, he added. "It is now our duty to identify and oppose all elements that divide society, whether in the name of caste, region, or language. These divisions are part of a conspiracy to create new Jinnahs," he said. Jinnah served as the leader of the

All-India Muslim League from 1913 until the inception of Pakistan on 14 August 1947. He then became Pakistan's first governor-general until his death a year later in 1948.

Jauhar was the co-founder of the All-India Muslim League. He urged people to ensure that no new Jinnah ever arises in India again, and if anyone dares to challenge the nation's integrity, "we must bury such divisive intent before it can take root." The chief minister said every citizen of India must stand united for this cause.

Adityanath said there is no justification for opposing "Vande Mataram".

CM Siddaramaiah says will serve full term, looks at DK Shivakumar, changes tone

Chief Minister Siddaramaiah's public remarks on Sunday again stirred speculation of a possible change in leadership in the state government. At a public event in Kudligi to inaugurate various development projects, Siddaramaiah initially asserted that he will "continue as chief minister", reaffirming his intention to serve the full term. But moments later, after glancing towards Deputy Chief Minister DK Shivakumar and media, he noticeably shifted his phrasing referring instead to "our government" rather than his individual role.

The subtle change in tone drew attention amid rumours of differences within Congress over leadership change. Both Siddaramaiah and Shivakumar have



publicly denied any plans for a change, insisting that the government remains "stable and united".

Political observers noted the timing of his comments and their potential implications for both state politics and Congress' image ahead of upcoming elections. At the event,

Siddaramaiah launched a sharp attack on BJP, alleging that the party continued its practice of "vote chori" in the Bihar elections, undermining the democratic process. He said Union Minister Pralhad Joshi has betrayed sugarcane farmers, as both the FRP and MSP are determined by the BJP-led Centre. "It was Joshi and Centre that deceived our sugarcane farmers," he charged.

He said BJP state president Vijayendra, instead of questioning his own party's betrayal, is trying to cover it up by staging protest dramas in Belagavi. "Though the Central government failed our farmers, the state government stepped in to provide additional financial support and protect our sugarcane growers."

Two attack family over land dispute, arrested

Gurgaon.(Agency)
Two men were arrested for allegedly attacking a family with sticks and an axe over a land dispute in Sohna on Nov 7. According to police, the incident took place on November 7 when the complainant and his family were working in their fields. A group of men — identified as Om Bir, Omdev, Pawan, Shiv Kumar, Raj Kumar, Mangal, and Sonu — allegedly attacked them, leaving several members injured. Following an inquiry, an FIR was registered at Sadar Sohna police station under relevant sections of the Bharatiya Nyaya Sanhita (BNS). Omdev and Raj Kumar, both residents of Abhaypur village, were arrested on Saturday. Police said that the accused's forefathers purchased the disputed land from the complainant's ancestors around 60 years ago. However, a mismatch between the land number and the actual plot handed over led to a prolonged legal dispute, which the accused recently lost in court. The attack, police said, was an act of revenge linked to the ongoing enmity between the families. Further investigation is ongoing.

Commuters raise safety fears over high-tension towers on key Gurgaon road

As winter approaches and fog is expected to reduce visibility, residents of sectors 102 and 102A have expressed concern over high-tension electricity towers standing in the middle of the 60 metre master road that connects Dwarka Expressway with Upper Dwarka Expressway. The structure, they say, not only endangers commuters but also obstructs traffic flow. "These high-tension lines are dangerous, especially during winter when low visibility and smog make it difficult for drivers to see the towers in time," said Kamal Malhotra, a resident of Adani Oyster Grande. He added that the presence of the towers could lead to accidents and also cause damage to the newly laid road surface. Residents said that due to limited space, vehicles are forced to navigate around the towers, which increases the likelihood of collisions. Several residents' associations have written to the authorities multiple times, requesting the relocation of the towers and power lines. Despite this, they said, no progress has been made since GMDA began redevelopment work on the stretch about a year ago.

Sunil Sareen, vice-president of Imperial Gardens RWA, said the issue has been pending for a long time despite repeated complaints. "The tower stands right in the middle of the carriageway. It should have been shifted long ago, but the issue seems to have been ignored. We have requested DCP (traffic) to look into the matter before any accident occurs," he said.

Meanwhile, GMDA officials said the metropolitan authority has written to Haryana Vidyut Prasaran Nigam Limited (HVPNL), requesting the shifting of the existing high-tension line that falls within the alignment of the sector 102-102A master road. The authority has asked that the work be taken up on priority to ensure commuter safety.

Watch out: Not properly covered, manholes are a gaping risk in Sector 46

Manholes with broken lids or makeshift cement covers on walkways and near parks in Sector 46's A Block have become a safety hazard for the children and the elderly. The tiles around the frames are broken, making the manholes jut out about a foot above the ground level. Over 3,000 residents of the block live in fear of accidents. According to residents, these manholes have been left unattended for a long time. The broken tiles around the manholes pose a risk of tripping over them and falling.



Sanjay Kumar Awana, general secretary of the Sector 46 Block A RWA, on Wednesday, wrote a petition to Noida Authority CEO highlighting the dire state of these manholes. He said that despite sending multiple reminders to local officials, including photographs documenting the issue, no action has been taken in the past three weeks. "I fear that if this issue is not addressed promptly, it may lead to a serious accident," Awana told. Awana added that the children play on the walkways around these hazardous manholes. This has added to the anxiety of the sector's residents. The conditions are not limited only to Block A. Block B, which houses an additional 250 triple-storey homes with over 2,000 residents, shares similar safety hazards. Community outrage continues to mount as residents demand immediate action from the Noida Authority and local officials. With winter vacations approaching, families worry about the safety of children who play in the area. Awana has requested the Noida Authority CEO to direct appropriate measures for the repair and replacement of the manhole covers and has emphasised the need for timely communication from local officials regarding this pressing issue. A response from the Authority is awaited on the matter.

Haryana DGP takes aim at Thar. But can behaviour be linked to a car?

Time and again, studies have explored the connection between vehicle types and personality types. However, seldom has a brand and its drivers been singled out the way Haryana's director-general of police, OP Singh, did this weekend when he criticised the Mahindra Thar. "The choice of car shows the mindset of a person," Singh said in Gurgaon on Saturday. Linking the SUV's drivers to road stunts and accidents, he added, "Whoever has a Thar, his mind would not be in its right place. Thar is not a car. It is a statement." People do make statements with a purchase. In that sense, Singh is right. But that is true across the spectrum of brands. Sure, one could be making a statement with a car, but one could be doing so with a watch, a dress, a pair of shoes, a handbag, or a perfume as well. "Even the iPhone is used to convey a pseudo sense of status. Perceptions get

attached to brands, especially those that catch popular imagination or command aspirational value," says Dr Sanjeev Bansal, Additional pro vice-Chancellor and dean of Faculty of Management Studies at Amity University. "And people associated with these brands get judged through them." Tahseen Haider, who heads administration at a private company, says this judgment of Thar owners, voiced by the DGP, has been fed by displays of machismo by people driving Thar on social media, which in turn has made road rage incidents involving the SUV more noticeable. Haider, who bought a red Thar four years ago, says, "It's now become one of those stereotypes. If you are driving a Thar, you are someone to whom traffic laws don't apply, you drive as you like, and you are a bully. Social media simply reinforces those stereotypes. Some



people driving may derive a sense of power from it, but they don't speak for all." SUVs worldwide, more so high-performance brands perceived as more masculine than others, have been the subject of driver behaviour studies for years, both in Europe and the US. In India, several SUVs before Thar have had this perception of unruly driving stuck to them, like Tata Sumo and the now withdrawn Toyota Qualis. But can rash driving or the tendency to break rules be linked to particular vehicles?

Likely not. For example, a 2023 UK govt study found 44% of cars broke speed limits in free-flowing traffic. This was not specific to a vehicle type. Besides, psychological factors have a connection with rash or dangerous driving. A 2023 Israeli study inferred drivers' more hostile behaviour was related to higher levels of state-trait anxiety among drivers.

In Delhi-NCR, where road rage incidents are still alarmingly frequent, perpetrators have been seen to drive all sorts of vehicles, sometimes even two-wheelers. "Am I wary of every SUV or Thar that I see while driving? No. I do sometimes get worried if I'm driving with my wife and daughter late at night and there's a car right behind us or a car is doing something funny, like overtaking and braking. Cops must crack down on that sort of behaviour to make our roads safe," says a Gurgaon-based consultant.

Businessman held by ATS over hawala funding, search on for Turkish aide

A Greater Noida businessman has been arrested for allegedly producing hate literature and using over Rs 11 crore in foreign funds transferred to him through illegal channels into buying land in various states. Police are looking for his Turkish partner, who helped him set up his frontline business. Farhan Nabi Siddiqui, co-director of Istanbul International Pvt Ltd, was arrested from Kasna on Saturday by UP anti-terrorist squad (ATS). "Siddiqui is accused of publishing inflammatory books aimed at spreading religious enmity and receiving large sums through hawala channels. We are searching for his Turkish associate, Nasi Torba," an ATS official said.

According to officials, investigation revealed that Siddiqui and his associates operated several companies, including M/s Hakikat Vakfi Foundation and M/s Real Global Express Logistic Pvt Ltd, which served as fronts for publishing and distributing material designed to provoke communal disharmony. Their printing unit, Hakikat Printing Publication in Kasna, was allegedly used to produce books in Hindi, Urdu, Arabic, and Bangla for distribution across the country. Officials said the literature promoted anti-Indian sentiment and targeted democratic institutions, fuelling communal discord.

ATS officials said the network received around Rs 11 crore from foreign sources — primarily Turkey and Germany — using hawala and other illicit routes. These funds were allegedly channelled into purchasing land in Amroha in UP and Punjab in the names of madrassas, mosques, and private firms. There are also allegations that land was bought in Bangladesh and Pakistan using these funds. The accounts of Siddiqui's relatives, including his brother and father, as well as some retired Army officers, are under scrutiny for alleged involvement in the funding and propaganda network.

Met factors help, Gurgaon's air quality better as Delhi chokes on smoke

While Delhi, Noida and Ghaziabad remain trapped under a thick smog layer with "very poor" air quality, the city has so far stayed relatively better off. On Sunday, CPCB data showed Delhi's average AQI at 370, Noida at 366 and Ghaziabad at 345, all in the 'very poor' range. The city's average AQI, meanwhile, was 238, in the 'poor' category. Officials at India Meteorological Department (IMD) said the city's position on the southwestern edge of the national capital region gives it a temporary meteorological advantage. An IMD scientist said, "Surface winds have been northwesterly for the past few days, which means smoke and pollutants from Punjab and Haryana are being transported mainly towards central and eastern Delhi first. Gurgaon stays on the cleaner edge of the air mass, at least in the first half of the day."

He added that clear skies and stronger daytime winds over the Aravalis allow faster dispersion of pollutants, while Delhi's flat terrain traps them once temperatures drop. "Delhi sits in a sort of bowl that holds pollution. By evening, when the inversion layer forms, pollutants can't rise and get trapped near the surface. Gurgaon benefits marginally because of its open terrain, but this advantage will fade as the inversion strengthens," the scientist explained. However, the reliability of these comparisons is far from certain. For much of Oct, several air quality monitoring stations across Gurgaon and other NCR cities remained non-functional or partially operational. Experts say that raises doubts over how authentic the current data really are. "How authentic these data are is itself debatable," Centre for Science and Environment research associate

Shubhansh Tiwari said. "If a large share of Continuous Ambient Air Quality Monitoring Stations (CAAQMS) were offline till late Oct, it's unclear whether instruments have been recalibrated or if their readings are consistent. Without regular calibration, even a few misreporting stations can skew the city's average AQI," Tiwari added. The data gap between Delhi and Gurgaon further complicates the picture. Delhi currently has 38 active monitoring stations spread across its districts, covering various land-use zones. Gurgaon, in contrast, has only five, including one at Manesar, which on Saturday recorded an AQI of 270 ('poor' range). With such a limited network, large residential and industrial areas in Gurgaon go unmonitored, leaving significant blind spots in the city's pollution map. Centre for Research on Energy and Clean Air (CREA).

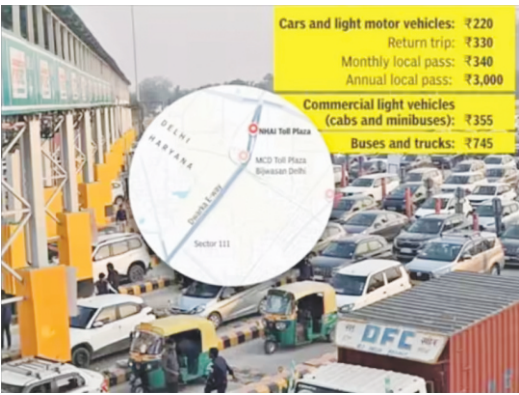
Tech glitches, lack of clarity take a toll on Dwarka Expressway commuters

A wave of confusion and frustration swept through Bijwasan toll plaza on Dwarka Expressway on Sunday after National Highways Authority of India (NHAI) abruptly began collecting tolls without prior notice.

Even on what was typically a lean-traffic day, chaos reigned at the newly operational plaza — with motorists trapped in long queues, making frantic U-turns, arguing with staff, and scrambling for information about new passes and charges. The disarray forced NHAI to announce a temporary three-day relief for local private car users, reserving three lanes on each side of the plaza for residents to pass without paying any fee.

For many, trouble began the moment they approached the toll gate, only to be told they would need to pay or produce a valid pass. "Had NHAI given a couple of days'

notice, people could have obtained local passes or opted for FASTag annual passes.



You only find out about the toll when you reach the gate. The govt should have anticipated these problems, especially since tolling is happening for the first time on this corridor," said Anil Kumar, a commuter. The confusion was

compounded by a lack of clarity on eligibility for local passes, technical glitches in the Rajmarg Yatra app, and the sudden need for documentation that many residents living in sectors off the expressway did not have at hand.

"I bought the annual pass this morning. The amount was deducted, but the pass hasn't been activated yet. The customer care team cited a server issue and said they couldn't help. It's disappointing to see such poor implementation from authorities. Residents living along Dwarka Expressway should be given fair concession or at least a smoother pass system.

Else, this will only add to the growing frustration among taxpayers," said Atul Napal, a resident of M3M Woodshire, who had to pay Rs 220 despite buying the annual pass.

Gurgaon teen battles for life after classmate shoots at him in condo flat

A 17-year-old boy is battling for life in hospital after being shot at by his classmate in a flat in Sector 48 around Saturday midnight — an attack that is likely to have been triggered by an altercation between the two students in school a couple of months ago.

The accused student has been detained along with a friend. All three teenagers are Class 11 students at an English medium school in the city.

According to police, the accused student — son of a property dealer — used his father's licensed pistol to fire at his classmate. Cops said they were trying to find out how he sneaked the loaded gun out of home without his family even realising it.

It was little past midnight that the police control room received an emergency call about a boy being shot at in a flat in Central

Park society. "A team from Sadar police station responded to the call and reached the location. But by the time cops arrived, the injured teenager had already been rushed to Medanta Hospital by his family," a police official said.

Doctors at Medanta described the boy's condition as critical, saying they were making every effort to save his life.

Investigators, including forensic experts and fingerprint specialists, searched the scene of crime — a vacant flat that the accused student's father had set aside to put on rent. They recovered a pistol, a magazine, five live cartridges, and one spent shell from the room where the shooting took place. A further search led to the discovery of another magazine and 65 live cartridges stored inside a box.

According to a written complaint by the victim's mother — a

homemaker — his son received a phone call earlier in the evening, where one of his friends urged him to come out and meet.

When the boy initially refused, the friend insisted and offered to pick him up on his bike. The victim eventually agreed and went to Kherki Daula toll plaza, where he met the accused and another friend. Together, they headed for the vacant flat in Central Park.

Preliminary questioning revealed that about two months ago, the victim and the main accused had a heated argument in front of others in school, which may have fuelled lingering resentment and ultimately led to the attack. "We are trying to find out more about the motive," an official said.

An FIR was registered under Section 109 (attempt to murder) of BNS and relevant

provisions of the Arms Act against the two students. "An investigation has been initiated.

Apart from the motive, we will also need to find out how the teenager managed to access the firearm. The father could also face legal consequences for negligence in storing the weapon," the police official said.

While the victim's mother is a homemaker, his father passed away three years ago. Haryana Police chief OP Singh described the incident as "extremely unfortunate". "Praying to God that there is no loss of life.

I have instructed the ACP and CP to alert arms license holders in their areas about such threats. Arrange for necessary training for them to handle weapons properly. The generation that plays video games doesn't even know that shooting is not

a game. Parents and schools should teach children skills.

NGT seeks states' response on tree protection framework

The Sikh Times

New Delhi: The National Green Tribunal (NGT) has directed states and Union Territories to review and submit their responses within four weeks to the Central Pollution Control Board's (CPCB) final report on strengthening tree protection and conservation frameworks. The CPCB, in its final report dated May 21, recommended that states and Union Territories without a legal framework for tree protection should establish one, while those with existing laws should align them with the objectives of the National Forest Policy, 1988. The report emphasised the need for robust enforcement mechanisms, the use of modern technologies for monitoring, and adequate staffing and resources for effective implementation. According to the report, "States and UTs not having a legal framework at present for promoting the growth of trees and enabling protection should take up the process of

establishing the required legal framework." It further suggested that, "States/UTs with the existing legal

efforts by integrating applicable advisories into their existing frameworks." The CPCB also advised that tree man-



framework may align with the broader objectives of national forest conservation

agement in non-forest areas should be governed by clear guidelines, including

authorization for felling, preservation of heritage trees, and preparation of plantation augmentation plans. It proposed that Tree Authorities should include representatives from government departments, urban planners, ecologists, arborists, legal experts, NGOs, and community members for "a holistic approach to tree management." The Ministry of Environment, Forest and Climate Change (MoEF&CC) has been asked to provide policy guidance, capacity-building support, and financial assistance under schemes such as the Green India Mission. The Tribunal directed that all respondents must also submit their views on the conduct of a tree census, including proposed modalities for its implementation, particularly in major urban local bodies (ULBs). The Bench noted that these measures were aimed at ensuring better coordination between central and state agencies and promoting effective monitoring of tree conservation across the country.

Woman's headless body: Cops yet to make any breakthrough

New Delhi: A day after a headless body of a woman with severed palms was found in a drain near the Sector 82 Cut in Noida, the police on Friday intensified their search to identify the deceased. They are also resorting to forensic examination and scanning CCTV footages to get lead in the case. Additional Deputy Commissioner of Police (ADCP) Sumit Shukla said three teams had been formed to identify the woman. They were awaiting the post-mortem report to determine the exact cause of death. Another official said it seems the woman was murdered around 24-30 hours ago and her body was dumped in the drain. The official said her palms might have been severed to hide her identification mark such as tattoos. However, the motive behind beheading her could only be established after a thorough investigation. A passer-by contacted the emergency helpline after spotting the body in an eight-foot-deep drain in a remote location near a high-rise residential building and Sector 108 park. As per the preliminary investigation, the woman appears to be around 30 years old and is married. Data from nearby police stations regarding missing complaints is being analysed and her photographs have also been circulated to get any clue about her identity, the police official added. The official said all possible angles, including personal enmity, sexual assault, illicit affair, honor killing, were being examined. However, the exact motive could only be ascertained after the completion of investigation.

Massive fire breaks out in Delhi slum near Rithala metro station; 1 dead

New Delhi: Police personnel and others gather as firemen try to douse a fire breaking out in a cluster of huts near Rithala metro station at Rohini area in New Delhi early Saturday. A man died and another sustained burn injuries after a massive fire broke out spreading to around 500 shanties near Rithala metro station in Delhi's Rohini, the Delhi Fire Services (DFS) said. Police said several LPG cylinders were said to have exploded late Friday evening, intensifying the blaze and triggering panic among residents. Thick plumes of smoke were seen rising from the area even as locals scrambled to save their belongings and move to safer places. Preliminary information suggests that 400 to 500 huts have been gutted, fire officials said.

MC to set up 4 new waste processing plants to end landfill crisis: Mayor

New Delhi: The Municipal Corporation of Delhi (MCD) is set to establish four new municipal solid waste (MSW) processing facilities across the city as part of its mission to eliminate Delhi's massive landfill sites and ensure 100 per cent scientific waste disposal, Mayor Raja Iqbal Singh announced on Tuesday. The new facilities, to be developed at Bhalswa (1,800 TPD), Singhola (700 TPD), Okhla (1,400 TPD) and Narela-Bawana (1,200 TPD), will collectively process 5,100 tonnes of waste per day (TPD). The total cost for setting up these plants is estimated at Rs 361.42 crore. According to the mayor, tenders have already been invited and the plants are expected to become operational within six months. "These new facilities will ensure no fresh waste is dumped at the existing landfill sites,"

the Mayor said, adding that the MCD is working

Okhla. "The goal is to make Delhi clean, healthy,



"on a war footing" to remediate and eliminate the city's three dumpsites — Bhalswa, Ghazipur, and

and pollution-free within the stipulated timeframe," he said. Currently, Delhi generates about 11,500

metric tonnes of municipal solid waste per day. The MCD operates four waste-to-energy (WTE) plants, at Narela-Bawana (1,300 TPD), Okhla (1,550 TPD), Tehkhand (2,000 TPD) and Ghazipur (1,300 TPD), with a combined processing capacity of 6,550 TPD. Despite these efforts, nearly 4,700 tonnes of waste continue to be dumped daily at the city's three major landfill sites. Since 2019, the MCD has been carrying out biomining of legacy waste to reclaim land at the dumpsites. So

far, 25 acres have been reclaimed at Bhalswa and 10 acres at Okhla, while 7.2 acres have been cleared at Singhola. An additional 10 acres of land is available waste-to-energy (WTE) plants, at Narela-Bawana (1,300 TPD), Okhla (1,550 TPD), Tehkhand (2,000 TPD) and Ghazipur (1,300 TPD), with a combined processing capacity of 6,550 TPD. Despite these efforts, nearly 4,700 tonnes of waste continue to be dumped daily at the city's three major landfill sites. Since 2019, the MCD has

been carrying at the Integrated MSW Processing Facility in Narela-Bawana for future development. Further, Mayor Singh said that senior MCD officials, including the Chairman of the Standing Committee, the Leader of the House and the Deputy Mayor, were conducting regular inspections of landfill sites to monitor progress. Councillors and sanitation teams are also surveying garbage-vulnerable points in their respective wards to strengthen waste management at the local level.

Texas man kills 3 co-workers at workplace, then shoots himself

A 21-year-old man shot and killed three co-workers at a San Antonio, Texas, landscape supply company and then died after shooting himself, authorities said Sunday. Two men and a woman died in the shooting Saturday at the business on the city’s north side, according to the San Antonio Police Department. Other employees ran from the scene when the gunfire erupted around 8 am, KSAT-TV reported. Police responded and secured the area, and hours later they found the gunman with a self-inflicted gunshot wound, officials said. He was identified by police as Jose Hernandez Galo. While the motive for the shooting wasn’t immediately known, Police Chief William McManus said during a Saturday news conference that it was not random. Detectives continued to investigate on Sunday.

7 dead, 13 rescued after boat carrying migrants from Myanmar capsizes off Malaysia

Rescuers in Malaysia recovered the bodies of seven migrants from Myanmar and found 13 alive from a boat that capsized with dozens aboard, officials said Sunday. The vessel had departed from the town of Buthidaung, in Myanmar’s Rakhine state, carrying some 300 people, said First Adm. Romli Mustafa from the Malaysian Maritime Enforcement Agency, citing a preliminary investigation. Police and the maritime agency said the passengers were believed to have been split into three smaller boats once the vessel neared Malaysia. One of the boats was believed to have sank near Tarutao island in southern Thailand on Thursday, and some of the victims drifted into Malaysia’s northern resort island of Langkawi, the authorities said. The timing and exact location of the incident is not known. The fate of the other two boats is also unclear, officials said. Local media quoted the Kedah state police chief in northern Malaysia, Adzli Abu Shah, as saying that some of those rescued were Rohingya Muslims, from Myanmar, where they have faced persecution for decades. Romli warned in a statement that cross-border syndicates are becoming increasingly active in exploiting migrants using perilous sea routes. The maritime agency said rescuers found 10 migrants and recovered the body of a woman from the sea on Saturday. Another six bodies were discovered Sunday as well as three survivors, it said, adding it has expanded the area of the search that will continue on Monday. The UN High Commissioner for Refugees urged regional governments to step up search and rescue efforts and take action to prevent such tragedies. So far this year, some 5,200 Rohingya refugees have embarked on dangerous maritime journeys, with nearly 600 reported to be missing or dead, said UNHCR spokesman Diogo Alcantara.

Trump doubles down on Obamacare as federal shutdown drags into 40th day

US President Donald Trump doubled down on Sunday on his push to gut Obamacare healthcare subsidies, which his Democratic opponents have insisted on preserving as a condition for ending the 40-day government shutdown. Trump on Saturday urged Republican senators to take federal money used to subsidise health insurance bought on Affordable Care Act marketplaces, and instead send payments to individuals buying coverage. The federal government has been shut down since October 1, making it the longest federal shutdown ever, because of a congressional impasse over healthcare. The ACA subsidies, which helped double Obamacare enrolment to 24 million since they were put in place in 2021, are at the heart of the shutdown. Democrats want to extend them before reopening the government, while Republicans say they are open to addressing the issue only after government funding is restored. Trump took to his Truth Social platform on Sunday to blast the subsidies as a “windfall for Health Insurance Companies, and a DISASTER for the American people,” while repeating his call for funds to be sent directly to individuals to buy coverage on their own. “I stand ready to work with both Parties to solve this problem once the Government is open,” Trump wrote. This weekend’s posts from Trump came as senators were deep in talks over ways to end the shutdown. But Treasury Secretary Scott Bessent and Senator Lindsey Graham, a staunch Trump ally, said in separate interviews that Trump’s healthcare idea will not be introduced before lawmakers pass a federal funding measure. “We’re not proposing it to the Senate right now,” Bessent said in an interview with ABC’s “This Week,” referring to Trump’s proposed direct payments. “We are not going to negotiate with the Democrats until they reopen the government.”

US Senate advances bill to end 40-day shutdown, Democrats call it betrayal

On Sunday night, the Senate voted 60-40 on the key procedural measure following an agreement between a group of moderate Democrats, Republican leaders, and the White House to advance the plan, even without a guaranteed extension of health care subsidies - a decision that has sparked a rift among some Democrats.

The US Senate has moved to advance a crucial measure aimed at ending the 40-day government shutdown, the longest in the country’s history, that has sidelined workers, delayed food aid, and disrupted air travel. On Sunday night, the Senate voted 60-40 on the key procedural measure following an agreement between a group of moderate Democrats, Republican leaders, and the White House to advance the plan,

even without a guaranteed extension of health care subsidies -- a decision that has sparked a rift among some Democrats. The deal was negotiated by New Hampshire Democrats Senators Maggie Hassan and Jeanne Shaheen, along with Maine Independent Angus King. Senate Minority Leader Chuck Schumer, the top Democrat in the chamber, voted against the measure. The key measure will prevent federal agencies from laying off employees until January 30, 2026, and would halt President Donald Trump’s effort to reduce the federal workforce. At the start of Trump’s second term, about 2.2 million civilians worked for the federal government, with at least 300,000 expected to leave by year-end due to his downsizing plan. The measure would also provide back pay for all federal employees, including military personnel, Border Patrol agents, and air-traffic controllers. The measure will now go

through additional procedural steps before being sent to the President for approval. Republican leaders have planned to amend



the bill to include a full-year funding package, agreed upon with moderate Democrats, while offering temporary government funding through January 2026. The Senate will hold more procedural votes, which could be delayed by members opposing the deal. Once these are cleared, the bill will move to the House for approval before reaching the President for final

signing. **HEALTHCARE SUBSIDIES’ DISCONTENT**
After more than two hours of discussions, Senate Minority Leader Chuck Schumer said he could not “in good faith” support the proposal. Schumer, who faced criticism from Democrats in March for voting to keep the government open, said the party has now “sounded the alarm” on healthcare. “We will not give up the fight,” he added. Independent Senator Bernie Sanders called giving up the fight a “horrific mistake,” while Democrat Chris Murphy noted that last week’s elections showed voters want Democrats to hold firm. The debate in Congress comes as President Trump again pushed to replace Affordable Care Act (ACA) subsidies with direct payments to individuals. These subsidies, credited with doubling ACA enrolment to 24 million since 2021, are a key point.

US air travel meltdown: 2,700 flights cancelled, 10,000 delayed; here's why

Thousands of passengers were left stranded across the United States on Sunday as airlines cancelled more than 2,700 flights and delayed over 10,000, the worst day of air travel disruption since the federal government shutdown began. The chaos has laid bare why America’s aviation network is faltering, as unpaid air traffic controllers call in sick, radar centres run thin on staff, and major airlines struggle under government-mandated flight cuts. **WHERE AND WHEN THE CHAOS HIT HARDEST**
The cancellations swept through the nation’s biggest air hubs, Atlanta, Chicago, Charlotte and Newark, snarling travel plans coast to coast. Flight-tracking site FlightAware reported over 1,000 cancellations on Friday, 1,500 on Saturday, and

Sunday’s record-breaking figures have already forced airlines to preemptively axe flights for the coming week. Delta Air Lines was hit the hardest, with disruptions affecting more than half its mainline flights on



Sunday. “It’s the worst I’ve seen in years,” a traveller stranded in Miami en route to the Dominican Republic, Emmy Holguin, was quoted as saying by AP. “We all have somewhere to be. I’m just hoping the government fixes this

soon.” **WHY ARE FLIGHTS BEING GROUNDED?**
The Federal Aviation Administration (FAA) has ordered airlines to reduce commercial flights by 4% across 40 major airports, with cuts expected to deepen to 10% by Friday if the shutdown continues. Transportation Secretary Sean Duffy warned more drastic measures could follow as air traffic controllers, now working six-day weeks without pay, increasingly call in sick or look for other jobs. The National Air Traffic Controllers Association said it has delivered 1,600 handwritten letters to Congress urging an end to the shutdown, citing “unsustainable pressure” on exhausted staff who are keeping the skies safe on borrowed time.

Watch: Trump booed by NFL fans during historic appearance at Commanders-Lions game

Loud boos rang out across Washington’s Northwest Stadium after US President Donald Trump appeared on the giant screen during Sunday’s NFL game between the Commanders and the Detroit Lions -- marking the first time in nearly half a century that a sitting president has attended a regular-season fixture. Trump, standing in a private suite alongside House Speaker Mike Johnson, was shown on the stadium’s big screen late in the first half. The crowd erupted into a mix of cheers and jeers, though the boos appeared to dominate. The reaction grew louder when the announcer formally introduced the US President at halftime.

During the break, Trump participated in an enlistment ceremony for new military recruits, reading aloud the oath of service as the audience noise



continued. “I’m a little bit late,” Trump told reporters earlier after landing at Joint Base Andrews, referring to his delayed arrival following a brief

flyover above the stadium. “We’re gonna have a good game. Things are going along very well. The country’s doing well. The Democrats have to open it up,” he added. Before Trump’s arrival, Lions receiver Amon-Ra St. Brown celebrated a touchdown by mimicking the “Trump dance.” Later, during the third quarter, Trump joined Fox Sports commentators Kenny Albert and Jonathan Vilma for a casual eight-minute on-air conversation. When asked about his high school football days at the New York Military Academy, Trump replied, “I played tight end, but it was not quite football like this. It was a little bit easier. It wasn’t so tough.”

Why President Murmu's Angola visit matters for India's Africa policy

India’s diplomatic engagement with Africa received a significant boost as President Droupadi Murmu embarked on a four-day state visit to Angola, marking the first-ever visit by an Indian President to the country. The trip comes at an important moment, with Angola celebrating 50 years of independence and India and Angola set to complete 40 years of formal diplomatic ties in 2025. The visit highlights New Delhi’s renewed focus on Africa as a strategic partner, particularly in energy, defence, technology, agriculture, and skills development. During the talks between President Murmu and Angolan President Joo Loureno, the emphasis was on expanding cooperation across key sectors. India sees Angola as a vital partner for its energy security, with Angola already supplying a substantial share of India’s crude oil imports. President Murmu underlined this relationship and conveyed India’s interest

in securing a long-term energy purchase agreement with Angola. In addition, Indian companies are exploring opportunities to invest in onshore and offshore oil exploration and refinery modernisation projects within Angola. The discussions also touched upon the expanding global focus on critical minerals. Angola possesses reserves of minerals that are central to manufacturing renewable energy technologies, electric vehicles, and electronics, areas that are integral to India’s energy transition goals. President Murmu emphasised that Indian companies were also interested in collaborating on exploration, processing, and value addition of such minerals, along with investment in fertiliser production and diamond processing. Given Angola’s place as one of the world’s major producers of diamonds and India’s global leadership in diamond cutting and polishing, both countries see a clear opportunity for



mutually beneficial cooperation. A number of Memorandums of Understanding (MoUs) were exchanged during the visit, including those related to fisheries, aquaculture, and marine resources. The two leaders also discussed intensifying collaboration in technology, agriculture, healthcare, defence, infrastructure, and people-to-people exchanges. President Murmu welcomed Angola’s decision to join the International Big Cat Alliance (IBCA) and the Global Biofuel Alliance (GBA), signalling shared

commitment to environmental sustainability and conservation. President Murmu also highlighted India’s advancements in rail technology, pointing to the Vande Bharat high-speed trains as an example. She conveyed India’s willingness to collaborate with Angola in modern railway development and skill-building initiatives for the youth. Both India and Angola have young populations, and skill development was recognised as a crucial area for future cooperation. Defence cooperation also featured prominently in the discussions. India is in the process of finalising a \$200 million Line of Credit to support Angola in strengthening its defence capacity. This follows Prime Minister Narendra Modi’s announcement earlier this year. India has also been providing military training support to African countries, including Angola and Botswana, and expressed willingness to deepen capacity-building programmes further.

Russian helicopter snaps in two before crashing in Dagestan, 5 killed

At least five people were killed when a Russian Ka-226 helicopter carrying senior staff from a defence-linked aviation company crashed near the village of Achi-Su in the Republic of Dagestan on Friday, according to officials and state media reports. The aircraft was operated by the Kizlyar Electromechanical Plant (KEMZ), a key supplier of systems used in Russian military aircraft. The helicopter was flying from Kizlyar to Izberbash when it caught fire mid-flight and attempted an emergency landing, the Russian media reported. Witnesses told local media that the pilot tried to bring the aircraft down on a nearby beach along the Caspian Sea, but it crashed into the yard of a private house in the Karabudakhkent district. Footage shared on social media showed the helicopter’s tail breaking off before it plunged into the ground. The pilot briefly managed to lift the aircraft over shallow waters before losing control completely. The impact triggered a fire that spread over roughly 80 square metres before being extinguished by emergency responders. The residential building was unoccupied at the time. “All three passengers and the pilot were pulled from the wreckage but later died from their injuries,” Dagestan’s Health Minister Yaroslav Glazov confirmed. Two other individuals were hospitalised, one of them in critical condition. **VICTIMS WERE DEFENCE INDUSTRY OFFICIALS**
The victims included senior personnel from KEMZ -- among them the company’s deputy general director, chief engineer, and chief designer, along with the helicopter’s flight mechanic, according to Russian media reports. Initial reports from state outlets suggested the helicopter was carrying tourists, but KEMZ later confirmed that its employees were on board. The helicopter, registered as RA-19307, has been classified as a “disaster” by Russia’s Federal Air Transport Agency (Rosaviatsia), which has launched a formal investigation into the cause of the crash. KEMZ, based in Dagestan, plays a crucial role in Russia’s defence production. The plant manufactures ground control, diagnostic, and suspension systems for Sukhoi and MiG fighter jets, including units used to deploy precision-guided missiles such as the Kh-29 and X-31. The company has been under US sanctions for supplying components and technologies used in Russia’s military operations against Ukraine.

Newly-married man charred to death after car hits median in Tiruvapur

TIRUVAPUR. (Agency)
A 28-year-old man here driving back from his in-laws' residence was charred to death after his car went up in flames during the early hours of Sunday, the police said. The deceased was identified as A Mohammed Rafiq of Tiruvapur. Rafiq, who was running shops in Vijayapuram of Tiruvapur, was early on Sunday returning from his in-laws' residence at Ammapattinam in Pudukkottai



district after visiting his wife whom he had married a few months ago. While driving on the Tiruthuraiipoondi bypass road, he suddenly lost control of the car, causing it to hit the median. The vehicle then fell into the nearby field and caught fire, the police said. Passersby informed the Tiruthuraiipoondi fire station and the police following which fire and rescue services personnel doused the flames. They, however, managed to only retrieve Rafiq's charred body. The Tiruthuraiipoondi town police sent the body to the Tiruthuraiipoondi government hospital for post-mortem and registered a case.

Village relocation for tiger introduction done sans public meeting: Satkosia Praja Surakhya Samiti

BHUBANESWAR. (Agency)
The Satkosia Praja Surakhya Samiti has claimed that no gram sabha or public meeting has been held yet with the residents of Satkosia Wildlife Sanctuary by the Forest department for introduction of tigers in the landscape. Referring to the statistics of voluntary relocation of villages in Satkosia, samiti president Nabakishore Bisoi pointed out that no gram sabha has been held in Katrang, Tulka and Bhurkundi. He said, out of 674 families relocated during 2017 and 2023, gram sabha was conducted only in Raigoda and Asanabahal villages. "There has been no gram sabha in Katrang, Tulka and Bhurkundi. Hence, it is not proper to mention that these three villages have been voluntarily relocated," Bisoi added. He said this has already been challenged by the villages in the court of law for which the compensation package amount allotted to the beneficiaries in these villages can be considered to have been distributed illegally. "Without gram sabha or household survey, how could the Forest department conclude how many families.

Eggs vanish from midday meal menu in Hyderabad as prices soar

HYDERABAD. (Agency)
A financial crunch has taken eggs off the plates of government school students in Hyderabad for over a month. The staple item in the midday meal scheme has gone missing as the supplying agency struggles with soaring prices and unpaid dues running into crores. According to officials and sources, the state government pays the supplier Rs 2.5 per egg, while the market price has climbed to about Rs 6. Unable to bear the loss, the agency — which has been requesting a price revision for years — halted supply from mid-October, after the Dasara holidays. The state owes the midday meal agency around Rs 4 crore for August, September and October, besides Rs 13 crore pending under the breakfast scheme introduced by the previous BRS government in 2023. The breakfast initiative, which included cooking and other costs, was discontinued, but payments remain unsettled.

Meals in government and aided schools are provided by Manna Trust, an NGO working in partnership with the state government. Teachers said the non-supply of eggs was depriving students of vital nutrition. As per the schedule, eggs are to be served on Mondays, Wednesdays and Saturdays, with bananas as substitutes on other days. However, neither has been served in recent weeks. "Not serving eggs to students will affect their health, as they already lack access to quality food. We have sent several representations, but there has been no response," said Ahmed Khan, in-charge headmaster of a government school in Charminar. Ravinder, headmaster of another government school in Nallakunta, echoed the concern, adding that the agency cited rising prices and non-payment of dues for halting supply. A representative of the supplying agency, speaking on condition of anonymity, said, "The government pays Rs 2.50 per egg, but the market price is '6. It is not possible for us to continue bearing the loss. Though the government recently revised midday meal costs, eggs were not included in that revision."

Mitigate human-animal conflict to save lives: DyCM Pawan Kalyan

CHITTOOR. (Agency)
Deputy Chief Minister (Environment and Forest) K Pawan Kalyan inaugurated the Kumki Elephant Training Camp at Muslimadugu in Palamaner mandal of Chittoor district on Sunday. Speaking on the occasion, he directed forest officials to implement measures in a time-bound manner to mitigate human-wildlife conflict in the State. Making a PowerPoint presentation on the HANUMAN (Human-Animal Conflict Mitigation) programme, Anantapur Conservator of Forest Yeshodabhai explained the initiatives taken to prevent elephant and leopard attacks, and reduce the monkey menace in human habitations. The initiatives include tracking elephant herds using radio frequency tags, GPS, and thermal drone cameras, and formation of animal rescue teams across the State. Volunteers will also be trained in catching snakes and monkeys in urban areas. Emphasis has also been laid on protection of people living in forest fringe areas. The Deputy Chief Minister has convened a meeting in Vijayawada on November 18 to finalise the strategy to mitigate human-wildlife conflict. Earlier, the Deputy CM inspected the Kumki elephants, observed their daily



routine, and witnessed a parade of five trained elephants. He also fed the elephants, and recorded videos on his phone. Solar-powered hanging fence to deter entry of wild tuskers The 20-acre Kumki camp, set up with four trained elephants brought from Karnataka, is the first of its kind in Andhra Pradesh. Under the ecotourism project, visitors will be

allowed to spend time at the camp to learn about elephant behaviour. The facility will also serve as a base for rapid-response teams to monitor the movement of wild elephants, and prevent attacks on agricultural crops. Pawan Kalyan laid the foundation stone for the Gajaramam Urban Forest Park, and launched a solar-powered hanging fence to prevent elephant intrusions.

Egg prices in Namakkal rise after months of slump; driven by winter demand, export pickup

NAMAKKAL. (Agency)
After months of subdued rates, farmgate egg prices in Namakkal — the hub of India's poultry production — have begun to show a steady upward trend. The rise follows a long spell of weak demand and falling prices during the monsoon months and festival season.

According to trade data from the National Egg Coordination Committee (NECC), Namakkal zone, the price of an egg had touched Rs 5.75 on July 9, before beginning a sharp slide through the rest of the month,



dropping to Rs 4.25 by July

31. The decline was attributed to reduced consumption during the 'Sawan' month and festivals such as 'Nag Panchami' and 'Janmashtami'. Though prices began to pick up gradually in the following months, they remained under Rs 5.50 until early November. In recent weeks, the rate has risen again, to Rs 5.65 as of November 9, signalling renewed market activity and improving demand. C Sasikumar, a poultry farmer from Namakkal, said the current rise is typical of the winter season when egg consumption increases.

"Usually, prices improve during this time as people prefer eggs in colder weather. Exports are also gradually picking up," he said. He added that the market is still below last year's levels. "In early November 2024, the rate was around Rs 5.85. This year, it's slightly lower, but we expect it to touch Rs 6 soon. Demand has gone up by nearly 6-7%, and if feed costs remain stable, prices will continue to rise," he said. Traders say that with steady consumption and improving export orders, the current upward trend is likely to continue.

Over Rs 100 crore may change hands before polling begins in Jubilee Hills

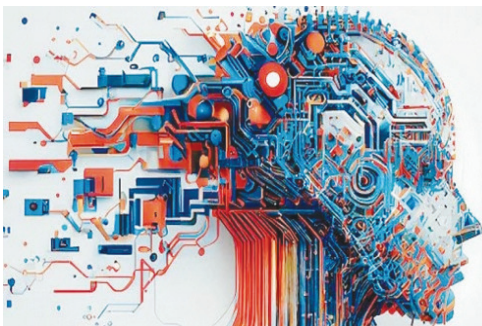

The campaign for the Jubilee Hills Assembly byelection concluded on Sunday, paving the way for last-ditch efforts to sway voters through various inducements. The next 48 hours will pose a major challenge for political parties in micro-managing electors. Political analysts do not rule out the possibility of parties going to any extent to influence voters. Sources claim that between Rs 100 crore and Rs 120 crore may change hands till the polling process begins on Tuesday — an exercise euphemistically termed "poll engineering". The main parties are focusing on voter mobilisation in bastis and slums, which form a major vote bank in the constituency. With 4.01 lakh voters, the segment has recorded around 47 per cent turnout in the last two Assembly polls. This time,

parties are pulling out all stops to boost polling percentage with reports indicating that they are spending up to Rs 2,000 per vote. The main parties have appointed booth-level in-charges, each responsible for managing 50 voters. These in-charges are tasked with coordinating voter transportation via autos and other vehicles to maximise turnout in their favour. Second-rung leaders are reportedly concentrating on persuading voters from rival camps and reaching out to apartment communities, where gifts are allegedly being distributed to woo urban electors. The parties are believed to have assigned special teams in the constituency to distribute money to their selected vote banks. The activity is expected to continue late into the night and might go on until 8 am on polling day.

Karnataka to get AI-enabled complaint generation system soon

Have you ever struggled to write a complaint letter to government authorities on water supply, power connection, bad roads or even government schemes? Come December, writing such letters to any government department would be easy. The Centre for e-Governance Karnataka is developing an Artificial Intelligence-Enabled Grievance Redressal System where one needs to provide only the basic information and the system generates the letter and sends it to the authorities concerned. A complainant can also just give oral instructions and utter a few key

words for the system to write the letter. It will be available in both Kannada and English. The system is still "work under



progress". However, there is an integrated Public Grievance Redressal System (iPGRS) that has been functioning since 2021

Andhra Pradesh government initiates LiDAR survey of Godavari canal system



RAJAMAHENDRAVARAM. (Agency)
The State government has initiated a comprehensive LiDAR (Light Detection and Ranging) survey to assess the condition of the vital Godavari delta irrigation system, and Sir Arthur Cotton Barrage at Dowleswaram. A sum of '13.42 crore has been sanctioned for the conduct of the aerial survey using a specialised aircraft. An agency for the survey project has already been finalised. Irrigation experts have finalised the survey methodology and logistics, Sir Arthur Cotton Barrage Superintending Engineer K Gopinath told.

The Godavari delta irrigation system, which is the lifeline of the erstwhile twin Godavari districts, has deteriorated significantly over the years. The Godavari canals supply irrigation water to nearly 10 lakh acres of agricultural land in Kharif and Rabi seasons, besides providing drinking water to over 1.2 crore people in the Godavari districts. The Godavari delta system includes 788 km length of major canals, 4,578 km minor canals, 761 km drainage canals, 814 km intermediate drains, and 2,650 km minor drains. The LiDAR survey will help map the Godavari delta, including canals, embankments and encroachments with high precision. This will enable the Water Resources Department to plan Godavari delta modernisation works scientifically. The entire exercise is likely to be completed in six to nine months. Once completed, the LiDAR survey will provide the State with scientific data for future irrigation planning, ensuring efficient water management for growth.

Man, beast and bureaucracy inside Mysuru's escalating tiger war

The clang of a school bell echoes through Hale Heggudilu, but not many students returned to their houses. Instead, children gathered in small clusters outside the school gate, watching a convoy of jeeps, police vans and private cars snaking into their village. The sight of white SUVs with beacon lights and khaki-clad men was unusual in this remote forest fringe village of Saragur taluk. At the centre of the crowd lay the small house of Danda Nayaka alias Chowda Nayaka, a 48-year-old farmer and labourer who had been mauled to death by a tiger only hours earlier. As politicians, forest officers arrived to console the family, the village stood with murmurs of disbelief. "Come home before dark," parents called out. By the time Nayaka's body was taken for postmortem, the narrow lanes of Hale Heggudilu had fallen silent. Not a single villager dared to step out. This is not a scene at this particular village. Dread now stalks every village along the edge of Saragur taluk -- from Badagalapura to Bennegere, Kurnegala to

Mullur. As dusk falls, doors are bolted, fields abandoned. **When fear becomes routine** The people of Saragur, once accustomed to living alongside wildlife, now live in terror. Four tiger attacks in 20 days have turned the region into a zone of panic. There is also fear of leopards and elephants entering the village. We have always seen elephants and even tigers from afar," said Mahadevaiah, a resident of Hale Heggudilu. "But they never attacked humans. Now, three men have been killed within 20 days. We have stopped going to our fields at night," he said. This wave of attacks has exposed more than just human fear; it has laid bare the deep cracks in the state's wildlife governance, political interference and conservation ethics. **Chain of deaths** The blood trail began on October 16, when Madegowda (48) of Badagalapura was mauled by a tiger. He survived, but remains under treatment in Mysuru. Ten days later,

on October 26, Rajashekar, a farmer from Bennegere, was killed near Mullur. On October 31, Doddanangaiah (65) of Kurnegala was attacked while grazing cattle. And finally, on November 7, came



Danda Nayaka's death in Hale Heggudilu. When Nayaka's oxen returned home, the yoke ropes still tied to their necks, his wife Rukmini sensed something was wrong. She rushed to the field with neighbours, only to find blood on the soil. A gruesome trail led them to a pit where Nayaka's body lay, partly eaten. Ironically, he had survived an elephant attack a few months ago. This

time, fate didn't spare him. In the aftermath of all these attacks, the Karnataka forest department launched combing operations and a tiger-capture drive that experts describe as a panic operation. Within 20 days, five tigers including cubs, were caught but no one is sure if they are the ones responsible for the killings in the region. Two cubs, separated from their mother during one such operation, have been shifted from Bennegere village to Bannerghatta Rescue and rehabilitation centre. Another one-and-a-half year old female tiger cub was rescued at Hosavindu village on November 5, while an eight-year-old tigress was captured on October 28 at Anjanapura village. In the latest operation, another tiger was captured on the night of November 8 -- a 10-12 year-old male tiger, which forest officials say is behind all these killings, but this can be confirmed only through various modes and guidelines set by the National Tiger Conservation Authority (NTCA).

Seven sins of pseudo-spirituality

When police entered the Peoples Temple settlement in Jonestown, Guyana, on November 19, 1978, a chilling sight awaited them— 909 dead bodies lay scattered across the compound. They all drank cyanide-laced Kool-Aid at the command of their leader, Jim Jones.

These were not the bodies of ‘gullible fools,’ but of people like us seeking meaning in life and a connection to something greater. The Jonestown tragedy illustrates how blind faith can kill hundreds in minutes, not just by cyanide, but due to their unexamined certainty. Though extreme, the Jonestown tragedy mirrors pseudo-spiritual sins that still mislead many today. Interestingly, the word sin originally meant not evil, but simply ‘missing the mark’. Pseudo-spiritual sins work the same way—not evil in themselves, but misguided efforts that erode freedom, clarity, and purpose. Here are seven such sins and the red flags to recognise them before they derail your journey.

1. Outsourcing Spiritual Growth

Just as no one can lift weights to build your muscles, no one can meditate, evolve, or transform for you. Your life is a garden only you can tend—sowing the seeds and clearing the weeds. True teachers foster independence; false ones breed dependence.

Red flag: Beware of look-at-me gurus who draw attention to their self-advertised greatness and promise to do your spiritual work. Authentic look-at-yourself teachers redirect your focus to your own attitudes, choices, and responsibilities.

2. Failing to Discern Noise from Signal

Our growth falters when we confuse noise with signal. Signals are practices that genuinely transform us—daily meditation, quiet reflection, small acts of kindness. Noise is what distracts—selfies with gurus, endless debates, or back-to-back retreats without application. If it doesn’t foster health, character, or purpose, it is gossip, not growth.

Red Flag: Beware fads and gurus who rely on catchy slogans, rituals, emotionally charged stories, or clever metaphors instead of offering evidence-based tools for growth.

3. Seeking Shields Against Misfortunes

No spiritual leader, however revered, can shield you from life’s storms. Tragedies strike gurus, their families, and followers alike. The universe won’t bend to our beliefs or wishful thinking. True spirituality doesn’t erase pain; it builds resilience to face it. The Buddha said, “Pain is inevitable; suffering is optional.”

Red flag: Be wary of teachers who peddle fear of hell, doomsday, and miserable rebirths, or promise immunity from misfortune. These are traps.

4. Confusing Popularity with Truth

Popularity doesn’t equate to factual or moral truth; millions once believed the sun orbited a flat earth and endorsed slavery. Test someone’s teachings and practices with reason and evidence, and the visible transformation in followers’ lives, not crowd size or hype. Red flag: Question your belief in gurus flaunting celebrity endorsements or massive following to prove their legitimacy. Truth needs no spotlight.

5. Expecting Omniscience, Grace, or Miracles

If anyone were truly all-knowing, pandemics would be prevented, diseases cured, and crimes solved—and we wouldn’t need scientists, doctors or detectives. Yet, suffering persists. Why would an omniscient person allow it, unless the claim is hollow or the claimant indifferent? Imagine a doctor saying, “I can cure you, but I won’t interfere with your karma.” Excuses such as “non-interference with cosmic law” only admit that such powers are of no practical use.

Singing our souls awake

Looking at upbeat faith trends like ‘bhajan clubbing’, I mourn that I belong to the cheated urban generation that was denied Sanskrit. Swamped by proud atheists, my low-maintenance faith became “the love that dare not speak its name” with time

A new trend is reportedly rocking young India called ‘bhajan clubbing’, in which Gen Z gathers in various spaces for sessions of singing and dancing to remixed devotional songs. Chai and buttermilk are to hand, not the liquor served in Western-style pubs and clubs. There are diyas, candles, incense sticks, and flowers to create a pleasant atmosphere. The young dress up, or don’t, depending on the occasion, clap along, and sing to guitars and drums. The music is modern, but the words are old, including mahamantras like ‘Hare Rama, Hare Rama’.

If we look, we’ll see that this movement was growing organically, with important contributions to the ‘vibe’ from singers like Shankar Mahadevan, Kailash Kher, Jubin Nautiyal, and a score more. The happy-clappy satsang and naamkirtan culture already in place was made more modern. The electric atmosphere during festivals like Navratri, Mahashivratri, and Janmashtami at temples, garba grounds, and in popular ashrams also fostered this development. Purists may cavil, but doesn’t it sound perfectly natural for a singing, dancing nation? The young have found their own, blessedly free expression of belief, blending fun and faith. I welcome this trend with all my heart and wish it had happened in my youth. It would have been grounding, energising, and expressive of the Ananda or joy, which is the driving principle of this upbeat faith. I would not have been conditioned to be a ‘coconut’—brown outside and white inside. I mourn that I belong to the cheated urban generation that was denied Sanskrit. I was taught French instead. No learning is wasted, true, but our access to and understanding of our heritage should not have been removed either. I am very thankful that the two terrible fault lines in our culture—caste and gender—are being repaired. I regret that along the way, they ‘threw the baby out with the bathwater’.

This brings back a question I was pointedly asked when I began writing about religion over twenty-five years ago, thanks to the newspaper editors who took a wild chance on me. Prior to that, growing up had been complicated. My mother, the believer, was long dead, my father was basically irreligious, and I was swamped by proud atheists. They were decent people, bright and well-spoken, whose one blind spot was faith. My friends included the ‘Khan Market gang’ and ‘Lutyens gang’ that ridiculed Indian religion. I was taken aback by the underlying self-hate when people breezily said things like, “Ram was a wimp”. My authentic self—a low-maintenance Hindu, maybe, but a Hindu nevertheless—was hidden from them. My faith became “the love that dare not speak its name”. But my cover was blown when I began writing about religion. I couldn’t lie there, though I openly shared my doubts, queries, and



critiques, drawing flak from traditionalists. All hell broke loose in my little world when I tried to explain the Hindu’s visceral need for temples, headlined ‘A House for Mr Vishwas’. ‘Left-lib’ friends told me sternly, “Renuka, you’ve become embarrassing,” and scornfully demanded, “What’s a column on religion doing in a newspaper?”

Wait, my peer group found me ridiculous, and was pressuring me to stop? It was a stark moment of choice. I chose God. A response came to me. “I think a newspaper could be compared to a farm,” I said slowly. “The news pages bear staple crops like wheat and rice. The sports and feature pages grow spice and vegetable crops. The business pages are the mandi, the crop market. The editorial pages are orchards, with the fruit of thought.”

“So, what’s a faith column?” my friends repeated. Their tone had subtly shifted, as though processing the comparison. An answer lit up in my head. “A faith column is the kesar bagh,” I said. “The ‘saffron garden’, as a garden of precious herbs is called. Its space may be smaller than that of the big crops. But if honestly tended, perhaps its scent may be able to enhance the quality of life.” There was a long moment of silence, and I looked back steadily, for, in having to explain myself, I found I had clarified my own thoughts. Perhaps it was what we’d

A bypoll to redefine shape of Telangana politics

If the Congress wins the Jubilee Hills byelection in Hyderabad, Revanth Reddy earns stripes. A BRS triumph would revive the pink camp’s confidence

The Jubilee Hills byelection in Hyderabad has turned into a litmus test for all the political parties in Telangana—the ruling Congress, the main opposition BRS, and the ambitious BJP. The outcome of the November 11 vote will do more than deciding one urban seat—it could reset the power equations that shape the state’s political landscape.

The contest pits the Congress bid to prove its staying power against the BRS’s attempt at resurrection and the BJP’s hunger for urban entrenchment. For the Congress, the stakes could not be higher. Chief Minister A Revanth Reddy has made it a prestige issue. A win would burnish his image and silence critics who claim his administration is wobbling under factional pulls. A loss, however, would deepen the cracks, leaving him gasping for breath amid cabinet indiscipline and a restless cadre. The Congress machinery is in overdrive—rolling out welfare testimonials, aggressive booth management, and door-to-door persuasion. A victory would give the party swagger. It would show that Hyderabad’s urban, aspirational voters



reward the Congress, too, and blow the myth of BRS invincibility in the capital. After all, the Congress has not made a dent in Hyderabad in a decade.

For the BRS, the bypoll is a battle for revival. Having lost ground in 2023 and then all 17 Lok Sabha seats a few months later, it is desperate for a comeback. By fielding

the late MLA Maganti Gopinath’s widow, it is banking on sympathy and legacy. A victory would signal that the pink flag still flies high in the city. The BJP, meanwhile, is likely to play the spoiler. It is pitching itself as the Hindu voice of the urban middle class, hoping to slice into both Congress and BRS votes. A strong showing would underline its expanding footprint and could nudge the BRS toward tactical cooperation in future contests. For the saffron party, Jubilee Hills is less about today’s seat and more about tomorrow’s momentum.

But urban byelections have a mind of their own. Turnout swings, candidate sympathy, and micro-level booth work often upend grand strategies. If the Congress wins, Revanth Reddy earns stripes. A BRS triumph would revive the pink camp’s confidence. A strong BJP performance could rewrite the script altogether. When the dust settles, the result will echo far beyond Hyderabad’s skyline—shaping alliances, ambitions, and agendas in Telangana’s next big political battle.

Vande Mataram: A mantra to stir the nation's soul

Bankim Chandra Chattopadhyay’s poem should not be seen through narrow parochial or religious eyes. It harkens to a higher ideal of nationhood that's relevant even today

Prime Minister Narendra Modi must be congratulated for making the 150th anniversary of ‘Vande mataram’, the song that stirred the soul of a fallen nation, into a State celebration. For what is a State—any State—which has no statement to make? Respect, even reverence, for one’s motherland is the least, some would even say the utmost, Indian statement. For Ma Bharati is not just a country, a political union, a nation, or even a state of mind. She is nothing short of a force of consciousness. In invoking her, Bankim Chandra Chattopadhyay, unified and activated the dormant soul of a defeated people, so enwrapped in darkness that it needed nothing less than a new mantra, almost magical in its incantatory power, to agitate it into awakening.

If I sound so enthusiastic, even laudatory to the point of being reverential, it is because I have just re-read and inwardly recited Bankim’s poem, India’s national song. Yes, it was so affirmed by India’s Constituent Assembly in 1950, the same body that gave us our Constitution. Let me confess that I have never sung or listened to ‘Vande mataram’ without being deeply moved, even to tears. And today is no exception.

But here’s a slight problem. The full song, for various political and historical reasons, is not easily available, especially in Devanagari. I actually had to source the full original from sanskritdocuments.org. This leads me to offer an aside to the powers that be. In our efforts to promote our many national languages, in addition to the two official ones, namely Hindi and English, we must try to make important texts available not

only in translation, but in transliteration. That is, from Punjab to Kerala, Gujarat to Assam, original texts should be in both Devanagari and Roman transliteration so that we can try to read them in original.

When it comes to ‘Vande mataram’, most educated Indians will find it easy to grasp, its mixture of Sanskrit and Bangla heavily weighted in favour of the former, rendering it truly a national text in much of the country. Which leads me to some slightly more chauvinistic Bengali friends, mostly Hindus. They are quick to point out that Bankim spoke of seven crore voices (saptakoti kantha), slightly in excess of the population of Bengal Presidency in his time. The teeming masses of undivided India, even in the late 19th century, numbered some 285 million souls. Ergo, they argue, Bande (with a b), not Vande (with a v) mataram, was for Bengalis, not Indians. Thank you, but why be so literal, I ask. Why can’t Bengal stand for India? After all, most important ideas in the colonial period, including Hindutva, coined before V D Savarkar by Chandranath Bose, came from Bengal. What Bengal thinks today, India thinks tomorrow, they used to say. Why should it be the other way round today—what India thinks today, Bengal thinks tomorrow? If we cry for national unity, even Hindu unity, why should Hindu Bengalis carp and cavil so much?

My apologies if I offend anyone. Given how much a Bongophile I am, my Kolkata friends long ago, albeit grudgingly, called me an ‘honorary Bengali’.

I found that one of the most honourable, in addition to flattering, compliment I have ever received.

From the regional to the ‘secularist’ national objection. I think it was K D Sethna, better known as Amal Kiran in Aurobindonian circles, who answered it best and most politely: “That Vande



mataram should ever have been challenged on the ground that it was too Hindu and not secular enough for a country where there were millions of Muslims, is a sad symptom of national decadence. Perhaps a still sadder one is the lukewarm apologia put up for it at times—namely, that the goddess invoked should not worry anybody since nobody now believes in the reality of such a being and she can be taken as a harmless poetic metaphor for the motherland. Heaven save us from this kind of secularism!” It was indeed Aurobindo who not only hailed Bankim as a ‘rishi’ but Vande mataram as a

mantra: “Among the rishis of the later age we have at last realised that we must include the name of the man who gave us the reviving mantra which is creating a new India, the mantra Bande mataram.” In an article reproduced in The Standard Bearer in 1920, Aurobindo even went so far as to say, “A greater mantra than Bande mataram has to come.”

I think that is because Bankim hails Mother India as a combination of Durga, Lakshmi, and Saraswati—the three powers we need at the practical and psychic levels—to turn earthly existence into a successful and cooperative enterprise. Understood in this light, there is nothing parochial, narrowly religious, or even rigidly nationalistic about Vande mataram.

Rather, especially when understood as a mantra, it signifies the energising feminine or active force in any transformative endeavour, whether physical, vital, intellectual, psychic, or spiritual. Writing on Bande mataram, Aurobindo explained that a nation, like an individual, has three bodies—the physical (annamaya kosha), the vital energy of its citizens (pranamaya kosha), and, “Within the gross body is a subtler body, the thoughts, the literature, the philosophy, the mental and emotional activities, the sum of hopes, pleasures, aspirations, fulfilments, the civilisation and culture, which make up the sukshma sharir of the nation.... but within them all is the source of her life, immortal and unchanging, of which every nation is merely one manifestation, the universal Narayan, One in the many of whom we are all the children.”

14 fishermen from Tamil Nadu arrested by Sri Lankan Navy

The Sri Lankan Navy arrested a total of 14 fishermen from Tamil Nadu in the early hours of Monday for allegedly crossing the International Maritime Boundary Line (IMBL) and fishing near Analaitivu in the Sri Lankan waters.

The arrested include 13 fishermen from Mayiladuthurai and one from Cuddalore. The arrested fishermen have been identified as Rajendran (32), Sivadas (20), Kulandaivel (27), Ranjith (30), Raj (30), Kalai (30), Gagan (28), Prasad (32), Akilan (27), Akash (27), Robin (29), Rajkumar (30), Govind (40) from Mayiladuthurai and Barathi (40) from Cuddalore. While reportedly fishing in the waters near Analaitivu on Monday, the Sri Lankan Navy intercepted the vessel and arrested all 14 fishermen on board and the arrested fishermen were later taken to Kankesanthurai in Sri Lanka for further procedures.

According to sources, the fishermen had originally set out to sea on November 3 from the Tharangambadi Fishing Harbour in a mechanised boat. The crew, consisting of 14 fishermen, began their routine fishing expedition. However, during the early hours of November 4, their boat developed a mechanical fault near Jegathapattinam. With the help of local fishermen, the crew managed to tow the vessel ashore for repairs. After fixing the issue, the fishermen resumed their journey from Jegathapattinam Fishing Harbour on November 8 before being caught by Sri Lankan Navy.

Karnataka SHRC wants Kodagu DC to prevent river pollution

The State Human Rights Commission has sought a comprehensive report from the Kodagu deputy commissioner detailing the initiatives undertaken to mitigate pollution in Cauvery and Lakshmana Theertha rivers. This directive follows a complaint lodged with the commission by members of the Save Cauvery River organisation.

The Save Cauvery organization stressed that untreated waste and sewage effluent from various towns and villages in the district were being discharged into the river, resulting in massive contamination. This complaint was later forwarded to the additional chief secretary overseeing the forest department, who instructed an inquiry and requested a detailed report. At the same time, the Central Pollution Control Board conducted an inspection and collected water samples from ten distinct locations along the River Cauvery.

Laboratory analyses of these samples confirmed the presence of pollutants, including sewage and untreated waste, particularly from the regions of Bhagamandala, Napoklu, Murnad, Kondangeri, Siddapura and Kudige.

The DC has been urged to implement stringent measures to prevent the inflow of waste and sewage into the rivers. The commission also sought a compliance report from the district administration by April 27, 2026.

MP Tejasvi Surya completes Ironman 70.3 endurance triathlon in Goa

BENGALURU. (Agency)

Bengaluru South MP Tejasvi Surya completed the Ironman 70.3 endurance triathlon in Goa on Sunday, marking his second consecutive finish in one of the world's most challenging fitness events. The race, which draws elite athletes from over 50 countries, involves 1.9km of open-water swimming, 90km of cycling and a 21.1km half-marathon, all to be completed within a strict cutoff time.



Surya finished the course in 7 hours and 49 minutes, clocking 44 minutes for swimming, 3 hours and 47 minutes for cycling and 2 hours and 54 minutes for the run. Former Tamil Nadu BJP president K Annamalai, who participated alongside Surya, completed the race in 8 hours and 13 minutes.

Speaking after the event, Surya said, "The Ironman 70.3 Goa has emerged as one of India's premier endurance events. It is the ultimate test of physical and mental strength. Over the past few months, I trained rigorously to improve my endurance and am delighted to have completed this challenge." He urged young Indians to take up sports and physical activity as part of their daily routine. "As a finisher of this demanding challenge, I can attest that setting and pursuing fitness goals truly pushes your boundaries and transforms you as an individual."

MGNREGA employment declines in Andhra Pradesh

Employment generation under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) has witnessed a sharp decline in Andhra Pradesh during the first half of the 2025-26 financial year, according to the latest MGNREGA Tracker released by LibTech India. The report, based on official MGNREGA MIS data (nrega.nic.in) for April-September 2025, highlights a sharp drop in both employment and household participation, coupled with growing digital exclusion due to the mandatory Aadhaar-based eKYC requirement. The report shows that persondays generated in Andhra Pradesh fell by 13.6%, a steep decline compared to the national average of 10.4%. The number of participating households also decreased from 42.79 lakh to 40.74 lakh, marking a 4.8% drop compared to the previous year. Scheduled Caste and Scheduled Tribe workers were disproportionately affected with persondays declining by 18.7% and 17% respectively, compared to an 11.3% fall among other categories. This reduction in work

opportunities has directly impacted household incomes. The average income generated per MGNREGA household dropped by 4.8%, from Rs 10,695 in 2024-25 to Rs 10,178 in 2025-26. LibTech advocates for suspension of Aadhaar-based eKYC requirement



Despite a marginal increase in the notified wage rate from Rs 300 to Rs 307 per day, workers collectively earned around Rs 435 crore, less than last year due to reduced work availability. At the district level, NTR recorded the steepest fall with a 44.7% decline in persondays generated, followed by Chittoor with a 31.3%.

In contrast, Nellore and Visakhapatnam were the only districts to register positive growth, increasing employment generation by 4.8% and 4.1% respectively. Palnadu remained largely stable, showing a marginal decline of 0.4%. The report cautioned that the ongoing

Aadhaar eKYC mandate could further deepen the crisis. In Andhra Pradesh, nearly 38 lakh registered workers are yet to complete eKYC verification, while over 21 lakh active workers remain unverified. "Many have been unable to complete the process due to migration for seasonal work, technical errors, and poor internet connectivity in rural areas," the report cited. LibTech India urged the State government to request the Centre to suspend the mandatory Aadhaar-based eKYC requirement, noting that such digital filters, intended to prevent fraud, are in practice excluding genuine workers from accessing employment and wages. It also recommended that the government hold consultations with worker groups, civil society organisations, researchers, and Central authorities to address these challenges, and ensure that accountability measures do not come at the cost of exclusion.

NFR Loco Pilots Exemplary Vigilance Prevents Elephant Mishaps

Maligaon, 10th November: Northeast Frontier Railway (NFR) has once again demonstrated its commitment towards wildlife conservation and safe train operations in elephant-prone areas. Due to the vigilance and timely action of alert loco pilots and staff, several elephants were recently saved from possible accidents in different sections under NFR. On 10th October 2025, Shri Jitendra Kumar, Tower Wagon Driver displayed exceptional alertness and dedication while on duty. During his run, he noticed two elephants crossing the railway track between Rajabhatkhawa and Kalchini section of Alipurduar Division. Acting swiftly and responsibly, he applied the brakes and brought the Tower Wagon to a complete halt, thereby preventing a poten-

tial elephant dashing incident. In another instance, on 16th October



2025, while operating a Special Train, Loco Pilot Shri Satyendra Yadav and Assistant Loco Pilot Shri Sudarshan Hatimuria noticed four elephants crossing the tracks in the Mariani – Titabar section of

Tinsukia Division. The crew acted promptly by applying the brakes

and stopping the train in time, saving the lives of four elephants. Similarly, on 24th October 2025, the crew of Train No. 20503 (Dibrugarh – New Delhi) Rajdhani Express Shri Lalman,

Loco Pilot and Shri Vinit Gupta, Assistant Loco Pilot, observed an elephant on the track between Bokajan – Khotkhoti section of Tinsukia Division. They immediately applied emergency brakes and brought the train to a halt, thereby averting a possible mishap and ensuring safety for both wildlife and passengers. These instances reflect the dedication, vigilance and compassion consistently demonstrated by the running staff of Northeast Frontier Railway. With the longest elephant corridors in the Indian Railways network, NFR remains committed to ensuring safe train operations while protecting wildlife. The railway is continuously implementing measures such as Intrusion Detection Systems, construction of underpasses and enhanced patrolling to reduce elephant-train collisions in sensitive areas.

Drones, three-tier security to ensure peaceful polling in Jubilee Hills bypolls on November 11

HYDERABAD. (Agency)

For the first time, drones will be deployed for surveillance to closely monitor the polling process for the Jubilee Hills Assembly byelection on November 11 where 58 candidates are in the fray. Drones will be deployed at all the 139 building locations where 407 polling stations have been established. Live webcasting will be carried out from all polling stations for peaceful polling and maintaining law and order, Hyderabad District Election Officer RV Karnan said.

As many as 226 of the 407 polling stations in 65 locations have been identified as critical polling stations, where paramilitary forces will be deployed for maintaining law and order. Addressing media on Sunday, Karnan along with Hyderabad JCP Tafseer Iqbal and others said that 407 polling stations have been set up across 139 locations in the Jubilee Hills constituency, with 3,000 polling staff and 1,761 police personnel have been deployed. A three-tier security system has been put in place. As per election rules, canvassing and loudspeaker use will remain prohibited

during the 48-hour silence period. Polling will be held from 7 am to 6 pm with an additional hour permitted compared to earlier elections. Given the large number of candidates (58) in the fray, EVMs consisting of one Control Unit (CU) and



one Voter Verifiable Paper Audit Trail (VVPAT) are provided to all the polling stations. The Assembly constituency has 4,01,365 voters, including 2,08,561 (male), 1,92,779 (female) and 25 (other voters). Counting of votes will be done in 10 rounds for which 42 counting tables have been arranged. Mobile deposit counters are being opened at all the polling stations to facilitate the voters to deposit their mobile before entering into the polling station and to take back after casting their vote.

After testing positive for HIV, woman kills son, ends life in Krishnagiri

KRISHNAGIRI. (Agency)

In a tragic incident highlighting the continued stigma related to HIV/AIDS, a 40-year-old woman near Hosur strangled to death her nine-year-old son before ending her life on Sunday, a week after learning that they had contracted the virus from her husband. Police said Rekha (name changed) of Krishnagiri district had quarrelled with her husband a few months ago after he tested positive for HIV and started treatment. Rekha, their son and teenage daughter subsequently tested for the virus and last week the results showed that mother and son were positive and daughter negative.

On Saturday night, Rekha and the boy went to sleep in one room, while the girl and husband slept in another. The next morning, her husband found their bodies. Police said Rekha had strangled her son to death and then died by suicide. Based on a complaint filed by Rekha's relative, police have launched a probe into the deaths.

A Krishnagiri official of the Tamil Nadu State AIDS Control Society (TANSACS) told TNIE

that they were initially unaware of the incident and said the authenticity of the test results needs to be verified. Awareness programmes regarding HIV and other sexually transmitted diseases (STDs) were conducted in 20 villages in the district last month, the official said, stressing that suicide is never a solution.



"Proper counselling will be given to the affected persons, and their details will be kept private. The community should support those living with HIV and not isolate them," the official said. It may be noted that with antiretroviral therapy (ART), persons with HIV/AIDS are able to live long, healthy lives.

Tirumala gets AI-powered command control centre

TIRUMALA. (Agency)

Cradled in the divine embrace of Tirumala's seven sacred hills, where chants of Govinda echo through the ages and pilgrims ascend in faith, a quiet technological revolution is underway. The Tirumala Tirupati Devasthanams (TTD), custodian of Lord Venkateswara's abode, has unveiled India's, and possibly the world's first fully AI-powered pilgrim management system, anchored by a state-of-the-art Integrated Command Control Centre (ICCC).

Built at a cost of Rs 28 crore, the ICCC located inside the Vaikuntam Queue Complex represents a landmark fusion of devotion and digital innovation. Designed to manage the daily inflow of over 1 lakh devotees, the system ensures safety, serenity, and operational efficiency even amid shrinking manpower. TTD's workforce has declined from 12,600 to 4,600 over the past three decades due to retirements and a hiring freeze.

"This initiative embodies our resolve to maintain devotion and discipline despite challenges," said Additional Executive Officer Venkaiah Choudary. "With AI, machine learning, and digital twin technology, we're ensuring that every pilgrim's journey remains sacred, safe, and seamless." The idea took shape in October 2024 after HRD and IT Minister Nara Lokesh's Silicon Valley visit, where he explored smart city models and digital twin systems, virtual replicas that enable real-time monitoring and predictive analytics. Inspired, he encouraged a collaboration between TTD and global technology philanthropists to blend ancient faith with modern intelligence.

By February 2025, a core vision team presented a detailed roadmap to TTD, identifying the need for an AI-driven control ecosystem capable of crowd prediction, anomaly detection, and drone surveillance. Following feasibility studies,



the project received approval on August 28, 2025. Funded entirely through donations from global philanthropists under the US-based Karya Foundation, the ICCC was conceptualised as an offering of 'digital seva.' Tech leaders including Anurag Jain, Srinu Raju, BV Jagadeesh, A Praveen, JP Vejjendra, and Dr Srinivas Mukkamal contributed over \$3.5 million to bring the project to life.

Constructed in just 16 days, the centre

operates on KloudSpot's AI platform and NVIDIA's high-performance computing infrastructure.

Chief Minister Nara Chandrababu Naidu inaugurated the ICCC, witnessing its live operations. The trial run exposed the importance of cybersecurity, prompting TTD to add a Rs 8 crore 'Cybersecurity and Digital Threat Intelligence' upgrade, making Tirumala the world's first AI/ML hybrid spiritual hub. The ICCC integrates over 3,000 CCTV cameras, processing 360,000 payloads per minute and generating over 518 million daily events. "It produces around 2.5 billion intelligent inferences in real time," Choudary explained.

The system provides live queue status, heat maps for crowd flow, and digital kiosks for navigation. AI even detects distress signals or emotional strain, ensuring pilgrims feel supported throughout their spiritual journey.

Ajit Doval office to probe possible GPS spoofing at Delhi airport: Sources

The office of National Security Advisor (NSA) Ajit Doval has launched an investigation into possible GPS spoofing incidents that were reported early last week. The possible GPS spoofing took place a couple of days before massive flight disruptions at the Delhi airport last week due to an ATC systems glitch that affected over 800 flights, causing major delays and diversions. GPS spoofing is a type of cyberattack where fake satellite signals are transmitted to deceive navigation systems about their actual location. In the Delhi airport case, pilots reported receiving false navigation data, including incorrect aircraft positions and misleading terrain warnings, particularly within a 60-nautical-mile radius of the national capital. The National Cybersecurity Coordinator (NCSC) at the NSA's office is responsible for national-level coordination on cybersecurity matters. The sitting NCSC is Navin Kumar



Singh, who was appointed in August this year. The NCSC works under the National Security Council Secretariat (NSCS) and coordinates with various agencies, including the Indian Computer Emergency Response Team (CERT-In) and the Ministry of Electronics and Information Technology (MeitY), to ensure a cohesive national response to cyber threats. The NCSC is also responsible for directing the country's cyber threat response and coordinating across

government bodies. Meanwhile, the investigation aims to determine the cause and scope of the alleged GPS spoofing incident. Authorities are also examining whether the airport disruption incident was a result of a technical glitch, cyberattack, or intentional interference. The Directorate General of Civil Aviation (DGCA) and the Airports Authority of India (AAI) are also involved in the investigation. On Friday, Delhi Airport, which handles over 1,500 flight movements daily, had witnessed widespread disruptions after the glitch caused delays to more than 800 flights and led to the cancellation of at least 20. Several flights were also diverted to nearby airports, including Jaipur and Lucknow. The incident caused significant air traffic congestion, with pilots relying on manual navigation and air traffic controllers switching to ground-based systems. The spoofing incident raised concerns about aviation safety, as pilots faced challenges navigating through Delhi's busy airspace.

Madhya Pradesh man on Delhi visit shoots himself dead at Jantar Mantar

A man died by suicide after allegedly shooting himself with a country-made pistol at the protest site in Jantar Mantar on Monday morning, triggering panic among protesters and bystanders. The incident took place around 9 am near a tea stall close to the metal detector gate installed by Delhi Police at the venue. Police officials said the man arrived at the protest site carrying a firearm and shot himself before any intervention could be made. According to police sources, the deceased had reportedly come to participate in a protest for which permission had been granted earlier. However, before the demonstration could begin, he allegedly took out the weapon and shot himself. Eyewitnesses said the man was seen standing quietly moments before the gunshot was heard. The area was immediately cordoned off, and police teams rushed to the spot. Preliminary reports suggest the man may have been a resident of Madhya Pradesh, though officials said his identity is still being verified. His body has been sent for post-mortem examination. A senior police officer said a case has been registered and forensic teams are examining the scene. The firearm has been recovered.

Rs 50 Lakh Money Trail Found In Adulterated Ghee In Tirupati Laddu Row

A Rs 50 lakh money trail has been unearthed in connection with adulterated ghee supplied to the Tirumala Tirupati Devasthanam to make the Srivari laddu, the devotional offering distributed to the lakhs of pilgrims, worshippers, and tourists who visit the famous temple every year. Sources said K Chinnappa, the personal assistant to YV Subba Reddy, a Lok Sabha MP from Andhra Pradesh's ruling YSR Congress Party and a former TTD Chairman, allegedly received that sum – in cash – from hawala agents linked to Uttar Pradesh-based Premier Agri Foods Pvt Ltd. Specifically, Chinnappa allegedly received Rs 20 lakh from Aman Gupta, a Delhi-based agent, and the rest from Premier Agri Foods senior executive Vijay Gupta. Both transactions were made near Delhi's Patel Nagar Metro Station, sources said. Last year a massive political (and legal and socio-cultural) row erupted after allegations the world-famous Tirupati laddus were made with 'impure' ghee, i.e., ghee made with animal fats. The matter reached the Supreme Court, which downplayed politicians expressing 'anguish' over the controversy – the reference was to Chief Minister N Chandrababu Naidu's public statements – stating firmly that politics and religion should not be mixed. The court, however, ordered a joint investigation – with officers drawn from the CBI, the state police force, and food safety officials. The team's report outlined several instances in which the four dairies supplying the ghee manipulated documents and prices to win tenders. Investigators found that 60.37 lakh kg of adulterated ghee, i.e., mixed with foreign particles, worth Rs 240.8 crore, reached the TTD. Specifically, Bhole Baba Organic Dairy Milk Pvt Ltd allegedly mixed palm oils and chemicals to make adulterated ghee at their plant in Roorke, some of which was routed to the temple via three others - Sri Vyshnavi Dairy Specialities supplied tainted ghee worth Rs 133.12 crore, Malganga Milk & Agro Products Rs 73.18 crore, and AR Dairy Foods Rs 1.61 crore.

4 doctors arrested in 4 days with chemicals, rifles: Face of white-collar terror

In a worrying string of arrests over the past week, authorities have arrested four doctors and several other associates linked to terror activities in two separate incidents, exposing a growing white-collar terror ecosystem operating from within professional circles. One of the set of arrests, which took place in Uttar Pradesh, Haryana, and Jammu & Kashmir, was accompanied by a seizure of over 2,500 kgs of bomb-making material, rifles, pistols, and other suspicious material. The other arrests, made in Gujarat, carried recoveries of poison-formulating material and pistols. Both sets of arrests took place within a



day of each other, but authorities haven't said whether they are linked, so far.

Investigations revealed that these radicalised doctors were in contact with foreign handlers operating from Pakistan and other countries and even banned outfits like ISIS, Jaish-e-Mohammad (JeM), and Ansar

Ghazwat-ul-Hind (AGUH).

These arrests of four doctors within four days point to a disturbing trend -- highly educated professionals leveraging their positions to further terror agendas. Officials have warned that these professionals had contact with international handlers and were actively preparing both chemical and firearms-based attacks in different parts of the country. **DR ADEEL RATHER ARRESTED FROM UP** The first arrest came last week when an AK-47 rifle was recovered from the personal locker of a senior resident doctor at Government Medical College (GMC) Anantnag, Jammu and Kashmir. Adeel Ahmad Rather, 27, a resident of Qazigund, Anantnag, had been working at GMC Anantnag.

"Seen Our Morphed Pics Too": Chief Justice Says "Judges Aware" Of AI Misuse

Agency New Delhi.

Chief Justice BR Gavai on Monday acknowledged the growing misuse of Artificial Intelligence (AI) tools and other digital tools against the judiciary, noting that he has seen the morphed pictures. - "Yes, yes, we have seen our morphed pictures too," the Chief Justice said while hearing a public interest litigation (PIL) seeking directions for framing guidelines or a policy to regulate the use of Generative AI (GenAI) in judicial and quasi-judicial bodies. According to the petition - filed by advocate Kartikeya Rawal - there is a difference between AI and GenAI,



with the latter capable of creating ambiguity in the legal system by generating new data and non-existent case laws. It also warned that GenAI

ethical and legal challenges.

"The characteristic of GenAI being a black box and having opaqueness has the possibility of creating an ambiguity in the legal system followed in India. In other words, the skill of GenAI to leverage advanced neural networks and unsupervised learning to generate new data, uncover hidden patterns, and automate complex processes can lead to 'hallucinations', resulting in fake case laws, AI bias, and lengthy observations. This process of hallucinations would mean that the GenAI would not be based on precedents but on a law that might not even exist. Such arbitrariness is a clear violation of Article 14," it claimed.

Upgrade by Jan 1 or shut shop: Drugmakers put on notice after cough syrup deaths

The government has set a firm deadline for all drug manufacturers to comply with global Good Manufacturing Practices by January 1, 2026, following international concerns over toxic cough syrups linked to child deaths.

After a string of global scandals over toxic Indian cough syrups linked to child deaths abroad, the Central Drugs Standard Control Organisation (CDSCO) has drawn a hard line, all drug manufacturers must comply with global Good Manufacturing Practices (GMP) by January 1, 2026, or face closure. No further extensions will be granted. **FINAL DEADLINE FOR NON-COMPLIANT UNITS** The CDSCO's latest order targets 1,470 pharmaceutical manufacturing units with an annual turnover below Rs 250 crore that had been granted extra time to meet revised Schedule M GMP standards.

These smaller facilities were earlier given until January 1, 2026, provided they applied for an extension before May 2025. The regulator has now made it clear that no more leeway will be allowed beyond that date. Out of India's 5,308 drug manufacturing units, around 3,838 micro, small and medium enterprises (MSMEs) have already complied with the upgraded norms. The remaining 1,470 companies, which had sought more time, now face a firm ultimatum - upgrade operations or shut down. **GLOBAL STANDARDS, DOMESTIC SCRUTINY** The move comes after mounting international pressure following multiple incidents of contaminated



cough syrups exported from India, which were linked to the deaths of children in Gambia, Uzbekistan and Cameroon. The government has faced criticism over lax enforcement and outdated manufacturing standards. Under the revised Schedule M, all drugmakers must ensure stricter quality control, traceability of raw

materials, and better documentation to align with World Health Organisation (WHO) standards. The revised GMP norms have already been in effect since 28 June 2024 for companies with turnover exceeding Rs 250 crore. **'NO MORE EXTENSIONS'** Senior CDSCO officials said the industry had been given enough time and assistance to upgrade their facilities. "The deadline of 1 January 2026 stands final. No further extensions will be considered," the regulator's order said. The decision effectively means that non-compliant units will have to suspend operations until they meet the upgraded GMP criteria, a significant push.

Bomb scare in Bengal after live explosives found in Murshidabad field

New Delhi. (Agency)

A bag containing live crude bombs was recovered from an agricultural field in West Bengal's Murshidabad on Monday morning, triggering a security scare and raising concerns over law and order situation in the state. Police said the bag was found near a culvert in the area following a tip-off late Sunday night. The area was cordoned off, and a Bomb Disposal Squad has been called in to defuse the explosives. The discovery has put the area on high alert. An investigation is underway to identify those who stashed the bombs and determine their motive. According to officials, Murshidabad has a history of similar recoveries during election seasons. In 2021, about 60 crude bombs were found in the district ahead of the Assembly elections. Ahead of the 2023 Panchayat polls, live bombs were recovered near a Congress candidate's residence, prompting allegations of political intimidation.

The district has also witnessed several incidents of violence linked to elections. Over 40 people were killed in clashes across West Bengal during the 2023 Panchayat elections, with Murshidabad among the worst affected. In 2016, a CPI(M) polling agent was killed after being attacked with crude bombs in Domkal. Police said the district's proximity to the India-Bangladesh border makes it vulnerable to illegal arms and explosives smuggling. Crude bombs are often used as weapons in political rivalries at the local level. Senior officials said security measures have been stepped up across the district, and patrolling has been intensified to prevent any untoward incidents ahead of the polls. "We have increased surveillance and are investigating the source of the explosives," a police officer said. The bombs were to be defused by the Bomb Disposal Squad later in the day.

60% Rise In Stubble Burning In 6 States In 24 Hours: Delhi Gasp For Air

The rising air pollution in the national capital Delhi continues to draw attention to stubble burning -- one of the causes of pollution -- in neighbouring states, including Punjab and Haryana. In just 24 hours, six states reported a 60 per cent collective rise in incidents of stubble burning on November 8, according to data collected by the Indian Council of Agricultural Research-Indian Agriculture Research Institute's CREAMS laboratory. The six states and union territories being studied include Punjab, Haryana, Uttar Pradesh, Delhi, Rajasthan and Madhya Pradesh. The number of stubble burning incidents increased from 568 on November 7 to 911 a day later, as per the satellite remote sensing data. The data has been collected following the "Standard Protocol for Estimation of Crop Residue Burning Fire Events using Satellite Data", said the CREAMS laboratory. On November 8, Madhya Pradesh reported a whopping 353 cases of stubble burning. This was followed by 238 in Punjab, 158 in Haryana, 120 in Rajasthan and 42 in Haryana. **Punjab At Centre Of Rising Stubble Burning Incidents** A total of 8,365 crop burning events have been detected this season in six states between September 15 and November 8, with Punjab recording the highest at 3,622. Within Punjab, Sangrur, one of the rice producing districts, reported the maximum number of stubble burning incidents at 602 during the same time. A microscopic view of the data suggests that even on November 8, Sangrur recorded the highest number of stubble burning incidents in Punjab. Sangrur is closely followed by Firozpur and Mansa reporting 33 and 27 cases respectively.

Manchester City boss Pep Guardiola sends Premier League title warning to rivals

Manchester City boss Pep Guardiola sent a warning to his Premier League rivals, saying that his side is ready to have a go for the title as they beat Liverpool 3-0 on Sunday, November 9. Goals from Erling Haaland, Nico Gonzalez and Jeremy Doku secured all three points for City as they cut the gap to Arsenal to four.The result for Guardiola's side came after Arsenal were held to a 2-2 draw by Sunderland. Speaking to the reporters, the Spanish tactician said that his message to the players before the game was to prove they can go up against the Champions of England while not looking at the Arsenal result.
"I think Liverpool and us said 'oh wow Arsenal dropped points finally and conceded two goals'," said Guardiola.
"But at the end we have to do it and I said to the players 'don't do it because yesterday Arsenal didn't win. Do it because we believe in ourselves that we can play against the champions of England and show them we are ready to be there with them this season'."Today we proved it. We did it."
Doku was the star of the show for City as he was a constant menace down the left and gave Connor Bradley a rough time. Guardiola said that the Belgian demands himself to get better and handled Bradley well, especially after the Liverpool right-back's performance against Real Madrid mid-week.
"He [Doku] is demanding himself to be better, he listens, and he has special attributes with dribbles," said Guardiola."Today, Conor [Bradley] -- the right-back of Liverpool -- I'm really, really impressed"Pep Lijnders told me a thousand incredibly good things about that guy, he can do everything. I know the game against [Real] Madrid how good [he was] against Vincius."And he [Doku] handled it. He was aggressive, quick without the ball, and we tried to help him. He played an outstanding game."

Renuka Singh overwhelmed by villagers' tribute after India's World Cup triumph

Indian pacer Renuka Singh Thakur received a hero's welcome on Sunday as she returned to her ancestral village, Parsa, in the Rohru subdivision of Shimla district, following India's historic triumph at the 2025 ICC Women's World Cup.
Renuka, who played a key role in India's campaign by taking three wickets in the tournament, was felicitated by villagers and local authorities in a heartwarming ceremony that celebrated her contribution to the nation's maiden Women's World Cup win. During the felicitation, she was surprised with a documentary made by her villagers chronicling her journey from the hills of Himachal Pradesh to the world stage, a gesture that moved her deeply.
"I feel really happy to be here, especially because of the documentary they made for me. I think this is the best gift I could have received," Renuka told news agency ANI during the event.

Raina also backed Ruturaj Gaikwad to continue leading CSK in IPL 2026."MS Dhoni should definitely be retained; he is playing this year, so he should remain with the team. Ruturaj Gaikwad should continue as captain," Raina told JioStar."Ravindra Jadeja should be retained again. He is a gun player for CSK. He has done really, really well for the team over the years, so 'Sir Ravindra Jadeja' has to be there." All 10 teams will announce their list of



retained and released players on the retention deadline day—November 15.
THE JADEJA-SAMSON SWAP SPECULATION
Raina's words carry significance, particularly in the middle of speculation that Jadeja may be part of a potential trade deal with Rajasthan Royals. Chennai are reportedly in talks to acquire Sanju Samson, a move that would not only hand them a long-term wicketkeeping option but also a solid middle-order presence for the years to come.
Samson has been with Rajasthan Royals for 11 seasons and has captained the side since 2021, but with CSK seeking a successor to

MS Dhoni and a reliable Indian batting core, the Royals skipper has emerged as a major target.A senior CSK official, speaking to PTI, confirmed ongoing interest in the Royals captain, saying the franchise has formally expressed its intention during the trading window. "Everyone knows we are interested in getting Sanju. We have expressed our interest in procuring him in this trading window. RR is yet to confirm as their management said they are weighing the options. We are hopeful Sanju will play for CSK," the official said.If the move goes through, it could become one of the biggest trades in league history. For Rajasthan, Jadeja's return would be symbolic — he last played for them in 2009 before becoming one of CSK's most iconic all-rounders, a player who has been instrumental in title runs, spin chokes, and unforgettable lower-order finishes. Adding another twist, England all-rounder Sam Curran is also reportedly part of the same package, potentially heading to Rajasthan in the reshuffle.

Across the city, their eternal rivals East Bengal continue to operate as usual, albeit with nervous optimism.But in Kolkata's football cauldron, where emotions often mix with wisdom, East Bengal's senior official Debabrata Sarkar made a rather interesting appeal: he asked the Board of

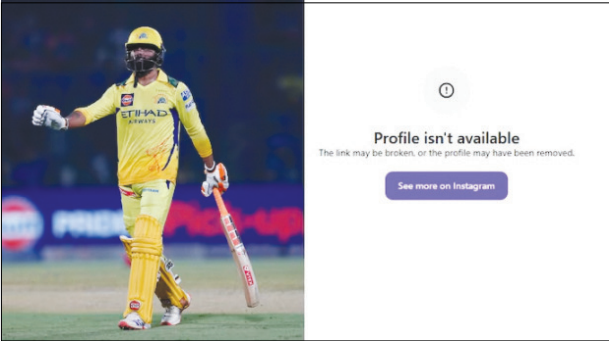


Control for Cricket in India (BCCI) to "sponsor Indian football" for a few years and help the sport stand on its own feet again.
"If BCCI steps in, football can move forward"
Speaking to PTI, Sarkar didn't mince words. "Indian football cannot stop like this," he said. "If the BCCI sponsors the sport for at least four-five years, it would make a huge difference. For them, Rs 100–150 crore is not a big amount. If they take responsibility,

Indian football can move forward in a better way." A plea like this may sound emotional — even desperate, but it reflects a growing truth: Indian football's glitzy experiment may finally be running out of luck.

Bavuma, who missed the start of South Africa's



World Test Championship (WTC) campaign in Pakistan due to a calf strain, returned to competitive action for the 'A' team. The right-hander, playing under Marques Ackerman's captaincy, scored a gritty 59 off 101 balls in the second innings of the second unofficial Test in Bengaluru to help his team secure a five-wicket win and level the series 1-1.

Middle-order batter Zubayr Hamza, another member of the 'A' squad, has also joined the main team. Known for his ability to handle spin, Hamza made valuable contributions in both matches, including a 77 in the second innings of the final game at the Centre of Excellence.

What is 'Digital Gold' and why has Sebi issued a warning?

New Delhi.(Agency)

The Securities and Exchange Board of India (Sebi) has issued a strong warning to investors about the rising popularity of digital gold, a product that lets users buy small amounts of gold online through apps.Millions of Indians have been investing in digital gold, assuming it is as safe as physical gold or gold exchange-traded funds (ETFs). But Sebi has clarified that these online gold products are not regulated under any of its frameworks and therefore carry significant risks.

WHAT EXACTLY IS DIGITAL GOLD?

Digital gold allows users to buy and sell gold through fintech apps and online platforms, often in very small amounts starting from Rs 10 or Rs 100. The platform claims to store the equivalent physical gold in a secure vault on behalf of the buyer.

Later, investors can sell it digitally or request delivery of physical gold.The idea became popular because it offered easy access to gold ownership without visiting a jeweller or buying large quantities. Apps like Paytm, Google Pay and PhonePe have offered digital gold through partnerships with companies such as MMTC-PAMP and Augmont.However, Sebi has pointed out a key difference between these digital gold products and regulated gold instruments like Gold ETFs or Electronic Gold Receipts (EGRs), which are traded on stock exchanges and fall under Sebi’s supervision.

WHY HAS SEBI ISSUED A WARNING?

Sebi’s warning is based on one clear concern: digital gold is not regulated by any financial authority. It does not qualify as a security, deposit or derivative, which means Sebi has no control over how these platforms operate or store investors’ gold.

Investors can now check whether they have received shares in one of India’s most talked-about public issues of the year.The parent company of Groww, Billionbrains Garage Ventures Ltd, saw massive investor interest during the subscription window, as the online investment platform continues to ride the boom in retail participation and digital finance. With the allotment now underway, here’s how you can find out if you’ve secured a piece of the company before its market debut.

On the BSE portal, select “Equity,” choose “Billionbrains Garage Ventures Ltd” from the dropdown menu, and enter your PAN number or application details before submitting.The page will display your status as either “Allotted” or “Not Allotted.”

On the NSE platform, go to the IPO section, pick the company name, and use your PAN number or application ID to check.If the allotment hasn’t been processed yet, it may show as “Approved” or “Pending,” so checking again later in the day can help.

You can also verify the status through the registrar’s website—details are available on the Groww IPO page. You’ll need your PAN number and application number handy to confirm whether shares have been allocated to your demat account.

If you’ve been allotted shares, they will be credited to your demat account before the listing date. Those who didn’t receive an allotment don’t need to worry—the blocked funds will be automatically released to their bank accounts within a few days.

Overcapacity in solar module manufacturing to moderate profitability

MUMBAI.(Agency)

The solar photovoltaic (PV) module manufacturing capacity is set to top 165 gw by March 2027 from 109 gw now, buoyed by the slew of incentives and policy measures in the form of the approved list of models and manufacturers (ALMM) that effectively bars direct import of modules, along with the imposition of basic customs duty on imported cells and modules, and the production-linked incentive (PLI) scheme, leading to an overcapacity build-up which may force industry-wide consolidation. The implementation of ALMM list-II for solar PV cells from June 2026 has spurred the ongoing expansion of cell manufacturing capacity by module original equipment manufacturers (OEMs), which is likely to increase to about 100 gw by December 2027 from 17.9 gw currently under ALMM, Icra Ratings said in a report.

But this is likely to lead a overcapacity scenario as the annual solar capacity

installation is expected at 45-50 gw direct current against an annual solar module production of 60-65 gw. Further, the recent imposition of US tariffs has adversely impacted export volumes, posing new challenges for the industry as modules have been redirected from the export market to the domestic market.

Thus, the overcapacity is likely to result in a consolidation of the smaller/pureplay module players, said the report based on the seven top players which contribute 50 percent of the volume. The report however did not name these seven companies.According to Ankit Jain, a vice-president at the agency, the operating profitability for of the top seven solar OEMs, which remained elevated at 25% in FY25, is likely to moderate due to competitive pressures and overcapacity build-up. The recent imposition of tariffs by US and the growing regulatory uncertainty in the US are likely to further

dampen exports, potentially exerting pricing pressures.

Given that the ALMM requirement for solar cells is effective from next June, a significant scale-up in the cell



manufacturing capacity along with its stabilisation in a timely manner remains critical in the near-term. Further, the cost of modules using domestic cells is expected to be higher by 3-4 cents/watt compared to the cost of the domestic modules using imported cells.

The agency also notes that all projects

wherein the last date of bid submission is prior to September 2025, translating into a solar project pipeline of 45-50 gw, will be exempted from the requirement of using solar PV cells under ALMM list-II even if their date of commissioning is after June 2026. This will support the order book without additional capacity ramp up in the near term.The solar PV manufacturing supply chain is dominated by China, with over 90 percent share in the global manufacturing capacity across polysilicon and wafer, over 85 percent share in cells and around 80 percent share in modules. Given the dependence on China for the sourcing of wafers and ingots, any potential geopolitical curbs on the supply of technology/machinery in setting up backward integration facilities for domestic OEMs remains a key monitorable. Moreover, each successive stage in the value chain demands higher technological complexity.

Credit card spends up 23% in Sept to Rs 2.17 trillion, highest since 2020

MUMBAI.(Agency)

Indicating the rising indebtedness of households and individuals or their spendthrift nature expecting better earnings going ahead, credit card spends soared 23 percent on-year and 13 percent sequentially to Rs 2.17 trillion in September—the highest since 2020.According to an analysis by Care Ratings, however, the total outstanding credit card balances stood at Rs 2.82 trillion in the reporting month marginally down from Rs 2.89 trillion in August 2025 and up from Rs 2.72 trillion in September 2024, indicating a moderate annual growth of 3.7 percent and a sequential decline of 2.38 percent.

Accordingly, the share of credit card outstanding balances in total retail loans has also fallen marginally by 40 bps to 4.5 percent in the reporting moth from 4.9 percent a year earlier. The



agency attributed the spike to bank-led festive offers in the run-up to the festive month, increasing consumer demand driven by the festive spending induced by GST rate cuts, along with increased card issuances in the month.

While the growth rate for the reporting month remained robust, it was slightly lower than the 24 percent expansion seen a year ago. Private sector banks maintained their dominance in the

credit card spends market with a 74.2 percent share in September, although this was a 130-basis point lower annually, while public sector banks increased their share to 21.2 percent from 18.4 percent.

The total number of outstanding credit cards grew from 10.6 crore in September 2024 to 11.3 crore in September 2025, reflecting a steady increase in card penetration, indicating an annual increasing of 7 percent and an on-month growth of 1%, attributed to an expansion in credit card adoption and usage. Private banks’ average spending per card in September was Rs 20,011, up 3 percent, while that of their state-run peers saw a more significant increase of 30 percent, with per-card spending rising to Rs 16,927, primarily due to enhanced digital and rewards offerings, apart from their.

Markets steady in mid-morning trade amid global optimism and earnings support

Indian equity benchmarks traded higher through mid-morning on Monday, supported by positive global cues and upbeat domestic earnings. The Nifty 50 was up around 0.3 percent, while the Sensex gained a similar margin, extending early gains on broad-based buying across sectors.Investor sentiment improved after reports suggested progress toward resolving the US government shutdown, lifting risk appetite across Asian markets. Back home, strong corporate earnings continued to provide support, particularly in select mid-cap and pharma counters.

Out of 16 major sectoral indices, 14 were in the green, with mid-cap and small-cap stocks rising about 0.5 percent. Among notable movers, Nykaa gained over 4 percent after posting robust second-quarter results,

while Lupin advanced more than 2 percent following a 73 percent year-on-year jump in quarterly profit. In contrast, Ola Electric slipped nearly 2 percent after a credit-rating downgrade.



Market breadth remained positive, indicating sustained buying interest beyond frontline stocks. However, analysts noted that the gains were modest and pointed to a “wait-and-

watch” approach among investors ahead of key global economic updates.

While optimism over US fiscal developments and resilient domestic earnings have boosted near-term sentiment, traders remain cautious about potential volatility linked to foreign institutional flows, inflation data, and policy signals from global central banks.

Market strategists say the near-term outlook remains cautiously constructive, with investors advised to focus on quality large-cap names while selectively adding exposure in sectors showing earnings momentum.

In summary, Indian equities were trading firm by mid-morning, reflecting steady optimism from global and domestic factors, though with a measured tone as investors look for fresh triggers to sustain the uptrend.

Lenskart makes a muted market debut, crashes 11% in initial trade

Eyewear major Lenskart Solutions shares made a weak stock market debut on Monday, despite its IPO receiving a thunderous response in the primary market. Shares of Lenskart were listed at Rs 395 percent share on the NSE, a 1.74 percent discount to its IPO price.

On the BSE, the stock was listed at Rs 390 apiece, a discount of nearly 3 percent. The company's market capitalisation post listing of shares stood at Rs 67,660 crore. The stock declined as much as 11% in the first few minutes to hit a low of Rs 356. However, it made a recovery from the lows and hit a high of Rs 404 as of 10.30 am. Ahead of its listing, the grey market premium (GMP) of Lenskart fell sharply on Friday. The unlisted shares of the company were trading with just 2.5% GMP over the IPO price, according to data on Investorgain. This is a steep decline from the 24% GMP the IPO was commanding on October 31.

Meanwhile, domestic brokerage Ambit Capital initiated coverage on Lenskart with a 'sell' rating. It warned that the company’s valuation appears stretched

and offers limited potential for short-term gains. Ambit has set a target price of around Rs 337 per share, about 16% below the issue price of Rs 402, implying that the stock could see pressure upon debut if sentiment weakens.

The initial Rs 7,278 crore public offer (IPO) of Lenskart was booked 28.26 times, highlighting confidence investors have in the Indian primary market and in the company despite valuation concerns. The Rs 7,278-crore IPO received bids for over 281 crore shares as against 9.97 crore shares on offer, as per BSE data.

The portion for Retail Individual Investors (RIIs) part for Lenskart’s IPO fetched 7.54 times subscription, while the non-institutional investor category got subscribed 18.23 times. The quota set aside for Qualified Institutional Buyers (QIBs) received 40.35 times the

subscription.

Lenskart’s valuation concerns stem from its high P/E. The Gurugram-based company turned profitable in FY25,



posting a net profit of Rs 297 crore and its Rs 70,000 crore valuation at the upper end of the IPO price band translates to a steep 237 times price-to-earnings multiple.

This, according to many, makes the IPO a highly ‘expensive’ affair. Harshal

Dasani, Business Head, INVasset PMS said that Lenskart’s forward valuation implies over 200 times current earnings, making it one of the most expensive listings in India’s digital retail space.Shivani Nyati, Head of Wealth at Swastika Investmart said that while concerns around high valuation, recent losses, and competitive intensity weighed on short-term sentiment, the IPO received solid institutional interest backed by expectations of strong growth in international markets and improving margins.

“Investors allotted shares may consider holding for the medium to long term, supported by earnings visibility and expanding store footprint, with a stop loss around Rs 350 and Short-term traders may exit the position and look for better opportunities elsewhere,” added Nyati.

Neha Kakkar's

Name Misused In Trading Scam, Mumbai Lawyer Duped Of Rs 5 Lakh

In yet another shocking case of online fraud, scammers allegedly used Bollywood singer Neha Kakkar's name to promote a fake international trading platform called FXOnet, duping a Mumbai-based lawyer of over ₹5 lakh. The cybercrime, which relied on forged promotional videos and fake social media content, is now under investigation by the Worli Police.

Fake Trading Platform Posing as 'Neha Kakkar-Endorsed'

According to the FIR filed at Worli police station, the victim, Advocate Shabnam Mohammad Hussain Syed (45), a resident of BDD Chawl in Worli, came across deceptive articles and videos in June 2025 falsely portraying Neha Kakkar as an ambassador for FXOnet — described in the content as a “trusted and legal trading platform.” Lured by the celebrity association, Syed contacted individuals posing as FXOnet representatives, identified as Vijay and Jimmy D’Souza, who communicated with her through international phone numbers, Telegram (user ID: @fxonetlbot), Zoom meetings, and emails that appeared professional and legitimate.

How the Fraud Unfolded

The scammers convinced Syed to open a trading account under her name, promising high returns and sending her “expert investment tips” over Telegram. Believing the scheme to be genuine, she transferred ₹5,02,025 between June 18 and October 9, 2025, from her HDFC Bank account to multiple accounts under names such as Rajesh Kannan (PONNURAKU@SUPERYES), VPI ProMedia Kigali, India Impex Trading Company, and VPI 361 VPECOM. However, when no profits or refunds arrived, Syed realized she had been scammed and filed a complaint.

Police Launch Digital Investigation

The Worli Police have registered a case under relevant sections of the Bharatiya Nyay Sanhita (BNS) and the Information Technology Act (IT Act). Investigators are now analyzing Telegram chats, Zoom meeting records, and UPI transaction trails to trace the culprits. Authorities said the fraudsters’ modus operandi mirrors a growing trend where cybercriminals use celebrity names to gain public trust and lure victims into bogus investment platforms.

Not the First Celebrity Fraud Case

This is not an isolated case. Earlier, the Mumbai Police filed an FIR against an unidentified person impersonating Hollywood star Keanu Reeves, who cheated a 69-year-old Versova woman of ₹65,000 by pretending to raise money for a flight ticket to India. The victim’s daughter later reported the scam, saying the imposter had built emotional trust by posing as the actor online. Vegan potlucks first made their debut in Delhi and Mumbai, close to three years ago. But the trend, which is making waves in Western countries, has now gripped the city. Every Sunday afternoon, close to 50 enthusiastic vegans from the Hyderabad Vegans Club gather together at one of the members' homes, carrying casseroles filled with vegan delights (dishes minus any ingredient made of animal products). Giving a lowdown on how it all began, Amita Desai, a member of the group says, "Earlier, it was a small group of friends who bonded over vegan food. Slowly, through

word of mouth, many mutual friends began to show interest. Soon, we formed a group on a social networking site and started organising potlucks." She adds, "We even screen a short film on animal abuse after the meal and later have discussions for the new members."

On the menu are dishes with a twist — masala chai with cashew and almond milk, stuffed capsicums, baked vegetables with cashew cheese, millet crackers, salads, tofu makhani, palak tofu, kadhi pakora (tamarind pulp replaces curd), mock meat biryani (with soya nuggets), peanut curd rice and a host of lip-smacking

desserts like chocolate ice cream made from tender coconut pulp, chocolates made from vegan chocolate slabs and date sesame laddoos. As the group begins to devour the huge

spread, there are recipes being exchanged, small talk on how veganism is the way to go and even quick ideas are sprung across on what to bring



for the next potluck.

Some club members even vouch for health improvements and better lifestyle, after turning vegan. Entrepreneur Rekha Saraf and homemaker Madhulika Jajodia claim to have cured their asthma by turning vegan. "I had asthma for nearly 15 years. Despite the best of medical treatments, nothing helped. But after turning vegan, my asthma miraculously disappeared! Now, I don't even use my inhaler," says Madhulika. Rekha too shares similar views. "Milk increases phlegm (mucus) production. Once you stop

the intake of milk, asthma can be cured," she says.

For software professional, Pulkit Parikh and wife Sejal, the idea of adopting a vegan lifestyle even compelled them to have a vegan baby! The proud momma, Sejal, says, "It's been two-and-a-half years now that I've turned vegan and my recent pregnancy too was completely vegan. My family was worried that not consuming milk will affect my pregnancy, but nothing of that sort happened." Husband Pulkit adds that if anything, Sejal's calcium level was above

average throughout her pregnancy and this was without taking any supplements. "I delivered a healthy 3.75 kg baby boy, indicating very strong protein levels in my body. I'm now committed to raising my son fully vegan," informs Sejal.

What started off a year-and-half ago as a casual meet

Nehru Place Metro Station, the new foodie address

Restaurant review: The Chatterhouse



Leveraging on the Nehru Place Metro Station's new found identity one of a 'food mall', this new watering hole touted to be Delhi's first gastro-pub holds promise to take the local pub culture a notch higher. The Chatterhouse tucked away in the far end of the lower ground floor of Epicuria (the food mall) drowns out the clamour of the food court making way for some peaceful unwinding and conversations.

Decor: For a resto-pub in a metro station-cum-food mall, you'll find Chatterhouse quite spacious and tastefully upholstered. Reminiscent of a typical English pub, the interiors are dark wood and leather accentuated with graphics on its brick walls and a pool table in one corner. At its heart is a rustically done up bar facing a giant screen for telecasting football matches surrounded by high stools. Its 110 covers extend to the outdoors too amid a finely manicured garden with a burning wood fire on one end for tossing out delicious thin crust pizzas. And unlike a typical pub which is mostly crammed, the seating here is divided into booths and open tables with bar stools to ensure you some quiet time without having to overhear others.

Food: The drink menu here has been crafted to go with that of the food, and not the other way round. Comprising a

veritable mix of Italian, Lebanese, Continental, Indian and traditional pub classics, you have the option of customising the offering with your choice of beers and burgers to go with French fries. The wood fire pizzas too move very quickly here, and would be even better to find a seat in the garden next to the oven on a cold day. The place exudes the warmth you crave for on a glum winter day by gratifying you with its comfort food, and drink. From linguine aglio olio to penne with vodka, the choices in pasta are decadent, but not abundant.

At any point, the gaze of the restaurant doesn't narrow only on the young crowd, which it ensures by serving up rock classics from the 70s and 80s, and by keeping hookah out of the menu altogether. True to its philosophy of offering a comfortable space to everyone with a taste for good life and food, you, at the end of the day, wouldn't really mind bringing your folks along. But in the same breath, the pub doesn't lean heavily on ambience alone, for the gastronomic offering here is every bit lip-smacking providing a bang for your buck.

Starters and main course: Begin with the in-house favourite, the 'Chatterhouse Platter' served in both vegetarian and non-vegetarian categories. The non-veg one we went for comprised shish taouk skewers with hummus and pita bread, honey mustard glazed chicken wings with a blue cheese dip, beer batter fish strips with tartar sauce, and chicken kebabs with mint chutney, presented beautifully on a wooden tray. The meats and the fish were

succulent and perfectly cooked whetting our appetite for the courses that lay ahead. Another must-try here is the wood fire pizza for its earthy fragrance aside from the sliders. Surprisingly, the tenderloin beef slider with caramelised onions, cheddar, bacon, lettuce and tomato is a lot more popular than familiar flavours like chicken breast or spiced lamb. The falafel burger too with grilled haloumi, tahini sauce and red onions is beautifully put together. If hard drinks are not on your mind to go with the food, order one of their refreshing and innovatively named mocktails like the Amrood Chaat (guava juice, Tabasco and chaat masala topped with lemonade) or Mango Julius (fresh mango juice, milk, vanilla extract and sugar).

Drinks: Once their liquor licence is in place, Chatterhouse plans to offer an experience called the bubble gum invasion in its vodkas and martinis apart from serving blow pop martini jelly shots, bubblegum vodka ice-cream float, and fruit and tequila popsicles, ostensibly to attract more women drinkers. Of course, there would be the usual premium Scotch Whiskies and Rum.

Desserts: Until then you can round it off with a portion of carrot cake with cream cheese icing served with vanilla ice-cream, or a gooey chocolate cake with coffee ice-cream. While the carrot cake could have done away with some sweetness, the choco cake was warm and squidgy complementing the bitter touch in the ice-cream.

Service: The staff is attentive, and try to accommodate guest requests even if they are not on the menu depending on the available ingredients.

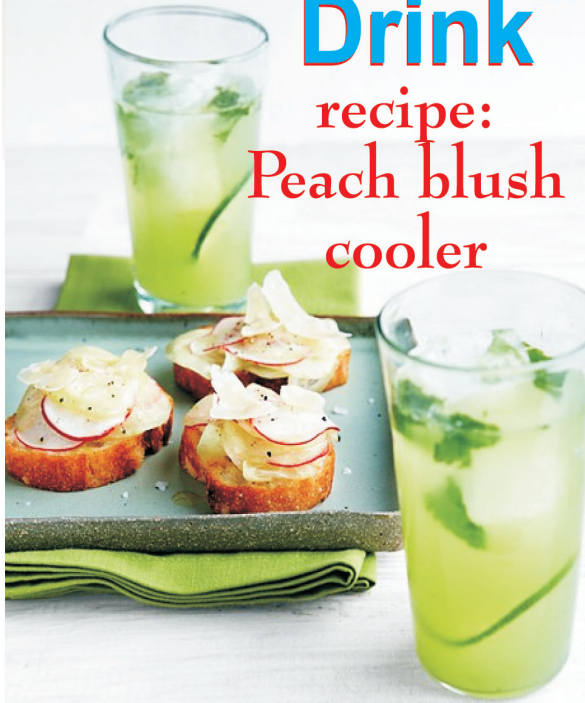
