## Delhi Blast A Terror Attack But Why India Is Shy Of Naming Pakistan? The Dilemma Of 'Act Of War' Explained

Delhi Blast Case: For a country that has long suffered from Pakistan-sponsored terrorism, the Modi government's decision to refrain from naming Pakistan marks a clear departure from previous administrations' approaches and signals a more cautious stance.

#### New Delhi.(Agency)

The Union Cabinet, led by Prime Minister Narendra Modi, on Wednesday declared the Delhi blast an act of terror. Despite the root of the attack being tracked to the Kashmir's Pulwama and Pakistan-based Jaish-e-Muhammad (JeM), the Narendra Modi government is yet to name Pakistan's involvement in the case. One may recall that after Operation Sindoor, Prime Minister Narendra Modi declared that any future terror attack would be considered an 'Act of War' in the New India. Even Defence Minister

Rajanth Singh reiterated the claim."Prime Minister Narendra Modi has redefined India's policy against terrorism, which now says that any attack on Indian soil will be considered as an act of war," said Singh while addressing the Indian Army soldiers at Badami Bagh Cantt, Srinagar on May 15, 2025.

Now, even the opposition leaders are questioning the government's silence. "50 hours after the Delhi bomb blasts Modi govt has accepted it is an 'Act of Terror'. But not a word on Pakistan. Is an act of terror possible in india without the involvement of Pakistan? Modi govt had said any act of terror will be seen as an act of war. But the govt's response so far is in contrast to this vow despite links being



quoted to Pakistan-based JeM. Did Mr Modi mess up India's security game by turning deterrence on its head and has now been trapped by his own rhetoric? Modi's ignorance and arrogance is proving costly for India. India deserves answers," said Supriya Shrinate, Congress spokesperson.

Why Silence On Pakistan? For a country that has long suffered from Pakistansponsored terrorism, the Modi government's decision to refrain from naming Pakistan marks a clear departure from previous administrations' approaches and signals a more cautious stance. Even though the government has officially acknowledged the Delhi blast as a terror attack, its reluctance to directly implicate Pakistan represents a shift from earlier positions.

Analysts, speaking on condition of anonymity, suggest that this departure from precedent may stem from the relatively low threshold Prime Minister Narendra Modi has set for military responses to terror incidents. They argue that explicitly naming Pakistan would heighten public expectations for retaliatory action-potentially escalating tensions and drawing India closer to the brink of war.

The Indian government painted itself into a corner a trap of one's own creation...With the declaration that an act of terror is an act of war and no elaboration on this doctrine, now they are confronting the consequences of what they say – a completely foolish position, not even a policy, that is short-sighted for political gains," Ajai Sahni, executive director of the South Asia Terrorism Portal (a platform that tracks and analyses attacks in South Asia), told Al Jazeera.

#### What's Next?

With the National Security Guard (NSG) and the National Investigation Agency (NIA) taking over the probe, the Modi government is unlikely to show a haste. The Indian Armed Forces have already stated that they are building on lessons learned from Operation Sindoor. The May conflict gave a reality check not only to Pakistan but also to the Indian Armed Forces.



#### New Delhi.(Agency)

Aam Aadmi Pary (AAP) leader Saurabh Bharadwaj on Thursday accused Prime Minister Narendra Modi and Delhi Chief Minister Rekha Gupta of turning their visits to meet those injured in Red Fort blast into a "photo opportunity", claiming that a patient's dressing was changed ahead of the Prime Minister's hospital visit. Sharing two photos on X, Bharadwaj said the same patient appeared with a "new costume and new plaster" when PM Modi visited Delhi's LNJP Hospital on November 12, a day after Chief Minister Rekha Gupta's visit."November 11, 2025 - CM Rekha Gupta met the patient before. November 12, 2025 – the next day, PM Modi met the same patient. New costume, new plaster in hand," Bharadwaj wrote.

The Prime Minister met those injured in the November 10 Delhi blast and said that the people behind the conspiracy would be brought to justice."Went to LNJP Hospital and met those



injured during the blast in Delhi. Praying for everyone's quick recovery. Those behind the conspiracy will be brought to justice!" PM Modi said in a post on X.Soon after landing from Bhutan, PM Modi went straight to LJJP Hospital and interacted with the injured and even wished them a speedy recovery. He was also briefed by officials and doctors at the hospital.

Meanwhile, the death toll in the high-intensity explosion near Red Fort early this week rose to 13 after another injured person succumbed to his injuries at the LNJP Hospital. The government has termed the blast near the Red Fort a "terrorist incident". Officials believe Dr Umar Nabi, who was driving the explosives-laden car, had planned the attack to coincide with the Babri Masjid demolition anniversary on December 6.Officials also believed that the suspects wanted to carry out a strike similar to the Mumbai attack in 2008.

## CM Rekha Gupta Flags Off Another Delhi—Sonipat Inter-State Bus Route

In a significant step towards strengthening public transport, Delhi Chief Minister Rekha Gupta yesterday flagged off another inter-state electric bus route operated by the Delhi Transport Corporation (DTC), running from the Kashmere Gate Bus Terminal to the Sonipat Bus Stand. The newly introduced electric buses are equipped with air-conditioning, CCTV cameras, panic buttons, and GPS systems.

On the occasion, the Chief Minister announced that the Government will soon resume DTC bus services connecting Delhi with adjoining NCR cities. At a special ceremony held at the Maharana Pratap Inter-State Bus Terminal, Kashmere Gate, the Chief Minister, accompanied by the Transport Minister, Dr Pankaj Kumar Singh, flagged off three inter-state electric

buses bound for Sonipat. Earlier, on the occasion of Prime Minister Narendra Modi's birthday celebrations during the Seva Pakhwada, the Chief Minister had inaugurated the first inter-state electric bus service between Delhi and Baraut.

Speaking at the event, the Chief Minister said that the Delhi Government is reviving interstate bus services between Delhi and NCR cities that had been discontinued several years ago. She added that this initiative will provide citizens with accessible and convenient public transport options, reduce traffic congestion, and help curb pollution.

The new DTC electric buses are equipped with state-of-the-art facilities including airconditioning, CCTV cameras, panic buttons and GPS systems. These buses will ensure safer and more comfortable travel

#### In Gurgaon, man assaults widow in bid to capture property, arrested

**Gurgaon.(Agency)**A 26-year-old man with a criminal background was arrested for allegedly assaulting a widow and attempting to capture a rented room on her property in Laxman Vihar phase 2. Kunal Jaiswal, alias Golu of Laxman Vihar, was taken into custody by police on Monday. Police said Jaiswal has 13 previous criminal cases registered against him, including murder, attempted murder, assault, illegal possession of arms, and rioting.

On Monday evening, the complainant, a widow who owns a plot with 17 rented rooms, received a call from one of her tenants, informing her that some men occupied room number 15, a police official added.

When she reached the spot around 8pm, she allegedly found Jaiswal and two to three others sitting inside after placing their furniture. "When the woman asked them to vacate the room, Jaiswal and his associates began assaulting her. When family members of the victim intervened, they too were beaten up and threatened with dire consequences," a police officer said. A case was registered for assault following a complaint and medical reports of the injured. During interrogation, he admitted that he targeted the property because he knew the owner was a widow and thought her to be an easy target. "He is a habitual offender with a 'history sheet' already opened against him. He was involved in 13 different cases, including one for murder and two for attempted murder.," an officer added.

#### Charges framed against SRS Group promoters in 2.2k cr money laundering case

Noida.(Agency).

In a move towards resolving one of north India's largest real estate scams, PMLA court in the city has formally charged the promoters and key officials of SRS Group in connection with a ?2,200-crore money laundering case. The case is being probed by Enforcement Directorate (ED). The Nov 3 order lists charges against Anil Jindal, the promoter-director of SRS Group along with Vinod Jindal, Bishan Bansal, Rajesh Singla, Vinod Kumar Garg, Navneet Kwatra, Seema Narang, Dheeraj Gupta and Devender Adhana. Also, charges have been framed against three corporate entities - SRS Real Estate, Horizon Global, and SRS Finance. According to ED, the SRS Group lured investors with promises of high returns on residential and commercial projects. However, the funds collected were allegedly diverted into numerous shell companies floated by the group, laundered, and then used to finance unrelated ventures. The agency's investigation was initiated based on 81 FIRs filed across Faridabad, Delhi and by CBI under various sections of IPC.ED officials stated that a provisional attachment order worth ?2,215 crore has already been issued, and a prosecution complaint was filed before the court in August 2022. "Framing of charges marks a step toward securing justice for thousands of homebuyers and investors who were duped," an ED officer said.

The agency also claimed three accused — Praveen Kumar Kapoor, Sunil Jindal, and Jitender Garg — had earlier been declared proclaimed offenders by the court. Proceedings under the Fugitive Economic Offenders Act (FEOA) were initiated against them, and Red Corner notices were requested from Interpol. Kapoor was intercepted at Newark International Airport in the US and deported to India on Nov 2, 2025. Officials also said framing of charges now sets the stage for the trial of the accused and potential restitution of the attached assets to rightful claimants and homebuyers.

#### Air quality still severe in Noida, but GRAP III violations continue

Noida.(Agency)

The Commission of Air Quality Management has enforced GRAP III across Delhi-NCR, but construction activities continue across the city, including a project under Noida Authority. The city's AQI came down a few notches on Wednesday, but remained severe with its AQI dropping from Tuesday's 425 to 408. In Greater Noida, the AQI improved from 406 (severe) to 387 (very poor). while in Ghaziabad, it dipped from 390 to 362, in the poor category. Despite a ban on non-essential construction activities under GRAP III, construction work continued at Noida Authority's clock tower project near the GIP police check post. An official said, "Construction activities are banned except for those related to metro rail, hospitals, and flyovers. We have directed a team to visit the spot and ensure compliance."

In Sector 31, construction activities were underway at several housing projects where construction material was left uncovered. At one site, workers were plastering walls, while at another, concreting work was in progress. An environmentalist, Vikrant Tongad, shared a video on X capturing construction work in Sector 107 and urged authorities to take action. Another resident, Amit Shahi, posted a video of construction work in Jaypee Wishtown, Sector 128, without proper dust control measures. Greater Noida Authority, meanwhile, said it has intensified its efforts to control dust pollution. The civic body has deployed 60 water tankers for regular sprinkling on city roads and major construction stretches. Eight mechanical sweeping machines are

operating across the city to ensure roads remain clean. To tackle emissions from construction activities, 186 antismog guns have been installed by developers at various builder sites across the city. Additionally, eight mobile smog guns are operational in high-dust zones. "These guns are moved to different locations depending on pollution levels and ongoing work. The use of smog guns and tankers is being closely monitored to ensure continuous coverage," an gofficial said. The Authority has imposed penalties worth Rs 62 lakh on 14 institutions and builders for violation of GRAP so far.

## Security stepped up in Gurgaon: RWAs, hotels, Pgs told to verify tenants, visitors and staff

Gurgaon.(Agency)

The district administration has directed all house owners, RWAs, hotels, guest houses, offices and PG accommodations in the city to maintain a record of every tenant, visitor, worker and servant, and ensure their police verification. The order, however, didn't mention the duration for which the records have to be kept. The order, issued by district magistrate Ajay Kumar on Wednesday under Section 163 of BNSS, is aimed at strengthening surveillance and public safety in view of heightened security concerns following the Delhi bomb blast on Monday. The order will remain in force from Nov 11 to Jan 31, 2026 covering the New Year and Republic Day period when public gatherings and celebrations typically increase. As per the directions, all establishments including cyber cafés, PGs, guest houses, dharamshalas, hotels and offices - must keep a register recording the identity details of each visitor, tenant or worker, along with a copy of their ID proof.

Police verification for tenants and domestic



staffers has been made mandatory.

The district magistrate has also imposed a temporary ban on the use of drones, micro light aircraft, gliders, powered gliders, hot air balloons and kite-flying across the district during this period, citing security reasons."In view of the current situation and shortage of time, the order has been issued ex-parte and applies to the general public," the

directive said.It instructed DCPs to ensure strict enforcement under the supervision of the commissioner of police (Gurgaon). The order warns that any person or establishment found violating these directions will face action under Section 223 of BNSS and other applicable laws.A police spokesperson said, "These measures are purely precautionary. We request residents to

immediately report any suspicious person or activity to their RWA, the nearest police station or by dialling 112. Verification of all tenants and foreigners at the nearest police station is mandatory. The identity of anyone providing information will be kept confidential."

RWAs have been instructed to check Aadhaar cards and ensure police verification for new tenants and foreign nationals staying in the societies.

Several RWAs said they have already begun complying with the directions.

Sector 92's Rising Homes RWA president Praveen Malik said the police visited the society on Tuesday and sought details of foreign nationals and tenants."We shared the required information with the local police. We informed all residents about the advisory and are giving all support to the police. Our security staff has been instructed to strictly check ID proofs before allowing any visitor inside," Malik said. Some RWAs in other sectors said they were yet to receive any formal communication from the police and were relying on verbal instructions.

### Councillors seek crackdown against liquor vends set up near societies in Gurgaon

Gurgaon.(Agency)

Mushrooming of liquor vends in residential areas triggered outrage at MCG House meeting on Wednesday, with councillors unanimously demanding an immediate crackdown on outlets operating near homes, schools and temples. Raising the issue, ward 2 councillor Jyotsna Yadav said liquor shops in her ward had become a "public nuisance," disturbing families and schoolchildren."These vends are coming up right next to residential colonies and schools, specifically in and children passing through the area where there are now unruly crowds because of the vends. It is a safety concern," Yadav said, adding, "Who gives licences to such liquor vends to come up in residential areas and near schools?"Ward 31 councillor Dalip Kumar Sahani said that a liquor vend stands "right beside a temple" in his ward and called it an insult

to people's sentiments. According to ward



27 councillor Ashish Gupta, there was a liquor vend in the middle of Sadar Bazar and posed a major safety concern for women going to the market.

Dundahera and Sarhaul. There are women Responding to the uproar, MCG commissioner Pradeep Dahiya said he would meet officials from the excise department to verify the legality of the vends in question. "No liquor vend can function without a licence. We will examine all such cases and take necessary action," Dahiya said. Backing the councillors, Gurgaon MLA Mukesh Sharma called for a city-wide review. "Liquor vends must not be allowed near

schools, temples, or marketplaces. Those violating the rules should be identified and shut down immediately," he said. The House directed MCG to coordinate with the excise department and conduct a comprehensive survey to identify all liquor vends operating in sensitive

According to Haryana excise policy, liquor vends cannot be established within 150 metres of the main gate of any recognised school, college, main bus stand, or place of worship. In the case of urban retail liquor outlets, the excise commissioner may relax this distance requirement from 150m to 75m. The policy further states that in urban areas, retail liquor vends should preferably be located in marketplaces. However, this restriction will not apply if a new recognised school, college, bus stand, or place of worship is established after a liquor vend has already been set up in accordance with the existing

is linked to nine companies through its managing trustee Javed Ahmed Siddiqui, who is a director in nine firms that have a diverse range, from investment, education and software to energy, export and consultancy, ministry of corporate affairs records show.An engineering graduate from Devi Ahilya Vishwavidyalaya in Indore, Siddiqui is chairman of Al Falah Charitable Trust that runs the Faridabad-based Al-Falah University of Medical Sciences and Research Centre, which has become the focal point of a widening investigation into a module of radicalised doctors that was behind the blast near Red Fort metro station in Delhi on Nov 10 in which nine people died. Three doctors linked to the terror plot – Umar Un Nabi who was driving the car that blew up, Muzammil Ahmad Ganaie who was arrested on Oct 30, and Shaheen Shahid, arrested in Lucknow on Nov 11 - taught at Al-Falah.Siddiqui's oldest association is with Al-Falah Investment, according to the records, which show him joining the company on Sept 18, 1992. Among other companies

he is part of is Al-Falah Software, Al-Falah Energies, Tarbia Education Foundation and Al-Falah Education Service, which is his newest association (joined on Dec 26,

Most companies have the same registered address: 274-A, Al-Falah House, Jamia Nagar, Okhla, New Delhi. This is the same building from where Al-Falah Charitable Trust operates. The university, now on a 78-acre campus, started as an engineering college in 1997. The trusts and companies also include the name of Usma Akhtar, who was part of the governing body of Al-Falah School of Engineering. According to her LinkedIn profile, she currently lives in the United Arab Emirates (UAE) and is associated with several businesses there. Usma's name is also registered as director in companies like Al-Falah Education Service and MJH Developers. Aaliya Siddiqui's name is also on the list of trustees.Back in 2000, Siddiqui and his brother Saood Ahmed were named in an FIR (no. 43/2000) under sections 420 (cheating), 406 and 409 (criminal breach of trust), 468

(fraudulent use of forged documents) and 120B (criminal conspiracy) of IPC at New Friends Colony Police Station in New Delhi.They were accused of misappropriating Rs 7.5 crore in an investment scheme they floated. Among the complainant was KR Singh, who alleged he was cheated of Rs 95 lakh through the scheme that induced people to make deposits in group of companies, which were converted into shares later by fabrication of documents. Asked about this, a source at Al-Falah said the case had later been quashed.Additional SP of Indore Rupesh Dwivedi said Siddiqui and his family used to live in Kayasth Mohalla in Mhow and his father Mohammad Hamid Siddiqui was the Seher Qazi of Mhow. "We are collecting information about his old contacts and r e l a t i v e s , " s a i d Dwivedi.Officials at Al-Falah University's Delhi office in Jamia Nagar told TOI on Wednesday it has no institutional connection to the doctors involved in the Old Delhi blast. The university's head office is located on the ground floor of a building

within a residential complex. Set in a quiet corner of a gated colony, the premises belongs to

the trust. Legal and finance officer Mohammad Razi said the university was unaware of the doctors' activities beyond their professional duties. "We have many meritorious students whose education should not be affected because of this," he said.Responding to claims that explosive materials were prepared in the university's laboratories, Razi said it was not possible to make such substances there. He said the university has biochemistry, anatomy, pathology and physiology laboratories where such materials cannot be kept. "We have children studying there. Why would someone want to set their own house on fire?" he asked.Earlier in the day, in its first reaction since the arrest of Muzammil on Oct 30, Vice-Chancellor Prof Bhupinder Kaur Anand expressed deep anguish over "unfortunate developments" and said the university was fully cooperating with investigations. Anand's statement said, "We have learnt that two of our doctors have

been detained by investigating agencies.

We wish to make it clear that the university has no connection with the said persons apart from them working in their official capacities with the university.

## Man arrested for running over roadside eatery operator in west Delhi

New Delhi: A man was arrested on Tuesday hours after he mowed down a 54-year-old roadside eatery operator near the Moti Nagar flyover in west Delhi, police said. According to police, Ramkaran was found dead near the flyover with injuries on his lower abdomen and forehead. A PCR call was received around 7.15 am regarding the body lying near a banquet hall on Najafgarh Road. "A police team reached the spot and found the body of a man lying across the footpath," a senior police officer said, adding that there were visible injury marks on his body. The body was later identified as Ramkaran, who had injuries on his lower abdomen and forehead. His personal belongings were also found scattered around the spot, the officer said. He further said that the area was cordoned off and crime and forensic teams were called to inspect the scene. The body was later shifted to Deen Dayal Upadhyay (DDU) Hospital for post-mortem examination. "During investigation, police examined several CCTV cameras in the vicinity and spotted a white Dzire car in a damaged condition, which was suspected to be involved in the accident," the officer added. Based on the findings, a case was registered. After technical surveillance and sustained inquiry, the accused driver, Mohit Yadav (25), from Guhori, Sector-53, Noida (Uttar Pradesh), was arrested, he said. Further investigation is underway, including verification of CCTV footage to establish the exact sequence of events leading to

#### Health Minister denies shortage of medicines at Lok Nayak Hospital

New Delhi: Delhi Health Minister Dr Pankai Kumar Singh on Friday termed media reports alleging medicine shortage at Lok Nayak Hospital baseless. The minister said after reviewing drug stocks across government hospitals, Medical Superintendents submitted reports confirming availability of essential medicines. Lok Nayak Hospital stated that all essential and life-saving medicines from the Delhi Government's approved drug list were in stock. It said daily monitoring of stock positions took place, with shortfalls replenished through procurement. The minister said, "The report from Lok Nayak, Sanjay Gandhi Memorial, Dr Baba Saheb Ambedkar and Lal Bahadur Shastri hospitals confirms the availability of over 40 critical items, including Amikacin, Meropenem, Vancomycin injections, vaccines, syrups, tablets, IV cannulas and normal saline." "Two items - injection Linezolid and syrup Ipravent - were not available as these were not on the essential drug list," he added. The government said medicine supply was an ongoing process, with shortages resolved promptly. A ground report from The Tribune, published on November 3, showed that empty shelves greeted patients at the Lok Nayak Hospital pharmacy. When The Tribune visited the ground, patients said they received one or two prescribed medicines, with the rest unavailable. They were directed to the Jan Aushadhi Kendra on the premises to buy discounted medicines. The Jan Aushadhi Kendra sold medicines at 50-80 per cent discount. The hospital authorities did not respond to The Tribune's request seeking clarification on the shortage of medicines and the redirection of patients to Jan Aushadhi centres.

#### Trump wants skilled overseas workers to 'train Americans' then 'go back home': US Treasury Secretary

A day after US President Donald Trump voiced support for the H-1B visa programme, Treasury Secretary Scott Bessent on Wednesday said that the administration's broader vision is to temporarily bring in skilled foreign workers to train Americans, before returning to their home countries.

The President's vision is to bring in overseas workers who have the skills that left with offshoring," Bessent said in an interview with Fox News. "Three, five, seven years, enough time to train US workers, then they can go home. The US workers fully take over."

Bessent's comments followed Trump's remarks earlier this week defending the H-1B visa system, which allows US employers to hire highly skilled foreign professionals, particularly in technology and engineering. Trump said that while America must develop its own workforce, it also needs to "bring in talent from around the world" to fill critical skill gaps.

For decades, Bessent said, the US has offshored advanced manufacturing and technical jobs, especially in sectors like shipbuilding and semiconductors."The President's point is that we can't just snap our fingers and expect Americans to learn how to build ships overnight," he said. "We want to bring the semiconductor industry back to the US."Describing the administration's approach as a "home run," Bessent emphasised that foreign experts would play a transitional role. "This idea of overseas partners coming in, teaching American workers, and then returning home, that's the goal," he said.

Washington: A deal to end the longest government shutdown in US history cleared Congress on Wednesday, after the House of Representatives voted to restart disrupted food assistance, pay hundreds of thousands of federal workers and revive a hobbled air-traffic control system. The Republican-controlled chamber passed the package by a vote of 222-209, with President Donald Trump's support largely keeping his party together in the face of vehement opposition from House Democrats, who are angry that a long standoff launched by their Senate colleagues failed to secure a deal to extend federal health insurance subsidies. The bill has already passed the Senate and the White House said Trump will sign it into law later on Wednesday, ending the shutdown. It would extend funding through January 30, leaving the federal government on a path to keep adding about \$1.8 trillion a year to its \$38 trillion in debt."I feel like I just lived a Seinfeld episode. We just spent 40 days and I still don't know what the plotline was," said Republican Representative David Schweikert of Arizona, likening Congress' handling of the shutdown to the misadventures in a popular 1990s US sitcom."I really thought this would be like 48 hours: people will have their piece, they'll get a moment to have a temper tantrum, and we'll get back to work."He added: "What's happened now when

#### France Marks 10th **Anniversary Of Paris** Attacks That Killed 130

Paris .(Agency)

France marks the 10th anniversary on Thursday of attacks in Paris in which Islamic State gunmen and suicide bombers killed 130 people in a rampage through cafes, restaurants and the Bataclan concert hall, and many survivors are still traumatized.

The attacks were the deadliest on French soil since World War Two, scarring the national psyche and prompting emergency security measures, many of which are now embedded in law. The assault began with suicide bomb blasts outside the Stade de France sports stadium where then-President Francois Hollande and the German foreign minister were watching a friendly soccer international, and continued with gunmen opening fire at five other locations in central Paris.

Starting at 11:30 a.m.(1030 GMT), President Emmanuel Macron will join officials, survivors and relatives of victims paying tribute to those killed and wounded in the attacks. The memorial events begin at the Stade de France and move on to the restaurants and cafés that were attacked, as well as the Bataclan. Attack On The Bataclan

Sebastian Lascoux was inside the Bataclan where the rock band Eagles of Death Metal were playing when what he thought was the noise from firecrackers pierced the concert hall. It quickly became apparent that the venue was under attack. People "ended up all squashed together and collapsed as one," he recalled. "And then (there was) the smell of blood," said Lascoux, now aged 46. One of his friends was shot dead trying to shield another member of their party.

"He saved her life," added Lascoux, who still suffers from post-traumatic stress and cannot be in crowded places or enclosed spaces, even cinemas. Loud pops remind him of gunshots. Like some other survivors, Lascoux plans to attend Thursday's commemorations." What made the November 13 attacks unique was that everyone was a potential victim," historian Denis Peschanski said

We're just going to make sure that they have integrity, that we're actually vetting the individuals who

want to be here for the right reasons, and that they're not supporters of terrorists and organisations that hate America," Noem said in an interview with Fox News.

Noem was responding to a question on the administration's position regarding H-1B visas, following Trump's recent remarks that the US must bring in talent from abroad because it lacks "certain talents."

"And that's what I think is so remarkable... under the Trump administration, we've sped up our process and added integrity to visa programmes, to Green Cards, to all of that. But also, more people are becoming naturalised under this administration than ever before. More people are becoming citizens because we're not just streamlining and rebuilding some processes into our immigration policies, we're also making sure that these individuals coming into our country and getting that privilege are here for the right reasons," she said. Noem further alleged that the Joe Biden administration had



They abused our asylum programmes, abused our protective programmes and visa programmes, and we fixed all of it. It's remarkable what President Trump has done, and it's because he's a great leader, a visionary, and this man is going to go down in history as our greatest president ever," she said. Trump recently defended the H-1B visa programme, stating that America needs to bring in talent from around the world."I agree, but you also do have to bring in talent," Trump said in an interview with Laura Ingraham on Fox News.Trump was responding to a question on whether H-1B visas would be a priority for his administration, given concerns that an influx of foreign workers could depress wages for Americans. When Ingraham noted that "we have plenty of talent," Trump replied, "No, you don't, no you don't. You don't have certain talents. And people have to learn. You can't take people off an unemployment line and say, 'I'm going to put you into a factory, we're

going to make missiles." Referring to a raid in Georgia, Trump said, "They had people from South Korea who made batteries all their lives. Making batteries is very complicated and dangerous, a lot of explosions, a lot of problems. They had 500-600 people in the early stages to make batteries and to teach people how to do it. But they wanted them to get out of the country. You're going to need that kind of expertise. You can't just take people who haven't worked in five years and expect them to start making missiles.

### Pakistan's prime minister offers talks to Afghanistan after deadly militant attacks

ISLAMABAD. (Agency)

Pakistan's prime minister on Wednesday offered talks to Afghanistan's Taliban government in a renewed peace overture, about a week after negotiations between the two sides collapsed in Istanbul, raising fears that a ceasefire brokered by Qatar and Turkey could unravel and trigger new border clashes.Shehbaz Sharif made the offer in a televised speech to parliament, a day after a deadly suicide bombing outside a court in Islamabad killed 12 people and wounded 27 others.

Seeking peace

Still, he said that Pakistan wanted peace in the region, because it was good for both sides, though there were "Afghan footprints" in this week's attacks.

'Let us sit with sincere hearts, rein in terrorism, and work together for peace and prosperity in the region," Sharif said. He said that during the recent rounds of talks in Doha and Istanbul,



Pakistan had only made one demand to Afghanistan: rein in the militants.

We want peace to prevail," he said, and "Afghanistan should realize that what is good for us is good for them. But it cannot be that they ake promises and then fail to act."There was no immediate comment from Kabul to Sharif's offer. The latest development came hours after Pakistanis buried their loved ones killed in the suicide bombing at an Islamabad court, as authorities opened an investigation into the assault. The bombing in Islamabad underscored the country's

challenges as the government struggles with a growing militancy, border tensions and a fragile truce with Afghanistan. Tuesday's attack at the district court, located on the edge of the city, raised alarms that despite multiple operations by security forces to crush the militants, they are still capable of mounting high-profile bombings — even in the Pakistani capital.Pakistan has struggled with a surge in militant attacks in recent years, but until Tuesday's bombing, Islamabad had largely been considered a safer place. Forensic teams and police were combing Wednesday through debris at the site of the blast, which had been sealed to preserve evidence. Across the city, grief-stricken relatives were receiving the bodies of their loved ones at an Islamabad hospital.

Later, funeral prayers got underway for some of the victims. Most of the 27 people wounded in the bombing had been discharged home after treatment.

#### US Says Boeing Owes \$28 Million To Family Of Indian Victim Of 2019 Crash

A US jury in the first civil trial over a fatal Boeing 737 MAX crash determined Wednesday that the aircraft manufacturing giant owes \$28.45 million to the family of a newly-wed Indian victim. The case involves the survivors of Shikha Garg of New Delhi, who died in the March 2019 Ethiopian Airlines crash, one of two fatal MAX crashes that together claimed 346 lives.

After about two hours of deliberation, a jury in federal court in Chicago returned with an award that included \$10 million for grief, \$10 million for Garg's pain and suffering, and other compensation.

The lawsuits stem from the March 10, 2019 flight that crashed six minutes after departing Addis Ababa for Nairobi, killing all 157 people on board.Garg's was the first case to go to trial after Boeing reached dozens of other civil settlements in cases brought by family members from the Ethiopian Airlines crash and from the Lion Air 737 MAX crash in 2018. Boeing had accepted responsibility for the Ethiopian Airlines crash and acknowledged the need to pay damages to Garg's survivors. But the trial weighed the sum, with Boeing's attorney contesting testimony from a plaintiff witness on the extent that

## A historic shutdown is over. It leaves no winners and much frustration

#### WASHINGTON . (Agency)

The longest government shutdown in history has come to an end, with almost no one happy with the final result.

Democrats didn't get the health insurance provisions they demanded added to the spending deal. And Republicans, who control the levers of power in Washington, didn't escape blame, according to polls and some state and local elections that went poorly for them. The fallout of the shutdown landed on millions of Americans, including federal workers who went without paychecks and airline passengers who had their trips delayed or canceled. An interruption in nutrition assistance programs contributed to long lines at food banks and added emotional distress going into the holiday season.

The agreement includes bipartisan bills worked out by the Senate Appropriations Committee to fund parts of government – food aid, veterans programs and the legislative branch, among other things. All other funding would be extended until the end of January, giving lawmakers more

than two months to finish additional spending bills.President Donald Trump signed the legislation Wednesday, just hours after the House passed it. #### What led to the shutdown

Democrats made several demands to win their support for a short-term funding bill, but the central one was an extension of an enhanced tax credit that lowers the cost of health coverage obtained through Affordable Care Act marketplaces.

The tax credit was boosted during the COVID-19 pandemic response, again through President Joe Biden's big energy and health care bill, and it's set to expire at the end of December. Without it, premiums on average will more than double for millions of Americans. More than 2 million



people would lose health insurance coverage altogether next year, the Congressional Budget Office projected."Never have American families faced a situation where their health care costs are set to double — double in the blink of an eye," said Senate Democratic leader Chuck Schumer, D-N.Y.While Democrats called for negotiations on the matter, Republicans said a funding bill would need to be passed first. "Republicans are ready to sit down with Democrats just as soon as they stop holding the government hostage to their partisan demands," Senate Majority Leader John

Thune, R-S.D., said. Thune eventually promised Democrats a December vote on the tax credit extension to help resolve the standoff, but many Democrats demanded a guaranteed fix, not just a vote that is likely to fail. Thune's position was much the same as the one Schumer took back in October 2013, when Republicans unsuccessfully sought to roll back parts of the Affordable Care Act in exchange for funding the government. "Open up all of the government, and then we can have a fruitful discussion," Schumer said then.Democratic leaders under pressure

The first year of President Donald Trump's second term has seen more than 200,000 federal workers leave their job through firings, forced relocations or the Republican administration's deferred resignation program, according to the Partnership for Public Service.

Whole agencies that don't align with the administration's priorities have been dismantled. And billions of dollars previously approved by Congress have been frozen or canceled.

#### Museum dog attack sparks demand to remove strays from public institutions

#### THIRUVANANTHAPURAM. (Agency)

The stray dog attack reported from the Museum premises has triggered widespread concern across the capital, with the City Corporation flooded with calls demanding the removal of dogs from public institutions. However, the absence of adequate shelters has landed the civic authorities in a fix.

On Wednesday, the Corporation's dog squad captured four dogs from the public office premises following complaints from officials. "We are getting numerous requests from various establishments to remove stray

But the lack of shelters to house them remains a serious challenge," said an official. In the wake of Tuesday's incident — where five morning walkers were attacked by a stray dog — the Museum authorities have decided to tighten regulations inside the campus.

Consumption of food brought from outside has been restricted to prevent dogs from being attracted to the premises. "We have put up display boards prohibiting eating in certain areas. Our resources are limited, but efforts are on to implement these measures effectively. People leaving food waste around is one of the main reasons for dogs entering the premises

One more dog was removed from the premises on Tuesday morning," said P S Manjula Devi, director of Museum and Zoo. She added there has been no decline in the number of morning walkers or visitors since the incident. When asked about the security arrangements in Chennai after the blast in Delhi, he said even though there is no direct threat to the city, 1,200 police officers and personnel have been deployed in checks across the city. "Since the blast occurred near a metro station in Delhi, all the locations in and around metro stations in Chennai were thoroughly checked," he

#### Cops in bind over late-night checks at history-sheeters' houses amid Kerala HC fiat


Police personnel in Kochi city are in a dilemma over conducting late-night checks at the homes of individuals whose names appear in the Rowdy History-Sheeter (RHS) list maintained by the home department. While senior officers insist on conducting late-night surveillance visits, the Kerala High Court has cautioned the police against entering houses of such individuals, leaving officers uncertain about how far they can go.

It is a regular practice to check the whereabouts of history-sheeters between 1am and 3am, and report details to higher officers. The practice was stopped after a High Court directive in June 2025 but restarted last month due to rising law and order issues," said a police officer attached to the Thoppumpady station's control room

During a recent night patrol in Thoppumpady, the police visited the house of a historysheeter named Thanseer. When the team knocked on the door, he objected, citing the court order. A brief scuffle followed before the police withdrew.

We get verbal instructions from our seniors to conduct such checks, but there is no legal backing for what we do. When suspects cite the court order, we have no answer," the officer added. A sub-inspector from the Kochi city police said that the High Court's directive stemmed from an earlier incident involving Prasad C, alias Odi Prasad, of Mundamveli.

#### **KSEB** assistant engineer accepts Rs 90k bribe, nabbed in Kochi

The Ernakulam unit of the Vigilance and Anti-Corruption Bureau on Wednesday nabbed an assistant engineer with the Kerala State Electricity Board (KSEB) as he was accepting a bribe of '90,000 from a builder at Thevara.

Predeepan N, a resident of Kaloor, who works at the KSEB's Thevara division office, was caught red-handed accepting the amount from the complainant near a bus stop at Thevara around 6 pm, said a VACB source.

The complainant, an assistant manager with a private construction company, approached the office to convert a temporary electrical connection to a permanent one at a fourstoreyed apartment building in Panampilly Nagar. However, the complainant was told that a permanent connection could be granted only if they met the assistant

The accused allegedly asked for a payment of Rs 1.5 lakh, and Rs 90,000 as a bribe and to avoid 'unnecessary hassles'. The complainant alerted the VACB DSP about the demand and a trap was laid," said the VACB official.

## BBMP chief inspects late-night road works, orders speedy completion of flyover projects

As part of the GBA's ongoing infrastructure projects, Chief Commissioner M Maheshwar Rao conducted a late-night inspection from 11.30 pm on Tuesday to 2.45 am on Wednesday to review the progress of whitetopping on Hennur-Bagalur Road, asphalting works on the Outer Ring Road and other stretches, as well as the completion of the Hosakerehalli flyover and the JC Road white-topping project.

White-topping work from Minerva Circle to Town Hall (1 km stretch) on JC Road is in progress. Half of the road has already been completed and opened for traffic, while the remaining 250 meters of work will be finished within four days," said Rao.

He issued strict instructions to the contractor to expedite the work. He also noted that the Hosakerehalli Flyover construction has been completed and minor pending works such as line marking and signage, are to be done.

The Bengaluru East City Corporation is executing approximately 5 km of the Hennur-Bagalur Road with whitetopping work. During his previous visit last week, the chief commissioner had issued strict instructions to the contractor to expedite the work, following which the work has gained

Rao said that out of the 5 km stretch, whitetopping has already been completed for 1 km on one side and 600 meters on the other. To accelerate completion, traffic will be

restricted on a 1.2 km portion from Poorna Prajna School to Gubbi Cross, allowing twoway movement on the remaining half.

The work is to be completed within 25 days, after which vehicular movement will be allowed on the finished section.

Subsequently, similar phased restrictions of 1.5 km segments will be implemented, as per the approval granted by the Traffic

Γο prevent traffic congestion during the execution of works, Rao directed the DCP to deploy Home Guards to ensure no vehicles are parked along the work zones and to manage the traffic flow efficiently.

At Bhadrappa Layout, asphalting work is underway under the High-Density Corridor Project to repair damaged road surfaces. The Chief Commissioner instructed that quality be maintained and proper slope ensured for effective drainage of rainwater into the stormwater drains. #### Arkavathi allottees get alternative sites in NPKL; call BDA's move 'justice delayed'

While the 755 site allottees of Arkavathi Layout who were unable to take possession of their sites were given alternative sites at the Nada Prabhu Kempegowda Layout (NPKL) in just 15 minutes, with Bangalore Development Authority (BDA) claiming it a historical move, the allottees are not happy.

They point out that NPKL is underdeveloped and may need five years to be developed, and their dream of owning land and building a home is still a distant dream.

BDA said that those who were running from pillar to post since 2005 to get an alternative site were awarded sites in NPKL, through the computer randomisation process on November 10 and claimed the move a historic milestone.

Advocate Rajeev K Jha, who represents the Arkavathi site allottees, said that they aren't happy with the allotment. "There is so much struggle the allottees have undergone since 2005. Their dream of owning a plot in Bengaluru and building their own house continues to remain a distant dream. NPKL is not fully developed, and allottees cannot even reach their sites easily; that much underdeveloped is the layout. Given the track record and the nature of the BDA's working style, it would take another five years for the road works and all the civic amenities to be built on the layout."

'BDA is trying to cover up bad things", he said. "Imagine the loss of benefits the site owners would have got by now, if there were no issues with the Arkavathi Layout. A father would have invested in land for himself in 2005 in the Arkavathi layout. But BDA has made it a generational purchase where his son or grandson may get the site", he said.

Some of the site owners of NPKL said that there is a lot of development work that is due in the layout. While they admitted that things are moving fast after P Manivannan took over as the Commissioner of BDA, they said

## Next in Trump's crosshair: The United Nations

United States President Donald Trump is taking aim at the United Nations. Reshaping it is his next big foreign policy project. Trump aims first to try to bend the UN to his will, capture it, and remake the world body in his image. If he fails, he will try to discredit the UN and destroy it. But destroying the UN will be easier said than done. Notwithstanding its institutional rough edges—like the veto power for a few in the 15nation UN Security Council (UNSC)—the world body in its present form is the most democratic global institution that humankind has known. The one-country-one-vote functional foundation of the UN General Assembly (UNGA), "the main policy-making organ" of the UN, means 2.02-sq-km Monaco has the same rights and privileges in the UNGA as the US, the sole superpower. India is credited with having contributed to the inscription of the one-member-one-vote principle as Article 18 of the UN Charter during negotiations in 1945 in San Francisco for its adoption. How does the 47th US president plan to go about his designs for transforming the UN? His first shot in this plan is likely to be fired at the end of this year, soon after the General Assembly president and the UNSC send a joint letter to all UN members inviting nominations for the post of the next UN secretary-general. It is one of toughest diplomatic jobs in the world. By convention, incumbent secretary-general António Guterres's successor should be from Latin America and the Caribbean. Trump would like the post to go to a US national, someone with a mind like his. But any such attempt would be vetoed by Russia and China, probably by France as well. Then, Trump's next step would be to induct a non-American who is sympathetic to his worldview. Tracking Trump's words and actions on the global stage so far in his second presidential term, it is increasingly clear that he views the UN favourably now. That is the inverse of his attitude towards the UN when he was president from 2017 to 2021. Within days of moving into the White House this year, Trump turned his back on the UN's Human Rights Council, its Educational, Scientific, and Cultural Organization, and its Relief and Works Agency for Palestine Refugees in the Near East. Then he showed up at the UNGA on the opening day of its annual General Debate on September 23. He arrived at the UN headquarters with a scowl: seven years ago, when Trump addressed the General Debate, the delegates laughed at him. He was ridiculed for his fantasies, his fictitious statements that did not bear factchecking. Trump did not know what to expect during his latest address. To the US president's great surprise, there were no sniggers, no derision. The entire UNGA listened to him silently, in attention. Trump was given 15 minutes, but he spoke for about an hour. Nobody stopped him. The General Assembly president, who did not hide her true feelings for Trump in her previous job as Germany's foreign minister, did not use her gavel to cut short the US president. For Trump, this was more comforting than having to address the US Congress, where the chamber is almost equally divided between his Republican supporters and hostile Democrats who don't listen in silence to the president's State of the Union address. Trump clearly liked being at the UNGA this year. By all accounts, the contrast between how his speech was received at the UN two months ago and his humiliation at the same venue in 2018 was a turning point. ### The Guru gave his all for freedom of faith

Guru Tegh Bahadur's supreme sacrifice carries a timeless message for posterity

THE 350th anniversary of Guru Tegh Bahadur's martyrdom falls on November 24. Union and state governments, besides several organisations, including the RSS, are commemorating the occasion. While doing so, the focus must remain on the historical context and the correct message that the Guru's supreme sacrifice holds for posterity. A narrow interpretation may merely recount the bigotry of some Mughal emperors, especially Aurangzeb. The Sikh religion evolved over two centuries, from the foundation of Kartarpur town by Guru Nanak Dev in 1504 to the creation of the Khalsa by Guru Gobind Singh in 1699. During this period, the Mughals

first captured power, then lost it and later regained it under Humayun; their empire peaked under Akbar and eventually declined after Aurangzeb's death.


Guru Arjan Dev (1606) and Guru Tegh Bahadur (1675) chose self-sacrifice over abandoning their religion or performing miracles. As the two sagas run parallel, their crucial linkages need to be analysed to understand Sikhism's defence of freedom of faith. Guru Nanak Dev is said to have first encountered Emperor Babur in Hyderabad as his forces advanced into India. Babur's successor Humayun lost the throne of Delhi to Sher Shah Suri; heading for exile in Iran, he made a halt to seek the blessings of Guru Angad Dev, the second Sikh Guru, in 1540. Two vital inflection points occurred during the Mughal rule which impacted Sikhism's evolution.

It is important to recall that Emperor Akbar's long reign (1556-1605) coincided with that of three Sikh Gurus — Guru Amar Das (1552-74), Guru Ram Das (1574-81) and

Guru Arjan Dev (1581-1606). Akbar's religious tolerance, the espousal of Din-i Ilahi (Religion of God) in 1582 and repeal of jaziya or tax on non-Muslims created an ethos in which Sikhism could flourish. Akbar visited Guru Amar Das in 1567 and also partook of langar.

Akbar favoured his grandson, Prince Khusrau, to succeed him as he considered his eldest son unfit to rule. But that son, Jahangir, succeeded him in 1605. When Khusrau rebelled against his father in 1606, he met Guru Arjan Dev on the way to Lahore. The Mughal army defeated and captured him. Although Jahangir was not totally bigoted, he could be unpredictably vindictive. He targeted Guru Arjan Dev mainly because the latter had received his rebellious son. Had Khusrau succeeded Akbar, perhaps tolerance and religious freedom would have persisted in India. After Guru Arjan Dev passed away in Mughal captivity, the Sikh religion mutated

under his son and successor Guru Hargobind, adopting martial training alongside religious discourse. He began carrying two swords, representing Miri and Piri, symbolising the temporal and the spiritual. Guru Hargobind's period (1606-44) bridged the reign of Jahangir (1605-27) and Shah Jahan (1627-58). His limited Sikh force successfully fought six battles with the Mughal forces, sent by Shah Jahan, until a grown-up Dara Shikoh, the heir apparent, restrained targeting of Sikhs. The second inflection point came when Shah Jahan's sons became rivals over succession. The eldest, Dara Shikoh, favoured Sufi thinking and religious tolerance, besides



peaceful coexistence between Hindus and Muslims. He translated the Upanishads from Sanskrit to Persian to enable Muslim scholars to study them. Shah Jahan's illness in 1657 started a power tussle. Dara fell seriously ill due to suspected poisoning by his main rival, Aurangzeb. Guru Har Rai, specialising in ayurveda, sent medicine that cured him. Dara sent gifts to the Guru in gratitude. However, he was defeated on the battlefield by Aurangzeb in 1658. He sought refuge in Punjab. The Guru extended him material help and obstructed Aurangzeb's forces to assist his escape. Betrayed by former associates, Dara was captured and eventually killed.Destiny again betrayed India and the Sikh Gurus. The Sufi lost to a bigoted fundamentalist. When summoned by Aurangzeb in 1660, Guru Har Rai sent his son Ram Rai, who was held hostage. When questioned about Adi Granth hymns ostensibly berating Muslims,

Ram Rai amended them in a bid to please Aurangzeb. The Guru excommunicated him, passing the succession to his younger son Har Krishan, who succeeded him a year later. Aurangzeb lured Guru Har Krishan to Delhi, where he contracted smallpox and passed away in 1664. Since he had declared that a Baba from Bakala would be his successor, many claimants came forward. Eventually, Guru Tegh Bahadur emerged as the chosen one.

Thus the eventual confrontation between Aurangzeb and the ninth Guru was not just over Pandit Kirpa Ram leading a delegation of Kashmiri Pandits to seek the Guru's protection against forced conversion to Islam. It was an

old tussle, reignited afresh, between the forces of bigotry and freedom of faith. It led to the birth of the Khalsa and greater resistance to Muslim invaders like Ahmad Shah Abdali and the remnants of the Mughal empire in Delhi. Today, there is a regression towards majoritarian, religioninfluenced rule globally and in India, with secular constitutions or governance being put to the test. The US, once a model of secular governance with a wall between the Church and the State, is witnessing rising White Christian supremacism. The White House ordered flags at half-mast when a bigoted Charlie Kirk was shot. US Vice-President JD Vance publicly pushed his wife to convert from Hinduism to Christianity, wooing MAGA supporters. President Donald Trump's strong supporter, Vivek Ramaswamy, a candidate for Ohio's governorship, was trolled by MAGA followers on religious and racial grounds after he posted a photo with his sons on Halloween.In India, minorities,

especially Muslims, feel targeted, especially when their nationalism is questioned. Proponents of Khalistan, such as Lok Sabha MP Amritpal Singh and his aides, are detained, but slogans and processions in support of Hindu Rashtra are tolerated. The rise of far-right parties in Europe has increased the risk of secular walls crumbling there too.

Ience, the commemoration of Guru Tegh Bahadur's 350th death anniversary demands not just recrimination of past bigotry but renewed commitment to freedom of faith and conscience, which the Indian Constitution safeguards. Article 18 of the Universal Declaration of Human Rights, adopted by the UN General Assembly in 1948, affirms this resolve. All must accept that true faith, as the Gurus demonstrated by self-sacrifice, lies in the acceptance of one Supreme God, ethical conduct and public service, besides being tolerant of multiple paths that lead to Him.

#### ECI must address trust deficit with transparency

The 'vote chori' campaign may seem like a show with little political impact; however, the concerns raised deserve to be dispelled through sound answers and actions

The credibility of India's elections is the strength of its democracy. Rahul Gandhi's persistent assault on the impartiality of the Election Commission of India has managed to sow a seed of suspicion about the integrity of one of the principal pillars of that credibility. As the Congress leader continues with his campaign against alleged 'vote chori'—something that became an issue at the just-concluded Bihar polls—the onus is squarely on the ECI to address the trust deficit. Mere dismissal of the diligently-gathered accusations is utterly inadequate in countering the allegations of fraud and restoring the public's trust in the electoral system.Rahul's latest presentation was based on the 2024 Haryana assembly election, where he alleged the BJP won with the help of 25 lakh 'fake votes'. While claiming that one in eight voters in the state was fake, he showed the picture of one woman that allegedly appeared 223 times on the voter list; another woman, apparently a Brazilian model, appeared 22 times under different names at 10 booths. At an age when election controllers around the world are considering 'pre-



bunking'—publishing factual information before disinformation is aired—the ECI has chosen an ostrichlike posture. To the accusation Gandhi levelled in August citing data from Karnataka's Mahadevapura, the ECI responded by asking him to register a formal complaint.

This time, its defence was that no appeal had been filed against the rolls and no multiple voting flagged during the election. Fair enough. But how does one explain 223 listings for one voter? Whether flagged in time or not, such gross anomalies punch holes in the touted impregnable fairness of the election process. The 'vote chori' campaign may seem like a show with little political impact; however, the concerns raised deserve to be dispelled through sound answers and actions. If not satisfactorily addressed, it will remain an issue at the upcoming elections. A recent survey that flagged a sharp drop in public trust in the ECI underscores the need to protect the constitutional body's image as an independent and impartial entity. That deficit is the reason the special intensive revisions, aimed at restoring the integrity of electoral rolls, have come under a

shadow. The honour of being the world's largest democracy also comes with an enormous responsibility of safeguarding the credibility of the election process. That task belongs mostly to the ECI.

## For due diligence on claiming your dues

When honouring claims is inefficient and rejection rates high, getting your rightful dues can be a nightmare. In the spirit of the govt campaign 'Your money, your right', particular attention should be paid to the EPFO, most of whose subscribers need help with the claims process

This October, the finance minister launched the nationwide campaign 'Your money, your right'. The objective is to make people aware of unclaimed funds and assets of up to ?1.84 lakh crore lying with various authorities. Coming after the GST and income tax incentives, unleashing such idle funds could further help private consumption and economic growth.

The expression 'your money' has three distinct dimensions. The first concerns 'unclaimed' assets—belonging to rightful owners who are unaware of their holdings. The solution lies in facilitating the 'claiming of the unclaimed' through greater awareness, accessibility, and procedural simplification. The second dimension concerns 'withheld' assets, where the owners are aware of their assets but have been unable to claim them, often despite repeated efforts. While the awareness campaign is expected to increase the number of claims, its real success will depend on the response of the custodians of such claims. It calls for an institutional commitment to 'release the withheld' promptly and efficiently. The third dimension concerns the flow of such assets, 'serve the claimed'. Custodians must proactively identify, trace, and return assets to their owners before they become unclaimed. This forward-looking approach will give full effect to the campaign's principle. The Reserve Bank seems to have become active on all three dimensions since launching the unified database for unclaimed deposits or UDGAM portal in August 2023. Further, this

September 26, it issued directions simplifying procedures for settling accounts of deceased depositors to nominees or to legal heirs. Shortly thereafter, it introduced an innovative, incentivebased scheme to reduce the stock of unclaimed deposits in the Depositor Education and Awareness Fund. The Insurance Regulatory and Development Authority has made tangible progress since 2022 in strengthening its Bima Bharosa portal, an integrated grievance redress system to facilitate claim settlements. The Securities and Exchange Board has operationalised the Mutual Funds Investment Tracing and Retrieval Assistant or MITRA, while the Pension Fund Regulatory and Development Authority has introduced a facility enabling subscribers to claim refunds.A key to address all three dimensions lies in honouring the claims in time rather than rejecting them on technical or procedural grounds. Consider the case of the Investor Education and Protection Fund, which reportedly holds unclaimed assets about ?1.1 lakh crore, comprising roughly ?9,000 crore in unpaid dividends and about ?150-crore unclaimed securities. These assets accumulated because companies and their registrars and transfer agents failed to disburse them to the rightful owners for several years. An authority was established in 2016 to facilitate the refund of unclaimed assets. However, its track record of refunds is yet to be inspiring. During 2023-24, while about 17,000 applications were approved, nearly 34,000 were rejected. Most of the unclaimed or withheld money

represents amounts individuals voluntarily deposited or invested. However, the situation is perhaps worse where they are mandatory, like subscriptions to pension or provident funds. The Employees Provident Fund Organisation (EPFO) is a glaring example of the challenges in ensuring



Your Money, Your Right'. A statutory body with 73 years of experience, it manages over ?28 lakh crore in funds for some 8 crore active members. The EPFO primarily serves the lowest rungs of the working class, who require special support on their savings-to-pension journey. As both an empowered regulator and service provider, it should have been a model of efficiency. However, the reality is different. The claim that there's only ?8,500 crore in unclaimed funds, even if correct, masks the deeper problems. EPFO's annual report for 2023-24 shows that overall, 25.5 percent of claims were rejected. Delays compound the problem, with 40 percent percent of claims taking more than 10 days to settle. On paper, the reasons for rejection appear reasonable. However, anecdotal experiences tell a different story. Of rejection on account of 'inadequate balance' at the age of 65, 'multiple unique account numbers', 'need to recheck of retirement rules of the organisation'; Issues with the digital interface turns out to be an obstacle race with multiple checkposts and desk officials, each one dismissing casually. There is also a deep disconnect between the system genie and humans, leaving even a few well-intentioned officials helpless, making citizens trapped in endless loops.

Our experience made us recall the horror story of a subscriber in Kochi who committed suicide after nine years of pursuing his PF claims. Not surprisingly, this has spanned a parallel ecosystem of brokers who charge up to 20 percent to help people access their funds, since it takes '25 steps to withdraw your own money'. Hope, EPFO 3.0 will reduce the disconnects between humans and machines, and the incentive problems. Semifunctional processes and apps without application of mind are a disservice to our people. Systems must enable subscribers/rightful owners to realise their assets, like digital bank account transactions. While all systems must be efficient and customerfriendly, compulsory systems must be perfect. Only perfect systems can make your money your right. If that cannot be guaranteed by their custodians, such schemes should shift to a voluntary mode so that their users need not crush their heads in singlewindow routes to prolonged traps.

#### Chandigarh administration mulls extending Mayor's term to 5 years

The Chandigarh Administration is preparing to give a go ahead to enhance the Mayor's term to five years. According to sources, Chandigarh Administrator Gulab Chand Kataria has asked the UT officers to prepare a report on the matter in a meeting with the Chief Secretary and other officers that took place at Raj Bhawan.

Already, the Administrator has changed the way of voting in Mayoral elections by way of show of hands, which will be implemented in the next election in a bid to prevent cross voting.

The Administrator has asked to prepare a report so that it can be sent to the Ministry of Home Affairs, which will further decide on the issue. Already Panchkula and Mohali have the Mayor's term for five years and a similar provision is being pushed for Chandigarh as well," a senior official of the Chandigarh administration said.

A Mayor in Chandigarh is elected from amongst the elected councillors for a oneyear term. Every year in January, the Mayor elections take place in the 'City Beautiful'.

In Chandigarh, all executive powers rest with the Commissioner of the civic body, while the Mayor has none. The Mayor has just one power, which is to convene a House meeting or any meeting or just decide on which all agendas to bring in the General House meeting. All the previous Mayors have been complaining that despite them and the councillors being the only elected representative in the Union Territory (UT), they have no powers to get residents' works done. A councillor or a Mayor has to request the administration officials and ensure a good bond to see that work is done

#### Gujarat DGP holds meet with senior officers, stresses importance of human intelligence

DGP Vikas Sahay on Wednesday headed a meeting with senior officers of the Gujarat Police through video-conferencing, following the alert in the wake of the blast in Delhi on Monday.

A statement from his office said, "With emphasis on ensuring citizen security, the meeting discussed in detail about strengthening the entire infrastructure of all field units including ATS." Sahay also reviewed the performance of the Special Operations Group (SOG) of all districts.

DGP Sahay underlined the importance of human intelligence not just for specialised units, but all police personnel, sources said. The sources said Sahay issued instructions on maintaining a registers of accused persons, including those with criminal history, who have been arrested earlier, especially in serious crimes related to terrorism activities, as well as those booked under the Unlawful Activities Prevention Act (UAPA) and Terrorist and Disruptive Activities Prevention Act (TADA), and other major crimes especially those involving drugs, arms, fake currency, and to monitor their whereabouts and activities.

#### 'Ricin terror plot': Two accused from UP studied at same madrasa in Muzaffarnagar

#### Lucknow .( Agency)

Two of three men arrested by the Gujarat Anti-Terrorist Squad (ATS) last week in connection with the alleged Ricin terror plot were studying Hafiz courses at the same madrasa in UP's Muzaffarnagar.

While their families claimed the men were innocent, police had said the accused were allegedly plotting attacks using the lethal toxin and conducting reconnaissance of potential targets — including the RSS office in Lucknow, the Agriculture Produce Market Committee in Azadpur, Delhi, and the fruit market in Naroda. The ATS had arrested the trio - Dr Ahmed Mohiyuddin Saived (35) from Hyderabad; Azad Suleman Sheikh, (20) from Shamli; and Mohammad Suhail (23) from Lakhimpur Kheri — on November 8. Senior officials said they were trying to produce Ricin.

Azad is a resident of Jhinjhana in Shamli. His elder brother, Shezad Saifi, who works as a construction labourer in Sonipat, told The Indian Express: "Before Covid, Azad was studying at a madrasa in Muzaffarnagar's Budhana. During the lockdown, the madrasa shut so I took him with me to Sonipat, where he did odd jobs - repairing sewing machines etc. Once the madrasa reopened, he returned to his studies.

Around two months ago, his family said that Azad had returned from a Jamaat trip to West Bengal; he had gone with 12 others. "On November 7, he said he was going to the madrasa... On November 8... I received a call from a police officer in Gujarat about Azad's arrest.""There must be some misunderstanding...," he added. The family said they were aware Suhail was also studying at the same madrasa. Suhail is from Lakhimpur Kheri's Nighasan. His father, Mohammad Saleem, said, "Around three years ago, when the Covid situation improved, Suhail joined the madrasa in Muzaffarnagar to pursue Hafiz studies.' Saleem said the family came to know about Suhail's arrest only when they received a call from the police.

## Pathways on Railway Bridges Strengthen Safety and Accessibility across NFR

#### Ricin poison terror plot: Gujarat ATS searches Hyderabad doctor's house, seizes chemicals & raw material

AS PART of its probe into the alleged Ricin terror plot, the Gujarat Anti-Terrorist Squad (ATS) conducted searches at the residence of the arrested Hyderabad doctor on Tuesday and Wednesday, said officers. Sources said Cyberabad police personnel observed from a distance as the ATS team seized unidentified chemicals and raw material in cartons from Dr Ahmed Mohiuddin Saiyed's flat in Rajendranagar.

A team from the Gujarat Anti-Terrorist Squad (ATŠ) searched the home - that was also a 'workshop' – of 35-year-old Saiyed, main accused in an alleged bio-terror plot using the deadly chemical agent, Ricin. The team found "substances and material" that will be sent to the

Forensic Science Laboratory for

Sources told The Indian Express that primarily it appeared, on the basis of interrogation of the accused, that he had not yet successfully isolated the toxin from Castor beans (Ricinus communis) before his arrest in Gujarat and neither had he decided what delivery mechanism to use in the purported bio-terror attack that the ATS said it had foiled.

However, investigators in Gujarat are looking closely at the 2018 Ricin bomb plot in Cologne, Germany, where a radicalised couple had allegedly successfully isolated Ricin. However, they were apprehended before any attempt at an attack could be carried out.

On Sunday, the Gujarat ATS claimed that Dr Saiyed was a member of a suspected terror module and was allegedly preparing Ricin — a lethal toxin to carry out large-scale attacks. His handler, Abu Khadija, the ATS claimed, is associated with the Islamic State Khorasan Province (ISKP). Two other men from Uttar Pradesh were also arrested in connection

The Centre, however, said the joint meetings "may not be in conformity with the mandate of DISHA committees". The Centre's directions came after Ambala Congress MP Varun Chaudhary raised objections to the state's July instructions.

Speaking with The Indian Express on Wednesday, Chaudhary said this (the state's

July instructions) was apparently an attempt to "undermine powers of Members of Parliament in their respective constituencies,

> even as the Congress has as many Lok Sabha members as the ruling BJP (five each) from Haryana."

Both meetings have distinct mandates, Chaudhary said. "The DISHA committee meetings, chaired by a state minister, monitor the centralsponsored schemes, while the Grievances Committee meetings, chaired by the MP listening to individuals' grievances.'

In July, the Haryana Development and Panchayats Department had instructed all deputy commissioners that both meetings would be convened on the same day and attended by both the minister and the MP. The department also issued a rotational schedule for all districts up to August 2026, which a section of Congress leaders viewed as an "encroachment on the rights of Mps".

In a letter to Union Rural Development Minister Shivraj Singh Chouhan on September 25, Chaudhary termed the state's instructions "totally against the guidelines issued by the Union Ministry of Rural Development and the federal system". Chaudhary wrote, "It's also not practical for a minister and an MP to be available on the same day as a DISHA meeting takes six to eight hours."

## **155 fresh farms fires in Punjab: SC directs Punjab to file** report on steps taken to curb stubble burning

The foundation of these convictions rested heavily on Koli's alleged confessional statement and the recovery of human remains from the drainage system behind House Number D-5, Sector 31, Noida. Another five years passed before the tide turned.

#### OCTOBER 2023: THE SCRUTINY OF No evidence against Pandher: The evidence **ERROR**

The appeal process brought the entire edifice of the investigation before the scrutiny of the Allahabad High Court. In a critical intervention in October 2023, the court began a systematic dissection of the prosecution's evidence, revealing flaws deemed fatal to the legal process.

Koli's confession was involuntary: Koli's key confession was inadmissible, having been extracted after prolonged, unauthorised police custody without adequate legal safeguards, thus violating fundamental constitutional rights. Evidence was tainted: The recovery of

against Pandher was found to be insufficient to connect him to the acts of murder or abduction. With these findings, the Allahabad High Court overturned all death sentences and life terms, acquitting both Surendra Koli and Moninder Singh Pandher. Only one case remained.

#### THE FINAL JUDGEMENT: CURATIVE **PETITION (2025)**

The final legal chapter closed in November

2025. Facing the sole remaining conviction against Koli (the Rimpa Haldar case, upheld in 2011), the Supreme Court invoked its curative

jurisdiction.

It ruled that since the identical evidence used in the 12 other cases had been definitively rejected as inadmissible, to maintain the conviction in the final case would constitute a "manifest miscarriage of justice."

This final judgment led to the complete acquittal of Koli. The judicial record concluded that the prosecution had failed to establish the guilt of the accused "beyond a reasonable doubt."

Koli, once just a few hours away from the gallows, was ordered released based on the integrity of legal procedure overriding the gravity of suspicion.

#### WHO KILLED THE NITHARI VICTIMS?

An alternate theory suggests that the Nithari killings were not acts of an isolated perpetrator, but part of an organised criminal syndicate involved in illegal organ harvesting.

Forensic evidence, such as the surgical precision of dismemberment, missing torsos in recovered remains, and absence of blood or murder weapons at the primary crime scene, pointed to professional medical involvement in the narrative of rape and

murder. However, it was systematically ignored by the Uttar Pradesh Police and the Central Bureau of Investigation (CBI), leading to sharp judicial criticism in the 2023 Allahabad High Court verdict. The Allahabad High Court in 2023 condemned this failure vividly: "The possibility of organ trade being the cause of killings in Nithari, particularly when the resident of adjoining house i.e. House No. D-6, Sector-31, Noida, had been arrested earlier in a case of kidney scam has not been properly probeD."With Koli's acquittal, the organ-trafficking theory remains the most plausible alternative, exemplifying systemic failures—bias against the marginalised, investigative shortcuts, and the inability to dismantle entrenched criminal networks.

#### Centre Orders Probe Into Al Falah University's Funding After Delhi Blast

New Delhi.(Agency)

The government has ordered the Enforcement Directorate (ED) to conduct a probe into the funding of the Al Falah University in Faridabad that has emerged as a key link between the terror suspects arrested over the Delhi blasts, sources said. It was at this institution that the conspiracy was allegedly hatched to carry out the 10/11 blast. The centre has now sought a forensic audit of the accounts of the Al Falah University. Besides, the Economic Offences Wing (Delhi Police) has also been asked to look into its functioning.

The National Investigation Agency (NIA) had already been probing the Delhi blast. The financial investigation agencies swung into action after at least four doctors of the university were found linked to the blast that ripped through the heart of the national capital on Monday evening. At least 13 died and nearly two dozen were injured after a Hyundai i20 car exploded in slow-moving traffic near the Red Fort on November 11.

#### The Al Falah Connection

Spread over 70 acres, the Al Falah is a private institution located about 27 km from the Delhi-Haryana border. Dr Umar Mohammad, driver of the i20 that exploded on Monday, was a doctor at the university. So were Dr Shaheen Saeed, Dr Adil Rather, and Dr Muzammil Shakeel; all are in police custody currently and are being questioned. The police have found incriminating materials in the room of Dr Muzammil Shakeel at the university. This includes the diaries of two doctors that contained coded messages, besides electronic devices

#### "Asli Kaam After 4 pm": What **Red Fort Blast Terror-Accused Doctor Said**

Dr Shaheen Saeed - a key suspect in the Delhi Red Fort blast case - would speak darkly of her 'work' starting only after 4 pm every day, after she clocked out of her 'day job' at the Al-Falah School of Medical Sciences and Research Centre in Faridabad, sources told Thursday.Saeed also carried a rosary (known in Islam as misbaha or tasbih) and a hadith book (a collection of Prophet Muhammad's teachings), officials familiar with the investigation said.

A colleague of hers told of her 'strange behaviour'; she did not adhere to the institution's rules and would often leave without informing anyone, he said, asking not to be named. The institute, which has been served a show-cause notice by the NAAC, has distanced itself from the Red Fort attack and pledged cooperation with the investigation and "unwavering commitment to the security of the nation". Earlier this week Saeed was identified as the head of the women's wing of Pakistan-based Jaish-e-Mohammed terrorist group. Intelligence suggests the JeM - responsible for the 2001 attack on Parliament and the 2019 Pulwama assault - was running this particular cell.

A resident of Lucknow's Lal Bagh, Saeed was arrested Monday, hours before a panicked fourth member of the terror cell - DNA tests identified him as Umar Mohammad - drove and detonated a Hyundai i20 stuffed with explosives near the Red Fort, killing himself and 13 others.

Intelligence sources said Saeed earlier served as Head of the Pharmacology Department at the Kanpur Medical College. She was later transferred to the Kannauj Medical College.

Two other suspects - Dr Mujammil Shakeel and Dr Adil Ahmad Rather - were arrested before Saeed, underlining a worrying 'white-collar terrorist' angle to the probe.

At least two of the cars used by the suspects have been traced back to Saeed - a Maruti Swift Dzire from which police recovered an assault rifle and ammunition, and a Maruti Brezza that may have been the preferred bomb delivery car if the police had not identified the terror cell.

Taking to X, Chaturvedi wrote, "Would you have an idea what happened to the 'any act of terror will be considered an act of war' decision by the central government after the Pahalgam terror attack? Asking not for a friend, but for my nation. No compromise on this — need a tough response to such terror planners based in Pakistan".

Her remarks came days after an explosives-laden car detonated near Red Fort, killing 13 people and injuring several others. The government has termed the attack a "heinous terror incident" and directed agencies to investigate with "utmost urgency and professionalism". In April, after the Pahalgam terror attack that killed 26 people, including tourists, Defence Minister Rajnath Singh had announced a major policy shift declaring that any act of terror against India would be considered an act of war. "It's now our policy that we will proactively eradicate terrorists wherever they are. Any act of terror is now considered an act of war," Singh had said after a high-level meeting chaired by Prime Minister Narendra Modi.

That meeting, attended by NSA Ajit Doval, CDS General Anil Chauhan, and the service chiefs, marked one of the strongest policy pronouncements on terrorism in recent years. Singh had also warned that unless Pakistan took credible action against UN-designated terrorists such as Hafiz Saeed and Masood Azhar, India's future engagement with Islamabad would remain limited to issues of terrorism and Pakistanoccupied Kashmir (POK).

## India's CO2 Emissions See Slower Increase In 2025: Report

New Delhi.(Agency)

India's carbon dioxide emissions were projected to rise by 1.4 per cent in 2025, marking a slower according to a report published on Thursday by a global network of more than 130 climate scientists and research institutions. The slowdown is attributed to an early monsoon that reduced cooling demand and to rapid growth in

renewable energy, which kept coal use almost flat, the Global Carbon Budget 2025 report, released at COP30 in Belem, Brazil, said.Despite this moderation, the report warned that India's emissions continue to grow

Globally, fossil-fuel carbon dioxide (CO2) emissions were expected to reach a record 38.1 billion tonnes in



2025, up about 1.1 per cent from 2024. China's emissions were projected to rise by about 3 per cent in 2025, driven mainly by continued industrial activity and growth in coal consumption despite record renewable additions.

The United States, the world's secondlargest emitter, is expected to see its emissions fall by around 2.2 per cent due to declining coal use and slower oil demand. The European Union's

emissions were projected to drop by 4.2 per cent. Together, these four top emitters account for nearly 60 per cent of global fossil CO2 emissions. The study said the remaining carbon budget consistent with limiting warming to 1.5 degrees Celsius has fallen to roughly 170 billion tonnes of CO2, barely four years of emissions at current levels.

Atmospheric CO2 concentrations are projected to climb to 425.7 parts per million next year, around 52 per cent above pre-industrial (1850-1900) levels.

The report said the planet's ability to absorb CO2 through land and ocean sinks is weakening. The scientists estimated that about 8 per cent of the increase in atmospheric CO2 since 1960 is due to climate change reducing the effectiveness of these natural sinks.


Jacob Duffy's early burst and a clinical New Zealand chase handed the hosts a comprehensive eight-wicket victory over the West Indies in the fifth T20I at Dunedin as the visitors crumbled in tricky, seaming conditions. The West Indies innings never really recovered after a reckless start. On a pitch that demanded caution up front, the visitors went after the bowlers and immediately paid for it, losing half their side inside the powerplay. Duffy controlled the lengths and exploited the awkward bounce to great effect, repeatedly finding the corridor and troubling the batters. He finished with superb figures of 4 for 35, ripping through the top and middle order in quick time. There were some brave counter-attacks lower down. Roston Chase battled with intent to make 38 off



32 balls, and Romario Shepherd produced late carnage with 36 off 22 to add much-needed respectability in the closing overs. Jason Holder also chipped in with useful cameos. Their combined efforts pushed the total to 137, which was likely short of the 160 to 170 range that would have been competitive under the cloudy skies.New Zealand's reply was swift and largely clinical. The openers exploded from the first ball, racing to 69 inside seven overs and putting the chase beyond doubt early. Tim Robinson led the charge with aggressive intent, his 45 featuring powerful hits that unsettled the new-ball bowlers before he fell to a clever slower delivery. Devon Conway anchored the innings with poise and timing, finishing unbeaten on 41 while guiding the chase to the target.Mark Chapman provided brisk support, his 20 off 12 keeping the scoreboard ticking through the middle overs.

#### Australia's Steve Smith questions England's all-out pace plans for Ashes

New Delhi. (Agency) Stand-in captain Steve Smith has questioned England's decision to rely heavily on express quicks for the upcoming Ashes, suggesting the tourists may have misunderstood what works best on Australian pitches. With England preparing one of their fastest attacks in recent years, the stand-in Australia captain believes seam and swing, rather than pure pace, have traditionally been more challenging for batters in local conditions. The Ashes begins on November 21 in Perth. England arrived without the experienced pair of James Anderson and Stuart Broad, and Ben Stokes has instead backed speed through Mark Wood, Jofra Archer, Gus Atkinson, Josh Tongue and Brydon Carse. It is a significant shift from previous tours, although one Smith thinks may not suit Australian surfaces."Those sort of nibblers can be quite tricky," Smith said, hinting that England's old formula might have served them better. "They might have got things the wrong way around, if that makes sense, in terms of the



acknowledged that England's current fast bowlers bring serious firepower, but he also noted that many were unavailable or too inexperienced on earlier trips. Even so, he believes that movement through the air or off the seam usually troubles batters more than speed, especially on the greener pitches prepared in recent seasons. He joked that some of the wickets in Australia have been so heavily grassed that they "have branches hanging off them." When asked if facing outright pace is easier than dealing with deliveries that nip around, Smith indicated that movement presents the tougher challenge."If you can do both, that is a good skill," he said. "But sometimes the slower guys are almost harder to play on those wickets where you have to make the pace.

## Pakistan move tri-series to Rawalpindi after Sri Lanka players flag safety concerns

Pakistan has shifted its upcoming T20 tri-series to Rawalpindi due to rising security concerns in the wake of a suicide attack in Islamabad.

Pakistan's upcoming T20I tri-series featuring Sri Lanka and Zimbabwe has been moved in its entirety to Rawalpindi following the suicide bombing in Islamabad earlier this week. The Pakistan Cricket Board (PCB) confirmed the shift on Thursday, November 13, releasing a revised schedule for the seven-match event. The tri-series is seen as an important preparation phase for all three teams as they build towards the 2026 T20 World Cup, to be co-hosted by India and Sri Lanka. As part of the revised arrangements, the second game of the series has been pushed back by a day to November 20. Initially, Lahore was set to host five of the seven games, including the final on November 29. However, after discussions involving all three boards, it was agreed that



Rawalpindi would now host the entire tournament to ensure player safety and logistical consistency. Concerns were raised within the Sri Lankan camp after the bombing, with the Sri Lanka Cricket Board (SLC) acknowledging that several players expressed a desire to return home due to security worries. The episode prompted internal discussions, with players seeking clarity on safety protocols and their own

participation in the series.In response, SLC issued a directive instructing all players, support staff, and team officials to continue the tour as planned. The board emphasised its commitment to supporting Pakistan while also ensuring that any apprehensions within the squad were addressed. However, the SLC made its position firm: if any player or staff member still chooses to return home despite the directive, replacements will be

dispatched immediately so the tour can proceed without disruption. Furthermore, SLC stated that any individual who withdraws from the tour against instructions will face a formal review upon returning to Sri Lanka. The board will assess their actions and determine an appropriate course of action once the tour concludes. With the venue shift finalised and the boards aligned on security measures, the tri-series is now set to move ahead in Rawalpindi. The focus for all three teams will be on cricket, even as the backdrop of heightened security remains a significant storyline heading into the competition.

#### Sensex, Nifty open slightly lower despite global optimism, record-low inflation

Benchmark indices opened marginally weaker on Thursday even as global cues turned positive and India's retail inflation eased to a record low of 0.25% in October.At around 9:21 am, the Sensex slipped 143 points to 84,323, while the Nifty50 fell 60 points to 25,816. Broader markets were also under pressure, indicating some profit booking after recent gains.

Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said the market now "needs more triggers to take it to new record highs," adding that with the Bihar election outcome mostly priced in, there are "no political triggers that can push the market significantly higher."He flagged the possibility of an India-US trade deal and the sharp drop in inflation opening the door for an RBI rate cut in December, though "monetary policy transmission turning weak has become a challenge."Vijayakumar expects the market to consolidate in the near term and react sharply once fresh cues emerge. "Positive triggers happening simultaneously can lead to shortcovering pushing the market sharply up," he said, though sustained upside may be difficult given FII selling and high valuations.

On the technical front, Anand James, Chief Market Strategist at Geojit, noted that a doji pattern in the previous session signals caution, even though oscillators still support further upside.

He sees Nifty potentially heading towards 26,130–26,550, but warns that the momentum could fade if the index fails to hold above 25,840, with a slide below 25,630 turning the setup bearish.Prashanth Tapse, Senior VP (Research) at Mehta Equities, maintained a bullish stance, saying Nifty is now eyeing its all-time high of 26,277, supported by global market strength, softer inflation, optimism around a US-India trade pact, and hopes of a US shutdown resolution. Despite FIIs selling Rs 1,750 crore on Wednesday, he pegged support at 25,500, with a breakout above 26,107 likely paving the way for fresh highs.

### Wipro, TCS, HCLTech: Know How Much Revenue Did IT Giants Earn Per Employee In

New Delhi.(Agency)

India's top information technology firms delivered a mixed performance on revenue per employee (RPE) in the September quarter, even as a few mid-tier players outshone industry leaders on productivity.

According to data from UnearthInsight Research,

HCLTech led the pack among large-cap IT firms with a 2% rise in RPE to over \$16,000 (Rs 14.17 lakh), alongside a 3.7% increase in headcount. Market leader Tata Consultancy Services (TCS) and Tech Mahindra also recorded modest RPE gains of 0.5% and 1%, respectively, aided by workforce optimisation and project mix improvements despite reduced employee counts.In contrast, Infosys and Wipro saw RPE declines of 0.7% and 4.7%, respectively. UnearthInsight attributed TCS's growth to workforce restructuring, while HCLTech's gains were driven by AI-led productivity improvements and strong project execution. Infosys's headcount expansion signals investment in AI-driven roles for future deal wins, whereas Wipro's flat hiring and weaker billability weighed on performance. Among mid-tier firms, Persistent Systems and Mphasis posted stronger RPE growth of 4.2% and 8.4%, respectively. Their ability to decouple revenue growth from headcount expansion—through cost efficiencies and smallerscale, high-value projects-boosted overall productivity, according to an earlier ET report. Despite operating at a larger scale, analysts said HCLTech continues to deliver steady productivity improvements. "Around 30-40% of HCLTech's RPE growth is driven by AI-led transformation and productivity initiatives," said Gaurav Vasu, cofounder of UnearthInsight, adding that hiring skilled AI and data engineers at a premium has also helped.

#### Tata Motors Shares Drop 3% Ahead Of Q2 Earnings Announcement

Tata Motors' share price declined 3.17% to Rs 319.40 apiece on Thursday ahead of the company's Q2 FY26 results announcement scheduled for November 13, 2025. ## Honasa Consumer shares jump up to 9% after strong Q2 earnings: Should you buy

Shares of Honasa Consumer, the parent company of Mamaearth, jumped as much as 9% on Thursday after the company posted a sharp turnaround in its September quarter (Q2FY26) performance. The gains came as the market reacted to Honasa's return to profitability and stronger margins, helped by a better product mix and consistent traction in its core beauty and personal care categories. The stock touched Rs 308.5 intraday on the BSE before cooling off to around Rs 294.05, still up over 4.30%. So far in 2025, the stock has risen nearly 20%, though it continues to trade below its IPO price of Rs 324.

Q2 RESULTS SHOW STRONG MOMENTUM

Honasa reported revenue of Rs 5,381 crore in Q2FY26, up 16.5% from a year ago, with volumes rising 16.7%. After adjusting for changes in Flipkart settlement accounting, like-for-like growth stood at a strong 22.5%. Profitability improved meaningfully. Gross margin expanded to

70.5%, up 172 basis points from last year, rate over the next couple of years. thanks to a favourable shift toward GROWTH DRIVERS AND NEW

premium products. The Ebitda margin moved to 8.9%, compared with a loss of 6.6% in Q2FY25. Net profit came in at Rs 39.2 crore, reversing a loss of Rs 18.6 crore a year earlier. Analysts attributed this to disciplined cost controls, lower advertising spends and better operating leverage as volumes scaled up.

Core categories such as face washes, sunscreens, moisturisers and haircare contributed more than threefourths of Honasa's revenue and showed broad-based growth.Mamaearth regained momentum, adding 123 basis points market share in face cleansers

according to NielsenIQ. Meanwhile, The Derma Co. crossed a Rs 750-crore annual revenue run rate and became India's top sunscreen brand as per Euromonitor CY24. The company now aims to scale Derma Co. to a Rs 1,000-crore annual run

Early subscription trends indicate a cautious but active start. As of 10:30 am on day one, the IPO was subscribed 2%, with the retail category booked 4% and non-institutional investors subscribing 1%. Qualified institutional buyers are yet to place their bids.

New Delhi: The Enforcement Directorate (ED) has arrested Manoj Gaur, managing director of Jaypee Infratech Limited. This action has been taken in a big case related to money laundering and misappropriation of home buyers' money. The ED has alleged that Jaypee Associates Limited (JAL) and its affiliated companies have made a mess of about Rs 12,000 million through Gaur. According to the agency, the company misused the money received from home buyers and these funds were transferred to other companies. Unpacking Rs 12,000 cr Jaypee Money Laundering Case

The ED has alleged that Jaypee Associates and its associated companies have committed fraud of around Rs 12,000 crore through Gaur. The investigating agency alleges that Jaypee Infratech Limited

misappropriated funds collected from homebuyers for its real estate projects and diverted them to other projects. This fraud resulted in the loss of many investors' money and resulted in losses. The searches covered the offices and premises of bankrupt Jaiprakash Associates, the related entities of the real estate company, and its promoters and directors. The ED also searched locations, including Gaursons India Pvt Ltd, Gulshan Homz Pvt Ltd, and Mahagun Real Estate Pvt Ltd.Several FIRs were also filed in 2017, when homebuyers protested against the builder and alleged that their funds were misappropriated. ## boAt founders step down before IPO: Should investors be concerned

Having been the face of their brands for years, these founders suddenly moving to non-executive positions has raised questions about intent and timing.

India's primary market has long-faced criticism for hosting overvalued IPOs. From sky-high pricing to post-listing underperformance, the "overvaluation" tag has been hard to shake off. But there's a new pattern drawing attention in recent times, founders stepping down from their executive roles just before their companies go public. Having been the face of their brands for years, these founders suddenly moving to nonexecutive positions has raised questions about intent and timing. The latest example is boAt, the popular homegrown audio and wearables brand, where cofounders Aman Gupta and Sameer Mehta

have stepped back from executive roles weeks before the company's Rs 1,500 crore IPO.According to the company's both founders resigned from their operational positions, Chief Executive Officer and Chief Marketing Officer, and will continue as non-executive directors. The IPO comprises a Rs 1,000 crore offerfor-sale (OFS) and a Rs 500 crore fresh issue. This move, however, has stirred debate about whether it's a routine step towards professionalisation or a red flag for investors.

WHY DID THE FOUNDERS STEP DOWN?

Abhishek Kumar, SEBI-registered investment adviser and Founder of SahajMoney, believes the timing of the decision is crucial."The founders have stepped down just 29 days before filing of the IPO prospectus and are transitioning from operational roles earning Rs 2.5 crore each to non-executive positions without any salary or sitting fees," he said."This could be a calculated move to distance themselves, probably to avoid accountability for post-IPO performance. The timing also suggests they might be prioritising reduced liability rather than

company's future under new leadership." IS IT A RED FLAG FOR INVESTORS?

Draft Red Herring Prospectus (DRHP), According to Kumar, such actions are not taken lightly by the market. "Such acts are



indeed viewed as red flags by investors," he said. "When insiders close to the business step back from operations right before listing, it signals limited conviction in the company's long-term prospects."While founder exits are not uncommon, they tend to attract attention when they coincide with other concerning factors such as leadership churn or slowing growth, both of which have reportedly been seen at boAt in recent months.

A STRATEGIC EXIT OR MONEY

demonstrating confidence in the When asked if stepping down before an IPO could be a way for founders to unlock wealth, Kumar pointed to the structure of the public offering itself."It could be an exit strategy. Usually during IPOs, when

founders shift to board roles without operational duties, they often sell their shareholdings through offer-for-sale components," he explained. "Unlike fresh issuance funds that go to the company, offer-for-sale proceeds go directly to selling shareholders such as founders and early investors. In the case of boAt's IPO, Rs 1,000 crore is through OFS versus Rs 500 crore in fresh issuance — meaning most of the capital raised would benefit existing stakeholders rather than the company

The decision could affect how investors perceive the upcoming IPO, Kumar warned."It is likely to impact investor confidence," he said. "Founder exits compounded with surging employee attrition, declining revenue, and sudden profitability improvements create a perception of fundamental weakness, not strength."However, he added that the IPO's success will depend on overall market conditions.
