

Selective outrage: Judges, bureaucrats slam Rahul Gandhi's vote chori charge

An open letter, written by 272 eminent personalities, called out the Congress's criticism towards the Election Commission and urged an end to conspiracy-laced rhetoric against institutions.



An open letter written by 272 eminent personalities, including retired judges, bureaucrats and armed officers, lashed out at Congress MP Rahul Gandhi for his repeated vote theft claims, saying that Indian democracy was witnessing a rising tide of venomous rhetoric directed toward its foundational institutions. The letter addressed to Rahul Gandhi and the Congress, said that some political leaders were resorting to provocative and unsubstantiated accusations, instead of offering a genuine policy alternative.

"After their attempts to tarnish the Indian armed forces by questioning their valour and accomplishments, and the judiciary by questioning its fairness, parliament, and its constitutional functionaries, now it is the turn of the Election Commission to face systematic and conspiratorial attacks on its integrity and reputation," the letter read.

Recalling Rahul Gandhi's vote chori claims during the Maharashtra and Haryana Assembly polls, the eminent personalities stressed that no formal complaint was lodged against him for "levelling unsubstantiated allegations and threatening public

servants in the performance of their duties". The Leader of Opposition, Lok Sabha, has repeatedly attacked the Election Commission, declaring that he has open and shut proof that the



Election Commission is involved in vote theft and claimed that he has 100 per cent proof. Using unbelievably uncouth rhetoric that what he has found is an atom bomb and when it explodes, the Election Commission would have no place to hide," they said.

"He has also issued threats that whoever in the Election Commission is involved in this exercise,

right from top to bottom, he will not spare them. According to him, the commission is indulging in treason. He has gone on record to threaten that if CEC/ECs are retired, he will hound them," they added.

The letter called out the Congress's criticism of the Special Intensive Revision (SIR) of electoral rolls, including calling the Election Commission a "B-team of the BJP", saying it amounted to blistering rhetoric."

Several senior figures of Congress and other political parties, leftist NGOs, ideologically opinionated scholars and a few attention seekers in other walks of life, have joined in with similarly blistering rhetoric against SIR, even declaring that the commission has descended into complete shamelessness by acting like the "B-team of the BJP," it stressed. "Such fiery rhetoric may be emotionally powerful – but it collapses under scrutiny because the Election Commission has publicly shared its SIR methodology, overseen verification by court-sanctioned means, removed ineligible names in a compliant manner and added new eligible voters," the letter said.

PM's Lecture Was Petty, Don't Know Why Shashi Tharoor Praised Him: Congress

The Congress on Wednesday said Prime Minister Narendra Modi delivered a "petty speech" at the Rammath Goenka Lecture and wondered how senior party leader Shashi Tharoor found any reason to praise it. Congress leader Supriya Shrinate said the Prime Minister should have spoken on "problem with fair journalism" and claimed he thinks of the opposition party "day and night". She was referring to PM Modi's criticisms of the opposition party in his speech on Monday evening. Her remarks came a day after Tharoor said PM Modi's Rammath Goenka Lecture served as both an economic outlook and a

cultural call to action. Speaking to reporters, Shrinate said: "I did not find anything in the speech worth appreciating. I think the PM must answer a lot of things. He was attending an event organised by a newspaper. He should tell us what his problem is with fair journalism. He should have told us why he is not happy with those who show and speak truth...So, I didn't see any reason to appreciate him."

She added: "I don't know how he (Tharoor) found one... I found it to be a petty speech. He criticised the Congress there too. The PM thinks of Congress day and night. This is amazing." In a post on X on Tuesday,



Tharoor said he attended the Lecture at the invitation of the organising newspaper - The Indian Express.

"Attended PM Narendra Modi's Rammath Goenka Lecture at the invitation of @IndianExpress last night. He spoke of India's 'constructive impatience' for

development and strongly pushed for a post-colonial mindset," the Lok Sabha MP from Thiruvananthapuram said on X. "On the whole, the PM's address served as both an economic outlook and a cultural call to action, urging the nation to be restless for progress. Glad to have been in the audience despite battling a bad cold and cough!" he added. At the sixth Rammath Goenka Lecture, PM Modi spoke on the Bihar election result, saying it has sent a clear message to all state governments that their development policies will determine the future of their parties, whether they belong to "left, right or centre".

Team Nitish's Oath Today, JDU-BJP Balance Caste Math In Minister Picks

Twenty-two ministers are expected to take the oath of office along with Chief Minister Nitish Kumar tomorrow during the grand swearing-in ceremony of the new NDA government in Bihar, according to top sources in the ruling coalition. The sources have said nine MLAs from the BJP, 10 from JDU, and one each from Chirag Paswan's LJP (Ram Vilas), Jitan Ram Manjhi's Hindustani Awami Morcha, and Upendra Kushwaha's Rashtriya Lok Morcha may take the oath tomorrow.

From the BJP's quota, Samrat Choudhary, Vijay Sinha, Nitin Navin, Renu Devi, Mangal Pandey, Neeraj Bablu, Sanjay Sarawagi, Hari Sahni, and Rajnish Kumar may take the oath. Eight out of these nine leaders were ministers in the outgoing government. Samrat Choudhary, who was Deputy Chief Minister in the previous government, has been elected the BJP's leader in the Assembly. BJP has tried to strike a caste balance by accommodating two Bhumihar leaders, two from EBC, and one each from the Brahman and Rajput communities. It has also accommodated the Kayastha and Vaishya groups.

From the JDU quota, 10 MLAs are likely to be sworn in at the Gandhi Maidan event tomorrow. These are Vijay Choudhary, Shrawan Kumar, Ashok Choudhary, Zama Khan, Ratnesh Sada, Leshi Singh, Bijender Yadav, Shyam Rajak, Sunil Kumar and Damodar Rawat. Eight of these MLAs were ministers in the outgoing government. The JDU, too, has balanced caste equations in its ministerial choices, with four Dalits and the representation of Muslims, Yadavs, EBCs, Rajputs and Bhumihars. Raju Tiwari, a Brahmin and state chief of Chirag Paswan's LJP (Ram Vilas), may represent his party in the new cabinet. Jitan Ram Manjhi's son Santosh Suman and Upendra Kushwaha's wife Snehalata Kushwaha are also likely to be sworn in. Nitish Kumar will be taking the oath as Bihar Chief Minister for the 10th time tomorrow after the NDA posted a mammoth victory in the Assembly polls last week. The NDA won 202 seats in the 243-member Assembly. Tomorrow's event at Patna's historic Gandhi Maidan is being planned as an NDA show of strength. Besides Prime Minister Narendra Modi, Chief Ministers of all BJP-ruled states are expected to be present at the event.

Congress president Mallikarjun Kharge and former party chiefs Sonia Gandhi and Rahul Gandhi paid floral tributes to Indira Gandhi at her memorial, Shakti Sthal, here. In a post on X, Kharge said the exemplary and dynamic leadership of Indira Gandhi, showing immense political courage, will forever inspire. "Her unwavering resolve and lifelong dedication to public service left an indelible mark on India's journey of progress. Her ultimate sacrifice in safeguarding the unity and integrity of the nation deserves a million salutations," Kharge said.

"On her birth anniversary, we offer our respectful homage to her enduring legacy," he said. Rahul Gandhi said her courage, patriotism, and morality continue to inspire him to stand firmly against injustice.

In a post in Hindi on X, he said, "I got inspiration to make fearless decisions for India and to put national interests first in every situation from my grandmother. Congress general secretary, in-charge, organisation, K C Venugopal remembered the first female prime minister as someone who steered the country through turbulent times and ushered in an era of welfare.

Delhi blast: Mobile phones seized, 10 Al-Falah students stopped from leaving university campus

Investigating agencies have confiscated cellphones of 10 Al-Falah University students, several of them in the final year, and barred them from leaving campus without permission. The students are believed to be close to the three doctors involved in the Delhi terror plot. Sources said the students were planning to leave for their hometowns and were prevented from leaving the campus without prior clearance from investigating agencies. Their phones were also taken for examination. On Tuesday, Jawad Ahmed Siddiqui, the founder of Al-Falah University, was arrested by Enforcement Directorate in connection with a money laundering case. So far, several students and faculty members have been questioned for information about operations of the module. Some faculty members have been detained too. But no student has been arrested so far. As the atmosphere on campus remained tense with visible security presence on the premises, at least 30 students had left for their homes till Tuesday, while several staff members also returned to their native states. A staff member who left the campus along with two colleagues told mediapersons that they might not return for at least two months. "Our relatives have begun questioning our activities. With the situation chaotic on the campus, we decided to return home," the staff member said.

Met factors keep Gurgaon AQI in 'poor' zone for second day

The city's AQI climbed to 272 (poor) on Tuesday from Monday's 253, a rise of about 7% in just 24 hours. Sector 51 hit 332 and Gwalpahari 321, both in the very poor bracket. Vikas Sadan logged 231, while Teri Gram remained relatively lower at 194. With no change in dispersion conditions, experts don't expect much relief this week. The pollution profile over the first half of Nov tells the same story. PM2.5 was the leading pollutant on 9 of the past 17 days, carbon monoxide topped the charts once and PM10 took the lead on the remaining days.

When PM2.5 dominates for more than half the month, it usually means combustion-linked sources—vehicles, waste burning and industrial emissions—are doing more damage than coarse dust. The city barely moved out of the poor to very poor categories throughout Nov.

Delhi's air quality stood in the very poor bracket on Nov 17 with an AQI of 351 at 4 pm. Minimum temperatures have been running 1 to 5 degrees below normal across the capital, while maximum temperatures have also dipped. The region has mostly seen clear skies and wind speeds of 8–10 kmph throughout the day. These wind regimes, mostly from the southwest, north-northwest or north, haven't offered the ventilation needed to flush out pollutants. Delhi-NCR is likely to remain in the very poor category till at least Nov 21. Doctors say the impact of this week's spike will be immediate. Dr Piyush Goel, senior consultant (Pulmonology) at Narayana Hospital, explained why PM2.5-heavy days are particularly dangerous. "PM2.5 is one of the most harmful pollutants in the air. PM refers to particulate matter and 2.5 indicates its diameter in microns, which is incredibly small. These particles are made up of dust, industrial toxins, emissions from vehicles, heavy metals, sulphur dioxide, nitrogen dioxide, carbon monoxide and even water vapour. Because they are so fine, they travel deep into the lungs when inhaled. From there, they can enter the bloodstream. Once in the blood, they can reach the heart and raise the risk of a heart attack. They can also travel to the brain and trigger a stroke. Long-term exposure is increasingly being linked to infertility among young adults. This is why air pollution is a serious concern and why doctors advise people to use N95 or surgical masks."

With no cops in sight, vehicles flout rules on Bhangel elevated road on Day 1

Bhangel elevated road saw a steady stream of traffic soon after the barricades were lifted. But it was a chaotic first day. Several cars and bikes were seen driving on the wrong side, raising concerns over safety and lack of traffic police enforcement on the newly opened corridor. A traffic inspector said that they took note of the situation and deployed teams on both sides of the stretch to ensure enforcement. Meanwhile, local residents and shopkeepers have welcomed the opening of the elevated road, saying that during the construction period, the DSC Road, which runs below the elevated stretch, was dug up and remains in poor condition, severely affecting their business. People travelling from the 7X sectors to Noida and Delhi rely on this route. A resident of Sector 78, Brajesh Sharma, uses this road daily. He said the elevated road was ready but awaiting inauguration. "The DSC Road remains in bad shape and has been dug up at several points, causing frequent traffic jams and even vehicle overturning at times. The intervention of the farmers' group expedited the opening, which otherwise may have been delayed further," he said. Bhangel is one of the oldest markets of the city. It is surrounded by sectors 47, 48 and villages like Salarpur and Barola. It is a wholesale and retail hub for thousands of residents, migrant workers and students. The elevated road project was launched in June 2020 with a deadline of December 2022, but it was completed earlier this year. Traders from markets located below and around the elevated road are frustrated over the pathetic condition of the road and lead to waterlogging during monsoon.

Imran Khan, who runs a mobile repair shop in Bhangel, said that business had suffered for nearly five years. "There is encroachment by street vendors, dumped garbage, and stray animals. There is also dust pollution, and this road is unmotorable. Initially, traders expected the elevated road project to be completed quickly, but delays and the neglected condition of the DSC Road turned the stretch into a bottleneck, discouraging customers and hurting business," he said. Due to the enforcement of GRAP stage III and the ban on all construction activities, the DSC Road repair works may take some time.

Marriage halls may face up to Rs 5L fine for waste violations

The municipal corporation has proposed hefty fines for violations of the solid waste management rules (SWM) 2016, in line with NGT guidelines. High-rise societies failing to segregate waste at source will face fines starting at Rs 1,000, increasing to Rs 20,000 for repeated violations. Marriage halls and bulk waste generators will face fines of Rs 5 lakh and potential cancellation of trade license.

Municipal health officer Mithelesh Kumar said the corporation, apart from being a maintenance agency, is also an enforcement agency as per the mandate by the municipal act. "The corporation's highest decision-making body has vetted the fine structure that will have more teeth and will certainly act as a deterrent," he said. "The violations of SWM rules have been identified under various heads: bulk waste generators, both residential and institutional; those who dump waste illegally; those who burn waste in the open; and dairy owners who dispose of



waste illegally," he said. Under the residential heads, GMC will impose a fine of Rs 1,000 on first-time offenders. This will be increased to Rs 5,000 for the second violation. If it continues, a fine of Rs 20,000 will be levied and the owner will be ineligible for availing rebates on house, water, and sewer taxes for two

years. If a marriage hall, farmhouse, or hotel is caught breaking the rules, it will face escalating penalties. The first and second violations will attract a penalty of Rs 1,000 and Rs 5,000, respectively. If they continue to break the rules, the fine will be raised to Rs 5 lakh along with cancellation of their licence. An FIR will

be filed under Section 269 (negligent acts that are likely to spread a life-threatening infectious disease) against them. Municipal commissioner Vikramaditya Singh Malik said there is also a provision for confiscating vehicles used for illegal dumping of waste which will be auctioned later on. If an e-rickshaw is involved, for the first two violations, the fine amount will be the same as for others and the vehicle will be confiscated after the second violation. In case of three- and four-wheelers, the fine amount will be Rs 25,000 on the first violation and Rs 1 lakh on the second with the vehicle being impounded after that. The same goes for tractor-trolleys, trucks and dumper. Echoing Malik's sentiment, mayor Sunita Dayal said, "Over the past few years, Ghaziabad has been used as a dumping ground for waste from neighbouring districts, including Delhi. On many occasions, we intercepted the vehicles and impounded them but had to let them go in the absence of rules."

Noida begins converting 2003 rolls to Excel files as residents hit SIR hurdle

Recognising difficulties residents are facing in sourcing their 2003 electoral roll details for the Election Commission's ongoing special intensive revision, the Noida administration has started converting scanned records of the old rolls into searchable Excel files. On Nov 16, TOI reported that most people were leaving the 2003 section blank in their enumeration forms, unable to source those details from the CEO UP website. Without a search option, one needs to know the old constituency name (pre-delimitation) and booth number to download the list. Going through the list is a tedious process. In several cases, scanned copies are illegible. DM Medha Roopam told TOI the move followed consistent feedback from residents. "During SIR reviews, we were repeatedly told that people struggled to locate their part and serial numbers in the 2003 rolls. Even BLOs were often unable to guide them. So, we decided to digitise the files and make names searchable," she said, adding that a team has been working on the task for four to five days. The scanned PDFs are being converted into



Excel sheets, and by Wednesday, they will be ready for circulation to all BLOs, BLAs and RWAs or AOAs. Once these searchable lists are available, the process will become much easier for voters," she added. Ghaziabad DM Ravindra Mander told TOI that the district is taking a

different route by integrating the 2003 voter list directly into the BLO mobile app. "We've shared Ghaziabad's 2003 electoral roll with the state election commission, which is mapping it to the current rolls. The upload is nearly complete," he said. "Once live, BLOs will be able to search a voter's name on the app and immediately check whether it appears in the 2003 list. This will allow quick verification, even if a voter has missed or incorrectly filled details during the digital upload of enumeration forms," Mander added. However, this data will be accessible only to BLOs. Under the SIR process, all enumeration forms collected from voters must be digitally uploaded by BLOs through the Election Commission's app. "Distribution of forms is nearly complete, and collection has begun. As BLOs start uploading data, 2003 voter list will already be fully integrated into the app," Mander said. "This will ensure BLOs can easily verify whether a voter's name appears in the 2003 rolls." Earlier, TOI reported how the SIR exercise had run into widespread confusion over the section asking for voters' 2003 details.

Haryana plans cap on doctors registering at medical termination of pregnancy centres

A doctor won't be allowed to register with more than two medical termination of pregnancy (MTP) centres in the entire state, according to a proposal the health department is preparing. On Tuesday, when the department pulled up six districts for falling behind last year's sex-ratio-at-birth (SRB) levels, a review highlighted a structural problem in how MTP centres are staffed. Officials said the cap is meant to reduce proxy practice, improve traceability during audits and push centres to maintain their own full-time qualified staff rather than relying on signatures of doctors who are rarely present. At present, doctors often enpanel themselves at multiple facilities, which makes it difficult to verify who actually conducts procedures and whether the

centres meet legal requirements at all times. Tuesday's state task force meeting chaired by additional chief secretary (health) Sudhir Rajpal saw unusually direct intervention. Rajpal directed the district administrations and health officials to work in close coordination and push the state's sex ratio to 920 this year. The latest review of SRB performance from Jan 1 to Nov 17 shows Sirsa, Sonipat, Yamunanagar, Jhajjar, Charkhi Dadri and Nuh all slipped compared to the same period last year. Sirsa is down by 16 points, Sonipat by 10, Yamunanagar by 11, Dadri by 14, Jhajjar by 4 and Nuh by 1. Senior officials said these declines are significant because each of these districts has already been under close scrutiny for PNDT enforcement. Rajpal spoke via video conference with the deputy

commissioners and superintendents of police of six low-performing districts—Sirsa, Sonipat, Yamunanagar, Charkhi Dadri, Nuh and Jhajjar—and asked them to work with civil surgeons and take proactive steps to improve the sex ratio. He instructed these districts to carry out reverse-tracking of illegal abortion cases and maintain strict monitoring. He ordered the suspension of the medical officer of PHC Jattawali in Sirsa and the SMO of Halalpur in Sonipat for negligence and for the district's declining sex ratio. Officials said accountability at the facility level is now "non-negotiable" given the persistent gaps between enforcement and outcomes. A senior officer who attended the meeting said the message is clear.

Behind steep fall in Haryana stubble fires this year: Wet fields & farm distress

This time of the year, the air smells of carbon here. But at two of Haryana's stubble burning hotspots, there's hardly a field on fire and only stray smoke trails to follow this time. The reason is apparent from the landscape. Thousands of acres of farmland are still wet because of rains in Oct. Dry patches—with straw heaps waiting to be taken away—are interrupted by inundated and swampy fields. This is the simplest explanation why farm fires in Haryana have seen a steep fall this season, sparing Delhi-NCR the deadly paddy stubble smoke that curls around it every year. Late rains killed a chunk of the harvest—some farmers say it's up to 30% of their crop. In fields that didn't drain well, standing water has reduced the paddy to mulch. In many other fields, lingering sogginess had made burning impractical for farmers. But while that's good news for the environment, crop destruction has left farmers in distress. And in debt. "The paddy harvest has come down for everyone this year," says Yogender Bhutan, the manager. Farmers gathered there

Fatehabad. So far, around 10,000 farmers have reported losses on land that adds up to 65,000 acres. The swampliness will also affect the next crop because some farms have developed salt crusts on the surface, which means the top soil will have to be removed before anything grows again. If that doesn't happen in the next week or so, which is the sowing window for wheat, it'll mean more losses. The reduction in crop residue output has meant, however, that getting rid of the straw bales is slightly easier. Power plants aren't the only ones collecting the bales. On Ratiya road, tractors carrying stacks of straw bales are all headed towards Chandigarh Distillers & Bottlers Ltd, which needs them for its packaging unit. There, several farmers are meeting the manager to list their bales for pickup. But with less load to manage, it's easier to keep up. "Since many fields are still waterlogged, we have got less stubble listed this year. We have been lifting the bales as soon as we are informed," says Ramesh Sharma, the manager. Farmers gathered there

don't speak in one voice on why there is less residue. The rains, yes, but, according to some of them, the move to basmati from non-basmati variants (which are the ones that generate stubble) is also a factor. Basmati is more commonly grown in Haryana than in Punjab, and since it is handpicked, the harvest does not leave a residue. The possibility of stiff fines and arrest due to stubble burning, says Mahavir Singh, who owns 15 acres of land in Hasanpur village, also persuaded several farmers to divert a section of their land to other crops like cotton. "Added to that, uncertainty of whether the bales will be lifted on time led to farmers opting for diversification. The straw pickup system can falter. Last year, many bales were not picked up. Cattle fell ill and died after chewing on them and that affected milk production. So this year, some farmers went for cotton, which got destroyed because of the rains. This year, my paddy yield has fallen to 7 quintals from 10."

There's another layer farmers mention quietly. Several claim

that insurance companies are not processing their claims, leaving compensation uncertain. "When your paperwork sits in doubt, the last thing you want is a red entry in revenue records or a fine that could shut the door on future claims," says Munshi Ram, a farmer in Nagpur village. This village falls on the link road of Fatehabad-Nagpur Road from Ratiya road. Visually, there's more rain-affected farmland as one approaches Jind via Bhuna-Fatehabad road. After Narwana, farms on both sides along a section of the highway are submerged. In villages such as Bihawala, Samalpur, Darodi and Naewana Morepati, most of the farmland is inundated. "We have not received any help from govt. Several farmers applied on the portal, but they are yet to get any help. No physical verification has been done. Satellite images will show that our field has standing crop, but it is destroyed. Who will tell them this?" asks Chand Bahadur, a farmer.

Surender Singh, working at an adjacent field, is distraught. He says he took four acres of

farmland on lease for Rs 65,000 per acre for a year.

"I spent Rs 50,000 on growing paddy. Now it's completely destroyed. I can't grow wheat this season as well."

'Khilafat' terror module posing as NGO busted

New Delhi: The Special Cell of Delhi Police has uncovered a suspected terror module known as Khilafat, which was allegedly operating under the guise of a non-governmental organisation and backed by a Pakistan-based handler, with the arrest of five operatives in raids across multiple states. The arrested accused have been identified as Ashhar Danish (23), Aftab Qureshi (25) and Sufiyan Abubakar (20), both from Mumbai; Mohammad Huzaifa (20) from Telangana; and Kamran Qureshi (26) from Madhya Pradesh. Pregnant Indian-origin techie, unborn baby killed in road accident in Australia

MELBOURNE . (Agency) An Indian-origin techie who was eight months pregnant has died along with her unborn baby after she was hit by a car in Australia's Sydney city. Samanyitha Dhareshwar, 33, was walking with her husband and their three-year-old son along George St in Hornsby shortly after 8 pm local time on Friday last week when a Kia car slowed at the entrance of a carpark to let the family pass. Moments later, the Kia was rear-ended by a BMW, causing it to surge forward and hit the woman, according to a report by 7news.com, quoting police. Emergency services treated Dhareshwar, who was just weeks away from giving birth to her second child, at the scene before she was rushed to Westmead Hospital in a critical and unstable condition, where she and her unborn baby died a short time later, police said. According to Dhareshwar's LinkedIn profile, she was an IT systems analyst who worked for Alco Uniforms. The 19-year-old BMW driver and the 48-year-old Kia driver were uninjured.

No other passengers were in either vehicle.

Police later arrested the teenage BMW driver, identified as Aaron Papazoglu, on Saturday. He has been charged with dangerous driving occasioning death, negligent driving occasioning death, and causing the loss of a foetus. At a bail hearing, Magistrate Ray Plibersek refused Papazoglu's application, describing the incident as "an absolutely tragic case".

NRI Reveals Deal-Breaker For Indians Looking To Return To Country For Retirement: 'Horrendous Traffic'

A Non-Resident Indian (NRI) who recently returned to India alongside his wife has ignited a conversation on social media as to why others settled abroad were hesitant to return to the homeland. "Wife and I lived in the US for 25 years and returned to India. As we are approaching retirement age, some US friends are asking how life in India really is, as they are debating moving to India for retirement," Naresh wrote on X (formerly Twitter). "So many positives here, but you know what the deal breaker for many is? The horrendous traffic," he added. Naresh pointed out that the traffic situation needed to be addressed on war footing as it would help with the inflow of money from the NRIs to the Indian economy.

Bangladesh Becomes Terror Hub: Hasina's Son Reveals LeT Camps, ISI Weapons, Delhi Attacks Linked To Militants

Bangladesh has turned into a terrorist sanctuary, and India needs to wake up fast. That's the blunt warning from Sajeeb Wazed Joy, whose mother, Sheikh Hasina, was forced to flee Dhaka in August 2024. Speaking to ANI from Virginia, Wazed didn't hold back: Lashkar-e-Taiba is operating freely across the border, thousands of jailed militants are back on the streets, and recent Delhi attacks have Bangladesh connections. "I think Prime Minister Modi is probably very, very concerned about terrorism from Bangladesh," Wazed said. He claims the Yunnus government has freed "tens of thousands of terrorists" his mother had locked up after years of crackdowns on militant groups. Lashkar-e-Taiba, the group behind the Mumbai 2008 attacks, is now running operations freely in Bangladesh. Wazed says LeT's local branch has direct ties to recent terror incidents in Delhi. If he's right, Bangladesh has gone from counter-terror ally to potential launchpad for attacks on Indian soil. Wazed also pointed fingers at Pakistan's ISI, claiming the spy agency armed militants who infiltrated last year's protests. "Without a doubt, these weapons had to have been supplied from somewhere in the subcontinent and the only possible source is ISI," he said, adding that video evidence shows armed people among the demonstrators.

Extradition Request Dismissed

Bangladesh wants Sheikh Hasina back to face charges, but Wazed called the legal process a complete sham. "They terminated 17 judges before the trial, amended laws illegally without parliamentary approval, and barred her defence attorneys from court," he said. "When there is no due process whatsoever, no country is going to extradite." He thanked Prime Minister Modi for saving his mother's life. "If she hadn't left Bangladesh, the militants had planned on killing her," Wazed said.

JOHANNESBURG: In South Africa's oldest township, volunteers in wetsuits jump into the thigh-deep water of the polluted Jukke River to untangle a net that's designed to trap garbage but damaged by heavy rains. Without the nets, the shacks of low-lying Alexandra on the outskirts of Johannesburg could face disastrous flooding. World leaders with the Group of 20 rich and developing nations will meet this weekend in Johannesburg for the bloc's first summit in Africa. Host South Africa wants to prioritize issues affecting poor countries, including responses to disasters made worse by climate change. South Africa will urge rich countries and international financial institutions to help more — a plea also being made at global climate talks in Brazil. Alexandra's over half a million residents live within steps of South Africa's richest financial district, Sandton. But flooding often submerges bridges, leaving the township's children unable to get to school. countries "The ravages of the climate are directly linked to the ravages of inequality," Binaifer Nowrojee, president of the Open Society Foundations, a non-governmental organization promoting democracy and governance, told The Associated Press. "Countries are facing the destructive choice between growing their economies and taking climate action." The World Bank says the poorest countries were hit by nearly eight times as many natural disasters in the decade from 2010-2020 as they were from 1980-1990. Southern Africa has been struck by strong tropical storms in the past decade, killing thousands of people and leaving nations with unbearable rebuilding costs. Cyclone Idai, which scientists say was made more powerful by climate change, ripped through Mozambique, Malawi and Zimbabwe in 2019, causing an estimated \$2 billion worth of damage, according to the World Bank. Malawi's gross domestic product is just \$12 billion. Last year, the El Nino weather phenomenon caused one of the worst droughts in decades in the region, devastating small-scale agriculture and leaving people even poorer.



Lobbying world leaders

Climate financing has been a focus of sharp debate between rich and poor countries at major summits like the G20.

Rich countries agreed at last year's United Nations climate summit to pool at least \$300 billion a year by 2035 to help developing countries deal with the impacts of climate change and weather disasters. But independent experts said much more — an estimated \$1 trillion a year — was needed by 2030. One of the world's largest polluters, the United States, won't even attend this weekend's G20 summit as it boycotts over US President Donald Trump's widely rejected claims that South

Africa is violently persecuting a white minority. That makes action on climate, or even a meaningful declaration, from the G20 a tall order.

South Africa's own failures

The Alexandra Water Warriors have considered themselves the guardians of their environment since they formed in 2021, planting native trees to reduce urban heat and collecting and recycling trash from the river. They face the kind of challenges seen in other townships and poor settlements across South Africa, which is the continent's most developed economy but also has some of the world's most dramatic inequality.

An Amnesty International report released this month for the G20 summit said the South African government is failing as many as 5 million people who live in informal settlements without proper housing and services and are impacted by the climate crisis. It said they are often forced to live in vulnerable, low-lying areas close to rivers. Floods in June in South Africa's Eastern Cape province killed more than 100 people. While South African President Cyril Ramaphosa said they were exacerbated by climate change.

A local court here on Tuesday framed charges against BJP MLA from Viramgam, Hardik Patel, in connection with an FIR registered against him and six others in Nikol, where they protested as Patidar Anamat Andolan Samiti (PAAS) leaders in 2018.

The additional civil judge and JMFC at the Ahmedabad rural court, G B Siag, framed charges against Patel for unlawful assembly, rioting, criminal conspiracy, and creating obstructions for police in performing their duty.

The complaint was filed on Aug 19, 2018, after PAAS held a one-day symbolic fast in Nikol without obtaining police permission to hold the protest, said one of his advocates in the case, Parvez Pathan.

After the registration of the FIR, the police filed three chargesheets against seven persons. As co-accused in the case have filed discharge applications, the court has posted proceedings in this regard on Nov 21. Patel's discharge plea in this case is pending in the Gujarat high court.

This court issued an arrest warrant against Patel two months ago for his continuous absence during the court proceedings. In Oct, Patel approached the high court for quashing of the non-bailable warrant, and the high court quashed the warrant on his undertaking that he would regularly attend the court proceedings. After the quashing of the arrest warrant, Patel was present in the court for the first time, and the court framed the charges against him. He appeared on the rural court campus at Navrangpura wearing a mask.

Ahmedabad: Parents oppose Loyola's plan to switch to ICSE**Ahmedabad. (Agency)**

Authorities of St Xavier's Loyola School in Naranpura organized a meeting with parents on Tuesday to seek consent for their decision to discontinue the Gujarat Secondary and Higher Secondary Education Board (GSHSEB) curriculum for the primary section and affiliate with the Indian Certificate of Secondary Education (ICSE) Board. The move was met with resistance from the majority of parents, especially those with younger children. The school currently operates as a private institution for Classes 1 to 8 and offers grant-in-aid education for Classes 9 to 12 under the Gujarat Board. The management is seeking approval from the education department to transition the primary section to the ICSE board starting next academic year.

In a letter to parents ahead of the meeting, the school assured them that current students would have the option to remain with the Gujarat Board until their batches are fully phased out, while also offering the choice to switch to ICSE.

During Tuesday's meeting, which involved parents from the primary section, the school management attempted to convince them to agree to the ICSE switch, citing the benefits of the curriculum in the age of technology. However, over 50% of the attendees voiced their opposition. The primary concern among dissenting parents is the anticipated increase in school fees that would come with the transition to a non-grant-in-aid ICSE affiliation.

Karnataka to prepare fresh DPR for Mekedatu project: Dy CM Shivakumar**BENGALURU. (Agency)**

Karnataka Deputy Chief Minister DK Shivakumar on Tuesday said the State Government will prepare a new DPR (Detailed Project Report) on the Mekedatu balancing reservoir project and submit it to the Centre. Speaking to media persons after holding a meeting with senior officers, the DyCM said they discussed the measures to be taken by the state government to implement the project. They have to submit the DPR again with all the details about the project, including the extent of land, including the forest that would be submerged. Shivakumar, who also holds the water resources portfolio, said the State government would submit a new report after addressing the shortcomings in the earlier report. He said that the government has opened the Mekedatu office in Harobele, and a separate office consisting of Chief Engineer and CCF has come up in Ramanagar.

Congress padayatra delayed it, says Basavaraj Bommai

Haveri MP and former CM Basavaraj Bommai said the state government should not bring politics into the Mekedatu balancing reservoir project and work closely with the Centre to get all approvals.

The Haveri MP appealed to the Centre to get the Detailed Project Report (DPR) approved so that the state can go ahead with the project.

Speaking to media persons in Bengaluru, Bommai accused the Congress of having done politics of padayatra over Mekedatu, which was the reason Tamil Nadu went to court with a miscellaneous application. "Had the Congress not undertaken the padayatra, the project would have reached an advanced stage by now."

Because of their padayatra, Tamil Nadu filed a miscellaneous case," he said. "We knew that it (Tamil Nadu's application) was going to be thrown out."

One more deer dies on Tiruchy-Chidambaram NH, activists slam forest department

According to forest department sources, a spotted deer was found inside the rainwater drain along the highway near Kallagam on Tuesday morning.

TIRUCHY. (Agency)

The Tiruchy-Ariyalur-Chidambaram highway, which runs alongside a reserve forest, is turning into a death trap for small animals that stray on to the road. On Tuesday, a spotted deer fell into a rainwater drain, frightened by speeding vehicles passing on the stretch following which animal activists reiterated their demand to the forest department for a permanent solution to protect the animals.

According to forest department sources, a spotted deer was found inside the rainwater drain along the highway near Kallagam on Tuesday morning. Upon getting information, personnel from the forest department tried to rescue the animal, but found out it had died.

M Daniel, a farmer and activist from Kallagam, said deer often stray out of the reserve forest near a lake in the village and enter agriculture fields in Kallagam, Pazhanganatham, Keela Arasur, Pullambadi,



Muthuvathur in Tiruchy district and Malvai and Mela Arasur in Ariyalur district. "Most often, the animals get fatally hit by speeding vehicles while they try to cross the highway. Despite repeated appeals, the forest department has not taken any action in this regard," Daniel told.

Quoting from an RTI reply he received from the forest department in response to his query about setting up a sanctuary on the Kallagam lake, Daniel said the district forest officer G Krishiga had stated that there was no proposal

for such a project.

"As a reserve forest beside the lake houses several spotted deer, it is usual for the animals to come out in search of water or food. On such occasions, the animals may get hit by speeding vehicles on the highway. Awareness is being created for drivers to slow down when they cross the stretch," the DFO stated in the reply. But locals say no driver slows down in the stretch, as no warning signs have been placed about animals crossing. The forest officials have no idea of the details of the population of the animals in the reserve forest, Daniel alleged.

The least the forest department could do to protect the animals is install signboards to alert drivers, he added. When contacted, forest range officer VP Subramanian told that the enumeration of deer and other animals in the forest would take place once in three years. "Drivers must go slowly in the stretch. Action will be taken to fix signboards on the stretch," he said.

18,500 revenue staff boycott SIR work in Tamil Nadu but impact mixed

CHENNAI. (Agency)

The federation of various associations of revenue officials in Tamil Nadu (FERA) said 18,500 revenue staff began their boycott of all Special Intensive Revision (SIR) related work on Tuesday as announced earlier. This is apart from employees of other departments including rural development and social welfare, FERA added.

While FERA said SIR work took a significant hit across TN as a result and impact of the boycott would be stronger in coming days as pending work mounts, senior officials contended that SIR works were, by and large, continuing as usual. Reports from different districts indicated

that the work continued in municipal corporations without any noticeable impact but a moderate impact was observed in other places. FERA had announced the boycott citing extreme work pressure, an unrealistic timeline, inadequate training and inadequate human and financial resources for the roll revision exercise. M P Murugaiyan, state coordinator, FERA, told that Revenue Secretary P Amutha and Commissioner of Revenue Administration M Saikumar met with FERA representatives. He said they had assured they would convey

FERA's demand to extend the enumeration period beyond December 4 to the Election Commission of India as only the commission could decide on

"We have sought the assurances in writing. We will continue to boycott the SIR work on Wednesday," he said, pointing out that an anganwadi worker in

Kumbakonam, deputed as a booth level officer, had attempted to end her life. He said a large number of teachers were engaged in urban areas where work seemed unaffected. As the work to be done by revenue staff is being dumped on teachers, they are also put to great hardship, he said.

In districts like Madurai, Virudhunagar, Dindigul and Kanniakumari, revenue officials said 300 to 500 employees boycotted SIR work.

Jagatsinghpur police probe terror links of accused sheltering 30 illegal Bangladeshi immigrants

JAGATSINGHPUR. (Agency)

Jagatsinghpur police has launched an investigation to ascertain any possible terror link of the accused who harboured nearly 30 illegal Bangladeshi nationals in houses built on government land for the last four years.

On Monday, the district administration razed around 17 illegal structures - 10 houses in Behrampur slum and seven unauthorised constructions in Satapura village, which were being used to shelter Bangladeshi infiltrators.

The houses were built by encroaching on government land by main accused Sikandar Alam (40) of Dhanipur village. Sikandar is at large.

Police sources said Sikandar and his brother Abdul Motalif Khan (38) of Behrampur and sisters Sawan Ajmi (39) of Patkura in

Kendrapara, Parween Bibi (34) of Paikakul village and Badrunisha (30) of Dhanipur, were providing shelter to the illegal immigrants. While Sawan and Parween have



been arrested, the remaining three accused are on the run.

The incident has exposed serious administrative lapses as the intelligence wing, police and revenue officials could not detect the presence of 30 illegal immigrants in Behrampur and Satapura for the past four years.

Besides, the Bangladeshi nationals managed to acquire fraudulent documents such as fake Aadhaar cards and birth certificates.

Police said a hunt is underway for Sikandar who fled after removing hard disks of CCTV cameras. He is suspected of having possible terror links and ties to extremist modules. Investigators have found that for nearly a decade, he worked in the merchant navy and an oil refinery, travelling to at least five countries. He was also running an unregistered madrasa in his village.

Preliminary investigation suggested that Sikandar facilitated the illegal entry of Bangladeshi nationals, provided them shelter, and allegedly involved them in unlawful activities. Police also suspect that the women and girls trafficked from Bangladesh were exploited.

HC: Family can't interfere with woman's choice to have MTP

Mumbai. (Agency)

The Medical Termination of Pregnancy (MTP) Act does not allow any interference with the personal choice of a pregnant woman in terms of proceeding with termination, said Bombay high court. It permitted a 19-year-old to undergo the procedure to terminate a 23-week pregnancy after doctors detected foetal abnormality.

"The MTP Act leaves no scope for interference by the family or the partner of the pregnant person in matters of reproductive choice," said a bench of Justices Revati Mohite Dere and Sandesh Patil in a recent order.

The teen petitioned HC to seek termination of her pregnancy, which at the time of filing the petition was under 24 weeks. She married at the age of 18 and alleged being subjected to domestic violence. She approached a doctor earlier for an MTP well within the permissible timeframe, HC noted, and expressed surprise over why the hospital in Navi Mumbai did not allow the procedure when her pregnancy was under 21 weeks. An MTP can be done till 24 weeks under certain conditions, HC noted. It observed that even now, a civic medical board, which was directed on Nov 11 to examine her, said she was 23 weeks and four days pregnant.

The medical board's report said an abnormality was detected in the foetus. "The abnormality may indicate other health issues, including heart, kidney and gastrointestinal issues," it suggested. The board, thus, said she could be permitted an MTP with the "informed consent" of the pregnant teen and her parents. HC interacted with the doctors and the teen. She said she wished to terminate her pregnancy.

"We are conscious of the petitioner's right to reproductive freedom, her autonomy over the body, and her right to choice, privacy and dignity, all of which are constitutionally protected," HC said. It observed that the delay occasioned was purely beyond the teen's control, who approached doctors well within the 24-week period.

New India-US bridge over troubled water

In a world increasingly defined by fragmentation and flux, the relationship between India and the US remains one of the few partnerships with the potential to shape a more stable, democratic, and innovative global order. The recent confirmation of a new US ambassador to India—a close aide of Donald Trump, albeit with no prior diplomatic or India experience, Sergio Gor—signals Washington's intent to reinvigorate ties with New Delhi at a time when both countries face shared challenges and converging opportunities.

President Trump's recent remarks about Prime Minister Narendra Modi, calling him "a strong leader and a great friend", mark a notable shift in tone from earlier weeks of undiplomatic statements and social media posts. While recent frictions over tariffs and trade imbalances have strained the relationship, the current moment appears to offer a chance to reset. Encouraging signs point to the possibility of a new bilateral trade deal, which could unlock growth, investment, and innovation across sectors ranging from pharmaceuticals and semiconductors to clean energy and artificial intelligence.

But to seize this moment, both sides must confront and clarify the geopolitical realities that shape their choices. At one time, both Washington and New Delhi saw the spectre of Chinese assertiveness looming large—from the Himalayas to South China Sea, from cyber intrusions to supply chain dependencies—and made common cause in recognising the need to constrain it. But after the recent 'G2 Summit' in Busan, there is renewed confusion about whether the US still sees China as a strategic competitor and global rival, or whether we are witnessing the dawning of a co-operative condominium arrangement between the two great powers of our times.

For India, the challenge is existential: we must defend our sovereignty while accelerating our development. Washington must decide whether it is strategic—balancing deterrence with diplomacy, and maintaining influence in a region where its primacy is no longer assured—or as Trump's recent silence on the Quad suggests, the Indo-Pacific is no longer a priority. Seen from New Delhi, a deeper US-India partnership is not merely desirable; it is imperative. Yet, it cannot be built on sentiment alone. It must be anchored in structural reforms, mutual strategic clarity, and a shared vision for the 21st century. First, both countries must remove the impediments that have long hampered economic cooperation. The legacy of US tariff policy—particularly the withdrawal of India's benefits under the generalised system of preferences during the first Trump administration, and the punitive 50 percent tariffs this year that have cost jobs in India and done real damage to our exporters—leaving deep wounds that could turn into lasting scars. Measures were aimed at protecting American industry, they also signalled a retreat from the strategic vision of the last quarter-century. A renewed push to reduce tariffs, eliminate regulatory barriers, harmonise standards, and facilitate cross-border investment would send a powerful message: that economic alignment is a pillar of strategic trust.

Second, India must continue its path of economic reform—not just to attract foreign capital, but to ensure policy certainty and transparency. Investors, both domestic and foreign, seek stability in taxation, clarity in digital regulation, and predictability in dispute resolution. In Trump's America, where executive volatility has become a feature of governance, India's steadiness can be an asset—but only if it is matched by reformist ambition. Third, the movement of people must be restored as a cornerstone of bilateral ties. The Indian diaspora in the US—now over 5-million-strong—has been a bridge of talent, entrepreneurship, and cultural diplomacy. Yet recent restrictions on work permits, H-1B visas, and green card processing have frayed that bridge. Liberalising skilled migration, especially in science, technology, engineering, and mathematics fields, would not only benefit both economies but also reinforce the human dimension of the partnership.

Despite the caste arithmetic suggesting a closer contest, all five regions of Bihar swung towards the NDA. The opposition alliance's inability to garner EBC votes in some pockets and consolidate Muslim votes in others made a big difference. Chirag Paswan and Upendra Kushwaha had their roles clearly cut out

The narrative surrounding the recent Bihar assembly election has been constructed in several overlapping ways. It has been interpreted as an expression of gratitude to, and trust in, a leader who is perceived to deliver on promises; as evidence of women emerging as anchors of voting decisions in poor households; and as a demonstration of how a tone of masculine arrogance can weaken emotional connect with voters. Across these different readings lies one clear lesson for the political class: admiration does not automatically translate into endorsement, especially among an electorate as politically attuned as Bihar's. The verdict itself has left little ambiguity. The NDA increased its tally dramatically, from 125 seats in 2020 to an emphatic 202. By contrast, the Mahagathbandhan suffered its worst performance since 2010, finishing with just 35 seats. These headline numbers are striking enough, but the real clarity emerges when the mandate is broken down regionally. A closer look at the five principal regions of Bihar shows how differently each area responded to the two competing alliances, rewarding some strategies while punishing others. As with the rivers that mark many of their boundaries, each region flowed in a particular direction. Take Tirhut first. Bordered by the Ganga and Gandak rivers and accounting for 73 seats, it forms the largest bloc in north Bihar. Tirhut was widely expected to witness a tight contest. This expectation stemmed from the substantial presence of one of the key Extremely Backward Classes (EBCs)—the Mallah community—whose leader, Mukesh Sahani, had crossed over to the MGB. As the VIP defector, he was projected as a deputy chief ministerial face of the MGB and expected to draw the fishers' community towards the alliance. His arrival was also seen as a direct challenge to Nitish Kumar's sustained cultivation of the EBC bloc since 2005. Yet, the results in Tirhut mirrored the broader state mandate. The NDA's tally jumped by 22 seats to 64. Its vote share rose sharply, from 39 percent to 46.6 percent. Much of this increase stemmed from the consolidation of its core vote blocs, aided significantly by Chirag Paswan's Lok Janshakti Party (Ram Vilas) rejoining the alliance. Although the MGB lost these 22 seats, its vote share, interestingly, also increased—by about 2 percentage points to 38.4 percent. This suggests that while the alliance did benefit from some Mallah EBC votes, the combined return of Chirag Paswan and Upendra Kushwaha's Rashtriya Lok Mortha shored up both Dalit Paswan and Kushwaha votes behind the NDA. A similar story unfolded in the Mithila region west of the Koshi river. This region has a significant presence of Muslims, Yadavs, and Mallahs, leading many analysts to



expect an uptick in MGB's performance. Sahani's roots in the region added weight to that expectation. Yet, the NDA increased its tally from 32 to 36 seats. Its vote share rose by about 6 percentage points, reaching 47.4 percent. The outcome reflected a noticeable improvement in the NDA's internal coordination, which enabled smoother transfer of votes across allies and ensured that each party's core bloc remained intact. This was an important correction for the NDA, given that some of these blocs had shown signs of drifting in the 2020 election.

The Seemanchal region, which borders Bengal and includes the Bhagalpur area, told a more nuanced story. With its sizeable Muslim population, ranging from around 68 percent in Kishanganj to roughly 40 percent in the three adjoining districts, Seemanchal was widely expected to consolidate behind the MGB. It was presumed to occur partly at the cost of the Asaduddin Owaisi-led All India Majlis-e-Ittehadul Muslimeen, which had won five seats with 7.4 percent of the vote in 2020. However, AIMIM retained its five seats and increased its vote share to 9.9 percent. This shift indicates that although Muslim consolidation against the ruling alliance did occur in places, the pattern was far from uniform. Muslim-majority constituencies displayed a willingness to experiment with alternatives. The most striking shift occurred in the Magadh-South East and

Shahabad-Bhojpur regions. These areas still retain pockets of Left influence and are home to several OBC and EBC caste groups. In 2020, the Left's organisational networks had significantly boosted the MGB, helping it secure 39 out of 69 seats in Magadh and 19 out of 22 seats in Bhojpur. The NDA, by contrast, had managed only 28 seats in Magadh and just two in the Bhojpur belt. In 2025, this picture changed dramatically. The NDA surged to 57 seats in Magadh and 19 in the Bhojpur region, supported by a substantial rise in vote share—13 percent in the former and 16 percent in the latter. For the MGB, this reversal stemmed from several factors. The RJD struggled to expand beyond its core Muslim-Yadav support in certain pockets, the Left parties saw their earlier momentum dissipate, and the Congress remained organisationally weak. Meanwhile, the NDA benefited from careful ticket distribution, the resolution of internal rivalries, and more efficient vote transfers among allies. Except for a few localised disruptions, this cohesion translated into a near-clean sweep. Taken together, the regional verdicts underscore a larger point. The 2025 Bihar election was shaped less by arithmetic and more by the ability of alliances to hold their blocs together while expanding into new social groups. The NDA managed this consistently, while the MGB faltered in the areas it needed to grow. That is what ultimately tipped the scales.

Telangana deflation casts light on factor keeping India's rate low

Plummeting rural demand could presage a more acute agrarian distress—less money in the hands of farmers or a lower inclination to spend. The worry for the state is acute

Statistics can confirm, challenge, or confound. In the case of October's retail inflation rates for Telangana and the nation, it can clarify too. Both the counts notched up records, but of different kinds. The national retail inflation rate printed at 0.25 percent, the lowest since the beginning of this Consumer Price Index series a decade and a half ago. On the other hand, in Telangana retail prices fell for the fourth time in five months—one of the dozen states that faced deflation in October. Among the causes contributing to both phenomena are GST rate cuts, higher bases a year ago, and lower food prices, which command a substantial combined weight in the CPI. It should be a moment to cheer—high growth estimates at a time of low inflation. However, economists advise a degree of caution. They argue that food inflation is unlikely to hold low for long because of a number of factors ranging from supply constraints to extreme climate events and geopolitical disruptions. Experts also point out that the shift to a new CPI series next year will affect calculations, as food items will carry less



weightage; non-food inflation is higher for most other categories at present.


The other side of the coin is seen in Telangana, the only state

to have registered a deflationary run this long. Between June's -0.93 percent and October's -1.16 percent, the state rate has remained subterranean—except in August, when it rose marginally to 0.94 percent before slipping again. Both urban and rural Telangana are in the same boat, though the price falls are sharper in the villages. Though this is good news for consumers, it isn't so for producers.

Plummeting rural demand could presage a more acute agrarian distress—less money in the hands of farmers or a lower inclination to spend. The worry for Telangana is acute because the state is running short of cash and, with GST rationalisation, stands to lose a substantial amount of revenues, at least in the short term. In other words, it cannot spend to spur the economy. This is the time to plug farm input shortages in the short term, measure and address rural indebtedness, and improve irrigation for better long-term prospects. The same could be said for many other parts of the country.

Lapses on the terror trail proved fatal

Police, intelligence agencies failed to anticipate and prevent attack near Red Fort



clear of the points made by Faridabad Police Commissioner Satender Gupta in his media briefing on November 10—a few hours before the Delhi incident. Gupta gave details of the operation conducted by the Faridabad police in which they had taken a doctor hailing from Kashmir into custody. All India Radio, which gave an account of Gupta's briefing, said his name was Mujjalab (actually, it is Muzammil). The police officer also revealed that the doctor was arrested 9-10 days earlier; media reports have stated that the arrest was made on October 30. Significantly, the Police Commissioner had admitted that a person was absconding and a probe was in progress in that matter. There have been a spate of media reports stating that the timely detection of the terror module prevented it from carrying out a series of blasts which would have resulted in a large number of fatalities. These reports are obviously based on 'sources', indicating that the police

and intelligence agencies are giving briefings to journalists. It would be best to await the result of the NIA investigation to know the granular details of the conspiracy, though some of the background briefings would contain some truth. What is certain, however, is that the state/UT police concerned and Central intelligence services failed to prevent the terror attack and apprehend the perpetrator, even though they knew for days that a member of the terror module was on the loose. They owe the country an explanation for this lapse. Clearly, the J&K police's claim that 'key operatives' had been apprehended was wrong. There can also be little doubt that the police investigation at the Al Falah University in Faridabad and the interrogation of Dr Muzammil would have revealed that the absconder was Nabi. Under these circumstances, why were all the resources of the state governments concerned and the Centre not used to apprehend Nabi? This was the first

terrorist act in the national capital after Modi assumed office in May 2014. It is good that the political leadership has assured that the "conspirators, collaborators and sponsors" of this terrible act will be found and meted out exemplary punishment. However, as the probe progresses, the powers that be must also focus on this insistent question: Why was Nabi not found and stopped before he could carry out the attack near the Red Fort?

The Cabinet expressed its gratitude to those countries which condemned this terror incident. These nations and the rest of the international community would be relieved that PM Modi has kept rhetoric in check and, as of now, not indicated a desire to reactivate Operation Sindoar. Nothing makes the major powers more jittery than a military conflict between two nuclear-armed states. On his part, Modi wants the India-US trade deal to be finalised. US President Trump has made positive noises on it, but these may change if armed hostilities were to recur. Also, Modi would not want Trump to get a fresh opportunity to claim credit for ending another round of war between India and Pakistan.

While these inhibitions have made PM Modi exercise caution, it can be surmised that the Red Fort attack would be a source of deep discomfort—notwithstanding the NDA's great victory in the Bihar elections. Signals would have been sent to Modi's supporters to dial down their vitriol, but for how long can this be so? Sooner or later, the PM would have to show his supporters and the country that terrorist groups which sponsored or incited this attack have been punished. Meanwhile, the attack's Kashmir link might further reduce the possibility of restoring statehood to J&K. While continuing with its UT status may be necessary for security reasons, it would continue to be a very sore point for the people of J&K. It's also vital for the national leadership to assert that all residents of the Kashmir valley are not terrorists or their sympathisers—on the whole, they are normal citizens of our great and plural country.

Odisha school head suspended after Class VII girl dies, locals protest alleged negligence

The Nabarangpur district administration suspended the headmistress of Kasturba Gandhi Balika Vidyalaya at Burja village under Umerkote block on Tuesday following the death of a Class VII student allegedly due to negligence of the school authorities.Umerkote block education officer (BEO) Iswar Majhi suspended headmistress Mamata Swain after 12-year-old Bhavani Harijan, a Class VII student of the residential school, died under mysterious circumstances on Monday evening with her family members holding the hostel authorities responsible for the death.

Sources said on the day, Bhavani's father Kartik Harijan filed an FIR in Umerkote police station alleging that though his daughter was unwell for the past three days, the hostel authorities did not provide her any medical care. Besides, they also did not inform the student's family members about her condition.

Kartik further claimed that his daughter was taken to Umerkote sub-divisional hospital (SDH) after she died in the hostel. Bhavani died due to the negligence of headmistress Swain and the hostel peon, Kartik alleged. After the news of Bhavani's death spread, locals including BJD and Congress workers staged dharna outside the SDH from 8 am demanding strict action against the school authorities and 10 lakh compensation for the deceased student's family members. They also did not allow the student's body to be taken for postmortem.

On being informed, district education officer Chhatrapati Sahu, additional SP Aditya Sen, SDPO Suvedu Sabar, other officials and former MP Pradeep Majhi reached the hospital and held discussions with the agitators. Subsequently, the protest was called off at 7 pm. The student's body was handed over to her family members after autopsy.

NIA chargesheets 10 for trafficking minor Bangladeshi girl into Odisha

BHUBANESWAR .(Agency)

The National Investigation Agency (NIA) has chargesheet-ed 10 people in connection with the trafficking of a minor Bangladeshi girl from across the east-ern border into Odisha.

In its charge sheet filed be-fore the Special Court in Bhu-baneswar, the agency has charged the accused of luring the girl on promise of employment and then pushing her into immoral trafficking to make money.Officials said the accused had taken advantage of the poor fi nancial condition of the girl's family to execute the trafficking operation. However, the NIA in-vestigation exposed a major human trafficking network in the case.

The Odisha police had initial ly filed two charge sheets in the Poco court against six accused in the case. After taking over the probe, the agency conducted searches in multiple locations in West Bengal and arrested two more persons. Examination of their social media accounts and financial transactions led the agency to arrest two more of their associates.

Accordingly, the agency filed a charge sheet against all the 10 accused under various sections of BNS 2023, the Poco Act 2012 and the Immoral Traffic (Prevention) Act 1956. Further investigation into the case is in progress, officials said. On November 9 last year, Cut-tack police had rescued the 17-year-old victim from Link Road in the city after she fled the rented accommodation of a couple.

Karnataka Zoo Authority confirms HS outbreak behind death of 31 blackbucks

BELAGAVI .(Agency)

A major wildlife health crisis has struck Belagavi, with the Karnataka Zoo Authority confirming that the mass death of 31 blackbucks at the Kittur Rani Chennamma Mini Zoo was caused by Hemorrhagic Septicemia (HS), a highly fatal bacterial infection known to kill herbivores within hours. A high-level expert committee led by Authority Member Secretary Sunil Panwal and senior wildlife veterinarian Dr Prayag inspected the facility on Tuesday and issued a preliminary confirmation of the outbreak after reviewing enclosure conditions, death patterns, and lab indicators. The team has directed zoo authorities to impose strict biosecurity controls, sanitation drives, and continuous surveillance of remaining herbivore populations. Carnivores, officials clarified, are not at risk from the disease.

District In-charge and Public Works Minister Satish Jarkiholi visited the zoo on Tuesday to review the emergency response and meet veterinarians, staff, and senior forest officials.

Calling the mass deaths "deeply alarming and unacceptable", the minister directed the zoo administration to tighten disease-prevention mechanisms and ensure round-the-clock veterinary monitoring for all animals — particularly endangered and high-stress species.

Expletives on hall-tickets: Mumbai college alleges 'external tampering,' files plaint with cyber cops

A day after the controversy over expletives in course registration forms and hall-tickets of students from Bandra's Government Polytechnic College came to light, an internal inquiry committee report found that the documents were "externally tampered with" and not from within the college. Higher and technical education minister Chandrakant Patil, taking cognizance of the matter, ordered an inquiry into the incident and also directed the principal of the college to file a complaint with the cyber crime cell based on the committee's report. The principal, along with officials from the joint director, technical education, regional office, filed the complaint on Tuesday.

The controversy began with the circulation of screenshots, allegedly showing an official course registration form for students with obscene content printed in place of their names. The minister had directed an urgent inquiry into the incident at the autonomous polytechnic istitute.

The investigation centered on a student, whose name was linked to one of the screenshots. The committee's cross-verification of the screenshot with the student's genuine form,

ensures secure access via a one-time password and direct email delivery. The committee, after examining the students' hall tickets, course registration, and exam registration forms downloaded directly from the official system, found no objectionable content.

The said student provided a written statement to the committee confirming that he did not find any objectionable content on his personal printouts. Based on the evidence, the inquiry committee concluded that the course registration form "had been maliciously tampered with after it was officially generated".

On Monday, some of the students alleged they were not allowed to appear for the exam as their hall-tickets were not generated. This, they claimed, was due to the input provided in the system, that had replaced their names with expletives and obscene language. The institute, however, in the report, claimed that no students were deprived of taking the exams on Nov 17, and that the exams for the said course were scheduled to commence from Nov 18. The students had approached former MLA Naseem Khan with their complaint.



Ahmedabad flyover tragedy: Court frames charges against Tathy Patel, his father

Ahmedabad.(Agency)

It took 28 months and a Supreme Court order for a trial court to frame charges against 21-year-old Tathy Patel and his father, Pragnesh Patel, on Tuesday in connection with the Iskcon flyover accident on July 20 2023, in which nine people lost their lives.

Police filed a 1,684-page chargesheet in a week after the then state home minister, Harsh Sanghvi, promised quick justice in the accident case. The car, allegedly being driven at high speed by Tathy, rammed into a crowd of people who had gathered on the flyover, where an accident had already taken place.

Principal district judge K M Sojitra read out the charges before Tathy and his father. Tathy was charged under Section 308 (attempt to commit culpable homicide), 304 (culpable homicide not amounting to murder), 337

generated from the institution's secure management information system (MIS), revealed significant discrepancies. The report highlighted differences in the name of the institution, the student's name, and the 'register for' column, strongly suggesting forgery. The report also mentioned that the MIS system

endedangering other person's life), 279 (rash driving), besides provisions of the Motor Vehicles Act. His father was charged under 506 (2) (criminal intimidation) and 504 (insult to provoke breach of peace), said district govt pleader Pravin Trivedi.

After the chargesheet was filed, Tathy and his father had sought discharge. Tathy did not seek discharge from all the allegations but sought to alter the charge from Section 304 of

the IPC to Section 304A (criminal negligence causing death), which has a provision of two years of imprisonment, and deletion of Section 308 of the IPC. A trial court turned down their discharge pleas, and they moved the Gujarat high court, where their discharge pleas have been pending for nearly two years.

Due to the pendency of the discharge pleas, the trial court did not move ahead with the criminal case. Tathy sought regular bail, but the trial court, as well as the high court, denied it. He then moved the apex court for bail and argued that the trial had not commenced even after over two years of the incident. On Nov 3, SC directed the trial court to complete the charge framing procedure within three weeks and proceed with the examination of witnesses, regardless of the pending discharge applications in the high court, which was hearing.

Survey says 90 per cent of adults in Tamil Nadu personally experienced effects of global warming

CHENNAI .(Agency)

A striking 90% of adults in Tamil Nadu say they have personally experienced the effects of global warming, the highest in the country, according to the newly released Climate Opinion Maps for India by the Yale Program on Climate Change Communication.

The findings align with what the state's own Economic Survey has repeatedly said, Tamil Nadu is on the frontline of rising temperatures, altered rainfall patterns and an escalating burden of extreme weather.

The survey also shows that 66% of adults in Tamil Nadu report knowing "a lot" or "something" about global warming, again among the top in India. Experts say this heightened awareness may be linked to the state's high urbanisation, concentrated industries, and recurring climate-linked disruptions, from heat stress in cities to erratic monsoon spells affecting reservoirs and agriculture. For comparison, awareness levels are significantly lower in states such as Uttar Pradesh (52%) and Bihar (48%), while higher levels are seen in Kerala (62%) and Delhi (70%).

In recent years, the state government has established the Tamil Nadu Governing Council on Climate Change and updated its State Action Plan on Climate Change, signalling an institutional effort to respond to rising

risks. Still, the new district-level data reveal a deeper perception gap. While 74% of adults in Tamil Nadu believe global warming is influencing severe storms, only 21% say they have personally experienced such storms in the past year.

By contrast, Odisha reports 64% of adults experiencing cyclones, and Rajasthan reports 28% of adults experiencing severe floods in the same period. The survey, conducted between 2022-25, covered 9,644 respondents from 575 of 634 districts in India, spanning across all states and union territories except Lakshadweep and Andaman & Nicobar Islands.

Across India as well, the survey revealed that the majority of people think global warming is affecting heat waves (78%), droughts (77%), cyclones (73%) and floods (70%), even in states where recent exposure has been low. In Haryana and Rajasthan, for instance, 80% of adults report experiencing severe heat waves, compared to just 55% in Kerala and 52% in Tamil Nadu.

Jagadish Thakker, senior lecturer, University of Queensland, said, "As India rapidly develops while facing intensifying extreme weather, understanding how people across states and districts perceive and experience climate change is essential."


The civic body's ambitious Rs 500-crore streetlight automation plan — put in place after authorities took five to six hours to turn off all the lights during Operation Sindoor in May — has hit an unexpected roadblock.

The AMC cancelled the tender after learning that the consultant who drafted it had been appointed without following the required bidding process. The revelation emerged just as the tender was nearing finalisation. The corporation is now examining how the lapse occurred and is preparing to restart the process with proper procedures.

According to sources, the AMC commissioner was informed that the consultant involved in drafting and finalising the Rs 500-crore tender for the supply, installation, testing, and commissioning (SITC), maintenance, operation, and automation of all streetlight poles in the city, was not empanelled with the corporation. Further, the consultancy assignment itself had been given without inviting bids, raising concerns about violations of procurement norms. Officials said the discovery left AMC with no option but to halt the tender and reassess the process.

The situation has unfolded at a time when the

city's streetlight maintenance system is already strained. On Jan 10, 2020, AMC had awarded a five-year contract for comprehensive streetlight maintenance to Citadelum India



Pvt. Ltd. At the time, the city operated 1.69 lakh streetlight poles; that number has since increased to 2.1 lakh. The contract formally expired on Jan 10, 2025, but the contractor declined to continue services further, despite repeated requests from the corporation. Meetings between AMC officials and the contractor continue, though the agreement has officially ended.

HC cancels closure of concrete unit at minister Sarnaik's behest

Bombay high court has set aside Maharashtra Pollution Control Board's directions for closure of a ready mix concrete plant in Ghodbunder village, Mira Bhayandar, observing it was at the behest of transport minister Pratap Sarnaik. "Quite clearly the communication dated Oct 8 containing the closure directions has been issued by the regional officer, MPCB at the instance of the letter dated Sept 9 (by Sarnaik)," said chief justice Shree Chandrashekhar and Justice Gautam Ankhad.

Raj Transit Infra Pvt Ltd challenged the Oct 8 order by MPCB's Thane office to immediately close down its plant and disconnect electricity and water supply. It said it had obtained licenses and approvals including from Mira Bhayandar Municipal Corporation and MPCB which had

recorded that the plant satisfied all environmental parameters.

On July 2, the company was issued a closure notice for not furnishing a bank guarantee and for its ambient air quality monitoring data not being linked to MPCB's server. It replied saying it had complied with both conditions. On Oct 7, it placed relevant documents before MPCB member-secretary. The next day directions were issued to close operations. On Oct 22, the HC vacation bench restrained disconnection of water supply and electricity until Nov 10.

MPCB's advocate Jaya Bagwe said facts can be ascertained after the physical verification of the plant. But the judges, after examining the material on record and in particular Sarnaik's Sept 9 letter, said there was no need to call for response



affidavits. "The reason is that the entire exercise undertaken by the MPCB is initiated in view of the complaint made by the minister..." They referred to the argument of senior advocate Ashish Kamat with advocate Apurva Gupte, for the company, that the July 2 show-cause notice did not refer to Sarnaik's complaint. A reference of his Sept 9 complaint letter was made "for the first time" on Oct 8. The judges said the closure "thus suffers from the vice of bias and has been issued against the rules of natural justice."

They granted MPCB liberty to inspect the plant "and if any deficiency is detected, it may issue a show-cause notice after affording... opportunity to the... company to rectify those deficiencies."

No metro for Coimbatore and Madurai, Centre cites population as prime reason

CHENNAI .(Agency)

The union housing and urban affairs ministry has rejected Tamil Nadu's proposals to build metro rail systems in Coimbatore and Madurai, arguing that both cities fall short of the population and ridership norms laid out in the 2017 Metro Rail Policy.

The detailed project reports (DPRs) submitted by TN overstate demand and underestimate engineering constraints, the ministry's missive to the state government, accessed by, said. The ministry, in its letter dated November 14, said it had conducted a "careful and thorough" appraisal of the DPRs after TN sought approval for the projects under a 50:50 equity-sharing arrangement with the centre. A senior state government official also confirmed the rejection.

For Coimbatore, the ministry said the proposed 34-km network is unlikely to attract the 5.9 lakh daily passengers projected in the DPR — a figure higher than the 4 lakh riders that Chennai Metro's 55-km Phase I system recorded in February 2025.

The ministry noted that average trip lengths in the city are relatively short, typically 6-8 km, reducing the time-saving advantage of a metro. With road traffic speeds already approaching those of the proposed system, "it is most unlikely that there will be a shift to the metro from other modes," the appraisal said. It also flagged engineering and design concerns, stating that many stretches along the alignment sit on roads as narrow as 7-12m, making elevated structures and 22m-wide stations technically challenging without costly demolitions.

Centre: Lower-cost transit systems would offer better value for money in Madurai

The DPR's assumption that the project could be built in three years was dismissed as unrealistic, while its economic and financial rate-of-return calculations were found to deviate from appraisal guidelines. Crucially, the centre emphasised that Coimbatore's population — 15.84 lakh within municipal limits as per the 2011 Census — does not meet the 2-million threshold required under the Metro Rail Policy for initiating the metro-rail planning.

AAP, BJP trade charges over stubble burning as Delhi's AQI crosses 400

As Delhi's air turns 'severe', AAP blames BJP-run agencies for most of the pollution and cites a sharp fall in Punjab stubble fires, while the BJP accuses AAP of shifting its stand.

Supreme Court asks to move children's sports activities to pollution-safe months



New Delhi.(Agency)

In the wake of the worsening air pollution in Delhi, the Supreme Court on Wednesday asked the Commission for Air Quality Management (CAQM) to issue directions advising that sports activities in schools should be shifted to pollution-safe months. The court observed that allowing such activities during November and December, when the pollution levels are at their peak, "amounts to putting school children in a gas chamber".

The Chief Justice of India-led bench's direction came after the amicus informed the court that the Delhi government has scheduled inter-zonal sports competitions for under-16 and under-14 students during the two months when the air quality is at its worst.

Delhi HC flags six-year delay in pleas linked to 2020 riot cases, seeks status report from police

Highlighting years of stagnation in a clutch of petitions linked to the 2020 northeast Delhi riots, the Delhi High Court on Tuesday asked the city police to place on record the latest status of the investigation. The direction came as the bench noted that several pleas — including those seeking criminal action against political leaders for alleged hate speech — have remained pending since 2020



without the petitioners invoking alternative statutory remedies available to them. A division bench of Justices Vivek Chaudhary and Manoj Jain, while hearing multiple matters arising from the February 2020 communal violence, flagged the prolonged pendency. The judges orally observed that although an alternate remedy existed, "the petitioners have not availed it," adding that the cases had remained before the court for six years.

During the hearing, counsel for one of the petitioners referred to the casualties in the riots. The bench responded that FIRs had already been registered and that the probe lay with the police, leaving little for the HC to adjudicate in the present writ petitions.

When the lawyer argued that the police were not conducting a fair investigation and urged the court to order an independent probe, the bench reiterated the proper legal course, "You challenge it before the magistrate. The magistrate will supervise. These are questions of fact. We cannot entertain questions of fact in writ petitions. You can give that evidence to the magistrate, who will look into it and pass orders. The HC cannot do this."

The Aam Aadmi Party (AAP) and the BJP traded sharp accusations on Tuesday over responsibility for Delhi's crippling air pollution crisis, which continues to drive the city's Air Quality Index (AQI) past the 400-mark. Blaming the BJP-led Municipal Corporation of Delhi (MCD) and other agencies for the city's toxic smog, AAP Delhi State President Saurabh Bharadwaj said, "Today I read in a newspaper that the contribution from stubble burning for city's pollution is only 8% percent. This means 92% of this pollution is the responsibility of the Delhi government, MCD and all the agencies here which are all BJP controlled." Bharadwaj cited statements from two central government institutions—the Secretary of the Department of Agricultural Research and Education, and the Director General of the Indian Council of Agricultural Research—to highlight a 95% reduction in stubble burning incidents in Punjab under the AAP

in a swift rebuttal, Delhi BJP president government. He presented satellite data showing a decline in total stubble burning incidents across the region: from 1,07,000 in 2020 (with 83,000 in Punjab) to an estimated 3,500 to 4,000 this year. "This means a near 95 percent decline from 83,000," he claimed, adding that central departments had congratulated the Punjab Government and Punjab's farmers for this achievement. Bharadwaj then targeted the BJP-led government for alleged pollution mismanagement, accusing officials of data manipulation by shutting down and hosing down AQI monitoring stations to falsify readings. He also claimed that officials responsible for enforcing the Graded Response Action Plan (GRAP) had turned fines for construction activity into a "money making business," indicating rampant corruption considered vulnerable to radicalisation.



Virendra Sachdeva condemned the AAP's statements and reaffirmed that while stubble burning may not be the primary cause, it is "certainly a major factor." Sachdeva highlighted past actions by the AAP government, noting that then-chief minister Arvind Kejriwal had written multiple letters to both the Punjab and Central governments between 2015 and 2021 demanding a ban on

stubble burning in Punjab. Furthermore, Sachdeva questioned the consistency of AAP's messaging. He referenced previous statements by former AAP Environment Minister Gopal Rai from 2022 to 2024, in which Rai annually acknowledged only a 25 to 30 percent decrease in stubble burning since the AAP came to power in Punjab.

"The people of Delhi want to know from Bhagwant Mann whether Arvind Kejriwal and Gopal Rai also falsely accused Punjab of increasing Delhi's pollution," Sachdeva said. He also claimed that the central government had provided numerous resources to the Punjab government for stubble pollution control, which had not been properly distributed to farmers. At present, Stage-III of the extant GRAP is in force across the entire NCR. Stage-III of GRAP imposes stringent measures when the Air Quality Index (AQI) reaches the "severe" category.

Nobody killed Nithari children? Moninder Pandher bares all on 19-year mystery

For months, between 2005 and 2006, Noida's Nithari, barely an hour away from Delhi, saw several women and children vanishing one after another. A probe revealed a macabre tale involving skeletal remains in drains and allegations of rape, murder and necrophilia. It led to bungalow D-5 in Nithari, and both its occupants - homeowner Moninder Singh Pandher and his domestic help Surinder Koli - were arrested. However, both have now been acquitted, leaving a single unanswered question: Who killed the children?

Pandher, a businessman, saw his life turn topsy-turvy after he was arrested and spent nearly 17 years in jail after being acquitted in all cases against him in 2023. Now, in an exclusive interview with India Today, Pandher has bared all on the mystery, the missing children, the behaviour of Koli and other sensational allegations.

BLAMES MEDIA FRENZY

Pandher, who was labelled as co-accused, claimed that media frenzy, public pressure and lapses by the investigating agencies derailed the probe into one of the country's most chilling serial-killing episodes. The incident has been captured in a film 'Sector 36', starring Vikrant Massey. Pandher said he had no role in the killings and the CBI never filed a chargesheet against him in any murder or rape case.

Who is responsible then? Is the police responsible? Am I responsible? Is someone else responsible? Many people are responsible. If the investigation had been proper, the truth would have come out," Pandher said.

Pandher said he believed the investigation was "110% influenced by media pressure" and parallel narratives "totally misled" the probe team. "Questions asked to me were the same ones published in newspapers each morning," he claimed.

ON MISSING CHILDREN

Between 2005 and 2006, several children, mostly young girls, went missing from Nithari. Their skeletal remains were later recovered from a drain behind Pandher's house, D-5. Pandher claimed stories of missing children surfaced only after the case broke in 2006. "Most missing children were last seen around houses D-1 to D-6, and sometimes beyond the Nithari bridge. It was not clearly limited to D-5," he said. Pandher also claimed that he stayed at the Nithari residence only a couple of days a week because of his business. He claimed that even months before the case was exposed, a police picket was stationed outside his house.

Students, activists seek action against Delhi's toxic air

New Delhi.(Agency)

Nearly a hundred citizens, including students, activists, parents, and senior citizens, gathered at Jantar Mantar on Tuesday to protest the worsening air pollution crisis in the capital. This marks the second significant demonstration in the city aimed at raising an urgent voice against the escalating pollution threat, which poses a severe health risk across all age groups. The protest drew notable participation from senior citizens and young children, the two groups most vulnerable to toxic air.

Manisha, a 62-year-old South Delhi resident, highlighted the dire situation, stating, "The issue of air pollution is so serious that it has compelled us to raise our voices. I normally don't come for protests... but the air

pollution has moved me." She expressed deep concern for her grandchildren's "smoggy future."

The demonstration took place as the Central Pollution Control Board



(CPCB) continued to report "severe" pollution levels, with the city's Air Quality Index (AQI) touching 344 on Tuesday morning. Forecasts indicate the air quality is likely to remain in the "very poor" category over the coming days. Spearheaded largely by

the youth, the rally saw a poignant moment when a seven-year-old child, clad in his school uniform, attended with his visibly concerned parents. Namrata Yadav, the boy's mother, said, "It's not that only people with asthma will face issues, everyone's having a problem. It has permeated into our lives and you never know who will get it." Protesters held placards with slogans like, "If air is free, why is breathing a privilege?" and "Crores for campaign, zero for clean air. Is this governance?" Some of them were also seen wearing industrial-grade respiratory masks as symbolic props at the protest. Environmental activist Vimlendu Jha was also present, emphasising that he was demonstrating not only as an activist but as a father.

Fraud, Forgery, And More: How Al Falah University Duped Students Of Crores

New Delhi.(Agency)

Widespread irregularities have emerged at the Faridabad-based Al Falah Charitable Trust and its affiliated institutions that have been under the scanner amid a probe into the November 10 Delhi blast. The institutions have been accused of making huge profits by showing false accreditation, with the Enforcement Directorate (ED) claiming before the court that it had earned about Rs 415 crore through false claims. Jawad Ahmed Siddiqui, founder and chairman of the Al Falah, was arrested by the ED in the terror financing-linked money laundering



investigation. A court has remanded him to ED custody for 13 days—till December 1. The probe into the alleged violations under the Prevention of Money Laundering Act (PMLA) has revealed that the bank accounts and income tax returns

(ITRs) of the institutions were under a single Permanent Account Number (PAN), indicating that financial control had been vested in a single trust.

An examination of the ITRs since 2014-15 showed shocking figures. The ITRs revealed that during 2014-15 and 2015-16, Rs 30.89 crore and Rs 29.48 crore were shown as donations. From 2016-17 onwards, the university began showing its income as academic income. A sharp rise in income was noted since 2018-19. The income went up from Rs 24.21 crore in 2018-19 to Rs 80.01 crore in 2024-25. This totalled Rs 415 crore during these seven years.

Promised electric heaters for Delhi's Resident Welfare Associations yet to arrive as winter sets

RWAs say not a single heater or guideline has reached them even as temperatures drop, forcing guards to light fires and raising questions over the practicality and implementation of the government's plan.

New Delhi.(Agency)

Three months after the Delhi government announced that it would distribute electric heaters to Resident Welfare Associations (RWAs) to discourage open burning during winter, none of the units have reached the ground, residents' groups across the city said. The assurance was made in September by

Environment Minister Majinder Singh Sirsa, who had said that 3,000 heaters would be provided through the Delhi State Industrial and Infrastructure Development Corporation (DSIIDC) as part of a push to reduce winter air pollution. With temperatures dipping to 8.7°C in recent days, RWAs say they are struggling to prevent security guards and domestic workers from lighting small fires to stay warm.

Many stress that they have not received heaters or even official communication on how the distribution would take place. "None of the RWAs in Rajinder Nagar has received any heaters so far," said Arvind Mehta, President of the Joint Forum of Residents, Rajinder Nagar. He said residents had constructed small

wooden cabins for security guards to shield them from the cold, but many continue to light fires on roadsides.

Mehta also alleged that other pollution-



control measures were missing.

"No dust control measures, no smog guns are frequent here. As a result, despite being surrounded by the ridge on three sides, pollution levels are still very high

in Rajinder Nagar." The idea itself may be unworkable, RWA representatives said. Saurabh Gandhi, general secretary of United Residents of Delhi (URD), said none of the RWAs in their network had received heaters nor any official intimation regarding distribution. "I don't think the idea is practical. It would work only in places where the RWA has a guard room. You need an enclosed space with an electricity connection. Guard rooms are uncommon. Only some posh colonies in South Delhi would have these," he said. Even in cases where guard rooms existed, many lack electrical connections, he added.

"Also, there are 25 guards in my RWA. How will one heater suffice?" DSIIDC officials declined to comment on the status of allocation or distribution.

England's Bazball was designed only for Ashes in Australia: Ponting's stunning claim

Former Australia captain Ricky Ponting has claimed that England's Bazball philosophy was crafted with a single purpose: to win the Ashes in Australia, while also accusing the team of being dishonest in the way they publicly speak about their style and their results. Ponting told 7NEWS that England's aggressive approach under Brendon McCullum and Ben Stokes has always been aimed at conquering Australian conditions, even if the team has packaged it as a long-term revolution. They're a side that have been together for two years (since the 2023 Ashes) building up to this," Ponting said. "Bazball, as far as I'm concerned, and I know Brendon reasonably well, was only designed for this one series. Forget about everything that's happened over the past two years, it was all about having a group together and a style of play that can stand up and win Test matches in Australia. "They've only done it four times in the past 25 years, and they are going to need



to do it at least three times this summer, so I can't wait to see how they play."

TACTICS SLOWLY EVOLVING

When McCullum first took charge in 2022, England embraced an ultra-aggressive method of play, scoring at high rates and attempting unconventional shots in unusual parts of the ground. It gave them brief periods of dominance but produced inconsistent results. Ponting believes England have tempered their approach since failing to win the 2023 Ashes at home.

"I think it has slightly changed," he said. "In its inception, it was a lot more reckless than it is now. I think now they are identifying moments better. "I do not think Joe Root is taking it on as much as he did. I do not think Ben Stokes is taking the whole Bazball thing as much as he probably once did at the start of it, but their openers do. And Ollie Pope tries to as well. That is why I think their openers are so important."

Curacao becomes the smallest-ever nation to qualify for FIFA World Cup

Curacao have completed one of football's most extraordinary fairytales, becoming the smallest country ever to qualify for a FIFA World Cup finals after grinding out a tense 0-0 draw against Jamaica on the final night of the Concacaf qualifying campaign. The tiny Caribbean nation, with a population of just 156,000, sealed their place at the 2026 tournament alongside Haiti and Panama after a dramatic conclusion across the region. The Blue Wave arrived in Kingston knowing that avoiding defeat would secure their passage to next year's expanded 48-team World Cup in the United States, Canada and Mexico. What followed was a nerve-shredding, backs-against-the-wall display as they clung on under waves of Jamaican pressure to claim the point that rewrote football history.

Curacao, covering a land mass of just 444 square kilometres, have now eclipsed Iceland's record as the smallest nation to reach a World Cup finals. Iceland, who stunned the world with their Euro 2016 run and qualified for the 2018 World Cup, had a population of roughly 350,000 at the time, which is more than double



Curacao's. Remarkably, Curacao navigated the entire qualifying campaign unbeaten. Their journey featured a resounding 7-0 demolition of Bermuda and consistent performances across all six matches to finish top of Group B with 12 points, one ahead of Jamaica. The achievement came despite the absence of veteran Dutch coach Dick Advocaat, who missed the decisive match for family reasons in the Netherlands. For a nation that only became a FIFA member in 2010 following the dissolution of the Netherlands Antilles, the qualification marks an unprecedented moment in its sporting history. Curacao will discover their group-stage opponents when the World Cup draw is held on 5 December at the Kennedy Center in Washington D.C.

Indian football team suffers embarrassing 0-1 loss to Bangladesh in Asian Cup qualifiers

India's last defeat against Bangladesh was during the 2003 SAFF Gold Cup, where the latter had prevailed 2-1 at the same venue in Dhaka.

DHAKA: India suffered their first defeat against Bangladesh in 22 years, going down 0-1 to the home side in an inconsequential Group C match of the Asian Cup qualifying round match here on Tuesday. Sheikh Morsalin scored the all-important goal for Bangladesh in the 11th minute to the wild cheer of the capacity crowd at the National Stadium here. The match, though, had been rendered inconsequential as both the sides were out of contention of the 2027 continental showpiece. India got a golden scoring chance in the 31st minute but Lallianzuala Chhangte's right-footed shot from the top of the box after Bangladeshi goalkeeper Mitul Marma was completely out of position was headed away by Hamza

Choudhury. There was an instance of pushing and shoving among some players of the two teams near the touch line in the first half but the referee brought it under control. India's last defeat against Bangladesh was during the 2003 SAFF Gold Cup, where the latter had prevailed 2-1 at the same venue in Dhaka. Since then, the two sides had faced each other in nine matches before Tuesday, and India had won three times while six were drawn affairs. India's campaign for the 2027 Asian Cup had effectively ended on October 14, when they squandered a 1-0 lead to lose 1-2 to Singapore in Margao, Goa. By virtue of the defeat, a winless India remained rooted at the bottom of the four-team table with just two points from five matches. This was their third loss in the third round of the qualifiers. The other two matches were drawn affairs.

After the win, Bangladesh, who notched their first win in five matches, remained on third with five points. The first leg match between the two sides had ended in a goal-less draw on March 25 in Shillong. Singapore, who defeated Hong Kong 2-1 earlier in the day in Hong Kong, sealed the top spot in Group C with 11 points and qualified for the 2027

Asian Cup. Hong Kong are in second place with eight points. India are currently ranked 136th in the FIFA chart while Bangladesh are at 183rd. India play their last match of the



2027 Asian Cup qualifiers against Hong Kong at home on March 31, 2026. Lallianzuala Chhangte played his 50th international match on Tuesday, while India head coach Khalid Jamil handed debuts to Mohammed Sanan and Lalremtluanga Fanai, bringing the two on from the bench.

After conceding the goal in the first half, the Blue Tigers mounted a barrage of attacks on Bangladesh in the second half. They came out with more intent in the second session, as Jamil introduced Mahesh Singh Naorem in place of Nikhil Prabhu. The substitution brought immediate impact, with Mahesh using his creativity to trouble the Bangladeshi defence. Suresh whipped a free-kick from the left into the box, which was headed goalwards by Rahul Bheke, with Rahim Ali waiting at the goalmouth to turn it in. However, Bangladesh's defenders managed to clear the danger. The introduction of Sanan created further opportunities for India, as the winger used his trickery and awareness on the left flank. Receiving a pass from Rahim in the 66th minute, Sanan dummied his marker to cut inside and shoot, but his effort was saved. A minute later, the winger hung a beautiful cross from the left towards an unmarked Brison Fernandes, who headed wide. Amid the Indian attacks, Bangladesh looked to create a few counters of their own and came close to doubling their lead in the 79th minute when Topu Barman's strike from outside the box was collected by a diving Gurpreet Singh Sandhu.

I don't care: Zimbabwe captain stuns Pak journalist with blunt reply before tri-series

Zimbabwe captain Sikandar Raza did not hold back when he delivered a blunt yet composed response to a reporter during a press conference ahead of the tri-series involving Pakistan and Sri Lanka in Rawalpindi. Raza's exchange with a Pakistani journalist has since gone viral on social media, with many praising the all-rounder for handling an unrelated question with both grace and firmness. The moment occurred when Raza addressed the media in Rawalpindi a day before the tournament opener between hosts Pakistan and Zimbabwe. A reporter attempted to draw him into an online debate, asking him to rank the best T20 sides in Asia and whether Zimbabwe were facing the first-, second- or third-best Asian team in the tri-series. Here is how the exchange between Sikandar Raza and the Pakistani journalist unfolded: Reporter: "There is a debate going on social media. I need an honest opinion from you. Who is the second-best and best T20 team



final Test surface once the board's team arrived. "No, no, I don't get involved at all," Ganguly told India Today when asked whether the Indian team management sought his expertise before finalising the pitch. And you've heard Gautam Gambhir say after the game that he wanted that sort of a pitch and was given that sort of a pitch. So you keep the captain and the coach's request," he said.

Ashes: Lightning halts Australia's training session ahead of 1st Test in Perth

Australia's final preparations for the opening Ashes Test were disrupted on Wednesday when their main training session at Perth Stadium was abruptly halted after lightning was detected near the venue. The suspension came despite bright, sunny conditions, leaving players and staff briefly puzzled as they were ushered off the field. The squad had completed around 40 minutes

of fielding drills and were moving into their net session when officials intervened. Bowlers had only just begun warming up when all players, coaches and media were directed indoors at approximately 10:30am local time - a significant interruption on the team's last major training day before facing England.

Event officials stressed that the stoppage was in line with established safety rules, noting

that "if lightning is 5kms or less away from the ground, then outside activity needs to stop." These protocols are standard across major sporting venues in Western Australia and have caused similar delays in AFL and other events in recent years. The timing of the halt was far from ideal for Australia, who were looking to fine-tune their match plans and adapt to conditions ahead of the series opener. With no rain in sight, the players were left in limbo inside the dressing rooms, uncertain whether they would be cleared to resume training later in the day.

While the weather remained clear above the stadium, the continued presence of lightning within the restricted radius meant the session risked being scrapped altogether if conditions failed to shift. Such safety-first interruptions, though common in the region, added an unwelcome layer of unpredictability to Australia's build-up. England are scheduled to use the stadium later in the afternoon, with their preparation block expected to begin around 2pm local time.

I personally don't care who the first, second, third or fourth-best team in Asia is. We're the second-best team in Africa and we're looking to build on that. We're trying to challenge the best team in Africa." Raza was also visibly unimpressed when asked whether Zimbabwe reaching the final of the tri-series involving Pakistan and Sri Lanka would be considered an upset. "It might be an upset for you. I can read the room. Maybe you people are not giving us too much of a chance," he said.

Shane Warne's magic lives on: England fans to make emotional tribute on Boxing Day

England's Barmy Army is preparing a fitting tribute to honour the late Shane Warne during the Boxing Day Test at the MCG, marking the first Ashes clash at the venue since his passing and uniting fans beyond traditional rivalry.

The popular English supporters' club, the Barmy Army, is reportedly preparing a special tribute to the late Shane Warne during the Boxing Day Test of the upcoming Ashes series in Australia. Known for their loud chants, humour, and ability to bring

colour to any cricket ground, the Barmy Army now appears ready to honour one of the sport's greatest icons in a heartfelt gesture. According to a report by news.com.au, the supporters' group has personally promised Warne's son, Jackson Warne, that they will organise a meaningful homage to the legendary leg-spinner during the marquee fixture at the Melbourne Cricket Ground (MCG). The Boxing Day Test is traditionally one of cricket's biggest annual events, but this edition holds added emotional significance. It will be the first Ashes Test at the MCG since Warne's passing in March 2022, marking a poignant moment for fans on both sides of the rivalry. Jackson Warne revealed that the Barmy Army had reached out to him, indicating that something special is in the works. "I am not sure what that is yet, but they've said, 'Jacko, stay tuned,'" he said on Tuesday.

English fans in particular grew increasingly fond of him after his retirement, when he transitioned seamlessly into commentary. Although the specifics of the planned tribute remain under wraps, one thing is certain: the Barmy Army intends to honour Warne in a manner befitting a modern-day great.

Growth shares crash 10% to hit lower circuit. Why are investors booking profits

New Delhi.(Agency)

Growth's parent company, Billionbrains Garage Ventures, saw its first big stumble on Wednesday after registering a stellar post-listing rally.

The share price of Growth fell 10% in early trade and slipped straight to the lower circuit, a sharp contrast to the over 90% rally investors had witnessed over the past few days. The fall looks like a classic case of profit-booking after an overextended run. Growth listed at Rs 100 on November 12 and had almost doubled in just four sessions, touching Rs 194. Moves like these are usually followed by a cooling-off period as early investors and traders lock in gains while sentiment is still strong. **THE SHORT SQUEEZE**

A big part of today's slide also comes from what unfolded on Tuesday. More than 30 lakh shares were pushed into the auction window at the NSE after many traders short-sold the stock expecting a dip. Instead, Growth kept rising, leaving them unable to deliver shares on the settlement date.

That squeeze had signalled how overheated the counter had become, and once the pressure eased, the stock was bound to correct.

UPCOMING Q2 RESULTS

Another reason for the pause is the lack of financial clarity. The company has not yet declared quarterly results and will announce numbers on November 21. Without earnings in hand, a significant part of the rally was driven by sentiment and enthusiasm around a popular fintech brand. Some investors now prefer to wait for actual financial data before chasing the stock further. Growth has still delivered one of the strongest post-listing performances of the year, and Wednesday's correction looks more like a reality check than a trend reversal.

Volatility may continue until the earnings announcement, but the broader picture will depend on whether the company's numbers can justify the steep early valuation.

Silver Prices To Rebound To \$52 In Near Term, ETFs Outperform Physical Metal

New Delhi.(Agency)

Silver prices will rebound to \$52-\$53 an ounce and then potentially advance to \$58 and \$62, with strong near-term support at \$47.60, a report said on Tuesday, giving investors price target levels for the next 12 months.

Silver exchange-traded funds (ETFs) and silver fund-of-funds (FoF) outperformed physical silver over the past 3 years due to robust fund management, efficient tracking, and growing investor confidence, the report from Emkay Wealth Management said. The wealth management firm expects further strong support levels for silver at \$45.60 and \$42.00, in that order. The report cited one-year gains of over 50 per cent by leading silver ETFs versus about 49 per cent for physical silver. Over three- and six-month periods, returns ranged between 34-56 per cent, underscoring the strength of the rally, it added.

Emkay Wealth Management said that despite short-term volatility, the fundamentals of the silver market remain strong. Rising industrial demand from sectors such as renewable energy and electronics, coupled with constrained supply, continues to support long-term price stability. Silver fund of funds also mirrored this trend, delivering one-year returns of around 49 per cent to 50 per cent. The minor difference in performance versus ETFs stems from fund-level expenses. After a brief correction, silver prices are hovering around \$48.80 an ounce amid profit booking and easing US-China trade restrictions on critical minerals. Global mining output has grown only modestly and is expected to peak by 2026, even as industrial and investment demand climbs, driven by solar photovoltaics, electric vehicles, electronics, 5G infrastructure, and semiconductors.

RP-Sanjiv Goenka Group enters luxury fashion space with 40% stake in FSP Design

CHENNAI.(Agency)

RPSG Ventures has moved into the luxury fashion space with a significant investment in FSP Design, the company behind the Falguni Shane Peacock label. The venture arm of the RP-Sanjiv Goenka Group is buying 40 percent of the company at a valuation of a little over Rs 455 crore, with the entire payment made in cash. It also has the option to pick up an additional 10 percent stake within the next two years, signalling that this may be the start of a deeper partnership. FSP Design, which generated about Rs 92 crore in revenue in FY25, operates across exclusive brand outlets, multi-brand luxury stores and international online platforms. For RPSG Ventures, the move marks a deliberate shift into a premium consumer category it has not previously tapped. The group's portfolio traditionally spans IT, business services, FMCG, sports, and real estate, making high-end couture an unconventional—but potentially high-margin—addition.

The investment gives RPSG a foothold in a segment driven by strong branding, global reach and aspirational spending, areas that are expanding rapidly as India's luxury market grows. For FSP Design, the deal provides capital and scale advantages that could support wider retail expansion, brand-building, and a push into more global markets.

The partnership also carries a degree of risk. Luxury fashion is highly dependent on brand perception, celebrity-driven visibility and unpredictable consumer trends. If FSP Design does not sustain its momentum, the valuation could come under pressure. But if the brand continues to strengthen its domestic and international presence, the investment could deliver attractive returns, says an industry analyst. For now, the acquisition positions RPSG Ventures as a more diversified consumer-facing player and gives FSP Design a stronger platform to accelerate its next phase of growth, he added.

NCR office rents are rising: What's driving commercial real estate prices up

Govt removes quality control requirement for Viscose Staple Fibre

New Delhi.(Agency)

To address raw material accessibility and foster growth in the textile industry, the government has removed the Quality Control Order (QCO) requirement for Viscose Staple Fibre (VSF) with immediate effect. The step was taken after due consultation with the Bureau of Indian Standards (BIS) and key industry stakeholders, said the Textile Ministry in a statement on Tuesday. Earlier last week, the government also rescinded QCO on polyester yarn and fibers.

"This decision directly responds to persistent industry concerns about supply constraints and higher costs, and demonstrates the government's commitment to improving ease of business for textile manufacturers, exporters, and MSMEs," says the ministry.

Quality Control Order is a government mandate that requires specific products to meet certain Indian standards and obtain a Bureau of Indian Standards (BIS) licence for manufacturing, sale, or import. Removal of the QCO on VSF is expected to ensure seamless access to quality raw material, enhance global competitiveness, and drive industry-led growth to support these national objectives. The ministry said that the policy move comes at a crucial time as India's textile sector pursues the ambitious Vision 2030—aiming to boost domestic consumption and meet the target of \$100 billion in exports while growing the total textiles and apparel market to \$350 billion. Meanwhile, the ministry has approved 17 new applicants under the Production Linked Incentive (PLI) scheme for textiles in round three of selection, it said in a press release on Tuesday. According to the ministry, the newly approved applicants have committed a total investment of ₹2,374 crore. The proposed projects are expected to achieve projected sales of over ₹12,893 crore and generate employment for about 22,646 persons in the coming years. The PLI Scheme for textiles was notified on September 24, 2021, with an approved outlay of ₹10,683 crore to promote the production of MMF apparel and fabrics, and products of Technical Textiles. The scheme aims to enable the textile industry to achieve the necessary size and scale, become globally competitive, and create substantial employment opportunities. Under the first two rounds of selections, a total of 74 applications have been approved under the scheme. Recently, the Ministry has notified major amendments to the scheme to further enhance industry participation. The online application portal has been reopened for acceptance of new applications till December 31, 2025. According to the Ministry, as many as 74 applicants' requests for PLI have been approved by the government.

Excelsoft Technologies IPO open for bidding: Should you subscribe Check GMP

New Delhi.(Agency)

The initial public offering (IPO) of Excelsoft Technologies opened for bidding on Wednesday, giving investors a chance to evaluate whether the company's business, valuation and growth plans justify the offer price.

Excelsoft Technologies IPO comes at a time when interest in technology-focused listings remains strong, but investors are also becoming more cautious about high valuations in the digital and SaaS space. Excelsoft Technologies aims to raise Rs 500 crore through the IPO, which includes a fresh issue of 1.50 crore shares worth Rs 180 crore and an offer for sale (OFS) of 2.67 crore shares worth Rs 320 crore. The subscription window is open from November 19 to November 21, and allotment is expected on November 24. The shares are likely to list on the BSE and NSE on November 26. The price band has been set at Rs 114-120 per share. A retail investor



needs to apply for at least one lot of 125 shares, which requires an investment of Rs 15,000 at the upper price band. Small non-institutional investors (SNI) need to apply for 14 lots, while big non-institutional investors (BNI) must apply for 67 lots. Anand Rathi Advisors is the lead manager, and MUFG Intime India is the registrar. The company plans to use the fresh issue money for a new Mysore facility, land purchase, electrical system upgrades, and improvement of software, hardware and network systems. A part

of the funds will also go towards general corporate purposes.

The \$30-billion bet: Why Anthropic's pact with Microsoft and Nvidia sends shockwaves through the AI race

The US artificial intelligence (AI) startup Anthropic's Tuesday announcement of a sweeping partnership with Microsoft and Nvidia, marked one of the largest AI-infrastructure commitments announced this year. Under the arrangement, Anthropic will spend about \$30 billion on Microsoft Azure's computing capacity and may scale this further to nearly one gigawatt of contracted compute power. Microsoft, in turn, will invest up to \$5 billion in Anthropic, while Nvidia plans to put in as much as \$10 billion. Alongside these financial commitments, Anthropic and Nvidia will also work closely on engineering, tuning Claude models—the range of generative artificial intelligence (AI) models and a chatbot developed by the company—for Nvidia's advanced Grace Blackwell and Vera Rubin systems and feeding performance data directly into Nvidia's future chip designs.

Microsoft will also bring several Claude models into its Azure AI Foundry services and integrate them across tools such as GitHub Copilot, Microsoft 365 Copilot, and Copilot Studio. The combined arrangement, which has sent shockwaves through the AI industry, gives each company a clear win. Anthropic secures the massive and predictable computing power it needs to scale Claude, while gaining access to Nvidia's latest hardware and engineering know-how. For Microsoft, Anthropic becomes a major, long-term customer for Azure and a second strong model partner alongside OpenAI, reducing dependence on a single provider. Nvidia benefits from guaranteed demand for its newest accelerators and gains a powerful real-world test bed for refining its chip architectures.

This deal also signals how quickly the industry is shifting into a compute-driven phase. Large AI labs now need enormous, stable infrastructure to

sustain training and inference, and partnerships are increasingly designed around co-developing hardware and models in tandem. That tight integration may give companies like Anthropic an edge in speed and efficiency, but it also raises barriers for smaller players that lack the capital or the hardware access required to keep up.

The marquee partnership is reshaping strategic positions across the AI industry. For Microsoft, supporting Anthropic alongside OpenAI broadens its model ecosystem and reduces dependence on a single partner, while giving Azure a major long-term customer. Anthropic gains the stability of guaranteed compute at scale and access to Nvidia's most advanced hardware, a combination that can push its Claude models to higher levels of performance. The alliance signals that compute access, not just model innovation, is becoming the decisive factor in the AI race.

How every day micro-payments eat into your savings

Welcome to India's new spending reality, the age of micro-payments that silently seep into your accounts and cause invisible leaks. By the end of the month, many people find their digital wallets, like Paytm, PhonePe, Google Pay, have quietly leaked hundreds and thousands of rupees.

Have you ever wondered how many micropayment transactions we make each day? Micropayments through digital wallets such as Paytm, PhonePe, and Google Pay, often involving minimal amounts of money, have turned every phone into a frictionless payment device. It starts with a tap for chai, another for a quick ride, and so on for an app subscription. By the end of the month, many Indians find their digital wallets, like Paytm, PhonePe, Google Pay, have quietly leaked hundreds and thousands of rupees. Digital wallets make paying too easy, and these tiny, forgettable spends

rarely get noticed until the bank statement is consciously examined. Further, have you ever paused to count how many digital subscriptions quietly renew on your digital payment apps each month? I reviewed my subscriptions recently, and the list surprised me: a Netflix Basic plan: Rs 199, Apple Music: Rs 119, Amazon Prime: Rs 299, Apple Cloud: Rs 75, Spotify: Rs 119, and the list goes on with many other subscriptions like Hotstar, Zomato Gold, and Swiggy One. Each seemed modest on its own, but together they added up to a pattern, a silent stream of micropayments that quietly nibble away at savings. Welcome to India's new spending reality, the age of micro-payments that silently seep into your accounts and cause invisible leaks, reminding me that digital convenience has a quiet price tag. We are hooked with everyday leaks in the form of micropayments. These everyday micropayments blur the boundary between optional and necessary spending. In-app nudges, cashback rewards, and "Buy Now Pay Later" options heighten the temptation, turning casual purchases into fixed habits.

SUBCONSCIOUS RISE OF THE TAP ECONOMY
India's digital payment revolution is one of the world's fastest. From Kirana stores to

autorickshaw drivers, a QR code is never far away. RBI reports digital payments accounted for 99.8% of all transaction volume, with UPI recording over 18 billion transactions in a single month. In



my early research on mobile payments in Bangalore (Padashetty & Kishore, Researchers World, 2013), I observed that convenience was the strongest driver of adoption. A decade later, that convenience has evolved into what I call "the tap economy", effortless, instant, and emotionally painless. But therein lies the paradox: what makes payments seamless also makes spending subconscious.

PSYCHOLOGY OF INVISIBLE SPENDING

Traditional cash payments created a tangible sense of loss; handing over notes or coins made us feel the expense. Digital wallets remove that "pain of paying."

Behavioural economists argue that when friction disappears, self-control weakens. One of my recent studies (Padashetty et al., 2023) found that 68% of respondents felt they spent more frequently after shifting to digital wallets, primarily on low-value purchases such as recharges, OTT renewals, and online food orders. Digital ease has created a micro-spending habit loop; small payments trigger neural spikes through dopamine release at the reward centre (Nucleus Accumbens) of the midbrain, eliciting pleasure, which in turn gets into an infinite loop of pleasure and payments. Each is harmless on its own, but collectively they create a steady "leak" from personal budgets.

SUBSCRIPTION CREEP AND AUTO-DEBIT TRAPS
A new layer of micro-leakage comes from subscription-based ecosystems. Consumers often forget about Rs 49 or Rs 99 recurring payments that continue monthly. Auto-debits from cards and wallets blur visibility, while cashback notifications create an illusion of saving. Fintech analysts point out that the subscription economy in India has grown nearly 30% annually since 2020, driven by digital media, learning apps, and SaaS tools.

Define the job

Before hiring a nanny, prepare a detailed job description that clearly outlines the specific duties involved. In case of specific requirements, such as a non-smoking nanny or one with a valid driver's license and a clean driving record, ensure to mention these. Employment agreement

According to the US Department of Labour, nannies come under the category of domestic workers. When you hire a nanny, it is important to understand your legal responsibilities the rights of the employee, and practices to maintain a healthy and safe work environment. Though a nanny contract is not legally required under federal law, it is best to have a written agreement that lays out the job responsibilities, pay and benefits, scheduled work hours, confidentially, holidays, and termination clause, to avoid conflict and have a safe environment. Also, be clear about the house rules and personal boundaries. Despite the nature of the job, it is best to maintain a professional relationship.

CPR and basic first aid certification

Ensure your ideal candidate for the nanny position should have certifications in CPR and First Aid. These certifications are crucial to ensure that they can be of help in case of any emergencies that may arise with the child. Other than emergency situations, with children, incidents such as a minor scrape, a choking hazard, or some other medical situations may arise, and in such cases

having a trained nanny, who could act immediately, provide first aid, and seek professional help is need is important.

Be aware of wage laws

The nanny is a domestic worker protected by the Federal Fair Labor Standards Act (FLSA). The hours worked apply to Domestic Service Employment under the FLSA. The hours worked are when an employee is 'on duty'. For instance, if a live-in nanny, takes care of baby duties for three hours in the morning, and then goes to class at a university, returns home, and helps with the childcare for two hours in the evening, she has worked five hours. The minimum wage rate per hour differs from state to state. A nanny is also entitled to be paid for overtime hours. The overtime differential wages are often calculated at 1.5 times the regular hourly rate.

Run a thorough background check

A step that you mustn't skip is conducting thorough background checks. Look at the criminal records and reference verification, to ensure the nanny has a clean and trustworthy history. Also, run a background check on whether they are legally staying in the state, and if they have relevant experience in child care. Look for candidates who are interested in a long-term position and willing to make a minimum one-year commitment to our family, because this will ensure stability in your lives.

Know about your tax responsibilities

As an employer, you pay a 6.2% Social Security tax on up to \$168,600 (in 2024) of your employee's earnings and a 1.45% Medicare tax on all earnings. Employees pay the same tax rates. They also pay 0.9% more in Medicare taxes on earnings higher than \$200,000 (\$125,000 if married, filing separately, or \$250,000 if married, filing jointly). While paying your nanny legally, you may be eligible for certain tax benefits. It is crucial to learn about your tax responsibilities prior to hiring a nanny.

1) Don't underestimate the nanny contract

Laying out a contract for a nanny may seem unnecessary. Maybe you bonded instantly during the interview and it seems like you're on the same page for everything. A contract ensures that you and the nanny have discussed terms, and come to an agreement on things like responsibilities, hours, pay-rate, overtime,

minimized. It's also helpful to review the contract each year together just in case updates are necessary.

4) Keep the necessities out
