# Teacher Eligibility Test mandate will destabilise schools, MK Stalin warns PM Modi

Tamil Nadu Chief Minister MK Stalin has urged Prime Minister Narendra Modi to amend the RTE and NCTE Acts to protect teachers appointed before August 23, 2010, from mandatory TET requirements after a recent Supreme Court ruling.

#### New Delhi.(Agency)

Tamil Nadu Chief Minister MK Stalin has urged Prime Minister Narendra Modi to intervene and amend the Right to Education (RTE) Act, 2009,

and the National Council for Teacher Education (NCTE) Act, 1993, to protect lakhs of teachers appointed before August 23, 2010, from mandatory Teacher Eligibility Test (TET) requirements. In a letter to the Prime Minister, Stalin said the issue has created an "urgent and significant" crisis affecting "lakhs of teachers across the country, including a substantial number in Tamil Nadu.'

Referring to the Supreme Court's September 1, 2025 judgment, he noted that the ruling requires all inservice teachers who have not cleared TET to do so within two years or risk losing their jobs. The

order also states that teachers with less than five years of service left may continue but cannot be promoted unless they qualify in TET. Stalin said this interpretation overrides the earlier NCTE exemption for teachers appointed before August

23, 2010.

"The retrospective application of TET creates a significant disruption of long-settled service rights," he wrote, adding that it "poses a serious



risk of destabilising the functioning of the school education system."Pointing out that nearly four lakh teachers in Tamil Nadu alone fall in this category, Stalin stressed that they were "fully eligible, properly qualified, and duly recruited

under the statutory rules in force at the time of their appointment." Imposing TET now, long after their entry into service, would lead to "significant administrative and personal hardship," he said.

> The Chief Minister warned that no state could replace such a vast number of teachers within a short period. "Replacing such a large number of teachers is not feasible for any State," he wrote, highlighting the shortage of qualified candidates and challenges in rural and remote areas.

> He further said that depriving longserving teachers of promotions due to a qualification introduced years after their appointment would cause "disproportionate hardship and stagnation," despite decades of experience.Stalin requested the Prime Minister to instruct the Ministry of Education to amend Section 23 of the RTE Act and Section 12A of the NCTE

Act. "Such amendments alone can ensure that teachers who were in service as on 23.08.2010 are duly protected, remain eligible for promotions, and continue to contribute without disruption," he

### Wait, will call you: Rahul Gandhi's text to DK Shivakumar amid CM seat buzz

Amid the leadership tussle in Karnataka, and with the Congress high command reportedly expected to decide on any change in the chief minister before the December 1 Parliament session, Rahul Gandhi has responded to Deputy Chief Minister DK Shivakumar after a week of his attempts to reach out.

According to party sources, Shivakumar had been attempting to speak with Rahul Gandhi regarding the internal developments. Gandhi responded with a short WhatsApp text: "Please wait, I will call you." The exchange comes at a time when the Congress is facing heightened speculation over possible changes in the state leadership.

A batch of MLAs loyal to Shivakumar, including ministers, travelled to Delhi to press their demand for a change in the Chief Minister's post. In Karnataka, the alleged "2.5-year power-sharing deal" has triggered infighting between loyalists of Siddaramaiah and his deputy, DK Shivakumar.

With Siddaramaiah midway through his term, Shivakumar's supporters have stepped up pressure on the party's top leadership to deliver on what they claim was an earlier agreement. On the other hand, Siddaramaiah's camp has denied that any formal rotational arrangement exists. They argue he remains committed to completing a full five-year term, and that the so-called pact was never officially sanctioned. Meanwhile, leaders at the Congress high command have stayed publicly silent or cautious.

### DK Shivakumar, Siddaramaiah aide hold late-night meet amid leadership buzz: Sources

Karnataka Deputy Chief Minister DK Shivakumar reportedly held a latenight meeting with PWD Minister Satish Jarkiholi on Tuesday, with both leaders cancelling all scheduled appointments to meet at an undisclosed

Jarkiholi, considered a key lieutenant of Chief Minister Siddaramaiah and a political rival of the Deputy Chief Minister within the Congress, is learnt to have told close aides that he is attempting to resolve differences with Shivakumar.

Discussions between the two continued well past midnight, sources from day, Shiyakumar



had hinted at "secret talks" dating back to the May 2023 election results, adding to speculation over the timing of the meeting.

The two leaders, who worked together as **KPCC** President

and Working President during the 2023 polls, are understood to have held wide-ranging talks on the party's roadmap for 2028, 2029 and the post-Siddaramaiah era, with the Chief Minister believed to be nearing the end of his electoral journey. A major focus of the discussions was reportedly on consolidating OBC support and positioning Jarkiholi as a key backward-classes leader. The meeting primarily centred on settling differences between the two.

The meeting comes against the backdrop of a deepening leadership tussle within the Karnataka Congress. Supporters of Deputy Chief Minister DK Shivakumar moved to Delhi, urging the party high command to implement what they claim was a 2023 "power-sharing" promise to rotate the Chief Ministership.

# SP removed as MP CM Mohan Yadav slams police over failure to arrest accused in six-year-old's rape case

MP CM Dr Mohan Yadav held emergency meeting at Bhopal PHQ, expressing displeasure over police inaction in six-year-old girl's Raisen rape case.

Inability of the police to arrest a 23-year-old youth who abducted a six-year-old girl and raped her before abandoning her in a serious condition in the jungles on November 21, led to the removal of Raisen district police superintendent Pankaj Pandey on Tuesday night.

The Madhya Pradesh chief minister, Dr Mohan Yadav, chaired a high-level emergency law and order review meeting at the state Police Headquarters (PHQ) in Bhopal on Tuesday night, where he expressed displeasure with the police action so far in the case pertaining to the rape of the six-year-old girl in Raisen district of central MP.Not only did the CM express displeasure over the manner in which the case of a minor's rape was dealt, even four days after the shocking incident, but he was also not

satisfied with the police response to the road blockade in Raisen's Mandideep area.

He ordered the immediate removal of Raisen district police superintendent Pankaj Pandey, who has been attached to the state PHQ as an Assistant IG (AIG). The Deputy Commissioner of Police (DCP) for Bhopal Zone I, Ashutosh, will be the new SP of Raisen district. The CM further directed the immediate removal of the in-charge of Misrod police station in Bhopal. This action is being seen as the direct result of the Misrod police's failure to deal with cases of crime, particularly the recent vandalisation of property by armed youths at a café.

In connection with the Raisen incident, the CM expressed severe displeasure not only with the police's inability to apprehend the accused who has now remained at large for four days



but also with their "lax response" in handling the massive public protests and road blockades that have affected the central MP

Importantly, the 23-year-old youth identified as Salman, remains on the run, even four days after allegedly committing the gruesome

crime with the six-year-old girl. On November 21, he had allegedly lured the minor (who was playing outside her house) to a nearby jungle with the promise of giving chocolate. Once in the jungle, Salman allegedly raped the minor and abandoned her there. While the minor is slowly recuperating from the mental and physical trauma at the AIIMS-Bhopal, massive protests have been reported by local residents, particularly women, outside the Gauharganj police station in Raisen district. The continued sit-in protests have been followed by violent protests and massive highway blockades. While the police initially used mild force (a baton charge) to clear the highway, the protesters quickly returned, forcing the deployment of personnel from five different police stations.

### Good luck or bad data? Air 'cleaner' in city than rest of NCR this season

Gurgaon.(Agency)

Never mind the haze that you've been engulfed in for weeks, if you go by official AQI (air quality index) data, Gurgaon is seeing the cleanest run among NCR cities in the year's peak pollution phase. In the 42 days between Oct 15 – the start of the peak pollution phase – and Nov 25, the city has seen no 'severe' days (when AQI touches or breaches 400). Delhi saw three, Noida five and Ghaziabad eight. Gurgaon has pulled off another surprise at the other end of the scale. It has recorded three 'moderate' days (AQI between 101 and 200). Delhi has seen none, and Noida and Ghaziabad one each.

Millennium City has also seen the least 'very poor' days (AQI of 301-400) in this 42-day period, just 8 compared to Delhi's 27, Noida's 26 and Ghaziabad's 23. In the most polluted phase within this period, from Nov 11-25, Gurgaon's AQI was conspicuously divergent from the three other cities.Data can be divergent on some days because of local factors, and wind speed and direction, but these will typically be anomalies. It's unusual for the difference to sustain over a period of time, as it has this year. So is it good luck or bad data? Experts believe it's a bit of both. Asked about it, a Central Pollution Control Board (CPCB) official denied any problems with the data. "Data generated by continuous monitoring stations is automatically validated through algorithms, and any abnormal spikes triggered by equipment issues are removed, so reported AQI reflects actual ground conditions."A former CPCB official said the AQI data reflects actual atmospheric conditions and not faulty sensors. "The system is in-built with self-calibration protocols for all parameters monitored for measurement of air quality. Air quality is dependent not only on the profile of pollutants but also on prevailing local meteorological conditions, particularly wind speed," said Dipankar Saha, former head of the air laboratory at

### CJI to inaugurate ITI for inmates at Bhondsi jail

Chief Justice of India (CJI), Justice Surya Kant, who took oath as the 53rd CJI on Monday, will visit the city on Dec 6 to inaugurate the newly constructed ITI at Bhondsi jail. This ITI is established to provide skill training to the inmates. This will mark Justice Kant's first visit as CJI to the city. The initiative reflects the judiciary's sensitive approach to transforming jails into centres of reform, rehabilitation, and skill development. Technical education and practical training will be provided to inmates, enabling them to re-establish themselves in society after release.In view of the Chief Justice's proposed visit, a High Court delegation led by Justice Ashwini Kumar Mishra of the Punjab and Haryana High Court reached District Jail Bhondsi on Monday. The delegation also included Justice Pankaj Jain, Justice Kuldeep Tiwari, Justice Sudipti Sharma, and Justice Shalini Singh Nagpal.During the inspection, the delegation thoroughly observed the ITI-related infrastructure, training capacities, and facilities in the jail. They gathered detailed information on the preparations from the jail superintendent and other officials and gave necessary directions to ensure all arrangements are completed smoothly. Justice Ashwini Kumar Mishra, during the inspection, visited the workshop, jail radio, computer lab, electronics lab, physics lab, music room, salon, and skill development centre. He examined in detail the resources available at each centre, training materials, availability of trainers, and participation of inmates. Justice Surya Kant belongs to Harvana's Hisar district. He was the advocate genera of the state before being elevated as a permanent judge to Punjab and Haryana High Court in 2004. As an HC judge, he heard several cases related to HSVP and land acquisition of Dwarka Expressway. He assumed the role of Chief Justice of High Court of Himachal Pradesh in 2018 and was elevated to Supreme Court in 2019.

### Greater Noida's ageing sewer network is crumbling under city's weight

More than 30 years after Greater Noida was conceived as a model city with wide, signal-free roads, manicured green belts and a grid of over 100 sectors, the shine is fading under the weight of a rapidly growing population and neglected underground infrastructure. What residents now live with is a sewer network so old, corroded and overburdened that lines are bursting somewhere in the city almost every couple of minutes.

The crisis is most acute in the sectors that were developed the first—Alpha 1 and 2, Beta 1 and 2, Gamma, Delta 1 and 2, Swarn Nagari, P3 and parts of Omicron—where the original network laid in the early 1990s remains largely unchanged despite the city's population swelling from a few lakh to nearly 10-12 lakh today.

After every moderate spell of rain, the system buckles. Sewer water spills onto roads, and a foul, persistent stench becomes part of daily life. This Sept, dirty sewer water entered several homes in Alpha 2 after a heavy bout of rain. Residents from sectors P3, Alpha 2, Mu 2, Sigma 4 and Beta 1 complained of chronic sewer overflows for weeks in Aug.Residents claimed the infrastructure has simply not kept pace with the city's expansion. What was designed for a fraction of today's population is now crumbling, rusting and leaking with alarming frequency."Older sectors like Alpha, Beta and Delta have been facing continuous sewer issues for several years," Subhash Bhati, RWA president of Alpha 2, said. Another resident from Alpha 2, who had raw sewage flooding his house and garden this monsoon, said there was a "stench of drains and faeces" in the area which "stayed with me well after the rainwater subsided". "This was my home and it feels like it was destroyed. You could smell it everywhere," he said.

Most of these houses were sold for multiple crores with promise of good roads and civic infrastructure.

In Delta 2, the main sewer line has been damaged for six months, and residents said the pace of repairs is painfully slow.

# Haryana in red, is among India's top 3 most polluted: Study

Haryana has slipped into the red zone of India's air quality map. No district is meeting the national annual PM2.5 standard. Every district in the state has breached the annual safety threshold for fine particulate matter — 40 µg/m³ — underscoring the scale of exposure across the state. This places the state as the third worst in the country after Delhi and Chandigarh, says a new satellite-based study for 2024. The Centre for Research on Energy and Clean Air (CREA) report flags Haryana as a major pollution cluster in the Indo-Gangetic Plain. Gurgaon is among seven Haryana districts that are making news for wrong reasons. They are among India's 50 most polluted districts. Compared to the annual safety threshold for fine particulate matter, all of them record PM2.5 levels double, sometimes nearly triple, the national standard.

Gurgaon ranks 13th at 81.3 μg/m³, followed by Faridabad (16th, 80.7), Jhajjar (17th, 77.0), Sonipat (23rd, 69.9), Charkhi Dadri (29th, 66.7), Rohtak (37th, 66.0)

dismisses the notion that weather is the primary factor; the quick rebound suggests that sustained emissions from industry, transport, waste burning and energy production are driving the crisis. CREA notes that this concentration of hotspots puts Haryana in the same risk band as Delhi, Punjab and Bihar. Seasonal analysis adds perspective.

Delhi remains the worst across all seasons, while Punjab peaks during the monsoon. For Haryana, the picture is one of uninterrupted exposure: there is no season when PM2.5 returns to safe levels statewide. The study argues that combining satellite data with a denser and better-sited monitoring network would sharpen accuracy across India.

With 100% district-level violations in Haryana, CREA analyst Manoj Kumar said, "The National Clean Air Programme must shift from a city-based approach to district-based planning. Satellite-derived PM2.5 should be formally integrated into the national clean air programme (NCAP)

to track performance, assess exposure gaps and guide real-time interventions. It also calls for accountability mechanisms under which states are evaluated and incentivised based on measurable reductions in PM2.5 using standardised satellite and ground indicators. The report concludes that for hotspot states like Haryana, piecemeal fixes will not suffice. Reducing emissions at source — industry, power generation, transport, and biomass burning — must become a policy mandate rather than a long-term aspiration."The broader national map is equally discouraging. Sixty percent of

India's 749 districts breach the annual limit. In winter, violations cross 80%, only to drop during the monsoon and surge again soon after. The study stresses that state averages mask local distress. A state may appear compliant on paper while industrial belts inside it continue to suffocate. Maharashtra is cited as a prime example: its overall average meets the national limit, yet several districts within it record extreme pollutant loads.

Meanwhile, Delhi has emerged as the most polluted of all states and Union territories in India, according to a new satellite-based assessment released by Centre for Research on Energy and Clean Air (CREA). The capital recorded an annual population-weighted PM2.5 concentration of 101 micrograms per cubic meter ( $\mu g/m^3$ ) — 2.5 times higher than the country's national ambient air quality standard and 20 times the World Health Organization guideline. The study found that the Indo-Gangetic airshed, of which Delhi is a part, continues to have the highest pollution levels.

### Footpaths, service lanes: Revamp for road linking IFFCO Chowk and SPR in Gurgaon

Gurgaon.(Agency) GMDA is drawing up a plan to revamp the 7.5km stretch between IFFCO Chowk and SPR, one of the city's busiest corridors. The plan, including two-lane service roads, footpath-cumdrainage networks and upgraded junctions, aims to ease the chronic congestion on the three-lane carriageway that runs parallel to Golf Course Road and serves as a key link to Cyber Hub, Udyog Vihar, NH8 and Faridabad. The 60-metre-wide road passes through sectors 27, 28, 29, 43, 47, 52, 52A, 56 and 57.Officials said the stretch faces congestion due to the absence of continuous service roads. With no dedicated lanes for internal traffic, vehicles from adjoining colonies constantly merge onto the main carriageway, slowing movement and creating choke points throughout the day. Once developed, these service roads are expected to take nearly 40% of the present load off the main carriageway, a senior GMDA official said. The redesigned cross-section also includes pedestrian infrastructure and a footpath-cum-drainage system to address frequent waterlogging, along with junction upgrades to improve turning movements at crowded intersections. The stretch accommodates two metro stations and six junctions, four of which -Millennium City Centre, Ardee Mall, Tau Devi Lal Park and Hong Kong Bazaar — are major congestion points. The corridor is lined with dense residential and commercial development, including gated colonies, urban villages, hospitals, malls and office hubs, contributing to heavy peakhour movement. Residents said the service road proposal was long overdue. RWA president of Ardee City Praveen Yadav said, "This stretch has been choking for years. At peak hours, traffic piles up for nearly 1km at the Ardee City traffic light alone. This is

# NIA takes Muzammil to Faridabad hideouts, Al-Falah

Faridabad: Muzammil Ahmad Ganaie, the Al-Falah University doctor arrested in connection with the Nov 10 Delhi blast, was on Monday taken to various locations in Faridabad by a National Investigation Agency team that wanted to recreate the crime scene. The day began with Muzammil returning to the two rooms he had taken on rent to store 2,900kg of ammonium nitrate, an explosive material. NIA sleuths also took him to the university campus, where he worked and lived, and to the room of a cab driver in Dhauj village where the doctor had stored an electric grinder and portable furnace tools allegedly used in bomb-making.

According to sources, Muzammil — who had been in the custody of Jammu and Kashmir Police ever since his arrest on Oct 30 — was brought to Delhi only last week as the probe intensified. Investigators, who spent hours combing through evidence in Muzammil's two rooms, learnt that the doctor had rented one of them in Sept, paying Rs 1,200 a month in advance. The

landlord, known locally as "Madrassi", told police, "He never stayed here, only brought in his bags. I had no idea what



was going on inside."It was in this room in Dhauj that cops had seized 358kg of ammonium nitrate a few days before the blast. The search continued to the other room of Muzammil in Fatehpur Taga — 4km from the university. Here, police had found a larger cache of 2,600kg of explosives on Nov 9, a day before the blast. The house owner, a local cleric, was arrested following the discovery.

# Fix civic infra flaws on premises of court and file report, Gurgaon agencies told

Gurgaon.(Agency)

It is the primary duty of every public authority to "ensure cleanliness, hygiene and safety" in a public institution, the district court said on Tuesday. It has sought a detailed reply from the authorities. While taking note of poor civic infrastructure inside the court premises. infrastructure inside the court premises, the court directed the authorities to jointly remove all existing infrastructure problems in the district court complex. The court has told authorities to submit a weekly status report every Monday "until all the nuisances are permanently eliminated" from the premises.Ensure daily sweeping, cleaning and removal of garbage from the entire court premises and complete removal and neutralisation of stray dogs, monkeys and other animals from the court complex — these are among the directions that were issued over a petition filed by the district bar association. The petition highlighted a

plethora of issues accusing MCG, GMDA, the public works department (PWD) and the district administration of their "collective failure to maintain hygiene and infrastructure in the court premises."Civil judge (senior division) Manish Kumar observed prima facie evidence of overflowing sewers, stagnant sewage water, broken internal roads. accumulated garbage and the menace of stray dogs and monkeys within the premises. The authorities will have to file a joint comprehensive action-taken report along with individual affidavits by the commissioner of MCG, CEO of GMDA, executive engineer of PWD and deputy commissioner of Gurgaon detailing the steps taken and the time-bound plan for the permanent resolution of the aforesaid issues within a week's time. The court cannot shut its eyes to a situation where the "temple of justice" has been allowed to become unhygienic, foul-smelling and unsafe, it said.MCG claimed that the

sewer line inside the court complex does not fall within its jurisdiction and that its responsibility starts only from Beriwala Bag. PWD is responsible for the sewer line inside the court premises. The court observed that irrespective of jurisdictional disputes among authorities, advocates, judicial officers, staff and litigants cannot be made to suffer on account of such disputes. Association counsel Manish Shandilya told TOI that the court directed the authorities to also ensure desilting, cleaning and ensuring the free flow of all sewer and drainage lines, repairing broken internal roads and removing stagnant water."Complete removal and neutralisation of stray dogs, monkeys and other animals from the court complex and installation of necessary measures to prevent their reentry are to be ensured to guarantee the safety and security of advocates, litigants, judicial officers and staff.

# After 13 years in Delhi, she took a 3-month break. When she returned, no one wanted her as a tenant

When she returned to Delhi this month after a three-month sabbatical from work, Maria Bilal could not find a house to rent. "It was like the city I lived in for 13 years did not want me anymore. It's the place where I made friends, found my identity and built a life from scratch, but it felt so alien," said the 36-yearold communications professional, who has spent all her working life in Delhi.

Since the Lajpat Nagar house she last lived in was no longer available, Maria contacted brokers, who showed her other houses in Lajpat Nagar as well as Jangpura, Vivek Vihar and Noida. But when it came to signing the agreement, she hit a wall every time. Brokers returned with the same reply – the owner does not want to give the house to a Kashmiri Muslim, said Maria, who landed in Delhi on Nov 11, a day after the terror attack near Red Fort that was executed by a module of radicalised doctors from J&K.Maria said she furnished her professional credentials and told prospective landlords she



had worked with the central govt, hoping it would make them trust her. "But they just Bilal went through three brokers. could not let go of their doubts,"

It's a feeling many Kashmiris have voiced publicly and privately in the aftermath of the Delhi terror plot. So much so that J&K CM Omar Abdullah stepped in with a public reminder that actions of a "handful of people should not define the vast majority of peace-loving residents of the side of terrorists. "Somewhere, they don't want a single man, somewhere they don't want meat eaters. So. for now, I have no choice but to put up with the expenses and continue living in Gurgaon," he

Neeraj Sahgal, a property dealer in Delhi, agreed some find it more difficult to get a house. "But not every homeowner cares about the tenant's religion. Even I have faced issues with prospective tenants getting rejected because the owner does not want to give their house to a Muslim, but there are also people who don't care about these things.

### Families displaced after tornadoes hit Houston as Thanksgiving week begins

Kenny Beck surveyed the damage Tuesday to his family's two-story home after at least two tornadoes tore through the Houston area, damaging over 100 homes at the start of a busy Thanksgiving travel week that has Americans closely eyeing the weather. "Half my roof on the back is gone," Beck, 46, said as workers cleared large tree branches and other debris from around nearby houses in the suburb of Cypress.

We've lost a lot of ceiling because of the rain. Our garage door got sucked in." No injuries were reported from Monday's storm but it uprooted trees, downed power lines and scattered debris throughout some neighborhoods northwest of Houston. The National Weather Service on Tuesday had confirmed at least two tornadoes, one in Cypress with winds up to 105 mph (168 kph) and another around the community of Klein with winds up to 115 mph (185 kph).

Beck said that while repairs are being made, his family will have to move out of the home where they've lived and shared many moments and memories with family and friends over the past 20 years.I'm just hoping that here in a couple of months, we can get back in and we can start making more of those memories," Beck said. Meanwhile, multiple rounds of storms and showers were expected in Mississippi, Alabama and Georgia. The storm system was expected to move to the Northeast by Tuesday night, with another one in the forecast in the Pacific Northwest.'Even though the official start of winter is nearly a month away, a wintry storm was developing in the northern part of the country, with snow falling in North Dakota."That's impacting North Dakota, Minnesota, including Minneapolis, and then portions of the northern Great Lakes," said weather service meteorologist Marc Chenard in College Park, Maryland. He said snowfall was expected into Wednesday. As much as 8 inches (20 centimeters) of snow had fallen by late Tuesday afternoon in parts of North Dakota and South Dakota, according to the National Weather Service. In North Dakota, officials closed parts of Interstate 94 and Interstate 29 due to ice, low visibility and multiple accidents.

### US climber among two killed after fall on New Zealand's tallest peak

BEIJING. (Agency)

Two climbers, including a man from the United States, died after falling near the summit of Aoraki, New Zealand's tallest mountain, authorities confirmed on Wednesday. Police said the men were part of a fourmember climbing team attempting the peak on Monday. According to the Associated Press, a distress call reached authorities late that night, prompting an immediate helicopter search. Two climbers -- a mountain guide and their client -- were located and rescued without injuries. Attempts to find the remaining two continued through the night. Search helicopters scanned the upper slopes in challenging alpine conditions. Their bodies were discovered on Tuesday morning (local time) and recovered later in the day by specialist crews from rescue organisations and government agencies.Police Area Commander Inspector Vicki Walker said neither of the two men had been formally identified, but confirmed that "one of the deceased is a United States national". She added that authorities are in contact with the US consulate and that a coroner's investigation will follow.

The second victim was an internationally recognised climbing guide and a member of the New Zealand Mountain Guides Association. In a statement, the association said it was mourning the loss of an experienced professional who was well known in the country's alpine community.Sgt Kevin McErlain told The Timaru Herald the two men who died had been roped together when they fell near the summit

ridge of Aoraki, which stands 3,724 metres (12,218

feet) above sea level on New Zealand's South Island.

### FBI probes 6 Democrats who urged US military to refuse illegal orders

The FBI has requested interviews with six Democratic members of the US Congress who in a video message told members of the military they can legally refuse to carry out unlawful orders, a Justice Department official told Reuters on Tuesday.

The move comes a day after the Pentagon threatened to recall Senator Mark Kelly, a Navy veteran and one of the six lawmakers, to active duty potentially to face military charges over what Secretary of Defence Pete Hegseth described on social media as "seditious" acts.President Donald Trump, who critics have said has sought to harness the power of the government to try to stifle dissent, accused the six Democrats of sedition and said in a social media post that the crime is punishable by death. The Justice Department official, who spoke on condition of anonymity, said the FBI interviews with the lawmakers were to determine "if there's any wrongdoing, and then go from there." The FBI is headed by Trump appointee Kash Patel.

NOT THE AMERICA I KNOW'

In statements on Tuesday, the Democrats described the FBI move as an effort by the Trump administration to intimidate them into silence."The President directing the FBI to target us is exactly why we made this video in the first place," US Senator Elissa Slotkin of Michigan, a former CIA officer and one of the six Democrats, said on X. "This is not the America I know, and I'm not going to let this next step from the FBI stop me from speaking up for my country, and our Constitution."The lawmakers have said their video statements accurately reflected US law. American troops swear an oath to the US Constitution, not the president, and under military rules must follow "any lawful general order or regulation.

# Bangladesh's convicted ex-PM Hasina's party announces nationwide protests till Nov 30

LONDON. (Agency)

DHAKA: Bangladesh's ousted prime minister Sheikh Hasina's Awami League party on Tuesday announced nationwide agitations and "resistance marches" till November 30 in protest against the death sentence handed to the former premier by what it described as an "illegal" tribunal.

On November 17, the International Crimes Tribunal (ICT-BD) sentenced 78-yearold Hasina to death along with then home minister Asaduzzaman Khan Kamal on charges of committing "crimes against humanity" after a trial held in absentia.

Hasina is currently in India, while Kamal is also believed to be hiding in the country. In a post on its official social media account, the Awami League alleged that the tribunal's verdict was part of a political "conspiracy" by the Muhammad Yunusled interim government to keep Hasina and the party "out of the election" scheduled for February next year. Rejecting the "illegal verdict of the illegal ICT tribunal" and demanding the resignation of



Yunus, the party announced protests, demonstrations and "resistance marches across all districts and upazilas (subdistricts) until November 30". The party

said the "farcical" judgment had been "rejected with contempt" by citizens and described the tribunal proceedings as a "mockery of a trial."The Awami League

said it was engaging with grassroots workers, political leaders and stakeholders to counter what it called "anti-state conspiracies," and vowed to lead nationwide resistance against any attempts to exclude pro-liberation forces

from the electoral process. A staged election will not be allowed in Bangladesh. It will be resisted at any cost," it said, adding that a "tough nationwide movement" would be announced soon.

Hasina's Awami League government was toppled in a student-led violent protest termed as the "July Uprising" on August 5 last year. Three days later, Nobel Laureate Yunus flew from Paris at the call of the protesting students to assume the charge of the interim government as its chief

Hasina and the two others were accused of adopting brutal means to tame the protestors, while a UN rights office report said about 1,400 people were killed between July 15 and August 15 last year.

### Inalienable part of India': MEA responds after China defends detention of Arunachal woman

India has issued a strong demarche (a formal diplomatic protest) to the Earlier, China denied allegations that an Chinese side, in Beijing and in Delhi.

India took strong exception to China over the "arbitrary detention" of Thongdok, while firmly reiterating that the state is an "integral and inalienable" part of the country.



Israel has agreed to release 15 Palestinian bodies for each hostage returned.Dror Or was killed by Islamic Jihad militants who overran his home in Kibbutz Beeri on Oct. 7, 2023, Israel's military said. His wife, Yonat Or, was also killed in the attack. That day, Palestinian militants killed some 1,200 people across southern Israel and abducted 251 to Gaza. Kibbutz Beeri was one of the hardest-hit farming communities in that attack that started the war in Gaza. Two of Or's children, Alma and Noam, were abducted by the militants on Oct. 7 and released in a hostage deal in



November 2023. Almost all of the hostages or their remains have been returned in ceasefires or other deals. The remains of two — one Israeli and one Thai national— are still in Gaza.Gaza's Health Ministry says more than 69,700 Palestinians have been killed and 170,800 injured in Israel's retaliatory offensive. The toll has increased during the ceasefire both from new Israeli strikes and from the recovery and identification of bodies of people killed earlier in the war.The ministry does not distinguish between civilians and combatants in its figures but has said women and children make up a majority of those killed. The ministry, part of the Hamas-run government and staffed by medical professionals, maintains detailed records viewed as generally reliable by independent

# Death toll rises to 13 after heavy rain triggers Thailand's worst floods in years

# Trump says he's sending envoys to see Putin, Ukrainians after fine-tuning plan to end war

WASHINGTON .(Agency)

President Donald Trump said Tuesday his plan to end the war in Ukraine has been 'fine-tuned" and he's sending envoy Steve Witkoff to meet with Russian President Vladimir Putin and Army Secretary Dan Driscoll to meet with Ukrainian officials.

Trump suggested he could eventually meet with Putin and Ukrainian President Volodymyr Zelenskyy, but not until further progress has been made in negotiations. Speaking to reporters on Tuesday evening aboard Air Force One, Trump said resolving the war was difficult, and described what had been a 28-point plan as a work in progress. "That was not a plan it was a concept," Trump said.

Trump's plan for ending the nearly four-year war emerged last week. It heavily favored Russia, prompting Zelenskyy to quickly engage with American negotiators. European leaders, fearing for their own future facing Russian aggression but apparently sidelined by Trump in drawing up the proposal, scrambled to steer the negotiations toward accommodating their concerns. Trump said he believed Witkoff

would be meeting with Putin next week in Moscow, with his son-inlaw Jared Kushner potentially joining the meeting. "People are starting to realize it's a good deal for both parties," Trump said. The president played down the element of his plan that would require Ukraine to cede territory to Russia, suggesting that Russian forces were already likely to seize the land they're seeking."The way it's going, if you look, it's just moving in one

direction," Trump said. "So eventually that's land that over the next couple of months might be gotten by Russia anyway."At the center of Trump's plan is the call on Ukraine to concede the entirety of its eastern Donbas region, even though a vast swath of that land remains in Ukrainian control. Analysts at the independent Institute for the Study of War have estimated it would take several years for the Russian military to completely seize the territory, based on its current rate of advances. Trump downplays transcript of Witkoff talks with Russian counterpart



Trump made his comments after Driscoll held talks late Monday and throughout Tuesday with Russian officials in Abu Dhabi, United Arab Emirates, to discuss the emerging proposal."The talks are going well and we remain optimistic," Lt. Col. Jeff Tolbert, spokesman for the Army secretary, said in a statement. Witkoff, a real estate developer turned diplomat, has been Trump's chief interlocutor with Putin, while Driscoll, who is close to Vance, has stepped up his involvement in the administration's peace push in recent days. As the talks were taking place, Russia

launched a wave of overnight attacks on Ukraine's capital, Kyiv, with at least seven people killed in strikes that hit city buildings and energy infrastructure. A Ukrainian attack on southern Russia killed three people and damaged homes, authorities said. Trump spoke to reporters after Bloomberg News published a transcript of an Oct. 14 call between Witkoff and Putin's foreign policy adviser Yuri Ushakov where Witkoff coached his counterpart on how Putin should handle a call with Trump.

Trump downplayed Witkoff's reported approach as "a very standard form of negotiation."But U.S. Rep. Don Bacon, a Nebraska Republican who has been critical of Trump's approach to Ukraine, said the transcript showed Witkoff favors the Russians. "He cannot be trusted to lead these negotiations. Would a Russian paid agent do less than he? He should be fired,' Bacon said on social media. Bloomberg said it reviewed a recording of the call, but did not say how it obtained access to the recording. The Associated Press has not independently verified the transcript.

### Court rejects bail plea of accused in Mithi river scam

A sessions court here has rejected the bail application of Shersingh M. Rathod, arrested for his alleged role in connection with the multi-crore Mithi River desilting scam. The court in its order, a copy of which was made available today, observed that Rathod played an active role in the conspiracy along with co-accused Ketan Kadam, who allegedly used shell companies to route funds and helped set contract terms in collusion with BMC officials.

Rathod, proprietor of M/s Maindeep Enterprise, is accused of conspiring with Kadam to execute an MoU and agreement to hire machines despite M/s Virgo Specialties Pvt Ltd not possessing the required machinery in January 2021.

He is also alleged to have prepared a fake MoU using forged signatures of deceased land owners for submission to the BMC, and of furnishing bills for dumping silt even though the project had not been carried out.

The scam, which allegedly involves multiple contractors and civic officials, is under active investigation by the Economic Offence Wing of the Mumbai police to trace the financial trail and identify beneficiaries of the siphoned funds.

# 'North Karnataka needs more districts, better governance and not statehood'

Kalyana-Karnataka districts lag in human development, with poorer education, healthcare, jobs, irrigation, and industry than Bengaluru.

Karnataka . (Agency)

The demand for a separate North Karnataka state has resurfaced once again, this time from within the ruling party. Congress MLA Bharamgouda (Raju) Kage has written to the President of India, the Prime Minister, the governor and the chief minister, calling for a new state carved out of 15 northern districts. He cited decades of neglect since the unification of Karnataka in 1956 and pointed to a signature campaign supported by over one crore people.

Behind the letter lies a grievance that is both old and real. Districts in what is now called Kalyana-Karnataka consistently rank at the bottom on human development indicators. Access to quality education, healthcare, irrigation, industry and stable employment is much weaker than in Bengaluru and the southern belt.

Large numbers of young people from Raichur, Yadgir, Koppal and Ballari migrate to other states or cities for basic livelihood. The state



itself has acknowledged this gap through the DM Nanjundappa Committee report on regional imbalance, the more recent Govind Rao committee set up to review it, and through the special status granted to the Kalyana Karnataka region under Article 371(J) of the Constitution. The problem is not lack of diagnosis, but lack of adequate response.

The question, however, is whether breaking Karnataka is the only way to address this crisis. Statehood is a drastic remedy. It requires a long and uncertain process under Article 3 of the Constitution, a political consensus that does

not yet exist, and a complex division of assets, staff and institutions.

It would raise fresh questions about the sharing of rivers and reservoirs in a region already strained by water disputes. It would also cut across the emotional idea of 'Akhanda Karnataka', which was built through a long movement for a unified Kannada-speaking state. Before choosing such an extreme instrument, it is necessary to examine whether less disruptive but serious structural reforms have been exhausted.

The core complaint that residents of North Karnataka describe is not only about the amount of money spent, but about distance from power. In several districts, many taluks are more than 100 km from the district headquarters. For a woman who needs a signature on a scholarship form, a farmer who disputes land records or a worker who wants to pursue a grievance, this can mean losing a full day, spending on travel and depending on local

### Pakistani couple 'elopes' to Gujarat's Kutch, detained

The duo identified themselves to the police as Popatkumar Nathu Bhil (24) and Gauri Gulab Bhil (20) but could not produce any formal identification, officers said. An investigation officer told The Indian Express that the two only carried 100 Pakistani Rupees (PKR). The officer added, "They claimed to be in a relationship but their families were against it."

While the BSF did not release a statement in the matter, police said the two claimed to be residents of a village in Tharparkar district, located in Mirpur Khas Division of the Sindh Province, Pakistan.

The two would be taken to the Joint Interrogation Centre in Bhuj city, Kutch, and questioned by security agencies, police said. Kutch (East) Superintendent of Police Sagar Bagmar was unavailable for comment on Tuesday.

On October 8, another "couple" from Pakistan - Toto alias Tara Ranmal Chudi and Meena alias Puja Karsan Chudi – were detained by the police at Ratanpar village in Kutch. They told the police that they lived in the same locality, near a temple in a village of Islamkot in Pakistan and since the families were against their relationship, they "eloped" on

# Nariman Point to Virar in under an hour? Here's how new sea link will redraw Mumbai's north-south map

The Uttan-Virar Sea Link, a high-speed, eight-lane north-south coastal corridor, is expected to enable seamless travel from Virar to South Mumbai.

Mumbai. (Agency) The Maharashtra government on

Tuesday approved the Detailed Project Report (DPR) for the Uttan-Virar Sea Link, a project that northernmost arm of Mumbai's coastal road network. When completed, this corridor is expected to become the final missing piece in a future ring road skirting the city's western shoreline, enabling a seamless high-speed drive from Nariman The project is estimated to cost Rs Point to Virar and, later, Palghar.

What is the Uttan-Virar Sea Link project?

The Uttan-Virar Sea Link (UVSL) is planned as a high-speed, eight-lane north-south coastal corridor within the Mumbai Metropolitan Region. It has been conceptualised to connect Uttan, near Bhayandar, with Virar through a 24.35 km sea bridge. This is the first phase of a larger vision that involves extending the corridor further north from Virar to the upcoming deep-draft port at Vadhavan in Palghar.

will eventually serve as the Phase 1 spans a total of 55.12 kilometres, including both the sea link and approach roads. These include 24.35 km of sea link between Uttan and Virar, the 9.32 km Uttan connecting road, a 2.5 km Vasai connecting road and an 18.95 km Virar connecting road.

On its own, the Uttan-Virar Sea Link does not directly improve connectivity to South Mumbai. Its significance lies in the fact that it is a crucial component of the state's long-term plan to create a continuous coastal road network along western Mumbai, effectively

forming a ring road around the city. Does this sea link improve This network will consist of the fully operational Mumbai Coastal Road, the Bandra-Worli Sea Link, the under-construction Bandra-Versova Sea Link and the Versova-Bhayandar elevated coastal corridor. Only when all these stretches are completed will commuters be able to travel seamlessly from South Mumbai to Virar on an uninterrupted, highspeed coastal route.

Which current problems will the sea link help solve?

Once the full coastal chain is in place, the sea links together will help reduce pressure on the Western Express Highway, SV Road and Link Road, all three of which routinely face heavy congestion. They will also fill the existing gap in coastal connectivity north of Versova, where no direct coastal route currently exists.

Today, travel between the far northern suburbs and South Mumbai can take between 90 minutes and two hours. With the complete coastal corridor in place, this time is expected to be reduced considerably. Virar to South Mumbai could take around 45 to 55 minutes, while travel from Vasai or Uttan to South Mumbai could drop to 30 to 40 minutes.

# Old hobbies give way to new addictions

Think this out. What are you addicted to? What's your addiction? What's your daily fix? All of us have one. It could be your morning newspaper read. It could be your morning cup of filter coffee. Or both. But each one of us has one, if not many.

Addiction, then, is the disease I am writing about. I call it one as it seems to be quite an epidemic as of now. It's all around us. It is within us. And yet we don't recognise it to be what it is. We continue oblivious, leading ostensibly happy lives.

Without pointing fingers out at the society all around us, let me talk of my personal addictions. I am addicted to my morning cup of coffee accompanied by my favorite newspaper every morning. If it's a holiday for the newspaper, my coffee doesn't taste half as good. And vice versa. I am addicted to the habit of posting on X, Threads, Instagram, and LinkedIn first thing every morning. I need to do it every day. I am addicted to chocolate just as I am addicted to rice. A meal without rice is no meal to eat at all.

You have your addictions and I have mine. Some are addicted to cigarettes, some to alcohol, and some to endlessly flipping fingers on Instagram reels. All are addictions for sure. Some happened on their own by habit, and others got planted there by purpose. Either way, over a period of time, each one of us has a bundle of addictions which we have either bought into on our own or have been subliminally forced to own by someone out there profiting from the addiction business altogether. Whatever it is, there seem to be very few people around who can claim they are addiction-free. If you are one of them, I doff my 'Mysuru peta' to you. I have just closed a study on the addictions of the young in India. The definition of this swathe of 'young' lies in the age-group of 10-35 in India. We did this probe across 13 big urban agglomerations and 106 villages in India. We had a sample size that is representative across the regions and the datapeek I present at the macro level here is as fresh as three weeks new. Let me just cover the top-line finding. The big headline.

The young in India are bored. Despite being engaged in a frenetic lifecycle of study, work, and play, the young are bored. They are typically bored of whatever they do. If you are studying, you are bored of studying. If you are teaching, you are bored of teaching. This boredom index varies across age groups and regions, but by and large, everyone is bored and wants to do something different. Something apart from what they are doing. In the old days, the hobby was an escape mechanism. Today, the hobbies of yore have died. Stamp-collecting went away with the literal death of the traditional postal system itself. Penfriendship (a hobby where you made friends with people you never met through the exchange of letters) died with it as well. The birds are still around, but who wants to be a bird-watcher? Beekeeping is a clumsy thing to do.

The young in India today are sublimating every differentiated hobby of the past into the common hobbies of the day forced upon them by the digital revolution that has overtaken our lives. All of a sudden, the advent of television in the country itself brought in the prime addiction of watching short and long format programs on television. This killed the hobby of going to the movies in theatres and transitioned it to a swathe of stuff you can watch on television today in the privacy of your drawing room.Digital media today has killed every hobby there is. Whatever your old hobby was, it can be done virtually online. You can travel to distant places online, meet new people on dating sites, and can listen to music digitally with ease today. Every nobby has got reduced to something you can do with ease with the digital ally. The old hobbies have given way to new addictions. While hobbies were a benign pleasure, the new addiction that dominates the young in India today is a bit worrying on the score of many being negative in terms of encouraging sloth, repetitiveness and the inane habit.

### **Lessons from the Red Fort blast**

### Why the bogeys of land, love and Pak-sponsored global jihad ultimately fail

THE terrorist car bombing at Red Fort on November 10 has led investigators to an alleged radicalised network of individuals, most of them doctors, mainly from Kashmir but also from other states, who were reportedly influenced by pan-Islamist ideologies, namely al-Qaeda and the ISIS, and mentored by "handlers" in faraway Afghanistan, Pakistan and Turkey. This is not the first time that India is confronting a group of highly educated, radicalised persons who wanted to overwhelm the Indian state with acts of terrors. In the 2000s, a group called the Indian Mujahideen (IM) claimed or was blamed for a string of bombings in various cities of India — Mumbai, Delhi, Pune, Varanasi.

IM still remains on India's list of banned organisations though it has been considered to be inactive since the 2013 arrest of one of its founders, Yasin Bhatkal. Two others were reported to have found safe haven across India's western border. IM itself was said to be an offshoot of Students' Islamic Movement of India (SIMI). People's Front of India is another such group.ndia held that IM was Pakistan's creation, an allegation that Pakistan denied. In the present case, a Kashmiri maulvi who preached at a mosque in Nowgam, is alleged to have worked as an "overground" operative of the Pakistan-based and protected Jaish-e-Mohammed. There is said to be no other evidence yet to say conclusively that the radicalisation of the doctors was mentored by the Jaish.

Irrespective of whether the group had Jaish links, or was a manifestation of global jihad, or even if the "module" was self-radicalised, the question really boils down to what lessons India draws from the Red Fort incident to check such radicalisation. Former Prime Minister Manmohan Singh told an interviewer during his July 2005 visit to the US that he "took pride in the fact that, although we have 150 million Muslims in our

country as citizens, not one has been found to have joined the ranks of al-Qaeda or participated in the activities of Taliban". Why is that, the interviewer, Wolf Blitzer of CNN, asked. "This is because India is a functioning democracy," Singh replied. "We are a secular state where all sections of communities, regardless of religion, caste and creed, they may belong to — can participate in our mainstream national activities. Being a democracy, being a secular democracy where all religions are free to practice their respective faiths without fear, without favour. I think that's something which has prevented that sort of eventuality."

Singh did not mention things he must have known were already concerns for the security agencies. India's secular

At long last, the Union government has notified the four labour codes. In 2019 and 2020, it repealed as many as 29 labour laws and replaced them with four amalgamated codes—on wages, industrial relations, social security, and occupational safety and working conditions. Though these were passed by parliament five years ago, the absence of the rules required for enforcement had kept them in abeyance. The government's stated rationale is that multiple overlapping laws made compliance and enforcement difficult, and that many colonial-era provisions were outdated. Though unstated, the move is also aimed at making India more attractive for foreign investment. Opposition trade unions have broadly condemned the new codes as an 'antilabour' move designed to usher in a 'hire-and-fire'

regime. The old threshold—companies employing 100 or more workers requiring government permission for closure or lay-offs—has been raised to 300, giving firms more flexibility to shut down or rationalise departments and manning levels. Similarly, the 8-hour working




day—considered a hard-won right secured by trade unions over decades—has been altered by the stroke of a pen.

For industry, the codes promise less red tape. The number of returns will come down from 39 to just one electronic return, and licences will be offered through single-window clearances. But the Association of Indian Entrepreneurs

reckons the codes will raise operating costs for smaller enterprises. For millions of unorganised workers, the focus will now shift to defining and enforcing minimum wages. Among the categories listed for minimum wages, work predominantly performed by women has often been slotted under the unskilled category; livestok care, for instance, is assumed to be done by men.A flexible hire-and-fire regime, while workable in a robust economy with plentiful jobs, can be detrimental in Indian conditions. Regular jobs are scarce and unemployment is rampant. Yet much of the job-protection framework has been dismantled. Today, barely 6.3 percent of the workforce is unionised, and labour disputes have dropped

dramatically—from 354 in 2014 to just 76 between 2015 and 2023. Generating and protecting jobs must, therefore, be a priority for governments. The new labour codes may be a start, but the need for course correction will be felt more urgently down the line.

### Post-COP30 global climate order



The last couple of days at the 30th Conference of Parties (COP30) in Brazil witnessed intense battles—between the legitimate demand of the developing world to enhance financial support for the energy transition and adaptation, and the push on climate ambition as perceived by the developed world. At every COP, the developed world seems a lot more concerned about its own industry, jobs, and the climate impact on its communities and ecosystems. It pushes the developing world to accelerate emission mitigation, even in the absence of adequate financial support. The same script repeated itself in the push for a 'fossil fuel transition roadmap', down to the last minute, at COP30.

COP is a platform where countries come together to give some and take some in the spirit of 'global mutirão', or community action, as framed by the Brazilian presidency. When so many countries come together to make difficult choices, there are two potential ways to ensure action. Either create a tight, legally-bound architecture where countries that don't act on climate are penalised, or have a bottom-up voluntary architecture based on trust and accountability. The Copenhagen COP (COP15) showed the world that top-down would not work. The Paris Agreement was built on the latter, a voluntary framework, and has already bent the emissions curve. By bringing real-world constraints, such as development barriers and lack of adequate finance, and workable pathways to the fore, the developing world helped chart a more honest course at COP30. It delivered meaningful wins—a long-awaited breakthrough on adaptation finance; real progress on just transition by recognising that countries will chart diverse, development-linked pathways; and, despite a

difficult geopolitical year, a deal that kept the multilateral process intact.

Enhancing mitigation ambition means difficult choices.

This is when the spirit of mutirão is tested. The big question is: would this bottom-up architecture, where countries undertake actions based on their national circumstances, work? The text coming out of COP30 emphasises the criticality of multilateralism to give a message to the world: it is important to not be swayed by what is happening to the global order. Trust is the bedrock of multilateralism. It will only be created if there are spaces for honest conversations on issues close to parties'

national interests. The COP30 presidency took a significant step in this direction by allowing some core issues to be discussed, even if it was impossible to put these on the formal agenda. Parties were heard, a critical first step to rebuild trust. However, continuous backsliding on the core principle of the UN Framework Convention on Climate Change, constant denial of the means of implementation, and implementation of unilateral trade measures don't bode well

for the future of the Paris Agreement. As research by the Council on Energy, Environment, and Water has highlighted for years, the transition to a net-zero world is an economic transformation. Countries whose economies are critically dependent on fossil fuels either for economic or energy security and access are bound to resist hard in the absence of meaningful and mandatory financial support. So the key question now is: which direction are we going post-COP30? The Global South is already acting on many fronts—simply because it cannot afford not to. CEEW research shows India's current climate policies could cut about 4 billion tonnes of CO2



between 2020 and 2030—1.6 times the EU's 2023 emissions.

The developing South will further accelerate transition if low-cost, predictable, and meaningful financial support is available—the required quantum of which is far beyond what developed countries have so far been willing to support. Most likely, the desired finance will never come. But the developed world, especially the EU, is deeply committed to the idea of global ambition.

There are potentially two directions from here. First, countries in the developed world will ramp up unilateral trade measures under the guise of environmental

integrity. Second, the idea of 'climate coalitions', where a group of large countries can come together to act themselves, and incentivise or penalise others outside the club, will start gaining ground.

The former is already in motion, spurred by the EU's Carbon Border Adjustment Mechanism. Many other countries in the developed North are thinking about the same. The latter idea has been gaining traction, with the Brazilian presidency proposing a climate coalition based on carbon pricing, supported by many others including China. Countries will assess their incentives for joining a climate coalition, and take a call based on that.

To safeguard its development and climate goals, India, like many other countries, must now play smart across all arenas. It can continue enhancing its ambition through its domestic resources, something it has already been doing for long now; it may

retaliate through its own version of CBAM or other trade measures; and it can assess the implications of being a part of climate coalitions. India should realise that the game is no longer being played solely at the UNFCCC platform. It has to meaningfully assess and devise strategies to engage in the other two arenas as well, committing equal intellectual investment. It has to somehow balance between principles and realpolitik. The outcome of COP30 shows that the task has become more complicated, but so is India's capacity to shape it with clarity, confidence, and real solutions.

### My remarks on BLOs distorted, claims Jharkhand Health Minister Irfan Ansari

Jharkhand Health Minister Dr. Irfan Ansari, who kicked up a controversy after telling people to lock up the Booth Level Officers (BLOs) inside if they visit their homes for the Special Intensive Revision (SIR) of electoral rolls, on Tuesday sought to claify his statement, terming it a "distortion" of his words and an attempt to create unnecessary confusion.

He is quoted as having told people: "If anybody (BLO) comes to remove your name (SIR) from the voter list, lock them inside your house.....I will come and open the lock. Never allow them at any cost to remove your name from the voter list," he said. Ansari also alleged that the BJP is conspiring to brand people as "infiltrators" and eliminate their names from the voter list under the guise of SIR.

The opposition BJP termed his remarks as an attack on Booth Level Officers (BLOs). Ansari rejected the allegations.

The minister said that cybercrime has been rising steadily in Jamtara, and certain individuals have been impersonating BLOs in order to extort or intimidate people under the pretext of adding or deleting names from the voters' list. "My remarks were aimed purely at alerting the public. But the BJP twisted my straightforward caution and tried to project me as some sort of 'national hero'. This only shows that the BJP has completely lost its sense of judgement and moral direction," he said.

Clarifying his original statement, Dr. Ansari stressed that a BLO is an authorized representative of the government and the Election Commission, and all additions or deletions in the voter list must take place strictly as per the Special Intensive Revision (SIR) procedure.

### Five killed as car plunges into Sharda Canal in Bahraich

A tragic accident occurred late Tuesday night when an Alto car returning from a wedding ceremony plunged into the Sharda Canal near Paras Purwa village on the Dakehrwa-Girjapuri Highway in the Padhua police station area. Five people lost their lives, while the driver remains critically injured, police confirmed on Wednesday

The incident occurred around 1:00 am on Wednesday. Residents reported hearing a loud splash as the car fell into the canal, which prompted nearby people to rush to the scene. By the time they arrived, the vehicle had almost completely submerged. Witnesses said the passengers were seen struggling inside, but the car sank within moments

Locals immediately informed the police. Sub-Inspector Abhishek Singh and his team from Padhua police station reached the site. With the help of villagers, they arranged a rope and a boat to enter the canal. Villagers tied the submerged vehicle with the rope and managed to pull it to the bank.

The doors of the car were reportedly locked, forcing rescuers to break the windows with bricks. All six occupants were removed from the vehicle. One victim briefly regained consciousness after CPR, but five others remained unresponsive. They were rushed to CHC Ramiya Behar, where doctors declared five people dead.

The deceased have been identified as Jitendra (23), Ghanshyam (25), Lalji (45), Surendra (50), and Azimullah, all residents of the Ghaghra Barrage area of Sujauli police station in Bahraich. Four of the deceased were employees of the Ghaghra Barrage in Bijnor. The driver, Bablu, is admitted in critical condition.

### Jharkhand to conduct first-ever **Digital Habitation** Mapping and Infant Registration

Ranchi. (Agency)

The Jharkhand Education Project Council (JEPC) has announced that, for the first time, habitation mapping and the upcoming infant registration survey will be carried out entirely through a digital platform using the Dahar 2.0 portal and mobile application.

Officials have been instructed to complete habitation mapping for every school by the end of November, while the infant registration survey will begin in December.

The directives were issued during a review meeting held on Tuesday, chaired by JEPC Director Shashi Ranjan.

Addressing district-level officials, Ranjan emphasized that negligence or indifference in completing habitation mapping will not be tolerated. "The work must be completed without delay. Continuous monitoring should be done for a week, and habitation mapping should ideally be completed within this period. After this, the infant registration survey must commence in December," he said.

Weekly monitoring of both activities will be conducted, and any unsatisfactory or delayed work may lead to action against Block Education Officers and Headmasters.

According to the Council, habitation mapping is mandatory for all schools and is being conducted digital-first for the first time in the state. The Dahar app, specifically version 1.4, must be downloaded and used for this purpose. So far, 3,614 schools across Jharkhand have completed the mapping, with Ranchi district achieving the highest progress 52% of its schools have already met the

# PSL turmoil: Multan Sultans owner quits amid rift with Pakistan Cricket Board

**MANCHESTER** . (Agency)

Ali Khan Tareen has officially exited his role as owner of the Pakistan Super League (PSL) franchise Multan Sultans after the Pakistan Cricket Board (PCB) chose not to offer him a renewal of his franchise agreement on Tuesday. Unlike the other five PSL teams, which secured renewals for the next decade, Multan Sultans now face an uncertain future regarding their ownership. The decision follows several months of escalating friction between Tareen and the league's governing body, culminating in his announcement on X, where he described the move as a difficult but inevitable conclusion."I know I'm not everyone's cup of tea, and I'm okay with that. But I have always been honest and I have always spoken my mind. I never learned how to play it safe or just play along. That simply isn't who I am. And if staying means compromising those principles there is only one choice I can make," Ali Khan said in his post."So, this is goodbye.

The Multan Sultans owner wshed the franchise well, highlighting how deeply he valued the



team and his association with the PSL.Despite the financial losses year after year, I never once thought about walking away. The Sultans have always meant more to me than just numbers. And I have always been willing to go as far as needed to protect it," he said."Please know that this team has always been much more than its owner. It

belongs to you and to South Punjab. So whoever takes control of the Sultans next, please keep supporting them with the same passion. You can count on me to be in the stands supporting them too."Tareen's resignation comes after a public standoff with the PCB. His criticism of the board's management of the PSL prompted sharp

responses, and he repeatedly maintained that he was never approached regarding a renewal offer. The PCB escalated matters by issuing him a legal notice, alleging breaches of contractual obligations and demanding a public apology — a demand he refused to

The conflict reached a tipping point when Tareen openly challenged the PCB's governance, calling out the current leadership under Mohsin Naqvi for its handling of the PSL and its intolerance of dissent from stakeholders. In response to the legal notice, Tareen recorded a video in which he read aloud and replied to the board's claims before tearing up the document on air. He also criticised the lack of communication from PSL management, noting he had never received any call or invitation to discuss concerns and was confronted only with legal action. With Multan Sultans performing strongly on the field, the uncertainty surrounding their ownership marks a significant moment for the PSL.

### Hiring demand strong; manufacturers face talent crunch

New Delhi, (Agency)
Manufacturing companies are finding it increasingly difficult to hire the right talent even as hiring intent in the sector remains strong. The demand for talent is expected to rise by 10–12% in FY27, according to estimates by HR and staffing firms. TeamLease Edtech notes that while overall hiring demand could grow by about 12%, companies are struggling to source skilled mid-level candidates with the right domain expertise and capabilities.

According to TeamLease's Employment Outlook Report for HY2 FY25, manufacturing, engineering and infrastructure together show an 8.7% net increase in employment for FY25. Translating this sentiment into annual demand, FY25 is likely to see 0.9–1.1 million roles, driven by industrial corridors, EV supply chains, construction, and capex-led expansion. If current investments continue, hiring demand in manufacturing could rise to 1.1–1.3 million in FY26, and 1.3–1.5 million in FY27 as industrial capacity, logistics integration and largescale infrastructure projects mature," says Shantanu Rooj, founder and CEO, TeamLease Edtech.

Rooj adds that while hiring intent remains strong, the nature of demand is shifting. "Firms now seek hybrid engineers (automation, IoT, industrial analytics) rather than purely traditional hands-on roles. While India's labour pool is sizable, there remains a gap in job-ready, specialised technicians. Firms often find entry-level candidates teachable but struggle to find mid-level candidates with both domain and digital skills out of the box," he told TNIE. The TeamLease report also notes that across all businesses in the services sector, 4-4.5 million jobs are likely to be created in FY26 due to digital adoption, GCC expansion, financial inclusion and growing consumption. Sonal Arora, country head, Gi Group Holding, said, "By the next financial year, we expect hiring demand in manufacturing to be 8–10% higher than this year, while demand for mid- and seniorlevel roles is expected to rise by 4-5%."Rohit Thakur, CHRO, Auto & Farm Sector, M&M, says: "While India has a strong labour pool, finding sufficiently trained and skilled workers—especially for new-age technologies—remains a challenge. Hence, we focus heavily on reskilling and upskilling our workforce."Amit Arora, senior vice president, Trivitron Healthcare, says that although the talent base is expanding, it remains difficult to find an exact match for niche skills readily in the market.

### GDP in second quarter to grow at 7-7.5%

New Delhi.(Agency)

The economy continues to be on a strong footing as analysts expect the second quarter GDP to grow at 7-7.5% boosted by high rural consumption as a result of low inflation and GST rate rationalization. Though the second quarter GDP growth is estimated to be lower than the first quarter number of 7.8%, a higher than 7% growth in the second quarter would still be higher than RBI's FY26 estimate of 6.8%.

Based on the estimated model, we obtain a forecast of real GDP growth of 7.5% in Q2FY26 with possibility of an upside surprise," it said in its report. According to IDFC First Bank chief economist Gaura Sen Gupta, high frequency growth indicators are showing improved growth momentum in Q2FY26, even before the GST cuts. "Pick-up in rural demand indicators have become broad-based supported by rise in rural wages and second consecutive year of good monsoons. Tractor sales jumped by 31%YoY in Q2FY26 and 7.7% rise in FMCG sales volume growth. Labour market conditions in rural areas have improved with sharp decline in demand for jobs under NREGA since July 2025 onwards," she says. IDFC First Bank estimates the Q2 GDP likely to have grown at 7.3%.

# 102 Indian seafood exporters allowed access to EU market

Several sea food exporters have managed to safeguard themselves from the severe impact of the US tariff as the European Union allowed 102 Indian sea food exporters to tap the European market, Commerce Minister Piyush Goyal said on Tuesday. Speaking with the media, Goyal said the government had initially anticipated a short-term setback for marine exporters after the US did not move forward on a bilateral trade pact this year. "Our seafood exports which we thought will take a hit as we have not been



able to conclude the bilateral trade agreement. We are happy to note that thanks to quality control measures, we have succeeded in getting Indian seafood exporters access to the EU market after 9 years," said Goyal. With the Quality Control Order (QCO) in place, the Ministry is hopeful that the Indian exporters have become more competitive

and will be able to tap more markets in future. With the EU allowing the export of seafood, there has been considerable growth in the sector in the last three months. With the US President Donald Trump imposing tariffs, sea food was one of the worst affected sectors. "From April to October last year our (seafood) export was \$4.21 billion. This year it is already

creation and business opportunities,' added Goyal. European countries have historically been difficult markets for marine products. The bloc had not approved any Indian fishing, fisheries or marine-processing establishments for nearly a decade, blocking significant export potential. According to the Commerce Ministry, the breakthrough could have been possible only after India's push to tighten its domestic quality ecosystem through a series of Quality Control Orders (QCOs). While QCOs were aimed at upgrading India's standards regime, they also became a point of negotiation with the EU, which was

Ask anyone about money, and you'll get a debate that sounds like IPL commentary."Mutual funds or insurance?""Stocks or real estate?""ETFs or FDs?"Everyone has an opinion. Everyone wants the "best" option. Everyone wants high returns and fast results. The problem is, most people aren't investing based on their goals — they're just following the crowd. Someone's cousin made a fortune in a stock and suddenly you feel like you need to jump in too. or long-term? Do I need liquidity? Once you fix the goal, the right tool naturally follows. It's easy to fall for traps with exciting returns, lifestyle upgrades, peer pressure or the "this stock is the next big thing" buzz. But life rarely hands you one challenge at a time. School fees, a home loan, a parent's health emergency or an unexpected crisis – they can all come together. Hence, relying on just one tool is like trying to build a house with no foundation – one storm and the whole thing collapses.Let's take an example: Kartik, 38, earns Rs 20 lakh annually and feels like he is juggling a

### ITR refund delays explained: Tax department shares expected timeline

New Delhi.(Agency)

Many taxpayers have been waiting longer than usual for their income tax refunds this year, even though they filed their returns months ago. The deadline for filing ITR for AY 2025-26 was September 16, and while several taxpayers have already received their refund, many others are still waiting without clear answers. Here's what the tax department has said about the delay and when refunds are expected to be released.WHY ITR REFUNDS ARE BEING DELAYED

CBDT Chairman Ravi Agrawal said that the Income Tax Department is closely reviewing cases where wrongful deductions may have been claimed. This detailed checking has slowed down the refund process. According to him, certain refund requests were marked as "high-value" or "red-flagged" by the system due to unusual deduction claims.

These cases are being examined more carefully, which is causing the delay. He added that while low-value refunds are already being processed, the department found several instances where incorrect refunds or deductions were claimed. To prevent such errors, the department is carrying out additional checks.

Agrawal also said that the slowdown in overall refunds may be linked to a fall in the number of claims, as TDS rates were rationalised this year. Government data from last week showed that refund payouts dropped 18%, with over Rs 2.42 lakh crore issued between April 1 and November 10.In some cases, the department has written to taxpayers, asking them to file a revised return if something was missed or incorrectly reported.

APPEALS AND PENDING CASES BEING **CLEARED** 

The CBDT Chairman said that the department is working to clear pending appeals at a much faster ace. He noted that more than 40% more appeals have been settled this year compared to the previous year.He added that the department expects to finish the year with a significantly higher number of disposals.WHEN WILL YOU **GETYOUR REFUND?** 

The good news is that refunds are expected soon. Agrawal said that the remaining refunds should be released by the end of this month or by December.Simple cases and low-value refunds are typically processed first, while returns with mismatches or unusual claims take longer to verify.In other words, as the department completes its checks, taxpayers can expect clearer updates and quicker movement in the

### Sensex roars back above 85,000; metals, **PSU** banks power mid-morning surge

By late morning on Wednesday, the Indian stock market staged a strong rebound, with the Sensex surging sharply around 11:30 AM after a soft spell earlier in the week. The energetic, lifting benchmark indices as well as the wider market. The Nifty 50 reclaimed the 26,100 zone, signalling renewed risk appetite among investors after several sessions of cautious trade.

The BSE Sensex surged 855 points to 85,358 in mid-morning trade, and the momentum continued as buying interest stayed strong across the index.

# Most Indians Are Saving Rs 5 Out Of Rs 100 Vs Parental Savings In 70s, 80s -- Why Money Rules Are Not Same In 2026 Explains Fin Expert

Angel investor and Financial Expert Ankur Warikoo believes that India is facing a silent but severe household savings crisis. He has proposed three simple formulas following which people can save more money and live a comfortable life.

Warikoo in a Youtube video-explainer said that India's household savings rate has plunged to just 5.1 percent. In simple terms, if a family earns Rs 100, they save only Rs 5 which is the lowest level in 47 years. In contrast, our previous generations saved far more compared to us. He said that savings have crashed and debt has risen. In his words, "debt has exploded in India". Warikoo said that India's total household debt has increased to Rs 120 lakh crore. But what matters more is where this debt will take us. Historically, families borrowed primarily to buy assets like homes or gold. Nowadays, people take out loans to buy cars, phones, clothing and even vacations. He stated that consumption is rising faster than income, as is cedit.

Warikoo said that a ajor warning sign is the surge in credit card stress. He stated that outstanding credit card balances now total



Rs 3 lakh crore with 28 percent of users defaulting. He said that the average credit card balance is Rs 33,000 in a country where the national average salary is around Rs 25,000. Between 2023 and 2025, the default rate for personal loans under Rs 1 lakh was 44 percent.

Financial stress resulting in mental stress Warikoo stated that financial stress is affecting mental health with some studies

indicating that roughly 19 percent of suicides in India are related to financial stress. Warikoo believes that traditional financial advice will not work in 2026. He said fixed deposits yield 6 to 7 percent but after tax returns are only around 6 percent. Real inflation is closer to 8 to 10 percent. All these indicate that your savings are

losing value year after year. Warikoo said that housing has become

nearly unachievable. Property prices in many cities have risen to Rs 4 to 5 crore while salaries have grown at only 6.3 percent per year over the last decade. Because of this disparity, most people are unable to own homes.

What are the financial survival strategies? Warikoo has offered a playbook for everyone in 2026. He claimed that if someone follows these three formulas in their financial journey then they will receive everything in life without exception. Warikoo stated that the first step towards financial success is to upskill yourself. He said that you must focus on your skills and beat the annual average growth of salary by at least 2x or 3x.

Second, invest and take calculated risks. He said taking calculated investment risks through equity markets will help build money in the long run.

The final stage is to consider a side gig in addition to your primary source of income. He said that the side gig could be music, graphics, content or code which would help build up your money over time. Warikoo has advised people to "Save a lot of money and live a simple and amazing life".

A new study has found that kids from high socioeconomic background are more likely to rely on parental help as adults.

uthor Anna Manzoni of the North Carolina State University said that she wanted to know how young adults become independent of their parents, adding that she ended up focusing on what he called 'partial independence,' when people don't live with their parents but still get financial support from them.

In the study, Manzoni looked at data on 6,471 people between 18 and 32 who participated in the National Longitudinal Study of Adolescent to Adult Health and found that 41.4 percent of the participants who were between the ages of 25 and 32 when the study conducted its most recent interviews in 2008 still relied on financial support from parents.

Manzoni said that those who attended four-year colleges and those from higher socioeconomic

backgrounds were much more likely to be partially independent in their early 20s.

However, people who attended college were more likely to become financially independent as they reached their late 20s and early 30s.

She said that this was especially true for people who paid their own way through college, adding people whose parents supported them financially throughout college were also more likely to move back in with their parents at some point.





# Dad's diet key to wellbeing of

A dad's diet before they conceive could be genetically passed onto the children, with a subsequent impact on those childrens' mental health, the team from Melbourne-based RMIT University reported.

While mothers' diet and impact on children has been widely





researched, this is believed to be the first time the behavioural and hormonal effects of the male diet on offspring has been studied.

During the study, lead researcher and professor Antonio Paolini allowed male rats to eat abundant amounts of food and compared them to those with access to 25 percent fewer calories in their diet.

"Even though the fathers had no contact with their offspring and the mother's behaviour remained relatively unchanged, the offspring of the food-limited rats were lighter, ate less and showed less evidence of anxiety," he

The differences appeared to be 'epigenetic', meaning the younger rats' genes functioned differently as a result of their fathers' experience.

"The results suggest that the diet of one generation may affect the next," Paolini pointed out.

Reduced calories may sharpen survival instincts, making animals less anxious and more adventurous in the way they explore their environment.

The kind of food your father relished may have a direct impact on your health and overall wellbeing, according to new research.

The environmental factors could also have an effect on sperm production in men in the days leading up to conception, posing an additional risk to the health of their children.

"This makes it important for both mothers and fathers to consider their environment and things such as diet, alcohol consumption and smoking, before conceiving," the authors



Even if your five-year-old kid does not know what money can buy for him or her, the moment he or she gets to know the value of it, chances are the knowledge may make him or her less philanthropic in nature, says an interesting research.

In other words, the act of handling money makes young children work harder and give less.

This effect was observed in children who lacked the concrete knowledge of money's purpose and persisted despite the denomination of the money.

"Money is a double-edged sword. It produces good outcomes in terms of concentration and effort but bad outcomes when it comes to helping, taking, and donating." said professor Kathleen Vohs from the University of Minnesota and co-author of the study.

For this, the researchers conducted five experiments and one study involving 550 children (ages three-six) in

Poland and the US. In one experiment, the children were asked to either sort

# Learning value of money may make kids less kind



money or buttons before completing a challenging puzzle.

After sorting money or buttons, the pre-schoolers were asked to help the experimenter prepare a task for another

The children who had sorted money were less helpful in terms of gathering crayons for the experimenter than those who had first handled buttons.

An additional study tested whether candy might elicit a similar response to money.

After sorting money, buttons or candy, the children were informed that they could take up to six Disney stickers. All of the children who sorted money took at least three stickers, whereas only 78 percent of children who sorted candies and 76 percent who sorted buttons took as many.

The children were then told they could give some of their stickers to other children who did not participate.

Kids who sorted money prior to receiving their stickers donated half as many stickers compared to kids who sorted buttons or candy.

"Our findings with children as young as three years old suggest potentially significant implications for achievement, generosity, and interpersonal harmony," added Lan Chaplin, associate professor of marketing at the University of Illinois.

According to Vohs, the results with children mirror patterns from European, Asian and North American adult samples.
