# Rift in Siddaramaiah camp? Aide says will accept Shivakumar for top post if...

Karnataka Home Minister G Parameshwara signalled a major endorsement by saying he would accept DK Shivakumar as Chief Minister if the Congress decides on a transition. Minister Zameer Ahmed Khan, however, said that the Chief Ministerial seat is not empty till 2028.

### Bengaluru.(Agency)

On a grey Thursday morning in Bengaluru, Karnataka Home Minister G Parameshwara, a confidante of Chief Minister Siddaramaiah, set political temperatures soaring after he said he would accept DK Shivakumar as the Chief Minister if the party high command decided so. A few minutes later, another Siddaramaiah aide, Minister Zameer Ahmed Khan, said the complete opposite, asserting that the Chief Minister will continue to remain in the top post. With this, a new twist was added to an already dramatic

leadership battle playing out in Karnataka between Chief Minister Siddaramaiah and his deputy DK Shivakumar. The action in the now-on-now-off tussle has moved to Delhi this time, with both sides wanting the Congress leadership to decide once and for all.

#### 'WILLACCEPT DK SHIVAKUMAR'

Speaking to India Today, he said "When someone asks me about Chief Minister aspirations, I naturally reply that I am in the Chief Minister race. But if there is a power transition and DK becomes Chief Minister, we will accept that.'



This marks one of the strongest signals yet from within Siddaramaiah's camp amid the ongoing churn.Parameshwara added that any transition, if approved by the party, would be smooth.

He also reiterated that he too has Chief Ministerial aspirations, adding that the High Command is fully aware of his "contribution to the party," while reiterating that the final decision rests with them. Congress president Mallikarjun Kharge was "also a suitable candidate for Chief Minister," he said, but maintained he had no knowledge of any pact

between Siddaramaiah and DK Shivakumar.

### 'CHAIR NOT EMPTY'

Meanwhile, when asked about the Vokkaliga community's demand to make DK Shivakumar the Chief Minister, Zameer Ahmed Khan said it was natural for Vokkaligas to back him "because they are his community," while stressing that "the Chief Minister's chair is not empty.

#### LEADERSHIPTUSSLE

The tussle in Karnataka centres on growing speculation over a leadership change, with pressure building around a reported powersharing pact between Chief Minister Siddaramaiah and Deputy Chief Minister DK Shivakumar. The chaos intensified as a batch

of MLAs loyal to Deputy Chief Minister DK Shivakumar flew to Delhi, pressing the party high command for the Chief Minister's post. As that pressure mounted, Chief Minister Siddaramaiah camp convened a huddle of its own, aiming to persuade the High Command the chair for the top post isn't vacant. The internal feud has forced party president Mallikarjun Kharge, and by extension, senior national leadership, to step in. 

## **Seeking votes through financial** promises inappropriate: Sharad Pawar on Ajit's remark

In a swipe at Maharashtra Deputy Chief Minister Ajit Pawar's 'vote or no funds' remark, NCP (SP) head Sharad Pawar on Thursday said it was inappropriate to seek votes based on financial assurances. Speaking to reporters at Baramati in Pune district, Sharad Pawar also said the aid provided by the state government to farmers for losses due to rains and floods is not sufficient. Ajit Pawar, who heads the rival NCP, last week told voters at Malegaon in Baramati tehsil of Pune district that he will ensure there is no shortage of funds for the town if they elected the candidates of his party, but if they rejected them, he will also "reject". Elections to various local bodies in the state are set to be held on

December 2.Responding to the debate over who controls the state treasury following the deputy CM's comments, Sharad Pawar said

there is a competition going on about how much funds to be given.

Instead of seeking votes on the basis of work done, the votes are sought based on financial



assurances. This thing is not appropriate. If there is only one goal to win the elections by bringing financial aspects, then what is the need to comment on such things," the senior Pawar said.

On the financial aid to farmers who suffered losses due to heavy rains in some parts of the state recently, the NCP (SP) chief said there was a need to provide adequate help to cultivators who suffered damages.

The state has taken a decision to stop the recovery of loans taken by farmers for one year. The measure will help the farmers temporarily, but not in the long term. Looking at the losses farmers suffered, the state should have provided partial financial aid to the farmers. This could have helped farmers adequately," he opined.

## Cabinet clears two rail multitracking projects for Gujarat, Maharashtra

New Delhi .(Agency)

The Union Cabinet on Wednesday approved doubling of the 141-km Dwarka-Kanalus rail line in Gujarat and building third and fourth lines between Badlapur and Karjat (32 km) in Mumbai metropolitan region. The two line-expansion projects worth Rs 2,781 crore are part of Indian Railways' push to improve connectivity on routes with high passenger footfall. The Devbhumi Dwarka (Okha)-Kanalus rail line will improve connectivity to the Dwarkadhish temple, a key pilgrimage site, and transportation of commodities such as coal, salt, container, and cement.

Okha is a coastal town in Dwarka, while Kanalus railway station is in Gujarat's Jamnagar district. The doubling of the railway line is expected

transportation of edible salt with overall additional freight traffic of 11 million ton per annum. The line will have 7 major bridges and 143 minor bridges. It will involve a total



expenditure of Rs 1,457 crore.

The Badlapur-Karjat line, which is part of 88-km Kalyan Lonavala, is a crucial link of the Mumbai suburban network. The line traverses through Thane and Raigad districts of Maharashtra and the expansion will further help the commuters between Pune to Mumbai. The line falls on the 1,238-km Mumbai-Chennai via Pune-Solapur-Guntakal-Arrakonam high-density network.

The 32-km line will have eight major bridges and 106 minor bridges. It will involve a total expenditure of Rs 1,324 crore, of which 50 per cent will be spent by the Maharashtra government. The expansion of this line is also expected to increase freight movement by 7.2 million tonnes per

## Assam moves a step closer to decision on ST status for 6 communities

## Guwahati.(Agency)

The Assam Cabinet on Wednesday approved the report of the Group of Ministers containing recommendations connected to the grant of Scheduled Tribe status to six communities in the state. The report will be tabled during the ongoing assembly session. This approval was granted in a special cabinet meeting held on Wednesday evening to deliberate on the issue.

Six communities, which are currently part of the state's Other Backward Classes list and comprise around 27% of Assam's population the Tai Ahoms, tea tribes or Adivasis, Moran, Motok, Chutia and Koch-Rajbongshi - have long been agitating for the grant of ST

status, and organisations of all six communities have been holding mass demonstrations in the past two months, building pressure on the



government ahead of the upcoming elections.At the same time, the state has also been witnessing counter-protests by organisations representing communities already notified as ST in the state.

proposing to include these six communities in Assam's ST list was introduced in the Rajya Sabha but was neither discussed nor passed. Based on the Home Ministry directions, the Group of Ministers was constituted that year – and reconstituted twice since - "to determine quantum of reservation for six communities in the State, suggest revised quantum of reservation for OBCs after creation of a new ST category in Assam and measures ensuring full safeguard to protect the interests, rights and privileges of the existing Scheduled Tribes of

## Haryana Thar owner sends DGP notice over his 'defamatory' comment

Gurgaon.(Agency)

A city resident has sent a legal notice to Haryana DGP OP Singh, calling his recent statement about Thar owners defamatory. Sarvo Mitra, who owns a Thar and lives in BPTP Amstoria in Sector 102, claimed that the DGP's public remarks had caused him humiliation and forced him to stop using his vehicle out of embarrassment. The controversy erupted during police chief OP Singh's visit to the city on Nov 8, when he said, "Whoever has a Thar, their mind must be twisted. Thar is not a vehicle, it's a statement that we are like this. All the goons ride it. Meaning, the kind of vehicle shows the mindset.'

Singh's comments, made in the context of rising concerns over road stunts and accidents, suggested that owning a Thar was a sign of reckless or criminal intent.

Mitra, who has owned a Thar since Jan 2023, insisted he chose the vehicle for its robust build, safety features, and reliability for daily commuting. "I bought the Thar because it is safe and dependable. To be branded as someone with a 'twisted mind' just because of my choice of car is deeply unfair," he said.

'A car does not define a person's mindset. Such sweeping statements only create divisions and hurt innocent people," he added. Represented by lawyer Vedant Verma, Mitra's legal notice accused the DGP of making baseless and insulting statements that had caused widespread ridicule and damaged the reputation of not just him, but all Thar owners."The remarks have lowered the image of every Thar owner in the eyes of the public," Verma's

## E-cycles: An idea that flopped in Noida to be rolled out in **Greater Noida**

Gurgaon.(Agency)

Greater Noida Industrial Development Authority (GNIDA) board approved a new e-cycling project under a Build-Operate-Transfer (BOT) model, where a selected agency will install and operate e-cycle stations across the city. Under this, GNIDA will provide 25 sqm of space at designated spots for a fixed period, while the agency will bear all infrastructure and operational costs.

Officials said the service was aimed at easing traffic pressure, improving last-mile connectivity, reducing travel costs and cutting pollution as the city's population

This e-cycle project is not unique to Greater Noida.

In 2023, Noida launched the e-cycle in the city on Noida Foundation Day with similar objectives, but the project has since collapsed. It was awarded to Turban Mobility, which was to operate e-cycles at 62 docking stations. At launch the company began services at 31 stations and committed to expand to all 62 within four months. However, the expansion never happened and within a year the project stalled completely.

According to officials, Turban Mobility failed to meet several obligations under its agreement, including timely installation of docking stations and proper operation of the service. Noida Authority issued notices seeking an explanation but received no satisfactory response. As the situation deteriorated, the CEO constituted a three-member committee to review why the system had collapsed. The committee found discrepancies in the company's performance and flagged concerns about project execution. With the system nonfunctional and no corrective action visible, the Authority has initiated proceedings to blacklist the operator.

While Greater Noida prepares to roll out its e-cycle network with renewed guidelines and a BOT structure designed to minimise risk, Noida's experience serves as a stark reminder of the need for stronger compliance and monitoring. Officials said that the new Greater Noida project aimed to avoid the lapses seen in Noida and provide residents with a reliable and sustainable mobility alternative.

## Decision-making 'slow & poor': Noida gets a rap from **UP** govt

Noida.(Agency)

Noida Authority has drawn strong rebuke from the state govt for "slow and poor" decision-making and taking unnecessarily "adversarial approach" against real estate company Omaxe Buildhome.

On Tuesday, additional chief secretary (industrial development) Alok Kumar set aside an Authority's demand notice to Omaxe and directed it to recalculate the dues within four weeks after granting proportionate zero-period benefits for five towers of the developer's stalled project in Sector 93. The revisional order specified that relief must apply on three towers (T23 to T25) at Forest Spa project and two yet-to-be-built towers (T26 and 27) planned on an adjoining plot for the period between March 23, 2018, and May 19, 2025, when a high court stay had halted issuance of completion certificates.Zero period, part of UP govt's rehabilitation policy for stalled projects, is a window during which no penal interest, time-extension charges or other penalties can be imposed. Omaxe approached UP govt in May after it received a demand notice from the Authority. The developer sought that the period from May 6, 2015, to May 29, 2025, be treated as a zero period,

citing a series of court-imposed stays over a decade that prevented it from completing the construction of the towers, handing over units and executing registries, even though it continued paying dues. The dispute dates back to 2006, when Omaxe was allotted three group housing plots in Sector 93 measuring 1.19 lakh sq m with a permissible floor area ratio (FAR) of 1.5. Until 2011, it completed towers 1 to 22 of Grand Omaxe project and received a partial completion certificate.In 2010, after the Authority revised its building bylaws to increase FAR to 2.75 and allow additional purchasable FAR, Omaxe purchased 0.5 FAR and secured approval in 2013 to construct five more towers (T23 to T27).

The revised policy, however, sparked a volley of litigation by residents and associations challenging both the legality of the higher FAR and the revised layout. A chart submitted to the govt listed eight major cases before the Allahabad high court, Supreme Court and NCDRC between 2011 and 2025, leading to a series of orders that halted construction of two towers (T26 and T27).

# NGT sends notices to govt, pollution boards for waste dumping in Aravalis

Ghaziabad .(Agency)

National Green Tribunal (NGT) has issued notices to 11 respondents, including the Union environment ministry, Haryana govt and Central Pollution Control Board (CPCB) over a petition alleging illegal dumping of industrial waste in the Aravalis of Khori Kalan and Khori Khurd in Nuh district.

A bench of chairperson Justice Prakash Shrivastava and expert member A Senthil Vel said the case raised important questions of environmental compliance. All respondents have been asked to file their replies at least a week before the next hearing on Feb 13. The petition, filed by Switzerland-based Dr Amit Kumar, alleges that hazardous industrial waste is being brought from Rajasthan and dumped or burnt in the Khori belt, affecting forests, groundwater and public health. Kumar told the tribunal that he had earlier filed OA 277/2025 and was then asked to submit a detailed representation

to Haryana State Pollution Control Board (HSPCB). "No action followed despite multiple reminders. The tribunal, in a review plea in Aug, allowed me to bring the issue back,'

Kumar cited a joint inspection report of HSPCB, which recorded heaps of plastic, solid waste and industrial waste dumped along the Tauru-Bhiwadi road near Haryana-Rajasthan border. Locals told the inspection team that waste was collected from Bhiwadi's industrial area and dumped on nearby land in Khori Kalan, some of which is classified as forest in revenue

inspection. He also submitted newspaper reports and a June 20 communication from the HSPCB regional office in Nuh to its Rajasthan counterpart, highlighting cross-border movement of waste. The Khori stretch of the Aravalis has frequently appeared in

records. No burning was seen during the

waste dumping, encroachment and unregulated activity linked to the Bhiwadi industrial cluster. Enforcement has been uneven, partly due to divided jurisdiction between Haryana and Rajasthan. The ridge area is environmentally sensitive and has faced earlier disputes over illegal construction, stone extraction and disposal of untreated scrap. Local residents and environmental groups have long said that routine dumping and occasional fires are harming forest land and polluting groundwater.

The tribunal has directed the applicant to serve all respondents and file an affidavit of service a week before the next hearing. In Aug, TOI reported that large quantities of chemical waste were being burnt at night in makeshift kilns in the Aravali terrain along the Rajasthan-Haryana border in Nuh, adding pollutants to the Delhi-NCR airshed despite ongoing efforts by state govts, the centre, the Supreme Court and NGT to improve air quality.TOI found that most of the kilns burning industrial waste, including chemically treated scrap, plastic and rubber, are located in Khori Kalan and Khori Khurd. Waste is brought in at night from Rajasthan, mixed with wood and set alight in kilns or open pits. The practice persists because many factory owners avoid the cost of legal disposal, opting instead for middlemen who transport the waste cheaply.

## GMDA CEO yet to take charge a month on, Gurgaon development projects can wait

Gurgaon.(Agency)

The leadership vacuum at GMDA is beginning to affect the development work in the city. For the first time since its formation, the authority has been without a functioning CEO for over a month.

Interestingly, the Haryana chief minister himself is the chairman of GMDA.

After previous CEO Shyamal Misra was transferred on Oct 27, a new CEO was appointed the same day. However, 2006batch IAS officer J Ganesan never assumed office.On Nov 18, the govt assigned MCG commissioner Pradeep Dahiya to take on the additional responsibility. But he too has not taken charge due to procedural gaps in the

The unprecedented situation has stalled administrative decisions, delayed project approvals and stalled financial clearances at the most crucial agency — GMDA — responsible for the city's planning, infrastructure and mobility.



Due to a lack of clarity over the transfer and posting, the designated link officer has not been able to discharge CEO-level duties even as some routine files have been cleared. Sources describe the ongoing situation as a "complete standstill," with officers reluctant to process files fearing administrative complications later. In the absence of an appointed head, project estimates are not being cleared, holding up new works at the file level. Even tenders that have completed their technical evaluation are unable to move to the next stage of financial evaluation. Contractors are also

annoyed since their payments are not getting processed.Officials admit the situation is unprecedented. A GMDA official said, "We are factioning, but only to the extent that rules permit. Estimates for new work, financial approvals and tenders are all stuck. There is no clarity on when the CEO will formally assume office."Another official said that decision-making has "practically come to a halt. Basic approval of change of land use, access to the right of way and right to services timelines are getting affected."

GMDA was formed in 2017 to streamline Gurgaon's planning and development at the city level. Since then, the authority has seen a number of CEOs, from senior IAS officers at the rank of principal secretary in the initial years to officers of secretary level in recent appointments. Officials point out that not only has the tenure of CEOs become shorter over the years, but the position itself has seen a dilution in seniority from principal secretary rank to secretary rank, weakening institutional

## Gurgaon lawyer held for spying for Pakistan, 3rd such arrest in a year; family says was in touch with relatives

Gurgaon.(Agency)

A lawyer was arrested in Nuh on Wednesday on charges of spying for Pakistan. Officials said Rizwan was practising law in Gurgaon and Nuh courts. Sources said the accused was in touch with a few people in Pakistan and also exchanged some messages, which are now under scrutiny. His trips to Pakistan and his digital transactions are under investigation. This is the third espionage-related arrest from the Mewat region this year. Officials said that the accused was arrested by Nuh police following a tip-off by National Investigation Agency from Kharkhari village in the Tauru subdivision. Police are tight-lipped about the developments. The accused, according to the sources, was detained on Monday from his in-laws' village Pipaka in Nuh. Delhi Police, along with the local police, then raided the house of the suspect on Wednesday and recovered some documents. A case was registered against him at the Tauru Sadar police station under sections related to antinational activities. However, his family, talking to the media in Nuh, ridiculed all the allegations, claiming that Rizwan was only in touch with his relatives in Pakistan and "was not part of any anti-national activities". Before Rizwan's arrest, Haryana police had detained two other residents of Nuh on similar charges. In May, police arrested Mohammad Tarif, a quack in Kangarka in Tauru Sadar, for allegedly sharing sensitive military information with Pakistani handlers and supplying Indian SIM cards to operatives linked to the Pakistan High Commission (HC) in Delhi.He was allegedly sharing sensitive details of the Indian Air Force with people in Pakistan in exchange for money. Tarif, in his confession video, said he was in touch with Pakistan HC officials Asim Baloch and Zafar.

He allegedly shared the location, videos and photos of the IAF station in Sirsa with Zafar, who sent those details to people in Pakistan. He went to Pakistan

## Take me in your lap, pain is unbearable': Haryana basketball player Aman Kumar's father recalls son's final moments

In Bahadurgarh and Lakhan Majra, Hardik Rathi and Aman Kumar left a void that is difficult to fill. The two aspiring basketball players, who died after rusted poles fell on them in the court, took with them their dreams of playing for India. At the Rathi house in Lakhan Majra, 16-year-

old Hardik's medals still lie neatly arranged on the shelf he dusted every week. Just a day earlier, he had told his father he would "play for India in 2026".

Hardik, who had already made a mark nationally, was studying at ITM Global School in Gwalior - a programme sponsored by the Basketball Federation of

India. But on Nov 21, he had requested a leaving certificate from school so he could return home to Rohtak. His mother was unwell, and the teenager did not want to continue staying away from her. Since then, he had been living and training in Rohtak, preparing for the upcoming Under-17 Nationals later this

The tragedy unfolded during dunk practice - a standard drill where players try to touch the rim to measure their vertical jump. Witnesses said Hardik missed the first attempt, touched the ring the second time, but his hand gripped the net and pulled him off balance. He fell backwards and never recovered.At Aman's (15) house in Bahadurgarh, the walls still have the balloons & festoons used on his birthday on Nov 19. His mother, Kanta Devi, sobbed, "Mummy, vishwas rakhna, I will make you proud.

## Ghaziabad saw 41% jump in diabetes cases in 2 years, shows report

Ghaziabad.(Agency) . Diabetes cases in the city have

surged 41% in two years from 2.5 lakh in FY 2022-23 to 3.5 lakh in FY 2024-25, according to a report published by the National Programme on Prevention & Control of Diabetes. Each year showed a steady rise, but the jump between 2023 and 2024 is particularly significant, with over 79,000 new cumulative cases added in just one year. Year-wise comparison of the data shows worrying trends.In FY 2022, total cumulative diabetes-related figures stood at 2,51,494, which rose to 2,76,258 in FY 2023, and then sharply escalated to 3,55,551 in FY 2024. The increase can be seen across all categories - newly diagnosed cases, patients starting treatment, and those under regular follow-up — indicating not only rising incidence but also more people entering the health system for diabetesrelated care. According to the report, when the gender breakup is examined, one pattern remains consistent throughout the three years – female cases are significantly higher than male cases across all

indicators."The sedentary lifestyle and fast food consumption are the main causes of the increase in diabetes cases. The govt proactively organises camps and awareness programmes to address the issue. The number increase is also due to awareness among people of more check-ups," said Dr RK G u p t a , A C M O , Ghaziabad.Currently, there are around 3,910 active diabetes cases in the district this year.In newly diagnosed cases alone, women accounted for 1,73,085 of the total 2.27 lakh cases in FY 2022, compared to 54,835 among men. Although the gap narrowed slightly in FY 2023, the trend remained similar. By FY 2024, newly diagnosed male cases rose sharply to 1,31,923, but even then, the number of female patients remained higher at 1,56,139. This shows that while detection among men is improving — nearly doubling from 2022 — women continue to dominate the diagnosed caseload every year.A similar trend appears in the number of patients who are put on treatment. The figures increased steadily from 10,218 in FY 2022 to 15,889 in FY 2023 and

further to 18,858 in FY 2024, with women again forming a slightly larger share. Meanwhile, the number of patients receiving treatment follow-up more than tripled, rising from 13,356 in FY 2022 to 48,631 in FY 2024, representing a 260% increase. This significant jump suggests improving follow-up and monitoring systems, although it also reflects growing chronic disease burden in the district.

Type 2 diabetes is one of the most common metabolic disorders today, yet its early signs are often overlooked, especially by individuals with a family history of the disease. While classic symptoms like increased thirst, frequent urination, and excessive hunger appear in only about 30% of patients, other subtle indicators—fatigue, blurred vision, slow-healing wounds, darkened skin patches, or recurrent infections—should never be ignored. In India, the rapid rise in diabetes is driven by sedentary lifestyles, unhealthy diets, genetic predisposition, stress, obesity, pollution, and late diagnosis. Recognising symptoms early and adopting healthier habits is our strongest defence," said Dr R K Prasad, senior consultant, Endocrinology, Fortis Noida.In Noida, the total number of diabetes patients remained low compared to Ghaziabad. However, in 2023, a total of 8,638 patients were diagnosed with diabetes, of which 4,675 are men, and 3,963 are women. In 2024, the total number of patients increased to 13,761, with 7,521 women and 6,240 men, and in 2025 from April to Nov, a total of 16,815 patients reported diabetes, with 8,864 female and 7,951 male patients.

However, these numbers don't always present the most accurate picture of the on-ground reality. "Many people remain unaware they have diabetes because early symptoms are often silent. A large number of asymptomatic cases go unnoticed, leading to delayed diagnosis. As a result, diabetes is frequently identified only when serious complications begin to appear. The challenge is worsened in regions with limited access to primary healthcare, where routine screening and timely intervention are difficult" said a senior official at the health department."Long working hours, erratic schedules, and high stress levels are becoming key drivers of India's rising diabetes epidemic. In the fastpaced urban corporate culture of India, our young generation often sacrifices sleep, exercise, and balanced meals.

# As national capital chokes, MCD sat on clean air funds

New Delhi: As the continued to choke, the Municipal Corporation of Delhi (MCD) spent only 17 per cent of its clean air funds in the last five years, documents received through an RTI query show. The information, shared by the Central Pollution Control Board (CPCB), also highlights repeated gaps flagged during official inspections of Delhi's air pollution mitigation measures. According to the CPCB's response, Delhi received Rs 8.93 crore under the National Clean Air Programme (NCAP) in 2023-24. Along with an unspent balance of Rs 26.60 crore from previous years, the total available fund for that year stood at Rs 35.31 crore. Of this, the MCD spent Rs 5.19 crore, which is about 15 per cent of the total. In 2024-25, the

any new NCAP grant. It had Rs 30.11 crore available from earlier allocations, but used only Rs. 1.34 crore, or 4.36 per cent of the amount. Taken together, the MCD spent Rs 6.54 crore out of the Rs 35.31 crore available across 2023-24 and 2024-25, amounting to 18.50 per cent utilisation. The CPCB said Delhi has received Rs 81.36 crore in NCAP funds over the past five years, but used only Rs 14.1 crore, or 17 per cent. "As per information submitted Municipal the Corporation of Delhi on Portal for Regulation of Air Pollution in Non-Attainment Cities (PRANA), funds under NCAP have been utilised for the procurement of truck-mounted multipurpose water sprinkler with anti-smog gun and C&D waste management," the CPCB wrote in a reply.

They were shifted to a nearby hospital where Muskan was declared dead on arrival, while Neeraj is undergoing treatment. Preliminary investigation suggests that the two were involved in a relationship and a quarrel might have led to the shooting. The police are questioning their family members to establish the sequence of events. A case has been registered and further investigation is underway.

## Woman swaps elderly's gold earrings in Delhi, arrested

New Delhi: According to the police, a PCR call regarding the theft of a gold earring was received on October 30 at the Chandni Mahal police station. The complainant, an elderly woman, reported that the accused had first visited her home on October 27, claiming to have known her late daughter. After befriending her, the woman returned the next day. During the visit, the accused told the elderly woman that one of her earrings had loosened. On the pretext of tightening it, she allegedly swapped the gold earring with an artificial one and left. The police carried out manual and technical surveillance and checked CCTV cameras. Investigators observed that the suspect's distinctive gait, along with her eyes and a portion of her forehead visible through her hijab, matched the description provided by the complainant, who suffers from low vision. After thorough analysis and local enquiries, the team identified the woman, who was apprehended on November 15. During interrogation, the accused confessed to committing the crime for monetary gain.

## Families displaced after tornadoes hit Houston as Thanksgiving week begins

A fire in a crowded slum in Bangladesh's capital has burned or damaged 1,500 shanties, leaving thousands homeless, authorities said Wednesday.

No casualties were reported. The blaze, which began Tuesday evening at the Korail slum in Dhaka, was doused Wednesday after 16 hours, said Rashed Bin Khalid, a duty officer at the Department of Fire Service and Civil Defense. The fire service's director, Lt Col Mohammad Tajul Islam Chowdhury, said about 1,500 shanties were burned or damaged in the blaze and thousands remained homeless. According to official data, about 60,000 families "many of them climate refugees" live in the slum which has an area of more than 160 acres (65 hectares). The slum straddles Dhaka's upscale Gulshan and Banani neighbourhoods, and it is surrounded by clusters of high-rise apartment and office buildings. Heavy smoke blanketed the area as flames engulfed the dwellings overnight.

On Wednesday, the residents who lost their homes were desperate to collect their valuables as they scoured the debris. The firefighters said they struggled to reach the area because of narrows alleys. Dhaka, a city of 10.2 million people as of 2024, has hundreds of slums where people from rural Bangladesh migrate because of poverty and exploitation. Climate-induced disasters also push them to the city slums, where they live on daily labour such as driving rickshaws and working as housemaids and cleaners.

## What we know about Hong Kong's deadly high-rise fire that killed at least 44

A devastating fire tore through a Hong Kong high-rise residential complex, killing dozens of people with hundreds still missing. The inferno -- the financial hub's worst in decades -- sent shock waves through the city, which has some of the world's most densely populated and tallest residential blocks.

Here's what we know about the fire and its possible cause:Intense flames burned on bamboo scaffolding on several apartment blocks of Wang Fuk Court, a residential complex undergoing repairs in the northern district of Tai Po, on Wednesday.

The blaze rapidly engulfed several towers at the housing estate, which includes eight buildings of 31 floors each and that have a combined total of 1,984 units.Firefighters, one of whom was killed, battled the inferno overnight and it was still burning in spots on Thursday morning. Hong Kong's fire department said at least 44 people have died and authorities have said hundreds remain missing. Around 900 residents have been moved to temporary shelters and dozens were in hospital, some in critical condition.

Tightly packed city

Hong Kong is one of the most densely populated places in the world, making urban disasters a significant risk. Its 7.5 million residents are squeezed into islands covered in steep hills.

The city's population density is more than 7,100 people per square kilometre of land, on par with packed metropolises like Tokyo. Vertical living

The financial hub is famous for its dramatic skyline of sky scrapers set against a picturesque harbour, many of which are home to residents as well as as banks and commercial offices. The city's construction boom in past decades has been largely fuelled by residential towers to house its growing population.

Much of the new residential development in recent decades has been in the New Territories, the area where Tai Po is located.

## At least 55 dead, 279 missing as fire rips through Hong Kong apartment blocks

**HONG KONG** . (Agency)

Hong Kong's deadliest fire in decades burned through the night, leaving at least 55 people dead and 279 reported missing with rescuers still pulling residents from blazing high-rise apartment buildings into the morning. Authorities on Thursday said 51 people had been found dead on the scene, bringing the death toll to 55 including four others who had been brought to the hospital. More than 70 people were injured, according to the city's Hospital Authority, many suffering from burn and inhalation injuries.

Police had arrested three men on suspicion of manslaughter in connection with fire which began Wednesday afternoon in a housing complex in Tai Po district, a suburb in the New Territories. By Thursday morning local time, the fire was yet to be put out and rescues continued. Hundreds of residents were evacuated as the fire spread across seven of the eight towers in the Wang Fuk Court complex, as bright flames and smoke shot out of windows.

Forty of the 44 fatalities were declared dead at the scene, officials said. At least 62 others were injured,

many suffering from burn and inhalation injuries. Authorities suspected some materials on the exterior walls of the high-rise buildings did not meet fire resistance standards, as the rapid spread of the fire was unusual. Police also said they found Styrofoam materials -- that are highly flammable -- outside the windows on each floor near the lift lobby of the one unaffected tower, believed to be installed by a construction company."We have reason to believe that those in charge of the construction company were grossly negligent," said Eileen Chung, a senior superintendent of police. # South Africa will not receive invitation for 2026 G20 summit, says Trump

WASHINGTON. (Agency)

South Africa will not receive an invitation to attend the G20 Summit to be hosted under the US Presidency in Florida next year, President Donald Trump said as he described the country as not being "worthy" of membership anywhere. The South Africa assumed the year-long G20 US takes over the Presidency of the G20 from South Africa and will head the grouping from December 1, 2025, through November 30, 2026."The United States did not attend the G20 in South Africa, because the South African Government refuses to acknowledge or address the horrific human right abuses endured by Afrikaners, and other descendants of Dutch, French, and German settlers," Trump said in a post on Truth Social Wednesday.He said South Africa has "demonstrated" to the world they are not a country worthy of membership anywhere, and we are going to stop all payments and subsidies to them, effective immediately."At the conclusion of the G20, South Africa refused to hand off the G20 Presidency to a Senior

Representative from our US Embassy, who attended the Closing Ceremony. Therefore, at my direction, South Africa will not be receiving an invitation to the 2026 G20, which will be hosted in the Great City of Miami, Florida next year," Trump said.

Presidency on December 1, 2024.

It hosted the grouping's leaders for a summit meeting in Johannesburg from November 22 to 23, the first time that the G20 Summit was held on African soil.Trump has previously said that he will host the G20 leaders for the 2026 summit at his golf club near Miami.Trump did not travel to Johannesburg for the Summit and had said that no US Government Official would attend as long as the human rights abuses continued.Trump accused South Africa of "killing" white people and slammed the country for refusing to hand over the G20 Presidency to a senior American representative from the US Embassy."To put it more bluntly, they are killing white people and randomly allowing their farms

to be taken from them. Perhaps, worst of all, the soon to be out of business New York Times and the Fake News Media won't issue a word against this genocide," he



said.South African President Cyril Ramaphosa noted the "regrettable" statement by Trump on his country's participation in the 2026 G20 meetings.

A statement issued by the Presidency of the Republic of South Africa said that the G20 South Africa 2025 Leaders' Summit was attended by several heads of state and governments and was "hailed by all those who attended the summit as one of the most successful summits."Prime Minister Narendra Modi had attended the G20 Summit in Johannesburg and said that the "successfuL" summit will contribute to a prosperous and sustainable planet."I'd like to thank the wonderful people of South Africa, President Ramaphosa and the Government of South Africa for organising the Summit," Modi had said. The statement added that as the United States was not present at the summit, instruments of the G20 Presidency were "duly" handed over to a US Embassy official at the Headquarters of South Africa's Department of International Relations and Cooperation.It said that as one of the founding members of the G20, South Africa has always valued the spirit of consensus, collaboration and partnership that defines the G20 as the premier forum for international economic cooperation. The United States was expected to participate in all the meetings of the G20 during South Africa's Presidency.

## Shark kills woman, seriously wounds another awimmer at Australian beach

MELBOURNE . (Agency)

A shark killed a woman and seriously wounded a man taking an early morning swim with her at a national park beach on Australia's east coast Thursday, police said.Experts say a shark rarely attacks more than one person. The attack occurred at Crowdy Bay National Park, which is known for beach camping, fishing spots and hiking tracks 360 kilometers (224 miles) north of Sydney. Beaches in the area and to the north of the attack were closed to swimmers indefinitely, Police Chief Insp. Timothy Bayly said.

Emergency services were called to Kylies Beach following reports that two people in their mid-20s had been bitten by a shark at 6:30 a.m., Bayly said.Bayly declined to detail the injuries or the circumstances of the attack. "At this stage, all I'm prepared to say is they were known to each other and they were going for a swim and the shark attacked," Bayly told reporters. A bystander helped the pair on the beach

before ambulance paramedics arrived, but the woman died at the scene.

The man was flown by helicopter to a hospital, and paramedic Josh Smyth but stable.Smyth said the bystander's first aid might have prevented a double fatality."I just really need to have a shoutout to the bystander on the beach



who put a makeshift tourniquet on the male's leg which obviously potentially saved his life and allowed New South Wales Ambulance paramedics to get to him and render first aid," Smyth told reporters. The identities of the man and woman were not released. Media reports said they are European tourists.

Bayly said police would work with experts to determine the species of the shark responsible.He also expected

drumlines — baited hooks suspended from floats — would be deployed in an attempt to catch the shark.Gavin Naylor, director of the University of Florida's shark research program and manager of the International Shark Attack File database, said a single shark attacking more than one person was exceptionally rare."It is very unusual. Individual shark attacks are rare. And shark attacks on two people by the same individual is not unheard of, but it's very rare," Naylor said.

Naylor said he would need to know details of the sequence of the shark's behavior Thursday to understand what had motivated it to bite.

The context of the attack was also important such as the size of the shark and whether other prey was in its vicinity."Sometimes younger sharks are less judicious and they can make mistakes. Where sharks are close to seal colonies and feeding, the probability (of attack) is higher," Naylor said."The few bites that we do have where a single shark has bitten multiple people, it's usually tiger sharks. We've never seen white sharks do that unless somebody's heroically jumping in the way," he added.

## Two National Guard members shot in an ambush attack just blocks from the White House

WASHINGTON . (Agency)

Two West Virginia National Guard members who deployed to the nation's capital were shot Wednesday just blocks from the White House in a brazen act of violence that the mayor described as a targeted attack.

FBI Director Kash Patel and Washington Mayor Muriel Bowser said they were hospitalized in critical condition. The rare shooting of National Guard members comes as the presence of the troops in the nation's capital and other cities around the country has been a flashpoint issue for months, fueling court fights and a broader public policy debate about the Trump administration's use of the military to combat what officials cast as an out-of-control crime problem.

Jeffrey Carroll, an executive assistant D.C. police chief, said investigators had no information on a motive. He said the assailant "came around the corner" and immediately started firing at the troops, citing video



reviewed by investigators.

"This was a targeted shooting," Bowser said.

Two law enforcement officials and a person familiar with the matter said the suspect was believed to be an Afghan national who entered the U.S. in September 2021 and has been living in Washington state. The suspect has been identified by law enforcement officials as Rahmanullah Lakanwal, but authorities were still working to fully confirm his background, they said. The people could not discuss details of an ongoing investigation and spoke to AP on condition of anonymity. West Virginia Gov. Patrick Morrisey initially said the troops had died, but he later walked that statement back to say his office was "receiving conflicting reports" about their condition.

A suspect who was in custody also was shot and had wounds that were not believed to be life-threatening, according to a law enforcement official who was not authorized to discuss the matter publicly and spoke to The Associated Press on condition of anonymity. # Schools but no books: Gaza's children return to makeshift classrooms

With no backpack, books or uniform, 11year-old Layan Haji navigates the ruins of Gaza City and heads to a makeshift classroom after two years of war halted her education.But the school is not what she is used to. Painted walls and students' artwork no longer adorn the walls and hallways -- instead, tents set up in a battered building serve as their temporary classrooms."I walk for half an hour at least. The streets are devastated, full of ruins... It is difficult and sad," Haji said, wearing a torn shirt and patched trousers.But "I am happy to return to my studies," added the young girl, who already dreams of becoming a doctor. Haji is one of 900 students who are going to the Al-Louloua al-Qatami school, one of a number of these establishments that have opened their doors in a bid to allow children to resume their schooling for the first time since the Israel-Hamas war broke out."We don't have books or notebooks. The libraries are bombed and destroyed," said Haji, who lives in a displacement camp in the Tal al-Hawa area in Gaza City.

"There is nothing left," she added.

A month after a fragile ceasefire took effect, the UN agency for Palestinian refugees (UNRWA) and Gaza's education ministry announced that children had gradually begun returning to schools in areas not under Israeli military control.A critical momentAccording to a UN assessment, 97 percent of Gaza's schools sustained some level of damage, including from "direct hits", with most of them needing full reconstruction or major rehabilitation.Israeli strikes have killed many Palestinians sheltering in schools, with Israel alleging that Hamas fighters hide in such establishments. With schools also serving as displacement shelters, UNRWA has recently opened "temporary learning spaces".Last month, UNRWA chief Philippe Lazzarini said that more than 25,000 children have joined these new spaces, and some 300,000 would follow online classes. But that still falls short of the education ministry's estimates of more than 758,000 students in the strip. In the Al-Mawasi area in southern Gaza, local initiatives, some of which receive

international support, are hoping to bring children back to school.

Oatar's Education Above All Foundation has launched the "Rebuilding Hope for Gaza"



programme, aimed at supporting more than 100,000 students. The programme includes distributing school supplies, ensuring access to the internet and electricity, and providing psychological support.

But even with that support, one such school in the Al-Mawasi area can only offer four subjects: Arabic, English, maths and science.Hazem Abu Habib, from an initiative backed by the foundation, said 'we aim to help as many students as possible resume their education, even if it's just with basic courses". Before the war,

Gaza was "completely free of illiteracy", he said. But now "education is facing its most critical period".

Heavy labour

Sixteen-year-old Said Sheldan said he was full of joy at being able to attend school now that the war has stopped. But "I don't have books, notebooks, pens or a bag. There are no chairs, electricity or water --not even streets," he said.But before going to the classroom, Sheldan has much more basic needs to attend to."Every morning, I have to collect water and wait in line for bread," said Sheldan, whose family has been displaced "10 times" and "no longer have a home". Headmaster Iman al-Hinawi, 50, said the school hopes to provide books and other supplies soon and for free.But she warned that the war has forced Gaza's children to perform "heavy labour" to support their families, especially in cases where the breadwinner has been killed.

## Toddler mauled to death, lioness captured: Forest dept

Minister of State for Forest and Environment Pravin Mali termed the incident "very sad" and said a cheque of Rs 10 lakh would be handed over to the girl's family on Thursday as compensation.

## Despite drug crackdown, Mysuru youth look for 'Mango', 'Kush' hit

In a shocking expose in the Chief Minister Siddaramaiah's hometown, the city's drug menace is spiralling out of control even as police maintain round-the-clock area domination patrolling and heightened surveillance. 'Mysuru Mango', 'Mysuru Kush' -- local slangs given for popular ganja variants available in the city are now openly used among young consumers and peddlers.

A week after Chief Minister Siddaramaiah publicly vowed to make Mysuru a drug-free city, the ground reality paints a grim and disturbing picture. What is even more alarming is the profile of the buyers. Students aged 18 to 20 years are reportedly travelling from Ramanagara, Hassan and even Kerala, specifically to source these Mysuru-branded ganja varieties, who have been detained while purchasing them in the city or consuming them and getting caught during the surveillance.

'We detained two youths from Ramanagara who were just 18 to 19-year-olds and another youth from Hassan who was 19-year-old during patrolling. On suspicion of them consuming ganja, we conducted a test which came positive, following which an FIR was registered," said a police officer attached to Mandi police station who recalled instances reported during night patrolling in the last one week.

Peddlers proudly project Mysuru as a quality hub, attracting young buyers who see these variants as premium products, an indicator of just how dangerously glorified the city's narcotics market has become.


THE GUJARAT High Court has directed the Regional Passport Officer to process the application of an Indian national from Gujarat,

working in Kuwait, whose passport renewal process was put on hold due to an FIR related to rash and negligent driving registered against him in Mahisagar district.

In an oral order on Tuesday, Justice Aniruddha P Mayee directed that the authorities must process the petitioner's renewal application within four weeks, considering the submissions of the petitioner that he "would face forceful deportation and permanent blacklisting which would put his livelihood at stake."

The order of the HC, uploaded Wednesday, states, "In the peculiar facts and circumstances of the present case and considering the nature of offence as mentioned in the FIR, the court is

inclined to direct the respondent to process the The court considered submissions of the passport application... within a period of four weeks on its own merits and in accordance with law in view of the written explanation ...

## MBBS cut-off of 118 for private college against 504 for govt colleges raises concern

Mumbai.(Agency)

As MBBS and BDS admissions have concluded in Maharashtra, the final cut-off score declared by the Maharashtra Common Entrance Test (CET) Cell shows a significant drop compared to last year. Data shows that in the open category, the cut-off score for MBBS in government medical colleges this year is 504 marks, while last year it was above 600 marks. The cut-off score for MBBS in private medical

colleges for the same category dropped sharply. The CET Cell on Wednesday declared the final cut-off scores for MBBS and BDS admissions in Maharashtra at government as well as private medical colleges. While the cut-off score shows a significant drop when compared to last year, when easy paper for National Eligibility cum Entrance Test (NEET) had led to inflation of marks, many have questioned the cut-off score at private medical colleges seen to have dropped below 120 marks. According to candidates and parents, last year the NEET paper was very easy and alleged lenient

evaluation had led to inflation of marks. 'Last year NEET toppers were way higher with as

many as 17 candidates scoring 720 out of 720 marks. Compared to that, the topper this year had scored 686 marks. Considering this



significant drop in scores of candidates, the cutoff scores were expected to be lower this year, which has been witnessed since the first round of MBBS/BDS admissions," said a parent representative. However, many experts have also pointed out the gap of cut-off scores between government and private medical colleges, to raise concerns. Stating that inflation

of marks last year is an analogy best suited for drop in cut-off scores of government medical colleges, an admission counsellor Sachin Bangan highlighted that cut-off score at private medical colleges going below 120 marks raises concerns. "These are final cut-off scores which means those including admissions done at the institutional level rounds at private medical colleges which are infamous for malpractices. If a candidate scoring as low as 118 is able to secure a seat in MBBS at a private medical college in open category; it is definitely a concern," he said.

CAP round for Ayush courses

In a good news for aspirants of Ayush courses -Bachelor of Ayurvedic Medicine and Surgery (BAMS), Bachelor of Homeopathic Medicine and Surgery (BHMS) and Bachelor of Unani Medicine and Surgery (BUMS), the Maharashtra Common Entrance Test (CET) Cell is to hold one more Centralised Admission Process (CAP) round to allow betterment in seats for all candidates of the previous round.

## Live-in relation also attracts laws on marital cruelty: Karnataka HC

BENGALURU. The Karnataka High Court held that the expression "husband" in Section 498A of IPC (cruelty and harassment against a married woman) is not confined to a man in a legally valid marriage alone, but also extends to one who enters into a marital relationship which is valid or voidable, as also to a livein relationship which bears the attributes of marriage, so long as the essential ingredients of cruelty as defined in the said provision are satisfied.

The facts... clearly show that the petitioner and complainant, who is the respondent to the case, lived together in a relationship having all the trappings of a marital union. They cohabited, represented themselves as husband and wife, and performed domestic and social obligations typically associated with marriage.

The relationship thus falls squarely within what has been recognised in recent times as a "relationship in the nature of marriage", or colloquially known as a "Live-In" relationship, attracting the protective umbrella of Section 498A, provided the factual allegations satisfy the elements of "cruelty" as defined in the explanation to the said Section," it observed.

Justice Suraj Govindaraj rejected the contention of the counsel for the petitioner-husband from Shivamogga that the Section cannot be invoked as the requirement is the existence of a legally valid marital relationship between the complainant-wife and the accused.

The petitioner's counsel contended that since the petitioner's marriage with the complainant is void, null, and without legal sanctity, the petitioner cannot be prosecuted under Sect 498A. The petitioner, already married, cannot be regarded as the "husband" of the complainant and no offence under Sec 498A can be made out against him, the counsel argued.

The court said it cannot accept the contention, and cannot permit the accused-petitioner to take advantage of his own wrong, particularly when he acted in bad faith to induce the complainant into a relationship clothed as

## several Mumbai pockets record poor AQI Mumbai. (Agency)

Amid growing concerns of worsening Air Quality Index (AQI) in Mumbai, the Brihanmumbai Municipal Corporation (BMC) are mooting decisions to stop ongoing construction works in some of the nockets in Mumbai November 25, in a meeting chaired by Mumbai's municipal commissioner - Bhushan Gagrani the civic administration had tabled the idea of imposing Graded Action Response Plan (GRAP) measures to mitigate the growing concern of air quality.

The GRAP mechanism is an action response that has been designed by the Commission of Air Quality Management (CAQM). The overall plan is divided into multiple stages which includes stoppage of construction works, banning entry of vehicles inside city limits and limiting vehicular movement.

In the November 25 meeting, it was discussed that if Mumbai continues to record poor AQI readings above

200 for three consecutive days, then the civic authorities may impose the GRAP mechanism. Meanwhile, it has also been discussed that if any particular area continues to record poor AQI relentlessly then local level interventions like stoppage of

the 21 air quality monitoring stations in Mumbai recorded poor AQI. Out of which nine of them recorded moderate AQI, while only one station recorded satisfactory

readings. Mazgaon recorded the worst AQI of 269, followed by 265 at Mulund, 250 at Malad and Borivali, 214 at Powai, 205 at Andheri and 204 at Deonar, among other places. Mumbai's overall AQI stood at 189 - which is regarded as moderate.

Mumbai's AQI has been hovering around the moderate category for the past one month, while several pockets have been recording poor AQI continuously.

For example, Mazgaon has recorded poor AQI for nearly 11 days now, followed by Deonar which has recorded poor AQI in 14 days so far this month and Malad has recorded 12 poor AQI days in 12 days.

# Before dissent, need playfulness in nationalism

Whenever I try to balance between the esoteric and the everyday, my mind tends to go back to the memory of my teacher, Ramchandra Gandhi.

He was a remarkable philosopher, an authority on mathematician and philosopher Alfred North Whitehead. I still remember the way Ramu would come to class and quote Whitehead's lecture at Harvard. Whitehead had apparently once walked into the classroom, banged his head gently, and said, "Gentlemen, I have disturbed the most distant star," referring to the interconnectedness of the cosmos. For Ramu, communication and connectivity were part of everyday life. The way he linked them reminds me of the way he used to talk about nationalism. For Ramchandra Gandhi, nationalism was a filigreed moment-full of nuances, a dissenting imagination that created a pluralistic world.

For him, deep down inside, nationalism was a different way of looking at reality—a dream world that created a sense of alternatives. Within this context, he pointed out that the world of nationalism was not actually an invention of the nation-state. For India, and in fact for many nationalists, the dream of nationalism was a dream of inventing an alternative childhood.

Childhood, in fact, was the focus of many nationalist moments. It's best captured in Rabindranath Tagore's statement: "Every child born today is an indication that god is not yet tired of man." In this sense, Tagore captured the essence of the Indian national movement.

Childhood was a dream of flexibility. Childhood was a dream of freedom. And childhood brought about a sense of playfulness. This sense of play—with the capacity to imagine and inhabit alternatives—is something we have lost today. The dream of playfulness is caught in many ways in how we learn to live with uncertainty and celebrate plurality. It is this sense of play that we have lost in our nationalist movement, which has become more monologic, more uniform. We have created a monopoly of ideas, which now come as dictates rather than dialogues. Playfulness—the politics of play—is something our politics has forgotten. The first thing we have to understand is that the emphasis on the nation-state is misleading. For many nationalists in India—from Tagore to Patrick Geddes to Maria Montessori—it was their childhood that was the basis of the dream world. Childhood, in a way, was an articulation of alternatives. And this is what we must begin by emphasising that the nation-state was not so much a political economy as a pedagogic construct—a new way of understanding reality, teaching it, and communicating it. What marked childhood, and what marked nationalism in particular, was a certain sense of playfulness. This can be brought out by a series of examples.

One of the first things one thinks of is Mahatma Gandhi's own work on the charkha. The charkha, he said, was not just an instrument; it is a weave of playful ideas. In this context, he said the charkha could be used to teach Pythagorean ideas and mathematics—a pedagogic tool, an invention to teach through play. Gandhi emphasised again and again the sense of fun that nationalism and play brought about. I am reminded of the time when industrialist Jamnalal Bajaj gave Gandhi a Ford Motor car. It ran in the ashram for a week or two, then broke down. Gandhi had it pulled by a set of oxen, and playfully introduced it to visitors as "my Ox-Ford". It is this sense of playfulness, this sense of alternatives, this openness to interpretation that made nationalism not only a dissenting imagination, but a dream of alternatives—something we have lost today.

As Ramu pointed out, nationalism was a dream of childhood, a dream of playfulness. And connecting the two was a deep sense of alternatives

## Why EC was born before the Republic

## The real test of reform is simple: Will the voter believe the EC can say 'no' to those in power?

ON Constitution Day, we rightfully celebrate fundamental rights, federalism, secularism and the audacity of universal adult suffrage. Yet one of the most farsighted decisions of the Constituent Assembly rarely receives the attention it deserves. When the Constitution was adopted on November 26, 1949, Articles 324 to 329 creating the Election Commission of India (ECI) were brought into force immediately, two months before the rest of the In TN Seshan (1995), the court held that free and fair Constitution commenced on January 26, 1950. This sequencing was not a technicality; it was a profound constitutional choice. The framers knew that once the Constitution began to operate, India would require a

government elected under its authority. The ECI, thus, had to be constituted before the Republic was born, so that the first government would derive its legitimacy not from an executive, but from a constitutionally independent referee. There was another equally significant concern. In a federal system, it would have been natural to let each state conduct its own Assembly elections, as many federations do. But the framers rejected this model. They feared that state governments might manipulate electoral rolls to exclude "outsiders" those who migrated for work, study or political activity. As several members warned, a state-run system could become a tool for provincialism. A single, independent national authority was, therefore, essential to guarantee that every Indian, wherever he/she lived, would be included on an equal, non-discriminatory roll. Seventy-five years later, the framers' fears are coming true more aggressively than ever, as controversies over residency, migration and deletion of names from voters' lists re-enter national politics.Article 324 grants the ECI

"superintendence, direction and control" over electoral rolls and elections to Parliament and state legislatures, and to the offices of President and Vice-President. Articles 325 and 326 guarantee a single general roll for all citizens and universal adult suffrage without discrimination. These provisions were not inserted as bureaucratic conveniences; they were designed as the Republic's foundational safeguards. Inclusion, fairness and independence were built into the electoral architecture from day one. Over the decades, the Supreme Court has expanded and protected this constitutional vision. In Mohinder Singh Gill (1978), Justice VR Krishna Iyer described Article 324 as a plenary power

enabling the EC to act in "areas left unoccupied by legislation", ensuring the purity of elections. In AC Jose (1984), the court clarified that the commission's powers supplement rather than supplant statutory law, setting a balanced constitutional rhythm: where law is silent, the commission must act; where law speaks, the ECI must

elections are part of the Constitution's basic structure and require an election commission "fully insulated from executive influence." Later decisions such as ADR (2002) and PUCL (2013) reinforced the voter's right to know and



the right to choose NOTA, placing the citizen at the centre of the process. A nuance often missed deserves emphasis. In Subramanian Swamy vs Election Commission of India (2013), the SC recognised the VVPAT paper trail as an "indispensable requirement" for free and fair elections. But the court did not order an immediate nationwide rollout. It commended the commission's initiative, permitted its proposal for a phased introduction and directed the Union government to ensure funds. This reflected the correct constitutional balance: technological transparency combined with respect for institutional judgement.

The ECI's authority is constitutional, but its credibility flows from practice — millions of acts performed by ordinary officials under extraordinary scrutiny. I learned this early. As an IAS probationer, I was posted as the presiding officer of a single polling booth while my colleagues were given supervisory positions.

We sought to make elections more inclusive, transparent and professional. SVEEP, our voter-education programme, treated citizens as partners rather than passive recipients of instructions. National Voters Day, launched in 2011, turned the enrolment of 18-year-olds into a nationwide civic rite. These two reforms have been responsible for record turnouts, the latest being Bihar.

We strengthened expenditure-monitoring, tackled paid news

through MCMC (Media Certification and Monitoring Committee) mechanisms and took actions such as covering publicly funded statutes during elections — not because symbolism mattered more than substance, but because neutrality must be practised, and must be seen to be practised. As India approaches its 18th General Election, the constitutional design faces renewed pressures. Technology must inspire confidence, with EVMs, VVPATs, audits and dashboards working together to assure verifiability. Campaign finance reform must move towards real-time disclosures. Electoral rolls, machine-readable, must maintain a balance: open and accessible for every eligible voter, but protected from manipulation and arbitrary deletion.Procedural independence remains the bedrock. Appointment processes and tenure security are not privileges; they are structural requirements for neutrality. A referee cannot be dependent on the very executive it must regulate. Whatever reform model Parliament adopts, it must meet a single test: Will the average voter believe that the Election Commission can say "no" to

power?Inclusion remains unfinished business. Migrant workers, persons with disabilities, first-time voters, women and the elderly who face mobility barriers must all find the electoral process welcoming. Prisoners who, ironically, can contest, must be allowed to vote. A democracy's legitimacy depends not just on who wins, but on who is allowed in. On this Constitution Day, we must remember why our founders activated Part XV ahead of the Republic. They were ensuring that when the people of India voted for the first time, they would do so under the watch of an institution designed to be independent of the government it would help create. That insight remains as vital today as it was 75 years ago.

## Pollution affects all, redress can't be left to private options

### Zoos need to be open about any disease outbreaks, even small ones, and keep their wildlife health records updated and accessible

Call it the Gurugram model of urban development. In this familiar pattern, the conurbation grows fast, government action on public goods lags, and citizens fend for themselves. If residents were once used to arranging their own power backup, security and even roads, the degraded common resource most metro dwellers are now trying to clean or avoid is the most plentiful of all—air. It is no longer only about masks and indoor purifiers. Portable purifiers and lotions claiming an 'anti-pollution factor' are flying off the shelves—never mind expert advice that these methods are unproven. Even hyperbaric chambers, meant to raise blood oxygen levels for medical purposes, are now marketed as anti-pollution services. None of these innovations make a dent in the public problem. The angst reached such a level this Sunday that when the Delhi Police tried to remove young protestors demanding cleaner air—the second such remonstrance this month some protestors allegedly used pepper spray on the policemen. Twenty-two of them were taken into judicial custody and charged with obstructing police work and



making 'assertions prejudicial to national integration', as some also raised slogans for the killed Maoist leader Madvi Hidma. Even if causes got confusingly coupled in Delhi, the greyness over Bengaluru and Mumbai held steady. In recent weeks, the IT capital—especially the densely populated East Bengaluru—has seen


unprecedented air-quality index levels of 150–170. The commercial capital's air has also stayed far above safe limits. It is no longer just a 'Delhi problem'.

The critical question is: how many Indians can afford these ad hoc personal solutions? And what about the public health burden? The Centre for Research on Energy and Clean Air recently highlighted that young children are the most vulnerable, as they breathe faster and absorb more pollutants. For a fair public discourse, we must first remove the artificial cap of 500 on official AQI counts, as independent monitors often notch far higher. The biggest culprits remain traffic

## Dipping into the new data protection regime



November 14 was an important date in India's digital journey, marking a milestone by bringing to life a comprehensive framework that fundamentally changes how companies handle personal data. One of the major things that changes with the notification of the Digital Personal Data Protection (DPDP) Rules, 2025—at least in theory—is the way an individual's browsing history, e-commerce trail, or social media use can be used by advertisers. We are all used to privacy policies posted on these platforms, though hardly anyone reads them. What's critical for the layman to note is that the DPDP framework transports privacy from a constitutional promise to enforceable rights and duties. The good news is that companies can no longer hide behind impenetrable legal jargon. There has to be a clear and understandable request from the person determining the purpose and means of processing personal data (data fiduciary), for consent from the person whose data is being processed (data principal). The request shall be accompanied by a notice informing the principal of the purpose for processing the personal data, the way the principal can withdraw or modify consent, the grievance mechanism available, and the way complaints can be raised against the data fiduciary. The rules provide timelines for data fiduciaries to maintain records before erasing them from their system. It is also significant to note that the rules apply to processing personal data outside India if it is in connection with offering goods or services within India.

The rules also provide for registration of 'consent managers', entities that play the role of a trusted intermediary between data principals and data fiduciaries, by assisting the data principal to manage their consents through a given platform. Consent managers have certain obligations too, such as implementing reasonable technical and organisational measures to prevent personal data breaches, and

maintaining detailed records of every consent given, denied, or withdrawn, along with related notices and data sharing. Ultimately, the consent must be a clear affirmation of an agreement to process personal data for a specific purpose. This shows a fundamental shift in power by placing the individual—data

principal—at the centre of the framework. The DPDP rules that convert the framework into day-to-day obligations.

The DPDP framework also takes data breaches seriously. The haunting stories of password leaks, personal photos getting exposed, and bank details stolen cannot be dealt with silently by companies accountable for the breach. There is a mandatory requirement for them to report to the Data Protection Board without delay, and the board will thereafter have to take note of the steps taken by the company to remedy the wrong or mitigate the risk. The board is designed to be entirely digital. This means filings, hearings, and decisions are all expected to be done online. Another important point to note (especially if you are a parent) is that your children are protected. Data fiduciaries cannot process your child's data without your verifiable consent. Companies cannot track your child's behaviour or show them targeted advertisements.

?10,000 (for data principals who provide wrong information or impersonate another person through the data they provide) to ?250 crore (for violations of the Act by data fiduciaries). These fines are designed for body corporates to take notice. However, not all body

corporates are treated the same way; the central government's department for promotion of industry and internal trade-recognised startups have lighter compliance mandates. Further, the rules provide softer tools, such as mediation and voluntary undertakings.



The penalties that the Board can impose range from There are also certain legitimate uses that are exempted. For example, in case of a medical emergency that poses a threat to life or immediate health of the data principal, or in taking measures to prevent an epidemic. The central government itself has been given a wide range of exemptions. It can process data for 'security' or 'public

order'. While the government maintains that public interest overrides privacy concerns to the worry of critics, the exemptions granted to them remain a concern, as they reignite the debate over unchecked surveillance and abuse of power. Unlike the General

Data Protection Regulation, 2018, which is the comprehensive data privacy law enacted by the European Union, which demands strict necessity, proportionality, and independent oversight, India's DPDP leaves these boundaries unclear, echoing the longstanding constitutional worries.Importantly, a recent notification states that the law will be rolled out in a staggered manner. While some provisions take effect immediately, the main compliance requirements for companies will take effect after 18 months. While this appears to be extremely practical, the most crucial citizen facing rights, such as informed consent, breach notification, data correction and erasure, and grievance redressal, are deferred for 18 months. The Data Protection Board, scheduled to be set up in the next one year for digitally accessible grievance redress, faces scrutiny for potentially limited independence-appointments and removals are tightly managed by the central government. In any event, the notification of the DPDP marks a

transformative moment and plays a crucial role in India's growing digital economy. Îts success shall inevitably rest on the shoulders of the citizens, corporates and the regulators in creating an ecosystem that is both secure and inclusive.

## UP: Two arrested in Rs 100 cr MBBS admission scam

## Lucknow . (Agency)

Lucknow Police on Wednesday arrested two men who allegedly cheated students and their families of nearly Rs 100 crore by promising guaranteed MBBS admissions in private medical colleges.

The accused — Prem Prakash Vidvarthi (35). alias Abhinav Sharma, from Aurangabad (Bihar), and Santosh Kumar (34) from Samastipur (Bihar) — created a fake consultancy network that targeted NEET aspirants with low ranks.

According to DCP Crime Kamlesh Dixit, the duo was arrested near Kathauta Lake in Chinhat. One of the accused is a B.Tech graduate, while the other has studied up to Class 12. Both were active on a dating app named "Tango," from where they collected phone numbers of young women. These women were then manipulated into working as telecallers for their scam.

The accused had allegedly purchased student data from private cyber companies. The telecallers contacted NEET aspirants and their parents, offering them admissions in reputed private medical colleges. After gaining their trust, the victims were called to consultancy offices set up by the accused. Once a scam operation was completed in one state, the duo shut the office and shifted to another state to start afresh.

## **Opposition** accuses HP govt of evading PRI and urban local body elections

Sharma argued that the government's justification of disaster conditions for postponing elections was flawed. Schools and anganwadis were functioning normally, and children were attending classes, he stated, questioning why their parents could not step out to vote.

He also criticised the government for citing road closures as a reason for the delay, calling it an admission of administrative failure. People have voted even in the past when roads did not exist, he said, urging the government not to deprive citizens of their constitutional rights by giving

Accusing the government of misplaced priorities, Sharma said the worst-hit region during the recent disaster was Mandi, yet the government chose the same district to present events marking three years in office.

# Supreme Court orders full scrutiny of private universities across India

►The Supreme Court has directed the Centre, States, UTs and the UGC to submit personally affirmed affidavits revealing the origins, governance models, finances and regulatory compliance of private, nongovernment and deemed universities. The order has expanded a student's grievance into a nationwide review of how India's private higher education sector has been

functioning.

The Supreme Court has widened a student's personal grievance into one of the most The matter arose from a petition filed by a extensive examinations of India's private higher education sector. According to a Live Law report, the Court has asked the Centre, all States and Union Territories, and the University Grants Commission (UGC) to file individually affirmed affidavits giving a complete account of how private, nongovernment and deemed universities in India were formed, how they are governed and what benefits they have received since their The Court had earlier directed the

The court's intervention has turned what began as an individual plea into a moment of rare scrutiny for a sector that touches millions of students and parents. It has raised questions long whispered but rarely answered: who establishes these universities, how they acquire land and permissions, what rules guide their daily operations and where the money paid by students ultimately goes.

Congress leader Kumar Ketkar on Wednesday alleged that the Central Intelligence Agency (CIA) and Israel's Mossad played a role in the party's defeat in the 2014 Lok Sabha elections.

Speaking at a Congress-organised Constitution Day event, the former Rajya Sabha MP noted that the party had won 145 seats in 2004 and increased its tally to 206 in 2009. Had this upward trend continued, he said, the Congress might have secured around 250 seats and retained power.

The party won 145 seats in the 2004 Lok Sabha polls and 206 in the general election five years later. Had this trend continued, the Congress could have won 250 seats and retained power convincingly. However, in 2014, the number of seats bagged by the party fell to 44," he said.

Ketkar claimed that "a game" had begun ahead of the 2014 polls, asserting that certain organisations were determined to ensure the Congress's seat count did not rise from its 2009 level.

He alleged that the CIA and Mossad had decided to influence developments in India, believing they would be unable to pursue their interests if a stable Congress or Congress-led coalition returned to power.According to Ketkar, these agencies had compiled extensive data on states and constituencies and preferred a majority government in New Delhi, but not one led by the

If a stable Congress government or a Congress-led alliance government came back to power again, they would not have been able to interfere in India and implement their policies," he alleged.

He acknowledged there was dissatisfaction with then Prime Minister Manmohan Singh in 2014 but argued that it was not severe enough to explain the drop from 206 to 44 seats. The reduced tally also left the Congress without the numbers required to claim the Leader of the Opposition post."This was not the mandate of the people," he asserted. ## "Judiciary Has No Magic Wand To Solve Delhi Pollution **Problem": Top Court**

The Supreme Court remarked on Thursday that it has no magic wand to solve the pollution problem in the Delhi-NCR (National Capital Region). A bench comprising CJI (Chief Justice of India) Surya Kant and Justice Joymala Bagchi was hearing a request for an urgent hearing by the court-appointed lawyer, Senior Advocate Aparajita Singh, in the Delhi air pollution matter.

The bench said that all reasons for the worsening air quality should be identified. "We are also residents of Delhi-NCR; we also face this hazard (bad air quality), but we must acknowledge that there is no one reason for this problem," the bench said."What magic wand

(Agency) Former India captain Kris Srikkanth echoed the disappointment of millions of Indian cricket fans after the home side were whitewashed by South Africa in Guwahati on Wednesday, November 26. A team that once obliterated touring sides and built a fortress envied across the cricketing world has now lost five of its last seven Tests at home.On Wednesday, India barely put up a fight. South Africa sealed a 408run win, handing India their heaviest defeat in Test cricket in terms of runs. The decimation was complete. India floundered on a spicy pitch in the first Test in Kolkata. When the conditions eased in Guwahati, India were expected to compete, but were instead overpowered again. After posting 489 in the first innings, South Africa bowled India out for 201. And when the pitch began assisting spin in the second innings, the Proteas showed composure to reach 260 for 5 before declaring. India, in response, could not survive even two full sessions. If you grew up watching India morph from a vulnerable, occasionally brilliant side into a ruthless home juggernaut, the journey felt personal. England's 2012 ambush stung, but India's response — an era of dominance rarely seen in Test cricket — felt inevitable.

Sourav Ganguly challenged the world order. MS Dhoni turned resistance into routine. Virat Kohli pushed the ceiling so high that the rest of the world could only look up. Over 21 years, India lost just 13 of 102 home Tests. Under Kohli? Only two defeats across 32 matches — a statistic that reads like a dare.So when Temba Bavuma, smiling in disbelief, said on Wednesday, "Coming here, I would have never thought 2–0 would be the result at the end of the series," it carried a weight far beyond polite victory pride. South

## Whirlpool India sees historic volume spike, but shares sink over 10% on

Whirlpool of India Ltd shares delivered one of the most dramatic stock-specific moves on Thursday, 27 November 2025, but the direction was sharply negative rather than a rally. Trading activity in the stock exploded, with nearly 164.33 lakh shares changing hands on the BSE by mid-morning, a staggering multiple compared with its typical turnover for the preceding fortnight. This surge pushed the counter to roughly 1,549 times its average two-week trading volume, signaling intense market interest and heavy institutional participation.

The stock's price, however, was crushed under the weight of sudden supply. Shares tumbled as much as 13.2 percent during the session, sliding to intraday lows a little above Rs 1,040 on the BSE before stabilising marginally. The trigger for the slump was widespread reporting of a large promoter-linked block sale. At 12.40 PM, the share price almost stabilised at Rs 1074, down 10.57 percent.

Market reports pointed to Whirlpool Mauritius, an affiliate of the global parent, as the likely seller in a discounted block deal that ranged in estimates from 7.5 percent to 11.8 percent of total equity. One account suggested about 1.5 crore shares, representing 11.8 percent ownership, were transacted, while another pegged the sale at roughly 95 lakh shares with a floor price of Rs 1,030—about 14 percent below the market rate at the time. The potential deal size was estimated close to Rs 965 crore. This heavy offering overwhelmed demand and ignited a wave of investor exits, including among retail holders who grew uneasy seeing the parentlinked promoter monetise a significant stake at a discount. Whirlpool India's recent financial performance set the stage for heightened sensitivity to negative catalysts. In the September quarter, the company reported a 21.9 percent year-on-year decline in consolidated net profit to Rs 41.80 crore, and a 3.8 percent fall in revenue from operations to Rs 1,647.27 crore. Operating profitability contracted further, as EBITDA dropped steeply and margins compressed, reflecting a mix of soft demand in consumer durables and sustained competitive pricing pressure across key appliance categories. While the broader market closed the day on firm footing, supported by positive global cues and renewed optimism around possible rate easing, Whirlpool India moved decisively out of sync. Index momentum failed to provide any cushion to the stock because the scale of the block trades abruptly altered the balance of supply and demand. The episode illustrated that even when markets are buoyant, investor confidence can fracture quickly if a highprofile shareholder introduces large discounted supply against a backdrop of earnings pressure.

## Nifty hits record high after 14 months; Sensex nears alltime peak

# Govt to relax quality control norms for footwear, electronics components

The government is planning to relax Quality Control Order (QCO) norms for footwear and electronics components manufacturing to boost domestic production and exports. According to industry sources, a high-level committee, constituted by the Cabinet Secretariat, has

either fully revoked or deferred by one to two years. The committee has been set up to remove regulatory barriers and establish a 'modern, flexible, and trustbased framework for non-financial sectors regulation'. At present, there are 191 QCOs covering 773 products, ranging from furniture and footwear to door hinges, steel, textiles, petrochemical products, and engineering goods, with several more under consideration. The government has already revoked QCOs on synthetic fibres, yarns, plastics and polymers, and base metals. It is also considering suspending the implementation of certain QCOs in steel product categories, except those covering construction materials, pressure vessels, and pipes. The government also plans to revoke the Steel Monitoring System and the No-Objection Certificate (NOC) requirement for the import of non-QCO steel grades. "The QCO measures have been relaxed for the

The QCOs are government regulations mandating that certain products meet specific Indian Standards before they can be manufactured, sold, or imported. Their key objectives include preventing the

import of substandard goods, ensuring consumer access to quality products, and enhancing the global competitiveness of Indian manufacturers. The committee recommended that QCOs for footwear components— such as PVC and rubber—be completely withdrawn. For copper wires used in general engineering applications, the committee has recommended revoking the proposed QCO or deferring its implementation by two years. It has also suggested revoking QCOs for wrought aluminium and aluminium alloys, and pressure-sensitive adhesive tapes. Products proposed to be referred to the IMG (Inter-Ministerial Group) for further review include crossrecessed screws and various furniture and fittings, for which the committee has recommended deferring implementation by one year. The committee has also suggested postponing QCO implementation by one year for household, commercial, and similar electrical appliances.

## RBI plans to update credit scores every 7 days: What is means for borrowers

New Delhi.(Agency)

From April 2026, borrowers may no longer have to wait weeks to see their credit scores move. The Reserve Bank of India (RBI) has proposed a major change that could make credit reports more up to date and far more responsive to a person's recent financial behaviour.

The draft rules suggest that credit scores will now be refreshed every seven days instead of the current twice-a-month cycle.

WHAT HAS THE RBI PROPOSED?

The RBI's draft "Credit Information Reporting (1st Amendment) Directions, 2025" aims to overhaul the way credit data is reported and updated. Under the proposal, all Credit Information Companies (CICs) will update borrower data five times a month—on the 7th, 14th, 21st, 28th, and the last day of each month.Banks and NBFCs will continue to send a full set of credit records once a month. But between these full updates, they must report incremental changes, such as new loans or cards issued, closed accounts, repayment updates, any change in borrower details and any change in loan classification, etc.CICs can also update even more frequently if they and lenders mutually agree.

#### HOW WILL THE WEEKLY UPDATE **SYSTEM WORK?**

Every month, banks will submit the full list of borrower accounts by the third day of the next month. For the weekly cut-off dates, they will only send updates that reflect new activities. This means if someone closes a credit card, pays off a loan, or improves their repayment track record, the change may reflect in their credit report within days. The RBI has also added an accountability clause: if a bank does not submit data on time, the CIC must flag the delay on the RBI's DAKSH portal during its half-yearly review.

A near-real-time update system could benefit borrowers in several ways. Faster improvement in credit scores: If someone clears outstanding dues or removes an error, the positive change will show much sooner.Quicker loan approvals: Applicants may no longer be stuck waiting for fortnightly updates before applying.

Better credit card eligibility: Banks will have more accurate data when assessing new card requests. Fairer interest rates: As more banks link loan pricing to credit scores, borrowers with improved

behaviour may get lower rates sooner. Shorter recovery time for those rebuilding credit: Weekly updates can reduce the waiting period for people trying to repair past defaults.

# PSU bank mergers: Do bigger banks mean happier employees

New Delhi.(Agency)

The consolidation of India's Public Sector Banks (PSBs) is once again on the policy radar, with speculation about a second round of mergers that could reduce their number from the current 12 to perhaps half that figure. The government's stated aim is to create stronger, globally competitive banks capable of supporting India's \$5-trillion economy. While size and scale undoubtedly matter in the global financial order, the real strength of a bank ultimately lies in its people. Employee morale, motivation, and cultural integration are as vital as capital adequacy and technology upgrades in ensuring that merged entities truly succeed.

**HISTORY OF MERGERS** 

India's tryst with PSB consolidation dates back more than three decades. The first post-nationalisation merger took place in 1993, when Punjab National Bank (PNB) absorbed the New Bank of India—a move aimed at rescuing the latter from mounting losses. What appeared to be a RECENT CONSOLIDATION soon turned into a prolonged episode of organisational turbulence. Employees of the erstwhile New Bank, which had a strong union and close ties with its management, struggled to adjust to the

new environment. Differences in work culture, privileges, and perceived loss of influence created deep resentment.Litigation followed, industrial peace was disturbed, and the combined bank struggled for years to regain normalcy. For nearly three years, no internal promotions took place. The episode became a cautionary tale of how mishandled human integration can undermine even a well-intentioned merger. For almost two decades thereafter, no major PSB merger occurred. But in the 2000s, the State Bank of India (SBI) took the lead, gradually absorbing its associate banks. While the move created a banking powerhouse with global scale, employee integration proved far more difficult.

Even after a decade, many staff members of the erstwhile associate banks continue to feel undervalued within the larger structure. The lesson was clear: a legal merger is not the same as an emotional merger.

straightforward administrative action The 2019-20 consolidation drive was the boldest so far, reducing the number of PSBs from 21 to 12 and creating fewer but much larger entities with pan-India presence. Balance-sheet size, capital strength, and operational efficiency



improved measurably. However, frictions soon surfaced beneath the statistics. In one of the recent North-India mergers, the smaller bank, anticipating the merger, had promoted an unusually high number of officers, creating a cadre of relatively young executives holding senior designations. After the merger, this disparity caused heartburn within the parent bank, whose officers saw their own career prospects curtailed by the influx of "younger seniors."

WHY SCALE STILL MATTERS

Despite these challenges, the logic for consolidation remains compelling. Larger banks enjoy economies of scale, stronger capital buffers, and wider geographic reach. They can fund big infrastructure projects, invest in digital transformation, and compete with private and global peers.For policymakers and regulators, having a few well-capitalised PSBs is

easier to supervise and recapitalise than managing dozens of small, unevenly governed entities. Globally too, banking systems in countries such as China, Japan, and South Korea are dominated by a handful of mega banks that drive growth and innovation.

#### THE HUMAN SIDE OF INTERGRATION

Every merger involves more than the blending of balance sheets—it is a fusion of cultures, histories, and aspirations. Common issues that have surfaced across PSB mergers include:Disparities in promotion and posting policies leading to perceptions of injustice; Differences in work culture and discipline btween regional and national entities; Technological mismatches in IT systems and business processes;Lingering legacy loyalties delaying the formation of a unified identity. It is also a fact that PSBs do not follow a uniform grooming and promotion policy. Smaller banks often promote officers faster, sometimes to higher grades. At one point, the erstwhile Corporation Bank and Allahabad Bank had among the highest numbers of wholetime directors in the industry—a reminder of how uneven HR structures can complicate integration.


### Palash Muchhal's Cousin Defends Him

Many domestic airlines connect the city to all the major cities of India including Jaipur, Mumbai, Delhi, Mumbai and Kolkata. Regular air services are available for Delhi and Mumbai too.

Udaipur Railway Station is located at a comfortable distance from the city of Udaipur. Rajasthan Railways connects Udaipur station with all the other cities of Rajasthan as well as India. There are frequent trains which run to and from Udaipur connecting Jaipur, Mumbai and

By road

The city lies on the Golden Quadrilateral National Highway (NH) 8, midway between Delhi and Mumbai, located around 700 kilometers from either city. The East West Corridor which starts from Porbandar and ends at Silchar passes and is intersecting the Golden Quadrilateral and shares the common space from Udaipur to Chittor. The roads in this part of the country are paved and fit for private vehicles. One can either drive from Jaipur (around 6 hours via Chittorgarh), from Kota (3 hours - four lane highway) or Surat (9 hours), or take a Rajasthan State Road Transport Corporation (RSRTC) bus from Bikaner House, India Gate in Delhi.
