Bhagwant Mann's Vision Turning Punjab into "Rangla Punjab": A State in Full Flight

New Delhi 1st December: Since taking oath as Chief Minister of Punjab, Bhagwant Mann has embarked on a resolute mission to transform Punjab: socially, economically, culturally and infrastructurally. Under his leadership, the state is witnessing a flurry of welfare schemes, development drives, and reforms aimed at uplifting the common people — especially the marginalized, farmers, workers, women, the elderly, and youth.

One of the headline achievements of Mann's government is the launch of Mukh Mantri Sehat Yojana (MMSY), a universal health-cover scheme offering ₹10 lakh annual cashless treatment per family, irrespective of income. The scheme, covering all families in Punjab, provides access to both government and empanelled private hospitals.

Under social security measures, the state has directed significant funds toward support for widows, destitute

women, elderly persons and other vulnerable groups so that social welfare becomes not charity, but a right. Through the Ashirwad Scheme, the government is offering financial assistance (₹51,000) for marriages of girls from low-income families belonging to SC, backward or economically weaker sections — a step to ease financial burdens on poor families and promote social dignity. These measures reflect Mann's promise that "Punjab belongs to Punjabis" — ensuring that no honest citizen is left behind, and that welfare is inclusive, transparent, and respectful.

Understanding that welfare must be matched by infrastructure and development, the Mann government has launched Rangla Punjab Scheme — a sweeping development programme under which each assembly constituency is allocated funds for local infrastructure, roads, community projects, and more. On November 27, 2025, the first instalment of ₹213 crore was released (out of a total ₹585 crore



earmarked for the year), aimed at ensuring no village, town or city is left behind. Officials say funds will go to panchayats, zila parishads and urban bodies kickstarting projects that were long overdue. According to statements, the state is also pushing to improve roads: reports mention tens of thousands of kilometres of road network upgrades under government planning. Moreover, under Mann's leadership, the government has pledged major works for grassroots including rural



upliftment, urban infrastructure, connectivity and local development with committees of MLAs and officials monitoring the work to ensure transparency and accountability. Bhagwant Mann's government is also pushing for economic revival across sectors. Through support for small industries and agro-enterprises, efforts are ongoing to encourage entrepreneurship and generate jobs, particularly for labourers and daily-



wage workers. The government under Mann aims to build a robust industrial and investment-friendly environment with announcements of policy support, incentives, and infrastructure that benefit both farmers and industrial entrepreneurs. There are early signs of efforts to modernize agriculture infrastructure and help farming communities join

the path of organised agro-industry in line with national schemes but with state-level facilitation. These moves aim not only to uplift rural Punjab, but also to curb the persistent agrarian distress by providing alternate livelihoods and better income avenues beyond traditional agriculture. Understanding that Punjab's future lies with its youth, Mann's administration is said to be planning as per internal announcements the development of multiple sports stadiums, youth-oriented infrastructure, and community facilities.

According to government sources, thousands of stadiums are to be built across rural and urban constituencies under the Rangla Punjab plan.

Such investments aim to give Punjabi youth a platform to excel be it in sports, arts or community development rather than being drawn to drugs, despair or migration. The larger narrative under Mann's vision is: build hope, build future, build Punjab as a land of opportunity.

E Shinde's 'Coalition Dharma' Note As 'Poaching Row' Rocks BJP-Led Mahayuti

The violation of a 'non-poaching' pact between the BJP and its ally, the Shiv Sena, in Maharashtra has ramped up tension in the ruling Mahayuti alliance as it preps for the Mumbai civic election, a battle for the world's richest municipal corporation. Alliance leaders Devendra Fadnis and Eknath Shinde tried to play down talk of a rift.

Asked if he deliberately avoided meeting Shinde last week - at a hotel while both were on the campaign trail - Fadnis laughed and said, "I came in late at night and had to leave before him... my meetings are scheduled earlier than his. So, we did

not meet. But we will. What is the big deal? We're both busy campaigning now but we talk on the phone every day..."

Shinde - who led a 2022 rebellion, allegedly orchestrated by the BJP, which broke the then-undivided Sena and helped the BJP reclaim power - offered similarly reassuring comments. "I don't take such comments seriously. From the day I became Chief Minister I have seen and heard many such accusations. Instead of getting caught in that, I focus on my work." "This alliance was not formed yesterday or today.

This alliance is built on a shared ideology and common principles,"



he said, referring to Bal Thackeray, Atal Bihari Vajpayee, and LK Advani. But one comment - "we

fully follow principles of coalition dharma... our alliance partners should also follow" - has raised eyebrows, suggesting all is not well within the partnership.

And a comment by Manikrao Kokate from the Ajit Pawar-led Nationalist Congress Party, the third member of the Mahayuti, has added to that unsettled feeling. "The BJP appears completely divided... it no longer has anything of its own. Their entire life revolves around manipulation, splitting here and there," he said. "And their old workers are all at home."

Lalu, RJD run in circles after 10 Circular Road eviction notice

Patna's 10 Circular Road, probably the city's hottest real estate address after CM Nitish Kumar's 1 Aney Marg, has housed the RJD first family for two decades. But after the NDA swept the Assembly polls in Bihar, former CM and the Leader of Opposition in the state Council, Rabri Devi, has been allotted a new bungalow at 39 Hardinge Road, barely a kilometre away and closer to her workplace.

Just the mention of the RJD first couple having to shift out of the 10 Circular Road bungalow, which is considered the party's power centre, has sparked consternation among its leaders, triggered a controversy and sparked a house hunt.

The RJD family has shown clear reluctance to move out. And even as the political back-and-

forth played out, reports surfaced that Lalu Prasad Yadav had visited a sprawling under-construction

mansion "grander than Golghar", Patna's iconic 18th-century granary.



mansion in Patna's Danapur.

The visit triggered a political storm, with the JD(U) questioning the source of funds and its spokesperson Neeraj Kumar dubbing the

The Bihar Building Construction Department, after the new NDA government took oath, issued a notice to former CM Rabri Devi, directing her to shift to 39 Hardinge Road. The 10 Circular Road bungalow was allotted to Rabri Devi in 2006 after she vacated the CM's residence.

Since then, the Lalu family has lived at 10 Circular Road continuously, irrespective of Rabri Devi's political role. Now, the eviction notice has effectively left Rabri Devi with no option but to vacate 10 Circular Road. The move hasn't gone down well with the RJD. The Yadav family may be maintaining silence, but party leaders are in full attack mode on the NDA government.

Mallikarjun Kharge vs Kiren Rijiju in Rajya Sabha over Jagdeep Dhankhar's exit

Congress President Mallikarjun Kharge on Monday welcomed Vice President CP Radhakrishnan as the new Rajya Sabha Chairman, but mentioned the "unexpected exit" of former Vice President Jagdeep Dhankhar, who resigned on health grounds in July. Kharge's remarks drew a fiery response from Parliamentary Affairs Minister Kiren Rijiju, who flagged the "unkind words" used by the Opposition on Dhankhar in the past. Kharge, the Leader of Opposition in Rajya Sabha, delivered his customary remarks, welcoming Radhakrishnan as the new Chair, but said that the House did not get an opportunity to hold a grand farewell ceremony for Dhankhar. "...I hope you will not mind that I am constrained to refer to your

predecessor's completely unexpected and sudden exit from the office of the Rajya Sabha Chairman, which is unprecedented in the annals of parliamentary history. The Chairman, being the custodian of the entire House, belongs as much to the opposition as to the government," Kharge said.

"I was disheartened that the House did not get an opportunity to bid him a farewell. Regardless, wish him, on behalf of the entire opposition, a very healthy life," the Congress President said, drawing sloganeering from the BJP members.

Hitting back at Kharge, BJP leader and Parliamentary Affairs Minister Kiren Rijiju questioned the former's need to raise Dhankhar's resignation on a "solemn

occasion". He then attacked the Opposition for using "unkind words" on Dhankhar in the



past. "Why did the Leader of the Opposition refer to a case that was not necessary to raise at this point? I want to remind the House of the

language used to insult the former Vice President. The unkind words that you used against the former Vice Chairman and the removal motion that you served, a copy of which we still have, we have not forgotten," Rijiju said as Opposition benches started to protest. Appealing to Kharge and the Opposition members to refrain from talking about Dhankhar's resignation, Rijiju said, "Just think how much you have tarnished the dignity of the Chair. We should respect everyone in a democracy. This is unfortunate." During his address, Kharge reminded Radhakrishnan of his past association with the Congress and urged him to remain impartial, warning that any tilt towards the BJP could be "dangerous."

Sloganeering broke out in the Rajya Sabha after Congress President Mallikarjun Kharge mentioned the "unexpected exit" of former Vice President Jagdeep Dhankhar earlier this year, drawing a retort from Parliamentary Affairs Minister Kiren Rijiju.

59-lakh salary scam in Nuh school leads to FIR against DDO

An FIR has been lodged against a former drawing and disbursing officer (DDO) and a messenger at a govt school in Nuh district after a former teacher discovered that over Rs 59 lakh was siphoned off using employees' unique codes.The mathematics teacher — who was transferred eight years ago — has alleged that "sizeable amounts were withdrawn in his name, without his knowledge".Following directions from the SP office, Bichhor police registered the FIR on Nov 28, naming former DDO Mohammad Ali and school messenger Wahid Ahmad as accused.The complainant, Hamid Husain, alleged the fraud began while he was posted at Government Senior Secondary School, Singar, Punhana, between 2009 and Sept 2017.

Hussain alleged the duo used similar tactics to tamper with the unique codes and financial details of multiple employees, siphoning off a total amount exceeding Rs 59,28,224. Husain said he filed complaints in July 2018 to the principal, BEO, DEO and the education directorate in Panchkula, but action was initiated only after the SP office intervened.

Horticulture waste, blocked drains, illegal vendors: What ails Noida’s Alpha 1

Residents of Alpha 1 in Greater Noida have raised concerns over the neglect of horticulture and sanitation works in the area. They alleged waste from pruned trees have been lying for 10 days, and also complained about sewer and sanitation problems, security concerns, and unauthorised street vendors. The sector RWA has written to the CEO of Greater Noida Authority, highlighting these unresolved issues.

Sher Singh Bhati, RWA president of Alpha 1, said that the horticulture department began pruning the trees approximately 10 days ago. However, the remains of dry leaves and branch cuttings remain uncollected, creating an unsightly and hazardous environment. The contractor responsible for these tasks has left the job incomplete due to the expiration of his contract six months ago, Bhati claimed, adding, "The parks are in poor condition, water is not being supplied, and trees and plants have dried up."He demanded immediate action in the absence of a response from officials.Additionally, residents expressed dissatisfaction with sanitation services in the sector.Gajendra Dutt Sharma, a resident, pointed out that the cleanliness of certain areas, specifically around house A-201, has not been maintained. "Cleaning should be done regularly, which was skipped even on holidays like Diwali," he said, adding that cleaning had become sporadic and inadequate.

Key Gurgaon roads turn dust bowls, 20 teams to conduct inspections

Haryana Pollution Control Board (HPCB) on Sunday deployed 20 teams across the city for a full-day sector-by-sector dust inspection. Seventy officers from across Haryana have been assigned zones covering all major sectors.This comes after Commission for Air Quality Management (CAQM) asked HPCB for an immediate field audit after widespread deposits were found along key stretches this week.Each team must document dust loads, construction debris, untreated patches and roadside dumping and send photo and video reports to the board by Dec 1. CAQM wants a clear, ground-level picture of how dust-control norms are actually being enforced — regular sprinkling, covering loose soil, managing construction material and prompt debris removal.A letter from HSPCB member secretary Pradeep Kumar said, "Teams have been allowed to hire taxis or jeeps if official vehicles aren't available, suggesting the inspection will run across multiple hours and dispersed sites. The

board will compile the zone-wise findings in a day and submit them to the CAQM for further action."An official who is part of the inspection said, "Fresh checks flagged excessive dust on arterial roads, including stretches where construction work and soil movement have been frequent."These dust-covered roads are what set off the CAQM order for a rapid assessment.

Road dust remains one of Gurgaon's most stubborn pollution sources, often pushing up PM10 levels even on days when other sectors show improvement.The HSPCB's deployment plan divides the city into 20 zones. Sectors 3 to 10 will be covered by a team from Karnal. Sectors 11 to 23 have officers from Faridabad and Bhiwani.The central belt from Sectors 31 to 70 has teams from Mahendragarh, Rewari, Rohtak and Sonapat.Outer sectors and the IMT-Manesar cluster will be inspected by officers from Ballabgarh, Nuh, Kaithal,



Hisar, and Gurugram (North and South). Winter's stagnant conditions make unmanaged dust far more visible and harmful and Gurgaon has been stuck in the very poor bracket for much of the week.TOI reported several times that Gurgaon is mostly covered with a cloud of dust and the phenomenon is exacerbated by the low-lying soil and the strong wind effect in the Indo-Gangetic plain.The problem is compounded by dry winters and summers. Also, the re-suspension of road dust because of

vehicular traffic is of particular concern as unpaved roads were cratered and cracked at certain points but still saw heavy traffic during peak hours, with thousands of cars and bikes kicking up a dust storm.Though it has been recommended to use dust suppressants to mitigate pollution from dust, the civic authorities like GMDA and MCG hardly use any such spray on roads; it keeps the dust down for longer. Also, the majority of Gurgaon is still under manual sweeping, and as a result, the dust does not get disseminated from the area.Most areas are either missing green belts or there are hardly any trees on the side of the roads. Every year, the city gets an urban target of plantation, but hardly any drive is carried out in the city.

For instance, last year GMDA had a target of 1,050,000 saplings, of which it has so far planted 167,000. This means just 16% of its target has been achieved. Similarly, MCG had a target of 525,000 saplings, out of which it has achieved 12%.

PC Meena returns as GMDA CEO in Haryana bureaucratic reshuffle

Haryana govt on Sunday appointed 2004-batch IAS officer PC Meena as the new GMDA CEO. His appointment, after a month-long uncertainty, came as part of the latest bureaucratic reshuffle in which 20 IAS officers were transferred.This will be Meena's second stint as the GMDA CEO. He earlier served as the authority's CEO between April 2023 and Jan 2024.

The govt has assigned him the post in addition to his current responsibilities as commissioner & secretary to the govt in the human resources department and the general administration depasrtment.

The appointment brings closure to the top-level paralysis that had left the authority without an administrative head — the first such instance since GMDA was formed in 2017.Meena's return is significant not only because of the ongoing infrastructure work across the

city but also because he is a familiar name in Gurgaon's administrative circle.

Over the past decade, he held some of the most critical positions in the city — deputy commissioner in 2011, MCG commissioner in 2013 and again in 2023, HUDA (now HSVP) administrator in 2014 and managing director of DHBVN in 2021 and again in 2024.

His experience with multiple agencies that now interface with GMDA is likely to streamline inter-departmental decision-making.Several names, including Yashpal Yadav, Shekhar Vidyarthi and A Sreenivas, were doing rounds for the post of GMDA CEO.With Meena finally stepping in to lead GMDA, it is expected that pending clearances, inter-agency coordination and project monitoring will gain pace.The CEO post at GMDA remained in limbo since Oct 28, when 2006-batch IAS officer J Ganesan was

appointed but he never assumed charge.On Nov 18, the govt assigned MCG commissioner Pradeep Dahiya additional responsibility as GMDA chief, but he also did not take over due to procedural gaps.TOI reported last Thursday that the metropolitan authority had been functioning without a CEO for the first time this long, raising concerns over key projects and approvals already moving at a sluggish pace.

Pradeep Singh appointed MCM chief

The latest reshuffle also led to two other key changes affecting the city. Pradeep Singh, a 2020-batch IAS officer, has been appointed the MCM commissioner, replacing Ayush Sinha, who has been transferred as deputy commissioner of Faridabad. Meanwhile, 2014-batch IAS officer Vikram, previously deputy commissioner of Faridabad, has been posted as managing director of DHBVN.

Gurgaon Sector 40 residents seek urgent repairs of damaged roads

Internal roads in Sector 40 have become difficult to use for both motorists and pedestrians. The 18-metre-wide main road, about 1km long, which links the sector's main market to the Sector 45 junction, along with the adjoining internal lanes, is marked by potholes, uneven surfaces and loose gravel.Residents said the roads were built around eight years ago and have steadily deteriorated since then. Patch repairs carried out over the years have not improved the situation, as the work was done unevenly and the surface

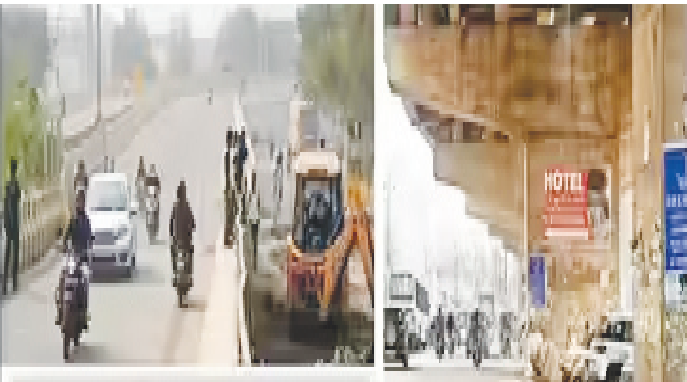
remains unsafe.Despite sending written complaints and making several phone calls to MCG, residents say there has been no substantial response. "We have raised grievances many times, but we only receive acknowledgements. Patch repairs have made the road more uneven. The absence of stormwater drains is also weakening the surface and reducing its life," said Abhimanyu Yadav, RWA president of Sector 40.Moreover, the damaged surface has added to dust pollution in the neighbourhood. Passing vehicles kick up clouds of loose soil into

the air, forcing local residents to keep doors and windows shut for most of the day.Motorists using the stretch daily face delays, with two-wheeler riders slowing down frequently to avoid deeper patches. Pedestrians are also affected, as broken edges on both sides of the road make walking unsafe.Residents have now demanded immediate recarpeting of the entire stretch, saying the current condition poses a daily hazard. They have also highlighted poor construction of 10m-wide internal roads and the lack of proper monitoring by MCG."It has become unsafe, and we have had to spend our own money to fill potholes. Even newly surfaced lanes are breaking apart. As this is an 18-metre road, it carries heavy traffic. MCG should prioritise its repair along with proper drainage planning," said Yogesh Jain, a resident.raveen Raghav, executive engineer, MCG, said a consultant is being appointed to prepare detailed project reports. "Sector-wise reports will be prepared, and any issues will be addressed once the report is submitted," he said.

Bhangel elevated corridor done, now Noida turns to Dadri road under it

For thousands of commuters in the city, relief is finally in sight. After five years of dodging potholes and enduring daily traffic jams, the battered road under the newly opened Bhangel elevated corridor is set to be rebuilt — this time by Noida Authority itself.The move comes after a prolonged standoff with the project's construction agency, UP State Bridge Corporation Ltd (UPSBCL), which has refused to take up the work citing unpaid dues of nearly Rs 150 crore.The surface road, stretching 5.5km under the flyover, has been in a state of disrepair since construction began on the elevated corridor. "This road is critical for several sectors along the Bhangel corridor. We have received communication from UPSBCL stating their inability to proceed with it. If they are unwilling, we will seek the Board's approval to execute repair work ourselves," said Authority CEO Lokesh M.The urgency is evident for



anyone who travels through Barola, Bhangel and the surrounding sectors. Years of heavy machinery, diverted traffic and neglect have left the road riddled with potholes and uneven surfaces, making it a daily ordeal for motorists and local residents alike."It's not just an inconvenience, but a safety hazard. School buses and ambulances get stuck in snarls here almost every day," said a resident of Sector 110.The deadlock is mostly because of a financial dispute between

UPSBCL and the Authority. Although the six-lane elevated road was officially handed over in Aug, UPSBCL claimed it is yet to be paid a significant amount, including for price escalation, GST differences and interest on delayed payments. The outstanding amount, according to the corporation, stands at about Rs 150 crore.Despite multiple reminders, the Authority has not cleared these dues, prompting UPSBCL to approach the Allahabad high court last Sept,

seeking the appointment of an arbitrator.As a result, UPSBCL has argued that without any further payment, it cannot be expected to complete ancillary work such as service roads and drainage channels — features vital for smooth traffic flow and flood prevention. The corporation has formally requested either to be released from these obligations or to be sanctioned an additional Rs 25 crore to finish them.Authority officials, however, insisted that UPSBCL must fulfil all aspects of the original contract. "UPSBCL cannot walk away from its contractual responsibilities. Construction of service roads and drains is part of the agreement. They are bound to finish it," said a senior official.

With no resolution in sight, the Authority is now considering taking over the road repairs directly."If we proceed, we will invoke contractual provisions to recover costs from UPSBCL, including seizing their

performance guarantee," said Vijay Rawal, DGM (civil).

New Delhi: The Delhi Police, in collaboration with the Telangana Anti-Narcotics Bureau, claimed to have busted a drug syndicate and arrested 10 peddlers, including three foreign nationals, supplying narcotics through courier service, officials said on Friday. The police also claimed to have recovered narcotics worth Rs 12 crore from their possession. According to the police, the transnational drug cartel run predominantly by African nationals would conceal contraband in the collar of the shirts they couriered. Three months ago, the Telangana Police busted a drug supply module in Hyderabad, uncovering a network that used courier services to transport narcotics, Joint Commissioner of Police (Crime) Surrender Kumar said. "During investigation, it was found that the drugs were being sourced from Delhi and supplied to Telangana. Multiple raids were carried out across Delhi-NCR, leading to the arrest of the 10 accused," Kumar said. Delhi and Telangana Police teams, formed after days of technical and manual surveil-

lance, carried out raids at several locations, including Mehrauli, Sant Garh, Nilothi, Pratap Enclave, Greater Noida, Munirka and Uttam Nagar. During a raid in the Mohan Garden



area, a Ugandan national, Zainab Kyobutungi, alias Pamela (35), was arrested with 195 grams of cocaine, 24 grams of MDMA and Rs 40,500. A case was registered against him under

the Narcotic Drugs and Psychotropic Substances Act, officials said. A Nigerian national, Bekki, alias Bekee (49), was arrested in another raid at Sant Garh in Tilak Nagar. The police

in Chander Vihar with 60 MD pills, the police added. The arrest of Jean Ahmad, alias Godwin, who was wanted by the Telangana Police, led to the recovery of 106.38 grams of cocaine and 107.83 grams of heroin from his locked house. Separate FIRs were registered in connection with these seizures. The joint teams also arrested several Indian nationals who allegedly acted as key facilitators, managing finances, providing SIM cards and supporting logistics for the cartel. Those arrested include Badruddin and his wife, Sama Umar, residents of Greater Noida, and Zafar from Mehrauli, who allegedly handled drug money. Titing Guite, S Joshua Guite and Lal Khosei Selien, residents of Delhi, were arrested for procuring and supplying SIM cards using fraudulent credentials to enable anonymous communication for peddlers, the police said. During the raids, 30 foreign nationals, including 12 women, were found overstaying without valid documents. They were residing in rental accommodations. The men were shifted to deportation facility, while process to shift the women was underway, the officials added.

SCERT launches three-day training for NEP nodal teachers

New Delhi: The State Council of Educational Research and Training (SCERT), Delhi, has announced a three-day training programme for NEP Nodal Teachers from the Directorate of Education (DoE). The initiative aims to strengthen the implementation of the National Education Policy (NEP) 2020 across Delhi government schools. The objective of the programme is to build a comprehensive understanding of the key elements and vision of NEP 2020, particularly in the context of school education. It is designed to equip Nodal Teachers with essential facilitation and pedagogical skills to mentor and train educators across Delhi's government school network. According to a circular issued by SCERT, the training would be conducted from December 3 to December 5, between 10.30 am and 4.30 pm. The programme would run under Cycle I and the list of participating teachers has been made available through an online link. SCERT has directed authorities concerned to ensure mandatory attendance of all nominated participants.

Gurugram police issue over 21,900 fines for riding without helmets

Gurugram: The special campaign, conducted between November 1 and 27, targeted riders flouting helmet regulations. A senior traffic police official emphasised the dangers of riding without a helmet. "Driving a two-wheeler without a helmet significantly increases the risk of severe head injuries in the event of an accident, which could result in brain damage, skull fractures or even death," he said. Under the Motor Vehicles Act, riding without a helmet is a traffic violation, punishable with a Rs 1,000 fine and potential three-month licence suspension. Dr. Rajesh Mohan, DCP (Traffic), said: "The aim of Gurugram police is to prevent road accidents and make our roads safe."

New Delhi: The Supreme Court is slated to hear on Monday a plea related to stubble burning that has been further worsening the air quality levels in Delhi-NCR. The

The court had made it clear that the use of green crackers will be confined to specific hours on Diwali and the day before. The sale of green crackers was permitted from October 18 to 20. It had also made clear that the relaxation was only on a "test case basis and it shall be only for the period specified".

New Delhi: Delhi's groundwater continues to rank among the most contaminated in the country, with the latest annual report of the Central Ground Water Board (CGWB) revealing dangerously high levels of uranium, lead, nitrate, fluoride and salinity-related indicators. Released this month, the report warns that several contaminants exceed national drinking water standards, posing long-term health risks to lakhs of residents who rely on borewells and hand pumps. According to the CGWB, "significant concerns have emerged" following a detailed analysis of samples collected across the Capital. The findings show that Delhi now reports one of the highest proportions of lead-con-

taminated groundwater in India. Lead, a potent neurotoxin, exceeded permissible limits in 9.3 per cent of pre-monsoon samples, far higher than states such as Assam (3.23 per cent) and Rajasthan (2.04 per cent). Even at low levels, lead exposure can impair cognitive development in children, damage kidneys, raise blood pressure and is classified as a probable human carcinogen. Uranium contamination also remains a major concern. Delhi recorded the third highest proportion of uranium-affected samples after Punjab and Haryana, with 13-15 per cent of samples exceeding safe limits. Uranium ingestion is known to cause kidney damage and heights

long-term cancer risk. Beyond heavy metals, nitrate levels in the city's groundwater remain troubling. The CGWB attributed the exceedances primarily to human-driven factors such as agricultural runoff and improper waste disposal. Elevated fluoride concentrations were found to stem largely from natural geological processes, especially in hard rock aquifers where groundwater interacts with minerals in granite and gneiss formations.

Indicators linked to salinity also reflected persistent stress. Electrical conductivity, a measure of dissolved solids, exceeded safe standards in 23.3 per cent of samples. The report further noted that monsoon-related groundwater recharge does not necessarily improve water quality. A Central

Pollution Control Board review of post-monsoon variations found several locations where conditions worsened, owing largely to site-specific factors such as aquifer characteristics and local contamination loads.

Mercedes rams into 3 near mall in Delhi's Vasant Kunj, leaving 1 dead

New Delhi: A 23-year-old man died and two others sustained injuries after a Mercedes SUV (G63) allegedly rammed into them near a mall on Nelson Mandela Marg in Delhi's Vasant Kunj area early Sunday, the police said. The police said the incident took place at 2.33 am when a PCR call regarding the accident was received at Vasant Kunj North police station. "A team reached the spot opposite a mall and found a Mercedes G63 in a mangled condition," Deputy Commissioner of Police (Southwest) Amit Goel in a statement said. According to the police, three men — two aged 23 years, and one 35 — all employees of a restaurant in Ambience Mall, were found injured at the spot. They were immediately shifted to a hospital where Rohit (23), a resident of Chamoli in Uttarakhand, was declared brought dead, while the other two are undergoing treatment. The driver of the vehicle, Shivam (29), a resident of Karol Bagh, has been apprehended. He was returning home after attending a wedding and was accompanied by his wife and elder brother at the time of the crash, read the statement. "Preliminary inquiry suggests that the vehicle lost balance on a road diversion, following which it veered towards an auto stand and hit the three victims who were waiting there for an autorickshaw. The car is registered in the name of Abhishek, a friend of the accused," said the officer. Legal action is being taken and further investigation is under way, the police added.

Four killed, two injured in fire at four-storey building

New Delhi: Four persons, including two women, died while two others suffered injuries after a massive fire broke out at a four-storey building at Block-B, Sangam Vihar, Tigr Extension, here on Saturday evening, officials said. A total of four deaths have been confirmed so far. Two of them have been identified as Anita (38) and Satender (38), while two others are yet to be identified. Flames engulf the building in Tigr Extension, Sangam Vihar, South Delhi, on Saturday. A 40-year-old woman, Mamta, who sustained 25 per cent burn injuries, has been shifted to a hospital. The identity of another injured person is yet to be established, the officials mentioned. A PCR call regarding the blaze was received around 6.24 pm. When the police reached the spot, they found the building engulfed in flames, with the fire believed to have originated from a footwear shop on the ground floor, a police official said. "Two injured women were rescued and rushed to hospital. Satender, alias Jimmy (38), was the owner of the buildings," the police said. "Two charred bodies were found on the ground floor, while two injured persons were rescued from the building and shifted to a hospital before the arrival of the fire engines," the DFS said. Further investigation is on ascertain the exact cause of the fire.

Indonesia floods, landslides leave 303 dead, 279 missing; Sumatra hardest hit

WORLD. (Agency)
A total of 303 people died and 279 remain missing after flash floods and landslides struck three provinces in Indonesia's Sumatra region, the country's National Disaster Management Agency (BNPB) said on Saturday.Heavy monsoon rains have submerged entire communities, forcing tens of thousands to evacuate and leaving residents stranded as access to many areas remains cut off.

BNPB Chief Suharyanto told a press conference that North Sumatra suffered the highest number of casualties, with 166 deaths and 143 people still unaccounted for. In West Sumatra, 90 people were confirmed dead and 85 missing, while in Aceh, 47 fatalities were recorded and 51 people remained missing.He chaired a coordination meeting with BNPB units deployed in the three hardest-hit provinces, emphasising that operations must be intensified as weather conditions in the affected areas



begin to improve.He noted that the agency is prioritising three urgent tasks: conducting search and rescue operations for those still missing, restoring disrupted communication access, and ensuring the swift delivery of logistics to affected residents.

Former Bangladesh PM Khaleda Zia's health condition critical: Senior party leader

DHAKA . (Agency)
The health condition of Bangladesh's critically ill former premier Khaleda Zia is "still unchanged", a senior leader of her party has said.

Zia, the 80-year-old Bangladesh Nationalist Party (BNP) chairperson, was admitted to a private hospital on November 23 when she developed a chest infection that affected both her heart and lungs. Four days later, the three-time prime minister was shifted to the coronary care unit after several of her health complications worsened.

BNP Senior Joint Secretary General Ruhul Kabir Rizvi on Sunday said Zia's physical condition remained unchanged."From the doctors, we heard that her condition has not deteriorated. We also did not get any news that her physical condition has improved much," he was quoted as saying by The Daily Star newspaper.Rizvi said there has not been any advice yet about taking Zia abroad for treatment.

On Saturday, BNP Secretary General Mirza Fakhru Islam Alamgir said that physicians said she may require treatment abroad, but her current physical condition does not permit overseas travel.

The BNP had on Friday said her condition is very critical and sought people to keep her in their prayers. Zia, the wife of slain Bangladesh president Ziaur Rahman, has been suffering from multiple other health complications, including liver and kidney issues, diabetes, arthritis, and eye-related illnesses.

Earlier in the year, Zia returned to the country from London on May 6 after spending four months for advanced medical treatment.

Kazakhstan condemns Ukraine for attacking assets that handle over 1% of global oil

Kazakhstan on Sunday told Ukraine to immediately stop drone strikes on the Caspian Pipeline Consortium's (CPC) Black Sea terminal, warning that repeated attacks on the critical oil facility had disrupted global supplies.

The appeal came after a major Ukrainian naval drone attack forced the CPC to suspend operations at its Novorossiysk terminal, which handles more than 1 per cent of the world's oil.The CPC -- whose shareholders include Russia, Kazakhstan, Chevron, Lukoil and ExxonMobil -- said a key loading buoy was "significantly damaged" in a November 29 strike, forcing the withdrawal of tankers and a halt in all loading operations.The pipeline system exports roughly 80 per cent of Kazakhstan's oil and carried 68.6 million tonnes last year, making it one of the most important arteries of energy supply in the region.

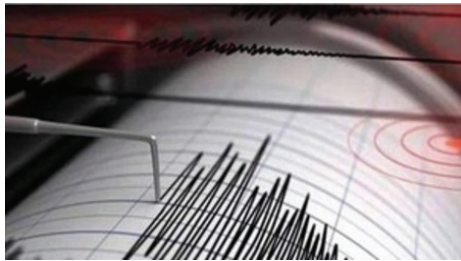
KAZAKHSTAN PROTESTS DELIBERATE ATTACK

Kazakhstan's foreign ministry condemned the strike, calling it the third series of attacks this year on what it described as "an exclusively civilian facility whose operation is safeguarded by norms of international law"."Kazakhstan expresses its protest over yet another deliberate attack on the critical infrastructure of the international Caspian Pipeline Consortium in the waters of the Port of Novorossiysk," the ministry said.We view what has occurred as an action harming the bilateral relations of the Republic of Kazakhstan and Ukraine, and we expect the Ukrainian side to take effective measures to prevent similar incidents in the future," it added.The CPC said the damaged Single-Point Mooring 2 -- a floating terminal used to load oil onto tankers -- could not continue functioning. "Further operation of Single Point Mooring 2 is not possible," the operator said, confirming a complete suspension of loading.

Pakistan's DG ISPR, Lieutenant General Ahmed Sharif Chaudhry's statement warning Afghanistan—"blood and business cannot go together"—now seems to have backfired and is hurting Islamabad itself. With bilateral relations between the two neighbours sinking to their lowest point, following the brief border clash and the mass expulsion of Afghan nationals during harsh winter months, the trade war between Pakistan and Afghanistan has erupted, and its effects are falling disproportionately on Pakistan.Since the closure of border trade points on October 11, Afghanistan has quickly adapted by redirecting commerce through Iran, India, and the Central Asian republics. Pakistan, however, has taken a severe hit. The halt in cross-border trade is dealing a heavy blow to Pakistan's already fragile economy. It is undermining its trade, manufacturing, and export sectors, according to several reports, including one in Dawn, the Karachi-based English daily.

US and Ukrainian negotiators held hours of what both sides called "productive" talks in Florida on Sunday on a plan Washington wants to form the basis of

a peace deal between Russia and Ukraine.The diplomatic flurry after nearly four years of conflict comes as Kyiv battles military pressure and reels from a domestic corruption scandal that forced Zelensky to remove his close aide and top negotiator.The Ukrainian leader has been a regular visitor to Paris since Russia launched its full-scale invasion in February 2022.

French Foreign Minister Jean-Noel Barrot said in comments to the La Tribune Dimanche newspaper on Sunday that the meeting aimed "to move the negotiations forward".

"Peace is within reach, if (Russian President) Vladimir Putin abandons his delusional hope of reconstituting the Soviet empire by first subjugating Ukraine," he added.Washington put forward an initial 28-point proposal to halt the war, drafted without input from Ukraine's European allies and regarded as too close a reflection of Moscow's maximalist demands on

Pakistan's Pathan-dominated Khyber Pakhtunkhwa erupted in outrage over the trade closure, with manufacturers and traders demanding the immediate lifting of the ban.

reconsider its decision to close trade routes with Afghanistan, reported Tolo News. Dar added that he would discuss the matter with Prime Minister Shehbaz Sharif and Army Chief Asim Munir.Notably, Afghanistan ranks among the world's poorest countries, with a projected GDP per capita of just \$434, which is lower than many African nations such as Burundi and Somalia

According to the United Nations Development Programme's 2025 Global Multidimensional Poverty Index, more than 64% of Afghanistan's population lives in poverty.Afghanistan's economy is in shambles, but the Taliban regime is attempting to rebuild it by diversifying trade. This effort was evident in two back-to-back Afghan delegations that visited India recently, including Afghanistan's Minister of Industry and Commerce, Alhaj Nooruddin Azizi. The Taliban regime is also working to open trade channels with Turkey.

Trump defends asylum freeze, claims Biden and Harris screwed US

After ordering a sweeping freeze on asylum processing, US President Donald Trump on Sunday defended the move after the arrest of an Afghan immigrant accused of killing a National Guard member near the White House, saying the United States "has enough problems" and may bar asylum for some nations "for a long time".The president's comments marks latest escalation in his immigration stance following Wednesday's attack that killed Specialist Sarah Beckstrom and critically wounded Staff Sergeant Andrew Wolfe -- an incident now driving one of the



most aggressive tightening of vetting rules since Trump returned to office.Speaking to reporters aboard Air Force One, Trump signalled that more restrictions are coming."No time limit, but it could be a long time," he said, when asked how long the United States might pause asylum admissions for certain nations.

"We have enough problems. We don't want those people," he added.The administration has also suspended all asylum processing in the aftermath of the shooting.

TRUMP SAYS BIDEN, HARRIS SCREWED US

Amid the ongoing crackdown, Trump renewed his attack on the previous Joe Biden administration."Crooked Joe Biden, Mayorkas, and so-called 'Border Czar' Kamala Harris really screwed our Country by letting anyone and everyone come in totally unchecked and unvetted," he wrote on Truth Social.The Department of Homeland Security (DHS) supported Trump's remarks, calling Biden-era vetting practices "an act of national self-sabotage" and saying the suspect "should never have been in this country."DHS has frozen all immigration requests from Afghan nationals "indefinitely" pending a full review of vetting protocols.

Homeland Security Secretary Kristi Noem also blamed the prior administration."This individual's application to be in this country started under the Joe Biden administration," Noem said.

Can anti-India lawmaker Ilhan Omar be deported from US amid fraud claims

Allegations that Somalia-born US Representative Ilhan Omar, Democratic congresswoman from Minnesota, committed marriage and immigration fraud to secure American citizenship have resurfaced, and this time, the MAGA crowd is calling for her denaturalisation and deportation. The claims, which first emerged in 2016, revolve around her marriage in 2009 to Ahmed Nur Said Elmi, who critics allege is her brother.The allegations were back in the spotlight days after US President Donald Trump raked up Omar's immigration background last week. Trump also alleged that Ilhan Omar came to America illegally by marrying her brother. The US President floated the conspiracy theory as he renewed his headline immigration rhetoric after an Afghan national shot two National Guard soldiers near the White House.The allegations went viral with images of Omar's marriage records being circulated on X, and called for immediate action by

the Department of Homeland Security (DHS).Notably, Omar has faced criticism for her anti-India foreign policy stance in the past. In 2022, she visited Pakistan-Occupied-Kashmir and met local leaders. New Delhi condemned her four-day visit to POK, during which she had accused India of human rights violations in Kashmir and co-sponsored resolutions critical of the Indian government towards religious minorities.Now, as the row over her marriage escalates, the question is, can an elected representative, and a naturalised citizen, be deported from the US?

MAGA ACCOUNTS ARE POSTING 'EVIDENCE' OF FRAUD

Dozens of people shared "evidence" on social media, alleging that Omar has committed fraud.A post by @Chicago1Ray, which was reposted over 12,000 times and garnered over 3.46 lakh views, said, "Evidence shows Ilhan Omar married her brother - Ahmed Nur Said Elmi she helped him gain citizenship, that's a

crime." Another user, @SaltyGoat17, whose post was also widely shared, said, "Ilhan Omar DID marry her brother Should



she be de-naturalised and deported back to Somalia?Similar posts by many such users got hundreds of thousands of engagements, with many quoting Elon Musk's recent statement that any violation of the citizenship oath should lead to deportation.

The allegations date back to an anonymous 2016 post on a Somali-American forum and were amplified during Omar's 2018

congressional campaign.Investigations by the Minnesota Star Tribune newspaper, Alpha News, and others did point to her overlapping marriages but produced no definitive proof of fraud or familial relations.The FBI reviewed tips in 2019-2020, and the House Ethics Committee examined the matter in 2020; and both processes closed without charges against Ilhan Omar.Omar has, over the years, described the claims as baseless, Islamophobic, and politically motivated.CAN I L H A N O M A R , A NATURALISED US CITIZEN, BE DEPORTED?

Under US law, naturalised citizens can lose citizenship through denaturalisation if it is proven they procured it by concealment of a material fact or wilful misrepresentation. Proceedings are civil, initiated by the Department of Justice in federal court, and require clear, unequivocal, and convincing evidence.

Woman dies after falling on tracks while alighting from train

A 58-YEAR-OLD woman from Andhra Pradesh who had come to the city to meet relatives died after she fell off while alighting from a long-distance train on Thursday at Dadar. The woman wanted to use the washroom on the train as she could not spot one on the platform.
However, when the train started moving, she tried to alight quickly and fell off on the tracks. The railway police have taken an accidental death report in the matter.
As per police, the deceased woman (will update her name later) wanted to go to Ambarnath to meet her relatives and was accompanied by her son. Her husband works as a cook at a shipping company in London.
As per railway police, the incident took place around 2pm on Thursday when the woman was standing on platform number 10 at Dadar railway station. She realised that she needed to relieve herself but could not spot a washroom around.
Seeing a mail train there, the woman climbed onto the train to use the washroom. After relieving herself, as she came towards the door, the train began moving. “In an attempt to alight the train, she jumped but ended up falling in the gap between the platform and the tracks resulting in getting crushed by the train,” said Anil Kadam, senior police inspector of Dadar GRP.
Kadam said that the woman’s son then raised an alarm alerting the GRP and other passengers who rushed the woman to the hospital where she succumbed to her injuries after two hours. “We have registered a case of accidental death (ADR) and are investigating further,” said Kadam.

HC seeks panel report on plea seeking human trials for cancer vaccine

The Central Drugs Standard Control Organisation (CDSCO) informed the Bombay High Court earlier this month that it has appointed an Expert Committee to examine grievances raised in a plea by Nashik-based Datar Cancer Genetics Pvt Ltd. The company sought approval for phase 1 human trials of its cancer immunotherapy drug, Per-C-Vax. The court directed the committee to examine the submissions and submit a report within three months
short article insertA bench of Justices Revati Mohite Dere and Sandesh D Patil on November 21 heard a plea by Nashik-based Datar Cancer Genetics Pvt Ltd aggrieved by the “arbitrary” rejection of its plea by the Central Drugs Standard Control Organization (CDSCO) to conduct phase I human trials for its indigenous vaccine to treat solid organ cancers. The petitioner claimed that the application was made in August 2023 under the New Drugs and Clinical Trials (NDCT) Rules, 2019 and CDSCO’s did not comply with the rule mandating its response within 30 days. On the other hand, it insisted upon pre-clinical animal study data despite the petitioner having stated that the same was scientifically impossible considering the nature of the vaccine. Aggrieved by the April 22 decision of the Drugs Controller General of India, the petitioners approached HC alleging the ‘mala fide’ action by the authority defeated the legislative safeguard built through the new rules.

Tech-driven SWM framework in the works

Govt to form high-level committee to implement end-to-end solid waste management system for city

BENGALURU. (Agency)
Following directions from the Karnataka high court, the state government has mandated the constitution of a seven-member Nodal Oversight and Implementation Committee to roll out a technology-driven solid waste management (SWM) framework for the city.
Acting on the court’s orders, the government, in its order dated November 28, said it will establish a ‘One City, One Platform’ digital system integrating dashboards, mobile apps, GPS tracking, weighbridges and CCTV surveillance for end-to-end SWM operations. The court had stressed that these components must function as a single ecosystem, where CCTV data, citizen reports and enforcement actions flow seamlessly through one platform.
The committee will be headed by the additional chief secretary, urban development department, with the chief commissioner of the Greater Bengaluru Authority as vice-



president. Managing Director/Chief Executive Officer of Bengaluru Solid Waste Management Ltd (BSWML) will be the member-secretary and the five municipal corporation commissioners will serve as members. The panel must oversee implementation and ensure compliance with the high court’s mandated timeline.
It may be recalled that the BSWML has been taking a slew of measures to improve solid waste management in the city, as Bengaluru’s image has taken a beating by the rising number of garbage blackspots on its streets and poor waste management.
To discourage the public from dumping waste on roads and in open spaces, the authorities launched initiatives such as ‘Kasa Suriyuva Habba’ (garbage dumping festival), under which many of those found disposing waste in non-designated areas had a load of garbage dumped right in front of their home.
The BSWML also introduced a special drive offering a reward of Rs 250 to citizens who submit videos of litterbugs through a dedicated WhatsApp number or official social media handles.
Additionally, the organisation is set to establish over 70 kasa (garbage) kiosks to enable people to dispose waste at designated spots without waiting for collection vehicles.

Cyclone Ditwah: Chennai gets moderate rainfall in last 24 hours; special medical camps arranged

The city did not witness any significant rainfall during the day on Sunday either, as the cyclone weakened into a depression in the evening.

CHENNAI. Parts of Chennai recorded light to moderate rainfall in the 24 hours between Saturday and Sunday morning, according to data from the Greater Chennai Corporation’s (GCC) Integrated Command and Control Centre. The city received an average of 3cm rainfall during this period.
Ennore recorded the highest rainfall at 5.58cm, followed by Madhavaram (4.92cm) and Medavakkam Junction (4.4cm). Northern zones — including Thiruvottiyur, Manali and Madhavaram — received between 2cm and 5cm, while southern neighbourhoods such as Adyar, Velachery, Palikaralai and Sholinganallur logged around 3-3.7 cm.
The city did not witness any significant rainfall during the day on Sunday either, as the cyclone weakened into a depression in the evening.



A resident of Velachery said that while people here were fearful of Cyclone Ditwah, it did not bring the expected rainfall on Sunday.
To prevent the spread of monsoon-related

diseases, 20 special medical camps were conducted on Sunday. Seven uprooted trees were cleared on priority basis. To ensure the swift removal of fallen trees during the cyclone, GCC had kept 457 tree-pruning machines on standby.
A release by GCC noted that 32,500 food packets were distributed to the public, most of them in the southern parts of the city, particularly in Adyar and Sholinganallur zones.
The stagnant water on Thiruvottiyur High Road was pumped out using high-capacity motors, followed by desilting of silt catchpits, the release added. A total of 22,000 officials, engineers, workers, and sanitary workers were engaged in round-the-clock operations, the release said.

Colleagues at Ruby Hall Clinic found dead at 2 spots

Two lab technicians working at the Ruby Hall Clinic in Pune were found dead at different locations, with body of one of them found at the other person’s residence, police said. Police have identified the deceased as Ganesh Kale (21), resident of Sangamwadi and Divya Nighote (20) of Wadgaonsheri area in Pune city.
According to police, Ganesh Kale, a native of Beed district, was found dead at the railway track in Talegaon Dabhade on Friday.
Divya Nighote was found dead at Kale’s residence in Sangamwadi on Saturday. Police said that after she went for work at the hospital, she not return home. Her family filed a missing report at the Koregaon Park police station.
“We launched a search for Divya. We traced her last location through a technical probe.
Our team found her dead at a house in Sangamwadi area. Further investigation is being done by the Yerwada police station team,”

senior police inspector Sangita Jadhav.
Deputy Commissioner of Police (zone 4) Somay Munde said “Divya’s body was found at Ganesh Kale’s residence on Saturday afternoon. Divya was missing since Friday night... Some external injuries are there on her body. Cause of death will be revealed after post mortem. Both deceased were working at Ruby Hall. Further investigation is on.”
Police have informed family members of both. A probe is on to confirm the cause of their deaths, police said.
In an official statement issued Sunday evening, Manjusha Kulkarni, Legal Advisor, Ruby Hall Clinic said that they regretted the unfortunate incident.
“The matter is currently under police investigation and we are fully cooperating with the authorities in all necessary procedures. Our prayers are with the families in such difficult times,” Kulkarni added

From JEE prep to President’s Medal, Siddhi’s win marks another milestone in NDA history

Before Siddhi Jain was selected for the 149th course of the National Defence Academy (NDA) as part of the second batch of female cadets, she was preparing for the IIT-JEE in Kota. On Sunday, when Navy Chief Admiral Dinesh Tripathi pinned the prestigious President’s Bronze Medal on her uniform, she became the first female cadet to be awarded the President’s Medal for overall order of merit.
As the 329 cadets of the 149th course passed out from the hallowed portals of the NDA on Sunday, they included 15 cadets from the second batch of women at the tri-services academy.
While two female cadets have topped the academic stream so far, one in the 148th course and another in the 149th, Siddhi is the first to win a



medal in the overall order of merit. The overall merit list is drawn from performance in academics, outdoor training, joint training, officer-like qualities and specialised service subjects. This year, the President’s

Gold Medal went to Academy Cadet Adjutant Deepak Kandpal of Alpha Squadron, the President’s Silver Medal to Academy Cadet Captain Siddharth Singh of Oscar Squadron, and the President’s Bronze Medal to Divisional Cadet Captain Siddhi Jain of Kilo Squadron.
Addressing the passing-out cadets, Admiral Tripathi said, “I am delighted to see the second batch of the women cadets graduating today, 15 of them standing shoulder to shoulder with their male counterparts. This reaffirms that the service honours only one standard, that is merit.”
Siddhi, who will join the Air Force, said after the parade, “We have experienced many ups and downs and many moments that have created happy memories for life.

Pune: Drunk IT professional rams car into pub’s parking, valet attendant dead

A valet attendant was crushed to death by a Volkswagen car at Toit Pub and Restaurant in Pune’s upscale Kalyani Nagar area on Sunday afternoon. Police have detained the driver, identified as Pratapsinh Daingade (49), an IT professional residing in Dhanori, and confirmed that he had consumed liquor when the incident occurred. The deceased, identified as Satyendra Mandal, was in his 30s and a native of Bihar. Police said the process of registering an FIR was underway at the Yerwada police station.
Senior police inspector Ajum Bagwan of Yerwada police station said the incident took place around 2.30 pm. “The car driver is from Atlanta Society, Nerul in the Navi

Mumbai area. He works at the Commerzone IT Park in Pune and is currently residing in Dhanori,” Bagwan said.
“A prima facie probe has revealed that he came to the Toit pub in the afternoon. As he was drunk, the pub staffers said they would book a cab for him. But he got into his car and while driving it out of the pub premises, he lost control, due to which the car went on to hit the counter in the valet parking area. A valet attendant was crushed between the wall behind him and the counter, in the incident. The injured worker was taken to a hospital, but he died. We have detained the car driver, who was found to be under the influence of alcohol when the incident took place. Further investigation is on,”

Bagwan added.
Toit pub issued a statement, “We are extremely sad to report that there was an incident outside our restaurant this afternoon around 3 PM, resulting in the loss of life of one of our colleagues, Satendar Mandal. A driver rammed his car into Mandal, who worked as a valet attendant. An FIR has been registered with the Yerawada Police Station and the authorities are investigating the incident. We are extending our complete cooperation with the police to help bring justice to the victim. The entire team at Toit deeply mourns this incident and we request that our privacy be respected during this difficult time.”Deputy Commissioner of Police (Zone 4) Somay Munde said the accused

driver has been taken into custody. “His medical examination is on. An offence of culpable homicide not amounting to murder will be registered against the accused,”



Munde said.
The incident comes months after residents of Kalyani Nagar raised concerns about the rising number of pubs, bars and restaurants in the neighbourhood. In July this year,

they held a public interaction to highlight issues related to noise, traffic and late-night disturbances. Following this, in August, Pune Police Commissioner Amitesh Kumar constituted a joint committee with senior police officials, representatives of the Pune Municipal Corporation, the District Collector, the State Excise Department and a reputed citizen from the area to address the concerns.

Earlier, Pune police had intensified action against “disorderly conduct” at and outside pubs after a 17-year-old boy, allegedly under the influence of alcohol consumed at two hotels, rammed a Porsche into a motorcycle at Kalyani Nagar junction on May 19, 2024, killing two IT engineers.

One more sanitary staff on indefinite hunger strike admitted to government hospital in Chennai

Bharathi, one of the four sanitary workers on an indefinite hunger strike demanding reinstatement of their jobs under the Greater Chennai Corporation (GCC), was admitted to Rajiv Gandhi Government General Hospital (RGGGH) on Sunday after her health deteriorated. She had been fasting for 14 days.
Earlier, Jenova, another protester, was admitted to Kilpauk Medical College (KMC) Hospital on Saturday and remains under observation.
Speaking to TNIE, LTUC state secretary K Suresh said, “The workers have been fasting for the last 14 days, but not a single corporation official has met them or responded to their demands. Bharathi allegedly had a thyroid condition and had been fasting without informing the association. She had not taken sufficient medical supplements, which led to giddiness and severe stomach pain. She was first taken to KMC on Sunday morning and later shifted to RGGGH, considering her condition.” Two other workers - Vasanthi and Geetha - continue their fast. With Vasanthi’s health also worsening, the association said it is considering replacing the current group of protesters with four other workers by Monday. The workers urged the CM, to intervene immediately.

Avoiding adverse association

Good association that takes our mind to the Truth is called satsang. Etymologically, ‘sat’ means ‘truth’, while ‘sang’ means ‘to associate’. Satsang includes holy congregations where devotional topics are discussed. Conversely, kusang is bad association that pulls our mind into worldly contemplation.

Narad refers to it as dusang. Just as weeds choke a plant, bad association chokes the sapling of bhakti in our heart. Thus, evading kusang is extremely important.

Kusang tempts us towards worthless pursuits. It presents us with easy opportunities for gratification. These come in myriad forms, including social media, video games, and movies. To protect one’s devotion, it is best to minimise exposure to low-value delights. Unfortunately, our material mind finds kusang very relishable.

Suppose one is bitten by a snake. What is the way to know if the venom has spread through the body? Here is a simple test for it. Offer bitter neem leaves to the person and ask how they taste. If the person finds them sweet, you can conclude that the poison has entered the blood.

Similarly, our mind and senses are made from maya. They are naturally drawn to worldly indulgences and entertainment. Hence, kusang tempts us to drop our guard. The intellect says, ‘What is the harm in looking? It will give me a quick short break for a few moments.’ Then the intellect yields further and thinks, ‘What is the harm in indulging a little more?’ And before we know it, kusang sways the mind beyond our control. We must therefore cautiously avoid adverse association, just as we avoid keeping garbage inside our home.

If we repeatedly succumb to savouring a lower pleasure, we risk falling into the grip of a pernicious habit. Then, to reverse the harmful tendency becomes a challenge.

The Mahabharata states: A small sapling can be chopped off easily, but cutting a fully grown tree takes a lot of effort. Thus, in matters of kusang, precaution is the better part of valour. Narad advises us to ‘stay away from adverse association by all means’. In the next sutra, he ups the ante on the dangers of kusang. Narad points out that kusang unleashes a chain of events. The Bhagavad Gita details the downward spiral of kusang: While contemplating on the objects of the senses, one develops attachment to them. Attachment leads to desire, and from desire arises anger. Anger leads to clouding of judgment, which results in bewilderment of memory. When memory is bewildered, the intellect gets destroyed; and when the intellect is destroyed, one is ruined. (verses 2.62-63) The buddhi is the most important faculty we possess in our mind-body mechanism. The convictions we harbour in our intellect become the ‘beliefs’ we live by. These are the lenses through which we see the world. If the buddhi is ruined through kusang, then our beliefs get warped. Every so often, parents approach me, ‘Swamiji, my teenage son has gone astray. He has fallen into an awful chemical addiction. What should I do?’ I respond to them, ‘Check his friends circle. If his close acquaintances are derelict, his beliefs have been adversely impacted. In association with drug addicts, he has become convinced that skirting responsibility and experiencing the euphoric high from drugs is the definition of a good life. His defective belief is destroying him.’ So powerful is the impact of association upon our convictions! Hence, Ram explained to Vibheeshan: ‘It is preferable to live in hell than to do sang of terrible people.’

Punjab’s special needs and the solution to Chandigarh’s shared status

Red Fort blast and Tejas crash underscore India's security and strategic challenges

The BJP-ruled Centre has been forced to withdraw one notification after another in quick succession regarding Punjab — one related to key changes in the governance of Panjab University and another, a Bill proposing changes in the governance of Chandigarh itself. The backlash over the PU notification and Chandigarh Bill forced the Centre to fall in line. The interesting thing is that PM Modi understands that with only 13 seats in the Lok Sabha, Punjab doesn’t carry the electoral weight that large states like Bihar or Bengal do. Punjab has special needs and it is the Centre’s duty to understand them — whether or not Punjabis vote the party into power or not, writes Editor-in-Chief Jyoti Malhotra in her weekly column The Great Game Two reversals and a missed opportunity. The healing touch that Punjab so desperately needs from the Centre is missing, she writes.

Going into the background as to why Chandigarh is still elusive to Punjab or Haryana, in July 1985, the transfer of Chandigarh to Punjab had become certain with Prime Minister Rajiv Gandhi signing an accord with Akali Dal president Harchand Singh Longowal that Chandigarh would be transferred to Punjab on Republic Day, i.e. January 26, 1986, but the promise was not honoured.

In his article Why Chandigarh still eludes Punjab, GNDU’s Professor Kuldip Singh writes that the official excuse given by the Centre was that the Matthew Commission had failed to identify the areas to be given to Haryana in lieu of Chandigarh. However, the real reason was the fear of the loss of Hindu votes in the upcoming Haryana Assembly elections, he writes. In his article A feasible solution to the imbroglio, former Punjab Chief Principal Secretary Suresh Kumar writes that the Punjab Reorganisation Act, 1966, does not include any provision to assign Chandigarh to Haryana nor does it establish any concept of shared ownership. Haryana’s claim to Chandigarh is devoid of constitutional foundation and territorial rationale, he avers. Chandigarh was constructed on land acquired, planned and developed by Punjab. The most pragmatic and forward-looking solution is that Haryana should build a new Centrally assisted capital; Punjab should be relieved of the full fiscal burden of Chandigarh and UT Chandigarh should remain a UT serving as the capital of Punjab, he suggests. Another important milestone the Central Government is boasting of is the saffron flag, now flying atop the Ram Jannabhoomi temple, which marks the culmination of the monumental complex. It will serve as a reminder of three things, writes former Rajya Sabha MP Vinay

Sahasrabudhe in his Op-Ed article Why the Dharma Dhwaja matters. First, it demolishes the argument that the caste-ridden Hindu society cannot come together. Second, it tells us about the art of mobilising public opinion and building a popular movement. Third, it underscores the dharmic character of Indians, for whom shraddha is an elixir.

With the Tejas aircraft coming under scrutiny after the mishap at the Dubai airshow resulting in the death of its pilot Wing Commander Namansh Syal, there is a need to differentiate between the aircraft’s capability and HAL’s production capacity, writes Air Vice Marshal Anil Golani (retd) in his Op-Ed article Tejas crash raises tough questions for HAL. The need to campaign for export



orders is questionable under the circumstances. GDP growth more broad-based, but dark cloud fill silver lining

Rising consumption should lead to more investment, but the global headwinds may hold back its growth

Between July and September this year, India’s GDP expanded at the sharpest clip in seven quarters. The latest quarterly growth of 8.2 percent beat RBI’s estimate of 7 percent and surpassed consensus projections that had tempered expectations citing American tariffs. The performance reaffirmed India’s strong underlying economic momentum amid global uncertainties. Though India is the only major economy yet to strike a trade deal with the US, it retained the tag of being the fastest-growing major economy notwithstanding the steep levies, which have compelled foreign investors to pull out a record \$16 billion from Indian equities so far in 2025. The most comforting data point from Friday’s numbers is that with consumption, investments, and manufacturing witnessing a revival, India’s growth engines are now more broad-based. Until now, one component or another was pulling in less than the desired output; but the second quarter saw a much-needed departure. The 9.1 percent uptick in manufacturing, followed by financial and professional services at 10.2 percent, and construction at 7.4 percent were the key growth drivers.



However, government spending contracted, while rural demand retained its level. Higher agricultural output, steady farm incomes, and improving rural labour conditions further strengthened private consumption to 7.9 percent. Higher consumption is a sign of healthy

On the other hand, Dhaka needs to be convinced that allying with a stable India is a much wiser option than siding with an unstable Pakistan, he writes. Despite October’s shocking trade performance, India’s showing in the first seven months was not that bad. The nation’s path will remain unsteady unless it undertakes key reforms, writes former finance secretary Subhash Chandra Garg in his Edit article India remains on trade-turning pitch. We need to conclude long-pending foreign trade and investment agreements/treaties with the US, EU and also China to make India a production and export powerhouse for new industrial products (including automobiles). We need to open up education, health, accounting, legal and personal services and thoroughly overhaul travel and transport infrastructure and services to build new services-export growth engines, he writes.

How the framers of the Constitution created the Election Commission of India (ECI) two months before the rest of the Constitution commenced on January 26, 1950, is an eye-opener for the people, the government and the Election Commission of India. This sequencing was not a technicality; it was a profound constitutional choice, says SY Quraishi, former Chief Election Commissioner of India, in his Edit piece Why EC was born before the Republic. The framers knew that once the Constitution began to operate, India would require a government elected under its authority. The ECI, thus, had to be constituted before the Republic was born, so that the first government would derive its legitimacy not from an executive but from a constitutionally independent referee.

Not at home at home, abroad when abroad

The immigrant experience is no longer a single story, it has splintered into multiple strands

David Szalay, this year’s Booker Prize winner, is an unusual immigrant. Born to a Hungarian father and Canadian mother, and having lived in several countries, including the UK, Canada and Lebanon, he is today, ironically, an immigrant in his native country, Hungary. In an interview with BBC Radio, the writer said, “Even though my father is Hungarian, I never felt entirely at home in Hungary. I suppose I’m always a bit of an outsider there, and living away from the UK and London for so many years, I also had a similar feeling about London.” Szalay’s life traces a familiar but often overlooked trajectory — the circular migrant, someone who migrates not once, but repeatedly, acquiring new layers of estrangement in each move. Szalay’s Booker-winning novel ‘Flesh’ follows the arc of Istvan, from his quiet housing complex in a Hungarian town, then as a struggling immigrant in London, and finally into a rarefied world of affluence. The book captures what it means to be untethered — never quite at home in the place one leaves, nor in the place one reaches. This is the friction Szalay says he wanted to explore: “a book that stretched between Hungary and London and involved a character who was not quite at home in either place.” This tension of in-betweenness echoed throughout the Booker shortlist. Most of the writers who made it to the shortlist were immigrant or post-immigrant. Three of the six shortlisted books, including ‘Flesh’, Kiran Desai’s ‘The Loneliness of Sonia and Sunny’, and Susan Choi’s ‘Flashlight’, lay bare the complexities of immigrant life. The Booker website notes how

these protagonists are “often caught between nations, finding it hard to fit in, and struggling with loneliness or isolation”. This captures the central paradox of the immigrant narrative: the dual identity, the simultaneous insider-outsider status, standing at the threshold of two countries yet belonging fully to neither.

Jhumpa Lahiri describes this poignantly. “A lot of my upbringing was about denying or fretting or evading,” she once said, acknowledging how the immigrant household is often built on anxieties that stretch across continents. Her debut novel ‘The Namesake’ embodies this duality. As Ashoke and Ashima attempt to re-root themselves in Massachusetts, the novel contrasts their experience with that of their children, who inhabit a hybrid terrain. The children are second-generation immigrants living between the inherited world of their parents and the American world that surrounds them. Yet Ashima, the first-generation immigrant, also comes to realise that Calcutta — “the city that was once home” — has become foreign in its own way. Vikram Seth, too, captures this dislocation in his poem ‘Diwali’, describing those “who are not at home at home/and are abroad abroad”. Earlier, much immigrant fiction followed a familiar track: the journey outward, the departure from a known setting — home, language, family, and perhaps a sense of self — into a new world where survival hinges on adapting to unfamiliar norms. But the reality is far more complex. In her memoir ‘They Called Us Exceptional’, Indian-

American writer Prachi Gupta describes the suffocating weight of the “model minority” expectation. Coming from a family that is educated, affluent and driven, she reflects on the unspoken demands of chasing the American Dream and how the immigrant minority is expected to

single story. It has splintered into multiple strands. Benjamin’s Malayalam novel ‘Aadujeevitham’ (Goat Days) and Sunjeev Sahota’s ‘The Year of the Runaways’ reveal the precarity and social invisibility that define the lives of undocumented migrants. The refugee narrative, by contrast, emerges in works such as Mohsin Hamid’s ‘Exit West’ and Khaled Hosseini’s ‘And The Mountains Echoed’, where displacement is abrupt, violent, and often irreversible. In Chimamanda Ngozi Adichie’s ‘Americanah’, migration becomes a series of crossings rather than a single departure.

Diaspora writing, in essence, shows identity evolving across cultural, racial, linguistic and political boundaries. Return, too, is central to immigrant literature. The journey back — literal or symbolic — asks who one becomes after crossing borders and whether “home” remains a fixed, meaningful space. Haitian-American author Edwidge Danticat offers an evocative view: “The idea of this great anguish of living between two worlds has diminished somewhat for many immigrant people.... I would like us to move beyond these tropes of being only between two worlds. We are at the same time speaking to no one and everyone.” It is a reminder that immigrant narratives now encompass the multi-layered identities of a world where movement is constant, and where belonging can be multiple, partial or one driven by choice and circumstance.



speak and behave in a way acceptable to the West. Gupta reveals the emotional and cultural labour required to fit into what she calls a “hypercapitalist culture that only values us for what we can produce”. Her poignant address to her mother underscores this complexity: “I never asked you what hopes and dreams buoyed you amid the all-consuming loneliness and grief of leaving your family and your country behind.”

Ex-CM raises alarm over rising drug overdose deaths

Expressing grave concern over the increasing number of drug overdose deaths in Himachal Pradesh, former Chief Minister and Leader of Opposition Jai Ram Thakur urged the state government to take immediate and stringent measures to curb the menace. He said that frequent reportage in the media about youths dying due to overdose of chitta and other narcotics reflects a deeply disturbing trend.

Referring to the recent death of a 15-year-old boy in Rohru, Thakur said it was heartbreaking to see young children losing their lives at such regular intervals while the government “fails to control a menace that is eating into the vitals of society.”

He remarked that drug abuse was spreading “like an epidemic” across the state, yet the government appeared more preoccupied with events and publicity than with combating the crisis.

The former Chief Minister criticised the lack of state-run rehabilitation facilities, stating that families were forced to spend their savings on private centres where, instead of treatment, cases of violence and abuse were often reported. “There is no government-supported rehabilitation centre. People are compelled to approach private facilities, and many of them face mistreatment in the name of de-addiction,” he said.

Thakur added that over 30 drug-related deaths had been reported this year, though the actual figure could be far higher, he warned.

Emphasising that there was “no place for drugs in Deybhoomi”, he called for the strictest possible action to save the youth.

He asserted that the BJP would support the government in every step taken to curb narcotics and prevent further loss of young lives.

UP govt approves Rs 1 cr for amenities at Lucknow’s Digambar Jain Temple

The UP government has approved Rs 1 crore for the development of amenities at Digambar Jain Temple in Indranagar area of Lucknow. Officials said it was a part of an attempt to strengthen “Jain Heritage” in the state capital, while special infrastructural development would be undertaken around the Digambar Jain Temple.

“The project has been cleared under the Chief Minister’s Tourism Development Scheme,” said an official, adding that the aim is to provide an experience to thousands of devotees who visit these centers of Jain faith.

Officials said that while the Jain temple in the Ashiyana area of Lucknow houses about a thousand-year-old idol of Lord Mahavir, the Indira Nagar temple houses an about 800-year-old handwritten Jain manuscript.

As part of the project, the area surrounding the temple would be redesigned with wider roads, new lighting, proper sanitation, drinking water facilities, clear signage, as well as seating areas, parking arrangements, and would also have a dedicated information kiosk.

Officials said that the latest plan is in line with the government’s efforts to develop locations within the Jain tourism circuit. “The idea is to ensure that the project also supports local employment, encourages small businesses near the temple area, and turns it into a significant place for religious tourism,” said an official.

‘Pressure, no support pushed him into stress’: Another BLO dies by suicide in UP over ‘SIR work’

A 42-year-old headmaster of a primary school, who was working as a Booth Level Officer (BLO) for the ongoing Special Intensive Revision (SIR) of electoral rolls, allegedly died by suicide at his residence in the Baheri area of Moradabad. Police said a purported suicide note of Sarvesh Singh stated that he was under stress for “not being able to meet the SIR-related targets on time due to lack of proper guidance”.

“Despite working hard and barely sleeping two hours a night, he felt extremely troubled. He also mentioned that his mental health was deteriorating and that two of his four daughters were unwell, adding to his distress,” a police officer said, quoting the purported suicide note. He did not hold anyone responsible for his death, the officer added.

According to police, Singh’s family found him hanging in his room on Sunday morning. “When the police arrived, the body was found lying on the floor. The family members told us that they had found him hanging and, with the help of neighbours, had taken the body down,” said Additional Superintendent of Police (Moradabad) Kunwar Akash Singh.

Moradabad District Magistrate Anuj Singh, in a video statement, said Singh had been carrying out his responsibilities “effectively”, and had already completed digitisation of nearly 67 per cent of the required SIR enumeration forms and was close to finishing the remaining work.

“Sarvesh Singh’s immediate supervisor — who is also a relative — was in regular contact with him to oversee the progress, and an anganwadi worker had also been assigned to support him in completing the BLO duties,” said the DM.

Gurdaspur MP writes to Shah, seeks meeting of central, state agencies on Punjab’s law and order

Senior Congress leader and Gurdaspur MP Sukhjinder Singh Randhawa has written to the Union Home Minister Amit Shah on the escalated targeted killings, extortions and transnational gangster activities in Punjab and sought an urgent high-level meeting of central and state agencies. The MPs letter to the Home Minister comes on the heels of a demi official letter written to the Lok Sabha Speaker Om Birla where too he highlighted the deteriorating law and order situation in Punjab.

In his letter to Amit Shah, the MP has asked for a meeting of IB, R&AW, NIA, BSF, Punjab Police, and Punjab Home Department officials so that a coherent and effective national security strategy can be put in place in Punjab without delay.

“I have remained calm in public life, but the events unfolding around us compel me to speak with firmness and a heavy heart. Punjab, particularly in the current calendar year 2025, has witnessed a deeply disturbing rise in

targeted killings, assassination attempts, extortion-related murders, gangster warfare, and grenade-type attacks,” wrote Randhawa. The MP has told the Home Minister that this



violence is not sporadic-it is systematic, coordinated, and emboldened. “Most recently, we saw an incident that every local eyewitness and security observer recognises as a grenade attack, yet the Punjab Police has inexplicably and blatantly denied this reality. This refusal to

acknowledge the nature of the threat is itself becoming a threat multiplier. The Punjab Government today, I regret to say, is sleeping like Kumbhakaran,” he said.

Randhawa said that despite several sincere officers, the Punjab Police appears either incapable or unwilling to deal with the scale and sophistication of the challenge. Even the Border Security Force, whose jurisdiction now extends up to 50 kilometres from the international border, has not been able to stem the flow of arms, drones, narcotics, and money, he said, adding that cross-border corridors remain active and, in many cases, hyperactive.

“A clearer pattern is emerging: international forces are acting in close coordination....the border belt of Punjab has historically borne the maximum brunt of the Indo-Pak wars, and later, the deep wounds of terrorism in the 1980s and early 1990s. Entire families were wiped out; villages lived under constant siege. We cannot allow this cycle to repeat itself,” he said.

“Gangland”: Punjab reels as gun violence spreads from streets to wedding hall

Marriage palaces to streets, cities to villages, a spate of shootouts and killings in Punjab have left the common people in state of shock, with the Opposition parties slamming the Aam Aadmi Party (AAP) government led by Chief Minister Bhagwant Mann, who also holds the home portfolio, for turning “Punjab into a gangland.”

The latest incident occurred Saturday night at Ludhiana’s Bath Castle resort, where gangs led by Shubham Mota and his rival Ankur exchanged heavy gunfire during a wedding. Two guests were killed in the crossfire. Over 20 rounds were fired at the high-profile wedding of contractor Varinder Kapoor, which was attended by politicians, MLAs, and bureaucrats. At least 15 major killings linked to gun violence have occurred in recent months. Victims have ranged from an RSS leader’s son and a kabaddi player to a grocery shop owner and a transport company employee. Police, in several encounters, have also “opened fire in self-defence,” killing suspects, while many

other cases involve extortion attempts or intimidation shootings outside homes and shops.

Even leaders of the ruling party have been targeted. On November 27, unidentified bike-



borne assailants fired nearly 20 rounds at the house of AAP leader Daljit Raju Darvesh in Phagwara, leaving extortion notes signed by the Raja Kala gang demanding Rs 5 crore. Earlier, on September 20, five assailants fired outside

AAP leader Sukhwinder Singh Shinda’s house in Ludhiana’s Lehra village, set his car on fire, and scaled boundary walls.

On November 19, a jail guard shot dead his wife and mother-in-law with his government rifle before killing himself. A day earlier, on November 18, the manager of Kahlon Transport Company, Makhan Singh, was shot dead at Amritsar’s ISBT terminal, causing panic among commuters. That same day, Shiv Sena (Bal Thackeray) Punjab vice-president Inderjit Karwal and his son Jimmy were assaulted by a group in Phagwara. On November 17, 22-year-old Rimple was killed and four friends injured in Banga, Nawanshahr district, when gunmen opened fire at their SUV near the bus stand, barely 100 metres from the local police station. CCTV footage showed pedestrians running for their lives. A day earlier, 65-year-old grocery shop owner Manjit Singh was shot dead in Dhoolka village, Amritsar district, after refusing to pay a Rs 50 lakh ransom. Police said the main accused, Raja Singh alias Billa, was later killed in an encounter.

2022 protests against Agnipath scheme : ‘Joining Army is not a person’s dream, but a family’s... One case shouldn’t destroy a future’

Mathura native Deepak, 25, had spent nearly four years preparing, with a single-minded focus to join the Army. But the dream collapsed in an instant when he was arrested in 2022, for allegedly taking part in a protest against the then newly introduced Agnipath defence recruitment scheme.

A resident of Nagla Jheenga village in Mathura, Deepak, who doesn’t use a second name like many in his Jat community, says: “It was my last attempt to join the Army as a jawan... With that, all the dreams I had, all the hopes my family had pinned on me, came crashing down.”

Because of the criminal charges, it was unlikely he could secure a government job. With his family unable to afford further studies or coaching, Deepak gave up the idea. A few months ago, he took up a private job, where he has 12-hours workdays.

During the 2022 protests against the Agnipath scheme, 51 cases were filed in 15 districts across Uttar Pradesh, with youths accused of damaging

trains and vehicles and setting them on fire at several places. Several private and government properties were damaged in stone-pelting. The anger was about the Agnipath scheme under which youths were to be henceforth hired for a four-year short-term contract, with only around 25% from each batch to be retained at the end of four years. It was seen as a curtailment of the only avenue available to many for a secure and stable government job.

There is a ray of hope now for Deepak and others. As reported by The Indian Express, the Uttar Pradesh government has initiated a review, writing to district police heads and district magistrates where the cases are registered. “Once the report is finalised, it will be forwarded to the government without delay,” said a senior government official.

Many of the youths whom The Indian Express spoke to, who are in the same shoes as Deepak, say they were falsely implicated, and were either not present at the protests or had only gone there to see what was happening when police picked them up.



Mumbai Imposes GRAP-4 Pollution Curbs As Severe Smog Pushes City Into Emergency Mode

Mumbai woke up under a dense haze this week as air quality plunged to “severe” levels across several neighbourhoods, forcing India’s financial capital to join the likes of Delhi and activate its toughest pollution-control measures under GRAP-4.

According to , over the past few days, air-quality monitors have registered “very poor” to “severe” pollution levels, prompting alarm across the city. Areas like Mazgaon, Deonar, Malad, Borivali East, Andheri East (Chakala), Navy Nagar, Powai and Mulund have been among the worst affected, with residents

complaining of breathing discomfort, reduced visibility and irritation in eyes.

Under GRAP-4, the Brihanmumbai Municipal Corporation (BMC) has imposed a range of emergency measures aimed at curbing further pollution. These include a ban or strict regulation on dust-producing construction and demolition activity; strict enforcement against garbage and waste-burning in landfills or open spaces; tightening of vehicle emissions, with intensified checks for pollution certificates (PUC) and attempts to reduce traffic-related emissions; frequent water-sprinkling and mechanised road-sweeping to

suppress dust from roads and open grounds.

BMC has also launched a citywide road-cleaning and dust-control drive from November 28 to 30 with focus particularly on long, busy corridors and sites where construction activity and vehicular movement contribute to dust build-up. The civic body has already issued “stop-work” orders to dozens of construction sites found to be contributing to the pollution surge, apart from reactivating ward-level teams and deploying “flying squads” to monitor compliance.

The pollution crisis has also turned into a political flashpoint. The

city’s Congress unit has unveiled the ‘Mumbai Clean Air Action Plan’, which calls for recognising



clean air as a fundamental right, implementing 24/7 monitoring of pollution-causing activities, planting one million trees, and enforcing stricter pollution

standards for vehicles, construction sites, and industries.

In a post on X, former Maharashtra minister and Mumbai Congress president Varsha Gaikwad accused the state government of failing to protect the environment. She argued that unchecked construction activity and policies favouring contractors have contributed to the city’s worsening pollution. Gaikwad said

Mumbai is “choking under smog and the BJP’s contractor raj”, adding that every resident has a fundamental right to breathe clean air.

Family of Haryana student killed in UK stabbing incident demands probe

The family of an Indian student, who was stabbed in the UK on November 25, has appealed to the Union Ministry of External Affairs (MEA) for assistance in repatriating his mortal remains and for intensified investigation into the case.

Vijay Kumar, 30, a resident of Jagrambass village in Haryana’s Charkhi Dadri district, had been pursuing an MBA at the University of the West of England (UWE), Bristol, since January this year. His elder brother, Ravi Kumar, told The Indian Express on Sunday that the family was informed of his death on November 25 evening. According to them, Vijay had no known enmity with anyone, but they suspect that individuals from Haryana or Punjab may have been involved in the killing.

Ravi added that after completing his studies, his brother had planned to settle in the UK.

The family also wrote to Union Minister of External Affairs S Jaishankar Wednesday. In his letter, Ravi stated, “Our family is devastated. We request the Ministry’s support to bring back my brother’s mortal remains for last rites. The complex foreign procedures, legal formalities, documentation, and financial aspects make it extremely difficult for us to manage the process on our own.” He also urged the minister to direct the Indian High Commission in the UK to provide immediate assistance. Ravi said, “Even after four days of our communication to the Union minister, we have not received any response. The UK police investigators remain in touch with us, but we also need updates on the ongoing investigation, which the Indian High Commission could facilitate.”

Meanwhile, Charkhi Dadri BJP MLA Sunil Satpal Sangwan has also sought Jaishankar and Union minister Manohar Lal Khattar’s intervention. In separate letters to both leaders on Sunday, Sangwan requested urgent steps to ensure the early repatriation of Vijay’s mortal remains.

A team of researchers led by Prof Rohini Nair, assistant professor at Gujarat Biotechnology University, Gandhinagar, will be working on affordable, scalable and minimally invasive RNA-based diagnostic and therapeutic tools for Heavy Menstrual Bleeding (HMB) as part of funding by Gates Foundation.

With the target to enable earlier detection, personalised treatment and improved menstrual health management, particularly for women in underserved regions, the project has been accepted under the Gates Foundation Grand Challenges Support with a financial support of around Rs 1.3 crore.

“The Gates Foundation launched its ‘Grand Challenges’ funding call in February 2025, inviting innovative approaches to address Heavy Menstrual Bleeding (HMB) – a critical yet often overlooked women’s health concern. The Foundation follows a two-step evaluation process, beginning with a Concept Note or Letter of Inquiry (LOI), followed by a full proposal from shortlisted candidates to ensure alignment with global health priorities and scientific rigour. Our proposal was approved for

the support last month and the official letter is expected to be issued on December 2,” Prof Rohini Nair told .

The study will be carried out in collaboration with Dr Rohina Aggarwal, Dean and Head, Department of Obstetrics and Gynaecology at the Institute of Kidney Diseases and Research Centre (IKDRC), Ahmedabad.

Delhi's air quality worsens as AQI nears very poor category after brief respite

>Delhi's air quality worsened again on Monday, with the AQI at 298, just a few notches from the 'very poor' range. This follows a short-lived improvement in air quality to the 'poor' category due to strong winds.

Delhi's air quality worsened on Monday as the AQI inched closer to the 'very poor' category, just a day after strong winds briefly improved the air quality from 'very poor' to 'poor' for the first time in 16 days. At 7 am, the AQI stood at 298 - still in the 'poor' category - as a layer of fog and smoke blanketed the capital, according to the Central Pollution Control Board (CPCB). A brief respite in air quality was observed on Sunday, when the AQI dropped to 279, marking the second-lowest reading for November following a value of 202 on November 5, data from the CPCB-developed Sameer app showed. At least 22 of the city's 39 monitoring stations reported

readings in the 'very poor' category. According to CPCB standards, an AQI between 0-50 is 'good', 51-100 'satisfactory', 101-200 'moderate', 201-300 'poor', 301-400 'very poor' and 401-500 'severe'.
Nehru Nagar in south Delhi recorded the highest pollution levels among city neighborhoods, with an AQI of 351, classified as 'very poor.' In contrast, NSIT Dwarka in the southwest part of the city with an AQI of 195, which falls under the 'moderate' category.
Several well-known pollution hotspots, including Anand Vihar (323), Bawana (337), Burari Crossing (304), Jahangirpuri (319), Mundka (330), Punjabi Bagh (326),

Shadipur (325), and Wazirpur (321), registered AQI readings in the 'very poor' category.
In the National Capital Region, Noida was the most polluted city on Monday, with an AQI of 316, also in the 'very poor' range. Faridabad, meanwhile, was the least polluted among nearby cities, with an AQI of 208, which falls in the 'poor' category. Greater Noida and Ghaziabad reported AQI levels of 288 and 291, respectively, both within the 'poor' range. DELHI'S JAN-NOV AVERAGE AQI LOWEST SINCE 2018
Meanwhile, the



capital recorded its lowest January-November average air quality index (AQI)

since 2018, barring the Covid-induced lockdown year of 2020, the Commission for Air Quality Management (CAQM) said on Sunday.
The average AQI for the period this year was 187, compared to 201 in 2024, 190 in 2023, 199 in 2022, 197 in 2021, 172 in 2020, 203 in 2019 and 213 in 2018, the CAQM said in a statement.
Only three days saw the daily average AQI exceed 400 (severe category) between January and November this year. There were 11 such days in 2024, 12 in 2023, four in 2022, 17 in 2021, 11 in 2020, 16 in 2019 and 12 in 2018.

Delhi horror: Teenager shot dead after minor scuffle in baraat; CISF man held

Delhi Police has arrested a CISF head constable for allegedly shooting a 17-year-old boy during a wedding procession in Shahdara's Mansarovar Park on Saturday evening. What began as a minor scuffle, allegedly while money was being showered in the procession, ended in the death of a teen whose family migrated from Jharkhand as labourers.
Police were alerted by a passer-by who reported that a child had been shot near the Community Centre in the DDA Market. When police arrived, they found the boy with a gunshot wound amid the commotion of a baraat moving through the lane.
He was taken to hospital and declared brought dead. The accused officer, identified as Madan Gopal Tiwari, is posted in Kanpur and was in Delhi on leave to attend the wedding of his cousin, the groom. He was arrested from his hometown Etawah.
Police said the dispute began when a group of children tried to enter the wedding procession, where the groom was on horseback and kin were celebrating. When kin asked the kids to move aside, they reportedly refused, triggering a quarrel. The CISF head constable, who was in Delhi to attend wedding, allegedly shot child in a fit of rage and left for Etawah, police said.
The child's father told that his son on his way back from a shop his son came across the wedding procession and stopped since money was being thrown. "He was collecting some thrown money, which some people there did not like. They beat him up after that. When he did not leave, the man, who was intoxicated, shot him," he said.
The child's brother was present at the spot and ran back home to inform the kin. A source said, "When he gets bail, CISF will initiate an inquiry as per the law. If a person is detained for more than 48 hours, the person is deemed to be suspended."

3 arrested from Shahzad Bhatti-led Pak terror module: Key suspects in Gurdaspur grenade attack, say Delhi Police

The Special Cell of Delhi Police has dismantled a Pakistan-backed terror module allegedly controlled by gangster-turned-terrorist Shahzad Bhatti, who is currently believed to be operating from Pakistan, officers said Sunday. The group was allegedly involved in the November 25 grenade attack outside the City Police Station in Punjab's Gurdaspur.
Additional Commissioner of Police (Special Cell) Pramod Singh Kushwah said three operatives associated with the module have been arrested from Punjab, Madhya Pradesh and Uttar Pradesh.
Those arrested have been identified as Vikas Prajapati alias Betu (19), a resident of Datia in Madhya Pradesh; Hargunpreet Singh alias Gurkaranpreet Singh (19) from Firozpur in Punjab; and Asif alias Arish (22) from Bijnor in Uttar Pradesh.
Police have recovered a semi-automatic pistol, 10 live cartridges and mobile phones containing incriminating chats, as well as reconnaissance videos.
The Gurdaspur attack was allegedly executed on Bhatti's directions, who has been coordinating terror operations using encrypted communication platforms and social media channels. The breakthrough came after investigators began monitoring Bhatti's digital footprints and communication networks. Police found that Prajapati, already wanted in an arms-smuggling case, was in frequent contact with Bhatti. His movement between Delhi and Gurdaspur and Bhatti's repeated instructions to switch off his phone triggered deeper surveillance. Prajapati was arrested after a two-day chase in Madhya Pradesh. During questioning, Prajapati gave details of the module's operations to police, said officers.
Police said Bhatti and his handlers in Pakistan scanned social media profiles to target vulnerable and impressionable youth, luring them with promises of quick money and cult-like gangster glamour.
The recruits were trained remotely, used for reconnaissance missions and deployed as disposable assets for terror strikes. Payments were made digitally to avoid detection.

Apex Court must revisit rulings on environment laws

Last week, a Supreme Court bench led by Chief Justice Surya Kant, sitting with Justice Joymala Bagchi, delivered a reminder that the Court does not have a "magic wand" to clear Delhi's air.
The Bench underscored that the capital's pollution crisis can be addressed only through scientific identification of each contributing factor, vehicular emissions, industrial activity, construction dust, waste burning, seasonal stubble smoke, and other regional influences.
The judges stressed that without a precise identification of sources and a corresponding evidence-based action plan, the annual winter smog will continue unabated. Equally important was the Bench's emphasis on the role of domain experts, scientific bodies, and technical institutions in shaping long-term solutions. The court called for continuous monitoring, coordinated action across jurisdictions, and strict

accountability from implementing agencies. The message was clear that the capital's air emergency requires a governance model that is steady, transparent, and resistant to political or administrative oscillation. It is in



this context that two orders of the Supreme Court earlier this year merit a careful, dispassionate review.
Both the orders were passed in response to petitions, including by the Delhi government and private individuals, seeking relaxations. Both were intended as interim reliefs. And both have had direct implications for the city's pollution profile this winter.

Lost our only breadwinner, says family of 23-year-old killed in Delhi accident

The family of Rohit, the 23-year-old restaurant employee who died after being hit by a speeding Mercedes SUV in southwest Delhi's Vasant Kunj, said their only hope for a better life is lost. According to family members, Rohit was their sole breadwinner, who was saving up to open his own restaurant one day.
The deceased, a native of Chamoli in Uttarakhand, worked as a chef at a restaurant in Ambience Mall and earned around Rs 15,000 a month.
Rohit was killed while two others were critically injured after a Mercedes SUV allegedly rammed into them near Ambience Mall on Nelson Mandela Marg in Vasant Kunj early

on Sunday.
The three men, who worked in a restaurant inside the mall, were



waiting for a vehicle to return to their rented accommodation in Munirka after finishing their shift when the accident took place.
Rohit's family said he had been

supporting his parents and siblings since the age of 20, sending home most of his earnings every month and saving a little for his dream.
"He was the only one earning. Our whole family depended on him," said Rohit's uncle Balwant Singh, holding back tears.
He said Rohit was a soft-spoken and humble person who never raised his voice at anyone. "Today, (without Rohit), we don't know how to handle anything. He was just standing there waiting for a ride home.
The SUV driver destroyed all our dreams," Singh added. Relatives said the news of Rohit's death has left the family, especially his mother, shattered.

Mission Decongest: NCR highway overhaul to transform mobility

With the Centre's ongoing and upcoming national highway projects, travel time around the capital is set to drop sharply, easing congestion and improving commuter experience.

Something is changing in and around the capital. It is fast becoming the most dominant flower around which a bouquet of massive, state-of-the-art highways is being created in the NCR.
Once completed, it will turn the city into an island, which is connected to the national grid of roads while maintaining its infrastructural and access autonomy.
At the heart of this transformation lies one of the largest road infrastructure overhauls in the country, which is aimed at easing chronic traffic congestion in and around Delhi. The Ministry of Road Transport and Highways (MoRTH), as the anchor ministry behind the overhaul, is executing a multilayered strategy involving completed, ongoing, and upcoming national highway projects designed to transform mobility in the

region. It is a massive 2,320 km plan, involving Haryana, Uttar Pradesh, Rajasthan, Punjab, Uttarakhand, and Jammu and Kashmir. The MoRTH data shows that it has already achieved 69 per cent completion.
A need for scale
The MoRTH ministry says the government has already completed planned road development work spanning 1,578 km, which were delivered at a cost of Rs 63,934 crore, while the projects that have been awarded to implementing agencies and are in various stages of completion cover 594 km, worth Rs 34,589 crore. Moreover, the government is planning to execute projects for another 128 km, which will cost around Rs 23,850 crore. At Delhi Dialogues, Union Minister of State for the Ministry of Road Transport and Highways and Ministry of

Corporate Affairs Harsh Malhotra said that the capital region witnessed unprecedented highway development in the past decade, whose momentum would



continue to grow with several more key corridors progressing toward completion. He says, "The ministry has been consistently working to make the national capital and its adjoining areas congestion free. A proper plan has been chalked out,

and it is being executed accordingly. Lots of projects have been executed over a decade, and many more are in the pipeline. In the near future, the entire region will have an augmented network of road infrastructure, which will help to remove traffic deadlocks."
Malhotra said the success of Eastern Peripheral Expressway (EPE) among the completed projects at the top of the list. This 135 km project was one of the first completed decongestion plans for the capital. Conceptualised at an investment of Rs 12,000 crore, it keeps around 95,000 passenger cars away from the Delhi borders every day. It picks traffic from key urban nodes in the NCR, like Kundli, Ghaziabad, Dadri, Greater Noida, and Palwal, and connects them to the Delhi-Chandigarh highway away from the national capital in Haryana.

How a girl who watched the Moon became India's Missile Woman: Tessy Thomas honoured with Dr Paulos Mar Gregorios Award

Long before India knew her as its 'Missile Woman', a young girl in Kerala's Alappuzha used to gaze at the sky with a quiet fascination. "When I returned home in the evenings, I would look at the Moon and feel happy I brought it back with me," Tessy Thomas, 62, recalls. Often, she would step outside at night just to see if it was still there, a ritual that nurtured her curiosity about the universe. Her interests soon expanded beyond the Moon. "When I was young, I was captivated by science and maths. I used to wonder how contrails coming out of an aircraft made marks in the sky." Simple questions like that formed the basis of an extraordinary career that transformed India's missile and defence landscape.
On Sunday, Thomas was awarded Dr Paulos Mar Gregorios Award 2025 by Wajahat Habibullah, former chief information commissioner of India. Instituted by Sophia Society of the Malankara (Indian) Orthodox Church, the award is given every alternate year in memory of first Metropolitan of Delhi Diocese and noted philosopher Dr Paulos Mar Gregorios.
Thomas is the first woman to lead a missile project in the country and a pioneering engineer in defence tech. She was the first Indian woman to be inducted into Aeronautical Society's Space Pioneer Hall of Fame in 2014 and is a recipient of multiple awards.
On the occasion, Dr Youhanon Mar Demetrios, president of Sophia Society, said, "Thomas has demonstrated to women, men and people of all ages that with determination, one can reach any height."
The event was attended by Catholicos Moran Mar Baselios Marthoma Mathews-III, Prof Shyamdas Balakrishna Menon, Rev Fr Dr KM George and Rev Fr Saji Abraham.
Thomas' own leap into advanced science came when she was selected as one of 10 students across India for a specialised missile tech program. "I was fortunate to be guided by Dr APJ Abdul Kalam," she recalls, acknowledging his pivotal role in shaping generations of Indian scientists.
Eventually, she was at the helm of Agni missile program, at a time when the field was heavily dominated by men. Her work was groundbreaking.

Grew up watching Virat Kohli on TV, bowling to him is fun yet annoying: Marco Jansen

South Africa all-rounder Marco Jansen said that bowling to Virat Kohli is both fun and annoying at the same time, following his match-winning hundred in the first ODI in Ranchi. Kohli produced yet another masterclass innings, scoring a phenomenal 135 off 120 deliveries, including 11 fours and seven sixes.Courtesy of his innings, India posted a mammoth total of 349/8 in their allotted 50 overs. Watching Kohli at his vintage best, Jansen recalled his early days of watching the Indian star play on television. He mentioned that it is both fun and annoying to bowl to the Indian batting stalwart, praising him for his wide array of strokes.“It’s nice to watch him play. Growing up watching him on TV, to actually bowling to him now — it’s annoying but it’s fun at the same time. He drives well, he pulls well, cuts well, plays with his pads well. I don’t think much has changed — he’s just batting longer and longer,” said Jansen in the post-match press conference.Jansen, who first bowled to Kohli as a 17-year-old net bowler during India’s 2017-18 tour of South Africa, said that



stopping world-class batters like Kohli becomes almost impossible once they settle in.“When you bowl to world-class players, it’s quite difficult to get them out. I always try to get a batter in his first 10 or 15 balls. That’s when they’re still getting used to the wicket. But once they’re in, and they get on a roll, it’s very difficult to stop them. Everyone here knows how to play — that’s why you go to plan B or C,” he added.Jansen continued his rich form from the Test series, as he scalped two wickets and played a sensational innings of 70 off 39 deliveries to keep South Africa in the hunt for chasing down 350. However, they were eventually bundled out for 332, resulting in a 17-run loss. Following their defeat, he said that the Proteas were not too disheartened by going 0-1 down and believed they were “doing the right things” despite India’s win.“We didn’t bowl too badly. They got early wickets, we were on the back foot, then we pulled it back. It’s just about adding the good things on top of each other, like we’ve been doing in the Test squad,” said Jansen.

Michael Jordan's fight against NASCAR heads to court, could shake up motorsports

Michael Jordan's bitter fight against NASCAR heads to federal court Monday in a jury trial that could rip apart the top motorsports series in the United States.The antitrust allegations leveled by Jordan-owned 23XI Racing and Front Row Motorsports has exposed salacious personal communications, NASCAR's finances and a deep contempt between some of the top executives in the sport and its participants. Three-time Daytona 500 winner Denny Hamlin, who owns 23XI alongside Jordan and less than a month ago had the Cup Series



championship slip through his fingers, warned this weekend that the gloves will be off during the two-week trial in the Western District of North Carolina."Our fans have been brainwashed with (NASCAR's) talking points for decades," Hamlin wrote on social media. "Lies are over starting Monday morning. It's time for the truth. It's time for change."NASCAR Commissioner Steve Phelps has said that the series has tried hard to settle the case ahead of Monday's trial.

What is the lawsuit about?
The lawsuit was filed by 23XI Racing, which is owned by Basketball Hall of Famer Jordan, Hamlin and Jordan's longtime business manager, Curtis Polk. They were joined by Front Row Motorsports, a team owned by entrepreneur Bob Jenkins that won the 2021 Daytona 500. The two were the only teams out of 15 to refuse to sign renewals on the charter agreements NASCAR presented to them in late 2024. All 15 teams had been fighting for more favorable terms in the charter agreements over more than two years of negotiations, and the final terms fell short of what the teams had been seeking. 23XI and Front Row accused NASCAR of being a monopoly and sued under antitrust grounds..

If not for Harshit Rana's early wickets, SA would've easily chased 350: Sitanshu Kotak

Harshit Rana's early wickets helped India defend 349 against South Africa in Ranchi. He finished the match with figures of 3/65 in ten overs helping India register a 17-run victory.

Indian batting coach Sitanshu Kotak credited fast bowler Harshit Rana for his game-changing spell with the new ball during the first ODI against South Africa on Sunday, November 30 at JSCA International Stadium Complex, Ranchi. Rana was phenomenal with the new ball as he dismissed Ryan Ricketton (0 off 1) and Quinton de Kock (0 off 2) in his very first over itself.He further got the crucial wicket of Dewald Brevis (37 off 28) and eventually finished with figures of 3/65 in ten overs. Following Rana’s remarkable performance, Sitanshu Kotak praised the young speedster, saying that if not for his early wickets, India would’ve had a



hard time defending their score of 349. “I think 350 on the same surface, if they were batting, then 350 would definitely be enough. But after so much dew, the bowler can’t even hold the ball properly. The ball is skidding off the wicket and coming straight onto the bat. I

think a lot of credit goes to Harshit as well for taking those early wickets, because otherwise it would have been quite easy for them to score runs in such heavy dew,” said Kotak in the post-match presentation.He also credited Rana for making the new ball talk

and making the most of the swinging conditions.“So, after losing the toss and still winning this game, I think it’s very creditable. I think he was moving the ball well, he was hitting the right areas in the early innings because a Kookaburra ball probably swings for two, four, maybe five overs. So, I think he made the most of it,” he added.Apart from Rana, Arshdeep Singh also started well with the new ball for India, dismissing Aiden Markram (7 off 15). However, crucial innings from Matthew Breetzke (72 off 80), Marco Jansen (70 off 39), Tony de Zorzi (39 off 35), Dewald Brevis (37 off 28) and Corbin Bosch (67 off 51) brought South Africa back in the game. However, Kuldeep Yadav’s (4/68) timely strikes in the middle overs ensured the Proteas didn’t run away with the game. India eventually won the match by 17 runs, bundling out South Africa for 332 and took a 1-0 lead in the series. Virat Kohli was adjudged Player of the Match for scoring his 52nd ODI century. He scored a remarkable 135 (120) with the help of 11 fours and seven sixes.

Sensex, Nifty scale fresh peaks as Q2 GDP surprise lifts market mood

Benchmark stock market indices opened Monday’s session on a strong note as upbeat Q2 GDP numbers lifted sentiment across Dalal Street.Both the S&P BSE Sensex and NSE Nifty50 touched fresh all-time highs in early trade. By 9:24 am, the Sensex was up 309.06 points at 86,015.73, while the Nifty50 rose 84.50 points to 26,287.45.
Broader market indices also edged higher, aided by a sharp drop in volatility—a positive signal for investors tracking near-term stability.JSW Steel, Adani Ports, SBI, TMPV and ONGC were among the top gainers on the Nifty50, while ITC, IndiGo, Tata Consumer Products, Bajaj Finance, Nestle India and Titan were the biggest laggards.Dr VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said the ongoing rally tells an unusual story beneath the headline numbers. “New record at the index level but no celebration in the market is the unique feature of the ongoing rally. For most retail investors, their portfolio values are lower than those at the previous peak of September 2024,” he said.
He explained that the disconnect stems from the narrow nature of the rally. “Eight stocks—HDFC Bank, RIL, ICICI Bank, Bharti Airtel, L&T, ITC, Infy and SBI—have 50% weighting in Nifty. So when 5 or 6 of these heavyweights move up, the index rises. But 330 stocks in NSE 500 are below their September 2024 peak, and those dominate most retail portfolios.”On the macro front, Vijayakumar said the Q2 GDP growth of 8.2%, driven by manufacturing, services and consumption, has the potential to take the market higher. But he flagged concerns as well.
“The modest nominal growth at 8.7 percent due to low GDP deflator is disappointing from the market perspective. A rate cut from the MPC may also not materialise on Friday since the economy doesn’t need a monetary stimulus when it is firing on all cylinders.”Anand James, chief market strategist at Geojit Financial Services, said the Nifty’s chart setup still supports further upside. He noted that despite two consecutive red candles, oscillators have not flagged Wednesday’s surge as an anomaly. He expects dips early in the week but believes they are unlikely to sustain.

FM rolls out new tobacco cess to back health and security funding

CHENNAI.(Agency)
Nifty and the Sensex began the new month on a strong footing, but away from markets, Parliament saw a major fiscal policy shift aimed at reshaping tobacco taxation. Finance Minister Nirmala Sitharaman formally introduced the Health Security and National Security Cess Bill, 2025, a legislative proposal that will replace the soon-to-expire GST compensation cess currently levied on tobacco products such as cigarettes, pan masala and gutkha. The GST compensation cess regime, which was introduced as a temporary measure to protect state revenues after the rollout of GST, is approaching its sunset as the borrowed funds used for compensation are close to being fully repaid.
The new cess marks a structural shift. Instead of channeling a uniform surcharge through the GST system, the government now intends to collect a dedicated cess under a separate statute. The stated purpose is to create a protected revenue stream specifically earmarked for public health programmes and national security initiatives, signaling a policy intent that goes beyond closing a fiscal gap. By linking the cess to health and security objectives, the government is framing tobacco taxation as a tool that serves both consumption deterrence and long-term national priorities.

Rupee hits 89.73, spotlight shifts to RBI as pressure mounts

The rupee sank to an all-time low of Rs 89.73 per US dollar in early trade on Monday, slipping past the previous records near Rs 89.49. The slide comes despite India’s recent strong economic growth numbers: the upbeat macroeconomic backdrop failed to offset pressures from weak capital inflows and shaky trade-deal prospects.The principal drivers behind the rupee’s sharp drop include persistent foreign outflows — across both equity and debt investments — and disappointing flows into the country’s foreign-exchange (FX) system. At the same time, the long-mooted trade agreement between India and the United States remains elusive, dousing hopes that a deal might galvanize dollar-inflows or improve sentiment for the rupee.Importers’ dollar demand is also strong amid a widening trade deficit and hefty foreign-exchange needs, especially for crude oil, raw materials and other imports. This elevated demand for dollars, unbalanced by adequate dollar supply via inflows or export receipts, has exacerbated downward pressure on the rupee.Adding to the strain, hedging activity in the non-deliverable forward (NDF) market has increased, as importers and corporates lock in dollar exposure ahead of uncertainty — amplifying broader dollar demand. Even though the Reserve Bank of India (RBI) has intervened — including occasional dollar sales — the intervention has been insufficient to arrest the slide, and the currency continues to weaken under structural pressures.The implications of this depreciation are mixed. For exporters, a weaker rupee makes Indian goods more competitive abroad, potentially boosting export volumes. Remittances from abroad also convert into more rupees, offering some benefit to households earning in foreign currency. On the flip side, imports — especially of crude oil and other essentials — become more expensive. That raises costs for businesses reliant on imported inputs and pushes inflation up, which could weigh on consumption and production costs across sectors.

Silver hits record high as gold shines. What's the latest bullion rally

The precious metals market is buzzing again as silver hits a fresh record high and gold continues its steady climb. What’s fuelling this powerful bullion rally

The bullion continues to shine. In fact, it is shining more brightly than ever. Gold prices have risen once again, while silver, in particular, surged to a fresh all-time high, lifting overall sentiment in the precious metals market.
GOLD STEADY, SILVER HITS NEW PEAK
Both precious metals traded firm after a sharp rise on Monday. At the time of

writing, gold was priced at Rs 1,30,631 per 10 grams, up 0.87%, while silver stood at Rs 1,77,647 per kg, rising 1.52% on MCX.Analysts say the gains reflect a mix of global uncertainty and higher domestic appetite, especially during the busy wedding season, when demand for jewellery usually spikes.
MARKET EXPERTS SEE STRONG MOMENTUMAHEAD
Rahul Kalantri, VP Commodities at Mehta Equities Ltd, said the broader trend remains supportive for precious metals.Gold heads for a fifth straight monthly gain; silver hits a fresh record high amid Fed rate cut expectations and profit-taking in the dollar index,” he said.
He added that technical indicators have turned favourable for silver.“The technical charts for silver have turned more bullish in the past week or so, and that’s inviting chart-based speculators to the long side of the silver market,” he noted.Kalantri mentioned that safe-haven buying strengthened after a brief halt in CME trading due to a data centre issue, while the weakening rupee also supported



domestic prices. However, he said optimism around a possible Russia–Ukraine peace deal may limit gains in the coming days.
SILVER’S STUNNING RISE OUTPACES GOLD IN 2025
Silver has been the standout performer this year. Dr Renisha Chainani, Head of Research at Augmont, said the metal has delivered extraordinary returns.
“Silver’s price has nearly doubled in just 11 months and risen more than gold, even though gold was the most popular commodity in 2025,” she said.She added that silver’s surge has clearly outpaced gold this year.“Over the past 12 months,

silver has climbed significantly higher than gold, rising 100% in 2025, whereas gold has only increased by 60%.”
WHAT’S DRIVING THE RALLY?
The sharp rise in gold and silver prices is being driven by a mix of global and domestic factors. Investors are expecting a US interest rate cut later this month, which usually supports precious metals.
At the same time, safe-haven demand has increased because of ongoing global uncertainties. In India, the wedding season has added to the buying momentum, while the weaker rupee has pushed domestic prices even higher.Technical charts, especially for silver, have also turned strongly bullish, drawing more traders into the market.Meanwhile, both metals are expected to remain firm in the near term, with global cues and central bank decisions likely to guide the next major move. While silver continues to lead the rally, analysts believe gold will remain well-supported as long as uncertainty persists.

expanding to 19.78%.Growth was broad-based. India remained the core



market, contributing Rs 1,230.6 crore in revenue, higher than both last quarter and the year-ago period.
But the standout story came from overseas operations, where revenue surged to Rs 879.6 crore, up from Rs 736.5 crore in Q1 and Rs 658.3 crore in

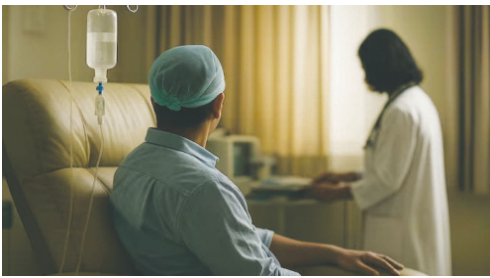

Cancer patients are facing a health insurance crisis. A new study finds early detection rising but coverage thinning, leaving households to manage high bills, multiple claims and growing out-of-pocket expenses.

Cancer patients in India are facing a health insurance crisis, according to a new study by Plum Data Labs of one lakh cancer claims filed between 2023 and 2025.The data shows a country getting better at catching cancer early, yet struggling with a system that cannot financially support patients through modern, multi-stage treatment.India’s stage 0, or in situ, cancers have increased sharply. Their share rose from 29% in early 2023 to

nearly 50% through 2024 before settling at 47% in early 2025. The public summary puts the rise in early-stage incidence at about 72% over the three-year window.But catching cancer early has not reduced the financial load on families. If anything, it has stretched the period over which they must engage with insurers.RISING CLAIMS WITH ADVANCED TREATMENT
A typical cancer patient now files close to four claims a year. One in five files more than five. Advanced cancers push this far higher, with patients filing between 11 and 22 claims over several months.Treatment is no longer a single episode. Surgery, multiple rounds of chemotherapy, targeted therapies, immunotherapy, PET scans, biopsies, radiation sessions and follow-up reviews all fall into separate claims. Each one requires documentation, approval, waiting time and repeated interactions with insurers.This fragmentation creates delays at the worst possible time and leaves families juggling hospital timelines and insurer processes



simultaneously.
THE COST OF CANCER
The case journeys in the deep-dive dataset show how quickly treatment costs escalate.A 40-year-old man treated for head and neck cancer spent Rs 42.44 lakh in just over two months, mostly due to two high-cost hospitalisations.
A 49-year-old woman with leukemia recorded Rs 40.56 lakh in three and a half months.
The pattern repeats across cancer types.
A 76-year-old stomach cancer patient needed seven chemotherapy cycles and three admissions, reaching Rs 33.84 lakh over six and a half months. A 66-year-old

woman with colorectal cancer went through seventeen hospital visits in eight months and ended with a bill of Rs 33.25 lakh.Even early-stage cancer is not spared. A 50-year-old woman with carcinoma in situ stayed in treatment and monitoring for nearly four years and still spent Rs 31.77 lakh.These cases reflect the broader financial map. Colorectal cancer has the highest average cumulative cost at about Rs 5.07 lakh. Brain cancer follows at Rs 4.9 lakh and stomach cancer at Rs 4.53 lakh. Blood and lymph cancers are heavily hospitalisation-driven, with almost 70% of spending occurring inside hospitals.Breast cancer is among the most chemotherapy intensive. Brain cancer has the highest diagnostic burden, with nearly 24% of costs tied to tests before and after treatment.The public-facing dataset adds scale. Across one sample cohort, total cancer treatment costs reached Rs 78.0 crore. Of this, patients paid Rs 23.2 crore out of pocket. Even in insured groups, out-of-pocket spending commonly ranges from 20% to 40% of total cost.

Juhi Chawla may be best remembered for her sparkling chemistry with Aamir Khan in *Qayamat Se Qayamat Tak*, but the early '90s also saw her forming two other major screen pairings — with Shah Rukh Khan and Sunny Deol. In 1993, the year she starred opposite both men in Yash Chopra's iconic *Darr*, Juhi also headlined Dharmesh Darshan's action romance *Lootere* opposite Sunny. For producer Suneel Darshan, *Lootere* remains one of the most defining yet underrated films of her career. "I hold it as one of the most underplayed and important films of Juhi Chawla's career," he said, looking back at the project. Juhi's Hesitation: 'There Were Some Reservations'

While she was the natural choice for the makers, Juhi had a few inhibitions — especially about the film's glamorous, Westernised heroine. "There was a beach song in which she had to just wear a shirt and get wet — 'Main Teri Rani Tu Raja'," Suneel recalled. "So, there were some reservations."

At the same time, rising star Divya Bharti was keen on the film. "Divya wanted to be a part of the movie. But I felt she didn't fit the role," Suneel said. Eventually, Juhi came on board after both he and Dharmesh Darshan agreed she was the perfect fit.

'Girl-Next-Door' to Sensual Lead: A Challenging Transition

Suneel admitted that reshaping Juhi's wholesome, girl-next-door image was a challenge. "Juhi was convinced, but also confused," he said. "It feels like nadaaniyan today, but there's a very cute instance that happened." The "cute instance" involved a crucial lip-to-lip kissing scene between Juhi and Sunny — something extremely rare in mainstream Bollywood in the early '90s. "When we narrated her the film and signed the contract, there was a key lip-to-lip kissing sequence," he revealed. "We saved it for the end. We'd erected a set outdoors, but realized that day that Juhi was missing."

According to Suneel, Juhi used the shoot of another film in Udaipur as an excuse to skip that day's schedule. But the team insisted on filming it later, as it was crucial to the story.

'As Per Contract, I Was Supposed to Do One Kiss'

To ease the process, Suneel suggested shooting the scene with multiple cameras so it could be captured in a single take. Juhi completed the take and immediately grabbed a robe.

With Google being the front runner, companies are now encouraging healthy environment through creatively designed workspaces, world-class sports facilities, recreational rooms, gyms, and even sleep pods for power naps. The workplace's? ha?ve ?become all the more dynamic and fast-paced. Invariably because of long shift hours, the office becomes a second home and the colleagues, an extended family. Sabbas Joseph, Director of one of the leading event management companies, Wizcraft shares, "For keeping the dynamism alive, we always host interesting activities that can help the Wizzes (team members) to get to know each other and more importantly, relieve stress. From quizzes to pop up shops, celebrating festivals together to dedicating an entire room with books and a music system for just 'chilling'; I think it's extremely important for companies, especially those that require loads of creativity, to provide an outlet for people to engage and bond with each other as they serve as the best stress antidotes."? ? Companies have realized the importance of innovation and how encouraging creative activities can boost team morale. Venkatramana B, President, Group HR, Landmark Group India asserts that

Landmark Group strongly believes in a culture of innovation and over the years has benefitted greatly from employee sourced solutions. He says, "Keeping the creative juices flowing is important for us and we continuously organize activities that encourage out-of-box thinking. Play in a Day or Theatre Methodology has been a very successful program for us, where various concepts. Be it business or soft skills, they are explained to employees through theater." He also talks about conducting an interesting engagement activity called Islempix, in which store teams are provided with various Olympic-like tasks and adds, "These activities are not only fun, but also increase employee morale, camaraderie and understanding between team members."
