# Protest In Bengal Against BSF; 'Let Women Object': Mamata Banerjee

In a heated escalation, Mamata Banerjee blames the BSF for pushing Indians into Bangladesh and attacks the Centre for blocking MGNREGA and housing scheme funds.

KOLKATA .(Agency)

West Bengal Chief Minister Mamata Banerjee on Tuesday called on women across the state to step forward and raise their voices against what she described as atrocities committed by the Border Security Force (BSF) in border side regions. Addressing a Trinamool Congress rally at Rashleela ground in Cooch Behar, Banerjee urged women to lead the resistance. "Let our mothers and sisters come forward and speak out against the BSF's actions in the border areas," she said, adding that she wanted to see whether Bengal's women could prove "braver and stronger" than those affiliated with the BJP.

The Chief Minister also appealed to residents to stay united and not be intimidated by Central forces. During an administrative meeting in the district on Monday, she had already instructed the police to respond swiftly to any reports of harassment by the BSF.

Reiterating her stance, Banerjee assured people that no detention camps would be set up in Bengal under her government. "No one will be pushed back. As long as the Trinamool Congress is in power, there will be no detention camps here. We will not bow down to the BJP," she said.

"We are working to bring back the remaining four Bengali-speaking Indian



nationals from Bangladesh," she said, noting that one of them, a pregnant woman, Sunali Khatun, and her eight year old son had already been reunited with their family in Birbhum. "Despite having valid citizenship documents, the BSF pushed them into Bangladesh," she alleged.

In June, six residents of Paikar village in Murarai, Birbhum, were reportedly forced across the border by the BSF on suspicion that they were Bangladeshi citizens. Referring to this, Banerjee linked the issue to the ongoing Special Intensive Revision (SIR) of electoral rolls. She claimed the Election Commission might announce dates for next year's Assembly polls soon after releasing the final voters' list to prevent legal challenges.

She further alleged that names of genuine voters were being removed during the revision process, even claiming that "people who are alive are being marked as dead" in the updated rolls.

# In rare unity, Rahul Gandhi's air pollution discussion call gets government nod

Rahul Gandhi pressed the Lok Sabha for an urgent and structured discussion on worsening air pollution, calling it a cross-party public health emergency. The government signalled readiness, with Kiren Rijiju saying a discussion will be scheduled soon.

#### New Delhi.(Agency)

Congress MP and Leader of Opposition in stressed that this was one of the rare issues pushed for an urgent and structured discussion on India's worsening air

pollution in Parliament, framing it as a public health emergency that cuts across party lines. The government signalled it was willing to take up the discussion.

Rising to speak during Zero Hour, the Congress leader said India's biggest cities were living under a blanket of poisonous air.

"Most of our major cities are living under a blanket of poisonous air. Millions of children are getting lung disease. Their future is being destroyed. People are getting cancer. Older people are struggling to breathe. This is an interesting

issue because I'm certain that there will be full agreement between the government and us on this issue," Gandhi said.

Furthermore, the former Congress president Lok Sabha Rahul Gandhi on Friday on which the House could find complete unanimity. "This is not an ideological



issue," he said, adding that both the government and the Opposition shared the responsibility to respond. He urged the government to allow a full debate and commit to concrete measures. Responding to Rahul Gandhi's suggestion, Parliamentary Affairs Minister Kiren Rijiju said the government was ready for a

> discussion on the issue and the Business Advisory Committee of the Lok Sabha can allot time for the same.

# **Jagan Mohan Reddy's Party Says Silk Shawls Scam 'Longstanding' Issue, Blames TDP**

#### New Delhi .(Agency)

In Andhra Pradesh, the faith has once again been shaken by revelations of a major fraud involving the Tirumala Tirupati Devasthanam's (TTD) shawls and dupatta supplies.

For years, TTD had been procuring items labelled as "pure silk," only to discover they were actually made of synthetic material.

"A major scam involving silk dupattas. A shawl costing around Rs 350 was being billed at over Rs 1300, leading to a total supply exceeding Rs

50 crore. TTD has requested an ACB probe into this matter," said Tirumala Tirupati Devasthanam's (TTD) chairperson BR Naidu.

TTD vigilance probe revealed that the so-called mulberry silk shawls and dupattas supplied to the temple were actually polyester. The fraud, which spanned from around 2015 to 2025, is estimated to have resulted in losses exceeding Rs 54 crore.

Central Silk Board laboratories conducted tests and confirmed that the items lacked genuine silk certification. The case is

now expected to be investigated by the Anti-Corruption Bureau (ACB). This decade-long fraud has led to intense exchanges between the ruling TDP-led NDA and the YSRCP.

Former Chief Minister YS Jagan's party YSRCP, has accused the scam of not being a recent occurrence but rather a longstanding issue during the TDP's tenure. YSRCP leaders argue that inadequate monitoring and unchecked procurement practices from the past years allowed this scam to remain undetected.

The party also accuses the current NDA government of exploiting the issue for political gain and using it as a weapon against its opponents. YSRCP state spokesperson and former TTD Chairman Bhoomna Karunakar Reddy strongly criticised the coalition government, accusing it of repeatedly harming Hindu sentiments and using Tirumala as a



action in response to the scam.

"From 'Samajwadi', Siddaramaiah is now 'Majawadi'. He avoids roads because of the poor conditions. The people of the state are paying for his air travel," Ravi said.

# 2 of 4 AQI monitors offline, Gurgaon sees 'poor' air

Gurgaon.(Agency)

The city's air continued to remain at 'poor' level on Thursday, with the air quality index (AQI) reaching 268, according to the data from CPCB. Only two of the city's four monitoring stations were working. At NISE Gwal Pahari, the AQI stood at 236 and Vikas Sadan recorded a higher 291. The missing data at Sector 51 and Teri Gram stations raised the possibility of the pollution level being understated. According to India Meteorological Department (IMD), the city saw a maximum temperature of 24.1 degrees Celsius on Thursday. The minimum temperature was 9.5 degrees Celsius.

The weather department has said no major change in the temperature for the next four days is likely, dense fog in isolated areas has been forecast. In the national capital, shallow morning fog is likely on Friday. Maximum temperatures may be in the 23-25°C range and minimum temperatures around 7-9°C. Minimum temperatures will remain below normal, and winds will stay weak, generally under 10kmph.Saturday and Sunday are expected to bring partly cloudy skies and shallow morning fog. Winds will remain light, mostly below 12kmph in the afternoons and dropping further in the evenings. Mixing depth is forecast at 1100m on Dec 10, tightening to 800m by Dec 12. Air quality is likely to stay in the poor range on Thursday and turn very poor from Dec 11 to 13. Meanwhile, after two consecutive days of poor AQI, Delhi's air quality deteriorated to very poor on Thursday. The AQI was 305 as opposed to 259 a day earlier. No respite is likely in the next few days as air quality is expected to remain in this range.

## 'Missing' voters to be reverified after SIR rolls pushed to Dec 31

Noida.(Agency)

The district administration has ordered booth-level officers (BLOs) to carry out a fresh round of verification of voters marked as "absent, shifted or dead" (ASD), as part of a final push to clean up electoral records before the draft rolls are published on Dec 31.

The directive follows a decision by the Election Commission of India (ECI) to extend the Special Intensive Revision (SIR) enumeration period in six states and Union Territories, including UP, after state chief electoral officers sought more time. Under the revised schedule, UP's enumeration window has been extended from Dec 11 to Dec 26, with the publication of draft rolls moved to Dec 31 from Dec 16.

In Noida, where 1,868 BLOs are responsible for the verification exercise, 1,321 have already completed full digitisation of voter forms. These officers have now been instructed to set up verification camps at their respective booths, publicly announce the names of voters tagged in the ASD category, and confirm their status before the draft list is finalised."BLOs who have completed 100% digitisation have been told to reverify entries marked as absent, shifted or dead. The aim is to minimise claims and objections after Dec 31," said additional district election officer and ADM Atul Kumar. Officials said the district has reached 75% digitisation of electoral forms, but only 58% have so far been mapped against the 2003 base roll used to verify continuity in voter records. Another 17% remain unmapped. Currently, around 4.3 lakh of the district's 18.7 lakh voters, or 23%, are marked in the ASD category. Noida accounts for the highest share of ASD entries within the district. Of its 7.7 lakh voters, 27% have been flagged: over 1% as deceased, 11% as untraceable, 13% as permanently shifted and more than 1% as duplicate entries. In Dadri, which has 7.3 lakh voters, 19.5% fall in the ASD bracket, while Jewar has marked 19% of its 3.7 lakh voters in the category. The pattern is broadly similar in neighbouring Ghaziabad, though officials said digitisation lags at 59%. More than 24% of forms have been mapped with the 2003 rolls, while 37% remain unmapped. Around 36% (over 10 lakh names) of Ghaziabad's 28.4 lakh voters are currently classified as ASD and may be liable for deletion if not verified in time.

## Friends' reunion, a trip from Kerala: All for a bite of Apple moment as first Noida store opens

Had there been a fan trophy for the occasion, Krishnan would have been a clear winner. In the continuous throng of visitors who wanted to be a part of the "moment" – the launch of the first Apple Store in the city - the young IT professional had made the longest dash."I had missed the Mumbai and Delhi launches as I was not in town at that time. I wanted to see the countdown live," said Krishnan, who flew in from Kerala, undeterred by the IndiGo crisis. He simply had to be here. "I saw videos of the other stores opening and wanted to experience what it's like when the doors open for the first time," the Apple fan gushed during the launch at Mall of India on Thursday, the American phonemaker's first store in UP, second in Delhi-NCR and fifth in India. For Puneet Bhardwaj, who came all the way from Agra, the launch of the Apple store became the backdrop for a special moment – a reunion with his college friends years later. They planned it, all dressed identically, and did their photo op as soon as the gates opened at 1pm. "We did not want to miss the countdown experience, the crowd echoing 3, 2, 1 in unison. We delayed our reunion so that we could do this together," he said. Saddam, who too was at Noida Apple during the launch, said he had taken a day off from work and came from Faridabad to explore the store. "Authorised resellers only keep basic products and don't have an extensive range. If you ask them a technical question, half the time they don't have detailed answers," he said, standing near the display of iPad accessories. The store experience was just as he had expected with 80 trained representatives available at hand to answer all questions thrown at them and demonstrate features to buyers. Existing Apple users said the store had practical benefits for them. "The biggest will be service and expertise," said one. Another said it will spare the drive to Saket for troubleshooting her iPhone.

# Map Aravalis and submit clear forest definition, high court tells Haryana

Punjab and Haryana high court has asked the Haryana govt to place on record a clear and legally sound definition of what constitutes the Aravali forest landscape in the state. The matter will next be heard on Jan 9, 2026, when the state is expected to place its affidavit before the court "mapping the exact area" covered under the Aravalis in line with earlier Supreme Court rulings and a fresh apex court judgment delivered last month.

The bench of Chief Justice Sheel Nagu and Justice Sanjiv Berry on Tuesday — while hearing a public interest litigation filed by activist Harinder Dhingra — directed principal chief conservator of forests (PCCF) Vineet Kumar Garg to "finally place a legally defensible" Aravali map on record, something the state has never done despite recurring ecological conflicts in Gurgaon, Faridabad, Nuh and Mahendragarh. The timing is crucial. The region continues to face pressure from

real estate expansion, road projects, mining and repeated attempts to alter land classifications.PCCF Garg said the department would begin compiling the required information. He told TOI, "The forest department would seek datasets from the mining department and Haryana Space Applications Centre, examine the court's order once received and prepare the compliance report within the stipulated time. We also have Forest Survey of India data, which we will also analyse before submitting."The affidavit is expected to clearly state how much land qualifies as forest based on the SC's interpretation and outline the boundaries of the Aravali ecosystem as recognised in law, not just revenue notations.Precise identification of Aravali forest areas has been central to disputes over the diversion of gair-mumkin pahar land, forest patches falling under the Godavarman ambit and zones where the state has been asked to halt or regulate

Ranges. She, however, submitted that if the definition as suggested by the committee is adopted, a larger area would be included as part of the Aravali Hills and Ranges." Environmental analyst Chetan Agarwal said, "The definitional exercise will have major implications. If the 100-metre height criterion is applied, nearly 90% of Haryana's Aravalis fall out of the definition. Keeping the present scenario in mind, the HC's direction is significant because it requires the state to explain the area using both FSI data and its own

construction. Dhingra had sought clarity on the extent of Haryana's Aravali land and the status of forest protection across the range. The bench cited long-standing directions issued by SC in the TN Godavarman forest conservation matter, which for nearly three decades has guided how states must identify and safeguard forest land irrespective of revenue classifications. The HC also relied on the SC's Nov 29, 2025, judgment in an interlocutory application related to the Godavarman case. That order bluntly acknowledged the definitional gap that

#### Greater SPR back on drawing board, set to link new sectors with NH8, KMP

Gurgaon.(Agency)

If the govt has its way, Greater Southern Peripheral Road (GSPR) will bridge the connectivity gap between new sectors and the city's main arteries. Union minister Rao Inderjit Singh has called for the revival of GSPR project, which is aimed at alleviating traffic congestion and enhancing connectivity between Delhi, Gurgaon, and the industrial hub of Manesar. The project, estimated to cost around Rs 12,000 crore, is designed to link new sectors with Delhi-Jaipur Highway and KMP Expressway.

Underlining the necessity of Greater SPR, Inderjit emphasised its role in easing the mounting urban traffic pressure in the city and urged officials to expedite land acquisition. "After the construction of Greater SPR, the sectors of new Gurgaon will be directly connected to Delhi-Jaipur Highway and Manesar," he said. The minister held a series of discussions with deputy commissioner Ajay Kumar, HSVP administrator Vaishali Singh, and GMDA officials about the project, which will provide direct connectivity for new sectors to Delhi-Jaipur highway and KMP Expressway."This road is expected to be more like an outer ring road of the city," said an official, adding that the stretch will not only benefit villages along the road, but it will also help reduce traffic congestion on Delhi-Gurgaon Expressway. Reduction in traffic jams on the expressway will also help cut

# Smuggled imports sold at vend via BYOB, evading taxes

Gurgaon.(Agency)

The smuggled imported liquor seized from the city on Wednesday was being sold at a vend, along with legal stock, at a discounted rate. The liquor store, located near Signature Towers on Delhi-Gurgaon Expressway, also operated a BYOB (Bring Your Own Bottle) facility, which drew a large crowd from across NCR due to the availability of low-priced imported liquor. The price difference gave this vend a competitive edge, allowing it to register sales of Rs 40-50 lakh in a single day. Officials involved in the investigation said the liquor was imported via ships and distributed to urban liquor vends through an organised network. The police are now working to trace this network and identify those involved. "We are still investigating how the network operates and how smuggled liquor managed to reach the city, evading customs and excise duty," said an excise dept officer. The smuggled liquor was stored in two specially created rooms behind the vend and sold alongside legal

stock at a reduced rate. Vikram Yadav, who has been in the liquor business for years, said the investigation should focus on how this liquor stock reached the vend and was sold at a lower price. "There is a huge difference in price between the smuggled imported liquor, which does not pay any kind of taxes, and legal imported bottles available at liquor vends. The price difference gives an advantage to those who are involved in such illegal practices," he said.

Another liquor vend owner questioned the efficiency of the excise department in curbing such practices. "How is it possible that some people manage to bring such a large quantity of smuggled liquor and sell it in the open market, and the excise department remains unaware of it?" he asked, calling for an inquiry into the department's operations. In response to the massive seizure of smuggled liquor in Gurgaon, the excise department plans to conduct random inspections and checks of liquor vends to prevent such 'The teams have been asked to conduct random inspections at liquor vends and check their inventory for irregularities, if there are any," said an excise department official. On Thursday, the manager of the liquor vend was arrested in connection with the case. However, owners of the vend, from which around 3,920 cases and 174 bottles of premium imported liquor were seized, remain at large. These bottles, stored at a warehouse located at L-1/L-14A, lacked the mandatory hologram trace strips. The accused, identified as Ajay (26) from Fatehabad's Nadhauri,

revealed during the interrogation that he was the manager of the wine shop where the foreign liquor was stored under his supervision. He will be produced in court for police remand. "During police remand, the accused will be intensively interrogated about his involvement in bringing and storing the recovered liquor," said a police spokesperson. Further action will be taken based on the

# Another Nuh lawyer held in espionage, terror-funding case

The special investigation team (SIT) on Wednesday arrested another lawyer from Nuh in the Pakistani espionage and terrorfunding case, weeks after the arrest of a lawver from the district.

A resident of Bhagon village in Haryana's Tauru subdivision, Nayub had been detained for questioning three days ago. police sources said. Nayub is an associate of Rizwan, who was arrested on Nov 26.

After sustained interrogation, investigators arrested Navub on charges of facilitating hawala routes and terror-funding transactions in coordination with Rizwan, who had been practising in Gurgaon and Nuh courts.Police said that Nayub travelled to Punjab several times with Rizwan and also practised law with him in Gurgaon. They also met with an accident in Punjab while they were returning to Nuh with cash. Earlier, after Rizwan's

arrest in Nuh for allegedly spying for Pakistan, SIT nabbed four of his associates in Punjab, in whose accounts he allegedly transferred money. A Jalandharbased sweet shop owner, Ajay Arora, who allegedly managed money transactions, was arrested. Then investigators arrested Sandeep Singh alias Gagan, Amandeep Singh and Jaskaran of Amritsar, in whose accounts multiple suspicious transactions were made by Rizwan. The investigators swung into action after they traced the movement of cash routed from Pakistan through a hawala network. The money was distributed across Punjab and handed over to operatives linked to narcotics trafficking, according to SIT.During the investigation, Rizwan led SIT to several locations in Amritsar, including Golden Gate, various points on Jalandhar-Attari Road bypass and Shahkot. He claimed to have received cash in multiple instalments

at these sites. At Shahkot, both Rizwan and Ajay identified a sweet shop, run by the latter's family, as the spot for money

Rizwan confessed to paying Rs 34 lakh to
Ajay in three to four instalments, linking
Although HSVP, earlier known as HUDA, these payments to the money he collected in Punjab and distributed further along the chain. SIT later recovered Rs 55,000 from Ajay, which he described as his "commission amount", from a locker in an almirah at his Shahkot home. The investigation began on Nov 25 when constable Rinku, stationed at Sadar Tauru police station, received information that Rizwan was receiving hawala money from Pakistan's ISI-linked operatives for activities, including espionage and narcosmuggling.transactions in Rizwan's PNB account and his frequent visits to

# No one gives jobs': How murder-accused tag has made them unemployable despite bail in Akhlaq case

Noida.(Agency)

For the men once named as accused in the Akhlaq murder case, life has never returned to normal. The "murder accused" label has followed them long after their release on bail, shutting most doors to employment and leaving families in a limbo. The 2015 murder case, which began with an FIR naming 10 persons and later expanded to 18 accused, has left its mark on every individual involved. Two of the accused, Ravi and Rohit, have died — one in judicial custody and the other in a workplace accident. Three were declared juveniles. The rest, now out on bail, have found themselves virtually unemployable, with both govt offices and private companies unwilling to hire

Rupendra (32) was a law student when he was named as the main accused. Unable to find work, he now sells chole-kulche from a thela in the village, a far cry from his earlier ambitions. Vivek (30) continues to work as an electrician, while his younger brother Sachin, who was a minor at the time, works as a labourer.



Brothers Hariom and Shriom also earn daily wages, having failed to secure stable jobs.Sandeep, who was unemployed before the incident, now runs a small auto-parts shop. Saurabh is jobless, but his brother Gaurav has managed to find work with a private company in Greater Noida. Vinay, once a home guard, lost his job after his arrest and remains unemployed. Hariom, previously jobless, now drives a

van, ferrying schoolchildren. Puneet, another minor at the time, works as a security guard. Arun, now 40, still works as a vet in Bisada, but the case, he said, had destroyed his professional network. "I was arrested after the incident and spent 18 months in jail. I had a toddler and my wife was pregnant at the time. She delivered our baby while I was still in jail. I spent nearly Rs 7-8 lakh on the legal battle. After

bail, I lost my network and my livelihood suffered. Alongside my vet work, I now buy and sell fly ash to make ends meet," he said. Vishal Rana (29) was pursuing a pharmacy degree when he was arrested. He spent nearly 22 months in jail, abandoned his studies, and struggled to find work after his release. "The case was in the limelight for years, and it tarnished the name of Bisada and the people involved. No

started a restaurant in Surajpur area," his father, Sanjay Rana, recalled.

# Afghan polio survivor's sock factory provides hope by employing disabled workers

HERAT. (Agency)

In a tiny room in the center of Herat, Afghanistan's westernmost city, Shahabuddin uses his hands to propel himself along the floor to a freshly-made pile of socks waiting to be sorted and packaged. A double amputee since a roadside bomb took both his legs a decade ago, when Afghanistan was mired in conflict between U.S.-led forces and Taliban insurgents, the 36-year-old father of four had struggled to find work. Unemployed for the last decade, he had been forced to rely on relatives for his family's survival.But a new sock production workshop in Herat employing only disabled workers has given him new hope."I became disabled due to the explosion. Both my legs were amputated," Shahabuddin, who like many Afghans goes by only one name, said during a brief pause in his work in early December. "Now I work here in a sock factory, and I am very happy that I have been given a job here."The workshop is the brainchild of Mohammad Amiri, 35, a former grocery shop worker who started the business about a month ago. Amiri, himself disabled by childhood polio, wanted to create jobs and help provide income for other people with disabilities, particularly as many of them were injured during the conflict and have no other means of income. He teamed up with another polio survivor to start the sock factory with a workforce of men disabled either through traumatic injuries or because of congenital issues or other reasons. They make four types of socks: long and short, for winter and summer. "The factory, which is funded and supported by people with disabilities, began operations last month and currently employs around 50 people with disabilities," Amiri said. "They are busy in the production, packaging and sale of socks in the city." A combination of decades of conflict, a weak health care system and struggling economy have contributed to high levels of disability in Afghanistan. Data from a 2019 Model Disability Survey conducted by The Asia Foundation nonprofit organization indicates that nearly 25% of adults live with a mild disability, while 40% have moderate and about 14% have severe disabilities.

## Hong Kong's pro-democracy media tycoon Jimmy Lai's national security trial verdict on December 15

**HONG KONG.(Agency)** 

Hong Kong pro-democracy media tycoon Jimmy Lai will receive the verdict in his national security trial on December 15, a court website showed.

Lai, who turned 78 this week, is charged with foreign collusion under Hong Kong's national security law, which Beijing imposed following huge and sometimes violent pro-democracy protests in 2019.

The founder of the Apple Daily newspaper has been behind bars since late 2020, reportedly in solitary confinement, with Western nations and rights groups calling for his release.Lai's case is scheduled for a 60-minute hearing "for verdict" before a three-judge panel at 10 am (0200 GMT) on Monday, according to a court diary item seen on Friday. Aside from the collusion offence -- which could land him in prison for life -- Lai is also charged with "seditious publication", with prosecutors citing 161 items including op-eds with Lai's byline. Hong Kong authorities have repeatedly rejected criticism related to Lai, saying that his case was "handled strictly on the basis of evidence and in accordance with the law".

During his trial, which began in December 2023, Lai denied calling for sanctions against China and Hong Kong as a whole and said he never advocated separatism or violent resistance."The core values of Apple Daily are actually the core values of the people of Hong Kong... (including) rule of law, freedom, pursuit of democracy, freedom of speech, freedom of religion, freedom of assembly," Lai said in his testimony. Lai is a British citizen, and his son Sebastien voiced new concerns last week over the mogul's health.

# "1 H-1B Worker Equals 10 Illegal Aliens": US Pollster's "De-Indianise" Call

Mark Mitchell, a leading US commentator and pollster, stirred a row after suggesting that major US firms should "de-Indianise" themselves. Attack On H-1B VisaSpeaking at 'The War Room' podcast with Stephen Bannon, Mitchell hit out at Indian dominance in the H-1B visa programme and said sending back a senior H-1B developer working at top firms like Apple was economically the same as deporting ten illegal aliens."But for every single H-1B, you know, senior developer at Apple that we send back, that's the equivalent economically, probably, of deporting ten illegal aliens. So, I don't know why we didn't do that yesterday. And the idea, yes, a lot of these people are entry level, but a lot of them are making a tonne of money," he said in the podcast released on December 8.The American pollster claimed 12 million American tech workers were left jobless because the "foreign-born workforce" has 'indificated' Silicon Valley.

# **Thailand's Parliament** dissolved ahead of new elections early next year

BANGKOK . (Agency)

Thailand's Parliament was dissolved Friday for new elections early next year in a country engaged in deadly fighting with Cambodia.

Prime Minister Anutin Charnvirakul dissolved the House of Representatives after getting approval from King Maha Vajiralongkorn, whose endorsement became effective Friday with its publication in the Royal Gazette. Anutin had signaled the move with a Facebook post late Thursday saying: "I'd like to return power to the people."The election must be held 45 to 60 days after the royal endorsement, a period during which Anutin will head a caretaker government with limited powers that cannot approve a new budget.

His action comes at a tricky political moment, as Thailand is engaged in large-scale combat with Cambodia over long-disputed border claims. About two dozen people were reported killed in the fighting this week, while hundreds of thousands have been displaced on both sides. Anutin has been prime minister for just three months, succeeding Paetongtarn Shinawatra, who served only a year in office.

Anutin won the September vote in Parliament with support from the main opposition People's Party in exchange for a promise to dissolve Parliament within four months and organize a referendum on the drafting of a new constitution by an elected constituent assembly, The party, which runs on progressive platforms, has long sought changes to the constitution, imposed during a military government, saying they want to make it more democratic. The issue of constitutional change appeared to trigger the dissolution, after the People's Party prepared to call a no-confidence vote Thursday. That threat came after lawmakers from Anutin's Bhumjaithai Party voted in favor of a bill to amend the constitution that the opposition party felt ran against the spirit of the agreement they had reached in September.

The People's Party holds the largest number of seats in the House of Representatives and is seen as the main challenger to Bhumjaithai. As news of the pending dissolution circulated late Thursday, its leaders said they hoped Anutin would still honor the agreement to arrange a constitutional referendum. Anutin had served in Paetongtarn's former government but resigned from his positions and withdrew his party from her coalition government in June in the wake of a political scandal related to border tensions with Cambodia.Paetongtarn, daughter of former Prime Minister Thaksin Shinawatra, was suspended from office in early July after being found guilty of ethics violations over a politically compromising phone call with Cambodia's Senate President Hun Sen ahead of July's armed conflict.

# Myanmar military strikes a hospital in a rebelcontrolled area, killing 34 and injuring 80 people

BANGKOK .(Agency)

An airstrike by Myanmar 's military destroyed a hospital in an area controlled by a leading rebel armed force, killing 34 patients and medical staff, according to a rescue worker and independent media reports Thursday. About 80 other people were injured in the attack Wednesday night on the general hospital in Mrauk-U township, an area controlled by the ethnic Arakan Army in the western state of Rakhine. The military, which took over Myanmar's government in 2021 and has been fighting ethnic militias and armed resistance forces since then, has not mentioned any attack in the area. Wai Hun Aung, a senior official for rescue services in Rakhine, told The Associated Press that a jet fighter dropped two bombs at 9:13 p.m. with one hitting the hospital's recovery ward and the other landing near the hospital's main building.He said he arrived at the hospital early Thursday to provide assistance and recorded the deaths of 17 women and 17 men. He said that most of the hospital building was

destroyed by the bombs, and taxis and motorbikes near the hospital were also damaged.Rakhine-based online media posted photos and videos showing damaged buildings and debris



including medical equipment. The hospital has been the main source of health care for people in Rakhine, where most hospitals have closed because of Myanmar's civil war, said Wai Hun Aung.It was reopened after doctors gathered in Mrauk-U to provide much-needed medical services.Mrauk-U, located 530 kilometers (326 miles) northwest of Yangon, the country's largest city, was captured by the Arakan Army in February 2024. The Arakan Army is the well-trained and well-armed military wing of the Rakhine ethnic minority movement, which seeks autonomy from Myanmar's central government. It began its offensive in Rakhine in November 2023 and has seized a strategically important regional army headquarters and 14 of Rakhine's 17 townships. Rakhine, formerly known as Arakan, was the site of a brutal army counterinsurgency operation in 2017 that drove about 740,000 minority Rohingya Muslims to seek safety across the border in Bangladesh. There is still ethnic tension between the Buddhist Rakhine and the Rohingya.

Myanmar's shadow National Unity Government, established by elected lawmakers who were barred from taking their seats in 2021, condemned the airstrike. The organization urged the international community to pressure the military to end its actions, take action against perpetrators and provide humanitarian assistance as soon as possible.

# China's new 'condom tax' draws skepticism and worries over health risks

China will soon start collecting a valueadded tax on contraceptive drugs and products for the first time in over three decades, a move aligned with Beijing's effort to get families to have more children after decades of limiting most to one child. 'Contraceptive drugs and products" will not be tax-exempt as of Jan. 1, according to the country's newest value-added tax law. Products such as condoms will be subject

to the usual 13% value-added tax imposed on most products. While state-run news outlets have not widely highlighted the change, it has been trending on Chinese social media, drawing ridicule among people who joked they'd have to be fools not to know that raising a child is more expensive than using condoms, even if they are taxed.More seriously, experts are raising concerns over potential increases in unplanned pregnancies and sexually transmitted diseases due to higher costs for contraceptives.The ruling Communist Party's past "one-child" policy was enforced from about 1980 until 2015 with

sometimes with forced abortions. In some cases, children born over the limit were deprived of an identification number, effectively making them non-citizens. The government raised the birth limit to two children in 2015. As China's population began to peak and then fall, it was lifted to three children in 2021. Contraception has been actively encouraged and easily accessed, even for free."That's a really ruthless mve," said Hu Lingling, mother of a 5-year-old who said she is determined not to have another child. She said she would "lead the way in abstinence" as a rebel."It is also hilarious, especially compared to forced abortions during the family planning era," she said.

In 2024, 9.5 million babies were born in China, about one-third fewer than the 14.7 million born in 2019, according to the National Bureau of Statistics. That's despite a higher-than-usual birth rate driven by a traditional preference to give birth in the Year of the Dragon, according to Chinese astrology.

"They used to control the population, but now they are encouraging people to have more babies; it is a return to normal methods to make these products ordinary commodities," Yi said. As is true in most places, most responsibility for birth control in China falls to women. Condoms are used by only 9% of couples, with 44.2% using intrauterine devices and 30.5% female sterilization, followed by 4.7% male sterilization, according to research released by Bill & Melinda Gates Foundation in 2022.

## Security forces recover arms, explosives; arrest suspect in Manipur

Security Forces on Wednesday recovered a substantial cache of arms and explosives during intensified intelligence-based combing, cordon and search operations in Jiribam district, even as police arrested one individual linked to extortion and criminal activities in Kakching on Thursday.

## Victim's parents move SC against acquittal or computation of death sentence

The family of four-year-old murder victim Yug Gupta has moved the Supreme Court challenging the Himachal Pradesh High Court's September 23 judgment that commuted the death sentences of two convicts and acquitted the third.

Family sources told UNI that Yug's father, Vinod Gupta, has filed a Special Leave Petition (SLP) before the apex court, which has been accepted for hearing.

The case, which shook Shimla in 2014, saw the district and sessions court convicting Chandra Sharma, Vikrant Bakshi, and Tejinder Pal on September 5, 2018, awarding all three the death penalty for kidnapping, torturing, and murdering the child. The conviction was based on more than 100 witness testimonies and a 2,300page CID charge sheet.

However, the High Court modified the verdict on September 23, 2025. A division bench of Justices Vivek Singh Thakur and Rakesh Kanthla held that the record did not show the convicts to be beyond reform and reduced the death sentences of Chandra Sharma and Vikrant Bakshi to life imprisonment "till their last breath." Tejinder Pal was acquitted for lack of evidence.

Family members, speaking to, expressed deep anguish over the judgment. They said the acquittal of Tejinder, who allegedly kept Yug confined and assisted in transporting him in a cardboard box, had "shattered" them. They demanded that he not be issued a passport and that no parole be granted to Chandra Sharma.

Vinod Gupta stated that despite enduring an 11-year struggle, the family continues to believe that only the death penalty would constitute justice for their son. "We have full faith that the Supreme Court will restore the punishment awarded by the trial court," he said. The infamous crime still sends shivers down the spines of Shimla residents, who recall how, in 2014, a four-year-old child was kidnapped for ransom, forced to consume liquor, tied to a heavy stone, and drowned in a Municipal Corporation water

## Mahayuti finalises election strategy for upcoming civic elections

The ruling Mahayuti alliance has reportedly finalised its formula for seat-sharing in the upcoming municipal corporation elections.

The agreement outlines how the three constituent parties — the BJP, the Eknath Shinde-led Shiv Sena, and the Ajit Pawar faction of the NCP — will contest in key municipal bodies across Maharashtra.

According to sources, the three parties will jointly contest elections in major corporations including Mumbai, Thane, Kalyan-Dombivli, Nashik and Nagpur. In Mumbai, discussions on seat-sharing have progressed significantly, with both sides moving towards a consensus. The Shiv Sena (Shinde) is said to be firm on a 50:50 formula, while final adjustments are being

However, in Pune and Pimpri-Chinchwad, the strategy will be different. Here, the BJP and NCP (Ajit Pawar) will contest separately, rather than as allies.

Both parties have strong local bases in these two cities. To ensure maximum opportunities for local leaders, avoid internal conflict, and prevent rebellion, the alliance has decided not to enforce a unified formula in these regions. By contesting independently, the parties hope to win more seats collectively and push opposition parties to the sidelines a move seen as part of Mahayuti's broader electoral strategy.

# 3,341 ha land acquisition delay stalls key Railway projects in Karnataka: Vaishnaw

As per the agreement, land is to be provided free of cost by the State.

Several key railway projects in Karnataka has by the state government, even as the Centre has significantly increased budgetary support for infrastructure development in the region.

In a written reply to the Lok Sabha, Railway Minister Ashwini Vaishnaw said, overall, Karnataka requires 9,020 hectares of land for various projects, of which 63% (5,679 ha) has been acquired, while 3,341 ha is still

Karnataka has risen from Rs 835 crore per year during 2009-14 to Rs 7,564 crore in 2025-26, an increase of more than nine times. As of April 1, 2025, a total of 25 sanctioned projects, including 15 new lines and 10 doubling works covering 3,264 km and costing Rs 42,517 crore, fall completely or partly within Karnataka. Of these, 1,394 km have been commissioned so far, with an expenditure of Rs 21,310 crore.

Recently completed projects include the Kottur-Harihar, Hassan-Bengaluru, Bidar-Gulbarga and several other doubling projects across Shivamogga, Bengaluru, Mangaluru, Arsikere and Hubballi regions.

Meanwhile, major ongoing projects such as the Hospet-Hubli-Londa-Vasco doubling, Hotgi-Gadag doubling and new lines like Gadag-Wadi, Bagalkot-Kudachi, Tumkur-Rayadurga and Tumkur-Davangere continue to progress, the minister said.

## **Uttarakhand school** children to get escorts to prevent animal attacks

Dehradun. (Agency)

Uttarakhand government will provide escort facilities to school-going children to safeguard them from wild animal attacks in the hill areas.

An instruction to this effect was passed by the Chief Minister Pushkar Singh Dhami in view of rising man-animal conflicts in the hill areas of the state.

Speaking to the forest department officials, Pushkar Singh Dhami on Thursday ordered that adequate arrangements must be made jointly by the district administration and forest department to provide escorts to the school going children as the cases of man-animal conflicts, mainly leopard attacks, have increased in the recent past.

"In areas with greater fear of wild animals attacks, the forest department and district administration must arrange for an escort facility to drop and pick school children from their homes to schools" said Dhami to the officials.

Directions from the chief minister came in the review meeting called in response to rising mananimal conflicts in Pauri Garhwal hill region of the state.

Dhami instructed the officials to take adequate and effective measures to eliminate manwildlife conflict in the state.

He said "It must be ensured that the Forest Department teams reach the incident locations within 30 minutes of receiving information about animal attacks. The responsibility for this must be fixed on concerned Divisional Forest Officers (DFOs) and Range officers. Apart from this financial assistance should be provided to the affected people immediately."

Due to the recent rise in leopard and bear attacks leading to loss of 3-4 lives in Pauri, the Chief Minister also directed the forest authorities for immediate removal of the DFO from his divisions.

Dhami asked the forest department to prepare and submit an action plan within two weeks to provide assistance for the livelihood of the family of a man-animal conflict deceased who was the lone livelihood earner for his or her dependants.

# Karnataka's neglect of detention directive irks HC

**BENGALURU** . (Agency)

The Karnataka High Court on Thursday expressed its displeasure in the state government not considering its order to follow the guidelines in cases booked under the GOONDA Act. The court said the guidelines issued by the Coordinate Bench were to be circulated to the authorities concerned, namely, the Additional Chief Secretary, Home Department; Principal Secretary, Law Department; Director General and Inspector General of Police; Secretary, Department of Parliamentary Affairs, etc.

Unfortunately, nothing seems to have changed, despite such guidelines being issued by this Court. Cyclostyled orders are being passed by the detaining authorities. Illegible copies of the documents are furnished without translations. If the guidelines are followed, the detenue raising objections regarding illegible copies will be considerably reduced, the court observed. # Maharashtra: Lokayukta Bill passed; Chief Minister now within Lokayukta's ambit

The Maharashtra Legislature approved the Maharashtra State Lokayukta Amendment Bill, 2025, in both houses after incorporating three minor revisions proposed by the central government. The updated law, which will come into force once the governor gives assent, grants the state's anti-corruption ombudsman the authority to investigate the Chief Minister, cabinet ministers and other public officials on allegations of corruption.

Chief Minister Devendra Fadnavis, who introduced the Bill in the assembly, said on Thursday that the centre had sought three adjustments to the earlier version of the Lokayukta Bill passed by the assembly in December 2022 and the council in December 2023. The changes include updating references to three criminal laws that were recently renamed by the central government, modifying the appointment clause so that the current Lokayukta remains in office until a new one is appointed and explicitly placing officers appointed by the state to bodies such as MahaRERA under Lokayukta

jurisdiction. A key provision requires a two-thirds majority in the assembly to begin an inquiry against the chief minister, a move officials say enhances accountability. The legislation replaces the earlier 1971 Act, offering a more comprehensive mechanism to curb corruption within the government.

Fadnavis clarified that the second amendment specifically aligns the Bill with the new titles of the IPC, CrPC, and Evidence Act, all of which were renamed last year. The third amendment, he said, resolves ambiguity over whether the Lokayukta can act against officials in statutory authorities created under central laws but appointed by the state. Bringing such officers within the Lokayukta's ambit removes the ambiguity.

Under the new framework, the Lokayukta may investigate the chief minister and the council of ministers, subject to procedural approvals: a two-thirds assembly vote for the chief minister, the governor's sanction for ministers and authorisation from the chief minister along with inputs from the chief secretary for IAS officers.

# SIMI to ISIS: Why this little village near Mumbai keeps getting raided by intelligence agencies

# The recent ED raids have once again shone the spotlight on Borivali-Padgha village on the outskirts of Mumbai and its rise to infamy.

Mumbai . (Agency)

For the past decade, Borivali-Padgha, a village in Maharashtra's Thane district, located 53 km north of Mumbai, has frequently figured in the news and public perception as a centre of subversive activities. It has also consistently remained on the radar of national security agencies. In the last two years alone, the National Investigation Agency (NIA), the Enforcement Directorate (ED), the Maharashtra Anti-Terrorism Squad (ATS), and the Thane rural police have carried out multiple raids here, including large coordinated searches in 2024 and 2025. In the most recent raid on Thursday, the ED conducted searches at 40 locations across The history of the settlement

including the Padgha-Borivali region, as part of a

money-laundering probe linked to cases registered by the NIA and Maharashtra ATS against Pune-based individuals allegedly connected to ISIS activities in the state.

A look at why this village repeatedly draws such massive scrutiny, its political and social landscape, and the long shadow cast by one of its

most prominent residents, the late

multiple states and districts, Borivali-Padgha's documented history dates back to the Shilahara



Dynasty (7th-10th century), when the region formed part of the northern Konkan administrative belt. Arab traders arriving at

Bhiwandi port in the 12th century established a settlement in neighbouring Borivali, which later merged, socially and economically, with Padgha.

The community that emerged from this mix—largely Muslim and economically selfsufficient—built sturdy homes, many of which still stand. Prominent families such as the Mullas, Nachans and Khots grew influential as landowners

and timber traders. The area is home to 5,780 residents, of whom 83 per cent are Muslims, as per the 2011 Census.

Borivali-Padgha's residents have a record of political participation. During the freedom movement, Muslim women from the village led a Swadeshi protest, burning British goods in Borivali's square, an event attended by Sarojini Naidu.

This political consciousness saw the village transform into a base for a range of ideological currents, ranging from leftist activism to Islamist student mobilisation. Before its ban in 2001, the Students Islamic Movement of India (SIMI) had a visible presence in the area, something that later became a reference point in intelligence assessments.

Bullets are bullish. The adage that war fills coffers is finally ringing true for India as the conflict in Ukraine is poised to enter its fourth year in less than three months. A single sentence in the 'outcome documents' released half-way through Russian President Vladimir Putin's visit to India on December 5 is pregnant with bullish possibilities. The description of this particular outcome hides more than it reveals—a memorandum of understanding that "entails cooperation in various sectors of maritime domain such as shipping, ports, joint mineral exploration, research and development". Two weeks before Putin's arrival in New Delhi, a visit to Goa by Nikolai Patrushev, chairman of Russia's Maritime Board, prepared the ground for what augurs to be the biggest military-industrial project to emerge from the 23rd annual India-Russia summit this month. The Maritime Board has identified Goa Shipyard as the base for production of frigates, corvettes, anti-mine and landing vessels as well as ice-breakers. Russia has also proposed continued production of Project 1135.6 class ships in Goa based on upgraded designs and state-of-the-art technology. Two such ships, Triput and Tavasya, based on Russian models, were launched for the Indian Navy in July last year and March this year, respectively.On November 20, the Russian foreign ministry's readout on Patrushev's visit quoted him as saying, "Our countries can jointly build up their own fleets, strengthen cooperation between them, establish robust and sanctionsresistant maritime logistics, and develop marine science and technology." The crux of the statement originated from grievances by head honchos of Goa Shipyard about delays in "material supply obligations" for collaborative naval projects with Russia. Both sides agreed that these challenges were because of "extraordinary global circumstances"—a euphemism for the war in Ukraine and supply chain disruptions. The current challenge on the strategic and commercial horizons for Russia's thriving shipbuilding sector is the Ukraine conflict. Midway through the war, Franco-British missiles supplied to Ukraine penetrated the defences of Russia's Black Sea fleet headquarters in Sevastopol, which was part of Ukraine until 2014. Major shipyards in Crimea have been affected by sanctions on supply of German engines and disruptions in getting

ancillaries such as turbines from Ukraine. If Goa Shipyard and Mormugao port become hubs for the activities of Russia's Maritime Board, ships could be built in Goa for Russia to at least partly compensate for production stoppages along the Black Sea, which is vulnerable to attacks from Ukraine. Patrushev was understandably guarded in his open meetings on Goa's maritime infrastructure. "The enterprise is subordinate to India's ministry of defence due to its military orientation, but we have very good prospects for cooperation," the authorised English translation of Patrushev's remarks said. The annual summit turned a new page in India-Russia engagement, which is best described as familial diplomacy. Patrushev, who has been by Putin's side as one of his most trusted aides since he became prime minister in 1999 and later president, is said to have an excellent chemistry with Prime Minister Narendra Modi. The two men met every time Patrushev came to India as secretary of Russia's Security Council, the equivalent of a national security adviser.In late September, as the groundwork for Putin's visit was under way, another Patrushev arrived in India—Deputy Prime Minister Dmitry Patrushev. He is Nikolai's son and was Russia's agriculture minister for six years before his promotion as deputy prime minister in charge of agriculture. During and after the visit, he initiated efforts to increase the market share of Indian shrimp products in Russia. The landed prices of Indian shrimp products in their biggest market, the US, have increased by 58 percent, thanks to the steep tariffs supplemented by antidumping duties.

# A red herring called Macaulay

#### India should focus on an education system that fosters scientific temper and creates an inclusive society

THE Ramnath Goenka Memorial Lecture, delivered by Prime Minister Narendra Modi recently, has opened a Pandora's box regarding the enduring legacy Thomas Babington Macaulay left behind in India — his 'Minute on Education' (February 2, 1835) and the legal system framed in 1860 and later. The focus has not merely been on pedagogy, which is value-neutral, but also in terms of what the students imbibed as ideas and practices through printed literature and other sources.

The PM accused Macaulay of 'Shiksha vyawastha ka samool naash' (destruction of the education system), breaking the back of kaushal (skill), shattering self-

confidence, throwing the entire knowledge system into the dustbin, condemning Indian heritage and culture instead of taking pride in them and rejecting local languages. All these developments produced an inferiority complex among Indians, he claimed. Blaming previous governments, particularly those of the Congress, the PM said these tendencies were concretised after Independence.It is indeed welcome that the Prime Minister is turning his attention to the state of education in the 12th year of his reign. Alas, the reality is not very bright. On October 19, 2020, addressing the centenary convocation of the University of Mysore, PM Modi highlighted the growth of higher education institutions such as IITs, IIMs, AIIMS and IIITs across the country during his rule. However, faculty appointments, admissions, funds and infrastructure as well as controversies regarding textbooks continue to cast dark shadows. The number of government schools has

decreased (around 90,000 fewer between 2014-15 and 2023-24), while the number of private schools has gone up. These are serious imbalances.

As a Law Member of the Governor-General's Council of India, British historian, poet and Whig politician Macaulay claimed to have presented his Minute on education that changed the entire course of education in India. Addressing the Committee of Public Instruction, He mentioned in the document: "I would strictly respect all he based his argument on the central theme of the Charter Act of 1813 that set aside a sum "for the revival and promotion of literature and the encouragement of the learned natives of India, and for the introduction and

promotion of a knowledge of the sciences among the inhabitants of the British territories". However, it is doubtful whether he said what is being attributed to him: "I have travelled across the length and breadth of India... I propose that we replace her old and ancient education system, her culture, for if the Indians think that all that is foreign and English is good and greater than their own, they will lose their self-esteem, their native culture and they will become what we want them, a truly dominated nation." That's because on February 2, 1835, he was in Calcutta, not in London.

Indeed, in referring to "the learned natives of India", he set



the tone for racial superiority even before he came to his central argument. The essential argument of his Minute was regarding not wasting public money on education in 'Sanscrit' and Persian. He stressed spending public funds on an education system that imparted education in science and the contemporary knowledge system in the West in English.

existing interests. I would deal even generously with all individuals who have had fair reason to expect a pecuniary provision. But I would strike at the root of the bad system which has hitherto been fostered by us. I would at once stop the printing of Arabic and Sanscrit books, I would abolish the Madrassa and the Sanscrit College at Calcutta. Benares is the great seat of Brahmanical learning; Delhi, of Arabic learning. If we retain the Sanscrit College at Benares and the Mahomedan College at Delhi, we do enough, and much more than enough in my opinion, for the eastern languages."He further said: "If the Benares and Delhi Colleges should be retained, I would at least recommend that no stipends shall be given to any students... The funds which would thus be placed at our disposal would enable us to give larger encouragement to the Hindoo College at

> Calcutta, and to establish in the principal cities throughout the Presidencies of Port William and Agra schools in which the English language might be well and thoroughly taught."He argued that a lac (lakh) rupees granted by the Government of India must not be wasted on scholarship for the students of 'Sanscrit' and Persian and on the publication of books in these languages, since the books in English sold more. Then came his aim, "We must at present do our best to form a class who may be interpreters between us and the millions whom we govern; a class of persons, Indian in blood and colour, but English in taste, in opinions, in morals, and in intellect". Further, his pithy remark, "a single shelf of a good European library was worth the whole native literature of India and Arabia", indeed offends us as Indians.

Howsoever racist Macaulay must have been, the statement above sounds more from the pen of an administrator, contemplating a utilitarian logic for the fund having been allocated for education.

The colonial administration he represented stood for extracting resources for the metropolis, not for charity. We should ask

ourselves in the same spirit: did it harm us?I will conclude with two personal experiences with two generations. A product of Macaulian education from my parents' generation, a doctor was well-versed in Urdu, but he quickly learnt administrative Hindi. My father, an officer in the Bihar Police, had proficiency in English, Hindi and Sanskrit. Beginning my education in Bihar, I found that Hindi-medium textbooks inculcated nationalism.Instead of drawing a red herring, we should keep building and refining an education system that is modern, contemporary, fosters scientific temper and creates an inclusive society.

# A debate on reforms that delivered only rancour

#### What might have been a sober discussion in Lok Sabha on systemic reform slid into a point-scoring exercise between the home minister and the leader of opposition

The two-day Lok Sabha debate on electoral reforms should have been an opportunity to clarify procedures, strengthen transparency, and reaffirm institutional neutrality at a time when public trust in democratic processes is increasingly brittle. Instead, it descended into a familiar political joust between the Leader of the Opposition Rahul Gandhi and Union Home Minister Amit Shah—each armed not only with arguments, but with history, grievance, and sharp-edged jibes.Rahul Gandhi levelled a sweeping charge of "institutional capture", accusing the Election Commission of operating without accountability and alleging "vote chori" through opaque voter-roll practices, questionable deletions under the ongoing Special Intensive Revision, and lack of transparency in electronic voting machines'

architecture. He demanded machine-readable electoral rolls, full technical disclosure of EVMs, access for parties to examine them, protection of CCTV evidence, and removal of immunities shielding election commissioners. His warning— that a future government would "change the law retrospectively"— was as much political



messaging as it was a call for reform. Amit Shah's rebuttal was equally political. He dismissed the opposition's claims as "manufactured narratives", arguing that SIR is a constitutional exercise conducted by the Election Commission independent of the government. When pressed on alleged voter-roll manipulation, he countered with the question of whether "infiltrators" and non-

citizens should remain on electoral rolls-reframing the debate around national security rather than institutional procedure. He invoked historical episodes to turn the "vote chori" charge back at the Congress, citing precedents from the Nehru, Indira, and Sonia eras to argue that the opposition lacked moral authority to lecture on electoral integrity.

What might have been a sober discussion on systemic reform slid into point-scoring. Gandhi's narrative of democratic erosion met Shah's counter-narrative of Congress's past failings. Allegations of voter manipulation were matched with charges of protecting "ghuspethiyas". Both leaders ended up appealing more to their constituencies than to the substance of electoral reform. And yet, the core question remains urgent: India needs a credible, transparent, error-free system of electoral roll revision, robust auditability, and institutional safeguards that command cross-party trust. Without concrete steps—legislative clarity, procedural reforms, or independent oversight—the debate risks becoming another episode of political theatre. Democracies weaken not only by manipulation, but also by neglect.

# The contradictions in offering privileges to extradite fugitives

True moral authority lies not in appeasing foreign courts for extraditing prominent economic fugitives, but in ensuring equal dignity for all those behind bars. Former European colonisers' demands on this count reveal double standards. An update of our extradition law is overdue

European courts seem keen to legitimise high privileges for other countries' economic fugitives. Belgian courts have reportedly approved the extradition of one of India's most wanted economic fugitives only after the Indian government furnished formal, legally-binding assurances. The government undertook to lodge him in a specially-prepared cell at Mumbai's Arthur Road Jail, conforming to the standards set by the European Committee for the Prevention of Torture—adequate space, ventilation, medical care, nutritious food, media access, and no solitary confinement.

Demands for special privileges are understandable when sought for a country's own citizens. But insistence on such treatment for those wanted elsewhere is discordant. The trend reflects a newfound love of some countries for wealthy economic fugitives. Oliver Bullough's 2022 bestseller, Butler to the World: How Britain Became the Servant of Tycoons, Tax Dodgers, Kleptocrats and Criminals, lucidly captures this phenomenon and its corrosive effects. Every individual, including an accused or a convict, is entitled to basic human rights. But demanding special comforts under the guise of human rights reflects troubling double standards and a transactional stance to justice. Using it as an excuse to embrace a fugitive moneybag's assets is an open endorsement of financial crimes. This is paradoxical especially because many of these countries are founding members of the Financial Action Task Force and signatories to global conventions against money laundering. Their offshore tax havens further expose this hypocrisy. Unless such duplicity is confronted, global public policy's fight against financial crimes and money

laundering risks becoming an empty slogan. Their own

histories offer reminders of these contradictions. Many European countries abolished barbaric prisons barely a century ago. Dismemberment, whipping, and long incarcerations, even for minor offences, were once common. Recall the hero in Victor Hugo's Les

Misérables (1862), an impoverished man imprisoned for 18 years for stealing a loaf of bread. In European colonies, nationalist leaders were left to rot in jails with appalling conditions. Yet, those nations now advocate exalted human rights for criminals from other countries, often to the point of obstructing justice itself.

Almost all the major prisons in India were built by the British, primarily to incarcerate freedom fighters. The Cellular Jail in the Andamans was the most notorious. Others such as Alipore Jail in Kolkata, Naini Jail in Prayagraj, and Yerawada Jail in Pune also served as sites of confinement and torture for countless nationalist leaders.Built in 1926, Arthur Road Jail in Mumbai continues to function as the city's central prison. It

houses a mix of inmates—business leaders, public officials, celebrities, and political figures—with some of them housed in upgraded cells. The need to offer casespecific assurances to foreign courts stems from the presumption that India's prisons do not meet minimum humanitarian standards. This raises a deeper moral and institutional concern: why should humane treatment be an exception, invoked only when international scrutiny demands it? A constitutional democracy governed by the rule of law must guarantee humane detention for every person, irrespective of nationality, status, or offence. Ensuring the minimum standards universally, rather than selectively, would enhance the credibility of the justice



system and obviate the need for external assurances in extradition proceedings.If India provides superior detention conditions to extradited fugitives while ordinary prisoners continue to endure substandard or overcrowded facilities, it raises a serious question of discriminatory treatment. Domestic prisoners could justifiably argue that such selective privileges violate the constitutional guarantees of equality and the right to life

with dignity. The State cannot defend this disparity solely on the grounds of diplomatic expediency or international image. India's limited success in securing the return of wanted persons has been a result of adroit diplomatic and legal efforts, rather than the strength of its

extradition law. The Extradition Act, 1962 is out of sync with contemporary global realities. It largely reflects the older paradigm of extradition centred on political offenders and non-financial crimes. discouraging the former while facilitating the latter. Despite amendments in 1993, the law does not adequately address the challenges posed by financial globalisation, India's own economic liberalisation, the rise of transnational financial crimes, offenders' increasing ease in crossing borders, and the growing practice of states offering expedited citizenship in exchange for investment.

The Extradition Act is also oblivious to the stonewalling tactics by many Western nations. While India imposes no restriction on the extradition of its own nationals and has been accommodative on such matters, most other nations rarely reciprocate. They often refuse to extradite their own citizens to India and are increasingly becoming intransigent in extraditing even third-country nationals involved in economic offences or other serious crimes.

India's extradition framework must be strengthened and treaties redrawn to reflect evolving global dynamics and India's growing international stature. A robust legal and diplomatic strategy, supported by credible, universal prison reforms, would enable India to negotiate from a position of strength and ensure that all fugitives are brought to justice under Indian law.

## AP: Nine killed as bus falls into gorge

Nine tourists were killed and 18 were injured, five of them critically, when a tourist bus fell into a gorge at Maredumilli village in the ASR district in the early hours of Friday.

Police said a group of tourists from Chittoor and Tirupati districts were on a pilgrimage. After visiting some places in the Araku region, they were on their way to the Sriram Temple in Bhadrachalam, Telangana. When the bus was ascending the ghat road, it veered off and plunged into a gorge.

Five tourists died on the spot, while four others succumbed to their injuries while being shifted to hospital. At least 18 people were injured in the mishap, and the condition of five of them is said to be very critical. All the injured were admitted to the GGH in Paderu.

Police said the driver was new to the area and was unable to negotiate a steep curve on the ghat road. Visibility was also very poor due to thick fog. As many as 35 people, including two drivers, were travelling in the bus when the mishap occurred. Efforts are on to identify the deceased, police said.

The death toll may rise as the condition of five injured persons remains critical, officials

# NGT stays further felling of trees at a Ludhiana distributary

#### Ludhiana .(Agency)

Hearing the matter on the alleged conversion of forest land for non-forest activities due to the modernisation of minor canal (distributary) from Fatehpur Awana to Ayali Khurd in Ludhiana district, the National Green

Tribunal (NGT) Thursday stayed further axing of trees "with immediate effect" until the next date of hearing.

Petitioners Kapil Arora and Kuldeep Singh Khaira, members, Public Action Committee (PAC), submitted that the Regional Officer (RO) Chandigarh, Ministry of Environment, Forest and Climate Change, had granted approval for change in land use for concreting the channel, permitting the felling of 391 well-grown trees. The petitioners approached the NGT seeking quashing of the order on the grounds that viable alternate methods of concreting — which would have saved over 350 trees - were never

Co-petitioners Jaskirat Singh and Amandeep Singh pointed out that the Supreme Court (SC), in matters concerning tree felling, has consistently held that all alternatives must be explored to minimise ecological loss, and that

development and environmental protection must go hand-in-hand. During the hearing, The PAC submitted that instead of awaiting the after submissions from the Forest Department, Irrigation Department, and the Ministry of Environment, it emerged that an amount of Rs



31.98 lakh was deposited as compensation for forest land and trees. However, the petitioners argued that manual concretisation, as successfully adopted in several similar projects in the past, would have avoided the need for felling most trees and substantially reduced project cost. Despite this, the departments failed to examine alternative options and proceeded with approvals for tree removal.

tribunal's final order, the departments had already commenced felling of trees, resulting in 207 trees being felled so far.

The forest department confirmed this,

The NGT bench expressed serious concern over the conduct of several departments, noting that such environmentally harmful practices are recurring, citing the previous case concerning forest damage along the Sirhind Canal. The Bench observed that the departments 'should have waited for the final orders' rather than proceeding unilaterally without considering alternative options or the potential consequences of the case," PAC said.

As per the interim directions by the NGT, the bench has stayed further cutting of trees with immediate effect, directing the Ministry of Environment and the Irrigation Department, Punjab, to place on record the alternatives, if any, evaluated prior to approving tree felling. The next hearing would be in the third week of January

## New UP BJP President to be announced on Sunday, election process to start today

#### Lucknow. (Agency)

After a long wait, ruling BJP has announced the formal process of organisational election to elect the new Uttar Pradesh party president. The name of new president would be revealed on December 14 even though it could be disclosed on December 13, if only one candidate files nomination.

Senior party leader and former Minister Mahendra Nath Pandey stated that nominations for the post of state president will be filed tomorrow. The nomination process will be held from 1 pm to 2 pm at the BJP state headquarters in Lucknow. According to Pandey, nomination papers will be accepted in the presence of Central Election Observer Vinod Tawde.

Central Election Officer Piyush Goyal will complete the election process on December 14. The formal announcement of the state president's election will also be made on the same day.

Though there are several names doing the rounds for state president, a leader from OBC, particularly of Kurmi community, could be the ultimate choice.

Names of Deputy CM Keshav Prasad Maurya, central minister Pankaj Choudhury, UP Ministers Swantra Deo Singh, Dharampal Singh and former central Minister Sadhvi Niranjan Jyoti are in circulation for the post.

The long-running president selection process within the BJP has now reached a decisive stage, and the party leadership is finalising the name of the new President with an eye on the 2027 assembly elections. It is noteworthy that, as per the constitutional process for electing the BJP state president, the members of the Provincial Council are first selected. One member is elected from each of the 403 assembly constituencies. However, these are elected only from those constituencies where the district presidents have already been declared. The BJP has divided the state into 98 districts.

For the state president election, above 50 per cent of the district presidents are required to be selected, whereas currently 86 per cent of the district presidents have been named. Similarly, elections have been completed in more than 1600 out of 1918 'mandals'.

# Book depot scam comes to light, PSEB chairman acts against three employees

Disciplinary action is expected once the charged officials submit their responses.

A massive financial irregularity spanning four years at the Punjab School Education Board's (PSEB) regional book depots in Jalandhar and Kapurthala has come to light. Taking strict action, board chairman Amar Pal Singh has taken action against three employees allegedly involved in large-scale book sale-purchase discrepancies between 2018

The scam came to light after board manager Tajinder Sharma raised concerns, prompting the board to order a detailed audit by its auditor Yudhveer Singh Chauhan. The audit revealed glaring mismatch running into crores of rupees between the books purchased and the books sold. Even more

disturbing were missing bills for books shown as

"Multiple ledger irregularities, minus balances, incomplete accounts, and serious negligence related to stock charge emerged during the examination of four years of records. Immediate action from senior authorities was necessary," the

report stated.

Based on the audit findings, the board entrusted the inquiry to a retired judge, Parminder Pal Singh. His report identified three officials as responsible for the discrepancies and recommended strict action. Acting on his recommendations, the board completed its local audit examination and has now chargesheeted the three employees posted at the regional book depots

in Kapurthala and Jalandhar.

When contacted, chairman Dr Amar Pal Singh told The Indian Express, "After the audit report, three employees have been chargesheeted. They have been asked to present their explanation. Further action will be taken

once their replies are reviewed.'

The financial mismanagement spanning incomplete ledgers, overwritten entries, missing stock records and minus balances has raised serious questions about accountability within the department. Further disciplinary action is expected once the charged officials submit their responses.

# ED raids 25 locations linked to UP cough syrup syndicate

#### Lucknow . (Agency)

today launched extensive raids across six cities as part of its moneylaundering investigation into the illegal trade of codeine-based cough syrup in Uttar Pradesh. Beginning early in the morning, ED teams conducted searches at 25 locations connected to the suspected syndicate in Lucknow, Varanasi, Ranchi, Ahmedabad, Jaunpur and Saharanpur. In Lucknow, ED officials carried out a major search operation at the luxurious residence of dismissed STF constable Alok Pratap Singh, who is accused in the codeine cough syrup trafficking case. Acting on intelligence inputs, officers searched the premises for several hours and recovered multiple suspicious documents, bank transaction files, Police apprehended Suraj Mishra digital devices and records allegedly linked to hawala transactions. All seized materials have been taken into custody for further examination.

The ED team arrived at around 6 am at Singh's residence located in Sushant Golf City on Gosainganj Road, adjacent to the house of former Jaunpur MP Dhananjay Singh. Alok

Pratap Singh is currently under STF The Enforcement Directorate (ED) custody. Meanwhile, in an earlier development related to the same case, Krishna Nagar police arrested two associates of Deepak Manwani—Suraj Mishra and Preetam Singh - who had been on the run. # After crackdown on gangs extorting traffic cops in Delhi, Special CP asks officers to report blackmail attempts

#### New Delhi.(Agency)

In the wake of police busting two gangs involved in extorting traffic police personnel, Special Commissioner of Police (Traffic) Neeraj Thakur has encouraged officers to report blackmail attempts by individuals.

To this effect, the Special CP has instructed the Deputy Commissioner of Police (Traffic) to hold Sampark Sabhas—formal meetings led by senior police officers to address the grievances of junior personnel—to motivate officers to come forward and report any attempts to extort money from them.

These instructions were issued during a meeting chaired by Special CP Thakur on December 4.

On Wednesday, the police said that they had arrested five men in connection with the syndicate, adding that the two gangs had acquired crores of rupees from commercial vehicle drivers and by blackmailing traffic police personnel. The first arrests in the case were made in the last week of November.

The probe revealed that the accused were actively running parallel systems. One gang sold fake stickers to commercial vehicle drivers for Rs 2,000 to Rs 5,000 per month to bypass entry-point restrictions, while another extorted money from traffic police personnel by fabricating videos of them performing

According to police, officers are also probing the role of some Traffic Inspectors (TIs) who allegedly assisted the gang and even took a share of the extorted money. The meeting also included discussions on ensuring minimum inconvenience to the general public during VIP movements. The Special CP directed that traffic should be halted only for the minimum duration necessary for security arrangements.

## Delhi's school fee law kicks in: 3 tier-system in place, parents can file complaints with 15% backing

#### New Delhi.(Agency)

Four months after the Delhi Assembly passed the Delhi School Education (Transparency in Fixation and Regulation of Fees) Bill, 2025, to regulate fees in private schools amid protests by parents over arbitrary hikes, the Delhi government officially notified the Act on Wednesday with Lieutenant-Governor V K Saxena issuing the Gazette notification, The Indian Express has

At the centre of the new regime is a three-tier committee structure — a School-level Fee Regulation Committee, the District Fee Appellate Committee, and the Revision Committee. Another key aspect of the Act is that a complaint to the District-level Committee must be backed by at least 15% of the affected parents. The Act makes parents a part of the decision-making process.

However, parent associations had previously raised concerns over the 15% threshold, arguing that it may be difficult to mobilise support, but the mechanism remains intact in the notified rules and now has a codified appeal format and scrutiny process.

Under the new Act, "private unaided recognised schools are strictly prohibited from collecting any fees that are not explicitly defined and sanctioned". The Act brings under its ambit over 1,500 private unaided schools in the Capital after years of protests by parents.

"All permissible fees must be itemised and disclosed as distinct components," reads Chapter II of the Act, which categorically prohibits the collection of "excess fee". The defined fee heads include admission charges, registration charges, security deposit — all of which are non-recurring

Tuition fees have been defined to include "standard establishment costs and expenditures directly related to curricular activities". It cannot be used to recover capital expenditure, including investments for infrastructure development or any other non-revenue generating assets, according to the Act. Apart from this, term fees, annual charges and development fees have also been defined under the Act.

# Birth to death services under one roof: How Delhi's expansion to 13 districts makes citizen lives easier

#### New Delhi.(Agency)

In a major overhaul, the Delhi government has approved a revamp of the Capital's administrative structure, reorganising its 11 revenue districts into 13 with an aim to improve coordination and speed up delivery of public services. The new districts will be aligned with the city's 12 municipal zones, along with the New Delhi Municipal Corporation (NDMC) and Delhi Cantonment Board.

The move aims to enhance ease of living for citizens with an increase in the number of sub-divisional and sub-registrar offices as well as establish mini secretariats in all the districts. "This reform will significantly speed up delivery of public services, and ensure seamless coordination for land records,

and grievance redressal for citizens," a spokesperson for the Delhi CM Rekha Gupta termed the decision government said.

The Capital currently has 11 revenue districts, headed by respective district magistrates, while the city is divided into 12 MCD zones, led by respective deputy commissioners. Under the new plan, the city gets three new districts — Outer North, Central North and Old Delhi. Meanwhile, areas under Shahdara district have been redistributed in All of these districts will also have a Northeast and East districts.

The gazette notification for the redrawing of boundaries will be issued within 15 days and the reorganisation will be completed by the end of this month, said officials. The government has sanctioned a budget of Rs 25 crore for the move.

## **Persian carvings, Kashimiri** woodwork: Delhi to get its very own houseboat along **Yamuna**

#### New Delhi.(Agency)

A houseboat in Delhi along Yamuna?

Residents may soon have an option to host meetings, conferences and small dining events in the heart of the city in a houseboat, typically found in Kerala and Jammu and Kashmir, with the DDA preparing to float tenders for a new convention centre at Baansera Park, a spokesperson for the Lieutenant Governor's Office said.

The ambitious project is a part of initiatives undertaken by L-G VK Saxena, who has been pushing for development of the Yamuna floodplain as a public space for citizens to bring the people closer to the river, in the process, making them direct stakeholders in its cleaning and rejuvenation," the spokesperson said.

The structure, though designed like a houseboat will be permanently fixed to the ground and will not float. The houseboat convention centre will be made of biodegradable timber and will not use concrete or steel. This is to ensure sustainability along the Yamuna floodplain.

The facility is expected to offer a meeting space for 15-20 people, a reception area with a waiting lounge, dining space with an attached pantry, gallery space, and interiors that match Kashmiri-style woodwork, including carved jail patterns and railings. The DDA expects the structure to have a lifespan of about 50 years, the spokesperson said. The DDA expects the work to be completed within 180 days of awarding the contract, with the planned completion timeline falling between May and June next year.

At roughly 9 m high, the houseboat will have multiple levels, including lower, ground, middle and upper decks. The spokesperson said the base will use deodar wood, while the superstructure will be made of cedar featuring walnut carvings. Interior wall panels and ceilings will use chinar wood. "The idea is to create a structure crafted by master artisans, with detailing inspired by traditional Kashmiri woodwork," the spokesperson added.

According to the project details shared by the L-G's Office, the houseboat will be located near the existing eatery at Baansera. All visible elements-including railings, columns, Mehrab arches and external panels-will feature Persianstyle carvings. Windows will be made of cedar wood with carved sash designs fitted with glass panes. Each piece of timber will be seasoned to avoid warping, and natural resin or suitable allweather sealants will be used to ensure structural

# Gangster Lagarpuria, aide convicted under MCOCA

#### New Delhi.(Agency)

Notorious gangster Vikas Lagarpuria and his associate Dhirpal have been convicted under the stringent Maharashtra Control of

Organised Crime Act (MČOCA) act for running an organised crime syndicate—nearly a decade after they were first booked for the same. The judgment was announced on Wednesday by Additional Sessions Judge Vandana Jain in Dwarka court.

In an order dated December 10, the court said, "..both the accused persons namely Vikas Gulia alias Vikas Lagarpuria and Dhirpal alias Kana are convicted

under Section 3 of MCOCA.

However, the court acquitted the duo

under Section 4 (punishment for possessing unaccountable wealth on behalf of a member of an organised crime syndicate) of MCOCA.



Lagarpuria, known as the leader of the Vikas Lagarpuria gang, is involved in as many as 18 criminal cases including that of murder, attempt to murder, extortion, robbery, house trespass, and criminal intimidation etc registered at various police stations at Delhi and Haryana.

The first case against him was lodged in 2012 at Chawla police station. The same year, Vikas was booked under Section 3 (punishment for organised crime) of MCOCA at Nazafgarh police station.

Lagarpuria was arrested by the Delhi Police in 2022, after absconding for years in Dubai. Langapuriya was also involved in the 2021 Rs 30 crore heist at the offices of Alpha G Corp Management Services in

Sector 84 in Gurgaon. He is currently lodged in Mandoli jail while Dhirpal stays in Rohini jail.

## **Idolising Virat Kohli, Nikhil** Chaudhary dreams IPL stint with RCB legend

**NEW DELHI** . (Agency)

When Nikhil Chaudhary walked onto the field for Punjab in 2017, Virat Kohli was at the height of his powers, dominating cricket across all formats. Nine years on, while Kohl approaches the twilight of his illustrious career, Chaudhary's journey has taken a very different trajectory—one that has led him far from India, to a new life in Australia.

For Chaudhary, Kohli has always been more than just a cricketer—he's an idol. And now, in a twist of fate, there's a chance he could line up alongside him in the upcoming Indian Premier League (IPL). Registered as a local player in the mini-auction, the 29-year-old dreams not just of an IPL contract but of sharing a dressing room with his childhood hero. The story of how Chaudhary landed in Australia is almost cinematic. In 2020, a simple visit to relatives became an unexpected turning point. Stranded due to the Covid-19 pandemic, he found himself staying longer than planned—and gradually, he made Australia his home. From representing Tasmania to pulling on the



jersey of the Hobart Hurricanes in the Big Bash League, Chaudhary has carved a niche for himself far from the land of his birth.

But success didn't come overnight. Chaudhary's early days in Australia were a grind. He delivered letters for Australia Post, drove for Uber, and even chopped vegetables in a Brisbane restaurant before his cricketing break arrived. The contrast with his early career in Punjab—sharing dressing rooms with Abhishek Sharma and Arshdeep Singh—couldn't have been starker. Now, with 20 BBL matches and stints in the Syed Mushtaq Ali Trophy to his name, Chaudhary is ready for the next step. The 2025-26 season could be the one where he stakes a claim in first-class cricket. In the ongoing Sheffield Shield, he has already amassed 367 runs at an average of 45.87, including a stunning 163 against New South Wales that has caught the eyes of selectors. And he's more than just a batter—his leg-spin has yielded a first-class five-wicket haul, adding another dimension to his game.India Today Digital caught up with Chaudhary recently.

## Is Gautam Gambhir's fixation on Shubman Gill threatening **India's T20 World Cup defence**

For months now, the most animated debate around India's T20I setup has centered on one deceptively simple question: who should open with Abhishek Sharma? The left-hander has sealed his spot with commanding form and unwavering intent, yet the identity of his partner remains a point of national contention. As things stand, vicecaptain Shubman Gill continues to be the preferred choice, even as Sanju Samson, the man with three T20I hundreds in 2024, watches from the periphery.

To understand how head coach Gautam Gambhir has arrived at this decision, one might need more than selectorial instinct; perhaps an algebraic equation would explain why he remains wedded to an out-



of-form opener less than two months before a World Cup. The Gill question has loomed large over Indian cricket since the summer, yet Gambhir has shown little inclination to entertain the logic or statistics that stand firmly against his chosen man.Samson's case is straightforward and compelling. Not many players produce three T20I centuries across an entire career, and Samson did it in a single year. His synergy with Abhishek at the top was one of India's most exciting developments in 2024. But come the 2025 Asia Cup, he found himself displaced, pushed down to the lower middle order, and eventually benched. None of those roles suits his game or reflects the kind of form he has shown.

### Gill's slump raises hard questions

Gill, meanwhile, has retained his place without producing the returns that justify such unwavering support. Thursday's golden duck against South Africa in Mullanpur was the latest addition to an uncomfortable pattern. He now has no fifty in his last 17 T20I innings. His struggles against Lungi Ngidi only deepened the sense of concern, as he has now been dismissed twice in three balls across the

# What wrong has Sanju Samson done Uthappa wants Shubman Gill replaced as T201 opener

Robin Uthappa called out India's decision to drop Sanju Samson from the opening slot in T201s. With Shubman Gill struggling, his criticism has put fresh spotlight on India's T201 selection.

Shubman Gill's ongoing struggles in T20Is have intensified scrutiny on India's selection calls, especially after his golden duck in the second T20I against South Africa in Mullanpur. Chasing a daunting 214, Gill lasted just one ball, beaten by Lungi Ngidi's movement and dismissed at first slip. The moment not only jolted India early in the chase but reopened a debate that has dominated discussions for months: why does Gill continue to open despite a prolonged

slump, while Sanju Samson remains sidelined?The frustration stems from the stark contrast in form and opportunity. Samson, who smashed three T20I hundreds in 2024 and developed a potent partnership with Abhishek Sharma, now finds himself pushed out of the XI. Meanwhile, Gill has been repeatedly backed, even as his returns at the top have dipped steadily. With the T20 World Cup inching closer, the decision to persist with Gill has raised questions about whether India are prioritising hierarchy over performance. Speaking on Star Sports after India's crushing defeat in the Mullanpur T20I on December 11, Robin Uthappa voiced what many Indian fans have wondered: what wrong has Sanju Samson done to deserve this treatment? He questioned why a successful opening pair was dismantled without a convincing explanation from the team management."I beg the question: what did the partnership of Abhishek Sharma and

Sanju Samson do so grossly wrong that they



had to be replaced? I understand Surya in the pre-series conference where he said Shubman has actually been in the T20 squad before Sanju got his opportunity. But when Sanju did get his opportunity, he got three hundreds. He was the first guy among the youngsters here to get hundreds in T20 cricket. It was after that when Abhishek got it, and after that when Tilak actually got it. So he perhaps even inspired the guys and challenged them, because at that point, they were figuring out who was going to be the next opener for India in T20 cricket,"

Uthappa said."So you have a proven opener, who's averaging just below Abhishek Sharma at this point, and you decided to move him to the middle order and then slowly leave him out. What wrong has he done? is my question. He deserves to have that opportunity," he added.

He was equally blunt in his assessment of Gill's current approach, and emphasised and on what is going wrong for the Test and ODI skipper in T20Is."It's not working for Shubman at this point, because I also think he's trying different things. I think he's trying initially to go toe-to-toe at the same pace that Abhishek is going — that is not how he bats. That is not how he's been successful in T20 cricket. How he has been successful is by taking that time, those first 10 balls, absorbing the pressure, getting in, and then once he reaches 15-20 balls, I don't think there is a batter like Shubman Gill until he gets himself out. That's the kind of batter he is. And I think that's what works for him in T20 cricket," Uthappa said.

# New labour codes: No, your take-home salary isn't reducing. Here's the math

New Delhi.(Agency)

Ever since the new labour codes were notified on November 21, 2025, many salaried employees have been worried that their take-home pay would shrink. Much of the anxiety came from the rule that basic pay and related components must form at least half of the total salary. The assumption was simple: if basic pay rises, provident fund deductions rise, and the in-hand salary falls. The Ministry of Labour and Employment has now made it clear that this fear is misplaced.Officials said on Wednesday that the new codes do not automatically reduce anyone's takehome salary. The key reason lies in how PF is actually calculated.SALARY CALCULATION MATH EXPLAINED

Even if an employee's basic pay increases under the new wage structure, PF contributions will continue to be calculated on the existing statutory ceiling of Rs 15,000 unless both the employer and employee voluntarily choose a higher base.

This ceiling is what matters for most salaried workers. As long as PF is capped at Rs 15,000, the monthly deduction remains unchanged. The ministry highlighted that nothing in the new law forces PF to be calculated on the full salary. To make this clearer, the ministry shared a simple example. Consider an employee with a monthly salary of Rs 60,000. If Rs 20,000 counts as basic pay and dearness allowance and the remaining Rs 40,000 is paid as allowances, PF will still be calculated on Rs 15,000 so long as the employee has not opted for a higher PF base. Under the old rules and the new codes, the PF contribution remains the same. The employer contributes Rs 1,800 and the employee contributes Rs 1,800, leaving the take-home salary unchanged at Rs 56,400.

This explanation has offered relief to many anxious employees who thought the new wage definition would automatically shrink their disposable income. The ministry said the purpose of the revised structure is to bring uniformity and clarity, not to reduce salaries.

## UDIN prevented Rs 80,000 crore frauds since 2019: ICAI

**NEW DELHI.(Agency)** 

Ever since India adopted the Unique Document Identification Number (UDIN) for certifications, GST and tax audit reports by practicing Chartered Accountants, the country has prevented frauds worth Rs 80,000 crore, claims Institute of Chartered Accountants in India (ICAI).ICAI president Charanjot Singh Nanda informed the media on Friday that UDIN is first of its kind initiative globally, and it has prevented unauthorized individuals from misusing a CA's name, signature, or membership details, eliminated the risk of fraudulent certifications and strengthened the integrity and reputation of the profession. He says that the initiative has received global attention with ICAI equivalent institutions and bodies from many countries seeking help from ICAI for implementing a similar system. UDIN was implemented in August 2019, and since then over 10 crore UDINs have been generated. To curb the malpractices of non-CAs falsely presenting themselves as CAs and authenticating documents, ICAI introduced the Unique Document Identification Number (UDIN), an 18-Digits system generated unique number for every document certified/attested by full time practicing Chartered Accountants.

## Gold Edges Higher To Rs 1,32,599 Per 10 Grams, Silver Slips After Record High

Gold prices inched up on Friday morning, while silver slipped as traders booked profits after the metal hit a fresh record high on the MCX. During early trade, MCX gold futures for February

were trading 0.10 per cent higher at Rs 1,32,599 per 10 grams."MCX Gold has broken out to lifetime highs, trading near Rs 1,32,776 inside a tightening ascending wedge with firm support at Rs 1,31,400,' analysts stated. The next resistance zone opens the momentum leg toward Rs 1,34,000 and above," they added.In contrast, MCX silver futures for March were down 0.50 per cent at Rs 1,97,951 per kg. In the previous session, silver had touched an all-time high of Rs 1,98,814 per kg and ended the day with a strong 5.33 per cent gain at Rs 1,98,799.Gold February futures also saw healthy buying, closing at Rs 1,32,469 per 10 grams after rising 2 per cent.Both metals railied after the US Federal Reserve cut its benchmark interest rate by 25 basis points and hinted at the possibility of another rate cut next year. The dollar index also slipped to 98.30 -- making gold cheaper for global buyers and boosting demand.At the same time, the Indian rupee continued to remain at its record low against the US dollar. The weaker currency is supporting gold prices in the domestic market.Investors are now waiting for key US data, including inflation numbers and the non-farm payrolls report due next week. These indicators will help shape expectations around the Fed's next policy moves."The US Federal Reserve's decision to cut key interest rates by 25 bps to 3.50 per cent-3.75 per cent amid persistent inflation has reinforced bullish sentiment in precious metals," market watchers stated.Lower rates reduce the opportunity cost of holding non-yielding assets like gold and silver, attracting fresh investment flows. With bullion already at record highs, this policy shift adds momentum to the rally, as investors seek safe-haven assets amid economic uncertainty and inflationary pressures," analysts mentioned.

# NPS expands investment options: Now gold, silver ETFs and Nifty 250 picks allowed

India's pension regulator issues updated unified investment rules for pension schemes, introducing clearer limits and a wider range of asset classes.

The National Pension System (NPS) is set to become more flexible and potentially more rewarding after the pension regulator opened the door to new investment options. # Keys to new homes first, then redevelopment begins: Pranav Adani on Dharavi plan

New Delhi.(Agency)

Pranav Adani, Managing Director of Agro and Oil & Gas at the Adani Group, outlined key details of the ambitious Dharavi redevelopment project during his first TV interview on Agenda AajTak.He described the initiative as one of the most significant urban transformation projects currently underway and addressed major concerns around relocation and rehabilitation.dani highlighted that the company's approach is to build new homes for existing residents first and hand over their house keys before any redevelopment work begins on their current settlements. First, we will build your house, we will give you the keys, you will move into the final house first, and then only we will break your slum and do the redevelopment," said Adani. He mentioned that despite several past

attempts over the past four decades, Dharavi's redevelopment never moved forward. This time, he said, the project is finally progressing with a concrete plan to build around 200,000 new homes, ensuring residents are moved into these units before any demolition

or redevelopment of old structures begins. Under the government's rehabilitation policy, those who have lived in Dharavi since before 2000 will receive new homes within the redevelopment area. Those who moved in after 2000 will be offered alternative



housing options elsewhere in Mumbai. Adani acknowledged that one of the biggest fears among residents is whether they will actually receive new homes if they vacate their existing ones. Reiterating the company's commitment, he said the keys to new houses will be handed over before any resident is asked to move, a step aimed at building trust and avoiding forced

evictions. The redevelopment plan also includes modern infrastructure, improved connectivity, and a "multimodel development" strategy. A detailed blueprint is already in motion, and work has begun on various components of the project. Beyond

Dharavi, Adani spoke about broader infrastructure needs in Mumbai, including the requirement for more airports to match global city standards. He also discussed the group's ongoing and upcoming projects in states like Assam, where airport and infrastructure development is underway. He highlighted business opportunities in Bihar as well, praising the ambition of the state's youth. He pointed to

# Mexico to impose up to 50% tariff on Indian exports

As India is still navigating ways to As India is still navigating ways to recover from the US tariff heat, Mexico has also slapped a steep tariff on several Indian items. Mexico's Congress has approved a bill that seeks to impose higher tariffs up to 50% on imports from India, China, Brazil and several other countries who are not having free trade agreements with the country. The tariff will take effect on January 1, 2026, after the lower house approves it. The tariff will be imposed on items like auto parts, light vehicles, plastic, toys, textiles, furniture, footwear, clothing, aluminium and glass. The proposed tariffs will range from 5% to 50%. The automobile sector is going to be the worst-hit as Mexico is India's thirdlargest car export market after South Africa and Saudi Arabia. India's total export to Mexico stood at \$5.7 billion



in 2024-25 with a trade surplus of \$2.8 billion.India's trade surplus with the country has gone up by nearly 12 times from 0.24 billion in 2020-21 to \$2.87 billion in 2024-25. Mexico's new tariffs on Asian imports are broadly aligning with US efforts to tighten trade barriers against China, along with other Asian nations. The Society of IndianAutomobile Manufacturers, an industry group that includes representatives of car exporters like

VW, Hyundai and Suzuki among its members, had previously urged India's commerce ministry in November to press Mexico to "maintain status quo" on tariffs for vehicles shipped from India, Reuters reported. Even export bodies like the Engineering Exports Promotion Council (EEPC) had written to Commerce Minister Piyush Goyal asking him to begin talks with Mexico on a potential FTA to mitigate the risk of the US tariff."We have also proposed FTAs with key Latin American countries such as Chile, Peru, and Mexico to get duty-free market access. # Price Of LPG Cylinder In India Vs Pakistan, Sri Lanka, Nepal: How Much Do Customers Have To Pay

In a written reply to a question in the Lok Sabha, Petroleum and Natural Gas Minister Hardeep Singh Puri tabled data showing the effective price of a 14.2 kg LPG cylinder in India.

### New Delhi.(Agency)

The price of LPG for consumers in India is much lower than in neighbouring Pakistan, Sri Lanka, and Nepal, Petroleum and Natural Gas Minister Hardeep Singh Puri informed the Parliament on Thursday.

In a written reply to a question in the Lok Sabha, the minister also tabled data showing that the effective price of a 14.2 kg LPG cylinder as on November 1 this year in India (Delhi) was Rs 553 for PMUY beneficiaries, while in the case of regular consumers, the price was Rs 853. This is much lower than the prevailing



prices in neighbouring Pakistan (Lahore) at Rs 902.20 per cylinder, Sri Lanka (Colombo) at Rs 1,227.58 and Nepal (Kathmandu) at Rs 1,205.72.India imports about 60 per cent of its LPG requirement, and accordingly, prices of LPG in the country are linked to its prices in the international market. While the average Saudi CP (international

benchmark for LPG pricing) rose by 21 per cent from US\$ 385/MT in July 2023 to US\$ 466/MT in November 2025, the prices of domestic LPG were reduced by about 22 per cent from Rs. 1103 to Rs. 853 during this period, the minister said.He said that for FY 2025-26, the government is providing a targeted subsidy of Rs 300 per 14.2 kg cylinder for up to 9 refills of a

14.2 kg cylinder to the PMUY consumers. For PMUY consumers, the effective price for domestic LPG has been reduced by about 39 per cent from Rs 903 in August 2023 to Rs 553 in November 2025.

As a result of various steps taken by the government to improve the affordability of domestic LPG for PMUY consumers, per connection consumption of PMUY beneficiaries (in terms of the number of 14.2 kg LPG cylinder refills taken per year) has increased from 3.68 (FY 2021-22) to 4.47 in FY 2024-25.

In order to provide more LPG for cooking in rural and remote areas, oil marketing companies (OMCs) have commissioned 8,017 distributorships, from April 1, 2016, to October 31, 2025, across the country, out of which 7,420 (i.e. 93 per cent) are catering to rural areas. As of November 1 this year, there are a total of 25,587 LPG distributorships across the country. These are served through 214 LPG bottling plants of OMCs located across the country. As a result of these efforts, LPG coverage in the country has improved from 62 per cent in April 2016 to near saturation now, the minister



# Table sugar does not up fatty liver disease

A new study has found compelling evidence that shows that consumption of both high fructose corn syrup (HFCS) and sucrose (table sugar) at levels consistent with average daily consumption does not increase liver fat in humans - a leading cause of non-alcoholic fatty liver disease (NAFLD). What

The findings also added to an already well-established body of science that HFCS and table sugar are metabolically equivalent.

is Mediterranean diet?

The study, conducted by James Rippe, MD, Founder and Director of the Rippe Lifestyle Institute and Professor of Biomedical Sciences at the University of Central Florida, examined 64 people, who consumed low-fat milk sweetened with

either HFCS or sucrose with the added sugar matching the 25th, 50th and 90th percentile population consumption levels of fructose for ten weeks.

The results showed that fat content of the liver was unchanged when the six HFCS and sucrose groups were averaged.

Fat content in muscle tissue also remained unchanged over the 10 weeks when the six HFCS and sucrose groups were

The two largest sources of fructose in the human diet are sucrose (containing 50 per cent fructose and 50 per cent glucose) and HFCS which is present in the human diet in two forms: HFCS-55 (which consists of 55 per cent fructose, 42 per cent glucose and 3 per cent other carbohydrates) and HFCS-42 (which consists of 42 per cent fructose and 58 per cent glucose).

You do not have to wait until you have any illness to start practising Jin Ji Du Li. It is especially beneficial for young people, when they practice it daily while they are healthy, so that their chances of contracting the various illness associated with aging is comparative lower.
