Rahul Gandhi and industrialist Gautam Adani, who has been at the Congress MP's crosshairs, came face-toface during Sharad Pawar's birthday bash. However, it was ensured that no photos of the encounter became public.

In politics, optics matter as much as words. That reality played out at NCP supremo Sharad Pawar's birthday bash, where Rahul Gandhi and industrialist Gautam Adani, who has been at the Congress MP's crosshairs, came face-to-face and even shook hands, but it was ensured that no photos of the encounter became public. Thus, while images of Rahul with Pawar and Telangana Chief Minister Revanth Reddy came out, photos of the Congress MP and Adani were conspicuously missing. The high-profile dinner was held on December 11 as Pawar turned 85. The birthday bash of Pawar, whose relationships span the political spectrum, invited politicians cutting across party

lines, brought together an eclectic mix of senior politicians, from his politically estranged nephew Ajit Pawar to the Gandhis, and business leaders.

Among those who attended the dinner was Adani Group chairperson Gautam Adani, who has relentlessly been targeted by Rahul over alleged corruption and creating monopolies in various sectors in collusion with the BJP. However, the highlight of the evening was Rahul and Adani sharing the same frame.

Speaking in The Lallantop's Netanagri, senior journalists Rajdeep Sardesai and Aadesh Rawal said Rahul, dressed in a traditional kurta pyjama and not his usual white t-shirt, and Adani met and shook



hands as well.

"It was the first time I saw Rahul and Adani come face to face. But surprisingly, no photo of them ever came out," Sardesai Rawal said at that time Pawar's daughter and Baramati MP Supriya Sule intervened, and ensured no pictures of the Rahul-Adani handshake were taken. "Supriya Sule ensured nobody took pictures of their meeting. She understood what its repercussions could have been,' Rawal said.

In fact, such an explosive image, of Rahul and Adani sharing a frame, would have sharply undercut the Congress's narrative against the conglomerate and become a political flashpoint. It would have invited uncomfortable questions for the Congress from both political rivals and allies.

The exchange came on a day Rahul and Union Home Minister Amit Shah faced off in Parliament over electoral reforms.

## Mamata Banerjee's Seat Saw 4X Voter Deletions Than Suvendu Adhikari's Nandigram

The Election Commission of India (ECI) has classified the deletions under standard categories such as deaths, relocation, untraceable addresses and duplicate entries.

#### New Delhi.(Agency)

Chief Minister Mamata Banerjee's Bhabanipur constituency has recorded one of the highest voter deletions in West Bengal, logging nearly four times more The commission has classified the deletions removals than Opposition Leader Suvendu Adhikari's Nandigram, according to constituency-wise data released by the Election Commission

(EC) on Friday. The EC released the figures a day after the deadline for submitting enumeration forms under the Special Intensive Revision (SIR) process ended, revealing significant variations across the state and adding a fresh political edge ahead of next week's draft rolls.

Data showed that Bhabanipur in south pocket borough, recorded 44,787 deletions from the 2,06,295 voters listed in January 2025, while Nandigram, the crucible of the anti-land acquisition

movement that propelled the TMC to power in 2011 and stronghold of Adhikari, Among the state's 294 Assembly saw 10,599 deletions from 2,78,212 voters.

Kolkata Port, represented by senior minister and Mayor Firhad Hakim, logged 63,730 deletions.

Hakim, a three-time MLA, had won the seat by a margin of around 70,000 votes, a factor that cemented his grip over the constituency. In Tollygunge, held by minister Aroop Biswas, 35.309 names were

removed.Biswas, a four-time MLA, had retained the seat in 2021 with a margin of about 50,000 votes, underscoring his organisational control over one of Kolkata's most politically crucial belts.

Though the dinner at Doddannavar's place is touted as a show of strength, those who attended it dismissed any such claims.

"It was only a dinner party.

About 50-60 MLAs attended the dinner. Such a meeting cannot be termed a show of strength. We did not discuss politics. If Shivakumar hosts a dinner, he will invite all the 224 MLAs. They will all come. That is because Shivakumar has cultivated several friends and he has strived hard for the party. If the party wants him as CM, he need not wait till Sankranti. He will become CM immediately after this session, Ramanagara MLA Iqbal Hussain.

Bandi Siddanagowda, Srirangapatna MLA, said that the high command will decide when

Shivakumar will become CM. "For the dinner, I was invited by my Belagavi friends. Do not draw any inference from it. There was no discussion on leadership," he said.

Magadi MLA Balakrishna said there was no head count or a meeting. "Some MLAs came and a few could not due to various reasons. It



was just a dinner, nothing else," he said.

On the chief minister's New Delhi visit, he said, "Everybody knows the purpose of his visit. My request to Yathindra is not to embarrass the

ST Somashekar said if it is destined, nobody can stop Shivakumar from becoming CM. "Why shouldn't he become CM. He has worked hard for the party." But MLA AS Ponanna said. "Somashekar is expelled from BJP, but he cannot join our party. He does not have the moral right to speak about our party."

## LG Saxena approves honorary ranks for Delhi Police personnel without financial benefits

In May, the MHA granted similar Honorary Ranks to personnel of CAPFs and Assam Rifles, on the day of retirement, without financial benefits.

LG VK Saxena approved the grant of Honorary Ranks—one level above existing posts—on Friday, benefiting over 88,000 personnel, Raj Niwas officials said. They added that this will not carry any financial or pensionary benefits.

The issue was first raised in 2014 by former IPS officers Deepak Misra, Sanjay Beniwal and Mukesh Kumar Meena, who had observed low



morale among lower-rank officials due to poor promotion policies and heavy workload. Beniwal and Meena had even prepared a detailed report. Misra retired as Special DG, CRPF; Beniwal as Director General (Prisons); and Meena as Special CP, Delhi Police. According to a statement from the LG office, Delhi Police personnel in non-gazetted ranks who have completed two years in their current post, have good APARs for the last five years. and have not faced major punishment, will be eligible for honorary ranks

## 'Officials should have refused illegal registrations': Ajit Pawar amid son's land deal row

NAGPUR.(Agency)

Maharashtra Deputy Chief Minister Ajit Pawar on Saturday said officials responsible for registering documents should have refused to process agreements that were not permissible under the law and clearly informed the parties concerned about such

His comments come against the backdrop of a notice issued by the deputy registrar to the firm of his son, Parth Pawar, seeking Rs 21 crore in stamp duty and penalties in connection with a controversial land deal in Pune.Recently, the Bombay High Court raised sharp questions regarding the police probe into the land deal, suggesting authorities might be shielding Parth Pawar by failing to name him in the FIR.

Ajit Pawar sought to dispel perceptions stemming from a bill cleared by the legislative assembly on Friday, which empowers the revenue minister to hold hearings in contentious cases related to the

IGR.Pawar said those who registered such documents were at fault, and officials should have exercised due diligence at the time of registration.

The officials who received the documents for registration of a deal should have refused to register it. They should have

clearly informed the parties that such an agreement cannot be processed," said the deputy chief minister. When asked about allegations that the bill was moved to protect Parth, who holds a 99 per cent equity stake in

Amadea Enterprises LLP, Pawar reiterated that responsibility lay with the registering authorities."We are elected representatives in the House, and people have voted for us. We are free to take decisions or make amendments we find suitable," he said when asked about the

intent behind the amendment. Revenue Minister Chandrashekhar Bawankule has said that under the earlier provision, complainants dissatisfied with decisions at the level of the IGR had to approach the High Court.

After the amendment, such complainants can now approach the revenue minister, who will be authorised to hold hearings in these matters.

They were named in an FIR registered at a police station in Pune.

## SIR is 'NRC in disguise', says Akhilesh Yadav

HYDERABAD.(Agency)

Samajwadi Party president Akhilesh Yadav has launched a scathing attack on the SIR of electoral rolls in Uttar Pradesh, alleging that it was "NRC in disguise" and part of a larger conspiracy to remove voters opposed to the BJP. Yadav, who is in Hyderabad to attend the Vision India - AI Summit on Saturday, also held meetings with Telangana Chief Minister A Revanth Reddy and BRS leaders, including its working president KTRama Rao.

Addressing reporters, Yadav said the Election Commission should focus on increasing voter participation instead of

allowing large-scale deletions. "More than three crore votes are at risk of

being cut in Uttar Pradesh," he claimed. "If such large-scale vote removal happens, and if the BJP and the Election Commission are conspiring to delete votes where the BJP has lost, it amounts to a conspiracy in democracy. This is not the intended purpose of the SIR.

This is not SIR. This is NRC (National Register of Citizens) in the guise of SIR. They could not directly implement the NRC. Now they have brought NRC. If the NRC is ever implemented, what documents have to be given? The same papers have to be presented," he said.

## Gurgaon cops step up heat on violators, 800 fined for flouting lane rules in 11 days

Gurgaon.(Agency)

In a crackdown against lane-driving violations, 842 challans were issued and fines amounting to around Rs 7 lakh were collected between Dec 1 and 11.The crackdown was part of a special drive to streamline vehicular movement and reduce road accidents. All violators were challaned "strictly as per traffic regulations" during the 11-day period, police said. The aim of the campaign is not only enforcement but also "long-term behavioural change", they said.

According to officials, the special campaign was launched to curb the growing menace of "lane-cutting and sudden lane-changing" two major contributors to road crashes in the city. Traffic teams were deployed across key stretches to monitor motorists, identify offenders and enforce lane discipline. "Despite clear markings, some motorists continue to violate lane norms," police said, adding, roads are marked to separate lanes: heavy vehicles are expected to keep left; lighter vehicles in the middle; and the right lane should remain primarily for overtaking. An official said, "Accidents are frequently caused when drivers abruptly switch lanes or drive in the wrong lane, endangering their own lives and those of others. Improper lane usage continues to be one of the biggest traffic issues in Gurgaon, often resulting in collisions, bottlenecks and unsafe driving conditions." The traffic unit regularly conducts awareness programmes for truck drivers, company staff drivers, school bus operators, auto-rickshaw drivers and other commercial vehicle operators. These sessions focus on safe-driving practices, proper lane usage and adherence

## 2 die as dumper crashes into culvert, catches fire on Delhi-Mumbai Expressway in Gurgaon

Noida.(Agency)

Two men were charred to death after a dumper truck crashed into a culvert and caught fire on Delhi-Mumbai Expressway on Friday evening. The incident took place around 5pm near Gurjar Nangla village when the vehicle was heading from Delhi towards Firozpur Jhirka. Preliminary suspicion points to high speed leading to loss of control, but mechanical failure has not been ruled out, police said. The deceased have been identified as Ranjit (36), a resident of Neemli in Rajasthan, and Rizwan (24), a resident of Dholet. Police said Ranjit was the maternal uncle of Rizwan."The impact was so severe that the heavy vehicle broke through the culvert and plunged off the expressway. Moments after it fell, the vehicle burst into flames, trapping the driver — Ranjit — and the conductor — Rizwan — inside." an officer said. Farmers working in nearby fields rushed to the spot and attempted to rescue the two despite the raging blaze.



They were able to drag Ranjit out of the blaze and and were rushed him to a hospital. However, he succumbed to his injuries on the way, an officer said.

Eyewitnesses said the fire spread rapidly.

While locals made repeated attempts to pull out Rizwan, the flames were too intense. Villagers said his body was burnt badly and he died on the spot. The bodies have been sent to Al Afia Hospital in Mandikhera for autopsy. Police are examining CCTV footage. "The mangled remains of the dumper have been removed from the spot to clear the carriageway," another officer said

### Nikki Bhati murder: Court denies bail to father-in-law

Noida.(Agency)

A district sessions court on Friday rejected the bail application of Satvir, who is accused of aiding the death of his daughter-in-law, Nikki Bhati, in Sirsa village last Aug. Additional sessions judge Atul Srivastava ruled that the seriousness of the allegations and the risk of witness tampering had made Satvir's release inappropriate at this stage.

On Aug 21, Nikki Bhati (32) was allegedly set on fire by her husband Vipin, mother-in-law Daya, brother-in-law Rohit, and father-in-law Satvir. According to a complaint filed by Nikki's sister, Kanchan Bhati, Nikki had faced persistent harassment for dowry since her marriage in 2016. On the evening of the incident, Kanchan, who is married in the same household, claimed the family poured a flammable liquid on Nikki and set her alight. She also alleged she was assaulted when she tried to intervene. Neighbours rushed Nikki to Fortis Hospital and later to Safdarjung Hospital in Delhi, where she succumbed to her injuries during treatment. Satvir was arrested on Aug 25 following the FIR filed by Kanchan. Rohit, the brother-in-law, had previously been denied bail, while Daya and Vipin have not yet applied for bail. During the bail hearing, Satvir's counsel, Manoj Mati, argued that Satvir was at his grocery shop on the ground floor when the incident occurred and only arrived upstairs after hearing a commotion. The defence cited CCTV footage showing Satvir at the hospital and highlighted Nikki's reported statements to medical staff, in which she claimed her burns were caused by a gas cylinder explosion.

Mati insisted the FIR was the result of family disputes and that Satvir, who has no criminal record, was being

falsely implicated.

## MCG expands anti-smog fleet, 5 new machines to combat dust in Gurgaon

PMCG has procured five new sprinklercum-anti-smog gun machines, with plans to double the fleet to 10 in the coming weeks.Officials said the purchase was mandated by Central Pollution Control Board (CPCB), which released a grant of Rs 4.8 crore for the purpose. Each machine costs around Rs 50 lakh. An MCG official said. "This is the first time that the MCG has bought its own machines to tackle pollution."The remaining five machines are expected to be purchased soon, after which deployment schedules will be finalised in coordination with the district pollution authorities. MCG officials said the enhanced fleet will "help extend coverage" to more areas and allow for more frequent rounds of dust suppression.Anti-smog guns are typically used along construction corridors, arterial roads and areas where



dust resuspension from traffic is high, officials said, adding they have decided the routes of these machines. According to officials, the machines will be deployed across pollution hotspots,

especially during the winter months when air quality dips sharply. The routes to be covered with these five machines include the stretch extending from Mahavir Chowk to Maharana Pratap Chowk and internal roads of Sector 14; internal roads of Sector 15 Part 1; Jharsa to Artemis Hospital Road; Jharsa to Huda City Centre, etc.

While such machines have become increasingly common across NCR cities, residents said that the authorities should work towards a long-term solution since such machinery offers only temporary relief, working best as part of a broader dust management plan that includes enforcing construction norms, covering debris and improving road maintenance.

Kundan Lal Sharma, a city resident, said, "In the face of widespread dust pollution, the proposed step is inadequate. Such reactionary measures achieve little. What we need is a continuous, system-wide dustmitigation plan sustained through all seasons. Even for a temporary measure, at least 50 machines should have been

## Raid reveals big grey mkt of foreign liquor in Gurgaon

Gurgaon.(Agency)

Foreign liquor that flies under the excise department's radar is available in abundance in the city, investigations that began with the discovery of a consignment of 47,000 bottles worth Rs 10 crore earlier this week at a vend called 'The Theka' at Signature Towers indicate.

The supply to multiple vends in the city has been happening for the past five years through a well-oiled syndicate, sources said. These are bottles for which customs and excise duties are not paid, helping traders make a much bigger grey profit than official sales, which have an end-toend tracking system with holograms.

The raid was conducted after a trader who has been in the city's liquor business for several years filed a complaint with the state and central govts, tipping them off on the thriving smuggling racket. Over the years, Gurgaon has become a goldmine for the excise department in Haryana with vend reserve prices drawing huge bids.

This year, the highest bid was Rs 98.6 crore. The vend from where the bottles were seized earlier this week was auctioned for Rs 50 crore. Retail business in the city has thrived on competitive pricing, with booze here selling at much cheaper rates than in Delhi and UP, and an abundance of premium brands. But has this been possible because of the thriving grey market, which has sustained the official business model? As the investigation tries to map the scale of this smuggling network, it's a question that is being asked increasingly, especially with the share of IMFL (Indian-made foreign liquor) sales falling in the city and that of foreign brands soaring. According to the complaint, IMFL sales in the city now account for only around 30% of the market share. Vend owners TOI spoke to on Friday agreed with this estimate. How were the bottles smuggled?Investigations have revealed that the syndicate set up at least 58 dummy customs bond companies - essentially fake warehouses on paper — to siphon off imported liquor into the retail market without paying customs duties.Imported liquor arrives in India by sea and is transferred to two govt-owned Customs warehouses in north India in Okhla and Gurgaon. From there, stocks instead was diverted straight to the retail market of the city and sold without any excise duties paid.

#### are supposed to move to private warehouses that have received a space certificate from Customs. Normally, the state excise department would track the movement of each bottle through a licensing process, ensuring all duties are paid before the liquor hits the retail shelves. That's how the official business model operates. But the syndicate bypassed this system entirely. On paper, the imported liquor was transferred from these two govt warehouses to other private warehouses. In reality, these warehouses did not exist at all. The liquor

Two die as car skids, overturns and gets hit by truck near Kherki Daula

Two men returning from a wedding function in Jaipur were killed and five others injured after the car they were travelling in skidded, overturned and was hit by a truck near the Rampura flyover in the Kherki Daula area on Thursday.

The victims were part of a wedding band and were on their way back to their rented accommodation in Deini accident took place at 4am, police said.

The deceased were identified as Govinda Singh, 23, from Faridkot in Punjab, and Mangal Singh, 20, from Fatehabad in Haryana. The two were close friends and had been performing together for several years. According to the police, the car, which had been rented for the band members, lost control after running over stones scattered on the road. A senior officer said initial findings suggest the stones may have fallen from a truck that had passed through the stretch earlier. The



vehicle hit the divider and overturned onto the opposite lane, where it was struck by a truck.Govinda and Mangal died on the spot due to head and internal injuries. The other occupants were rescued by passersby and taken to hospitals in Delhi, where they are undergoing treatment. Police seized the truck involved

in the collision and a case was registered under sections 281 (rash driving) and 106 (causing death by negligence) of BNS at the Kherki Daula police station. Police are also checking CCTV footage from the expressway and nearby toll points to find out how the stones came to be on the road and to

#### Owners of key commercial hub served notice for breaches in building code

Gurgaon.(Agency)

The district town planner (enforcement) has served a show-cause notice to the owners and collaborators of 32nd Avenue, a popular commercial hub in Sector 15-II. The move follows a recent inspection that uncovered deviations from the approved building and layout plans. The notice comes nearly 10 months after another one was issued in Jan 2025, which sought rectification of key breaches that, according to the department's latest findings, were not fixed.32nd Avenue is known for its vibrant food and retail offerings.

The first notice flagged several violations, including complete closure of a 6-metre fire tender path, operation of an office in basement-1, and illegal closure of the basement's second exit. The actions directly contradicted the sanctioned plans for the area known as "32 Avenue". Despite being given time to respond, officials reported that no satisfactory reply or corrective action was received over the past year.District town planner (enforcement) Amit Madholia said, "The latest inspection has revealed that not only were the earlier violations left unaddressed, but several additional contraventions have emerged. These include encroachment of an unlicensed green belt or service road by erecting a wall, obstruction of the service road through kiosks, and conversion of a banquet hall approved under the occupation certificate — into multiple shops, cafés and restaurants."

## Noida expressway's parallel sector roads to be linked as riverside highway stalls

Noida.(Agency)

A plan to build a second expressway along Noida Expressway has run into a roadblock after the irrigation department refused a noobjection certificate for construction along the Yamuna embankment from Okhla Barrage near Kalindi Kunj to Yamuna Expressway near Pari Chowk.With the proposed 30km corridor stalled, but traffic pressure growing on the expressway, Noida Authority has shifted focus to making a 45-metre-wide sector road expressway fully operational. But this will be an interim measure. Efforts to build the second expressway, officials said, would continue and regulatory approvals would be sought again. The 25km Noida Expressway is a six-lane corridor. On both sides of the main carriageway run narrow service lanes. Beyond these service lanes lie wider 45metre-wide sector roads that are, for now, parallel connectors for local traffic. It is these outer

45-metre stretches that the Authority wants to develop as relief corridors.Officials said this road could absorb a portion The existing 11 km Yamuna of the traffic currently using the expressway, which carries lakhs of vehicles daily. But the sector roads currently are not continuous stretches and have interruptions at three points between Greater Noida and Noida, where land acquisition remains pending. These gaps, extending 74 metres, 75 metres, and 81.5 metres, respectively, are between sectors 163 and

#### Caretaker exploits phone access to dupe elderly woman of Rs 14 lakh, arrested

New Delhi: The Delhi Police have arrested a man from Rajasthan for allegedly defrauding an elderly woman of over Rs 14 lakh while working as her caretaker in southwest Delhi's Dwarka, an official said on Sunday. The accused, identified as Deepak Kumar Saini (31), hails from Chokdi village in Rajasthan, he said. According to the police, Manjusha Rani Gupta, a resident of Royal Residency in Dwarka, filed a complaint that her former caretaker had accessed her mobile phone without permission and transferred money from her bank account to his account using Paytm between January 30 and June 6. Saini, who had been working in Gupta's house since March 2020, exploited his occasional access to her phone to install financial applications, retrieve OTPs, and carry out all unauthorised transactions without her knowledge, police said. He stole a total of Rs 14.35 lakh from Gupta's mobile phone. During the investigation, the police identified the accused by analysing call records, customer application forms, bank transactions, and IP logs. New Delhi: A 40-year-old scrap dealer was stabbed to death by his live-in partner in the DLF Phase 3 area here early on Saturday after an argument over him talking to his wife, police said. Harish Sharma, a resident of Baliawas village in Gurugram, had been in a live-in relationship with the 27-year-old accused, Yashmeet Kaur, for more than a year. They lived in a rented flat. Sharma was married and had two daughters who lived with his wife in the village. His wife was not keeping well for some time, and Sharma would often talk to her, which infuriated Kaur, police said. On Friday night, Kaur saw Sharma talking to his wife, and the couple had a heated argument. In a fit of rage, Kaur stabbed Sharma in the chest with a kitchen knife. He was taken to a hospital but was declared dead on arrival. A friend of the deceased, Vijay alias Sethi, who was reportedly present in another room, is also under the scanner. The victim's nephew has alleged in his complaint that both Kaur and Vijay planned the murder. Kaur, a resident of Delhi's Ashok Nagar, has been arrested and has confessed to the crime, police said, adding that the murder weapon and a blood-stained T-shirt were seized from the flat.

### Delhi Police SI held for taking Rs 40,000 bribe

New Delhi: The Central Bureau of Investigation (CBI) on Wednesday apprehended a Sub-Inspector (SI) of the Delhi Police for allegedly accepting a bribe of Rs 40,000 from a complainant, the agency said. The Sub-Inspector, Vijay Singh, who was posted at the North Rohini police station, has been suspended with immediate effect. "The CBI apprehended SI Vijay Singh, who was posted at the North Rohini police station, while accepting a bribe of Rs 40,000 in a case being investigated by him. SI Vijay and his supervisory officer, SHO of the North Rohini police station, have been placed under suspension with immediate effect and departmental proceedings have been initiated against them," the Delhi Police said in a statement on X. The CBI registered a case against the SI on Tuesday based on a complaint alleging that the officer had demanded a bribe of Rs 50,000 for not arresting the complainant's cousin and also helping him to secure anticipatory bail. After negotiation, the SI agreed to accept the bribe of Rs 40,000. A trap was laid and the SI was caught red-handed while accepting the money, an official said. #### Over 8 Lakh people screened for tuberculosis

New Delhi: Delhi Health Minister Pankaj Kumar Singh on Thursday reviewed the TB Mukt Bharat Abhiyan. He was apprised by officials that 8.78 lakh individuals have been screened and 3.8 lakh chest X-rays conducted since the campaign began. "We will continue to strengthen our screening and support systems, and community participation to ensure that every TB patient receives timely care, nutrition and encouragement," the health minister said. Officials from the ministry said Delhi achieved 99% of its National TB Elimination Programme Delhi operates 190 diagnostic centres and 365 treatment centres.

to premeditated murder Woman dies by suicide in Southeast Delhi's Sunlight Colony area

New Delhi: Her family has alleged that she faced sustained abuse from her husband and in-laws since her marriage nearly two years ago. According to police, a PCR call about the incident was received around noon on Saturday. When officers arrived at the scene, the woman, identified as Sadhna, was found hanging in her room in the Sidharth Basti locality. Her body was sent for post-mortem and later handed over to the family. Statements of her mother and brother were recorded by the Sub-Divisional Magistrate of Defence Colony. Sadhna's mother, Sunita, alleged that her daughter endured constant harassment. "She was never happy in that house. They kept hurting her," she said tearfully. Recalling the morning of the incident, Sunita said she had spoken to Sadhna around 8.30 am. "She didn't say anything was wrong. I left for work soon after. Later, my elder daughter called to inform me that Sadhna had taken her life. By the time I got home, her body had already been taken down.

The family has filed a written complaint with the police and submitted a video as evidence. "We want justice. Those responsible for pushing my daughter to this must be punished." Sunita demanded. Police said the case is under investigation and action would be taken based on the findings. Meanwhile, a video circulating on social media shows Sadhna in tears, alleging repeated physical abuse by her husband, Yogesh, and his family. In the footage, she claims the violence began after

she married Yogesh against the wishes of both families. Police are currently verifying the video's authenticity.

### Iran Detains Nobel-Prize Winner In "Brutal" Arrest

**HONG KONG.(Agency)** 

Iranian security forces on Friday detained the 2023 Nobel Peace Prize winner Narges Mohammadi along with at least eight other activists in an arrest condemned as "brutal" by the Norwegian Nobel committee. Mohammadi, who was granted temporary leave from prison in December 2024, was detained along with eight other activists at the ceremony for lawyer Khosrow Alikordi, who was found dead in his office last week, her foundation wrote on X.Those arrested at the ceremony in the eastern city of Mashhad included Mohammadi's fellow prominent activist Sepideh Gholian, who had previously been jailed alongside her in Tehran's Evin prison."These individuals were present solely to pay their respects and express solidarity at a memorial ceremony," her foundation said, adding the arrests "constitute a blatant and serious violation of fundamental freedoms and basic human rights".

'Narges was beaten on the legs and she was held by her hair and dragged down," one of her brothers, Hamid Mohammadi, told AFP in Oslo where he lives.

The Norwegian Nobel Committee said it was "deeply concerned by today's brutal arrest" of Mohammadi, calling on Iran to "immediately" clarify her whereabouts. The arrest came two days after the ceremony in Oslo for the 2025 prize winner, Venezuelan opposition leader Maria Corina Machado, a fierce critic of Venezuelan President Nicolas Maduro who is an ally of Tehran.

The Nobel committee said it "notes" the timing "given the close collaboration between the regimes in Iran and Venezuela". Within Iran, the Mehr news agency cited the Mashhad governor Hassan Hosseini as saying the individuals were arrested at the ceremony after "chanting slogans deemed contrary to public norms" but did not name them.

## Americans Skeptical Of Trump On Epstein, But Republican Doubts Ease: Survey

Washington . (Agency)

Americans are deeply skeptical of President Donald Trump's handling of the Jeffrey Epstein scandal, though he is shoring up support among his core Republican followers who have long focused on the case, a new Reuters/Ipsos poll found. The poll, completed on Monday, found that most Americans believe Trump's administration is covering up information about the late sex offender, including his 2019 death and his ties to rich and powerful people, and do not believe Trump's claim that he was unaware of Epstein's alleged trafficking of teenage girls when the two were friends decades ago. Only 23% of Americans approve of the way Trump is handling the ongoing scandal, the poll found, while 52% disapprove. However, the poll found he appears to be easing the concerns of his supporters: 53% of Republicans said they approved of the way he was handling the issue, up from 44% last month. That is still well below the 85% approval rating Trump enjoys overall among Republicans. That could prove crucial. Trump stoked conspiracy theories about Epstein before he returned to the White House this year, and prominent supporters have accused his administration of a cover-up. Republicans and Democrats in Congress defied Trump last month and passed a law requiring the Justice Department to release documents by December 19 from its longrunning investigation into Epstein. The online poll of 4,434 U.S. adults, conducted December 3 through December 8, found lingering suspicion about the U.S. government's role. Some 62% of those surveyed, including 56% of Republicans, said they believed the government is hiding information about Epstein's death, which was ruled a suicide, in a Manhattan jail in 2019 as he faced federal sex trafficking charges. An even higher proportion - 70% - said they thought the government is hiding information about people who may have participated in the late financier's alleged sex trafficking of teenage girls, including 62% of Republicans.

However, on Saturday, Thai Prime Minister Anutin Charnvirakul said the country would "continue to perform military actions until we feel no more harm and threats to our land

and people".Bangkok's joint press centre confirmed that Thai forces had "retaliated" against Cambodian

## Trump sued by preservationists seeking reviews, congressional approval for White House ballroom project

BANGKOK. (Agency)

President Donald Trump was sued on Friday by preservationists asking a federal court to halt his White House ballroom project until it goes through multiple independent reviews and wins approval from Congress. The National Trust for Historic Preservation, a privately funded group, is asking the U.S. District Court to block Trump's White House ballroom addition, which already has involved razing the East Wing, until it goes through comprehensive design reviews, environmental assessments, public comments and congressional debate and ratification.

The project has prompted criticism in the historic preservation and architectural communities, and among his political adversaries, but the lawsuit is the most tangible effort thus far to alter or stop the president's plans for an addition that itself would be nearly twice the size of the White House before the East Wing's demolition."No president is legally allowed to tear down portions of the White House without any review whatsoever — not President Trump, not President Biden, and not anyone else," the lawsuit states. "And no president is legally allowed to construct a ballroom on public property without giving the public the opportunity to weigh in."

Additionally, the Trust wants the court to declare that Trump, by fast-tracking the project, has committed multiple violations of the Administrative Procedures Act and the National Environmental Policy Act, while also exceeding his constitutional authority by not the Trust argues, until administration officials "complete the required reviews — reviews that should have taken place before the Defendants demolished the East Wing, and before they began construction of the Ballroom."White House maintains that Trump has 'full legal authority' over the building

Asked questions about the lawsuit, White House spokesman David Ingle responded with a blanket assertion that Trump is within his "full legal authority to modernize, renovate and beautify the White House - just like all of his predecessors did."Ingle did not specifically address an Associated Press question asking whether the president would consult Congress at any point. The White House response correctly notes that essentially every president makes some changes to the White House. But Trump's efforts are the most sweeping since a nearly complete gutting of the decaying interior of the oldest portion of the mansion during President Harry Truman's tenure.

## California, 19 other states sue Trump administration over USD 100,000 H-1B visa fee

BANGKOK .(Agency)

President Donald Trump's USD100,000 fee on new H-1B visas for highly skilled foreign workers, according to a report by Reuters. California Attorney General Rob Bonta is leading the 20state coalition lawsuit, calling the policy unlawful and warning it could disrupt sectors that rely on skilled foreign workers.

The lawsuit, filed Friday in federal court, argues that the Department of Homeland Security (DHS) imposed the fee outside the bounds of congressional authority and bypassed required notice-and-comment procedures. Bonta's office said the fee, more than 10 times the typical H-1B cost, would place significant strain on schools, universities, and hospitals that depend on H-1B employees.

The H-1B program allows employers to hire highly skilled foreign workers, including engineers, researchers, doctors, and teachers. While many government and nonprofit employers are exempt from the program's annual



fee, which critics say will make it harder to recruit essential personnel amid nationwide shortages.

Trump signed the executive order on September 19, introducing the USD 100,000 charge for new H-1B petitions. DHS retains discretion over which applications are subject to the fee, prompting states to argue it could be applied selectively. Joining California in the lawsuit are Arizona, Colorado, Connecticut, Delaware, Hawaii, Illinois, Maryland, Massachusetts, Michigan, Minnesota, Nevada, North Carolina, New Jersey, New York, Oregon, Rhode Island, Vermont, Washington, and Wisconsin.

A local official reportedly acknowledged arrests had been made, but did not directly name Mohammadi, 53. It wasn't clear if authorities would immediately return her to prison, where she had been serving a sentence until her temporary release in December 2024 for medical purposes. However, her detention comes as Iran has been cracking down on intellectuals and others as Tehran struggles with sanctions, an ailing economy and the fear of a renewed war with Israel. Arresting Mohammadi may spark increased pressure from the West at a time when Iran repeatedly signals it wants new negotiations with the United States over its nuclear program — something that has yet

to happen. The Norwegian Nobel Committee said it was "deeply concerned" by Mohammadi's arrest. The committee "calls on the Iranian authorities to immediately clarify Mohammadi's whereabouts, ensure her safety and integrity, and to release her without conditions," it said in a statement.

Activist detained at ceremony for dead lawyerHer supporters on Friday described her as having been "violently detained earlier today by security and police forces." Hosseini described the detentions as preventive to protect those there from others in the crowd, but did not address claims that security forces used violence in making the arrests.

### Oil depots shut in Manipur over threats; fuel crisis deepens

Oil depots across Manipur remained closed on Saturday in protest against threats and extortion demands issued by unknown armed persons.

The shutdown has triggered a major fuel crisis, as oil depots had already been closed for the past two days due to a strike called by various organisations. With fuel supplies disrupted for three consecutive days, many people were forced to purchase petrol from the black market. The Manipur petroleum dealers' fraternity called for the shutdown following an incident on December 6, when a hand grenade was found inside an oil depot at Koirengei in Imphal. An intimidating letter threatening the staff was also recovered from the site.

Condemning the incident, the fraternity appealed to authorities to ensure the safety of oil depot staff and demanded an end to

#### Manipur Police seize arms and explosives near Khuga Dam

Manipur Police recovered a significant cache of arms, explosives, and other war-like materials during a search operation near Khuga Dam, under Churachandpur Police Station, in Churachandpur district on Friday.

The seized items included a locally made .303 rifle, three pistol magazines, a 51 mm mortar smoke bomb, a stun grenade, and an improvised mortar (PUMPI). Authorities also recovered four improvised explosive devices (IEDs), 12 rounds of ammunition of various calibres, two ammunition clips, and a cartridge belt for a 12-bore weapon.

In addition, two Baofeng hand-held wireless sets, two helmets, and a tactical belt fitted with magazine and pistol pouches were recovered from the area, police said today.

### Maharashtra braces for cold wave; temperatures drop below 10 degrees Celsius

#### Pune. (Agency)

Maharashtra is likely to experience a cold wave, with temperatures in several districts falling below 10 degrees Celsius, according to the India Meteorological Department (IMD).

Dense morning fog is being reported across many regions, while cold conditions have intensified in Marathwada and Vidarbha. The IMD has warned that chilly weather is expected to persist throughout December.

In response, several schools have rescheduled opening hours to cope with the low temperatures.

Northern India is also witnessing a sharp drop in temperatures, with states such as Punjab, Uttarakhand, Jammu and Kashmir, Haryana, Madhya Pradesh, Bihar, and Uttar Pradesh experiencing intensifying cold waves.

Cold northerly winds sweeping across the region are contributing to falling temperatures in Maharashtra as well. The IMD has cautioned that the cold is likely to strengthen further in the coming days.

Cities including Pune, Mumbai, and Nashik are experiencing a significant chill due to incoming cold waves from the north. The IMD forecasts that these waves will continue to persist, keeping winter temperatures unusually low across the state.

In terms of minimum temperatures, Jeur recorded 5 degrees Celsius, while Parbhani and Niphad recorded 5.5 degrees Celsius and 5.6 degrees Celsius respectively. Ahilyanagar and Nashik saw temperatures drop below 8 degrees Celsius.

Other districts including Washim, Satara, Bhandara, Gondia, and Nagpur recorded minimum temperatures around 10 degrees Celsius. Cold conditions have also intensified in Chhatrapati Sambhajinagar, Jalna, Parbhani, Nanded, Beed, Latur, Hingoli, and Akola, signaling a noticeable increase in winter chill across most parts of the state.

#### Mumbai .(Agency)

In some corners of South Bombay, time holds a different rhythm — meals are hearty, prices are modest, and tables stay full. While portions shrink and prices climb elsewhere, these old eateries still serve generous plates without straining the wallet. One of them is Bagdadi in Colaba, a century-old institution loved for its traditional Mughlai food.

Featuring an old wooden structure with a high ceiling now reinforced with iron bars, Bagdadi is a reminder of an era gone by, but earnestly preserved. A fresh coat of white paint, wooden trims, a couple of posters, and bench-style seating keep the space simple and functional. On one wall hang photographs of old Bombay, and next to it, a large, old-style menu board lists biryani, mutton, chicken, dal, and more in English and Urdu, with a note at the top: "Half Plate Price".

#### A joint for labourers

Like most eateries of its time, Bagdadi was built to serve those who had left their homes and fields to make a living in the city.

'When my great-grandfather, Banne Sukhe, came to Bombay, he noticed a dearth of eateries in the vicinity, especially for labourers constructing the Gateway of India and the Taj Mahal Hotel (now The Taj Mahal Palace). So he started this eatery," shared Saud Ahmed, 34, the fourth generation at the helm. "There's no story behind the name, except that he used to frequent Baghdad," added his father, Atique Ahmed, 62. Atique recalls coming here during his summer vacations and learning the tricks of the trade. While Bagdadi was officially registered as a "tea stall" in 1936, he estimates that it began sometime in the late 1890s. "Back then, all the licences were issued for tea stalls,



he said.

Bagdadi started as a 1,700-sqft eatery serving tea, biscuits, bun maska, keema pav, shami kebab pav, urad dal, rice, and Irani khubz — a soft, chewy, large tandoori roti. Some of these dishes are still on that old menu board.

'Back in the day, a lot of ships would come to Bombay. A lot of Arab traders, too. That led us to start these giant tandoori rotis," said Atique, adding that they were the first to establish a tandoor in South Bombay, if not the entire city.

'The tandoors you commonly see have very small capacity. They wouldn't have met our demand. Ours is bigger, built inside the premises, with a thick metal ring around it," he said, while walking us to the kitchen where an igloo-like structure glowed with live coal. Back in the dining room, Saud pulls out a graphic for Bagdadi's 'legendary banger' shami kebab pav, grinning as he announces it's returning, at Rs 80 a plate. From freedom fighters to traders, actors, and sportsmen

Bagdadi's crowd has shifted with the city. It began with labourers, then traders — Arabs, Irani, Iraqi and Parsis. Atique recalled that pre-Independence, if a protest took place at Azad Maidan, the crowd would often walk to Bagdadi for tea and a meal. "Even today, many of our regulars are retired Army and Navy men," said Saud, who himself grew up visiting before studying hospitality at Rizvi College.

By the 1970s and '80s, film crews were the latenight staple. "Amitabh Bachchan came with his team and had chole masala. Sanjay Dutt was a regular, he's now like a family," said Atique. Word travelled, and the menu expanded to match: chicken fry biryani, fish curry, and brain masala.

Cricketers followed. Ravi Shastri still orders; Suresh Raina drops in. "Players from Cooperage Football Ground would come after matches — from Shabbir Ali to Ranjit Thapa." There is also the story of M F Husain taking a particular table, reading his newspaper, and having copious cups of tea.

### Meghalaya: MPSCB will hold scheduled public hearing for setting up of cement plant

Despite opposition from a section of the society, the Meghalaya State Pollution Control Board (MSPCB) would hold the scheduled public hearing on the proposed establishment of a cement plant at Daistong village in East Jaintia Hills district.

'We cannot cancel the public hearing in Daistong village after receiving the Term of Reference (TOR) from the Central Regulator (CR). The MSPCB must complete the public hearing within 45 days," MSPCB Member Secretary, G.H. Chyrmang, said on Saturday.

"The public hearing will be carried out strictly as per Environment Impact Assessment (EIA) 2006 guidelines. Our responsibility is to organise the hearing in coordination with the district authorities of East Jaintia Hills,' he said. On the demand for the cancellation of the public hearing, Chyrmang said, "I have nothing to say on their demand. Our role is only to ensure compliance with EIA requirements.

We will move forward with the public hearing."The Jaiñtia National Council (JNC), along with residents of Daistong village and surrounding areas of Elaka Nongkhlieh, on December 10 had staged a protest outside the office of the Deputy Commissioner in Khliehriat seeking halt to the upcoming public hearing for Shree Cement Company, citing that the company does not adhere to environmental rules. The groups alleged that the Shree Cement Integrated Cement Plant violated Section 2 of the Meghalaya Transfer of Land (Regulation) Act, 1971, which prohibits the transfer of tribal land to non-tribals without written permission from the Deputy Commissioner.

Moreover, they said that the cement company did not received permission from the Jaintia Hills Autonomous District Council and that the project does not adhere to environmental rules.

## Families who escaped 1984 anti-Sikh riots fear displacement again in Mohali

Residents of a rehabilitation colony in Mohali's Phase 11 have intensified protests against an anti-encroachment drive, saying the demolitions have revived memories of displacement after the 1984 Sikh riots and threaten their only source of livelihood.

The residents of the rehabilitation colony in Mohali's Phase 11 As the anti-encroachment drive Friday set up their tents as part of their continuous protests for the last three days against the Municipal Corporation and GMADA's joint antiencroachment drive.

The joint drive that began on November 27, from Mohali's Phase 4, had to be halted as it faced strong resistance from the residents. Following this, the authorities issued a final public notice before 1 December 2025, giving encroachers three days to remove illegal structures on their own. Failing compliance, the MC and GMADA announced that they would proceed with removals

under the directions of the Punjab and Haryana High Court.

From there we came here. The government gave us matchboxlike rooms, and we made them our homes. Our children grew up here.

But now, after hearing about demolition again, we haven't been able to sleep at night. Where do we

The small rehabilitation colony shared a collective voice: "If the government gives us proper commercial spaces, why would we run shops from our homes? We are not illegal encroachers on public roads. We simply can't afford high rents. What other option do we have?'

The action by GMADA and the Municipal Corporation has reopened the wounds of decades past. These families, who rebuilt their shattered lives after losing everything in the riots, once again stand under the looming threat of displacement.

## Passage to Dubai: A geoeconomic artery of influence

After an absence of almost a year, I found myself making a couple of visits to Dubai, and I must say I am more impressed than ever. It's a city that has never been content to accept the horizon as the boundary of possibility. In a landscape where sand once dictated limits, ambition now sketches skylines; where imagination once seemed speculative, innovation now stands in steel and glass.Dubai's transformation has not been driven by ambition alone, but by the systems that sustain ambition: transparent regulation, predictable frameworks, and institutions that function with consistency and foresight. It has shown that when policy, professionalism and preparedness move in harmony, a city evolves from a centre of activity into a model of confidence for the wider world.

While ambitious geopolitical projects like the India-Middle East-Europe Economic Corridor grab headlines, a more powerful and dynamic economic artery is already pulsating between India and the UAE without any fanfare. There's a bustling, organic 'Delhi-Dubai Passage' forged from an ever-rising exchange of business, people, and ideas. What you see in Dubai is one of the world's most exciting geoeconomic sites, a powerful nexus of commerce, strategy, and cultural exchange that's quietly reshaping the possibilities for India. The economic statistics are nothing short of phenomenal. Bilateral trade between India and the UAE has rocketed, reaching an astounding \$100.06 billion in 2024-25. This explosive growth is largely fuelled by the landmark Comprehensive Economic Partnership Agreement signed in 2022, which has eliminated tariffs and streamlined trade across a multitude of sectors. The UAE is now India's third-largest trading partner and may soon overtake the tariffladen US, while India has become the UAE's second-largest. The previously ambitious goal of \$100 billion in non-oil and non-precious metals trade by 2030 has been revised to 2028, and given the 34 percent increase in the first half of 2025, seems entirely attainable.

Dubai's role as a global marketplace is crucial to this success. Its central location makes it an ideal hub for Indian exports, from textiles and agricultural products to jewellery and cutting-edge technology. This strategic positioning allows Indian businesses to seamlessly connect with international supply chains, leveraging the UAE's immense influence as a global trade giant. Dubai is connected everywhere. (Indian exports even go to Pakistan, after due repackaging here.)

Beyond trade, Dubai, already teeming with Indian talent, is becoming a powerful magnet for Indian capital investment. In the first quarter of 2024, India emerged as Dubai's largest source of foreign direct investment, contributing a staggering \$3.05 billion and representing 21.5 percent of the Emirate's total inflow. This isn't a gradual shift; it's a seismic leap from just \$589 million in the same period a year earlier. This five-fold increase in just one year propelled India from the fifth to the first place.A key factor in attracting this investment is the UAE's network of duty-free zones, which offer foreign companies full ownership, tax exemptions, and simplified regulations. The Jebel Ali Free Zone (Jafza), for instance, is now home to over 2,300 Indian companies, marking a 15 percent year-on-year increase. Similarly, the Dubai Multi-Commodities Centre has seen an influx of Indian businesses, with nearly 3,900 Indian companies now operating within this single free zone. These numbers paint a clear picture of Dubai's role as a launchpad for Indian enterprises looking to go global. Dubai's significance extends far beyond. On a strategic level, India and the UAE are increasingly aligned on key issues. Our countries collaborate on the security of vital maritime routes, counter-terrorism efforts, and the formation of new regional frameworks like the I2U2 group, which brings together India, Israel, the UAE, and the US (though it has recently been dormant thanks to regional tensions)

## DeepSeek saga holds lessons for India

#### State-funded BharatGen will have to walk a tightrope by balancing govt support and public good


IN January this year, a little-known Chinese startup made a dramatic announcement which shook up the world of artificial intelligence (AI). The company was DeepSeek, which released its Large Language Model (LLM) to compete with models developed by American technology giants, such as ChatGPT.What surprised everyone was the minuscule cost of its development in comparison to hundreds of billions of dollars spent by Silicon Valley behemoths. The development showed to the world that China was much ahead in AI and that America was not the only dominant force in technology development. Now, scientific journal Nature has named DeepSeek founder Liang Wenfeng among the top 10

people behind key scientific developments globally during 2025.DeepSeek's general-purpose V3 model and advanced model, R1, did not just make sensational headlines but have made a substantial difference to the AI landscape in just about a year. R1 is a reasoning LLM that can handle complex tasks in mathematics and coding. The Chinese firm went a step ahead of American companies by making DeepSeek an open model, allowing researchers to adapt the model's algorithms for different fields. It has also revealed how it kept the 'training' costs so low.All LLMs have to be fed with massive amounts of data or must be 'data-trained' to make them efficient. An industry survey has shown that Chinese models raced ahead in the AI markets this year, accounting for one-third of the global use of this

technology. Chinese-language prompts ranked second in token volume behind English. It shows that the Chinese models are doing well globally and also being used widely within China. Tokens are units of data processed by AI models during training and inference and help in enabling prediction, generation and reasoning.

Soon after the DeepSeek splash, India announced a set of projects to develop foundational models, including LLMs, Small Language Models and problem-specific AI solutions suitable for Indian needs. The plan includes the development of Digital India Bhashini (AI language translation platform for Indian languages), BharatGen (multimodal LLM for public service delivery), Sarvam-1 AI Model (LLM for 10 Indian languages), Chitralekha (video transcreation platform) and Hanooman's Everest 1.0 (a multilingual AI system for 35 Indian languages). A consortium of technology institutes, BharatGen, was

formed with headquarters at IIT-Bombay; it was tasked with the development of 'sovereign multilingual LLMs' with funding from different ministries, including Rs 980 crore from the National AI Mission. The support makes BharatGen the first such venture mandated to develop LLMs as a national goal. Since the Indian announcement followed soon after that of DeepSeek, BharatGen has been viewed as a direct response to the Chinese initiative. However, there are significant differences. DeepSeek is a commercial venture, built in the startup mode and meant to serve global markets. BharatGen is a strategic national mission, fully funded by the government and focused on achieving technological



sovereignty. A key challenge for global models like ChatGPT and DeepSeek is understanding India's complex linguistic and cultural diversity. BharatGen seeks to fill this gap as it will be trained on vast amounts of Indian-specific data. DeepSeek models are general purpose and meant for global consumption, while BharatGen will be India-specific. The biggest difference is the fact that DeepSeek is already in the market, while BharatGen is yet to announce firm timelines.

Unlike companies that developed ChatGPT, DeepSeek and other such LLMs, BharatGen is not a commercial venture. It has been registered this month as a non-profit company by IIT-Bombay. Though it is fully funded by the government, it is a corporate entity. Ganesh Ramakrishnan, the IIT professor who heads the BharatGen Technology Foundation, has explained that autonomy and operational flexibility are necessary to take AI models from the lab to the market.

BharatGen is an interesting example of what can be called 'government entrepreneurship' — a model of the 1970s and 1980s. Two of the most successful technology ventures of that period - Computer Maintenance Corporation (CMC) and Centre for Development of Telematics (C-DOT) — followed this model. Both were formed to assert technological sovereignty and promote self-reliance in strategic areas. In both cases, research institutions like IITs and Tata Institute of Fundamental Research contributed significantly.

The absence of Indian technology companies in the development of foundational models is intriguing, though

> the private sector has been enthusiastic about collaborating with global firms in creating AI infrastructure such as data centres. The Indian technology services industry, with revenue close to \$200 billion, should not remain just a bystander or mere adopter in the fast-changing AI landscape. It has the necessary talent, experience and financial power that must be used for national ventures like BharatGen.

DeepSeek is owned and funded by a Chinese quantitative hedge fund, High Flayer. The founder and CEO of both companies is Liang Wenfeng. It is not supported by the government, but the models it has developed follow government rules of censorship. The current Chinese regulations require all AI services to "reflect socialist core values" and refrain from delivering content that might "subvert state power" and "undermine national unity". The Chinese models go silent or provide the official view on topics like the Tiananmen

Square protests, status of Taiwan, human rights violations and criticism of the Chinese Communist Party leadership.

The India AI Governance Guidelines, released last month, talk of "responsible AI development" and underscore the need for accountability, fairness, safety and human oversight. The state-funded BharatGen will have to walk a tightrope by balancing government support and public good. Its models must avoid algorithmic bias seen in Western models and also steer clear of misinformation as well as possible political influence as seen in the Chinese models. Given that it is being funded from the taxpayer's money, BharatGen must follow principles of transparency and accountability while developing its LLMs for different language models. Wider engagement with linguists, social scientists and experts from different fields would go a long way in developing robust AI models and avoiding mistakes of others.

## Impeachment not the right tool for judicial disagreement

Through an impeachment notice in the Lok Sabha against a high court judge over what essentially was a judicial disagreement in Tamil Nadu, the opposition INDIA bloc weaponised a sparingly-used constitutional tool to serve political ends. While on a single-judge bench of the Madras High Court, Justice G R Swaminathan recently allowed a PIL directing the Subramaniya Swamy temple at Madurai's Thiruparankundram hill to light an annual lamp at a deepathoon (stone lamp pillar) adjacent a hilltop dargah. Observing that the temple was duty-bound to do so, the judge ruled that lighting the lamp there would not encroach upon the rights of the dargah or the Muslim community. Since the temple authorities refused to comply, the petitioners filed a contempt petition. The judge then allowed the petitioners to go to the deepathoon themselves with security cover from central paramilitary forces to light the lamp. The DMK government, however, blocked it and approached the Supreme Court, which agreed to hear the matter. Yet, the opposition jumped the gun.Impeachment provisions under Article 217 of the



Constitution, read with Article 124, are special tools that deliberately set a high bar for sacking judges in the higher judiciary. Both require rigorous proof of misbehaviour or incapacity, as also a special majority in parliament. Besides, the presiding officer, who is the gatekeeper, "may either admit the motion or refuse to admit the same" even it has the requisite signatures. The grounds for impeachment of Justice Swaminathan include "serious questions" regarding impartiality and transparency; favouring a particular senior counsel and advocates from a particular community; and flouting secular principles. His supporters, however, argue that the charges not only gloss over his erudition and high disposal rate of cases, but also progressive verdicts like affirming the rights of transgender persons and recognising civil unions of samesex couples. Judicial independence is part of the basic structure of the Constitution. Browbeating it to align with the executive goes against the spirit of democracy. The Constitution provides various appellate mechanisms to challenge judicial decisions. The state government ought to have waited for the Supreme Court to take a call and bring quietus to the matter. Contesting judicial decisions is a legitimate right, but seeking impeachment is hardly the way to go about it.

When the Government of India released a report titled powerfully: at the secondary school level, girls are now marginally ahead of boys in enrolment. The Gender Parity Index at this stage is close to 1.1, meaning that in many classrooms across the country, girls slightly outnumber boys. Add to this the sharp fall in secondary school dropout rates from 13.8 percent in 2022-23 to 8.2 percent in 2024-25 and the steady decline in child marriage, and a clear story emerges. India's long-term investment across levels-national policies, state innovations, and community leadership in educating its daughters is paying dividends. This progress reflects years of sustained policy action, with state-level innovations that build on broader policy priorities to strengthen outcomes for girls. This includes initiatives such as free cycles in several states including Jharkhand, hostels for girls in Madhya Pradesh, and Odisha's ANWESHA scheme, which has supported over 22,000 disadvantaged children including girls in betterequipped urban schools since 2015.

Equally signifiant is Odisha's Mission Shakti, one of the largest women's self-help group movements in the country, which shows how women's collective leadership can inspire adolescent girls. Philanthropies and companies have also complemented government action by piloting adolescent programmes, funding digital classrooms, and supporting safe transport. Together, these efforts have created an environment where families see girls' education as both possible and valuable.But enrolment is only the first step. The next challenge is ensuring that girls who remain in school can also transition smoothly into higher education, vocational training, and meaningful work. Without this

transition, the current gains risk being short-lived. Children in India 2025, one statistic stood out quietly but First, strengthening the bridge from school to higher education. The government can expand transport subsidies, hostel facilities, and targeted scholarships, especially for rural girls. District administrations could consider establishing cluster colleges in semi-urban

centres to expand access to higher education beyond distant cities. ### **UP:** Wolf terror continues in Bahraich, one-year-old child abducted

#### Bahraich. (Agency)

The menace of wolf attacks continues unabated in Uttar Pradesh's Bahraich district. In a shocking incident early Saturday morning, a wolf reportedly carried away a one-year-old child who was sleeping beside her mother in Jaruwa hamlet of Godahiya No. 4 village under the Kaiserganj police station area. Panic has gripped the village, and a search operation is underway to trace the missing child.

According to police sources, the victim, one-year-old Aarvi, daughter of Ram Kumar, was sleeping with her mother, Ram Kumari, on the veranda of their house.

At around 3 am, a wolf silently approached, grabbed the child in its jaws, and fled towards nearby sugarcane fields. The child's cries woke her mother, who raised an alarm and attempted to chase the wolf, but it disappeared into the fields.

Hearing the commotion, villagers rushed to the spot armed with sticks. A search operation has been ongoing since early morning, but the child has not yet been

On receiving information, Station House Officer Brijendra Mishra and Forest Ranger Omkar Yadav reached the site along with their teams. Ranger Omkar Yadav said that the forest department, in coordination with the police, has launched an intensive search in the fields and surrounding areas and heightened vigilance across the region. He expressed hope that the child would be traced soon.

Notably, Bahraich district has witnessed a series of wolf attacks over the past two months, resulting in the deaths of ten people, including eight children.

Acting on the directions of Chief Minister Yogi Adityanath, the forest department had deployed special shooters to eliminate the wolves, and four wolves have reportedly been killed so far. However, despite these measures, the attacks continue, leading to fear and anger among residents.

### Yuva Bharati Stadium in turmoil as fans vent frustration over Messi's brief visit

Chaos unfolded at the Yuva Bharati Krirangan, as irate fans broke chairs and threw plastic water bottles and other items onto the ground on Saturday after being unable to catch a proper glimpse of soccer magician Messi, despite having paid astronomical amounts

The Messi show here, part of the first leg of the Argentine soccer star's four-city India tour, descended into a virtual free-for-all as Messi left the ground after a brief 22-minute stay. Organising officials had earlier promised that Messi would be on the ground for over an hour. Even during his brief stay, Messi was surrounded by security personnel, organisers and others including state sports minister Arup Biswas, preventing the fans - many of whom had arrived from various parts of West Bengal, and even beyond - from getting a proper glimpse of the soccer star.

Messi, who arrived at 11:30 am in a white Audi, left at 11:52 am, disapponting the fans.

The disappointment quickly turned into frustration, and all hell broke loose. Fans threw water bottles at those on the ground, uprooted fibreglass seats and seat covers and flung them onto the athetic tracks surrounding the soccer pitch. They also threw whatever else they could lay their hands on.

Invectives were hurled at the security staff and organising officials by angry fans, who had paid between Rs 4,000 and Rs 18,000 for the opportunity to see the football legend from close range.

### **EOW Kashmir files** chargesheet against four in Rs 53 lakh land-sale fraud case

### Srinagar. (Agency)

The Economic Offences Wing (EOW) of the Crime Branch Kashmir filed a chargesheet before the Court of the Chief Judicial Magistrate, Srinagar, in connection with a major land-sale fraud case, naming four residents of Srinagar for their alleged role in cheating and criminal conspiracy, officials said on Saturday. The chargesheet was produced in 2025 FIR, against Tariq Ahmad Hajam, Ghulam Hassan Mir, Mohammad Sultan Mir alias Sulla and Abdul Razaq Mir all residents of Barthana Qamarwari, Srinagar. The four have been charged for offences punishable under Sections 420 and 120-B of the Ranbir Penal Code. EoW said the case originated from a complaint alleging that the accused persons deceitfully obtained a sum of Rs 53 lakh from the complainant and his father under the pretext of selling land.

"Preliminary inquiry and subsequent investigation by the Economic Offences Wing revealed that the accused, acting in connivance, received the full payment but fraudulently sold the same patch of land to other parties and even transferred portions of it to their own family members," they said. Through meticulous examination of both oral and documentary evidence, investigators established that the accused had orchestrated a deliberate criminal conspiracy to cheat the complainant and unlawfully grabbed the amount paid for land measuring 2.09 kanals at Estate Barthana, Srinagar, EoW said, adding the matter is ready for judicial adjudication.

According to the emerging trends, the UDF is leading in multiple corporations, with strong showings in Thrissur and Kochi. In the Thrissur Municipal Corporation, the Congress-led front has steadily increased its lead in several wards, signaling a potential comeback in the city's civic body. Kochi also shows the UDF maintaining a clear advantage as counting progresses.

n Thiruvananthapuram Municipal Corporation, the contest remains highly competitive, with the NDA emerging as a strong challenger. The BJP-led alliance is ahead in more than two dozen wards, posing a serious challenge to the long-standing dominance of the LDF, which has controlled the corporation for decades.

Other municipal corporations, such as Kollam, are witnessing tight contests, with the UDF holding a narrow lead over rivals in the early rounds of counting.

Several notable individual victories have been reported. UDF candidate Vyshna Suresh won the Muttada ward in the Thiruvananthapuram Corporation, flipping a seat previously held by the CPI(M).

In another significant result, BJP's former DGP R. Sreelekha IPS registered a decisive victory in the Sasthamangalam ward against LDF's Amrutha Arun, strengthening her position as a leading mayoral contender in the

## Kerala: NDA wins Munambam, centre of dispute between Christians and waqf board

Munambam, located in Kerala's Ernakulam district, has been at the centre of protests and court cases after over 404 acres of land were declared as waaf property.

The NDA secured an emphatic win in Munambam in the Kerala local body elections, marking an important chapter in a ward that has been at the centre of a longrunning dispute involving the state waqf board. The result comes against the backdrop of year-long protests by over 500 Christian families who face the threat of eviction due to an alleged illegal claim by the Waqf over their land.

Anoop Antony Joseph, Kerala BJP general secretary, called it a "historic" victory for the NDA.

"The Modi government and the BJP stood with the Munambam people in fighting the Waqf, and they have now chosen the BJP as their mandate," Joseph tweeted. The ward was won by the Congress in the previous polls.

The win in Munambam will give the BJP a massive boost ahead of the 2026 Kerala assembly polls in a state where it has struggled to gain even a toehold. The BJP is also ahead in the Thiruvananthapuram corporation - the constituency which is held by Congress MP Shashi Tharoor.

The disputed land in Munambam is inhabited by about 500 families, most of them Christians. The families, under the banner of Munambam Land Protection Council, have been protesting for over 400 days, fearing eviction.

They have demanded that the revenue rights of their land holdings be restored. The government had stopped accepting land tax from the families living on the disputed

The protests led by Munambam's Christian residents gained national attention earlier this year when the Centre passed the Waqf Amendment bill. The law expands the government's role in regulating waqf properties.

Initially, the families decided to boycott the local body polls, but eventually participated in the election process.

The decision came after the Kerala High Court ruled that the land in Munambam was not waqf property, in a big win for the protesters. However, on Friday, the Supreme Court paused the High Court's finding and ordered status quo on the dispute.

## CAQM forms expert panel to curb air pollution in Delhi



#### New Delhi.(Agency)

As vehicular pollution continues to significantly contribute to rising levels of air pollution in the capital, the Commission for Air Quality Management (CAQM) has constituted an expert committee to draft a comprehensive strategy for reducing vehicular

According to the CAQM, the new committee brings together a diverse group of specialists, including academicians, public health experts, automotive researchers and policy advisers. The 15-member panel will be chaired by Ashok Jhunjhunwala, professor of IIT Madras, with Dr Randeep Guleria, former director of AIIMS Delhi, serving as co-chair. Representatives from key ministries, think tanks, research institutions and civil society groups will form the rest of the committee. The committee has been mandated to review existing clean mobility policies ranging from Bharat Stage (BS) emission norms to electric vehicle (EV) initiatives and fuelefficiency standards and assess how well they are working across Delhi-NCR.

It will also examine the contribution of different vehicle categories to overall emissions and identify the associated exposure risks for the population. The panel has been given two months to submit its recommendations. The first meeting is scheduled for December 15, 2025.

## **Delhi government notifies** law to regulate private school fees, cap charges

New Delhi.(Agency)

Four months after the Delhi Assembly passed the Delhi School Education (Transparency in Fixation and Regulation of Fees) Bill, 2025, the Delhi government officially notified the Act, with Lieutenant-Governor V K Saxena issuing the notification on Thursday. The move comes after years of protests over arbitrary fee hikes in private schools. The Act introduces a three-tier committee structure to regulate fees: a School-level Fee Regulation Committee, a District Fee Appellate Committee, and a Revision Committee.



Under the new set of rules, complaints to the district-level committee must be supported by at least 15% of affected parents, ensuring parental participation in decisionmaking. Parent associations had raised concerns over this threshold, citing difficulties in mobilising support, but the provision remains intact.Registration fees have been capped at Rs 25, admission charges at Rs 200, and caution money at Rs 500, which will be refundable with interest. Development fees cannot exceed 10% of the annual tuition fee. Any fee not expressly permitted in the Act will be

treated as an "unjustified fee demand". It applies to over 1,500 private unaided schools and strictly prohibits collection of capitation fees, direct or disguised.

## After Settlement, Court **Quashes FIR Against Hospital In Cotton Mop Case**

New Delhi.(Agency)

The Delhi High Court has quashed an FIR registered against a private hospital and one of its senior doctors after noting that the medical negligence dispute -- arising from allegations that a cotton mop was left inside the patient's abdominal cavity during a Lower Segment C-Section -- had been "amicably resolved" between the parties.

Opining that continuing the proceedings would serve no purpose, a single-judge bench of Justice Amit Mahajan allowed the petition filed by Venkateshwar Hospital and Dr. Dipti K. Yadav, seeking quashing of the FIR registered at Dwarka North police station under Sections 336, 337, and 34 of the IPC. The complainant, who had undergone a C-section at the hospital in January 2021, told the Delhi High Court that she had received compensation of Rs 14 lakh and no longer wished to pursue the proceedings."All the disputes have since been settled, without any coercion, pressure or undue influence," she told Justice Mahajan adding that "continuation of the proceedings would amount to further harassment". The FIR stemmed from the complainant's allegation that a cotton mop had been left inside her abdominal cavity during the C-section, causing severe infection and necessitating a second surgery. A prior inquiry by the Delhi Medical Council (DMC) had found that while the mop was "in all likelihood" left behind during the C-section, the lapse apparently arose from an error in counting surgical mops.

DMC held that Dr. Yadav "did not exercise due diligence which is expected from an ordinary prudent doctor", but highlighted that her conduct was "not reckless or patently want to

It further directed removal of the doctor's name from the State Medical Register for 30 days and recommended disciplinary action against the scrub nurse who had incorrectly counted the

While acknowledging the hardship suffered by the complainant, Justice Mahajan said, "The incident was unintentional and due to oversight, bereft of the necessary means and such degree of rashness to attract the rigours of a criminal trial."

He began his wicket-taking spree in the 17th over, first removing Suryansh Shedge with a sharp return catch.On the very next ball, he trapped Mumbai captain Shardul Thakur leg-before wicket, putting Hyderabad in a commanding position. Siraj's third wicket came soon after, dismissing Tanush Kotian for just two runs, effectively ending Mumbai's hopes of posting a competitive total. With a target of



132 set, Hyderabad's batting unit made light work of the chase, completing the win in just 11.5 overs while losing only one wicket. Siraj's performance comes at a time when he finds himself out of favour with the Indian T20I side.He was part of India's triumphant campaign in the T20 World Cup 2024 and played his last game in the shortest format in the same year against Sri Lanka in July. The 31-year-old has played 16 T20Is so far and has scalped 14 wickets, with best figures of 4/17 to his name. Earlier, Siraj bowled an economical spell of 1/15 against Uttar Pradesh in his first appearance of the SMAT this season. He was recently rested for the three-match ODI series against South Africa after playing both Test matches against the same opposition. ### Four Assam cricketers suspended for corrupt practice

Amit Sinha, a former Ranji Trophy team captain, is also among those found guilty by the BCCI's ACSU. The other players are Ishan Ahmed, Aman Tripathi and Abhishek Thakuri and, according to the statement, they have been suspended "with immediate effect after allegations emerged that they were involved in corrupt practices relating to the game of cricket.""The above four players, who have represented Assam at various stages, are accused of influencing and attempting to instigate some of the current Assam team players, who took part in the Syed Mushtaq Ali Trophy 2025 held in Lucknow from November 26 to December 8," said Sanatan Das, the ACA secretary said. The top tier BCCI T20 event was played across centres in India. "Following the emergence of these allegations, the Anti-Corruption and Security Unit (ACSU) of the BCCI conducted an enquiry," said the ACA secretary. "The ACA has also initiated criminal proceedings. Prima facie, there appears to be involvement of the aforementioned four players in serious misconduct, affecting the integrity of the sports." Of the four, Thakuri was part of the team that travelled to Lucknow for the matches. Sinha played his last T20 match in 2019.According to ACA, the suspension was done to curtail any scope of further deterioration of the situation. The four cricketers have been barred from all cricketing activities in the state.

# Global players union advocates for rest periods to alleviate player workload in women's soccer

Top women's soccer players are increasingly having to juggle more club and international matches while getting less time for rest and recovery, according to a report by the global players' union.FIFPRO's report released Friday noted that the rise of women's leagues worldwide, expanded fields for international competitions and the addition of new tournaments have added to elite player workload. But it also noted there's a vast disparity in the women's game, with many players not getting enough matches or time in training environments, which can hamper development and possibly lead to injury.

FIFPRO is calling for a more balanced competition calendar and greater player



spectrum, including mandated rest periods. 'It is about the calendar and the cadence of the calendar, but it's also about the conditions in which those games are played and the rest and recovery for the players," said Alex Among the game's top players, Ballon d'Or Culvin, FIFPRO director of women's football. "We take this as a very holistic view. It's all about growing the game sustainably, but allowing the players to be in environments where they can thrive."

Under a Proof of Concept (PoC) currently underway, IRCTC has separated meal preparation from meal service, allowing established food and beverage brands, including industrial kitchens, restaurant chains and flight caterers, to step in and supply meals. The aim, the corporation said, is "to provide fresh, hygienic meals for service to the passengers" and drive "perceptible improvements in on-board catering services in trains". The trials are being conducted across multiple railway zones on some of the newly introduced Vande Bharat and Amrit Bharat trains. IRCTC, a Navaratna Central Public Sector Enterprise under the ministry of railways, presently caters to nearly 16.50 lakh meals every day across the Indian Railways network. According to an official release, the corporation has initiated the trials to bring about a "paradigm shift in quality of meal services in trains". "În order to have paradigm shift in quality of meal services in trains and with an objective to have perceptible improvements in on-board catering services in trains, IRCTC has commenced meal trials is some select trains," it said.

A night meant for music and celebration turned into a scene of panic and loss in Goa, leaving families shattered. The tragedy felt painfully familiar with previous incidents, a crowded venue, a sudden fire, people scrambling for exits that were never meant for emergencies.India has seen this pattern

At a time when families are grieving, they also find themselves navigating complex laws, paperwork, and blame games between venue owners, event organisers, insurers, and authorities. Understanding what they can legally claim becomes not just a matter of justice, but a lifeline in the months that follow. VICTIMS' RIGHTS AND WHY



Legal expert Anisha Mathur, Founding Partner at Shepherd Law Associates, said the first thing families must remember is that compensation is not a favour, but a legal right when negligence is involved. She explained that in cases like Goa, "If any fire-related deaths or injuries occur due to negligence, families have several legal remedies available. They can file a FIR under IPC provisions like Section 304A for causing death by

negligence, Section 336/337/338 for endangering life, and Section 285 for negligent conduct with fire or combustible materials.

Mathur said families can claim compensation under civil law as well. "The victims or their families can file civil suits seeking monetary compensation for death, injuries, medical expenses, and loss of livelihood. Compensation can be claimed under the law of torts for negligence. Courts consider factors such as age, earning capacity, the

circumstances of the accident, and long-term impact while determining compensation amounts.'

She added that criminal and civil cases can run parallel. At the same time, families do not have to wait for years for a final verdict. "Courts may grant interim compensation in cases of severe negligence," she said.

## India Grows, But Not Everywhere: NITI Aayog Flags A Widening Regional Divide

According to the latest NITI Aayog reports on India's services sector and state-level economic performance, the services industry now drives most of the country's economy.

India's economic growth is strong overall, but it is unevenly spread across states and regions. Some states have become powerful centres of modern economic activity, while many others lag behind in jobs, income, and opportunities. According to the latest NITI Aayog reports on India's services sector and state-level economic performance, the services industry now drives most of the country's economy. Services contribute around 55 percent of India's gross value added (GVA) and account for roughly 30 percent of total employment, with much of this growth concentrated in a few states. States such as Karnataka, Maharashtra, Tamil Nadu, and Telangana have become services-led economic hubs. Together, they generate about 40 percent of India's total services output. These regions host high-value industries like IT, finance, professional services, and digital platforms, attracting investment and skilled workers. By contrast, many

other states — especially in the north and east — remain dependent on agriculture or low-value industries and have not kept pace with this shift. This pattern is reflected in rising income gaps. NITI Aayog leadership has



highlighted that high-income states (about 26 percent of India's population) contribute 44 percent of the country's GDP, while low-income states (about 38 percent of the population) generate only 19 percent of GDP, illustrating major regional disparity.

These differences are more than just numbers — they affect people's lives. Regions with weaker economic growth often have fewer job opportunities, lower incomes, and slower improvements in health, education, and infrastructure. This leads to internal

migration, with people moving from weaker regions to strong urban centres in search of work and a better

NITI Aayog also tracks progress toward sustainable development. Its SDG India Index shows that many districts in some regions perform well on health, education, and other indicators, while others lag, highlighting unequal social and economic progress between areas.

## Historic Surge: Silver Breaks Rs 2 Lakh Mark, Gold At New Peak — Here's Why

New Delhi: Silver prices soared past the Rs 2 lakh-per-kg mark on Friday, marking a major milestone for the precious metal. Backed by strong investor demand and supportive global cues, silver futures continued their rally for the fourth straight session. On the MCX, March delivery contracts climbed by Rs 1,420 (0.71 per cent), hitting a record high of Rs 2,00,362 per kg. The bullish sentiment was

mirrored globally as well, with Comex silver futures touching a new peak of USD 64.74 per ounceSilver has been on a powerful upward run, fuelled by rising industrial demand, shrinking global stockpiles and growing interest from investors. Additional triggers



including US Federal Reserve rate cuts and heightened geopolitical tensions have only strengthened its appeal. So far this year, domestic spot gold has risen by 70 per cent, while spot silver has delivered an impressive 115 per cent jump. The US dollar is trading close to a two-month low and is consecutive weekly decline, making precious metals cheaper for global buyers. According to analyst Zain Vawda of MarketPulse by OANDA, the jump in US weekly jobless claims and rising tensions between the US and Venezuela are also boosting safe-haven demand, helping gold maintain its strong momentum.US jobless claims rose last week by the

## Johnson & Johnson ordered to pay \$40 million to 2 women in talc powder case

The verdict comes as the company faces tens of thousands of similar lawsuits nationwide and after its latest attempt to resolve the litigation through bankruptcy was rejected by US courts.

A California jury on Friday awarded USD 40 million to two women who said Johnson & Johnson's (JNJ.N), open-new tab baby powder was to blame for their ovarian cancer. The jury in Los Angeles Superior Court awarded USD 18 million to Monica Kent and USD 22 million to Deborah Schultz and her husband after finding that Johnson & Johnson knew for years its talc-based products were dangerous but failed to warn consumers.Erik Haas, Johnson &

Johnson's worldwide vice president of litigation, said in a statement the company plans to "immediately appeal this verdict and expect to prevail as we typically do with aberrant adverse verdicts." A spokesperson for the plaintiffs did not immediately respond to a request for comment.Kent was diagnosed with ovarian cancer in 2014, according to court records. Schultz was diagnosed in 2018. Both women are California residents who say they used J&J's baby powder after bathing for 40 years. Their treatments for ovarian cancer have involved major surgeries and dozens of rounds of chemotherapy, they testified at the trial.In closing arguments that Reuters viewed on Courtroom View Network, Andy Birchfield, an attorney for the women, told the jury that Johnson & Johnson knew as far back as the 1960s that its product could cause cancer." Absolutely they knew, they knew, and they were doing everything they could to hide it, to bury the truth about the dangers," Birchfield said.

Allison Brown, an attorney for Johnson & Johnson, said the only people to tell Kent and Schultz that their cancers were caused by talc were their lawyers, as the alleged connection isn't backed by any major US health authority and there is no study that shows talc can migrate from the outside of the body to the reproductive organs."They don't have the evidence in this case, and



they hope you don't mind," Brown told the jury.J&J is facing lawsuits from more than 67,000 plaintiffs who say they were diagnosed with cancer after using its baby powder and other talc products, according to court filings. The company has said its products are safe, do not contain asbestos and do not cause cancer. J&J stopped selling talc-based baby powder in the US in 2020, switching to a cornstarch product.J&J has sought to resolve the

litigation through bankruptcy, a proposal that has been rejected three times by federal courts, most recently in April. The bankruptcies have put most cases on hold. Brown and Kent's cases are the first to go to trial since the latest Chapter 11 attempt

> was dismissed. Before the bankruptcy attempts, J&J had a mixed record in talc trials, with verdicts as high as USD 4.69 billion awarded to women who said baby powder caused their ovarian cancer. The company has won some trials outright and had other verdicts reduced on appeal.

The majority of lawsuits involve ovarian cancer claims. Cases alleging talc caused a rare and deadly cancer called mesothelioma make up a

smaller portion of the claims J&J is facing. The company has previously settled some of those claims but has not struck a nationwide settlement, so many lawsuits over mesothelioma have proceeded to trial in state courts in recent months.In the past year, J&J has been hit with several substantial verdicts in mesothelioma cases, including one for more than USD 900 million in Los Angeles in October.



Love plants, but not sure if you can maintain them with ease? Ashok kumar mundetiya tells you how to add an extra edge to your balcony garden and interiors this season...

The glory of gardening: hands in the dirt, head in the sun, heart with nature. To nurture a garden is to feed not just on the body, but the soul

With space being a rarity these days, it is difficult to dream of a garden space more so, if you are staying in a small apartment. But fear not! For terrace garden — big or small — is a wonderful way to add colour to your otherwise dull life. You can just sit there, listen to music, read books or simply pull up a couch to lie down and soak in the natural beauty. Low space in metros and big cities has also compelled plant lovers to grow vegetables on their balconies. It is not only a great stress-buster, but the benefits of consuming home-grown vegetables also compensate for the time spent on pruning it. But wait... Before you start painting your house green, a few things should be taken into account, because no matter how much you care, your plants aren't going to thrive if you are ignorant of their specific needs. CT provides the basic guidelines to beginners..

#### Know your plants

Before adding a plant to your potted collection, it is advisable to ask an expert at a nursery about the conditions the plant needs. "It's usually much easier to grow plants that do well in your region, temperature and soil. For instance, don't

that gets sunlight only for an hour in the morning. While it's important to maintain a steady temperature for indoor plants, a terrace garden needs adequate sunlight. Again, if you notice your plant becoming thin and reaching out toward the light, it needs to be closer to sunshine," informs AB Karmakar, executive/ administrator for The Globe Nursery on Lindsay Street.

#### Maintenance of indoor plants

- Most indoor plants do best in partial shade, which works out well since indoor areas don't usually get direct sunlight. Keep this in mind before you decide to put a potted plant in a place where it will get hours of direct sunlight; you may end up exposing it for too long.

- One must select the right size of the pots. For indoor plants, go for pots either 4 inches or 6 inches in size. Allow enough space for the roots to grow. Make sure the pots are light and strong, so as to hold the plant for a

- Place plastic saucers under the pots to avoid soil and water spillage.

- Ficus Elastica, Areca Palm, a variety of philodendron or dracaena are best suited for indoors. These plants can do without sunlight for 7-10 days with minimum requirement of water.

#### Water the plants carefully

"Water the plants as and when required. Many first-time gardeners or potted plant owners water plants more than necessary, believing that the more water the plant gets, the better they grow. While it holds true for certain plants, it can kill others," suggests Dr SL Rahman, consultant at Agri-Horticultural Society of India.

#### Kitchen garden in pots

- If you thought a kitchen garden only works in bigger houses, you are highly mistaken. Get creative. Don't throw away buckets, containers etc. Use them along with hanging baskets for smaller plants. You can even

the garden. It can be filled with weed seeds, insects, and fungal diseases. It is better and easier to buy readymade potting soil (a mixture comprising clay, bone dust, vermicompost, neem cake and mustard

cake) from the local nursery. You can also go

for coco peat, which are made from coconut

husks and is a medium for growing plants. - Get various seedlings from the nursery. Remove the plants from its nursery container. Never pull a plant out by its stem. If it is stuck, tap the sides of the pot to loosen it. Gently tease the ends of the roots free

before planting it in the bigger pot. - For the proper growth of vegetables in your balcony, the pot size should be between 8-10

- Make one or more drain holes in the pot. Place small chips right over them so that they don't clog and excess water can pass through.

- Do not pile soil on top of the plant; make sure the stem is completely above the surface. Leave about an inch between the

soil surface and the rim of the pot. - All vegetable plants need constant moisture. Some plants need water on a daily

### Veggies for beginners

Coriander: How many times did you get sad looking at half-dried coriander leaves (dhania) in the market? Coriander is something that is used in everyday cuisine to spice it up. And that makes it a must-grow for every kitchen garden. The seed is technically a fruit containing two seeds in it. When split, it increases the germination rate since it scarifies the seed. Take a tray with potting mix filled up to half inch from the top. Then make rows by drawing a line with your index finger or a stick. Simply sow the split coriander seeds in each row. Once done, water them and wait! It starts germinating between 5-7 days.

Potatoes: Plant potatoes during late February and March. When the green shoots begin to appear above the soil, cover them with more compost. You only need remember to water them. After 10 to 20

Peas: It's a trouble-free crop that enjoys cooler weather. Sow them in the pots between March and June. Erect some sticks or posts for support. You'll be amazed at how good fresh peas taste and the more that you pick them, the more they produce!

**Tomato:** With a little water and a lot of sun, tomato plants are quick to grow. Roots of a tomato plant grow deeper into the soil. So, choose a bush variety like 'Cherry Cascade' that can be planted in hanging baskets and window boxes. Just cut a tomato into four pieces and bury it about 1/2 an inch into the soil. Wait for 3-4 weeks for the seeds to start

**Cucumber:** These grow best when the soil is warm. Cucumber plants tend to sprawl all over. Provide your plants with ample space to stretch their roots. Again, since these are climbers, you must get a proper support. Go for smaller varieties if there's less space.

Green chilli: These are good companion plants for tomatoes and coriander. Just take two or three dried red chillies. Slit them open and sprinkle the seeds in a pot filled with soil and a little manure, available in the nurseries. Ensure the seeds don't go too deep. Cover it with little soil and water it. It takes about a week or so for the seeds to sprout. If the pot is not large enough, you can replant the sprouts into a bigger pot. You may need to tie up the chili plant to a pole to let it grow and avoid bending.

#### Winter blossom

- According to Nirupom Sen, secretary-cum-CEO, Agri-Horticultural Society of India, if you have a garden without flowers, you have got to do something about it. So, before deciding where to plant your flowers, you should know when the best time to grow flowers is. "During winter, the best flowers to grow in Indian climate are Petunia, Cockscomb, Antirrhinum, Cineraria, Zinnia, Calendula, Chrysanthemum, Marigold and Dahlia," he says.

- Flower plants need up to 5 inches deep soil. So take an earthen pot of 6-8 inches in height. Dig a hole in the potted soil. Bury the seed

do not need to be smothered with the soil. Do not bury them too deep. After 6 weeks, you will see the seeds sprout into saplings.

- The after-care is very essential. Sprinkle water as and when required.

#### Terrace talk

- As the main element of a terrace garden comprises watering of plants and keeping the soil wet, it is important that the best quality proofing material is

selected. - One has to bear in mind that the area selected to build a terrace garden should have a slight slope, so that it can drain water easily and has the capacity to bear the load.

- It is always advisable to pick plants which don't grow big in size.

- You can install a separate tank to store water or have a mechanical watering arrangement. But most often, people love to water their garden themselves and see the plants grow.

Preparing the potting mixture & sowing seeds 'These days, one can easily get exotic and hybrid seeds of capsicum, chilly, cabbage, broccoli, coriander, tomatoes, brinjal, basil and parsley. The potting mixture should have 20% of leaf mould, 40% sand and 40% soil. You can add mustard cake and cow dung cake as fertilizers. After the seeds are sown, one should cover the soil with a layer of fine sand. Sand makes the soil porous and helps the roots grow. Keeping insects away

'Use neem-based organic pesticides. Or you can take 100 gram of chillies, 4-5 cloves of garlic and a few bulbs of turmeric, paste it and mix it in 1 litre of water. Pour the liquid in a container and simmer it till it is reduced to half. Refrigerate it and use it

whenever necessary. All you need to do is take out about 20 ml or the concentrated paste, mix it in a litre of water and sprinkle it on the plants. However, if insects or diseases do strike your plants, go for the safest botanical or microbial
