## No third party: India's firm reply as China joins Trump in Pak truce credit war

**India has consistently maintained that the ceasefire on May 10, following Operation Sindoor, was reached following direct talks between New Delhi and Islamabad.**

**New Delhi .(Agency)**

India has firmly rejected China's claims that it mediated between New Delhi and Islamabad during the military conflict earlier this year, reiterating that no third party was involved in the ceasefire decision. India has consistently maintained that the ceasefire on May 10, following Operation Sindoor, was reached following direct talks between the Director General of Military Operations (DGMOs) of the two countries. "We have already refuted such claims. On bilateral issues between India and Pakistan, there is no role for a third party. Our position has been clarified on several occasions in the past that the India-Pakistan ceasefire was agreed to directly between the DGMOs of the two countries," the source told.

The development comes after Chinese Foreign Minister Wang Yi did a Donald Trump and claimed that Beijing mediated several global conflicts, including the standoff between India and Pakistan in May. "This year, local wars and cross-border conflicts flared up more often than at any time since the end of WWII," Wang Yi said at an event on Tuesday. He further said that China, in an attempt to "build peace that lasts",



has taken an objective and neutral stance while focusing on addressing both symptoms and root causes.

"Following this Chinese approach to settling hotspot issues, we mediated in northern Myanmar, the Iranian nuclear issue, the tensions between Pakistan and Israel, the issues between Palestine and Israel, and the recent conflict between Cambodia and Thailand," the Chinese foreign minister said.

### CHINA JOINS CREDIT WAR

China is the latest after US President Donald Trump to claim that it stopped the military conflict between India and Pakistan this year. While this was a first such claim by China,

Trump has repeated it a hundred times - at global forums, press meets and even during bilaterals with foreign leaders. However, China's claim only exposes its hypocrisy as it firmly backed Pakistan and allegedly provided military assistance during the three-day hostilities. It is a different matter that Chinese air defence systems came a cropper as India struck 11 military bases deep inside Pakistan at the height of the conflict.

China's role has also come under scrutiny after top Army general Rahul R Singh said Beijing used the confrontation as a "live lab" and gave real-time inputs to Pakistan.

"Pakistan was at the front. China was providing all possible support... In the last five years, 81% of the military hardware that Pakistan is getting is all Chinese.

China is able to test its weapons against other weapons, so it's like a live lab available to them," he said at an event in Delhi. India and Pakistan were locked in a brief but intense military confrontation in May, triggered by a terror attack in Pahalgal on April 22, which claimed 26 innocent lives. India responded with Operation Sindoor, destroying nine terror camps in Pakistan.

## "Don't Stop At One Child, Have 2-3": Himanta Sarma To Hindu Couples

**Himanta Biswa Sarma's remarks underscore the ongoing political and social debate in Assam over migration, identity and citizenship.**

Assam Chief Minister Himanta Biswa Sarma has sparked a fresh controversy after urging Hindu couples in the state to have more than one child, citing what he described as a declining birth rate among Hindus compared to religious minority-dominated areas. Speaking to reporters on Tuesday, Sarma said the ratio of childbirth was higher in minority-dominated regions, while it was steadily falling among Hindus. "In religious minority-dominated areas, the ratio of giving birth to a child is more. In Hindus, the ratio of giving birth to a child is coming down.

There is a difference," he said.

The chief minister said this was the reason behind his appeal to Hindu families to have more children. "That is why we are urging Hindu people not to stop at one child and give birth to at least two. Those who can, even have three children," Sarma said. At the same time, he added, "We ask the Muslim people not to give birth to seven to eight, while we urge the Hindus to have more children. Otherwise, there will be no one to look after the house of Hindus." Earlier, on December 27, Sarma also spoke on population trends in the state, saying that the population of Bangladeshi-origin Miya Muslims could touch 40 percent in the 2027 census. He said that when he began his political career with the All Assam Students' Union (AASU), their population stood at 21 percent, which rose to 31 percent in the 2011 census.



## KARC-2 recommends deploying surplus staff from low-workload units to service-delivery functions

**BENGALURU .(Agency)**

The Karnataka Administrative Reforms Commission-2 (KARC-2) has recommended the redeployment of surplus staff from low-workload units to frontline and service-delivery functions for human resource optimisation and vacancy management in government departments.

Former Minister and KARC-2 Chairman R V Deshpande submitted the 10th report of the commission to Chief Minister Siddaramaiah on Tuesday. The commission conducted a comprehensive review of sanctioned, filled, vacant and

outsourced posts across departments, boards and corporations. Cadre and Recruitment Rules were examined to assess relevance to present-day functional requirements, said a note from the commission.

While recommending to the government to fill long-pending frontline vacancies on priority, particularly where vacancies have persisted beyond one year and affect citizen-facing services, the commission asked the government to freeze further outsourcing in Group-C and Group-D cadres where sanctioned



regular posts exist but remain unfilled.

The commission recommended rationalising district-level staffing patterns by linking sanctioned strength to population, beneficiary load, regional backwardness and

service intensity, converting redundant clerical posts into technical or multi-tasking posts, based on functional requirements and departmental inputs, and abolishing obsolete and functionally irrelevant posts identified through Cadre and Recruitment Rules review. To strengthen governance systems, the commission recommended institutionalisation of a Reform Monitoring Unit (RMU) within the Department of Personnel and Administrative Reforms (DPAR-AR), integration of reform recommendations into departmental annual action.

## Punjab Govt has spent over 800 crore on modernisation of Punjab Police in last 3 years, with major upgrades set to continue in 2026: DGP Gaurav Yadav

CHANDIGARH, December 31: To make policing more efficient, responsive, and professional as per the commitment of Chief Minister Bhagwant Singh Mann, Director General of Police (DGP) Punjab Gaurav Yadav on Wednesday outlined an ambitious and technology-driven "Vision 2026" for the Punjab Police, centered on a massive infrastructure and capability upgrade. A key focus is the upgrade of the Dial 112 Emergency Response Support System (ERSS) with dedicated Dial 112 Central control room building to be established at Mohali with the cost of ₹52 crores, while a fleet of vehicles will be augmented with the cost of ₹50 crores. "Our target is to drastically reduce the current average response time of 12-13 minutes to just

7-8 minutes," said the DGP, while adding that simultaneously, District Control Rooms across Punjab are also being upgraded with an investment of ₹25 crores to ensure seamless coordination and faster incident management, directly contributing to the reduced response time target. DGP Gaurav Yadav, accompanied by IGP Headquarters Sukhchain Singh Gill, was addressing a press conference to share the future roadmap of Punjab Police. For border security, DGP Gaurav Yadav said that the Second Line of Defence will see 2,367 CCTV cameras installed at 585 locations along the International Border at a cost of ₹49.58 crores, which will be act as force multipliers. The Anti-

Drone System (ADS) fleet will be expanded from the current three oper-



ational systems to an additional six under procurement, with 10 more to be procured later in a phased manner, he said, while adding that Drone Response Teams (DRTs) have also been pressed into action, and will be

greatly synergised with Village Defence Committees (VDC) members' involvement in the coming year. Highlighting the continuous modernisation drive, the DGP revealed that the Punjab Government has spent over ₹800 crores on modernisation of Punjab Police in the last three years. He said that all the SP rank officers in the field have been given new vehicles, besides, all the Police Stations and Police Posts have also been equipped with new vehicles. He added that the state government has approved a mega police building project worth ₹426 crores to be spent over the next three years. This includes new headquarters for the Cyber Crime division at Phase 4 in Mohali, new police lines in Nawanshahr and Malerkotla districts, and 11 other new police station buildings.

## Defence Ministry signs over Rs 4,666-crore deals for procurement of combat carbines, torpedoes


**New Delhi .(Agency)**

The Defence Ministry Tuesday signed contracts for the procurement of 4.25 lakh Close Quarter Battle (CQB) Carbines and 48 heavyweight torpedoes worth Rs 4,666 crore. The massive order for the forces comes ahead of the Union Budget for the next fiscal. In FY 2025-26, the Defence Ministry has signed capital contracts amounting to Rs 1,82,492 crore. The contract for over 4.25 lakh CQB Carbine along with accessories, worth Rs 2,770 crore, for Indian Army and Navy was signed with Bharat Forge Ltd and PLR Systems Pvt Ltd. The contract for procurement and integration of 48 heavyweight torpedoes, along with associated equipment for Kalvari-class submarines of the Navy at an approximate cost of Rs 1,896 crore, was signed with WASS Submarine Systems SRL, Italy.

According to Defence Ministry, the long-due deal signed to procure

CQB Carbines will equip soldiers with "world-class lethality, replacing legacy systems with cutting-edge indigenous technology under the 'Atmanirbhar Bharat' vision." "As a cornerstone of the modern infantry arsenal, the CQB Carbine provides a critical edge in close combat through its compact design and high rate of fire, ensuring rapid, decisive lethality in confined spaces," the Ministry said in a statement. It added that the contract highlights the synergy between the government and the private sector, which will give impetus to the Make-in-India initiative.

"This project will also play a pivotal role in boosting overall economy, increasing employment avenues and will also empower indigenous defence industries by encouraging Indian MSMEs through components' manufacturing and raw material supply," it said. The acquisition and integration of torpedoes along with associated equipment for Kalvari-class Submarines (P-75) of the Navy will enhance combat capability of six submarines, the Ministry said, adding that delivery will start from April 2028 and will be completed by early 2030.



## Delhi Government's Talks With Ola, Uber Signal Comeback Of Carpooling

**New Delhi .(Agency)**

Delhi Govt Pushes Carpooling After Talks With Ola, Uber, Rapido The government held talks with major cab and mobility aggregators, including Ola, Uber and Rapido, as part of its effort to ease traffic congestion and curb rising vehicular emissions, signalling a comeback of carpooling.

Environment Minister Manjinder Singh Sirsa chaired a high-level meeting on Wednesday, where the government asked aggregators to restart ride-sharing services at the earliest and begin work on a separate carpooling framework.

"The sooner we start large-scale ride sharing and carpooling, we will see fewer vehicles on our roads. I appeal to the people of Delhi to actively choose ride sharing and



carpooling options so that together we can reduce pollution levels in the city," Sirsa said. Officials said ride-sharing, which allows multiple passengers to book the same cab, is expected to resume soon.

Aggregators told the government they need time to make technical and operational changes, following which they have been asked to fully roll out ride-sharing features within a month.

Carpooling, officials clarified, will be treated as a non-commercial shared mobility option. Aggregators have been directed to start developing in-app carpooling modules or independent platforms, while the Transport Department will examine the legal framework needed to enable and regulate carpooling in Delhi.

The meeting also focused on cutting down the number of private vehicles on the road. Aggregators were urged to expand bus and shuttle services, especially on office routes and high-demand corridors, to improve last-mile connectivity and reduce peak-hour pressure.

Electric mobility was prominent in the discussions. The government said privately registered electric vehicles could be allowed to

operate under aggregator platforms without commercial permits or registration fees. The Transport Department has been asked to study the legal, regulatory and safety implications, including insurance and passenger safety norms.

Aggregators were also advised to promote green ride options and introduce in-app features that show users the emission savings from shared or electric rides. They were asked to share route-wise data to help the government identify congestion hotspots and plan targeted traffic interventions.

Reiterating the government's wider pollution control strategy, Sirsa said action is being taken on vehicular emissions, industrial pollution, dust and waste management alongside enforcement measures.

MCG seals seven properties over 1.8 crore tax dues

**Gurgaon.(Agency)**  
Enforcement teams of the Municipal Corporation of Gurugram (MCG) sealed seven properties across the city on Tuesday for non-payment of property tax dues amounting to Rs 1.8 crore, despite multiple notices being issued to the owners.The sealing drive was led by zonal taxation officer Pankaj Kumar, along with tax inspector Pankaj Saluja and their team. According to MCG officials, two properties in Kherki Daula had outstanding dues of Rs 30,82,747 and RS 19,72,508, respectively. In Mohammadpur Jharsa, two properties were found to have pending tax of Rs 27,35,536 and Rs 22,65,126.A property in Narsinghpur with outstanding dues of RS 14,04,967 and another in Pace City-1 owing Rs 18,17,872 were also sealed. In addition, a property in Palam Vihar with pending tax dues of around ?52 lakh was sealed during the drive.MCG commissioner Pradeep Dahiya said, "Property tax is the main source of income for the MCG, through which the city's cleanliness, roads, sewers, water supply, and other civic amenities are operated. Strict action like sealing will continue against defaulters who do not deposit tax despite repeated notices."He appealed to property owners to deposit their outstanding property tax on time to avoid punitive action, adding that the corporation will intensify its campaign against tax defaulters in the coming days.The sealing drive resulted in the collection of Rs 7 crore in a single day. So far, MCG has collected Rs 285 crore in property tax during the current financial year, with officials expecting further increases by March 2026 as enforcement continues. This year, MCG and MCM have also introduced artificial intelligence (AI) to boost property tax revenue. Using AI, residents with outstanding dues are being identified and approached, their queries resolved, and assistance provided in paying pending taxes.

Contractor held for labourer’s death in Gurgaon

**Gurgaon.(Agency)**  
A contractor was arrested on Tuesday, a day after a 20-year-old labourer died during basement excavation work in Sector 56. Police said the excavation was allegedly carried out without safety equipment and beyond permitted working hours.  
The accused was identified as Shivpukar Giri (46), a resident of Deoria district in UP.Police said they received information through the police control room about several labourers being trapped under a collapsed mound of soil at Plot No. 26 in E Block. A police team reached the site and found a crowd gathered outside the plot. Locals informed them that labourers were buried during excavation work.  
Rescue operations were launched immediately, and the crime scene unit and a magistrate were informed. Two labourers were initially pulled out, while another remained trapped. After continued digging, the third labourer was rescued. All three were taken to Marengo Hospital in Sector 56.One of them, Badal, was later shifted to Civil Hospital in Sector 10, where he was declared dead. His body was sent to mortuary.  
Govind, one of the injured workers, later submitted a complaint stating that the contractor had brought him, his brother Roshan, and three others — Uday, Sagar and Badal — from their villages for basement excavation work.He alleged that although work usually stopped in the evening, the contractor forced them to continue for two additional hours after dark, assuring extra payment.Based on the complaint, a case was registered under the sections for negligence and culpable acts leading to death.

Ghaziabad man allows shell co in his name to park syrup racket funds

**Ghaziabad.(Agency)**  
A 50-year-old man was arrested near Hindon metro station on Tuesday for his alleged role in a cough syrup smuggling racket in which codeine-based syrup, categorised as a narcotic drug, was moved illegally and proceeds were routed through a shell firm registered in his name.According to police, Deep Prakash Gupta of Hardoi allowed the masterminds to use his name to set up a paper company against a commission. The firm's bank account was used to park and route money linked to the smuggling.The racket came to light on Oct 18, when three persons were arrested in UP's Sonbhadra with illegal cough syrup worth Rs 3 crore. During investigation, Sonbhadra police learnt that some gang members were in Ghaziabad and the supply chain ran from Delhi. The information was shared with cops from Ghaziabad, who agreed to carry out a joint operation with their counterparts in Sonbhadra.Following a tip-off on Nov 4, the police team arrested a total of eight gang members from a transport warehouse on Meerut Road. The cops recovered 1,150 cartons of cough syrup from four trucks parked there, including 850 cartons of Eskuf and 300 cartons of Phensedyl, which were hidden between lime sacks.Those arrested included Saurabh Tyagi (37), a resident of Indirapuram and one of the masterminds. An FIR was registered against all the accused under relevant sections of the NDPS Act at Nandgram police station.  
Piyush Kumar Singh, ADCP (crime and cyber), said evidence pointed to financial links between Gupta, described as the owner of ‘DP Enterprises’, Saurabh Tyagi, owner of RS Pharma, and Vishal Upadhyay, owner of Vanya Enterprises.Although transactions worth Rs 5 crore came to light between the three of them in 2024-25, police found ‘DP Enterprises’ had no existence and operated only on paper to convert illegal money from the smuggling of syrups into legitimate earnings.Gupta said he had worked in the medicine business in Odisha since 2005. There, he would contact medical representatives (MR) and take medicines to supply to Delhi, due to which he frequently travelled to the capital. During this period, he met Vishal Upadhyay. In 2023, when his work in Odisha stopped, he returned to Hardoi, and in 2024, went to Delhi again to meet Vishal Upadhyay. Vishal introduced him to RS Pharma's owner, Saurabh Tyagi, and told him about cough syrup smuggling, saying he would get a commission of Rs 2 to Rs 3 per bottle. He only needed to register an agency in his name. Lred by the commission, he got the licence for DP Enterprises registered at a Delhi address in Dec last year," he said.

CBSE suspends affiliation of private school in Gurgaon for flouting rules

**Noida.(Agency)**  
Central Board of Secondary Education (CBSE) has suspended the affiliation of GD Goenka High School in Sohna for one academic year (2026–27) after finding multiple violations of the board's bylaws. After reviewing the school's reply sent on Sept 29 along with the inspection committee's observations, CBSE barred the school from admitting students in classes IX and XI for the next session. Students currently enrolled in classes IX to XII, however, will be permitted to continue in the same school, subject to stringent safety compliance.  
In its submission to CBSE, the school stated that it was operating on 7.68 acre with separate entry and exit, within a total land holding of 60 acre. CBSE, however, recorded a discrepancy between this claim and the information uploaded by the school on OASIS Portal, which reflected a land area of 18,211 sqm as on Sept 18.

Multi-level car parking to community centre: CM Saini launches Rs113cr infra projects in city

**Gurgaon.(Agency)**  
Chief minister Nayab Singh Saini on Tuesday inaugurated and laid the foundation for development projects worth around Rs 113 crore in the city. Projects worth Rs 73 crore were inaugurated, including a multi-level car park in Sadar Bazar costing Rs 55 crore and a community centre in Sector 14 costing Rs 18 crore.The projects for which the foundation stone was laid include a model road and drain in Sector 16 at a cost of Rs 8.32 crore, a sewerage and drinking water pipeline in Sector 17A at a cost of Rs 6.28 crore, hostel construction work in Sector 16 at a cost of Rs 6.67 crore, and special repair work in the new vegetable market at a cost of Rs 19.41 crore.The much-awaited multi-level car parking facility in Sadar Bazar was completed a few months back and the inauguration was pending. To ensure smooth management, MCG outsourced

its operation and maintenance to a private company for a period of 5 years.The car parking facility was constructed over 3,187 square metres, with 3 basements and 6 floors and can accommodate 218 cars. The facility is expected to ease parking woes in one of the city's most crowded and oldest markets. Construction of this parking facility was completed in 2025 after a delay of 4 years. Scheduled to be completed in Dec 2021, the project was delayed. Saini was in the city for the ‘Viksit Gurugram Maharally’, organised by MLA Mukesh Sharma. CM, addressing the crowd, said that out of 217 promises made in the assembly election manifesto, 54 promises were fulfilled in just 1 year, while work on 163 promises is in progress. "This govt is the people's govt. The govt's resolve is 'Sabka Saath, Sabka Vikas, Sabka Vishwas and Sabka Prayas'," said CM.Assuring development of the city, CM said, "Govt will leave no

stone unturned in the comprehensive development of Gurgaon, and continuous and effective steps will be taken in the direction of making it the most developed city in the country."Listing the works done by the BJP-led govt for Gurgaon assembly constituency, the CM said that in the last 11 years, development works worth Rs 1,909 crore were carried out in the Gurgaon assembly constituency, and out of 67 announcements made for the area in the past 11 and a half years, 39 were completed and work on 11 is in progress.  
Meanwhile, Saini said that efforts are being made to control the pollution through the operation of electric buses and modern waste management technologies. "Around 300 electric buses will join the fleet of city buses, and works are being carried out to improve sanitation management to deal with air pollution," said CM.

BMW speeding through dense fog mows down cyclist in Noida

**Noida.(Agency)**  
A 49-year-old cyclist died after a BMW speeding through fog crashed into him from behind in Nithari village late on Monday night.Ashok Sharma, a resident of Khurja in Bulandshahr, was returning home on his bicycle after work when the BMW hit him near Saraswati School, close to pillar number 30 of the Noida elevated road, around 11pm. The impact flung him in the air, hurled him several metres ahead and snapped the bicycle into two halves. He suffered grievous injuries in the head and other body parts.After striking the cyclist, the BMW went out of control and crashed into a nearby electricity pole, damaging it badly, before climbing onto the road divider. Passersby who witnessed the accident informed police and rushed Sharma to a nearby hospital, where he succumbed to injuries. A team from Sector 20 police station reached the accident spot and arrested the driver — Mankul Mahajan (39), a property dealer living in a society in

Sector 44. Police said Mahajan attempted to flee after the accident, but locals caught him and handed him over to cops.



An FIR was registered against Mahajan for causing death by negligence and rash driving. The BMW — bearing a VIP registration number UP16-EB 4444 — was seized and taken to the police station. Its front portion was badly damaged. A senior police officer said the accident occurred amid foggy conditions and compromised visibility, when speed limits are already reduced on major stretches.

concrete boundary wall on all four sides and that a common reception for all three institutions created serious safety and security concerns. TOI tried to contact the school authorities but didn't receive a response.eyond infrastructure and safety lapses, the inspection committee reported admission irregularities, including students admitted without transfer certificates from previous schools, and the absence of a composite science lab as required under CBSE norms. The board flagged deficiencies in records, stating that

documentation was not maintained in strict compliance with bylaws, standard operating procedures, and CBSE circulars and notifications issued from time to time.  
Taking what it termed a "sympathetic view" in the interest of students, CBSE ordered a one-year suspension to allow corrective action. The school has been directed to disengage other institutions from its premises, ensure exclusive use of the building and grounds by school students with separate entry and exit from the main road, construct a six-foot-high concrete boundary wall around the campus to demarcate school land, and ensure that no infrastructure or human resources are shared with any other institution.  
It must also establish a Composite Science Lab, maintain records as per CBSE regulations, ensure complete student safety, and comply strictly with all norms and bylaws in future.

**Frauds borrow Rs 2cr from senior citizen in Gurgaon, con him, 1 arrested**  
**Gurgaon.(Agency)**  
A man was arrested from Hyderabad on Monday for allegedly cheating a senior citizen under the pretext of cancer treatment for a woman.  
Officials from the economic offences wing (EOW) said the fraud was carried out in collusion by two perons, with fake bank transfer screenshots and emotional blackmail used to extract money.The case came to light after a senior citizen registered a complaint, alleging that a woman from Nepal, identified as Yangji Sherpa, alias Yana, duped him of Rs 2.21 crore. The complainant said that he met the woman at a spa centre last year  
"The complainant said that the woman sought money repeatedly for one year, claiming it was needed for her sister's cancer treatment, and sent forged screenshots of bank transactions to create an impression that she was returning the funds. Whenever the complainant demanded his money, she allegedly threatened to end her life," the officer said.A case was registered at Sector 40 police station and the investigation was handed over to EOW-I. Cops found the involvement of a second accused, Azhar Ahmad (30) from Hyderabad."The accused disclosed that he executed the fraud along with his female friend Yangji Sherpa," the officer said, adding Ahmad was nabbed from Hyderabad on Dec 29.Police said Yangji received around Rs 2.18 crore from the complainant between May 2024 and April 2025. To maintain trust, about Rs 18 lakh was sent back to the complainant at intervals, while forged screenshots of additional transfers were shared to falsely indicate repayment.Investigators said the bank account used to receive the money belonged to Yangji Sherpa, while the mobile number used to communicate with the complainant was registered in Ahmad's name.

According to ED, the investigation found that corporate entities, including Apollo Green Energy Ltd, borrowed large amounts of cash from Jhajjar-based private financiers and issued post-dated cheques as security. Inderjit allegedly acted as an enforcer, facilitating coercive settlements of high-value loan transactions and disputes running into hundreds of crores.ED claimed these settlements were carried out through threats, intimidation, and use of armed associates and local gangs, with links to organised crime syndicates operating from abroad. In

Haryana Police seek red corner notice against Dubai-based gangster

**Gurgaon.(Agency)**  
Haryana Police has initiated proceedings to obtain a red corner notice (RCN) against businessman-turned-gangster Inderjit Singh Yadav. Police have already secured look out circulars (LOCs) against him in five cases registered in the city.A police officer said Inderjit is currently living in Dubai with his wife. He owns Gem Records Entertainment, which operates under the name Gems Tunes. Two murder cases have been registered against him, including one at Rohtak's Sadar police station in connection with the murder of Jhajjar-based financier Manjeet Dighal last year.Gurgaon police also registered an FIR against him at Kherki Daula police station for the murder of Rohit Shaukeen, an associate of singer Rahul Yadav alias Fazilpuria, earlier this year. Police records show Inderjit faces four attempt-to-murder cases in the city. He was

named in three such cases this year — firing at the residence of social media influencer Elvish Yadav, firing at the office of MNR Builders in Sector 45, and the attack in which miscreants opened fire at Fazilpuria's car. Another attempt-to-murder case was registered against him in 2020 at Sector 34 police station.Inderjit has been charged for three extortion and criminal intimidation cases in the city, a kidnapping case in Rewari, and 12 cheating cases across Gurgaon, Rajasthan, and UP.Inderjit is a close associate of fugitive gangsters Himanshu Bhau, Deepak Nandal, and Sunil Singh alias Sardhanian. Sardhanian, a Sonipat resident, fled to Dubai after jumping parole in Haryana last year. While trying to reach the US, he was allegedly kidnapped by donkey-route agents and later brought back to India from Nicaragua, where Haryana Police arrested him earlier this

year. Police said Inderjit paid money to secure Sardhanian's release from the agents. Inderjit is also alleged to have links with prominent political leaders and film actors and to own multiple properties in India and abroad. While he lives in Dubai with his wife, his two children live in a society in the city. Punjab Police had earlier provided security at his flat in the city, but it was withdrawn earlier this month."We will bring him back soon," a senior Haryana Police officer said. Meanwhile, Enforcement Directorate of (ED) conducted searches at 10 locations in Delhi, Gurgaon, and Rohtak in connection with an ongoing money-laundering case against Inderjit, his associates, Apollo Green Energy Ltd, and other linked entities under the Prevention of Money Laundering Act (PMLA). 2002 on Dec 26 and 27.ED said the proe was initiated on the basis of more than 15 FIRS

and pensioners, it becomes clear that governments change but policies do not change, so nothing new has been achieved for the employees in the year 2025. The year 2025 has left a lot of questions for the employee movement! Teacher leader Bikramdev Singh said that the teacher organizations have a leading role in the entire employee movement. In the year 2025, the employ-

ee movement is going through a period of serious crisis, which is also affecting the employees. In the year 2025, due to the teachers' movement being active, new recruitments continued only in the education department, even though it was decided by the previous governments, no new recruitments were made in any other department. ## Shiv Sena Demand for Separate State for Western Uttar Pradesh

Muzaffarnagar: Shiv Sena has once again adopted an aggressive stance, intensifying its demand for granting separate statehood to Western Uttar Pradesh and for the implementation of a population control law across the country. Under the leadership of district president Bittu Sikheda, a memorandum addressed to the Prime Minister was submitted through the District Magistrate. In the memorandum, Shiv Sena stated that the 28 districts of Western Uttar Pradesh have long remained neglected in terms of development. Despite contributing nearly 80 percent of the state's total revenue, the region's youth are not receiving adequate benefits of development, government schemes, or employment opportunities. The party argued that the vast state of Uttar Pradesh, comprising 75 districts, should be reorganized into smaller states on the lines of Uttarakhand, Haryana, Punjab, and Delhi, in the interest of local residents. Shiv Sena emphasized that the creation of a separate

state for Western Uttar Pradesh would accelerate development in education, healthcare, employment, and basic infrastructure,



while also making the administrative system more efficient and accountable. Along with this, the memorandum also raised a strong demand for the enactment of a population control law. The organization stated that the rapidly growing population is putting immense pressure on the country's limited resources, and if a concrete law is not introduced in time, the situation could become even more serious in the future. Speaking on the occasion,

State Vice Chief Pramod Agrawal said that the people of Western Uttar Pradesh have been demanding separate state-

hood for years. "Our region is the backbone of the country's economy, yet it continues to lag behind in development. A separate state will create employment opportunities for youth and ensure permanent solutions to regional problems. A population control law is the need of the hour, and the government must take a serious decision on this," he said. Shiv Sena has urged the central government to take an early decision on both issues and implement concrete steps in the larger public interest. CIA behind strike at Venezuelan dock that Trump claims was used by drug smugglers, say sources

**WASHINGTON . (Agency)**  
The CIA was behind a drone strike last week at a docking area believed to have been used by Venezuelan drug cartels, according to two people familiar with details of the operation who requested anonymity to discuss the classified matter. The first known direct operation on Venezuelan soil since the US began strikes in September marks a significant escalation in the administration’s months-long pressure campaign on Venezuelan President Nicolás Maduro’s government. The strike has not been acknowledged by Venezuelan officials. US President Donald Trump first made reference to the operation in an interview Friday with John Catsimatidis on WABC radio in New York, saying the US had knocked out some type of “big facility where ships come from."In an exchange with reporters Monday as he hosted Israeli Prime Minister Benjamin Netanyahu at his Mar-a-Lago resort, Trump added that the operation targeted a “dock area where they load the boats up with drugs.” But the president declined to comment when asked whether the attack was conducted by the military or the CIA.The CIA and White House officials also declined to offer further comment on the matter. Col. Allie Weiskopf, a spokesperson for Special Operations Command, which oversees US operations in the Caribbean, said in a statement that “Special Operations did not support this operation to include intel support.”

Thieves drill into German bank vault, make off with about 30mn euros in cash, valuables

**BERLIN. (Agency)**  
Robbers used a large drill to break into a German savings bank's vault room and steal cash, gold and jewelry worth some 30 million euros (\$35 million), police said Tuesday.The heist in the western city of Gelsenkirchen saw the thieves break into more than 3,000 safe deposit boxes, they said. While the criminals remained at large, hundreds of distressed bank customers massed outside the branch on Tuesday demanding information, but were kept at bay by police.According to police, the robbers drilled their way into the underground vault room of the Sparkasse savings bank from a parking garage. Investigators suspect the gang spent much of the weekend inside, breaking open the deposit boxes.



The break-in came to light after a fire alarm was triggered in the early hours of Monday and emergency services discovered the hole. Witnesses reported seeing several men carrying large bags in the stairwell of the parking garage during the night from Saturday to Sunday.Footage from security cameras has also shown a black Audi RS 6 leaving the parking garage early Monday morning, with masked persons inside.The car's license plate had been stolen earlier in the city of Hanover, police said. A police spokesman told AFP that the break-in was "indeed very professionally executed", likening it to the heist movie "Ocean's Eleven".

Taiwan coastguard says Chinese ships 'withdrawing' after drills

Chinese warships and coastguard vessels are withdrawing from waters around Taiwan, the island's coastguard said on Wednesday, with Beijing's military drills appearing to be "over."China launched missiles and deployed dozens of fighter jets, navy ships and coastguard vessels around the island on Monday and Tuesday in live-fire drills aimed at simulating a blockade of the Taiwan's key ports and assaults on maritime targets.Taipei, which slammed the two-day war games as "highly

provocative and reckless," said the manoeuvre failed to impose a blockade on the island.Communist China has never ruled democratic Taiwan, but Beijing claims the island of 23 million people is part of its territory and has threatened to use force to annex it."The warships and coastguard vessels are withdrawing, but a few are still lingering outside the 24-nautical-mile line," Hsieh Ching-chin, deputy director-general of Taiwan's coastguard, told AFP, indicating the "drills should be over."Taiwan's coastguard has maintained a deployment of 11 ships at sea because China Coast Guard vessels "haven't completely left the area yet" and "we can't let our guard down," he said. Beijing has not yet publicly declared the drills to be finished.Taiwan's President Lai Ching-te warned on Wednesday that Chinese drills targeting the island "are not an isolated incident" and pose "significant risks" to the region. "China's authoritarian expansion and

escalating coercion pose significant risks to regional stability and also impact global shipping, trade and peace," Lai said at a promotion and rank conferment ceremony for military officers in Taipei.China's show



of force follows a bumper round of arms sales to Taipei by the United States, Taiwan's main security backer, and comments from Japan's prime minister that the use of force against Taiwan could warrant a military response from Tokyo. There has been a chorus of international

criticism of China's drills.Japan said Wednesday that China's military exercises "increase tensions" across the Taiwan Strait, and that it had expressed its "concerns" to Beijing.Australia's foreign ministry also condemned on Wednesday China's "destabilising" military drills around Taiwan, saying it had raised concerns with Beijing counterparts.Beijing slammed criticism of its exercises as "irresponsible.""These countries and institutions are turning a blind eye to the separatist forces in Taiwan attempting to achieve independence through military means," foreign ministry spokesman Lin Jian told a news briefing Wednesday."Yet, they are making irresponsible criticisms of China's necessary and just actions to defend its national sovereignty and territorial integrity, distorting facts and confusing right and wrong, which is utterly hypocritical.

The relations among the four countries — the United States, Australia, India, and Japan — continue to be stable and strong," he said and posted a photo of

the four envoys, including Indian Ambassador to Beijing Pradeep Kumar Rawat.The Indian Embassy



here has not yet commented on the meeting.China, over the years, has been a strong critic of the Quad and has not yet reacted to the meeting. Beijing, in the past while reacting to the Quad

meetings, stated that it is opposed to countries forming cliques, engaging in group politics and bloc confrontation. Zohran Mamdani will become mayor of New York City as the clock ticks over into 2026 — but the celebrations are set to last through New Year's Day.The Democrat's team is planning two separate swearing-in ceremonies Thursday — a small, private one with his family in an old subway station around midnight, followed by a large event in the afternoon that will include a public block party outside City Hall.As a new mayor's term begins immediately with the new year, it has been

customary for the city's incoming leaders to hold two events. Outgoing mayor Eric Adams held his initial swearing-in at Times Square shortly after the famous ball drop, while Adams' predecessor, Bill de Blasio, took his first oath at home in Brooklyn. For his part, Mamdani will take his initial oath at the former City Hall subway station in Manhattan — one of the city's original stops on its subterranean transit system, known for its tiled arches and vaulted ceilings.New York Attorney General Letitia James, a political ally and notable foe of US President Donald Trump, will administer the oath of office. The old City Hall stop was designed as the flagship station of the city's first subway line, but was decommissioned in 1945. These days, outside of occasional guided historical tours, locals can usually only catch a glimpse of it by staying on the 6 train after its last stop downtown when it turns around to head north.In a statement, Mamdani's office said the choice to be sworn in at the station reflected his "commitment to the working people who

keep our city running every day." "When Old City Hall Station first opened in 1904 — one of New York's 28 original subway stations — it was a physical monument to a city that dared to be both



beautiful and build great things that would transform working peoples' lives," Mamdani said."That ambition need not be a memory confined only to our past, nor must it be isolated only to the tunnels beneath City Hall: it will be the purpose of the administration fortunate enough to

serve New Yorkers from the building above," he said.On Thursday afternoon, Mamdani will be sworn in again, this time by US Sen. Bernie Sanders, one of his political heroes, on the steps of City Hall in a ceremony scheduled to kick off at 1 p.m. US Rep. Alexandria Ocasio-Cortez, another political ally, will deliver opening remarks.Mamdani's transition formed an inaugural committee that includes actor John Turturro, playwright Cole Escola and writer Colson Whitehead, as well as advocates, small business owners and campaign workers who the incoming mayor's office says have "provided perspective, guidance, and cultural sensibility" for the ceremony. The public swearing-in will be accompanied by a block party along a stretch of Broadway leading up to City Hall. Mamdani's office expects thousands of people to attend and says there will be performances, music and interfaith elements.

Jharkhand: Three inmates missing from Hazaribag Central Jail

Hazaribag. (Agency)

Three inmates have gone missing from the Loknayak Jayaprakash Narayan Central Jail, triggering concern within the state administration over security arrangements at the high-security prison. Confirming the incident, Jail Superintendent Chandrashekhar Suman said preliminary information suggests that all three inmates are residents of Dhanbad.

However, he added that details regarding their identities and whether they were convicts or undertrials are yet to be ascertained.

The incident has raised fresh questions about prison security, as the Hazaribag Central Jail is known for housing hardened criminals, Naxalites and several high-profile undertrial prisoners. The jail is considered one of the most secure facilities in the state.

In recent weeks, security at the jail had been further tightened. The Inspector General of Prisons had suspended 12 security personnel to strengthen vigilance, following which security protocols were reportedly reinforced. Despite these measures, the disappearance of three inmates has put the jail administration under renewed scrutiny.

The prison is protected by a five-layer security system, requiring thorough checks for anyone entering or exiting the premises. The jail also holds historical significance, as veteran freedom fighter Jayaprakash Narayan had famously escaped from the same prison during the freedom movement.

PGI contract workers observe hunger strike over non-payment of wages

Chandigarh .(Agency)

Several contract workers at the Postgraduate Institute of Medical Education and Research (PGI) observed a hunger strike from 6 am on Tuesday, protesting non-payment of long-pending wages and other service-related demands.

The PGIMER currently has close to 4,000 contract workers. According to the Joint Action Committee (JAC) of the PGIMER contract workers, those participating in the hunger strike included sanitary attendants, sanitation supervisors, hospital attendants, bearers and cooks working in morning and evening shifts. The JAC said the protest was carried out in a “peaceful, voluntary and democratic manner”.

JAC chairman Ashwani Kumar Munjal said the hunger strike was a result of compulsion, alleging that nearly Rs 55 crore in basic pay and dearness allowance has been pending since January 13, 2024. He said arrears of sanitation supervisors, sewer men, and staff posted at Nehru Hospital Extension and the Sangrur

satellite centre are also yet to be cleared.

Munjal further alleged that a written assurance given by the PGIMER administration on August 12 had not been honoured, leading to



widespread anger among contract workers. Other demands include maternity leave and medical benefits for women contract staff, payment of a bonus, reinstatement of four security guards removed in November 2024, and parity in facilities with regular employees.

The JAC warned that if no resolution is reached within the next two to three days, it will chalk out further action, including another one-day collective hunger strike in the first week of January.

A statement issued by the PGIMER said that its administration successfully maintained full operational capacity despite the strike. “Due to a robust contingency plan deployed by the administration, patient care across all departments remained entirely unaffected,” the institute said in the statement. The services, including OPD, indoor, operation theatre, emergency, trauma, diagnostics, and others, remained unaffected, the statement added.

A total of 8,770 patients were seen in the OPD, and 166 in the Emergency and Trauma department. Around 100 new patients were admitted, and 137 surgeries were performed. The majority of outsourced workers continued to perform their duties, the institute claimed.

From sleepy suburb to bustling metropolis, Mohali steps out of Chandigarh’s shadow

It was not long ago that Mohali was dismissed as Chandigarh’s sleepy sibling, a patchwork of villages and housing clusters shaped largely by the spillover from the region’s meticulously planned capital. Chandigarh’s strict planning norms kept it neat and contained, leaving Mohali to grow around its edges. Fast forward to 2025, and Mohali’s skyline, roads and social fabric tell a very different story of rapid growth, demographic churn and entrepreneurial energy. The city is now bursting at the seams.

Mohali was conceptualised in the 1960s as part of the region’s planned expansion, but it began to draw attention only in the 1990s and early 2000s. Infrastructure projects played a decisive role. The operationalisation of the Shaheed Bhagat Singh International Airport significantly boosted air connectivity, while new road links, particularly along the Airport and Kharar corridors, strengthened road access and opened up large tracts for development.

Today, Mohali sits at the crossroads of education, technology, real estate and lifestyle economies. It thrives not merely because of its proximity to

Chandigarh, but because it has steadily built an ecosystem of its own. Education cluster

One of Mohali’s most visible success stories is its emergence as a knowledge and education hub. Institutions such as the National Institute of



Pharmaceutical Education and Research first put the city on India’s academic map, paving the way for both public and private players.

The district today hosts multiple universities including Amity University, Rayat Bahra University, Ashoka University and Plaksha University, along with centres of excellence

such as the Indian School of Business and the Indian Institute of Science Education and Research. Students from across the country and overseas now call Mohali home, lending the city a distinctly youthful and cosmopolitan character.

This growth is anchored in the Education City project, envisaged as a 1,700-acre learning destination offering land to global institutions across disciplines ranging from engineering and pharmaceuticals to media and hospitality. With residential, commercial and academic clusters planned together, the project aims to position Mohali as a global learning hub rather than just a student town. Mohali’s identity has evolved sharply over the decades. Conceived as a village in the 1960s, it was later planned as an industrial town and then transitioned into a satellite city. In 2002, during the tenure of former Chief Minister Amarinder Singh, the state introduced the Mega Project Policy, offering incentives to projects spread over at least 100 acres. This opened the door for developers such as DLF, Emaar, MGF and Ansal, who brought large-scale housing projects and accelerated urbanisation.

Odisha: Former agriculture cooperative society functionary held for Rs 79 lakh misappropriation

A former managing director of agricultural cooperative society in Odisha’s Sambalpur district was arrested today by Vigilance sleuths on the charge of embezzling Rs 79 lakh which was collected from the farmers towards loan repayment.

Fanindra Kumar Sahu, Former Managing Director of Jamankira Large-sized Agricultural Multi-Purpose Cooperative Society (LAMPCS) Limited, Sambalpur was arrested today by Odisha Vigilance.

The arrest follows an investigation into the financial discrepancies of the 2021-22 fiscal year, where a total of Rs . 7 9 , 2 8 , 0 0 0 (approximately) was allegedly misappropriated by Sahu, the Vigilance said in a statement. Sahu allegedly collected loan repayment amounts directly from local farmers but intentionally omitted these entries from the Day Book (the primary accounting record). To hide the missing funds, he reportedly submitted false

repayment vouchers to the SDCC Bank (Sambalpur District Cooperative Central Bank), Jamankira Branch. These documents were bolstered by fake seals to mimic official bank verification. In this connection, Odisha Vigilance has registered a case under sections 13(2) r/w 13



(1)(a) Prevention of Corruption (Amendment) Act, 2018 besides sections 468/471/477-A/409 Indian Penal Code against the accused Sahu. Sahu was later remanded to judicial custody after a local Court rejected his bail.

Netizens of Kolkata woke up season's coldest day this year-end with temperature dipped to 11 Degrees

The netizens of Kolkata on Wednesday woke up to a season's coldest day with mercury dipped to the lowest 11 degrees so far, a record in 2025, initially with poor visibility, which later cleared with the sunshine allowing to clear traffic of trains and flights with delayed schedules, official sources said.

The cold spell, which persisted for past weeks, further tightened in the neighbouring districts of South Bengal in Bankura and Purulia between 5 and 6 and hardened to below 3 degrees in the Darjeeling hills. The netizens of Kolkata have been experiencing a significant cold spell from mid December, with temperatures dropping between 12-13°C, marking the coldest period of the season.

Even the areas like Dum Dum and its outskirts have been witnessing temperatures between 8 to 10 degrees and further colder weather conditions in the surrounding South Bengal districts like Bankura and Purulia. This intense chilly weather condition due to persisted dry, and

cool northerly winds and dense morning fog, making it the most significant winter month of the year.

Dense fog, or truly the smog condition wrapped large parts of the state causing disruption of train schedules, flight departure also causing difficulties in navigating waterways traffic in the city and suburban areas.

The seasonal travellers are also flocking Darjeeling Hills hoping for snow, though it is rare in the main town, with higher chances in nearby areas like Sandakphu, Tiger Hill, and Phalut; The visitors seek clear views of snow-capped Kanchenjunga and experience the chill.

The dip in the mercury in the Darjeeling hills and snowfall in the upper reaches of Sikkim have triggered a massive influx of tourists since Christmas, with visitors flocking to the mountains to enjoy the chill.

The India Meteorological Department (IMD) says the possibility of light to moderate snowfall in the upper reaches of the hills by the weekend.

Kolkata on high alert for New Year’s Eve as police plan massive security cover

Kolkata will be under an unprecedented security blanket on New Year’s Eve, with police deploying nearly double the number of personnel compared to Christmas Day to manage large crowds, prevent rowdiness and ensure public safety during year-end celebrations.

Around 6,500 police personnel will be deployed across the city in two phases — an initial posting from around 9 am, followed by the main deployment from 4 pm onwards.

Senior officers said the crowd on December 31 is expected to be larger than on Christmas, requiring tighter crowd control and quicker response mechanisms. Sources in Kolkata police said that there will be special concentration in Central Kolkata, particularly the Park Street area where the rush is expected to be high. Of the total deployment, around 4,000 police personnel will be stationed on roads between Park Street and the Alipore Zoo–Alipore Jail Museum stretch, with nearly 2,500 cops

posted on Park Street alone. Another 1,300 uniformed personnel will be deployed across other hotspots and special nakas in different parts of the city. As in previous years, extensive use of technology will be made for surveillance. Drones and a wide network of CCTV cameras will monitor crowd movement in Park Street and the Alipore Zoo areas.

Multiple watchtowers will be set up, and the central business district will be divided into several zones, overseen by 18 IPS officers. Police assistance booths will also be set up to help revellers.

Specialised teams from the detective department, the Kolkata Police STF, Special Branch and quick response teams (QRTs) will be on the ground. By evening, plainclothes personnel, teams from the detective department’s watch section and the all-women “Winners Team”

will be deployed in and around Park Street to prevent harassment and other illegal activities. Sources at Kolkata Police



headquarters, Lalbazar, said special teams have been formed based on intelligence inputs, with a special focus on the safety of women, children, and the elderly.

Extra security will also be in place on the Kolkata Metro, with additional Railway Protection Force personnel deployed to manage passenger rush. Police have ordered a strict crackdown on drink driving, with special raids likely to continue daily through the festive period.

Instructions have also been issued to ensure crackers are not burst beyond court-mandated hours and to act against DJs playing music above permissible sound limits. Cops have further decided not to allow people to loiter or block entrances of eateries.

“The crowd will be larger than Christmas and rowdiness is usually higher on this day, so our response has to be adequate,” a senior police officer said, adding that while Kolkata is generally considered safe, strict enforcement is necessary to ensure peaceful celebrations.

Let’s resist attempts to weaponise ignorance

IN this terribly toxic, violent and polarised world, it is easy to get carried away by the all-pervading negativity that characterises our times. Yet, as a teacher, I continue to feel that we should not give up, and we must sow the seeds of hope and inspire the new generation to imagine and strive for a better world.I wish to appeal to the teaching fraternity to welcome the new year with a heart-felt prayer: Let the pedagogy of hope alter the dynamics of the classroom, redefine the purpose of education and activate the power of critical thinking, creative imagination, empathy and love.

However, it is important to acknowledge that the despair we see among contemporary students and teachers often manifests itself in the form of some sort of cynical pragmatism.

As the market-driven/instrumental logic of neoliberalism robs education of a higher and nobler purpose, and transforms into a mere technical skill for economic productivity, many youngsters begin to regard social Darwinism or hyper-competitiveness as a new virtue, money as a new God, and egotistic pride as a status symbol.

No flower blooms in their inner world; seldom do they converse with Gandhi and Marx; and they have no ‘surplus’ time to struggle for equity, ecology, peace and justice. Yes, this sort of pragmatism means the absence of hope for a new world.Likewise, the cult of hyper-nationalism further intensifies this sort of pragmatism among many teachers. As surveillance is normalised, many teachers in our colleges and universities begin to feel that they are being constantly monitored and observed.And possibly, this sort of fear makes them extremely cautious of what they can teach, speak and write. As the colonisation of the academic sphere by the discourse of hyper-nationalism robs education of its libertarian potential, it is not impossible to find a significant section of teachers who prefer to remain silent, or become over-enthusiastic to show their loyalty to the system.It is, therefore, not surprising that these ‘pragmatic’ teachers fail to arouse a new imagination, or the language of resistance amongst their students.Here is a world tormented by war, authoritarianism and climate emergency. Yet, our colleges and universities refuse to see anything beyond the metrics of ‘ranking’, and the narratives of ‘placements and salary packages’.

Hence, the question arises: What is the pedagogy of hope I am referring to? And is it at all possible? Let it be understood clearly that it is not an empty ideal, or an imaginary utopian act.It’s impossible to nurture it without critical pedagogy: the kind of education that encourages the young learner to regain his/her creative agency, and question what damages the possibility of a just, egalitarian, humane and ecologically sensitive world.It is like understanding and theorising rigorously, say, the aggression of hyper-nationalism that causes war, genocide, militancy, terrorism and religious fundamentalism; the greed implicit in the logic of modern technocratic capitalism that reduces everything — be it a tree, a river, a forest or a mountain — into a mere ‘resource’ for ceaseless ‘growth’ and ‘development’, and leads to the horrors of climate emergency; and above all, the unholy alliance of billionaire technocrats and neo-fascists that erodes the spirit of democracy.Moreover, the pedagogy of hope means that education cannot be reduced to a mere technical skill; instead, it is essentially about awakened intelligence, or what Henry Giroux — one of the finest educationists in our times — would have characterised as a transformative tool for nurturing informed and politically aware democratic citizens. This is the only way to resist the weaponisation of ignorance.Apart from critical thinking, the pedagogy of hope needs something more. It needs a mode of learning that arouses every young learner’s hidden potential — I mean, the courage to dream of a new world; the willingness to unite knowledge and praxis, thinking and feeling, and science and aesthetics.

AAP on top in rural polls, but no room for complacency

The recent victory is no guarantee of AAP’s success in the 2027 Assembly polls.

The ruling party’s sweeping victory in the rural body elections has been a foregone conclusion since long, particularly after the 73rd Amendment (1992) gave constitutional status to Panchayati Raj institutions (PRIs) in India.In Punjab, the ruling Aam Aadmi Party (AAP) was the runaway winner in the recent block samiti and zila parishad polls. Opposition parties such as the Congress and the Shiromani Akali Dal (SAD) made their presence felt in areas where local leaders wielded influence.The AAP claimed that the mandate was an endorsement of the good work done by the Bhagwant Mann government since 2022 in rural Punjab and it would help the party retain power in the 2027 Assembly elections. However, the Congress and the SAD accused the AAP of indulging in high-handedness and misusing state machinery to win the elections.The aim of establishing the three-tier Panchayati Raj system was to strengthen the democratic process at the grassroots level. Though the system was implemented in 1959, it did not have full constitutional validity before the 73rd Amendment in 1992.Subsequently, it became a permanent, mandatory part of India’s democratic structure and incorporated in Part IX of the Constitution. However, devolution of powers to rural bodies has been mostly conspicuous by its absence, thus making them political tools in the hands of the ruling party.

The first block samiti and zila parishad elections in Punjab were held during the rule of the Beant Singh-led Congress government in 1994. Riding high after having rooted out decade-long terrorism in the state, the ruling party swept the elections. It was the first normal election in Punjab in the post-terrorism period.The 1992 Assembly and parliamentary elections witnessed a very low turnout (23.50 per cent) due to the boycott by major Akali Dal factions and threats from terrorist organisations against people’s participation. The SAD, having a rural base, had contested the block samiti and zila parishad elections but failed to make a major impact. Rather, the party had levelled allegations of large-scale malpractices and accused the Congress of throwing all democratic norms to the wind to win those elections. The end result was the Congress’ rout in the 1997 Assembly elections — it could win only 14 seats against 87 in 1992. In the Lok Sabha elections in Punjab, the Congress’ tally dropped from 12 seats (out of 13) in 1992 to two in 1996; it drew a blank in the 1998 parliamentary elections.

The AAP performed below par in the 2024 parliamentary elections, winning only three seats despite being in power. Its performance in the urban elections was also dismal as it failed to get a clear-cut majority in the majority of the civic bodies. The party was desperate to reassert its dominance. No wonder it went all out to win



the rural elections.The party relied on brazen messaging during campaigning in rural areas, with slogans such as “AAP di Sarkar, AAP di Zila Parishad, AAP di Block Samiti — taanki sidha kam AAP de hath”. It was a message for the rural masses: vote for us or struggle to get your work done.The ruling party made its intentions clear; in some cases, it was throwback to the SAD-BJP rule (2007-17) when halqa incharges were made extra-constitutional centres of power. The SAD had given them a free hand, which ultimately resulted in the political marginalisation of the party.The outcome only reflects an assertion of power, not the eagerness of the people to endorse the work done by the government. The highhandedness will breed deep resentment among the rural masses. The ruling party may consider this victory as significantly pro-incumbency, but this is no guarantee of success in the Assembly elections.

A close look at these elections lays bare fault lines in state politics, particularly at the grassroots level. The allegations and counter-allegations have become an integral part of Punjab politics, ignoring the core issues and problems faced by the people of the state.

The entry of gangsters and candidates backed by gangsters and their success in some cases have raised disturbing questions about politics in Punjab.

Notably, the Viksit Bharat Guarantee for Rozgar and Ajeevika Mission (Gramin) (VB G-RAM-G) Act, which has replaced the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) as the flagship Central scheme for wage employment for rural workers, has been opposed by AAP, SAD and the Congress.With a little over a year left for the Assembly elections, the AAP continues to grapple with several issues: deteriorating law and order situation, dissatisfaction among various sections of society, inaccessibility of some elected representatives, the financial crisis and the failure to meet the expectations of the people who had voted wholeheartedly for the party in the 2022 elections.The influence of an unconstitutional power centre based in Delhi is also a matter of concern for the electorate. The unfortunate part of Punjab’s story in the post-Green Revolution era is ‘growth without development’, which is the result of dominance of the rural elite in politics. Political leaders and their parties are largely not keen on strengthening the democratic structure at the grassroots.Factional politics without ideological commitment has also contributed to the degeneration of the political process in the state. The big question is: Whether or when will Punjab move towards a participatory political process?

Congress must rebuild organisational muscle

The alleged assault on a Colonel and his son by Punjab Police officials in March throws up questions on policing methods

IT has been a forgettable year for the Congress on the electoral front — the party suffered a debacle in Delhi as well as Bihar and didn’t find many takers for its ‘vote chori’ allegations. The new year will be even more challenging, with Assembly elections scheduled to be held in Assam, Kerala, Tamil Nadu and West Bengal. No wonder the top brass put on a brave front at the party’s 140th foundation day. Leader of the Opposition Rahul Gandhi said the Congress was “not just a political party, but the voice of India’s soul that has stood with every weak, deprived and hardworking person”; party chief Mallikarjun Kharge declared that “the Congress is an ideology and ideologies never die.”The harsh reality is that the party’s existential crisis is worsening by the day. Rumbblings of discontent are quite evident. Senior leader Digvijaya Singh caused a flutter on Saturday when he lauded the RSS-BJP’s organisational



power and shared an old picture of Narendra Modi in a post on X. He also stressed the need to strengthen the Congress at the grassroots level. Shashi Tharoor’s measured support for Digvijaya’s views suggests that the party cannot afford to compromise on rebuilding organisational muscle.

The Congress has claimed that history, values and ideology remain its core assets. Whether these assets can be converted into electoral gains depends less on rhetoric and more on the party’s ability to reform, reorganise and convincingly reconnect with the masses. The BJP, whose juggernaut rolls on, has dubbed the Congress an “army of sycophants” and the “weakest link” in Indian democracy. Such criticism, which is not far off the mark, should spur the grand old party to turn the tide. At 140, the Congress stands at a crossroads; its resurgence holds the key to the Opposition’s prospects of combating the BJP.

Aravallis are vital for food security

There is a dire need to protect the hills that serve as a green wall against desertification

IN the 2021 Hollywood satire Don’t Look Up, two American astronomers warn the world about a comet racing towards the planet. However, the US President is lured by a billionaire CEO, who claims that the celestial object contains trillions of dollars’ worth of rare-earth elements. Eventually, the comet strikes Earth, triggering a global disaster.Had the protagonists flagged the dreadful consequences of the plunder of natural resources — evident from the proposed 100-metre definition of the environmentally sensitive and degraded Aravalli range, known as North India’s green lungs — the film would have been titled Don’t Look Up, Look Down. This is what Mahatma Gandhi had warned against when he said: “The world has enough for everyone’s need, but not enough for everyone’s greed.”

Several years ago, I visited Bilaspur district in Himachal Pradesh for reporting on limestone quarrying at a site overlooking the Gobind Sagar reservoir in the fragile Himalayas. A cement company was steadily peeling, layer by layer, a limestone-bearing hill. When I asked the company’s general manager whether he realised that severe ecological damage would be caused by levelling the hill, his answer reflected the dominant mindset: “What ecological damage are you talking about when the hill will no longer be there?”This does not, however, mean tat all development activities based on the exploitation of natural resources must stop. It only means that excessive mining for major nutrients, for instance, comes with severe environmental consequences, and there is a need for tougher regulations as well as an economic evaluation of ecosystem services. It has social implications for which no measurement formula exists. In such a scenario, even if the policymakers have to err, they need to err on the side of the people and the environment.Similarly, when Himalayan glaciers began to melt, there was an effort to build a narrative challenging what were then referred to as highly



misguided claims. Thank heavens the world is now awake to the catastrophic consequences of melting glaciers. Going beyond global warming, the world has already entered the global boiling stage. It implies reckless exploitation of hills and forests, which will only push the world towards a climate catastrophe.Stretching across 1,44 lakh sq km in 37 districts of four states — Gujarat, Rajasthan, Haryana and Delhi — the Aravallis have abundant reserves of major minerals like lead, zinc, silver, copper and of course, marble. In addition, the hills are also rich in critical minerals like lithium, nickel, molybdenum, niobium and tin. Just as the US President in Don’t Look Up was made to believe that the comet’s economic wealth would bring in immense fortune, it is being acknowledged that the minerals present in the

Aravallis are essential for the economic development of the country. If that be so, I don’t know why massive #SaveAravalli protests are taking place. Don’t people understand the economic value of the mineral wealth that needs to be extracted at any cost?Over a billion years old, the Aravallis have served as a green wall against desertification of the northwestern region. These hills are also a repository of rich biodiversity; they play a key role in recharging aquifers and have resisted the march of the desert into Delhi, Haryana and Uttar Pradesh. But a lot of damage has already been done to the wildlife habitats and local livelihoods by human intervention and the development process in the Aravalli belt.

As the desert expands, the country’s hard-earned food security is under threat.Parliament was informed in

February 2025 that as per the 2021 Desertification and Land Degradation Atlas of India prepared by the Indian Space Research Organisation, deserts are fast creeping into the food bowl. Already, more than 3.64 lakh hectares in Haryana, 1.68 lakh hectares in Punjab and 1.54 lakh hectares in Uttar Pradesh are under land degradation and desertification. If the Aravallis are made to conform to the new definition, land degradation will only hasten. It will open the floodgates for gushing hot winds, frequent dust storms, soaring temperatures; coupled with the depletion of deep aquifers due to exhausting crop farming, this will lead to rapid soil erosion, thereby degrading farming lands.While the debate on the proposed new benchmark for the Aravallis is focused on mining and the environment, the emerging threat to long-term food security is getting sidelined. The United Nations Convention to Combat Desertification has warned that desertification deals a severe blow to soil fertility, turning fertile lands semi-arid. Surely, desertification is too serious an issue to be confined to claims and pledges. Putting a new management plan into action and promises of ‘robust protection’ are no longer adequate safeguards.

The Aravallis are not just a natural reserve for strategic minerals; they also provide massive ecosystem services. The true economic cost of these ecological and environmental services has not been worked out.

Once this cost is known, the nation will realise the economic necessity of keeping the hills intact, even as the economic cost of extracting minerals is overemphasised.

If national accounting as per the TEEB (The Economics of Ecosystem Services of Biodiversity) norms can ascribe an economic value to the religiously important Mount Kailash and the Dal Lake, a similar cost-benefit analysis must be done for one of the oldest hill ranges in the world.

## Light snowfall triggers traffic curbs as New Year tourist rush builds up in Himachal

Light snowfall in higher regions and adjoining areas has prompted the district administration on Wednesday to regulate vehicular movement and issue fresh advisories to commuters and tourists ahead of the New Year rush. Authorities said freezing of surface water and formation of black ice have made mountain roads slippery and potentially life-threatening. "As a precautionary measure, tourist cabs and private vehicles were advised to return to safer locations after announcements were made at the North Portal".

Officials cautioned that frost and invisible ice layers significantly raise the risk of vehicles skidding, collisions and hitting roadside parapets. The district administration of Lahaul-Spiti had already issued a traffic advisory for local commuters and tourists, restricting movement on vulnerable stretches and closing entry beyond the Rohtang Tunnel after light snowfall along the snowline areas.

Though it was briefly opened for regulated vehicular traffic on Monday, officials said movement was later curtailed as conditions deteriorated. Across the state, weather remained largely dry to overcast on Tuesday, with reports of light snowfall confined to higher elevations. There was no snowfall till morning at popular hill destinations on Wednesday.

Meanwhile, the New Year tourist influx intensified, with hospitality units in Shimla and Manali reporting around 80 per cent occupancy. Authorities warned that roads may witness heavy congestion as large numbers of visitors arrive for short stays. Police and district officials have appealed to tourists to avoid unnecessary travel, follow advisories strictly, and plan journeys with caution, stressing that traditional winter travel discipline remains essential for safety in the hills.

These services include Mail/Express & Passenger trains connecting key destinations such as Guwahati, Sairang, Dibrugarh, Agartala, North Lakhimpur, Katihar, Jogbani, Anand Vihar and several other major locations of the nation, providing additional travel options to passengers, particularly in long-distance and previously tough to access corridors. Further to enhance passenger convenience, the frequency of certain existing train services has also been increased. For e.g. passenger trains operating between Silchar and Mahishashan, which were earlier running only two days a week, have now been upgraded to operate six days a week. This enhancement is expected to greatly benefit daily commuters and passengers from the Barak Valley region by offering more flexible and reliable travel options. The new time table has

also formally incorporated Special trains that are operated during peak travel periods. A total of 12 pairs of Special trains running on important

New ANTF range officers will be opened in Ludhiana, Ferozepur, and Jalandhar, with existing ones upgraded with modern gadgets and forensic tools. The DGP said that pursuant to the New Criminal Laws, witness protection scheme has already been notified by the Punjab government which will further help in improving the conviction rate. Network connectivity at Police Stations will be upgraded by 50 Mbps to 100 Mbps at all the Police Stations depending on the workload. # "No One Tried To Save Him": Uproar Over Tripura Man's Murder In Uttarakhand

The uncle of Anjel Chakma, the Tripura MBA student murdered in Uttarakhand after he objected to locals using racial slurs – including calling his brother Michael and him 'Chinese momo' – has hit back at the state police force for claiming the horrid remarks were made in “jest”.Momen Chakma told Thursday morning, “When they went to the market to buy some things, some people, who were already drunk, made some comments, like calling them Chinese. And when Michael told them not to say such things, they attacked him.””Then Angel went to protect him, and they started beating and stabbing him. . . no one tried to save them. Uttarakhand Police said this is not racism, but it is indeed a case of racism.” The cops were also criticised by the Chakma Students Union, which represents the community, and for which Bipul Chakma said he had been hassled by an initially reluctant-to-act police.The young man's father, Tarun Chakma, a Border Security Force soldier stationed in Manipur, made the same allegation; he said police in Dehradun's Selakui area



initially refused to register his complaint. The FIR was filed only 48 hours later, under pressure from the students union.On Monday Ajai Singh, Senior Superintendent of Police (Dehradun), said the remarks Chakma objected to, and over which he was murdered, "does not fall into the category of a racist comment because a young man involved in the incident is also a resident of the same state". The derogatory remarks were made in "jest", Singh declared.On Tuesday he told Padmaja Joshi, "When I was asked on Day 1, I gave my

version according to the evidence I got...(now) these things have been raised, we will investigate it..."Asked specifically about the allegations about the word 'Chinese' being used, he said it is possible it had been used in 'jest' by the attackers which was misunderstood by the victims.Under pressure from the Chakma community and civil society activists, Singh also announced the formation of a special team to probe the killing. Five people have been arrested so far.A sixth, believed to be of Nepali origin, is on the run. The killing of Chakma has also spiralled into a political firestorm for the ruling Bharatiya Janata Party, with the Congress ripping into it; Congress leader Shama Mohamed red-flagged violence against minority communities and question Prime Minister Narendra Modi's silence.Speaking to ANI, Mohamed said, "Such an incident can happen with anyone. I saw a video in which Hindu men said they would kill all Muslims. Why is our PM silent? The Supreme Court should take suo motto cognisance... There is a complete breakdown of law and order..."

## Capital catalogue: Scandals & celebrities land up in city courts

New Delhi .(Agency)

The biggest news that came out of the courts was not of a verdict. A large stash of cash was discovered at the residence of Delhi High Court judge Justice Yashwant Varma during a fire incident on March 14, making national headlines. According to officials, close to Rs 15 crore was found during the firefighting operation. Following the incident, the Supreme Court repatriated Justice Varma to the Allahabad High Court and ordered an enquiry into the matter.An impeachment motion, too, was moved against him.The year saw several high-profile cases. Be it the dispute over actor Karisma Kapoor's late husband Sunjay Kapur's property or a petition seeking cancellation of the CBFC certificate of the film ‘Udaipur Files: Kanhaiya Lal Tailor Murder’, the front pages of the national dailies created quite a buzz. On August 7, the HC, however, refused to stay the release of the film. The Delhi High Court remained busy dealing with personality rights of multiple public figures, including Deputy Chief Minister of Andhra Pradesh Pawan Kalyan, cricketer Sunil Gavaskar and ‘The Art of Living’ foundation founder Sri Sri Ravi Shankar. Salman Khan, Nagarjuna, NTR Junior, Aishwarya Rai Bachchan, Abhishek Bachchan, Ajay Devgn, R Madhavan and Karan Johar also followed suit. An injunction was also granted to protect Hrithik Roshan's personality and publicity rights. A trial court became the centre of national attention after the ED filed a chargesheet against Congress leaders Sonia and Rahul Gandhi in connection with the alleged National Herald scam. The trial court also gathered media attention in two cases — IRTC corruption case and land-for-jobs scam case — filed against RJD chief Lalu Prasad and his family members. HC reserved judgement in the land-for-jobs case.

## Debate on pollution crisis to raise heat in winter session

The Delhi Legislative Assembly will re-convene on January 5, with the four-day winter session focussing on the pollution crisis in the national capital and scrutiny of three CAG reports, Art, Culture and Tourism Minister Kapil Mishra said on Tuesday.The minister said the government will table a proposal on pollution and table three CAG reports ‘one each on corruption in ‘Sheeshmahal,’ the functioning of the Delhi Jal Board (DJB), and Delhi government-run universities. The term ‘Sheeshmahal’ was coined by the BJP to point out the alleged opulence of the 6, Flagstaff Road residence of the ex-Delhi chief minister Arvind Kejriwal.“There is a very detailed report on the functioning of the DJB till the year 2022, it has all the details of all the irregularities which caused the sewage system of the city to collapse,” Mishra said at a press conference. “The CAG report on the irregularities in the functioning of universities governed by the Delhi government will be tabled, and all the corruption which occurred in the functioning of universities till 2023 will be exposed in the upcoming session,” he added. Mishra said the Assembly would examine the root causes of the perennial problem of pollution and assess past measures. “We will discuss what the previous government had done to curb the pollution. Further, we will also discuss the affidavits which were submitted in the Supreme Court and what their current status is in regards to mitigate pollution,” he said. Mishra also sought the opposition's feedback on battling the city's air pollution. The minister also said that the recent suspension of a registrar and tehsildar by the Delhi government reaffirms its stance of zero tolerance for corruption. “The days of corruption are over. The previous government is not in power anymore. This is a new government, and we will not tolerate any official indulging in corruption,” Mishra said. Meanwhile, Delhi BJP spokesperson Praveen Shankar Kapoor said that the AAP leaders should stop spreading false propaganda and play the role of a constructive opposition.He said, “Otherwise, AAP will soon be wiped out from Delhi's political landscape.” “The Arvind Kejriwal government had left behind a stalled Delhi, but the BJP-led government under Rekha Gupta has put Delhi back on the path of development within just 10 months. Except for the air pollution problem inherited from the Kejriwal government, the achievements and transformation brought by the BJP government are clearly visible in all other sectors,” he added.

## Mumbai Restaurant Fined Rs 50,000 For Mandatory Service Charge

New Delhi .(Agency)

The Central Consumer Protection Authority (CCPA) has imposed a fine of Rs 50,000 on China Gate Restaurant Private Limited, which operates the Bora Bora restaurant chain in Mumbai, for illegally levying mandatory service charges on customers.In an order dated December 29, the Central Consumer Protection Authority said the restaurant was adding a 10 per cent service charge by default to customers' bills and was also charging GST on that amount.This was done despite clear guidelines stating that service charges are voluntary and cannot be added automatically. The action followed a complaint filed by a Mumbai consumer through the National Consumer Helpline.The complainant alleged that the Bora Bora restaurant refused to remove the



service charge from the bill and even misbehaved when the issue was raised.The CCPA noted that the Delhi High Court, in its March 28, 2025 ruling in the case of National Restaurant Association of India versus Union of India, had clearly upheld the authority's guidelines and ruled that mandatory service charges are illegal. Despite this clear direction, the restaurant continued to levy service charges by default through its billing system.A detailed investigation by the CCPA's director general

(investigation) found that service charges were automatically added to all bills between March 28 and April 30, 2025.This showed that the charge was not optional but imposed on all customers. The investigation also found that the restaurant failed to resolve the consumer's complaint despite receiving multiple notices, charged GST on the service charge in violation of the guidelines, and had a non-functional email address, which restricted consumers from accessing grievance redressal mechanisms. While the restaurant claimed that the service charge was discretionary and said it had stopped the practice after becoming aware of the court ruling, the CCPA said it failed to provide any proof showing compliance during the relevant period.The authority also observed that the refund to the complainant was processed only after regulatory intervention.

## IndiGo Faces Rs 458 Crore GST Penalty, Airline Set To Contest Ruling

New Delhi .(Agency)

The country's largest airline IndiGo on Tuesday said authorities have slapped a GST penalty of over Rs 458 crore, and that it would contest the decision. The Additional Commissioner of CGST- Delhi South Commissionerate has slapped the penalty. It pertains to the assessment order under Section 74 of the Central Goods and Services Tax Act, 2017, for FY-2018-19 to FY 2022-23, according to a regulatory filing.The total GST penalty is Rs 458,26,16,980."GST department has passed an order imposing GST demand along with interest and penalty on compensation received from foreign supplier and denial of Input Tax credit. The company strongly believes that the order passed by the GST department is erroneous and not in accordance with law, backed by advice from external tax advisors."Accordingly, the company will contest the same and shall take appropriate legal remedies against the aforesaid order. The company is already in appeal before the Commissioner (Appeals) in a similar matter for FY 2017-18," the filing said on Tuesday. Further, IndiGo said that since it will contest the order, the order does not have any significant impact on financials, operations or other activities of the company.Separately, the Office of the Joint Commissioner, Lucknow, has imposed a penalty of Rs 14,59,527 on IndiGo for the period 2021-22. "The department has denied input tax credit availed and has raised a demand along with interest and penalty on the company. The company believes that the order passed by the authorities is erroneous. Further, the company believes that it has a strong case on merits, backed by advice from external tax advisors," InterGlobe Aviation, the parent of IndiGo, said in another regulatory filing. According to the company, it will contest the order before the appropriate authority, and there is no significant impact on its financials, operations or other activities.

## Government lifts the city, literally, with elevated corridors

New Delhi .(Agency)

As an ever-evolving city, the capital requires infrastructure updates, and a significant part of the state budget has been set aside for roads, bridges, sewage and water systems, drainage, and other public works.In a push to strengthen South Delhi's infrastructure, the Expenditure Finance Committee cleared three long-pending and critical projects — the Modi Mill Flyover, Savitri Cinema Flyover, and the MB Road Storm Water Drain project. The projects will be executed by the Public Works Department (PWD) with a combined investment of over Rs 759 crore. In 2025–26, the department secured substantial funding of around Rs 803 crore from the Central Road and Infrastructure Fund to upgrade over 140 road and flyover projects. These upgrades include widening, rehabilitation, resurfacing, and strengthening of key arterial thoroughfares such as Kashmiri Gate–Wazirabad Road, Vikas Marg (ITO to D-93), and Ferozeshah Road, as well as flyovers and connectors in Shahdara and East Delhi. A significant infrastructure push is the Sonia Vihar elevated corridor—a 5.5–6 km elevated road along Pustha Road in North East Delhi designed to decongest, and improve connectivity towards the Uttar Pradesh border.The PWD also initiated a large-scale 55-km redevelopment plan for the Mahatma Gandhi Ring Road corridor, aimed at decongesting major junctions with phased improvements, grade separators, and smarter traffic design. The PWD has been working on extensive repair and resurfacing of approximately 500 km of damaged roads across Delhi by March 2026.The Delhi Master Plan 2041 is also in the works, to guide major infrastructure decisions and help shape the city's future. The PWD is being reorganised to have its own dedicated engineering cadre, to hire and manage engineers independently.A new drainage master plan was launched with a huge investment to tackle chronic waterlogging problems and ensure water runs off streets quickly during rains.Work has begun on desilting 22 major drains, which will help reduce pollution flowing into rivers.

## New in the New Year: Noida looks at Jewar airport opening, real estate, infra boost in 2026

New Delhi .(Agency)

As 2025 draws to a close, Noida is set for one of its largest infrastructure expansions in recent years, fueled by the opening of the long-awaited Noida International Airport at Jewar. The airport has sparked a series of development projects along the Yamuna Expressway corridor.Speaking to The Indian Express, Shailendra Kumar Bhatia, Nodal Officer of the airport project, said, “Development of Noida International Airport is complete and the process of issuing the aerodrome license is underway.” While initially, the airport will open with one runway and an annual passenger capacity of around 1.2 crore, in the long-term, it is set to be spread over 11,750 acres, featuring five runways, and handling up to 30 crore passengers annually – making it one of the biggest airports globally. Currently, agricultural fields and village settlements surround the airport, though

the approach from Noida and Greater Noida shows increasing real estate activity. Work on projects like the extension of Regional Rapid Transit System rail links to Delhi and the manufacturing, Minda Corporation for wiring harnesses, as well as solar power players like SAEL Solar P6 and Amber Enterprises India.Electronics and semiconductor manufacturers like



Aditech Semiconductors, Dixon Technologies, and Ascent K Circuit are also set to start operations near the airport. The Electric Vehicles Manufacturers Welfare Trust is focused on electric vehicles and components,

and Havells India is bringing consumer goods manufacturing to the area. According to YEIDA officials, these projects are expected to be completed in 2026. While basic amenities in Jewar are still limited, they are set to improve: a 100-bed trauma centre and multi-speciality hospital is under construction near the airport.On the real estate front, 2026 is set to see significant progress after 2025 was marked by stalled projects and insolvency issues. Real estate lawyer Chaitanyashil Priyadarshi of Mimansa Law Offices said, “This year was not good when it came to real estate project handovers in Noida as most were stuck in insolvency. But for 2026, there is an exhaustive list of projects that are close to completion... Many of the pending projects are gradually being executed now and insolvency is also reaching .

The 32-year-old has already endured a busy home summer, featuring in the white-ball series against India before playing a Sheffield Shield match as preparation for the Ashes. Head has been in belligerent form in the Ashes, hitting two decisive hundreds, including the whirlwind 123 in the series opener in Perth.When asked about turning out for the Adelaide Strikers in the BBL, Head told News Corp: “Probably unlikely with the emotional drain of an Ashes series, and what’s coming up in terms of the World Cup.The emotional drain of actually being in an Ashes series and playing is always



tough. So I think it’s important to go into a World Cup fresh.”Head has not appeared for the Adelaide Strikers since the 2022–23 season of the Big Bash League. The star batter has regularly skipped Australia’s premier domestic T20 competition in recent years to prioritise international commitments and the Indian Premier League since returning to the tournament in 2024. Head has been an integral member of the SunRisers Hyderabad setup, forming a devastating opening partnership with Abhishek Sharma. He scored 567 runs at a staggering strike rate of 191.59 when SRH reached the final in 2024, followed by another prolific season in 2025.The BBL, which got underway on December 14, has once again been without several of Australia’s leading Test stars due to the Ashes.

### Magnus Carlsen now a 20-time world champion, ends 2025 with Rapid and Blitz double

NEW DELHI. (Agency)

World No. 1 Magnus Carlsen showcased his endgame genius once again as he added a record-extending ninth World Blitz title to the Rapid gold medal he had won two days earlier. Carlsen defeated Uzbek GM Nodirbek Abdusattorov in a hard-fought final of the World Blitz Championship in Doha on Tuesday, December 30. The Norwegian took home a €70,000 prize, securing his 20th world championship title overall across all three time controls. The triumph also marked the fifth time he has claimed the rare double crown as both the World Rapid and World Blitz champion.Carlsen refused to settle for a draw in the title showdown against the



young Abdusattorov and produced a stunning, unexpected pawn move in the fourth game of the clash to seal a 2.5–1.5 victory and extend his reign in Blitz chess.After the first three games, both players were locked at 1.5 points apiece. The victory was all the more sweet and fulfilling for the Norwegian, who had endured a string of losses during the qualifying (Swiss round) and struggled to secure a place in the knockout semifinals.A draw in Round 19 against Abdusattorov saw both Carlsen, on 13.5 points, and the Uzbek, on 13 points, clinch the final two semifinal spots on Tuesday, finishing behind sole leader Arjun Erigaisi, who topped the standings with 15 points, and American GM Fabiano Caruana, who followed with 14 points.Carlsen then went on to defeat Caruana 3–1 to book his place in the final, while an impeccable Abdusattorov handed Erigaisi a crushing 2.5–0.5 defeat in the semifinals, as the Indian settled for a second bronze medal after finishing third in the Rapid event.Meanwhile, the two bronze medals are a remarkable achievement for the 22-year-old Erigaisi, who will return home stronger and more resolute from the experience.

# Arsenal end 2025 on top, Man United stumble against bottom-placed Wolves

**Premier League 2025-26: Arsenal delivered a commanding 4-1 win against Aston Villa to end 2025 at the top of the table. Meanwhile, Manchester United struggled to a 1-1 draw with bottom-placed Wolves on Tuesday night.**

Arsenal delivered a resounding message in the Premier League title race on Tuesday night, demolishing third-placed Aston Villa 4–1 at the Emirates Stadium to end 2025 firmly at the top of the table. The Gunners had trailed Villa in momentum—Villa came into the game on an 11-match winning run across competitions—but Arsenal’s performance turned heads and highlighted their title credentials.The scoring burst came after a tight first half: Gabriel Magalhes opened the scoring early in the second half with a well-

timed finish, before Martin Zubimendi doubled the lead minutes later, adding impetus to Arsenal’s charge. Leandro Trossard’s composed strike made it 3–0, and substitute Gabriel Jesus added a fourth just minutes after entering the pitch—a goal that underlined both Arsenal’s depth and attacking fluidity. Villa managed a late consolation through Ollie Watkins, but it was little more than a footnote to a dominant evening for the hosts.The significance of the win goes well beyond the scoreline. Arsenal extended their lead to five points at the summit, topping the Premier League as the calendar year closed—five points clear of second-placed Manchester City and six ahead of Villa. Crucially, this result came against one of the division’s most in-form sides, signaling not just consistency but the sort of performance that transforms title ambition into genuine momentum.For Villa, the loss halts their streak and sees them slip further behind a charging Arsenal, but Unai Emery’s side remain firmly in the hunt for a top-four finish. Still, the emphatic nature of Arsenal’s victory will likely resonate across the title race discussions over the winter

period.While Arsenal were celebrating, Manchester United endured another frustrating evening at Old Trafford, drawing 1–1 with bottom-placed Wolverhampton



Wanderers. What should have been a straightforward home victory instead quickly became a statistic United will want to forget, days after a 1-0 win over Newcastle.The result was particularly embarrassing given Wolves’ position; the Midlands side are at rock-bottom of the Premier League and had managed only a handful of points all season. That they could take a point from Old Trafford not only denied United valuable ground in the race for

Champions League qualification but also sparked discontent from supporters, with boos heard at full time.

United took the lead through Joshua Zirkzee, whose effort deflected in and gave the hosts the advantage shortly before the half-hour mark. But the positivity was short-lived: Ladislav Krejci headed Wolves level just before half-time, ending United’s hopes of a comfortable progress. In the second half, United dominated possession and saw a last-gasp effort ruled out for offside, but could not find a decisive breakthrough.

United manager Ruben Amorim did not sugar-coat his assessment of the draw. Post-match, he pinpointed the team’s lack of quality and fluidity in attack as key reasons they failed to put away a team struggling so massively on paper. Amorim highlighted the absence of key players—many away at the Africa Cup of Nations or sidelined through injury—as contributors to the disjointed display, but stressed that this should not be used as an excuse.That is normal, but we didn’t use that excuse against Newcastle. We are not going to use it today (Dec 30).

## Indian sports in 2025: Handshake rows, stampedes and controversies that shaped the year

Sports in India may have had many memorable highs, but it has also had their fair share of controversies. Isolated moments quickly escalated to a year that had many notable moments defined by public disputes, administrative lapses and moments that embarrassed India as a nation. From international fixtures clouded by political tensions to domestic events marred by chaos, sport repeatedly slipped out of control.These controversies were no mere social media scandals or fleeting cycles of outrage; they disrupted schedules, people’s careers and also raised uncomfortable questions on how sport is run in India, where there has always been passion, but planning or the administrative side of things tends to have fallen short.

This was the year when the noise around the game proved louder than the game itself. Let us take a look at some of the biggest sporting controversies in India for 2025.

### BREAKDOWN OF INDIAN FOOTBALL

Indian football’s biggest worry in 2025 wasn’t results on the pitch, but whether its

premier competition would survive at all. The future of the Indian Super League, long projected as the backbone of the sport’s professional structure, drifted into uncertainty after its commercial and ownership framework unravelled. With no



clear bidders, unresolved contracts and mounting financial strain, the league’s next season was left without firm timelines or guarantees.For clubs, the silence was crippling. Recruitment stalled, preseason planning froze, and players were left unsure if they would even have a competition to prepare for. Administrators offered reassurances, but clarity never followed. The instability also exposed how heavily

Indian football had come to rely on a single top-flight product, with little cushioning beneath it.As weeks passed without resolution, concern spread beyond boardrooms. Coaches warned of lost development time, fans feared regression, and the national ecosystem began to feel the strain. In 2025, Indian football wasn’t battling opponents — it was battling uncertainty over whether its top tier could stay upright at all.

### WOMEN’S WORLD CUP MARRED BY SAFETY CONCERNS

What should have been a routine day during a global tournament instead exposed an uncomfortable gap between hosting prestige and on-ground safety. During the Women’s World Cup in Indore, two members of the Australia women’s cricket team were subjected to harassment while walking near their hotel, an incident that jolted players, officials and organisers alike. The brief encounter, involving a man on a motorcycle, was enough to trigger an alarm within the visiting camp and force an immediate police response.

## Margins to mainstream: India women's cricket team wins Battle of the Sexes in 2025

For decades, India has fielded two senior national cricket teams—Men’s and Women’s. Yet, for much of that time, public attention, media coverage, and institutional support remained overwhelmingly skewed toward the men’s side. The women’s team, despite consistent performances and international success, was often relegated to the margins of public discourse.Rather than receiving the recognition they deserved, players from the women’s team were frequently subjected to dismissive commentary and online ridicule. Social media narratives questioning the relevance of women’s cricket—along with derogatory labels that trivialised their professionalism—became all too common, undermining both their achievements and credibility.The contrast in public reaction was stark. Landmark performances by male cricketers routinely sparked nationwide celebration, while equally impactful

contributions from leading women cricketers were met with comparatively muted acknowledgement. This imbalance highlighted a deeper issue: the women’s



team was not only competing on the field but also fighting for visibility and respect in a sport where they had long proven their excellence.For years, this disparity defined the narrative around Indian women’s cricket. However, 2025 has signalled a decisive turning point—a moment that

marks a profound shift in perception, recognition, and the broader cultural conversation surrounding the women’s game.But 2025 has marked a seismic shift.

This year, things changed. India Women’s Cricket has finally come into its own.2025 will go down as the year that transformed the fortunes of these incredible athletes. It’s the year when the players, who once faced endless mockery, could finally sleep with the quiet knowledge that their struggle had been worth it.The relentless effort, the tough journeys, and the battles—both on and off the field—have led them to a place where they can now proudly call themselves a force to be reckoned with.

2025 is the year when women’s cricket in India was no longer an afterthought. It’s the year the Indian women’s team could stand tall, heads held high, and with the word “respect” finally associated with their name.

# After World Cup snub, Shubman Gill to play Vijay Hazare Trophy in January: Report

India Test and ODI captain Shubman Gill, all-rounder Ravindra Jadeja and star batter KL Rahul are all set to play in the Vijay Hazare Trophy in January. The trio will join their respective teams ahead of the upcoming three-match ODI series against New Zealand, beginning on January 11.According to Cricbuzz, Shubman Gill is expected to feature in Punjab’s matches on January 3 and 6 against Sikkim and Goa in Jaipur. Punjab, grouped with powerhouse Mumbai in Group C, currently sit fourth with



two wins from three games. After playing two games, Gill will leave his state side to join the Indian team, which is set to assemble in Baroda on January 7-8 ahead of the first ODI against New Zealand.Ravindra Jadeja has also informed the Saurashtra Cricket

Association (SCA) that he will play the January 6 and 8 fixtures against Services and Gujarat. Saurashtra are playing their league matches in Alur, Karnataka, and currently have one win from three games, placing them sixth in the eight-team group.The

Karnataka State Cricket Association (KSCA) has not confirmed KL Rahul’s participation, but he’s likely to play in the January 3 and 6 games against Tripura and Rajasthan in Ahmedabad.

Karnataka are second in Group A, maintaining a 100% win record from three matches.Several big names have lit up the ongoing season of the Vijay Hazare Trophy, as star batters Rohit Sharma and Virat Kohli also fulfilled their mandatory domestic commitments set by the BCCI. Wicketkeeper batter Rishabh Pant is also consistently featuring for Delhi and will play the entire season for his team.Kohli will return to play for Delhi for their January 6 fixture against Railways under Pant’s captaincy. Opening batter Yashasvi Jaiswal also returned to play for Mumbai for their fourth fixture against Goa after being hospitalised with severe stomach cramps following Mumbai’s Syed Mushtaq Ali Trophy (SMAT) 2025 match against Rajasthan.

Sensex opens 227 points higher, Nifty above 26,000; Tata Steel up 3%

Benchmark stock market indices opened higher on the last trading day of 2025, as metal stocks rallied after India imposed a 3-year import tariff of 11–12% on select steel products, a move aimed largely at checking a surge in shipments from China.  
The S&P BSE Sensex was up 185.43 points to 84,860.51, while the NSE Nifty50 added 76.75 points to 26,015.60 as of 9:29 am.Dr. VK Vijayakumar, Chief Investment Strategist, Geojit Investments Limited, said that the market has the potential for a directional move upwards but is being weighed down by sustained FII selling and absence of fresh triggers like positive news on the US-India trade front."The coming days are going to be eventful, starting with the auto sales data for December, Q3 corporate results, expectations from the budget and other news relating to global economy like the possible Fed action in 2026," he added.Tata Steel led the gainers, rising 2.13%, followed by Titan Company, which was up 0.97%. Bharat Electronics gained 0.88%, Axis Bank moved higher by 0.76%, and Hindustan Unilever added 0.71%, supporting the index in early trade.  
Bajaj Finserv was the biggest laggard, falling 1.06%. Tata Consultancy Services slipped 0.51%, Bajaj Finance declined 0.45%, Tech Mahindra was down 0.45%, and Mahindra and Mahindra lost 0.40%.The Q3 results have to be watched carefully for indications of uptick in earnings. This is significant since there is lot of hope that there will be a rebound in earnings, going forward," said Vijaykumar.  
"Earnings growth will be the single most important factor determining the market trend in 2026. The FII flows in 2026, too, will depend on the earnings performance and expectations surrounding that," he added.

Retail rush and SIPs drive Rs 14 lakh crore jump in mutual fund assets in 2025

**New Delhi.(Agency)**  
Mutual fund industry extended its bull run in 2025, adding a staggering Rs 14 lakh crore to its asset base and pushing total AUM to a record Rs 81 lakh crore by November, powered by surge in retail participation and record SIP inflows.  
Venkat Chalasani, Chief Executive Officer of AMFI, told PTI that the industry's outlook remains positive, with steady SIP inflows continuing to offset foreign portfolio investor outflows and strengthening market resilience.Going ahead, fund flows are likely to be guided by valuations and global developments, with investors increasingly favouring large-cap, diversified and hybrid strategies, he added.  
The year 2025 also witnessed a robust net inflow of Rs 7 lakh crore, along with a sharp increase of 3.36 crore in the investor base, while SIPs alone contributed about Rs 3 lakh crore, according to data from Association of Mutual Funds in India (AMFI).  
These inflows lifted the industry's assets under management (AUM) by 21 per cent from Rs 67 lakh crore at the end of 2024 to Rs 81 lakh crore by November-end.While the pace of growth was lower than the 31 per cent rise recorded in 2024 and the 27 per cent increase in 2023, the longer-term trend remains strong. The industry had posted a 7 per cent growth in 2022 and nearly 22 per cent in 2021, and has collectively added Rs 50 lakh crore to its asset base over the last five years.

Long-term policy support key to meeting India's renewable energy goals, say experts

Long-term policy frameworks, particularly for hybrid renewables energy, along with a thrust on adoption of technologies and incentive-driven manufacturing, will help the country meet its renewable energy goals, experts said.Experts also believed decarbonisation will continue to be a priority for the industry.Sharing his views, Piyush Goyal, CEO and Co-founder of Volks Energie, said there are certain areas which are essential not only for meeting



climate commitments, but also for powering India's industrial growth, enhancing energy security, and ensuring affordable electricity for consumers.  
"Accelerating grid upgrades and storage adoption must be treated as national priorities as India's future energy mix depends on both. Further, incentivising domestic manufacturing of inverters, batteries, and critical components will reduce import dependencies and build supply-chain resilience," Goyal said.Manish Dabkara, CMD of carbon credits firm EKI Energy Services, said emerging technologies, including green hydrogen, advanced storage chemistries, and smart grid systems have the potential to address intermittency and ramping flexibility challenges."Stable, long-term policy frameworks particularly for hybrid renewables, offshore wind, and green hydrogen will be critical in attracting sustained private and global capital flows," he noted.Gaurav Modra, Partner and Energy Sector Leader, EY-Parthenon India, said that accelerating renewables, efficiency-led decarbonisation, and digital adoption are delivering measurable returns, while renewed momentum in nuclear energy point to a more integrated and commercially grounded phase of the energy transition.

Gold set for a 50-year best, silver breaks records: Where should money go in 2026

Gold and silver prices have cooled off in the last few days of 2025, but the bigger picture remains unchanged. Both metals are heading towards one of their strongest years on record as 2025 draws to a close.  
After months of sharp gains, some investors are locking in profits, leading to short-term weakness in gold and silver. Even so, prices remain far higher than where they began the year.Gold was trading near \$4,334 an ounce, down slightly from recent levels. The yellow metal had

touched a lifetime high of \$4,549 last week.US gold futures for February delivery were also lower at around \$4,346 an ounce. The fall came as the US dollar strengthened, which often puts pressure on gold prices because it becomes costlier for buyers using other currencies.  
**GOLD SET FOR BEST GAINS IN 50 YEARS**  
Gold has risen about 66% so far in 2025, putting it on course for its strongest yearly performance since the late 1970s. This rally has not been driven by one single factor. Instead, several global developments have come together.  
Lower interest rates in the US have made gold more attractive, as it does not pay interest. Expectations that rates will stay low for longer have also helped.Ongoing global conflicts, worries around government debt, and heavy buying by central banks have further supported prices. At the same time, investment demand through exchange-traded funds has picked up steadily through the year.  
Minutes from the US Federal Reserve's



December meeting showed that the decision to cut rates was not simple and involved long discussions on risks to the economy.The Fed's next meeting is scheduled for January 27 and 28, and markets expect no immediate change in rates. This environment continues to favour gold as a store of value.  
**SILVER OUTSHINES GOLD WITH RECORD-BREAKING GAINS**  
Silver has been the standout performer among precious metals in 2025. Prices fell to around \$74.41 an ounce in the latest session, after touching a record high of \$83.62 earlier in the week. Even after this


fall, silver has gained about 157% this year, far more than gold.  
This sharp rise has been driven by strong industrial demand and tight supply. Silver is now seen as a critical mineral in the US, which has lifted its importance.  
Demand from clean energy, electronics and electric vehicles has remained strong, while supplies have struggled to keep up. Low inventories have added to the pressure, pushing prices higher for much of the year.  
**PLATINUM AND PALLADIUM ALSO END STRONG YEAR**  
Other precious metals have also posted impressive gains in 2025. Platinum slipped to about \$2,123 an ounce after touching a lifetime high of \$2,478 earlier this week.Despite the recent fall, platinum is still up around 135% for the year. Its rise has been supported by tight supply, higher investor interest and policy changes in Europe related to combustion engines.  
Palladium was trading near \$1,584 an ounce, down on the day but still up roughly 74% for the year.

Hindustan copper share price tanks 3%: What's behind the fall

Copper prices have risen sharply this year due to supply disruptions at key global mines and strong demand from sectors such as electrification, renewable energy and artificial intelligence-led infrastructure.

Shares of Hindustan Copper fell nearly 3% in Tuesday's trade as investors chose to book profits after the stock's sharp rise in recent weeks.The fall came even as the broader outlook for copper remains strong, supported by global demand and supply challenges.  
Hindustan Copper was trading around Rs 515 in intraday trade after slipping as much as 3.3% during the session but recovered to trade at Rs 529.80 down 0.78% as of 10:20 am.Market

participants said the decline was largely driven by year-end profit booking and a mild correction in global copper prices, rather than any company-specific bad news.  
**WHY DID HINDUSTAN COPPER**



**SHARES FALL TODAY?**  
Copper prices eased by more than 1% as traders locked in gains at the end of the year. This had a direct impact on copper-linked stocks, including Hindustan Copper, which has been one of the biggest beneficiaries of the metal's rally in 2025.Copper prices have risen sharply this year due to supply disruptions at key global mines

and strong demand from sectors such as electrification, renewable energy and artificial intelligence-led infrastructure.However, after such a strong run, some cooling off was expected in the short term.  
Experts tracking the stock said the recent fall looks like a pause rather than a trend reversal, especially given the scale of gains already seen.Despite today's fall, Hindustan Copper has delivered very strong returns across time frames. The stock has gained more than 26% in the last five trading sessions. Over the past one month, it is up around 56%.  
Looking at a longer period, the share price has jumped nearly 89.49% in the last six months. On a yearly basis, the stock has risen about 113.71%, making it one of the top performers among metal stocks.This sharp rise is one of the key reasons why investors may be choosing to lock in profits, especially as the calendar year comes to an end.

From Reliance Jio, PhonePe to Zepto: 5 key IPOs to watch in 2026

After a strong run in 2025, India's primary market is entering 2026 with high expectations. Several large and well-known companies are preparing to tap the stock market, and 2026 is shaping up to be an exciting year for investors. Many of these firms have been waiting for the right market conditions, and the current mood appears favourable.From digital giants to new-age startups, the upcoming IPO list reflects growing confidence among Indian companies and sustained interest from investors.Reliance Jio Platforms is expected to be the biggest attraction in the 2026 IPO calendar. Valued at around Rs 11–12 lakh crore, its public listing could be one of the largest ever seen on Dalal Street. The telecom and digital services major is reportedly preparing its draft papers and may look to launch the IPO in the first half of the year, subject to approvals.A Jio listing is likely to draw

strong interest from both domestic and global investors, given its dominant position in telecom and its expanding digital ecosystem.  
**Flipkart**  
Flipkart, backed by US retail giant Walmart, is also expected to enter the public markets in 2026. Reports suggest the e-commerce firm is aiming for a valuation in the range of \$60 billion to \$70 billion. This would place it among the biggest technology IPOs in India.In preparation for the listing, the Flipkart Group has narrowed its losses in the 2024–25 financial year, signalling a stronger focus on profitability and operational efficiency.  
**OYO**  
Hospitality platform OYO has taken another step towards going public. Shareholders of its parent company have approved plans to raise up to Rs 6,650 crore through a fresh issue of equity shares as part of the proposed

IPO.While the exact launch date is yet to be announced, the listing will depend on regulatory clearance from Sebi and overall market conditions. Investors will be closely watching how OYO positions its business ahead of the offering.  
**PhonePe**  
Digital payments firm PhonePe is also preparing for an IPO in 2026. The company is expected to raise around \$1.2 billion to \$1.5 billion through a mix of fresh shares and an offer for sale by existing investors.Reports indicate that PhonePe could be valued at close to \$15 billion at the time of listing. With its strong presence in India's digital payments space, the IPO is likely to attract wide attention.  
**Zepto**  
Bengaluru-based quick commerce startup Zepto is another name to watch. Known for its 10-minute grocery delivery service.

How India overtook China to become the world's top rice producer

India has emerged as the world's largest rice producer, but closing the yield gap and managing water stress will decide whether this production surge becomes a lasting advantage.

India has shattered China's dominance that had continued for years in the field of rice. By overtaking China, India has reached number one in the world in terms of rice production.The country's share in total global rice production has crossed more than 28%. The United States Department of Agriculture (USDA) has also acknowledged India's achievement.  
In its December 2025 report, the USDA said India's rice production has reached 152 million metric tonnes, while China's output stands at 146 million metric tonnes.This record will require a revision of long-held assumptions that China is the world's largest rice-producing country.

An interesting aspect of India's success is the significant contribution made by Taiwan. Relations between China and Taiwan remain extremely tense.  
Rice has been grown and consumed in India since ancient times. Whenever the origin of rice is discussed, India's name is often mentioned first. There are about 123,000 varieties of rice in the world, of which nearly 60,000 are found in India. This highlights India's richness in rice diversity. However, in terms of production, India had lagged far behind China for a long time.This is the first time India has overtaken China in rice production.Dr Sudhanshu Singh, Director of the South Asia Regional Centre at the International Rice Institute, says that India's emergence as the world's largest rice producer is a major achievement. Indian rice is exported to 172 countries, and rice has also become an important tool of India's foreign policy.  
**EARNINGS FROM RICE**  
In 2024–25, India exported agricultural produce worth a record Rs 450,840 crore, with rice accounting for the largest share of about 24%.

By exporting basmati and non-basmati rice, India earned foreign exchange worth Rs 105,720 crore in a single year.This underlines the importance of rice to the Indian economy.  
**TAIWAN'S CONTRIBUTION**  
At the time of Independence, India produced only 20.58 million metric



tonnes of rice annually. By 2025, this figure had risen to 152 million metric tonnes.This record in rice production is undoubtedly the result of the hard work of farmers and scientists. However, Taiwan also played a significant role in India's success in rice cultivation, which merits special mention.In the 1960s, India was struggling with a shortage of food grains.

At the time, cultivation was limited to traditional long-stem rice varieties, with yields of only about 800 kg per hectare.  
By then, urea had been introduced as a chemical fertiliser. While the use of fertiliser and additional water could increase output, this required dwarf and strong-stem varieties, which India did not have.Indian varieties tended to lodge when fertiliser and water were used, as their long stems caused the crop to fall over. This led to the need for dwarf varieties to increase production and address food shortages.  
Taiwan stepped in to meet this requirement by providing its dwarf rice variety, Taichung Native-1 (TN1). This transformed Indian agriculture. Taichung Native-1 played a key role in the Green Revolution and is considered the world's first semi-dwarf rice variety.  
**IR-8 CHANGED THE WORLD**  
Another dwarf rice variety, IR-8, was introduced in India in 1968 by the International Rice Research Institute. This triggered a rapid increase in production. Because of its revolutionary productivity, IR-8 came to be known as "Miracle Rice".
