

Anti-reform mindset: PM Modi blasts Congress for derailing women's quota bill

PM Modi's attack on the Congress came a day after a Constitutional Amendment to implement 33 per cent reservation for women in the Lok Sabha and state Assemblies failed to pass in the lower House of the Parliament. While the Bill required the support of at least 352 out of the 528 MPs present in the Lok Sabha, it could only garner 298 votes in its favour.

Prime Minister Narendra Modi on Saturday targeted the Congress for its "anti-reform" mindset, blaming the party for defeating the Women's Reservation Bill in the Lok Sabha. In his address to the nation, PM Modi alleged that the Congress has long opposed women's reservation in Parliament and state legislatures and has consistently sought to obstruct it. "By opposing the reservation of seats for women, the Congress has once again conclusively demonstrated that it is an anti-reform party. The anti-reformist stance adopted by the Congress has consistently inflicted immense damage upon the nation," he alleged. PM Modi's attack on the Congress came a day after a Constitutional Amendment to implement 33 per cent reservation for women in the Lok Sabha and state Assemblies failed to pass in the lower House of the Parliament.



While the Bill required the support of at least 352 out of the 528 MPs present in the Lok Sabha, it could only garner 298 votes in its favour.

He accused the Congress of using "falsehoods" to block the bill, adding that the party had missed a historic opportunity to support the measure and correct its past mistakes. Comparing the party to a parasite, PM Modi accused the Congress of surviving on the support of regional parties and alleged that it orchestrated opposition to the bill to undermine them. "The Congress itself has already lost its very existence in the majority of the country's states. However, it does not wish to see regional parties grow.

Hence, it hatched a political conspiracy to plunge the future of numerous regional parties into darkness," he said.

The Prime Minister also accused the party of spreading misinformation on delimitation and criticised it for pursuing "divide and rule" politics. "The Congress has learnt the politics of divide and rule from the British. It has always fanned sentiments that create divisions within the country," he said.

'Unfortunate': Mamata accuses PM Modi of misleading nation on women's reservation Bill

West Bengal chief minister Mamata Banerjee on Sunday slammed PM Narendra Modi, stating that it was "deeply unfortunate" that he had chosen to "mislead the nation" over the women's reservation Bill.

In a post on X, the West Bengal Chief Minister also alleged that the Centre was attempting to push forward the delimitation exercise by "using women as a shield". "It is deeply unfortunate that the Prime Minister chose to mislead the nation rather than address it honestly," Banerjee said.

Her remarks came a day after the Prime Minister, in an address to the nation following the defeat of a Bill proposing 33% reservation for women in legislatures from 2029 in the Lok Sabha, accused the Congress and its allies of committing a "sin of foeticide" and warned that women voters would punish them.



Banerjee asserted that the Trinamool Congress (TMC) has consistently supported greater political representation for women. "We have the highest proportion of female elected representatives in both Parliament and the state legislature. In the Lok Sabha, 37.9 per cent of TMC's elected members are women," she said, adding that the party has nominated 46% women members in the Rajya Sabha.

She emphasised that there was no question of opposing women's reservation. "What we are fundamentally opposed to is the delimitation exercise that the Modi government was plotting to push through by using women as a shield for its vested political.

Women's reservation law: BJP hits back at Oppn, says 'hypocrisy exposed'

Senior BJP leaders Ravi Shankar Prasad and Smriti Irani on Saturday clapped back at Priyanka Gandhi Vadra and the Congress, terming the Opposition's stance a "hypocrisy exposed" on the issue of women's empowerment.

Their comments came during a press conference, a day after a Constitution Amendment Bill, aimed at enabling reservation for women in legislatures from 2029 and increasing the strength of the Lok Sabha, failed to get passed in the Lower House after it did not meet the required majority of 2/3.

Shortly after Priyanka's media briefing, the BJP intensified its criticism, accusing the Congress of "betraying" women and then celebrating the defeat of their political aspirations. Ravi Shankar Prasad asked the Congress to first understand constitutional provisions before making statements.

"Congress needs to understand the Constitution. No revision in the number of seats in Parliament or Assemblies can be done or is possible without delimitation," he said. Taking a swipe at Priyanka Gandhi, Prasad added, "I don't say anything against her (Priyanka Gandhi), but this is the first time I am doing so.

3 days before election, Chandrababu Naidu set for whirlwind campaign across Tamil Nadu

A day after strongly criticising Opposition parties for opposing the Constitution (131st Amendment) Bill — aimed at fresh delimitation, increasing seats in Lok Sabha, and 33% reservation for women in Lok Sabha and state Assemblies — Andhra Pradesh Chief Minister N Chandrababu Naidu is all set to undertake a two-day campaign tour across Tamil Nadu on April 20 and 21 as part of the National Democratic Alliance (NDA)'s intensified outreach in the state ahead of Assembly elections.

The visit is aimed at energising cadre, strengthening voter connect, and reinforcing the NDA's development-driven narrative, a statement from Naidu's office said. The Assembly election in Tamil Nadu will be held on April 23.

Naidu will begin his tour in Coimbatore, where he is scheduled to address a major public meeting in the afternoon. He will then travel to Hosur and proceed to Thalli for a public rally later in the day. In the evening, Naidu will reach Chennai and participate in a large roadshow in Avadi, engaging directly with citizens and NDA supporters. On the second day, the Chief Minister will travel to Madurai and proceed to Sattur, where he will interact with community leaders and take part in a key campaign event later in the afternoon.

Strait of Hormuz crisis shifted global shipping to Vizhinjam Port in Kerala, says Shashi Tharoor

Congress leader Shashi Tharoor who is an MP from Kerala's Thiruvananthapuram, highlighted how the Vizhinjam Port in the city was handling large vessels, with having already handled 66 ships in the month of March. Vizhinjam is officially India's transshipment answer to the world, said Tharoor.

Congress MP Shashi Tharoor highlighted that amidst the ongoing tensions in the Strait of Hormuz, there could be a window of opportunity for an Indian port. This port is none other than the Vizhinjam Port in Kerala's capital Thiruvananthapuram. Taking to social media platform, 'X', the Congress leader pointed towards the surge in vessels waiting to dock there.

Global shipping eyes shifted to my constituency: Tharoor

Congress leader Tharoor took to social media platform, 'X' and wrote, "The Strait of Hormuz crisis has shifted global shipping eyes to my constituency! Thiruvananthapuram's Vizhinjam Port is currently seeing a massive



surge with 100 vessels in queue or seeking calls."

He also said that Vizhinjam is officially India's transshipment answer to the world. He highlighted how the port in his constituency handled its 1 millionth TEU in record time to

fast-tracking Phase II. He said that when he helped get the tender for this port, this achievement was a long shot project. He said that he also faced a lot of criticism and skepticism regarding this ambitious project.

He said, as of today times have changed for the Vizhinjam Port. With the ongoing tensions in the Strait of Hormuz, the world is looking for a new, reliable gateway and this port is answering their call, he added.

He called it not just a project, but a global necessity. The port reportedly handled 66 vessels in March 2026, setting a new record. More than 100 berthing calls are currently pending at this port. The Congress leader said that efforts were underway and expansions were being made to accommodate 5 motherships simultaneously.

'Modi ji mentioned Congress 59 times, women barely few times': Kharge slams PM's speech

Congress president Mallikarjun Kharge on Saturday accused Prime Minister Narendra Modi of turning an official address to the nation into a "political speech" marked by "mudslinging" and "outright lies", following the defeat of the Constitution (131st Amendment) Bill, 2026, in the Lok Sabha.

The Prime Minister's remarks came hours after the proposed legislation, which sought to expand the Lok Sabha from 543 to 850 seats to enable 33% reservation for women by the 2029 elections, failed to secure the required two-thirds majority. While 298 members voted in favour, 230 Opposition MPs voted against the bill. In a post on X, Kharge said:



"A desperate and frustrated PM [Narendra Modi] with nothing meaningful to show for the last 12 years, turned an official address to the nation into a political speech, full of mudslinging, and outright LIES." Alleging a violation of electoral norms, he said the Prime Minister had misused official machinery ahead of Assembly elections in two States.

"The Model Code of Conduct is already in place and it was very clear how PM Modi misused official machinery to attack his opponents. This is a travesty of Democracy and the Constitution of India," he added.

The bill was linked to the implementation of the Women's Reservation Act, passed in 2023, and required delimitation and census-related processes before coming into effect.

D K Shivakumar on Sunday slammed the BJP-led Centre over the timing and handling of the Women's Reservation Amendment Bill, alleging that the opposition was not taken into confidence.

The Karnataka Deputy Chief Minister reiterated that while the Congress has consistently supported women's reservation, it objected to the way the Bill was introduced without adequate consultation. "This is democracy; this is not a Hitler-style rule. They cannot bring it in the middle of elections and try to alter the entire constituencies," Shivakumar told reporters.

Calling for broader democratic engagement, he said, "They have to take everyone into confidence, but they have not done that. That is



why the opposition parties have done a very good job. So, it is a victory of the INDIA alliance." The remarks come after the Constitution (131st Amendment) Bill, which proposed 33 per cent reservation for women in legislatures from 2029 and an increase in Lok Sabha seats from 543 to 816, was defeated in the Lok Sabha. The Bill secured 298 votes in favour and 230 against, falling short of the required two-thirds majority. The proposal aimed to operationalise women's reservation following a delimitation exercise based on the 2011 Census, including expansion of seats in state and Union Territory assemblies. Responding to criticism from the Bharatiya Janata Party that Congress is anti-

women, Shivakumar said, "This is not anyone's personal property—women are the nation's asset. We had passed this in the Rajya Sabha and Congress has already given 50 per cent reservation to women in local bodies. Even today, we support it."

India bloc for quick rollout of the 2023 Act

Top leaders of the alliance agreed that each constituent party would independently push for the implementation of the Act, while also continuing to raise the issue in public to hold the BJP accountable.

A day after the historic defeat of amendments to the women's quota bill in Parliament, the opposition INDIA bloc decided to push for the immediate rollout of the Women's Reservation Act, 2023, within the existing framework of the 543-member Lok Sabha, while also seeking to counter the BJP's narrative to portray the Opposition in a negative light.

At a meeting chaired by the Leader of Opposition in the Rajya Sabha, Mallikarjun Kharge, on Saturday, top leaders of the alliance agreed that each constituent party would independently push for the implementation of the Act, while also continuing to raise the issue in public to hold the BJP accountable.

The meeting was also attended by CPP leader Sonia Gandhi, NCP (SP)'s Supriya Sule, Shiv Sena (UBT)'s Sanjay Raut, CPI(M)'s John Brittas, and CPI's P Sandosh Kumar, among others.

It was decided that parties in the INDIA bloc will hold press conferences across the country and stress that they support women's reservation, adding Parliament had already passed the bill in 2023. By introducing three new bills, they said the government was trying to change the political map of the country under its guise.

At a press conference after the meeting, Congress general secretary Priyanka Gandhi underlined that the Opposition was not against reservation for women and would support the Women's Reservation Act, 2023, if the government sought to implement it on the current strength of the Lok Sabha.

Speaking to this paper, Congress MP Manickam Tagore said Prime Minister Narendra Modi has to clarify when the government will implement the Act.

2 die in hit & run, one on way home, another out for a walk after dinner

Gurgaon.(Agency)

Two men died in separate hit-and-run accidents late on Thursday night and early Friday — one while riding home from work on Delhi-Gurgaon Expressway, the other while out for a walk in Palam Vihar. In both cases, the vehicles that struck them fled, leaving police to piece together the final moments and trace the drivers.

The first victim, Amit Kumar (37) of Rajasthan, was hit by a vehicle on NH-8 near Murali Wala Dhaba in Bilaspur. Kumar, who worked for a private company in Manesar, was returning home on his Hero Splendor when an unidentified vehicle hit his motorcycle.

According to a complaint filed by his younger brother, Hitesh Kumar, the impact threw Amit onto the road, causing fatal injuries. Police said they received information about the crash around Friday midnight and reached the spot soon after. He was taken to General Hospital, where doctors declared him dead on arrival. His body was later handed over to the family after an autopsy. "We are trying to trace the vehicle involved in the accident using technical inputs and local intelligence," said Rajesh, the investigating officer. A case was registered under sections 281 and 106 of BNS for rash driving and causing death by negligence.

In the second case, Arpit Singh (32) of Agra died in a late-night hit-and-run in Palam Vihar. Singh, who worked with a private company and lived in the area on rent, had stepped out for a walk after dinner around 12.15am on April 16, according to a complaint filed by his elder brother, Amit Singh. Police said Arpit was walking from Krishna Chowk towards the C-2 gate in Palam Vihar when an unidentified vehicle hit him from behind. The force of the collision flung him to the roadside, leaving him fatally injured. A passerby took him to Civil Hospital in Sector 10, where doctors declared him brought dead. His body was kept in the mortuary, and his brother identified him on Friday. Police have registered a case under sections 281 and 106 of the BNS against an unknown driver.

Rain relief over, temperature set to rise again this week

After a brief spell of light rainfall on Friday evening, the city is set to get warmer again as IMD has forecast a rise of 3-5 degrees Celsius in maximum temperatures during the next 5-6 days. On Saturday, the minimum temperature dipped to 19.9 degrees Celsius, down from 22.4 degrees Celsius recorded a day earlier at the Gurgaon KVK observatory. At The NorthCap University weather station, the minimum settled at 20.8 degrees Celsius, compared to 24.3 degrees Celsius on Friday. The maximum temperature, too, saw a slight dip. At the Gurgaon KVK observatory, it was recorded at 38.3 degrees Celsius, down from 39.1 degrees Celsius a day earlier. At The NorthCap University, the maximum stood at 40.1 degrees Celsius, compared to 40.8 degrees Celsius previously. According to IMD, a western



disturbance is circulating over north Pakistan and adjoining areas in the lower tropospheric levels. In addition, upper air cyclonic circulations persist over central Rajasthan and over Haryana and neighbouring regions. However, these systems are currently weak and are not expected to trigger any rainfall activity. With no active weather system impacting the region, dry conditions are set to dominate. According to IMD, daytime temperatures are expected to hover between 41 degrees Celsius and 44 degrees Celsius over the next few days, while minimum temperatures may range between 24 degrees Celsius and 26 degrees Celsius.

Noida DM wants medical camps, mobile vans in industrial areas

The district administration on Saturday directed private hospitals to organise regular medical camps in industrial areas to improve healthcare access for workers, and asked officials to submit a plan to empanel more hospitals under the Ayushman Bharat scheme.

At a meeting with chief medical officer Dr Narendra Kumar and Government Institute of Medical Sciences (GIMS) director Dr Rakesh Gupta, district magistrate Medha Roopam said providing quality healthcare to workers was a shared responsibility.

"We have urged all private hospitals to utilise their CSR funds to organise regular medical camps in industrial areas. Special facilities shall be ensured for women workers at these camps," she said. Hospitals were directed to ensure camps include OPD services and screening for serious illnesses such as breast and cervical cancer. They were also asked to deploy mobile medical vans in industrial clusters, conduct eye examinations, distribute spectacles to those in need, and facilitate treatment for conditions such as cataract.

The DM stressed the need to extend health check-up camps and mobile medical services to construction sites, and asked all private hospitals to prepare detailed micro-plans in coordination with the health department and appoint nodal officers. "Their details are to be shared for effective implementation," she said.

Health department officials were also directed to ensure adequate availability of doctors, medicines and equipment at district hospitals, community health centres, primary health centres and GIMS.

Dr DK Gupta, chairman of Felix Hospital in Sector 137, said the hospital regularly conducted health camps across the city and would deploy mobile vans in industrial areas. "This will not only provide basic check-ups but also promote early diagnosis, preventive care and health awareness," he said.

Exports down due to war, industries seek review of 35% wage hike

Industrialists from across the state urged the govt to review the recent 35% increase in minimum wages, calling it impractical amid current economic pressures. At a meeting in Udyog Vihar, participants said industries, especially MSMEs, were already under strain due to the ongoing West Asia conflict, which has hurt exports. They resolved to submit memorandums to the chief minister next week, seeking a phased implementation of the hike instead of a one-time increase of 35%. A parallel meeting organised by Confederation of Haryana Industries Association (CHIA) echoed similar concerns, with leaders calling for a balanced approach.

"The govt's objective of safeguarding workers' interests is commendable. However, the current condition of industries cannot be overlooked. A sudden hike will severely impact the MSME sector in particular. If the govt



implements the wage increase in a phased manner, it will help maintain a balance between the interests of workers and industries," said Progressive Federation of Trade and Industry (PFTI) chairman Deepak Maini.

The industry body demanded reconsideration of the recent lump-sum increase of Rs 4,000 in minimum wages, with participants unanimously stating that such a sudden hike is impractical and could have serious repercussions on the

industrial sector under the current economic conditions. They highlighted that exporters, already under pressure, expect support from the govt rather than the imposition of additional financial burdens. RL Sharma, director general of PFTI and a senior advocate, reiterated that industrialists do not oppose an increase in minimum wages. "But implementation should be carried out in a phased manner to avoid sudden financial strain on industries," he said.

The CHIA meeting in Udyog Vihar was attended by around two dozen industrial associations from NCR. The meeting was chaired by Chamber of Industries president Ashok Kohli.

The wage debate comes against a backdrop of simmering worker unrest in Haryana and elsewhere. Manesar and Noida have witnessed repeated flashpoints between labour and management, with workers protesting stalled wage negotiations, contract work conditions and delayed disbursements.

All done except revised wages: Minister on 18-month waste tender delay in Gurgaon

More than 18 months after the city's door-to-door waste collection system fell into uncertainty, the Haryana govt is yet to hire an agency for the job. When asked about the delays and tender revisions, Haryana Urban Local Bodies (ULB) minister Vipul Goel said the tender is currently under process. When TOI asked about the long timeline, over one-and-a-half years, and multiple rewrites of the Request for Proposal (RFP), the minister attributed the hold-up to recent wage hikes.

"The wages have increased, which need to be incorporated. The Haryana govt has increased these in the budget and implemented them. So naturally, they will be included in this tender," he said, maintaining that apart from incorporating revised wages, everything else in the door-to-door collection plan was in order. TOI reported on April 9 that the



MCG was forced to scrap its ongoing bidding process for the Rs 315.2-crore project after the ULB department revised the RFP for the sixth time. Each revision has changed key aspects of the tender, including eligibility criteria and financial structures, which has put the process back at the start. The civic body is now

preparing yet another revised cost estimate before fresh tenders can be floated, further delaying implementation of a unified waste collection system. "We have prepared an estimate of around Rs 700 crore for the city's door-to-door waste collection for five years. The cost has escalated because of the increase in number of vehicles to around 700 vehicles. We will send it to the ULB by the end of day," said MCG commissioner Pradeep Dahiya. The continued delay has left the city dependent on temporary and often unreliable waste collection arrangements since the termination of its previous contractor in June 2024.

With no clear timeline, the gap between policy assurances and on-ground reality continues to widen, leaving residents to grapple with the consequences of a system that remains stuck in perpetual revision.

Gurgaon court orders FIR against ex-minister for grant fraud

A local court has directed the police to register an FIR against former minister Sukhbir Kataria and others for alleged misuse of govt grants by diverting benefits to ineligible persons. The petition filed last year by a Gurgaon resident, Om Parkash, claimed that Kataria abused his ministerial position between 2014 and 2019 to secure a Rs 20 lakh govt grant for a female acquaintance allegedly residing in his own building. The grant was intended for the construction and repair of houses for the economically weaker sections. Parkash alleged police delay in acting on the matter, prompting him to approach the court. Observing that the evidence indicated possible misuse of public funds for personal and electoral benefit, chief judicial magistrate Rajat Verma on Friday asked SHO of New Colony police station to register a case under IPC sections 403 (dishonest misappropriation of property), 405 (criminal breach of trust), 409 (criminal breach of trust by public servants), 420 (cheating) and provisions of the Prevention of Corruption Act against Kataria. The complainant alleged that former minister Sukhbir Kataria misused his official position to facilitate illegal grant of funds to individuals like Sharmila Devi and others, by falsely showing them as residents of a property that allegedly belonged to him. According to the complainant, the grants were purportedly diverted to secure "fake votes." The police, in their action taken report, confirmed that grants had been provided at the request of the former minister. However, it stated that clarification regarding the legitimacy of the grant and the residential details of the beneficiaries could only be provided by the concerned department and the deputy commissioner's office. Appearing in person, Parkash argued that the electricity bill submitted by the beneficiaries for verification bore the address of a house owned by the minister himself.

Teen skips Class 12 boards, NEET to donate liver to grandmother

When his friends were busy with last-minute revisions, 19-year-old Aditya Raj made a choice few at his age would be asked to. The Class 12 student from Bihar's Hajipur put his boards — and even his first shot at NEET on hold to save his grandmother's life, donating a part of his liver when her condition turned critical. Sunita Devi (62) had been battling liver cirrhosis for more than a year. The illness had led to repeated hospitalisations, fluid build-up in the abdomen and growing weakness. When her health worsened, the family brought her to NCR — Max Hospital in Vaishali — where doctors found she was in an advanced stage of cirrhosis. A transplant, they said, was the only definitive treatment. And that couldn't wait. Doctors told the family Aditya's grandmother would die if the transplant wasn't done at the earliest.

The family did have other possible donors.

Aditya's father and aunt were both found compatible, but existing health conditions ruled them out. That left the teenager to volunteer to donate a part of his liver. But the timing of the surgery was crucial. It clashed with the CBSE Class 12 boards — Feb 17 to March 27. Since the surgery couldn't wait, Aditya decided to skip the boards this year. And NEET too. After detailed medical, psychological and legal assessments at Max hospital, Aditya was cleared for surgery under national transplant protocols, becoming the family's first living donor. The date of the transplant was fixed for March 12.

"I was fully prepared for my Class 12 exams, but that wasn't more important than my family. Exams can be taken again next year. So, I decided to skip them and do my bit to save my grandmother," the teenager told TOI. Aditya, who wants to become a doctor himself, said he planned to make his first attempt at NEET this year. "That, too, will happen next year," he

added.

Dr Subhash Gupta, group chairman at the Centre for Liver and Biliary Sciences at Max Healthcare, said the case was both emotionally moving and medically demanding. "What stood out was the young donor's determination despite his academic commitments.

Careful matching of the donor and recipient, meticulous preparations for the surgery and strict adherence to transplant protocols were essential to ensure a safe and successful transplant," Dr Gupta said.

Dr Rajesh Dey, director of liver transplant and biliary sciences at Max, said the procedure involved a right lobe graft weighing about 710 grams and was carried out for almost 10 hours. "Living donor liver transplantation is a complex surgery in which a portion of a healthy donor's liver is transplanted into the recipient.

Because the liver can regenerate, both donor and recipient livers gradually return to

Engineer accused of 'inciting' Noida protesters held at TN station

The Special Task Force and a police team from Noida arrested Aditya Anand, described as "mastermind" behind the April 13 labour protest violence in the city, from Tiruchirappalli railway station in Tamil Nadu on Saturday.

Anand was tracked through electronic surveillance and intelligence inputs, and a reward of Rs 1 lakh was announced for his capture. Police claimed Anand played a central role in orchestrating the violence that erupted during the workers' protest, which initially began as a demonstration over labour-related grievances. There was large-scale vandalism in the city's industry hubs on April 13 after violence broke out. Investigators alleged Anand and his associates planned to incite unrest and escalate the protest into a violent confrontation. Originally from Hazaribagh in Jharkhand, Anand holds a BTech degree from NIT Jamshedpur and was placed as a software engineer at a private company in Noida through campus recruitment. He lived in Gurgaon for work before shifting back to Noida in June 2025 and was residing in rented accommodation in Sector 37 at the time of the protest, sources said. Police said Anand first came into contact with



Mazdoor Bigul, a labour-focused organisation led by Anubhav Sinha, on Facebook in 2022 and subsequently began reporting on factory workers' conditions in the city. He met co-accused Rupesh Roy — arrested on April 11 along with Manisha Chauhan as alleged conspirators — during the Bhagat Singh Jan Adhikar Yatra in 2023, an initiative organised by Mazdoor Bigul.

Over time, Anand deepened his association with the organisation's senior leadership and participated in agitations across the country, police said. Police also link

Anand with Disha Student Organisation, RWPI and Naujawan Bharat Sabha.

Multiple police teams from Noida and the STF were deployed across several states to track Anand after investigators initially suspected he may have fled to Delhi. Officials said his questioning is expected to shed light on others involved.

Anand will be brought to Noida on transit remand, police said. A non-bailable warrant was earlier issued against him by a local court, and a case was registered at Noida Phase 2 police station under BNS sections 191(1) and (2) (rioting), 115(2)

(voluntarily causing hurt), 121(1) and (2) (voluntarily causing hurt or grievous hurt to deter public servant from his duty), 351(3) (criminal intimidation), 352 (intentional insult with intent).

Illegal properties of 9 criminals razed in Gurugram

Gurugram: 1-JCB demolishing shops built on government land occupied by criminal Ricky in Sector-37. 2-Illegal shops and tin sheds of liquor sellers located in sector 5 area were razed. Continuing its crackdown on criminals, the Gurugram police demolished illegal properties belonging to 9 criminals, including a gangster, on Tuesday. An illegal mar-

ket, 'Ricky Ki Mandi', built by gangster Ricky on government land in Khandsa village was demolished. Ricky is a repeat criminal offender who has been jailed in a case registered at the Sector-50 police station. He had illegally occupied HSIIDC land and built approximately 100 temporary shops and 10 permanent shops on it. He was collecting roughly Rs 6 lakhs from the shops per

month, said a police official. "These illegal shops were demolished by a joint team of police and enforcement led by Inspector Manjeet, SHO, Sector-37 police station, with the assistance of 80 police personnel. A total of 31 cases have been registered against gangster Ricky, 2 in Rewari and 29 in Gurugram. Gurugram police has prepared a profile of criminals who have acquired property illegally and immorally through criminal activities. Properties of all such criminals will be demolished", said a Gurugram police spokesperson. The police also demolished liquor stores and tin sheds of eight criminals. All were built on government land in Sector-5. Of the eight accused, seven were identified as Mohit, Naveen, Izhar, Rahul, Deepak, Prashant and Rahul, all of whom were residents of 12 Biswa

Gurgaon village and were repeat offenders for selling illegal liquor with multiple cases registered against them under the Excise Act. The eighth accused was Manjeet

Singh Saini, resident of 8 Biswa Gurgaon village with a total of 17 cases registered against him. "Such strict action against criminals and illegal encroachers will continue

to be taken in the future and those who play loose with law and order will not be spared under any circumstances", said a senior police officer.

Man held with 458 kg of banned firecrackers

Gurugram: Over 458 kg of banned firecrackers were seized and a man arrested following a police raid in the Jaikampura area of Gurugram. The arrested accused was identified as Harsh Arora, a resident of Jaikampura, Gurugram. According to the police, a total of 485 kg and 180 g of banned firecrackers were recovered from his possession. A case has been registered under relevant sections of the Explosives Act at City Police Station. "During police interrogation, it was revealed that the accused had brought the fireworks from Delhi with the intention of selling them. He had stored them in the basement of his rented house in Jaikampura. A further probe is underway," said a spokesperson for Gurugram Police.

India develops indigenous handheld device to detect traumatic brain injuries

New Delhi: Traumatic brain injuries (TBIs) are a significant public health challenge, particularly in emergency settings, rural areas, and underserved populations where advanced diagnostic tools like CT or MRI scans are inaccessible or delayed. India has now developed a handheld device, Cerebo, to detect TBI, and it has received approval from the Drugs Controller General of India (DCGI). Developed through a collaboration between the Indian Council of Medical Research- Medical Device and Diagnostics Mission Secretariat, AIIMS Bhopal, NIMHANS Bengaluru, and Bioscan Research (ICMR-MDMS), a handheld device called CEREBO has been developed to detect brain injuries. "We use CT scans to detect brain injuries. This device is an easy alternative to check for bleeding in the brain. It has received approval from DCGI," ICMR Director General Dr Rajiv Bahl said. Globally, TBI affects 69 million people, and more than 8 million are misdiagnosed. In its annual report, ICMR has explained the efficiency of Cerebo over traditional methods, such as the Glasgow Coma Scale and imaging techniques, which require specialised infrastructure, trained personnel, and are cost-intensive. The Glasgow Coma Scale is a neurological scale used to assess a person's level of consciousness after a traumatic brain injury or other acute medical conditions. "To address this issue, Cerebo—a portable, non-invasive brain injury diagnostic tool—has been developed using advanced near-infrared spectroscopy technology powered by machine learning. Capable of detecting intracranial bleeding and edema within a minute, Cerebo provides color-coded, radiation-free, and cost-effective results. Designed for deployment in ambulances, trauma centers, rural clinics, and disaster response units, it enhances early TBI detection and patient outcomes," ICMR said. ICMR said that the device underwent clinical validation, regulatory approvals, and feasibility studies, paving the way for global adoption in emergency and military healthcare systems. Published in the health journal Neurology India, the researchers mentioned that while Cerebo is not intended to replace CT scans, it may be beneficial in instances where CT scans are unavailable to study deep tissues non-invasively and bring hospital-grade diagnosis to the point of care. "This is especially relevant because nearly half of patients with a head injury who get CT scans within 2 hours after damage, especially those with cerebral contusions, are suspected to have early progressive bleeding," said the study aimed at assessing the device.

Over 21,000 challans in 7 days, in Gurugram

Gurugram: The Gurugram traffic police issued 21,901 challans to commuters for flouting traffic rules like wrong side driving, driving without seat belt, riding without helmets, drunk driving etc. The traffic police issued these challans only in a week from January 4 to 11, with fines amounting to over Rs 1.78 crores. It includes 13,331 challans issued on the ground. According to traffic police data, 1,907 challans were issued for driving on the wrong side, 829 for road marking violations, 781 for pillion riders without helmets, 1,013 for driving without seat belts, 750 for driving without helmets, 299 for drunk driving, 1148 for wrong parking and 356 for dangerous U-turn. A total of 8570 challans were issued through cameras which include 5402 for no entry, 1739 for over speeding, 934 for lane change, 101 for pillion rider without helmet, 150 for driver without seat belt, 109 for pollution, 65 for driver without helmet, 22 for triple riding and 48 for front passenger without seat police data, 1,907 challans were issued for driving on the wrong side, 829 for road marking violations, 781 for pillion riders without helmets, 1,013 for driving without seat belts, 750 for driving without helmets, 299 for belt. Action was taken on wrongly parked vehicles and on heavy vehicles changing lanes on highways causing inconvenience to commuters. People driving without helmets, seat belts and under the influence of alcohol, were also penalised. "In order to maintain road discipline and curb road accidents, special surveillance is being maintained on NH-48, Dwarka Expressway and Delhi-Mumbai Expressway with the help of NHAI cameras and drone technology," said DCP traffic Rajesh Mohan.

5 killed, several injured as house collapses after explosion in Ayodhya

Ayodhya: At least five people were killed and several others were injured after a house collapsed following a powerful explosion in Pagla Bhari village under the Pura Kalandar police station area of Ayodhya on Thursday, officials said. Circle Officer (CO) Shailendra Singh told that several people were still feared trapped under the debris, and rescue operations were underway. "Five people have died in the explosion, a few have been injured, and efforts are on to rescue those trapped. The cause of the blast is not yet clear," Singh said. Upon receiving information about the incident, the police, the fire department and the local administration teams rushed to the spot. Rescue workers have police data, 1,907 challans were issued for driving on the wrong side, 829 for road marking violations, 781 for pillion riders without helmets, 1,013 for driving without seat belts, 750 for driving without helmets, 299 for using excavators to clear the rubble, while nearby houses have been evacuated as a precautionary measure. Officials have appealed to residents to stay away from the accident site to facilitate rescue efforts. Senior police and administrative officers are supervising the operation and have begun an investigation to determine the cause of the explosion. Chief Minister Yogi Adityanath has taken cognisance of the incident and expressed deep condolences over the loss of lives. According to an official statement, the Chief Minister has directed senior officials to rush to the spot, ensure proper medical treatment for the injured, and personally oversee the ongoing rescue and relief operations.

Cops slap MCOCA on 10 Bhau gang members

New Delhi: The Delhi Police have intensified their search for infamous gangster Himanshu Bhau, who is believed to be abroad, and have slapped the Maharashtra Control of Organised Crime Act (MCOCA) on his 10 gang members, they said on Monday. Moreover, four members of the Bhau gang were killed in separate encounters so far this year, they added. "The police are actively working on to locate Himanshu Bhau, who allegedly operates the syndicate from foreign locations. By doing so, the North Delhi Range Crime Branch has effectively dismantled the gang," Surender Singh, Joint Commissioner of Police (Crime), said in a statement. Gang leader Bhau and his close aide Sahil have been declared proclaimed offenders. They are currently believed to be residing abroad. They fled India via Portugal on the basis of a fake passport, the cop mentioned. Moreover, he added that a request for trial in absentia has been moved against them before the court concerned. Efforts were being made to track and nab other active members of this crime syndicate. The syndicate has been active since 2020 perpetrating crimes, including extortion, kidnapping, murder, targeting business owners, property dealers and public figures. Its activities have been marked by violence and intimidation with notable incidents such as firing at car showrooms in Tilak Nagar and Naraina, murder of anti-gang member at a restaurant in Rajouri Garden among others. The action stems from a firing incident that took place on May 6, 2024, at Fusion Car showroom in Tilak Nagar, where three armed men opened fire inside and outside the premises to spread terror in the name of their leader.

Asiatic lion numbers in Gujarat increase 32% in 5 yrs, touch 891

New Delhi: Union Environment Minister Bhupendra Patel Yadav announced the figures during an event to observe World Lion Day at Barda Wildlife Sanctuary in Gujarat's Porbandar district, which was also attended by Chief Minister Bhupendra Patel. Union Minister Yadav said: "The Asiatic Lion (Panthera leo persica) is a global symbol of successful wildlife conservation. On this World Lion Day, we celebrate their remarkable recovery. From just 284 lions in 1990, the population has now risen to 891 in 2025 — a 32 per cent increase since 2020 and over 70 per cent growth in the past decade." "It is heartening to note that such remarkable growth has been made possible through collective will, dedication and policies rooted in co-existence," he said. At the event, Yadav announced a

Rs 180 crore plan for conservation and tourism infrastructure in Barda Wildlife Sanctuary. This includes facilities for visitors, roads, water sources and veterinary care. Barda currently has 17 lions — six adults and 11 cubs — which moved there naturally in 2023. The Gujarat government has granted in-principle approval for a safari park and zoo in Barda. A National Referral Centre for Wildlife Healthcare is planned in Junagadh district, with 20.24 hectares of land already allocated. Project Lion, launched on August 15, 2020, has a budget of Rs 2,927.71 crore over 10 years. It covers the Greater Gir Landscape, which spans 11 districts of Gujarat. The programme focuses on creating satellite habitats for lions beyond Gir, improving veter-

inary facilities, and involving local communities in conservation. It also includes disease surveillance, genetic diversity initiatives and measures to reduce human-lion conflict through awareness programmes and technology-based monitoring. World Lion Day celebrations were held across all districts of the lion landscape, connected to the main event via satellite. Schools took part in awareness activities. In 2024, 18.63 lakh students participated virtually. The Asiatic lion is listed as endangered on the IUCN Red List. Its only wild population is found in Gujarat. Conservation efforts began in the early 20th century after the population dropped to fewer than

20 individuals. The Gir National Park and surrounding sanctuaries remain the core habitat for the species. In recent years, lions have been recorded in coastal areas and agricultural land, prompting expansion of suitable habitats to reduce

conflict.

Iran 'victorious' in war with US, says speaker

TEHRAN. (Agency)

Iran had been "victorious in the field" during weeks of war and had only agreed to a temporary truce with the United States because its demands had been met, the Iranian parliamentary speaker said on Saturday.

The two-week ceasefire is set to end Wednesday unless it is renewed, with a permanent deal that mediators including Pakistan are pushing to get over the line still not finalised and progress on key sticking points uncertain. "We were victorious in the field," Speaker Mohammad Bagher Ghalibaf said in a national televised address, adding the United States had not achieved its goals and Iran controlled the strategic Strait of Hormuz maritime transit route. "If we accepted the ceasefire, it was because they accepted our demands," he said, referring to the United States.

"The enemy's every effort was to impose its demands on us and it is important that we register our rights, so this is where negotiation is a method of struggle."

Ghalibaf and his delegation held closed door talks in Islamabad with US Vice President JD Vance on April 11, in the highest level Iran-US contacts since before the 1979 Islamic revolution. The talks did not result in a final deal and officials have signalled negotiations are continuing, though Iran's deputy foreign minister said on Saturday no date had been set for a new round of talks.

'Relationship very strong': Iran reacts after India summons envoy over firing on its vessels in Hormuz

Iran on Sunday responded to the shooting incident involving India-flagged vessels in the Strait of Hormuz amid escalating regional tensions, with its top envoy in India highlighting strong bilateral ties and calling restraint and peace.

"The relationship between Iran and India is very strong and I don't know anything about this event which you mentioned and we hope that it will be okay and it will be solved," said representative of Iran's Supreme Leader in India Abdul Majid Hakeem Ilahi. He further called for peace adding, "We don't want this war. We want peace, and we hope that the other side will also follow peace so that we can have a peaceful area." "The Strait of Hormuz was open, and due to the imposed war against Iran, it was closed, because of the security issues, and we hope that very soon it will be open... Yes, it was open for some time, but as there are some problems and crises around Iran, they wanted to be sure that the problems would be solved and it would be open very soon," he said.

Iran representative's statement comes after India lodged a strong protest after two India-flagged ships, Sanmar Herald and Jag Arnav, were fired upon while transiting the Strait of Hormuz, forcing them to turn back mid-journey. The vessels, carrying around 2 million barrels of Iraqi crude, were reported safe, but the incident heightened tensions between the two countries. The Ministry of External Affairs summoned Iranian envoy Mohammad Fathali and pressed Tehran to ensure the safe passage of India-bound ships. Meanwhile, reports said several vessels, including Greek tankers, were forced to turn back following gunfire as Iran announced the complete closure of the Strait of Hormuz less than 24 hours after announcing it to be open, citing a US blockade as the reason.

Crisis-hit Bulgaria votes in eighth election in five years, with pro-Russian Radev seen as favourite

Bulgarians began heading to the polls in the eighth election in five years on Sunday with ex-president Rumen Radev's grouping expected to win on a pledge to fight corruption. The European Union's poorest member has been mired in a political crisis since 2021 when large anti-corruption rallies toppled the conservative government of long-time leader Boyko Borissov. Radev, a former airforce general who has advocated for renewing ties with Russia and slammed sending military aid to Ukraine, was president for nine years in the Balkan nation.

He stepped down in January to lead newly formed centre-left grouping Progressive Bulgaria, with opinion polls before Sunday's vote suggesting the bloc could gain 35 percent of the vote.

Radev has said he wants to rid the country of its "oligarchic governance model" and backed anti-corruption protests in late 2025 that brought down the conservative-backed government.

"Radev's cause is for Bulgaria to have a future. We have reached a point where we are questioning the very future of our own country," Lazar Lazarov, a 28-year-old philosophy teacher, told AFP at Radev's final campaign rally in Sofia earlier this week.

"Radev has proven himself as president and as a statesman. He's the one who is most acceptable for the EU, the United States, Russia and, if you like, even for China." Borissov's pro-European GERB party, which also led the last government, is likely to come second, according to opinion polls, with around 20 percent, ahead of the liberal PP-DB. Polling stations opened at 7 a.m. local time (0400 GMT), according to AFP journalists. They will close at 1700 GMT. Radev has slammed the EU's green energy policy, which he considers naive "in a world without rules", as well as any Bulgarian efforts to send arms to Ukraine battling a Russian invasion since 2022 though he has said he would not use his country's veto to block Brussels' decisions. Pushing for renewed ties with Russia, Radev denounced a 10-year defence agreement between Sofia and Kyiv that was signed last month, which earned him fresh accusations from his opponents of being too soft on Moscow. The ex-president also stoked dismay by screening images at his rally on Thursday of his meetings with world leaders including Russia's Vladimir Putin.

Trump-backed voting act could hurt women, minorities the most in US national elections

House Republicans have already passed a version of the SAVE America Act, but it faces steep obstacles in the Senate, where it appears Democratic opposition will be too strong to overcome.

Millions of married women and transgender Americans could find their ability to vote more complicated than ever if the "SAVE America Act" promoted by US President Donald Trump, currently being debated in the Senate, were to pass. The draft law would require Americans to prove their citizenship when registering to vote in federal elections and present identification materials when casting a ballot, such as a

passport, driver's license or birth certificate. But many women change their names when they get married, meaning the names on their birth certificates no longer match what they currently use -- forcing them to provide additional documentation to justify the discrepancy. The same issue would affect transgender voters, whose documentation may not consistently reflect their current identity. According to the Brennan Center for Justice, a public policy institute at New York University, "more than 21 million Americans lack ready access to those documents. Roughly half of Americans don't even have a passport." For Rick Hasen, an expert on election law at the University of California, Los Angeles, "women and transgender people are the ones who are most likely to be affected," along with low-income and working class Americans who do not have passports. Republicans in the House of Representatives have already passed a version of the Safeguard American Voter Eligibility (SAVE) America Act, but it

faces steep obstacles in the Senate, where it appears Democratic opposition will be too strong to overcome. Name changes Letitia



Harmon, the policy and research director at the grassroots voting activist group Florida Rising, was married and then divorced in Washington state, she told AFP. She changed her name twice. "So the problem is I don't know which name is in the database records," Harmon said, making it difficult to know which set of documents she would need to take to her polling place. Harmon said she will likely need to order proof of divorce from Washington state -- a costly

and time-consuming process. The White House argues that the SAVE America Act is necessary to combat voter fraud, and prevent non-citizens from voting -- though current US law already forbids that. As for the issue of married women, White House Press Secretary Karoline Leavitt said last month: "They just have to go through their state processes to update that documentation."

Voting gender gap

The prospect of millions of women struggling to vote matters because historically, men tend to skew Republican. According to the Pew Research Center, 52 percent of men surveyed said they identified with or leaned toward the Republican Party in 2024, while only 44 percent of women said the same.

"There has been a trend over the last decade and a half of mostly Republican states passing laws that make it harder to register or to vote, and mostly Democratic states passing laws that make it easier to register," Hasen explained.

Life jacket worn by a passenger who survived the Titanic auctioned off for over \$900,000

LONDON. (Agency)

A life jacket worn by a passenger on RMS Titanic as she escaped the sinking steamship on a lifeboat sold at auction on Saturday for 670,000 pounds (\$906,000). The flotation device was worn by Laura Mabel Francatelli, a first-class passenger on the doomed ocean liner, and is signed by her and other survivors from the same lifeboat.

It was the star among items in a sale of Titanic memorabilia by Henry Aldridge & Son auctioneers in Devizes, western England, and sold to an unidentified telephone bidder for well over the presale estimate of between 250,000 and 350,000 pounds.

A seat cushion from one of the Titanic lifeboats sold at the same auction for 390,000 pounds (\$527,000) to the owners of two Titanic museums in Pigeon Forge, Tennessee, and Branson, Missouri. The prices include an auction-house fee known as the



buyer's premium. "These record-breaking prices illustrate the continuing interest in the Titanic story, and the respect for the passengers and crew whose stories are immortalized by these items of memorabilia," auctioneer Andrew Aldridge said. Billed as the world's most luxurious ocean liner and described as "practically unsinkable," the Titanic hit an iceberg off Newfoundland

during its maiden voyage from England to New York. It sank within hours on April 15, 1912. Some 1,500 of the 2,200 passengers and crew died. The Titanic is still a subject of worldwide fascination, in part because of the range of passengers aboard the ship, from paupers to plutocrats. Francatelli was traveling with her employer, fashion designer Lucy Duff Gordon, and Lucy's husband Cosmo Duff Gordon. All three survived in the ship's lifeboat No. 1, which was launched carrying 12 people despite having capacity for 40. Its failure to pick up survivors from the frigid water became a source of controversy. The record auction price for a piece of Titanic memorabilia is 1.56 million pounds (almost \$2 million at the time) paid in 2024 for a gold pocket watch given to the captain of RMS Carpathia, the ship that rescued 700 Titanic survivors.

North Korea launches ballistic missiles toward sea: Seoul

SEOUL. (Agency)

North Korea launched multiple ballistic missiles toward the sea on Sunday, its neighbors said, days after the U.N.'s nuclear watchdog warned that North Korea was making "very serious" advances in efforts to build nuclear weapons. South Korea's Joint Chiefs of Staff said the launches happened on Sunday morning from the Sinpo area, an eastern coastal site where North Korea has a major shipyard use for building submarines. South Korea's military said it has bolstered its surveillance posture and is closely exchanging information with the U.S. and Japan. South Korea's presidential office said its National Security Council plans to hold an emergency meeting to discuss the launches.

Japan's Defense Ministry also detected the launches, saying the weapons were believed to have landed in the waters off North Korea's east coast. It said Tokyo strongly protested to Pyongyang, saying Sunday's launches threaten regional and international peace and violated U.N. Security Council resolutions that bans any ballistic activities by North Korea.

The launches were the latest in North Korea's run of weapons testing activities this year. Last week, North Korea said leader Kim Jong Un supervised missile tests from the country's destroyer. In the previous week, North Korea said it had three



days of testing activities to examine ballistic missiles armed with cluster-bomb warheads and other new weapons systems. Last month, it said it tested an upgraded solid-fuel engine for missiles capable of reaching the U.S. mainland. Kim has focused on enlarging his nuclear and missile arsenals since his high-stakes nuclear diplomacy with U.S. President Donald

Trump collapsed in 2019. Trump has repeatedly expressed his desire to restore diplomacy with Kim, and the North Korean leader has recently left open the door for dialogue with Trump but urged Washington to drop demands for the North's nuclear disarmament as a precondition for talks. On Wednesday, International Atomic Energy Agency Director General Rafael Grossi said that his agency has confirmed "a rapid increase" in activities at nuclear manufacturing facilities in North Korea. Grossi told reporters in Seoul that activities in North Korea point to "a very serious increase" in its nuclear weapons production capabilities. His comments echoed a view by many outside observers that North Korea has taken steps to expand its main Yongbyon nuclear complex and build additional uranium-enrichment sites in recent years. Last September, South Korea's Unification Minister Chung Dong-young said that North Korea was operating four uranium enrichment facilities and that they were running everyday.

What travelers can do as Iran war drives up flight costs and cuts availability

As the U.S. and Israel's war with Iran squeezes global oil supplies, travelers have valid reasons to worry about the cost and availability of flights as they plan their late spring and summer trips.

The head of the International Energy Agency has warned that European countries could run low on jet fuel within weeks, forcing the continent's airlines and carriers that fly to Europe to significantly reduce flights. Many airlines have already raised checked bag fees or added fuel surcharges as the global price of jet fuel increased from about \$99 per barrel at the end of February to as high as \$209 a barrel at the beginning of April.

In a sign of the conflict's ongoing repercussions for travel, Air Canada said Friday it planned to suspend its service to New York's John F. Kennedy International Airport from June 1 until Oct. 25 to lower its fuel costs. Other airlines, ranging from U.S. carriers like United and Delta to Air France-KLM, SAS, Philippine Airlines and Cathay Pacific in Europe and Asia, have reduced routes and either increased ticket prices or said they would hike them if the war keeps oil from passing through the Strait of Hormuz. "It's very hard for the airlines to make predictions in this environment, so they're going to be conservative, and that's why it's likely that their prices will remain elevated for some time until things really stabilize," said Shye Gilad, a former airline captain who now teaches at Georgetown University's business school. With fares and fees on the rise, consumers still can make choices that determine how much of their travel budgets will get taken up by paying to get to and from their destinations. While consumers may be tempted to see if the war ends before buying airline tickets, the "wait-and-see" approach to booking flights is riskier this year, travel experts say, especially the longer the war goes on and the closer to summer and other peak travel periods it gets. Presuming there is a lasting ceasefire — or better yet, peace agreement — it will take a few months for normal levels of jet fuel production and delivery to resume," airline industry analyst Henry Hartevelde, president of Atmosphere Research Group, said. Iran's reversal on Saturday of its decision to reopen the Strait of Hormuz and President Donald Trump's insistence on maintaining a U.S. blockade of Iranian ports illustrated the shakiness of prospects for oil flowing reliably again from the Persian Gulf and with it, an easing of the price pressure on airlines and their customers. "My advice to travelers is this: If you find a flight whose schedule fits yours, with a fare you can afford, and on an airline you can at least tolerate, book it," Hartevelde said. "But — and I cannot emphasize this enough — do not book a Basic Economy fare," the cheapest but also the most restrictive airline ticket class.

While Trump lashes out at Spain, US Democrats join progressive world leaders' rally in Barcelona

Sen. Murphy, a Democrat from Connecticut, spoke at the progressive rally and didn't shy away from blasting Trump while celebrating the loss of power of Trump's ally Viktor Orbán in Hungary last week.

Progressive leaders from around the globe gathered in Barcelona on Saturday to try and galvanize their forces and defend a rules-based world order. Spanish Prime Minister Pedro Sánchez, an outspoken critic of U.S. President Donald Trump and the US-Israeli war against Iran, hosted two overlapping events about democracy and progressive politics in Spain's second-largest city. Democrats US Sen. Chris Murphy and Minnesota Gov. Tim Walz were present alongside the leaders of Brazil, South Africa and high-ranking officials from other left-leaning governments. While no foreign leader criticized Trump by name in public, the staunchly unilateral position of the American president that breaks with decades of US foreign policy, including his derision of NATO and the United Nations, hung over the meetings. "We all see the

attacks against the multilateral system, the repeated attempts to undermine international law and the dangerous normalization of the use of force," Sánchez said. Trump again lashed out on Saturday on social media at Sánchez, who has faced Trump's scorn for not allowing the US to use jointly operated military bases in Spain for operations related to the Iran war and for refusing to raise military spending from 2% to 5% of GDP. "Has anybody looked at how badly the country of Spain is doing. Their financial numbers, despite contributing almost nothing to NATO and their military defense, are absolutely horrendous. Sad to watch!!!" Trump posted on Truth Social. Sánchez says the right's time is running out in Spain, like the US and other developed countries, is in debt, but it has one of the world's leading economies under Sánchez. Sánchez told

the rally of progressive politicians and party members held later on Saturday that the populist right "screams and shouts not



because they are winning but because they know their time is running out." They know their vision of how the world should be ordered is falling apart due to the tariffs and wars," he said. "Their embrace of climate change denial, of xenophobia, or sexism is their greatest error." They have tried again and again to make us embarrassed of our

beliefs. That ends now. From now on they can be the ones who feel ashamed." Brazilian President Luiz Inácio Lula da Silva, Mexican President Claudia Sheinbaum, South African President Cyril Ramaphosa and Colombian President Gustavo Petro, and other leaders and officials, including Cabinet members from the United Kingdom and Germany, were in attendance at the IV Meeting in Defense of Democracy that kicked off Saturday's double-header of political events at the Barcelona convention center.

Later in the day, Sánchez, Lula and Ramaphosa stayed put to attend the inaugural Global Progressive Mobilization, where some 6,000 left-leaning elected officials, policy analysts and activists exchanged ideas. "The far right is international, so we must be too," German Vice Chancellor and Finance Minister Lars Klingbeil told a crowd of activists.

Soon, common man's drink to cost 20% more in Karnataka under new alcohol tax plan

The maximum retail price (MRP) on the common man's alcohol -- whiskey, rum, gin and brandy -- in Karnataka will soon increase by at least 20%, with the government issuing a draft notification to bring in a new tax structure that will tax the content of alcohol in beverages. Higher the content of alcohol in Indian Made Liquor (IML) made in Karnataka, higher will be the tax on it once the amendment comes into effect.

IML in the state is sold in slabs depending upon the MRP. The first four excise slabs, which till now are with the lowest MRP and meant for low-income group consumers, now stand to become more expensive. The average alcohol content in this segment of IML is 42.8v/v.

These four slabs contribute 80% towards the excise revenue. From Rs 80 per 180 ml (nip) the price last year went up to Rs 95 per nip. It will now cost between Rs 105-110 with AIB taxation.

The government on Saturday issued draft notification to amend a more than six-decade-long alcohol taxation policy and usher in 'Alcohol-in-Beverage' (AIB)-based excise duty structure. With amendment to Karnataka Excise (Excise Duties and Fees) Rules, 1968, the state will become the first in India to introduce excise duty based on AIB.

Karnataka PHC officers stretched thin as staff shortage deepens, care may suffer

Mounting vacancies in Karnataka's primary healthcare system are forcing frontline workers to take on multiple roles, with Primary Health Care Officers (PHCOs) now being asked to shoulder the responsibilities of Community Health Officers (CHOs), triggering concerns over workload, training gaps, and patient care.

In 2024-25, as many as 1,194 CHO posts remain vacant out of 6,780 sanctioned positions. At the same time, 2,949 PHCO posts are also unfilled, pointing to a wider human resource crisis at the grassroots level.

PHCOs, earlier known as Auxiliary Nurse Midwives (ANMs), are primarily trained in reproductive and child health. However, a recent order by the Department of Health and Family Welfare has directed district officials to obtain consent from PHCOs to take on CHO duties in centres where vacancies persist, instead of filling these posts.

Experts say the move reflects deeper systemic issues. "There is a clear mismatch of capacity and skills. CHOs are trained as mid-level healthcare providers focusing on non-communicable diseases, while PHCOs are trained mainly in maternal and child health.

Simply transferring responsibilities is not a sustainable solution," says Dr Swathi SB, public health practitioner and member of Sarvatrika Arogya Andolana Karnataka (SAAK). She added that the approach risks weakening the system further. "When both cadres themselves are understaffed, redistributing roles only increases pressure without strengthening healthcare delivery," she noted.

As Siddu plays it safe, Jarkiholi steps in to take on AHINDA mantle

With Chief Minister Siddaramaiah reluctant to back under fire Muslim leaders and MLCs, Naseer Ahmed and K Abdul Jabbar, PWD Minister Satish Jarkiholi, who is aspiring to become KPCC president, has stepped in to control damage.

Naseer was sacked as CM's political secretary. Jabbar was suspended from the party after having been made to resign as KPCC minority cell chief. Siddaramaiah is said to have suggested to Zameer to explain to the party high command his alleged anti-party activities to defeat Samarth Shamanur, son of Horticulture Minister SS Mallikarjun. Jarkiholi and Mahadevappa had a breakfast meeting with Zameer and discussed strategy, a source said. "Zameer along with Siddaramaiah's son Dr Yathindra has been reiterating that Siddaramaiah will continue as CM for five years and his interest should be safeguarded," a Congress leader said.

Dushyant Chautala and Hisar crime branch in-charge file complaints against each other

Twist in pan parlour owner's kidnap: Vadodara woman, lover abduct her husband, throw him in canal using hitmen, he survives

Wife and lover among 7 arrested; husband says he was held captive, assaulted, and robbed of his belongings, including his wallet, mobile phone and cash in his account

What appeared to be a case of a late-night robbery and abduction of a local pan parlour owner in Vadodara has now taken a far more sinister turn.

The businessman, who was rammed off the road, kidnapped, and thrown into a canal near Anand district in an apparent attempt on his life, survived not only to tell the story but also lead the investigators to unravel a shocking conspiracy allegedly orchestrated by his wife and her former lover.

The victim, Girishbhai Patel, a resident of the Chhani area, was returning home on the night of April 8 after shutting down his shop as usual when a white hatchback car rammed into his two-wheeler on the Chhani-Sokhda Road. Before he could react, a group of men allegedly forced him into the car and drove away, marking the beginning of a horrifying ordeal. Even as CCTV footage of the alleged abduction went

viral, the Vadodara city police began an investigation when Patel returned the following day to tell the story.

According to the complaint lodged by Patel, he was held captive, physically assaulted, and robbed of his



belongings, including his wallet, mobile phone, and cash by the unknown attackers. Patel has alleged that his attackers also forced him into revealing his ATM PIN, which they used to allegedly withdraw Rs 1 lakh from multiple locations across the city

and nearby highways. The accused then allegedly took Patel to a canal near Sojitra in Anand district and in an attempt to allegedly eliminate him, they threw him off a bridge into the canal.

However, Patel managed to cling to a pillar in the canal and remain in hiding until dawn. Police said that he was rescued the next morning with the help of locals and later informed his family that he had survived.

Stunned by the revelation a detailed probe by the Chhani police, under the supervision of Deputy Commissioner of Police, Zone-I, Jagdish Chavda revealed that the crime was not the handiwork of random criminals but allegedly a conspiracy by Patel's wife Falguni along with Kaushik Sharma—her former lover. Police said that although Falguni and Sharma were allegedly engaged, the relationship was called off and Falguni eventually married Patel about five years ago.

ASCI report bats for phased ban on sleeper buses in Andhra Pradesh

Following back-to-back severe road accidents involving privately operated sleeper buses catching fire, the State government has sought an inquiry into the causes behind the fire mishaps and recommendations on measures needed to ensure safe travel for passengers.

Based on the government's request, the Administrative Staff College of India (ASCI) carried out a detailed investigation into one such road mishap and submitted a report to the State government recommending a complete ban on sleeper buses in a phased manner.

Ironically, Transport Minister Mandipalli Ramprasad Reddy too stated that the State government is considering a ban on sleeper buses in the State.

According to the study report, ASCI has recommended a phased ban on sleeper buses following a series of fatal accidents, including a major fire incident on the Nayakallu flyover along National Highway-44. The report, submitted to the State government, highlights serious safety concerns and calls for complete removal of sleeper bus operations within 22 months.

The study draws comparisons with international practices, noting that China banned sleeper buses in 2012, while several European countries enforced similar prohibitions as early as 2004 due to inherent safety risks.

ASCI's findings underline critical design flaws in sleeper buses, including elevated centres of gravity due to multi-tier bunks, which increase rollover risk, and the incompatibility of horizontal sleeping arrangements with rapid evacuation during emergencies.

Gujarat Gas reduces PNG price for Morbi cluster, but ceramics prices to remain dearer

Decision after Morbi Ceramics Manufacturers Association's talks with PSU, govts; fuel costs still 48% higher than pre-crisis period

Two weeks after the price of the Piped Natural Gas (PNG) proposed by the Gujarat Gas Ltd left the propane-run ceramic units in Morbi upset, the state government-run public sector unit has agreed to bring the price down.

From Rs 88 per cubic metre which was offered on April 1, which would add up to Rs 93 per cm, GGL has brought the price down to Rs 77 per cubic metre following multiple negotiations. The price of PNG for the tile-makers, however, still is 48% higher than Propane-LPG (Rs 52 SCM) whose supplies ran out after the blockade of the Strait of Hormuz following the war in West Asia. It does however, bring the difference in prices between the regular users of PNG which were largely the sanitaryware units and those returning to

PNG, which is the tile making units, to Rs 7 instead of Rs 23, bringing some semblance of parity to the sector.

The decision by Gujarat Gas comes two days after the retail prices of the ceramic products were increased by the Morbi Ceramics Manufacturers Association (MCMA) on April 15 by 30% to 50%. In spite of these decreased rates of PNG, the prices of end products will remain unchanged, the association said.

The shutdown at Morbi cluster, which accounts for 90% of the Indian ceramic industry, started on March 17 due to the fuel shortage in India following the blockade of the Strait of Hormuz by Iran in light of devastating attacks by the US and Israel starting February 28.

Almost all the fuel for the ceramic industry

is imported, including all of the Propane-LPG and half of the natural gas.

According to data from Gujarat Gas, as of



February 2026 (pre-crisis), of the 792 ceramic units in Morbi, 377 had been using PNG supplied by it while the other 415 units had been using Propane-LPG

supplied by Oil Marketing Companies IOCL, BPCL and HPCL. While the 110-odd sanitaryware units and smaller tiles units had been using PNG, all the other tile units had been relying on Propane-LPG to fire their kilns. Before the West Asia war began, consumption of Propane-LPG was an average of 55 lakh cubic metres per day, and consumption of Natural Gas was approximately 25 lakh cubic metres per day. After the supply of Propane-LPG to industry was throttled by lack of supplies from Qatar and other Gulf Cooperation Council (GCC) nations and remaining stocks were ordered priority redirection to residential cooking needs by the Government of India, the ceramic units, mostly the tiles units, were forced to turn to Gujarat Gas seeking PNG supplies.

In a key development in the case related to the alleged circulation of explicit videos of minor girls online in Maharashtra's Amravati, a victim has agreed to record her statement before the police.

Revenue Minister and guardian minister of Amravati Chandrashekhar Bawankule on Saturday visited the SP's office in Amravati to review the progress of the probe. He directed police to investigate the case from all angles and ensure that no accused escapes the law.

Police said three mobile phones seized from the accused are being examined for forensic data. Authorities have also appealed to other victims to come forward without fear and record their statements. Police assured that all necessary precautions are being taken to protect the identity of survivors. The case came to light when several obscene videos of the main accused with girls, believed to be minors, were widely shared on social media platform, Telegram.

Over eight accused came under the scanner. Police have conducted house searches and seized electronic devices for forensic analysis to trace digital evidence and establish the extent of the crime.

Women's credit access: To ensure borrowing means building

The conversation on women in science, technology, engineering and mathematics (STEM) has, for too long, been framed around inclusion. It is time to reframe it around power, leadership and agency. The real question is not whether women should participate in science and technology, but whether they will shape its future. Across the world, women are stepping forward not just as scientists and innovators, but as institution builders, capital allocators and ecosystem shapers. Their influence is redefining how we think about empowerment—not as access alone, but as the ability to create, lead and transform systems.

India begins from a position of latent strength. Women account for a significant 43 percent of its STEM graduates, placing the country among the strongest globally in terms of participation. The imperative now is to convert this participation into authority and leadership. Though women enter STEM education in significant numbers, their drop-offs at senior levels—in research leadership, deep-tech entrepreneurship and policy influence—remain stark. This is not a pipeline problem alone. It is a power asymmetry. Empowerment in STEM must, therefore, move beyond with elevation to leadership, ownership and participation in decision-making. Encouragingly, India's wider policy experience shows what is possible when structural barriers are removed. Over the past decade, women's access to assets, credit, health and basic infrastructure has expanded at unprecedented scale. More than 72 percent of homes under PM Awas Yojana (Gramin) are owned by women, while women account for nearly 69 percent of loans sanctioned under the Mudra Yojana and 84 percent of beneficiaries under the Stand-Up India scheme. These outcomes demonstrate that when women are given agency and control over resources, participation can translate into leadership.

When women lead in science, they expand the frontier of what science chooses to solve. They bring not just representation, but reorientation. From healthcare to climate science, women leaders often prioritise preventive and community health models, focus on access, affordability and equity, and drive collaborative, interdisciplinary innovation. This is not anecdotal; it is structural. Diverse leadership produces more relevant, scalable and humane solutions.

A defining shift of our time is that women are not waiting to be included; they are deploying capital and influence to build new pathways. American philanthropist MacKenzie Scott has redefined large-scale trust-based philanthropy, directing billions towards education, equity and institutional capacity. Closer home, Rohini Nilekani has consistently emphasised building public goods and ecosystems—recognising that access to knowledge, digital infrastructure and education are foundational to participation in the future economy. In India, this shift is also being reinforced by public policy that expands women's economic agency by bringing them into the mainstream. Over the past decade, the country has invested in enabling conditions that free up women's time, energy and ambition. Clean cooking access through more than 10 crore Ujjwala LPG connections has reduced health burdens. Tap water to over 14 crore rural households under the Jal Jeevan Mission has lifted one of the most invisible forms of unpaid labour. Improved dignity and safety through Swachh Bharat—where over 90 percent of women report freedom from the dangers of open defecation—has transformed everyday lives. Yet, we risk under-leveraging this advantage if women continue to be underrepresented in advanced research, innovation ecosystems and leadership roles. Empowerment must therefore be engineered deliberately. Women trained in science and technology bring evidence-based thinking, data literacy and systems reasoning into governance—strengthening policymaking across public health, climate and digital infrastructure.

Stalin finds gold in delimitation row

Delimitation, which threatens to shrink Tamil Nadu's space and voice in the federal polity, is the darkest red flag that the DMK has waved over the years.

THE Centre's delimitation ambush, a week before Tamil Nadu votes in the Assembly elections, has infused new life into the DMK's campaign for a second term. The party that in 2021 won 133 seats on its own in the 234-seat Assembly—an absolute majority that silenced the murmurs of partners in the Secular Progressive Alliance—was beset this time by concerns about incumbency, the Vijay effect (Vijay, the popular Tamil film star and founder of the Tamilaga Vettri Kazhagam, who has emerged as a new political factor in Tamil Nadu politics) and a dysfunctional alliance with the Congress. While DMK insiders were confident that the party still had the edge, it was with the caveat of a definite erosion in the party's vote share, perhaps even dependence on its allies. But the Narendra Modi government may have just erased DMK's worries. Over the last five years, Chief Minister MK Stalin has lost no opportunity to highlight Tamil Nadu's fight to retain what little autonomy India's federal system gives it considering the BJP's apparent appetite for centralising everything—from finances to language, culture and religion.

Delimitation, which threatens to shrink Tamil Nadu's space and voice in the federal polity, is the darkest red flag that the DMK has waved over the years.

Last year, Stalin convened a meeting of chief ministers of four Opposition-ruled states—three of them in the south and Bhagwant Mann of Punjab—deputy chief minister of Karnataka D K Shivram, and representatives of Opposition parties, including BRS, BJD and SAD. The discussion was how states that had managed to rein in population growth with their progressive policies and development priorities were being punished for it. It's no longer talk. On April 16 and 17, at a time when the DMK (and the TMC in West Bengal) are in the thick of their campaigns, the Centre wants to rush through Parliament two related Bills: the Constitution (131st Amendment) Bill, which removes the constitutional freeze on delimitation until after the first census to be conducted post 2026. This means delimitation can begin immediately on the basis of the 2011 Census, without waiting for the 2027 Census. It increases the number of seats in the Lok Sabha from 543 to 850. Deviously, the government has linked delimitation to the implementation of Nari Shakti Vandan Adhiniyam, which provides 33% reservation of seats for women in Parliament and state Assemblies. Under the 2023

Women's Reservation Act, this was to be implemented only after the first Census to be conducted after 2023. The BJP's political message is clear: you are against women's reservation if you are against delimitation. The associated Constitution (131st Amendment) Bill, 2026 seeks to replace the Delimitation Act of 2002.

If these Bills become law, Tamil Nadu's share of representation in Parliament will reduce, even though the number of parliamentary constituencies is set to increase from 39 to 50 in the expanded Lok Sabha. This reduction will carry serious repercussions for both politics and governance. Stalin's response, invoking the memory of the "DMK of the 1950s and 1960s", was a not-so-subtle reminder about a history that is precious in

By then, Tamil Nadu had mobilised against Hindi for nearly three decades, starting from the pre-Independence 1937 Madras government's move to impose the language in schools. In the 1950s, the newly formed DMK ran a campaign to black out the names of railway stations written in the Devanagari script. The late DMK leader, former Chief Minister and Stalin's father, M Karunanidhi, then a celebrated scriptwriter for Tamil films, led the protests against the renaming of the Kallakudi station in Tiruchirappalli as Dalmiapuram, after the industrial township set up by the Dalmia group in 1939. The anti-Hindi agitation of the 1950s also fuelled a secessionist demand for Dravida Nadu, which remained on the DMK's books until 1963, when it faced the reality check of the Constitution (16th Amendment) Act, which banned secessionist speech and also included "upholding the sovereignty and integrity" of India in the wording of the oath of office. But the agitation against Hindi continued. Led by CN Annadurai, the DMK mobilised students behind the cause in Chennai and other cities in the Madras state, using Tamil movies, songs, poetry and newspapers. Annadurai was arrested on January 25, 1965, ahead of the planned protests on Republic Day. Scores of students and other youth were killed in the protests that erupted throughout the state. After that, Madras burned for nearly two months. The violence stopped only after assurances from Prime Minister Lal Bahadur Shastri that there would be no compulsory imposition of Hindi and that English would remain the official language for an indefinite period. The state won the right to implement a two-language formula in its schools. The Congress was voted out in 1967, and has never been voted back to office since then. The

BJP is trying but is nowhere close to succeeding. The AIADMK, whose tense alliance with the BJP has already sucked the life out of the NDA campaign, and the inexperienced but popular Vijay, the biggest crowd puller in this election, have yet to come to grips with this new challenge from the Centre. For the DMK, however, it is election gold for sure.

The best hope for Tamil Nadu and the country is that these Bills, which go against the spirit of India's federal compact, are defeated on April 17. Never mind if the BJP paints those who voted against it as anti-women's reservation. Nothing prevents the Centre from implementing the reservation for women without linking it to delimitation.

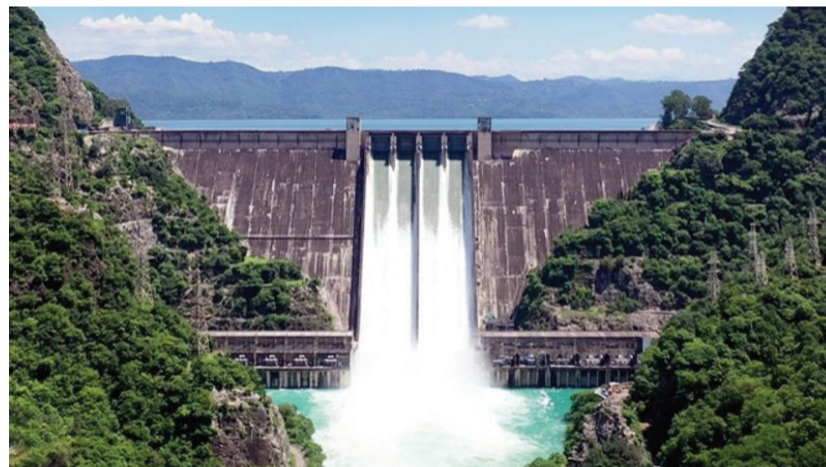


Tamil Nadu for a hard-won victory that changed the course of the state politically and in every other way in the nascent years of the Republic. The long history of street protests and political agitation against Hindi is what Stalin was referencing when he messaged: "Not just a threat, but a warning" that "every family" would take to the streets. For those who may not know: on January 25, 1964, 4.30 am, Keezhapazhur Chinnasamy, a 27-year-old youth, walks into Tiruchirappalli junction railway station, pours kerosene on himself and sets himself ablaze. It was possibly the first self-immolation as political protest in India. As the flames consumed him, his screams of "Vaazhga Tamil, Ozhiga Hindi (long live Tamil, down with Hindi)" became the slogan of a generation.

Eroding federalism: BBMB rule change dilutes riparian rights

What is needed is not unilateral change but consultation and consensus

THE Centre's decision to amend the rules governing the Bhakra Beas Management Board (BBMB) has triggered predictable outrage in Punjab and Haryana. But the issue goes far beyond routine political protest. At its core lies a fundamental question: how far can Central authority extend into institutions that were designed to embody cooperative federalism? By ending the longstanding convention that key technical posts in the BBMB would be held by officers from the partner states, the Centre has altered the delicate balance that underpins the management of crucial river waters. For Punjab and Haryana, whose agrarian economies depend heavily on these waters, the move is being seen as a dilution of their rightful stake. The timing is equally significant. With summer approaching and water demand set to rise, any perception of reduced state control risks fuelling inter-



state tensions, particularly against the backdrop of the unresolved SYL canal dispute. Trust, once eroded in water-sharing arrangements, is difficult to rebuild. The Centre may argue that broad-based appointments

enhances efficiency and professionalism. Yet, governance structures in a federal polity cannot be judged by technocratic logic alone. They must also inspire confidence among stakeholders. In river water management, where history, geography and politics intersect, legitimacy is as important as competence.

What is needed is not unilateral change but consultation and consensus. The BBMB has long been a symbol of negotiated coexistence between riparian states. Undermining that symbolism risks reopening old fault lines. A course correction is still possible. The Centre must engage with the states to evolve a framework that balances efficiency with federal sensitivity. In matters of shared resources, cooperation cannot be commanded; it has to be cultivated.

No respite in sight for the rupee

It's unlikely that the RBI will be able to prevent its slide in 2026-27

THE rupee closed at 94.35 to the dollar on March 31, declining in a year by 10.5% from Rs 85.4 (its rate on March 31, 2025). In free fall since September last year, the rupee touched nearly 95/dollar on March 27. After the Reserve Bank of India (RBI) took some extraordinary measures and a ceasefire was brokered between the US and Iran, it is currently trading around Rs 93/dollar. The rupee's depreciation hurts India badly. Dependence on energy and Chinese imports makes our situation worse, while Indian merchandise exports don't gain any additional traction as we don't have products which the world has to import only from India or which we offer at the most competitive prices.

Foreign loans and their servicing become much costlier when the rupee depreciates. It is necessary to look at what is in store for the rupee in 2026-27. Will it touch the 100/dollar mark? Will it depreciate again by 10%? Does the RBI have sufficient firepower to stem the rot?

The RBI's foreign currency reserves (FCRs) of \$551 billion—our stock of dollars and other foreign currency assets and deposits—are its real firepower. Headline foreign exchange reserves of \$688.1 billion—the RBI's total reserves—include, besides FCRs, gold reserves (\$113.5 billion) and our holdings in the International Monetary Fund (\$24.4 billion). Gold reserves are difficult to sell, especially for India, as considerable odium is attached to it, thanks to the gold sales we had to undertake in 1991. Other components are too small.

Gold reserves make up as much as one-sixth (16.5%) of the RBI's total reserves. Gold did not have that dominance earlier. The RBI's fascination for the purchase of gold in the past four years and higher gold prices have materially reduced the real firepower—the FCRs' share. In March 2022, FCRs at \$553.7 billion were nearly 90% of the total reserves (\$619.7 billion). Currently, FCRs make up only about 80% of the total

reserves. There is another factor which reflects the RBI's mindset: it is unwilling to use its firepower. India was precariously vulnerable in 1991, with its total reserves being less than \$10 billion. This gave us the mindset of wanting to add more and build "adequate" reserves. When reserves reached \$100 billion in 2003-04, we felt adequately covered, but only for some time. In 2007-08, our reserves crossed \$300 billion and remained at that level for the next 4-5 years. Still, India suffered a bout of rupee depreciation in 2013 when the taper tantrum struck (the US Federal Reserve decided to reduce purchases of bonds, making the dollar appreciate).

India launched a costly FCNR(B) deposit scheme (foreign currency non-resident accounts) to collect \$26 billion to shore up reserves. In 2017-18, we had more than \$450 billion in reserves, yet we panicked when crude went past only \$80 a barrel and foreign portfolio investors (FPIs) withdrew about \$50 billion. Instead of using reserves, the government and the RBI contemplate raising \$50 billion in forex deposits/bonds.

Currently, we have total reserves of about \$700 billion and FCRs of \$550 billion. Yet, the RBI finds it difficult to use reserves for arresting the fall of the rupee. In the past few months, the Central bank went on adding to its reserves by undertaking swap operations (buying dollars now to sell dollars later) of about \$80 billion.

How should we assess the adequacy of our reserves (FCRs for me)? It has been traditionally measured in terms of months of merchandise imports they can finance; 10-12 months' coverage is considered comfortable. This, however, is not a good benchmark. Current account deficit (CAD) matters more. India's total imports of

\$915.2 billion in 2024-25 were more than 90% financed by exports of \$825.3 billion. Surplus in other items of current account (like remittances from our workers abroad) reduced CAD to only \$23.3 billion in 2024-25, which hardly needed about 4% of FCRs to finance it. It is the capital account (receipts of equity, bonds and NRI deposits minus payments for loans taken and



investments withdrawn) which should worry us more. Our foreign exchange reserves have been built by surpluses in the capital account. Two big volatile constituents of capital account—foreign debt and portfolio investment—can cause real trouble.

Foreign debt flows reverse when the rupee depreciates, as servicing and hedging costs go up. Indian holders of foreign debt stop borrowing and start paying off. For

FPIs, their rupee investment in Indian equities and debt lose big when stock markets plummet and the rupee depreciates (as loss in share value and exchange rate far exceeds dividends, as is happening currently). In 2025-26, FPI investments generated large negative returns of more than 15%. No wonder FPIs sold over Rs 1 trillion worth of equities in March 2026 alone.

The ratio of outstanding foreign debt and portfolio liability to India's foreign currency reserves is a better marker to see where the rupee-dollar exchange rate is headed. India's foreign debt is about \$750 billion. FPIs' stock is also about the same amount. Together, these volatile foreign debt and portfolio investment assets are about \$1.5 trillion, which is about 2.7 times the RBI's currency reserves. This is India's real vulnerability. A ratio of more than 1 should worry policymakers and the RBI.

Prospects for 2026-27 are indeed quite worrying. The damage to oil and gas production infrastructure in the Middle East, which produces more than 20% of the global oil and 30% of the natural gas supplies, is extensive and unlikely to be undone anytime soon, even if there is a permanent agreement. Iran has successfully weaponised the Strait of Hormuz and would continue to recover a toll charge (currently \$1 million per ship). Iran has the ability to regulate the supply/flow of oil. Iran and other members of the Organisation of Petroleum Exporting Countries (OPEC) are likely to ensure that oil prices stay around \$90-100 per barrel in 2026-27. This will make India's oil bill go up massively as every \$10 per barrel increase in crude oil prices adds about \$50 million a day to our import bill, making the current account worsen. FPIs are unlikely to return to Indian markets anytime soon. With a weakening rupee, they may continue to exit.

“To promote science education among girls in Punjab:” STEM Collective launched

100 girls from 25 govt schools of Patiala were chosen for the programme's first cohort

The Punjab government, academia, civil society and industry came together at Thapar Institute in Patiala on Saturday to launch the STEM Collective, a multi-year programme to promote science education among girls in Punjab.

As many as 100 girls from 25 government schools across the city joined the programme's first cohort. Aiming to reach 100 girls annually, the programme is designed to be replicated across other states.

The STEM Conclave marked the public launch of the STEM Collective, built in partnership between Sanjhi Sikhiya, Avanti Fellows, PI-RAHI and the Department of School Education, Punjab, with support from Genpact. The selected 100 girls took a tour of the exhibition put

up by various organisations, heard STEM alumni talk through their science journey and later participated in a guided campus immersion at Thapar's ongoing Techfest – Helix, exploring robo wars, hackathons, and advanced laboratories, many for the first time.

Simultaneously, science and mathematics teachers held small group sessions with professors from IIT Ropar, Thapar University, Punjabi University.

“This is not just about choosing science as a subject — it is about understanding why we learn what we learn,” said Dr Jaswinder Singh, national award-winning science teacher from Patiala. “Students shouldn't be scared of science. They should be curious about what lies inside their geometry boxes and how the world around them works.”

Alumni of government schools, now engineering students at NIT Jalandhar, spoke about what made the difference in their journeys: timely mentorship and access.

Prof Arvind, former vice-chancellor of Punjabi University, reflected on his own path through a village government school. “Classroom environments often push students away from science rather than drawing them in. In my own journey, real learning began when I had to explore and understand concepts on my own.”

“Students learn as much from each other as they do from teachers,” said Prof Arun Kumar Grover, former vice-chancellor of



Punjab University. “We need to create environments where curiosity is encouraged, and teachers continuously evolve with the times.” Raising concerns

around shrinking opportunities for hands-on learning, Prof Rajat Sandhir, Director, PI-RAHI, said, “How do we promote science in an ecosystem where imagination is limited and practical learning is disappearing? That is the challenge we must address together.”

Sarika Rastogi, representing Genpact CSR, highlighted the broader impact of the initiative. “When a girl from a government school in Punjab enters a career in technology, it transforms not only her life but also the aspirations of her family and community. That ripple effect is what Genpact aims to support,” she said.

Meet this Haryana farmer earning Rs 6.5 lakh per acre growing 5 varieties of watermelon

A watermelon farmer from Siwah village in Panipat, Ram Pratap Sharma, 63, honoured with the Krishi Rattan Award, has built a remarkable reputation by cultivating five distinct varieties of watermelon. He supplies his produce to families in Gurgaon, Ludhiana, Chandigarh, and Delhi, maintaining close ties with influential households. Firms with online supply chains serving Delhi and Noida are also among his regular buyers.

Sharma, who studied up to the second year of graduation in 1981, contributed to years to his family's farming and small-scale horticulture before turning full-time to vegetables and fruits in 2011, when polyhouse, plynnet, and drip irrigation began to gain ground in the region.

Over time, he developed his own client base, including industrialists and administrators from major cities, who often collect 10–15 kg fruit packs from him to share with their relatives.

“My watermelon is especially in demand from firms engaged in online supply to Delhi and Noida, where fresh fruit is delivered to homes on a phone call,” Sharma told. In recent years, his watermelons have earned him recognition, with five colour varieties—red, orange, dark yellow, light yellow, and blue. “To ensure good quality watermelon, I procure seed from companies in Thailand and Taiwan at a rate of Rs 1 lakh per kg. For one acre, only 300 grams of seed is required to grow a good crop with 6,000 plants,” Sharma said.

HC upholds Pangna Gram Panchayat pradhan's disqualification under Panchayati Raj Act

The Himachal Pradesh High Court has dismissed a petition challenging the disqualification of a panchayat representative, asserting that “strict penalties for electoral malpractice are justified and necessary to maintain the integrity of the democratic process”.

Hearing the matter on Friday, a Division Bench of Justice Vivek Singh Thakur and Justice Ranjan Sharma upheld the order disqualifying petitioner Basant Lal from contesting elections for six years under Section 146(2) of the Himachal Pradesh Panchayati Raj Act, 1994.

The court observed that “for corrupt practices in the election process, punishment should be harsher”, adding that “the statutory disqualification cannot be termed harsh or disproportionate”. Finding “no merit” in the plea, the bench dismissed the petition, along with all pending applications.

The petitioner had approached the high court under Article 226 of the Constitution, seeking to quash the February 3, 2025, order of the Mandi Deputy Commissioner, and also challenging the constitutional validity of Section 146(2), terming it “arbitrary and violative of Articles 14 and 21”.

Basant Lal was elected pradhan of Pangna Gram Panchayat in Mandi district during the 2020 Panchayati Raj elections, but his election was set aside following an election petition filed by a private respondent.

The Karsog Sub-Divisional Officer (Civil), in an order dated April 25, 2022, had declared his election “null and void” after finding that he had deliberately concealed a pending criminal case in his nomination form filed on February 17, 2021.

Gangsters of Gurdaspur

Chandigarh. (Agency)

The border district of Gurdaspur, has emerged as a major breeding ground for a new generation of high-profile gangsters and radicals who have fled India and are now directing organised crime and extortion rackets, data compiled by the Punjab Police shows.

The data further reveals that these gangsters are also hand-in-glove with Pakistan's Inter Services Intelligence (ISI) and involved in targeted killings and terror activities from safe havens in Germany, Portugal, Canada, USA, UAE, UK, Armenia and Philippines. It shows that most of these gangsters operating in Batala, Gurdaspur, Amritsar and Tarn Taran area belong to powerful syndicates such as the Lawrence Bishnoi gang, Jaggu Bhagwanpuria gang and the Harry Chattha network.

“Several of these gangsters also have direct or indirect links with banned Khalistani outfits who in turn are working at the behest of Pakistan's ISI, smuggling weapons and drugs through drones and coordinating grenade attacks on police establishments,” a senior police officer said. Intelligence dossiers list at least a dozen notorious figures from Gurdaspur and its Batala sub-division who continue to

operate transnationally despite multiple criminal cases ranging from five to over 50 against each.

Senior Congress leader and Gurdaspur MP Sukhjinder Singh Randhawa says, “These individuals are wanted in multiple cases of murder, attempt to murder, extortion and



illegal arms possession. They continue to run their criminal empires in the sensitive border belt of Punjab virtually unchecked. I have complained to the DGP and even to union home ministry. But to no avail. Residents of Gurdaspur have been left to fend for themselves”.

Terror Operatives
Jaswinder Singh alias Baghi, alias Mannu Agwan

A key link of the Khalistan Zindabad Force (KZF), Mannu Agwan originally hails from Agwan village and is suspected to be hiding in Germany. After moving to Greece and connecting with KZF militants via social media, he has openly claimed responsibility for recent grenade attacks on Punjab Police stations and personnel. He is also involved in cross-border smuggling of arms and narcotics through drones on behalf of Pakistan's ISI.

Swaran Singh alias Jeevan Fauji
From Shahzada Kalan village in the district, he is an army deserter who later moved abroad, traveling from India to Germany via Delhi and the UAE. Suspected to be hiding in Germany, he became actively associated with the Harvinder Singh Rinda-Happy Passia terror network. He has been involved in anti-national and terror-related activities, including planning and coordinating grenade attacks on police establishments in Punjab. Swaran Singh has also issued direct threats to police officials and their families. He operates primarily through online and digital platforms while staying outside India.

Himachal: Vikramaditya Singh flags 'deferment of justice' in women's quota rollout

Shimla, Apr 18 (UNI) Himachal Pradesh Public Works and Urban Development Minister, Vikramaditya Singh, today criticised the Centre's approach to the Women's Reservation Bill, alleging that its current structure delays implementation and threatens the federal balance.

Addressing a press conference here, he said that linking the proposed 33 per cent reservation for women in the Lok Sabha and state assemblies to the completion of the Census and subsequent delimitation exercise would effectively defer its implementation by nearly a decade. He termed the move as a “postponement of justice” rather than a genuine step towards women's empowerment.

Highlighting his party's position, the minister said the Congress has a long-standing commitment to enhancing women's political participation, pointing to initiatives such as the 73rd and 74th Constitutional Amendments and the passage of the Women's Reservation Bill in the Rajya Sabha in 2010. In contrast, he alleged that the present framework introduced by the NDA government creates procedural barriers that delay the actual benefits of the legislation.

Singh expressed serious concern over the proposed delimitation exercise, warning that any increase in Lok Sabha seats beyond the existing 543 could lead to what he described as “demographic re-engineering.” He claimed that such a move may disproportionately favour states with higher population growth, while disadvantaging smaller states like Himachal Pradesh that have achieved progress in population stabilisation, education and healthcare.

Calling it an “assault on federalism,” Singh said altering the electoral map without broad consensus would weaken the representation of states that have adhered to national population control goals. He cautioned that women's reservation should not be used as a justification for restructuring the country's political balance.

The minister reiterated that his party supports 33 per cent reservation for women but insisted that it should be implemented immediately within the existing framework. He demanded that the Centre delink the reservation from Census and delimitation processes and ensure its rollout in time for the 2029 general elections.

Women to be given their share at any cost, claims Naveen Jindal

BJP MP Naveen Jindal today blamed the Opposition for non-passing of the 31st Amendment Bill in parliament, brought under the leadership of Prime Minister Narendra Modi to give 33 per cent reservation to women in parliament and state legislatures, alleging that it reflected the mentality of the opposition.

He alleged that the entire opposition united and tried to crush the rights of crores of women of the country. But the intentions of Prime Minister Narendra Modi are so strong that by presenting this bill again, women will be given their respect at any cost, he claim MP Jindal was talking to journalists at the Market Committee office located in Kalayat Grain Market. Before

this, he interacted with the farmers in the market and took stock of wheat procurement arrangements. Jindal also claimed that the government under the leadership of Chief Minister Naib Saini is committed to purchasing every grain of the crop. To bring transparency in the mandis, many new systems including biometric system have been implemented. Its purpose is to understand the schemes that the government is bringing in the interest of farmers. There should be no corruption in them and farmers should get direct benefits. He said that due to the revolution in the agricultural sector, the yield is continuously increasing. Crop yields are increasing due to technical farming and improved seeds. In such a situation, there

is less space in the markets. He said that they will consider how crops are managed in foreign countries so that similar small systems can be implemented here to store the crops and save them from spoilage.

Regarding sports, Jindal said that he has given instructions to his team to visit wherever there are stadiums.

After identifying them, a report should be prepared so that by bringing them to the notice of this government, these stadiums can be made suitable for players to play. He said that sports is the only way to keep the youth away from drugs.

Along with this, he also told that the target is given to the officers in the Disha meeting. They themselves review it in the next meeting. If any officer tries to mislead,

action will be taken against him, he added. Iran's representative downplays Hormuz shooting, says ties with India very strong

Iran's representative in India downplayed concerns over the reported shooting at two Indian-flagged ships in the Strait of Hormuz, stressing strong bilateral ties and calling for peace. India flagged "deep concern" and summoned the Iranian envoy after the vessels were fired upon by IRGC forces.

New Delhi.(Agency)
Iran's representative of the Supreme Leader in India, Dr Abdul Majid Hakeem Ilahi, on Sunday played down concerns over the reported shooting involving two Indian-flagged ships in the Strait of Hormuz, saying he was not aware of the specifics of the incident. "The relationship between Iran and India is very strong, and I don't know anything about this event which you mentioned. We hope that it will be okay, and it will be solved," Ilahi said while talking to news agency ANI.

Ilahi also stressed that Tehran does not seek further escalation and remains committed to peace in the region. "We don't want this war. We want peace, and we hope that the other side will also follow peace so that we can have a peaceful area," he said.

His remarks come amid heightened tensions in the strategic waterway, which has seen increased friction linked to the broader US-

Iran standoff. INDIAN SHIPS COME UNDER FIRE

Two Indian-flagged merchant vessels, including a supertanker, came under gunfire on Saturday while attempting to transit the Strait of Hormuz, according to the Ministry of External Affairs (MEA). The ships were forced to reverse course after firing by Iran's Islamic Revolutionary Guard Corps (IRGC).

The supertanker was carrying nearly 2 million barrels of Iraqi oil. Audio intercepts indicated IRGC gunboats fired during the encounter as vessels were redirected westward. The United Kingdom Maritime Trade Operations (UKMTO) centre also confirmed that two IRGC gunboats opened fire on a tanker in the strait.

Earlier reports indicated gunfire between the Qeshm and Larak islands, with vessels



abruptly. A container ship was also reportedly hit, according to a maritime security source. Several ships also picked up VHF broadcasts declaring the Strait of Hormuz "completely closed again".

"Attention all ships, regarding the failure of the US government to fulfil its commitment in the negotiation, Iran declares the Strait of Hormuz completely closed again. No vessel of any type or nationality is allowed to pass

through the Strait of Hormuz," the message said.

INDIA FLAGS 'DEEP CONCERN'

India summoned the Iranian ambassador to lodge a formal protest, flagging its "deep concern" over the incident. One of the vessels involved was identified as Sanmar Herald, a government source said, adding that the crew and the ship were safe.

The MEA said India's top foreign ministry official urged the envoy to convey New Delhi's concerns to Iranian authorities and called for the early resumption of safe passage for India-bound ships. The ambassador assured that the concerns would be communicated. Authorities said the Directorate General of Shipping is closely monitoring the situation and taking steps to ensure the safety of Indian seafarers and vessels in the region.

LG Taranjit Singh Sandhu flags traffic, parking reforms at Delhi heritage event

Lieutenant Governor Taranjit Singh Sandhu on Saturday participated in DDA's Delhi Heritage Week at Mehrauli Archaeological Park, maintained by the Delhi Development Authority. "Mehrauli park has been restored by DDA as part of its redevelopment project. We want people to come and see the 'ease of living' efforts by the DDA," LG said.

Highlighting infrastructure concerns, the LG said the traffic situation in the national capital will be improved. "A new system will be adopted in Delhi to eliminate the problem of illegal roadside parking. Additionally, modern technology will be used for better management of street lights and traffic in the capital. Extra steps will be taken to enhance women's safety in Delhi," he said.

He added that Resident Welfare Associations (RWAs) will be involved in addressing traffic congestion. "Local-level RWAs will work in coordination with Delhi Traffic Police. Wherever there are problems of illegal parking and traffic, emphasis will be placed on implementing this system at those locations first," Sandhu said.

The LG also said he has been continuously engaging with citizens. "The general public wants that if a road is in poor condition, it should be repaired immediately," he added.

In a post on X, Sandhu described the event as "a magical evening" celebrating heritage. He highlighted a "soulful tribute to Delhi's rich cultural and architectural legacy," mentioning the welcome dance, a Qawwali performance by the Niazi Nizami Brothers, and exhibitions by DDA and ASI that showcased ongoing conservation efforts.

Chaos erupts during polls to Gargi College council

Chaos erupted during student council elections at Delhi University's Gargi College on Friday, with rival student groups and a candidate alleging intimidation, misconduct, and irregularities in the polling process.

Videos circulating on social media showed a presidential candidate claiming she was "treated disrespectfully" and physically pushed out of the campus by teachers after her political leanings became known. She alleged she was made to wait for hours and pressured to sign documents certifying that the elections were being



conducted fairly. She further claimed ballot boxes were not inspected before polling and voting began without her signature.

The Akhil Bharatiya Vidyarthi Parishad supported the candidate's allegations, claiming the administration tried to coerce her into withdrawing her nomination, denied her entry during voting and counting, and subjected her to "rude and disrespectful" behaviour. ABVP's Delhi state secretary Sarthak Sharma demanded that the polls be annulled and fresh elections conducted, alleging the process was manipulated.

Sharma said the candidate sought help from DUSU president Aryan Mann and maintained she had no formal affiliation with ABVP. He also alleged that Left-affiliated students raised slogans when Mann arrived.

Meanwhile, the Students' Federation of India (SFI) accused ABVP members of forcibly entering the campus and engaging in intimidation. It alleged hooliganism and attempts to disrupt the campus environment. AAP leader Saurabh Bhardwaj questioned police inaction and demanded an FIR.

Torch rally in Imphal West turns tense, tear gas used to disperse protesters

A torch rally in Imphal West's Sagolband on Saturday turned tense after security forces used tear gas to disperse the protesters amid a fresh spurt of violence in Manipur. The agitators were demanding accountability for the deaths of two children in Tronglaobi.

The protest was part of a series of demonstrations across Manipur. The participants were shouting slogans while holding torches when the security personnel resorted to tear gas firing. The smoke reportedly created confusion and panic in the area with residents rushed to safer areas.

There were chaos and confusion in the area as shells were fired in quick succession. Several of the protesters were arrested by the security forces. Heavy security was later deployed in

the area to suppress any flareup.

Public resentment building ever since the April 7

Public resentment has been building ever since the April 7 attack on a residential house at Moirang



Tronglaobi village in Bishnupur. Suspected militants launched rocket bombs at a house resulting in the deaths of a five-year-old boy and his five-month-old sister. Their mother suffered injuries in the attack.

According to reports, five suspects

from United Kuki National Army have been taken into custody in relation with the case.

The protesters allege that despite prolonged instability the security agencies have failed to prevent violence in the state.

Two killed in an ambush in Ukhrul

Meanwhile, a retired Army personnel was among two persons shot dead by suspected militants in an ambush in Ukhrul district on Saturday. The incident took place at T M Kasom village in Litan police station area in the afternoon.

The deceased were identified as Chinaoshang Shokwungnao, a retired Army personnel, from Tashar village; and Yaruingam Vashum from Kharasom village. Chief minister Y Khemchand Singh announced that the probe in the incident will be handed over to the NIA.

Deer no dear: Villagers in Chhattisgarh rescue Chital from dogs before killing it for meat, arrested

New Delhi.(Agency)

The deer at first thought that it was being rescued from a pack of dogs in Chhattisgarh's Raigarh district. But then, the rescuers themselves turned into predators, with the villagers allegedly killing and eating it.

In the Raigarh forest division's Delari village, a spotted deer (commonly known as Chital in India), while searching for food and water, strayed into the village from nearby forests. Its entry into the habitation proved to be dangerous as a pack of dogs chased and injured the animal.

According to reports, some villagers first saved the injured deer by dispersing the dogs. But later, those who saved the animal allegedly killed it and divided its meat among themselves.

Accused arrested, sent to judicial custody

The forest department got a tip-off that several houses in the

village was consuming venison and it dispatched a team to the place. The team conducted raids and recovered pieces of deer meat from five homes, and have sent the samples for forensic test. The law enforcement first detained the



five accused, Mayaram Rathia, Atmaram Rathia, Tarun Agaria, Haricharan Sao, and Motilal Agaria and later arrested them after they allegedly confessed to the crime while being questioned.

Raigarh forest division SDO Tanmay Kaushik has reportedly said that the team found remains of the animal in five houses and they have

sent the samples for examination. The department is probing the matter and further action will be taken once the report comes. A case has been registered against the accused under sections of the Wildlife Protection Act, 1972.

How NDA aims to convert Lok Sabha defeat into an opportunity with women voters

NDA setback in Lok Sabha: During voting in the Lok Sabha on Friday night, 528 MPs voted for the amendment Bill. With 352 votes required for the passage, the government could secure only 298 votes, while the Opposition got 230.

Days after suffering a rare setback in the Lok Sabha, the NDA government is attempting to turn the defeat of its women's reservation amendment into a political opportunity, with the governing alliance led by BJP betting on its outreach to women voters and framing a narrative against the opposition — presenting them as being anti-women.

The Constitution amendment, which proposed implementing 33 per cent reservation for women by 2029 along with a 50 per cent increase in Lok Sabha seats, failed to secure the required majority after the Opposition opposed the legislation. While the outcome handed the Opposition a moment of unity, the NDA has moved quickly to frame the defeat as resistance to women's empowerment.

Numbers and the setback

During voting in the Lok Sabha on Friday night, 528 MPs voted for the amendment Bill. With



352 votes required for the passage, the government could secure only 298 votes, while the Opposition got 230.

For the first time since 2014, the BJP-led government failed to push through a legislative proposal. The outcome has triggered speculation over whether the government anticipated the numbers and whether the special session was also aimed at shaping a political narrative. Had the bill

passed, the government would have claimed credit; its defeat now allows it to target the Opposition.

Reframing the loss

The government's response has been swift. Prime Minister Narendra Modi, in an address to the nation, targeted Opposition parties, saying women would not "forgive" them for blocking the measure.

Within the NDA, there is an acknowledgement that the defeat is an embarrassment. However, leaders believe the issue can still be leveraged to consolidate support among women voters — a constituency that has played a major role in recent electoral successes for the alliance. In the ongoing assembly elections too, the women are being heavily courted by the political parties. The BJP is already on the ground with protests and sloganeering. While the senior party leaders including Smriti Irani, Kiren Rijiju addressed press briefings.

Army officer injured during para training in Ballari, airlifted to Bengaluru

The personnel was identified as Colonel Chinnaraj. According to reports, the PD Halli area of Ballari has long been used as drop zone for para training exercises with aircraft taking off from Bengaluru and the participants landing in the outskirts of the district.

Colonel Chinnaraj was part of a group of 417 soldiers participating in the training. After jumping from the sky from a height of 800 feet his parachute stopped functioning properly at around 50 feet from the ground, according to reports. This led to a loss of balance after which he fell and suffered serious injuries to his leg.

Ballari SP confirmed the incident

Ballari Superintendent of Police confirmed that a minor incident occurred during the parachute dropping training at the Army centre, according to a Republic report.

"There was a minor incident during a parachute dropping training at the Army Centre. The Army has not given any report so far. Army has brought the helicopter and airlifted injured to Bengaluru.

They have not told the police anything yet, so we can't confirm anything officially. Army has informed one person is injured. This was annual training.

When incident happened, he was airlifted to Bengaluru," the SP said. According to a Deccan Chronicle report, the training exercises are conducted at all times except during the monsoon. These exercises go on for several days.

Heinrich Klaasen unbothered by strike-rate critics after crucial win vs CSK

Ahmedabad. (Agency)

Retired South African-batter Heinrich Klaasen has shut down his critics over his slow strike rate after Sunrisers Hyderabad secured a 10-run victory over Chennai Super Kings at the Rajiv Gandhi International Stadium in Uppal on Saturday. The former South African batter, leading the charts with his bat, brought up his 10th fifty in the Indian Premier League, helping SRH post a respectable total to defend. With 283 runs under his belt in six games, Klaasen has come under consistent scrutiny for his strike rate. In IPL 2026, Klaasen has been scoring at a strike rate of 144.39, far lower than his previous season highs of over 170. "I know there's been a lot said about my strike rate this season, but I've been putting the team in good positions, and I'm just doing my job," Klaasen told reporters after the game on Saturday. Against CSK, Klaasen brought up his fifty in 31 balls before Anshul Khambhoj got the better of him. His innings included six fours and two sixes at a strike rate of 151.28. "I've been in difficult situations, and you have to take responsibility and be mature about it. You can't just deal with it like that—that's not



how the game works. We get paid to do the job, and I don't care about strike rate. You just have to be mature about it and find different ways of scoring 10 runs an over and making sure that you still get a good score on the board," he added. EYE GYM FOR REFLEXES?

The South African batter explained how going to an 'eye gym' back in Cape Town during the off-season had helped him sharpen his reflexes. "It's all a personal programme for yourself, and it's just a big tool to make decisions under pressure. It's about a 10-minute session a day, and you make about four to five hundred decisions in that time under pressure, within a certain timeframe and reaction work," Klaasen explained. "I'm still keeping up with the pace of the game, and that's kept me at ease—not to play more cricket because 150 doesn't feel like 150 when you're seeing the ball nicely. When you feel out of sync, 135 feels like 150, and that's not happening."

Made Ayush Mhatre run when limping! Ashwin slams CSK's shocking injury management

In a scathing critique, veteran spinner Ravichandran Ashwin has launched a blistering attack on Chennai Super Kings' (CSK) medical and management protocols. The flashpoint? The visible physical distress of rising star Ayush Mhatre during Chennai Super Kings' defeat to Sunrisers Hyderabad on Saturday - a scene Ashwin described as nothing short of "shocking."

Ayush Mhatre has been one of the breakout stories of the season, but his meteoric rise hit a harrowing roadblock. Despite being utilized as an Impact Player to shield him from fielding duties, Mhatre appeared for his knock with a heavy strap on his knee. The situation turned from concerning to controversial when Mhatre began visibly limping between the wickets in the powerplay in CSK's unsuccessful chase of 195. Despite physios checking on him, CSK



took the call to let him continue batting in the fifth over. To make matters worse, Ruturaj Gaikwad, their captain, called Mhatre for a quick single, knowing Mhatre was in serious discomfort.

The teenager started limping across the 22 yards and was in danger of getting run-out at the striker's end as he completed the single. However, in the very next delivery, Mhatre was caught at mid-off when he tried to clear Nitish Kumar Reddy's full-length delivery over the in-field. The young batter was on 30 off 17, but the unfortunate injury led to his early dismissal. Ashwin, never one to mince words, was appalled by the decision to keep the youngster on the field. "Ayush Mhatre's injury: I hope he is back, but by the look of it, I fear he will be out for a while," Ashwin said in his YouTube show.

Full-time doctor, full-time marathon runner: Kartik Karkera eyes Asian Games gold

Kartik Karkera has emerged as a wildcard in the Indian marathon scene. The Orthopedic doctor has won the Mumbai and Delhi marathons, at a pace that makes him one of India's fastest marathoners of all time. Currently in Nashik, Kartik speaks to India Today about his dream of winning Asian Games gold and representing India at the Olympics.

Kartik Karkera was 15 when the question was hurled towards him for the first time: do you want to focus on your studies, or do you want to become a runner? Hailing from a middle-class family in Mumbai, Kartik knew that the question was rhetorical. In India, what is often presented as a choice usually has a very clear answer. Studies, said the bright 15-year-old Kartik, shelving the multiple medals that he had won in school competitions in Mumbai. Like most middle-class children, he chose certainty. He put his head down, cleared his exams, and left for Russia in 2016 to study MBBS. Kartik lived in Russia for seven years, completing his MBBS and a

post-graduation in orthopaedics and traumatology. He passed his Foreign Medical Graduate Exam in January 2024 to be eligible for practice in India, when the same question returned for the second time in his life. What did he actually want? Did he want to become a doctor, or did he want to pursue his passion of becoming a runner?

Only this time, the answer was not already decided for him. While working as a resident at the Dr Vasant Pawar Medical College and Hospital in Nashik, he started pursuing his old dream of becoming a professional athlete. The work was unforgiving. Hospital shifts stretched endlessly, training sessions had to be squeezed into the cracks of the day, and sleep often became negotiable. But despite the impossible grind, results soon followed.

INDIAN MARATHON WAKES UP FROM SLUMBER

Running only in his third competition ever, the 28-year-old beat Olympian T Gopi and 2024 Asian Marathon winner Man Singh to clinch the Delhi Marathon in April. More importantly, Kartik recorded his personal

best, 2:13:10, faster than the Athletics Federation of India's (AFI) qualification standard of 2:15:04 for the Asian



Games. What Kartik had done was sudden, almost disruptive. From someone unknown in Indian athletics circles, Kartik had suddenly become one of the fastest marathon runners in the history of India. Only days after his Delhi Marathon win, Sawan Barwal broke the 48-year-old national record of Shivnath Singh, clocking 2:11:58 in Rotterdam. This meant that in a space of just a few days, T Gopi and Man Singh were no longer the automatic favourites for the Asian

Games. Kartik and Sawan had entered the conversation. The stagnant Indian marathon scene had been woken from its slumber once again. Speaking to India Today from Nashik, Kartik laughed at the idea that he had become an overnight sensation after his exploits in Delhi. "People are calling me an overnight success. They do not see the 10 years of hard work that I have put behind this," Kartik said. He does not see the days that I used to cry and call my father that, OK, I think I need to leave one thing. I need to stop. Maybe I need to become a doctor or a runner."

RUNNING AFTER 36-HOUR HOSPITAL SHIFTS

Kartik Karkera is an anomaly. And it does not take long to understand that. In a demanding ecosystem like India, it is difficult enough to sustain a career in medicine. Doing so while training as a professional marathon runner is something else entirely, especially in a sport that offers very little financial certainty. If balancing the two was hard enough, Karkera says that when he returned to India and started working in the hospital, many of his fellow senior doctors were not sympathetic.

BCCI to extend Ajit Agarkar's tenure as Chief Selector with 2027 World Cup in focus

Ajit Agarkar is set for an extension as chief selector, with BCCI backing his tenure after India's ICC success, despite Test setbacks, ahead of the 2027 ODI World Cup.

Ajit Agarkar is set to receive an extension as India's chief selector, with the Board of Control for Cricket in India keen to maintain continuity ahead of the 2027 ODI World Cup. Agarkar's current tenure is due to expire in June 2026, but sources indicate that the board has been impressed by both the results and the transition overseen during his stint. India's recent success in white-ball cricket has been a key factor in the decision, with the team securing multiple ICC titles under his watch. "Under Agarkar's tenure, the team had a seamless transition and was fearless in taking bold decisions and that's the reason board felt he should continue Agarkar's contract. Will be renewed which is expiring in June 26," sources told India Today. India won the T20 World Cup in 2024 and successfully defended it in 2026, in addition to lifting the Champions Trophy in 2025. The side also reached the final of the 2023 ODI World

Cup at home, reinforcing the perception of sustained excellence in limited-overs cricket. One of the standout achievements



during Agarkar's tenure has been the evolution of India's T20I setup. The team has embraced a fearless, flexible approach, with bold selection calls playing a defining role. The squad composition for the 2026 T20 World Cup, in particular, drew attention for prioritising balance and form over reputation, even leaving out high-profile names such as Shubman Gill. While the white-ball sides have largely

thrived, India's Test performances have raised concerns. The team endured rare home series defeats against New Zealand in October 2025 and South Africa in November 2025, marking a break from their long-standing dominance in familiar conditions. However, there were mitigating factors. India competed strongly in challenging circumstances, including a hard-fought 2-2 series draw despite the retirement of key players like Virat Kohli, Rohit Sharma and limited availability of Jasprit Bumrah.

The overall body of work, particularly in white-ball cricket, has convinced the BCCI that Agarkar's leadership has brought clarity and direction to the selection process. His willingness to make tough calls and back a new generation of players is seen as central to India's recent success. With the ODI World Cup cycle now underway, the board is keen to avoid disruption and ensure stability in team-building, making Agarkar's extension a logical step as India look to build on their recent momentum.

Manchester City vs Arsenal preview: Guardiola's final chance to win Premier League

Man Utd captain Bruno Fernandes in a rush to seal Champions League qualification

Manchester United boosted their Champions League hopes with a 1-0 win over Chelsea FC, extending the hosts' losing streak to four matches. Captain Bruno Fernandes starred with an assist as Chelsea's top-five ambitions continued to fade amid a prolonged goal drought.

With Champions League qualification on the line, it was Michael Carrick's Manchester United who came out as 1-0 victors against a struggling Chelsea side on Saturday night at Stamford Bridge. This was Chelsea's fourth straight loss, further dimming their chances of securing an automatic qualification spot for next season's Champions League. With

just five games left in the season, the race for a top-five finish is intensifying as teams battle for the remaining Champions League places. Captain Bruno Fernandes, who provided the assist for Matheus Cunha's winner late in the first half, wants the team to get the job done swiftly and efficiently. "It's an amazing feeling for us. We had to bounce back after two games that we didn't win," Fernandes told TNT Sports post-match. "I feel three points closer now, but we have another game that we have to win. We know we need points to get that place secured, and we will do everything possible to be as quick as possible. We knew we had to put in a great performance because Chelsea are a good side. It's important for us because our aim is to finish in the top four, so creating some distance is perfect for us." Fernandes has Premier League history in his sights, as his assist for Cunha was his 18th of the season. This puts him behind only Manchester City's Kevin De Bruyne with 20 (2019-20),

Thierry Henry with 20 (2002-03), and Mesut Ozil with 19 (2015-16)—the players with the most recorded assists in a single season.



United, who lined up with a depleted defence for the all-important game, remained third on the league table with 58 points, 10 clear of sixth-placed Chelsea with five games left to

play. **UNITED EDGE CLOSER, CHELSEA RUN OUT OF TIME**

On the other hand, Chelsea, who were boosted by the return of their star midfielder Enzo Fernandez, previously suspended for his comments over a potential move to Madrid, fell short of scoring despite hitting the bar twice and the post once.

"In terms of the game tonight, it's a really, really difficult one to take because people don't want to hear me say how well we played and didn't win the game. We're here to win," Chelsea head coach Liam Rosenior said post-match, as quoted by The Guardian. "It doesn't look like it at the moment, but the reality is Manchester United have come in, had one shot, scored, and won the game 1-0, which should be pretty much impossible."

One dead, six injured in Nuerburgring multi-car crash featuring Max Verstappen

Bengaluru. (Agency)

Four time Formula One champion Max Verstappen was set to compete at the ADAC 24h Nuerburgring qualifiers on Saturday, but the event was overshadowed by a fatal crash that left a 66 year old driver dead and six others injured. The accident took place during the opening race at the Nuerburgring Nordschleife, one of the most demanding circuits in motorsport, with seven cars involved in a multi car collision in the early stages. Race control immediately halted proceedings to allow for extensive recovery and rescue operations, bringing an abrupt end to what was scheduled to be a four hour race.



Despite the swift arrival of emergency services, the driver, identified as Juha Miettinen, could not be saved. He was extracted from his BMW 325i and transported to the circuit medical centre, where he died after all attempts at resuscitation proved unsuccessful. Organisers later confirmed that the remaining six drivers involved in the incident were taken to the medical centre and nearby hospitals for precautionary examinations, with none suffering life-threatening injuries. Officials also announced that the race would not resume on Saturday, with the remainder of the day programme cancelled. A minute silence is set to be observed during the grid formation ahead of Sunday race in memory of Miettinen, as the motorsport community comes to terms with the tragedy.

Who is Juha Miettinen?

Juha Miettinen was a 66 year old racing driver competing in the Nuerburgring endurance qualifiers, part of the build up to the iconic 24 hour race held annually at the circuit. Driving a BMW 325i, Miettinen was among a diverse field that typically includes both professional racers and experienced amateur competitors.

While he was not a high profile name on the global racing stage, Miettinen represented the spirit of endurance racing, where passion for the sport often brings together drivers from varied backgrounds to compete on equal terms. Events at the Nuerburgring, particularly on the Nordschleife layout, demand a high level of skill, focus and familiarity with the circuit, making participation itself a mark of experience.

India's banks remain resilient supported by asset quality, credit momentum: Report

New Delhi, (Agency)

India's banking sector remained resilient, supported by improved asset quality, strengthening capital buffers, robust retail and SME credit momentum, and early signs of revival in private capital expenditure, a survey showed on Sunday.

The survey from FICCI and Indian Bank Association (IBA) said the banking sector maintains a broadly constructive outlook on credit growth over the near term, supported by improving balance sheets, steady economic activity, and sustained demand across multiple segments of the economy. Respondents expect current monetary policy to remain broadly stable in the coming months, suggesting that the existing policy framework remains appropriately calibrated to balance growth and inflation considerations. Only cooperative banks stood, with all respondents expecting a 25-basis point rate increase.

Expectations regarding overall credit expansion remain positive, with banks anticipating continued momentum in non-food credit, the report said.

Public Sector Banks (PSB) appear particularly confident in the outlook, reflecting improved asset quality, stronger capital positions, and increasing traction in corporate lending. Private banks demonstrated a balanced and selective approach to credit growth, while foreign banks displayed moderate optimism consistent with their focused exposure to corporate and institutional segments, the report noted. Sectorally, credit demand from services and retail segments is expected to remain a key driver of overall lending growth. The services sector outlook reflected strong expectations of expansion, supported by activity in real estate, financial services, logistics, and tourism-related industries.

HDFC Bank Q4 profit rises 9.1% to Rs 19,122 crore; board declares final, special dividends

New Delhi, (Agency)

The largest private sector lender, HDFC Bank, has reported a healthy set of numbers for the March quarter, with a 9.1% year-on-year growth in standalone net income at Rs 19,122 crore. For the full year, profit grew 10.9% to Rs 74,670 crore.

The key operational metric, net interest income, grew at a tepid 3.2% to Rs 33,080 crore in the March quarter. However, a drop in provisions and robust fee income, including higher treasury gains despite a marginal hit due to the Reserve Bank-ordered forex unwinding, supported earnings. The bank did not disclose the quantum of the forex hit. Total revenue grew 5% to Rs 46,280 crore for the quarter.

Key profitability metric net interest margin stood at 3.38% on total assets for the quarter and at 3.53% for the full year based on interest-earning assets. Asset quality improved, with gross non-performing assets (GNPA) declining to 1.15% from 1.33%, while net non-performing assets fell to 0.33% from 0.38%. Provisions and contingencies for the quarter stood at Rs 2,610 crore, while the total credit cost ratio was 0.35. Other income rose to Rs 13,200 crore, of which fees and commissions contributed Rs 9,220 crore, up from Rs 8,530 crore. Gains from foreign exchange and derivatives stood at Rs 1,490 crore, up from Rs 1,440 crore, while net trading and mark-to-market gains rose to Rs 820 crore from Rs 390 crore. Miscellaneous income, including recoveries and dividends, stood flat at Rs 1,670 crore, the bank said during the concall on Saturday. Expenses rose to Rs 18,480 crore from Rs 17,560 crore, while the cost-to-income ratio stood at 39.9.

India's LPG consumption drops 13% in March amid Middle East supply disruptions

New Delhi, (Agency)

India's cooking gas consumption saw a sharp decline in March, with LPG usage falling 13 per cent year-on-year due to supply disruptions linked to the ongoing Middle East conflict, according to official data.

LPG consumption stood at 2.379 million tonnes in March, down from 2.729 million tonnes in the same month last year. The decline comes as disruptions in the Strait of Hormuz, a key route for India's fuel imports, impacted supplies from major exporters like Saudi Arabia and the UAE. Household supply prioritised, commercial usage hit hard. To manage shortages, the government curtailed LPG supply to commercial establishments such as hotels and industries, prioritising household consumption.

According to the news agency PTI, LPG sales to domestic users fell by 8.1 per cent to 2.219 million tonnes. The impact was far more severe on non-domestic segments. LPG sales to commercial users dropped nearly 48 per cent, while bulk LPG consumption plunged by a massive 75.5 per cent.

The data from the Petroleum Planning and Analysis Cell (PPAC) contrasts with government claims that household demand was being fully met.

Domestic production boosted to offset imports. With India importing around 60 per cent of its LPG needs, the disruption forced authorities to ramp up domestic output. Refineries were directed to divert feedstock from petrochemical production to LPG manufacturing. As a result, LPG production rose to 1.4 million tonnes in March from 1.1 million tonnes a year earlier, reported PTI. For the full 2025-26 fiscal, production increased to 13.1 million tonnes, compared to 12.8 million tonnes in the previous two years. Despite the March dip, overall LPG consumption for the fiscal year rose 6 per cent to 33.212 million tonnes, reflecting steady long-term growth driven by cleaner fuel adoption.

What is the difference between HRA, DA, and DR? Explained In detail

If you have ever looked carefully at your salary slip or a government employee's pay structure, you have probably noticed several allowances listed below the basic pay figure. Three of them — House Rent Allowance, Dearness Allowance, and Dearness Relief — appear regularly and are often confused with each other. They sound related, and in some ways they are. But they serve entirely different purposes, are calculated differently, and apply to different groups of people. Here is a clear explanation of each one. House Rent Allowance, universally abbreviated as HRA, is a component of salary specifically designed to help employees cover the cost of renting a place to live. It acknowledges a basic reality: if you work in a city, you probably need to pay rent, and rent is expensive, especially in large urban centres. The amount of HRA you receive depends on where you live. The

government classifies Indian cities into tiers based on population. Employees living in metro cities like Mumbai, Delhi, Kolkata, and Chennai, along with Bengaluru, Hyderabad, Pune, and Ahmedabad under the new 2026 rules, receive HRA equal to 50 percent of their basic salary. Those living in other cities and towns receive 40 percent of basic salary. The logic is simple — rent is higher where more people live, so the allowance is proportionally larger.

HRA is paid to working employees only. If you are retired, you do not receive HRA. And crucially, HRA is not automatically tax-free. The actual tax exemption you can claim on HRA depends on three factors calculated together: the HRA you actually received, the rent you actually paid minus ten percent of your basic salary, and fifty or forty percent of your basic salary depending on your city. Whichever of these three calculations

produces the smallest number is the amount you can exempt from tax. The remaining portion is taxable income. One important rule: if you live in a house you own, you cannot claim any HRA tax exemption. The allowance is specifically for people paying rent to someone else. However, if you pay rent to a parent or family member and can prove it with documentation, the exemption applies. Dearness Allowance — protection against rising prices for working employees — Dearness Allowance, known as DA, is a completely different kind of payment. It has nothing to do with housing.

It is entirely about inflation — specifically, protecting the purchasing power of employees whose salaries would otherwise lose real value as prices rise around them. The concept is straightforward. Suppose you earned Rs 50,000 per month last year and prices

across the economy have risen by six percent since then. Your salary buys six percent less than it used to. DA is the government's mechanism to compensate for that loss. It is calculated as a percentage of basic pay and revised periodically — twice a year for central government employees — based on changes in the All India Consumer Price Index for Industrial Workers, commonly called the AICPI-IW. DA applies to working employees — both government employees and, in many cases, employees of public sector undertakings. It is linked to active employment. The moment you retire, DA as such stops applying to your salary. Because DA is tied to inflation data that changes over time, it is not a fixed number. When inflation is high and prices are rising quickly, DA rises to compensate. When prices stabilise, DA adjustments are smaller.

China-India trade deficit balloons to USD 112.16 billion as India is behind 25-30 years in most industrial metrics — But leads in this area

The President of the Federation of There is a number buried inside India's FY26 trade data that deserves more attention than it has received. India's trade deficit with China — the gap between what India buys from its northern neighbour and what it sells back — hit USD 112.16 billion in the financial year ending March 2026. That is an all-time record. It is larger than India's entire annual defence budget. It is roughly the size of the entire economy of Morocco. And it did not happen by accident.

To understand why India's China deficit keeps growing, you have to go back further than last year's trade data. You have to go back 35 years — to 1990, when India and China were, by most measures, economic equals. When both countries started from the same place

In 1990, India's GDP per capita was approximately USD 370. China's was USD 350. India was actually marginally wealthier on a per-person basis. Both countries were poor, agrarian, and largely closed to the world. Both were home to over a billion

people. Both had everything in front of them. Then they made different



choices. China, beginning in the late 1970s under Deng Xiaoping and accelerating through the 1980s and 1990s, threw its weight behind manufacturing. The state directed capital toward factories, infrastructure, and export capacity. It built ports, roads, and industrial zones at a scale and speed the modern world had not seen. It brought hundreds of millions of people from fields into factories, raised their productivity, and made Chinese goods the default input for the entire global economy.

India chose a different path. It opened its

economy in 1991 following a balance-of-payments crisis, but the liberalisation was incomplete. Manufacturing never became the centrepiece of India's growth story the way it did for China. Instead, India grew through services — IT, software, outsourcing, finance. These sectors created wealth for millions but did not absorb the vast low-skilled rural workforce the way factory floors would have. India's manufacturing sector today contributes roughly 17 percent of GDP. China's contributes around 28 percent. The gap between those two numbers represents roughly 28 years of divergence. The numbers that show the distance by 2025, the consequences of those choices had compounded into a chasm that is difficult to look at directly.

China's GDP per capita is USD 13,806. India's is USD 2,818. China is 4.83 times richer per person. To find a year when China had roughly the same per-capita income as India does today, you have to go back to around 2005. India is, on this measure, approximately 20 years behind.

Akshaya Tritoaya 2026: Gold, silver trade likely to cross Rs 20,000 crore despite high prices, low volumes

Record-breaking sales of precious metals are expected on Akshaya Tritoaya 2026, with total trade expected to exceed Rs 20,000 crore, even as soaring prices influence how India buys gold and silver, according to the Confederation of All India Traders (CAIT). This is set to be a notable jump from last year's estimated Rs 16,000 crore, despite bullion rates touching unprecedented highs. "Akshaya Tritoaya has traditionally been one of India's most auspicious occasions for purchasing gold... While gold continues to dominate, the nature of purchasing is evolving significantly in response to steep price escalation," said Praveen Khandelwal, Member of Parliament from Chandni Chowk and Secretary General of CAIT. Gold prices have surged from around Rs 1,00,000 per 10 grams last year to nearly Rs 1.58 lakh this year, while silver prices have

jumped from Rs 85,000 per kg to an unprecedented Rs 2.55 lakh per kg. Rather than kill demand, CAIT said the



spike is pushing consumers toward "more calculated and value-driven purchases"

"There is a clear shift towards lightweight, wearable jewellery, alongside a stronger focus on silver and diamond products. Attractive incentives such as reduced making charges and complimentary gold coins are also helping sustain consumer

interest," said CAIT National President BC Bhartiya. The value-volume divergence is stark. Pankaj Arora, National President of the All India Jewellers and Goldsmith Federation (AIJGF), an associate of CAIT, said the projected Rs 16,000 crore gold trade translates to about 10,000 kilograms (10 tonnes) at current prices. Spread across an estimated 2 to 4 lakh jewellers, that means average sales of just 25 to 50 grams per jeweller — "clearly indicating a sharp decline in volume". The Rs 4,000 crore silver trade equals roughly 1,56,800 kilograms (157 tonnes), implying an average of only 400 to 800 grams per jeweller during the festival. "These figures underline a critical shift: while the value of business is expanding due to rising prices, actual consumption is contracting," Khandelwal said. That explains the rising popularity of lightweight jewellery and small-denomination coins this year.

Why your car insurance may not pay when you need it most

An accident, a flooded road, a damaged engine, and a car insurance claim is filed with the expectation that the insurer will step in. But for many, that moment turns into something else entirely: confusion, partial payouts, or in some cases, outright rejection.

For most vehicle owners, motor insurance is something you buy once and forget about. It sits quietly in your inbox, renewed every year, until the day something goes wrong.

That is when the real test begins.

An accident, a flooded road, a damaged engine, and a car insurance claim is filed with the expectation that the insurer will step in. But for many, that moment turns into something else entirely: confusion, partial payouts, or in some cases, outright



rejection. The problem, experts say, is not always the insurer. More often, it is the gap between what customers think their motor insurance policy covers and what it actually does. Saurabh Vijayvergia, founder and CEO of CoverSure, said that when his team looks into motor insurance claim rejection cases, the reasons are often simple. "Nine times out of ten, the reason is something that could have been avoided entirely," he said.

In many cases, it is a policy that has lapsed because the renewal reminder was ignored. In others, it is a driving licence that expired months ago. Sometimes, it is a modification, like a CNG kit or accessories — that was never declared to the insurer. "These aren't obscure technicalities. Their conditions are well within the insurer's rights to enforce," Vijayvergia explained.

WHY MOTOR INSURANCE CLAIMS

ARE PARTIALLY PAID

Not all motor insurance claims are rejected outright. Many are settled, but not fully.

"The claim isn't rejected, but the customer gets back maybe 60% of what they spent at the garage," he said. The reason is depreciation. In a standard car insurance policy, the value of replaced parts is reduced before reimbursement. So even if you replace a bumper or headlamp, you may not get the full cost back. "Most people don't know this until the cheque arrives," Vijayvergia said.

MOTOR INSURANCE CLAIM REJECTION: IT'S OFTEN AWARENESS, NOT FRAUD

When motor insurance claims get rejected, many customers feel cheated. But the issue is often lack of awareness. "I'll be honest with you, it's almost always awareness. Or rather, the absence of it," Vijayvergia said. He pointed out that most people do not fully understand their motor insurance policy terms and exclusions. "The terms are in the document. But the document is forty pages of dense language handed over with a 'please read carefully'. Nobody reads it carefully. And nobody explains it clearly either."

and flower-bearing indigenous plants should be the only species in gardens here," he said. "By using these plants, one can not only have a beautiful garden, but also contribute towards conserving the environment." Environmentalist Biswajit Roy Chowdhury said the trend of opting for foreign plant breeds has been taking its toll on the local ecosystem. Since these plants are unknown to local birds and insects, they fail to attract them, resulting in ecological imbalance. "Planting a tree is not enough. The real benefits come from the biodiversity that it helps evolve. Foreign plants do not share that relationship with the local ecosystem and end up upsetting the ecological balance," he said.

Another adverse impact of this trend is the destruction of local shrubs, which are being replaced by foreign exotic species like Bougainvillea, Callistemon citrinus and Magnolia grandiflora. "Due to rampant plantation, most native plants are vanishing and fancy shrubs, non-fruit bearing plants and manicured lawns are taking their place," Das said. Roy Chowdhury revealed that some exotic plants also caused pollution by releasing pollens capable of causing respiratory problems and serious allergies. Parthenium is one such species. All of them, however, agree that not all exotic species are harmful. Some, like the sunflower, share a symbiotic relationship with the local environment. On the other hand, Alstonia, an Indian species, can cause respiratory problems. So, it's your turn to create an ecosystem, and not just a garden.

Relocating to new home? Clean it well



If you're relocating to a new home, make sure you clean the walls, toilet seats, drains and pipes well for hygienic surroundings, says an expert.

Here are some tips:

Walls: Start cleaning the walls using the broom. Do it in top-to-bottom direction. Reach out for the webs and dust on the walls and remove all of it.

Glass surfaces:

Whether it is window glass, door glass, shower glass or mirrors, all are equally prone to getting scratched if a hard sponge is used. Use a soft (cotton) cloth to dust these and then clean them using window or glass cleaning

agents.

Toilets and toilet seats:

The toilet seat can be cleaned using a sponge soaked in liquid soap water mixture. Just add disinfectant or an antiseptic along with the liquid soap. For the toilet bowl, use a cleaning agent and leave it on for some time.

Drains and pipes:

Use a plunger on all pipes and drains, even if they don't appear to be clogged. Check for open drains which permit entry for rats and cockroaches. Place drain covers on such openings.

Do not miss:

Sink drains (kitchen drainage system), bathroom drains (shower, tub, wash basin and toilet) and balcony drains.

Kitchen:

Use strong cleaning agents with care - especially in areas where you plan to store food. Note presence of pests - especially stubborn cockroaches and tell tale signs of rats. If you spray any pesticides and use rat poison, air the kitchen for a day before unpacking food stuff.

It was happy start for wannabe gardener Soumita Banerjee when she decided to beautify her home with some exotic plants.

So, off she dashed to the Gullif street market, bought all kinds of ornamental plants and started her very own garden! A few months later, however, when her garden was in full bloom, she noticed that it was not attracting butterflies or insects. Sure something was amiss, she contacted gardening consultant, Somnath Pal Das.

To her amazement, Das asked her to replace the exotic plants with some local shrubs, which Soumita knew as nothing but weeds. She did so, and within a few weeks, saw her garden transform. "I had no idea local plants could be this beautiful. They are also attracting butterflies and birds to the garden," said Banerjee, while watering a bunch of Nayantara picked up from a neighbourhood pavement. She has also replaced all the exotic plants with five more local species, including Catharanthus roseus (Nayantara), Ixora coccinea (Rangan) and Gardenia jasminoides (Gandharaj).

Das said gardening with the local plant species is not only pocket-friendly, but also helps the environment. "Kolkata is in a tropical region with lots of water and good soil. There are thousands of local plants that one can use for gardening," he said, adding that a mid-sized garden won't cost anything more than '500 to '700. "Most of these plants grow everywhere in the state, so they don't need additional fertilizers or extra care." Environmentalist HS Debnath also recommends trees like the banyan, mango, neem or palm that not only yield seasonal fruits but also attract birds and animals. "Fruit
