

Congress, NCP (SP) hold merger talks amid Maharashtra opposition shake-up

Congress and Sharad Pawar's NCP are discussing a possible merger in Maharashtra. The talks come as the opposition Maha Vikas Aghadi faces strains and renewed questions over opposition unity.

Mumbai.(Agency) Amid growing uncertainty within Maharashtra's opposition camp, the Congress and Sharad Pawar-led Nationalist Congress Party are holding discussions over a possible merger, sources said. The move, if it materialises, could trigger a major political realignment in the state. According to the sources, discussions are currently focused on the Maharashtra units of both parties, with the NCP (SP) leadership working on building internal consensus before moving ahead. Once a broad agreement is reached at the state level, the final decision is expected to come from the top leadership of both parties in Delhi. The possibility of a Congress-NCP (SP) merger had also been discussed before the 2024 Maharashtra Assembly polls. The discussions,

however, were put on hold due to the election setbacks in recent months, including a rebellion within Uddhav Sena after six MPs switched to the Eknath Shinde-led Shiv Sena. The move comes at a time when the opposition



Maha Vikas Aghadi (MVA) is facing internal challenges and questions over its unity. The alliance, comprising the Congress, NCP (SP) and Shiv Sena (UBT), has suffered

identity. In May this year, Sharad Pawar's faction had ruled out any possibility of a merger with Ajit Pawar's group, maintaining that the two sides had taken different political paths. At a recent MVA meeting in Mumbai, Shiv Sena (UBT) chief Uddhav Thackeray openly questioned the alliance's cohesion, asking, "We say we are together, but are we really?" The fresh merger talks come 27 years after Sharad Pawar broke away from the Congress in 1999 to form the Nationalist Congress Party. In 2023, however, his nephew Ajit Pawar split the NCP, leading a group of MLAs to join the BJP-Shiv Sena government in Maharashtra. The split resulted in both sides claiming the party's legacy and political

Freedom of speech not freedom to abuse: Pawan Kalyan slams attacks on daughters

A controversy has erupted in Andhra Pradesh after a series of abusive and derogatory social media posts targeting the minor daughters of Deputy Chief Minister Pawan Kalyan triggered widespread outrage and police action. The Jana Sena Party chief condemned the attacks, asserting that while criticism of governments is protected under the Constitution, abuse, threats and harassment are criminal offences. The controversy comes in the wake of a recent custodial death, following which several social media accounts allegedly began circulating hateful and defamatory posts directed not only at Pawan Kalyan but also at his minor daughters. Addressing the issue in a video message shared by the Jana Sena Party on X, Pawan Kalyan drew a clear distinction between the constitutional right to free speech and online abuse. "Social media has become a powerful platform to express our views, raise public issues and hold governments accountable. Freedom of speech and expression is a fundamental right guaranteed by our Constitution, and our government fully respects that right," he said. "Freedom of speech does not mean the freedom to abuse. You have the right to criticise the government. You have the right to question us.

PM Modi marching to environmental disaster in Great Nicobar: Jairam Ramesh

Congress leader Jairam Ramesh on Thursday accused Prime Minister Narendra Modi of pushing ahead with an "onward march to environmental disaster" in Great Nicobar, and said "the nation's ecological conscience is on trial". He renewed his attack on the Great Nicobar Island Project and said he would continue to raise the issue. Ramesh said on X that there had been interest in his public engagement over the past few years on the project and what he described as its devastating impact on the island's biodiversity-rich ecosystem. He shared an anthology that, he said, included most of his social media posts, a couple of brief interventions in Parliament, and letters to various Union ministers along with their



replies. He said five petitions filed by citizens and civil society groups are pending in the Calcutta High Court. According to Ramesh, these include challenges based on alleged violations of the Eco Sensitive Zone Notification for Campbell Bay National

Park, the Eco Sensitive Zone Notification for Galathea National Park, and the Forest Rights Act, 2006, and its Rules, 2008. He also listed a challenge based on alleged violations of the Coastal Zone Regulation Notification, 2019, and the Environment (Protection) Act, 1986, as well as a challenge on various grounds relating to the National Green Tribunal's order dated February 16, 2026. Repeating his criticism of the project, Ramesh said there would "undoubtedly" be more such public engagements as the prime minister continued with what he called an "onward march to environmental disaster" in Great Nicobar. Last week, Ramesh wrote to Union minister Sarbanand Sonowal seeking clarifications on the development of a transhipment port under the project.

Air India Express restores Kuwait, Salalah services as West Asia network returns to full strength

New Delhi: Air India Express on Thursday said that it had restored connectivity across its West Asia network with the resumption of flights to Kuwait and Salalah in Oman, with services from Kozhikode and Bengaluru being reintroduced in phases from this week. The airline resumed flights on the Kozhikode-Salalah route from July 2 with two weekly services operating on Tuesdays and Thursdays. Services between Kozhikode and Kuwait will resume from July 3. The route will initially operate once a week on Fridays before being increased to three weekly flights from July 5 with services on Wednesdays, Fridays and Sundays. Flights between Bengaluru and Kuwait will restart from July 4 with one weekly service on Fridays. The frequency will increase to three flights a week from July 7, operating on Mondays, Tuesdays and Saturdays. With the resumption of services to Salalah, the airline will now operate from two airports in Oman — Muscat International Airport and Salalah International Airport. The carrier has also reinstated flights between Muscat and Mangaluru from July 3. It currently operates around 40 week-

ly flights from Muscat to seven destinations in India. All flights to and from Kuwait will operate from Terminal 4 at Kuwait International Airport. Under the revised schedule, flights from Kozhikode to Salalah will depart at 11 am and arrive at 1.05 pm, while the return service will leave Salalah at 2.15 pm and reach Kozhikode at 7.45 pm. The Kozhikode-Kuwait service departing on Fridays will leave at 7.30 am and arrive in Kuwait at 10.05 am. The return flight will depart Kuwait at 11.05 am and land in Kozhikode at 6.50 pm. From July 5, the revised Kozhikode-Kuwait schedule will see departures from Kozhikode at 2.15 am with arrival in Kuwait at 4.50 am. The return service will depart Kuwait at 5.50 am and reach Kozhikode at 1.35 pm. Flights from Bengaluru to Kuwait will depart at 2.25 am and arrive at 4.50 am, while the return flight will leave Kuwait at 5.50 am and land in Bengaluru at 1.25 pm. The airline currently operates flights to 13 destinations across Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates and runs around 780 weekly services between India and West Asia, connecting 18 Indian cities directly with the region.

Petrol, diesel price reduction only when crude oil rates stabilise at lower levels, hints Puri

New Delhi: International crude oil prices may have fallen to a four-month low, but retail petrol and diesel prices in India are unlikely to be cut anytime soon as state-run refiners are still processing costlier crude purchased during the peak of the West Asia crisis, Oil Minister Hardeep Singh Puri said. Petrol and diesel prices were raised by about Rs 7.50 per litre each in the second half of May - more than two months after the outbreak of the West Asia conflict and by less than the increase in global fuel costs - resulting in state-owned fuel retailers absorbing a significant portion of the higher crude prices. The delayed and partial pass-through left Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) with substantial losses on the sale of petrol and diesel, even as international oil prices have since retreated. Puri said state-owned fuel retailers incurred cumulative losses of Rs 74,781 crore on the sale of petrol, diesel and subsidised cooking gas (LPG). The figure includes losses from

selling petrol and diesel below cost for four months following the outbreak of the West Asia conflict on February 28, as well as unrecovered LPG subsidies for the same period and earlier months. International oil prices have retreated over the past two to three weeks after the United States and Iran signed an interim peace deal, easing concerns over the Strait of Hormuz - a critical energy shipping route used to transport oil and gas from Gulf producers. Crude oil prices have fallen from USD 119 per barrel at the peak of the conflict to around USD 70 now. Puri, however, said refiners, who turn crude oil into fuels like petrol and diesel, are currently processing crude bought two or two and a half months back. "That crude would have been obtained two months back (when) prices were high, cost of insurance was high, cost of freight was high," he said. "Crude priced at current lower rates will arrive (at refineries) later." A fuel price cut can be looked at if oil prices remain at low levels for a sustained period, he said. "If it (oil prices) remains like this (at current rates), it (cutting retail prices) is a legitimate

thing," he said. On Nayara Energy, India's largest private fuel retailer, cutting petrol prices by Rs 5 per litre and diesel by Rs 3 per litre while state-owned firms have not followed suit, Puri said the company was effectively rolling back the increases it had implemented in March. He added that Nayara subsequently matched every price increase undertaken by state-run refiners in May. The latest cuts, he said, have effectively brought Nayara's retail fuel prices back in line with those of state-owned competitors. Talking about how India managed the four-month period when the Iran war largely blocked access to Gulf producers, Puri said refiners diversified the sourcing of crude oil across continents and brought more LPG from the US. The result was that no retail outlet in the country ran dry, even when countries in the neighbourhood rationed fuel. "Every one of our refineries is stocked, every port, terminal, pipeline and depot is stocked. In all, we have stocks to cover the country's requirement for 76-80 days," he said. "This is not to say that we don't need additional (strategic) storage.

Kejriwal asks PM Modi who is being 'saved' in Ayodhya donation embezzlement case

AAP convener Arvind Kejriwal on Thursday questioned Prime Minister Narendra Modi over the alleged embezzlement of donations meant for the Ram temple in Ayodhya, alleging that only "pawns" had been arrested while the "powerful" people behind the scam were being protected. Addressing a press conference, Kejriwal alleged that corruption had taken place in land purchases, temple construction and the handling of devotees' donations. "It cannot be accepted that all this was going on and the prime minister was unaware of it," he said. Claiming that the Ram Mandir Trust office bearers were handpicked by the prime minister and that a Union Home Ministry officer is also part of the Trust, Kejriwal questioned why Modi "did not act to stop the theft". "They are hoodwinking us with the arrest of the eight persons; the real people (culprits) are someone else. These eight are merely pawns. I want to ask the PM whom he is saving and why," he said.

Teen murders stepfather after quarrel, on the run

Gurgaon.(Agency)

A 19-year old youth allegedly murdered his stepfather with a hoe after a heated argument at their home in Pataudi late Monday night. According to the police, Shivam and the victim, Manoj (45) frequently quarreled since Manoj married Shivam's mother 13 years ago. On Monday, during an altercation, Shivam allegedly attacked Manoj several times with a hoe, inflicting fatal injuries. Manoj died at the scene, and the accused escaped immediately after the incident.

Receiving a complaint from Prempal, a relative of the deceased, the Pataudi police station registered the case and rushed to the spot with a forensic team to collect evidence. The body was further sent for post-mortem examination. Police told that raids are underway to trace the accused, who remains absconding. In a separate case, Ravi, a 32-year-old marketing executive, died on Tuesday night, nearly a month after he was brutally assaulted during a parking dispute in Sector 7 Extension. On June 6, Ravi went to Sector 7 Extension Road with his friends after celebrating his brother's birthday when an argument broke out with a group of youth over parking a car outside a shop. Ravi told the group that he would remove the vehicle shortly, but the argument escalated into a physical assault. According to police, as the altercation intensified, Ravi's three friends managed to flee the scene. The group caught hold of Ravi and repeatedly assaulted him. His condition deteriorated the following day, leading to his hospitalisation. Doctors later found that he sustained a serious head injury.

After remaining under treatment for nearly a month, he succumbed to his injuries on Tuesday night. He is survived by his wife, a son and a daughter.

Three face FIR for morphing two sisters' photos with AI, sharing them online

Police registered an FIR against a man and two others after he allegedly created morphed videos and pictures of a 26-year-old woman and her sister using AI. The accused, Himanshu alias Lukka, has allegedly been harassing the woman for some time now. The complainant said that in April last year, she had gotten engaged. The accused contacted her to-be in-laws and cast false aspersions on her character, leading to them breaking off the engagement. The woman's family tried to persuade Himanshu to stop harassing her as he was insisting that she get into a relationship with him, but he allegedly refused to stop. He then began creating morphed images and videos of her as well as her older sister, who is married, and sending them to both of them and her sister's husband. He has also allegedly routinely defamed her on social media platforms such as Instagram by creating fake IDs and posting obscene comments and posts on various such profiles. The harassment has persisted for over a year despite the woman and her family's attempts to dissuade him. DCP (city) Dhawal Jaiswal said they have filed an FIR against Himanshu and two of his associates — Manohar and Sonu, a father-son duo — under BNS sections (stalking), 351(3) (criminal intimidation), 61(2) (criminal conspiracy) of BNS and relevant sections of the IT Act at Crossings Republik police station.

"The accused's location was traced to Punjab and teams have been formed to nab them," the DCP added.

IndiGo adds nine routes, links Noida airport to 15 cities

IndiGo expanded its network from Noida International Airport on Wednesday, launching flights to nine more cities, including Jaipur, Jodhpur, Dharamshala, Bhopal, Dehradun, Bareilly, Kishangarh, Pantnagar and Chandigarh. The airline commenced commercial operations from Noida airport on June 15 with the inaugural flight from Lucknow to Noida. It has since been running daily flights to Bengaluru, Hyderabad, Jammu and Amritsar. The July 1 additions take the number of cities connected to the airport to 15. Akasa, which started operations from Noida airport on June 16, flies to Bengaluru and Navi Mumbai. While IndiGo will operate daily to most cities, it will fly to Bareilly on Monday, Wednesday, Friday and Sunday, and Kishangarh (Ajmer) on Tuesday, Thursday and Friday. IndiGo will start direct Navi Mumbai flights on July 10. A direct flight service to Srinagar will also start soon," NIAL nodal officer



Shailendra Bhatia said. Currently, the airline has a Jaipur layover for the Noida-Navi Mumbai route and Noida-Srinagar flights are routed via Chandigarh. RK Shahi, a resident of Sector Zeta 1 in Greater Noida, who flew from Noida airport to Hyderabad on Tuesday afternoon, said, "It took me just 40 minutes to reach the airport from home, against the 90 minutes it usually takes to reach IGI. There's no rush at Noida airport, so check-in was smooth. The airport is significantly improving the travel experience for people in Noida and Greater Noida." NIA expects to have the infrastructure for international flights, like customs and immigration, ready by the end of this year. The carrier, meanwhile, introduced IndiGo Lite Fare, a new entry-level economy option for passengers travelling with only cabin baggage up to 7 kg and with an auto-assigned seat at no additional cost. The fare excludes free checked baggage, allowing customers to pay only for the services they use.

Missing GPS to broken emergency exits: School bus checks on after safety lapses found

With schools set to reopen after summer break from next week, the district administration has ordered a fresh round of inspections of school buses in July after recent audits found serious safety lapses that could put thousands of children at risk. The authorities had inspected 325 school buses between Jan 1 and May 26 this year and issued 56 challans for violations of the Surakshit School Vahan Policy. This prompted the district road safety committee (DRSC) to carry out another audit before the new term gathers pace.

The earlier audit had found an alarming number of buses operating without GPS tracking systems. Many had non-functional or missing CCTV cameras, no horizontal safety grilles and broken emergency exit doors. In some buses, officials found illegal tinted glass windows, batteries installed without protective covers to prevent leaking of fumes, expired medicines in first-aid kits and no identification of the school for which they were plying. Some schools also



failed to show police verification for the drivers and helpers on the buses. The authorities also found mandatory documents in several vehicles were out of order. Now, the road safety committee has directed the regional transport authority to circulate the safe schoolbus compliance checklist among every school through the

district education officer and ensure that all institutions rectify the shortcomings before inspections begin again in July. The checklist has already been sent to all schools. Sub-divisional magistrate Sanjeev Singla said those found not following the rules will face strict action. "Along with the challan, we will also start registering

FIRs against the schools and their transport agencies for violating norms," he said. The safety drive extends beyond buses. Taking note of the fact that children remain vulnerable outside school gates, the committee has also instructed all road-owning agencies, including GMDA, MCG, NHA and PWD, to upgrade road infrastructure round educational institutions. Officials have been asked to ensure warning signboards, zebra crossings, speed breakers or rumble strips, and road markings to create safer school zones and reduce the risk of accidents involving children. "SDMs have been directed to coordinate with the concerned agencies and monitor compliance in their respective jurisdictions," said an official.

The initiative is part of the district's broader road safety strategy, which has become even more important after Gurgaon recorded 1,118 road crashes in 2025 — a 9% increase over the previous year. Pedestrians and two-wheeler users were found to be among the most vulnerable.

MCG sacks 4 staff over AI image fraud, GPS spoofing & misconduct

Artificial intelligence was always going to catch up with day-to-day governance. One just hoped it would be for the better. In a case of technology being misused, Municipal Corporation of Gurgaon (MCG) has terminated an assistant sanitation inspector (ASI) for allegedly using AI tools to falsely show that civic complaints had been resolved. Officials said the complaint in question concerned illegal garbage dumping at a site and the photo showed the spot as clean. According to an official speaking on condition of anonymity, MCG commissioner Pradeep Dahiya on Wednesday, ASI Waseem — engaged through Haryana Kausal Rozgar Nigam Limited (HKRNL) — edited field photographs using AI tools and uploaded the manipulated images to the grievance portal to claim sanitation work had been completed when it had never been carried

out on the ground. The order stated that Waseem used the images to secure closure of public complaints, making his continuation in service "undesirable and against the corporation's interests". He was terminated with immediate effect. During the departmental inquiry and personal hearing, Waseem admitted to editing the photos, but the civic body found his explanation "unsatisfactory". The inquiry described the act as "grave misconduct, fraud, dishonesty, falsification of official records, breach of trust and dereliction of duty," concluding that using AI to fabricate evidence on an official govt platform amounted to serious fraud in grievance redressal. The order also observed that such conduct was contrary to prescribed procedures and inconsistent with the standards expected from a public servant. "We visited the site and found waste still lying there. When we examined

the images using our AI detection mechanism, we found indicators, including a SynthID watermark, suggesting AI tools had been used," MCG additional commissioner Yash Jaluka told TOI, adding that the misuse of AI to was an emerging governance challenge and that the corporation was strengthening its verification mechanisms. In a separate case, ASI Sonu was dismissed for allegedly using a GPS-spoofing application to mark attendance on the corporation's digital solid waste management portal while being absent from his assigned duty location.

The same day, MCG also terminated the contracts of two computer operators, Neeraj Vashishth and Ankur Arora, after a June inquiry found they had raised unnecessary objections in property ID and tax cases, deviating from the prescribed standard operating procedure and delaying applications.

Noida, Ghaziabad to get 5 working women's hostels by next April

Five working women's hostels, each with a capacity to accommodate 500, will be built across NCR by April 2027. Four hostels will come up in Noida — of them, two in Surajpur, one in Sector 85 and one in Kasna — while one will come up in Ghaziabad.

District probation officer Manoj Kumar Pushkar said these hostels aim to provide safe, affordable accommodation with modern amenities and enhanced security for working women in the region. The hostels will be built by the state govt's Construction and Design Services at Rs 40 crore. He said they will encourage women to participate in the workforce.

The hostels will be developed under a public-private partnership model, with the govt facilitating the infrastructure while private agencies will operate and maintain the facilities. Pushkar said the tender

process for selecting the operator has already been initiated. According to the plan, the four hostels in Noida will be



constructed as G+10 buildings, while the hostel in Ghaziabad will have six floors. Pushkar said a dedicated police kiosk will be established within the hostel premises to provide an additional layer of safety to the residents.

He said that the hostels will also include several amenities aimed at making daily life

more convenient for occupants. "These will include a gymnasium, canteen, grocery store and cafeteria, enabling women residents to access essential services without having to step outside the campus for routine needs," he said. "The emphasis is on creating a self-sufficient and secure environment." He said the standard operating procedures governing eligibility and access to the hostels are yet to be finalised. The guidelines will be prepared under the supervision of the officer and will define which categories of working women will be eligible to avail the accommodation.

According to Delhi govt's department of women and child development website, there are currently 16 working women's hostels in the capital. Officials expect the projects to significantly improve the availability of safe housing for working women in Noida, which has emerged as a major employment destination with a large concentration of industries, corporate

No annual audit reports, UP-Rera issues notices to 76 projects

UP Rera has issued show-cause notices to promoters of 76 real estate projects, several of them in NCR, for failing to upload mandatory annual audit reports for the 2024-25 fiscal year by Sept last year. The real estate regulator has now directed the erring promoters to upload the annual audit report within 15 days with a late fee. The biggest projects among the defaulters are in Noida and Ghaziabad, including VVIP Addresses Greater Noida (West) by Vibhor Vaibhav Infrahome, CRC Maesta by CRC Homes, Central Ikon by Business Bay Fin Infra, Signature Park by RS Resource, ACE Estate by Logix Buildestate, Avenue IV by Aura Buildcom LLP, The Flagship Phase 4 by IT Infrastructure Park, and Oasis Grandstand Phase-2 by Oasis Realtech.

The list also includes Metro Suites Bellavie by Metro Suites Homes LLP in Ghaziabad and Migsun Lucknow Central by Wilmot Infratech Private Limited in Lucknow.

Promoters are required to submit audited project accounts within six months of each financial year's end. The Authority said it will levy a late fee of Rs 25,000 on defaulters, and warned that continued non-compliance could attract penalties of up to 5% of a project's estimated cost, as provided under Section 4 of the UP Rera Act. "It is mandatory for promoters to get their project accounts audited at the end of the financial year and to upload the annual audit report on the UP Rera website within six months from the end of the financial year. The report is reviewed, and the information is made available to allottees and the general public. The exercise ensures transparency, independent verification and accuracy of financial disclosures submitted before the authority," said a UP Rera official. UP Rera chairperson Sanjay Bhoosreddy said timely submission of annual audit reports was a fundamental responsibility of every promoter under Rera. "Independent audit and accurate reporting strengthen transparency and build confidence among homebuyers.

Section of Aravali hillock flattened in Mangar

A section of an Aravali hillock has been flattened in Mangar, one of the most ecologically sensitive zones of the ranges and home to the eponymous Mangar Bani grove. The cleared patch measures around an acre. Local residents reported activities at the hillock around 7pm on Tuesday and alerted police, who found an earthmover abandoned at the site. No FIR has been filed so far. The forest department also inspected the area. "It looks like some part of the hill was damaged. We are investigating," said Jhalkar Uyake, Faridabad divisional forest officer.

Fresh earth cuts were visible on Wednesday along the edges of the cleared patch, with the natural hill slope rising immediately behind it. A damaged mesh fence was also found at the site.

The land is classified in revenue records as 'magda' — rainfed agricultural land — even though it is partly hilly. According to environmentalist S S Oberoi, repeated attempts have been made to alter the natural landscape here — trees and shrubs have been cut in the past before this attempt to level it with an earthmover. Construction and mining have done large-scale damage to the Aravalis. In Rajasthan, entire tracts of the hills have been flattened. In south



Haryana districts like Gurgaon, Faridabad and Nuh, despite a ban on mining and laws restricting construction in the Aravalis, hills continue to sustain damage. In Dec 2024, a hillock in Nuh's Rava was blown to pieces by stone miners.

In its Mangar order, National Green Tribunal had recorded the Haryana govt's own submission that there had been past instances of gair mumkin pahar (rocky, hilly or uncultivable wasteland) being wrongly labelled as agricultural land in revenue records by a patwari.

The tribunal's order directed state authorities to act against "unauthorised

cutting of trees or breaking of the land or any non-forest activity in the forest, including gair mumkin pahar," which it recognised as deemed forest under notifications issued under Punjab Land Preservation Act (PLPA) and Supreme Court's declarations.

Mangar is no ordinary tract of land. Spread across 4,262 acres, including around 3,810 acres of gair mumkin pahar, it is among the richest biodiversity pockets of the Aravalis in NCR. Within it lies Mangar Bani, spread over 677 acres, regarded as NCR's last surviving grove and possibly its only remaining patch of primary forest. Of

Mangar's hill area, 1,132 acres are protected under sections 4 and 5 of Punjab Land Preservation.

Gurugram police issue 10,768 challans worth Rs 63 lakh

Gurugram: The Gurugram traffic police issued 10,768 challans to commuters for violating traffic rules, including wrong-side driving, driving without a seat belt, riding without a helmet and drunk driving. The challans were issued within a week, from June 15 to 21, with penalties amounting to more than Rs 63.08 lakh. According to NIC server data, 3,975 challans were issued through on-ground enforcement. These included 354 for wrong-side driving, 76 for road-marking violations, 149 for pillion riders without helmets, 118 for driving without a seat belt, 230 for riding without a helmet, 409 for drunk driving, 37 for dangerous U-turns, 48 for triple riding, 45 for over-speeding and 669 for lane-changing violations. In addition, 6,793 challans were generated through surveillance cameras. These included 2,692 for lane-changing violations, 2,912 for no-entry violations, two for over-speeding, 145 for pillion riders without helmets, 163 for riding without a helmet, 22 for triple riding, 443 for driving without a seat belt, 334 for pollution-related violations and 70 for front-seat passengers without seat belts.

'Positive progress' in US-Iran indirect talks in Doha: Qatar spokesman

DOHA.(Agency)

US and Iran negotiators made "positive progress" during indirect talks in Doha, with the next round expected after the late Iranian supreme leader's funeral, Qatar's foreign ministry spokesman said.

"Qatar & Pakistan mediators concluded separate meetings with the US & Iranian negotiators in Doha today, with positive progress made on issues related to the Islamabad Memorandum of Understanding, building on the outcomes of the Lake Lucerne Summit," foreign ministry spokesman Majed Al Ansari said Wednesday on X. "The parties agreed to continue discussions over the coming period, with the next meeting to be scheduled at the earliest possible time following the funeral processions of the former Iranian Supreme Leader." Earlier, US President Donald Trump hailed the progress of indirect talks between the United States and Iran in Qatar, as the sides aimed to push forward negotiations and quell tensions following exchanges of fire. The US leader said there had been "very good meetings" in Doha after an early dispute over the format threatened to overshadow discussions.

No Land For Expectant Moms? After Court Setback, Trump's Birthright Plan B

After the begrudging defeat from the Supreme Court in the birthright citizenship case, US President Donald Trump's aides and his MAGA (Make America Great Again) allies are reportedly pivoting to their Plan B: targeting the so-called 'birth tourism' by blocking pregnant foreign women from entering America.

By definition, birth tourism occurs when visitors come to America specifically to give birth to ensure their child receives US citizenship.

After the Supreme Court verdict, White House spokesperson Abigail Jackson, in a statement to Axios, said, "President Trump remains totally committed to protecting the value of natural-born American citizenship, which is why, following yesterday's ruling, he directed Congress to take immediate action to address this." Jackson emphasised that the Department of Justice will also prioritise investigations of birth tourism schemes, adding that the Trump administration has many tools to safeguard American citizenship.

The Policy Options

This was followed by a discussion about the many policy options among White House aides and allies, who noted that the next course of action could include prosecuting organisations or individuals involved in "birth tourism schemes" or women already in the country for fraud or barring the entry of pregnant women entirely, Politico reported, citing two administration officials and several others close to the administration. MAGA figures like Federalist founder Sean Davis also came forward and demanded that the Trump administration bar pregnant foreign women from entering the country.

While talking to Fox News, Trump's immigration policy advisor Stephen Miller also claimed that America must "think very carefully about who you let into your country, even on a temporary basis", because, according to him, children born to non-Americans can become US citizens and get an opportunity to access the social safety net.

US Man Named Santa Claus, 75, Arrested In Child Sex Sting

A US man who legally changed his name to 'Santa Claus' has been arrested after an undercover sting operation exposed him as a paedophile. Claus, 75, formerly known as George Quigley, was taken into custody in the New Orleans suburb of Kenner after



allegedly arranging an in-person meeting with a detective posing as a 15-year-old boy.

As per the official statement by Kenner police, apart from arranging the meeting, Claus also sent explicit photographs of himself to the undercover officer during their digital interactions. After he arrived at the meeting spot, the investigators confronted him, and he surrendered without any resistance.

Claus' physical appearance mirrored the traditional Christmas figure, with the police finding images of the 75-year-old posing as Santa Claus for photo opportunities. "All these defendants are a danger to our youth and society, we preach daily about the vulnerability of our children on social media and gaming platforms and now we have arrested a person who dresses up as Santa Clause inviting parents to drop their young children in his lap for photo ops, this is a cautionary tale to parents and guardians," said Kenner Police Chief Keith A. Conley. Claus is now facing counts of illegal computer-aided solicitation of a minor as well as indecent behaviour with a juvenile. He lived in Texas before moving to New Orleans where he was caught. Claus was among 11 suspects who were arrested during the sting operation. The agency said its cybercrimes division had also obtained warrants to arrest another 10 suspects who were not immediately captured. "Anyone who uses the anonymity of the internet to exploit children should understand one thing, we are there too. Our investigators will continue to identify these predators, build strong cases, and bring them to justice before they have the opportunity to victimise a child," said Conley.

Russian missiles and drones kill eight and cause damage across Kyiv**Many residents took shelter at metro stations after Ukrainian President Volodymyr Zelenskyy and other authorities issued the first warnings of the attack.**

Russia launched a large-scale attack on Ukraine's capital overnight into Thursday that killed at least eight people and injured dozens as loud explosions shook Kyiv for hours. The attack with ballistic and cruise missiles and drones damaged buildings and civilian infrastructure across the city. Many residents took shelter at metro stations after Ukrainian President Volodymyr Zelenskyy and other authorities

issued the first warnings of the attack. The attack killed eight people, said Tymur Tkachenko, head of the Kyiv City Military Administration. Damage was recorded in 28 locations across the city, mainly residential buildings and civilian infrastructure, he added. Mayor Vitali Klitschko said 34 people were injured. Russia has intensified its attacks on Kyiv in recent weeks, even as Ukraine's own long-range drone campaign against Russian military sites and energy facilities has caused fuel shortages and disrupted supply lines inside Russia.

Klitschko urged residents to remain in shelters, describing an ongoing "furious enemy attack" on the capital. He said five people were injured in the Shevchenkivskiy district and one of the injured, a paramedic, was in extremely critical condition. Ukraine's Emergency Service says a hotel and two five-story residential buildings were damaged in the

district. In the Desnianskyi district, people were trapped inside a damaged nine-story



residential building and rescuers headed to the scene, Klitschko said. In the Holoivskiy district, a fire broke out on the roof of a 16-story building, according to the Emergency Service. In the Sviatoshynskiy district, fire broke out

in two private residences, the Emergency Service said. Debris trapped people in one of them, according to the mayor. In the Darnytskyi district, six levels of a nine-story building collapsed after a Russian strike and another five-story residential building was damaged, Klitschko said. The Emergency Service said a 16-story building and private residences were damaged in the area. Tkachenko said the attack partially destroyed a residential building in the Desnianskyi district, sparked fires near residential buildings at two locations in the Pecherskyi district, and ignited a fire near an administrative building in the Solomianskyi district. He said authorities were also recording damage in the Obolonskyi and Podilskyi districts. The head of the Kyiv Regional Administration, Mykola Kalashnyk, said damage occurred in five regional districts. There were no immediate reports of casualties in the region.

Rescue of trapped Venezuelan underway one week after quakes

Hundreds of rescuers were working late Wednesday to save a 43-year-old Venezuelan man who has survived for a week under the ruins of a seven-story building, an AFP reporter witnessed.

Hernan Gil, a 43-year-old security guard, is trapped inside his booth under the building where he worked in Catia La Mar, a coastal area almost entirely razed to the ground in the June 24 twin earthquakes, magnitude 7.2 and 7.5. Rescue teams from seven countries -- Venezuela, Chile, the United States, Portugal, Costa Rica, El Salvador, and Mexico -- have been working around-the-clock over the past three days to reach him. By late Wednesday they were almost one meter from his position, rescuers told AFP. Chile's fire service published an Instagram video of Gil inside his chamber, moving his head to look at the camera. He was wearing a face mask and his right eye was

bloodshot. "This is truly a miracle," Gil's wife Gusbimar Gonzalez told AFP. "I'm completely amazed because it's the first time I've seen so many countries come together like this to save



a single person," she said. News of the rescue bid came at the end of a day in which hope of finding more survivors had faded, seven days after the catastrophic earthquakes, which killed almost 2,300 people and have left thousands more unaccounted for.

As firefighters drew near him, others were monitoring the movements of a neighboring building, which is in danger of collapsing. Working since Monday, the rescuers shored up the building's foundations with wood and iron to prevent the listing structure from completely collapsing further. Throughout the operation, they gave Gil water to keep him hydrated and installed a tube through which they supplied him with air. The men advanced along two routes simultaneously to reach Gil. "This is a rather complicated structure to access," Cristian Vera, the leader of the Chilean rescue team told AFP. He said that the existence of "very large pillars" meant "it wasn't easy to reach the exact spot where the victim was located." An initial plan to construct a 60-by-60-centimeter tunnel was discarded on Tuesday when the building shifted slightly. "We had to develop a new work plan to try to enter through a different route than the one we had used until last night," Vera explained.

Retrofitted Qatari jet takes flight as Air Force One for Trump's trip to North Dakota

President Donald Trump on Wednesday took his maiden voyage on a new Air Force One — a retrofitted Boeing 747-800 worth \$400 million gifted by Qatar that embeds his personality more deeply into the institution of the American presidency. Gone is the trademark light blue hull that helped Air Force One blend into the sky. The refurbished jet is painted in Trump's preferred color scheme: a navy-blue belly with red and gold stripes. It has the luxury features that the president believes a commander-in-chief's entourage should have — plush carpets, lie-flat seats, wood paneling and a presidential seal on the seat belts, according to reported tours of the plane. Trump told reporters that he was proud of the luxurious plane. "You can do two things: You can low-key it, or you can show it," he said. The retrofitted Qatari jet is intended to serve as a "bridge" between the aging Boeing jets that have served as Air Force One for the last 36

years and two new aircraft, which are years behind schedule and expected to be delivered in 2028 at the earliest. Trump toured the new jet just weeks after returning to the White House last year and directed that it be prepared for his use for the bulk of his remaining time in office. The compressed timetable set by the president limited the modifications to the plane. Images of the jet captured since its unveiling and analyzed by the Associated Press show that it is not equipped with at least some of the same missile detection and countermeasure systems as the outgoing Cold War-era jets. The Air Force has said that it did little to change the cabin layout of the plane and that it spent less than \$400 million on security upgrades. Jeremiah Gertler, a senior analyst for Teal Group, an aviation and defense consulting firm, said that this absence, as well as a seemingly smaller number of communications antennas, suggested that the Qatari jet is better suited to only work as a domestic

aircraft. If you're going on a long trip, you take the big fancy car, but if you're just buzzing around town, you'll settle for something less. Right? And this looks like it's a domestic-only model," Gertler said, speaking of the new jet. "If the idea was to do it as quickly and inexpensively as possible, it would seem to lead to the notion that there's less content" in the jet's modifications, Gertler said. Trump has said he plans to use the new plane next week when he travels to attend the NATO summit in Turkey. The Air Force argued that the rapid conversion of the jet was done "without accepting any risk regarding security, safety, or secure communications," but added that "several highly complex engineering modifications required for the final (Air Force One aircraft) were intentionally excluded from the Bridge aircraft." The service acknowledged that it did not widen the doors leading out of the aircraft or include multiple stairs built into the hull of the plane.

Trump upbeat as US, Iran hold 'very good' indirect talks in Qatar

US President Donald Trump hailed the progress on Wednesday of indirect talks between the United States and Iran in Qatar, as the sides aimed to push forward negotiations and quell tensions following exchanges of fire. The US leader said there had been "very good meetings" in Doha after an early dispute over the format threatened to overshadow discussions.

Iran insisted there would be no direct negotiations between the sides in the Qatari capital on the two parties' memorandum of understanding aimed at ending the Middle East war, which broke out with US-Israeli strikes on Iran in late February. "As far as things are going, the denuclearisation of Iran is moving along well," Trump told reporters as he prepared to board his Qatar-gifted Air Force One plane, which the wealthy Gulf emirate donated last year. "We hit them very hard... but we're getting along very well." The memorandum of understanding, brokered by Qatar and Pakistan, culminated in a summit last month in Lucerne, Switzerland. It includes a 60-day ceasefire pausing the war, the reopening of the blockaded Strait of Hormuz and a timeframe for a final deal to permanently end the conflict and reach an agreement on Iran's nuclear programme. Earlier a diplomat, speaking on condition of anonymity to discuss the sensitive talks, confirmed negotiations were underway in Doha with Qatari and Pakistani mediators. Different public messages' The discussions, being held at a lower level and focused on the details of the MOU, were to "build on the progress made at the Lake Lucerne Summit", the diplomat told AFP. Tehran denied an earlier claim by Trump that there would be direct talks in Doha.

Iranian foreign ministry spokesman Esmaeil Baqaei said the Iranian delegation would be led by Deputy Foreign Minister Kazem Gharibabadi, but added the officials "have no plans for negotiations with the American side at any level over the coming days".

US envoys Jared Kushner and Steve Witkoff were not taking part in the technical talks, the anonymous diplomat told AFP, after they met with Qatar's Prime Minister Sheikh Mohammed bin Abdulrahman Al Thani on Tuesday. Qatar's foreign ministry said the trio discussed "the ongoing talks" between the US and Iran "within the framework of the memorandum of understanding", as well as developments in Lebanon. On Wednesday, the office of Qatar's emir also said the two US envoys had met with Qatari ruler Sheikh Tamim bin Hamad Al Thani. Anna Jacobs, non-resident fellow at the Arab Gulf States Institute, told AFP it was "very early in the negotiation process and battles are being fought privately and publicly". The overall positive message is that they are continuing to engage after the clashes last week," she said.

HA Hellyer, an analyst at the Royal United Services Institute in London, said there was a "lack of transparency" surrounding the talks with both sides "sending very different public messages".

Climber couple arrested after scaling Empire State Building antenna for apparent marriage proposal**Dressed in black and wearing masks but not tethers, the two balanced on a narrow ledge and appeared to kiss atop the New York skyscraper's antenna, news helicopter video showed.**

A daredevil couple scaled the Empire State Building's antenna Wednesday and unfurled a banner about "the power of love" and peace, apparently as part of an audacious, high-altitude marriage proposal, soon followed by their arrest. The Russian climbers, who go by Angela Nikolau and Ivan Beerkus, were the subject of the 2024 Netflix documentary "Skywalkers: A Love Story" about their "roof-flopping" exploits and budding romance. Dressed in black and wearing masks but not tethers, the two balanced on a narrow ledge and appeared to

kiss atop the New York skyscraper's antenna, news helicopter video showed. The banner, reading "when the power of love beats the love of power the world knows peace," waved from the structure, which rises 1,454 feet (443 meters) above midtown Manhattan. After lingering for a time, the two collected the banner and began to climb down, picking their way along the latticework of metal to a wider ledge, where one seemed to set up a piece of photography equipment and got down on one knee. After the two kissed again and hugged, the other person took selfies with an outstretched left hand, as if examining a ring. Police Emergency Services Unit officers started ascending a ladder in the spindly structure to intercept them. Police body camera video showed an officer calling out a greeting and explaining, "Well, you can't be up here." An off-camera voice replied with what sounded like, "We are engaged." A few seconds later, officers reached a landing within the antenna and

met the couple, who were coming down a ladder and calmly spoke with police, the video showed.



Nikolau posted images of the escapade on her social media accounts, including a photo that modeled an engagement-style ring above a bird's-eye view of Manhattan. The two climbers, whom police identified by their formal names, Angelina Nikolau and Ivan Kuznetsov were arrested on burglary, reckless endangerment and other

charges. It wasn't immediately clear whether they had attorneys who could speak to the allegations. Messages seeking comment were sent to the couple. Skywalkers: A Love Story" follows Beerkus and Nikolau as they make often unauthorized ascents of tall structures, sometimes posing as construction workers to sneak in. It wasn't clear how the pair gained access to the Empire State Building's antenna, which rises well above public areas of the 102-story building. Building management said in a statement that the episode was "unauthorized" and didn't endanger anyone in the skyscraper. The management didn't answer questions about how the two reached the antenna and what interactions, if any, they had with security workers. Empire State Building visitors are screened and told not to bring large packages, sports equipment, costumes or masks, among other items.

Subsidised urea diversion: Punjab Police books MILKFED officials, private company owners

The Khanna Police have booked MILKFED officials, including the General Manager, and owners of two private firms for allegedly "diverting the subsidised neem-coated urea supplied by the Government of India (GoI) for farmers". The persons booked have been allegedly passing off subsidised urea as technical-grade urea for "personal profit-making" and "causing loss to the state exchequer". An FIR has been registered against the General Manager (GM) and other officials of MILKFED's cattle feed plant located on GT Road, Khanna; and the owners of two private companies — Muktsar-based M/S Indo Organics and Delhi-based M/S Manisha Trading Company. Punjab government-owned milk cooperative MILKFED owns the popular milk product brand "Verka" in Punjab. It runs two plants, one at Bhattian village, Khanna, and the other in Gurdaspur. The FIR was filed based on a complaint by Gurbuneet Kaur, an agriculture development officer. Kaur claimed that the neem-coated subsidised urea meant for farmers was "filled in the white bags and passed off as technical-grade urea". "The subsidy provided to farmers by the GoI was misused for personal profiteering; and a loss has been caused to the state exchequer," the FIR said.

Panchkula police's 'Op Maidan 2.0' campaign: 404 drug traffickers on bail put under surveillance, 22 drug hotspots identified

VISAKHAPATNAM.(Agency)

Panchkula police said that 404 drug traffickers currently out on bail had been put under continuous surveillance, and that they identified 22 drug hotspots across the district during their month-long anti-narcotics "Operation Maidan 2.0" campaign in a bid to prevent repeat offences and dismantle drug networks. Police said during the campaign, they seized narcotics worth Rs 6.3 crore and arrested 34 drug traffickers in 21 cases registered under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. During the month-long drive, police teams conducted 253 raids with the assistance of dog squads, searched 719 suspicious vehicles, and intensified surveillance at vulnerable locations. A total of 23 CCTV cameras are monitoring the identified hotspots, while 41 previously defunct cameras have been repaired and made operational, according to police. Launched on May 28 under the leadership of Police Commissioner Pankaj Nain, the campaign focused on dismantling supply chains rather than merely arresting street-level peddlers. Police seized 2.787 kg of heroin, 11.757 kg of opium, 931 grams of charas, 1.045 kg of ganja and 67 grams of cocaine, with the total value of the recovered contraband estimated at around Rs 6.30 crore. Investigations are continuing to trace the supply network and identify key suppliers.

Court dismisses notice of motion filed by journalist expelled for press club

Mumbai.(Agency)

The Mumbai City Civil court on Wednesday dismissed a notice of motion filed by senior journalist Gurbir Singh, who had sought a stay on his six-year expulsion from the Mumbai Press Club till a suit filed by him is decided. Singh and two others were expelled for six years from its membership, over an informal meeting held at the club's terrace on January 19, with some of the Elgaar Parishad accused in attendance.

While the civil court had in May stayed the expulsion and issued notices to the press club and others to seek their response, the current office-bearers had approached the Bombay High Court. The high court had on May 22, stayed the civil court's order stating that it did not assign any reason or basis to arrive at the conclusion to grant Singh a stay and also permit him to contest elections of the club. The High Court had also later directed the court to decide the notice of motion by June 20, setting aside the previous relief. City Civil Judge A H Baig said in the order on Wednesday that Singh had failed to make a prima facie case for interim relief, and dismissed it with costs.

It said that the club's action was according to its rules, with no malafides on its part. Singh had said in his plea that the club's inquiry committee's inquiry based on which the suspension was ordered was not conducted as per procedure. The club's office-bearers opposing this contention said that Article 11 of the Club's bylaws which deals with disciplinary action, was followed. "After going through all the documents, prima facie it appears to me that the Club has substantially followed the procedure before taking disciplinary action against the plaintiff (Singh) and other two members.

Rajkot demolitions: Rs 27 lakh food bill rejected; tenders issued since 2023 'under review'

Mayor says food procurement done without tender; SIT to probe bills worth Rs 3 crore for irregularities.

In response to allegations of misappropriation of public funds and lack of tender processes followed for the demolitions carried out in Jangleshwar here in February, Rajkot Municipal Corporation (RMC) on Wednesday rejected a bill amounting to Rs 27.20 lakh. The amount was spent on food expenses of its officials that month. The bill was put up for review by RMC's standing committee, which also placed all tenders issued by the civic body since 2023 "under review".

Also, the has learnt that a special investigation team (SIT) chaired by a deputy municipal commissioner will probe the allegations of financial irregularities in bills worth almost Rs 3 crore. Shortly after the standing committee's meeting, Mayor Nehal C Shukla said, "The standing committee has rejected the food bill as it was not in line with the regulations of the state finance department since no tender had

been issued for it. This is the only bill that was put forth before RMC for consideration." On the reason why the food procurement had been done without a tender, even when eviction notices were issued two months



prior, Shukla said: "That's because there was an urgency. While notices had been issued earlier, the scale of the demolitions and their timing were decided only shortly before they were carried out."

However, a senior corporation official, on the

condition of anonymity, said, "A food tender was floated earlier, but the lowest bidder had proposed to charge Rs 240 per plate, which was why it was rejected. We then approached a voluntary organisation, which supplied food at Rs 110 per plate and buttermilk for Rs 20 per bottle."

The Wednesday meeting was presided over by Pares Pipaliya, the committee chairman. Speaking to The Indian Express, he said, "The food bill of Rs 27.20 lakh presented for approval was rejected. It was even put forth in the first meeting, but more information was sought on the expenditure. We rejected the bill today because the tender process had not been carried out."

When asked if the vendor would now have to bear the loss, Pipaliya said: "Officers will deal with that issue." However, administrative officials said the food bill could be put up for approval again on the basis of the SIT's findings.

Air Marshal PV Shivanand takes over as South Western Air Command chief

AIR MARSHAL P V Shivanand assumed charge as Air Officer Commanding-in-Chief, South Western Air Command (SWAC), headquartered in Gandhinagar, Gujarat, on Wednesday. Commissioned into the Fighter stream of the Indian Air Force in December 1988, Shivanand was previously the Senior

Air Staff Officer at HQ Central Air Command, a statement said.

Air Marshal Shivanand has a cumulative flying experience of 2,800 hours on MiG-21 and the IL-76 AWACS. He has spearheaded the operationalisation of key platforms and several Air Defence initiatives. The SWAC operates over the entire western region across

Gujarat Rajasthan and parts of Maharashtra.

The AOC-in-C of SWAC, a three-star rank officer, is the senior most military commander stationed in Gujarat. The Army and Navy have two-star officers, a Major General and Rear Admiral, stationed in Gujarat. Meanwhile, his predecessor at SWAC, Air Marshal Tejinder Singh, took over as the Chief of Integrated Defence Staff to the Chairman Chiefs of Staff Committee (CISC), said the statement. Singh's appointment as head of the Integrated Defence Staff broke a streak of SWAC chiefs going on to be appointed Vice Chiefs of Air Staff (VCAS) of the Indian Air Force (IAF).

Singh's immediate predecessor at SWAC, Air Marshal Nagesh Kapoor had been the second consecutive SWAC chief to be appointed Vice Chief of Air Staff (VCAS)—the 50th—in January 2026. Kapoor's immediate predecessor at SWAC, Air Marshal Narmadeshwar Tiwari, also went on to serve as the 49th Vice Chief of the IAF.

Supreme Court stays trial against officer accused of secretly filming ex-Anand collector

The Supreme Court on Tuesday stayed criminal proceedings against Ketki Vyas, a Class-I Gujarat Administrative Service officer and former resident additional collector of Anand, in the 2023 alleged case of spy-camera blackmail. Vyas was accused of secretly filming then Anand collector D.S. Gadhvi's private moments and using the footage to force him into clearing official files.

A Supreme Court bench of Justice MM Sundresh and Justice Sheel Nagu issued notice on Vyas's special leave petition, filed through advocate Aum Kotwal, challenging the Gujarat High Court order that rejected the application seeking her discharge from the case. The SC ordered that, pending further consideration, the criminal trial against her would remain halted. The Supreme Court's interim

order dated June 30 stated, "Issue notice, returnable on 24.08.2026. In the meantime, there shall be an order of stay on further proceedings qua the petitioner arising out of (the criminal



case)." The SC also condoned the delay in filing the petition and allowed Vyas's applications seeking exemption from filing the certified copy of the impugned judgment and official translations, besides permitting additional documents to be placed on record. Vyas was arrested,

along with deputy mamlatdar Jayesh Patel and advocate Hareesh Chavda, in August 2023 in a case that sent shockwaves through Gujarat's bureaucracy.

According to investigators, the trio procured and installed hidden cameras in the Anand collector's chamber to secretly record Gadhvi's meetings with a woman visitor and later used the footage to compel him to clear disputed land files and other official matters. The prosecution alleged that Patel carried a laptop containing the footage to Gadhvi's office and threatened to release the videos and initiate criminal proceedings through the woman unless the files were cleared. The charge sheet further alleged that copies of the videos were stored on flash drives and later shared with media organisations.

Cabinet approves Rs 579 crore Jaydev Vihar-Nandankanan road corridor

In what would be one of the most ambitious urban infrastructure project in the capital city, the state cabinet chaired by Chief Minister Mohan Charan Majhi on Wednesday cleared the 9.5-km Jaydev Vihar-Nandankanan road, which will transform connectivity between Bhubaneswar and Cuttack.

Briefing mediapersons after the cabinet meeting at Lok Seva Bhawan, chief secretary Anu Garg said the project will be executed on a turnkey basis by Dineshchandra R Agrawal Infracon Pvt Ltd, the lowest bidder at 579 crore. The project is targeted for completion within 24 months.

The Works department had earlier accorded administrative approval for the project at an estimated cost of 949.35 crore in January this year. The corridor, stretching from Kalinga Stadium (Gate No. 4) to Raghunathpur bridge, will be widened from six lanes to an eight-lane carriageway with service roads and modern traffic infrastructure.

A key feature of the project is the construction of four flyovers at Jaydev Vihar (cable-stayed bridge), Kalinga Hospital Square, Damana Square and KIIT Square along with improvements at Kalarahanga Junction. The project also includes service roads, slip roads, pedestrian subways, underground parking, drainage systems, bridges, roundabouts, road safety measures, lighting, landscaping and avenue plantation.

While she was in conversation with the resident, her phone buzzed. "Ma'am, where are you? I will come give you my family's documents," said Mushraf Ali Peerzada, the voice on the other side. Even though Shinde assured him that she would visit his residence to collect his information, Peerzada insisted on getting his family's enumeration process started. Within a few minutes, he arrived at the location and provided necessary identity

documents like passport-sized photos of his family members to the BLO.

"I have gotten at least six to seven such calls since the morning. They are all from Muslim families. They are anxious and insist that they will come and deliver their documents to us even if we tell them we will be visiting their house over the next few days," said Swati Owhal, another BLO working in the same region.

"The SIR is currently being conducted by the Election Commission of India in various states. The door-to-door distribution of enumeration forms commenced in Maharashtra on June 30 and will continue till July 29. The controversial SIR in West Bengal left over 27 lakh people

GBA takes up safe footpath drive, clears 75km

Amid a hue and cry by hawkers across five city corporations under Greater Bengaluru Authority (GBA), a footpath encroachment clearance operation was initiated as part of the 'Safe Footpath Campaign' on major arterial and sub-arterial roads. As per the GBA, more than 75km of road was covered on the first day of the operation.

While hawkers have been visiting the GBA head office in batches to convince the authorities, the encroachment clearance operation was conducted on major roads with the aim of providing safe, smooth and uninterrupted pedestrian movement.

The officials began to act swiftly only after standing instructions from Bengaluru Development Minister Krishna Byre Gowda, who stated that around 300 pedestrian deaths in Bengaluru are due to unsafe footpaths.

Municipal officers/staff, with police security, using bulldozers, tractors and other vehicles, removed all types of encroachments on footpaths, including nameplates, stairs, OFC cables, sheets installed on shops, construction waste, pushcarts, permanent boxes, temporary sheds, unauthorised iron structures, etc., that obstruct the movement of the public.

The GBA has also appealed to shop owners, commercial establishments, private institutions and street vendors in all five city corporations to voluntarily clear encroachments on footpaths. If encroachments are not removed voluntarily, a clearance operation will be conducted as per rules, and legal action will be taken if necessary.

The minister, who is managing the drive at the macro level, said, "Every resident of Bengaluru has the right to safe and obstruction-free footpaths. I appeal to citizens, traders, commercial establishments and all stakeholders to join hands with the city administration in keeping our footpaths free from encroachments.

Storms in World Cup, XL edition

This is the XL World Cup, much in the image of the main co-host, the United States, where everything is supersized—from food portions to the NFL stadiums where most of the matches have been played. According to Fifa president Gianni Infantino, this World Cup is bigger and better than ever. Indeed, his expansionism will allow him to channel ever-more revenue to the 211 member associations and consolidate his power. But the first 48-team tournament—played in three countries, another first—is simply too bloated. At every match, from Mexico City to Vancouver and from San Francisco to Boston, Fifa welcomes spectators to “The greatest show on Earth”. But the progress of that show has been slow and meandering. It took 72 matches to eliminate 16 teams from the group phase. Yet, the stage offered some dramatic moments—like when Folarin Balogun, a player of Nigerian descent, scored a brace for the US in the opening match, when Morocco’s 18-year-old Ayyoub Bouaddi orchestrated the midfield against Brazil, and when Lionel Messi and Ousmane Dembélé scored hat-tricks against Algeria and Norway.

Every World Cup stages David-and-Goliath battles, too. In 2026, Cape Verde are playing David with aplomb. Alongside Iceland and Curaçao, the island nation ranks among the minnows of World Cup history. But manager Bubista, goalkeeper Vozinha and centre-back Pico have become household names, engineering Cape Verde’s progress from the group stage with three hard-fought draws, including holding mighty Spain in their opening match. However, that fairy tale has been somewhat tainted after accusations of rape against team captain Ryan Mendes. Cape Verde is part of the story of Africa, the continent that has benefitted most from the tournament’s expansion, as nine of its 10 teams—double the number represented at previous World Cups—advanced to the knockout stages. The only disappointment was Tunisia, who dismissed their manager halfway and exited early with a goal difference of -10.

The North Africans belonged to a class of teams that perhaps had little business being at the World Cup. Scotland, Czech Republic, Türkiye, New Zealand, Qatar, Iraq, Saudi Arabia, Curaçao, Bosnia and Herzegovina, Uzbekistan, Jordan and Panama, too, demonstrated large gaps in quality. It brings us back to the point that Fifa’s World Cup expansion was always about generating revenue, with the 2023-26 cycle projected to bring in \$13 billion. The sport’s global governing body can achieve its mission—to develop football around the world—without diluting the quality of its main tournament. After all, under Infantino, Fifa has already distributed more than \$5 billion in development money. But this isn’t all. The South American nations, spearheaded by regional confederation Conmebol’s boss Alejandro Domínguez, have been advocating for a 64-team World Cup in 2030 as a centenary celebration of the tournament, whose first edition was held in Uruguay in 1930. It’s perhaps a leverage to stage more group matches, but other confederations have opposed the idea. Ghana manager Carlos Queiroz summed up the format controversy: “The number of teams that qualify for this competition can turn it into something vulgar and ordinary. When so many teams can qualify, is the value still rare? That would seem debatable to me, but it’s only my opinion. For now, the smaller nations will have to survive the round of 32 to back up their credentials. Meanwhile, Asian powerhouse Japan showcased their development under manager Hajime Moriyasu’s possession-based game.

The Moroccans benefited from both the diaspora and talent developed at home. They went up against five-time winners Brazil and three-time finalists Netherlands, who have industrialised talent development. Brazil resemble Carlo Ancelotti’s Real Madrid: disjointed but with flashes of genius that are often delivered by Vinícius Júnior. At a deeper level, they have fallen behind Europe.”

An invoice for Netanyahu

He might appreciate that Kasol therapy restores Israeli youth’s capacity to be recalled for battle

THE late Narindar Singh taught economics, but his economics was of a different kind. He wrote just two books and both were unique. In his 1976 book, *Economics and the Crisis of Ecology*, he suggested new ways to calculate the cost of the harm done to the environment by the pursuit of profit and economic growth. He was among the rare few in the field of economics who questioned the established procedure of estimating the value of a tree by measuring its timber. He asked us to look at the wider canvas, which includes the future. A tree provides many services during its lifetime. It holds the soil and does not allow erosion; it provides a habitat for birds and insects; if it is a fruit tree, its value for humans goes beyond the shade it provides and its aesthetic presence. All these would go when the tree is cut down. These days, contractors offer to relocate it: they are reasonably sure that no one will recall its new home, let alone inspect it. Narindar Singh’s formula would have given the State far bigger revenue in projects involving shaking down forest-covered hills for the construction of new highways that shorten dhHis second book, *The Keynesian Fallout* (1996), cut a deep hole in the compensatory employment theory by distinguishing sensible from harmful work. If a rave party offers employment in garbage collection—including bottles of alcohol—it can hardly be called meaningful work.

I was reminded of Narindar Singh’s work when I read Sonali Gupta’s article, ‘High in Kasol’ in *The Tribune* (June 21). It introduces us to the scale and range of problems faced by nature and society in Kullu’s Parvati valley. The village of Kasol serves as a comfort and renewal site for young, mentally exhausted people from other countries, especially Israel, riving time to distant tourist spots from polluted cities. Israel has a tough conscription policy under which every 18-year-old must devote 32 months to military service. I have known for many years the role Dharamsala played as a recovery site for these young men and women. Kasol is a different kind of refuge. In Dharamsala, the Dalai Lama’s presence gave the agitated mind a sense of calm and purpose. Kasol offers rave parties. Kasol plays its therapeutic role with the help of DJs, loud electronic music, strobe lights, alcohol and drugs. Gupta portrays a frightening picture of Kasol. Her concern has been testified by a court order against senior police officers for negligence in controlling the ravages of Kasol’s rave culture.

Conscription is not unique to Israel, but its meaning and social impact there is special. Over two decades ago, I had the occasion to visit a few Israeli schools. By any routine standards, these were good schools, with hardworking



teachers and a system that cares for every child, except that in Israel, “every” means Jewish. The complex history—and even more complex geography—of Jewish-Palestinian relations makes childhood a deeply politicised concept in Israel. The education system is also sharply divided in terms of curriculum, textbooks and opportunities. It is not easy for other nations to make sense of Israel. A new book by Omer Bartov, *Israel: What Went Wrong?* (Penguin, 2026) explains its current convulsion. Bartov starts by introducing the reader to its short history which began in 1948 with the violent displacement of a long-settled Palestinian society. Israel’s perpetual war is nothing less than fate. Many Israelis recognise that reconciliation and justice for the Palestinians is the only way to erase collective guilt and fear of revenge, but this recognition has no political value. Only war and territorial expansion have. All three schools that I visited had an honour list painted in the foyer near the national flag. This list showed the names of former students killed in various wars Israel has fought. The history taught in schools ignores the brutal nakba (catastrophe in Arabic) that the Palestinians had to suffer when Israel was created after World War II as a kind of compensation for the Holocaust that the Jews had suffered under Hitler. This short discussion of a complicated inheritance that shapes childhood and adolescence in Israel is hardly sufficient to grasp why Israeli youth crave for radical unwinding after their conscription years. Rave parties in the Parvati valley seem to have become a favoured mass therapy resource. The arrival of rave culture—and its economy—marks yet another chapter in the wild growth

of tourism in Himachal Pradesh. Every year, the monsoon brings Himachal’s renowned tourist spots back into disaster news. Bridges and highways are washed away. Buildings tumble, tourists are stranded, but everything eventually fades out like the violent part of a movie. Work on new projects resumes along with repair work at sites of devastation. The state’s commitment to maintaining its fame as a destination for the pleasure seeker survives the rainy season. If you thought some lessons would be learnt, you would feel sorry for yourself. Now, if rave parties in Kasol are exacerbating the environmental crisis and bringing drugs into the social ethos, it is not going to ring alarm bells. Let us, for our own benefit, apply the Narindar Singh formula to measure the consequences of rave culture financially. If the stressed Israeli youth were to seek psychological therapy in their own country, they would pay a high professional fee. Himachal should mention that fee in an imaginary invoice for Prime Minister Benjamin Netanyahu.

Given his commitment to Israel’s ideology of perpetual war, he might appreciate that Kasol therapy restores his youth’s capacity to be recalled for battle. For the brute valour they would show, their unwinding in Kasol becomes a State responsibility. The invoice from Himachal will indicate that they were given a good opportunity to feel restored after their tough years of conscription. If Netanyahu doesn’t like the invoice, it will still serve a purpose. Future generations of Himachal’s devastated landscape and drug-poisoned social ethos will treat the invoice as a reference point to figure out what began at Kasol.

Chanda chori’ charge : Temple donations must inspire trust

The controversy highlights the dangers of reducing sensitive religious issues to political ammunition

THE controversy over the alleged misappropriation of donations meant for the Ram Mandir is a reminder that faith and accountability must go hand in hand. The row stems from allegations that some individuals collected money in the temple’s name through unauthorised means and diverted it for personal gain. A petition seeking an investigation into the alleged “chanda chori” (donation theft) reached the Supreme Court, though the court declined to entertain it directly and asked the petitioner to pursue the appropriate legal remedy. But the issue has quickly spiralled into a political slugfest, with the BJP and the Opposition trading accusations instead of allowing institutions to ascertain the facts. Religious institutions occupy a unique place in public life. Donations made to them are acts of trust and carry emotional and spiritual significance. That trust must be



protected through transparent financial management, regular audits and prompt disclosure whenever questions arise. Accountability is not an affront to faith;

it is the strongest guarantee of its integrity. The larger and more revered the institution, the greater its responsibility to demonstrate that every contribution is being used for its intended purpose.

The controversy also highlights the dangers of reducing sensitive religious issues to political ammunition. Opposition parties have accused the BJP of failing to prevent “donation theft” and demanded strict action against those responsible. The BJP has countered by accusing its rivals of exploiting a sacred issue for political gain. The distinction between questioning financial management and questioning faith itself must never be blurred. The way forward is an impartial and lawful inquiry. If the allegations are baseless, transparency will restore confidence. If irregularities are found, those responsible must face the law, regardless of their position.

How science is shaping art of war

Military reforms are about developing leaders capable of navigating the intersection of warfare, technology and organisational change

THE debate on military reforms and theatreisation has rightly highlighted an important reality: military transformation cannot be the responsibility of a single individual, institution or appointment. While the creation of the Chief of Defence Staff (CDS) and the efforts toward jointness and theatre commands are significant milestones, they represent only one part of a much larger transformation that the forces must undertake. The central challenge facing militaries worldwide today is adaptation to a rapidly changing character of warfare. The nature of war may remain constant, but the means through which military power is generated, exercised and sustained are undergoing a profound change. Consequently, military reform must be viewed not only through the lens of structures and command arrangements but also through the lenses of technology, human capital, doctrine and national capability. The future battlefield is increasingly defined by technologies that transcend traditional service boundaries. Multi-domain operations (MDO), integrated intelligence, surveillance and reconnaissance (ISR), net-centric warfare, sensor-to-shooter architectures, AI-enabled decision support, cyber warfare, electronic warfare, autonomous systems, drones, robotics and space-based capabilities are redefining how military power is applied. In such an environment, military effectiveness will depend less on the number of platforms a nation possesses and more on how effectively it connects sensors, decision-makers and effectors across all domains. The decisive military advantage of the future will not come merely from possessing tanks, aircraft, ships or missiles. It will come from achieving decision superiority—the ability to observe, orient, decide and act faster and more accurately than an adversary. This requires integrated systems, common operational pictures, secure communications, data fusion, AI-enabled

analytics and resilient networks. Theatreisation can facilitate such integration, but it cannot create it by itself. A theatre command without integrated data architecture may simply become three services operating under a common headquarters. True transformation demands much more. If future military capability is tech-driven, then military reforms and technological self-reliance become inseparable. India’s pursuit of Atmanirbharta in defence must therefore extend beyond manufacturing platforms. Indigenous production of equipment is important, but the future battlespace will increasingly be shaped by control over software, algorithms, data, communications, cyber capabilities, sensors, semiconductors, autonomy, and artificial intelligence.

Dependence on external sources for critical technologies may create vulnerabilities far more significant than dependence on traditional military hardware. AI models, data repositories, operating systems, communication networks, cyber tools and digital infrastructure are becoming strategic assets. Technology-driven military reforms therefore require technology-driven Atmanirbharta. This demands a national effort involving the armed forces, academia, startups, industry, research institutions and policymakers. Defence capability can no longer be viewed solely as the output of military organisations. It is increasingly the product of an entire national innovation ecosystem.

Much of the military leadership architecture of today was designed for the industrial-age military. The challenges of the future are different. The AI age requires leaders who can operate simultaneously in the physical, informational, cyber, cognitive and technological domains. It requires institutions capable of rapid adaptation. It requires closer

integration between military organisations and national innovation ecosystems. Most importantly, it requires recognition that military reforms extend far beyond headquarters’ reorganisation. Theatreisation, jointness, and organisational restructuring are necessary. But they are only part of the solution.

The larger challenge is creating a force capable of



achieving decision dominance in an era characterised by data abundance, algorithmic warfare, autonomous systems, cyber contestation, and persistent surveillance. The discussion often evokes an important counterpoint—that while technology continues to advance at an unprecedented pace, the enduring principles of warfare remain unchanged. Leadership, judgment, initiative, courage, strategic foresight and operational art will

always lie at the heart of military success. The art of war therefore retains its relevance and primacy.

However, the challenge before modern militaries is not one of choosing between the art and the science of war. It is about understanding how the science of war is increasingly shaping the manner in which the art of war is conceived and executed. Historically, technological change certainly influenced warfare, but its impact on operational decision-making and battlefield outcomes was often limited by the pace of information flow and the relative simplicity of military systems. Today, the relationship has fundamentally changed. Artificial intelligence, integrated ISR networks, cyber warfare, electronic warfare, space-based capabilities, autonomous systems and sensor-to-shooter architectures are no longer peripheral enablers. They increasingly determine how commanders perceive the battlefield, generate situational awareness, make decisions and apply combat power. They are becoming central instruments through which military commanders achieve operational effects.

A commander who lacks technological understanding may struggle to exploit emerging capabilities effectively. Equally, technologists who lack understanding of warfighting realities risk creating solutions in search of problems. The art of war and the science of war can therefore no longer be viewed as separate domains. Modern operational art is increasingly exercised through technological systems. A commander may still rely on intuition, experience and judgment, but these are now informed by data, algorithms, networks and machine-assisted decision support. The commander remains central, but the tools through which command is exercised are undergoing profound transformation.

Bhagwant Mann leaves for Bengaluru for detox programme amid Akal Takht row

Punjab CM Bhagwant Mann has been under scrutiny following the Akal Takht's decision to declare him a 'Guru dokhi' (anti-Guru) and 'Khalsa panth virodhi' (anti-Khalsa community).

Punjab Chief Minister Bhagwant Mann left for Bengaluru on Thursday morning for a four-day detox programme at a private wellness institute, days after facing censure from the Akal Takht over the controversy surrounding his video message responding to the Sikh temporal body's criticism. Sources said Mann boarded a flight at around 7.30 am and is expected to return after four days. "He is likely to come back on Monday. But he may extend his trip," a source added. Mann's Bengaluru visit comes a day after he launched the Mawan Dhiyan Satkar Yojana from his home constituency of Dhuri, where the state government

credited financial assistance to around 36 lakh women beneficiaries under its flagship welfare scheme. The timing of the visit is significant as the chief minister has been under political and religious scrutiny following the Akal Takht's decision to declare him a "Guru dokhi" (anti-Guru) and "Khalsa panth virodhi" (anti-Khalsa community). The censure came after a video in which Mann criticised the Akal Takht for its directions to Punjab legislators to amend the state's anti-sacrilege law. The issue has since dominated Punjab's political discourse, with Opposition parties stepping up attacks on the Aam Aadmi Party (AAP) government.



In 2022, a similar trip. This is not the first time Mann has gone for a detox programme. In October 2022, a few months after assuming office as chief minister, he had travelled to a private wellness facility in

Bengaluru for a similar programme. The visit had come amid persistent speculation over his health and drinking habits after videos showing him appearing unwell during public engagements had triggered political attacks. AAP had then maintained that the chief minister was undergoing a routine health check-up and detox programme. Mann later resumed official duties after returning and subsequently said publicly that he had given up alcohol. Government sources maintained that the chief minister's Bengaluru visit had been scheduled in advance and was unrelated to the political controversy.

Haryana ranked third in SGST collections, after Gujarat and Andhra Pradesh

Haryana celebrated the ninth anniversary of the successful implementation of the Goods and Services Tax (GST) with a state-level function in Panchkula on Wednesday, highlighting the state's remarkable revenue growth and its emergence as one of the country's top-performing GST administrations.

The function was presided over by Ashima Brar, Commissioner and Secretary, Excise & Taxation Department, and attended by Vinay Pratap Singh, Excise & Taxation Commissioner, senior departmental officers, members of the tax bar, chartered accountants, tax practitioners, and representatives of trade and industry. Delivering the keynote address, Ashima Brar traced Haryana's GST journey over the past nine years and highlighted the state's success in overcoming implementation challenges while building a robust and transparent tax ecosystem.

She noted that the state's GST revenue has more than doubled between 2018-19 and 2024-25, reflecting sustained economic growth and improved tax compliance. Despite accounting for only 1.34 per cent of India's geographical area and 2.2 per cent of its population, Haryana contributes nearly 7.4 per cent of the country's total GST collections, underlining its strong industrial and commercial base.

Brar also highlighted the landmark GST reforms introduced in September 2025, which simplified the earlier multi-tier tax structure into a practically two-rate regime. The reforms also eliminated the inverted duty structure in most sectors, rationalised tax rates, placed all merit goods in the 5 per cent slab and standard consumer goods under the 18 per cent rate, thereby reducing the tax burden on consumers while making the GST framework simpler and more efficient.

Haryana Governor calls for time-bound, transparent delivery of welfare schemes to every eligible beneficiary

Maharashtra introduces bill to recognise women farmers

The definition of farmer in the Maharashtra Women Farmers Empowerment Bill, 2026, says that any woman resident of Maharashtra engaged in agriculture, irrespective of the nature of the land.

Maharashtra government on Wednesday introduced a bill to recognise women farmers and issuance of woman farmer certificates in order to enable their access to various welfare policies, programmes, scheme and credit. The definition of farmer in the Maharashtra Women Farmers Empowerment Bill, 2026, says that any woman resident of Maharashtra engaged in agriculture, irrespective of the nature of the land.

It further stated that it contribute to any type of innovation, conservation, preservation or propagation of diverse agricultural varieties of seeds, any type of farm animals and fish, cultivation methods for climate resilience, practice of integrated farming system; add value to primary produce or

raw agricultural and animal produce by engaging in primary processing. "The agricultural policies, schemes, and extension systems are largely gender-



neutral. However, the requirement of land ownership as a precondition for access to most agricultural schemes and underlying entitlements has rendered such schemes inaccessible to many women farmers,

since only a very small percentage of these women own agricultural land," said the statement of objects and reasons for the bill. It added that women who cultivate family or community land without holding formal titles to the land are often counted as agricultural labourers rather than farmers.

"Similarly, women who are engaged in allied non-cultivation-based activities such as fishing, collection of minor forest produce, poultry, animal husbandry, etc., are also not recognised as farmers. This systemic non-recognition of women farmers and their agricultural labour is significant and leads to other forms of exclusion, including, but not limited to discrimination in access to schemes, credit and markets," it said.

Ayodhya row heats up, UP weighs option to send probe to Central agency

Amid the clamour for a speedy probe into the alleged theft and embezzlement of funds and valuables donated to the Ram temple in Ayodhya, the Uttar Pradesh government is actively considering the option of turning over the investigation of the case to the CBI or another Central agency. The Indian Express has learnt.

Sources said since the matter constitutes an economic offence which requires deep investigation, the option of handing over the case to the CBI or another Central agency is being looked at. The state SIT, which submitted a

preliminary report on its findings, was Wednesday granted time until July 15 to complete its probe. It will be revisiting Ayodhya Thursday to conduct further inquiries.

Sources said a parallel probe by the Ayodhya police has only uncovered cash allegedly stolen in recent months — eight persons have been arrested and are currently in judicial custody — and an extensive investigation is required to trace movable and immovable assets acquired by the accused

who were involved in the work of counting cash and valuables. Ever since it submitted its preliminary report to the office



of the Chief Minister on June 23, the SIT has not visited Ayodhya. The local police, which registered an FIR on June 25, have conducted

searches in Ayodhya and the adjoining districts of Pratapgarh, Gonda and Basti. Police have so far recovered Rs 79.80 lakh from the eight accused.

The SIT, sources said, has already questioned all trustees of the Shri Ram Jambhoomi Teerth Kshetra Trust including top office-bearers Champat Rai, Anil Mishra and Gopal Rao. Details obtained from the trustees, sources said, were related to their role and involvement in the management of the cash and valuables dropped by devotees in the temple's donation boxes.

Haryana: Panchkula police launches month-long drive to protect senior citizens living alone

In a proactive step to strengthen the safety net for elderly residents, Panchkula police have launched a month-long special campaign to ensure the security and well-being of senior citizens living alone.

The initiative, launched under the direction of Police Commissioner Pankaj Nain, combines regular police outreach, cybercrime awareness and emergency response mechanisms to safeguard vulnerable citizens. Police Commissioner Pankaj Nain said the campaign aims to provide senior citizens with a secure environment by maintaining close police contact and protecting them from crimes such as cyber fraud, digital arrest scams, online financial cheating and other criminal activities.

He said Panchkula Police is committed to ensuring that elderly residents receive immediate assistance whenever required. During the first week of the campaign, police teams led by DCP Panchkula Srishti Gupta visited 78 senior citizens living alone across the district to assess their security requirements. The exercise is being expanded to identify and reach all such senior citizens so that no vulnerable person is left out.

As part of the drive, police are conducting a detailed survey and creating an online database of senior citizens to facilitate prompt assistance during emergencies. Verification of domestic helpers, drivers, cooks, gardeners and other household staff is also being undertaken to strengthen residential security. Police teams are encouraging senior citizens to install CCTV cameras and are sensitising them about cyber fraud, digital arrest scams, suspicious visitors and safe online practices.

To ensure quick access to police assistance, contact details of the concerned Station House Officer or Police Post In-charge have been shared with every senior citizen. Panchkula Police has also activated a dedicated helpline, 9115777026, for senior citizens and their family members. Beat officers and local police personnel will make regular visits to monitor their well-being and address their concerns.

NEARLY a month after a 40-year-old woman was sexually assaulted by two men, while other accomplices took a video, the Jalgaon police arrested 11 persons and apprehended three minors after the video began circulating on social media. On June 2, the accused were visiting a forest area in Jamner taluka to collect firewood, when they saw the woman with a 38-year-old male friend. They were known to each other and began threatening her. Two of the men raped the woman, while others filmed the act. While initially the woman did not file a complaint due to the threats by the accused, the video subsequently began circulating on social media around June 25. A complaint was filed by the Fatehpur police on Monday, which names 15

persons in all — 14 including the two who assaulted her have been apprehended, an official said. The accused also threatened the male accompanying the victim.

The Fatehpur police has filed a complaint under Section 70 (1) (gangrape) and Section 77 (voyeurism) of the Bharatiya Nyaya Sanhita and relevant sections of the Information Technology Act for the circulation of the video.

Police officials said that a probe was on to identify the role played by each of the arrested, and those behind the circulation of the video.

Delhi CM Rekha Gupta offers: Can cut House term for simultaneous polls

Describing the concept of One Nation One Election as “the need of the hour”, Delhi Chief Minister Rekha Gupta Wednesday told the Joint Committee of Parliament on Bills relating to simultaneous elections that her government would be willing to consider adjusting the tenure of the Delhi Assembly to align with that of the Lok Sabha. She pointed to cutting short the Assembly’s term which currently ends eight months after that of Lok Sabha.

The committee, chaired by BJP MP P P Chaudhary, conducted a study visit in the Capital, meeting the Chief Minister at the Delhi Secretariat, Speaker Vijender Gupta and representatives of parties at the Assembly and Lieutenant Governor Taranjit Singh Sandhu at Lok

Niwas.

In a statement, the Chief Minister’s Office said: “Referring to Delhi, she (Gupta) pointed out that elections in the national Capital are held roughly a year apart from the Lok Sabha elections. If aligning election schedules at the national level requires a suitable adjustment in Delhi’s tenure, the Delhi Government is willing to consider it with a positive approach. If required in the national interest, she said, Delhi could be among the leading states to extend such cooperation.” The next Lok Sabha elections are likely in April-June 2029, as the term of the House ends on June 23, 2029, while the Delhi Assembly’s term ends on February 23,

2030. Since its formation in December 2024, the committee has held consultations with stakeholders in Delhi

impact of frequent elections on different sectors like education and labour,” he said.

While the Bills in their current form provide for the first simultaneous elections in 2034 by cutting short the terms of all Assemblies elected after the Lok Sabha elections of 2029, Chaudhary, speaking at the Idea Exchange programme of The Indian Express recently, that if some states want, they can curtail the terms of their Assemblies to align with the 2029 elections too.

According to the CMO statement, the Chief Minister said One Nation One Election was the need of the hour. A statement from the Assembly Secretariat said Speaker Vijender Gupta made suggestions to the committee

during their meeting, including conducting a “comprehensive examination of issues relating to the synchronisation of electoral cycles, constructive votes of no-confidence, premature dissolution of legislatures, harmonisation of electoral rolls, strengthening the logistical preparedness of the Election Commission, and institutional mechanisms to ensure political stability while preserving India’s democratic and federal character.” It is learnt that during the meeting with the Speaker and MLAs, it was suggested to create a national forum with representation from each Legislative Assembly of the country to discuss the way forward and the need to extend the provisions of One Nation One Election to Rajya Sabha and municipal body elections.

Stone pelting during Hanuman Chalisa recital in Southwest Delhi

Days after local residents alleged that flags similar to that of Pakistan were hoisted during a Muharram procession in Southwest Delhi’s Sagarpur last Friday, fresh friction erupted in the area when stones were allegedly thrown during a Hanuman Chalisa recital organised by Bajrang Dal members on Tuesday, police said. Following the incident, a case has been registered under sections relating to voluntarily causing hurt and wrongful restraint against unknown persons.

According to police, the incident took place between 7 pm and 8 pm at a DDA park behind the jhuggi cluster in Gali 8 under the jurisdiction of Sagarpur police station. “A brief confrontation broke out at a DDA park after members of Bajrang Dal gathered to recite the Hanuman Chalisa and some nearby residents objected to the event,” DCP Amit Goel said.

According to another officer, “There were reports that a group of women started objecting to the recital of Hanuman Chalisa. Amid the commotion, some stones were thrown at those reciting the Hanuman Chalisa.” Police said tension in the locality had been simmering since Friday’s Muharram procession that passed through the area. “Some residents claimed that during the procession, they spotted Pakistani flags being hoisted. However, it was found later that they were religious flags not pertaining to any country,” said a source in the police.

Purported videos of the incident showed a group of women standing a few metres away from the DDA park, raising slogans. Another video from the Muharram procession showed a child waving a green-and-white flag in the same locality. While the police intervened and dispersed the two groups peacefully, the incident prompted the deployment of more than 100 police personnel in the area to keep a check on the law and order situation. Police said both groups were counselled and no injuries or damage to property were reported.

Delhi government approves annual fellowship programmes in archives and archaeology

The Delhi government has approved two new annual research fellowship programmes, in archives and archaeology, aimed at strengthening documentation, conservation and academic research on the national capital’s heritage. The ‘Research Fellowship in Archives’ and ‘Research Fellowship in Archaeology’ schemes will be implemented by the departments of Delhi Archives and Archaeology, respectively.

Under the archives fellowship, the government will engage 15 researchers every year for a one-year term — 10 Senior Research Fellows (SRFs), who will receive a monthly stipend of Rs 50,000, and five Junior Research Fellows (JRFs) who will get Rs 25,000 a month.

The archives fellowship will include research in seven areas: records management, conservation and preservation of archival material, digitisation of records, dissemination of information and data, micro-filming and reprography, research and publication, and oriental languages, particularly Urdu and Persian. Fellows will use rare manuscripts, maps, photographs and administrative records to study themes, ranging from Delhi’s institutional history and urban expansion to environmental history, festivals, cinema and social life. The archaeology fellowship will support 12 researchers annually — three SRFs each in archaeology and conservation, and three JRFs in both disciplines. Senior fellows will receive a stipend of Rs 50,000 a month, while junior fellows will get Rs 25,000 a month. Research under the archaeology scheme will cover topics such as the earliest settlements in the Delhi Ridge and Yamuna basin, the Painted Grey Ware and Northern Black Polished Ware cultures, early historic Delhi, trade routes, archaeology of the Yamuna floodplain, conservation of Delhi monuments, digital conservation, heritage conservation and climate change, public archaeology and community engagement, and encroachment and heritage preservation.

Processing capacity gap galore, Delhi stinks

The first part of this series examined how mixed waste, weak enforcement and inconsistent collection practices undermine the city’s waste management system at its very first step. But even if every household and commercial establishment segregated its garbage perfectly, the national capital would still face another structural challenge; it does not have enough infrastructure to process all the waste it generates each day, though authorities are working to expand capacity.

The Municipal Corporation of Delhi (MCD) is working towards an ambitious roadmap to expand the national capital’s waste-processing capacity by 13,550 tonnes per day (TPD) with the help of new waste-to-energy (WTE) plants, expansion of existing facilities and fresh waste-processing projects. This move is aimed at bridging the widening gap between waste being

generated and the one being processed.

According to official data accessed by this newspaper, the proposed projects, expected to be completed in phases between 2026 and 2028, would increase Delhi’s waste-processing capacity from the existing 7,841 TPD to over 21,000 TPD.



This comes at a time when Delhi generates nearly 14,000 metric tonnes of municipal solid waste every day. The MCD, the primary agency responsible for waste management across most of the city, currently has an installed processing capacity of only 7,841 TPD. Considering that the civic body is responsible for

managing waste in nearly 90-95% of the capital, the numbers indicate that the city may still be facing a processing shortfall of 6,000 tonnes daily, thereby putting continued pressure on the city’s landfill sites.

According to the MCD’s plans, 7,650 TPD of additional capacity will be created through new and expanded

WTE and compressed biogas (CBG) facilities. This will include a 3,000 TPD WTE plant at Narela-Barwana, a 2,000 TPD WTE plant at Ghazipur, expansion of the Okhla and Tehkhand WTE plants by 1,000 TPD each, along with new CBG facilities proposed at Okhla and Ghazipur.

Apart from that, the civic body also has five new waste-processing facilities in the pipeline with a combined capacity of 5,900 TPD at Bhalswa, Shinghola, Okhla, Bawana and Ghazipur.

Vehicle, construction curbs, work from home: Delhi moves to combat winter haze

In a move to combat air pollution during the winter months, the Delhi government has notified a series of restrictions that will come into force from November 1 to February 28 every year — from curbs on vehicles and construction activities, to staggered office timings and work from home.

Until now, the practice was to impose various stages of the Graded Response Action Plan (GRAP), depending on the air quality index (AQI), during these months. The implementation of GRAP — a framework mechanism under which the governments in Delhi and the National Capital Region (NCR) must take specific sets of actions — is overseen by the Commission for Air Quality Management (CAQM).

But with the new restrictions, notified on June 23 and made public on Wednesday, many of the measures will mandatorily come into force during this period. These restrictions are set to operate alongside GRAP.



This could tackle two key concerns. The move seeks to reduce disruptions to workplaces, educational institutions and transport through advance planning while addressing long-standing criticism that

pollution-control restrictions under GRAP are largely reactive as they are implemented as air quality deteriorates.

The notification said the framework was based on an analysis of air quality trends over the past three winter seasons, which showed that Delhi’s air quality consistently deteriorated between November 1 and February 15. During these months in 2023-24, 2024-25, and 2025-26, the city’s median AQI ranged between 312 and 342 (‘very poor’), while the peak AQI ranged between 461 and 494 (‘severe+’). According to the new restrictions, motor vehicles registered outside Delhi and below BS-VI emission standards will not be allowed to ply in the national capital from November 1 to January 31 every year.

Delhi Police apprehends Ghaziabad man over hoax bomb threat emails to multiple organisations

A 36-year-old man from Ghaziabad has been apprehended by the Delhi Police for allegedly sending a series of hoax bomb threat emails targeting several organisations, including the NIA, ISRO, DRDO and an Air India flight.

Officials said on Thursday that the accused has been undergoing treatment for mental illness since 2008. The emails, sent on June 29, claimed the presence of bombs at multiple high-security establishments, including the headquarters of the National Investigation Agency (NIA), Indian Space Research Organisation (ISRO), Nuclear Power Corporation of India Limited (NPCIL), Defence Research and Development Organisation (DRDO) and the Ministry of Civil Aviation (MoCA), the officials said.

A threat email was also sent for an Air India flight operating from New Delhi to New York, triggering immediate security checks and alerting multiple agencies. The police said all organisations concerned and security agencies were informed and standard safety protocols were followed, and the threats were found to be a hoax. Following the incident, an inquiry was initiated by the police, which tracked the digital trail of the emails.

During the technical investigation, the police analysed two mail accounts suspected to have been used to send the emails. A detailed examination of the email trail led investigators to a mobile number linked to the accounts, officials said. Using technical surveillance, the police team traced the suspect to Sanyog Nagar in Uttar Pradesh’s Ghaziabad on June 30. The police reached the location and examined the suspect, identified as Nishant Tyagi, at his residence, they said.

According to the police, Tyagi had pursued his education through open schooling and had enrolled in a bachelor’s degree programme in 2010 but did not complete it.

During preliminary inquiry, it emerged that he had allegedly been suffering from a mental illness since 2008 and had been undergoing treatment at various medical institutions over the years. His family members also informed the police about his prolonged medical history, officials said.

The police said no explosives or suspicious materials were recovered during the inquiry.

Tunnel to link Dwarka E-way with Vasant Kunj approved

8.1-km tunnel to link Dwarka Expressway with south Delhi; 117.7-km greenfield highway to halve Kanpur-Kabrai travel time as Centre targets smoother urban mobility and freight movement.

NEW DELHI: From Delhi’s gridlocked roads to the freight routes linking Uttar Pradesh and Madhya Pradesh, commuters and businesses got a Rs 14,114.81-crore infrastructure boost on Wednesday. The Union Cabinet approved a six-lane tunnel connecting the Dwarka Expressway with south Delhi and a new access-controlled highway linking industrial Kanpur with mineral-rich Kabrai. Together, the projects promise faster travel, smoother logistics and stronger regional connectivity. The projects were cleared by the Cabinet Committee on Economic Affairs (CCEA), chaired by PM Narendra Modi. Briefing reporters after the meeting, I&B Minister Ashwini

Vaishnav said the projects are aimed at easing congestion, improving logistics and accelerating regional economic growth. Delhi’s share of the package is a ‘6,969.67-crore project to build an 8.1-km six-lane tunnel on NH-148AE. It will connect the Shivmurti Interchange on the Dwarka Expressway (NH-248BB) with Nelson Mandela Marg in Vasant Kunj. The project will be implemented under the Hybrid Annuity Model (HAM). The tunnel is expected to provide seamless connectivity for commuters travelling from Gurugram, Dwarka, IGIA and west Delhi to south Delhi. It will also integrate with the proposed elevated AIIMS-Mahipalpur

corridor, creating a direct link to the Barapullah elevated road and improving access to east Delhi, Ghaziabad and Noida. To minimise the environmental



impact, the tunnel will pass beneath the ecologically sensitive Southern Ridge Forest using tunnel boring machines

(TBMs), avoiding large-scale surface disruption. The project includes a 3.14-km underground tunnel, approach ramps, elevated stretches and at-grade roads. It provides for a 1.8-km elevated road along Nelson Mandela Marg, a new flyover towards Mahipalpur and an elevated U-turn to decongest the busy Mahipalpur-Chhatrapur junction. It is estimated that the project will generate about 7.54 lakh man-days of direct employment and nearly 9.8 lakh man-days of indirect employment. The Cabinet also approved a Rs 7,145.14-crore project to build a 117.7-km four-lane access-controlled greenfield highway between Kanpur and Kabrai.

Sooryavanshi's wait for India debut will put him under more pressure: Gavaskar

New Delhi, (Agency)

Vaibhav Sooryavanshi's wait for his senior India debut continued on Wednesday after the 15-year-old was once again left out of the playing XI for the opening T20I against England in Chester-le-Street.

While the Indian team management has continued to back its World Cup-winning top order of Sanju Samson, Abhishek Sharma and Ishan Kishan, batting great Sunil Gavaskar believes delaying the teenager's debut will only increase the pressure on him when he eventually gets his chance. Sooryavanshi, who earned his maiden India call-up after a record-breaking IPL season, had also remained on the bench for both T20Is against Ireland. With anticipation around the youngster continuing to grow, Gavaskar said the longer the wait, the greater the expectations will be when he finally makes his India debut.

"It will put him (Sooryavanshi) under more pressure whenever he gets an opportunity," Gavaskar said on Sony Sports. "But at 15 years of age, you don't think too much about pressure. He knows that if he gets the opportunity in the second or third game, he will have to deliver almost immediately. That's there." The former India captain, however, believes



Sooryavanshi's age could work in his favour and said the teenager would be making the most of the opportunity to learn from some of the country's best players. "But he is happy to be around. This Indian team is full of lovely, tremendous players, and it is just fantastic for him to be learning from them," Gavaskar added. India's decision to persist with their established opening combination came despite their surprise T20I series defeat in Ireland. The management once again showed faith in the trio of Samson, Abhishek and Kishan, leaving Sooryavanshi to wait for another opportunity. The opening T20I against England, however, ended in frustration after rain forced the match to be abandoned without a ball being bowled in England's chase. India had recovered well from a disastrous start to post 189 for 7 after being reduced to 6 for 2 inside the opening two overs. Sanju Samson departed after Tom Banton pulled off a superb catch at backward point off Saqib Mahmood, while Ishan Kishan was run out following a mix-up with Abhishek Sharma.

DR Congo coach learns of father's death in press conference after England loss

New York, (Agency)

The Democratic Republic of the Congo's FIFA World Cup campaign ended on a deeply emotional note after head coach Sebastien Desabre was informed of his father's death during the team's post-match press conference following the 2-1 defeat to England on Wednesday. Desabre had just overseen DR Congo's exit from the tournament after Harry Kane scored twice in the closing stages to complete England's comeback and send Thomas Tuchel's side into the Round of 16. Moments later, as the French coach answered questions from reporters, the team's media



officer interrupted the press conference with a solemn announcement. Thank you, but we are announcing that the coach has lost his father. Our sincere condolences," the media officer said in French. Desabre appeared stunned by the news. After quietly responding, "Merçi," he left the press conference, which was immediately brought to an end. The incident, broadcast live, drew an outpouring of support from football fans and members of the football community. The tragic moment overshadowed what had been a landmark tournament for DR Congo. Playing at their first World Cup since 1974, the Leopards exceeded expectations by reaching the knockout stage for the first time in the nation's history. Under Desabre, they also scored their first World Cup goals and registered their maiden victory at the tournament, marking one of the standout stories of the 2026 edition. Their historic run ended after England recovered from a goal down in the Round of 32. DR Congo held a deserved 1-0 lead until the 75th minute before Harry Kane equalised. The England captain struck again in the 86th minute to seal a 2-1 victory and set up a Round of 16 meeting with Mexico. Despite the defeat, DR Congo earned widespread praise for pushing one of the tournament favourites to the limit.

England out to break South Africa curse with Nat Sciver-Brunt boost for semis

Women's T20 World Cup, ENG vs SA: England have lost their last two knockout matches against South Africa and will be eager to snap that streak when the two sides meet in the second semi-final at The Kennington Oval in London on Thursday.

New Delhi, (Agency)

England and South Africa will once again find themselves on familiar territory when they clash in the second semi-final of the Women's T20 World Cup at The Kennington Oval in London on Thursday, July 2. It is a rivalry England may not look back on fondly, having stumbled against the Proteas in recent knockout encounters. For the unbeaten hosts, the contest presents an opportunity to finally erase the scars of semi-final defeats to South Africa in the 2023 T20 World Cup and the 2025 ODI World Cup. The Proteas, however, have developed a reputation for thriving when the stakes are at their highest and will be eager to derail England's title ambitions once again.

With Australia already waiting in Sunday's final at Lord's, another high-stakes showdown promises to deliver plenty of drama. Charlotte Edwards' side head into the knockout clash unbeaten and brimming with confidence after topping Group B with five wins from as many matches. South Africa, meanwhile, recovered impressively from an inconsistent start to secure another semi-final berth and will be hoping to pull off yet another upset against the hosts.

SCIVER-BRUNT HANDED TIMELY FITNESS BOOST

England have received the perfect boost ahead of the knockout clash with captain Nat Sciver-Brunt declared fit after recovering from a calf injury. The all-rounder had retired hurt against Ireland before missing England's final two group matches, raising fears that she could miss the semi-final. However, Sciver-Brunt returned to full training earlier this week and confirmed she is available for selection. England's medical staff accelerated her rehabilitation with intensive recovery work, while the skipper said the team had "thrown everything" at ensuring she would be fit. Her return restores balance to England's XI, providing a world-class batter and a

valuable seam-bowling option.

England hardly looked weakened during her



absence, comfortably beating Scotland, West Indies and defending champions New Zealand under stand-in captain Charlie Dean. Yet Sciver-Brunt's presence adds invaluable experience and leadership as England chase their first Women's T20 World Cup title since 2009.

ENGLAND'S BATTING DEPTH MEETS SOUTH AFRICA'S FIGHTING SPIRIT

England have been the standout team of the Women's T20 World Cup, combining explosive batting with a disciplined bowling attack. Their totals of 164, 186 and a tournament-best 219 reflect the depth in the

line-up, with Danni Wyatt-Hodge leading from the front and Sophia Dunkley making the most of her opportunity during Nat Sciver-Brunt's absence. Heather Knight has added stability in the middle order, while Charlie Dean, Lauren Bell and Freya Kemp have impressed with the ball. England also underlined their credentials by crushing defending champions New Zealand by nine wickets to complete an unbeaten group-stage campaign.

South Africa, meanwhile, have once again demonstrated their ability to rise to the occasion. After recovering from a group-stage defeat to India, the Proteas enter the semi-finals with renewed confidence. Captain Laura Wolvaardt has anchored the batting, Tazmin Brits has provided brisk starts, while Marizanne Kapp remains the side's premier all-rounder. Chloe Tryon offers power and spin, with Sinalo Jafta contributing valuable lower-order runs. South Africa's bowling attack, featuring Ayabonga Khaka, Nonkululeko Mlaba and Nadine de Klerk, will need to strike early against England's formidable batting line-up if they are to repeat their memorable semi-final victory over the hosts in 2023.

10-man USA keep World Cup dream alive, send Bosnia packing to reach last 16

Malik Tillman spared the United States an anxious finish with a sublime late free-kick as the co-hosts defeated Bosnia and Herzegovina 2-0 on Wednesday to reach the World Cup Round of 16, despite playing the final stages with 10 men after Folarin Balogun's dismissal.

New Delhi, (Agency)

The United States kept their World Cup dream alive with a spirited 2-0 victory over Bosnia and Herzegovina on Wednesday, booking a place in the round of 16 despite playing the closing stages with 10 men. Folarin Balogun gave the co-hosts the lead before being sent off, but Malik Tillman put the result beyond doubt with a superb late free-kick as the Americans showed grit to see the game out. The victory sends the Americans into the Round of 16, where Belgium await in Seattle on July 6, and keeps alive hopes of matching or even bettering their memorable run to the quarter-finals in 2002.

USA vs Bosnia & Herzegovina, FIFA World Cup: HIGHLIGHTS

The United States earned their first World



Cup knockout victory since 2002, but it was far from straightforward after Balogun, who broke the deadlock just before half-time, was shown a straight red card in the 64th minute. Matt Freese made three saves to record his second clean sheet of the tournament as the home crowd roared the co-hosts over the line. Bosnia and Herzegovina were playing in the World Cup knockout stage for the first time and started brightly. Freese was forced into back-to-back saves from Ermedin Demirovic and Kerim

Alajbegovic after an early corner as the visitors threatened to take the lead. The Americans gradually settled into the contest and began to dominate possession. Christian Pulisic thought he had broken the deadlock in the 78th minute, but the effort was ruled out for offside. Before that, the hosts had finally made their pressure count in first-half stoppage time. A defensive mix-up saw the ball ricochet off Tarik Muharemovic into Balogun's path, and the striker reacted quickest, stopping, turning onto his left foot and calmly sliding the ball through the goalkeeper's legs for his third goal of the tournament.

Balogun almost doubled the advantage moments later when he crashed Sergio Dest's pass against the crossbar. The game turned in the 64th minute when Balogun was sent off following a challenge on Muharemovic. Referee Raphael Claus initially allowed play to continue but was called to the pitchside monitor, where he upgraded the decision to a straight red card after seeing Balogun's studs catch the defender high on the ankle.

Thomas Tuchel urges parents to let children stay up for England's clash with Mexico

New Delhi, (Agency)

England manager Thomas Tuchel has urged parents to let their children stay up to watch the Three Lions' blockbuster FIFA World Cup last-16 clash against Mexico, insisting the tournament is a rare occasion worth sacrificing a few hours of sleep.

England booked their place in the Round of 16 after Harry Kane struck twice in the final 15 minutes to inspire a dramatic 2-1 comeback win over DR Congo. They will now face tournament co-hosts Mexico at the iconic Azteca Stadium on Sunday, with kick-off scheduled for 1am BST on Monday. The late start presents a dilemma for families in England, with children facing school the following morning. Tuchel, however, had a simple message for parents.

"Let them watch football," he said after England's victory. There's so much school to go to, but the World Cup is every four years. There will be a big, big match on in four days. We need the support of everyone, and

especially of the children."

TUCHEL MISSED MEXICO'S WIN OVER ECUADOR



Ironically, Tuchel did not watch England's next opponents secure their place in the knockout stage. Mexico's 2-0 victory over Ecuador was delayed by an hour because of adverse weather around Mexico City, prompting the England manager to stick to his unusually early World Cup routine.

"I was happy to watch the first half and then it

wasn't on, and I slept at 10 o'clock," Tuchel said. Very unusual for me, but I have somehow a crazy early bedtime during this World Cup and I didn't see it. I saw the result, of course, and I saw that they didn't concede, and it will be a tough one."

England's coaching staff have since begun analysing Mexico ahead of what promises to be one of the biggest ties of the tournament.

PROUD OF ENGLAND'S FIGHTING SPIRIT

Tuchel was particularly pleased with the way England responded after falling behind against DR Congo, with Kane scoring in the 75th and 86th minutes to complete the turnaround. "Things stayed difficult but this team today did not accept a defeat as an outcome," Tuchel said. "They just didn't accept it, and that makes me very proud because they did what was necessary." The going got tough, and they showed up, and we got a deserved win, even if it was a late one.

Balogun did not deserve a red card: USA coach questions referee's decision

United States coach Mauricio Pochettino launched a passionate defence of Folarin Balogun after the striker's controversial sending-off in the 2-0 World Cup round-of-32 victory over Bosnia and Herzegovina on Wednesday.

United States coach Mauricio Pochettino strongly defended Folarin Balogun after the striker's controversial sending-off in the 2-0 win over Bosnia and Herzegovina, insisting the forward "never" deserved a red card despite the hosts booking their place in the World Cup last 16 on Wednesday. The victory secured the United States' first World Cup knockout win since 2002 and set up a last-16 clash against Belgium, but celebrations were tempered by the dismissal of Balogun, who

will miss the tie after receiving an automatic one-match suspension. Balogun had fired the Americans ahead just before half-time with his third goal of the tournament before being shown a straight red card in the 64th minute.

The striker was initially booked after his foot landed on the ankle of Bosnia defender Tarik Muharemovic while challenging for the ball, but the decision was upgraded to a dismissal following a VAR review. Pochettino was left furious, arguing the incident was accidental and should never have warranted a red card. "For me, it was never a red card," the Argentine said after the match. "There was never any intention to step on the player. It was a normal action in football when you are fighting for the ball. Maybe in slow motion it looks worse, but it was never intentional."

Bosnia coach Sergej Barbarez backed the referee's decision, but Pochettino remained unconvinced. "He is very disappointed because it was an unintentional action,"

Pochettino said of Balogun. But he's also happy because we qualified. These things happen in football. I hope we go through to the next round because then he will be available to help us again. Christian Pulisic also came to his



teammate's defence, saying Balogun "didn't deserve the red card" and describing the decision as "unfortunate". USA DIG DEEP TO REACH LAST 16

The sending-off could have derailed the hosts, but they responded with one of their most disciplined displays of the tournament to shut out Bosnia and seal a memorable victory.

Malik Tillman put the result beyond doubt with a superb free-kick after Balogun's dismissal, capping another influential display from the midfielder. It was amazing," Pochettino said of Tillman. "Malik is an amazing player, full of talent. We knew he had the quality to score from that free-kick. I'm so happy for him." Pochettino reserved his biggest praise for his team's resilience, saying their composure reflected the progress they had made over the course of the tournament.

"It's difficult to describe our feeling because the players were amazing," he said.

"There are no easy games at the World Cup. The maturity of this team and the way we have grown over the last five or six weeks has been incredible."

Lamborghini Urus SE Performante revealed: 812 HP, 1,000 Nm and 0-100 kmph in 3.3 seconds

Lamborghini has brought back the high-performance version of the Urus with the new Urus SE Performante. The original non-hybrid Performante was discontinued in 2024, and this new version picks up where it left off, but with significantly more firepower. It's currently the most powerful SUV Lamborghini makes, and it gets meaningful upgrades over the standard Urus SE.

Power and performance

The Urus SE Performante uses the same 4.0-litre twin-turbo V8 from the standard SE, paired with an electric motor. It gets an 8-speed automatic transmission, which sends power to all four wheels (AWD). The 25.9 kWh lithium-ion battery sits under the rear cargo floor. Combined output comes in at 812 hp and 1,000 Nm of torque, up 12 hp and 50 Nm over the standard SE, and a massive 146 hp and 150 Nm more than the old non-hybrid Performante. Lamborghini claims a 0 to 100 kmph time of 3.3 seconds and 0 to 200 kmph in 10.8 seconds, both 0.1 seconds and 0.4 seconds quicker than the standard model respectively. Top speed remains electronically limited to 312 kmph, the same as the regular SE. Despite all the extra power, the Urus SE Performante still offers 60 km of all-electric range. Lamborghini has also recalibrated the transmission and updated the engine management software to reduce response times and cut down on torque lag. A new Rally driving mode has been added, specifically tuned for loose surfaces. This joins the existing Strada, Sport, Corsa, and EV modes.

Wheels and tyres

The Performante rides on 22 or 23-inch alloy wheels fitted with Pirelli P Zero tyres as standard. Buyers can also opt for Pirelli Scorpion Winter 2 snow tyres or Bridgestone Potenza Race semi-slick tyres for track use, both available as accessories.

Capgemini temporarily closes Bengaluru daycare after alleged child abuse

MUMBAI.(Agency)

Capgemini has announced temporary closure of its on-campus daycare facility in Bengaluru after allegations of child abuse at the centre surfaced, the company said in a statement. The company further added that it is cooperating fully with the relevant authorities and assisting them in their efforts to establish the facts.

"As a precautionary measure, we are temporarily closing the Bengaluru on-campus daycare facility," the statement said. Moreover, reports claim that an FIR has been registered against five women caregivers under relevant provisions of the Juvenile Justice (Care and Protection of Children) Act. The daycare facility is located at the IT company's HAL campus in Brookfield, Bengaluru. Police said the alleged incidents came to light after videos purportedly showing abuse inside the childcare centre circulated on WhatsApp. According to the FIR, which was registered on June 29 at the HAL police station based on a complaint filed by a district child protection unit official, five caregivers have been named in the case. The complaint alleged that the caregivers physically mistreated and threatened toddlers when they cried. The children involved are believed to be between two and three years old. The FIR further alleged that some children were sprayed with water in their mouths using a toilet jet spray, locked inside bathrooms, made to sit on western-style toilets and placed inside a front-loading washing machine. Meanwhile, police are investigating the allegations. Earlier in January, Capgemini announced to cut up to 2,400 jobs in France, representing about 6 per cent of its workforce in the country as the IT services company grapples with weak demand in key sectors in its home market, according to a report.

Sensex, Nifty trade higher as falling crude, strong auto sales lift sentiment

MUMBAI.(Agency)

The rupee fell 19 paise to 94.75 against the American currency in early trade on Wednesday, weighed down by the strength of the American currency in the overseas market. Forex traders said whenever fresh foreign inflows enter the country, the central bank is likely to use the opportunity to rebuild its reserve position rather than allowing the rupee to strengthen too much. Moreover, unSectorally, IT emerged as top gainer, with Nifty IT index jumping over 3 per cent, followed by Nifty MidSmall IT & Telecom, Nifty Consumer Durables, Nifty Metal and Nifty Realty. Nifty PSU Bank and Nifty Media edged lower. Meanwhile, NTPC, Power Grid Corporation, Bajaj Finance, ONGC and Bharti Airtel were among the top Nifty losers, falling up to 1 per cent. According to market experts, several factors are supporting the market in the near term. They said the sharp decline in crude oil prices is strengthening India's macroeconomic fundamentals by supporting growth while keeping inflation in check. They also pointed to robust June auto sales -- particularly a 24.1 per cent rise in passenger vehicle sales -- as a sign that domestic demand remains resilient. Experts added that banking stocks and digital platform companies are likely to remain strong on expectations of healthy first-quarter earnings. However, they cautioned that the sustainability of the market's outperformance will depend largely on the progress of the monsoon, which has remained below expectations. International oil benchmark Brent crude declined more than 1 per cent to \$70.65 per barrel. Similarly, US West Texas Intermediate (WTI) crude slipped 1.47 per cent to remain below \$68. Asian markets showed a mixed trend. Japan's Nikkei traded over 1 per cent lower, while South Korea's KOSPI fell more than 4 per cent. In contrast, Hong Kong's Hang Seng jumped 1 per cent.

EPFO new rules: PF contribution capped at Rs 1,800; what it means for you

If you're a salaried employee, there's an important update you should know about. The Centre has notified the new Employees' Provident Fund (EPF) Scheme, 2026, replacing the EPF Scheme, 1952. While your PF contribution rate has not changed, the new scheme clearly explains

how much contribution is compulsory and what happens if you want to contribute more. The updated rules are expected to make the EPF system simpler, more digital and easier to use for nearly 8 crore active EPFO subscribers. The new scheme came into effect on June 29 after it was published in the Gazette, replacing the long-standing EPF Scheme, 1952.

WHAT HAS CHANGED FOR PF CONTRIBUTIONS?

One of the biggest changes is that the new scheme clearly states that the mandatory employee contribution applies only up to the statutory wage ceiling, which is currently Rs 15,000 a month. This means the compulsory EPF contribution remains 12% of Rs 15,000, which works out to Rs 1,800 a month. Employers will continue to make a matching contribution as required under the law. Earlier, many employees contributed on higher salaries based on company policies or mutual agreements.

The new rules now clearly distinguish between mandatory and voluntary contributions. However, if you wish to



contribute more towards your retirement savings, you can still do so. However, any amount above the mandatory Rs 1,800 will now be treated as a voluntary contribution. Importantly, employers are not required to match these additional voluntary contributions unless they have agreed to do so under an employment contract or company policy.

CONTRIBUTION RATES REMAIN

THE SAME

The new scheme does not change the existing EPF contribution rates. Employees and employers will continue to contribute 12% of wages each. However, establishments that are already eligible for the reduced 10% contribution rate under existing government notifications will continue to follow that lower rate.

WITHDRAWAL RULES HAVE ALSO BEEN SIMPLIFIED

The EPF Scheme, 2026, also brings changes to partial withdrawals. These changes had already been approved by the EPFO's Central Board of Trustees last year and are now part of the new scheme.

Instead of several different categories, withdrawal rules have been simplified into three broad groups. Members can withdraw funds for essential needs such as illness, education and marriage, for housing-related purposes, and for certain special circumstances, subject to the prescribed conditions and minimum balance requirements.

Mehli Mistry steps down from Ratan Tata's family office

Mistry's resignation from RNT Associates comes months after he was removed from Tata Trusts in November 2025.

New Delhi.(Agency)

Mehli Mistry, one of the late Ratan Tata's closest associates, has resigned from the board of RNT Associates Pvt Ltd, the family office that managed Ratan Tata's personal investments. His resignation comes a little over three years after he joined the board and follows his exit from Tata Trusts last year.

According to reports, Mistry submitted his resignation on June 30 and stepped down as a director from July 1. He reportedly said he was leaving due to "preoccupation with my other commitments". Mistry's resignation from RNT Associates comes months after he was removed from Tata Trusts in

November 2025. Tata Trusts are the charitable organisations that own Tata Sons, the holding company of the Tata Group. His latest decision marks another step away from the Tata Group and organisations linked to it. However, Mistry continues to serve as a



board member of Tata Education and Development Trust, one of the largest affiliates of Tata Trusts. Following Mistry's exit, RNT Associates has four directors on its board. They are Ratan Tata's sisters, Shireen Jejeebhoy and Deanna Jejeebhoy, along with Jamsheed

Poncha, a senior executive at Tata Sons, and Tata Sons General Counsel Sidharth Sharma.

What is RNT Associates?

RNT Associates was set up in 2009 as the main investment office for Ratan Tata's personal investments. Through this platform, the veteran industrialist invested in several promising startups across different sectors. Unable to withdraw PF or file claims? EPFO services unavailable for 7 days

NEW DELHI.(Agency)

The Employees' Provident Fund Organisation (EPFO) has temporarily suspended several online services to carry out a planned database consolidation and software upgrade aimed at improving the speed, reliability and security of its claims processing system. According to an official notice displayed on website, the migration exercise is "to enhance service delivery, improve processing efficiency, and provide a better user experience."

"As part of the upgrade, EPFO is consolidating its database and upgrading software applications used for claims processing.

The outage began at 12 am on June 26 and was said to continue until 11:59 pm on July 1, with services expected to be restored from 12 am on July 2. However, the website still shows the "Scheduled System Migration & Temporary Service Unavailability" message on Thursday

morning. Few people complained on social media about the issue asking for updates. "The scheduled downtime has already passed, but the EPFO portal remains inaccessible.

Thousands of users are affected. Please communicate the reason for the delay and when services will be restored," said one X user. During this 'down time', members and employers cannot log in to the Member Interface or Employer Interface, making all online services through these portals unavailable. This includes submission of new EPF claims, claim processing, e-passbook access, Electronic Challan-cum-Return (ECR) filing, UAN linking for new employees and other digital services. Claims submitted before the migration window will be processed after services resume.

Centre notifies new EPF Scheme, 2026 with digital-first reforms. While, the outage continues separately, the Centre has notified the Employees' Provident

Fund (EPF) Scheme, 2026, replacing the 1952 framework with immediate effect. The new scheme retains the mandatory 12 per cent contribution by both employers and employees while introducing a more digital and compliance-focused framework to support the implementation of the labour codes.

Among the key changes are simplified rules for partial withdrawals for illness, education, marriage and housing, mandatory submission of Aadhaar, PAN and Aadhaar-linked bank account details for digital processing, and enhanced compliance requirements for employers, including electronic filings and ownership disclosures. The scheme also introduces three initiatives—Employees' Enrolment Campaign 2026, VISHWAS 2026 and AMNESTY 2026—to help regularise past compliance gaps and resolve legacy issues.

Ship breaking: India targets recycling 16,000 vessels in 10 years with \$8-bn commitment

India's shares in the ship recycling industry rose from 30.1% in 2024 to 35.4% in 2025, which indicates that more and more vessels are being sent to India for dismantling. The country recycled 2.99 million gross tons of ships in 2025, marking almost 60% surge compared to 1.86 million tons recycled in 2024.

Kolkata.(Agency)

India is breaking more ships than ever before and the ships recycling industry is poised for a jump in the next few years, Union shipping minister Sarbananda Sonowal has said. The target is to recycle about 16,000 ships in the next 10 years and the government has announced a commitment of \$8 billion to support the growth of the shipbuilding and ship recycling sectors, according to the minister. The announcement came against the backdrop of India and the European Union



reaffirming their commitment to strengthening cooperation in sustainable ship recycling. Work is progressing on the inclusion of India under the European Union Ship Recycling Regulation. During the discussions that featured Sonowal and Jessika Roswall, the European Commissioner for Environment, Water Resilience and a Competitive Circular Economy, the two parties reviewed the audit and compliance process for Indian ship recycling yards.

Joint working group to be set up

The European Commissioner proposed establishing a joint working group with representatives from the Ministry of Environment and other relevant ministries and organisations with the objective of facilitating coordination and support the next phase of the process. A statement after the meeting flagged the importance of surprise inspections in order to maintain rigorous standards of compliance, transparency and accountability. Roswall also said that the issue will be discussed with EU states before any final decision is

taken. Roswall also wanted to visit Indian ship recycling facilities after the consultation and assessment process goes through.

Rising share of India

Estimates by UNCTAD (UN Conference on Trade & Development) show that India's share in global ship recycling went up from 30.1% in 2024 to 35.4% in 2025. About 2.99 million gross tonnes of ships were dismantled in 2025, which marked a 60% growth over 1.86 million GT recycled in 2024. Sonowal said that the Centre is catalysing the process of listing of Indian ship recycling yards through a process of audits, inspections and regulatory compliance.

The minister said that the Indian ship recycling facilities are assisted by environmental infrastructure and worker welfare measures, including effluent treatment plants, scientific waste management systems, multi-specialty healthcare facilities. The process is important since there are concerns about the health and environment in the ship recycling or ship breaking industry.

Parents can benefit by looking at themselves as coaches who build life skills. In an extract from her book, a family therapist and psychologist prescribes a gentler approach. We measure our worth according to how well the children fit into those dreams. If they fall short, we feel cheated, angry, depressed and wonder 'Why me?' We feel inadequate and, in our anxiety, react by cranking up our resentment towards our children. We become judgemental, critical and comparative. And, therefore, get stuck in a spiral of negativity. Before we know it, unhealthy patterns of a lifetime get carved out. A long time back I came across this book titled, Stop Parenting, Start Coaching and I really loved the title. It resonated so deeply with my belief that our role as parents is to help our children build life skills. Here are seven steps to highly effective coaching.

CLEAR GOAL

'What is the one skill I want to nurture in my child which will help her become a more healthy, responsible, independent and happy human being?' Depending on the age of the child, it could range from eating well, sleeping on her own, staying fit, doing less screen, being more organised, managing time better, being financially savvy, getting better grades, being more communicative, articulate, confident, happy, sociable, respectful, emotionally balanced, focused and so on and so forth. We would all like that in our children. It makes our work easier as parents and feels good to boot. However, just start with one or two skills. Make it very specific. Rather than making good habits a goal as it is too vague, be more specific and narrow it down to one or, maybe, two activities. For example, clear up the bathroom after using it or go and play in the park every day. Rate it on a scale of 0 to 10 where 5 is in the middle

'Where is my child right now in that skill?'
'Where does he need to be?'
'What is the one step he needs to take that will help him move one point up in that scale?'
'What would I need to do to help him move one step further?'

These are extremely important questions as they help you clarify the goal and establish the next step forward, for you and for your child. For example, you want your child to get better grades. You might identify that on the scale he is at 3 where the goal is 8. I would always suggest that you stay away from making 10 as a goal as it will then make you seek perfection (which I think is a huge problem) and establish extremely high expectations (for a child who is at 3 right now). The next step that you might think would work in helping him move to 4 would be to make him sit down and study for an extra half hour every day. You might want to keep yourself free around that time so that you could provide him some level of 'scaffolding' till he is ready to sit and work on his own.

ASK INSTEAD OF TELLING

We are constantly telling children what they need to do and not ask them as much as is required what they would want to do. So, you could sit down with your child and ask, 'Are you happy with your grades right now? Do you think you are putting in enough time? How can I help you in this?' Make sure you ask without sounding sarcastic or angry.

DRAW UP A PLAN

For any change to happen you would have to get down and draw up a clear plan. So you might want to first make sure that your connect with your child is solid and strong. Then you might want to sit with him and ask him a few questions regarding how he feels about his grades. Initially, he might show a bit of his rebellious child (I hate studying, it is so boring); listen to him, empathise with it (I

know it can be a drag sometimes. I remember feeling like that), but bring him back to the issue (I can understand you find it boring but we still need to do it). After being listened to and understanding your point of view, he might agree that he needs to work on his grades too. That's when you need to gently work out a plan of action. Make sure you don't make it too overwhelming and remember he is at 3 and we just want him to move up to 4 and not 8. Work out when he could take out that hour for studying, where he would like to study, with whom, how, etc.

RHYTHMS AND ROUTINES

When we lived in England, I heard a very experienced nanny say once, 'There is nothing like a bad child, there are just bad routines!' It sounds a bit drastic but there is a lot of truth in that statement. I do believe that if children follow a clear routine then you have already won half the battle. Routines give a rhythm and flow to the day. If a child knows that after school she can relax for an hour followed by homework time at 4 p.m., playtime from 5 to 7 p.m. and then bath, dinner, reading in bed and

lights off at 9 p.m., then chances of her following it every day without much protest are higher. However, if there is no clear routine and the homework can be done anytime she chooses or dinner time changes every day, then she might push things around as she deems fit and everything might turn into a battle ground. It could vary during the holidays when you make it more flexible with timings that can be stretched a little like 'get ready and finish breakfast by 10 a.m.' or 'finish homework before going to the park in the evening'. Teenagers can be given a choice in making their own time schedule with some basic expectations outlined by you. I would also like to point out that it is most important that as parents we also need to follow a routine before we start advocating it to our children. Do remember that children have very sensitive hypocrisy radars.

RECOGNITIONS

Recognitions are a very powerful tool in parenting. They are about acknowledging and celebrating the child in front of you. It is about building in the child a sense of



and 'careful with her things'. We have to water the wholesome seeds rather than just the negativity seeds of lack, deficit and what's wrong.

EXTERNALISATION

However, you might want to address the 'problem' sometimes, but how can you do that without the child feeling attacked. In Narrative Therapy, we use an approach pioneered by the late Michael White called Externalisation. Through this approach, we place the problem outside the child rather than within him and give it a name. So, for example, if the child is struggling with anger we might call the problem Anger and talk to the child as if the Anger was separate from him. So the questions statements might go as, 'Did you see how Anger was controlling you yesterday?' (It is best to do this when the child is calm and more receptive.) I think Anger is really troubling you nowadays in the evening.' 'Can you make out when Anger is coming close?' It might seem a little bizarre but children take to this slight change in language and approach very well. Personifying feelings, difficulties, imaginations and fantasies come very easily to them.

Do remember you have to be consistent in this approach otherwise you might end up confusing the child. If you feel unsure about it or after trying it you feel it does not work, just drop it.
