Developed as a joint venture between Hindustan Petroleum Corporation Limited (HPCL) and the Rajasthan government, the 9 Million Metric Tonnes Per Annum (MMTPA) Greenfield Refinery-cum-Petrochemical Complex has been established with an investment of over Rs 79,450 crore. "A lot of rumours were spread and people were instigated and political games were played, but those whose intentions were wrong did not succeed," the PM said on the energy crisis.

80% work on bullet train project done, will meet rollout deadline: Vaishnaw

Bullet trains on the corridor have been engineered for speeds up to 350 km per hour, while the operational speed is expected to be 320 kmph.

New Delhi .(Agency) Railway Minister Ashwini Vaishnaw said on Saturday that nearly 80% of works for the Mumbai-Ahmedabad bullet train project, India's first high-speed rail corridor, has been completed. "Construction is progressing at a rapid pace. The first phase of the service, connecting Surat and Billimora, will become operational in 2027," Vaishnaw said. He added that the project would subsequently be extended in phases to Vapi, Ahmedabad and finally Mumbai, bringing India closer to realisation of a world-class rail network. Bullet trains on the corridor have been engineered for speeds up to 350 km per hour, while the operational speed is expected to be 320 kmph. Once fully operational, the 508-kilometre corridor will reduce the journey time between Mumbai and Ahmedabad, two key economic centres, to approximately 1 hour and 58 minutes. The project spans 348 kilometres in Gujarat, 156 km in Maharashtra and 4 km in the Union Territory of Dadra and Nagar Haveli. Being developed with Japanese Shinkansen technology and operational practices, the corridor incorporates some of the most advanced systems in traction electrification, track infrastructure and railway operations.



'No competition': Uttarakhand CM Dhami credits all his predecessors, including ND Tiwari, for State's progress

DEHRADUN.(Agency) Uttarakhand Chief Minister Pushkar Singh Dhami on Saturday said he sees 'no competition' with former chief ministers of the state, including ND Tiwari, and credited all his predecessors for guiding him. Addressing a gathering during a programme in Rishikesh, Dhami said, "Every former CM of Uttarakhand was more experienced than him when they took office." "All the former CMs were senior to me in experience and age, and I have learnt a lot from them," Dhami said. "There is no question of any competition," he said. The remarks came amid talk in political circles that Dhami is set to surpass the tenure record of veteran Congress leader ND Tiwari, who served as Uttarakhand CM for the longest period so far. Dhami, however, downplayed the comparisons. "A few people are saying that I am going to break former CM ND Tiwari's record. But I have learnt a lot from ND Tiwari ji," he said. "When ND Tiwari became chief minister of Uttarakhand, he had the experience of his entire life behind him. But when I became CM, I was a novice. So there is no question of competition." Dhami acknowledged all former CMs of the state, saying, "From Nityanand Swami to all who followed, each contributed to Uttarakhand's progress. I have learnt a lot from them." The chief minister's comments reflect an attempt to strike a conciliatory tone at a time when the BJP government is marking five years of his leadership.

Jolted by defections, DMK, AIADMK, BJP air their woes to Tamil Nadu Governor

Tamil Nadu.(Agency) The opposition DMK, AIADMK and BJP on Saturday separately met Tamil Nadu Governor Rajendra Vishwanath Arlekar, urging him to intervene over allegations of horse-trading, misuse of state machinery and the participation of unauthorised individuals in cabinet meetings under the TVK government. A DMK delegation led by organisational secretary RS Bharathi called on the Governor and submitted a memorandum alleging attempts to poach legislators, misuse of police machinery and undue influence exercised by private individuals in the functioning of the



government. According to a statement issued by the Governor, the DMK's memorandum raised concerns over the alleged illegal arrest, custodial coercion and attempts to induce

electorates to defect through the misuse of police machinery. The party also alleged that inducements were offered to MLAs to switch sides and questioned the participation of unauthorised individuals in official government proceedings. The memorandum urged immediate constitutional intervention, an independent enquiry, and appropriate action to safeguard democratic institutions. Governor Arlekar said in a post on X.Speaking after the meeting, Bharathi reiterated the party's allegations and claimed that two individuals, John and Vishnu Reddy, wielded influence far beyond their official standing.

Army seals escape routes as hunt for two LeT terrorists continues

New Delhi.(Agency) A major counter-terrorism operation against two suspected Lashkar-e-Taiba (LeT) terrorists entered its second day in Jammu and Kashmir's Shopian district on Sunday, with security forces tightening the cordon around a dense orchard to prevent the militants from escaping. The operation began on Friday after surveillance cameras spotted the two suspected terrorists in an orchard in the Meemandar area, which comprises seven villages. Cordon-and-search operation underway A joint team of the Army, Jammu and Kashmir Police



and the Central Reserve Police Force (CRPF) launched a cordon-and-search operation, clearing four villages by Friday evening. Officials said the search resumed on Sunday after an overnight pause. The two trapped terrorists, identified as Latif and Zakir, allegedly opened fire on security personnel as troops closed in, triggering a gunfight. Security forces retaliated, and additional personnel from the Army's Victor Force have since been deployed to seal all possible escape routes through the thick foliage, officials said. According to security records, both men are residents of Kulgam district in south Kashmir. Zakir is believed to have joined the Pakistan-backed Lashkar-e-Taiba in 2024, while Latif reportedly became a member in 2025.

the Akal Takht's recent declaration branding Mann as "Guru Dokhi" (one who has insulted the Guru) and "Khalsa Panth Virodhi" (opposed to the Khalsa Panth). The devotees were part of the Punjab government's pilgrimage scheme, under which senior citizens are taken to various

religious destinations. The identity cards issued under the scheme prominently feature the photograph of the chief minister. The SGPC has called a Panthic congregation on Sunday to discuss the fallout of the viral video in which Mann was seen inside the Golden Temple complex during the inauguration of the SGPC's newly established viewing gallery. The video triggered a major controversy after it showed Mann speaking while seated in an area traditionally reserved for Sikh religious discourse, drawing sharp objections from Sikh bodies and religious leaders. The Akal Takht took serious note of the incident and issued a directive declaring Mann "Guru Dokhi" and "Khalsa Panth Virodhi." It also asked the Punjab government to amend the relevant.

One month in, CM Shivakumar's government faces cabinet expansion test

Karnataka (Agency) Earlier this week, Chief Minister DK Shivakumar's government completed one month in office. Although it is a short period to judge a government's performance, the change of guard seems to have brought fresh energy to the administration, which looked jaded, especially in the last few months of Siddaramaiah's tenure. After recovering from the initial shock of the portfolio allocation, with two senior ministers sulking, the CM has managed to keep the spotlight on his government rather than on the political uncertainty in his party. Unlike his predecessor, the CM has avoided open confrontation with the Union government, and has so far refrained from joining his party leaders in the state in aggressively criticising the Rashtriya Swayamsevak Sangh (RSS). However, it is just the beginning, and the Congress government has a long way to go. Maintaining the same tempo and cohesiveness in the government is a Herculean task, especially after the expansion of the cabinet. The government presently functions with just 13 ministers out of a 34-member-capacity cabinet. Of these, only two are new faces, and the rest were part of the previous cabinet. If the Congress leadership decides to give a majority of the remaining berths to new faces, the seniors hoping to return to the cabinet would be aggrieved. However, if most seniors are accommodated again, it would leave new aspirants disappointed. Either way, it's a tricky situation. Congress will be counting on the new government's performance for the 2028 polls, but how those left out respond will also be crucial. It would be interesting to see how the party strikes a balance between the loyalists of Shivakumar, Siddaramaiah, and AICC president Mallikarjun Kharge in the cabinet expansion.

Traitors, join BJP and fight me: Mamata Banerjee's blistering attack on rebels

Kolkata.(Agency) Mamata Banerjee on Saturday launched a sharp attack on the rebel faction that has split the Trinamool Congress, accusing the dissidents of working with the BJP to engineer a break in the party and daring them to join the BJP openly if they had the courage. In a Facebook Live address, her first since the TMC entered its biggest crisis, Banerjee defended her leadership, attacked the rebels, vowed to go ahead with the party's July 21 Martyrs' Day rally despite what she called administrative hurdles, and said that while individuals may leave, "an institution does not cease to exist". Her remarks came on a day she lost another long-time associate, Chandrima Bhattacharya, who resigned as the TMC's West Bengal president and from other party posts. Responding to Banerjee's

allegations, the BJP said TMC leaders were leaving because the 'cut-money culture', which it claimed had held the party together, had ended after the saffron party came to power. "I dare the treacherous and ungrateful traitors who are abandoning the party to directly join the BJP and take me on if they have the courage to do so, instead of playing this dishonest BJP-sponsored game," Banerjee said. Attacking the dissenters, she added, "You call yourself rebels? Where was your rebellion before the elections? Where was your dissent during the last 15 years when you were MPs and MLAs on TMC tickets and operated as ministers and in other important government positions? Why didn't you come to me then and voice your differences."

'LOYALS ARE PARTY'S GOLDMINE' Calling workers who remain loyal in 'these difficult times' the 'party's goldmine', Banerjee told the rebels, who 'have betrayed and quit the party with their luggage and baggage', to ensure that they did not commit 'the same treachery with the people who voted for them'. On Bhattacharya's exit, she struck an

unconcerned note, saying, "Chandrima had been saying for some time now that she wants to resign. Her son had already joined hands with them (the rebels). It doesn't matter to me if a few leaders here and there desert the party and join hands with the BJP." Banerjee said that, along with her responsibilities as the party's chairperson, she would also function as the TMC's Bengal president until veteran leader Subrata Bakshi, who is indisposed, recovers. She also announced the induction of party leaders Kunal Ghosh and Madan Mitra as general secretaries. 'REBELS BETRAYED US' Referring to the Ritabrata Banerjee-led rebel faction moving the Election Commission and staking claim to the party's twin flower symbol, Banerjee said people in Bengal would see through.

## Dumper on wrong side rams SUV, law student injured

Gurgaon.(Agency)

A 21-year-old law student was injured after an overloaded dumper, allegedly speeding on the wrong side of the road, crashed into his SUV near Mount Carmel School in Sector 114 on Friday.

Krish Goenka, a resident of Dwarka, was driving his Ford EcoSport from Bajghera towards his father's office in the city around 10.30am when the truck ramed into the right side of his vehicle.

Goenka alleged that the dumper was being driven at a speed of around 70 km per hour and in a rash and negligent manner. "I was driving at 40-50 km per hour when a dumper truck hit my car," he told TOI. "The impact has caused extensive damage to my car and endangered my life."

He claimed in his complaint that the dumper lacked rear taillights and displayed a registration number plate that was not clear and readable. He

also alleged that it was seemingly being driven under the influence of intoxicants.

After the collision, Goenka said he attempted to stop the driver, but the driver fled the scene, leaving the truck behind. Goenka's father took him to a hospital in Dwarka Sector-12, New Delhi, where his medico-legal case examination was conducted. He wrote in his complaint that the impact of the accident led to chest pain, breathing difficulty and other physical injuries.

Police said that an emergency response vehicle informed Bajghera police station about the crash. Head constable Ankit and his team arranged a crane to remove the damaged EcoSport.

## Two wanted Lawrence Bishnoi gang members injured in police encounter in Haryana

Gurgaon.(Agency)

Two alleged members of the Lawrence Bishnoi gang, each carrying a reward of Rs 1 lakh, and a police officer were injured during an exchange of fire in Haryana's Bahadurgarh on Sunday following a joint operation by the Haryana Police and the Delhi Police. The operation was carried out jointly by the STF Bahadurgarh unit of the Haryana Police and the Counter Intelligence wing of the Delhi Police's Special Cell, based on specific intelligence inputs.

The accused were identified as Pravesh, son of Jai Prakash and a resident of Tibba Danasher in Hisar, and Himanshu, son of Sushil Kumar and a resident of Jakhod Khera village in Hisar district.

Police said both men were wanted in connection with FIR No. 379, dated June 11, 2026, registered at the City Hansi police station under Sections 103(1) (murder), 109(1) (attempt to murder), 3(5) (act done by multiple persons) and 61(2)(A) of the Bharatiya Nyaya Sanhita (BNS), along with Sections 25, 54 and 59 of the Arms Act, in connection with the broad daylight murder of gym operator Kapil in Hansi. According to police, both accused carried a cash reward of ₹1 lakh each and were associated with the Lawrence Bishnoi gang.

Police said they had received specific intelligence that the armed accused had reached the Bahadurgarh area with the intention of committing a crime.

During the operation, the accused allegedly opened fire, prompting the police team to retaliate in self-defence. In the ensuing exchange of fire, both accused and one police officer sustained injuries. All three were shifted to a hospital for treatment. Further investigation is underway.

## Helper buried alive as truck driver unloads sand and gravel

Gurgaon.(Agency)

A truck helper died after he got buried under sand and gravel when the truck's driver offloaded the material without realising the victim was standing behind it. The incident happened in Sector 113 early on Friday.

According to a complaint filed by the victim's father, Priyanshu was helping with transportation of sand and gravel at a stockyard in Sector 113. After reaching there around 1 am, the driver asked Priyanshu to get off the vehicle and open the truck's rear gate for unloading.

As the helper opened the rear gate, a heap of sand and gravel first trapped his legs. His father said he screamed for help, but the driver did not hear him and continued lifting the truck body hydraulically, unloading the entire consignment. Soon, Priyanshu was completely buried beneath sand and gravel. The truck driver was on the run at the time of filing this report. Police said the first information about the incident reached Bajghera police station through an Emergency Response Vehicle (ERV) call on July 3, informing them that a boy was buried under gravel at a stockyard in Sector 113.

By the time police reached the spot, an ERV team was already there and had pulled him out from beneath the gravel and taken him to Manipal Hospital in Palam Vihar. He was totally unconscious at this point.

Police said, when asked about his age at the hospital, the truck's owner said Priyanshu was 20 years old. However, the complaint submitted by his father said the victim was 16 years old. The hospital said the victim succumbed to his injuries sustained in what was described in the medical records as a road traffic accident.

Proceedings under Section 194 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) were initiated. The post-mortem examination was scheduled subsequently. Police are investigating the circumstances that led to the accident and the role of the driver in what happened. Based on a complaint filed by the victim's father, Durga Prasad Maurya, Bajghera police registered a case under Section 106 (causing death by negligence) of the Bharatiya Nyaya Sanhita (BNS) on Friday.

## Foreigner among 3 held with MDMA worth Rs 14 lakh in Greater Noida

Noida.(Agency)

Three persons, including a Nigerian man, were arrested from the service road near Janata Flats in Sector Chi-IV, Greater Noida, for allegedly running an MDMA racket on Saturday. Police said they seized 143 g of MDMA, commonly known as ecstasy. It has an estimated international market value of around Rs 14 lakh.

Besides the narcotics, officers seized a scooter allegedly used for transportation, an electronic weighing machine and Rs 17,500 in cash believed to be linked to the illegal trade.

The cops were acting on a tip-off and they arrested Arun Kasana of Ghaziabad; Atul Singh, a resident of Sampoonam Society in Greater Noida; and Chidubem Stanley, a Nigerian national residing in Uttam Nagar.

Greater Noida DCP Ravi Shankar Nim said an initial investigation has suggested



that the men procured the drug at comparatively lower prices and repackaged it into smaller sachets before selling it at higher rates in residential societies across Noida, Greater Noida and other parts of Delhi-NCR. The profits were allegedly shared among the members of the network.

Investigators suspect the gang deliberately targeted residential neighbourhoods and highrise societies, where synthetic party drugs are believed to have a steady demand. Police are now examining whether the accused supplied narcotics to local peddlers or directly to consumers.

Police also found that Chidubem Stanley had been previously arrested by the Delhi Police Crime Branch in 2025 under the Narcotic Drugs and Psychotropic Substances Act. Officers said he was out on bail and had allegedly resumed drug trafficking activities.

A case was registered against the three accused at Beta-II police station under relevant provisions of the NDPS Act. The Nigerian national was also booked under Section 14 of the Foreigners Act for alleged violations related to his stay in India, police said.

Investigators are now working to identify the source of the seized MDMA and uncover the larger supply chain behind the racket.

Police are also trying to trace other associates, including suspected local contacts and financiers, who may have helped distribute the drugs across NCR.

## From July 21, families can shift voter names to one booth

Noida.(Agency)

With several families found registered at different polling stations during the ongoing special intensive revision (SIR) of electoral rolls, election officials have opened a correction window to help club family members at a single booth.

District election officer Uttam Singh said the mismatch is largely reported from sectors and colonies where two polling stations share a building but cover different areas, prompting family members to file Form 6 applications with different BLOs. Voters wanting all eligible family members listed at one booth can now apply via Form 8 during the claims and objections period, from July 21 to Aug 20.

Singh advised new voters to cite the details of an already-registered family member while filling Form 6, and to submit the application to the BLO of the same polling station, to avoid future discrepancies. "BLOs are continuing door-to-door visits to distribute, collect and

digitise enumeration forms. Voters should submit forms to their designated BLOs within the stipulated time," he said.

The house-to-house verification drive will continue until July 14, with forms submitted

said voters needing help can contact their area BLO, use the ECINet 'Book a Call' facility, or call Election Commission's toll-free helpline, 1950.

Haryana chief electoral officer A Sreenivas said the SIR exercise will run till July 14, with final electoral rolls scheduled for publication on Sept 22. Where enumeration forms have not been received, BLOs may verify status by enquiring with neighbouring residents and recording the likely reason — "absent," "shifted," "deceased" or "duplicate" — after visiting each such household at least three times, he said. Sreenivas added that booth-wise lists of voters excluded from the draft rolls, along with probable reasons for exclusion, will be displayed on notice boards at Panchayat Bhawans, urban local body offices and BDPO offices.

ECI has directed all chief electoral officers to compile these lists and upload them in an accessible format on CEO and district election officer websites.

## Noida schools failing to upload RTE data to lose fee aid

Noida.(Agency)

Private schools that fail to submit details of students admitted under the Right to Education (RTE) Act by July 10 will not receive fee reimbursement for the 2025-26 academic year, the basic education department has announced.

The warning comes despite the state government releasing nearly Rs 15 crore towards reimbursement for students admitted under the RTE quota. Officials said only around 100 of the more than 350 private schools eligible under the scheme have submitted the required student data to the Basic Shiksha Adhikari (BSA) office so far. Basic Education Officer Rahul Panwar said schools had earlier been directed to furnish the details by June 10, but the response remained poor, prompting the department to issue a final deadline for next week.

Under the RTE Act, private schools are mandated to reserve 25% of entry-level



seats for children belonging to economically weaker sections and disadvantaged groups. The government reimburses schools for these admissions with an amount of around Rs 450 per student under the current norms.

Panwar said timely submission of student information is essential for processing reimbursement claims and ensuring that

eligible beneficiaries receive the scheme's benefits without delay. "Notices have been issued to all defaulting schools. Those that fail to provide the required information by July 10 will not be eligible for fee reimbursement," he said.

Officials said many private schools, including several prominent institutions, have either failed to update admission records or have not submitted the mandatory details, slowing the reimbursement process.

The education department has asked all schools admitting students under the RTE quota to complete the documentation within the stipulated timeline. "The move is aimed at ensuring transparency in the implementation of the scheme and preventing delays in the release of government funds meant for children studying under the 25% reservation provision," said a senior education official.

## In Ghaziabad, Kanwar route shops must display owner names, licence details

Ghaziabad.(Agency)

Shop owners along the Kanwar yatra route in the district will have to prominently display their names and food safety licence details as part of measures to ensure hygienic food for pilgrims, officials said. The district administration said the requirement is intended to improve transparency and strengthen compliance with food safety regulations.

Assistant commissioner of food safety Suresh Mishra said all food establishments on the yatra route must display the owner's name along with relevant licensing information. He clarified that the requirement is part of the department's efforts to verify compliance with food safety regulations and make information about licensed establishments easily accessible to consumers.

The four key yatra routes — spanning Modinagar-Kadriabad-Ghaziabad-Delhi, Gangnahar-Gyani Border-Muradnagar-Tila Mod-Loni, Chhijars-Pilukhwa-Sector 62, and Noida-Partapur-DME-Ghaziapur — stretch for more than 70 kilometres across



Ghaziabad. "Nine food safety teams have been constituted and are currently being trained in sanitation, hygiene and food safety protocols. These teams will serve as the first responders in the event of any food-related complaints or emergencies involving Kanwar pilgrims during the yatra," the official said.

The food safety department is also

introducing a digital verification system to improve transparency. "QR codes will be pasted at food establishments along the route and linked to the Food Safety Connect app. By scanning the code, consumers will be able to access details such as the food business operator's registration or licence number, the name of the establishment, the owner's name, address, mobile number and email ID,"

Mishra said.

# DMRC plans in-train audio ads on 4 metro lines

New Delhi: A brief pause between Delhi metro announcements could soon be followed by an advertisement, with the DMRC planning to roll out in-train audio commercials across the Red, Yellow, Blue and Magenta lines to boost its non-fare revenue. The move is aimed at strengthening the Delhi Metro Rail Corporation's (DMRC) non-ticketing earnings, while turning its trains into a premium advertising platform, an official said. The initiative also seeks to position the metro alongside leading global transit systems and airports for audio advertising, he added. To take the plan forward, the corporation has floated a tender inviting agencies to secure, market and manage in-train audio advertisement slots across six trains each on the Red (Line 1), Yellow (Line 2), Blue (Line 3) and Magenta (Line 8) corridors, the official said. The Yellow Line, one of the capital's oldest and busiest metro corridors connecting Kashmere Gate and Sultanpur, offers the largest uninterrupted advertising

inventory among the four routes after the Red Line's cumulative inventory, with 596 seconds of audio slots available in both directions, the official said. The Red



Line, connecting Dilshad Garden and Rithala, has the highest overall inventory at 721 seconds, followed by the Blue Line between Dwarka and Yamuna Bank with 634 seconds. The Magenta Line between Janakpuri West and Botanical Garden has 300 seconds, the official explained. He specified that advertisements will be aired only during silent intervals between routine operational announcements, with passenger

# Agra woman kills husband, buries body in bathroom

Agra: Agra Police on Friday arrested a woman for allegedly killing her husband and burying his body beneath the bathroom floor, officials said, adding that the accused also filed a missing person's complaint for the victim. The body of Surendra Sharma (45), who was missing for around 45 days, was recovered after police dug up the bathroom floor at the couple's house in Renuka Dham Colony under Sikandra police station limits. Assistant Commissioner of Police Amisha said Sharma was allegedly murdered by his wife, Ruby Sharma, who buried the body beneath the bathroom floor before covering it with concrete to conceal the crime. The officer said the breakthrough came after police questioned Ruby following a complaint regarding her husband's disappearance. During the investigation, police uncovered the alleged murder and recovered the body. Ruby has been arrested and is being interrogated to ascertain the motive behind the killing, the police said. A neighbour, Gaurav Dixit, said the couple frequently quarrelled and that Surendra, a native of Bharatpur, had been living in Renuka Dham Colony for about nine years. He said neighbours had repeatedly asked Ruby about her husband's whereabouts after he went missing, but she allegedly kept evading their questions.

# Training flight ends in crash in UP's Kasganj, woman pilot injured

New Delhi: A routine training sortie turned into a frightening ordeal on Monday as a trainee aircraft crashed in Uttar Pradesh's Kasganj district, leaving a woman trainee pilot injured. The Cessna 152 aircraft operated by Chetak Aviation went down in a field near a highway in Kasganj, sending locals rushing towards the crash site moments after the aircraft hit the ground. Villagers and passers-by reached the wreckage before emergency services arrived and pulled the injured trainee pilot to safety. She

was given first aid at a nearby medical facility before being referred to Agra. Officials said her condition was being monitored closely and she was out of danger. According to preliminary information, the aircraft was carrying out a routine solo training flight after taking off from Aligarh when the incident occurred. The exact sequence of events leading to the crash remains unclear. Senior police and district administration officials reached the spot and supervised rescue and security operations. Authorities cor-

doned off the area and secured the wreckage to preserve evidence for investigators. Aviation and district officials have not ruled out any possibility at this stage, with technical failure, weather conditions and operational issues among the factors being examined. The Directorate General of Civil Aviation (DGCA) has launched a formal investigation into the incident. "A Chetak Aviation Cessna 152 aircraft VT-APB engaged in solo flying at Aligarh has crash-landed in a field in Kasganj. Pilot is reported to be safe. The DGCA is investigating the occurrence," the aviation watchdog said. The district administration has also ordered a detailed inquiry, with officials from various agencies collecting evidence and examining the wreckage to establish the precise cause of the crash. In May last month, a Red Bird Aviation trainee aircraft crash-landed near Baramati, Maharashtra.

# Delhi: Cyber fraud victims can reclaim losses below Rs 50K

New Delhi: Victims of cyber fraud who have lost up to Rs 50,000 can now seek recovery of their money by registering on the Money Restoration Module (MRM) or by visiting the nearest Cyber Police Station. Highlighting the effectiveness of the initiative, the Delhi Police have facilitated the restoration of Rs 3.59 lakh to 34 victims who had lost money to cyber fraudsters through the victim-centric system developed by the Indian Cyber Crime Coordination Centre (I4C). According to the police, the amount was restored in 34 cyber fraud cases after the completion of all verification and documentation formalities. A total of 70 requests were received from the I4C for processing under the module, which has been designed to help victims

recover funds that were temporarily frozen or secured following cyber fraud complaints. The Money Restoration Module enables the return of lien amounts of up to Rs 50,000 in eligible cases where banking intervention has blocked suspicious transactions. Once a case is flagged under the system, the complainant is contacted and guided through the recovery procedure. The police officials said victims must visit the concerned police station in person with supporting documents, including PAN card details and an indemnity bond executed on stamp paper, for verification before the funds can be released. However, 22 cases could not be processed as the com-

plaintants did not respond to repeated communication from the authorities. The I4C Recovery Portal, officially known as the Money Restoration

# 5 killed, 11 injured after speeding canter truck rams into stationary bus in UP's Etah

Etah (UP): Five people were killed and 11 injured after a speeding canter truck rammed into a stationary Uttar Pradesh State Road Transport Corporation (UPSRTC) bus on the Etah-Aliganj road in the state's Etah district, officials said. District Magistrate Arvind Singh said the UPSRTC bus of the Etah depot was on its way from Farrukhabad to Delhi when it developed a mechanical fault around 11.30 pm on Thursday near Keelarnau village in the Bagwala area. The bus was parked on the roadside for repairs and several passengers had got down and were standing nearby when the speeding canter truck hit the bus from behind, crushing those standing outside, he said. Four people—identified as Rajesh (34), Sukhram (42), Shailesh (32) and an unidentified man—died on the spot, while another unidentified person succumbed to injuries during treatment at a hospital, the district magistrate said. The bodies have been sent for post-mortem examination, he said.

## Iran envoy says friendly nations to get 'special' Hormuz fee treatment

BEIJING.(Agency)

Iran's ambassador to China insisted Saturday that new fees would be charged to ships transiting the Strait of Hormuz -- an idea rejected by Washington -- while assuring that "friendly" nations would receive special treatment. The initial deal struck between Iran and the United States to end their war stipulated that commercial ships would transit the strait free of charge for 60 days, but it remains unclear what will be in place after that period. Iranian Ambassador Abdolreza Rahmani Fazli told the World Peace Forum in Beijing that his country was working in "collaboration and cooperation" with Oman on "new arrangements" for the vital waterway. "As a country where the Hormuz is part of its territorial waters, we will definitely charge service fees," Azli said in translated remarks, while insisting such fees would not be a "toll." "These new arrangements will be concerning guaranteeing the security of passage through the Straits of Hormuz, supervision of the passage of the vessels... and also guaranteeing and dealing with the environmental consequences of the massive number of ships," he said. "We will definitely consider special treatment for the countries that were friendly to us and specially stood by us during the hard times," he added. The strait normally carries one-fifth of the world's crude oil and liquefied natural gas, but it was all but closed by Iran during the Middle East war, sending energy prices soaring. Iran lifted its blockade of the Hormuz after it struck an initial deal with the US to end the Middle East war, and negotiations on a permanent settlement of the conflict are ongoing.

## Boat transporting students from exams sinks in Congo, killing at least 20, authorities say

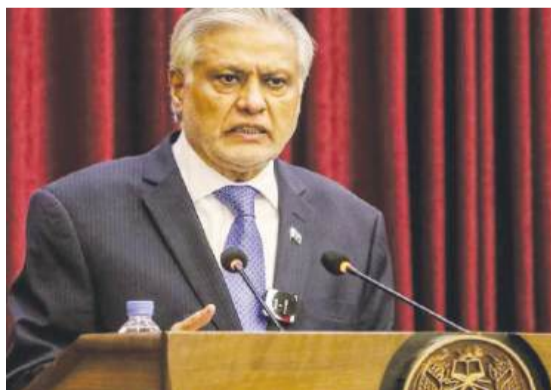

A wooden boat transporting students back from state exams sank in central Congo, killing at least 20 people, authorities said. The vessel was traveling in Kasai province when it sank while entering the confluence of the Sankuru and Kasai rivers, according to witnesses. Deadly boating tragedies are common in the central African country, where late-night travels and overcrowded vessels are often blamed. Poor safety standards and lack of infrastructure in remote parts of the country also contribute to the hundreds killed in boat disasters in recent years. "There were 80 survivors and 20 bodies," said Francois Kabula, administrator of the Ilebo territory in Kasai province, where the sinking happened Friday. However, Tshikudi Jean, who witnessed the crash, told The Associated Press that the boat was carrying over 200 people. "The shipowners of the DRC are only after money and don't care about human lives," Francois Malepo, president of the Ilebo civil society organization said.

## "Quit Immediately": Pakistan Deputy PM Faces Flak After Grandson Arrested For Rape

A Pakistani senator, with close links to the country's military establishment, on Saturday demanded the resignation of Deputy Prime Minister Ishaq Dar after a relative of his was arrested in a case concerning the abduction and gangrape of two foreigners here. Senator Faisal Vawda also accused the federal government and the provincial government in Punjab of protecting the minister's relative in the high-profile case. Two women - one from the Netherlands and the other from Venezuela - were allegedly abducted by a group of men on June 29 and gangraped in Lahore. The police have arrested four men, while one is absconding. They were sent to five-day police custody by a Lahore court on Friday. One of the arrested men - Muhammad Raza Dar - was identified as the prime suspect in the case. Police sources said Raza Dar is Ishaq Dar's grandson. During the investigation, police have said, it emerged that Raza Dar met the two women



in Singapore last year, and they were partners in a cryptocurrency venture. He arranged business visas for them for their visit to Pakistan. Vawda on Saturday said Pakistan is being "run like a family corporation", as he highlighted the gangrape incident and described the prime suspect as "alleged grandson" of Ishaq Dar, who is also the foreign minister. "He (Raza Dar) was arrested only after the intervention of the relevant foreign embassy. After such serious allegations, how can Ishaq Dar continue to represent Pakistan before the world as Deputy Prime Minister and Foreign Minister?" Vawda said in a post on X. "If there is any concern for Pakistan and its international image, Ishaq Dar should resign immediately," he said. Vawda, widely seen as a mouthpiece of the Pakistani military establishment, was elected as Senator on the vote of both Pakistan People's Party (PPP) and the Pakistan Muslim League-Nawaz (PML-N), which are coalition partners in the federal government. He, however, does not represent any political party. Vawda further said on Saturday, "Attempts are being made to limit the case to extortion rather than rape."

## Prosecutors to lay out their case against the man accused of killing

**The five-day preliminary hearing that starts Monday will be the first time members of Kirk's family are in the Utah courtroom with defendant Tyler Robinson.**

SALT LAKE CITY.(Agency)

Charlie Kirk's widow and parents are expected this week in a Utah court where prosecutors seeking the death penalty will argue that the man charged with killing the conservative activist should stand trial for murder. The five-day preliminary hearing that starts Monday will be the first time members of Kirk's family are in the Utah courtroom with defendant Tyler Robinson.

The hearing will be livestreamed.

Robinson turned himself in after the shooting. Prosecutors allege that he also sent a text message confession to his partner and left a note saying he had an opportunity to kill one of the nation's leading conservative voices "and I'm going to take it." He has not entered a plea in the case, however. Robinson, 23, is charged with aggravated murder in the Sept. 10 assassination of Kirk, who was addressing a crowd of thousands at Utah Valley University. His attorneys have not commented on his guilt or innocence. Months of legal jostling leading up to the hearing centered largely on media access. Beginning Monday, the focus shifts to whether there is enough evidence for a trial and if the death penalty is warranted, said Paul Cassell, a University of Utah law professor and former federal judge. Cassell said evidence made public to date in court filings suggests prosecutors have "an overwhelming case." "This seems like the

proverbial slam dunk at this stage of the case, where the only issue is whether there is a sound basis for moving forward with a trial on the merits," he said.



A death sentence is an option in Utah only when a crime has aggravating circumstances. Prosecutors will argue in Robinson's case that Kirk's shooting endangered others in attendance. The proceeding will resemble a minitrial, with prosecutors planning to offer DNA evidence linking Robinson to the suspected murder

weapon, testimony from investigators, autopsy findings, witness statements and video of Kirk's killing. They are not required to present all their evidence and can use secondhand information, or hearsay.

After the hearing concludes, state District Judge Tony Graf must determine if the case should proceed. Reporters and the public will be allowed to attend after Graf denied a defense request to restrict access. Kirk's killing drew backlash from his Republican allies, including President Donald Trump, who first announced Robinson's arrest in a Sept. 12 interview on Fox News and said, "I hope he gets the death penalty." This week prosecutors need only demonstrate that there are reasonable grounds to believe Robinson killed Kirk. The standard is lower than for a trial, where prosecutors have to prove guilt "beyond a reasonable doubt." Authorities have said DNA consistent with Robinson's was found on the trigger of the rifle used to kill Kirk.

## Performer calls for Trump's death at funeral for Iran's late supreme leader

A performer at the funeral for Iran's late Supreme Leader Ayatollah Ali Khamenei called for the death of US President Donald Trump before a crowd of hundreds of thousands of people Sunday in the capital, Tehran. The comment represents the first, direct call for Trump's death by an emcee at the funeral, which has seen posters and graffiti calling for the killing of Trump and Israeli Prime Minister Benjamin Netanyahu. That's been a hard-line demand even as Tehran negotiates with the US over a permanent end to the war that's disrupted global energy supplies.

Mohammad Rasouli, a poet, drew calls of "Death to America!" and "Death to Israel!" Speaking to the crowd over loudspeakers at the funeral, Rasouli asked, referring to Trump: "Why is the most bastard man in the world still



alive?" The question drew cheers from the crowd, and again when Rasouli said that "the world is no longer a good place for" Trump. Larger crowd attends second day of Khamenei's funeral. A far larger crowd for the funeral than the day before attended the ceremony Sunday. Mourners dressed in black walked to the site, carrying banners and flags

honoring Khamenei and also calling for Trump's killing as the American president gave a speech in Washington for the 250th anniversary of the founding of the United States.

"We've had tremendous success," Trump said, speaking of the American military. "You look at Venezuela, you look at Iran. We wiped it out, wiped out their military." US federal authorities have been tracking Iranian threats against Trump and other administration officials for years. That stems from Trump ordering the 2020 killing of Gen. Qassem Soleimani, who led the expeditionary Quds Force of Iran's paramilitary Revolutionary Guard. Iran repeatedly has denied plotting to kill Trump, though hard-line propaganda footage long has suggested Trump was in Tehran's crosshairs.

Trump meanwhile promised to destroy Iran's very civilization during the war among a variety of other threats.

## Xi says ready to work with Kim for 'stable' China-N. Korea ties: KCNA

SEOUL.(Agency)

China's President Xi Jinping said he was ready to work with North Korean leader Kim Jong Un to steer their bilateral relationship toward "long-term, sound and stable" development, Pyongyang's state media reported Sunday.

The exchange follows Xi's rare visit to North Korea last month, when the two leaders pledged to deepen ties as tensions rise on the Korean Peninsula and Pyongyang expands its military cooperation with Russia. In a message dated July 1, Xi thanked Kim for his congratulatory message marking the 105th anniversary of the founding of China's Communist Party, according to the official Korean Central News Agency (KCNA). Xi said Kim's message reflected the "deep and warm feelings" of the North Korean leader, the ruling

Workers' Party and the North Korean people toward China. "The Communist Party of China and the Workers' Party of Korea are the Marxist ruling parties," Xi



said, adding that the two countries had stood together for national independence and had jointly advanced the socialist cause over generations. "I am ready to guide the relevant sectors and regions of both sides to the full

implementation of the important common understanding achieved among us and lead the China-DPRK relations to a long-term, sound and stable development," Xi said, using the initials of the North's official name.

Referring to his recent state visit to Pyongyang, Xi thanked Kim for the "enthusiastic and friendly" hospitality during the trip. The message came in response to a letter from Kim, who described their summit in Pyongyang as a "historic occasion" and said it was North Korea's "steadfast stand" to continue strengthening ties with Beijing. North Korea has expanded security ties with Russia, where Pyongyang has sent soldiers and munitions to assist Moscow's invasion of Ukraine.

Still, China remains North Korea's largest economic partner, accounting for nearly 98 percent of the country's foreign trade in 2024, according to South Korea's Ministry of Economy and Finance.

## Trump mixes patriotism with partisanship as he celebrates America's 'joyous' 250th anniversary

**Trump highlighted his support for the Second Amendment and revived denunciations of communism, which are becoming an increasingly central part of Trump's message ahead of the November midterms.**

President Donald Trump mixed partisan politics with patriotic appeals on Saturday as he commemorated the 250th anniversary of American independence, a moment he declared "one of the most joyous and glorious milestones of all time." Speaking in Washington after storms prompted a roughly two-hour evacuation of the National Mall, Trump honored veterans, including several from World War II and one of the first Black officers to lead a Special

Forces team in combat in Vietnam. They appeared before flags that symbolized some of the most significant and challenging moments in American history, from the one that was draped over Abraham Lincoln's casket to the one that flew on the plane piloted by the Wright Brothers.

Yet Trump also leaned into partisan territory unusual for an Independence Day address, which presidents typically use as a moment to unify the country. Instead, he stumped again for the SAVE America Act, an elections bill that's encountering challenges even from Trump's fellow Republicans in Congress. He highlighted his support for the Second Amendment and revived denunciations of communism, which are becoming an increasingly central part of Trump's message ahead of the November midterms. The speech capped a holiday that Trump has gone to great lengths to shape to his own tastes. He was introduced by two musical performers who often appear at his trademark rallies, including Lee

Greenwood, who performed "God Bless America." The event organizers were largely aligned with the White House, supplanting a bipartisan organization that



was launched by Congress a decade ago. "We will always be on top," Trump said. "We will never let our country fall. We will always be the best." Trump didn't talk about himself as much as he does during his normal rally speeches. Still, he still found time to include a joke about seeking a third presidential term and about World War II's "greatest generation."

"They are the greatest generation," Trump said. "I hate to admit that, but they are."

Anticipation for the milestone holiday has been building for much of the year, serving as an opportunity for Americans to reflect on their complicated history as onetime colonists of an empire who became a superpower of their own. Organizers of celebrations months in the making had to adjust or cancel activities entirely as much of the East Coast sweltered under heat that approached and in many cases surpassed triple digits. Heat is defining the big weekend in many places. Severe weather prompted the cancellation of celebrations in Hartford, Connecticut, along with Harrisburg and Wilkes-Barre, Pennsylvania. Spectators at Boston's fireworks and concert were told to briefly seek shelter before events later resumed. An evacuation was also ordered in Philadelphia. New York and Pittsburgh moved forward with fireworks but shifted the time to accommodate the shifting weather.

## Report contaminated water supply, says Panvel mayor after two GBS cases

Mumbai.(Agency)

Panvel City Municipal Corporation (PCMC) mayor, Nitin Patil, has appealed to the people to report contaminated water supply. His appeal came after two confirmed cases of the rare and serious autoimmune disorder (Guillain-Barre Syndrome-GBS) were reported in Panvel in the past month.

The PCMC has launched an awareness drive across suspected places and started collecting water samples. The two cases were reported at the Aadhar Multispecialty Hospital, Panvel. A 40-year-old male patient, complaining of weakness, was admitted to the hospital on June 6 and after treatment, was released on June 15. Another 71-year-old female patient from Konkan arrived at Takka on June 12 after a Chardham journey. She had symptoms of fever and weakness from June 16. She suffered with numbness in her hands and legs on June 24.

The disease is triggered by a preceding viral or bacterial infection arising out of consuming contaminated water, eating outside food, among others.

This affects the brains besides other symptoms, as is observed among the infected persons. Patil stressed upon checking the potable water quality before consumption. He further said that in the advent of monsoon season, infectious diseases spread fast and hence people should remain cautious.

## UP man killed 4 mnths after interfaith union; bro-in-law held

Agra.(Agency)

A 30-year-old man, who had married a woman from Firozabad in March, was allegedly beaten to death during his first visit to his in-laws' house on Thursday night. The prime accused, his brother-in-law, was arrested after an encounter on Friday, police said.

Devesh Singh alias Dau, an autorickshaw driver and resident of Tedhi Bagiya, had been living in Agra with his wife after the couple married against her family's wishes. "According to Devesh's family, the woman's relatives assaulted and strangled him after he reached his in-laws' house with his wife for the first time after the wedding," an officer at Ramgarh police station, privy to the case, told TOI. His body was found near Chapariya locality late Thursday night.

An FIR was registered at Ramgarh police station on the complaint of the victim's uncle under BNS sections 103(1) for murder and 115(2) for voluntarily causing hurt. Two police teams were formed to investigate the case.

Police said they received information on Friday morning that the prime accused, Sameer Mohammad, 28, was hiding in Hasmatnagar, Firozabad. When a police team surrounded him, he allegedly opened fire instead of surrendering. Police retaliated and Sameer sustained bullet injuries in both legs. He was arrested and admitted to the district hospital under police custody. SP (city) Ravishankar Prasad said raids were on to arrest the remaining named accused.

## State can't undo 33-year-old appointment: Gujarat High Court

The Gujarat High Court has quashed a state govt order cancelling an appointment of a teacher 33 years after he was given the job and some 17 years after his death, and stopping the pension being given to his widow.

In this case, Harshad Bhavsar, along with five others, was appointed as a teacher in its school by Sugyan Education Trust in 1988. After ascertaining he got requisite qualification for the post, his appointment was regularised by the district education officer in 1989. After serving for 16 years, Bhavsar died in 2004. The education department began paying family pension to Bhavsar's widow, Manorama.

In 2021, the director of schools cancelled the appointment of six teachers and a librarian of the school, including that of Bhavsar, withdrew grant benefits, cancelled employee numbers and stopped salary payments under the Direct Salary Scheme.

The govt action was initiated following a complaint made in 2015 by the husband of then school principal, alleging that the appointments had been made in violation of recruitment rules. The govt cancelled the appointments on the grounds that they were based on forged documents, made without obtaining a no-objection certificate, without publishing advertisements and without seeking names from the employment exchange, causing a financial loss of over Rs 6 crore to the exchequer. The school trust and the affected employees, including Bhavsar's widow, challenged the order before HC in 2021. A single-judge bench quashed the govt's decision, ruling that appointments could not be cancelled after more than three decades.

## An unsung forest fire warrior's battle to save the greenery in Odisha

This guardian of the forests has been the first responder to wildfires for last 33 years in Sundargarh

Every summer, when the forests of Ujjalpur range in Sundargarh begin to crackle under an unforgiving sun and carpets of dry leaves wait for a spark, one man readies himself for war. Not with machines or protective gear but with grit, experience and an unceasing love for the forests.

For 52-year-old Debanand Mahaling, the last 33 summers have meant only one thing - fighting forest fire. A resident of the forest-fringed Sagarparli hamlet under Mangaspur village in Tangarpali block, about 130 km from Rourkela, Debanand has spent more than three decades standing between raging flames and the forests he calls home. While others seek safety when fire sweeps across the hills, he runs towards it.

For villagers, he is not merely an environment warrior. He is the forest's first responder and its unofficial guardian. Forest fires are a



recurring menace in this part of western Odisha, triggered by natural, accidental and human causes. Every blaze threatens not just trees but entire ecosystems, forcing birds from nests and animals from habitats built over generations. For Debanand, the loss is personal. "These fires are not just environmental disasters. They are personal battles for me. Every burning tree, every

fleeing animal and every charred patch of forest strengthens my resolve to protect nature," he says.

His journey began in 1993 after he returned home following completion of his ITI course in Rourkela and joined his family's farming activities. Around the same time, senior volunteer Santosh Patel introduced him to the Nehru Yuva Kendra movement, an experience that shaped his commitment to community service and conservation. His work prompted the Forest department to engage him as a watcher in 2012.

What started with plantation drives and occasional firefighting gradually became a mission. Debanand mobilised 24 village youths to form a community forest fire response team. The moment smoke rises above the hills, the team heads out carrying little more than green branches, spades and fire beaters, often trekking across rugged terrain in slippers.

## Telangana revives Gond kingdom's historic fort with heritage-focused makeover

For over six centuries—from 1308 CE until Indian Independence — the Gondwana kings ruled a vast tribal kingdom stretching across present-day Maharashtra, Madhya Pradesh, Chhattisgarh, northern Telangana, western Odisha and parts of southern Uttar Pradesh. Now, their legacy is getting a modern makeover.

The Uttoor Fort, once the seat of Gond power, is undergoing a Rs 3.9 crore renovation, with plans for a museum, architectural lighting, landscaped greenery, a children's play area and open spaces for cultural celebrations. The Telangana government has sanctioned Rs 3.9 crore for the restoration of the historic fort, with renovation work currently under way. Besides conserving the fort, officials plan to transform it into a heritage destination showcasing the history, culture and traditions of the Gond community.



During a recent inspection, District Collector Rajarshi Shah and Integrated Tribal Development Agency (ITDA), Uttoor Project Officer Manda Makarand directed officials to prepare proposals for a state-of-the-art museum that will preserve the history of the Gond kingdom, its rulers and tribal heritage for future generations.

The collector also asked engineering officials to prepare plans for decorative lighting,

greenery, a children's play area and open spaces to host small cultural and community events within the fort premises, which spread across nearly 15 acres.

Officials say the Archaeology department and ITDA are jointly executing the restoration works, ensuring that conservation does not compromise the fort's historical character. Speaking to , Kumra Vittal Rao, adviser to the Gondwana Panchayat Raj Centre and a member of

the Gond royal family, says the Gondwana kingdom ruled the region from 1308 AD until Indian Independence. The first ruler was Raja Hanumanth Rao, while the last ruler was Attram Dev Shah. The Gond rulers governed the region from their capital at Chandrapur, in present-day Maharashtra, with their influence extending across Uttoor, Kanchanpelli and Mahoor. After Independence, the kingdom merged.

## Cop who turned thalassaemia crusader in Western Odisha

For years, Ramdas Panda organised blood donation camps, mobilised donors and responded to emergency calls for blood. But it was a chance encounter with a distressed mother of two children suffering from thalassaemia at VIMSAR, Burla, during the Covid-19 pandemic that changed the course of his life.

Four years later, the former Odisha Police constable took voluntary retirement to dedicate himself to supporting thalassaemia patients, building a network of over 500 affected individuals across western Odisha and campaigning for greater awareness of the genetic blood disorder that requires lifelong blood transfusions.

The encounter with two brothers, Sipun and Papun Barik from Bargarh, in 2020 was Panda's introduction to thalassaemia. The children were struggling to find blood for their regular transfusions as the pandemic



disrupted blood donation activities and hospital services.

"I was surprised to learn that a healthy-looking child could require blood twice every month just to survive. I wanted to understand why," the 46-year-old recalled.

After arranging blood for the two siblings, he began studying the disorder and interacting with doctors, patients and their families. What began as an effort to help two children soon evolved into a larger mission.

Panda not only took responsibility for arranging blood for the brothers but

also bore their monthly travel and treatment-related expenses. At the same time, he started compiling information on thalassaemia patients across western Odisha.

From a handful of families, the initiative gradually has since grown into a WhatsApp network of more than 500 patients who use the platform to seek blood donors whenever they visit VIMSAR for transfusions. "I

can now assure that any thalassaemia patient coming to VIMSAR for blood will not have to face any hassle," Panda said. The network eventually became more than a support group. It evolved into a platform for awareness generation and advocacy. Panda has since conducted awareness programmes in educational institutions across the region, including Gangadhar Meher University, VSSUT and AIIMS, highlighting the importance of voluntary blood donation and premarital screening to prevent.

## Telangana's avionics engineer who grounded himself to lift others

HYDERABAD.(Agency)

At an age when many professionals focus on advancing their careers, 34-year-old Vinil Reddy Adudodla chose a different path. In 2023, he stepped away from his job in avionics engineering to devote himself full-time to social service and built a volunteer network that works in education, healthcare, agriculture and environmental conservation.

Through Youth Force and in his role as general secretary of the Telangana Development Forum, Vinil has mobilised thousands of young volunteers for community initiatives. He also contributes around 90% of his income towards social causes. One of his key initiatives is 'Mana



Panta Mana Vanta', under which 86 villages have been adopted to help preserve indigenous paddy varieties. Working with farmers, the programme collects traditional seeds from Telangana, Andhra Pradesh and Odisha, multiplies them and preserves them

in community seed banks.

The idea that shaped Vinil's life emerged during his Intermediate studies. Moved by a television programme on children battling cancer, he began discussing ways to help with friends and family. The first initiative started modestly in a college canteen, where he and his classmates encouraged students to donate the loose change left after buying snacks.

The small contributions added up quickly, with nearly Rs 2 lakh collected in the first month. The funds were donated to Basavarakam Hospital to support children undergoing cancer treatment.

Recalling an incident that left a lasting impression, Vinil said a four-year-old girl

who had completed cancer treatment could not be discharged because her family could not pay the final hospital bill. "We quietly cleared the amount and left. Her parents searched for us for two days just to say thank you. That experience convinced us that our contributions should remain anonymous," he tells.

Today, the organisation works with students across colleges and encourages them to contribute not just money, but also their time. "If every young person gives even one or two hours a week to society, the collective impact can be enormous. We don't expect everyone to become social workers. We only ask them to become responsible citizens," he adds.

## This Thane pet crematorium has witnessed hundreds of goodbyes

The faux diamond stud in his right ear catches the 6 pm light. Bluetooth earphones hang around his neck as Rahul Suradkar watches a woman walk silently down a corridor painted with paw prints and a playful pup.

"I am here for the ashes... of the rabbit," she says.

"Have you brought...?" "The white dabba right there," she replies before he can finish.

That's his cue. Suradkar opens the plastic box, disappears inside, and returns with a metal wok holding the rabbit's cooled remains. He gently scoops the ashes into the container, snaps the lid shut and hands it back.

Neither says another word. As he watches her leave, weighed down by grief, Suradkar recalls other owners who have broken down before him — some weeping uncontrollably, others calling priests to perform the last rites. "For some, they're family," says the khaki-clad operator.

Opened in Majiwada last November by transport minister Pratap Sarnaik — whose own family had to travel to Mumbai to cremate their dog, Moti, because no such facility existed in Thane — the crematorium has already handled nearly 1,500 cremations. Families travel from as far as Ambernath and Kharegaon, says Suradkar, one of the two operators who run the gas-fired incinerator and return the ashes to owners.

At 35, this animal-loving father of two, has cremated dogs, cats, rabbits, turtles and, once, a deer brought in by the forest department with all the necessary paperwork. His Rs 19,000-a-month job is not for the faint-hearted. Every day, wearing gloves, a mask and goggles, he lifts the bodies of animals into the furnace before later collecting their ashes for grieving families.

## Jio fastest on Jodhpur-Ahmedabad rail route, BSNL lags: TRAI report

Ahmedabad.(Agency)

Rail passengers travelling between Jodhpur and Ahmedabad can expect the fastest mobile internet speeds on Reliance Jio's network, while BSNL users are more likely to encounter weak signals and dropped calls, according to an independent network assessment by the Telecom Regulatory Authority of India (TRAI). The regulator recently released the findings of the drive test conducted on the 456.9-km rail corridor.

The assessment, carried out on May 4, covered the Rajasthan and Gujarat licensed service areas from Bhagat ki Kothi in Jodhpur to Ahmedabad. The findings provide a snapshot of the quality of mobile services available to passengers on one of the key rail links connecting the two states.

Among the four telecom operators, Jio recorded the highest average download speed at 89.61 Mbps, nearly double Airtel's 48.53 Mbps. Vodafone Idea averaged 12.71 Mbps, while BSNL recorded 7.95 Mbps. Airtel led upload performance with an average speed of 11.69 Mbps, followed by Jio (9.06 Mbps), Vodafone Idea (8.81 Mbps) and BSNL (3.76 Mbps). TRAI noted that all operators exceeded the typical download and upload speeds they had declared for the technologies tested.

The regulator also found wide variations in network coverage along the route. BSNL recorded the highest number of poor-signal samples at 7,368, along with 1,271 instances where there was no network coverage at all.

## Air pollution plan needs political will, not an eye on the election cycle

Over the past few years, we have witnessed a troubling disconnect between scientific evidence and policy implementation in the country. First, the weak enforcement of the fuel-ban policy for end-of-life vehicles undermined its intended impact. Then, the draft Electric Vehicles (EV) Policy 2.0 raised serious concerns among environmentalists by proposing to extend EV incentives to hybrid vehicles. While hybrids combine petrol engines with electric motors, they remain dependent on fossil fuels and cannot deliver the full environmental and public-health benefits of zero-emission mobility.

Against this backdrop, the Delhi government's latest initiative marks a step in the right direction by targeting emissions at their source rather than targeting the open sky. It offers renewed hope for sustained improvements in air quality. The push for the EV policy 2.0 might shrink the urban carbon footprint, and the purification of local air could help alleviate concerns over respiratory and other non-communicable diseases that affect a substantial section of the city's population. For the metropolis, which juggles a staggering fleet of over 15 million vehicles, transitioning to electric mobility is no longer just an environmental aspiration; it is a public health imperative.

The Delhi emission inventory database in the National Institute of Advanced Study's (NIAS) 2025 policy brief reveals that the transport sector accounted for 41 per cent of the city's most deadly air pollutant, PM 2.5, in 2024. The new policy will unfold in two phases. Starting January 1, 2027, the city will completely halt the registration of conventional three-wheelers and light goods vehicles, permitting only electric models. From April 1, 2028, only electric two-wheelers will be allowed. Two-wheelers contribute 20 per cent, whereas three-wheelers contribute less than 5 per cent of transport emissions. Currently, almost half of the three-wheelers are already non-fossil fuel, so their contribution is not 17-20 per cent as estimated by earlier studies, including the one by TERI in 2018. So, the overall gain with 100 per cent EV conversion of these three categories of vehicles would be 35 per cent of total transport, which will translate to just 15 per cent of Delhi's PM 2.5 concentration — this is a good initiative, but it won't lead to drastic change. However, a balanced perspective is one of the fundamental requirements of science. Studies conducted by the NIAS show that this policy is merely the first battle in a much larger war. While the present policy is a good start, to truly clear the air, subsequent policies must tackle the two heaviest polluters: Heavy commercial vehicles and buses, which command around 60 per cent of transport emissions. Tackling pollution from their tailpipes could reduce Delhi's PM 2.5 by 20-25 per cent. The number of commercial vehicles and buses might be low, but their emissions are higher compared to those from two-wheelers and cars. Policymakers need to prioritise targets based on the most polluting fleet. Transforming commercial vehicles to EVs will yield the maximum benefit. However, practical challenges need to be assessed. The public-health payoffs of this structural shift are monumental. According to an NIAS policy brief, adoption of EVs would avert 800 premature deaths annually because cleaner air would reduce diseases linked to vehicle emissions, such as heart disease, stroke, lung cancer, and respiratory illnesses. It will save 12,000 years lost to disability every year. In other words, Delhi's population would collectively gain the equivalent of 12,000 additional healthy years of life every year through reduced illness and premature death. Beyond the intrinsic value of human life, this transition makes undeniable economic sense. According to the NIAS study in 2025, transitioning two-wheelers, three-wheelers, and light commercial vehicles fully to electric power could save at least Rs 1,000 crore every year in averted medical expenses.

## Egg on a mid-day meal plate

Removing a low-cost source of high-quality protein from a school plate demands more than sentiment

The egg is a modest food, yet in India's school meals it has acquired political weight. The reported decision in West Bengal to replace eggs with vegetarian options in government-aided schools managed by a vegetarian provider has reopened a question. Should nutrition policy for children be governed by science and evidence, or by adult anxieties about religion, caste and purity? In an evidence-guided system, the answer would be simple. The National Family Health Survey-6 shows that India's child nutrition challenge remains grave: 29.3 per cent of children under five are stunted and 31.8 per cent are underweight. Behind these percentages are children whose bodies do not grow as they should, whose immunity is fragile, whose learning is blunted, and whose school life begins with a disadvantage. Improved protein intake, alongside calories is the solution.

In such a country, removing a low-cost source of high-quality protein from a school plate demands more than sentiment. It requires evidence. The nutritional case for eggs is uncomplicated and strong. An egg is affordable, easy to cook, simple to distribute and familiar across India. It provides high-quality protein and essential amino acids, along with vitamin B12, choline, selenium and nutrients needed for growth and brain development. For a rich household, an egg may be one item in a varied diet. For a poor child, it may be among the most nourishing foods received all week. That is why the state-wise picture matters.

PM POSHAN, generally called the mid-day meal scheme, allows states and UTs to decide menus according to local needs while meeting nutrition norms. Eggs entered mid-day meals in some states in the mid-1990s. Yet analyses of government data show that around 13 states provided eggs as an option in 2025-26, down from 16 states in 2015-16. Over the past decade, several states have either dropped eggs or considered removing them. When children need dietary variety, the menu has shrunk. The states that provide eggs acknowledge local food habits and nutritional need. Southern India has been more consistent. Tamil Nadu introduced eggs decades ago. Karnataka expanded egg provision after focusing on districts with anaemia. Andhra Pradesh has persisted with eggs despite vegetarian providers. Kerala, Telangana and several eastern or tribal states have also used eggs in child nutrition programmes. The principle is simple: a public meal should strengthen nutrition where diets are inadequate. The opposition to eggs seldom arises from nutrition science. It usually comes from politics. Vegetarian pressure groups, religious organisations and local elites invoke sentiment, purity, satvik food or



community preference. These words may sound benign. Their consequence is not. One section's dietary preference becomes a rule for everyone. That is unjust in a country as varied as India. India is not a vegetarian nation. Food habits differ by region, caste, tribe, religion, income and ecology. Many Dalit, Adivasi, backward caste, Muslim, Christian and other communities have long consumed eggs and animal-source foods. For their children, the egg is ordinary food. To remove it because some adults consider it impure is to smuggle hierarchy into a meal. Food in India has always carried social meaning. It has marked caste status, ritual purity, exclusion and power. The mid-day meal scheme challenged this by asking children from different backgrounds to sit together and eat. Its achievement was civic, not merely caloric. When eggs are banned because they offend the powerful, children receive a lesson no school should teach: the food of their homes is inferior. There is a constitutional question too. The Indian State is secular and plural. It cannot elevate one community's dietary code into public policy. The right to food has been read into the right to life under Article 21. A school meal should not merely relieve hunger; it should advance nutrition. A child's nutritional right cannot be hostage to another household's preference.

This does not mean vegetarian families should be dismissed. Some parents may not want their children to eat eggs. Their choice deserves respect. But respecting one family's preference does not require denying another

child nutritious food. The answer is not prohibition. It is choice. Practical solutions exist. Eggs can be served on specified days. Children who do not eat them can receive milk, banana, chikki, pulses or soya. Schools can arrange separate serving. Parents can opt in or out. This requires clarity, not dogma. A blanket ban, or an approach close to one, is the poorest response. It does not protect vegetarian children; they can be offered alternatives. What it does is deprive egg-eating children, often poorer, of protein they need. It allows adult opinion to overrule an undernourished child's need.

School meals must be guided by evidence, not ideology. What do children need to grow, learn and remain healthy? The answer must come from paediatric science, nutrition data, local food habits and poverty. India speaks of human capital, demographic dividend and Viksit Bharat. Such phrases are hollow if children remain stunted and undernourished. The first investment in the future is not a tablet or coding lesson. It is a child nourished enough to learn. Nutrition deficits in childhood can impair development in ways later feeding cannot fully reverse. Protein deficiency and undernutrition increase chronic disease risk in adulthood.

The midday meal is not just lunch. For millions, it is the State's promise. Removing eggs from that plate is not a minor menu change. It is a public health decision. A school meal should not become a site for cultural policing. It should remain a promise that no child will be too hungry or undernourished to learn.

## Ethanol push : Address concerns of key stakeholders

Preparedness, transparency and stakeholder collaboration, not haste, will determine whether E85 becomes a successful model or a missed opportunity

A month after India introduced E85 fuel, a high-ethanol blend for flex-fuel vehicles, concerns persist among consumers and the automotive industry. These vehicles are designed to run on higher blends such as E85 (85% ethanol, 15% petrol) and E100 (nearly pure ethanol), unlike petrol-powered vehicles compatible with E20 fuel (20% ethanol, 80% petrol). The decision to make E85 available at select outlets is aimed at reducing dependence on imported crude oil. With around 90% of the country's crude oil sourced from overseas, global geopolitical tensions have repeatedly exposed the vulnerabilities of India's energy ecosystem. Promoting ethanol as a mainstream fuel for flex-fuel vehicles is an ambitious step towards achieving energy self-reliance and reducing greenhouse gas emissions. However, a carefully calibrated execution that inspires public confidence is a must to facilitate this transition. India has already demonstrated the benefits of ethanol blending through substantial foreign exchange savings and the creation of a robust domestic ethanol industry. Higher



ethanol demand can provide farmers with additional income opportunities by expanding the market for

sugarcane and maize. The decision to price E85 at a discount to conventional petrol could make it a good option for consumers using compatible vehicles, even after accounting for its relatively lower fuel efficiency. Yet optimism must be tempered with realism. Automobile manufacturers have expressed apprehensions about engine compatibility, corrosion, fuel systems and long-term durability. These issues deserve serious attention rather than outright dismissal. Without clear communication, there is a genuine risk of widespread confusion, misfuelling (putting the wrong type of fuel into a vehicle) and misplaced scepticism. Infrastructure, vehicle readiness, fuel quality standards and technical training must evolve alongside fuel availability. There is a need to recognise that biofuels are not an immediate replacement for fossil fuels. Preparedness, transparency and stakeholder collaboration — not haste — will determine whether E85 becomes a successful model or a missed opportunity.

## More power to women in khaki

Tamil Nadu's all-women police task force raises the bar; Punjab also on the right track

TAMIL Nadu Chief Minister C Joseph Vijay recently inaugurated an all-women police unit called the Singappen Special Task Force, aimed at ensuring the safety of women and children in his state. That was a promise he had made during electioneering after he formed the TVK (Tamilaga Vettri Kazhagam). He has decided that Singappen would be supervised by him. Most chief ministers keep the Home portfolio in their own hands. This is not surprising as the police are the most visible agency of the government on the street; the image of the party in power depends a lot on how the cops behave in their daily interaction with the people they have sworn to serve. Vijay has taken a resolute step forward. He has appointed a woman IPS officer, K Bhavaneeswari, to head the all-women unit and ordered that she report to him. That arrangement may not turn out to be practical, but the initiative is bound to send the desired message: the safety of women and children is of utmost importance to the CM and he is going to ensure that they go about their business without constantly looking over their shoulders. In my city of Mumbai, the police have evolved the "Didi" project. Female cops are specifically designated as "Didis" in every police station's jurisdiction to keep in touch with school authorities and monitor the safety of children from the moment they leave their homes to the time they return. Kids travelling in school buses are vulnerable to sexual harassment. The antecedents of bus drivers and conductors, besides toilet attendants and janitors in schools, need to be verified before they are employed. The safety of women on the street is another problem altogether. As a trustee of the Public Concern for Governance Trust (PCGT), I was in contact with another NGO that had been involved in this work for several years. We joined forces and were successful in getting many



spots in the city identified and equipped with better street lighting, to begin with. That experience was enough for us to realise the magnitude of the problem. The incidence of misbehaviour with women has increased exponentially in the last few decades. It is difficult to put your finger on the exact causes of this phenomenon, but what is certain is that we need to sensitise young men about the importance of respecting their mothers, sisters and daughters, and to extend this respect to all women. While it will be interesting to keep track of the Singappen project, the fact that women police officers in Punjab are leading major

operations against criminals is another heartening trend. Some of them are involved in the anti-gangster drive ("Gangstran Te Vaar"). Pragma Jain, Assistant Inspector General of Police (AIG, Law and Order) and former Faridkot SSP, believes that gender has nothing to do with the roles she has been asked to perform. "Policing is about competence, courage and commitment," she says. I agree with her completely. Much depends on the police leaders. If they can take all their juniors along to achieve various goals, their gender, religion, caste or economic status become irrelevant. The

leaders need to be honest, fair and just in their dealings with the public as well as their subordinates. Are women better than men in policing? I don't think so. It all depends on individuals. I have come across outstanding women and men at different levels of the police force. I have also seen laggards in both genders. Even corruption has affected both of them. Much depends on those in the top echelons. Both male and female personnel will look up to them. If the leaders are persons of integrity and willing to lead from the front, they can transform the outlook of the personnel entrusted to their care. There are some physical differences between men and women that have to be considered. For example, an all-out lathicharge should be assigned to men. Most other qualities required for getting a job done, like integrity, fair play, initiative and commitment, are common to them. The Punjab Police have found that women are more open to sharing information about wrongdoers in their locality with police officers of their own gender. This is to be expected. Similarly, a victim of molestation may not be keen to share details of the agony she has suffered with policemen, but would be more comfortable with policewomen. These realities should be kept in mind by police leaders who have to make on-the-spot decisions. I vividly remember an incident that happened decades ago. The late Jayawantiben Mehta, a feisty BJP leader from Mumbai, and others had blocked a key road prior to then Prime Minister Indira Gandhi's arrival. I was the DCP sent to clear the road. I tried to persuade Jayawantiben, but she was adamant. She insisted on dealing with women cops who, in those days, were not as numerous as they are today. I told her I did not have any policewoman with me and requested her to permit the PM to proceed. On the ground for making a racket to unsettle the protesters.

## CBI arrests military services engineer in bribery case

Shimla. (Agency)

The CBI has arrested KK Soni, Assistant Garrison Engineer with the Military Engineering Services (MES) in Manali, Himachal Pradesh, on Saturday for allegedly demanding and accepting a bribe of Rs 93,000 from a contractor's representative for clearing pending bills.



According to the CBI, a case was registered on July 3 based on a complaint filed by a supervisor who works with a contractor's firm. The complainant alleged that Soni had demanded Rs 93,000 to clear the firm's bills. While the supervisor allegedly paid Soni Rs 40,000, he said that he was asked to bring the remaining Rs 53,000 on Saturday, according to the complaint. On July 4, the CBI laid a trap and caught the accused red-handed. The agency also recovered Rs 40,000 from the accused's residence in the MES area of Manali. Officials said the search operation is on, and added that Rs 10 lakh in unaccounted cash was recovered from the premises. The accused will be produced before the court on July 5. Further probe is on, police said.

## 15 districts in Andhra Pradesh reel under deficient rainfall

VIJAYAWADA. (Agency)

Andhra Pradesh is confronting a deepening monsoon crisis as 15 districts reel under deficient rainfall and reservoir storage has fallen sharply, raising concerns over kharif cultivation, irrigation, drinking water supply and hydropower generation. The state has received 73.8 mm of rainfall against the normal 100.6 mm between June 1 and July 4, registering an overall 26.6 percent rainfall deficit, while water storage in major and medium reservoirs remains significantly lower than the corresponding period last year.

The prolonged dry spell has slowed progress of the southwest monsoon across large parts of the state, reducing inflows into reservoirs and increasing pressure on available water resources. With July being the most crucial month for the kharif season, officials are closely monitoring the rainfall situation and reservoir levels.

According to the latest APWRIMS data, 15 districts have recorded deficient rainfall, while NTR district is the only district to register excess rainfall, receiving 25.4 per cent above normal precipitation.

Districts witnessing severe rainfall shortages include Visakhapatnam (-50.4%), Alluri Sitharama Raju (-49%), Annamayya (-49%), West Godavari (-46%), East Godavari (-44.7%), Parvathipuram Manyam (-41.9%), Konaseema (-41.7%), Srikakulam (-39.7%), Tirupati (-36.8%), Chittoor (-34.9%), Polavaram (-34.4%), YSR Kadapa (-32.2%), Prakasam (-25.6%) and Vizianagaram (-25.4%), while another district also remained under the deficient category. Only a few districts, including Krishna, Eluru, Guntur, Bapatla, Kurnool, Nandyal, Anantapuramu, Sri Sathya Sai, SPSR Nellore.

## Teachers bear transport costs to educate tribal children in AP's Vizianagaram

VIZIANAGARAM. (Agency)

In a commendable effort to boost school enrolment among underprivileged children and prevent dropouts, government teachers in Vizianagaram district have gone beyond their professional duties to support tribal students by arranging free transportation. Spending from their own salaries, they have ensured that children from remote hamlets can attend school, significantly reducing absenteeism and dropout rates in region.

At Mandal Parishad Primary (MPP) School in Kapusompuram village under Kiltampalem Gram Panchayat, 55 students are enrolled, including 16 from hilltop hamlets Rayapalem, Munupurai and Ippamanvalasa, located up to six kilometres away, and 15 from Dabbagunta, 2.5 kilometres away. Until recently, these 31 children rarely attended classes due to the long walk and lack of public transport. To address this, the school's four teachers pooled resources to hire auto-rickshaws, spending Rs 5,000 monthly for one vehicle serving the hilltop villages and Rs 4,500 for another covering Dabbagunta. Together, they share the Rs 9,500 monthly cost, ensuring safe daily transport for the children.

In another initiative, Indukuri Ashok Raju, Headmaster of Mandal Parishad Upper Primary (MPUP) School at Tennuboddavara village under Mulaboddavara Gram Panchayat, has been spending Rs 2,000 monthly from his salary to provide transport for students from Mulaboddavara and Lachandorapalem.

## Mumbai floods: Roads shut, train, Metro services hit, red alert issued

With over 200-mm rain lashing pockets of the city in a span of 10 hours, traffic came to a standstill and people were left wading through knee-deep waters after the Mogra nalla and its associated drains overflowed in the western suburbs on Saturday afternoon.

Amid a red alert and high tide, torrential rain crippled life in Mumbai on Saturday.

With over 200-mm rain lashing pockets of the city in a span of 10 hours, traffic came to a standstill and people were left wading through knee-deep waters after the Mogra nalla and its associated drains overflowed in the western suburbs on Saturday afternoon.

The inundated streets nudged the Brihanmumbai Municipal Corporation (BMC) to enforce road closures across suburbs like Andheri, Vikhroli and Chembur.

In no respite from the downpour, heavy showers continued to sweep the Mumbai Metropolitan Region (MMR) on Saturday. The Met had issued a red



alert for Saturday.

Data from the weather department and BMC's automatic weather stations showed between 8 am and 6 pm, Vikhroli area received 247-mm rain, Powai logged 240 mm, 220 mm in Chincholi and 208 mm in Andheri. In the neighbouring district of Navi Mumbai, over 180 mm rainfall was recorded between 8.30 am and 6.30 pm

in Airoli, followed by 155 mm rain in Digha and 143 mm rain in Koparkhairme.

According to IMD records, the Santacruz station recorded 164 mm rainfall between 8.30 am and 5.30 pm on Saturday.

## CBI arrests former CFO of Reliance Capital in bank fraud case

The CBI has arrested Reliance Capital's former chief financial officer (CFO) Amit Bapna in connection with the investigation into the Reliance ADA Group cases.

Bapna, who served as the CFO of Reliance Capital Limited from August 2014 to December 2019, was one of the key decision-makers responsible for managing the company's financial affairs.

The CBI has so far arrested six accused, including Bapna, in the bank fraud cases linked to Reliance ADA Group.

Bapna has been lodged in Tihar Central Jail since April this year after being arrested by the ED in connection with a bank loan



fraud and money laundering case linked to Reliance Home Finance Limited (RHFL) and Reliance Commercial Finance Limited (RCFL).

The CBI obtained Bapna's production warrant from a Mumbai court and secured his custody from the Tihar Jail. He was

produced before the CBI Special Court in Mumbai on Saturday and remanded in the agency's custody for four days. Bapna has been accused of facilitating and approving loans to intermediary and conduit companies despite being aware that such lending was against the RBI guidelines and the sanction conditions governing borrowings from public sector banks. The funds borrowed by RCFL were allegedly diverted through intermediary entities to various Reliance ADA Group companies, including Reliance Capital Ltd, Reliance Infrastructure Ltd and Reliance Power Ltd, thereby causing wrongful loss to the lending banks and corresponding wrongful gain to the accused persons and related entities, said a release issued by CBI.

## A 'supari' from ex-employer in Fiji: Two men who shot at Vadodara trader arrested

The June 26 firing on garment trader Ashish Kumar, who was shot in his moving car on Waghodia Road here, was the result of a contract killing plot allegedly hatched by his former employer based in Fiji, police said on Saturday.

The crime was executed after over two months of surveillance, rehearsals and cross-country travel, police said after announcing two arrests in the case.

Vadodara Range inspector general Sandeep Singh said the conspiracy was allegedly orchestrated by Jay Dayal, one of Kumar's former employers, who convinced his employee, Vikram Pratap Singh, to return to India and eliminate Kumar.

Kumar and Dayal had a long-running financial dispute. Vikram Singh,



meanwhile, is an electronics engineer from Durg, the IG added.

Police said Vikram arrived in New Delhi from Singapore on April 20 and got in touch with co-accused Gurjeet Singh to begin preparations for the hit.

Over the next two months, the duo allegedly made repeated trips to Vadodara, watched Kumar's movements, and identified

escape routes. Police said that the two accused went to unusual lengths to avoid attracting attention while in Vadodara. "During one visit, they watched a movie at Pooja Mall. Before they shot Kumar, they had watched another movie at Bansal Mall," Sandeep Singh said, adding that the actions reflected "the extent of planning and preparation involved in the conspiracy."

On the night of June 26, the men allegedly opened fire on Ashish Kumar's moving car near Waghodia Chokdi before disappearing into the night and beginning their journey back to Durg. Investigators reconstructed the trail through CCTV footage, train tickets, mobile phone data, and an image captured outside a medical store.

## Nine months after worker's death on duty, widow still awaits ESIC benefits as 'stress' query delays claim

Shobha's husband died during his night shift on October 23, 2025, and was declared

"brought dead" at Civil Hospital, Mohali.

Nearly nine months after her husband died while on duty, Shobha Devi is still waiting for the Employees' State Insurance Corporation (ESIC) to release dependent benefits to her family, with fresh official queries delaying the claim despite an earlier finding that his death qualified as an employment injury.

A resident of Gobindganj in Bihar's East Champaran district, Shobha's husband, Ram Nath Paswan (Insurance No. 1214222305), was employed with M/s Ocean Support and Industrial Services in Mohali. He died during his night shift on October 23, 2025, and was declared "brought dead" at Civil Hospital, Mohali. "My husband went to work but never returned home. It has been nine months, yet I have not received the benefits that our family is entitled to. Every time we hope for relief, another query is raised,"

Shobha Devi told The Indian Express. She said she sought legal help after receiving a June 18, 2026, letter from ESIC Assistant Director Harpal Singh stating that "stress due to routine cannot be treated as Employment Injury" and asking the employer to explain the reasons for stress, noting that Paswan had been working as a helper.

"I have now approached Advocate Jasbir Singh, who has agreed to fight my case without charging any fee. I only want justice for my husband's death," she said.

The latest query comes despite an investigation report prepared by the ESIC Branch Office, Mohali, on April 22, 2026, which found that Paswan was on duty from 10 pm to 6 am, fell ill around 11.40 pm, and died during the course of his employment. Based on witness statements, hospital records and the FIR,

the branch office concluded that the "employment injury stands confirmed" and treated the death as an employment-related accident.



Advocate Jasbir Singh argued that the department's latest query was inconsistent with the provisions of the law.

"Section 51-A of the ESI Act, 1948 presumes that any accident or death arising during the course of employment

is an employment injury. The law does not require an employer to medically establish the cause of stress. That determination rests on medical evidence," he said.

Questioning the department's approach, he added, "The worker died during duty. Asking the employer to explain the reason for stress when he was employed as a helper is difficult to justify."

When contacted, Assistant Director Harpal Singh said he was undergoing dialysis and was unable to comment on the matter.

Regional Director Deepak Malik said the corporation had sought information from the employer to establish a causal connection between the death and employment and would proceed in accordance with the law after receiving the required information.

# Delhi Gymkhana members move High Court over Centre's eviction notice

**Delhi Gymkhana Club members and staff have challenged the Centre's eviction notice in the Delhi High Court. The case pits a defence infrastructure claim against allegations of vague reasoning and denial of due process.**

**New Delhi.(Agency)**

Delhi Gymkhana Club members and staff have moved the Delhi High Court against the Centre's show-cause notice seeking their eviction from the club's premises on Safdarjung Road. The applications seek a stay on the operation of the notice and are listed for hearing before Justice Avneesh Jhingan on July 6. The fresh applications are part of a pending lawsuit filed after the Land and Development Office's May 22 order directed the colonial-era



club to return its land by June 5 "strengthening and securing on the ground of defence infrastructure". The

court challenge has been brought by club member Vijay Khurana and the Delhi Gymkhana Club Ltd Staff Welfare Association.

On June 29, the Land and Development Office under the Union Housing and Urban Affairs Ministry issued a show-cause notice to the club, asking why an eviction order should not be passed under the Public Premises (Eviction of Unauthorised Occupants) Act, 1971. The notice, issued by Estate Officer Bipin Kumar Singh, directed the club and all

persons concerned occupying the premises to submit their response by July 7 and appear for a personal hearing on the same day at 2.30 pm. The latest move came more than a month after the Centre told the Delhi High Court on May 26 that it would not take forcible possession of the 27.3-acre premises by June 5, though it said the land was required for "strengthening and securing defence infrastructure".

In his lawsuit, Khurana said the "vague and generalised reasons" of defence

infrastructure and security given by the Centre were a "sham". He alleged that the move was an "attempt to effect forced eviction" instead of following the due process of law.

The petition is stated to be supported by more than 500 members of the club. The dispute now centres on the Centre's move to reclaim the club's land and the challenge by members and staff, with the High Court set to hear the plea for a stay on the eviction notice on July 6.

## Suspecting Affair, Delhi Man Kills Wife With Battery, Consumes Poison, Then Tells Family

**New Delhi.(Agency)**

A 28-year-old man allegedly bludgeoned his wife to death with a battery after suspecting her of talking to someone on the phone, and later died by suicide after consuming poison in the Ranhola area, police said on Saturday. The incident came to light on July 2 when police received a PCR call regarding an attempted murder at Tilangpur Kotla village in Outer Delhi.

According to investigators, Vinay allegedly hit Nisha, 24, on the head with an Exide battery following a dispute. Police said after killing his wife, Vinay allegedly consumed aluminium phosphide. He then took their three-year-old daughter to his mother's rented accommodation in nearby Kotla Vihar Phase-I, about 150 yards from his rented room, where he confessed to his sister Priya that he had killed his wife and consumed poison, police said.

They said Priya rushed to the couple's room, found Nisha lying in a pool of blood, and alerted neighbours, who then informed police.

Vinay was taken to Sanjay Gandhi Memorial Hospital, where he was declared brought dead, they said.

Police said post-mortem examinations of both the deceased have been conducted and the bodies handed over to their family for the last rites. Police said after they found Nisha, lying critically injured with severe head wounds, they rushed her to Sanjay Gandhi Memorial Hospital, where doctors declared her brought dead.

Preliminary investigation revealed that Nisha had been married to Vinay for five years. The couple had a daughter around three years old and had been living as tenants in the area for the last six or seven months.

## East Delhi govt hospital floods; waterlogged OPD sparks political reactions

**New Delhi.(Agency)**

A spell of rain on Saturday reportedly led to waterlogging inside parts of the Outpatient Department (OPD) at Lal Bahadur Shastri (LBS) Hospital in east Delhi. Visuals circulating on social media showed water accumulated on the floor of a waiting area while patients and attendants looked on.

Images and a short video clip shared by local political representatives and other users appeared to show water entering the hospital premises, with seating areas partially submerged and people navigating through puddles. The incident was reported after a brief period of rainfall, though its exact duration could not be



independently verified.

Several elected representatives, including an MLA Kuldeep Kumar and a municipal councilor from Trilokpuri, shared the visuals online, criticising civic preparedness and hospital infrastructure. They alleged that even a short spell of rain was enough to disrupt basic services and raised concerns over patient safety at a government healthcare facility.

There was no official clarification on whether the waterlogging was caused by drainage blockage, infrastructure gaps or external flooding entering the premises.

A Trilokpuri resident, RK Gupta, said, "a few minutes of rain have already exposed how fragile the public health infrastructure is. This is just the start of the season. How will Delhi survive through the next month, if such a situation persists?"

## Ahead of first E20 protest, Team Bharat dares Delhi Police on protesters limit

**New Delhi.(Agency)**

A day ahead of the first protest against the "rushed implementation" of the Central government's E20 ethanol-blended petrol policy, organisers of the demonstration claimed that the Delhi Police had verbally permitted them to hold the agitation at Jantar Mantar but asked them to limit the number of protesters to 200.

Leading the protest scheduled for 2 pm on Sunday under the banner "Team Bharat against Ethanol scam", entrepreneur and TV personality Tehseen Poonawalla criticised the conditions imposed by Delhi Police and told India Today Digital that the demonstration would go ahead regardless of any restrictions. Poonawalla also said that he would be addressing a press

conference on Sunday and expose the "sham press conference" held on Saturday by auto experts defending the government's ethanol policy.

"We have got the permission verbally from Delhi Police. Strangely, Delhi



Police has asked us to limit the number of protesters to 200 only. I don't know how a police force in a democracy can dictate to citizens that a protest must be limited,"

Poonawalla told India Today Digital. Other members of Team Bharat told India Today Digital that the protest wasn't against the ethanol-blending policy but against its implementation and how car owners were being left without choice.

Poonawalla also warned of a stir outside Union Minister Nitin Gadkari's house if the Delhi Police resort to any "funny act" to try and "stop the protest". "In any case, we are protesting at Jantar Mantar irrespective of what the police say. We don't care. If they don't allow us to protest or act funny, we will sit in front of Nitin Gadkari's house," he said. Though Nitin Gadkari is the Union Minister of Road Transport and Highways, he is seen as the face of the government's ethanol-blended fuel campaign because of his support.

## Cops Trace Sources Of Rs 15 Lakh Transactions In Ram Temple Theft Case

**New Delhi.(Agency)**

The police have found new evidence in the theft of donations from the Ram Temple in Uttar Pradesh's Ayodhya. The details are linked to one of the accused, Avinash Shukla, whose transactions exceeded Rs 15 lakh. He sent the money to many people and also handed over cash to some. The police are investigating whether these funds were linked to the stolen donation money.

The investigation found Shukla gifted approximately Rs 2 lakh in cash and an expensive mobile phone to a woman friend. This, too, is under investigation. His brother, Abhishek, had frequently seen him carrying cash to a yoga centre after his shift, the police said.

He did not give a clear answer when his

brother asked him about the source of the funds. Later, when Abhishek asked another individual, Anukalp, about the source of the cash, he said the devotees gave money out of



happiness and also offered payments in exchange for assistance during the darshan. He also warned Abhishek not to bring up the subject again.

On July 3, the Special Investigation Team (SIT) probing the alleged

embezzlement of donations at the Ram Temple arrived at the temple premises to carry out further investigation in the case.

The state government on July 1 granted a 15-day extension to the SIT to complete its investigation. The extension has been given to enable the SIT to widen the scope of its probe and conduct a comprehensive inquiry into all aspects of the case.

An FIR was registered on June 25 after the SIT submitted the preliminary report on June 23, and eight accused were arrested. Subsequently, Champat Rai and former trustee Anil Mishra resigned, taking moral responsibility for alleged misappropriation of donations hours after the police arrested all eight people named in the FIR.

## Delhi temperature dips after rain, more showers for next few days

**New Delhi.(Agency)**

The national capital recorded a slight dip in maximum temperature on Saturday as light to moderate rainfall was witnessed in parts of the city and Noida. The weather office forecast similar conditions over the next few days. The city's base weather station, Safdarjung, recorded a maximum of 35.4 degrees Celsius, two degrees below normal and 0.4 degrees lower than Friday. The minimum temperature settled at 29 degrees Celsius, 1.1 degree below normal but 0.9 degrees higher than the previous day.

However, Safdarjung received no rainfall till 5.30 pm on Saturday, according to India Meteorological Department data. The Pusa weather station recorded 23.5 mm rainfall between 11.30 am and 2.30 pm, while Janakpuri received 9.5 mm during the same period.

Maximum temperatures also declined at other weather stations on Saturday. Palam recorded a maximum of 35.1 degrees Celsius, one degree lower than the previous day. Lodhi Road recorded a maximum of 35.2 degrees Celsius, 0.6 degrees less than Friday's maximum. Ridge and Ayanagar recorded maximums at 36.4 degrees and 34.6 degrees Celsius respectively, 0.5 and 0.7 degrees lower than Friday's. The IMD forecast light rain and gusts to continue at least till Friday.

"There is a possibility of very light to light rain, accompanied by thunderstorm, lightning and gusty wind with speeds of 40-50 kmph during the afternoon and evening in the coming days," an IMD official said.

According to the met department's forecast, the maximum may dip further and may settle around 32-34 degrees Celsius on Sunday. The minimum temperature is expected to be around between 27-29 degrees Celsius.

Meanwhile, the southwest monsoon advanced into some parts of Haryana and Punjab on July 1, the IMD said. Conditions are favourable for its further advance into the remaining parts of the two states over the next four days.

## Govt orders Meta to remove child abuse ads on Instagram, seeks reply in 7 days

**The Centre has issued a notice to Meta over paid Instagram ads allegedly promoting Child Sexual Exploitative and Abuse Material (CSEAM). MeitY has ordered the removal of such ads and content and sought a detailed explanation from the company within seven days, sources said.**

**New Delhi.(Agency)**

The government has issued a stern notice to Meta over the alleged presence of Child Sexual Exploitative and Abuse Material (CSEAM) in paid advertisements on Instagram, news agency ANI reported citing sources.

According to the report, the Ministry of Electronics and Information Technology (MeitY) has directed Instagram to immediately disable all advertisements and content that promote or facilitate access to CSEAM on its platform. The government has also sought a detailed explanation from Meta, asking the company to respond within seven days.

The action comes as part of the Centre's crackdown on the circulation and promotion of child sexual abuse

material online, with authorities seeking stricter compliance from digital platforms.

### BBC INVESTIGATION TRIGGERED SCRUTINY

The government's action follows a BBC Eye investigation that found Instagram displaying paid advertisements containing terms such as "rape video" and "child video", which allegedly redirected users to Telegram channels where child sexual abuse material could be purchased for as little as Rs 99.

According to the investigation, the advertisements had passed Instagram's moderation process before appearing on the platform.

### TEST ACCOUNT RECEIVED ILLEGAL ADVERTISEMENTS

The BBC said it created an alias Instagram

account in India after observing that the platform recommended sexually suggestive content even without users actively searching for it.

The account followed 10 profiles posting sexually suggestive content to study Instagram's recommendation system.



Within a week, it began receiving advertisements offering video calls and explicit sexual content. Days later, the account was shown advertisements

depicting children with adults in sexually suggestive situations, along with links to Telegram channels.

The investigation found around 30 unique advertisements allegedly promoting child sexual abuse material, some appearing through multiple advertiser accounts, in addition to about 20 advertisements featuring adult pornography.

### DISTURBING CONTENT IDENTIFIED

According to the BBC, one advertisement showed a boy and a girl, appearing to be around 12 years old, engaged in a sexual act. Another featured a man claiming to be 52 years old alongside a girl described as 12, urging users to click through to Telegram. The investigation also reported an advertisement

France captain Kylian Mbappe said his side proved they are much more than just an entertaining attacking team after grinding out a hard-fought win over Paraguay in the FIFA World Cup Round of 16, insisting Les Bleus are equally capable of winning a physical and scrappy battle if needed.

Speaking after France sealed their place in the quarter-finals, Mbappe said the team's display against Paraguay showed they could adapt to whatever the occasion demanded. "If we have to get our hands dirty, we'll do it," Mbappe said in the post-match interview. "They thought we'd come in tuxedos, playing pretty football with one-tos and attacking moves. But we know how to play ugly football too. We did that today, we won, and even in that kind of game we were better than them." Paraguay vs France, FIFA World Cup 2026 Round of 16: Highlights | Report Paraguay turned the knockout clash into a scrappy affair, repeatedly trying to break France's rhythm and draw the players into



confrontations. Mbappe, however, said the French squad had anticipated exactly that kind of contest. "We knew the kind of match we were going to have. Today we showed that we're not just a team that knows how to play attacking football."

**"BEAT THEM AT THEIR OWN GAME"**

The Real Madrid forward also brushed aside Paraguay's attempts to unsettle France during the closing stages of the match, saying every team has its own way of competing.

"That's their football. That's the way they play," Mbappe said. "Everyone uses the weapons they have. There's no right or wrong way to play football. There's only one way, and that's to win." "They tried to beat us that way, but we beat them at their own game." France eventually came through one of their sternest tests of the tournament to move into the last eight, showing a side of their game that has often been overshadowed by their attacking quality.

**MOROCCONEXT**

France will now take on Morocco in the quarter-finals, with the tie set to pit Mbappe against close friend and former Paris Saint-Germain teammate Achraf Hakimi. Mbappe revealed Hakimi may have already reached out after the match but said friendships will be put on hold once the two teams step onto the pitch.

**Mbappe settles battle of wills as France edge resilient Paraguay into quarters**

Philadelphia, (Agency)

Kylian Mbappe eventually found the one moment Paraguay could not survive.

For 70 minutes, France's talisman was kicked, crowded, wrestled and frustrated as Paraguay turned their World Cup Round of 16 clash into an attritional battle fought as much through grit as quality. The South Americans, fresh from their penalty shoot-out upset over Germany, arrived with little interest in matching France's star power and every intention of disrupting it. They succeeded for long stretches, but when substitute Desire Doue burst into the penalty area and was brought down by Diego Gomez, Mbappe stepped up to settle the contest from the spot. His coolly taken penalty secured a hard-fought 1-0 victory in searing 38°C heat, sending Didier Deschamps' side into a



quarter-final against Morocco while ending one of the tournament's most spirited underdog stories. It also took Mbappe to seven goals at the tournament, drawing him level with Lionel Messi in the race for the Golden Boot. STAR-STUDDERED STALEMATE

France arrived boasting arguably the most feared attacking quartet left in the competition. Mbappe, Ousmane Dembele, Michael Olise and Bradley Barcola had dismantled Sweden in the previous round, and the expectation was that Paraguay would be the latest side to fall victim to Les Bleus' attacking firepower. Instead, Gustavo Alfaro's men produced one of the defensive performances of the tournament. Happy to concede possession, Paraguay retreated into a compact defensive shape, crowding central areas and forcing France into harmless circulation of the ball. Mbappe was rarely afforded space to run, Dembele found himself double-marked, while Olise's clever movement was repeatedly met by a wall of white shirts. The statistics at half-time underlined Paraguay's discipline. France had enjoyed more than 80 per cent possession but failed to register a single shot on target, producing an expected goals figure of just 0.15.

**England Women are flying, but can they break the Australia hoodoo in final?****Women's T20 World Cup, AUSW vs ENGW: Nat Sciver-Brunt's England and Sophie Molineux's Australia will lock horns in the blockbuster final on Sunday, July 5, at the iconic Lord's Cricket Ground.**

England could hardly have asked for a better build-up to the ICC Women's T20 World Cup final. Seven wins from seven matches, dominant performances with both bat and ball, and a place in the title clash at Lord's have established them as one of the standout teams of the tournament. Yet, standing between them and history is a familiar foe - Australia. For all of England's resurgence under Charlotte Edwards, the final presents a psychological hurdle that has haunted

generations. England have never beaten Australia in a Women's World Cup final, losing all six previous meetings across the ODI and T20 World Cups. Three of those defeats came in the 50-over showpiece (1988, 1997 and 2022), while Australia also got the better of England in the 2012, 2018 and 2023 Women's T20 World Cup finals. That daunting record makes Sunday's clash about far more than simply lifting the trophy, it is an opportunity to finally end the Australia hoodoo. Australia, however, have once again shown why they remain the benchmark in women's cricket. The defending champions are unbeaten heading into the final after sweeping through the group stage before brushing aside West Indies in the semi-finals. England have matched that flawless run, defeating every opponent in their path and sealing their place in the final with a commanding 40-run win over South Africa. With both teams yet to suffer a defeat, the tournament has built towards the blockbuster final everyone had hoped for.

**BATTLE BETWEEN TWO FLAWLESS CAMPAIGNS**

England have looked the most complete side in the competition. Their batting has clicked



consistently, while a disciplined bowling attack has strangled opponents throughout the tournament. They began their campaign with an emphatic 87-run win over Sri Lanka before overcoming Ireland, Scotland, West Indies and New Zealand in the group stage. The semi-final against South Africa further

underlined their resilience as Nat Sciver-Brunt and Heather Knight rescued England from 23 for 3 with a match-winning 133-run partnership before the bowlers wrapped up a comprehensive 40-run victory.

Australia's campaign has been equally ruthless. Comfortable victories over Bangladesh, Netherlands, Pakistan and India in the group stage were followed by an emphatic eight-wicket win over West Indies in the semi-final. Their depth has once again set them apart from the rest of the field, with different players stepping up in every match and ensuring there has been little drop in standards, regardless of the situation.

**AUSTRALIA'S DYNASTY MEETS ENGLAND'S DREAM**

Australia enter the final chasing a seventh Women's T20 World Cup title, having already won the tournament in 2010, 2012, 2014, 2018, 2020 and 2023. Victory at Lord's would also hand them a remarkable 14th women's world title across the ODI and T20 World Cups, further cementing one of the greatest dynasties in international sport.

Kylian Mbappe's match-winning penalty sent France into the FIFA World Cup quarter-finals on Sunday, July 5, but the final whistle brought with it an ugly flashpoint involving Paraguay goalkeeper Orlando Gill. Moments after France secured a hard-fought 1-0 win in the Round of 16, Gill walked towards Mbappe to congratulate him with a handshake. The France captain, still celebrating, appeared to ignore the gesture and walked past the Paraguayan

goalkeeper. Frustrated by the snub, Gill threw the match ball at Mbappe's back before walking away. Mbappe did not react to the incident and continued celebrating



France's progression, ensuring the confrontation did not escalate further. The incident quickly drew attention after a fiercely contested encounter in which Paraguay had spent 90 minutes trying to unsettle the two-time world champions.

**FIFA WORLD CUP: FRANCE EKE OUT TOUGH WIN**

France knew they were unlikely to enjoy a straightforward evening against the South

Americans, who defended deep, disrupted the rhythm of the game with frequent fouls and looked to drag Didier Deschamps' side into a physical battle in sweltering conditions. Mbappe eventually settled the contest in the 70th minute, calmly converting a penalty after Desire Doue's driving run into the penalty area forced Diego Gomez into a clumsy challenge. The referee initially waved play on before awarding the spot-kick following a VAR review. The goal was Mbappe's seventh of the tournament and the 19th of his World Cup career, drawing him level with Lionel Messi in the race for the Golden Boot while moving him within one goal of the Argentine's all-time

World Cup scoring record. "It wasn't easy. They used every trick in the book," France coach Didier Deschamps said after the match. "It is not the kind of football that will bring people to the stadium, but they defended well. It is always difficult against these South American teams." Mbappe echoed his coach's assessment, insisting France had expected exactly this kind of contest.

**I'd rather be us than them: Jesse Marsch defiant despite Canada's World Cup exit**

Canada's FIFA World Cup 2026 journey came to an end with a 3-0 last-16 defeat to Morocco in Houston on July 4, Saturday, but head coach Jesse Marsch refused to let the scoreline overshadow his team's performance. The Canadian boss said he would "rather be us than them," insisting his players stayed true to their attacking identity despite Morocco's clinical second-half display. The result sends Morocco into a quarter-final against either France or Paraguay as they continue their bid to match or better their historic semi-final run from the 2022 World Cup in Qatar.

"We went after the game. We didn't play defensively. We showed we can be better," Marsch said after the defeat. "Of course, we have to be in these situations more and more, and then we have to find ways to succeed. But what a great team. I'd rather be us than them, as good as Morocco is. I'm really proud

of our guys. They're hurting right now, but my goodness, I couldn't be prouder. Canada, thank you. I thank Canada." Canada started



brightly in Houston and forced Morocco goalkeeper Yassine Bounou into two important early saves through Jonathan David and Tani Oluwaseyi. However, Morocco took control after the break as

Azzedine Ounahi scored twice before substitute Soufiane Rahimi sealed a 3-0 victory in stoppage time.

Despite the scoreline, Marsch focused on the progress Canada had made and the identity his side displayed against one of the tournament favourites. Reflecting on Canada's performance, Marsch added: "In the biggest games, in the biggest moments, it's about how much we can be ourselves, how much belief we can show and how much we can put the game on our terms. We did that. We had 11 incredible performances in the first half. We were unlucky not to take the lead. Then it's the fine details. They have quality and players who compete at the highest level, but in terms of how we played and sticking to who we wanted to be, it was an incredible performance."

close game that got out of hand late. the second T20I, India head coach Gautam Gambhir was seen having a long conversation with Samson. Gambhir appeared to console the batter, holding his hand as the two spoke following the selection call. SAMSON'S STRING OF POOR SCORES

Samson did not leave the Indian team management with many options. The opener failed to reach double figures in each of his last three T20I innings on the tour of the United Kingdom. After scores of 0 and 5 in India's historic series defeat against Ireland, Samson managed just one run off seven balls in the first T20I against England. With fans increasingly calling for Vaibhav Sooryavanshi's inclusion, the management eventually made the change. Samson's omission paved the way for the 15-year-old to make his international debut. Vaibhav scored 14 off 10 balls in his first outing for India.

## Govt raises ONGC chairman entry age to 59, offers up to five-year tenure

New Delhi.(Agency)

The government has relaxed the eligibility conditions for appointing the next chairman of state-owned ONGC by raising the maximum entry age to 59 years and offering the successful candidate a fixed three-year term extendable by up to two years, widening the pool of eligible contenders to head India's largest oil and gas producer. The Public Enterprises Selection Board (PESB), the government's headhunter for appointments to state-run firms, has invited applications for the post, which will fall vacant on December 7 when incumbent Arun Kumar Singh completes his extended tenure.

Under the Oil and Natural Gas Corporation (ONGC) advertisement, candidates should not have attained the age of 59 years on the date of occurrence of the vacancy -- December 7, 2026. The selected candidate will initially be appointed for three years, with the tenure extendable by another two years after a performance review. Any employment or extension of tenure beyond the age of 60 shall be on a contract basis," the advertisement said. The selection will be made by a search-cum-selection committee constituted by the oil ministry instead of the normal PESB selection process. The revised age limit marks a departure from the norms followed for most board-level appointments in Central Public Sector Enterprises (CPSEs). While recent appointments have largely been governed by a residual service criterion rather than fixed age limits, the advertisement prescribes a maximum entry age of 59 years, allowing both internal and external candidates who would otherwise have been ineligible to be considered. The tenure conditions are also a departure from the prevailing practice of appointing PSU chiefs until the age of superannuation, which is generally 60 years.

Under the revised framework, a chairman may continue beyond that age on a contractual basis. The government had made a similar relaxation when appointing Singh in 2022.

## Tata Steel aims to spend 20,000 cr in FY27 on expansion, technology

NEW DELHI.(Agency)

Tata Steel is looking to spend around ₹20,000 crore as capex in the current financial year and a major share of it will be spent to support the India business, the company's management said.

The capex for the ongoing FY27 will be around 38 per cent higher from ₹14,559 crore that Tata Steel has spent on capital expenditure in the preceding 2025-26 financial year. "In FY26, we spent ₹14,559 crore on capital expenditure, and we plan to increase this to approximately ₹20,000 crore in FY 2026-27, with 60 per cent allocated to India," said Tata Steel's CEO & MD T V Narendran, and Koushik Chatterjee, the company's Executive Director & Chief Financial Officer. The management made the statement in reply to a question related to Tata Steel's capex plans and long-term growth strategy.

They said the capital allocation strategy for FY27 focuses on a balanced mix of sustenance projects, ongoing investments in value-added downstream and infrastructure projects, new technologies, and long-term growth projects, with a clear emphasis on India. "This includes expansions in tinplate and wires, the HRPGL (Hot Rolled Pickling & Galvanising Line) facility at Tarapur, and the Coke Ovens project at Jamshedpur. In addition, we are continuing to invest in mining, a stronger supply chain and sustainability of operations," the company officials said.

## SEBI share buyback: Open market operations to resume from August 1; will you benefit?

**Sebi has decided to resume open market share buybacks from August 1. As a result, listed companies will now be able to buy back their shares through tender offers as well as through stock exchanges. The decision of the regulator will provide companies with greater flexibility. It will also provide investors with an additional option to sell shares.**

Sebi has taken a momentous decision regarding share buyback. As a result, there could be a big shift that could trigger a wave of cash distribution on Dalal Street. In a landmark board meeting, market regulator Sebi (Securities and Exchange Board of India) officially approved the reintroduction of open market share buybacks through stock exchanges from August 1, 2026. This not only constitutes a reversal of phasing out of open market buybacks in early 2025 but will also boost the interest of investors. Analysts have pointed out that SEBI's latest move is designed to inject immense flexibility into how India industry manages surplus cash. What does this mean for the everyday investor, and perhaps more important, how does it benefit investors with a payday? Let's

have a look at the implications and policy reversal in detail.

**New SEBI open market buyback rules** Since earlier open market buybacks were described as slow and opaque, the market regulator has completely overhauled the framework to inject efficiency and investor protection. Companies must wrap up the entire buyback process within 66 working days

**Who will benefit the most?**

## Decision to drop Adani charges not tied to planned investments: US DOJ

NEW DELHI.(Agency)

The US Department of Justice has denied that its decision to drop criminal charges against Indian billionaire Gautam Adani and seven others was linked to the Adani Group's plans to invest about \$10 billion in the United States, saying the prosecution was legally unsustainable and should never have been brought. In a filing, responding to a federal judge's demand for a fuller explanation, Principal Associate Deputy Attorney General R Trent McCotter rejected media reports suggesting the dismissal was influenced by the conglomerate's investment plans. "The current or former

Department attorneys... have suggested that I sought dismissal of the securities charges at least in part because of some promise by those defendants to invest money in the United States. That is false," McCotter wrote.

I would have sought dismissal of the securities charges regardless of any mentions of investments," he added, saying he had already concluded that the case should be dropped before the issue was ever raised. "The mention of potential investments could not have played any role." Reports in US media had linked the DOJ decision to drop charges altogether to Adani hiring a new legal team led by Robert J Giuffra Jr, one

The stock has offered investors a return of 1008% in the last five years.

The need of semiconductors can hardly be overestimated. They are used as needed in cars, mobile phones, computers, defense equipment, the artificial intelligence sector, data centers and many other sectors advanced technologies. The global chip crisis during the pandemic demonstrated the importance of domestic chip manufacturing for any country. Consequently, India is rapidly increasing its investment in this sector. Experts have pointed out that the sector can grow fast and the government could take steps such as single window clearances for investments in this sector.
