DKS' 100-day milestone: Karnataka CM to meet guarantee beneficiaries on September 10

KOPPAL. (Agency)

Chief Minister DK Shivakumar's government is set to complete 100 days in office on Thursday. To mark the milestone, the CM will hold a town hall meeting with beneficiaries of the Congress government's flagship guarantee schemes at Vidhana Soudha on Thursday morning.

Sources in the government said the CM is likely to talk about various initiatives taken by his government and also outline his vision for the next 500 days. After taking over as CM, Shivakumar hit the ground running from day one and took several new initiatives, despite the government facing several shortcomings.

While implementation of five guarantee schemes rolled out during Siddaramaiah's tenure as CM remained the key focus, the new government under Shivakumar's leadership is also emphasising infrastructure projects, sources said. To ensure that the administration is responsive and bureaucratic delays are eliminated, the Shivakumar government launched the Praja Seva Department.

BJP chief Nabin says India's youth are with Modi, turning from job-seekers to job- creators

BJP national president Nitin Nabin on Wednesday asserted that the country's youth are with Prime Minister Narendra Modi. He said young Indians are participating and contributing across various fields, moving beyond being merely job-seekers to becoming job-creators through start-ups and unicorns. Speaking to the media at the BJP's central office, Nitin also highlighted the transformation and development work being carried out in villages located along the country's borders. "There was a time when border villages were referred to as the last villages of India. PM Modi changed that narrative and called them the first villages of India. This has not only transformed the lives of people residing in those villages along the borders but also changed the way people think about these villages and the communities residing there," Nabin claimed.

Taking a dig at the Opposition, he said the country's youth, once immersed in an atmosphere of despair, are now breaking records under the leadership and support of PM Modi. "It is happening since PM Modi, who, since 2014, took up the task of placing the youth in an environment of hope and optimism", he said. Highlighting the work done towards the eradication of Naxalism, Nabin further said that every Indian is now progressing with dignity and that Naxalism has been almost eradicated.

The milestone spans his years as Chief Minister of Gujarat, a post he took charge of on October 7, 2001, and his subsequent tenure as Prime Minister of India.

The campaign, titled "Sewa Sankalp Abhiyan," was formally announced at the party headquarters by BJP National President Nitin Nabin, in the presence of senior leaders Vinod Tawde and Anil Baluni. It will run from September 17 to October 17. Nitin Nabin while addressing media told that the initiative is meant to reflect the Prime Minister's own commitment to public service, and said

Build 1,000-acre administrative city outside Chennai: NDA ally Ramadoss to Vijay

PMK chief Anbumani Ramadoss has opposed the Vijay government's plan for a new Secretariat at Pattinapakkam. He says a larger administrative city outside Chennai would avoid congestion and meet long-term needs.

PMK president Anbumani Ramadoss on Wednesday urged the Tamil Nadu government to drop its reported plan to build a new Secretariat complex at Pattinapakkam in Chennai. Instead, he called for an integrated administrative city spread across 500 to 1,000 acres outside the state capital to meet the government's needs for the next 100 years. In a statement, Anbumani said a modern Secretariat was needed, but argued that locating it at Pattinapakkam would create serious traffic and space problems. He said the government should look at a larger, self-contained site rather than a limited urban plot. Reacting to media reports, he said the proposed Rs 1,200 crore Secretariat and



Legislative Assembly complex, measuring 20 lakh square feet and announced by Chief Minister C. Joseph Vijay, was likely to come up on a 26.36-acre parcel in Pattinapakkam. He described the move as "shortsighted". "While the need for a modern Secretariat in Tamil Nadu is beyond dispute, establishing it

at Pattinapakkam will cause more harm than good," the PMK leader said.

Referring to Vijay's stated vision that the new complex should serve the state's needs for the next century, Anbumani said global and historical examples favoured shifting administrative hubs to dedicated greenfield locations. He urged the government to acquire at least 500 to 1,000 acres outside Chennai for a self-contained administrative city. He said such a township should include the Secretariat, the Legislative Assembly, departmental headquarters, residences for the Chief Minister, ministers and civil servants, along with Metro connectivity, helipads, schools, colleges, sports arenas and commercial complexes.

Jolt To Jagan Reddy Ahead Of Civic Polls, Key Leader Switches To TDP

The defection of Vizianagaram Zilla Parishad Chairman and former YSRCP district president Majji Srinivasa Rao, popularly known as Chinna Srinu, to the TDP has given the ruling party a potentially valuable organisational boost in North Andhra ahead of the state's local-body elections. Srinivasa Rao and his daughter, Siri Sahasra, joined the TDP late on Tuesday in the presence of Chief Minister Chandrababu Naidu in Amaravati. The move is politically significant as Srinivasa Rao was regarded as a key YSRCP organiser with a close working relationship with party president YS Jagan Mohan Reddy.



He is also a close relative of senior YSRCP leader and former minister Botsa Satyanarayana. Srinivasa Rao joined active YSRCP politics in

2015 and subsequently became the party's Vizianagaram district president and Zilla Parishad chairman. His exit therefore represents more than the loss of just another party functionary. It raises questions about whether his district-level political network and supporters will follow him into the TDP.

The timing is significant. Andhra Pradesh's local-body elections are expected later this year, with the Election Department indicating that the process is to be completed by October, subject to the election authorities' schedule. The YSRCP has been seeking to make the local polls a test of grassroots strength and a political battle between its organisation and the ruling TDP-led.

'Ready to give up' reservation if casteism ends, says Union minister Ramdas Athawale

Union minister Ramdas Athawale on Wednesday said opposing reservation was against the Constitution and asserted that if casteism ended, "we are ready to give up reservation".

Opposing reservation is not right, the Minister of State for Social Justice and Empowerment told reporters at Swami Vivekananda Airport here after arriving for a day-long visit to Chhattisgarh.

Asked about ongoing debates in parts of the country over reservation, including demands for its removal or amendment, Athawale said the policy was introduced to strengthen the country by providing opportunities to weaker sections.

"When casteism ends, we are ready to give up reservation," said the minister, a prominent Dalit leader who heads the Republican Party of India (A).

Reservation for Scheduled Castes and Scheduled Tribes was provided when the Constitution came into force in 1950, while reservation for Other Backward Classes was introduced during the V P Singh government in 1990-91, he noted.

The Narendra Modi government later introduced 10% reservation for Economically Weaker Sections among those not covered under the SC, ST or OBC categories, he said.

"Reservation is based on caste. Although the Constitution abolished untouchability under Article 17, atrocities against Dalits and tribals still take place. Reservation should continue until casteism is eliminated," Athawale stated.

"If you can end casteism, we are ready to give up reservation. But opposing reservation is not right. It is against the Constitution," he added. Athawale said those opposing reservation should engage in dialogue and put forward their demands.

Dalit man's suicide rocks Punjab

Rahul Gandhi seeks minister's exit, CM hits back

The suicide of a Dalit daily wage earner in Punjab's Sangrur has triggered a massive political storm, with the Congress and BJP coming down heavily on the AAP government with leaders, including Rahul Gandhi, alleging he was humiliated and subjected to caste abuse for questioning Finance Minister Harpal Singh Cheema about the drug menace. Chief Minister Bhagwant Mann mounted a defensive response, accusing the opposition of playing politics over the death. Gulzar, 47, died on Monday night after allegedly consuming poison. His family has alleged that he was pressured to apologise and abused with casteist slurs after he questioned Cheema at an event on September 6 over the "unabated" supply of drug in his area. Rahul Gandhi, in a social media post, launched a pointed attack on the

With just months to go before the Punjab Assembly elections, the suicide of a Dalit man who questioned a minister over the drug menace has rocked state politics.



Mann government, calling the incident part of a "dangerous pattern" and seeking the

dismissal of Minister Cheema. Gandhi alleged that the Dalit community member was "tortured and humiliated" for simply asking the Finance Minister, "why has the government failed so miserably in stopping the drug trade".

"The government's job is to answer to the people, not to crush those who ask questions. May Gulzar Singh ji's family get justice as soon as possible. The Chief Minister should immediately demand the Finance Minister's resignation and ensure an independent and impartial investigation, with his name registered in the FIR," Gandhi wrote on X. The Congress MP also posted a video of Gulzar's final moments, in which he is heard questioning Cheema about the availability of 'chitta', a term commonly used to refer to heroin, in the area and saying that his son was also consuming the drug. He also allegedly held the village sarpanch responsible for his death.

Punjab MP Raghav Chadha's Name Added To Delhi Voter List

BJP Rajya Sabha MP from Punjab Raghav Chadha's name has been added to the voters list of Delhi currently being revised under the ongoing Special Intensive Revision (SIR) of the national capital's electoral rolls, poll officials said on Tuesday.

AAP leaders, in a press conference, raised the issue and alleged that Chadha's name was included in the electoral rolls of the Rajinder Nagar Assembly constituency without following the due procedure. Poll officials said that Chadha's name was added to the electoral rolls of Delhi through the updation process. His name was removed from the rolls of Punjab, from where he was sent to the Rajya Sabha by his previous party AAP.

"A total of 700 forms for inclusion of names in the electoral rolls were approval by the electoral registration officers (EROs) in 70 Assembly constituencies in Delhi till Tuesday. Chadha's name was among them," said an official at the office of Delhi Chief Electoral Officer. The electoral roll of Delhi was frozen on June 16 for the preparation of SIR and remained in the frozen state till August 31, when the draft electoral rolls were published, said a Delhi CEO statement. During this period, approximately 2.14 lakh Forms-6 for new voters (besides Form-7 and 8) were submitted by the electors.



PhD scholar’s death: FIR against girlfriend, friend for abetment

An FIR for abetment to suicide was registered against a PhD scholar’s girlfriend and a mutual friend, days after the 24-year-old Delhi University student allegedly died by suicide in Siddharth Vihar. Police said the family told them he used to speak to the two women for hours on the phone. The Jodhpur resident, pursuing a PhD at DU’s Deshbandhu College, allegedly fell from the 27th floor of a high-rise on Aug 25. He was staying with relatives at a third-floor flat in Prateek Grand since Aug 18.ACP (Kotwali) Upasana Pandey said the scholar’s uncle, Pramendra Kumar, approached police and submitted a suicide note written by the student. An FIR was then registered at Vijay Nagar police station against his girlfriend and a mutual friend under BNS section relating to abetment of suicide. “A few days ago, the uncle came with a note and submitted it at Vijay Nagar police station. The note stated, ‘main mar raha hu apni marzi se, kisi ka name nahi lunga’ (I am ending my life by my own choice; I will not take anyone’s name),” Pandey said. She added that the family told police the scholar would speak to both women for hours. “We have applied for call details of the victim and are investigating the matter,” she said.A senior police officer said the scholar’s phone had been recovered and sent for forensic examination. The family also told police that on the day of his death, he spoke on the phone for several hours and stepped outside the flat while talking to someone.Vijay Nagar SHO Dharam Pal Singh said police were examining CCTV footage provided by the society. Footage showed the scholar walking towards the stairs on the third floor around 7pm before taking a lift to the 27th floor.

Six in police net for bike theft, mobile snatching

Noida.(Agency)

Six persons were arrested on Tuesday during a crackdown on gangs involved in bike thefts and mobile phone snatching, police said, adding that 16 stolen two-wheelers, 16 mobile phones, a lock-breaking tool, a country-made pistol, several knives and Rs 5,000 in cash were recovered after their arrests. A juvenile was also detained in the operation. Police conducted three operations in different parts of the city to trace the accused. In Sector 28, three men — Mannu Kumar (19), a motorcycle mechanic, Naved Khan (32), who works in a mobile repair shop, and Ashu Kumar (20) — were arrested. According to police, Mannu and Ashu would steal bikes, then use the stolen two-wheelers to target pedestrians and snatch their mobile phones. They would sell the stolen phones to Naved, who would strip them of their parts and sell them separately.Two motorcycles, one without a number plate, and 14 phones were recovered from them. All three have had cases registered against them previously in Noida, Delhi and Bulandshahr.In a separate operation, police arrested a 19-year-old and detained a juvenile from near Heart Beat City. Two mobile phones and a pistol were recovered from them. Police in Badalpur said they busted an interstate two-wheeler theft gang with the arrest of two men, Saif Ali and Shadab.An officer said the two chse the place from where they were going to steal the bikes after several reconnaissance missions. Afterwards, they kept the stolen vehicles in vacant plots and sold them off to passers-by at low prices.A total of 14 two-wheelers — 13 motorcycles and one scooter — were recovered after their arrest.

Leopard Trail in Gurgaon to get 1-acre revived waterbody, butterfly park

The forest department is giving the city’s Leopard Trail a nature-focused makeover, with plans to revive a one-acre waterbody and develop a half-acre butterfly park while keeping the visitor trail largely in its natural form. The project is being executed on forest land and is targeted for completion by the end of Sept.A 100-metre walkway will be created around the waterbody, but it will remain a kaccha path instead of being paved. “The walkway will be similar to the trail at Sultanpur National Park. The approach is aimed at ensuring that the natural terrain and vegetation are not disturbed while making the area accessible to visitors,” a forest official said. The trail will have a bamboo boundary, while a misting system will also be installed along the stretch. The forest department plans to revive the waterbody by clearing excessive algae and water hyacinth that has spread across parts of its surface. Officials will also ensure that it receives water through the natural drainage channels of the Aravalis, while avoiding major changes to the surrounding terrain. he half-acre butterfly park will be another attraction at the site, with suitable plantations planned to provide food and habitat for butterflies and support their presence in the area.The one-acre waterbody is currently part of the Aravali landscape at Leopard Trail. Its revival will restore a water feature within the forested terrain.The development comes as Leopard Trail has become a popular destination for residents of nearby areas seeking access to the city’s Aravali landscape. Unlike formal parks and recreational spaces, the trail offers visitors an opportunity to experience the rocky.

Satya Niketan aftermath: MCG seeks details of unsafe buildings

Gurgaon.(Agency)

Following the building collapse in Satya Niketan, MCG commissioner Pradeep Dahiya has directed the joint commissioners of all zones to submit details of unsafe buildings in their respective areas, along with information on demolition orders already issued against such structures.The directions come amid concerns over the civic body’s enforcement of safety measures for buildings identified as structurally unsafe. However, MCG has not done any fresh survey of unsafe buildings in the last one year.“We are in the process of preparing this report,” said an MCG official familiar with the matter.The civic body had, in Feb this year, identified 45 unsafe buildings across the city. Of these, six buildings have since

been demolished, while 21 have been repaired, according to a report submitted by MCG to Haryana Human Rights Commission (HRC).The report was submitted after HRC in Aug last year had criticised the civic body over an alleged lack of enforcement and inaction against unsafe buildings. The latest directions are aimed at obtaining an updated zone-wise status of such structures and determining the action already taken against unsafe buildings.At the time of the Feb assessment, Gurgaon was divided into four zones. Zone 1 had 18 buildings on the list; two were demolished, seven could not be located at the reported sites and nine were found to be safe. In zone 2, one of six identified buildings was demolished, three were repaired by their owners and two could not be located.Zone 3 had the highest

number of identified unsafe structures, with 20 buildings. Of these, two were demolished, nine were repaired by their



owners and nine could not be located at the reported sites. The lone building identified in zone 4 was demolished. MCG chief engineer Vijay Dhaka confirmed the numbers to TOI: “We have also demolished six of the 45 buildings identified as unsafe or dangerous.”

Asked about the buildings not found at their reported locations, Dhaka said: “It implied that either these buildings were demolished or repaired, so unsafe buildings were not found at the site.” Buildings identified in the Feb report are located in areas including Badshahpur, Kherki Daula and Hari Nagar.MCG had prepared the Feb report after HHRC, in Aug last year, criticised the civic body over alleged inaction and inadequate enforcement against unsafe structures. The latest directive is meant to establish a current zone-wise status of such buildings and assess action taken on those with pending demolition orders. It is expected to give MCG an updated picture of buildings that remain potentially hazardous and require further enforcement.

U-turn opens near Pari Chowk metro station to ease trade show traffic

Noida.(Agency)

Greater Noida Authority has opened a U-turn near Pari Chowk metro station, about 300 metres ahead of Pari Chowk roundabout, for light vehicles on a trial run to assess if it could ease traffic pressure at the busy intersection. It is also expected to facilitate traffic movement during Uttar Pradesh International Trade Show (UPITS), scheduled to be held from Sept 25 to 29 at India Expo Mart in Greater Noida. The trade show brings together MSMEs, exporters, manufacturers, artisans and govt agencies and provides a platform for businesses to showcase their products and connect with buyers from across India and abroad.Developed at a



cost of Rs 20 lakh, the U-turn is the first such facility on Noida Expressway.Greater Noida Authority senior manager Rajesh Kumar Nim said Pari Chowk sees heavy traffic pressure as traffic from Noida Expressway, Surajpur and Kasna converges at the T-point, with

the volume increasing significantly during the rush hours. “We have opened the U-turn on a trial basis. We are continuously monitoring the traffic situation at this spot. If it helps ease traffic at Pari Chowk, it will be made permanent,” he said. Authority has installed barriers along the central verge to open the U-turn to allow commuters travelling from Delhi and Noida towards Greater Noida to turn back before reaching Pari Chowk roundabout. Commuters from Expo Mart, Jaypee Greens and Knowledge Park 2 can also take the U-turn to head towards Yamuna Expressway, Ansal Golf Link, Mitra Enclave and other residential societies.Ravi Kumar, who headed to Agra, said.

Fire breaks out inside locked warehouse in Noida, doused after 2 hours

Noida.(Agency)

A fire broke out at an electronic goods warehouse in a densely populated residential area of Hoshiyarpur village in Sector 51 on Tuesday morning. Firefighters said the blaze, which engulfed the warehouse within minutes, was brought under control after around two hours. Locals noticed smoke emerging from the locked warehouse around 7.30am and alerted emergency services. Fire officials deployed 16 units from different fire stations, and police personnel were also sent to the spot. Firefighters immediately began efforts to prevent the flames from spreading to adjoining houses and buildings.According to fire officials, the biggest challenge was gaining access to the locked warehouse. Firefighters cut through the tin roof of the structure to enter the premises. Teams then attacked the fire from different directions and continuously



sprayed water on the warehouse and surrounding structures.Residents were evacuated from nearby houses as a precautionary measure, and firefighters also kept water jets directed towards adjoining buildings to prevent the intense heat and flames from spreading. The blaze was brought under control after nearly two hours.esidents, however, were left feeling

on edge till much later in the day, with many stepping out of their homes after seeing the thick smoke and flames.No injuries or casualties were reported as the warehouse was unoccupied at the time. A substantial quantity of electronic goods stored inside was destroyed, with preliminary estimates suggesting losses worth several lakhs. Fire officials said that while the official cause is yet to be determined, a short circuit is likely to have triggered the blaze. The cause will be confirmed following a detailed inspection.Chief fire officer (CFO) Pradeep Kumar Chaubey said the exact extent of the damage has not been assessed yet. Fire and police teams are examining the premises and assessing the loss. The warehouse was inspected after the fire was completely extinguished, while further investigation into the cause of the incident is underway, the CFO added.

'Suffered from hypertension, diabetes': Ex-Delhi chief secretary dies by suicide; note says no one responsible

Former Delhi chief secretary and municipal commissioner Rakesh Mehta, 74, was found dead at his rented flat in Sector 82 on Sunday afternoon.Police recovered a one-page note in which the retired bureaucrat referred to his illnesses and stated that no one was responsible for his death.Mehta had been living alone at Central Vihar-2 for around five years. His wife, also a retired Delhi-cadre IAS officer, and their son live in Dehradun, while their married daughter is based in London. Family members visited him in Noida from time to time. According to police, Mehta's wife last spoke to him on Saturday night. When repeated calls went unanswered on Sunday afternoon, family members alerted the society's security staff. Two guards went to his flat and found him dead in one of the rooms. A police team and a relative living nearby arrived soon afterwards.A forensic team examined the flat and collected evidence before the body was sent for an autopsy. Till late Tuesday night, the family had not lodged any complaint, though police said an inquiry had been initiated into the circumstances surrounding the death. Family members said Mehta had been suffering from hypertension, diabetes and other health problems, including tremors in his right hand and leg. A 1975-batch AGMUT-cadre IAS officer, Mehta took charge as Delhi chief secretary in December 2007 during the Sheila Dikshit government's tenure and remained in the post until 2010. His tenure included preparations for the 2010 Commonwealth Games, one of the biggest administrative challenges faced by the capital.Before becoming chief secretary, Mehta served in several key positions, including as MCD commissioner, chairman and managing director of Delhi Transport Corporation, and secretary (power). He was known for his focus on urban governance and public transport.

Banker runs over 2-year-old, sister escapes by a whisker in Gurgaon

A two-year-old girl playing outside her house died after a banker, allegedly speeding through a narrow internal colony road, ran over her while taking a sharp turn in Sector 5 on Monday night. Her four-year-old sister narrowly escaped being hit by the Volkswagen Taigun. The incident took place around 9pm, shortly after Adrija and her elder sister Chhavija had finished dinner and were playing outside their house. CCTV footage showed the car turning into the lane as the sisters sat and played on the road. Driver Nitin Yadav (31), who works with National Australia Bank as an analyst, failed to spot them, police said, and ran both the front and rear wheels over Adrija.Her mother Pooja was talking to another woman a short distance away when the car screeched into the lane. Chhavija managed to move out of its path as it approached. But Adrija suffered injuries to her nose and mouth and was rushed to Manjpal Hospital in Palam Vihar, where doctors declared her dead.



Nitin, who lives just four houses away in the same lane, stopped after the accident and took the family to hospital in the same car. He was later arrested from his house. The girl’s father, Virendra Tiwari, an IT engineer with Global Logic in Noida, alleged that Nitin was driving rashly and at high speed on the narrow internal road. He also alleged that the circumstances raised questions about whether the act was intentional and sought stringent action against him.

“Our lives have been ruined by rash driving. He cannot drive like this on internal roads. He took the turn at such high speed that he did not even see my children. He could have killed both of them. Adrija would have turned two next month. We are in deep shock. I want the stringent punishment for him,” he told TOI.Tiwari, a native of Mahendergarh, said the family had moved into the rented house about a year ago after living elsewhere in the locality.Based on his

complaint, a case was registered under sections 281 (rash driving).

New Delhi: The National Testing Agency (NTA) has issued an advisory to candidates appearing for UGC-NET re-exam in the national capital on September 9 and 10, in view of the traffic curbs in place due to the BRICS summit. The 18th BRICS Summit is scheduled to be held in Bharat Mandapam

"In connection with the Summit, extensive security arrangements are being made, and traffic diversions and restrictions are expected to be imposed by the Delhi Traffic Police and other concerned authorities in various parts of Delhi," the NTA said in an advisory. "Although the UGC-NET Examination

Centres are not located in the areas expected to be directly affected by the major restrictions, candidates travelling to examination centres in Delhi may experience traffic congestion, diversions and delays on certain routes due to the security and traffic management arrangements," it added. The NTA has urged candidates to make appropriate travel arrangements and plan

their journey in advance to avoid any inconvenience or delay in reaching the examination centre. The NTA had to be directly affected by the major restrictions, candidates travelling to examination centres in Delhi may experience traffic congestion, diversions and delays on certain routes due to the

security and traffic management arrangements," it added. last month announced the retest for three papers of the UGC-NET June 2026 examination — English, Commerce and Sociology — following complaints about several errors in these papers. The English paper will be held

Ancient Rome's biggest fresco and mosaic open to public for first time since discovery three decades ago

ROME.(Agency)

Authorities on Tuesday unveiled what is believed to be the largest fresco and mosaic complex of ancient Rome, a first century A.D. depiction of a maritime city in what became the largest bath complex in the world.Mayor Roberto Gualtieri presented the recently restored "Painted City" fresco and "Great Mosaic" that were discovered in an underground gallery during excavations in the 1990s of the Baths of Trajan on the Oppio hill near the Colosseum. The works are opening to the public for the first time, initially in small groups of 15 and during a trial period of weekend access starting this month. The aim is to determine how the delicate works respond to increased humidity and climactic impacts before allowing more general access.Gualtieri said the fresco, which features images of a walled port city from a birds-eye view perspective, was the largest wall fresco of its kind from ancient Rome and as such needs to be open to the public. After being hidden underground for centuries, its blues and terra cotta colors are still clear but faded."They are truly unique in the world, both from the point of view of artistic beauty and the historic and documental importance," he said at the unveiling.Rome's cultural superintendent, Claudio Parisi Presicce, said the grandeur of the port city as depicted in the fresco, with buildings, a theater and temple, public piazzas and towers, was particularly well conserved. The restoration work included techniques to preserve and improve visibility, remove surface deposits and consolidate the grouting to keep the decorated surfaces intact."We don't know what city it refers to, but it must have been a particularly well-known one," he saidThe mosaic, for its part, measures some 15 meters (yards) high and features intricately decorated columns and architectural elements and figures over four different levels. The top levels are up-close images with people that are almost like theatrical scenes, while at the bottom are views of the port city's layout from above.

Iran Captures US Submarine In Hormuz After Attack On 5 Oil Tankers

WASHINGTON.(Agency)

The Iranian navy has claimed to have captured one of the US military's "most modern, smart" unmanned submarines at the entrance of the Strait of Hormuz. In a statement published by Sepah News, the official news outlet of the Islamic Revolutionary Guard Corps (IRGC), the navy said it captured the unmanned underwater vehicle -- identified as a Dive-LD -- in a complex intelligence operation. The submersible vehicle is equipped with the world's most modern subsurface vehicle technology, it said, and released a video of the captured vehicle. In a separate statemet, the IRGC also claimed that its air defence systems had shot down an MQ-9 Reaper drone over the Strait of Hormuz, Sepah News reported.US Response Following the IRGC's announcement, the US military also released a statement saying one of its underwater drones "malfunctioned" over a day earlier during a survey of regional waters, without mentioning whether the device was the one seized by Iran."It was surveying regional waters in support of ongoing operations. The defective drone was an older model that neither collected sensitive data nor carried any classified sonar or radar equipment," a Pentagon spokesperson said.The US military is investing heavily in unmanned naval systems, including underwater and surface vessels, as it seeks cheaper ways to monitor vast areas of ocean, gather intelligence, and track adversary ships and submarines without putting sailors at risk.

Pakistan issues warning as Houthi attacks target Saudi Arabia

Pakistan has warned that any attack on one of the three members of the newly established Makkah Defence Alliance would be regarded as an attack on all three,



with Defence Minister Khawaja Asif saying the pact's collective-defence mechanism could be activated following recent Houthi attacks on Saudi Arabia.Asif made the remarks on Tuesday, hours after Yemen's Iran-aligned Houthi forces launched a series of missile and drone strikes against Saudi Arabia. The attacks targeted several cities as

well as key economic and energy infrastructure, leaving at least 73 civilians injured.The defence minister said te agreement provides for a collective response to any unprovoked aggression against a member state. He also warned that if the conflict in Yemen spills over into Saudi territory, the provisions of the pact could be invoked.The agreement, signed by Pakistan, Saudi Arabia and Turkiye in Makkah last month, commits the three countries to treating an attack against one member as an attack against all, strengthening their mutual defence arrangements."There should be no doubt about this. We are bound by the terms and conditions of this pact and, God willing, we will honour them in case there is a need," Asif asserted.Asif, however, said he was not aware of any contact between Pakistan and Saudi Arabia following the Houthi attacks.He stressed that the agreement was defensive in nature and did not authorise the three countries to launch attacks against another state on their own initiative.

In President Donald Trump's telling at a White House event on Tuesday, two firefighters bodily lifted him to safety from a site near an unstable building after the September 11, 2001 attacks."And I'll never forget," Trump said, "we thought it was coming down on top of us, and two firemen, big strong guys -- and I'm not the smallest guy in the world -- they grabbed me under the arm, said, 'Got to get out of here!'" Trump said.

His comments, at an event honoring

emergency personnel killed on 9/11, appeared to be a new installment in a constantly evolving narrative that Trump has told over the years about his actions after the attacks.It's a story that has long featured the New York property tycoon as the hero, with variations on him taking workers down to Ground Zero.But Trump's version of events is one that US media say is disputed by rescue officials present at the time.The remarks also come amid a stir about Trump not being present as president in New York for the 25th anniversary of the attacks in which 2,977 people were killed.Instead of being at the site where Al-Qaeda hijackers rammed planes into the World Trade Center towers, Trump will pay his respects on Friday at the Pentagon in Washington, another target in the attacks.Trump and the White House have hotly denied reports that he chose the Pentagon because he was not allowed to deliver a speech at the 9/11 memorial."This is more Corrupt News, I've been to New York many times over the years, and no one

ever speaks, it's a 'solemn ceremony!'" Trump said on his Truth Social network last week.But it will still place the 80-year-old native New Yorker away from



the main focus of the day's commemorative events.Vice President JD Vance and Trump's four living predecessors -- Democrats Joe Biden, Barack Obama and Bill Clinton, as well as Republican George W Bush, who was president at the time of the attacks -- are all expected at "Ground Zero."Later on Friday, Trump is due to fly to Ireland

where he will attend the Irish Open golf tournament at his family's golf course over the weekend.More famous than me' His absence from New York marks a contrast with Trump's usual approach, which has been to put himself at the heart of the 9/11 story.Two days after the attacks, Trump told reporters that he had been to Ground Zero and had sent 100 workers to the site to help recovery efforts. CNN and the New York Times said people present at the site disputed his account.In the event on the White House Ellipse on Tuesday, where a steel beam recovered from the World Trade Center's South Tower was on display, Trump gave a fresh account of his actions that day.Trump said it had been a "beautiful morning" and that he had then seen a news alert on television, before looking out of his window "and I saw things that I never want to see again."He added that he was overseeing a building project and that he "took the whole crew down there right after this happened.

IRGC attacks American base in Jordan, claims strikes on US vessels, 8 tankers as 5 Iranian tankers destroyed

Iran's Revolutionary Guards said Wednesday they pummelled a US military base in Jordan, vowing retaliation for American strikes on Iranian oil tankers that dragged the foes deeper into war.Tehran's bombs came after US forces destroyed five Iranian oil tankers on Tuesday in response to Iran targeting an American warship, the second such attack in less than a week.The Iranian Revolutionary Guards also said on Wednesday that they attacked two US vessels, eight oil tankers and 10 "non-compliant vessels" trying to pass through the Strait of Hormuz."Two US vessels, eight oil tankers, and 10 non-compliant vessels attempting to pass through the prohibited and unsafe zone of the Strait of Hormuz were targeted," the Guards said in a statement published

by the official IRNA.The United States and Iran are locked in a stalemate six months into the war, with Iran maintaining a stranglehold on the Strait of Hormuz, a vital shipping route for the world's oil and gas, and Washington pushing a campaign to choke Ira's ports and economy. The Islamic republic said on Wednesday it would target oil tankers off US-allied Kuwait and Bahrain in retaliation for the strikes on its tankers.Minutes later, Iran's Revolutionary Guards -- the most powerful arm of the Iranian military, said they had struck the US air base of Al-Azraq in Jordan with missiles, state media reported.The "punitive operation" damaged maintenance and repair facilities, deployment locations and shelters for fighter jets, according to IRNA.Jordan's army said it shot down 18 missiles from

Iran targeting the kingdom.

The strikes came after Tehran urged crews on oil tankers off Kuwait and Bahrain to leave their vessels, warning they "will be targeted", the Guards said in a statement posted on IRNA.The US military said it destroyed five Iranian oil tankers on Tuesday after Iran's Revolutionary Guards targeted a U.S. Navy warship with ballistic missiles twice over two days, according to U.S. Central Command.The vessels -- Kivik, Charminar, Horizon 1, Riesco and Derya -- were struck in the Gulf of Oman and near Kharg Island in the Strait of Hormuz. CENTCOM said the crews were warned to abandon the ships before the strikes. The US had also destroyed three Iranian oil tankers on Saturday, after Iran attempted to attack a U.S. aircraft carrier and destroyer with ballistic missiles.

Taliban denies Pakistan's claim that India's most-wanted terrorist Masood Azhar is hiding in Afghanistan

Azhar, wanted in India over the Parliament, Mumbai, Pathankot and Pulwama attacks, has been claimed by Pakistan to have fled to Afghanistan since 2019.

JAKARTA.(Agency)

The Taliban regime has rejected Pakistan's repeated claims that Jaish-e-Mohammed (JeM) founder Masood Azhar is hiding in Afghanistan, with a senior Afghan Foreign Ministry official confirming that the UN-designated terrorist is not in the country, reported. The development comes as Pakistan faces renewed scrutiny over its efforts to crack down on terror groups and their leadership. Islamabad has

long claimed that Azhar fled to Afghanistan after crossing the Durand Line in May 2019 and has remained at large there.Kabul, meanwhile, reiterated that Afghan



territory would not be used against any other country.Azhar remains one of India's most-wanted terrorists and is accused of masterminding several major attacks in the country, including the 2001 Parliament attack, the 2008 Mumbai attacks, the 2016 Pathankot airbase attack and the 2019

Pulwama bombing. The UN Security Council designated him a global terrorist in May 2019.Pakistan's claim about Azhar's whereabouts has also come amid international scrutiny of its counter-terror financing efforts. The Financial Action Task Force (FATF) had placed Pakistan on its grey list from 2018 to 2022 over deficiencies in combating money laundering and terror financing. Among the concerns cited by the global watchdog were Pakistan's failure to effectively curb terror financing linked to groups such as JeM and Lashkar-e-Taiba and weak implementation of financial sanctions against UN-designated terrorists.To secure its removal from the grey list, Pakistan took several measures, including banning JeM, LeT and their affiliated organisations and prosecuting leaders of the groups. Azhar was convicted in absentia by a Pakistani court in 2021.

UK air traffic control failure disrupts 1,000-plus flights, leaves passengers stranded for hours

An air traffic control problem disrupted travel across Britain on Tuesday, canceling more than 1,000 flights and leaving passengers stranded for hours on airport runways and in terminals, according to flight-tracking website Flightradar24.ritain's National Air Traffic Services said it had resolved a problem in its flight processing system in the evening but delays rippled across 15 U.K. airports and beyond as airlines and airports worked to clear a huge backlog of delayed flights. Josie Donoghue spent three hours stuck on a plane at Gatwick before her Ryanair flight to Ireland was canceled."Getting through that airport was like trying to get out of Alcatraz," she said, referring to the notorious former island prison in San Francisco Bay. "It's just an absolute nightmare down there. It's the only word I can use to describe it." Departures at London Heathrow resumed but

the busy airport suspended arrivals for the rest of the night because of the disruption and warned of further delays. Passengers on a British Airways flight that



had been due to fly to Baltimore disembarked after four hours on the ground at Heathrow. During the long delay, flight attendants served pasta and chicken curry while patient passengers watched movies or strolled up and down the aisles.But passengers then learned their problems were far from over. There was mayhem at the baggage claim area

and they were told no one could help them and to file claims for their bags.British Airways said it was forced to cancel or divert more than 100 flights. Ryanair said more than 65,000 of its passengers had been disrupted and it had canceled more than 50 scheduled flights."The severity of the issue means there will be a significant knock-on impact," a British Airways spokesperson said. "This incident was entirely out of our control and incredibly frustrating for our customers and colleagues, with aircraft and crews ending up out of place."Some passengers took to social media to complain about being stuck on planes for hours and expressed frustration about a lack of communication from airlines.Affected airports included Stansted and City in London, as well as those in Manchester, Birmingham, Gatwick and Scotland. They warned passengers to check the status of their flight with their airline.Budget airline EasyJet said some of its flights were "unable to operate" and that the system failure caused "delays to flights across Europe."

Four killings, one capture bid — then the tigress died

Ahmedabad (Agency). Twenty-four hours before she died, she was suspected of killing four people in Maharashtra’s Amravati and Wardha. Tracked down, the objective was to capture her alive. But she died. How? What happened? First, this isn’t the story of a woman who allegedly killed four people. This is the story of a tigress who allegedly killed four people.

That doesn’t make her death any less significant. There are fewer than 4,000 tigers in India’s jungles and forests, and that’s based on a census conducted in 2022.

The death of a tigress

The tigress that died on Monday – and had reportedly been stalking the Amravati and Wardha districts since mid-August – was being transported to a wildlife rescue centre when it died. Questions have now emerged over the tranquilisation process, including the administration of multiple doses of sedatives and the non-availability of stimulants to awaken her.

Sources familiar with the operation to catch her said the tigress – tracked to Shirajgaon Kasba village in Amravati – was darted twice with a combination of Xylazine and Ketamine; the latter is a dissociative anaesthetic and the former is a non-opioid animal tranquiliser. However, she continued moving after the dose. A preliminary post-mortem cites "cardio-respiratory failure" as the prima facie cause. Organ samples have been sent for histopathological and toxicological examination to establish the exact cause.

AI to predict traffic snarls, guide police deployment

Pune (Agency).

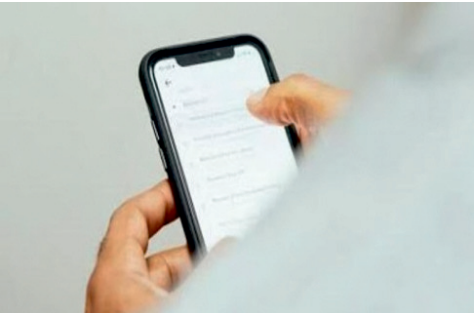
As Pune prepares for Ganeshotsav, the traffic police have said they will use artificial intelligence (AI) tools to identify congestion-prone areas and decide where personnel need to be deployed during the festival. The Traffic Control Branch will use an AI-based platform, Trafficure, from the first day of the festival to track traffic patterns, predict congestion and help officers redeploy personnel based on the situation on the ground. Daily analysis generated by the platform will also be shared with citizens. Additional Commissioner of Police Manoj Patil told The Indian Express. “We will be observing Trafficure from day one. It is an AI-based platform which gives predictions. We will have daily analytical reports on jamming and congestion, including which areas face problems and at what time,” Patil said. The reports will be made available through the traffic police’s communication platforms and the phone-based application. They will include information on the day’s traffic conditions as well as predictions for the following day. The system is expected to be particularly useful during Ganeshotsav, when traffic patterns change frequently because of processions, road closures, diversions, parking restrictions and immersion-related movement. Patil said the data would help the department move away from a fixed deployment model, where personnel are assigned to junctions in advance regardless of the traffic situation.

BMTC’s live tracking for app-based taxi users soon

BENGALURU(Agency).

Commuters using Ola, Uber and other app-based taxis will soon be able to access BMTC’s live bus-tracking facility through ‘Namma BMTC Mobile App 2.0’, Transport Minister Byrathi Suresh said on Tuesday.

Chairing a meeting of senior officials of the Transport Department, KSRTC and BMTC, Suresh directed them to extend the BMTC’s live-tracking app to private app-based taxis. This will help people to check the availability of BMTC buses to their destinations after getting off app-based cabs. The minister directed the BMTC to deploy 200 mini air-conditioned electric buses at all Metro stations. These buses will be part of the 4,500 electric buses being



procured by BMTC under the Centre’s PM E-DRIVE scheme. The mini AC buses will provide connectivity within a radius of 5km from the Metro stations, linking residential layouts and peripheral areas. The BMTC will provide more air-conditioned buses to IT-BT companies in Bengaluru for the benefit of their employees. The officials have been instructed to hold discussions with such companies, the minister said.

Stagnant output, demand increase: What has triggered Punjab power crisis

Punjab’s dependence on power purchased from private generators and outside the state has come under renewed scrutiny amid the ongoing crisis. The five-hour scheduled power cuts for industry were withdrawn on Monday after a week following protests, even as domestic and rural consumers continued to report unscheduled outages. Here’s why the crisis unfolded.

From 6,580 MW to 5,680 MW

Punjab’s total thermal generation capacity stood at around 6,580 MW in 2016, including state-owned plants and private independent power producers (IPPs). Today, it is down to about 5,680 MW. The state-owned Guru Nanak Dev Thermal Plant (GNDTP), Bathinda, had a capacity of 460 MW. Its four units, commissioned between 1974 and 1979, were shut on January 1, 2018. At the Guru Gobind Singh Super Thermal Plant, Ropar, two of the original six units were also retired in 2018, reducing its capacity from 1,260 MW to 840 MW. The Guru Hargobind Thermal Plant at Lehra Mohabbat has 920 MW of installed capacity. The 540-MW Guru Amardas Thermal Plant at Goindwal Sahib,

commissioned in 2016 as a private plant, was acquired by PSPCL in 2024. Together, Punjab’s state-owned thermal plants now account for around 2,300 MW.

Private plants carry a major load

Punjab’s two major private thermal plants — Rajpura and Talwandi Sabo — have a combined capacity of 3,380 MW. Rajpura has



1,400 MW, while Talwandi Sabo has three 660-MW units with both units being commissioned between 2014 and 2016. The result is stark: no new thermal generation capacity has been added in Punjab since 2016. Instead, the state lost 880 MW through the Bathinda closure and

retirement of two Ropar units in 2018.

Demand has jumped by over 6,000 MW

While generation capacity stagnated, demand surged. Punjab’s peak demand in 2016 was around 11,000 MW. In July 2026, PSPCL met a record peak demand of 17,452 MW, an increase of more than 6,000 MW in a decade. The mismatch has left Punjab increasingly dependent on purchased power, particularly when its own plants cannot operate at full capacity.

Coal shortage exposes Punjab’s vulnerability

Power Minister Tarunpreet Singh Sond said reduced coal availability had cut Punjab’s generation by around 1,500 MW, affecting both Rajpura and Talwandi Sabo plants. He said the wider coal shortage had affected around 63 GW of generation capacity nationally and sought Centre’s intervention to restore supplies. Punjab BJP president Kewal Singh Dhillon,

however, questioned the government’s explanation, citing earlier claims that the Pachhwara coal mine would provide Punjab long-term coal security and that thermal plants had adequate stocks.

Rohan Parikh: From London to the centre of BKC’s ‘PMO ID’ case

At 24, Rohan Premal Parikh has studied in London, completed a BSc in Mathematics and Science and developed an interest in drone technology. On Monday, the young businessman found himself in police custody after allegedly using a suspect Prime Minister’s Office (PMO) identity card to enter Jio World Plaza in BKC, a day before Prime Minister Narendra Modi’s visit to the area.

Parikh, who works as a share broker, had arrived at the premises with his friend Prathamesh Ganesh Bagul, 26, and his personal security guard, Dilip Rajaram Kunde, 49, a retired Army personnel from rural Nashik. Kunde, who retired from the Army around a decade ago, had been working as Parikh’s bodyguard. Kunde was carrying a

licensed revolver and six live cartridges when the trio entered the premises, police said.

Parikh’s background in drone technology is



now among the aspects being examined by investigators as they try to establish why he

was carrying an identity card identifying him as a PMO official. “He has studied in London and is into drone technology. We are investigating whether someone took advantage of this and duped him or whether there was some other reason for him carrying the fake card,” a Crime Branch officer said. The identity card allegedly identified Parikh as a Grade C official of the PMO and mentioned his association with drone technology. Police said Parikh, Bagul and Kunde entered Jio World Plaza around 4.50 pm on Monday. During a security check, one of them allegedly produced the identity card and claimed an association with the PMO. Security personnel alerted the police, following which investigators traced Parikh through CCTV footage and the vehicle used by the three men.

‘Not against rules but...’: Pune’s mandals react to noise-free Ganeshotsav call

Pune(Agency).

A citizens’ campaign demanding that DJs and dhol-tasha pathaks violating noise limits be kept off Pune’s streets during Ganeshotsav and other festivals or public events has drawn a mixed response from the city’s Ganesh mandals.

While several mandal representatives say they support the police’s sound system cap of four bass and four top speakers, most are firmly opposed to an outright ban on DJ music and traditional drum troupes.

The demand, spearheaded by activist Vidyanand Bapat, calls for a completely noise pollution-free festival. But mandal leaders across the city say the picture on the ground is more nuanced than a simple case of compliance versus defiance, with some mandals having gone without loudspeakers for decades and others insisting that a single day of celebration with a sound system is a reasonable ask.

‘No choice but to opt for a sound system’ Uday Mahale, president of the Shri Gurudatta Mitra Mandal, Shivajinagar, said the sheer scale of Pune’s Ganeshotsav makes dhol-tasha troupes hard to come by

for every mandal. “Considering the main and smaller Ganpati mandals, thousands of processions take place every year in Pune, but we don’t have that many dhol-tasha groups, so actually we don’t have a choice but to opt for a sound system,” Mahale said.

His mandal, now in its 57th year, has used



a DJ system during the visarjan procession for roughly the last 35 years, having earlier relied on dhol-tasha pathaks. Mahale said the mandal supports the Pune police commissioner’s mandate capping sound systems and opposes the use of plasma, pressure-mid, and laser lights.

Travelling along the Patiala-Sangrur highway, it is hard to miss the grand entrance to Toor Banzara village. Its ornate design and beautified bus-stop waiting area announce the village long before one enters it. Former sarpanch Harpreet Singh had the gate built during his tenure, and villagers often showcase it in social media videos. On Tuesday, however, few villagers used the gate.

An uneasy calm hung over the village as people moved through kutchra roads and narrow lanes towards its rear end. The village, in Dirba constituency represented by Punjab Finance Minister Harpal Singh Cheema, has around 1,800 voters, nearly 700 of them from the Scheduled Caste community. About 100 people sat on durries in a wide lane, raising slogans against Cheema and the AAP government. Speakers took turns addressing the gathering just metres from the house of

Gulzar Singh, a 53-year-old Dalit agricultural labourer who died after allegedly consuming a poisonous substance on Monday night. The house lies in a lane so narrow that barely two two-wheelers can pass each other. Open drains run along the side. Gulzar’s house tells its own story. A kutchra verandah opens into two rooms with unplastered walls. A third remains unfinished. The family cooks in one of the rooms, where Gulzar lived with his wife Pal Kaur, their three sons and his mother. On Tuesday, his absence was impossible to miss. Gulzar had publicly questioned Cheema at a meeting at the village gurdwara on Sunday about the easy availability of chitta in the village. He told the minister that his own son was addicted and could obtain drugs easily. His widow, Pal Kaur, alleged that what followed was humiliation. “My husband asked Cheema

where the drugs were coming from because our son gets them easily. Later, two policemen from Dirba police station dropped him home. In the evening, the village sarpanch called and said she would



make him apologise for his mistake,” she said. Pal Kaur alleged that on Monday, panchayat members came to their home

and asked Gulzar to apologise to Baljit Singh alias Raj, the husband of village sarpanch Baljinder Kaur, by touching his feet. “My husband felt deeply humiliated,” she said. Gulzar’s 23-year-old son, Sehbaz Singh, a BA second-year student at Government Ranbir College, Sangrur, said his father left home later that day.

“I don’t know whether he met the sarpanch or not. When he returned, he went to my uncle’s house in our lane and fell from his bicycle. He told my uncle that he had consumed poison because the sarpanch, panchayat members and others had humiliated him for questioning the finance minister,” Sehbaz said. What followed was a desperate rush between hospitals.

“We reached Sangrur Civil Hospital around 1.30 pm. They referred him to Rajindra Hospital in Patiala.

SIR: 3 in 10 voters not carried forward in Muslim-heavy seats in Maharashtra

Nearly 30 per cent of voters in 38 Maharashtra Assembly constituencies, where Muslims account for more than one-fifth of the population, have not been carried forward to the draft electoral rolls prepared as part of the Special Intensive Revision (SIR), according to an analysis of the draft roll data.

Of the total electorate in these 38 constituencies, 37.51 lakh voters, or 29.77 per cent, have been marked as “uncollectable”. Across Maharashtra, the corresponding figure is 21.14 per cent.

The highest rates have been recorded in several densely populated constituencies in Mumbai and the Mumbai Metropolitan Region. In Bhiwandi East, 49.10 per cent of voters have not been carried forward, followed by Bhiwandi West at 44.72 per cent, Mumbra-Kalwa at 42.91 per cent and Mankhurd Shivaji Nagar at 42.31 per cent. In Mumbai, Chandivali, where Muslims account for 27.6 per cent of the population, recorded an uncollectable rate of 41.44 per cent. Sion-Koliwada and Pune Cantonment also recorded rates above 40 per cent. The figures, however, do not indicate whether individual Muslim voters were excluded. The SIR data is not classified by religion and the analysis is based on Assembly constituencies with a Muslim population of more than 20 per cent. The data also shows that the proportion of voters not carried forward does not necessarily rise with the Muslim population share of a constituency. Malegaon Central, which has the highest Muslim population share among the 38 constituencies at 78.4 per cent, recorded an uncollectable rate of 23.46 per cent.

FDA suspends licences of 3 ISKCON eateries in Mumbai’s Juhu over food safety violations

Ahmedabad (Agency). Maharashtra’s food safety regulator’s crackdown to ensure compliance has now reached Lord Krishna’s doorstep, with the state regulator suspending licences of three food units run by ISKCON Juhu after inspections revealed glaring violations.

The Maharashtra Food and Drug Administration (FDA) raids at three ISKCON food units found serious food-safety and hygiene violations, including pest infestation, inadequate food storage and segregation, poor drainage and gaps in water and food testing, employee medical checks and food-safety training. The action was part of a wider crackdown in which the FDA suspended the licences of six food establishments in Mumbai, three in the Konkan division and 11 in the Pune division. In Pune, 12 establishments were hit, with one ordered to stop business for operating without a valid food licence. The three ISKCON establishments whose licences were suspended by the FDA are the main food establishment at Hare Krishna Land, ISKCON Juhu Food Services–Restaurant and Govindas Restaurant. Officials said they were

inspected on September 3.

At the main establishment at Hare Krishna Land, the FDA found inadequate checks of raw materials, improper storage conditions, pest infestation, inadequate cleaning and drainage, and missing records of water testing, employee medical checks, vaccination, training and audits.

At Govindas Restaurant, inspectors found standing water in cold storage, blocked drains, pest-control deficiencies and inadequate segregation of raw and cooked food. Meanwhile, the food safety body, led by Commissioner Tukaram Mundhe, also suspended the licence of Drogheria Sellers Pvt Ltd (Zepto), Malad West. Inspectors found live cockroaches in packed egg boxes and on a beverage table. Milk, paneer and curd were stored at 14-15°C as against the expected 2-6°C, while cold storage was at 20-21°C. Expired food was also found on shelves for sale.

Mateshwari Milk, Kharghar, also faced suspension after the FDA found discrepancies in milk labelling, including loose toned milk being sold as cow’s milk and loose standardised milk as buffalo milk.

The new order faces a familiar test of power

On September 21, 2024, Sri Lankans were determined to pursue a complete political overhaul. They had survived Covid 19, a year in which the island’s economy nosedived, and the 2022 financial collapse along with massive public protests demanding an end to elite political rule. In the ninth presidential election, the winning candidate was a foregone conclusion. The public voted for the man dubbed the most trustworthy politician to rewrite the island’s political trajectory and decisively end 76 years of elite political rule. The stage was set for a different political class and ideology: Anura Kumara Dissanayake, leader of the once-revolutionary Janatha Vimukthi Peramuna (JVP) and the National People’s Power (NPP), who promised the people “a thriving nation, a beautiful life”. He campaigned heavily to fight graft, systemic governance reform, economic relief, social protection and rode the crest of a popular wave to become President. Two years later, popularity is gradually declining with many likely to conclude that Dissanayake has delivered a ‘mixed bag’, with many promises still to be fulfilled. Manifesto-tracking assessments recognise Dissanayake’s political pragmatism over idealism, progress in social protection and institutional transparency, but fault the delay in constitutional overhauls, reconciliation efforts and even keeping his own house in check.

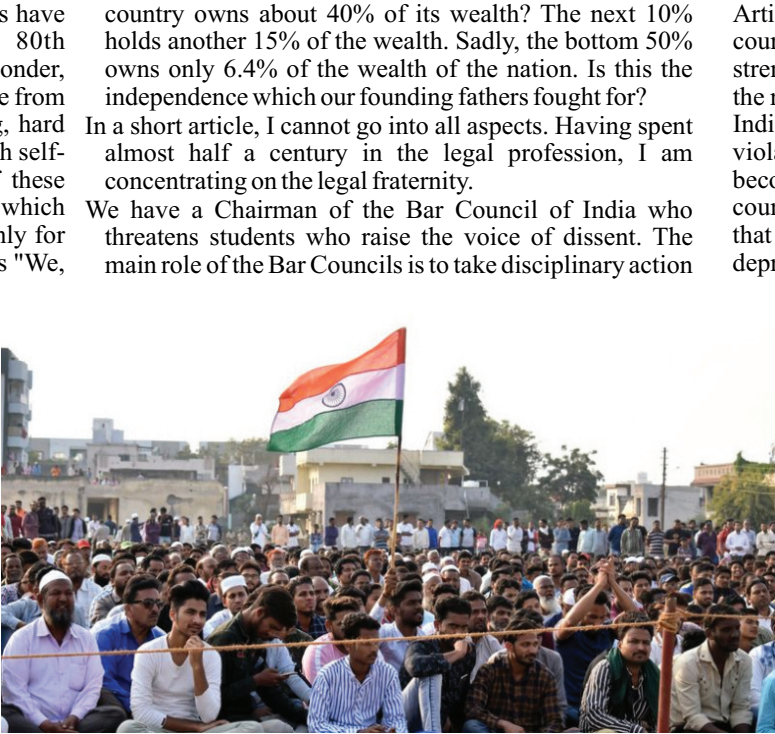
A careful examination shows that public perception of Dissanayake is also beginning to change, following recent attempts to bulldoze through a constitutional amendment to increase the retirement age of judges, seen as an effort to keep the current chief justice in office for another two years. The matter has cast a pall of gloom and if there was already muttering about inefficiency and corruption, this move is drawing significant flak. Dissanayake swept into office on several key pledges: curb corruption, act against previous corruption and political wrongdoing, expand social security, practice political austerity, and abolish the executive presidency—the latter a 30-year-long electoral pledge. For his part, he has cut parliamentarians’ privileges, taken measures to reduce the cost of governance, scrapped luxury vehicle permit allocations for legislators, reduced Cabinet expenditure and eliminated several State-funded perks that earned him credit, actions the public holds in contrast to the opulence of the Rajapaksas, often compared to the Philippines’ Marcos family for lavish public spending. Among the most appreciated decisions is the structural relief offered through the expansion of the Aswesuma welfare scheme, raising monthly grant allocations for low-income and vulnerable families. The government has pushed through public-sector pay hikes and adjusted private-sector minimum wage targets. It also rode the popular wave, held local authorities’ elections, and took control of 265 of 339 local councils. Making good on his pledge to revisit several controversial matters, investigations continue into the 2019 Easter Sunday attacks and some past financial irregularities. However, in contrast to his campaign rhetoric, he has chosen to tread a pragmatic middle ground rather than attempt to shake the fragile economic foundations through a massive economic experiment. This decision does not sit well with his party’s hardcore, which calls for a swift and complete exit from the International Monetary Fund (IMF) engagement and for a complete system overhaul. Still, he has chosen to pursue the IMF formula, adhere to macroeconomic targets, complete IMF reviews and finalise debt restructuring agreements without rocking the boat. However, while campaigning, NPP leaders criticised the harsh conditions of the IMF bailout arranged under the previous administration.

The true meaning of freedom

eachers’ Day once honoured learning; today, neglected schools expose systemic failure

After the marching has come to a halt, the drumrolls have fallen silent and the euphoria of India’s 80th Independence Day celebrations has lessened, I ponder, how free are we, the citizens of India? Independence from foreign colonial powers was attained after a long, hard and peaceful struggle. Our leaders led the way with self-sacrifice and devotion to the country. Some of these leaders were also part of the Constituent Assembly which framed the Constitution. They had a vision not only for the country but also for its people. That is why it is “We, the People” who gave ourselves the Constitution of India. Freedom from foreign powers is extremely important. No sovereign nation can be truly independent if it is under colonial rule. However, independence is not mere removal of the foreign yoke. Independence is not only the country being independent, but also the citizens being free and independent. We are an independent nation when the citizens have the freedom to think and speak without fear. We are independent when citizens can raise the voice of dissent and openly express their views. We can be called truly independent only when hunger and poverty do not decide the future of a child, whether it be in the fields of education, healthcare or basic human rights. We are a country truly independent when there is no caste or religious bias and equal opportunity is not denied to citizens on account of their belonging to the depressed classes or minority religions. We can be truly independent only when we get rid of corruption, bias, bigotry and intolerance. Looking back, one is proud that we have progressed a lot. Citizens are living a better life than before. India’s economy is in better shape than that of many other countries. Life expectancy has improved considerably. Infrastructure has improved vastly. India is one of the leaders in the digital space. We are a global power heading towards a trillion-dollar economy. But what use is a trillion-dollar economy if a large proportion of the citizenry still lives below the poverty line? According to the government, it provides free foodgrains to around 57% of India’s population. These people, who cannot even afford food or housing, are denied equal opportunity in education, healthcare and employment.

The condition of government-run schools is abysmal. Healthcare in most states is virtually absent. Employment opportunities are dwindling and unemployment hovers around 6%. To those who claim that the education and healthcare facilities provided by the government are very good, my simple questions are: where do your children study? Which hospitals do you go to for treatment? Our founding fathers envisaged a society where there was justice - social, economic and political. How can we claim to have moved towards these goals when the top 1% of the



country owns about 40% of its wealth? The next 10% holds another 15% of the wealth. Sadly, the bottom 50% owns only 6.4% of the wealth of the nation. Is this the independence which our founding fathers fought for? In a short article, I cannot go into all aspects. Having spent almost half a century in the legal profession, I am concentrating on the legal fraternity.

We have a Chairman of the Bar Council of India who threatens students who raise the voice of dissent. The main role of the Bar Councils is to take disciplinary action

Article 32. Sadly, in the last few years, the constitutional courts have not shown the requisite sensitivity or strength. One of the most important of all human rights is the right to liberty, which is guaranteed to every citizen of India under Article 21 of the Constitution. This liberty is violated with impunity, and the courts in many cases have become mute spectators. Justice HR Khanna, in his courageous dissent in the ADM Jabalpur case, had said that even during an Emergency, a citizen could not be deprived of fundamental rights except in accordance with the procedure prescribed by law. “Bail, not jail, is the rule” is the oft-quoted legal principle. In actual practice, however, it is jail, not bail, which has become the rule.

About 75% of the people behind bars are undertrials. Only about 24% are convicts and the remainder are detenus. It is shocking that in a country where we swear by the rule of law and a person is presumed innocent until proven guilty, there are three undertrials for every convict. Umar Khalid has been behind bars for more than six years and the trial has not even started. What about his right to liberty? What about his right to speedy trial? The Supreme Court, in a later decision, has itself questioned the validity of the judgment in Umar Khalid’s case. The accused in the Elgar Parishad case were kept behind bars for years; one died in jail. The allegations against them are said to be very serious. If so, why has the prosecution not shown the same seriousness to start the trial? Eight years have passed since the incident took place. The trial is yet to begin. The process has become the punishment. People are condemned and their lives ruined by labelling them as anti-nationals. Unfortunately, the courts do not protect the fundamental rights of these citizens.

Sonam Wangchuk was detained for about six months. Any student of law knows that a petition of habeas corpus must be decided at the earliest. In this case, the Supreme Court kept adjourning it, with a request to the government to have a relook into the matter. That is not the way matters concerning liberty have to be decided. Finally, when the powers that be realised that the Court was unlikely to decide the matter in their favour, the order of detention was withdrawn. Surprisingly, the Court then said that the matter had become infructuous. In a civilised society, every citizen has a right to know why they have been deprived of their liberty, even if only for a day. The Supreme Court should not have abdicated its function and should have decided whether Wangchuk’s detention was legal. Democracy is the rule of the majority, but majoritarianism, where the voice of the other side is not heard, is anathema to democracy. Unfortunately, courts at all levels are moving towards majoritarianism.

Big announcements must promptly be followed by House debate and scrutiny

The return of Rule 110 to the centre of Tamil Nadu’s political conversation raises a question about how it is being used. Successive governments have taken its help to place policy announcements before the Assembly without immediate debate. Chief Minister C Joseph Vijay has now made major expenditure announcements under that rule, including an integrated Assembly and Secretariat complex at ₹1,200 crore, an ₹11,000-crore urban infrastructure programme, including a ₹4,800-crore desalination plant, a crop-loan waiver involving ₹6,220 crore, a semiconductor park, logistics and finance hubs, and many more. Rule 110 permits a minister to make a statement on a matter of public importance, but provides for no debate on the statement when it is made. The government can therefore set out its decisions and plans in the House without having to immediately answer questions from the Opposition on their cost, priorities or implementation. The responsibility of the legislature assumes greater significance when announcements involve substantial expenditure. The government has



drawn attention to Tamil Nadu’s difficult financial position. Its first budget has emphasised fiscal repair, while the debt and liabilities have been put at ₹13.18 lakh crore. The government has sought to present austerity and financial discipline as necessary to restore the state’s finances. At the same time, it is announcing projects and welfare measures involving thousands of crores. There is no contradiction between fiscal repair and spending

on development or welfare. Nor does a Rule 110 statement itself sanction expenditure. But the juxtaposition raises a question about whether fiscal commitments are insulated from opposition’s oversight. If the government is asking the state to accept austerity, the Assembly is entitled to examine how new commitments will be financed, prioritised and accommodated within stretched finances. That is where debate matters. Opposition scrutiny is not an obstacle to executive action; it allows assumptions to be tested and the government to explain choices involving public money. Rule 110 necessarily limits that scrutiny at the time of announcement. A functioning democracy relies on checks and balances and significant policy decisions should not bypass floor debates. Vijay’s government would strengthen its case for fiscal prudence by ensuring that commitments announced under Rule 110 receive examination through the budgetary and legislative processes. Transparency is better served when announcements are followed by scrutiny.

Vishwaguru And the Trouble With Pluralism

➡A Hindu India in which Bhagwat can publicly declare that the desire to expel Muslims negates a citizen’s claim to Hinduism merits serious debate, not reflexive denunciation

History is humanity’s perpetual memoir, whose plot carries a subtext of irony. The indignation of New York’s anti-Semitic mayor Zohran Mamdani towards Mohan Madhukar Bhagwat, the sixth and current Sarsanghchalak of the RSS addressing Indian-Americans is imbued with deep irony. This resentment of Mamdani, a practising Muslim, duplicates a profound dislike of the RSS, which the global liberal-Left apparatus casts as the embodiment of exclusion. Bhagwat’s New York script that any Hindu who believes Muslims are not Indians, are not Hindus, is not bound to be accepted by every BJP politician, Hindutva activist, or voices invoking Hindu nationalism. Nor will it convince career wackadoodles that Bhagwat was serious. But India persists in its indefinite complexity, as most civilisations tend to. Its tradition carries within itself ideas, practices, and philosophical positions that modern sensibilities find both magnificent and troubling. The correct response to history is not to venerate it uncritically, but also not to expunge it from textbooks—it is to understand its contradictions with mature discernment. When mythos meets politics, the result is debate on truth. Or better, fact. To understand why the RSS describes its annual collections as guru dakshina in the face of intense interrogation by its current tormentor Priyank Kharge, the explanation lies in an ancient concept in Indian civilisation. Long before universities charged fees, political parties raised unaudited funds and companies offered government-monitored CSRs, Indian society had evolved an unique educational mechanism of financial transaction. Students acknowledged their debt to their teachers through guru dakshina. In the epics and Puranas, the value of what disciples offer their teachers lay not in its amount, but in the spirit of gratitude behind it. There is a clear distinction between a fee and a dakshina. A fee is a transaction upon completion of a job or purchase. A dakshina is the distinguished finale of a sacred relationship—a voluntary offering in gratitude, respect and recognition that knowledge is not a commodity purchased in a marketplace. Hence the guru dakshina becomes a

sacred covenant between guru and disciple, enacted through trust, discipline, and personal example. Consequently, the relationship between them was moral, spiritual, and civilisational, not transactional. In the Upanishadic tradition, the guru is the force at the centre of intellectual and spiritual life. The Taaittiriya Upanishad instructs students to honour their gurus for the



knowledge gained through education. However, there is nothing amiss in demanding that an organisation account for its finances. When RSS adopted this metaphor in its guru dakshina tradition, the symbolic guruship it offered to the bhagwa dhvaj rather than to an individual was its cultural motif. Records state that at the first Guru Dakshina Utsav in 1928, RSS collected the princely amount of ₹84. Since the RSS is widely regarded as the ideological

fountainhead of the broader Sangh Parivar, questions are raised on the scale, accounting, and transparency of the collections. But reducing the debate to a chartered accountant’s domain is to miss an important cultural dimension. The contrary liberal critique is: the RSS is dangerous because it is exclusionary. Bhagwat says exclusion of Muslims contradicts Hindu principle; therefore, Bhagwat harbours exclusionary intent. This is not reasoning but a pre-decided conclusion looking for supporting evidence. Bhagwat’s compelling message from New York did not imitate BJP’s stance of India as the “vishwaguru” in the usual bombastic sense. His proposition suggests India itself can be the guru to the world because it is a civilisation that has spent millennia in conversation with itself by arguing about gods and faiths, truth and identity, caste and philosophy, invasion and coexistence, and the contradictions these generate. If India truly aspires to be a vishwaguru, it must teach through example. A Hindu India in which Bhagwat can publicly declare that the desire to expel Muslims negates a citizen’s claim to Hinduism merits serious debate, not reflexive denunciation. Consider its global implication. If Mamdani’s idea of diversity genuinely aspires to universality, should it not be welcomed rather than be suspect? Hamas is not just another grievance within the political catalogue. The fanatics who chant support for massacres by its idols are not merely dissenters of Israeli policies. Bhagwat’s formulation that human dignity is universal, and requires protection, and that no group possesses the right to declare entire communities beyond the national identity extends far beyond Hindu-Muslim relations.

This column is a neither a tribute to the RSS nor is it a condemnation of the liberal Left. It is a nuanced attempt to reconcile antithetical ideologies of India and Bharat. The significant question is, can India truthfully embody the vishwaguru role it claims for itself? A guru who speaks only to disciples is merely a preacher. A guru who perpetually teaches himself is an altogether different philosopher, acutely moral, and infinitely powerful than the idea itself.

Upset over CCTVs at home, how Kanpur woman 'plotted' father-in-law's murder

Shalu Minocha, 35, had been upset with her father-in-law for some time. Vineet Minocha, a 63-year-old pharmaceutical businessman, "controlled" the household finances. According to police, Shalu claimed she had to ask him for money even for small expenses. Then, about two weeks ago, Vineet allegedly installed four CCTV cameras in the drawing room of their home in Kanpur's Kalyanpur. He told the family the cameras were meant to ensure their safety. Shalu, police said, was distressed by the cameras, claiming it stripped her of her privacy. Then, on Saturday night, Vineet was killed. The crime was discovered around 4 am the next day when Shalu, her husband Subrat and their child came home and found the main door open. Inside, Vineet lay dead in a pool of blood on the bedroom floor — he had been stabbed repeatedly. Subrat immediately called the police, who rushed to the house.

When they looked for clues, police found no signs that the attackers had forced their way into the house. They began examining CCTV footage from inside the flat and its surroundings to piece together what had happened. The footage led investigators to two men — Vishal Gautam, 30, and Raj Kishore, 25 — who were arrested after an 'encounter' on Monday. When they questioned the duo, police said, the investigation took an unexpected turn. They told police that they had allegedly been hired to kill the victim — by Shalu.

She was arrested the same day. The three were produced before a court, which remanded them to judicial custody, Deputy Commissioner of Police SM Qasim Abidi said.

A plan to make it look like a heart attack
Police claimed Shalu approached Vishal, a former employee at her father-in-law's shop, and offered him Rs 6 lakh to carry out the murder. Vishal, who police said was under a debt of Rs 2 lakh, allegedly agreed. He then recruited his unemployed friend Raj Kishore, offering him an advance of Rs 30,000. The plan, according to police, was chillingly simple: smother the victim with a pillow as he slept, making it look like a fatal heart attack. Around 20 days before the killing, police said Shalu allegedly handed Vishal the original key to the house so he could get a duplicate made.

'Won't forget': Posters of 2013 Muzaffarnagar riots appear at bus stands

LUCKNOW (Agency). In the early hours of Monday, posters invoking the 2013 Muzaffarnagar riots appeared near the city's bus stand with this message: 'Na bhoole the, na bhoole hai, na bhooleenge (We had not forgotten, we have not forgotten, we will not forget).'

Newspaper clippings were pasted alongside the posters, which appeared on the day that marked 13 years since the riots erupted. Muzaffarnagar police quickly removed the posters after being alerted, and are now trying to identify the people behind them and probing their motive. Police said the miscreants were caught on CCTV getting off a bus on Monday and pasting posters. "I have directed the Superintendent of Police, City, to probe the poster episode and submit a report," said Senior Superintendent of Police, Muzaffarnagar, Sanjai Kumar. He added that CCTV footage from cameras installed near the site had been collected, and efforts were underway to identify the persons seen getting off the bus. Police suspect two to three people were involved. When contacted, Superintendent of Police, City (Muzaffarnagar), Amrit Jain declined to comment, saying an inquiry into the matter is underway. Similar posters were reportedly seen in other districts as well, including Aligarh, with photographs circulating on social media. Superintendent of Police, Aligarh, Aditya Bansal said officers had come across photographs of the alleged site, but physical verification revealed nothing there. The development comes amid renewed political references to the 2013 riots, which occurred ahead of the 2014 Lok Sabha elections — and months before the 2027 state assembly polls. The violence in Muzaffarnagar and neighbouring districts left more than 60 people dead and displaced over 40,000 people, according to official figures.

The issue has also remained part of the political and legal discourse in the state. UP Chief Minister Yogi Adityanath frequently said in public rallies that riots no longer happen in UP, boasting of the law and order transformation under his regime in the state since 2017.

App-based rides hit in Chandigarh as Uber, Rapido licences suspended for 6 months

Officials said Uber and Rapido failed to satisfy the prescribed norms relating to driver insurance and training, fares, vehicle eligibility and other safety and operational norms despite being given multiple opportunities.

Chandigarh (Agency).

The Chandigarh Administration Tuesday suspended the licences of Uber and Rapido for six months, cutting off two of the city's most widely used app-based cab services with immediate effect. The State Transport Authority (STA) has said the companies failed to satisfy the prescribed regulations relating to driver insurance and training, fares, vehicle eligibility and other safety and operational norms despite being given multiple opportunities.

Earlier, the Union Territory had suspended the licences of Ola and inDrive, citing alleged violations of driver welfare and training. The regulatory crackdown on the sector is likely to affect thousands of commuters travelling between Chandigarh, Panchkula and Mohali, particularly daily office-goers and late-night travellers.

Issues flagged

In Uber's case, one of the key issues was its alleged failure to implement the fare

structure notified by the Chandigarh Administration in July 2025. The STA had also received complaints alleging that passengers were being charged fares higher



than the prescribed rates. The authority also raised objections to Uber's subscription or recharge-based model for drivers, which it found inconsistent with the UT's aggregator regulations. Officials further found that non-commercial vehicles were attached to the platform, as against the rules. Moreover, officials reportedly found Uber's local office

in Sector 47-C closed or locked during three inspections conducted in May. Rapido, meanwhile, was flagged for several similar compliance issues. According to STA, the insurance cover provided to its bike-taxi captains was limited to accidental death and injury. It did not fulfil the broader insurance requirements prescribed under the 2025 rules. The Rapido office in Sector 32-D was also reportedly found locked during three inspections. The company was additionally flagged over its subscription model, alleged overcharging and the attachment of non-commercial vehicles to its platform. The action follows growing friction between regulators, aggregators and drivers over the functioning of app-based transport services. Driver representatives have also raised concerns over fare structures and commissions, alleging that aggregators were charging commissions beyond the limit prescribed by the Chandigarh Administration.

Woman's death in 'hit-&-run' turns into murder probe: Ahmedabad Police point to 'honour killing'

Autopsy report, CCTV footage reveal 'accident' claim by kin false; murder weapon yet to be found

Ahmedabad (Agency).

THE INVESTIGATION of an fatal "accident" was on Tuesday handed over to Sarkhej police station by the traffic police in Ahmedabad after they found that the death of a 22-year-old woman was likely a murder, allegedly orchestrated by the brother and father of the woman, to "preserve the honour of the family."

The M Division Traffic Police were initially investigating an "accident" that took place on August 12, wherein a 38-year-old man said that he was driving a two-wheeler and his sister Sofia (22) was riding pillion, heading towards their residence in Sarkhej area of the city around 11 pm. In his complaint, he claimed that another vehicle hit their two-wheeler from behind and then sped away. Sofia suffered grievous head injuries and had been admitted to GMERS Sola Civil Hospital, where she died at 12:05 am on August 13. However, the

traffic police found that no such accident had taken place at the spot as claimed in the complaint.

A statement issued by the M Division Traffic



Police said, "We found that the deceased's brother (38) and father (56) earlier reprimanded Sofia over a video of her purportedly interacting with a youth a few

months ago." It added, "... they later conspired together, got a metal hammer from their godown, drove her to an area near Ghelipura village. There, one of the suspects (brother) hit her on the head with the hammer, causing her death. He then gave a false complaint about an "accident" to mislead the police." Asked about the clues that led them to believe it was a case of honour killing, Inspector U B Dhakhada told The Indian Express, "They (the two suspects) chose the "accident" spot they mentioned in the initial complaint believing that there were no CCTVs in the vicinity. However, there was a roadside camera. The footage revealed that there was no accident at 11 pm on August 12."

Inspector Dhakhada added, "The postmortem report also says that the woman died due to brain haemorrhage caused by injury."

YouTuber held in Saharanpur for 'breach of peace'

A 34-year-old YouTuber and journalist was arrested in Saharanpur on Monday for "breach of peace" after she created a ruckus at the Circuit House, police said on Tuesday. Police, meanwhile, lodged another FIR against Huda Zariwala for allegedly posting objectionable content on social media following the demolition of a mosque within the Saharanpur Collectorate premises. "We have arrested Huda Zariwala on charges of breach of peace for creating a nuisance at the Circuit House. She was produced before the court, which sent her to judicial custody," Superintendent of Police, Saharanpur, Vyom Bindal said. According to the police, Zariwala was stopped from entering the Circuit House by woman police personnel during the visit of Leader of Opposition Lal Bihari Yadav. "The woman (Zariwala) created disturbance and behaved aggressively, despite the female officers present at the spot trying to convince her that she was not permitted to go further," said a police officer. It is alleged that Zariwala wanted to accompany the Samajwadi Party delegation to the site of the demolished mosque. Police subsequently arrested Zariwala under Section 170 of the Bharatiya Nagarik Suraksha Sanhita (arrest to prevent the commission of a cognizable offence).

'We prefer cash': UPI everywhere, foreigners and NRIs 'face payment issues' in Gujarat

They cite a bunch of issues: credit cards don't work in ATMs, small-time vendors not accepting international credit cards and less money exchange facilities.

Ahmedabad (Agency).

Thibault Spitakhis was in Ahmedabad, as head of delegation of the Thailand basketball team playing the Under 18 Men's FIBA tournament held in Gujarat in August. He decided to visit popular tourist spots around the city, but payment issues affected his plans, he said.

With most places enabled with contactless payments, Spitakhis had to carry cash for small payments like entry tickets to tourist sites, since he was not prepared to pay by the Unified Payment Interface (UPI). The International Basketball Federation (FIBA) tournaments were held in Ahmedabad from August 13 to 23.

"First of all, it is hard to find money exchanges in Ahmedabad. Credit

cards don't work in ATMs: we couldn't withdraw money because there is some issue with the bank coordination. So we went to a shopping mall, but no one was there at



the money exchange counter. We returned to the counter after an hour, but the situation remained the same. Finally, when the counter was open,

we found the exchange rate very bad," Spitakhis said. Several foreign tourists and NRIs spoke to shared similar experiences.

Anya Bajaj from Zurich, Switzerland, who was in Ahmedabad to visit her family, said, "The biggest limitation is with small purchases. UPI is extremely common in India, but I don't use it. Most of the small-time vendors don't accept cards and it was very difficult as I only had larger denomination currency notes, most of the time. They might not have enough change, which can make a very simple purchase surprisingly inconvenient. For example, if you want to buy street food or something inexpensive from a small vendor, you need small denomination currency notes."

In Paash's village, a fight over the space that keeps his memory alive

Jalandhar (Agency). The words of Avtar Singh Sandhu, better known as Paash, have travelled far beyond Talwandi Salem, his birthplace in Jalandhar district. Nearly four decades after he was killed, his poetry continues to surface wherever people gather around democratic rights and resistance — at farmers' protests, workers' meetings, student gatherings and literary forums. For generations of readers, Paash was not merely a poet who wrote about struggle; he was a poet who participated in it. Ahead of his birth anniversary on September 9, however, his legacy has become the centre of a dispute in his native village. Tension erupted after the village panchayat allegedly tried to stop members of the Paash-Hans Raj Memorial Committee from erecting a pandal at an

eponymous complex for the celebrations. Allegations of manhandling prompted the local administration to deploy police to prevent a confrontation. The dispute centres around two kanals of land at the entrance of Talwandi Salem, where the Pash-Hans Raj Memorial has stood for 26 years. The committee says the land was allotted to it in 2000 through a written panchayat resolution. The panchayat, however, maintains that the land belongs to it.

How the dispute began

The confrontation dates back to early August, when the Paash Memorial International Trust, the Paash-Hans Raj Shaheed Yagadgar Committee and several unions approached the Nakodar SDM and local MLA with allegations of

vandalism. According to their complaint, panchayat representatives broke the locks of the memorial gate. When the committee replaced them, one side of the gate was



allegedly removed and panchayat representatives entered the premises and installed swings, pipes and open-gym equipment.

Local administrative officials initially maintained that the land belonged to the panchayat, while indicating that the matter was close to resolution. The dispute flared again when committee members arrived to prepare for Paash's September 9 birth anniversary. A group led by sarpanch Pardeep Singh allegedly confronted them, including veteran activist Jhanda Singh Jethuke. Committee members alleged that some activists were pushed and that mobile phones were confiscated.

For villagers and Paash's admirers, the confrontation has taken on a larger meaning. "It is a great disrespect to a great poet, and that too by the people and the panchayat of his own village," said a local resident.

Codeine crackdown: Rs 83 lakh cough syrup prohibited from sale in Gujarat

Ahmedabad (Agency). The Gujarat Food and Drugs Control Administration (FDCA) seized codeine-based cough syrups worth more than Rs 83 lakh from Balaji Pharma last week and cancelled the licence of a firm as part of a special drive against the illegal use, unauthorised storage, and sale of such medicines.

The FDCA conducted the action on September 1 and also issued show-cause notices to seven firms. A statement issued by the office of Health Minister Praful Pansheriya on Tuesday said teams are carrying out intensive inspections of wholesale and retail medicine traders across districts and verifying records related to the purchase, sale, storage and distribution of codeine-containing medicines.

At Balaji Pharma in Ahmedabad Rural and Gandhinagar, officials allegedly found 37,762 bottles of Rexton-T Syrup containing codeine. The seized stock is estimated to be worth Rs 83.07 lakh. Authorities have prohibited the sale and distribution of the stock and collected samples of the syrup for analysis.

A scrutiny of the firm's purchase and sale records allegedly showed that it mainly deals in medicines containing codeine. The FDCA has issued a show-cause notice to the firm and sought an explanation.

Show-cause notices were also issued to Formalin Lifesciences in Changodar, Rain Remedies in Santej, Capital Pharma in Visnagar, HRDM Global Solutions in Ahmedabad, Jai Ambe Distributors in Ahmedabad, and Krishna Pharma in Kathwada.

A show-cause notice was also issued to Health Point Pharma in Kalol, Gandhinagar, on the alleged defects found during the inspection. As the firm's explanation was allegedly unsatisfactory, its licence to sell medicines was cancelled.

Upgraded Nehru Planetarium with new 3D AR-VR shows set to enthrall visitors in Delhi

As part of the much-awaited facelift project of the facility at Teen Murti Bhawan complex opened in 1984, several new facilities and infrastructure upgrades have been introduced to strengthen the Planetarium’s role as a centre for science communication and public engagement, said officials. The comprehensively upgraded Planetarium was unveiled at a ceremony in the presence of the chairman of the Execution Council, Prime Ministers Museum and Library (PMML) Nripendra Misra, member and former chairperson of Prasar Bharati A Surya Prakash, director (PMML) Ashwani Lohani,

and its Chief Executive Officer (CEO) Priyanka Mishra. The key additions introduced are a dedicated reading room cum library to support self-directed learning and reference use by students, researchers, and visitors, and a lounge to facilitate high-profile visits, protocol events, and institutional interactions. Comprehensive modernisation of exhibition, projection, and visitor amenities to improve accessibility, comfort, and educational impact has also been undertaken, added the official. The Nehru Planetarium is a premier centre for astronomy education and public engagement, dedicated to nurturing scientific temper and curiosity about the universe. It was inaugurated on 6 February

1984 by the then Prime Minister Indira Gandhi. The Planetarium has played a significant role in popularising astronomy



through immersive and engaging learning experiences for visitors of all ages. At the core of the Planetarium is its full-dome sky theatre, equipped with a 15-metre 4K digital dome capable of presenting high-quality 2D

and 3D shows. The capacity of the auditorium is 250. The daily average footfall is 2,000; however, it increases on weekends and during holidays. "New 3D AR VR shows have been introduced, and the process is underway to add more features. Trials are being conducted. New carpet and paintings have improved aesthetics," said officials. Following the inauguration, Lohani notes that the Nehru Planetarium has now emerged as one of the leading planetariums in the country, equipped with state-of-the-art facilities designed to promote scientific temper, enhance astronomy awareness, and inspire curiosity among students, youth, and the public at large. To further improve footfall, the Planetarium authority is working on an outreach programme and taking the initiative by extending invitations to educational institutions and other organisations.

Delhi building collapse: PG operator arrested, business partner absconding

The Delhi Police has arrested PG operator Sudhanshu in connection with the Satya Niketan building collapse that claimed seven lives, a day after apprehending labour contractor Sanoj from Kasganj in Uttar Pradesh, a senior police officer said. On Monday, a Delhi court sent building owner Hariram, an 81-year-old retired Indian Air Force sergeant, and his 75-year-old wife Urmila to 14 days’ judicial custody, while their 52-year-old son Mahesh was remanded to police custody for two days. During the investigation, Mahesh stated that he managed the maintenance of the building on behalf of his parents, who had leased it to the PG operators, ‘Hostel Daze’, in August 2025. Sudhanshu was one of the two business partners running the ‘Hostel Daze’ PG, along with Shubham Tyagi, who is currently absconding and is being traced, sources said. The basement floor was being repaired as waste had accumulated during the rainy season over the past eight to 10 days and the ground floor was being repaired for extension for commercial purposes. On the day of the incident, they came to know about the collapse from the locals and fled their home to his in-laws’ house in Bhiwadi, Rajasthan. The labour contractor, Sanoj, has been apprehended from Kasganj and is being brought for examination, the officer said. The collapsed building in Satya Niketan was decades old and housed a boys’ PG. Spread over around 55 square metres, it comprised a basement and ground plus four floors. Each floor reportedly had two rooms with two beds each. Police sources said the structure did not have columns and beams.

MCD to demolish 'unsafe' girls’ PG beside Satya Niketan building that collapsed

The MCD is set to start the demolition of an ‘unsafe’ building beside the collapsed structure in Satya Niketan. Officials said that they will begin the demolition drive only after the belongings of the students living inside the premises are completely cleared. The adjacent building which is set for demolition functions as a PG accommodation for girls. After being declared as ‘unsafe’, the civic body has begun the process of shifting its occupants to another place. The representatives of the civic body are assisting the students in taking their belongings out so that they do not face difficulties during the evacuation drive. The clearance process is expected to continue till at least Wednesday, as there are still many belongings to be removed from the premises. For the students living in the densely-populated neighbourhood, the incident has brought back long-standing concerns over cramped accommodations in unsafe buildings, where they spend much of their college lives, and shell out significant sums as rent. Students in the area said that the government must ensure safe accommodation in the area, and address the issue of high rents that has made residing here increasingly difficult. “Rent is around `12,000-13,000 for a bed and even then the rooms are not always safe,” said Annu Priya, a physics student at Motilal Nehru College. Students also complained about poor water and insects in some PG facilities. Swati Ray, a Hindi student at Maitreyi College, said students should not be made to choose between education and safety. “Students from other states come here because of the colleges. If they are asked to leave their accommodation, they may not have anywhere else to go,” she said.

Delhi to roll out PG, coaching institute policy and portal within 45 days after Satya Niketan incident

The portal will list rents, amenities and safety compliance, while the government is also exploring vacant buildings for hostels and higher floor area ratio for campus accommodation.

The Delhi government is set to bring a comprehensive policy and a web portal to regulate PG accommodations and coaching institutes within 30-45 days. Education and urban development minister Ashish Sood made the announcement after meeting the students living in PGs to understand their concerns, days after the Satya Niketan incident. “The urban development department was already working on a PG policy and on implementing the Justice

Gauba committee report for coaching institutes. The Satya Niketan incident has forced us to speed up the implementation of the Gauba committee report and frame a policy that addresses the concerns,” Sood stated.



During the interaction, student delegates highlighted critical operational and infrastructure issues like the demand for a dedicated web portal where the PG owners must

declare rents, meal plans, provided facilities, and structural safety details beforehand. The students said that it should also include unenforced agreement complaints that landlords frequently fail to honour; rent agreement deeds; arbitrary power charges levied by property owners; urgent need for pre-monsoon audits; structural safety certifications; and regular inspection mechanisms. Sood said that since agreements exist between two private individuals, the government is looking into a legal way to make these tenancy deeds a binding. He emphasised upon a two-pronged strategy to deliver a long-term solution. He also announced a digital portal to create a mandatory registry displaying rents, amenities, and audit compliance for students and approval of higher floor area ratio to allow universities.

Student bodies in DU intensify protest, demand safer housing & accountability

In the fallout of the Satya Niketan PG building collapse, student organisations across the political spectrum staged protests in Delhi University’s South Campus on Tuesday, intensifying demands for accountability and urgent reforms in student housing. Demonstrations were led by the Akhil Bharatiya Vidyarthi Parishad, National Students’ Union of India, along with AISA and ASAP, with protesters calling for the resignation of Chief Minister Rekha Gupta and stricter safety regulations for private accommodations. The ABVP organised a large “Student Safety March” that began at the

university’s Rugby Ground and culminated at the Arts Faculty, drawing participation from students across colleges. Raising the slogan “Aakhir



Kab Tak?”, the group demanded immediate structural and fire-safety audits of PG accommodations in student-dominated areas and action against those responsible for the collapse. ABVP also launched a

dedicated platform, No More Satya Niketan, aimed at helping students assess the safety of their accommodations. The website includes features such as “Check Your PG” and “Spot the Signal”, enabling students to evaluate risks and anonymously report unsafe structures. It also lists key demands, including a 30-day deadline for safety audits, construction of more hostels and the introduction of a regulatory framework for PG housing. ABVP Delhi State Secretary Sarthak Sharma said, “The purpose of this initiative is to give students a simple and accessible way to identify risks in their accommodation and bring unsafe conditions.

Satya Niketan building collapse: Two discharged, one still critical at AIIMS JPNA Trauma Centre

The AIIMS update further mentioned that the fourth patient, Asgar Ali, is stable.

Two of the four patients admitted at the AIIMS JPNA Trauma Centre following the Satya Niketan building collapse have been discharged, while another 19-year-old student remains in critical condition in the ICU. In an official update given on Tuesday, the hospital authorities said that the two patients discharged after treatment are Motilal Nehru College student Nitish Chib, 19, and Aditya Chib, who is a second-year student from Jammu, had been staying at the Hostel Daze PG accommodation in Satya Niketan when the building collapsed on Sunday afternoon. He sustained injuries to his head, leg and shoulder and required stitches on his head. One of his family friends and fellow student, Nitin

Jamwal, said Chib was eventually pulled out of the debris by rescue teams around 6 pm on Sunday. Chib had been in the room of fellow student Neeraj Bawa shortly before the collapse. “He heard a few sounds, following which the floor suddenly gave way,” Jamwal had said, recounting what Chib told his cousin while recovering in hospital. Chib and Jamwal, both aged 19 and from Jammu, had come to Delhi around one and a half years ago and are second-year students at Motilal Nehru College. Jamwal had moved out of the same PG to Ber Sarai over two months ago. While Chib has now been discharged,

condition, AIIMS said in its latest bulletin. Bawa, also a 19-year-old and a second-year student, was among those



rescued after the collapse. The AIIMS update further mentioned that the fourth patient, Asgar Ali, is stable. Earlier, the hospital had informed that 12 people were received at the trauma centre in connection with the collapse. Of these, seven were brought dead, while the remaining patients were treated for injuries. For Chib’s family, the latest update brings relief after two days of uncertainty. His mother had flown in from Jammu on Sunday after learning about the collapse and remained by his side during his treatment.

Bangladesh set up India clash in Women's Asia Cup semis, Pakistan face Sri Lanka

Bangladesh booked a semi-final clash with India in the Women's Asia Cup 2026 after beating the United Arab Emirates by 34 runs in Dubai on Tuesday. Pakistan will face Sri Lanka in the other last-four contest.

The win helped Bangladesh recover from their defeat to Sri Lanka and complete the semi-final line-up. India topped Group A, while Sri Lanka finished first in Group B.India will face Bangladesh in the first semi-final on Thursday, September 10, at the Dubai International Cricket Stadium, with the match scheduled for 8pm IST. Pakistan will take on Sri Lanka at the same venue on Friday, September 11, also at 8pm IST.

BANGLADESH OVERCOME UAE SCARE

Bangladesh were sent in to bat but struggled to build momentum, finishing on 103 for seven. Sharmin Akhter top-scored with 38 off 31 balls, while captain Nigar Sultana made 23 off 28.Nahida Akter provided a crucial late boost, scoring 16 and sharing a 42-run seventh-wicket stand with Sharmin after Bangladesh slipped to 55 for six. She then returned with the ball to claim 4-0-18-2.Marufa Akter continued her good form from the Sri Lanka game, taking two wickets for nine runs, while Rabeya Khan picked up three wickets. UAE's Suraksha Kotte was the standout bowler, finishing with figures of 4-0-11-3.The UAE chase never got going as Bangladesh's bowlers kept striking at regular intervals. The hosts finished on 69 for nine in 20 overs, handing Bangladesh the comprehensive victory and the final semi-final spot.BANGLADESH IN FOR TOUGH CHALLENGE

Bangladesh now face a formidable India side that won all three of its group matches. India also produced a dominant seven-wicket victory over Pakistan after bowling them out for just 55.Smriti Mandhana has been among India's standout performers, smashing 124 off 64 balls against Hong Kong in a 137-run win. Her innings also made her the leading run-scorer in women's international cricket.

Cafu's message to India ahead of Brazil friendly: Treat it as a learning experience

India's upcoming clash against Brazil can be much more than a high-profile football spectacle, according to Brazil legend Cafu. The 2002 World Cup-winning captain believes the Blue Tigers can gain valuable lessons from facing the five-time world champions, provided they look beyond the occasion itself.

Brazil are set to face India at the Salt Lake Stadium in Kolkata on October 3, with Carlo Ancelotti's side arriving for one of the biggest friendlies in Indian football. Speaking during his visit to India, Cafu said the match should be viewed as a learning



experience and an opportunity to exchange knowledge with Brazil's players."India is really going to play the biggest match in its national team's history, against the Brazilian national team, five-time world champions," Cafu said.

"This match will provide a lot of learning, a lot of lessons. India can gain a great deal from this in exchanging knowledge, exchanging ideas, exchanging experiences with Brazilian players."The fixture, however, has not been without controversy in India. While the arrival of Brazil has generated considerable excitement, former India captain Bhaichung Bhutia had urged fans to boycott the game amid his criticism of the administration of Indian football.

For Cafu, the bigger question is what India does with the experience after the final whistle. He believes a game against Brazil can have lasting value if it becomes part of a wider plan rather than being treated as an achievement in itself.

11th seed Frances Tiafoe mounted an incredible comeback against US compatriot Alex Michelsen. Battling back from two sets down, Tiafoe fought for four hours and 40 minutes to produce one of the matches of the US Open this year, winning 5-7, 3-6, 7-5, 6-3, 7-6(6).The incredible comeback produced one of the best moments of the US Open this year. With his nerves shot after

letting a two-set lead slip away, 22-year-old Michelsen broke down in tears as Tiafoe celebrated his win on the other side of the court.Seeing an inconsolable Michelsen weep in front of the crowd, Tiafoe dropped his racket, cut short his celebration, and rushed to hug his opponent. The long embrace, followed by a few words of comfort, perhaps brought some solace to the young American, who had producedBut behind the emotional moment was a brutal five-set battle that saw Michelsen come within touching distance of the biggest win of his career before Tiafoe produced an extraordinary fightback.

Michelsen had flown somewhat under the radar during his deepest run at a major, but earned plenty of respect on the biggest stage of American tennis. The 22-year-old fired 21 aces and looked firmly in control for much of the contest, putting Tiafoe under pressure from the very begiTiafoe, meanwhile, struggled to find his rhythm at Arthur Ashe Stadium despite thriving at his beloved Louis Armstrong Stadium earlier in

the tournament.

He hit just four winners compared to Michelsen's 15 in the opening set before handing over the critical break on set point. Michelsen then did some of his best work at



the net in the second set, earning another decisive break with a fine backhand strike.nning. his deepest run at a Grand Slam.The unseeded American had the momentum and was suddenly just one set away from the biggest victory of his career. It got even better for Michelsen at the start of the third set.

He broke Tiafoe in the opening game and moved to within touching distance of the semi-finals. But just when the pressure of the occasion began to creep in, Tiafoe found a way back.Michelsen was serving for the match at 5-4 when his nerves took over. Two double faults handed Tiafoe the opening he had been waiting for, and the 11th seed converted the break point to level the set at 5-5.Suddenly, the match had changed.

Tiafoe slammed his foot on the gas and broke again on set point after surviving a cat-and-mouse exchange. He then carried that momentum into the fourth set, winning the first three games as he raised his level across the board.Michelsen, who had appeared to have the match under control, was now fighting simply to stay alive.

The two Americans saved their best tennis for the deciding set.The final set became a nerve-searing battle, with neither player willing to give the other an opening.

of words between the two players. The referee reviewed the incident and decided it



was serious enough to warrant a red card.At 19 years and 253 days,

Ethan became the youngest player to be sent off in the Champions League for a French club.His dismissal came after Betis had completed a remarkable comeback.

Lille took the lead through Ueda in the 12th minute, but Marc Bartra equalised from Pablo Fornals' cross. Alessandro restored Lille's advantage three minutes later following a corner.Bartra struck again inthe 49th minute, heading in Isco's free kick, before Ayoze Perez completed the turnaround five minutes later with a low strike after an individual run.

COURTOIS SAVES MADRID

Brent crude crosses \$100 as Middle East conflict raises supply fears

New Delhi. (Agency)

Brent crude prices crossed the \$100-a-barrel mark on Wednesday, returning to the psychologically important level for the first time since July 24 as the escalating Middle East conflict heightened concerns over disruptions to oil supplies.

Brent futures rose as much as 2.2% to \$100.07 a barrel.As of 1:31 PM, Brent was at \$99.60 a barrel, up \$1.68 or 1.72%, while US West Texas Intermediate (WTI) crude was trading at \$94.15, up \$1.12 or 1.20%.The latest surge extends a sharp rally in crude prices. Brent has gained around 25% since early August, with markets increasingly worried that the prolonged US-Iran conflict could further disrupt oil flows from the Middle East.Fresh attacks by Iran-backed Houthis on Saudi energy facilities have added to those concerns, with oil installations reportedly set ablaze. The attacks have raised fears of disruption to crude shipments through the Red Sea, an important alternative route to the Strait of Hormuz. Oil flows through Hormuz have already been severely curtailed since the Iran war began on February 28. Before fighting resumed on August 30, around 8 million to 9 million barrels per day (bpd) of crude had been moving through the strait, according to Rystad Energy. More recently, flows have fallen below 2 million bpd.The prospect of prolonged supply disruptions has also prompted several major banks to raise their oil price forecasts. Goldman Sachs, Bank of America and HSBC are among those that have revised their crude outlooks higher in recent days.Despite increased production from non-OPEC producers such as the US, Canada and Guyana, the International Energy Agency expects global oil supply to decline by 4.3 million bpd, or around 4%, this year.

The much-awaited initial public offering (IPO) of the National Stock Exchange (NSE) could hit the market later this month, with the nearly Rs 30,000-crore issue likely to open for subscription on September 18, according to a PTI report citing sources. However, NSE has not officially announced the IPO dates, price band or issue details yet.According to the report, the NSE IPO is likely to open on September 18 and remain open for subscription on September 18, September 21 and September 22. The exchange could make its stock market debut on September 25.The price band is expected to be announced on September 15, followed by the anchor book on September 17, PTI reported.Separately, Reuters reported that NSE is likely to price its IPO at Rs 1,700 to Rs 1,785 per share, citing a source familiar with the matter. The source did not wish to be identified as they were not authorised to speak to the media.Here is everything that has been reported so far about the NSE IPO 2026, including the expected IPO date, price band, issue size and listing date.

RIL plans Rs 12,500 crore rupee bond sale, first since 2023

New Delhi. (Agency)

Reliance Industries, India's largest company by cash balances, is planning to tap the domestic debt market with a Rs 12,500-crore five-year bond issue as early as next week, according to a source. If completed, it would be the largest listed corporate bond issuance in the domestic market this year.

RIL, which has a cash pile of Rs 2.46 lakh crore against net debt of Rs 1.23 lakh crore, is likely to offer a coupon of 7.47% on the five-year notes. The issue will have a base size of Rs 10,000 crore and a greenshoe option of Rs 2,500 crore.

The proposed coupon is significantly lower than the average yield of around 7.87% on AAA-rated corporate bonds of similar tenor.

The timing of the issue is significant as the market expects the Reserve Bank of India to consider tightening monetary policy at its next meeting early next month amid concerns over the liquidity impact of the huge dollar inflows through the special swap windows. Dollar inflows under the scheme have reached \$137.43 billion.The bond issue also comes ahead of another major fundraising exercise by the Reliance group. Its subsidiary Jio Platforms is preparing to launch what is expected to be India's largest IPO on record, seeking to raise close to Rs 38,000 crore after receiving Sebi approval last week. The issue is expected to hit the market before Diwali, which falls on November 8.

Domestic companies have raised around Rs 8.9 lakh crore through bonds so far this year, down about 11% over the trailing 12-month period. While yields on AAA-rated three-year corporate bonds have risen 70 basis points over the past year, the weighted average lending rate on fresh bank loans has declined by 29 basis points during the period.Axis Bank, HDFC Bank, ICICI Bank and Yes Bank are the lead arrangers to the proposed issue, the source said.

Singapore Airlines may seek more say before fresh Air India funding

Singapore Airlines is expected to seek stronger safeguards and greater influence over Air India's management before agreeing to put more money into the Indian airline, according to people familiar with the matter, reported Reuters.The proposed conditions could include greater voting power on the board and targets for Air India to reduce its losses. These terms are expected to be discussed with Tata Sons, Air India's

majority owner.Singapore Airlines owns a 25.1% stake in Air India. Its majority shareholder, Singapore state investor Temasek, is not expected to provide the funds or take part in decisions related to the Indian airline, the people said.The discussions come after Air India sought around \$1.5 billion in fresh equity from its owners. Tata has approved a \$1.1 billion infusion, according to two people familiar with the matter. Singapore Airlines would be expected to contribute based on its shareholding.Singapore Airlines said its board would carefully assess any request for additional capital. It said the decision would take into account Air India's business strategy, the group's operating cash flow and its other capital needs.Temasek declined to comment on what it called speculation about the proposed conditions. Tata Sons and Air India did not respond to requests for comment.

SINGAPORE AIRLINES HAS

LIMITED SAY

The push for stronger terms comes as Singapore Airlines faces pressure to justify further investment in Air India.



The Indian carrier reported a \$2.33 billion loss for the financial year ended March, which directly affected Singapore Airlines' profits.Singapore Airlines has also incurred losses on some of its previous overseas investments. Tata said in July that turning around Air India could take up to 10 years.Air India has appointed former Ethiopian Airlines chief Tewolde Gebremariam as its new

CEO, replacing Campbell Wilson, a former Singapore Airlines executive.

Singapore Airlines currently has limited formal influence over Air India. Under the 2022 merger agreement that brought its 49%-owned Indian airline Vistara into Air India, Singapore Airlines received one board seat. Its CEO, Goh Choon Phong, holds that position.

However, its more than 25% stake gives Singapore Airlines the ability to block special resolutions on important matters under Indian company law. These include mergers, share buybacks and voluntary winding up.

TEMASEK BACKS LONG-TERM INDIAN BET

The funding request has also drawn attention in Singapore. An opposition lawmaker there had called for Temasek's funds not to be used to support Air India.

Singapore Airlines said its investments in India have been and will continue to be funded through its internal resources.

Volkswagen, JSW explore partnership: Why German carmaker wants bigger India play

Volkswagen is exploring a strategic partnership with JSW Group in India to expand its product portfolio, increase local sourcing and strengthen manufacturing and research capabilities as the German automaker looks to improve its competitiveness in one of the world's fastest-growing car markets,m reported news agency Reuters.Skoda Auto Volkswagen India has signed an initial agreement with JSW Group to explore the key principles of a strategic partnership, a company spokesperson said, according to the report.The proposed arrangement would be based on a two-party structure with joint control and clearly defined operational roles.The companies are also expected to explore sharing vehicle

platforms, increasing local sourcing and expanding production capacity.The proposed partnership comes as Volkswagen has struggled to build a larger presence in India



despite being in the market for more than two decades. Its market share in the country remains at around 2%, according to the report.

The company is now looking to use deeper localisation and greater scale to offer more competitive products and improve profitability.The

spokesperson said the partnership would focus on deep localisation and platform synergies, which are intended to support more competitive products, increase scale and improve profitability in India.For Volkswaen, this means potentially using JSW's local business presence and capabilities to address some of the challenges that have limited its growth in India.

WHAT THE PROPOSED PARTNERSHIP WILL DO

The two companies are looking at a structure with joint control, defined operational responsibilities and governance mechanisms aimed at enabling faster decision-making.

The areas being explored include expanding Volkswagen's product portfolio in India, increasing local sourcing of components, sharing vehicle platforms, expanding production capacity, strengthening manufacturing capabilities.

The index offers a glimpse into where India's next generation of high-value startups is coming from — and where their founders studied before entering the entrepreneurial world.

IIT MADRAS LEADS THE UNDERGRADUATE LIST

IIT Madras has emerged as the most common undergraduate institution among founders in the 2026 cohort, with 13 founders having studied there.

IIT Bombay followed with 10 founders, while the University of Delhi had nine. The University of Mumbai, BITS Pilani, IIT Delhi and Anna University



were next, with eight founders each.The IIT Madras alumni featured in the cohort include Aditya Kumbakonam and Anuj Krishna of MathCo, and Kiran Naik of Vegrow, among others.

Paid but still no home: SC rejects Parsvnath proposal, warns of tougher action

New Delhi. (Agency)

The Supreme Court on Tuesday rejected a proposal by Parsvnath Developers to resolve the claims of homebuyers through possession of flats or repayment of money with interest, saying it appeared to be "another device" to delay the proceedings.The bench of Chief Justice Surya Kant and Justices Joymalya Bagchi and V Mohana gave the developer another opportunity to submit a fresh proposal covering the claims of allottees and homebuyers across the company and its subsidiary firms.It warned that if a comprehensive proposal is not submitted, the court may appoint a High-Powered Committee to take over the responsibilities.The claims include refunds, compensation for delayed possession and non-execution of orders passed by Haryana RERA.

SC REJECTS ONE-YEAR POSSESSION PLAN

During the hearing, Parsvnath proposed to deliver possession of dwelling units to homebuyers within one year. The Supreme Court rejected the proposal. The company's counsel told the court that the Parsvnath Group has 24 housing projects involving 27,000 dwelling units. Of these, around 24,000 units have been sold, while about 3,000 are yet to be offered possession.The court said the homebuyers had already suffered considerably and asked the company to come up with a proposal that could address their claims.The Chief Justice also suggested that Parsvnath deposit Rs 500 crore with the Supreme Court registry, after which the court could consider appointing a High-Powered Committee.

HOMEBUYERS HAVE MONEY DECREES BUT ARE STILL WAITING

The bench said some homebuyers already have money decrees in their favour but continue to struggle to obtain relief.The Chief Justice observed that they were "running from pillar to post" and said that even ordering a CBI probe would not necessarily help them.The court has already asked Parsvnath Developers and its directors to submit a status report on cases filed by homebuyers against them and the stage at which those proceedings are pending.

The Supreme Court is currently hearing more than 10 cases against the builder.

PAID RS 1.78 CRORE, BUT FLAT WAS NOT READY

During the hearing, the bench referred to the case of Rita Tikku, a cancer survivor, and Lokaish Tikku, who invested their life savings in the Parsvnath Exotica project in Sector 53, Gurugram.The court said the couple had paid the full sale consideration of Rs 1.78 crore for the flat.

Adani Enterprises shares rose nearly 5% after the company announced the \$1 billion fundraise by its airport subsidiary. The stock was trading at Rs 3,094.80, up Rs 135 or 4.56%, as of 11:43 am, compared with the previous close of Rs 2,959.80.

Adani Airport Holdings Ltd (AAHL), the airports arm of Adani Enterprises, will raise Rs 9,825 crore (around \$1 billion) from a consortium of global and domestic investors, who will collectively hold about 5.54% in the company after the completion of the transaction.The investor consortium comprises Alpha Wave Global, Premji Invest, Temasek and funds managed by BlackRock. The

investment values AAHL at a pre-money equity valuation of around \$18 billion, according to an exchange filing by Adani Enterprises on Wednesday.Adani Enterprises shares rose 5% after the company announced the \$1 billion fundraise by its airport subsidiary. The stock was trading at Rs 3,094.80, up Rs 135 or 4.56%, as of 11:43 am, compared with the previous close of Rs 2,959.80. The stock opened at Rs 2,963.35 and touched an intraday high of Rs 3,141.40.

The investors will subscribe to fresh equity shares of AAHL in three tranches under a Share Subscription Agreement and Shareholders' Agreement. The final tranche is expected to be completed by July 2027, subject to customary conditions and applicable approvals.An expansion spree in recent years has turned AAHL into India's largest airport operator by the number of airports it manages.The company operates eight airports, including Mumbai International Airport, and accounts for about 25% of

India's passenger traffic and 33% of its air cargo volumes. The GMR Group, another major player in India's aviation sector, remains the largest operator by the number of passengers handled.The



expansion has given Adani Airports a sizeable presence across India's aviation infrastructure, as passenger traffic and air connectivity continue to grow.

WHERE WILL THE \$1 BILLION GO

The fresh capital will be used to modernise and expand airport infrastructure, develop Adani Airport City projects and scale up ground

handling and other non-aeronautical businesses.AAHL plans around 22 million sq ft of mixed-use development in the first phase of its Airport City projects. The company aims to scale its airport capacity to around 200 million passengers annually.Jeet Adani, Non-Executive Director of Adani Airport Holdings, said the investment marked an important milestone for the airports platform and that the company would continue to invest ahead of growth.

"India's aviation sector is one of the most powerful multipliers of the country's GDP growth," he said, adding that air connectivity catalyses trade, tourism, employment and regional development. The new partnership, he said, would help the company scale infrastructure, city-side developments and non-aeronautical businesses.Arun Bansal, CEO of Adani Airport Holdings, said the company would continue building capabilities to scale AAHL into "the world's largest airports platform."

Faces 3 Crore Defamation Suit Over ‘Toy Airplane’ Remarks, Aviation Firm Claims Business Loss

Nora Fatehi’s comments about a chartered aircraft has led her in trouble with an aviation company. They are seeking Rs 3 crore in damages from the actress. The dispute centres on social media videos that Nora allegedly posted after travelling on the aircraft last year. Dunes Aviation has filed a civil defamation suit against Nora at a Gandhinagar court, alleging that her remarks caused reputational harm and affected the company’s business. The aviation firm has also asked the court to direct her to remove the posts and issue a public clarification. As reported by PTI, the matter stems from a Mumbai-Jaipur flight in December last year. Nora had shared videos from inside the aircraft on Instagram, following which Dunes Aviation objected to the way the aircraft was allegedly described. The company has claimed that Nora referred to the aircraft as a “miniature”, a “toy” and a “Lego airplane” in the videos. Dunes Aviation has alleged that the comments were widely circulated because of the actor’s social media reach, which the company has put at more than 4.6 crore followers. According to the suit, the posts had a direct commercial impact on the company. Dunes Aviation has claimed that it saw a 15-20 per cent decline in bookings after the controversy, along with an increase in cancellations. The company has strongly rejected the suggestion that the aircraft was unsuitable for the journey. Dunes Aviation said the aircraft used for the flight was a Cessna Citation CJ2 and described it as a standard aircraft that was appropriately sized for the Mumbai-Jaipur route. It further stated that the aircraft was fully DGCA-certified and airworthy. The company also maintained that the aircraft was being operated legally under a valid Non-Scheduled Operator’s Permit (NSOP). Dunes Aviation has accused Nora of making “derogatory and reckless” comments about the aircraft. The company reportedly described her statements as “reckless, irresponsible, and made without any technical knowledge, verification or factual basis”. It has further alleged that the remarks resulted in “serious reputational damage, loss of goodwill and adverse commercial impact”.

Of all the musical choices in Mirzapur: The Movie, one of its most talked-about moments belongs to a composition that predates the franchise by decades. “Saanson Ki Mala Pe”, immortalised in the voice of Ustad Nusrat Fateh Ali Khan, arrives during the film’s mid-credit sequence and has sent listeners back to a song that has repeatedly found new lives across qawwali mehfilis, Hindi cinema, streaming platforms and social media. The version heard on the film’s nine-track album combines Nusrat’s vocals with a contemporary treatment by Madhur Sharma and Vaibhav Pani. But how did a decades-old qawwali arrive here?
The Nusrat Fateh Ali Khan Connection
The story of “Saanson Ki Mala Pe” and Nusrat’s association with India goes back to 1979. During his first visit to the country, Nusrat was invited by Raj Kapoor to perform at Rishi Kapoor’s wedding. Accounts of the composition trace one of its earliest celebrated Indian performances to that occasion. It subsequently appeared on Nusrat’s commercial releases, including Supreme Collection, Vol. 12 in 1982. Nusrat’s treatment gave the composition the ecstatic architecture of qawwali. A later live performance from Birmingham in 1983 is also among the recordings associated with its enduring popularity.
Who Actually Wrote Saanson Ki Mala?
The composition is frequently associated with Mirabai, largely because its language and imagery are steeped in Krishna devotion. However, Sufinama identifies “Saanson Ki Mala Par Simroon Nis-Din Pi Ka Naam” as the work of poet Tufail Hoshiarpuri, who lived from 1914 to 1993. The text itself contains unmistakable references to Shyam, Mohan, Vrindavan and Gokul.
