Amit Shah to discuss national drug control operations with state task force chiefs

New Delhi(Agency)

Union Home Minister Amit Shah will inaugurate the third national conference of heads of Anti-Narcotics Task Forces (ANTFs) on Tuesday, with the two-day meeting set to review progress under the government's Vision Document on Narcotics Control (2026-29) and discuss strategies to tackle drug trafficking and substance abuse across the country.

The conference will bring together heads of ANTFs from all 36 states and Union Territories, besides representatives of central government departments and other stakeholders. Deliberations will focus on strengthening the government's supply, demand, and harm reduction measures, according to an official statement.

Held under the theme "United Resolve, Shared Responsibility", the conference will assess the progress of targets assigned to state and UT ANTFs under the recently released vision document and examine initiatives to combat drug trafficking and substance abuse.

Shah will also release television commercials aimed at creating awareness about the dangers of drug abuse. He is set to lay the foundation stones for new Narcotics Control Bureau (NCB) Zone complexes in Lucknow and Dehradun.

Himanta Sarma vs Congress Face Off Over Attack On Party's Campaign Convoy

Assam Chief Minister Himanta Biswa Sarma and Congress General Secretary (Organisation) KC Venugopal traded allegations on Monday following a violent incident in Nagaon district, where a Congress campaign convoy was allegedly attacked with stones.

The incident took place while Congress leaders were travelling to a public meeting at Barma as part of the party's campaign for the Nagaon Lok Sabha bypoll.

The episode triggered tension in the area, with a crowd taking to the streets and waving black flags. Police later resorted to lathi charge to disperse the gathering, while stones were also reportedly hurled at CRPF personnel deployed at the spot.

Sarma blamed factionalism within the Congress for the incident and accused the party of attempting to shift responsibility.

In a post on X, the Assam Chief Minister said the incident took place in the Samaguri Assembly constituency, represented by Congress MLA Tanzil Hussain, son of Congress MP Rakibul Hussain. "At its core, this was a clash between rival factions within the Congress itself," Sarma said, pointing out that Congress had secured 1,45,212 votes in the constituency in the last Assembly election, compared with 36,902 votes for the BJP.

He also highlighted Samaguri's predominantly minority population and said the Congress state leadership should take responsibility for its internal differences.

'Global order under stress, multilateralism must assert itself strongly': Jaishankar at UNGA summit

External Affairs Minister S Jaishankar has said the global order is under growing stress and called for stronger multilateralism as geopolitical competition, tensions and conflicts reshape the international landscape. Addressing the inaugural Partners for Multilateralism Summit on the sidelines of the 81st United Nations General Assembly, Jaishankar said the world was going through a period of significant structural change, marked by heightened competition and geopolitical tensions.

"We meet at a time when the global order is under stress. For some decades the world has witnessed a steady rebalancing, which was a long-expected structural evolution. However, extreme competition, geopolitical tensions, and actual conflicts have given this an entirely different character," Jaishankar said.

He warned that unchecked tensions could weaken the spirit of international cooperation and stressed that multilateralism needed to play a stronger

role at a time of growing uncertainty.

"If left unchecked, it would call into question the very spirit of international cooperation. That is why it is so essential that multilateralism asserts itself strongly at this juncture," he said. Peace, climate and development need cooperation. Jaishankar said the challenges facing the international community had consequences far beyond diplomacy, affecting global peace, security and development.

"At stake here are very real issues, not just words and expressions. The future of peace and international security, of climate action and climate justice, of emerging technologies and development finance, of countering terrorism and strengthening supply chains, and of ensuring disaster resilience and preparing for pandemics. All depend on a will to cooperate," he said. He noted that many of the international system's achievements had come through collective action and called for existing gains to be protected while efforts continued to address new

challenges.

"Let us recognise that whatever we have achieved so far is only through collective efforts. The lesson here is to safeguard the good while striving for the better," he said. The minister also called for practical steps



to deal with immediate problems rather than waiting for wider agreements before acting. He said specific issues arising from ongoing conflicts could be addressed alongside efforts to achieve broader peace. "That objective can be realised

He warned that unchecked tensions could weaken the spirit of international cooperation and stressed that multilateralism needed to play a stronger role at a time of growing uncertainty.

through a range of efforts, through a combination of initiatives, while ongoing conflicts are concerned, specific dimensions could be addressed even while we strive for a broader peace," he said.

Referring to pressures affecting the global economy and supply systems, Jaishankar said the "four 'F' crisis" of Fuel, food, fertiliser and finance cannot be left to itself. "Call for safeguards on emerging technologies

Jaishankar also stressed the need for international frameworks to address new technologies and capabilities, along with measures to make global supply chains less vulnerable to disruptions. "Where new capabilities and concerns arise, there is a very powerful case for frameworks and guardrails. Where there is a threat of choke points, dominance and disruptions, de-risking and diversifying must be encouraged," he said. He said countries with shared interests should be willing to work together where collective action was necessary, while emphasising that international.

Operation Sindoor lessons to be implemented in multi-nation exercise

New Delhi: Operational lessons derived from Operation Sindoor against Pakistan last year will be applied in a multi-nation air exercise 'Tarang Shakti', in which 40 countries, including the US, France and Germany, are expected to participate. The exercise (September 26-October 11) is being conducted at the Indian Air Force base in Jodhpur. IAF Vice Chief, Air Marshal Ashutosh Dixit, while addressing a press conference about the scope of the exercise explained: "Operation



Sindoor gives us lessons. Our partners bring their own operational experience. Bringing these together in a realistic training environment allows us to test assumptions, challenge procedures, understand different methods of employing air power and improve interoperability." Answering another question on how the lessons of Op Sindoor would be implemented, the Air Marshal said, "Our way of war fighting has changed and that is visible... We are not going to conduct a class on Operation Sindoor." The IAF Vice Chief added that the discussions and tactics that changed during Operation Sindoor would get reflected 'it is up to the participants on how much they absorb from that. Tarang Shakti will be the first multi-nation air exercise of this scale since the IAF's strikes on Pakistani airbases during Operation Sindoor in May last year. Asked if the drone warfare scenario would be simulated, the Air Marshal said: "I think all possible scenarios should get stimulated, we will give broad guidelines." Earlier, briefing about the exercise, IAF officials said the drills will include large force engagements involving high value aerial assets, air mobility operations, dynamic targeting, combat search and rescue. The diversity of missions will enable the participants to train across multiple facets of air operations, bringing together fighter support and

specialist capabilities in a common operational conduct. IAF is expected to field the Rafale and the Sukhoi-30MKI while the F-35 is set to make its debut here in an exercise on Indian soil. This is not the F-35's first visit to India, it has been showcased at aero-shows in Bengaluru, but the plane has never come for

a military exercise. However, the IAF has operated alongside the F-35 at exercise Pitch Black in Australia in July. The US, France, Germany, the UAE, Bangladesh, Australia and Sri Lanka will send in their air assets. Air Marshal Dixit said 32 more countries are participating as observers.

No Cabinet reshuffle on cards; PM Modi calls 2-day 'Chintan Shivir' of all ministers

New Delhi: If there were any impending signs of a Union Cabinet reshuffle, those have been firmly rebutted. Official sources say Prime Minister Narendra Modi has called all ministers, the entire council, for a two-day 'Chintan Shivir' starting Wednesday. Sources say this is not the last of such introspection meetings. More will be held, they say, signalling no immediate rush in the top echelons of the ruling party to revamp the ministerial council. The focus of the meeting will be on 'Making India a developed nation by 2047 — challenges and opportunities'. All ministers have been asked to come up with ideas that can make a difference to policy and inform the next wave of reforms. Sources said focused work on Viksit Bharat Mission has been under way since 2021 and each ministry has been asked to devel-

op a vision document around the goal. As of now, 10 sector-specific groups are working to prepare a

40-year-old man dies after Thar hits scooter in Greater Noida, wife injured

A 40-year-old man died and his wife was injured after a Thar SUV and their scooter collided in the Bistrakh police station area on Monday, police said. The deceased has been identified as Neeraj, a resident of Chiippiyana village in the Bistrakh area. — ians_india (@ians_india) According to police, the accident took place on Monday when Neeraj and his wife were travelling on a scooter. A Thar SUV was also involved in the collision.Both Neeraj and his wife sustained injuries in the accident. They were immediately rushed to a nearby hospital for treatment. However, Neeraj succumbed to his injuries during treatment, while his wife continues to receive medical care.Police said the body was taken into custody and a legal proceedings were done before sending it for postmortem examination. Police have taken the Thar SUV into custody. Police said efforts were underway to trace and apprehend the driver of the vehicle, who allegedly fled after the accident.Officials said a complaint was being obtained from the victim's family, following which an FIR would be registered and further legal action taken against the accused driver.Police are also expected to examine CCTV footage from the area and gather other evidence to establish how the collision occurred and determine whether the SUV driver was driving rashly or negligently.

Iderjit seeks Saini’s intervention to tackle Gurgaon waterlogging, restore natural drains

Gurgaon MP and Union minister Rao Inderjit Singh has urged Haryana chief minister Nayab Singh Saini to take urgent measures to address recurring waterlogging in the city and protect its natural drainage network, warning that rapid urbanisation and encroachments on natural water channels are aggravating the problem.In a letter to chief minister, Singh referred to discussions held with officials and experts following the waterlogging witnessed during the monsoon in Gurgaon. He said GMC had sought expert inputs from IIT Gandhinagar, while GMDA had also obtained advice from experts, including a Japanese agency, on managing rainwater and flooding. Singh said around 20 acres of land belonging to the tourism department near the Badshapur drain could be developed as a water-retention or water-holding area. According to the letter, the land is surrounded by natural features and could potentially be used to temporarily hold excess rainwater during heavy rainfall. He suggested that such a measure could help reduce the pressure on Gurgaon’s drainage system and minimise waterlogging. The minister also highlighted prolonged water accumulation on agricultural land in several villages, including Daulatabad, Dhankot, Khedki Majra and Chandu. He said farmers had been unable to cultivate parts of their land because of persistent waterlogging, while in some areas rainwater had remained stagnant for years.Singh further pointed to the increasing dependence on groundwater in Gurgaon. Referring to a NITI Aayog report, he said the groundwater level in Gurgaon had fallen from about 18 metres in 2004 to around 38 metres in 2025.

Chintels seeks Gurgaon administration nod to raze Tower J in Paradiso

Chintels India has sought A written permission from the Gurgaon administration to demolish Tower J of Paradiso in Sector 109, another unsafe structure in the project where five of nine towers have already been razed. The move comes after repeated structural concerns that followed the vertical collapse of living rooms in one of the towers in Feb 2022, which killed two residents.In a letter dated Sept 14, the developer asked the deputy commissioner to grant permission for the demolition and deploy a govt team to supervise it. Chintels said it had contracted Edifice Engineering for the work and was ready to begin once approval was issued. Tower J was declared unsafe for habitation after a structural assessment by IIT Delhi. A district administration order in Aug 2024, based on a joint committee report and the IIT assessment, asked residents to vacate the tower.The assessment found a high risk of reinforcement corrosion because of chlorides in the concrete. It also flagged reduced alkalinity and deterioration of the concrete, warning that corrosion could accelerate even when no visible distress was apparent.The administration concluded that repair and rehabilitation were not feasible because of the high chloride content and its impact on the structure. Residents were directed to vacate and hand over possession to Chintels.The latest request follows the Supreme Court’s Sept 3 order on unsafe towers and the redevelopment of Paradiso. The project originally had nine towers in two phases. D, E, F, G and H in Phase I have been completely demolished, leaving A, B, C and J in Phase II.Under the approved arrangement, owners of flats in the four remaining towers will receive redeveloped apartments on the existing Phase II land/towers. The Supreme Court also noted that 80-90 occupants were still living in structures declared unsafe.The occupants of unsafe flats have been asked to vacate and hand over possession by Jan 1, 2027. The 2024 order had appointed DTP (enforcement) as nodal officer and duty magistrate to oversee execution and facilitate possession.

Aqua Line ridership up 21% since skywalk opened last month

Aqua Line ridership has risen sharply since the Sector 51-52 skywalk opened last month, according to Noida Metro Rail Corporation. Daily footfall has increased from around 70,000 to 85,000—a jump of about 21%. Residents said the skywalk has made the interchange between the two sectors easier. However, the area below the structure remains barricaded, affecting movement around the site.“Now, NMRC records normally 85,000 commuters per day. On some days, the ridership increased to 95,000. This shows there is an increase of about 20% commuters,” Noida CEO Krishna Karunesh said.The L-shaped, 400m air-conditioned skywalk project, equipped with travelators, was launched in March 2023 with a one-year completion target.



It is also equipped with CCTV cameras and fire safety equipment for passenger safety.However, it faced multiple hurdles, including a change in alignment and construction curbs imposed by the National Green Tribunal (NGT) during winter. The skywalk was finally opened

on Aug 28, coinciding with Raksha Bandhan.The skywalk was initially planned as a single-pillar structure, but the discovery of an underground metro cable during excavation led to a redesign with a two-column support system. Later, a beam was found to be

obstructing its entry at Sector 51 station, prompting the Authority to modify the design and extend the skywalk further. The project cost also increased from Rs 25 crore to Rs 33 crore following the design changes.Sanjeev Kumar, a Sector 51 resident, said the skywalk has made the interchange between the two stations easier for commuters. “I take this interchange for commuting. The skywalk protects pedestrians from harsh weather like rainfall, sun and heat while maintaining safe, continuous urban mobility. It normally takes 4-5 minutes to cover this distance as people also use the travelators,” he added.

However, a portion of the road between Sector 51 and 52 remains barricaded despite the project’s completion. Construction debris has also accumulated below the skywalk and needs to be cleared.

LPG e-KYC deadline gets 5th extension, this time till Sept 30

LPG consumers in the city who have still not completed e-KYC verification will get one final opportunity, with the deadline extended to Sept 30. Officials said those who fail to complete the process by then will have to buy cylinders at commercial rates.The deadline has been extended for the fifth time after the oil companies initially fixed Aug 15 as the last date. It was subsequently extended to Aug 23, Sept 7 and Sept 14. A senior official said the cost of a cylinder could go up to Rs 1,600 under commercial pricing, against around Rs 1,000 currently being charged to eligible consumers who have completed the e-KYC.According to district supply officer (DSO) Amit Tiwari, around 1.65 lakh consumers in

Ghaziabad are yet to complete their e-KYC despite the extensions. He urged consumers to complete the e-KYC before the latest deadline, as this will be the final extension.Ghaziabad has more than 100 LPG agencies serving over 12 lakh consumers. LPG supplies to nearly 2.5 lakh consumers were suspended until June because of incomplete e-KYC, while new connections were also put on hold during the period, officials said. Officials said the oil companies have held meetings with LPG distributors and directed them to speed up the e-KYC process. Distributors have been asked to ensure that the maximum possible number of consumers complete the verification before the Sept 30 deadline. Consumers who are currently staying outside their registered area can complete their e-KYC through the

nearest LPG distributor. They can also complete the process themselves through the respective oil company’s mobile application by creating an account, officials said.he supply department has also started verifying consumers who have failed to complete e-KYC despite repeated opportunities. Officials said some of the pending connections may belong to consumers who have died, shifted from Ghaziabad or otherwise become inactive. Once the verification is completed, authorities may consider permanently deactivating connections that are found to be no longer valid.Another challenge is that many consumers have changed their mobile numbers without updating them in the LPG records, making it difficult for distributors and authorities to contact them, an official said.

Residents urge Noida Authority to conduct surprise inspections amd rising encroachments

Several Noida residents have urged Noida Authority CEO Krishna Karunesh to conduct at least two surprise field inspections every week, alleging that weakened ground-level monitoring by senior officials has allowed encroachments to return soon after enforcement drives. Their five-point demand includes physical verification before closing encroachment-related Integrated Grievance Redressal System (IGRS) complaints, follow-up inspections after enforcement drives, monitoring of repeat-violation locations, confidentiality around surprise enforcement plans and greater emphasis on sustained outcomes than temporary solutions.The residents specifically flagged Atta Market, claiming that large stretches of footpaths and parts of main roads remain occupied by vendors.“When a pedestrian cannot use a footpath safely, this is no longer simply an

encroachment issue; it becomes a matter of public safety and accessibility,” the letter stated.Similar concerns were raised regarding sectors 77, 78 and 79, areas near



Nimbus Hyde Park, Golf View, Mahagun Moderne, Elite Golf Greens, Gaur Sportswood and Supertech Cape Town in Sector 74.Residents have also questioned the process of closing encroachment-related complaints filed through IGRS.

They said such grievances are often closed after enforcement action is carried out and photographs of the cleared site are uploaded. However, they pointed out that this does not resolve the issue as encroachments often return. They are therefore demanding regular physical inspections instead of relying solely on the IGRS system.Responding to the concerns, Noida Authority CEO Krishna Karunesh said regular enforcement drives were being conducted across the city. He said the Authority had deployed five designated JCB machines across different zones and was also issuing notices to vendors. “The problem is that once we remove the encroachment, it reappears in the next three days. But there will be a considerable difference in the next 10 days,” Karunesh said.He added that several vending zones have been identified and efforts are underway to relocate vendors to designated areas.

FIR against 2 after car falls in drain, man found dead nearby

An FIR was registered against two persons after the car they were travelling in crashed into a drain in Sector 24, where a man was later found dead. Police are probing whether the victim died after being hit by the car.

The sequence of events remains unclear because there were few witnesses when the accident occurred around 3am on Saturday. Police said Aman alias Armaan and Aniket were travelling from Sector 49 towards Sector 12-22 when the car allegedly went out of control near the underpass close to Wave City Mall. The vehicle, travelling at around 100 kmph, jumped several feet, overturned and landed over the drain.

Police suspect the man, who was near the spot, may have been struck during the crash and fallen into the drain. He suffered multiple injuries and was found dead there. The cops, however, are yet to establish whether the injuries were caused by the car or whether he died under other circumstances.

“The autopsy report mentions multiple injuries and indicates that they were sustained before his death,” an officer said. The victim’s identity has not yet been established. Police are checking records at nearby stations and circulating his details on social media to trace his family.

The crash was severe enough to deploy the car’s airbags. Aman and Aniket suffered minor injuries, got out of the vehicle and fled, leaving the damaged car behind. Residents spotted it the next morning and alerted police. A crane was used to remove the vehicle.

The car belonged to Shiva, who lives in the same building as the accused at Baraula. Police later traced the vehicle to its owner and identified the occupants.

An FIR was registered on a complaint by Morna police post in-charge Ajit Singh. Police identified Aman and Aniket as residents of Bulandshahr now living in rented accommodation in Baraula. Aniket works in the sanitation department of Noida Authority, while Aman is a gym trainer.

UP rental agreements see a 5-time fee cut

In a reprieve for tenants and landlords, stamp duty and registration fees for rental agreements have been reduced by the UP cabinet last week. Officials said that this will bring parity with respect to other states where the rates are already lower.Under the revised rates, a on-year agreement for a property with an annual rent of up to Rs 2 lakh will attract Rs 1,000 in stamp duty and another Rs 1,000 as a registration fee. The total cost will therefore be Rs 2,000, against the earlier cumulative charge of Rs 10,000. It will rise to Rs 2,000 for agreements of more than one year and up to five years, and Rs 4,000 for agreements running beyond five years and up to 10 years. For properties with annual rent between Rs 2 lakh and Rs 6 lakh, the corresponding stamp duty will be Rs 3,000, Rs 6,000 and Rs 8,000. Similarly, for annual rent between Rs 6 lakh and Rs 10 lakh, the rates will be Rs 4,500, Rs 10,000 and Rs 13,000. The cabinet on Sept 15 also approved a proposal to keep the registration fee equal to the stamp duty under each slab.“We are yet to receive a govt order. But stamp duty and registration fees for lease and rent agreements have been



significantly cut down by the cabinet. As of now, we charge 1% of annual rental value as registration fee and 2% of annual rental value as stamp duty and 4% on developed land which is under municipal limits,” Prem Pratap Singh, AIG (stamp and registration), said.In UP, rent and lease agreements come under Section 4 of the Uttar Pradesh Regulation of Urban

Premises Tenancy Act, 2021, which states that no person can let or take premises on rent except through a written agreement. It adds that a landlord and tenant must jointly inform the Rent Authority in the prescribed form, generally within two months. It, however, exempts residential tenancies of less than 12 months from informing

the Rent Authority.A registered agreement provides a formal record of the rent, tenure and other conditions agreed between the landlord and tenant, which can be useful if a dispute arises.

NCPCR child labour rescue campaign: Over 3,800 children freed, 575 FIRs registered

New Delhi: The National Commission for Protection of Child Rights (NCPCR) has rescued more than 3,800 children from child labour during its Pan-India Rescue and Rehabilitation Campaign. More than 575 FIRs were also registered during the campaign, the Ministry of Women and Child Development said. NCPCR undertook coordinated measures with the concerned state governments, UT Administrations, District Magistrates, Labour Departments, Police authorities and other stakeholders to intensify the identification, rescue and rehabilitation of children engaged in child labour and those vulnerable to trafficking and exploitation. The meetings focused on reviewing rescue operations, resolving operational bottlenecks,

ensuring timely submission of Action Taken Reports and strengthening coordination among concerned departments and agencies. The Ministry said that the NCPCR also carried out awareness and outreach activities through social media and other communication platforms. These efforts focused on reporting child labour and highlighting the importance of rehabilitation and bringing rescued children back into the mainstream of education. With 1,480 children, Uttar Pradesh reported the highest number of children rescued, followed by Rajasthan with

804 and Gujarat with 630. Bihar reported 183 children rescued, while Andhra Pradesh reported 147. According to a statement, the NCPCR also issued communications to the concerned authorities

requesting intensified and targeted rescue operations at child labour and trafficking hotspots, including factories, brick kilns, construction sites, hotels/dhabas, workshops, markets, railway

stations and other vulnerable locations.

Alfaz Sheikh, a resident of Betiya village in the Padrauna tehsil area of Kushinagar district, was deeply moved after watching images of the devastation and suffering caused by the floods in Nepal on television and social media, officials said. He handed over the piggy bank to the district magistrate and requested that the money be deposited in a relief fund and sent to the flood victims in Nepal, officials said. The six-year-old's gesture drew the attention of officials and employees present at the district magistrate's office, who praised his compassion and willingness to help people in distress. "At an age when children usually save money for toys and their small personal needs,

Alfaz decided to dedicate his entire savings of one year to help disaster victims," a district administration official said. The officials described the child's initiative as an example of humanitarian sensitivity and goodwill towards a neighbouring country. Administration officials said efforts were being made to find an appropriate way to send the child's savings to Nepal in accordance with his wish. Alfaz's gesture, they said, was a reminder that the value of help is determined not by the

amount of money involved but by the intention behind it. The child's grandfather, Kasim Ali, told reporters that he was moved after seeing devastating pictures coming from Nepal after the flood and expressed his desire to donate his savings which will be about Rs 20,000 in his piggy bank "We reached the district magistrate office where Alfaz handed over his piggy bank to the DM," Ali said. EAM Jaishankar discusses regional, global issues with foreign counterparts on margins of UNGA session

External Affairs Minister S Jaishankar held a series of bilateral meetings with his foreign counterparts in New York, discussing regional and global developments on the sidelines of the high-level United Nations General Assembly session.Jaishankar arrived in New York on Sunday to lead the Indian delegation at the 81st session of the UN General Assembly.His engagements on Monday began with a meeting with French Foreign Minister Jean-Noel Barrot. Jaishankar said their regular meetings and telephone conversations had helped maintain momentum in the India-France Special Global Strategic Partnership. The two ministers discussed regional and global issues, including the Ukraine conflict and the Gulf crisis, as well as multilateral matters such as reform of the UN Security Council.Jaishankar also met Ukrainian Foreign Minister Andrii Sybiha, weeks after his recent visit to Kyiv.“Welcomed the opportunity to meet FM @andrii_sybiha again, after my recent visit to Ukraine. Our conversation focused on developments over the past few weeks,” Jaishankar said in a post on X.Sybiha said the two ministers discussed peace efforts, bilateral cooperation and international developments, including the situation in the Black Sea and its impact on global markets.He said restoring freedom of navigation in the Black Sea was critical for global food security and added that Ukraine valued India’s engagement.The two sides also discussed preparations for the next meeting of the India-Ukraine Intergovernmental Commission, which Sybiha said would include a strong business component focused on innovation.

In Bangladesh, Pakistan's Jinnah photo stirs anger

Pakistan founder Muhammad Ali Jinnah died nearly eight decades ago, but his photograph has become the centrepiece of a fresh battle over history at Bangladesh's top university.The image of Jinnah was shown at a new museum display this month at Dhaka University -- only to be torn down, exposing a bitter dispute over how Bangladesh remembers its complicated history.Abu Tayyab Habibdar, the university student who ripped the photograph, called Jinnah a "villain". The row shows how the legacies of nationality, religion and language that shaped Bangladesh are politically potent -- and how the 2024 revolution that toppled Sheikh Hasina has upended old narratives.Pakistan and Bangladesh were once the western and eastern wings of a single country, created by the violent partition of British-ruled India in 1947.They were separated by more than 1,500 kilometres (930 miles) of Indian territory. Bangladesh won independence from Pakistan after a bitter 1971 war, during which Pakistani forces were accused of widespread atrocities.Hundreds of thousands were killed — Bangladeshi estimates say millions -- and many in Dhaka still demand Islamabad apologise for the killings.Jinnah was not an Islamist, but his campaign for a separate Muslim homeland makes him a potent symbol for Bangladesh's opposition Islamist politicians, who seek to emphasise the country's Muslim identity. "In Bangladesh, Jinnah was never celebrated," said political analyst Altaf Parvez."The ground is fertile for the rise of the Islamists. They need a suitable leader, and that is why there is so much fuss around Jinnah.” Part of history The Dhaka University Central Students Union (DUCSU), led by Bangladesh Chhatra Shibir, the student wing of the country's largest Islamist political party, said the photograph was part of a chronological display tracing the university's history.

Worsening El Nino threatens Asia with drought, potentially raising food prices globally

Indonesia: All signs are pointing toward a record-breaking El Nino this year, which experts say may cause severe drought in Asia and other extreme weather across the world, threatening food security for millions of people.El Nino is part of a natural climate cycle of warming ocean temperatures, but this year’s is expected to reach new extremes of drought, heat waves, flooding and other climate-related disruptions in South America, Africa and Asia.Southeast Asia is one of the world's most climate vulnerable regions.It's already beset by an energy crisis triggered by the war in Iran. El Nino is already fueling wildfires across farmland, depleting water supplies for major cities and hurting fish catches in the region.Asian governments that have been drawing on their financial reserves to mitigate the war's ripple effects of higher energy costs and scarce fertilizer supplies have less capacity to cope with this year's intensifying El Nino, which is

forecast to peak in December. The phenomenon may amplify other crises in Southeast Asia, according to Paul Teng, with Singapore’s ISEAS-Yusof Ishak Institute, who said, “El Nino is only compounding all the other problems that we see.”During El Nino years, sea surface temperatures in the Pacific Ocean are warmer than usual. This happens every few years and often alters global weather patterns.This year, the seas already are hotter than average, with global oceans hitting new temperature records in August as the climate warms, said Kareff Rafisura, chief of the Disaster Risk Reduction Division at the U.N. Economic and Social Commission for Asia and the Pacific.This intensifying El Nino may be the “strongest in living memory,” according to the United Kingdom’s national weather and climate service. Similarly, the U.S.' National Oceanic and Atmospheric Administration said there is a 69% chance that this will be the strongest recorded El Nino since record-keeping began in 1950.

'Messy, troubled, unpredictable': Diplomats describe a world in turmoil as UN opens annual meeting

In interviews leading up to the annual meeting, current and former ministers, ambassadors and officials from across the world painted a stark picture of the crises plaguing the international community.

There is not much that diplomats can agree on these days. But if asked about the state of the world ahead of the annual meeting at the U.N. General Assembly, heads of state and government and ministers alike will describe a globe in massive turmoil.With two escalating wars raging in Europe and the Middle East, a

global economy in flux, and a shifting world order, international leaders are arriving in New York on Tuesday to an outlook that is massively different from this time last year.“World leaders will be gathering at the United Nations in an era of deep uncertainty,” U.N. Secretary-General António Guterres told reporters recently. “At the same time, power is shifting. The world is changing. And our institutions must change with it.”The last nine months alone saw the audacious U.S. military operation that plucked Venezuelan leader Nicolás Maduro from power before a deadly crackdown took place in Iran after tens of thousands of pro-government demonstrators took to the streets to challenge the country’s theocracy. 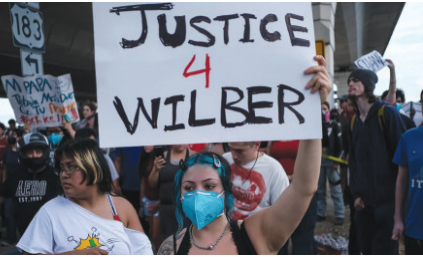

Man shot by US immigration agent describes pain of bullet still inside him

A Venezuelan national shot and wounded by a US immigration agent in Texas was jailed with the bullet still inside his body, his lawyer said Monday.Wilber Rafael Garces Perez, 28, told reporters he was delivering an order for DoorDash on Sunday when his vehicle was rammed by an ICE agent and he was shot. "I'm in a lot of pain because the shot fractured my clavicle and at the hospital where they took me they couldn't remove the bullet because it's close to the spinal cord...I'm not doing very well, I still have the bullet inside," he told reporters by phone. Hours later, his attorney Kate Lincoln-Goldfinch said Garces Perez was "moved to another hospital as he

What's next for Germany's troubled chancellor after a string of state election defeats

Friedrich Merz says he intends to stay on as the leader of Germany and his party after a string of state election defeats. But it's unclear how much room for maneuver the chancellor still has, only 16 months after he took office.The 70-year-old sought within minutes of polls closing Sunday in Mecklenburg-Western Pomerania and Berlin to shore up his position in his center-right Christian Democratic Union. He made a highly unusual election evening appearance to insist that he would press ahead with reforms meant to get the sluggish economy moving.“What has to be done now requires backbone, steadfastness and patience,” Merz said. “I will demonstrate that as the CDU party leader and above all as chancellor of our country.”The key is Merz's partyThe big question is whether the CDU will support him in that, and for how long. The party's eight state governors publicly backed him before Sunday's two elections.

But Merz's statement on Sunday itself underlined the erosion of his authority in recent weeks, and it remains to be seen whether support from powerful regional leaders and lawmakers will hold.Merz has



one advantage: there's no single obvious successor waiting in the wings. Potential options who have been named include the governors of North Rhine-Westphalia, Hendrik Wüst; Bavaria, Markus Söder; and Hesse, Boris Rhein.For now, though, no one has signaled any interest in taking over, and Wüst has an election to fight next spring in

his own state, Germany's most populous. It won't be easy to deliver Survival is one thing, but this month's state elections haven't made it easier for Merz to govern effectively.Merz already agreed the outline of proposed reforms with his junior governing partners, the center-left Social Democrats. But politicians on both sides of the governing coalition have questioned details of them during these election campaigns, particularly aspects of an overhaul of the pension system, and it's unclear whether he can get them through parliament the way he planned.The governing coalition has only a 12-seat majority in the 630-seat Bundestag, the national parliament's lower house. It will need to show discipline that it hasn't always mustered to pass the reform plans, which won't be easy if lawmakers grow more nervous. G7 nations called on Yemen's Houthis Tuesday to halt strikes on Saudi Arabia, offering a show of solidarity with Riyadh as the Tehran-backed fighters have added a new threat to the Middle East war.The Houthi movement staged a lightning offensive in recent weeks to take over Yemen's entire Red Sea coast, including Mokha, threatening global trade and pushing up energy prices up.Gains made by Yemen's Houthis have cemented Iran and its allies hold over two key waterways, including the Strait of Hormuz, that the wider Gulf and top crude exporter Saudi Arabia rely on to ship out its oil.G7 leaders representing Canada, France, Germany, Italy, Japan, the United Kingdom and the United States said in a statement "we call on the Houthis to immediately cease all military actions". "All threats and attacks against civilian shipping, and to return to the political process in good faith," it added.They also called on Iran "to end its arming of and support for the Houthis," alleging Tehran is in violation of past UN Security Council resolutions.The war in impoverished Yemen, which began in 2014 with the Houthi capture of the capital Sanaa, had been largely frozen since 2022 but resumed in July. Saudi Arabia has led a coalition backing the internationally recognised government since 2015. Its intervention escalated the war, which has triggered one of the world's worst humanitarian crises.Saudi strikes on Yemen's strategic Red Sea port Mokha killed at least six people and wounded eight others, the Houthi-affiliated news agency Saba reported Tuesday.The strikes come off the back of a Houthi attack on Riyadh on Saturday which marked the first to target the Saudi capital in years and a major escalation by the pro-Iranian fighters.

Britain agreed to ive military support to Saudi Arabia, media reports said Monday, adding that the UK would provide "defensive" air-to-air refuelling for Saudi jets.France also pledged their support saying it is ready to work on "securing" Saudi energy infrastructure targeted by Iran-backed Houthis, adopting a "strictly defensive approach", a diplomatic source told AFP Monday."This in no way involves taking part in the conflict with the Houthis," the source added.The Houthis have carried out attacks against facilities belonging to the Saudi oil giant Aramco in the Red Sea port city of Yanbu. The East-West Pipeline -- a crucial crude oil export route -- has also been shut down following drone attacks launched from Iraq, according to Riyadh.The head of Yemen's governing body Rashad al-Alimi held a call with US President Donald Trump to request American support against the pro-Iranian fighters, a source in Alimi's office told AFP on Monday.

Idol immersion: 139 tonnes of waste cleared from five beaches in Chennai

CHENNAI (Agency). The Greater Chennai Corporation on Monday said that it has cleared a total of 139.63 MT of waste from the five immersion points across the city, following the Vinayagar Chaturthi idol immersion event held from September 19 to 21. According to the official data shared by the civic body, a total of



11,653 idols were immersed over the three days at five designated beach locations — Pallavakkam, Pattinapakkam, Kasimedu, behind the popular weighbridge at Thiruvottiyur, and Ennore. The total waste collected include 84,690 kg of wooden pallets used as idol platforms, 16,390 kg of flower waste, 3,650 kg of wet waste, 33,555 kg of dry and other waste, and 1,350 kg of food waste. The highest number of idols were

immersed at Pattinapakkam (6,479), where 37.5MT of waste was collected, including 17MT of wooden pallets, 11MT of dry waste and 8MT of flower waste. In contrast, though the number of idols immersed at Palavakkam beach stood at 704 — significantly less compared to Pattinapakkam — the amount of waste cleared was 78MT, largely on account of 57MT of wooden pallets, apart from 3.7MT of flower waste, 1.5MT of wet waste, 14.5MT of dry waste and 1.3MT of food waste. Kasimedu, Ennore, and Thiruvottiyur recorded 13,693 kg, 9,711 kg, and 493 kg, respectively. Besides, many of the residents who came with their Vinayagar idol to get them immersed in Pattinapakkam on Sunday alleged that the machinery, including earthmovers and cranes, was fewer in number. When contacted, a city corporation official told, “Usually, the machinery was also provided by police officials. But this time, GCC provided the machinery. In Pattinapakkam alone, seven earthmovers and excavators, 11 tractors, 11 tippers, and 12 BOVs along with 152 sanitary workers were deployed for immersion and waste clearing.”

IMD predicts heavy rain in Karnataka for 3 days, issues orange, red alerts

Bengaluru (Agency).

Some parts of Karnataka are expected to receive spells of heavy rainfall over the next three days due to a low-pressure area developing in the Bay of Bengal, which coincided with the Southwest Monsoon’s withdrawal from the state. The India Meteorological Department (IMD) issued an orange alert for the entire state for Wednesday, a red alert for coastal areas on Thursday, and an orange alert for the South Interior region.

Rainfall will continue in the South Interior and coastal Karnataka regions on Friday, with some parts forecast to receive a spell of very intense showers. Karnataka has received light to moderate rainfall over the past couple of days following a prolonged dry spell.

Deficit rainfall

According to Karnataka State Natural Disaster Monitoring Centre data, the state has faced one of the worst monsoon seasons in recent years. Compared with deficits in earlier monsoon months, rainfall in September has been the lowest, adding to concerns. The monsoon rainfall deficit in September is currently 67 per cent. Against a normal of 107 mm, the state has received only 35 mm to date. In June, the deficit was 42 per cent (116 mm against a normal of 199 mm), 29 per cent in July (192 mm against a normal of 271 mm), and 23 per cent in August (169 mm against a normal of 220 mm). Poor monsoons also meant reservoir levels were well below those recorded in previous years. For instance,

water storage at KRS reservoir was 27.76 TMC on September 21, compared to 47.73 TMC recorded on



the same date last year. Reservoirs in North Karnataka, however, were better off than dams in the South. Almatti, the largest dam in North Karnataka, had 115 thousand million cubic feet of water, compared to 123 TMC, its full capacity, last year.

Apple executive shot dead in Lucknow: Ex-cop gets 10 years, family calls it ‘murder’

Vivek Tiwari was shot dead during police patrol in Lucknow. A court has sentenced a former cop involved in the case to 10 years’ rigorous imprisonment.

Eight years after Apple sales executive Vivek Tiwari was shot dead in Lucknow during a late night police check, a court on Monday sentenced a former constable to 10 years’ rigorous imprisonment. Prashant Chaudhary was convicted last Thursday of culpable homicide not amounting to murder. The court acquitted co-accused constable Sandeep Kumar, who was out on bail. Speaking to The Indian Express after the verdict, Tiwari’s brother-in-law, Vishnu Shukla, said the family will challenge both the sentence and Kumar’s acquittal. “This is only half justice for us,” he said. “How could a trained police constable have made a mistake while firing his service weapon?... It was a clear case of murder.” District Government Counsel, Lucknow,

Rakesh Pandey, said: “Chaudhary appeared before the court from jail under tight security.



The court sentenced him to 10 years’ imprisonment and imposed a fine of Rs 20,000.” Tiwari, from New Hyderabad Colony in Lucknow, is survived by his wife, Kalpana, an Officer on Special Duty at the

Nagar Nigam, and two children. He was 38. What happened on September 29, 2018 According to the prosecution, Tiwari and his colleague, Sana Khan, were returning home in his car around 1.30 am on September 29, 2018. As they reached near Makdoompur outpost in Gomti Nagar Extension, Chaudhary and Kumar, who were on a bike, signalled to them to stop. When Sana rolled down the window to ask why, Kumar allegedly struck her with a baton. Police claimed Tiwari did not stop and continued driving. Chaudhary then allegedly pulled out his service pistol and fired at the vehicle. The bullet struck Tiwari, causing him to crash into a divider. The two constables then fled the scene. Sana sought help from the police control room and rushed Tiwari to a hospital, where he died during treatment.

IIT-Bombay student suicide: Key takeaways from CCTV footage and police probe

Two days after IIT-Bombay second-year student Sahil Wakode died by suicide after he was allegedly caught using ChatGPT during an examination, CCTV footage from the exam hall and hostel has emerged, providing investigators with a timeline of the events leading up to his death. The footage from the 12.30 pm to 12.45 pm window reportedly shows Professor Suryanarayana Doolla questioning Wakode after appearing to notice him looking at something in his pocket, before taking him aside from

other students. The footage could help investigators establish what happened inside the examination hall and whether the interaction was routine or involved any confrontation. A second CCTV recording reportedly shows Wakode entering his hostel room around 1.25 pm. He did not leave the room again. The Mumbai Crime Branch, led by ACP Dharamveer Bansod, is expected to analyse the footage as part of its investigation. Police have also searched Wakode’s room but have not found a suicide note so far.

Universe: Misunderstanding the flood myth

The Bible (500 BC) tells the story of Noah and the Great Flood. God becomes angry with humanity because people have turned away from His commandments. As punishment, He sends a flood to destroy the world. Only Noah is chosen to survive. He is instructed to build an ark, take his family aboard, and preserve a pair of every animal. After the flood, Noah’s descendants repopulate the earth.A similar story appears in the Shatapatha Brahmana (800 BC), where Manu meets a tiny fish while washing his hands. The fish asks for protection from the larger fish. Manu saves it, first in a pot, then in bigger containers, until it finally grows large enough to return to the sea. Years later, the fish returns and warns Manu of an approaching flood. Manu builds a boat, takes with him the sages who preserve the Vedas, and is rescued when the great fish pulls his boat to safety. After the waters recede, he restores human society.Because both stories involve a flood, a boat, and a chosen survivor, many people assume that Manu is the Indian version of Noah or that Noah is the Biblical Manu. This comparison overlooks the real meaning of the two stories.In the Bible, the flood is an act of divine punishment. God sends it because humanity has sinned. Noah survives because he obeys God. The message is clear: follow God’s commandments or face His wrath. The Vedic story is completely different. No god sends the flood, and no moral reason is given for why it happens. The focus is not on divine anger but on karma. Manu is rescued because he had earlier shown kindness to the helpless fish. The fish



simply repays that kindness. The story teaches that good actions eventually bring good results. It is the earliest story about karma.These different ideas reflect two very different worldviews. The Bible presents a single God who rewards obedience and punishes disobedience. The Shatapatha Brahmana presents a universe governed by karma, where actions naturally produce consequences. An even older flood story comes from ancient Sumeria, nearly a thousand years before either text. In this version, the gods become annoyed by noisy human beings and decide to destroy them with a flood. A fish associated with the god Ea warns Utnapishtim, who builds a boat and survives. Like the Biblical story, the Sumerian myth is about powerful gods controlling humanity. Some historians have tried to connect all three stories because they share floods, boats, and fish. But these similarities are only superficial. The meanings are entirely different. The Sumerian and Biblical stories revolve around divine authority and punishment. The Vedic story is about compassion, gratitude, and the law of karma. There is even a Chinese flood myth which speaks of the world’s first water engineer who was chosen by the people as their first king.Comparing myths requires more than noticing similar characters or events. The deeper ideas behind a story matter far more than its outward details. When we look beyond the flood itself, it becomes clear that Manu and Noah belong to very different philosophical traditions. Their stories may resemble, but they teach fundamentally different lessons.

Genetics of Love-Jihad and Love-Jauhar

The legend of Jauhar predates the advent of Islam by several hundred years; however, the vilifiers of Love-Jihad choose not to acknowledge this

Twenty years ago, the phrase ‘Love-Jihad’ entered the Indian public sphere. The underlying idea was that Hindu women were being enchanted into marrying Muslim men. This was not perceived as genuine love but rather as a clandestine Islamic expansionist strategy, using marriage as a means to propagate the faith. The Hindu lobby that raised this issue never questioned why Hindu women might choose Muslim men over Hindu men; their sole focus was on how to prevent such unions. Contrast this with another term: ‘Jauhar’. This refers to the self-immolation of women in a besieged fortress, choosing death by fire over capture. It is portrayed as an act of true love and fidelity, hence the term ‘Love-Jauhar’. This narrative appears in textbooks and on television, embedded in the legends of Rajasthan, where it is consistently presented as a sacrifice and never a tragedy. No one interprets it as a strategy, nor does anyone question whether it was a free choice or forced upon them by husbands or fathers who preferred death by fire to a life of disgrace and shame.Both Love-Jihad and Love-Jauhar address the same underlying concern: a Hindu woman’s transgression of boundaries, specifically concerning the body of an upper-caste Hindu woman. This fear has nothing to do with religion. It has more to do with caste.The concept of ‘religion’ as a term is a 19th-century European colonial invention, based on conversion, which is fundamental to Christianity and Islam. Hinduism, however, does not convert. Like Japanese Shinto and Chinese Han identity, being Hindu is an ethnic identity acquired by birth into a particular caste (jati). The British did not invent caste, as claimed by Sanatanis; rather, they invented the concept of religion as understood by historians. Religions are inherently imperialistic in nature. They expand their reach through military might, conversion, and marriage. This characteristic is absent in China, Japan, and India. The Chinese choose to assimilate conquered territories, hence they regulate and dissuade Uighur Muslim or Tibetan Buddhist practices. Japan restricts the entry of foreigners into its nation, preferring tourists. Hindus protect boundaries by preventing inter-caste marriage. This practice solidified approximately 2,000 years ago and was documented in the Manusmriti, the most authoritative of all lawbooks on dharma, known as the dharma-shastra.According to Manusmriti, if a Shudra man were to marry a Brahmin woman, their child would become a Chandala. Today, as Hinduism is projected as a casteless religion by Sanatanis, the Muslim man takes the place of the Shudra man. He is contamination to be shunned. Even the Muslim woman

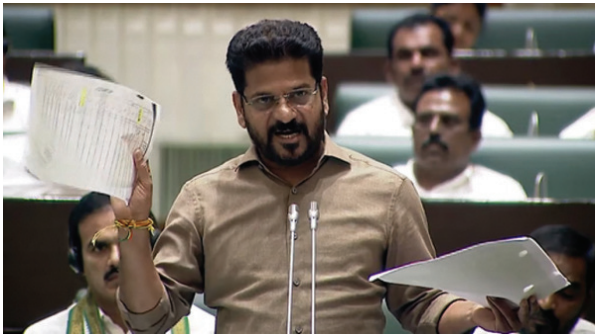


cannot be brought into the Hindu fold where purity of marriage is still determined by caste. Even today, across India, there are new reports of boys and girls who marry outside caste being killed. The legend of Jauhar predates the advent of Islam by several hundred years; however, the vilifiers of Love-Jihad choose not to acknowledge this. Kalhana’s Rajatarangini contains accounts of the Hindu king Harsha during his invasions of Kashmir. The Mahabharata describes Krishna’s widows killing themselves by fire, and the Yadava caravan subsequently being raided by Abhira tribesmen, with no Muslim invaders present. Whatever the terminology—be it ‘sahagamana,’ ‘sati,’ or ‘jauhar’—the practice of burning women began in India 1,500 years ago, according to inscriptional evidence in Eran, Madhya Pradesh, a few centuries after the establishment of caste boundaries. This is not coincidental.History shows that Mughal emperors married Rajput princesses without difficulty, while Rajputs almost never married Mughals, and Mughal princesses often remained unmarried. The flow of purity has always been unidirectional. In warrior communities, giving away a daughter was often an act of submission and shame. Many Sanatanis argue that the women sent to Mughal harems were not daughters of queens but rather daughters of concubines.

There is a more perplexing question that the establishment is unwilling or unable to address: Why did Hindu women want to marry Muslim men? Perhaps they imagined, or sometimes perceived, Muslim men to be more physically vital, while Brahmins and Baniyas prioritised the mind and neglected the body. This was formerly compensated for by gyms and gods with biceps and six-packs, now marketed as ancient Hindu virility. India once had the Anangaranga, which taught men to be expert and considerate lovers. Tradition offers no such schooling, and the neo-Hindu establishment is uncomfortable with it.The Sanatani establishment has primarily been compelled to organise itself against Hindu reformers, rather than against Muslims. Nineteenth-century anti-sati campaigns, led by Rammohan Roy, provoked a Sanatani backlash that redefined itself as the protector of traditions. Here lies the deeper divide. Currently, some people are promoting Hinduism as a religion suitable for everyone, irrespective of birth or caste, based solely on devotion to a guru. This approach is generous, popular, and growing rapidly. Sanatanis are effectively trying to turn Hinduism into a conversion-based religion. But caste proves the biggest obstacle. The idea of a meat-eating bride entering a pure vegetarian household continues to evoke disgust in Hinduism’s elite circles.

It also needs to be wrapped up in a time-bound manner. At the same time, the government has the responsibility to sort out the problems arising out of Section 22A of the Registration Act, 1908, whose misapplication allegedly placed wrong private properties on the prohibited list. At stake are not just political fortunes—all of this directly affects the people of Telangana.

Exhausting Bangalore hustle: Never again will I curse Delhi-Noida traffic

☞The trees are still there. So is the famous Bengaluru weather. But everything else? After 20 years, the city is almost unrecognisable

After almost 20 years, I visited Bangalore recently. We had to attend a conference in Hubli and decided that we’d keep aside a few days for Bangalore to catch up with friends we hadn’t met for a long time. In any case, having read so much about the buzzing life there, I decided that we must see for ourselves what has changed. The short answer to that was: Everything! The lovely parks and verdant neighbourhoods have become crowded spaces with towering high-rise apartment blocks and although the trees still stand, they are now a dwarfed and apologetic presence in this new concrete jungle. As for the traffic, the less said the better. Just covering a few kilometres can take up to two hours in a car or cab and if, God forbid, you have an early morning flight to catch, you have to leave at 4 am to be there by 6 am. As if the volume and chaos of cars and traffic jams were not enough, half the city has been dug up for the Metro that is expected to help commuters. The joy of going out to meet friends in a convivial club or restaurant is wiped out by the sheer logistics of a rendezvous. Never again will I curse the Delhi-Noida or Delhi-Gurgaon traffic. Nothing can possibly be worse than being stuck on Bangalore’s narrow winding roads choked with cars, two-wheelers, buses, trucks and delivery vans. Whew! What is still wonderful is the balmy Bangalore weather. Often, you don’t even need a fan and in the 10 days or so that we spent in this region, we did not feel the need for an air-conditioner. This despite the fact that there is a severe dry spell there and Dharwad farmers are worried about the prevailing drought. Those of us who live or travel mainly in North India can be unprepared for the evident prosperity and civility of India south of the Vindhyas. I must add, however, that when you hear rapid Kannada being spoken, you can be forgiven for thinking that there



is an argument going on instead of greetings being exchanged! The harsh consonants and pitch of voice are so alien to our ears. South Indian food is another experience. We were served a sadya lunch with dozens of little dollops of pickles, chutneys, papads, avial, and rice, sambar and rasam topped with payasam and heavenly aromatic filter coffee. I snored shamelessly through the session of lectures that followed but there were others who looked as if they were dozing secretly too. All in all, we returned exhausted and

‘fully fed up’ as they say in sadda Punjab to mean replete with food and drink.Another shock awaited us here: the BRICS conference meant that large areas of Delhi were cordoned off for the delegates and traffic diversions took one on a safari in another direction if you were forced to enter Delhi for some reason. Happy to be holed up in peaceful Noida, I savoured the peace and quiet this meant. I wonder though, what happens to those who need to go to a hospital in such a situation, but the answer is that we have so many medical facilities across the NCR that one

can be reassured about getting help in case of an emergency. Children and their parents got a long weekend off as office-goers were encouraged to work from home and schools were shut down. I’m told the streets were so quiet that one wondered if a leopard had just passed by.Now about a film that has made box office history: ‘Hanuman Ansh’. Made on a shoestring budget of just about Rs 2 crore, it has raked in almost a hundred times more and is being dubbed now into Tamil and other languages. I’ve wanted to go and see it but no hall has free seats and viewers stay on for two consecutive screenings. My interest is partly because I want to see what has made it such a blockbuster but the more important reason is that my husband’s family were devoted followers of Neem Karoli Baba. He was a regular visitor to our home and whenever we went up to Almora, a mandatory stop at Kainchi was always on the trip. Babaji never gave gyan: he just looked at one with such love in his eyes that it felt as if he had entered one’s secret heart and taken away all one’s tension. Reclining on a takhat, clad in just a rough blanket, he accepted no gifts or offerings. Often he shooed away a visitor rudely for a reason only he knew. But the love he exuded and the peace that descended on one when seated close to him can only be described by someone who has felt it. Babaji passed away in September 1973, the same year as our first-born arrived in December. He had told my mother-in-law, ‘Main tere ghar aunga,’ so she always believed that her first grandson was the reincarnation of Babaji. The stories about Babaji from Steve Jobs to Virat Kohli are now well-known but for us, he will always be the protector of our family. He loved my husband, a dedicated atheist, so much that even now, I am convinced that he is there for us.

Masked gang attacks four in Bengaluru's southwest, Police launch manhunt

BENGALURU (Agency).

Panic gripped parts of Southwest police division in Bengaluru on Sunday night, after a group of six or seven masked men allegedly went on an attacking spree with machetes and long knives at two locations in Uttarahalli, leaving four people injured.

DCP (Southwest) SK Soumyalatha said four suspects were identified and three special teams were formed under the Subramanyapura sub-division ACP to trace and arrest those involved. The motive behind the attacks is yet to be established.

The incidents occurred around 9 pm near Maramma Circle, and subsequently near Arehalli arch on Uttarahalli Main Road. The assailants were travelling on three or four motorcycles, a few were wearing helmets and others covered their faces with masks.

The gang allegedly first targeted the public standing by the roadside near Maramma Circle in Hosahalli. Kiran N and Kiran H suffered cut injuries in the attack. One of them is undergoing treatment as an in-patient, while the other was discharged after receiving treatment.

Minutes later, the same group allegedly moved towards Arehalli arch, near a fish stall, where they attacked two more men identified as Raju and Ravi. Ravi reportedly sustained serious injuries to his ear and hand and is undergoing treatment as an in-patient. Raju reportedly sustained minor injuries.

The jurisdictional Subramanyapura police station rushed to the spot and recorded statements from the injured in hospital. Medico-legal cases were registered by hospitals treating the two in-patients.

Rain triggers waterlogging, traffic snarls across Bengaluru

BENGALURU (Agency).

Commuters had a tough time navigating city roads owing to waterlogging at several places following heavy rains during peak hours on Monday evening. Those using private vehicles witnessed traffic snarls in the central business district and other parts of the city. Traffic pile-ups were reported at B Narayanapura Main Road, Marathahalli, Kadubeesanahalli, Varthur Kodi, Krishnarajapuram Outer Ring Road, SJP



Road, Mahatma Gandhi Road, Queen's Road and several other locations across the city. The Bengaluru Traffic Police (BTP), in a post on its official X account, confirmed that normal traffic flow in and around Whitefield was also affected following the rain and advised commuters to use alternative routes. Meanwhile, vehicular movement on the BGS Flyover in the Chamarajpet traffic police station limits was severely affected due to waterlogging, reports said. Traffic police personnel were seen using sticks to clear clogged inlets to the drainages in waterlogged areas on the BGS Flyover.

Bangle in nightclub, fight over a woman: How Pak terror network was busted

A probe into a late-night brawl at a Panchkula nightclub has now been handed over to the ATS, with the police finding alleged links to foreign-based handlers.

What began as a late-night brawl over a man wearing a kada (metal bangle) to a nightclub in Haryana has now expanded into an investigation into a suspected cross-border narco-terror network, with alleged links to Pakistan and US-based handlers. The investigation took a turn following the arrest of several accused and the recovery of a sophisticated pistol, purportedly worth lakhs of rupees.

According to police sources, on September 13, six men from Kharar visited Alif Laila club in Panchkula to party, when a bouncer stopped one of them allegedly because he was wearing a kada. The duo got into an argument, which later escalated into a confrontation, allegedly involving a woman. The men were asked to leave the club. The group allegedly re-entered. Around 2.30 am on September 14, two shots were fired inside the club. A Panchkula assistant sub-inspector was also partying with his friends at the time. "One of the men pulled out a firearm and opened fire. At first, it appeared to be yet another case of a nightclub fight," the official said.

Subsequently, three men, Karan, Gurpreet and Lakhbir, were arrested. It was when the police allegedly recovered a Zigana pistol from Karan, who is from Mohali, that the investigation took a turn. Investigators said the firearm, reportedly worth several lakhs, was not an ordinary country-made pistol.



They are now probing how it reached the accused and who supplied it. Subsequently, Ludhiana-based Shiva, whom the police describe as a handler, was arrested on September 21. "What initially appeared to be a nightclub firing has revealed leads that require investigation from a wider security perspective. During the investigation, we

have come across suspected links with foreign-based handlers and a possible narco-terror angle. The matter has therefore been transferred to the Anti-Terrorism Squad (ATS) for a deeper probe into the network," Panchkula Police Commissioner Pankaj Nain said.

Probe reveals calls from US and Pakistan

According to sources, the men were allegedly ground-level operatives in a wider narcotics network that extended beyond Punjab, towards Pakistan and the US. "They worked for a handler in the US. Calls from handlers in the US and Pakistan were seen. When their room was searched, money-counting machines were found. They would make payments sent by these handlers for delivering

narcotics here. One week's payment runs in crores," a police officer said. Sources said investigators have identified locations in Punjab allegedly connected to proceeds from cross-border drug trafficking. The cash was reportedly being moved through channels controlled by handlers operating from abroad.

'Wanted to teach owner a lesson': Ex-accountant set fire to Surat textile market over pending Rs 10,000

Surat (Agency).

The Surat Crime Branch on Monday arrested a man on charges of setting fire to a Surat textile market on September 9, leading to an estimated loss of around Rs 24 crores. The accused, identified as Vinod Salve, a resident of Maharashtra's Dhule district, worked as an accountant at a shop in Shyam Sangini Textile market in Surat.

During his primary interrogation, Salve, who quit his job as accountant at the shop a month ago allegedly due to the harassment by his seniors and the shop owner, confessed to setting fire to Shyam Sangini Textile market in a bid to "teach his former owner a lesson about the importance of money", police said. Salve, according to police, claimed that he did not get his pending salary of Rs 10,000 and that the owner refused to give it during his multiple visits to the shop after he left his job, by giving some

excuse or the other. The fire broke out on the sixth floor of Shyam Sangini textile market in the early morning on September 9. The fire



department got a call around 12.50 am and sent teams to fight the fire that took 14 hours to douse. All the shops on the floor were gutted

while some on the fifth floor of the six-storey building were also affected. Salve was caught based on CCTV footage that showed a masked man sprinkling something on parcels of textile goods stacked in the passage for delivery, and setting them ablaze. As per the footage, the man was inside the building for just four minutes after midnight of September 8. The police lodged an FIR booking an unknown person for arson before Salve was identified.

Bought petrol a day before, Ayodhya visit after fire

On a tip off, the Surat city crime branch officials reached the Dindoli area, a largely migrant ghetto, on Monday and spotted Salve standing on the roadside and detained him.

Salve disclosed that he had worked as an accountant in a textile trading shop on the sixth floor in Shyam Sangini market since April 2026, on a monthly salary of Rs 30,000.

Advisory or fake circular? Punjab Opposition flags 'no police uniform' letter

Two Opposition leaders in Punjab on Tuesday released an alleged internal Border Range Police circular advising personnel to avoid wearing uniforms while travelling to and from duty, claiming that the force is operating in fear under the Aam Aadmi Party (AAP) government. The Punjab Police, however, dismissed the document as fake. The letter released by state Congress president Amrinder Singh Raja Warring and Shiromani Akali Dal leader Bikram Singh Majithia stated that police personnel should not wear uniforms while coming on duty or returning from duty. It advised personnel to wear plain clothes before leaving home and the police post (chowki). It added that ordinary civilian dress, badge, identity card, police equipment, or any other item that makes a person's police identity obvious should not be displayed in public. However, the Punjab Police issued a statement, saying

it has not issued any such advisory. "Such messages circulating on social media are fake and should be ignored. Citizens and police personnel are advised to rely only on official channels for authentic information," the statement said. The purported letter shared by Warring and Majithia was said to be written by Inspector General of Police, Border Range, Amritsar, Gurpreet Singh Bhullar, to the senior superintendents of police of Amritsar (Rural), Batala, Gurdaspur and Pathankot.

What the letter states

The letter posted on social media sets out "special instructions" on the personal security of police personnel, security of duty points, and tighter vigilance. It advises police personnel to

avoid travelling alone whenever possible. "Movement should be undertaken according to the Buddy Pair System



(companion-pair system). Necessary information regarding departure and safe arrival at the destination should be provided to the concerned officer/control point," it

added. Sharing the letter and an audio recording purported to be of a police official, Raja Warring posted on X, "Rome was burning and Nero was playing the flute...Punjab is burning and Bhagwant Mann is telling jokes on the stage".

Majithia also shared the same letter on X. "Punjab Police, once known for eliminating terrorism and maintaining law and order, has allegedly been rendered helpless under "Guru Dokhi" Bhagwant Mann's leadership.....Fear prevails among Punjabis over the deteriorating law and order situation.....In view of the alarming nature of the audio that is going viral across various groups, the police must clarify their position and explain whether the situation has deteriorated to such an extent," the post read.

Record paddy area, ageing CRM fleet: Punjab readies 1.25 lakh machines for stubble season

The Agriculture Department expects around 1.25 lakh crop residue management (CRM) machines to be operational this season, even as nearly 67,000 machines distributed since the scheme was launched in 2018 have completed about five years and are now considered non-functional or scrap.

BHOPAL (Agency).

PUNJAB is heading into this year's paddy harvest with a record rice area to cover and a sizeable part of the crop-residue management machinery supplied during the initial years of the anti-stubble-burning programme having reached the end of its operational life.

The Agriculture Department expects around 1.25 lakh crop residue management (CRM) machines to be operational this season, even as nearly 67,000 machines distributed since the scheme was launched in 2018 have completed about five years and are now considered non-functional or scrap. The distinction is significant: the 67,000 machines that have reached the end of their life are not part of the state's projected 1.25 lakh operational fleet for this season. To replenish the fleet, around

22,000 new CRM machines are being added this year under the scheme at an expenditure of about Rs 600 crore, with funding shared between the Centre and



state in a 60:40 ratio. Around 2,000 additional machines are also expected to come through other schemes and grants. The CRM scheme has been integrated

with the national agricultural mechanisation framework on the 60:40 Centre-State funding pattern since 2023-24. "Punjab has distributed around 1.65 lakh CRM machines since 2018. Of these, about 67,000 have now completed their roughly five-year operational cycle, leaving around 98,000 machines from previous years that are considered functional. The department, however, expects the total operational availability this season to be around 1.25 lakh after fresh additions and machines sourced through other schemes," said Director Agriculture Gurjit Singh Brar.

Punjab has more paddy to manage than ever before. Rice, including Basmati and non-Basmati varieties, has touched a record 32.86 lakh hectares, accounting for more than 92 per cent of the state's kharif crop

Super seeder becomes the workhorse

More than 70,000 of the operational machines are expected to be Super Seeders, making the machine the most sought-after CRM equipment in the state after the Happy Seeder dominated the early years of the programme.

A Super Seeder allows farmers to manage standing paddy residue and sow wheat in the same operation, cutting and incorporating the residue while preparing the field for the next crop and sowing the seed. Its growing use has shifted the focus towards machinery that can combine residue management with timely wheat sowing. Punjab now has around 6,100 Custom Hiring Centres (CHCs) from where farmers can hire CRM machinery instead of purchasing it.

Tea stall owner killed, 11 injured as SUV 'runs into' pilgrims, pedestrians in Gujarat, crowd sets vehicle ablaze

Ahmedabad (Agency).

A CROWD allegedly set an SUV ablaze after it allegedly ran into a group of pilgrims, the impact killing a tea stall owner and injuring 11 other persons headed on foot to the Ambaji temple in Sabarkantha near Himmatnagar, police said on Monday. The driver of the SUV was detained and was being interrogated, police said.

The incident took place near Dolgadh, just 11 km north of Himmatnagar, the district headquarters of Sabarkantha. The village is on the state highway way to Ambaji town, which lies a further 93 km to the north and is a popular pilgrimage destination that sees several devotees make the trip on foot for the Bhadarvi Poonam fair, which is organised from September 20-26. Police identified the deceased as Bharat Vaghela, who had set up a roadside



stall along the highway to cater to the pilgrims walking to the temple. Sabarkantha Superintendent of Police (SP) Parthrajsinh Gohil said, "The incident took place at 6:30 pm near Dolgadh outside Himmatnagar. As many as 11 persons, including pilgrims and local residents and volunteers, were injured and have been admitted to G M E R S Himmatnagar Civil Hospital."

"The SUV driver is being interrogated regarding the circumstances of the incident. Some local residents have alleged that the driver, who is also a local resident, made a U-turn around the road and drove at high speed towards the people, causing the accident," SP Gohil told The Indian Express. The SP also said that some in the crowd "manhandled the driver and set fire to the SUV."

Rajya Sabha polls on October 16 for 12 seats in UP, Uttarakhand and Bengal

The Election

Commission has scheduled voting on October 16 for 12 Rajya Sabha seats across Uttar Pradesh, Uttarakhand and West Bengal. The contest could reshape Uttar Pradesh's Upper House balance and further squeeze the BSP.

The Election Commission on Tuesday announced that elections to 12 Rajya Sabha seats in Uttar Pradesh, Uttarakhand and West Bengal will be held on October 16. The exercise will include 10 seats from Uttar Pradesh, one from Uttarakhand and a bypoll to one seat from West Bengal. The 10 Uttar Pradesh seats and the Uttarakhand seat are falling vacant as the terms of the sitting members end on November 25. In West Bengal, the bypoll is being held after the resignation of Rukmini Mallick, popularly known as actor Koel Mallick. According to the schedule announced by the Election Commission, the notification will be issued on September 29, nominations can

be filed till October 6 and the votes will be counted on October 16.

Among those retiring from Uttar Pradesh are BJP leaders Arun Singh, Geeta Shukya, Neeraj Shekhar, Brijlal, BL Verma, Seema Dwivedi and Hardeep Singh Puri, Samajwadi Party leader Ram Gopal Yadav and BSP leader Ramji Gautam. The seat held by former Uttar Pradesh deputy chief minister Dinesh Sharma has also been vacant since September 11, when his resignation took effect after his appointment as lieutenant governor of the Andaman and Nicobar Islands. In Uttarakhand, BJP member Naresh Bansal's term is ending. Of the 10 outgoing Uttar Pradesh seats, eight were held by the BJP, while the Samajwadi Party and the BSP held one

each. The Rajya Sabha elections are due ahead of the Uttar Pradesh Assembly polls next year. Based on the present Assembly arithmetic, the BJP-led alliance is



expected to win eight seats, while the Samajwadi Party is projected to secure two. This could leave the BSP without representation in the Rajya Sabha, as it

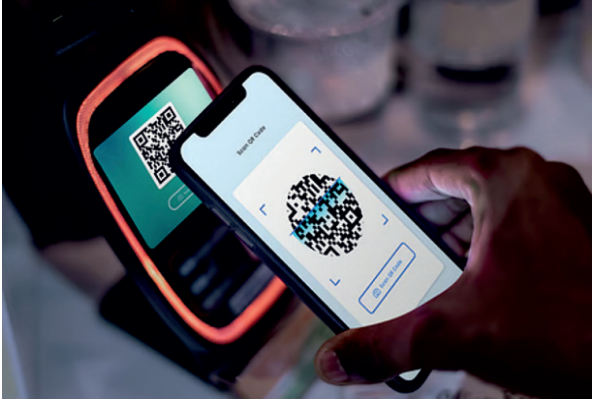
does not have the numbers to retain Gautam's seat on its own.

The BSP currently has no MLA in Uttar Pradesh after the death of its lone legislator, Uma Shankar Singh, in August. Even in 2020, it did not have the numbers to elect a Rajya Sabha member on its own. At the time, the BJP fielded only eight candidates for 10 seats, leaving room for Gautam. He was elected unopposed after the nomination of a Samajwadi Party-backed Independent was rejected, prompting the SP to allege a BJP-BSP understanding. The BJP is also comfortably placed to retain the Uttarakhand seat. In West Bengal, the winner of the bypoll will serve the remainder.

QR code signage project to start on PWD roads soon

The Public Works Department (PWD) plans begin work on its 'Know Your Road' initiative under which QR display boards will be installed on all roads, officials said on Monday. Each QR code will give citizens instant access to complete project details, including the name and length of the road, date of last strengthening, contractor details, sanctioned cost and defect liability period.



"It will also integrate a feedback mechanism, allowing citizens to directly share experience, complaints, or suggestions regarding the quality of work," an official said. The PWD has mandated a uniform design for all display boards. "All divisions have been directed to ensure that boards remain clearly visible, QR codes are functional at all times, and information is updated after any subsequent work," another official said. Where did the 43 million Korean Won go from Indian embassy? 18 years, multiple probes no answer

And despite an inquiry by the Ministry of External Affairs, a CBI investigation, departmental proceedings and now a tribunal order, one basic question remains unanswered: where did the money go? The latest twist came earlier this month, when the Central Administrative Tribunal quashed the dismissal of an embassy official who had been held responsible for the alleged embezzlement. MEA officially said that Won 43,269,861 had been withdrawn through 25 cheques. Three embassy officials came under investigation, Assistant, later Assistant Section Officer, Thomte Thangchinkhup; Drawing and Disbursing Officer and Attaché (Administration) D Banerjee; and Head of Chancery TW Sherpa. As per the MEA, some of the cheques carried amounts that did not match the cash book, while others contained fake signatures of Banerjee. A handwriting expert, the Ministry said, found that the dates and amounts on the cheques were written by Thangchinkhup, although the signatures were not genuine. But Thangchinkhup told a different story. His lawyer told the tribunal that he had dealt with only three cheques, writing them on Banerjee's verbal instructions, withdrawing the cash and handing it directly to Banerjee. The other 22 cheques, he said, were handled by Banerjee "himself or through somebody else" about which he had "no idea." The Ministry also claimed that Thangchinkhup confessed to the embezzlement in November and December 2008. He said the confession was obtained under threat from his seniors. The Ministry lawyer "categorically denied" that allegation. The CBI took over the case in 2009, registering a case on September 25 that year and filing a charge sheet in March 2011. Thangchinkhup's lawyer pointed out that he was never arrested and that the CBI's laboratory report did not establish that he had forged the signatures.

EaseMyTrip co-founder Nishant Pitti named as accused in Mahadev betting case

The ED alleged that Nishant Pitti helped route Skyexchange betting proceeds into the Indian stock market through FPIs and manipulated Easy Trip Planners' share price.

The Enforcement Directorate (ED) has named EaseMyTrip co-founder Nishant Pitti as an accused in the Mahadev online betting app money laundering case, alleging that he facilitated the routing of proceeds from illegal betting into the Indian equity market under the guise of foreign portfolio investments (FPIs). The allegations were made in the agency's fifth supplementary chargesheet, filed before a special Prevention of Money Laundering Act (PMLA) court in Raipur. The ED has also provisionally attached shares worth Rs 59.60 crore held by Pitti in his Demat account. The agency has sought the court's

approval to confiscate the shares, describing them as proceeds of crime under the anti-money laundering law. According to officials, the charges against Pitti, 40, chairman-cum-

According to the agency, Pitti was directly involved in facilitating the entry of proceeds of crime into the Indian equity market under the guise of FPIs. The chargesheet alleged that Pitti, on behalf of the promoters of Easy Trip Planners Ltd, entered into a pre-arranged stock price manipulation deal with an associate of Tibrewal to artificially inflate the company's share price and market capitalisation. The ED is understood to have alleged that Pitti knowingly and willingly assisted Tibrewal in layering proceeds of crime generated through Skyexchange, and acquired, possessed, concealed.

Under the scheme, consumers using up to 400 units of electricity per month will be provided free installation of solar panels up to 3 KW capacity. The consumers who want to install solar panels above this capacity will also get government aid of Rs 1.56 lakh, comprising Rs 78,000 each from the Centre and the city government, she said. Power minister Ashish Sood, who was present at the launch, said that the

scheme brings free electricity and income opportunities for residents through rooftop solar panels. The extra electricity generated to the government. The panels is expected to generate an income ranging from Rs 293 to Rs 2,400 a month, besides receiving free electricity for 25 years. He added that this launch marks the end of the politics of falsehood that had been propagated in Delhi over the past few years. Refuting political claims regarding free electricity, the minister highlighted that the government has fulfilled its

commitment while expanding benefits for citizens.

Three men posing as cops rape teen in park in Delhi's Kalkaji; one arrested after police encounter

A man accused of the gang rape of a 17-year-old girl near Kalkaji Mandir has been arrested following a police shootout in southeast Delhi, officials confirmed on Tuesday.

The suspect, identified as Asif, was reportedly one of three men who posed as police officers before attacking the teenager inside Astha Kunj Park on Monday evening. According to police, Asif fired three rounds at officers attempting to intercept him near DM Office Road in Amar Colony. During the exchange of gunfire, a bullet struck the bulletproof vest of Head Constable Rajesh. In self-defence, the officer returned fire, striking Asif in the right leg. The wounded suspect was subsequently transported to the AIIMS Trauma Centre for medical treatment.

The development came during ongoing enquiries into Monday's incident at Astha Kunj Park, near Kalkaji Mandir. The victim stated that she and her 17-year-old male friend had visited the temple for darshan before entering the park via Gate Number 7. Three men allegedly approached them while posing as policemen and separated the girl from her friend before taking her towards a secluded area, police said.

Asif allegedly threatened the girl with a firearm and a knife and raped her. The two other men with him also allegedly raped her, following which the three men threatened the girl and her friend, according to the complaint.

A PCR call regarding the alleged rape was received at around 8.45 pm, following which the SHO of Amar Colony police station and staff reached Astha Kunj Park, where the girl was found with her friend, police said.

The girl was medically examined at AIIMS, while the crime and forensic teams examined the scene and collected relevant exhibits.

An FIR was registered at Amar Colony police station under relevant sections of the Bharatiya Nyaya Sanhita and the POCSO Act.

Several teams were constituted to trace the accused. During the investigation, police received specific information about Asif's movement near DM Office Road in Amar Colony and laid a trap, police said.

When the police team intercepted him, Asif allegedly opened fire and fired three rounds despite being directed to surrender.

Infantino open to independent FIFA governance review after backlash over failed FFE project

FIFA President Gianni Infantino has indicated he'd be open to an independent review of its governance system and signaled a willingness to consider reforms.

Facing intense scrutiny and criticism following the failure of the “ FIFA Forward Enterprise ” (FFE) project, Infantino sent a letter on Monday outlining this proposal to all FIFA Council members and the 211 member associations ahead of the next FIFA Council meeting scheduled for Oct. 15.

“I will ask the Council whether it wishes to commission an external, independent assessment of FIFA’s current governance framework for major strategic initiatives and to recommend potential improvements,” Infantino stated in his letter, which was seen by The Associated Press. “I will propose that the Council establish a direct, structured, and time-bound consultation with the confederations and member associations on how to further strengthen FIFA’s decision-making processes,” he added.

Backlash over private investors plan

Under the FIFA Forward Enterprise concept, private investors would have purchased shares in the World Cup and other competitions. However, the project leaked publicly sooner than Infantino had anticipated, sparking sharp criticism and creating a rift among member associations. Some of the most high-profile members — including several from European soccer body UEFA — withdrew their support for Infantino. ““The proposal entered the public domain before FIFA’s planned institutional process had been completed and before it could be presented in full to the Council and the member associations. I recognize that, without full context, this caused concern and created the impression that decisions had already been taken. They had not,” Infantino said in the letter.

Legal pressure, strategic ambitions

The fallout has escalated beyond internal disagreement. Last month, UEFA started drafting criminal charges against Infantino in U.S. courts regarding the FFE plan, requesting the release of all relevant documents.

Asian Games, table tennis: 21-year-old Yashaswini fires India into quarterfinals

India's women's table tennis team moved to within one victory of a historic Asian Games medal after edging past 2022 bronze medallists Thailand in a thrilling 3-2 pre-quarterfinal tie on Tuesday.

The victory kept India's hopes of adding to their modest medal tally in the sport alive. India have won only three table tennis medals in Asian Games history, with the men's team's bronze in 2018 their only medal in the team events.

The women's team had to dig deep after falling behind twice before Sreeja Akula delivered in the deciding match. 21-year-old Yashasswini Ghorpade continued her fine run, winning both her matches in the pre-quarters. They will face traditional powerhouses North Korea in the quarter-finals, with victory guaranteeing India a medal. Sreeja began the tie by letting slip a strong start against Orawan Paranang. She won the opening two games 11-7, 11-1, but Paranang fought back to take the next three 9-11, 6-11, 10-12.

Yashaswini Ghorpade restored parity with a gritty 3-2 victory over Suthasini Sawettabut. The 21-year-old fought back after trailing 1-2, winning the fourth and fifth games 11-9, 11-9 to level the tie. Thailand moved ahead again when Diya Chitala lost a five-game battle to Jinnipa Sawettabut. Chitala won the second and third games to take a 2-1 lead, but Jinnipa responded to win 11-7, 11-13 in the final two games and put Thailand within one victory of the quarter-finals. Ghorpade, however, refused to let India slip away. She produced perhaps the most dominant performance of the tie, sweeping Paranang 11-5, 11-8, 11-9 to make it 2-2.

Caroline Weir wants to help OL Lyonnes return to the top of women's soccer

Not only did OL Lyonnes miss the chance of a record-extending ninth Women's Champions League title, the crushing 4-0 loss to Barcelona in last season's final underlined its rival's ongoing status as the best side in the game. When goal-scoring midfielder Caroline Weir joined Lyon from Real Madrid in the offseason, she understood how much that loss hurt.

“Everyone that was here last season knows what it took to get there. Obviously the disappointment of that final, I know the players felt that,” Weir told The Associated

Press in an interview at the club’s training ground on Monday. “I’m a new player, I’m here to learn from the players who have that experience. Also the coach (Jonatan Giráldez) has been there and done it.”

The Women's Champions League begins Tuesday and sees 18 teams competing over six match days in the league phase, with the top four advancing to the quarterfinals and the clubs finishing between fifth and 12th entering knockout-phase playoffs.

After shrugging off a minor muscle injury, Weir could make her Lyon debut at Swiss club Servette on Wednesday. “It starts now,” the 31-year-old Weir said. “It’s exciting that the games are coming a little bit quicker.”

Prolific goal scorer in Spain

She scored freely in Spain — 20 goals overall last season and 28 during the 2022-23 campaign — and is aware what makes Barca tick. Painfully so, since Barca crushed Madrid 12-2 on aggregate in last

Weir hopes she can help her club improve in key moments under the guidance of Giráldez, who previously guided Barca to two Champions League titles. “The coach has been very clear with me about his expectations and what he likes of me as a player — impact the game in the final third (of the pitch),” she explained. “If that’s scoring goals or assisting, that’s where I judge my seasons. At the end of the season, I will look at that impact, especially in big games.”

Taking due note of the concerns raised, the government, after detailed discussion, decided to keep the PLI scheme in abeyance. Softer crude is its main support, offset by a firm dollar after the Fed's hike and continued foreign portfolio outflows," said Anindya Banerjee, Head of Commodity and Currency Research, Kotak Securities. Banerjee further said: "We see 96.30 as the upper cap, with strong Reserve Bank intervention expected as the pair approaches 96.30-96.50, and support at 95.50 and then 95.""The central bank has also been actively draining the surplus liquidity created by the special deposit inflows through bond sales and reverse-repo auctions, which is keeping the adjustment orderly," he added.

PhonePe receives initial UAE central bank nod for payment licenses

Digital payments platform PhonePe said on Tuesday it received in-principle approval from the UAE central bank for two licenses covering retail payment services, card schemes, and stored value facilities. The Walmart-backed fintech firm said the approval follows initial regulatory due diligence



and that it still needs final central bank sign-off before it can begin commercial operations in the Gulf state."Upon receipt of final regulatory approval, the company looks forward to collaborating with regional banks, licensed payment service providers, and local technology vendors," it said.Launched in 2016, PhonePe offers a payments application that lets users recharge, pay bills, and send money using India's Unified Payments Interface network.Earlier this year, the company put its closely watched initial public offering on hold, citing geopolitical uncertainty and volatile global market conditions. The company has said it will revive the listing process once market stability improves.PhonePe is targeting a valuation of\$9 billion to \$10.5 billion in the IPO, two sources with direct knowledge of the matter told Reuters in March.The IPO filing showed Walmart plans to cut its stake in the fintech firm by about 12% through the offering.

Noel Tata has proposed exploring a split or wider restructuring of Tata Sons as an alternative to listing the holding company. The move adds to the internal debate over RBI compliance, SP Group's exit route and capital flows across the Tata Group.

Tata Trusts Chairman Noel Tata has proposed exploring a restructuring of Tata Sons, including the possibility of

splitting the holding company into multiple entities, as an alternative to listing it to meet regulatory requirements, reported Economic Times.The proposal was made at the Tata Sons board meeting on September 17, the report said, citing people familiar with the matter. It was not immediately clear whether the board would take up the proposal for consideration.Tata Trusts, the majority shareholder in Tata Sons, has maintained that the holding company should remain unlisted and has been exploring alternatives after the Reserve Bank of India (RBI) rejected Tata Sons' application to surrender its registration.

WHAT DOES THE PROPOSAL INVOLVE?

The restructuring could potentially take different forms, including a demerger, moving assets into subsidiaries, a merger

or a broader scheme of arrangement, the ET report said.Given the size of Tata Sons



and its wide portfolio of businesses, such a restructuring could involve regulatory, commercial and tax complexities. Tata Sons is the holding company for several major group businesses, including Tata Consultancy Services, Tata Motors, Tata Steel, Tata Capital, Tata Communications, Tata Consumer Products, Tata Investment Corporation, Air India, Tata Digital, Tata Electronics

and Agratas.The proposal comes as Tata Sons faces a regulatory requirement after being classified as an upper-layer non-banking finance company. The company had sought to surrender its registration after repaying its debt, but the RBI rejected the application.

LISTING VS RESTRUCTURING

The proposal comes amid a wider disagreement within Tata Sons over its future structure.

At the September 17 board meeting, the board voted to reappoint N Chandrasekaran as Tata Sons chairman for another five years. Noel Tata opposed the reappointment as well as the move towards a listing, according to the eport. The holding company is understood to have started preparing for a potential public listing after the RBI's decision, with February 2027 emerging as an approximate internal target for a possible market debut, ET had reported earlier.

RBI could implement 2 rate hikes in 2026 amid sticky inflation: Report

Global financial services firm Nomura's Head of Global Macro Research, Rob Subbaraman, has said he expects the Reserve Bank of India (RBI) to raise interest rates in both October and December monetary policy meetings as inflation pressures build.

India's growth remains resilient, with Nomura forecasting 7 per cent GDP growth for FY27, while inflation is expected to breach 6 per cent in the coming months, he said, IANS said, quoting a TV report.Subbaraman highlighted prospects for India to attract more global investment and gain space on the global value-chain chart, particularly through higher-end manufacturing. India holds immense opportunities across sectors but could face laggardness in select sectors if the AI investment narrative remains very strong in the US and Northeast Asia.India could attract more capital, with



FCNR-B deposits seeing stronger-than-expected flows, along with possibility of a strong balance-of-payments surplus, he said.

Markets are watching diplomatic developments at the UN General Assembly and the expected meeting between US President Donald Trump and Chinese President Xi Jinping this week.

On global policy, Subbaraman said at least one more US Federal Reserve rate increase is expected this year, likely in December. He flagged the risk of more increases if inflation remains elevated, adding that the latest FOMC projections point to a broadly hawkish policy direction. Of 18 policymakers, 12 expected one more hike this year; four see two more and only two expect no further increase.The Fed last week raised its policy rate by 25 basis points to 3.75 per cent—4 per cent.

Subbaraman said markets are hoping diplomacy can ease global tensions and US-China trade restrictions that could lower energy costs and long-term yields.

India-New Zealand FTA to come into force from 20 October 2026

The India-New Zealand Free Trade Agreement, is going to enter into force on 20th October 2026 said the Ministry of Commerce & Industry. The FTA was signed on 27th April 2026 in New Delhi, by Union Minister of Commerce and Industry Piyush Goyal and New Zealand's Minister for Trade and Investment Todd McClay.

Goyal and McClay have spoken via virtual conference and announced the date for entering into force of the agreement following the completion of internal processes in both countries. The legislation was passed by the New Zealand Parliament on 16th September, 2026. Prime Minister Narendra Modi's visit to New Zealand in July 2026, the first visit by an Indian Prime Minister to New Zealand in four decades, provided further momentum to the bilateral relationship and emphasised the importance of the early implementation of the India-New Zealand FTA, said Ministry of Commerce & Industry. The visit also marked an important elevation in the relationship, with India and New Zealand announcing a Strategic Partnership and endorsing the India-New Zealand Strategic Partnership: Roadmap

to 2030 as a shared framework to guide cooperation over the next four years including an aspirational goal of doubling bilateral two-way trade in goods and services to NZ\$7 billion (approximately ₹35,000 crore) by 2030.

Operationalisation of the FTA will serve as a key enabler for translating the ambitions of the Strategic Partnership: Roadmap to 2030 into tangible economic outcomes.“The India-New Zealand FTA would provide fresh momentum to the bilateral partnership, create greater synergies between the two economies, enable economies of scale and contribute to enhancing overall competitiveness. We have chosen the auspicious day Dussshera- Vijay Dashmi for the entry into force of the India-New Zealand FTA. I am confident that the entry into force will overcome all hurdles that stood between our trade, technology and investment relationship, and will ensure prosperity for people of both sides,” Goyal said.From the entry into force, every single tariff line covering 100% of India's exports to New Zealand becomes duty-free, offering Indian industry a level playing field that puts it

on par with New Zealand's other trading partners. Sectors that power livelihoods across the country - textiles and apparel, leather and footwear, gems and jewellery, engineering goods and processed foods - stand to gain



immediately as New Zealand's peak tariffs of up to 10% are eliminated. Indian manufacturers will also benefit from tariff-free access to critical inputs such as wooden logs, coking coal and metal scrap, sharpening their competitive edge in global markets, said commerce ministry."At the same time, the Government has safeguarded the interests of Indian farmers by keeping sensitive products such as dairy, animal meat (except sheep), key agricultural commodities, sugar and edible oils

excluded from tariff concessions," it added. A calibrated market access has been structured for New Zealand's apples, kiwifruit and Manuka honey through Tariff Rate Quotas with Minimum Import Price and seasonal import windows, alongside safeguards to protect domestic farmers. The Agreement establishes an Agriculture Productivity Partnership to strengthen cooperation in agriculture, with dedicated Action Plans for kiwifruit, apples and honey aimed at improving productivity, quality and farmer incomes in India. Centres of Excellence will be established for orchard management, post-harvest practices, supply chains, food safety and sustainable beekeeping, facilitating the exchange of knowledge, technology and capacity. A Joint Agriculture Productivity Council will monitor that the market access is complemented by cooperation activities by New Zealand under Agriculture Productivity Partnership.The FTA also sts the stag for deeper investment gains for India, with New Zealand's commitment to facilitate USD 20 billion in investment into India.
